ON $q$-ANALOGUES OF SOME SERIES FOR $\pi$ AND $\pi^{2}$

Abstract. We obtain a new $q$-analogue of the classical Leibniz series $\sum_{k=0}^{\infty}(-1)^{k} /(2 k+1)=\pi / 4$, namely

$$
\sum_{k=0}^{\infty} \frac{(-1)^{k} q^{k(k+3) / 2}}{1-q^{2 k+1}}=\frac{\left(q^{2} ; q^{2}\right)_{\infty}\left(q^{8} ; q^{8}\right)_{\infty}}{\left(q ; q^{2}\right)_{\infty}\left(q^{4} ; q^{8}\right)_{\infty}}
$$

where $q$ is a complex number with $|q|<1$. We also show that the Zeilberger-type series $\sum_{k=1}^{\infty}(3 k-1) 16^{k} /\left(k\binom{2 k}{k}\right)^{3}=\pi^{2} / 2$ has two $q$ analogues with $|q|<1$, one of which is

\sum_{n=0}^{\infty} q^{n(n+1) / 2} \frac{1-q^{3 n+2}}{1-q} \cdot \frac{(q ; q)_{n}^{3}(-q ; q)_{n}}{\left(q^{3} ; q^{2}\right)_{n}^{3}}=(1-q)^{2} \frac{\left(q^{2} ; q^{2}\right)_{\infty}^{4}}{\left(q ; q^{2}\right)_{\infty}^{4}}
$$

## 1. Introduction

Let $q$ be a complex number with $|q|<1$. As usual, for $n \in \mathbb{N}=$ $\{0,1,2, \ldots\}$ and a complex number $a$, we define the $q$-shifted factorial by

$$
(a ; q)_{n}=\prod_{k=0}^{n-1}\left(1-a q^{k}\right)
$$

(An empty product is considered to take the value 1 , and thus $(a ; q)_{0}=1$.) We also adopt the standard notion

$$
(a ; q)_{\infty}=\lim _{n \rightarrow \infty}(a ; q)_{n}=\prod_{k=0}^{\infty}\left(1-a q^{k}\right)
$$

By the definition of the $q$-Gamma function [6, p. 20], we have

$$
\frac{\left(q^{2} ; q^{2}\right)_{\infty}}{\left(q ; q^{2}\right)_{\infty}}=\Gamma_{q^{2}}\left(\frac{1}{2}\right)\left(1-q^{2}\right)^{-1 / 2} .
$$

[^0]Therefore,

$$
\begin{equation*}
\lim _{q \rightarrow 1}(1-q) \frac{\left(q^{2} ; q^{2}\right)_{\infty}^{2}}{\left(q ; q^{2}\right)_{\infty}^{2}}=\Gamma\left(\frac{1}{2}\right)^{2} \lim _{q \rightarrow 1} \frac{1-q}{1-q^{2}}=\frac{\pi}{2} \tag{1.1}
\end{equation*}
$$

and

$$
\lim _{q \rightarrow 1}\left(1-q^{2}\right) \frac{\left(q^{4} ; q^{4}\right)_{\infty}^{2}}{\left(q^{2} ; q^{4}\right)_{\infty}^{2}}=\frac{\pi}{2} .
$$

In view of this, Ramanujan's formula

$$
\begin{equation*}
\sum_{k=0}^{\infty} \frac{(-q)^{k}}{1-q^{2 k+1}}=\frac{\left(q^{4} ; q^{4}\right)_{\infty}^{2}}{\left(q^{2} ; q^{4}\right)_{\infty}^{2}} \quad(|q|<1) \tag{1.2}
\end{equation*}
$$

(equivalent to Example (iv) in [2, p. 139]) can be viewed as a $q$-analogue of Leibniz's identity

$$
\begin{equation*}
\sum_{k=0}^{\infty} \frac{(-1)^{k}}{2 k+1}=\frac{\pi}{4} \tag{1.3}
\end{equation*}
$$

Guo and Liu [8] used the WZ method to deduce the identities

$$
\begin{equation*}
\sum_{n=0}^{\infty} q^{n^{2}} \frac{1-q^{6 n+1}}{1-q} \cdot \frac{\left(q ; q^{2}\right)_{n}^{2}\left(q^{2} ; q^{4}\right)_{n}}{\left(q^{4} ; q^{4}\right)_{n}^{3}}=\frac{(1+q)\left(q^{2} ; q^{4}\right)_{\infty}\left(q^{6} ; q^{4}\right)_{\infty}}{\left(q^{4} ; q^{4}\right)_{\infty}^{2}} \tag{1.4}
\end{equation*}
$$

and

$$
\begin{equation*}
\sum_{n=0}^{\infty}(-1)^{n} q^{3 n^{2}} \frac{1-q^{6 n+1}}{1-q} \cdot \frac{\left(q ; q^{2}\right)_{n}^{3}}{\left(q^{4} ; q^{4}\right)_{n}^{3}}=\frac{\left(q^{3} ; q^{4}\right)_{\infty}\left(q^{5} ; q^{4}\right)_{\infty}}{\left(q^{4} ; q^{4}\right)_{\infty}^{2}} \tag{1.5}
\end{equation*}
$$

with $|q|<1$, which are $q$-analogues of Ramanujan's formulas [3, p. 352]

$$
\sum_{n=0}^{\infty}(6 n+1) \frac{(1 / 2)_{n}^{3}}{n!^{3} 4^{n}}=\sum_{n=0}^{\infty}(6 n+1) \frac{\binom{2 n}{n}^{3}}{256^{n}}=\frac{4}{\pi}
$$

and

$$
\sum_{n=0}^{\infty}(6 n+1)(-1)^{n} \frac{(1 / 2)_{n}^{3}}{n!^{3} 8^{n}}=\sum_{n=0}^{\infty}(6 n+1) \frac{\binom{2 n}{n}^{3}}{(-512)^{n}}=\frac{2 \sqrt{2}}{\pi}
$$

where $(a)_{n}=\prod_{k=0}^{n-1}(a+k)$ is the Pochhammer symbol. Note that

$$
\frac{(1 / 2)_{n}}{n!}=(-1)^{n}\binom{-1 / 2}{n}=\frac{\binom{2 n}{n}}{4^{n}} \quad \text { for all } n \in \mathbb{N} \text {. }
$$

Quite recently, Sun [12] provided $q$-analogues of Euler's classical formulas $\zeta(2)=\pi^{2} / 6$ and $\zeta(4)=\pi^{4} / 90$.

In 1993, Zeilberger [13] used the WZ method to show that

$$
\sum_{n=0}^{\infty}(21 n+13) \frac{n!^{6}}{8(2 n+1)!^{3}}=\sum_{k=1}^{\infty} \frac{21 k-8}{k^{3}\binom{2 k}{k}^{3}}=\frac{\pi^{2}}{6}
$$

A complicated $q$-analogue of the identity $\sum_{k=1}^{\infty}(21 k-8) /\left(k^{3}\binom{2 k}{k}\right)^{3}=\zeta(2)$ was given by Hessami Pilehrood and Hessami Pilehrood [9] in 2011. Following Zeilberger's work, in 2008 Guillera [7, Identity 1] employed the WZ method to obtain the Zeilberger-type series

\begin{equation*}
\sum_{k=1}^{\infty} \frac{(3 k-1) 16^{k}}{k^{3}\binom{2 k}{k}^{3}}=\frac{\pi^{2}}{2} \tag{1.6}
\end{equation*}
$$

In this paper we study $q$-analogues of the identities (1.3) and (1.6).
Now we state our main results.
Theorem 1.1. For $|q|<1$ we have

$$
\begin{equation*}
\sum_{k=0}^{\infty} \frac{(-1)^{k} q^{k(k+3) / 2}}{1-q^{2 k+1}}=\frac{\left(q^{2} ; q^{2}\right)_{\infty}\left(q^{8} ; q^{8}\right)_{\infty}}{\left(q ; q^{2}\right)_{\infty}\left(q^{4} ; q^{8}\right)_{\infty}} \tag{1.7}
\end{equation*}
$$

The above identity gives a new $q$-analogue of Leibniz's identity (1.3) since

$$
\lim _{q \rightarrow 1}\left(1-q^{2}\right) \frac{\left(q^{2} ; q^{2}\right)_{\infty}\left(q^{8} ; q^{8}\right)_{\infty}}{\left(q ; q^{2}\right)_{\infty}\left(q^{4} ; q^{8}\right)_{\infty}}=\lim _{q \rightarrow 1} \Gamma_{q^{2}}\left(\frac{1}{2}\right) \Gamma_{q^{8}}\left(\frac{1}{2}\right)=\Gamma\left(\frac{1}{2}\right)^{2}=\pi
$$

Theorem 1.2. For $|q|<1$ we have

$$
\begin{equation*}
\sum_{n=0}^{\infty} q^{2 n(n+1)}\left(1+q^{2 n+2}-2 q^{4 n+3}\right) \frac{\left(q^{2} ; q^{2}\right)_{n}^{3}}{\left(q ; q^{2}\right)_{n+1}^{3}(-1 ; q)_{2 n+3}}=\frac{1}{2} \sum_{n=0}^{\infty} \frac{q^{2 n}}{\left(1-q^{2 n+1}\right)^{2}} \tag{1.8}
\end{equation*}
$$

and

$$
\begin{equation*}
\sum_{n=0}^{\infty} q^{n(n+1) / 2} \frac{1-q^{3 n+2}}{1-q} \cdot \frac{(q ; q)_{n}^{3}(-q ; q)_{n}}{\left(q^{3} ; q^{2}\right)_{n}^{3}}=(1-q)^{2} \frac{\left(q^{2} ; q^{2}\right)_{\infty}^{4}}{\left(q ; q^{2}\right)_{\infty}^{4}} \tag{1.9}
\end{equation*}
$$

Multiplying both sides of (1.8) by $(1-q)^{2}$ and then letting $q \rightarrow 1$, we obtain

$$
\frac{1}{4} \sum_{n=0}^{\infty}(3 n+2) \frac{2^{4 n} n!^{6}}{(2 n+1)!^{3}}=\frac{1}{2} \sum_{n=0}^{\infty} \frac{1}{(2 n+1)^{2}}=\frac{1}{2}\left(1-\frac{1}{4}\right) \zeta(2)=\frac{\pi^{2}}{16},
$$

which is equivalent to (1.6). In view of (1.1) and the fact that

$$
\lim _{q \rightarrow 1} q^{n(n+1) / 2} \frac{1-q^{3 n+2}}{1-q} \cdot \frac{(q ; q)_{n}^{3}(-q ; q)_{n}}{\left(q^{3} ; q^{2}\right)_{n}^{3}}=\frac{(3 n+2) 16^{n+1}}{2(n+1)^{3}\binom{2 n+2}{n+1}},
$$

the identity (1.9) is also a $q$-analogue of (1.6). The expansions of both sides of (1.9) are

$$
1+2 q-q^{2}+3 q^{4}-6 q^{5}+3 q^{6}+8 q^{7}-16 q^{8}+8 q^{9}+10 q^{10}+\cdots
$$

In [11, Conjecture 1.4], Sun presented several conjectural identities similar to Zeilberger-type series (one of which is $\sum_{k=1}^{\infty}(10 k-3) 8^{k} /\left(k^{3}\binom{2 k}{k}^{2}\binom{3 k}{k}\right)=$ $\pi^{2} / 2$ ), but we could not find $q$-analogues of them.

We are going to show Theorems 1.1 and 1.2 in Sections 2 and 3 respectively. Finally, in Section 4, we give alternative proofs for (1.4) and (1.5).

## 2. Proof of Theorem 1.1

As usual, for $x \in \mathbb{Z}$ we let $T_{x}$ denote the triangular number $x(x+1) / 2$.
Lemma 2.1. Let $n \in \mathbb{N}$, and define

$$
t_{2}(n):=\left|\left\{(x, y) \in \mathbb{N}^{2}: T_{x}+4 T_{y}=n\right\}\right| .
$$

Then

$$
\begin{equation*}
t_{2}(n)=\sum_{\substack{d \mid 8 n+5 \\ d<\sqrt{8 n+5}}}(-1)^{(d-1) / 2} \tag{2.1}
\end{equation*}
$$

Proof. By Theorem 3.2.1 of [4, p. 56], for any positive integer $m$ we have

$$
r_{2}(m)=4 \sum_{2 \nmid d \mid m}(-1)^{(d-1) / 2},
$$

where $r_{2}(m):=\left|\left\{(x, y) \in \mathbb{Z}^{2}: x^{2}+y^{2}=m\right\}\right|$. Observe that

$$
\begin{aligned}
t_{2}(n) & =\left|\left\{(x, y) \in \mathbb{N}^{2}:(2 x+1)^{2}+4(2 y+1)^{2}=8 n+5\right\}\right| \\
& =\frac{1}{4}\left|\left\{(x, y) \in \mathbb{Z}^{2}: x^{2}+(2 y)^{2}=8 n+5\right\}\right|=\frac{1}{8} r_{2}(8 n+5) \\
& =\frac{1}{2} \sum_{d \mid 8 n+5}(-1)^{(d-1) / 2}=\sum_{\substack{d \mid 8 n+5 \\
d<\sqrt{8 n+5}}} \frac{(-1)^{(d-1) / 2}+(-1)^{((8 n+5) / d-1) / 2}}{2} \\
& =\sum_{\substack{d \mid 8 n+5 \\
d<\sqrt{8 n+5}}}(-1)^{(d-1) / 2} .
\end{aligned}
$$

This proves (2.1).

As usual, for $|q|<1$ we define

$$
\psi(q):=\sum_{n=0}^{\infty} q^{T_{n}} .
$$

By a known formula of Gauß (cf. (1.3.14) of [4, p. 11]),

$$
\begin{equation*}
\psi(q)=\frac{\left(q^{2} ; q^{2}\right)_{\infty}}{\left(q ; q^{2}\right)_{\infty}} \tag{2.2}
\end{equation*}
$$

First proof of (1.7). Let $L$ and $R$ denote the left-hand side and the righthand side of (1.7), respectively. In view of Gauß' identity (2.2) and (2.1), we have

$$
R=\psi(q) \psi\left(q^{4}\right)=\sum_{n=0}^{\infty} t_{2}(n) q^{n}=\sum_{n=0}^{\infty}\left(\sum_{\substack{d \mid 8 n+5 \\ d<\sqrt{8 n+5}}}(-1)^{(d-1) / 2}\right) q^{n} .
$$

On the other hand,

$$
\begin{aligned}
L & =\sum_{k=0}^{\infty}(-1)^{k} \sum_{m=0}^{\infty} q^{k(k+3) / 2+(2 k+1) m} \\
& =\sum_{k=0}^{\infty} \sum_{m=0}^{\infty}(-1)^{k} q^{((2 k+1)(2 k+1+4(2 m+1))-5) / 8}=\sum_{n=0}^{\infty} \sum_{\substack{d \mid 8 n+5 \\
d<\sqrt{8 n+5}}}(-1)^{(d-1) / 2} q^{n}
\end{aligned}
$$

Therefore (1.7) is valid.

Second proof of (1.7). Recall the standard basic hypergeometric notation

b_{1}, \ldots, b_{s}
\end{array} ; q, z\right]=\sum_{\ell=0}^{\infty} \frac{\left(a_{1} ; q\right)_{\ell} \cdots\left(a_{r} ; q\right)_{\ell}}{(q ; q)_{\ell}\left(b_{1} ; q\right)_{\ell} \cdots\left(b_{s} ; q\right)_{\ell}}\left((-1)^{\ell} q^{\left(\frac{\ell}{2}\right)}\right)^{s-r+1} z^{\ell}
$$

(with $\left(a_{1} ; q\right)_{\ell} \cdots\left(a_{r} ; q\right)_{\ell}$ often abbreviated as $\left.\left(a_{1}, \ldots, a_{r} ; q\right)_{\ell}\right)$. We start with the transformation formula (cf. [6, Eq. (3.10.4)])

\left.\begin{array}{rl}

a, \sqrt{a} q,-\sqrt{a} q, b, x,-x, y,-y, \\
\sqrt{a},-\sqrt{a}, a q / b, a q / x,-a q / x, a q / y,-a q / y,
\end{array}\right. \\
\quad-q^{-n}, q^{-n} \\
& \left.-a q^{n+1}, a q^{n+1} ; q,-\frac{a^{3} q^{2 n+3}}{b x^{2} y^{2}}\right]
\end{array}\right] \quad \begin{gathered}
\left.q^{2} a^{2} q^{2}, a^{2} q^{2} / x^{2} y^{2} ; q^{2}\right)_{n} \\
\left(a^{2} q^{2} / x^{2}, a^{2} q^{2} / y^{2} ; q^{2}\right)_{n} \\
5
\end{gathered} \phi_{4}\left[\begin{array}{c}
q^{-2 n}, y^{2},-a q / b,-a q^{2} / b \\
\left.x^{2} y^{2} / a^{2} q^{2 n}, a^{2} q^{2} / b^{2},-a q,-a q^{2} ; q^{2}, q^{2}\right],
\end{array}\right.
$$

where $n$ is a nonnegative integer. In this identity, set $a=q, x=y=\sqrt{q}$, and let $n \rightarrow \infty$. In this way, we obtain

$$
\left.\begin{array}{rl}
{ }_{4} \phi_{5}\left[\begin{array}{c}
q, b, \sqrt{q},-\sqrt{q} \\
q^{2} / b, q^{3 / 2},-q^{3 / 2}, 0,0
\end{array} ; q, \frac{q^{4}}{b}\right] \\
& =\frac{\left(q^{2} ; q^{2}\right)_{\infty}\left(q^{4} ; q^{2}\right)_{\infty}}{\left(q^{3} ; q^{2}\right)_{\infty}{ }^{2}}{ }_{4} \phi_{3}\left[\begin{array}{c}
q,-q^{2} / b,-q^{3} / b, q \\
-q^{3},-q^{2}, q^{4} / b^{2}
\end{array} ; q^{2}, q^{2}\right.
\end{array}\right] .
$$

By performing the limit as $b \rightarrow 0$, the above transformation formula is reduced to

If the left-hand side is written out explicitly, we see that it agrees with the left-hand side in (1.7) up to a multiplicative factor of $1-q$. On the other hand, the ${ }_{2} \phi_{2}$-series on the right-hand side can be evaluated by means of the summation formula (cf. [6, Ex. 1.19(i); Appendix (II.10)])

$$
{ }_{2} \phi_{2}\left[\begin{array}{c}
a, q / a \\
-q, b
\end{array} ; q,-b\right]=\frac{\left(a b, b q / a ; q^{2}\right)_{\infty}}{(b ; q)_{\infty}} .
$$

Thus, we arrive at

$$
\sum_{k=0}^{\infty} \frac{(-1)^{k} q^{k(k+3) / 2}(1-q)}{1-q^{2 k+1}}=\frac{\left(q^{2} ; q^{2}\right)_{\infty}\left(q^{4} ; q^{2}\right)_{\infty}\left(-q^{4} ; q^{4}\right)_{\infty}^{2}}{\left(-q^{3} ; q^{2}\right)_{\infty}\left(q^{3} ; q^{2}\right)_{\infty}^{2}}
$$

which is indeed equivalent to (1.7).

## 3. Proof of Theorem 1.2

Proof of (1.8). We construct a $q$-analogue of the WZ pair given by Guillera [7. Identity 1].

Recall that a pair of bivariate functions $(F(n, k), G(n, k))$ is called a $W Z$ pair [10, Chapter 7] if

$$
F(n+1, k)-F(n, k)=G(n, k+1)-G(n, k) .
$$

It was shown (cf. [1]) that

$$
\begin{equation*}
\sum_{n=0}^{\infty} G(n, 0)=\lim _{k \rightarrow \infty} \sum_{n=0}^{\infty} G(n, k)+\sum_{k=0}^{\infty} F(0, k) \tag{3.1}
\end{equation*}
$$

We make the following construction. Let

$$
F_{q}(n, k)=4 \cdot \frac{1-q^{2 n}}{1-q} \cdot B_{q}(n, k)
$$

and

$$
G_{q}(n, k)=\frac{4\left(1+q^{2 n+1}-2 q^{4 n+2 k+1}\right)}{(1-q)\left(1+q^{2 n}\right)\left(1+q^{2 n+1}\right)} B_{q}(n, k),
$$

where

$$
B_{q}(n, k)=\frac{\left(q ; q^{2}\right)_{k}^{2}\left(q ; q^{2}\right)_{n}^{3}}{\left(q^{2 n+2} ; q^{2}\right)_{k}^{2}\left(q^{2} ; q^{2}\right)_{n}^{3}(-1 ; q)_{2 n}} q^{2 n^{2}+4 n k}
$$

We can extend the definition of $B_{q}(n, k)$ from nonnegative integers $n, k$ to any real numbers $n, k$ by defining

$$
(a ; q)_{n}=\frac{(a ; q)_{\infty}}{\left(a q^{n} ; q\right)_{\infty}}
$$

Let $a$ be a positive real number. It is straightforward to check that $\left(F_{q}(n+a, k), G_{q}(n+a, k)\right)$ is a WZ pair. Observing that $B_{q}(n, k)$ contains the factor $q^{4 n k}$, we get

$$
\lim _{k \rightarrow \infty} \sum_{n=0}^{\infty} G_{q}(n+a, k)=0
$$

Thus,

$$
\begin{equation*}
\sum_{n=0}^{\infty} G_{q}(n+a, 0)=\sum_{n=0}^{\infty} F_{q}(a, k) \tag{3.2}
\end{equation*}
$$

Setting $a=1 / 2$ and noting that

$$
\left(q ; q^{2}\right)_{n+1 / 2}=\frac{\left(q ; q^{2}\right)_{\infty}}{\left(q \cdot q^{2 n+1} ; q^{2}\right)_{\infty}}=\frac{\left(q ; q^{2}\right)_{\infty}\left(q^{2} ; q^{2}\right)_{n}}{\left(q^{2} ; q^{2}\right)_{\infty}}
$$

and

$$
\left(q^{2} ; q^{2}\right)_{n+1 / 2}=\frac{\left(q^{2} ; q^{2}\right)_{\infty}}{\left(q^{2} \cdot q^{2 n+1} ; q^{2}\right)_{\infty}}=\frac{\left(q^{2} ; q^{2}\right)_{\infty}\left(q ; q^{2}\right)_{n+1}}{\left(q ; q^{2}\right)_{\infty}}
$$

for any $n \in \mathbb{N}$, we infer that

$$
F_{q}\left(\frac{1}{2}, k\right)=\frac{2 q^{1 / 2}}{1-q} \cdot \frac{q^{2 k}}{\left(1-q^{2 k+1}\right)^{2}} \cdot \frac{\left(q ; q^{2}\right)_{\infty}^{6}}{\left(q^{2} ; q^{2}\right)_{\infty}^{6}},
$$

and

$$
\begin{aligned}
G_{q}\left(n+\frac{1}{2}, 0\right)= & \frac{4 q^{2 n^{2}+2 n+1 / 2}\left(1+q^{2 n+2}-2 q^{4 n+3}\right)}{(1-q)} \\
& \times \frac{\left(q ; q^{2}\right)_{\infty}^{3}\left(q^{2 n+3} ; q^{2}\right)_{\infty}^{3}}{(-1 ; q)_{2 n+3}\left(q^{2 n+2} ; q^{2}\right)_{\infty}^{3}\left(q^{2} ; q^{2}\right)_{\infty}^{3}}
\end{aligned}
$$

After cancelling the common factors, we arrive at (1.8).
Remark 3.1. Guillera [7] obtained the identity (1.6) via the WZ pair

$$
F(n, k)=8 n B(n, k), \quad G(n, k)=(6 n+4 k+1) B(n, k),
$$

where

$$
B(n, k)=\frac{(2 k)!^{2}(2 n)!^{3}}{2^{8 n+4 k}(n+k)!^{2} k!^{2} n!^{4}}
$$

Since

$$
\lim _{q \rightarrow 1} F_{q}(n, k)=F(n, k) \quad \text { and } \quad \lim _{q \rightarrow 1} G_{q}(n, k)=G(n, k)
$$

the pair $\left(F_{q}(n, k), G_{q}(n, k)\right)$ is indeed a $q$-analogue of the pair $(F(n, k)$, $G(n, k))$.

Proof of (1.9). We start from the quadratic transformation formula (cf. [6, Eq. (3.8.13)])

$$
\left.\begin{array}{l}
\sum_{n=0}^{\infty} \frac{\left(1-a q^{3 n}\right)\left(a, d, a q / d ; q^{2}\right)_{n}(b, c, a q / b c ; q)_{n}}{(1-a)(q, a q / d, d ; q)_{n}\left(a q^{2} / b, a q^{2} / c, b c q ; q^{2}\right)_{n}} q^{n} \\
=\frac{\left(a q^{2}, b q, c q, a q^{2} / b c ; q^{2}\right)_{\infty}}{\left(q, a q^{2} / b, a q^{2} / c, b c q ; q^{2}\right)_{\infty}}{ }_{3} \phi_{2}\left[\begin{array}{l}
b, c, a q / b c \\
d q, a q^{2} / d
\end{array} q^{2}, q^{2}\right. \tag{3.3}
\end{array}\right] .
$$

We set $a=q^{2}$ and $b=c=q$. This yields

$$
\begin{align*}
& \sum_{n=0}^{\infty} \frac{\left(1-q^{3 n+2}\right)\left(q^{2}, d, q^{3} / d ; q^{2}\right)_{n}(q, q, q ; q)_{n}}{\left(1-q^{2}\right)\left(q, q^{3} / d, d ; q\right)_{n}\left(q^{3}, q^{3}, q^{3} ; q^{2}\right)_{n}} q^{n} \\
& =\frac{\left(q^{4}, q^{2}, q^{2}, q^{2} ; q^{2}\right)_{\infty}}{\left(q, q^{3}, q^{3}, q^{3} ; q^{2}\right)_{\infty}}{ }_{3} \phi_{2}\left[\begin{array}{c}
q, q, q \\
d q, q^{4} / d
\end{array} q^{2}, q^{2}\right] . \tag{3.4}
\end{align*}
$$

At this point, we observe that the limit $d \rightarrow 0$ applied to the left-hand side of (3.4) produces exactly the left-hand side of (1.9). Thus, it remains to show the limit $d \rightarrow 0$ applied to the right-hand side of (3.4) yields the right-hand side of (1.9).

In order to see this, we take recourse to the transformation formula (cf. [6, Eq. (3.3.1) or Appendix (III.34)])

\end{array}\right] } \\
& -\frac{(q / E, A, B, C, D q / E ; q)_{\infty}}{(C q / E, B q / E, D, E / q, A q / E ; q)_{\infty}}{ }_{3} \phi_{2}\left[\begin{array}{c}
C q / E, B q / E, A q / E \\
D q / E, q^{2} / E
\end{array} ; q, q\right] .
\end{aligned}
$$

Here we replace $q$ by $q^{2}$ and set $A=B=C=q, D=d q$, and $E=q^{4} / d$, to obtain

$$
\begin{aligned}
& { }_{3} \phi_{2}\left[\begin{array}{c}
q, q, q \\
d q, q^{4} / d
\end{array} q^{2}, q^{2}\right]=\frac{\left(d, d / q^{2} ; q^{2}\right)_{\infty}}{\left(d / q, d / q ; q^{2}\right)_{\infty}}{ }^{2} \phi_{1}\left[\begin{array}{c}
q, q ; q^{2}, \frac{d}{q} \\
d q
\end{array}\right] \\
& -\frac{\left(d / q^{2}, q, q, q, d^{2} / q ; q^{2}\right)_{\infty}}{\left(d / q, d / q, d q, q^{2} / d, d / q ; q^{2}\right)_{\infty}}{ }_{3} \phi_{2}\left[\begin{array}{c}
d / q, d / q, d / q \\
d^{2} / q, d
\end{array} q^{2}, q^{2}\right] .
\end{aligned}
$$

From here it is evident that

$$
\lim _{d \rightarrow 0}{ }_{3} \phi_{2}\left[\begin{array}{c}
q, q, q  \tag{3.5}\\
d q, q^{4} / d^{\prime}
\end{array} q^{2}, q^{2}\right]=1
$$

Indeed, the first term on the right-hand side of (3.5) converges trivially to 1 , while in the second term everywhere the substitution $d=0$ is fine - and thus produces a well-defined finite value - , except for the factor $\left(q^{2} / d, q^{2}\right)_{\infty}$ in the denominator. However, as $d \rightarrow 0$ (to be precise, we take $d=q^{2} / D$
with $D \rightarrow-\infty$ ), this term becomes unbounded, whence the whole term tends to 0 . Thus, performing this limit, we get

$$
\begin{aligned}
\sum_{n=0}^{\infty} \frac{\left(1-q^{3 n+2}\right)\left(q^{2} ; q^{2}\right)_{n}(q, q, q ; q)_{n}}{\left(1-q^{2}\right)(q ; q)_{n}\left(q^{3}, q^{3}, q^{3} ; q^{2}\right)_{n}} q^{n+\binom{n}{2}} \\
=\frac{\left(q^{4}, q^{2}, q^{2}, q^{2} ; q^{2}\right)_{\infty}}{\left(q, q^{3}, q^{3}, q^{3} ; q^{2}\right)_{\infty}}=\frac{(1-q)^{3}\left(q^{2}, q^{2}, q^{2}, q^{2} ; q^{2}\right)_{\infty}}{\left(1-q^{2}\right)\left(q, q, q, q ; q^{2}\right)_{\infty}}
\end{aligned}
$$

as desired.

## 4. Alternative proofs of the identities of Guo and Liu

In this last section, we provide alternative proofs of (1.4) and (1.5), showing that they can be obtained as special/limiting cases of a quadratic summation formula due to Gasper and Rahman (5).

Proof of (1.4). We start with the quadratic summation formula (cf. [6, Eq. (3.8.12)])

\begin{aligned}
& \sum_{k=0}^{\infty} \frac{1-a q^{3 k}}{1-a} \cdot \frac{(a, b, q / b ; q)_{k}}{\left(q^{2}, a q^{2} / b, a b q ; q^{2}\right)_{k}} \cdot \frac{\left(d, f, a^{2} q / d f ; q^{2}\right)_{k}}{(a q / d, a q / f, d f / a ; q)_{k}} \cdot q^{k} \\
& +\frac{(a q, f / a, b, f / q ; q)_{\infty}}{(a / f, f q / a, a q / d, d f / a ; q)_{\infty}} \cdot \frac{\left(d, a^{2} q / b d, a^{2} q / d f, f q^{2} / d, d f^{2} q / a^{2} ; q^{2}\right)_{\infty}}{\left(a q^{2} / b, a b q, f q / a b, b f / a, a q^{2} / b f ; q^{2}\right)_{\infty}} \\
& \quad \times{ }_{3} \phi_{2}\left[\begin{array}{c}
f, b f / a, f q / a b \\
\left.f q^{2} / d, d f^{2} q / a^{2} ; q^{2}, q^{2}\right]
\end{array}\right. \\
& \quad=\frac{(a q, f / a ; q)_{\infty}}{(a q / d, d f / a ; q)_{\infty}} \cdot \frac{\left(a q^{2} / b d, a b q / d, b d f / a, d f q / a b ; q^{2}\right)_{\infty}}{\left(a q^{2} / b, a b q, b f / a, f q / a b ; q^{2}\right)_{\infty}} .
\end{aligned}
$$

Now replace $f$ by $a^{2} q^{2 N+1} / d$, with $N$ a positive integer. The effect is that, because of the factor $\left(a^{2} q / d f ; q^{2}\right)_{\infty}$, this kills off the second term on the lefthand side. In other words, now this is indeed a genuine summation formula. Now replace $q$ by $q^{2}$ and choose $a=b=q$. Then the above identity reduces to

$$
\begin{align*}
\sum_{k=0}^{\infty} \frac{1-q^{6 k+1}}{1-q} & \cdot \frac{\left(d, q^{4 N+4} / d, q^{-4 N} ; q^{4}\right)_{k}}{\left(q^{4}, q^{4}, q^{4} ; q^{4}\right)_{k}} \cdot \frac{\left(q, q, q ; q^{2}\right)_{k}}{\left(q^{3} / d, d q^{-4 N-1}, q^{4 N+3} ; q^{2}\right)_{k}} \cdot q^{2 k} \\
& =\frac{\left(q^{3}, q^{4 N+3} / d ; q^{2}\right)_{\infty}}{\left(q^{3} / d, q^{4 N+3} ; q^{2}\right)_{\infty}} \cdot \frac{\left(q^{4} / d, q^{4} / d, q^{4 N+4}, q^{4 N+4} ; q^{4}\right)_{\infty}}{\left(q^{4}, q^{4}, q^{4 N+4} / d, q^{4 N+4} / d ; q^{4}\right)_{\infty}} \tag{4.1}
\end{align*}
$$

Finally, we set $d=q^{2}$ and let $N \rightarrow \infty$. Upon little simplification, we arrive at (1.4).

Proof of (1.5). We proceed in a similar manner. In (4.1), we set $d=q^{-2 N}$ with $N$ a positive integer. This yields the identity

$$
\begin{array}{r}
\sum_{k=0}^{\infty} \frac{1-q^{6 k+1}}{1-q} \cdot \frac{\left(q^{-2 N}, q^{6 N+4}, q^{-4 N} ; q^{4}\right)_{k}}{\left(q^{4}, q^{4}, q^{4} ; q^{4}\right)_{k}} \cdot \frac{\left(q, q, q ; q^{2}\right)_{k}}{\left(q^{2 N+3}, q^{-6 N-1}, q^{4 N+3} ; q^{2}\right)_{k}} \cdot q^{2 k} \\
=\frac{\left(q^{3} ; q^{2}\right)_{N}\left(q^{2 N+4} ; q^{4}\right)_{N}^{2}}{\left(q^{4} ; q^{4}\right)_{N}^{2}\left(q^{4 N+3} ; q^{2}\right)_{N}}
\end{array}
$$

Letting $N \rightarrow \infty$, we then obtain (1.5).
