# Asymptotic Stability of Solutions for 1-D Compressible Navier-Stokes-Cahn-Hilliard system

#### Abstract

This paper is concerned with the evolution of the periodic boundary value problem and the mixed boundary value problem for a compressible mixture of binary fluids modeled by the Navier-Stokes-Cahn-Hilliard system in one dimensional space. The global existence and the large time behavior of the strong solutions for these two systems are studied. The solutions are proved to be asymptotically stable even for the large initial disturbance of the density and the large velocity data. We show that the average concentration difference for the two components of the initial state determines the long time behavior of the diffusive interface for the two-phase flow.


Keywords: asymptotic stability, compressible viscous fluid, Navier-Stokes equations, CahnHilliard equations, diffusive interface

## 1 Introduction and Main Result

The evolution for the compressible mixture of binary fluids (e.g. foams, solidification processes, fluid-gas interface etc.) is one of the fundamental problems in hydrodynamical science, and it is attracting more and more attention with the development of modern science and technology. As is well known, the flow of such fluid can be described by the well-known diffusive interface system of equations nonlinearly coupled the Navier-Stokes and Cahn-Hilliard

[^0]equations, called Navier-Stokes-Cahn-Hilliard system [1, 8, 24] as follows:

where the unknown functions $\rho, \mathbf{u}, \mu$ and $\chi$ denote the total density, the mean velocity, the chemical potential and the difference of the two components for the fluid mixture respectively. More precisely, the difference of two components for the fluid mixture is $\chi=\chi_{1}-\chi_{2}$, where $\chi_{i}=\frac{M_{i}}{M}$, and $M_{i}$ denotes the mass concentration of the fluid $i(i=1,2)$ and mass of the components in the representative material volume $V$ respectively. The total density is given by $\rho=\rho_{1}+\rho_{2}$, where $\rho_{i}=\frac{M_{i}}{V}$ denotes the apparent mass density of the fluid $i$. The mean velocity $\mathbf{u}$ is defined as the average velocity given by $\rho \mathbf{u}=\rho_{1} \mathbf{u}+\rho_{2} \mathbf{u} . \partial I(\cdot)$ is the subdifferential of the indicator function $I(\cdot)$ of the set $[-1,1]$. The Cauchy stress-tensor is represented by

and the conventional Newtonian viscous stress is

where $\mathbb{I}$ is the unit matrix, $\nu(\chi)>0, \eta(\chi) \geq 0$ are defined as viscosity coefficients, $\epsilon>0$ is the thickness of the diffuse interface of the fluid mixture, and $f=f(\chi)$ is the potential free energy density. We suppose that $f$ satisfies the Ginzburg-Landau double-well potential non-smooth model which is widely used in [3, 4, 4, 10, 30, 35, 36, 37, and the references therein:

Physically, the pressure $p$ is given by

where $a$ is a positive constant, $\gamma \geq 1$ is the adiabatic constant.
Remark 1.1. Compared to the momentum equation in compressible Navier-Stokes system, An additional force $-\epsilon\left(\nabla \chi \otimes \nabla \chi-\frac{|\nabla \chi|^{2}}{2} \mathbb{I}\right)$ is added in the Cauchy stress tensor, which describes the capillary effect associated with free energy

To avoid the difficulty of the estimation of density gradient, (1.6) was first presented by Abels-Feireisl [1] which is a simplified model of the following total free energy

proposed by Lowengrub and Truskinovsky in [24]. The potential (1.4) is the polynomial nonsmooth approximation of the so-called logarithmic potential suggested by Cahn-Hilliard [6]

where $\theta$ and $\theta_{c}>0$ are positive constants. It follows that $f$ is convex on $(-1,1)$ for $\theta>\theta_{c}$, and has the bistable form for $\theta<\theta_{c}$.

Now let us draw the background on the well-posedness of the solutions for the system (1.1). We begin by recalling the compressible Navier-Stokes system. In 1980, Matsumura-Nishida [25] first proved the global existence of smooth solutions for Navier-Stokes equations for initial data close to a non-vacuum equilibrium. Later, Kawashima-Matsumura [17, MatsumuraNishihara [26]-27] obtained the asymptotic stability for the rarefaction waves and shock waves in one-dimensional successively. We also refer to the papers due to Huang-Li-Matsumura [12], Huang-Matsumura [13], Huang-Matsumura-Xin [14], Huang-Wang-Wang-Yang [15], Shi-Yong-Zhang [31-32] and the references therein, in which the asymptotic stability on the superposition of nonlinear waves are studied.

In the case of diffusive interface model for two immiscible fluids, in order to understand the motion of the interfaces between immiscible fluids, phase field models for mixtures of two constituents were studied over the past century which can be traced to van der Waals [34]. Cahn-Hilliard [6] first replaced the sharp interface into the narrow transition layer across which the fluids may mix, and the famous Cahn-Hilliard equations was proposed to describe these diffusive interfaces between two immiscible fluids, Lowengrub-Truskinovsky [24] added the effect of the motion of the particles and the interaction with the diffusion into Cahn-Hilliard quation, and put forward the Navier-Stokes-Cahn-Hilliard equations. The similar result was established by Abels-Feireisl [1], Anderson-Mcfadden-Wheeler [2] and the references therein. Heida-Málek-Rajagopal [11] and Kotschote [19] generalized these models to non-isentropic case. The global existence of weak solutions in three dimensional was obtained by Abels-Feireisl [1], the method they used is the framework which was introduced by Leray [21] and Lions [22]. Kotschote-Zacher [20] established a local existence and uniqueness result for strong solutions. Ding-Li [8] proved the global existence of strong solution in a bounded domain with initial boundary condition (1.9) in one dimension.

In this paper, on the basis of the previous work outlined above, we begin to study the
large time behavior for the solutions of the system (1.1) in $\Omega \times(0,+\infty)$

where $\Omega \subseteq \mathbb{R}, t \in(0,+\infty)$. We study only two model cases for (1.7):
(i) $L$-periodic boundary case, that is $\Omega=\mathbb{R}$, and

We denote by $C$ and $c$ the positive generic constants without confusion throughout this paper. $L^{2}$ denotes the space of Lebesgue measurable functions on $\mathbb{R}$ which are square integrable, with the norm $\|f\|=\left(\int_{0}^{L}|f|^{2}\right)^{\frac{1}{2}} . H^{l}(l \geq 0)$ denotes the Sobolev space of $L^{2}$ functions $f$ on $\mathbb{R}$ whose derivatives $\partial_{x}^{j} f, j=1, \cdots, l$ are $L^{2}$ functions too, with the norm $\|f\|_{l}=\left(\sum_{j=0}^{l}\left\|\partial_{x}^{j} f\right\|^{2}\right)^{\frac{1}{2}}$. Let

For the periodic boundary condition (i), because the periodic solutions $(\rho, u, \chi)(x, t)$ of (1.7) with the period $L$ in the whole space $\mathbb{R}$ can be regarded as $L$-periodic extensions of that on $[0, L]$, we only need to consider the system (1.7) on the bounded interval $[0, L]$. We introduce the Hilbert space $L_{\mathrm{per}}^{2}(\mathbb{R})$ of locally square integrable functions that are periodic with the period $L$ :

with the norm denoted also by $\|\cdot\|$ (without confusion) which is given by the integral over $[0, L],\|g\|=\left(\int_{0}^{L}|g(x)|^{2} d x\right)^{\frac{1}{2}} . H_{\mathrm{per}}^{l}(\mathbb{R})(l \geq 0)$ denotes the Sobolev space of $L_{\mathrm{per}}^{2}(\mathbb{R})$-functions
$g$ on $\mathbb{R}$ whose derivatives $\partial_{x}^{j} g, j=1, \cdots, l$ are $L_{\text {per }}^{2}$ functions too, with the norm $\|g\|_{l}=$ $\left(\sum_{j=0}^{l}\left\|\partial_{x}^{j} g\right\|^{2}\right)^{\frac{1}{2}}$. Throughout this paper, the initial and boundary data for the density, velocity and concentration difference of two components are assumed to be:

Our main result is that we show the average concentration difference for the two components of the initial state determines the long time behavior of the diffusive interface for the twophase flow. This leads to a separation of two regions for the initial concentration difference: regions $A_{\text {stable }}$ and $A_{\text {unstable }}$, which correspond to the stable and unstable regions.

It should be pointed out that the reason for the classification of stable and unstable regions is just that the energy estimates(please refer to (3.5) and (3.6)) ask for the coefficient $\frac{3 \chi^{2}-1}{\epsilon \rho}$ in parabolic equation (1.20) should be positive. If $\chi \in A_{\text {unstable }}$, it is thus physically unstable and mathematically ill-posed for the two-phase flow, and the phase separation will occur in this region.

Now we will give the global existence and asymptotic stability results as follows.

Theorem 1.1 (Periodic boundary case). Assume that ( $\left.\rho_{0}, u_{0}, \chi_{0}\right)$ satisfies the periodic boundary (1.8) with the regularities given in (1.13) -(1.18), then there exists a unique global strong solution $(\rho, u, \chi)$ of the system (1.7)-(1.8), satisfying that, for any $T>0$, there exists positive constants $m, M>0$ such that

For the mixed initial boundary value problem, we have the following results concerning the asymptotic behavior of the global classical solutions.

Theorem 1.2 (Mixed boundary case). Assume that $\left(\rho_{0}, u_{0}, \chi_{0}\right)$ satisfies the mixed boundary (1.9) with the regularities given in (1.13)-(1.18), then there exists a unique global strong solution $(\rho, u, \chi)$ of the system (1.7),(1.9), satisfying that, for any $T>0$, there exists positive constants $m, M>0$ such that

Remark 1.3. In above theorems, the solutions for two different boundary cases are proved to be asymptotically stable even for the large initial disturbance of the density and the large velocity data.

The key point of the proof for the main theorems is to construct some special energy functions and the approximate systems for (1.7) to get the upper and lower bound of the density and the concentration difference. The outline of this paper is organized as follows. In section 2, we construct an approximate system for (1.7), and obtain the local existence of the solutions for the approximate system. In section 3, we obtain the desired a priori estimates on strong solutions of the approximate system and take the limit for the approximate system, then give the proof of the main theorem 1.1. Moreover, we generalized the Theorem 1.1 to the mixed boundary value problem (1.7) and (1.9), and get the proof of theorem 1.2.

## 2 Local Existence and Uniqueness

In this section, we will give the local existence and uniqueness of the solution for the periodic boundary problem (1.7)-(1.8). For this purpose, we should construct a family of smooth approximate functions for the non-smooth free energy density $f$ (1.4) firstly. This process is strongly motivated by the work of Blowey-Elliott [4. The polynomial part of the free energy density $\frac{1}{4}\left(\chi^{2}-1\right)^{2}$ is replaced by the twice continuously differentiable function $f_{\lambda}$
$(0<\lambda<1)$ :

Moreover, $\left(\rho^{(n)}, u^{(n)}, \chi^{(n)}\right)$ is the Cauchy sequence in $C^{0}\left(\left[0, T_{*}\right] ; H_{\text {per }}^{1}\right) \times C^{0}\left(\left[0, T_{*}\right] ; H_{\text {per }}^{1}\right) \times C^{0}\left(\left[0, T_{*}\right] ; H_{\text {per }}^{1}\right)$. We define $\left(\rho_{\lambda}, u_{\lambda}, \chi_{\lambda}\right)$ the limit of the sequence $\left(\rho^{(n)}, u^{(n)}, \chi^{(n)}\right)$. It is easy to know that ( $\left.\rho_{\lambda}, u_{\lambda}, \chi_{\lambda}\right)$ is the uniqueness solution of the systems (2.8) in the space $\tilde{X}_{\frac{m}{2}, 2 M, 2 B}\left(\left[0, T_{*}\right]\right)$. Finially, letting $\delta \rightarrow 0$, we can easily derive the limit $(v, u, \chi)$ of sequence $\left(\rho^{\delta}, u^{\delta}, \chi^{\delta}\right)$ satisfies, $(v, u, \chi) \in X_{m, M, B}\left(\left[0, T_{0}\right]\right)$, and it is a solution of system (2.8) with the initial data $\left(\rho_{0}, u_{0}, \chi_{0}\right)$. The proof of Proposition 2.1 is completed.

## 3 A Priori Estimates

In this section, we will present the desired estimates and global existence of the solution for the approximate periodic boundary problem (2.8), then we will take the limit of the approximate equation (2.8), and give the proof of the main theorem 1.1. Furthermore, we will extend these results to mixed boundary problem (1.7),(1.9) and obtain the Theorem 1.2. Based on the local existence and the a priori estimates, we may obtain the global solution by the continuity extension argument developed in the previous papers [13]-[14], [26]-[32] and the references therein.

Proposition 3.1. Let $\bar{\chi} \in A_{\text {stable }} \cap[-1,1]$ be fixed. Assume that ( $\rho_{0}, u_{0}, \chi_{0}$ ) satisfies (1.13)(1.18). Then there exist positive constants $C$ and $\varepsilon_{1}$ depending only on $\nu, \epsilon$, such that if

& \leq C \epsilon \lambda\left(\int_{0}^{L} \rho_{\lambda} \mu_{\lambda}^{2} d x+\frac{1}{\epsilon^{2}} \int_{0}^{L} \rho_{\lambda}\left(\frac{\partial f_{\lambda}}{\partial \chi}\left(\rho_{\lambda}, \chi_{\lambda}\right)\right) d x\right)+\frac{1}{2 \epsilon \lambda} \int_{0}^{L} \rho_{\lambda} \beta_{\lambda}^{2} d x, \tag{3.38}
\end{align*}
$$

combining with

$$
\begin{align*}
\epsilon \int_{0}^{L} \rho_{\lambda}\left(\chi_{\lambda}\right)_{x}\left(\beta_{\lambda}\right)_{x} d x & =\epsilon \int_{0}^{L} \rho_{\lambda} \beta_{\lambda}^{\prime}\left(\chi_{\lambda}\right)_{x}^{2} d x \\
& \geq \epsilon \int_{0}^{L} \rho_{\lambda}\left(\beta_{\lambda}^{\prime}\right)^{2}\left(\chi_{\lambda}\right)_{x}^{2} d x \geq \epsilon \int_{0}^{L} \rho_{\lambda}\left(\beta_{\lambda}\right)_{x}^{2} d x \tag{3.39}
\end{align*}
$$

one obtains

$$
\begin{equation*}
\left\|\beta_{\lambda}\right\|_{L^{2}\left(0, T ; L^{2}\right)} \leq C \lambda, \text { and }\left\|\left(\beta_{\lambda}\right)_{x}\right\|_{L^{2}\left(0, T ; L^{2}\right)} \leq C \lambda^{\frac{1}{2}}, \tag{3.40}
\end{equation*}
$$

thus, letting $\lambda \rightarrow 0$, one has $\beta(\chi)=0$, that is,

$$
\begin{equation*}
-1 \leq \chi \leq 1 \tag{3.41}
\end{equation*}
$$

Moreover, by using the compactness theory and the Lions-Aubin argument, combining with the results above, it is easy to know that the system (1.7)-(1.8) has a strong solution ( $\rho, u, \chi$ ) when $\lambda \rightarrow 0$. Therefore, the proof of Proposition 3.1 is completed.

Now we will give the proof of Theorem 1.1. For the global existence, we only need to get rid of the small condition (3.1) in the Proposition 3.1. Noting that the small condition for the initial value $\chi$ only used in (3.5) to get the estimate (3.6), rewriting (3.5) as follows

$$
\begin{equation*}
\frac{1}{2} \frac{d}{d t} \int_{0}^{L} \rho \chi^{2} d x+\frac{1}{\epsilon} \int_{0}^{L} 3 \chi^{2} \chi_{x}^{2} d x+\epsilon \int_{0}^{L} \frac{1}{\rho} \chi_{x x}^{2} d x \leq \frac{1}{\epsilon} \int_{0}^{L} \chi_{x}^{2} d x \tag{3.42}
\end{equation*}
$$

integrating over $[0, T]$, one has

$$
\begin{equation*}
\frac{1}{2} \int_{0}^{L} \rho \chi^{2}(t) d x+\frac{1}{\epsilon} \int_{0}^{L} 3 \chi^{2} \chi_{x}^{2} d x+\epsilon \int_{0}^{T} \int_{0}^{L} \frac{1}{\rho} \chi_{x x}^{2} d x=\frac{1}{\epsilon} \int_{0}^{T} \int_{0}^{L} \chi_{x}^{2} d x+\frac{1}{2} \int_{0}^{L} \rho \chi_{0}^{2} d x \tag{3.43}
\end{equation*}
$$

by using (3.4) and Gronwall's inequality, one obtains similar energy estimates without the small condition (3.1), but the constant $C$ depending on $T$, and the global existence for (1.7)(1.8) is obtained, the uniqueness of this solution can be obtained by the classical method, we omit it. At last, it suffices to present the large time behavior for the solution $(\rho, u, \chi)$ of system (1.7)-(1.8). By using the energy inequality (3.2), combining with Sobolev embedding theorem for periodic functions, one has at once

$$
\begin{align*}
\sup _{x \in[0, L]}|(\rho-\bar{\rho}, \rho u-\overline{\rho u}, \rho \chi-\overline{\rho \chi})(x, t)| & \leq L\left\|\left(\rho_{x},(\rho u)_{x},(\rho \chi)_{x}\right)(t)\right\| \\
& \longrightarrow 0, \text { as } t \rightarrow+\infty, \tag{3.44}
\end{align*}
$$

thus, (1.24) is obtained. Moreover, by the similar way above, we have the proof of Theorem 1.2, the details are omitted here.
