# CLASSIFICATION OF TENSOR DECOMPOSITIONS OF $I_{1}$ FACTORS ASSOCIATED WITH POLY-HYPERBOLIC GROUPS

#### Abstract

We demonstrate von Neumann algebra arising from an icc group $\Gamma$ in Chifan's, Ioana's, and Kida's class of poly- $\mathcal{C}_{\text {rss }}$, such as a poly-hyperbolic group with no amenable factors in its composition series, satisfies the following rigidity phenomenon discovered in DHI16] (see also CdSS17): every tensor decomposition of the $\mathrm{II}_{1}$ factor $L(\Gamma)$ must arise from direct product decomposition of $\Gamma$ by groups which are poly- $\mathcal{C}_{\text {rss }}$. Through heavy usage and developments of the techniques in CdSS15, we improve the second author's and their collaborator's work in CKP14 by providing group-level criteria for determining whether a group von Neumann algebra is prime: $L(\Gamma)$ is prime precisely when the group is indecomposable as a direct product of non-amenable groups. We further demonstrate that all tensor decompositions of finite index subalgebras of $L(\Gamma)$ correspond to a splitting of $\Gamma$ as a product by groups which are also poly- $\mathcal{C}_{\text {rss }}$ up to commensurability.


## 1. Introduction

An important topic in structural properties of $\mathrm{II}_{1}$ factors is the classification of an algebra's tensor decompositions. In his seminal work, Popa provided the first result in this direction by demonstrating that the non-separable von Neumann algebra arising from the free group on uncountably many generators, $L\left(\mathbb{F}_{S}\right)$, cannot written as a tensor product of $\mathrm{II}_{1}$ factors Po83. Popa called von Neumann algebras which exhibit this indecomposability property prime. Primeness results for separable $\mathrm{II}_{1}$ factors remained elusive for over a decade; only after Ge's adaptation of Voiculescu's free probability theory were the separable free group factor(s), $L\left(\mathbb{F}_{n}\right)$ with $n \geq 2$, shown to be prime Ge98. Ge conjectured that the internal structure of $L\left(\mathbb{F}_{n}\right)$ should in fact have greater restriction on relative commutants of subalgebras. By developing $C^{*}$ algebraic methods, Ozawa provided a sweeping generalization of previous works and confirmed Ge's suspicions by proving that all $\mathrm{II}_{1}$ factors arising from non-amenable icc hyperbolic groups are in fact solid, i.e. the relative commutant of any diffuse subalgebra remains amenable. Developing the innovative framework of deformation/rigidity, Popa provided an alternative approach for establishing solidity for the free group factors exclusively contained within von Neumann algebra theory [Po06]. The advent of these methods paved the way for much of intense research activity over the past decade Oz04, OP07, CH08, C108, CP10, Fi10, Si10, Va10, CS11, CSU11, SW11, HV12, Bo12, BHR12, DI12, CKP14, Is14, HI15, Ho15, DHI16, Is16.
1.1. Statement of the main results. In [DHI16], Drimbe, Hoff and Ioana prove that if $\Gamma$ is an icc group which is measure equivalent to a direct product of hyperbolic icc groups, then every tensor decomposition of $L(\Gamma)$ into $\mathrm{II}_{1}$ factors $P_{1} \bar{\otimes} P_{2}$ must arise from direct product decomposition of the group $\Gamma$. In an investigation independent of this project, Chifan,

[^0]Sucpikarnon, and the first author uncovered the same phenomenon occurs the setting of von Neumann algebras arising from a large collection of groups stemming from amalgamated free product and HNN extensions [CdSS17.

A natural extension to the result of [DHI16] is to investigate whether the algebras induced from a subcollection of poly-hyperbolic groups, those whose quotients are non-amenable hyperbolic and more generally Chifan, Ioana and Kida's class Quot ( $\mathcal{C}_{\text {rss }}$ ), admit similar classification of their respective tensor product decompositions. Chifan, Kida, and Pant established primeness for the group von Neumann algebras of icc groups in the collection Quot $\left(\mathcal{C}_{\text {rss }}\right) \cap N C_{1}$ (see [CSU13, Notation 0.1]). Eliminating the assumption that the group lies in the class $N C_{1}$, we combine the methods and results from PV11, PV12, Va13, CIK13, CKP14, CdSS15 to demonstrate that whenever $\Gamma \in \operatorname{Quot}\left(\mathcal{C}_{\text {rss }}\right)$ is an icc group, every decomposition of $L(\Gamma)$ as a tensor product of $\mathrm{I}_{1}$ factors is in correspondence with decomposition $\Gamma$ as a direct product. Moreover, we are also able to show that each factor which decomposes a group $\Gamma$ as a direct product is contained within the collection $\operatorname{Quot}\left(\mathcal{C}_{\text {rss }}\right)$ thereby providing a group-level criterion for deducing primeness of the resulting factors.

Theorem A. Let $\Gamma \in \operatorname{Quot}_{n}\left(\mathcal{C}_{r s s}\right)$ be an icc group and suppose there exist $I I_{1}$ factors $P_{1}, P_{2}$ such that $L(\Gamma) \cong P_{1} \bar{\otimes} P_{2}$. Then there exist subgroups $\Gamma_{1}, \Gamma_{2} \leqslant \Gamma$, a unitary $u \in \mathcal{U}(L(\Gamma))$, positive integers $n_{1}, n_{2}$, and a scalar $t>0$ such that:
(1) $\Gamma=\Gamma_{1} \times \Gamma_{2}$ with $\Gamma_{i} \in \operatorname{Quot}_{n_{i}}\left(\mathcal{C}_{r s s}\right)$ and $n_{1}+n_{2}=n$; and
(2) $P_{1}^{t}=u L\left(\Gamma_{1}\right) u^{*}$ and $P_{2}^{1 / t}=u L\left(\Gamma_{2}\right) u^{*}$.

Recall that A. Connes' landmark result implies that no algebraic information of an icc amenable group $\Gamma$ be recovered from the algebra $L(\Gamma)$ Co76. For instance, $L\left(S_{\infty}\right) \cong$ $L\left(S_{\infty} \times S_{\infty}\right)$, but $S_{\infty}$ does not admit a direct product decomposition. Despite the fact the assignment $\Gamma \mapsto L(\Gamma)$ often fails to retain properties of the underlying group, Theorem A demonstrates that the algebra $L(\Gamma)$ can indeed "remember" the direct product structure of the group $\Gamma$ for a prominent class of groups.

Since the class $\mathcal{C}_{\text {rss }}$ is closed under commensurability, so is each class Quot ${ }_{n}\left(\mathcal{C}_{\text {rss }}\right)$. Notably, this property allows us to classify not only every tensor product decomposition of $L(\Gamma)$ but also classify every tensor product decomposition of finite index subalgebras of $L(\Gamma)$.

Theorem B. Let $\Gamma \in \operatorname{Quot}_{n}\left(\mathcal{C}_{r s s}\right)$ be an icc group and $p \in \mathcal{P}(L(\Gamma))$ be a projection. Suppose there exists $P_{1}, \ldots, P_{k} \subset p L(\Gamma) p$ commuting diffuse subalgebras generating a finite index subalgebra of $p L(\Gamma) p$. Then there exists a projection $p_{i} \in P_{i}$, finite index subfactors $Q_{i} \subset$ $p_{i} P_{i} p_{i}$, groups $\Gamma_{1}, \ldots, \Gamma_{k}$, and a unitary $u \in p L(\Gamma) p$ such that
(1) $Q_{i} \subset p_{i} u^{*} L\left(\Gamma_{i}\right) u p_{i}$ is a finite index inclusion of algebras so that $\Gamma_{i} \in \operatorname{Quot}_{n_{i}}\left(\mathcal{C}_{r s s}\right)$ and $\sum_{i=1}^{k} n_{i}=n$, and
(2) $\Gamma$ is commensurable to $\Gamma_{1} \times \cdots \times \Gamma_{k}$.

In particular, $L(\Gamma)$ is prime if and only if $\Gamma$ is not commensurable to a non-trivial direct product of groups in $\operatorname{Quot}\left(\mathcal{C}_{\text {rss }}\right)$.

As a simple corollary to the theorems above, we obtain a unique prime decomposition similar to that of Ozawa and Popa for these group von Neumann algebras [OP03, Corollary $3]$.

Theorem C. Suppose $\Gamma_{1}, \ldots, \Gamma_{m}$ and $\Lambda_{1}, \ldots, \Lambda_{m}$ are groups such that $\Gamma_{i} \in \operatorname{Quot}_{n_{i}}\left(\mathcal{C}_{r s s}\right)$ and $\Lambda_{i} \in \operatorname{Quot}_{m_{j}}\left(\mathcal{C}_{r s s}\right)$. If $L\left(\Lambda_{i}\right)$ and $L\left(\Gamma_{j}\right)$ are prime $I_{1}$ factors so that $L\left(\Gamma_{1} \times \cdots \times \Gamma_{m}\right) \cong L\left(\Lambda_{1} \times\right.$ $\cdots \times \Lambda_{n}$ ), then $n=m$ and we have $L\left(\Gamma_{i}\right) \cong L\left(\Lambda_{i}\right)$, up to permutation and amplification.
1.2. Comments on the Proof. The class of groups $\mathcal{C}_{\text {rss }}$ is comprised of all groups which satisfy the dichotomy result for the classification of normalizes for crossed products by nonelementary hyperbolic groups of Popa and Vaes [PV12]. We utilize this criterion to infer algebraic and analytic structural properties $\Gamma$ and $L(\Gamma)$, respectively. To give a brief outline of the strategy involved, assume $\Gamma \in \operatorname{Quot}_{n}\left(\mathcal{C}_{\text {rss }}\right)$ is an $n$-step extension by groups in $\mathcal{C}_{\text {rss }}$.

We begin by exploiting the aforementioned analytic aspects of $L(\Gamma)$ to conclude that whenever $\Gamma=\Gamma_{1} \times \Gamma_{2}$, then either: $\Gamma_{1}$ is finite and $\Gamma_{2} \in \operatorname{Quot}_{n}\left(\mathcal{C}_{\mathrm{rss}}\right) ; \Gamma_{2}$ is finite and $\Gamma_{1} \in \operatorname{Quot}_{n}\left(\mathcal{C}_{\mathrm{rss}}\right)$; or there exist positive integers $n_{1}, n_{2}$ so that $\Gamma_{i} \in \operatorname{Quot}_{n_{i}}\left(\mathcal{C}_{\mathrm{rss}}\right)$. This result holds in greater generality. If we instead assume $\Gamma$ has two commuting subgroups which generate a finite index subgroup of $\Gamma$, than a parallel statement holds.

In CdSS15, Chifan, Sinclair and the first author prove that whenever two groups $\Gamma$ and $\Lambda$ are such that $\Gamma=\Gamma_{1} \times \cdots \times \Gamma_{k}$ is a $k$-fold product of icc hyperbolic groups such with $L(\Gamma) \cong L(\Lambda)$, then $\Lambda$ is necessarily a $k$-fold product of non-amenable groups. This so-called product rigidity result describes a non-trivial procedure whereby one transfers the existence of commuting algebras into the existence of large commuting subgroups of the mystery group $\Lambda$, which can then be perturbed to decompose the group $\Lambda$ into a non-trivial direct product. Most notably, this provides a case where the analytic properties of the algebra $L(\Lambda)$ can be correlated to algebraic data of the group $\Lambda$. Adapting this procedure to the situation where $\Gamma \in \operatorname{Quot}_{n}\left(\mathcal{C}_{\mathrm{rss}}\right)$ and $L(\Gamma) \cong P_{1} \bar{\otimes} P_{2}$ for some pair $P_{i}$ of $\mathrm{II}_{1}$ factors, then the classification for normalizers allows us to assume that a corner of $P_{1}$ can be embedded, in the sense of Popa, into $L\left(\Gamma_{1}\right)$ for some normal subgroup $\Gamma_{1} \triangleleft \Gamma$. $\Gamma_{1}$ is necessarily an $n-1$-step extension by groups in $\mathcal{C}_{\text {rss }}$. This, in conjunction with intertwining results found within [CKP14], will lead to the following two cases:
(1) A corner of $P_{1}$ is conjugate to a finite index subalgebra of a corner of $L(\Lambda)$, or
(2) A corner of $P_{1}$ and its relative commutant generate a finite index subalgebra of a corner of $L(\Lambda)$.
The former case allows us to identify $P_{1}$ with $L\left(\Gamma_{1}\right)$ and applying a procedure presented in CdSS15] we have that $\Gamma_{1}$ the centralizer $\Gamma_{2}=C_{\Gamma}\left(\Gamma_{1}\right)$ effectively decompose $\Gamma$ as a direct product. While case (2) requires a more detailed analysis, the proof essentially follows the same line of argument as case (1).

## 2. Preliminaries

A von Neumann algebra $M$ is a unital, SOT closed, *-subalgebra of $B(H)$ for some Hilbert space $H$. As proven by Murray and von Neumann , $M \subset B(H)$ is a von Neumann algebra if and only if $M=M^{\prime \prime}$, where $M^{\prime}=\{y \in B(H): x y=x y \forall x \in M\}$ is the commutant of $M$ MvN36]. A von Neumann algebra $M$ is termed a factor if the center is trivial, i.e. $\mathcal{Z}(M)=M \cap M^{\prime} \cong \mathbb{C}$.

Unless explicitly stated, we shall assume all von Neumann algebras considered are separable (in the sense that they act upon a countable Hilbert space) and all inclusions of von Neumann algebras $P \subseteq M$ are considered unital. Whenever $P \subseteq M$ is an inclusion of algebras, $P^{\prime} \cap M$ is the relative commutant of $P$ inside $M$. The center of a von Neumann algebra is $M \cap M^{\prime}$, denoted simply as $\mathcal{Z}(M)$. Given von Neumann subalgebras $P, Q \subset M, P \vee Q$ denotes the smallest subalgebra of $M$ containing both $P$ and $Q$, and if $\left\{P_{i} \subseteq M: i \in I\right\}$ is a collection of von Neumann sub algebras of $M, \bigvee_{i \in I} P_{i}$ denotes the smallest subalgebra of $M$ containing $\bigcup_{i \in I} P_{i}$. If $P \subseteq M$ is a von Neumann subalgebra, the normalizer of $P$ inside $M$ is the subgroup of unitaries $\mathcal{N}_{M}(P)=\left\{u \in \mathcal{U}(M): u P u^{*}=P\right\}$. A von Neumann algebra is tracial if there exists a normal, faithful, tracial state $\tau: M \rightarrow \mathbb{C}$ and finite if $\tau\left(1_{M}\right)=1$. When $M$ is a factor, any tracial state $\tau$ will be the unique such state.

A von Neumann algebra $M$ is type $\mathrm{I}_{1}$ if $M$ is infinite dimensional and is tracial. Whenever $M$ is a type $\mathrm{II}_{1}$ factor, $\tau(\mathcal{P}(M))=[0,1]$. For every scalar $0 \leq t \leq 1$, the amplification of $M$ by $t$ is the von Neumann algebra $M^{t}=p M p$, where $p \in \mathcal{P}(M)$ is any projection with $\tau(p)=t$. It is well-known that the isomorphism class of $M^{t}$ is independent of the choice of projection $p$ since for any projection $q$ such that $\tau(p)=\tau(q)=t$, the algebras $p M p$ and $q M q$ are unitarily conjugate via a unitary in $M$. We may extend the definition $M^{t}$ to all scalars $t>0$ by taking a sufficiently large integer $n$ and projection $p$ in $M_{n}(M)$ with $\tau \circ \operatorname{Tr}_{n}(p)=t$, where $\operatorname{Tr}_{n}: M_{n}(\mathbb{C}) \rightarrow \mathbb{C}$ is the standard trace on $n \times n$ matrices.

To a discrete countable group $\Gamma$, Murray and von Neumann describe how one associates a von Neumann algebra via the left regular representation: Consider the Hilbert space $\ell^{2}(\Gamma)$, the space of square summable sequences indexed by $\Gamma$. For every $\gamma \in \Gamma$, we can define a unitary $u_{\gamma} \in B\left(\ell^{2}(\Gamma)\right)$ by linearly extending the map $u_{\gamma}\left(\delta_{g}\right)=\delta_{\gamma g}$ where the collection $\left\{\delta_{g}\right\}_{g \in \Gamma}$ are the standard basis vectors for $\ell^{2}(\Gamma)$. The group von Neumann algebra $L(\Gamma) \subset$ $B\left(\ell^{2}(\Gamma)\right)$ is the von Neumann algebra generated by the canonical unitaries $\left\{u_{\gamma}\right\}_{\gamma \in \Gamma}$. All groups considered herein will be discrete, unless specified otherwise.

Fix a group discrete $\Gamma$. We denote conjugation of $\gamma \in \Gamma$ by $\lambda \in \Gamma$ as $\gamma^{\lambda}=\lambda^{-1} \gamma \lambda$. For each group element $\gamma \in \Gamma$, and a subset $S \subset \Gamma$ we denote the orbit of $\gamma$ under conjugation by $S$ as $\gamma^{S}=\left\{\gamma^{s}: s \in S\right\}$. A group is said to be of infinite conjugacy class, hereby initialized as icc, if for every $\gamma \in \Gamma \backslash\{e\}$ we have $\left|\gamma^{\Gamma}\right|=\infty$. A well-know result of Murray and von Neumann states the algebra $L(\Gamma)$ is a type $\mathrm{II}_{1}$ factor if and only if $\Gamma$ is an icc group MvN43]. In this case, the the unique normal faithful tracial state $\tau: L(\Gamma) \rightarrow \mathbb{C}$ given by $\tau(x)=\left\langle x \delta_{e}, \delta_{e}\right\rangle$. We let $C_{\Gamma}(S)=\{\gamma \in \Gamma: \gamma s=s \gamma \forall s \in S\}$ denote the centralizer of a set $S \subset \Gamma$, and $\mathcal{V}_{\Gamma}(S)=\left\{\gamma \in \Gamma:\left|\lambda^{S}\right|<\infty\right\}$ will denote the virtual centralizer of $S$ inside $\Gamma$. Given subsets $S, T \subset \Gamma, S T=\{s t: s \in S, t \in T\}$ is the collection of all products of elements in $S$ and $T$.
2.1. Inclusions of Algebras. A von Neumann algebra $M$ is diffuse if there does not exist a non-zero projection $p \in \mathcal{P}(M)$ so that $p M p=\mathbb{C} p$, i.e. $M$ does not contain any minimal projections. $M$ is prime if $M$ cannot be written as a tensor product of any two diffuse von Neumann algebras.

Given a tracial von Neumann algebra $(M, \tau)$, we define $L^{2}(M)$ as the Hilbert space completion of $M$ with regards to the sesquilinear form $\tau: M \times M \rightarrow \mathbb{C}$ given by $\langle x, y\rangle=\tau\left(y^{*} x\right)$. Let $P \subset M$ be an inclusion tracial of von Neumann algebras with trace $\tau$. The basic construction Ch79] $\left\langle M, e_{P}\right\rangle \subset \mathbb{B}\left(L^{2}(M)\right)$ is the smallest von Neumann algebra generated by
$M$ and the orthogonal projection $e_{P}: L^{2}(M) \rightarrow L^{2}(P) .\left\langle M, e_{P}\right\rangle$ is endowed with a faithful semi-finite trace $\operatorname{Tr}$ given by $\operatorname{Tr}\left(x e_{P} y\right)=\tau(x y)$, for all $x, y \in M$. Also, we note that $E_{P}:=e_{P \mid M}: M \rightarrow P$ is the unique $\tau$-preserving conditional expectation onto $P$.

If $P \subset M$ is an inclusion of von Neumann algebras, a state $\phi: M \rightarrow \mathbb{C}$ is said to be $P$-central if $\phi(m x)=\phi(x m)$ for every $x \in P$ and every $m \in M$. A tracial von Newmann algebra $(M, \tau)$ is amenable if there exists an $M$-central state $\phi: B\left(L^{2}(M)\right) \rightarrow \mathbb{C}$ so that $\left.\phi\right|_{M}=\tau$. By the celebrated result of A. Connes, a von Neumann algebra is amenable if and only if it is approximately finite dimensional, i.e. $M=\underline{\lim } M_{n}$ for an increasing sequence of finite dimensional algebras $M_{n}$ Co76. In the spirit of Popa's intertwining techniques (see 3.1), Ozawa and Popa described a relative version of this concept which proves useful in the analysis of structural properties of subalgebras.:

Definition 2.1. OP07, Section 2.2] Let $(M, \tau)$ be a tracial von Neumann algebra, $p \in M$ a projection, and $P \subset p M p, Q \subset M$ von Neumann subalgebras. We say that $P$ is amenable relative to $Q$ inside $M$ if there exists a $P$-central state $\phi: p\left\langle M, e_{Q}\right\rangle p \rightarrow \mathbb{C}$ such that $\phi(x)=$ $\tau(x)$, for all $x \in p M p$.

The classical notion of amenability is recovered by letting $Q=\mathbb{C}$. More generally, if $Q$ is amenable and $P$ is amenable relative to $Q$, then $P$ is necessarily amenable. This definition is fruitful for numerous reasons, not the least of which its strong semblance to that definition of relative amenability for groups: as an amenable group Neumann algebra corresponds to an amenable group, so does relative amenability of group von Neumann algebras coincide with relative amenability of the groups, i.e. given a group $\Gamma$ and a pair of subgroups $\Lambda_{1}, \Lambda_{2} \leqslant \Gamma$, then $\Lambda_{1}<\Gamma$ is amenable relative to $\Lambda_{2}$ inside $\Gamma$ is amenable relative to $\Lambda_{2}$ inside $\Gamma$ if and only if $L\left(\Lambda_{1}\right)$ is amenable relative to $L\left(\Lambda_{2}\right)$ inside $L(\Gamma)$. Should the ambient algebra $M$ be understood from context, we simply state that $P$ is amenable relative to $Q$.

Given an inclusion $P \subset M$ of $\mathrm{II}_{1}$ factors, the Jones index of $P \subset M$, denoted $[M: P]$, is the dimension of $L^{2}(M)$ as a (left) $P$ module. For an arbitrary inclusion of tracial von Neumann algebras $P \subset M$, Pimnser and Popa defined a probabilistic notion of index via the conditional expectation from $M$ onto $P$.

Definition 2.2 (Pimsner \& Popa, [PP86]). Let $(M, \tau)$ be a tracial von Neumann algebra with a von Neumann subalgebra P. Let

$$
\lambda=\inf \left\{\left\|E_{P}(x)\right\|_{2}^{2} /\|x\|_{2}^{2}: x \in M_{+}\right\} .
$$

The Pimnser-Popa index of the inclusion $P \subseteq M$ is defined as $[M: P]_{P P}=\lambda^{-1}$, under the convention that $\frac{1}{0}=\infty$.

Theorem 2.3 ( Jo81, PP86]). Suppose $P \subset M$ is an inclusion of tracial von Neumann algebras. Then the following hold:
(1) If $P \subset M$ is an inclusion of $I I_{1}$ factors, then $[M: P]_{P P}=[M: P]$
(2) If $[M: P]_{P P}<\infty$ and $p \in P$ is a projection, $[p M p: p P p]<\infty$;
(3) If $P$ is a $I I_{1}$ factor and $[M: P]_{P P}<\infty$ then $P^{\prime} \cap M$ is finite dimensional;
(4) If $P \subset M$ is an inclusion of $I_{1}$ factors with $[M: P]_{P P}<\infty$, then $\operatorname{dim}_{\mathbb{C}}\left(P^{\prime} \cap M\right)<\infty$.

Whenever $\Gamma$ a discrete group and $\Lambda$ a finite index subgroup, it follows $[L(\Gamma): L(\Lambda)]_{P P}$ is finite as well. In [CdSS15], the authors provide a generalized converse to this fact.

Proposition 2.4 ( CdSS15]). Let $\Omega \leqslant \Lambda \leqslant \Theta$ be groups such that there exists projections $p \in L(\Omega)$ and $z \in L(\Lambda)^{\prime} \cap L(\Theta)$ so that $p z \neq 0$ and $[p L(\Lambda) p z: p L(\Omega) p z]_{P P}<\infty$. Then $[\Lambda: \Omega]<\infty$.

## 3. Popa's intertwining techniques

To describe the structure of von Neumann algebras, Popa introduced a powerful new conceptual framework: deformation/rigidity theory. This methodology includes a powerful criteria for identifying intertwiners between subalgebras of type $\mathrm{II}_{1}$ factors, now called Popa's intertwining-by-bimodules techniques. Much of the recent progress in classifying von Neumann algebras can be largely attributed to this philosophy.

Theorem 3.1 (Popa, [Po03]). Let $(M, \tau)$ be a separable tracial von Neumann algebra and $P, Q$ be two (not necessarily unital) von Neumann subalgebras of $M$. The following are equivalent:
(1) There exist non-zero projections $p \in P, q \in Q$, a*-homomorphism $\theta: p P p \rightarrow q Q q$ and a non-zero partial isometry $v \in q M p$ such that $\theta(x) v=v x$, for all $x \in p P p$.
(2) Let $\mathcal{G} \subset P$ be a group of unitaries generating $P$. There is no sequence $u_{n} \in \mathcal{G}$ satisfying $\left\|E_{Q}\left(x u_{n} y\right)\right\|_{2} \rightarrow 0$, for all $x, y \in M$.

If either of the equivalent conditions hold, we say $P$ intertwines into $Q$ over $M$, denoted $P \prec_{M} Q$. Should $P z \prec_{M} Q$ for every $z \in P^{\prime} \cap M$, then we say $P$ strongly intertwines into $Q$ and denote this property by $P \prec_{M}^{s} Q$. Whenever the ambient algebra $M$ is clear from context, we suppress the subscript and write $P \prec Q$ (or $P \prec^{s} Q$ ) whenever $P$ (strongly) intertwines into $Q$.

Fix a trace preserving action $\Gamma \curvearrowright(N, \tau)$ of a group $\Gamma$ on a tracial von Neumann algebra $(N, \tau)$ and let $S$ be a collection of subgroups of $\Gamma$. A set $\mathcal{F} \subset \Gamma$ is small relative to $\mathcal{S}$ if $\mathcal{F}$ is contained in a finite union of left/right translates of groups in $\mathcal{S}$, i.e. there exist a finite collection $g_{1}, \ldots, g_{j}, h_{1}, \ldots h_{j} \in \Gamma, \Sigma_{i} \in S$ so that $\mathcal{F} \subset \bigcup_{i=1}^{j} g_{i} \Sigma_{i}$ BO08]. Clearly, if $S$ is a collection of normal subgroups of $\Gamma$, then we need only consider right translates of $S$. A resource detailing the interplay between small sets and intertwining techniques can be found in Va10].

In general, if $P_{1}, P_{2} \subset M$ are subalgebras such that $P_{1}$ and $P_{2}$ both intertwine into a common algebra $Q$, one cannot make any conclusion about $P_{1} \cap P_{2}$ or $P_{1} \vee P_{2}$ without additional assumptions. We proceed by describing an instance where if one has multiple commuting subalgebras $P_{1}, \ldots, P_{k}$ of $M$ each of which strongly intertwine into subalgebras $Q_{1}, \ldots, Q_{k}$ respectively, one can construct a common subalgebra $Q \subset M$ where $\bigvee_{i=1}^{k} P_{i} \prec Q$.
Proposition 3.2. Let $\Gamma \curvearrowright(N, \tau)$ be a trace preserving action of a group on a $I I_{1}$ factor $N$ and denote by $M=N \rtimes \Gamma$.

Suppose there exists normal subgroups $\Sigma_{1}, \ldots, \Sigma_{k} \triangleleft \Gamma$ and pairwise commuting subalgebras $P_{1}, \ldots, P_{k} \subset M$ so that $P_{i} \prec_{M}^{s} N \rtimes \Sigma_{i}$. Then if $\Sigma=\Sigma_{1} \cdots \Sigma_{k}$,

$$
\bigvee_{i=1}^{k} A_{i} \prec_{M} N \rtimes \Sigma
$$

Proof. Given a set $\mathcal{F} \subset \Gamma, P_{\mathcal{F}}$ is the orthogonal projection from $L^{2}(M)$ to the closed linear span of $\left\{n_{g} u_{g}: n_{g} \in n, g \in \mathcal{F}\right\}$. Fixing $1>\varepsilon>0, P_{1} \prec_{M}^{s} N \rtimes \Sigma_{1}$ implies there exists a set
$\mathcal{F}_{1} \subset \bigcup_{i=1}^{j} \Sigma_{1} \gamma_{i}$ small relative to $\Sigma_{1}$ so that

$$
\left\|a_{1}-\mathcal{P}_{\mathcal{F}_{1}}\left(a_{1}\right)\right\|<\varepsilon / 2
$$

Recursively choose $\mathcal{F}_{i} \subset \cup_{j=1}^{j_{i}} \Sigma_{i} \gamma_{j, i}$ small relative to $\Sigma_{i}$ so that whenever $a_{i} \in A_{i}$ with $\left\|a_{i}\right\| \leq 1$ we have

$$
\begin{equation*}
\left\|a_{i}-\mathcal{P}_{\mathcal{F}_{i}}\left(a_{i}\right)\right\| \leq \varepsilon /\left(k j_{1} \cdots j_{i-1}\right) \tag{1}
\end{equation*}
$$

Now since the algebras $P_{1}, \ldots, P_{k}$ pairwise commute, we see

$$

\left\|a_{1} \cdots a_{k}-\mathcal{P}_{\mathcal{F}}\left(a_{1} \cdots a_{k}\right)\right\|_{2} \leq\left\|a_{1} \cdots a_{k}-\mathcal{P}_{\mathcal{F}_{1}}\left(a_{1}\right) \cdots \mathcal{P}_{\mathcal{F}_{k}}\left(a_{k}\right)\right\|_{2} \tag{2}
\end{equation*}
$$

Combining equations 1 and (2), we now have

\begin{aligned}
&\left\|a_{1} \cdots a_{k}-\mathcal{P}_{\mathcal{F}}\left(a_{1} \cdots a_{k}\right)\right\|_{2} \leq\left\|\left(a_{1}-\mathcal{P}_{\mathcal{F}_{1}}\left(a_{1}\right)\right)\left(a_{2} \cdots a_{k}\right)\right\|_{2} \\
&+\left\|\mathcal{P}_{\mathcal{F}_{1}}\left(a_{1}\right)\left(a_{2} \cdots a_{k}-\mathcal{P}_{\mathcal{F}_{2}}\left(a_{1}\right) \cdots \mathcal{P}_{\mathcal{F}_{k}}\left(a_{k}\right)\right)\right\|_{2} \\
& \leq \varepsilon / k+\left\|\mathcal{P}_{\mathcal{F}_{1}}\left(a_{1}\right)\left(a_{2} \cdots a_{k}-\mathcal{P}_{\mathcal{F}_{2}}\left(a_{1}\right) \cdots \mathcal{P}_{\mathcal{F}_{k}}\left(a_{k}\right)\right)\right\|_{2}
\end{aligned}
$$

Since $\mathcal{F}_{1}$ is contained $j_{1}$ left translates of $\Sigma_{1},\left\|\mathcal{P}_{\mathcal{F}_{1}}\left(a_{1}\right)\right\|_{2} \leq j_{1}\left\|a_{1}\right\|_{2}$. Thus the inequality above implies

\begin{aligned}
\left\|a_{1} \cdots a_{k}-\mathcal{P}_{\mathcal{F}}\left(a_{1} \cdots a_{k}\right)\right\|_{2} \leq & \varepsilon / k+j_{1}\left\|a_{1}\right\|\left\|a_{2} \cdots a_{k}-\mathcal{P}_{\mathcal{F}_{2}}\left(a_{1}\right) \cdots \mathcal{P}_{\mathcal{F}_{k}}\left(a_{k}\right)\right\|_{2} \\
\leq & \varepsilon / k+j_{1}\left\|\left(a_{2}-\mathcal{P}_{\mathcal{F}_{2}}\left(a_{2}\right)\right)\left(a_{3} \cdots a_{k}\right)\right\|_{2} \\
& +j_{1}\left\|\mathcal{P}_{\mathcal{F}_{2}}\left(a_{2}\right)\left(a_{3} \cdots a_{k}-\mathcal{P}_{\mathcal{F}_{3}}\left(a_{3}\right) \cdots \mathcal{P}_{\mathcal{F}_{k}}\left(a_{k}\right)\right)\right\|_{2} \\
\leq & \varepsilon / k+j_{1}\left\|a_{2}-\mathcal{P}_{\mathcal{F}_{2}}\left(a_{2}\right)\right\|_{2} \\
& j_{1}\left\|\mathcal{P}_{\mathcal{F}_{2}}\left(a_{2}\right)\left(a_{3} \cdots a_{k}-\mathcal{P}_{\mathcal{F}_{3}}\left(a_{3}\right) \cdots \mathcal{P}_{\mathcal{F}_{k}}\left(a_{k}\right)\right)\right\|_{2} \\
\leq & 2 \varepsilon / k+j_{1} j_{2}\left\|a_{3} \cdots a_{k}-\mathcal{P}_{\mathcal{F}_{3}}\left(a_{3}\right) \cdots \mathcal{P}_{\mathcal{F}_{k}}\left(a_{k}\right)\right\|_{2} .
\end{aligned}
$$

Repeated application of this procedure will then yield

$$

\left\|a_{1} \cdots a_{k}-\mathcal{P}_{\mathcal{F}}\left(a_{1} \cdots a_{k}\right)\right\|_{2}<\varepsilon \tag{3}

Note that the normality of the groups $\Sigma_{i}$ yield that the set $\mathcal{F}=\mathcal{F}_{1} \cdots \mathcal{F}_{k}$ is contained in a finite union of right translates of $\Sigma=\Sigma_{1} \cdots \Sigma_{k} \triangleleft \Gamma$. Thus there exist $\lambda_{1}, \cdots, \lambda_{n} \in \Gamma$ so that

$$
\mathcal{F} \subset \bigcup_{i=1}^{n} \Sigma \lambda_{i}
$$

Thus $\left\|\sum_{i=1}^{n} P_{\mathcal{F}}\left(a_{1} \cdots a_{k} u_{\lambda_{i}}\right)\right\|_{2}^{2} \geq\left\|\mathcal{P}_{\mathcal{F}}\left(a_{1} \cdots a_{k}\right)\right\|_{2}^{2}>1-\varepsilon$ for every $a_{-} \in P_{i}$ with $\left\|a_{i}\right\| \leq 1$.

$$
\sum_{i=1}^{n}\left\|E_{N \rtimes \Sigma}\left(w u_{\lambda_{i}}\right)\right\|_{2}^{2} \geq\left\|\sum_{i=1}^{n} E_{N \rtimes \Sigma}\left(w u_{\lambda_{i}}\right)\right\|_{2}^{2}>1-\varepsilon
$$

where $w$ is any unitary of the form $w=u_{1} \cdots u_{k}$ with $u_{i} \in \mathcal{U}\left(P_{i}\right)$. As unitaries of this form generate $P_{1} \vee \cdots \vee P_{k}$, Theorem 3.1 establishes the result.

## 4. Finite Step Extensions of Groups

Fixing a class of groups $\mathcal{C}$, a discrete countable group $\Gamma$ is a finite step extension by $\mathcal{C}$ if there exists a exists a chain of groups and homomorphisms

$$
\begin{equation*}
\Gamma=\Gamma_{n} \xrightarrow{\pi_{n}} \Gamma_{n-1} \xrightarrow{\pi_{n-1}} \cdots \xrightarrow{\pi_{2}} \Gamma_{1} \xrightarrow{\pi_{f}} 1 \tag{4}
\end{equation*}
$$

such that for every $1 \leq k \leq n, \pi_{k}: \Gamma_{k} \rightarrow \Gamma_{k-1}$ is a surjective homomorphism with $\operatorname{ker}\left(\pi_{k}\right) \in$ $\mathcal{C}$. For each $n \in \mathbb{N}, \operatorname{Quot}_{n}(\mathcal{C})$ denotes the collection of all groups which are $n$-step extensions by $\mathcal{C}$. We denote the collection of all finite step extension by $\mathcal{C}$ by $\operatorname{Quot}(\mathcal{C})=\cup \operatorname{Quot}_{n}(\mathcal{C})$. Combining the results in both [CIK13] and [CKP14], we have the following facts for the collection of groups $\operatorname{Quot}(\mathcal{C})$.

Proposition 4.1 (CIK13,CKP14]). Let $\mathcal{C}$ be any class of groups.
(1) If $\rho: \Lambda \rightarrow \Gamma$ with $\Gamma \in \operatorname{Quot}_{n}(\mathcal{C})$ and $\operatorname{ker}(\rho) \in \mathcal{C}$, then $\Lambda \in \operatorname{quot}_{n+1}(\mathcal{C})$.
(2) If $\Gamma_{i} \in \operatorname{Quot}_{n_{i}}(\mathcal{C}), \Gamma_{1} \times \cdots \times \Gamma_{k} \in \operatorname{Quot}_{n_{1}+\cdots+n_{k}}(\mathcal{C})$.
(3) If $\mathcal{C}$ is closed under commensurability (up to finite kernel), then so is $\operatorname{Quot}_{n}(\mathcal{C})$.
(4) If $\Gamma \in \operatorname{Quot}_{n}(\mathcal{C})$ with $\pi_{n}: \Gamma_{k} \rightarrow \Gamma_{k-1}$ a family as in the definition of $\operatorname{Quot}_{n}(\mathcal{C})$ and $\rho_{k}:=\pi_{2} \circ \cdots \circ \pi_{n}$, then ker $\rho_{n} \in \operatorname{Quot}_{n-1}(C)$.

A generalization of part (4) of Proposition 4.1 may be verified using the following construction. Given any group $\Gamma \in \operatorname{Quot}_{n}(\mathcal{C})$ with $n>2$ we may recursively define the following family of groups: First let $\Gamma_{n}^{(0)}=\Gamma_{n}$. For $0<j \leq n-1$, suppose we have

$$
\Gamma_{n}^{(j-1)} \xrightarrow{\pi_{n}} \Gamma_{n-1}^{(j-1)} \xrightarrow{\pi_{n-1}} \cdots \xrightarrow{\pi_{j+1}} \Gamma_{j}^{(j-1)} \rightarrow 1
$$

with be a sequence of surjections with $\operatorname{ker}\left(\pi_{i}\right) \in \mathcal{C}$. Defining $\rho_{k}^{(j-1)}=\pi_{j+1} \circ \cdots \circ \pi_{k}$ and $\Gamma_{k}^{(j)}=\operatorname{ker} \rho_{k}^{(j-1)}$, by appropriately restricting $\pi_{k}$ we now have

$$
\Gamma_{n}^{(j)} \xrightarrow{\pi_{n}} \Gamma_{n-1}^{(j)} \xrightarrow{\pi_{n-1}} \cdots \xrightarrow{\pi_{j+1}} \Gamma_{j}^{(j)}=1
$$

is a chain satisfying the conditions implying $\Gamma_{n}^{(j)} \in \operatorname{Quot}_{n-j}(\mathcal{C})$. More generally we have for $0 \leq j<k \leq n$ :

- $\Gamma_{k}^{(j)} \in \operatorname{Quot}_{k-j}(\mathcal{C})$,
- $\Gamma_{k}^{(j)} \triangleright \Gamma_{k}^{(j-1)}$,
- $\Gamma_{k}^{(j)} / \Gamma_{k}^{(j-1)} \in \mathcal{C}$,
- $\Gamma_{n} \triangleright \Gamma_{n}^{(1)} \triangleright \cdots \triangleright \Gamma_{n}^{(n-1)} \triangleright 1$ with $\Gamma_{n-1}^{(j)} / \Gamma_{n}^{(j+1)} \in \mathcal{C}$

Hence an equivalent characterization of $\Gamma \in \operatorname{Quot}_{n}(\mathcal{C})$ is $\Gamma$ is poly-C with Hirsch length $n$.
If $\mathcal{C}$ is a class of groups closed under commensurability (up to finite kernel), then we generalize the definition of $\operatorname{Quot}_{n}(\mathcal{C})$ there exists a chain as in (4)

$$
\begin{equation*}
\Gamma_{n} \rightarrow \Gamma_{n-1} \rightarrow \cdots \rightarrow \Gamma_{1} \rightarrow 1 \tag{5}
\end{equation*}
$$

with $\Gamma$ commensurable (up to finite kernel) to $\Gamma_{n}$. In this situation, we must take care as commensurabilty may introduce unexpected variability. For instance, if we take the family of all non-amenable free groups $\mathcal{F}$, naturally $\mathbb{F}_{4} \in \operatorname{Quot}_{1}(\mathcal{F})$. The cannonical surjection $\mathbb{F}_{4} \rightarrow \mathbb{F}_{2}$ demonstrates the fact $\mathbb{F}_{4} \in \operatorname{Quot}_{2}(\mathcal{F})$. In general, $\mathbb{F}_{2 n} \in \operatorname{Quot}_{n}(\mathcal{F})$. As all nonamenable free groups are commensurable, $\mathbb{F}_{2} \in \operatorname{Quot}_{n}(\mathcal{F})$ for every $n$. Thus we impose the following minimality condition in the definition of $\operatorname{Quot}_{n}(\mathcal{C})$ :

Definition 4.2. Let $\mathcal{C}$ be a class of groups closed under commensurabilty (up to finite kernel). $\Gamma \in \operatorname{Quot}(\mathcal{C})$ if there exists a chain of surjections

$$
\Gamma_{n} \xrightarrow{\pi_{n}} \Gamma_{n-1} \xrightarrow{\pi_{n-1}} \cdots \xrightarrow{\pi_{2}} \Gamma_{1} \xrightarrow{\pi_{7}} 1
$$

so that $\Gamma$ is commensurable to $\Gamma_{n}, \operatorname{ker}\left(\pi_{k}\right) \in \mathcal{C} . \Gamma \in \operatorname{Quot}_{n}(\mathcal{C})$ if $n$ is the smallest positive integer such that $\Gamma$ is a $k$-step extension by $\mathcal{C}$.

## 5. Relative Strong Solidity and Poly-Hyperbolic Groups

A von Neumann algebra $M$ is said to be solid if for any diffuse subalgebra $D \subset M$, the relative commutant $D^{\prime} \cap M$ is amenable; $M$ is strongly solid if the normalizer $\mathcal{N}_{M}(A)$ of any diffuse amenable subalgebra $A \subseteq M$ generates an amenable subalgebra of $M$. When $M$ is non-amenable, strong solidity implies solidity, which in turn yields primeness.

Definition 5.1 ( [CKP14]). Given a group $\Sigma, \mathcal{C}_{r s s}(\Sigma)$ is the collection of all non-amenable, exact groups containing $\Sigma$ as a proper malnormal subgroup so that the following holds:
Assume $\Gamma \curvearrowright N$ is any trace preserving action on a tracial von Neumann algebra $N$ and denote $M=N \rtimes \Gamma$. Let $p \in M$ be a projection and $P \subset p M p$ a subalgebra amenable relative to $N \rtimes \Sigma$. Then either
(1) $P \prec_{M} B \rtimes \Sigma$, or
(2) $\mathcal{N}_{p M p}(P)^{\prime \prime}$ is amenable relative to $N \rtimes \Sigma$.

Our work concerns the case where $\Sigma=\{e\}$ and thus for ease of notation we set $\mathcal{C}_{\text {rss }}:=$ $\mathcal{C}_{\text {rss }}(\{e\})$. The following is a summary of known facts of the class $\mathcal{C}_{\text {rss }}$
(1) PV11 Any weakly amenable group with positive first $\ell^{2}$-Betti number is in $\mathcal{C}_{\text {rss }}$.
(2) PV12 Any non-amenable, weakly amenable, biexact group is in $\mathcal{C}_{\text {rss }}$, e.g. nonamenable hyperbolic groups.
(3) VV14 $\mathcal{C}_{\text {rss }}$ is closed under commensurabilty up to finite kernel.

If $\mathcal{F}$ denotes the collection of groups commensurable to the non-amenable free groups, $\mathcal{H}$ non-elementary hyperbolic groups and all non-amenable, non-trivial free product of exact groups, then we have the following elementary inclusions:

$$
\mathcal{F} \subset \mathcal{H} \subset \mathcal{C}_{\mathrm{rss}}
$$

Hence all poly-hyperbolic groups no amenable factors in its composition series are each poly$\mathcal{C}_{\text {rss }}$ groups. We note that In view of item (3) above, each collection of groups Quot $_{n}\left(\mathcal{C}_{\text {rss }}\right.$ is closed under commensurability.
5.1. Mixed Surface Braid Groups. Let $M$ be an orientable surface. For every fixed positive integer $k, F_{k}(M)=\left\{\left(x_{1}, \ldots, x_{k}\right) \in M^{k}: x_{i} \neq x_{k} \forall i \neq j\right\}$ denotes the $k$-th configuration space of $M$. The symmetric group $\mathcal{S}_{k}$ acts freely on $F_{k}(M)$ by permutation of the coordinates. The groups $P B_{k}(M):=\pi_{1}\left(F_{k}(M)\right)$ and $B_{k}(M):=\pi_{1}\left(F_{k}(M) / S_{k}\right)$ are the pure braid group of $k$ strands and the braid group of $k$ strands of the surface $M$, respectively. When $M=\mathbb{D}^{2}$. we recover the classical (pure/mixed) braid groups, and in this case we simply denote $B_{k}\left(\mathbb{D}^{2}\right), P_{k}\left(\mathbb{D}^{2}\right)$, or $B_{k, j}\left(\mathbb{D}^{2}\right)$ by $B_{k}, P_{k}$ and $B_{j, k}$, respectively.

Now, fix a pair of positive integers $k$ and $j$. Regarded as a subgroup of $S_{k+j}, S_{k} \times S_{j}$ has a natural free action on $F_{k+j}(M)$ by allowing $S_{k}$ to act on the first $k$ coordinates and $S_{j}$ on the remaining $j$ coordinates. The group $B_{k, j}(M):=\pi_{1}\left(F_{k+j}(M) /\left(S_{k} \times S_{j}\right)\right)$ is the mixed braid group of $(k, j)$ strands. Note that there is a canonical embedding of $B_{k, j}(M)$
into $B_{k, j}(M)$. Following as in CKP14, $\widetilde{P}_{k}, \widetilde{B}_{k, j}$, and $\widetilde{B}_{j}$ will denote the central quotients of the pure, mixed, and standard braid groups.

Fix $j$ distinct points $x_{1}, \ldots, x_{j} \in M$. The map $F_{k+j}(M) /\left(S_{k} \times S_{j}\right) \rightarrow F_{j}(M) / S_{j}$ given by forgetting the first $k$ coordinates is a locally trivial fibration with fiber $F_{k}\left(M \backslash\left\{x_{1}, \ldots, x_{j}\right\}\right.$ called the Fadwell-Newarth fibration. The long exact sequence in homotopy of this fibration yields the following short exact sequence for the mixed braid groups:

$$
\begin{equation*}
\left.1 \rightarrow B_{k}\left(M \backslash\left\{x_{1}, \ldots, x_{j}\right)\right\}\right) \rightarrow B_{k, j}(M) \rightarrow B_{j}(M) \rightarrow 1 \tag{6}
\end{equation*}
$$

provided that $M \neq S^{2}$ or $\mathbb{R} P^{2}$ [FN62, Theorem 3, Corollary 2.2].
Let $M=\Sigma_{0, b}$ be an orientable genus $g=0$ surface with $b$ boundary components. Letting $k, j \geq 3$, Equation (6) becomes

$$
1 \rightarrow B_{k}\left(\Sigma_{0, b+j}\right) \rightarrow B_{k, j}(M) \rightarrow B_{j}(M) \rightarrow 1
$$

where $\Sigma_{0, b+j}$ is a surface with $b+j$ boundary components. Passing to the central quotients, [CKP14, Theorem 3.5] implies that $\widetilde{B}_{k, n}(M) \in \operatorname{Quot}_{k+j-4}(\mathcal{F})$.
5.2. Direct Product Decompositions for $\operatorname{Quot}\left(\mathcal{C}_{\text {rss }}\right)$. Fixing a group $\Gamma$ in $\operatorname{Quot}\left(\mathcal{C}_{\text {rss }}\right)$, we begin by demonstrating that the existence of large commuting subgroups $\Sigma_{1}, \Sigma_{2}$ inside the group $\Gamma$ implies the existence of a virtual splitting of the group as a direct product. Essentially, we perturb the groups $\Sigma_{i}$ to commensurable groups $\Lambda_{i} \leqslant \Gamma$ so that $\Lambda_{1} \times \Lambda_{2}$ are $\Gamma$ are commensurable. This is achieved by examining the relationship between the analytic properties and algebraic properties of groups in the class $\mathcal{C}$ rss and subsequently investigating how these properties translate to all groups in Quot $\left(\mathcal{C}_{\text {rss }}\right)$.

Lemma 5.2. Let $p \in L(\Gamma)$ be a projection and $A, B \subset p L(\Gamma) p$ be two diffuse commuting subalgebras of $p L(\Gamma) p$ with $\Gamma \in \mathcal{C}_{\text {rss }}$. Then $[p L(\Gamma) p: A \vee B]_{P P}=\infty$. In particular if $\Sigma_{1}, \Sigma_{2}<\Gamma$ are commuting subgroups such that $\left[\Gamma: \Sigma_{1} \Sigma_{2}\right]<\infty$, then either $\Sigma_{1}$ or $\Sigma_{2}$ is finite.

We omit the proof, as it is the base step of the induction argument of the main theorem of [CKP14].

Proposition 5.3. $\Gamma \in \operatorname{Quot}_{n}\left(\mathcal{C}_{\text {rss }}\right)$. Suppose there exist infinite groups such that $\Gamma$ is commensurable to $\Sigma_{1} \times \Sigma_{2}$. Then we may find $n_{1}, n_{2}>0$ such that $n_{1}+n_{2}=n$ with $\Sigma_{i} \in \operatorname{Quot}_{n_{i}}\left(\mathcal{C}_{r s s}\right)$.

Proof. As $\Gamma \in \operatorname{Quot}_{n}\left(\mathcal{C}_{\mathrm{rss}}\right)$, there exists a chain

$$
\begin{equation*}
\Gamma_{n} \xrightarrow{\pi_{n}} \Gamma_{n-1} \xrightarrow{\pi_{n-1}} \cdots \xrightarrow{\pi_{2}} \Gamma_{1} \xrightarrow{\pi_{1}} 1 \tag{7}
\end{equation*}
$$

with $\Gamma$ commensurable to $\Gamma_{n}$. As Quot $_{j}\left(\mathcal{C}_{\text {rss }}\right)$ is closed under commensurability for all $j$, after passing to a finite index subgroup, we may assume $\Sigma_{1} \times \Sigma_{2}=\Gamma_{n}$.

Let $\rho_{n}: \Gamma_{n} \rightarrow \Gamma_{1}$ be given by the concatenation of the homomorphisms given in (7). Note $\rho_{n}\left(\Sigma_{1} \times\{e\}\right), \rho_{n}\left(\{e\} \times \Sigma_{2}\right)$ are commuting groups generating $\Gamma_{1}$. Lemma 5.2 implies either $\rho_{n}\left(\Sigma_{1} \times\{e\}\right)$ or $\rho_{n}\left(\{e\} \times \Sigma_{2}\right)$ is finite. Symmetry allows us to assume $\operatorname{ker}\left(\left.\pi_{n}\right|_{\Sigma_{1}}\right)=\Sigma<\Sigma_{1}$ is a finite index normal subgroup of $\Sigma_{1}$ with $\Sigma<\operatorname{ker}\left(\rho_{n}\right)=\Gamma_{n}^{(1)} . \Sigma \times \Sigma_{2}$ is a finite index subgroup of $\Gamma_{n}$. If we restrict $\rho_{n}$ to $\Sigma \times \Sigma_{2}$, a simple calculation yields $\Gamma_{n}^{(1)}=\Sigma \times \Lambda$ where
$\Lambda=\operatorname{ker}\left(\left.\rho_{n}\right|_{\Sigma_{2}}\right)$. Thus we have

$$
\begin{equation*}
\frac{\Sigma_{2}}{\Lambda} \cong \frac{\Sigma \times \Sigma_{2}}{\Sigma \times \Lambda}<\frac{\Gamma_{n}}{\Gamma_{n}^{(1)}} \in \mathcal{C}_{\mathrm{r} s s} \tag{8}
\end{equation*}
$$

Since $\Gamma$ is commensurable to $\Sigma \times \Sigma_{2}$, the inclusion in (8) is a finite index inclusion of groups. Thus $\Sigma_{2} / \Lambda \in \mathcal{C}_{\text {rss }}$.

When $n=2$, we have $\Gamma_{2}^{(1)} \in \mathcal{C}_{\text {rss }}$ and $\Gamma_{2}^{(1)}=\Sigma \times \Lambda$ Lemma 5.2 implies $\Lambda$ is finite. Thus $\Sigma$ is commensurable to $\Gamma_{n}^{(1)}$ yielding $\Sigma \in \operatorname{Quot}_{1}\left(\mathcal{C}_{\text {rss }}\right)$. Since $\Lambda \triangleleft \Sigma_{2}$ and $\Lambda$ is finite, passing to a finite index subgroup of both $\Lambda$ and $\Sigma_{2}$, (8) shows $\Sigma_{2} \in \mathcal{C}_{\text {rss }}$.

Now if the result holds for all groups in Quot $_{n-1}\left(\mathcal{C}_{\text {rss }}\right)$ up to some integer $n-1$, we have $\Gamma_{n}^{(1)} \in \operatorname{Quot}_{n-1}\left(\mathcal{C}_{\text {rss }}\right)$ with $\Gamma_{n}^{(1)}=\Sigma \times \Lambda$. If $\Lambda$ is a finite group, then repeating the argument when $n=2$ proves the result for $n$. If instead $\Lambda$ is an infinite group, then by the induction hypothesis, we may find $n_{1}, n_{2}>0$ so that $n_{1}+n_{2}=n-1, \Sigma \in \operatorname{Quot}_{n_{1}}\left(\mathcal{C}_{\text {rss }}\right)$, and $\Lambda \in \operatorname{Quot}_{n_{2}}\left(\mathcal{C}_{\text {rss }}\right)$. By (8), we then have $\Sigma_{2} \in \operatorname{Quot}_{n_{2}+1}\left(\mathcal{C}_{\mathrm{rss}}\right)$. Furthermore, $\Sigma_{1}$ is commensurable to $\Sigma$ which by Propositions 4.1 ensures $\Sigma_{1} \in$ Quot $_{n_{1}}\left(\mathcal{C}_{\mathrm{rss}}\right)$.
Corollary 5.4. Let $\Gamma \in$ Quot $_{n}\left(\mathcal{C}_{r s s}\right)$ and suppose $\Gamma$ is commensurable to $\Sigma_{1} \times \Sigma_{2}$ with $\Sigma_{1} \in \operatorname{Quot}_{j}(\mathcal{C})$ for some $j \in \mathbb{N}$. Then either $n=j$ and $\Sigma_{2}$ is finite, or $j<n$ and $\Sigma_{2} \in$ Quot $_{n-j}\left(\mathcal{C}_{r s s}\right)$.
Proof. By the minimality constraint in Definition 4.2, we naturally have $j \leq n$. If $j=n$ and $\Sigma_{2}$ were infinite, Proposition 5.3 yields $\Sigma_{i} \in \operatorname{Quot}_{n_{i}}(\mathcal{C})$ for some $n>n_{i} \geq 1$, once again contradicting minimality.

Now suppose $1 \leq j<n$. If $n=2$, by Proposition 5.3, we have the result. We momentarily define Quot $_{0}\left(\mathcal{C}_{\text {rss }}\right)$ as the collection of all finite groups. Proceeding as in the proof of the previous proposition, we have either
(1) $\Gamma_{n}^{(1)}$ is commensurable to $\Sigma_{1} \times \Lambda_{2}$
(2) $\Gamma_{n}^{(1)}$ is commensurable to $\Lambda_{1} \times \Sigma_{2}$,
where $\Lambda_{i}=\operatorname{ker}\left(\left.\rho_{n}\right|_{\Sigma_{i}}\right)$. In case (1), $\Sigma_{1} \in \operatorname{Quot}_{a}\left(\mathcal{C}_{\text {rss }}\right)$ and $\Lambda_{2} \in \operatorname{Quot}_{b}\left(\mathcal{C}_{\text {rss }}\right)$, for $a, b \geq 0$ with $a+b=n-1$. Hence $\Sigma_{2} \in$ Quot $_{b+1}\left(\mathcal{C}_{\mathrm{rss}}\right)$ By minimality $a \geq j$. If $a>j$, this would imply $\Gamma \in \operatorname{Quot}_{j+b+1}\left(\mathcal{C}_{\text {rss }}\right)$ where $j+b+1<n$ once again contradicting minimality. In case (2), a similar argument will guarantee $\Lambda \in \operatorname{Quot}_{j-1}\left(\mathcal{C}_{\text {rss }}\right)$ and thus $\Sigma \in \operatorname{Quot}_{n-j}\left(\mathcal{C}_{\text {rss }}\right)$.

Further analysis of the claims above yields the following stronger statement. We will omit the proof as it follows almost identically

Corollary 5.5. Let $\Gamma \in \operatorname{Quot}_{n}\left(\mathcal{C}_{r s s}\right)$. Suppose we have a chain witnessing $\Gamma \in \operatorname{Quot}_{n}(\mathcal{C})_{r s s}$

$$
\Gamma_{n} \xrightarrow{\pi_{n}} \Gamma_{n-1} \xrightarrow{\pi_{n-1}} \cdots \xrightarrow{\pi_{2}} \Gamma_{1} \xrightarrow{\pi_{1}} 1
$$

with $\left[\Gamma_{n}: \Sigma_{1} \Sigma_{2}\right]<\infty$ for some infinite commuting groups $\Sigma_{1}, \Sigma_{2}<\Gamma_{n}$. Then there exists $n_{1}, n_{2}>0$ so that $n_{1}+n_{2}=n$ so that $\Sigma_{i} \in \operatorname{Quot}_{n_{i}}\left(\mathcal{C}_{r s s}\right)$. Furthermore, if a priori we have $\Sigma_{1} \in$ Quot $_{j}$, then $\Sigma_{2} \in \operatorname{Quot}_{n-j}\left(\mathcal{C}_{r s s}\right)$.

## 6. Proof of the Main Theorem

Through their analysis of the generalized comultiplication map described within [CIK13], Chifan, Kida, and the second authors work in [CKP14] establish primeness results for the
algebras coming from a large natural class of groups. These groups include most mapping class groups, central quotients of pure braid groups, Torelli groups, and Johnson kernels of punctured low-genus surfaces. We further Chifan's, Kida's and the second author's analysis of the algebras coming from groups in Quot $_{n}\left(\mathcal{C}_{\text {rss }}\right)$ by introducing to their work the techniques found within CdSS15. This combined approach will allow us to detect a direct product within the underlying group $\Gamma$ whenever the algebra is non-prime.

To establish the main results, we set out the following notation taken [CIK13]. A group homomorphism $\rho: \Gamma \rightarrow \Lambda$ lifts $\rho$ to a $*$-homormorphism of von Neumann algebras $\Delta$ : $L(\Gamma) \rightarrow L(\Gamma) \bar{\otimes} L(\Lambda)$ by extending the map $u_{\gamma} \mapsto u_{\gamma} \otimes v_{\rho(\gamma)}$ where $\left\{u_{\gamma}\right\}_{\gamma \in \Gamma},\left\{v_{\lambda}\right\}_{\lambda \in \Lambda}$ are the canonical unitaries of $L(\Gamma)$ and $L(\Lambda)$, respectively. When $\rho: \Gamma \rightarrow \Gamma$ is the identity, this is precisely the compultiplication map along $\Gamma$. For a group $\Gamma \in \operatorname{Quot}_{n}\left(\mathcal{C}_{\mathrm{rss}}\right)$, we will consider the group homomorphism $\rho_{n}: \Gamma_{n} \rightarrow \Gamma_{1}$ as defined in the previous section. If $P_{1}, \ldots, P_{k} \subset M$ are subalgebras of $M$, then $P_{1} \vee \cdots \vee P_{k} \subset M$ is defined to be the smallest von Neumann algebra in $M$ containing $P_{1} \cup \cdots \cup P_{k}$. For every $j \in\{1, \ldots, k\}$, we denote $\hat{P}_{j}:=P_{1} \vee \cdots \vee P_{j-1} \vee P_{j+1} \vee \cdots \vee P_{k}$.
Lemma 6.1. Let $M$ be a type $I I_{1}$ factor with $P_{1}, \ldots, P_{k} \subset M$ diffuse commuting $I I_{1}$ factors such that $P_{1} \vee \cdots P_{k} \subset M$ is a finite index inclusion of algebras. Then there exists a projection $z \in M$ so that $\mathcal{Z}\left(Q_{i} z\right) \cong \mathbb{C}$, where $\mathcal{N}_{M}\left(P_{i}\right)^{\prime \prime}=Q_{i}$.

Proof. Letting $P=P_{1} \vee \cdots \vee P_{k}$, Theorem 2.3 part (d) implies $P^{\prime} \cap M$ is finite dimensional. Notice $P \subset Q_{i}$ for every $i=1, \ldots, k$ since $P_{i}$ and $P_{i}^{\prime} \cap M$ are both subalgebras of $Q_{i}$. Thus $\mathcal{Z}\left(Q_{i}\right)$ is finite dimensional since $\mathcal{Z}\left(Q_{i}\right) \subset Q_{i}^{\prime} \cap M \subset P^{\prime} \cap M$.

Now for any projection $z \in \mathcal{Z}\left(Q_{i}\right)$, we claim $Q_{i} z=\mathcal{N}_{z M z}\left(P_{i} z\right)^{\prime}$. It suffices to show $\mathcal{N}_{M}\left(P_{i}\right) z=\mathcal{N}_{z M z}\left(P_{i} z\right)$. This follows clearly form the following facts: given any unitary $u \in \mathcal{N}_{M}\left(P_{i}\right),(u z)^{*} u z=z=u z(u z)^{*}$; if $v \in \mathcal{U}(z M z)$ is a normalizing unitary of $P_{i} z$, then $v+(1-z) \in \mathcal{U}(M)$ is a normalizing unitary of $P_{i}$.

Since the algebras $\mathcal{Z}\left(Q_{i}\right)$ pairwise commute, we may take any minimal projections $z_{i} \in$ $\mathcal{Z}\left(Q_{i}\right)$ so that $z_{i} z_{j}=z_{j} z_{1} \neq 0$. Then

$$
A z \subset z M z=N
$$

is a finite index inclusion of algebras with $\mathcal{Z}\left(\mathcal{N}_{N}\left(P_{i} z\right)^{\prime \prime}\right)=\mathcal{Z}\left(Q_{i} z\right)=\mathbb{C} z$.
Proposition 6.2. Let $\Gamma \in \operatorname{Quot}_{n}\left(\mathcal{C}_{r s s}\right)$ with $p \in L(\Gamma)$ a non-zero projection. Suppose there exist $A, B \subset p L(\Gamma) p$ diffuse commuting subalgebras so that $[p L(\Gamma) p: A \vee B]_{P P}<\infty$. Then either
(1) $A \prec_{L(\Gamma)} L\left(\Gamma_{n}^{(1)}\right)$, or
(2) $B \prec_{L(\Gamma)} L\left(\Gamma_{n}^{(1)}\right)$.

Proof. First note $n \geq 2$ by Lemma 5.2, Let $P_{0} \subset A$ be an amenable subalgebra. Letting $M=L(\Gamma)$, we see $\Delta\left(P_{0}\right)$ and $\Delta(B)$ are diffuse commuting subalgebras of $M \bar{\otimes} L\left(\Gamma_{1}\right)$ with $\Delta\left(P_{0}\right)$ amenable. Since $\Gamma_{1} \in \operatorname{Quot}_{1}\left(\mathcal{C}_{\mathrm{rss}}\right)=\mathcal{C}_{\mathrm{rss}}$, we have either
(1) $\Delta\left(P_{0}\right) \prec M \bar{\otimes} 1$, or
(2) $\mathcal{N}_{M \otimes \bar{\otimes} L\left(\Gamma_{1}\right)}\left(\Delta\left(P_{0}\right)\right)^{\prime \prime}$ is amenable relative to $M \bar{\otimes} 1$ in $M \bar{\otimes} L\left(\Gamma_{1}\right)$.

Assume (2) holds. Noting $\Delta(B) \subset \mathcal{N}_{M \otimes \bar{\otimes}\left(\Gamma_{1}\right)}\left(\Delta\left(P_{0}\right)\right)^{\prime \prime}$ yields $\Delta(B)$ is amenable relative to $M \bar{\otimes} 1$ inside $M \bar{\otimes} L\left(\Gamma_{1}\right)$. Applying the dichotomy property of $\mathcal{C}_{\text {rss }}$ either

[^1](3) $\Delta(B) \prec_{M \bar{\otimes} L\left(\Gamma_{1}\right)} M \bar{\otimes} 1$, or
(4) $\mathcal{N}_{M \bar{\otimes} L\left(\Gamma_{1}\right)}(\Delta(B))^{\prime \prime}$ is amenable relative to $M \bar{\otimes} 1$ in $M \bar{\otimes} L\left(\Gamma_{1}\right)$.

To summarize we have either
(5) $\Delta\left(P_{0}\right) \prec_{M \bar{\otimes} L\left(\Gamma_{1}\right)} M \bar{\otimes} 1$,
(6) $\Delta(B) \prec_{M \bar{\otimes} L\left(\Gamma_{1}\right)} M \bar{\otimes} 1$, or
(7) $\Delta(A \vee B) \subset \mathcal{N}_{M \bar{\otimes} L\left(\Gamma_{1}\right)}(\Delta(B))^{\prime \prime}$ is amenable relative to $M \bar{\otimes} 1$ in $M \bar{\otimes} L\left(\Gamma_{1}\right)$.

We first show case (7) is impossible. Since $A \vee B$ is a finite index subalgebra of $M, M \prec^{s} A \vee B$ and hence $M$ is amenable relative to $A \vee B$. By OP07, Proposition 2.4], $\Delta(M)$ is amenable relative to $M \bar{\otimes} 1$ in $M \bar{\otimes} L\left(\Gamma_{1}\right)$. However, [CIK13, Proposition 3.5] would imply $\rho(\Gamma)=\Gamma_{1}$ is amenable, a contradiction. Thus we only have case (5) and (6). Since $P_{0}$ was an arbitrary amenable subalgebra of $A$, by [B008] we have either
(8) $\Delta(A) \prec_{M \bar{\otimes} L\left(\Gamma_{1}\right)} M \bar{\otimes} 1$, or
(9) $\Delta(B) \prec_{M \bar{\otimes} L\left(\Gamma_{1}\right)} M \bar{\otimes} 1$.

Noting $\operatorname{ker}\left(\rho_{n}\right)=L\left(\Gamma_{n}^{(1)}\right)$, the result follows from application of [CIK13, Proposition 3.4].
Lemma 6.3. Let $\Gamma \in$ Quot $_{n}\left(\mathcal{C}_{r s s}\right)$. If $A, B \subset p L(\Gamma) p$ are diffuse commuting subalgebras with $A$ amenable, then $[p L(\Gamma) p: A \vee B]_{P P}=\infty$.

Proof. We proceed by induction on $n$. When $n=1$, this follows from Lemma 5.2, Now assume the statement holds for all groups in Quot $_{k}\left(\mathcal{C}_{\text {rss }}\right)$ where $k \leq n-1$ and take $\Gamma \in$ Quot $_{n}\left(\mathcal{C}_{\text {rss }}\right)$ with $A, B \subset p L(\Gamma) p$ as stated. Then $\Delta(A)$ is amenable and therefore amenable relative to $M \bar{\otimes} 1$ in $M \bar{\otimes} L\left(\Gamma_{1}\right)$. Since $\Gamma_{1} \in \mathcal{C}_{\text {rss }}$, either
(1) $\Delta(A) \prec_{M \bar{\otimes} L\left(\Gamma_{1}\right)} M \bar{\otimes} 1$, or
(2) $\mathcal{N}_{M \otimes L\left(\Gamma_{1}\right)}(\Delta(A))^{\prime \prime}$ is amenable relative to $M \bar{\otimes} 1$ in $M \bar{\otimes} L\left(\Gamma_{1}\right)$.

We first show (1) is impossible. If (1) were to hold, CIK13, Proposition 3.4] implies $A \prec$ $L\left(\Gamma_{n}^{(1)}\right)$. By CKP14, Proposition 2.4], there exists a $*$-isomorphism $\psi: p_{1} A p_{1} \rightarrow P_{1} \subset$ $q L\left(\Gamma_{n}^{(1)}\right) q$ such that $P_{1} \vee\left(P_{1}^{\prime} \cap q L\left(\Gamma_{n}^{(1)}\right) q\right) \subset q L\left(\Gamma_{n}^{(1)}\right) q$ is a finite index inclusion of algebras. Since $A$ is a diffuse amenable algebra, $P_{1}$ is also diffuse amenable. Since $\Gamma_{n}^{(1)}$ is non-amenable, $P_{1}^{\prime} \cap q L\left(\Gamma_{n}^{(1)}\right) q$ is non-amenable. Supposing $P_{1}^{\prime} \cap q L\left(\Gamma_{n}^{(1)}\right) q$ has an atomic corner, cutting by a minimal central projection $z, P_{1} z \subset q z L\left(\Gamma_{n}^{(1)}\right) q z$ is a finite index inclusion of algebra. Since $P_{1} z$ is amenable is an amenable corner of $L\left(\Gamma_{n}^{(1)}\right)$, this is would imply $\Gamma_{n}^{(1)}$ is an amenable group, a contradiction. If instead $P_{1}^{\prime} \cap q L\left(\Gamma_{n}^{(1)}\right) q$ were diffuse, this would contradict the induction hypothesis.

Now if (2) holds, the assumption $[M: A \vee B]_{P P}<\infty$ implies $\Delta(A \vee B) \subset M \bar{\otimes} L\left(\Gamma_{1}\right)$ is also a finite index inclusion of algebras. Since $\Delta(A \vee B) \subset \mathcal{N}_{M \bar{\otimes} L\left(\Gamma_{1}\right)}(\Delta(A))^{\prime \prime}, \Delta(A \vee B)$ is amenable relative to $M \bar{\otimes} 1$ in $M \bar{\otimes} L\left(\Gamma_{1}\right)$. By OP07, Proposition 2.4], $M \bar{\otimes} L\left(\Gamma_{1}\right)$ is amenable relative to $M \bar{\otimes} 1$. However, this is impossible as [CIK13, Proposition 3.5] would imply $\Gamma_{1} \in \mathcal{C}_{\text {rss }}$ is amenable.

To establish the main result, we show that the maximal number of commuting diffuse subalgebras is controlled by the Hirsh length. Note that we have an upper bound rather than equality. As an example of when we have a strict upper bound, central quotients of braid groups are poly-free groups which give rise to prime von Neumann algebras CKP14, Theorem A].

Lemma 6.4. Let $\Gamma \in \operatorname{Quot}_{n}\left(\mathcal{C}_{r s s}\right)$ and suppose $P_{1}, \ldots, P_{k} \subset q L(\Gamma) q$ are diffuse commuting $I I_{1}$ factors. If $P_{1} \vee \cdots \vee P_{k} \subset q L(\Gamma) q$ generate a finite index subalgebra, then $k \leq n$.

Proof. When $n=1$, Lemma 5.2 proves the assertion. Now suppose the conclusion holds for all groups in $\operatorname{Quot}_{m}\left(\mathcal{C}_{\text {rss }}\right)$ up to $m=n-1$. Now let $\Gamma \in \operatorname{Quot}_{n}\left(\mathcal{C}_{\text {rss }}\right)$ and assume to the contrary there are $k>n$ diffuse subalgebras $P_{1}, \ldots, P_{k} \subset q L(\Gamma) q$ generating a finite index subalgebra of $q L(\Gamma) q$. Without loss of generality, we may assume $k=n+1$. Then by Proposition 6.2, for every $j \in\{1, \ldots, k\}$, either $\hat{P}_{j} \prec_{L(\Gamma)} L\left(\Gamma_{n}^{(1)}\right)$ or $P_{j} \prec_{L(\Gamma)} L\left(\Gamma_{n}^{(1)}\right)$.

Now if $\hat{P}_{j} \prec L\left(\Gamma_{n}^{(1)}\right)$, by [CKP14, Proposition 2.4] there exists a $*$-isomorphism $\psi: p \hat{P}_{j} p \rightarrow$ $A \subset r L\left(\Gamma_{n}^{(1)}\right) r$ so that $A \vee A^{\prime} \cap r L\left(\Gamma_{n}^{(1)}\right) r \subset r L\left(\Gamma_{n}^{(1)}\right) r$ is a finite index inclusion of algebras. We may assume $p=p_{1} \cdots p_{k}, p_{i} \in P_{i}$ for $i \neq j$. Hence $\psi\left(p \hat{P}_{j} p\right)=\psi\left(\bigvee_{i \neq j} p_{i} P_{i} p\right)=\bigvee_{i \neq j} \psi\left(p_{i} P_{i} p\right)$. Thus

$$
\bigvee_{i \neq j} \psi\left(p_{i} P_{i} p\right) \vee\left(\psi\left(p \hat{P}_{j} p\right)^{\prime} \cap r L\left(\Gamma_{n}^{(1)}\right) r\right) \subset r L\left(\Gamma_{n}^{(1)}\right) r
$$

is a finite index inclusion of algebras. By Lemma6.6, the center $\mathcal{Z}\left(\bigvee_{i \neq j} \psi\left(p_{i} P_{i} p\right) \vee\left(\psi\left(p \hat{P}_{j} p\right)^{\prime} \cap\right.\right.$ $\left.r L\left(\Gamma_{n}^{(1)}\right) r\right)$ ) cannot be diffuse. Thus, cutting by a minimal central projection we may assume

$$
\bigvee_{i \neq j} \psi\left(p_{i} P_{i} p\right) \vee\left(\psi\left(p \hat{P}_{j} p\right)^{\prime} \cap r L\left(\Gamma_{n}^{(1)}\right) r\right) \subset r L\left(\Gamma_{n}^{(1)}\right) r
$$

is a finite index inclusion of factors. However, this would contradict the induction hypothesis as it would allow for at least $n$ commuting diffuse non-amenable subalgebras of $r L\left(\Gamma_{n}^{(1)}\right) r$.

If instead $P_{j} \prec_{L(\Gamma)} L\left(\Gamma_{n}^{(1)}\right)$ for all $j$, Va10, Lemma 2.5, Proposition 2.6], in conjunction with the factoriality of each $P_{j}$, imply $P_{j} \prec_{L(\Gamma)}^{s} L\left(\Gamma_{n}^{(1)}\right)$. Proposition 3.2 would then give $L(\Gamma) \prec_{L(\Gamma)} L(\Gamma)$, which implies $\Gamma_{n}^{(1)}$ is finite index in $\Gamma$ once again leading to a contradiction.

The following proposition is the key ingredient in decomposing a group as a product: if we may find an subgroup of $\Sigma<\Gamma \in \operatorname{Quot}_{n}\left(\mathcal{C}_{\mathrm{rss}}\right)$ then we may also find another subgroup commuting with $\Sigma$ so that $\Gamma$ is commensurable to the direct product $\Sigma \times \Omega$. The proof of this proposition closely follows the proof of [CdSS15, Theorem 4.3].
Proposition 6.5. Let $\Gamma \in \operatorname{Quot}_{n}\left(\mathcal{C}_{r s s}\right)$ be an icc group and denote by $L(\Gamma)=M$. Suppose we have subgroup $\Sigma<\Gamma$, and a projection $p \in L(\Sigma)^{\prime} \cap M$ so that $\Sigma \in \operatorname{Quot}_{j}\left(\mathcal{C}_{r s s}\right)$ and

$$
p\left[L(\Sigma) \vee\left(L(\Sigma)^{\prime} \cap M\right)\right] p \subset p M p
$$

is a finite index inclusion of $I I_{1}$ factors. Then we may find commuting subgroups $\Sigma_{1}, \Sigma_{2}<\Gamma$ such that $\left[\Sigma: \Sigma_{1}\right]<\infty$ and $\left[\Gamma: \Sigma_{1} \times \Sigma_{2}\right]<\infty$. Furthermore, if $\Sigma \in \operatorname{Quot}_{j}\left(\mathcal{C}_{r s s}\right)$, then $\Sigma_{2} \in \operatorname{Quot}_{n-j}\left(\mathcal{C}_{r s s}\right)$.
Proof. Letting $\Sigma_{2}=\left\{\gamma \in \Gamma:|\gamma|^{\Sigma}<\infty\right\}$ and proceeding as in CdSS15, claim 4.7], we see $\left[\Gamma: \Sigma_{2} \Sigma\right]<\infty$. Now, the first half of [CdSS15, Claim 4.8] demonstrates $\Sigma \cap \Sigma_{2}$ is amenable since it can be written as an increasing tower of amenable groups. Let $\Gamma_{1}$ act trivially on $\mathbb{C}, \Gamma \cong \Gamma_{n} \rightarrow \cdots \rightarrow \Gamma_{1}$ is a chain witnessing $\Gamma \in \operatorname{Quot}_{n}\left(\mathcal{C}_{\text {rss }}\right)$. Since $L\left(\Sigma \cap \Sigma_{2}\right)$ is amenable and $\Sigma$ normalizes $\Sigma_{2} \cap \Sigma$, the dichotomy of $\mathcal{C}_{\mathrm{rss}}$ will imply $L\left(\Sigma_{2} \cap \Sigma\right) \prec \mathbb{C} 1$. Thus, CdSS15, Proposition 2.6] implies $\Sigma \cap \Sigma_{2}$ is finite.

Claims 4.9-4.12 in the proof of [CdSS15, Theorem 4.3] provides the existence of a subgroup $\Sigma_{1} \leqslant \Sigma$ satisfying $\left[\Sigma: \Sigma_{1}\right]<\infty,\left[\Gamma: \Sigma_{1} \Sigma_{2}\right]<\infty$, and $\left[\Sigma_{2}, \Sigma_{1}\right]=\{e\}$. Since $\Sigma \cap \Sigma_{2} \geqslant \Sigma_{1} \cap \Sigma_{2}$, it follows $\Sigma_{1} \cap \Sigma_{2}$ is finite as well. Since $\Gamma$ is icc and $\left[\Gamma: \Sigma_{1} \Sigma_{2}\right]<\infty$ then $\Sigma_{1} \cap \Sigma_{2}=\{e\}$. Thus $\left[\Gamma: \Sigma_{1} \times \Sigma_{2}\right]<\infty$.

Now if we also had assumed $\Sigma \in \operatorname{Quot}_{j}\left(\mathcal{C}_{\mathrm{rss}}\right)$, Corollary 5.5 yields $\Sigma_{2} \in \operatorname{Quot}_{n-j}\left(\mathcal{C}_{\mathrm{rss}}\right)$.
Theorem 6.6. Let $\Gamma \in \operatorname{Quot}_{n}\left(\mathcal{C}_{r s s}\right)$ be an icc group and $q \in L(\Gamma)$ a projection. Suppose $P_{1}, \ldots, P_{k} \subset q L(\Gamma) q=M$ are diffuse commuting $I I_{1}$ factors such that $\left[M: P_{1} \vee \cdots \vee P_{k}\right]<\infty$. Then there exist icc groups $\Sigma_{i} \in \operatorname{Quot}_{n_{i}}\left(\mathcal{C}_{r s s}\right)$, non-zero projections $p_{i} \in P_{i}$, finite index subfactors $D_{i} \subset p_{i} P_{i} p_{i}$, and a unitary $u \in M$ such that

- $\Gamma$ is commensurable to $\Sigma_{1} \times \cdots \times \Sigma_{k}$,
- $\sum_{i=1}^{k} n_{i}=n$,
- $D_{i} \subset p_{i} u^{*} L\left(\Sigma_{i}\right) u p_{i}$ is a finite index inclusion of $I I_{1}$ factors.

Proof. As our theorem is taken up to commensurability, we will treat the case when $\Gamma=\Gamma_{n}$ where

$$
\Gamma_{n} \rightarrow \Gamma_{n-1} \rightarrow \cdots \rightarrow \Gamma_{1} \rightarrow 1
$$

witnesses $\Gamma \in$ Quot $_{n}\left(\mathcal{C}_{\text {rss }}\right)$. Furthermore, Lemma 6.1 implies we may assume $\mathcal{N}_{p M p}\left(P_{i}\right)^{\prime \prime}$ is a factor. By Proposition 6.2, for every $i$ we have either $\hat{P}_{i} \prec_{M} L\left(\Gamma_{n}^{(1)}\right)$ or $P_{i} \prec_{M} L\left(\Gamma_{n}^{(1)}\right)$. If we assume $P_{i} \prec_{M} L\left(\Gamma_{n}^{(1)}\right)$, then $P_{i} \prec_{M}^{s} L\left(\Gamma_{n}^{(1)}\right)$ and hence $P_{1} \vee \cdots \vee P_{k} \prec L\left(\Gamma_{n}^{(1)}\right)$. Since $P_{1} \vee \cdots \vee P_{k}$ is a finite index subalgebra of $L(\Gamma)$, then $\left[\Gamma: \Gamma_{n}^{(1)}\right]<\infty$ contradicting that $\Gamma / \Gamma_{n}^{(1)} \in \mathcal{C}_{\mathrm{rss}}$. Thus, there exists $i$ such that $\hat{P}_{i} \prec_{M} L\left(\Gamma_{n}^{(1)}\right)$ but $P_{i} \nprec_{M} L\left(\Gamma_{n}^{(1)}\right)$. For simplicity, we consider the case $i=k$. [CKP14, Proposition 2.4] give the existence of projections $p \in$ $\hat{P}_{k}, q_{1} \in L\left(\Gamma_{n}^{(1)}\right)$, a partial isometry $v \in M$, and a $*$-isomorphism $\psi: p \hat{P}_{k} p \rightarrow B \subset q_{1} L\left(\Gamma_{n}^{(1)}\right) q_{1}$ such that
(a) $B \vee\left(B^{\prime} \cap q_{1} L\left(\Gamma_{n}^{(1)}\right) q_{1}\right) \subset q_{1} L\left(\Gamma_{n}^{(1)}\right) q_{1}$ is a finite index inclusion of algebras,
(b) $\psi(x) v=v x$ for all $x \in p \hat{A}_{k} p$.

As in the proof of Lemma 6.4, we may assume $p=p_{1} \cdots p_{k-1}$ where $p_{i} \in P_{i}$ are projections such that $B=\psi\left(p \hat{P}_{k} p\right)=\psi\left(p_{1} P_{i} p\right) \vee \cdots \vee \psi\left(p_{k-1} P_{k-1} p\right)=B_{1} \vee \cdots \vee B_{k-1}$. Thus we have
(c) $\psi\left(p_{i} P_{i} p\right)=B_{i}$,
(d) $\psi(x) v=v x$ for all $x \in p \hat{P}_{k} p$,
(e) $B_{1} \vee \cdots \vee B_{k-1} \vee\left(B^{\prime} \cap q_{1} L\left(\Gamma_{n}^{(1)}\right) q_{1}\right) \subset q_{1} L\left(\Gamma_{n}^{(1)}\right) q_{1}$ is a finite index inclusion of algebras.

We first assume $n=2$. In this case, Lemma 6.4 implies $k=2$. Since $\Gamma_{n}^{(1)} \in \operatorname{Quot}_{1}\left(\mathcal{C}_{\mathrm{rss}}\right)$, Lemma 5.2 implies $\mathcal{Z}\left(B^{\prime} \cap q_{1} L\left(\Gamma_{n}^{(1)}\right) q_{1}\right)$ cannot have any diffuse part and therefore is completely atomic. Thus multiplying $v$ by some minimal central projection $q^{\prime} \in B^{\prime} \cap q_{1} L\left(\Gamma_{n}^{(1)}\right) q_{1}$ so that $v q^{\prime} \neq 0$, we may assume $\psi\left(p P_{1} p\right)=B \subset q_{1} L\left(\Gamma_{n}^{(1)}\right) q_{1}$ is a finite index inclusion of factors. Moreover, $\operatorname{dim}_{\mathbb{C}}\left(\mathcal{Z}\left(q L\left(\Gamma_{n}^{(1)}\right)\right) q\right) \leq\left[q L\left(\Gamma_{n}^{(1)}\right) q: B\right]_{P P}<\infty$ since $B$ is a $\mathrm{II}_{1}$ factor. Thus, after multiplying again by a minimal central projection, we may assume $B \subset q_{1} L\left(\Gamma_{n}^{(1)}\right) q_{1}$ is a finite index inclusion of $\mathrm{II}_{1}$ factors. We claim there exists a projection $r \in L\left(\Gamma_{n}^{(1)}\right)^{\prime} \cap M$ such that.

$$
\begin{equation*}
r\left[L\left(\left(\Gamma_{n}^{(1)}\right) \vee L\left(\Gamma_{n}^{(1)}\right)^{\prime} \cap M\right)\right] r \subset r M r \tag{9}
\end{equation*}
$$

is a finite index inclusion of $\mathrm{II}_{1}$ factors.
To this end, the downward basic construction [Jo81, Lemma 3.1.8] gives a projection $e \in$ $q_{1} L\left(\Gamma_{n}^{1}\right) q_{1}$ and a subfactor $C \subset B \subset q_{1} L\left(\Gamma_{n}^{(1)}\right) q_{1}=\langle B, e\rangle$ such that $[B: C]=\left[q_{1} L\left(\Gamma_{n}^{(1)}\right) q_{1}:\right.$ $B], C e=e L\left(\Gamma_{n}^{(1)}\right) e$ and $C e \cong C$. Then the restriction $\psi^{-1}: C \rightarrow D \subset p P_{1} p$ is a ${ }^{*-}$ isomorphism such that $\left[p P_{1} p: D\right]<\infty$ with $\psi^{-1}(y) v^{*}=v^{*} y$ for all $y \in C$. Let $\theta: C e \rightarrow C$ be the $*$-isomorphism given by $x e \mapsto x$ and denote by $v^{\prime}=e v$. If we suppose $v^{\prime}=0$, we would have $v v^{*} x e=x v v^{*} e=0$ for all $x \in B$. As $\langle B, e\rangle e=B e, v v^{*} t=0$ for all $t \in\langle B, e\rangle$. However, since $q$ is the central support of $e$ in $\langle B, e\rangle$, this would yield $v v^{*}=0$. Thus it follows that $\varphi=\psi^{-1} \circ \theta: e L\left(\Gamma_{n}^{(1)}\right) e \rightarrow D$ is a $*$-isomorphism satisfying

$$
\begin{equation*}
\varphi(y) w^{*}=w^{*} x \text { for all } y \in e L\left(\Gamma_{n}^{(1)}\right) e \tag{10}
\end{equation*}
$$

where $w^{*}$ is the partial isometry from the polar decomposition of $v^{*} e=\left|v^{*} e\right| w^{*}$. Note that $s=w^{*} w \in D^{\prime} \cap p M p$ and $w w^{*} \leq e$. Thus equation (10), we obtain

$$
\begin{align*}
& w^{*} L\left(\Gamma_{n}^{(1)}\right) w=\varphi\left(e L\left(\Gamma_{n}^{(1)}\right) e\right) w^{*} w=D s  \tag{11}\\
& \left(w^{*} L\left(\Gamma_{n}^{(1)}\right) w\right)^{\prime} \cap s M s=(D s)^{\prime} \cap s M s \tag{12}
\end{align*}
$$

First note $P_{2} p \subset D^{\prime} \cap p M p$. Since $D \subset p P_{1} p$ is a finite index inclusion, so are the inclusions $D \vee P_{2} p \subset p\left(P_{1} \vee P_{2}\right) p \subset p M p$ and hence $D \vee P_{2} p \subset p M p$ is a finite index inclusion of algebras. By the local index formula, we also have $D s \vee s\left(D^{\prime} \cap M\right) s \subset s M s$ is also a finite index inclusion of $\mathrm{II}_{1}$ factors.

Let $r=w w^{*}$ and $u \in M$ a unitary with $w^{*}=u r$. Conjugating (11) and (12) by $u$ implies $r\left[L\left(\Gamma_{n}^{(1)}\right) \vee L\left(\Gamma_{n}^{(1)}\right)^{\prime} \cap M\right] r=L\left(\Gamma_{n}^{(1)}\right) r \vee\left(L\left(\Gamma_{n}^{(1)}\right)^{\prime} \cap r M r\right) \subset r M r$ is a finite index inclusion of $\mathrm{II}_{1}$ factors (after shrinking $r$ is necessary). By Proposition 6.5, there exists a finite index subgroup $\Sigma_{1}<\Gamma_{n}^{(1)}$ such that $\Sigma_{i} \in \operatorname{Quot}_{1}\left(\mathcal{C}_{\mathrm{rss}}\right)$ with $\left[\Gamma: \Sigma_{1} \times \Sigma_{2}\right]<\infty$ and $r P_{2} r \subset r u^{*} L\left(\Sigma_{2}\right) u r$, where $\Sigma_{2}=V_{\Gamma}\left(\Gamma_{n}^{(1)}\right)$. Since $r u^{*} L\left(\Gamma_{n}^{(1)}\right) u r \subset r P_{1} r$ is a finite index inclusion of $\mathrm{II}_{1}$ factors, so is the inclusion $r u^{*} L\left(\Sigma_{1}\right) r \subset r P_{1} r$. Performing the downward basic construction gives a subfactor $P_{1} f \subset r u^{*} L\left(\Sigma_{1}\right) r$ where $f \in P_{1}^{\prime} \cap r M r$.

Since $r P_{2} r \subset r\left(P_{1}^{\prime} \cap M\right) r$ is a finite Pimnser-Popa index inclusion of algebras, so is the inclusion $r P_{2} r \subset r u^{*} L(\Omega) u r$. Thus cutting once again by a minimal projection we have $r_{2} P_{2} r_{r} \subset r_{2} u^{*} L\left(\Sigma_{2}\right) u r_{2}$ is a finite index inclusion of $\mathrm{II}_{1}$ factors.

Now suppose the result holds for all icc groups $\Lambda \in$ Quot $_{n-1}\left(\mathcal{C}_{\text {rss }}\right)$ for some $n \in \mathbb{N}$. Take $\Gamma \in \operatorname{Quot}_{n}\left(\mathcal{C}_{r s s}\right)$ an icc group. Proceeding as in the case when $n=2$, we may assume $\hat{P}_{k} \prec_{M} L\left(\Gamma_{n}^{(1)}\right)$. More precisely, since the center of $P_{1} \vee \cdots \vee P_{k}$ is trivial, by Va10, Lamma 2.5, Proposition 2.6] $\hat{P}_{k} \prec_{M}^{s} L\left(\Gamma_{n}^{(1)}\right)$. CKP14, Proposition 2.4] give the existence of projections $p \in P_{1}, q \in L\left(\Gamma_{n}^{(1)}\right)$, a partial isometry $v \in M$ and a $*$-isomorphism $\psi: p P_{1} p \rightarrow B \subset$ $q_{1} L\left(\Gamma_{n}^{(1)}\right) q_{1}$ such that
(f) $B \vee\left(B^{\prime} \cap q_{1} L\left(\Gamma_{n}^{(1)}\right) q_{1}\right) \subset q_{1} L\left(\Gamma_{n}^{(1)}\right) q_{1}$ is a finite index inclusion of algebras,
(g) $\psi(x) v=v x$ for all $x \in p P_{1} p$.

If $B_{k}=B^{\prime} \cap q_{1} L\left(\Gamma_{n}^{(1)}\right) q_{1}$ was not diffuse, we cutting by a minimal central projection to obtain $B \subset q_{1} L\left(\Gamma_{n}^{(1)}\right) q_{1}$ is finite Pimnser-Popa index inclusion of algebras. As before, $\mathcal{Z}\left(q L\left(\Gamma_{n}^{(1)}\right)\right)$ is finite dimensional. Thus, we cut by an appropriate minimal central projection to obtain a finite index inclusion of $\mathrm{II}_{1}$ factors and proceed exactly as in the case when $n=2$.

Now suppose $B$ and $B_{k}=B^{\prime} \cap q_{1} L\left(\Gamma_{n}^{(1)}\right) q_{1}$ are both diffuse. Then, by cutting by a minimal central projection if necessary, we have $B \vee B_{k} \subset q_{1} L\left(\Gamma_{n}^{(1)}\right) q_{1}$ is a finite index inclusion of $\mathrm{II}_{1}$ factors. By the induction hypothesis, there exists a unitary $w \in q_{1} L\left(\Gamma_{n}^{(1)}\right) q_{1}$,subgroups $\Lambda 1, \ldots, \Lambda_{k}$ of $\Gamma_{n}^{(1)}$ and projections $p_{i} \in B_{i}, q_{i} \in L\left(\Lambda_{i}\right)$ so that

- $w\left(p_{1} B_{i} p_{1}\right) w^{*} \subset q_{1} L\left(\Lambda_{i}\right) q_{1}$ is a finite index inclusion of $\mathrm{II}_{1}$ factors
- $\Gamma_{n}^{(1)}$ is commensurable to $\Lambda_{1} \times \cdots \times \Lambda_{k}$
- $\Lambda \in \operatorname{Quot}_{m_{1}}\left(\mathcal{C}_{\mathrm{rss}}\right)$ with $1 \leq m_{1}<n-1$.
- $\sum m_{i}=n-1$.

Letting $\Lambda=\Lambda_{1} \times \cdots \times \Lambda_{k}$ and proceeding as in the case when $n=2$, there exists a projection $s$ such that

$$
s\left[L(\Lambda) \vee L(\Lambda)^{\prime} \cap M\right] s \subset s M s
$$

is a finite index inclusion of $\mathrm{II}_{1}$ factors. Applying Lemma 6.5 and following the same procedure as in the case when $n=2$, we may find a finite index subgroup $\Lambda_{1}<\Lambda$ so that $r \hat{P}_{j} r \subset r u^{*} L\left(\Lambda_{1}\right) u r$ and $r P_{k} r \subset L\left(\Lambda_{2}\right)$ are finite index inclusions of $\mathrm{II}_{1}$ factors with $\left[\Gamma: \Lambda_{1} \times \Lambda_{2}\right]<\infty$. Furthermore, we may assume

$$
r \hat{P}_{j} r=r P_{1} r \vee \cdots \vee r P_{k-1} r .
$$

Letting $\Gamma_{k}=\Sigma_{2}$ and once again applying the induction hypothesis, we may appropriately identify corners of $P_{i}$ with groups $\Gamma_{i}$ so that $\Gamma_{i} \in \operatorname{Quot}_{n_{i}}\left(\mathcal{C}_{\mathrm{rss}}\right)$ with $n_{1}+\cdots+n_{k}=n$.

The above result may be extended to amplifications of the algebra $L(\Gamma)$.
Corollary 6.7. Let $\Gamma \in$ Quot $_{n}\left(\mathcal{C}_{r s s}\right)$ be an icc group and denote by $M=L(\Gamma)^{t}$. If $P_{1}, \ldots, P_{k}$ are diffuse commuting $I I_{1}$ factors such that $\left[M: P_{1} \vee \cdots P_{k}\right]<\infty$, then $k \leq n$ and there exist icc groups $\Sigma_{1} \in \operatorname{Quot}_{n_{i}}\left(\mathcal{C}_{r s s}\right)$, non-zero projections $p_{i} \in P_{i}$, finite index subfactors $D_{i} \subset p_{i} P_{i} p_{i}$ and a unitary $u \in M$ such that

- $\Gamma$ is commensurable to $\Sigma_{1} \times \cdots \times \Sigma_{k}$,
- $\sum_{i=1}^{k} n_{i}=n$,
- $D_{i} \subset p_{i} u^{*} L\left(\Sigma_{i}\right) u p_{i}$ is a finite index inclusion of $I I_{1}$ factors.

Proof. Fix an integer $N>t>0$. Since $M=L(\Gamma)^{t}$, there exists a projection $q \in$ $M_{N}(\mathbb{C}) \bar{\otimes} L(\Gamma)$ so that $q M_{N}(\mathbb{C}) \bar{\otimes} L(\Gamma) q=M$ and $\operatorname{Tr}(q)=t$, where $\operatorname{Tr}: M_{N}(\mathbb{C}) \bar{\otimes} L(\Gamma) \rightarrow \mathbb{C}$ is the trace induced on $M_{N}(\mathbb{C}) \bar{\otimes} L(\Gamma)$ from the trace $\tau$ on $L(\Gamma)$. Now fix a projection $r \in M$ with $\tau(r)=1 / N$ and $\tilde{r} \leq q$, where $\tilde{r}$ is the image of $r$ inside $M_{n}(\mathbb{C}) \bar{\otimes} L(\Gamma)$ in the obvious way. Then $\tilde{r} u_{0}^{*} M u_{0} \tilde{r}=s L(\Gamma) s$ for some non-zero projection $s \in L(\Gamma)$ and unitary $u_{0} \in M$.

Labeling $Q_{i}=r u_{0}^{*} P_{i} u_{0} r$ for each $i \in\{1, \ldots, k\}$, we see $\bigvee_{i=1}^{k} Q_{i} \subset s L(\Gamma) s$ is a finite index inclusion of algebras. Theorem 6.6 now finished the proof.

Corollary 6.8. Let $\Gamma \in \operatorname{Quot}_{n}\left(\mathcal{C}_{r s s}\right)$ be an icc group and suppose $L(\Gamma)^{t} \cong P_{1} \bar{\otimes} P_{2}$ for some diffuse von Neumann algebras $P_{i}$. Then there exist groups $\Gamma_{1}, \Gamma_{2}$, a unitary $u \in \mathcal{U}(L(\Gamma))$, positive integers $n_{1}, n_{2}$, and a scalar $s>0$ such that:
(1) $\Gamma$ is commenarable to $\Gamma_{1} \times \Gamma_{2}$ with $\Gamma_{i} \in \operatorname{Quot}_{n_{i}}\left(\mathcal{C}_{r s s}\right)$ and $n_{1}+n_{2}=n$; and
(2) $P_{1}^{s}=u L\left(\Gamma_{1}\right) u^{*}$ and $P_{2}^{t / s}=u L\left(\Gamma_{2}\right) u^{*}$.

Since the proof closely follow the proof of CdSS15, Theorem 4.14], we include only the relevant details.

Proof. By Theorem [6.7, there exists groups $\Gamma_{i} \in \operatorname{Quot}_{n_{i}}\left(\mathcal{C}_{\mathrm{rss}}\right)$, a unitary $u \in L(\Gamma)^{t}$, and projections $p_{i} \in P_{i}$, and finite subfactors $D_{i} \subset p_{i} P_{i} p_{i}$ so that
(1) $\Gamma$ is commensurable to $\Sigma_{1} \times \Sigma_{2}$,
(2) $n_{1}+n_{2}=n$, and
(3) $D_{i} \subset p_{i} u^{*} L\left(\Sigma_{i}\right) u p_{i}$.

Thus, all that remains to show is the existence of a scalar $s$ so that $P_{1}^{s}=u L\left(\Gamma_{1}\right) u^{*}$ and $P_{2}^{t / s}=u L\left(\Gamma_{2}\right) u^{*}$. Since $\Gamma$ is commensurable to $\Sigma_{1} \times \Sigma_{2}$, there exist commuting non-amenable subgroups $\Omega_{1}, \Omega_{2} \leqslant \Gamma$ such that $\left[\Gamma: \Omega_{1} \Omega_{2}\right]<\infty$. Thus, we are now in position to follow the proof of [CdSS15, Theorem 4.14] exactly.

Proceeding by way of induction, we obtain the following generalization of Corollary 6.8
Corollary 6.9. Let $\Gamma \in \operatorname{Quot}_{n}\left(\mathcal{C}_{r s s}\right)$ be an icc group and suppose $L(\Gamma) \cong P_{1} \bar{\otimes} \cdots \bar{\otimes} P_{k}$ for some diffuse von Neumann algebras $P_{1} \ldots, P_{k}$. Then there exist subgroups $\Gamma_{1}, \ldots \Gamma_{k} \leqslant \Gamma$, a unitary $u \in \mathcal{U}(L(\Gamma))$, positive integers $n_{1}, \ldots, n_{k}$, and scalars $t_{1}, \ldots, t_{k}>0$ with $t_{1} t_{2} \cdots t_{k}=t$ such that:
(1) $\Gamma=\Gamma_{1} \times \cdots \times \Gamma_{k}$ with $\Gamma_{i} \in \operatorname{Quot}_{n_{i}}\left(\mathcal{C}_{r s s}\right)$ and $\sum_{i=1}^{k} n_{i}=n$; and
(2) $P_{i}^{t_{i}}=u L\left(\Gamma_{i}\right) u^{*}$ for every $i \in\{1, \ldots, k\}$.

Proof. When $k=2$, this follows from Corollary 6.8. Now assume the conclusion of the corollary holds for all tensor decompositions with at most $k-1$ factors. Writing $L(\Gamma)^{t}=$ $Q_{1} \bar{\otimes} Q_{2}$ where $Q_{1}=P_{1} \bar{\otimes} \cdots \bar{\otimes} P_{k-1}$ and $Q_{2}=P_{k}$, Corollary 6.8 implies the existence of subgroups $\Gamma_{1}, \Gamma_{2} \leqslant \Gamma$, a unitary $u \in \mathcal{U}(L(\Gamma))$, and a scalar $s_{1}$ so that $Q_{1}^{s}=u L\left(\Gamma_{1}\right) u^{*}$ and $Q_{2}^{t / s}=u L\left(\Gamma_{2}\right) u^{*}$. Applying the induction hypothesis to $Q_{1}$ will give the conclusion of the corollary.

Corollary 6.10. Suppose $\Gamma_{1}, \ldots, \Gamma_{m}$ and $\Lambda_{1}, \ldots, \Lambda_{m}$ are icc groups such that $\Gamma_{i} \in \operatorname{Quot}_{n_{i}}\left(\mathcal{C}_{r s s}\right)$ and $\Lambda_{i} \in \operatorname{Quot}_{m_{j}}\left(\mathcal{C}_{r s s}\right)$. If $L\left(\Lambda_{i}\right)$ and $L\left(\Gamma_{j}\right)$ are prime II factors so that $L\left(\Gamma_{1} \times \cdots \times \Gamma_{m}\right) \cong$ $L\left(\Lambda_{1} \times \cdots \times \Lambda_{n}\right)$, then $n=m$ and we have $L\left(\Gamma_{i}\right) \cong L\left(\Lambda_{i}\right)$ for every $i \in\{1, \ldots, m\}$, up to permutation and amplification.

Proof. The statement that $n=m$ clearly follows from Lemma 6.4 and Theorem 6.6. Letting $P_{i}=L\left(\Lambda_{i}\right)$ for every $i \in\{1, \ldots m\}$, Corollary 6.9 immediately implies the conclusion.

We now provide explicit examples to which we apply our results.
Corollary 6.11. If $k, j \geq 3$ and $\widetilde{B}_{j, k} \leq \widetilde{B}_{k+j}$ is a mixed braid subgroup, then $p L\left(\widetilde{B}_{j, k}\right) p$ is prime for every non-zero projection $p \in \mathcal{P}\left(L\left(\widetilde{B}_{k, j}\right)\right)$.
Proof. Suppose to the contrary that there exists a projection $p \in \mathcal{P}\left(L\left(\widetilde{B}_{k, j}\right)\right)$ so that $p L\left(\widetilde{B}_{k, j}\right) p$ is non-prime. The by Theorem 6.6, $\widetilde{B}_{k, j}$ is commensurable to a product of groups. However, since $B_{k, j}$ is a finite index subgroup of $\widetilde{B}_{k+j}$ of index $k!j$ !, this would impy that $\widetilde{B}_{k+j}$ is commensurable to a product of infinite groups, which contradicts [CKP14, Theorem A].

Fix an integer $n \geq 3$ and choose a collection of at least two positive integers $k_{1}, \ldots, k_{m}$ such that $k_{i} \neq 2$ for all $i \in\{1, \ldots, m\}$ with $k_{1}+\cdots+k_{m}=n$. Then there exists a canonical
epimorphism $\pi: B_{n} \rightarrow S_{k_{1}} \times \cdots \times S_{k_{m}}$. If we denote by $B_{k_{1}, \ldots, k_{m}}:=\operatorname{ker} \pi$, then this generalizes the mixed braid groups. Note that since $\left[B: B_{k_{1}, \ldots, k_{m}}\right]=\prod_{i=1}^{m} k_{i}$ !, the proof of Corollary 6.11 can be modified to verify the following:

Corollary 6.12. Let $\widetilde{B}_{k_{1}, \ldots ., k_{m}}$ be as above. Then for any projection $p \in \mathcal{P}\left(L\left(\widetilde{B}_{k_{1}, \ldots, k_{m}}\right)\right)$, $p L\left(\widetilde{B}_{k_{1}, \ldots, k_{m}}\right) p$ is prime.

## 7. Closing Remarks

Note the analysis involved in the proofs of the theorems in Section 5 continue to hold if we forgo the factoriality assumption and instead assume $L(\Gamma)$ has a finite dimensional center, e.g. $\Gamma$ is a finite-by-icc group. By carrying out the same procedure we have the following generalization of the main theorem:

Theorem 7.1. Suppose $P_{1} \vee \cdots \vee P_{k} \subset L(\Gamma)$ where $\Gamma \in \operatorname{Quot}_{n}\left(\mathcal{C}_{r s s}\right)$. Then there exist commuting groups $\Sigma_{i} \in \operatorname{Quot}_{n_{i}}\left(\mathcal{C}_{r s s}\right)$ so that $\Gamma$ is commensurable to the product $\Sigma_{1} \cdots \Sigma_{k}$.

While our methods provide a criterion whereby one determines if a group von Neumann algebra which arises from a finite-step extension by $\mathcal{C}_{\text {rss }}$ is prime, we have not addressed the question of [CKP14]: is the $N C_{1}$ condition sufficient to conclude that the resulting group von Neumann algebra is prime?
