# Dirichlet boundary value problems for elliptic operators with measure data: a probabilistic approach

#### Abstract

In this paper, we use probabilistic approach to prove that there exists a unique weak solution to the Dirichlet boundary value problem for second order elliptic equations whose coefficients are signed measures, and we will give a probabilistic representation of the solutions. This is the first time to study Dirichlet boundary value problems with this generality. The heat kernel estimates play a crucial role in our approach.


Key Words: Dirichlet boundary value problem; signed measures; probabilistic representation; heat kernel estimates.

## 1 Introduction

Suppose $D$ is a bounded domain in $\mathbb{R}^{d}$. Let $\mu_{i}, \nu, \rho$ be signed measures on $\mathbb{R}^{d}$ for each $1 \leq i \leq d$. In this paper, we are concerned with the following boundary value problem:

\begin{cases}\mathcal{A} u=-\rho, & \forall x \in D  \tag{1.1}\\ \left.u(x)\right|_{\partial D}=\varphi(x), & \forall x \in \partial D\end{cases}
$$

where

$$
\begin{equation*}
\mathcal{A} u:=\frac{1}{2} \Delta u+\nabla u \cdot \mu+u \nu . \tag{1.2}
\end{equation*}
$$

Let $b=\left(b_{i}\right)_{1 \leq i \leq d}: D \rightarrow \mathbb{R}^{d}$ and $q, f: D \rightarrow \mathbb{R}$ are measurable functions in $D$ such that $|b|^{2}, q$ and $f$ belong to the Kato class $\mathbf{K}_{d, 2}$ (See the Definition 2.1 for the precise definition of $\mathbf{K}_{d, 2}$ ) and $\varphi$ is a continuous function on $\partial D$. W.D.Gerhard in 9 proved the following result that there exists a unique continuous weak solution to the Dirichlet boundary value

\begin{cases}\frac{1}{2} \Delta u(x)+\nabla u(x) \cdot b(x)+u(x) q(x)=-f(x), & \forall x \in D \\ \left.u(x)\right|_{\partial D}=\varphi(x), & \forall x \in \partial D\end{cases}

\]

under the condition that there exists a $x_{0} \in D$ such that

$$
E_{x_{0}}\left[e^{\int_{0}^{\tau} D q\left(X_{s}\right) d s}\right]<\infty
$$

where $X=\left(\Omega, \mathcal{F}_{t}, X_{t}, P_{x}, x \in \mathbb{R}^{d}\right)$ is the diffusion process associated with the generator $L u:=\frac{1}{2} \Delta u+\nabla u \cdot b, \tau_{D}$ is the first exit time of $X$ from $D$ and $E_{x_{0}}$ is the expectation under $P_{x_{0}}$. Precisely speaking, there exists a unique $u \in W^{1,2}(D) \bigcap C(\bar{D})$ such that $u=\varphi$ on $\partial D$ and

$$
\begin{aligned}
& \frac{1}{2} \sum_{i=1}^{d} \int_{\mathbb{R}^{d}} \frac{\partial u(x)}{\partial x_{i}} \frac{\partial \phi(x)}{\partial x_{i}} d x-\sum_{i=1}^{d} \int_{\mathbb{R}^{d}} \frac{\partial u(x)}{\partial x_{i}} \phi(x) b_{i}(x) d x-\int_{D} u(x) \phi(x) q(x) d x \\
= & \int_{D} \phi(x) f(x) d x, \quad \forall \phi \in C_{0}^{\infty}(D) .
\end{aligned}
$$

In this paper, we will show that there exists a unique solution to the boundary value problem (1.1) under the conditions that for each $1 \leq i \leq d$, the signed measures $\mu_{i}, \nu$ and $\rho$ belong to $\mathbf{K}_{d, \alpha}$ for some $\alpha<1$, and we will obtain a global $C^{1, \alpha}$-estimates in this case.

Using probabilistic approaches to solve boundary value problems has a long history. The pioneering work goes back to Kukutani [12] who used Brownian motion to represent the solution of the classical Laplace's equations. In Chen and Zhang [4], they used the Girsanov transformation and the Dirichlet forms methods to obtain the solution to the following problem:

\begin{cases}\frac{1}{2} \sum_{i, j=1}^{d} \frac{\partial}{\partial x_{i}}\left(a_{i j}(x) \frac{\partial u}{\partial x_{j}}\right)+\sum_{i=1}^{d} b_{i}(x) \frac{\partial u}{\partial x_{i}}+q(x) u(x)=0, & \forall x \in D  \tag{1.3}\\ \left.u(x)\right|_{\partial D}=\varphi(x), & \forall x \in \partial D\end{cases}
$$

under some conditions, including that $|b|^{2}, q$ belong to the Kato class $\mathbf{K}_{d, 2}$.
Note that for any $f \in \mathbf{K}_{d, 2}$ and $\epsilon>0$, there exists a $\delta>0$ such that

$$
\begin{equation*}
\int_{\mathbb{R}^{d}} \phi(x)^{2} f(x) d x \leq \epsilon \int_{\mathbb{R}^{d}}|\nabla \phi(x)|^{2} d x+\delta \int_{\mathbb{R}^{d}}|\phi(x)|^{2} d x, \quad \forall \phi \in C_{0}^{\infty}\left(\mathbb{R}^{d}\right) \tag{1.4}
\end{equation*}
$$

The property (1.4) plays an important role in [4] and [5]. As far as we know, all the previous works about the weak solutions to elliptic PDEs (1.3) were considered under the condition that $|b|^{2}$ satisfies the property (1.4). However, there exist functions which are belong to $\mathbf{K}_{d, \alpha}$ such that the square of them are not locally integrable with regard to (w.r.t.) the Lebesgue measure $d x$, hence they fail to hold the property (1.4). For example: let $\frac{1}{2}<\alpha<1$, $1-\alpha<\gamma<\frac{1}{2}$ and $g: \mathbb{R}^{d-1} \rightarrow \mathbb{R}$, then $f\left(x_{1}, x_{2}, \ldots, x_{d}\right):=\left(x_{d}-g\left(x_{1}, x_{2}, \ldots, x_{d-1}\right)\right)^{\gamma-1} \in \mathbf{K}_{d, \alpha}$ following form the arguments in the proof of Proposition 2.1 and Example 2.4 in [2]. But $f^{2}$ is not locally integrable obviously. Hence the results in the previous works do not cover our case.

Let $W_{t}$ be a standard Brownian motion in $\mathbb{R}^{d}$ w.r.t. $P_{x}$. Following from Remark 2.1 (i) in the next section, $|b|^{2} \in \mathbf{K}_{d, 2}$ is equivalent to

$$
\begin{equation*}
\lim _{t \rightarrow 0} \sup _{x \in \mathbb{R}^{d}} E_{x}\left[\int_{0}^{t}\left|b\left(W_{s}\right)\right|^{2} d s\right]=0 \tag{1.5}
\end{equation*}
$$

which implies that $M_{t}:=e^{\int_{0}^{t} b\left(W_{s}\right) d W_{s}-\frac{1}{2} \int_{0}^{t}\left|b\left(W_{s}\right)\right|^{2} d s}$ is a martingale. Hence the Girsanov transformation can be applied in this case (e.g. see [5] and (9). However we have seen that (1.5) may fail when $f \in \mathbf{K}_{d, \alpha}$. Even for $\pi \in \mathbf{K}_{d, \alpha}$ is absolutely continuous w.r.t. dx, it have enormous difficulties to prove that $|\pi|(d x)$ satisfies the Kato-type inequality, thus it is not clear whether the quadratic form associated with the generator $\mathcal{A}$ defined in (1.2) is a closed form, i.e. it is lower bounded, closable and satisfies the sector condition (see [16]). Hence the Girsanov transformation and the Dirichlet form methods can not be used in this paper immediately.

On the other hand, we stress also that the maximum principle plays a key role in showing the uniqueness of the solutions to the elliptic PDEs. However, the Trudinger's criterion about the maximum principle in [17] is not met even when $\nu=0$.

Hence all the previous known methods in solving the existence and uniqueness about the solutions to the elliptic boundary value problems such as those in [4, [5, [9] and (15) ceased to work.

In this paper, we will give the definition of the weak solution (see the definition 2.2 in the next section) to the problem (1.1). And we will show that there exists a unique weak solution to the Dirichlet value problem under some general conditions. When $\nu=0$, we will use the heat kernel estimates in [14] to obtain the existence of the solution to the problem (1.1). when $\nu \neq 0$, note that $-\nu$ may not be a positive measure, thus there will not exists a Markov process correspond to the generator $\mathcal{A}$. The proposition of continuous additive functionals (CAFs) associated with $\nu$ and $\rho$ (see the definition 2.3 in the next section) will play an important role to show the existence and uniqueness of the solutions to the problem (1.1).

The rest of the paper is organized as follows. In Section 2, we set up the precise framework. And we will first establish some estimates in Section 3. Section 4 is devoted to obtaining the existence and uniqueness of solutions to problem (1.1) under the case that $\nu=0$. The boundary value problem (1.1) will be completely solved in Section 5 .

## 2 Framework

Assume that $d \geq 3$. We first recall the following notion.
Definition 2.1 Let $\pi$ be a Radon signed measure on $\mathbb{R}^{d}$. For $0<\alpha \leq 2$, set

M_{\pi}^{\alpha}(r):=\sup _{x \in \mathbb{R}^{d}} \int_{B_{r}(x)}|x-y|^{\alpha-d}|\pi|(d y)
$$

where $|\pi|$ is the total variation of the signed measure $\pi$ and $B_{r}(x)$ is the ball in $\mathbb{R}^{d}$ centered at $x$ with radius $r$. We say that $\pi$ is in the Kato class $\mathbf{K}_{d, \alpha}$, if $\lim _{r \rightarrow 0} M_{\pi}^{\alpha}(r)=0$. And we say a function $f \in \mathbf{K}_{d, \alpha}$ if the measure $f(x) d x \in \mathbf{K}_{d, \alpha}$.

Remark 2.1 (i) Set $N_{\pi}^{\alpha, c}(t):=\sup _{x \in \mathbb{R}^{d}} \int_{0}^{t} \int_{\mathbb{R}^{d}}{ }^{-\frac{d+2-\alpha}{2}} e^{-\frac{c|x-y|^{2}}{2}}|\pi|(d y) d s$. It was proved in (14) that for any $0<\alpha \leq 2$ and $c>0, \pi \in \mathbf{K}_{d, \alpha}$ if and only if $\lim _{t \rightarrow 0} N_{\pi}^{\alpha, c}(t)=0$.
(ii) From the definition of the Kato class, it is easy to see that if $0<\alpha<\beta \leq 2$, $\mathbf{K}_{d, \alpha} \subset \mathbf{K}_{d, \beta}$. And for $\pi \in \mathbf{K}_{d, 2},|\pi|(D)<\infty$.

Let $D$ be a bounded, connected $C^{1,1}$-domain and $\varphi \in C(\partial D)$. Hereafter we fix some $0<\alpha_{0}<1$ and let $\mu_{i}, \nu, \rho \in \mathbf{K}_{d, 1}$ for each $1 \leq i \leq d$. Without loss of generality, we assume the measures above vanish on $D^{c}$. We will use $\cdot$ to denote the inner product of the Euclidean space $\mathbb{R}^{d} .|\cdot|$ and $\|\cdot\|_{C(\bar{D})}$ denote the norm in $\mathbb{R}^{d}$ and the supremum norm in $C(\bar{D})$ respectively. Let $R_{0}$ be the diameter of $D$, i.e. $R_{0}=\sup _{x, y \in D}|x-y|$. For a signed measure $\pi$ on $\mathbb{R}^{d}$, denote by $\pi^{+}$and $\pi^{-}$the positive and negative parts of $\pi$ respectively. Let $0<\alpha<1$, recall that the Hölder space $C^{1, \alpha}(\bar{D})$ is defined as the subset of $C^{1}(\bar{D})$ with the norm $\|\cdot\|_{C^{1, \alpha}(\bar{D})}$, where

$$
\|f\|_{C^{1, \alpha}(\bar{D})}:=\|f\|_{C(\bar{D})}+\sup _{1 \leq i \leq d}\left\|\mid \partial_{x_{i}} f\right\|_{C(\bar{D})}+\sup _{1 \leq i \leq d} \sup _{x, y \in \bar{D}, x \neq y} \frac{\left|\partial_{x_{i}} f(x)-\partial_{x_{i}} f(y)\right|}{|x-y|^{\alpha}}<\infty .
$$

For $f \in C^{1, \alpha}(\partial D)$, define $\|f\|_{C^{1, \alpha}(\partial D)}:=\inf _{\Phi}\|\Phi\|_{C^{1, \alpha}(\bar{D})}$, where the infimum is taken over the set of all global extensions $\Phi$ of $f$ to $\bar{D}$.

Let $\mathcal{A} u:=\frac{1}{2} \Delta u+\nabla u \cdot \mu+u \nu$. For $u, v \in C_{0}^{\infty}(D)$, define the quadratic form

$$
\mathcal{Q}(u, v):=\frac{1}{2} \sum_{i=1}^{d} \int_{D} \frac{\partial u(x)}{\partial x_{i}} \frac{\partial v(x)}{\partial x_{i}} d x-\sum_{i=1}^{d} \int_{D} \frac{\partial u(x)}{\partial x_{i}} v(x) \mu_{i}(d x)-\int_{D} u(x) v(x) \nu(d x) .
$$

Definition 2.2 A function $u \in C^{1}(D) \bigcap C(\bar{D})$ is called a weak solution to the boundary value problem

$$
\begin{cases}\mathcal{A} u=-\rho, & \forall x \in D  \tag{2.1}\\ \left.u(x)\right|_{\partial D}=\varphi(x), & \forall x \in \partial D\end{cases}
$$

if $u$ satisfies

$$
\mathcal{Q}(u, \phi)=\int_{D} \phi(x) \rho(d x) \text { for any } \phi \in C_{0}^{\infty}(D)
$$

and $u(x)=\varphi(x)$ when $x \in \partial D$.
Remark 2.2 Since for each $1 \leq i \leq d$, the measures $\mu_{i}, \nu, \rho$ are not absolutely continuous w.r.t. dx, the classical notion of weak solution in the Sobolev space $W^{1,2}(D)$ is not suitable anymore.

Fix a nonnegative smooth radial function $\psi \in C_{0}^{\infty}\left(B_{1}(0)\right)$ with $\int_{\mathbb{R}^{d}} \psi(x) d x=1$. Let $\psi_{n}(x)=2^{n d} \psi\left(2^{n} x\right)$ and $G_{n}(x):=\left(G_{n}^{1}(x), G_{n}^{2}(x), \ldots, G_{n}^{d}(x)\right)$, where

$$
G_{n}^{i}(x):=\int_{\mathbb{R}^{d}} \psi_{n}(x-y) \mu_{i}(d y), \quad \forall 1 \leq i \leq d
$$

It was shown in [2] that there exists a unique strong Markov process $\left\{\Omega, \mathcal{F}_{t}, X_{t}, P_{x}, x \in\right.$ $\left.\mathbb{R}^{d}\right\}$ such that

$$
X_{t}=X_{0}+W_{t}+A_{t}
$$

where $W_{t}$ is a $\mathcal{F}_{t^{-}}$standard Brownian motion in $\mathbb{R}^{d}$ and $A_{t}=\lim _{n \rightarrow \infty} \int_{0}^{t} G_{n}\left(X_{s}\right) d s$ uniformly in t over finite intervals, where the convergence is in probability. By Theorem 3.14 in [14], we know that $X_{t}$ has a continuous transition density function $p(t, x, y)$ which admits a two-sided Gaussian type estimate, i.e. there exist positive constants $M_{i}, 1 \leq i \leq 5$, such that for any $(t, x, y) \in(0, \infty) \times \mathbb{R}^{d} \times \mathbb{R}^{d}$,

\begin{equation*}
M_{1} e^{-M_{2} t} t^{-\frac{d}{2}} e^{-\frac{M_{3}|x-y|^{2}}{2 t}} \leq p(t, x, y) \leq M_{4} e^{M_{5} t} t^{-\frac{d}{2}} e^{-\frac{M_{6}|x-y|^{2}}{2 t}} . \tag{2.2}
\end{equation*}
$$

Definition 2.3 Fix a constant $c>M_{5}$. For any signed measure $\pi$ in $\mathbb{R}^{d}$, we say that $a$ CAF $B_{t}$ of $X$ is associated with $\pi$, if

$$
B_{t}=B_{t}^{+}-B_{t}^{-}, \quad \forall t>0,
$$

where $B_{t}^{+}$and $B_{t}^{-}$are positive CAFs satisfy that for any $x \in \mathbb{R}^{d}$,

$$
\begin{aligned}
& E_{x}\left[\int_{0}^{\infty} e^{-c t} d B_{t}^{+}\right]=\int_{0}^{\infty} e^{-c t} \int_{\mathbb{R}^{d}} p(t, x, y) \pi^{+}(d y) d t \\
& E_{x}\left[\int_{0}^{\infty} e^{-c t} d B_{t}^{-}\right]=\int_{0}^{\infty} e^{-c t} \int_{\mathbb{R}^{d}} p(t, x, y) \pi^{-}(d y) d t .
\end{aligned}
$$

Remark 2.3 By Proposition 3.2 in the next section, we know that for any $\pi \in \mathbf{K}_{d, 2}$ with compact support, there exists a unique CAF $B_{t}$ associated with $\pi$. Moreover $B_{t}$ is independent of the choice of the constant $c$.

## 3 Preliminary results

As a preparation of solving the boundary value problem (2.1), in this section, we prove a number of results on the regularity of the heat kernel and establish the existence and properties of the CAFs associated with Kato class measures.

We firstly give the following result concerns general Feller processes.
Lemma 3.1 Assume that a Feller process $\left\{Y_{t}, Q_{x}, x \in \mathbb{R}^{d}\right\}$ has a continuous transition density function w.r.t. the Lebesgue measure, which admits a Gaussian type lower estimate. Let $\tau_{\bar{D}}$ be the first exit time of $Y_{t}$ from $\bar{D}$. Then we have

$$
\begin{equation*}
Q_{x}\left(\tau_{\bar{D}}=0\right)=1, \forall x \in \partial D . \tag{3.1}
\end{equation*}
$$

and

$$
\begin{equation*}
Q_{x}\left(\tau_{\bar{D}}<\infty\right)=1, \forall x \in \bar{D} \tag{3.2}
\end{equation*}
$$

Proof: First we show (3.1). By Theorem IV.2.19 in [13] we know that for any $x \in \partial D$, there exists a ball $B_{r}(x)$ such that $Q_{x}\left(\tau_{\overline{B_{r}(x) \cap D}}=0\right)>0$. By Blumenthal's zero-or-one law for Feller processes (see Theorem 2.3.6 in [6]), we deduce that $Q_{x}\left(\tau_{\overline{B_{r}(x) \cap D}}=0\right)=1$. Since regularity is a local condition, we have $Q_{x}\left(\tau_{\bar{D}}=0\right)=1$.

Now we proof (3.2). There exists constants $c_{1}, c_{2}>0$ such that the transition density function $g(t, x, y)$ of $Y$ satisfies

$$
g(t, x, y) \geq c_{1} t^{-\frac{d}{2}} e^{-\frac{c_{2}|x-y|^{2}}{2 t}}, \forall(t, x, y) \in(0,1] \times \mathbb{R}^{d} \times \mathbb{R}^{d}
$$

Thus, we have

$$
\begin{align*}
\sup _{x \in \bar{D}} Q_{x}\left[Y_{1} \in \bar{D}\right] & =1-\inf _{x \in \bar{D}} Q_{x}\left(Y_{1} \in \bar{D}^{c}\right) \\
& \leq 1-\inf _{x \in \bar{D}} \int_{\bar{D}^{c}} c_{1} e^{-\frac{c_{2}|x-y|^{2}}{2}} d y  \tag{3.3}\\
& \leq 1-\int_{\left\{z:|z|>R_{0}\right\}} c_{1} e^{-\frac{c_{2}|z|^{2}}{2}} d z:=\beta<1,
\end{align*}
$$

where $R_{0}$ is the diameter of $D$. Hence

$$
\begin{equation*}
\sup _{x \in \bar{D}} Q_{x}\left(\tau_{\bar{D}}>1\right) \leq \sup _{x \in \bar{D}} Q_{x}\left[Y_{1} \in \bar{D}\right] \leq \beta \tag{3.4}
\end{equation*}
$$

By (3.3), (3.4) and the Markov property of $Y$, we have

$$
\begin{aligned}
\sup _{x \in \bar{D}} Q_{x}\left(\tau_{\bar{D}}>2\right) & =\sup _{x \in \bar{D}} Q_{x}\left(Y_{1} \in \bar{D} ; \tau_{\bar{D}}>2\right) \\
& =\sup _{x \in \bar{D}} E_{x}^{Q}\left[Y_{1} \in \bar{D} ; Q_{Y_{1}}\left[\tau_{\bar{D}}>1\right]\right] \\
& \leq \beta \sup _{x \in \bar{D}} Q_{x}\left[Y_{1} \in \bar{D}\right] \leq \beta^{2},
\end{aligned}
$$

where $E_{x}^{Q}$ is the expectation under $P_{x_{0}}$.
By inductions, we have $\sup _{x \in \bar{D}} Q_{x}\left(\tau_{\bar{D}}>n\right) \leq \beta^{n}$. Letting $n \rightarrow \infty$, we obtain (3.2).
Given a signed measure $\pi$ in $\mathbb{R}^{d}$, set

$$
\begin{equation*}
H_{n}(x):=\int_{\mathbb{R}^{d}} \psi_{n}(x-y) \pi(d y) \tag{3.5}
\end{equation*}
$$

Lemma 3.2 Assume $\pi \in \mathbf{K}_{d, \alpha}$ for some $0<\alpha \leq 2$. Then for any $n \geq 1, r, c>0$, we have

$$
\begin{equation*}
M_{H_{n}}^{\alpha}(r) \leq M_{\pi}^{\alpha}(r), \tag{3.6}
\end{equation*}
$$

and

$$
\begin{equation*}
\lim _{t \rightarrow 0} \sup _{n \geq 1} N_{H_{n}}^{\alpha, c}(t)=0 \tag{3.7}
\end{equation*}
$$

where $M_{H_{n}}^{\alpha}(r):=M_{H_{n}(x) d x}^{\alpha}(r)$ and $N_{H_{n}}^{\alpha, c}(t):=N_{H_{n}(x) d x}^{\alpha, c}(t)$.
Proof: For any $r>0$, by Fubini's theorem,

$$
\begin{aligned}
M_{H_{n}}^{\alpha}(r) & =\sup _{x \in \mathbb{R}^{d}} \int_{B_{r}(x)}|x-y|^{\alpha-d}\left|H_{n}(y)\right| d y \\
& \leq \sup _{x \in \mathbb{R}^{d}} \int_{B_{r}(x)}|x-y|^{\alpha-d} \int_{\mathbb{R}^{d}} \psi_{n}(y-z)|\pi|(d z) d y \\
& =\sup _{x \in \mathbb{R}^{d}} \int_{\mathbb{R}^{d}} \int_{B_{r}(x)} \psi_{n}(y-z)|x-y|^{\alpha-d} d y|\pi|(d z) \\
& =\sup _{x \in \mathbb{R}^{d}} \int_{\mathbb{R}^{d}} \int_{B_{r}(x-z)} \psi_{n}\left(y^{\prime}\right)\left|x-z-y^{\prime}\right|^{\alpha-d} d y^{\prime}|\pi|(d z) \\
& =\sup _{x \in \mathbb{R}^{d}} \int_{\mathbb{R}^{d}} \psi_{n}\left(y^{\prime}\right) \int_{B_{r}\left(x-y^{\prime}\right)}\left|x-y^{\prime}-z\right|^{\alpha-d}|\pi|(d z) d y^{\prime} \\
& \leq M_{\pi}^{\alpha}(r) .
\end{aligned}
$$

This together with the proof of Proposition 2.2 in [14, we deduce that for any $c>0$, $\lim _{t \rightarrow 0} \sup _{n \geq 1} N_{H_{n}}^{\alpha, c}(t)=0$.

Following the arguments of Lemma 3.1 in 18 we can also show:

Note that $\int_{0}^{\infty} t^{-\frac{d}{2}} e^{-\frac{M_{6}|x-y|^{2}}{2 t}} d t \leq c_{1}|x-y|^{2-d}$ for some $c_{1}>0$ and $\pi^{+} \in \mathbf{K}_{d, 2}$. Using (2.2) and Lemma 3.4, we have that for any $T>0$,

\leq & M_{4} e^{\left(M_{5}-c\right) T} \sup _{x \in \mathbb{R}^{d}} \int_{\mathbb{R}^{d}} \int_{0}^{\infty} t^{-\frac{d}{2}} e^{-\frac{M_{6}|x-y|^{2}}{2 t}} d t \pi^{+}(d y) \\
\leq & M_{4} e^{\left(M_{5}-c\right) T} c_{1} \sup _{x \in \mathbb{R}^{d}} \int_{B_{r}(0)}|x-y|^{2-d} \pi^{+}(d y) \\
\leq & 2 M_{4} e^{\left(M_{5}-c\right) T} c_{1} M_{\pi^{+}}^{2}(r) .
\end{aligned}
$$

Since supp $H_{n}^{+} \subset B_{r+1}(0)$ and $M_{H_{n}^{+}}^{2}(r+1) \leq M_{\pi^{+}}^{2}(r+1)$ by (3.6), we similarly have

\lim _{T \rightarrow \infty} \sup _{n \geq 1} \sup _{x \in \mathbb{R}^{d}} \int_{T}^{\infty} e^{-c t} \int_{\mathbb{R}^{d}} p(t, x, y) H_{n}^{+}(y) d y d t=0 . \tag{3.26}
\end{array}

On the other hand, taking into account Remark 2.1 (i), (2.2) and (3.7), we can show that

\lim _{\delta \rightarrow 0} \sup \sup _{n \geq 1} \int_{x \in \mathbb{R}^{d}}^{\delta} \int_{0}^{\delta c t} e_{\mathbb{R}^{d}} p(t, x, y) H_{n}^{+}(y) d y d t=0 . \tag{3.27}
\end{align*}

Fix $\delta<T$. For any $R>1$, note that if $x \in B_{r+4 R}(0)^{c}$, then supp $\pi^{+} \bigcup$ supp $H_{n}^{+} \subset\{y$ : $|x-y| \geq 3 R\}$. Then similar to the proof of Lemma 3.5 in [14], we have

& \left.+\int_{\delta}^{T} \int_{\{y:|x-y| \geq 3 R\}} M_{4} t^{-\frac{d}{2}} e^{-\frac{M_{6}|x-y|^{2}}{2 t}} H_{n}^{+}(y) d y d t\right\} \\
\leq & c_{2} M_{4} T \lim _{R \rightarrow \infty} \sup _{x \in \mathbb{R}^{d}} \int_{\{y:|x-y| \geq R\}} e^{-\frac{M_{6}|x-y|^{2}}{2 T}} \pi^{+}(d y)=0,
\end{aligned}
$$

where $c_{2}>0$ is some constant, and the last equality follows from Proposition 2.2 in [14]. Thus, for any given $\varepsilon>0$, we can choose $R$ sufficiently large so that

Hence by (3.25), Theorem IV.2.13 and Theorem IV.3.13 in [3], there exists a unique positive CAF $B_{t}^{+}$such that for any $x \in \mathbb{R}^{d}$, (3.21) holds. Similarly there exists a unique positive CAF $B_{t}^{-}$satisfying (3.22). Hence there exists a unique CAF $B_{t}:=B_{t}^{+}-B_{t}^{-}$is associated with $\pi$.

Next we prove (3.23).

\leq & 2 M_{7}(1)|\pi|\left(B_{r}(0)\right) \frac{e^{-M_{8}(1) T}}{M_{8}(1)} .

Using the above bound and the fact that $p^{D}(t, x, y)$ is continuous on $(0, \infty) \times \bar{D} \times \bar{D}$, and following the same arguments as in the proof of (3.25), we obtain

\leq & M_{13} \sup _{n \geq 1} \sup _{x \in \mathbb{R}^{d}} \int_{B_{r+1}(0)} c_{3}|x-y|^{2-d} \bar{H}_{n}(y) d y \\
\leq & 2 M_{13} c_{3} M_{\pi}^{2}(r+1)<\infty,
\end{align*}
$$

for some $c_{3}>0$.
By (3.32), (3.33) and the strong Markov property of $X$, we see that

The proof of the following result is straightforward. We omit it.

\lim _{t \rightarrow 0} \sup _{x \in \mathbb{R}^{d}} E_{x}\left[e^{c|B| t \mid t}\right]=1 . \tag{3.42}

we have $\int_{0}^{t} I_{E}\left(X_{s}\right) d B_{s}=B_{t}^{+}$. Similarly we have $\int_{0}^{t} I_{E^{c}}\left(X_{s}\right) d B_{s}=-B_{t}^{-}$. Hence $|B|_{t}=$ $B_{t}^{+}+B_{t}^{-}$, which is the CAF associated with $|\pi|$. Similar to the proof of (3.24), we have (3.39).
(3.40)-(3.42) follow from Lemma 3.5 and (3.39).

Let $\pi \in \mathbf{K}_{d, 1}$. For any $r>0$ and $x_{0} \in \mathbb{R}^{d}$, recall that $q^{B_{r}\left(x_{0}\right)}(t, x, y)$ is the transition density of the killed Brownian motion $W^{B_{r}\left(x_{0}\right)}$. Define $R_{B_{r}\left(x_{0}\right)} \pi(x):=\int_{0}^{\infty} \int_{B_{r}\left(x_{0}\right)} q^{B_{r}\left(x_{0}\right)}(t, x, y) \pi(d y) d t$ and the measure $\mathfrak{B}_{B_{r}\left(x_{0}\right)} \pi:=\left(\nabla R_{B_{r}\left(x_{0}\right)} \pi\right) \cdot \mu_{B_{r}\left(x_{0}\right)}$, where $\mu_{B_{r}\left(x_{0}\right)}(d x):=I_{B_{r}\left(x_{0}\right)}(x) \mu(d x)$.

\sup _{x \in B_{r}}\left|\nabla R_{B_{r}} \pi(x)\right| & \leq \sup _{x \in B_{r}} \int_{0}^{\infty} \int_{B_{r}}\left|\nabla_{x} q^{B_{r}}(t, x, y)\right||\pi|(d y) d t \\
& \leq \sup _{x \in \mathbb{R}^{d}} \int_{B_{r}} \int_{0}^{\infty} c_{4} t^{-\frac{d+1}{2}} e^{-\frac{c_{2}|x-y|^{2}}{2 t}} d t|\pi|(d y) \\
& \leq \sup _{x \in \mathbb{R}^{d}} \int_{B_{r}} c_{4} c_{5}|x-y|^{1-d}|\pi|(d y) \\
& \leq 2 c_{4} c_{5} M_{\pi}^{1}(r)
\end{aligned}
$$

for some $c_{5}>0$.
Take $r_{0}>0$, such that $\sum_{1 \leq i \leq d} M_{\mu_{i}}^{1}\left(r_{0}\right) \leq \frac{1}{4 c_{4} c_{5}}$. Then for any $r \leq r_{0}$,

\begin{aligned}
M_{\mathfrak{B}_{B_{r}} \pi}^{1}(r) & \leq \sup _{x \in B_{r}}\left|\nabla R_{B_{r}} \pi(x)\right| \sum_{1 \leq i \leq d} M_{\mu_{i}}^{1}(r) \\
& \leq 2 c_{4} c_{5} M_{\pi}^{1}(r) \sum_{1 \leq i \leq d} M_{\mu_{i}}^{1}(r) \\
& \leq \frac{1}{2} M_{\pi}^{1}(r) .
\end{aligned}
$$

## 4 Case for $\nu=0$

In this section, we will establish the existence and uniqueness of solution to the following boundary problem:

$$
\begin{cases}\frac{1}{2} \Delta u+\nabla u \cdot \mu=-\rho, & \forall x \in D  \tag{4.1}\\ \left.u(x)\right|_{\partial D}=\varphi(x), & \forall x \in \partial D\end{cases}
$$

Recall that $\varphi \in C(\partial D)$. Set $\tilde{u}(x):=E_{x}\left[\varphi\left(X_{\tau_{D}}\right)\right]$. We have the following result.
Lemma 4.1 For any $x_{0} \in \partial D$, we have

\lim _{D \ni x \rightarrow x_{0}} \tilde{u}(x)=\tilde{u}\left(x_{0}\right)=\varphi\left(x_{0}\right) .
$$

Proof: Set $\tilde{u}_{0}(x):=E_{x}\left[\varphi\left(W_{\tau_{D}}\right)\right]$. It is well known that $\tilde{u}_{0}$ is continuous on $\bar{D}$ and $\tilde{u}_{0}\left(x_{0}\right)=$ $\varphi\left(x_{0}\right)$ for $x_{0} \in \partial D$. For any $\delta>0$ and $x \in D$, we have

\begin{align*}
& \tilde{u}(x)-\tilde{u}_{0}(x) \\
= & E_{x}\left[\tilde{u}_{0}\left(X_{\tau_{D}}\right)\right]-\tilde{u}_{0}(x) \\
= & E_{x}\left[\tilde{u}_{0}\left(X_{\tau_{D}}\right) ; \tau_{D}>\delta\right]+E_{x}\left[\tilde{u}_{0}\left(X_{\tau_{D}}\right)-\tilde{u}_{0}(x) ; \tau_{D} \leq \delta\right]-\tilde{u}_{0}(x) P_{x}\left(\tau_{D}>\delta\right)  \tag{4.2}\\
\leq & 2\left\|\mid \tilde{u}_{0}\right\|_{C(\bar{D})} P_{x}\left(\tau_{D}>\delta\right)+E_{x}\left[\sup _{s \leq \delta}\left|\tilde{u}_{0}\left(X_{s}\right)-\tilde{u}_{0}(x)\right| ; \tau_{D} \leq \delta\right] .
\end{align*}
$$

Fix $x_{0} \in \partial D$. Since $\left(X_{t}, P_{x}\right)$ is strong Feller and $x_{0}$ is regular for $D^{c}$, similar to the proof of Proposition 4.4.1 in [6] we can show that $x \mapsto P_{x}\left(\tau_{D}>\delta\right)$ is upper semi-continuous in $\mathbb{R}^{d}$. Hence

$$
\begin{equation*}
\lim _{D \ni x \rightarrow x_{0}} P_{x}\left(\tau_{D}>\delta\right)=0 \tag{4.3}
\end{equation*}
$$

For any $\varepsilon>0$, since $\tilde{u}_{0}$ is uniformly continuous on $\bar{D}$, there exists a $\beta>0$ such that for any $x, y \in \bar{D}$ with $|x-y|<\beta$, we have

\begin{equation*}
\left|\tilde{u}_{0}(x)-\tilde{u}_{0}(y)\right| \leq \varepsilon . \tag{4.4}
\end{equation*}
$$

By Remark 3.1, (3.39) and the Doob's inequality,

\begin{aligned}
& \lim _{\delta \rightarrow 0} \sup _{x \in \mathbb{R}^{d}} P_{x}\left[\sup _{t \leq \delta}\left|X_{t}-x\right| \geq \beta\right] \\
\leq & \lim _{\delta \rightarrow 0} \sup _{x \in \mathbb{R}^{d}} P_{x}\left[\sup _{t \leq \delta}\left|W_{t}\right| \geq \frac{\beta}{2}\right]+\lim _{\delta \rightarrow 0} \sup _{x \in \mathbb{R}^{d}} P_{x}\left[\sup _{t \leq \delta}\left|A_{t}\right| \geq \frac{\beta}{2}\right] \\
\leq & \frac{16}{\beta^{2}} \lim _{\delta \rightarrow 0} \sup _{x \in \mathbb{R}^{d}} E_{x}\left[\left|W_{\delta}\right|^{2}\right]+\frac{2}{\beta} \lim _{\delta \rightarrow 0} \sup _{x \in \mathbb{R}^{d}} E_{x}\left[|A|_{\delta}\right] \\
\leq & \frac{16}{\beta^{2}} \lim _{\delta \rightarrow 0} \sup _{x \in \mathbb{R}^{d}} E_{x}\left[\left|W_{\delta}\right|^{2}\right]+\frac{2}{\beta} \lim _{\delta \rightarrow 0} \sup _{x \in \mathbb{R}^{d}} \sum_{1 \leq i \leq d} \int_{0}^{\delta} \int_{\mathbb{R}^{d}} p(s, x, y)\left|\mu_{i}\right|(d y) d s=0 .
\end{aligned}
$$

Thus there exists a constant $\delta>0$ such that

$$
\sup _{x \in \mathbb{R}^{d}} P_{x}\left(\sup _{t \leq \delta}\left|X_{t}-x\right| \geq \beta\right) \leq \varepsilon .
$$

Hence, in view of (4.4), for $x \in D$,

$$
\begin{aligned}
& E_{x}\left[\sup _{s \leq \delta}\left|\tilde{u}_{0}\left(X_{s}\right)-\tilde{u}_{0}(x)\right| ; \tau_{D} \leq \delta\right] \\
\leq & E_{x}\left[\sup _{s \leq \delta}\left|\tilde{u}_{0}\left(X_{s}\right)-\tilde{u}_{0}(x)\right| ; \sup _{t \leq \delta}\left|X_{t}-x\right| \geq \beta\right]+E_{x}\left[\sup _{s \leq \delta}\left|\tilde{u}_{0}\left(X_{s}\right)-\tilde{u}_{0}(x)\right| ; \sup _{t \leq \delta}\left|X_{t}-x\right|<\beta\right] \\
\leq & 2\left|\left|\tilde{u}_{0}\right| \|_{C(\bar{D})} P_{x}\left[\sup _{t \leq \delta}\left|X_{t}-x\right| \geq \beta\right]+E_{x}\left[\sup _{|x-y| \leq \beta}\left|\tilde{u}_{0}(y)-\tilde{u}_{0}(x)\right| ; \sup _{t \leq \delta}\left|X_{t}-x\right|<\beta\right]\right. \\
\leq & 2 \varepsilon\left\|\tilde{u}_{0}\right\|_{C(\bar{D})}+\varepsilon .
\end{aligned}
$$

Combining (4.2), (4.3) with (4.5), we arrive at

$$
\begin{equation*}
\lim _{D \ni x \rightarrow x_{0}}\left|\tilde{u}(x)-\tilde{u}_{0}(x)\right| \leq 2 \varepsilon\left\|\tilde{u}_{0}\right\|_{C(\bar{D})}+\varepsilon . \tag{4.6}
\end{equation*}

Since $\lim _{D \ni x \rightarrow x_{0}} \tilde{u}_{0}(x)=\varphi\left(x_{0}\right)=\tilde{u}\left(x_{0}\right)$ by Lemma 3.1, letting $\varepsilon \rightarrow 0$ in (4.6), we see that $\lim _{D \ni x \rightarrow x_{0}} \tilde{u}(x)=\tilde{u}\left(x_{0}\right)=\varphi\left(x_{0}\right)$.

Next we will show that $\tilde{u}$ is a weak solution to the problem:

\begin{cases}\frac{1}{2} \Delta \tilde{u}+\nabla \tilde{u} \cdot \mu=0, & \forall x \in D \\ \left.\tilde{u}(x)\right|_{\partial D}=\varphi(x), & \forall x \in \partial D\end{cases}
$$

To this end, we will approximate $\tilde{u}$ by approximate smooth functions.
Recall that $X_{t}^{n}$ is defined in (3.8). Set $\tilde{u}_{n}(x):=E_{x}\left[\varphi\left(X_{\tau_{D}^{n}}^{n}\right)\right]$, where $\tau_{D}^{n}$ is the first exit time of $X_{t}^{n}$. We are going to show that $\tilde{u}_{n} \rightarrow \tilde{u}$ and $\nabla \tilde{u}_{n} \rightarrow \nabla \tilde{u}$ uniformly on compact subsets of $D$. This will be done in the following two lemmas.

Lemma 4.2 For any $x \in D$, we have

\lim _{n \rightarrow \infty} \tilde{u}_{n}(x)=\tilde{u}(x) \tag{4.7}
\end{equation*}
$$

Proof: It is known from [2] and [14] that $X^{n}$ converges in law to $X$.. Fix $x \in D$. By Skorokhod's representation theorem, there exist a probability space $\left(\widehat{\Omega}, \widehat{P}_{x}\right)$ and a sequence
of diffusion processes $\left\{\widehat{X}^{n}\right\}_{n \geq 1}$ and $\widehat{X}$, which have the same distributions as $\left\{X^{n}\right\}_{n \geq 1}$ and $X$, such that $\widehat{X}^{n}$ converges to $\widehat{X}$ in the space $C\left([0, \infty), \mathbb{R}^{d}\right)$ almost surely w.r.t. $\widehat{P}_{x}$.

We still use $\tau_{D}$ and $\tau_{D}^{n}$ to denote the first exit time of $\widehat{X}$ and $\widehat{X}^{n}$ respectively. Since for any Borel measurable $A \subset \partial D,\left\{f \in C\left([0, \infty), \mathbb{R}^{d}\right): f\left(e_{f}\right) \in A\right\} \in \mathcal{B}\left(C\left([0, \infty), \mathbb{R}^{d}\right)\right)$, where $e_{f}:=\inf \{t>0: f(t) \notin D\}$, we have $E_{x}\left[\varphi\left(X_{\tau_{D}}\right)\right]=\widehat{E}_{x}\left[\varphi\left(\widehat{X}_{\tau_{D}}\right)\right]$, where $\widehat{E}_{x}$ is the expectation w.r.t. $\widehat{P}_{x}$. The same is true for $X^{n}$ and $\widehat{X}^{n}$, i.e. $E_{x}\left[\varphi\left(X_{\tau_{D}^{n}}^{n}\right)\right]=\widehat{E}_{x}\left[\varphi\left(\widehat{X}_{\tau_{D}^{n}}^{n}\right)\right]$. Hence, to prove (4.7) is the same as to show that

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \widehat{E}_{x}\left[\varphi\left(\widehat{X}_{\tau_{D}^{n}}^{n}\right)\right]=\widehat{E}_{x}\left[\varphi\left(\widehat{X}_{\tau_{D}}\right)\right] . \tag{4.8}
\end{equation*}
$$

Since the transition density functions of $\widehat{X}_{t}$ and $\widehat{X}_{t}^{n}$ have Gaussian type two-sided estimates, by Lemma 3.1, we have

\widehat{P}_{x}\left(\tau_{\bar{D}}<\infty\right)=\widehat{P}_{x}\left(\tau_{\bar{D}}<\infty\right)=1 .
$$

For $l \geq 1$, set $C_{l}:=\bigcup_{n \geq 1}\left\{\omega \in \widehat{\Omega}: \tau_{D}^{n}(\omega)>l\right\}$. Then

$$
\bigcap_{l \geq 1} C_{l}=\left\{\omega \in \widehat{\Omega}: \exists \text { a sequence of } n_{k} \uparrow \infty \text {, s.t. } \tau_{D}^{n_{k}}(\omega)>k\right\}, P_{x}-\text { a.e.. }
$$

For any $\omega \in\left\{\tau_{\bar{D}}<\infty\right\} \bigcap\left\{\widehat{X}^{n} \rightarrow \widehat{X}\right\}$, there exists a constant $T(\omega)<\infty$ such that $\widehat{X}(\omega, T(\omega)) \in \bar{D}^{c}$ and hence we can find an integer $N(\omega)>0$, such that $\widehat{X}^{n}(\omega, T(\omega)) \in \bar{D}^{c}$ for any $n \geq N(\omega)$. Thus, we have $\tau_{D}^{n}(\omega)<T(\omega)$ for $n \geq N(\omega)$. Therefore $\left\{\tau_{\bar{D}}<\infty\right\} \bigcap\left\{\widehat{X}^{n} \rightarrow\right.$ $\widehat{X}\} \subset\left(\bigcap_{l \geq 1} C_{l}\right)^{c}$. Consequently,

$$
\begin{equation*}
\widehat{P}_{x}\left(\bigcap_{l \geq 1} C_{l}\right)=0 . \tag{4.9}
\end{equation*}
$$

Set $\widehat{\Omega}_{l}:=\bigcap_{k \geq 1}\left\{\tau_{D}^{k} \leq l\right\} \bigcap\left\{\widehat{X}^{n} \rightarrow \widehat{X}\right\} \bigcap\left\{\tau_{D}=\tau_{\bar{D}}<\infty\right\}$. Fix $\omega \in \widehat{\Omega}_{l}$. Since $\widehat{X}^{n}$ converges uniformly to $\widehat{X}$ over $[0, l]$ and $\widehat{X}_{\tau_{D}^{n}}^{n} \in \partial D$, we have $\widehat{X}_{\tau} \in \partial D$ for any limit point $\tau$ of $\left\{\tau_{D}^{n}\right\}_{n \geq 1}$ and therefore $\tau_{D} \leq \tau$. On the other hand, for any $c>0$, since $\tau_{\bar{D}}(\omega)=\tau_{D}(\omega)$, there exists a $t<\tau_{D}+c$ such that $\widehat{X}_{t} \in \bar{D}^{c}$. Thus, $\widehat{X}_{t}^{n} \in \bar{D}^{c}$ for any $n$ sufficiently large. Hence $\tau_{D}^{n}<t<\tau_{D}+c$, which yields $\tau<\tau_{D}+c$. Let $c \rightarrow 0$ to deduce that $\tau=\tau_{D}$. Thus we have proven that $\lim _{n \rightarrow \infty} \tau_{D}^{n}(\omega)=\tau_{D}(\omega)$ for $\omega \in \widehat{\Omega}_{l}$. Since $\widehat{\Omega}_{l} \subset \bigcap_{n \geq 1}\left\{\tau_{D}^{n} \leq l\right\}$, by the uniform convergence of $\widehat{X}^{n}$ over finite intervals, we deduce that

$$
\lim _{n \rightarrow \infty} \widehat{X}_{\tau_{D}^{n}}^{n}(\omega)=\widehat{X}_{\tau_{D}}(\omega), \forall \omega \in \widehat{\Omega}_{l} .
$$

On the other hand, by the strong Markov property of $\hat{X}$ and Lemma 3.1,

\widehat{P}_{x}\left(\tau_{\bar{D}} \neq \tau_{D}\right)=\widehat{P}_{x}\left(\tau_{\bar{D}}>\tau_{D}\right)=\widehat{E}_{x}\left[\widehat{P}_{\widehat{X}_{\tau_{D}}}\left(\tau_{\bar{D}}>0\right)\right]=0
$$

Together with (4.9), we conclude that $\widehat{P}_{x}\left(\bigcup_{l \geq 1} \widehat{\Omega}_{l}\right)=1$. Hence

\lim _{n \rightarrow \infty} \widehat{X}_{\tau_{D}^{n}}^{n}(\omega)=\widehat{X}_{\tau_{D}}(\omega), \widehat{P}_{x}-\text { a.e.. }
$$

which yields (4.8) due to the continuity of $\varphi$.

It is well known that $\tilde{u}_{n}$ is the solution of the following equation:

\begin{cases}\frac{1}{2} \Delta \tilde{u}_{n}(x)+\nabla \tilde{u}_{n}(x) \cdot G_{n}(x)=0, & \forall x \in D  \tag{4.10}\\ \left.\tilde{u}_{n}(x)\right|_{\partial D}=\varphi(x), & \forall x \in \partial D\end{cases}
$$

From the smoothness of $G_{n}$ and Theorem 6.17 in [10] we know that $\tilde{u}_{n} \in C^{\infty}(D)$.
We have the following Lemma.
Lemma 4.3 Assume $\varphi \in C^{1, \alpha_{0}}(\partial D)$. Then $\tilde{u} \in C_{b}^{1}(D) \bigcap C(\bar{D})$ and for any compact subset $K \subset D$,

\lim _{n \rightarrow \infty} \sup _{x \in K}\left|\nabla \tilde{u}_{n}-\nabla \tilde{u}(x)\right|=0 \tag{4.11}
\end{equation*}

Moreover, if $\mu_{i} \in \mathbf{K}_{d, 1-\alpha_{0}}$ for each $1 \leq i \leq d$, then $\tilde{u} \in C^{1, \alpha_{0}}(\bar{D})$ and there exists a $c>0$, depending on $\mu$ only via the function $\max _{1 \leq i \leq d} M_{\mu_{i}}^{1-\alpha_{0}}(\cdot)$, such that

Proof: Recall that $p^{n, D}(t, x, y)$ is the transition density function of the killed process $X^{n, D}$.
Note that $\tilde{u}_{0}(x)=E_{x}\left[\varphi\left(W_{\tau_{D}}\right)\right]$ is the solution of the Laplace's equation:

\left\|\tilde{u}_{0}\right\|_{C^{1, \alpha_{0}}(\bar{D})} \leq c_{1}\|\varphi\|_{C^{1, \alpha_{0}}(\partial D)}<\infty . \tag{4.13}
\end{equation*}
$$

for some constant $c_{1}>0$.
First we prove that for any compact subset $K \subset D$,

& \lim _{n \rightarrow \infty} \sup _{x \in K} \mid \int_{0}^{\infty} \int_{D} \partial_{x_{i}} p^{D}(s, x, y) \nabla \tilde{u}_{0}(y) \cdot \mu(d y) d s \\
& \quad-\int_{0}^{\infty} \int_{D} \partial_{x_{i}} p^{n, D}(s, x, y) \nabla \tilde{u}_{0}(y) \cdot G_{n}(y) d y d s  \tag{4.14}\\
& =0
\end{align*}
$$

Hereafter, set $|\mu|:=\sum_{1 \leq i \leq d}\left|\mu^{i}\right|$. For $0<\delta<2<T, 1 \leq i \leq d$ and a compact subset
$D_{c} \subset D$ we have

\begin{aligned}
& \sup _{x \in K}\left|\int_{0}^{\infty} \int_{D} \partial_{x_{i}} p^{D}(s, x, y) \nabla \tilde{u}_{0}(y) \cdot \mu(d y) d s-\int_{0}^{\infty} \int_{D} \partial_{x_{i}} p^{n, D}(s, x, y) \nabla \tilde{u}_{0}(y) \cdot G_{n}(y) d y d s\right| \\
\leq & \sup _{x \in K} \int_{T}^{\infty} \int_{D}^{\infty}\left|\nabla \tilde{u}_{0}(y)\right|\left\{\left|\partial_{x_{i}} p^{D}(s, x, y)\right||\mu|(d y)+\left|\partial_{x_{i}} p^{n, D}(s, x, y)\right|\left|G_{n}(y)\right| d y\right\} d s \\
& +\sup _{x \in K} \int_{0}^{\delta} \int_{D}\left|\nabla \tilde{u}_{0}(y)\right|\left\{\left|\partial_{x_{i}} p^{D}(s, x, y)\right||\mu|(d y)+\left|\partial_{x_{i}} p^{n, D}(s, x, y)\right|\left|G_{n}(y)\right| d y\right\} d s \\
& +\sup _{x \in K} \int_{\delta}^{T} \int_{D \backslash D_{c}}\left|\nabla \tilde{u}_{0}(y)\right|\left\{\left|\partial_{x_{i}} p^{D}(s, x, y)\right||\mu|(d y)+\left|\partial_{x_{i}} p^{n, D}(s, x, y)\right|\left|G_{n}(y)\right| d y\right\} d s \\
& +\sup _{x \in K}\left|\int_{\delta}^{T} \int_{D_{c}} \partial_{x_{i}} p^{D}(s, x, y) \nabla \tilde{u}_{0}(y) \cdot \mu(d y) d s-\int_{\delta}^{T} \int_{D_{c}} \partial_{x_{i}} p^{D}(s, x, y) \nabla \tilde{u}_{0}(y) \cdot G_{n}(y) d y d s\right| \\
& +\sup _{x \in K}\left|\int_{\delta}^{T} \int_{D_{c}}\left(\partial_{x_{i}} p^{D}(s, x, y)-\partial_{x_{i}} p^{n, D}(s, x, y)\right) \nabla \tilde{u}_{0}(y) \cdot G_{n}(y) d y d s\right| \\
:= & I_{1}^{n}+I_{2}^{n}+I_{3}^{n}+I_{4}^{n}+I_{5}^{n} .
\end{aligned}
$$

By (3.12) and Fubini's theorem, for any $\varepsilon>0$ there exists a $T>2$ such that

$$
\begin{align*}
\sup _{n \geq 1} I_{1}^{n} & \leq \sup _{y \in D}\left|\nabla \tilde{u}_{0}(y)\right| \int_{T}^{\infty} M_{11} e^{-M_{8}(1) s} d s\left\{|\mu|(D)+\sup _{n \geq 1} \sup _{x \in \mathbb{R}^{d}} \int_{D} \int_{\mathbb{R}^{d}} \psi_{n}(y-x)|\mu|(d x) d y\right\}  \tag{4.16}\\
& =\sup _{y \in D}\left|\nabla \tilde{u}_{0}(y)\right| 2 M_{11} M_{8}(1)^{-1} e^{-M_{8}(1) T}|\mu|(D) \leq \varepsilon .
\end{align*}
$$

In view of (3.7) and (3.13), there exists a $\delta<2$ such that

\begin{align*}
\sup _{n \geq 1} I_{2}^{n} & \leq \sup _{y \in D}\left|\nabla \tilde{u}_{0}(y)\right| \sup _{n \geq 1} \sup _{x \in K} \int_{0}^{\delta} \int_{\mathbb{R}^{d}} M_{12} s^{-\frac{d+1}{2}} e^{-\frac{M_{10}|x-y|^{2}}{2 s}}\left(|\mu|(d y)+\left|G_{n}(y)\right| d y\right) d s  \tag{4.17}\\

& \leq 2^{-n} \sup _{x \in B_{r}}|\nabla v(x)| M_{16} M_{\mu}^{1}(r) .
\end{align*}
$$

Let $n \rightarrow \infty$ in (4.35) to obtain

$$
|\nabla v(x)|=0, \forall x \in B_{r}
$$

Since $v \in C\left(\overline{B_{r}}\right)$ and $v=0$ on $\partial B_{r}$, we conclude that $v=0$ in $B_{r}$, which is the uniqueness of the solution to the problem (4.34).

Now we can state the main result in this section.
Theorem 4.2 Assume $\mu, \rho \in \mathbf{K}_{d, 1-\alpha_{0}}$ and $\varphi \in C^{1, \alpha_{0}}(\partial D)$. Then there exists a unique weak solution $u$ in $C^{1, \alpha_{0}}(D)$ to problem 4.1). Moreover the solution $u$ is given by

$$
u(x)=E_{x}\left[\varphi\left(X_{\tau_{D}}\right)+V_{\tau_{D}}\right] .
$$

Proof: Existence was proved in Theorem 4.1, It remains to prove the uniqueness.
Suppose $u_{1}, u_{2} \in C^{1, \alpha_{0}}(D)$ are two weak solutions to problem (4.1). Let $v=u_{1}-u_{2}$. Take a sequence of balls $\left\{B_{r_{n}}\left(x_{n}\right)\right\}_{n \geq 1}$ that satisfies $\bigcup_{n>1} B_{r_{n}}\left(x_{n}\right)=D, \overline{B_{r_{n}}\left(x_{n}\right)} \subset D$ and $r_{n} \leq r_{0}$ for each $n \geq 1$, where $r_{0}$ is defined in Lemma 3.6.

For any $n \geq 1$, set $B_{n}:=B_{r_{n}}\left(x_{n}\right)$. Note that $v$ satisfies the following equation:

$$
\begin{cases}\frac{1}{2} \Delta v(x)+\nabla v(x) \cdot \mu(d x)=0, & \forall x \in B_{n} \\ \left.v(x)\right|_{\partial B_{n}}=v(x), & \forall x \in \partial B_{n} .\end{cases}
$$

Since $v \in C^{1, \alpha_{0}}\left(\partial B_{n}\right)$, by Lemma 4.5 we have $v(x)=E_{x}\left[v\left(X_{\tau_{B_{n}}}\right)\right]$ for $x \in \bar{B}_{n}$.
Let us now consider $B_{1} \bigcup B_{2}$. Let $x \in B_{1}$ and define a sequence of stoping times $\tau_{k}$ recursively as follows:

$$
\begin{aligned}
& \tau_{0}:=0, \\
& \tau_{2 k-1}:=\inf \left\{t>\tau_{2 k-2}: X_{t} \in B_{1}^{c}\right\}, \\
& \tau_{2 k}:=\inf \left\{t>\tau_{2 k-1}: X_{t} \in B_{2}^{c}\right\} .
\end{aligned}
$$

By the strong Markov property of $X$, we have

$$
E_{x}\left[v\left(X_{\tau_{2}}\right)\right]=E_{x}\left[E_{x}\left[v\left(X_{\tau_{2}}\right) \mid \mathcal{F}_{\tau_{1}}\right]\right]=E_{x}\left[E_{X_{\tau_{1}}}\left(v\left(X_{\tau_{B_{2}}}\right)\right)\right]=E_{x}\left[v\left(X_{\tau_{1}}\right)\right]=v(x) .
$$

Similarly, we get $E_{x}\left[v\left(X_{\tau_{n}}\right)\right]=v(x)$ for $n \geq 1$. On the other hand, since $X_{t}$ is continuous, we can show $\lim _{n \rightarrow \infty} \tau_{n}=\tau_{B_{1} \cup B_{2}}<\infty, P_{x^{-}}$a.e.. Hence, we have $v(x)=\lim _{n \rightarrow \infty} E_{x}\left[v\left(X_{\tau_{n}}\right)\right]=$ $E_{x}\left[v\left(X_{\tau_{B_{1} \cup B_{2}}}\right)\right]$.

Repeating the same procedure, we have $v(x)=E_{x}\left[v\left(X_{\tau_{1 \leq i \leq n} B_{i}}\right)\right]$ for all $n \geq 1$. Since $\lim _{n \rightarrow \infty} \tau_{\cup_{1 \leq i \leq n} B_{i}}=\tau_{D}, P_{x}$-a.e., it follows that

$$
v(x)=\lim _{n \rightarrow \infty} E_{x}\left[v\left(X_{\tau_{\cup_{1 \leq i \leq n} B_{i}}}\right)\right]=E_{x}\left[v\left(X_{\tau_{D}}\right)\right]=0, \forall x \in B_{1} .
$$

The same will be valid for $x \in B_{n}$ for any fixed $n \geq 1$. Hence, $v(x)=0$ for all $x \in D$. The desired uniqueness is proved.

## 5 Case for $\nu \neq 0$

We now consider the following problem:

$$
\begin{cases}\frac{1}{2} \Delta u+\nabla u \cdot \mu+u \nu=-\rho, & \forall x \in D  \tag{5.1}\\ \left.u(x)\right|_{\partial D}=\varphi(x), & \forall x \in \partial D\end{cases}
$$

Let $L_{t}$ denote the CAF associated with $\nu$. Recall that $V_{t}$ is the CAF associated with $\rho$.
Lemma 5.1 Assume that there exists a $x_{0} \in D$ such that

$$
E_{x_{0}}\left[e^{L_{\tau_{D}}}\right]<\infty .
$$

Then we have

$$
\begin{array}{r}
\sup _{x \in D} E_{x}\left[e^{L_{\tau_{D}}}\right]<\infty, \\
\sup _{x \in D} E_{x}\left[\int_{0}^{\tau_{D}} e^{L_{s}} d|V|_{s}\right]<\infty . \tag{5.3}
\end{array}
$$

Proof: For any bounded Borel measurable function $f$ on $D$, define

$$
Q_{t} f(x):=E_{x}\left[e^{L_{t}} f\left(X_{t}\right) ; t<\tau_{D}\right] .
$$

Then $Q_{t}, t>0$, is a semigroup. We first show that $Q_{t}$ is strong Feller, i.e. for any bounded Borel measurable function $f$ on $D$,

$$
\begin{equation*}
Q_{t} f(x) \in C_{b}(D) \tag{5.4}
\end{equation*}
$$

By the Markov property of $X^{D}$, for $0<s<t$,

$$
Q_{t} f(x)=Q_{s}\left(Q_{t-s} f\right)(x)=E_{x}\left[Q_{t-s} f\left(X_{s}^{D}\right)\right]+E_{x}\left[\left(e^{L_{s}}-1\right) Q_{t-s} f\left(X_{s}^{D}\right)\right]
$$

Hence

$$
\begin{equation*}
\left|Q_{t} f(x)-E_{x}\left[Q_{t-s} f\left(X_{s}^{D}\right)\right]\right| \leq\|f\|_{L^{\infty}} E_{x}\left[\left(e^{L_{s}}-1\right)^{2}\right]^{\frac{1}{2}} \operatorname{Sup}_{x \in D} E_{x}\left[e^{\mid L_{t}}\right] . \tag{5.5}
\end{equation*}
$$

By (3.42), we get

$$
\begin{align*}
& \lim _{s \rightarrow 0} \sup _{x \in \mathbb{R}^{d}} E_{x}\left[\left(e^{L_{s}}-1\right)^{2}\right] \\
\leq & \lim _{s \rightarrow 0} \sup _{x \in \mathbb{R}^{d}} E_{x}\left[e^{2|L|_{s}}-1\right]  \tag{5.6}\\
= & \lim _{s \rightarrow 0} \sup _{x \in \mathbb{R}^{d}} E_{x}\left[e^{2|L|_{s}}\right]-1=0 .
\end{align*}
$$

It follows from (3.41), (5.5) and (5.6) that

$$
\begin{equation*}
\lim _{s \rightarrow 0} \sup _{x \in D}\left|Q_{t} f(x)-E_{x}\left[Q_{t-s} f\left(X_{s}^{D}\right)\right]\right|=0 \tag{5.7}
\end{equation*}
$$

On the other hand, since $\left|Q_{t-s} f(x)\right|=\left|E_{x}\left[e^{L_{t-s}} f\left(X_{t-s}\right) ; t-s<\tau_{D}\right]\right| \leq\|f\|_{L^{\infty}} \mid E_{x}\left[e^{L_{t-s}}\right]$ is bounded in $D$ by (3.41), the strong Feller property of $X^{D}$ yields $E_{x}\left[Q_{t-s} f\left(X_{s}^{D}\right)\right] \in C_{b}(D)$. Together with (5.7) we prove (5.4).

Now we prove (5.2). For any open subset $E \subset D$ and $s>0$, by the Markov property of $X_{t}$ we have

$$
\begin{align*}
\sup _{x \in \mathbb{R}^{d}} E_{x}\left[|L|_{\tau E}\right] & \leq \sup _{x \in \mathbb{R}^{d}} \sum_{n \geq 0} E_{x}\left[|L|_{(n+1) s}-|L|_{n s} ; \tau_{E}>n s\right] \\
& \leq \sup _{x \in \mathbb{R}^{d}} \sum_{n \geq 0} E_{x}\left[E_{X_{n s}}\left[|L|_{s}\right] ; \tau_{E}>n s\right]  \tag{5.8}\\
& \leq \sup _{x \in \mathbb{R}^{d}} E_{x}\left[|L|_{s}\right] \sup _{x \in \mathbb{R}^{d}} \sum_{n \geq 0} P_{x}\left[\tau_{E}>n s\right] .
\end{align*}
$$

By (3.39), we have

$$
\begin{equation*}
\lim _{s \rightarrow 0} \sup _{x \in \mathbb{R}^{d}} E_{x}\left[|L|_{s}\right]=\lim _{s \rightarrow 0} \sup _{x \in \mathbb{R}^{d}} \int_{0}^{s} \int_{\mathbb{R}^{d}} p(t, x, y)|\nu|(d y) d t=0 . \tag{5.9}
\end{equation*}
$$

On the other hand, by (3.14), we have

$$
\begin{align*}
& \sup _{x \in \mathbb{R}^{d}} \sum_{n \geq 0} P_{x}\left[\tau_{E}>n s\right] \\
\leq & 1+\sup _{x \in D} \sum_{n \geq 1} P_{x}\left[X_{n s}^{D} \in E\right] \\
\leq & 1+\sup _{x \in D} \sum_{n \geq 1} \int_{E} M_{13}(n s)^{-\frac{d}{2}} e^{-\frac{M_{10}|x-y|^{2}}{2 n s}} d y  \tag{5.10}\\
\leq & 1+M_{13} s^{-\frac{d}{2}} m(E) \sum_{n \geq 1} n^{-\frac{d}{2}} .
\end{align*}
$$

Hence by (5.8)-(5.10), for any $\varepsilon>1$, there exists a $\delta>0$ such that for any open subset $E \subset D$ with $m(E)<\delta$, we have $\sup _{x \in E} E_{x}\left[|L|_{\tau_{E}}\right] \leq 1-\frac{1}{\varepsilon}$. This together with Lemma 3.5 gives

$$
\begin{equation*}
\sup _{x \in E} E_{x}\left[e^{|L|_{\tau_{E}}}\right] \leq \varepsilon \tag{5.11}
\end{equation*}
$$

Using (5.11) and the strong Feller property of $Q_{t}, t>0$, following the same arguments as in the section 5.6 in [7] we obtain (5.2).

Next we show that

$$
\begin{equation*}
\sup _{x \in D} E_{x}\left[\int_{0}^{\tau_{D}} e^{L_{s}} d s\right]<\infty \tag{5.12}
\end{equation*}
$$

By Lemma 3.1 and (3.24), we have

$$
\begin{equation*}
\inf _{x \in \bar{D}} E_{x}\left[e^{L_{\tau_{D}}}\right] \geq \exp \left(-\sup _{x \in D} \int_{0}^{\infty} \int_{D} p^{D}(t, x, y)|\nu|(d y) d t\right) \geq c_{1} \tag{5.13}
\end{equation*}
$$

for some constant $c_{1}>0$. Combining (5.2), (5.13) with Theorem 4.6 in [7] we obtain (5.12).
Finally we prove (5.3). In view of (3.39), we have

$$
\begin{equation*}
\inf _{x \in D} E_{x}\left[e^{\inf _{s \leq 1} L_{s}}\right] \geq \exp \left(-\sup _{x \in D} \int_{0}^{1} \int_{\mathbb{R}^{d}} p(t, x, y)|\nu|(d y) d t\right) \geq c_{2} \tag{5.14}
\end{equation*}
$$

for some constant $c_{2}>0$. By Cauchy-Schwarz inequality and Proposition 3.4,

$$
\begin{align*}
\sup _{x \in \mathbb{R}^{d}} E_{x}\left[\int_{0}^{1} e^{L_{s}} d|V|_{s}\right] & \leq \sup _{x \in \mathbb{R}^{d}} E_{x}\left[e^{|L|_{1}}|V|_{1}\right]  \tag{5.15}\\
& \leq \sup _{x \in \mathbb{R}^{d}}\left(E_{x}\left[e^{2|L|_{1}}\right]\right)^{\frac{1}{2}} \sup _{x \in \mathbb{R}^{d}}\left(E_{x}\left[|V|_{1}^{2}\right]\right)^{\frac{1}{2}} \leq c_{3}<\infty
\end{align*}
$$

for some constant $c_{3}>0$. Using (3.41), (5.2), (5.12), (5.14) and (5.15), we get

$$
\begin{aligned}
\sup _{x \in D} E_{x}\left[\int_{0}^{\tau_{D}} e^{L_{s}} d|V|_{s}\right] & \leq \sup _{x \in D} \sum_{n \geq 0} E_{x}\left[\int_{n}^{n+1} e^{L_{s}} d|V|_{s} ; \tau_{D}>n\right] \\
& =\sup _{x \in D} \sum_{n \geq 0} E_{x}\left[e^{L_{n}} E_{X_{n}}\left[\int_{0}^{1} e^{L_{s}} d|V|_{s}\right] ; \tau_{D}>n\right] \\
& \leq c_{3} \sup _{x \in D} \sum_{n \geq 0} E_{x}\left[e^{L_{n}} ; \tau_{D}>n\right] \\
& \leq c_{2}^{-1} c_{3} \sup _{x \in D} \sum_{n \geq 0} E_{x}\left[e^{L_{n}} E_{X_{n}}\left[e^{\inf _{s \leq 1} L_{s}}\right] ; \tau_{D}>n\right] \\
& =c_{2}^{-1} c_{3} \sup _{x \in D} \sum_{n \geq 0} E_{x}\left[e^{\inf _{s \leq 1} L_{n+s}} ; \tau_{D}>n\right] \\
& \leq c_{2}^{-1} c_{3} \sup _{x \in D} E_{x}\left[\int_{0}^{\tau_{D}+1} e^{L_{s}} d s\right] \\
& \leq c_{2}^{-1} c_{3} \sup _{x \in D}\left(E_{x}\left[\int_{0}^{\tau_{D}} e^{L_{s}} d s\right]+E_{x}\left[e^{L_{\tau_{D}}} E_{X_{\tau_{D}}}\left[\int_{0}^{1} e^{L_{s}} d s\right]\right]\right) \\
& \leq c_{2}^{-1} c_{3}\left\{\sup _{x \in D} E_{x}\left[\int_{0}^{\tau_{D}} e^{L_{s}} d s\right]+\sup _{x \in D} E_{x}\left[e^{L_{\tau_{D}}}\right] \sup _{x \in \mathbb{R}^{d}} E_{x}\left[e^{\mid L_{1}}\right]\right\}<\infty .
\end{aligned}
$$

Remark 5.1 When $\nu, \rho \in \mathbf{K}_{d, 2}$, Lemma 5.1 is still valid.

Recall that $R_{0}$ is the diameter of $D$. Set

$$
\begin{equation*}
u(x):=E_{x}\left[e^{L_{\tau_{D}}} \varphi\left(X_{\tau_{D}}\right)+\int_{0}^{\tau_{D}} e^{L_{s}} d V_{s}\right] \tag{5.16}
\end{equation*}
$$

Now we are ready to state the main result in this paper:
Theorem 5.1 Let $\varphi \in C^{1, \alpha_{0}}(\partial D)$. Assume there exists a $x_{0} \in D$ such that

$$
E_{x_{0}}\left[e^{L_{\tau_{D}}}\right]<\infty .
$$

Then $u$ defined in (5.16) is a weak solution to the Dirichlet boundary value problem (5.1). If for each $1 \leq i \leq d, \mu_{i}, \nu$ and $\rho$ belong to $\mathbf{K}_{d, 1-\alpha}$, then $u$ is the unique weak solution to problem (5.1) in $C^{1, \alpha_{0}}(D)$. Moreover, $u \in C^{1, \alpha_{0}}(\bar{D})$ and there exists a $c>0$, depending on $\mu$ and $\nu$ only via the function $\max _{1 \leq i \leq d} M_{\mu_{i}}^{1-\alpha_{0}}(\cdot)$ and $M_{\nu}^{1-\alpha_{0}}\left(R_{0}\right)$, such that

$$
\begin{equation*}
\|u\|_{C^{1, \alpha_{0}}(\bar{D})} \leq c\left(\|\varphi\|_{C^{1, \alpha_{0}}(\partial D)}+M_{\rho}^{1-\alpha_{0}}\left(R_{0}\right)+\|u\|_{C(\bar{D})}\right) . \tag{5.17}
\end{equation*}
$$

Proof: By theorem 4.1, we know that $u_{1}:=E_{x}\left[\varphi\left(X_{\tau_{D}}\right)+V_{\tau_{D}}\right]$ is a weak solution to the following problem:

$$
\begin{cases}\frac{1}{2} \Delta u_{1}(x)+\nabla u_{1}(x) \cdot \mu(d x)=-\rho(d x), & \forall x \in D,  \tag{5.18}\\ \left.u_{1}(x)\right|_{\partial D}=\varphi(x), & \forall x \in \partial D .\end{cases}
$$

Then $u$ defined in (5.16) is a weak solution to problem (5.1) if and only if $u_{2}:=u-u_{1}$ is a weak solution to the following problem:

$$
\begin{cases}\frac{1}{2} \Delta u_{2}+\nabla u_{2} \cdot \mu=-u \nu, & \forall x \in D  \tag{5.19}\\ \left.u_{2}(x)\right|_{\partial D}=0, & \forall x \in \partial D\end{cases}
$$

Set $\tilde{u}_{2}(x):=E_{x}\left[\int_{0}^{\tau_{D}} u\left(X_{t}\right) d L_{t}\right]$. Then it follows from Proposition 3.3, Theorem 4.1 and Lemma 5.1 that $\tilde{u}_{2}$ is a weak solution to the problem (5.19). To show that $u$ is a weak solution to problem (5.1), it is sufficient to prove $\tilde{u}_{2}=u_{2}$.

By Theorem 5.13 in [11] and the Fubini's theorem,

$$
\begin{aligned}
& \tilde{u}_{2}(x) \\
= & E_{x}\left[\int_{0}^{\tau_{D}} u\left(X_{t}\right) d L_{t}\right] \\
= & E_{x}\left[\int_{0}^{\tau_{D}} E_{X_{t}}\left[e^{L_{\tau_{D}}} \varphi\left(X_{\tau_{D}}\right)+\int_{0}^{\tau_{D}} e^{L_{s}} d V_{s}\right] d L_{t}\right] \\
= & E_{x}\left[\int_{0}^{\tau_{D}} E_{x}\left[e^{L_{\tau_{D}}-L_{t \wedge \tau_{D}}} \varphi\left(X_{\tau_{D}}\right)+\int_{0}^{\tau_{D}-t \wedge \tau_{D}} e^{L_{t \wedge \tau_{D}+s}-L_{t \wedge \tau_{D}}} d V_{t \wedge \tau_{D}+s} \mid \mathcal{F}_{t \wedge \tau_{D}}\right] d L_{t}\right] \\
= & E_{x}\left[\int_{0}^{\tau_{D}}\left(e^{L_{\tau_{D}}-L_{t}} \varphi\left(X_{\tau_{D}}\right)+\int_{0}^{\tau_{D}-t} e^{L_{t+s}-L_{t}} d V_{t+s}\right) d L_{t}\right] \\
= & E_{x}\left[\varphi\left(X_{\tau_{D}}\right)\left(e^{L_{\tau_{D}}}-1\right)\right]+E_{x}\left[\int_{0}^{\tau_{D}} e^{-L_{t}} \int_{t}^{\tau_{D}} e^{L_{s}} d V_{s} d L_{t}\right] \\
= & E_{x}\left[\varphi\left(X_{\tau_{D}}\right)\left(e^{L_{\tau_{D}}}-1\right)\right]+E_{x}\left[\int_{0}^{\tau_{D}} e^{L_{s}} \int_{0}^{s} e^{-L_{t}} d L_{t} d V_{s}\right] \\
= & E_{x}\left[\varphi\left(X_{\tau_{D}}\right)\left(e^{L_{\tau_{D}}}-1\right)\right]+E_{x}\left[\int_{0}^{\tau_{D}}\left(e^{L_{s}}-1\right) d V_{s}\right] \\
= & E_{x}\left[e^{L_{\tau_{D}}} \varphi\left(X_{\tau_{D}}\right)+\int_{0}^{\tau_{D}} e^{L_{t}} d V_{t}\right]-E_{x}\left[\varphi\left(X_{\tau_{D}}\right)+V_{\tau_{D}}\right] \\
= & u(x)-u_{1}(x)=u_{2}(x) .
\end{aligned}
$$

This proves the existence.
Now we assume for each $1 \leq i \leq d, \mu_{i}, \nu, \rho \in \mathbf{K}_{d, 1-\alpha_{0}}$. Then by Lemma 4.3, Lemma 4.4 and the fact that $u_{1}, u_{2}$ are solutions to the problems (5.18) and (5.19), hence $u=u_{1}+u_{2} \in$ $C^{1, \alpha_{0}}(\bar{D})$ and (5.17) holds.

Next we prove the uniqueness. Assume $u_{1}, u_{2} \in C^{1, \alpha_{0}}(D)$ are solutions to problem (5.1). Let $v:=u_{1}-u_{2}$. Then $v$ satisfies the following equation:

$$
\begin{cases}\frac{1}{2} \Delta v+\nabla v \cdot \mu=-v \nu, & \forall x \in D, \\ \left.v(x)\right|_{\partial D}=0, & \forall x \in \partial D .\end{cases}
$$

By Proposition 3.3 and Theorem 4.2, we have $v(x)=E_{x}\left[\int_{0}^{\tau_{D}} v\left(X_{s}\right) d L_{s}\right]$. By the strong Markov property of $X$, it is easy to see that

$$
v\left(X_{t \wedge \tau_{D}}\right)=E_{x}\left[\int_{0}^{\tau_{D}} v\left(X_{s}\right) d L_{s} \mid \mathcal{F}_{t \wedge \tau_{D}}\right]-\int_{0}^{t \wedge \tau_{D}} v\left(X_{s}\right) d L_{s} .
$$

Note that $M_{t}:=E_{x}\left[\int_{0}^{\tau_{D}} v\left(X_{s}\right) d L_{s} \mid \mathcal{F}_{t \wedge \tau_{D}}\right]$ is a martingale. Using the integration by parts formula, we have

$$
\begin{aligned}
v\left(X_{t \wedge \tau_{D}}\right) e^{L_{t \wedge \tau_{D}}}-v(x) & =\int_{0}^{t \wedge \tau_{D}} v\left(X_{s}\right) e^{L_{s}} d L_{s}+\int_{0}^{t \wedge \tau_{D}} e^{L_{s}} d M_{s}-\int_{0}^{t \wedge \tau_{D}} v\left(X_{s}\right) e^{L_{s}} d L_{s} \\
& =\int_{0}^{t \wedge \tau_{D}} e^{L_{s}} d M_{s} .
\end{aligned}
$$



$$
\begin{align*}
|v(x)| & =\left|E_{x}\left[v\left(X_{t \wedge \tau_{D}}\right) e^{L_{t \wedge \tau_{D}}}\right]\right| \\
& \leq E_{x}\left[|v|\left(X_{t \wedge \tau_{D}}\right) e^{L_{t \wedge \tau_{D}}}\right]  \tag{5.20}\\
& \leq c_{1}^{-1} E_{x}\left[|v|\left(X_{t \wedge \tau_{D}}\right) e^{L_{t \wedge \tau_{D}}} E_{X_{t \wedge \tau_{D}}}\left[e^{L_{\tau_{D}}}\right]\right] \\
& \leq c_{1}^{-1} E_{x}\left[|v|\left(X_{t \wedge \tau_{D}}\right) e^{L_{\tau_{D}}}\right] .
\end{align*}
$$

Since $v \in C(\bar{D})$ and $v$ vanishs on $\partial D$, by (5.2) and the dominated convergence theorem, let $t \rightarrow \infty$ in (5.20) to obtain $v(x)=0$, proving the uniqueness.
