On random polynomials generated by a symmetric three-term recurrence relation

Abstract

We investigate the sequence $(P_n(z))_{n=0}^{\infty}$ of random polynomials generated by the threeterm recurrence relation $P_{n+1}(z) = zP_n(z) - a_nP_{n-1}(z)$, $n \geq 1$, with initial conditions $P_{\ell}(z) = z^{\ell}$, $\ell = 0, 1$, assuming that $(a_n)_{n \in \mathbb{Z}}$ is a sequence of positive i.i.d. random variables. $(P_n(z))_{n=0}^{\infty}$ is a sequence of orthogonal polynomials on the real line, and P_n is the characteristic polynomial of a Jacobi matrix J_n . We investigate the relation between the common distribution of the recurrence coefficients a_n and two other distributions obtained as weak limits of the averaged empirical and spectral measures of J_n . Our main result is a description of combinatorial relations between the moments of the aforementioned distributions in terms of certain classes of colored planar trees. Our approach is combinatorial, and the starting point of the analysis is a formula of P. Flajolet for weight polynomials associated with labelled Dyck paths.

Keywords: Random polynomial, orthogonal polynomial, three-term recurrence relation, spectral measure, Dyck path, colored tree.

1 Introduction

Let μ be a Borel probability measure on $(0, +\infty)$, and let $(a_n)_{n \in \mathbb{Z}}$ be a sequence of i.i.d. random variables with distribution μ , taking values in $(0, +\infty)$. We assume that all moments of μ are finite, i.e.,

$$m_k := \int x^k d\mu(x) < \infty, \quad \text{for all } k \in \mathbb{Z}_{\geq 0}.$$
 (1.1)

We emphasize that these hypotheses will be maintained throughout our work.

In this paper we consider the sequence of random polynomials $(P_n)_{n=0}^{\infty}$ generated by the three-term recurrence relation

$$zP_n(z) = P_{n+1}(z) + a_n P_{n-1}(z), \qquad n \ge 1,$$
 (1.2)

with initial conditions

$$P_{\ell}(z) = z^{\ell}, \qquad \ell = 0, 1.$$

Note that $P_n(z)$ is a monic polynomial of degree n, and for each realization of the random variables $(a_n)_{n\in\mathbb{Z}}$, the sequence $(P_n(z))_{n=0}^{\infty}$ is a sequence of orthogonal polynomials on the

real line. The primary goal of this work is to study the relationship between μ and the asymptotic behavior of two discrete random measures associated with P_n that will be defined shortly.

Let H denote the tridiagonal infinite matrix

$$H = \begin{pmatrix} 0 & 1 & & & & \\ a_1 & 0 & 1 & & & \\ & a_2 & 0 & 1 & & \\ & & a_3 & 0 & 1 & \\ & & & \ddots & \ddots & \ddots \end{pmatrix}$$
 (1.3)

and let H_n denote its principal $n \times n$ truncation

$$H_n = \begin{pmatrix} 0 & 1 & & & \\ a_1 & 0 & \ddots & & \\ & \ddots & \ddots & 1 \\ & & a_{n-1} & 0 \end{pmatrix}. \tag{1.4}$$

From the recurrence (1.2) we easily get the relation

$$P_n(z) = \det(zI_n - H_n)$$

with I_n denoting the $n \times n$ identity matrix. Hence the zeros of P_n are the eigenvalues of H_n . As it is well known, these eigenvalues are real and simple and will be indicated as follows:

$$\lambda_1^{(n)} < \lambda_2^{(n)} < \ldots < \lambda_n^{(n)}.$$

In this paper, we will use the notation

$$\sigma_n := \frac{1}{n} \sum_{j=1}^n \delta_{\lambda_j^{(n)}} \tag{1.5}$$

for the empirical measure associated with H_n , where δ_{λ} denotes as usual the Dirac unit measure at λ . Since H_n is diagonalizable, we have the relation

$$\int x^k d\sigma_n(x) = \frac{1}{n} \operatorname{Tr} (H_n^k), \qquad k \in \mathbb{Z}_{\geq 0}.$$
(1.6)

We will also analyze another random measure associated with H_n . This is the measure τ_n defined on $[\lambda_1^{(n)}, \lambda_n^{(n)}]$ with moments given by

$$\int x^k d\tau_n(x) = \langle H_n^k e_1, e_1 \rangle = H_n^k(1, 1), \qquad k \in \mathbb{Z}_{\geq 0}.$$
 (1.7)

Because of the identity

$$H_n^k(1,1) = J_n^k(1,1), \qquad k \in \mathbb{Z}_{\geq 0},$$

where J_n is the finite Jacobi matrix

$$J_n = \begin{pmatrix} 0 & \sqrt{a_1} & & & \\ \sqrt{a_1} & 0 & \ddots & & \\ & \ddots & \ddots & \sqrt{a_{n-1}} \\ & & \sqrt{a_{n-1}} & 0 \end{pmatrix},$$

the measure τ_n is known as the spectral measure of J_n . A basic result in the theory of finite Jacobi matrices, which the reader can easily check, is that τ_n has the expression

$$\tau_n = \sum_{j=1}^n q_{j,n}^2 \, \delta_{\lambda_j^{(n)}}, \qquad q_{j,n} = |v_j^{(n)}(1)|, \tag{1.8}$$

where $\{v_1^{(n)},\ldots,v_n^{(n)}\}$ is any orthonormal basis in \mathbb{R}^n formed by eigenvectors associated with the eigenvalues $\lambda_1^{(n)},\ldots,\lambda_n^{(n)}$, respectively. The first (and last) component of each eigenvector $v_j^{(n)}$ is non-zero, so $q_{j,n}>0$ for all $1\leq j\leq n$, and we have $\sum_{j=1}^n q_{j,n}^2=1$. In the theory of orthogonal polynomials on the real line, the coefficients $q_{j,n}^2$ are known as Christoffel numbers. For a description of their important role in the study of orthogonal polynomials and Padé approximation, see e.g. sections 5 and 6 of Chapter 2 in [7].

In this paper we analyze the relationship between μ and two probability distributions obtained as weak limits of the average measures $\mathbb{E}\sigma_n$ and $\mathbb{E}\tau_n$. Our main result is a combinatorial description of the mutual relations between the moments of these three distributions in terms of certain classes of planar trees.

We wish to mention some closely related works on random Jacobi matrices which partly motivated our work. Popescu [8] studied the asymptotic distribution of eigenvalues of general Jacobi matrices assuming certain growth conditions on the off-diagonal entries, and a boundedness condition on the diagonal entries, see [8, Theorem 1]. Even though the situation he analyzes differs from ours, in view of [8, Remark 2], it seems that after an appropriate normalization he obtains moment sequences that seem to be related as our sequences $(m_k)_{k=0}^{\infty}$ and $(\omega_n)_{n=0}^{\infty}$ defined in (1.1) and (3.2). If this is the case, then our Theorem 4.3 provides the combinatorial interpretation that he posed as an open question in his remark. Duy [4] and Duy-Shirai [5] studied the asymptotic behavior of spectral measures of Jacobi matrices that are obtained as tridiagonal models of Gaussian, Wishart and MANOVA beta ensembles.

This paper is structured as follows. In Section 2 we introduce certain classes of lattice paths and associated weight polynomials. We first express the moments (1.6) and (1.7) in terms of these weight polynomials. Then we turn our attention to the analysis of weight polynomials associated with Dyck paths and generalized Dyck paths, and analyze relations between these polynomials in terms of formal Laurent series. In Section 3 we introduce the two sequences $(\alpha_n)_{n=0}^{\infty}$ and $(\omega_n)_{n=0}^{\infty}$ that form the main object of study of our work. In Proposition 3.1 and Theorem 3.2 we describe some analytic relations between these sequences and the sequence $(m_k)_{k=0}^{\infty}$. In Section 4 we introduce four classes of rooted planar trees, which are used to describe combinatorial relations between the sequences $(m_k)_{k=0}^{\infty}$, $(\alpha_n)_{n=0}^{\infty}$, and $(\omega_n)_{n=0}^{\infty}$, see Theorems 4.1 through 4.4. These combinatorial relations are more direct than those described in Section 3, as they do not involve the intermediate quantities defined in (3.3). Finally, in Section 5 we show that under an additional condition, the averages $\mathbb{E}\tau_n$ and $\mathbb{E}\sigma_n$ converge to symmetric probability measures whose even moments are given by the sequences $(\alpha_n)_{n=0}^{\infty}$ and $(\omega_n)_{n=0}^{\infty}$, respectively.

2 Lattice paths and associated weight polynomials

In this section we introduce certain lattice paths and associated weight polynomials, which constitute the first ingredients in our analysis. This approach is classical for the study of orthogonal polynomials, random polynomials and random matrices. In the area of orthogonal polynomials it goes back at least to the work of Viennot [10], and in random matrices applications of this approach abound.

2.1 Path representation of quantities of interest

We consider the oriented graph $\mathcal{G} = (\mathcal{V}, \mathcal{E})$ with set of vertices $\mathcal{V} := \mathbb{Z}_{\geq 0} \times \mathbb{Z}$ and set of edges $\mathcal{E} := \mathcal{E}_u \cup \mathcal{E}_d$,

where

$$\mathcal{E}_u := \{ (n, m) \to (n+1, m+1) : n \in \mathbb{Z}_{\geq 0}, m \in \mathbb{Z} \}$$
 (the *up steps*),
$$\mathcal{E}_d := \{ (n, m) \to (n+1, m-1) : n \in \mathbb{Z}_{\geq 0}, m \in \mathbb{Z} \}$$
 (the *down steps*).

Here, $v \to v'$ indicates the edge with initial vertex v and ending vertex v'. By a path on \mathcal{G} we mean a finite sequence of edges

$$\gamma = e_1 e_2 \cdots e_k, \tag{2.1}$$

where for each $1 \leq j \leq k-1$, the ending vertex of e_j conicides with the initial vertex of e_{j+1} . We say that the path in (2.1) has length k. If $(n,m) \in \mathcal{V}$ is a vertex in the path γ , we say that γ has height m at time n. We define $\max(\gamma)$ to be the maximum of all the heights of γ , and $\min(\gamma)$ to be the minimum of all the heights of γ . Also, if $q \in \mathbb{Z}$ and γ is a path, we denote by $\gamma + q$ the path obtained by shifting γ vertically |q| units upwards or downwards according to whether q is positive or negative.

Let $(a_n)_{n\in\mathbb{Z}}$ be the sequence of random variables that we considered before. To each edge we associate a weight as follows:

$$w((n,m) \to (n+1,m+1)) = 1, \qquad w((n,m) \to (n+1,m-1)) = a_{m-1}.$$
 (2.2)

Hence, all upstep edges have weight 1 and a downstep edge has a weight that depends on the ordinate of its ending vertex. If γ is now a path on \mathcal{G} , we define its weight by

$$w(\gamma) = \prod_{e \subset \gamma} w(e), \tag{2.3}$$

the product being taken over all edges of γ .

With these notions introduced, we now turn to the analysis of the traces $\operatorname{Tr}(H_n^k)$, where H_n is the $n \times n$ matrix in (1.4). We have

$$\operatorname{Tr}(H_n^k) = \sum_{1 \le i_1, \dots, i_k \le n} h_{i_1, i_2} h_{i_2, i_3} \cdots h_{i_{k-1}, i_k} h_{i_k, i_1}, \tag{2.4}$$

where $h_{i,j}$, $i, j \ge 1$, is the (i, j)-entry of H. For short, we will write

$$h_{\mathbf{i}} := h_{i_1, i_2} h_{i_2, i_3} \cdots h_{i_{k-1}, i_k} h_{i_k, i_1}, \quad \mathbf{i} := (i_1, i_2, \dots, i_k, i_1).$$
 (2.5)

From the form of H_n it follows that the only nonzero terms (2.5) that appear in the trace (2.4) are those associated with vectors \mathbf{i} such that for each j = 1, ..., k, we have $|i_j - i_{j+1}| = 1$ (where $i_{k+1} = i_1$).

With this in mind, we define $\mathcal{A}(n, k, i)$ to be the set of all vectors $\mathbf{i} = (i_1, \dots, i_{k+1}) \in \mathbb{N}^{k+1}$ with the following properties:

- 1) Each component satisfies $1 \le i_j \le n$, and $i_{k+1} = i_1 = i$.
- 2) For each j = 1, ..., k, we have $|i_j i_{j+1}| = 1$.

To each vector $\mathbf{i} \in \mathcal{A}(n,k,i)$ we associate a path $\gamma_{\mathbf{i}} = e_1 e_2 \cdots e_k$ of length k on \mathcal{G} having edges

$$e_j: (j-1, i_j) \to (j, i_{j+1}), \qquad 1 \le j \le k.$$
 (2.6)

Thus, γ_i is a path with starting point $(0, i_1)$ and ending point (k, i_1) . It is clear that the map $\mathbf{i} \mapsto \gamma_i$ is one-to-one, and we will denote by $\mathcal{P}(n, k, i)$ the image under this map of $\mathcal{A}(n, k, i)$. Thus, $\mathcal{P}(n, k, i)$ is the collection of all paths γ on \mathcal{G} satisfying $1 \leq \min(\gamma) \leq \max(\gamma) \leq n$ and having initial point (0, i) and ending point (k, i).

In virtue of (2.4) and (2.5) we have

$$\operatorname{Tr}(H_n^k) = \sum_{i=1}^n \sum_{\mathbf{i} \in \mathcal{A}(n,k,i)} h_{\mathbf{i}} = \sum_{i=1}^n \sum_{\mathbf{i} \in \mathcal{A}(n,k,i)} w(\gamma_{\mathbf{i}})$$

where the second equality follows from the fact that for each $1 \leq j \leq k$, the entry $h_{i_j,i_{j+1}}$ is precisely the weight of the edge e_j in (2.6). In virtue of the bijection between $\mathcal{A}(n,k,i)$ and $\mathcal{P}(n,k,i)$, we can also write

$$\operatorname{Tr}(H_n^k) = \sum_{i=1}^n \sum_{\gamma \in \mathcal{P}(n,k,i)} w(\gamma). \tag{2.7}$$

Similarly, the (1,1)-entry of H_n^k can be expressed in the form

$$H_n^k(1,1) = \sum_{\gamma \in \mathcal{P}(n,k,1)} w(\gamma). \tag{2.8}$$

If $\gamma \in \mathcal{P}(n, k, i)$, since the path starts and ends at the same height, necessarily

$$\operatorname{card} \{ \text{up steps in } \gamma \} = \operatorname{card} \{ \text{down steps in } \gamma \}, \tag{2.9}$$

implying that k is even (k is the total number of edges in γ). In particular, if k is odd, then $\mathcal{P}(n,k,i)=\emptyset$ for all $1\leq i\leq n$, and therefore

$$k \text{ odd} \implies \text{Tr}(H_n^k) = H_n^k(1, 1) = 0.$$
 (2.10)

2.2 Generalized Dyck paths and associated weight polynomials

In the previous subsection we observed that the trace of H_n^k is naturally associated with the collections of paths $\mathcal{P}(n,k,i)$. However, for the asymptotic analysis of these traces, it is convenient to consider a more uniform and less restricted collection of paths that we define next.

For any $n \in \mathbb{Z}_{\geq 0}$, let \mathcal{P}_n denote the collection of all paths on \mathcal{G} of length 2n with starting point (0,0) and ending point (2n,0). We will refer to \mathcal{P}_n as the collection of generalized Dyck paths of length 2n (also known as flawed Dyck paths). Note that there are $\binom{2n}{n}$ different paths in \mathcal{P}_n .

There are two natural involutions $I: \mathcal{P}_n \longrightarrow \mathcal{P}_n$ that can be defined on \mathcal{P}_n , i.e., maps with the property that I^2 is the identity. One is the map $\gamma \mapsto \overline{\gamma}$ defined by taking the symmetric image with respect to the real axis, and the other one is the map $\gamma \mapsto \gamma^*$ defined by taking the symmetric image with respect to the vertical line x = n.

An important subset of \mathcal{P}_n is the collection of *Dyck paths* of length 2n, which we will denote by \mathcal{D}_n . This collection consists of those paths $\gamma \in \mathcal{P}_n$ such that $\min(\gamma) = 0$. It is well known that the cardinality of \mathcal{D}_n is




Figure 1: Example of a Dyck path of length 14 with weight $a_0^3 a_1^3 a_2$.




Figure 2: Example of a generalized Dyck path of length 14 with weight $a_0^2 a_1 b_0^3 b_1$.

$$C_n = \frac{1}{n+1} \binom{2n}{n},$$

the *n*th Catalan number. Observe also that $\mathcal{D}_n = \mathcal{D}_n^*$, i.e., \mathcal{D}_n is invariant under the involution $\gamma \mapsto \gamma^*$. See Figures 1 and 2 for examples of a Dyck path and a generalized Dyck path.

To make our formulas below more symmetric, we will adopt a new notation for the random variables a_n with n < 0, namely we define

$$b_n := a_{-n-1}, \qquad n \in \mathbb{Z}_{\geq 0}. \tag{2.11}$$

We now introduce three sequences of polynomials $(W_n)_{n=0}^{\infty}$, $(A_n)_{n=0}^{\infty}$ and $(B_n)_{n=0}^{\infty}$, defined as the weight polynomials associated with the collections of paths \mathcal{P}_n , \mathcal{D}_n and $\overline{\mathcal{D}}_n$,

respectively, where $\overline{\mathcal{D}}_n$ is the image of \mathcal{D}_n under the map $\gamma \mapsto \overline{\gamma}$. Precisely, for each $n \in \mathbb{Z}_{\geq 0}$,

$$W_n = \sum_{\gamma \in \mathcal{P}_n} w(\gamma), \tag{2.12}$$

$$A_n = \sum_{\gamma \in \mathcal{D}_n} w(\gamma), \tag{2.13}$$

$$W_{n} = \sum_{\gamma \in \mathcal{P}_{n}} w(\gamma), \qquad (2.12)$$

$$A_{n} = \sum_{\gamma \in \overline{\mathcal{D}}_{n}} w(\gamma), \qquad (2.13)$$

$$B_{n} = \sum_{\gamma \in \overline{\mathcal{D}}_{n}} w(\gamma), \qquad (2.14)$$

where by definition $W_0 = A_0 = B_0 = 1$. In general, if $S \subset \mathcal{P}_n$, then we call the expression

$$\sum_{\gamma \in \mathcal{S}} w(\gamma)$$

the weight polynomial associated with S.

Observe that W_n is a polynomial in the 2n variables a_0, \ldots, a_{n-1} and b_0, \ldots, b_{n-1} , while A_n and B_n are polynomials in the *n* variables a_0, \ldots, a_{n-1} and b_0, \ldots, b_{n-1} , respectively. To emphasize this dependence, sometimes we write

$$W_n = W_n(a_0, \dots, a_{n-1}; b_0, \dots, b_{n-1}),$$

 $A_n = A_n(a_0, \dots, a_{n-1}),$
 $B_n = B_n(b_0, \dots, b_{n-1}).$

The explicit expressions of some of these polynomials are given below:

$$A_0 = 1$$

$$A_1 = a_0$$

$$A_2 = a_0(a_0 + a_1)$$

$$A_3 = a_0(a_0^2 + 2a_0a_1 + a_1^2 + a_1a_2)$$

$$W_0 = 1$$

$$W_1 = a_0 + b_0$$

$$W_2 = a_0(a_0 + a_1) + 2a_0b_0 + b_0(b_0 + b_1)$$

$$W_3 = a_0(a_0^2 + 2a_0a_1 + a_1^2 + a_1a_2) + a_0b_0(3a_0 + 3b_0 + 2a_1 + 2b_1) + b_0(b_0^2 + 2b_0b_1 + b_1^2 + b_1b_2).$$

In the following proposition we gather some elementary properties of these weight polynomials:

Proposition 2.1. The following properties hold for every $n \in \mathbb{Z}_{\geq 0}$:

- 1) The polynomials W_n , A_n , B_n are homogeneous polynomials of degree n.
- 2) We have the symmetry property

$$W_n(a_0,\ldots,a_{n-1};b_0,\ldots,b_{n-1})=W_n(b_0,\ldots,b_{n-1};a_0,\ldots,a_{n-1}).$$

3) We have

$$B_n = A_n(b_0, \dots, b_{n-1}).$$

Proof. The weight of any path $\gamma \in \mathcal{P}_n$ is the product of n variables in $\{a_i, b_i\}_{i=0}^{n-1}$ since the path contains exactly n down steps. This proves the first statement.

It is easy to see that for any $\gamma \in \mathcal{P}_n$, $w(\overline{\gamma})$ is obtained from $w(\gamma)$ by replacing any variable a_i by b_i , and any variable b_i by a_i . Therefore

$$W_n(a_0, \dots, a_{n-1}; b_0, \dots, b_{n-1}) = \sum_{\gamma \in \mathcal{P}_n} w(\gamma) = \sum_{\gamma \in \mathcal{P}_n} w(\overline{\gamma}) = W_n(b_0, \dots, b_{n-1}; a_0, \dots, a_{n-1}).$$

The third statement is obvious.

We also need to define the following polynomials obtained from (2.13)–(2.14) by shifting the variables. For each $k \ge 0$, let

$$A_n^{(k)} := A_n(a_k, \dots, a_{k+n-1}) \qquad n \ge 0, \tag{2.15}$$

$$B_n^{(k)} := B_n(b_k, \dots, b_{k+n-1}) \qquad n \ge 0,$$
 (2.16)

in particular $A_n = A_n^{(0)}$, $B_n = B_n^{(0)}$ for all n.

In this paper we will frequently use formal Laurent series in the space $\mathbb{C}((z^{-1}))$, equipped with the usual addition and multiplication of series, which makes this space a field. We define the following series:

$$W(z) := \sum_{n=0}^{\infty} \frac{W_n}{z^{2n+1}},\tag{2.17}$$

$$A^{(k)}(z) := \sum_{n=0}^{\infty} \frac{A_n^{(k)}}{z^{2n+1}}, \qquad k \ge 0,$$
(2.18)

$$B^{(k)}(z) := \sum_{n=0}^{\infty} \frac{B_n^{(k)}}{z^{2n+1}}, \qquad k \ge 0.$$
(2.19)

In the case k = 0, we use the notation

$$A(z) := \sum_{n=0}^{\infty} \frac{A_n}{z^{2n+1}},$$
(2.20)

$$B(z) := \sum_{n=0}^{\infty} \frac{B_n}{z^{2n+1}}.$$
 (2.21)

The decoupling formula that we present in (2.22) is well-known in the theory of deterministic bi-infinite Jacobi matrices and is due to Masson-Repka [6], who gave an analytic proof of it in their paper. We give here a combinatorial proof of this formula based on lattice paths.

Proposition 2.2. The following relation holds:

$$W(z) = \frac{1}{z - a_0 A^{(1)}(z) - b_0 B^{(1)}(z)}. (2.22)$$

We also have that for each $k \geq 0$,

$$A^{(k)}(z) = \frac{1}{z - a_k A^{(k+1)}(z)},$$
(2.23)

$$B^{(k)}(z) = \frac{1}{z - b_k B^{(k+1)}(z)}. (2.24)$$

Proof. First, consider the set $\widehat{\mathcal{P}}_n \subset \mathcal{P}_n$ consisting of all paths γ that do not touch the real line except at times 0 and 2n. The portion of a path $\gamma \in \widehat{\mathcal{P}}_n$ that corresponds to the time interval [1, 2n-1] is either above the line y=1 or below the line y=-1, and therefore it can be identified with the translation of a path in \mathcal{D}_{n-1} or in $\overline{\mathcal{D}}_{n-1}$, respectively. This identification shows that the weight polynomial of $\widehat{\mathcal{P}}_n$ is exactly the polynomial $a_0A_{n-1}^{(1)} + b_0B_{n-1}^{(1)}$.

We can partition the set \mathcal{P}_n into different subsets by looking at the first time that a path returns to zero. For each $k=1,\ldots,n$, we define $\mathcal{S}_k\subset\mathcal{P}_n$ to be the set of all paths that return first to zero at time 2k. Then the sets \mathcal{S}_k indeed form a partition of \mathcal{P}_n , and any path in \mathcal{S}_k is a concatenation of a path in $\widehat{\mathcal{P}}_k$ with a horizontal translation of a path in \mathcal{P}_{n-k} . Hence the weight polynomial of \mathcal{S}_k is $(a_0A_{k-1}^{(1)}+b_0B_{k-1}^{(1)})W_{n-k}$ and adding we obtain the relation

$$W_n = \sum_{k=1}^{n} (a_0 A_{k-1}^{(1)} + b_0 B_{k-1}^{(1)}) W_{n-k}, \qquad n \ge 1.$$

In terms of series this means

$$zW(z) - 1 = (a_0 A^{(1)}(z) + b_0 B^{(1)}(z)) W(z),$$

which gives (2.22).

If we use the same argument above, replacing \mathcal{P}_n by \mathcal{D}_n and $\overline{\mathcal{D}}_n$, we will obtain (2.23)–(2.24) in the case k = 0. Since the polynomials $A^{(k)}$ and $B^{(k)}$ all have the same structure, it is obvious that the same relation will also hold for any $k \geq 1$.

Corollary 2.3. We have the relation

$$W(z) = \frac{1}{A(z)^{-1} + B(z)^{-1} - z}. (2.25)$$

For any $k \geq 1$, we have

$$A(z) = \frac{1}{z - \frac{a_0}{z - \frac{a_1}{z - \dots - \frac{a_{k-1}}{z - a_k A^{(k+1)}(z)}}},$$
(2.26)

and a similar identity holds between the B polynomials.

Proof. The relations follow immediately from (2.22)–(2.24).

In view of (2.25) and (2.26), the series A(z) and W(z) are naturally connected to certain random continued fractions:

$$A(z) \to \cfrac{1}{z - \cfrac{a_0}{z - \cfrac{a_1}{z - \cfrac{a_2}{\cdots}}}}$$

$$W(z) \to \cfrac{1}{z - \cfrac{a_0}{z - \cfrac{a_1}{z - \cfrac{a_2}{z - \cfrac{b_1}{z - \cfrac{b_2}{\cdots}}}}}.$$

2.3 Explicit formulae for the weight polynomials

In this subsection we give some explicit formulae for the weight polynomials defined in (2.12)–(2.14). We first introduce some definitions and notations.

Given an integer n > 1, let

$$C(n) := \{ (n_0, \dots, n_r) : n_0 + \dots + n_r = n, n_j \in \mathbb{N} \text{ for all } 0 \le j \le r \}$$
 (2.27)

denote the set of all integer compositions of n. For example,

$$C(4) = \{(4), (3, 1), (1, 3), (2, 2), (2, 1, 1), (1, 2, 1), (1, 1, 2), (1, 1, 1, 1)\}.$$

It is also convenient to define the set

$$C(0) := \{e\} \tag{2.28}$$

whose only element is the empty sequence e.

The following formulas for the polynomials A_n and B_n are due to Flajolet [3, Prop. 3B]: For any $n \in \mathbb{Z}_{>0}$,

$$A_{n} = \sum_{(n_{0},\dots,n_{r})\in\mathcal{C}(n)} \binom{n_{0}+n_{1}-1}{n_{0}-1} \binom{n_{1}+n_{2}-1}{n_{1}-1} \cdots \binom{n_{r-1}+n_{r}-1}{n_{r-1}-1} a_{0}^{n_{0}} a_{1}^{n_{1}} \cdots a_{r}^{n_{r}},$$

$$(2.29)$$

$$B_{n} = \sum_{(n_{0},\dots,n_{r})\in\mathcal{C}(n)} \binom{n_{0}+n_{1}-1}{n_{0}-1} \binom{n_{1}+n_{2}-1}{n_{1}-1} \cdots \binom{n_{r-1}+n_{r}-1}{n_{r-1}-1} b_{0}^{n_{0}} b_{1}^{n_{1}} \cdots b_{r}^{n_{r}}.$$

$$(2.30)$$

In the case n=0, we understand the right-hand sides of (2.29)–(2.30) to be 1, and if $n \ge 1$, r=0, the product of the binomials to be 1 as well. In [3], Flajolet gives the polynomials A_n the name Stieltjes-Rogers polynomials.

In order to make our formulas below more compact and manageable, we introduce some more definitions and notations. Given $n \in \mathbb{Z}_{\geq 0}$ and a composition $\overline{n} \in \mathcal{C}(n)$, we define

$$\rho_1(\overline{n}) := \begin{cases} \prod_{j=0}^{r-1} {n_j + n_{j+1} - 1 \choose n_j - 1} & \text{if } \overline{n} = (n_0, \dots, n_r), \ r \ge 1, \\ 1 & \text{if } \overline{n} = (n), \ n \ge 1, \text{ or } \overline{n} = e, \end{cases}$$
(2.31)

where e is the element in (2.28). We also define

$$a(\overline{n}) := \begin{cases} \prod_{j=0}^{r} a_j^{n_j} & \text{if } \overline{n} = (n_0, \dots, n_r), \ r \ge 0, \\ 1 & \text{if } \overline{n} = e, \end{cases}$$
 (2.32)

and similarly

$$b(\overline{n}) := \begin{cases} \prod_{j=0}^{r} b_j^{n_j} & \text{if } \overline{n} = (n_0, \dots, n_r), \ r \ge 0, \\ 1 & \text{if } \overline{n} = e. \end{cases}$$
 (2.33)

With these definitions, (2.29)–(2.30) take the form

$$A_n = \sum_{\overline{n} \in C(n)} \rho_1(\overline{n}) a(\overline{n}), \qquad (2.34)$$

$$A_{n} = \sum_{\overline{n} \in C(n)} \rho_{1}(\overline{n}) a(\overline{n}), \qquad (2.34)$$

$$B_{n} = \sum_{\overline{n} \in C(n)} \rho_{1}(\overline{n}) b(\overline{n}). \qquad (2.35)$$

Our main goal in this subsection is to prove a formula for the polynomials W_n that is analogous to (2.34)–(2.34). To accomplish this we need some more definitions.

Given $n \in \mathbb{Z}_{>0}$, let

$$\widehat{\mathcal{C}}(n) := \bigcup_{j=0}^{n} \mathcal{C}(j) \times \mathcal{C}(n-j), \tag{2.36}$$

i.e., $\widehat{\mathbf{C}}(n)$ consists of all pairs $(\overline{p}, \overline{q})$ with $\overline{p} \in \mathbf{C}(j)$ and $\overline{q} \in \mathbf{C}(n-j)$ for some $0 \leq j \leq n$. Additionally, for a given $(\overline{p}, \overline{q}) \in \widehat{C}(n)$ we define

$$\rho_{2}((\overline{p},\overline{q})) := \begin{cases}
\binom{n_{0}+n'_{0}}{n_{0}} \rho_{1}(\overline{p}) \rho_{1}(\overline{q}) & \text{if } \overline{p} = (n_{0},\ldots,n_{r}), \ r \geq 0, \ \overline{q} = (n'_{0},\ldots,n'_{s}), \ s \geq 0, \\
\rho_{1}(\overline{p}) & \text{if } \overline{q} = e, \\
\rho_{1}(\overline{q}) & \text{if } \overline{p} = e.
\end{cases}$$
(2.37)

Using (2.36)–(2.37), we give in (2.46) below a formula for W_n .

In the sequel, we use the notation

$$X(z) := A^{(1)}(z), \qquad Y(z) := B^{(1)}(z),$$

see (2.18)-(2.19). Then, in virtue of (2.22)-(2.24), we have

$$W(z) = \frac{1}{z - (a_0 X(z) + b_0 Y(z))},$$
(2.38)

$$A(z) = \frac{1}{z - a_0 X(z)},$$
(2.39)

$$B(z) = \frac{1}{z - b_0 Y(z)}. (2.40)$$

Finally, given a formal Laurent series $S(z) \in \mathbb{C}((z^{-1}))$, the notation $[S]_n$ will indicate the coefficient of z^{-n} in the expression of S(z). If S(z) is not the zero series, we define

$$\deg(S) := \max\{n \in \mathbb{Z} : [S]_{-n} \neq 0\}. \tag{2.41}$$

Note that this agrees with the definition of degree of a polynomial in z.

Proposition 2.4. For any $n \geq 0$,

$$A_n = \sum_{k=0}^n a_0^k [X^k]_{2n-k},$$

$$B_n = \sum_{k=0}^n b_0^k [Y^k]_{2n-k}.$$
(2.42)

Moreover, for every k = 0, ..., n,

$$[X^k]_{2n-k} = \sum_{(n_1,\dots,n_r)\in\mathcal{C}(n-k)} \binom{k+n_1-1}{k-1} \binom{n_1+n_2-1}{n_1-1} \cdots \binom{n_{r-1}+n_r-1}{n_{r-1}-1} a_1^{n_1} \cdots a_r^{n_r},$$
(2.43)

$$[Y^k]_{2n-k} = \sum_{(n_1,\dots,n_r)\in\mathcal{C}(n-k)} \binom{k+n_1-1}{k-1} \binom{n_1+n_2-1}{n_1-1} \cdots \binom{n_{r-1}+n_r-1}{n_{r-1}-1} b_1^{n_1} \cdots b_r^{n_r},$$
(2.44)

where C(n-k) is defined in (2.27)–(2.28). The right-hand side in (2.43)–(2.44) is understood to be 1 in the case n = k. For each k = 0, ..., n, the expression $a_0^k[X^k]_{2n-k}$ is the weight polynomial associated with the set of all Dyck paths of length 2n with exactly k returns to zero.

Proof. The two formulas in (2.42) follow immediately from Lemma 6.1 and the two relations (2.39)-(2.40).

To justify (2.43), observe that the first relation in (2.42) gives a decomposition of A_n into n+1 different groups of terms, where the group $a_0^k[X^k]_{2n-k}$ gathers all terms in the expression of A_n whose a_0 factor is exactly a_0^k . Therefore, the expression for $a_0^k[X^k]_{2n-k}$ is obtained by taking $n_0 = k$ in (2.29). This gives immediately (2.43) after dividing by a_0^k . The proof for (2.44) is obviously the same. The last statement in the Lemma also follows immediately.

In the proof of (2.46) below, we will apply (2.43)–(2.44) in the case when k=0, n>0. In this case, we obviously have $[X^k]_{2n-k}=[Y^k]_{2n-k}=0$, which we get through the formulas (2.43)–(2.44) if we adopt, as in [3], the convention

$$\begin{pmatrix} n \\ -1 \end{pmatrix} = \delta_{n,-1} \tag{2.45}$$

where δ is Kronecker's symbol. Indeed, if k=0, n>0, with this convention we get $\binom{k+n_1-1}{k-1}=\binom{n_1-1}{-1}=0$ since $n_1\geq 1$.

Theorem 2.5. The following formula holds for every $n \ge 0$:

$$W_n = \sum_{(\overline{p}, \overline{q}) \in \widehat{C}(n)} \rho_2((\overline{p}, \overline{q})) a(\overline{p}) b(\overline{q}), \qquad (2.46)$$

see (2.36)–(2.37) and (2.32)–(2.33) for the meaning of notation.

Proof. First, from (2.38) and Lemma 6.1, we obtain that for every $n \ge 0$,

$$W_n = \sum_{m=0}^{n} [(a_0 X + b_0 Y)^m]_{2n-m} = \sum_{m=0}^{n} \sum_{k=0}^{m} {m \choose k} a_0^k b_0^{m-k} [X^k Y^{m-k}]_{2n-m}.$$
 (2.47)

In order to make the formula symmetric, we rewrite the above expression in the form

$$W_n = \sum_{m=0}^n \sum_{n_0 + n_0' = m} \binom{n_0 + n_0'}{n_0} a_0^{n_0} b_0^{n_0'} [X^{n_0} Y^{n_0'}]_{2n-m}, \tag{2.48}$$

where the second summation is taken over the set

$$\{(n_0, n'_0) \in \mathbb{Z}^2_{\geq 0} : n_0 + n'_0 = m\}.$$

Now we identify the coefficient $[X^{n_0}Y^{n'_0}]_{2n-m}$ in the series expansion of $X^{n_0}Y^{n'_0}$. Writing

$$X^{n_0}(z)\,Y^{n_0'}(z) = \sum_{i=0}^\infty \frac{[X^{n_0}]_{n_0+2i}}{z^{n_0+2i}}\,\sum_{j=0}^\infty \frac{[Y^{n_0'}]_{n_0'+2j}}{z^{n_0'+2j}},$$

we deduce that

$$[X^{n_0} Y^{n'_0}]_{2n-m} = \sum_{j=0}^{n-m} [X^{n_0}]_{n_0+2j} [Y^{n'_0}]_{2n-m-2j-n_0}.$$
(2.49)

Applying (2.43)–(2.44),

$$[X^{n_0}]_{n_0+2j} = \sum_{(n_1,\dots,n_r)\in\mathcal{C}(j)} \binom{n_0+n_1-1}{n_0-1} \cdots \binom{n_{r-1}+n_r-1}{n_{r-1}-1} a_1^{n_1} \cdots a_r^{n_r}, \quad (2.50)$$

$$[Y^{n'_0}]_{2n-m-2j-n_0} = \sum_{(n'_1,\dots,n'_s)\in\mathcal{C}(n-m-j)} \binom{n'_0+n'_1-1}{n'_0-1} \cdots \binom{n'_{s-1}+n'_s-1}{n'_{s-1}-1} b_1^{n'_1} \cdots b_s^{n'_s}. \quad (2.51)$$

Combining (2.48)–(2.51) we obtain

$$W_{n} = \sum_{m=0}^{n} \sum_{n_{0}+n'_{0}=m} \sum_{j=0}^{n-m} \sum_{\substack{(n_{1},\dots,n_{r}) \in \mathcal{C}(j) \\ (n'_{1},\dots,n'_{s}) \in \mathcal{C}(n-m-j)}} \pi(n_{0},\dots,n_{r};n'_{0},\dots,n'_{s}) a_{0}^{n_{0}} \cdots a_{r}^{n_{r}} b_{0}^{n'_{0}} \cdots b_{s}^{n'_{s}}$$

$$(2.52)$$

where

$$\pi(n_0, \dots, n_r; n'_0, \dots, n'_s) = \binom{n_0 + n'_0}{n_0} \times \prod_{k=0}^{r-1} \binom{n_k + n_{k+1} - 1}{n_k - 1} \times \prod_{k=0}^{s-1} \binom{n'_k + n'_{k+1} - 1}{n'_k - 1}.$$
(2.53)

The expression in (2.52) reduces to the expression in (2.46). Indeed, observe first that some terms in (2.52) give a null contribution. These are the terms obtained by taking $n_0 = 0$ and j > 0, or taking $n'_0 = 0$ and j < n - m. In both cases the expression (2.53) is zero as a consequence of (2.45). In the remaining cases, if we construct the vectors $\overline{p} = (n_0, \ldots, n_r)$ and $\overline{q} = (n'_0, \ldots, n'_s)$, then clearly $(\overline{p}, \overline{q}) \in \widehat{C}(n)$ (if one of the vectors is the zero vector, we identify it with the element e in C(0)) and we have

$$\pi(n_0,\ldots,n_r;n_0',\ldots,n_s')\,a_0^{n_0}\cdots a_r^{n_r}\,b_0^{n_0'}\cdots b_s^{n_s'}=\rho_2((\overline{p},\overline{q}))\,a(\overline{p})\,b(\overline{q}).$$

It is also clear that there is a one-to-one correspondance between the terms in (2.52) that give a non-zero contribution and the set of all pairs $(\overline{p}, \overline{q}) \in \widehat{C}(n)$. With this we conclude the proof.

Below we present alternative formulae for the polynomials A_n and W_n . These formulae are, however, not convenient for our purposes, and they will not be used in the rest of the paper, but we include them for their independent interest. Formula (2.54) for A_n appears in Touchard [9]. It is also a particular case of what Aptekarev-Kaliaguine-Van Iseghem [1, sections 1 and 3] call *genetic sums*. For the sake of completeness, we give an independent proof of (2.54). Note also that, in contrast to (2.46), the formula given below for W_n is asymmetric, in the sense that we write W_n as a polynomial in the variables $\{a_j\}_{j=-n}^{n-1}$, instead of the variables $\{a_j,b_j\}_{j=0}^{n-1}$.

Proposition 2.6. The following formulas hold for every $n \geq 0$,

$$A_n = \sum_{i_1=0}^{0} \sum_{i_2=0}^{i_1+1} \sum_{i_3=0}^{i_2+1} \cdots \sum_{i_n=0}^{i_{n-1}+1} \prod_{j=1}^{n} a_{i_j},$$
 (2.54)

$$W_n = \sum_{i_1=-1}^{n-1} \sum_{i_2=i_1-1}^{n-2} \sum_{i_3=i_2-1}^{n-3} \cdots \sum_{i_n=i_{n-1}-1}^{0} \prod_{j=1}^{n} a_{i_j}.$$
 (2.55)

Proof. Given a general path $\gamma \in \mathcal{P}_n$, we denote by d_j , $j = 1, \ldots, n$, the jth down step edge of γ , counting from left to right.

We first prove (2.55). For each j = 1, ..., n, let a_{i_j} be the weight of the edge d_j in the general path γ , i.e., $a_{i_j} = w(d_j)$, cf. (2.2). We first look at the possible values for $a_{i_1} = w(d_1)$. These values are clearly those with index in the range $-1 \le i_1 \le n-1$, and observe that the number of up step edges that precede d_1 is $i_1 + 1$. Indeed, $i_1 = -1$ if d_1 is the first edge in γ , $i_1 = 0$ if d_1 is the second edge in γ , and so on, up to the value $i_1 = n - 1$ in case that the first n edges in γ are all up step edges. For a fixed value of i_1 , the number of remaining up step edges that follow d_1 is $n-i_1-1$. Hence the possible values for $a_{i_2} = w(d_2)$ are those with index in the range $i_1 - 1 \le i_2 \le n - 2$, where the upper bound is obtained by adding $n - i_1 - 1$, the number of remaining up step edges, to $i_1 - 1$. For a fixed value of i_2 in that range, the total number of up step edges that precede d_2 is $(i_1+1)+(i_2-i_1+1)=i_2+2$, so the total number of up step edges that follow d_2 is $n-i_2-2$. In general, given $2 \le j \le n$, suppose that one of the possible values for i_{j-1} is fixed, and the number of up step edges that follow d_{j-1} is $n-i_{j-1}-j+1$. Then clearly the possible values for i_j are in the range $i_{j-1}-1 \le i_j \le n-j$, and the number of up step edges that follow d_j is $n - i_j - j$. This shows that the collection of all possible values for $w(\gamma), \gamma \in \mathcal{P}_n$, is exactly given by (2.55).

The proof of (2.54) follows the same reasoning, with the difference that the analysis is done backwards instead of forward. Now we let $a_{ij} := w(d_{n-j+1})$, $1 \le j \le m$, so a_{i1} is the weight of the last down step d_n , a_{i2} is the weight of d_{n-1} , and so on. If $\gamma \in \mathcal{D}_n$ is a Dyck path, then necessarily its last edge is the down step edge d_n that joins the points (2n-1,1) and (2n,0), hence $a_{i1} = a_0$. The possible values for a_{i2} are a_0 (if there is exactly one up step edge between d_{n-1} and d_n) and a_1 (if there is no up step edge between d_{n-1} and d_n), i.e., $0 \le i_2 \le 1$. So the number of up step edges between d_{n-1} and d_n is $1-i_2$. For a fixed value of i_2 , the possible values for i_3 are in the range $0 \le i_3 \le i_2 + 1$, since between d_{n-2} and d_{n-1} one can have at most $i_2 + 1$ up step edges. For a fixed value of i_3 , the number of up step edges between d_{n-2} and d_{n-1} is $i_2 - i_3 + 1$, so the total number of up step edges that precede d_{n-2} is $n - (i_2 - i_3 + 1) - (1 - i_2) = n + i_3 - 2$. In general, by induction one can show that for each $2 \le j \le n$, the possible values for i_j are $0 \le i_j \le i_{j-1} + 1$ and the total number of up step edges that precede d_{n-j+1} is $n+i_j-j+1$. In the final case j=n, this shows that the number of up steps that precede d_1 is precisely i_n+1 . This concludes the proof of (2.54).

3 The sequences $(\alpha_n)_{n=0}^{\infty}$, $(\omega_n)_{n=0}^{\infty}$, and associated formal series

In this section we describe some properties of the two sequences $(\alpha_n)_{n=0}^{\infty}$ and $(\omega_n)_{n=0}^{\infty}$ defined by

$$\alpha_n := \mathbb{E}(A_n), \qquad n \ge 0, \tag{3.1}$$

$$\omega_n := \mathbb{E}(W_n), \qquad n \ge 0. \tag{3.2}$$

Note that in virtue of (1.1) and the definition of the polynomials A_n and W_n , the values α_n and ω_n are finite for all n. The first few values are

$$\begin{split} &\alpha_0 = 1 \\ &\alpha_1 = m_1 \\ &\alpha_2 = m_2 + m_1^2 \\ &\alpha_3 = m_3 + 3m_2m_1 + m_1^3 \\ &\alpha_4 = m_4 + 4m_3m_1 + 3m_2^2 + 5m_2m_1^2 + m_1^4 \\ &\alpha_5 = m_5 + 5m_4m_1 + 10m_3m_2 + 7m_3m_1^2 + 11m_2^2m_1 + 7m_2m_1^3 + m_1^5 \\ &\omega_0 = 1 \\ &\omega_1 = 2m_1 \\ &\omega_2 = 2m_2 + 4m_1^2 \\ &\omega_3 = 2m_3 + 12m_2m_1 + 6m_1^3 \\ &\omega_4 = 2m_4 + 16m_3m_1 + 12m_2^2 + 32m_2m_1^2 + 8m_1^4 \\ &\omega_5 = 2m_5 + 20m_4m_1 + 40m_3m_2 + 50m_3m_1^2 + 70m_2^2m_1 + 60m_2m_1^3 + 10m_2^5. \end{split}$$

In this section we also define the quantities

$$\alpha_n^{(k)} := \mathbb{E}([A^k]_{k+2n}), \qquad k, n \in \mathbb{Z}_{\geq 0},$$
(3.3)

where A is the series in (2.20). These values are all finite. Observe that $\alpha_0^{(k)} = 1$ for all $k \ge 0$ and $\alpha_n^{(0)} = 0$ for all n > 0. Also note that $\alpha_n^{(1)} = \alpha_n$ for all $n \ge 0$.

We also introduce the following formal Laurent series:

$$g_k(z) := \sum_{n=0}^{\infty} \frac{\alpha_n^{(k)}}{z^{2n+k}}, \qquad k \ge 0,$$
 (3.4)

$$f(z) := \sum_{n=0}^{\infty} \frac{\omega_n}{z^{2n+1}},\tag{3.5}$$

and note that $g_0 \equiv 1$. Finally, in analogy to (2.32)–(2.33) we define, for each $\overline{n} \in C(n)$, $n \geq 0$, the function

$$m(\overline{n}) := \begin{cases} \prod_{j=0}^{r} m_{n_j} & \text{if } \overline{n} = (n_0, \dots, n_r), \ r \ge 0, \\ 1 & \text{if } \overline{n} = e. \end{cases}$$
(3.6)

Proposition 3.1. The following identities hold. For every $n \in \mathbb{Z}_{\geq 0}$,

$$\alpha_n = \sum_{\overline{n} \in C(n)} \rho_1(\overline{n}) \, m(\overline{n}), \tag{3.7}$$

$$\omega_n = \sum_{(\overline{p}, \overline{q}) \in \widehat{C}(n)} \rho_2(\overline{p}, \overline{q}) \, m(\overline{p}) \, m(\overline{q}). \tag{3.8}$$

For all $k, n \in \mathbb{Z}_{\geq 0}$,

$$\alpha_n^{(k)} = \sum_{\overline{n} \in C(n)} \left(\overline{n}(1) + k - 1 \atop k - 1 \right) \rho_1(\overline{n}) m(\overline{n}), \tag{3.9}$$

where $\overline{n}(1)$ denotes the first entry of \overline{n} .

Proof. The formulas are obtained immediately by taking the expected value in (2.29), (2.46) and (2.43), and using the fact that the random variables $\{a_n, b_n\}_{n=0}^{\infty}$ are i.i.d. with moments (1.1). Also note that $\mathbb{E}([X^k]_{k+2n}) = \mathbb{E}([A^k]_{k+2n})$ for all $k, n \geq 0$.

Before we state our next result, we make a clarification regarding the expressions on the right-hand sides of (3.13)–(3.15). In general, the addition of infinitely many series in the space $\mathbb{C}((z^{-1}))$ is not well-defined. However, if we have a sequence $(\xi_n(z))_{n=0}^{\infty}$ of series such that $\deg(\xi_n) \longrightarrow -\infty$ as $n \to \infty$ (cf. (2.41)), then the expression $\xi(z) = \sum_{n=0}^{\infty} \xi_n(z)$ is well-defined as the series whose coefficients are $[\xi]_j = \sum_{n=0}^{\infty} [\xi_n]_j$, $j \in \mathbb{Z}$, since the latter summation is in fact finite for every j. This is the case of the expressions on the right-hand sides of (3.13)–(3.15).

Theorem 3.2. The following relations hold. For any $n \geq 0$,

$$\alpha_n^{(k)} = \sum_{j=0}^n {j+k-1 \choose k-1} m_j \, \alpha_{n-j}^{(j)}, \qquad k \ge 0, \tag{3.10}$$

$$\omega_n = \sum_{j=0}^n \sum_{\ell=0}^{n-j} m_j \, \alpha_\ell^{(j)} \, \alpha_{n-j-\ell}^{(j+1)}, \tag{3.11}$$

$$\omega_n = \sum_{j=0}^n \sum_{i=0}^j \sum_{\ell=0}^{n-j} \binom{j}{i} m_i m_{j-i} \alpha_\ell^{(i)} \alpha_{n-j-\ell}^{(j-i)}.$$
 (3.12)

We also have the following relations.

$$g_k(z) = \sum_{j=0}^{\infty} {j+k-1 \choose k-1} \frac{m_j g_j(z)}{z^{j+k}}, \qquad k \ge 0,$$
 (3.13)

$$f(z) = \sum_{j=0}^{\infty} m_j g_j(z) g_{j+1}(z), \qquad (3.14)$$

$$f(z) = \sum_{j=0}^{\infty} \sum_{i=0}^{j} {j \choose i} \frac{m_i \, m_{j-i} \, g_i(z) \, g_{j-i}(z)}{z^{j+1}}.$$
 (3.15)

Proof. From the relations (2.39) and (6.5), where in the latter we take R = A and $S = a_0 X$, we obtain

$$[A^k]_{k+2n} = \sum_{j=0}^n \binom{j+k-1}{k-1} a_0^j [X^j]_{2n-j}.$$

Taking expectation, and using the facts that the random variables a_0 and $[X^j]_\ell$ are independent and $\mathbb{E}([X^k]_{k+2m}) = \mathbb{E}([A^k]_{k+2m})$, we obtain (3.10). The identity (3.12) is obtained by taking expectation in (2.47) and in (2.49), and taking into account that the random variables a_0 , b_0 , $[X^j]_\ell$ and $[Y^r]_s$ are independent. To justify (3.11), we write

$$\omega_{n} = \sum_{j=0}^{n} \sum_{i=0}^{j} \sum_{\ell=0}^{n-j} \binom{j}{i} m_{i} m_{j-i} \alpha_{\ell}^{(i)} \alpha_{n-j-\ell}^{(j-i)}$$

$$= \sum_{i=0}^{n} \sum_{\ell=0}^{n-i} \sum_{j=i}^{n-\ell} \binom{j}{i} m_{i} m_{j-i} \alpha_{\ell}^{(i)} \alpha_{n-j-\ell}^{(j-i)}$$

$$= \sum_{i=0}^{n} \sum_{\ell=0}^{n-i} m_{i} \alpha_{\ell}^{(i)} \left(\sum_{j=i}^{n-\ell} \binom{j}{i} m_{j-i} \alpha_{n-j-\ell}^{(j-i)} \right)$$

and in virtue of (3.10), the expression inside the parenthesis is exactly $\alpha_{n-i-\ell}^{(i+1)}$

The identities (3.13)–(3.15) follow immediately from (3.10)–(3.12) and (3.4)–(3.5). In the case of (3.13), if we call $h_k(z)$ the right-hand side of (3.13), then it is clear that $\deg(h_k) = -k$, and for every $n \ge 0$,

$$[h_k]_{k+2n} = \sum_{j=0}^{\infty} {j+k-1 \choose k-1} m_j \left[\frac{g_j(z)}{z^{j+k}} \right]_{k+2n},$$

where, in view of (3.4),

$$\left[\frac{g_j(z)}{z^{j+k}}\right]_{k+2n} = \left[\sum_{\ell=0}^{\infty} \frac{\alpha_{\ell}^{(j)}}{z^{2(j+\ell)+k}}\right]_{k+2n} = \begin{cases} \alpha_{n-j}^{(j)}, & \text{if } j \le n, \\ 0, & \text{if } j > n. \end{cases}$$

Hence

$$[h_k]_{k+2n} = \sum_{j=0}^{n} {j+k-1 \choose k-1} m_j \, \alpha_{n-j}^{(j)}.$$

On the other hand, for every $n \geq 0$,

$$\left[\frac{g_j(z)}{z^{j+k}}\right]_{k+2n+1} = 0,$$

so $[h_k]_{k+2n+1} = 0$. Consequently, in virtue of (3.4) and (3.10) we obtain the desired identity $h_k = g_k$.

The proofs of (3.14) and (3.15) are done similarly, using (3.11) and (3.12). We leave them to the reader.

4 Trees and relations

In this section we describe combinatorial relations between the three sequences $(m_n)_{n=0}^{\infty}$, $(\alpha_n)_{n=0}^{\infty}$, and $(\omega_n)_{n=0}^{\infty}$, complementing the formulas (3.7) and (3.8).

We first describe how the quantities m_n and ω_n can be expressed in terms of the quantities α_k , $k = 0, \ldots, n$. The first few relations of this type are

$$\begin{split} m_0 &= \alpha_0 \\ m_1 &= \alpha_1 \\ m_2 &= \alpha_2 - \alpha_1^2 \\ m_3 &= \alpha_3 - 3\alpha_2\alpha_1 + 2\alpha_1^3 \\ m_4 &= \alpha_4 - 4\alpha_3\alpha_1 + 13\alpha_2\alpha_1^2 - 3\alpha_2^2 - 7\alpha_1^4 \\ m_5 &= \alpha_5 - 5\alpha_4\alpha_1 - 10\alpha_3\alpha_2 + 23\alpha_3\alpha_1^2 + 34\alpha_2^2\alpha_1 - 79\alpha_2\alpha_1^3 + 36\alpha_1^5 \\ \omega_0 &= \alpha_0 \\ \omega_1 &= 2\alpha_1 \\ \omega_2 &= 2\alpha_2 + 2\alpha_1^2 \\ \omega_3 &= 2\alpha_3 + 6\alpha_2\alpha_1 - 2\alpha_1^3 \\ \omega_4 &= 2\alpha_4 + 8\alpha_3\alpha_1 - 14\alpha_2\alpha_1^2 + 6\alpha_2^2 + 6\alpha_1^4 \\ \omega_5 &= 2\alpha_5 + 10\alpha_4\alpha_1 + 20\alpha_3\alpha_2 - 24\alpha_3\alpha_1^2 - 42\alpha_2^2\alpha_1 + 72\alpha_2\alpha_1^3 - 28\alpha_1^5 \end{split}$$

Our formulas will use certain classes of planar trees. The first one of these classes is described next. Let $n \geq 1$ be an integer and let $\overline{n} = (n_0, n_1, \dots, n_r) \in C(n)$ be fixed. We consider rooted leveled trees associated with \overline{n} , defined by the following conditions:

- T1) Each vertex of the tree is represented by a positive integer, called the value of the vertex. The tree has a root vertex with value n.
- T2) The vertices of the tree are distributed in d+1 disjoint levels $\ell=0,\ldots,d, d\geq 0$, where level 0 is formed solely by the root vertex, and level d consists of the vertices with values n_0, n_1, \ldots, n_r , from left to right. The vertices at level ℓ are those at a distance ℓ from the root. For each $\ell=0,\ldots,d-1$, we represent graphically the vertices at level ℓ above the vertices at level $\ell+1$.




Figure 3: Example of an admissible tree with height 3 and associated with $(1,3,2,1,2,1,2) \in$ C(12).

- T3) For each $\ell = 0, \dots, d-1$, every vertex at level ℓ is a neighbor of at least one vertex at level $\ell+1$, and there exists at least one vertex at level ℓ that is a neighbor of at least two vertices at level $\ell+1$. The vertices at level $\ell+1$ that are neighbors of a vertex v at level ℓ are called the direct descendants of v, and v is called the parent of these vertices. For each $\ell = 0, \dots, d$, the sum of the values of the vertices at level ℓ is n. If v_1, \ldots, v_k are the direct descendants of a vertex v, then the sum of the values of v_1, \ldots, v_k is the value of v.
- T4) For each $\ell = 0 \dots, d-1$, if a vertex v at level ℓ has only one direct descendant v' at level $\ell+1$, then v' has only one direct descendant as well, unless v' is a vertex in the last level d of the tree.

A tree satisfying the four properties T1) – T4) is called an admissible tree associated with \overline{n} , see Fig. 3. The collection of all these trees is denoted $\mathcal{T}_1(\overline{n})$. We say that an admissible tree has height d if it has d+1 levels. If a vertex v of an admissible tree has more than one direct descendant, we say that v is a multi-branching vertex.

We define now a weight for each admissible tree. First, for any vertex v of an admissible

$$\kappa_1(v) := \begin{cases} -\rho_1((\lambda_1, \dots, \lambda_s)) & \text{if } v \text{ is multi-branching, and } \lambda_1, \dots, \lambda_s, \ s \geq 2, \text{ are the values of the direct descendants of } v, \text{ from left to right,} \\ 1 & \text{otherwise,} \end{cases}$$

(4.1)recall that $\rho_1((\lambda_1,\ldots,\lambda_s)) = \prod_{j=1}^{s-1} {\lambda_j + \lambda_{j+1} - 1 \choose \lambda_j - 1}$. Then, for an admissible tree t we define

$$w_1(t) := \prod_{v} \kappa_1(v) \tag{4.2}$$

where the product is taken over all vertices of t.

In analogy to (3.6), we define the following expressions for each composition $\overline{n} \in C(n)$, $n \ge 0$:

$$\alpha(\overline{n}) := \begin{cases} \prod_{j=0}^{r} \alpha_{n_j} & \text{if } \overline{n} = (n_0, \dots, n_r), r \ge 0, \\ 1 & \text{if } \overline{n} = e, \end{cases}$$

$$(4.3)$$

$$\alpha(\overline{n}) := \begin{cases} \prod_{j=0}^{r} \alpha_{n_j} & \text{if } \overline{n} = (n_0, \dots, n_r), r \ge 0, \\ 1 & \text{if } \overline{n} = e, \end{cases}$$

$$\omega(\overline{n}) := \begin{cases} \prod_{j=0}^{r} \omega_{n_j} & \text{if } \overline{n} = (n_0, \dots, n_r), r \ge 0, \\ 1 & \text{if } \overline{n} = e. \end{cases}$$

$$(4.3)$$

Before we state our first result in this section, we want to define an operation on admissible trees called *extension*. Let t be an admissible tree. We say that a tree s is an extension of t by k units if s is obtained by appending to each vertex v in the last level of t a vertical




Figure 4: The tree shown is an extension of the tree in Fig. 3 by two units.

line tree with l edges and vertices with the same value as the vertex v, see Fig. 4. If l=0, we understand s=t. However, if $l \geq 1$, the new tree s is not an admissible tree (it does not satisfy property T3)).

Theorem 4.1. For each integer $n \geq 1$,

$$m_n = \sum_{\overline{n} \in C(n)} \phi_1(\overline{n}) \alpha(\overline{n}), \tag{4.5}$$

where

$$\phi_1(\overline{n}) := \sum_{t \in \mathcal{T}_1(\overline{n})} w_1(t). \tag{4.6}$$

Moreover, for each $n \geq 2$ we have

$$\sum_{\overline{n} \in \mathcal{C}(n)} \phi_1(\overline{n}) = 0. \tag{4.7}$$

See (4.3) and (4.2) for the meaning of notation.

Proof. The proof is by induction on n. The result holds trivially in the case n=1 since $C(1)=\{(1)\}, \phi_1((1))=1$ and $m_1=\alpha_1$.

Suppose that (4.5) is valid for all values $n=1,\ldots,k-1,\,k\geq 2$, and let us show that it is also valid for n=k. First, we deduce from (3.7) that

$$m_k = \alpha_k - \sum_{\overline{n} \in C_*(k)} \rho_1(\overline{n}) m(\overline{n}),$$
 (4.8)

where

$$C_*(k) := C(k) \setminus \{(k)\}. \tag{4.9}$$

Now we rewrite (4.8) in a convenient way.

Fix a particular $\overline{n} = (n_0, \dots, n_r) \in C_*(k)$. Then $m(\overline{n}) = m_{n_0} \cdots m_{n_r}$ and we can apply the induction hypothesis to each m_{n_j} since $1 \le n_j \le k-1$ for all $0 \le j \le r$. So

$$m_{n_j} = \sum_{\overline{p}_j \in \mathrm{C}(n_j)} \phi_1(\overline{p}_j) \, \alpha(\overline{p}_j), \qquad 0 \leq j \leq r,$$

and therefore

$$m(\overline{n}) = \prod_{j=0}^{r} \sum_{\overline{p}_{j} \in C(n_{j})} \phi_{1}(\overline{p}_{j}) \alpha(\overline{p}_{j}) = \sum_{(\overline{p}_{0}, \dots, \overline{p}_{r})} \prod_{j=0}^{r} \phi_{1}(\overline{p}_{j}) \alpha(\overline{p}_{j}), \tag{4.10}$$

where the last summation runs over all tuples $(\overline{p}_0, \dots, \overline{p}_r) \in C(n_0) \times \dots \times C(n_r)$. Applying (4.6) we get

$$\prod_{j=0}^{r} \phi_1(\overline{p}_j) \alpha(\overline{p}_j) = \prod_{j=0}^{r} \left(\sum_{t_j \in \mathcal{T}_1(\overline{p}_j)} w_1(t_j) \right) \alpha(\overline{p}_j) = \sum_{(t_0, \dots, t_r)} \prod_{j=0}^{r} w_1(t_j) \alpha(\overline{p}_j),$$
(4.11)

where the last summation runs over all tuples $(t_0, \ldots, t_r) \in \mathcal{T}_1(\overline{p}_0) \times \cdots \times \mathcal{T}_1(\overline{p}_r)$. From (4.8), (4.10) and (4.11) we deduce that

$$m_{k} = \alpha_{k} - \sum_{(n_{0}, \dots, n_{r}) \in C_{*}(k)} \sum_{(\overline{p}_{0}, \dots, \overline{p}_{r})} \sum_{(t_{0}, \dots, t_{r})} \rho_{1}((n_{0}, \dots, n_{r})) \prod_{j=0}^{r} w_{1}(t_{j}) \alpha(\overline{p}_{j}).$$
(4.12)

The summation in (4.12) has one term for each choice of $(n_0, \ldots, n_r) \in C_*(k)$ and corresponding choices of $(\overline{p}_0, \ldots, \overline{p}_r) \in C(n_0) \times \cdots \times C(n_r)$ and $(t_0, \ldots, t_r) \in \mathcal{T}_1(\overline{p}_0) \times \cdots \times \mathcal{T}_1(\overline{p}_r)$. The idea now is to show that for each term in this summation we can make the identification

$$-\rho_1((n_0,\ldots,n_r))\prod_{j=0}^r w_1(t_j)\,\alpha(\overline{p}_j) = w_1(t)\,\alpha(\overline{p})$$
(4.13)

for a certain admissible tree t associated with a vector $\overline{p} \in C_*(k)$ (the tree and the vector depends of course on the particular term).

So let us define two sets and a map between these sets to describe this identification. The first set S_1 consists of all tuples $(\overline{n}, \overline{\pi}, \overline{t})$ satisfying the conditions

$$\overline{n} = (n_0, \dots, n_r) \in \mathcal{C}_*(k),
\overline{\pi} = (\overline{p}_0, \dots, \overline{p}_r) \in \mathcal{C}(n_0) \times \dots \times \mathcal{C}(n_r),
\overline{t} = (t_0, \dots, t_r) \in \mathcal{T}_1(\overline{p}_0) \times \dots \times \mathcal{T}_1(\overline{p}_r).$$

The second set \mathcal{T}_1 is the collection of all admissible trees associated with a vector $\overline{p} \in C_*(k)$. Let $T_1 : \mathcal{S}_1 \longrightarrow \mathcal{T}_1$ be the map that assigns to each $(\overline{n}, \overline{\pi}, \overline{t}) \in \mathcal{S}_1$ the tree $t \in \mathcal{T}_1$ constructed using the following multi-step procedure:

- 1) Construct the admissible tree s with two levels (levels 0 and 1) associated with the vector $\overline{n} = (n_0, \dots, n_r)$.
- 2) Let d_j be the height of the admissible tree t_j in $\overline{t} = (t_0, \dots, t_r)$, and let $d := \max_{0 \le j \le r} d_j$. For each $j = 0, \dots, r$, construct a new tree \widehat{t}_j by performing an extension of t_j with $d d_j$ units. Note that at least one t_j remains unchanged after performing the extensions.
- 3) For each j = 0, ..., r, append the tree \hat{t}_j to the tree s by using the vertex in level 1 of s with value n_j as the root vertex of the tree \hat{t}_j . Let t be the resulting tree after completing this process.

It is evident that t is an admissible tree associated with a vector $\overline{p} \in C_*(k)$. Moreover, from (4.1) and (4.2) we easily deduce that (4.13) indeed holds. Also, the reader can easily check that the map T_1 is a one-to-one and onto. Therefore, from (4.12) and (4.13) we deduce the desired identity (4.5) for n = k.

Finally, we prove (4.7). If we formally set $\alpha_n = 1$ for all $n \geq 0$, then (4.5) transforms into $m_n = \sum_{\overline{n} \in C(n)} \phi_1(\overline{n})$ for all $n \geq 1$. Hence (4.7) will be justified if we show that

$$\alpha_n = 1 \text{ for all } n \ge 0 \implies m_n = 0 \text{ for all } n \ge 2.$$
 (4.14)

We prove this implication by induction on n. First, assuming the hypothesis we get $m_1 = \alpha_1 = 1$ and $m_2 = \alpha_2 - \alpha_1^2 = 0$. Let $k \geq 3$ and assume that $m_n = 0$ for all $2 \leq n \leq k - 1$. Then applying (4.8) we get

$$m_k = \alpha_k - \sum_{\overline{n} \in C_*(k)} \rho_1(\overline{n}) m(\overline{n}) = \alpha_k - \rho_1((1, \dots, 1)) m_1^k = 1 - 1 = 0,$$

since the only non-zero term in the summation is the one corresponding to the constant vector $\overline{n} = (1, ..., 1)$.

In order to state our next result, we need to define a second class of trees. Let $n \ge 1$ be an integer and let $\overline{n} = (n_0, \dots, n_r) \in C(n)$ be fixed. We say that a tree t belongs to the class $\mathcal{T}_2(\overline{n})$, if in addition to T1)–T4), t satisfies the following edge coloring conditions:

- A1) Every edge of the tree is either a blue edge (b-edge) or a red edge (r-edge).
- A2) If t does not reduce to a single vertex, v is the root vertex of t, and $v_1, \ldots, v_s, s \geq 2$, are the direct descendants of v, listed from left to right, then there exists $1 \leq j \leq s-1$ such that the edges connecting v with v_1, \ldots, v_j are all b-edges, and the edges connecting v with v_{j+1}, \ldots, v_s are all r-edges.
- A3) If v is a vertex in t different from the root vertex, then the edge connecting v with its parent has the same color as the edges connecting v with its direct descendants, in case v has any.

Note that among the edges connecting the root vertex with its direct descendants, there are at least one b-edge and and at least one r-edge. Let $t \in \mathcal{T}_2(\overline{n})$. For any vertex v of t, we define

$$\kappa_2(v) := \begin{cases} 2 & \text{if } v \text{ is the only vertex of } t, \\ \rho_2((\lambda_1, \dots, \lambda_j), (\lambda_{j+1}, \dots, \lambda_s)) & \text{if } v \text{ is the root vertex of } t, v \text{ is multi-branching,} \\ \lambda_1, \dots, \lambda_s \text{ are the values of the direct descendants } v_1, \dots, v_s \text{ of } v, \text{ respectively, and } j \text{ is as in } A2), \\ \kappa_1(v) & \text{if } v \text{ is not the root vertex of } t. \end{cases}$$

(4.15)

We also define

$$w_2(t) := \prod \kappa_2(v), \tag{4.16}$$

the product taken over all vertices of t.

Theorem 4.2. For each integer $n \ge 1$,

$$\omega_n = \sum_{\overline{n} \in C(n)} \phi_2(\overline{n}) \, \alpha(\overline{n}), \tag{4.17}$$

where

$$\phi_2(\overline{n}) := \sum_{t \in \mathcal{T}_2(\overline{n})} w_2(t). \tag{4.18}$$

Moreover, for each $n \geq 1$,

$$\sum_{\overline{n} \in C(n)} \phi_2(\overline{n}) = 2n. \tag{4.19}$$

Proof. According to (3.8), for any $n \ge 1$,

$$\omega_n = \sum_{(\overline{p}, \overline{q}) \in \widehat{C}(n)} \rho_2(\overline{p}, \overline{q}) m(\overline{p}) m(\overline{q})$$
(4.20)

Let $\ell(\overline{p})$ denote the number of components of \overline{p} , and $\overline{p}(j)$ the j-th component of \overline{p} . Then applying (4.5) we obtain

$$m(\overline{p}) = \prod_{j=1}^{\ell(\overline{p})} m_{\overline{p}(j)} = \sum_{(\overline{n}_1, \dots, \overline{n}_{\ell(\overline{p})})} \prod_{j=1}^{\ell(\overline{p})} \phi_1(\overline{n}_j) \alpha(\overline{n}_j)$$

where the summation runs over all tuples $(\overline{n}_1, \dots, \overline{n}_{\ell(\overline{p})}) \in C(\overline{p}(1)) \times \dots \times C(\overline{p}(\ell(\overline{p})))$. Inserting in the above identity the relations (4.6), we get

$$m(\overline{p}) = \sum_{(\overline{n}_1, \dots, \overline{n}_{\ell(\overline{n})})} \sum_{(t_1, \dots, t_{\ell(\overline{n})})} \prod_{j=1}^{\ell(\overline{p})} w_1(t_j) \alpha(\overline{n}_j), \tag{4.21}$$

where the inner summation is over all the tuples $(t_1, \ldots, t_{\ell(\overline{p})}) \in \mathcal{T}_1(\overline{n}_1) \times \cdots \times \mathcal{T}_1(\overline{n}_{\ell(\overline{p})})$. Hence, (4.21) and the analogous expression for $m(\overline{q})$ applied to (4.20) give

$$\omega_{n} = \sum_{(\overline{p},\overline{q}) \in \widehat{C}(n)} \sum_{\overline{\pi}} \sum_{\overline{\tau}} \sum_{\overline{\tau}'} \sum_{\overline{\tau}'} \rho_{2}(\overline{p},\overline{q}) \left(\prod_{j=1}^{\ell(\overline{p})} w_{1}(t_{j}) \alpha(\overline{n}_{j}) \right) \left(\prod_{i=1}^{\ell(\overline{q})} w_{1}(t'_{i}) \alpha(\overline{n}'_{i}) \right), \quad (4.22)$$

where we used the abbreviations $\overline{\pi} = (\overline{n}_1, \dots, \overline{n}_{\ell(\overline{p})}), \overline{\tau} = (t_1, \dots, t_{\ell(\overline{p})}), \overline{\pi}' = (\overline{n}'_1, \dots, \overline{n}'_{\ell(\overline{q})}), \overline{\tau}' = (t'_1, \dots, t'_{\ell(\overline{p})}).$

In (4.22) we shall distinguish different groups of terms. The first group is formed by only two terms; one is obtained by taking $(\overline{p}, \overline{q}) = ((n), e), \overline{n}_1 = (n)$ and t_1 the tree whose only vertex has value n, and the other term is obtained by taking $(\overline{p}, \overline{q}) = (e, (n)), \overline{n}'_1 = (n)$ and t'_1 as t_1 before. Both terms give the same contribution and we call this first group

$$S_{1,n} := 2\alpha_n$$
.

The second group we distinguish is formed by all terms in (4.22) obtained by taking $(\overline{p}, \overline{q}) = ((n), e), \overline{n}_1 \in C_*(n)$, cf. (4.9). The sum of all these terms is

$$S_{2,n} := \sum_{\overline{n} \in C_*(n)} \sum_{t \in \mathcal{T}_1(\overline{n})} w_1(t) \, \alpha(\overline{n}).$$

By symmetry, it is clear that we obtain the same expression if we take $(\overline{p}, \overline{q}) = (e, (n))$, $\overline{n}'_1 \in C_*(n)$. The third group that we distinguish is formed by all terms in (4.22) obtained by taking $\overline{p} \in C_*(n)$, $\overline{q} = e$, which we denote

$$S_{3,n} := \sum_{\overline{p} \in C_*(n)} \sum_{(\overline{n}_1, \dots, \overline{n}_{\ell(\overline{p})})} \sum_{(t_1, \dots, t_{\ell(\overline{p})})} \rho_1(\overline{p}) \prod_{j=1}^{\ell(\overline{p})} w_1(t_j) \alpha(\overline{n}_j).$$

We get the same expression if we take $\overline{p} = e$, $\overline{q} \in C_*(n)$. Finally, the last group that we consider is formed by all the terms in (4.22) obtained by taking

$$(\overline{p}, \overline{q}) \in \bigcup_{j=1}^{n-1} C(j) \times C(n-j),$$

i.e., $(\overline{p}, \overline{q}) \in \widehat{C}(n)$ with $\overline{p} \neq e$, $\overline{q} \neq e$. We call $S_{4,n}$ the sum of all the terms in this last group. Hence, we have

$$\omega_n = S_{1,n} + 2S_{2,n} + 2S_{3,n} + S_{4,n}.$$

But $S_{3,n} = -S_{2,n}$, since in virtue of (4.12), (4.5) and (4.6),

$$S_{3,n} = \alpha_n - m_n = \alpha_n - \sum_{\overline{n} \in C(n)} \sum_{t \in \mathcal{T}_1(\overline{n})} w_1(t) \alpha(\overline{n}) = -S_{2,n}.$$

We conclude that

$$\omega_n = 2\alpha_n + S_{4,n}. (4.23)$$

To finish the proof of (4.17), we will show that there is a bijective correspondence between terms in $2\alpha_n + S_{4,n}$ and trees in the classes $\mathcal{T}_2(\overline{n})$, $\overline{n} \in C(n)$. This correspondence can be constructed in a way similar to the construction of the map T_1 in the proof of (4.5). We describe this construction below.

First, observe that

$$2\alpha_n = w_2(t_0) \,\alpha((n)) = \phi_2((n)) \,\alpha((n)), \tag{4.24}$$

where t_0 represents the tree with only one vertex with value n. Now we focus on the terms that appear in $S_{4,n}$. These terms are parametrized by the elements in the set S_2 consisting of all the tuples $((\overline{p}, \overline{q}), \overline{\pi}, \overline{\tau}, \overline{\pi}', \overline{\tau}')$ satisfying

$$(\overline{p}, \overline{q}) \in \bigcup_{j=1}^{n-1} C(j) \times C(n-j)$$

$$\overline{\pi} = (\overline{n}_1, \dots, \overline{n}_{\ell(\overline{p})}) \in C(\overline{p}(1)) \times \dots \times C(\overline{p}(\ell(\overline{p})))$$

$$\overline{\tau} = (t_1, \dots, t_{\ell(\overline{p})}) \in \mathcal{T}_1(\overline{n}_1) \times \dots \times \mathcal{T}_1(\overline{n}_{\ell(\overline{p})})$$

$$\overline{\pi}' = (\overline{n}'_1, \dots, \overline{n}'_{\ell(\overline{q})}) \in C(\overline{q}(1)) \times \dots \times C(\overline{q}(\ell(\overline{q})))$$

$$\overline{\tau}' = (t'_1, \dots, t'_{\ell(\overline{q})}) \in \mathcal{T}_1(\overline{n}'_1) \times \dots \times \mathcal{T}_1(\overline{n}'_{\ell(\overline{q})})$$

see (4.22). Let \mathcal{T}_2 be the collection of all trees belonging to the classes $\mathcal{T}_2(\overline{n})$, $\overline{n} \in C_*(n)$. Let $T_2 : \mathcal{S}_2 \longrightarrow \mathcal{T}_2$ be the map that assigns to each element $((\overline{p}, \overline{q}), \overline{\pi}, \overline{\tau}, \overline{\pi}', \overline{\tau}')$ the tree t constructed using the following multi-step procedure:

- 1) Construct the admissible tree with two levels (levels 0 and 1), where level 1 is formed, from left to right, by the vertices with values $\overline{p}(1), \ldots, \overline{p}(\ell(\overline{p})), \overline{q}(1), \ldots, \overline{q}(\ell(\overline{q}))$. Color blue all the edges connecting the root with the vertices with values $\overline{p}(1), \ldots, \overline{p}(\ell(\overline{p}))$, and color red the remaining edges.
- 2) Let d_j denote the height of the tree t_j , $1 \leq j \leq \ell(\overline{p})$, and d'_l the height of the tree t'_l , $1 \leq l \leq \ell(\overline{q})$. If d is the maximum of all the values d_j and d'_l , construct new trees \hat{t}_j (and \hat{t}'_l) by performing extensions of the trees t_j (respectively, t'_l) with $d d_j$ units (respectively, $d d'_l$ units). Color blue all the edges of the trees \hat{t}_j , $1 \leq j \leq \ell(\overline{p})$, and color red all the edges of the trees \hat{t}'_l , $1 \leq l \leq \ell(\overline{q})$.
- 3) For each $j=1,\ldots,\ell(\overline{p})$, append the tree \widehat{t}_j to the tree constructed in step 1) by using the vertex with value $\overline{p}(j)$ as the root vertex of the tree \widehat{t}_j , and do the same with the trees \widehat{t}_l' and the vertices with values $\overline{q}(l)$. Let t be the tree obtained after completing this step.

Since $\overline{p} \neq e$, $\overline{q} \neq e$, the tree t is indeed a tree in the class $\mathcal{T}_2(\overline{n})$, for some $\overline{n} \in C_*(n)$. The entries of \overline{n} are obtained by concatenation of the entries of $\overline{n}_1, \ldots, \overline{n}_{\ell(\overline{p})}, \overline{n}'_1, \ldots, \overline{n}'_{\ell(\overline{q})}$, in this order from left to right. It is also clear from the construction of t and the definitions (4.15)–(4.16) that

$$\rho_2(\overline{p}, \overline{q}) \left(\prod_{j=1}^{\ell(\overline{p})} w_1(t_j) \alpha(\overline{n}_j) \right) \left(\prod_{i=1}^{\ell(\overline{q})} w_1(t_i') \alpha(\overline{n}_i') \right) = w_2(t) \alpha(\overline{n}). \tag{4.25}$$

Moreover, it is easy to see that the map T_2 is a bijection. Hence, from (4.23), (4.24) and (4.25) we deduce that

$$\omega_n = 2\alpha_n + \sum_{\overline{n} \in C_*(n)} \sum_{t \in \mathcal{T}_2(\overline{n})} w_2(t) \alpha(\overline{n}),$$

which is the identity (4.17).

Now we justify (4.19). We proceed as in the proof of (4.7), and we formally set $\alpha_n = 1$ for all $n \ge 0$. The goal is to show that in this case $\omega_n = \sum_{\overline{n} \in C(n)} \phi_2(\overline{n}) = 2n$. According to

(4.14), in this situation we have $m_1 = 1$ and $m_k = 0$ for all $k \ge 2$, hence in virtue of (4.20) we get

$$\omega_n = \sum_{(\overline{p},\overline{q}) \in \widehat{C}(n)} \rho_2(\overline{p},\overline{q}) \, m(\overline{p}) \, m(\overline{q}) = \sum_{j=0}^n \rho_2(\mathbf{1}_j,\mathbf{1}_{n-j}) = 2n,$$

where for j > 0, $\mathbf{1}_j$ denotes the vector $(1, \dots, 1) \in \mathbf{C}(j)$ with all its j entries equal to 1, and $\mathbf{1}_0 = e \in \mathbf{C}(0)$.

In this section we also analyze the relations that express the quantities m_n and α_n in terms of the quantities ω_k , $k=0,\ldots,n$. The first few relations between these sequences take the form

$$\begin{split} m_1 &= \frac{1}{2}\omega_1 \\ m_2 &= \frac{1}{2}\omega_2 - \frac{1}{2}\omega_1^2 \\ m_3 &= \frac{1}{2}\omega_3 - \frac{3}{2}\omega_2\omega_1 + \frac{9}{8}\omega_1^3 \\ m_4 &= \frac{1}{2}\omega_4 - 2\omega_3\omega_1 + 7\omega_2\omega_1^2 - \frac{3}{2}\omega_2^2 - \frac{17}{4}\omega_1^4 \\ m_5 &= \frac{1}{2}\omega_5 - \frac{5}{2}\omega_4\omega_1 - 5\omega_3\omega_2 + \frac{95}{8}\omega_3\omega_1^2 + \frac{145}{8}\omega_2^2\omega_1 - 45\omega_2\omega_1^3 + \frac{365}{16}\omega_1^5 \\ \alpha_1 &= \frac{1}{2}\omega_1 \\ \alpha_2 &= \frac{1}{2}\omega_2 - \frac{1}{4}\omega_1^2 \\ \alpha_3 &= \frac{1}{2}\omega_3 - \frac{3}{4}\omega_2\omega_1 + \frac{1}{2}\omega_1^3 \\ \alpha_4 &= \frac{1}{2}\omega_4 - \omega_3\omega_1 - \frac{3}{4}\omega_2^2 + \frac{25}{8}\omega_2\omega_1^2 - \frac{29}{16}\omega_1^4 \\ \alpha_5 &= \frac{1}{2}\omega_5 - \frac{5}{4}\omega_4\omega_1 - \frac{5}{2}\omega_3\omega_2 + \frac{21}{4}\omega_3\omega_1^2 + \frac{33}{4}\omega_2^2\omega_1 - \frac{309}{16}\omega_2\omega_1^3 + \frac{19}{2}\omega_1^5. \end{split}$$

We need to introduce two more classes of bi-colored trees. The first one is defined as follows. For $n \geq 1$ and $\overline{n} = (n_0, \dots, n_r) \in C(n)$, we say that a tree t belongs to the class $\mathcal{T}_3(\overline{n})$, if in addition to T1)-T4, t satisfies the following conditions:

- B1) Every edge of the tree is either a blue edge (b-edge) or a red edge (r-edge).
- B2) If a vertex v is multi-branching and $v_1, v_2, \ldots, v_s, s \geq 2$, are the direct descendants of v, listed from left to right, then there exists $0 \leq j \leq s$ such that the edges connecting v with v_1, \ldots, v_j are all b-edges, and the edges connecting v with v_{j+1}, \ldots, v_s are all v-edges. If j=0, then we understand that all the edges are v-edges, and if v-edges are v-edges.
- B3) If a vertex v has only one direct descendant, then the edge connecting v with its parent and the edge connecting v with its direct descendant have the same color.

Note that these rules uniquely determine the color of each edge. For any vertex v of a

tree $t \in \mathcal{T}_3(\overline{n})$, we define

$$\kappa_3(v) := \begin{cases} \frac{1}{2} & \text{if } v \text{ is the only vertex of the tree, or if} \\ v \text{ is not multi-branching and is a direct} \\ -\frac{1}{2} \, \rho_2((\lambda_1,\ldots,\lambda_j),(\lambda_{j+1},\ldots,\lambda_s)) & \text{if } v \text{ is multi-branching, } \lambda_1,\ldots,\lambda_s, \, s \geq 2, \\ \text{are the values of the direct descendants} \\ v_1,\ldots,v_s \text{ of } v, \text{ respectively, and } j \text{ is as in} \\ B2), \\ 1 & \text{otherwise.} \end{cases}$$

if v is the only vertex of the tree, or if

In this definition, we understand $(\lambda_1, \ldots, \lambda_j) = e$ if j = 0, and $(\lambda_{j+1}, \ldots, \lambda_s) = e$ if j = s. The third case in (4.26) refers to a vertex that is not multi-branching and is not a direct descendant of a multi-branching vertex.

Finally, for a tree $t \in \mathcal{T}_3(\overline{n})$ we define

$$w_3(t) := \prod \kappa_3(v), \tag{4.27}$$

where the product is taken over all vertices of t.

Theorem 4.3. For each integer $n \geq 1$,

$$m_n = \sum_{\overline{n} \in C(n)} \phi_3(\overline{n}) \,\omega(\overline{n}), \tag{4.28}$$

where

$$\phi_3(\overline{n}) := \sum_{t \in \mathcal{T}_3(\overline{n})} w_3(t). \tag{4.29}$$

Proof. The argument used here is the same used in the proof of (4.5), but for the sake of clarity in the exposition we reproduce it.

First, the result is trivially true for n=1, since $\phi_3((1))=1/2$ and $m_1=\omega_1/2$. Assume that (4.28) holds for all values $n = 1, \dots, k - 1, k \ge 2$, and let us prove that it also holds for n = k.

It follows from (3.8) that

$$m_{k} = \frac{\omega_{k}}{2} - \frac{1}{2} \sum_{(\overline{p}, \overline{q}) \in \widehat{\mathbb{Q}}_{+}(k)} \rho_{2}(\overline{p}, \overline{q}) \, m(\overline{p}) \, m(\overline{q}), \tag{4.30}$$

where

$$\widehat{\mathcal{C}}_*(k) := \widehat{\mathcal{C}}(k) \setminus \{((k), e), (e, (k))\}.$$

Given a pair $(\overline{p}, \overline{q}) \in \widehat{C}_*(k)$, if we apply the induction hypothesis to each factor in $m(\overline{p})$ and

$$m(\overline{p}) = \prod_{j=1}^{\ell(\overline{p})} m_{\overline{p}(j)} = \sum_{(\overline{n}_1, \dots, \overline{n}_{\ell(\overline{p})})} \prod_{j=1}^{\ell(\overline{p})} \phi_3(\overline{n}_j) \, \omega(\overline{n}_j) = \sum_{(\overline{n}_1, \dots, \overline{n}_{\ell(\overline{p})})} \sum_{(t_1, \dots, t_{\ell(\overline{p})})} \prod_{j=1}^{\ell(\overline{p})} w_3(t_j) \, \omega(\overline{n}_j),$$

$$(4.31)$$

$$m(\overline{q}) = \prod_{i=1}^{\ell(\overline{q})} m_{\overline{q}(i)} = \sum_{(\overline{n}'_1, \dots, \overline{n}'_{\ell(\overline{q})})} \prod_{i=1}^{\ell(\overline{q})} \phi_3(\overline{n}'_i) \,\omega(\overline{n}'_i) = \sum_{(\overline{n}'_1, \dots, \overline{n}'_{\ell(\overline{q})})} \sum_{(t'_1, \dots, t'_{\ell(\overline{q})})} \prod_{i=1}^{\ell(\overline{q})} w_3(t'_i) \,\omega(\overline{n}'_i),$$

$$(4.32)$$

where the summations in (4.31) are taken over $(\overline{n}_1, \ldots, \overline{n}_{\ell(\overline{p})}) \in C(\overline{p}(1)) \times \cdots \times C(\overline{p}(\ell(\overline{p})))$, $(t_1, \ldots, t_{\ell(\overline{p})}) \in \mathcal{T}_3(\overline{n}_1) \times \cdots \times \mathcal{T}_3(\overline{n}_{\ell(\overline{p})})$, and the summations in (4.32) are taken over $(\overline{n}'_1, \ldots, \overline{n}'_{\ell(\overline{q})}) \in C(\overline{q}(1)) \times \cdots \times C(\overline{q}(\ell(\overline{q})))$, $(t'_1, \ldots, t'_{\ell(\overline{q})}) \in \mathcal{T}_3(\overline{n}'_1) \times \cdots \times \mathcal{T}_3(\overline{n}'_{\ell(\overline{q})})$. From (4.30) and (4.31)–(4.32) we obtain

$$m_{k} = \frac{\omega_{k}}{2} - \frac{1}{2} \sum_{(\overline{p}, \overline{q}) \in \widehat{C}_{*}(k)} \sum_{\overline{\pi}} \sum_{\overline{\tau}} \sum_{\overline{\tau}'} \sum_{\overline{\tau}'} \rho_{2}(\overline{p}, \overline{q}) \left(\prod_{j=1}^{\ell(\overline{p})} w_{3}(t_{j}) \omega(\overline{n}_{j}) \right) \left(\prod_{i=1}^{\ell(\overline{q})} w_{3}(t'_{i}) \omega(\overline{n}'_{i}) \right)$$

$$(4.33)$$

where we have the same abbreviations used in (4.22).

One can show, as in the proof of (4.25), that for each term in the summation in (4.33) there exists a unique tree $t \in \mathcal{T}_3(\overline{n})$ associated with a vector $\overline{n} \in C_*(k)$ such that

$$-\frac{1}{2}\rho_2(\overline{p},\overline{q})\left(\prod_{j=1}^{\ell(\overline{p})}w_3(t_j)\,\omega(\overline{n}_j)\right)\left(\prod_{i=1}^{\ell(\overline{q})}w_3(t_i')\,\omega(\overline{n}_i')\right) = w_3(t)\,\omega(\overline{n}). \tag{4.34}$$

To make the argument explicit, let us consider the set S_3 consisting of all the tuples $((\overline{p}, \overline{q}), \overline{\pi}, \overline{\tau}, \overline{\pi}', \overline{\tau}')$ where

$$(\overline{p}, \overline{q}) \in \widehat{C}_{*}(k)$$

$$\overline{\pi} = (\overline{n}_{1}, \dots, \overline{n}_{\ell(\overline{p})}) \in C(\overline{p}(1)) \times \dots \times C(\overline{p}(\ell(\overline{p})))$$

$$\overline{\tau} = (t_{1}, \dots, t_{\ell(\overline{p})}) \in \mathcal{T}_{3}(\overline{n}_{1}) \times \dots \times \mathcal{T}_{3}(\overline{n}_{\ell(\overline{p})})$$

$$\overline{\pi}' = (\overline{n}'_{1}, \dots, \overline{n}'_{\ell(\overline{q})}) \in C(\overline{q}(1)) \times \dots \times C(\overline{q}(\ell(\overline{q})))$$

$$\overline{\tau}' = (t'_{1}, \dots, t'_{\ell(\overline{q})}) \in \mathcal{T}_{3}(\overline{n}'_{1}) \times \dots \times \mathcal{T}_{3}(\overline{n}'_{\ell(\overline{q})})$$

$$(4.35)$$

and let \mathcal{T}_3 be the collection of all trees in the classes $\mathcal{T}_3(\overline{n})$, $\overline{n} \in C_*(k)$. If $\overline{p} = e$ (or $\overline{q} = e$) in (4.35), then we understand that the corresponding elements in \mathcal{S}_3 are of the form $((e, \overline{q}), \overline{\pi}', \overline{\tau}')$ (respectively $((\overline{p}, e), \overline{\pi}, \overline{\tau})$). Now consider the map $T_3 : \mathcal{S}_3 \longrightarrow \mathcal{T}_3$ that assigns to each element $((\overline{p}, \overline{q}), \overline{\pi}, \overline{\tau}, \overline{\pi}', \overline{\tau}')$ the tree t constructed using the following procedure:

- 1) Construct the admissible tree with two levels (levels 0 and 1), where level 1 is formed, from left to right, by the vertices with values $\overline{p}(1), \ldots, \overline{p}(\ell(\overline{p})), \overline{q}(1), \ldots, \overline{q}(\ell(\overline{q}))$. Color blue the edges connecting the root with the vertices with values $\overline{p}(1), \ldots, \overline{p}(\ell(\overline{p}))$, and color red the rest. If $\overline{p} = e$ (or $\overline{q} = e$), then all edges in this tree are red (respectively blue). Note that this tree contains at least two edges.
- 2) Let d_j denote the height of the tree t_j , $1 \leq j \leq \ell(\overline{p})$, and d_i' the height of the tree t_i' , $1 \leq i \leq \ell(\overline{q})$. If d is the maximum of all the values d_j and d_i' , construct new trees \widehat{t}_j (and \widehat{t}_i') by performing an extension of the trees t_j (respectively t_i') with $d-d_j$ units (respectively $d-d_i'$ units). The coloring of the new edges that are added in the extensions follows the following rules. Assume that $d-d_j>0$ (otherwise $t_j=\widehat{t}_j$ and there are no additional edges). If the tree t_j has height $d_j>0$, then each new edge added to form \widehat{t}_j is colored so that the rule B3) holds for all vertices in \widehat{t}_j that are not multi-branching. If t_j has height $d_j=0$, then each new edge added to t_j is colored blue. The same rules are valid for the trees \widehat{t}_i' , except that red is used instead of blue in the case that t_i' has height zero.
- 3) For each $j = 1, ..., \ell(\overline{p})$, append the tree \hat{t}_j to the tree constructed in step 1) by using the vertex with value $\overline{p}(j)$ as the root vertex of the tree \hat{t}_j , and do the same with the trees \hat{t}'_i and the vertices with values $\overline{q}(i)$. Let t be the tree obtained after completing this step.

From this construction we easily deduce that t is a tree in the class $\mathcal{T}_3(\overline{n})$ for some $\overline{n} \in C_*(k)$, and it is clear that (4.34) holds. Moreover, the map $T_3 : \mathcal{S}_3 \longrightarrow \mathcal{T}_3$ is a bijection and therefore we can write

$$m_k = \frac{\omega_k}{2} + \sum_{\overline{n} \in C_*(k)} \sum_{t \in \mathcal{T}_3(\overline{n})} w_3(t) \,\omega(\overline{n}),$$

which is the desired identity.

For our last result in this section, we introduce the following class of trees. Given $n \ge 1$ and $\overline{n} = (n_0, \dots, n_r) \in C(n)$, we say that a tree t belongs to the class $\mathcal{T}_4(\overline{n})$, if in addition to T1)–T4), t satisfies the following conditions:

- C1) Every edge of the tree is either a blue edge (b-edge) or a red edge (r-edge).
- C2) If t does not reduce to a single vertex and v is the root vertex of t, then condition A2) holds for this vertex. That is, if $v_1, \ldots, v_s, s \geq 2$, are the direct descendants of v, listed from left to right, then there exists $1 \le j \le s-1$ such that the edges connecting v with v_1, \ldots, v_i are all b-edges, and the edges connecting v with v_{i+1}, \ldots, v_s are all r-edges.
- C3) If v is a vertex in t different from the root vertex, then condition B2) holds for v if vis multi-branching, and condition B3) holds for v if v is not multi-branching.

These rules uniquely determine the color of each edge. Also note that among the edges connecting the root vertex with its direct descendants, there are at least one b-edge and at least one r-edge. For any vertex v of a tree $t \in \mathcal{T}_4(\overline{n})$, let

$$\kappa_4(v) := \begin{cases} \frac{1}{2} & \text{if } v \text{ is the only vertex of } t, \\ -\frac{1}{2} \rho_2((\lambda_1, \dots, \lambda_j), (\lambda_{j+1}, \dots, \lambda_s)) & \text{if } v \text{ is the root vertex of } t, v \text{ is multibranching, } \lambda_1, \dots, \lambda_s \text{ are the values of the direct descendants } v_1, \dots, v_s \text{ of } v, \text{ respectively, and } j \text{ is as in } C2), \\ \kappa_3(v) & \text{if } v \text{ is not the root vertex of } t. \end{cases}$$

We define

$$w_4(t) := \prod_v \kappa_4(v),$$

the product taken over all vertices of t.

Theorem 4.4. For each $n \ge 1$,

$$\alpha_n = \sum_{\overline{n} \in C(n)} \phi_4(\overline{n}) \,\omega(\overline{n}), \tag{4.36}$$

where

$$\phi_4(\overline{n}) := \sum_{t \in \mathcal{T}_4(\overline{n})} w_4(t). \tag{4.37}$$

Proof. According to (3.7), we have

$$\alpha_n = \sum_{\overline{p} \in C(n)} \rho_1(\overline{p}) m(\overline{p}) = m_n + \beta_n, \tag{4.38}$$

where

$$\beta_n := \sum_{\overline{p} \in C_*(n)} \rho_1(\overline{p}) m(\overline{p}).$$

Using (4.31), we can rewrite β_n as

$$\beta_n = \sum_{\overline{p} \in C_*(n)} \sum_{(\overline{n}_1, \dots, \overline{n}_{\ell(\overline{p})})} \sum_{(t_1, \dots, t_{\ell(\overline{p})})} \rho_1(\overline{p}) \left(\prod_{j=1}^{\ell(\overline{p})} w_3(t_j) \omega(\overline{n}_j) \right),$$




Figure 5: The four trees that form the set $\bigcup_{\overline{n} \in C(2)} \mathcal{T}_3(\overline{n})$.

and, reproducing (4.33), we have

$$m_{n} = \frac{\omega_{n}}{2} - \frac{1}{2} \sum_{(\overline{p}, \overline{q}) \in \widehat{C}_{*}(n)} \sum_{\overline{\pi}} \sum_{\overline{\tau}} \sum_{\overline{\tau}'} \sum_{\overline{\tau}'} \sum_{\overline{\tau}'} \rho_{2}(\overline{p}, \overline{q}) \left(\prod_{j=1}^{\ell(\overline{p})} w_{3}(t_{j}) \omega(\overline{n}_{j}) \right) \left(\prod_{i=1}^{\ell(\overline{q})} w_{3}(t'_{i}) \omega(\overline{n}'_{i}) \right)$$

$$(4.39)$$

where the summation indexes have the same meaning as in the referenced formulas.

If we distinguish in the summation in (4.39) the terms with $\overline{p}=e$, we readily see that the sum of all these terms is exactly β_n (here we are disregarding the prefactor $-\frac{1}{2}$). Likewise, the sum of all the terms obtained by taking $\overline{q}=e$ is β_n . The remaining terms in the summation are those corresponding to the choice $(\overline{p},\overline{q})\in\widehat{C}_*(n), \ \overline{p}\neq e, \ \overline{q}\neq e$, or equivalently, $(\overline{p},\overline{q})\in\widehat{C}(n):=\bigcup_{j=1}^{n-1}C(j)\times C(n-j)$. Therefore, these considerations together with (4.38) and (4.39) imply that

$$\alpha_n = \frac{\omega_n}{2} - \frac{1}{2} \sum_{(\overline{p},\overline{q}) \in \widetilde{C}(n)} \sum_{\overline{\pi}} \sum_{\overline{\tau}} \sum_{\overline{\pi}'} \sum_{\overline{\tau}'} \sum_{\overline{\tau}'} \rho_2(\overline{p},\overline{q}) \left(\prod_{j=1}^{\ell(\overline{p})} w_3(t_j) \, \omega(\overline{n}_j) \right) \left(\prod_{i=1}^{\ell(\overline{q})} w_3(t_i') \, \omega(\overline{n}_i') \right).$$

The rest of the argument can be completed as in the proof of (4.34). Indeed, we can consider the set S_4 consisting of all the tuples $((\overline{p}, \overline{q}), \overline{\pi}, \overline{\tau}, \overline{\tau}', \overline{\tau}')$ satisfying (4.35) with $\widehat{C}_*(k)$ replaced by $\widetilde{C}(n) = \bigcup_{j=1}^{n-1} C(j) \times C(n-j)$, and consider the set \mathcal{T}_4 consisting of all trees in the classes $\mathcal{T}_4(\overline{n})$, $\overline{n} \in C_*(\overline{n})$. If we define the map $T_4: S_4 \longrightarrow \mathcal{T}_4$ the same way T_3 was defined in the proof of (4.34), then T_4 is a bijection, which will imply that

$$\alpha_n = \frac{\omega_n}{2} + \sum_{\overline{n} \in C_*(n)} \sum_{t \in \mathcal{T}_4(\overline{n})} w_4(t) \,\omega(\overline{n})$$

and this is (4.36).

We finish this section illustrating the formulas (4.28) and (4.36) in the cases n = 2, 3. The four trees that form the set $\bigcup_{\overline{n} \in C(2)} \mathcal{T}_3(\overline{n})$ are shown in Fig. 5. We have $w_3(\widetilde{\mathbf{t}}_1) = 1/2$, $w_3(\widetilde{\mathbf{t}}_2) = w_3(\widetilde{\mathbf{t}}_4) = -1/8$, and $w_3(\widetilde{\mathbf{t}}_3) = -1/4$, hence according to (4.28),

$$m_2 = w_3(\widetilde{\mathbf{t}}_1) \,\omega_2 + (w_3(\widetilde{\mathbf{t}}_2) + w_3(\widetilde{\mathbf{t}}_3) + w_3(\widetilde{\mathbf{t}}_4)) \,\omega_1^2 = \frac{1}{2} \,\omega_2 - \frac{1}{2} \,\omega_1^2.$$

The two trees that form the set $\bigcup_{\overline{n} \in C(2)} \mathcal{T}_4(\overline{n})$ are the trees $\widetilde{\mathbf{t}}_1$ and $\widetilde{\mathbf{t}}_3$ shown in Fig. 5. Since $w_4(\widetilde{\mathbf{t}}_1) = 1/2$, $w_4(\widetilde{\mathbf{t}}_3) = -1/4$, formula (4.36) gives

$$\alpha_2 = w_4(\widetilde{\mathbf{t}}_1) \,\omega_2 + w_4(\widetilde{\mathbf{t}}_3) \,\omega_1^2 = \frac{1}{2} \,\omega_2 - \frac{1}{4} \,\omega_1^2.$$




Figure 6: The twenty-nine trees that form the set $\bigcup_{\overline{n} \in C(3)} \mathcal{T}_3(\overline{n})$.

Now we check the formulas in the case n=3. The set $\bigcup_{\overline{n}\in C(3)} \mathcal{T}_3(\overline{n})$ consists of twenty-nine trees that are shown in Fig. 6. The reader can check that the values of the w_3 -weights

of these trees are

$$w_3(\mathbf{t}_1) = \frac{1}{2}$$

$$w_3(\mathbf{t}_j) = -\frac{1}{4}, \quad j \in \{2, 4\}$$

$$w_3(\mathbf{t}_j) = -\frac{3}{8}, \quad j \in \{3, 6\}$$

$$w_3(\mathbf{t}_j) = -\frac{1}{8}, \quad j \in \{5, 7, 9, 10\}$$

$$w_3(\mathbf{t}_j) = -\frac{1}{16}, \quad j \in \{8, 11\}$$

$$w_3(\mathbf{t}_j) = \frac{1}{16}, \quad j \in \{12, 14, 18, 20, 22, 28\}$$

$$w_3(\mathbf{t}_j) = \frac{1}{8}, \quad j \in \{13, 19\}$$

$$w_3(\mathbf{t}_j) = \frac{3}{32}, \quad j \in \{15, 17, 24, 26\}$$

$$w_3(\mathbf{t}_j) = \frac{3}{16}, \quad j \in \{16, 25\}$$

$$w_3(\mathbf{t}_j) = \frac{1}{32}, \quad j \in \{21, 23, 27, 29\}$$

which gives $\phi_3((3)) = 1/2$, $\phi_3((2,1)) + \phi_3((1,2)) = \sum_{j=2}^7 w_3(\mathbf{t}_j) = -3/2$, and $\phi_3((1,1,1)) = \sum_{j=8}^{29} w_3(\mathbf{t}_j) = 9/8$. This shows that

$$m_3 = \sum_{\overline{n} \in C(3)} \phi_3(\overline{n}) \,\omega(\overline{n}) = \frac{1}{2} \,\omega_3 - \frac{3}{2} \,\omega_2 \,\omega_1 + \frac{9}{8} \,\omega_1^3.$$

There are eleven trees in the collection

$$\bigcup_{\overline{n} \in C(3)} \mathcal{T}_4(\overline{n}) = \{ \mathbf{t}_j : j \in J \}, \quad J = \{1, 3, 6, 9, 10, 15, 16, 17, 24, 26 \},$$

where the right-hand side refers to trees in Fig. 6. The reader can check that

$$w_4(\mathbf{t}_1) = \frac{1}{2}$$

$$w_4(\mathbf{t}_j) = -\frac{3}{8}, \quad j \in \{3, 6\}$$

$$w_4(\mathbf{t}_j) = -\frac{1}{8}, \quad j \in \{9, 10\}$$

$$w_4(\mathbf{t}_j) = \frac{3}{32}, \quad j \in \{15, 17, 24, 26\}$$

$$w_4(\mathbf{t}_j) = \frac{3}{16}, \quad j \in \{16, 25\}$$

which gives $\phi_4((3)) = 1/2$, $\phi_4((2,1)) + \phi_4((1,2)) = w_4(\mathbf{t}_3) + w_4(\mathbf{t}_6) = -3/4$, $\phi_4((1,1,1)) = \sum_{j \in J \setminus \{1,3,6\}} w_4(\mathbf{t}_j) = 1/2$, hence

$$\alpha_3 = \sum_{\overline{n} \in C(3)} \phi_4(\overline{n}) \,\omega(\overline{n}) = \frac{1}{2} \,\omega_3 - \frac{3}{4} \,\omega_2 \,\omega_1 + \frac{1}{2} \,\omega_1^3.$$

Asymptotics 5

We remind the reader that throughout this work we keep the hypotheses stated at the beginning of the Introduction. Recall also that in subsection 2.1 we defined $\mathcal{P}(n,k,i)$ as the collection of all paths γ on \mathcal{G} satisfying $1 \leq \min(\gamma) \leq \max(\gamma) \leq n$ and having initial point (0,i) and ending point (k,i).

Lemma 5.1. Let $m \ge 1$ and $n \ge 1 + 2m$ be fixed. For each i satisfying $1 + m \le i \le n - m$, the map $\gamma \mapsto \gamma - i$ is a bijection from $\mathcal{P}(n, 2m, i)$ onto \mathcal{P}_m , where \mathcal{P}_m is the collection of all generalized Dyck paths of length 2m. Similarly, the map $\gamma \mapsto \gamma - 1$ is a bijection from $\mathcal{P}(n,2m,1)$ onto \mathcal{D}_m , where \mathcal{D}_m is the collection of all Dyck paths of length 2m. We have

$$\omega_{m} = \sum_{\gamma \in \mathcal{P}(n,2m,i)} \mathbb{E}(w(\gamma)), \qquad 1 + m \le i \le n - m.$$

$$\alpha_{m} = \sum_{\gamma \in \mathcal{P}(n,2m,1)} \mathbb{E}(w(\gamma)).$$

$$(5.1)$$

$$\alpha_m = \sum_{\gamma \in \mathcal{P}(n, 2m, 1)} \mathbb{E}(w(\gamma)). \tag{5.2}$$

Proof. Assume that $m \geq 1$, $n \geq 1 + 2m$ and $1 + m \leq i \leq n - m$. Recall that any path $\gamma \in \mathcal{P}(n, 2m, i)$ has m up steps and m down steps. The restrictions on the initial height i allow to have the m up steps in any position (equivalently the m down steps in any position). For example, the first m edges could be down steps and all subsequent edges up steps (this is not possible if i < 1 + m). It then follows that the map $\gamma \mapsto \gamma - i$ is a bijection from $\mathcal{P}(n,2m,i)$ onto \mathcal{P}_m . Moreover, since the random variables $(a_n)_{n\in\mathbb{Z}}$ are independent and identically distributed, we have

$$\mathbb{E}(w(\gamma)) = \mathbb{E}(w(\gamma - i)), \quad \text{for all } \gamma \in \mathcal{P}(n, 2m, i).$$

Hence, in view of (2.12) and (3.2),

$$\sum_{\gamma \in \mathcal{P}(n,2m,i)} \mathbb{E}(w(\gamma)) = \sum_{\gamma \in \mathcal{P}(n,2m,i)} \mathbb{E}(w(\gamma-i)) = \sum_{\gamma \in \mathcal{P}_m} \mathbb{E}(w(\gamma)) = \omega_m,$$

which establishes (5.1).

If $n \geq m+1$, then the map $\gamma \mapsto \gamma - 1$ is clearly a bijection from $\mathcal{P}(n, 2m, 1)$ onto \mathcal{D}_m , and (5.2) follows from (2.13) and (3.1).

Theorem 5.2. Let $k \in \mathbb{Z}_{\geq 0}$ be fixed, and let H_n be the tridiagonal matrix defined in (1.4).

$$\lim_{n \to \infty} \frac{1}{n} \mathbb{E}(\operatorname{Tr}(H_n^k)) = \begin{cases} 0, & \text{if } k \text{ is odd,} \\ \omega_{k/2}, & \text{if } k \text{ is even,} \end{cases}$$
 (5.3)

$$\lim_{n \to \infty} \mathbb{E}(H_n^k(1, 1)) = \begin{cases} 0, & \text{if } k \text{ is odd,} \\ \alpha_{k/2}, & \text{if } k \text{ is even.} \end{cases}$$
 (5.4)

Proof. If k is odd then the result follows from (2.10). Suppose now that $k=2m, m\geq 1$. According to (2.7), we have

$$\frac{1}{n}\mathbb{E}(\operatorname{Tr}(H_n^{2m})) = \frac{1}{n}\sum_{i=1}^n \sum_{\gamma \in \mathcal{P}(n,2m,i)} \mathbb{E}(w(\gamma)).$$

If $n \geq 1 + 2m$, then

$$\sum_{\gamma \in \mathcal{P}(n,2m,i)} \mathbb{E}(w(\gamma)) = \omega_m, \qquad 1 + m \le i \le n - m,$$

and for each $1 \leq i \leq n$, the expression $\sum_{\gamma \in \mathcal{P}(n,2m,i)} \mathbb{E}(w(\gamma))$ is a constant that only depends on m (not on n). Therefore

$$\frac{1}{n}\mathbb{E}(\operatorname{Tr}(H_n^k)) = \frac{n-2m}{n}\omega_m + o(1), \quad n \to \infty,$$

and (5.3) follows.

In virtue of (2.8) and (5.2), for $n \ge 2m + 1$,

$$\mathbb{E}(H_n^{2m}(1,1)) = \sum_{\gamma \in \mathcal{P}(n,2m,1)} \mathbb{E}(w(\gamma)) = \alpha_m,$$

hence (5.4) follows.

Let σ_n and τ_n be the discrete random measures indicated in (1.5) and (1.8). We consider the averages $\mathbb{E}\sigma_n$ and $\mathbb{E}\tau_n$, which are the measures satisfying the duality identities

$$\int f d\mathbb{E}\sigma_n = \mathbb{E} \int f d\sigma_n,$$
$$\int f d\mathbb{E}\tau_n = \mathbb{E} \int f d\tau_n,$$

for all f in the space $C_b(\mathbb{R})$ of all real-valued bounded continuous functions on \mathbb{R} .

Corollary 5.3. Assume there exist probability measures σ and τ on \mathbb{R} with moments of all orders finite, such that for all $k \in \mathbb{Z}_{>0}$,

$$\int x^k d\sigma(x) = \begin{cases} 0, & \text{if } k \text{ is odd,} \\ \omega_{k/2}, & \text{if } k \text{ is even,} \end{cases}$$
$$\int x^k d\tau(x) = \begin{cases} 0, & \text{if } k \text{ is odd,} \\ \alpha_{k/2}, & \text{if } k \text{ is even.} \end{cases}$$

Assume further that the measures σ and τ are uniquely determined by their moments. Then, the sequences $(\mathbb{E}\sigma_n)_{n=1}^{\infty}$ and $(\mathbb{E}\tau_n)_{n=1}^{\infty}$ converge weakly to σ and τ , respectively. That is, for any $f \in C_b(\mathbb{R})$, we have

$$\lim_{n \to \infty} \int f d\mathbb{E}\sigma_n = \int f d\sigma, \tag{5.5}$$

$$\lim_{n \to \infty} \int f d\mathbb{E}\tau_n = \int f d\tau. \tag{5.6}$$

Moreover, these limits also hold for a continuous function f for which there exists a polynomial P such that $|f(x)| \leq P(x)$ for all $x \in \mathbb{R}$.

Proof. Using elementary measure theoretic arguments, the reader can easily check that for each n, the measures $\mathbb{E}\sigma_n$ and $\mathbb{E}\tau_n$ have moments of all orders finite, and

$$\int x^k d\mathbb{E}\sigma_n(x) = \mathbb{E} \int x^k d\sigma_n(x), \qquad k \in \mathbb{Z}_{\geq 0},$$
$$\int x^k d\mathbb{E}\tau_n(x) = \mathbb{E} \int x^k d\tau_n(x), \qquad k \in \mathbb{Z}_{\geq 0}.$$

Hence, combining (1.6)–(1.7) with (5.3)–(5.4), we obtain

$$\lim_{n \to \infty} \int x^k d\mathbb{E}\sigma_n(x) = \int x^k d\sigma(x), \qquad k \in \mathbb{Z}_{\geq 0},$$
$$\lim_{n \to \infty} \int x^k d\mathbb{E}\tau_n(x) = \int x^k d\tau(x), \qquad k \in \mathbb{Z}_{\geq 0}.$$

Thus, (5.5)–(5.6) follows after applying Lemma 6.2. See [4, Lemma 2.1] for a justification of the claim in the case of functions f with polynomial growth.

6 Appendix

Recall that for a formal Laurent series $S(z) \in \mathbb{C}((z^{-1}))$, the symbol $[S]_n$ refers to the coefficient of z^{-n} in the expression of S(z).

Lemma 6.1. Let S(z) be the series

$$S(z) = \sum_{n=0}^{\infty} \frac{s_n}{z^{2n+1}}.$$
 (6.1)

Then the series R(z) given by

$$R(z) = \frac{1}{z - S(z)} \tag{6.2}$$

is also of the form

$$R(z) = \sum_{n=0}^{\infty} \frac{r_n}{z^{2n+1}},\tag{6.3}$$

and we have

$$r_n = \sum_{k=0}^{n} [S^k]_{2n-k}, \qquad n \ge 0.$$
 (6.4)

More generally, for any $k \geq 1$, $m \geq 0$,

$$[R^k]_{2m+k} = \sum_{n=0}^m \binom{n+k-1}{k-1} [S^n]_{2m-n}.$$
 (6.5)

Proof. From (6.2), or equivalently

$$zR(z) - 1 = R(z)S(z),$$

we easily deduce that R(z) is of the form (6.3) and

$$r_0 = 1,$$

$$r_n = \sum_{k=0}^{n-1} s_k \ r_{n-k-1}, \qquad n \ge 1.$$
(6.6)

Now we prove (6.4) by induction.

First, (6.4) for n=0 is simply that $r_0=1$. Assume that (6.4) holds for every $n=0,\ldots,\ell$, and let us prove that this identity is valid for $n=\ell+1$. We have

$$r_{\ell+1} = \sum_{k=0}^{\ell} s_k \ r_{\ell-k} = \sum_{k=0}^{\ell} \sum_{i=0}^{\ell-k} s_k [S^i]_{2\ell-2k-i} = \sum_{i=0}^{\ell} \sum_{k=0}^{\ell-i} s_k [S^i]_{2\ell-2k-i}$$
(6.7)

where in the second equality we used the induction hypothesis. On the other hand, from (6.1) we obtain immediately that the powers of S(z) are of the form

$$S^{i}(z) = \sum_{n=0}^{\infty} \frac{[S^{i}]_{2n+i}}{z^{2n+i}}, \quad i \ge 0,$$

and therefore

$$S^{i+1}(z) = S^{i}(z)S(z) = \sum_{n=0}^{\infty} \frac{[S^{i}]_{2n+i}}{z^{2n+i}} \sum_{k=0}^{\infty} \frac{s_{k}}{z^{2k+1}},$$

which gives the relations

$$[S^{i+1}]_{2n+i+1} = \sum_{k=0}^{n} s_k [S^i]_{2n+i-2k}, \qquad i, n \ge 0.$$
(6.8)

Applying (6.7) and (6.8) for $n = \ell - i$, we get

$$r_{\ell+1} = \sum_{i=0}^{\ell} \sum_{k=0}^{\ell-i} s_k [S^i]_{2\ell-2k-i} = \sum_{i=0}^{\ell} [S^{i+1}]_{2\ell+1-i} = \sum_{k=0}^{\ell+1} [S^k]_{2(\ell+1)-k}$$

where in the last equality we used the fact that $[S^0]_{2\ell+2} = 0$, and this concludes the proof of (6.4).

Finally, we prove (6.5), again by induction. This identity for k = 1 is precisely (6.4). Assume that (6.5) holds and let us prove that

$$[R^{k+1}]_{2m+k+1} = \sum_{n=0}^{m} {n+k \choose k} [S^n]_{2m-n}.$$
 (6.9)

Making use of (6.8) (applied to R), (6.4) and (6.5), we obtain

$$[R^{k+1}]_{2m+k+1} = \sum_{j=0}^{m} r_j [R^k]_{2(m-j)+k}$$

$$= \sum_{j=0}^{m} \sum_{\ell=0}^{j} \sum_{n=0}^{m-j} \binom{n+k-1}{k-1} [S^\ell]_{2j-\ell} [S^n]_{2(m-j)-n}$$

$$= \sum_{\ell=0}^{m} \sum_{n=0}^{m-\ell} \sum_{j=\ell}^{m-n} \binom{n+k-1}{k-1} [S^\ell]_{2j-\ell} [S^n]_{2(m-j)-n},$$

where in the last equality we transposed the summations twice. This and the relation

$$[S^{\ell+n}]_{2m-(\ell+n)} = \sum_{j=\ell}^{m-n} [S^{\ell}]_{2j-\ell} [S^n]_{2(m-j)-n}$$

give

$$[R^{k+1}]_{2m+k+1} = \sum_{\ell=0}^{m} \sum_{n=0}^{m-\ell} \binom{n+k-1}{k-1} [S^{\ell+n}]_{2m-(\ell+n)}.$$

Considering the different ways we can add ℓ and n to obtain $t = \ell + n$, we deduce from the previous relation that

$$[R^{k+1}]_{2m+k+1} = \sum_{t=0}^{m} \left(\sum_{n=0}^{t} \binom{n+k-1}{k-1} \right) [S^t]_{2m-t} = \sum_{t=0}^{m} \binom{t+k}{k} [S^t]_{2m-t},$$

which proves (6.9).

The following is a well-known result in the theory of moment problems. For a proof, see [2, Theorem 30.2].

Lemma 6.2. Let $(\mu_n)_{n=1}^{\infty}$ and μ be probability measures on \mathbb{R} with moments of all orders finite, and suppose that for each $k \in \mathbb{Z}_{\geq 0}$,

$$\lim_{n \to \infty} \int x^k d\mu_n(x) = \int x^k d\mu(x).$$

Assume further that the measure μ is uniquely determined by its moments. Then μ_n converges weakly to μ , i.e., for any $f \in C_b(\mathbb{R})$ we have

$$\lim_{n \to \infty} \int f d\mu_n = \int f d\mu.$$
