

RATIONAL PICARD GROUP OF MODULI OF POINTED HYPERELLIPTIC CURVES

ABSTRACT. We determine the rational divisor class group of the moduli spaces of smooth pointed hyperelliptic curves and of their Deligne-Mumford compactification, over the field of complex numbers.

1. INTRODUCTION

The moduli stack \mathcal{M}_g of smooth curves of fixed genus $g \geq 2$, together with its Deligne-Mumford compactification [10], are fundamental objects in algebraic geometry. In moduli theory, an important role is also played by the pointed versions $\mathcal{M}_{g,n}$ and $\overline{\mathcal{M}}_{g,n}$. Many geometric properties of these moduli stacks and of their coarse moduli spaces have been established. The irreducibility of $\mathcal{M}_{g,n}$ and $\overline{\mathcal{M}}_{g,n}$ was proved in the seminal paper of Deligne and Mumford [10], and the projectivity of the coarse moduli space of $\overline{\mathcal{M}}_{g,n}$ by Knudsen in [21], [22] and [23].

Of great interest is the tautological Chow ring of \mathcal{M}_g , whose study was initiated by Mumford [28]. Relations between classes in this ring immediately inform the enumerative geometry of families of curves. In particular, over the field of complex numbers, the divisor class group (i.e. the Picard group) of $\mathcal{M}_{g,n}$ and $\overline{\mathcal{M}}_{g,n}$ is well understood. When $g \geq 3$, Harer proved that $\text{Pic}(\overline{\mathcal{M}}_{g,n})$ is a free abelian group on $n + 1$ generators in [16], and Mumford showed that $\text{Pic}(\mathcal{M}_{g,n})$ and $\text{Pic}(\overline{\mathcal{M}}_{g,n})$ are free abelian groups in [27]. In [2], Arbarello and Cornalba provided explicit bases for $\text{Pic}(\mathcal{M}_{g,n})$ and $\text{Pic}(\overline{\mathcal{M}}_{g,n})$, when $g \geq 3$.

The stack \mathcal{H}_g of smooth hyperelliptic curves of fixed genus $g \geq 2$, its compactification $\overline{\mathcal{H}}_g$, and their pointed generalizations $\mathcal{H}_{g,n}$ and $\overline{\mathcal{H}}_{g,n}$ are also basic objects of study in moduli theory, but less is known about them compared to $\mathcal{M}_{g,n}$ and $\overline{\mathcal{M}}_{g,n}$. In [4], Arsie and Vistoli described \mathcal{H}_g as a moduli stack parametrizing double covers of the projective line. They used this description to show that $\text{Pic}(\mathcal{H}_g)$ is finite cyclic, of order $8g + 4$ for odd g , and $4g + 2$ for even g . In [15], Gorchinskiy and Viviani produced geometrically meaningful generators for $\text{Pic}(\mathcal{H}_g)$. A presentation of $\text{Pic}(\overline{\mathcal{H}}_g)$ via generators and relations was given by Cornalba in [7]. As a consequence of these results, $\text{Pic}(\mathcal{H}_g)_{\mathbb{Q}} = 0$ and $\text{Pic}(\overline{\mathcal{H}}_g)_{\mathbb{Q}}$ has a basis consisting of all the boundary divisors.

In this article, we determine the rational divisor class group of the moduli of smooth n -pointed hyperelliptic curves $\mathcal{H}_{g,n}$, and of its Deligne-Mumford compactification $\overline{\mathcal{H}}_{g,n}$, for every $n \geq 1$ (see Section 2 for the definitions). We work over the field of complex numbers.

Theorem 1.1. *For every $g \geq 2$ and $n \geq 1$, we have:*

- (a) $\text{Pic}(\mathcal{H}_{g,n})_{\mathbb{Q}} \cong \text{Cl}(\mathcal{H}_{g,n})_{\mathbb{Q}}$ has a basis given by ψ -classes;
- (b) $\text{Cl}(\overline{\mathcal{H}}_{g,n})_{\mathbb{Q}}$ has a basis given by ψ -classes and all the boundary divisors.

As we discuss in Proposition 2.2, the stack $\mathcal{H}_{g,n}$ is smooth, hence $\text{Pic}(\mathcal{H}_{g,n})_{\mathbb{Q}} \cong \text{Cl}(\mathcal{H}_{g,n})_{\mathbb{Q}}$. We do not know if $\overline{\mathcal{H}}_{g,n}$ is smooth, but we show in Proposition 5.4(b) that it is smooth in codimension 1. The question of the smoothness of $\overline{\mathcal{H}}_{g,n}$ appears to be open.

Recall the definition of ψ -classes ψ_1, \dots, ψ_n in $\text{Pic}(\overline{\mathcal{M}}_{g,n}) \cong \text{Cl}(\overline{\mathcal{M}}_{g,n})$: denoted by \mathcal{L}_i the line bundle on $\overline{\mathcal{M}}_{g,n}$ which to a family $X \rightarrow S$ in $\overline{\mathcal{M}}_{g,n}(S)$ with sections $\sigma_1, \dots, \sigma_n$ associates the line bundle $\sigma_i^* \omega_{X/S}$, ψ_i is defined as the class of \mathcal{L}_i in $\text{Pic}(\overline{\mathcal{M}}_{g,n})$; see [3, §XIII.2].

The strategy of the proof is as follows. Using the Leray spectral sequence for the forgetful morphism $\mathcal{H}_{g,n} \rightarrow \mathcal{H}_g$ together with results of Totaro [34] on cohomology of configuration spaces, we show that $H^1(\mathcal{H}_{g,n}, \mathbb{Q}) = 0$ and that $H^2(\mathcal{H}_{g,n}, \mathbb{Q})$ has a basis consisting of all ψ -classes. The exponential sequence for $\mathcal{H}_{g,n}$ gives (a), from which it immediately follows that $\text{Cl}(\overline{\mathcal{H}}_{g,n})_{\mathbb{Q}}$ is generated by ψ -classes and irreducible boundary divisors. We then enumerate the irreducible boundary divisors and show that this set of generators is linearly independent via degree computations on suitable families of curves.

2. PRELIMINARIES ON MODULI STACKS OF CURVES

For every $g, n \geq 0$ such that $2g - 2 + n > 0$, we denote by $\mathcal{M}_{g,n}$ the moduli stack of smooth n -pointed projective curves of genus g , and by $\overline{\mathcal{M}}_{g,n}$ its Deligne-Mumford compactification. We also let $\mathcal{M}_{g,n}^{rt}$ be the moduli stack of stable curves with rational tails. By definition, it is the inverse image of \mathcal{M}_g under the forgetful morphism $\overline{\mathcal{M}}_{g,n} \rightarrow \overline{\mathcal{M}}_g$. When C is a smooth curve of genus g , we will write $F(C, n)$ for the ordered configuration space of n distinct points in C :

$$F(C, n) := \{(z_1, \dots, z_n) \in C^n : z_i \neq z_j \text{ for every } i \neq j\}.$$

Lemma 2.1. *Let $g, n \geq 0$ such that $2g - 2 + n > 0$.*

- (a) *The forgetful morphism $\overline{\mathcal{M}}_{g,n} \rightarrow \overline{\mathcal{M}}_g$ is proper, flat, and has connected fibers of dimension n .*
- (b) *If C is a smooth curve of genus g , the fiber of $\mathcal{M}_{g,n} \rightarrow \mathcal{M}_g$ at $[C]$ is isomorphic to $F(C, n)$, and the fiber of $\overline{\mathcal{M}}_{g,n} \rightarrow \overline{\mathcal{M}}_g$ at $[C]$ is isomorphic to the Fulton-MacPherson compactification of $F(C, n)$.*
- (c) *The forgetful morphism $\mathcal{M}_{g,n}^{rt} \rightarrow \mathcal{M}_g$ is proper, smooth and has irreducible fibers.*
- (d) *The forgetful morphism $\mathcal{M}_{g,n} \rightarrow \mathcal{M}_g$ is smooth.*

Proof. Let $\pi : \mathcal{Z}_{g,n} \rightarrow \overline{\mathcal{M}}_{g,n}$ be the universal curve over $\overline{\mathcal{M}}_{g,n}$. By definition, a morphism $S \rightarrow \overline{\mathcal{M}}_{g,n}$ corresponds to a family of n -pointed stable curves over S , together with an extra section that is allowed to pass through the nodes; see [22, Definition 1.2]. For every morphism $f : S \rightarrow \overline{\mathcal{M}}_{g,n}$, the pullback of $\mathcal{Z}_{g,n} \rightarrow \overline{\mathcal{M}}_{g,n}$ along f is the family of n -pointed stable curves over S corresponding to f . It follows that $\mathcal{Z}_{g,n} \rightarrow \overline{\mathcal{M}}_{g,n}$ is proper, flat and has connected fibers of dimension 1, and that its restriction to $\pi^{-1}(\mathcal{M}_{g,n})$ is smooth.

Knudsen [22] constructed a contraction morphism $c : \overline{\mathcal{M}}_{g,n+1} \rightarrow \mathcal{Z}_{g,n}$ and a stabilization morphism $s : \mathcal{Z}_{g,n} \rightarrow \overline{\mathcal{M}}_{g,n+1}$ which are compatible with π and the morphism $\mathcal{M}_{g,n+1} \rightarrow \mathcal{M}_{g,n}$ which forgets the last section. He then proved that c and s are inverse to each other in [22, Corollary 2.6]. The forgetful morphism $\overline{\mathcal{M}}_{g,n+1} \rightarrow \overline{\mathcal{M}}_{g,n}$ is defined as the composition $\pi \circ c$.

(a) We may factor the morphism $\overline{\mathcal{M}}_{g,n} \rightarrow \overline{\mathcal{M}}_g$ as a composition

$$\overline{\mathcal{M}}_{g,n} \rightarrow \overline{\mathcal{M}}_{g,n-1} \rightarrow \cdots \rightarrow \overline{\mathcal{M}}_{g,1} \rightarrow \overline{\mathcal{M}}_g.$$

By the previous discussion, every intermediate map is proper, flat, and has connected fibers of dimension 1. It follows immediately that $\overline{\mathcal{M}}_{g,n} \rightarrow \overline{\mathcal{M}}_g$ is proper, flat and has connected fibers of dimension n .

(b) Let $\mathcal{E}_{g,n} \rightarrow \mathcal{M}_g$ be the n -fold fibered product of the forgetful morphism $\mathcal{M}_{g,1} \rightarrow \mathcal{M}_g$. The fiber of $\mathcal{E}_{g,n} \rightarrow \mathcal{M}_g$ at $[C]$ is isomorphic to C^n . We can view $\mathcal{E}_{g,n}$ as the stack parametrizing smooth curves of genus g with n sections that are allowed to cross each other. We have an open embedding $\mathcal{M}_{g,n} \hookrightarrow \mathcal{E}_{g,n}$ over \mathcal{M}_g , as the locus where the sections are disjoint. It follows that the fiber of $\mathcal{M}_{g,n} \rightarrow \mathcal{M}_g$ at $[C]$ is the complement of the fat diagonal in C^n , i.e. it is $F(C, n)$.

In [13, p. 194-195], the Fulton-MacPherson compactification of $F(C, n)$ is described as the moduli space of all configurations of n distinct smooth points on C with trees of \mathbb{P}^1 such that the resulting pointed nodal curve has finite automorphism group, up to projective equivalence on the rational curves. These are exactly the configurations that are parametrized by the fiber of the forgetful morphism $\overline{\mathcal{M}}_{g,n} \rightarrow \overline{\mathcal{M}}_g$ at $[C]$; see also [30, p. 195].

(c) The morphism $\mathcal{M}_{g,n}^{rt} \rightarrow \mathcal{M}_g$ is flat because it is the pullback of $\overline{\mathcal{M}}_{g,n} \rightarrow \overline{\mathcal{M}}_g$ along the open embedding $\mathcal{M}_g \hookrightarrow \overline{\mathcal{M}}_g$. By (b) its fibers are the Fulton-MacPherson compactifications, which are smooth.

(d) This follows immediately from (c). □

Let $g \geq 2$ be an integer. A *hyperelliptic curve* C of genus g is a smooth complete curve admitting a morphism $C \rightarrow \mathbb{P}^1$ of degree 2. Equivalently, there exists an involution σ of C with quotient the projective line. It is a classical fact that such σ is unique: it is called the *hyperelliptic involution* of C .

Let \mathcal{H}_g be the closed substack of \mathcal{M}_g , with reduced structure, parametrizing hyperelliptic curves of genus g . Both \mathcal{H}_g and its Zariski closure $\overline{\mathcal{H}}_g$ in $\overline{\mathcal{M}}_g$ are smooth and irreducible of dimension $2g - 1$; see [3, Lemma XI.6.15, Exercise XII.C-1], and [4][Corollary 4.7] for a presentation of \mathcal{H}_g as a quotient stack. A stable curve C is defined to be *hyperelliptic* if it admits an involution σ with only isolated fixed points and such that the quotient $C / \langle \sigma \rangle$ is a nodal curve of genus 0; see [3, p. 101]. Such an involution is again unique and is called the *hyperelliptic involution*; see [3, Lemma X.3.5]. By [3, Lemma XI.6.14], the points of $\overline{\mathcal{H}}_g$ correspond exactly to stable hyperelliptic curves.

We denote by Γ_g the hyperelliptic mapping class group. It is a standard fact that \mathcal{H}_g may be constructed as an orbifold quotient of a contractible analytic subspace of the Teichmüller space \mathcal{T}_g by the action of Γ_g ; see [14] or [24, §1, §3.2]. Therefore, \mathcal{H}_g is an Eilenberg-MacLane space $K(\Gamma_g, 1)$, in the sense of orbifolds.

The stack $\mathcal{H}_{g,n}$ parametrizes smooth hyperelliptic curves of genus g , together with n distinct marked points. We denote by $H_{g,n}$ the coarse moduli space of $\mathcal{H}_{g,n}$. We define the stack $\overline{\mathcal{H}}_{g,n}$ as the inverse image of $\overline{\mathcal{H}}_g$ under the forgetful morphism $\overline{\mathcal{M}}_{g,n} \rightarrow \overline{\mathcal{M}}_g$, with the reduced structure. Recall that the definition of the forgetful morphism involves a contraction procedure; see [3, §X.6]. In other words, an n -pointed stable curve of genus g belongs to $\overline{\mathcal{H}}_{g,n}$ if and only if, after forgetting its markings and contracting its unstable components, one obtains a stable hyperelliptic curve. We denote by $H_{g,n}$ the coarse moduli space of $\overline{\mathcal{H}}_{g,n}$.

Let $\mathcal{H}_{g,n}^{rt}$ be the moduli stack of hyperelliptic curves with rational tails. It is the inverse image of \mathcal{H}_g under the forgetful morphism $\overline{\mathcal{M}}_{g,n} \rightarrow \overline{\mathcal{M}}_g$.

Proposition 2.2. *Let $g \geq 2$ and $n \geq 0$.*

- (a) *The forgetful morphism $\overline{\mathcal{H}}_{g,n} \rightarrow \overline{\mathcal{H}}_g$ is universally open and has connected fibers of dimension n .*
- (b) *If C is a smooth hyperelliptic curve of genus g , the fiber of $\mathcal{H}_{g,n} \rightarrow \mathcal{H}_g$ at $[C] \in \mathcal{H}_g$ is isomorphic to $F(C, n)$, and the fiber of $\overline{\mathcal{H}}_{g,n} \rightarrow \overline{\mathcal{H}}_g$ at $[C]$ is the Fulton-MacPherson compactification of $F(C, n)$.*
- (c) *The forgetful morphism $\mathcal{H}_{g,n}^{rt} \rightarrow \mathcal{H}_g$ is proper, smooth, and has irreducible fibers.*
- (d) *The forgetful morphism $\mathcal{H}_{g,n} \rightarrow \mathcal{H}_g$ is smooth.*
- (e) *The stacks $\mathcal{H}_{g,n}^{rt}$ and $\mathcal{H}_{g,n}$ are smooth and irreducible.*
- (f) *The stack $\overline{\mathcal{H}}_{g,n}$ is irreducible, and it is the closure of $\mathcal{H}_{g,n}$ inside $\overline{\mathcal{M}}_{g,n}$.*

Proof. (a) By Lemma 2.1(a), the forgetful morphism $\overline{\mathcal{M}}_{g,n} \rightarrow \overline{\mathcal{M}}_g$ is flat, hence universally open. It follows that $\overline{\mathcal{H}}_{g,n} \rightarrow \overline{\mathcal{H}}_g$ is open (openness is a topological property, so it holds even if we have given $\overline{\mathcal{H}}_{g,n}$ the reduced structure), and has connected fibers of dimension n .

(b) This follows immediately from Lemma 2.1(b).

(c) The morphism $\mathcal{H}_{g,n}^{rt} \rightarrow \mathcal{H}_g$ is the base change of $\mathcal{M}_{g,n}^{rt} \rightarrow \mathcal{M}_g$ along the inclusion $\mathcal{H}_g \hookrightarrow \mathcal{M}_g$, hence it is smooth by Lemma 2.1(c).

(d) This follows immediately from (c).

(e) As $\mathcal{H}_{g,n}$ is open in $\mathcal{H}_{g,n}^{rt}$, it suffices to prove the claim for $\mathcal{H}_{g,n}^{rt}$. We know that \mathcal{H}_g is smooth and irreducible. By (a), the forgetful morphism $\mathcal{H}_{g,n}^{rt} \rightarrow \mathcal{H}_g$ is open, and by (b) the fibers of $\overline{\mathcal{H}}_{g,n} \rightarrow \overline{\mathcal{H}}_g$ are irreducible. The conclusion follows from [31, 004Z].

(f) By (e) it is enough to show that $\mathcal{H}_{g,n}$ is dense in $\overline{\mathcal{H}}_{g,n}$. Let $\mathcal{U} \subseteq \overline{\mathcal{H}}_{g,n}$ be a non-empty open substack. By (a), the image of \mathcal{U} under $\overline{\mathcal{H}}_{g,n} \rightarrow \overline{\mathcal{H}}_g$ is open and non-empty, hence it intersects \mathcal{H}_g . It follows that \mathcal{U} intersects $\mathcal{H}_{g,n}^{rt}$. By (e), $\mathcal{H}_{g,n}^{rt}$ is irreducible. Since $\mathcal{H}_{g,n}$ is open in $\mathcal{H}_{g,n}^{rt}$, we conclude that \mathcal{U} intersects $\mathcal{H}_{g,n}$ non-trivially. This shows that $\mathcal{H}_{g,n}$ is dense in $\overline{\mathcal{H}}_{g,n}$, as desired. \square

If \mathcal{X} is a topological stack, the singular (Betti) homology and cohomology of \mathcal{X} are defined; see [5, Definition 33]. We briefly sketch the definition, referring the reader to [5, p. 22, p. 27-28] for the details. One fixes a groupoid presentation of \mathcal{X} , takes the associated simplicial nerve, and constructs a double complex by applying the singular chain complex functor in each degree. The total complex $C_\bullet(\mathcal{X})$ associated to this double complex is, by definition, the singular chain complex associated to the groupoid presentation. By definition, the homology of \mathcal{X} is the homology of $C_\bullet(\mathcal{X})$, and the cohomology of \mathcal{X} is the homology of the dual complex of $C_\bullet(\mathcal{X})$.

In this paper, we will be exclusively interested in cohomology with rational coefficients of \mathcal{X} , which we denote by $H^\bullet(\mathcal{X}, \mathbb{Q})$.

Proposition 2.3. *Let \mathcal{X} be a Deligne-Mumford stack with coarse moduli space $\pi : \mathcal{X} \rightarrow X$.*

- (a) *The induced map $\pi^* : H^\bullet(X, \mathbb{Q}) \rightarrow H^\bullet(\mathcal{X}, \mathbb{Q})$ is an isomorphism.*
- (b) *If \mathcal{X} is pure-dimensional, the induced map $\pi^* : \text{Cl}(X)_{\mathbb{Q}} \rightarrow \text{Cl}(\mathcal{X})_{\mathbb{Q}}$ is an isomorphism.*

(c) Let \mathcal{X} be one of $\mathcal{X} = \mathcal{M}_{g,n}, \overline{\mathcal{M}}_{g,n}, \mathcal{H}_{g,n}$. Then the induced maps $\pi^* : \text{Pic}(X)_{\mathbb{Q}} \rightarrow \text{Pic}(\mathcal{X})_{\mathbb{Q}}$, are isomorphisms.

Proof. (a) See [5, Proposition 36].

(b) This is a particular case of [35, Proposition 6.1].

(c) See [3, Lemma XIII.6.6] for a proof in the case of $\mathcal{M}_{g,n}$ and $\overline{\mathcal{M}}_{g,n}$, the case of $\mathcal{H}_{g,n}$ being entirely analogous (another reference is [17, Proposition 3.88]). \square

3. COHOMOLOGY OF FIBERS OF THE FORGETFUL MORPHISM

We will understand the low dimensional cohomology of $\mathcal{H}_{g,n}$ by relating it to the cohomology of \mathcal{H}_g via the Leray spectral sequence for the forgetful morphism $\pi_n : \mathcal{H}_{g,n} \rightarrow \mathcal{H}_g$. In order to do so, we must first understand the cohomology of the fibers of π_n . By Proposition 2.2, the map π_n is smooth, and for every point $[C] \in \mathcal{H}_g$, the fiber $\pi_n^{-1}([C])$ is the ordered configuration space $F(C, n)$.

Let $n, r \geq 0$ and X be an oriented manifold of dimension r . Let $\text{pr}_i : X^n \rightarrow X$ be the projection onto the i -th factor, and $\text{pr}_{ij} : X^n \rightarrow X^2$ be the projection onto the i -th and j -th factors. Denote by Δ the class of the Poincaré dual of the diagonal in $H^r(X^2, \mathbb{Q})$. Let $(E_X(n), d)$ be the differential bigraded commutative algebra given by $H^\bullet(X^n, \mathbb{Q})[G_{ij}]_{1 \leq i, j \leq n}$ where elements of $H^i(X^n, \mathbb{Q})$ have degree $(i, 0)$ and the variables G_{ij} have degree $(0, r-1)$, subject to the following relations:

- $G_{ii} = 0$,
- $G_{ij}^2 = 0$,
- $G_{ij} = (-1)^r G_{ji}$,
- $G_{ij}G_{ik} + G_{jk}G_{ji} + G_{ki}G_{kj} = 0$,
- $G_{ij}(\text{pr}_i^* \alpha - \text{pr}_j^* \alpha) = 0$,

for any i, j and for any $\alpha \in H^\bullet(X^n, \mathbb{Q})$. The differential is defined by $d(G_{ij}) = \text{pr}_{ij}^*(\Delta)$ and $d(\alpha) = 0$ for $\alpha \in H^\bullet(X^n, \mathbb{Q})$.

Proposition 3.1. (Totaro) *Let X be an oriented manifold of dimension r . Then the differential bigraded algebra $E_X(n)$ is isomorphic to the E_r -page of the Leray spectral sequence for $F(X, n) \hookrightarrow X^n$. The E_r -page is the first page of the spectral sequence with non-trivial differentials.*

Proof. [34, Theorem 1, Theorem 2]. \square

Proposition 3.2. (Totaro) *If X is a smooth projective variety over the complex numbers, every differential in the Leray spectral sequence for $F(X, n) \hookrightarrow X^n$ except d_r vanishes, and the rational cohomology of $F(X, n)$ is the cohomology of $(E_X(n), d)$.*

Proof. [34, Theorem 3]. \square

We will apply these results to the case where $X = C$ is a smooth hyperelliptic curve of genus g (so $r = 2$). By the Künneth Formula:

$$(3.1) \quad H^2(C^n, \mathbb{Q}) \cong H^2(C, \mathbb{Q})^{\oplus n} \oplus (H^1(C, \mathbb{Q})^{\otimes 2})^{\oplus \frac{n(n-1)}{2}}.$$

Fix a point p of C . For $i = 1, \dots, n$, let $\gamma_i := \text{pr}_i^*([p])$, where $[p] \in H^2(C, \mathbb{Q})$ is the Poincaré dual of the class of p in $H_0(C, \mathbb{Q})$. In (3.1), the homomorphisms $H^2(C, \mathbb{Q}) \hookrightarrow H^2(C^n, \mathbb{Q})$ are induced by the projections $\text{pr}_i : C^n \rightarrow C$. It follows that under the isomorphism (3.1), γ_i is a generator for the i -th summand $H^2(C, \mathbb{Q})$ inside $H^2(C^n, \mathbb{Q})$.

Denote by Δ' the projection to $H^1(C, \mathbb{Q})^{\otimes 2}$ of Δ with respect to the Künneth decomposition

$$(3.2) \quad H^2(C^2, \mathbb{Q}) \cong H^0(C, \mathbb{Q})^{\oplus 2} \oplus H^1(C, \mathbb{Q})^{\otimes 2},$$

and set $\gamma_{ij} := \text{pr}_{ij}^*(\Delta')$. The inclusions $H^1(C, \mathbb{Q})^{\otimes 2} \hookrightarrow H^2(C^n, \mathbb{Q})$ factor as

$$H^1(C, \mathbb{Q})^{\otimes 2} \rightarrow H^2(C^2, \mathbb{Q}) \rightarrow H^2(C^n, \mathbb{Q}),$$

where the maps on the left are cross products, and the maps on the right are induced by the projections $\text{pr}_{ij} : C^n \rightarrow C^2$; see [18, Appendix 3.3.B].

Lemma 3.3. (a) *The γ_i and the γ_{ij} generate the same subspace as the γ_i and $\text{pr}_{ij}^*(\Delta)$.*
 (b) *The γ_i and the $\text{pr}_{ij}^*(\Delta)$ (for $i < j$) are linearly independent.*

Proof. (a) With respect to (3.2) we have $\Delta - \Delta' \in H^2(C, \mathbb{Q})^{\oplus 2}$, therefore $\text{pr}_{ij}^*(\Delta) - \gamma_{ij}$ is a linear combination of γ_i and γ_j .

(b) By what we have said above, under the isomorphism (3.1) each summand $H^2(C, \mathbb{Q})$ contains exactly one of the γ_i , and each $H^1(C, \mathbb{Q})^{\otimes 2}$ contains exactly one of the γ_{ij} , therefore the γ_i and γ_{ij} are linearly independent. Now (b) follows from (a). \square

Lemma 3.4. *Let C be a smooth curve, and consider the Leray spectral sequence for $\iota : F(C, n) \hookrightarrow C^n$.*

- (a) *A basis for the image of $d_2^{0,1}$ is given by the classes $\text{pr}_{ij}^*(\Delta)$ in $H^2(C^n, \mathbb{Q})$, where $1 \leq i < j \leq n$.*
 (b) *The differentials $d_2^{0,1}$ and $d_2^{0,2}$ are injective.*

Proof. By Proposition 3.1, we may identify the E_2 -page of the Leray spectral sequence for ι with $(E_C(n), d)$.

By definition, $E_C(n)^{0,1}$ is the \mathbb{Q} -vector space with basis G_{ij} , where $1 \leq i < j \leq n$ (recall that $G_{ij} = G_{ji}$, since $r = 2$ is even). Moreover, $d_2^{0,1}(G_{ij}) = \text{pr}_{ij}^*(\Delta)$. The G_{ij} (for $i < j$) form a basis of $E_C(n)^{0,1}$, and by Lemma 3.3(b) the $\text{pr}_{ij}^*(\Delta)$ are linearly independent (for $i < j$). We deduce that the differential $d_2^{0,1}$ is injective and that the $\text{pr}_{ij}^*(\Delta)$ form a basis of the image of $d_2^{0,1}$. By Proposition 3.1, this proves (a) and the injectivity of $d_2^{0,1}$.

We now prove that $d_2^{0,2}$ is injective. The vector space $E_C(n)^{0,2}$ has a basis consisting of the $G_{ij}G_{hk}$, where $i < j$, and $i < h < k$, together with the $G_{ij}G_{ik}$, where $i < j$ and $i \neq k$. We identify $E_C(n)^{2,1}$ with $H^2(C^n, \mathbb{Q}) \otimes \langle G_{ij} \rangle_{1 \leq i < j \leq n}$. For every i, j, h, k , we have

$$d_2^{0,2}(G_{ij}G_{hk}) = d_2^{0,1}(G_{ij})G_{hk} - G_{ij}d_2^{0,1}(G_{hk}) = \text{pr}_{ij}^*(\Delta) \otimes G_{hk} - \text{pr}_{hk}^*(\Delta) \otimes G_{ij}.$$

Consider an element $G = \sum a_{ijhk}G_{ij}G_{hk} + \sum b_{ijk}G_{ij}G_{ik}$, where the indices satisfy the conditions above. Fix $p < q$, and consider the projection $G'_{p,q}$ of $d_2^{0,2}(G)$ to the summand $H^2(C^n, \mathbb{Q}) \otimes \langle G_{pq} \rangle \cong H^2(C^n, \mathbb{Q})$. We have

$$(3.3) \quad G'_{p,q} = \sum_{h,k} \epsilon_{pqhk} a_{pqhk} \text{pr}_{hk}^*(\Delta) + \sum_k \epsilon_{pqk} b_{pqk} \text{pr}_{pk}^*(\Delta) \in H^2(C^n, \mathbb{Q}),$$

where $\epsilon_{pqkh}, \epsilon_{pqk} \in \{\pm 1\}$. By Lemma 3.3(b), the $\text{pr}_{uv}^*(\Delta)$ (for $u < v$) are linearly independent. In the first sum of (3.3) we are considering pairs (h, k) such that $p < h < k$, and in the second sum $k < p$. Thus, (3.3) is an irredundant linear

combination of the $\text{pr}_{uv}^*(\Delta)$ (for $u < v$). Assume now that $d_2^{0,2}(G) = 0$. Then $G'_{p,q} = 0$, and so $a_{pqhk} = b_{pk} = 0$. Letting p, q vary, we see that $G = 0$. We conclude that $d_2^{0,2}$ is injective, as desired. \square

A presentation of the hyperelliptic mapping class group Γ_g was given by Birman and Hilden in [6]. There are $2g + 1$ generators $\zeta_1, \dots, \zeta_{2g+1}$. We refer the reader to [32, §2.2] for the statement of the theorem. For the convenience of the reader, we transcribe the description of the images Z_1, \dots, Z_{2g+1} of the generators under the modular representation

$$\rho : \Gamma_g \rightarrow \text{Sp}(2g, \mathbb{Z}).$$

The homomorphism ρ is given by considering the action of Γ_g on $H_1(C, \mathbb{Z})$, in the coordinates given by the standard symplectic basis $a_1, \dots, a_g, b_1, \dots, b_g$ for $H_1(C, \mathbb{Z})$. Let

$$A = \begin{pmatrix} 1 & 1 \\ 0 & 1 \end{pmatrix} \quad B = \begin{pmatrix} 1 & 0 \\ -1 & 1 \end{pmatrix} \quad C = \begin{pmatrix} 1 & 0 & 0 & 0 \\ -1 & 1 & 1 & 0 \\ 0 & 0 & 1 & 0 \\ 1 & 0 & -1 & 1 \end{pmatrix}.$$

Denote by I_m the $m \times m$ identity matrix. Using the standard symplectic basis $a_1, \dots, a_g, b_1, \dots, b_g$ for $H_1(C, \mathbb{Z})$, we can write

$$\begin{aligned} Z_{2l} &= I_{2l-2} \oplus A \oplus I_{2g-2l} \quad (1 \leq l \leq g) \\ Z_1 &= B \oplus I_{2g-2} \\ Z_{2g+1} &= I_{2g-2} \oplus B \\ Z_{2l+1} &= I_{2l-2} \oplus C \oplus I_{2g-2l-2} \quad (1 \leq l \leq g-1) \end{aligned}$$

The group of orientation-preserving diffeomorphisms of C naturally acts on C , so it acts on C^n and on the fat diagonal of C^n , hence on $F(C, n)$ and therefore on $H^\bullet(F(C, n), \mathbb{Q})$. The subgroup of diffeomorphisms that are isotopic to the identity of C acts trivially on $H^\bullet(F(C, n), \mathbb{Q})$, hence we obtain an induced action of the mapping class group on $H^\bullet(F(C, n), \mathbb{Q})$, and a fortiori of its subgroup Γ_g .

Lemma 3.5. *Let Δ' be the projection of the Poincaré dual of the class of the diagonal in $C \times C$ to $H^1(C, \mathbb{Q})^{\otimes 2}$ under the decomposition (3.2). Then the Γ_g -invariant subspace of $H^1(C, \mathbb{Q})^{\otimes 2}$ is exactly the one-dimensional subspace generated by Δ' .*

Proof. Using the standard symplectic basis $a_1, \dots, a_g, b_1, \dots, b_g$ for $H_1(C, \mathbb{Z})$, we may represent an element α of $H_1(C, \mathbb{Q})^{\otimes 2}$ as a square matrix P of size $2g$. In these coordinates, if α is Γ_g -invariant, then P satisfies

$$ZPZ^t = P \text{ for every } Z \in \rho(\Gamma_g).$$

In particular, by considering $Z = Z_i, Z_i^{-1}$, for $i = 1, \dots, 2g + 1$, we see that

$$Z_i P Z_i^t = Z_i^t P Z_i = P, \quad i = 1, \dots, 2g + 1.$$

Let J be the 2×2 matrix

$$J := \begin{pmatrix} 0 & -1 \\ 1 & 0 \end{pmatrix}$$

We now impose the condition $Z_i P Z_i^t = Z_i^t P Z_i = P$ for each i . In principle, it suffices to impose the conditions $Z_i P Z_i^t = P$, however the computations become trickier.




FIGURE 1. E_3 -page of the Leray spectral sequence for $F(C, n) \hookrightarrow C^n$

$i = 2, \dots, 2g$: P is a block diagonal matrix, with g blocks of size 2.

$i = 1$: the first block of P is a multiple of J .

$i = 2g + 1$: the last block of P is a multiple of J .

$i = 2, \dots, 2g - 1$: every block is a multiple of J , and with the same coefficient.

Therefore, the invariants form a one-dimensional vector space, generated by the Poincaré dual of

$$\sum_{i=1}^g a_i \wedge b_i.$$

By [26, Theorem 11.11], this is exactly Δ' . \square

We are ready to prove the main results of this section. They concern the $\text{Aut}(C)$ -invariants and the Γ_g -invariants in $H^\bullet(F(C, n), \mathbb{Q})$.

Proposition 3.6. *Let C be a smooth hyperelliptic curve, let $n \geq 0$, and denote by $\iota : F(C, n) \hookrightarrow C^n$ the natural open embedding.*

- (a) *The pullback $\iota^* : H^1(C^n, \mathbb{Q}) \rightarrow H^1(F(C, n), \mathbb{Q})$ is an isomorphism. Moreover, the natural action of $\text{Aut}(C)$ on $H^1(F(C, n), \mathbb{Q})$ has no non-zero invariants.*
- (b) *The vector space $H^2(C^n, \mathbb{Q})^{\Gamma_g}$ has a basis given by γ_i and $\text{pr}_{ij}^*(\Delta)$ (for $i < j$).*
- (c) *The pullback $\iota^* : H^2(C^n, \mathbb{Q}) \rightarrow H^2(F(C, n), \mathbb{Q})$ induces a surjective map $H^2(C^n, \mathbb{Q})^{\Gamma_g} \rightarrow H^2(F(C, n), \mathbb{Q})^{\Gamma_g}$. Moreover, $\iota^*(\gamma_1), \dots, \iota^*(\gamma_n)$ is a basis for $H^2(F(C, n), \mathbb{Q})^{\Gamma_g}$.*

Proof. By Proposition 3.1, we may identify the Leray spectral sequence for the inclusion $F(C, n) \hookrightarrow C^n$ with $(E_C(n), d)$. By Lemma 3.4, after applying the differential d_2 , the spectral sequence becomes as in Figure 1.

In the figure, V is a subspace of $E_C(n)^{1,1} = H^1(C^n, \mathbb{Q}) \otimes \langle G_{ij} \rangle_{1 \leq i < j \leq n}$, and

$$W = H^2(C^n, \mathbb{Q}) / \text{Im } d_2^{0,1}.$$

Recall that in the Leray spectral sequence for a map $f : X \rightarrow Y$ the edge homomorphisms $H^p(Y, \mathbb{Q}) \rightarrow H^p(X, \mathbb{Q})$ on the p -axis coincide with the usual pull-back in cohomology f^* . By Proposition 3.2, we deduce that $\iota^* : H^1(C^n, \mathbb{Q}) \rightarrow$

$H^1(F(C, n), \mathbb{Q})$ is an isomorphism, and we obtain a short exact sequence

$$(3.4) \quad 0 \rightarrow W \rightarrow H^2(F(C, n), \mathbb{Q}) \rightarrow V \rightarrow 0.$$

The composition $H^2(C^n, \mathbb{Q}) \rightarrow W \hookrightarrow H^2(F(C, n), \mathbb{Q})$ is given by pullback in cohomology.

If G is a group acting on C through homeomorphisms, then G acts diagonally on C^n and on $F(C, n)$, therefore it acts on the cohomology of C, C^n and $F(C, n)$. By the functoriality of the Leray spectral sequence, G acts on the spectral sequence as well, and this action is compatible with the natural action on $E_C(n)$, given by acting trivially on the variables G_{ij} . Therefore, the isomorphism $\iota^* : H^1(C^n, \mathbb{Q}) \rightarrow H^1(F(C, n), \mathbb{Q})$ is G -equivariant. Moreover, G acts on V and W , and the short exact sequence of (3.4) is compatible with the G -action.

(a) We have already shown that $\iota^* : H^1(C^n, \mathbb{Q}) \rightarrow H^1(F(C, n), \mathbb{Q})$ is an $\text{Aut}(C)$ -equivariant isomorphism. To show that $H^1(F(C, n), \mathbb{Q})^{\text{Aut}(C)} = 0$, it suffices to show that $H^1(C^n, \mathbb{Q})^{\text{Aut}(C)} = 0$. By the Künneth formula, we have an $\text{Aut}(C)$ -equivariant isomorphism $H^1(C^n, \mathbb{Q}) \cong H^1(C, \mathbb{Q})^{\oplus n}$, hence it is enough to show that $H^1(C, \mathbb{Q})^{\text{Aut}(C)} = 0$. Let σ be the (algebraic) hyperelliptic involution of C . It is an algebraic automorphism of C , and the quotient $C/\langle\sigma\rangle$ is isomorphic to \mathbb{P}^1 . We have

$$H^1(C, \mathbb{Q})^{\langle\sigma\rangle} \cong H^1([C/\langle\sigma\rangle], \mathbb{Q}) \cong H^1(C/\langle\sigma\rangle, \mathbb{Q}) \cong H^1(\mathbb{P}^1, \mathbb{Q}) = 0.$$

Here $[C/\langle\sigma\rangle]$ is a quotient stack, and the second isomorphism comes from Proposition 2.3(a).

(b) The decomposition (3.1) is Γ_g -equivariant. The summands $H^2(C, \mathbb{Q})$ are clearly Γ_g -invariant, and $(H^1(C, \mathbb{Q})^{\otimes 2})^{\Gamma_g} = \mathbb{Q}\Delta'$ by Lemma 3.5. Looking back at the definitions of γ_i and γ_{ij} given after (3.1), we deduce that $H^2(C^n, \mathbb{Q})^{\Gamma_g}$ is generated by the γ_i and the γ_{ij} ($i < j$). By Lemma 3.3, we deduce that the γ_i and the $\text{pr}_{ij}^*(\Delta)$ (for $i < j$) are a basis of $H^2(C^n, \mathbb{Q})^{\Gamma_g}$.

(c) The group of orientation-preserving diffeomorphisms of C acts on C , hence on (3.4). Diffeomorphisms that are isotopic to the identity act trivially on (3.4), so we obtain an action of Γ_g . Taking Γ_g -invariants, we obtain an exact sequence

$$(3.5) \quad 0 \rightarrow W^{\Gamma_g} \xrightarrow{\varphi} H^2(F(C, n), \mathbb{Q})^{\Gamma_g} \rightarrow V^{\Gamma_g}.$$

Denote by $\tau \in \Gamma_g$ the hyperelliptic involution of C , in the sense of topology. It is an element of Γ_g that acts on $H^1(C, \mathbb{Q})$ by $-\text{id}$; see [12, p. 215-216]. In particular, $H^1(C, \mathbb{Q})^{\langle\tau\rangle} = 0$, and so $H^1(C^n, \mathbb{Q})^{\Gamma_g} = (H^1(C^n, \mathbb{Q})^{\oplus n})^{\Gamma_g} = 0$. As V is a subspace of $H^1(C^n, \mathbb{Q}) \otimes \langle G_{ij} \rangle_{1 \leq i < j \leq n}$, we deduce that $V^{\Gamma_g} = 0$. Combining this with (3.5), we deduce that φ is an isomorphism. Consider the short exact sequence

$$(3.6) \quad 0 \rightarrow H^0(C^n, \mathbb{Q}) \otimes \langle G_{ij} \rangle_{i < j} \xrightarrow{d_2^{0,1}} H^2(C^n, \mathbb{Q}) \rightarrow W \rightarrow 0$$

which defines W . The first term of (3.6) is a trivial Γ_g -module. By [19, Corollary 3.3], $H^1(\Gamma_g, \mathbb{Q}) = 0$, so (3.6) stays exact after taking Γ_g -invariants. By (b), $H^2(C^n, \mathbb{Q})^{\Gamma_g}$ has a basis consisting of γ_i and $\text{pr}_{ij}^*(\Delta)$ (for $i < j$), and by Lemma 3.4(a) the image of $d_2^{0,1}$ is generated by the $\text{pr}_{ij}^*(\Delta)$. Therefore, the surjective linear map $H^2(C^n, \mathbb{Q})^{\Gamma_g} \rightarrow W^{\Gamma_g}$ sends $\gamma_1, \dots, \gamma_n$ to a basis of W^{Γ_g} , as desired. Since φ is an isomorphism, we conclude that the composition

$$\iota^* : H^2(C^n, \mathbb{Q})^{\Gamma_g} \rightarrow W^{\Gamma_g} \xrightarrow{\varphi} H^2(F(C, n), \mathbb{Q})^{\Gamma_g}$$

is surjective and sends $\gamma_1, \dots, \gamma_n$ to a basis of $H^2(F(C, n), \mathbb{Q})^{\Gamma_g}$, as desired. \square

4. PROOF OF THEOREM 1.1(A)

Let $\pi_n : \mathcal{H}_{g,n} \rightarrow \mathcal{H}_g$ be the natural forgetful morphism. We intend to compute $H^1(\mathcal{H}_{g,n}, \mathbb{Q})$ and $H^2(\mathcal{H}_{g,n}, \mathbb{Q})$ using the Leray spectral sequence for π_n .

Recall that if $f : E \rightarrow X$ is a (topologically) locally trivial orbifold fibration, then for any $q \geq 0$ the sheaf $R^q f_* \mathbb{Q}$ is a local system on X ; see [29, §2]. The morphism $\mathcal{M}_{g,n} \rightarrow \mathcal{M}_g$ is a locally trivial orbifold fibration: it is enough to show this for $\mathcal{M}_{g,n+1} \rightarrow \mathcal{M}_{g,n}$, in which case the result follows from embedding $\mathcal{M}_{g,n+1}$ in the universal curve $\mathcal{Z}_{g,n}$ over $\mathcal{M}_{g,n}$, which is a locally trivial fibration by Ehresmann's theorem. Thus, the sheaves $R^q \pi_{n*} \mathbb{Q}$ are local systems on \mathcal{H}_g . They satisfy

$$(R^q \pi_{n*} \mathbb{Q})_{[C]} = H^q(F(C, n), \mathbb{Q})$$

for every point $[C] \in \mathcal{H}_g$.

Lemma 4.1. *We have $\pi_{n*} \mathbb{Q} \cong \mathbb{Q}$. Furthermore*

$$H^p(\mathcal{H}_g, \pi_{n*} \mathbb{Q}) = H^p(\mathcal{H}_g, \mathbb{Q}) = \begin{cases} \mathbb{Q} & \text{if } p = 0, \\ 0 & \text{if } p > 0. \end{cases}$$

Proof. For every point $[C] \in \mathcal{H}_g$, the fiber of the local system $\pi_{n*} \mathbb{Q}$ at C is given by $H^0(F(C, n), \mathbb{Q})$. This is canonically isomorphic to \mathbb{Q} because $F(C, n)$ is connected. Therefore, the local system $\pi_{n*} \mathbb{Q}$ corresponds to the trivial one-dimensional representation of the orbifold fundamental group of \mathcal{H}_g , so $\pi_{n*} \mathbb{Q} \cong \mathbb{Q}$.

By [20, Theorem 2.13], \mathcal{H}_g has the rational cohomology of a point, so the result follows. \square

Lemma 4.2. *We have $H^\bullet(\mathcal{H}_g, R^1 \pi_{n*} \mathbb{Q}) = 0$.*

Proof. Let $V := R^1 \pi_{n*} \mathbb{Q}$. Denote by $f : \mathcal{H}_g \rightarrow \mathcal{H}_g$ the structure morphism to the coarse moduli space. We wish to compute $H^\bullet(\mathcal{H}_g, V)$ using the Leray spectral sequence for f and V :

$$E_2^{p,q} = H^p(\mathcal{H}_g, R^q f_* V) \Rightarrow H^{p+q}(\mathcal{H}_g, V).$$

It is enough to show that all terms in the E_2 -page of the spectral sequence are zero. To prove this, it suffices in turn to show that $R^q f_* V = 0$ for every $q \geq 0$. Let C be a hyperelliptic curve. The fiber of f above $[C] \in \mathcal{H}_g$ is the classifying space $B \text{Aut}(C)$. This implies that the fiber of $R^q f_* V$ at $[C]$ is

$$H^q(B \text{Aut}(C), H^1(F(C, n), \mathbb{Q})) = H^q(\text{Aut}(C), H^1(F(C, n), \mathbb{Q})).$$

On the right hand side we are considering group cohomology, where $\text{Aut}(C)$ acts diagonally on $F(C, n)$. Since the coefficient module is a \mathbb{Q} -vector space and $\text{Aut}(C)$ is finite by Hurwitz's theorem [1, Exercise 1.F], group cohomology vanishes for $q > 0$. Therefore, $R^q f_* V = 0$ for every $q > 0$. By Proposition 3.6(a),

$$H^0(\text{Aut}(C), H^1(F(C, n), \mathbb{Q})) = H^1(F(C, n), \mathbb{Q})^{\text{Aut}(C)} = 0,$$

so $R^0 f_* V = 0$ as well. \square

We now come to the main result of this section, which implies Theorem 1.1(a).

Proposition 4.3. *We have:*

$$(a) \ H^1(\mathcal{H}_{g,n}, \mathbb{Q}) = 0;$$

(b) $\text{Pic}(\mathcal{H}_{g,n})_{\mathbb{Q}} \cong H^2(\mathcal{H}_{g,n}, \mathbb{Q})$ has a basis given by ψ -classes.

Proof. We consider the Leray spectral sequence for π_n :

$$E_2^{p,q} = H^p(\mathcal{H}_g, R_*^q \mathbb{Q}) \Rightarrow H^{p+q}(\mathcal{H}_{g,n}, \mathbb{Q}).$$

The combination of Lemma 4.1 and Lemma 4.2, shows that in the E_2 -page the first two rows are zero, with the exception of $(0, 0)$. It follows that

$$H^1(\mathcal{H}_{g,n}, \mathbb{Q}) = 0$$

and that the edge homomorphism

$$\varphi : H^2(\mathcal{H}_{g,n}, \mathbb{Q}) \rightarrow H^0(\mathcal{H}_g, R^2 \pi_{n*} \mathbb{Q})$$

is an isomorphism. Recall that in the Leray spectral sequence for a map $f : X \rightarrow Y$, the edge homomorphisms $H^q(X, \mathbb{Q}) \rightarrow H^0(Y, R^q f_* \mathbb{Q})$ on the q -axis are given by sending a cohomology class $\alpha \in H^q(X, \mathbb{Q})$ to the section $p \mapsto \alpha|_{f^{-1}(p)}$ of $R^q f_* \mathbb{Q}$. Since \mathcal{H}_g is an orbifold $K(\Gamma_g, 1)$, associating to a finite-dimensional local system over \mathcal{H}_g its fiber at $[C] \in \mathcal{H}_g$ gives a correspondence between finite-dimensional local systems and finite-dimensional Γ_g -representations. Moreover, the cohomology of a local system over \mathcal{H}_g coincides with the group cohomology of the associated Γ_g -representation. Therefore

$$H^0(\mathcal{H}_g, R^2 \pi_{n*} \mathbb{Q}) \cong H^0(\Gamma_g, H^2(F(C, n), \mathbb{Q})) \cong H^2(F(C, n), \mathbb{Q})^{\Gamma_g}.$$

Since the first Chern class $c_1(\cdot)$ commutes with pullbacks, we have a commutative diagram

$$\begin{array}{ccc} \text{Pic}(\mathcal{H}_{g,n})_{\mathbb{Q}} & \xrightarrow{\rho} & \text{Pic}(F(C, n))_{\mathbb{Q}} \\ \downarrow c_1(\cdot) & & \downarrow c_1(\cdot) \\ H^2(\mathcal{H}_{g,n}, \mathbb{Q}) & \xrightarrow{\varphi} H^0(\mathcal{H}_g, R^2 f_* \mathbb{Q}) \xleftarrow{\sigma} & H^2(F(C, n), \mathbb{Q}), \end{array}$$

where ρ and σ are given by restriction to $\pi_n^{-1}([C]) = F(C, n)$.

Let $\psi_1, \dots, \psi_n \in \text{Pic}(\mathcal{H}_{g,n})$ be the restriction of the ψ -classes to the hyperelliptic locus. Recall that, by definition, ψ_i is the class of the line bundle \mathcal{L}_i on $\mathcal{H}_{g,n}$ which to a family $X \rightarrow S$ in $\mathcal{H}_{g,n}(S)$ with sections $\sigma_1, \dots, \sigma_n$ associates the line bundle $\sigma_i^* \omega_{X/S}$. The restriction $\rho(\mathcal{L}_i)$ of \mathcal{L}_i to $\pi_n^{-1}([C]) = F(C, n)$ is given by the pullback of the canonical line bundle of C along the composition

$$F(C, n) \xrightarrow{\iota} C^n \xrightarrow{\text{pr}_i} C.$$

Since $H^2(C, \mathbb{Q}) \cong \mathbb{Q}$, the canonical class of C is a non-zero scalar multiple of the Poincaré dual of the class of a point. Pulling back to $F(C, n)$, we see that $c_1(\rho(\mathcal{L}_i))$ restricts to a scalar multiple of $\iota^*(\gamma_i)$. From the commutativity of the diagram, we see that $c_1(\psi_i)$ is a non-zero scalar multiple of $\iota^*(\gamma_i)$. By Proposition 3.6(c), $\iota^*(\gamma_1), \dots, \iota^*(\gamma_n)$ is a basis of $H^2(F(C, n), \mathbb{Q})^{\Gamma_g}$. Therefore, $H^2(\mathcal{H}_{g,n}, \mathbb{Q})$ has dimension n , and $c_1(\psi_1), \dots, c_1(\psi_n)$ is a basis of $H^2(\mathcal{H}_{g,n}, \mathbb{Q})$.

Recall from Proposition 2.3 that $\mathcal{H}_{g,n}$ and its coarse space $H_{g,n}$ have the same rational cohomology and rational Picard group. The exponential sequence for $H_{g,n}$ (see [9, §2.8]) gives

$$\dots \rightarrow H^1(H_{g,n}, \mathbb{Z}) \rightarrow H^1(H_{g,n}, \mathcal{O}_{H_{g,n}}) \rightarrow \text{Pic}(H_{g,n}) \xrightarrow{c_1(\cdot)} H^2(H_{g,n}, \mathbb{Z}) \rightarrow \dots$$

where $c_1(\cdot)$ is given by the first Chern class. Recall that $H^1(H_{g,n}, \mathbb{Z})$ is a full lattice in $H^1(H_{g,n}, \mathcal{O}_{H_{g,n}})$. By Proposition 4.3(a) and Proposition 2.3(a), we have $H^1(H_{g,n}, \mathbb{Z})_{\mathbb{Q}} = H^1(H_{g,n}, \mathbb{Q}) = 0$, thus $H^1(H_{g,n}, \mathcal{O}_{H_{g,n}}) = 0$. It follows that the rational Chern class $\text{Pic}(H_{g,n})_{\mathbb{Q}} \rightarrow H^2(H_{g,n}, \mathbb{Q})$ is injective. It is also surjective, since $H^2(H_{g,n}, \mathbb{Q})$ is generated by the first Chern classes of the ψ -classes. \square

5. DESCRIPTION OF THE BOUNDARY

Proposition 5.1. *The group $\text{Cl}(\overline{\mathcal{H}}_{g,n})_{\mathbb{Q}}$ is generated by ψ -classes and boundary divisors.*

Proof. By Proposition 4.3, $\text{Pic}(\mathcal{H}_{g,n})_{\mathbb{Q}} = \text{Cl}(\mathcal{H}_{g,n})_{\mathbb{Q}}$ is generated by ψ -classes. The conclusion immediately follows from the consideration of the excision exact sequence

$$\oplus \mathbb{Q} \mathcal{D}_h \rightarrow \text{Cl}(\overline{\mathcal{H}}_{g,n})_{\mathbb{Q}} \rightarrow \text{Cl}(\mathcal{H}_{g,n})_{\mathbb{Q}} \rightarrow 0,$$

where \mathcal{D}_h are the codimension 1 components of the boundary of $\overline{\mathcal{H}}_{g,n}$; see [35, p. 614], or [25, Proposition 2.4.1]. \square

In order to complete the proof of Theorem 1.1(b), we must study the geometry of the boundary of $\overline{\mathcal{H}}_{g,n}$ and prove that ψ -classes and classes of boundary divisors are linearly independent. Our analysis requires some basic deformation theory, as explained, for example, in [3, Chapter XI] and [10].

Recall the product decomposition for an irreducible boundary divisor of $\overline{\mathcal{M}}_{g,n}$ as the image of a finite morphism from a product of moduli of curves with smaller genus and number of markings; see [22] or [3, §X.10, §XII.10] for detailed proofs. Informally, there is an irreducible boundary divisor $\mathcal{D}_{irr,n}$, which is the image of the finite map

$$\xi_{\mathcal{D}_{irr,n}} : \overline{\mathcal{M}}_{g-1,n+2} \rightarrow \overline{\mathcal{M}}_{g,n}$$

that glues the last two sections to a node. Moreover, there is an irreducible boundary divisor $\mathcal{D}_{i,I}$, which is the image of the finite morphism

$$\xi_{\mathcal{D}_{i,I}} : \overline{\mathcal{M}}_{i,I \cup \{n+1\}} \times \overline{\mathcal{M}}_{g-i,I^c \cup \{n+2\}} \rightarrow \overline{\mathcal{M}}_{g,n}$$

that glues the two curves along the sections σ_{n+1} and σ_{n+2} , for every $0 \leq i \leq \frac{g}{2}$ and $I \subseteq \{1, \dots, n\}$ such that the domain of $\xi_{\mathcal{D}_{i,I}}$ is non-empty. These divisors are the irreducible components of $\partial \overline{\mathcal{M}}_{g,n}$, and the morphisms are called clutching morphisms. More generally, $\overline{\mathcal{M}}_{g,n}$ can be stratified by topological type, and there is a similarly defined clutching map ξ_{Δ} for every stratum Δ .

We also recall the structure of the boundary of $\overline{\mathcal{H}}_g$. We refer the reader to [3, §X.3, §XIII.8] for a more thorough discussion. For a stable curve C , and nodes q_1, \dots, q_r of C , denote by $\tilde{C}_{q_1, \dots, q_r}$ the partial normalization of C at q_1, \dots, q_r . The irreducible divisor η_{irr} parametrizes stable hyperelliptic curves C with at least one non-separating node q , that is, such that \tilde{C}_q is connected. For every $1 \leq i \leq \frac{g}{2}$, the irreducible divisor δ_i parametrizes curves C admitting a node q such that \tilde{C}_q is the disjoint union of two curves of genera i and $g-i$. Such a node is necessarily fixed by the hyperelliptic involution of C , i.e., it is a *Weierstrass point*. Lastly, for $1 \leq i \leq \frac{g-1}{2}$, there is an irreducible divisor η_i parametrizing curves C having two nodes q_1 and q_2 that are conjugated by the involution, and such that \tilde{C}_{q_1, q_2} is the disjoint union of two curves of genera i and $g-i-1$. In the first two cases, we say that q is a node of type η_{irr} or δ_i , and in the third case we say that q_1 and q_2 are a pair of nodes of type η_i ; c.f. [3, p. 102].

Our purpose is now to generalize this description to the boundary of $\overline{\mathcal{H}}_{g,n}$, for a fixed integer $n \geq 1$. We will do so by considering the inverse images of the boundary divisors of $\overline{\mathcal{H}}_g$ under the forgetful morphism $\overline{\pi}_n : \overline{\mathcal{H}}_{g,n} \rightarrow \overline{\mathcal{H}}_g$. Recall from Proposition 2.2 that $\overline{\pi}_n$ is open. From now on, we denote by I a subset of $\{1, \dots, n\}$.

Recall that we denote by $\mathcal{H}_{g,n}^{rt}$ the moduli stack of hyperelliptic curves with rational tails. The complement $\mathcal{H}_{g,n}^{rt} \setminus \mathcal{H}_{g,n}$ is a union of irreducible divisors $\delta'_{0,I}$ parametrizing curves having rational tails marked by I , for every I having at least two elements (so that the resulting pointed curves are stable); see [33, §1]. We denote by $\delta_{0,I}$ the divisors of $\overline{\mathcal{H}}_{g,n}$ given by the closure of $\delta'_{0,I}$.

Let now \mathcal{D} be an irreducible divisor of $\overline{\mathcal{H}}_{g,n}$ mapping to the boundary of $\overline{\mathcal{H}}_g$. If \mathcal{D} maps to some δ_i then \mathcal{D} is a component of $\overline{\pi}_n^{-1}(\delta_i)$. The fiber above a point $[C] \in \delta_i$ contains the ordered configuration space $F(C, n)$ as a dense open subspace. Here $F(C, n)$ is defined in the same way as for smooth curves. Since a general curve parametrized by δ_i has exactly two components, the general fiber of $\overline{\pi}_n$ over δ_i has 2^n components. By Proposition 2.2(a), $\overline{\pi}_n|_{\overline{\pi}_n^{-1}(\delta_i)} : \overline{\pi}_n^{-1}(\delta_i) \rightarrow \delta_i$ is open, hence every irreducible component of $\overline{\pi}_n^{-1}(\delta_i)$ dominates δ_i . By [31, Tag 0554], we deduce that $\overline{\pi}_n^{-1}(\delta_i)$ has at most 2^n irreducible components.

We now claim that $\overline{\pi}_n^{-1}(\delta_i)$ has exactly 2^n irreducible components. To prove this, it is enough to exhibit 2^n disjoint open subsets of $\overline{\pi}_n^{-1}(\delta_i)$ and take their closures. For every $I \subseteq \{1, \dots, n\}$, denote by $\delta_{i,I}^\circ$ the set of points of $\overline{\pi}_n^{-1}(\delta_i)$ corresponding to hyperelliptic curves C obtained by glueing two smooth hyperelliptic curves C_1 and C_2 of genera i and $g-i$ at one point (necessarily a Weierstrass point for C), and such that $q_j \in C_1$ if $j \in I$ and $q_j \in C_2$ if $j \in I^c$.

Note that $\delta_{i,I}^\circ \neq \emptyset$ for any choice of I , because the divisor δ_i is defined only for $i \geq 1$. Moreover, a point of $\overline{\pi}_n^{-1}(\delta_i)$ belongs to $\delta_{i,I}^\circ$ if and only if it belongs to $\text{Im } \xi_{\mathcal{D}_{i,I}}$ and it does not belong to $\text{Im } \xi_{\mathcal{D}}$ for any $\mathcal{D} \neq \mathcal{D}_{i,I}$. The curves parametrized by $\overline{\pi}_n^{-1}(\delta_i)$ are all singular, hence they belong to at least one $\text{Im } \xi_{\mathcal{D}}$. This shows that

$$\delta_{i,I}^\circ = \overline{\pi}_n^{-1}(\delta_i) \setminus \bigcap_{\mathcal{D} \neq \mathcal{D}_{i,I}} (\text{Im } \xi_{\mathcal{D}} \cap \overline{\pi}_n^{-1}(\delta_i)).$$

By [22, Corollary 3.9] the clutching morphisms are finite, hence $\text{Im } \xi_{\mathcal{D}} \cap \overline{\pi}_n^{-1}(\delta_i)$ is closed in $\overline{\pi}_n^{-1}(\delta_i)$, and so $\delta_{i,I}^\circ$ is open in $\overline{\pi}_n^{-1}(\delta_i)$. Therefore, the $\delta_{i,I}^\circ$ are 2^n pairwise disjoint open subspaces of $\overline{\pi}_n^{-1}(\delta_i)$. If we denote by $\delta_{i,I}$ the closure of $\delta_{i,I}^\circ$, we have shown that

$$(5.1) \quad \overline{\pi}_n^{-1}(\delta_i) = \bigcup_{I \subseteq \{1, \dots, n\}} \delta_{i,I}$$

is the irredundant decomposition of $\overline{\pi}_n^{-1}(\delta_i)$ in irreducible components. For every I , the general fiber of $\overline{\pi}_n|_{\delta_{i,I}} : \delta_{i,I} \rightarrow \delta_i$ has dimension n , hence every $\delta_{i,I}$ is an irreducible divisor of the boundary of $\overline{\mathcal{H}}_{g,n}$.

A similar reasoning shows that, for $i \geq 1$,

$$(5.2) \quad \overline{\pi}_n^{-1}(\eta_i) = \bigcup_{I \subseteq \{1, \dots, n\}} \eta_{i,I},$$

where every $\eta_{i,I}$ is an divisor of $\overline{\mathcal{H}}_{g,n}$. A general point of $\eta_{i,I}$ represents a pointed hyperelliptic curve $(C; p_1, \dots, p_n)$ obtained by joining two smooth hyperelliptic curves

C_1 and C_2 of genera i and $g - i$ at two points that are conjugated under the involution of C , and $p_j \in C_1$ if and only if $j \in I$. In this case, the role of $\mathcal{D}_{i,I}$ is taken up by the stratum Δ corresponding to this topological type. Finally, if $i = 0$ and C is a general curve parametrized by η_{irr} , then C is irreducible. It follows that in this case $\overline{\pi}_n^{-1}([C])$ is irreducible of dimension n , so by [31, 004Z]

$$(5.3) \quad \overline{\pi}_n^{-1}(\eta_{irr}) = \eta_{irr,n}$$

is an irreducible divisor of $\overline{\mathcal{H}}_{g,n}$. We have obtained the following description of the boundary of $\overline{\mathcal{H}}_{g,n}$.

Proposition 5.2. *The boundary of $\overline{\mathcal{H}}_{g,n}$ is a divisor. Let $\mathcal{D} \subseteq \overline{\mathcal{H}}_{g,n}$ be an irreducible boundary divisor, and let $(C; p_1, \dots, p_n)$ be a general curve parametrized by \mathcal{D} . Then exactly one of the following holds.*

- (i) *We have $\mathcal{D} = \delta_{i,I}$ for some $0 \leq i \leq \frac{g}{2}$ and some $I \subseteq \{1, \dots, n\}$, C is obtained by glueing two smooth hyperelliptic curves C_1 and C_2 of genera i and $g - i$ at a Weierstrass point, and $p_j \in C_1$ if and only if $j \in I$.*
- (ii) *We have $\mathcal{D} = \eta_{i,I}$ for some $1 \leq i \leq \frac{g-1}{2}$ and some $I \subseteq \{1, \dots, n\}$, C is obtained by glueing two smooth irreducible curves C_1 and C_2 of genera i and $g - i$ at a pair of points switched by the involutions, and $p_j \in C_1$ if and only if $j \in I$.*
- (iii) *We have $\mathcal{D} = \eta_{irr,n}$, C is irreducible and has exactly one node.*

If \mathcal{D} is of the form $\delta_{0,I}$, a general point of \mathcal{D} belongs to $\mathcal{H}_{g,n}^{rt}$. Otherwise, a general curve parametrized by \mathcal{D} is stable even after removing the marked points.

The purpose of this section is to determine the class of the restriction of each boundary divisor of $\overline{\mathcal{M}}_{g,n}$ in $\text{Cl}(\overline{\mathcal{H}}_{g,n})_{\mathbb{Q}}$. If $(C; p_1, \dots, p_n)$ is a stable n -pointed curve, we denote by $D = (p_1, \dots, p_n)$ the ordered n -uple of markings, and we write $(C; D)$ for $(C; p_1, \dots, p_n)$. We denote by $\Phi: \overline{\mathcal{M}}_{g,n} \rightarrow \overline{\mathcal{M}}_g$ the forgetful morphism.

Recall that if $(X \rightarrow S; \sigma_1, \dots, \sigma_n)$ is a family of pointed nodal curves, the locus of points in S having stable fiber is open; see [3, Lemma X.3.4]. It follows that there exists an open substack $\overline{\mathcal{M}}_{g,n}^{\circ}$ of $\overline{\mathcal{M}}_{g,n}$ parametrizing curves $(C; D)$ such that C is stable as an unmarked curve. Clearly $\mathcal{M}_{g,n}$ is contained in $\overline{\mathcal{M}}_{g,n}^{\circ}$.

Lemma 5.3. *The restriction of Φ to $\overline{\mathcal{M}}_{g,n}^{\circ}$ is smooth.*

Proof. We must show that for every $(C; D) \in \overline{\mathcal{M}}_{g,n}$ such that C is stable as a curve without marked points, the differential $d\Phi_{(C;D)}$ of Φ at $(C; D)$ is surjective.

We will use the theory of first order deformations of nodal curves; see e.g. [3, §XI.3]. We have the local-to-global Ext spectral sequences

$$E_2^{p,q} = H^p(C, \mathcal{E}xt^q(\Omega_C^1, \mathcal{O}_C(-D))) \Rightarrow H^{p+q}(\Omega_C^1, \mathcal{O}_C(-D)),$$

$$E_2^{p,q} = H^p(C, \mathcal{E}xt^q(\Omega_C^1, \mathcal{O}_C)) \Rightarrow H^{p+q}(\Omega_C^1, \mathcal{O}_C).$$

The inclusion $\mathcal{O}_C(-D) \hookrightarrow \mathcal{O}_C$ induces a homomorphism from the first spectral sequence to the second. Since C is a curve,

$$H^2(C, \mathcal{H}om_{\mathcal{O}_C}(\Omega_C^1, \mathcal{O}_C)) = H^2(C, \mathcal{H}om_{\mathcal{O}_C}(\Omega_C^1, \mathcal{O}_C(-D))) = 0.$$

Considering the associated five-term short exact sequences, we obtain by functoriality a commutative diagram with exact rows:

$$\begin{array}{ccccccc}
 0 & \longrightarrow & H^1(C, \mathcal{H}om_{\mathcal{O}_C}(\Omega_C^1, \mathcal{O}_C(-D))) & \longrightarrow & \text{Ext}_{\mathcal{O}_C}^1(\Omega_C^1, \mathcal{O}_C(-D)) & \longrightarrow & H^0(C, \mathcal{E}xt_{\mathcal{O}_C}^1(\Omega_C^1, \mathcal{O}_C(-D))) \longrightarrow 0 \\
 & & \downarrow & & \downarrow & & \downarrow \\
 0 & \longrightarrow & H^1(C, \mathcal{H}om_{\mathcal{O}_C}(\Omega_C^1, \mathcal{O}_C)) & \longrightarrow & \text{Ext}_{\mathcal{O}_C}^1(\Omega_C^1, \mathcal{O}_C) & \longrightarrow & H^0(C, \mathcal{E}xt_{\mathcal{O}_C}^1(\Omega_C^1, \mathcal{O}_C)) \longrightarrow 0.
 \end{array}$$

Here the vertical maps are canonically induced from the inclusion $\mathcal{O}_C(-D) \hookrightarrow \mathcal{O}_C$.

Let $\nu : \tilde{C} \rightarrow C$ be the normalization of C , $\tilde{D} = \nu^{-1}(D)$, and R be the inverse image of the nodes of C . Since C is stable as an unmarked curve, $(C; D)$ maps to $[C]$ in $\overline{\mathcal{M}}_g$. An elementary computation shows that $\mathcal{H}om_{\mathcal{O}_C}(\Omega_C^1, \mathcal{O}_C) = \nu_* T_C(-R)$ and $\mathcal{H}om_{\mathcal{O}_C}(\Omega_C^1, \mathcal{O}_C(-D)) = \nu_* T_{\tilde{C}}(-\tilde{D} - R)$; see [3, p. 182, p. 186]. The sheaves $\mathcal{E}xt_{\mathcal{O}_C}^1(\Omega_C^1, \mathcal{O}_C)$ and $\mathcal{E}xt_{\mathcal{O}_C}^1(\Omega_C^1, \mathcal{O}_C(-D))$ are isomorphic and concentrated at the nodes of C , and their global sections are given by $\bigoplus_{q \text{ node}} \text{Ext}_{\mathcal{O}_{C,q}}^1(\Omega_{C,q}^1, \mathcal{O}_{C,q})$; see [3, p. 179]. Finally, using the Kodaira-Spencer map, the homomorphism in the middle may be identified with the differential $d\Phi_{(C;D)} : T_{(C;D)}\overline{\mathcal{M}}_{g,n} \rightarrow T_{[C]}\overline{\mathcal{M}}_g$; see [3, Theorem XI.3.17]. We have obtained the following commutative diagram:

$$\begin{array}{ccccccc}
 0 & \longrightarrow & H^1(\tilde{C}, T_{\tilde{C}}(-\tilde{D} - R)) & \longrightarrow & \text{Ext}_{\mathcal{O}_C}^1(\Omega_C^1, \mathcal{O}_C(-D)) & \longrightarrow & \bigoplus_{q \text{ node}} \text{Ext}_{\mathcal{O}_{C,q}}^1(\Omega_{C,q}^1, \mathcal{O}_{C,q}) \longrightarrow 0 \\
 & & \downarrow \varphi & & \downarrow d\Phi_{(C;D)} & & \parallel \\
 0 & \longrightarrow & H^1(\tilde{C}, T_{\tilde{C}}(-R)) & \longrightarrow & \text{Ext}_{\mathcal{O}_C}^1(\Omega_C^1, \mathcal{O}_C) & \longrightarrow & \bigoplus_{q \text{ node}} \text{Ext}_{\mathcal{O}_{C,q}}^1(\Omega_{C,q}^1, \mathcal{O}_{C,q}) \longrightarrow 0.
 \end{array}$$

where φ is induced from the natural inclusion $\iota : T_{\tilde{C}}(-\tilde{D} - R) \hookrightarrow T_{\tilde{C}}(-R)$. The rows of this diagram appear in [3, XI.3 (3.14)]. By the snake lemma, to prove the surjectivity of $d\Phi_{(C;D)}$ it is enough to show that φ is surjective. Consider the following short exact sequence on \tilde{C} :

$$0 \rightarrow T_{\tilde{C}}(-\tilde{D} - R) \xrightarrow{\iota} T_{\tilde{C}}(-\tilde{D}) \rightarrow \mathcal{O}_R \rightarrow 0.$$

Since \mathcal{O}_R is supported on a zero-dimensional locus, the associated cohomology long exact sequence

$$\dots \rightarrow H^1(\tilde{C}, T_{\tilde{C}}(-\tilde{D} - R)) \xrightarrow{\varphi} H^1(\tilde{C}, T_{\tilde{C}}(-\tilde{D})) \rightarrow H^1(\tilde{C}, \mathcal{O}_R) = 0$$

shows the surjectivity of φ . \square

Let $\overline{\mathcal{H}}_{g,n}^\circ := \overline{\mathcal{H}}_{g,n} \cap \overline{\mathcal{M}}_{g,n}^\circ$, and define $\mathcal{U}_{g,n} \subseteq \overline{\mathcal{H}}_{g,n}$ as the union of $\mathcal{H}_{g,n}^{rt}$ and $\overline{\mathcal{H}}_{g,n}^\circ$. The stack $\mathcal{U}_{g,n}$ is open in $\overline{\mathcal{H}}_{g,n}$, and it contains $\mathcal{H}_{g,n}$. By Proposition 5.2, $\mathcal{U}_{g,n}$ is dense in every boundary divisor, hence its complement has codimension at least 2.

Proposition 5.4. (a) *The morphism $\mathcal{U}_{g,n} \rightarrow \overline{\mathcal{H}}_g$ is smooth.*

(b) *The stack $\mathcal{U}_{g,n}$ is smooth. In particular, $\overline{\mathcal{H}}_{g,n}$ is smooth in codimension one.*

Proof. (a) By Proposition 2.2, the morphism $\mathcal{H}_{g,n}^{rt} \rightarrow \mathcal{H}_g$ is smooth. The morphism $\overline{\mathcal{H}}_{g,n}^\circ \rightarrow \overline{\mathcal{H}}_g$ is the base change of the morphism $\overline{\mathcal{M}}_{g,n}^\circ \rightarrow \overline{\mathcal{M}}_g$ along the inclusion $\overline{\mathcal{H}}_g \hookrightarrow \overline{\mathcal{M}}_g$, hence it is smooth by Lemma 5.3. As smoothness is a local property on the domain, the proof is complete.

(b) This follows from (a) and the smoothness of \mathcal{H}_g . \square

Let $f : \mathcal{X} \rightarrow \mathcal{Y}$ be a morphism of smooth Deligne-Mumford stacks over \mathbb{C} , let $\mathcal{Z} \subseteq \mathcal{Y}$ be a smooth locally closed substack, and let $q \in \mathcal{Z}$. We say that f and \mathcal{Z} are *transverse* at q if for every point p in $f^{-1}(q)$ we have $df(T_p\mathcal{X}) + T_q\mathcal{Z} = T_q\mathcal{Y}$; c.f. [11, p. 18] and [3]. By Proposition 5.4, $\mathcal{U}_{g,n}$ is smooth. The next two lemmas

will show that $\mathcal{U}_{g,n}$ is transverse at every point to all the clutching morphisms $\xi_{\mathcal{D}}$, where \mathcal{D} is a boundary divisor of $\overline{\mathcal{M}}_{g,n}$.

Lemma 5.5. *Let $(C; D) \in \mathcal{U}_{g,n}$, and let \mathcal{D} be an irreducible boundary divisor of $\overline{\mathcal{M}}_{g,n}$ containing $(C; D)$. Then the clutching map $\xi_{\mathcal{D}}$ is transverse to $\mathcal{U}_{g,n}$ at $(C; D)$.*

Proof. If $(C; D) \in \overline{\mathcal{H}}_{g,n}^{\circ}$, it follows from Lemma 5.3 that the forgetful morphism $\Phi : \overline{\mathcal{M}}_{g,n} \rightarrow \overline{\mathcal{M}}_g$ is an orbifold submersion at $(C; D)$. If $(C; D) \in \mathcal{H}_{g,n}^{rt}$, by Lemma 2.1(c) the forgetful morphism Φ is again an orbifold submersion around $(C; D)$. Since $\overline{\mathcal{H}}_{g,n} = \Phi^{-1}(\overline{\mathcal{H}}_g)$ (set-theoretically), $\mathcal{U}_{g,n}$ is locally the inverse image of $\overline{\mathcal{H}}_g$. Therefore, in each case we obtain

$$T_{(C;D)}\mathcal{U}_{g,n} = T_{(C;D)}\Phi^{-1}(\overline{\mathcal{H}}_g) = d\Phi_{(C;D)}^{-1}(T_C\overline{\mathcal{H}}_g).$$

By [22, Corollary 3.9], $\xi_{\mathcal{D}}$ is unramified, so if p is a point of the domain of $\xi_{\mathcal{D}}$ mapping to $(C; D)$, $d(\xi_{\mathcal{D}})_p$ is injective and $\text{Im } d(\xi_{\mathcal{D}})_p$ has codimension one in $T_{(C;D)}\overline{\mathcal{M}}_{g,n}$. Therefore, to prove transversality of $\xi_{\mathcal{D}}$ it suffices to show that there is a vector $v \in T_{(C;D)}\mathcal{U}_{g,n}$ that does not belong to the image of $d(\xi_{\mathcal{D}})_p$. Since $(C; D)$ belongs to \mathcal{D} , the curve C has at least one node, so consider a first-order deformation of C as a point of $\overline{\mathcal{H}}_g$ that smooths all the nodes of C . Via the Kodaira-Spencer map, this deformation corresponds to a tangent vector $v \in T_{[C]}\overline{\mathcal{H}}_g$. By Lemma 5.3, we may lift v to a vector $w \in T_{(C;D)}\mathcal{U}_{g,n}$. Since not all nodes may be smoothed inside \mathcal{D} , the vector w does not belong to $\text{Im } d(\xi_{\mathcal{D}})_p$. \square

Let $j : \overline{\mathcal{H}}_{g,n} \hookrightarrow \overline{\mathcal{M}}_{g,n}$ be the natural inclusion, and let j^* and $\overline{\pi}_n^*$ denote the composition $\text{Pic}(\overline{\mathcal{M}}_{g,n})_{\mathbb{Q}} \rightarrow \text{Pic}(\overline{\mathcal{H}}_{g,n})_{\mathbb{Q}} \rightarrow \text{Cl}(\overline{\mathcal{H}}_{g,n})_{\mathbb{Q}}$. Recall that since we do not know if $\overline{\mathcal{H}}_{g,n}$ is smooth, we do not know if $\text{Pic}(\overline{\mathcal{H}}_{g,n})_{\mathbb{Q}} \rightarrow \text{Cl}(\overline{\mathcal{H}}_{g,n})_{\mathbb{Q}}$ is an isomorphism, or even injective.

Proposition 5.6. *We have the following identities in $\text{Cl}(\overline{\mathcal{H}}_{g,n})_{\mathbb{Q}}$:*

$$j^*\mathcal{D}_{i,I} = \delta_{i,I}, \quad j^*\mathcal{D}_{\text{irr},n} = \eta_{\text{irr},n} + 2 \sum_{i,I} \eta_{i,I}.$$

Proof. Since the complement of $\mathcal{U}_{g,n}$ has codimension 2 in $\overline{\mathcal{H}}_{g,n}$, the restriction map

$$\text{Cl}(\overline{\mathcal{H}}_{g,n})_{\mathbb{Q}} \rightarrow \text{Cl}(\mathcal{U}_{g,n})_{\mathbb{Q}}$$

is an isomorphism. It thus suffices to prove the relations in $\text{Cl}(\mathcal{U}_{g,n})_{\mathbb{Q}}$.

Let $(C; D) \in \overline{\mathcal{M}}_{g,n}$, let q_1, \dots, q_r be the nodes of C , and let N be the dimension of $\text{Ext}_{\mathcal{O}_C}^1(\Omega_C^1, \mathcal{O}_C(-D))$. We recall some standard facts on universal deformations of n -pointed stable curves; good references on the topic are [10, p. 82] (when $n = 0$), or [17, 3.B]. There exists a universal deformation $(\tilde{C} \rightarrow \text{Spec } \hat{\mathcal{O}}_M; \tilde{D})$ of $(C; D)$ with nodes $\tilde{q}_1, \dots, \tilde{q}_r$, where $\hat{\mathcal{O}}_M$ is the completed local ring of $\overline{\mathcal{M}}_{g,n}$ at $(C; D)$. The ring $\hat{\mathcal{O}}_M$ is (non-canonically) isomorphic to the ring of complex power series in N variables. More precisely, one can find a presentation

$$\hat{\mathcal{O}}_M \cong \mathbb{C}[[t_1, \dots, t_r, t_{r+1}, \dots, t_N]]$$

such that for every $i = 1, \dots, r$ we have

$$\hat{\mathcal{O}}_{C, \tilde{q}_i} \cong \mathbb{C}[[u_i, v_i, t_1, \dots, t_N]] / (u_i v_i - t_i)$$

for suitable u_i, v_i . Informally speaking, $\text{Spec } \hat{\mathcal{O}}_M / (t_i)$ is the locus where q_i remains a node.

Assume now that $(C; D) \in \mathcal{U}_{g,n}$. Since $\mathcal{U}_{g,n}$ is locally closed in $\overline{\mathcal{M}}_{g,n}$, the completed stalk $\hat{\mathcal{O}}_H$ of $\mathcal{U}_{g,n}$ at $(C; D)$ is a quotient of $\hat{\mathcal{O}}_M$. By Proposition 5.4(b), $\mathcal{U}_{g,n}$ is smooth, hence $\hat{\mathcal{O}}_H$ is also a power series ring. If $t \in \hat{\mathcal{O}}_M$, we denote by \bar{t} its reduction in $\hat{\mathcal{O}}_H$. We also let \mathfrak{m} be the maximal ideal of $\hat{\mathcal{O}}_H$. If $\mathcal{Z} \subseteq \overline{\mathcal{M}}_{g,n}$ is a locally closed substack passing through $(C; D)$, we denote by $\hat{\mathcal{Z}}$ its base change to $\text{Spec } \hat{\mathcal{O}}_M$.

Let \mathcal{D} be a boundary divisor through $\overline{\mathcal{M}}_{g,n}$, let $\mathcal{D}_0 := \mathcal{D} \cap \mathcal{U}_{g,n}$, let δ be a boundary divisor of $\mathcal{U}_{g,n}$ which appears as an irreducible component of \mathcal{D}_0 , and assume that $(C; D) \in \delta$ is a general point. As $\overline{\mathcal{M}}_{g,n}$ and $\mathcal{U}_{g,n}$ are smooth, \mathcal{D} and δ are Cartier divisors in $\overline{\mathcal{M}}_{g,n}$ and $\mathcal{U}_{g,n}$, respectively. Since $(C; D)$ is general, $\hat{\delta}$ is irreducible. Therefore, we have $\hat{\mathcal{D}} = \text{Spec } \hat{\mathcal{O}}_M/(t)$ for some non-zero divisor t , $\hat{\mathcal{D}}_0 = \text{Spec } \hat{\mathcal{O}}_H/(\bar{t})$, and $\hat{\delta} = \text{Spec } \hat{\mathcal{O}}_H/(u)$ for some u such that (u) is a prime ideal of $\hat{\mathcal{O}}_H$.

Since \mathcal{D}_0 is a Cartier divisor, we may compute the divisor class $j^*\mathcal{D}$ by computing the multiplicities of \mathcal{D}_0 at its irreducible components; see [31, Tags 0AZA, 0B05, 0DR4]. The multiplicity of \mathcal{D}_0 along δ equals the length of the ring $\hat{\mathcal{O}}_{\mathcal{D}_0, \delta} \cong (\hat{\mathcal{O}}_H)_{(u)}/(\bar{t})$, that is, the natural number a such that $(\bar{t}) = (u)^a$ (note that $(\hat{\mathcal{O}}_H)_{(u)}$ is a discrete valuation ring with uniformizing parameter u). To conclude the proof, it suffices to compute the number a in all cases.

Assume first that $\mathcal{D} = \mathcal{D}_{i,I}$. Since $\mathcal{D}_{i,I}$ does not contain the general point of any boundary divisor of $\mathcal{U}_{g,n}$ other than $\delta_{i,I} \cap \mathcal{U}_{g,n}$, we need only consider the case when $\delta = \delta_{i,I} \cap \mathcal{U}_{g,n}$. Then $t = t_1$, and the image of $d\xi_{\mathcal{D}_{i,I}}$ at $(C; D)$ is the hyperplane $t_1 = 0$ (recall that clutching maps are unramified by [22, Corollary 3.9]). By Lemma 5.5, we know that $\mathcal{D}_{i,I}$ intersects $\mathcal{U}_{g,n}$ transversely at $(C; D)$. This means exactly that $\bar{t}_1 \in \mathfrak{m} \setminus \mathfrak{m}^2$, and so we may complete \bar{t}_1 to a system of regular parameters for $\hat{\mathcal{O}}_H$. In particular, (\bar{t}_1) is a prime ideal, hence $a = 1$. This proves the first equality.

Assume now that $\mathcal{D} = \mathcal{D}_{irr,n}$. Set-theoretically, $\mathcal{D}_{irr,n} \cap \mathcal{U}_{g,n}$ coincides with the union of all the $\eta_{i,I} \cap \mathcal{U}_{g,n}$ and $\eta_{irr,n} \cap \mathcal{U}_{g,n}$. If $\delta = \eta_{irr,n} \cap \mathcal{U}_{g,n}$, then $t = t_1$ and $a = 1$, the proof being identical to that of the previous case.

Consider the case when $\delta = \eta_{i,I} \cap \mathcal{U}_{g,n}$. Then $t = t_1 t_2$, and the image of $d\xi_{\mathcal{D}_{i,I}}$ at $(C; D)$ is the union of the hyperplanes $t_1 = 0$ and $t_2 = 0$. By Lemma 5.5, the clutching map $\xi_{\mathcal{D}_{irr,n}}$ is transverse to $\mathcal{U}_{g,n}$ at $(C; D)$, hence both hyperplanes are transverse to $\mathcal{U}_{g,n}$ at $(C; D)$. As before, this means that $\bar{t}_1, \bar{t}_2 \in \mathfrak{m} \setminus \mathfrak{m}^2$, and so (\bar{t}_1) and (\bar{t}_2) are prime ideals. It follows that $(\bar{t}_1) = (u) = (\bar{t}_2)$, hence $(\bar{t}_1 \bar{t}_2) = (u)^2$ and $a = 2$. This proves the second equality. \square

6. PROOF OF THEOREM 1.1(B)

To complete the proof of Theorem 1.1, we will use the method of test curves, as explained in [17, Lemma 3.94], in conjunction with Proposition 5.6.

Proof of Theorem 1.1(b). By Proposition 5.1, it suffices to prove that ψ -classes and irreducible boundary divisors are linearly independent in $\text{Cl}(\overline{\mathcal{H}}_{g,n})_{\mathbb{Q}}$. Since $\mathcal{U}_{g,n}$ is smooth and its complement has codimension 2, we have $\text{Cl}(\overline{\mathcal{H}}_{g,n})_{\mathbb{Q}} = \text{Cl}(\mathcal{U}_{g,n})_{\mathbb{Q}} = \text{Pic}(\mathcal{U}_{g,n})_{\mathbb{Q}}$. Let

$$(6.1) \quad D = \sum a_i \psi_i + \sum b_{i,I} \delta_{i,I} + c_{irr,n} \eta_{irr,n} + \sum c_{i,I} \eta_{i,I} \in \text{Pic}(\mathcal{U}_{g,n})_{\mathbb{Q}}$$

and assume that $D = 0$. We may assume that all the coefficients are integers. We will show that each coefficient is zero by computing the degree of D on suitable families of test curves. In order to compute degrees, we need to make sure that our test families are entirely contained in $\mathcal{U}_{g,n}$.

By Theorem 1.1(a), the ψ -classes are independent in $\text{Pic}(\mathcal{H}_{g,n})_{\mathbb{Q}}$, hence restriction to $\mathcal{H}_{g,n}$ shows that $a_i = 0$ for each $i = 0, \dots, n$. We split the rest of the proof in several lemmas.

Lemma 6.1. *We have $b_{0,I} = 0$ if $|I| = 2$.*

Proof. Let C be a smooth hyperelliptic curve of genus g , and let p_1, \dots, p_{n-1} be distinct points of C . Denote by X the blow-up of $C \times C$ at $(p_1, p_1), \dots, (p_{n-1}, p_{n-1})$. For $1 \leq h \leq n-1$, let σ_h be the proper transform of $\{p_h\} \times C$ in X , and let σ_n be the proper transform of the diagonal in $C \times C$. Letting $\pi : X \rightarrow C$ be the composition of the blow-up $X \rightarrow C \times C$ and the second projection $C \times C \rightarrow C$, we obtain a family $\rho_1 = (\pi : X \rightarrow C; \sigma_1, \dots, \sigma_n)$ of n -pointed stable hyperelliptic curves of genus g . Note that ρ_1 is contained in $\mathcal{H}_{g,n}^{rt}$, hence in $\mathcal{U}_{g,n}$. By Proposition 5.6 and [17, Lemma 3.94], we see that for this family

$$\delta_{0,\{h,n\}}(\rho_1) = j^* \mathcal{D}_{0,\{h,n\}}(\rho_1) = \mathcal{O}_C(p_h), \quad 1 \leq h \leq n-1,$$

and all other divisors are trivial. We obtain the relation

$$\mathcal{O}_C\left(\sum_{h=1}^{n-1} b_{0,\{h,n\}} p_h\right) = 0.$$

The points $p_h \in C$ were arbitrarily chosen, therefore $b_{0,\{h,n\}} = 0$ for $h = 1, \dots, n-1$. Changing order of the sections, we obtain $b_{0,I} = 0$ for every I of cardinality 2, as desired. \square

Lemma 6.2. *We have $b_{0,I} = 0$ for every I such that $|I| \geq 2$.*

Proof. Recall that in order for $\delta_{0,I}$ to exist, we must have $|I| \geq 2$. Assume that I does not contain n . Consider a smooth hyperelliptic curve C_1 of genus g , a smooth rational curve C_2 , and let $q_1 \in C_1$ and $q_2 \in C_2$. Consider distinct points p_j on C_1 different from q_1 , one for each $j \in I^c$, $j \neq n$, and distinct points p_h on C_2 different from q_2 , one for each $h \in I$. Let X be the blow-up of $C_1 \times C_1$ at (q_1, q_1) and (p_j, p_j) for all $j \in I^c$, $j \neq n$. Glue X and $C_2 \times C_1$ along the proper transform of $\{q_1\} \times C_1$ in X and $\{q_2\} \times C_1$. Let σ_j be the proper transform of $\{p_j\} \times C_1$ for $j \in I^c$, $j \neq n$, let σ_h be the proper transform of $\{p_h\} \times C_1$ for $h \in I$, and let σ_n be the proper transform of the diagonal of $C_1 \times C_1$. This gives a family $(Y \rightarrow C_1; \sigma_1, \dots, \sigma_n)$, which we call ρ_2 . Note that ρ_2 is entirely contained in $\mathcal{H}_{g,n}^{rt}$.

The glueing of the proper transform of $\{q_1\} \times C_1$ and $\{q_2\} \times C_1$ corresponds to a node q in each fiber, such that σ_j belongs to the component of genus 0 through q if and only if $j \in I$; there are no isolated nodes with the same property. The self-intersection of $\{q_1\} \times C_1$ and $\{q_2\} \times C_1$ is zero, and blowing up decreases the self-intersection by one, so by Proposition 5.6 and [17, Lemma 3.94]:

$$\deg_{\rho_2} \delta_{i,I} = -1.$$

For every $j \in I^c$, $j \neq n$, there is exactly one fiber admitting a node q' , such that σ_j and σ_n belong to the component of genus 0 through q' , and no other section does. Finally, there is one fiber consisting of a curve of genus g and a tree with two

rational components, such that σ_j marks the tree if and only if $\sigma \in I \cup \{n\}$. By Proposition 5.6 and [17, Lemma 3.94]:

$$\deg_{\rho_2} \delta_{0, I \cup \{n\}} = 1, \quad \deg_{\rho_2} \delta_{0, \{j, n\}} = 1 \quad (j \in I^c, j \neq n),$$

and the other divisors have degree zero. By Lemma 6.1 $b_{0, \{j, n\}} = 0$, it follows that $b_{0, I} = b_{0, I \cup \{n\}}$. Permuting sections and letting I vary, we deduce that $b_{0, I}$ is independent of I . By Lemma 6.1, we conclude that $b_{0, I} = 0$ for every I . \square

In [3, Theorem XIII.8.4], where the independence of boundary divisors is shown for $\overline{\mathcal{H}}_g$ (see [8, §4.(b)] for the original proof), one-parameter families F_1, \dots, F_{2g} of unmarked stable hyperelliptic curves of genus g are constructed, such that the general fiber is smooth and:

- (i) any singular fiber of F_1 has one node of type η_{irr} , and no other node;
- (ii) for $i \geq 1$, any singular fiber of F_{2i+1} either has a pair of nodes of type η_i , and no other node, or has a node of type η_{irr} , and no other node;
- (iii) for $i \geq 1$, any singular fiber of F_{2i} either has a node of type δ_i , and no other node, or has a node of type η_{irr} , and no other node.

We now endow suitably modified versions of the F_h with n sections, and use them as test curves.

Lemma 6.3. *We have $c_{irr, n} = 0$.*

Proof. We start by recalling the construction of F_1 ; see [3, Theorem XIII.8.4] for more details. In $\mathbb{P}^1 \times \mathbb{P}^1$, consider general divisors B_1, B_2 of bidegree $(1, 1)$, general divisors B_3, \dots, B_{2g+2} of bidegree $(1, 0)$, and set $B := \sum B_h$. Then B has bidegree $(2g+2, 2)$ and its singular locus B^s consists of $4g+2$ nodes. If R is the blow-up of $\mathbb{P}^1 \times \mathbb{P}^1$ at B^s , and D_j are the proper transforms of the B_j , the family $R \rightarrow \mathbb{P}^1$ induced by the second projection is a family of nodal curves of genus 0, stable when marked with the D_j . Moreover, $\mathcal{O}(\sum D_j)$ is a square, hence one may consider the double cover $X \rightarrow R$ branched along the D_j . The composition $X \rightarrow R \rightarrow \mathbb{P}^1$ is a family of (unmarked) semistable curves; c.f. [3, p. 392]. Using the stable model construction (see [3, Proposition X.6.7]), one may contract the unstable rational components in $X \rightarrow \mathbb{P}^1$, to obtain a family of hyperelliptic stable curves over \mathbb{P}^1 , called F_1 . By construction, F_1 is as in (i).

Let now $k \geq 0$, and consider k points p_1, \dots, p_k in \mathbb{P}^1 . If we require the p_j to be sufficiently general, then the $\{p_j\} \times \mathbb{P}^1$ are not contained in B , and do not intersect B^s . Let $C_j \subseteq X$ be the inverse image of the strict transform of $\{p_j\} \times \mathbb{P}^1$. It is a ramified double cover of \mathbb{P}^1 , possibly split. Now a base change along a suitable ramified cover $C \rightarrow \mathbb{P}^1$ produces a family $X' = X \times_{\mathbb{P}^1} C \rightarrow C$, together with $2k$ disjoint sections of $X' \rightarrow C$. For example, if $C_1 \rightarrow \mathbb{P}^1$ is not already split, one might base change via the map $C_1 \rightarrow \mathbb{P}^1$ itself to split it, then do the same for the base change of $C_2 \rightarrow \mathbb{P}^1$ to C_1 , and so on. Note that the curves appearing as fibers of $X' \rightarrow C$ are the same as those appearing in $X \rightarrow \mathbb{P}^1$. The stable model construction of [3, Proposition X.6.7] also applies to pointed curves. It yields a family F'_1 of $2k$ -pointed stable hyperelliptic curves over C , such that every fiber is stable as an unmarked curve, the general fiber is smooth, and the singular fibers have exactly one node, which is of type η_{irr} . Since k was arbitrary, we may assume that $2k \geq n$, and after forgetting some sections we obtain a family contained in $\mathcal{H}_{g, n}^c$, hence in $\mathcal{U}_{g, n}$. By Proposition 5.6 and [17, Lemma 3.94], it follows that

$\deg_{F'_1}(\eta_{irr,n}) = \deg_{F'_1}(\mathcal{D}_{irr,n}) > 0$, and the degree of every other divisor is zero. We have $0 = \deg_{F'_1}(D) = c_{irr,n} \deg_{F'_1}(\mathcal{D}_{irr,n})$, hence $c_{irr,n} = 0$. \square

Lemma 6.4. *We have $c_{i,I} = 0$ for every $i \geq 1$ and every I .*

Proof. We first recall the construction of F_{2i+1} . Let $p \in \mathbb{P}^1 \times \mathbb{P}^1$ be a point, and choose divisors B_1, \dots, B_{2i+2} of bidegree $(1, 1)$, generic among those passing through p , and general divisors $B_{2i+3}, \dots, B_{2g+2}$ of bidegree $(1, 0)$. Set $B := \sum B_j$. The singular locus B^s of B consists of an ordinary $(2i + 2)$ -fold point at p , and $(i + 1)(4g - 2i + 1)$ nodes. Let $R \rightarrow \mathbb{P}^1 \times \mathbb{P}^1$ be the blow-up at B^s . If D_j is the proper transform of B_j , then $\mathcal{O}(\sum D_j)$ is a square, hence we may consider the two-sheeted double covering $X \rightarrow R$ ramified at the D_j . The composition of $X \rightarrow R \rightarrow \mathbb{P}^1 \times \mathbb{P}^1$ with the second projection $\text{pr}_2 : \mathbb{P}^1 \times \mathbb{P}^1 \rightarrow \mathbb{P}^1$ is a family of semi-stable curves, and we let F_{2i+1} be its stable model. By construction, F_{2i+1} is as in (ii).

Let now $h, k \geq 0$, and consider h general points $p_1, \dots, p_h \in \mathbb{P}^1$ and k divisors $L_{h+1}, \dots, L_{h+k} \subseteq \mathbb{P}^1 \times \mathbb{P}^1$ of bidegree $(1, 1)$ passing through p . By choosing the configuration to be sufficiently general, we may assume that all intersections between the B_j , the L_j , and the $\{p_j\} \times \mathbb{P}^1$ are transverse, that all intersection points other than p are nodes mapping to different points of \mathbb{P}^1 under pr_2 , and that all intersections are transversal.

For $j = 1, \dots, h$, denote by $C_j \subseteq X$ the inverse image of the proper transform of $\{p_j\} \times \mathbb{P}^1$, and for $j = h + 1, \dots, k$ let $C_j \subseteq X$ be the inverse image of the proper transform of L_j . The C_j are ramified double covers of \mathbb{P}^1 . As in the proof of Lemma 6.3, using the C_j we construct a ramified cover $C \rightarrow \mathbb{P}^1$ such that the pullback of C_j along $C \rightarrow \mathbb{P}^1$ splits as the disjoint union of two sections σ_j^+ and σ_j^- . We denote by $X' \rightarrow C$ the base change of $X \rightarrow \mathbb{P}^1$ along $C \rightarrow \mathbb{P}^1$.

Let $\Gamma \subseteq X$ be the fiber of $X \rightarrow \mathbb{P}^1$ at $\text{pr}_2(p)$. Then Γ is a stable nodal curve of genus g with a pair of nodes of type η_i , and no other nodes. It is the only fiber of $X \rightarrow \mathbb{P}^1$ with a pair of nodes of type η_i . Moreover, the C_j intersect Γ in the genus i component when $1 \leq j \leq h$, and in the genus $g - i - 1$ component when $h + 1 \leq j \leq h + k$. Thus, in every fiber of $X' \rightarrow C$ isomorphic to Γ , the σ_j^\pm mark the genus i component when $1 \leq j \leq h$, and the genus $g - i - 1$ component when $h + 1 \leq j \leq h + k$. We now pick h and k such that $2h \geq |I|$ and $2k \geq |I^c|$. For every $m \in I$ we let σ_m be one of the σ_j^\pm ($1 \leq j \leq h$), and for every $m \in I^c$ we let σ_m be one of the σ_j^\pm ($h + 1 \leq j \leq h + k$), in such a way that each σ_j^\pm is selected at most once.

By our genericity requirement, all the intersections between the C_j are transverse, and the morphism $C \rightarrow \mathbb{P}^1$ is unramified at the images of the intersection points. Therefore, the intersections between the σ_m belong to a smooth fiber of $X' \rightarrow C$ and are transverse. Blowing up the intersection points of the σ_m , we obtain a family of semistable n -pointed curves $X'' \rightarrow C$ marked by the proper transforms ϵ_m of the σ_m . After blow-up, some smooth fibers of $X' \rightarrow C$ acquire a smooth rational component with two markings in $X'' \rightarrow C$; the other fibers are unchanged. Let $F'_{2i+1} := (X''' \rightarrow C; \tau_1, \dots, \tau_n)$ be the stable model of $(X'' \rightarrow C; \epsilon_1, \dots, \epsilon_n)$; see [3, Proposition X.6.7]. It is a family of stable n -pointed hyperelliptic curves of genus g with the following properties:

- the general fiber is smooth;

- a singular fiber either admits a pair of nodes of type η_i and no other node, or exactly one node of type η_{irr} , or is the union of a smooth curve of genus g and a smooth rational curve with exactly two markings;
- for every fiber admitting a pair of nodes of type η_i , a section τ_j marks the component of genus i if and only if $j \in I$.

In particular, F'_{2i+1} is entirely contained in $\mathcal{U}_{g,n}$.

By Proposition 5.6 and [17, Lemma 3.94], $\deg_{F'_{2i+1}}(\eta_{i,I}) = 2 \deg_{F'_{2i+1}}(\mathcal{D}_{irr,n}) > 0$. By Lemma 6.1 and Lemma 6.3, we have $0 = \deg_{F'_{2i+1}}(D) = c_{i,I} \deg_{F'_{2i+1}}(\eta_{i,I})$, hence $c_{i,I} = 0$, as desired. \square

Lemma 6.5. *We have $b_{i,I} = 0$ for every $i \geq 1$ and every I .*

Proof. The proof is essentially the same as that of Lemma 6.4, using the families F_{2i} of [3, Theorem XIII.8.4] instead of the F_{2i+1} . \square

Combining all the steps, we get $D = 0$ in $\text{Pic}(\mathcal{U}_{g,n})_{\mathbb{Q}}$. This completes the proof of Theorem 1.1. \square
