# On Gauss codes of virtual doodles

#### Abstract

We discuss Gauss codes of virtual diagrams and virtual doodles. The notion of a left canonical Gauss code is introduced and it is shown that oriented virtual doodles are uniquely presented by left canonical Gauss codes.


Keywords: Gauss codes; doodles; virtual doodles; virtual diagrams; left canonical Gauss codes.

## 1 Introduction

A virtual diagram is a generically immersed 1 -manifold in $\mathbb{R}^{2}$ such that the crossings are classified into two families, real crossings and virtual crossings. A virtual crossing is depicted by a crossing encircled with a small circle. Throughout this paper, we only consider a case that the 1 -manifold is a circle and we assume that a virtual diagram is oriented, as a 1-manifold.

For a virtual diagram $D$ with $n(>0)$ real crossings, removing an open regular neibourhood of the real crossings, we have a collection of $2 n$ immersed arcs. We call them semiarcs of $D$. If two virtual diagrams $D$ and $D^{\prime}$ are identical except for a semiarc of $D$ and a semiarc of $D^{\prime}$, then we say that $D^{\prime}$ is obtained from $D$ by a detour move.

Two virtual diagrams are called strictly equivalent if they are related by a finite sequence of detour moves and isotopies of $\mathbb{R}^{2}$. Two virtual diagrams are strictly equivalent if and only if they are related by a finite sequence of moves depicted in Figures 17 and 2 and isotopies of $\mathbb{R}^{2}$ (cf. [1, []). The moves are referred to as $V R_{1}, V R_{2}, V R_{3}$ and $V R_{4}$, which are flat versions of virtual Reidemeister moves in virtual knot theory [8].

For a virtual diagram $D$, let $\operatorname{rev}(D)$ or $-D$ denote the virtual diagram obtained from $D$ by reversing the orientation as a 1 -manifold.

We denote by $\operatorname{Diagram}_{\text {strict }}(n)$ the set of virtual diagrams with $n$ real crossings modulo strict equivalence, and by $\operatorname{Diagram}_{\text {strict+rev }}(n)$ the set of virtual diagrams with $n$ real crossings modulo strict equivalence and reversing orientations.

A virtual diagram can be described by a sequence called a Gauss code (see Section 21). Such a sequence is not unique. We introduce the notion of a left canonical Gauss code.

Theorem 1.1. There are bijections

\operatorname{Diagram}_{\text {strict }}(n) \longleftrightarrow \operatorname{Gauss}^{\mathrm{LC}}(n) \tag{1}
\end{equation*}
$$

and

$$
\begin{equation*}
\operatorname{Diagram}_{\text {strict }+\mathrm{rev}}(n) \longleftrightarrow \operatorname{Gauss}_{\mathrm{rev}}^{\mathrm{LC}}(n) \tag{2}
\end{equation*}
$$

where $\mathbf{G a u s s}{ }^{\mathrm{LC}}(n)$ is the set of left canonical Gauss codes with $n$ letters. The set $\mathbf{G a u s s}_{\mathrm{rev}}^{\mathrm{LC}}(n)$ is explained later.

We refer to the moves depicted in Figure 3 as $R_{1}$ and $R_{2}$, which are flat versions of Reidemeister moves of type 1 and type 2.

Two virtual diagrams are orientedly doodle-equivalent if they are related by a finite sequence of moves $R_{1}, R_{2}, V R_{1}, V R_{2}, V R_{3}, V R_{4}$ and isotopies of $\mathbb{R}^{2}$, or equivalently if they are related by a finite sequence of moves $R_{1}, R_{2}$, detour moves and isotopies of

$\mathbb{R}^{2}$. Two virtual diagrams $D$ and $D^{\prime}$ are unorintedly doodle-equivalent if $D$ is orientedly equivalent to $D^{\prime}$ or $\operatorname{rev}\left(D^{\prime}\right)$, i.e., they are related by a finite sequence of $R_{1}, R_{2}, V R_{1}$, $V R_{2}, V R_{3}, V R_{4}$ and isotopies of $\mathbb{R}^{2}$ and reversing orientations.

Definition 1.2 ([1). An oriented (or unoriented) virtual doodle is an oriented (or unoriented) doodle-equivalence class of virtual diagrams.

When virtual crossings are not allowed, virtual doodles are doodles in the original sense defined by the second author and P. Taylor [3] and by M. Khovanov [7].

It is proved in [1] that there is a natural bijection between the set of oriented (or unoriented) virtual doodles and the set of oriented (or unoriented) doodles on surfaces. This fact is analogous to the fact that there is a natural bijection between the set of oriented (or unoriented) virtual knots and the set of stably equivalence classes of oriented (or unoriented) knot diagrams on surfaces (cf. [2, 6]).

A virtual diagram is minimal if we cannot apply any $R_{1}$ or $R_{2}$ move even after changing diagrams up to strict equivalence.

Theorem 1.3 ([1]). An oriented (or unoriented) virtual doodle has a unique minimal representative. That is, any oriented (or unoriented) virtual doodle can be represented by a minimal virtual diagram and such a diagram is unique up to strict equivalence (or up to strict equivalence and reversing orientations).

This is analogous to Kuperberg's theorem on virtual knots [9].
Theorem 1.3 states that there are bijections

\text { Doodle }_{\text {ori }} \longleftrightarrow \text { Diagram }_{\text {strict }}^{\min } \tag{3}
\end{equation*}
$$

and

$$
\begin{equation*}
\text { Doodle }_{\text {unori }} \longleftrightarrow \text { Diagram }_{\text {strict+rev }}^{\min } \tag{4}
\end{equation*}
$$

where Doodle ${ }_{\text {ori }}$ (or Doodle unori) ) is the set of oriented (or unoriented) virtual doodles and Diagram ${ }_{\text {strict }}^{\min }$ (or Diagram strict $+\mathrm{rev}_{\min }$ ) is the set of minimal virtual diagrams modulo strict equivalence (or modulo strict equivalence and reversing orientations).

The minimum real crossing number of an oriented (or unoriented) virtual doodle is the minimum number among the numbers of real crossings of all virtual diagrams representing the oriented (or unoriented) virtual doodle.

Let Doodle $_{\text {ori }}(n)$ (or Doodle unori $(n)$ ) be the restriction of Doodle $_{\text {ori }}\left(\right.$ or Doodle $\left._{\text {unori }}\right)$ to those with minimum real crossing number $n$, and let $\operatorname{Diagram}_{\text {strict }}^{\min }(n)\left(\right.$ or $\left.\operatorname{Diagram}_{\text {strict+rev }}^{\min }(n)\right)$ be the restriction of Diagram ${ }_{\text {strict }}^{\min }$ (or Diagram strict+rev $_{\min }$ ) to those with real crossing number $n$.

Then Theorem 1.3 implies that there are bijections

$$
\begin{equation*}
\operatorname{Doodle}_{\text {ori }}(n) \longleftrightarrow \text { Diagram }_{\text {strict }}^{\min }(n) \tag{5}
\end{equation*}
$$

and

$$
\begin{equation*}
\operatorname{Doodle}_{\text {unori }}(n) \longleftrightarrow \text { Diagram }_{\text {strict+rev }}^{\min }(n) \tag{6}
\end{equation*}
$$

On the other hand, the bijections in (1) and (2) implies
Theorem 1.4. There are bijections

$$
\begin{equation*}
\operatorname{Diagram}_{\text {strict }}^{\min }(n) \longleftrightarrow \mathbf{G a u s s}^{\min , \mathrm{LC}}(n) \tag{7}
\end{equation*}
$$

and

$$
\begin{equation*}
\operatorname{Diagram}_{\mathrm{strict+rev}}^{\min }(n) \longleftrightarrow \operatorname{Gauss}_{\mathrm{rev}}^{\min , \mathrm{LC}}(n) \tag{8}
\end{equation*}
$$

where Gauss ${ }^{\min , L C}(n)$ is the set of minimal and left canonical Gauss codes with $n$ letters. The set $\mathrm{Gauss}_{\mathrm{rev}}^{\min , \mathrm{LC}}(n)$ is explained later.

Combining these, we have
Theorem 1.5. There are bijections

$$
\begin{equation*}
\operatorname{Doodle}_{\text {ori }}(n) \longleftrightarrow \text { Diagram }_{\text {strict }}^{\min }(n) \longleftrightarrow \text { Gauss }^{\min , L C}(n) \tag{9}
\end{equation*}
$$

and

$$
\begin{equation*}
\operatorname{Doodle}_{\text {unori }}(n) \longleftrightarrow \operatorname{Diagram}_{\text {strict }+\mathrm{rev}}^{\min }(n) \longleftrightarrow \operatorname{Gauss}_{\mathrm{rev}}^{\min , \mathrm{LC}}(n) \tag{10}
\end{equation*}
$$

This paper is organized as follows: We introduce Gauss codes for virtual diagrams in Section 2, left preferred Gauss codes in Section 3 and left canonical Gauss codes in Section 4. Theorem 1.1 is proved in Section 4. In Section 5 we discuss minimal Gauss codes and prove Theorem 1.4. Section 6 is devoted to demonstration of making a list of virtual doodles using Theorem 1.5. In Section 7 we summarize the results we have seen for virtual diagrams and virtual doodles, and then we introduce canonical orientations for unoriented virtual diagrams and unoriented virtual doodles. In Section 8 arrow diagrams for virtual doodles are discussed.

## 2 Gauss codes

A Gauss code on $n$ letters is a sequence $x_{1} x_{2} \ldots x_{2 n}$ of length $2 n$ such that each $x_{i}$ is an element of

J=\{(1, L),(1, R),(2, L),(2, R), . .,(n, L),(n, R)\}
$$

and all elements of $J$ appear in the sequence.
Let $D$ be a virtual diagram. Let $c$ be a real crossing of $D$ and let $N(c)$ be a regular neighbourhood of $c$. The intersection of $D$ and $N(c)$ is a pair of two oriented short arcs intersecting transversely at $c$. We call the arcs the branches at $c$.

- As we move through a real crossing along $D$ on a branch $b$, if the other branch of the real crossing passes from the left to the right (or right to the left), then the branch $b$ is called a left branch (or a right branch).

Let $D$ be a virtual diagram with $n(>0)$ real crossings. It is decomposed into $2 n$ branches and $2 n$ semiarcs. We denote by $X(D), B(D)$ and $A(D)$ the set of real crossings, the branches and the semiarcs of D , respectively.

A labeling of real crossings of $D$ is a bijection $f: X(D) \rightarrow\{1, \ldots, n\}$ from the real crossings to integers $1, \ldots, n$.

For a labeling of real crossings $f: X(D) \rightarrow\{1, \ldots, n\}$, there is a unique bijection $F: B(D) \rightarrow J$ such that for each branch $b, F(b)$ is $(j, L)$ or $(j, R)$ where $j$ is $f$ of the real crossing on the branch $b$ and the second component means that the branch is a left $(L)$ or right $(R)$ branch. We call the map $F: B(D) \rightarrow J$ the $J$-labeling of branches of $D$ associated with $f$ and the value $F(b)$ the $J$-label of $b$ associated with $f$.

Take a semiarc $a_{0}$ of $D$, which we call a base semiarc.
Fix a base semiarc $a_{0}$ of $D$ and a labeling $f$ of real crossings. Let $b_{1}, \ldots, b_{2 n}$ be branches at real crossings of $D$ appearing in this order as we move along $D$ from $a_{0}$.

The Gauss code of $D$ is defined as a sequence $w=x_{1} x_{2} \ldots x_{2 n}$ such that for each $i \in\{1, \ldots, 2 n\}, x_{i}$ is the $J$-label of the $i$-th branch $b_{i}$ associated with $f$, i.e., it is $(j, L)$ or $(j, R)$ where $j$ is $f$ of the real crossing on $b_{i}$, and $L$ or $R$ in the second component means that $b_{i}$ is a left or right branch.

It depends on the base semiarc $a_{0}$ and the labeling $f$ of real crossings. When we do not specify the base semiarc or the labeling of real crossings, it is just called a Gauss code of $D$.

If two virtual diagrams $D$ and $D^{\prime}$ equipped a base semiarc and a labeling of real crossings are related by detour moves with respect to the base semiarc and the labeling of real crossings, then their Gauss codes are the same. Thus the Gauss code is also defined for a strict equivalence class of virtual diagrams equipped with a base semiarc and a labeling of real crossings.

Proposition 2.1. There is a bijection from the set of strict equivalence classes of virtual diagrams with $n$ real crossings equipped with a base semiarc and a labeling of real crossings to the set of Gauss codes on $n$ letters.

Proof. For a Gauss code on $n$ letters, a virtual diagram equipped with a base semiarc and a labeling of real crossings is constructed as follows: Let $w=x_{1} x_{2} \ldots x_{2 n}$ be a Gauss code. Consider $n$ mutually disjoint discs $N_{1}, \ldots, N_{n}$ on $\mathbb{R}^{2}$ and consider a pair of oriented, properly embedded arcs in each disc $N_{j}, j=1, \ldots, n$, intersecting transversely at a point. We assume that the pair of arcs have $J$-labels $(j, L)$ and $(j, R)$. Connect these arcs in $N_{1}, \ldots, N_{n}$ by using $2 n$ immersed arcs outside of $N_{1}, \ldots, N_{n}$ to obtain a virtual diagram with the Gauss code $w=x_{1} x_{2} \ldots x_{2 n}$. (All crossings of the immersed arcs outside of $N_{1}, \ldots, N_{n}$ are considered as virtual crossings.)

Suppose that two diagrams $D$ and $D^{\prime}$ equipped with a base semiarc and a labeling of real crossings have the same Gauss code. By an isotopy of $\mathbb{R}^{2}$ we assume that they are identical near the real crossings with the same label. The difference of $D$ and $D^{\prime}$ are
semiarcs, and the connection of branches by the semiarcs of $D$ is the same with that of $D^{\prime}$. Thus $D$ and $D^{\prime}$ are strictly equivalent with respect to the base point and the labeling of real crossings.

We have considered the Gauss code for a virtual diagram equipped with a base semiarc and a labeling of real crossings. When we change the base semiarc and the labeling of real crossings, the Gauss code is transformed by a simple rule. Let us observe this.

Let Gauss $(n)$ be the set of Gauss codes on $n$ letters.
For a permutation $\pi$ of $\{1,2, \ldots, n\}$, define a map

$$
\begin{equation*}
\pi_{*}: \operatorname{Gauss}(n) \rightarrow \operatorname{Gauss}(n) \tag{11}
\end{equation*}
$$

as follows: For a Gauss code $w, \pi_{*}(w)$ is the Gauss code such that if the $i$-th element of $w$ is $(j, L)$ (or $(j, R)$ ) then the $i$-th element is $(\pi(j), L)$ (or $(\pi(j), R)$ ) for each $i \in\{1, \ldots, 2 n\}$.

For an integer $m(\in\{0,1, \ldots, 2 n-1\})$, define a map

$$
\begin{equation*}
\operatorname{shift}[m]: \operatorname{Gauss}(n) \rightarrow \operatorname{Gauss}(n) \tag{12}
\end{equation*}
$$

as follows: For a Gauss code $w=x_{1} x_{2} \ldots x_{2 n}, \operatorname{shift}[m](w)$ is the Gauss code

$$
x_{m+1} x_{m+2} \ldots x_{2 n} x_{1} x_{2} \ldots x_{m}
$$

Define a map

$$
\begin{equation*}
\text { rev : } \operatorname{Gauss}(n) \rightarrow \operatorname{Gauss}(n) \tag{13}
\end{equation*}
$$

as follows: For a Gauss code $w=x_{1} x_{2} \ldots x_{2 n}$, let $\operatorname{rev}(w)=x_{2 n} \ldots x_{2} x_{1}$.
The following lemma is obtained directly from the definition and we leave the proof to the reader.
Lemma 2.2. Let $D$ be a virtual digram with $n$ real crossings.
(1) Fix a base semiarc $a_{0}$ on $D$. Let $w$ and $w^{\prime}$ be the Gauss codes of $D$ with respect to labelings $f$ and $f^{\prime}$ of real crossings, respectively. Then $w^{\prime}=\left(f^{\prime} \circ f^{-1}\right)_{*}(w)$.
(2) Fix a labeling of real crossings. Let $w$ and $w^{\prime}$ be the Gauss codes of $D$ with respect to base semiarcs $a_{0}$ and $a_{0}^{\prime}$, respectively. Let $m$ be the number of branches we meet when we move along $D$ from $a_{0}$ to $a_{0}^{\prime}$. Then $w^{\prime}=\operatorname{shift}[m](w)$.
(3) Fix a base semiarc $a_{0}$ on $D$ and a labeling of real crossings. Let $w$ and $w^{\prime}$ be the Gauss codes of $D$ and $\operatorname{rev}(D)$. Then $w^{\prime}=\operatorname{rev}(w)$.
Definition 2.3. Two Gauss codes on $n$ letters $w$ and $w^{\prime}$ are orientedly equivalent if there is a permutation $\pi$ and an integer $m$ such that $w^{\prime}=\operatorname{shift}[m] \circ \pi_{*}(w)$. Two Gauss codes on $n$ letters $w$ and $w^{\prime}$ are unorientedly equivalent if $w$ is orientedly equivalent to $w^{\prime}$ or $\operatorname{rev}\left(w^{\prime}\right)$.

Let $\operatorname{Gauss}_{\text {ori }}(n)$ (or $\left.\operatorname{Gauss}_{\text {unori }}(n)\right)$ denote the oriented (or unoriented) equivalence classes of Gauss codes on $n$ letters. There are consecutive natural projections

$$
\begin{equation*}
\operatorname{Gauss}(n) \rightarrow \operatorname{Gauss}_{\text {ori }}(n) \rightarrow \operatorname{Gauss}_{\text {unori }}(n) \tag{14}
\end{equation*}
$$

Proposition 2.4. There are bijections

$$
\begin{equation*}
\operatorname{Diagram}_{\text {strict }}(n) \longleftrightarrow \operatorname{Gauss}_{\text {ori }}(n) \quad \text { and } \quad \operatorname{Diagram}_{\text {strict+rev }}(n) \longleftrightarrow \operatorname{Gauss}_{\text {unori }}(n) \tag{15}
\end{equation*}
$$

Proof. This is a consequence of Proposition 2.1 and Lemma 2.2.

## 3 Left preferred Gauss codes

Definition 3.1. Let $w=x_{1} x_{2} \ldots x_{2 n}$ be a Gauss code. It is weakly left preferred if $(1, L)(2, L) \ldots(n, L)$ is a subsequence. It is left preferred if it is weakly left preferred and $x_{1}=(1, L)$.

Let Gauss ${ }^{\text {LP }}(n)$ be the set of left preferred Gauss codes with $n$ letters.
First we consider a map

$$
\begin{equation*}
\operatorname{proj}^{\mathrm{LP}}: \mathbf{G a u s s}(n) \rightarrow \operatorname{Gauss}^{\mathrm{LP}}(n) . \tag{16}
\end{equation*}
$$

Let $w=x_{1} x_{2} \ldots x_{2 n}$ be a Gauss code on $n$ letters. Let $\left(j_{1}, L\right)\left(j_{2}, L\right) \ldots\left(j_{n}, L\right)$ be the subsequence of $w$ obtained by removing elements whose second component is $R$. Let $\pi$ be a permutation of $(1, \ldots, n)$ which sends $j_{1}, j_{2}, \ldots, j_{n}$ to $1,2, \ldots, n$, respectively. Then $\pi_{*}(w)$ is weakly left preferred. Let $m$ be an integer in $\{1, \ldots, 2 n\}$ such that the $m$-th element of $\pi_{*}(w)$ is $(1, L)$. Apply shift $[m-1]$ to $\pi_{*}(w)$, and we have a left preferred Gauss code. This is the definition of $\operatorname{proj}^{\mathrm{LP}}(w)$. By definition, $w$ and $\operatorname{proj}^{\mathrm{LP}}(w)$ are orientedly equivalent Gauss codes.

If $w \in \operatorname{Gauss}^{\mathrm{LP}}(n)$ then $\operatorname{proj}^{\mathrm{LP}}(w)=w$. In particular, $\operatorname{proj}^{\mathrm{LP}}\left(\operatorname{proj}^{\mathrm{LP}}(w)\right)=\operatorname{proj}^{\mathrm{LP}}(w)$ for any Gauss code $w$.

By a direct computation we see that for any Gauss code $w$,

$$
\begin{equation*}
\operatorname{proj}^{\mathrm{LP}}(\operatorname{rev}(w))=\operatorname{proj}^{\mathrm{LP}}\left(\operatorname{rev}\left(\operatorname{proj}^{\mathrm{LP}}(w)\right)\right) . \tag{17}
\end{equation*}
$$

Define a map

$$
\begin{equation*}
\operatorname{shift}^{\mathrm{LP}}: \operatorname{Gauss}^{\mathrm{LP}}(n) \rightarrow \text { Gauss }^{\mathrm{LP}}(n) \tag{18}
\end{equation*}
$$

by

$$
\begin{equation*}
\operatorname{shift}^{\mathrm{LP}}(w)=\operatorname{proj}^{\mathrm{LP}}(\operatorname{shift}[1](w)) \tag{19}
\end{equation*}
$$

Let $w=x_{1} x_{2} \ldots x_{2 n}$ be a left preferred Gauss code. Assume $n \geq 2$. Let $m$ be an integer with $x_{m}=(2, L)$ and let $\pi$ be a permutation of $\{1, \ldots, n\}$ sending $i$ to $i-1 \bmod$ $n$ for each $i \in\{1, \ldots, n\}$. Then $\operatorname{shift}^{\mathrm{LP}}(w)=\operatorname{shift}[m-1] \circ \pi_{*}(w)$.

Remark 3.2. When $n \geq 2$, for each $k=1, \ldots, n-1$,

$$
\begin{equation*}
\left(\operatorname{shift}^{\mathrm{LP}}\right)^{k}: \operatorname{Gauss}^{\mathrm{LP}}(n) \rightarrow \operatorname{Gauss}^{\mathrm{LP}}(n) \tag{20}
\end{equation*}
$$

is computed as follows. Let $w=x_{1} x_{2} \ldots x_{2 n}$ be a left preferred Gauss code. Let $m$ be an integer with $x_{m}=(k+1, L)$ and let $\pi$ be a permutation of $\{1, \ldots, n\}$ sending $i$ to $i-k$ $\bmod n$ for each $i \in\{1, \ldots, n\}$. Then $\left(\operatorname{shift}^{\mathrm{LP}}\right)^{k}(w)=\operatorname{shift}[m-1] \circ(\pi)_{*}(w)$.

Example 3.3. Let $w=(1, L)(2, R)(2, L)(3, R)(1, R)(3, L) \in$ Gauss $^{\mathrm{LP}}(3)$. Then

$$
\begin{align*}
w & =(1, L)(2, R)(2, L)(3, R)(1, R)(3, L), \\
\operatorname{shift}^{\mathrm{LP}}(w) & =(1, L)(2, R)(3, R)(2, L)(3, L)(1, R),  \tag{21}\\
\left(\operatorname{shift}^{\mathrm{LP}}\right)^{2}(w) & =(1, L)(2, L)(3, R)(3, L)(1, R)(2, R) .
\end{align*}
$$

We define a map

$$
\begin{equation*}
\operatorname{rev}^{\mathrm{LP}}: \operatorname{Gauss}^{\mathrm{LP}}(n) \rightarrow \operatorname{Gauss}^{\mathrm{LP}}(n) \tag{22}
\end{equation*}
$$

by

$$
\begin{equation*}
\operatorname{rev}^{\mathrm{LP}}(w)=\operatorname{proj}^{\mathrm{LP}}(\operatorname{rev}(w)) \tag{23}
\end{equation*}
$$

The maps shift ${ }^{\mathrm{LP}}$ and rev ${ }^{\mathrm{LP}}$ are bijections of Gauss ${ }^{\mathrm{LP}}(n)$ satisfying that

$$
\begin{equation*}
\left(\operatorname{shiff}^{\mathrm{LP}}\right)^{n}=1 \quad \text { and } \quad\left(\operatorname{rev}^{\mathrm{LP}}\right)^{2}=1 \tag{24}
\end{equation*}
$$

where 1 is the identity map.
Definition 3.4. Two left preferred Gauss codes on $n$ letters are orientedly equivalent as left preferred Gauss codes if they are in the same orbit by the group action generated by shift ${ }^{\mathrm{LP}}$. Two left preferred Gauss codes on $n$ letters are unorientedly equivalent as left preferred Gauss codes if they are in the same orbit by the group action generated by shift ${ }^{\text {LP }}$ and rev ${ }^{\text {LP }}$.

Theorem 3.5. Let $w$ and $w^{\prime}$ be Gauss codes on $n$ letters. They are orientedly (or unorientedly) equivalent as Gauss codes (Definition (2.3) if and only if $\operatorname{proj}^{\mathrm{LP}}(w)$ and $\operatorname{proj}^{\mathrm{LP}}\left(w^{\prime}\right)$ are orientedly (or unorientedly) equivalent as left preferred Gauss codes.

Proof. First we show the only if part.
(1) Suppose $w^{\prime}=\pi_{*}(w)$ for some permutation $\pi$. It is obvious that $\operatorname{proj}^{\mathrm{LP}}\left(w^{\prime}\right)=$ $\operatorname{proj}^{\mathrm{LP}}(w)$.
(2) Suppose that $w^{\prime}=\operatorname{shift}[1](w)$. Let $x_{1}$ be the first element of $w$. If $x_{1}=(j, R)$ for some $j$, then $\operatorname{proj}^{\mathrm{LP}}\left(w^{\prime}\right)=\operatorname{proj}^{\mathrm{LP}}(w)$. If $x_{1}=(j, L)$ for some $j$, then $\operatorname{proj}^{\mathrm{LP}}\left(w^{\prime}\right)=$ $\operatorname{shift}^{\mathrm{LP}}\left(\operatorname{proj}^{\mathrm{LP}}(w)\right)$.
(3) Suppose $w^{\prime}=\operatorname{rev}(w)$. By (17), we have

$$
\operatorname{proj}^{\mathrm{LP}}\left(w^{\prime}\right)=\operatorname{proj}^{\mathrm{LP}}(\operatorname{rev}(w))=\operatorname{proj}^{\mathrm{LP}}\left(\operatorname{rev}\left(\operatorname{proj}^{\mathrm{LP}}(w)\right)\right)=\operatorname{rev}^{\mathrm{LP}}\left(\operatorname{proj}^{\mathrm{LP}}(w)\right) .
$$

Therefore, we have the only if part.
We show the if part. Suppose that $\operatorname{proj}^{\mathrm{LP}}(w)$ and $\operatorname{proj}^{\mathrm{LP}}\left(w^{\prime}\right)$ are orientedly (or unorientedly) equivalent as left preferred Gauss codes. Then they are orientedly (or unorientedly) equivalent as Gauss codes. Note that $w$ and $\operatorname{proj}^{\mathrm{LP}}(w)$ are orientedly equivalent as Gauss codes, and so are $w^{\prime}$ and $\operatorname{proj}^{\mathrm{LP}}\left(w^{\prime}\right)$. Thus $w$ and $w$ are orientedly (or unorientedly) equivalent as Gauss codes.

Corollary 3.6. Two left preferred Gauss codes are orientedly (or unorientedly) equivalent as Gauss codes if and only if they are orientedly (or unorientedly) equivalent as left preferred Gauss codes.

Let $\operatorname{Gauss}_{\text {ori }}^{\mathrm{LP}}(n)\left(\right.$ or $\left.\operatorname{Gauss}_{\text {unori }}^{\mathrm{LP}}(n)\right)$ be the set of oriented (or unoriented) equivalence classes of left preferred Gauss codes on $n$ letters.
Theorem 3.7. The projection map $\operatorname{proj}^{\mathrm{LP}}: \operatorname{Gauss}(n) \rightarrow \operatorname{Gauss}^{\mathrm{LP}}(n)$ induces bijections:

$$
\begin{equation*}
\operatorname{Gauss}_{\text {ori }}(n) \longleftrightarrow \operatorname{Gauss}_{\text {ori }}^{\mathrm{LP}}(n) \quad \text { and } \quad \boldsymbol{G a u s s}_{\text {unori }}(n) \longleftrightarrow \operatorname{Gauss}_{\text {unori }}^{\mathrm{LP}}(n) . \tag{25}
\end{equation*}
$$

Proof. It follows from Theorem 3.5.

## 4 Left canonical Gauss codes

We fix an order on $J$ with

$$
\begin{equation*}
(1, L)<(1, R)<(2, L)<(2, R)<\cdots<(n, L)<(n, R) \tag{26}
\end{equation*}
$$

and assume that $\operatorname{Gauss}(n)$ and its subset $\operatorname{Gauss}^{\mathrm{LP}}(n)$ are ordered sets with a lexicographical order using the order of $J$.

For a left preferred Gauss code $w$ with $n$ letters, the oriented equivalence class of $w$ as left preferred Gauss codes, $[w]_{\text {ori }}^{\mathrm{LP}} \in \operatorname{Gauss}_{\text {ori }}^{\mathrm{LP}}(n)$, is given by

$$
\begin{equation*}
[w]_{\mathrm{ori}}^{\mathrm{LP}}=\left\{w, \operatorname{shift}^{\mathrm{LP}}(w),\left(\operatorname{shift}^{\mathrm{LP}}\right)^{2}(w), \ldots,\left(\operatorname{shift}^{\mathrm{LP}}\right)^{n-1}(w)\right\} \tag{27}
\end{equation*}
$$

Definition 4.1. A left canonical Gauss code is a left preferred Gauss code w such that it is the smallest element in $[w]_{\text {ori }}^{\mathrm{LP}}$, the oriented equivalence class as left preferred Gauss codes. The left canonical representative of an oriented equivalence class of left preferred Gauss codes is the smallest representative.

For example, let $w=(1, L)(2, R)(2, L)(3, R)(1, R)(3, L)$ (as in Example 3.3). Then

$$
\begin{align*}
w & =(1, L)(2, R)(2, L)(3, R)(1, R)(3, L) \\
\operatorname{shift}^{\mathrm{LP}}(w) & =(1, L)(2, R)(3, R)(2, L)(3, L)(1, R)  \tag{28}\\
\left(\operatorname{shift}^{\mathrm{LP}}\right)^{2}(w) & =(1, L)(2, L)(3, R)(3, L)(1, R)(2, R)
\end{align*}
$$

The smallest element is $(1, L)(2, L)(3, R)(3, L)(1, R)(2, R)$. It is the left canonical representative of $[w]_{\text {ori }}^{\text {LP }}$ and it is a left canonical Gauss code. The other two Gauss codes $w$ and $\operatorname{shift}^{\mathrm{LP}}(w)$ are not left canonical Gauss codes.

Let Gauss ${ }^{\mathrm{LC}}(n)$ be the set of left canonical Gauss codes of $n$ letters. Sending oriented equivalence classes of left preferred Gauss codes to their left canonical representatives, we have a bijection

$$
\begin{equation*}
\operatorname{Gauss}_{\mathrm{ori}}^{\mathrm{LP}}(n) \longleftrightarrow \text { Gauss }^{\mathrm{LC}}(n) \tag{29}
\end{equation*}
$$

We define a map

$$
\begin{equation*}
\operatorname{proj}^{\mathrm{LC}}: \operatorname{Gauss}(n) \rightarrow \operatorname{Gauss}^{\mathrm{LC}}(n) \tag{30}
\end{equation*}
$$

by sending a Gauss code $w$ to the left canonical representative of the oriented equivalence class $\left[\operatorname{proj}^{\mathrm{LP}}(w)\right]_{\text {ori }}^{\mathrm{LP}}$ of $\operatorname{proj}^{\mathrm{LP}}(w)$.

For example, let $w=(1, L)(2, R)(2, L)(3, R)(1, R)(3, L)$ as above. Then $\operatorname{proj}^{\mathrm{LC}}(w)=$ $(1, L)(2, L)(3, R)(3, L)(1, R)(2, R)$.

If $w \in \operatorname{Gauss}^{\mathrm{LC}}(n)$ then $\operatorname{proj}^{\mathrm{LC}}(w)=w$. In particular, for any Gauss code $w$, $\operatorname{proj}^{\mathrm{LC}}\left(\operatorname{proj}^{\mathrm{LC}}(w)\right)=\operatorname{proj}^{\mathrm{LC}}(w)$.

By Proposition 2.4. Theorem 3.7 and the bijection in (29), we obtain a bijection

$$
\begin{equation*}
\operatorname{Diagram}_{\text {strict }}(n) \longleftrightarrow \text { Gauss }^{\mathrm{LC}}(n) \tag{31}
\end{equation*}
$$

which is claimed in Theorem 1.1
We define a map

$$
\begin{equation*}
\operatorname{rev}^{\mathrm{LC}}: \operatorname{Gauss}^{\mathrm{LC}}(n) \rightarrow \mathbf{G a u s s}^{\mathrm{LC}}(n) \tag{32}
\end{equation*}
$$

by

$$
\begin{equation*}
\operatorname{rev}^{\mathrm{LC}}(w)=\operatorname{proj}^{\mathrm{LC}}(\operatorname{rev}(w)) \tag{33}
\end{equation*}
$$

Let $\operatorname{Gauss}_{\mathrm{rev}}^{\mathrm{LC}}(n)$ be the quotient of $\operatorname{Gauss}^{\mathrm{LC}}(n)$ by the action of rev ${ }^{\mathrm{LC}}$, i.e., the elements of $\operatorname{Gauss}_{\mathrm{rev}}^{\mathrm{LC}}(n)$ are $\left\{w, \operatorname{rev}^{\mathrm{LC}}(w)\right\}$ for $w \in \operatorname{Gauss}^{\mathrm{LC}}(n)$.

Let $w$ be a left preferred Gauss code with $n$ letters. The unoriented equivalence class of $w$ as left preferred Gauss codes, $[w]_{\text {unori }}^{\mathrm{LP}} \in \operatorname{Gauss}_{\text {unori }}^{\mathrm{LP}}(n)$, is given by

$$
\begin{align*}
{[w]_{\text {unori }}^{\mathrm{LP}}=} & {[w]_{\text {ori }}^{\mathrm{LP}} \cup\left[w^{\prime}\right]_{\text {ori }}^{\mathrm{LP}} } \\
= & \left\{w, \operatorname{shift}^{\mathrm{LP}}(w),\left(\operatorname{shift}^{\mathrm{LP}}\right)^{2}(w), \ldots,\left(\operatorname{shift}^{\mathrm{LP}}\right)^{n-1}(w)\right\}  \tag{34}\\
& \cup\left\{w^{\prime}, \operatorname{shift}^{\mathrm{LP}}\left(w^{\prime}\right),\left(\operatorname{shift}^{\mathrm{LP}}\right)^{2}\left(w^{\prime}\right), \ldots,\left(\operatorname{shift}^{\mathrm{LP}}\right)^{n-1}\left(w^{\prime}\right)\right\},
\end{align*}
$$

where $w^{\prime}=\operatorname{rev}^{\mathrm{LP}}(w)=\operatorname{proj}^{\mathrm{LP}}(\operatorname{rev}(w))$. Then $\left\{\operatorname{proj}^{\mathrm{LC}}(w), \operatorname{proj}{ }^{\mathrm{LC}}(\operatorname{rev}(w))\right\}$ is an element of Gauss ${ }_{\text {rev }}^{\mathrm{LC}}(n)$.

We have a bijection

$$
\begin{equation*}
\operatorname{Gauss}_{\mathrm{unori}}^{\mathrm{LP}}(n) \longleftrightarrow \operatorname{Gauss}_{\mathrm{rev}}^{\mathrm{LC}}(n) \tag{35}
\end{equation*}
$$

by sending $[w]_{\text {unori }}^{\text {LP }} \in$ Gauss $_{\text {unori }}^{\text {LP }}(n)$ to $\left\{\operatorname{proj}^{\mathrm{LC}}(w), \operatorname{proj}^{\mathrm{LC}}(\operatorname{rev}(w))\right\}$ for any $w \in \operatorname{Gauss}^{\mathrm{LP}}(n)$.
By Proposition 2.4. Theorem 3.7 and the bijection in (35), we obtain a bijection

$$
\begin{equation*}
\operatorname{Diagram}_{\text {strict+rev }}(n) \longleftrightarrow \operatorname{Gauss}_{\mathrm{rev}}^{\mathrm{LC}}(n) \tag{36}
\end{equation*}
$$

which is claimed in Theorem 1.1.
Definition 4.2. The left canonical representative of an unoriented equivalence class of left preferred Gauss codes is the smallest representative.

In other words, for any left preferred Gauss code $w$, the left canonical representative of $[w]_{\text {unori }}^{\mathrm{LP}}$ is the smaller one between the left canonical representative $\operatorname{proj}^{\mathrm{LC}}(w)$ of $[w]_{\text {ori }}^{\mathrm{LP}}$ and the left canonical representative $\operatorname{proj}^{\mathrm{LC}}(\operatorname{rev}(w))$ of $\left[\operatorname{rev}^{\mathrm{LP}}(w)\right]_{\text {ori }}^{\mathrm{LP}}$.

## 5 Minimal Gauss codes

We discuss minimal Gauss codes, which are Gauss codes of minimal virtual diagrams representing virtual doodles.

For a Gauss code $w=x_{1} x_{2} \ldots x_{2 n}$, we assume that $x_{2 n+1}$ is $x_{1}$.
A Gauss code $w=x_{1} x_{2} \ldots x_{2 n}$ is 1-reducible if there is an integer $i \in\{1, \ldots, 2 n\}$ such that

$$
\left(x_{i}, x_{i+1}\right)=((j, L),(j, R)) \quad \text { or } \quad((j, R),(j, L))
$$

for some $j$. Otherwise, it is called 1-irreducible.
A Gauss code $w=x_{1} x_{2} \ldots x_{2 n}$ is 2 -reducible if one of the following holds:
(1) There are integers $i, i^{\prime} \in\{1, \ldots, 2 n\}$ such that

$$
\begin{equation*}
\left(x_{i}, x_{i+1}\right)=((j, L),(k, R)) \quad \text { and } \quad\left(x_{i^{\prime}}, x_{i^{\prime}+1}\right)=((j, R),(k, L)) \tag{37}
\end{equation*}
$$

for some $j \neq k$.
(2) There are integers $i, i^{\prime} \in\{1, \ldots, 2 n\}$ such that

$$
\begin{equation*}
\left(x_{i}, x_{i+1}\right)=((j, L),(k, R)) \quad \text { and } \quad\left(x_{i^{\prime}}, x_{i^{\prime}+1}\right)=((k, L),(j, R)) \tag{38}
\end{equation*}
$$

or

$$
\begin{equation*}
\left(x_{i}, x_{i+1}\right)=((j, R),(k, L)) \quad \text { and } \quad\left(x_{i^{\prime}}, x_{i^{\prime}+1}\right)=((k, R),(j, L)) \tag{39}
\end{equation*}
$$

for some $j \neq k$.
Otherwise, it is called 2-irreducible.
We say that $w$ is minimal or irreducible if it is 1 -irreducible and 2-irreducible.
Lemma 5.1. Let $D$ be a virtual diagram and $w$ a Gauss code of $D$. Then $D$ is minimal if and only if $w$ is minimal.

Proof. It is easily verified that a move $R_{1}$ can be applied to $D$ (after applying detour moves if necessary) if and only if $w$ is 1 -reducible and that a move $R_{2}$ can be applied to $D$ (after applying detour moves if necessary) if and only if $w$ is 2-reducible.

Note that if a Gauss code $w$ is minimal then any Gauss code which is orientedly (or unorientedly) equivalent to $w$ is minimal.

Let $\operatorname{Gauss}_{\text {ori }}^{\min }(n)$ (or $\left.\operatorname{Gauss}_{\text {unori }}^{\min }(n)\right)$ denote the set of minimal Gauss codes with $n$ letters modulo oriented (or unoriented) equivalence.

Proposition 5.2. There are bijections

$$
\begin{equation*}
\operatorname{Diagram}_{\text {strict }}^{\min }(n) \longleftrightarrow \operatorname{Gauss}_{o r i}^{\min }(n) \quad \text { and } \quad \operatorname{Diagram}_{\text {strict+rev }}^{\min }(n) \longleftrightarrow \operatorname{Gauss}_{\text {unori }}^{\min }(n) \tag{40}
\end{equation*}
$$

Proof. By Proposition 2.4 and Lemma 5.1, we have the result.
Let Gauss ${ }^{\text {min,LP }}(n)$ be the set of minimal and left preferred Gauss codes with $n$ letters.
If $w$ is minimal, then so is $\operatorname{proj}^{\mathrm{LP}}(w)$. We denote by the same symbols for the restriction of the maps proj ${ }^{\mathrm{LP}}$, shift ${ }^{\mathrm{LP}}$ and $\mathrm{rev}^{\mathrm{LP}}$ to minimal Gauss codes:

$$
\begin{array}{rll}
\operatorname{proj}^{\mathrm{LP}}: & \operatorname{Gauss}^{\min }(n) & \rightarrow \operatorname{Gauss}^{\min , \mathrm{LP}}(n), \\
\operatorname{shift}^{\mathrm{LP}}: & \operatorname{Gauss}^{\min , \mathrm{LP}}(n) & \rightarrow \operatorname{Gauss}^{\min , \mathrm{LP}}(n), \quad \text { and }  \tag{41}\\
\operatorname{rev}^{\mathrm{LP}}: & \operatorname{Gauss}^{\min , \mathrm{LP}}(n) & \rightarrow \operatorname{Gauss}^{\min , \mathrm{LP}}(n) .
\end{array}
$$

Let Gauss ${ }_{\mathrm{ori}}^{\min , \mathrm{LP}}(n)$ (or Gauss $\left.{ }_{\text {unori }}^{\min , L P}(n)\right)$ be the set of oriented (or unoriented) equivalence classes of minimal and left preferred Gauss codes on $n$ letters.

Theorem 5.3. The projection map $\operatorname{proj}^{\mathrm{LP}}: \operatorname{Gauss}^{\min }(n) \rightarrow$ Gauss $^{\min , \mathrm{LP}}(n)$ induces bijections:

$$
\begin{equation*}
\operatorname{Gauss}_{\mathrm{ori}}^{\min }(n) \longleftrightarrow \text { Gauss }_{\mathrm{ori}}^{\min , \mathrm{LP}}(n) \quad \text { and } \quad \operatorname{Gauss}_{\mathrm{unori}}^{\min }(n) \longleftrightarrow \text { Gauss }_{\text {unori }}^{\min , \mathrm{LP}}(n) \tag{42}
\end{equation*}
$$

Proof. It follows from Theorem 3.5 (cf. Theorem 3.7).

Let Gauss ${ }^{\min , L C}(n)$ be the set of minimal and left canonical Gauss codes of $n$ letters.
If $w$ is minimal, then so is $\operatorname{proj}^{\mathrm{LC}}(w)$. We denote by the same symbols for the restriction of the maps proj ${ }^{\mathrm{LC}}$ and $\mathrm{rev}^{\mathrm{LC}}$ to minimal Gauss codes:

$$
\begin{array}{rll}
\operatorname{proj}^{\mathrm{LC}}: \operatorname{Gauss}^{\min }(n) & \rightarrow \text { Gauss }^{\min , \mathrm{LC}}(n) \quad \text { and } \\
\operatorname{rev}^{\mathrm{LC}}: \operatorname{Gauss}^{\min , \mathrm{LC}}(n) & \rightarrow \operatorname{Gauss}^{\min , \mathrm{LC}}(n) . \tag{43}
\end{array}
$$

Let Gauss ${ }_{\text {rev }}^{\min , L C}(n)$ be the quotient of $\operatorname{Gauss}^{\min , \mathrm{LC}}(n)$ by the action of rev ${ }^{\mathrm{LC}}$, i.e., the elements of $\mathbf{G a u s s}_{\mathrm{rev}}^{\min , \mathrm{LC}}(n)$ are $\left\{w, \operatorname{rev}^{\mathrm{LC}}(w)\right\}$ for $w \in \operatorname{Gauss}^{\min , \mathrm{LC}}(n)$. Note that $\operatorname{Gauss}_{\mathrm{rev}}^{\min , \mathrm{LC}}(n)$ is the subset of $\operatorname{Gauss}_{\mathrm{rev}}^{\mathrm{LC}}(n)$ consisting of elements $\left\{w, \operatorname{rev}^{\mathrm{LC}}(w)\right\}$ for $w \in$ Gauss $^{\text {min,LC }}(n)$.

Considering the restrictions of the bijections in Theorem 1.1, we have bijections

$$
\operatorname{Diagram}_{\text {strict }}^{\min }(n) \longleftrightarrow \text { Gauss }^{\min , \mathrm{LC}}(n)
$$

and

$$
\operatorname{Diagram}_{\mathrm{strict}+\mathrm{rev}}^{\min }(n) \longleftrightarrow \operatorname{Gauss}_{\mathrm{rev}}^{\min , \mathrm{LC}}(n),
$$

which are claimed in Theorem 1.4,

## 6 Making a list of virtual doodles

By Theorem 1.5 or Theorem 5.3, in order to make a list of Doodle $_{\text {ori }}(n)$, we may use Gauss ${ }^{\min , L C}(n)$ or Gauss ${ }_{\text {ori }}^{\min , L P}(n)$.

Here is a way to make a list of Gauss ${ }^{\min , \mathrm{LC}}(n)$ or $\operatorname{Gauss}_{\text {ori }}^{\min , \mathrm{LP}}(n)$.

- Make a list of the elements of Gauss ${ }^{\text {LP }}(n)$. Removing elements which are 1-reducible or 2-reducible, we have a list of Gauss ${ }^{\min , L P}(n)$.
- Let $G[1]=$ Gauss $^{\text {min,LP }}(n)$. Take the smallest element, say $w_{1}$, of $G[1]$. Make a list of all elements that are orientedly equivalent to $w_{1}$, which are

$$
w_{1}, \operatorname{shift}^{\mathrm{LP}}\left(w_{1}\right),\left(\operatorname{shift}^{\mathrm{LP}}\right)^{2}\left(w_{1}\right), \ldots,\left(\operatorname{shift}^{\mathrm{LP}}\right)^{n-1}\left(w_{1}\right)
$$

Remove them from $G[1]$ and let $G[2]$ be the result.

- Inductively, assume that $G[k]$ is already defined. If $G[k]$ is non-empty, take the smallest element, say $w_{k}$, of $G[k]$. Make a list of all elements that are orientedly equivalent to $w_{k}$. Remove them from $G[k]$ and let $G[k+1]$ be the result.
- This procedure must finish when we have $G[m+1]=\emptyset$ for some $m$. Then $\left\{w_{1}, \ldots, w_{m}\right\}$ is a list of representatives of all elements of Gauss ${ }_{\text {ori }}^{\min , L P}(n)$. Moreover, $\left\{w_{1}, \ldots, w_{m}\right\}$ is a list of the elements of Gauss ${ }^{\text {min }, \mathrm{LC}}(n)$.

Once we have a list of Gauss ${ }^{\min , L C}(n)$ or Gauss ${ }_{\text {ori }}^{\min , L P}(n)$, using rev ${ }^{\text {LC }}$ or rev ${ }^{\text {LP }}$, we have a list of $\mathbf{G a u s s}_{\text {rev }}^{\min , L C}(n)$ or Gauss ${ }_{\text {unori }}^{\min , L P}(n)$.

Example 6.1. Let us consider a case of $n=3$. The order on $J$ is

$$
\begin{equation*}
(1, L)<(1, R)<(2, L)<(2, R)<(3, L)<(3, R) \tag{44}
\end{equation*}
$$

For simplicity, we put

$$
\begin{equation*}
1=(1, L), \quad 2=(1, R), \quad 3=(2, L), \quad 4=(2, R), \quad 5=(3, L), \quad 6=(3, R) . \tag{45}
\end{equation*}
$$

For example, $w=(1, L)(2, R)(2, L)(3, L)(1, R)(3, R)$ is denoted by $(1,4,3,5,2,6)$. In this notation, $w=\left(m_{1}, m_{2}, \ldots, m_{6}\right)$ is left preferred if and only if its subsequence consisting of odd numbers is $(1,3,5)$ and $m_{1}=1$.

Let GLP $\left(=\right.$ Gauss $\left.^{\mathrm{LP}}(3)\right)$ be the set of elements $\left(m_{1}, m_{2}, \ldots, m_{6}\right)$ which are left preferred. It consists of 60 elements:

\text { PrepA2 }:=\{(1,2),(1,3),(2,1),(2,3),(3,1),(3,2)\} \tag{48}
\end{equation*}
$$

which is the set of pairs $(i, j)$ with $i \neq j$ and $1 \leq i, j \leq 3$. For an element $a \in \operatorname{PrepA2}$, we denote by $a[1]$ and $a[2]$ the first and second components of $a$.

Let A2 be a set consisting of all $\left(\left(p_{1}, p_{2}\right),\left(q_{1}, q_{2}\right)\right)$ with $1 \leq p_{1}, p_{2}, q_{1}, q_{2} \leq 6$ such that
(i) $\left(\left(p_{1}, p_{2}\right),\left(q_{1}, q_{2}\right)\right)=((2 a[1]-1,2 a[2]),(2 a[1], 2 a[2]-1)$ for some $a \in \operatorname{PrepA2}$,
(ii) $\left(\left(p_{1}, p_{2}\right),\left(q_{1}, q_{2}\right)\right)=((2 a[1]-1,2 a[2]),(2 a[2]-1,2 a[1])$ for some $a \in \operatorname{PrepA2}$, or
(iii) $\left(\left(p_{1}, p_{2}\right),\left(q_{1}, q_{2}\right)\right)=((2 a[1], 2 a[2]-1),(2 a[2], 2 a[1]-1)$ for some $a \in \operatorname{PrepA2}$.

Then A2 consists of

In the notation, $\left(m_{1}, m_{2}, \ldots, m_{6}\right)$ is 2-reducible if and only if there are integers $i$ and $j$ in $\{1, \ldots, 6\}$ such that $\left(\left(m_{i}, m_{i+1}\right),\left(m_{j}, m_{j+1}\right)\right)$ belongs to A2. Here we assume $m_{7}=m_{1}$.

Let GLPmin ( $=$ Gauss $^{\text {min,LP }}(3)$ ) be the set of elements $\left(m_{1}, m_{2}, \ldots, m_{6}\right)$ which are minimal and left preferred. It is obtained from GLP by removing all elements that are 1-reducible or 2-reducible.

The set GLPmin consists of
$(1,3,2,6,4,5),(1,3,5,2,6,4),(1,3,5,4,2,6),(1,3,6,4,2,5),(1,4,2,6,3,5),(1,6,4,2,3,5)$.
This is a complete list of Gauss ${ }^{\min , L P}(3)$. Now we consider oriented equivalence classes. For an element $w=\left(m_{1}, m_{2}, \ldots, m_{6}\right)$ of GLPmin, its oriented equivalence class is

$$
\left\{w, \quad \operatorname{shift}^{\mathrm{LP}}(w), \quad\left(\operatorname{shift}^{\mathrm{LP}}\right)^{2}(w)\right\}
$$

$\operatorname{shift}{ }^{\mathrm{LP}}(w)$ is obtained from $\left(m_{1}-2, m_{2}-2, \ldots, m_{6}-2\right)$ by rotation so that the first element becomes 1. Here 0 and -1 in $\left(m_{1}-2, m_{2}-2, \ldots, m_{6}-2\right)$ are identified with 6 and 5 respectively.
$\left(\operatorname{shift}^{\mathrm{LP}}\right)^{2}(w)$ is obtained from $\left(m_{1}-4, m_{2}-4, \ldots, m_{6}-4\right)$ by rotation so that the first element becomes 1 .

For example, the oriented equivalence class of $(1,3,2,6,4,5)$ is

\{(1,3,2,6,4,5), \quad(1,3,5,4,2,6), \quad(1,6,4,2,3,5)\}
$$

The smallest element is $(1,3,2,6,4,5)$, which is the left canonical representative of the class.

Let GLPminOri be the set of oriented equivalence classes of elements of GLPmin. It consists of two elements,
(1) $d_{3,1}^{+}=[(1,3,2,6,4,5)]_{\text {ori }}=\{(1,3,2,6,4,5), \quad(1,3,5,4,2,6), \quad(1,6,4,2,3,5)\}$,
(2) $d_{3,1}^{-}=[(1,3,5,2,6,4)]_{\text {ori }}=\{(1,3,5,2,6,4), \quad(1,3,6,4,2,5), \quad(1,4,2,6,3,5)\}$.
(The meaning of symbols $d_{3,1}^{+}$and $d_{3,1}^{-}$will be explained later.)
Note that $(1,3,2,6,4,5)$ and $(1,3,5,2,6,4)$ are left canonical Gauss codes and GLC, the set of left canobnical elements, is $\{(1,3,2,6,4,5),(1,3,5,2,6,4)\}$.

Now we consider unoriented equivalence classes.
We first translate the map rev ${ }^{\mathrm{LP}}:$ Gauss $^{\min , \mathrm{LP}}(3) \rightarrow$ Gauss $^{\text {min,LP }}(3)$ to a map

Let $\pi$ be a permutation of $\{1, \ldots, 6\}$ with

In general, let $\pi$ be a permutation of $\{1, \ldots, 2 n\}$ with

\pi(k)=2 n-k \quad(\text { for odd } k) \quad \text { and } \quad \pi(k)=2 n+2-k \quad(\text { for even } k) .
$$

For an element $w=\left(m_{1}, m_{2}, \ldots, m_{6}\right)$, let

$$
\pi_{*}(\operatorname{rev}(w))=\pi_{*}\left(m_{6}, \ldots, m_{2}, m_{1}\right)=\left(\pi\left(m_{6}\right), \ldots, \pi\left(m_{2}\right), \pi\left(m_{1}\right)\right) .
$$

It is weakly left preferred, i.e., the subsequence consisting of odd numbers is $(1,3,5)$. Apply a rotation to it, and we have a left preferred element. This is $\operatorname{rev}^{\mathrm{LP}}(w)$.

For example, for $w=(1,3,2,6,4,5)$,

\pi_{*}(\operatorname{rev}(1,3,2,6,4,5))=\pi_{*}(5,4,6,2,3,1)=(1,4,2,6,3,5),

This implies that $(1,3,2,6,4,5)$ is unorientedly equivalent to $(1,4,2,6,3,5)$. Therefore the unoriented equivalence class $[(1,3,2,6,4,5)]_{\text {unori }}$ of $(1,3,2,6,4,5)$ is the union of $[(1,3,2,6,4,5)]_{\text {ori }}$ and $[(1,4,2,6,3,5)]_{\text {ori }}$.

Let GLPminUnori be the set of unoriented equivalence classes of elements of GLPmin. It consists of a single element,

\text { (1) } d_{3,1}=[(1,3,2,6,4,5)]_{\text {unori }}=[(1,3,2,6,4,5)]_{\text {ori }} \cup[(1,4,2,6,3,5)]_{\text {ori }} \text {. }

The left canonical representative of the class $[(1,3,2,6,4,5)]_{\text {unori }}$ is $(1,3,2,6,4,5)$, since the smallest element of $[(1,3,2,6,4,5)]_{\text {ori }}$ is $(1,3,2,6,4,5)$ and that of $[(1,4,2,6,3,5)]_{\text {ori }}$ is $(1,3,5,2,6,4)$.

Therefore we see that GLPminOri $\left(=\right.$ Gauss $\left._{\text {ori }}^{\min , L P}(3)\right)$ consists of 2 elements

d_{3,1}^{+}=[(1,3,2,6,4,5)]_{\text {ori }} \quad \text { and } \quad d_{3,1}^{-}=[(1,3,5,2,6,4)]_{\text {ori }},

which stand for

[(1, L)(2, L)(1, R)(3, R)(2, R)(3, L)]_{\text {ori }} \quad \text { and } \quad[(1, L)(2, L)(3, L)(1, R)(3, R)(2, R)]_{\text {ori }},
$$

and the set GLPminUnori $\left(=\right.$ Gauss $\left._{\text {unori }}^{\min , L P}(3)\right)$ consists of a single element

$$
d_{3,1}=[(1,3,2,6,4,5)]_{\text {unoori }},
$$

which stands for

$$
[(1, L)(2, L)(1, R)(3, R)(2, R)(3, L)]_{\text {unori }} .
$$

The symbol $d_{3,1}$ means that it is the first element of GLPminUnori identified with Gauss ${ }_{\text {unori }}^{\min , \mathrm{LP}}(3)$. The smallest representative of $d_{3,1}$ is $(1,3,2,6,4,5) . d_{3,1}^{+}$and $d_{3,1}^{+}$are elements of GLPminOri identified with Gauss ${ }_{\text {ori }}^{\min , L P}(3)$ such that $d_{3,1}^{+}$is represented by the smallest element $(1,3,2,6,4,5)$ of $d_{3,1}$, and $d_{3,1}^{-}$is represented by $\operatorname{rev}^{\mathrm{LP}}(1,3,2,6,4,5)$.

Example 6.2. Let us consider a case of $n=4$. The order on $J$ is

Let GLP $\left(=\right.$ Gauss $\left.^{\text {LP }}(4)\right)$ be the set of elements $\left(m_{1}, m_{2}, \ldots, m_{8}\right)$ which are left preferred. It consists of 840 elements:

(i) $\left(\left(p_{1}, p_{2}\right),\left(q_{1}, q_{2}\right)\right)=((2 a[1]-1,2 a[2]),(2 a[1], 2 a[2]-1)$ for some $a \in \operatorname{PrepA2}$,
(ii) $\left(\left(p_{1}, p_{2}\right),\left(q_{1}, q_{2}\right)\right)=((2 a[1]-1,2 a[2]),(2 a[2]-1,2 a[1])$ for some $a \in \operatorname{PrepA2}$, or

Let GLPmin ( $=$ Gauss $^{\min , \mathrm{LP}}(4)$ ) be the set of elements $\left(m_{1}, m_{2}, \ldots, m_{8}\right)$ which are left preferred and minimal. It is obtained from GLP by removing all elements that are 1-reducible or 2-reducible.

The set GLPmin consists of 124 elements,

$\left(\operatorname{shift}^{\mathrm{LP}}\right)^{2}(w)$ is obtained from $\left(m_{1}-4, m_{2}-4, \ldots, m_{8}-4\right)$ by rotation so that the first element becomes 1 .
$\left(\operatorname{shift}^{\mathrm{LP}}\right)^{3}(w)$ is obtained from $\left(m_{1}-6, m_{2}-6, \ldots, m_{8}-6\right)$ by rotation so that the first element becomes 1 .

For each class listed above, the first element is the left canonical representative. Thus we also have a complete list of Gauss ${ }^{\text {min,LC }}(4)$.

Now we consider unoriented equivalence classes.
First we translate the map rev ${ }^{\mathrm{LP}}:$ Gauss $^{\min , \mathrm{LP}}(4) \rightarrow$ Gauss $^{\min , \mathrm{LP}}(4)$ to a map

$$
\operatorname{rev}^{\mathrm{LP}}: \mathbf{G L P m i n} \rightarrow \mathbf{G L P m i n}
$$

as follows. Let $\pi$ be a permutation of $\{1, \ldots, 8\}$ with
$\pi(1)=7, \quad \pi(2)=8, \quad \pi(3)=5, \quad \pi(4)=6, \quad \pi(5)=3, \quad \pi(6)=4, \quad \pi(7)=1, \quad \pi(8)=2$.

Recall that, in general, let $\pi$ be a permutation of $\{1, \ldots, 2 n\}$ with

$$
\pi(k)=2 n-k \quad(\text { for odd } k) \quad \text { and } \quad \pi(k)=2 n+2-k \quad(\text { for even } k) .
$$

For an element $w=\left(m_{1}, m_{2}, \ldots, m_{8}\right)$, let

$$
\pi_{*}(\operatorname{rev}(w))=\pi_{*}\left(m_{8}, \ldots, m_{2}, m_{1}\right)=\left(\pi\left(m_{8}\right), \ldots, \pi\left(m_{2}\right), \pi\left(m_{1}\right)\right)
$$

It is weakly left preferred, i.e., the subsequence consisting of odd numbers is $(1,3,5,7)$. Apply a rotation to it, and we have a left preferred element. This is $\operatorname{rev}^{\mathrm{LP}}(w)$.

For example, for $w=(1,3,2,4,5,7,6,8)$,

$$
\pi_{*}(\operatorname{rev}(1,3,2,4,5,7,6,8))=\pi_{*}(8,6,7,5,4,2,3,1)=(2,4,1,3,6,8,5,7),
$$

and $\operatorname{rev}^{\mathrm{LP}}(1,3,2,4,5,7,6,8)=(1,3,6,8,5,7,2,4)$.
This implies that $(1,3,2,4,5,7,6,8)$ is unorientedly equivalent to $(1,3,6,8,5,7,2,4)$. Therefore the unoriented equivalence class $[(1,3,2,4,5,7,6,8)]_{\text {unori }}$ of $(1,3,2,4,5,7,6,8)$ is the union of $[(1,3,2,4,5,7,6,8)]_{\text {ori }}$ and $[(1,3,6,8,5,7,2,4)]_{\text {ori }}$.

Let GLPminUnori be the set of unoriented equivalence classes of elements of GLPmin. It consists of 19 elements,

$$
\begin{aligned}

For each unoriented equivalence class listed above, the representative given there is the left canonical representative. Thus we also have a list of Gauss rev min, ${ }^{\min }(4)$.

Therefore we see that Gauss ${ }_{\text {ori }}^{\min , L P}(4)$ consists of 32 elements and the set Gauss ${ }_{\text {unori }}^{\min , L P}(4)$ consists of 19 elements.

## 7 Left canonical Gauss codes and orientations

In this section we first summarize the results we have seen for virtual diagrams and virtual doodles. Then we discuss canonical orientations for unoriented virtual diagrams and unoriented virtual doodles.

Let $D$ be a virtual diagram with $n(>0)$ real crossings. Let $w_{0}$ be a Gauss code of $D$ with respect to a base semiarc and a labeling of real crossings. Let $w=\operatorname{proj}^{\mathrm{LP}}\left(w_{0}\right)$, which is a left preferred Gauss code presenting $D$, where $\operatorname{proj}^{\mathrm{LP}}: \operatorname{Gauss}(n) \rightarrow \operatorname{Gauss}^{\mathrm{LP}}(n)$ is a map defined in Section 3. Then $w$ is also a Gauss code of $D$.

The oriented equivalence class of $w$ as left preferred Gauss codes is

$$
\begin{equation*}
[w]_{\text {ori }}^{\mathrm{LP}}=\left\{w, \operatorname{shift}^{\mathrm{LP}}(w),\left(\operatorname{shift}^{\mathrm{LP}}\right)^{2}(w), \ldots,\left(\operatorname{shift}^{\mathrm{LP}}\right)^{n-1}(w)\right\} \tag{53}
\end{equation*}
$$

and the unoriented equivalence class of $w$ as left preferred Gauss codes is

$$
\begin{align*}
{[w]_{\text {unori }}^{\mathrm{LP}}=} & {[w]_{\text {ori }}^{\mathrm{LP}} \cup\left[w^{\prime}\right]_{\text {ori }}^{\mathrm{LP}} } \\
= & \left\{w, \operatorname{shift}^{2 \mathrm{P}}(w),\left(\operatorname{shift}^{\mathrm{LP}}\right)^{2}(w), \ldots,\left(\operatorname{shift}^{\mathrm{LP}}\right)^{n-1}(w)\right\}  \tag{54}\\
& \cup\left\{w^{\prime}, \operatorname{shift}^{\mathrm{LP}}\left(w^{\prime}\right),\left(\operatorname{shift}^{\mathrm{LP}}\right)^{2}\left(w^{\prime}\right), \ldots,\left(\operatorname{shift}^{\mathrm{LP}}\right)^{n-1}\left(w^{\prime}\right)\right\},
\end{align*}
$$

where $w^{\prime}=\operatorname{rev}^{\mathrm{LP}}(w)=\operatorname{proj}^{\mathrm{LP}}(\operatorname{rev}(w))$.
Definition 7.1. The oriented left canonical Gauss code of $D$, denoted by $G_{\text {ori }}(D)$, is the smallest element of $[w]_{\text {ori }}^{\mathrm{LP}}$, i.e., $G_{\text {ori }}(D)=\operatorname{proj}^{\mathrm{LC}}(w)$.

The unoriented left canonical Gauss code of $D$, denoted by $G_{\text {unori }}(D)$, is the smallest element of $[w]_{\text {unori }}^{\mathrm{LP}}$, i.e., it is the smaller one between $\operatorname{proj}^{\mathrm{LC}}(w)$ and $\operatorname{proj}^{\mathrm{LC}}(\operatorname{rev}(w))$.

Theorem 1.1 may be restated as follows.
Theorem 7.2. Let $D$ and $D^{\prime}$ be virtual diagrams with $n$ real crossings.
(1) $D$ is strictly equivalent to $D^{\prime}$ if and only if $G_{\text {ori }}(D)=G_{\text {ori }}\left(D^{\prime}\right)$.
(2) $D$ is strictly equivalent to $D^{\prime}$ or $\operatorname{rev}\left(D^{\prime}\right)$ if and only if $G_{\text {unori }}(D)=G_{\text {unori }}\left(D^{\prime}\right)$.

More precisely, we have seen the following.
Let $w_{0}$ and $w_{0}^{\prime}$ be Gauss codes presenting $D$ and $D^{\prime}$, respectively, and let $w=$ $\operatorname{proj}^{\mathrm{LP}}\left(w_{0}\right)$ and $w^{\prime}=\operatorname{proj}^{\mathrm{LP}}\left(w_{0}^{\prime}\right)$. The following conditions are mutually equivalent.
(i) $D$ is strictly equivalent to $D^{\prime}$.
(ii) $w_{0}$ and $w_{0}^{\prime}$ are orientedly equivalent as Gauss codes.
(iii) $w$ and $w^{\prime}$ are orientedly equivalent as left preferred Gauss codes.
(iv) $[w]_{\text {ori }}^{\mathrm{LP}}=\left[w^{\prime}\right]_{\text {ori }}^{\mathrm{LP}}$.
(v) $G_{\text {ori }}(D)=G_{\text {ori }}\left(D^{\prime}\right)$.

By Proposition [2.4, we have (i) $\Leftrightarrow$ (ii). By Theorem 3.5 (or Theorem 3.7), we have (ii) $\Leftrightarrow$ (iii). (iii) $\Leftrightarrow$ (iv) $\Leftrightarrow$ (v) are obvious. Similarly we see that the following conditions are mutually equivalent.
(i) $D$ is strictly equivalent to $D^{\prime}$ or $\operatorname{rev}\left(D^{\prime}\right)$.
(ii) $w_{0}$ and $w_{0}^{\prime}$ are unorientedly equivalent as Gauss codes.
(iii) $w$ and $w^{\prime}$ are unorientedly equivalent as left preferred Gauss codes.
(iv) $[w]_{\text {unori }}^{\mathrm{LP}}=\left[w^{\prime}\right]_{\text {unori }}^{\mathrm{LP}}$.
(v) $G_{\text {unori }}(D)=G_{\text {unori }}\left(D^{\prime}\right)$.

Theorem 1.5 may be restated as follows.
Theorem 7.3. Let $D$ and $D^{\prime}$ be minimal virtual diagrams with $n$ real crossings.
(1) $D$ is orientedly equivalent to $D^{\prime}$ if and only if $G_{\text {ori }}(D)=G_{\text {ori }}\left(D^{\prime}\right)$.
(2) $D$ is unorientedly equivalent to $D^{\prime}$ if and only if $G_{\text {unori }}(D)=G_{\text {unori }}\left(D^{\prime}\right)$.

Definition 7.4. Let $K$ be an oriented (or unoriented) virtual doodle. The left canonical Gauss code of $K$, denoted by $G_{\text {ori }}(K)$ (or $G_{\text {unori }}(K)$ ), is $G_{\text {ori }}(D)$ (or $G_{\text {unori }}(D)$ ) for a minimal virtual diagram $D$ representing $K$.

Then Theorem 1.5 may be restated as follows.
Theorem 7.5. Let $K$ and $K^{\prime}$ be oriented (or unoriented) virtual doodles. $K=K^{\prime}$ if and only if $G_{\text {ori }}(K)=G_{\text {ori }}\left(K^{\prime}\right)\left(\right.$ or $\left.G_{\text {unori }}(K)=G_{\text {unori }}\left(K^{\prime}\right)\right)$.

Now we discuss canonical orientations for unoriented virtual diagrams and unoriented virtual doodles.

Let $D$ be a virtual diagram and let $|D|$ be the unoriented virtual diagram by forgetting the orientation. Let $G_{\text {ori }}(D)$ and $G_{\text {ori }}(\operatorname{rev}(D))$ be left canonical Gauss codes of $D$ and $\operatorname{rev}(D)$. If $G_{\text {ori }}(D) \leq G_{\text {ori }}(\operatorname{rev}(D))$ then we say that $D$ has a left canonical orientation for $|D|$. When $G_{\text {ori }}(D) \neq G_{\text {ori }}(\operatorname{rev}(D))$, there is a unique left canonical orientation for $|D|$. When $G_{\text {ori }}(D)=G_{\text {ori }}(\operatorname{rev}(D))$, there are two left canonical orientations for $|D|$.

Let $|K|$ be an unoriented virtual doodle. Let $D$ be a minimal virtual diagram representing $|K|$. If $D$ has a left canonical orientation for $|D|$, then we say that the oriented virtual doodle $K$ represented by $D$ has a left canonical orientation for $|K|$.

Proposition 7.6. For any unoriented virtual doodle, there is a unique left canonical orientation.

Proof. Let $D$ be a minimal virtual diagram representing an unoriented virtual doodle $|K|$. Let $K$ and $K^{\prime}$ be the oriented virtual doodles represented by $D$ and $\operatorname{rev}(D)$ respectively.

- If $G_{\text {ori }}(D)<G_{\text {ori }}(\operatorname{rev}(D))$, then $K$ has a left canonical orientation for $|K|$.
- If $G_{\text {ori }}(D)>G_{\text {ori }}(\operatorname{rev}(D))$, then $K^{\prime}$ has a left canonical orientation for $|K|$.
- If $G_{\text {ori }}(D)=G_{\text {ori }}(\operatorname{rev}(D))$, then $K=K^{\prime}$ and it has a left canonical orientation for $|K|$.


## 8 Arrow diagrams

We discuss arrow diagrams for virtual doodles. The notion of arrow diagrams for virtual doodles is analogous to the notion of Gauss diagrams for virtual knots. However the methods assigning orientations on arrows (or chords) are different.

Let $S^{1}$ be the unit circle in the $x y$-plane. Let $n$ is a positive integer and let $P_{1}, \ldots, P_{2 n}$ be points of $S^{1}$ such that $P_{i}=(\cos (i \pi / n+\pi / 2 n), \sin (i \pi / n+\pi / 2 n))$ for $i \in\{1, \ldots, 2 n\}$. We assume that $P_{2 n+1}$ is $P_{1}$.

An arrow is an oriented chord connecting two points of $P_{1}, \ldots, P_{2 n}$. An arrow diagram (with $n$ arrows) is the circle $S^{1}$ with $n$ arrows such that every point of $P_{1}, \ldots, P_{2 n}$ is a head or tail of an arrow.

Let $w=x_{1} x_{2} \ldots x_{2 n}$ be a Gauss code on $n$ letters. For each $i \in\{1, \ldots, 2 n\}$, assign the $i$-th element $x_{i}$ of $w$ to the point $P_{i}$. For each $j \in\{1, \ldots, n\}$, there is a pair of points in $P_{1}, \ldots, P_{2 n}$ to which $(j, L)$ and $(j, R)$ are assigned. Connect the two points by a chord, labeled $j$, and give an orientation to this chord from the point assigned $(j, R)$ to the point assigned $(j, L)$. Then we have an arrow diagram with $n$ arrows such that the arrows are labeled with integers $1, \ldots, n$. We call it the arrow diagram with labeled arrows of the Gauss code $w$. (We may forget the $J$-labels assigned to $P_{1}, \ldots, P_{2 n}$, since they are recovered from the labels of arrows.) By forgetting the labels on arrows, we have an arrow diagram without labels, which we call the arrow diagram of the Gauss code $w$.

Lemma 8.1. Let $w$ and $w^{\prime}$ be Gauss codes with $n$ letters and let $A$ and $A^{\prime}$ be the arrow diagrams of them.
(1) $w^{\prime}=\pi_{*}(w)$ for a permutation $\pi$ of $\{1, \ldots, n\}$ if and only if $A=A^{\prime}$.
(2) $w^{\prime}=\operatorname{shift}[m](w)$ for some integer $m$ if and only if $A^{\prime}$ is obtained from $A$ by rotation by $-m \pi / n$ radian.
(3) $w^{\prime}=\operatorname{rev}(w)$ if and only if $A^{\prime}$ is obtained from $A$ by reflection along the $x$-axis.

Proof. It is a direct consequence from the definition.
Let $\operatorname{Arrow}(n)$ be the set of arrow diagrams with $n$ arrows.
We say that an arrow diagram $A^{\prime}$ is obtained from an arrow diagram $A$ by a reflection if there is a line through the origin of the $x y$-plane along which the reflection changes $A$ into $A^{\prime}$.

The dihedral group $D_{2 n}$ with $4 n$ elements acts on $\operatorname{Arrow}(n)$ by rotations around the origin of the $x y$-plane by $m \pi / n$ radian rotation for $m \in\{0,1, \ldots, 2 n-1\}$ and $2 n$ reflections along lines through the origin. The action is generated by the rotation by $\pi / n$ radian and the reflection along the $x$-axis.

Let $\operatorname{Arrow}_{\text {rot }}(n)$ be the set of arrow diagrams with $n$ arrows modulo the rotations, and $\operatorname{Arrow}_{\text {rot+ref }}(n)$ the set of arrow diagrams with $n$ arrows modulo the rotations and the reflections. Namely, $\operatorname{Arrow}_{\text {rot }}(n)$ (or $\operatorname{Arrow}_{\text {rot+ref }}(n)$ ) is the quotient of $\operatorname{Arrow}(n)$ by the cyclic action by the rotations (or by the whole actions of the dihedral group.)

We have the following.

Proposition 8.2. There are bijections:

$$
\begin{equation*}
\operatorname{Diagram}_{\text {strict }}(n) \longleftrightarrow \operatorname{Gauss}_{\text {ori }}(n) \longleftrightarrow \operatorname{Arrow}_{\text {rot }}(n) \tag{55}
\end{equation*}
$$

and

$$
\begin{equation*}
\operatorname{Diagram}_{\text {strict+rev }}(n) \longleftrightarrow \operatorname{Gauss}_{\text {unori }}(n) \longleftrightarrow \operatorname{Arrow}_{\text {rot }+\mathrm{ref}}(n) . \tag{56}
\end{equation*}
$$

Proof. This is a consequence of Proposition 2.4 and Lemma 8.1 ,
For the points $P_{1}, \ldots, P_{2 n}$ as before, we assume that $P_{2 n+1}$ is $P_{1}$.
An arrow diagram is 1-reducible if there is an arrow connecting $P_{i}$ and $P_{i+1}$ for some $i \in\{1, \ldots, 2 n\}$. Otherwise, it is called 1-irreducible.

An arrow diagram is 2 -reducible if one of the following holds:
(1) There are integers $i, i^{\prime} \in\{1, \ldots, 2 n\}$ such that $P_{i}$ and $P_{i}^{\prime}$ are connected by an arrow and $P_{i+1}$ and $P_{i^{\prime}+1}$ are connected by an arrow such that if $P_{i}$ is a head (tail) then $P_{i+1}$ is a tail (head).
(2) There are integers $i, i^{\prime} \in\{1, \ldots, 2 n\}$ such that $P_{i}$ and $P_{i^{\prime}+1}$ are connected by an arrow and $P_{i+1}$ and $P_{i^{\prime}}$ are connected by an arrow such that if $P_{i}$ is a head (tail) then $P_{i+1}$ is a tail (head).

Otherwise, it is called 2-irreducible.
An arrow diagram is called minimal or irreducible if it is 1-irreducible and 2-irreducible.
Lemma 8.3. Let $D, w$ and $A$ be a virtual diagram, a Gauss code of $D$ and the arrow diagram of $w$. The following three conditions are mutually equivalent: (1) $D$ is minimal, (2) $w$ is minimal, and (3) $A$ is minimal.

Proof. It is a direct consequence from the definition.
Let $\operatorname{Arrow}_{\text {rot }}^{\min }(n)\left(\operatorname{Arrow}_{\text {rot }+ \text { ref }}^{\min }(n)\right)$ denote the subset of $\operatorname{Arrow}_{\text {rot }}(n)\left(\operatorname{Arrow}_{\text {rot }+\mathrm{ref}}(n)\right)$ consisting of the classes of minimal arrow diagrams with $n$ arrows.

Theorem 8.4. There are bijections

$$
\begin{equation*}
\operatorname{Doodle}_{\text {ori }}(n) \longleftrightarrow \text { Diagram }_{\text {strict }}^{\min }(n) \longleftrightarrow \operatorname{Gauss}_{\text {ori }}^{\min }(n) \longleftrightarrow \operatorname{Arrow}_{\text {rot }}^{\min }(n) \tag{57}
\end{equation*}
$$

and

$$
\begin{equation*}
\operatorname{Doodle}_{\text {unori }}(n) \longleftrightarrow \operatorname{Diagram}_{\text {strict }+ \text { rev }}^{\min }(n) \longleftrightarrow \operatorname{Gauss}_{\text {unori }}^{\min }(n) \longleftrightarrow \operatorname{Arrow}_{\text {rot }+ \text { ref }}^{\min }(n) \tag{58}
\end{equation*}
$$

Proof. Combining Theorem [1.3, Proposition 5.2 and Proposition 8.2, we have the result.

Computation of virtual doodles using arrow diagrams is easy and practical when the number of real crossings is small. At the conference "Self-distributive system and quandle (co)homology theory in algebra and low-dimensional topology"held in Busan, Korea in June 2017 as 2017 KIAS Research Station, after the talk on doodles given by the fourth author, Victoria Lebed made a table of minimal arrow diagrams with 4 arrows by hand. By Theorem 8.4 it provides a table of virtual doodles with 4 real crossings.
