# Remarks on Mathieu-Zhao Subspaces of Commutative Associative Algebras and Vertex Algebras

#### Abstract

We introduce a notion of Mathieu-Zhao subspaces of vertex algebras. Among other things, we show that for a vertex algebra $V$ and its subspace $M$ that contains $C_{2}(V), M$ is a Mathieu-Zhao subspace of $V$ if and only if the quotient space $M / C_{2}(V)$ is a Mathieu-Zhao subspace of a commutative associative algebra $V / C_{2}(V)$. As a result, one can study the famous Jacobian conjecture in terms of Mathieu-Zhao subspaces of vertex algebras. In addition, for a CFTtype vertex operator algebra $V$ that satisfies the $C_{2}$-cofiniteness condition, we classify all Mathieu-Zhao subspaces $M$ that contain $C_{2}(V)$.

## 1. Introduction

The notion of Mathieu-Zhao subspaces of commutative associative algebras is a generalization of the fundamental notion of ideals and was introduced by Zhao in 2009 (cf. [Z3]). The study of Mathieu-Zhao subspaces of commutative associative algebras grew out of many attempts to understand the Jacobian conjecture (cf. $\lfloor\mathrm{M}, \mathrm{Z} 1, \boxed{Z 2}, \boxed{Z 4}]$ ). This conjecture is a famous problem on polynomials in several variables and was proposed by Keller in 1939. The Jacobian conjecture claims that any polynomial map $F$ of $\mathbb{C}^{n}$ with $\operatorname{det} J(F)=1$ is an automorphism of $\mathbb{C}^{n}($ cf. K $\left.\mathbb{K}]\right)$. Here $J(F)=\left(\frac{\partial F\left(x_{i}\right)}{\partial x_{j}}\right)_{1 \leq i, j \leq n}$. This conjecture remains open even for the case when $n=2$. In 1998, the Fields Medalist and
the Wolf Prize Winner S. Smale included the Jacobian conjecture in his list of 18 fundamental mathematical problems for the 21st century (cf. [S]).

The theory of vertex (operator) algebras has been showing its powers in the solution of concrete mathematical problems and in the understanding of conceptual but subtle mathematical and physical structures of conformal field theories. The original motivation for the introduction of the notion of vertex operator algebra arose from the problem of realizing the Monster group as a symmetry group of a certain infinite-dimensional graded vector space with natural additional structure (cf. B1, B2, FLM1, FLM2]). Vertex (operator) algebras are known as the mathematical counterparts of chiral algebras in twodimensional quantum conformal field theory (cf. [BPZ, MS]). In many aspects, vertex (operator) algebras are analogous to commutative associative algebras. In fact, commutative vertex algebras are commutative associative algebras with derivations (cf. B1]).

The aim of this paper is to deepen our understanding on connections between vertex (operator) algebras and commutative associative algebras through Mathieu-Zhao subspaces of commutative associative algebras. In addition, we want to find a way to study the Jacobian conjecture in term of vertex algebras. In section 2, we provide necessary background on vertex algebras $V$ and commutative associative algebras $V / C_{2}(V)$, which is an important algebra for the study of representation theory of vertex operator algebras, that we will need in later sections. In section 3, we introduce a notion of Mathieu-Zhao subspaces of vertex algebras and study properties of these subspaces. We show that for a vertex algebra $V$ and its subspace $M$ that contains $C_{2}(V), M$ is a Mathieu-Zhao subspace of $V$ if and only if the quotient space $M / C_{2}(V)$ is a Mathieu-Zhao subspace of a commutative associative algebra $V / C_{2}(V)$. In section 4, we study Mathieu-Zhao subspaces of vertex algebras of CFT-type that satisfy the $C_{2}$-cofinite condition. Particularly, we show that if $M$ is a subspace of $V$ that contains $C_{2}(V)$ and $\mathbf{1} \notin M$, then $M$ is a Mathieu-Zhao subspace of $V$. In addition, we discuss a connection between the Jacobian conjecture and certain subspaces of Heisenberg vertex operator algebras.

## 2. Background Materials

In this section we will review materials on vertex algebras $V$, and commutative associative algebras $V / C_{2}(V)$ that we will need in later sections. Also, we recall examples of vertex algebras that we will refer to in later sections.

Definition 1. (B1, FLM2, LLi] )A vertex algebra is a vector space $V$ equipped with a linear map

and equipped with a distinguised vector 1, called the vacuum (vector), such that for $u, v \in V$,

= & z_{2}^{-1} \delta\left(\frac{z_{1}-z_{0}}{z_{2}}\right) Y\left(Y\left(u, z_{0}\right) v, z_{2}\right) \tag{5}

the Jacobi identity.

A vertex algebra $V$ equipped with a $\mathbb{Z}$-grading $V=\coprod_{n \in \mathbb{Z}} V_{(n)}$ is called a $\mathbb{Z}$-graded vetex algebra if $\mathbf{1} \in V_{(0)}$ and if for $u \in V_{(k)}$ with $k \in \mathbb{Z}$ and for $m, n \in \mathbb{Z}$,

An $\mathbb{N}$ graded vertex algebra is defined in the obvious way.

From the Jacobi identity we have Borcherds' commutator formula and iterate formula:

for $u, v, w \in V, m, n \in \mathbb{Z}$. Specifically, we have

Define a linear operator $\mathcal{D}$ on $V$ by

Moreover, $Y(u, z) v=e^{z \mathcal{D}} Y(v,-z) u$ for $u, v \in V$. Equivalently,

In particular, we have

u_{-1} v & =v_{-1} u-\sum_{i \geq 1} \frac{(-1)^{i+1}}{i!} \mathcal{D}^{i} v_{i-1} u,  \tag{17}\\
u_{0} \mathcal{D}(v) & =\mathcal{D}(u(0) v) \text { and } u_{-1} \mathcal{D}(v)=\mathcal{D}\left(u_{-1} v\right)-u_{-2} v . \tag{18}

Definition 2. ([FLM2, LLi]) A vertex operator algebra is a $\mathbb{Z}$-graded vertex algebra

$$
V=\coprod_{n \in \mathbb{Z}} V_{(n)} \text { for } v \in V_{(n)}, n=w t v
$$

such that $\operatorname{dim} V_{(n)}<\infty$ for $n \in \mathbb{Z}$ and $V_{n}=0$ for $n$ sufficiently negative, equipped with a distinguished homogeneous vector $\omega \in V_{(2)}$ (the conformal vector), satisfying the following conditions:

[L(m), L(n)]=(m-n) L(m+n)+\frac{1}{12}\left(m^{3}-m\right) \delta_{m+n, 0} c_{V}

for $m, n \in \mathbb{Z}$ where $Y(\omega, z)=\sum_{n \in \mathbb{Z}} L(n) z^{-n-2}$ and $c_{V} \in \mathbb{C}$. We also have $L(0) v=n v=(w t v) v$ for $n \in \mathbb{Z}$ and $v \in V_{(n)} ;$ and $Y(L(-1) v, z)=\frac{d}{d z} Y(v, z)$.

Definition 3. A vertex operator algebra $V$ is of $C F T$-type if $V=\coprod_{n \geq 0} V_{(n)}$ and $V_{0}=\mathbb{C} 1$.

Definition 4. ( LLi$]$ ) An ideal of the vertex algebra $V$ is a subspace $I$ such that for all $v \in V$ and $w \in I, v_{n} w \in I$ and $w_{n} v \in I$ for all $v \in V, w \in I$ and $n \in \mathbb{Z}$.

If $V \neq\{0\}$ and $V$ is the only nonzero ideal we say that $V$ is simple.
Definition 5. Let $(V, Y, 1)$ be a vertex algebra. We define

C_{2}(V):=\operatorname{Span}_{\mathbb{C}}\left\{u_{-2} v \mid u, v \in V\right\}
$$

$V$ satisfies the $C_{2}$-cofiniteness condition if the dimension of $V / C_{2}(V)$ is finite.

Remark 6.

1. $\mathcal{D}(V) \subseteq C_{2}(V)$, and $u_{-n} v \in C_{2}(V)$ for all $u, v \in V$ and $n \geq 2$.
2. For $a \in V, w \in C_{2}(V)$, we have $a_{0} w, a_{-1} w \in C_{2}(V)$.

Proposition 7. ([Zh]) For a vertex algebra $V$, the $(0)^{\text {th }}$ product and $(-1)^{\text {th }}$ product induce a commutative Poisson algebra structure on $V / C_{2}(V)$. In particular, we have

\left(a_{-1} b\right)_{0} v & \equiv a_{-1}\left(b_{0} v\right)+b_{-1}\left(a_{0} v\right) \bmod C_{2}(V)
\end{aligned}
$$

for $a, b, v \in V$.

Corollary 8. Let $a \in V$. We have

1. $a_{0} a_{0} \ldots a_{0} a \in C_{2}(V)$.
2. Let $n_{1}, \ldots, n_{t} \in\{0,-1\}$ such that the number of $n_{i}$ that equals to -1 is $k$ and $k$ is strictly less than $t$. Then

a_{n_{1}} a_{n_{2}} \ldots a_{n_{t}} a \equiv \underbrace{a_{-1} \ldots a_{-1}}_{k \text { terms }} a_{0} a_{0} \ldots a_{0} a \quad \bmod C_{2}(V) \equiv 0 \quad \bmod C_{2}(V) .
$$

Proof. These follow immediately from (16), Remark 6, and Proposition 7

## Example 9. Commutative Vertex Algebras

A commutative vertex algebra is a vertex algebra $V$ such that

$$
\left[Y\left(u, z_{1}\right), Y\left(v, z_{2}\right)\right]=0
$$

for all $u, v \in V$. Equivalently, $V$ is commutative if and only if $u_{n} v=0$ for all $u, v \in V, n \geq 0$. If $V$ is a commutative vertex algebra then $V$ is an honest commutative associative algebra with the product defined by $u \cdot v=u_{-1} v$ for $u, v \in V$, and with 1 as the identity element. Furthermore, the operator $\mathcal{D}$ of $V$ is a derivation and $Y(u, z) v=\left(e^{z \mathcal{D}} u\right) v$ for $u, v \in V$.

Also, for any commutative associative algebra $A$ with identity 1 equipped with a derivation $\partial$. $A$ carries the structure of a commutative vertex algebra where $Y$ is defined by $Y(a, z)=\left(e^{z \partial} a\right) b$ for $a, b \in A$.

## Example 10. Heisenberg Vertex Operator Algebras

Let $\mathfrak{h}$ be a vector space equipped with a symmetric nondegenerate bilinear form $(\cdot, \cdot)$. We will identity $\mathfrak{h}$ with its dual $\mathfrak{h}^{*}$. The corresponding affine Lie algebra

\hat{\mathfrak{h}}=\mathfrak{h} \otimes \mathbb{C}\left[t, t^{-1}\right] \oplus \mathbb{C} c
$$

has a Lie structure defined by

$$
\left[x \otimes t^{m}, y \otimes t^{n}\right]=(x, y) m \delta_{m+n, 0} c \text { for } x, y \in \mathfrak{h}, m, n \in \mathbb{Z}, \text { and }[c, \hat{\mathfrak{h}}]=0
$$

Consider the induced $\hat{\mathfrak{h}}$-module

M(1)=U(\hat{\mathfrak{h}}) \otimes_{U(\mathfrak{h} \otimes \mathbb{C}[t] \oplus \mathbb{C} c)} \mathbb{C} \cong S\left(\hat{\mathfrak{h}}^{-}\right) \text {(linearly) }
$$

$h \otimes \mathbb{C}[t]$ acting triviall on $\mathbb{C}$ and $c$ acting as 1 . For $\alpha \in \mathfrak{h}$ and $n \in \mathbb{Z}$, we write $\alpha(n)$ for the operator $\alpha \otimes t^{n}$ and set $\alpha(z)=\sum_{n \in \mathbb{Z}} \alpha(n) z^{-n-1}$. We define

Y(v, z)=\circ\left(\frac{1}{\left(n_{1}-1\right)!}\left(\frac{d}{d z}\right)^{n_{1}-1} \alpha_{1}(z)\right) \ldots\left(\frac{1}{\left(n_{k}-1\right)!}\left(\frac{d}{d z}\right)^{n_{k}-1} \alpha_{k}(z)\right) \circ
$$

where $v=\alpha_{1}\left(-n_{1}\right) \ldots . \alpha_{k}\left(-n_{k}\right) \otimes 1 \in M(1)$ for $\alpha_{1}, \ldots, \alpha_{k} \in \mathfrak{h}, n_{1}, \ldots, n_{k}$ are positive integers and where we use a normal ordering procedure, indicated by open colons, which signify that the expression is to be reordered if necessary so that all the operators $\alpha(n)(\alpha \in \mathfrak{h}, n<0)$ are to be placed to the left of all the operator $\alpha(n)(\alpha \in \mathfrak{h}, n \geq 0)$ before the expression is evaluated. Extend this definition to all $v \in M(1)$ by linearity. Set $\mathbf{1}=1, \omega=\frac{1}{2} \sum_{i=1}^{d} \beta^{i}(-1)^{2} \otimes 1 \in$ $M(1)$ where $\left\{\beta^{i} \mid 1 \leq i \leq d\right\}$ is an orthonormal basis of $\mathfrak{h}$. Then

Proposition 11. ([FLM2]) The space $M(1)$ is a simple vertex operator algebra. Moreover, $M(1)$ does not satisfy the $C_{2}$-condition. If $\operatorname{dim} \mathfrak{h}=d$, then $M(1) / C_{2}(V) \cong \mathbb{C}\left[x_{1}, \ldots, x_{d}\right]$ as commutative associative algebra.

Remark 12. The vertex operator algebra $M(1)$ is generated by $\left\{\beta_{i}(-1) \mathbf{1} \mid 1 \leq\right.$ $i \leq d\}$. When we identify $M(1)$ with a symmetric algebra $\mathbb{C}\left[x_{i, n} \mid i=1, \ldots, d, n=\right.$ $1,2,3, \ldots .$.$] , it is easy to see that all vertex operators are built from the operators$ $x_{i, n}$ and $\frac{\partial}{\partial x_{i, n}}$.

## Example 13. Lattice Vertex Operator Algebras

Let $L$ be a finite-rank free abelian group equipped with a symmetric nondegenerate bilinear form ( , ) such that $(\alpha, \alpha) \in 2 \mathbb{Z}_{+}$for all $\alpha \neq 0 \in L$. Here $\mathbb{Z}_{+}$is a set of positive integers. We set $\mathfrak{h}=\mathbb{C} \otimes_{\mathbb{Z}} L$ and extend the $\mathbb{Z}$-form $(\cdot, \cdot)$ of $L$ to $\mathfrak{h}$.

Let $\hat{L}$ be the canonical central extension of $L$ by the cyclic group $\langle \pm 1\rangle$ : $1 \rightarrow\langle \pm 1\rangle \rightarrow \hat{L} \xrightarrow{-} L \rightarrow 1$ with the commutator map $c(\alpha, \beta)=(-1)^{(\alpha, \beta)}$ for $\alpha, \beta \in L$. Form the induced $\hat{L}$-module $\mathbb{C}\{L\}=\mathbb{C}[\hat{L}] \otimes_{\langle \pm 1\rangle} \mathbb{C}(\cong \mathbb{C}[L]$ (linearly) $)$, where $\mathbb{C}[\cdot]$ denotes the group algebra and -1 acts on $\mathbb{C}$ as multiplication by -1 .

The underlying vector space for the vertex operator algebra $V_{L}$ is

$$
V_{L}=M(1) \otimes_{\mathbb{C}} \mathbb{C}\{L\}\left(\cong S\left(\hat{\mathfrak{h}}^{-}\right) \otimes \mathbb{C}[L] \text { (linearly) }\right) .
$$

Proposition 14. ([FLM2, DLM]) $V_{L}$ is a simple vertex operator algebra. Moreover, $V_{L}$ satisfies the $C_{2}$-condition.

## Example 15. Vertex Operator Algebras associated with the Highest Weight Representations of Affine Lie Algebras

Let $\mathfrak{g}$ be a finite-dimensional simple Lie algebra, $\mathbf{h}$ its Cartan subalgebra, and $\langle\cdot, \cdot\rangle$ normalized killing form such that the square length of a long root is 2 . Let $\hat{\mathfrak{g}}=\mathfrak{g} \otimes \mathbb{C}\left[t, t^{-1}\right] \oplus \mathbb{C} c$ be the affine Lie algebra. Let $l$ be a complex number such that $l \neq-h$ where $h$ is the dual Coxeter number of $\mathfrak{g}$. Let $\mathbb{C}_{l}$ be the onedimensional $(\mathfrak{g} \otimes \mathbb{C}[t]+\mathbb{C} c)$-module on which $c$ acts as scalar $l$ and $\mathfrak{g} \otimes \mathbb{C}[t]$ acts as zero. Form the generalized Verma $\hat{\mathfrak{g}}$-module $M_{\mathfrak{g}}(l, 0)=U(\hat{\mathfrak{g}}) \otimes_{U(\mathfrak{g} \otimes \mathbb{C}[t]+\mathbb{C} c)} \mathbb{C}_{l}$.
Proposition 16. ( $[D L, D L M, L Z])$

1. If $l \neq-h$ then $M(l, 0)$ is a vertex operator algebra. However, $M(l, 0)$ does not satisfy the $C_{2}$-condition.
2. Let $I(l, 0)$ be the unique maximal submodule of $M(l, 0)$. Let $L(l, 0)$ be the corresponding quotient. If $l \neq 0$ and $l \neq \hbar$ then $I(l, 0)$ is an ideal of $M(l, 0)$ and $L(l, 0)$ is a simple vertex operator algebra. Moreover, $L(l, 0)$ satisfies the $C_{2}$-condition.

## Example 17. Vertex Operator Algebras associated with Virasoro algebras

We denote the Virasoro algebra by $\mathcal{L}=\oplus_{n \in \mathbb{Z}} \mathbb{C} L_{n} \oplus \mathbb{C} c$ with relation

$$
\left[L_{m}, L_{n}\right]=(m-n) L_{m+n}+\delta_{m+n, 0} \frac{m^{3}-m}{12} C,\left[L_{m}, C\right]=0
$$

We set $\mathfrak{b}=\left(\oplus_{n \geq 1} \mathbb{C} L_{n}\right) \oplus\left(\mathbb{C} L_{0} \oplus \mathbb{C} C\right)$.
For any complex number $c$, let $\mathbb{C}_{c}$ be a 1-dimensional $\mathfrak{b}$-module defined as follows: $L_{n} \cdot 1=0$ for $n \geq 0, C \cdot 1=c \cdot 1$. We set

$$
V(c, 0)=U(\mathcal{L}) \otimes_{U(\mathfrak{b})} \mathbb{C}_{c} .
$$

$V(c, 0)$ has a unique maximal proper submodule $J(c, 0)$. Let $L(c, 0)$ be the unique irreducible quotient module of $V(c, 0)$. It is well known that $\overline{V(c, 0)}=$ $V(c, 0) /\left(U(\mathcal{L}) L_{-1} 1 \otimes 1\right)$ is a vertex operator algebra. Moreover,

Proposition 18. ([DLM, FZ])

1. $L(c, 0)$ is the unique irreducible quotient vertex operator algebra of $\overline{V(c, 0)}$.
2. For $m \geq 2$, set $c_{m}=1-\frac{6}{m(m+1)}$. The vertex operator algebra $L\left(c_{m}, 0\right)$ satisfies the $C_{2}$-condition.

## 3. Mathieu-Zhao subspaces of Vertex Algebras

In this section, we define Mathieu-Zhao subspaces of vertex algebras and study their properties. Also, we study relationships between Mathieu-Zhao subspaces of vertex algebras $V$ and Mathieu-Zhao subspaces of commutative associative algebras $V / C_{2}(V)$.

Definition 19. Let $V$ be a vertex algebra. Let $M$ be a $\mathbb{C}$-subspace of $V$. We define the radical, left-strong radical, right-strong radcial, and strong radical of $M$ with respect to $0^{t h}$ and $(-1)^{t h}$-products in the following way.

1. The radical of $M$ with respect to $0^{t h}$ and $(-1)^{t h}$-products is the set

2. The left-strong radical of $M$ with respect to $0^{t h}$ and $(-1)^{t h}$-products is the set

& b_{s} v_{n_{1}} v_{n_{2}} \ldots v_{n_{t}} v \in M \text { for all } t \geq m, \\
& \left.s, n_{1}, \ldots, n_{t} \in\{0,-1\}\right\} .
\end{aligned}
$$

3. The right-strong radical of $M$ with respect to $0^{t h}$ and $(-1)^{t h}$-products is
the set

$$
\begin{aligned}
r s r_{0,-1}(M)=\{v \in V \quad \mid \quad & \text { for } w \in V, \text { there exists } m \geq 0 \text { such that } \\
& \left(v_{n_{1}} \ldots v_{n_{t}} v\right)_{n} w \in M \text { for all } t \geq m, \\
& \left.n, n_{1}, \ldots, n_{t} \in\{0,-1\}\right\} .
\end{aligned}
$$

4. The strong radical of $M$ with respect to $0^{t h}$ and $(-1)^{t h}$-products is the set

$$
s r_{0,-1}(M)=l s r_{0,-1}(M) \cap r s r_{0,-1}(M)
$$

Remark 20. Notice that

1. $s r_{0,-1}(M) \subseteq l s r_{0,-1}(M) \subseteq r_{0,-1}(M)$.
2. $s r_{0,-1}(M) \subseteq r s r_{0,-1}(M) \subseteq r_{0,-1}(M)$.

Example 21. ([DW]) Let $V=\mathbb{C}\left[t, t^{-1}\right]$ be a commutative vertex algebra. Let $M \subset V$ be a set of Laurent polynomials whose constant term equals 0 . Then $r_{0,-1}(M)=s r_{0,-1}(M)=t \mathbb{C}[t] \cup t^{-1} \mathbb{C}\left[t^{-1}\right]$.

Lemma 22. Let $M$ be a subspace of $V$. If $\mathcal{D}(V) \subset M$. Then $u \in l s r_{0,-1}(M)$ if and only if $u \in \operatorname{rsr}_{0,-1}(M)$. In particular, we have $l s r_{0,-1}(M)=\operatorname{rsr}_{0,-1}(M)=$ $s r_{0,-1}(M)$.

Proof. The above statements are consequences of equations (15), (17).

Definition 23. Let $V$ be a vertex algebra with a $\mathbb{C}$-subspace $M$. We say that $M$ is a Mathieu-Zhao subspace of $V$ with respect to $0^{t h}$ and $(-1)^{t h}$-products $\left(M Z_{0,-1}\right.$-subspace of $\left.V\right)$ if $r_{0,-1}(M)=s r_{0,-1}(M)$.

Example 24. Let $I$ be an ideal of $V$. Then $I$ is a $M Z_{0,-1}$-subspace of $V$.

Proof. Let $u \in r_{0,-1}(I)$. Then there exists $m \geq 0$ such that $u_{n_{1}} \ldots u_{n_{t}} u \in I$ for all $t \geq m$ and $n_{1}, \ldots, n_{t} \in\{0,-1\}$. Since $I$ is an ideal of $V$, this implies that for $b, w \in V, b_{s} u_{n_{1}} \ldots u_{n_{t}} u \in I$ and $\left(u_{n_{1}} \ldots u_{n_{t}} u\right)_{n} w \in I$ for all $t \geq m$ and $s, n, n_{1}, \ldots, n_{t} \in\{0,-1\}$. Hence, $u \in s r_{0,-1}(M)$. Moreover, $I$ is a $M Z_{0,-1^{-}}$ subspace of $V$.

Recall that for $n \geq 2, C_{n}(V)=\operatorname{Span}_{\mathbb{C}}\left\{u_{-n} v \mid u, v \in V\right\}$. Also, if $p \geq q$ then $C_{p}(V) \subseteq C_{q}(V)$.

Example 25. For $n \geq 2, C_{n}(V)$ is a $M Z_{0,-1}$-subspace of $V$.

Proof. Let $u \in r_{0,-1}\left(C_{n}(V)\right)$. Then there exists $m \geq 0$ such that $u_{n_{1} \ldots u_{n_{t}} u \in}$ $C_{n}(V)$ for all $t \geq m$ and $n_{1}, \ldots, n_{t} \in\{0,-1\}$. By (7), (8), we can conclude that for $v \in V, v_{s}\left(u_{n_{1}} \ldots u_{n_{t}} u\right),\left(u_{n_{1}} \ldots u_{n_{t}} u\right)_{s} v \in C_{n}(V)$ for all $s \in\{0,-1\}$. Hence, $u \in s r_{0,-1}\left(C_{n}(V)\right)$. Moreover, $C_{n}(V)$ is a $M Z_{0,-1}$-subspace of $V$.

Example 26. Let $V$ be a vertex operator algebra of $C F T$-type. We set $V_{+}=$ $\coprod_{n \geq 1} V_{(n)}$. Recall that $C_{1}(V)$ is a subspace of $V$ linearly spanned by elements of type $a_{-1} b, L(-1) w$ for $a, b \in V_{+}, w \in V$. Also, $\mathcal{D}(V) \subseteq C_{2}(V) \subseteq C_{1}(V)$. In this example, we will show that $C_{1}(V)$ is in fact a $M Z_{0,-1}$-subspace of $V$.

Proof. Let $u \in r_{0,1}\left(C_{1}(V)\right)$. Then there exists $m \geq 0$ such that $u_{n_{1}} \ldots u_{n_{t}} u \in$ $C_{1}(V)$ for all $t \geq m$ and $n_{1}, \ldots, n_{t} \in\{0,-1\}$. Since $V$ is of $C F T$-type and $\mathcal{D}(V) \subseteq C_{1}(V)$, to show that $u \in s r_{0,-1}\left(C_{1}(V)\right)$, we only need to show that for $v \in V_{+}$,

$$
\begin{equation*}
v_{s}\left(u_{n_{1}} \ldots u_{n_{t}} u\right) \in C_{1}(V) \tag{19}
\end{equation*}
$$

for all $s \in\{0,-1\}$. However, (19) follows immediately from (7), and (14). We can conclude that $u \in s r_{0,-1}\left(C_{1}(V)\right)$ and $C_{1}(V)$ is a $M Z_{0,-1}$-subspace of $V$.

Remark 27. We first recall the definition of Mathieu-Zhao subspace of associative algebra in [Z5]. Let $R$ be a commutative unital ring, and let $\mathcal{A}$ be an associative unital $R$-algebra. Let $U$ be an $R$-submodule of $\mathcal{A}$. The radical of $U$,
$r(U)$, and strong radical, $s r(U)$, are defined as follow:
$r(U)=\{a \in A \mid$ there exists $m \geq 1$ such that $\underbrace{a \cdot \ldots \cdot a}_{t \text { terms }} \in U$ for all $t \geq m\}$, $\operatorname{sr}(U)=\{a \in A \mid$ for $u, v \in A$, there exists $m \geq 1$ such that $b \underbrace{a \cdot \ldots \cdot a}_{t \text { terms }} c \in U$ for all $t \geq m\}$.

The subspace $U$ is a Mathieu-Zhao subspace of $\mathcal{A}$ when $r(U)=\operatorname{sr}(U)$.
Next, we let $V$ be a commutative vertex algebra. Hence, $V$ is a commutative associative algebra. Let $M$ be a subspace of a commutative vertex algebra $V$. It is straight forward show that $r_{0,-1}(M)=r(M)$ and $s r_{0,-1}(M)=s r(M)$. Moreover $M$ is a $M Z_{0,-1}$-subspace of $V$ if and only if $M$ is a Mathieu-Zhao subspace of $V$ when we consider $V$ as a commutative associative algebra.

Next, we study properties of Mathieu-Zhao subspaces of vertex algebras.
Proposition 28. Let $V$ be a vertex algebra. Let $M$ be a subspace of $V$.

1. If $r_{0,-1}(M) \subseteq r_{0,-1}(\{0\})$, then $M$ is a $M Z_{0,-1}$-subspace of $V$.
2. If $\operatorname{sr}_{0,-1}(M)=V$ then $M$ is a $M Z_{0,-1-s u b s p a c e ~ o f ~} V$.
3. If $\mathbf{1} \in s r_{0,-1}(M)$ then $M$ is a $M Z_{0,-1-s u b s p a c e ~ o f ~} V$.
4. If $U$ be is a subspace of $V$ such that $U \subseteq M$, then $r_{0,-1}(U) \subseteq r_{0,-1}(M)$.

Proof. The above statements follow immediately from the definition of $M Z_{0,-1^{-}}$ subspace of $V$.

Theorem 29. Let $V$ be a vertex algebra. Let $M$ is a subspace of $V$ such that


Proof. $(\Leftarrow)$ Clear.
$(\Rightarrow)$ Assume that $M$ is a $M Z_{0,-1}$-subspace of $V$. Since $1 \in r_{0,-1}(M)=$ $s r_{0,-1}(M)$, it implies that $b \in M$ for all $b \in V$. Hence, $V=M$.

Recall that $f$ is a homomorphism from a vertex algebra $V^{1}$ to a vertex algebra $V^{2}$ if $f$ is a linear map such that $f\left(u_{n} v\right)=f(u)_{n} f(v)$ for $u, v \in V, n \in \mathbb{Z}$ and such that $f(\mathbf{1})=\mathbf{1}$.

Lemma 30. Let $V^{1}$ and $V^{2}$ be vertex algebras and let $f: V^{1} \rightarrow V^{2}$ be a homomorphism. If $M$ is a $M Z_{0,-1}$-subspace of $V^{2}$, then $f^{-1}(M)$ is a $M Z_{0,-1^{-}}$ subspace of $V^{1}$.

Proof. Let $v \in r_{0,-1}\left(f^{-1}(M)\right)$. Hence, there exists $m \geq 0$ such that

$$
v_{n_{1}} v_{n_{2}} \ldots v_{n_{t}} v \in f^{-1}(M)
$$

for all $t \geq m, n_{1}, \ldots, n_{t} \in\{0,-1\}$. Using the fact that $f$ is a homomorphism, we can conclude that

$$
f(v)_{n_{1}} f(v)_{n_{2}} \ldots f(v)_{n_{t}} f(v) \in M
$$

for all $t \geq m, n_{1}, \ldots, n_{t} \in\{0,-1\}$. Hence, $f(v) \in r_{0,-1}(M)$. Let $b \in V^{1}$. Because $M$ is a $M Z_{0,-1}$-subspace of $V^{2}$, there exists $q \geq 0$ such that

$$
f(b)_{s} f(v)_{n_{1}} f(v)_{n_{2}} \ldots f(v)_{n_{t}} f(v) \in M
$$

 Therefore, $v \in s r_{0,-1}\left(f^{-1}(M)\right)$, and $f^{-1}(M)$ is a $M Z_{0,-1}$-subspace of $V^{1}$ as desired.

Corollary 31. Let $V^{1}$ and $V^{2}$ be vertex algebras such that $V^{1} \subseteq V^{2}$. If $M$ is a $M Z_{0,-1}$-subspace of $V^{2}$ then $M \cap V^{1}$ is a $M Z_{0,-1}$-subspace of $V^{1}$.

Proof. Let $\iota: V^{1} \rightarrow V^{2}$ be an inclusion map. Clearly, $\iota$ is a homomorphism from $V^{1}$ to $V^{2}$. By Lemma 30 we can conclude immediately that $M \cap V^{1}=\iota^{-1}(M)$ is a $M Z_{0,-1}$-subspace of $V^{1}$.

Example 32. Let $M$ be a $M Z_{0,-1}$-subspace of $V_{L}$. Then $M \cap M(1)$ is a $M Z_{0,-1}$-subspace of $M(1)$.

Theorem 33. Let $V$ be a vertex algebra and let $I$ be its ideal. Let $M$ be a subspace of $V$ such that $I \subseteq M$. Then $M$ is a $M Z_{0,-1}$-subspace of $V$ if and only if $M / I$ is a $M Z_{0,-1}$-subspace of $V / I$.

Proof. $(\Leftarrow)$ Let $f: V \rightarrow V / I$ be a projection map. By Lemma 30, we can conclude immediately that if $M / I$ is a $M Z_{0,-1}$-subspace of $V / I$, then $M$ is a $M Z_{0,-1 \text {-subspace }}$ of $V$.
$(\Rightarrow)$ Now, assume that $M$ is a $M Z_{0,-1}$-subspace of $V$. Let $v+I \in$ $r_{0,-1}(M / I)$. Then there exists $m \geq 0$ such that

$$
v_{n_{1}} v_{n_{2}} \ldots v_{n_{t}} v+I \in M / I
$$

for all $t \geq m, n_{1}, \ldots, n_{t} \in\{0,-1\}$. Consequently, we have

$$
v_{n_{1}} v_{n_{2}} \ldots v_{n_{t}} v \in M
$$

for all $t \geq m, n_{1}, \ldots, n_{t} \in\{0,-1\}$ and $v \in r_{0,-1}(M)$. Let $b \in V$. Because $r_{0,-1}(M)=s r_{0,-1}(M)$, there exists $q \geq 0$ such that

$$
b_{s} v_{n_{1}} v_{n_{2}} \ldots v_{n_{t}} v \in M \text { and }\left(v_{n_{1}} v_{n_{2}} \ldots v_{n_{t}} v\right)_{s} b \in M
$$

for all $t \geq q, s, n_{1}, \ldots, n_{t} \in\{0,-1\}$. Hence,

$$
b_{s} v_{n_{1}} v_{n_{2}} \ldots v_{n_{t}} v+I \in M / I \text { and }\left(v_{n_{1}} v_{n_{2}} \ldots v_{n_{t}} v\right)_{s} b+I \in M / I .
$$

Moreover, $v+I \in s r_{0,-1}(M / I)$ and $M / I$ is a $M Z_{0,-1}$-subspace of $V / I$.

Example 34. Let $U$ be a subspace of $M(l, 0)$ such that $I(l, 0) \subseteq U$. Then $U$ is a $M Z_{0,-1}$-subspace of $M(l, 0)$ if and only if $U / I$ is a $M Z_{0,-1}$-subspace of $L(l, 0)$.

The following theorem will play an important role for the rest of this paper.

Theorem 35. Let $M$ be a subspace of $V$ such that $M \supseteq C_{2}(V)$. Let $a \in V$. We have the following:

1. $a \in r_{0,-1}(M)$ if and only if $a+C_{2}(V) \in r\left(M / C_{2}(V)\right)$.
2. $a \in s r_{0,-1}(M)$ if and only if $a+C_{2}(V) \in \operatorname{sr}\left(M / C_{2}(V)\right)$.
 subspace of $V / C_{2}(V)$.

Proof. First, we will prove statement (1). Clearly, if $a \in r_{0,-1}(M)$ then $a+$ $C_{2}(V) \in r\left(M / C_{2}(V)\right)$. Now, we assume that $a+C_{2}(V) \in r\left(M / C_{2}(V)\right)$. Hence, there exists $m \geq 0$ such that $\underbrace{a_{-1} \ldots . a_{-1}}_{t \text { terms }} a+C_{2}(V) \in M / C_{2}(V)$ for all $t \geq m$. In particular, $\underbrace{a_{-1} \ldots . a_{-1}}_{t \text { terms }} a \in M$. By Corollary 8 we can conclude immediately that $a \in r_{0,-1}(M)$.

Next, we will prove the statement (2). Clearly, if $u \in s r_{0,-1}(M)$ then for $b, w \in V$, there exists $p \geq 0$ such that $\left(b_{-1} w\right)_{-1} \underbrace{u_{-1} \ldots u_{-1}}_{q \text { terms }} u+C_{2}(V) \in M / C_{2}(V)$ for all $q \geq p$. This implies that

$$
b_{-1} \underbrace{u_{-1} \ldots u_{-1} u_{-1}}_{q+1 \text { terms }} w \equiv b_{-1}(\underbrace{u_{-1} \ldots u_{-1}}_{q \text { terms }} u)_{-1} w+C_{2}(V) \in M / C_{2}(V)
$$

for all $q \geq p$ and $u+C_{2}(V) \in \operatorname{sr}\left(M / C_{2}(V)\right)$.
Now we will show that if $v+C_{2}(V) \in \operatorname{sr}\left(M / C_{2}(V)\right)$ then $v \in s r_{0,-1}(M)$. Let $v+C_{2}(V) \in \operatorname{sr}\left(M / C_{2}(V)\right)$. To show that $v \in s r_{0,-1}(M)$, we only need to show that for $b \in V$, there exists $m \geq 0$ such that $b_{0} \underbrace{v_{-1} \ldots v_{-1}}_{t \text { terms }} v \in M$ for all $t \geq m$. Notice that

$$
\begin{aligned}
b_{0} \underbrace{v_{-1} \ldots v_{-1}}_{t \text { terms }} v & =v_{-1} b_{0} \underbrace{v_{-1} \ldots v_{-1}}_{t-1 \text { terms }} v+\left(b_{0} v\right)_{-1} \underbrace{v_{-1} \ldots v_{-1}}_{t-1 \text { terms }} v \\
& \equiv v_{-1} b_{0} \underbrace{v_{-1} \ldots v_{-1}}_{t-1 \text { terms }} v+(\underbrace{v_{-1} \ldots . v_{-1}}_{t-1 \text { terms }} v)_{-1}\left(b_{0} v\right) \bmod C_{2}(V) \\
& \equiv(t+1)(\underbrace{v_{-1} \ldots v_{-1}}_{t-1 \text { terms }} v)_{-1}\left(b_{0} v\right) \bmod C_{2}(V)
\end{aligned}
$$

Since $v+C_{2}(V) \in \operatorname{sr}\left(M / C_{2}(V)\right.$, this implies that there exists $d \geq 0$ such that

$$
(\underbrace{v_{-1} \ldots v_{-1}}_{f \text { terms }} v)_{-1}\left(b_{0} v\right)+C_{2}(V) \in M / C_{2}(V)
$$

for all $f \geq d$. Therefore, $b_{0} \underbrace{v_{-1} \ldots v_{-1}}_{f \text { terms }} v \in M$ for all $f \geq d$ and $v \in s r_{0,-1}(M)$.
By using the statements (1) and (2), we can conclude immediately that $M$ is a $M Z_{0,-1}$-subspace of $V$ if and only if $M / C_{2}(V)$ is a Mathieu-Zhao subspace of $V / C_{2}(V)$.

Corollary 36. Let $V$ be a vertex algebra and let $M$ be a subspace of $V$ that contains $C_{2}(V)$ such that $M / C_{2}(V)$ is an ideal of a commutative associative algebra $V / C_{2}(V)$. Then $M$ is a $M Z_{0,-1}$-subspace of $V$.

Example 37. Let $\mathfrak{h}=\mathbb{C} \alpha$ and let $\lambda \in \mathbb{C}$. We set

$$
M=\operatorname{Span}_{\mathbb{C}}\left\{u_{-1}(\alpha(-1) \mathbf{1}-\lambda \mathbf{1})+v \mid u \in M(1), v \in C_{2}(M(1))\right\}
$$

Recall that a basis of $M(1)$ is $\left\{\alpha\left(-n_{1}\right) \ldots . \alpha\left(-n_{k}\right) \mathbf{1} \mid n_{1} \geq n_{2} \geq \ldots \geq n_{k} \geq 1\right\}$, and $M(1) / C_{2}(M(1))$ is isomorphic to $\mathbb{C}[x]$ as commutative associative algebras. If $n_{1} \geq 2$, by 8 , we have $\left(\alpha\left(-n_{1}\right) \ldots . \alpha\left(-n_{k}\right) \mathbf{1}\right)_{-1}(\alpha(-1) \mathbf{1}-\lambda \mathbf{1}) \in C_{2}(V)$. Hence,

$$
M=\operatorname{Span}_{\mathbb{C}}\{(\underbrace{\alpha(-1) \ldots \alpha(-1) \mathbf{1}}_{k \text { terms }})_{-1}(\alpha(-1) \mathbf{1}-\lambda \mathbf{1})+v \mid k \geq 0, v \in C_{2}(V)\}
$$

and $M / C_{2}(V)$ is isomorphic to an ideal generated by $x-\lambda$. Therefore, $M$ is a $M Z_{0,-1}$-subspace of $M(1)$.

## 4. Mathieu-Zhao subspaces of CFT-type Vertex Operator Algebras that satisfy the $C_{2}$-cofiniteness condition

In this section, we will study Mathieu-Zhao subspaces of vertex operator algebras $V$ of $C F T$-type that satisfy the $C_{2}$-cofiniteness condition. In particular, we will show that if $M$ is a subspace of $V$ such that $M \supseteq C_{2}(V)$ and $\mathbf{1} \notin M$, then $M$ is a $M Z_{0,-1}$-subspace of $V$.

Also, at the end of this section we will discuss a relationship between the Jacobian conjectures and Mathieu-Zhao subspaces of Heisenberg vertex operator algebras.

Theorem 38. Let $V$ be a vertex operator algebra. Let $M$ be a subspace of $V$.

1. If $V=\oplus_{n=n_{0}}^{\infty} V_{n}$ and $n_{0}<0$, then $s r_{0,-1}(M) \neq\{0\}$. In fact, if $v \in$ $\oplus_{n=n_{0}}^{-1} V_{n}$, then $v \in s r_{0,-1}(M)$.
2. Assume that $V$ satisfies the $C_{2}$-condition and $M \supseteq C_{2}(V)$. If $u \in \oplus_{i=1}^{k} V_{k}$ for some positive integer $k$, then $u \in s r_{0,-1}(M)$.

Proof. To proof the first statement, we observe that if $v \in \oplus_{n=n_{0}}^{-1} V_{n}$, then there exists a nonnegative integer $m$ such that $v_{n_{1}} v_{n_{2}} \ldots v_{n_{t}} v=0$ for all $n_{i} \in\{0,-1\}$, $m \geq t$. This implies that $b_{s}\left(v_{n_{1}} v_{n_{2}} \ldots v_{n_{t}} v\right)=\left(v_{n_{1}} v_{n_{2}} \ldots v_{n_{t}} v\right)_{s} b=0$ for all $b \in V$, $s \in\{0,-1\}$. Hence, $v \in s r_{0,-1}(M)$.

The second statement follows from the following facts. If $V$ satisfies the $C_{2}$-cofiniteness condition and $u \in \oplus_{i=1}^{k} V_{k}$ for some positive integer $k$, then there exists a nonnegative integer $m$ such that $u_{n_{1}} u_{n_{2}} \ldots u_{n_{t}} u \in C_{2}(V)$ for all $n_{i} \in$ $\{0,-1\}, t \geq m$. By using the facts that $\mathcal{D}(V) \subseteq C_{2}(V) \subseteq M$ and $C_{2}(V)$ is closed under $(0)^{t h}$ and $(-1)^{t h}$-products, we can conclude that $u \in s r_{0,-1}(M)$.

Next, we recall useful information about Mathieu Zhao subspaces of associative algebras that we will need to use later on.

Proposition 39. [Z5] Let $K$ be an arbitrary field and $\mathcal{A}$ an associative algebra over $K$. For convenience, we denote by $\mathcal{G}(\mathcal{A})$ the collection of all $K$-subspaces $\mathcal{V}$ of $\mathcal{A}$ such that $r(\mathcal{V})$ is algebraic over $K$.

1. Let $\mathcal{V}$ be a $K$-subspace of $\mathcal{A}$. Then $\mathcal{V} \in \mathcal{G}(\mathcal{A})$ if one of the following four conditions holds:
(a) $\mathcal{A}$ is algebraic over $K$;
(b) $\mathcal{V}$ is algebraic over $K$;
(c) $\operatorname{dim}_{K} \mathcal{A}<\infty$;
(d) $\operatorname{dim}_{K} \mathcal{V}<\infty$.
2. Let $\mathcal{V} \in \mathcal{G}(\mathcal{A})$ such that $\mathcal{V}$ does not contain any nonzero idempotent. Then $\mathcal{V}$ is a Mathieu subspace of $\mathcal{A}$.
3. Let $\mathcal{A}$ be a commutative $K$-algebra and $\mathcal{V} \in \mathcal{G}(\mathcal{A})$. Then $\mathcal{V}$ is a Mathieu subspace of $\mathcal{A}$ if and only if $r(\mathcal{V})$ is an ideal of $\mathcal{A}$.

Theorem 40. Let $V$ be a vertex algebra. Let $M$ be a subspace of $V$ such that $C_{2}(V) \subseteq M$. Assume that $\operatorname{dim} M / C_{2}(V)<\infty$. Then $M$ is a $M Z_{0,-1-\text { subspace }}$ of $V$ if and only if $r\left(M / C_{2}(V)\right)$ is an ideal of $V / C_{2}(V)$.

Proof. This follows immediately from Theorem 35] and Propositin 39.

Now we study Mathieu-Zhao subspaces of CFT-type vertex operator algebras that satisfy the $C_{2}$-cofiniteness condition.

Lemma 41. Let $V$ be a vertex operator algebra of CFT-type that satisfies the $C_{2}$-cofiniteness condition. Then $V / C_{2}(V)$ has no nontrivial idempotent.

Proof. Clearly if $u \in \oplus_{n=1}^{\infty} V_{n}$ then $u+C_{2}(V)$ is nilpotent in $V / C_{2}(V)$. Let $v \in$ $\oplus_{n=1}^{\infty} V_{n}$. If $(1+v)_{-1}(1+v) \equiv 1+v \bmod C_{2}(V)$ then $v_{-1} v \equiv-v \bmod C_{2}(V)$. Moreover, we have $\underbrace{v_{-1} \ldots v_{-1} v}_{n \text { terms }} \equiv(-1)^{n-1} v \bmod C_{2}(V)$ for all $n \geq 2$. Hence, $v \equiv 0 \bmod C_{2}(V)$, and $V / C_{2}(V)$ has no nontrivial idempotent.

Theorem 42. Let $V$ be a vertex algebra of CFT-type that satisfies the $C_{2}$ cofiniteness condition. Let $M$ be a subspace of $V$ such that $\mathbf{1} \notin M$ and $C_{2}(V)$ is a subset of $M$, then $M$ is a $M Z_{0,-1}$-subspace of $V$ and $r_{0,-1}(M)=\oplus_{n=1}^{\infty} V_{n}$.

Proof. Since $V / C_{2}(V)$ has no nontrivial idempotent, $\operatorname{dim}_{\mathbb{C}} M / C_{2}(V)<\infty$ and $1+C_{2}(V) \notin M / C_{2}(V)$, by Proposition 39, we can conclude that $M / C_{2}(V)$ is
an MZ-subspace of $V / C_{2}(V)$. Also, by Theorem [35, $M$ is a $M Z_{0,-1}$-subspace of $V$.

Recall that $\oplus_{n=1}^{\infty} V_{i} \subseteq s r_{0,-1}(M)=r_{0,-1}(M)$. Let $u \in V$ such that $u=1+v$ where $v \in \oplus_{n=1}^{\infty} V_{n}$. If $u \in r_{0,-1}(M)$ then $u+C_{2}(V) \in r\left(M / C_{2}(V)\right)$. Since $r\left(M / C_{2}(V)\right)$ is an ideal, and $v+C_{2}(V), u+C_{2}(V)$ are in $r\left(M / C_{2}(V)\right)$, we can conclude that $\mathbf{1}+C_{2}(V) \in r\left(M / C_{2}(V)\right)$. This implies that $\mathbf{1} \in M$ which is impossible. Hence elements of the form $\mathbf{1}+v$ where $v \in \oplus_{n=1}^{\infty} V_{n}$ are not in $r_{0,-1}(M)$. Therefore, $r_{0,-1}(M)=\oplus_{n=1}^{\infty} V_{n}$.

Example 43. Assume that $V$ is either $V_{L}$ or $L(l, 0)$ or $L\left(c_{m}, 0\right)(m \geq 2)$. If $M$ is a subspace of $V$ such that $\mathbf{1} \notin M$ and $C_{2}(V)$ is a subset of $M$, then $M$ is a $M Z_{0,-1}$ subspace of $V$.

Remark 44. If $V$ is a vertex operator algebra of $C F T$-type that satisfies the $C_{2}$-condition. If $M$ is a subspace of $V$ such that $C_{2}(V) \subseteq M$ and $M \neq V$, then $M$ is a $M Z_{0,-1}$-subspace of $V$ only when $\mathbf{1} \notin M$.

We end this paper with a discussion about a connection between the Jacobian conjecture and Mathieu-Zhao subspaces of Heisenberg vertex operator algebras. The Jacobian conjecture was originally formulated in an article written by Keller in 1939 for the occasion of Furtwängler's 70th birthday [K]. In this article he described a problem about polynomial automorphisms which he considered as interesting problem to think about. Nowadays, this problem is called the Keller problem. The Keller problem has been generalized to the Jacobian conjecture which is named after the occurrence of the Jacobian determinant in the problem.

Jacobian Conjecture. For every positive integer $n$ the following statement holds: Every $\mathbb{C}$-endomorphism $\phi$ of $\mathbb{C}\left[x_{1}, \ldots, x_{n}\right]$ with $\operatorname{det} J \phi=1$ is an automorphism, where $J \phi=\left(\frac{\partial \phi\left(x_{i}\right)}{\partial x_{j}}\right)_{1 \leq i, j \leq n}$.
The Jacobian conjecture is a problem that is still open in all dimension $n>1$. There are partial solutions of this problem [BE1, BE2, $\mathrm{D}, \mathrm{H}, \mathrm{Mo}, \mathrm{W}, \mathrm{Wr}]$.

As we mentioned in the introduction, Mathieu-Zhao subspaces of commutative associative algebras grew out of several attempts to solve the Jacobian conjecture. One of these attempts was a result due to Zhao [Z3]. He stated the following conjecture and showed that this conjecture implies the Jacobian conjecture.

Image Conjecture. $\sum_{i=1}^{n}\left(\partial_{x_{i}}-\zeta_{i}\right) \mathbb{C}\left[\zeta_{1}, \ldots, \zeta_{n}, x_{1}, \ldots, x_{n}\right]$ is a Mathieu-Zhao subspace of $\mathbb{C}\left[\zeta_{1}, \ldots, \zeta_{n}, x_{1}, \ldots, x_{n}\right]$.

Now, we let $\mathfrak{h}$ be a vector space over $\mathbb{C}$ with a basis $\left\{\beta^{1}, \ldots, \beta^{n}, \alpha^{1}, \ldots, \alpha^{n}\right\}$ and a bilinear form (, ) such that $\left(\beta^{i}, \beta^{j}\right)=\delta_{i, j},\left(\alpha^{i}, \alpha^{j}\right)=\delta_{i, j},\left(\beta^{i}, \alpha^{j}\right)=0$. Recall that $M(1) / C_{2}(M(1))$ is isomorphic to $\mathbb{C}\left[\zeta_{1}, \ldots, \zeta_{n}, x_{1}, \ldots, x_{n}\right]$ as commutative associative algebras. For $i \in\{1, \ldots, n\}$, we define a linear map $f_{i}$ : $M(1) \rightarrow M(1)$ by $f_{i}(a)=\left(\beta_{1}^{i}-\alpha_{-1}^{i}\right)(a)$ for $a \in M(1)$. Clearly, $f_{i}\left(C_{2}(M(1))\right) \subseteq$ $C_{2}(M(1))$.

By Theorem 35], we can conclude that

Theorem 45. $\sum_{i=1}^{k} f_{i}(M(1))+C_{2}(M(1))$ is a $M Z_{0,-1}$-subspace of $M(1)$ if and only if $\sum_{i=1}^{k}\left(\partial_{x_{i}}-\zeta_{i}\right) \mathbb{C}\left[\zeta_{1}, \ldots, \zeta_{n}, x_{1}, \ldots, x_{n}\right]$ is a Mathieu-Zhao subspace of $\mathbb{C}\left[\zeta_{1}, \ldots, \zeta_{n}, x_{1}, \ldots, x_{n}\right]$.

Corollary 46. If $\sum_{i=1}^{k} f_{i}(M(1))+C_{2}(M(1))$ is a $M Z_{0,-1-\text { subspace of } M(1)}$ for all $n \in \mathbb{N}$ then for every positive integer $n$ the following statement holds: Every $\mathbb{C}$-endomorphism $\phi$ of $\mathbb{C}\left[x_{1}, \ldots, x_{n}\right]$ with $\operatorname{det} J \phi=1$ is an automorphism, where $J \phi=\left(\frac{\partial \phi\left(x_{i}\right)}{\partial x_{j}}\right)_{1 \leq i, j \leq n}$.
