# Torsion of abelian varieties and Lubin-Tate extensions

#### Abstract

We show that, for an abelian variety defined over a $p$-adic field $K$ which has potential good reduction, its torsion subgroup with values in the composite field of $K$ and a certain Lubin-Tate extension over a $p$-adic field is finite.


## 1 Introduction

Let $p$ be a prime number and $A$ an abelian variety over a $p$-adic field $K$ (here, a $p$-adic field is a finite extension of $\mathbb{Q}_{p}$ ). For an algebraic extension $L / K$, we denote by $A(L)$ the group of $L$-rational points of $A$ and also denote by $A(L)_{\text {tor }}$ its torsion subgroup. We are interested in determining whether $A(L)_{\text {tor }}$ is finite or not. The most basic result is given by Mattuck [Ma]; $A(L)_{\mathrm{tor}}$ is finite if $L$ is a finite extension of $K$. Thus our main interest is the case where $L$ is an infinite algebraic extension of $K$. For this, Imai's result $\llbracket \mathrm{m}$ is well-known. He showed that $A\left(K\left(\mu_{p^{\infty}}\right)\right)_{\text {tor }}$ is finite if $A$ has potential good reduction, where $\mu_{p^{\infty}}$ denotes the group of $p$-power roots of unity in a fixed separable closure $\bar{K}$ of $K$. Since the field $K\left(\mu_{p}\right)$ is the composite field of $K$ and the Lubin-Tate extension over $\mathbb{Q}_{p}$ associated with a uniformizer $p$ of $\mathbb{Q}_{p}$, we naturally have the following question.

Question. Let $A$ be an abelian variety over a $p$-adic field $K$. Let $k_{\pi}$ be the Lubin-Tate extension associated with a uniformizer $\pi$ of a $p$-adic field $k$. Then, is $A\left(K k_{\pi}\right)_{\text {tor }}$ finite?

In the case of Imai's theorem $\left(k=\mathbb{Q}_{p}\right.$ and $\left.\pi=p\right)$, the answer of the question is affirmative for good reduction cases. However, the question sometimes has a negative answer. For example, if $A$ is a Tate curve over $K, k=\mathbb{Q}_{p}$ and $\pi=p$, then $A\left(K k_{\pi}\right)\left[p^{\infty}\right]=A\left(K\left(\mu_{p}\right)\right)\left[p^{\infty}\right]$ is clearly infinite. We also have an example even for good reduction cases as given in Remark 2.10

The aim of this paper is to give a sufficient condition on $k$ and $\pi$ so that the question has an affirmative answer for good reduction cases. Let $k, \pi$ and $k_{\pi}$ be as above. Let $q$ be the order of the residue field of $k$. We denote by $k_{G}$ the Galois closure of $k / \mathbb{Q}_{p}$. We put $d_{G}=\left[k_{G}: \mathbb{Q}_{p}\right]$ and denote by $e_{G}$ the ramification index of the extension $k_{G} / k$. Our main result is as follows (see Definitions 2.1 and 2.2 for some undefined notion).

Theorem 1.1. Let $A$ be an abelian variety over a p-adic field $K$ with potential good reduction. If $\mathrm{Nr}_{k / \mathbb{Q}_{p}}(\pi)$ is not a $q$-Weil integer of weight $s d_{G} / t$ for some integers $1 \leq s \leq e_{G}$ and $1 \leq t \leq s d_{G}$, then $A\left(K k_{\pi}\right)_{\text {tor }}$ is finite.

Applying Theorem 1.1 to the case where $k=\mathbb{Q}_{p}$ and $\pi=p$, we can recover Imai's theorem. We should note that there is an another generalization of Imai's theorem which is given by Kubo and Taguchi [KT]. The main result of loc. cit. states that the torsion subgroup of $A\left(K\left(K^{1 / p^{\infty}}\right)\right)$ is

[^0]finite, where $A$ is an abelian variety over $K$ with potential good reduction and $K\left(K^{1 / p^{\infty}}\right)$ is the extension field of $K$ by adjoining all $p$-power roots of all elements of $K$.

For the proof of the above theorem, the essential difficulty appears in the finiteness of the $p$ power torsion part $A\left(K k_{\pi}\right)\left[p^{\infty}\right]$ of $A\left(K k_{\pi}\right)_{\text {tors }}$. For this, we proceed our arguments in more general settings. We study not only abelian varieties but also étale cohomology groups of proper smooth varieties.

Theorem 1.2. Let $X$ be a proper smooth variety over a p-adic field $K$ with potential good reduction. Let $V$ be a $\operatorname{Gal}(\bar{K} / K)$-stable subquotient of $H_{\text {ett }}^{i}\left(X_{\bar{K}}, \mathbb{Q}_{p}(r)\right)$ with $i \neq 2 r$. Assume that $V^{\operatorname{Gal}(\bar{K} / L)} \neq$ 0 for some finite extension $L / K k_{\pi}$. Then $\mathrm{Nr}_{k / \mathbb{Q}_{p}}(\pi)$ is a $q$-Weil number of weight $-(i-2 r) / h$ for some non-zero $h \in[-i+r, r] \bigcap\left(\bigcup_{1 \leq s \leq e_{G}}\left(1 / s d_{G}\right) \mathbb{Z}\right)$. Moreover, $q^{r} \operatorname{Nr}_{k / \mathbb{Q}_{p}}(\pi)^{-h}$ is an algebraic integer.

Applying Theorem 1.2 to the case where $k=\mathbb{Q}_{p}$ and $\pi=p$, we obtain [CSW, Theorem 1.5] for 0 -th cohomology groups. The assumption $i \neq 2 r$ in Theorem 1.2 is essential as explained in the Introduction of KT . The key ingredients for our proof are the theory of locally algebraic representations (cf. Se]) and some "weight arguments" of eigenvalues of Frobenius on various objects. For weight arguments, we use p-adic Hodge theory related with Lubin-Tate characters and results on weights of a Frobenius operator on crystalline cohomologies (cf. [CLS, KM , Na ).

Notation : In this paper, we fix algebraic closures $\overline{\mathbb{Q}}$ and $\overline{\mathbb{Q}}_{p}$ of $\mathbb{Q}$ and $\mathbb{Q}_{p}$, respectively, and we fix an embedding $\overline{\mathbb{Q}} \hookrightarrow \overline{\mathbb{Q}}_{p}$. If $F$ is a $p$-adic field, we denote by $G_{F}$ and $U_{F}$ the absolute Galois group $\operatorname{Gal}\left(\overline{\mathbb{Q}}_{p} / F\right)$ of $F$ and the unit group of the integer ring of $F$, respectively. We also denote by $F^{\text {ur }}$ and $I_{F}$ the maximal unramified extension of $F$ in $\overline{\mathbb{Q}}_{p}$ and the inertia subgroup $\operatorname{Gal}\left(\overline{\mathbb{Q}}_{p} / F^{\mathrm{ur}}\right)$ of $G_{F}$, respectively. We set $\Gamma_{F}:=\operatorname{Hom}_{\mathbb{Q}_{p}}\left(F, \overline{\mathbb{Q}}_{p}\right)$. If $F^{\prime} / F$ is a finite extension, we denote by $f_{F^{\prime} / F}$ the residual extension degree of $F / F^{\prime}$. that is, the extension degree of the residue fields corresponding to $F^{\prime} / F$. We put $f_{F}=f_{F / \mathbb{Q}_{p}}$.

## 2 Proofs of main theorems

Our goal is to prove results in the Introduction. Let $K, k$ and $E$ be a finite extension of $\mathbb{Q}_{p}$. Let $\pi$ be a uniformizer of $k$ and $k_{\pi}$ the Lubin-Tate extension of $k$ associated with $\pi$. We denote by $\chi_{\pi}: G_{k} \rightarrow k^{\times}$the Lubin-Tate character associated with $\pi$. If we regard $\chi_{\pi}$ as a continuous character $k^{\times} \rightarrow k^{\times}$by the local Artin map with arithmetic normalization, then $\chi_{\pi}$ is characterized by the property that $\chi_{\pi}(\pi)=1$ and $\chi_{\pi}(u)=u^{-1}$ for any $u \in U_{k}$.

Definition 2.1. Let $q_{0}>1$ be an integer. A $q_{0}$-Weil number (resp. $q_{0}$-Weil integer) of weight $w$ is an algebraic number (resp. algebraic integer) $\alpha$ such that $|\iota(\alpha)|=q_{0}^{w / 2}$ for all embeddings $\iota: \mathbb{Q}(\alpha) \hookrightarrow \mathbb{C}$.

Definition 2.2. Let $F$ be a finite extension of $\mathbb{Q}_{p}$ with residual extension degree $f=f_{F}$ and $F_{0} / \mathbb{Q}_{p}$ the maximal unramified subextension of $F / \mathbb{Q}_{p}$.
(1) Let $D$ be a $\varphi$-module over $F$, that is, a finite dimensional $F_{0}$-vector space with $\varphi_{F_{0}}$-semilinear $\operatorname{map} \varphi: D \rightarrow D$. Then $\varphi^{f}: D \rightarrow D$ is a $F_{0}$-linear map. We call $\operatorname{det}\left(T-\varphi^{f} \mid D\right)$ the characteristic polynomial of $D$.
(2) For a $\mathbb{Q}_{p}$-representation $U$ of $G_{F}$, we set $D_{\text {cris }}^{F}(U):=\left(B_{\text {cris }} \otimes_{\mathbb{Q}_{p}} U\right)^{G_{F}}$ and $D_{\mathrm{st}}^{F}(U):=\left(B_{\mathrm{st}} \otimes_{\mathbb{Q}_{p}}\right.$ $U)^{G_{F}}$, which are filtered $\varphi$-modules over $F$. Here, $B_{\text {cris }}$ and $B_{\text {st }}$ are usual $p$-adic period rings. Note that we have $D_{\text {cris }}^{F}(U)=D_{\mathrm{st}}^{F}(U)$ if $U$ is crystalline.
(3) Let $S$ be a set of rational numbers. Let $U$ be a potentially semi-stable $\mathbb{Q}_{p}$-representation of $G_{F}$. Suppose that $\left.U\right|_{G_{F^{\prime}}}$ is semi-stable for a finite extension $F^{\prime}$ of $F$ with residue field $\mathbb{F}_{q^{\prime}}$. We say
that $U$ has Weil weights in $S$ if any root of the characteristic polynomial of $D_{\mathrm{st}}^{F^{\prime}}(U)$ is a $q^{\prime}$-Weil number of weight $w$ for some $w \in S$. (Note that this definition does not depend on the choice of $F^{\prime}$.)

The following theorem is a key to the proof of our main results.
Theorem 2.3. Let $S$ be a subset of $\mathbb{Q} \backslash\{0\}$. Let $V$ be a semi-stable $\mathbb{Q}_{p}$-representation of $G_{K}$ with Hodge-Tate weights in $\left[h_{1}, h_{2}\right]$. Assume that $V$ has Weil weights in $S$ and $V^{\operatorname{Gal}(\bar{K} / L)} \neq 0$ for some finite extension $L / K k_{\pi}$. Then
(1) $\mathrm{Nr}_{k / \mathbb{Q}_{p}}(\pi)$ is a $q$-Weil number of weight $-w / h$ for some $w \in S$ and some non-zero $h \in$ $\left[h_{1}, h_{2}\right] \cap\left(\bigcup_{1 \leq s \leq e_{G}}\left(1 / s d_{G}\right) \mathbb{Z}\right)$.
(2) If the coefficients of the characteristic polynomial of $D_{\mathrm{st}}^{K}(V(-r))$ are algebraic integers for some integer $r$, then we can choose $h$ in (1) so that $q^{r} \mathrm{Nr}_{k / \mathbb{Q}_{p}}(\pi)^{-h}$ is an algebraic integer.

### 2.1 Proof of Theorem 2.3

In this section, we prove Theorem 2.3. We begin with some lemmas.
Lemma 2.4. Let $F$ be a p-adic field and $\left(n_{\sigma}\right)_{\sigma \in \Gamma_{F}}$ a family of integers. If there exists an open subgroup $U$ of $U_{F}$ with the property that $\prod_{\sigma \in \Gamma_{F}} \sigma(x)^{n_{\sigma}}=1$ for any $x \in U$, then we have $n_{\sigma}=0$ for any $\sigma \in \Gamma_{F}$.

Proof. Replacing $U$ by a finite index subgroup, we may assume that the $p$-adic logarithm map is defined on $U$. Then we have $\sum_{\sigma \in \Gamma_{F}} n_{\sigma} \sigma(\log x)=0$ for any $x \in U$. Since $\log U$ is an open ideal of the ring of integers of $F$, we obtain $\sum_{\sigma \in \Gamma_{F}} n_{\sigma} \sigma(y)=0$ for any $y \in F$. Although the desired fact $n_{\sigma}=0$ for any $\sigma \in \Gamma_{F}$ follows from Dedekind's theorem Bo, $\S 6$, no. 2, Corollaire 2] immediately, we also give a direct proof for this. Take any $\alpha \in F$ such that $F=\mathbb{Q}_{p}(\alpha)$ and let $\Gamma_{F}=\left\{\sigma_{1}=\mathrm{id}, \sigma_{2}, \ldots, \sigma_{c}\right\}$ where $c:=\left[F: \mathbb{Q}_{p}\right]$. Then we have $\left(n_{\sigma_{1}}, n_{\sigma_{2}}, \ldots, n_{\sigma_{c}}\right) X=\mathbf{0}$ where $X$ is the $c \times c$ matrix with $(i, j)$-th component $\sigma_{i}(\alpha)^{j-1}$. Since det $X=\prod_{j>i}\left(\sigma_{j}(\alpha)-\sigma_{i}(\alpha)\right) \neq 0$, we obtain $n_{\sigma_{1}}=n_{\sigma_{2}}=\cdots=n_{\sigma_{c}}=0$.

Lemma 2.5. Let $E$ be a p-adic field and $V$ an E-representation of $G_{K}$. Assume that $k / \mathbb{Q}_{p}$ is Galois, $V$ is Hodge-Tate and the $G_{K k_{\pi}}$-action on $V$ factors through a finite quotient. Then, there exist finite extensions $K^{\prime} / K$ and $E^{\prime} / E$ with $K^{\prime}, E^{\prime} \supset k$ such that any Jordan-Höllder factor of $\left.\left(V \otimes_{E} E^{\prime}\right)\right|_{G_{K^{\prime}}}$ is of the form $E^{\prime}\left(\prod_{\sigma \in \Gamma_{k}} \sigma^{-1} \circ \chi_{\pi}^{r_{\sigma}}\right)$ for some $r_{\sigma} \in \mathbb{Z}$. Moreover, $r_{\sigma}$ is a Hodge-Tate weight of $V$.

Proof. Replacing $K$ by a finite extension, we may assume that $G_{K k_{\pi}}$ acts on $V$ trivial and $K$ is a finite Galois extension of $k$. Since the $G_{K^{-}}$-action on $V$ factors through the abelian group $\operatorname{Gal}\left(K k_{\pi} / K\right)$, it follows from Schur's lemma that, for a finite extension $E^{\prime} / E$ large enough, any Jordan-Höllder factor $W$ of $V \otimes_{E} E^{\prime}$ is of dimension 1. Our goal is to show that $W$ is of the required form. We may assume $E^{\prime}=E \supset K$.

Let $\rho: G_{K} \rightarrow G L_{E}(W) \simeq E^{\times}$be the continuous homomorphism given by the $G_{K}$-action on $W$. Let $\tilde{E}$ be the Galois closure of $E / \mathbb{Q}_{p}$ and take any finite extension $K^{\prime \prime} / K$ which contains $\tilde{E}$. Since $W$ is Hodge-Tate, it follows from [Se, Chapter III, A. 5, Theorem 2] that there exists an open subgroup $I$ of $I_{K^{\prime \prime}}$ such that $\rho=\prod_{\sigma \in \Gamma_{E}} \sigma^{-1} \circ \chi_{\sigma E}^{n_{\sigma}}$ on $I$ for some integer $n_{\sigma}$. Here, $\chi_{\sigma E}: G_{\sigma E} \rightarrow U_{\sigma E}$ is the Lubin-Tate character associated with $\sigma E$ (it depends on the choice of a uniformizer of $\sigma E$, but its restriction to the inertia subgroup does not). Put $\tilde{\rho}=\prod_{\sigma \in \Gamma_{E}} \sigma^{-1} \circ \chi_{\sigma E}^{n_{\sigma}}$, considered as a character of $G_{K^{\prime \prime}}$. Replacing $K^{\prime \prime}$ by a finite extension, we may assume the following:

$$
-K^{\prime \prime} / \mathbb{Q}_{p} \text { is Galois, } \operatorname{Gal}\left(k_{\pi} /\left(k_{\pi} \cap K^{\prime \prime}\right)\right) \text { is torsion free and } \rho=\tilde{\rho} \text { on } I_{K^{\prime \prime}} .
$$

Since $\left.\rho\right|_{G_{K k_{\pi}}}$ is trivial, we have that $\tilde{\rho}$ is trivial on $I_{K^{\prime \prime}} \cap G_{K k_{\pi}}=G_{\left(K^{\prime \prime}\right)}{ }^{\text {ur }} k_{\pi}$. Hence, putting $N^{\prime}=$ $\operatorname{Gal}\left(\left(K^{\prime \prime}\right)^{\mathrm{ur}} k_{\pi} /\left(K^{\prime \prime}\right)^{\mathrm{ur}}\right)$, we may regard $\left.\tilde{\rho}\right|_{I_{K^{\prime \prime}}}$ as a representation of $N^{\prime}$. Put $N=\operatorname{Gal}\left(k^{\mathrm{ur}} k_{\pi} / k^{\mathrm{ur}}\right)$.

Then $N^{\prime}$ is canonically isomorphic to a torsion free finite index subgroup of $N \simeq U_{k}$, and thus we regard $N^{\prime}$ as a subgroup of $N$.

Now we claim that $\tilde{\rho}: N^{\prime} \rightarrow \tilde{E}^{\times}$extends to a continuous character $\hat{\rho}: N \rightarrow \overline{\mathbb{Q}}_{p}^{\times}$. It follows from the theory of elementary divisors that we may regard $N=N_{\text {tor }} \oplus\left(\oplus_{i=1}^{d} \mathbb{Z}_{p}\right) \supset\{0\} \oplus\left(\oplus_{i=1}^{d} p^{m_{i}} \mathbb{Z}_{p}\right)=$ $N^{\prime}$ with some integer $m_{i} \geq 0$. Here, $N_{\text {tor }}$ is the torsion subgroup of $N$ and $d:=\left[k: \mathbb{Q}_{p}\right]$. Hence it suffices to show that any continuous character $p^{m} \mathbb{Z}_{p} \rightarrow \overline{\mathbb{Q}}_{p}^{\times}$with $m>0$ extends to $\mathbb{Z}_{p} \rightarrow \overline{\mathbb{Q}}_{p}^{\times}$, but this is clear.

By local class field theory, we may regard $\left.\tilde{\rho}\right|_{I_{K^{\prime \prime}}}$ and $\hat{\rho}$ as characters of $U_{K^{\prime \prime}}$ and $U_{k}$, respectively. It follows from the construction of $\hat{\rho}$ that we have $\tilde{\rho}(x)=\hat{\rho}\left(\operatorname{Nr}_{K^{\prime \prime} / k}(x)\right)$ for $x \in U_{K^{\prime \prime}}$. In particular, we have

$$
\begin{equation*}
\tilde{\rho}(x)=\tilde{\rho}(\tau x) \tag{2.1}
\end{equation*}
$$

for $x \in U_{K^{\prime \prime}}$ and $\tau \in \operatorname{Gal}\left(K^{\prime \prime} / k\right)$. On the other hand, by definition of $\tilde{\rho}$ and the condition that $K^{\prime \prime} / \mathbb{Q}_{p}$ is Galois, we have

$$
\begin{equation*}
\tilde{\rho}(x)=\prod_{\sigma \in \Gamma_{E}} \sigma^{-1} \mathrm{Nr}_{K^{\prime \prime} / \sigma E}\left(x^{-1}\right)^{n_{\sigma}}=\prod_{\tilde{\sigma} \in \Gamma_{K^{\prime \prime}}} \tilde{\sigma}^{-1}\left(x^{-1}\right)^{n_{\tilde{\sigma}}} \tag{2.2}
\end{equation*}
$$

for $x \in U_{K^{\prime \prime}}$ where $n_{\tilde{\sigma}}:=n_{\sigma}$ if $\left.\tilde{\sigma}\right|_{E}=\sigma$.
We claim that $n_{\tilde{\sigma}}=n_{\tilde{\sigma}^{\prime}}$ if $\left.\tilde{\sigma}\right|_{k}=\left.\tilde{\sigma}^{\prime}\right|_{k}$. By (2.1) and (2.2), we have

$$
\begin{equation*}
\prod_{\tilde{\sigma} \in \Gamma_{K^{\prime \prime}}} \tilde{\sigma}^{-1}\left(x^{-1}\right)^{n_{\tau \tilde{\sigma}}}=\prod_{\tilde{\sigma} \in \Gamma_{K^{\prime \prime}}} \tilde{\sigma}^{-1}\left(x^{-1}\right)^{n_{\tilde{\sigma}}} \tag{2.3}
\end{equation*}
$$

for $x \in U_{K^{\prime \prime}}$ and $\tau \in \operatorname{Gal}\left(K^{\prime \prime} / k\right)$. Choosing a lift $\hat{\sigma} \in \Gamma_{K^{\prime \prime}}$ for each element of $\operatorname{Gal}\left(k / \mathbb{Q}_{p}\right)$, we have a decomposition $\Gamma_{K^{\prime \prime}}=\bigcup_{\hat{\sigma}} \hat{\sigma} \operatorname{Gal}\left(K^{\prime \prime} / k\right)$. Since $k / \mathbb{Q}_{p}$ is Galois, we see that $\operatorname{Gal}\left(K^{\prime \prime} / k\right)$ acts on $\hat{\sigma} \operatorname{Gal}\left(K^{\prime \prime} / k\right)$ stable and this action is transitive. By Lemma 2.4 we know that the family $\left(n_{\tilde{\sigma}}\right)_{\tilde{\sigma} \in \Gamma_{K^{\prime \prime}}}$ is determined uniquely by the restriction of $\prod_{\sigma \in \Gamma_{K^{\prime \prime}}}\left(\tilde{\sigma}^{-1}\right)^{n_{\tilde{\sigma}}}$ to any open subgroup of $U_{K^{\prime \prime}}$. Hence the equation (2.3) gives $n_{\tilde{\sigma}}=n_{\tilde{\sigma}^{\prime}}$ if $\left.\tilde{\sigma}\right|_{k}=\left.\tilde{\sigma}^{\prime}\right|_{k}$ as desired.

For any $\sigma \in \Gamma_{k}$, we define $r_{\sigma}:=n_{\tilde{\sigma}}$ for a lift $\tilde{\sigma} \in \Gamma_{K^{\prime \prime}}$ of $\sigma$, which is independent of the choice of $\tilde{\sigma}$ by the claim just above. Then we see $\tilde{\rho}(x)=\prod_{\tilde{\sigma} \in \Gamma_{K^{\prime \prime}}} \tilde{\sigma}^{-1}\left(x^{-1}\right)^{n_{\tilde{\sigma}}}=\prod_{\sigma \in \Gamma_{k}} \sigma^{-1} \mathrm{Nr}_{K^{\prime \prime} / k}\left(x^{-1}\right)^{r_{\sigma}}$ for $x \in U_{K^{\prime \prime}}$. This implies

$$
\tilde{\rho}=\prod_{\sigma \in \Gamma_{k}} \sigma^{-1} \circ \chi_{\pi}^{r_{\sigma}}
$$

on $I_{K^{\prime \prime}}$. Now we define $\psi: G_{K} \rightarrow E^{\times}$by $\psi:=\rho \cdot\left(\prod_{\sigma \in \Gamma_{k}} \sigma^{-1} \circ \chi_{\pi}^{r_{\sigma}}\right)^{-1}$. Then $\psi$ is trivial on $I_{K^{\prime \prime}}$ since $\rho=\tilde{\rho}=\prod_{\sigma \in \Gamma_{k}} \sigma^{-1} \circ \chi_{\pi}^{r_{\sigma}}$ on $I_{K^{\prime \prime}}$. Furthermore, $\psi$ is trivial on $G_{K k_{\pi}}$ since $\chi_{\pi}$ and $\rho$ is trivial on $G_{K k_{\pi}}$. Therefore, putting $K^{\prime}=\left(K^{\prime \prime}\right)^{\mathrm{ur}} \cap K k_{\pi}$, then $K^{\prime} / K$ is a finite extension and $\psi$ is trivial on $G_{K^{\prime}}$.

Finally, we note that $r_{\sigma}$ is a Hodge-Tate weight of $V$ by [Se, Chapter III, A.5, Theorem 2]. This is the end of the proof.

Lemma 2.6. Let $E$ be a p-adic field and $V$ an E-representation of $G_{K}$. Assume that $k / \mathbb{Q}_{p}$ is Galois, $V$ is potentially semi-stable with Hodge-Tate weights in $\left[h_{1}, h_{2}\right]$ and the $G_{K k_{\pi}}$-action on $V$ factors through a finite quotient. Then, there exists a finite extension $K^{\prime} / K k$ which satisfy the following property: $\left.V\right|_{G_{K^{\prime}}}$ is semi-stable and, for any root $\alpha$ of the characteristic polynomial of $D_{\mathrm{st}}^{K^{\prime}}(V)$, we have

$$
\alpha=a^{f_{K^{\prime} / k}}, \quad a=\prod_{\tau \in \Gamma_{k}} \tau(\pi)^{-n_{\tau}}
$$

for some integers $\left(n_{\tau}\right)_{\tau \in \Gamma_{k}}$ such that $d h_{1} \leq \sum_{\tau \in \Gamma_{k}} n_{\tau} \leq d h_{2}$. Here, $d:=\left[k: \mathbb{Q}_{p}\right]$.
Proof. By Lemma 2.5 there exist finite extensions $K^{\prime} / K$ and $E^{\prime} / E$ with $E^{\prime}, K^{\prime} \supset k$ which satisfy the following:

- $\left.V\right|_{G_{K^{\prime}}}$ is semi-stable and any Jordan-Höllder factor $W$ of $\left.\left(V \otimes_{E} E^{\prime}\right)\right|_{G_{K^{\prime}}}$ is of the form $E^{\prime}\left(\prod_{\sigma \in \Gamma_{k}} \sigma^{-1} \circ \chi_{\pi}^{r_{\sigma}}\right)$ for some $r_{\sigma} \in\left[h_{1}, h_{2}\right]$. In particular, $W$ is crystalline.
Replacing $E$ by a finite extension, we may assume $E^{\prime}=E$. Now we take a root $\alpha$ of the characteristic polynomial of $D_{\mathrm{st}}^{K^{\prime}}(V)$, and choose $W$ so that $\alpha$ is a root of the the characteristic polynomial of $D_{\text {cris }}^{K^{\prime}}(W)$.

To study $\alpha$, we first consider the characteristic polynomial of $D_{\text {cris }}^{K^{\prime}}\left(E\left(\sigma^{-1} \circ \chi_{\pi}^{r_{\sigma}}\right)\right)$ for $\sigma \in \Gamma_{k}$. Let $K_{0}^{\prime}$ be the maximal unramified subextension of $K^{\prime} / \mathbb{Q}_{p}$ and put $q^{\prime}=p^{f_{K^{\prime}}}$. We note that we have an isomorphism $k\left(\sigma^{-1} \circ \chi_{\pi}^{r_{\sigma}}\right)^{\mathrm{ss}} \simeq k\left(\chi_{\pi}^{r_{\sigma}}\right)^{\mathrm{ss}}$ of $\mathbb{Q}_{p}\left[G_{K^{\prime}}\right]$-modules (here, "ss" stands for the semi-simplification of $\mathbb{Q}_{p}\left[G_{K^{\prime}}\right]$-modules). In fact, for any $g \in G_{K^{\prime}}$, we have

$$
\begin{aligned}
\operatorname{Tr}_{\mathbb{Q}_{p}}\left(g \mid k\left(\sigma^{-1} \circ \chi_{\pi}^{r_{\sigma}}\right)\right) & =\operatorname{Tr}_{k / \mathbb{Q}_{p}}\left(\operatorname{Tr}_{k}\left(g \mid k\left(\sigma^{-1} \circ \chi_{\pi}^{r_{\sigma}}\right)\right)=\operatorname{Tr}_{k / \mathbb{Q}_{p}}\left(\sigma^{-1} \chi_{\pi}^{r_{\sigma}}(g)\right)\right. \\
& =\operatorname{Tr}_{k / \mathbb{Q}_{p}}\left(\chi_{\pi}^{r_{\sigma}}(g)\right)=\operatorname{Tr}_{k / \mathbb{Q}_{p}}\left(\operatorname{Tr}_{k}\left(g \mid k\left(\chi_{\pi}^{r_{\sigma}}\right)\right)=\operatorname{Tr}_{\mathbb{Q}_{p}}\left(g \mid k\left(\chi_{\pi}^{r_{\sigma}}\right)\right) .\right.
\end{aligned}
$$

(Here, for a representation $U$ of a group $G$ over a field $F$ and $g \in G$, we denote by $\operatorname{Tr}_{F}(g \mid U)$ the trace of the $g$-action on the $F$-vector space $U$.) Therefore, we have

$$
\begin{equation*}
\operatorname{det}\left(T-\varphi^{f_{K^{\prime}}} \mid D_{\text {cris }}^{K^{\prime}}\left(E\left(\sigma^{-1} \circ \chi_{\pi}^{r_{\sigma}}\right)\right)\right)=\operatorname{det}\left(T-\varphi^{f_{K^{\prime}}} \mid D_{\text {cris }}^{K^{\prime}}\left(k\left(\chi_{\pi}^{r_{\sigma}}\right)\right)\right)^{[E: k]} \tag{2.4}
\end{equation*}
$$

To study the roots of (2.4), we recall the explicit description of $D_{\text {cris }}^{k}\left(k\left(\chi_{\pi}^{-1}\right)\right)$ (cf. Con, Proposition B.4]. See also [Col, Proposition 9.10]). Let $k_{0}$ be the maximal unramified subextension of $k / \mathbb{Q}_{p}$. By definition, we have $f_{k}=\left[k_{0}: \mathbb{Q}_{p}\right]$ and $q=p^{f_{k}}$. Then $D_{\text {cris }}^{k}\left(k\left(\chi_{\pi}^{-1}\right)\right)$ is a free $\left(k_{0} \otimes_{\mathbb{Q}_{p}} k\right)$-module of rank one, and we can take a basis $\mathbf{e}$ of $D_{\text {cris }}^{k}\left(k\left(\chi_{\pi}^{-1}\right)\right)$ such that $\varphi^{f_{k}}(\mathbf{e})=(1 \otimes \pi) \mathbf{e}$. We claim

$$
\begin{equation*}
\operatorname{det}\left(T-\varphi^{f_{k}} \mid D_{\text {cris }}^{k}\left(k\left(\chi_{\pi}^{-1}\right)\right)\right)=\prod_{0 \leq i \leq f_{k}-1} E^{\varphi^{i}}(T) \tag{2.5}
\end{equation*}
$$

where $E(T)=T^{e}+\sum_{j=0}^{e-1} a_{j} T^{j} \in k_{0}[T]$ is the minimal polynomial of $\pi$ over $k_{0}$ and $E^{\varphi^{i}}(T)=$ $T^{e}+\sum_{j=0}^{e-1} \varphi^{i}\left(a_{j}\right) T^{j}$. To show this, it suffices to show that the characteristic polynomial of the homomorphism $1 \otimes \pi: k_{0} \otimes_{\mathbb{Q}_{p}} k \rightarrow k_{0} \otimes_{\mathbb{Q}_{p}} k$ of $k_{0}$-modules coincides with the right hand side of 2.5). (Here, the $k_{0}$-action on $k_{0} \otimes_{\mathbb{Q}_{p}} k$ is given by $a .(x \otimes y):=a x \otimes y$ for $a, x \in k_{0}$ and $y \in k$.) We consider a natural isomorphism

$$
k_{0} \otimes_{\mathbb{Q}_{p}} k_{0} \simeq \oplus_{j \in \mathbb{Z} / f_{k} \mathbb{Z}} k_{0, j}, \quad a \otimes b \mapsto\left(a \varphi^{j}(b)\right)_{j}
$$

where $k_{0, j}=k_{0}$. For $0 \leq s \leq f_{k}-1$, let $e_{s} \in k_{0} \otimes_{\mathbb{Q}_{p}} k_{0}$ be the element which corresponds to $\left(\delta_{s j}\right)_{j} \in$ $\oplus_{j \in \mathbb{Z} / f_{k} \mathbb{Z}} k_{0, j}$ where $\delta_{s j}$ is the Kronecker delta. Then $\left\{e_{j}\left(1 \otimes \pi^{i}\right) \mid 0 \leq j \leq f_{k}-1,0 \leq i \leq e-1\right\}$ is a $k_{0}$-basis of $k_{0} \otimes_{\mathbb{Q}_{p}} k$. We see that the matrix of $1 \otimes \pi: k_{0} \otimes_{\mathbb{Q}_{p}} k \rightarrow k_{0} \otimes_{\mathbb{Q}_{p}} k$ associated with the ordered basis $\left\langle e_{0}, \ldots, e_{f_{k}-1}, e_{0}(1 \otimes \pi), \ldots, e_{f_{k}-1}(1 \otimes \pi), \ldots, e_{0}\left(1 \otimes \pi^{e-1}\right), \ldots, e_{f_{k}-1}\left(1 \otimes \pi^{e-1}\right)\right\rangle$ is

$$
\left(\begin{array}{cccc}
O & O & \cdots & -A_{0} \\
I_{f_{k}} & O & \cdots & -A_{1} \\
\vdots & \ddots & & \vdots \\
O & \cdots & I_{f_{k}} & -A_{e-1}
\end{array}\right)
$$

where $I_{f_{k}}$ is the $f_{k} \times f_{k}$ identity matrix and $A_{i}$ is the $f_{k} \times f_{k}$ diagonal matrix with diagonal entries $a_{i}, \varphi\left(a_{i}\right), \ldots, \varphi^{f_{k}-1}\left(a_{i}\right)$. Now it is an easy exercise to check that the characteristic polynomial of this matrix is $\prod_{0 \leq i \leq f_{k}-1} E^{\varphi^{i}}(T)$ as desired.

By the claim (2.5), we know that any root of the characteristic polynomial of $D_{\text {cris }}^{K^{\prime}}\left(k\left(\chi_{\pi}\right)\right)$ is of the form $\tau(\pi)^{-f_{K^{\prime} / k}}$ for some $\tau \in \Gamma_{k}$. Hence, by 2.4), any root of the characteristic polynomial of $D_{\text {cris }}^{K^{\prime}}\left(E\left(\sigma^{-1} \circ \chi_{\pi}^{r_{\sigma}}\right)\right)$ is of the form $\prod_{\tau \in \Gamma_{k}} \tau(\pi)^{-f_{K^{\prime} / k} n_{\tau}^{\sigma}}$ with $\sum_{\tau \in \Gamma_{k}} n_{\tau}^{\sigma}=r_{\sigma}$. Therefore, since $\alpha$ is a root of the characteristic polynomial of $D_{\text {cris }}^{K^{\prime}}(W)=D_{\text {cris }}^{K^{\prime}}\left(E\left(\prod_{\sigma \in \Gamma_{k}} \sigma^{-1} \circ \chi_{\pi}^{r_{\sigma}}\right)\right)$, we have

$$
\alpha=\prod_{\tau \in \Gamma_{k}} \tau(\pi)^{-f_{K^{\prime} / k} n_{\tau}}
$$

with $-\sum_{\tau \in \Gamma_{k}} n_{\tau}=-\sum_{\sigma \in \Gamma_{k}} r_{\sigma}=: R$. We note that $R$ is an integer such that $-d h_{2} \leq R \leq-d h_{1}$ since we have $r_{\sigma} \in\left[h_{1}, h_{2}\right]$. This completes the proof.

We need the following two standard lemmas which describe inclusion properties of two LubinTate extensions.

Lemma 2.7. Let $k_{2} / k_{1}$ be a finite extension of p-adic fields with residual extension degree $f$. For $i=1,2$, let $\pi_{i}$ be a uniformizer of $k_{i}$ and $k_{i, \pi_{i}} / k_{i}$ the Lubin-Tate extension associated with $\pi_{i}$.
(1) We have $\operatorname{Nr}_{k_{2} / k_{1}}\left(\pi_{2}\right)=\pi_{1}^{f}$ if and only if $k_{1, \pi_{1}} \subset k_{2, \pi_{2}}$.
(2) $\pi_{1}^{-f} \operatorname{Nr}_{k_{2} / k_{1}}\left(\pi_{2}\right)$ is a root of unity if and only if there exists a finite extension $M / k_{2, \pi_{2}}$ such that $k_{1, \pi_{1}} \subset M$. If this is the case, we can take $M$ to be the degree $\sharp \mu_{\infty}\left(k_{1}\right)$ subextension in $k_{2}^{\mathrm{ab}} / k_{2, \pi_{2}}$. Here, $\mu_{\infty}\left(k_{1}\right)$ is the set of roots of unity in $k_{1}$,
Proof. For $i=1,2$, we denote by $k_{i}^{\mathrm{ur}}$ and $k_{i}^{\mathrm{ab}}$ the maximal unramified extension of $k_{i}$ and the maximal abelian extension of $k_{i}$, respectively. We recall that the Artin map $\operatorname{Art}_{k_{i}}: k_{i}^{\times} \rightarrow \operatorname{Gal}\left(k_{i}^{\mathrm{ab}} / k_{i}\right)$ associated with $k_{i}$ satisfies $\left.\operatorname{Art}_{k_{i}}\left(\pi_{i}\right)\right|_{k_{i, \pi_{i}}}=\mathrm{id}$ and $\left.\operatorname{Art}_{k_{i}}\left(\pi_{i}\right)\right|_{k_{i}^{\text {ur }}}=\operatorname{Frob}_{k_{i}}$, where $\operatorname{Frob}_{k_{i}}$ is the geometric Frobenius of $k_{i}$.
(1) Suppose $\operatorname{Nr}_{k_{2} / k_{1}}\left(\pi_{2}\right)=\pi_{1}^{f}$. For any lift $\sigma \in G_{k_{2}}$ of $\operatorname{Art}_{k_{2}}\left(\pi_{2}\right)$, we have

$$
\left.\sigma\right|_{k_{1, \pi_{1}}}=\left.\left(\left.\operatorname{Art}_{k_{2}}\left(\pi_{2}\right)\right|_{k_{1}^{\mathrm{ab}}}\right)\right|_{k_{1, \pi_{1}}}=\left.\operatorname{Art}_{k_{1}}\left(\operatorname{Nr}_{k_{2} / k_{1}}\left(\pi_{2}\right)\right)\right|_{k_{1, \pi_{1}}}=\left.\operatorname{Art}_{k_{1}}\left(\pi_{1}\right)^{f}\right|_{k_{1, \pi_{1}}}=\mathrm{id}
$$

Since the intersection of the fixed fields (in $\overline{\mathbb{Q}}_{p}$ ) of such $\sigma$ 's is $k_{2, \pi_{2}}$, we obtain the desired result.
Conversely, suppose $k_{1, \pi_{1}} \subset k_{2, \pi_{2}}$. Then we have

$$
\left.\operatorname{Art}_{k_{1}}\left(\operatorname{Nr}_{k_{2} / k_{1}}\left(\pi_{2}\right)\right)\right|_{k_{1, \pi_{1}}}=\left.\operatorname{Art}_{k_{2}}\left(\pi_{2}\right)\right|_{k_{1, \pi_{1}}}=\left.\left(\left.\operatorname{Art}_{k_{2}}\left(\pi_{2}\right)\right|_{k_{2, \pi_{2}}}\right)\right|_{k_{1, \pi_{1}}}=\mathrm{id}
$$

and

$$
\left.\operatorname{Art}_{k_{1}}\left(\operatorname{Nr}_{k_{2} / k_{1}}\left(\pi_{2}\right)\right)\right|_{k_{1}^{\text {ur }}}=\left.\operatorname{Art}_{k_{2}}\left(\pi_{2}\right)\right|_{k_{1}^{\text {ur }}}=\left.\left(\left.\operatorname{Art}_{k_{2}}\left(\pi_{2}\right)\right|_{k_{2}^{\mathrm{ur}}}\right)\right|_{k_{1}^{\text {ur }}}=\left.\operatorname{Frob}_{k_{2}}\right|_{k_{1}^{\mathrm{ur}}}=\operatorname{Frob}_{k_{1}}^{f} .
$$

Thus we have $\operatorname{Art}_{k_{1}}\left(\operatorname{Nr}_{k_{2} / k_{1}}\left(\pi_{2}\right)\right)=\operatorname{Art}_{k_{1}}\left(\pi_{1}^{f}\right)$, which shows $\operatorname{Nr}_{k_{2} / k_{1}}\left(\pi_{2}\right)=\pi_{1}^{f}$.
(2) A very similar proof to that of (1) proceeds. Suppose that $\pi_{1}^{-f} \mathrm{Nr}_{k_{2} / k_{1}}\left(\pi_{2}\right)$ is a root of unity. If we denote by $h$ the order of the set of roots of unity in $k_{1}$, then we have $\operatorname{Nr}_{k_{2} / k_{1}}\left(\pi_{2}^{h}\right)=\pi_{1}^{f h}$. We see that any lift $\sigma \in G_{k_{2}}$ of $\operatorname{Art}_{k_{2}}\left(\pi_{2}^{h}\right)$ fixes $k_{1, \pi_{1}}$. This implies that $k_{1, \pi_{1}}$ is contained in the degree $h$ subextension in $k_{2}^{\text {ab }} / k_{2, \pi_{2}}$.

Suppose that there exists a finite extension $M / k_{2, \pi_{2}}$ such that $k_{1, \pi_{1}} \subset M$. Then $M^{\prime}:=$ $k_{1, \pi_{1}} k_{2, \pi_{2}}$ is a finite subextension in $k_{2}^{\text {ab }} / k_{2, \pi_{2}}$. Put $h=\left[M^{\prime}: k_{2, \pi_{2}}\right]$. Since $\left.\operatorname{Art}_{k_{2}}\left(\pi_{2}^{h}\right)\right|_{M^{\prime}}$ is the identity map, we have $\left.\operatorname{Art}_{k_{1}}\left(\operatorname{Nr}_{k_{2} / k_{1}}\left(\pi_{2}^{h}\right)\right)\right|_{k_{1, \pi_{1}}}=$ id and $\left.\operatorname{Art}_{k_{1}}\left(\operatorname{Nr}_{k_{2} / k_{1}}\left(\pi_{2}^{h}\right)\right)\right|_{k_{1}^{\text {ur }}}=\operatorname{Frob}_{k_{1}}^{f h}$. Thus we have $\operatorname{Art}_{k_{1}}\left(\operatorname{Nr}_{k_{2} / k_{1}}\left(\pi_{2}^{h}\right)\right)=\operatorname{Art}_{k_{1}}\left(\pi_{1}^{f h}\right)$, which shows $\operatorname{Nr}_{k_{2} / k_{1}}\left(\pi_{2}^{h}\right)=\pi_{1}^{f h}$.

We recall that $k_{G}$ is the Galois closure of $k / \mathbb{Q}_{p}$ and $d_{G}:=\left[k_{G}: \mathbb{Q}_{p}\right]$.
Lemma 2.8. There exist a finite unramified extension $k^{\prime} / k_{G}$ and a uniformizer $\pi^{\prime}$ of $k^{\prime}$ which satisfy the following.

- $\operatorname{Nr}_{k^{\prime} / k}\left(\pi^{\prime}\right)=\pi^{f_{k^{\prime} / k}}$,
- $k_{\pi} \subset k_{\pi^{\prime}}^{\prime}$, where $k_{\pi^{\prime}}^{\prime}$ is the Lubin-Tate extension of $k^{\prime}$ associated with $\pi^{\prime}$,
- the extension $k^{\prime} / \mathbb{Q}_{p}$ is Galois, and
- $\left[k^{\prime}: \mathbb{Q}_{p}\right]=s d_{G}$ for some integer $1 \leq s \leq e_{G}$.

Proof. Let $k_{G, 0} / k$ be the maximal unramified subextension in $k_{G} / k$. By Se, Chapter $\mathrm{V}, \S 6$, Proposition 10], there exists an unramified extension $\tilde{k}_{0}$ over $k_{G, 0}$ of degree at most $\left[k_{G}: k_{G, 0}\right]$ (= $\left.e_{G}\right)$ such that $\pi=\operatorname{Nr}_{k^{\prime} / \tilde{k}_{0}}\left(\pi^{\prime}\right)$ for some $\pi^{\prime} \in\left(k^{\prime}\right)^{\times}$, where $k^{\prime}:=k_{G} \tilde{k}_{0}$. Since $k_{G} / \mathbb{Q}_{p}$ is Galois and $k^{\prime} / k_{G}$ is unramified, we see that $k^{\prime} / \mathbb{Q}_{p}$ is Galois. We also see that $\pi^{\prime}$ is a uniformizer of $k^{\prime}$. Since $k_{G} \cap \tilde{k}_{0}=k_{G, 0}$, we have $\left[k^{\prime}: k_{G}\right]=\left[\tilde{k}_{0}: k_{G, 0}\right] \leq e_{G}$. Thus we obtain $\left[k^{\prime}: \mathbb{Q}_{p}\right]=\left[k^{\prime}: k_{G}\right]\left[k_{G}:\right.$ $\left.\mathbb{Q}_{p}\right]=s d_{G}$ for some integer $1 \leq s \leq e_{G}$. Furthermore, we have $\operatorname{Nr}_{k^{\prime} / k}\left(\pi^{\prime}\right)=\operatorname{Nr}_{\tilde{k}_{0} / k}\left(\operatorname{Nr}_{k^{\prime} / \tilde{k}_{0}}\left(\pi^{\prime}\right)\right)=$ $\mathrm{Nr}_{\tilde{k}_{0} / k}(\pi)=\pi^{f_{k^{\prime} / k}}$. By Lemma 2.7] we have $k_{\pi} \subset k_{\pi^{\prime}}^{\prime}$.

Now we are ready to prove Theorem [2.3,
Proof of Theorem 2.3, First we consider the case where $k / \mathbb{Q}_{p}$ is Galois. Replacing $L$ by a finite extension, we may assume that $L / K$ is Galois. Then $V^{G_{L}}$ is a $G_{K}$-stable submodule of $V$. By Lemma 2.6, there exists a finite extension $K^{\prime} / K k$ such that any root $\alpha$ of the characteristic polynomial of $D_{\mathrm{st}}^{K^{\prime}}\left(V^{G_{L}}\right)$ is of the form

$$
\alpha=a^{f_{K^{\prime} / k}}, \quad a=\prod_{\tau \in \Gamma_{k}} \tau(\pi)^{-n_{\tau}}
$$

with some integers $\left(n_{\tau}\right)_{\tau \in \Gamma_{k}}$ such that $d h_{1} \leq \sum_{\tau \in \Gamma_{k}} n_{\tau} \leq d h_{2}$. Here, $d:=\left[k: \mathbb{Q}_{p}\right]$. Put $R:=$ $-\sum_{\tau \in \Gamma_{k}} n_{\tau}$. Then we have

$$
\begin{equation*}
\prod_{\sigma \in \Gamma_{k}} \sigma(a)=\prod_{\tau \in \Gamma_{k}} \prod_{\sigma \in \Gamma_{k}} \sigma \tau(\pi)^{-n_{\tau}}=\prod_{\tau \in \Gamma_{k}} \mathrm{Nr}_{k / \mathbb{Q}_{p}}(\pi)^{-n_{\tau}}=\mathrm{Nr}_{k / \mathbb{Q}_{p}}(\pi)^{R} \tag{2.6}
\end{equation*}
$$

Since $V^{G_{L}}$ has Weil weights in $S$, we see that $\sigma(a)$ is a $q$-Weil number of weight $w \in S$ for any $\sigma \in \Gamma_{k}$. Thus it follows from the condition $w \neq 0$ and the equation (2.6) that we have $R \neq 0$. Therefore, we obtain that $\mathrm{Nr}_{k / \mathbb{Q}_{p}}(\pi)$ is a $q$-Weil number of weight $-w / h$ where $h:=-R / d \in$ $\left[h_{1}, h_{2}\right] \cap(1 / d) \mathbb{Z}$. This shows Theorem 2.3 (1). Now Theorem 2.3 (2) follows from the fact that we have $\left(q^{r} \mathrm{Nr}_{k / \mathbb{Q}_{p}}(\pi)^{-h}\right)^{d}=\mathrm{Nr}_{k / \mathbb{Q}_{p}}\left(q^{r} a\right)$ and $\left(q^{r} a\right)^{f_{K^{\prime} / k}}=q_{K^{\prime}}^{r} \alpha$ is a root of the characteristic polynomial of $D_{\mathrm{st}}^{K}(V(-r))$. Thus we obtained a proof of Theorem 2.3 in the case where $k / \mathbb{Q}_{p}$ is Galois.

Next we consider the case where $k / \mathbb{Q}_{p}$ is not necessarily Galois. Take a finite extension $k^{\prime} / k_{G}$ and a uniformizer $\pi^{\prime}$ of $k^{\prime}$ as in Lemma 2.8. Put $d^{\prime}=\left[k^{\prime}: \mathbb{Q}_{p}\right]$. We have $d^{\prime}=s d_{G}$ for some $1 \leq s \leq e_{G}$. Let $q^{\prime}$ be the order of the residue field of $k^{\prime}$. Let $L^{\prime}$ be the composite field of $L$ and $k_{\pi^{\prime}}^{\prime}$, which is a finite extension of $K k_{\pi^{\prime}}^{\prime}$. Assume that $V^{G_{L}}$ is not zero. Since $V^{G_{L^{\prime}}}$ is also not zero and the extension $k^{\prime} / \mathbb{Q}_{p}$ is Galois, we know that $\operatorname{Nr}_{k^{\prime}} / \mathbb{Q}_{p}\left(\pi^{\prime}\right)$ is a $q^{\prime}$-Weil number of weight $-w / h$ for some $w \in S$ and $h \in\left[h_{1}, h_{2}\right] \cap\left(1 / d^{\prime}\right) \mathbb{Z}$. By the equation $\operatorname{Nr}_{k^{\prime} / k}\left(\pi^{\prime}\right)=\pi^{f_{k^{\prime} / k}}$, we have $\operatorname{Nr}_{k^{\prime}} / \mathbb{Q}_{p}\left(\pi^{\prime}\right)=$ $\left(\operatorname{Nr}_{k / \mathbb{Q}_{p}}(\pi)\right)^{f_{k^{\prime} / k}}$, and hence $\operatorname{Nr}_{k / \mathbb{Q}_{p}}(\pi)$ is a $q$-Weil number of weight $-w / h$. Furthermore, we have $q^{\prime r} \mathrm{Nr}_{k^{\prime}} / \mathbb{Q}_{p}\left(\pi^{\prime}\right)^{-h}=\left(q^{r} \mathrm{Nr}_{k / \mathbb{Q}_{p}}(\pi)^{-h}\right)^{f_{k^{\prime} / k}}$. This completes the proof of Theorem 2.3,

### 2.2 Proofs of Theorems 1.1 and 1.2

We prove Theorems 1.1 and 1.2 in the Introduction. We start with a proof of Theorem 1.2
Proof of Theorem 1.2. Let the notation be as in the theorem. Replacing $K$ by a finite extension, we may assume that $X$ has good reduction over $K$. Then we know that $V$ is crystalline with HodgeTate weights in $[-i+r, r]$. Let $K_{0}$ be the maximal unramified subextension of $K / \mathbb{Q}_{p}$. Put $q_{K}=p^{f_{K}}$, the order of the residue field of $K$. By Theorem [2.3, it suffices to show that the characteristic polynomial of $D_{\text {cris }}^{K}\left(H_{\text {ett }}^{i}\left(X_{\bar{K}}, \mathbb{Q}_{p}\right)\right)$ has integer coefficients and its roots are $q_{K}$-Weil numbers of weight $i$. Let $Y$ be the special fiber of a proper smooth model of $X$ over the integer ring of $K$. By the crystalline conjecture shown by Faltings (cf. [Fa]), we have an isomorphism $D_{\text {cris }}^{K}\left(H_{\text {et }}^{i}\left(X_{\bar{K}}, \mathbb{Q}_{p}\right)\right) \simeq$ $K_{0} \otimes_{W\left(\mathbb{F}_{q_{K}}\right)} H_{\text {cris }}^{i}\left(Y / W\left(\mathbb{F}_{q_{K}}\right)\right)$ of $\varphi$-modules over $K_{0}$. It follows from Corollary 1.3 of [CLS] (cf. [KM, Theorem 1] and [Na, Remark 2.2.4 (4)]) that the characteristic polynomial of $K_{0} \otimes_{W\left(\mathbb{F}_{q_{K}}\right)}$
$H_{\text {cris }}^{i}\left(Y / W\left(\mathbb{F}_{q_{K}}\right)\right)$ coincides with $\operatorname{det}\left(T-\operatorname{Frob}_{\mathbb{F}_{q_{K}}} \mid H_{\text {et }}^{i}\left(X_{\bar{K}}, \mathbb{Q}_{\ell}\right)\right)$ for any prime $\ell \neq p$. Hence the result follows by the Weil Conjecture (cf. [De1], $\overline{\mathrm{De} 2] \text { ). }}$

Finally, we prove Theorem 1.1 Let $A$ be an abelian variety over a $p$-adic field $K$ and let $\ell$ be any prime number. We denote by $T_{\ell}(A)$ the $\ell$-adic Tate module of $A$ and set $V_{\ell}(A):=$ $T_{\ell}(A) \otimes_{\mathbb{Z}_{\ell}} \mathbb{Q}_{\ell}$. It is well-known that we have $G_{K}$-equivalent isomorphisms $V_{\ell}(A) \simeq H_{\text {ét }}^{1}\left(A_{\bar{K}}, \mathbb{Q}_{\ell}\right)^{\vee}$ and $V_{\ell}(A) / T_{\ell}(A) \simeq A(\bar{K})\left[\ell^{\infty}\right]$. Here, $g$ is the dimension of $A$ and $A(\bar{K})\left[\ell^{\infty}\right]$ is the $\ell$-power torsion subgroup of $A(\bar{K})$. Furthermore, for an algebraic extension $L / K$, the $\ell$-power torsion subgroup $A(L)\left[\ell^{\infty}\right]$ of $A(L)$ is finite if and only if $V_{\ell}(A)^{G_{L}}=0$. Below we denote by $L$ any finite extension of $K k_{\pi}$. Assume that $A$ has potential good reduction and $N_{k / \mathbb{Q}_{p}}(\pi)$ satisfies the condition in the statement of Theorem 1.1. For the proof of Theorem 1.1] it is enough to show that both the $p$-part and the prime-to- $p$ part of $A(L)_{\text {tor }}$ are finite.

Finiteness of the $p$-part of $A(L)_{\text {tor }}$ : If we put $W=V_{p}(A)^{G_{L}}$, then it is enough to show $W=0$. Replacing $L$ by a finite extension, we may suppose that the extension $L / K$ is Galois. Then the $G_{K}$-action on $V_{p}(A)$ preserves $W$, and thus the dual representation $W^{\vee}$ of $W$ is a quotient representation of $H_{\text {êt }}^{1}\left(A_{\bar{K}}, \mathbb{Q}_{p}\right)$. By Theorem 1.2, we have $W^{\vee}=\left(W^{\vee}\right)^{G_{L}}=0$, which implies $W=0$ as desired.

Finiteness of the prime-to- $p$ part of $A(L)_{\text {tor }}$ : The finiteness of the prime-to- $p$ part of $A(L)_{\text {tor }}$ immediately follows from the following more general proposition.

Proposition 2.9. Let $X$ be a proper smooth variety over a p-adic field $K$ with potential good reduction. For any prime number $\ell \neq p$, let $V$ be a $G_{K}$-stable subquotient of $H_{\text {ett }}^{i}\left(X_{\bar{K}}, \mathbb{Q}_{\ell}(r)\right)$. Let $L / \mathbb{Q}_{p}$ be an algebraic extension with finite residue field. Assume $i \neq 2 r$.
(1) We have $V^{G_{L}}=0$ for any $\ell \neq p$.
(2) Let $T$ be a $G_{K}$-stable $\mathbb{Z}_{\ell}$-lattice of $V$. Then we have $(V / T)^{G_{L}}=0$ for almost all $\ell$.

Proof. This is essentially shown in Section 4 of KT] but we give a proof here for the sake of completeness. Replacing $K$ and $L$ by finite extensions, we may assume that $X$ has good reduction over $K$. The $G_{L}$-action on $V$ factors through $G_{\mathbb{F}_{q_{L}}}$ where $q_{L}$ is the order of the residue field of $L$. Let $\operatorname{Frob}_{L} \in G_{\mathbb{F}_{L}}$ be the geometric Frobenius. Put $P_{\ell}(T)=\operatorname{det}\left(T-\operatorname{Frob}_{L} \mid V\right)$ and $Q_{\ell}(T)=\operatorname{det}\left(T-\operatorname{Frob}_{L} \mid H_{\text {êt }}^{i}\left(X_{\bar{K}}, \mathbb{Q}_{\ell}(r)\right)\right)$. Clearly $P_{\ell}(T)$ divides $Q_{\ell}(T)$. By the Weil Conjecture, $Q_{\ell}(T)$ is independent of the choice of $\ell \neq p$, the coefficients of $Q_{\ell}(T)$ are in $\mathbb{Z}\left[1 / q_{L}\right]$ and the roots of $P(T)$ are $q_{L}$-Weil numbers of weight $i-2 r$. Since $i \neq 2 r$, we know $Q_{\ell}(1) \neq 0$ and then $P_{\ell}(1) \neq 0$. This in particular shows (1). To show (2), it suffices to show $(T / \ell T)^{G_{L}}=0$ for almost all $\ell \neq p$. Take any prime number $\ell \neq p$ which is prime to $P_{\ell}(1)$. For any root $\alpha$ of $P_{\ell}(T)$, we know that $\alpha-1$ is a rational number and is an $\ell$-adic unit. It follows from this fact that the action of $\mathrm{Frob}_{L}$ on $T / \ell T$ does not have eigenvalue one, which implies $(T / \ell T)^{G_{L}}=0$.

Therefore, we obtained the proof of Theorem 1.1
Remark 2.10. (This is pointed out by Yuichiro Taguchi.) We can construct an example which gives a negative answer to the question given in the Introduction for good reduction case. Let $E$ be an elliptic curve over $\mathbb{Q}$ with complex multiplication by the full ring of integers $\mathcal{O}_{F}$ of an imaginary quadratic field $F$. Let $\psi=\psi_{E / F}$ be the Grössencharacter associated with $E$. Let $p$ be a prime number such that $E$ has good ordinary reduction and $\mathfrak{p}$ a prime ideal of $\mathcal{O}_{F}$ above $p$. If we set $\pi:=\psi(\mathfrak{p})$, then $\pi$ is a generator of $\mathfrak{p}$ and we have $p=\pi \bar{\pi}$. Here, $\bar{\pi}$ is the complex conjugation of $\pi$. Note that $\pi$ is a $p$-Weil number of weight 1 . Let $K=k$ be the completion of $F$ at $\mathfrak{p}$. By definition, we have $K=k=\mathbb{Q}_{p}$ and $\pi$ is a uniformizer of them. If we identify a decomposition group of $G_{F}$ at $\mathfrak{p}$ with $G_{K}$, then the action of $G_{K}$ on the set of $\pi$-power torsion points of $E(\bar{K})$ is given by the Lubin-Tate character $\chi_{\pi}$ associated with $\pi$. In particular, we see that $E\left(K k_{\pi}\right)\left[p^{\infty}\right]$ is infinite.
