# Carleman estimates for a magnetohydrodynamics system and application to inverse source problems

#### Abstract

In this article, we consider a linearized magnetohydrodynamics system for incompressible flow in a three-dimensional bounded domain. We first prove two kinds of Carleman estimates. This is done by combining the Carleman estimates for the parabolic and the elliptic equations. Then we apply the Carleman estimates to prove Hölder type stability results for some inverse source problems.


## 1 Introduction

The magnetohydrodynamics equations (the MHD equations in short) are concerned with the magnetic properties of electrically conducting fluids such as plasmas, liquid metals and salt water.

Before the formulation, we introduce the following notations. Let $\Omega \subset \mathbb{R}^{3}$ be a bounded domain with smooth boundary, and let $n=n(x)$ be the outward unit normal vector to $\partial \Omega$ at $x$, and $\partial_{n} \varphi=\nabla \varphi \cdot n$. Moreover.$^{T}$ denotes the transpose of matrices or vectors, and let $\partial_{t}=\frac{\partial}{\partial t}, \partial_{j}=\frac{\partial}{\partial x_{j}}, j=1,2,3, \Delta=\sum_{j=1}^{3} \partial_{j}^{2}, \nabla=$ $\left(\partial_{1}, \partial_{2}, \partial_{3}\right)^{T}, \nabla_{x, t}=\left(\nabla, \partial_{t}\right)^{T}$. We also use the following notations:

for vectors $v=\left(v_{1}, v_{2}, v_{3}\right)^{T}, w=\left(w_{1}, w_{2}, w_{3}\right)^{T}$.
By using the divergence-free condition of the magnetic field, we simplify Maxwell's equations into a second-order parabolic equation. Then for the velocity field $u=$ $\left(u_{1}, u_{2}, u_{3}\right)^{T}$, the pressure $p$ and the magnetic field intensity $H=\left(H_{1}, H_{2}, H_{3}\right)^{T}$, the MHD equations are described as follows:

Here $\nu$ describes the viscosity of the fluids, while $\sigma$ and $\mu$ denote the electric conductivity and the magnetic permeability, respectively. We assume that they are all positive constants. For more details about the derivation of the MHD equations, we refer to Li and Qin [22] for example. Moreover, div $H=0$ is used for the proof of one of our Carleman estimates (Theorem 2.3).

There are several papers concerning the direct problems of the MHD equations. Since our main purpose of this article is the inverse problems, we do not explain more on the direct problems and we refer to Ladyzhenskaya and Solonnikov [23], as a classical work, Li [21] and the references therein.

The purpose of this article is the stability for inverse source problems, more precisely, the determination of the spatially varying factor in the source term. Our main strategy is based on a method by Bukhgeim-Klibanov [4] and Klibanov [20], applying so-called Carleman estimates.

Carleman estimate is an $L^{2}$-weighted estimate for the solution to a partial differential equation with large parameter, which is nowadays known as a powerful tool in treating the uniqueness and stability estimates for inverse problems. Actually, the Carleman estimate itself and its applications to inverse problems have been intensively studied for a variety of partial differential equations in mathematical physics including, for example,

- Transport equations: Cannarsa, Floridia and Yamamoto [6], Cannarsa, Floridia, Gölgeleyen and Yamamoto [7];
- Hyperbolic equations: Bellassoued and Yamamoto [5], Imanuvilov and Yamamoto [18];
- Parabolic equations: Imanuvilov and Yamamoto [17], Yamamoto [24];
- Lamé equation and the Navier-Stokes equations: Bellassoued, Imanuvilov and Yamamoto [2, 3], Choulli, Imanuvilov, Puel and Yamamoto [8].

To the authors' best knowledge, there are few papers on Carleman estimates for the MHD equations. For the MHD equations, Havârneanu, Popa and Sritharan $[12,13]$ proved a Carleman estimate and established the exact controllability. In their Carleman estimate, the observation of the first-order spatial derivative of the source $F$ is necessary, and so it is not suitably designed for inverse problems. Besides, Huang [10] established Carleman estimates for the MHD equations and investigate inverse coefficient problems by the measurements of velocity field, magnetic field and pressure on some sub-boundary. However, some additional data on the derivative of pressure are imposed due to the technical proof. In this article, we apply the recent idea of Huang, Imanuvilov, Yamamoto [11] and Imanuvilov, Lorenzi, Yamamoto [15] to eliminate the additional data and propose simplified proofs for the Carleman estimates as well as the stability estimates for the inverse source problems. Furthermore, under some assumptions on the source term we discuss also the inverse source problem without the knowledge of the pressure, that is, inverse source problem 2 in the following context.

Now we formulate our inverse problems and state the main results. For simplicity, we set $\kappa=\frac{1}{\sigma \mu}>0$ and we consider the following linearized MHD equations:

where the coupling operators $L_{1}, L_{2}$ are defined by

and the vector coefficients $A^{(j)}, C^{(k)}, j=1,2,3,4, k=1,2,3,4,5$ are supposed to be sufficiently smooth. Henceforth we arbitrarily fix $0<t_{0}<T, 0<\delta<$ $\min \left\{t_{0}, T-t_{0}\right\}$ and we denote

Moreover, let $H^{k}(\Omega)$, etc., denote usual Sobolev spaces (e.g., Adams and Fournier [1]). Let $\gamma_{0} \in(\mathbb{N} \cup\{0\}), \gamma=\left(\gamma_{1}, \gamma_{2}, \gamma_{3}\right) \in(\mathbb{N} \cup\{0\})^{3}$, $\partial_{x}^{\gamma}=\partial_{1}^{\gamma_{1}} \partial_{2}^{\gamma_{2}} \partial_{3}^{\gamma_{3}}$ and $|\gamma|=\gamma_{1}+\gamma_{2}+\gamma_{3}$. Then we set

for any sub-domain $D \subset Q$. If there is no confusion, we do not distinguish $L^{2}(\Omega)$ with $L^{2}\left(\Omega ; \mathbb{R}^{3}\right)$ and we use $L^{2}(\Omega)$ for both meanings.

Henceforth, depending on different cases, we consider some of the following
conditions:

We are ready to state the different conditional stability estimates under the conditions (1.3), (1.4) and (1.5)-(1.6), respectively. Our first inverse source problem can be described as follows:

## Inverse source problem 1 :

Let $F$ satisfy (1.3). For arbitrarily given sub-boundary $\Gamma \subset \partial \Omega$, and arbitrarily given sub-domain $\Omega_{0} \subset \Omega \cup \Gamma$, determine the source term $F\left(\cdot, t_{0}\right)$ in $\Omega_{0}$ by the observation data of $\left\{\left.(u, \nabla u, p, H, \nabla H)\right|_{\Gamma \times I},\left.u\left(\cdot, t_{0}\right)\right|_{\Omega},\left.p\left(\cdot, t_{0}\right)\right|_{\Omega}\right\}$.

More precisely, by introducing an admissible set of the unknown function $F$ :

with arbitrarily given constant $M>0$ and the norm of the data:

we have the following stability estimate of Hölder type for the inverse source problem.

Theorem 1.1. Assume that $F \in \mathcal{F}_{M, 1}$ and a solution to (1.1) satisfies $(u, p, H) \in$ $H^{2,2}(Q) \times H^{1,1}(Q) \times H^{2,2}(Q)$ with

Then there exist constants $C>0$ and $\theta \in(0,1)$ such that

Remark 1. In the above theorem and the following theorems in this section, the constants $C$ and $\theta$ depend on $M, \delta, \Omega$, the coefficients and also the choices of $t_{0}, \Omega_{0}$ and $\Gamma$. In particular, as one can see from the proof, the constant $C$ goes to infinity and the constant $\theta$ goes to zero as $t_{0}$ goes to zero, or $\Omega_{0}$ tends to $\Omega$, or $\Gamma$ tends to an empty set. However, we mention that the arbitrary choice of $\Omega_{0}$ enables us to prove the corresponding uniqueness results of determining $F\left(\cdot, t_{0}\right)$ in $\Omega$ immediately by contradiction.
Remark 2. According to the condition (1.3), one can readily see that Theorem 1.1
also implies the estimate of the source term in $\Omega_{0} \times I$ as follows:

In Theorem 1.1, the data on the pressure $p$ is needed. However, sometimes it is not easy to measure the pressure. Thus, we discuss also the second inverse source problem as follows:

## Inverse source problem 2:

Let $F$ satisfy (1.5) and (1.6). For arbitrarily given sub-boundary $\Gamma \subset \partial \Omega$, and arbitrarily given sub-domain $\Omega_{0} \subset \Omega \cup \Gamma$, determine the source term $F\left(\cdot, t_{0}\right)$ in $\Omega_{0}$ by the observation data of $\left\{\left.(u, \nabla u, \nabla \operatorname{rot} u, H, \nabla H, \nabla \operatorname{rot} H)\right|_{\Gamma \times I},\left.u\left(\cdot, t_{0}\right)\right|_{\Omega},\left.H\left(\cdot, t_{0}\right)\right|_{\Omega}\right\}$.

By introducing the admissible set:

with arbitrarily given constant $M>0$ and the norm of the data:

we have the following stability estimate.
Theorem 1.2. Assume that $F \in \mathcal{F}_{M, 2}$ and $(u, p, H) \in H^{2,3}(Q) \times H^{2,2}(Q) \times H^{2,3}(Q)$ is a solution to (1.1) satisfying $\operatorname{rot} u$, $\operatorname{rot} H \in H^{2,3}(Q)$ and

Then there exist constants $C>0$ and $\theta \in(0,1)$ such that

Remark 3. In Theorem 1.2, we can actually determine additionally the source term in the second equation of (1.1) at the same time. That is, let the second equation be substituted by

Then under suitable assumptions on $F$ and $G$, we can prove the stability estimate:

$$

Remark 4. In contrast to Theorem 1.1, here we need not any data of $p$ since we assume the condition (1.6). Thus, Theorem 1.2 indicates that one can recover a transverse field source, that is, a source whose divergence is zero, even if we do not measure the pressure $p$. Indeed, according to the Helmholtz decomposition:

with a real-valued function $\widetilde{p}$ and an $\mathbb{R}^{3}$-valued function $\widetilde{F}$ satisfying $\operatorname{div} \widetilde{F}=0$, we can rewrite the first equation in (1.1) by

Therefore, there are no hopes of determining the longitudinal field component $\nabla \widetilde{p}$ as long as we do not have the knowledge of $\nabla p$ and we can determine at most the information of the transverse field component $\widetilde{F}$.

As we see from the above remark, we can identify only the transverse field component of the source provided that the pressure $p$ is not measured. In the next theorem, we consider the case that $F$ is not necessarily a transverse field, that is, we do not assume the condition (1.6), and we determine the information of the transverse field component of the source.

Note that the decomposition (1.7) is not unique. For example, we could replace $\nabla \widetilde{p}$ by $\nabla(\widetilde{p}-q)$ and $\widetilde{F}$ by $\widetilde{F}+\nabla q$ for any $q$ satisfying $\Delta q=0$. Thus, it is not a suitable problem to recover $\widetilde{F}$ itself. Instead, we show the next theorem identifying $\operatorname{rot} \widetilde{F}=\operatorname{rot} F$ within the following admissible set:

Theorem 1.3. Assume that $F \in \mathcal{F}_{M, 3}$ and $(u, p, H) \in H^{2,2}(Q) \times H^{2,1}(Q) \times H^{2,2}(Q)$ is a solution to (1.1) satisfying $\operatorname{rot} u$, $\operatorname{rot} H \in H^{2,2}(Q)$ and

Then there exist constants $C>0$ and $\theta \in(0,1)$ such that

$$

Remark 5. Since the unknown source $F$ appears only in the first equation of (1.1),
we can take advantage of the coupling between $u$ and $H$, and we manage to remove the measurement of $H\left(\cdot, t_{0}\right)$ in the data.
Remark 6. Under some suitable boundary conditions on $\widetilde{F}\left(\cdot, t_{0}\right)$ (see e.g., [25]), the decomposition (1.7) at $t=t_{0}$ can be uniquely determined. Hence one can recover the transverse field component $\widetilde{F}\left(\cdot, t_{0}\right)$ in $\Omega_{0}$ by using $\operatorname{rot} \widetilde{F}\left(\cdot, t_{0}\right)=\operatorname{rot} F\left(\cdot, t_{0}\right)$ in $\Omega_{0}$.

We end up this section with two examples which justify the conditions (1.4) and (1.5).

Example 1. We assume that the temporal varying factor of the force $F$ is independent of the position $x$, that is, we let

where $r \in C^{2}[0, T]$ is a given real-valued function and $f=\left(f_{1}, f_{2}, f_{3}\right)^{T}, f_{j} \in C^{1}(\bar{\Omega})$, $j=1,2,3$. Then (1.4) and (1.5) can be justified as long as

Actually, we have

for all $(x, t) \in Q$ and $k=0,1,2$, which implies (1.4). By noting that

$$
\left|\operatorname{rot} F\left(x, t_{0}\right)\right| \leq C\left|\nabla F\left(x, t_{0}\right)\right|, \quad x \in \Omega,
$$

we immediately find (1.5). Moreover, (1.6) holds true if we further assume $\operatorname{div} f=0$. Example 2. We consider a more general case that the temporal varying factor of the force depends also on the position $x$, which can be modeled by a matrix $R(x, t)$ :

$$
F(x, t)=R(x, t) f(x), \quad x \in \Omega, 0<t<T
$$

where $R=\left(r_{i j}\right)_{1 \leq i, j \leq 3}$ is a given matrix-valued function and $f=\left(f_{1}, f_{2}, f_{3}\right)^{T}$ is a vector-valued function. Here we assume that each entry $r_{i j}$ and each component $f_{j}$ are smooth enough, for example, $r_{i j} \in C^{2}\left([0, T] ; C^{1}(\bar{\Omega})\right)$ for $i, j=1,2,3$ and $f_{j} \in C^{1}(\bar{\Omega})$ for $j=1,2,3$. Then (1.5) is satisfied if

$$
\left|\operatorname{det} R\left(x, t_{0}\right)\right|>0, \quad x \in \bar{\Omega}
$$

In fact, by direct calculations, we have

$$
\begin{equation*}
\left|\partial_{t}^{k} \operatorname{rot} F(x, t)\right| \leq C(|\nabla f(x)|+|f(x)|), \quad(x, t) \in Q, k=0,1,2 \tag{1.8}
\end{equation*}
$$

On the other hand, we have

$$
\partial_{\ell} F(x, t)=\partial_{\ell} R(x, t) f(x)+R(x, t) \partial_{\ell} f(x), \quad(x, t) \in Q, \ell=1,2,3
$$

Since $\left|\operatorname{det} R\left(\cdot, t_{0}\right)\right|>0$ on $\bar{\Omega}$, we find that $R\left(\cdot, t_{0}\right)$ is invertible and the norm of its inverse $R^{-1}\left(\cdot, t_{0}\right)$ is bounded from above. Thus, we rewrite the above equality at $t=t_{0}$ to obtain

$$
\partial_{\ell} f(x)=R^{-1}\left(x, t_{0}\right) \partial_{\ell} F\left(x, t_{0}\right)-R^{-1}\left(x, t_{0}\right) \partial_{\ell} R\left(x, t_{0}\right) f(x), \quad x \in \Omega, \ell=1,2,3,
$$

which implies

$$
\begin{equation*}
\left|\partial_{\ell} f(x)\right| \leq C\left(\left|\partial_{\ell} F\left(x, t_{0}\right)\right|+|f(x)|\right), \quad x \in \Omega, \quad \ell=1,2,3 . \tag{1.9}
\end{equation*}
$$

Therefore, we obtain (1.5) by combining (1.8) and (1.9) with the following inequality

$$
|f(x)|=\left|R^{-1}\left(x, t_{0}\right) F\left(x, t_{0}\right)\right| \leq C\left|F\left(x, t_{0}\right)\right|, \quad x \in \Omega
$$

We remark that in Example 2, we do not know a convenient sufficient condition for (1.4) in terms of $R$ and $f$.

The rest of this article is organized as follows. In Section 2, we show the key Carleman estimates which are stated in Theorems 2.1 and 2.3. In Section 3, we prove Theorems 1.1-1.3 on the basis of these Carleman estimates.

## 2 Key Carleman estimates

In this section, we consider the following linearized MHD system

$$
\begin{cases}\partial_{t} u-\nu \Delta u+\left(A^{(1)} \cdot \nabla\right) u+(u \cdot \nabla) A^{(2)}+L_{1} H+\nabla p=F & \text { in } Q  \tag{2.1}\\ \partial_{t} H-\kappa \Delta H+\left(A^{(3)} \cdot \nabla\right) H+(H \cdot \nabla) A^{(4)}+L_{2} u=G & \text { in } Q \\ \operatorname{div} u=h & \text { in } Q\end{cases}
$$

Here $L_{1}, L_{2}$ are defined in (1.2) and the vector coefficients $A^{(j)}, C^{(k)}, j=1,2,3,4$, $k=1,2,3,4,5$ are smooth enough (e.g., $\left.W^{3, \infty}(Q)\right)$.

The purpose of this section is to establish suitable Carleman estimates for (2.1), which are the key points in proving our stability results of Theorems 1.1-1.3. To this end, we first introduce the weight function for our Carleman estimates.

Let $\Gamma \subset \partial \Omega$ be an arbitrarily fixed non-empty relatively open sub-boundary. We choose a bounded domain $\widetilde{\Omega} \subset \mathbb{R}^{3} \backslash \bar{\Omega}$ such that $\partial \widetilde{\Omega} \cap \partial \Omega=\bar{\Gamma}$. We construct a domain $\Omega_{1} \supset \Omega$ by setting

$$
\Omega_{1}=\Omega \cup \widetilde{\Omega} \cup \Gamma .
$$

Then

$$
\bar{\Gamma}=\partial \Omega \cap \overline{\Omega_{1}}, \quad \partial \Omega_{1}=(\partial \Omega \backslash \Gamma) \cup(\partial \widetilde{\Omega} \backslash \Gamma)
$$

With this new domain $\Omega_{1}$, we can choose a non-empty domain $\omega \subset \Omega_{1}$ such that $\bar{\omega} \subset \Omega_{1} \backslash \bar{\Omega}=\widetilde{\Omega}$. Thus, referring to e.g., Fursikov and Imanuvilov [9] or Imanuvilov [14], we can construct a function $d \in C^{2}\left(\overline{\Omega_{1}}\right)$ such that

$$
\begin{equation*}
d=0 \quad \text { on } \partial \Omega_{1}, \quad d>0 \quad \text { in } \Omega_{1}, \quad|\nabla d|>0 \quad \text { on } \overline{\Omega_{1} \backslash \omega} . \tag{2.2}
\end{equation*}
$$

In particular, $d>0$ in $\Omega$ and $|\nabla d|>0$ on $\bar{\Omega}$. For arbitrarily given $0<t_{0}<T$ and $0<\delta<\min \left\{t_{0}, T-t_{0}\right\}$, we denote

$$
I:=\left(t_{0}-\delta, t_{0}+\delta\right), \quad Q:=\Omega \times I, \quad Q_{1}:=\Omega_{1} \times I
$$

Moreover, we fix a large constant $\lambda>0$, and for a constant $\beta>0$ we set

$$
\begin{equation*}
\psi(x, t)=d(x)-\beta\left(t-t_{0}\right)^{2}, \quad \varphi(x, t)=e^{\lambda \psi(x, t)}, \quad(x, t) \in \overline{Q_{1}} . \tag{2.3}
\end{equation*}
$$

Now we establish our Carleman estimates in the following two cases.

### 2.1 Carleman estimate with pressure term $p$

Here we state the first Carleman estimate in which we include the estimate of $p$.
Theorem 2.1. Let $F \in L^{2}(Q)$. Then there exist constants $s_{0}>0$ and $C>0$ such that

$$
\begin{aligned}
& \int_{Q}\left(\frac{1}{s^{2}}\left(\left|\partial_{t} u\right|^{2}+|\Delta u|^{2}\right)+\frac{1}{s}\left(\left|\partial_{t} H\right|^{2}+|\Delta H|^{2}\right)+|\nabla u|^{2}+s|\nabla H|^{2}\right. \\
& \left.+s^{2}|u|^{2}+s^{3}|H|^{2}+\frac{1}{s}|\nabla p|^{2}+s|p|^{2}\right) e^{2 s \varphi} d x d t \\
\leq & C \int_{Q}\left(|F|^{2}+|G|^{2}+\left|\nabla_{x, t} h\right|^{2}\right) e^{2 s \varphi} d x d t \\
& +C s^{3} \int_{\partial \Omega \times I}\left(|u|^{2}+|H|^{2}+\left|\nabla_{x, t} u\right|^{2}+\left|\nabla_{x, t} H\right|^{2}\right) e^{2 s \varphi} d S d t \\
& +\left.C s^{3} \int_{\Omega}\left(|u|^{2}+|H|^{2}+|\nabla u|^{2}+|\nabla H|^{2}\right) e^{2 s \varphi} d x\right|_{t=t_{0} \pm \delta}
\end{aligned}
$$

for all $s \geq s_{0}$ and

$$
u, H \in H^{1}\left(I ; H^{1}(\Omega)\right) \cap L^{2}\left(I ; H^{2}(\Omega)\right), \quad p \in L^{2}\left(I ; H_{0}^{1}(\Omega)\right)
$$

satisfying (2.1).
Henceforth $C>0$ denotes a generic constant which depends on $\lambda, t_{0}, \delta, T, \beta, \Omega$ and the coefficients, but is independent of the parameter $s$. Such uniformity in $s$ is used for deriving the stability results for the inverse problems.

Proof of Theorem 2.1. We divide the proof into three steps.

## First step:

At the beginning of the proof, we assume that $p \in L^{2}\left(I ; C_{0}^{\infty}(\Omega)\right)$. Later in the third step, we will take approximations and treat the case of $p \in L^{2}\left(I ; H_{0}^{1}(\Omega)\right)$. In the first step, we prove the following lemma.

Lemma 2.2. Let $p \in L^{2}\left(I ; C_{0}^{\infty}(\Omega)\right)$ satisfy

$$
\begin{equation*}
\Delta p=f_{0}+\sum_{j=1}^{3} \partial_{j} f_{j} \quad \text { in } Q \tag{2.4}
\end{equation*}
$$

Then there exist constants $\hat{s}>0$ and $C>0$ such that

$$
\int_{Q}\left(|\nabla p|^{2}+s^{2}|p|^{2}\right) e^{2 s \varphi} d x d t \leq C \int_{Q}\left(\frac{1}{s}\left|f_{0}\right|^{2}+s \sum_{j=1}^{3}\left|f_{j}\right|^{2}\right) e^{2 s \varphi} d x d t
$$

for all $s \geq \hat{s}$.
Proof. By noting that $p \in L^{2}\left(I ; C_{0}^{\infty}(\Omega)\right)$, we can take the zero extension of $p$ from $\Omega$ to $\Omega_{1}$, which is denoted by the same letter. Then we find that $p(\cdot, t) \in C_{0}^{\infty}\left(\Omega_{1}\right)$ for $t \in I$ and (2.4) holds true in $Q_{1}$ as long as we take also the zero extensions of $f_{j}, j=0,1,2,3$.

Now we apply the $H^{-1}$ Carleman estimate for the elliptic equation (Theorem A. 1 in Imanuvilov and Puel [16]) to (2.4) in $\Omega_{1}$ and we obtain

$$
\begin{aligned}
& \int_{\Omega_{1}}\left(|\nabla p(x, t)|^{2}+s^{2}|p(x, t)|^{2}\right) e^{2 s e^{\lambda d(x)}} d x \\
\leq & C \int_{\Omega_{1}}\left(\frac{1}{s}\left|f_{0}(x, t)\right|^{2}+s \sum_{j=1}^{3}\left|f_{j}(x, t)\right|^{2}\right) e^{2 s e^{\lambda d(x)}} d x+C \int_{\omega} s^{2}|p(x, t)|^{2} e^{2 s e^{\lambda d(x)}} d x
\end{aligned}
$$

for all $s \geq s_{1}, t \in I$ and $\bar{\omega} \subset \Omega_{1}$. Recalling the construction of the domain $\Omega_{1}$, we can choose a non-empty domain $\omega$ such that $\bar{\omega} \subset \Omega_{1} \backslash \bar{\Omega}$. Since we take the zero extensions for $f_{j}, p$ outside of $\Omega$, the integral over $\omega$ vanishes and we have

$$
\begin{align*}
& \int_{\Omega}\left(|\nabla p(x, t)|^{2}+s^{2}|p(x, t)|^{2}\right) e^{2 s e^{\lambda d(x)}} d x \\
\leq & C \int_{\Omega}\left(\frac{1}{s}\left|f_{0}(x, t)\right|^{2}+s \sum_{j=1}^{3}\left|f_{j}(x, t)\right|^{2}\right) e^{2 s e^{\lambda d(x)}} d x \tag{2.5}
\end{align*}
$$

for all $s \geq s_{1}$ and each $t \in I$. Let $\hat{s}:=s_{1} e^{\lambda \beta \delta^{2}}$. Then $s \geq \hat{s}$ implies

$$
s e^{-\lambda \beta\left(t-t_{0}\right)^{2}} \geq s e^{-\lambda \beta \delta^{2}} \geq \hat{s} e^{-\lambda \beta \delta^{2}}=s_{1}
$$

for $t \in I$, and thus, replacing $s$ by $s e^{-\lambda \beta\left(t-t_{0}\right)^{2}}$ in (2.5) yields

$$
\begin{aligned}
& \int_{\Omega}\left(|\nabla p(x, t)|^{2}+s^{2} e^{-2 \lambda \beta\left(t-t_{0}\right)^{2}}|p(x, t)|^{2}\right) e^{2 s \varphi(x, t)} d x \\
\leq & C \int_{\Omega}\left(\frac{1}{s} e^{\lambda \beta\left(t-t_{0}\right)^{2}}\left|f_{0}(x, t)\right|^{2}+s e^{-\lambda \beta\left(t-t_{0}\right)^{2}} \sum_{j=1}^{3}\left|f_{j}(x, t)\right|^{2}\right) e^{2 s \varphi(x, t)} d x
\end{aligned}
$$

for all $s \geq \hat{s}$ and each $t \in I$. Here we used $\varphi(x, t)=e^{\lambda d(x)} e^{-\lambda \beta\left(t-t_{0}\right)^{2}},(x, t) \in Q$. Therefore, we complete the proof of Lemma 2.2 by integrating the above estimate over $t \in I$.

## Second step:

In this step, we apply the estimate in the first step and the Carleman estimate for parabolic system to prove the theorem in the case where $p \in L^{2}\left(I ; C_{0}^{\infty}(\Omega)\right)$.

We derive the following elliptic equation with respect to $p$ by taking the divergence on both sides of the first equation in (2.1) and using the third equation there:

$$
\begin{equation*}
\Delta p=\operatorname{div} F-\partial_{t} h+\nu \operatorname{div}(\nabla h)-\operatorname{div}\left(\left(A^{(1)} \cdot \nabla\right) u\right)-\operatorname{div}\left((u \cdot \nabla) A^{(2)}\right)-\operatorname{div}\left(L_{1} H\right) . \tag{2.6}
\end{equation*}
$$

In particular, we rewrite several terms on the right-hand side as follows

$$
\begin{aligned}
& \nu \operatorname{div}(\nabla h)=\nu \sum_{j=1}^{3} \partial_{j}\left(\partial_{j} h\right), \\
& \begin{aligned}
\operatorname{div}\left(\left(A^{(1)} \cdot \nabla\right) u\right) & =\sum_{j, k=1}^{3} \partial_{k}\left(A_{j}^{(1)} \partial_{j} u_{k}\right)=\sum_{j=1}^{3} A_{j}^{(1)} \partial_{j}\left(\sum_{k=1}^{3} \partial_{k} u_{k}\right)+\sum_{j, k=1}^{3}\left(\partial_{k} A_{j}^{(1)}\right) \partial_{j} u_{k} \\
& =A^{(1)} \cdot \nabla(\operatorname{div} u)+\sum_{j, k=1}^{3}\left(\partial_{j}\left(\left(\partial_{k} A_{j}^{(1)}\right) u_{k}\right)-\left(\partial_{j} \partial_{k} A_{j}^{(1)}\right) u_{k}\right)
\end{aligned} \\
& \operatorname{div}\left((u \cdot \nabla) A^{(2)}\right)+\operatorname{div}\left(L_{1} H\right)=\sum_{j=1}^{3} \partial_{j}\left((u \cdot \nabla) A_{j}^{(2)}+\left[L_{1} H\right]_{j}\right)
\end{aligned}
$$

where $[v]_{j}$ denotes the $j$-th component of a vector $v, j=1,2,3$. Besides, we have

$$
\operatorname{div} F=\sum_{j=1}^{3} \partial_{j} F_{j}
$$

Therefore, we are able to represent the right-hand side of (2.6) in the form of $f_{0}+\sum_{j=1}^{3} \partial_{j} f_{j}$ with

$$
f_{0}=-\partial_{t} h-\left(A^{(1)} \cdot \nabla\right) h+\sum_{k, \ell=1}^{3}\left(\partial_{\ell} \partial_{k} A_{\ell}^{(1)}\right) u_{k}
$$

$$
f_{j}=F_{j}+\nu \partial_{j} h-\sum_{k=1}^{3}\left(\partial_{k} A_{j}^{(1)}\right) u_{k}-(u \cdot \nabla) A_{j}^{(2)}-\left[L_{1} H\right]_{j}, \quad j=1,2,3
$$

Thus, by noting

$$
\begin{aligned}
& \left|f_{0}\right| \leq C\left(\left|\partial_{t} h\right|+|\nabla h|+|u|\right), \\
& \left|f_{j}\right| \leq C(|F|+|\nabla h|+|u|+|H|+|\nabla H|), \quad j=1,2,3
\end{aligned}
$$

we apply Lemma 2.2 to obtain

$$
\begin{align*}
\int_{Q}\left(\frac{1}{s}|\nabla p|^{2}+s|p|^{2}\right) e^{2 s \varphi} d x d t \leq & C \int_{Q}\left(|F|^{2}+\left|\nabla_{x, t} h\right|^{2}\right) e^{2 s \varphi} d x d t \\
& +C \int_{Q}\left(|u|^{2}+|H|^{2}+|\nabla H|^{2}\right) e^{2 s \varphi} d x d t \tag{2.7}
\end{align*}
$$

for all $s \geq s_{2}:=\max \{1, \hat{s}\}$.
On the other hand, we can regard $\nabla p$ in the first equation of (2.1) as a nonhomogeneous term, and then the first and second equations of (2.1) become a weakly coupling parabolic system with respect to $u$ and $H$. Hence we can apply the Carleman estimate for the parabolic system (e.g., Yamamoto [24, Theorem 3.2]) and we obtain

\begin{align*}
& \int_{Q}\left(\frac{1}{s^{2}}\left(\left|\partial_{t} u\right|^{2}+|\Delta u|^{2}\right)+|\nabla u|^{2}+s^{2}|u|^{2}\right) e^{2 s \varphi} d x d t \\
\leq & C \int_{Q} \frac{1}{s}|F|^{2} e^{2 s \varphi} d x d t+C \int_{Q} \frac{1}{s}\left(|\nabla p|^{2}+|\nabla H|^{2}+|H|^{2}\right) e^{2 s \varphi} d x d t \\
& +C s^{2} \int_{\partial \Omega \times I}\left(\left|\nabla_{x, t} u\right|^{2}+|u|^{2}\right) e^{2 s \varphi} d S d t+\left.C s^{2} \int_{\Omega}\left(|\nabla u|^{2}+|u|^{2}\right) e^{2 s \varphi} d x\right|_{t=t_{0} \pm \delta} \tag{2.8}
\end{align*}
$$

and

$$
\begin{align*}
& \int_{Q}\left(\frac{1}{s}\left(\left|\partial_{t} H\right|^{2}+|\Delta H|^{2}\right)+s|\nabla H|^{2}+s^{3}|H|^{2}\right) e^{2 s \varphi} d x d t \\
\leq & C \int_{Q}|G|^{2} e^{2 s \varphi} d x d t+C \int_{Q}\left(|\nabla u|^{2}+|u|^{2}\right) e^{2 s \varphi} d x d t \\
& +C s^{3} \int_{\partial \Omega \times I}\left(\left|\nabla_{x, t} H\right|^{2}+|H|^{2}\right) e^{2 s \varphi} d S d t+\left.C s^{3} \int_{\Omega}\left(|\nabla H|^{2}+|H|^{2}\right) e^{2 s \varphi} d x\right|_{t=t_{0} \pm \delta} \tag{2.9}
\end{align*}
$$

for all $s \geq s_{3}$. Substituting (2.9) into the last term on the right-hand side of (2.7) and then substituting the derived inequality into the second term on the right-hand side of (2.8), we obtain

$$
\int_{Q}\left(\frac{1}{s^{2}}\left(\left|\partial_{t} u\right|^{2}+|\Delta u|^{2}\right)+|\nabla u|^{2}+s^{2}|u|^{2}\right) e^{2 s \varphi} d x d t
$$

$$
\begin{align*}
\leq & C \int_{Q}\left(|F|^{2}+\frac{1}{s}|G|^{2}+\left|\nabla_{x, t} h\right|^{2}\right) e^{2 s \varphi} d x d t \\
& +C \int_{Q}\left(\frac{1}{s}|\nabla u|^{2}+|u|^{2}+\frac{1}{s}|\nabla H|^{2}+\frac{1}{s}|H|^{2}\right) e^{2 s \varphi} d x d t \\
& +C s^{2} \int_{\partial \Omega \times I}\left(\left|\nabla_{x, t} u\right|^{2}+|u|^{2}+\left|\nabla_{x, t} H\right|^{2}+|H|^{2}\right) e^{2 s \varphi} d S d t \\
& +\left.C s^{2} \int_{\Omega}\left(|\nabla u|^{2}+|u|^{2}+|\nabla H|^{2}+|H|^{2}\right) e^{2 s \varphi} d x\right|_{t=t_{0} \pm \delta} \tag{2.10}
\end{align*}
$$

for all $s \geq s_{4}:=\max \left\{s_{2}, s_{3}\right\}$. Therefore, we combine the inequalities (2.7), (2.9) and (2.10), by choosing $s>0$ sufficiently large, we can absorb the lower-order terms $\int_{Q}\left(|\nabla u|^{2}+s|u|^{2}+|\nabla H|^{2}+|H|^{2}\right) e^{2 s \varphi} d x d t$ into the left-hand side and this completes the proof in the case of $p \in L^{2}\left(I ; C_{0}^{\infty}(\Omega)\right)$.

## Third step:

In this step, we consider the case of $p \in L^{2}\left(I ; H_{0}^{1}(\Omega)\right)$ by a density argument. Recall the density $\overline{C_{0}^{\infty}(\Omega)}=H_{0}^{1}(\Omega)$ by the norm of $H^{1}(\Omega)$ (e.g., Adams and Fournier[1]). This yields the existence of an approximating sequence $p_{n} \in$ $L^{2}\left(I ; C_{0}^{\infty}(\Omega)\right), n \in \mathbb{N}$ such that

$$
\begin{equation*}
\lim _{n \rightarrow \infty}\left\|p_{n}-p\right\|_{L^{2}\left(I ; H^{1}(\Omega)\right)}=0 \tag{2.11}
\end{equation*}
$$

Then we rewrite the first equation of (2.1) in terms of $p_{n}$ :

$$
\partial_{t} u-\nu \Delta u+(A \cdot \nabla) u+(u \cdot \nabla) B+L_{1} H+\nabla p_{n}=F+\nabla\left(p_{n}-p\right)
$$

Therefore, by applying the Carleman estimate in the above steps, we have

$$
\begin{aligned}
& \int_{Q}\left(\frac{1}{s^{2}}\left(\left|\partial_{t} u\right|^{2}+|\Delta u|^{2}\right)+\frac{1}{s}\left(\left|\partial_{t} H\right|^{2}+|\Delta H|^{2}\right)+|\nabla u|^{2}+s|\nabla H|^{2}\right. \\
& \left.+s^{2}|u|^{2}+s^{3}|H|^{2}+\frac{1}{s}|\nabla p|^{2}+s|p|^{2}\right) e^{2 s \varphi} d x d t \\
\leq & C \int_{Q}\left(\left|F+\nabla\left(p_{n}-p\right)\right|^{2}+|G|^{2}+\left|\nabla_{x, t} h\right|\right) e^{2 s \varphi} d x d t \\
& +C s^{3} \int_{\partial \Omega \times I}\left(|u|^{2}+|H|^{2}+\left|\nabla_{x, t} u\right|^{2}+\left|\nabla_{x, t} H\right|^{2}\right) e^{2 s \varphi} d S d t \\
& +\left.C s^{3} \int_{\Omega}\left(|u|^{2}+|H|^{2}+|\nabla u|^{2}+|\nabla H|^{2}\right) e^{2 s \varphi} d x\right|_{t=t_{0} \pm \delta}
\end{aligned}
$$

for all $s \geq s_{0}$. Since

$$
\left|F+\nabla\left(p_{n}-p\right)\right|^{2} \leq C\left(|F|^{2}+\left|\nabla\left(p_{n}-p\right)\right|^{2}\right)
$$

by letting $n \rightarrow \infty$ and using (2.11), we complete the proof of Theorem 2.1.

### 2.2 Carleman estimate without pressure term $p$

In this subsection, we propose another Carleman estimate for the linearized MHD system (2.1) in which we do not estimate $p$. Such estimate is useful in proving the stability results without the information of the pressure.

Although we can argue with less regularity which is similar to the previous subsection, here we assume higher regularity for the non-homogeneous term and the coefficients in order to clarify the essential idea.

Recall that $\Gamma \subset \partial \Omega$ is an arbitrarily given non-empty relatively open subboundary, the functions $d$ and $\varphi$ are given by (2.2) and (2.3) respectively. Now we state the second Carleman estimate.

Theorem 2.3. Let $h=0, F, G \in L^{2}(Q)$ and $\operatorname{rot} F, \operatorname{rot} G \in L^{2}(Q)$. Then there exist constants $C>0$ and $\widehat{s_{0}}>0$ such that

Proof of Theorem 2.3. The key to the proof is the reduction of (2.1) to a parabolicelliptic system. Then we can apply standard Carleman estimates for parabolic equations and elliptic equations to establish our desired Carleman estimate.

To start with, we denote $y:=\operatorname{rot} u, z:=\operatorname{rot} H$. By noting

The proof is based on the standard elliptic Carleman estimate which is wellknown. For example, it can be directly proved by following similar steps as the proof of [24, Theorem 3.1], and keeping the boundary integrals.

By applying Lemma 2.4 to the third and the fourth equations of (2.12) and multiplying both sides by $s$, we have

we sum up the estimates (2.13)-(2.16) and insert (2.13)-(2.14) into the right-hand side, and then we can find a sufficiently large constant $\widehat{s_{0}} \geq \max \left\{\widehat{s_{1}}, \widehat{s_{2}}\right\}$ such that we absorb the term $C \int_{Q}\left(|\nabla u|^{2}+|u|^{2}+|\nabla H|^{2}+|H|^{2}+|\nabla y|^{2}+|\nabla z|^{2}\right) e^{2 s \varphi} d x d t$ on the right-hand side into the left-hand side. This completes the proof of Theorem 2.3.

## 3 Proofs of Theorems 1.1-1.3

### 3.1 Proof of Theorem 1.1

We divide the proof into four steps.

## First step: Choice of a suitable cut-off function $\chi$

In Theorem 1.1, we do not have $p=0$ on $\partial \Omega$, which prevents us from applying the Carleman estimate (Theorem 2.1) established in the former section directly. Thus, here we need a cut-off argument.

Recall that $d=d(x)$ satisfies (2.2). Since $d(x)>0$ for $x \in \Omega_{0} \subset \Omega_{1}$, we can choose constants $0<\varepsilon_{1}<\varepsilon_{2}<\varepsilon_{3}$ such that $\Omega_{0} \subset\left\{x \in \Omega ; d(x)>\varepsilon_{3}\right\}$.

We choose a cut-off function as follows: $\chi \in C^{\infty}\left(\mathbb{R}^{3}\right)$ satisfying $0 \leq \chi \leq 1$ and

On the other hand, by the Sobolev extension theorem, we can find $p_{0} \in H^{1}\left(I ; H^{1}(\Omega)\right)$ such that

Here $J_{1}, J_{2}$ include the terms of $p, p_{0}$ and at most first spatial derivatives of $u, H$ multiplied by the derivatives of the cut-off function $\chi$, in other words, we have

Here $J_{3}, J_{4}$ include the terms of $p, p_{0}, \partial_{t} p, \partial_{t} p_{0}$ and at most first spatial derivatives
of $u, H, \partial_{t} u, \partial_{t} H$ multiplied by the derivatives of the cut-off function $\chi$, in other words, we have

By denoting $\mu_{2}:=e^{\lambda\left(\|d\|_{C(\bar{\Omega})}-\beta \delta^{2}\right)}$, we estimate

### 3.2 Proof of Theorem 1.2

With the additional regularity assumptions on the unknown and the measurements, we can employ Theorem 2.3 and derive the stability result without the measurements on the pressure $p$.

## First step: A preliminary estimate

We start the proof with a weighted estimate. In order to erase the effect of the pressure $p$, we need to apply the rotation operator to both sides of the first equation of (1.1). Actually by using the equalities $\operatorname{rot}(\operatorname{rot} u)=-\Delta u+\nabla(\operatorname{div} u)$, $\operatorname{rot}(\operatorname{rot} F)=-\Delta F+\nabla(\operatorname{div} F)$ and $\operatorname{rot}(\nabla p)=0$, we take the rotation operator twice on both sides of the first equation of (1.1). In particular, we fix $t=t_{0}$ and then by (1.6) we obtain

This enables us to end up with a stability of Hölder type by minimizing the right-hand side of (3.32) with respect to $s$.

### 3.3 Proof of Theorem 1.3

Thanks to the assumption (1.4), we need only apply the rotation operator once to the governing equation (1.1). Actually we can simply follow the steps of the former subsection.

## First step: A preliminary estimate

Again we start the proof with a weighted estimate. In order to erase the effect of the pressure $p$, we apply the rotation operator to both sides of the first equation of (1.1). In particular, by setting $v=\operatorname{rot} u$ and taking $t=t_{0}$, we obtain

& +C \int_{Q}\left(s^{4}\left|\partial_{t} H\right|^{2}+s^{4}|H|^{2}\right) e^{2 s \varphi} d x d t+C \int_{Q}\left(s^{2}\left|\nabla\left(\partial_{t} H\right)\right|^{2}+s^{2}|\nabla H|^{2}\right) e^{2 s \varphi} d x d t \\
& +C e^{2 s \mu_{1}} M^{2}+C e^{C s} E_{5}^{2} . \tag{3.35}
\end{align*}
$$

## Second step: Application of the Carleman estimate

For simplicity of the expressions, we introduce the following notations:

$$
u^{(1)}=\partial_{t} u, H^{(1)}=\partial_{t} H, p^{(1)}=\partial_{t} p .
$$

Recall that we take the time derivative of the governing system (1.1) and obtain

$$
\left\{\begin{array}{l}
\partial_{t} u^{(1)}-\nu \Delta u^{(1)}+\left(A^{(1)} \cdot \nabla\right) u^{(1)}+\left(u^{(1)} \cdot \nabla\right) A^{(2)}+L_{1} H^{(1)}+\nabla p^{(1)}=\partial_{t} F+J_{1}  \tag{3.36}\\
\partial_{t} H^{(1)}-\kappa \Delta H^{(1)}+\left(A^{(3)} \cdot \nabla\right) H^{(1)}+\left(H^{(1)} \cdot \nabla\right) A^{(4)}+L_{2} u^{(1)}=J_{2} \\
\operatorname{div} u^{(1)}=0
\end{array}\right.
$$

where $J_{1}, J_{2}$ satisfy

$$
\left|\operatorname{rot} J_{k}\right| \leq C(|u|+|\nabla u|+|\nabla \operatorname{rot} u|+|H|+|\nabla H|+|\nabla \operatorname{rot} H|), \quad k=1,2 .
$$

We employ Theorem 2.3 to (1.1) and by the same argument in deriving (3.24), we obtain

$$
\begin{align*}
& \int_{Q}\left(s|\nabla \operatorname{rot} u|^{2}+s|\nabla \operatorname{rot} H|^{2}+s^{2}|\nabla u|^{2}+s^{2}|\nabla H|^{2}+s^{4}|u|^{2}+s^{4}|H|^{2}\right) e^{2 s \varphi} d x d t \\
& \leq C \int_{Q}|\operatorname{rot} F|^{2} e^{2 s \varphi} d x d t+C s^{4} e^{C s} E_{6}^{2}+C s^{4} e^{2 s \mu_{1}} M^{2} \tag{3.37}
\end{align*}
$$

for all sufficiently large $s \geq 1$. Here

$$
\begin{aligned}
E_{6}:= & \|\nabla \operatorname{rot} u\|_{H^{1}\left(I ; L^{2}(\Gamma)\right)}+\|\nabla \operatorname{rot} H\|_{H^{1}\left(I ; L^{2}(\Gamma)\right)}+\|\nabla u\|_{H^{2}\left(I ; L^{2}(\Gamma)\right)} \\
& +\|\nabla H\|_{H^{2}\left(I ; L^{2}(\Gamma)\right)}+\|u\|_{H^{1}\left(I ; L^{2}(\Gamma)\right)}+\|H\|_{H^{1}\left(I ; L^{2}(\Gamma)\right)} .
\end{aligned}
$$

Next, we employ Theorem 2.3 to (3.36) and we obtain

$$
\begin{align*}
& \int_{Q}\left(\frac{1}{s}\left|\partial_{t} \operatorname{rot} u^{(1)}\right|^{2}+s\left|\nabla \operatorname{rot} H^{(1)}\right|^{2}+s^{2}\left|\nabla H^{(1)}\right|^{2}+s^{3}\left|\operatorname{rot} u^{(1)}\right|^{2}+s^{4}\left|H^{(1)}\right|^{2}\right) e^{2 s \varphi} d x d t \\
& \leq C \int_{Q}\left(\left|\operatorname{rot}\left(\partial_{t} F\right)+\operatorname{rot} J_{1}\right|^{2}+\left|\operatorname{rot} J_{2}\right|^{2}\right) e^{2 s \varphi} d x d t+C s^{4} e^{C s} E_{6}^{2}+C s^{4} e^{2 s \mu_{1}} M^{2} \\
& \leq C \int_{Q}\left|\partial_{t} \operatorname{rot} F\right|^{2} e^{2 s \varphi} d x d t+C s^{4} e^{C s} E_{6}^{2}+C s^{4} e^{2 s \mu_{1}} M^{2} \\
& \quad+C \int_{Q}\left(|\nabla \operatorname{rot} u|^{2}+|\nabla \operatorname{rot} H|^{2}+|\nabla u|^{2}+|\nabla H|^{2}+|u|^{2}+|H|^{2}\right) e^{2 s \varphi} d x d t \tag{3.38}
\end{align*}
$$

for all sufficiently large $s \geq 1$. Inserting (3.37) into the right-hand side of (3.38) yields

$$
\begin{aligned}
& \int_{Q}\left(\frac{1}{s}\left|\partial_{t} \operatorname{rot} u^{(1)}\right|^{2}+s\left|\nabla \operatorname{rot} H^{(1)}\right|^{2}+s^{2}\left|\nabla H^{(1)}\right|^{2}+s^{3}\left|\operatorname{rot} u^{(1)}\right|^{2}+s^{4}\left|H^{(1)}\right|^{2}\right) e^{2 s \varphi} d x d t \\
& \leq C \int_{Q}\left(\left|\partial_{t} \operatorname{rot} F\right|^{2}+|\operatorname{rot} F|^{2}\right) e^{2 s \varphi} d x d t+C s^{4} e^{C s} E_{6}^{2}+C s^{4} e^{2 s \mu_{1}} M^{2}
\end{aligned}
$$

for all sufficiently large $s \geq 1$. We combine this inequality with (3.37) to obtain

$$
\begin{aligned}
& \int_{Q}\left(\frac{1}{s}\left|\partial_{t} \operatorname{rot} u^{(1)}\right|^{2}+s\left|\nabla \operatorname{rot} H^{(1)}\right|^{2}+s|\nabla \operatorname{rot} H|^{2}+s^{2}\left|\nabla H^{(1)}\right|^{2}+s^{2}|\nabla H|^{2}\right. \\
& \left.\quad+s^{3}\left|\operatorname{rot} u^{(1)}\right|^{2}+s^{4}\left|H^{(1)}\right|^{2}+s^{4}|H|^{2}\right) e^{2 s \varphi} d x d t \\
& \leq C \int_{Q}\left(\left|\partial_{t} \operatorname{rot} F\right|^{2}+|\operatorname{rot} F|^{2}\right) e^{2 s \varphi} d x d t+C s^{4} e^{C s} E_{6}^{2}+C s^{4} e^{2 s \mu_{1}} M^{2}
\end{aligned}
$$

According to the assumption (1.4), we can estimate the first term on the right-hand side above and we further have

$$
\int_{Q}\left(\frac{1}{s}\left|\partial_{t} \operatorname{rot} u^{(1)}\right|^{2}+s\left|\nabla \operatorname{rot} H^{(1)}\right|^{2}+s|\nabla \operatorname{rot} H|^{2}+s^{2}\left|\nabla H^{(1)}\right|^{2}+s^{2}|\nabla H|^{2}\right.
$$

$$
\begin{gather*}
\left.\quad+s^{3}\left|\operatorname{rot} u^{(1)}\right|^{2}+s^{4}\left|H^{(1)}\right|^{2}+s^{4}|H|^{2}\right) e^{2 s \varphi} d x d t \\
\leq C \int_{Q}\left|\operatorname{rot} F\left(x, t_{0}\right)\right|^{2} e^{2 s \varphi} d x d t+C s^{4} e^{C s} E_{6}^{2}+C s^{4} e^{2 s \mu_{1}} M^{2} \tag{3.39}
\end{gather*}
$$

for all sufficiently large $s \geq 1$. By noting $v=\operatorname{rot} u$, we insert (3.39) into the right-hand side of (3.35) and we obtain

$$
\begin{align*}
\int_{\Omega}\left|\operatorname{rot} F\left(x, t_{0}\right)\right|^{2} e^{2 s \varphi\left(x, t_{0}\right)} d x \leq & C \int_{Q}\left|\operatorname{rot} F\left(x, t_{0}\right)\right|^{2} e^{2 s \varphi} d x d t \\
& +C s^{4} e^{2 s \mu_{1}} M^{2}+C s^{4} e^{C s} D_{3}^{2} \tag{3.40}
\end{align*}
$$

for all sufficiently large $s \geq 1$. Here we noted that $E_{5}^{2}+E_{6}^{2} \leq C D_{3}^{2}$ where $D_{3}$ is the norm of the data that introduced in the theorem.

## Third Step: Completion of the proof

As we mentioned in the fourth step in Subsection 3.1, thanks to the choice of the weight function $\varphi$, we find

$$
\int_{Q}\left|\operatorname{rot} F\left(x, t_{0}\right)\right|^{2} e^{2 s \varphi} d x d t=o(1) \int_{\Omega}\left|\operatorname{rot} F\left(x, t_{0}\right)\right|^{2} e^{2 s \varphi\left(x, t_{0}\right)} d x
$$

as $s \rightarrow \infty$. Thus, by taking $s$ large enough, we can absorb the first term on the right-hand side of (3.40) into the left-hand side. This yields

$$
\begin{equation*}
\int_{\Omega}\left|\operatorname{rot} F\left(x, t_{0}\right)\right|^{2} e^{2 s \varphi\left(x, t_{0}\right)} d x \leq C s^{4} e^{2 s \mu_{1}} M^{2}+C s^{4} e^{C s} D_{3}^{2} \tag{3.41}
\end{equation*}
$$

for all $s$ large enough. With the same argument and the same constant $\mu_{0}>0$ introduced in the last step in Subsection 3.2, we have the lower bound of the lefthand side of (3.41):

$$
\int_{\Omega}\left|\operatorname{rot} F\left(x, t_{0}\right)\right|^{2} e^{2 s \varphi\left(x, t_{0}\right)} d x \geq e^{2 s \mu_{0}}\left\|\operatorname{rot} F\left(\cdot, t_{0}\right)\right\|_{L^{2}\left(\Omega_{0}\right)}^{2}
$$

which implies

$$
\begin{equation*}
\left\|\operatorname{rot} F\left(\cdot, t_{0}\right)\right\|_{L^{2}\left(\Omega_{0}\right)}^{2} \leq C s^{4} e^{-2 s\left(\mu_{0}-\mu_{1}\right)} M^{2}+C s^{4} e^{C s} D_{3}^{2} \tag{3.42}
\end{equation*}
$$

for all $s$ large enough. Since we have $\mu_{0}>\mu_{1}$ by taking $\beta>0$ sufficiently large, we end up with the stability of Hölder type by minimizing the right-hand side of (3.42) with respect to $s$.

## 4 Concluding remarks

### 4.1 Linearization of the MHD equations

Let $\left(u_{i}, p_{i}, H_{i}\right)$ satisfy the following MHD equations

$$
\left\{\begin{array}{l}
\partial_{t} u_{i}-\nu \Delta u_{i}+\left(u_{i} \cdot \nabla\right) u_{i}-\mu \operatorname{rot} H_{i} \times H_{i}+\nabla p_{i}=F_{i} \\
\partial_{t} H_{i}-\frac{1}{\sigma \mu} \Delta H_{i}-\operatorname{rot}\left(u_{i} \times H_{i}\right)=0 \\
\operatorname{div} u_{i}=0, \quad \operatorname{div} H_{i}=0
\end{array}\right.
$$

for $i=1,2$. Then by taking the difference and setting $u=u_{1}-u_{2}, p=p_{1}-p_{2}$, $H=H_{1}-H_{2}$ and $F=F_{1}-F_{2}$, we have

$$
\left\{\begin{array}{l}
\partial_{t} u-\nu \Delta u+\left(u_{1} \cdot \nabla\right) u+(u \cdot \nabla) u_{2}-\mu\left(H_{1} \cdot \nabla\right) H-\mu(H \cdot \nabla) H_{2} \\
\quad+\frac{\mu}{2} \nabla\left(\left(H_{1}+H_{2}\right) \cdot H\right)+\nabla p=F, \\
\partial_{t} H-\frac{1}{\sigma \mu} \Delta H+\left(u_{1} \cdot \nabla\right) H-(H \cdot \nabla) u_{2}-\left(H_{1} \cdot \nabla\right) u+(u \cdot \nabla) H_{2}=0 \\
\operatorname{div} u=0, \quad \operatorname{div} H=0
\end{array}\right.
$$

which corresponds to the linearized MHD equations (1.1) with (1.2). For example, we let $A^{(1)}=u_{1}, A^{(2)}=u_{2}, \ldots$

Therefore, in order to apply the main results in this article to the (nonlinear) MHD equations, we need some a priori regularity of the solutions $\left(u_{i}, p_{i}, H_{i}\right), i=$ 1,2 . Although the existence of the solutions to the initial boundary value problems for the MHD equations is a serious issue with the regularity, here we focus on the inverse problems and we assume the existence of such solutions $\left(u_{i}, p_{i}, H_{i}\right), i=1,2$ with sufficient regularity.

### 4.2 Global Lipschitz stability

As for the Carleman estimates for the parabolic equations including the NavierStokes equations and our MHD equations, one can have Carleman estimates according to each of the weight functions in the following forms:

$$
\begin{equation*}
\text { (i) } \quad \varphi(x, t):=e^{\lambda\left(d(x)-\beta\left(t-t_{0}\right)^{2}\right)} \tag{4.1}
\end{equation*}
$$

which is regular in $x, t$.
(ii) $\quad \alpha(x, t):=\frac{e^{\lambda d(x)}-e^{2 \lambda\|d\|_{C(\bar{\Omega})}}}{\ell(t)}$,
which is singular at $t=0, T$.
Usually one uses the Carleman estimate with the regular weight function (4.1) to prove a local Hölder stability estimate for an inverse problem. On the other hand,
one can apply the Carleman estimate with the singular weight function (4.2) to prove a global Lipschitz stability for an inverse problem provided that the boundary condition on $\partial \Omega \times(0, T)$ is given.

In this article, it is clear that we employed the Carleman estimates with (4.1) and proved the Hölder stability estimates for some inverse source problems. If we assume suitable boundary conditions, for example,

$$
u(x, t)=0, \quad H(x, t)=0, \quad(x, t) \in \partial \Omega \times(0, T)
$$

in additional to (1.1), we can easily combine the arguments in Choulli, Imanuvilov, Puel and Yamamoto [8] or Imanuvilov and Yamamoto [19], in which the authors discussed similar inverse source problems for the linearized Naiver-Stokes equations by the Carleman estimates with (4.2), with what we have done in this article to derive the global Lipschitz stability estimates for the inverse source problems.

However, the boundary condition on the magnetic field intensity $H(x, t)=0$, $(x, t) \in \partial \Omega \times(0, T)$ is not physical. As a possible solution, instead of the boundary conditions, we measure $u$ and $H$ on the full boundary. Then immediately we can prove the related global Lipschitz stability which is parallel to Theorem 1.1 as follows:

$$
\begin{aligned}
& \left\|F\left(\cdot, t_{0}\right)\right\|_{L^{2}(\Omega)} \leq C\left(\|u\|_{H^{2}\left(I ; H^{1}(\partial \Omega)\right)}+\left\|\partial_{n} u\right\|_{H^{1}\left(I ; L^{2}(\partial \Omega)\right)}+\|H\|_{H^{2}\left(I ; H^{1}(\partial \Omega)\right)}\right. \\
& \left.\quad+\left\|\partial_{n} H\right\|_{H^{1}\left(I ; L^{2}(\partial \Omega)\right)}+\|p\|_{H^{1}\left(I ; H^{\frac{1}{2}}(\partial \Omega)\right)}+\left\|u\left(\cdot, t_{0}\right)\right\|_{H^{2}(\Omega)}+\left\|\nabla p\left(\cdot, t_{0}\right)\right\|_{L^{2}(\Omega)}\right)
\end{aligned}
$$

Comparing to the inverse source problem for the parabolic equations, the data on the right-hand side above are too many since we need additionally $\partial_{n} u, \partial_{n} H$ on the boundary. The global Lipschitz stability for the inverse source problems for the MHD equations by less data still remains open.
