Existence of ground state solutions of Nehari-Pankov type to Schrödinger systems *

Abstract: This paper is dedicated to studying the following elliptic system of Hamiltonian type:

$$\begin{aligned} &-\varepsilon^2 \triangle u + u + V(x)v = Q(x)F_v(u,v), \quad x \in \mathbb{R}^N, \\ &-\varepsilon^2 \triangle v + v + V(x)u = Q(x)F_u(u,v), \quad x \in \mathbb{R}^N, \\ &|u(x)| + |v(x)| \to 0, \quad \text{as } |x| \to \infty, \end{aligned}$$

where $N \geq 3$, $V, Q \in \mathcal{C}(\mathbb{R}^N, \mathbb{R})$, V(x) is allowed to be sign-changing and inf Q > 0, and $F \in \mathcal{C}^1(\mathbb{R}^2, \mathbb{R})$ is superquadratic at both 0 and infinity but subcritical. Instead of the reduction approach used in [Calc Var PDE, 2014, 51: 725-760], we develop a more direct approach – non-Nehari manifold approach to obtain stronger conclusions but under weaker assumptions than these in [Calc Var PDE, 2014, 51: 725-760]. We can find an $\varepsilon_0 > 0$ which is determined by terms of N, V, Q and F, then we prove the existence of a ground state solution of Nehari-Pankov type to the coupled system for all $\varepsilon \in (0, \varepsilon_0]$.

Keywords: Hamiltonian elliptic system, Ground state solutions of Nehari-Pankov type, Strongly indefinite functionals.

1 Introduction

In this paper we study standing waves for the following system of time-dependent nonlinear

Schrödinger equations

$$\begin{cases} i\hbar\frac{\partial\phi_1}{\partial t} + \frac{\hbar^2}{2m}\Delta\phi_1 + \phi_1 + f(x,\phi)\phi_2 = 0,\\ i\hbar\frac{\partial\phi_2}{\partial t} + \frac{\hbar^2}{2m}\Delta\phi_2 + \phi_2 + f(x,\phi)\phi_1 = 0, \end{cases}$$
(1.1)

where *m* is the mass of a particle, \hbar is the Planck constant, $\phi = (\phi_1, \phi_2), \phi_1(t, x)$ and $\phi_1(t, x)$ are the complex valued envelope functions. Suppose that $f(x, e^{i\theta}\phi) = f(x, \phi)$ for $\theta \in [0, 2\pi]$. We will look for standing waves of the form

$$\phi_1(t,x) = e^{i\omega t}u(x), \quad \phi_2(t,x) = e^{i\omega t}v(x),$$

which propagate without changing their shape and thus have a soliton-like behavior. System (1.1) arises quite naturally in nonlinear optics and Bose-Einstein condensates (see [2, 17, 27] and the references therein). In general, the above coupled nonlinear Schrödinger system leads to the elliptic system of Hamiltonian form

$$\begin{cases} -\varepsilon^{2} \Delta u + u = H_{v}(x, u, v), & x \in \mathbb{R}^{N}, \\ -\varepsilon^{2} \Delta v + v = H_{u}(x, u, v), & x \in \mathbb{R}^{N}, \\ |u(x)| + |v(x)| \to 0, \text{ as } |x| \to \infty, \end{cases}$$
(1.2)

where $N \ge 3$, $H \in \mathcal{C}^1(\mathbb{R}^N \times \mathbb{R}^2, \mathbb{R})$ and $\varepsilon > 0$ is a small parameter. The study of the systems similar to (1.2) has only begun quite recently. When $\varepsilon = 1$, it was considered recently in some works [6, 9, 15, 16, 34–39]. For a similar problem on a bounded domain we refer the reader to [5, 7, 9, 14] and the references therein. For a survey on this direction see [8, 25].

For the case $\varepsilon > 0$ is a small parameter, there are some recent works considering the existence of solutions; see for instance [3, 12, 27] and the references therein. In contrast with the case $\varepsilon = 1$, except for the difficulties that the lack of the compactness of the Sobolev embedding and the energy functional is strongly indefinite, no uniqueness results seem to be known for the "limit problem" and this is in some cases a crucial assumption in the single equation case. So asymptotic analysis of solutions with respect to small $\varepsilon > 0$ has been very recently performed; see for example [3, 4, 11, 12, 20, 22–24, 27] and their references. Except for [11, 12, 27], most of the above works considered the case that H(x, u, v) = F(u) + G(v). In particular, in [4], the authors obtained the existence of positive solutions which concentrate on the boundary of Ω for an elliptic system with zero Neumann boundary condition on a bounded domain Ω (see also [20]). In [22], Ramos and Soares considered the following problem

$$\begin{cases} -\varepsilon^2 \Delta u + V(x)u = g(v), & x \in \Omega, \\ -\varepsilon^2 \Delta v + V(x)v = f(u), & x \in \Omega, \\ u, v \in H^1(\mathbb{R}^N), \end{cases}$$
(1.3)

where Ω is a domain of \mathbb{R}^N , $V \in \mathcal{C}(\mathbb{R}^N, \mathbb{R})$ satisfies $0 < V(0) = \min V(x) < \liminf_{|x|\to\infty} V(x) \in (0,\infty]$, f(u) and g(v) are power type functions, superlinear but subcritical at infinity. The authors established the existence of positive solutions which concentrate, as $\varepsilon \to 0$, at a prescribed

finite number of local minimum points (possibly degenerate) of the potential V. Different from those discussed in [3, 22, 23], Ding, Lee and Zhao [11] dealt with existence and concentration phenomena of the ground state solutions to the following subcritical problem

$$\begin{cases} -\varepsilon^{2} \Delta u + u + V(x)v = Q(x)g(|z|)v, & x \in \mathbb{R}^{N}, \\ -\varepsilon^{2} \Delta v + v + V(x)u = Q(x)g(|z|)u, & x \in \mathbb{R}^{N}, \\ |u(x)| + |v(x)| \to 0, \text{ as } |x| \to \infty, \end{cases}$$
(1.4)

where z := (u, v), $V, Q \in \mathcal{C}^1(\mathbb{R}^N, \mathbb{R})$ and $g \in \mathcal{C}^1(\mathbb{R}^+, \mathbb{R}^+)$. Since the energy functional Φ_{ε} associated with system (1.4) is strongly indefinite, to overcome this difficulty, as in [1] (see also [22] and [23]), the authors constructed a reduced functional $\mathcal{R}_{\varepsilon}$ whose critical points are in one to one to critical points of Φ_{ε} , which was first proposed in [1]. With the help of the Nehari manifold of Φ_{ε} , an important information of the least energy c_{ε} was obtained. By estimating the asymptotic behavior of c_{ε} as $\varepsilon \to 0$, they proved c_{ε} is attained for sufficiently small $\varepsilon > 0$. In order to state their results, some notations and assumptions are required. Set

$$V_{\min} := \min_{x \in \mathbb{R}^N} V(x), \quad V_{\max} := \max_{x \in \mathbb{R}^N} V(x), \quad \mathcal{V} := \{x \in \mathbb{R}^N : V(x) = V_{\min}\};$$

$$Q_{\min} := \min_{x \in \mathbb{R}^N} Q(x), \quad Q_{\max} := \max_{x \in \mathbb{R}^N} Q(x), \quad \mathcal{Q} := \{x \in \mathbb{R}^N : Q(x) = Q_{\max}\};$$

$$V_{\infty} := \liminf_{|x| \to \infty} V(x), \quad Q_{\infty} := \limsup_{|x| \to \infty} Q(x);$$

$$\mathcal{A}_v := \{x \in \mathcal{V} : Q(x) = Q(x_v)\} \cup \{x \notin \mathcal{V} : Q(x) > Q(x_v)\}$$

and

$$\mathcal{A}_q := \{ x \in \mathcal{Q} : V(x) = V(x_q) \} \cup \{ x \notin \mathcal{W} : V(x) < V(x_q) \}.$$

Furthermore, the following assumptions are required:

(A0) $V, Q \in \mathcal{C}^1(\mathbb{R}^N, \mathbb{R}), \|V\|_{\infty} < 1, 0 < Q_{\min} \le Q_{\max} < \infty;$

(A1) $V_{\min} < V_{\infty}$, and there exist $x_v \in \mathcal{V}$ and R > 0 such that

$$Q(x_v) = \max_{y \in \mathcal{V}} Q(y) \ge Q(x), \quad \forall \ |x| \ge R;$$

(A2) $Q_{\max} > Q_{\infty}$, and there exist $x_q \in \mathcal{Q}$ and R > 0 such that

$$V(x_q) = \min_{y \in \mathcal{Q}} V(y) \le V(x), \quad \forall \ |x| \ge R;$$

- (G1) $g \in C^1(\mathbb{R}^+, \mathbb{R}^+), g(0) = 0 \text{ and } g'(s) \ge 0 \text{ for } s > 0, \text{ where } \mathbb{R}^+ := [0, \infty);$
- (G2) there exist C > 0 and $p \in (2, 2^*)$ such that $|g(s)| \le C(1 + s^{p-2})$ for all $s \in \mathbb{R}^+$;
- (G3) there exists $\mu > 2$ such that $g(s)s^2 \ge \mu \int_0^s g(t)t dt > 0$ if s > 0.

In [11], they proved the following theorem.

Theorem 1.1. ([11, Theorem 1]) Let (A0), (G1), (G2) and (G3) be satisfied. Suppose that (A1) or (A2) is satisfied. Then for sufficiently small $\varepsilon > 0$, (1.4) has a least energy solution $\hat{z}_{\varepsilon} = (\hat{u}_{\varepsilon}, \hat{v}_{\varepsilon}).$

Theorem 1.1 is very interesting. In its proof, many new tricks were used to overcome the difficulties caused by the strong indefinity of the energy functional Φ_{ε} associated with system (1.4). We point that the regularity assumptions $V, Q \in C^1$ and $g \in C^1$ are very crucial in [11], which seem to be necessary when the reduction method is used. Motivated by the works [11], in this paper, we further study the existence of the ground state solutions of Nehari-Pankov type to the following more general problem

$$\begin{cases} -\varepsilon^2 \triangle u + u + V(x)v = Q(x)F_v(u,v), & x \in \mathbb{R}^N, \\ -\varepsilon^2 \triangle v + v + V(x)u = Q(x)F_u(u,v), & x \in \mathbb{R}^N, \\ |u(x)| + |v(x)| \to 0, \text{ as } |x| \to \infty, \end{cases}$$
(1.5)

where $V, Q \in \mathcal{C}(\mathbb{R}^N, \mathbb{R})$ and $F \in \mathcal{C}^1(\mathbb{R}^2, \mathbb{R})$. Instead of the reduction method used in [11], we will use a more direct approach – non-Nehari manifold approach which was first proposed in [29] for a single Schrödinger equation (see also [30,31]). The main idea of this approach is to construct a minimizing Cerami sequence for the energy functional outside Nehari-Pankov manifold by using the diagonal method, which is completely different from that of Szulkin and Weth [28]. This approach is valid when finding a ground state solution of Nehari-Pankov type.

We will obtain stronger conclusions on existence of the ground state solutions of Nehari-Pankov type to (1.5) for small $\varepsilon > 0$ but under weaker assumptions than these in [11]. Roughly speaking, we can find an $\varepsilon_0 > 0$ which is determined by terms of N, V, Q and F, then we prove the existence of a ground state solutions of Nehari-Pankov type to (1.5) for all $\varepsilon \in (0, \varepsilon_0]$. In particular, we only need $V, Q \in \mathcal{C}(\mathbb{R}^N, \mathbb{R})$ and $F \in \mathcal{C}^1(\mathbb{R}^2, \mathbb{R})$. To the best of our knowledge, there seems to be no similar results in literature.

To state our theorems accurately, we set

$$\mathcal{ND}_{0} = \left\{ h \in \mathcal{C}(\mathbb{R}^{+}, \mathbb{R}^{+}) : \left\{ \begin{array}{l} h(0) = 0 \text{ and } h(s) \text{ is nondecreasing on } \mathbb{R}^{+}, \\ \text{there exist constants } p \in (2, 2^{*}) \text{ and } c_{0} > 0 \text{ such that} \\ |h(s)| \leq c_{0}(1 + |s|^{p-2}), \quad \forall s \geq 0. \end{array} \right\}$$
(1.6)

Furthermore, we make the following assumptions.

- (V0) $V, Q \in \mathcal{C}(\mathbb{R}^N, \mathbb{R}), \|V\|_{\infty} \leq \frac{2\eta ab}{a^2+b^2} \text{ and } 0 < Q_{\min} \leq Q_{\max} < \infty, \text{ where } a, b > 0 \text{ and } \eta \in (0, 1);$
- (V1) $V_{\min} < V_{\infty}$, and there exist $x_v \in \mathcal{V}$ and R > 0 such that

$$Q(x_v) \ge Q(x), \quad \forall |x| \ge R;$$

(V2) $Q_{\max} > Q_{\infty}$, and there exist $x_q \in \mathcal{Q}$ and R > 0 such that

$$V(x_q) \le V(x), \quad \forall |x| \ge R;$$

(F1) there exist $g_i, h_j \in \mathcal{ND}_0$, $\alpha_i, \beta_i, \alpha'_j, \beta'_j \in \mathbb{R}$ with $\alpha_i^2 + \beta_i^2 \neq 0$ and $\alpha'_j > {\beta'_j}^2$, $i = 1, 2, \ldots, k; j = 1, 2, \ldots, l$, such that

$$F(u,v) = \sum_{i=1}^{k} \int_{0}^{|\alpha_{i}u+\beta_{i}v|} g_{i}(s)sds + \sum_{j=1}^{l} \int_{0}^{\sqrt{u^{2}+2\beta_{j}'uv+\alpha_{j}'v^{2}}} h_{j}(s)sds;$$

(F2) $\lim_{|au+bv|\to\infty} \frac{|F(u,v)|}{|au+bv|^2} = \infty;$

(F3) there exist $C_0 > 0, T_0 > 0, \mu > 2$ and $F_0 \in C(\mathbb{R}^2, \mathbb{R})$ with $F_0(u, v) > 0$ if $au + bv \neq 0$, such that

$$F(tz) \ge C_0 t^{\mu} F_0(z), \quad \forall \ z \in \mathbb{R}^2, \ t \ge T_0.$$

Remark 1.2. It is clear that (i) (F3) is weaker than (AR)-condition: there exists $\mu > 2$ such that $F_z(z) \cdot z \ge \mu F(z) > 0$ for $z \ne 0$; (ii) (F2) is also weaker than the common super-quadratic condition (SQ): $\lim_{|z|\to\infty} \frac{|F(z)|}{|z|^2} = \infty$; (iii) Let $F(z) = \int_0^{|z|} g(s)sds$. Then (G1)-(G3) imply (F1)-(F3); (iv) Let $Q(x) \equiv 1$ and $F(z) = \int_0^{|u|} g(s)sds + \int_0^{|v|} h(s)sds$, then problem (1.5) reduces to (1.3), which was studied in [22]. Moreover, the assumptions in [22, (H)] also imply (F1)-(F3).

Before presenting our results, we give three nonlinear examples to illustrate the above assumptions.

Example 1.3. Let $F(z) = |au + bv|^{\mu}$, where $\mu \in (2, 2^*)$ and a, b > 0 with $||V||_{\infty} < \frac{2ab}{a^2+b^2}$. It is easy to see that F(z) satisfies (F1)-(F3) with $F_0 = F$, but not (AR).

Example 1.4. Let $F(z) = |au + bv|^{\mu} + (u^2 + uv + v^2) \ln(1 + u^2 + uv + v^2)$, where $\mu \in (2, 2^*)$ and a, b > 0 with $||V||_{\infty} < \frac{2ab}{a^2+b^2}$. It is easy to see that F(z) satisfies (F1)-(F3) with $F_0(u, v) = |au + bv|^{\mu}$, but not (AR).

Example 1.5. Let $F(z) = |2u + v|^{\mu} + |u + 2v|^{\mu}$, where $\mu \in (2, 2^*)$. It is easy to see that F(z) satisfies (F1)-(F3) with a = b = 1 and $F_0 = F$.

Let $x_m = x_v$ if (V1) holds, or $x_m = x_q$ if (V2) holds. Replacing $u(\varepsilon x + x_m)$ and $v(\varepsilon x + x_m)$ by u(x) and v(x), respectively, then system (1.5) is equivalent to

$$\begin{cases} -\triangle u + u + V(\varepsilon x + x_m)v = Q(\varepsilon x + x_m)F_v(u, v), & x \in \mathbb{R}^N, \\ -\triangle v + v + V(\varepsilon x + x_m)u = Q(\varepsilon x + x_m)F_u(u, v), & x \in \mathbb{R}^N, \\ |u(x)| + |v(x)| \to 0, & \text{as } |x| \to \infty. \end{cases}$$
(1.7)

Let $E = H^1(\mathbb{R}^N) \times H^1(\mathbb{R}^N)$. Then E is a Hilbert space with the standard inner product

$$(z_1, z_2)_{H^1(\mathbb{R}^N)} = (u_1, u_2)_{H^1(\mathbb{R}^N)} + (v_1, v_2)_{H^1(\mathbb{R}^N)}, \quad \forall \ z_i = (u_i, v_i) \in E, \ i = 1, 2,$$

and the corresponding norm

$$||z||_{H^1(\mathbb{R}^N)} = \left(||u||^2_{H^1(\mathbb{R}^N)} + ||v||^2_{H^1(\mathbb{R}^N)} \right)^{1/2}, \quad \forall \ z = (u, v) \in E$$

Let $E = E^- \oplus E^+$ be an orthogonal decomposition, see Section 2. Define a functional

$$\Phi_{\varepsilon}(z) = \int_{\mathbb{R}^N} \left[\nabla u \cdot \nabla v + uv + \frac{1}{2} V(\varepsilon x + x_m) |z|^2 \right] \mathrm{d}x - \int_{\mathbb{R}^N} Q(\varepsilon x + x_m) F(z) \mathrm{d}x \tag{1.8}$$

for all $z = (u, v) \in E$. Under assumptions (V0), (F1) and (F2), $\Phi_{\varepsilon} \in \mathcal{C}^1(E, \mathbb{R})$ and

$$\langle \Phi'_{\varepsilon}(z), \varphi \rangle = \int_{\mathbb{R}^N} \left[\nabla u \cdot \nabla \psi + \nabla v \cdot \nabla \phi + (u\psi + v\phi) + V(\varepsilon x + x_m) z \cdot \varphi \right] \mathrm{d}x - \int_{\mathbb{R}^N} Q(\varepsilon x + x_m) F_z(z) \cdot \varphi \mathrm{d}x, \quad \forall \ z = (u, v), \ \varphi = (\phi, \psi) \in E.$$
 (1.9)

Let

$$\mathcal{N}_{\varepsilon}^{-} = \left\{ z \in E \setminus E^{-} : \langle \Phi_{\varepsilon}'(z), z \rangle = \langle \Phi_{\varepsilon}'(z), \zeta \rangle = 0, \quad \forall \zeta \in E^{-} \right\}.$$
(1.10)

 $\mathcal{N}_{\varepsilon}^{-}$ was first introduced by Pankov [19], which is a subset of the Nehari manifold

$$\mathcal{N}_{\varepsilon} = \left\{ z \in E \setminus \{0\} : \left\langle \Phi_{\varepsilon}'(z), z \right\rangle = 0 \right\}.$$
(1.11)

We are now in a position to state the first main result of this paper.

Theorem 1.6. Assume that V, Q and F satisfy (V0), (V1) and (F1)-(F3). Then there exists an $\varepsilon_0 > 0$ such problem (1.5) has a nontrivial solution $\hat{z}_{\varepsilon} = (\hat{u}_{\varepsilon}, \hat{v}_{\varepsilon}) \in \mathcal{N}_{\varepsilon}^-$ with $\Phi_{\varepsilon}(z_{\varepsilon}) = \inf_{\mathcal{N}_{\varepsilon}^-} \Phi_{\varepsilon} > 0$ for $\varepsilon \in (0, \varepsilon_0]$, where $z_{\varepsilon}(x) = \hat{z}_{\varepsilon}(\varepsilon x + x_v)$. If (V1) is replaced by (V2), then the above conclusion remains true by replacing x_v with x_q .

The "limit problem" associated to (1.7) is an autonomous system

$$\begin{cases} -\triangle u + u + V(x_m)v = Q(x_m)F_v(u,v), & x \in \mathbb{R}^N, \\ -\triangle v + v + V(x_m)u = Q(x_m)F_u(u,v), & x \in \mathbb{R}^N. \end{cases}$$
(1.12)

We will prove that the least energy $c_{\varepsilon} := \inf_{\mathcal{N}_{\varepsilon}^{-}} \Phi_{\varepsilon}$ is attained for $\varepsilon \in (0, \varepsilon_{0}]$ by comparing with c_{ε} and the least energy c_{0} associated with "limit problem" (1.12). Therefore, it is very crucial if c_{0} can be attained, i.e. if (1.12) has a solution at which Φ_{0} has the least energy c_{0} on \mathcal{N}_{0}^{-} . Prior to this, we consider the following more general periodic system

$$\begin{cases} -\triangle u + V_1(x)u + V_2(x)v = W_v(x, u, v), & x \in \mathbb{R}^N, \\ -\triangle v + V_1(x)v + V_2(x)u = W_u(x, u, v), & x \in \mathbb{R}^N, \\ u, v \in H^1(\mathbb{R}^N), \end{cases}$$
(1.13)

where $N \geq 3$, $V_1, V_2 : \mathbb{R}^N \to \mathbb{R}$ and $W : \mathbb{R}^N \times \mathbb{R}^2 \to \mathbb{R}$. More precisely, we make the following assumptions.

 $(\mathrm{V0}') \ V_1, V_2 \in \mathcal{C}(\mathbb{R}^N)$ and satisfy

$$|V_2(x)| \le \frac{2\eta ab}{a^2 + b^2} V_1(x), \quad 0 < \inf_{x \in \mathbb{R}^N} V_1(x) \le \sup_{x \in \mathbb{R}^N} V_1(x) < \infty, \tag{1.14}$$

where a, b > 0 and $\eta \in (0, 1)$;

- (V1') $V_1(x)$ and $V_2(x)$ are 1-periodic in each of x_1, x_2, \ldots, x_N ;
- (W0) $W \in \mathcal{C}(\mathbb{R}^N \times \mathbb{R}^2, \mathbb{R}^+)$, W(x, z) is continuously differentiable on $z \in \mathbb{R}^2$ for every $x \in \mathbb{R}^N$, and there exist constants $p \in (2, 2^*)$ and $C_0 > 0$ such that

$$|W_z(x,z)| \le C_0 \left(1+|z|^{p-1}\right), \quad \forall \ (x,z) \in \mathbb{R}^N \times \mathbb{R}^2;$$
(1.15)

(W1) $W_z(x,z) = o(|z|)$, as $|z| \to 0$, uniformly in $x \in \mathbb{R}^N$;

- (W2) $\lim_{|au+bv|\to\infty} \frac{|W(x,u,v)|}{|au+bv|^2} = \infty$, a.e. $x \in \mathbb{R}^N$;
- (W2') $\lim_{|au+bv|\to\infty} \frac{|W(x,u,v)|}{|au+bv|^2} = \infty$, uniformly in $x \in \mathbb{R}^N$;
- (W3) W(x,z) is 1-periodic in each of x_1, x_2, \ldots, x_N ;
- (W4) for all $\theta \ge 0, \ z, \zeta \in \mathbb{R}^2$, there holds

$$\frac{1-\theta^2}{2}\nabla W(x,z)\cdot z - \theta\nabla W(x,z)\cdot \zeta + W(x,\theta z + \zeta) - W(x,z) \ge 0$$

Observe that, the natural functional associated with (1.13) is given by

$$\Phi(z) = \int_{\mathbb{R}^N} \left[\nabla u \cdot \nabla v + V_1(x)uv + \frac{1}{2}V_2(x)|z|^2 \right] \mathrm{d}x - \int_{\mathbb{R}^N} W(x,z)\mathrm{d}x, \qquad (1.16)$$

for all $z = (u, v) \in E$. Furthermore, under assumptions (V0'), (W0) and (W1), $\Phi \in \mathcal{C}^1(E, \mathbb{R})$ and

For system (1.13), we obtain the following existence theorem on the ground state solutions of Nehari-Pankov type.

Theorem 1.8. Assume that V and W satisfy (V0'), (V1') and (W0)-(W4). Then problem (1.13) has a solution $z^* \in \mathcal{N}^-$ such that $\Phi(z^*) = \inf_{\mathcal{N}^-} \Phi > 0$.

However, it is not easy to check assumption (W4). Next, we give several classes functions satisfying (W4). Prior to this, we define one set as follows:

Corollary 1.9. Assume that V and W satisfy (V0'), (V1') and (W2), and that

where $\alpha_i, \beta_i, \alpha'_j, \beta'_j \in \mathbb{R}$ with $\alpha_i^2 + \beta_i^2 \neq 0$ and $\alpha'_j > {\beta'_j}^2, g_i, h_j \in \mathcal{ND}, i = 1, 2, \dots, k; j = 1, 2, \dots, l$. Then problem (1.13) has a solution $z^* \in \mathcal{N}^-$ such that $\Phi(z^*) = \inf_{\mathcal{N}^-} \Phi > 0$.

The paper is organized as follows. In the next section, we develop a functional setting to deal with (1.7) and (1.13). Section 3 is devoted to the proof of Theorem 1.8. In Section 4, we discuss the existence of ground state solutions of Nehari-Pankov type to (1.7).

2 Variational setting

Let $V_{\varepsilon}(x) := V(\varepsilon x + x_m)$ and $Q_{\varepsilon}(x) := Q(\varepsilon x + x_m)$. Then we can rewrite (1.7) as

We will mainly deal with (2.1) instead of (1.7). Let

$$E^{-} = \left\{ \left(-\frac{u}{a}, \frac{u}{b} \right) : u \in H^{1}(\mathbb{R}^{N}) \right\}, \quad E^{+} = \left\{ \left(\frac{u}{a}, \frac{u}{b} \right) : u \in H^{1}(\mathbb{R}^{N}) \right\}.$$

For any $z = (u, v) \in E$, set

It is obvious that $z = z^- + z^+$. Now we define two new inner products on E

$$(z_1, z_2)_{\dagger} = \int_{\mathbb{R}^N} \left[\left(\nabla z_1^+ \cdot \nabla z_2^+ + \nabla z_1^- \cdot \nabla z_2^- \right) + V_1(x) \left(z_1^+ \cdot z_2^+ + z_1^- \cdot z_2^- \right) \right] \mathrm{d}x, \\ \forall \ z_i = (u_i, v_i) \in E, \ i = 1, 2.$$

The corresponding norms are

By virtue of (V0) and (V0'), it is easy to check that the norms $\|\cdot\|$, $\|\cdot\|_{\dagger}$ and $\|\cdot\|_{H^1(\mathbb{R}^N)}$ are equivalent on E. It is easy to see that z^- and z^+ are orthogonal with respect to the inner products (\cdot, \cdot) and $(\cdot, \cdot)_{\dagger}$. Thus we have $E = E^- \oplus E^+$. By a simple calculation, one can get that

$$\frac{ab}{a^{2} + b^{2}} \left(\|z^{+}\|^{2} - \|z^{-}\|^{2} \right) = \int_{\mathbb{R}^{N}} \left(\nabla u \cdot \nabla v + uv \right) \mathrm{d}x, \quad \forall \ z = (u, v) \in E$$

and

$$\frac{ab}{a^2 + b^2} \left(\|z^+\|_{\dagger}^2 - \|z^-\|_{\dagger}^2 \right) = \int_{\mathbb{R}^N} \left[\nabla u \cdot \nabla v + V_1(x) uv \right] \mathrm{d}x, \quad \forall \ z = (u, v) \in E.$$

Therefore, the functionals Φ_{ε} defined by (1.8) and Φ by (1.16) can be rewritten

Lemma 2.1. Suppose that (V0), (F1)-(F2) are satisfied. If z = (u, v) is a critical point of Φ_{ε} , then $|z(x)| \to 0$ as $|x| \to \infty$. In a word, z is a solution to system (2.1).

The proof is almost standard (see [10, Lemma 2.1 and Theorem 2.1].

3 Ground state solutions of Nehari-Pankov type for periodic system

Let $X = X^- \oplus X^+$ be a real Hilbert space with $X^- \perp X^+$ and X^- be separable. On X we define a new norm

- (H1) φ is τ -upper semi-continuous;
- (H2) φ' is weakly sequentially continuous;
- (H3) there exist $r > \rho > 0$ and $e \in X^+$ with ||e|| = 1 such that

Let $\Psi(z) = \int_{\mathbb{R}^N} W(x, z) dx$. Employing a standard argument, one can check easily the following lemma.

$$\leq\frac{ab}{a^{2}+b^{2}}\left(\|z^{+}\|_{\dagger}^{2}-\|z^{-}\|_{\dagger}^{2}\right)+\frac{1+\eta}{2(1-\eta)}\int_{\mathbb{R}^{N}}|V_{2}(x)||z^{+}|^{2}dx+\frac{1+\eta}{4\eta}\int_{\mathbb{R}^{N}}|V_{2}(x)||z^{-}|^{2}dx$$

$$\leq\frac{ab}{a^{2}+b^{2}}\int_{\mathbb{R}^{N}}\left[|\nabla z^{+}|^{2}+\frac{1+\eta^{2}}{1-\eta}V_{1}(x)|z^{+}|^{2}\right]dx$$

$$-\frac{ab}{a^{2}+b^{2}}\int_{\mathbb{R}^{N}}\left[|\nabla z^{-}|^{2}+\frac{1-\eta}{2}V_{1}(x)|z^{-}|^{2}\right]dx$$

The rest of the proof is standard, so we omit it.

Proof. (2.5) and (3.10) imply $\Phi(z) \leq 0$ for $z \in E^-$. Next, it is sufficient to show that $\Phi(z) \to -\infty$ as $z \in E^- \oplus \mathbb{R}^+ e$ and $||z||_{\dagger} \to \infty$. Arguing indirectly, assume that for some sequence $\{\zeta_n + s_n e\} \subset E^- \oplus \mathbb{R}^+ e$ with $||\zeta_n + s_n e||_{\dagger} \to \infty$, there is an M > 0 such that $\Phi(\zeta_n + s_n e) \geq -M$ for all $n \in \mathbb{N}$. Set $e = \left(\frac{e_0}{a}, \frac{e_0}{b}\right), \zeta_n = \left(-\frac{w_n}{a}, \frac{w_n}{b}\right)$ and $\xi_n = (\zeta_n + s_n e)/||\zeta_n + s_n e||_{\dagger} = \xi_n^- + t_n e$, then $||\xi_n^- + t_n e||_{\dagger} = 1$. Passing to a subsequence, we may assume that $t_n \to \overline{t}$ and $\xi_n \to \xi$ in E, then $\xi_n \to \xi$ a.e. on \mathbb{R}^N , $\xi_n^- := \left(-\frac{\tilde{w}_n}{a}, \frac{\tilde{w}_n}{b}\right) \to \xi^- := \left(-\frac{\tilde{w}}{a}, \frac{\tilde{w}}{b}\right)$ in E. Hence, by (2.5) and (3.10), one has

- \int_{\mathbb{R}^{N}} \frac{W\left(x, \frac{-w_{n} + s_{n}e_{0}}{a}, \frac{w_{n} + s_{n}e_{0}}{b}\right)}{\|\zeta_{n} + s_{n}e\|_{\dagger}^{2}} dx \\
\leq \frac{(1 + \eta^{2})abt_{n}^{2}}{(1 - \eta)(a^{2} + b^{2})} - \frac{(1 - \eta)ab}{2(a^{2} + b^{2})} \|\xi_{n}^{-}\|_{\dagger}^{2} \\
- \int_{\mathbb{R}^{N}} \frac{W\left(x, \frac{-w_{n} + s_{n}e_{0}}{a}, \frac{w_{n} + s_{n}e_{0}}{b}\right)}{\|\zeta_{n} + s_{n}e\|_{\dagger}^{2}} dx.$$

If $\bar{t} = 0$, then it follows from (3.12) that

If $\bar{t} \neq 0$, then $s_n \to \infty$. Hence, it follows from (3.12), (W2) and Fatou's Lemma that

a contradiction.

Since E^- is separable, let $\{e_k\}_{k=1}^{\infty}$ be a total orthonormal basis of E^- . On E we define the τ -norm

Proof. It is clear that $\Phi \in \mathcal{C}^1(E, \mathbb{R})$. First we prove that Φ is τ -upper semi-continuous. Let $z_n \xrightarrow{\tau} z$ in E and $\Phi(z_n) \ge c$. It follows from (2.5), (3.10), (3.14) and (W0) that $z_n^+ \to z^+$ in E and

This shows that Φ is τ -upper semi-continuous.

The proof that Φ' is weakly sequentially continuous is standard, so we omit it. \Box

Lemma 3.9. Suppose that (V0'), (W0), (W1), (W2) and (W4) are satisfied. Then there exist a constant $c \in [\kappa, \sup \Phi(\mathfrak{Q}_r)]$ for $r \geq r_0$ and a sequence $\{z_n\} \subset E$ satisfying

The proof is the same as one of [28, Lemma 2.6].

Then $||\tilde{z}_n||_{\dagger} = 1$. By Sobolev embedding theorem, there exists a constant $C_2 > 0$ such that $||\tilde{z}_n^+||_2 \le C_2$. If $\delta := \limsup_{n\to\infty} \sup_{y\in\mathbb{R}^N} \int_{B_1(y)} |\tilde{z}_n^+|^2 dx = 0$, then by Lions' concentration compactness principle [33, Lemma 1.21], $\tilde{z}_n^+ \to 0$ in $L^p(\mathbb{R}^N)$. Obviously, (3.21) implies that $\zeta^+ \ne 0$. For a.e. $x \in \{y \in \mathbb{R}^N : \zeta^+(y) \ne 0\} := \Omega$, we have $\lim_{n\to\infty} |au_n^{k_n}(x) + bv_n^{k_n}(x)| = \infty$. Hence, it follows from (2.5), (3.10), (3.19), (W2), (W3) and Fatou's lemma that

This contradiction shows that $\{||u_n||_{\dagger}\}$ is bounded.

In the last part of the proof of Lemma 3.12, we make use of the periodicity of W(x, z) on x, which is still valid by using (W2') instead of (W2) and (W3). Therefore, we have the following lemma.

Lemma 3.16.([32]) Suppose that $W(x, u, v) = \int_0^{\sqrt{u^2 + 2\beta uv + \alpha v^2}} h(x, s) s ds$, where $\alpha, \beta \in \mathbb{R}$ with $\alpha > \beta^2$ and $h \in \mathcal{ND}$. Then W satisfies (W0), (W1) and (W4).

Proof of Theorem 1.8. Applying Lemmas 3.10 and 3.12, we deduce that there exists a bounded sequence $\{z_n\} = \{(u_n, v_n)\} \subset E$ satisfying (3.18). The rest of the proof is standard. \Box

Employing Theorem 1.8, the conclusion of Corollary 1.9 follows by Lemmas 3.14-3.16.

4 Ground state solutions of Nehari-Pankov type for (2.1)

Without loss of generality, from now on, we assume that $x_v = 0 \in \mathcal{V}$. We only consider the case when (V1) is satisfied, since the arguments are similar when (V2) is satisfied. Then

Passing to a subsequence, we have $\tilde{z}_n^{\varepsilon} \to \tilde{z}^{\varepsilon}$ and $(\tilde{z}_n^{\varepsilon})^+ \to (\tilde{z}^{\varepsilon})^+ \to (\tilde{z}^{\varepsilon})^+$ in $L^s_{\text{loc}}(\mathbb{R}^N)$, $2 \leq s < 2^*$ and $(\tilde{z}_n^{\varepsilon})^+ \to (\tilde{z}^{\varepsilon})^+$ a.e. on \mathbb{R}^N . Obviously, (4.31) implies that $(\tilde{z}^{\varepsilon})^+ \neq 0$. Let $\eta_n^{\varepsilon} := \tilde{\zeta}_n^{\varepsilon}/t_n^{\varepsilon}$. Hence, it follows from (4.2), (4.28), (F1) and (F3) that

$$D = \langle \hat{\Phi}'(t_n^{\varepsilon} z_n^{\varepsilon} + \zeta_n^{\varepsilon}), t_n^{\varepsilon} z_n^{\varepsilon} + \zeta_n^{\varepsilon} \rangle = \langle \hat{\Phi}'(t_n^{\varepsilon} \tilde{z}_n^{\varepsilon} + \tilde{\zeta}_n^{\varepsilon}), t_n^{\varepsilon} \tilde{z}_n^{\varepsilon} + \tilde{\zeta}_n^{\varepsilon} \rangle$$

$$= \langle \hat{\Phi}'(t_n^{\varepsilon} (\tilde{z}_n^{\varepsilon} + \eta_n^{\varepsilon})), t_n^{\varepsilon} (\tilde{z}_n^{\varepsilon} + \eta_n^{\varepsilon}) \rangle$$

$$= \left[\frac{2ab}{a^2 + b^2} \left(\| (\tilde{z}_n^{\varepsilon})^+ \|^2 - \| (\tilde{z}_n^{\varepsilon})^- + \eta_n^{\varepsilon} \|^2 \right) + \hat{V} \int_{\mathbb{R}^N} |\tilde{z}_n^{\varepsilon} + \eta_n^{\varepsilon}|^2 dx \right] (t_n^{\varepsilon})^2$$

$$-Q(0) \int_{\mathbb{R}^N} F_z (t_n^{\varepsilon} (\tilde{z}_n^{\varepsilon} + \eta_n^{\varepsilon})) \cdot t_n^{\varepsilon} (\tilde{z}_n^{\varepsilon} + \eta_n^{\varepsilon}) dx$$

$$\leq \left[\frac{2ab}{a^2 + b^2} \left(\| (\tilde{z}_n^{\varepsilon})^+ \|^2 - \| (\tilde{z}_n^{\varepsilon})^- + \eta_n^{\varepsilon} \|^2 \right) + \hat{V} \int_{\mathbb{R}^N} |\tilde{z}_n^{\varepsilon} + \eta_n^{\varepsilon}|^2 dx \right] (t_n^{\varepsilon})^2$$

$$-2Q(0) \int_{\mathbb{R}^N} F(t_n^{\varepsilon} (\tilde{z}_n^{\varepsilon} + \eta_n^{\varepsilon})) dx$$

$$\leq \left[\frac{2ab}{a^2 + b^2} \left(\| (\tilde{z}_n^{\varepsilon})^+ \|^2 - \| (\tilde{z}_n^{\varepsilon})^- + \eta_n^{\varepsilon} \|^2 \right) + \hat{V} \int_{\mathbb{R}^N} |\tilde{z}_n^{\varepsilon} + \eta_n^{\varepsilon}|^2 dx \right] (t_n^{\varepsilon})^2$$

$$-2\mathcal{C}_0 Q(0) (t_n^{\varepsilon})^{\mu} \int_{\mathbb{R}^N} F_0 (\tilde{z}_n^{\varepsilon} + \eta_n^{\varepsilon}) dx, \qquad (4.32)$$

which, together with (4.26), implies that

$$0 \leq \frac{2ab}{a^{2}+b^{2}} \left(\| (\tilde{z}_{n}^{\varepsilon})^{+} \|^{2} - \| (\tilde{z}_{n}^{\varepsilon})^{-} + \eta_{n}^{\varepsilon} \|^{2} \right) + \hat{V} \int_{\mathbb{R}^{N}} |\tilde{z}_{n}^{\varepsilon} + \eta_{n}^{\varepsilon}|^{2} dx$$

$$\leq \frac{2(1+\eta^{2})ab}{(1-\eta)(a^{2}+b^{2})} \| (\tilde{z}_{n}^{\varepsilon})^{+} \|^{2} - \frac{(1-\eta)ab}{a^{2}+b^{2}} \| (\tilde{z}_{n}^{\varepsilon})^{-} + \eta_{n}^{\varepsilon} \|^{2}.$$
(4.33)

This shows that $\{\|\eta_n^{\varepsilon}\|\}_{n=1}^{\infty}$ is bounded in E^- . Passing to a subsequence, we have $\eta_n^{\varepsilon} \rightharpoonup \eta^{\varepsilon}$ in $E^-, \eta_n^{\varepsilon} \rightarrow \eta^{\varepsilon}$ in $L^s_{\text{loc}}(\mathbb{R}^N), 2 \leq s < 2^*$ and $\eta_n^{\varepsilon} \rightarrow \eta^{\varepsilon}$ a.e. on \mathbb{R}^N .

Since $(\tilde{z}^{\varepsilon} + \eta^{\varepsilon})^+ = (\tilde{z}^{\varepsilon})^+ \neq 0$, it follows from (F3) that $\int_{\mathbb{R}^N} F_0(\tilde{z}^{\varepsilon} + \eta^{\varepsilon}) dx > 0$, which, together with (4.32), implies that $\{t_n^{\varepsilon}\}_{n=1}^{\infty}$ is bounded, and so $\{\|\zeta_n^{\varepsilon}\|\}_{n=1}^{\infty}$ is also bounded. Therefore, there exist $K_1(\varepsilon) > 0$ and $K_2(\varepsilon) > 0$ such that (4.29) holds.

Theorem 4.10. Assume that V, Q and F satisfy (V0), (V1) and (F1)-(F3). Then for $\varepsilon \in (0, \varepsilon_0]$, problem (2.1) has a solution $z_{\varepsilon} \in E$ such that $\Phi_{\varepsilon}(z_{\varepsilon}) = \inf_{\mathcal{N}_{\varepsilon}^-} \Phi_{\varepsilon} > 0$.

Proof. By Lemmas 4.7 and 4.8, there exists a bounded sequence $\{z_n^{\varepsilon}\} = \{(u_n^{\varepsilon}, v_n^{\varepsilon})\} \subset E$ satisfying (4.25). Thus there exists a $z^{\varepsilon} = (u^{\varepsilon}, v^{\varepsilon}) \in E$ such that $z_n^{\varepsilon} \rightharpoonup z^{\varepsilon}$. Next, we prove that $z^{\varepsilon} \neq 0$ for all $\varepsilon \in (0, \varepsilon_0]$.

Arguing by contradiction, suppose that $z^{\varepsilon} = 0$ for some $\varepsilon \in (0, \varepsilon_0]$, i.e. $z_n^{\varepsilon} \to 0$ in E, and so $z_n^{\varepsilon} \to 0$ in $L^s_{\text{loc}}(\mathbb{R}^N)$, $2 \le s < 2^*$ and $z_n^{\varepsilon} \to 0$ a.e. on \mathbb{R}^N .

We first prove that $\zeta_n^{\varepsilon} \to 0$ in E^- . Since $\{\|\zeta_n^{\varepsilon}\|\}_{n=1}^{\infty}$ is bounded, passing to a subsequence we may assume that $\zeta_n^{\varepsilon} \to \zeta^{\varepsilon}$ in E^- . By Lemma 4.9, $\{t_n^{\varepsilon}\}$ is bounded, then $t_n^{\varepsilon} z_n^{\varepsilon} + \zeta_n^{\varepsilon} \to \zeta^{\varepsilon}$. By Brezis-Lieb's Lemma (see [33, Lemma 1.32]), one can demonstrate that

$$\hat{\Phi}(t_n^{\varepsilon} z_n^{\varepsilon} + \zeta_n^{\varepsilon}) - \hat{\Phi}(t_n^{\varepsilon} z_n^{\varepsilon} + \zeta_n^{\varepsilon} - \zeta^{\varepsilon}) - \hat{\Phi}(\zeta^{\varepsilon}) = o(1),$$
(4.34)

which, together with (4.9), (V0) and (V1), yields

$$o(1) \ge -\hat{\Phi}(\zeta^{\varepsilon}) \ge \frac{ab}{a^2 + b^2} \|\zeta^{\varepsilon}\|^2 - \frac{\hat{V}}{2} \int_{\mathbb{R}^N} |\zeta^{\varepsilon}|^2 \mathrm{d}x \ge \frac{(1 - \eta)ab}{a^2 + b^2} \|\zeta^{\varepsilon}\|^2.$$
(4.35)

This shows that $\zeta^{\varepsilon} = 0$, i.e. $\zeta_n^{\varepsilon} \rightarrow 0$ in E^- . By (4.2), (4.9), (4.20), (4.25), (4.28) and (F1), we have

$$\begin{aligned} c_{\varepsilon} + o(1) &\geq \bar{c}_{\varepsilon} + o(1) = \Phi_{\varepsilon}(z_{n}^{\varepsilon}) \\ &\geq \Phi_{\varepsilon}(t_{n}^{\varepsilon}z_{n}^{\varepsilon} + \zeta_{n}^{\varepsilon}) + \frac{1 - (t_{n}^{\varepsilon})^{2}}{2} \langle \Phi_{\varepsilon}^{\prime}(z_{n}^{\varepsilon}), z_{n}^{\varepsilon} \rangle - t_{n}^{\varepsilon} \langle \Phi_{\varepsilon}^{\prime}(z_{n}^{\varepsilon}), \zeta_{n}^{\varepsilon} \rangle \\ &= \Phi_{\varepsilon}(t_{n}^{\varepsilon}z_{n}^{\varepsilon} + \zeta_{n}^{\varepsilon}) + o(1) \\ &= \hat{\Phi}(t_{n}^{\varepsilon}z_{n}^{\varepsilon} + \zeta_{n}^{\varepsilon}) + \frac{1}{2} \int_{\mathbb{R}^{N}} \left(V_{\varepsilon}(x) - \hat{V} \right) |t_{n}^{\varepsilon}z_{n}^{\varepsilon} + \zeta_{n}^{\varepsilon}|^{2} dx \\ &+ \int_{\mathbb{R}^{N}} \left[Q(0) - Q_{\varepsilon}(x) \right] F(t_{n}^{\varepsilon}z_{n}^{\varepsilon} + \zeta_{n}^{\varepsilon}) dx + o(1) \\ &\geq \hat{c} + \frac{1}{2} \int_{|x| \leq R_{0}/\varepsilon} \left(V_{\varepsilon}(x) - \hat{V} \right) |t_{n}^{\varepsilon}z_{n}^{\varepsilon} + \zeta_{n}^{\varepsilon}|^{2} dx \\ &+ \int_{|x| \leq R_{0}/\varepsilon} \left[Q(0) - Q_{\varepsilon}(x) \right] F(t_{n}^{\varepsilon}z_{n}^{\varepsilon} + \zeta_{n}^{\varepsilon}) dx + o(1) \\ &\geq \hat{c} - \frac{2V_{\max} - V_{\infty} - V(0)}{4} \int_{|x| \leq R_{0}/\varepsilon} |t_{n}^{\varepsilon}z_{n}^{\varepsilon} + \zeta_{n}^{\varepsilon}|^{2} dx \\ &+ \left[Q(0) - Q_{\max} \right] \int_{|x| \leq R_{0}/\varepsilon} F(t_{n}^{\varepsilon}z_{n}^{\varepsilon} + \zeta_{n}^{\varepsilon}) dx + o(1) \\ &= \hat{c} + o(1). \end{aligned}$$

$$(4.36)$$

On the other hand, by Lemmas 4.3 and 4.6, one has

$$\hat{c} \ge c_0 + \hat{\delta} \ge c_{\varepsilon} + \frac{1}{4}\hat{\delta},$$

which contradicts to (4.36). Therefore, $z^{\varepsilon} \neq 0$ for all $\varepsilon \in (0, \varepsilon_0]$. In a standard way, we can certify that $\Phi'_{\varepsilon}(z^{\varepsilon}) = 0$ and $\Phi_{\varepsilon}(z^{\varepsilon}) = c_{\varepsilon} = \inf_{\mathcal{N}_{\varepsilon}^-} \Phi_{\varepsilon}$. This shows that $z^{\varepsilon} \in E$ is a solution for problem (2.1) with $\Phi_{\varepsilon}(z^{\varepsilon}) = \inf_{\mathcal{N}_{\varepsilon}^-} \Phi_{\varepsilon} > 0$.

Proof of Theorem 1.6. For $\varepsilon \in (0, \varepsilon_0]$, Theorem 4.10 implies that problem (2.1) has a solution $z_{\varepsilon} \in E$ such that $\Phi_{\varepsilon}(z_{\varepsilon}) = \inf_{\mathcal{N}_{\varepsilon}^-} \Phi_{\varepsilon} > 0$. Then

$$\hat{z}_{\varepsilon}(x) = (\hat{u}_{\varepsilon}(x), \hat{v}_{\varepsilon}(x)) := z_{\varepsilon}(\varepsilon^{-1}(x - x_v)) = (u_{\varepsilon}(\varepsilon^{-1}(x - x_v)), v_{\varepsilon}(\varepsilon^{-1}(x - x_v)))$$

is a nontrivial solution of problem (1.5).
