# GENERALIZED PSEUDO-COEFFICIENTS OF DISCRETE SERIES OF $p$-ADIC GROUPS

#### Abstract

Let $G$ be a connected reductive group over a $p$-adic field $F$ of characteristic 0 and let $M$ be an $F$-Levi subgroup of $G$. Given a discrete series representation $\sigma$ of $M(F)$, we prove that there exists a locally constant and compactly supported function on $M(F)$, which generalizes a pseudo-coefficient of $\sigma$. This function satisfies similar properties to the pseudo-coefficient, and its lifting to $G(F)$ is applied to the Plancherel formula.

## 1. Introduction

Given a connected semi-simple group $G$ over a $p$-adic field $F$ of characteristic 0 and a discrete series representation $\sigma$ of $G(F)$ (that is, $\sigma$ is an irreducible, admissible, unitary representation whose matrix coefficients are square-integrable modulo the center of $G(F)$ ), it is well-known ([Kaz86], [SS97]) that there exists a pseudo-coefficient $\phi_{\sigma}$ for $\sigma$, which lies in the Hecke algebra $C_{c}^{\infty}(G(F))$ of locally constant and compactly supported functions on $G(F)$, satisfying the property that, for any tempered representation $\pi$ of $G(F)$,

$$
\operatorname{trace}(\pi)\left(\phi_{\sigma}\right)= \begin{cases}1, & \text { if } \pi \simeq \sigma \\ 0, & \text { otherwise }\end{cases}
$$

Historically, Harish-Chandra already knew that the Howe conjecture implied the existence (see Clo91, p.102]). Another proof of the existence relies on the trace Paley-Wiener theorem ([BDK86]). As an explicit

[^0]example of such a pseudo-coefficient, $\phi_{\text {St }}$ with the Steinberg representation St of $G(F)$ forms an EulerPoincaré function in Kot88, and this result is generalized to any discrete series representation of $G(F)$ in SS97.

The pseudo-coefficient $\phi_{\sigma}$ satisfies interesting properties. The orbital integral of $\phi_{\sigma}$ at a regular semisimple element $\gamma$ of $G(F)$ vanishes unless $\gamma$ is elliptic (Kaz86, SS97). This property, so-called cuspidality, is so crucial as to get various trace formulas (see Har11 for example). It is also applied to endoscopic transfers (AC89, HS12]) and the limit multiplicities of discrete series representations in spaces of automorphic forms ([lo86], FLM14]). The orbital integral is also related to the Harish-Chandra character function of $\sigma$ (Kaz86, SS97]).

All work on pseudo-coefficients under the condition 'semi-simplicity' can be extended to the case that $G(F)$ has compact center. This is possible because the group $\Psi(G)$ of unramified characters on $G(F)$ is finite (see Remark (2.4). One then chooses a regular function $\xi$ on the $\Psi(G)$-orbit of $\sigma$ such that $\xi(z)$ vanishes unless $z=\sigma$. This $\xi$ thus gives the pseudo-coefficient $\phi_{\sigma}$ by means of the trace Paley-Wiener theorem ([BDK86]).

In the general case that the group $G(F)$ has non-compact center, however, $\Psi(G)$ is no longer finite. It follows that there exists no such $\xi$ as above. For such a group, instead, one can find a function $\phi_{\sigma}^{\omega}$ in the Hecke algebra $C_{c}^{\infty}\left(G(F), \omega^{-1}\right)$ of locally constant functions with compact support modulo the center and transforming under the center by $\omega^{-1}$, where $\omega$ is the central character of $\sigma$. The function $\phi_{\sigma}^{\omega}$ satisfies the property that, for any tempered representation $\pi$ of $G(F)$ whose central character is $\omega$,

$$
\operatorname{trace}(\pi)\left(\phi_{\sigma}^{\omega}\right)= \begin{cases}1, & \text { if } \pi \simeq \sigma \\ 0, & \text { otherwise }\end{cases}
$$

We also say such a function $\phi_{\sigma}^{\omega}$ is a pseudo-coefficient of $\sigma$ (see [Clo91, [DKV84, A.4]).
The purpose of this paper is to study a locally constant and compactly supported function on $G(F)$ with non-compact center, which generalizes both pseudo-coefficients $\phi_{\sigma} \in C_{c}^{\infty}(G(F))$ for the case with compact center and $\phi_{\sigma}^{\omega} \in C_{c}^{\infty}\left(G(F), \omega^{-1}\right)$ for the case with non-compact center. We work with an arbitrary $F$-Levi subgroup $M$ (possibly, $M=G$ ) of a connected reductive group $G$ over $F$. Our generalized pseudo-coefficient is determined by a discrete series representation of $M(F)$ and a regular function on the $\Psi(G)$-orbit of $\sigma$. It also satisfies the cuspidal property. Furthermore, its projection to $C_{c}^{\infty}\left(M(F), \omega^{-1}\right)$ is related to the pseudocoefficient $\phi_{\sigma}^{\omega}$ and the Harish-Chandra character function of $\sigma$. As an application, we lift it to a function in $C_{c}^{\infty}(G(F))$ and simplify the Plancherel formula.

We explain our results more precisely. Let $\sigma$ be a discrete series representation of $M(F)$ and let $\xi$ be a regular function on the $\Psi(M)$-orbit of $\sigma$ (denoted by $\Omega(\sigma)$ ). Using the trace Paley-Wiener theorem ([BDK86]), we prove that there exists a locally constant and compactly supported function $\phi_{\sigma, \xi}$ on $M(F)$ such that, for all tempered representations $\pi$ of $(M(F))$,

$$
\operatorname{trace}(\pi)\left(\phi_{\sigma, \xi}\right)= \begin{cases}\xi(\pi), & \text { if } \pi \simeq \sigma \otimes \psi \text { for some } \psi \in \Psi(M) \\ 0, & \text { otherwise }\end{cases}
$$

We call $\phi_{\sigma, \xi}$ a generalized pseudo-coefficient for $\sigma$ and $\xi$. We remark that the regular function $\xi(z)$ cannot be chosen to be 0 for $z \neq \sigma$, unless $M=G$ and $G(F)$ has compact center. The reason is that $\Omega(\sigma)$ is isomorphic to the quotient of $\left(\mathbb{C}^{\times}\right)^{d}$ by a finite subgroup, the stabilizer $\operatorname{Stab}_{\Psi}(\sigma)$ of $\sigma$ in $\Psi(M)$, where $d$ is the dimension of the split component in the center $Z_{M}$ of $M$ (see Sections 2.3 and 2.4 for details). This part is different from the case with compact center. Furthermore, the fact that $\phi_{\sigma, \xi}$ has compact support on $M(F)$ makes a distinction from $\phi_{\sigma}^{\omega} \in C_{c}^{\infty}\left(M(F), \omega^{-1}\right)$.

Despite such differences the generalized pseudo-coefficient $\phi_{\sigma, \xi}$ satisfies several properties similar to those pseudo-coefficients $\phi_{\sigma}$ and $\phi_{\sigma}^{\omega}$. Given $\sigma$ and $\xi$, the function $\phi_{\sigma, \xi}$ is uniquely determined modulo the $\mathbb{C}$ subspace that is spanned by the functions of the form $m \mapsto\left(h(m)-h\left(x m x^{-1}\right)\right)$, for all $h \in C_{c}^{\infty}(M(F))$ and $x \in M(F)$ (see Remark 3.7). The function also satisfies the cuspidal property (Proposition 3.9)

$$
O_{\gamma}^{M(F)}\left(\phi_{\sigma, \xi}\right)=0=O_{\gamma}^{M(F)}\left(\phi_{\sigma, \xi}^{\omega}\right)
$$

for any $\gamma$ regular semi-simple but not elliptic in $M(F)$, where $\phi_{\sigma, \xi}^{\omega}(m)$ denotes the canonical projection $\int_{Z_{M}(F)} \omega(z) \phi_{\sigma, \xi}(z m) d z$ of $\phi_{\sigma, \xi}$ onto $C_{c}^{\infty}\left(M(F), \omega^{-1}\right)$. Furthermore, by making a suitable choice of $\xi$ so
that $\xi(z)$ vanishes on a finite subset of $\Omega(\sigma)$ whose central character is $\omega$, unless $z=\sigma$ (see Lemma 3.12 for the finite subset), Proposition 3.13 provides a relationship between the orbital integral of $\phi_{\sigma, \xi}^{\omega}$ and the Harish-Chandra character $\Theta_{\sigma}$

$$
O_{\gamma}^{M(F)}\left(\phi_{\sigma, \xi}^{\omega}\right)=\xi(\sigma) \overline{\Theta_{\sigma}(\gamma)}
$$

for every elliptic regular semi-simple $\gamma$ in $M(F)$. Here the bar ${ }^{-}$means the complex conjugation. We note that the value $\xi(\sigma)$ above is determined by $h_{\sigma}^{\omega}(1)$ and the formal degree $d_{M}(\sigma)$, where $h_{\sigma}^{\omega}$ is a matrix coefficient of $\sigma$ (see Remark 3.16). By taking the regular function $\xi$ with $\xi(\sigma)=1$, that is, $h_{\sigma}^{\omega}(1)=d_{M}(\sigma)$, we get a simple relationship between $\phi_{\sigma, \xi}^{\omega}$ and a pseudo-coefficient $\phi_{\sigma}^{\omega}$ of $\sigma$ (see Proposition 3.18). Applying $\phi_{\sigma, \xi}^{\omega}$ to the Plancherel formula, we also get

$$
\phi_{\sigma, \xi}(1)=d_{M}(\sigma) \int_{\psi \in \Psi_{u}(M) / \operatorname{Stab}_{\Psi}(\sigma)} \xi(\sigma \otimes \psi) d \psi
$$

where $\Psi_{u}(M)$ is the subgroup of $\Psi(M)$ consisting of unitary characters (Proposition 3.24).
Using the cuspidal property and parabolic descent, we lift the generalized pseudo-coefficient $\phi_{\sigma, \xi} \in$ $C_{c}^{\infty}(M(F))$ to $f_{\sigma, \xi} \in C_{c}^{\infty}(G(F))$. They are related by the formula (Theorem 3.22)

$$
\left|D_{G / M}(\gamma)\right|^{1 / 2} O_{\gamma}^{G(F)}\left(f_{\sigma, \xi}\right)=O_{\gamma}^{M(F)}\left(\bar{f}_{\sigma, \xi}^{(P)}\right)=O_{\gamma}^{M(F)}\left(|W(\theta, \theta)| \cdot \phi_{\sigma, \xi}\right),
$$

for every elliptic regular semi-simple $\gamma$ in $M(F)$, where $D_{G / M}(\gamma)=\left.\operatorname{det}(1-a d(\gamma))\right|_{\operatorname{Lie}(G) / \operatorname{Lie}(M)}$. Here we impose the condition that $\xi$ be a $W(\theta, \theta)$-invariant regular function on $\Omega(\sigma)$. We refer to Section 3.3 for unexplained notations. As an application, this lifting $f_{\sigma, \xi}$ turns out to simplify the Plancherel formula as in Proposition 3.26 .

This paper is organized as follows. In Section 2, we recall background material and review basic facts on the Plancherel formula, unramified characters, and regular functions on $\Psi(M)$ and $\Omega(\sigma)$. In Section 3 we prove the existence of a generalized pseudo-coefficient and study its properties: cuspidality, a relation to the Harish-Chandra character function as well as 'usual' pseudo-coefficients. We also lift the generalized pseudo-coefficient in $C_{c}^{\infty}(M(F))$ to a function in $C_{c}^{\infty}(G(F))$ and apply the generalized pseudo-coefficient and the lift to the Plancherel formula.

## 2. Preliminaries

This section is devoted to basic notions, terminologies and known results. We mainly refer to [HR10], HC73, Kot86, Sha90, Shi10, and Wal03.
2.1. Notation and convention. Let $F$ be a $p$-adic field of characteristic 0 , that is, a finite extension of $\mathbb{Q}_{p}$, where $p$ is a prime number. Let $\bar{F}$ be an algebraic closure of $F$. Denote by $\mathcal{O}_{F}$ the ring of integers of $F$ and by $\mathfrak{p}$ the maximal ideal in $\mathcal{O}_{F}$. Let $q$ denote the cardinality of the residue field $\mathcal{O}_{F} / \mathfrak{p}$ and $|\cdot|_{F}$ the normalized absolute value on $F$.

Let $G$ be a connected reductive algebraic group over $F$. Write $G(F)$ for the group of $F$-points of $G$. For a semi-simple element $\gamma \in G(F)$, write $G_{\gamma}$ for the centralizer in $G$ of $\gamma$ and $G_{\gamma}^{\circ}$ for its identity component. We say $\gamma$ is regular if $G_{\gamma}^{\circ}$ is a maximal torus in $G$. Let $G(F)^{\text {reg }}$ denote the set of regular semi-simple elements in $G(F)$. We say $\gamma$ is elliptic if the quotient $G_{\gamma}^{\circ} / Z_{G}^{\circ}$ is anisotropic over $F$. Let $G(F)^{\text {ell }}$ denote the set of elliptic regular semi-simple elements in $G(F)$.

We denote by $C_{c}^{\infty}(G(F))$ the Hecke algebra of locally constant functions with compact support. Let $\operatorname{Irr}(G(F))$ (resp., $\operatorname{Irr}_{u}(G(F))$ ) be the set of equivalence classes of irreducible admissible (resp., unitary) representations of $G(F)$. By abuse of notation, we identify an equivalence class with its representative. Let $\Pi_{\text {temp }}(G(F))$ and $\Pi_{\text {disc }}(G(F))$ be the subsets of $\operatorname{Irr}(G(F))$ consisting of irreducible tempered representations and discrete series representations of $G(F)$, respectively. Here, we say an admissible representation is a discrete series representation if it is in $\operatorname{Irr}_{u}(G(F))$ and has non-zero matrix coefficients which are squareintegrable modulo the center of $G(F)$. Since it is irreducible, if one non-zero matrix coefficient is squareintegrable, then so are all the others.

Fix a minimal $F$-parabolic subgroup $P_{0}$ of $G$ with its Levi decomposition $M_{0} N_{0}$, where $M_{0}$ is a minimal $F$-Levi subgroup and $N_{0}$ is the unipotent radical of $P_{0}$. Let $A_{0}$ be the split component of $M_{0}$ (or $P_{0}$ ), that
is, the maximal $F$-split torus in the center of $M_{0}$. Denote by $W_{G}=W\left(G, A_{0}\right):=N_{G}\left(A_{0}\right) / Z_{G}\left(A_{0}\right)$ the Weyl group of $A_{0}$ in $G$, where $N_{G}\left(A_{0}\right)$ and $Z_{G}\left(A_{0}\right)$ are the normalizer and the centralizer of $A_{0}$ in $G$, respectively. We denote by $\Phi$ the set of roots of $G$ with respect to $A_{0}$. Let $\Phi^{+}$be the set of positive roots. Note that the choice of $P_{0}$ determines the set $\Phi^{+}$of positive roots. Let $\Delta \subset \Phi^{+}$denote the set of simple roots.

Let $P$ be a standard $F$-parabolic subgroup (that is, $P \supseteq P_{0}$ ) with its Levi factor $M=M_{\theta} \supseteq M_{0}$ generated by a subset $\theta \subseteq \Delta$ and its unipotent radical $N \subseteq N_{0}$. Let $A_{M}$ be the split component of $M$. Then we write $\Phi_{\theta}$ for the subset of $\Phi$ consisting of $\mathbb{Z}$-linear combinations of the roots in $\theta$, and $\Phi_{\theta}^{+}$for $\Phi_{\theta} \cap \Phi^{+}$. Denote by $W_{M}=W\left(G, A_{M}\right):=N_{G}\left(A_{M}\right) / Z_{G}\left(A_{M}\right)$ the Weyl group of $A_{M}$ in $G$. We denote by $P^{-}=M N^{-}$the parabolic subgroup opposite to $P$, where $N^{-}$is opposite to $N$. For a standard $F$-Levi subgroup $L=L_{\vartheta}$, we set $W(\vartheta, \theta):=\left\{w \in W_{G}: w(\vartheta)=\theta\right\}$.

Let $X^{*}(M)_{F}$ be the group of $F$-rational characters of $M$. We denote by $\mathfrak{a}_{M}:=\operatorname{Hom}\left(X^{*}(M)_{F}, \mathbb{R}\right)=$ $\operatorname{Hom}\left(X^{*}\left(A_{M}\right)_{F}, \mathbb{R}\right)$ the real Lie algebra of $A_{M}$. Let $\mathfrak{a}_{M, \mathbb{C}}^{*}:=\mathfrak{a}_{M}^{*} \otimes_{\mathbb{R}} \mathbb{C}$ be the complex dual of $\mathfrak{a}_{M}$, where $\mathfrak{a}_{M}^{*}:=X^{*}\left(A_{M}\right)_{F} \otimes_{\mathbb{Z}} \mathbb{R}=X^{*}(M)_{F} \otimes_{\mathbb{Z}} \mathbb{R}$ denotes the dual of $\mathfrak{a}_{M}$. We define the homomorphism $H_{M}: M(F) \rightarrow$ $\mathfrak{a}_{M}$ by

$$
q^{\left\langle\chi, H_{M}(m)\right\rangle}=|\chi(m)|_{F}
$$

for all $\chi \in X^{*}(M)_{F}$ and $m \in M(F)$. Fix a maximal special compact (parahoric) subgroup $K$ of $G(F)$. Then we have the Iwasawa decomposition $G(F)=P(F) K$. Note that one can extend $H_{M}$ to $G(F)$ using the Iwasawa decomposition by $q\left\langle\chi, H_{M}(m n k)\right\rangle=|\chi(m)|_{F}$.

Let $\delta_{P}: M(F) \rightarrow \mathbb{R}_{>0}^{\times}$be the modulus character of $\left.P \operatorname{defined~by~} m \mapsto|\operatorname{det}(\operatorname{ad}(m))|_{\operatorname{Lie}(P) / \operatorname{Lie}(M)}\right|_{F}$. Note that $\delta_{P}(m)=q^{\left\langle 2 \rho_{P}, H_{M}(m)\right\rangle}$, where $\rho_{P}:=\frac{1}{2} \sum_{\alpha \in \Phi^{+} \backslash \Phi_{\theta}^{+}} \alpha$. Moreover, $\delta_{P}$ can be extended to $G(F)$ in the same way as $H_{M}$.

Now we define the normalized induced representation and the intertwining operator. For $\sigma \in \operatorname{Irr}(M(F))$ and $\nu \in \mathfrak{a}_{M, \mathbb{C}}^{*}$, we denote by $I(\nu, \sigma)$ the normalized induced representation

$$
I(\nu, \sigma)=\operatorname{Ind}_{P(F)}^{G(F)}\left(\sigma \otimes q^{\left\langle\nu, H_{M}()\right\rangle} \otimes \mathbb{1}\right) .
$$

The space $V(\nu, \sigma)$ of $I(\nu, \sigma)$ consists of locally constant functions $f$ from $G(F)$ into the representation space of $\sigma$ such that $f(m n g)=\sigma(m) q^{\left\langle\nu+\rho_{P}, H_{M}(m)\right\rangle} f(g)$, for $m \in M(F), n \in N(F)$ and $g \in G(F)$. The group $G(F)$ acts on $V(\nu, \sigma)$ by the regular right action. We often write $i_{G, M}(\nu, \sigma)$ for $I(\nu, \sigma)$ in order to specify groups.
2.2. Plancherel formula. We review the Plancherel formula. We continue with the notation of Section 2.1. Fix a representative $w \in G$ of $\tilde{w} \in W_{G}$ such that $\tilde{w}(\theta) \subseteq \Delta$. For simplicity we often omit $\sim$ for the representative (see [Sha90, p.280]). Denote $N_{\tilde{w}}:=N_{0} \cap w N^{-} w^{-1}$, that is, the subgroup of $N_{0}$ generated by the root groups $U_{\alpha}, \alpha \in \Phi^{+}$such that $w^{-1} \alpha \in N^{-}$. We fix a Haar measure $d n$ on $N_{\tilde{w}}$. Given $f \in V(\nu, \sigma)$, for $g \in G(F)$, the standard intertwining operator is defined as

$$
A(\nu, \sigma, \tilde{w}) f(g)=\int_{N_{\tilde{w}}(F)} f\left(w^{-1} n g\right) d n .
$$

Note that the integral converges absolutely if $\operatorname{Re}\left\langle\nu, \alpha^{\vee}\right\rangle \gg 0, \forall \alpha \in \Delta \backslash \theta$, where $\alpha^{\vee}$ is the coroot attached to $\alpha$. Moreover, it turns out that $A(\nu, \sigma, \tilde{w}): I(\nu, \sigma) \rightarrow I(\tilde{w}(\nu), \tilde{w}(\sigma))$, where $\tilde{w}(\sigma)\left(m_{w}\right):=\sigma\left(w^{-1} m_{w} w\right)$ for $m_{w} \in M_{\tilde{w}(\theta)}(F)$ with $M_{\tilde{w}(\theta)}=w M w^{-1}$. We set

$$
\gamma_{\tilde{w}}(G \mid M)=\int_{\bar{N}_{\tilde{w}}(F)} q^{\left\langle 2 \rho_{P}, H_{M}(\bar{n})\right\rangle} d \bar{n},
$$

where $\bar{N}_{\tilde{w}}:=w^{-1} N_{\tilde{w}} w=N^{-} \cap w^{-1} N_{0} w$ and $d \bar{n}$ is the normalized Haar measure on $\bar{N}_{\tilde{w}}(F)$ so that the measure of $K_{0} \cap \bar{N}_{\tilde{w}}(F)$ is one. Here, $K_{0}$ is a maximal special parahoric subgroup of $G(F)$.

We define the Plancherel measure, due to [HC73, Theorem 20], as follows.
Definition 2.1. For $\nu \in \mathfrak{a}_{M, \mathbb{C}}^{*}, \sigma \in \operatorname{Irr}_{u}(M(F))$ and $\tilde{w}(\theta) \subseteq \Delta$, the Plancherel measure attached to $\nu, \sigma$ and $\tilde{w}$ for $i_{G, M}(\nu, \sigma)$ is defined as a non-zero complex number $\mu_{M}(\nu, \sigma, w)$ such that

$$
A(\nu, \sigma, \tilde{w}) A\left(\tilde{w}(\nu), \tilde{w}(\sigma), \tilde{w}^{-1}\right)=\mu_{M}(\nu, \sigma, w)^{-1} \gamma_{\tilde{w}}(G \mid M)^{2} .
$$

The Plancherel measure $\mu_{M}(\nu, \sigma, w)$ depends only on $\nu, \sigma$ and $\tilde{w}$. It is independent of the choices of any Haar measure and of any representative $w$ of $\tilde{w}$ (Sha90, p.280]).
Example 2.2. Suppose $F=\mathbb{Q}_{p}, G=S L_{2}, M \simeq G L_{1}$ (the diagonal matrix) and $w=\left(\begin{array}{cc}0 & 1 \\ -1 & 0\end{array}\right)$. Denote by $\chi$ a unitary unramified character of $M(F)$. For $s \in \mathbb{C}$, we identify $s$ with $s \tilde{\alpha} \in \mathfrak{a}_{M, \mathbb{C}}^{*} \simeq \mathbb{C}$, where $\tilde{\alpha}=\frac{1}{2}\left(e_{1}-e_{2}\right)$. Then the Plancherel measure $\mu_{M}(s, \chi, w)$ attached to $s, \chi$ and $w$ is

$$
\left(1+\frac{1}{p}\right)^{2} \cdot \frac{1-\chi(p) p^{-s}}{1-\chi(p) p^{-s-1}} \cdot \frac{1-\chi(p)^{-1} p^{s}}{1-\chi(p)^{-1} p^{s-1}},
$$

which lies in the field $\mathbb{C}\left(p^{-s}\right)$ of rational functions in $p^{-s}$.
We now recall the Plancherel formula of Harish-Chandra. We refer to HC84, Section 16] and Wal03, Theorem VIII.1.1]. We normalize Haar measures as in [HC84, Section 5]. Fix a maximal special parahoric subgroup $K_{0}$ of $G(F)$, which is in a good relative position with $M_{0}$ (cf. [Sil79, Section 0.6]). For any closed subgroup $H(F)$ of $G(F)$ with a Haar measure $d h$ on $H(F)$, we normalize $d h$ so that the volume $\operatorname{Vol}_{d h}\left(H(F) \cap K_{0}\right)=1$. Then, Harish-Chandra's $\gamma$-factor $\gamma(G \mid M)$ and Harish-Chandra's $c$-factor $c(G \mid M)$ are defined as

$$
\begin{gathered}
\gamma(G \mid M):=\int_{N^{-}} q^{\left\langle 2 \rho_{P}, H_{M}\left(n^{-}\right)\right\rangle} d n^{-}, \\
c(G \mid M):=\gamma(G \mid M)^{-1} \prod_{\alpha \in \Phi\left(P, A_{M}\right)} \gamma\left(M_{\alpha} \mid M\right) .
\end{gathered}
$$

Set

$$
a(G \mid M):=c(G \mid M)^{-2} \gamma(G \mid M)^{-1}\left|W_{M}\right|^{-1}
$$

For $\pi \in \Pi_{\text {disc }}(M(F))$, we denote by $d_{M}(\pi)$ the formal degree of $\pi$ with respect to the Haar measure $d m$ on $M(F)$ and by $\mu_{M}(\pi)$ the Plancherel measure $\mu_{M}(0, \pi, w)$ as in Definition 2.1. We write $d \pi$ for the measure at $\pi \in \Pi_{\text {disc }}(M(F))$ that is transferred from the normalized Haar measure $d \psi$ on the quotient $\Psi_{u}(M) / \operatorname{Stab}_{\Psi}(\pi)$ (see Sections 2.3 and 2.4 for definitions) via the natural isomorphism

$$
\Psi_{u}(M) / \operatorname{Stab}_{\Psi}(\pi) \simeq\left\{\pi \otimes \psi: \psi \in \Psi_{u}(M)\right\}
$$

(see [MT11, Section 5.4] and HC84, Section 2]). The following proposition states the Plancherel formula.
Theorem 2.3. (Harish-Chandra, HC84, Section 16]) For any $f \in C_{c}^{\infty}(G(F))$,

$$
f(1)=\sum_{M} a(G \mid M) \int_{\pi \in \Pi_{\mathrm{disc}}(M(F))} d_{M}(\pi) \mu_{M}(\pi) \operatorname{trace}\left(i_{G, M} \pi\right)(f) d \pi
$$

where the sum runs over all $F$-Levi subgroups $M$ up to $G(F)$-conjugacy.
2.3. Unramified characters. We introduce the group $\Psi(M)$ of unramified characters of $M(F)$. We continue with the notation in Sections 2.1 and 2.2. Let $M$ be a standard $F$-Levi subgroup of $G$ with split component $A_{M}$. We denote by $Z_{M}$ the center of $M$. We write

$$
M(F)^{1}:=\left\{m \in M(F):|\chi(m)|_{F}=1 \text { for all characters } \chi \in X^{*}(M)_{F}\right\}
$$

We define the group of unramified characters $\Psi(M)$ on $M(F)$ as follows

$$
\Psi(M):=\operatorname{Hom}\left(M(F) / M(F)^{1}, \mathbb{C}^{\times}\right)
$$

Denote by $\Psi_{u}(M)$ the subgroup of $\Psi(M)$ consisting of unitary unramified characters.
Remark 2.4. We note the following facts (see [MT11, Section 3.3] and Roc09, Section 1.4.1]).
(i) $M(F)^{1}=\operatorname{ker}\left(H_{M}\right)$.
(ii) Every compact subgroup in $M(F)$ is contained in $M(F)^{1}$. In particular, $U(F)$ is contained in $L(F)^{1}$ for all standard $F$-parabolic subgroups $Q$ of $M$ with Levi decomposition $Q=L U$.
(iii) $M(F)^{1}$ is an open, closed, normal and unimodular subgroup in $M(F)$.
(iv) The quotient $M(F) / M(F)^{1}$ is isomorphic to $\mathbb{Z}^{d}$, where $d$ is the dimension of $A_{M}$. In particular, if the center of $M$ is anisotropic over $F$, then we have $M(F)=M(F)^{1}$.
(v) The index $\left[M(F): Z_{M}(F) M(F)^{1}\right]$ is finite. Since the quotient $Z_{M}(F) /\left(Z_{M}(F) \cap M(F)^{1}\right)$ is a full rank sublattice of $M(F) / M(F)^{1}$, the index $\left[M(F) / M(F)^{1}: Z_{M}(F) /\left(Z_{M}(F) \cap M(F)^{1}\right)\right]$ is also finite.
Remark 2.5. We fix a $\mathbb{Z}$-basis $\left(m_{1}, m_{2}, \cdots, m_{d}\right)$ for $M(F) / M(F)^{1} \simeq \mathbb{Z}^{d}$. Then the map

$$
\psi \mapsto\left(\psi\left(m_{1}\right), \psi\left(m_{2}\right), \cdots, \psi\left(m_{d}\right)\right)
$$

yields the following isomorphisms

$$
\Psi(M) \simeq\left(\mathbb{C}^{\times}\right)^{d} \text { and } \Psi_{u}(M) \simeq\left(S^{1}\right)^{d}
$$

where $S^{1}$ is the unit circle in $\mathbb{C}^{\times}$(see [Roc09]).
Example 2.6. Suppose $G=M=G L_{m}$. One has that $X^{*}(G)_{F}=\left\{\operatorname{det}^{n}: n \in \mathbb{Z}\right\} \simeq \mathbb{Z}$. We then have a short exact sequence

$$
1 \longrightarrow G^{1}(F) \longrightarrow G(F) \xrightarrow{|\operatorname{det}|_{F}} q^{\mathbb{Z}} \longrightarrow 1
$$

We get $G(F) / G^{1}(F) \simeq \operatorname{Image}\left(|\operatorname{det}|_{F}\right)=\left\{q^{k}: k \in \mathbb{Z}\right\} \simeq \mathbb{Z}$. Thus we have $\Psi(G) \simeq \operatorname{Hom}\left(\mathbb{Z}, \mathbb{C}^{\times}\right) \simeq \mathbb{C}^{\times}$and $\Psi_{u}(G) \simeq \operatorname{Hom}\left(\mathbb{Z}, S^{1}\right) \simeq S^{1}$. In particular, we note that

$$
\begin{gathered}
\Psi(G)=\left\{g \mapsto|\operatorname{det}(g)|_{F}^{s}: s \in \mathbb{C}\right\} \simeq \mathfrak{a}_{G, \mathbb{C}}^{*} / \mathcal{L}_{G} \\
\Psi_{u}(G)=\left\{g \mapsto|\operatorname{det}(g)|_{F}^{s}: s \in \sqrt{-1} \mathbb{R}\right\} \simeq \sqrt{-1} \mathfrak{a}_{G}^{*} / \mathcal{L}_{G}
\end{gathered}
$$

Here $\mathcal{L}_{G}:=\frac{2 \pi \sqrt{-1}}{\log (q)} X^{*}(G)_{F}$ is a lattice in $\sqrt{-1} \mathfrak{a}_{G}^{*}$.
Remark 2.7 (Epimorphism from $\mathfrak{a}_{M, \mathbb{C}}^{*}$ onto $\Psi(M)$ ). There is a natural homomorphism $\nu \mapsto \psi_{\nu}$ from the $\mathbb{C}$-vector space $\mathfrak{a}_{M, \mathbb{C}}^{*}$ to the group $\Psi(M)$ of unramified characters defined by

$$
\psi_{\nu}(m):=q^{\left\langle\nu, H_{M}(m)\right\rangle}
$$

We thus have the following properties (see [MT11, Section 3.3]).
(a) $\psi_{\nu} \in \Psi_{u}(M)$ (that is, $\psi_{\nu}$ is unitary) if and only if $\nu \in \sqrt{-1} \mathfrak{a}_{M}^{*}$.
(b) $\psi_{\nu}$ is trivial if and only if $\nu \in \frac{2 \pi \sqrt{-1}}{\log (q)} X^{*}(M)_{F} \subset \sqrt{-1} \mathfrak{a}_{M}^{*}$. Notice that $\mathcal{L}_{M}:=\frac{2 \pi \sqrt{-1}}{\log (q)} X^{*}(M)_{F}$ is a lattice in $\sqrt{-1} \mathfrak{a}_{M}^{*}$.
(c) The homomorphism $\nu \mapsto \psi_{\nu}$ is surjective. Hence, we have natural isomorphisms

$$
\mathfrak{a}_{M, \mathbb{C}}^{*} / \mathcal{L}_{M} \simeq \Psi(M) \text { and } \sqrt{-1} \mathfrak{a}_{M}^{*} / \mathcal{L}_{M} \simeq \Psi_{u}(M)
$$

Remark 2.8. Let $\nu \in \mathfrak{a}_{M, \mathbb{C}}^{*}, \sigma \in \operatorname{Irr}_{u}(M(F))$ and $\tilde{w} \in W_{G}$ be given as in Definition 2.1. We observe that if $\nu \in \mathcal{L}_{M}$, then we have $\mu_{M}(\nu, \sigma, w)=\mu_{M}(0, \sigma, w)$. Hence, given $\psi \in \Psi(M)$, we write $\mu_{M}(\sigma \otimes \psi)$ for $\mu_{M}(\nu, \sigma, w)$, where $\nu \in \mathfrak{a}_{M, \mathbb{C}}^{*}$ is obtained by letting $\psi_{\nu}=\psi$ in the above natural isomorphism $\nu \mapsto \psi_{\nu}$ from $\mathfrak{a}_{M, \mathbb{C}}^{*} / \mathcal{L}_{M}$ onto $\Psi(M)$.
2.4. Regular functions on $\Psi(M)$ and $\Omega(\sigma)$. We discuss a regular function (resp., a rational function) on $\Psi(M)$, based on the notions and facts in Wal03, Sections III - V]. We continue with the notation as in Sections 2.2 and 2.3. We fix a $\mathbb{Z}$-basis $\left(m_{1}, m_{2}, \cdots, m_{d}\right)$ for $M(F) / M(F)^{1} \simeq \mathbb{Z}^{d}$. Then $\Psi(M)$ is an abelian complex algebraic group that is isomorphic to $\left(\mathbb{C}^{\times}\right)^{d}$ via

$$
\lambda(\psi)=\left(\psi\left(m_{1}\right), \psi\left(m_{2}\right), \cdots, \psi\left(m_{d}\right)\right)
$$

Here $d$ is the dimension of $A_{M}$. Note that $\mathbb{C}\left[z_{1}, z_{1}^{-1}, \cdots, z_{d}, z_{d}^{-1}\right]$ is the set of all regular functions on $\left(\mathbb{C}^{\times}\right)^{d}$.
Definition 2.9. A function $\xi: \Psi(M) \rightarrow \mathbb{C}$ is said to be a regular function (resp., a rational function) on $\Psi(M)$ if there exists a regular (resp., rational) function $p(z)$ on $\left(\mathbb{C}^{\times}\right)^{d}$ such that $\xi(\psi)=p(\lambda(\psi))$ for all $\psi \in \Psi(M)$. Here $z=\left(z_{1}, \cdots, z_{d}\right)$.

Remark 2.10. (Wal03, Section IV. 3 and Lemma V.2.1] and [HC73, Theorem 20]) Let $\sigma \in \operatorname{Irr}(M(F))$ be given. The Plancherel measure $\mu_{M}(\sigma \otimes \psi)$ (see Remark 2.8) is a rational function on $\Psi(M)$. Moreover, it is a non-negative and regular function on $\psi \in \Psi_{u}$.

Remark 2.11. There is a natural action of $W_{M}$ on the set of regular functions on $\Psi(M)$ as follows. Given a regular function $\xi$ on $\Psi(M)$, there exists a regular function $p(z)$ on $\left(\mathbb{C}^{\times}\right)^{d}$ such that $\xi(\psi)=p(\lambda(\psi))$ for all $\psi \in \Psi(M)$. We define

$$
{ }^{w} \xi(\psi)=\xi\left({ }^{w} \psi\right)
$$

Here, the action of the Weyl group $W_{M}$ on $\Psi(M)$ is defined by ${ }^{w} \psi(m)=\psi\left(w^{-1} m w\right)$, for $w \in W_{M}, \psi \in \Psi(M)$, and $m \in M(F)$. It then turns out that ${ }^{w} \xi$ is again a regular function on $\Psi(M)$, since ${ }^{w} \xi(\psi)={ }^{w} p(\lambda(\psi))$, where ${ }^{w} p(z):=p\left(\lambda\left({ }^{w}\left(\lambda^{-1}(z)\right)\right)\right)$ is a regular function on $\left(\mathbb{C}^{\times}\right)^{d}$.

Next, we introduce a regular function (resp., a rational function) on the $\Psi(M)$-orbit

$$
\Omega(\sigma):=\{\sigma \otimes \psi: \psi \in \Psi(M)\}
$$

of $\sigma \in \operatorname{Irr}(M(F))$. Set

$$
\operatorname{Stab}_{\Psi}(\sigma):=\{\psi \in \Psi(M): \sigma \otimes \psi \simeq \sigma\}
$$

to be the stabilizer of $\sigma$ in $\Psi(M)$.
Remark 2.12. We note that $\operatorname{Stab}_{\Psi}(\sigma)$ is a finite subgroup in $\Psi_{u}(M)$ (see [Roc09, Section 1.4.1]) and thus a finite subgroup in $\left(S^{1}\right)^{d}$, where $d$ is the integer with $\Psi_{u}(M) \simeq\left(\mathbb{C}^{\times}\right)^{d}$. There is also an isomorphism $\Omega(\sigma) \simeq \Psi(M) / \operatorname{Stab}_{\Psi}(\sigma)$, whence $\Omega(\sigma)$ is naturally equipped with a complex (quotient) variety structure.

Definition 2.13. A function $\xi: \Omega(\sigma) \rightarrow \mathbb{C}$ is said to be a regular function (resp., a rational function) on $\Omega(\sigma)$ if the function $\psi \mapsto \xi(\sigma \otimes \psi)$ is a regular function (resp., a rational function) on $\Psi(M)$.
Remark 2.14. For a given subgroup $H \subset \Psi(M)$, a regular (resp., rational) function $\xi$ on $\Psi(M)$ is said to be invariant under $H$ if $\xi(\psi)=\xi\left(\psi^{\prime}\right)$ for all $\psi, \psi^{\prime} \in H$. We consider an isomorphism $\Omega(\sigma) \simeq \Psi(M) / \operatorname{Stab}_{\Psi}(\sigma)$. Then, given a regular (resp., rational) function $\xi_{o}$ on $\Psi(M)$ which is invariant under $\operatorname{Stab}_{\Psi}(\sigma)$, we set

$$
\xi(z):=\xi_{o}(\psi)
$$

for $z=\sigma \otimes \psi \in \Omega(\sigma)$. It then turns out that $\xi$ is a regular function (resp., a rational function) on $\Omega(\sigma)$.
Here are some examples of regular functions on $\Psi(M)$ and $\Omega(\sigma)$.
Example 2.15. Let $\sigma \in \operatorname{Irr}_{u}(M(F))$ be given. We denote by $m$ the cardinality of the finite group $\operatorname{Stab}_{\Psi}(\sigma)$. For any polynomial $p(z) \in \mathbb{C}\left[z_{1}^{m}, z_{1}^{-m}, \cdots, z_{d}^{m}, z_{d}^{-m}\right]$, we set $\xi_{o}(\psi)=p(\lambda(\psi))$ for all $\psi \in \Psi(M)$. Then $\xi_{o}$ is a regular function on $\Psi(M)$ that is invariant under $\operatorname{Stab}_{\Psi}(\sigma)$, since $\chi^{m}=1$ for any $\chi \in \operatorname{Stab}_{\Psi}(\sigma)$. Hence, a function

$$
\xi(z)=\xi(\sigma \otimes \psi):=\xi_{o}(\psi)
$$

on $\Omega(\sigma)$ is regular.
Remark 2.16. Let $\xi_{o}$ be a regular function on $\Psi(M)$. For any $w \in W_{M}$, Remark 2.11 implies that ${ }^{w} \xi_{o}$ is again a regular function on $\Psi(M)$. Define

$$
\begin{equation*}
\xi(z):=\frac{1}{\left|W_{M}\right|} \sum_{w \in W_{M}}{ }^{w} \xi_{o}(z) \tag{2.1}
\end{equation*}
$$

Then $\xi(z)$ turns out to be a $W_{M}$-invariant regular function on $\Psi(M)$, that is, ${ }^{w} \xi=\xi$ for any $w \in W_{M}$. Therefore, there is always a $W_{M}$-invariant regular function on $\Psi(M)$. In fact, this holds for any subgroup of $W_{M}$ by replacing $W_{M}$ in (2.1) with the subgroup.

## 3. Generalized pseudo-Coefficients

We continue with the notation of Section 2. Let $G$ be a connected reductive algebraic group over a $p$-adic field $F$ of characteristic 0 , and let $M$ be a standard $F$-Levi subgroup (possibly, $M=G$ ) of $G$ with split component $A_{M}$. In this section, for any $\sigma \in \Pi_{\text {disc }}(M(F))$ and regular function $\xi$ on the $\Psi(M)$-orbit $\Omega(\sigma)$ of $\sigma$, we obtain a function $\phi_{\sigma, \xi} \in C_{c}^{\infty}(M(F))$ satisfying a certain trace relation (Theorem 3.6). We then explore several properties of $\phi_{\sigma, \xi}$ and lift $\phi_{\sigma, \xi} \in C_{c}^{\infty}(M(F))$ to $f_{\sigma, \xi} \in C_{c}^{\infty}(G(F))$. Finally, we apply the Plancherel formula to $\phi_{\sigma, \xi}$ and $f_{\sigma, \xi}$.

Following the notation of BDK86, we denote by $R(M)$ the Grothendieck group of smooth representations of $M(F)(M(F)$-module) of finite length. Note that $R(M)$ is a free abelian group with basis $\operatorname{Irr}(M(F))$. For a standard $F$-parabolic subgroup $Q=L U$ of $M$, the normalized (twisted by $\delta_{Q}^{1 / 2}$ ) induced representation $i_{M, L}(\pi)$ from $\pi \in \operatorname{Irr}(L(F))$ defines the morphism $i_{M, L}: R(L) \rightarrow R(M)$. Here $\delta_{Q}$ is the modulus character of $Q(F)$. A cuspidal pair is defined by $(L, \rho)$, where $L$ is a standard $F$-Levi subgroup of $M$ and $\rho \in \operatorname{Irr}(L(F))$ is an irreducible supercuspidal $L(F)$-module. We denote by $\Theta(M)$ the set of all cuspidal pairs up to $M(F)$ conjugation. We say $(L, \rho)$ and $\left(L^{\prime}, \rho^{\prime}\right)$ are $M(F)$-conjugate if there exists $m \in M(F)$ such that $L^{\prime}=m L m^{-1}$ and $\rho^{\prime}=m \rho m^{-1}$.

Given a cuspidal pair $(L, \rho)$, the set $\{(L, \psi \rho) \mid \psi \in \Psi(L)\}$ is called a connected component of $\Theta(M)$. For each $\pi \in \operatorname{Irr}(M(F))$, there exists a cuspidal pair $(L, \rho)$ unique up to conjugation by $M$ such that $\pi$ is a sub-quotient of $i_{M, L}(\rho)$. By sending $\pi$ to $(L, \rho)$, we define a map inf.ch. : $\operatorname{Irr}(M(F)) \rightarrow \Theta(M)$. The map inf.ch. is $\Psi(M)$-equivariant, onto, and finite-to-one. Given a connected component $\Theta$ of $\Theta(M)$, the inverse image inf.ch. ${ }^{-1}(\Theta)$ is called a connected component of $\operatorname{Irr}(M(F))$.
3.1. Construction of a generalized pseudo-coefficient. We recall the trace Paley-Wiener theorem from [BDK86, Section 1.2] and Clo86, Section 4.2].

Definition 3.1. A linear functional (group homomorphism) $\lambda: R(M) \rightarrow \mathbb{C}$ is called good if
(i) the function $\lambda: \operatorname{Irr}(M(F)) \rightarrow \mathbb{C}$ is supported on a finite number of components;
(ii) for any standard $F$-Levi subgroup $L$ and $\pi \in R(M)$, the function $\psi \mapsto \lambda\left(i_{M, L}(\pi \otimes \psi)\right)$ is a regular function on the complex variety $\Psi(L)$.

Proposition 3.2 (Bernstein-Deligne-Kazhdan). Let $\lambda$ be as in Definition 3.1. $\lambda$ is good if and only if there is a function $h \in C_{c}^{\infty}(M(F))$ such that for any $\pi \in R(M)$

$$
\lambda(\pi)=\operatorname{trace}(\pi)(h)
$$

Remark 3.3. Instead of (i) in Definition 3.1, it is customary to use the condition that there exists an open compact subgroup $K_{M} \subset M(F)$ such that $\lambda$ is non-zero only on the $M(F)$-modules having nontrivial $K_{M^{-}}$ invariant vectors. We note that both are equivalent by Decomposition Theorem in BDK86, Section 2.3].

Definition 3.4. We say that the normalized induced representation $i_{M, L}(\pi)$ is a standard module if $\pi \simeq$ $\tau \otimes q^{\left\langle\nu, H_{L}()\right\rangle}$ for some $\tau \in \Pi_{\text {temp }}(L(F))$ and $\nu \in\left(\mathfrak{a}_{L}^{*}\right)^{+}:=\left\{\nu \in \mathfrak{a}_{L}^{*}:\left\langle\alpha^{\vee}, \nu\right\rangle>0, \quad \forall \alpha \in \Delta_{M} \backslash \Delta_{L}\right\}$ (the positive Weyl chamber), where $\Delta_{M}$ and $\Delta_{L}$ are the sets of simple roots in $M$ and $L$ respectively (see [Clo86, p.279] where it is called a standard character).

Proposition 3.5. (Clo86, Proposition 2 p.279]) The standard modules form a basis over $\mathbb{Z}$ for the Grothendieck group $R(M)$.

Theorem 3.6 (Existence of generalized pseudo-coefficients). For any $\sigma \in \Pi_{\mathrm{disc}}(M(F))$ and any regular function $\xi$ on $\Omega(\sigma)$, there exists a function $\phi_{\sigma, \xi} \in C_{c}^{\infty}(M(F))$ such that for all $\pi \in \Pi_{\text {temp }}(M(F))$,

$$
\operatorname{trace}(\pi)\left(\phi_{\sigma, \xi}\right)= \begin{cases}\xi(\pi), & \text { if } \pi \simeq \sigma \otimes \psi \text { for some } \psi \in \Psi(M) \\ 0, & \text { otherwise } .\end{cases}
$$

We call the function $\phi_{\sigma, \xi} \in C_{c}^{\infty}(M(F))$ a generalized pseudo-coefficient for $\sigma$ and $\xi$.
Remark 3.7 (Uniqueness of generalized pseudo-coefficients). For given a regular function $\xi$ on $\Omega(\sigma)$, the function $\phi_{\sigma, \xi}$ is determined uniquely modulo the $\mathbb{C}$-subspace $J_{M}$ spanned by the functions of the form $m \mapsto$ $\left(h(m)-h\left(x m x^{-1}\right)\right)$ for all $h \in C_{c}^{\infty}(M(F))$ and $x \in M(F)$. This follows from the fact ([Kaz86, Theorem 0]) that

$$
\phi_{1}-\phi_{2} \in J_{M} \Longleftrightarrow \operatorname{trace}(\pi)\left(\phi_{1}\right)=\operatorname{trace}(\pi)\left(\phi_{2}\right), \quad \forall \pi \in \Pi_{\mathrm{temp}}(M(F))
$$

Remark 3.8. We note that, since $\pi \in \Pi_{\text {temp }}(M(F))$ is unitary, the unramified character $\psi$ satisfying $\pi \simeq \sigma \otimes \psi$ must be unitary, that is, in $\Psi_{u}(M)$.

Proof of Theorem [3.6. We refer to Clozel's proof of [Clo86, Proposition 1]. Given a regular function $\xi$ on $\Omega(\sigma)$, we define a linear functional $\lambda: R(M) \rightarrow \mathbb{C}$ such that

$$
\lambda(\pi)= \begin{cases}\xi(\pi), & \text { if } \pi \simeq \sigma \otimes \psi \text { for some } \psi \in \Psi(M) \\ 0, & \text { if } \pi \text { is a standard module but not in } \Omega(\sigma)\end{cases}
$$

Since essentially square-integrable representations can never be realized by an induced representation from a proper $F$-Levi subgroup and by Proposition 3.5, the linear functional $\lambda$ is well-defined.

Now we show that $\lambda$ is good (see Proposition(3.2). If the image inf.ch. $(\sigma)$ is $(L, \rho)$ for some standard $F$-Levi subgroup $L$ of $M$ and a supercuspidal representation $\rho$ of $L(F)$, then inf.ch. maps $\Omega(\sigma)$ into the connected component $\Theta$ containing $(L, \rho)$. Indeed, since the map inf.ch. is $\Psi(M)$-equivariant, we have inf.ch. $(\Psi(M) \sigma)=$ $(L, \Psi(M) \rho) \subset(L, \Psi(L) \rho)=\Theta$. It follows that the linear functional is supported only on $\Theta$, so the condition (i) of Definition 3.1 is fulfilled.

For the condition (ii) of Definition 3.1, it suffices to show that $\lambda$ vanishes on any induced representation $i_{M, L}(\tau)$ with proper standard $F$-Levi subgroup $L$ of $M$ and $\tau \in R(L)$. By Proposition 3.5, we may assume that $\tau$ is a standard module $i_{L, L_{1}}(\varsigma)$, where $L_{1}$ is a standard $F$-Levi subgroup of $L$ and $\varsigma \simeq \varsigma_{1} \otimes q^{\left\langle\nu_{1}, H_{L_{1}}()\right\rangle}$ for some $\varsigma_{1} \in \Pi_{\text {temp }}\left(L_{1}(F)\right)$ and $\nu_{1} \in\left(\mathfrak{a}_{L_{1}}^{*}\right)^{+}$. Then $i_{M, L}(\tau)$ is isomorphic to $i_{M, L_{1}}(\varsigma)$ which is a standard module but not an essentially square-integrable representation (since $L_{1}$ is proper), that is, $i_{M, L}(\tau) \notin \Omega(\sigma)$. It turns out that $\lambda\left(i_{M, L}(\tau)\right)=0$ for any proper standard $F$-Levi subgroup $L$ of $M$ and any $\tau \in R(L)$. Hence, the condition (ii) also follows, and $\lambda$ is good. Due to the trace Paley-Wiener theorem (Proposition 3.2), the proof is complete.
3.2. Properties of $\phi_{\sigma, \xi}$. We provide several properties of the generalized pseudo-coefficient $\phi_{\sigma, \xi}$ for $\sigma$ and $\xi$ defined in Theorem 3.6. Denote by $\omega$ a unitary character of $Z_{M}(F)$, where $Z_{M}$ is the center of $M$. By $C_{c}^{\infty}\left(M(F), \omega^{-1}\right)$ we denote the Hecke algebra of locally constant functions with compact support modulo the center and transforming under the center by $\omega^{-1}$. Let $\Pi_{\text {temp }}(M(F), \omega)$ and $\Pi_{\text {disc }}(M(F), \omega)$ be the sets of equivalent classes of irreducible tempered representations and discrete series representations of $M(F)$, respectively, whose central character is $\omega$.

Let $\sigma \in \Pi_{\text {disc }}(M(F), \omega)$ be given. The projection $\phi_{\sigma, \xi}^{\omega}$ of $\phi_{\sigma, \xi} \in C_{c}^{\infty}(M(F))$ onto $C_{c}^{\infty}\left(M(F), \omega^{-1}\right)$ is defined by

$$
\begin{equation*}
\phi_{\sigma, \xi}^{\omega}(m):=\int_{Z_{M}(F)} \omega(z) \phi_{\sigma, \xi}(z m) d z \tag{3.1}
\end{equation*}
$$

where $d z$ is a Haar measure on $Z_{M}(F)$.
Given $h \in C_{c}^{\infty}(M(F))$, the orbital integral $O_{\gamma}^{M(F)}(h)$ of $h$ for $\gamma \in M(F)$ is defined by

$$
\begin{equation*}
O_{\gamma}^{M(F)}(h):=\int_{M_{\gamma}^{\circ}(F) \backslash M(F)} h\left(x^{-1} \gamma x\right) d x \tag{3.2}
\end{equation*}
$$

where $d x$ is a quotient Haar measure on the quotient $M_{\gamma}^{\circ}(F) \backslash M(F)$. Given a character $\omega$ of $Z_{M}(F)$, we define $O_{\gamma}^{M(F)}\left(h^{\omega}\right)$ for $h^{\omega} \in C_{c}^{\infty}\left(M(F), \omega^{-1}\right)$ in the same way.

We present the cuspidal properties of $\phi_{\sigma, \xi}$ and $\phi_{\sigma, \xi}^{\omega}$.
Proposition 3.9 (Cuspidality of $\phi_{\sigma, \xi}$ and $\left.\phi_{\sigma, \xi}^{\omega}\right)$. With the function $\phi_{\sigma, \xi} \in C_{c}^{\infty}(M(F))$ in Theorem 3.6 and its projection $\phi_{\sigma, \xi}^{\omega}$ defined in (3.1), we have

$$
O_{\gamma}^{M(F)}\left(\phi_{\sigma, \xi}\right)=0=O_{\gamma}^{M(F)}\left(\phi_{\sigma, \xi}^{\omega}\right)
$$

for any $\gamma \in M(F)^{\text {reg }} \backslash M(F)^{\text {ell }}$.
Proof. We first notice from Definition (3.1) that

$$
O_{\gamma}^{M(F)}\left(\phi_{\sigma, \xi}^{\omega}\right)=\int_{Z_{M}(F)} \omega(z) O_{z \gamma}^{M(F)}\left(\phi_{\sigma, \xi}\right) d z
$$

It is sufficient to show that for every $\gamma \in M(F)^{\mathrm{reg}} \backslash M(F)^{\mathrm{ell}}$,

$$
O_{\gamma}^{M(F)}\left(\phi_{\sigma, \xi}\right)=0
$$

KWANGHO CHOIY

Let $\gamma \in M(F)^{\text {reg }} \backslash M(F)^{\text {ell }}$ be given. Then there exists a proper standard $F$-Levi subgroup $L$ of $M$ containing $\gamma$. We denote by $Q$ the standard $F$-parabolic subgroup in $M$ with its Levi factor $L$. We consider the following parabolic descent $\bar{\phi}_{\sigma, \xi}^{(Q)}$ of $\phi_{\sigma, \xi}$ which is due to Harish-Chandra (cf. [vD72, p.236] and [Kot05, Section 13]). By vD72, Lemma 9], we have

$$
\begin{equation*}
\left|D_{M / L}(\gamma)\right|^{1 / 2} O_{\gamma}^{M(F)}\left(\phi_{\sigma, \xi}\right)=O_{\gamma}^{L(F)}\left(\bar{\phi}_{\sigma, \xi}^{(Q)}\right) \tag{3.3}
\end{equation*}
$$

where $D_{M / L}(\gamma)=\left.\operatorname{det}(1-a d(\gamma))\right|_{\operatorname{Lie}(M) / \operatorname{Lie}(L)}$. We claim that

$$
O_{\gamma}^{L(F)}\left(\bar{\phi}_{\sigma, \xi}^{(Q)}\right)=0
$$

for all $\gamma \in L(F)$. It is well-known (cf. vD72, p.237] and Kot05, Section 13.7]) that

$$
\operatorname{trace}(\pi)\left(\bar{\phi}_{\sigma, \xi}^{(Q)}\right)=\operatorname{trace}\left(i_{M, L}(\pi)\right)\left(\phi_{\sigma, \xi}\right)
$$

for any $\pi \in \operatorname{Irr}(L(F))$. Since $L$ is proper and the orbit $\Omega(\sigma)$ consists only of essentially square-integrable representations, $i_{M, L}(\pi)$ cannot be in $\Omega(\sigma)$. Theorem 3.6 implies that

$$
\begin{equation*}
\operatorname{trace}\left(i_{M, L}(\pi)\right)\left(\phi_{\sigma, \xi}\right)=0 \tag{3.4}
\end{equation*}
$$

for any $\pi \in \operatorname{Irr}(L(F))$. It follows that $\operatorname{trace}(\pi)\left(\bar{\phi}_{\sigma, \xi}^{(Q)}\right)=0$. Therefore, the claim is true from the fact (Kaz86, Theorem 0]) that

$$
\operatorname{trace}(\pi)\left(\bar{\phi}_{\sigma, \xi}^{(Q)}\right)=0 \quad \text { for all } \pi \in \Pi_{\text {temp }}(L(F))
$$

if and only if

$$
O_{\gamma}^{L(F)}\left(\bar{\phi}_{\sigma, \xi}^{(Q)}\right)=0 \quad \text { for all } \gamma \in M(F)^{\mathrm{reg}}
$$

Since $D_{M / L}$ is never zero for any element in $M(F)^{\text {reg }}$, the proof is complete.
Remark 3.10. Proposition 3.9 is called the Selberg principle (cf. [HC70, Lemma 45]). Furthermore, it turns out that $\phi_{\sigma, \xi}$ is a cuspidal function in the sense of Arthur (see [Art93, p.130]).

We give a relationship between the orbital integral of $\phi_{\sigma, \xi}^{\omega}$ and the Harish-Chandra character $\Theta_{\sigma}$ (defined below) over the elliptic regular semi-simple set $M(F)^{\text {ell }}$.

Definition 3.11. (Harish-Chandra, [HC81, p.96]) For any $\pi \in \operatorname{Irr}(M(F))$, there exists a unique locally constant function on $M(F)^{\text {reg }}$ which is invariant under conjugation by $M(F)$ such that for all $h \in C_{c}^{\infty}(M(F))$,

$$
\operatorname{trace}(\pi)(h)=\int_{M(F)^{\mathrm{reg}}} h(m) \Theta_{\pi}(m) d m
$$

with $d m$ a Haar measure on $M(F)^{\text {reg }}$. We call $\Theta_{\pi}$, the Harish-Chandra character of $\sigma$.
We note that the distribution character $\operatorname{trace}(\pi)$ is dependent upon the choice of Haar measure $d m$, but the Harish-Chandra character $\Theta_{\pi}$ is not. Furthermore, Definition 3.11stems from a theorem of Harish-Chandra, which proves the existence and uniqueness (see [HC99] for details).

We present the following lemma to state Proposition 3.13
Lemma 3.12. For any $\sigma \in \Pi_{\mathrm{disc}}(M(F), \omega)$, the set $\Omega(\sigma) \cap \Pi_{\mathrm{disc}}(M(F), \omega)$ is finite.
Proof. Let $\pi \in \Pi_{\text {disc }}(M(F), \omega)$ be given such that $\pi \simeq \sigma \otimes \psi$ for some $\psi \in \Psi(M)$. Since both central characters of $\sigma$ and $\pi$ are the same as $\omega$, the restriction $\left.\psi\right|_{Z_{M}(F)}$ of $\psi$ to $Z_{M}(F)$ is trivial. The set $\Omega(\sigma) \cap \Pi_{\text {disc }}(M(F), \omega)$ is a subset of

$$
\begin{equation*}
\left\{\psi \in \Psi_{u}(M):\left.\psi\right|_{Z_{M}(F)}=\mathbb{1}\right\} \tag{3.5}
\end{equation*}
$$

Note that $\psi$ is already trivial on $M(F)^{1}$. Since the index $\left[M(F): Z_{M}(F) M(F)^{1}\right]$ is finite from Remark 2.4, there are only finitely many characters on $M(F)$ whose restriction to $Z_{M}(F) M(F)^{1}$ is trivial. Thus the set (3.5) is finite, which implies that the set $\Omega(\sigma) \cap \Pi_{\mathrm{disc}}(M(F), \omega)$ is finite.

Proposition 3.13 (Relationship between $\phi_{\sigma, \xi}$ and $\left.\Theta_{\sigma}\right)$. Let $\sigma \in \Pi_{\text {disc }}(M(F), \omega)$ be given, and let $\xi$ be $a$ regular function on $\Omega(\sigma)$. Suppose that $\xi(z)$ vanishes on $\Omega(\sigma) \cap \Pi_{\text {disc }}(M(F), \omega)$ unless $z \simeq \sigma$. Then we have

$$
\begin{equation*}
O_{\gamma}^{M(F)}\left(\phi_{\sigma, \xi}^{\omega}\right)=\xi(\sigma) \overline{\Theta_{\sigma}(\gamma)} \tag{3.6}
\end{equation*}
$$

for every $\gamma \in M(F)^{\mathrm{ell}}$. Here the bar ${ }^{-}$means the complex conjugation.
Remark 3.14. The orbital integral in the left-hand side is computed with respect to the Haar measure $d x$ in Definition (3.2). Changing $d x$ to $c d x$ for some non-zero constant $c$, we then get $c^{-1} \phi_{\sigma, \xi}$ from Proposition 3.6 in place of $\phi_{\sigma, \xi}$. Thus the left-hand side is independent of choice of Haar measure, as the right-hand side should be. Note that the right-hand side depends only on $\xi$ and $\sigma$.

Proof of Proposition 3.13. For any matrix coefficient $h_{\sigma}^{\omega}$ of $\sigma$, from the proof of Clo91, Proposition 6], there exists $\widetilde{h_{\sigma}^{\omega}} \in C_{c}^{\infty}\left(M(F), \omega^{-1}\right)$ such that

$$
\begin{equation*}
O_{\gamma}^{M(F)}\left(\widetilde{h_{\sigma}^{\omega}}\right)=O_{\gamma}^{M(F)}\left(h_{\sigma}^{\omega}\right), \quad \forall \gamma \in M(F) \tag{3.7}
\end{equation*}
$$

We recall the Weyl integration formula (cf. DKV84, A.3.f] and [Kot05, Section 7]). For any function $h^{\omega} \in C_{c}^{\infty}\left(M(F), \omega^{-1}\right)$ and any $\pi \in \Pi_{\text {temp }}(M(F), \omega)$,

$$
\operatorname{trace}(\pi)\left(h^{\omega}\right)=\sum_{T}\left|W_{T}\right|^{-1} \int_{Z_{M}(F) \backslash T(F)^{\mathrm{reg}}}\left|D_{M}(t)\right| O_{\gamma}^{M(F)}\left(h^{w}\right) \Theta_{\pi}(t) d t
$$

where the sum is taken over $M(F)$-conjugacy classes of maximal $F$-tori $T$ in $M, W_{T}:=N_{M}(T) / Z_{M}(T)$, $T(F)^{\mathrm{reg}}:=M(F)^{\mathrm{reg}} \cap T(F), D_{M}(t):=\left.\operatorname{det}(1-a d(t))\right|_{\operatorname{Lie}(M) / \operatorname{Lie}(T)}$, and $d t$ is a Haar measure on $Z_{M}(F) \backslash T(F)^{\mathrm{reg}}$. From (3.7) and the Weyl integration formula, we deduce that

$$
\begin{equation*}
\operatorname{trace}(\pi)\left(\widetilde{h_{\sigma}^{\omega}}\right)=\operatorname{trace}(\pi)\left(h_{\sigma}^{\omega}\right) \tag{3.8}
\end{equation*}
$$

for any $\pi \in \Pi_{\text {temp }}(M(F), \omega)$. Moreover, it is well-known [DKV84, Proposition A.3.g] that

$$
\operatorname{trace}(\pi)\left(h_{\sigma}^{\omega}\right)=\left\{\begin{array}{cl}
\frac{h_{\sigma}^{\omega}(1)}{d_{M}(\sigma)}, & \text { if } \pi \simeq \sigma  \tag{3.9}\\
0, & \text { otherwise }
\end{array}\right.
$$

Here $d_{M}(\sigma)$ is the formal degree. We also recall from [DVV84, Proposition A.3.e.2)] that for all $\gamma \in M(F)^{\text {reg }}$, we have

$$
O_{\gamma}^{M(F)}\left(h_{\sigma}^{\omega}\right)= \begin{cases}\frac{h_{\sigma}^{\omega}(1)}{d_{M}(\sigma)} \overline{\Theta_{\sigma}(\gamma)}, & \text { if } \gamma \in M(F)^{\mathrm{ell}}  \tag{3.10}\\ 0, & \text { if } \gamma \in M(F)^{\mathrm{reg}} \backslash M(F)^{\mathrm{ell}}\end{cases}
$$

For any given regular function $\xi$ on $\Omega(\sigma)$, we choose a matrix coefficient $h_{\sigma}^{\omega}$ of $\sigma$ such that

$$
\begin{equation*}
h_{\sigma}^{\omega}(1)=\xi(\sigma) d_{M}(\sigma) \tag{3.11}
\end{equation*}
$$

It then follows from (3.7) and (3.10) that

$$
O_{\gamma}^{M(F)}\left(\widetilde{h_{\sigma}^{\omega}}\right)=\xi(\sigma) \overline{\Theta_{\sigma}(\gamma)}
$$

for all $\gamma \in M(F)^{\text {ell }}$. We also have the following.
Lemma 3.15. For any $\pi \in \Pi_{\text {temp }}(M(F), \omega)$,

$$
\operatorname{trace}(\pi)\left(\phi_{\sigma, \xi}^{\omega}\right)=\operatorname{trace}(\pi)\left(\widetilde{h_{\sigma}^{\omega}}\right)
$$

Proof of Lemma 3.15. Since $\xi(z)$ vanishes on $\Omega(\sigma) \cap \Pi_{\text {disc }}(M(F), \omega)$ unless $z \simeq \sigma$, one sees from Theorem 3.6 that for any $\pi \in \Pi_{\text {temp }}(M(F), \omega)$,

$$
\operatorname{trace}(\pi)\left(\phi_{\sigma, \xi}^{\omega}\right)=\left\{\begin{array}{cl}
\xi(\sigma), & \text { if } \pi \simeq \sigma  \tag{3.12}\\
0, & \text { otherwise }
\end{array}\right.
$$

Therefore, since $h_{\sigma}^{\omega}(1)=\xi(\sigma) d_{M}(\sigma)$, the lemma follows from (3.8) and (3.9).

Continuing with the proof of Proposition 3.13, for given $h^{\omega} \in C_{c}^{\infty}\left(M(F), \omega^{-1}\right)$, it is well-known that

$$
\operatorname{trace}(\pi)\left(h^{\omega}\right)=0, \forall \pi \in \Pi_{\text {temp }}(M(F), \omega) \Longrightarrow O_{\gamma}^{M(F)}\left(h^{\omega}\right)=0, \forall \gamma \in M(F)^{\mathrm{reg}}
$$

(see DKV84, A.2.b]). From Lemma 3.15 we have

$$
O_{\gamma}^{M(F)}\left(\phi_{\sigma, \xi}^{\omega}\right)=O_{\gamma}^{M(F)}\left(\widetilde{h_{\sigma}^{\omega}}\right)
$$

for all $\gamma \in M(F)^{\text {reg }}$. Hence, the proof of Proposition 3.13 is complete.
Remark 3.16. From (3.11), we note that the value $\xi(\sigma)$ in (3.6) must be determined by both $h_{\sigma}^{\omega}(1)$ and $d_{M}(\sigma)$.

We provide a relationship between a generalized pseudo-coefficient and a pseudo-coefficient of $\sigma$.
Definition 3.17. (DKV84, A.4]) For $\delta \in \Pi_{\text {disc }}(M(F), \omega)$, we say a function $\phi_{\delta}^{\omega} \in C_{c}^{\infty}\left(M(F), \omega^{-1}\right)$ is $a$ pseudo-coefficient of $\delta$ if for $\pi \in \Pi_{\text {temp }}(M(F), \omega)$,

$$
\operatorname{trace}(\pi)\left(\phi_{\delta}^{\omega}\right)= \begin{cases}1, & \text { if } \pi \simeq \delta \\ 0, & \text { otherwise }\end{cases}
$$

Proposition 3.18. (Clo91, Propositions 5(ii) and 6]) For $\delta \in \Pi_{\text {disc }}(M(F), \omega)$, there exists a pseudocoefficient $\phi_{\delta}^{\omega} \in C_{c}^{\infty}\left(M(F), \omega^{-1}\right)$ satisfying:

$$
O_{\gamma}^{M(F)}\left(\phi_{\delta}^{\omega}\right)=\overline{\Theta_{\delta}(\gamma)}, \quad \forall \gamma \in M(F)^{\mathrm{ell}}
$$

Proof. By letting the matrix coefficient $\phi_{\delta}^{\omega}(1)=d_{M}(\delta)$ (the formal degree of $\delta$ ) in the proof of Clo91, Proposition 6], we have a pseudo-coefficient $\phi_{\delta}^{\omega}$ whose orbital integral is the same as that of the matrix coefficient $h_{\delta}^{\omega}$ in the proof of Proposition 3.13. Then, [Clo91, Proposition 5(ii)] implies Proposition 3.18,

Proposition 3.19. Let $\xi$ be as in Proposition 3.13. Suppose $\xi(\sigma)=1$. Then, the projection $\phi_{\sigma, \xi}^{\omega} \in$ $C_{c}^{\infty}\left(M(F), \omega^{-1}\right)$ is a pseudo-coefficient of $\sigma$.

Proof. This is a consequence of (3.12) with $\xi(\sigma)=1$.
3.3. Lifting $\phi_{\sigma, \xi} \in C_{c}^{\infty}(M(F))$ to $f_{\sigma, \xi} \in C_{c}^{\infty}(G(F))$. We lift the generalized pseudo-coefficient $\phi_{\sigma, \xi} \in$ $C_{c}^{\infty}(M(F))$ to $f_{\sigma, \xi} \in C_{c}^{\infty}(G(F))$ and discuss a relationship between $\phi_{\sigma, \xi}$ and $f_{\sigma, \xi}$. Following the notation of BDK86, given a standard $F$-parabolic subgroup $P=M N$ of $G$, the normalized (twisted by $\delta_{P}^{-1 / 2}$ ) Jacquet functor $r_{M, G}(\Pi)$ for $\Pi \in \operatorname{Irr}(G(F))$ defines the morphism $r_{M, G}: R(G) \rightarrow R(M)$. Let $R^{*}(G)$ (resp., $R^{*}(M)$ ) be the space of all linear functionals on $R(G)$ (resp., $R(M)$ ). By $i_{G, M}^{*}: R^{*}(G) \rightarrow R^{*}(M)$ and $r_{M, G}^{*}: R^{*}(M) \rightarrow R^{*}(G)$ we denote morphisms adjoint to $i_{G, M}$ and $r_{M, G}$, respectively. Namely, $i_{G, M}^{*}(\mathrm{f})=$ $\mathrm{f}\left(i_{G, M}(\pi)\right)$ for $\mathrm{f} \in R^{*}(G)$ and $\pi \in R(M)$, and $r_{M, G}^{*}(\mathrm{~h})=\mathrm{h}\left(r_{M, G}(\Pi)\right)$ for $\mathrm{h} \in R^{*}(M)$ and $\Pi \in R(G)$. We set $\mathcal{F}_{t r}(G)=\left\{\operatorname{trace}(\Pi)(f) \mid \Pi \in R(G), f \in C_{c}^{\infty}(G(F))\right\}$ and $\mathcal{F}_{t r}(M)=\{\operatorname{trace}(\pi)(h) \mid \pi \in R(M), h \in$ $\left.C_{c}^{\infty}(M(F))\right\}$.

Proposition 3.20. For any generalized pseudo-coefficient $\phi_{\sigma, \xi} \in C_{c}^{\infty}(M(F))$, there exists $f_{\sigma, \xi} \in C_{c}^{\infty}(G(F))$ such that

$$
\begin{equation*}
\operatorname{trace}(\Pi)\left(f_{\sigma, \xi}\right)=\operatorname{trace}\left(r_{M, G}(\Pi)\right)\left(\phi_{\sigma, \xi}\right), \quad \forall \Pi \in R(G) \tag{3.13}
\end{equation*}
$$

Moreover, the function $f_{\sigma, \xi} \in C_{c}^{\infty}(G(F))$ is uniquely determined modulo $J_{G}$ (cf. Remark 3.7).
Proof. The first part is a consequence of the fact ( $\overline{\mathrm{BDK} 86}$, Proposition 3.2(ii)]) that

$$
r_{M, G}^{*}\left(\mathcal{F}_{t r}(M)\right) \subset \mathcal{F}_{t r}(G)
$$

The uniqueness is due to the following short exact sequence ([BDK86, Remark 1.2] and [Kaz86, Theorem 0])

$$
0 \longrightarrow J_{G} \longrightarrow C_{c}^{\infty}(G(F)) \xrightarrow{\text { trace }} \mathcal{F}_{t r}(G) \longrightarrow 0
$$

where trace maps $f \mapsto(\Pi \mapsto \operatorname{trace}(\Pi)(f))$ from $C_{c}^{\infty}(G(F))$ onto $\mathcal{F}_{t r}(G)$.

For any standard $F$-Levi subgroups $M$ and $L$, we set

$$
W(L, M):=\left\{w \in W_{G}: w L w^{-1}=M\right\} .
$$

We say that $L$ and $M$ are associate if $W(L, M)$ is non-empty. When $L$ and $M$ are associate, it turns out that $W_{M} \cdot W(L, M) \cdot W_{L}=W(L, M)$ since the element $w_{M} w w_{L}$ sends $L$ to $M$ for $w_{M} \in W_{M}, w \in W(L, M)$ and $w_{L} \in W_{L}$. Furthermore, given any standard $F$-Levi subgroups $L$ and $M$ corresponding to $\vartheta$ and $\theta$, respectively, we note from [BZ77, pp.448-449] that

$$
\begin{equation*}
W_{M} \backslash W(L, M) / W_{L}=W(L, M) / W_{L} \simeq W(\vartheta, \theta) \tag{3.14}
\end{equation*}
$$

where $W(\vartheta, \theta):=\left\{w \in W_{G}: w(\vartheta)=\theta\right\}$. For any $\pi \in \Pi_{\text {temp }}(L(F))$ and $w \in W(L, M)$, we denote by ${ }^{w} \pi$ the representation of $M(F)$ such that ${ }^{w} \pi(m):=\pi\left(w^{-1} m w\right)$ for $m \in M(F)$. It is clear that ${ }^{w} \pi \in \Pi_{\text {temp }}(M(F))$.

Proposition 3.21. For any standard $F$-Levi subgroup $L$ of $G$ and $\pi \in \Pi_{\text {temp }}(L(F))$,

$$
\operatorname{trace}\left(i_{G, L} \pi\right)\left(f_{\sigma, \xi}\right)=\left\{\begin{array}{cl}
\sum_{w \in W(\vartheta, \theta)} \operatorname{trace}\left({ }^{w} \pi\right)\left(\phi_{\sigma, \xi}\right), & \text { if } L \text { and } M \text { are associate } \\
0, & \text { otherwise } .
\end{array}\right.
$$

Proof. We first recall from BZ77, Lemma 2.11(a) and 2.12] and BDK86, Lemma 5.4(ii)] that

$$
r_{M, G} \circ i_{G, L}(\pi)=\sum_{w \in W_{M} \backslash W_{G} / W_{L}} i_{M, M_{w}} \circ w \circ r_{L_{w}, L}(\pi),
$$

where $M_{w}=M \cap w L w^{-1}$ and $L_{w}=w^{-1} M w \cap L$. Then (3.13) says that for any $\pi \in \operatorname{Irr}(L(F))$,

$$
\begin{aligned}
\operatorname{trace}\left(i_{G, L} \pi\right)\left(f_{\sigma, \xi}\right) & =\operatorname{trace}\left(r_{M, G} \circ i_{G, L}(\pi)\right)\left(\phi_{\sigma, \xi}\right) \\
& =\sum_{w \in W_{M} \backslash W_{G} / W_{L}} \operatorname{trace}\left(i_{M, M_{w}} \circ w \circ r_{L_{w}, L}(\pi)\right)\left(\phi_{\sigma, \xi}\right) .
\end{aligned}
$$

By (3.4), it turns out that the sum runs over $w \in W(L, M) / W_{L}$ only when $L$ and $M$ are associate. Otherwise, the group $M_{w}=M \cap w L w^{-1}$ has to be proper, so the sum vanishes by the cuspidal property of $\phi_{\sigma, \xi}$ (see Proposition 3.9). When $L$ and $M$ are associate, we note that $i_{M, M_{w}} \circ w \circ r_{L_{w}, L}(\pi)={ }^{w} \pi$ and $W(L, M) / W_{L} \simeq$ $W(\vartheta, \theta)$. Thus the proof is complete.

Now we consider the case that $L=M$, that is, $\vartheta=\theta$. Write $W(\theta, \theta):=\left\{w \in W_{G}: w(\theta)=\theta\right\}$. We say that $M$ is self-associate if $W(\theta, \theta) \supsetneqq\{1\}$. Otherwise, that is, if $W(\theta, \theta)=\{1\}, M$ is called non self-associate. We note that

$$
\begin{equation*}
\operatorname{trace}\left(i_{G, M} \pi\right)\left(f_{\sigma, \xi}\right)=\sum_{w \in W(\theta, \theta)}{ }^{w} \xi(\pi) \tag{3.15}
\end{equation*}
$$

Here the action ${ }^{w} \xi(\pi)$ of $W_{M}$ on a regular function $\xi$ is naturally defined as $\xi\left({ }^{w} \pi\right)$ (cf. Remark 2.11). Then we have the following theorem which is a consequence of Proposition 3.21.

Theorem 3.22. Let $M$ be an $F$-Levi subgroup of $G$ corresponding to $\theta \subset \Delta$, and let $\xi$ be a $W(\theta, \theta)$-invariant regular function on $\Omega(\sigma)$ (see Remarks 2.14 and (2.16). For every $\gamma \in M(F)^{\text {reg }}$, we have

$$
\left|D_{G / M}(\gamma)\right|^{1 / 2} O_{\gamma}^{G(F)}\left(f_{\sigma, \xi}\right)=O_{\gamma}^{M(F)}\left(\bar{f}_{\sigma, \xi}^{(P)}\right)=O_{\gamma}^{M(F)}\left(|W(\theta, \theta)| \cdot \phi_{\sigma, \xi}\right)
$$

where $D_{G / M}(\gamma)=\left.\operatorname{det}(1-\operatorname{ad}(\gamma))\right|_{\operatorname{Lie}(G) / \operatorname{Lie}(M)}$.
Proof. The first equality holds in general due to (3.3) in Section 3.2. We shall check the second equality.
When $M$ is not self-associate, $|W(\theta, \theta)|=1$. In this case, we do not need the condition of the $W(\theta, \theta)$ invariance. Thus the second equality is a consequence of [Kaz86, Theorem 0] and the fact that for any $\pi \in \operatorname{Irr}(M(F))$,

$$
\begin{aligned}
\operatorname{trace}(\pi)\left(\bar{f}_{\sigma, \xi}^{(P)}\right) & =\operatorname{trace}\left(i_{G, M} \pi\right)\left(f_{\sigma, \xi}\right) \\
& \stackrel{(3.15}{=} \operatorname{trace}(\pi)\left(\phi_{\sigma, \xi}\right)
\end{aligned}
$$

When $M$ is self-associate, we note that $|W(\theta, \theta)| \geq 2$. Since $\xi$ is a $W(\theta, \theta)$-invariant by hypothesis, (3.15) implies that

$$
\operatorname{trace}(\pi)\left(\bar{f}_{\sigma, \xi}^{(P)}\right)=|W(\theta, \theta)| \cdot \operatorname{trace}(\pi)\left(\phi_{\sigma, \xi}\right)
$$

for any $\pi \in \operatorname{Irr}(M(F))$. Therefore, we have from Kaz86, Theorem 0]

$$
O_{\gamma}^{M(F)}\left(\bar{f}_{\sigma, \xi}^{(P)}\right)=O_{\gamma}^{M(F)}\left(|W(\theta, \theta)| \cdot \phi_{\sigma, \xi}\right) .
$$

This completes the proof.
Remark 3.23. In the case that $|W(\theta, \theta)| \geq 2$, given any regular function $\xi_{o}$ on $\Omega(\sigma)$ and any $w \in W(\theta, \theta)$, we set

$$
{ }^{w} \xi_{o}(z)={ }^{w} \xi_{o}(\sigma \otimes \psi):=\xi_{o}\left({ }^{w} \sigma \otimes{ }^{w} \psi\right) .
$$

Then, ${ }^{w} \xi_{o}(z)$ is clearly a regular function on $\Omega(\sigma)$. It turns out that

$$
\xi(z):=\frac{1}{|W(\theta, \theta)|} \sum_{w \in W(\theta, \theta)}{ }^{w} \xi_{o}(z)
$$

must be a $W(\theta, \theta)$-invariant regular function on $\Omega(\sigma)$. It thus follows that there is always a $W(\theta, \theta)$-invariant regular function on $\Psi(M)$ (cf. Remark 2.16).
3.4. Application to the Plancherel formula. Given a discrete series representation $\sigma \in \Pi_{\text {disc }}(M(F))$ and a regular function $\xi$ on $\Omega(\sigma)$, by means of the Plancherel formula, we see a relationship between the value $\phi_{\sigma, \xi}(1)$ and the formal degree $d_{M}(\sigma)$. We also express the value $f_{\sigma, \xi}(1)$ in terms of $\xi$, the formal degree of $\sigma$, and the Plancherel measure on $\Omega(\sigma)$.

Proposition 3.24 (Relationship between $\phi_{\sigma, \xi}(1)$ and $\left.d_{M}(\sigma)\right)$. We have

$$
\begin{equation*}
\phi_{\sigma, \xi}(1)=d_{M}(\sigma) \int_{\psi \in \Psi_{u}(M) / \operatorname{Stab}_{\Psi}(\sigma)} \xi(\sigma \otimes \psi) d \psi \tag{3.16}
\end{equation*}
$$

Proof. We apply the generalized pseudo-coefficient $\phi_{\sigma, \xi}$ to the Plancherel formula (Theorem 2.3). Since $G=M$, we have $a(G \mid M)=1$ and $\mu_{M}(\pi)=1$ for any $\pi \in \Pi_{\text {disc }}(M(F))$. By the construction of $\phi_{\sigma, \xi}$ in Theorem 3.6] we have

$$
\operatorname{trace}(\pi)\left(\phi_{\sigma, \xi}\right)=0
$$

unless $\pi \in \Omega(\sigma)$, in which case $\operatorname{trace}(\pi)\left(\phi_{\sigma, \xi}\right)=\xi(\pi)$. Note that $\pi \in \Omega(\sigma)$ is of the form $\sigma \otimes \psi$ with $\psi \in \Psi_{u}(M)$, and $d_{M}(\sigma \otimes \psi)=d_{M}(\sigma)$ for any unitary character $\psi$ of $M(F)$. From the Plancherel formula (Theorem 2.3), we then have

$$
\phi_{\sigma, \xi}(1)=d_{M}(\sigma) \int_{\pi \in \Pi_{\mathrm{disc}}(M(F)) \cap \Omega(\sigma)} \xi(\pi) d \pi
$$

Since $\Pi_{\text {disc }}(M(F)) \cap \Omega(\sigma) \simeq \Psi_{u}(M) / \operatorname{Stab}_{\Psi}(\sigma)$, we have (3.16).
Remark 3.25. If $\xi=1$ so that $\phi_{\sigma, \xi}^{\omega}$ becomes a pseudo-coefficient (Proposition 3.19), the right-hand side of (3.16) becomes $d_{M}(\sigma) \int_{\psi \in \Psi_{u}(M) / \operatorname{Stab}_{\Psi}(\sigma)} d \psi$. By choosing a suitable measure $d \psi$ on $\Psi_{u}(M)$ so that $\int_{\psi \in \Psi_{u}(M) / \operatorname{Stab}_{\Psi}(\sigma)} d \psi=1$ (see Section 2.2), we deduce

$$
\begin{equation*}
\phi_{\sigma, \xi}(1)=d_{M}(\sigma) \tag{3.17}
\end{equation*}
$$

If the center $Z_{M}$ is anisotropic over $F$, so that $\Psi(M)$ is trivial and the regular function $\xi$ on $\Omega(\sigma)$ equals just 1 , then (3.17) immediately follows. This is an analogue of the well-known property of a pseudo-coefficient $\phi_{\sigma, \xi}^{\omega}(1)=d_{M}(\sigma)$ (for example, see [DKV84, A.4]).

Recall the notation $\mu_{M}(\sigma \otimes \psi)$ for the Plancherel measure from Remark 2.8. We then have the following proposition.

Proposition 3.26 (Relationship between $f_{\sigma, \xi}(1)$ and $\mu_{M}(\sigma \otimes \psi)$ ). Let $M$ be an $F$-Levi subgroup of $G$ corresponding to $\theta \subset \Delta$, and let $\xi$ be a $W(\theta, \theta)$-invariant regular function on $\Omega(\sigma)$. Then we have

$$
f_{\sigma, \xi}(1)=a(G \mid M) d_{M}(\sigma)|W(\theta, \theta)| \int_{\psi \in \Psi_{u}(M) / \operatorname{Stab}_{\Psi}(\sigma)} \mu_{M}(\sigma \otimes \psi) \xi(\sigma \otimes \psi) d \psi
$$

Proof. Similar to the proof of Proposition 3.24, we apply $f_{\sigma, \xi}$ to the Plancherel formula (Theorem 2.3). Proposition 3.21 then yields

$$
\begin{equation*}
f_{\sigma, \xi}(1)=a(G \mid M) \int_{\pi \in \Pi_{\mathrm{disc}}(M(F))} d_{M}(\pi) \mu_{M}(\pi) \sum_{w \in W(\theta, \theta)} \operatorname{trace}\left({ }^{w} \pi\right)\left(\phi_{\sigma, \xi}\right) d \pi \tag{3.18}
\end{equation*}
$$

Due to Theorem 3.6, the isomorphism $\Pi_{\text {disc }}(M(F)) \cap \Omega(\sigma) \simeq \Psi_{u}(M) / \operatorname{Stab}_{\Psi}(\sigma)$, and the assumption that $\xi$ is $W(\theta, \theta)$-invariant, the right-hand side of (3.18) equals

$$
a(G \mid M)|W(\theta, \theta)| \int_{\psi \in \Psi_{u}(M) / \operatorname{Stab}_{\Psi}(\sigma)} d_{M}(\sigma \otimes \psi) \mu_{M}(\sigma \otimes \psi) \xi(\sigma \otimes \psi) d \psi
$$

Again, using the fact that $d_{M}(\sigma \otimes \psi)=d_{M}(\sigma)$ for any unitary character $\psi$ of $M(F)$, the proof is complete.
