# A Berry-Esseen theorem for Pitman's $\alpha$-diversity

#### Abstract

This paper contributes to the study of the random number $K_{n}$ of blocks in the random partition of $\{1, \ldots, n\}$ induced by random sampling from the two parameter Poisson-Dirichlet process. For any $\alpha \in(0,1)$ and $\theta>-\alpha$ Pitman [24] showed that $n^{-\alpha} K_{n} \xrightarrow{\text { a.s. }} S_{\alpha, \theta}$ as $n \rightarrow+\infty$, where $S_{\alpha, \theta}$, is known as Pitman's $\alpha$-diversity. Our main result is a Berry-Esseen theorem for Pitman's $\alpha$-diversity $S_{\alpha, \theta}$, namely we show that $$
\sup _{x \geq 0}\left|\mathrm{P}\left[\frac{K_{n}}{n^{\alpha}} \leq x\right]-\mathrm{P}\left[S_{\alpha, \theta} \leq x\right]\right| \leq \frac{C(\alpha, \theta)}{n^{\alpha}}
$$ holds for every $n \in \mathbb{N}$ with an explicit constant term $C(\alpha, \theta)$, for $\alpha \in(0,1)$ and $\theta>0$. The proof relies on three intermediate novel results which are of independent interest: i) a representation of the law of $K_{n}$ as a compound distribution; ii) a quantitative version of Laplace's approximation method; iii) a refined quantitative bound for Poisson approximation. An application of our Berry-Esseen theorem is presented in the context of Bayesian nonparametric inference for species sampling problems.


## 1 Introduction

The two parameter Poisson-Dirichlet process is a discrete (almost surely) random probability measure introduced by Perman et al. [22]. For any $\alpha \in[0,1)$ and $\theta>-\alpha$, let $\left\{V_{i}\right\}_{i \geq 1}$ be independent random variables such that $V_{i}$ is distributed as a Beta distribution with parameter $(1-\alpha, \theta+i \alpha)$, for $i \geq 1$. If $P_{1}:=V_{1}$ and $P_{i}:=V_{i} \prod_{1 \leq j \leq i-1}\left(1-V_{j}\right)$ for $i \geq 2$, then

$\sum_{i \geq 1} P_{i}=1$ almost surely. The two parameter Poisson-Dirichlet process is defined as the random probability measure $\tilde{\mathfrak{p}}_{\alpha, \theta}$ on ( $\mathbb{N}, 2^{\mathbb{N}}$ ) such that $\tilde{\mathfrak{p}}_{\alpha, \theta}(\{i\})=P_{i}$ for all $i \in \mathbb{N}$. A random sample $\left(X_{1}, \ldots, X_{n}\right)$ from $\tilde{\mathfrak{p}}_{\alpha, \theta}$ is the first $n$-segment of the $\mathbb{N}$-valued exchangeable sequence $\left\{X_{i}\right\}_{i \geq 1}$ having $\tilde{\mathfrak{p}}_{\alpha, \theta}$ as directing measure. Due to the discreteness of $\tilde{\mathfrak{p}}_{\alpha, \theta},\left(X_{1}, \ldots, X_{n}\right)$ induces a random partition $\Pi_{n}$ of $\{1, \ldots, n\}$ by means of the (random) equivalence relation $i \sim j \Longleftrightarrow X_{i}=X_{j}$ (Aldous [2] and Pitman [24]). Let $K_{n}:=K_{n}\left(X_{1}, \ldots, X_{n}\right)$, where $K_{n}\left(X_{1}, \ldots, X_{n}\right)$ is the (random) number of blocks of $\Pi_{n}$, i.e., the random number of distinct elements in $\left(X_{1}, \ldots, X_{n}\right)$. Let $N_{j, n}:=N_{j, n}\left(X_{1}, \ldots, X_{n}\right)$, where $N_{j, n}\left(X_{1}, \ldots, X_{n}\right)$ is the (random) size of the $j$-th block of $\Pi_{n}$. If $\mathbf{N}_{n}:=\left(N_{1, n}, \ldots, N_{K_{n}, n}\right)$, then Pitman [23] (see also Lijoi et al. [17]) showed that

\mathrm{P}\left[K_{n}=j, \mathbf{N}_{n}=\left(n_{1}, \ldots, n_{j}\right)\right]=\frac{1}{j!}\binom{n}{n_{1}, \ldots, n_{j}} \frac{[\theta]_{(j, \alpha)}}{[\theta]_{(n)}} \prod_{i=1}^{j}[1-\alpha]_{\left(n_{i}-1\right)}, \tag{1}
\end{equation*}
$$

for any $j \in\{1, \ldots, n\}$ and $\left(n_{1}, \ldots, n_{j}\right) \in \mathbb{N}^{j}$ such that $\sum_{1 \leq i \leq j} n_{i}=n$, where $[x]_{(n, a)}$ denotes the rising factorial of $x$ of order $n$ and increment $a$, i.e. $\left.{ }^{x}\right]_{(n, a)}:=\prod_{0 \leq i \leq n-1}(x+i a)$, and $[x]_{(n)}:=[x]_{(n, 1)}$. Equation (1) is referred to as Ewens-Pitman sampling formula. The two parameter Poisson-Dirichlet process plays a fundamental role in a variety of research areas, such as mathematical population genetics, Bayesian nonparametric statistics, statistical machine learning, excursion theory, combinatorics and statistical physics. We refer to Pitman [24] and Crane [4] for a comprehensive treatment.

There have been several studies on the large $n$ behaviour of $K_{n}$. For $\alpha=0$ and $\theta>0, \tilde{\mathfrak{p}}_{0, \theta}$ reduces to the Dirichlet process and $K_{n}=\sum_{1 \leq i \leq n} Z_{i}$ where the $Z_{i}$ 's are independent Bernoulli random variables with parameter $\theta /(\theta+i-1)$, for $i=1, \ldots, n$. Korwar and Hollander [13] showed that $K_{n} / \log (n)$ converges almost surely to $\theta$ as $n \rightarrow+\infty$. Also, it follows from Lindberg's theorem that $\left(K_{n}-\theta \log (n)\right) / \sqrt{\theta \log (n)}$ converges weakly to a standard Gaussian random variable as $n \rightarrow+\infty$. For $\alpha \in(0,1)$ the large $n$ Gaussian limit for $K_{n}$ no longer holds. In particular, Theorem 3.8 in Pitman [24] exploited a martingale convergence argument to show that

\frac{K_{n}}{n^{\alpha}} \xrightarrow{\text { a.s. }} S_{\alpha, \theta} \tag{2}
\end{equation*}

as $n \rightarrow+\infty$, where $0<S_{\alpha, \theta}<+\infty$ is a random variable distributed as a scaled Mittag-Leffler distribution. Precisely, let $\Gamma$ stand for the Gamma
function, and let

\begin{equation*}
f_{\alpha}(z)=\frac{1}{\pi} \sum_{j \geq 1} \frac{(-1)^{j+1}}{j!} \sin (\pi \alpha j) \frac{\Gamma(\alpha j+1)}{z^{\alpha j+1}} \mathbb{1}\{z>0\}, \tag{3}
\end{equation*}
$$

for $\alpha \in(0,1)$, be the positive $\alpha$-stable density function. Then, $S_{\alpha, \theta}$ has density function

$$
\begin{equation*}
f_{S_{\alpha, \theta}}(s)=\frac{\Gamma(\theta+1)}{\alpha \Gamma(\theta / \alpha+1)} s^{\frac{\theta-1}{\alpha}-1} f_{\alpha}\left(s^{-1 / \alpha}\right) \mathbb{1}\{s>0\} . \tag{4}
\end{equation*}
$$

One may easily generate random variates from $S_{\alpha, \theta}$ (e.g., Devroye [5]). For $\theta=0$, equation (4) reduces to the Mittag-Leffler density function. For $\alpha \in(0,1)$ and $\theta>-\alpha$, the random variable $S_{\alpha, \theta}$ is referred to as Pitman's $\alpha$-diversity. Large and moderate deviations for $K_{n}$ are established in Feng and Hoppe [10] and Favaro et al. [8], whereas a concentration inequality for $K_{n}$ is obtained in Pereira et al. [21] by relying on concentration inequalities for martingales.

In this paper, we formulate a Berry-Esseen theorem for Pitman's $\alpha$ diversity $S_{\alpha, \theta}$. In particular, let $\mathrm{F}_{n}$ and $\mathrm{F}_{\alpha, \theta}$ stand for the distribution functions of $K_{n} / n^{\alpha}$ and $S_{\alpha, \theta}$, respectively, i.e. $\mathrm{F}_{n}(x):=\mathrm{P}\left[K_{n} / n^{\alpha} \leq x\right]$ and $\mathrm{F}_{\alpha, \theta}(x):=\mathrm{P}\left[S_{\alpha, \theta} \leq x\right]$, for any $x>0$. To measure the discrepancy between $\mathrm{F}_{n}$ and $\mathrm{F}_{\alpha, \theta}$, we consider the Kolmogorov distance which, for any pair of distribution functions $F_{1}$ and $F_{2}$ supported in $[0,+\infty)$, is defined as $\mathrm{d}_{K}\left(\mathrm{~F}_{1} ; \mathrm{F}_{2}\right):=\sup _{x \geq 0}\left|\mathrm{~F}_{1}(x)-\mathrm{F}_{2}(x)\right|$. The next theorem states our BerryEsseen bound.

Theorem 1. For any $\alpha \in(0,1)$ and $\theta>0$, there exists a positive constant $C_{\alpha, \theta}$, depending solely on $\alpha$ and $\theta$, such that $\mathrm{d}_{K}\left(\mathrm{~F}_{n} ; \mathrm{F}_{\alpha, \theta}\right) \leq n^{-\alpha} C_{\alpha, \theta}$ for every $n \in \mathbb{N}$.

Theorem 1 is the first quantitative version of Theorem 3.8 in Pitman [24]. The constant $C_{\alpha, \theta}$ is obtained constructively, and its value can be made explicit by gathering equations displayed in Section 2. The proof of Theorem 1 relies on three intermediate novel results which are of independent interest: i) a probabilistic representation of the distribution of $K_{n}$ as a compound distribution where the latent term is the distribution of the random number of blocks in Poisson compound random partition model, and the mixing term is the law of a scale mixture between Pitman's $\alpha$-diversity and a Gamma random variable; ii) a quantitative version of the asymptotic expansion, in the sense of Poincaré, of a Laplace-type integral; iii) a refined quantitative bound for Poisson approximation which improves results in Hwang [11].

We present an application of Theorem 1 in Bayesian nonparametric inference for species sampling. Consider a population of individuals belonging to an infinite number of species with unknown proportions. Given an initial (observable) random sample of size $n$ from the population, a classical statistical problem is to infer the number $K_{m}^{(n)}$ of hitherto unseen species that would be observed in $m$ additional (unobservable) samples (Orlitsky et al. [20]). A Bayesian approach to this problem was proposed in Lijoi et al. [16], and it relies on the law of $\tilde{\mathfrak{p}}_{\alpha, \theta}$ as a prior distribution for the unknown species composition of the population. That is, the Ewens-Pitman sampling formula (1) models the species composition of the initial (observable) random sample ( $X_{1}, \ldots, X_{n}$ ) from the population, i.e., the number $K_{n}$ of species and their frequencies $\mathbf{N}_{n}$. Lijoi et al. [16] first derived the posterior distribution, given $\left\{K_{n}, \mathbf{N}_{n}\right\}$, of $K_{m}^{(n)}$. Then, Favaro et al. [9] showed that there exists a random variable $S_{\alpha, \theta}(n, j)$, referred to as Pitman's posterior $\alpha$-diversity, such that

\begin{equation*}
\mathrm{P}\left[\frac{K_{m}^{(n)}}{m^{\alpha}} \longrightarrow S_{\alpha, \theta}(n, j) \text { as } m \rightarrow+\infty \mid K_{n}=j, \mathbf{N}_{n}=\left(n_{1}, \ldots, n_{j}\right)\right]=1 \tag{5}
\end{equation*}
$$

holds for any $j \in\{1, \ldots, n\}$ and $\left(n_{1}, \ldots, n_{j}\right) \in \mathbb{N}^{j}$ with $\sum_{1 \leq i \leq j} n_{i}=n$. Also, $\mathrm{P}\left[S_{\alpha, \theta}(n, j) \in \cdot \mid K_{n}=j, \mathbf{N}_{n}=\left(n_{1}, \ldots, n_{j}\right)\right]=\mathrm{P}\left[B_{j+\theta / \alpha, n / \alpha-j} S_{\alpha, \theta+n} \in \cdot\right]$ where, under P: i) $S_{\alpha, \theta+n}$ has a density given by (4); ii) $B_{j+\theta / \alpha, n / \alpha-j}$ is a Beta random variable with parameter ( $j+\theta / \alpha, n / \alpha-j$ ); iii) $S_{\alpha, \theta+n}$ and $B_{j+\theta / \alpha, n / \alpha-j}$ are independent. The importance of (5) is motivated by the fact that the computational burden for evaluating the posterior distribution of $K_{m}^{(n)}$ becomes overwhelming for large $m$. This is common in genomics, where DNA libraries consists of millions of genes. In such a context, (5) has been extensively applied to obtain large $m$ approximated posterior inferences for $K_{m}^{(n)}$ (Favaro et al. [9]). We show that Theorem 1 leads to formulate a Berry-Esseen theorem for Pitman's posterior $\alpha$-diversity, thus quantifying the error in approximating the posterior distribution of $K_{m}^{(n)}$ with the law of $S_{\alpha, \theta}(n, j)$.

The paper is structured as follows. In Section 2 we prove Theorem 1, whereas in Section 3 we state and prove a Berry-Esseen theorem for Pitman's posterior $\alpha$-diversity.

## 2 Proof of Theorem 1

The proof is divided into four main parts, developed in the Subsections 2.1-2.4. Along these subsections, we make use of the notion of probability
generating function (PGF) of a random variable $X$ with values in $\mathbb{N}_{0}:=$ $\{0,1,2, \ldots\}$, i.e. $\mathrm{G}_{X}(s):=\sum_{x \geq 0} \mathrm{P}[X=x] s^{x}$.

### 2.1 A new probabilistic representation for $K_{n}$

Consider a population of individuals containing a random number $N_{\lambda}$ of types, where $N_{\lambda}$ has a Poisson distribution with parameter $\lambda=z\left[1-(1-q)^{\alpha}\right]$, for $\alpha \in(0,1), q \in(0,1)$ and $z>0$. For any $j \in \mathbb{N}$, let $Q_{j}(\alpha, q)$ be the random number of individuals of type $j$ in the population. Assume the $Q_{j}(\alpha, q)$ 's are independent of $N_{\lambda}$ and independent of each other, with the same probability law

$$
\begin{equation*}
\mathrm{P}\left[Q_{1}(\alpha, q)=x\right]=-\frac{1}{\left[1-(1-q)^{\alpha}\right]}\binom{\alpha}{x}(-q)^{x}=\frac{\Gamma(\alpha+1) \sin \pi \alpha}{\pi\left[1-(1-q)^{\alpha}\right]} \frac{\Gamma(x-\alpha)}{x!} q^{x} \tag{6}
\end{equation*}
$$

for any $x \in \mathbb{N}$. In the next lemma we derive the conditional distribution of $N_{\lambda}$ given the size of the random sample $S(\alpha, q, z):=\sum_{j=0}^{N_{\lambda}} Q_{j}(\alpha, q)$, with the proviso that $\mathrm{P}\left[Q_{0}(\alpha, q)=0\right]=1$. This distribution relies on a noteworthy probability distribution $\rho(\cdot ; \alpha, n, z)$ on $\{1, \ldots, n\}$ involving the generalized factorial coefficients, namely $\mathscr{C}(n, k ; \alpha):=\frac{1}{k!} \sum_{i=1}^{k}(-1)^{i}\binom{k}{i}[-i \alpha]_{(n)}$ (Charalambides [3]).

Lemma 1. Let $\left\{Q_{j}(\alpha, q)\right\}_{j \geq 1}$ be i.i.d. random variables distributed according to (6), and define $S(\alpha, q, z):=\sum_{j=0}^{N_{\lambda}} Q_{j}(\alpha, q)$, with the proviso that $\mathrm{P}\left[Q_{0}(\alpha, q)=0\right]=1$. Then, for every $n \in \mathbb{N}$ and $k \in\{1, \ldots, n\}$, it holds

$$
\begin{equation*}
\rho(\{k\} ; \alpha, n, z):=\mathrm{P}\left[N_{\lambda}=k \mid S(\alpha, q, z)=n\right]=\frac{\mathscr{C}(n, k ; \alpha) z^{k}}{\sum_{j=1}^{n} \mathscr{C}(n, j ; \alpha) z^{j}} . \tag{7}
\end{equation*}
$$

Proof of Lemma 1. For fixed $n \in \mathbb{N}$ and $k \in\{1, \ldots, n\}$, one has $\mathrm{P}[S(\alpha, q, z)=$ $\left.n \mid N_{\lambda}=k\right]=\mathrm{P}\left[\sum_{j=1}^{k} Q_{j}(\alpha, q)=n\right]$. By virtue of the binomial series, the PGF G $(\cdot ; k, \alpha, q)$ of $\sum_{j=1}^{k} Q_{j}(\alpha, q)$ reads

$$
\mathrm{G}(s ; k, \alpha, q)=\left\{-\sum_{x=1}^{\infty} \frac{1}{\left[1-(1-q)^{\alpha}\right]}\binom{\alpha}{x}(-s q)^{x}\right\}^{k}=\left[\frac{1-(1-s q)^{\alpha}}{1-(1-q)^{\alpha}}\right]^{k}
$$

for $|s|<1$. Since $\left[1-(1-u)^{\alpha}\right]^{k}=k!\sum_{n \geq k} \mathscr{C}(n, k ; \alpha) \frac{u^{n}}{n!}$ holds whenever $|u|<1$ (see Theorem 8.14 in Charalambides [3]), conclude that

$$
\begin{equation*}
\mathrm{P}\left[S(\alpha, q, z)=n \mid N_{\lambda}=k\right]=\frac{k!}{\left[1-(1-q)^{\alpha}\right]^{\kappa}} \mathscr{C}(n, k ; \alpha) \frac{q^{n}}{n!} \tag{8}
\end{equation*}
$$

for $n \geq k$. Moreover, (8) holds also for $k>n$ since $\mathscr{C}(n, k ; \alpha)=0$. Hence, using the explicit expression of $\mathrm{P}\left[N_{\lambda}=k\right]$, (7) ensues from (8) by means of the Bayes formula.

Let $G_{\tau, \lambda}$ be a Gamma random variable with scale parameter $\lambda>0$ and shape parameter $\tau>0$, and let $\{R(\alpha, n, z)\}_{z>0}$ be a family of random variables such that $\mathrm{P}[R(\alpha, n, z)=k]=\rho(\{k\} ; \alpha, n, z)$, for any $n \in \mathbb{N}, k \in$ $\{1, \ldots, n\}, \alpha \in(0,1)$ and $z>0$.

Proposition 1. For fixed $n \in \mathbb{N}, \alpha \in(0,1)$ and $\theta>-\alpha$, there holds the following (distributional) identity

$$
\begin{equation*}
K_{n} \stackrel{d}{=} R\left(\alpha, n, S_{\alpha, \theta} G_{\theta+n, 1}^{\alpha}\right), \tag{9}
\end{equation*}
$$

where $S_{\alpha, \theta}, G_{\theta+n, 1}$ and $\{R(\alpha, n, z)\}_{z>0}$ are independent random elements.
Proof of Proposition 1. Start from the well-known identity (e.g., Pitman [24])

$$
\begin{equation*}
\mathrm{P}\left[K_{n}=k\right]=\frac{[\theta]_{(k, \alpha)}}{[\theta]_{(n)}} \frac{\mathscr{C}(n, k ; \alpha)}{\alpha^{k}}=\frac{\Gamma(\theta / \alpha+k)}{\Gamma(\theta / \alpha)} \frac{\Gamma(\theta)}{\Gamma(\theta+n)} \mathscr{C}(n, k ; \alpha) \tag{10}
\end{equation*}
$$

for any $k \in\{1, \ldots, n\}$. Due to the identity $\int_{0}^{+\infty} x^{-\theta} f_{\alpha}(x) \mathrm{d} x=\frac{\Gamma(\theta / \alpha)}{\alpha \Gamma(\theta)}$, it is easily checked that

$$
\begin{equation*}
f(z ; \alpha, \theta, n)=\frac{z^{\theta / \alpha+n / \alpha-1}}{\Gamma(\theta / \alpha)[\theta]_{(n)}}\left(\int_{0}^{+\infty} x^{n} e^{-x z^{1 / \alpha}} f_{\alpha}(x) \mathrm{d} x\right) \mathbb{1}\{z>0\} \tag{11}
\end{equation*}
$$

is a probability density function. Thus, one has the following identities

$$
\begin{aligned}
\mathrm{P} & {\left[K_{n}=k\right] } \\
& =\frac{\mathscr{C}(n, k ; \alpha)}{\Gamma(\theta / \alpha)[\theta]_{(n)}} \int_{0}^{+\infty} z^{k+\theta / \alpha-1} e^{-z} \mathrm{~d} z \\
& =\frac{1}{\Gamma(\theta / \alpha)[\theta]_{(n)}} \int_{0}^{+\infty} z^{\theta / \alpha-1} e^{-z}\left(\sum_{j=1}^{n} \mathscr{C}(n, j ; \alpha) z^{j}\right) \frac{\mathscr{C}(n, k ; \alpha) z^{k}}{\sum_{j=1}^{n} \mathscr{C}(n, j ; \alpha) z^{j}} \mathrm{~d} z \\
& =\frac{1}{\Gamma(\theta / \alpha)[\theta]_{(n)}} \int_{0}^{+\infty} z^{\theta / \alpha+n / \alpha-1}\left(\int_{0}^{+\infty} x^{n} e^{-x z^{1 / \alpha}} f_{\alpha}(x) \mathrm{d} x\right) \frac{\mathscr{C}(n, k ; \alpha) z^{k}}{\sum_{j=1}^{n} \mathscr{C}(n, j ; \alpha) z^{j}} \mathrm{~d} z \\
& =\int_{0}^{+\infty} \mathrm{P}[R(\alpha, n, z)=k] f(z ; \alpha, \theta, n) \mathrm{d} z,
\end{aligned}
$$

where: i) the first identity follows from (10) upon noticing that $\alpha^{-k}[\theta]_{(k, \alpha)}=$ $\Gamma(k+\theta / \alpha) / \Gamma(\theta / \alpha)$; ii) the third exploits the following identity

\begin{equation*}
\sum_{j=1}^{n} \mathscr{C}(n, j ; \alpha) z^{j}=e^{z} z^{n / \alpha} \int_{0}^{+\infty} x^{n} e^{-x z^{1 / \alpha}} f_{\alpha}(x) \mathrm{d} x \tag{12}
\end{equation*}
$$

displayed in Proposition 1 of Favaro et al. [7]; the fourth follows from a combination of (7) with (11). To conclude, it is enough to show that the probability distribution of $S_{\alpha, \theta} G_{\theta+n, 1}^{\alpha}$ possesses a density coinciding with $f(\cdot ; \alpha, \theta, n)$. In fact, one has

\begin{aligned}
& \mathrm{P}\left[S_{\alpha, \theta} G_{\theta+n, 1}^{\alpha} \leq u\right] \\
& \quad=\int_{0}^{+\infty} \mathrm{P}\left[G_{\theta+n, 1} \leq\left(\frac{u}{s}\right)^{1 / \alpha}\right] \frac{\Gamma(\theta+1)}{\alpha \Gamma(\theta / \alpha+1)} s^{\frac{\theta-1}{\alpha}-1} f_{\alpha}\left(s^{-1 / \alpha}\right) \mathrm{d} s \\
& \quad=\int_{0}^{+\infty}\left(\int_{0}^{u^{1 / \alpha} x} \frac{t^{\theta+n-1} e^{-t}}{\Gamma(\theta+n)} \mathrm{d} t\right) \frac{\Gamma(\theta+1)}{\Gamma(\theta / \alpha+1)} x^{-\theta} f_{\alpha}(x) \mathrm{d} x \\
& \quad=\int_{0}^{+\infty}\left(\int_{0}^{u} \frac{1}{\Gamma(\theta+n)} e^{-x z^{1 / \alpha}} z^{\frac{\theta+n}{\alpha}-1} \mathrm{~d} z\right) \frac{\Gamma(\theta+1)}{\alpha \Gamma(\theta / \alpha+1)} x^{n} f_{\alpha}(x) \mathrm{d} x
\end{aligned}
$$

where: i) the first identity follows from conditioning; ii) the second and the third ensue from the changes of variable $x=s^{-1 / \alpha}$ and $t=x z^{1 / \alpha}$, respectively.

Observe that the representation (9) highlights the central role of the probability distribution $\rho(\cdot ; \alpha, n, z)$. The next result describes the asymptotic behavior of such distribution for large values of $n$, to be used later on.

Lemma 2. For fixed $\alpha \in(0,1)$ and $z>0, \lim _{n \rightarrow+\infty} \rho(\{k\} ; \alpha, n, z)=$ $e^{-z} \frac{z^{k-1}}{(k-1)!}$ for any $k \in \mathbb{N}$. This is tantamount to saying that $R(\alpha, n, z) \longrightarrow$ $1+N_{z}$ in distribution, as $n \rightarrow+\infty$.

Proof of Lemma 2. Letting $\mathrm{G}(\cdot ; \alpha, n, z)$ be the PGF of the random variable $R(\alpha, n, z)$, we show that $\mathrm{G}(s ; \alpha, n, z) \rightarrow s \exp \{z(s-1)\}$ as $n \rightarrow+\infty$, for any $s>0$. By using the definition of $\mathscr{C}(n, k ; \alpha)$, for every $u \in \mathbb{C}$ we write

$$
\begin{aligned}
\sum_{k=1}^{n} \mathscr{C}(n, k ; \alpha) u^{k} & =\sum_{i=1}^{n}(-1)^{i}[-i \alpha]_{(n)} \sum_{k=i}^{n} \frac{1}{k!}\binom{k}{i} u^{k} \\
& =\sum_{i=1}^{n}(-1)^{i}[-i \alpha]_{(n)} e^{u} u^{i} \frac{\Gamma(n-i+1, u)}{i!\Gamma(n-i+1)}
\end{aligned}
$$

where $\Gamma(a, x):=\int_{x}^{+\infty} t^{a-1} e^{-t} \mathrm{~d} t$ denotes the incomplete gamma function for $a, x>0$. Whence, $\mathrm{G}(\cdot ; \alpha, n, z)$ has the following expression

$$
\mathrm{G}(s ; \alpha, n, z)=e^{z(s-1)} \frac{-z s \frac{\Gamma(n, z s)}{\Gamma(n)}+\sum_{i=2}^{n}(-1)^{i} \frac{[-i \alpha]_{(n)}}{[-\alpha]_{(n)}}(z s)^{i} \frac{\Gamma(n-i+1, z s)}{i!\Gamma(n-i+1)}}{-z \frac{\Gamma(n, z)}{\Gamma(n)}+\sum_{i=2}^{n}(-1)^{i} \frac{[-i \alpha]_{(n)}}{[-\alpha]_{(n)}} z^{i} \frac{\Gamma(n-i+1, z)}{i!\Gamma(n-i+1)}}
$$

Since $\lim _{n \rightarrow+\infty} \frac{\Gamma(n, x)}{\Gamma(n)}=1$ for any $x>0$, the proof ends by showing that

$$
\lim _{n \rightarrow+\infty} \sum_{i=2}^{n}(-1)^{i} \frac{[-i \alpha]_{(n)}}{[-\alpha]_{(n)}} \frac{\Gamma(n-i+1, t)}{\Gamma(n-i+1)} \frac{t^{i}}{i!}=0
$$

for any $t>0$. Upon noticing that $\frac{\Gamma(n, x)}{\Gamma(n)} \leq 1$, we have the following relations

$$
\begin{aligned}
\frac{1}{i!}\left|\frac{[-i \alpha]_{(n)}}{[-\alpha]_{(n)}}\right| & =\frac{1}{i!}\left|\frac{\Gamma(n-i \alpha)}{\Gamma(-i \alpha)} \frac{\Gamma(-\alpha)}{\Gamma(n-\alpha)}\right| \\
& =\frac{\Gamma(n-i \alpha)}{i!\Gamma(n-\alpha)} \frac{|\sin i \pi \alpha|}{\pi} \\
& \leq|\Gamma(i \alpha+1)| \Gamma(-\alpha) \mid \\
& \frac{\Gamma(n-i \alpha)}{\Gamma(n-\alpha)} \frac{\Gamma(i \alpha+1)}{i!} \leq|\Gamma(-\alpha)| \frac{\Gamma(n-i \alpha)}{\Gamma(n-\alpha)}
\end{aligned}
$$

for all $n \in \mathbb{N}, x>0$ and $i \in\{1, \ldots, n\}$. Then, we can write

$$
\begin{aligned}
& \left|\sum_{i=2}^{n}(-1)^{i} \frac{[-i \alpha]_{(n)}}{[-\alpha]_{(n)}} \frac{\Gamma(n-i+1, t)}{\Gamma(n-i+1)} \frac{t^{i}}{i!}\right| \\
& \quad \leq \sum_{i=2}^{n} \frac{t^{i}}{i!}\left|\frac{[-i \alpha]_{(n)}}{[-\alpha]_{(n)}}\right| \\
& \quad \leq|\Gamma(-\alpha)| \sum_{i=2}^{n} t^{i} \frac{\Gamma(n-i \alpha)}{\Gamma(n-\alpha)} \leq|\Gamma(-\alpha)| \frac{\max _{i=2, \ldots, n} n^{i \alpha} \Gamma(n-i \alpha)}{\Gamma(n-\alpha)} \sum_{i=2}^{n}\left(\frac{t}{n^{\alpha}}\right)^{i}
\end{aligned}
$$

The monotonic increasing character of the function $(0, n) \ni x \mapsto n^{x} \Gamma(n-x)$, due to $\psi(z):=\frac{\Gamma^{\prime}(z)}{\Gamma(z)} \leq \log (z)$ for any $z>0$, entails that $\max _{i=2, \ldots, n} n^{i \alpha} \Gamma(n-$ $i \alpha)=n^{n \alpha} \Gamma(n-n \alpha)$. Thus, observe that $\frac{n^{n \alpha} \Gamma(n-n \alpha)}{\Gamma(n-\alpha)} \sim n^{\alpha}$ to conclude that

$$
\frac{\max _{i=2, \ldots, n} n^{i \alpha} \Gamma(n-i \alpha)}{\Gamma(n-\alpha)} \sum_{i=2}^{n}\left(\frac{t}{n^{\alpha}}\right)^{i} \sim\left(\frac{t}{n^{\alpha}}\right)^{2} \frac{\left(\frac{t}{n^{\alpha}}\right)^{n-1}-1}{\left(\frac{t}{n^{\alpha}}\right)-1} n^{\alpha} \sim \frac{1}{n^{\alpha}}
$$

as $n \rightarrow+\infty$, completing the proof.

Remark 1. Let $\Pi_{n}$ denote the random partition of the set $\{1, \ldots, n\}$ induced by a random sample $\left(X_{1}, \ldots, X_{n}\right)$ from $\tilde{\mathfrak{p}}_{\alpha, \theta}$, and let $M_{l, n}$ be the number of blocks with frequency $l$, i.e., $M_{l, n}=\sum_{1 \leq j \leq K_{n}} \mathbb{1}\left\{N_{j, n}=l\right\}$. It is not difficult to show that results analogous to Proposition 1 and Lemma 2 hold true for $M_{l, n}$. In particular, let $R_{l}(\alpha, n, z)$ be a random variable whose distribution coincides with the conditional distribution of the number of $Q_{j}(\alpha, q)$ 's equal to $l$, given the size of the random sample $S(\alpha, q, z)=n$. It can be shown that: i) for $l \geq 1, n \in \mathbb{N}, \alpha \in(0,1)$ and $\theta>-\alpha$ the distribution of $M_{l, n}$ coincides with the distribution of the random variable $R_{l}\left(\alpha, n, S_{\alpha, \theta} G_{\theta+n, 1}^{\alpha}\right)$; ii) for $l \geq$ $1, \alpha \in(0,1)$ and $z>0$ the random variable $R_{l}(\alpha, n, z)$ converges weakly, as $n \rightarrow+\infty$, to a Poisson random variable with parameter $z \alpha[1-\alpha]_{(l-1)} / l!$.

### 2.2 A quantitative Laplace method for $\mathcal{I}_{n}(z)$

Here, we study the Laplace integral $\mathcal{I}_{n}(z):=\int_{0}^{+\infty} e^{-n \phi_{z}(y)} f_{\alpha}(y) \mathrm{d} y$ for $z>0$, where $\phi_{z}(y):=z y-\log y$. This quantity is connected with (12) in view of the identity

$$
\begin{equation*}
d_{n}(x):=\sum_{j=1}^{n} \mathscr{C}(n, j ; \alpha)\left(x n^{\alpha}\right)^{j}=e^{x n^{\alpha}} x^{n / \alpha} n^{n} \mathcal{I}_{n}\left(x^{1 / \alpha}\right) \tag{13}
\end{equation*}
$$

valid for all $x>0$. As first step, after noticing that $\bar{y}(z):=1 / z$ is the only minimum point of $\phi_{z}(y)$, a direct application of the Laplace method (Section
7 in Chapter 3 of Olver [19]) shows that $\mathcal{I}_{n}(z) \sim\left(\frac{1}{z}\right)^{n+1} f_{\alpha}\left(\frac{1}{z}\right) e^{-n} \sqrt{\frac{2 \pi}{n}}$ as $n \rightarrow+\infty$. However, a more precise large $n$ estimate is provided by the next

Lemma 3. For any $n \in \mathbb{N}$, there exists a continuous function $\delta_{n}:(0,+\infty) \rightarrow$ $(0,+\infty)$ such that

$$
\begin{equation*}
\mathcal{I}_{n}(z)=\left(\frac{1}{z}\right)^{n+1} f_{\alpha}\left(\frac{1}{z}\right) e^{-n} \sqrt{\frac{2 \pi}{n}}\left[1+\delta_{n}(z)\right] \tag{14}
\end{equation*}
$$

and $\left|\delta_{n}(z)\right| \leq \Delta(z) / n$ for any $z>0$, where $\Delta:(0,+\infty) \rightarrow(0,+\infty)$ is a suitable continuous function which is independent of $n$. Moreover, $\Delta$ can be chosen in such a way that $\Delta(z)=O(1)$ as $z \rightarrow 0$, and $\Delta(z) f_{\alpha}(1 / z)=$ $O\left(z^{-\infty}\right)$ as $z \rightarrow+\infty$.

Recall from Kanter [12] that the positive $\alpha$-stable density function (3) can be written as

$$
\begin{equation*}
f_{\alpha}(z)=\frac{1}{\pi}\left(\frac{\alpha}{1-\alpha}\right)\left(\frac{1}{z}\right)^{\frac{1}{1-\alpha}} \int_{0}^{\pi} A(\varphi) \exp \left\{-\left(\frac{1}{z}\right)^{\frac{\alpha}{1-\alpha}} A(\varphi)\right\} \mathrm{d} \varphi \tag{15}
\end{equation*}
$$

holds for any $\alpha \in(0,1)$ and $z>0$, with $A(\varphi):=\left(\frac{\sin (\alpha \varphi)}{\sin (\varphi)}\right)^{\frac{1}{1-\alpha}}\left(\frac{\sin ((1-\alpha) \varphi)}{\sin (\alpha \varphi)}\right)$. In particular, (15) entails

$$
\begin{equation*}
f_{\alpha}(z) \sim \frac{(\alpha / z)^{\frac{2-\alpha}{2(1-\alpha)}}}{\sqrt{2 \pi \alpha(1-\alpha)}} \exp \left\{-(1-\alpha)\left(\frac{\alpha}{z}\right)^{\frac{\alpha}{1-\alpha}}\right\} \tag{16}
\end{equation*}
$$

as $z \rightarrow 0$, the asymptotic relation remaining valid after differentiating both sides with respect to $z$ as many times as needed. See, e.g., Zolotarev [30] for details.

Proof of Lemma 3. The change of variables $s=z y-1$ gives $\mathcal{I}_{n}(z)=\left(\frac{1}{z}\right)^{n+1} e^{-n} \int_{-1}^{+\infty} e^{-n h(s)} f_{\alpha}\left(\frac{s+1}{z}\right) \mathrm{d} s$ with $h(s):=s-\log (s+1)$. In order to exploit the analyticity of the function $h$ for $s \in(-1,1)$, fix $\sigma \in(0,1)$ and split the above integral into the regions $s \in(\sigma,+\infty), s \in(0, \sigma), s \in(-\sigma, 0)$ and $s \in(-1,-\sigma)$. The ensuing analysis will provide the desired bound on $\Delta$ by expressing it as a sum of three other functions called $\Delta_{1}, \Delta_{2}$ and $\Delta_{3}$. First, write $h(s) \geq h^{\prime}(\sigma)(s-\sigma)+h(\sigma)$ for every $s \in(\sigma,+\infty)$ by the convexity of $h$, yielding

$$
\begin{aligned}
& \int_{\sigma}^{+\infty} e^{-n h(s)} f_{\alpha}\left(\frac{s+1}{z}\right) \mathrm{d} s \\
& \quad \leq(\sigma+1)^{n} \exp \left\{-\frac{n \sigma}{\sigma+1}\right\} \int_{\sigma}^{+\infty} \exp \left\{-\frac{n s \sigma}{\sigma+1}\right\} f_{\alpha}\left(\frac{s+1}{z}\right) \mathrm{d} s \\
& \quad=(\sigma+1)^{n} \int_{\sigma+1}^{+\infty} \exp \left\{-\frac{n t \sigma}{\sigma+1}\right\} f_{\alpha}\left(\frac{t}{z}\right) \mathrm{d} t
\end{aligned}
$$

Observe that the analysis of this term leads to the study of

$$
\Delta_{1}(z):=\frac{1}{f_{\alpha}(1 / z)} \sup _{n \in \mathbb{N}} n^{3 / 2}(\sigma+1)^{n} \int_{\sigma+1}^{+\infty} \exp \left\{-\frac{n t \sigma}{\sigma+1}\right\} f_{\alpha}\left(\frac{t}{z}\right) \mathrm{d} t
$$

For small $z$, there holds $f_{\alpha}(1 / z)=O\left(z^{1+\alpha}\right)$ in view of (3), and the supremum turns out to be of the same order $z$, i.e. $O\left(z^{1+\alpha}\right)$, since $f_{\alpha}(x) \leq C_{\alpha} x^{-(1+\alpha)}$. For large $z$, put $\lambda:=\frac{\sigma}{2(\sigma+1)}$ and use the Cauchy-Schwartz inequality to obtain

$$
\begin{aligned}
& \int_{\sigma+1}^{+\infty} \exp \left\{-\frac{n t \sigma}{\sigma+1}+\lambda t\right\} e^{-\lambda t} f_{\alpha}\left(\frac{t}{z}\right) \mathrm{d} t \\
& \quad \leq\left(\int_{\sigma+1}^{+\infty} \exp \left\{-\frac{2 n t \sigma}{\sigma+1}+2 \lambda t\right\} \mathrm{d} t\right)^{1 / 2}\left(\left\|f_{\alpha}\right\|_{\infty} \int_{0}^{+\infty} e^{-2 \lambda t} f_{\alpha}\left(\frac{t}{z}\right) \mathrm{d} t\right)^{1 / 2} \\
& \quad=\frac{e^{\sigma / 2} \sqrt{1+1 / \sigma}}{\sqrt{2 n-1}} e^{-n \sigma} \sqrt{z}\left\|f_{\alpha}\right\|_{\infty}^{1 / 2} \exp \left\{-\frac{1}{2}\left(\frac{\sigma z}{\sigma+1}\right)^{\alpha}\right\}
\end{aligned}
$$

which entails the desired asymptotic behavior. Second, take into account the region $s \in(-1,-\sigma)$. Writing $h(s) \geq h^{\prime}(-\sigma)(s+\sigma)+h(-\sigma)$ for every $s \in(-1,-\sigma)$, and still using the convexity of the function $h$, we can write the following

$$
\int_{-1}^{-\sigma} e^{-n h(s)} f_{\alpha}\left(\frac{s+1}{z}\right) \mathrm{d} s \leq(1-\sigma)^{n} \int_{0}^{1-\sigma} \exp \left\{\frac{n t \sigma}{1-\sigma}\right\} f_{\alpha}\left(\frac{t}{z}\right) \mathrm{d} t
$$

Therefore, the quantity to bound is now equal to

$$
\Delta_{2}(z):=\frac{1}{f_{\alpha}(1 / z)} \cdot \sup _{n \in \mathbb{N}} n^{3 / 2}(1-\sigma)^{n} \int_{0}^{1-\sigma} \exp \left\{\frac{n t \sigma}{1-\sigma}\right\} f_{\alpha}\left(\frac{t}{z}\right) \mathrm{d} t
$$

For small $z$, argue as above using that $f_{\alpha}(1 / z)=O\left(z^{1+\alpha}\right)$ and $f_{\alpha}(x) \leq$ $C_{\alpha} x^{-(1+\alpha)}$. For large values of $z$, exploit that $\sup _{t \in[0,1-\sigma]} \exp \left\{\frac{n t \sigma}{1-\sigma}\right\}=e^{n \sigma}$ and conclude by using that $\int_{0}^{1-\sigma} f_{\alpha}\left(\frac{t}{z}\right) \mathrm{d} t \sim z^{\frac{1-3 \alpha / 2}{1-\alpha}} \exp \left\{-C_{\alpha} z^{\alpha /(1-\alpha)}\right\}$, as a consequence of (16). Third, to study the integral in the region $(0, \sigma)$, consider the inversion of the analytic function $h(s)$. Since $t=h(s)=\sum_{k=2}^{\infty} \frac{(-s)^{k}}{k}$ for $s \in(0, \sigma)$, by means of Lagrange's inversion formula $s=\sum_{k=1}^{\infty} \alpha_{k} t^{k / 2}$. The coefficients $\alpha_{k}$ are given by $\alpha_{1}=\sqrt{2}, \alpha_{2}=2 / 3$ and

$$
\frac{k+2}{\sqrt{2}} \alpha_{k+1}=\alpha_{k}-\sum_{j=0}^{k-2} \frac{j+2}{2} \alpha_{j+2} \alpha_{k-j}
$$

for $k=2,3, \ldots$ See, e.g., Example 1 in Chapter 2 of Wong [29]. Thus, $h:(0, \sigma) \rightarrow(0, h(\sigma))$ is bijective, with inverse function given by $q(t):=$ $\sum_{k=1}^{\infty} \alpha_{k} t^{k / 2}$ for $t \in(0, h(\sigma))$. These facts guarantee the possibility to change the variable, to get

$$
\int_{0}^{\sigma} e^{-n h(s)} f_{\alpha}\left(\frac{s+1}{z}\right) \mathrm{d} s=\int_{0}^{h(\sigma)} e^{-n t} f_{\alpha}\left(\frac{q(t)+1}{z}\right) q^{\prime}(t) \mathrm{d} t .
$$

At this stage, invoke the Taylor formula to show that, for all $s \in(0, \sigma)$ and $t \in(0, h(\sigma))$, there holds $|F(s ; z)| \leq \frac{1}{2} \sup _{y \in(0, \sigma)}\left|f_{\alpha}^{\prime \prime}\left(\frac{y+1}{z}\right)\right|\left(\frac{s}{z}\right)^{2},|Q(t)| \leq$ $C t^{3 / 2}$ and $\left|Q_{1}(t)\right| \leq C t^{1 / 2}$ with some numerical constant $C$, where we defined

$$
\begin{aligned}
F(s ; z) & :=f_{\alpha}\left(\frac{s+1}{z}\right)-\left[f_{\alpha}\left(\frac{1}{z}\right)+f_{\alpha}^{\prime}\left(\frac{1}{z}\right) \frac{s}{z}\right] \\
Q(t) & :=q(t)-\left[\alpha_{1} t^{1 / 2}+\alpha_{2} t\right] \\
Q_{1}(t) & :=q^{\prime}(t)-\left[\frac{1}{2} \alpha_{1} t^{-1 / 2}+\alpha_{2}\right] .
\end{aligned}
$$

Finally, the study in the region $(-\sigma, 0)$ starts from the inversion of the analytic functions $h(-s)$ for $s \in(0, \sigma)$. Deduce that $s=\sum_{k=1}^{\infty}(-1)^{k+1} \alpha_{k} t^{k / 2}=$ : $\bar{q}(t)$ is the inverse of $t=h(-s)$ for $s \in(0, \sigma)$. Changing the variable yields

$$
\int_{-\sigma}^{0} e^{-n h(s)} f_{\alpha}\left(\frac{s+1}{z}\right) \mathrm{d} s=\int_{0}^{h(-\sigma)} e^{-n t} f_{\alpha}\left(\frac{-\bar{q}(t)+1}{z}\right) \bar{q}^{\prime}(t) \mathrm{d} t
$$

Again, the Taylor formula shows that, for all $s \in(0, \sigma)$ and $t \in(0, h(-\sigma))$, there holds $|\bar{F}(s ; z)| \leq \frac{1}{2} \sup _{y \in(0, \sigma)}\left|f_{\alpha}^{\prime \prime}\left(\frac{-y+1}{z}\right)\right|\left(\frac{s}{z}\right)^{2},|\bar{Q}(t)| \leq C t^{3 / 2}$ and $\left|\bar{Q}_{1}(t)\right| \leq C t^{1 / 2}$ with some numerical constant $C$, where we defined

$$
\begin{aligned}
\bar{F}(s ; z) & :=f_{\alpha}\left(\frac{-s+1}{z}\right)-\left[f_{\alpha}\left(\frac{1}{z}\right)-f_{\alpha}^{\prime}\left(\frac{1}{z}\right) \frac{s}{z}\right] \\
\bar{Q}(t) & :=\bar{q}(t)-\left[\alpha_{1} t^{1 / 2}-\alpha_{2} t\right] \\
\bar{Q}_{1}(t) & :=q^{\prime}(t)-\left[\frac{1}{2} \alpha_{1} t^{-1 / 2}-\alpha_{2}\right] .
\end{aligned}
$$

Then, the way is paved to study

$$
\Delta_{3}(z):=\sup _{n \in \mathbb{N}} n\left|\frac{\int_{0}^{\sigma} e^{-n h(s)} f_{\alpha}\left(\frac{s+1}{z}\right) \mathrm{d} s+\int_{-\sigma}^{0} e^{-n h(s)} f_{\alpha}\left(\frac{s+1}{z}\right) \mathrm{d} s}{f_{\alpha}(1 / z) \sqrt{\frac{2 \pi}{n}}}-1\right|
$$

by expanding the sum of the two integrals in the numerator. The multitude of the ensuing terms is then split into four groups, according to the dependence on the $z$-variable. The first group corresponds to

$$
\begin{aligned}
f_{\alpha}\left(\frac{1}{z}\right)\{ & \frac{\alpha_{1}}{2} \int_{0}^{h(\sigma)} e^{-n t} t^{-1 / 2} \mathrm{~d} t+\alpha_{2} \int_{0}^{h(\sigma)} e^{-n t} \mathrm{~d} t+\int_{0}^{h(\sigma)} e^{-n t} Q_{1}(t) \mathrm{d} t \\
& \left.+\frac{\alpha_{1}}{2} \int_{0}^{h(-\sigma)} e^{-n t} t^{-1 / 2} \mathrm{~d} t-\alpha_{2} \int_{0}^{h(-\sigma)} e^{-n t} \mathrm{~d} t+\int_{0}^{h(-\sigma)} e^{-n t} \bar{Q}_{1}(t) \mathrm{d} t\right\} .
\end{aligned}
$$

The key remark rests on the identity $\alpha_{1} \int_{0}^{+\infty} e^{-n t} t^{-1 / 2} \mathrm{~d} t=\sqrt{\frac{2 \pi}{n}}$, so that the term -1 that appears in the definition of $\Delta_{3}(z)$ cancels out. The other noteworthy simplification is obtained by considering the identity $\int_{0}^{h(\sigma)} e^{-n t} \mathrm{~d} t-$ $\int_{0}^{h(-\sigma)} e^{-n t} \mathrm{~d} t=\frac{1}{n}\left[e^{-n h(-\sigma)}-e^{-n h(\sigma)}\right]$. The remaining terms are handled by means of the Watson lemma (Section 5.I of Wong [29]). Therefore, this first group of terms contributes as a bounded function of $z$, because of the simplification of the pre-factor $f_{\alpha}(1 / z)$ with the same term appearing in the
denominator of the expression that defines $\Delta_{3}$. The second group of terms is given by

$$
\begin{aligned}
\frac{1}{z} f_{\alpha}^{\prime}\left(\frac{1}{z}\right) & \left\{\frac{\alpha_{1}^{2}}{2} \int_{0}^{h(\sigma)} e^{-n t} \mathrm{~d} t+\alpha_{1} \int_{0}^{h(\sigma)} e^{-n t} t^{1 / 2}\left[\alpha_{2}+Q_{1}(t)\right] \mathrm{d} t\right. \\
& +\int_{0}^{h(\sigma)} e^{-n t}\left[\alpha_{2} t+Q(t)\right] \cdot\left[\frac{1}{2} \alpha_{1} t^{-1 / 2}+\alpha_{2}+Q_{1}(t)\right] \mathrm{d} t \\
& -\frac{\alpha_{1}^{2}}{2} \int_{0}^{h(-\sigma)} e^{-n t} \mathrm{~d} t-\alpha_{1} \int_{0}^{h(-\sigma)} e^{-n t} t^{1 / 2}\left[-\alpha_{2}+\bar{Q}_{1}(t)\right] \mathrm{d} t \\
& \left.+\int_{0}^{h(-\sigma)} e^{-n t}\left[-\alpha_{2} t+\bar{Q}(t)\right] \cdot\left[\frac{1}{2} \alpha_{1} t^{-1 / 2}-\alpha_{2}+\bar{Q}_{1}(t)\right] \mathrm{d} t\right\}
\end{aligned}
$$

As before, it is worth remarking the simplification involving the quantity $\int_{0}^{h(\sigma)} e^{-n t} \mathrm{~d} t-\int_{0}^{h(-\sigma)} e^{-n t} \mathrm{~d} t=\frac{1}{n}\left[e^{-n h(-\sigma)}-e^{-n h(\sigma)}\right]$. Again, the remaining terms are handled by means of the Watson lemma. As to the asymptotic behavior, recall (3) and (16) to get $f_{\alpha}^{\prime}\left(z^{-1}\right) / z f_{\alpha}\left(z^{-1}\right)=O(1)$ and $f_{\alpha}^{\prime}\left(z^{-1}\right) / z f_{\alpha}\left(z^{-1}\right)=O\left(z^{\frac{\alpha}{1-\alpha}}\right)$ as $z \rightarrow 0$ and $z \rightarrow+\infty$, respectively. Finally, consider

\frac{1}{2 z^{2}} \sup _{y \in(0, \sigma)}\left|f_{\alpha}^{\prime \prime}\left(\frac{y+1}{z}\right)\right| \int_{0}^{h(\sigma)} e^{-n t}[q(t)]^{2} \cdot\left[\frac{1}{2} \alpha_{1} t^{-1 / 2}+\alpha_{2}+Q_{1}(t)\right] \mathrm{d} t
$$

and

\frac{1}{2 z^{2}} \sup _{y \in(0, \sigma)}\left|f_{\alpha}^{\prime \prime}\left(\frac{-y+1}{z}\right)\right| \int_{0}^{h(-\sigma)} e^{-n t}[\bar{q}(t)]^{2} \cdot\left[\frac{1}{2} \alpha_{1} t^{-1 / 2}-\alpha_{2}+\bar{Q}_{1}(t)\right] \mathrm{d} t
$$

Thanks to equations (3) and (16), the asymptotic behavior of these expressions stems from $f_{\alpha}^{\prime \prime}\left(z^{-1}\right) / z^{2} f_{\alpha}\left(z^{-1}\right)=O(1)$ and $f_{\alpha}^{\prime \prime}\left(z^{-1}\right) z^{2} f_{\alpha}\left(z^{-1}\right)=$ $O\left(z^{\frac{2 \alpha}{1-\alpha}}\right)$ as $z \rightarrow 0$ and $z \rightarrow+\infty$, respectively. This completes the proof.

### 2.3 A quantitative Poisson approximation

Our result improves Theorem 1 of Hwang [11] by reformulating it as a true inequality, i.e., without "big O" terms. As to notation, for any $r>0$ and $z_{0} \in \mathbb{C}, D_{r}\left(z_{0}\right)\left(\overline{D_{r}}\left(z_{0}\right)\right.$, respectively) will denote the open (closed, respectively) disc in $\mathbb{C}$ of radius $r$, centered at $z_{0}$.

Proposition 2. Let $\mathrm{G}_{X_{n}}$ be holomorphic in $D_{\eta+\tau_{n}}(0)$ for every $n \in \mathbb{N}$, with $\eta>3$ independent of $n$ and $\tau_{n}>0$. Moreover, suppose that $G_{X_{n}}$ can be written as

\mathrm{G}_{X_{n}}(s)=\exp \left\{\lambda_{n}(s-1)\right\} s^{h}\left[g(s)+\epsilon_{n}(s)\right] \tag{17}
\end{equation*}
$$

for every $s \in D_{\eta+\tau_{n}}(0)$, where:
i) $\left\{\lambda_{n}\right\}_{n \geq 1}$ is a diverging sequence of positive numbers;
ii) $h \in \mathbb{N}_{0}$ is a constant, independent of $n$;
iii) the restriction of $g$ to $D_{\eta}(0)$ is independent of $n$ and holomorphic on that domain, with $g(1)=1$ and $g(0) \neq 0$;
iv) $\epsilon_{n}$ is holomorphic in $D_{\eta}(0)$ and satisfies $K(\eta-1)<+\infty$, where

K(\delta):=\sup _{n \in \mathbb{N}} \sup _{0<|s-1|<\delta} \lambda_{n}\left|\frac{\epsilon_{n}(s)}{s-1}\right|<+\infty .
$$

Then, there exist some $n_{0} \in \mathbb{N}$ and $C(\eta)>0$, independent of $n$, such that

\sum_{k \geq h}\left|\mathrm{P}\left[X_{n}=k\right]-\exp \left\{-\left[\lambda_{n}+g^{\prime}(1)\right]\right\} \frac{\left[\lambda_{n}+g^{\prime}(1)\right]^{k-h}}{(k-h)!}\right| \leq \frac{C(\eta)}{\lambda_{n}} \tag{18}
\end{equation*}
$$

holds for every $n \geq n_{0}$.
The following proof contains also a quantification of $C(\eta)$. In addition, notice that $\lambda_{n}+g^{\prime}(1)>0$ holds eventually (with respect to $n$ ), and that the integer $h$ is well-defined in view of $g(0) \neq 0$ and the holomorphic character of $g$ and $\epsilon_{n}$ about $s=0$.

Proof of Proposition 2. Set $\sigma_{n}:=\lambda_{n}+g^{\prime}(1)$. Write $\mathrm{P}\left[X_{n}=k+h\right]=$ $I_{1}^{(k, n)}(\rho)+I_{2}^{(k, n)}(\rho)$, where, in view of (17) and the Cauchy formula,

& I_{2}^{(k, n)}(\rho)=\frac{1}{2 \pi i} \oint_{D_{\rho}(0)} \epsilon_{n}(s) s^{-(k+1)} e^{\lambda_{n}(s-1)} \mathrm{d} s
\end{aligned}
$$

for any $\rho \in(0, \eta)$. Observe that the left-hand side of (18) is bounded by

\sum_{k \geq 0}\left[\left|I_{1}^{(k, n)}(\rho)-e^{-\sigma_{n}} \frac{\sigma_{n}^{k}}{k!}\right|+\left|I_{2}^{(k, n)}(\rho)\right|\right] \tag{19}

Fix $\delta \in(1, \eta-1)$ and define $M_{1}(n):=\lambda_{n}-\lambda_{n}^{1 / 2+1 / 7}$ and $M_{2}(n):=\lambda_{n}+$ $\lambda_{n}^{1 / 2+1 / 7}$, yielding $M_{1}(n)<M_{2}(n)<\delta \lambda_{n}$ definitely with respect to $n$. Then, (19) is majorized by

\sum_{0 \leq k<M_{1}(n)}\left[e^{-\sigma_{n}} \frac{\sigma_{n}^{k}}{k!}+\left|I_{1}^{(k, n)}(\rho)\right|+\left|I_{2}^{(k, n)}(\rho)\right|\right]
$$

\begin{align*}
& +\sum_{M_{1}(n) \leq k<M_{2}(n)}\left[\left|I_{1}^{(k, n)}(\rho)-e^{-\sigma_{n}} \frac{\sigma_{n}^{k}}{k!}\right|+\left|I_{2}^{(k, n)}(\rho)\right|\right] \\
& +\sum_{k \geq M_{2}(n)} e^{-\sigma_{n}} \frac{\sigma_{n}^{k}}{k!}+\sum_{M_{2}(n) \leq k<\delta \lambda_{n}}\left[\left|I_{1}^{(k, n)}(\rho)\right|+\left|I_{2}^{(k, n)}(\rho)\right|\right] \\
& +\sum_{k \geq \delta \lambda_{n}}\left[\left|I_{1}^{(k, n)}(\rho)\right|+\left|I_{2}^{(k, n)}(\rho)\right|\right] . \tag{20}
\end{align*}
$$

For the last sum in (20), choose $\rho=\delta$ to obtain

\left|I_{1}^{(k, n)}(\delta)\right|+\left|I_{2}^{(k, n)}(\delta)\right| \leq \frac{1}{2} \sqrt{\frac{\pi}{2}}\left[\eta K(\eta) \lambda_{n}^{-1}+\sup _{s \in D_{\eta}(0)}|g(s)|\right] \lambda_{n}^{-1 / 2} \delta^{-k} e^{\lambda_{n}(\delta-1)}
$$

for all $k \geq \delta \lambda_{n}$. Hence, noticing that $1-\delta+\delta \log \delta>0$, conclude that

Then, if $k \in\left(0, M_{1}(n)\right) \cup\left[M_{2}(n), \delta \lambda_{n}\right)$, set $\rho:=k / \lambda_{n}$ to get

\left|I_{2}^{(k, n)}\left(k / \lambda_{n}\right)\right| & \leq \frac{e \sqrt{\pi}}{2 \sqrt{2}} K(\eta)\left(\frac{1}{\lambda_{n}}\right)\left[\left|\frac{k}{\lambda_{n}}-1\right|+\sqrt{\frac{\pi \delta}{2 \lambda_{n}}}\right] e^{-\lambda_{n}} \frac{\lambda_{n}^{k}}{k!} .
\end{aligned}
$$

By Chernoff bounds for Poisson probabilities, for the fourth sum in (20) there holds

\sum_{M_{2}(n) \leq k<\delta \lambda_{n}}\left[\left|I_{1}^{(k, n)}(\rho)\right|+\left|I_{2}^{(k, n)}(\rho)\right|\right] \leq C_{2}(\eta, \delta, g) \exp \left\{-\frac{1}{2} \lambda_{n}^{2 / 7}\right\}
$$

while, for the third sum in (20), there exists a constant $C_{3}$ such that

\sum_{0 \leq k<M_{1}(n)} e^{-\sigma_{n}} \frac{\sigma_{n}^{k}}{k!}+\sum_{k \geq M_{2}(n)} e^{-\sigma_{n}} \frac{\sigma_{n}^{k}}{k!} \leq C_{3} \exp \left\{-\frac{1}{2} \lambda_{n}^{2 / 7}\right\}
$$

Furthermore, the same argument based on the Chernoff bounds for Poisson probabilities shows that

\sum_{0 \leq k<M_{1}(n)}\left[\left|I_{1}^{(k, n)}(\rho)\right|+\left|I_{2}^{(k, n)}(\rho)\right|\right] \leq C_{4}(\eta, \delta, g) \exp \left\{-\frac{1}{2} \lambda_{n}^{2 / 7}\right\}
$$

It remains the second sum in (20), which brings the main contribution. In particular, for the sum relative to $\epsilon_{n}$, choose $\rho:=k / \lambda_{n}$ and write

& \times\left[K\left(\delta_{n}\right) \int_{|\theta| \leq \lambda_{n}^{-5 / 14}}\left|\frac{k}{\lambda_{n}} e^{i \theta}-1\right| e^{-k(1-\cos \theta)} \mathrm{d} \theta\right. \\
& \left.+K(\eta) \int_{|\theta|>\lambda_{n}^{-5 / 14}}\left|\frac{k}{\lambda_{n}} e^{i \theta}-1\right| e^{-k(1-\cos \theta)} \mathrm{d} \theta\right] \\
\leq & C_{5}(\eta)\left(e^{-\lambda_{n}} \frac{\lambda_{n}^{k}}{k!}\right)\left[K\left(\delta_{n}\right) \exp \left\{-\frac{1}{5} \lambda_{n}^{2 / 7}\right\}+K\left(\delta_{n}\right) \lambda_{n}^{-19 / 14}\right]
\end{aligned}
$$

where $\delta_{n}:=\sqrt{\left[1-\left(1-\lambda_{n}^{-5 / 14}\right) \cos \lambda_{n}^{-5 / 14}\right]^{2}+\left[\left(1-\lambda_{n}^{-5 / 14}\right) \sin \lambda_{n}^{-5 / 14}\right]^{2}} \sim$ $\sqrt{2} \lambda_{n}^{-5 / 14}$. Whence,

\sum_{M_{1}(n) \leq k<M_{2}(n)}\left|I_{2}^{(k, n)}(\rho)\right| \leq C_{5}(\eta)\left[K\left(\delta_{n}\right) \exp \left\{-\frac{1}{5} \lambda_{n}^{2 / 7}\right\}+K\left(\delta_{n}\right) \lambda_{n}^{-19 / 14}\right]
$$

Finally, upon noticing that

$$
I_{1}^{(k, n)}(\rho)-e^{-\sigma_{n}} \frac{\sigma_{n}^{k}}{k!}=\frac{1}{2 \pi i} \oint_{D_{\rho}(0)}\left[g(s)-e^{g^{\prime}(1)(s-1)}\right] s^{-(k+1)} e^{\lambda_{n}(s-1)} \mathrm{d} s
$$

is valid, write the integral on the right-hand side as

$$
\begin{aligned}
& \frac{g^{\prime \prime}(1)-\left[g^{\prime}(1)\right]^{2}}{4 \pi i} \oint_{D_{\rho}(0)}(s-1)^{2} s^{-(k+1)} e^{\lambda_{n}(s-1)} \mathrm{d} s \\
& +\sum_{m=3}^{\infty} \frac{1}{m!}\left\{g^{(m)}(1)-\left[g^{\prime}(1)\right]^{m}\right\} \frac{1}{2 \pi i} \oint_{D_{\rho}(0)}(s-1)^{m} s^{-(k+1)} e^{\lambda_{n}(s-1)} \mathrm{d} s
\end{aligned}
$$

Choosing $\rho:=k / \lambda_{n}$ once again, and taking account of the well-known Cauchy estimates for holomorphic functions, conclude that the modulus of the above sum is bounded by
$e^{-\lambda_{n}} \frac{\lambda_{n}^{k}}{k!}\left[\frac{1}{2}\left|g^{\prime \prime}(1)-\left[g^{\prime}(1)\right]^{2}\right| \cdot\left|\mathcal{C}_{2}\left(\lambda_{n}, k\right)\right|+\left(\frac{1}{\lambda_{n}}\right)^{\frac{15}{14}} \sum_{m=3}^{\infty} 2^{m+1} \lambda_{n}^{-(m-3) / 14} M_{n}(g)^{m}\right]$
where $\mathcal{C}_{2}\left(\lambda_{n}, k\right):=\frac{k^{2}-\left(2 \lambda_{n}+1\right) k+\lambda_{n}^{2}}{\lambda_{n}^{2}}$ stands for the Poisson-Charlier polynomial of degree 2 and $M_{n}(g):=\sup _{|s-1| \leq \lambda_{n}^{-2 / 7}}|g(s)|$. To conclude the proof,
recall that $\sum_{k=0}^{\infty} e^{-\lambda_{n}} \frac{\lambda_{n}^{k}}{k!}\left|\mathcal{C}_{2}\left(\lambda_{n}, k\right)\right| \leq C_{6} \lambda_{n}^{-1}$ holds with some numerical constant $C_{6}$ by virtue of Proposition 1 of Hwang [11], and observe that $2 \lambda_{n}^{-1 / 14} M_{n}(g) \leq \frac{1}{2}$ for all $n$ sufficiently large. Whence, for all $n \geq n_{0}$, write

\sum_{M_{1}(n) \leq k<M_{2}(n)}\left|I_{1}^{(k, n)}(\rho)-e^{-\sigma_{n}} \frac{\sigma_{n}^{k}}{k!}\right| \leq \frac{C_{7}}{\lambda_{n}}\left[\frac{1}{2}\left|g^{\prime \prime}(1)-\left[g^{\prime}(1)\right]^{2}\right|+1\right] \tag{22}
\end{equation*}
$$

for some suitable numerical constant $C_{7}$. This fact completes the proof.
A sharper bound than the one obtained in Proposition 2 can be obtained by strengthening the hypotheses on $g$. This is stated in the following

Corollary 1. In addition to the assumptions made in Proposition 2, suppose that

holds for every $r \in \mathbb{N}_{0}$ and some $B>0$ independent of $r$. Then, it holds

\sum_{k \geq 0}\left|I_{1}^{(k, n)}(\rho)-\exp \left\{-\left[\lambda_{n}+g^{\prime}(1)\right]\right\} \frac{\left[\lambda_{n}+g^{\prime}(1)\right]^{k}}{k!}\right| \leq \frac{C_{*}(\eta)}{\lambda_{n}}
$$

for every $n \geq n_{0}, C_{*}(\eta)$ being a suitable constant depending solely on $\eta$.
Proof. Rewrite $I_{1}^{(k, n)}(\rho)$ by means of an identity due to Ch. Jordan (see Kullback [14] and Uspensky [28]). For any $x>0$ and $r \in \mathbb{N}_{0}$, define
$L_{r}(x ; n):=\frac{r!}{2 \pi i} \oint_{D_{\bar{\rho}(0)}} g(1+s) s^{-(k+1)} e^{\left(\lambda_{n}-x\right) s} \mathrm{~d} s=\sum_{l=0}^{r}\binom{r}{l} g^{(l)}(1)\left(\lambda_{n}-x\right)^{r-l}$
the radius $\bar{\rho}$ being any number in ( $1, \eta-1$ ). See formulae (6) and (2.3) in Uspensky [28] and Kullback [14]. Setting $x=\sigma_{n}:=\lambda_{n}+g^{\prime}(1)$, Jordan's identity reads

\end{equation*}
$$

the symbol $\mathcal{C}_{r}(x ; k):=\sum_{l=0}^{r}\binom{r}{l}(-1)^{r-l}[k]_{[l]} x^{-l}$ standing for the PoissonCharlier polynomial, where $[k]_{[j]}$ denotes the falling factorial, i.e. $[k]_{[0]}:=1$ and $[k]_{[j]}:=\prod_{m=0}^{j-1}(k-m)$ if $j \in \mathbb{N}$. At this stage, the argument used to prove Proposition 1 of Hwang [11] (see also Lemma 6 in Shorgin [27]) shows
that, for any $x_{0}>1$, there exists a constant $M\left(x_{0}\right)$ depending solely by $x_{0}$ such that

\sum_{k=0}^{\infty} e^{-x} \frac{x^{k}}{k!}\left|\mathcal{C}_{r}(x ; k)\right| \leq\left[M\left(x_{0}\right)\right]^{r} \Gamma\left(\frac{r+1}{2}\right) x^{-r / 2} \tag{25}
\end{equation*}
$$

holds for every $x \geq x_{0}$ and $r \in \mathbb{N}_{0}$. Combination of (23)-(25) yields

\sum_{k \geq 0}\left|I_{1}^{(k, n)}(\rho)-e^{-\sigma_{n}} \frac{\sigma_{n}^{k}}{k!}\right| \leq \frac{B M\left(x_{0}\right)}{\sigma_{n}} \sum_{r=2}^{\infty} \Gamma\left(\frac{r+1}{2}\right) \frac{1}{\sqrt{r!}}\left(\frac{B M\left(x_{0}\right)}{\sigma_{n}}\right)^{(r-2) / 2} \tag{26}
\end{equation*}
$$

whenever $\sigma_{n} \geq x_{0}>1$, since $L_{0}\left(\sigma_{n} ; n\right)=1$ and $L_{1}\left(\sigma_{n} ; n\right)=0$. Thus, if $\sigma_{n} \geq 2 B M\left(x_{0}\right)$, the series on the right-hand side of (26) is bounded by a numerical constant, say $c_{1}$. Since $-2 g^{\prime}(1) \leq \lambda_{n}$ holds eventually in $n$, entailing that $1 / \sigma_{n} \leq 2 / \lambda_{n}$, the LHS of (26) is bounded by $2 c_{1} B M\left(x_{0}\right) / \lambda_{n}$, for all $n$ greater or equal than some $n_{0}$. This completes the proof.

Our application of Proposition 2 starts from the evaluation of the probability generating function of the random variable $R\left(\alpha, n, t n^{\alpha}\right)$, which is playing the role of $X_{n}$. In fact, a combination of equations (7) and (13) with Lemma 3 yields

\mathrm{G}_{R\left(\alpha, n, \text { nn }^{\alpha}\right)}(s)=e^{t^{\alpha}(s-1)} s \frac{\left(\frac{1}{s}\right)^{\frac{1}{\alpha}+1} f_{\alpha}\left(\left(\frac{1}{s t}\right)^{\frac{1}{\alpha}}\right)\left[1+\delta_{n}\left((s t)^{\frac{1}{\alpha}}\right)\right]}{f_{\alpha}\left(\left(\frac{1}{t}\right)^{\frac{1}{\alpha}}\right)\left[1+\delta_{n}\left(t^{\frac{1}{\alpha}}\right)\right]} . \tag{27}
\end{equation*}
$$

Currently, (27) holds for all $s, t>0$, but it will be shown that the numerator on the right-hand side can be analytically continued, as a function of $s$, to the whole complex plane. To parallel (27) with (17), set $\lambda_{n}=t n^{\alpha}, h=1$,

g(s)=\frac{\left(\frac{1}{s}\right)^{\frac{1}{\alpha}+1} f_{\alpha}\left(\left(\frac{1}{s t}\right)^{\frac{1}{\alpha}}\right)}{f_{\alpha}\left(\left(\frac{1}{t}\right)^{\frac{1}{\alpha}}\right)} \quad \text { and } \quad \epsilon_{n}(s)=g(s)\left[\frac{1+\delta_{n}\left((s t)^{\frac{1}{\alpha}}\right)}{1+\delta_{n}\left(t^{\frac{1}{\alpha}}\right)}-1\right] .
$$

As $\eta$, it can be chosen as any number strictly greater than 3 , since $\mathrm{G}_{R\left(\alpha, n, n^{\alpha}\right)}$ is an entire function. Apropos of the analytic continuation of the right-hand side of (27), recall the definition of the Wright-Mainardi function $M_{\alpha}(z):=$ $\frac{1}{\pi} \sum_{n=1}^{\infty} \frac{(-z)^{n-1}}{(n-1)!} \Gamma(\alpha n) \sin (\pi \alpha n)$, for $z \in \mathbb{C}$ and $\alpha \in(0,1)$, which coincides with $\frac{1}{\alpha z^{1+1 / \alpha}} f_{\alpha}\left(\frac{1}{z^{1 / \alpha}}\right)$ if $\Im(z)=0$ and $\Re(z)>0$ (Mainardi et al. [18]). It turns out that $g$ can be re-written as $g(s)=M_{\alpha}(s t) / M_{\alpha}(t)$, for all $s \in \mathbb{C}$, and (27) reads

$$
\mathrm{G}_{R\left(\alpha, n, t n^{\alpha}\right)}(s)=e^{t^{\alpha}(s-1)} s \frac{\int_{-1}^{+\infty} e^{n h(\sigma)}(1+\sigma)^{-\alpha} M_{\alpha}\left(s t(1+\sigma)^{-\alpha}\right) \mathrm{d} \sigma}{\int_{-1}^{+\infty} e^{n h(\sigma)}(1+\sigma)^{-\alpha} M_{\alpha}\left(t(1+\sigma)^{-\alpha}\right) \mathrm{d} \sigma} .
$$

Furthermore, the rate $\lambda_{n}+g^{\prime}(1)$ of the shifted Poisson distribution in (18) becomes

$$
\omega(t ; n, \alpha):=\lambda_{n}+g^{\prime}(1)=t n^{\alpha}+\frac{t M_{\alpha}^{\prime}(t)}{M_{\alpha}(t)}
$$

which is positive whenever $n$ is sufficiently large and $t \leq T(n, \alpha)$. The determination of the asymptotic behavior of $T(n, \alpha)$ is determined by the behavior of $M_{\alpha}$ for large arguments. In fact, as shown in the work of Mainardi et al. [18], $M_{\alpha}(t / \alpha) \sim(2 \pi(1-\alpha))^{-1 / 2} t^{\frac{\alpha-1 / 2}{1-\alpha}} \exp \left\{-\frac{1-\alpha}{\alpha} t^{\frac{1}{1-\alpha}}\right\}$ as $t \rightarrow+\infty$, in agreement with (16).

At this stage, this subsection is completed by stating a corollary that matches Proposition 2 with Lemma 3. After recalling that the symbol $N_{\lambda}$ denotes a Poisson random variable with parameter $\lambda$, we have the following

Corollary 2. There exists $n_{0}$ independent of $t$ such that, for all $n \geq n_{0}$ and $t \leq T(n, \alpha)$, there holds

$$
\sum_{k=1}^{\infty}\left|\mathrm{P}\left[R\left(\alpha, n, t n^{\alpha}\right)=k\right]-\mathrm{P}\left[1+N_{\omega(t ; n, \alpha)}=k\right]\right| \leq \frac{\Upsilon(t)}{t n^{\alpha}}
$$

where $T(n, \alpha) \sim n^{\kappa \alpha}$ as $n \rightarrow+\infty$ for some $\kappa \in(0,1)$, and $\Upsilon:(0,+\infty) \rightarrow$ $(0,+\infty)$ is a suitable continuous function which is independent of $n$. Moreover, $\Upsilon$ can be chosen in such a way that $\Upsilon(t)=O(1)$ as $t \rightarrow 0$, and $\Upsilon(t) \cdot f_{\alpha}\left(\frac{1}{t^{1 / \alpha}}\right)=O\left(t^{-\infty}\right)$ as $t \rightarrow+\infty$.
Proof. It is enough to recover the bounds (21)-(22). After they are rewritten in terms of $t$, it is enough to exploit the properties of the function $\Delta$ in Lemma 3.

### 2.4 Conclusion

This subsection contains the heart of the proof of Theorem 1, whose strategy consists in four main steps. Maintaining the notation used in Subsections 2.1 and 2.3 , these steps can be summarized as follows:
A) since the strong law of large numbers hints that $G_{\theta+n, 1}^{\alpha} \sim n^{\alpha}$ as $n \rightarrow+\infty$, with probability 1 , one tries to rigorously prove that the probability laws of $K_{n}$ and $R\left(\alpha, n, S_{\alpha, \theta} \cdot n^{\alpha}\right)$ are close, even in total variation;
B) after conditioning on the hypothesis that $S_{\alpha, \theta}=t$, one invokes Corollary 2 to prove that the probability laws of $R\left(\alpha, n, t n^{\alpha}\right)$ and $1+N_{\omega(t, n, \alpha)}$ are close in total variation;
C) by resorting to well-known results about Poisson mixtures contained in [15] (see also Proposition 4 below), one shows that the probability laws of $N_{\omega\left(S_{\alpha, \theta}, n, \alpha\right)}$ and $N_{S_{\alpha, \theta} \cdot n^{\alpha}}$ are close in total variation, the random variable $S_{\alpha, \theta}$ being thought of as independent of the family of random variables $\left\{N_{\lambda}\right\}_{\lambda>0}$;
D) in view of a quantitative law of large numbers for the Poisson process stated in Adell and de la Cal [1], one concludes by checking that the probability laws of $\left(1+N_{S_{\alpha, \theta} \cdot n^{\alpha}}\right) / n^{\alpha}$ and $S_{\alpha, \theta}$ are close in the Kolmogorov metric.

To grasp our strategy, write $\mathrm{d}_{K}(X ; Y)$ to denote the Kolmogorov distance between the distribution functions of $X$ and $Y$, and define $\Omega_{n, \alpha, \theta}:=$ $\omega\left(S_{\alpha, \theta} ; n, \alpha\right) \mathbb{1}\left\{S_{\alpha, \theta} \leq T(n, \alpha)\right\} \geq 0, T(n, \alpha)$ being the same as in Corollary 2 , to get

$$
\begin{aligned}
\mathrm{d}_{K}\left(K_{n} / n^{\alpha} ; S_{\alpha, \theta}\right) \leq & \mathrm{d}_{K}\left(K_{n} / n^{\alpha} ; R\left(\alpha, n, n^{\alpha} S_{\alpha, \theta}\right) / n^{\alpha}\right) \\
& +\mathrm{d}_{K}\left(R\left(\alpha, n, n^{\alpha} S_{\alpha, \theta}\right) / n^{\alpha} ;\left(1+N_{\Omega_{n, \alpha, \theta}}\right) / n^{\alpha}\right) \\
& +\mathrm{d}_{K}\left(\left(1+N_{\Omega_{n, \alpha, \theta}}\right) / n^{\alpha} ;\left(1+N_{S_{\alpha, \theta} n^{\alpha}}\right) / n^{\alpha}\right) \\
& +\mathrm{d}_{K}\left(\left(1+N_{S_{\alpha, \theta} n^{\alpha}}\right) / n^{\alpha} ; S_{\alpha, \theta}\right)
\end{aligned}
$$

where $S_{\alpha, \theta}$ is independent of both $\{R(\alpha, n, z)\}_{z>0}$ and $\left\{N_{\lambda}\right\}_{\lambda>0}$. Moreover, $N_{0}$ is intended, henceforth, as the degenerate random variable equal a.s. to 0 . After recalling that $\mathrm{d}_{K}(a X+b ; a Y+b)=\mathrm{d}_{K}(X ; Y)$ for any $a>0$ and $b \in \mathbb{R}$, and that $\mathrm{d}_{K}(X ; Y) \leq \mathrm{d}_{T V}(X ; Y):=\sup _{B \in \mathscr{B}(\mathbb{R})}|\mathrm{P}[X \in B]-\mathrm{P}[Y \in B]|, \mathrm{d}_{T V}$ being the total variation distance, one can write

$$
\begin{align*}
\mathrm{d}_{K}\left(K_{n} / n^{\alpha} ; S_{\alpha, \theta}\right) \leq & \mathrm{d}_{T V}\left(K_{n} ; R\left(\alpha, n, n^{\alpha} S_{\alpha, \theta}\right)\right)  \tag{28}\\
& +\int_{0}^{T(n, \alpha)} \mathrm{d}_{T V}\left(R\left(\alpha, n, t n^{\alpha}\right) ; 1+N_{\omega(t ; n, \alpha, \theta)}\right) f_{S_{\alpha, \theta}}(t) \mathrm{d} t \\
& +\mathrm{P}\left[S_{\alpha, \theta}>T(n, \alpha)\right] \\
& +\mathrm{d}_{K}\left(N_{\Omega_{n, \alpha, \theta}} ; N_{S_{\alpha, \theta} \cdot n^{\alpha}}\right)+\mathrm{d}_{K}\left(\left(1+N_{S_{\alpha, \theta} \cdot n^{\alpha}}\right) / n^{\alpha} ; S_{\alpha, \theta}\right) .
\end{align*}
$$

Hence, one starts by studying the first term on the RHS of (28).
Proposition 3. For fixed $\alpha \in(0,1)$ and $\theta>0$, there exists a positive constant $C_{1}(\alpha, \theta)$ such that

$$
\begin{align*}
& 2 \mathrm{~d}_{T V}\left(K_{n} ; R\left(\alpha, n, n^{\alpha} S_{\alpha, \theta}\right)\right)  \tag{29}\\
& \quad=\sum_{k=1}^{n}\left|\mathrm{P}\left[K_{n}=k\right]-\mathrm{P}\left[R\left(\alpha, n, n^{\alpha} S_{\alpha, \theta}\right)=k\right]\right| \leq C_{1}(\alpha, \theta) / n
\end{align*}
$$

holds for all $n \in \mathbb{N}$.
Proof of Proposition 3. The law of $R\left(\alpha, n, S_{\alpha, \theta} \cdot n^{\alpha}\right)$ is given by

$$
\begin{equation*}
\mathrm{P}\left[R\left(\alpha, n, S_{\alpha, \theta} \cdot n^{\alpha}\right)=k\right]=\int_{0}^{+\infty}\left[\frac{\mathscr{C}(n, k ; \alpha)\left(t n^{\alpha}\right)^{k}}{\sum_{j=1}^{n} \mathscr{C}(n, j ; \alpha)\left(t n^{\alpha}\right)^{j}}\right] f_{S_{\alpha, \theta}}(t) \mathrm{d} t \tag{30}
\end{equation*}
$$

for $k=1, \ldots, n$. Combining (10), (13) and (30), the LHS of (29) is equal to

$$
\sum_{k=1}^{n}\left|\mathscr{C}(n, k ; \alpha) \frac{\Gamma(k+\theta / \alpha)}{\Gamma(\theta / \alpha)} \frac{\Gamma(\theta)}{\Gamma(n+\theta)}-\int_{0}^{+\infty} \frac{\mathscr{C}(n, k ; \alpha)\left(t n^{\alpha}\right)^{k}}{d_{n}(t)} f_{S_{\alpha, \theta}}(t) \mathrm{d} t\right|
$$

Set $d_{n}^{*}(t):=e^{t n^{\alpha}}(n-1)!\frac{1}{t^{1 / \alpha}} f_{\alpha}\left(\frac{1}{t^{1 / \alpha}}\right)$ and majorize the above quantity by

$$
\begin{aligned}
& \sum_{k=1}^{n}\left|\mathscr{C}(n, k ; \alpha) \frac{\Gamma(k+\theta / \alpha)}{\Gamma(\theta / \alpha)} \frac{\Gamma(\theta)}{\Gamma(n+\theta)}-\int_{0}^{+\infty} \frac{\mathscr{C}(n, k ; \alpha)\left(t n^{\alpha}\right)^{k}}{d_{n}^{*}(t)} f_{S_{\alpha, \theta}}(t) \mathrm{d} t\right| \\
& \quad+\int_{0}^{+\infty} \frac{\left|d_{n}^{*}(t)-d_{n}(t)\right|}{d_{n}^{*}(t)} f_{S_{\alpha, \theta}}(t) \mathrm{d} t .
\end{aligned}
$$

Since $\int_{0}^{+\infty} \frac{\left(t^{\alpha}\right)^{k}}{d_{n}^{*}(t)} f_{S_{\alpha, \theta}}(t) \mathrm{d} t=\frac{1}{(n-1)!} \frac{\Gamma(k+\theta / \alpha)}{n^{\theta}} \frac{\Gamma(\theta)}{\Gamma(\theta / \alpha)}$ holds after taking account of (4), one has

$$
\begin{aligned}
& \sum_{k=1}^{n}\left|\mathscr{C}(n, k ; \alpha) \frac{\Gamma(k+\theta / \alpha)}{\Gamma(\theta / \alpha)} \frac{\Gamma(\theta)}{\Gamma(n+\theta)}-\int_{0}^{+\infty} \frac{\mathscr{C}(n, k ; \alpha)\left(t n^{\alpha}\right)^{k}}{d_{n}^{*}(t)} f_{S_{\alpha, \theta}}(t) \mathrm{d} t\right| \\
& \quad=\left|1-\frac{\Gamma(\theta+n)}{\Gamma(n) n^{\theta}}\right| \leq \frac{([\theta]+1)!-1}{n}
\end{aligned}
$$

where: i) the identity is a consequence of (10); ii) the inequality, in which $[\theta]$ denotes the integral part of $\theta$, follows from the well-known Tricomi-Erdelyi expansion of the gamma ratio. Finally, by resorting to (13)-(14), one has

$$
\begin{aligned}
& \int_{0}^{+\infty} \frac{\left|d_{n}^{*}(t)-d_{n}(t)\right|}{d_{n}^{*}(t)} f_{S_{\alpha, \theta}}(t) \mathrm{d} t \\
& \quad \leq\left|\frac{(n / e)^{n} \sqrt{2 \pi n}}{n!}-1\right|+\left(\frac{(n / e)^{n} \sqrt{2 \pi n}}{n!}\right) \frac{1}{n} \int_{0}^{+\infty} \Delta\left(t^{1 / \alpha}\right) f_{S_{\alpha, \theta}}(t) \mathrm{d} t
\end{aligned}
$$

which leads to the desired conclusion, in view of the well-known Stirling approximation and the fact that $\int_{0}^{+\infty} \Delta\left(t^{1 / \alpha}\right) f_{S_{\alpha, \theta}}(t) \mathrm{d} t<+\infty$, by virtue of Lemma 3. Indeed, suffice it to recall that $\Delta\left(t^{1 / \alpha}\right)=O(1)$ and $f_{S_{\alpha, \theta}}(t) \sim t^{\theta / \alpha}$ as $t \rightarrow 0$, whereas the condition $\Delta(z) f_{\alpha}(1 / z)=O\left(z^{-\infty}\right)$, valid as $z \rightarrow+\infty$, entails the integrability of $\Delta\left(t^{1 / \alpha}\right) f_{S_{\alpha, \theta}}(t)$ at infinity.

The conclusion of the proof of Theorem 1 requires to combine results of Subsection 2.3 with other known results. According to point B), invoke Corollary 2 to obtain

$$
\begin{aligned}
& \int_{0}^{T(n, \alpha)}\left(\sum_{k=1}^{\infty}\left|\mathrm{P}\left[R\left(\alpha, n, t n^{\alpha}\right)=k\right]-\mathrm{P}\left[1+N_{\omega(t ; n, \alpha)}=k\right]\right|\right) f_{S_{\alpha, \theta}}(t) \mathrm{d} t \\
& \quad \leq C_{2}(\alpha, \theta) / n^{\alpha}
\end{aligned}
$$

where $C_{2}(\alpha, \theta):=\int_{0}^{+\infty} t^{-1} \Upsilon(t) f_{S_{\alpha, \theta}}(t) \mathrm{d} t<+\infty$ in view of the asymptotic properties of $f_{S_{\alpha, \theta}}$. In order to proceed with point $C$ ), notice that

$$
\mathrm{P}\left[\omega\left(S_{\alpha, \theta} ; n, \alpha\right)<0\right]=\int_{T(n, \alpha)}^{+\infty} f_{S_{\alpha, \theta}}(t) \mathrm{d} t \sim \frac{1}{n^{\alpha}}
$$

as $n \rightarrow \infty$.
To bound the fourth term on the right-hand side of (28), note that this is the Kolmogorov distance between two Poisson mixtures. This problem is tackled in Theorem 1 of Le Cam [15], which is re-stated for the reader's ease.

Proposition $4\left(\mathrm{Le}\right.$ Cam). Given two probability measures $\gamma_{1}, \gamma_{2}$ on $\mathscr{B}([0,+\infty))$, one gets

$$
\begin{aligned}
& \sup _{x \geq 0}\left|\int_{0}^{+\infty} \mathrm{P}\left[N_{\lambda} \leq x\right] \gamma_{1}(\mathrm{~d} x)-\int_{0}^{+\infty} \mathrm{P}\left[N_{\lambda} \leq x\right] \gamma_{2}(\mathrm{~d} x)\right| \\
& \quad \leq 2\left(1+e^{2}\right) \sup _{B \in \mathscr{B}([0,+\infty))}\left|\gamma_{1}(B)-\gamma_{2}(B)\right|
\end{aligned}
$$

Therefore, a direct application of Proposition 4 yields

$$
\begin{aligned}
& \sum_{k=0}^{\infty} \mid \int_{0}^{T(n, \alpha)}\left[\mathrm{P}\left[N_{\omega(t ; n, \alpha)}=k\right]-\mathrm{P}\left[N_{t n^{\alpha}}=k\right]\right] f_{S_{\alpha, \theta}}(t) \mathrm{d} t \\
& \quad \leq 2\left(1+e^{2}\right) \int_{0}^{T(n, \alpha)}\left|f_{S_{\alpha, \theta}}(t)-n^{\alpha} f_{S_{\alpha, \theta}}\left(\psi_{n}\left(t n^{\alpha}\right)\right) \psi_{n}^{\prime}\left(t n^{\alpha}\right)\right| \mathrm{d} t \sim \frac{1}{n^{\alpha}}
\end{aligned}
$$

the function $\psi_{n}$ denoting the inverse of $(0, T(n, \alpha)) \ni t \mapsto \omega(t ; n, \alpha)$.
Finally, according to point D), first get rid of the shift +1 relative to the Poisson mixture. In fact, this yields an extra term which goes to zero as $1 / n^{\alpha}$, since $\int_{0}^{1 / n^{\alpha}} f_{S_{\alpha, \theta}}(t) \mathrm{d} t \sim 1 / n^{\alpha}$. Then, it remains to consider the following term

$$
\sup _{x \geq 0}\left|\mathrm{P}\left[N_{S_{\alpha, \theta} \cdot n^{\alpha}} \leq x n^{\alpha}\right]-\mathrm{P}\left[S_{\alpha, \theta} \leq x\right]\right|
$$

$$
=\sup _{x \geq 0}\left|\int_{0}^{\infty}\left\{\mathrm{P}\left[N_{t \cdot n^{\alpha}} \leq x n^{\alpha}\right]-\mathbb{1}\{t \leq x\}\right\} f_{S_{\alpha, \theta}}(t) \mathrm{d} t\right| .
$$

This quantity is bounded by $C_{3}(\alpha, \theta) / n^{\alpha}$ for a suitable $C_{3}(\alpha, \theta)>0$, as a direct application of Theorem 1 of Adell and de la Cal [1], which is here re-stated for the reader's ease.

Proposition 5 (Adell-de la Cal). Consider a probability density $h:[0,+\infty) \rightarrow$ $[0,+\infty)$ satisfying the following conditions
i) $h \in \mathrm{C}_{b}^{1}([0,+\infty))$, the space of $\mathrm{C}^{1}$ functions on $[0,+\infty)$ which are bounded together with their first derivatives;
ii) $\sup _{x \geq 0}\left|h(x)+\frac{1}{2} x h^{\prime}(x)\right|<+\infty$ :
iii) there exist $b_{0} \geq 0$ and $0<\gamma<\frac{1}{2}$ such that

$$
\lim _{s \rightarrow+\infty} \sup _{b \geq b_{0}} b \sup _{\substack{x \geq 0 \\|x-b| \leq b^{1-\gamma} / s^{\gamma}}}\left|h^{\prime}(x)-h^{\prime}(b)\right|=0 .
$$

Then, there exists a constant $C(h)$, depending on the above analytical properties of $h$, for which

$$
\sup _{x \geq 0}\left|\int_{0}^{\infty}\left\{\mathrm{P}\left[N_{t m} \leq x m\right]-\mathbb{1}\{t \leq x\}\right\} h(t) \mathrm{d} t\right| \leq \frac{C(h)}{m}
$$

holds for all $m>0$.
To apply Proposition 5 it is enough to set $m=n^{\alpha}$ and $h=f_{S_{\alpha, \theta}}$. Checking conditions i) and ii) is obvious, while the condition iii) can be verified as in Section 3 of the work of Adell and de la Cal [1]. The proof Theorem 1 is completed.

Remark 2. According to Remark 1, a natural extension of Theorem 1 may be to consider the random number $M_{l, n}$ of blocks in the random partition $\Pi_{n}$ induced by a random sample from $\tilde{\mathfrak{p}}_{\alpha, \theta}$. In particular, Pitman [24] showed that

$$
\begin{equation*}
\frac{M_{l, n}}{n^{\alpha}} \xrightarrow{a . s .} \frac{\alpha[1-\alpha]_{(l-1)}}{l!} S_{\alpha, \theta}, \tag{31}
\end{equation*}
$$

as $n \rightarrow+\infty$. Then one may apply the results in Section 2.2 and Section 2.3 to obtain a Berry-Esseen theorem for (31). A more challenging task is to prove Theorem 1 for the class of $\alpha$-stable Poisson-Kingman processes (Pitman [24]).

## 3 Pitman's posterior $\alpha$-diversity

Pitman's posterior $\alpha$-diversity (5) was first introduced in Favaro et al. [9] for Bayesian nonparametric inference of the number of new species in $m$ additional samples, given $n$ initial observed samples. Samples are modeled by the random vectors $\left(X_{1}, \ldots, X_{n}\right)$ and $\left(X_{n+1}, \ldots, X_{n+m}\right)$, which are subsequent segments of the exchangeable sequence $\left\{X_{i}\right\}_{i \geq 1}$ with $\tilde{\mathfrak{p}}_{\alpha, \theta}$ as directing measure. Let $K_{m}^{(n)}=K_{m}^{(n)}\left(X_{1}, \ldots, X_{n} ; X_{n+1}, \ldots, X_{n+m}\right):=\sum_{1 \leq i \leq m} \mathbb{1}\left\{X_{n+i} \notin\right.$ $\left.\left\{X_{1}, \ldots, X_{n}\right\}\right\}$ be the number of new species in $\left(X_{n+1}, \ldots, \bar{X}_{n+m}\right)$. Lijoi et al. [16] obtained the posterior distribution of $K_{m}^{(n)}$ given $\left(X_{1}, \ldots, X_{n}\right)$. For $\left(X_{1}, \ldots, X_{n}\right)=\left(x_{1}, \ldots, x_{n}\right) \in \mathbb{N}^{n}, K_{n}=j \in\{1, \ldots, n\}$ such that $\left\{X_{1}=x_{1}, \ldots, X_{n}=x_{n}\right\} \cap\left\{K_{n}=j\right\} \neq \emptyset$, and $\mathbf{N}_{n}=\left(n_{1}, \ldots, n_{j}\right) \in \mathbb{N}^{j}$ such that $\sum_{1 \leq i \leq j} n_{i}=n$, they showed that

$$
\begin{align*}
& \mathrm{P}\left[K_{m}^{(n)}=k \mid X_{1}=x_{1}, \ldots, X_{n}=x_{n}, K_{n}=j\right]  \tag{32}\\
& \quad=\mathrm{P}\left[K_{m}^{(n)}=k \mid K_{n}=j, \mathbf{N}_{n}=\left(n_{1}, \ldots, n_{j}\right)\right] \\
& \quad=\mathrm{P}\left[K_{m}^{(n)}=k \mid K_{n}=j\right]=\frac{\left[\frac{\theta}{\alpha}+j\right]_{(k)}}{[\theta+n]_{(m)}} \mathscr{C}(m, k ; \alpha,-n+j \alpha)
\end{align*}
$$

for any $k \in\{0,1, \ldots, m\}$. Here, $\mathscr{C}(n, k ; s, r)$ denotes the non-central generalized factorial coefficient, i.e., $\mathscr{C}(n, k ; s, r)=\frac{1}{k!} \sum_{i=0}^{k}(-1)^{i}\binom{k}{i}[-i s-r]_{(m)}$ (Charalambides [3]) The posterior distribution (32) is at the basis of Bayesian nonparametric inference for $K_{m}^{(n)}$, e.g. estimation and uncertainty quantification (Lijoi et al. [16]). However, since the computational burden for evaluating the non-central generalized factorial coefficient becomes overwhelming for large $m$, the evaluation of (32) is practically impossible for large $m$. To overcome this drawback, Favaro et al. [9] introduced Pitman's posterior $\alpha$-diversity $S_{\alpha, \theta}(n, j)$ to provide a practical tool to obtain large $m$ approximated posterior inferences for $K_{m}^{(n)}$ via straightforward Monte Carlo sampling from $S_{\alpha, \theta}(n, j)$. Here, we formulate a Berry-Esseen theorem for Pitman's posterior $\alpha$-diversity, thus quantifying the error of the approximated inference.

We start with a novel representation of the posterior distribution (32) in terms of the distribution of a compound sum of independent Bernoulli random variables with random parameter. For any $n \in \mathbb{N}$ and $p \in[0,1]$, we denote by $Z(n, p)$ a Binomial random variable with parameters $n, p$. Also, we use the symbol $B_{a, b}$ to denote a Beta random variable with parameters $a, b>0$.

Lemma 4. Let $n, m \in \mathbb{N}$ and $j \in\{1, \ldots, n\}$. For any $\alpha \in(0,1)$ and $\theta>$ $-\alpha$, let $K_{m}^{*}$ be the number of blocks of the random partition $\Pi_{m}$ induced by a random sample $\left(X_{1}^{*}, \ldots, X_{m}^{*}\right)$ from $\tilde{\mathfrak{p}}_{\alpha, \theta+n}$. Then, for any $k \in\{0,1, \ldots, m\}$, there holds

$$
\mathrm{P}\left[K_{m}^{(n)}=k \mid K_{n}=j\right]=\mathrm{P}\left[Z\left(K_{m}^{*}, B_{\theta / \alpha+j, n / \alpha-j}\right)=k\right],
$$

where the random variables $Z, K_{m}^{*}$ and $B_{\theta / \alpha+j, n / \alpha-j}$ are mutually independent under P .

Proof. Let $[x]_{[n, a]}$ be the falling factorial of $x$ of order $n$ and decrement $a$, i.e. $[x]_{[n, a]}=\prod_{0 \leq i \leq n-1}(x-i a)$, let $S(n, k)$ be the Stirling number of the second kind, and let $S(n, k ; x):=\sum_{k \leq t \leq n}\binom{t}{i}[x]_{[i-k, 1]} S(n, i)$ be the noncentral Stirling number of the second kind. Furthermore, let $s(n, k)$ be the Stirling number of the first kind and recall that $[x]_{[n, 1]}=\sum_{i=1}^{n} s(n, i) x^{i}$. We combine the definition of $S(n, k ; x)$ with Proposition 1 in Favaro et al. [9] to write, for any $r \in \mathbb{N}$,

$$
\begin{aligned}
& \mathrm{E}\left[\left(K_{m}^{(n)}\right)^{r} \mid K_{n}=j\right]^{\prime} \\
& =\sum_{t=0}^{r} S(r, t) \frac{\left[j+\frac{\theta}{\alpha}\right]_{(t, 1)}}{\left[\frac{\theta+n}{\alpha}\right]_{(t)}}\left[\frac{\theta+n}{\alpha}\right]_{(t)} \sum_{i=0}^{t}(-1)^{t-i}\binom{t}{i} \frac{[\theta+n+i \alpha]_{(m)}}{[\theta+n]_{(m)}} \\
& =\sum_{t=0}^{r} S(r, t) \frac{\left[j+\frac{\theta}{\alpha}\right]_{(t, 1)}}{\left[\frac{\theta+n}{\alpha}\right]_{(t)}} \mathrm{E}\left[\left[K_{m}^{*}\right]_{t, 1]}\right] \\
& =\sum_{t=0}^{r} S(r, t) \mathrm{E}\left[\left[K_{m}^{*}\right]_{[t, 1]}\right] \frac{\Gamma\left(\frac{\theta+n}{\alpha}\right)}{\Gamma\left(\frac{\theta}{\alpha}+j\right) \Gamma\left(\frac{n}{\alpha}-j\right)} \int_{0}^{1} x^{t+\frac{\theta}{\alpha}+j-1}(1-x)^{\frac{n}{\alpha}-j-1} \mathrm{~d} x \\
& =\sum_{t=0}^{r} S(r, t) \mathrm{E}\left[\left[K_{m}^{*}\right]_{[t, 1]}\right] \mathrm{E}\left[\left(B_{\left.\theta / \alpha+j, n / \alpha-j)^{t}\right]}\right.\right. \\
& =\mathrm{E}\left[\left(Z\left(K_{m}^{*}, B_{\theta / \alpha+j, n / \alpha-j}\right)\right)^{r}\right],
\end{aligned}
$$

where the last identity follows by $\mathrm{E}\left[(Z(n, p))^{r}\right]=\sum_{0 \leq t \leq r} S(r, t)[n]_{[t, 1]} p^{t}$. Then the proof is completed by resorting to the one-to-one correspondence between the conditional law of $K_{m}^{(n)}$ and the sequence of its conditional moments.

Let $\mathrm{F}_{m}(n, j)$ and $\mathrm{F}_{\alpha, \theta}(n, j)$ stand for the distribution functions of $K_{m}^{(n)} / m^{\alpha}$ and $S_{\alpha, \theta}(n, j)$, respectively, conditioned on the event $\left\{K_{n}=j\right\}$. Then, the followiong theorem may be interpreted as the natural posterior counterpart of Theorem 1, namely a Berry-Esseen theorem for Pitman's posterior $\alpha$-diversity.

Theorem 2. Let $n \in \mathbb{N}$ and $j \in\{1, \ldots, n\}$. For any $\theta>0$ and $\alpha \in(0,1)$ such that $\frac{n}{\alpha}-j \geq 1$, there exists a positive constant $C_{\alpha, \theta}(n, j)$, depending solely on $n, j, \alpha$ and $\theta$, such that $\mathrm{d}_{K}\left(\mathrm{~F}_{m}(n, j) ; \mathrm{F}_{\alpha, \theta}(n, j)\right) \leq m^{-\alpha} C_{\alpha, \theta}(n, j)$ holds for every $m \in \mathbb{N}$.

Proof. For a generic random variable $X$, let $\mathrm{F}_{X}$ denote its distribution function. Then, notice that $\mathrm{F}_{\alpha, \theta}(n, j)(x)=\mathrm{E}\left[F_{B_{\theta / \alpha+j, n / \alpha-j}}\left(x / S_{\alpha, \theta+n}\right)\right]$. Hereafter, it will be shown there exists a suitable constant $C_{\alpha, \theta}^{*}(n, j)$ such that

$$
\begin{equation*}
\mathrm{d}_{K}\left(\mathrm{~F}_{m}(n, j) ; \mathrm{F}_{\alpha, \theta}(n, j)\right) \leq C_{\alpha, \theta}^{*}(n, j) \mathrm{E}\left[\frac{1}{K_{m}^{*}+1}\right]+\mathrm{d}_{K}\left(\mathrm{~F}_{K_{m}^{*} / m^{\alpha}} ; \mathrm{F}_{S_{\alpha, \theta+n}}\right), \tag{33}
\end{equation*}
$$

is valid, along with

$$
\begin{equation*}
\mathrm{E}\left[\frac{1}{K_{m}^{*}+1}\right] \leq \frac{1}{m^{\alpha}} \mathrm{E}\left[\frac{1}{S_{\alpha, \theta+n}}\right]+\mathrm{d}_{K}\left(\mathrm{~F}_{K_{m}^{*} / m^{\alpha}} ; \mathrm{F}_{S_{\alpha, \theta+n}}\right) . \tag{34}
\end{equation*}
$$

With regards to (33), write

$$
\begin{align*}
& \mathrm{d}_{K}\left(\mathrm{~F}_{m}(n, j) ; \mathrm{F}_{\alpha, \theta}(n, j)\right)=\sup _{x \geq 0}\left|\mathrm{~F}_{K_{m}^{(n)}}\left(m^{\alpha} x\right)-\mathrm{E}\left[\mathrm{~F}_{B_{\theta / \alpha+j, n / \alpha-j}}\left(\frac{x}{S_{\alpha, \theta+n}}\right)\right]\right| \\
& \quad \leq \sup _{x \geq 0}\left|\mathrm{~F}_{K_{m}^{(n)}}\left(m^{\alpha} x\right)-\mathrm{E}\left[\mathrm{~F}_{B_{\theta / \alpha+j, n / \alpha-j}}\left(\frac{m^{\alpha} x}{K_{m}^{*}}\right)\right]\right| \\
& \quad+\sup _{x \geq 0}\left|\mathrm{E}\left[\mathrm{~F}_{B_{\theta / \alpha+j, n / \alpha-j}}\left(\frac{m^{\alpha} x}{K_{m}^{*}}\right)\right]-\mathrm{E}\left[\mathrm{~F}_{B_{\theta / \alpha+j, n / \alpha-j}}\left(\frac{x}{S_{\alpha, \theta+n}}\right)\right]\right| \\
& =\sup _{x \geq 0}\left|\mathrm{~F}_{K_{m}^{(n)}}(x)-\mathrm{E}\left[\mathrm{~F}_{B_{\theta / \alpha+j, n / \alpha-j}}\left(\frac{x}{K_{m}^{*}}\right)\right]\right|  \tag{35}\\
& \quad+\sup _{x \geq 0}\left|\mathrm{E}\left[\mathrm{~F}_{B_{\theta / \alpha+j, n / \alpha-j}}\left(\frac{m^{\alpha} x}{K_{m}^{*}}\right)\right]-\mathrm{E}\left[\mathrm{~F}_{B_{\theta / \alpha+j, n / \alpha-j}}\left(\frac{x}{S_{\alpha, \theta+n}}\right)\right]\right|
\end{align*}
$$

and we treat separately the terms in (35). With regard to the first term,

$$
\begin{aligned}
& \sup _{x \geq 0}\left|\mathrm{~F}_{K_{m}^{(n)}}(x)-\mathrm{E}\left[\mathrm{~F}_{B_{\theta / \alpha+j, n / \alpha-j}}\left(\frac{x}{K_{m}^{*}}\right)\right]\right| \\
& \quad \leq \mathrm{E}\left[\sup _{x \geq 0}\left|\mathrm{~F}_{K_{m}^{(n)}}(x)-\mathrm{F}_{B_{\theta / \alpha+j, n / \alpha-j}}\left(\frac{x}{K_{m}^{*}}\right)\right|\right] \\
& \quad=\mathrm{E}\left[\sup _{x \geq 0}\left|\mathrm{~F}_{K_{m}^{(n)}}\left(K_{m}^{*} x\right)-\mathrm{F}_{B_{\theta / \alpha+j, n / \alpha-j}}(x)\right|\right] \\
& \quad=\mathrm{E}\left[\sup _{x \geq 0}\left|\mathrm{P}\left[\left.\frac{1}{K_{m}^{*}} \sum_{i=1}^{K_{m}^{*}} Y_{i} \leq x \right\rvert\, K_{m}^{*}\right]-\mathrm{F}_{B_{\theta / \alpha+j, n / \alpha-j}}(x)\right|\right],
\end{aligned}
$$

where in the last identity we used Lemma 4 . Thus, given $B_{\theta / \alpha+j, n / \alpha-j}$, the $Y_{i}$ 's are (conditionally) independent and identically distributed Bernoulli variables with parameter $B_{\theta / \alpha+j, n / \alpha-j}$. Moreover, $K_{m}^{*}, B_{\theta / \alpha+j, n / \alpha-j}$ and the sequence $\left\{Y_{i}\right\}_{i \geq 1}$ are mutually independent under P. Since $\frac{\theta}{\alpha}+j \geq 1$ and $\frac{n}{\alpha}-j \geq 1$, invoke Corollary 3 in Dolera and Favaro [6] to conclude that

$$
\begin{equation*}
\sup _{x \geq 0}\left|\mathrm{P}\left[\left.\frac{1}{K_{m}^{*}} \sum_{i=1}^{K_{m}^{*}} Y_{i} \leq x \right\rvert\, K_{m}^{*}\right]-\mathrm{F}_{B_{\theta / \alpha+j, n / \alpha-j}}(x)\right| \leq \frac{C_{\alpha, \theta}^{*}(n, j)}{K_{m}^{*}+1}, \tag{36}
\end{equation*}
$$

with $C_{\alpha, \theta}^{*}(n, j):=\frac{1}{2} \sup _{x \in[0,1]}\left|\mathrm{F}_{B_{\theta / \alpha+j, n / \alpha-j}^{\prime \prime}}(x)\right|$, exploiting that $1 / K_{m}^{*} \leq$ $2 /\left(K_{m}^{*}+1\right)$. Now, taking the expectation of both sides of (36) yields the first term on the right-hand side of (33). With regard to the second term in (35), we notice that, for any random variable $X$ supported in $(0,+\infty)$ there holds $\mathrm{E}\left[\mathrm{F}_{B_{\theta / \alpha+j, n / \alpha-j}}(x / X)\right]=\int_{0}^{1} \mathrm{~F}_{X}(x / t) \mathrm{dF}_{B_{\theta / \alpha+j, n / \alpha-j}}(t)$. Whence,

$$
\begin{aligned}
& \sup _{x \geq 0}\left|\mathrm{E}\left[\mathrm{~F}_{B_{\theta / \alpha+j, n / \alpha-j}}\left(\frac{m^{\alpha} x}{K_{m}^{*}}\right)\right]-\mathrm{E}\left[\mathrm{~F}_{B_{\theta / \alpha+j, n / \alpha-j}}\left(\frac{x}{S_{\alpha, \theta+n}}\right)\right]\right| \\
& \quad \leq \int_{0}^{1} \sup _{x \geq 0}\left|\mathrm{~F}_{K_{m}^{*} / m^{\alpha}}\left(\frac{x}{t}\right)-\mathrm{F}_{S_{\alpha, \theta+n}}\left(\frac{x}{t}\right)\right| \mathrm{dF}_{B_{\theta / \alpha+j, n / \alpha-j}}(t) \\
& \quad \leq \mathrm{d}_{K}\left(\mathrm{~F}_{K_{m}^{*} / m^{\alpha}} ; \mathrm{F}_{S_{\alpha, \theta+n}}\right),
\end{aligned}
$$

yielding the second term on the RHS of (33). With regard to (34),

$$
\mathrm{E}\left[\frac{1}{K_{m}^{*}+1}\right] \leq\left|\mathrm{E}\left[\frac{1}{K_{m}^{*}+1}\right]-\mathrm{E}\left[\frac{1}{m^{\alpha} S_{\alpha, \theta+n}+1}\right]\right|+\frac{1}{m^{\alpha}} \mathrm{E}\left[\frac{1}{S_{\alpha, \theta+n}}\right]
$$

and we deal separately with the two expectations inside the modulus, taking advantage that we have expressions of the form $\mathrm{E}[1 /(1+X)]$. Indeed, setting $\varphi(x)=(1+x)^{-1}$, we have $\int_{0}^{+\infty} \varphi(x) \mathrm{dF}(x)=\varphi(0)+\int_{0}^{+\infty} \varphi^{\prime}(x)[1-\mathrm{F}(x)] \mathrm{d} x$ for every distribution function F supported in $[0,+\infty)$. From $\int_{0}^{+\infty}\left|\varphi^{\prime}(x)\right| \mathrm{d} x=$ 1 , we get

$$
\begin{aligned}
\mid \mathrm{E} & { \left.\left[\frac{1}{K_{m}^{*}+1}\right]-\mathrm{E}\left[\frac{1}{m^{\alpha} S_{\alpha, \theta+n}+1}\right] \right\rvert\, } \\
& \leq \int_{0}^{+\infty}\left|\varphi^{\prime}(x)\right| \mathrm{d} x \cdot \sup _{x \geq 0}\left|\mathrm{~F}_{K_{m}^{*}}(x)-\mathrm{F}_{m^{\alpha} S_{\alpha, \theta+n}}(x)\right| \\
& =\mathrm{d}_{K}\left(\mathrm{~F}_{K_{m}^{*}} ; \mathrm{F}_{m^{\alpha} S_{\alpha, \theta+n}}\right)=\mathrm{d}_{K}\left(\mathrm{~F}_{K_{m}^{*} / m^{\alpha}} ; \mathrm{F}_{S_{\alpha, \theta+n}}\right) .
\end{aligned}
$$

To conclude, note that $\mathrm{E}\left[1 / S_{\alpha, \theta+n}\right]=\frac{\alpha \Gamma(\theta+n+1) \Gamma(\alpha(\theta+n-\alpha))}{\Gamma\left(\frac{\theta+n}{\alpha}+1\right) \Gamma(\theta+n-\alpha)}$ is finite for all $n \in \mathbb{N}$ whenever $\theta>-\alpha$, so that (34) holds true. The proof is completed by combining (33)-(34), and then by a direct application of Theorem 1.

As a direct consequence of Theorem 2, it is possible to construct credible intervals containing high posterior probability for the Bayesian nonparametric estimator $\hat{K}_{m}^{(n)}$. Due to the definition of the Kolmogorov distance, for every $a<b$
$\mathrm{P}\left[\left.\frac{K_{m}^{(n)}}{m^{\alpha}} \in[a, b] \right\rvert\, K_{n}=j\right] \geq \mathrm{P}\left[S_{\alpha, \theta}(n, j) \in[a, b] \mid K_{n}=j\right]-2 m^{-\alpha} C_{\alpha, \theta}(n, j)$.
Therefore, after fixing any confidence level, say $1-\gamma$, it is possible to choose $a, b$ so that

$$
\left\{\begin{array}{l}
\text { length of }(a, b) \text { is minimum } \\
\mathrm{P}\left[S_{\alpha, \theta}(n, j) \in[a, b] \mid K_{n}=j\right] \geq 1-\gamma+2 m^{-\alpha} C_{\alpha, \theta}(n, j) .
\end{array}\right.
$$

This provides with a practical, simple tool for assessing uncertainty quantification in the context of the Bayesian nonparametric estimation of $K_{m}^{(n)}$.

We conclude this section by pointing out a useful generalization of Theorem 2, which follows by the invariance under scaling of the Kolmogorov distance. Let $\lambda(m)$ be an arbitrary function of $m$ such that $\lambda(m) / m^{\alpha} \rightarrow 1$ as $m \rightarrow+\infty$. That is, $\lambda(m)$ is asymptotically equivalent to $m^{\alpha}$ for large $m$. Moreover, let $\mathrm{F}_{m}^{(\lambda)}(n, j)$ denote the posterior distribution function of $K_{m}^{(n)} / \lambda(m)$, given $\left(X_{1}, \ldots, X_{n}\right)$ featuring $K_{n}=j \leq n$ distinct species. For any $\alpha \in(0,1), \theta>-\alpha$ and $n \in \mathbb{N}$ such that $\frac{n}{\alpha}-j \geq 1$, Theorem (2) implies that there exists a constant $C_{\alpha, \theta}^{(\lambda)}(n, j)$, depending solely on $n, j, \alpha$ and $\theta$, such that

$$
\begin{equation*}
\mathrm{d}_{K}\left(\mathrm{~F}_{m}^{(\lambda)}(n, j) ; \mathrm{F}_{\alpha, \theta}(n, j)\right) \leq \frac{C_{\alpha, \theta}^{(\lambda)}(n, j)}{\lambda(m)} \tag{37}
\end{equation*}
$$

for every $m \in \mathbb{N}$. One may apply (37) to identify a function $\lambda$ that leads to an upper bound for $\mathrm{d}_{K}\left(\mathrm{~F}_{m}^{(\lambda)}(n, j) ; \mathrm{F}_{\alpha, \theta}(n, j)\right)$ which is smaller than the upper bound of Theorem 2. For instance, one may consider $\lambda(m)=(c+m)^{\alpha}-c^{\alpha}$, with $c$ being a positive parameter, and then optimize the upper bound in (37) with respect to $c$.
