State Leakage and Coordination with Causal State Knowledge at the Encoder

Abstract

We revisit the problems of state masking and state amplification through the lens of empirical coordination. Specifically, we characterize the rate-equivocation-coordination trade-offs regions of a state-dependent channel in which the encoder has causal and strictly causal state knowledge. We also extend this characterization to the cases of two-sided state information and noisy channel feedback. Our approach is based on the notion of core of the receiver's knowledge, which we introduce to capture what the decoder can infer about all the signals involved in the model. Finally, we exploit the aforementioned results to solve a channel state estimation zero-sum game in which the encoder prevents the decoder to estimate the channel state accurately.

I. INTRODUCTION

The study of state-dependent channels can be traced back to the early works of Shannon [2] and Gelf'and and Pinsker [3], which identified optimal coding strategies to transmit reliably in the presence of a state known at the encoder causally or non-causally, respectively. The insights derived from the models have since proved central to the study of diverse topics including wireless communications [4], [5], information-hiding and watermarking [6], and information transmission in repeated games [7]. The present work relates to the latter application and studies state-dependent channels with causal state knowledge from the perspective of *empirical coordination* [8].

Previous studies that have explored the problem of not only decoding messages at the receiver but also estimating the channel state, are particularly relevant to the present work. The *state masking* formulation




Fig. 1. The memoryless channel $\mathcal{T}_{Y|XS}$ depends on the state drawn i.i.d. according to \mathcal{P}_S . The encoding function is causal $f_i : \mathcal{M} \times S^i \to \mathcal{X}$, for all $i \in \{1, \ldots, n\}$ and the decoding functions $g : \mathcal{Y}^n \to \mathcal{M}$ and $h : \mathcal{Y}^n \to \Delta(\mathcal{V}^n)$ are non-causal.

of the problem [9] aims at characterizing the trade-off between the rate of reliable communication and the minimal leakage about the channel state. The rate-leakage capacity region of state masking has been successfully characterized for both causal and non-causal state knowledge. The *state amplification* formulation [10], in which the state is conveyed to the receiver instead of being masked, aims at characterizing the trade-off between the rate of reliable communication and the reduction of uncertainty about the state. The rate-uncertainty reduction capacity region of state amplification formulation was subsequently extended in the causal case by replacing the reduction of uncertainty about the state by an average distortion function [11] (this model was dubbed causal *state communication*). Note that, in such a scenario, the channel output feedback at the encoder increases the region of achievable rate-distortion pairs [12]. The rate-distortion capacity region of state communication has been successfully characterized for causal state knowledge, and has been characterized for noiseless and noisy non-causal state knowledge in the case of Gaussian channels with a quadratic distortion [13], [14]. Both formulations have been combined in [15] to study the trade-off between amplification and leakage rates in a channel with two receivers having opposite objectives. The amplification-leakage capacity

region has been investigated for non-causal state knowledge, via generally non-matching inner and outer bounds. As a perhaps more concrete example, [16] has studied the trade-off between amplification and leakage in the context of an energy harvesting scenario. An extreme situation of state masking, called state obfuscation, in which the objective is to make the channel output sequence nearly independent of the channel states, has recently been investigated in [17].

We revisit here, the problems of state masking and state amplification with causal and strictly causal state knowledge through the lens of *empirical coordination* [8], [18]. Empirical coordination refers to the control of the joint histograms of the various sequences such as states, codewords, that appear in channel models, and is related to the coordination of autonomous decision makers in game theory [7]. Specifically, the study of empirical coordination over state-dependent channels is a proxy for characterizing the utility of autonomous decision makers playing a repeated game in the presence of an environment variable (the state), random [7], [19] or adversarial [20], [21], [22], and of an observation structure (the channel) describing how agents observe each other's actions. The characterization of the decision makers are sequences that embed coordination information. The empirical coordination capacity has been studied for state-dependent channels under different constraints including strictly causal and causal encoding [23], for perfect channel [24], for strictly causal and causal decoding [25], with source feedforward [26], for lossless decoding [27], with secrecy constraint [28], with two-sided state information [29] and with channel feedback [30]. Empirical coordination is also a powerful tool for controlling the Bayesian posterior beliefs of the decoder, e.g. in the problems of Bayesian persuasion [31] and strategic communication [32].

The main contribution of the present work is to show that empirical coordination provides a natural framework in which to jointly study the problems of reliable communication, state masking, and state amplification. This connection highlights some of the benefits of empirical coordination beyond those already highlighted in earlier works [23]–[30]. In particular, we obtain the following.

- We introduce and characterize the notion of *core of the receiver's knowledge*, which captures what the decoder can exactly know about the other variables involved in the system. For instance, this allows us to characterize the rate-leakage-coordination region for the causal state-dependent channel (Theorem II.3). Our definition of leakage refines previous work by exactly characterizing the leakage rate instead of only providing a single-sided bound. When specialized, our result (Theorem II.6) simultaneously recovers the constraints already established both in [9, Section V] and [10, Theorem 2].
- We revisit the problem of causal state communication and characterize the normalized Kullback-Leibler (KL)-divergence between the decoder's posterior beliefs and a target belief induced by

• We extend the results to other models, including two-sided state information (Theorem IV.2), noisy feedback (Theorem IV.4), and strictly causal encoding (Theorem V.2).

The rest of the paper is organized as follows. In Section II, we formally introduce the model, along with necessary definitions and notation, and we state our main results. In Section III, we investigate the channel state estimation problem by introducing the KL-divergence and the decoder's posterior beliefs. In Section IV and Section V, we present some extensions of our results to different scenarios. The proofs of most results are provided in Appendices A-E, with some details relegated to Supplementary Materials.

II. PROBLEM FORMULATION AND MAIN RESULT

A. Notation

Throughout the paper, capital letters, e.g., S, denote random variables while lowercase letters, e.g., s. denote their realizations and calligraphic fonts, e.g., S, denote the alphabets in which the realizations take values. All alphabets considered in the paper are assumed finite, i.e., $|S| < \infty$. Sequences of random variables and realizations are denoted by $S^n = (S_1, \ldots, S_n)$ and $s^n = (s_1, \ldots, s_n)$, respectively. We denote the set of probability distributions over S by $\Delta(S)$. For a distribution $Q_S \in \Delta(S)$, we drop the subscript and simply write Q(s) in place of $Q_S(s)$ for the probability mass assigned to realization $s \in S$. The notation $Q_X(\cdot|y) \in \Delta(\mathcal{X})$ denotes the conditional distribution of $X \in \mathcal{X}$, given the realization $y \in \mathcal{Y}$. For two distributions $Q_X, \mathcal{P}_X \in \Delta(\mathcal{X})$, $||Q_X - \mathcal{P}_X||_1 = \sum_{x \in \mathcal{X}} |Q(x) - \mathcal{P}(x)|$ stands for the ℓ_1 -distance between the vectors representing the distributions, see also [33, pp. 370] and [34, pp. 19]. We write $Y \Leftrightarrow X \Leftrightarrow W$ when Y, X, and W form a Markov chain in that order. The notation $\mathbb{1}(v = s)$ stands for the indicator function, which is equal to 1 if v = s and 0 otherwise.

For a sequence $s^n \in S^n$, $N(\tilde{s}|s^n)$ denotes the occurrence number of symbol $\tilde{s} \in S$ in the sequence s^n . The empirical distribution $Q_S^n \in \Delta(S)$ of sequence $s^n \in S^n$ is then defined as

$$\forall \tilde{s} \in \mathcal{S}, \quad Q^n(\tilde{s}) = \frac{\mathsf{N}(\tilde{s}|s^n)}{n}.$$

Given $\delta > 0$ and a distribution $\mathcal{Q}_{SX} \in \Delta(\mathcal{S} \times \mathcal{X})$, $T_{\delta}(\mathcal{Q}_{SX})$ stands for the set of sequences (s^n, x^n) that are jointly typical with tolerance $\delta > 0$ with respect to the distribution \mathcal{Q}_{SX} , i.e., such that

$$\left| \left| Q_{SX}^n - \mathcal{Q}_{SX} \right| \right|_1 = \sum_{s,x} \left| Q^n(s,x) - \mathcal{Q}(s,x) \right| \le \delta.$$

We denote by $\mathbb{P}(S^n \in T_{\delta}(\mathcal{P}_S))$ the probability value assigned to the event $\{S^n \in T_{\delta}(\mathcal{P}_S)\}$, according to the distribution of S^n .

B. System model

The problem under investigation is illustrated in Figure 1. A uniformly distributed message represented by the random variable $M \in \mathcal{M}$ is to be transmitted over a state dependent memoryless channel characterized by the conditional distribution $\mathcal{T}_{Y|XS}$ and a channel state $S \in S$ drawn according to the i.i.d. distribution \mathcal{P}_S . For $n \in \mathbb{N}^* = \mathbb{N} \setminus \{0\}$, the message M and the state sequence S^n are encoded into a codeword $X^n \in \mathcal{X}^n$ using an encoder, subject to causal constraints to be precised later. Upon observing the output $Y^n \in \mathcal{Y}^n$ of the noisy channel, the receiver uses a decoder to form an estimate $\hat{M} \in \mathcal{M}$ of M and to generate actions $V^n \in \mathcal{V}^n$, whose exact role will be precised shortly. For now, V^n can be thought of as an estimate of the state sequence S^n but more generally captures the ability of the receiver to coordinate with the transmitter and the channel state. Both $\mathcal{T}_{Y|XS}$ and \mathcal{P}_S are assumed known to all parties. We are specifically interested in causal encoders formally defined as follows.

Definition II.1 A code with causal encoding consists of stochastic encoding functions $f_i : \mathcal{M} \times \mathcal{S}^i \longrightarrow \Delta(\mathcal{X}) \quad \forall i \in \{1, ..., n\}$, a deterministic decoding function $g : \mathcal{Y}^n \longrightarrow \mathcal{M}$, and a stochastic receiver action function $h : \mathcal{Y}^n \longrightarrow \Delta(\mathcal{V}^n)$. The set of codes with causal encoding with length n and message set \mathcal{M} is denoted $\mathcal{C}_{\mathsf{c}}(n, \mathcal{M})$.

A code $c \in C_{c}(n, \mathcal{M})$, the uniform distribution of the messages \mathcal{P}_{M} , the source \mathcal{P}_{S} and the channel $\mathcal{T}_{Y|XS}$, induce a distribution on $(M, S^{n}, X^{n}, Y^{n}, V^{n}, \hat{M})$ given by

$$\mathcal{P}_M \prod_{i=1}^n \left[\mathcal{P}_{S_i} f_{X_i | S^i M} \mathcal{T}_{Y_i | X_i S_i} \right] h_{V^n | Y^n} \mathbb{1} \left(\hat{M} = g(Y^n) \right).$$

Since the sequences (S^n, X^n, Y^n, V^n) are random, the empirical distribution Q_{SXYV}^n is also a random variable. The performance of codes is measured as follows.

Definition II.2 Fix a target rate $R \ge 0$, a target state leakage $E \ge 0$ and a target distribution Q_{SXYV} . The triple (R, E, Q_{SXYV}) is achievable if for all $\varepsilon > 0$, there exists $\overline{n} \in \mathbb{N}^*$, for all $n \ge \overline{n}$, there exists a code $c \in C_c(n, \mathcal{M})$ that satisfies

$$\begin{aligned} \frac{\log_2 |\mathcal{M}|}{n} \geq & \mathcal{R} - \varepsilon, \\ \left| \mathcal{L}_{\theta}(c) - \mathcal{E} \right| \leq & \varepsilon, \quad \text{with} \quad \mathcal{L}_{\theta}(c) = \frac{1}{n} I(S^n; Y^n), \\ \mathcal{P}_{\theta}(c) = & \mathbb{P}\left(M \neq \hat{M} \right) \\ & + & \mathbb{P}\left(\left| \left| Q_{SXYV}^n - \mathcal{Q}_{SXYV} \right| \right|_1 > \varepsilon \right) \leq \varepsilon \end{aligned}$$

We denote by A_c the set of achievable triples (R, E, Q_{SXYV}) .

In layman's term, performance is captured along three metrics: i) the rate at which the message M can be reliably transmitted; ii) the information leakage rate about the state sequence S^n at the receiver; and iii) the ability of the encoder to coordinate with the receiver, captured by the empirical coordination with respect to Q_{SXYV} . The need to coordinate with receiver action V is motivated by problems in which the terminals represent decision makers that choose actions (X, V) as a function of the system state S, as in [7]. The state can also be used to represent a system to control, in which case coordination also ties to the Witsenhausen's counterexample [35], [36].




Fig. 2. The region of achievable $(\mathsf{R},\mathsf{E}) \in \mathcal{A}_{\mathsf{c}}$ for a given distribution $\mathcal{Q}_{SW_1W_2XYV}$ for which $H(S) < I(S, W_1; Y)$.

C. Main result

Theorem II.3 Consider a target distribution Q_{SXYV} that decomposes as $Q_{SXYV} = \mathcal{P}_S Q_{X|S} \mathcal{T}_{Y|XS} Q_{V|SXY}$. Then, $(\mathbf{R}, \mathbf{E}, Q_{SXYV}) \in \mathcal{A}_c$ if and only if there exist two auxiliary random variables (W_1, W_2) with distribution $Q_{SW_1W_2XYV} \in \mathbb{Q}_c$ satisfying

$$I(S; W_1, W_2, Y) \le \mathbf{E} \le H(S), \tag{4}$$

$$\mathbf{R} + \mathbf{E} \le I(W_1, S; Y),\tag{5}$$

where \mathbb{Q}_{c} is the set of distributions $\mathcal{Q}_{SW_1W_2XYV}$ with marginal \mathcal{Q}_{SXYV} that decompose as

$$\mathcal{P}_{S}\mathcal{Q}_{W_{1}}\mathcal{Q}_{W_{2}|SW_{1}}\mathcal{Q}_{X|SW_{1}}\mathcal{T}_{Y|XS}\mathcal{Q}_{V|YW_{1}W_{2}},\tag{6}$$

and such that $\max(|\mathcal{W}_1|, |\mathcal{W}_2|) \leq |\mathcal{S} \times \mathcal{X} \times \mathcal{Y} \times \mathcal{V}| + 1.$

The achievability and converse proofs are provided in Appendices A and B, respectively, with the cardinality bounds established in the Supplementary Materials. The key idea behind the achievability proof is the following. The encoder operates in a Block-Markov fashion to ensure that the transmitted signals, the state, the received sequence, and the receiver actions are coordinated subject to the causal

constraint at the encoder. This requires the use of two auxiliary codebooks, captured by the auxiliary random variables W_1 and W_2 , where the first codebook is used for reliable communication while the second one is used to coordinate with the state. Simultaneously, the encoder quantizes the channel state and transmits carefully chosen bin indices on top of its messages to finely control how much the receiver can infer about the channel state. The region of achievable pairs (R, E) is depicted in Fig. 2 for a given distribution $Q_{SW_1W_2XYV}$, assuming $H(S) < I(S, W_1; Y)$.

Remark II.4 Equation (5) and the first inequality of (4) imply the information constraints of [11, Theorem 3] for causal state communication and of [23, Theorem 2] for empirical coordination.

$$\mathbf{R} \le I(W_1, W_2; Y) - I(W_2; S|W_1).$$

Indeed, both Markov chains $X \Leftrightarrow (S, W_1) \Leftrightarrow W_2$ and $Y \Leftrightarrow (X, S) \Leftrightarrow (W_1, W_2)$ imply $Y \Leftrightarrow (W_1, S) \Leftrightarrow W_2$.

Theorem II.3 has several important consequences. First, the coordination of both encoder and decoder actions according to $\mathcal{P}_S \mathcal{Q}_{X|S} \mathcal{T}_{Y|XS} \mathcal{Q}_{V|SXY}$ is compatible with the reliable transmission of additional information at rate $\mathbb{R} \ge 0$. Second, the case of equality in the right-hand-side inequality of (4) corresponds to the full disclosure of the channel state S to the decoder. Third, for any $(\mathbb{R}, \mathcal{Q}_{SXYV})$, the minimal state leakage $\mathbb{E}^*(\mathbb{R}, \mathcal{Q}_{SXYV})$ such that $(\mathbb{R}, \mathbb{E}^*(\mathbb{R}, \mathcal{Q}_{SXYV}), \mathcal{Q}_{SXYV}) \in \mathcal{A}_c$, if it exists, is given by

$$\mathsf{E}^{\star}(\mathsf{R}, \mathcal{Q}_{SXYV}) = \min_{\substack{\mathcal{Q}_{SW_1W_2XYV} \in \mathbb{Q}_c, \\ \text{st. } \mathsf{R} \le I(W_1, W_2; Y) - I(W_2; S|W_1)}} I(S; W_1, W_2, Y).$$

The reliable transmission of information requires the decoder to know the encoding function, from which it can estimate the channel state S. In Section III, we investigate the relationship between the state leakage $\mathcal{L}_{e}(c)$ and the decoder's posterior belief $\mathcal{P}_{S^{n}|Y^{n}}$ induced by the encoding process.

D. Special case without receiver actions

We now assume that the decoder does not return an action V coordinated with the other symbols (S, X, Y), in order to compare our setting with the problems of "state masking" [9, Section V] and "state amplification" [10, Section IV]. Note that these earlier works involve slightly different notions of achievable state leakage. In [9], the state leakage is upper bounded by $\mathcal{L}_{e}(c) = \frac{1}{n}I(S^{n};Y^{n}) \leq \mathsf{E} + \varepsilon$. In [10], the decoder forms a list $L_{n}(Y^{n}) \subseteq S^{n}$ with cardinality $\log_{2}|L_{n}(Y^{n})| = H(S) - \mathsf{E}$ such that the list decoding error probability $\mathbb{P}(S^{n} \notin L_{n}(Y^{n})) \leq \varepsilon$ is small, hence reducing the uncertainty about the state. Here, we require the leakage $\mathcal{L}_{e}(c) = \frac{1}{n}I(S^{n};Y^{n})$ induced by the code to be controlled by $|\mathcal{L}_{e}(c) - \mathsf{E}| \leq \varepsilon$. Nevertheless, we shall see that our definition allows us to obtain the rate constraints of [9], [10] as extreme cases.

Definition II.5 A code without receiver actions consists of stochastic encoding functions $f_i : \mathcal{M} \times S^i \longrightarrow \Delta(\mathcal{X}) \ \forall i \in \{1, ..., n\}$ and a deterministic decoding function $g : \mathcal{Y}^n \longrightarrow \mathcal{M}$. The set of such codes with length n and message set \mathcal{M} is denoted $C_d(n, \mathcal{M})$. The corresponding set of achievable triples $(\mathcal{R}, \mathcal{E}, \mathcal{Q}_{SXY})$ is defined as in Definition II.2 and is denoted \mathcal{A}_d .

Note that the target distribution is here restricted to $Q_{SXY} \in \Delta(S \times X \times Y)$ since the receiver does not take an action.

Theorem II.6 Consider a target distribution Q_{SXY} that decomposes as $Q_{SXY} = \mathcal{P}_S Q_{X|S} \mathcal{T}_{Y|XS}$. Then, $(R, E, Q_{SXY}) \in \mathcal{A}_d$ if and only if there exists an auxiliary random variable W_1 with distribution $Q_{SW_1XY} \in \mathbb{Q}_d$ that satisfies

$$I(S; W_1, Y) \le \mathbf{E} \le H(S),\tag{9}$$

$$\mathbf{R} + \mathbf{E} \le I(W_1, S; Y), \tag{10}$$

where \mathbb{Q}_d is the set of distributions \mathcal{Q}_{SW_1XY} with marginal \mathcal{Q}_{SXY} that decompose as

$$\mathcal{P}_{S}\mathcal{Q}_{W_{1}}\mathcal{Q}_{X|SW_{1}}\mathcal{T}_{Y|XS},\tag{11}$$

and such that $|\mathcal{W}_1| \leq |\mathcal{S} \times \mathcal{Y}| + 1$.

The achievability proof is obtained from Theorem II.3 by setting $W_2 = \emptyset$ and by considering a single block coding instead of block-Markov coding. The converse proof is similar to the converse of Theorem II.3 and is provided in the Supplementary Materials.

Remark II.7 When setting $W_2 = \emptyset$, (7) in Remark II.4 simplifies to

$$\mathbf{R} \le I(W_1; Y),\tag{12}$$

which, together with the first inequality in (9), coincides with the information constraints of [9, pp. 2260]. Furthermore, (12), (10) and the second inequality of (9) correspond to the region \mathcal{R}_0 stated in [10, Lemma 3]. Formally, the region characterized by Theorem II.6 is the intersection of the regions identified in [9, pp. 2260] and [10, Lemma 3].

III. CHANNEL STATE ESTIMATION VIA DISTORTION FUNCTION

A. Decoder posterior belief

In this section, we provide an upper bound on the KL-divergence between the decoder posterior belief $\mathcal{P}_{S^n|Y^n}$ induced by an encoding, and the target conditional distribution $\mathcal{Q}_{S|YW_1W_2}$.

Theorem III.1 (Channel state estimation) Assume that the distribution $Q = Q_{SW_1W_2XY}$ has full support. For any conditional distribution $\mathcal{P}_{W_1^nW_2^nX^n|S^n}$, we have

$$\frac{1}{n}D\left(\mathcal{P}_{S^{n}|Y^{n}}\left\|\left|\prod_{i=1}^{n}\mathcal{Q}_{S_{i}|Y_{i}W_{1,i}W_{2,i}}\right.\right)\right.$$

$$\leq \mathcal{L}_{\boldsymbol{\theta}}(c) - I(S;W_{1},W_{2},Y) + \alpha_{1}\delta \\
+ \alpha_{2}\mathbb{P}\left(\left(S^{n},W_{1}^{n},W_{2}^{n},Y^{n}\right)\notin T_{\delta}(\mathcal{Q})\right),$$
(13)

where $\delta > 0$ denotes the tolerance of the set of typical sequences $T_{\delta}(\mathcal{Q})$ and the constants $\alpha_1 = \sum_{\substack{s,w_1, \ w_2,y}} \log_2 \frac{1}{\mathcal{Q}(s|w_1,w_2,y)}$ and $\alpha_2 = \log_2 \frac{1}{\min_{s,y,w_1,w_2} \mathcal{Q}(s|y,w_1,w_2)}$ are strictly positive.

The proof of Theorem III.1 is given in Appendix C. Consider a target leakage $\mathsf{E} = I(S; W_1, W_2, Y)$ and a pair ($\mathsf{R}, \mathcal{Q}_{SXYV}$), and assume there exists a distribution $\mathcal{Q}_{SW_1W_2XYV} \in \mathbb{Q}_{\mathsf{c}}$ with full support, satisfying (4) and (5). By Theorem II.3, for all $\varepsilon > 0$ and for all $\delta > 0$, there exists $\overline{n} \in \mathbb{N}^*$ such that for all $n \ge \overline{n}$ there exists a code $c \in \mathcal{C}(n, \mathcal{M})$ with two auxiliary sequences (W_1^n, W_2^n) , such that

$$\left| \mathcal{L}_{\Theta}(c) - I(S; W_1, W_2, Y) \right| \leq \varepsilon \quad \text{and} \\ \mathbb{P}\left(\left| \left| Q_{SW_1W_2Y}^n - \mathcal{Q}_{SW_1W_2Y} \right| \right|_1 > \delta \right) \leq \varepsilon.$$
(15)

Hence, by Theorem III.1 we have

$$\frac{1}{n}D\left(\mathcal{P}_{S^{n}|Y^{n}}\left\|\left|\prod_{i=1}^{n}\mathcal{Q}_{S_{i}|Y_{i}W_{1,i}W_{2,i}}\right.\right)\leq\varepsilon+\alpha_{1}\delta+\alpha_{2}\varepsilon,$$
(16)

where ϵ and δ may go to zero when n goes to infinity. The control of the leakage $\mathcal{L}_{e}(c)$ and the joint typicality of the sequences $(S^n, W_1^n, W_2^n, Y^n) \in T_{\delta}(\mathcal{Q})$ implies that the decoder posterior belief $\mathcal{P}_{S^n|Y^n}$ approaches the single-letter distribution $\mathcal{Q}_{S|YW_1W_2}$. Based on the triple of symbols (Y, W_1, W_2) , the decoder generates action V using the conditional distribution $\mathcal{Q}_{V|YW_1W_2}$ and infers the channel state Saccording to the conditional distribution $\mathcal{Q}_{S|YW_1W_2}$. In that regard, the random variables (Y, W_1, W_2) capture the "core of the receiver's knowledge," regarding other random variables S and V. The bound on the KL-divergence in (14) relates to the notion of strategic distance [19, Section 5.2], later used in several articles on repeated game [20], [21], [22], on Bayesian persuasion [31] and on strategic communication [32].

B. Channel state estimation zero-sum game

We now introduce a channel state estimation zero-sum game, in which the encoder and decoder are opponents choosing an encoding and a decoding strategy, respectively. Although the encoder and the decoder cooperate in transmitting reliably at rate R, the encoder seeks to prevent the decoder from

returning a good estimate $v \in V$ of the channel state $s \in S$ by maximizing the expected long-run distortion, while the decoder attempts to minimize it.

Definition III.2 A target rate $R \ge 0$ and a target distortion $D \ge 0$ are achievable if for all $\varepsilon > 0$, there exists $\bar{n} \in \mathbb{N}^*$ such that for all $n \ge \bar{n}$, there exists a code in $C_d(n, \mathcal{M})$ such that

$$\frac{\log_2 |\mathcal{M}|}{n} \ge \mathbf{R} - \varepsilon, \tag{17}$$

$$\mathbb{P}\left(M \neq \hat{M}\right) \leq \varepsilon,\tag{18}$$

$$\left|\min_{h_{V^{n}|Y^{n}}} \frac{1}{n} \sum_{i=1}^{n} \mathbb{E}\left[d(S_{i}, V_{i})\right] - \mathcal{D}\right| \leq \varepsilon.$$
(19)

We denote by \mathcal{A}_g the set of achievable pairs $(\mathbf{R}, \mathbf{D}) \in \mathcal{A}_g$.

Theorem III.3 (Zero-sum game) A pair of rate and distortion $(\mathbf{R}, \mathbf{D}) \in \mathcal{A}_g$ is achievable if and only if there exists an auxiliary random variable W_1 with distribution $\mathcal{Q}_{SW_1XY} \in \mathbb{Q}_d$ that satisfies

$$\mathbf{R} \le I(W_1; Y),\tag{20}$$

$$D = \min_{\mathcal{P}_{V|W_1Y}} \mathbb{E}\Big[d(S, V)\Big],\tag{21}$$

where the set \mathbb{Q}_d is defined in Theorem II.6.

The achievability proof of Theorem III.3 is provided in Appendix D and is a consequence of Theorem II.6 and Theorem III.1, and of [31, Lemma A.8, Lemma A.21]. The converse proof of Theorem is provided in Appendix E.

Remark III.4 (Maximin-minimax result) The optimal distortion-rate function $D^*(R)$ reformulates as a maximin problem

$$D^{\star}(\boldsymbol{R}) = \max_{\substack{\mathcal{Q}_{W_{1}}, \mathcal{Q}_{X}|SW_{1}\\R \leq I(W_{1};Y)}} \min_{\mathcal{P}_{V|W_{1}Y}} \mathbb{E}\left[d(S,V)\right]$$
$$= \min_{\substack{\mathcal{P}_{V|W_{1}Y}\\R \leq I(W_{1};Y)}} \max_{\substack{\mathcal{Q}_{W_{1}}, \mathcal{Q}_{X}|SW_{1}\\R \leq I(W_{1};Y)}} \mathbb{E}\left[d(S,V)\right].$$
(22)

The maximum and the minimum are taken over compact and convex sets and the distortion function is linear. Hence by Sion's Theorem [37] the maximin is equal to the minimax and the value of this channel state estimation zero-sum game is $D^*(R)$.

Remark III.5 (One auxiliary random variable) The formulation of Theorem III.3 is based on the set of distributions \mathbb{Q}_d with only one auxiliary random variable W_1 , instead of the two random variables

 (W_1, W_2) of the set \mathbb{Q}_c . When the encoder tries to mask the channel state, it does not require the auxiliary random variable W_2 anymore, since

$$D^{\circ} = \max_{\substack{\mathcal{Q}_{W_{1}}, \mathcal{Q}_{X}|SW_{1}, \mathcal{Q}_{W_{2}}|SW_{1}\\R \leq I(W_{1}, W_{2}; Y) - I(W_{2}; S|W_{1})}} \min_{\mathcal{P}_{V|W_{1}W_{2}Y}} \mathbb{E}\left[d(S, V)\right]$$
(23)

$$\leq \max_{\substack{\mathcal{Q}_{W_1}, \mathcal{Q}_X \mid S_{W_1}, \mathcal{Q}_{W_2} \mid S_{W_1}\\ \mathcal{R} \leq I(W_1, W_2; Y) - I(W_2; S \mid W_1)}} \min_{\mathcal{P}_{V \mid W_1 Y}} \mathbb{E} \Big[d(S, V) \Big]$$
(24)

$$\leq \max_{\substack{\mathcal{Q}_{W_1},\mathcal{Q}_X|SW_1\\\mathcal{R}\leq I(W_1;Y)}} \min_{\mathcal{P}_{V|W_1Y}} \mathbb{E}\Big[d(S,V)\Big] = D^{\star},\tag{25}$$

where (24) comes from taking the minimum over $\mathcal{P}_{V|W_1Y}$ instead of $\mathcal{P}_{V|W_1W_2Y}$; (25) comes from the Markov chain $Y \rightarrow (S, W_1) \rightarrow W_2$ stated in (6), that ensures $I(W_1, W_2; Y) - I(W_2; S|W_1) \leq I(W_1; Y)$. Hence, the information constraint $\mathbf{R} \leq I(W_1, W_2; Y) - I(W_2; S|W_1)$ is more restrictive than $\mathbf{R} \leq I(W_1; Y)$.

Remark III.6 (Zero rate case) In the special case R = 0, which corresponds to a channel estimation game without communication, the encoding functions reduce to $f_{X_i|S^i}$ instead of $f_{X_i|S^iM}$. The channel state estimation zero-sum game becomes the maximin problem

$$\max_{\{f_{X_i|S^i}\}_{i\in\{1,\dots,n\}}} \min_{h_{V^n|Y^n}} \mathbb{E}\bigg[\frac{1}{n} \sum_{i=1}^n d(S_i, V_i)\bigg],\tag{26}$$

in which the encoder chooses $\{f_{X_i|S^i}\}_{i \in \{1,...,n\}}$ and the decoder chooses $h_{V^n|Y^n}$. Theorem III.3 shows that the single-letter solution is $\max_{\mathcal{Q}_{W_1}, \mathcal{Q}_{X|SW_1}} \min_{\mathcal{P}_{V|W_1Y}} \mathbb{E}\Big[d(S,V)\Big]$.

If the objectives of both encoder and decoder were aligned, i.e., they would both try to minimize the long term average distortion

$$\min_{\{f_{X_i|S^i\}_{i\in\{1,\dots,n\}},\atop h_{V^n|Y^n}} \mathbb{E}\bigg[\frac{1}{n}\sum_{i=1}^n d(S_i, V_i)\bigg],$$
(27)

the problem would become the causal channel state communication studied in [11].




Fig. 3. The causal encoding function is $f_i : \mathcal{M} \times \mathcal{U}^i \times \mathcal{S}^i \to \mathcal{X}$, for all $i \in \{1, \ldots, n\}$ and the non-causal decoding functions are $g : \mathcal{Y}^n \times \mathcal{Z}^n \to \mathcal{M}$ and $h : \mathcal{Y}^n \times \mathcal{Z}^n \to \Delta(\mathcal{V}^n)$.

IV. EXTENSIONS TO MORE GENERAL SCENARIOS

A. Two-sided state information

The case of two-sided state information is illustrated in Fig. 3. The channel state S^n , information source U^n and decoder state information Z^n are jointly distributed according to the i.i.d. distribution $\mathcal{P}_{USZ} \in \Delta(\mathcal{U} \times \mathcal{S} \times \mathcal{Z}).$

Definition IV.1 A code with two-sided state information consists of stochastic functions $f_i : \mathcal{M} \times \mathcal{U}^i \times \mathcal{S}^i \longrightarrow \Delta(\mathcal{X}) \ \forall i \in \{1, ..., n\}$, a deterministic decoding function $g : \mathcal{Y}^n \times \mathcal{Z}^n \longrightarrow \mathcal{M}$, and a stochastic receiver action function $h : \mathcal{Y}^n \times \mathcal{Z}^n \longrightarrow \Delta(\mathcal{V}^n)$. The set of codes with causal encoding with length n and message set \mathcal{M} is denoted $C_s(n, \mathcal{M})$.

A code $c \in C_s(n, \mathcal{M})$, the uniform distribution of the messages \mathcal{P}_M , the source \mathcal{P}_{USZ} and the channel $\mathcal{T}_{Y|XS}$ induce a distribution on $(M, U^n, S^n, Z^n, X^n, Y^n, V^n, \hat{M})$ given by

$$\mathcal{P}_{M}\prod_{i=1}^{n} \left[\mathcal{P}_{U_{i}S_{i}Z_{i}}f_{X_{i}|U^{i}S^{i}M}\mathcal{T}_{Y_{i}|X_{i}S_{i}} \right]$$
$$h_{V^{n}|Y^{n}Z^{n}}\mathbb{1}\left(\hat{M}=g(Y^{n},Z^{n})\right).$$
(28)

We denote by A_s the set of achievable triples (R, E, Q_{USZXYV}), defined similarly as in Definition II.2.

Theorem IV.2 (Two-sided state information) Consider a target distribution Q_{USZXYV} that decomposes as $Q_{USZXYV} = \mathcal{P}_{USZ}Q_{X|US}\mathcal{T}_{Y|XS}Q_{V|USZXY}$. Then, $(\mathbf{R}, \mathbf{E}, Q_{USZXYV}) \in \mathcal{A}_{s}$ if and only if there exist two auxiliary random variables (W_1, W_2) with distribution $Q_{USZW_1W_2XYV} \in \mathbb{Q}_{s}$ satisfying

$$I(U, S; W_1, W_2, Y, Z) \le \mathbf{E} \le H(U, S),$$
(29)

$$\mathbf{R} + \mathbf{E} \le I(W_1, U, S; Y, Z), \tag{30}$$

where \mathbb{Q}_s is the set of distributions $\mathcal{Q}_{USZW_1W_2XYV}$ that decompose as

$$\mathcal{P}_{USZ}\mathcal{Q}_{W_1}\mathcal{Q}_{W_2|USW_1}\mathcal{Q}_{X|USW_1}\mathcal{T}_{Y|XS}\mathcal{Q}_{V|YZW_1W_2},\tag{31}$$

and such that $\max(|\mathcal{W}_1|, |\mathcal{W}_2|) \leq d+1$ with $d = |\mathcal{U} \times \mathcal{S} \times \mathcal{Z} \times \mathcal{X} \times \mathcal{Y} \times \mathcal{V}|$.

The achievability proof follows directly from the proof of Theorem II.3, by replacing the random variable of the channel state S by the pair (U, S) and the random variable of the channel output Y by the pair (Y, Z). The converse proof is provided in the Supplementary Materials.




Fig. 4. The noisy feedback sequence Y_2^{i-1} is drawn i.i.d. according to $\mathcal{T}_{Y_1Y_2|XS}$. The encoding is $f_i : \mathcal{M} \times \mathcal{S}^i \times \mathcal{Y}_2^{i-1} \to \mathcal{X}$, $\forall i \in \{1, \ldots, n\}$.

Remark IV.3 The Markov chains $X \rightarrow (U, S, W_1) \rightarrow W_2$, $Y \rightarrow (X, S) \rightarrow (U, Z, W_1, W_2)$ and $Z \rightarrow (U, S) \rightarrow (X, Y, W_1, W_2)$ imply another Markov chain property $(Y, Z) \rightarrow (W_1, U, S) \rightarrow W_2$. Indeed, for all $(u, s, z, w_1, w_2, x, y)$ we have

$$\mathcal{P}(y, z | w_1, w_2, u, s)$$

= $\sum_{x \in \mathcal{X}} \mathcal{Q}(x | u, s, w_1) \mathcal{T}(y | x, s) \mathcal{P}(z | u, s) = \mathcal{P}(y, z | w_1, u, s).$

By combining (29) and (30) with the Markov chain $(Y, Z) \Leftrightarrow (W_1, U, S) \Leftrightarrow W_2$, we recover the information constraint of [29, Theorem V.1]:

$$\mathbf{R} \le I(W_1, W_2; Y, Z) - I(W_2; U, S|W_1).$$
(32)

B. Noisy channel feedback observed by the encoder

In this section, we consider that the encoder has noisy feedback Y_2 from the state-dependent channel $\mathcal{T}_{Y_1Y_2|XS}$, as depicted in Fig. 4. The encoding function becomes $f_i : \mathcal{M} \times \mathcal{S}^i \times \mathcal{Y}_2^{i-1} \to \mathcal{X}, \forall i \in \{1, \ldots, n\}$ while the decoding functions and the definition of the state leakage remain unchanged. The corresponding set of achievable triples ($\mathsf{R}, \mathsf{E}, \mathcal{Q}_{SXY_1Y_2V}$) is denoted \mathcal{A}_{f} .

Theorem IV.4 (Noisy channel feedback) We consider a target distribution $\mathcal{Q}_{SXY_1Y_2V}$ that decomposes as $\mathcal{Q}_{SXY_1Y_2V} = \mathcal{P}_S \mathcal{Q}_{X|S} \mathcal{T}_{Y_1Y_2|XS} \mathcal{Q}_{V|SXY_1Y_2}$. Then, $(\mathbf{R}, \mathbf{E}, \mathcal{Q}_{SXY_1Y_2V}) \in \mathcal{A}_{\mathbf{f}}$ if and only if there exist two auxiliary random variables (W_1, W_2) with distribution $\mathcal{Q}_{SW_1W_2XY_1Y_2V} \in \mathbb{Q}_{\mathbf{f}}$ that satisfy

$$\mathbf{R} \le I(W_1, W_2; Y_1) - I(W_2; S, Y_2 | W_1), \tag{33}$$

$$I(S; W_1, W_2, Y_1) \le \mathbf{E} \le H(S),$$
(34)

$$\boldsymbol{R} + \boldsymbol{E} \le I(W_1, S; Y_1), \tag{35}$$

where \mathbb{Q}_{f} is the set of distributions with marginal $\mathcal{Q}_{SW_{1}W_{2}XY_{1}Y_{2}V}$ that decompose as

$$\mathcal{P}_S \mathcal{Q}_{W_1} \mathcal{Q}_{X|SW_1} \mathcal{T}_{Y_1Y_2|XS} \mathcal{Q}_{W_2|SW_1Y_2} \mathcal{Q}_{V|Y_1W_1W_2},$$

and such that $\max(|\mathcal{W}_1|, |\mathcal{W}_2|) \leq d+1$ with $d = |\mathcal{S} \times \mathcal{X} \times \mathcal{Y}_1 \times \mathcal{Y}_2 \times \mathcal{V}|$.

The achievability proof of Theorem IV.4 follows directly from the proof of Theorem II.3, by replacing the pair (S^n, W_1^n) by the triple (S^n, W_1^n, Y_2^n) in order to select W_2^n . The decoding functions and the leakage analysis remain unchanged. The converse proof is stated in the Supplementary Materials.

Remark IV.5 (Noisy feedback improves coordination) The channel feedback increases the set of achievable triples, i.e. $\mathcal{A}_{c} \subset \mathcal{A}_{f}$, since the conditional distribution $\mathcal{Q}_{W_{2}|SW_{1}Y_{2}}$ depends on channel outputs Y_{2} . The information constraints of Theorem IV.4 are reduced to that of Theorem II.3 since $\mathcal{Q}_{W_{2}|SW_{1}Y_{2}} = \mathcal{Q}_{W_{2}|SW_{1}} \iff W_{2} \Leftrightarrow (S, W_{1}) \Leftrightarrow Y_{2} \iff I(W_{2}; Y_{2}|S, W_{1}) = 0$. This was already pointed out for the coordination problem in [30], and for the rate-and-state capacity problem in [12].




Fig. 5. The strictly causal encoding function is $f_i : \mathcal{M} \times \mathcal{S}^{i-1} \to \Delta(\mathcal{X})$, for all $i \in \{1, \ldots, n\}$ and the non-causal decoding functions are $g : \mathcal{Y}^n \to \mathcal{M}$ and $h : \mathcal{Y}^n \to \Delta(\mathcal{V}^n)$.

V. STRICTLY CAUSAL ENCODING

Definition V.1 A code with strictly causal encoding consists of stochastic encoding functions $f_i : \mathcal{M} \times S^{i-1} \longrightarrow \Delta(\mathcal{X}) \ \forall i \in \{1, ..., n\}$, a deterministic decoding function $g : \mathcal{Y}^n \longrightarrow \mathcal{M}$, and a stochastic receiver action function $h : \mathcal{Y}^n \longrightarrow \Delta(\mathcal{V}^n)$. The set of codes with strictly causal encoding with length n and message set \mathcal{M} is denoted $C_{sc}(n, \mathcal{M})$. The corresponding set of achievable triples $(\mathbf{R}, \mathbf{E}, \mathcal{Q}_{SXYV})$ is defined similarly as in Definition II.2 and is denoted \mathcal{A}_{sc} .

Theorem V.2 (Strictly causal encoding) Consider a target distribution Q_{SXYV} that decomposes as $Q_{SXYV} = \mathcal{P}_S Q_X \mathcal{T}_{Y|XS} Q_{V|SXY}$. Then, $(\mathbf{R}, \mathbf{E}, Q_{SXYV}) \in \mathcal{A}_{sc}$ if and only if there exists an auxiliary random variable W_2 with distribution $Q_{SW_2XYV} \in \mathbb{Q}_{sc}$ that satisfies

$$I(S; X, W_2, Y) \le \mathbf{E} \le H(S),\tag{36}$$

$$\mathbf{R} + \mathbf{E} \le I(X, S; Y),\tag{37}$$

where \mathbb{Q}_{sc} is the set of distributions \mathcal{Q}_{SW_2XYV} with marginal \mathcal{Q}_{SW_2XYV} that decompose as

$$\mathcal{Q}_{SW_2XYV} = \mathcal{P}_S \mathcal{Q}_X \mathcal{Q}_{W_2|SX} \mathcal{T}_{Y|XS} \mathcal{Q}_{V|XYW_2}$$
(38)

and such that $|\mathcal{W}_2| \leq |\mathcal{S} \times \mathcal{X} \times \mathcal{Y}| + 1$.

The achievability proof is obtained from Theorem II.3 by replacing the auxiliary random variable W_1 by the channel input X. The converse proof is provided in the Supplementary Materials.

Remark V.3 Equation (37), the first inequality of (36), the Markov chain $Y \rightarrow (X, S) \rightarrow W_2$, and the independence between S and X imply

$$R \le I(X, W_2; Y) - I(W_2; S|X).$$
(39)

Corollary V.4 (Without receiver's outputs) A pair of rate and state leakage (R, E) is achievable if and only if there exists a distribution Q_X that satisfies

$$I(S;Y|X) \le \mathbf{E} \le H(S),\tag{40}$$

$$\mathbf{R} + \mathbf{E} \le I(X, S; Y). \tag{41}$$

The achievability proof of Corollary V.4 comes from the achievability proof of Theorem V.2. The converse proof is based on standard arguments. Equations (40) and (41) imply $R \leq I(X;Y)$.

APPENDIX A

ACHIEVABILITY PROOF OF THEOREM II.3

A. Random coding

The case H(S) = 0 can be handled using a standard channel coding scheme and is detailed in the Supplementary Materials. In the remaining of the proof, we assume that H(S) > 0 and we fix a rate, a state leakage, and a distribution ($\mathsf{R}, \mathsf{E}, \mathcal{Q}_{SXYV}$) for which there exists a distribution $\mathcal{Q}_{SW_1W_2XYV} \in \mathbb{Q}_c$ with marginal \mathcal{Q}_{SXYV} , that satisfies

$$I(S; W_1, W_2, Y) < \mathsf{E} \le H(S),$$
(42)

$$\mathsf{R} + \mathsf{E} \le I(W_1, S; Y),\tag{43}$$

where the inequality in (42) is strict. The case of equality has to be treated with care because the channel capacity might be zero; a detailed analysis is available in the Supplementary Materials. We show that $(\mathsf{R}, \mathsf{E}, \mathcal{Q}_{SXYV})$ is achievable by introducing the rate parameters R_{L} , R_{J} , R_{K} and by considering a block-Markov random code $c \in C(nB, \mathcal{M})$ defined over $B \in \mathbb{N}^*$ blocks of length $n \in \mathbb{N}^*$. The codebook is defined over one block of length $n \in \mathbb{N}^*$ and the total length of the code is denoted by $N = nB \in \mathbb{N}^*$. In the following, the notation $T_{\delta}(\mathcal{Q})$ stands for the set of typical sequences with respect to the distribution $\mathcal{Q} = \mathcal{Q}_{SW_1W_2XYV}$.

Random Codebook.

1) We draw $2^{n(H(S)+\varepsilon)}$ sequences $S^n(l,j)$ according to the i.i.d. distribution \mathcal{P}_S , with indices $(l,j) \in \mathcal{M}_L \times \mathcal{M}_J$ such that $|\mathcal{M}_L| = 2^{n\mathsf{R}_L}$ and $|\mathcal{M}_J| = 2^{n\mathsf{R}_J}$.

2) We draw $2^{n(\mathsf{R}+\mathsf{R}_{\mathsf{L}}+\mathsf{R}_{\mathsf{K}})}$ sequences $W_1^n(m,l,k)$ according to the i.i.d. distribution \mathcal{Q}_{W_1} with indices $(m,l,k) \in \mathcal{M} \times \mathcal{M}_{\mathsf{L}} \times \mathcal{M}_{\mathsf{K}}$.

3) For each triple of indices $(m, l, k) \in \mathcal{M} \times \mathcal{M}_{\mathsf{L}} \times \mathcal{M}_{\mathsf{K}}$, we draw the same number $2^{n(\mathsf{R}+\mathsf{R}_{\mathsf{L}}+\mathsf{R}_{\mathsf{K}})}$ of sequences $W_2^n(m, l, k, \hat{m}, \hat{l}, \hat{k})$ with indices $(\hat{m}, \hat{l}, \hat{k}) \in \mathcal{M} \times \mathcal{M}_{\mathsf{L}} \times \mathcal{M}_{\mathsf{K}}$ according to the i.i.d. conditional distribution $\mathcal{Q}_{W_2|W_1}$ depending on $W_1^n(m, l, k)$.

Encoding function at the beginning of block $b \in \{2, \dots B-1\}$.

1) The encoder observes the sequence of channel states S_{b-1}^n corresponding to the block b-1 and finds the indices $(l_{b-1}, j_{b-1}) \in \mathcal{M}_{\mathsf{L}} \times \mathcal{M}_{\mathsf{J}}$ such that $(S^n(l_{b-1}, j_{b-1}), S_{b-1}^n) \in T_{\delta}(\mathcal{P})$ for the distribution $\mathcal{P}(s, \hat{s}) = \mathcal{P}(s)\mathbb{1}(\hat{s} = s) \ \forall (s, \hat{s}) \in S \times S.$

2) The encoder observes the message m_b and the index l_{b-1} and recalls $W_1^n(m_{b-1}, l_{b-2}, k_{b-1})$ corresponding to the block b-1. It finds the index $k_b \in \mathcal{M}_K$ such that $(S_{b-1}^n, W_1^n(m_{b-1}, l_{b-2}, k_{b-1}), W_2^n(m_{b-1}, l_{b-2}, k_{b-1}, m_b, l_{b-1}, k_b)) \in T_{\delta}(\mathcal{Q}).$

3) The encoder sends X_b^n drawn from the i.i.d. conditional distribution $\mathcal{Q}_{X|SW_1}$ depending on $W_1^n(m_b, l_{b-1}, k_b)$ and S_b^n observed causally on the current block $b \in \{2, \ldots B-1\}$.

Decoding function at the end of block $b \in \{2, \dots B-1\}$.

1) The receiver recalls Y_{b-1}^n and the indices $(m_{b-1}, l_{b-2}, k_{b-1})$ corresponding to $W_1^n(m_{b-1}, l_{b-2}, k_{b-1})$ decoded at the end of the block b-1.

2) The receiver observes Y_b^n and finds the triple of indices (m_b, l_{b-1}, k_b) such that $(Y_b^n, W_1^n(m_b, l_{b-1}, k_b)) \in T_{\delta}(\mathcal{Q})$ and $(Y_{b-1}^n, W_1^n(m_{b-1}, l_{b-2}, k_{b-1}))$,

 $W_2^n(m_{b-1}, l_{b-2}, k_{b-1}, m_b, l_{b-1}, k_b)) \in T_{\delta}(\mathcal{Q}).$

3) The receiver returns the message m_b corresponding to block b.

4) The receiver returns V_{b-1}^n drawn from the conditional distribution $\mathcal{Q}_{V|YW_1W_2}$ depending on $(Y_{b-1}^n, W_1^n(m_{b-1}, l_{b-2}, k_{b-1})),$

 $W_2^n(m_{b-1}, l_{b-2}, k_{b-1}, m_b, l_{b-1}, k_b)).$

5) The receiver knows that over block b-1, the sequences $(S_{b-1}^n, W_1^n(m_{b-1}, l_{b-2}, k_{b-1}), W_2^n(m_{b-1}, l_{b-2}, k_{b-1}, m_b, l_{b-1}, k_b), X_{b-1}^n, Y_{b-1}^n, V_{b-1}^n) \in T_{\delta}(\mathcal{Q})$ and the sequence of states S_{b-1}^n belongs to the bin with index $l_{b-1} \in \mathcal{M}_{\mathsf{L}}$.

Initialization of the encoder. Arbitrary indices (m_1, l_0, k_1) are given to both encoder and decoder. The encoder sends the sequence $X_{b_1}^n$ drawn according to the conditional distribution $\mathcal{Q}_{X|SW_1}$ depending on $(S_{b_1}^n, W_1^n(m_1, l_0, k_1))$. At the beginning of the second block b_2 , encoder recalls $W_1^n(m_1, l_0, k_1)$, observes the message m_2 , finds the index l_1 such that $(S_{b_1}^n, S^n(l_1, j_1)) \in T_{\delta}(\mathcal{P})$ and finds the index k_2 such that $(S_{b_1}^n, W_1^n(m_1, l_0, k_1), W_2^n(m_1, l_0, k_1, m_2, l_1, k_2)) \in T_{\delta}(\mathcal{Q})$. The encoder sends $X_{b_2}^n$ drawn from the conditional distribution $\mathcal{Q}_{X|SW_1}$ depending on $(S_{b_2}^n, W_1^n(m_2, l_1, k_2))$. The index m_1 does not correspond to an informational message.

Initialization of the decoder. At the end of second block b_2 , the decoder finds the triple of indices (m_2, l_1, k_2) such that $(Y_{b_2}^n, W_1^n(m_2, l_1, k_2)) \in T_{\delta}(\mathcal{Q})$ and $(Y_{b_1}^n, W_1^n(m_1, l_0, k_1), W_2^n(m_1, l_0, k_1, m_2, l_1, k_2)) \in T_{\delta}(\mathcal{Q})$. The decoder returns the message m_2 corresponding to the block b_2 and the sequence $V_{b_1}^n \in \mathcal{V}^n$ drawn from the conditional probability $\mathcal{Q}_{V|YW_1W_2}$ depending on $(Y_{b_1}^n, W_1^n(m_1, l_0, k_1), W_2^n(m_1, l_0, k_1, m_2, l_1, k_2))$. The decoder knows that over the first block b_1 , the sequence $S_{b_1}^n$ belongs to the bin l_1 . The sequences $(S_{b_1}^n, W_1^n(m_1, l_0, k_1), W_2^n(m_1, l_0, k_1, m_2, l_1, k_2), X_{b_1}^n, Y_{b_1}^n, V_{b_1}^n) \in T_{\delta}(\mathcal{Q})$ and $(S_{b_2}^n, W_1^n(m_2, l_1, k_2), K_{b_1}^n, k_1)$.

 $W_2^n(m_2, l_1, k_2, m_3, l_2, k_3), X_{b_2}^n, Y_{b_2}^n, V_{b_2}^n) \in T_{\delta}(\mathcal{Q}).$

Last block at the encoder. At the beginning of the last block B, the encoder recalls $W_1^n(m_{B-1}, observes message <math>m_B$, finds the index l_{B-1} such that $(S_{B-1}^n, S^n(l_{B-1}, j_{B-1})) \in T_{\delta}(\mathcal{P})$. It finds the index k_B such that $(S_{B-1}^n, W_1^n(m_{B-1}, l_{B-2}, k_{B-1}), W_2^n(m_{B-1}, l_{B-2}, k_{B-1})$

 $k_{B-1}, m_B, l_{B-1}, k_B) \in T_{\delta}(\mathcal{Q})$. The encoder sends the sequence X_B^n drawn from the conditional distribution $\mathcal{Q}_{X|SW_1}$ depending on $(S_B^n, W_1^n(m_B, l_{B-1}, k_B))$.

Last block at the decoder. At the end of the last block B, the decoder finds the triple of indices (m_B, l_{B-1}, k_B) such that $(Y_B^n, W_1^n(m_B, l_{B-1}, k_B)) \in T_{\delta}(\mathcal{Q})$ and $(Y_{B-1}^n, W_1^n(m_{B-1}, l_{B-2}, k_{B-1}))$, $W_2^n(m_{B-1}, l_{B-2}, k_{B-1}, m_B, l_{B-1}, k_B) \in T_{\delta}(\mathcal{Q})$. The decoder returns the message m_B corresponding to the last block B and the sequence $V_{B-1}^n \in \mathcal{V}^n$ drawn from the conditional probability $\mathcal{Q}_{V|YW_1W_2}$ depending on $(Y_{B-1}^n, W_1^n(m_{B-1}, l_{B-2}, k_{B-1}))$,

 $W_2^n(m_{B-1}, l_{B-2}, k_{B-1}, m_B, l_{B-1}, k_B))$. The decoder knows that over the block B - 1, the sequence S_{B-1}^n belongs to the bin l_{B-1} . Then $(S_{B-1}^n, W_1^n(m_{B-1}, l_{B-2}, k_{B-1}))$,

 $W_2^n(m_{B-1}, l_{B-2}, k_{B-1}, m_B, l_{B-1}, k_B), X_{B-1}^n, Y_{B-1}^n, V_{B-1}^n)$

 $\in T_{\delta}(\mathcal{Q})$ but $(S_B^n, W_{1,B}^n, W_{2,B}^n, X_B^n, Y_B^n, V_B^n) \notin T_{\delta}(\mathcal{Q})$ on the last block *B*. The decoder does not know the index l_B of the bin corresponding to sequence S_B^n .

In the following, we introduce the notation $W_{1,b}^n = W_1^n(m_b, l_{b-1}, k_b)$ and $W_{2,b}^n = W_2^n(m_b, l_{b-1}, k_b, m_{b+1}, l_b, k_{b+1})$, with $b \in \{1, \ldots, B-1\}$. If there is no error in the coding scheme, the messages (m_2, \ldots, m_B) are correctly decoded and the decoder knows the bin indices (l_1, \ldots, l_{b-1}) of the sequences $(S_1^n, \ldots, S_{b-1}^n)$, and $(S_b^n, W_{1,b}^n, W_{2,b}^n, X_b^n, Y_b^n, V_b^n) \in T_{\delta}(\mathcal{Q})$, for each blocks $b \in \{1, \ldots, B-1\}$.

B. Rate parameters R, R_L and R_K

1) At the end of block $b \in \{2, ..., B\}$, the decoder observes (Y_{b-1}^n, Y_b^n) and decodes $(W_{1,b-1}^n, W_{2,b-1}^n)$ corresponding to the block b - 1. Intuitively, the observation of $(W_{1,b-1}^n, W_{2,b-1}^n, Y_{b-1}^n)$ leaks $nI(S; W_1, W_2, Y) = nI(S; W_2, Y|W_1)$ bits of information regarding S_{b-1}^n . By fixing the rate parameter $\mathsf{R}_{\mathsf{L}} = \mathsf{E} - I(S; W_1, W_2, Y)$, the encoder will transmit $n\mathsf{R}_{\mathsf{L}} = n(\mathsf{E} - I(S; W_1, W_2, Y))$ additional bits of information corresponding to the state sequence S_{b-1}^n . As it will be proven in the Section A-E, the leakage rate $I(S_{b-1}^n; Y_{b-1}^n)$ over block b-1 is close to $n(I(S; W_1, W_2, Y) + \mathsf{E} - I(S; W_1, W_2, Y)) = n\mathsf{E}$. We fix the rate parameter R_{L} equal to:

The first inequality $I(S; W_1, W_2, Y) \leq \mathsf{E}$ in (42) implies there exists a positive rate parameter R_{L} . In case of equality $\mathsf{E} = I(S; W_1, W_2, Y)$, then the rate $\mathsf{R}_{\mathsf{L}} = 0$ and no index $l \in \mathcal{M}_{\mathsf{L}}$ is transmitted to the decoder.

2) The rates parameters R_L , R_J corresponding to the indices (l_{b-1}, j_{b-1}) , guarantee that almost every sequences S_{b-1}^n appear in the codebook.

3) The rates parameter R_{K} corresponding to the index k_b , is used by the encoder in order to correlate $(W_1^n(m_{b-1}, l_{b-2}, k_{b-1}), W_2^n(m_{b-1}, l_{b-2}, k_{b-1}, m_b, l_{b-1}, k_b))$ with S_{b-1}^n .

$$\mathbf{R}_{\mathbf{K}} = I(W_2; S|W_1) + \varepsilon, \tag{47}$$

Since the random variables W_1 and S are independent, we have $I(W_1, W_2; S) = I(W_2; S|W_1)$.

4) The rate parameters R, R_L , R_K are correctly decoded if

where (50) comes from the independence between W_1 and S; (51) comes from the Markov chain $Y - \bigoplus (W_1, S) \bigoplus W_2$ stated in Remark II.4.

Equation (43) implies that for each block $b \in \{2, ..., B\}$, the indices with rates R, R_L, R_K are recovered by the decoder, with large probability. Hence the rate of the total code of length N = nB is given by

The properties of the typical sequences, see [38, pp. 27], implies that for all $\varepsilon > 0$ there exists $n_1 \in \mathbb{N}^*$ such that for all $n \ge n_1$, the expected probability of the error event is bounded by

From the covering Lemma, see [38, pp. 62],

implies that $\forall \varepsilon > 0, \ \exists n_3 \in \mathbb{N}^{\star}$ such that $\forall n \ge n_3$,

We show \widetilde{Q}^N is close to the empirical distribution Q^N over all the *B* blocks, for a number of blocks $B \in \mathbb{N}^*$ sufficiently large, *i.e.* for which $\frac{2}{B}|\mathcal{S} \times \mathcal{X} \times \mathcal{Y} \times \mathcal{V}| \leq \varepsilon$. The term at line (66) is equal to zero since the causal encoding and the i.i.d. property of the channel state, imply that the random variables $(S_{b+1}^n, \ldots, S_B^n)$ are independent of the message M_{b+1} and of the random variables $(S_b^n, W_{1,b}^n, W_{2,b}^n, Y_b^n, L_b)$ of the block b, and the term at line (67) is equal to zero since in the encoding process, the sequence S_b^n only affects the choice of the bin index L_b and of the sequences $(W_{1,b}^n, W_{2,b}^n, Y_b^n)$ of the current block b. This induces the following Markov chain: $S_b^n \rightarrow (W_{1,b}^n, W_{2,b}^n, Y_b^n, L_b, C) \rightarrow (Y^{nB}, M_{b+1}, S_{b+1}^n, \ldots, S_B^n)$, that is valid for each block $b \in \{1, \ldots, B-1\}$. The sequence S_b^n is correlated with the random variables of the other blocks $b' \neq b$ only through $(W_{1,b}^n, W_{2,b}^n, Y_b^n, L_b, C)$.

By considering a fixed sequence $W_{1,b}^n$ and fixed indices (L_b, M_{b+1}) , the encoder chooses an index $K_{b+1} \in \mathcal{M}_K$ corresponding to the sequence $W_{2,b}^n$. Hence, the sequence $W_{2,b}^n$ belongs to the bin of cardinality $|\mathcal{M}_K|$. The rate parameters are given by $\mathsf{R}_{\mathsf{L}} = \mathsf{E} - I(S; W_1, W_2, Y) - 2\varepsilon$ and $\mathsf{R}_{\mathsf{K}} = I(W_2; S|W_1) + \varepsilon$; (74) comes from the independence between W_1 and S that induces $I(S; W_2|W_1) = I(S; W_1, W_2)$.

For each block $b \in \{1, ..., B-1\}$, we introduce the random event of error $E_b \in \{0, 1\}$ defined with respect to the achievable distribution $\mathcal{Q}_{SXW_1W_2YV}$, as follows:

F. Conclusion of the achievability proof of Theorem II.3

APPENDIX B

CONVERSE PROOF OF THEOREM II.3

A. Information Constraints

Consider that the triple of rate, state leakage and distribution ($\mathsf{R}, \mathsf{E}, \mathcal{Q}_{SXYV}$) is achievable by using a sequence of codes with causal encoding. We simplify the notation by using \mathcal{Q} in place of \mathcal{Q}_{SXYV} and

We introduce the random variable T that is uniformly distributed over the indices $\{1, \ldots, n\}$ and we denote by $W_{1,T}$, $W_{2,T}$, S_T , X_T , Y_T , V_T the corresponding averaged random variables. where (225), comes from the hypothesis F = 0, which guarantees the correct decoding of the message m based on the observation of y^n ; (226) is a reformulation; (227) comes from the identification of the auxiliary random variable $w_{1,i} = (m, y^{-i})$; (228) comes from the introduction of the uniform random variable T; (230) comes from the identification of the auxiliary random variables $w_1 = (w_{1,T}, T)$. APPENDIX F

Case of H(S) = 0 in the achievability proof of Theorem II.3

In this section, we consider the case where H(S) = 0. We choose a target distribution Q_{XYV} that decomposes as $Q_{XYV} = Q_X T_{Y|X} Q_{V|XY}$. Standard channel coding arguments, see [38, Sec. 3.1], show that a pair (\mathbf{R}, Q_{XYV}) is achievable if and only if

$$\mathsf{R} \le I(X;Y). \tag{238}$$

We recover the information constraints of Theorem II.3 by setting E = 0, $W_1 = X$ and $|W_2| = 1$.

We denote by $\mathcal{P}_{W_1}^{\star}$ and $\mathcal{P}_{X|W_1S}^{\star}$ the distributions that achieve the maximum in (241). We define $\mathcal{Q}_{SW_1W_2XYV}^{\star} = \mathcal{P}_S \mathcal{P}_{W_1}^{\star} \mathcal{P}_{W_2} \mathcal{P}_{X|W_1S}^{\star} \mathcal{T}_{Y|XS} \mathcal{Q}_V$ where V is independent of (S, W_1, W_2, X, Y) and W_2 is independent of (S, W_1, X, Y) , hence $I(W_2; S|W_1) = I(W_2; Y|W_1) = 0$, and therefore

$$I_{\mathcal{Q}^{\star}}(W_1, W_2; Y) - I_{\mathcal{Q}^{\star}}(W_2; S | W_1) = I_{\mathcal{Q}^{\star}}(W_1; Y) > 0.$$

We assume that the distributions $Q_{SW_1W_2XYV}$ and $Q_{SW_1W_2XYV}^{\star}$ are selected according to the random variable $T \in \{0, 1\}$, where T = 0 corresponds to the distribution $Q_{SW_1W_2XYV}$ and T = 1 corresponds to the distribution $Q_{SW_1W_2XYV}^{\star}$. By hypothesis, we have

This show the existence of a distribution $\widetilde{\mathcal{Q}}_{SW_1TW_2XYV}$ that decomposes as

that converges to the distribution $Q_{SW_1W_2XYV}$ as $\mathbb{P}(T=1)$ goes to zero, and that satisfies the information constraint (247) with strict inequality. Thus the achievability proof of Appendix A applies.

where (251) comes from the hypothesis $I(S; W_1, W_2, Y) = I(W_1, S; Y)$ and (252) comes from the independence between W_1 and S.

Moreover, the two Markov chains $W_2 \rightarrow (W_1, S) \rightarrow X$ and $Y \rightarrow (X, S) \rightarrow (W_1, W_2)$ induce $W_2 \rightarrow (W_1, S) \rightarrow Y$. Therefore, we have

$$W_2 \twoheadrightarrow (W_1, S) \twoheadrightarrow Y \Longleftrightarrow I(W_2; Y|W_1, S) = 0, \tag{253}$$

We design a coding scheme for this special case.

Codebook. We choose a typical sequence W_1^n that is known by both the encoder and the decoder.

Encoder. At stage $i \in \{1, ..., n\}$, the encoder observes the symbol S_i , recalls the sequence W_1^n and generates X^n according to the i.i.d. conditional distribution $\mathcal{Q}_{X|SW_1}$.

Decoder. The decoder observes the sequence of channel output Y^n , recalls the pre-defined sequence W_1^n and generates sequence W_2^n according to the i.i.d. conditional distribution $\mathcal{Q}_{W_2|YW_1}$ which, according to (255), satisfies $\mathcal{Q}_{W_2}(\cdot|w_1, y) = \mathcal{Q}_{W_2}(\cdot|w_1, s)$ for all $(w_1, s, y) \in \mathcal{W}_1 \times \mathcal{S} \times \mathcal{Y}$ such that $\mathcal{Q}(w_1, s, y) > 0$. Then, the decoder generates V^n by using the conditional distribution $\mathcal{Q}_{V|W_1W_2Y}$.

This coding scheme achieves the target distribution

APPENDIX H

CARDINALITY BOUND FOR THEOREM II.3

Lemma 9 We consider the following information constraints with two auxiliary random variables (W_1, W_2)

$$I(S; W_1, W_2, Y) \le \mathbf{E} \le H(S),$$

The cardinality of the supports of the auxiliary random variables (W_1, W_2) are bounded by

$$\max(|\mathcal{W}_1|, |\mathcal{W}_2|) \le d+1, \qquad \text{with} \qquad d = |\mathcal{S} \times \mathcal{X} \times \mathcal{Y} \times \mathcal{V}|.$$

This result is based on the Lemma of Fenchel-Eggleston-Carathéodory, see [38, pp. 631], and the proof is provided below. From Lemma 9, we deduce the cardinality bounds of Theorems IV.2 and IV.4.

Proof. [Lemma 9] We denote by $d = |S \times X \times Y \times V|$, the cardinality of the product of the discrete sets. We consider the family of continuous functions $h_i : \Delta(S \times X \times Y \times V) \mapsto \mathbb{R}$, with $i \in \{1, \ldots, d+1\}$, defined as follows:

$$h_i \Big(\mathcal{P}_{SXYV|W_1W_2} \Big) = \begin{cases} \mathcal{P}_{SXYV|W_1W_2}(i), & \text{for } i \in \{1, \dots, d-1\}, \\ H(Y|S, W_1 = w_1), & \text{for } i = d, \\ H(S|Y, W_1 = w_1, W_2 = w_2), & \text{for } i = d+1. \end{cases}$$

The support Lemma, see [38, pp. 631], implies that there exists a pair of auxiliary random variables $(W'_1, W'_2) \sim \mathcal{P}_{W'_1W'_2}$ defined on a set $\mathcal{W}'_1 \times \mathcal{W}'_2$ with finite cardinality $\max(|\mathcal{W}'_1|, |\mathcal{W}'_2|) \leq d+1$ such that for all $i \in \{1, \ldots, d+1\}$ we have:

$$\int_{\mathcal{W}_1 \times \mathcal{W}_2} h_i \Big(\mathcal{P}_{SXYV|W_1W_2} \Big) dF(w_1, w_2) = \sum_{(w_1', w_2') \in \mathcal{W}_1' \times \mathcal{W}_2'} h_i \Big(\mathcal{P}_{SXYV|W_1'W_2'} \Big) \mathcal{P}(w_1'w_2').$$

This implies that the probability \mathcal{P}_{SXYV} is preserved and we have:

It is a direct consequence of the strictly causal encoding function, the non-causal decoding function and the memoryless property of the channel $\mathcal{T}_{Y|XS}$.

We introduce the random variable T that is uniformly distributed over the indices $\{1, \ldots, n\}$ and the corresponding mean random variables $W_{2,T}$, S_T , X_T , Y_T , V_T . The auxiliary random variable $W_2 = (W_{2,T}, T)$ belongs to the set of distributions \mathbb{Q}_{sc} and satisfies the information constraints of Theorem V.2

where (386) comes from the definition of achievable information leakage rate E, stated in equation (379); (389) comes from equation (380) and Fano's inequality, see [38, pp. 19]; (392) comes from the strictly causal encoding $X_i = f_i(M, S^{i-1})$ that implies $I(S_i; X_i | Y_{i+1}^n, Y_i, M, S^{i-1}) = 0$, for all $i \in \{1, ..., n\}$; (393) comes from the introduction of the auxiliary random variable $W_{2,i} = (M, S^{i-1}, Y_{i+1}^n)$, for all $i \in \{1, ..., n\}$; (394) comes from the introduction of the uniform random variable T over $\{1, ..., n\}$ and the introduction of the corresponding mean random variables $S_T, W_{2,T}, X_T, Y_T$; (395) comes from identifying $W_2 = (W_{2,T}, T)$; (396) comes from the empirical coordination requirement as stated in Lemma 4, since the sequences of symbols (S^n, X^n, Y^n, V^n) are not jointly typical with small error probability $\mathbb{P}(E = 1)$; (397) comes from Lemma 6. The sequences of symbols (S^n, X^n, Y^n, V^n) are jointly typical, hence the distribution of the mean random variables $\mathcal{P}_{S_T X_T Y_T V_T | E=0}$ is close to the target distribution \mathcal{Q}_{SXYV} . The result of [34, Lemma 2.7, pp. 19] concludes.

Second Constraint: From (135), we have

where (400) comes from the definition of achievable rate and information leakage (R,E), stated in equations (378) and (379); (402) comes from equation (380) and Fano's inequality, see [38, pp. 19]; (403) comes from the independence between the message M and the channel states S^n , hence $I(M;Y^n) \leq$ $I(M;Y^n,S^n) = I(M;Y^n|S^n)$; (405) comes from the Markov chain $Y^n \Leftrightarrow (X^n,S^n) \Leftrightarrow M$, induced by the channel; (406) comes from the memoryless property of the channel that implies: $H(Y^n|S^n,X^n) =$ nH(Y|X,S).

Conclusion: If the triple of rate, information leakage and distribution ($\mathsf{R}, \mathsf{E}, \mathcal{Q}_{SXYV}$) is achievable with a code with strictly causal encoding, then the following equations are satisfied for all $\varepsilon > 0$:

$$I(S; X, Y, W_2) - 4\varepsilon \le \mathsf{E} \le H(S) + \varepsilon, \tag{407}$$

This corresponds to (36) and (37) and this concludes the converse proof of Theorem V.2.
