# The Capacity Region of the Arbitrarily Varying MAC: With and Without Constraints

#### Abstract

We determine both the random code capacity region and the deterministic code capacity region of the arbitrarily varying multiple access channel (AVMAC) under input and state constraints. The underlying assumption is that zero-rate transmission can be arbitrary in the deterministic setting as well, where there is no shared randomness. As opposed to the random code capacity region, the deterministic code capacity region can be non convex. For the AVMAC without constraints, the characterization due to Ahlswede and Cai is complete except for two cases, pointed out in the literature as an open problem. The missing piece is obtained as a special case of our results.

## I. Introduction

The arbitrarily varying multiple access channel (AVMAC) without constraints was first considered by Jahn [33, 34], to describe a communication network with unknown statistics, that may change over time. It is especially relevant to uplink communication in the presence of an adversary, or a jammer, attempting to disrupt communication. Another scenario is that one of multiple users becomes adversarial and attacks the other users [43, 44]. Jahn established the 'divided-randomness capacity region' [33, 34], namely the capacity region achieved when each encoder shares randomness with the decoder independently, and showed that the AVMAC inherits some of the properties of its single user counterpart. In particular, the divided-randomness capacity region is not necessarily achievable using deterministic codes [8]. Furthermore, Jahn showed that the deterministic code capacity region either coincides with the divided-randomness capacity region or else, it has an empty interior [33, 34]. This phenomenon is an analogue of Ahlswede's dichotomy property [1]. Therefore, in order to calculate the deterministic code capacity region, it is essential to confirm that the capacity region has a non empty interior, i.e. positive rates are achievable using deterministic codes. Gubner [24] presented three computable conditions which are necessary for this to hold, and conjectured that they are also sufficient. Then, Ahlswede and Cai [3] confirmed Gubner's conjecture [24], implying that Gubner's conditions are both necessary and sufficient for a non empty capacity region. As Wiese and Boche recognized, the case where exactly one of the users has zero capacity has remained an open problem [48, Remark 9], until now.

Furthermore, constraints are known to have a drastic effect on the behavior of the single user AVC [17], while the effect on the AVMAC has never been established. Csiszár and Narayan [17] considered the single user AVC when input and state constraints are imposed on the user and the jammer, respectively. Such constraints are often due to power limitations of the transmitter and the jamming signal. Not only the constrained setting provokes serious technical difficulties analytically, but also, as shown in [17], there is a significant effect on the behavior of the deterministic code capacity. Specifically, it is shown in [17] that dichotomy in the notion of [1] no longer holds when state constraints are imposed on the jammer. That is, the deterministic code capacity can be lower than the random code capacity, and yet non-zero. As for the AVMAC under constraints, Gubner and Hughes [27] determined the divided-randomness capacity region. Results on the Gaussian AVMAC were recently presented in a talk [31]. Solved examples can be found in [25, 26] as well.

Other relevant settings include the AVMAC with conferencing encoders [48, 47, 9], list codes [40, 9, 11], fading [45, 10], and an eavesdropper [29, 5, 13]. Among the models of channel uncertainty are also the compound multiple access channel [ $16,38,49,51,39]$ and the random parameter multiple access with side information [19, 12, 46, 36, 37]. After the publication of this work, Sangwan et al. [43] considered a multiple access channel with three users, where one of the users is possibly adversarial, yet the identity of the jamming user is not known in advance (see also [44]).

In this work, we consider the AVMAC when input and state constraints are imposed on the users and the jammer, respectively. We give full characterization for both the random code capacity region and the deterministic code capacity region. The underlying assumption is that zero-rate transmission can be arbitrary in the deterministic setting as well, where there is no shared randomness. In particular, the encoder can simulate a random transmission, as long as there is no shared randomness
between the parties. This assumption is generally considered to be natural for real-life communication systems (see e.g. remark in [16, p. 282]), whereas shared randomness is often impractical [34, 6]. Nonetheless, the analysis without shared randomness is a lot more challenging. When state constraints are imposed, the operational time sharing argument does not apply to the AVMAC. Roughly speaking, using a code over a part of the blocklength effectively increases the state constraint and loosens the restriction on the jammer over this period of time. Thus, it becomes essential to replace the operational time sharing argument with coded time sharing [28]. Our decoder is then a coded time sharing variant of Ahlswede and Cai's decoding rule [3], while the time sharing sequence is deterministic and known to the jammer as well. Yet, a fundamental difference between our coding scheme and the one in [3] arises from the dichotomy discrepancy, sinceAhlswede and Cai only showed achievability of positive rates $R_{1}=R_{2}=\varepsilon>0$, proving that the capacity region has a non-empty interior. However, for the AVMAC under constraints, dichotomy does not apply and achievability of positive rates is insufficient. Hence, in our problem, proving achievability is more demanding. Hereby, the codebooks construction and the analysis are based on generalization of the techniques by Csiszár and Narayan [17], along with the insights of Ahlswede and Cai [3]. The converse proof involves observations by Gubner [24] as well. As a special case, we obtain a full characterization of the capacity region of the AVMAC without constraints, filling the gap left by Ahlswede and Cai [3].

## II. Definitions and Previous Results

We use the following notation conventions throughout. Calligraphic letters $\mathcal{X}, \mathcal{S}, \mathcal{Y}, \ldots$ are used for finite sets. Lowercase letters $x, s, y, \ldots$ stand for constants and values of random variables, and uppercase letters $X, S, Y, \ldots$ stand for random variables. The distribution of a random variable $X$ is specified by a probability mass function (pmf) $P_{X}(x)=p(x)$ over a finite set $\mathcal{X}$. The set of all pmfs over $\mathcal{X}$ is denoted by $\mathcal{P}(\mathcal{X})$. We use $x^{j}=\left(x_{1}, x_{2}, \ldots, x_{j}\right)$ to denote a sequence of letters from $\mathcal{X}$. A random sequence $X^{n}$ and its distribution $P_{X^{n}}\left(x^{n}\right)$ are defined accordingly. The type $\hat{P}_{x^{n}}$ of a given sequence $x^{n}$ is defined as the empirical distribution $\hat{P}_{x^{n}}(a)=N\left(a \mid x^{n}\right) / n$ for $a \in \mathcal{X}$, where $N\left(a \mid x^{n}\right)$ is the number of occurrences of the symbol $a$ in the sequence $x^{n}$. A type class is denoted by $\mathcal{T}^{n}(\hat{P})=\left\{x^{n}: \hat{P}_{x^{n}}=\hat{P}\right\}$. For a pair of integers $i$ and $j$, $1 \leq i \leq j$, we define the discrete interval $[i: j]=\{i, i+1, \ldots, j\}$. In the continuous case, we use the cumulative distribution function $F_{Z}(z)=\operatorname{Pr}(Z \leq z)$ for $z \in \mathbb{R}$, or alternatively, the probability density function (pdf) $f_{Z}(z)$, when it exists.

## A. Channel Description

A state-dependent discrete memoryless multiple access channel (MAC) $\left(\mathcal{X}_{1} \times \mathcal{X}_{2} \times \mathcal{S}, W_{Y \mid X_{1}, X_{2}, S}, \mathcal{Y}\right)$ consists of finite input alphabets $\mathcal{X}_{1}$ and $\mathcal{X}_{2}$, state alphabet $\mathcal{S}$, output alphabet $\mathcal{Y}$, and a conditional pmf $W_{Y \mid X_{1}, X_{2}, S}$ over $\mathcal{Y}$. The channel is memoryless without feedback, and therefore $W_{Y^{n} \mid X_{1}^{n}, X_{2}^{n}, S^{n}}\left(y^{n} \mid x_{1}^{n}, x_{2}^{n}, s^{n}\right)=\prod_{i=1}^{n} W_{Y \mid X_{1}, X_{2}, S}\left(y_{i} \mid x_{1, i}, x_{2, i}, s_{i}\right)$. The AVMAC is a MAC with a state sequence of unknown distribution, not necessarily independent nor stationary. That is, $S^{n} \sim q\left(s^{n}\right)$ with an unknown joint pmf $q\left(s^{n}\right)$ over $\mathcal{S}^{n}$. In particular, $q\left(s^{n}\right)$ could give mass 1 to some state sequence $s^{n}$. The AVMAC is denoted by $\mathscr{A}=\left\{W_{Y \mid X_{1}, X_{2}, S}\right\}$.

The compound MAC is used as a tool in the analysis. Different models of compound MACs are described in the literature $[16,38]$. Here, the compound MAC is a channel with a discrete memoryless state, where the state distribution $q(s)$ is not known in exact, but rather belongs to a family of distributions $\mathcal{Q}$, with $\mathcal{Q} \subseteq \mathcal{P}(\mathcal{S})$. That is, the state sequence $S^{n}$ is independent and identically distributed (i.i.d.) according to $q(s)$, for some $\operatorname{pmf} q \in \mathcal{Q}$. We note that this differs from the classical definition of the compound channel, as in [16], where the state is fixed throughout the transmission. The compound MAC is denoted by $\mathscr{A}^{\mathcal{Q}}$.

## B. Coding

We introduce some preliminary definitions, starting with the definitions of a deterministic code and a random code for the AVMAC $\mathscr{A}$ under input and state constraints.
Definition 1 (Code). A $\left(2^{n R_{1}}, 2^{n R_{2}}, n\right)$ code for the AVMAC $\mathscr{A}$ consists of the following; two message sets $\left[1: 2^{n R_{1}}\right]$ and $\left[1: 2^{n R_{2}}\right]$, where $2^{n R_{1}}$ and $2^{n R_{2}}$ are assumed to be integers, two encoding functions $f_{1}:\left[1: 2^{n R_{1}}\right] \rightarrow \mathcal{X}_{1}^{n}$ and $f_{2}:\left[1: 2^{n R_{2}}\right] \rightarrow \mathcal{X}_{2}^{n}$, and a decoding function $g: \mathcal{Y}^{n} \rightarrow\left[1: 2^{n R_{1}}\right] \times\left[1: 2^{n R_{2}}\right]$.

Given a pair of messages $m_{1} \in\left[1: 2^{n R_{1}}\right]$ and $m_{2} \in\left[1: 2^{n R_{2}}\right]$, Encoder $k$ transmits the codeword $x_{k}^{n}=f_{k}\left(m_{k}\right)$, for $k=1,2$. The decoder receives the channel output $y^{n}$, and finds an estimate of the message pair $\left(\hat{m}_{1}, \hat{m}_{2}\right)=g\left(y^{n}\right)$. We denote the code by $\mathscr{C}=\left(f_{1}(\cdot), f_{2}(\cdot), g(\cdot)\right)$.

We proceed now to coding schemes when using stochastic-encoders stochastic-decoder pairs with common randomness. We distinguish between two classes; random codes [48] and divided-randomness codes [34].
Definition 2 (Random code). A $\left(2^{n R_{1}}, 2^{n R_{2}}, n\right)$ random code for the AVMAC $\mathscr{A}$ consists of a collection of $\left(2^{n R_{1}}, 2^{n R_{2}}, n\right)$ codes $\left\{\mathscr{C}_{\gamma}=\left(f_{1, \gamma}, f_{2, \gamma}, g_{\gamma}\right)\right\}_{\gamma \in \Gamma}$, along with a probability distribution $\mu(\gamma)$ over the code collection $\Gamma$. We denote such a code by $\mathscr{C}^{\Gamma}=\left(\mu, \Gamma,\left\{\mathscr{C}_{\gamma}\right\}_{\gamma \in \Gamma}\right)$.
Definition 3 (Divided-randomness code). A $\left(2^{n R_{1}}, 2^{n R_{2}}, n\right)$ divided-randomness code for the AVMAC $\mathscr{A}$ is a random code, where the random element consists of two components, i.e. $\gamma=\left(\gamma_{1}, \gamma_{2}\right)$, one at each encoder. The components are drawn
according to a product distribution $\mu\left(\gamma_{1}, \gamma_{2}\right)=\mu_{1}\left(\gamma_{2}\right) \mu_{2}\left(\gamma_{2}\right)$ over $\Gamma_{1} \times \Gamma_{2}$. Then, User 1 sends $x_{1}^{n}=f_{1, \gamma_{1}}\left(m_{1}\right)$, User 2 sends $x_{2}^{n}=f_{2, \gamma_{2}}\left(m_{2}\right)$, and upon receiving the channel output $y^{n}$, the receiver applies a decoding mapping $g_{\gamma_{1}, \gamma_{2}}$. We denote such a code by $\mathscr{C}^{\Gamma_{1} \times \Gamma_{2}}$.

The general random code in Definition 2 can thus be thought of as a divided-randomness code where statistical dependence between $\gamma_{1}$ and $\gamma_{2}$ is viable.
Remark 1. Our underlying assumption is that zero-rate transmission can be arbitrary in the deterministic setting as well, as long as there is no shared randomness. In particular, if User 1 has zero capacity while User 2 transmits at a positive rate, then Encoder 1 may transmit a random sequence at zero rate, i.e. $x_{1}^{n}=f_{1}(\sigma)$ where $\sigma \in\left[1: 2^{n \varepsilon}\right]$ is a random parameter, which is not known to the other encoder, the decoder, nor the jammer, and the decoder is not required to recover the value of $\sigma$. This means that the encoders have access to $n \varepsilon$ random bits, where $\varepsilon>0$ is arbitrarily small. Since the randomness is local, such an assumption is generally considered to be reasonable (see e.g. remark in [16, p. 282]). On the other hand, in the codes in Definitions 2 and 3, there is shared randomness between the encoders and the decoder, which is often impractical [34, 6].

One may also consider the AVMAC with stochastic encoders, i.e. when Encoder $k$ transmits $x_{k}^{n}=f_{k}\left(m_{k}, \sigma_{k}\right)$, for $m_{k} \in$ [1: $\left.2^{n R_{k}}\right], k=1,2$, where $\sigma_{1}$ and $\sigma_{2}$ the random parameters. Then, our results apply to the stochastic encoder capacity region.

## C. Input and State Constraints

Next, we consider input constraints and state constraint, imposed on the encoders and the jammer, respectively. We note that the constraints specifications are known to both users and the jammer in this model. Let $\phi_{k}: \mathcal{X}_{k} \rightarrow[0, \infty), k=1,2$, and $l: \mathcal{S} \rightarrow[0, \infty)$ be some given bounded functions, and define

Let $\Omega_{1}>0, \Omega_{2}>0$, and $\Lambda>0$. Below, we specify the input constraints $\left(\Omega_{1}, \Omega_{2}\right)$ and state constraint $\Lambda$, corresponding to the functions $\phi_{1}^{n}\left(x_{1}^{n}\right), \phi_{2}^{n}\left(x_{2}^{n}\right)$, and $l^{n}\left(s^{n}\right)$, respectively, for the AVMAC and the compound MAC.

Given input constraints ( $\Omega_{1}, \Omega_{2}$ ), the encoding functions need to satisfy

That is, the inputs satisfy $\phi_{1}^{n}\left(X_{1}^{n}\right) \leq \Omega_{1}$ and $\phi_{2}^{n}\left(X_{2}^{n}\right) \leq \Omega_{2}$ with probability 1 . Moving to the state constraint $\Lambda$, we have different definitions for the AVMAC and for the compound MAC.

The compound MAC has a constraint on average, with a memoryless state such that $\mathbb{E}_{q} l(S) \leq \Lambda$, while the AVMAC has an almost-surely constraint, with a non-stationary state sequence such that $l^{n}\left(S^{n}\right) \leq \Lambda$ with probability 1 . Explicitly, we say that a compound MAC $\mathscr{A}^{\mathcal{Q}}$ is under a state constraint $\Lambda$, if the set $\mathcal{Q}$ of state distributions is limited to $\mathcal{Q} \subseteq \overline{\mathcal{P}}_{\Lambda}(\mathcal{S})$, where

As for the AVMAC $\mathscr{A}$, it is now assumed that the joint distribution of the state sequence is limited to $q\left(s^{n}\right) \in \mathcal{P}_{\Lambda}\left(\mathcal{S}^{n}\right)$, where

This includes the case of a deterministic unknown state sequence, i.e. when $q$ gives probablity 1 to a particular $s^{n} \in \mathcal{S}^{n}$ with $l^{n}\left(s^{n}\right) \leq \Lambda$.

We may assume without loss of generality that $0 \leq \Omega_{k} \leq \phi_{k, \max }, k=1,2$, and $0 \leq \Lambda \leq l_{\max }$, where $\phi_{k, \max }=$ $\max _{x_{k} \in \mathcal{X}_{k}} \phi_{k}\left(x_{k}\right), k=1,2$, and $l_{\max }=\max _{s \in \mathcal{S}} l(s)$. It is also assumed that for some $a \in \mathcal{X}_{1}, b \in \mathcal{X}_{2}$, and $s_{0} \in \mathcal{S}$, $\phi_{1}(a)=\phi_{2}(b)=l\left(s_{0}\right)=0$.

## D. Capacity Region Under Constraints

We move to the definition of achievable rate pairs and the capacity region of the AVMAC $\mathscr{A}$ under input and state constraints. Deterministic codes and random codes over the AVMAC $\mathscr{A}$ are defined as in Definition 1 and Definition 2, respectively, with the additional constraint (3) on the codebook.

Define the conditional probability of error of a code $\mathscr{C}$ given a state sequence $s^{n} \in \mathcal{S}^{n}$ by

Now, define the average probability of error of $\mathscr{C}$ for some distribution $q\left(s^{n}\right) \in \mathcal{P}\left(\mathcal{S}^{n}\right)$,

Definition 4 (Achievable rate pair and capacity region under constraints). A code $\mathscr{C}=\left(f_{1}, f_{2}, g\right)$ is a called a $\left(2^{n R_{1}}, 2^{n R_{2}}, n, \varepsilon\right)$ code for the AVMAC $\mathscr{A}$ under input constraints $\left(\Omega_{1}, \Omega_{2}\right)$ and state constraint $\Lambda$, when (3) is satisfied and

or, equivalently, $P_{e \mid s^{n}}^{(n)}(\mathscr{C}) \leq \varepsilon$ for all $s^{n} \in \mathcal{S}^{n}$ with $l^{n}\left(s^{n}\right) \leq \Lambda$.
We say that a rate pair $\left(R_{1}, R_{2}\right)$ is achievable, under input constraints $\left(\Omega_{1}, \Omega_{2}\right)$ and state constraint $\Lambda$, if for every $\varepsilon>0$ and sufficiently large $n$, there exists a $\left(2^{n R_{1}}, 2^{n R_{2}}, n, \varepsilon\right)$ code for the AVMAC $\mathscr{A}$ under input constraints $\left(\Omega_{1}, \Omega_{2}\right)$ and state constraint $\Lambda$. The operational capacity region is defined as the closure of the set of achievable rate pairs, and it is denoted by $\mathbb{C}(\mathscr{A})$. We use the term 'capacity region' referring to this operational meaning, and in some places we call it the deterministic code capacity region in order to emphasize that achievability is measured with respect to deterministic codes.

Analogously to the deterministic case, a $\left(2^{n R_{1}}, 2^{n R_{2}}, n, \varepsilon\right)$ random code $\mathscr{C} \Gamma=\left(\mu, \Gamma,\left\{\mathscr{C}_{\gamma}\right\}_{\gamma \in \Gamma}\right)$ for the AVMAC $\mathscr{A}$, under input constraints $\left(\Omega_{1}, \Omega_{2}\right)$ and state constraint $\Lambda$, satisfies the requirements

The capacity region achieved by random codes is then denoted by $\mathbb{C}^{\star}(\mathscr{A})$, and it is referred to as the random code capacity region. In addition, a $\left(2^{n R_{1}}, 2^{n R_{2}}, n, \varepsilon\right)$ divided-randomness code $\mathscr{C} \Gamma_{1} \times \Gamma_{2}$ satisfies the requirements

The capacity region achieved by divided-randomness codes is then denoted by $\mathbb{C}^{\star \star}(\mathscr{A})$, and it is referred to as the dividedrandomness capacity region.

Note that based on the definitions above,

\mathbb{C}(\mathscr{A}) \subseteq \mathbb{C}^{\star \star}(\mathscr{A}) \subseteq \mathbb{C}^{\star}(\mathscr{A}) \tag{10}
\end{equation*}
$$

The definitions above are naturally extended to the compound MAC, under input constraints $\left(\Omega_{1}, \Omega_{2}\right)$ and state constraint $\Lambda$, by limiting the requirements (3), (7) and (8) to i.i.d. state distributions $q \in \mathcal{Q}$. The respective deterministic code capacity region, random code capacity region, and divided-randmoness capacity region $\mathbb{C}\left(\mathscr{A}^{\mathcal{Q}}\right), \mathbb{C}^{\star}\left(\mathscr{A}^{\mathcal{Q}}\right)$ and $\mathbb{C}^{\star \star}\left(\mathscr{A}^{\mathcal{Q}}\right)$ are defined accordingly.

## E. Related Work

1) Without Constraints: In this subsection, we briefly review known results for the case where there are no constraints. Denote the deterministic code capacity region and the divided-randomness capacity regions of the AVMAC free of constraints by $\mathbb{C}\left(\mathscr{A}_{\text {free }}\right)$ and $\mathbb{C}^{\star \star}\left(\mathscr{A}_{\text {free }}\right)$, respectively. We note that this is a special case of the AVMAC under constraints, with $\Omega_{1} \geq \phi_{1, \text { max }}$, $\Omega_{2} \geq \phi_{2, \max }$, and $\Lambda \geq l_{\text {max }}$.

We cite the divided-randomness capacity theorem of the AVMAC free of constraints, due to Jahn [33]. Let

& R_{2} \leq \min _{q(s \mid u)} I_{q}\left(X_{2} ; Y \mid X_{1}, U\right) \\
& R_{1}+R_{2} \leq \min _{q(s \mid u)} I_{q}\left(X_{1}, X_{2} ; Y \mid U\right)
\end{align*}\right\}
$$

with $\left(U, X_{1}, X_{2}, S\right) \sim P_{U}(u) P_{X_{1} \mid U}\left(x_{1} \mid u\right) P_{X_{2} \mid U}\left(x_{2} \mid u\right) q(s \mid u)$.
Theorem 1 (see [33, Theorem 1a]). The divided-randomness capacity region of an AVMAC, free of constraints, is given by

$$
\begin{equation*}
\mathbb{C}^{\star \star}\left(\mathscr{A}_{\text {free }}\right)=C^{\star \star}\left(\mathscr{A}_{\text {free }}\right) . \tag{12}
\end{equation*}
$$

Remark 2. Originally, the random code capacity region is expressed in [33, Theorem 1] as a closed convex hull of a union of regions. Achievability of (11) is established through time sharing.

Now, we move to the deterministic code capacity region.
Theorem 2 (Ahlswede's Dichotomy [33, 34]). The capacity region of an AVMAC, free of constraints, either coincides with the divided-randomness capacity region or else, it has an empty interior. That is, $\mathbb{C}\left(\mathscr{A}_{\text {free }}\right)=\mathbb{C}^{\star \star}\left(\mathscr{A}_{\text {free }}\right)$ or else, int $\left(\mathbb{C}\left(\mathscr{A}_{\text {free }}\right)\right)=\emptyset$.

Necessary and sufficient conditions for the capacity region to have a non-empty interior were established by Gubner [24, 23] and Ahlswede and Cai [3] in terms of the following definition.
Definition 5. [24, 23, 22] A state-dependent MAC $W_{Y \mid X_{1}, X_{2}, S}$ is said to be

1) symmetrizable- $\mathcal{X}_{1} \times \mathcal{X}_{2}$ if for some conditional distribution $J\left(s \mid x_{1}, x_{2}\right)$,

& \forall x_{1}, \tilde{x}_{1} \in \mathcal{X}_{1}, x_{2}, \tilde{x}_{2} \in \mathcal{X}_{2}, y \in \mathcal{Y} \tag{13}
\end{align*}
$$

Equivalently, the channel $\widetilde{W}\left(y \mid x_{1}, x_{2}, \tilde{x}_{1}, \tilde{x}_{2}\right)=\sum_{s \in \mathcal{S}} W_{Y \mid X, S}\left(y \mid x_{1}, x_{2}, s\right) J\left(s \mid \tilde{x}_{1}, \tilde{x}_{2}\right)$ is symmetric with respect to $\left(x_{1}, x_{2}\right)$ and $\left(\tilde{x}_{1}, \tilde{x}_{2}\right)$.
2) symmetrizable- $\mathcal{X}_{1} \mid \mathcal{X}_{2}$ if for some conditional distribution $J_{1}\left(s \mid x_{1}\right)$,

\sum_{s \in \mathcal{S}} W_{Y \mid X_{1}, X_{2}, S}\left(y \mid x_{1}, x_{2}, s\right) J_{1}\left(s \mid \tilde{x}_{1}\right)=\sum_{s \in \mathcal{S}} W_{Y \mid X_{1}, X_{2}, S}\left(y \mid \tilde{x}_{1}, x_{2}, s\right) J_{1}\left(s \mid x_{1}\right), \forall x_{1}, \tilde{x}_{1} \in \mathcal{X}_{1}, x_{2} \in \mathcal{X}_{2}, y \in \mathcal{Y} \tag{14}
\end{equation*}
$$

3) symmetrizable- $\mathcal{X}_{2} \mid \mathcal{X}_{1}$ if for some conditional distribution $J_{2}\left(s \mid x_{2}\right)$,

\begin{equation*}
\sum_{s \in \mathcal{S}} W_{Y \mid X_{1}, X_{2}, S}\left(y \mid x_{1}, x_{2}, s\right) J_{2}\left(s \mid \tilde{x}_{2}\right)=\sum_{s \in \mathcal{S}} W_{Y \mid X_{1}, X_{2}, S}\left(y \mid x_{1}, \tilde{x}_{2}, s\right) J_{2}\left(s \mid x_{2}\right), \forall x_{1} \in \mathcal{X}_{1}, x_{2}, \tilde{x}_{2} \in \mathcal{X}_{2}, y \in \mathcal{Y} \tag{15}
\end{equation*}
$$

We say that the AVMAC $\mathscr{A}$ is symmetrizable- $\mathcal{X}_{1} \times \mathcal{X}_{2}$ if the corresponding state-dependent MAC $W_{Y \mid X_{1}, X_{2}, S}$ is symmetrizable$\mathcal{X}_{1} \times \mathcal{X}_{2}$, and similarly for symmetrizability $-\mathcal{X}_{1} \mid \mathcal{X}_{2}$ and symmetrizability- $\mathcal{X}_{2} \mid \mathcal{X}_{1}$.
Example 1. [24] Consider an adder channel specified by $Y=X_{1}+X_{2}+S$, where $\mathcal{X}_{1}=\mathcal{X}_{2}=\{0,1\}$. For $\mathcal{S}=\{0,1,2\}$, the AVMAC satisfies the conditions in Definition 5, as (13)-(15) hold with $J\left(s \mid x_{1}, x_{2}\right)=\delta\left(s-x_{1}-x_{2}\right), J_{1}\left(s \mid x_{1}\right)=\delta\left(s-x_{1}\right)$, $J_{2}\left(s \mid x_{2}\right)=\delta\left(s-x_{2}\right)$, where $\delta(u)$ is the Kronecker delta function, i.e. $\delta(u)=1$ for $u=0$, and $\delta(u)=0$ otherwise. On the other hand, it is shown in [24] that for $\mathcal{S}=\{0,1\}$, the AVMAC is symmetrizable- $\mathcal{X}_{1} \mid \mathcal{X}_{2}$ and symmetrizable- $\mathcal{X}_{2} \mid \mathcal{X}_{1}$, but non-symmetrizable- $\mathcal{X}_{1} \times \mathcal{X}_{2}$.

Ahlswede and Cai [3] showed by example that it is also possible that an AVMAC satisfies the first condition in Definition 5 but does not satisfy the other two.
Example 2. [3] Consider a binary MAC, with $\mathcal{X}_{1}=\mathcal{X}_{2}=\mathcal{S}=\mathcal{Y}=\{0,1\}$, specified by the following. For $s=0$,

& W_{Y \mid X_{1}, X_{2}, S}(\cdot \mid 0,0,0)=W_{Y \mid X_{1}, X_{2}, S}(\cdot \mid 1,1,0)=(1,0) \\
& W_{Y \mid X_{1}, X_{2}, S}(\cdot \mid 1,0,0)=W_{Y \mid X_{1}, X_{2}, S}(\cdot \mid 0,1,0)=\left(\frac{1}{2}, \frac{1}{2}\right) \tag{16}
\end{align*}
$$

and for $s=1$,

\begin{align*}
& W_{Y \mid X_{1}, X_{2}, S}(\cdot \mid 0,0,1)=W_{Y \mid X_{1}, X_{2}, S}(\cdot \mid 1,1,1)=\left(\frac{1}{2}, \frac{1}{2}\right) \\
& W_{Y \mid X_{1}, X_{2}, S}(\cdot \mid 1,0,1)=W_{Y \mid X_{1}, X_{2}, S}(\cdot \mid 0,1,1)=(0,1) \tag{17}
\end{align*}
$$

Then it is shown in [3] that $W_{Y \mid X_{1}, X_{2}, S}$ is symmetrizable- $\mathcal{X}_{1} \times \mathcal{X}_{2}$, as (13) holds for $J\left(s \mid x_{1}, x_{2}\right)=1$ for $\left(x_{1}=x_{2}, s=0\right)$ or $\left(x_{1} \neq x_{2}, s=1\right)$, and $J\left(s \mid x_{1}, x_{2}\right)=0$ otherwise. On the other hand, plugging $x_{2}=0$ in (14) yields $J_{1}\left(s \mid x_{1}\right)=\delta\left(s-x_{1}\right)$, while plugging $x_{2}=1$ in (14) yields $J_{1}\left(s \mid x_{1}\right)=\delta\left(s-\left(1-x_{1}\right)\right)$. This means that fixing $x_{2}$, both marginals $W_{Y \mid X_{1}, X_{2}, S}(\cdot \mid \cdot, 0, \cdot)$ and $W_{Y \mid X_{1}, X_{2}, S}(\cdot \mid \cdot 1, \cdot)$ of User 1 are symmetrizable in the single-user sense, i.e. as in [17, Definition 2]. However, the AVMAC is not symmetrizable- $\mathcal{X}_{1} \mid \mathcal{X}_{2}$, because there is no $J_{1}\left(s \mid x_{1}\right)$ which symmetrizes both marginals at the same time. In a similar manner, (15) implies a contradiction as well. Therefore, the AVMAC is symmetrizable- $\mathcal{X}_{1} \times \mathcal{X}_{2}$, but non-symmetrizable- $\mathcal{X}_{2} \mid \mathcal{X}_{1}$ and non-symmetrizable- $\mathcal{X}_{1} \mid \mathcal{X}_{2}$.

Intuitively, symmetrizability $-\mathcal{X}_{1} \times \mathcal{X}_{2}$ identifies a poor channel, where the jammer can impinge the communication scheme by randomizing the state sequence $S^{n}$ according to $J^{n}\left(s^{n} \mid \tilde{x}_{1}^{n}, \tilde{x}_{2}^{n}\right)=\prod_{i=1}^{n} J\left(s_{i} \mid \tilde{x}_{1, i}, \tilde{x}_{2, i}\right)$, for some codewords $\tilde{x}_{1}^{n}$ and $\tilde{x}_{2}^{n}$ in the codebooks of User 1 and User 2, respectively. Suppose that the transmitted codewords are $x_{1}^{n}$ and $x_{2}^{n}$. The codewords $\tilde{x}_{1}^{n}$ and $\tilde{x}_{2}^{n}$ can be thought of as impostors transmitted by the jammer. Now, since the "average channel" $\widetilde{W}$ is symmetric with respect to $\left(x_{1}^{n}, x_{2}^{n}\right)$ and $\left(\tilde{x}_{1}^{n}, \tilde{x}_{2}^{n}\right)$, the codeword pairs appear to the receiver as equally likely. Similarly, if the AVMAC is
symmetrizable- $\mathcal{X}_{1} \mid \mathcal{X}_{2}$, then the decoder confuses between $\left(x_{1}^{n}, x_{2}^{n}\right)$ and $\left(\tilde{x}_{1}^{n}, x_{2}^{n}\right)$, and if the AVMAC is symmetrizable $-\mathcal{X}_{2} \mid \mathcal{X}_{1}$, then the decoder confuses between $\left(x_{1}^{n}, x_{2}^{n}\right)$ and $\left(x_{1}^{n}, \tilde{x}_{2}^{n}\right)$, where $\tilde{x}_{1}$ and $\tilde{x}_{2}$ are the codewords chosen by the jammer. Indeed, by [24], if one of the conditions in Definition 5 holds, then the capacity region of the AVMAC free of constraints has an empty interior. This means that the capacity region $\mathbb{C}\left(\mathscr{A}_{\text {free }}\right)$ is either an interval or $\{(0,0)\}$, i.e. one of the users or both have zero capacity.

Ahlswede and Cai [3] proved that the three types of non-symmetrizability are not only a necessary condition for a non-empty capacity region, but they are sufficient conditions as well. This yields the following theorem.
Theorem 3 (see [24, 23][3, Theorem 1]). An AVMAC free of constraints has a capacity region with a non-empty interior, i.e. $\operatorname{int}\left(\mathbb{C}\left(\mathscr{A}_{\text {free }}\right)\right) \neq \emptyset$, if and only if it is non-symmetrizable- $\mathcal{X}_{1} \times \mathcal{X}_{2}$, non-symmetrizable- $\mathcal{X}_{1} \mid \mathcal{X}_{2}$, and non-symmetrizable- $\mathcal{X}_{2} \mid \mathcal{X}_{1}$.

The following theorem combines the results by Gubner [24, 23] and Ahlswede and Cai [3]. This statement was also given by Boche and Wiese [48, 47], who considered the AVMAC with conferencing encoders.
Theorem 4 (see [48, Theorem 8]). There are four scenarios for the capacity region of the AVMAC free of constraints:
a) If $W_{Y \mid X_{1}, X_{2}, S}$ is not symmetrizable- $\mathcal{X}_{1} \times \mathcal{X}_{2},-\mathcal{X}_{1} \mid \mathcal{X}_{2}$, nor $-\mathcal{X}_{2} \mid \mathcal{X}_{1}$, then

$$
\begin{equation*}
\mathbb{C}\left(\mathscr{A}_{\text {free }}\right)=C^{\star \star}\left(\mathscr{A}_{\text {free }}\right) . \tag{18}
\end{equation*}
$$

b) If $W_{Y \mid X_{1}, X_{2}, S}$ is not symmetrizable- $\mathcal{X}_{1} \times \mathcal{X}_{2}$ nor $-\mathcal{X}_{2} \mid \mathcal{X}_{1}$, but symmetrizable- $\mathcal{X}_{1} \mid \mathcal{X}_{2}$, then

$$
\begin{equation*}
\mathbb{C}\left(\mathscr{A}_{\text {free }}\right) \subseteq\left\{\left(0, R_{2}\right): R_{2} \leq \min _{q(s)} \max _{P_{X_{1}} P_{X_{2}}} I_{q}\left(X_{2} ; Y \mid X_{1}\right)\right\} \tag{19}
\end{equation*}
$$

c) If $W_{Y \mid X_{1}, X_{2}, S}$ is not symmetrizable- $\mathcal{X}_{1} \times \mathcal{X}_{2}$ nor $-\mathcal{X}_{1} \mid \mathcal{X}_{2}$, but symmetrizable- $\mathcal{X}_{2} \mid \mathcal{X}_{1}$, then

$$
\begin{equation*}
\mathbb{C}\left(\mathscr{A}_{\text {free }}\right) \subseteq\left\{\left(R_{1}, 0\right): R_{1} \leq \min _{q(s)} \max _{P_{X_{1}} P_{X_{2}}} I_{q}\left(X_{1} ; Y \mid X_{2}\right)\right\} \tag{20}
\end{equation*}
$$

d) In all other cases,

$$
\begin{equation*}
\mathbb{C}\left(\mathscr{A}_{\text {free }}\right)=\{(0,0)\} . \tag{21}
\end{equation*}
$$

Remark 3. Observe that in Case b) and Case c) of Theorem 4, the characterization is incomplete. As pointed out by Wiese and Boche, this has remained an open problem for nearly 20 years [48, Remark 9] (see also [47, Remark 5.6]). At first glance, it may appear as if achievability in Cases b) and c) immediately follows from the capacity theorem of the single user AVC [17]. Consider Case c), and denote the channel from $X_{1}$ to $Y$, for a fixed $x_{2} \in \mathcal{X}_{2}$, by $W_{Y \mid X_{1}, S}^{\left(x_{2}\right)}=W_{Y \mid X_{1}, X_{2}, S}\left(\cdot \mid \cdot, x_{2}, \cdot\right)$. Then, based on the results by Csiszár and Narayan for the single user AVC [17], if $W_{Y \mid X_{1}, S}^{\left(x_{2}\right)}$ is non-symmmetrizable- $\mathcal{X}_{1}$ for some $x_{2} \in \mathcal{X}_{2}$, then the capacity of User 1 is positive. Furthermore, if $W_{Y \mid X_{1}, S}^{\left(x_{2}\right)}$ is non-symmetrizable for all $x_{2} \in \mathcal{X}_{2}$, then User 1 can achieve every rate $R_{1}<\min _{q(s)} \max _{P_{X_{1} P_{X_{2}}}} I_{q}\left(X_{1} ; Y \mid X_{2}\right)$. However, in Case c), knowing that the AVMAC is non-symmetrizable- $\mathcal{X}_{1} \mid \mathcal{X}_{2}$ does not guarantee that $W_{Y \mid X_{1}, S}^{\left(x_{2}\right)}$ is non-symmetrizable for all $x_{2} \in \mathcal{X}_{2}$. Actually, it only guarantees that the channels $W_{Y \mid X_{1}, S}^{\left(x_{2}\right)}, x_{2} \in \mathcal{X}_{2}$, are not all symmetrized by a single $J_{1}\left(s \mid x_{1}\right)$ (see Example 2). Therefore, it is not immediately clear whether the conditions in Cases b) and c) are sufficient for achievability. We are going to fill this gap and show that (19) and (20) hold with equality.
Remark 4. The dichotomy property in Theorem 2 was proved using Ahlswede's Elimination Technique [1], where the encoder transmits the random elements $\gamma_{1}$ and $\gamma_{2}$ over a negligible portion of the blocklength. The Elimination Technique only works without state constraints [17], since positive capacity under a state constraint does not guarantee reliable transmission over a fraction of the blocklength. Moreover, as Csiszár and Narayan demonstrated in the single user setting, the dichotomy property does not hold when state constraints are imposed on the jammer. That is, the deterministic code capacity can be lower than the capacity with shared randomness, even if positive rates are achievable with deterministic codes. This demonstrates the significant effect that constraints have on the behavior of the deterministic code capacity of arbitrarily varying channels.
2) Divided-Randomness Capacity Region: Gubner and Hughes [27] considered the AVMAC under input and state constraints, and determined the divided-randomness capacity region, i.e. assuming each encoder shares an independent random element with the decoder. Their result is given below. Define
with $\left(U, X_{1}, X_{2}, S\right) \sim P_{U}(u) P_{X_{1} \mid U}\left(x_{1} \mid u\right) P_{X_{2} \mid U}\left(x_{2} \mid u\right) q(s \mid u)$. It is shown in [27] that the region above is not necessarily convex. In Remark 7, we discuss the interpretation of this property and the connection to the statistical independence between the variables $S$ and $U$ above.

Theorem 5 (see [27]). The divided-randomness capacity region of the AVMAC under input constraints $\left(\Omega_{1}, \Omega_{2}\right)$ and state constraint $\Lambda$ is given by

$$
\begin{equation*}
\mathbb{C}^{\star \star}(\mathscr{A})=C^{\star \star}(\mathscr{A}) . \tag{23}
\end{equation*}
$$

In the next sections, we determine both the random code capacity region and the deterministic code capacity region.

## III. Main Results - Random Code Capacity Region

In this section, we establish the random code capacity region of the AVMAC under input and state constraints. To this end, we first give an auxiliary result on the compound MAC.

## A. The Compound MAC

We begin with the capacity theorem for the compound MAC $\mathscr{A}^{\mathcal{Q}}$ under input constraints $\left(\Omega_{1}, \Omega_{2}\right)$ and state constraint $\Lambda$. This is an auxiliary result, obtained by a simple extension of related work (see [38]). Let

\mathbb{E} \phi_{k}\left(X_{k}\right) \leq \Omega_{k}, k=1,2}}{ }\left\{\begin{array}{rr}
\left(R_{1}, R_{2}\right): & R_{1} \leq \\
R_{2} \leq & \inf _{q \in \mathcal{Q}} I_{q}\left(X_{1} ; Y \mid X_{2}, U\right) \\
& \inf _{q \in \mathcal{Q}} I_{q}\left(X_{2} ; Y \mid X_{1}, U\right) \\
& R_{1}+R_{2} \leq \\
& \inf _{q \in \mathcal{Q}} I_{q}\left(X_{1}, X_{2} ; Y \mid U\right)
\end{array}\right\}
$$

with $\left(U, X_{1}, X_{2}, S\right) \sim P_{U}(u) P_{X_{1} \mid U}\left(x_{1} \mid u\right) P_{X_{2} \mid U}\left(x_{2} \mid u\right) q(s)$.
Lemma 6. The capacity region of the compound MAC $\mathscr{A}^{\mathcal{Q}}$ is given by

$$
\begin{equation*}
\mathbb{C}\left(\mathscr{A}^{\mathcal{Q}}\right)=\mathrm{C}\left(\mathscr{A}^{\mathcal{Q}}\right) \tag{25}
\end{equation*}
$$

and it is identical to the divided-randomness capacity region and the random code capacity region, i.e. $\mathbb{C}^{\star}\left(\mathscr{A}^{\mathcal{Q}}\right)=\mathbb{C}^{\star \star}\left(\mathscr{A}^{\mathcal{Q}}\right)=$ $\mathbb{C}\left(\mathscr{A}^{\mathcal{Q}}\right)$.

The proof of Lemma 6 is given in Appendix A.
Remark 5. Regardless of the statement in Lemma 6, the capacity region of the compound MAC must be convex, due to the operational time sharing argument. That is, if $\left(R_{1, u}, R_{2, u}\right), u \in \mathcal{U}$, are achievable rate pairs, then any convex combination

\begin{equation*}
\left(\sum_{u \in \mathcal{U}} \theta_{u} R_{1, u}, \sum_{u \in \mathcal{U}} \theta_{u} R_{2, u}\right) \tag{26}
\end{equation*}
$$

is achievable, for $\theta_{u} \geq 0, \sum_{u \in \mathcal{U}} \theta_{u}=1$. To achieve this rate pair, one can employ a sequence of consecutive codes that achieve ( $R_{1, u}, R_{2, u}$ ), such that $\theta_{u}$ is the fraction of the corresponding code length from the total blocklength (see [14, Section 15.3.3]). In the classical setting, the random variable $U$ is referred to as the time sharing variable, since $P_{U}(u)$ can be interpreted as the coefficient $\theta_{u}$ in the convex combination. We explain below why this interpretation is lacking in the case of the compound MAC. Furthermore, we will see that operational time sharing is impossible for the AVMAC, yet the convexity of $C\left(\mathscr{A}^{\mathcal{Q}}\right)$ will play a role (see the remarks below Theorem 7).

For the classical MAC, achievability of the capacity region can be established by first considering independent inputs $\left(X_{1}, X_{2}\right) \sim P_{X_{1}}\left(x_{1}\right) P_{X_{2}}\left(x_{2}\right)$, and then generalizing to $P_{U}(u) P_{X_{1} \mid U}\left(x_{1} \mid u\right) P_{X_{2} \mid U}\left(x_{2} \mid u\right)$ through the operational time sharing argument. However, for the compound MAC, a straightforward application of the operational time sharing argument is insufficient, because

\inf _{q \in \mathcal{Q}} I_{q}\left(X_{1}, X_{2} ; Y \mid U\right) \geq \sum_{u \in \mathcal{U}} p(u) \cdot \inf _{q \in \mathcal{Q}} I_{q}\left(X_{1}, X_{2} ; Y \mid U=u\right) \tag{27}
\end{equation*}
$$

in general, and similarly for $I_{q}\left(X_{1} ; Y \mid X_{2}, U\right)$ and $I_{q}\left(X_{2} ; Y \mid X_{1}, U\right)$. Hence, achievability of the convex combination in the RHS of (27) does not immediately imply achievability of the LHS.

We deduce that the external variable $U$ may not represent the operational time sharing strategy as in the classical sense. Nevertheless, we associate $U$ with coded time sharing [28] [21, Section 4.5.3]. Specifically, to prove Lemma 6, we use a coded time sharing scheme, where a time sharing sequence $U^{n}$ is generated, and then a single codebook is selected accordingly.

## B. The AVMAC

We determine the random code capacity region of the AVMAC under input constraints $\left(\Omega_{1}, \Omega_{2}\right)$ and state constraint $\Lambda$. As opposed to Theorem 5 by [27], considering divided-randomness coding, we address the case where the three parties, two encoders and decoder, share randomness together. The random code derivation is based on our result on the compound MAC and a simple extension of Ahlswede's RT.

Define $\left.C^{\star}(\mathscr{A}) \triangleq \mathrm{C}\left(\mathscr{A}^{\mathcal{Q}}\right)\right|_{\mathcal{Q}=\overline{\mathcal{P}}_{\Lambda}(\mathcal{S})}$, i.e.

with $\left(U, X_{1}, X_{2}, S\right) \sim P_{U}(u) P_{X_{1} \mid U}\left(x_{1} \mid u\right) P_{X_{2} \mid U}\left(x_{2} \mid u\right) q(s)$. Notice the resemblance between the random code capacity region formula (28) and the divided-randomness capacity region formula (22), as the only difference between the formulas is that the state $S$ and the "time-sharing" variable $U$ are statistically independent in the random code case, while $S$ and $U$ are dependent in the divided-randomness case. An intuitive interpretation is given in the remark.

Theorem 7. The random code capacity region of the AVMAC $\mathscr{A}$ under input constraints $\left(\Omega_{1}, \Omega_{2}\right)$ and state constraint $\Lambda$ is given by

\mathbb{C}^{\star}(\mathscr{A})=\mathrm{C}^{\star}(\mathscr{A}) . \tag{29}
\end{equation*}
$$

The proof of Theorem 7 is given in Appendix B. The proof is based on the aforementioned result on the compound MAC and an extension of Ahlswede's Robustification Technique [2]. Essentially, we use a reliable code for the compound MAC to construct a random code for the AVMAC by applying random permutations to each codeword symbols.

Remark 6. As opposed to the compound channel, the operational time sharing argument is not eligible for the AVC under a state constraint, even in the single user case, as we explain below. Suppose that two codebooks are used in time sharing, one of rate $R^{\prime}$ and length $\theta n$, and one of rate $R^{\prime \prime}$ and length $(1-\theta) n$, for $0<\theta<1$, where $R^{\prime}$ and $R^{\prime \prime}$ are both achievable for the AVC under a state constraint $\Lambda$. Due to the state constraint, it is guaranteed that $\sum_{i=1}^{n} l\left(S_{i}\right) \leq n \Lambda$ with probability 1 . However, the jammer is entitled to concentrate the jamming power on the first $\theta n$ symbols, in which case, $\sum_{i=1}^{\theta n} l\left(S_{i}\right)=n \Lambda$. If the jammer does so, then the first code, of rate $R^{\prime}$ and length $\theta n$, needs to be robust against a state sequence $S^{\theta n}$ with the following cost,

Therefore, in order to achieve the rate $R=\theta R^{\prime}+(1-\theta) R^{\prime \prime}$ with operational time sharing, the first coding rate $R^{\prime}$ needs to be achievable for an AVC under a state constraint $\Lambda / \theta$, and the second coding rate $R^{\prime \prime}$ needs to be achievable for a state constraint $\Lambda /(1-\theta)$, which is not guaranteed. Hence, operational time sharing is not eligible for neither the single user AVC, nor the AVMAC (see also [27]).

Nevertheless, we observe that using the proof technique in Appendix B, one can devise a reliable coding scheme with "shuffled time sharing". That is, instead of using the codes of rates $R^{\prime}$ and $R^{\prime \prime}$ above consecutively, random interleaving of the codes can be realized. Intuitively, the users are thus able to carry out a time sharing protocol of which the jammer is oblivious, which explains the statistical independence between the state $S$ and the time sharing variable $U$ in (28).
Remark 7. As mentioned above, the difference between the formulas given for the random code capacity region and for the divided-randomness capacity region is the statistical independence between the state and the time sharing variable. Now, we discuss the implications in terms of the convexity of the regions.

By Theorem 7 and Lemma 6, we have that the random code capacity region of the AVMAC under input and state constraints is the same as that of the compound MAC with $\mathcal{Q}=\overline{\mathcal{P}}_{\Lambda}(\mathcal{S})$. As a consequence, we have that the random code capacity region of the AVMAC is convex. It can also be verified directly that the set in the RHS of (28) is convex, as $(U, S) \sim P_{U}(u) q(s)$.
On the other hand, Gubner and Hughes [27] demonstrated that the divided-randomness capacity region given by (22) is not necessarily convex, as $(U, S) \sim P_{U}(u) q(s \mid u)$ (see Section IV in [27]). In their setting, the encoders have statistically independent random elements $\gamma_{1}$ and $\gamma_{2}$ (see Definition 3). Gubner and Hughes attribute the non-convexity to the preclusion of operational time sharing [27]. It is further mentioned in [27] that there are other instances of non-convex capacity regions in the literature, such as the asynchronous MAC [32, 42], where the users' timeframes do not synchronize hence time sharing does not work either. We observe that the "shuffled time sharing" mentioned in the previous remark could only work if the shared randomness element is exploited for the coordination between the users. Whereas, in a scenario where the random elements are independent, as in [27], such coordination is impossible.
In our setting, the random elements are not independent, as $\gamma_{1}=\gamma_{2}=\gamma$ ( $c f$. Definition 2 and Definition 3). In the remark that follows Definition 2 in [27], it is stated without proof that removing the restriction of independence could result in a
strictly larger capacity region. Indeed, our result above that $\mathbb{C}^{\star}(\mathscr{A})$ is convex implies that for the erasure AVMAC in [27, Section IV], our random code capacity region $\mathbb{C}^{\star}(\mathscr{A})$ must be strictly larger than the non-convex divided-randomness capacity region. Therefore, we have now validated the assertion by Gubner and Hughes [27]. Comparing (22) and (28), we infer that the conditioning of the state distribution on $U$ may lead to a strictly smaller region. Intuitively, knowing the time sharing protocol helps the jammer reduce the coding rates for such a channel.

## IV. Main Results - Deterministic Code Capacity Region

The principal result of this paper is the deterministic code capacity theorem, i.e. without shared randomness. The deterministic code derivation is independent of our previous results, and the analysis modifies the techniques of Csiszár and Narayan [17], and merges their ideas with those of Ahlswede and Cai [3].

Before we state the capacity theorem, we give the following definitions. Given an input distribution $P_{X_{1}, X_{2}} \in \mathcal{P}\left(\mathcal{X}_{1} \times \mathcal{X}_{2}\right)$, consider the average state costs below,

where the minimizations are over $J\left(s \mid x_{1}, x_{2}\right), J_{1}\left(s \mid x_{1}\right)$, and $J_{2}\left(s \mid x_{2}\right)$, which satisfy the symmetrizing conditions in (13), (14), and (15), respectively. We use the convention that a minimum over an empty set is $+\infty$. Then, for every $P_{U, X_{1}, X_{2}} \in$ $\mathcal{P}\left(\mathcal{U} \times \mathcal{X}_{1} \times \mathcal{X}_{2}\right)$, define

Intuitively, $\min \left\{\widetilde{\Lambda}\left(P_{U, X_{1}, X_{2}}\right), \widetilde{\Lambda}_{1}\left(P_{U, X_{1}}\right), \widetilde{\Lambda}_{2}\left(P_{U, X_{2}}\right)\right\}$ is the minimal average state cost which the jammer has to pay to symmetrize the channel, for a given inputs distribution $P_{X_{1}, X_{2} \mid U}$, where symmetrizing refers to using a conditional distribution that satisfies either one of the symmetrizability conditions in Definition 5. If this minimal state cost violates the state constraint $\Lambda$, then the jammer is prohibited from symmetrizing the channel.
Remark 8. The minimal average state cost can be expressed more explicitly as

with minimization over a set of distribution $\left\{J_{u}\right\}_{u \in \mathcal{U}}$, where each distribution $J_{u}\left(s \mid x_{1}, x_{2}\right)$ symmetrizes- $\mathcal{X}_{1} \times \mathcal{X}_{2}$ the AVMAC. Notice that the state distributions are indexed by the time sharing variable. This has the interpretation of a jamming scheme that varies over time in accordance with the time sharing sequence chosen by the users.
We have defined $\widetilde{\Lambda}\left(P_{U, X_{1}, X_{2}}\right), \widetilde{\Lambda}_{1}\left(P_{U, X_{1}}\right)$ and $\widetilde{\Lambda}_{2}\left(P_{U, X_{2}}\right)$ in (32) as the minimal average state costs which the jammer has to pay to symmetrize the channel, for a given input distribution $P_{U, X_{1}, X_{2}}$. Intuitively, the users are interested in restricting the jammer by increasing those costs as much as possible, hence the following quantities represent the best thresholds the users can obtain,

We note that $L^{*}, L_{1}^{*}$ and $L_{2}^{*}$ depend on the input constraints $\left(\Omega_{1}, \Omega_{2}\right)$, the MAC $W_{Y \mid X_{1}, X_{2}, S}$, and the state cost function $l: \mathcal{S} \rightarrow[0, \infty)$, but they do not depend on the state constraint $\Lambda$.
Definition 6. Define the rate region $\mathrm{C}(\mathscr{A})$ as follows.
a) If $L^{*}>\Lambda, L_{1}^{*}>\Lambda$, and $L_{2}^{*}>\Lambda$, then

Remark 9. Observe that the optimization set of the input distribution $P_{U} P_{X_{1} \mid U} P_{X_{2} \mid U}$ in (37) is a subset of the corresponding set in (22), for the divided-randomness capacity region, hence $C(\mathscr{A}) \subseteq C^{\star \star}(\mathscr{A})$. Furthermore, if the AVMAC is non-symmetrizable in the sense of neither $\mathcal{X}_{1} \times \mathcal{X}_{2}, \mathcal{X}_{1} \mid \mathcal{X}_{2}$, nor $\mathcal{X}_{2} \mid \mathcal{X}_{1}$, then $\widetilde{\Lambda}\left(P_{U, X_{1}, X_{2}}\right)=\widetilde{\Lambda}_{1}\left(P_{U, X_{1}}\right)=\widetilde{\Lambda}_{2}\left(P_{U, X_{2}}\right)=+\infty$, in which case we have that $\mathrm{C}(\mathscr{A})=\mathrm{C}^{\star \star}(\mathscr{A})$.
Theorem 8. Assume that $L^{*} \neq \Lambda, L_{1}^{*} \neq \Lambda$ and $L_{2}^{*} \neq \Lambda$. Then, the capacity region of the AVMAC $\mathscr{A}$ under input constraints $\left(\Omega_{1}, \Omega_{2}\right)$ and state constraint $\Lambda$ is given by

Furthermore, if $\mathscr{A}$ is non-symmetrizable- $\mathcal{X}_{1} \times \mathcal{X}_{2}$, non-symmetrizable- $\mathcal{X}_{1} \mid \mathcal{X}_{2}$, and non-symmetrizable- $\mathcal{X}_{2} \mid \mathcal{X}_{1}$, then the capacity region coincides with the divided-randomness capacity region, i.e. $\mathbb{C}(\mathscr{A})=\mathbb{C}^{\star \star}(\mathscr{A})=\mathrm{C}^{\star \star}(\mathscr{A})$.

The proof of Theorem 8 is given in Appendix E. The second part of the theorem follows from Remark 9 and (38). The proof does not use our results on the random code capacity region of the AVMAC and on the compound MAC, and it is independent of the divided-randomness analysis by Gubner and Hughes [27]. The analysis, however, makes use of the properties established for the decoding rule and codebooks specified below, in Subsections IV-A and IV-B. As mentioned, coded time sharing is an essential replacement for the classical operational time sharing argument, which cannot be applied to the AVMAC under constraints (see Remark 6). Hence, our analysis combines our coded time sharing variant of the decoder by Ahlswede and Cai [3], with our generalization of the codebook generated by Csiszár and Narayan [17]. The converse proof further uses Gubner's observations in [24].
Remark 10. As explained in Remark 3 for the AVMAC without constraints, the case where one of the users has zero capacity does not immediately follow from the results on the single user AVC. The reason behind this is that Gubner's second and third conditions are stronger than single-user symmetrizability, as defined in [17, Definition 2]. In particular, if the AVMAC is symmetrized- $\mathcal{X}_{1} \mid \mathcal{X}_{2}$ by $J_{1}\left(s \mid x_{1}\right)$, then the marginal AVC $W_{Y \mid X_{1}, S}$ is also symmetrized by $J_{1}\left(s \mid x_{1}\right)$, but the other direction is not true. In the constrained setting, this means that the minimal state cost $\widetilde{\Lambda}_{1}\left(P_{X_{1}}\right)$ for symmetrizability- $\mathcal{X}_{1} \mid \mathcal{X}_{2}$ can be higher than the minimal state cost $\widetilde{\Lambda}_{0}\left(P_{X_{1}}\right)$ in [17, Equation (2.13)], for symmetrizability of the marginal AVC $W_{Y \mid X_{1}, S}$. In Example 2, we have seen that the AVMAC is non-symmetrizable- $\mathcal{X}_{1} \mid \mathcal{X}_{2}$, even though the marginal $W_{Y \mid X_{1}, S}$ could be symmetrizable, in which case, $\widetilde{\Lambda}_{1}\left(P_{X_{1}}\right)=+\infty$ but $\widetilde{\Lambda}_{0}\left(P_{X_{1}}\right) \leq l_{\max }<\infty$. Therefore, even if $L_{1}^{*}>\Lambda$, it is not guaranteed that User 1 can achieve a positive rate.
Remark 11. The boundary case where either $L^{*}=\Lambda$ or $L_{k}^{*}=\Lambda, k=1,2$, remains unsolved. Even in the single user setting, say $\mathcal{X}_{2}=\emptyset$, the case of $L_{1}^{*}=\Lambda$ is an open problem (see [17]), although it is conjectured in [17] that the capacity is zero in this case. Similarly, we conjecture that the capacity region is $\mathbb{C}(\mathscr{A})=\mathrm{C}(\mathscr{A})$ for all values of $L^{*}, L_{1}^{*}$ and $L_{2}^{*}$. There are special cases where we can prove that this holds, given in the corollary below. The corollary generalizes the remark following Theorem 3 in [17].

Corollary 9. Let $\mathscr{A}$ be an AVMAC under input constraints $\left(\Omega_{1}, \Omega_{2}\right)$ and state constraint $\Lambda$, where $\mathscr{A}$ is symmetrizable- $\mathcal{X}_{1} \times \mathcal{X}_{2}$, symmetrizable- $\mathcal{X}_{1} \mid \mathcal{X}_{2}$, and symmetrizable- $\mathcal{X}_{2} \mid \mathcal{X}_{1}$. If the symmetrizability equations (13), (14), and (15) are only satisfied by conditional distributions $J\left(s \mid x_{1}, x_{2}\right), J_{1}\left(s \mid x_{1}\right) J_{2}\left(s \mid x_{2}\right)$ which are 0-1 laws, then

The proof of Corollary 9 is given in Appendix F. In particular, we note that the condition of 0-1 laws in Corollary 9 holds when the output $Y$ is a deterministic function of $X_{1}, X_{2}$ and $S$.

## A. Decoding Rule

We specify the decoding rule and state the corresponding properties, which are used in the analysis. As mentioned in Remark 6 above, we cannot use the operational time sharing argument for the AVMAC under constraints, and therefore, we use coded time sharing [28] [21, Section 4.5.3]. Our decoder is similar to that of Ahlswede and Cai [3], and the codebooks are generated based on the techniques of Csiszár and Narayan [17], along with the insights of Ahlswede and Cai [3]. We note that since the code is deterministic, the time sharing sequence is also deterministic, and it is known to the encoders, the decoder, and the jammer as well.

A fundamental difference between our coding scheme and the one in [3] arises from Ahlswede's dichotomy property. Specifically, Ahlswede and Cai only showed achievability of positive rates $R_{1}=R_{2}=\varepsilon>0$, proving that the capacity region has a non-empty interior. According to the dichotomy result in Theorem 2 by Jahn [33, 34], this implies that the capacity region of the AVMAC free of constraints is the same as the random code capacity region, which was also determined in [33, 34]. However, for the AVMAC under constraints, dichotomy does not apply and achievability of positive rates is insufficient. Thereby, our proof is a lot more involved than the one in [3].

To specify the decoding rule, we define the decoding sets $\mathcal{D}\left(m_{1}, m_{2}\right) \subseteq \mathcal{Y}^{n}$, for $\left(m_{1}, m_{2}\right) \in\left[1: 2^{n R_{1}}\right] \times\left[1: 2^{n R_{2}}\right]$, such that $g\left(y^{n}\right)=\left(m_{1}, m_{2}\right)$ iff $y^{n} \in \mathcal{D}\left(m_{1}, m_{2}\right)$.
Definition 7 (Decoder). Given the codebooks $\left\{f_{k}\left(m_{k}\right)\right\}_{m_{k} \in\left[1: 2^{n R_{k}}\right]}, k=1,2$, and a time sharing sequence $u^{n}$, declare that $y^{n} \in \mathcal{D}\left(m_{1}, m_{2}\right)$ if there exists $s^{n} \in \mathcal{S}^{n}$ with $l^{n}\left(s^{n}\right) \leq \Lambda$ such that the following hold.

1) For $\left(U, X_{1}, X_{2}, S, Y\right)$ which is distributed according to the joint type $\hat{P}_{u^{n}, f_{1}\left(m_{1}\right), f_{2}\left(m_{2}\right), s^{n}, y^{n}}$, we have that

We note that in Definition 7, the variables $U, X_{1}, X_{2}, \widetilde{X}_{1}, \widetilde{X}_{2}, S, \widetilde{S}, Y$ are dummy random variables, distributed according to the joint type of $\left(u^{n}, f_{1}\left(m_{1}\right), f_{2}\left(m_{2}\right), f_{1}\left(\widetilde{m}_{1}\right), f_{2}\left(\widetilde{m}_{2}\right), s^{n}, \widetilde{s}^{n}, y^{n}\right)$, where $u^{n}$ is a given time sharing sequence, $f_{1}\left(m_{1}\right), f_{2}\left(m_{2}\right)$ are "tested" codewords, $f_{1}\left(\widetilde{m}_{1}\right), f_{2}\left(\widetilde{m}_{2}\right)$ are competing codewords, $s^{n}$ is a "tested" state sequence, $\widetilde{s}^{n}$ is a competing state sequence, and $y^{n}$ is the received sequence. None of the sequences are random here. The Markov relation $U \bullet\left(X_{1}, X_{2}, S\right) \bullet Y$ may not hold for those dummy variables, and we may have that the conditional type $P_{Y \mid X_{1}, X_{2}, S}$ differs from the actual channel $W_{Y \mid X_{1}, X_{2}, S}$. Therefore, the divergences and mutual informations in Definition 7 could be positive.

For the definition above to be proper, we need to verify that the decoding sets are disjoint, as stated in the following lemma.

Lemma 10 (Decoding Disambiguity). Let $u^{n}$ be a given time sharing sequence, and denote by $P_{U}$ its type, that is, $P_{U}=\hat{P}_{u^{n}}$. ## B. Codebooks

While the decoding rule above is similar to that of Ahlswede and Cai [3], here we prove a generalization of a lemma by Csiszár and Narayan [17], in order to generate proper codebooks.

For every $\varepsilon>0$, sufficiently large $n$, rates $R_{k} \geq \varepsilon$ and types $P_{U}$ and $P_{k}=P_{X_{k} \mid U}$, $k=1,2$, there exist a time sharing sequence $u^{n} \in \mathcal{T}^{n}\left(P_{U}\right)$, and codebooks, $\left\{\left(x_{1}^{n}\left(m_{1}\right), x_{2}^{n}\left(m_{2}\right)\right): m_{k} \in\left[1: 2^{n R_{k}}\right], k=1,2\right\}$ of type $P_{1} \times P_{2}$, such that for every $a_{1}^{n} \in \mathcal{X}_{1}^{n}, a_{2}^{n} \in \mathcal{X}_{2}^{n}, s^{n} \in \mathcal{S}^{n}$ with $l^{n}\left(s^{n}\right) \leq \Lambda$, and every joint type $P_{U, X_{1}, X_{2}, \widetilde{X}_{1}, \widetilde{X}_{2}, S}$ with $P_{X_{1}, X_{2} \mid U}=P_{\widetilde{X}_{1}, \widetilde{X}_{2} \mid U}=P_{1} \times P_{2}$, the following hold.

## C. Examples

To illustrate our results, we give the following examples.
Example 3. (see [27]) In the first example, we use Corollary 9 and previous results by Gubner and Hughes [27] to show that the deterministic code capacity region can be non convex. Consider the state dependent erasure MAC, specified

Consider the AVMAC under a state constraint $\frac{1}{n} \sum_{i=1}^{n} s_{i} \leq \Lambda$, for $0<\Lambda \leq 1$, and with inactive input constraints, i.e. $\Omega_{k}=\phi_{k, \max }$ for $k=1,2$.

It can be readily verified that the symmetrizability conditions in Definition 5 hold when the distributions $J\left(s \mid x_{1}, x_{2}\right)$ and $J_{k}\left(s \mid x_{k}\right)$ assign unit probability to $S=1$. Then, $\widetilde{\Lambda}\left(P_{U, X_{1}, X_{2}}\right)=\widetilde{\Lambda}_{k}\left(P_{U, X_{k}}\right)=1$ for all $P_{U, X_{1}, X_{2}}$, hence $L^{*}=L_{k}^{*}=1$ for $k=1,2$. By Corollary 9, we have that without a state constraint, i.e. for $\Lambda=1$, the deterministic code capacity region is

Now, based on Theorem 5 (see [27]), we deduce that the deterministic code capacity region is the same as the dividedrandomness capacity region, i.e. $\mathbb{C}(\mathscr{A})=\mathbb{C}^{\star \star}(\mathscr{A})$. For the latter, Gubner and Hughes derive inner and outer bounds that are close enough in order to establish that $\mathbb{C}^{\star \star}(\mathscr{A})$ is non convex for high values of $r \geq 2$. This, in turn, implies that the deterministic code capacity region is also non convex in general.
Example 4. Let $\mathscr{A}$ be an AVMAC which consists of independent binary symmetric channels. Specifically, let the state and the output be pairs as well, i.e. $S=\left(S_{1}, S_{2}\right)$ and $Y=\left(Y_{1}, Y_{2}\right)$, such that

In particular, if $\Lambda \geq \frac{1}{2}$, then the random code capacity region is $\mathbb{C}^{\star}(\mathscr{A})=\{(0,0)\}$.
It can further be seen that the binary AVMAC is symmetrizable- $\mathcal{X}_{1} \times \mathcal{X}_{2}$, symmetrizable- $\mathcal{X}_{1} \mid \mathcal{X}_{2}$, and symmetrizable- $\mathcal{X}_{2} \mid \mathcal{X}_{1}$. In particular, the symmetrizability equations (13), (14), and (15) only hold with the 0-1 laws $J\left(s \mid x_{1}, x_{2}\right)=\delta\left(s_{1}-x_{1}\right) \delta\left(s_{2}-x_{2}\right)$, $J_{1}\left(s \mid x_{1}\right)=\delta\left(s_{1}-x_{1}\right) \delta\left(s_{2}-x_{2}^{\prime}\right), J_{2}\left(s \mid x_{2}\right)=\delta\left(s_{1}-x_{1}^{\prime}\right) \delta\left(s_{2}-x_{2}\right)$, for arbitrary $x_{1}^{\prime}, x_{2}^{\prime} \in\{0,1\}$, where $\delta(u)=1$ for $u=0$, and $\delta(u)=0$ otherwise.

Then, we use Corollary 9 to show that the capacity region is given by the following. If $\Omega_{1}>\Lambda$ and $\Omega_{2}>\Lambda$, then

The analysis is given in Appendix G.
We observe that the deterministic code capacity region and the random code capacity region are the same, only if $\Lambda \geq \frac{1}{2}$ or both input constraints are higher than the state constraints. In all other cases, the deterministic code capacity is strictly included within the random code capacity region, i.e. $\mathbb{C}(\mathscr{A}) \subset \mathbb{C}^{\star}(\mathscr{A})$.
Example 5. Consider the Gaussian AVMAC, specified by

This channel was treated independently by Hosseinigoki and Kosut [31], using the packing lemmas from [30]. Here, we use our results on the general AVMAC.

Although we previously assumed that the input, state and output alphabets are finite, our results can be extended to the continuous case as well, using standard discretization techniques [7, 1, 15] [21, Section 3.4.1]. First, we use Theorem 7 to show that the random code capacity region is

Then, we use Theorem 8 to show that the capacity region is given by the following. If $\Omega_{1}>\Lambda$ and $\Omega_{2}>\Lambda$, then

The analysis is given in Appendix H. We observe that the deterministic code capacity region and the random code capacity region are the same, only if both input constraints are higher than the state constraints. In all other cases, the deterministic code capacity is strictly included within the random code capacity region.

1) Without Constraints: We have seen in Subsection II-E1 that Gubner [24] and Ahlswede and Cai [3] determined the capacity region in all but two cases, where User 1 has zero capacity and User 2 has positive capacity, and vice versa (see Remark 3). In this subsection, we give full characterization of the capacity region of the AVMAC without constraints, closing the gap in the results by Ahlswede and Cai [3].
Theorem 12. The capacity region of the AVMAC free of constraints is given by the following.

Theorem 12 is a direct consequence of our previous results in the presence of constraints, since plugging $\Omega_{k}>\phi_{k, \max }$, $k=1,2$, and $\Lambda>l_{\max }$ yields the capacity region without constraints. In particular, if the AVMAC free of constraints is non-symmetrizable- $\mathcal{X}_{1} \times \mathcal{X}_{2}$, then $L^{*}=+\infty>\Lambda$. Otherwise, if the AVMAC free of constraints is symmetrizable- $\mathcal{X}_{1} \times \mathcal{X}_{2}$, then $L^{*} \leq l_{\max }<\Lambda$. A similar argument holds for $L_{1}^{*}, L_{2}^{*}$ and non-symmetrizability- $\mathcal{X}_{1}\left|\mathcal{X}_{2},-\mathcal{X}_{2}\right| \mathcal{X}_{1}$, respectively. Thus, Theorem 12 follows from Theorem 8 and Definition 6. The theorem above completes the partial characterization in Cases b) and c) in Theorem 4.

## Appendix A <br> Proof of Lemma 6

Consider the compound MAC $\mathscr{A}^{\mathcal{Q}}$ under input constraints $\left(\Omega_{1}, \Omega_{2}\right)$ and state constraint $\Lambda$. To prove the direct part, we construct a code based on simultaneous decoding with respect to a state type which is "close" to some $q \in \mathcal{Q}$. The converse part follows by standard arguements.

## A. Achievability Proof

Let $\varepsilon, \delta>0$ be arbitrarily small. We use the following notation. Basic method of types concepts are defined as in [16, Chapter 2]; including the definition of a type $\hat{P}_{x^{n}}$ of a sequence $x^{n}$; a joint type $\hat{P}_{x^{n}, y^{n}}$ and a conditional type $\hat{P}_{x^{n} \mid y^{n}}$ of a pair of sequences $\left(x^{n}, y^{n}\right)$; and a $\delta$-typical set $\mathcal{A}^{\delta}\left(P_{X, Y}\right)$ with respect to a distribution $P_{X, Y}(x, y)$. We also define a set of state types $\hat{\mathcal{Q}}_{n}$ by

Codebook Generation: Generate a random time sharing sequence $u^{n} \sim \prod_{i=1}^{n} P_{U}\left(u_{i}\right)$. Then, generate $2^{n R_{k}}$ conditionally independent sequences $x_{k}^{n}\left(m_{k}\right), m_{k} \in\left[1: 2^{n R_{k}}\right]$, at random, each according to $\prod_{i=1}^{n} P_{X_{k} \mid U}\left(x_{k, i} \mid u_{i}\right)$, for $k=1,2$. Reveal the sequence $u^{n}$ and the codebooks $\left\{x_{1}^{n}\left(m_{1}\right)\right\}$ and $\left\{x_{2}^{n}\left(m_{2}\right)\right\}$ to the encoders and the decoder.

Encoding: To send $\left(m_{1}, m_{2}\right)$, Encoder $k$ transmits $x_{k}^{n}\left(m_{k}\right)$, provided that

We conclude that the probability of error, averaged over the class of the codebooks, exponentially decays to zero as $n \rightarrow \infty$. Therefore, there must exist a $\left(2^{n R_{1}}, 2^{n R_{2}}, n, \varepsilon\right)$ deterministic code, for a sufficiently large $n$.

## B. Converse Proof

The converse part follows from the same arguments as in the converse proof of the classical MAC [4] (see also [14, Section 15.3.4]). Since the deterministic code capacity region is always bounded by the random code capacity region, we consider a sequence of $\left(2^{n R_{1}}, 2^{n R_{2}}, n, \alpha_{n}\right)$ random codes, where $\alpha_{n} \rightarrow 0$ as $n \rightarrow \infty$. Then, let $X_{1}^{n}=f_{1, \gamma}^{n}\left(M_{1}\right)$ and $X_{2}^{n}=f_{2, \gamma}^{n}\left(M_{2}\right)$ be the channel input sequences, and $Y^{n}$ be the corresponding output sequence, where $\gamma \in \Gamma$ is the random element shared between the encoders and the decoder. For every $q \in \mathcal{Q}$, we have by Fano's inequality that $H_{q}\left(M_{1}, M_{2} \mid Y^{n}, \gamma\right) \leq n \varepsilon_{n}$, hence $H_{q}\left(M_{1} \mid M_{2}, Y^{n}, \gamma\right) \leq n \varepsilon_{n}$ and $H_{q}\left(M_{2} \mid M_{1}, Y^{n}, \gamma\right) \leq n \varepsilon_{n}$, where $\varepsilon_{n} \rightarrow 0$ as $n \rightarrow \infty$. Since

To prove the random code capacity theorem for the AVMAC, we use our result on the compound MAC along with a simple extension of Ahlswede's Robustification Technique (RT). We begin with a lemma from [41], based on Ahlswede's RT [2].

& \stackrel{(c)}{=} \frac{1}{2^{n\left(R_{1}+R_{2}\right)}} \sum_{m_{1}, m_{2}} \sum_{y^{n}: g\left(\pi y^{n}\right) \neq\left(m_{1}, m_{2}\right)} W_{Y^{n} \mid X_{1}^{n}, X_{2}^{n}, S^{n}}\left(y^{n} \mid \pi^{-1} f_{1}\left(m_{1}\right), \pi^{-1} f_{2}\left(m_{2}\right), s^{n}\right) \tag{117}

where $(a)$ is obtained by plugging $\pi s^{n}$ in (6a); in (b) we simply change the order of summation over $y^{n}$; and (c) holds because the channel is memoryless.

Therefore, together with (116), we have that the probability of error of the random code $\mathscr{C}{ }^{\Pi}$ is bounded by $P_{e}^{(n)}\left(q, \mathscr{C}{ }^{\Pi}\right) \leq e^{-\theta n}$, for every $q\left(s^{n}\right) \in \mathcal{P}_{\Lambda}\left(\mathcal{S}^{n}\right)$. It follows that $\mathscr{C}^{\Pi}$ is a $\left(2^{n R}, n, e^{-\theta n}\right)$ random code for the AVMAC $\mathscr{A}$ under input constraints $\left(\Omega_{1}, \Omega_{2}\right)$ and state constraint $\Lambda$.

## B. Converse Proof

Assume to the contrary that there exists an achievable rate pair

Consider using the random code $\mathscr{C}^{\Gamma}$ over the compound MAC $\mathcal{W}^{\overline{\mathcal{P}}_{\Lambda-\delta}(\mathcal{S})}$ under input constraints $\left(\Omega_{1}, \Omega_{2}\right)$. Let $\bar{q}(s) \in$ $\overline{\mathcal{P}}_{\Lambda-\delta}(\mathcal{S})$ be a given state distribution. Then, define a sequence of i.i.d. random variables $\bar{S}_{1}, \ldots, \bar{S}_{n} \sim \bar{q}(s)$. Letting $\bar{q}^{n}\left(s^{n}\right) \triangleq$ $\prod_{i=1}^{n} \bar{q}\left(s_{i}\right)$, the probability of error is bounded by

It follows that the random code $\mathscr{C}^{\Gamma}$ achieves a rate pair $\left(R_{1}, R_{2}\right)$ as in (119) over the compound MAC $\mathscr{A}^{\overline{\mathcal{P}}_{\Lambda-\delta}(\mathcal{S})}$ under input constraints $\left(\Omega_{1}, \Omega_{2}\right)$, for an arbitrarily small $\delta>0$, in contradiction to Lemma 6 . We deduce that the assumption is false, and $\left.\mathbb{C}^{\star}(\mathscr{A}) \subseteq \mathrm{C}\left(\mathscr{A}^{\mathcal{Q}}\right)\right|_{\mathcal{Q}=\mathcal{P}_{\Lambda}}=\mathrm{C}^{\star}(\mathscr{A})$.

It follows that the LHS of (123) must be positive. This completes the proof of the auxiliary Lemma.

We move to the main part of the proof. Notice that while the parameters $\eta, \eta_{1}$ and $\eta_{2}$ can be chosen freely, the rest of the parameters, $\xi, \delta_{0}, \delta_{1}$, and $\delta_{2}$, depend on $P_{U}$ and $P_{X_{k} \mid U}$. ## Appendix E <br> Proof of Theorem 8

Decoding: Find a unique message pair $\left(\hat{m}_{1}, \hat{m}_{2}\right)$ such that the received sequence $y^{n}$ belongs to $\mathcal{D}\left(\hat{m}_{1}, \hat{m}_{2}\right)$, as in Definition 7 . If there is none, declare an error. Lemma 10 guarantees that there cannot be two message pairs for which this holds.

= & \prod_{i=1}^{n} \sum_{s_{i} \in \mathcal{S}} W_{Y \mid X_{1}, X_{2}, S}\left(y_{i} \mid x_{1, i}\left(m_{1}\right), x_{2, i}\left(m_{2}\right), s_{i}\right) J_{i}\left(s_{i} \mid x_{1, i}\left(\widetilde{m}_{1}\right), x_{2, i}\left(\widetilde{m}_{2}\right)\right) \\
= & \sum_{s^{n} \in \mathcal{S}^{n}} W^{n}\left(y^{n} \mid x_{1}^{n}\left(m_{1}\right), x_{2}^{n}\left(m_{2}\right), s^{n}\right) J^{n}\left(s^{n} \mid x_{1}^{n}\left(\widetilde{m}_{1}\right), x_{2}^{n}\left(\widetilde{m}_{2}\right)\right), \tag{215}

Since User 1 has a positive rate, $R_{1}>0$, the corresponding codebook has size $\mathrm{M}_{1} \geq 2$, hence $P_{e}^{(n)}(q, \mathscr{C}) \geq \frac{1}{4}$.
The proof of part 3 is similar, and thus omitted.
Now, we are in position to prove the converse part of Theorem 8. Consider a sequence of ( $2^{n R_{1}}, 2^{n R_{2}}, n, \alpha_{n}$ ) deterministic codes $\mathscr{C}_{n}$ over the AVMAC under input constraints $\left(\Omega_{1}, \Omega_{2}\right)$ and state constraint $\Lambda$, where $\alpha_{n} \rightarrow 0$ as $n \rightarrow \infty$. In particular, we have that the conditional probability of error given a state sequence $s^{n}$ is bounded by

where $\varepsilon_{n}>0$ tends to zero as $n \rightarrow \infty$. To this end, consider using the same code in the following setting. Consider a different channel model, with an average state constraint. Specifically, consider a MAC where the jammer selects an independent state sequence at random, $\bar{S}^{n} \sim \prod_{i=1}^{n} \bar{q}_{i}\left(z_{i}\right)$, under the average state constraint $\frac{1}{n} \sum_{i=1}^{n} \mathbb{E} l\left(S_{i}\right) \leq \Lambda-\delta$. Here, there is no state constraint with probability 1 , as the jammer may select a sequence $\bar{S}^{n}$ with $l^{n}\left(\bar{S}^{n}\right)>\Lambda$. We claim that the code sequence of the constrained AVMAC achieves the same rate pair $\left(R_{1}, R_{2}\right)$ over the "new" MAC $W_{Y \mid X_{1}, X_{2}, \bar{S}}$, which is governed by the state sequence $\bar{S}^{n}$, under an average constraint. Indeed, using the code $\mathscr{C}_{n}$ over the MAC $W_{Y \mid X_{1}, X_{2}, \bar{S}}$, the probability of error is given by

By (221), we have that the sum in the RHS is bounded by $\alpha_{n}$, hence tends to zero as $n \rightarrow \infty$. As for the second term,

where the first inequality holds since $\frac{1}{n} \sum_{i=1}^{n} \mathbb{E} l\left(\bar{S}_{i}\right) \leq \Lambda-\delta$, and the second is due to Chebyshev's inequality. Thus, we have by (225) that the probability of error tends to zero as $n \rightarrow \infty$, when using the code $\mathscr{C}_{n}$ over the MAC governed by $\bar{S}^{n}$.

Therefore, it suffices to prove the converse part for the MAC $W_{Y \mid X_{1}, X_{2}, \bar{S}}$ governed by the state sequence $\bar{S}^{n} \sim \bar{q}^{n}\left(s^{n}\right)=$ $\prod_{i=1}^{n} \bar{q}_{i}\left(s_{i}\right)$. Then, let $X_{1}^{n}=f_{1}^{n}\left(M_{1}\right)$ and $X_{2}^{n}=f_{2}^{n}\left(M_{2}\right)$ be the channel input sequences, and $Y^{n}$ be the corresponding output sequence. Fano's inequality implies that for every jamming strategy $\bar{q}^{n}\left(s^{n}\right)$,

Returning to the original AVMAC, we now show that $\widetilde{\Lambda}\left(P_{U, X_{1}, X_{2}}\right) \geq \Lambda$. If the AVMAC is non-symmetrizable- $\mathcal{X}_{1} \times \mathcal{X}_{2}$, then $\widetilde{\Lambda}\left(P_{U, X_{1}, X_{2}}\right)=+\infty$, and there is nothing to show. Hence, consider the case where the AVMAC is symmetrizable- $\mathcal{X}_{1} \times \mathcal{X}_{2}$. Assume to the contrary that $\widetilde{\Lambda}\left(P_{U, X_{1}, X_{2}}\right)<\Lambda$. Based on Remark 8, and our definition of the external variable $U$, this means that there exist conditional state distributions $J_{i}\left(s \mid x_{1}, x_{2}\right), i \in[1: n]$, which symmetrize- $\mathcal{X}_{1} \times \mathcal{X}_{2}$ the AVMAC, such that

Then, the jammer selects a sequence $\widetilde{S}^{n}$ at random, according to the conditional distribution

At last, if $l^{n}\left(\widetilde{S}^{n}\right) \leq \Lambda$, the jammer chooses the state sequence to be $S^{n}=\widetilde{S}^{n}$. Otherwise, the jammer chooses $S^{n}$ to be some sequence of zero cost. Such jamming strategy satisfies the state constraint $\Lambda$ with probability 1.

To contradict our assumption that $\widetilde{\Lambda}\left(P_{U, X_{1}, X_{2}}\right)<\Lambda$, we first show that $\mathbb{E} l^{n}\left(\widetilde{S}^{n}\right)=\widetilde{\Lambda}\left(P_{U, X_{1}, X_{2}}\right)$. Observe that for every $\left(x_{1}^{n}, x_{2}^{n}\right) \in \mathcal{X}_{1}^{n} \times \mathcal{X}_{2}^{n}$,

Thus, by Chebyshev's inequality we have that for sufficiently large $n$,

where $\widetilde{q}\left(s^{n}\right)$ is as defined in (208). On the other hand, the sequence $\widetilde{S}^{n}$ can be thought of as the state sequence of an AVMAC without a state constraint, hence, by part 1 of Lemma 16,

Thus, by (239)-(240), the probability of error is bounded by $P_{e}^{(n)}\left(q, \mathscr{C}_{n}\right) \geq \frac{1}{4}-\delta_{0}$. As this cannot be the case for a code with vanishing probability of error, we deduce that the assumption is false, i.e. $\widetilde{\Lambda}\left(P_{U, X_{1}, X_{2}}\right) \geq \Lambda$.
It remains to show that $\widetilde{\Lambda}_{1}\left(P_{U, X_{1}}\right) \geq \Lambda$ and $\widetilde{\Lambda}_{2}\left(P_{U, X_{2}}\right) \geq \Lambda$. Due to the symmetry, it suffices to show this for User 1 . We only need to consider an AVMAC which is symmetrizable- $\mathcal{X}_{1} \mid \mathcal{X}_{2}$, as otherwise, $\widetilde{\Lambda}_{1}\left(P_{X_{1}}\right)=+\infty$. Then, assume to the contrary that $\widetilde{\Lambda}_{1}\left(P_{X_{1}}\right)<\Lambda$, and let $J_{1, i}\left(s \mid x_{1}\right), i \in[1: n]$, be the symmetrizing distributions that satisfy (14) and achieves the minimum in (32b), i.e.

Consider a jamming strategy, where the jammer first selects a codeword $\widetilde{X}_{1}^{n}$ from the codebook of User 1, uniformly at random. Then, the jammer selects a sequence $\widetilde{S}_{1}^{n}$ at random, according to the conditional distribution

\operatorname{Pr}\left(\widetilde{S}_{1}^{n}=s^{n} \mid \widetilde{X}_{1}=x_{1}^{n}\right)=J_{1}^{n}\left(s^{n} \mid x_{1}^{n}\right) \triangleq \prod_{i=1}^{n} J_{1, i}\left(s_{i} \mid x_{1, i}\right) \tag{242}
\end{equation*}
$$

At last, if $l^{n}\left(\widetilde{S}_{1}^{n}\right) \leq \Lambda$, the jammer chooses the state sequence to be $S^{n}=\widetilde{S}_{1}^{n}$. Otherwise, the jammer chooses $S^{n}$ to be some sequence of zero cost.

To contradict our assumption that $\widetilde{\Lambda}_{1}\left(P_{U, X_{1}}\right)<\Lambda$, we first show that $\mathbb{E} l^{n}\left(\widetilde{S}_{1}^{n}\right)=\widetilde{\Lambda}_{1}\left(P_{U, X_{1}}\right)$. Observe that for every $x_{1}^{n} \in \mathcal{X}_{1}^{n}$,

Since $\widetilde{X}_{1}^{n}$ is distributed as $X_{1}^{n}$, we obtain

\mathbb{E} l^{n}\left(\widetilde{S}_{1}^{n}\right)=\sum_{u, s \in \mathcal{S}} P_{U}(u) P_{X_{1} \mid U}\left(x_{1} \mid u\right) J_{1, u}\left(s \mid x_{1}\right) l(s)=\widetilde{\Lambda}_{1}\left(P_{U, X_{1}}\right)<\Lambda \tag{244}
\end{equation*}
$$

where the last equality is due to (241). Next, the probability of error is bounded by

P_{e}^{(n)}\left(q, \mathscr{C}_{n}\right) & \geq \operatorname{Pr}\left(g\left(Y^{n}\right) \neq\left(M_{1}, M_{2}\right), l^{n}\left(\widetilde{S}_{1}^{n}\right) \leq \Lambda\right) \\
& =\sum_{s^{n}: l^{n}\left(s^{n}\right) \leq \Lambda} \widetilde{q}_{1}\left(s^{n}\right) P_{e \mid s^{n}}^{(n)}\left(\mathscr{C}_{n}\right) \tag{245}
\end{align*}
$$

where $\widetilde{q}_{1}\left(s^{n}\right)$ is as defined in (210). On the other hand, the sequence $\widetilde{S}_{1}^{n}$ can be thought of as the state sequence of an AVMAC without a state constraint, hence, by part 2 of Lemma 16,

\frac{1}{4} & \leq P_{e}^{(n)}\left(\widetilde{q}_{1}, \mathscr{C}_{n}\right) \leq \sum_{s^{n}: l^{n}\left(s^{n}\right) \leq \Lambda} \widetilde{q}_{1}\left(s^{n}\right) P_{e \mid s^{n}}^{(n)}\left(\mathscr{C}_{n}\right)+\operatorname{Pr}\left(l^{n}\left(\widetilde{S}_{1}^{n}\right)>\Lambda\right) \\
& \leq \sum_{s^{n}: l^{n}\left(s^{n}\right) \leq \Lambda} \widetilde{q}_{1}\left(s^{n}\right) P_{e \mid s^{n}}^{(n)}\left(\mathscr{C}_{n}\right)+\delta_{1} \tag{246}
\end{align*}
$$

where the last line is due to (244) and Chebyshev's inequality, with arbitrarily small $\delta_{1}>0$. Thus, (245)-(246) imply that $P_{e}^{(n)}\left(q, \mathscr{C}_{n}\right) \geq \frac{1}{4}-\delta_{1}$, which cannot hold for a code with vanishing probability of error. We deduce that the assumption is false, i.e. $\widetilde{\Lambda}_{1}\left(P_{U, X_{1}}\right) \geq \Lambda$. This completes the converse proof.

## Case B and Case C

Before we begin, we note that Cases B-D can also be proved by directly adjusting the techniques of Csiszár and Narayan for the single user AVC [17]. Although, as explained in Remark 3, it is not an immediate consequence. Thereby, it is easier for us to use our previous derivations instead.

The proof follows similar arguments as in Case A, and thus we only give the outline. Since Case B and Case C in Definition 6 are symmetric, we only treat the former. Suppose that $L^{*}>\Lambda$ and $L_{2}^{*}>\Lambda$, but $L_{1}^{*}<\Lambda$. For the direct part, we can use the same coding scheme as in Case A with the following changes. First, coded time sharing is no longer necessary, hence we take $U=\emptyset$. Then, let $P_{X_{1}}$ and $P_{X_{2}}$ be types, such that $\mathbb{E} \phi_{k}\left(X_{k}\right) \leq \Omega_{k}$, for $k=1,2, \widetilde{\Lambda}_{2}\left(P_{X_{2}}\right)>\Lambda$ and $\widetilde{\Lambda}\left(P_{X_{1}, X_{2}}\right)>\Lambda$. As User 1 transmits at zero rate, we can discard of Condition 2 b ) of the decoding rule (see Definition 7). Nevertheless, given our assumption in Remark 1, Encoder 1 may use "local randomness" and send a sequence $x_{1}^{n}=f_{1}(\sigma)$, where $\sigma \in\left[1: 2^{n R_{1}}\right]$ is drawn uniformly at random, with $R_{1}=\varepsilon$. Upon receiving $y^{n} \in \mathcal{Y}^{n}$, the decoder declares its estimation $g\left(y^{n}\right)=m_{2}$ iff there exists $\sigma$ such that $y^{n} \in \mathcal{D}\left(\sigma, m_{2}\right)$, where the decoding sets $\mathcal{D}\left(\sigma, m_{2}\right) \subseteq \mathcal{Y}_{\sim}^{n}$ are as in Definition 7. The message of User 2 is still decoded uniquely, since the only part of Lemma 10 that depends on $\widetilde{\Lambda}_{1}\left(P_{X_{1}}\right)$ is part 2 , which is no longer necessary.

The analysis of the probability of error remains exactly the same, except that the error event $\mathcal{E}_{2 \mathrm{~b}}$ can be ignored. It follows that the probability of error tends to zero, provided that

Since $R_{1}=\varepsilon$, and $I_{q}\left(X_{1}, X_{2} ; Y\right) \geq I_{q}\left(X_{2} ; Y \mid X_{1}\right)$, the first inequality is inactive, and the direct part follows.
The converse part also follows from the converse proof for Case A. It was shown that if the jammer selects the state sequence to be

for $\widetilde{S}_{1}^{n} \sim \widetilde{q}_{1}\left(s^{n}\right)$ as in (210), and $s_{0} \in \mathcal{S}$ with $l\left(s_{0}\right)=0$, then the probability of error is lower bounded by $P_{e}^{(n)}\left(q, \mathscr{C}_{n}\right) \geq \frac{1}{4}-\delta_{1}$ for $R_{1}>0$, hence User 1 cannot achieve positive rates. As for User 2, we have by (223) that

Then, observe that $I_{q}\left(X_{2} ; Y \mid X_{1}, U\right) \leq I_{q}\left(X_{2} ; Y \mid X_{1}\right)$, since $U \ominus\left(X_{1}, X_{2}\right) \ominus Y$ form a Markov chain, and conditioning reduces entropy (see e.g. [14, Theorem 2.6.5]). By the same considerations as in Case $\mathrm{A}, \widetilde{\Lambda}_{2}\left(P_{X_{2}}\right) \geq \Lambda$, and the converse part follows.

## Case D

Suppose that $L^{*}<\Lambda$. It was shown in the converse proof for Case A, that if the jammer selects the state sequence

for $\widetilde{S}^{n} \sim \widetilde{q}\left(s^{n}\right)$ as in (208), and $s_{0} \in \mathcal{S}$ with $l\left(s_{0}\right)=0$, then the probability of error is lower bounded by $P_{e}^{(n)}\left(q, \mathscr{C}_{n}\right) \geq \frac{1}{4}-\delta_{0}$ for $R_{1}+R_{2}>0$. Thus, positive rates cannot be achieved.

Now, suppose that both $L_{1}^{*}<\Lambda$ and $L_{2}^{*}<\Lambda$. We have already seen in the proof of Case B, that $L_{1}^{*}<\Lambda$ implies that User 1 cannot achieve $R_{1}>0$, and by symmetry, $L_{2}^{*}<\Lambda$ implies that User 2 cannot achieve $R_{2}>0$. Therefore, if $L^{*}<\Lambda$, or both $L_{1}^{*}<\Lambda$ and $L_{2}^{*}<\Lambda$, then the deterministic code capacity region is $\{(0,0)\}$, as we were set to prove. This concludes the proof of Theorem 8.

## Appendix F <br> Proof of Corollary 9

Assume that the AVMAC $\mathscr{A}$ satisfies the conditions of Corollary 9. Looking into the converse proof of Theorem 8 in Appendix E above, the following addition suffices. We show that for every code $\mathscr{C}_{n}$ as in Appendix $\mathrm{E}, \widetilde{\Lambda}\left(P_{U, X_{1}, X_{2}}\right)=\Lambda$ implies that $R_{1}+R_{2}=0, \widetilde{\Lambda}_{1}\left(P_{U, X_{1}}\right)=\Lambda$ implies that $R_{1}=0$, and $\widetilde{\Lambda}_{2}\left(P_{U, X_{2}}\right)=\Lambda$ implies that $R_{2}=0$. Since there is only a polynomial number of types, we may consider $P_{U, X_{1}, X_{2}}$ to be the joint type of $\left(u^{n}, f_{1}\left(m_{1}\right), f_{2}\left(m_{2}\right)\right)$, for all $m_{1}$ and $m_{2}$ (see [16, Problem 6.19]).

Suppose that $\widetilde{\Lambda}\left(P_{U, X_{1}, X_{2}}\right)=\Lambda$, assume to the contrary that $R_{1}+R_{2}>0$, and let $J_{u}\left(s \mid x_{1}, x_{2}\right)$ be distributions that achieve the minimum in (32a), i.e.

Based on the condition of the corollary, we may assume that $J_{u}\left(s \mid x_{1}, x_{2}\right)$ is a 0-1 law, i.e.

\end{equation*}

Recall that we have defined $U$ in the converse proof as a uniformly distributed variable over $\mathcal{U}=[1: n]$. Now, consider the following jamming strategy. First, the jammer selects from the codebooks a pair of codewords ( $\widetilde{X}_{1}^{n}, \widetilde{X}_{2}^{n}$ ) uniformly at random.

Then, given $\widetilde{X}_{1}^{n}={\underset{X}{1}}_{1}^{n}$ and $\widetilde{X}_{2}^{n}=x_{2}^{n}$, the jammer chooses the state sequence $S^{n}=\left(G_{i}\left(x_{1, i}, x_{2, i}\right)\right)_{i=1}^{n}$. Observe that given pair of codewords, $\widetilde{X}_{1}^{n}=x_{1}^{n}$ and $\widetilde{X}_{2}^{n}=x_{2}^{n}$,

l^{n}\left(S^{n}\right)=\frac{1}{n} \sum_{i=1}^{n} l\left(G_{i}\left(x_{1, i}, x_{2, i}\right)\right)=\mathbb{E} l\left(G_{U}\left(X_{1}, X_{2}\right)\right)=\Lambda \tag{254}
\end{equation*}
$$

where the last equality is due to (253). Thus, the state sequence satisfies the state constraint. Now, observe that the jamming strategy $S^{n}=\left(G_{i}\left(\widetilde{X}_{1, i}, \widetilde{X}_{2, i}\right)\right)_{i=1}^{n}$ is equivalent to $S^{n} \sim \widetilde{q}\left(s^{n}\right)$ as in (208). Thus, by part 1 of Lemma 16, we have that $P_{e}^{(n)}\left(\widetilde{q}, \mathscr{C}_{n}\right) \geq \frac{1}{4}$, hence both users cannot achieve a positive rate.

Next, consider the case where $\widetilde{\Lambda}_{1}\left(P_{U, X_{1}}\right)=\Lambda$. Assume to the contrary that $R_{1}>0$, and let $J_{1, u}\left(s \mid x_{1}\right)$ be distributions that achieves the minimum in (32b), i.e.

for some deterministic function $G_{1, u}: \mathcal{X}_{1} \rightarrow \mathcal{S}$. Thus, by (255),

Now, suppose the jammer selects from the codebook of User 1, a codeword $\widetilde{X}_{1}^{n}$ uniformly at random. Then, given $\widetilde{X}_{1}^{n}=x_{1}^{n}$, the jammer chooses the state sequence $S^{n}=\left(G_{1, i}\left(x_{1, i}\right)\right)_{i=1}^{n}$. Hence, For every given codeword $\widetilde{X}_{1}^{n}=x_{1}^{n}$,

Thus, by (257), we have that $l^{n}\left(S^{n}\right)=\Lambda$ with probability 1 . This means that the state sequence satisfies the state constraint. Now, observe that the jamming strategy $S^{n}=\left(G_{1, i}\left(\widetilde{X}_{1, i}\right)\right)_{i=1}^{n}$ is equivalent to $S^{n} \sim \widetilde{q}_{1}\left(s^{n}\right)$ as in (210). Thus, by part 2 of Lemma 16, we have that $P_{e}^{(n)}\left(\widetilde{q}_{1}, \mathscr{C}_{n}\right) \geq \frac{1}{4}$, hence $R_{1}=0$. By symmetry, we have that $\widetilde{\Lambda}_{2}\left(P_{X_{2}}\right)=\Lambda$ implies that $R_{2}=0$.

We begin with the random code capacity region. To show achievability, set $U=\emptyset, X_{1} \sim \operatorname{Bernoulli}\left(\omega_{1}\right), X_{2} \sim \operatorname{Bernoulli}\left(\omega_{2}\right)$, and observe that

& \stackrel{(c)}{\geq} H\left(X_{1}\right)+H\left(X_{2}\right)-H_{q}\left(X_{1} \mid Y_{1}, Y_{2}\right)-H_{q}\left(X_{2} \mid Y_{1}, Y_{2}\right) \\
& \stackrel{(d)}{\geq} I_{q}\left(X_{1} ; Y_{1}\right)+I_{q}\left(X_{2} ; Y_{2}\right) \tag{260}

where ( $a$ ) holds since $X_{2}$ is independent of $\left(X_{1}, S_{1}, Y_{1}\right) ;(b)$ holds since $X_{1}$ is independent of $\left(X_{2}, S_{2}, Y_{2}\right) ;(c)$ is due to the independence bound on entropy [14, Theorem 2.6.6.]; and $(d)$ holds since conditioning reduces entropy [14, Theorem 2.6.5.]. Therefore, based on Theorem 7, $\left(R_{1}, R_{2}\right)$ is achievable for

S_{2}=0}}=h\left(p_{1} * \lambda\right)-h(\lambda) \leq h\left(\omega_{1} * \lambda\right)-h(\lambda), \tag{264}
\end{align*}

with $X_{1} \sim \operatorname{Bernoulli}\left(p_{1}\right)$, for $0 \leq p_{1} \leq \Omega_{1}$, where the first equality holds since $S_{2}=0$ implies that $Y_{2}=X_{2}$, and the last inequality holds since $h(\alpha * t)$ is a concave- $\cap$ function over $0 \leq t \leq 1$ with maximum at $t=\frac{1}{2}$. Similarly, the rate of User 2 is bounded by

\begin{align*}
L^{*} & =\max _{\substack{0 \leq p_{1} \leq \Omega_{1} \\
0 \leq p_{2} \leq \Omega_{2}}} \Psi\left(P_{X_{1}, X_{2}}\right)=\omega_{1}+\omega_{2}  \tag{269}\\
L_{1}^{*} & =\max _{0 \leq p_{1} \leq \Omega_{1}} \Psi_{1}\left(p_{1}\right)=\omega_{1}  \tag{270}\\
L_{2}^{*} & =\max _{0 \leq p_{2} \leq \Omega_{2}} \Psi_{2}\left(p_{2}\right)=\omega_{2} \tag{271}
\end{align*}
$$

Observe that based on the result on the random code capacity region, we have that for $\Lambda \geq \frac{1}{2}$, or equivalently, $\lambda=\frac{1}{2}$, the capacity region is given by $\mathbb{C}(\mathscr{A})=\mathbb{C}^{\star}(\mathscr{A})=\{(0,0)\}$, in agreement with (66)-(69). Henceforth, assume that $\Lambda<\frac{1}{2}$.

The first case to consider is $\Omega_{1}>\Lambda$ and $\Omega_{2}>\Lambda$. The converse part is immediate, since the deterministic code capacity region is always bounded by the random code capacity region. As for the direct part, we are going to show that under the assumption that $\Lambda<\frac{1}{2}$, we have that $L^{*}, L_{1}^{*}$ and $L_{2}^{*}$ are greater than $\Lambda$. Indeed, if $\Omega_{k} \geq \frac{1}{2}$, then $\omega_{k}=\frac{1}{2}>\Lambda$, for $k=1,2$. Otherwise, if $\Omega_{k}<\frac{1}{2}$, then $\omega_{k}=\Omega_{k}>\Lambda$, for $k=1,2$. Therefore, in both cases, we have by (269)-(271) that $L^{*}>\Lambda, L_{1}^{*}>\Lambda$, and $L_{2}^{*}>\Lambda$, which corresponds to Case a) in Definition 6. It is further inferred that taking $p_{1}=\omega_{1}$ and $p_{2}=\omega_{2}$, we have that $\widetilde{\Lambda}\left(p_{1}, p_{2}\right)=\omega_{1}+\omega_{2}>\Lambda$ and $\widetilde{\Lambda}_{k}\left(p_{k}\right)=\omega_{k}>\Lambda$ for $k=1,2$. It follows that this inputs distribution is legitimate, in the sense that it belongs to the optimization set $\overline{\mathcal{P}}_{\Omega_{1}, \Omega_{2}, \Lambda}\left(\mathcal{U} \times \mathcal{X}_{1} \times \mathcal{X}_{2}\right)$ (see definition in (37b)). This completes the achievability proof for the first case, because we have already seen in the achievability proof of the random code capacity region above, that the inputs distribution $p_{1}=\omega_{1}$ and $p_{2}=\omega_{2}$ achieves the region in the RHS of (66), with $U=\emptyset$.

Next, we consider the second case, $\Omega_{1} \leq \Lambda$ and $\Omega_{2}>\Lambda$. Assuming that $\Lambda<\frac{1}{2}$, we have that $\Omega_{1}<\frac{1}{2}$, hence $L_{1}^{*}=\omega_{1}=$ $\Omega_{1} \leq \Lambda$. As for $L_{2}^{*}$, if $\Omega_{2} \geq \frac{1}{2}$, then $\omega_{2}=\frac{1}{2}>\Lambda$, and if $\Omega_{2}<\frac{1}{2}$, then $\omega_{2}=\Omega_{2}>\Lambda$. It follows that $L^{*}=\omega_{1}+\omega_{2}>\Lambda$ and $L_{2}^{*}=\omega_{2}>\Lambda$, but $L_{1} \leq \Lambda$, which corresponds to Case b) in Definition 6. Furthermore, the input distributions $p_{1}=\omega_{1}$ and $p_{2}=\omega_{2}$ belong to the maximization set in (37a), as $\widetilde{\Lambda}\left(p_{1} p_{2}\right)=\omega_{1}+\omega_{2}>\Lambda$ and $\widetilde{\Lambda}_{2}\left(p_{2}\right)=\omega_{2}>\Lambda$. Thus, User 2 can achieve rates below

$$
\begin{align*}
& \min _{q\left(s_{1}, s_{2}\right): \mathbb{E} S_{1}+\mathbb{E} S_{2} \leq \Lambda} I_{q}\left(X_{2} ; Y_{1}, Y_{2} \mid X_{1}\right) \geq \min _{q\left(s_{1}, s_{2}\right): \mathbb{E} S_{1}+\mathbb{E} S_{2} \leq \Lambda} I_{q}\left(X_{2} ; Y_{2} \mid X_{1}\right) \\
= & \min _{0 \leq q_{2} \leq \Lambda}\left[h\left(\omega_{2} * q_{2}\right)-h\left(q_{2}\right)\right]=h\left(\omega_{2} * \lambda\right)-h(\lambda) \tag{272}
\end{align*}
$$

It is also the highest rate achievable for User 2, since

$$
\begin{align*}
R_{2} & \leq \min _{q\left(s_{1}, s_{2}\right): \mathbb{E} S_{1}+\mathbb{E} S_{2} \leq \Lambda} I_{q}\left(X_{2} ; Y_{1}, Y_{2} \mid X_{1}\right) \leq\left. I_{q}\left(X_{2} ; Y_{1}, Y_{2} \mid X_{1}\right)\right|_{\substack{S_{2}=\operatorname{Bernoulli}(\lambda)}} \\
& =\left.I_{q}\left(X_{2} ; Y_{2}\right)\right|_{\substack{S_{1}=0 \\
S_{2} \sim \operatorname{Bernoulli}(\lambda)}} \leq \max _{0 \leq p_{2} \leq \Omega_{2}} h\left(p_{2} * \lambda\right)-h(\lambda)=h\left(\omega_{2} * \lambda\right)-h(\lambda) \tag{273}
\end{align*}
$$

following the same considerations as in the derivation of the random code capacity region above. The third case, $\Omega_{1}>\Lambda$ and $\Omega_{2} \leq \Lambda$, follows by symmetry.

In the fourth case, $\Omega_{1}<\Lambda$ and $\Omega_{2}<\Lambda$, we have that

$$
\begin{align*}
& L_{1}^{*}=\omega_{1} \leq \Omega_{1}<\Lambda \\
& L_{2}^{*}=\omega_{2} \leq \Omega_{2}<\Lambda \tag{274}
\end{align*}
$$

as in Case d) in Definition 6. Thus, the capacity region is $\mathbb{C}(\mathscr{A})=\{(0,0)\}$.

## Appendix H

## AnAlysis of Example 5

Deriving the random code capacity region is straightforward. To show achievability, we set $U=\emptyset, X_{1} \sim \mathcal{N}\left(0, \Omega_{1}\right)$, and $X_{2} \sim \mathcal{N}\left(0, \Omega_{2}\right)$. Then, since Gaussian noise is known to be the worst additive noise under variance constraint [20, Lemma II.2], we have that

$$
\begin{align*}
& \min _{F_{S}: \mathbb{E} S^{2} \leq \Lambda} I\left(X_{1} ; Y \mid X_{2}\right)=\frac{1}{2} \log \left(1+\frac{\Omega_{1}}{\Lambda+\sigma^{2}}\right),  \tag{275}\\
& \min _{F_{S}: \mathbb{E} S^{2} \leq \Lambda} I\left(X_{2} ; Y \mid X_{1}\right)=\frac{1}{2} \log \left(1+\frac{\Omega_{2}}{\Lambda+\sigma^{2}}\right),  \tag{276}\\
& \min _{F_{S}: \mathbb{E} S^{2} \leq \Lambda} I\left(X_{1}, X_{2} ; Y\right)=\frac{1}{2} \log \left(1+\frac{\Omega_{1}+\Omega_{2}}{\Lambda+\sigma^{2}}\right) . \tag{277}
\end{align*}
$$

This proves achievability. To prove the converse part, observe that the rate of User 1 is bounded by

$$
\begin{equation*}
\min _{F_{S}: \mathbb{E} S^{2} \leq \Lambda} I\left(X_{1} ; Y \mid X_{2}, U\right) \leq\left. I\left(X_{1} ; Y \mid X_{2}, U\right)\right|_{S \sim \mathcal{N}(0, \Lambda)} \leq \frac{1}{2} \log \left(1+\frac{\Omega_{1}}{\Lambda+\sigma^{2}}\right) \tag{278}
\end{equation*}
$$

where the last inequality follows as in the converse proof of the classical Gaussian MAC $Y=X_{1}+X_{2}+\widetilde{Z}$, with $\widetilde{Z} \sim$ $\mathcal{N}\left(0, \Lambda+\sigma^{2}\right)$ [50]. The bounds on the rate of User 2 and on the sum rate are proved in the same manner. We have thus determined the random code capacity region.

We move to the deterministic code capacity region, as in Theorem 8. First, we calculate the thresholds $L^{*}, L_{1}^{*}$, and $L_{2}^{*}$. Based on Definition 5, the Gaussian AVMAC is symmetrized $-\mathcal{X}_{1} \times \mathcal{X}_{2}$ by a conditional pdf $\varphi\left(s \mid x_{1}, x_{2}\right)$ if

$$
\begin{equation*}
\int_{-\infty}^{\infty} \varphi\left(s \mid \tilde{x}_{1}, \tilde{x}_{2}\right) f_{Z}\left(y-x_{1}-x_{2}-s\right) d s=\int_{-\infty}^{\infty} \varphi\left(s \mid x_{1}, x_{2}\right) f_{Z}\left(y-\tilde{x}_{1}-\tilde{x}_{2}-s\right) d s, \forall x_{1}, x_{2}, \tilde{x}_{1}, \tilde{x}_{2}, y \in \mathbb{R} \tag{279}
\end{equation*}
$$

where $f_{Z}(z)=\frac{1}{\sqrt{2 \pi \sigma^{2}}} e^{-z^{2} / 2 \sigma^{2}}$. In particular, observe that (279) holds for $\varphi\left(s \mid x_{1}, x_{2}\right)=\delta\left(s-x_{1}-x_{2}\right)$, where $\delta(\cdot)$ is the Dirac delta function. In other words, the channel is symmetrized by a distribution $\varphi\left(s \mid x_{1}, x_{2}\right)$ which gives probability 1 to $S=x_{1}+x_{2}$. The minimal state cost $\widetilde{\Lambda}\left(F_{X_{1}} F_{X_{2}}\right)$ for the jammer to symmetrize- $\mathcal{X}_{1} \times \mathcal{X}_{2}$, for the input distribution $f_{X_{1}}\left(x_{1}\right) f_{X_{2}}\left(x_{2}\right)$, is the contiuous version of (32a),

$$
\begin{equation*}
\widetilde{\Lambda}\left(F_{X_{1}} F_{X_{2}}\right)=\min \int_{-\infty}^{\infty} \int_{-\infty}^{\infty} \int_{-\infty}^{\infty} f_{X_{1}}\left(x_{1}\right) f_{X_{2}}\left(x_{2}\right) \varphi\left(s \mid x_{1}, x_{2}\right) s^{2} d s d x_{1} d x_{2} \tag{280}
\end{equation*}
$$

where the minimization is over all conditional pdfs $\varphi\left(s \mid x_{1}, x_{2}\right)$ that symmetrize $-\mathcal{X}_{1} \times \mathcal{X}_{2}$ the channel, that is, satisfy (279). Similar expressions can be written for the individual state costs $\widetilde{\Lambda}_{1}\left(F_{X_{1}}\right)$ and $\widetilde{\Lambda}_{2}\left(F_{X_{2}}\right)$ as the continuous versions of ( 32 b ) and (32c), respectively. The following lemma states that the minimal state cost for joint symmetrizability is the total input power, and the minimal state cost for individual symmetrizability is the input power of the corresponding transmitter.
Lemma 17. For zero mean random variables $X_{1}$ and $X_{2}$,

$$
\begin{align*}
\Psi\left(F_{X_{1}} F_{X_{2}}\right) & =\mathbb{E} X_{1}^{2}+\mathbb{E} X_{2}^{2}  \tag{281}\\
\Psi_{1}\left(F_{X_{1}}\right) & =\mathbb{E} X_{1}^{2}  \tag{282}\\
\Psi_{2}\left(F_{X_{2}}\right) & =\mathbb{E} X_{2}^{2} \tag{283}
\end{align*}
$$

Proof of Lemma 17. First, we evaluate $\Psi\left(F_{X_{1}} F_{X_{2}}\right)$. Observe that by (280), the Gaussian AVMAC is symmetrized- $\mathcal{X}_{1} \times \mathcal{X}_{2}$ by a conditional pdf $\varphi_{x_{1}, x_{2}}(s)=\varphi\left(s \mid x_{1}, x_{2}\right)$ if

$$
\begin{equation*}
\int_{-\infty}^{\infty} \varphi_{0,0}(s) f_{Z}\left(y-x_{1}-x_{2}-s\right) d s=\int_{-\infty}^{\infty} \varphi_{x_{1}, x_{2}}(s) f_{Z}(y-s) d s \tag{284}
\end{equation*}
$$

for all $x_{1}, x_{2}, y \in \mathbb{R}$. By substituting $z=y-x_{1}-x_{2}-s$ in the LHS, and $\bar{z}=y-s$ in the RHS, this is equivalent to

$$
\begin{equation*}
\int_{-\infty}^{\infty} \varphi_{0,0}\left(y-x_{1}-x_{2}-z\right) f_{Z}(z) d z=\int_{-\infty}^{\infty} \varphi_{x_{1}, x_{2}}(y-\bar{z}) f_{Z}(\bar{z}) d \bar{z} \tag{285}
\end{equation*}
$$

For every $x_{1}, x_{2} \in \mathbb{R}$, define the random variable $\bar{S}\left(x_{1}, x_{2}\right) \sim \varphi_{x_{1}, x_{2}}$. We note that the RHS is the convolution of the pdfs of the random variables $Z$ and $\bar{S}\left(x_{1}, x_{2}\right)$, while the LHS is the convolution of the pdfs of the random variables $Z$ and $\bar{S}(0,0)+x_{1}+x_{2}$. This is not surprising since the channel output $Y$ is a sum of independent random variables, and thus the pdf of $Y$ is a convolution of pdfs. It follows that $\varphi_{0,0}\left(y-x_{1}-x_{2}\right)=\varphi_{x_{1}, x_{2}}(y)$, and by plugging $s$ instead of $y$, we have that $\varphi_{x_{1}, x_{2}}$ symmetrizes- $\mathcal{X}_{1} \times \mathcal{X}_{2}$ the Gaussian AVMAC if and only if

$$
\begin{equation*}
\varphi_{x_{1}, x_{2}}(s)=\varphi_{0,0}\left(s-x_{1}-x_{2}\right) \tag{286}
\end{equation*}
$$

Then, the corresponding state cost satisfies

$$
\begin{align*}
& \int_{-\infty}^{\infty} \int_{-\infty}^{\infty} \int_{-\infty}^{\infty} f_{X_{1}}\left(x_{1}\right) f_{X_{2}}\left(x_{2}\right) \varphi_{x_{1}, x_{2}}(s) s^{2} d x_{1} d x_{2} d s \\
= & \int_{-\infty}^{\infty} \int_{-\infty}^{\infty} \int_{-\infty}^{\infty} f_{X_{1}}\left(x_{1}\right) f_{X_{2}}\left(x_{2}\right) \varphi_{0,0}\left(s-x_{1}-x_{2}\right) s^{2} d x_{1} d x_{2} d s \\
= & \int_{-\infty}^{\infty} \int_{-\infty}^{\infty} \int_{-\infty}^{\infty} f_{X_{1}}\left(x_{1}\right) f_{X_{2}}\left(x_{2}\right) \varphi_{0,0}(a)\left(a+x_{1}+x_{2}\right)^{2} d a d x_{1} d x_{2} \\
= & \int_{-\infty}^{\infty}\left[\int_{-\infty}^{\infty} \int_{-\infty}^{\infty}\left(x_{1}+x_{2}+a\right)^{2} f_{X_{1}}\left(x_{1}\right) f_{X_{2}}\left(x_{2}\right) d x_{1} d x_{2}\right] \varphi_{0,0}(a) d a \tag{287}
\end{align*}
$$

where the second equality follows by the integral substitution of $a=s-x_{1}-x_{2}$. Observe that the bracketed integral can be expressed as $\mathbb{E}\left[\left(X_{1}+X_{2}+a\right)^{2}\right]=\mathbb{E} X_{1}^{2}+\mathbb{E} X_{2}^{2}+a^{2}$. Thus,

$$
\begin{equation*}
\int_{-\infty}^{\infty} \int_{-\infty}^{\infty}\left(x_{1}+x_{2}+a\right)^{2} f_{X_{1}}\left(x_{1}\right) f_{X_{2}}\left(x_{2}\right) d x_{1} d x_{2} \geq \mathbb{E} X_{1}^{2}+\mathbb{E} X_{2}^{2} \tag{288}
\end{equation*}
$$

The last inequality holds for any $\varphi_{x_{1}, x_{2}}$ which symmetrizes- $\mathcal{X}_{1} \times \mathcal{X}_{2}$ the channel. Now, observe that (286) holds for $\hat{\varphi}_{x_{1}, x_{2}}(s)=$ $\delta\left(s-x_{1}-x_{2}\right)$, where $\delta(\cdot)$ is the Dirac delta function, hence $\hat{\varphi}_{x_{1}, x_{2}}$ symmetrizes- $\mathcal{X}_{1} \times \mathcal{X}_{2}$ the channel. In addition, since $\hat{\varphi}_{0,0}$ gives probability 1 to $S=0$, we have that (288) holds with equality for $\hat{\varphi}_{x_{1}, x_{2}}$, and thus, $\Psi\left(F_{X_{1}} F_{X_{2}}\right)=\mathbb{E} X_{1}^{2}+\mathbb{E} X_{2}^{2}$.

Next, consider $\Psi_{1}\left(F_{X_{1}}\right)$. The Gaussian AVMAC is symmetrized $-\mathcal{X}_{1} \mid \mathcal{X}_{2}$ by a conditional pdf $\varphi_{x_{1}}^{\prime}(s)=\varphi_{1}\left(s \mid x_{1}\right)$ if

$$
\begin{equation*}
\int_{-\infty}^{\infty} \varphi_{0}^{\prime}(s) f_{Z}\left(y-x_{1}-x_{2}-s\right) d s=\int_{-\infty}^{\infty} \varphi_{x_{1}}^{\prime}(s) f_{Z}\left(y-x_{2}-s\right) d s \tag{289}
\end{equation*}
$$

for all $x_{1}, x_{2}, y \in \mathbb{R}$. By substituting $y^{\prime}=y-x_{2}, z=y^{\prime}-x_{1}-s$ in the LHS, and $\bar{z}=y^{\prime}-s$ in the RHS, this is equivalent to

$$
\begin{equation*}
\int_{-\infty}^{\infty} \varphi_{0}^{\prime}\left(y^{\prime}-x_{1}-z\right) f_{Z}(z) d z=\int_{-\infty}^{\infty} \varphi_{x_{1}}^{\prime}\left(y^{\prime}-\bar{z}\right) f_{Z}(\bar{z}) d \bar{z} \tag{290}
\end{equation*}
$$

As earlier, it follows that $\varphi_{x_{1}}^{\prime}$ symmetrizes- $\mathcal{X}_{1} \mid \mathcal{X}_{2}$ if and only if $\varphi_{x_{1}}^{\prime}(s)=\varphi_{0}^{\prime}\left(s-x_{1}\right)$. By similar derivation as in (287), the corresponding state cost satisfies

$$
\begin{equation*}
\int_{-\infty}^{\infty} \int_{-\infty}^{\infty} f_{X_{1}}\left(x_{1}\right) \varphi_{x_{1}}^{\prime}(s) s^{2} d x_{1} d s=\mathbb{E} X_{1}^{2}+\int_{-\infty}^{\infty} a^{\prime 2} \varphi_{0}^{\prime}\left(a^{\prime}\right) d a^{\prime} \geq \mathbb{E} X_{1}^{2} \tag{291}
\end{equation*}
$$

with equality for $\varphi_{x_{1}}^{\prime}(s)=\delta\left(s-x_{1}\right)$. Hence, $\widetilde{\Lambda}_{1}\left(F_{X_{1}}\right)=\mathbb{E} X_{1}^{2}$, and by symmetry, $\Psi_{2}\left(F_{X_{2}}\right)=\mathbb{E} X_{2}^{2}$. This completes the proof of Lemma 17.

Going forward with the derivation of the deterministic code capacity region, we have by Lemma 17 that the thresholds defined in (34)-(36) are given by

$$
\begin{align*}
& L^{*}=\max _{F_{X_{1}} F_{X_{2}}: \mathbb{E} X_{1}^{2} \leq \Omega_{1}, \mathbb{E} X_{2}^{2} \leq \Omega_{2}} \widetilde{\Lambda}\left(F_{U, X_{1}, X_{2}}\right)=\Omega_{1}+\Omega_{2}  \tag{292}\\
& L_{1}^{*}=\max _{F_{X_{1}} \mathbb{E} X_{1}^{2} \leq \Omega_{1}} \widetilde{\Lambda}_{1}\left(F_{U, X_{1}}\right)=\Omega_{1}  \tag{293}\\
& L_{2}^{*}=\max _{F_{X_{2}} \mathbb{E} X_{2}^{2} \leq \Omega_{2}} \widetilde{\Lambda}_{2}\left(F_{U, X_{2}}\right)=\Omega_{2} \tag{294}
\end{align*}
$$

We can now complete the derivation by applying Theorem 8 to cases where $\Omega_{k} \neq \Lambda$ for $k=1,2$.
If $\Omega_{1}>\Lambda$ and $\Omega_{2}>\Lambda$, then $L^{*}>\Lambda, L_{1}^{*}>\Lambda$, and $L_{2}^{*}>\Lambda$, which corresponds to Case a) in Definition 6. We have seen that the random code capacity region is achieved with the input distribution specified by $U=\emptyset, X_{1} \sim \mathcal{N}\left(0, \Omega_{1}\right)$, and $X_{2} \sim \mathcal{N}\left(0, \Omega_{2}\right)$, which is in the set $\overline{\mathcal{P}}_{\Omega_{1}, \Omega_{2}, \Lambda}\left(\mathcal{U} \times \mathcal{X}_{1} \times \mathcal{X}_{2}\right)$ (see (37b)). It follows that the capacity region is the same as the random code capacity region, i.e. $\mathbb{C}(\mathscr{A})=\mathbb{C}^{\star}(\mathscr{A})$, as in (72).

For the Gaussian AVMAC, as opposed to the scenario discussed in Remark 10, the cases where one of the users has zero capacity can be derived from the single user results. This occurs as the minimal state cost $\widetilde{\Lambda}_{1}\left(F_{U, X_{1}}\right)$ for symmetrizability- $\mathcal{X}_{1}$, given in Lemma 17, is the same as the minimal state cost for single user symmmetrizability of the Gaussian AVC (see [17]).

Now, based on Csiszár and Narayan's results on the single user Gaussian AVC [18], we have the following. If $\Omega_{1} \leq \Lambda$ and $\Omega_{2}>\Lambda$, then the individual capacities of User 1 and User 2 are $C_{1}=0$ and $C_{2}=\frac{1}{2} \log \left(1+\frac{\Omega_{2}}{\Lambda+\sigma^{2}}\right)$, respectively, which implies (73). Similarly, if $\Omega_{1}>\Lambda$ and $\Omega_{2} \leq \Lambda$, then the individual capacities are $C_{1}=\frac{1}{2} \log \left(1+\frac{\Omega_{1}}{\Lambda+\sigma^{2}}\right)$ and $C_{2}=0$, which results in (74). If $\Omega_{1} \leq \Lambda$ and $\Omega_{2} \leq \Lambda$, then $C_{1}=C_{2}=0$, hence, (75) follows.
