# A squeezing invariant measurement to test displacement of quantum Gaussian states

#### Abstract

We consider a hypothesis testing problem for displacement parameters of $n$ independent copies of an $m$-mode squeezed quantum Gaussian state whose mixture parameter is known. Given $n \geq 2$, we construct a quantum measurement as a test using an observable which is invariant by $n$-fold tensor product of any $m$-mode squeezing operator. For a pure state case, we calculate the type II error probability of this test. We compare this test with a Hotelling's $T$-squared test which is based on heterodyne measurements.


## 1 Introduction

In quantum hypothesis testing [1], it is important to test whether the displacement parameter of several independent copies of a quantum Gaussian state [2] is zero or not. Kumagai and Hayashi [3] have studied this problem in a situation that the mixture parameter is unknown and that the state is not squeezed. They constructed a Positive Operator Valued Measurement (POVM) as a test which is invariant by some unitary actions. Using the invariance, they proved that their test is optimal in a minimax criterion. On the other hand, if the states are squeezed by an unknown squeezing action, then, even if the mixture parameter is known, we have not obtained an optimal test. For example, we will need such a test when we should check a displacement channel by setting a squeezed probe which is generated by a squeezing device which is not completely controlled.

One of reasonable measurements for this problem might be the Hotelling's $T$-squared test [4] using data from heterodyne measurements [5]. We call this test the Heterodyne-Hotelling (HH) test. Let $\hat{\rho}_{\vec{\theta}, N}$ be an $m$-mode nonsqueezed quantum Gaussian state parameterized by a displacement vector $\vec{\theta} \in \mathbb{C}^{m}$ and by a mixture value $N \geq 0$. Let $\hat{S}_{\eta}$ be an $m$-mode squeezing operator parameterized by a matrix $\eta$. The $m$-mode squeezed quantum

Gaussian state is defined by $\hat{\rho}_{\vec{\theta}, \eta, N}=\hat{S}_{\eta} \hat{\rho}_{\vec{\theta}, N} \hat{S}_{\eta}^{*}$. If there are $n$ independent copies of $\hat{\rho}_{\vec{\theta}, \eta, N}$, and if $m n$ independent heterodyne measurements are applied to $\hat{\rho}_{\hat{\theta}, \eta, N}^{\otimes n}$, then we obtain $n$ independent random vectors obeying a common $2 m$-dimensional normal distribution. If $n \geq 2 m+1$, then the sample covariance matrix $\bar{\Sigma}_{n}$ is invertible by probability one, and the Hotelling's $T$-squared statistic $T^{2}$ can be defined using $\bar{\Sigma}_{n}^{-1}$. Let $\mu=2 m$, and let $\nu=n-\mu$. If $\vec{\theta}$ is the zero vector $\overrightarrow{0}_{m} \in \mathbb{C}^{m}$, then $F_{\mathrm{HH}}=(n-1)^{-1}(\nu / \mu) T^{2}$ obeys $F_{\mu, \nu}$, the central $F$ distribution with $\mu$ and $\nu$ degrees of freedom. (See [6].) Choose a constant $\alpha$ as a level (of significance). (See [7].) Define a critical point $c$ as a solution to the equation $\operatorname{Pr}\left\{F_{\mathrm{HH}}>c \mid \vec{\theta}=\overrightarrow{0}_{m}\right\}=\alpha$. The HH test $T_{\alpha}^{\mathrm{HH}}$ of level $\alpha$ is a decision rule by which $\vec{\theta}=\overrightarrow{0}_{m}$ is accepted if $F_{\mathrm{HH}} \leq c$ is observed. Even if $N$ is unknown, $T_{\alpha}^{\mathrm{HH}}$ can be defined. However, if $n \leq 2 m$, then $T_{\alpha}^{\mathrm{HH}}$ can not be defined for the sake of non-invertibility of $\bar{\Sigma}_{n}$. Moreover, even if $N$ is zero, $T_{0}^{\mathrm{HH}}$ is a trivial test in a sense that $c$ is infinity. Furthermore, in a minimax criterion, $T_{\alpha}^{\mathrm{HH}}$ is not optimal.

In this paper, assuming $N$ is known and $\eta$ is unknown, we propose a new test. Since the new test is invariant by the action of $\hat{S}_{\eta}^{\otimes n}$, it is said to be Squeezing Invariant (SI). The SI test of level $\alpha$ is denoted by $T_{\alpha}^{\mathrm{SI}}$. If $N$ is unknown, then $T_{\alpha}^{\text {SI }}$ is not defined. However, for the following three reasons, $T_{\alpha}^{\mathrm{SI}}$ is superior to $T_{\alpha}^{\mathrm{HH}}$. First, $n \geq 2$ is enough to define $T_{\alpha}^{\mathrm{SI}}$. Second, if $N=0$, then $T_{0}^{\mathrm{SI}}$ is not a trivial test. Third, if $N=0$, then, in a minimax criterion, $T_{\alpha}^{\mathrm{SI}}$ dominates $T_{\alpha}^{\mathrm{HH}}$.

In Sec. 2, we will setup the problem by defining words and symbols. In Sec. 3, we will construct $T_{\alpha}^{\mathrm{HH}}$ and $T_{\alpha}^{\mathrm{SI}}$. In Sec. 4, we will give six theorems and a numerical comparison. In Sec. 5 , we will give proofs of the theorems.

## 2 Setups

We define words and symbols.

### 2.1 What is quantum hypothesis testing?

Let $\mathcal{H}$ be a Hilbert space. For $f \in \mathcal{H}$, let $f^{*}$ be the dual vector, and let $\|f\|=\sqrt{f^{*} f}$ be the norm. Let $\mathcal{L}(\mathcal{H})$ be the set of linear operators on $\mathcal{H}$. Let $\hat{I}_{\mathcal{H}} \in \mathcal{L}(\mathcal{H})$ be the identity. Let $X^{*}$ be the adjoint of $X \in \mathcal{L}(\mathcal{H})$. Let $\mathcal{U}(\mathcal{H}) \subset \mathcal{L}(\mathcal{H})$ be the set of unitary operators. If $X \in \mathcal{L}(\mathcal{H})$ is positive, then we write $X \geq 0$. Let $\operatorname{Tr}[X]$ be the trace of $X \in \mathcal{L}(\mathcal{H})$. The set of density operators is given by $\mathcal{S}(\mathcal{H})=\{\hat{\rho} \in \mathcal{L}(\mathcal{H}) \mid \hat{\rho} \geq 0, \operatorname{Tr}[\hat{\rho}]=1\}$.

Consider a quantum system described by $\mathcal{H}$ whose state $\hat{\rho} \in \mathcal{S}(\mathcal{H})$ is unknown. Let $\mathcal{S}_{0}$ and $\mathcal{S}_{1}$ be subsets of $\mathcal{S}(\mathcal{H})$, where the intersection $\mathcal{S}_{0} \cap \mathcal{S}_{1}$ is
empty. Assume that either $\hat{\rho} \in \mathcal{S}_{0}$ or $\hat{\rho} \in \mathcal{S}_{1}$ is true. When we need to accept the null hypothesis $H_{0}: \hat{\rho} \in \mathcal{S}_{0}$ or the alternative hypothesis $H_{1}: \hat{\rho} \in \mathcal{S}_{1}$, it is said that we test

H_{0}: \hat{\rho} \in \mathcal{S}_{0} \text { versus } H_{1}: \hat{\rho} \in \mathcal{S}_{1} . \tag{1}

Let $\hat{\Pi}_{0}$ and $\hat{\Pi}_{1}$ be positive operators satisfying $\hat{\Pi}_{0}+\hat{\Pi}_{1}=\hat{I}_{\mathcal{H}}$. A test for (1) is a two-valued POVM $\left\{\hat{\Pi}_{0}, \hat{\Pi}_{1}\right\}$ by which $H_{k}$ is accepted if $\hat{\Pi}_{k}$ is observed.

Let $T$ be a test with POVM $\left\{\hat{\Pi}_{0}, \hat{\Pi}_{1}\right\}$. There are two types of mistakes caused by $T$. The type I error is acceptance of $H_{1}$ while $H_{0}$ is true. The type II error is acceptance of $H_{0}$ while $H_{1}$ is true. Hence, the type I error probability is defined by $\alpha_{\hat{\rho}}[T]=\operatorname{Tr}\left[\hat{\rho} \hat{\Pi}_{1}\right]$ as a function of $\hat{\rho} \in \mathcal{S}_{0}$, and the type II error probability is defined by $\beta_{\hat{\rho}}[T]=\operatorname{Tr}\left[\hat{\rho} \hat{\Pi}_{0}\right]$ as a function of $\hat{\rho} \in \mathcal{S}_{1}$. A level (of significance) is an upper bound for $\alpha_{\hat{\rho}}[T]$. If $\sup _{\hat{\rho} \in \mathcal{S}_{0}} \alpha_{\hat{\rho}}[T] \leq \alpha$ holds, then $T$ is called a test of level $\alpha$. If $\alpha$ is small, and if $H_{1}$ is accepted, then one may be confident that $H_{1}$ is really true because the risk of type I error is negligible. This method was proposed by [1] as a generalization of the classical statistical hypothesis testing theory, which is described in [7].

For any $\alpha$ with $0 \leq \alpha \leq 1$, there exists a test of level $\alpha$. Let $T_{\alpha}^{\text {triv }}$ be a test defined by $\hat{\Pi}_{0}=(1-\alpha) \hat{I}_{\mathcal{H}}$. For any $\hat{\rho} \in \mathcal{S}_{0}$, it holds that $\alpha_{\hat{\rho}}\left[T_{\alpha}^{\text {triv }}\right]=\alpha$. Hence, $T_{\alpha}^{\text {triv }}$ is a test of level $\alpha$, and is called a trivial test of level $\alpha$.

If $T_{1}$ and $T_{2}$ are tests of a common level $\alpha$, then they are compared by the type II error probabilities. If

\beta_{\hat{\rho}}\left[T_{1}\right] \leq \beta_{\hat{\rho}}\left[T_{2}\right]\left(\forall \hat{\rho} \in \mathcal{S}_{1}\right) \text { and } \beta_{\hat{\rho}}\left[T_{1}\right]<\beta_{\hat{\rho}}\left[T_{2}\right]\left(\exists \hat{\rho} \in \mathcal{S}_{1}\right) \tag{2}

hold, then we conclude that $T_{1}$ dominates $T_{2}$. If a test $T$ dominates $T_{\alpha}^{\text {triv }}$, then there exists $\hat{\rho} \in \mathcal{S}_{1}$ such that $\beta_{\hat{\rho}}[T]<1-\alpha$.

In many cases, however, the condition (2) is so strict that we can not complete the comparison. Hence, we use a minimax criterion instead of (2). Consider a case where $\hat{\rho} \in \mathcal{S}_{0} \cup \mathcal{S}_{1}$ is parameterized by $\theta \in \Theta$ and $\xi \in \Xi$ as $\hat{\rho}_{\theta, \xi}$. If there exists $\Theta_{1} \subset \Theta$ such that $\mathcal{S}_{1}=\left\{\hat{\rho}_{\theta, \xi} \mid \theta \in \Theta_{1}, \xi \in \Xi\right\}$, then we are not interested in the true value of $\xi$. In such a case, $\theta$ is called the parameter of interest, and $\xi$ is called the parameter of nuisance. (In this sense, the displacement is the parameter of interest, and the squeezing is the parameter of nuisance.) The condition (2) is modified as

& \text { and } \sup _{\xi \in \Xi} \beta_{\hat{\rho}_{\theta, \xi}}\left[T_{1}\right]<\sup _{\xi \in \Xi} \beta_{\hat{\rho}_{\theta, \xi}}\left[T_{2}\right]\left(\exists \theta \in \Theta_{1}\right) . \tag{3}
\end{align*}
$$

If $T_{1}$ and $T_{2}$ of a common level $\alpha$ satisfy the condition (3), then we conclude that $T_{1}$ domintates $T_{2}$ in the minimax criterion. If a test $T$ of level $\alpha$ satisfies
$\sup _{\xi \in \Xi} \beta_{\hat{\rho}_{\theta}, \xi}[T]=1-\alpha\left({ }^{\forall} \theta \in \Theta_{1}\right)$, then, in the minimax criterion, $T$ is no better than $T_{\alpha}^{\text {triv }}$.

Kumagai and Hayashi [3] studied a theory of the minimax criterion in quantum hypothesis testing, and they showed that an optimality in the minimax criterion is concerned with unitary invariance. Let $\theta \in \Theta$ be the parameter of interest, and let $\xi \in \Xi$ be the parameter of nuisance. Let $U: \Xi \rightarrow \mathcal{U}(\mathcal{H})$ be a map given as $\xi \mapsto U_{\xi}$. Assume that there exists $\xi_{0} \in \Xi$ such that $\hat{\rho}_{\theta, \xi}=U_{\xi} \hat{\rho}_{\theta, \xi_{0}} U_{\xi}^{*}$ holds for any $\theta \in \Theta$ and for any $\xi \in \Xi$. A test $T$ whose POVM $\left\{\hat{\Pi}_{0}, \hat{\Pi}_{1}\right\}$ satisfies $U_{\xi}^{*} \hat{\Pi}_{0} U_{\xi}=\hat{\Pi}_{0}\left({ }^{\forall} \xi \in \Xi\right)$ is said to be invariant by $U$. If $T$ is invariant by $U$, then it holds that

\beta_{\hat{\rho}_{\theta, \xi}}[T]=\operatorname{Tr}\left[\hat{\rho}_{\theta, \xi_{0}} \hat{\Pi}_{0}\right] \quad\left({ }^{\forall} \theta \in \Theta_{1},{ }^{\forall} \xi \in \Xi\right) . \tag{4}
\end{equation*}
$$

Kumagai and Hayashi [3] proved that a test is invariant by such $U$ if the test is optimal in the minimax criterion.

We do not prove optimality of $T_{\alpha}^{\mathrm{SI}}$. However, we prove that $T_{\alpha}^{\mathrm{SI}}$ is SI, and that, if the mixture $N$ is zero, then $T_{\alpha}^{\mathrm{SI}}$ dominates $T_{\alpha}^{\text {triv }}$ in the minimax criterion. Moreover, we prove that $T_{\alpha}^{\mathrm{HH}}$ does not satisfy (4), which is a necessary condition for $T$ to be SI. Furthermore, we prove that $T_{\alpha}^{\mathrm{HH}}$ is no better than $T_{\alpha}^{\text {triv }}$ in the minimax criterion. Hence, $T_{\alpha}^{\mathrm{SI}}$ dominates $T_{\alpha}^{\mathrm{HH}}$ in the minimax criterion.

### 2.2 Notations of sets of matrices

To parameterize multi-mode squeezing operators, we use several sets of matrices. Let $\mathbb{N}$ be the set of positive integers.. For any $m, n \in \mathbb{N}$, let Mat $\mathbb{K}_{\mathbb{K}}^{m, n}$ be the set of $m$-by- $n$ matrices whose entries belong to $\mathbb{K}$, which will be $\mathbb{C}$ or $\mathbb{R}$. For $X \in \operatorname{Mat}_{\mathbb{C}}^{m, n}$, the transpose is denoted by ${ }^{t} X \in \operatorname{Mat}_{\mathbb{C}}^{n, m}$, the entry-wise complex conjugate is denoted by $\bar{X} \in \mathrm{Mat}_{\mathbb{C}}^{m, n}$, and the adjoint ${ }^{t} \bar{X}$ is denoted by $X^{*} \in \operatorname{Mat}_{\mathbb{C}}^{n, m}$. Let Mat $\mathbb{K}_{\mathbb{K}}^{m}$ be $\operatorname{Mat}_{\mathbb{K}}^{m, m}$. The set of anti-hermitian matrices is defined by $\mathrm{Ant}_{\mathbb{K}}^{m}=\left\{A \in \operatorname{Mat}_{\mathbb{K}}^{m} \mid A=-A^{*}\right\}$. The set of symmetric matrices is defined by $\operatorname{Sym}_{\mathbb{K}}^{m}=\left\{S \in \operatorname{Mat}_{\mathbb{K}}^{m} \mid S={ }^{t} S\right\}$. Define $\operatorname{Sqz}^{m} \subset \operatorname{Mat}_{\mathbb{C}}^{2 m}$ by

For $\eta \in \mathrm{Sqz}^{m}$, the upper-left submatrix $A \in \mathrm{Ant}_{\mathbb{C}}^{m}$ is called the anti-hermitian part of $\eta$, and the upper-right submatrix $S \in \mathrm{Sym}_{\mathbb{C}}^{m}$ is called the symmetric part of $\eta$.

### 2.3 Multi-mode squeezed quantum Gaussian states

Let $\mathcal{H}$ be $L^{2}(\mathbb{R})$, the set of $\mathbb{C}$-valued square-integrable functions of a real coordinate variable $x \in \mathbb{R}$. The inner product of $f, g \in \mathcal{H}$ is defined by $f^{*} g=\int_{\mathbb{R}} \overline{f(x)} g(x) d x$, where $\bar{z}$ is the conjugate of $z \in \mathbb{C}$. A single-mode electromagnetic field is described by $\mathcal{H}$. (See [8] and [9].) For $\theta \in \mathbb{C}$, the coherent vector $|\theta\rangle \in \mathcal{H}$ is defined by

|\theta\rangle(x)=\frac{e^{-|\theta|^{2} / 2}}{\pi^{1 / 4}} e^{-x^{2} / 2+\sqrt{2} \theta x-\theta^{2} / 2} .
$$

Let $\langle\theta|$ be $|\theta\rangle^{*}$. For $\theta \in \mathbb{C}$, and for $N \geq 0$, the single-mode non-squeezed quantum Gaussian state $\hat{\rho}_{\theta, N} \in \mathcal{S}(\mathcal{H})$ is defined by

\hat{\rho}_{\theta, N}= \begin{cases}|\theta\rangle\langle\theta| & \text { if } N=0, \\ \frac{1}{\pi N} \iint_{\mathbb{R}^{2}} e^{-|r+i s-\theta|^{2} / N}|r+i s\rangle\langle r+i s| d r d s & \text { if } N>0,\end{cases}
$$

where $i=\sqrt{-1}$. (See [2].) The state is pure if $N=0$.
For $m \in \mathbb{N}$, an $m$-mode system is described by $\mathcal{H}^{\otimes m}$. For $\vec{\theta}={ }^{t}\left(\theta_{1}, \theta_{2}, \ldots\right.$, $\left.\theta_{m}\right) \in \operatorname{Mat}_{\mathbb{C}}^{m, 1}$, and for $N \geq 0$, the $m$-mode non-squeezed quantum Gaussian state $\hat{\rho}_{\vec{\theta}, N} \in \mathcal{S}\left(\mathcal{H}^{\otimes m}\right)$ is defined by $\hat{\rho}_{\vec{\theta}, N}=\hat{\rho}_{\theta_{1}, N} \otimes \hat{\rho}_{\theta_{2}, N} \otimes \cdots \otimes \hat{\rho}_{\theta_{m}, N}$.

Define $\hat{q} \in \mathcal{L}(\mathcal{H})$ by $\hat{q} f(x)=x f(x)$, and define $\hat{p} \in \mathcal{L}(\mathcal{H})$ by $\hat{p} f(x)=$ $-i d f(x) / d x$, where $i=\sqrt{-1}$. They satisfy $\hat{q}=\hat{q}^{*}, \hat{p}=\hat{p}^{*}$ and $[\hat{q}, \hat{p}]=$ $\hat{q} \hat{p}-\hat{p} \hat{q}=i \hat{I}$, where $\hat{I} \in \mathcal{L}(\mathcal{H})$ is the identity. The annihilation operator $\hat{a} \in \mathcal{L}(\mathcal{H})$ is defined by $\hat{a}=(\hat{q}+i \hat{p}) / \sqrt{2}$. It holds that $\left[\hat{a}, \hat{a}^{*}\right]=\hat{I}$, and that

For $i \in\{1,2, \ldots, m\}$, the $i$-th annihilation operator $\hat{a}_{i} \in \mathcal{L}\left(\mathcal{H}^{\otimes m}\right)$ is defined by $\hat{a}_{i}=\hat{I}^{\otimes(i-1)} \otimes \hat{a} \otimes \hat{I}^{\otimes(m-i)}$. For $\eta \in \mathrm{Sqz}^{m}$, let $A_{i, j}$ and $S_{i, j}$ be the $(i, j)$-th entries of the anti-hermitian part and of the symmetric part, respectively, and let

\hat{s}_{\eta}=\sum_{i=1}^{m} \sum_{j=1}^{m}\left(A_{i, j} \hat{a}_{i}^{*} \hat{a}_{j}+\frac{1}{2} S_{i, j} \hat{a}_{i}^{*} \hat{a}_{j}^{*}-\frac{1}{2} \bar{S}_{i, j} \hat{a}_{i} \hat{a}_{j}\right) .
$$

An $m$-mode squeezing operator $\hat{S}_{\eta} \in \mathcal{U}\left(\mathcal{H}^{\otimes m}\right)$ is defined by $\hat{S}_{\eta}=\exp \left(\hat{s}_{\eta}\right)$. The $m$-mode squeezed quantum Gaussian state $\hat{\rho}_{\vec{\theta}, \eta, N} \in \mathcal{S}\left(\mathcal{H}^{\otimes m}\right)$ is defined by $\hat{\rho}_{\vec{\theta}, \eta, N}=\hat{S}_{\eta} \hat{\rho}_{\vec{\theta}, N} \hat{S}_{\eta}^{*}$.

### 2.4 Our hypothesis testing problem

Suppose that a quantum state of the form $\hat{\rho}_{\hat{\theta}, \eta, N}^{\otimes n} \in \mathcal{S}\left(\mathcal{H}^{\otimes m n}\right)$ is given. We call $m \in \mathbb{N}$ the mode size, $n \in \mathbb{N}$ the sample size, $\vec{\theta} \in \operatorname{Mat}_{\mathbb{C}}^{m, 1}$ the displacement parameter, $\eta \in \mathrm{Sqz}^{m}$ the squeezing parameter and $N \geq 0$ the mixture
parameter. We assume that $\vec{\theta}$ and $\eta$ are unknown, and that $N$ is known. Our problem is to test

H_{0}: \vec{\theta}=\overrightarrow{0}_{m} \text { versus } H_{1}: \vec{\theta} \neq \overrightarrow{0}_{m}, \tag{6}
\end{equation*}
$$

where $\overrightarrow{0}_{m} \in$ Mat $_{\mathbb{C}}^{m, 1}$ is the zero vector.
The squeezing parameter $\eta \in \mathrm{Sqz}^{m}$ is a nuisance parameter because (6) does not depend on $\eta$. Hence, the minimax criterion (3) is specified by $\Theta_{1}=\left\{\vec{\theta} \in \operatorname{Mat}_{\mathbb{C}}^{m, 1} \mid \vec{\theta} \neq \overrightarrow{0}_{m}\right\}$ and by $\Xi=$ Sqz $^{m}$. For a subspace $\mathcal{K} \subset \mathcal{H}^{\otimes m n}$, and for $\hat{L} \in \mathcal{L}\left(\mathcal{H}^{\otimes m n}\right)$, let $\hat{L} \mathcal{K} \subset \mathcal{H}^{\otimes m n}$ be $\{\hat{L} f \mid f \in \mathcal{K}\}$. If $\hat{S}_{\eta}^{\otimes n} \mathcal{K}=\mathcal{K}$ holds for any $\eta \in \mathrm{Sqz}^{m}$, then $\mathcal{K}$ is said to be Squeezing Invariant (SI). If $\hat{L} \in \mathcal{L}\left(\mathcal{H}^{\otimes m n}\right)$ satisfies $\hat{L}=\left(\hat{S}_{\eta}^{\otimes n}\right)^{*} \hat{L} \hat{S}_{\eta}^{\otimes n}\left({ }^{\forall} \eta \in\right.$ Sqz $\left.^{m}\right)$, then $\hat{L}$ is said to be SI. A test with POVM $\left\{\hat{\Pi}_{0}, \hat{\Pi}_{1}\right\}$ is said to be SI if $\hat{\Pi}_{0}$ is SI.

### 2.5 Definition of $a_{i, j}$

For $i \in\{1,2, \ldots, m\}$ and for $j \in\{1,2, \ldots, n\}$, the $(i, j)$-th annihilation operator $\hat{a}_{i, j} \in \mathcal{L}\left(\mathcal{H}^{\otimes m n}\right)$ is defined by

$$
\hat{a}_{i, j}=\hat{I}^{\otimes(j m-m)} \otimes \hat{a}_{i} \otimes \hat{I}^{\otimes(m n-j m)}=\hat{I}^{\otimes(i-1+j m-m)} \otimes \hat{a} \otimes \hat{I}^{\otimes(m-i+m n-j m)} .
$$

## 3 Constructions of $T_{\alpha}^{\mathrm{SI}}$ and $T_{\alpha}^{\mathrm{HH}}$

### 3.1 Construction of $T_{\alpha}^{\text {SI }}$

Assume that $n \geq 2$. We first construct an observable $\hat{T}_{\text {SI }} \in \mathcal{L}\left(\mathcal{H}^{m n}\right)$, which is positive and SI. For $j, k \in\{1,2, \ldots, n\}$, let $\hat{v}_{j, k}=\sum_{i=1}^{m}\left(\hat{a}_{i, k}^{*} \hat{a}_{i, j}-\hat{a}_{i, j}^{*} \hat{a}_{i, k}\right)$. We will show, in Theorem 1, that $\hat{v}_{j, k}$ is SI. Moreover, by Lemma $14, \hat{v}_{j, k}$ is unitarily equivalent to

$$
\begin{equation*}
\hat{d}_{j, k}=\sqrt{-1} \sum_{i=1}^{m}\left(\hat{a}_{i, j}^{*} \hat{a}_{i, j}-\hat{a}_{i, k}^{*} \hat{a}_{i, k}\right) . \tag{7}
\end{equation*}
$$

For $k \in\{1,2, \ldots, n-1\}$, let $\hat{r}_{k}=\arctan (\sqrt{k}) \hat{v}_{k, k+1}$, and let $\hat{R}_{k}=\exp \left(\hat{r}_{k}\right) \in$ $\mathcal{U}\left(\mathcal{H}^{\otimes m n}\right)$. Let $\hat{R}=\hat{R}_{n-1} \hat{R}_{n-2} \cdots \hat{R}_{1} \in \mathcal{U}\left(\mathcal{H}^{\otimes m n}\right)$. Let $\hat{T}_{\mathrm{SI}}=\sum_{k=1}^{n-1} \hat{R}^{*} \hat{v}_{k, n} \hat{v}_{k, n}^{*} \hat{R}$.
Because of $\hat{v}_{k, n} \hat{v}_{k, n}^{*} \geq 0$, we have $\hat{T}_{\text {SI }} \geq 0$. Moreover, since $\hat{v}_{j, k}$ is SI, $\hat{T}_{\mathrm{SI}}$ is SI.
Next, we construct the SI test of level $\alpha \in[0,1]$. For $t \in \mathbb{R}$, define a Hilbert subspace $\mathcal{K}_{t} \subset \mathcal{H}^{\otimes m n}$ by

$$
\mathcal{K}_{t}=\left\{f \in \mathcal{H}^{\otimes m n} \mid f^{*} \hat{T}_{\mathrm{SI}} f \leq t\|f\|^{2}\right\} .
$$

Since $\hat{T}_{\mathrm{SI}}$ is SI, $\mathcal{K}_{t}$ is SI. Since $\hat{T}_{\mathrm{SI}} \geq 0$ holds, $s<0$ implies $\mathcal{K}_{s}=\{0\}$. Let $\hat{K}_{t} \in \mathcal{L}\left(\mathcal{H}^{\otimes m n}\right)$ be the projection on $\mathcal{K}_{t}$. Since $\mathcal{K}_{t}$ is SI, $\hat{K}_{t}$ is SI. Hence, for any $\eta \in \operatorname{Sqz}^{m}$, it holds that $\operatorname{Tr}\left[\hat{\rho}_{\vec{\theta}, \eta, N}^{\otimes n} \hat{K}_{t}\right]=\operatorname{Tr}\left[\hat{\rho}_{\vec{\theta}, N}^{\otimes n} \hat{K}_{t}\right]$.

Assume that $N$ is known. For $\alpha \in[0,1]$, let $s, t, w \in \mathbb{R}$ be solutions to

$$
\left\{\begin{array}{l}
1-\alpha=(1-w) \operatorname{Tr}\left[\hat{\rho}_{0_{m}, N}^{\otimes n} \hat{K}_{s}\right]+w \operatorname{Tr}\left[\hat{\rho}_{\hat{0}_{m}, N}^{\otimes n} \hat{K}_{t}\right] \\
s<t \text { and } 0<w \leq 1 .
\end{array}\right.
$$

Let $\hat{\Pi}_{0}=(1-w) \hat{K}_{s}+w \hat{K}_{t}$, and let $\hat{\Pi}_{1}=\hat{I}^{\otimes m n}-\hat{\Pi}_{0}$. The SI test $T_{\alpha}^{\mathrm{SI}}$ is defined by the POVM $\left\{\hat{\Pi}_{0}, \hat{\Pi}_{1}\right\}$.

### 3.2 Construction of $T_{\alpha}^{\mathrm{HH}}$

Let $\mathcal{F}$ be the set of Borel subsets of $\mathbb{R}^{2}$. A single-mode heterodyne measurement is a POVM defined by

$$
\mathcal{F} \ni M \mapsto \frac{1}{\pi} \iint_{M}|x+i y\rangle\langle x+i y| d x d y
$$

where $i=\sqrt{-1}$. For $\eta \in \mathrm{Sqz}^{m}$, let $A \in \operatorname{Ant}_{\mathbb{C}}^{m}$ be the anti-hermitian part, and let $S \in \operatorname{Sym}_{\mathbb{C}}^{m}$ be the symmetric part. Define $\vec{\mu}_{\vec{\theta}} \in \operatorname{Mat}_{\mathbb{R}}^{2 m, 1}$ and $G_{\eta} \in \operatorname{Mat}_{\mathbb{R}}^{2 m}$ by

$$
\vec{\mu}_{\vec{\theta}}=\binom{\operatorname{Re}(\vec{\theta})}{\operatorname{Im}(\vec{\theta})} \text { and } G_{\eta}=\exp \left(\begin{array}{cc}
\operatorname{Re}(A)+\operatorname{Re}(S) & -\operatorname{Im}(A)+\operatorname{Im}(S)  \tag{8}\\
\operatorname{Im}(A)+\operatorname{Im}(S) & \operatorname{Re}(A)-\operatorname{Re}(S)
\end{array}\right)
$$

respectively. Define $\vec{\mu}_{\vec{\theta}, \eta} \in \operatorname{Mat}_{\mathbb{R}}^{2 m, 1}$ and $\Sigma_{\eta, N} \in \operatorname{Mat}_{\mathbb{R}}^{2 m}$ by

$$
\begin{equation*}
\vec{\mu}_{\vec{\theta}, \eta}=G_{\eta} \vec{\mu}_{\vec{\theta}} \text { and } \Sigma_{\eta, N}=\frac{2 N+1}{4} G_{\eta}\left({ }^{t} G_{\eta}\right)+\frac{1}{4} I_{2 m} \tag{9}
\end{equation*}
$$

respectively. By Lemma 30, applying $m n$ independent single-mode heterodyne measurements to $\hat{\rho}_{\hat{\theta}, n, N}^{\otimes n}$, we obtain $n$ independent $2 m$-dimensional random vectors $\vec{X}_{1}, \vec{X}_{2}, \ldots, \vec{X}_{n}$ according to a common $2 m$-dimensional normal distribution whose mean vector is $\vec{\mu}_{\vec{\theta}, \eta}$ and whose covariance matrix is $\Sigma_{\eta, N}$; say $N_{2 m}\left(\vec{\mu}_{\vec{\theta}, \eta}, \Sigma_{\eta, N}\right)$. Let $\bar{X}_{n}$ be the sample mean vector $n^{-1} \sum_{j=1}^{n} \vec{X}_{j}$, and let $\bar{\Sigma}_{n}$ be the sample covariance matrix $(n-1)^{-1} \sum_{j=1}^{n}\left(\vec{X}_{j}-\bar{X}_{n}\right)\left({ }^{t} \vec{X}_{j}-{ }^{t} \bar{X}_{n}\right)$.

Assume that $n \geq 2 m+1$. Then, $\bar{\Sigma}_{n}$ has the inverse $\bar{\Sigma}_{n}^{-1}$ by probability one. The Hotelling's $T$-squared statistic is defined by $T^{2}=n\left({ }^{t} \bar{X}_{n}\right) \bar{\Sigma}_{n}^{-1} \bar{X}_{n}$. Let $\mu=2 m, \nu=n-2 m, F_{\mathrm{HH}}=(n-1)^{-1}(\nu / \mu) T^{2}$ and $\lambda=n\left({ }^{t} \vec{\mu}_{\vec{\theta}, \eta}\right) \Sigma_{\eta, N}^{-1} \vec{\mu}_{\vec{\theta}, \eta}$. Then, $F_{\text {HH }}$ obeys $F_{\mu, \nu ; \lambda}$, the non-central $F$ distribution with $\mu$ and $\nu$ degrees
of freedom and with non-centrality $\lambda$. The probability density function of $F_{\mu, \nu ; \lambda}$ is

$$
\begin{equation*}
p_{\lambda}(f)=\sum_{k=0}^{\infty} \frac{e^{-\lambda / 2}(\lambda / 2)^{k} / k!}{B(k+\mu / 2, \nu / 2)}\left(\frac{\mu f}{\mu f+\nu}\right)^{k+\mu / 2}\left(\frac{\nu}{\mu f+\nu}\right)^{\nu / 2} \frac{1}{f}, \tag{10}
\end{equation*}
$$

where $B(x, y)$ is the beta function. (See [6].) If $\vec{\theta}=\overrightarrow{0}_{m}$, then $\lambda=0$ and thus $F_{\mathrm{HH}}$ obeys $F_{\mu, \nu}=F_{\mu, \nu ; 0}$ the central $F$ distribution. Define the critical point $c$ as a solution to the equation $\int_{c}^{\infty} p_{0}(f) d f=\alpha$. The HH test $T_{\alpha}^{\mathrm{HH}}$ is a test by which $H_{0}$ is accepted if $F_{\mathrm{HH}} \leq c$ is observed.

For $\vec{z}={ }^{t}\left(z_{1}, z_{2}, \ldots, z_{m}\right) \in$ Mat $_{\mathbb{C}}^{m, 1}$, define $|\vec{z}\rangle \in \mathcal{H}^{\otimes m}$ by $|\vec{z}\rangle=\left|z_{1}\right\rangle \otimes$ $\left|z_{2}\right\rangle \otimes \cdots \otimes\left|z_{m}\right\rangle$. For $Z=\left(\vec{z}_{1}, \vec{z}_{2}, \ldots, \vec{z}_{n}\right) \in \operatorname{Mat}_{\mathbb{C}}^{m, n}$, define $|Z\rangle \in \mathcal{H}^{\otimes m n}$ by $|Z\rangle=\left|\vec{z}_{1}\right\rangle \otimes\left|\vec{z}_{2}\right\rangle \otimes \cdots \otimes\left|\vec{z}_{n}\right\rangle$. Let $\langle Z|$ be $|Z\rangle^{*}$. The POVM $\left\{\hat{\Pi}_{0}, \hat{\Pi}_{1}\right\}$ for $T_{\alpha}^{\mathrm{HH}}$ is given by

$$
\hat{\Pi}_{0}=\frac{1}{\pi^{m n}} \overbrace{\int \cdots \int_{F_{\mathrm{HH}} \leq c}|Z\rangle\langle Z| \prod_{i=1}^{m} \prod_{j=1}^{n} d x_{i, j} d y_{i, j}, \quad, \quad \text {, }{ }^{2 m n}}
$$

where $x_{i, j}$ and $y_{i, j}$ are $(i, j)$-th entries of $\operatorname{Re}(Z)$ and $\operatorname{Im}(Z)$, respectively.

## 4 Theorems and a numerical comparison

Let $m$ be the mode size, $n$ be the sample size, $\vec{\theta}$ be the displacement parameter, $\eta$ be the squeezing parameter, $N$ be the mixture parameter, and $\alpha$ be the level. The first theorem implies that $\hat{v}_{j, k} \in \mathcal{L}\left(\mathcal{H}^{\otimes m n}\right), \hat{R}=\hat{R}_{n-1} \hat{R}_{n-2} \cdots \hat{R}_{1} \in$ $\mathcal{U}\left(\mathcal{H}^{\otimes m n}\right), \hat{T}_{\mathrm{SI}} \in \mathcal{L}\left(\mathcal{H}^{\otimes m n}\right), \mathcal{K}_{t} \subset \mathcal{H}^{\otimes m n}, \hat{K}_{t} \in \mathcal{L}\left(\mathcal{H}^{\otimes m n}\right)$ and $T_{\alpha}^{\mathrm{SI}}$ are all SI.

Theorem 1. For any $\eta \in \mathrm{Sqz}^{m}$, and for any $j, k \in\{1,2, \ldots, n\}$, it holds that $\left(\hat{S}_{\eta}^{\otimes n}\right)^{*} \hat{v}_{j, k} \hat{S}_{\eta}^{\otimes n}=\hat{v}_{j, k}$.

Proof. See Sec. 5.2.
A vector $f \in \mathcal{H}^{\otimes m n}$ is regarded as a function $f: \operatorname{Mat}_{\mathbb{R}}^{m, n} \rightarrow \mathbb{C}$, where the $(i, j)$-th entry $x_{i, j}$ of the matrix variable $X \in \operatorname{Mat}_{\mathbb{R}}^{m, n}$ is specified by $\hat{a}_{i, j} f=\left(x_{i, j} f+\partial f / \partial x_{i, j}\right) / \sqrt{2}$. If $f(X)=f\left(X e^{A}\right)$ holds for any $A \in \mathrm{Ant}_{\mathbb{R}}^{n}$, then $f(X)$ is said to be Mode-wisely Rotationally Invariant (MwRI). If $m=1$ and if $n \geq 2$, then an MwRI function is a radial function of $n$ variables.

Theorem 2. The Hilbert subspace $\mathcal{K}_{0}$ is the set of square-integrable MwRI functions.

Proof. See Sec. 5.4.
Consider the case of $n=2$. Then, $\hat{T}_{\mathrm{SI}}=\hat{v}_{1,2} \hat{v}_{1,2}^{*}$ holds because $\hat{R}^{*} \hat{v}_{1,2} \hat{R}=$ $\hat{v}_{1,2}$ holds. Let $X$ be a random variable given by observing $\hat{T}_{\text {SI }}$. Let $\hat{T}=$ $-i \hat{v}_{1,2}$. where $i=\sqrt{-1}$. It holds that $\hat{T}^{*}=\hat{T}$ and that $\hat{T}_{\mathrm{SI}}=\hat{T}^{2}$. Let $Y$ be a random variable given by observing $\hat{T}$. For any state, the probability distribution of $X$ is equal to that of $Y^{2}$.

For a random variable $Z$, the probability distribution can be identified by the characteristic function $\varphi_{Z}(r)=E\left[e^{i r Z}\right]$, where $E[W]$ is the expected value of a random variable $W$. Let $N B_{m}(p)$ be the negative binomial distribution whose probability function is $f(x)=\binom{m+x-1}{x}(1-p)^{m} p^{x}$. If $Z$ obeys $N B_{m}(p)$, then it holds that $\varphi_{Z}(r)=(1-p)^{m}\left(1-p e^{i r}\right)^{-m}$. Let Poi $(\lambda)$ be the Poisson distribution whose probability function is $f(x)=e^{-\lambda} \lambda^{x} /(x!)$. If $W$ obeys $\operatorname{Poi}(\lambda)$, then it holds that $\varphi_{W}(r)=e^{\lambda\left(e^{i r}-1\right)}$. Define $\gamma(r)$ and $\psi_{s}(r)$ by

$$
\begin{equation*}
\gamma(r)=\frac{1}{N+1-N e^{i r}} \text { and } \psi_{s}(r)=\exp \left[\gamma(r)\left(e^{i r}-1\right) s^{2}\right] \tag{11}
\end{equation*}
$$

Theorem 3. (i) If $n=2$, then it holds that

$$
\varphi_{Y}(r)=[\gamma(r) \gamma(-r)]^{m} \psi_{\|\vec{\theta}\|}(r) \psi_{\|\vec{\theta}\|}(-r) .
$$

(ii) Assume that $F, G, P_{k}$ and $Q_{k}(k \in \mathbb{N})$ are mutually independent random variables, where $F$ and $G$ obey $N B_{m}(N /(N+1))$, and where $P_{k}$ and $Q_{k}$ obey Poi $\left(\frac{\|\theta\|^{2} N^{k-1}}{(N+1)^{k+1}}\right)$. If $n=2$, then the probability distribution of $Y$ is that of $F-G+\sum_{k=1}^{\infty}\left(k P_{k}-k Q_{k}\right)$.

Proof. See Sec. 5.7.
The following theorem shows that $T_{\alpha}^{\mathrm{SI}}$ dominates $T_{\alpha}^{\text {triv }}$ if $N=0$.
Theorem 4. If $N=0$, then, for any $m \geq 1$ and for any $n \geq 2$, the type II error probability of $T_{\alpha}^{\mathrm{SI}}$ is

$$
\beta_{\hat{\rho_{\vec{\theta}}, n, 0}}\left[T_{\alpha}^{\mathrm{SI}}\right]=(1-\alpha) \frac{e^{-n\|\vec{\theta}\|^{2}}}{B\left(\frac{n-1}{2}, \frac{1}{2}\right)} \int_{0}^{\pi} e^{n\|\vec{\theta}\|^{2} \cos \varphi}(\sin \varphi)^{n-2} d \varphi,
$$

where $B(x, y)$ is the beta function.
Proof. See Sec. 5.8.

For a test to be SI, it is necessary that the type II error probability does not depend on $\eta \in \mathrm{Sqz}^{m}$. In the following theorem, (i) implies that $T_{\alpha}^{\mathrm{HH}}$ is not SI. Moreover, (ii),implies that $T_{\alpha}^{\mathrm{HH}}$ is no better than $T_{\alpha}^{\text {triv }}$ in the minimax criterion.

Theorem 5. (i) If $\vec{\theta} \neq \overrightarrow{0}_{m}$, then $\beta_{\hat{\rho}_{\hat{\theta}, n, N} n}\left[T_{\alpha}^{\mathrm{HH}}\right]$ depends on $\eta \in \mathrm{Sqz}^{m}$.
(ii) It holds that $\sup _{\eta \in \mathrm{Sqz}^{m}} \beta_{\hat{\rho}_{\theta, \eta, N} \mathrm{Q}_{n}}\left[T_{\alpha}^{\mathrm{HH}}\right]=1-\alpha$.

Proof. See Sec. 5.9.
For the case of $m=1, n=3$ and $N=0$, the type II error probabilities of $T_{\alpha}^{\mathrm{SI}}$ and $T_{\alpha}^{\mathrm{HH}}$ are plotted in Figure. The figure says that $\beta_{\hat{\rho}_{\theta, n, 0}^{\otimes 3}}\left[T_{\alpha}^{\mathrm{SI}}\right]<$ $\beta_{\beta_{\theta, \eta, 0}^{\otimes 3}}\left[T_{\alpha}^{\mathrm{HH}}\right]$ if $\theta \fallingdotseq 0$, and that $\beta_{\hat{\rho}_{\theta, \eta, 0}^{\otimes 3}}\left[T_{\alpha}^{\mathrm{SI}}\right]>\beta_{\hat{\rho}_{\theta, \eta, 0} 33}\left[T_{\alpha}^{\mathrm{HH}}\right]$ if $\theta \gg 0$. If $\eta=O_{2}$ We can evaluate $\beta_{\hat{\rho}_{\theta, O_{2}, 0}^{\otimes 3}}\left[T_{\alpha}^{\mathrm{SI}}\right]$ with $\beta_{\hat{\rho}_{\theta, O_{2}, 0}^{\otimes 3}}\left[T_{\alpha}^{\mathrm{HH}}\right]$ as follows.

Theorem 6. Consider the case of $m=1, n=3, \eta=O_{2}, N=0$ and $0<\alpha<1$.
(i) There exists $s>0$ such that, if $0<|\theta|<s$, then $\beta_{\hat{\rho}_{\theta, 0}^{\otimes 33}}\left[T_{\alpha}^{S I}\right]<\beta_{\hat{\rho}_{\theta, 0} 3}^{S 3}\left[T_{\alpha}^{\mathrm{HH}}\right]$ holds.
(ii) There exists $t>0$ such that, if $\theta>t$, then $\beta_{\hat{\rho}_{\theta, 0}^{\otimes 33}}\left[T_{\alpha}^{\mathrm{SI}}\right]>\beta_{\hat{\rho}_{\theta, 0}^{\otimes 33}}\left[T{ }_{\alpha}^{\mathrm{HH}}\right]$ holds.

Proof. See Sec. 5.10.

## 5 Proofs of the theorems

### 5.1 Matrix notations of operators

Let $m$ be the mode size, and let $n$ be the sample size. For any $\mu, \nu \in \mathbb{N}$, let Mat ${ }_{m, n}^{\mu, \nu}$ be the set of $\mu$-by- $\nu$ matrices whose entries belong to $\mathcal{L}\left(\mathcal{H}^{\otimes m n}\right)$. Identifying 1 with $\hat{I}^{\otimes m n}$, we regard that Mat $t_{\mathbb{C}}^{\mu, \nu}$ is a vector subspace of Mat ${ }_{m, n}^{\mu, \nu}$. Let Mat ${ }_{m, n}^{\mu}$ be Mat $_{m, n}^{\mu, \mu}$. We will use $L \in \mathcal{L}\left(\mathcal{H}^{\otimes m n}\right)$ which can be written by a linear combination of entries of $X \in \mathrm{Mat}_{m, n}^{\mu, \nu}$.

Define a linear map $\operatorname{tr}_{\mu}:$ Mat $_{m, n}^{\mu} \rightarrow \mathcal{L}\left(\mathcal{H}^{\otimes m n}\right)$ by $\operatorname{tr}_{\mu}[X]=\sum_{i=1}^{\mu} X_{i, i}$, where $X_{i, j}$ is the $(i, j)$-th entry of $X$. For $X \in \operatorname{Mat}_{m, n}^{\mu, \nu}$ and for $L \in \mathcal{L}\left(\mathcal{H}^{\otimes m n}\right)$, define $X L, L X,[X, L] \in \operatorname{Mat}_{m, n}^{\mu, \nu}$ by $(X L)_{i, j}=X_{i, j} L,(L X)_{i, j}=L X_{i, j}$ and $[X, L]=X L-L X$, respectively. If $X \in \operatorname{Mat}_{\mathbb{C}}^{\mu, \nu}$ and $L \in \mathcal{L}\left(\mathcal{H}^{\otimes m n}\right)$, then it holds that

$$
\begin{equation*}
[X, L]=O_{\mu, \nu} \tag{12}
\end{equation*}
$$

where $O_{\mu, \nu} \in \operatorname{Mat}_{\mathbb{C}}^{\mu, \nu}$ is the zero matrix. For $X \in \operatorname{Mat}_{m, n}^{\lambda, \mu}$ and for $Y \in \operatorname{Mat}_{m, n}^{\mu, \nu}$, define the product $X Y \in \operatorname{Mat}_{m, n}^{\lambda, \nu}$ by $(X Y)_{i, j}=\sum_{k=1}^{\mu} X_{i, k} Y_{k, j}$. For $X \in$ Mat ${ }_{m, n}^{\mu, \nu}$, define $X^{*} \in \operatorname{Mat}_{m, n}^{\nu, \mu}$ by $\left(X^{*}\right)_{i, j}=\left(X_{j, i}\right)^{*}$, and define ${ }^{t} X \in$ Mat $_{m, n}^{\nu, \mu}$ by $\left({ }^{t} X\right)_{i, j}=X_{j, i}$. The operations $X \mapsto X^{*}$ and $X \mapsto{ }^{t} X$ are commutative as $\left({ }^{t} X\right)^{*}={ }^{t}\left(X^{*}\right)$, and it holds that $\left({ }^{t} X^{*}\right)_{i, j}=X_{i, j}^{*}$. For $X \in$ Mat $_{m, n}^{\lambda, \mu}$, for $Y \in \operatorname{Mat}_{m, n}^{\mu, \nu}$ and for $C \in \operatorname{Mat}_{\mathbb{C}}^{\mu, \nu}$, it holds that $(X Y)^{*}=Y^{*} X^{*}$ and that ${ }^{t}(X C)=\left({ }^{t} C\right)\left({ }^{t} X\right)$. Moreover, for $X \in$ Mat $_{m, n}^{\mu}$ and for $C \in$ Mat $_{\mathbb{C}}^{\mu}$, it holds that

For $j \in\{1,2, \ldots, n\}$, define $\vec{a}_{j} \in \operatorname{Mat}_{m, n}^{m, 1}$ and $\vec{a}_{j} \in \operatorname{Mat}_{m, n}^{2 m, 1}$ by

\vec{a}_{j}=\left(\begin{array}{c}
\hat{a}_{1, j} \\
\vdots \\
\hat{a}_{m, j}
\end{array}\right) \text { and } \vec{a}_{j}=\binom{\vec{a}_{j}}{t \vec{a}_{j}^{*}}
$$

respectively. Define $\tilde{a}_{m, n} \in \operatorname{Mat}_{m, n}^{m, n}$ by $\tilde{a}_{m, n}=\left(\vec{a}_{1}, \vec{a}_{2}, \ldots, \vec{a}_{n}\right)$. Define ${\underset{\sim}{a}}_{m, n} \in$ Mat ${ }_{m, n}^{2 m, n}$ by ${\underset{\sim}{m, n}}^{a_{m}}=\left(\vec{a}_{1}, \vec{a}_{2}, \ldots, \vec{a}_{n}\right)$. For $\mu \in \mathbb{N}$, let $I_{\mu} \in \operatorname{Mat}_{\mathbb{R}}^{\mu}$ be the identity matrix, let $O_{\mu} \in \operatorname{Mat}_{\mathbb{R}}^{\mu}$ be the zero matrix, and let

K_{\mu}=\left(\begin{array}{cc}
I_{\mu} & O_{\mu} \\
O_{\mu} & -I_{\mu}
\end{array}\right) \in \operatorname{Mat}_{\mathbb{R}}^{2 m} .

If $n=1$, then, it holds that $\hat{s}_{\eta}=2^{-1} \vec{a}_{1}^{*} K_{m} \eta \vec{a}_{1}-{\underset{\sim}{c}}_{\eta} \hat{I}^{\otimes m}$, where $c_{\eta}=$ $4^{-1} \operatorname{tr}_{2 m}\left[K_{m} \eta\right] \in \sqrt{-1} \mathbb{R}$. For any $m, n \in \tilde{\mathbb{N}}$, and for any $\eta \in \mathrm{Sqz}^{m}$, define $\hat{u}_{\eta} \in \mathcal{L}\left(\mathcal{H}^{\otimes m n}\right)$ by

Then, it holds that $\exp \left(\hat{u}_{\eta}\right)=\hat{S}_{\eta}^{\otimes n}$. For any $A \in \operatorname{Ant}_{\mathbb{C}}^{m}$, define $\hat{u}_{A} \in \mathcal{L}\left(\mathcal{H}^{\otimes m n}\right)$ by

$$

For $\eta \in \mathrm{Sqz}^{m}$, if the anti-hermitian part is $A$, and if the symmetric part is $O_{m}$, then it holds that $\hat{u}_{A}={\underset{\sim}{u}}_{\eta}$.

For $A \in \operatorname{Ant}_{\mathbb{C}}^{n}$, define $\hat{v}_{A} \in \mathcal{L}\left(\mathcal{H}^{\otimes m n}\right)$ by

\hat{v}_{A}=\operatorname{tr}_{m}\left[t \tilde{a}_{m, n}^{*} A\left({ }^{t} \tilde{a}_{m, n}\right)\right] .

For $j, k \in\{1,2, \ldots, n\}$ with $j<k$, define $J_{j, k} \in \operatorname{Ant}_{\mathbb{R}}^{n}$ by

& 0 & & -1 & \\
& & O_{k-j-1} & & \\
& 1 & & 0 & \\
& & & & O_{n-k}
\end{array}\right)

If $j=k$, let $J_{j, k}=O_{n}$. If $j>k$, let $J_{j, k}=-J_{k, j}$. It holds that $\hat{v}_{J_{j, k}}=\hat{v}_{j, k}$.
By Eq. (5), for any $A \in$ Ant $_{\mathbb{C}}^{m}$ and for any $B \in$ Ant $_{\mathbb{C}}^{n}$, it holds that

Lemma 1. If $n=1$, then, for any $m \in \mathbb{N}$, and for any $\eta \in \mathrm{Sqz}^{m}$, it holds that $\left[\vec{a}, \hat{s}_{\eta}\right]=\eta \vec{a}$.

Proof. Let $A \in \operatorname{Ant}_{\mathbb{C}}^{m}$ be the anti-hermitian part of $\eta$, and let $S \in \operatorname{Sym}_{\mathbb{C}}^{m}$ be the symmetric part of $\eta$. For $i \in\{1,2, \ldots, m\}$, let

Then, for any $i \leq m$, it holds that

\left[\hat{a}_{i}, \hat{s}_{\eta}\right]=\left[\hat{a}_{i}, \hat{F}_{i}\right]=\left(\sum_{j=1}^{m} A_{i, j} \hat{a}_{j}\right)+S_{i, i} \hat{a}_{i}^{*}+\left(\sum_{j \neq i} S_{i, j} \hat{a}_{j}^{*}\right)=\eta_{i} \vec{a}, \tag{16}
\end{equation*}
$$

where $\eta_{i} \in \operatorname{Mat}_{\mathbb{C}}^{1,2 m}$ is the $i$-th row vector of $\eta$. Similarly, let

\hat{G}_{i}=\left(\sum_{j=1}^{m} A_{j, i} \hat{a}_{j}^{*} \hat{a}_{i}\right)-\frac{\bar{S}_{i, i}}{2} \hat{a}_{i}^{2}-\left(\sum_{j \neq i} \bar{S}_{i, j} \hat{a}_{i} \hat{a}_{j}\right) \in \mathcal{L}\left(\mathcal{H}^{\otimes m}\right) .

This definition is equivalent to

For any $i \leq m$, it holds that

\left[\hat{a}_{i}^{*}, \hat{s}_{\eta}\right]=\left[\hat{a}_{i}^{*}, \hat{G}_{i}\right]=\bar{S}_{i, i} \hat{a}_{i}+\left(\sum_{j \neq i} \bar{S}_{i, j} \hat{a}_{j}\right)+\left(\sum_{j=1}^{m} \bar{A}_{i, j} \hat{a}_{j}^{*}\right)=\eta_{i+m} \vec{a} . \tag{17}
\end{equation*}
$$

By Eqs. (16) and (17), we obtain $\left[\vec{\sim}, \hat{s}_{\eta}\right]=\eta \vec{a}$.
Then, for any $n \geq 1$, we obtain a representation of ${\underset{\sim}{\hat{~}}}_{\eta}$ on $\underset{\sim}{a_{m, n}}$.
Lemma 2. For any $m, n \in \mathbb{N}$, and for any $\eta \in \operatorname{Sqz}^{m}$, it holds that $\left[{\underset{\sim}{m, n}}, \hat{\sim}_{\eta}\right]=$ $\eta{\underset{\sim}{a}}_{m, n}$.
Proof. For any $i \in\{1,2, \ldots, m\}$, and for any $j, k \in\{1,2, \ldots, n\}$ with $j \neq k$, it holds that $\left[\hat{a}_{i, j}, \vec{a}_{k}\right]=\left[\hat{a}_{i, j}^{*}, \vec{a}_{k}\right]=O_{2 m, 1}$. Hence, by Lemma 1, we obtain $\left[a_{m, n}, \hat{u}_{n}\right]=\eta a_{m, n}$.
Lemma 3. For any $A \in \operatorname{Ant}_{\mathbb{C}}^{m}$, it holds that $\left[\tilde{a}_{m, n}, \hat{u}_{A}\right]=A \tilde{a}_{m, n}$ and that $\left[{ }^{t} \tilde{a}_{m, n}^{*}, \hat{u}_{A}\right]=\bar{A}\left({ }^{( } \tilde{a}_{m, n}^{*}\right)$.
Proof. Applying Lemma 2 to the case where the symmetric part of $\eta$ is $O_{m}$, we obtain the statement.

Lemma 4. For any $A \in$ Ant $_{\mathbb{C}}^{n}$, it holds that $\left[\tilde{a}_{m, n}, \hat{v}_{A}\right]=-\tilde{a}_{m, n} \bar{A}$ and that $\left[\tilde{a}_{m, n}^{*}, \hat{v}_{A}\right]=-{ }^{t} \tilde{a}_{m, n}^{*} A$.
Proof. By Lemma 3, it holds that $\left[{ }^{t} \tilde{a}_{m, n}, \hat{v}_{A}\right]=A\left({ }^{t} \tilde{a}_{m, n}\right)$ and that $\left[\tilde{a}_{m, n}^{*}, \hat{v}_{A}\right]=$ $\bar{A} \tilde{a}_{m, n}^{*}$. By transposing, we obtain the statement.
Lemma 5. For any $m, n \in \mathbb{N}$, and for any $B \in \operatorname{Ant}_{\mathbb{R}}^{n}$, it holds that $\left[{ }_{a}{ }_{m, n}, \hat{v}_{B}\right]=$ $-a_{m, n} B$.

= & \operatorname{tr}_{n}\left(a_{m, n}^{*} K_{m} \eta\left[{\underset{\sim}{a}}_{m, n}, \hat{v}_{B}\right]\right)+\operatorname{tr}_{n}\left(\left[a_{m, n}^{*}, \hat{v}_{B}\right] K_{m} \eta a_{m, n}\right) .
\end{aligned}
$$

By Lemma 5, we have

By Eq. (13), the right-hand side is zero.
Proof of Theorem 1. Using $J_{j, k} \in \operatorname{Ant}_{\mathbb{R}}^{n}$ of (14), it holds that $\hat{v}_{j, k}=\hat{v}_{J_{j, k}}$. Hence, by Lemma 6, it holds that $\left[\hat{u}_{\eta}, \hat{v}_{j, k}\right]=0$. As $\hat{S}_{\eta}^{\otimes n}=\exp \left(\hat{u}_{\eta}\right)$, we obtain $\left(\hat{S}_{\eta}^{\otimes n}\right)^{*} \hat{v}_{j, k} \hat{S}_{\eta}^{\otimes n}=\hat{v}_{j, k}$.

& -\hat{v}_{B} \operatorname{tr}_{m}\left(\tilde{a}_{m, n}^{*} A^{t} \tilde{a}_{m, n}\right) \\
= & \left.\operatorname{tr}_{m}\left({ }^{t} \tilde{a}_{m, n}^{*} A{ }^{t} \tilde{a}_{m, n}, \hat{v}_{B}\right]\right)+\operatorname{tr}_{m}\left(\left[\tilde{a}_{m, n}^{*}, \hat{v}_{B}\right] A^{t} \tilde{a}_{m, n}\right) .
\end{aligned}
$$

Moreover, by Lemma 4, we have

\left[\hat{v}_{A}, \hat{v}_{B}\right]=\operatorname{tr}_{m}\left({ }^{t} \tilde{a}_{m, n}^{*} A B^{t} \tilde{a}_{m, n}\right)-\operatorname{tr}_{m}\left({ }^{t} \tilde{a}_{m, n}^{*} B A^{t} \tilde{a}_{m, n}\right)
$$

Hence, we have $\left[\hat{v}_{A}, \hat{v}_{B}\right]=\hat{v}_{[A, B]}$.
We will use the following lemma in Sec. 5.5.
Lemma 8. For any $A \in \operatorname{Ant}_{\mathbb{C}}^{m}$ and for any $B \in \operatorname{Ant}_{\mathbb{C}}^{n}$, it holds that $\left[\hat{u}_{A}, \hat{v}_{B}\right]=$ 0.

Proof. By Eq. (12), it holds that $\left[A, \hat{v}_{B}\right]=O_{m}$. Hence, we have

{\left[\hat{u}_{A}, \hat{v}_{B}\right]=} & \operatorname{tr}_{n}\left(\tilde{a}_{m, n}^{*} A \tilde{a}_{m, n}\right) \hat{v}_{B}-\operatorname{tr}_{n}\left(\tilde{a}_{m, n}^{*}\left[A, \hat{v}_{B}\right] \tilde{a}_{m, n}\right) \\
& -\hat{v}_{B} \operatorname{tr}_{n}\left(\tilde{a}_{m, n}^{*} A \tilde{a}_{m, n}\right) \\
= & \operatorname{tr}_{n}\left(\tilde{a}_{m, n}^{*} A\left[\tilde{a}_{m, n}, \hat{v}_{B}\right]\right)+\operatorname{tr}_{n}\left(\left[\tilde{a}_{m, n}^{*}, \hat{v}_{B}\right] A \tilde{a}_{m, n}\right) .
\end{aligned}
$$

By Lemma 4, we have

$$

By Eq. (13), the right-hand side is zero.

### 5.4 Proof of Theorem 2 (MwRI functions)

We consider how $\hat{v}_{j, k} \in \mathcal{L}\left(\mathcal{H}^{\otimes m n}\right)$ is represented by $f(X) \in \mathcal{H}^{\otimes m n}$ where $X \in \operatorname{Mat}_{\mathbb{R}}^{m, n}$.

Lemma 9. For any $r \in \mathbb{R}$, it holds that $e^{r \hat{v}_{j, k}} f(X)=f\left(X e^{r J_{j, k}}\right)$.

Proof. Let $x_{i, j}$ be the $(i, j)$-th entry of $X$. It holds that $\hat{v}_{j, k}=\sum_{i=1}^{m}\left(\hat{a}_{i, k}^{*} \hat{a}_{i, j}-\right.$ $\left.\hat{a}_{i, j}^{*} \hat{a}_{i, k}\right)=\sum_{i=1}^{m}\left(x_{i, k} \partial / \partial x_{i, j}-x_{i, j} \partial / \partial x_{i, k}\right)$. Let $\left(s_{i, j, k}, \varphi_{i, j, k}\right)$ be a polar coordinate of $\left(x_{i, j}, x_{i, k}\right)$ defined by $x_{i, j}=s_{i, j, k} \cos \varphi_{i, j, k}$ and $x_{i, k}=s_{i, j, k} \sin \varphi_{i, j, k}$. Then, it holds that

$$
-\frac{\partial}{\partial \varphi_{i, j, k}}=-\frac{\partial x_{i, j}}{\partial \varphi_{i, j, k}} \frac{\partial}{\partial x_{i, j}}-\frac{\partial x_{i, k}}{\partial \varphi_{i, j, k}} \frac{\partial}{\partial x_{i, k}}=x_{i, k} \frac{\partial}{\partial x_{i, j}}-x_{i, j} \frac{\partial}{\partial x_{i, k}},
$$

and so that $\hat{v}_{j, k}=-\sum_{i=1}^{m} \partial / \partial \varphi_{i, j, k}$. As $e^{-t \partial / \partial \varphi}=\sum_{k=0}^{\infty}(-t \partial / \partial \varphi)^{k} / k$ ! holds, it holds that $e^{-t \partial / \partial \varphi} \varphi^{n}=\sum_{k=0}^{n}\binom{n}{k} \varphi^{n-k}(-t)^{k}=(\varphi-t)^{n}$. Hence, we obtain $\exp \left(r \hat{v}_{j, k}\right) f(X)=f\left({ }^{t}\left[\exp \left(-r J_{j, k}\right)\left({ }^{t} X\right)\right]\right)=f\left(X \exp \left(r J_{j, k}\right)\right)$.

For $\hat{L} \in \mathcal{L}\left(\mathcal{H}^{\otimes m n}\right)$, let $\operatorname{Null}(\hat{L}) \subset \mathcal{H}^{\otimes m n}$ be the nullspace $\left\{f \in \mathcal{H}^{\otimes m n}\right.$ $\hat{L} f=0\}$. The following lemma shows that $\bigcap_{k=1}^{n-1} \operatorname{Null}\left(\hat{v}_{k, n}\right)$ is the set of square-integrable MwRI functions.

Lemma 10. It holds that $\bigcap_{k=1}^{n-1} \operatorname{Null}\left(\hat{v}_{k, n}\right)=\bigcap_{A \in \operatorname{Ant} \mathbb{R}^{n}} \operatorname{Null}\left(\hat{v}_{A}\right)$.
Proof. By Lemma 7, it holds that $\left[\hat{v}_{i, j}, \hat{v}_{j, k}\right]=\hat{v}_{k, i}$ for any $i, j, k \in\{1,2, \ldots, n\}$. Hence, it holds that

\operatorname{Null}\left(\hat{v}_{i, j}\right) \cap \operatorname{Null}\left(\hat{v}_{j, k}\right)=\operatorname{Null}\left(\hat{v}_{i, j}\right) \cap \operatorname{Null}\left(\hat{v}_{j, k}\right) \cap \operatorname{Null}\left(\hat{v}_{k, i}\right) .
$$

Hence, we have $\bigcap_{k=1}^{n-1} \operatorname{Null}\left(\hat{v}_{k, n}\right)=\bigcap_{i=1}^{n} \bigcap_{j=1}^{n} \operatorname{Null}\left(\hat{v}_{i, j}\right)$. Since $J_{j, k} \in \operatorname{Ant}_{\mathbb{R}}^{n}$ holds, $\bigcap_{i=1}^{n} \bigcap_{j=1}^{n} \operatorname{Null}\left(\hat{v}_{i, j}\right) \supset \bigcap_{A \in \operatorname{Ant}_{R}^{n}} \operatorname{Null}\left(\hat{v}_{A}\right)$ holds. Since any $\hat{v}_{A}$ is a linear combination of $\hat{v}_{j, k}$, we have $\bigcap_{i=1}^{n} \bigcap_{j=1}^{n} \operatorname{Null}\left(\hat{v}_{i, j}\right) \subset \bigcap_{A \in \operatorname{Ant}_{R}^{n}} \operatorname{Null}\left(\hat{v}_{A}\right)$. Hence, we obtain the statement.

Proof of Theorem 2. Let $\hat{T}=\sum_{k=1}^{n-1} \hat{v}_{k, n} \hat{v}_{k, n}^{*}$. Then, it holds that $\operatorname{Null}(\hat{T})=$ $\bigcap_{k=1}^{n-1} \operatorname{Null}\left(\hat{v}_{k, n} \hat{v}_{k, n}^{*}\right)$. Since $\operatorname{Null}\left(\hat{v}_{k, n} \hat{v}_{k, n}^{*}\right)=\operatorname{Null}\left(\hat{v}_{k, n}^{*} \hat{v}_{k, n}\right)=\operatorname{Null}\left(\hat{v}_{k, n}\right)$ holds, we have $\bigcap_{k=1}^{n-1} \operatorname{Null}\left(\hat{v}_{k, n} \hat{v}_{k, n}^{*}\right)=\bigcap_{k=1}^{n-1} \operatorname{Null}\left(\hat{v}_{k, n}\right)$. By Lemma $10, \operatorname{Null}(\hat{T})$ is the set of square-integrable MwRI functions. Since $\hat{T}_{\mathrm{SI}}=\hat{R}^{*} \hat{T} \hat{R}$ holds, we have $\mathcal{K}_{0}=\operatorname{Null}\left(\hat{T}_{\mathrm{SI}}\right)=\hat{R}^{*} \operatorname{Null}(\hat{T})$. By $\hat{R}=\hat{R}_{n-1} \hat{R}_{n-2} \cdots \hat{R}_{1}$, and $R_{k}=\exp \left(\arctan (\sqrt{k}) \hat{v}_{k, k+1}\right)$, we have $\hat{R}^{*} \operatorname{Null}(\hat{T})=\operatorname{Null}(\hat{T})$.

### 5.5 Actions of $\hat{u}_{A}$ and $\hat{v}_{B}$ on $\vec{\theta}$

For $\theta \in \mathbb{C}$, the displacement operator $\hat{D}_{\theta} \in \mathcal{U}(\mathcal{H})$ is defined by $\hat{D}_{\theta}=\exp \left(\hat{d}_{\theta}\right)$, where $\hat{d}_{\theta}=\theta \hat{a}^{*}-\bar{\theta} \hat{a}$. It holds that

because of $\left[\hat{a}, \hat{d}_{\theta}\right]=\theta \hat{I}$, and $\left[\hat{a}^{*}, \hat{d}_{\theta}\right]=\bar{\theta} \hat{I}$, respectively. Using Taylor expansion, for $r \in \mathbb{R}$, we have $\hat{D}_{r} f(x)=\exp (-i r \sqrt{2} \hat{p}) f(x)=f(x-\sqrt{2} r)$. For $\vec{z}={ }^{t}\left(z_{1}, z_{2}, \ldots, z_{m}\right) \in \operatorname{Mat}_{\mathbb{C}}^{m, 1}$, let $|\vec{z}\rangle=\left|z_{1}\right\rangle \otimes\left|z_{2}\right\rangle \otimes \cdots \otimes\left|z_{m}\right\rangle \in \mathcal{H}^{\otimes m}$. For $Z=\left(\vec{Z}_{1}, \vec{Z}_{2}, \ldots, \vec{Z}_{n}\right) \in \operatorname{Mat}_{\mathbb{C}}^{m, n}$, let $|Z\rangle=\left|\vec{Z}_{1}\right\rangle \otimes\left|\vec{Z}_{2}\right\rangle \otimes \cdots \otimes\left|\vec{Z}_{n}\right\rangle \in \mathcal{H}^{\otimes m n}$. For $W \in \operatorname{Mat}_{\mathbb{C}}^{m, n}$, let

and define a displacement operator $\hat{D}_{W} \in \mathcal{U}\left(\mathcal{H}^{\otimes m n}\right)$ by $\hat{D}_{W}=\exp \left(\hat{d}_{W}\right)$. By Eq. (19), it holds that $\hat{D}_{W}\left|O_{m, n}\right\rangle=|W\rangle$, where $O_{m, n} \in \operatorname{Mat}_{\mathbb{C}}^{m, n}$ is the zero matrix. For $A \in \operatorname{Ant}_{\mathbb{C}}^{m}$, let $\hat{U}_{A}=\exp \left(\hat{u}_{A}\right) \in \mathcal{U}\left(\mathcal{H}^{\otimes m n}\right)$. For $B \in \operatorname{Ant}_{\mathbb{C}}^{n}$, let $\hat{V}_{B}=\exp \left(\hat{v}_{B}\right) \in \mathcal{U}\left(\mathcal{H}^{\otimes m n}\right)$.

By Lemmas 3 and 4 , it holds that $\hat{U}_{A}^{*} \hat{V}_{B}^{*} \hat{d}_{W} \hat{V}_{B} \hat{U}_{A}=$ $\hat{d}_{e^{-A} W e^{\bar{B}}}$. By Eq (15), it holds that $\hat{U}_{A} \hat{V}_{B}\left|O_{m, n}\right\rangle=\left|O_{m, n}\right\rangle$. Hence,

is obtained.
For $Z=\left(\vec{Z}_{1}, \vec{Z}_{2}, \ldots, \vec{Z}_{n}\right) \in \operatorname{Mat}_{\mathbb{C}}^{m, n}$, and for $N \geq 0$, let $\hat{\rho}_{Z, N} \in \mathcal{S}\left(\mathcal{H}^{\otimes m n}\right)$ be $\hat{\rho}_{\vec{Z}_{1}, N} \otimes \hat{\rho}_{\vec{Z}_{2}, N} \otimes \cdots \otimes \hat{\rho}_{\vec{Z}_{n}, N}$.

where $\|W-Z\|^{2}=\operatorname{tr}_{m}\left[(W-Z)\left(W^{*}-Z^{*}\right)\right]$, and where $u_{i, j}$ and $v_{i, j}$ are the $(i, j)$-th entries of $\operatorname{Re}(W)$ and $\operatorname{Im}(W)$, respectively. Replace $\operatorname{Re}\left(e^{A} W e^{-\bar{B}}\right)$ by $R \in \operatorname{Mat}_{\mathbb{R}}^{m, n}$, and replace $\operatorname{Im}\left(e^{A} W e^{-\bar{B}}\right)$ by $S \in \operatorname{Mat}_{\mathbb{R}}^{m, n}$. Let $\vec{u}_{j}, \vec{v}_{j}, \vec{r}_{j}$ and $\vec{s}_{j} \in \operatorname{Mat}_{\mathbb{R}}^{m, 1}$ be $j$-th column vectors of $\operatorname{Re}(W), \operatorname{Im}(W), R$ and $S$, respectively. Define $\vec{u}, \vec{v}, \vec{r}$ and $\vec{s} \in \operatorname{Mat}_{\mathbb{R}}^{m n, 1}$ by

respectively. Let $r_{i, j}$ and $s_{i, j}$ be the $(i, j)$-th entries of $R$ and $S$, respectively. Then, it holds that $\vec{r}+\sqrt{-1} \vec{s}=C(\vec{u}+\sqrt{-1} \vec{v})$, where $C \in \operatorname{Mat}_{\mathbb{C}}^{m n}$ is a unitary matrix given by the Kronecker product of $e^{B}$ and $e^{A}$ as $C=e^{B} \otimes e^{A}$. Let $D=B \otimes I_{m}+I_{n} \otimes A \in$ Ant $_{\mathbb{C}}^{m n}$. Then, it holds that $C=e^{D}$. Define $\vec{w}, \vec{t} \in \mathrm{Mat}_{\mathbb{R}}^{2 m n, 1}$ and $E \in \mathrm{Ant}_{\mathbb{R}}^{2 m n}$ by

respectively. Then, it holds that $\vec{t}=e^{E} \vec{w}$ and that $\operatorname{det}\left[e^{E}\right]=\exp \left(\operatorname{tr}_{2 m n}[E]\right)=$ 1. Hence, the Jacobian of the replacement of $e^{E} \vec{w}$ by $\vec{t}$ is one. Hence, we have

$$

where $T=e^{A} W e^{-\bar{B}}$. Since

& \left\|e^{-A} T e^{\bar{B}}-Z\right\|^{2}=\operatorname{tr}_{m}\left[\left(e^{-A} T e^{\bar{B}}-Z\right)\left(e^{-A} T e^{\bar{B}}-Z\right)^{*}\right] \\
& =\operatorname{tr}_{m}\left[\left(T-e^{A} Z e^{-\bar{B}}\right)\left(T-e^{A} Z e^{-\bar{B}}\right)^{*}\right]=\left\|T-e^{A} Z e^{-\bar{B}}\right\|^{2}
\end{aligned}
$$

holds, we obtain $\sigma=\hat{\rho}_{e^{A} Z e^{-\bar{B}}, N}$.

By Lemma 12 , it holds that $\hat{R} \hat{\rho}_{\vec{\theta}, N}^{\otimes n} \hat{R}^{*}=\hat{\rho}_{\vec{\theta}\left[{ }^{t}\left(R \overrightarrow{1}_{n}\right)\right], N}$. The $k$-th and $k+1$-th row vectors of $R_{k} R_{k-1} \cdots R_{1}$ are recursively obtained by calculating the 2 -by- 2 submatrix as

Let $\hat{N} \in \mathcal{L}(\mathcal{H})$ be the number operator $\hat{a}^{*} \hat{a}$. It holds that $[\hat{a}, \hat{N}]=\hat{a}$, and so that $e^{-i r \hat{N}} \hat{a} e^{i r \hat{N}}=e^{i r} \hat{a}\left({ }^{\forall} r \in \mathbb{R}\right)$, where $i=\sqrt{-1}$. Let $\mathbb{N}_{0}$ be $\mathbb{N} \cup\{0\}$. For $n \in \mathbb{N}_{0}$, the $n$-th Fock vector, or the $n$-th number vector, $f_{n} \in \mathcal{H}$ is defined by $f_{n}=(1 / \sqrt{n!})\left(\hat{a}^{*}\right)^{n}|0\rangle$. It holds that $\hat{a} f_{n}=\sqrt{n} f_{n-1}, \hat{a}^{*} f_{n}=\sqrt{n+1} f_{n+1}$ and $\hat{N} f_{n}=n f_{n}$.

By Baker-Hausdorff formula, the displacement operator $\hat{D}_{\theta} \in \mathcal{U}(\mathcal{H})$ satisfies $\hat{D}_{\theta}=e^{-|\theta|^{2} / 2} e^{\theta \hat{a}^{*}} e^{-\bar{\theta} \hat{a}}$ for $\theta \in \mathbb{C}$. Hence we have

\langle\theta \mid \eta\rangle=e^{-|\theta|^{2} / 2-|\eta|^{2} / 2+\bar{\theta} \eta} . \tag{21}
\end{equation*}

Moreover, $\left\{f_{n}\right\}_{n=0}^{\infty}$ is a complete orthonormal basis of $\mathcal{H}$ because $f_{n}^{*} g=0$ $\left({ }^{\forall} n \in \mathbb{N}_{0}\right)$ is equivalent to $\int_{\mathbb{R}} e^{i \sqrt{2} s x} g(x) d x=0\left({ }^{\forall} s \in \mathbb{R}\right)$. Hence, it holds that $\hat{N}=\sum_{n=0}^{\infty} n f_{n} f_{n}^{*}$. Calculating the Gaussian mixture of $|\theta\rangle\langle\theta|$ using the form of (20), we have

\hat{\rho}_{0, N}=\frac{1}{N+1} \sum_{n=0}^{\infty} \frac{N^{n}}{(N+1)^{n}} f_{n} f_{n}^{*} . \tag{22}
\end{equation*}

This equation will be used in Lemma 17.
For $j, k \in\{1,2, \ldots, n\}$ with $j<k$, define $K_{j, k} \in$ Ant $_{\mathbb{C}}^{n}$ by

For $k>j$, let $K_{j, k}=-K_{k, j}$. Let $K_{j, j}=O_{n}$. The operator $\hat{d}_{j, k}$ defined in (7) is equal to $\hat{v}_{K_{j, k}}$. In Sec. 5.7, we will use the following lemma.

Lemma 14. ${ }^{1}$ For any $j, k \in\{1,2, . ., n\}$, let $\hat{U} \in \mathcal{U}\left(\mathcal{H}^{\otimes m n}\right)$ be $\exp \left((\pi / 4) \hat{v}_{J_{j, k}}\right)$, and let $\hat{V} \in \mathcal{U}\left(\mathcal{H}^{\otimes m n}\right)$ be $\exp \left((\pi / 4) \hat{v}_{K_{j, k}}\right)$. Then, it holds that $\hat{U}^{*} \hat{V}^{*} \hat{v}_{j, k} \hat{V} \hat{U}=$ $\hat{d}_{j, k}$.
Proof. Let $U=\exp \left[\frac{\pi}{4}\left(\begin{array}{cc}0 & -1 \\ 1 & 0\end{array}\right)\right]$, and let $V=\exp \left[\frac{\pi}{4}\left(\begin{array}{cc}i & 0 \\ 0 & -i\end{array}\right)\right]$. As $U=$ $\frac{1}{\sqrt{2}}\left(\begin{array}{cc}1 & -1 \\ 1 & 1\end{array}\right)$ and $V=\left(\begin{array}{cc}e^{i \pi / 4} & 0 \\ 0 & e^{-i \pi / 4}\end{array}\right)$, it holds that $U^{*} V^{*} J_{j, k} V U=K_{j, k}$. By Lemma 7 , we have $\hat{U}^{*} \hat{V}^{*} \hat{v}_{j, k} \hat{V} \hat{U}=\hat{d}_{j, k}$.

In quantum optical experiments, the unitary operators $\hat{U}$ and $\hat{V}$ of the above lemma can be realized by phase-shifting and beam-splitting, respectively. Moreover, $\hat{T}_{j, k}=-\sqrt{-1} \hat{d}_{j, k}$ is an observable whose POVM can be realized by arithmetic subtraction of data obtained by number measurements. Hence, if $n=2$, then $T_{\alpha}^{\text {SI }}$ can be realized by beam-splitters and photon counters.

### 5.7 Proof of Theorem 3 (Negative binomial and Poisson distributions)

Let $\hat{N} \in \mathcal{L}(\mathcal{H})$ be $\hat{a}^{*} \hat{a}$. Let $h_{\theta, N}(r)$ be $\operatorname{Tr}\left[\hat{\rho}_{\theta, N} e^{i r \hat{N}}\right]$, where $i=\sqrt{-1}$. We write $h_{\theta, N}(r)$ using $\gamma(r)$ and $\psi_{s}(r)$ of (11).
Lemma 15. For any $N \geq 0$, it holds that $h_{0, N}(r)=\gamma(r)$.
Proof. By Eq. (22), it holds that

h_{0, N}(r)=\frac{1}{N+1} \sum_{k=0}^{\infty}\left(\frac{e^{i r} N}{N+1}\right)^{k}=\frac{1}{N+1} \frac{1}{1-\frac{e^{i r} N}{N+1}}=\frac{1}{N+1-N e^{i r}} .

Hence, we have $h_{0, N}(r)=\gamma(r)$.

h_{\theta, 0}(r)=e^{-|\theta|^{2}} \sum_{k=0}^{\infty} \frac{e^{i k r}|\theta|^{2 k}}{k!}=\exp \left[|\theta|^{2}\left(e^{i r}-1\right)\right] .
$$

Since $\gamma(r)$ is one, $h_{\theta, 0}(r)$ is $\psi_{|\theta|}(r)$.
Lemma 17. For any $N \geq 0$, it holds that $h_{\theta, N}(r)=\gamma(r) \psi_{|\theta|}(r)$.
Proof. If $N=0$, then $\gamma(r)$ is one, and by Lemma 16, we have $h_{\theta, 0}(r)=$ $\gamma(r) \psi_{|\theta|}(r)$. Hereafter, assume that $N>0$. For $x, y \in \mathbb{R}$, let $z \in \mathbb{C}$ be $x+i y$, and let $f_{\theta, N}(z)$ be $\exp \left(-|z-\theta|^{2} / N\right)$. It holds that

Then, it holds that

& =c_{N, r}\left({ }^{t} \vec{\mu}_{z}-\frac{{ }^{t} \vec{\mu}_{\theta}}{N c_{N, r}}\right)\left(\vec{\mu}_{z}-\frac{\vec{\mu}_{\theta}}{N c_{N, r}}\right)-\log \left(\psi_{|\theta|}(r)\right) .
\end{aligned}

We can factorize $h_{\theta, N}(r)$ to $\psi_{|\theta|}(r)$ and $h_{0, N}(r)$ as

\end{aligned}

holds, we have $\varphi_{S}(r)=\gamma(r) \gamma(-r) \psi_{\|\vec{\theta}\|}(r) \psi_{\|\vec{\theta}\|}(-r)$.

For $X \in \operatorname{Mat}_{\mathbb{R}}^{\mu, \nu}$ and for $K \in \mathbb{N}$, let $\mathcal{P}=$ $\left\{P_{1}(X), P_{2}(X), \ldots, P_{K}(X)\right\} \subset \operatorname{Mat}_{\mathbb{R}}^{\mu}$ and $\mathcal{Q}=\left\{Q_{1}(X), Q_{2}(X), \ldots, Q_{K}(X)\right\} \subset$ Mat ${ }_{\mathbb{R}}^{\nu}$ be sets of $K$ matrices which satisfy $\sum_{k=1}^{K} \operatorname{tr}_{\nu}\left[{ }^{t} M P_{k}(X) M Q_{k}(X)\right]>0$ for any non-zero matrix $M \in \operatorname{Mat}_{\mathbb{R}}^{\mu, \nu}$. The inner product $(u, v)_{X}^{\mathcal{P}, \mathcal{Q}}$ of $u, v \in$ $T_{X}^{\mu, \nu}$ is defined by $\left(\partial /\left.\partial x_{p, q}\right|_{X}, \partial /\left.\partial x_{r, s}\right|_{X}\right)_{X}^{\mathcal{P}, \mathcal{Q}}=\sum_{k=1}^{K} P_{k, p, r}(X) Q_{k, s, q}(X)$, where $P_{k, i, j}(X)$ and $Q_{k, i, j}(X)$ are the $(i, j)$-th entries of $P_{k}(X)$ and $Q_{k}(X)$, respectively. Let $\|u\|_{X}^{\mathcal{P}, \mathcal{Q}}$ be $\sqrt{(u, u)_{X}^{\mathcal{P}, \mathcal{Q}}}$. If $\mathcal{P}=\left\{I_{\mu}\right\}$ and $\mathcal{Q}=\left\{I_{\nu}\right\}$ for any $X \in \mathrm{Mat}_{\mathbb{R}}^{\mu, \nu}$, then the inner product is said to be Euclidean. The pullback of $(\cdot, \cdot)_{f_{Y, Z}(X)}^{\mathcal{P}, \mathcal{Q}}$ by $f_{Y, Z}$ is $(\cdot, \cdot)_{X}^{\mathcal{P}^{\prime}, \mathcal{Q}^{\prime}}$, where $\mathcal{P}^{\prime} \subset \operatorname{Mat}_{\mathbb{R}}^{\mu}$ and $\mathcal{Q}^{\prime} \subset$ Mat $_{\mathbb{R}}^{\nu}$ consist of ${ }^{t} Y P_{k}\left(f_{Y, Z}(X)\right) Y$ and ${ }^{t} Z Q_{k}\left(f_{Y, Z}(X)\right) Z$, respectively.

Let $\mathrm{SO}_{\mathbb{R}}^{n}$ be $\left\{e^{A} \mid A \in \mathrm{Ant}_{\mathbb{R}}^{n}\right\}$, the set of special orthogonal matrices. For $R \in \mathrm{SO}_{\mathbb{R}}^{n}$, let $T_{R} \subset T_{R}^{n, n}$ be the tangent space of $\mathrm{SO}_{\mathbb{R}}^{n} \subset \mathrm{Mat}_{\mathbb{R}}^{n}$ at $R$. We use $(\cdot, \cdot)_{R}^{\mathcal{P}, \mathcal{Q}}$ by restricting the space $T_{R}^{n, n}$ to $T_{R}$. The dimension of $T_{R}$ is $d_{n}=n(n-1) / 2$. If $C \subset T_{R}$ is a cuboid framed by edge vectors $v_{1}, v_{2}, \ldots, v_{d_{n}} \in T_{R}$ which are mutually orthogonal with respect to $(\cdot, \cdot)_{R}^{\mathcal{P}, \mathcal{Q}}$, then the volume $\operatorname{vol}_{R}^{\mathcal{P}, \mathcal{Q}}[C]$ is $\prod_{k=1}^{d_{n}}\left\|v_{k}\right\|_{R}^{\mathcal{P}, \mathcal{Q}}$. Let $\mathcal{F}_{\mathrm{SO}_{\mathbb{R}}^{n}}$ be the set of Borel subsets of $\mathrm{SO}_{\mathbb{R}}^{n}$. Let $\mu^{\mathcal{P}, \mathcal{Q}}: \mathcal{F}_{\mathrm{SO}_{\mathbb{R}}^{n}} \rightarrow[0, \infty)$ be a measure on $\mathrm{SO}_{\mathbb{R}}^{n}$ given by $\operatorname{vol}_{R}^{\mathcal{P}, \mathcal{Q}}[\cdot]$. For $L \in \mathrm{SO}_{\mathbb{R}}^{n}$, and for $M \subset \mathrm{SO}_{\mathbb{R}}^{n}$, let $L M \subset \mathrm{SO}_{\mathbb{R}}^{n}$ be $\{L x \mid x \in M\}$. It holds that $\operatorname{vol}_{L R}^{\mathcal{P}, \mathcal{Q}}[L C]=$ $\operatorname{vol}_{R}^{\mathcal{P}, \mathcal{Q}}[C]$. Hence, we have $\mu^{\mathcal{P}, \mathcal{Q}}(L M)=\mu^{\mathcal{P}, \mathcal{Q}}(M)$.

Let $\mu: \mathcal{F}_{\mathrm{SO}_{\mathbb{R}}^{n}} \rightarrow[0, \infty)$ be $\mu^{\mathcal{P}, \mathcal{Q}}$ with $\mathcal{P}=\mathcal{Q}=\left\{I_{n}\right\}$. For $U \in \mathrm{SO}_{\mathbb{R}}^{n}$, let
$\hat{\underline{V}}_{U} \in \mathcal{U}\left(\mathcal{H}^{\otimes m n}\right)$ be $\exp \left(\hat{v}_{\log U}\right)$. By Lemma 7, for any $L, R \in \mathrm{SO}_{\mathbb{R}}^{n}$, it holds that $\hat{V}_{L} \hat{V}_{R}=\hat{V}_{L R}$. Moreover, by Lemma 9, it holds that $\hat{V}_{L} \hat{V}_{R} f(X)=\hat{V}_{L} f(X R)=$ $f(X L R)$. Hence, $\mathrm{SO}_{\mathbb{R}}^{n}$ acts on the left of $\mathcal{H}^{\otimes m n}$ by $\underset{\sim}{\hat{V}}: \mathrm{SO}_{\mathbb{R}}^{n} \rightarrow \mathcal{U}\left(\mathcal{H}^{\otimes m n}\right)$. Let $\hat{W} \in \mathcal{L}\left(\mathcal{H}^{\otimes m n}\right)$ be $\mu\left(\mathrm{SO}_{\mathbb{R}}^{n}\right)^{-1} \int_{\mathrm{SO}_{\mathbb{R}}^{n}} \hat{V}_{U} \mu(d U)$.

Let $\mathcal{F}_{\mathcal{S}^{n-1}}$ be the set of Borel subsets of $\mathcal{S}^{n-1}$. If a measure $\lambda: \mathcal{F}_{\mathcal{S}^{n-1}} \rightarrow[0, \infty)$ satisfies $\lambda(M U)=\lambda(M)$ $\left({ }^{\forall} M \in \mathcal{F}_{\mathcal{S}^{n-1}},{ }^{\forall} U \in \mathrm{SO}_{\mathbb{R}}^{n}\right)$, then $\lambda$ is said to be rotationally uniform. For $\vec{v} \in \mathcal{S}^{n-1}$, let $T_{\vec{v}}^{\mathcal{S}} \subset T_{\vec{v}}^{1, n}$ be the tangent space of $\mathcal{S}^{n-1} \subset \operatorname{Mat}_{\mathbb{R}}^{1, n}$ at $\vec{v}$. We use the inner product $(\cdot, \cdot)_{\vec{v}}^{\mathcal{P}, \mathcal{Q}}$ by restricting the space to $T_{\vec{v}}^{\mathcal{S}}$. Since elements of $\mathcal{P}$ are scalars, we assume, without loss of generality, that $\mathcal{P}=\left\{I_{1}\right\}$ and that $\mathcal{Q}=\{Q(\vec{v})\}$, where $Q(\vec{v}) \in \operatorname{Sym}_{\mathbb{R}}^{n}$ is a positive matrix which may depend on $\vec{v}$. Let $(\cdot, \cdot)_{\vec{v}}^{\mathcal{Q}}=(\cdot, \cdot)_{\vec{v}}^{\left\{I_{1}\right\},\{Q(\vec{v})\}}$, and let $\|\cdot\|_{\vec{v}}^{\mathcal{Q}}=\|\cdot\|_{\vec{v}}^{\left\{I_{1}\right\},\{Q(\vec{v})\}}$. For any $U \in \mathrm{SO}_{\mathbb{R}}^{n}$, for any $\vec{v} \in \mathcal{S}^{n-1}$, and for any $u, v \in T_{\vec{v}}^{\mathcal{S}}$, it holds that $\left(d f_{U}(u), d f_{U}(v)\right)_{\vec{v} U-1}^{\{Q(\vec{v}\}}=(u, v)_{\vec{v}}^{\{t U Q(\vec{v}) U\}}$. The group action $(U, \vec{v}) \mapsto f_{U}(\vec{v})$ is transitive, that is, for any $\vec{v} \in \mathcal{S}^{n-1}$, the orbit $\left\{f_{U}(\vec{v}) \mid U \in \mathrm{SO}_{\mathbb{R}}^{n}\right\}$ is $\mathcal{S}^{n-1}$. For $\vec{v} \in \mathcal{S}^{n-1}$, let $\Sigma_{\vec{v}} \subset \mathrm{SO}_{\mathbb{R}}^{n}$ be $\left\{U \in \mathrm{SO}_{\mathbb{R}}^{n} \mid f_{U}(\vec{v})=\vec{v}\right\}$, the set of stabilizers of $\vec{v}$. For any $\vec{v} \in \mathcal{S}^{n-1}, \Sigma_{\vec{v}}$ is isomorphic to $\mathrm{SO}_{\mathbb{R}}^{n-1}$. For $\vec{v} \in \mathcal{S}^{n-1}$, define a group representation $\rho_{\vec{v}}: \Sigma_{\vec{v}} \rightarrow \operatorname{GL}\left(T_{\vec{v}}^{\mathcal{S}}\right)$ by $\left.U \mapsto d f_{U}\right|_{\vec{v}}$. Then, $\rho_{\vec{v}}$ is irreducible. Since $\lambda^{\mathcal{Q}}$ is rotationally uniform, it is necessary that, for any $\vec{v} \in \mathcal{S}^{n-1}$, for any $R \in \Sigma_{\vec{v}}$, and for any $u, v \in T_{\vec{v}}^{\mathcal{S}},\left(\rho_{\vec{v}}(R) u, \rho_{\vec{v}}(R) v\right)_{\vec{v}}^{\mathcal{V}}$ is $(u, v)_{\vec{v}}^{\mathcal{Q}}$, and so that, for any $\vec{v} \in \mathcal{S}^{n-1}$, and for any $R \in \Sigma_{\vec{v}},{ }^{t} R Q(\vec{v}) R$ is $Q(\vec{v})$. By Schur's lemma, there exists a function $\varphi: \mathcal{S}^{n-1} \rightarrow \mathbb{R}$ such that $Q(\vec{v})=\varphi(\vec{v}) I_{n}$. (See [10].)

By the positivity of the inner product, $\varphi(\vec{v})$ is positive for any $\vec{v} \in \mathcal{S}^{n-1}$. By the transitivity of $f_{U}, \varphi(\vec{v})$ is constant.

For $\vec{v} \in \mathcal{S}^{n-1}$, define a measure $\lambda_{\vec{v}}: \mathcal{F}_{\mathcal{S}^{n-1}} \rightarrow[0, \infty)$ by $\lambda_{\vec{v}}(M)=\mu(\{U \in$ $\left.\left.\mathrm{SO}_{\mathbb{R}}^{n} \mid \vec{v} U^{-1} \in M\right\}\right)$.

Lemma 22. For any $\vec{v} \in \mathcal{S}^{n-1}$, $\lambda_{\vec{v}}$ is rotationally uniform.
Proof. Choose $M \in \mathcal{F}_{\mathcal{S}^{n-1}}$ and $U \in \mathrm{SO}_{\mathbb{R}}^{n}$, arbitrarily. Consider the case of $m=1$, and, for $\vec{r}=\left(r_{1}, r_{2}, \ldots, r_{n}\right) \in \operatorname{Mat}_{\mathbb{R}}^{1, n}$, let $|\vec{r}\rangle \in \mathcal{H}^{\otimes n}$ be $\left|r_{1}\right\rangle \otimes\left|r_{2}\right\rangle \otimes \cdots \otimes\left|r_{n}\right\rangle$.

For $k \in$ $\{1,2, \ldots, n-1\}$, let $t_{k}$ be the coordinate variable of the $k$-th entry of $\vec{t} \in \mathcal{T}$. We define unit row vectors $\vec{\nu}_{0}, \vec{\nu}_{1}, \ldots, \vec{\nu}_{n-1} \in \mathcal{S}^{n-1}$ which are parameterized by $\vec{t} \in \mathcal{T}$, as follows. Let $\vec{\nu}_{0} \in \mathcal{S}^{n-1}$ be ( $1, O_{1, n-1}$ ). For $k \in\{1,2, \ldots, n-1\}$, let $\vec{\nu}_{k} \in \mathcal{S}^{n-1}$ be

The pushforward $d \varphi\left(\partial /\left.\partial t_{i}\right|_{\vec{t}}\right)$ is $\sum_{j=1}^{n}\left(\partial x_{j} / \partial t_{i}\right) \partial /\left.\partial x_{j}\right|_{\varphi(\vec{t})}$. Let $\vec{J}_{i} \in \operatorname{Mat}_{\mathbb{R}}^{1, n}$ be a row vector whose $j$-th entry is $\partial x_{j} / \partial t_{i}$. Then, as the pullback of the Euclidean inner product for $T_{\varphi(\vec{t})}^{\mathcal{S}}$, the inner product of $\partial /\left.\partial t_{i}\right|_{\vec{t}}$ and $\partial /\left.\partial t_{j}\right|_{\vec{t}}$ is given by

By Eq. (19), we have $\hat{D}_{\vec{z}}\left|\overrightarrow{0}_{m}\right\rangle=|\vec{z}\rangle$. By Eq. (21), we have $\left\langle\overrightarrow{0}_{m} \mid \vec{z}\right\rangle=$ $\exp \left(-\|\vec{u}\|^{2} / 4-\|\vec{v}\|^{2} / 4\right)$. Hence, we obtain

$$
\begin{equation*}
F_{\overrightarrow{0}_{m}, O_{2 m}, 0}(\vec{u}, \vec{v})=\exp \left(-\left({ }^{t} \vec{w}\right) \vec{w} / 4\right) \tag{26}
\end{equation*}
$$

Next, we have $L^{*} e^{\eta} L=\exp \left(L^{*} \eta L\right)=G_{\eta}$. Moreover, it holds that $F_{\vec{\theta}, \eta, 0}=$ $\left\langle\overrightarrow{0}_{m}\right| \hat{D}_{\vec{\theta}}^{*} \hat{S}_{\eta}^{*} \exp \left(-i\left({ }^{t} \vec{w}\right) L^{*} \vec{a}\right) \hat{S}_{\eta} \hat{D}_{\vec{\theta}}\left|\overrightarrow{0}_{m}\right\rangle$. By Lemma 1, it holds that $\hat{S}_{\eta}^{*} \vec{a} \hat{S}_{\eta}=$ $e^{\eta} \underset{\sim}{\vec{a}}$. By Eq. (18), it holds that $\hat{D}_{\vec{\theta}}^{*} \underset{a}{a} \hat{D}_{\vec{\theta}}=\underset{\sim}{\vec{a}}+\sqrt{2} L \vec{\mu}_{\vec{\theta}} \hat{I}^{\otimes m}$. Hence, we have

$$
\begin{align*}
F_{\vec{\theta}, \eta, 0}(\vec{u}, \vec{v}) & =\left\langle\overrightarrow{0}_{m}\right| \exp \left[-i\left({ }^{t} \vec{w}\right) L^{*} e^{\eta}\left(\vec{a}+\sqrt{2} L \vec{\mu}_{\vec{\theta}}\right)\right]\left|\overrightarrow{0}_{m}\right\rangle \\
& =\left\langle\overrightarrow{0}_{m}\right| \exp \left[-i\left({ }^{t} \vec{w}\right) G_{\eta} \vec{r}-i \sqrt{2}\left({ }^{t} \vec{w}\right) G_{\eta} \vec{\mu}_{\vec{\theta}}\right]\left|\overrightarrow{0}_{m}\right\rangle \tag{27}
\end{align*}
$$

By (26) and (27), we obtain

$$
\begin{equation*}
F_{\vec{\theta}, \eta, 0}(\vec{u}, \vec{v})=\exp \left(-\frac{1}{4}\left({ }^{t} \vec{w}\right) G_{\eta}\left({ }^{t} G_{\eta}\right) \vec{w}-i \sqrt{2}\left({ }^{t} \vec{w}\right) G_{\eta} \vec{\mu}_{\vec{\theta}}\right) \tag{28}
\end{equation*}
$$

Next, for $\vec{x}={ }^{t}\left(x_{1}, x_{2}, \ldots, x_{m}\right) \in \operatorname{Mat}_{\mathbb{R}}^{m, 1}$ and for $\vec{y}={ }^{t}\left(y_{1}, y_{2}, \ldots, y_{m}\right) \in \operatorname{Mat}_{\mathbb{R}^{m, 1}}$, let $g_{\vec{\theta}, N}(\vec{x}, \vec{y})=(\pi N)^{-1} e^{-\|\vec{x}+i \vec{y}-\vec{\theta}\|^{2} / N}$. Then, it holds that

$$
\begin{equation*}
F_{\vec{\theta}, \eta, N}(\vec{u}, \vec{v})=\overbrace{\int \cdots \int_{\mathbb{R}^{2 m}}^{2 m}}^{g_{\vec{\theta}, N}}(\vec{x}, \vec{y}) F_{\vec{x}+i \vec{y}, \eta, 0}(\vec{u}, \vec{v}) \prod_{k=1}^{m} d x_{k} d y_{k} . \tag{29}
\end{equation*}
$$

By (28), the integrated factor of (29) is the Fourier transform of $g_{\vec{\theta}, N}(\vec{x}, \vec{y})$. Hence, we obtain the statement.

We use $\Sigma_{\eta, N}$ defined in (9).
Lemma 30. It holds that

$$
\frac{1}{\pi^{m}}\langle\vec{z}| \hat{\rho}_{\vec{\theta}, \eta, N}|\vec{z}\rangle=\frac{\exp \left[-^{t}\left(\vec{\mu}_{\vec{z}}-G_{\eta} \vec{\mu}_{\vec{\theta}}\right) \Sigma_{\eta, N}^{-1}\left(\vec{\mu}_{\vec{z}}-G_{\eta} \vec{\mu}_{\vec{\theta}}\right) / 2\right]}{(2 \pi)^{m} \sqrt{\operatorname{det}\left[\Sigma_{\eta, N}\right]}}
$$

Proof. Let $W_{\hat{\rho}}(x, y)$ be the Wigner function of $\hat{\rho} \in \mathcal{S}(\mathcal{H})$. By the overlap formula, it holds that $\operatorname{Tr}[\hat{\rho} \hat{\sigma}]=2 \pi \iint_{\mathbb{R}^{2}} W_{\hat{\rho}}(x, y) W_{\hat{\sigma}}(x, y) d x d y$. (See (3.22) of [8].) Moreover, by the Parseval's formula, it holds that $\operatorname{Tr}[\hat{\rho} \hat{\sigma}]=$ $(2 \pi)^{-1} \iint_{\mathbb{R}^{2}} \overline{F_{\hat{\rho}}(u, v)} F_{\hat{\sigma}}(u, v) d u d v$. Let $\vec{\nu}=\vec{\mu}_{\vec{z}}-G_{\eta} \vec{\mu}_{\vec{\theta}}$. By Lemma 29, we have

$$
\begin{align*}
\langle\vec{z}| \hat{\rho}_{\vec{\theta}, \eta, N}|\vec{z}\rangle= & \frac{1}{(2 \pi)^{m}} \overbrace{\int \cdots \int_{\mathbb{R}^{2 m}}}^{2 m} \exp \left(-\left({ }^{t} \vec{w}\right) \Sigma_{\eta, N} \vec{w}-i \sqrt{2}\left({ }^{t} \vec{w}\right) \vec{\nu}\right) \\
& \times \prod_{i=k}^{m} d u_{k} d v_{k} . \tag{30}
\end{align*}
$$

Let $\vec{w}^{\prime}=\vec{w}+i \Sigma_{\eta, N}^{-1} \vec{\nu} / \sqrt{2}$. Then, the argument of the exponential function of (30) is equal to $-\left({ }^{t} \vec{w}^{\prime}\right) \Sigma_{\eta, N} \vec{w}^{\prime}-\left({ }^{t} \vec{\nu}\right) \Sigma_{\eta, N}^{-1} \vec{\nu} / 2$. Calculating the Gausian intagration and multiplying $\pi^{-m}$, we obtain the statement.

Let $\kappa={ }^{t} \vec{\mu}_{\vec{\theta}, \eta} \Sigma_{\eta, N}^{-1} \vec{\mu}_{\vec{\theta}, \eta}$.
Lemma 31. For any $r>0$, for any $\vec{\theta} \in \operatorname{Mat}_{\mathbb{C}}^{m, 1} \backslash\left\{\overrightarrow{0}_{m}\right\}$ and for any $N \geq 0$, there exists $\eta \in \mathrm{Sqz}^{m}$ such that

$$
\begin{equation*}
\kappa=\frac{4 r^{2}\|\vec{\theta}\|^{2}}{(2 N+1) r^{2}+1} . \tag{31}
\end{equation*}
$$

Proof. Let $\zeta \in \mathrm{Sqz}^{m}$ be $\log (r)\left(\begin{array}{cc}O_{m} & I_{m} \\ I_{m} & O_{m}\end{array}\right)$. Then, $G_{\zeta}$ is $\left(\begin{array}{cc}r I_{m} & O_{m} \\ O_{m} & r^{-1} I_{m}\end{array}\right)$. Let $\vec{u} \in \operatorname{Mat}_{\mathbb{R}}^{m, 1}$ be any real column vector. Then, it holds that $\vec{\mu}_{\vec{u}}=\vec{\mu}_{\vec{u}, O_{2 m}}=$ $\binom{\vec{u}}{\overrightarrow{0}_{m}}$, and that

$$
{ }^{t} \vec{\mu}_{\vec{u}, \zeta} \Sigma_{\zeta, N}^{-1} \vec{\mu}_{\vec{u}, \zeta}=r^{2}\left({ }^{t} \vec{u}\right)\left(r^{2} \frac{2 N+1}{4} I_{m}+\frac{1}{4} I_{m}\right)^{-1} \vec{u}=\frac{4 r^{2}\|\vec{u}\|^{2}}{r^{2}(2 N+1)+1} .
$$

Let $A \in$ Ant $_{\mathbb{C}}^{m}$ be a diagonal matrix satisfying $e^{-A} \vec{\theta} \in \operatorname{Mat}_{\mathbb{R}}^{m, 1}$. Let $\vec{s}=e^{-A} \vec{\theta}$. Let $U=\left(\begin{array}{cc}e^{A} & O_{m} \\ O_{m} & e^{-A}\end{array}\right)$. Let $\eta \in \mathrm{Sqz}^{m}$ be $U \zeta U^{*}$. There exists an orthogonal matrix $R \in \operatorname{Mat}_{\mathbb{R}}^{2 m}$ such that $G_{\eta}=R G_{\zeta}\left({ }^{t} R\right)$ and ${ }^{t} R \vec{\mu}_{\vec{\theta}}=\binom{\overrightarrow{\vec{~}}}{\overrightarrow{0}_{m}}$. Hence, it holds that

$$
\begin{aligned}
\kappa & ={ }^{t}\left(G_{\zeta}{ }^{t} R \vec{\mu}_{\vec{\theta}}\right)\left(\frac{2 N+1}{4} G_{\zeta}\left({ }^{t} G_{\zeta}\right)+\frac{1}{4} I_{2 m}\right)^{-1}\left(G_{\zeta}{ }^{t} R \vec{\mu}_{\vec{\theta}}\right) \\
& =r^{2}\left({ }^{t} \vec{s}\right)\left(r^{2} \frac{2 N+1}{4} I_{m}+\frac{1}{4} I_{m}\right)^{-1} \vec{s} .
\end{aligned}
$$

Hence, we obtain (31).
Let $\lambda$ be $n \kappa$. Let $p_{\lambda}(f)$ be the probability density function of $F_{\mu, \nu ; \lambda}$ defined in (10). Let $c$ be the critical point of level $\alpha$, that is, the solution to $\int_{c}^{\infty} p_{0}(f) d f=\alpha$.

Lemma 32. For any $m \geq 1$, for any $n \geq 2 m+1$, for any $\vec{\theta} \in \operatorname{Mat}_{\mathbb{C}}^{m, 1}$, for any $\eta \in \mathrm{Sqz}^{m}$, for any $N \geq 0$ and for any $\alpha \in(0,1)$, there exists $\delta>0$ such that $\beta_{\hat{\rho}_{\hat{\theta}, \eta, N}(n)}\left[T_{\alpha}^{\mathrm{HH}}\right]=1-\alpha-(1-\alpha-\delta) \lambda / 2+o(\lambda)$ holds as $\lambda$ goes to zero.

Proof. Let $q(f)=\partial p_{\lambda}(f) /\left.\partial \lambda\right|_{\lambda=0}$. It holds that

$$
q(f)=-\frac{1}{2} p_{0}(f)+\frac{1}{2} \frac{\mu+\nu}{\mu} \frac{\mu f}{\mu f+\nu} p_{0}(f)=\left(\frac{\mu+\nu}{\mu f+\nu} f-1\right) \frac{p_{0}(f)}{2} .
$$

Let $\delta=(\mu+\nu) \int_{0}^{c}(\mu f+\nu)^{-1} f p_{0}(f) d f$. Then, it holds that $\int_{0}^{c} q(f) d f=$ $(\delta-1+\alpha) / 2$. Hence, we have $\beta_{\hat{\rho}_{\overparen{\theta}, \eta, N} n}\left[T_{\alpha}^{\mathrm{HH}}\right]=1-\alpha+(\delta-1+\alpha) \lambda / 2+o(\lambda)$ as $\lambda \rightarrow 0$.

Proof of Theorem 5. (i) By Lemma 31, $\lambda$ depends on $\eta$. By Lemma 32, $\beta_{\beta_{\hat{\rho}}^{\theta}, \eta, N}\left[T_{\alpha}^{\mathrm{HH}}\right]=\int_{0}^{c} p_{\lambda}(f) d f$ depends on $\eta$.
(ii) By Eq. (10), $\beta_{\hat{\rho}_{\bar{\theta}, \eta, N} \otimes}\left[T_{\alpha}^{\mathrm{HH}}\right]=\int_{0}^{c} p_{\lambda}(f) d f$ is greater than $e^{-\lambda / 2}(1-\alpha)$. By Lemma 31, for any $\varepsilon \in \mathbb{R}$ with $0<\varepsilon<1-\alpha$, there exists $\eta \in \mathrm{Sqz}^{m}$ such that ${ }^{t} \vec{\mu}_{\vec{\theta}, \eta} \Sigma_{\eta, N}^{-1} \vec{\mu}_{\vec{\theta}, \eta}<2 \log [(1-\alpha) /(1-\alpha-\varepsilon)]$, that is, $\beta_{\hat{\rho}_{\hat{\theta}, \eta, N} \otimes n}\left[T_{\alpha}^{\mathrm{HH}}\right]>1-\alpha-\varepsilon$. Hence, we have $\sup _{\eta \in \operatorname{Sqz}^{m}} \beta_{\hat{\rho}_{\hat{\theta}, \eta, N}^{\otimes n}}\left[T_{\alpha}^{\mathrm{HH}}\right]=1-\alpha$.

### 5.10 Proof of Theorem 6(Comparison of $\beta_{\hat{\rho}_{\theta, 0}}\left[T_{\alpha}^{\mathrm{SI}}\right]$ with $\left.\beta_{\hat{\rho}_{\theta, 0}^{8 刃 z}}\left[T_{\alpha}^{\mathrm{HH}}\right]\right)$

We compare orders of type II error probabilities for $\|\vec{\theta}\| \fallingdotseq 0$ and for $\|\vec{\theta}\| \gg 0$.
Lemma 33. For any $m \geq 1$, for any $n \geq 2$ and for any $\alpha \in[0,1)$, it holds that $\beta_{\hat{\rho}_{\vec{\theta}, 0}^{\otimes n}}\left[T_{\alpha}^{\mathrm{SI}}\right]=1-\alpha-(1-\alpha) n\|\vec{\theta}\|^{2}+o\left(\|\vec{\theta}\|^{2}\right)$ as $\|\vec{\theta}\|^{2}$ goes to zero.

Proof. Let $f(r)=e^{-n r} \int_{0}^{\pi} e^{n r \cos \varphi}(\sin \varphi)^{n-2} d \varphi$. It holds that

$$
\frac{d f}{d r}(0)=-n f(0)+n \int_{0}^{\pi} \cos \varphi(\sin \varphi)^{n-2} d \varphi=-n f(0)
$$

and that $f(0)=B((n-1) / 2,1 / 2)$. By Theorem 4, it holds that $\beta_{\hat{\rho}_{\bar{\theta}, 0}}\left[T_{\alpha}^{\mathrm{SI}}\right]=$ $(1-\alpha) f\left(\|\vec{\theta}\|^{2}\right) / B((n-1) / 2,1 / 2)$. Hence, we have $\beta_{\hat{\rho}_{\theta, 0} \otimes n}\left[T_{\alpha}^{\mathrm{SI}}\right]-1+\alpha=$ $-(1-\alpha) n\|\vec{\theta}\|^{2}+o\left(\|\vec{\theta}\|^{2}\right)$ as $\|\vec{\theta}\|^{2} \rightarrow 0$.
Lemma 34. If $m=1, n=3$ and $N=0$, then, for any $\alpha \in[0,1)$, it holds that $\beta_{\hat{\rho}_{\theta, 0}^{\otimes 3}}\left[T_{\alpha}^{\mathrm{SI}}\right]=O\left(|\theta|^{-2}\right)$ as $|\theta|$ goes to infinity.

Proof. Let $r=3|\theta|^{2}$, let $s=e^{-r} / B(1,1 / 2)$, and let $t=\int_{0}^{\pi} e^{r \cos \varphi} \sin \varphi d \varphi$. By Theorem 4, it holds that $\beta_{\hat{\rho}_{\theta, 0} 3}\left[T_{\alpha}^{\mathrm{SI}}\right]=(1-\alpha)$ st. We can calculate $t$ as

$$
t=-\left.\frac{1}{r} e^{r \cos \varphi}\right|_{\varphi=0} ^{\pi}=\frac{e^{r}-e^{-r}}{r}
$$

Hence, we have $\beta_{\hat{\rho}_{\theta, 0}^{\otimes 33}}\left[T_{\alpha}^{\mathrm{SI}}\right]=(1-\alpha)\left(1-e^{-2 r}\right) /[r B(1,1 / 2)]=O\left(|\theta|^{-2}\right)$ as $\|\vec{\theta}\|^{2} \rightarrow \infty$.

Let $\lambda=n\left({ }^{t} \vec{\mu}_{\vec{\theta}, \eta}\right) \Sigma_{\eta, N}^{-1} \vec{\mu}_{\vec{\theta}, \eta}$. Let $p_{\lambda}(f)$ be the probability density function of $f$ given in (10).

Lemma 35. For any $m \geq 1$, for any $n \geq 2 m+1$, for any $\vec{\theta} \in \operatorname{Mat}_{\mathbb{C}}^{m, 1}$, for any $\eta \in \mathrm{Sqz}^{m}$, for any $N \geq 0$ and for any $c>0$, there exists $t>0$ such that $\int_{0}^{c} p_{\lambda}(f) d f=o\left(e^{-t \lambda}\right)$ as $\lambda$ goes to infinity.
Proof. Let $A_{0}=\int_{0}^{c} p_{\lambda}(f) d f$. Replace $\mu f /(\mu f+\nu)$ by $x$. The Jacobian of this replacement is $d f / d x=(d x / d f)^{-1}=x^{-1}(1-x)^{-1} f$. Let $b_{0}=\mu c /(\nu+\mu c)$. Let

$$
q_{k}=\frac{e^{-\lambda / 2}(\lambda / 2)^{k}}{k!} \text { and } r_{k}(x)=\frac{x^{k+\mu / 2-1}(1-x)^{\nu / 2-1}}{B(k+\mu / 2, \nu / 2)} .
$$

It holds that $A_{0}=\int_{0}^{b_{0}} \sum_{k=0}^{\infty} q_{k} r_{k}(x) d x$. Choose $b_{1} \in\left(b_{0}, 1\right)$ arbitrarily. There exists $k_{0} \in \mathbb{N}$ such that, for any $k \geq k_{0}$ and for any $x \in\left(0, b_{0}\right)$,

$$
\begin{equation*}
\frac{r_{k+1}(x)}{r_{k}(x)}=\frac{k+(\mu+\nu) / 2}{k+\mu / 2} x<\frac{k+(\mu+\nu) / 2}{k+\mu / 2} b_{0}<b_{1} \tag{32}
\end{equation*}
$$

holds. Let $R_{k}=\int_{0}^{b_{0}} r_{k}(x) d x$. By (32), for any $k \geq k_{0}$, it holds that $R_{k+1}<$ $b_{1} R_{k}$. Let $A_{1}=\sum_{k=0}^{k_{0}-1} q_{k} R_{k}$, and let $A_{2}=A_{0}-A_{1}=\sum_{k=k_{0}}^{\infty} q_{k} R_{k}$. It holds that

$$
\begin{equation*}
A_{2}<\sum_{k=k_{0}}^{\infty} q_{k} R_{k_{0}} b_{1}^{k-k_{0}}<\sum_{k=0}^{\infty} q_{k} R_{k_{0}} b_{1}^{k-k_{0}}=b_{1}^{-k_{0}} R_{k_{0}} e^{\lambda\left(b_{1}-1\right) / 2} . \tag{33}
\end{equation*}
$$

For any $s>0$, it holds that

$$
\begin{equation*}
A_{1}<\sum_{k=0}^{k_{0}-1} q_{k} e^{\left(k_{0}-1-k\right) s}<\sum_{k=0}^{\infty} q_{k} e^{\left(k_{0}-1-k\right) s}=e^{\left(k_{0}-1\right) s} e^{\lambda\left(e^{-s}-1\right) / 2} \tag{34}
\end{equation*}
$$

Let $t=2^{-1} \min \left\{\left(1-b_{1}\right) / 2,\left(1-e^{-s}\right) / 2\right\}$. By (33) and (34), we have $A_{0}=$ $o\left(e^{-t \lambda}\right)$ as $\lambda \rightarrow \infty$.
Proof of Theorem 6. (i) By Lemmas 33 and 32, there exists $\delta>0$ such that $\beta_{\hat{\rho}_{\theta, 0}^{\otimes 83}}\left[T_{\alpha}^{\mathrm{HH}}\right]-\beta_{\hat{\rho}_{\theta, 0}^{\otimes 3}}\left[T_{\alpha}^{\mathrm{SI}}\right]=3 \delta|\theta|^{2}+o\left(|\theta|^{2}\right)$ holds as $|\theta| \rightarrow 0$.
(ii) By Lemmas 34 and 35, we obtain the statement.
