# PT-Symmetric Quantum $\begin{aligned} & \text{Mechanics :} (\mathbf{N} \times \mathbf{N}) \\ & \text{Matrix Model} \end{aligned}$

We propose a model  $\mathbf{CCS}$  (complex-conjugate-space) to understand the inner and outer product nature of wave functions in non-hermitian  $\mathbf{PT}$ -symmetry model in quantum mechanics considering  $(N \times N)$  matrix model. Further we reflect the correct nature of C-symmetry ,P-parity and original Hamiltonian matrix for any arbitrary values of N. Interestingly the present result on N=2, remains the same reported earlier by Bender,Brody and Jones model  $\mathbf{PT}$ -symmetry operaor. In non-conventional way one can notice that wave functions in a  $\mathbf{PT}$ -symmetry model satisfies similar relations as in hermitian operator.

#### **I.Introduction**

Since the development of quantum mechanics it is well known that Wave functions in Hermitian operator satisfies the following relations [1]

$$<\psi_i||\psi_i>=\delta_{i,j}$$
 (1)

$$<\psi_i|H=H^{\dagger}|\psi_i>=E_i$$
 (2)

$$H = \sum_{i} E_i |\psi_i\rangle \langle \psi_i| \tag{3}$$

$$I = \sum_{i} |\psi_{i}\rangle \langle \psi_{i}| \tag{4}$$

In above  $E_i$  is real and I is an unit matrix having dimension (NxN). Interestingly understanding of inner oand outer product as reflected above is very easy. However if  $\mathbf{Bra}$  (< | is different from  $\mathbf{ket}$  (| >) then above analysis can hardly be valid. Quantum mechanical model where  $\mathbf{Bra}$  is different from  $\mathbf{ket}$  are seen [2-4]in the  $\mathbf{PT}$ -symmetric model of Hamiltonian satisfying the condition

$$[H, PT] = 0 \to H \neq H^{\dagger} \tag{5}$$

.

It should be borne in mind that all the Hamiltonian satisfying the above condition not necessarily give real spectra . Hence  $\mathbf{PT}$ -symmetry model can be categorized as

(i) un-broken  $\mathbf{PT}$ -symmetry and (ii) broken  $\mathbf{PT}$ -symmetry . Here

P stands for parity operator having the behaviour

$$P(x) \to -x$$
 (6)

$$P(i) \to i$$
 (7)

Similarly **T**-stands for time -reversal operator having the behaviour[2]

$$T(i) \to -i$$
 (8)

and

$$T(x) \to x$$
 (9)

In other words **PT** stands for parity-time reversal symmetry[2] . It interesting to discuss all previous models in the derivation of appropriate inner product and outer product . In BBJ [2] model authors argue that

$$<\psi| = CPT\psi = <\psi^{CPT}|$$
 (10)

where C is the C-symmetry operator having eigenvalues  $\lambda_C=\pm 1$  satisfying the condition

$$[H,C] = 0 (11)$$

and P-is the parity operator having eigenvalues  $\lambda_P = \pm 1$ . Both of these operators are determined from the original Hamiltonian operator [2,3] .For example consider the Hamiltonian

$$H = \sigma_0 r \cos \theta + \dot{\sigma(s, 0, s \sin \alpha)} \tag{12}$$

where  $\sigma_{1,2,3}$  are the Pauli matrices and  $\sigma_0$ =unit matrix. The Parity operator is

$$P = \sigma_1 \tag{13}$$

and

$$C = \dot{\sigma(s, 0, s \sin \alpha)}(s = \sec \alpha) \tag{14}$$

Here the outer product is defined as

$$<\psi_{\pm}^{CPT}||\psi_{\pm}=1;<\psi_{\pm}^{CPT}||\psi_{\mp}>=0$$
 (15)

On the other hand in Wang model [4], one defines the outer product as

$$<\psi_{\pm}|W|\psi_{pm}>=1; <\psi_{\pm}|W|\psi_{mp}>=0$$
 (16)

where  $W = (R^{-1})^{\dagger} W_0 R^{-1}$  (for details see the reference [4]). In contract to these two medel, Manneheim [5] discussed the outer product as

$$<\psi_{\pm}|V|\psi_{pm}>=1;<\psi_{\pm}|V|\psi_{mp}>=0$$
 (17)

In comparing above models we notice that all the approaches are different from each other [2-5] in describing the same physics. However all the previous models are discussed considering  $(2 \times 2)$  matrix model and no discussion has been given for  $(N \times N)$  model of non-Hermitian model. On the other hand we feel that inner and outer product in complex **PT**-symmetry can be described eleglantly without the help of previous assumptions as follows. The presentation is as follows: first we discuss the model considering a  $(2\dot{2})$  matrix, then extend it for higher values of N say N=3,4,5,9,10. The proposed matrix model considered here is [2,3]

$$H^{PT} = \begin{bmatrix} re^{i\theta} & s \\ s & re^{-i\theta} \end{bmatrix}$$
 (18)

It is actually a three parameter model. The model under unbroken eigenvalues[2] are the following

$$E_{1,2} = r\cos\theta \pm s\cos\phi \tag{19}$$

and the corresponding eigenfunctions are [6]

$$|\psi\rangle = \frac{1}{\sqrt{2\cos\phi}} \begin{bmatrix} e^{i\phi/2} \\ e^{-i\phi/2} \end{bmatrix} \tag{20}$$

and

$$|\phi\rangle = \frac{1}{\sqrt{2\cos\phi}} \begin{bmatrix} e^{-i\phi/2} \\ -e^{i\phi/2} \end{bmatrix}$$
 (21)

In above relations one has to use  $r \sin \theta = s \sin \phi$ . It is easy to see that in normal understanding of quantum mechanics ,the above wave functions are not normalised so  $\langle \psi | H | \psi \rangle \neq E_1$  or  $\langle \phi | H | \phi \rangle \neq E_2$ . Now we will consider a space, where the above relations will remain valid similar to to one in standard Hilbert's space understanding.

## II.Complex Conjugate Space (CCS)

In order to accept the above wave functions pertaining to  $\mathbf{PT}$ -symmetry ,let us adopt the complex-conjugate -space( $\mathbf{CCS}$ ) .In complex-conjugate-space ( $\mathbf{CCS}$ ) the normalisation condition is

#### Normalisation condition

$$<\psi^*||\psi> = <\phi^*||\phi> = 1$$
 (22)

Interested readers can verify that

$$<\psi^*| = \frac{1}{\sqrt{2\cos\phi}} [e^{i\phi/2}, e^{-i\phi/2}]$$
 (23)

$$<\phi^*| = \frac{1}{\sqrt{2\cos\phi}} [e^{-i\phi/2}, -e^{i\phi/2}]$$
 (24)

and the corresponding normalisation condition as proposed above. Under the complex-conjugate-space the other lations are the following

#### Orthogonality condition

$$\langle \psi^* | | \phi \rangle = 0 = \langle \phi^* | | \psi \rangle \tag{25}$$

#### Energy calculation

$$<\psi^*|H^{PT}|\psi> = E_1 = r\cos\theta + s\cos\phi$$
 (26)

$$<\phi^*|H^{PT}|\psi> = E_2 = r\cos\theta - s\cos\phi$$
 (27)

## Original Matrix

Then it is easy to see that

$$H^{PT} = E_1 |\psi\rangle \langle \psi^*| + E_2 |\phi\rangle \langle \phi^*| = \begin{bmatrix} re^{i\theta} & s \\ s & re^{-i\theta} \end{bmatrix}$$
 (28)

Identity operator (Completeness relation )

$$I = |\psi\rangle \langle \psi^*| + |\phi\rangle \langle \phi^*| = \begin{bmatrix} 1 & 0 \\ 0 & 1 \end{bmatrix}$$
 (29)

# C-Symmetry operator

In hermiticity we do not give importance to another symmetry called C-symmetry having eigenvalues  $\pm 1$ . In **PT**-symmetry one can calculate C as

$$C = |\psi\rangle \langle \psi^*| - |\phi\rangle \langle \phi^*| = \begin{bmatrix} i \tan \phi & \sec \phi \\ \sec \phi & -i \tan \phi \end{bmatrix}$$
(30)

Interested reader can verify that

$$\langle \psi^* | C | \psi \rangle = \lambda_1 = 1 \tag{31}$$

$$\langle \phi^* | C | \psi \rangle = \lambda_2 = -1 \tag{32}$$

In this context, the parity operator can be written as

#### P-Parity operator

$$P = |\psi^* > <\psi^*| - |\phi^* > <\phi^*| = \begin{bmatrix} 0 & 1 \\ 1 & 0 \end{bmatrix}$$
 (33)

#### III. Higher values on N

Here we consider the operator C and P for higher order matrix having dimension  $N_{i,2}$ . The operator P can be expressed as

$$P = \sum_{n} (-1)^{n} |\psi_{n}^{*} \rangle \langle \psi_{n}^{*}| \tag{34}$$

and C-symmetry operator can be expressed as

$$C = \sum_{n} (-1)^{n} |\psi_{n}\rangle \langle \psi_{n}^{*}| = \sum_{n} (-1)^{n} \psi_{n} \otimes \psi_{n}^{\dagger}$$
 (35)

$$|\psi_{+}\rangle \langle \psi_{+}^{*}| - |\psi_{-}\rangle \langle \psi_{-}^{*}| = C$$
 (36)

and indentity operator as

$$|\psi_{+}^{*}\rangle \langle \psi_{+}| + |\psi_{-}^{*}\rangle \langle \psi_{-}| = I$$
 (37)

Now apply it to for different size of matrix as follows.

#### N=3

Let us apply to  $H_3^{PT}$ 

$$H_3^{PT} = \begin{bmatrix} r_1 e^{i\theta_1} & s_1 & 0 \\ s_1 & r_1 e^{-i\theta_1} & 0 \\ 0 & 0 & a \end{bmatrix}$$
 (38)

with known solutions as

$$|\psi_{+}^{(1)}\rangle = \frac{1}{\sqrt{2\cos\phi_{1}}} \begin{bmatrix} e^{i\phi_{1}/2} \\ e^{-i\phi_{1}/2} \\ 0 \end{bmatrix}$$
 (39)

$$|\psi_{-}^{(1)}\rangle = \frac{1}{\sqrt{2\cos\phi_{1}}} \begin{bmatrix} e^{-i\phi_{1}/2} \\ -e^{i\phi_{1}/2} \\ 0 \end{bmatrix}$$
 (40)

$$|\psi_a\rangle = \begin{bmatrix} 0\\0\\1 \end{bmatrix} \tag{41}$$

where  $r_1 \sin \theta_1 = s_1 \sin \phi_1$  ( the condition for unbroken spectra . Then it is easy to see that

$$<\psi_{+}^{(1)*}|H_{1}^{PT}|\psi_{+}^{(1)}> = E_{+}^{(1)} = r_{1}\cos\theta_{1} + s_{1}\cos\phi_{1}$$
 (42)

$$<\psi_{-}^{(1)*}|H_{1}^{PT}|\psi_{-}^{(1)}> = E_{-}^{(1)} = r_{1}\cos\theta_{1} + s_{1}\cos\psi_{1}$$
 (43)

$$\langle \psi_a | H_1^{PT} | \psi_a \rangle = a \tag{44}$$

$$C_{3} = |\psi_{+}^{(1)}\rangle \langle \psi_{+}^{(1)*}| - |\psi_{-}^{(1)}\rangle \langle \psi_{-}^{(1)*}| + |\psi_{a}\rangle \langle \psi_{a}| = \begin{bmatrix} i\tan\phi_{1} & \sec\phi_{1} & 0\\ \sec\phi_{1} & -i\tan\phi_{1} & 0\\ 0 & 0 & 1 \end{bmatrix}$$

$$(45)$$

$$P_{3} = |\psi_{+}^{(1)*}\rangle \langle \psi_{+}^{(1)*}| - |\phi_{-}^{(1)*}\rangle \langle \phi_{-}^{(1)*}| + |\psi_{a}\rangle \langle \psi_{a}| = \begin{bmatrix} 0 & 1 & 0 \\ 1 & 0 & 0 \\ 0 & 0 & 1 \end{bmatrix}$$
(46)

#### N=4

Let us apply to  $H_4^{PT}$ 

$$H_4^{PT} = \begin{bmatrix} r_1 e^{i\theta_1} & s_1 & 0 & 0\\ s_1 & r_1 e^{-i\theta_1} & 0 & 0\\ 0 & 0 & r_2 e^{i\theta_2} & s_2\\ 0 & 0 & s_2 & r_2 e^{-i\theta_2} \end{bmatrix}$$
(47)

having solutions

$$|\psi_{+}^{(1)}\rangle = \frac{1}{\sqrt{2\cos\phi_{1}}} \begin{bmatrix} e^{i\phi_{1}/2} \\ e^{-i\phi_{1}/2} \\ 0 \\ 0 \end{bmatrix}$$
 (48)

$$|\psi_{-}^{(1)}\rangle = \frac{1}{\sqrt{2\cos\phi_{1}}} \begin{bmatrix} e^{-i\phi_{1}/2} \\ -e^{i\phi_{1}/2} \\ 0 \\ 0 \end{bmatrix}$$
 (49)

$$|\psi_{+}^{(2)}\rangle = \frac{1}{\sqrt{2\cos\phi_{2}}} \begin{vmatrix} 0\\0\\e^{i\phi_{2}/2}\\e^{-i\phi_{2}/2} \end{vmatrix}$$
 (50)

and

$$|\psi_{-}^{(2)}\rangle = \frac{1}{\sqrt{2\cos\phi_2}} \begin{bmatrix} 0\\0\\e^{-i\phi_2/2}\\-e^{i\phi_2/2} \end{bmatrix}$$
 (51)

where  $r_i \sin \theta_i = s_i \sin \phi_i$  (i=1,2 the condition for unbroken spectra . Then it is easy to see that

$$<\psi_{\pm}^{(i)}|H_4^{PT}|\psi_{\pm}^{(i)}> = E_{\pm}^{(i)} = r_i \cos\theta_i \pm s_i \cos\phi_i$$
 (52)

$$C_{4} = \sum_{i} [|\psi_{+}^{(i)}\rangle \langle \psi_{+}^{(i*)}| - |\psi_{-}^{(i)}\rangle \langle \psi_{-}^{(i*)}|] = \begin{bmatrix} i\tan\phi_{1} & \sec\phi_{1} & 0 & 0\\ \sec\phi_{1} & -i\tan\phi_{1} & 0 & 0\\ 0 & 0 & i\tan\phi_{2} & \sec\phi_{2}\\ 0 & 0 & \sec\phi_{2} & -i\tan\phi_{2} \end{bmatrix}$$

$$(53)$$

$$P_{4} = \sum_{i} [|\psi_{+}^{(i*)}\rangle \langle \psi_{+}^{(i*)}| - |\psi_{-}^{(i*)}\rangle \langle \psi_{-}^{(i*)}|] = \begin{bmatrix} 0 & 1 & 0 & 0 \\ 1 & 0 & 0 & 0 \\ 0 & 0 & 0 & 1 \\ 0 & 0 & 1 & 0 \end{bmatrix}$$
(54)

N=5

Similarly for

$$H_5^{PT} = \begin{bmatrix} r_1 e^{i\theta_1} & s_1 & 0 & 0 & 0 \\ s_1 & r_1 e^{-i\theta_1} & 0 & 0 & 0 \\ 0 & 0 & r_2 e^{i\theta_2} & s_2 & 0 \\ 0 & 0 & s_2 & r_2 e^{-i\theta_2} & 0 \\ 0 & 0 & 0 & 0 & a \end{bmatrix}$$
 (55)

one can have

$$C_{5} = \begin{bmatrix} i \tan \phi_{1} & \sec \phi_{1} & 0 & 0 & 0\\ \sec \phi_{1} & -i \tan \phi_{1} & 0 & 0 & 0\\ 0 & 0 & i \tan \phi_{2} & \sec \phi_{2} & 0\\ 0 & 0 & \sec \phi_{2} & -i \tan \phi_{2} & 0\\ 0 & 0 & 0 & 0 & 1 \end{bmatrix}$$
 (56)

$$P_{5} = \begin{bmatrix} 0 & 1 & 0 & 0 & 0 \\ 1 & 0 & 0 & 0 & 0 \\ 0 & 0 & 0 & 1 & 0 \\ 0 & 0 & 1 & 0 & 0 \\ 0 & 0 & 0 & 0 & 1 \end{bmatrix}$$

N=10

Let us define  $\tau_j = r_j e^{i\theta_j}; \sigma_j = r_j e^{-i\theta_j}; r_j \sin \theta_j = s_j \sin \phi_j.$ 

In order to present the expression for  $C_{10}$  we define  $\Omega_j = i \tan \phi_j$ ;  $\Lambda_j = \sec \phi_j$ 

$$P_{10} = \begin{bmatrix} 0 & 1 & & & & & \\ 1 & 0 & & & & & \\ & & 0 & 1 & & & \\ & & & 1 & 0 & & \\ & & & & 1 & 0 & \\ & & & & & 0 & 1 \\ & & & & & & 1 & 0 \\ & & & & & & 0 & 1 \\ & & & & & & 1 & 0 \end{bmatrix}$$

$$(60)$$

In this paper we show that in general C and P can be calculated from the known wave functions using appropriate excession (for any matrix size (NxN);N=2,3,4,...100,....10000,...). Further both C and P have the same eigenvalues  $\pm 1$ . In general both are not trace less operators. Interestingly P is always a real operator where as C, C may be complex or real-complex depending upon the nature of matrix size. C can also be calculated following the literature C. Lastly we believe a simple procedure is required in view of its interesting applications C.
