# HILBERT SCHEMES, COMMUTING MATRICES, AND HYPERKÄHLER GEOMETRY

#### Abstract

We represent algebraic curves via commuting matrix polynomials. This allows us to show that the Hilbert scheme of cohomologically stable nonplanar curves of genus 0 and degree $d$ in $\mathbb{P}^{3} \backslash \mathbb{P}^{1}$ is isomorphic to a complexified hyperkähler quotient of an open subset of a vector space by a nonreductive Lie group.


It has been observed in [4] that the Hilbert scheme of real cohomologically stable (i.e. satisfying $h^{0}(\mathcal{N}(-2))=0$ ) nonplanar curves of fixed genus and degree in $\mathbb{P}^{3}$, not intersecting a fixed real line, carries a natural pseudo-hyperkähler structure. Here "real" means invariant under a fixed point free antilinear involution of $\mathbb{P}^{3}$. In the case of $g=0$ and $d=3$ this pseudo-hyperkähler structure was shown in [4] to be flat, and in fact, the manifold of cohomologically stable pure-dimensional Cohen-Macaulay nonplanar curves in $\mathbb{P}^{3} \backslash \mathbb{P}^{1}$ with Hilbert polynomial $3 n+1$ with its natural complexified hyperkähler structure was shown there to be isomorphic to $\mathbb{C}^{12} \simeq \mathbb{C}^{3} \otimes \operatorname{Mat}_{2 \times 2}(\mathbb{C})$. The proof of this relies on such curves being ACM and so clearly different methods are needed to study the pseudo-hyperkähler geometry of the corresponding open subset of $\mathrm{Hilb}_{d, g}$ for other values of $d$ and $g$.

In the present article we present such a method via a correspondence between algebraic curves equipped with a flat projection onto $\mathbb{P}^{1}$ and commuting matrix polynomials. This correspondence allows us to describe the locus of cohomologically stable nonplanar curves of arithmetic genus 0 and degree $d$ in $\mathbb{P}^{3} \backslash \mathbb{P}^{1}$ as a complexified hyperkähler quotient of (an open subset of) a vector space by a nonreductive Lie group (Theorem 5.6). Formally, our moment map equations are very similar to the complex ADHM equations used by Frenkel and Jardim [10] in their construction of admissible torsion-free sheaves on $\mathbb{P}^{3}$. The main difference is that the Lie group acting on solutions is no longer reductive.

Restricting this description to real curves, we obtain the above pseudo-hyperkähler structure for $g=0$ and any odd $d$ (for even $d$ there are no real rational curves in the above sense) as a hyperkähler quotient of an open subset of a flat quaternionic vector space by a nonreductive Lie group. There is also an analogous description of the natural hypersymplectic structure on cohomologically stable nonplanar curves of genus 0 and any degree which are invariant under an antilinear involution of $\mathbb{P}^{3}$, the fixed point set of which is $\mathbb{R} \mathbb{P}^{3}$.

We briefly describe the structure and the content of the paper. In the next section we provide alternative (to the one given by Nakajima [22]) descriptions of the Hilbert scheme $\left(\mathbb{C}^{2}\right)^{[n]}$ and of its open subset of non-collinear points. In $\S 2$ we discuss the above-mentioned correspondence between algebraic curves and commuting matrix polynomials. In $\S 3$ we restrict our attention to space curves, and show

[^0]how to construct a twistor space $Z_{d} \rightarrow \mathbb{P}^{1}$, the sections of which can be identified with either a) algebraic curves of fixed degree, or b) equivalence classes of certain commuting pairs of polynomials. Section 4 discusses complexified hyperkähler and hypercomplex structures and their quotients. Finally, in $\S 5$ we apply these ideas and results to genus 0 space curves and show that in this case the description b) of sections of $Z_{d}$ is equivalent to a complexified hyperkähler quotient.

Remark 0.1. Throughout the paper a curve means a projective Cohen-Macaulay scheme of pure dimension 1.

## 1. Hilbert schemes of points in $\mathbb{C}^{2}$ and commuting matrices

We begin with the following easy observation (cf. [22] if $k=2$ and [16, Thm. 2.5] for general $k$ ):

Proposition 1.1. There exists a natural set-theoretic bijection between the Hilbert scheme $\left(\mathbb{C}^{k}\right)^{[n]}$ of $n$ points in $\mathbb{C}^{k}$ and $G L(n, \mathbb{C})$-orbits of $k$-tuples $\left(A_{1}, \ldots, A_{k}\right)$ of $n \times n$ matrices such that $\mathbb{C}\left[A_{1}, \ldots, A_{k}\right]$ is an $n$-dimensional commutative algebra which is conjugate to its image in $\operatorname{End}\left(\mathbb{C}^{n}\right)$ under the regular representation.

Proof. A point in the Hilbert scheme $\left(\mathbb{C}^{k}\right)^{[n]}$ is defined by an ideal $I \subset \mathbb{C}\left[z_{1}, \ldots, z_{k}\right]$ of length $n$, i.e. such that $\operatorname{dim} \mathbb{C}\left[z_{1}, \ldots, z_{k}\right] / I=n$. Multiplication by $z_{i}, i=$ $1, \ldots, k$, defines an endomorphism $A_{i}$ of $\mathbb{C}\left[z_{1}, \ldots, z_{k}\right] / I$. Clearly the $A_{i}$ commute and $\operatorname{dim} \mathbb{C}\left[A_{1}, \ldots, A_{k}\right]=\operatorname{dim} \mathbb{C}\left[z_{1}, \ldots, z_{k}\right] / I=n$. Moreover, directly from the construction, $\mathbb{C}\left[A_{1}, \ldots, A_{k}\right]$ is conjugate to its image under the regular representation. Conversely, given $k$ commuting matrices $A_{1}, \ldots, A_{k}$ with $\operatorname{dim} \mathbb{C}\left[A_{1}, \ldots, A_{k}\right]=n$ we define a homomorphism $\mathbb{C}\left[z_{1}, \ldots, z_{k}\right] \rightarrow \mathbb{C}^{n} \simeq \mathbb{C}\left[A_{1}, \ldots, A_{k}\right]$ via $p\left(z_{1}, \ldots, z_{k}\right) \mapsto$ $p\left(A_{1}, \ldots, A_{k}\right)$. Clearly it is surjective and its kernel is an ideal of length $n$. Moreover this ideal does not change under simultaneous conjugation of $A_{1}, \ldots, A_{k}$, and so we obtain a well-defined point of $\left(\mathbb{C}^{k}\right)^{[n]}$. Since we assume that $\mathbb{C}\left[A_{1}, \ldots, A_{k}\right]$ is conjugate to its image under the regular representation, the two maps are inverse to each other.

Remark 1.2. The condition that the algebra $\mathcal{A}=\mathbb{C}\left[A_{1}, \ldots, A_{k}\right]$ is conjugate to its image under the regular representation is equivalent to the existence of a cyclic vector for $\mathcal{A}$. This is the same argument as in [22, p.8]. Also, the set of $k$-tuples $\left(A_{1}, \ldots, A_{k}\right)$ of commuting $n \times n$ matrices with $\operatorname{dim} \mathbb{C}\left[A_{1}, \ldots, A_{k}\right]=n$ and having a cyclic vector is open in the set of all commuting $k$-tuples. Indeed, due to the Cayley-Hamilton theorem, any element of $\mathbb{C}\left[A_{1}, \ldots, A_{k}\right]$ belongs to the linear span of $A_{1}^{i_{1}} \ldots A_{k}^{i_{k}}$ for $i_{1}, \ldots, i_{k} \leq n-1$. Thus the condition of not having cyclic vector is equivalent to $\operatorname{dim}\left\langle A_{1}^{i_{1}} \ldots A_{k}^{i_{k}} v ; i_{1}, \ldots, i_{k} \leq n-1\right\rangle \leq n-1$ for any $v$. This is a closed condition.

Henni and Jardim show that the quotient of the variety of $k$ commuting matrices together with a choice of a cyclic vector by $G L(n, \mathbb{C})$ is a geometric quotient [16, $\S 2]$, and that the resulting scheme is isomorphic to $\left(\mathbb{C}^{k}\right)^{[n]}[16$, Cor. 4.9]. For $k=2$, these results are due to Nakajima [22, §1.2].

We shall now modify this description of $\left(\mathbb{C}^{2}\right)^{[n]}$ in several ways. First of all, we shall want to eliminate the dependence on a cyclic vector. We recall the following theorem of Neubauer and Saltman [23]:

Theorem 1.3 (Neubauer-Saltman). Let $A$ and $B$ be two commuting $n \times n$ matrices. Then the following conditions are equivalent:
(1) $\operatorname{dim} \mathbb{C}[A, B]=n$.
(2) $\operatorname{dim} Z(A, B)=n$, where $Z(A, B)$ is the centraliser of the pair $(A, B)$.
(3) $(A, B)$ is a nonsingular point of the variety of commuting matrices.

The equivalence between (1) and (2) will be used repeatedly throughout the paper.

Let us write $M_{n}$ for the variety of pairs of commuting $n \times n$ matrices and define

M_{n}^{0}=\left\{(A, B) ; A, B \in \operatorname{Mat}_{n \times n}(\mathbb{C}), \quad[A, B]=0, \operatorname{dim} Z(A, B)=n\right\}
$$

and its open subset $M_{n}^{\text {reg }}$ consisting of those $(A, B) \in M_{n}^{0}$ for which $\mathbb{C}[A, B]$ is conjugate to its image in $\operatorname{Mat}_{n \times n}(\mathbb{C})$ under the regular representation.
Proposition 1.4. $\left(\mathbb{C}^{2}\right)^{[n]}$ is the geometric quotient of $M_{n}^{\mathrm{reg}}$ by $G L(n, \mathbb{C})$.
Proof. It is the matter of checking the conditions that a geometric quotient has to satisfy [21, Def. 0.6]. The only one which perhaps requires an argument is that the structure sheaf of $\left(\mathbb{C}^{2}\right)^{[n]}$ is equal to the $G L(n, \mathbb{C})$-invariant part of the structure
 isomorphic to the geometric quotient of the (smooth) variety

\tilde{H}_{n}=\{(A, B, v) ;[A, B]=0, v \text { is a cyclic vector for }(A, B)\}
$$

by the (free) action of $G L(n, \mathbb{C})$. Hence $\mathcal{O}_{\left(\mathbb{C}^{2}\right)^{[n]}}=\left(\mathcal{O}_{\tilde{H}_{n}}\right)^{G L(n, \mathbb{C})}$.
We have the natural forgetful map $p: \tilde{H}_{n} \rightarrow M_{n}^{\text {reg }},(A, B, v) \mapsto(A, B)$, and the proof of Theorem 1.9 in [22] shows that $p$ is a submersion. Observe now that the fibre $p^{-1}(A, B)$ is isomorphic to the stabiliser of $(A, B)$ in $G L(n, \mathbb{C})$. Indeed, the stabiliser is $n$-dimensional and it acts freely on the fibre. Since, owing to Proposition 1.1, the projection $\tilde{H}_{n} \rightarrow\left(\mathbb{C}^{2}\right)^{[n]}$ factors (set-theoretically) through $M_{n}^{\text {reg }}$, the action of the stabiliser on the fibre must be transitive. Therefore, for any open subset $U \subset M_{n}^{\mathrm{reg}}, \mathcal{O}(U)^{G L(n, \mathbb{C})}=\mathcal{O}\left(p^{-1}(U)\right)^{G L(n, \mathbb{C})}$, and so $\mathcal{O}_{M_{n}^{\mathrm{reg}}}=\left(\mathcal{O}_{\tilde{H}_{n}}\right)^{G L(n, \mathbb{C})}$.

We shall now present another description of $\left(\mathbb{C}^{2}\right)^{[n]}$ : as a symplectic quotient of an open dense subset of pairs of matrices by a nonreductive group. The relevant subset $K_{n}$ consists of pairs $(A, B)$ of $n \times n$ matrices, such that the vector $e_{1}=$ $(1,0, \ldots, 0)^{T}$ is cyclic for the pair $A, B$. The group $G$ is the subgroup of $G L(n, \mathbb{C})$ preserving the cyclic vector $e_{1}$, i.e. the first column of elements of $G$ is equal to $e_{1}$. The symplectic form on $K_{n}$ is $\operatorname{tr} d A \wedge d B$, and the corresponding moment map $\mu: K_{n} \rightarrow \mathfrak{g}^{*}$ is the projection of $[A, B]$ onto the last $n-1$ rows.

Theorem 1.5. The action of $G$ on $\mu^{-1}(0) \subset K_{n}$ is free and proper, and the symplectic quotient $\mu^{-1}(0) / G$ is biholomorphic to $\left(\mathbb{C}^{2}\right)^{[n]}$.

Proof. First of all, we claim that $\mu(A, B)=0$ implies $[A, B]=0$. Indeed, $\mu(A, B)=$ 0 means that $[A, B]$ can have nonzero entries only in the first row. Suppose that $[A, B] \neq 0$. Then $\operatorname{Im}[A, B]=\left\langle e_{1}\right\rangle$ is a 1-dimensional subspace which is cyclic for $(A, B)$. On the other hand, according to [13] (see also [9, Lemma 12.7] for a simple proof) $A$ and $B$ can be simultaneously conjugated into upper-triangular matrices. But then any vector in $\operatorname{Im}[A, B]$ has the last coordinate equal to zero and since no such vector can be cyclic for a pair of upper-triangular matrices, we obtain a contradiction. Hence $[A, B]=0$.

The action of $G$ on $\mu^{-1}(0)$ is free, since the action of $G L(n, \mathbb{C})$ on $\tilde{H}_{n}$ is free. This implies, in particular, that $\mu^{-1}(0)$ is smooth. To show that the action of $G$ on $\mu^{-1}(0)$ is proper it is enough to show that the action of $G L(n, \mathbb{C})$ on $\tilde{H}_{n}$ is proper, since $K_{n}$ is closed in $\tilde{H}_{n}$ and $G$ is closed in $G L(n, \mathbb{C})$. The properness of the $G L(n, \mathbb{C})$ on $\tilde{H}_{n}$ is equivalent to $\tilde{H}_{n}$ being a principal $G L(n, \mathbb{C})$-bundle over $\left(\mathbb{C}^{2}\right)^{[n]}$. Nakajima [22, Theorem $3.24 \&$ Cor. 3.42] shows that $\left(\mathbb{C}^{2}\right)^{[n]}$ is a (real) symplectic quotient $\nu^{-1}(c) / U(n)$ of $\tilde{H}_{n}$, where $\nu$ denotes the moment map. Since $U(n)$ is compact, $\nu^{-1}(c)$ is a principal $U(n)$-bundle over $\left(\mathbb{C}^{2}\right)^{[n]}$. This means that $\nu^{-1}(c) \rightarrow\left(\mathbb{C}^{2}\right)^{[n]}$ admits local sections. Such a local section gives a local section of $\tilde{H}_{n} \rightarrow\left(\mathbb{C}^{2}\right)^{[n]}$, and, consequently, $\tilde{H}_{n}$ is a principal $G L(n, \mathbb{C})$-bundle over $\left(\mathbb{C}^{2}\right)^{[n]}$. As explained above, this implies that the action of $G$ on $\mu^{-1}(0)$ is proper. It follows that $\mu^{-1}(0) / G$ is a complex manifold [7, Ch.III, Prop.10], biholomorphic to $\tilde{H}_{n} / G L(n, \mathbb{C})$.
1.1. $\left(\mathbb{C}^{2}\right)^{[n]}$ and torsion-free sheaves on $\mathbb{P}^{2}$. We shall now give a description of an open subset of $\left(\mathbb{C}^{2}\right)^{[n]}$ consisting of 0-dimensional subschemes not contained in any line (thus, necessarily, $n \geq 3$ ). It is closely related to the description of the moduli space $\mathcal{M}(2, n-1)$ of framed torsion-free sheaves on $\mathbb{P}^{2}$ of rank 2 and $c_{2}=n-1$ in terms of the ADHM equations [22, Theorem 2.1]. In order to simplify the notation, set $k=n-1$. The moduli space $\mathcal{M}(2, k)$ is biholomorphic to the $G L(k, \mathbb{C})$-quotient of the set $U$ of stable solutions to the equation

$$
\begin{equation*}
[X, Y]+i j=0, \quad X, Y \in \operatorname{Mat}_{k, k}(\mathbb{C}), \quad i \in \operatorname{Mat}_{k, 2}(\mathbb{C}), \quad j \in \operatorname{Mat}_{2, k}(\mathbb{C}) \tag{1.1}
\end{equation*}
$$

Here a quadruple $(X, Y, i, j)$ is called stable if there is no proper subspace $S$ of $\mathbb{C}^{k}$ such that $\operatorname{Im} i \subset S, X S \subset S, Y S \subset S$, and the framing of a sheaf $\mathcal{F}$ is a trivialisation on the line $l_{\infty} \subset \mathbb{P}^{2}$ (in particular $c_{1}=0$ ).

Lemma 1.6. Let $\mathcal{F} \in \mathcal{M}(2, k)$. The following conditions are equivalent:
(i) the rank of $i$ is equal to 1 ;
(ii) $H^{0}\left(\mathbb{P}^{2}, \mathcal{F}\right) \neq 0$;
(iii) $\mathcal{F}$ is an extension of the form $0 \rightarrow \mathcal{O}_{\mathbb{P}^{2}} \rightarrow \mathcal{F} \rightarrow \mathcal{I}_{Z} \rightarrow 0$, where $\mathcal{I}_{Z}$ is the ideal sheaf of $Z \in\left(\mathbb{P}^{2} \backslash l_{\infty}\right)^{[k]}$.

Proof. Given $c_{2}(\mathcal{F})=k$, the conditions (ii) and (iii) are clearly equivalent. We prove the equivalence of (i) and (iii). If $i$ has rank 1 , then $i j=i_{0}\left(\alpha_{1} j_{1}+\alpha_{2} j_{2}\right)$ for some $i_{0} \in \mathbb{C}^{k}, \alpha_{1}, \alpha_{2} \in \mathbb{C}$, where $j_{1}, j_{2}$ are the two rows of $j$. Equation (1.1) implies that $[X, Y]$ has rank 1, and therefore $\alpha_{1} j_{1}+\alpha_{2} j_{2}=0$ [22, Prop. 2.8]. Thus $j$ has also rank 1 and we can write $\mathbb{C}^{2} \simeq W_{1} \oplus W_{2}$, where $W_{1}=\operatorname{Im} j=\operatorname{Ker} i$. The sheaf $\mathcal{F}$ is then isomorphic to $\operatorname{Ker} b / \operatorname{Im} a$, where $(a, b)$ is the monad given on p. 23 in 22. The embedding $W_{1} \otimes \mathcal{O}_{\mathbb{P}^{2}} \hookrightarrow \operatorname{Ker} b$ induces an injective morphism $\mathcal{O}_{\mathbb{P}^{2}} \rightarrow \mathcal{F}$. Its cokernel is the sheaf obtained from the monad with $W$ replaced by
$W_{2}$ and $j=0$. This is a rank one framed torsion free sheaf with $c_{2}=k$, i.e. the ideal sheaf of a $Z \in\left(\mathbb{P}^{2} \backslash l_{\infty}\right)^{[k]}$. Conversely, given $\mathcal{F}$ as in the statement, we obtain from $\mathcal{I}_{Z}$ a stable solution $\left(X, Y, i_{0}, 0\right)$ to the ADHM equation with $i_{0} \in \mathbb{C}^{k}$. Let $j_{0}^{T}$ be the extension class of $\mathcal{F}$ in $\operatorname{Ext}^{1}\left(\mathcal{I}_{Z}, \mathcal{O}_{\mathbb{P}^{2}}\right) \simeq \mathbb{C}^{k}$. Then $(X, Y, i \oplus 0,0 \oplus j)$ is a solution to the ADHM equation which yields (the isomorphism class of) $\mathcal{F}$.

We denote by $\mathcal{M}(2, k)^{\circ}$ the complement of the (isomorphism classes of) sheaves described in this lemma. If $(X, Y, i, j)$ is the ADHM-data corresponding to a point in $\mathcal{M}(2, k)^{\circ}$, then $i$ has rank 2 and we can use the action of $G L(k, \mathbb{C})$ to fix $i$ to be

$$
i=\left(\begin{array}{lllll}
1 & 0 & 0 & \ldots & 0  \tag{1.2}\\
0 & 1 & 0 & \ldots & 0
\end{array}\right)^{T}
$$

The stabiliser $G_{0}$ of $i$ consists of matrices of the form

$$
\left(\begin{array}{cc}
1_{2 \times 2} & * \\
0 & *
\end{array}\right)
$$

and $\mathcal{M}(2, k)^{\circ}$ is also biholomorphic to the quotient of the space $U_{0}$ of such $(X, Y, i, j)$ by $G_{0}$. Here "quotient" means that $U_{0}$ is a principal $G_{0}$-bundle over $\mathcal{M}(2, k)^{\mathrm{o}}$. Indeed, a well-known description of $\mathcal{M}(2, k)$ as a hyperkähler quotient means that $U$ is a principal $G L(k, \mathbb{C})$-bundle over $\mathcal{M}(2, k)$ (cf. the proof of Theorem (1.5) and, consequently, the action of $G L(k, \mathbb{C})$ on $U$ is free and proper. This implies that the action of $G_{0}$ on $U_{0}$ is also free and proper, so that $U_{0}$ is a principal $G_{0}$-bundle over $\mathcal{M}(2, k)^{\circ}$. In fact, $j$ is now superfluous: it is simply given by the first two rows of $[X, Y]$. Equation (1.1) is now equivalent to the last $k-2$ rows of $[X, Y]$ being identically zero. Since the projection onto the last $k-2$ rows is precisely the moment map $\mu$ for the action of $G_{0}$ on pairs of matrices $X, Y$ with respect to the symplectic form $\operatorname{tr} d X \wedge d Y$, we conclude:

Proposition 1.7. Let $V^{\mathrm{s}}$ be the set of pairs $(X, Y) \in \operatorname{Mat}_{k, k}(\mathbb{C})^{2}$ such that $(X, Y, i)$ is stabl ${ }^{1}$, where $i$ is given by (1.2). The group $G_{0}$ acts freely and properly on $\mu^{-1}(0) \subset V^{\mathrm{s}}$ and the symplectic quotient $\mu^{-1}(0) / G_{0}$ is biholomorphic to $\mathcal{M}(2, k)^{\mathrm{o}}$.

Remark 1.8. Clearly, there is an analogous description of an open dense subset of $\mathcal{M}(r, k)$ for sheaves of higher rank $r$.

Given a quadruple ( $X, Y, i, j$ ) (not necessarily satisfying (1.1) or (1.2) ), we define a pair of $(k+1) \times(k+1)$-matrices as follows (cf. [5]):

\hat{X}=\left(\begin{array}{cc}
0 & -j_{2}  \tag{1.3}\\
i_{1} & X
\end{array}\right), \quad \hat{Y}=\left(\begin{array}{cc}
0 & j_{1} \\
i_{2} & Y
\end{array}\right)
$$

where $i_{s}$ (resp. $j_{s}$ ) denotes the $s$-th column (resp. $s$-th row) of $i$ (resp. of $j$ ).
Lemma 1.9. ( $X, Y, i, j)$ satisfies (1.1) if and only if $[\hat{X}, \hat{Y}]$ has nonzero entries only in the first row or the first column. Moreover $(X, Y, i, j)$ is stable if and only if $e_{1}$ is cyclic for $(\hat{X}, \hat{Y})$.

Proof. The first statement is obvious. For the second one, observe that if $S$ is a destabilising subspace for $(X, Y, i, j)$, then $S \oplus\left\langle e_{1}\right\rangle$ is invariant for $(\hat{X}, \hat{Y})$. Conversely, suppose that $\hat{S}$ contains $e_{1}$ and is invariant for $(\hat{X}, \hat{Y})$. Let $p: \mathbb{C}^{k+1} \rightarrow \mathbb{C}^{k}=$

[^1]$\mathbb{C}^{k+1} /\left\langle e_{1}\right\rangle$ be the projection and set $S=p(\hat{S})$. Then $i_{1}=p\left(\hat{X} e_{1}\right), i_{2}=p\left(\hat{Y} e_{1}\right)$ belong to $S$. Moreover, if $v \in S$, then there is an $\alpha \in \mathbb{C}$ such that $\alpha e_{1}+v \in \hat{S}$. Since
$$
\hat{X}\left(\alpha e_{1}+v\right)=\alpha i_{1}+X v \quad \bmod \left\langle e_{1}\right\rangle
$$
and similarly for $Y$, it follows that $X S \subset S$ and $Y S \subset S$. Therefore $S$ is a destabilising subspace for $(X, Y, i, j)$.

We now fix $i$ to be (1.2). Let $\hat{G}_{0}$ denote the subgroup of $G L(k+1, \mathbb{C})$, consisting of matrices of the form

$$
\left(\begin{array}{ll}
1 & u \\
0 & h
\end{array}\right), \quad h \in G_{0}, \quad u_{1}=u_{2}=0
$$

i.e. matrices, the first 3 columns of which are $\left(e_{1}, e_{2}, e_{3}\right) . \hat{G}_{0}$ is a semidirect product of $G_{0}$ and $\mathbb{C}^{k-2}$. Its action by conjugation on $\hat{X}, \hat{Y}$ defined in (1.3) is given by

$$
\hat{X} \mapsto\left(\begin{array}{cc}
0 & -j_{2} h^{-1}+u X h^{-1} \\
i_{1} & -i_{1} u h^{-1}+h X h^{-1}
\end{array}\right), \quad \hat{Y} \mapsto\left(\begin{array}{cc}
0 & j_{1} h^{-1}+u Y h^{-1} \\
i_{2} & -i_{2} u h^{-1}+h Y h^{-1}
\end{array}\right) .
$$

This means that $\hat{G}_{0}$ acts on pairs of matrices $X, Y$ via

$$
\begin{equation*}
(X, Y) \mapsto\left(-i_{1} u h^{-1}+h X h^{-1},-i_{2} u h^{-1}+h Y h^{-1}\right) \tag{1.4}
\end{equation*}
$$

Owing to Lemma 1.9, $\hat{G}_{0}$ preserves $V^{\mathrm{s}}$ of Proposition 1.7.
We consider the following codimension 2 subset of $V^{\mathrm{s}}$ :

$$
V_{0}^{\mathrm{s}}=\left\{(X, Y) \in V^{\mathrm{s}} ; X_{12}=Y_{11}, \quad X_{22}=Y_{21}\right\}
$$

It is $\hat{G}^{0}$-invariant and the restriction of the symplectic form $\operatorname{tr} d X \wedge d Y$ to $V_{0}^{\text {s }}$ is nondegenerate.

Theorem 1.10. Let $\hat{\mu}$ denote the moment map for the action of $\hat{G}^{0}$ on $V_{0}^{\mathrm{s}}$. The action of $\hat{G}^{0}$ on $\hat{\mu}^{-1}(0)$ is free and proper and the symplectic quotient $\hat{\mu}^{-1}(0) / \hat{G}_{0}$ is biholomorphic to the open subset of $\left(\mathbb{C}^{2}\right)^{[k+1]}$ consisting of 0 -dimensional subschemes not contained in any line.

Proof. The moment map for the action of $\hat{G}_{0} \simeq G_{0} \ltimes \mathbb{C}^{k-2}$ is equal to $\hat{\mu}(X, Y)=$ $(\mu(X, Y), \alpha(X, Y))$, where

$$
\alpha(X, Y)=\left(X_{32}-Y_{31}, \ldots, X_{k 2}-Y_{k 1}\right)^{T}
$$

Thus, given the definition of $V_{0}^{\mathrm{s}}$, the condition $\alpha(X, Y)=0$ means that the first column of $Y$ is equal to the second column of $X$. This in turn implies that the first column of $[\hat{X}, \hat{Y}]$ is equal to 0 . On the other hand $\mu(X, Y)=0$ means that the last $k-2$ rows of $[X, Y]$ are zero. If we now take $j_{1}$ to be the first row of $[Y, X]$ and $j_{2}$ the second row of $[X, Y]$, then $[\hat{X}, \hat{Y}]$ has nonzero entries only in the first row. The argument in the proof of Theorem 1.5 together with Lemma 1.9 imply that $[\hat{X}, \hat{Y}]=0$. Let $K_{k+1}^{0}$ be the set of pairs $(A, B) \in \operatorname{Mat}_{k+1, k+1}(\mathbb{C})^{2}$ such that $e_{1}$ is cyclic for $(A, B)$, the first column of $A$ is equal to $e_{2}$, and the first column of $B$ is equal to $e_{3}$. The above discussion shows that the map $V_{0}^{\mathrm{s}} \rightarrow K_{k+1}^{0}$, sending $(X, Y)$ to the matrices $\hat{X}, \hat{Y}$ defined above, restricts to a $\hat{G}_{0}$-equivariant isomorphism between $\hat{\mu}^{-1}(0)$ and $T=\left\{[A, B] \in K_{k+1}^{0} ;[A, B]=0\right\}$. The action of $\hat{G}_{0}$ on $T$ is free and proper, owing to the same argument as in the proof of Theorem 1.5. It remains to show that $T / \hat{G}_{0}$ is biholomorphic to the open subset of $\left(\mathbb{C}^{2}\right)^{[k+1]}$ consisting of 0-dimensional subschemes not contained in any line.

Let $H^{0} \subset\left(\mathbb{C}^{2}\right)^{[k+1]}$ be the set of 0-dimensional subschemes not contained in any line. If $D \in H^{0}$ has ideal $I$, then $1, z_{1}, z_{2}$ are linearly independent elements of $\mathbb{C}\left[z_{1}, z_{2}\right] / I$. Therefore we can choose a basis $\mathbb{C}\left[z_{1}, z_{2}\right] / I$ such that $1, z_{1}, z_{2}$ are its first 3 elements. This means that the resulting commuting matrices $A, B$ belong to $K_{n}^{0}$. The group preserving $K_{n}^{0} \subset K_{n}$ is precisely $\hat{G}_{0}$, so that $H^{0} \subset T / \hat{G}_{0}$. Conversely, let $D$ be a 0-dimensional subscheme of $\mathbb{C}^{2}$ represented by an element of $T / \hat{G}_{0}$. The ideal of $D$ is given by polynomials $p\left(z_{1}, z_{2}\right)$ vanishing on $(A, B)$. Given the form of the first column of $A$ and of $B$, no linear polynomial vanishes on $(A, B)$.

## 2. Curves and commuting matrices

We now wish to describe a correspondence between finite coverings of $\mathbb{P}^{1}$ and certain commuting matrix polynomials.
2.1. Flat projections. Let $C$ be a connected curve (cf. Remark 0.1) of arithmetic genus $g$ and $\pi: C \rightarrow \mathbb{P}^{1}$ a flat projection of degree $d$. We consider the sheaf of algebras $\pi_{*} \mathcal{O}_{C}$. As a sheaf of $\mathcal{O}_{\mathbb{P}^{1}}$-modules it is locally free, i.e. a vector bundle of rank $d$, which we denote by $E_{\pi}$. It has a trivial summand and all remaining summands have a negative degree. Moreover the degree of $E_{\pi}$ is equal to $-(d+g-1)$ (since $\left.\chi\left(E_{\pi}\right)=\chi\left(\mathcal{O}_{C}\right)=1-g\right)$. Consider now the regular representation of $\pi_{*} \mathcal{O}_{C}$ on itself. It gives a global injective morphism $\pi_{*} \mathcal{O}_{C} \rightarrow \mathcal{E} n d\left(E_{\pi}\right)$, i.e. a global section of $\mathcal{E} n d\left(E_{\pi}\right) \otimes E_{\pi}^{*}$. Suppose that

$$
\begin{equation*}
E_{\pi} \simeq \bigoplus_{i=1}^{d} \mathcal{O}_{\mathbb{P}^{1}}\left(-k_{i}\right), \tag{2.1}
\end{equation*}
$$

where $0=k_{1}<k_{2} \leq \cdots \leq k_{d-1}$. Then a global section of $\mathcal{E} n d\left(E_{\pi}\right) \otimes E_{\pi}^{*}$ corresponds to $d d \times d$ matrices $A_{1}, \ldots, A_{d}$ of polynomials in one variable with $A_{1}=1$ and the $(i, j)$ entry of $A_{l}$ having degree $k_{j}-k_{i}+k_{l}$. Moreover these matrices commute, since $\mathcal{O}_{C}$ is commutative. Finally, since each stalk of $\pi_{*} \mathcal{O}_{C}$ is a $d$-dimensional algebra, we have $\operatorname{dim} \mathbb{C}\left[A_{2}(t), \ldots, A_{d}(t)\right]=d$ for each $t$. Clearly the freedom in choosing the matrices $A_{l}$ is equivalent to the choice of the isomorphism (2.1).

Conversely, let $R$ be such a $d$-dimensional commutative subalgebra of $\operatorname{Mat}_{d \times d}(\mathbb{C}[t])$ with identity. Then $R$ is integral over $\mathbb{C}[t]$. Consider the matrices $A_{l}^{\prime}$ over $\mathbb{C}[1 / t]$ obtained by conjugating $A_{l}$ by $\operatorname{diag}\left(t^{k_{1}}, \ldots, t^{k_{d}}\right)$ and dividing by $t^{k_{l}}$. We obtain a commutative ring $R^{\prime}$, integral over $\mathbb{C}[1 / t]$. The affine curves $\operatorname{Spec} R$ and Spec $R^{\prime}$ have an obvious gluing and we obtain a curve $C$ together with a projection $C \rightarrow \mathbb{P}^{1}=\operatorname{Spec} \mathbb{C}[t] \cup \operatorname{Spec} \mathbb{C}[1 / t]$. Each fibre $C_{t}$ is a 0 -dimensional scheme of length $d$ and so the projection $C \rightarrow \mathbb{P}^{1}$ is flat. It is clear that the constructions are inverse to each other.

Proposition 2.1. There exists a natural $1-1$ correspondence between:
(A) connected curves $C$ with a flat projection $\pi$ of degree $d$ onto $\mathbb{P}^{1}$ and a fixed isomorphism

$$
\pi_{*} \mathcal{O}_{C} \simeq \mathcal{O}_{\mathbb{P}^{1}} \oplus \bigoplus_{i=2}^{d} \mathcal{O}_{\mathbb{P}^{1}}\left(-k_{i}\right)
$$

(B) $d$ - 1-tuples of commuting $d \times d$ matrix polynomials $A_{2}(t), \ldots, A_{d}(t)$ such that
(i) the first column of $A_{l}$ is the constant vector $e_{l}$;
(ii) the $(i, j)$ entry of $A_{l}$ has degree $k_{j}-k_{i}+k_{l}$;
(iii) $\operatorname{dim} \mathbb{C}\left[A_{2}(t), \ldots, A_{d}(t)\right]=d$ for any $t \in \mathbb{P}^{1}$.
2.2. Curves in projective spaces. Suppose now that $C$ is a connected curve of degree $d$ in $\mathbb{P}^{r} \backslash \mathbb{P}^{r-2}$, not contained in any hyperplane, and let the projection $\pi$ be the restriction of the projection

$$
\left[z_{1}, \ldots, z_{r+1}\right] \mapsto\left[z_{r}, z_{r+1}\right] .
$$

Each $z_{i}, i=1, \ldots, r-1$, defines a direct summand of $\pi_{*} \mathcal{O}_{C}$, isomorphic to $\mathcal{O}_{\mathbb{P}^{1}}(-1)$. Moreover, since $C$ is not contained in a hyperplane, these summands are linearly independent, and, consequently, $k_{2}=\cdots=k_{r}=1$ in (2.1). Since $\mathcal{O}_{C_{t}}$ is generated by $z_{1}, \ldots, z_{r-1}$, the matrices $A_{2}(t), \ldots, A_{r}(t)$ generate $\mathbb{C}\left[A_{2}(t), \ldots, A_{d}(t)\right]$ for each $t$. We conclude:
Proposition 2.2. There exists a natural 1-1 correspondence between:
(A) pairs $(C, \phi)$, where $C$ is a connected curve $C$ of degree d in $\mathbb{P}^{r} \backslash \mathbb{P}^{r-2}$ not contained in any hyperplane and such that the projection $\pi$ onto the complementary $\mathbb{P}^{1}$ is flat, while $\phi$ is a fixed isomorphism
and

$$
\pi_{*} \mathcal{O}_{C} \simeq \mathcal{O} \oplus \mathcal{O}(-1)^{\oplus r-1} \oplus \bigoplus_{i=r+1}^{d} \mathcal{O}\left(-k_{i}\right)
$$

(B) $(r-1)$-tuples of commuting $d \times d$ matrix polynomials $A_{2}(t), \ldots, A_{r}(t)$ such that
(i) the first column of $A_{l}$ is the constant vector $e_{l}, l=2, \ldots, r$;
(ii) the (ij)-entry of $A_{l}$ has degree $k_{j}-k_{i}+k_{l}$ (here $k_{1}=0$ and $k_{2}=\cdots=$ $k_{r}=1$ );
(iii) for any $t \in \mathbb{P}^{1}, \mathbb{C}\left[A_{2}(t), \ldots, A_{r}(t)\right]$ has dimension $d$ and is conjugate to its image in $\operatorname{End}\left(\mathbb{C}^{d}\right)$ under the regular representation.

Example 2.3. Let $C$ be a smooth curve of degree $r$ in $\mathbb{P}^{r} \backslash \mathbb{P}^{r-2}$. Such a curve is cut out by the $2 \times 2$ minors of a $2 \times r$ matrix of linear forms in homogeneous coordinates $z_{1}, \ldots, z_{r+1}$. Thus we obtain $\binom{r}{2}$ quadratic equations. Since we assume that the projection onto $\left[z_{r}, z_{r+1}\right.$ ] is flat, the matrix of coefficients of $z_{i} z_{j}, i, j \leq r-1$, is invertible and we can write the equations in affine coordinates $t=z_{r} / z_{r+1}$, $x_{i}=z_{i} / z_{r+1}, i \leq r-1$, as

$$
x_{i} x_{j}=\sum_{k=1}^{r-1} a_{i j}^{k}(t) x_{k}+b_{i j}(t), \quad i, j=1, \ldots r-1
$$

where $a_{i j}$ are linear in $t$ and $b_{i j}$ is quadratic in $t$. It follows that the commuting matrices $A_{2}(t), \ldots, A_{r}(t)$ are given by

$$
A_{l}(t)=\left(\begin{array}{cccc}
0 & b_{l 1}(t) & \ldots & b_{l, r-1}(t) \\
0 & a_{l 1}^{1}(t) & \ldots & a_{l, r-1}^{1}(t) \\
\vdots & \vdots & & \vdots \\
1 & a_{l 1}^{l}(t) & \ldots & a_{l, r-1}^{l}(t) \\
\vdots & \vdots & & \vdots \\
0 & a_{l 1}^{r-1}(t) & \ldots & a_{l, r-1}^{r-1}(t)
\end{array}\right) .
$$

Example 2.4. The correspondence in Proposition 2.2 commutes with projections. Thus, if $C$ is a curve of degree $d$ in $\mathbb{P}^{r} \backslash \mathbb{P}^{r-2}$ obtained by projection onto the first $r$ coordinates from a curve $\hat{C}$ in $\mathbb{P}^{n} \backslash \mathbb{P}^{n-2}$, then the matrix polynomials $A_{2}(t), \ldots, A_{r}(t)$ corresponding to the curve $C$ are simply the first $r-1$ matrix polynomials corresponding to the curve $\hat{C}$.
Example 2.5. Let $C$ be a rational curve of degree 4 in $\mathbb{P}^{3}$ parametrised by $\left[u^{3} v, v^{3} u, u^{4}, v^{4}\right]$. We can either use the previous example or proceeed directly as follows: if we set $x=z_{1} / z_{4}, y=z_{2} / z_{4}, t=z_{3} / z_{4}$, then the ideal of $C$ is generated by

$$
x y-t, t^{2} y-x^{3}, t y^{2}-x^{2}, y^{3}-x
$$

It follows that $\mathcal{O}\left(C_{t}\right)$ is spanned by $1, x, y, y^{2}$ for $t \neq \infty$ and by $1, x, y, x^{2}$ for $t \neq 0$. Computing the endomorphisms $x \cdot()$ and $y \cdot()$ gives:

$$
A=\left(\begin{array}{llll}
0 & 0 & t & 0 \\
1 & 0 & 0 & 0 \\
0 & 0 & 0 & t \\
0 & t & 0 & 0
\end{array}\right), \quad B=\left(\begin{array}{cccc}
0 & t & 0 & 0 \\
0 & 0 & 0 & 1 \\
1 & 0 & 0 & 0 \\
0 & 0 & 1 & 0
\end{array}\right)
$$

Example 2.6. Let $C$ a complete intersection of two quadrics in $\mathbb{P}^{3}$, given by equations $Q_{1}(x, y, t)=0, Q_{2}(x, y, t)=0$. Let $\tilde{Q}_{1}(x, y), \tilde{Q}_{2}(x, y)$ be the parts involving only $x, y$ and let $\tilde{Q}_{3}(x, y)$ be the quadratic polynomial in $x, y$ independent of $\tilde{Q}_{1}, \tilde{Q}_{2}$. Then $\mathcal{O}\left(C_{t}\right)$ is spanned by $1, x, y, \tilde{Q}_{3}$, and hence $E_{\pi} \simeq \mathcal{O}_{\mathbb{P}^{1}} \oplus \mathcal{O}_{\mathbb{P}^{1}}(-1) \oplus \mathcal{O}_{\mathbb{P}^{1}}(-1) \oplus$ $\mathcal{O}_{\mathbb{P}^{1}}(-2)$. In particular, the arithmetic genus of $C$ is 1 . Generically, such a $C$ is a smooth elliptic curve, but if $Q_{1}$ and $Q_{2}$ are two of the three quadrics defining a twisted cubic, then $C$ is the union of this cubic and a line, intersecting in two points.

## 3. Space curves

We consider the fibrewise Hilbert scheme $Z_{d}$ of $d$ points for the projection $\pi$ : $\mathbb{P}^{3} \backslash \mathbb{P}^{1} \rightarrow \mathbb{P}^{1}$ (see [1, Ch. 1, §7] for a definition and properties of relative Hilbert schemes). Locally, over an open subset $U$ of $\mathbb{P}^{1}$, it is just $U \times\left(\mathbb{C}^{2}\right)^{[d]}$. It is therefore a $(2 d+1)$-dimensional complex manifold with a holomorphic projection $p: Z_{d} \rightarrow \mathbb{P}^{1}$.
$Z_{d}$ satisfies the necessary conditions to be the twistor space of a pseudo-hyperkähler manifold (i.e. a pseudo-Riemannian manifold $M$ with a fibrewise action of quaternions on $T M$, parallel with respect to the Levi-Civita connection):
(i) it has an antiholomorphic involution $\sigma$ covering the antipodal map on $\mathbb{P}^{1}$, induced from the standard antiholomorphic involution on the total space of $\mathcal{O}_{\mathbb{P}^{1}}(1) \oplus \mathcal{O}_{\mathbb{P}^{1}}(1) \simeq \mathbb{P}^{3} \backslash \mathbb{P}^{1}$;
(ii) it has an $\mathcal{O}_{\mathbb{P}^{1}}(2)$-valued symplectic form $\omega$ along the fibres of $\pi$, again induced ${ }^{2}$ from the $\mathcal{O}_{\mathbb{P}^{1}}(2)$-valued fibrewise symplectic form on the total space of $\mathcal{O}_{\mathbb{P}^{1}}(1) \oplus \mathcal{O}_{\mathbb{P}^{1}}(1)$.
The pseudo-hyperkähler manifold is then the Kodaira moduli space of $\sigma$-invariant sections of $p$, the normal bundle of which splits as $\mathcal{O}_{\mathbb{P}^{1}}(1)^{\oplus 2 d}[18, \S 3(\mathrm{~F})]$.

### 3.1. Normal sheaf of space curves.

Proposition 3.1. There exists a natural isomorphism between an open subset of the Hilbert scheme of $\mathbb{P}^{3} \backslash \mathbb{P}^{1}$ consisting of degree $d$ curves which are flat over $\mathbb{P}^{1}$, and the Hilbert scheme of sections of $p: Z_{d} \rightarrow \mathbb{P}^{1}$.
Remark 3.2. The Hilbert scheme of curves of degree $d$ is the union of all components of $\operatorname{Hilb}\left(\mathbb{P}^{3} \backslash \mathbb{P}^{1}\right)$ which have the Hilbert polynomial of the form $h(n)=d n+c, c \in \mathbb{Z}$. The Hilbert scheme of sections of $p: Z_{d} \rightarrow \mathbb{P}^{1}$ is an open subscheme of $\operatorname{Hilb}\left(Z_{d}\right)$.
Proof. If $C$ is a degree $d$ curve in $\mathbb{P}^{3} \backslash \mathbb{P}^{1}$, flat over $\mathbb{P}^{1}$, then its scheme-theoretic intersection with each fibre of $\mathbb{P}^{3} \backslash \mathbb{P}^{1} \rightarrow \mathbb{P}^{1}$ yields a section of $Z_{d}$. The inverse map is defined as follows: given a section of $Z_{d}$, pullback the universal family over the relative Hilbert scheme $Z_{d}$ to $\mathbb{P}^{1}$. A flat family of curves $W$ in $\mathbb{P}^{3} \backslash \mathbb{P}^{1}$ parameterised by a scheme $T$ is sent to a flat family of sections of $p$ (viewed as a flat family of $\mathbb{P}^{1}$ 's in $Z_{d}$ ). Similarly, the inverse map sends a flat family of sections to a flat family of degree $d$ curves. The functorial interpretation of Hilbert schemes implies that both maps are morphisms of schemes.

We can relate the normal bundle $N_{s / Z_{d}}$ of a section to the normal sheaf $\mathcal{N}_{C / \mathbb{P}^{3}}$ of the corresponding curve as follows:

Lemma 3.3. $N_{s / Z_{d}} \simeq \pi_{*} \mathcal{N}_{C / \mathbb{P}^{3}}$.
Proof. The normal bundle of a section is isomorphic to the restriction of the vertical tangent bundle Ker $d p$ of $Z_{d}$ to the section. Since $Z_{d}$ is the fibrewise Hilbert scheme of points, the fibre of the vertical tangent bundle at $D \in Z_{d}$ is $H^{0}\left(D, \mathcal{N}_{D / F}\right)$, where $F \simeq \mathbb{C}^{2}$ is the fibre containing $D$. On the other hand the ideal of $D$ in $F$ is just $J_{C} \otimes \mathcal{O}_{F}$, where $J_{C}$ is the ideal of $C$ in $\mathbb{P}^{3}$. Thus $\mathcal{N}_{D / F}=\mathcal{N}_{C / \mathbb{P}^{3}} \otimes \mathcal{O}_{F}$, and hence the function $\mathbb{P}^{1} \ni z \rightarrow h^{0}\left(\pi^{-1}(z),\left.\mathcal{N}_{C / \mathbb{P}^{3}}\right|_{\pi^{-1}(z)}\right)$ is constant. It follows from a result of Grauert [14, Cor. III.12.9] that $\pi_{*} \mathcal{N}_{C / \mathbb{P}^{3}}$ is locally free. Therefore both $\pi_{*} \mathcal{N}_{C / \mathbb{P}^{3}}$ and $N_{s / Z_{d}}$ are vector bundles and the natural map $\pi_{*} \mathcal{N}_{C / \mathbb{P}^{3}} \rightarrow N_{s / Z_{d}}$ is an isomorphism on fibres.

Corollary 3.4. The normal sheaf of a Cohen-Macaulay curve in $\mathbb{P}^{3}$ is torsion-free.
Proof. We can find a projective line $l \subset \mathbb{P}^{3}$ such that the projection $\pi: C \rightarrow l$ is flat. Were $\mathcal{N}_{C / \mathbb{P}^{3}}$ not torsion free, neither would be $\pi_{*} \mathcal{N}_{C / \mathbb{P}^{3}}$, contradicting the above lemma.

Lemma 3.3 implies that the normal bundle of a section splits as $\mathcal{O}_{\mathbb{P}^{1}}(1)^{\oplus 2 d}$ if and only if $H^{*}\left(C, \mathcal{N}_{C / \mathbb{P}^{3}}(-2)\right)=0$. As mentioned at the beginning of the section, the parameter space of curves satisfying this condition has a natural complexified pseudo-hyperkähler structure and on its $\sigma$-invariant part a genuine pseudohyperkähler structure [4]. We now want to investigate this parameter space via commuting matrix polynomials.

If $E$ is a rank $d$ vector bundle on $\mathbb{P}^{1}$, we denote by $\mathcal{K}(E)$ the subsheaf of $\left(\mathcal{E} n d(E) \otimes \mathcal{O}_{\mathbb{P}^{1}}(1)\right)^{\oplus 2}$ defined by
$\mathcal{K}(E)(U)=\left\{(A(t), B(t)) \in\left(\mathcal{E} n d(E) \otimes \mathcal{O}_{\mathbb{P}^{1}}(1)\right)^{\oplus 2}(U) ; \forall_{t \in U} \quad(A(t), B(t)) \in M_{d}^{\mathrm{reg}}\right\}$.
We then denote by $K(E)$ the total space of $\mathcal{K}(E)$, i.e. the subset of the total space of $\left(\mathcal{E} n d(E) \otimes \mathcal{O}_{\mathbb{P}^{1}}(1)\right)^{\oplus 2}$ consisting of points through which passes a local section of $\mathcal{K}(E)$. Since $Z_{d}$ is the relative Hilbert scheme for the projection $\mathcal{O}_{\mathbb{P}^{1}}(1) \oplus \mathcal{O}_{\mathbb{P}^{1}}(1) \rightarrow$
$\mathbb{P}^{1}$, Proposition 1.4 implies that $Z_{d}$ is biholomorphic to the quotient of $K\left(\mathcal{O}_{\mathbb{P}^{1}}^{\oplus d}\right)$ by the fibrewise action of $G L(d, \mathbb{C})$. In fact we have:
Lemma 3.5. Let $E$ be a vector bundle of rank $d$ on $\mathbb{P}^{1}$. Then the quotient of $K(E)$ by the fibrewise action of $G L(d, \mathbb{C})$ is biholomorphic to $Z_{d}$.
Proof. Let $E \simeq \bigoplus \mathcal{O}_{\mathbb{P}^{1}}\left(\lambda_{i}\right)$. Then $\mathcal{E} n d(E) \otimes \mathcal{O}_{\mathbb{P}^{1}}(1)$ is isomorphic to two copies $\mathbb{C} \times$ $\operatorname{Mat}_{d \times d}(\mathbb{C})$ glued over $t \neq 0, \infty$ by $(\tilde{t}, \tilde{A})=\left(1 / t, t^{\lambda} A t^{-\lambda}\right)$, where $\lambda=\operatorname{diag}\left(\lambda_{1}, \ldots, \lambda_{d}\right)$. Thus, after taking the fibrewise quotient by $G L(d, \mathbb{C})$, we obtain the same complex manifold, independently of the choice of $E$.

From now on $d \geq 3$. Let $C$ be a connected nonplanar curve of degree $d$ in $\mathbb{P}^{3} \backslash \mathbb{P}^{1}$, flat over $\mathbb{P}^{1}$. If $C$ satisfies $\pi_{*} \mathcal{O}_{C} \simeq E$, then the corresponding section of $p: Z_{d} \rightarrow \mathbb{P}^{1}$ arises as the projection of a global section of $\mathcal{K}(E) \rightarrow \mathbb{P}^{1}$, i.e. it can be represented by a pair of commuting matrix polynomials, the degrees of which satisfy the constraints of part B in Proposition 2.2. We should like to remark that this gives constraints for possible degrees of commuting pairs of polynomials $A(t), B(t)$, such that $\operatorname{dim} Z(A(t), B(t))=d$ for each $t$.

Let $\mathcal{Z}$ denote the bundle of centralisers of $(A, B)$, i.e. a subbundle of $\mathcal{E} n d(E)$, the fibre of which over each $t$ is spanned by $Z(A(t), B(t))$. Let $\mathcal{T}$ denote the kernel of the homomorphism

$$
\begin{equation*}
D:\left(\mathcal{E} n d(E) \otimes \mathcal{O}_{\mathbb{P}^{1}}(1)\right)^{\oplus 2} \rightarrow \mathcal{E} n d(E) \otimes \mathcal{O}_{\mathbb{P}^{1}}(2), \quad(a, b) \rightarrow[A, b]+[a, B] \tag{3.1}
\end{equation*}
$$

In other words $\mathcal{T}$ is the fibrewise tangent bundle to $K(E)$. We obtain a short exact sequence of locally free sheaves on $\mathbb{P}^{1}$ :

$$
\begin{equation*}
0 \rightarrow \mathcal{E} n d(E) / \mathcal{Z} \rightarrow \mathcal{T} \rightarrow N \rightarrow 0 \tag{3.2}
\end{equation*}
$$

where $N$ is the normal bundle of the section in $Z_{d}$ and the first map is given by $\rho \mapsto([\rho, A],[\rho, B])$, i.e. its image consists of fundamental vector fields for the action of $G L(d, \mathbb{C})$.

Lemma 3.6. $\mathcal{Z} \simeq E$ and if we write $E \simeq \mathcal{O}_{\mathbb{P}^{1}} \oplus E^{\prime}$, then the embedding $\mathcal{Z} \hookrightarrow$ $\mathcal{E} n d(E) \simeq \mathcal{O}_{\mathbb{P}^{1}} \oplus E^{\prime} \oplus\left(E^{\prime}\right)^{*} \oplus \mathcal{E} n d\left(E^{\prime}\right)$ is the isomorphism with the direct sum of the first two summands.
Proof. Let $C$ be the curve in $\mathbb{P}^{3} \backslash \mathbb{P}^{1}$ determined by $A(t), B(t)$. We know that $\pi_{*} \mathcal{O}_{C} \simeq E$. Let $E^{\prime} \simeq \bigoplus_{i=2}^{d} \mathcal{O}_{\mathbb{P}^{1}}\left(\lambda_{i}\right)$. Each summand defines a section $A_{i}(t)$ of $\mathcal{E} n d(E) \otimes \mathcal{O}_{\mathbb{P}^{1}}\left(-\lambda_{i}\right)$ and these matrix polynomials commute. Moreover the first column of each $A_{i}(t)$ is just $e_{i}$. The bundle $\mathcal{Z}$ is spanned over each $t$ by 1 and the $A_{i}(t)$, i.e. it is isomorphic to the first column of $\mathcal{E} n d(E)$. The claim follows.

The image sheaf of $D$ is also locally free and can be identified with the annihilator of $\mathcal{Z}$ in $\mathcal{E} n d(E) \otimes \mathcal{O}_{\mathbb{P}^{1}}(2)$ (as vector bundles):

$$
\rho \in \operatorname{Im} D \Longleftrightarrow \operatorname{tr} \rho z=0 \forall z \in \mathcal{Z}
$$

Let us write $\mathcal{L}=\left(E^{\prime}\right)^{*} \oplus \mathcal{E} n d\left(E^{\prime}\right) \simeq \mathcal{E} n d(E) / \mathcal{Z}$. As a matrix of endomorphisms of $E$, it has the first column equal to 0 . From the above characterisation of $\operatorname{Im} D$ it follows that $\operatorname{Im} D \simeq \mathcal{L}^{*}(2)$, and, consequently, we can write the two short exact sequences (i.e. (3.2) and the sequence induced by (3.1)) as:

$$
\begin{gather*}
0 \rightarrow \mathcal{L} \rightarrow \mathcal{T} \rightarrow N \rightarrow 0  \tag{3.3}\\
0 \rightarrow \mathcal{T} \rightarrow\left(\mathcal{E} n d(E) \otimes \mathcal{O}_{\mathbb{P}^{1}}(1)\right)^{\oplus 2} \rightarrow \mathcal{L}^{*}(2) \rightarrow 0 \tag{3.4}
\end{gather*}
$$

These sequence describe $Z_{d}$, at least infinitesimally, as a fibrewise symplectic quotient of the total space of $\left(\mathcal{E} n d(E) \otimes \mathcal{O}_{\mathbb{P}^{1}}(1)\right)^{\oplus 2}$ by a Lie group, the Lie algebra of which is $\mathcal{L}$. Our idea, on how to study the hyperkähler structure of the Hilbert scheme of curves in $\mathbb{P}^{3} \backslash \mathbb{P}^{1}$, is essentially to describe the hyperkähler manifold of sections of $Z_{d}$ as a "hyperkähler quotient" of the (open dense subset of) vector space $H^{0}\left(\mathbb{P}^{1},\left(\mathcal{E} n d(E) \otimes \mathcal{O}_{\mathbb{P}^{1}}(1)\right)^{\oplus 2}\right)$ by a Lie group, the Lie algebra of which is $H^{0}\left(\mathbb{P}^{1}, \mathcal{L}\right)$. This cannot quite work in this form for various reasons, the most obvious of which is that the sections of $\left(\mathcal{E} n d(E) \otimes \mathcal{O}_{\mathbb{P}^{1}}(1)\right)^{\oplus 2}$ have the wrong normal bundle in order to form a hyperkähler manifold. In $\$ 5$ we shall show how to modify and implement this idea for curves of genus 0 . For higher genera, one probably has to work with the $\mathcal{P}$-structures of Gindikin [12], and with their quotients.

Remark 3.7. The above sequences provide numerical restrictions on curves which are cohomologically stable. Indeed, tensor (3.3) and (3.4) with $\mathcal{O}(-2)$ and put:

$$
\begin{gathered}
a=h^{0}\left((\mathcal{L}(-2))=h^{1}\left(\mathcal{L}^{*}\right), \quad b=h^{1}\left((\mathcal{L}(-2))=h^{0}\left(\mathcal{L}^{*}\right)\right.\right. \\
c=h^{0}(\mathcal{E} n d(E)(-1))=h^{1}(\mathcal{E} n d(E)(-1))
\end{gathered}
$$

Then $h^{0}(\mathcal{T}(-2)) \geq 2 c-b$ and, consequently, if $C$ is cohomologically stable, i.e. $h^{0}(N(-2))=h^{1}(N(-2))=0$, then $a \geq 2 c-b$. Let

$$
\pi_{*} \mathcal{O}_{C} \simeq \mathcal{O}_{\mathbb{P}^{1}} \oplus \bigoplus_{i=1}^{s} \mathcal{O}_{\mathbb{P}^{1}}(-i)^{m_{i}}
$$

Then $a=\sum_{j \geq i+2}(j-i-1) m_{i} m_{j}+\sum_{i \geq 2}(i-1) m_{i}, b=\sum_{j \geq i}(j-i+1) m_{i} m_{j}$, $c=\sum_{j \geq i+1}(j-i) m_{i} m_{j}+\sum_{i} i m_{i}$. Thus

$$
0 \geq 2 c-a-b=\sum_{i}(i+1) m_{i}-\sum_{i} m_{i}^{2}
$$

For example a curve such that $m_{i} \leq i+1$ for all $i$ and $m_{i} \leq i$ for at least one $i$ cannot be cohomologically stable (cf. Example 2.6).
3.2. Twistor space revisited. Given the constraints of Proposition 2.2 on the matrices $A, B$ representing a space curve, we can replace $Z_{d}$ for $d \geq 3$ by its open dense subset $Z_{d}^{\prime}$, the fibres of which consist of 0-dimensional subschemes of $\mathbb{C}^{2}$ not contained in any line. We have an analogue of Proposition 3.1, the proof of which is the same:

Proposition 3.8. Let $d \geq 3$. There exists a natural isomorphism between an open subset of the Hilbert scheme of $\mathbb{P}^{3} \backslash \mathbb{P}^{1}$ consisting of degree $d$ curves which are flat over $\mathbb{P}^{1}$, and the Hilbert scheme of sections of $p: Z_{d}^{\prime} \rightarrow \mathbb{P}^{1}$.

Theorem 1.10 tells us how to construct $Z_{d}^{\prime}$ from a vector bundle on $\mathbb{P}^{1}$. Let $E^{\prime}$ be a vector bundle of rank $d-1$ over $\mathbb{P}^{1}$ of the form $E^{\prime} \simeq \bigoplus_{i=1}^{d-1} \mathcal{O}_{\mathbb{P}^{1}}\left(-k_{i}\right)$ with $k_{1}=k_{2}=1$ and all $k_{i}$ positive. Define $\mathcal{K}^{0}\left(E^{\prime}\right)$ to be the subsheaf of $\left(\mathcal{E} n d\left(E^{\prime}\right) \otimes\right.$ $\left.\mathcal{O}_{\mathbb{P}^{1}}(1)\right)^{\oplus 2}$, the local section of which are pairs $(X(t), Y(t))$ such that for all $t$ :
(i) the first column of $Y(t)$ is equal to the second column of $X(t)$;
(ii) there is no subspace $S$ of $\mathbb{C}^{d-1}$ such that $e_{1}, e_{2} \in S, X(t) S \subset S, Y(t) S \subset S$;
(iii) $[X(t), Y(t)]$ has nonzero entries only in the first two rows.

We denote by $K^{0}(E)$ the total space of $\mathcal{K}^{0}(E)$ (defined as for $K(E)$ ). We define $Z\left(E^{\prime}\right)$ to be the fibrewise quotient of $K^{0}\left(E^{\prime}\right)$ by the action (1.4) of the group $\hat{G}^{0}$ defined in $\$ 1.1$ Theorem 1.10 implies that $Z\left(E^{\prime}\right) \simeq Z_{d}^{\prime}$ and that is a smooth manifold fibreing over $\mathbb{P}^{1}$ and we can conclude:

Proposition 3.9. $Z\left(E^{\prime}\right) \simeq Z_{d}^{\prime}$.
Proof. This is the same argument as in the proof of Lemma 3.5.
Consequently, sections of $Z_{d}^{\prime}$ corresponding to curves with $\pi_{*} \mathcal{O}_{C} \simeq \mathcal{O}_{\mathbb{P}^{1}} \oplus E^{\prime}$ arise as projections of global sections of $K\left(E^{\prime}\right)$, and we can represent them by pairs $(X(t), Y(t))$ of matrix polynomials satisfying the above constraints.

## 4. Interlude: COMPLEXIFIED HYPERKÄHLER STRUCTURES

The complexified algebra of quaternions is isomorphic to $\mathrm{Mat}_{2,2}(\mathbb{C})$. Consequently, a complexification of a real manifold with a geometry based on quaternions (such as hyperkähler, hypercomplex, quaternionic) or on split quaternions (hypersymplectic geometry) will posses a geometry based on this algebra (called algebra of biquaternions by Hamilton). Such geometries have been considered in the past, in particular by Jardim and Verbitsky in [19]. They call a complexified hyperkähler structure a trisymplectic structure generating an $S L(2, \mathbb{C})$-web. Although there are good reasons for this terminology, we prefer the shorter name $\mathbb{C}$-hyperkähler.

Definition 4.1. A complex manifold $M$ is called almost $\mathbb{C}$-hypercomplex if its holomorphic tangent bundle $T M$ decomposes as $T M \simeq E \otimes \mathbb{C}^{2}$, where $E$ is a holomorphic vector bundle. It is $\mathbb{C}$-hypercomplex if, in addition, for any $v \in \mathbb{C}^{2}$ the subbundle $E \otimes v$ defines an integrable distribution on $M$.

Definition 4.2. A $\mathbb{C}$-hypercomplex manifold is called $\mathbb{C}$-hyperkähler if it is equipped with a holomorphic section $g$ of $S^{2} T^{*} M$, such that:
(i) at any $m \in M, g_{m}$ is nondegenerate,
(ii) for any $A \in \operatorname{Mat}_{2,2}(\mathbb{C}), g(A \cdot, \cdot)=g\left(\cdot, A_{\text {adj }} \cdot\right)$, and
(iii) for any $A \in \mathfrak{s l}(2, \mathbb{C})$, the holomorphic 2-form $\omega_{A}=g(A \cdot, \cdot)$ is closed.

Given a $\mathbb{C}$-hypercomplex manifold we can define an integrable distribution $\mathcal{D}$ on $M \times \mathbb{P}^{1}$ by $\mathcal{D}_{\mid M \times\{z\}}=E \otimes h$, where $h$ is the highest weight vector for the maximal torus in $S L(2, \mathbb{C})$ corresponding to $z \in \mathbb{P}^{1}$. If $\mathcal{D}$ is simpl $\mathbb{B}^{3}$, then the leaf space $Z$ is the twistor space of $M$, and points of $M$ correspond to sections of $Z \rightarrow \mathbb{P}^{1}$ with normal bundles spliting as $\bigoplus \mathcal{O}_{\mathbb{P}^{1}}(1)$. If the distribution $\mathcal{D}$ is not simple, we need to view $Z$ in terms of foliated geometry.

If $M$ is $\mathbb{C}$-hyperkähler, then its twistor space is equipped with a fibrewise $\mathcal{O}_{\mathbb{P}^{1}}(2)$ valued complex symplectic form.

We shall now discuss $\mathbb{C}$-hypercomplex and $\mathbb{C}$-hyperkähler quotients. In the case of a reductive Lie group, $\mathbb{C}$-hyperkähler quotients have been introduced and studied by Jardim and Verbitsky [19] under the name "trisymplectic reduction". For us the case of nonreductive groups will be of paramount importance.

[^3]Definition 4.3. Let $M$ be a $\mathbb{C}$-hypercomplex manifold equipped with a holomorphic action of a complex Lie group $G$ preserving the $\mathbb{C}$-hypercomplex structure. A $\mathbb{C}$ hypercomplex moment map is a $G$-equivariant holomorphic map $\mu: M \rightarrow \mathfrak{g}^{*} \otimes$ $\mathfrak{s l}(2, \mathbb{C})^{*}$, such that there exists a holomorphic $\mathfrak{g}^{*}$-valued 1-form $\phi$ with the property that $\Phi=\phi \cdot 1_{2 \times 2}+d \mu: T M \rightarrow \mathfrak{g}^{*} \otimes \operatorname{Mat}_{2,2}(\mathbb{C})^{*}$ satisfies $\langle\Phi(A v), B\rangle=\left\langle\Phi(v), A_{\text {adj }} B\right\rangle$ for any $A \in \operatorname{Mat}_{2,2}(\mathbb{C})$.
Definition 4.4. Let $M$ be a $\mathbb{C}$-hyperkähler manifold equipped with a holomorphic action of a complex Lie group $G$ preserving the $\mathbb{C}$-hyperkähler structure. A $\mathbb{C}$ hyperkähler moment map is a $G$-equivariant holomorphic map $\mu: M \rightarrow \mathfrak{g}^{*} \otimes$ $\mathfrak{s l}(2, \mathbb{C})^{*}$, such that, for any $A \in \mathfrak{s l}(2, \mathbb{C})$ and any fundamental vector field $X_{\rho}$, $\rho \in \mathfrak{g},\langle d \mu(\cdot), \rho \otimes A\rangle=\omega_{A}\left(X_{\rho}, \cdot\right)$.
Remark 4.5. A $\mathbb{C}$-hyperkähler moment map is also a $\mathbb{C}$-hypercomplex moment map, with $\langle\phi(v), \rho\rangle=g\left(X_{\rho}, v\right), \rho \in \mathfrak{g}, v \in T M$.

The $\mathbb{C}$-hypercomplex or $\mathbb{C}$-hyperkähler reduction proceeds now along the usual lines: given $G$ and a moment map $\mu: M \rightarrow \mathfrak{g}^{*} \otimes \mathfrak{s l}(2, \mathbb{C})^{*}$, choose a $G$-invariant element $c \in \mathfrak{g}^{*} \otimes \mathfrak{s l}(2, \mathbb{C})^{*}$. Unlike in the hyperkähler case, the freeness of the action of $G$ on $\mu^{-1}(c)$ does not imply that $\mu^{-1}(c)$ is smooth. Moreover, even if $\mu^{-1}(c)$ is smooth and the action of $G$ on $\mu^{-1}(c)$ is free and proper, then although $\mu^{-1}(c) / G$ is a complex manifold [7, Ch.III, Prop.10], it is not necessarily a $\mathbb{C}$-hypercomplex or $\mathbb{C}$-hyperkähler manifold. As observed by several authors in related settings (especially [20, §3], [17], [8, §4]), both smoothness of $\mu^{-1}(c)$ and the existence of induced geometry on $\mu^{-1}(c) / G$ are guaranteed by a single nondegeneracy condition. Namely, we have:
Theorem 4.6. Let $\mu: M \rightarrow \mathfrak{g}^{*} \otimes \mathfrak{s l}(2, \mathbb{C})^{*}$ be $a \mathbb{C}$-hypercomplex (resp. $\mathbb{C}$-hyperkähler) moment map and let $c \in \mathfrak{g}^{*} \otimes \mathfrak{s l}(2, \mathbb{C})^{*}$ be $G$-invariant. Suppose that the action of $G$ on $\mu^{-1}(c)$ is free and proper and that, at any $m \in \mu^{-1}(c), \phi_{m}\left(X_{\rho}\right) \neq 0$ for any $\rho \in \mathfrak{g}$ (resp. the restriction of $g$ to the subspace of $T_{m} M$ generated by fundamental vector fields is nondegenerate). Then $\mu^{-1}(c) / G$ is a $\mathbb{C}$-hypercomplex (resp. $\mathbb{C}$-hyperkähler) manifold.

However, the assumptions in Theorem 4.6 are not the most general ones, under which one obtains a nondegenerate $\mathbb{C}$-hyperkähler quotient:
Proposition 4.7. Let $\mu: M \rightarrow \mathfrak{g}^{*} \otimes \mathfrak{s l}(2, \mathbb{C})^{*}$ be a $\mathbb{C}$-hyperkähler moment map and let $c \in \mathfrak{g}^{*} \otimes \mathfrak{s l}(2, \mathbb{C})^{*}$ be $G$-invariant. Suppose that $\mu^{-1}(c)$ is smooth and the action of $G$ on $\mu^{-1}(c)$ is free and proper. Then $\mu^{-1}(c) / G$ is a $\mathbb{C}$-hyperkähler manifold if and only if $\check{\mathfrak{g}} \cap \check{\mathfrak{g}}^{\perp}$ is $\operatorname{Mat}_{2,2}(\mathbb{C})$-invariant along $\mu^{-1}(c)$, where $\check{\mathfrak{g}}$ denotes the subspace of $T_{m} M$ generated by fundamental vector fields, and $\check{\mathfrak{g}}^{\perp}=\left\{v ; g\left(X_{\rho}, v\right)=0 \forall \rho \in \mathfrak{g}\right\}$.
Proof. Let $I, J, K \in \mathfrak{s l}(2, \mathbb{C})$ denote the standard basis of quaternions. Hitchin [17] (see also [8, p.102]) shows that along $\mu^{-1}(c)$,

$$
\operatorname{Ker} \omega_{I}=\check{\mathfrak{g}}+J \check{\mathfrak{g}} \cap \check{\mathfrak{g}}^{\perp}+K \check{\mathfrak{g}} \cap \check{\mathfrak{g}}^{\perp},
$$

and cyclically in $I, J, K$. Thus $\omega_{I}$ descends to a nondegenerate symplectic form on $\mu^{-1}(c) / G$ if and only if $J \check{\mathfrak{g}} \cap \check{\mathfrak{g}}^{\perp}+K \check{\mathfrak{g}} \cap \check{\mathfrak{g}}^{\perp} \subset \mathfrak{g}$. Therefore $\mu^{-1}(c) / G$ is a $\mathbb{C}$-hyperkähler manifold if and only if $\mathfrak{g} \cap \mathfrak{g}^{\perp}$ is $\mathrm{Mat}_{2,2}(\mathbb{C})$-invariant.

Proposition 4.8. Suppose that the conditions of the above proposition are satisfied. Then $\operatorname{dim} \check{\mathfrak{g}} \cap \check{\mathfrak{g}}^{\perp}=k$ is constant along $\mu^{-1}(c)$ and

$$
\operatorname{dim} \mu^{-1}(c) / G=\operatorname{dim} M-4 \operatorname{dim} G+2 k
$$

Proof. The smoothness of $\mu^{-1}(c)$ implies that $(\operatorname{Ker} d \mu)^{\perp}=I \check{\mathfrak{g}}+J \check{\mathfrak{g}}+K \check{\mathfrak{g}}$ has constant dimension along $\mu^{-1}(c)$, where $\perp$ denotes the orthogonal "complement" with respect to the form $g$. Suppose that $I X_{\rho_{1}}+J X_{\rho_{2}}+K X_{\rho_{3}}=0$. Taking the scalar products (for the form $g$ ) with $I X_{\rho}, J X_{\rho}, K X_{\rho}$ shows that $X_{\rho_{1}}, X_{\rho_{2}}, X_{\rho_{3}} \in$ $\check{\mathfrak{g}} \cap \check{\mathfrak{g}}^{\perp}$. Therefore $\operatorname{dim}(\operatorname{Ker} d \mu)^{\perp}=3 \operatorname{dim} G-2 \operatorname{dim} \check{\mathfrak{g}} \cap \check{\mathfrak{g}}^{\perp}$ and it follows that $\operatorname{dim} \check{\mathfrak{g}} \cap \check{\mathfrak{g}}^{\perp}$ must be constant along $\mu^{-1}(c)$.

We shall use the above results in the following situation.
Corollary 4.9. Let $\mu=\mu_{H} \oplus \mu_{L}: M \rightarrow \mathfrak{g}^{*} \otimes \mathfrak{s l}(2, \mathbb{C})^{*}$ be a $\mathbb{C}$-hyperkähler moment map for a semidirect product $G \simeq H \ltimes L$ and let $c=\left(c_{H}, c_{L}\right) \in \mathfrak{g}^{*} \otimes \mathfrak{s l}(2, \mathbb{C})^{*}$ be $G$-invariant. Suppose that the following conditions are satisfied:
(i) the action of $G$ on $\mu^{-1}(c)$ is free and proper;
(ii) $\mu_{L}^{-1}\left(c_{L}\right)$ is smooth and the action of $L$ on $\mu_{L}^{-1}\left(c_{L}\right)$ is free and proper;
(iii) $\check{\mathfrak{l}}$ is $\mathrm{Mat}_{2,2}(\mathbb{C})$-invariant along $\mu^{-1}\left(c_{L}\right)$;
(iv) $\check{\mathfrak{l}} \subset \check{\mathfrak{g}} \cap \check{\mathfrak{g}}^{\perp}$ along $\mu^{-1}(c)$, with equality holding generically.

Then:
a) $\mu^{-1}(c) / G$ is smooth if and only if $\operatorname{dim} I \check{\mathfrak{h}}+J \check{\mathfrak{h}}+K \check{\mathfrak{h}}=3 \operatorname{dim} H$ along $\mu^{-1}(c)$.
b) $\mu^{-1}(c) / G$ is a $\mathbb{C}$-hyperkähler manifold if and only if $\check{\mathfrak{g}} \cap \check{\mathfrak{g}}^{\perp}=\check{\mathfrak{l}}$ along $\mu^{-1}(c)$. In both a) and b), the dimension of $\mu^{-1}(c) / G$ is $\operatorname{dim} M-4 \operatorname{dim} H-2 \operatorname{dim} L$.

Proof. Conditions (ii) and (iii) together with Proposition 4.7 imply that $M_{L}=$ $\mu_{L}^{-1}\left(c_{L}\right) / L$ is a $\mathbb{C}$-hyperkähler manifold (of dimension $\operatorname{dim} M-2 \operatorname{dim} L$ ). Since $L$ is normal in $G$, we obtain a $\mathbb{C}$-hyperkähler action of $H$ on $M_{L}$ and a $\mathbb{C}$-hyperkähler moment map $\bar{\mu}_{H}: M_{L} \rightarrow \mathfrak{h}^{*} \otimes \mathfrak{s l}(2, \mathbb{C})^{*}$. The $\mathbb{C}$-hyperkähler quotient of $M_{L}$ by $H$ is isomorphic to the $\mathbb{C}$-hyperkähler quotient of $M$ by $G$. Statement a) follows, since $\operatorname{dim} I \check{\mathfrak{h}}+J \check{\mathfrak{h}}+K \check{\mathfrak{h}}=3 \operatorname{dim} H$ is equivalent to $\bar{\mu}_{H}$ being a submersion at points of $\bar{\mu}_{H}^{-1}\left(c_{H}\right)$. On the other hand, the condition in b) means that the triple $\left(M_{L}, H, \bar{\mu}_{H}\right)$ satisfies conditions of Theorem 4.6, and is therefore sufficient. Conversely, if $\mu^{-1}(c) / G$ is a $\mathbb{C}$-hyperkähler manifold, then, owing to a), $\operatorname{dim} I \check{\mathfrak{h}}+J \check{\mathfrak{h}}+K \check{\mathfrak{h}}=3 \operatorname{dim} H$, which means that $\bar{\mu}_{H}^{-1}\left(c_{H}\right)$ is smooth. The neccessity of $\check{\mathfrak{g}} \cap \mathfrak{g}^{\perp}=\check{\mathfrak{l}}$ follows now from Proposition 4.7.

## 5. Genus zero space curves

We return to the situation discussed in $\oint 3$ and consider in detail the case of genus 0 space curves. We denote by $R_{d}$ an open subset of the Hilbert scheme $\operatorname{Hilb}_{d, 0}$ of subschemes in $\mathbb{P}^{3}$ with Hilbert polynomial $h(n)=d n+1$, consisting of those $C \in \operatorname{Hilb}_{d, 0}$ which satisfy
(i) $C$ is contained in $\mathbb{P}^{3} \backslash\left\{\left[z_{0}, z_{1}, 0,0\right]\right\}$;
(ii) the projection $\pi$ of $C$ onto $\left\{\left[0,0, z_{2}, z_{3}\right]\right\}$ is flat;
(iii) $C$ is nonplanar.

Such a $C$ is automatically Cohen-Macaulay and connected. We denote by $R_{d}^{i}$, $i=0,1,2$, an open subset of $R_{d}$ consisting of those $C \in \operatorname{Hilb}_{d, 0}$ which satisfy, in addition, $h^{1}\left(\mathcal{N}_{C / \mathbb{P}^{3}}(-i)\right)=0$. We have $R_{d}^{2} \subset R_{d}^{1} \subset R_{d}^{0}$ and $R_{d}^{0}$ is precisely the smooth locus of $R_{d}$. Moreover, the results of Ghione and Sacchiero [11, Cor. 1.4] imply that any immersed rational curve in $R_{d}$ belongs to $R_{d}^{1}$.

For a $C \in R_{d}$ we have $\pi_{*} \mathcal{O}_{C} \simeq \mathcal{O}_{\mathbb{P}^{1}} \oplus \mathcal{O}_{\mathbb{P}^{1}}(-1)^{\oplus(d-1)}$ (since $\operatorname{deg} \pi_{*} \mathcal{O}_{C}=$ $-(d+g-1), g=0$, the degrees of the summands are nonpositive, and $\left.h^{0}\left(\mathcal{O}_{C}\right)=1\right)$
and thus curves in $R_{d}$ correspond to sections of $p: Z_{d} \rightarrow \mathbb{P}^{1}$ which arise as projections of sections of $K(E) \rightarrow \mathbb{P}^{1}$ with $E=\mathcal{O}_{\mathbb{P}^{1}} \oplus \mathcal{O}_{\mathbb{P}^{1}}(-1)^{\oplus(d-1)}$ (and the map associating a section to a curve is a biholomorphism between $R_{d}$ and the corresponding open subset of the Kodaira moduli space of sections of $p$, cf. Proposition 3.1). Equivalently, owing to Proposition 3.9, curves in $R_{d}$ can be obtained as sections of $Z\left(E^{\prime}\right)$ with $E^{\prime} \simeq \mathcal{O}_{\mathbb{P}^{1}}(-1)^{\oplus(d-1)}$.

If $C \in R_{d}^{2}$, then the normal bundle of the corresponding section of $Z_{d}$ is isomorphic to $\mathcal{O}_{\mathbb{P}^{1}}(1)^{\oplus 2 d}$ and, hence, $R_{d}^{2}$ comes equipped with a $\mathbb{C}$-hyperkähler structure. Moreover, given a real structure $\sigma$ on $\left|\mathcal{O}_{\mathbb{P}^{1}}(-1) \oplus \mathcal{O}_{\mathbb{P}^{1}}(-1)\right|$, covering a real structure on $\mathbb{P}^{1}$, we obtain a pseudo-hyperkähler or hypersymplectic structure on $\left(R_{d}^{2}\right)^{\sigma}$ (depending on whether $\sigma$ is fixed-point free or not).

Example 5.1. Let $C$ be a twisted rational curve of degree 3 not meeting the $\mathbb{P}^{1}$. Its ideal is generated by the minors of the $3 \times 2$ matrix

$$
\left(\begin{array}{ll}
x & 0 \\
y & x \\
0 & y
\end{array}\right)-C(t)
$$

where the entries of $C$ are constant or linear in $t$. Thus
$x^{2}=\left(c_{11}+c_{22}\right) x-c_{12} y-C_{3}, x y=c_{32} x+c_{11} y-C_{2}, y^{2}=\left(c_{21}+c_{32}\right) y-c_{31} x-C_{1}$, where $C_{i}$ denotes the determinant of a $2 \times 2$ matrix obtained by deleting the $i$-th row from $C$. Thus the matrices $A$ and $B$ are

$$
A(t)=\left(\begin{array}{ccc}
0 & -C_{3} & -C_{2} \\
1 & c_{11}+c_{22} & c_{32} \\
0 & -c_{12} & c_{11}
\end{array}\right), \quad B(t)=\left(\begin{array}{ccc}
0 & -C_{2} & -C_{1} \\
0 & c_{32} & -c_{31} \\
1 & c_{11} & c_{21}+c_{32}
\end{array}\right)
$$

The metric is given as the coefficient of $t$ in power series expansion of

$$
\begin{aligned}
\operatorname{tr} d A \wedge d B & =d\left(c_{11}+c_{22}\right) \wedge d c_{32}+d c_{32} \wedge d c_{11}+d c_{12} \wedge d c_{31}+d a_{11} \wedge d\left(c_{21}+c_{32}\right)= \\
& =d\left(c_{11}+c_{22}\right) \wedge d\left(c_{32}+c_{21}\right)-d c_{22} \wedge d c_{21}+d c_{12} \wedge d c_{31}
\end{aligned}
$$

The antiholomorphic involution $\sigma$, covering the antipodal map on $\mathbb{P}^{1}$, acts on linear polynomials $c_{i j}(t)$ as

$$
\left(\begin{array}{cc}
c_{11}(t) & c_{12}(t) \\
c_{21}(t) & c_{22}(t) \\
c_{31}(t) & c_{32}(t)
\end{array}\right) \mapsto t \overline{\left(\begin{array}{cc}
c_{32}(-1 / \bar{t}) & c_{31}(-1 / \bar{t}) \\
-c_{22}(-1 / \bar{t}) & c_{21}(-1 / \bar{t}) \\
-c_{12}(-1 / \bar{t}) & -c_{11}(-1 / \bar{t})
\end{array}\right)}
$$

Restricting the above formula for $\operatorname{tr} d A \wedge d B$ to $\sigma$-invariant sections shows that the hyperkähler metric on the space of real twisted cubics is flat with signature $(8,4)$.

We shall now describe $R_{d}^{2}, d \geq 4$, as a $\mathbb{C}$-hyperkähler quotient of a flat $\mathbb{C}$ hyperkähler manifold. Let $M=\operatorname{Mat}_{d-1, d-1}(\mathbb{C}) \otimes \mathbb{C}^{4}$ and write its elements as $\left(X_{0}, X_{1}, Y_{0}, Y_{1}\right) . M$ is a $\mathbb{C}$-hyperkähler manifold with the action of $\operatorname{Mat}_{2,2}(\mathbb{C})$ on $T M$ given by the left multiplication on $\operatorname{Mat}_{2,2}(\mathbb{C}) \simeq \mathbb{C}^{4}$, i.e.:

$$
\left(\begin{array}{ll}
X_{0} & Y_{0}  \tag{5.1}\\
X_{1} & Y_{1}
\end{array}\right) \mapsto\left(\begin{array}{ll}
a I & b I \\
c I & d I
\end{array}\right)\left(\begin{array}{ll}
X_{0} & Y_{0} \\
X_{1} & Y_{1}
\end{array}\right)
$$

The symmetric holomorphic $(2,0)$-tensor $g$ is

$$
\begin{equation*}
g=\operatorname{tr}\left(d X_{1} d Y_{0}-d X_{0} d Y_{1}\right) \tag{5.2}
\end{equation*}
$$

The twistor space $Z$ of $M$ is the total space of $\operatorname{Mat}_{d-1, d-1}(\mathbb{C}) \otimes \mathcal{O}_{\mathbb{P}^{1}}(1)^{\oplus 2}$, and an element $\left(X_{0}, X_{1}, Y_{0}, Y_{1}\right)$ of $M$ is identified with the section

$$
(X(t), Y(t))=\left(X_{0}+t X_{1}, Y_{0}+t Y_{1}\right)
$$

of $Z \rightarrow \mathbb{P}^{1}$. The twisted fibrewise symplectic form on $Z$ is $\operatorname{tr} d\left(X_{0}+t X_{1}\right) \wedge d\left(Y_{0}+t Y_{1}\right)$.
We define a $\mathbb{C}$-hyperkähler submanifold $M_{d}$ of $M$ to consist of $\left(X_{0}, X_{1}, Y_{0}, Y_{1}\right)$ such that:
(i) $\forall t \in \mathbb{P}^{1}\left(X(t), Y(t),\left\langle e_{1}, e_{2}\right\rangle\right)$ is stable.
(ii) $\forall_{t \in \mathbb{P}^{1}} X_{12}(t)=Y_{11}(t), \quad X_{22}(t)=Y_{21}(t)$.

Next we define the relevant group $\hat{G}_{d}$ acting on $M_{d}$. It consists of invertible $d \times d$ matrices of the form

$$
g(t)=\left(\begin{array}{cccccc}
1 & 0 & 0 & u_{1}(t) & \ldots & u_{d-3}(t)  \tag{5.3}\\
0 & 1 & 0 & * & \ldots & * \\
0 & 0 & 1 & * & \ldots & * \\
0 & 0 & 0 & * & \ldots & * \\
\vdots & \vdots & \vdots & \vdots & & \vdots \\
0 & 0 & 0 & * & \ldots & *
\end{array}\right)
$$

where asterisks denote complex numbers, and $u_{i}(t), i=1, \ldots, d-3$, are linear polynomials. The group structure is given by matrix multiplication. Observe that if we fix $t$, we obtain a group $\hat{G}_{d}(t)$ isomorphic to the group $\hat{G}_{0}$ of $\S 1.1$ We have $\hat{G}_{d} \simeq G_{0} \ltimes L$, where $G_{0}$ is obtained by deleting the first row and the first column of (5.3) and $L \simeq \mathbb{C}^{2(d-3)}$ is the additive group of $d-3$ linear polynomials. If we write an element of $L$ as $u(t)=\left(0,0, u_{1}(t), \ldots, u_{d-3}(t)\right)$, then the action of $\hat{G}_{d}$ on pairs of linear matrix polynomials $(X(t), Y(t))$ can be written as (cf. (1.4)):

$$
\begin{equation*}
\left(g_{0}, u(t)\right) \cdot(X(t), Y(t))=\left(g_{0} X(t) g_{0}^{-1}-e_{1} u(t) g_{0}^{-1}, g_{0} Y(t) g_{0}^{-1}-e_{2} u(t) g_{0}^{-1}\right) \tag{5.4}
\end{equation*}
$$

This action preserves the $\mathbb{C}$-hyperkähler structure of $M_{d}$ and it lifts to an action on the twistor space of $M_{d}$ : an element $g(t)$ acts as $g\left(t_{0}\right)$ on the fibre over $t_{0}$. We easily compute the $\mathbb{C}$-hyperkähler moment map $\mu: M_{d} \rightarrow \hat{\mathfrak{g}}_{d}^{*} \otimes \mathfrak{s l}(2, \mathbb{C}) \simeq$ $\left(\mathfrak{g}_{0}^{*} \oplus \mathfrak{l}^{*}\right) \otimes \mathfrak{s l}(2, \mathbb{C}):$

$$
\mu_{i j}= \begin{cases}\frac{1}{2}\left(\pi\left(\left[X_{0}, Y_{1}\right]+\left[X_{1}, Y_{0}\right]\right),\left(X_{1}+t X_{0}\right) e_{2}-\left(Y_{1}+t Y_{0}\right) e_{1}\right) & \text { if } i j=11  \tag{5.5}\\ \left(\pi\left(\left[X_{0}, Y_{0}\right]\right), X_{0} e_{2}-Y_{0} e_{1}\right) & \text { if } i j=21 \\ \left(\pi\left(\left[X_{1}, Y_{1}\right]\right), t\left(X_{1} e_{2}-Y_{1} e_{1}\right)\right) & \text { if } i j=12\end{cases}
$$

where $\pi: \operatorname{Mat}_{d-1, d-1} \rightarrow \mathfrak{g}_{0}^{*}$ is the projection onto the last $d-3$ rows. We conclude:
Lemma 5.2. An element $\left(X_{0}, X_{1}, Y_{0}, Y_{1}\right)$ of $M_{d}$ belongs to $\mu^{-1}(0)$ if and only if, for every $t \in \mathbb{P}^{1}, X(t) e_{2}=Y(t) e_{1}$ and $[X(t), Y(t)]$ has nonzero entries only in the first two rows.

Remark 5.3. We should like to remark that the moment map equations for $\hat{G}_{d}$ are formally similar to the complex ADHM equations considered in [10. The difference is that the $((d-1) \times 2,2 \times(d-1))$-part $(i, j)$ (cf. §1.1) of the ADHM-datum is no longer linear in $t ; i$ is now constant, while $j$ is quadratic.

Lemma 5.4. The action of $\hat{G}_{d}$ on $\mu^{-1}(0)$ is free and proper.

Proof. If $g \in \hat{G}_{d}$ fixes a point $\left(X_{0}, X_{1}, Y_{0}, Y_{1}\right)$ of $M_{d}$, then $g\left(t_{0}\right)$ fixes $\left(X\left(t_{0}\right), Y\left(t_{0}\right)\right)$, for every $t_{0}$. Choosing a $t_{0}$ such that $g\left(t_{0}\right) \neq 1$ contradicts Theorem1.10. Therefore $\hat{G}_{d}$ acts freely. The moment map for the twisted symplectic form $\operatorname{tr} d X(t) \wedge d Y(t)$ is $\mu(t)=\mu_{21}+2 \mu_{11} t+\mu_{12} t^{2}$. Setting $X_{0}=\mu(0)^{-1}(0), X_{1}=\mu(1)^{-1}(0), X_{2}=$ $\mu(\infty)^{-1}(0)$, we have $\mu^{-1}(0)=X_{0} \cap X_{1} \cap X_{2}$. For every $t_{0}$, the group $\hat{G}_{d}\left(t_{0}\right)$ (obtained by evaluating (5.3) at $t_{0}$ ) acts properly on $\mu\left(t_{0}\right)^{-1}(0)$, owing to Theorem 1.10. It follows that, if $m_{i} \in \mu^{-1}(0), g_{i}=\left(g_{i}^{0}, u_{i}(t)\right) \in \hat{G}_{d}, i \in \mathbb{N}$, and $m_{i} \rightarrow m$, $g_{i} m_{i} \rightarrow m^{\prime}$, then both $\left(g_{i}^{0}, u_{i}(0)\right)$ and $\left(g_{i}^{0}, u_{i}(\infty)\right)$ have convergent subsequences. Therefore $\left(g_{i}\right)$ has a convergent subsequence and $\hat{G}_{d}$ acts properly on $\mu^{-1}(0)$.

This lemma implies that $\mu^{-1}(0) / \hat{G}_{d}$ is a Hausdorff topological space, and that the smooth part of $\mu^{-1}(0)$ is a principal $\hat{G}_{d}$-bundle over a complex manifold. Observe now that the fundamental vector field corresponding to $u_{0}+t u_{1} \in \mathfrak{l}$ is

$$
X_{u}=\left(-e_{1} u_{0},-e_{1} u_{1},-e_{2} u_{0},-e_{2} u_{1}\right)
$$

and, consequently, the subspace of these vector fields is $\mathrm{Mat}_{2,2}(\mathbb{C})$-invariant, owing to (5.1). Observe also that $g\left(X_{u}, X_{\rho}\right)=0$ at points of $\mu^{-1}(0)$, for every $\rho \in \hat{\mathfrak{g}}_{d}$. Corollary 4.9 implies:

Proposition 5.5. Let $m=\left(X_{0}, X_{1}, Y_{0}, Y_{1}\right) \in \mu^{-1}(0)$ and let $\bar{m}$ denote its image in $\mu^{-1}(0) / \hat{G}_{d}$.
(i) $\bar{m}$ is a smooth point of $\mu^{-1}(0) / \hat{G}_{d}$ if and only if the dimension of the subspace of $T_{m} M_{d}$ spanned by $A X_{\rho}, A \in \mathfrak{s l}(2, \mathbb{C}), \rho \in \mathfrak{g}_{0}$, equals $3 \operatorname{dim} \mathfrak{g}_{0}$;
(ii) $\bar{m}$ is a smooth point of $\mu^{-1}(0) / \hat{G}_{d}$ and the $\mathbb{C}$-hyperkähler structure is nondegenerate at $\bar{m}$ if and only if the quadratic form (5.2) is nondegenerate on the subspace generated by $X_{\rho}, \rho \in \mathfrak{g}_{0}$.

Let us denote by $M_{d}^{0}$ (resp. $M_{d}^{2}$ ) the subset of $M_{d}$ where the condition (i) (resp. (ii)) is satisfied. Thus $\mu^{-1}(0) \cap M_{d}^{0} / \hat{G}_{d}$ is a complex manifold and $\mu^{-1}(0) \cap M_{d}^{2} / \hat{G}_{d}$ is a $\mathbb{C}$-hyperkähler manifold. We can now state and prove our main result:

Theorem 5.6. There is a natural bijection between $R_{d}$ and $\mu^{-1}(0) / \hat{G}_{d}$. This bijection is a biholomorphism between $R_{d}^{0}$ and $\left(\mu^{-1}(0) \cap M_{d}^{0}\right) / \hat{G}_{d}$ and a $\mathbb{C}$-hyperkähler isomorphism between $R_{d}^{2}$ and $\left(\mu^{-1}(0) \cap M_{d}^{2}\right) / \hat{G}_{d}$.

Proof. Propositions 3.8 and 3.9 show that there is a natural isomorphism between $R_{d}$ and sections of $Z\left(E^{\prime}\right)$ with $E^{\prime} \simeq \mathcal{O}_{\mathbb{P}^{1}}(-1)^{\oplus(d-1)}$. From the construction, $Z\left(E^{\prime}\right)$ is the twistor space of $\mu^{-1}(0) / \hat{G}_{d}$. Sections of $Z\left(E^{\prime}\right)$ are projections of sections of $K\left(E^{\prime}\right)$, which in turn correspond to points of $\mu^{-1}(0)$ (as shown in Lemma 5.2). The smooth locus of the (component of) Hilbert scheme of sections of $Z\left(E^{\prime}\right)$ is then the smooth locus of $\mu^{-1}(0) / \hat{G}_{d}$, i.e. $\mu^{-1}(0) \cap M_{d}^{0} / \hat{G}_{d}$, and the locus of sections, the normal bundle of which splits as $\mathcal{O}_{\mathbb{P}^{1}}(1)^{\oplus 2 d}$, is $\left(\mu^{-1}(0) \cap M_{d}^{2}\right) / \hat{G}_{d}$. The result follows.

Remark 5.7. The bijection in the first statement of this theorem is an isomorphism if we give $\mu^{-1}(0) / \hat{G}_{d}$ the scheme structure of the Hilbert scheme of sections of $Z\left(E^{\prime}\right)$. A natural question is whether this scheme structure can be obtained via nonreductive invariant theory 3].

Remark 5.8. One can compute the restriction of (5.2) to the subspace generated by fundamental vector fields, and thus characterise $M_{d}^{2}$ as consisting of points $m$ such that certain linear operator $L_{m}: \mathfrak{g}_{0} \rightarrow \mathfrak{g}_{0}^{*}$ is invertible.
5.1. Real structures. Up to the action of $\operatorname{PGL}(4, \mathbb{C}), \mathbb{P}^{3}$ has two antilinear involutions:

$$
\begin{gathered}
\sigma\left[z_{0}, z_{1}, z_{2}, z_{3}\right]=\left[-\bar{z}_{1}, \bar{z}_{0},-\bar{z}_{3}, \bar{z}_{2}\right], \\
\sigma^{\prime}\left[z_{0}, z_{1}, z_{2}, z_{3}\right]=\left[\bar{z}_{1}, \bar{z}_{0}, \bar{z}_{3}, \bar{z}_{2}\right] .
\end{gathered}
$$

Both of them preserve $\mathbb{P}^{1}=\left\{\left[z_{0}, z_{1}, 0,0\right]\right\}$, and the space of invariant lines in $\mathbb{P}^{3} \backslash \mathbb{P}^{1}$ is diffeomorphic to $\mathbb{R}^{4}$. In the case of $\sigma$, the $\mathbb{C}$-hyperkähler structure on the space of lines restricts to a flat hyperkähler structure on $\mathbb{R}^{4}$, while in the case of $\sigma^{\prime}$, it restricts to a flat hypersymplectic structure [8]. The involutions $\sigma, \sigma^{\prime}$ act on curves in $\mathbb{P}^{3} \backslash \mathbb{P}^{1}$ and we obtain a pseudo-hyperkähler (resp. hypersymplectic) structure on manifolds of $\sigma$-invariant (resp. $\sigma^{\prime}$-invariant) cohomologically stable curves of fixed genus and degree. We want to describe these manifolds in the case of genus 0 curves, i.e. $\left(R_{d}^{2}\right)^{\sigma}$ and $\left(R_{d}^{2}\right)^{\sigma^{\prime}}$. First of all we have:
Proposition 5.9. $R_{d}^{\sigma}$ is empty if $d$ is even.
Proof. For $C$ in $R_{d}$ and the corresponding $\pi: C \rightarrow \mathbb{P}^{1}$ we have, as observed before, $\pi_{*} \mathcal{O}_{C} \simeq \mathcal{O}_{\mathbb{P}^{1}} \oplus \mathcal{O}_{\mathbb{P}^{1}}(-1)^{\oplus(d-1)}$. The involution $\sigma$ induces an antilinear involution on $W=\mathcal{O}_{\mathbb{P}^{1}}(-1)^{\oplus(d-1)}$, which covers the antipodal map on $\mathbb{P}^{1}$. This, in turn, induces an antilinear involution on $\Lambda^{d-1} W^{*} \simeq \mathcal{O}_{\mathbb{P}^{1}}(d-1)$, which covers the antipodal map. Since this involution has no fixed points, the number of zeros of any section of $\Lambda^{d-1} W^{*}$ must be even.

If $d$ is odd, then there is an induced involution $\sigma$ on $E^{\prime} \simeq \mathcal{O}_{\mathbb{P}^{1}}(-1)^{\oplus(d-1)}$. Modulo conjugation we can write $\sigma$ in the standard trivialisation over $t \neq \infty$ as

$$
\sigma\left(t ; f_{1}, \ldots, f_{d-1}\right)=\left(-1 / \bar{t} ;-\bar{t} \bar{f}_{2}, \bar{t} \bar{f}_{1},-\bar{t} \bar{f}_{4}, \bar{t} \bar{f}_{3}, \ldots,-\bar{t} \bar{f}_{d-1}, \bar{t} \bar{f}_{d-2}\right)
$$

This, in turn, yields an antiholomorphic involution on $\operatorname{End}\left(E^{\prime}\right): M \mapsto \sigma M \sigma$ and, finally, on $M_{d}$ :

$$
(X(t), Y(t)) \mapsto(-\sigma Y(t) \sigma / \bar{t}, \sigma X(t) \sigma / \bar{t})
$$

It follows that:

$$
\begin{equation*}
\left(X_{0}, X_{1}, Y_{0}, Y_{1}\right) \mapsto\left(-\tau \bar{Y}_{1} \tau, \tau \bar{Y}_{0} \tau, \tau \bar{X}_{1} \tau,-\tau \bar{X}_{0} \tau\right) \tag{5.6}
\end{equation*}
$$

where

$$
\tau_{i j}= \begin{cases}-1 & \text { if } j=i+1 \text { and } i \text { is odd } \\ 1 & \text { if } j=i-1 \text { and } i \text { is even } \\ 0 & \text { otherwise }\end{cases}
$$

Consequently:

$$
M_{d}^{\sigma}=\left\{\left(X_{0}, X_{1}, Y_{0}, Y_{1}\right) \in M_{d} ; Y_{0}=\tau \bar{X}_{1} \tau, \quad Y_{1}=-\tau \bar{X}_{0} \tau\right\}
$$

An easy computation shows that the quadratic form (5.2) restricted to $M_{d}^{\sigma}$ is a pseudo-Riemannian metric of signature $\left(2(d-1)^{2}+2(d-3), 2(d-1)^{2}-2(d-1)\right)$. The subgroup $\hat{G}_{d}^{\sigma}$ commuting with $\sigma$ consists of elements $(h, u) \in G_{0} \ltimes L$, where $h=\tau \bar{h} \tau^{-1}$ and $u_{2 i-1}(-1 / \bar{t})=-\overline{u_{2 i}(t)} / \bar{t}, i=1, \ldots,(d-3) / 2$. We conclude from Theorem 5.6.

Theorem 5.10. Let $d$ be odd. The pseudo-hyperkähler manifold $\left(R_{d}^{2}\right)^{\sigma}$ of cohomologically stable connected $\sigma$-invariant Cohen-Macaulay curves of arithmetic genus 0 in $\mathbb{P}^{3} \backslash \mathbb{P}^{1}$ is isomorphic to the hyperkähler quotient of $\left(M_{d}^{2}\right)^{\sigma}$ by the group $\hat{G}_{d}^{\sigma}$. $\square$
Remark 5.11. It follows from the main result of [6] that the signature of the pseudohyperkähler metric on $\left(R_{d}^{2}\right)^{\sigma}$ is $(2 d+2,2 d-2)$.

There is an analogous description of the hypersymplectic manifold $\left(R_{d}^{2}\right)^{\sigma^{\prime}}$. Essentially, we just have to remove all the minus signs in the above formulae (in particular, $d$ can be arbitrary). We leave the details to the interested reader.
