# THE NEUMANN PROBLEM FOR A CLASS OF FULLY NONLINEAR ELLIPTIC PARTIAL DIFFERENTIAL EQUATIONS

#### Abstract

In this paper, we establish a global $C^{2}$ estimates to the Neumann problem for a class of fullly nonlinear elliptic equations. By the method of continuity, we establish the existence theorem of $k$-admissible solutions of the Neumann problems.


## 1. Introduction

In this paper, we consider the $k$-admissible solutions of the Neumann problem of the fully nonlinear equations

where the matrix $W=\left(w_{\alpha_{1} \cdots \alpha_{m}, \beta_{1} \cdots \beta_{m}}\right)_{C_{n}^{m} \times C_{n}^{m}}$, for $2 \leq m \leq n-1$ and $C_{n}^{m}=\frac{n!}{m!(n-m)!}$, with the elements as follows,

w_{\alpha_{1} \cdots \alpha_{m}, \beta_{1} \cdots \beta_{m}}=\sum_{i=1}^{m} \sum_{j=1}^{n} u_{\alpha_{i} j} \delta_{\beta_{1} \cdots \beta_{i-1} \beta_{i} \beta_{i+1} \cdots \beta_{m}}^{\alpha_{1} \cdots \alpha_{i-1} j \alpha_{i+1} \cdots \alpha_{m}}, \tag{1.2}
\end{equation*}
$$

a linear combination of $u_{i j}$, where $u_{i j}=\frac{\partial^{2} u}{\partial x_{i} \partial x_{j}}$ and $\delta_{\beta_{1} \cdots \beta_{i-1} \beta_{i} \beta_{i+1} \cdots \beta_{m}}^{\alpha_{1} \cdots \alpha_{i-1} \gamma \alpha_{i+1} \cdots \alpha_{m}}$ is the generalized Kronecker symbol. All indexes $i, j, \alpha_{i}, \beta_{i}, \cdots$ come from 1 to $n . f \in C^{\infty}(\Omega)$ is a positive function. And for any $k=1,2, \cdots, C_{n}^{m}$,

S_{k}(W)=S_{k}(\lambda(W))=\sum_{1 \leq i_{1}<i_{2}<\cdots<i_{k} \leq C_{n}^{m}} \lambda_{i_{1}} \lambda_{i_{2}} \cdots \lambda_{i_{k}},
$$

where $\lambda(W)=\left(\lambda_{1}, \lambda_{2}, \cdots, \lambda_{C_{n}^{m}}\right)$ is the eigenvalues of $W$. We also set $S_{0}(W)=1$.
In fact, the matrix $W$ comes from the following operator $U^{[m]}$ as in [4] and [14]. First, we note that $\left(u_{i j}\right)_{n \times n}$ induces an operator $U$ on $\mathbb{R}^{n}$ by

U\left(e_{i}\right)=\sum_{j=1}^{n} u_{i j} e_{j}, \quad \forall 1 \leq i \leq n,

[^0]where $\left\{e_{1}, e_{2}, \cdots, e_{n}\right\}$ is the standard basis of $\mathbb{R}^{n}$. We further extend $U$ to acting on the real vector space $\wedge^{m} \mathbb{R}^{n}$ by

U^{[m]}\left(e_{\alpha_{1}} \wedge \cdots \wedge e_{\alpha_{m}}\right)=\sum_{i=1}^{m} e_{\alpha_{1}} \wedge \cdots \wedge U\left(e_{\alpha_{i}}\right) \wedge \cdots \wedge e_{\alpha_{m}}
$$
where $\left\{e_{\alpha_{1}} \wedge \cdots \wedge e_{\alpha_{m}} \mid 1 \leq \alpha_{1}<\cdots<\alpha_{m} \leq n\right\}$ is the standard basis for $\wedge^{m} \mathbb{R}^{n}$. Then $W$ is the matrix of $U^{[m]}$ under this standard basis. It is convenient to denote the multi-index by $\bar{\alpha}=\left(\alpha_{1} \cdots \alpha_{m}\right)$. We only consider the admissible multi-index, that is, $1 \leq \alpha_{1}<\alpha_{2}, \cdots<\alpha_{m} \leq n$. By the dictionary arrangement, we can arrange all admissible multi-indexes from 1 to $C_{n}^{m}$, and use $N_{\bar{\alpha}}$ denote the order number of the multi-index $\bar{\alpha}=\left(\alpha_{1} \cdots \alpha_{n}\right)$, i.e., $N_{\bar{\alpha}}=1$ for $\bar{\alpha}=(12 \cdots m), \cdots$. We also use $\bar{\alpha}$ denote the index set $\left\{\alpha_{1}, \cdots, \alpha_{n}\right\}$. It is not hard to see that

and

W_{N_{\bar{\alpha}} N_{\bar{\beta}}}=w_{\bar{\alpha} \bar{\beta}}=(-1)^{|i-j|} u_{\alpha_{i} \beta_{j}}, \tag{1.4}
\end{equation*}

if the index set $\left\{\alpha_{1}, \cdots, \alpha_{m}\right\} \backslash\left\{\alpha_{i}\right\}$ equals to the index set $\left\{\beta_{1}, \cdots, \beta_{m}\right\} \backslash\left\{\beta_{j}\right\}$ but $\alpha_{i} \neq \beta_{j}$ ; and also

$$
\begin{equation*}
W_{N_{\bar{\alpha}} N_{\bar{\beta}}}=w_{\bar{\alpha} \bar{\beta}}=0, \tag{1.5}
\end{equation*}

if the index sets $\left\{\alpha_{1}, \cdots, \alpha_{m}\right\}$ and $\left\{\beta_{1}, \cdots, \beta_{m}\right\}$ are differed by more than one elements. It follows that $W$ is symmetric and is diagonal if $\left(u_{i j}\right)_{n \times n}$ is diagonal. The eigenvalues of $W$ are the sums of eigenvalues of $\left(u_{i j}\right)_{n \times n}$.

Define the Garding's cone in $\mathbb{R}^{n}$ as

\Gamma_{k}=\left\{\mu \in \mathbb{R}^{n} \mid S_{i}(\mu)>0, \forall 1 \leq i \leq k\right\} .
$$

Then we define the generalized Garding's cone as, $1 \leq m \leq n, 1 \leq k \leq C_{n}^{m}$,

$$
\Gamma_{k}^{(m)}=\left\{\mu \in \mathbb{R}^{n} \mid\left\{\mu_{i_{1}}+\cdots+\mu_{i_{m}} \mid 1 \leq i_{1}<\cdots<i_{m} \leq n\right\} \in \Gamma_{k} \text { in } \mathbb{R}^{C_{n}^{m}}\right\}
$$

Obviously, $\Gamma_{k}=\Gamma_{k}^{(1)}$ and $\Gamma_{n} \subset \Gamma_{k}^{(m)} \subset \Gamma_{1}$. If the eigenvalues of $D^{2} u$, denoted by $\mu\left(D^{2} u\right)$, is contained in $\Gamma_{k}^{(m)}$ for any $x \in \Omega$, then equivalently $\lambda(W) \in \Gamma_{k}$, such that the equation (1.1) is elliptic (see [4] or [18]). It is naturally to define $k$-admissible solution as follows.

Definition 1.1. We say $u$ is $k$-admissible if $\mu\left(D^{2} u\right) \in \Gamma_{k}^{(m)}$. In addition, if $u$ is a solution of (1.1), we say $u$ is a $k$-admissible solution.

If $m=1$, (1.1) is known as the k -Hessian equation. In particular, (1.1) is the Poisson equation if $k=1$, and the Monge-Ampère equation if $k=n, m=1$.

For the Dirichlet problem in $\mathbb{R}^{n}$, many results are known. For example, the Dirichlet problem of Laplace equation is studied in [9], Caffarelli-Nirenberg-Spruck 3] and Ivochkina [16] solved the Dirichlet problem of Monge-Ampère equation, and Caffarelli-NirenbergSpruck [4] solved the Dirichlet problem of general Hessian equations even including the case considered here. For the general Hessian quotient equation, the Dirichlet problem is solved by Trudinger in [29]. Finally, Guan [8] treated the Dirichlet problem for general fully nonlinear elliptic equation on the Riemannian manifolds without any geometric restrictions to the boundary.

Also, the Neumann or oblique derivative problem of partial differential equations was widely studied. For a priori estimates and the existence theorem of Laplace equation with Neumann boundary condition, we refer to the book [9]. Also, we can see the book written by Lieberman [17] for the Neumann or oblique derivative problem of linear and quasilinear elliptic equations. In 1987, Lions-Trudinger-Urbas solved the Neumann problem of MongeAmpère equation in the celebrated paper [20]. For the the Neumann problem of k-Hessian equations, Trudinger [30] established the existence theorem when the domain is a ball, and he conjectured (in [30], page 305) that one can solve the problem in sufficiently smooth uniformly convex domains. Recently, Ma and Qiu [22] gave a positive answer to this problem and solved the the Neumann problem of k-Hessian equations in uniformly convex domains. After their work, the research on the Neumann problem of other equatios has made many progresses(see [23] [6] [2] [33]).

For general $m$, the $W$-matrix is quite related to the " $m$-convexity" or " $m$-positivity" in differential geometry and partial differential equations. We say a $C^{2}$ function $u$ is $m$-convex if the sum of any $m$ eigenvalues of its Hessian is nonnegative, equivalently, $\mu\left(D^{2} u\right) \in \overline{\Gamma_{C_{n}^{m}}^{(m)}}$ or $\lambda(W) \in \overline{\Gamma_{C_{n}^{m}}}$. Similarly, we can formulate the notion of $m$-convexity for curvature operator and second fundamental forms of hypersurfaces. There are large amount literature in differential geometry on this subject. For example, Sha [27] and Wu [34] introduced the $m$-convexity of the sectional curvature of Riemannian manifolds and studied the topology for these manifolds. In a series interesting papers, Harvey and Lawson [10] [11] [12] introduce some generally convexity on the solutions of the nonlinear elliptic Dirichlet problem, $m$-convexity is a special case. Han-Ma-Wu [14] obtained an existence theorem of $m$-convex starshaped hypersurface with prescribed mean curvature. More recently, in the complex space $\mathbb{C}^{n}$ case, Tosatti and Weinkove 31] 32] solved the Monge-Ampère equation for ( $n-1$ )-plurisubharmonic functions on a compact Kähler manifold, where the ( $n-1$ )-plurisubharmonicity means the sum of any $n-1$ eigenvalues of the complex Hessian is nonnegative.

From the above geometry and analysis reasons, it is naturally to study the Neumann problem for general equation (1.1).

The methods of Ma and Qiu [22] for the problem with $m=1$ can be generalized to our case. The key ingredient in the present paper is to understand the structure of $W$, precisely, to replace the eigenvalues of $D^{2} u$ by the sums of them. For $k \leq C_{n-1}^{m-1}=\frac{m}{n} C_{n}^{m}$, we obtain an existence theorem of the $k$-admissible solution with less geometric restrictions to the boundary. For $m<\frac{n}{2}$ and $k=C_{n-1}^{m-1}+k_{0} \leq \frac{n-m}{n} C_{n}^{m}$, we can obtain an existence theorem if $\Omega$ is strictly ( $m, k_{0}$ )-convex (see Definition 1.2). It seems that as the degree of nonlinearity of the equation (1.1) increases, i.e., $k$ becomes larger, the problem becomes more difficult to solve. Particularly, for $m=n-1$, we get the existence of the $k$-admissible solution for $k \leq n-1$ only except that of the strictly ( $n-1$ )-convex solution for $k=n$. The author will continue to study this case in [7].

A $C^{2}$ domain $\Omega \subset \mathbb{R}^{n}$ is convex, that is, $\kappa_{i}(x) \geq 0$ for any $x \in \partial \Omega$ and $i=1, \cdots, n-1$, or equivalently, $\kappa(x) \in \overline{\Gamma_{n-1}}$ for any $x \in \partial \Omega$, where $\kappa(x)=\left(\kappa_{1}, \cdots, \kappa_{n-1}\right)$ denote the principal curvatures of $\partial \Omega$ with respect to its inner normal $-\nu$. Then, we say $\Omega$ is a strictly $k$-convex domain if $\kappa(x) \in \Gamma_{k}$. To state the results in precise way, we need a definition of $\left(m, k_{0}\right)$-convexity as follows.

Definition 1.2. We say $\Omega$ is a strictly ( $m, k_{0}$ )-convex if $\kappa(x)=\left(\kappa_{1}, \cdots, \kappa_{n-1}\right) \in \Gamma_{k_{0}}^{(m)}$ for any $x \in \partial \Omega$. Obviously, $\Gamma_{n-1} \subset \Gamma_{k_{0}}^{(m)}$ in $\mathbb{R}^{n-1}$, if $k_{0} \leq n$.

We now state the main results of this paper as follows. The case $k \leq C_{n-1}^{m-1}$ is easy to treat so we consider that first.

Theorem 1.3. Suppose $\Omega \subset \mathbb{R}^{n}(n \geq 3)$ is a bounded domain with $C^{4}$ boundary, $2 \leq$ $m \leq n-1$ and $2 \leq k \leq C_{n-1}^{m-1}$. Denote $\nu(x)$ the outer unit normal vector, and $\kappa_{\min }(x)$ the minimum principal curvature at $x \in \partial \Omega$. Let $f \in C^{2}(\Omega)$ is a positive function, and $a, b \in C^{3}(\partial \Omega)$ with $a>0, a+2 \kappa_{\text {min }}>0$. Then there exists a unique $k$-admissible solution $u \in C^{3, \alpha}(\bar{\Omega})$ of the Neumann problem

$$
\left\{\begin{align*}
S_{k}(W) & =f(x), \quad \text { in } \Omega,  \tag{1.6}\\
u_{\nu} & =-a(x) u+b(x), \quad \text { on } \partial \Omega .
\end{align*}\right.
$$

For $k=C_{n-1}^{m-1}+k_{0} \leq \frac{n-m}{n} C_{n}^{m}$, we can settle more cases if $\Omega$ is strictly $\left(m, k_{0}\right)$-convex as in the following theorem.

Theorem 1.4. Suppose $\Omega \subset \mathbb{R}^{n}(n \geq 3)$ is a strictly $\left(m, k_{0}\right)$-convex bounded domain with $C^{4}$ boundary, $2 \leq m \leq \frac{n}{2}$ and $k=C_{n-1}^{m-1}+k_{0} \leq \frac{n-m}{n} C_{n}^{m}$. Denote $\nu(x)$ the outer unit normal vector, and $\kappa_{\text {min }}(x)$ the minimum principal curvature at $x \in \partial \Omega$. Let $f \in C^{2}(\Omega)$
is a positive function, and $a, b \in C^{3}(\partial \Omega)$ with $a>0, a+2 \kappa_{\min }>0$. Then there exists $a$ unique $k$-admissible solution $u \in C^{3, \alpha}(\bar{\Omega})$ of the Neumann problem

$$
\left\{\begin{align*}
S_{k}(W) & =f(x), \quad \text { in } \Omega,  \tag{1.7}\\
u_{\nu} & =-a(x) u+b(x), \quad \text { on } \partial \Omega .
\end{align*}\right.
$$

The rest of this paper is arranged as follows. In section 2, we give some basic properties of the elementary symmetric functions. In section 3 and section 4, we establish $C^{0}$ estimates and the gradient estimates, interior and global. Specifically, we extend the interior gradient estimates in Chou and Wang [5 to our cases. In section 5, we show the proof of the global estimates of second order derivatives. Finally, we can prove the existence theorem by the method of continuity in section 6.

## 2. Preliminary

In this section, we give some basic properties of elementary symmetric functions.
First, we denote by $S_{k}(\lambda \mid i)$ the symmetric function with $\lambda_{i}=0$ and $S_{k}(\lambda \mid i j)$ the symmetric function with $\lambda_{i}=\lambda_{j}=0$.

Proposition 2.1. Let $\lambda=\left(\lambda_{1}, \cdots, \lambda_{n}\right) \in \mathbb{R}^{n}$ and $k=1, \cdots, n$, then

\begin{align*}
& \sigma_{k}(\lambda)=\sigma_{k}(\lambda \mid i)+\lambda_{i} \sigma_{k-1}(\lambda \mid i), \quad \forall 1 \leq i \leq n,  \tag{2.1}\\
& \sum_{i=1}^{n} \lambda_{i} \sigma_{k-1}(\lambda \mid i)=k \sigma_{k}(\lambda)  \tag{2.2}\\
& \sum_{i=1}^{n} \sigma_{k}(\lambda \mid i)=(n-k) \sigma_{k}(\lambda) . \tag{2.3}
\end{align*}
$$

We denote by $S_{k}(W \mid i)$ the symmetric function with $W$ deleting the $i$-row and $i$-column and $S_{k}(W \mid i j)$ the symmetric function with $W$ deleting the $i, j$-rows and $i, j$-columns. We also define the mixed symmetric functions as follows, for $A=\left(a_{i j}\right)_{n \times n}, B=\left(b_{i j}\right)_{n \times n}$, $0 \leq l \leq k \leq n$,

S_{k, l}(A, B)=\frac{1}{k!} \sum \delta_{j_{1} \cdots j_{k-l} j_{k-l+1} \cdots j_{k}}^{i_{1} \cdots i_{k-l} i_{k-l+1} \cdots i_{k}} a_{i_{1} j_{1}} \cdots a_{i_{k-l} j_{k-l}} b_{i_{k-l+1} j_{k-l+1}} \cdots b_{i_{k} j_{k}},
$$

where $\delta_{j_{1} \cdots j_{k-l} j_{k-l+1} \cdots j_{k}}^{i_{1} \cdots i_{k-l} i_{k-l+1} \cdots i_{k}}$ is the Kronecker symbol. It is easy to see that

$$
\begin{equation*}
S_{k}(A+B)=\sum_{i=0}^{k} C_{k}^{i} S_{k, i}(A, B) \tag{2.4}
\end{equation*}
$$

where $C_{k}^{i}=\frac{k!}{i!(k-i)!}$. Then we have the following identities.

Proposition 2.2. Suppose $A=\left(a_{i j}\right)_{n \times n}$ is diagonal, and $k$ is a positive integer, then

$$
\frac{\partial S_{k}(A)}{\partial a_{i j}}= \begin{cases}S_{k-1}(A \mid i), & \text { if } i=j,  \tag{2.5}\\ 0, & \text { if } i \neq j\end{cases}
$$

Furthermore, suppose $W=\left(w_{\bar{\alpha} \bar{\beta}}\right)_{C_{n}^{m} \times C_{n}^{m}}$ defined as in (1.2) is diagonal, then

$$
\frac{\partial S_{k}(W)}{\partial u_{i j}}= \begin{cases}\sum_{i \in \bar{\alpha}} S_{k-1}\left(W \mid N_{\bar{\alpha})},\right. & \text { if } i=j,  \tag{2.6}\\ 0, & \text { if } i \neq j\end{cases}
$$

Proof. For (2.5), see a proof in [18].
Note that

$$
\begin{equation*}
\frac{\partial S_{k}(W)}{\partial u_{i j}}=\sum_{\bar{\alpha}, \bar{\beta}} \frac{\partial S_{k}(W)}{\partial w_{\bar{\alpha} \bar{\beta}}} \frac{\partial w_{\bar{\alpha} \bar{\beta}}}{\partial u_{i j}}, \tag{2.7}
\end{equation*}
$$

Using (1.3), (1.4), and (1.5), (2.6) is immediately a consequence of (2.5).
Recall that the Garding's cone is defined as

$$
\Gamma_{k}=\left\{\lambda \in \mathbb{R}^{n} \mid S_{i}(\lambda)>0, \forall 1 \leq i \leq k\right\} .
$$

Proposition 2.3. Let $\lambda \in \Gamma_{k}$ and $k \in\{1,2, \cdots, n\}$. Suppose that

$$
\lambda_{1} \geq \cdots \geq \lambda_{k} \geq \cdots \geq \lambda_{n}
$$

then we have

$$
\begin{align*}
& S_{k-1}(\lambda \mid n) \geq \cdots \geq S_{k-1}(\lambda \mid k) \geq \cdots \geq S_{k-1}(\lambda \mid 1)>0  \tag{2.8}\\
& \lambda_{1} \geq \cdots \geq \lambda_{k}>0, \quad S_{k-1}(\lambda \mid k) \geq C(n, k) S_{k}(\lambda)  \tag{2.9}\\
& \lambda_{1} S_{k-1}(\lambda \mid 1) \geq \frac{k}{n} S_{k}(\lambda)  \tag{2.10}\\
& S_{k}^{\frac{1}{k}}(\lambda) \text { is concave in } \Gamma_{k} . \tag{2.11}
\end{align*}
$$

where $C_{n}^{k}=\frac{n!}{k!(n-k)!}$ and $C(n, k)$ is a positive constant depends only on $n$ and $k$.
Proof. All the properties are well known. For example, see [18] or [15] for a proof of (2.8), [21] for (2.9), [5] or [13] for (2.10) and [4] for (2.11).

The Newton-Maclaurin inequality is as follows,
Proposition 2.4. For $\lambda \in \Gamma_{k}$ and $k>l \geq 0$, we have

\left(\frac{S_{k}(\lambda)}{C_{n}^{k}}\right)^{\frac{1}{k}} \leq\left(\frac{S_{l}(\lambda)}{C_{n}^{l}}\right)^{\frac{1}{l}} \tag{2.12}
\end{equation*}
$$

where $C_{n}^{k}=\frac{n!}{k!(n-k)!}$. Furthermore we have

$$
\begin{equation*}
\sum_{i=1}^{n} \frac{\partial S_{k}^{\frac{1}{k}}}{\partial \lambda_{i}} \geq\left[C_{n}^{k}\right]^{\frac{1}{k}} \tag{2.13}
\end{equation*}
$$

Proof. See [25] for a proof of (2.12). For (2.13), we use (2.12) and Proposition 2.1] to get

$$
\sum_{i=1}^{n} \frac{\partial S_{k}^{\frac{1}{k}}(\lambda)}{\partial \lambda_{i}}=\frac{1}{k} S_{k}^{\frac{1}{k}-1} \sum_{i=1}^{n} S_{k-1}(\lambda \mid i)=\frac{n-k+1}{k} S_{k}^{\frac{1}{k}-1} S_{k-1}(\lambda) \geq\left[C_{n}^{k}\right]^{\frac{1}{k}}
$$

Then we give some useful inequalities of elementary symmetric functions.
Proposition 2.5. Suppose $\lambda=\left(\lambda_{1}, \cdots, \lambda_{n}\right) \in \Gamma_{k}, k \geq 1$, satisfies $\lambda_{1}<0$. Then we have

\frac{\partial S_{k}(\lambda)}{\partial \lambda_{1}} \geq \frac{1}{n-k+1} \sum_{i=1}^{n} \frac{\partial S_{k}}{\partial \lambda_{i}} \tag{2.14}
\end{equation*}
$$

and

$$
\begin{equation*}
\sum_{i=1}^{n} \frac{\partial S_{k}(\lambda)}{\partial \lambda_{i}} \geq\left(-\lambda_{1}\right)^{k-1}, \quad \forall 1 \leq k \leq n \tag{2.15}
\end{equation*}
$$

Proof. See Lemma 3.9 in [1] for the proof of (2.14), and [6] or [5] for (2.15).
The following proposition is useful to establishments of gradient estimates(for $f=$ $f(x, u, D u)$ ) and double normal estimates(for $m \leq \frac{n}{2}$ ). This proposition also indicates the major difference between our $\operatorname{cases}(m \geq 2)$ and the $k$ - $\operatorname{Hessian}(m=1)$.

Proposition 2.6. Let $\mu=\left(\mu_{1}, \cdots, \mu_{n}\right)$ with $\mu_{1} \geq \cdots \geq \mu_{n}, \lambda=\left\{\mu_{i_{1}}+\mu_{i_{2}}+\cdots+\mu_{i_{m}} \mid 1 \leq\right.$ $\left.i_{1}<i_{2}<\cdots<i_{m} \leq n\right\}$ and $2 \leq k \leq \frac{n-m}{n} C_{n}^{m}$. If $\mu \in \Gamma_{k}^{(m)}$ and $\mu_{n}<-\delta L<0$, where $\delta$ is a small positive constant, then there exits a constant $\theta_{1}=\left(\frac{\delta^{k}}{\left(C_{n}^{m}\right)!4^{k}}\right)^{k-1}$ such that

$$
\begin{equation*}
\sum_{i=1}^{C_{n}^{m}} \frac{\partial S_{k}(\lambda)}{\partial \lambda_{i}} \geq \theta_{1} L^{k-1} \tag{2.16}
\end{equation*}
$$

Furthermore, if in addition that $-\delta_{1} L \leq \lambda_{i} \leq m L, \forall 1 \leq i \leq C_{n}^{m}$, with $\delta_{1}=\frac{\delta^{k}}{\left(C_{n}^{m}\right)!4^{k}}$, then there exists a constant $\theta_{2}=\frac{\delta^{k-1}}{2^{k} m^{k-1}\left(C_{n}^{m}\right)^{3}}$, such that, for $1 \leq j \leq C_{n}^{m}$

$$
\begin{equation*}
\frac{\partial S_{k}(\lambda)}{\partial \lambda_{i}} \geq \theta_{2} \sum_{j=1}^{C_{n}^{m}} \frac{\partial S_{k}(\lambda)}{\partial \lambda_{j}} \tag{2.17}
\end{equation*}
$$

Proof. Let $\lambda_{1} \geq \cdots \geq \lambda_{C_{n}^{m}}$. We consider the following two cases.
Case1. $\lambda_{C_{n}^{m}}<-\delta_{1} L$, where $\delta_{1}=\frac{\delta^{k}}{\left(C_{n}^{m}\right)!4^{k}}$.
It is exactly the case in Proposition [2.5), so we have

\sum_{i=1}^{C_{n}^{m}} \frac{\partial S_{k}(\lambda)}{\partial \lambda_{i}} \geq\left(\delta_{1} L\right)^{k-1} \tag{2.18}
\end{equation*}

Case2. $\lambda_{C_{n}^{m}} \geq-\delta_{1} L$.
We see that

$$

Denote $\lambda^{\prime}=\left(\lambda_{1}, \cdots, \lambda_{p}\right), \lambda^{\prime \prime}=\left(\lambda_{1}, \cdots, \lambda_{q}\right)$, and $\lambda^{\prime \prime \prime}=\left(\lambda_{q+1}, \cdots, \lambda_{C_{n}^{m}}\right)$. We pint out that $\lambda^{\prime \prime \prime}$ may be empty. From (2.19) we see that

and, use $\lambda_{1} \leq m L$ (only for the second inequality of (2.20)) to get

since every element of $\lambda^{\prime \prime}$ is positive.
By Proposition 2.2 and (2.4), we have

\sum_{i=1}^{C_{n}^{m}} \frac{\partial S_{k}(\lambda)}{\partial \lambda_{i}} & =\sum_{i=1}^{C_{n}^{m}} S_{k-1}(\lambda \mid i)=\left(C_{n}^{m}-k+1\right) S_{k-1}(\lambda) \\
& =\left(C_{n}^{m}-k+1\right)\left[S_{k-1}\left(\lambda^{\prime \prime}\right)+\sum_{i=1}^{k-1} C_{k}^{i} S_{k-1, i}\left(\lambda^{\prime \prime}, \lambda^{\prime \prime \prime}\right)\right] \tag{2.22}
\end{align*}
$$

where $S_{k-1, i}\left(\lambda^{\prime \prime}, \lambda^{\prime \prime \prime}\right)$ is the mixed symmetric function. Recall $\delta_{1}=\frac{\delta^{k}}{\left(C_{n}^{m}\right)!4^{k}}$ and (2.20), such that

\left|\sum_{i=1}^{k-1} C_{k}^{i} S_{k-1, i}\left(\lambda^{\prime \prime}, \lambda^{\prime \prime \prime}\right)\right| \leq\left(\frac{\delta}{2}\right)^{k} L^{k-1} \leq \frac{1}{2} S_{k-1}\left(\lambda^{\prime}\right) \tag{2.23}
\end{equation*}
$$

Plug (2.21) and (2.23) into (2.22),

\frac{\left(C_{n}^{m}-k+1\right)}{2} S_{k-1}\left(\lambda^{\prime}\right) \leq \sum_{i=1}^{C_{n}^{m}} \frac{\partial S_{k}(\lambda)}{\partial \lambda_{i}} \leq C_{n}^{m}\left(C_{n}^{m}-k+1\right) S_{k-1}\left(\lambda^{\prime}\right) \tag{2.24}
\end{equation*}
$$

Note that we don't need $\lambda_{i} \leq m L$ in the first inequality. Combining (2.18), (2.20) and (2.24), we prove the (2.16).

We also have

\end{equation*}

Due to $p \geq k, \delta_{1}=\frac{\delta^{k-1}}{\left(C_{n}^{m}\right)!4^{k}},(2.20)$ and (2.24), we have

S_{k-1}(\lambda \mid 1) & \geq \frac{1}{2} S_{k-1}\left(\lambda^{\prime} \mid 1\right) \geq \frac{\delta^{k-1}}{2^{k} m^{k-1} C_{n}^{m}} S_{k-1}\left(\lambda^{\prime}\right) \\
& \geq \frac{\delta^{k-1}}{2^{k} m^{k-1}\left(C_{n}^{m}\right)^{3}} \sum_{i=1}^{C_{n}^{m}} \frac{\partial S_{k}(\lambda)}{\partial \lambda_{i}}
\end{aligned}
$$

Then we proved the (2.17) since $S_{k-1}(\lambda \mid i) \geq S_{k-1}(\lambda \mid 1)$ for $1 \leq i \leq C_{n}^{m}$.
Finally, we give a key inequality which play an important role in the establishment of the double normal derivative estimate(see Theorem (5.4).

Proposition 2.7. Suppose $\lambda=\left(\lambda_{1}, \cdots, \lambda_{n}\right) \in \Gamma_{k}, k \geq 2$, and $\lambda_{2} \geq \cdots \geq \lambda_{n}$. If $\lambda_{1}>0$, $\lambda_{1} \geq \delta \lambda_{2}$, and $\lambda_{n} \leq-\varepsilon \lambda_{1}$ for small positive constants $\delta$ and $\varepsilon$, then we have

\begin{equation*}
S_{l}(\lambda \mid 1) \geq c_{0} S_{l}(\lambda), \quad \forall l=0,1, \cdots, k-1 \tag{2.26}
\end{equation*}
$$

where $c_{0}=\min \left\{\frac{\varepsilon^{2} \delta^{2}}{2(n-2)(n-1)}, \frac{\varepsilon^{2} \delta}{4(n-1)}\right\}$.
One can find a generalized inequality and the proof in [6]. For completeness we give a proof for our case as same as in [22].

Proof. For $l=0$, (2.26) holds directly. In the following, we assume $1 \leq l \leq k-1$.
Firstly, if $\lambda_{1} \geq \lambda_{2}$, we have from (2.10)

It follows from (2.27) and (2.28) that

\end{equation*}

We use $S_{l}(\lambda)=S_{l}(\lambda \mid n)+\lambda_{n} S_{l-1}(\lambda \mid n) \leq S_{l}(\lambda \mid n)$, for $\lambda_{n}<0$, in the second inequality. Then we consider the following two cases.

Case1. $S_{l}(\lambda \mid 1) \geq \theta\left(-\lambda_{n}\right) S_{l-1}(\lambda \mid 1 n), \theta$ is a small positive number to be determined. Use (2.29) directly to obtain

Case2. $S_{l}(\lambda \mid 1)<\theta\left(-\lambda_{n}\right) S_{l-1}(\lambda \mid 1 n)$.
From proposition 2.1] we have

(l+1) S_{l+1}(\lambda \mid 1) & =\sum_{i=2}^{n} \lambda_{i} S_{l}(\lambda \mid 1 i)=\sum_{i=2}^{n} \lambda_{i}\left[S_{l}(\lambda \mid 1)-\lambda_{i} S_{l-1}(\lambda \mid 1 i)\right] \\
& =\sum_{i=}^{n} \lambda_{i} S_{l}(\lambda \mid 1)-\sum_{i=2}^{n} \lambda_{i}^{2} S_{l-1}(\lambda \mid 1 i) \\
& \leq(n-2) \lambda_{2} S_{l}(\lambda \mid 1)-\lambda_{n}^{2} S_{l-1}(\lambda \mid 1 n) \\
& \leq\left(\frac{n-2}{\delta} \theta-\varepsilon\right) \lambda_{1}\left(-\lambda_{n}\right) S_{l-1}(\lambda \mid 1 n)=-\frac{\varepsilon}{2} \lambda_{1}\left(-\lambda_{n}\right) S_{l-1}(\lambda \mid n), \tag{2.31}
\end{align*}
$$

if we choose $\theta=\frac{\varepsilon \delta}{2(n-2)}$ in the last equality. From (2.29), we have

S_{l+1}(\lambda \mid 1) \leq-\frac{\varepsilon^{2} \delta m}{2(n-1)(l+1)} \lambda_{1} S_{l}(\lambda) \tag{2.32}
\end{equation*}
$$

then

\begin{align*}
S_{l}(\lambda \mid 1) & =\frac{S_{l+1}(\lambda)-S_{l+1}(\lambda \mid 1)}{\lambda_{1}} \geq-\frac{S_{l+1}(\lambda \mid 1)}{\lambda_{1}} \\
& \geq \frac{\varepsilon^{2} \delta}{2(l+1)} \frac{l}{n-1} S_{l}(\lambda)>\frac{\varepsilon^{2} \delta}{4(n-1)} S_{l}(\lambda) . \tag{2.33}
\end{align*}
$$

Hence (2.26) holds.

## 3. $C^{0}$ Estimate

Following the idea of Lions-Trudinger-Urbas [20], we prove the following theorem.

Theorem 3.1. Let $\Omega \subset \mathbb{R}^{n}(n \geq 3)$ be a bounded domain with $C^{1}$ boundary, and $\nu$ be the unit outer normal vector of $\partial \Omega$. Suppose that $u \in C^{2}(\bar{\Omega}) \cap C^{3}(\Omega)$ is an $k$-admissible solution of the following Neumann boundary problem,

\left\{\begin{aligned}
S_{k}(W) & =f(x), \quad \text { in } \Omega \\
u_{\nu} & =-a(x) u+b(x), \quad \text { on } \quad \partial \Omega
\end{aligned}\right.
$$

where $f>0$ and $a, b \in C^{3}(\partial \Omega)$ with $\inf _{\partial \Omega} a(x)>\sigma$. Then

$$
\begin{equation*}
\sup _{\bar{\Omega}}|u| \leq \frac{C}{\sigma} \tag{3.1}
\end{equation*}
$$

where $C$ depends on $k, n, a, b, f$ and $\operatorname{diam}(\Omega)$.
Proof. Because $f>0$, the comparison principle tells us that $u$ attains its maximum on the boundary. At the maximum point $x_{0} \in \partial \Omega$ we have

0 \leq u_{\nu}\left(x_{0}\right)=(-a u+b)\left(x_{0}\right)
$$

It implies that

\end{equation*}

Assume $0 \in \Omega$ and let $w=u-A|x|^{2}$. We obtain

F\left[A|x|^{2}\right] \geq f=F[u]
$$

if we choose $A$ large enough depends on $\mathrm{k}, \mathrm{n}$ and $\sup f$. Similarly $w$ attains its minimum on the boundary by comparison principle. At the minimum point $x_{1} \in \partial \Omega$ we have

0 \geq w_{\nu}\left(x_{1}\right)=(-a u+b)\left(x_{1}\right)-2 A x_{0} \cdot \nu
$$

We use $\left.w(x) \geq w_{( } x_{1}\right)$ to get

\begin{equation*}
u(x) \geq-\frac{\left|\inf _{\partial \Omega} b-2 A L(L+1)\right|}{\sup _{\partial \Omega} a} \geq-\frac{\left|\inf _{\partial \Omega} b-2 A L(L+1)\right|}{\inf _{\partial \Omega} a} \tag{3.3}
\end{equation*}
$$

where $L=\operatorname{diam}(\Omega)$. Then we complete the proof of Theorem 3.1.

## 4. Global Gradient estimate

Throughout the rest of this paper, we always admit the Einstein's summation convention. All repeated indices come from 1 to n . We will denote $F\left(D^{2} u\right)=S_{k}(W)$ and

F^{i j}=\frac{\partial F\left(D^{2} u\right)}{\partial u_{i j}}=\frac{\partial S_{k}(W)}{\partial w_{\bar{\alpha} \bar{\beta}}} \frac{\partial w_{\bar{\alpha} \bar{\beta}}}{\partial u_{i j}}
$$

From (1.3) and (2.6) we have, for any $1 \leq j \leq n$,

F^{i i}=\sum_{i \in \bar{\alpha}} \frac{\partial S_{k}(W)}{\partial w_{\overline{\alpha \alpha}}} . \tag{4.1}
\end{equation*}
$$

Throughout the rest of the paper, we will denote $\mathcal{F}=\sum_{i=1}^{n} F^{i i}=m \sum_{N_{\bar{\alpha}}=1}^{C_{n}^{m}} S_{k-1}\left(W \mid N_{\bar{\alpha}}\right)$ for simplicity.
4.1. Interior gradient estimate. Chou-Wang [5] gave the interior gradient estimates for $k$-Hessian equations. In a similar way, we will prove the following theorem.
Theorem 4.1. Let $\Omega \subset \mathbb{R}^{n}(n \geq 3)$ be a bounded domain and $2 \leq k \leq \frac{n-m}{n} C_{n}^{m}$. Suppose that $u \in C^{3}(\Omega)$ is a $k$-admissible solution of the following equation,

$$
\begin{equation*}
S_{k}(W)=f(x, u, D u), \quad \text { in } \Omega \tag{4.2}
\end{equation*}
$$

where $f(x, z, p) \in C^{1}\left(\bar{\Omega} \times\left[-M_{0}, M_{0}\right] \times \mathbb{R}^{n}\right)$ is a nonnegative function, $M_{0}=\sup _{\bar{\Omega}}|u|$. We also assume that

$$
\begin{equation*}
|f|_{C^{0}}+\sum_{i=1}^{n}\left|f_{x_{i}}\right|_{C^{0}}+\left|f_{z}\right|_{C^{0}}+\sum_{i=1}^{n}\left|f_{p_{i}}\right|_{C^{0}}|D u|_{C^{0}} \leq L_{1}\left(1+|D u|_{C^{0}}^{2 k-1}\right), \tag{4.3}
\end{equation*}
$$

for some constant $L_{1}$ independent of $|D u|_{C^{0}}$. For any $B_{r}(y) \subset \Omega$, we have

$$
\begin{equation*}
\sup _{B_{\frac{r}{2}}(y)}|D u| \leq C_{1}+C_{2} \frac{M_{0}}{r}, \tag{4.4}
\end{equation*}
$$

where $C_{1}$ depends only on $M_{0}, L_{1}, n, m$, and $k$, and $C_{2}$ depends only on $L_{1}, n$, $m$, and $k$. Moreover, if $f \equiv$ constant, then $C_{1}=0$.

Proof. Assume $y=0 \in \Omega$ and $B_{r}(0) \subset \Omega$. Choose the auxiliary function as

where $\rho(x)=\left(1-\frac{x^{2}}{r^{2}}\right)^{2}$ such that $|D \rho| \leq b_{0} \rho^{\frac{1}{2}}$ and $\left|\nabla^{2} \rho\right| \leq b_{0}^{2}$, with $b_{0}=\frac{4}{r}$, and $\varphi(u)=$ $(M-u)^{-\frac{1}{2}}$ with $M=4 M_{0}$. It is easy to see that

\varphi^{\prime \prime}-\frac{2\left(\varphi^{\prime}\right)^{2}}{\varphi} \geq \frac{1}{16} M^{-\frac{5}{2}} \tag{4.6}
\end{equation*}

Suppose $G$ attains its maximum at the point $x_{0} \in \Omega=B_{r}(0)$. In the following, all the calculations are at $x_{0}$. First, we have

After a rotation of the coordinates, we may assume that the matrix $\left(u_{i j}\right)_{n \times n}$ is diagonal at $x_{0}$, so are $W$ and $\left(F^{i j}\right)_{n \times n}$. The above identity can be rewrote as

& +2 \varphi\left(\rho_{i} u_{k} u_{k j}+\rho_{j} u_{k} u_{k i}\right)+\rho u_{i j} \varphi^{\prime}|D u|^{2}+\rho \varphi^{\prime \prime}|D u|^{2} u_{i} u_{j} \\
& +\varphi^{\prime \prime}|D u|^{2}\left(\rho_{i} u_{j}+\rho_{j} u_{i}\right)+\rho_{i j} \varphi|D u|^{2} .
\end{align*}
$$

Use the maximum principle to get

0 \geq & F^{i j} G_{i j}=F^{i i} G_{i i}  \tag{4.9}\\
= & 2 \rho \varphi u_{k} F^{i i} u_{i i k}+2 \rho \varphi F^{i i} u_{i i}^{2}+4 \rho \varphi^{\prime} F^{i i} u_{i}^{2} u_{i i}+4 \varphi F^{i i} \rho_{i} u_{i} u_{i i} \\
& +\rho \varphi^{\prime}|D u|^{2} F^{i i} u_{i i}+\rho \varphi^{\prime \prime}|D u|^{2} F^{i i} u_{i}^{2}+2 \varphi^{\prime}|D u|^{2} F^{i i} \rho_{i} u_{i}+F^{i i} \rho_{i i} \varphi|D u|^{2} .
\end{align*}
$$

From the facts that

\begin{equation*}
F^{i i} u_{i i}=k f, \quad F^{i i} u_{i i l}=f_{x_{l}}+f_{z} u_{l}+f_{p_{l}} u_{l l} \tag{4.10}
\end{equation*}
$$

we have

0 \geq & 2 \rho \varphi u_{l}\left(f_{l}+f_{z} u_{l}\right)+2 \rho \varphi f_{p_{l}} u_{l} u_{l l}+2 \rho \varphi F^{i i} u_{i i}^{2} \\
& +4 \rho \varphi^{\prime} F^{i i} u_{i}^{2} u_{i i}+4 \varphi F^{i i} \rho_{i} u_{i} u_{i i}+m f \rho \varphi^{\prime}|D u|^{2}+\rho \varphi^{\prime \prime}|D u|^{2} F^{i i} u_{i}^{2} \\
& +2 \varphi^{\prime}|D u|^{2} F^{i i} \rho_{i} u_{i}+F^{i i} \rho_{i i} \varphi|D u|^{2} .
\end{aligned}
$$

Assume $|D u|\left(x_{0}\right) \geq b_{0}$, otherwise we have (4.4). By (4.3) and (4.7), which used to deal with the second, fourth and fifth terms, then

0 \geq & -4 L_{1}\left(\varphi+\varphi^{\prime}\right)|D u|^{2 k+1}+2 \rho \varphi F^{i i} u_{i i}^{2}-2 \varphi^{\prime}|D u|^{2} F^{i i} u_{i} \rho_{i}-\frac{2 \varphi|D u|^{2}}{\rho} F^{i i} \rho_{i}^{2} \\
& +\left(\varphi^{\prime \prime}-\frac{2 \varphi^{\prime 2}}{\varphi}\right) \rho|D u|^{2} F^{i i} u_{i}^{2}+\varphi|D u|^{2} F^{i i} \rho_{i i} .
\end{aligned}
$$

By (4.6) and properties of $\rho$ we have

\begin{align*}
0 \geq & 2 \rho \varphi F^{i i} u_{i i}^{2}-2 b_{0} \varphi^{\prime} \rho^{\frac{1}{2}}|D u|^{3} \mathcal{F}-3 b_{0}^{2} \varphi|D u|^{2} \mathcal{F} \\

4.2. Gradient estimate near boundary. In this subsection, we will establish a gradient estimate in the small neighborhood near boundary. We use a similar method as in Ma-Qiu [22] with minor changes. We define

## 5. Global Second Order Derivatives Estimates

5.1. Reduce the global second derivative estimates into double normal derivatives estimates on boundary. Using the method of Lions-Trudinger-Urbas [20], we can reduce the second derivative estimates of the solution into the boundary double normal estimates.

Lemma 5.1. Let $\Omega \subset \mathbb{R}^{n}$ be a bounded domain with $C^{4}$ boundary. Assume $f(x, z) \in$ $C^{2}(\bar{\Omega} \times \mathbb{R})$ is positive and $\phi(x, z) \in C^{3}(\bar{\Omega} \times \mathbb{R})$ with $\phi_{z}-2 \kappa_{\min }<0$. If $u \in C^{4}(\Omega) \cap C^{3}(\bar{\Omega})$ is a $k$-admissible solution of the Neumann problem

5.2. Global second order estimates by double normal estimates on boundary. Generally, the double normal estimates are the most important and hardest parts for the Neumann problem. As in [20] and [22], we construct sub and super barrier function to give lower and upper bounds for $u_{\nu \nu}$ on the boundary. Then we give the global second order estimates.
5.2.1. Global second order estimate for Theorem 1.3. In this subsection, we establish the following global second order estimate.

Theorem 5.2. Let $\Omega \subset \mathbb{R}^{n}$ be a bounded domain with $C^{4}$ boundary, $2 \leq m \leq n-1$, and $2 \leq k \leq C_{n-1}^{m-1}$. Assume $f(x, z) \in C^{2}(\bar{\Omega} \times \mathbb{R})$ is positive and $\phi(x, z) \in C^{3}(\bar{\Omega} \times \mathbb{R})$ with $\phi_{z}-2 \kappa_{\text {min }}<0$. If $u \in C^{4}(\Omega) \cap C^{3}(\bar{\Omega})$ is a $k$-admissible solution of the Neumann problem (5.1). Then we have

If $u \in C^{4}(\Omega) \cap C^{3}(\bar{\Omega})$ is a $k$-admissible solution of the Neumann problem (5.1). Then we have

\left|u_{i i}\right| \leq 2 C_{0} N, \quad \forall i \in I . \tag{5.94}
\end{equation*}
$$

Because $u_{11}<0$, and from (2.9) in Proposition [2.3, we have $\lambda_{k}>0$, then $\mu_{i_{1}}>0$. It follows that $\lambda_{k} \geq \lambda_{m_{1}}$. Using (2.8) and (2.9) again, we obtain

$$
\begin{equation*}
F^{11}>S_{k-1}\left(\lambda \mid m_{1}\right) \geq S_{k-1}(\lambda \mid k) \geq C(n, m, k) \mathcal{F} \tag{5.95}
\end{equation*}
$$

Similarly we choose $\beta=\frac{6 n k_{1} C_{0}}{\sigma C(n, m, k)}+2 n k_{1}+1$ and $A>\frac{\beta C_{1}}{k_{3}}$ to get

$$
\begin{equation*}
F^{i j} \bar{P}_{i j}>0 \tag{5.96}
\end{equation*}
$$

This contradicts to that $P$ attains its maximum in the interior of $\Omega_{\mu}$. This contradiction implies that $P$ attains its maximum on the boundary $\partial \Omega_{\mu}$.

On $\partial \Omega$, it is easy to see

$$
\bar{P}=0 .
$$

On $\partial \Omega_{\mu} \cap \Omega$, we have

$$
\bar{P} \leq C_{3}\left(|u|_{C^{1}},|\psi|_{C^{0}}\right)-(A+\sigma N) \frac{\mu}{2} \leq 0
$$

if we take $A=\frac{2 C_{3}}{\mu}+\frac{\beta C_{1}}{k_{3}}+1$. Finally the maximum principle tells us that

$$
\begin{equation*}
\bar{P} \leq 0, \quad \text { in } \quad \Omega_{\mu} \tag{5.97}
\end{equation*}
$$

Suppose $u_{\nu \nu}\left(y_{0}\right)=\inf _{\partial \Omega} u_{\nu \nu}$, we have

$$
\begin{align*}
0 & \leq P_{\nu}\left(y_{0}\right) \\
& \leq\left(u_{r \nu} h_{r}+u_{r} h_{r \nu}-\psi_{\nu}\right)+(A+\sigma N) h_{\nu} \\
& \leq u_{\nu \nu}\left(y_{0}\right)+C\left(|u|_{C^{1}},|\partial \Omega|_{C^{2}},|\psi|_{C^{2}}\right)+(A+\sigma N) \tag{5.98}
\end{align*}
$$

Then we get

$$
\begin{equation*}
\inf _{\partial \Omega} u_{\nu \nu} \geq-C-\sigma N \tag{5.99}
\end{equation*}
$$

Then we prove Theorem 5.4 immediately.
Proof of Theorem 5.4. We choose $\sigma=\frac{1}{2}$ in Lemma 5.6 and 5.7, then

$$
\begin{equation*}
\sup _{\partial \Omega}\left|u_{\nu \nu}\right| \leq C \tag{5.100}
\end{equation*}
$$

Combining (5.100) with (5.2) in Lemma 5.1, we obtain

$$
\begin{equation*}
\sup _{\bar{\Omega}}\left|D^{2} u\right| \leq C \tag{5.101}
\end{equation*}
$$

## 6. Existence of the Neumann boundary problem

We use the method of continuity to prove the existence theorem for the Neumann problem (1.6) and(1.7).

Proof of Theorem 1.3 and 1.4. Consider a family of equations with parameter $t$,

$$
\left\{\begin{array}{l}
S_{k}(W)=t f+(1-t) \frac{\left(C_{n}^{m}\right)!m^{k}}{\left(C_{n}^{m}-k\right)!k!}, \quad \text { in } \Omega,  \tag{6.1}\\
u_{\nu}=-a u+t b+(1-t)\left(x \cdot \nu+\frac{a}{2} x^{2}\right), \quad \text { on } \partial \Omega .
\end{array}\right.
$$

From Theorem 3.1, 4.2, 4.4, 5.2 and 5.4, we get a glabal $C^{2}$ estimate independent of $t$ for the equation (6.1) in both cases of Theorem 1.3 and Theorem 1.4, It follows that the equation (6.1) is uniformly elliptic. Due to the concavity of $S_{k}^{\frac{1}{k}}(W)$ with respect to $D^{2} u$ (see [4]), we can get the global Hölder estimates of second derivatives following the arguments in [19], that is, we can get

$$
\begin{equation*}
|u|_{C^{2, \alpha}} \leq C, \tag{6.2}
\end{equation*}
$$

where $C$ depends only on $n, m, k,|u|_{C^{1}},|f|_{C^{2}}, \min f,|\phi|_{C^{3}}$ and $\Omega$. It is easy to see that $\frac{1}{2} x^{2}$ is a $k$-admissible solution to (6.1) for $t=0$. Applying the method of continuity (see 6], Theorem 17.28), the existence of the classical solution holds for $t=1$. By the standard regularity theory of uniformly elliptic partial differential equations, we can obtain the higher regularity.
