# CONNECTING ORBITS IN HILBERT SPACES AND APPLICATIONS TO P.D.E. 

PANAYOTIS SMYRNELIS


#### Abstract

We prove a general theorem on the existence of heteroclinic orbits in Hilbert spaces, and present a method to reduce the solutions of some P.D.E. problems to such orbits. In our first application, we give a new proof in a slightly more general setting of the heteroclinic double layers (initially constructed by Schatzman [20]), since this result is particularly relevant for phase transition systems. In our second application, we obtain a solution of a fouth order P.D.E. satisfying similar boundary conditions.


## 1. Introduction and Statements

Functional Analysis methods are often useful to solve efficiently P.D.E. problems. We refer to 9, Ch. 10] and 12, Ch. 7 and 9] for some classical applications to evolution equations. The idea is to view a solution $\mathbb{R}^{2} \ni(t, x) \mapsto u(t, x)$ of a P.D.E. as a map $t \mapsto[U(t): x \mapsto[U(t)](x):=u(t, x)]$ taking its values in a space of functions, and reduce the initial P.D.E. to an O.D.E. problem for $U$. For instance, in the case of the heat equation and the wave equation, this reduction is based on the theorem of Hille-Yosida [9, Ch. 10] .

In this paper, we apply this viewpoint to the elliptic system

where $W: \mathbb{R}^{m} \rightarrow \mathbb{R}$ is a function such that

D^{2} W(u)(\nu, \nu) \geq c, \forall u \in \mathbb{R}^{m}:\left|u-a^{ \pm}\right| \leq r, \forall \nu \in \mathbb{R}^{m}:|\nu|=1, \text { with } r, c>0,  \tag{2b}\\

\liminf _{|u| \rightarrow \infty} W(u)>0 .

That is, $W$ is a double well potential (2a), with nondegenerate minima (2b), satisfying moreover the standard asymptotic condition (2c) to ensure the boundedness of finite energy orbits. To clarify the notation, we point out that $\nabla W(u(t, x))$ is the gradient of $W$ evaluated at $u(t, x)$, while $D^{2} W(u)(\nu, \nu)$ stands for the quadratic form $\sum_{i, j=1}^{m} \frac{\partial^{2} W(u)}{\partial u_{i} \partial u_{j}} \nu_{i} \nu_{j}, \forall u=\left(u_{1}, \ldots, u_{m}\right) \in \mathbb{R}^{m}, \forall \nu=\left(\nu_{1}, \ldots, \nu_{m}\right) \in \mathbb{R}^{m}$. We also denote respectively by $|\cdot|$ and $\cdot$, the Euclidean norm and inner product. Finally, given smooth maps $u: \mathbb{R}^{2} \rightarrow \mathbb{R}^{m}, u=\left(u_{1}, \ldots, u_{m}\right)$, and $\phi: \mathbb{R}^{2} \rightarrow \mathbb{R}^{m}, \phi=\left(\phi_{1}, \ldots, \phi_{m}\right)$, we set $|\nabla u|^{2}:=\sum_{i=1}^{m}\left|\nabla u_{i}\right|^{2}$, and $\nabla u \cdot \nabla \phi:=\sum_{i=1}^{m} \nabla u_{i} \cdot \nabla \phi_{i}$.

System (1) as well as the corresponding O.D.E.

have variational structure. We denote by

the associated energy functionals. We also recall that a heteroclinic orbit is a solution $e \in C^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)$ of (3) such that $\lim _{x \rightarrow \pm \infty} e(x)=a^{ \pm}$. A heteroclinic orbit is called minimal if it is a minimizer of the Action functional (5) in the class $A:=\left\{v \in W_{\mathrm{loc}}^{1,2}\left(\mathbb{R} ; \mathbb{R}^{m}\right): \lim _{x \rightarrow \pm \infty} v(x)=a^{ \pm}\right\}$, i.e. if $J_{\mathbb{R}}(e)=\min _{v \in A} J_{\mathbb{R}}(v)=$ : $J_{\min }$. Assuming (2), we know that there exists at least one minima1] heteroclinic orbit $e$ (cf. for instance [7],

[^0][14], [23] or 4], for a general theorem about the existence of heteroclinic connections). In addition, since the minima $a^{ \pm}$are nondegenerate, the convergence to the minima $a^{ \pm}$is exponential for every heteroclinic orbit $e$, i.e.

where the constants $k, K>0$ depend on $e$ (cf. [7, Proposition 6.5.]. Clearly, if $x \mapsto e(x)$ is a heteroclinic orbit, then the maps

obtained by translating $x$, are still heteroclinic orbits.
1.1. Heteroclinic orbits in Hilbert spaces. In the first part of this paper, we establish the existence of minimal heteroclinic orbits in a Hilbert space $\mathcal{H}$, under very mild assumptions (cf. Theorem 1.1 below). Indeed, the potential $\mathcal{W}: \mathcal{H} \rightarrow[0,+\infty]$ is assumed to be weakly lower semicontinuous and to satisfy the standard asymptotic condition (13). For the sake of the applications to P.D.E. (1), we only consider the standard case of a double well potential $\mathcal{W}$ vanishing at $e^{-}$and $e^{+}$, but clearly our approach can be applied to more general potentials vanishing either on finite sets or on manifolds (cf. [7] in the finite dimensional case). Denoting by $\langle\cdot, \cdot\rangle$ (resp. $\|\cdot\|$ ) the inner product (resp. the norm) in $\mathcal{H}$, the minimal heteroclinic $U$ will be obtained as a minimizer of the Action functional:

in the constrained class $\mathcal{A}$ defined by:

\mathcal{A}=\left\{V \in H_{\mathrm{loc}}^{1}(\mathbb{R} ; \mathcal{H}): \begin{array}{ll} 
& \left.\left\langle V(t)-e^{-}, \mathbf{n}\right\rangle \leq 3 l_{0} / 4, \text { for } t \leq t_{V}^{-}, \quad \text { for some } t_{V}^{-}<t_{V}^{+}\right\} \\
& \left\langle V(t)-e^{-}, \mathbf{n}\right\rangle \geq l_{0} / 4, \text { for } t \geq t_{V}^{+},
\end{array}\right.
$$

where $\mathbf{n}:=\frac{e^{+}-e^{-}}{\left\|e^{+}-e^{-}\right\|}$, and $l_{0}:=\left\|e^{+}-e^{-}\right\|$. Note that in the definition of $\mathcal{A}$ no limitation is imposed on the numbers $t_{V}^{-}<t_{V}^{+}$that may largely depend on $V$. We refer to [17], [15], [11] and [8], for the general theory of Sobolev spaces of vector-valued functions.

For nonsmooth potentials, the minimizer $U$ may be considered as a heteroclinic orbit in a generalized sense, since $U(t)$ converges weakly to $e^{ \pm}$, as $t \rightarrow \pm \infty$ (cf. (15a)), and furthermore $U$ satisfies the equipartition relation (15b). To illustrate Theorem 1.1 let us take for example $\mathcal{W}=\chi_{\mathcal{H} \backslash\left\{e^{-}, e^{+}\right\}}$, where $\chi$ is the characterictic function. Then, one obtains in view of (15b) that (up to translations):

U(t)= \begin{cases}e^{-} & \text {for } t \leq 0  \tag{9}\\ e^{-}+\sqrt{2} t \mathbf{n} & \text { for } 0 \leq t \leq l_{0} / \sqrt{2} \\ e^{+} & \text {for } t \geq l_{0} / \sqrt{2}\end{cases}
$$

We refer for instance to [10], [19] or [6], for the study of phase transition problems involving nonsmooth potentials.

In the case where $\mathcal{W} \in C^{1}(\mathcal{H} ; \mathbb{R})$ is smooth, the minimizer $U$ is a classical solution of the system

where given $u \in \mathcal{H}, \nabla \mathcal{W}(u)$ is the element of $\mathcal{H}$ corresponding to $D \mathcal{W}(u) \in \mathcal{H}^{\prime}$ by identifying $\mathcal{H}$ with $\mathcal{H}^{\prime}$ via the isomorphism:

After these explanations, we give the complete statement of Theorem 1.1.
Theorem 1.1. Let $\mathcal{H}$ be a Hilbert spac $\epsilon^{2}$, and assume that $\mathcal{W}: \mathcal{H} \rightarrow[0,+\infty]$ is a weakly lower semicontinuous function satisfying
$\mathcal{W}$ has exactly 2 zeros $e^{-}$and $e^{+}$,

Then, the condition

$$
\begin{equation*}
\inf _{V \in \mathcal{A}} \mathcal{J}_{\mathbb{R}}(V)<+\infty \tag{14}
\end{equation*}

implies that $\mathcal{J}_{\mathbb{R}}$ admits a minimizer $U \in \mathcal{A}$ i.e. $\mathcal{J}_{\mathbb{R}}(U)=\min _{V \in \mathcal{A}} \mathcal{J}_{\mathbb{R}}(V)$, such that

U(t) \rightharpoonup e^{ \pm}, \text {as } t \rightarrow \pm \infty  \tag{15a}\\
\frac{1}{2}\left\|U^{\prime}(t)\right\|^{2}=\mathcal{W}(U(t)) \text { for a.e. } t \in \mathbb{R} \text { (equipartition relation). } \tag{15b}
\end{gather*}

Assuming moreover that $\mathcal{W} \in C^{1}(\mathcal{H} ; \mathbb{R})$, then (14) holds and $U \in C^{2}(\mathbb{R} ; \mathcal{H})$ is a classical solution of (10).
The method of constrained minimization to construct the minimal heteroclinic goes back to [5]. However, most of the arguments used in finite dimensional spaces, fail in the infinite dimensional case due to the lack of compactness. Thus, in order to recover compactness on closed balls, the idea is to work with the weak topology. On the other hand, the convergence in (15a) is established thanks to an argument first introduced in the context of fourth order O.D.E. (cf. [21, Lemma 2.4.]). In what follows, we will see that for some specific potentials, the convergence to the minima $e^{ \pm}$may hold in the strong sense (cf. (25a)).

To apply Theorem 1.1 to P.D.E. problems, one may consider the solution $\mathbb{R} \times \Omega \ni(t, x) \mapsto u(t, x) \in \mathbb{R}^{m}$ (with $\Omega \subset \mathbb{R}^{n}$ ) of a P.D.E., as a connecting orbit $t \mapsto U(t) \in \mathcal{H}, U(t): x \mapsto[U(t)](x):=u(t, x)$, taking its values in a Hilbert space $\mathcal{H}$ of functions, defined according to the boundary conditions satisfied by $u$. Of course, this can be done if the initial equation can be reduced to an O.D.E. similar to (10), and if the boundary conditions satisfied by $u$ are appropriate. The scope of this paper is to provide a method for performing such a reduction, and constructing various kinds of solutions of P.D.E. problems.
1.2. First application: heteroclinic double layers. As a first application of Theorem 1.1 we give a new proof, in a slightly more general setting, of the existence of heteroclinic double layers (established by Schatzman (20), since this result is particularly relevant for the phase transition system (11). Indeed, this construction provides for system (1) the first examples of two-dimensional minimal solutions, in the sense that

\end{equation*}

This notion of minimality is standard for many problems in which the energy of a localized solution is actually infinite due to non compactness of the domain. Assuming that for system (11), with $W$ as in (2), there exist (up to translations) exactly two minimal heteroclinic orbits $e^{-}$and $e^{+}$which are also nondegenerat $\sqrt[3]{3}$, Schatzman constructed a solution of (1) such that

\forall x \in \mathbb{R}: \lim _{t \rightarrow \pm \infty} u(t, x)=e^{ \pm}\left(x-m^{ \pm}\right), \text {for some constants } m^{ \pm} \in \mathbb{R}  \tag{17a}\\
\forall t \in \mathbb{R}: \lim _{x \rightarrow \pm \infty} u(t, x)=a^{ \pm} \tag{17b}
\end{gather*}
$$

Moreover, the convergence in (17b) as well as in (17a) is exponential, due to the nondegeneracy of $a^{ \pm}$and $e^{ \pm}$. This construction has initially been performed by Alama, Bronsard and Gui [1] for potentials $W$ invariant by the reflexion which exchanges $a^{ \pm}$. The symmetry assumption enabled the authors to control the translation parameters $m^{ \pm}$, since they considered only solutions which were equivariant by the reflexion. In [2], the Alama-Bronsard-Gui solution was constructed under the weaker assumption (22), and the existence of an infinity of periodic solutions of (11) was established (cf. also [3]). Recently, new proofs of Schatzman's result were given in [13] (where a Gibbon's type conjecture was also proved), and in [18] via minimization of the Jacobi functional.

[^2]In Theorem 1.2 below we obtain Schatzman's solution as a minimal heteroclinic orbit $U$ connecting $e^{ \pm}$in the appropriate Hilbert space. This construction highlights the real nature of the heteroclinic double layers, and provides a clear interpretation of the equipartition property (34) (already observed in the aforementioned works). The boundary conditions (17b) suggest to set

\mathbf{e}_{0}(x)= \begin{cases}a^{-}, & \text {for } x \leq-1  \tag{18}\\ a^{-}+\left(a^{+}-a^{-}\right) \frac{x+1}{2}, & \text { for }-1 \leq x \leq 1 \\ a^{+}, & \text {for } x \geq 1\end{cases}
$$

and work in the affine subspace $\mathcal{H}:=\mathbf{e}_{0}+L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)=\left\{u=\mathbf{e}_{0}+h: h \in L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)\right\}$ which has the structure of a Hilbert space with the inner product

\langle u, v\rangle_{\mathcal{H}}:=\left\langle\left(u-\mathbf{e}_{0}\right),\left(v-\mathbf{e}_{0}\right)\right\rangle_{L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}, \forall u, v \in \mathcal{H} . \tag{19}
\end{equation*}
$$

We denote by $\|\cdot\|_{\mathcal{H}}$ the norm in $\mathcal{H}$, and by $d_{\mathcal{H}}(u, v):=\|u-v\|_{L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}$ the corresponding distance. We shall also consider the Hilbert space $\tilde{\mathcal{H}}:=\mathbf{e}_{0}+H^{1}\left(\mathbb{R} ; \mathbb{R}^{m}\right)=\left\{u=\mathbf{e}_{0}+h: h \in H^{1}\left(\mathbb{R} ; \mathbb{R}^{m}\right)\right\}$ with the inner product

$$
\begin{equation*}
\langle u, v\rangle_{\tilde{\mathcal{H}}}:=\left\langle\left(u-\mathbf{e}_{0}\right),\left(v-\mathbf{e}_{0}\right)\right\rangle_{H^{1}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}, \forall u, v \in \tilde{\mathcal{H}} \tag{20}
\end{equation*}
$$

Similarly, $\|\cdot\|_{\tilde{\mathcal{H}}}$, and $d_{\tilde{\mathcal{H}}}(u, v):=\|u-v\|_{H^{1}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}$ stand for the norm and the distance in $\tilde{\mathcal{H}}$. In view of (6), it is clear that $e \in \tilde{\mathcal{H}}$, for every minimal heteroclinic $e$.

Next, we define in $\mathcal{H}$ the effective potential $\mathcal{W}: \mathcal{H} \rightarrow[0,+\infty]$ by

\mathcal{W}(u)= \begin{cases}J_{\mathbb{R}}(u)-J_{\min }, & \text { when the distributional derivative } u^{\prime} \in L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)  \tag{21}\\ +\infty, & \text { otherwise }\end{cases}
$$

where $J_{\min }=\min _{v \in A} J_{\mathbb{R}}(v)$. Note that $\mathcal{W} \geq 0$, since $u^{\prime} \in L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)$ implies that $\lim _{x \rightarrow \pm \infty} u(x)=a^{ \pm}$i.e. $u \in A$, and thus $J_{\mathbb{R}}(u) \geq J_{\min }$. It is also obvious that $\mathcal{W}$ only vanishes on the set $F$ of minimal heteroclinics. More generally than in [20, we assume that this set satisfies

F=F^{-} \cup F^{+}, \text {with } F^{-} \neq \varnothing, F^{+} \neq \varnothing, \text { and } d_{\min }:=d_{\mathcal{H}}\left(F^{-}, F^{+}\right)>0 \tag{22}
\end{equation*}

(where $d_{\mathcal{H}}\left(F^{-}, F^{+}\right):=\inf \left\{\left\|e^{-}-e^{+}\right\|_{L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}: e^{-} \in F^{-}, e^{+} \in F^{+}\right\}$). For instance, if $F$ contains (up to translations) a finite number of elements $e_{1}, \ldots, e_{N}$, one may take $F^{-}=\left\{x \mapsto e_{1}\left(x-T_{1}\right): T_{1} \in \mathbb{R}\right\}$, and $F^{+}=\left\{x \mapsto e_{k}\left(x-T_{k}\right): T_{k} \in \mathbb{R}, k=2, \ldots, N\right\}$ (cf. [1] and [20]). In this case it is easy to check that $d_{\mathcal{H}}\left(F^{-}, F^{+}\right)>0$, since the map $\mathbb{R} \ni T \mapsto e^{T}(x)=e(x-T) \in \mathcal{H}$ is continuous for every $e \in F$, and the images of two distinct minimal heteroclinics do not intersect. In Lemma 3.3 below, we give explicit examples of potentials for which (22) holds.

Finally we define the constrained class

\mathcal{A}=\left\{V \in H_{\mathrm{loc}}^{1}(\mathbb{R} ; \mathcal{H}): \begin{array}{l}
\left.d_{\mathcal{H}}\left(V(t), F^{-}\right) \leq d_{\min } / 4, \text { for } t \leq t_{V}^{-}, \quad \text { for some } t_{V}^{-}<t_{V}^{+}\right\} \\
d_{\mathcal{H}}\left(V(t), F^{+}\right) \leq d_{\min } / 4, \text { for } t \geq t_{V}^{+},
\end{array}\right.
$$

and the functiona $\sqrt[5]{5}$

\mathcal{J}_{\mathbb{R}}(V):=\int_{\mathbb{R}}\left[\frac{1}{2}\left\|V^{\prime}(t)\right\|_{L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}^{2}+\mathcal{W}(V(t))\right] \mathrm{d} t \tag{23}
\end{equation*}

Since the effective potential $\mathcal{W}$ has been normalized by substracting the constant $J_{\min }$ from $J_{\mathbb{R}}$, it follows that $\inf _{\mathcal{A}} \mathcal{J}_{\mathbb{R}}<\infty$. All variational constructions of the heteroclinic double layers are based on the minimization of this renormalized energy (cf. also [5] for some other applications). Proceeding as in Theorem 1.1] we are going to show that this solution is actually a minimizer of $\mathcal{J}_{\mathbb{R}}$ in $\mathcal{A}$ :

[^3]Theorem 1.2. Assume the potential $W$ satisfies (2), (22), and one of the following
either there exists $\rho>0$ such that $W(s u) \geq W(u)$ for $s \geq 1$ and $|u|=\rho$.

Then, $\mathcal{J}_{\mathbb{R}}$ admits a minimizer $U \in \mathcal{A}$ i.e. $\mathcal{J}_{\mathbb{R}}(U)=\min _{V \in \mathcal{A}} \mathcal{J}_{\mathbb{R}}(V)$, which is such that
(i) $u \in C^{2}\left(\mathbb{R}^{2} ; \mathbb{R}^{m}\right)$ where $u(t, x):=[U(t)](x), t \mapsto U(t) \in \mathcal{H}$.
(ii) $u$ solves (1) together with the boundary conditions

\lim _{t \rightarrow \pm \infty} d_{\mathcal{H}}\left(U(t), F^{ \pm}\right)=0 \tag{25a}
\end{equation*}

\lim _{x \rightarrow \pm \infty} u(t, x)=a^{ \pm}, \text {uniformly when } t \text { remains bounded. } \tag{25b}
\end{equation*}

(iii) For every $t \in \mathbb{R}$, $u$ satisfies the equipartition relation $\frac{1}{2}\left\|U^{\prime}(t)\right\|_{\mathcal{H}}^{2}=\mathcal{W}(U(t))$, or equivalently:

(iv) $u$ is a minimal solution of (11) (cf. (16)).

In addition, if (24a) holds and $\mathcal{W}$ satisfies the nondegeneracy condition

\liminf _{d_{\mathcal{H}}(u, F) \rightarrow 0} \frac{\mathcal{W}(u)}{\left(d_{\mathcal{H}}(u, F)\right)^{2}}>0 \tag{27}
\end{equation*}
$$

then there exist $e^{ \pm} \in F^{ \pm}$, and constants $k, K>0$ such that

$$
\begin{gather*}
\left\|U(t)-e^{+}\right\|_{\tilde{\mathcal{H}}} \leq K e^{-k t}, \forall t \geq 0, \text { and }\left\|U(t)-e^{-}\right\|_{\tilde{\mathcal{H}}} \leq K e^{k t}, \forall t \leq 0  \tag{28a}\\
\left|u(t, x)-a^{+}\right| \leq K e^{-k x}, \forall t \in \mathbb{R}, \forall x \geq 0, \text { and }\left|u(t, x)-a^{-}\right| \leq K e^{k x}, \forall t \in \mathbb{R}, \forall x \leq 0 \tag{28b}
\end{gather*}
$$

To establish Theorem 1.2, the arguments in the proof of Theorem 1.1 need to be adjusted, since the set $F$ is unbounded. However, $\mathcal{W}$ and $F$ have nice properties, that allow us to address the lack of compactness issue. Indeed, $F$ intersected with closed balls of $\mathcal{H}$ is compact (cf. Lemma 3.2 (i)), and $d_{\tilde{\mathcal{H}}}(u, F) \rightarrow 0$, as $\mathcal{W}(u) \rightarrow 0$ (cf. Lemma 3.1 (ii)).

Theorem 1.2 outlines the hierarchical structure of solutions of (1), since by taking the limit of $u(t, x)$ as $t \rightarrow \pm \infty$ (resp. $x \rightarrow \pm \infty$ ), lower dimensional solutions are obtained. There is also a striking analogy between the functionals $J$ (cf. (5)) and $\mathcal{J}$. On the one hand, the zeros $a^{ \pm}$of $W$ (i.e. the global minimizers of $J$ ) have their counterparts in the minimal heteroclinics $e \in F$, which are the zeros of $\mathcal{W}$ (and the global minimizers of $\mathcal{J}$ ). On the other hand, the heteroclinic orbits of (3) (one dimensional solutions) have their counterparts in the heteroclinic orbit $U$ provided by Theorem 1.2 which corresponds to a two dimensional solution of (11).

Finally, we point out that the shape of heteroclinics can be very complicated (cf. [22]), and that a nondegeneracy assumption similar to (27) is needed to ensure the convergence of the orbit $U$ at $\pm \infty$, even in finite dimensional spaces (cf. [7, Corollary 6.3.]). The nondegeneracy assumption considered in [20] implies the existence of $\alpha, \beta>0$ such that $d_{\tilde{\mathcal{H}}}(u, F) \leq \beta \Rightarrow \mathcal{W}(u) \geq \alpha\left(d_{\tilde{\mathcal{H}}}(u, F)\right)^{2}$ (cf. [20, Lemma 4.5.]). Clearly, this assumption is stronger than (27).
1.3. Second application: In Theorem 1.2 we constructed a heteroclinic orbit $U$ connecting at $\pm \infty$ the subsets $F^{ \pm}$in the Hilbert space $\mathcal{H}$. Going further one may ask: what kind of solution is obtained if instead of $\mathcal{H}$, we consider another space? Assuming that $W$ satisfies (2) as well as

F=F^{-} \cup F^{+}, \text {with } F^{-} \neq \varnothing, F^{+} \neq \varnothing, \text { and } \tilde{d}_{\min }:=d_{\tilde{\mathcal{H}}}\left(F^{-}, F^{+}\right)>0 \tag{29}
\end{equation*}
$$

(cf. subsection 1.2 for the definition of $\tilde{\mathcal{H}}, F$, and $\mathcal{W}$ ), we shall construct in this subsection a heteroclinic orbit $\tilde{U}$ connecting at $\pm \infty$ the subsets $F^{ \pm}$in $\tilde{\mathcal{H}}$. This new orbit $\tilde{U}$ produces a heteroclinic double layers solution $\tilde{u}$ to the fourth order system

$$
\begin{equation*}
\tilde{u}_{t t x x}(t, x)=\Delta \tilde{u}(t, x)-\nabla W(\tilde{u}(t, x)), \tilde{u}: \mathbb{R}^{2} \rightarrow \mathbb{R}^{m} \tag{30}
\end{equation*}
$$

Proceeding as in Theorems 1.1 and 1.2 , we shall establish that $\tilde{U}$ is a minimizer of the functional

$$
\begin{equation*}
\tilde{\mathcal{J}}_{\mathbb{R}}(V):=\int_{\mathbb{R}}\left[\frac{1}{2}\left\|V^{\prime}(t)\right\|_{H^{1}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}^{2}+\mathcal{W}(V(t))\right] \mathrm{d} t \tag{31}
\end{equation*}
$$

in the constrained class

$$
\tilde{\mathcal{A}}=\left\{V \in H_{\mathrm{loc}}^{1}(\mathbb{R} ; \tilde{\mathcal{H}}): \begin{array}{l}
\left.d_{\tilde{\mathcal{H}}}\left(V(t), F^{-}\right) \leq \tilde{d}_{\min } / 4, \text { for } t \leq t_{V}^{-}, \quad \text { for some } t_{V}^{-}<t_{V}^{+}\right\} \\
d_{\tilde{\mathcal{H}}}\left(V(t), F^{+}\right) \leq \tilde{d}_{\min } / 4, \text { for } t \geq t_{V}^{+},
\end{array}\right.
$$

Theorem 1.3. Assume the potential $W$ satisfies (2) and (29). Then, $\tilde{\mathcal{J}}_{\mathbb{R}}$ admits a minimizer $\tilde{U} \in \tilde{\mathcal{A}}$ i.e. $\tilde{\mathcal{J}}_{\mathbb{R}}(\tilde{U})=\min _{V \in \tilde{\mathcal{A}}} \tilde{\mathcal{J}}_{\mathbb{R}}(V)$, which is such that
(i) $\tilde{U} \in C^{2}(\mathbb{R} ; \tilde{\mathcal{H}})$ is a classical solution of system $\tilde{U}^{\prime \prime}(t)=\nabla \mathcal{W}(\tilde{U}(t))$, where $\mathcal{W} \in C^{1}(\tilde{\mathcal{H}} ;[0, \infty))(c f$. Lemma 3.1 (iii)).
(ii) Setting $\tilde{u}(t, x):=[\tilde{U}(t)](x), t \mapsto \tilde{U}(t) \in \tilde{\mathcal{H}}$, we have $\tilde{u} \in H_{\mathrm{loc}}^{1}\left(\mathbb{R}^{2} ; \mathbb{R}^{m}\right)$, $\tilde{u}_{t}$, $\tilde{u}_{t x} \in L^{2}\left(\mathbb{R}^{2} ; \mathbb{R}^{m}\right)$, $\tilde{u}_{x} \in L^{2}\left((\alpha, \beta) \times \mathbb{R} ; \mathbb{R}^{m}\right), \forall[\alpha, \beta] \subset \mathbb{R}$, and $\tilde{u}$ is a weak solution of system (30) :

\int_{\mathbb{R}^{2}}\left(\tilde{u}_{t x} \cdot \phi_{t x}+\nabla \tilde{u} \cdot \nabla \phi+\nabla W(\tilde{u}) \cdot \phi\right)=0, \forall \phi \in C_{0}^{2}\left(\mathbb{R}^{2} ; \mathbb{R}^{m}\right) \tag{32}
\end{equation*}
$$

satisfying the boundary conditions

$$
\begin{gather*}
\lim _{t \rightarrow \pm \infty} d_{\tilde{\mathcal{H}}}\left(\tilde{U}(t), F^{ \pm}\right)=0  \tag{33a}\\
\lim _{x \rightarrow \pm \infty} \tilde{u}(t, x)=a^{ \pm}, \text {uniformly when } t \text { remains bounded. }
\end{gather*}
$$

(iii) For every $t \in \mathbb{R}$, $\tilde{u}$ satisfies the equipartition relation $\frac{1}{2}\left\|\tilde{U}^{\prime}(t)\right\|_{\tilde{\mathcal{H}}}^{2}=\mathcal{W}(\tilde{U}(t))$, or equivalently:

\frac{1}{2} \int_{\mathbb{R}}\left(\left|\tilde{u}_{t}(t, x)\right|^{2}+\left|\tilde{u}_{t x}(t, x)\right|^{2}\right) \mathrm{d} x=\int_{\mathbb{R}}\left[\frac{1}{2}\left|\tilde{u}_{x}(t, x)\right|^{2}+W(\tilde{u}(t, x))\right] \mathrm{d} x-J_{\min } \tag{34}

(iv) $u$ is a minimal solution of system (30) in the sense that

\tilde{E}_{\operatorname{supp} \phi}(\tilde{u}) \leq \tilde{E}_{\operatorname{supp} \phi}(\tilde{u}+\phi), \quad \forall \phi \in C_{0}^{2}\left(\mathbb{R}^{2} ; \mathbb{R}^{m}\right) \tag{35}
\end{equation*}
$$

where $\tilde{E}_{\Omega}(u):=\int_{\Omega}\left[\frac{1}{2}\left(\left|u_{t x}\right|^{2}+|\nabla u|^{2}\right)+W(u)\right]\left(\Omega \subset \mathbb{R}^{2}\right)$, is the energy functional associated to (30). In addition, if $\mathcal{W}$ satisfies the nondegeneracy condition

\liminf _{d_{\tilde{\mathcal{H}}}(u, F) \rightarrow 0} \frac{\mathcal{W}(u)}{\left(d_{\tilde{\mathcal{H}}}(u, F)\right)^{2}}>0 \tag{36}

then there exist $e^{ \pm} \in F^{ \pm}$, and constants $k, K>0$ such that

\begin{equation*}
\left\|\tilde{U}(t)-e^{+}\right\|_{\tilde{\mathcal{H}}} \leq K e^{-k t}, \forall t \geq 0, \text { and }\left\|\tilde{U}(t)-e^{-}\right\|_{\tilde{\mathcal{H}}} \leq K e^{k t}, \forall t \leq 0 \tag{37}
\end{equation*}
$$

and the convergence in 3 B is uniform for $t \in \mathbb{R}$.
1.4. Other possible applications. The previous method applies directly to construct heteroclinic double layers for the systems associated to the energy functionals $E_{\Omega}(u)=\int_{\Omega}\left[\left|\frac{\partial u}{\partial t}\right|^{q}+\left|\frac{\partial u}{\partial x}\right|^{p}+W(u)\right]$, with $p, q \in$ $(1, \infty), u: \mathbb{R}^{2} \rightarrow \mathbb{R}^{m}, \Omega \subset \mathbb{R}^{2}$, and $W$ as in (21). On the other hand, we expect that Theorem 1.1 can be extended to fourth order systems by considering the functional $\mathcal{J}_{\mathbb{R}}(V)=\int_{\mathbb{R}}\left[\frac{1}{2}\left\|V^{\prime \prime}(t)\right\|^{2}+\mathcal{W}\left(V(t), V^{\prime}(t)\right)\right] \mathrm{d} t$ (cf. 21] for the corresponding result in finite dimensional spaces). As a consequence, a heteroclinic double layers solution should be obtained for the system

$$
\Delta^{2} u-\beta \Delta u+\nabla W(u)=0, u: \mathbb{R}^{2} \rightarrow \mathbb{R}^{m}, \beta \geq 0, W: \mathbb{R}^{m} \rightarrow[0, \infty)
$$

which is called the extended Fisher-Kolmogorov equation. Finally, due to the variety of choices for the space $\mathcal{H}$, several types of boundary conditions may be considered in the applications of Theorem 1.1

## 2. Proof of Theorem 1.1

We first notice that since $\mathcal{W}: \mathcal{H} \rightarrow[0,+\infty]$ is weakly lower semicontinuous, the function $t \mapsto \mathcal{W}(V(t))$ is lower semicontinuous (thus measurable), for every $V \in W_{\mathrm{loc}}^{1,2}(\mathbb{R} ; \mathcal{H})$. Assumption (14) is satisfied for instance if $\mathcal{W}$ is bounded on the line segment $\left[e^{-}, e^{+}\right]$. Indeed, in this case the map $\mathbf{V}_{0} \in \mathcal{A}$ defined by

\mathbf{V}_{0}(t)= \begin{cases}e^{-}, & \text {for } t \leq 0  \tag{38}\\ e^{-}+t\left(e^{+}-e^{-}\right), & \text {for } 0 \leq t \leq 1 \\ e^{+}, & \text {for } t \geq 1\end{cases}
$$

is such that $\mathcal{J}_{\mathbb{R}}\left(\mathbf{V}_{0}\right)<+\infty$. In what follows we assume that

$$
\inf _{V \in \mathcal{A}} \mathcal{J}_{\mathbb{R}}(V)<\mathcal{J}_{0}, \text { for a constant } \mathcal{J}_{0}<+\infty
$$

and we set $\mathcal{A}_{b}=\left\{V \in \mathcal{A}: \mathcal{J}_{\mathbb{R}}(V) \leq \mathcal{J}_{0}\right\}$. It is clear that

$$
\inf _{V \in \mathcal{A}} \mathcal{J}_{\mathbb{R}}(V)=\inf _{V \in \mathcal{A}_{b}} \mathcal{J}_{\mathbb{R}}(V)<+\infty
$$

Our next claim is that finite energy orbits are equicontinuous and uniformly bounded:
Lemma 2.1. There exist $M, M^{\prime}>0$ such that $\sup _{\mathbb{R}}\|V(t)\| \leq M$, and $\left\|V\left(t_{2}\right)-V\left(t_{1}\right)\right\| \leq M^{\prime}\left|t_{2}-t_{1}\right|^{1 / 2}$, $\forall t_{1}, t_{2} \in \mathbb{R}, \forall V \in \mathcal{A}_{b}$. Moreover every map $V \in \mathcal{A}_{b}$ satisfies $V(t) \rightharpoonup e^{ \pm}$, as $t \rightarrow \pm \infty$.

Proof. It is clear that for every $t_{1}<t_{2}$, and every $V \in \mathcal{A}_{b}$, we have

$$
\left\|V\left(t_{2}\right)-V\left(t_{1}\right)\right\| \leq \int_{t_{1}}^{t_{2}}\left\|V^{\prime}(s)\right\| \mathrm{d} s \leq\left|\int_{t_{1}}^{t_{2}}\left\|V^{\prime}(s)\right\|^{2} \mathrm{~d} s\right|^{1 / 2}\left|t_{2}-t_{1}\right|^{1 / 2} \leq M^{\prime}\left|t_{2}-t_{1}\right|^{1 / 2}
$$

with $M^{\prime}=\sqrt{2 \mathcal{J}_{0}}$. Next, in view of (13), $\|v\| \geq R$ implies that $\mathcal{W}(v) \geq m$ for some constant $m>0$, and $R>0$ sufficiently large. Thus, for every $V \in \mathcal{A}_{b}$, we have

$$
m \mathcal{L}^{1}(\{t \in \mathbb{R}:\|V(t)\| \geq R\}) \leq \int_{\mathbb{R}} \mathcal{W}(V(t)) \mathrm{d} t \leq \mathcal{J}_{0}
$$

where $\mathcal{L}^{1}$ stands for the one dimensional Lebesgue measure. Assuming that $\|V(t)\|>R$, for some $t \in \mathbb{R}$, it follows that there exists $t_{0}<t$ such that $\left\|V\left(t_{0}\right)\right\|=R$, and $\|V(s)\| \geq R, \forall s \in\left[t_{0}, t\right]$. According to what precedes we can see that $m\left(t-t_{0}\right) \leq \mathcal{J}_{0}$. Hence we deduce that $\left\|V(t)-V\left(t_{0}\right)\right\| \leq M^{\prime}\left(t-t_{0}\right)^{1 / 2} \leq \sqrt{2 / m} \mathcal{J}_{0}$, and $\|V(t)\| \leq R+\sqrt{2 / m} \mathcal{J}_{0}=: M$.

Now, we recall that the ball $B_{M}:=\{v \in \mathcal{H}:\|v\| \leq M\}$ is compact for the weak topology. Let $\mathcal{V}=$ $\left\{v \in \mathcal{H}:\left\langle f_{j}, v-e^{+}\right\rangle<2 \delta, \forall j=1, \ldots, N\right\}$ (with $\delta>0$ and $f_{j} \in \mathcal{H} \backslash\{0\}$ ) be a neighbourhood of $e^{+}$for the weak topology. If we assume by contradiction the existence of a sequence $t_{k}$ such that $\lim _{k \rightarrow \infty} t_{k}=\infty$, and $V\left(t_{k}\right) \notin \mathcal{V}$ (i.e. $\left\langle f_{j_{k}}, V\left(t_{k}\right)-e^{+}\right\rangle \geq 2 \delta$ for some $j_{k} \in\{1, \ldots, N\}$ ), we get

$$
\left\langle f_{j_{k}}, V(t)-e^{+}\right\rangle \geq\left\langle f_{j_{k}}, V(t)-V\left(t_{k}\right)\right\rangle+2 \delta \geq 2 \delta-M^{\prime}\left\|f_{j_{k}}\right\|\left|t-t_{k}\right|^{1 / 2} \geq \delta
$$

provided that $\left|t-t_{k}\right| \leq \eta:=\min _{1 \leq j \leq N}\left(\delta / M^{\prime}\left\|f_{j}\right\|\right)^{2}$. Next, let $\mu$ be the infimum of $\mathcal{W}$ on the set

$$
K_{\delta}:=\left\{v \in B_{M}:\left\langle v-e^{-}, \mathbf{n}\right\rangle \geq l_{0} / 4, \text { and }\left\langle f_{j}, v-e^{+}\right\rangle \geq \delta \text { for some } j \in\{1, \ldots, N\}\right\},
$$

which is compact for the weak topology. The weakly lower semicontinuity of $\mathcal{W}$ and (12), imply that $\mu>0$, thus according to what precedes we have $\mathcal{W}(V(t)) \geq \mu, \forall t \in\left[t_{k}-\eta, t_{k}+\eta\right]$, with $t_{k} \geq t_{V}^{+}+\eta$. Finally, since the intervals $\left[t_{k}-\eta, t_{k}+\eta\right]$ may be assumed to be disjoint, we obtain $\mathcal{J}_{\mathbb{R}}(V)=\infty$, which is a contradiction. This establishes that $V(t) \rightharpoonup e^{+}$, as $t \rightarrow \infty$. Similarly we can prove that $V(t) \rightharpoonup e^{-}$, as $t \rightarrow-\infty$.

Lemma 2.2. Given a sequence $\left\{V_{k}\right\} \subset \mathcal{A}_{b}$, there exist a sequence $\left\{x_{k}\right\} \subset \mathbb{R}$, and a map $U \in \mathcal{A}_{b}$, such that $\mathcal{J}_{\mathbb{R}}(U) \leq \liminf _{k \rightarrow \infty} \mathcal{J}_{\mathbb{R}}\left(V_{k}\right)$, and up to subsequence the maps $\bar{V}_{k}(t):=V_{k}\left(t-x_{k}\right)$ satisfy
(i) $\forall t \in \mathbb{R}: \bar{V}_{k}(t) \rightharpoonup U(t)$, as $k \rightarrow \infty$,
(ii) $\bar{V}_{k}^{\prime} \rightharpoonup U^{\prime}$ in $L^{2}(\mathbb{R}, \mathcal{H})$, as $k \rightarrow \infty$.

Proof. By extracting if necessary a subsequence we may assume that $\mathcal{J}_{\mathbb{R}}\left(V_{k}\right)$ converges to $\lim \inf _{k \rightarrow \infty} \mathcal{J}_{\mathbb{R}}\left(V_{k}\right)$, as $k \rightarrow \infty$. For every $k$ we define the sequence

$$
-\infty<x_{1}(k)<x_{2}(k)<\ldots<x_{2 N_{k}-1}(k)<x_{2 N_{k}}(k)=\infty
$$

by induction:

- $x_{1}(k)=\sup \left\{t \in \mathbb{R}:\left\langle V_{k}(s)-e^{-}, \mathbf{n}\right\rangle \leq 3 l_{0} / 4, \forall s \leq t\right\}<\infty$,
- $x_{2 i}(k)=\sup \left\{t \in \mathbb{R}:\left\langle V_{k}(s)-e^{-}, \mathbf{n}\right\rangle \geq l_{0} / 4, \forall s \in\left[x_{2 i-1}(k), t\right]\right\} \leq \infty$,
- $x_{2 i+1}(k)=\sup \left\{t \in \mathbb{R}:\left\langle V_{k}(s)-e^{-}, \mathbf{n}\right\rangle \leq 3 l_{0} / 4, \forall s \in\left[x_{2 i}(k), t\right]\right\}<\infty$, if $x_{2 i}(k)<\infty$,
where $i=1, \ldots, N_{k}$. In addition, we set
- $y_{2 i-1}(k)=\sup \left\{t \leq x_{2 i-1}(k):\left\langle V_{k}(t)-e^{-}, \mathbf{n}\right\rangle \leq l_{0} / 4\right\}$,
- $y_{2 i}(k)=\sup \left\{t \leq x_{2 i}(k):\left\langle V_{k}(t)-e^{-}, \mathbf{n}\right\rangle \geq 3 l_{0} / 4\right\}$, if $x_{2 i}(k)<\infty$.

Next, we notice that the set $K:=\left\{v \in \mathcal{H}:\|v\| \leq M, l_{0} / 4 \leq\left\langle v-e^{-}, \mathbf{n}\right\rangle \leq 3 l_{0} / 4\right\}$ is compact for the weak topology. As a consequence of (12) and the lower semicontinuity of $\mathcal{W}$, we have $\mathcal{W}_{0}:=\min _{v \in K} \mathcal{W}(v)=\mathcal{W}\left(v_{0}\right)$, for some $v_{0} \in K$, thus $\mathcal{W}_{0}>0$. Finally, since

$$
\mathcal{J}_{\left[y_{j}(k), x_{j}(k)\right]}\left(V_{k}\right) \geq \int_{y_{j}(k)}^{x_{j}(k)} \sqrt{2 \mathcal{W}\left(V_{k}(t)\right)}\left\|V_{k}^{\prime}(t)\right\| \mathrm{d} t \geq \sqrt{\mathcal{W}_{0} / 2} l_{0}
$$

holds for every $k \geq 1$ and $j=1, \ldots, 2 N_{k}-1$, we can see that $\left(2 N_{k}-1\right) \sqrt{\mathcal{W}_{0} / 2} l_{0} \leq \mathcal{J}_{0}$, i.e. the integers $N_{k}$ are uniformly bounded. By passing to a subsequence, we may assume that $N_{k}$ is a constant integer $N \geq 1$.

Our next claim (cf. [21, Lemma 2.4.]) is that up to subsequence, there exist an integer $i_{0}\left(1 \leq i_{0} \leq N\right)$ and an integer $j_{0}\left(i_{0} \leq j_{0} \leq N\right)$ such that
(a) the sequence $x_{2 j_{0}-1}(k)-x_{2 i_{0}-1}(k)$ is bounded,
(b) $\lim _{k \rightarrow \infty}\left(x_{2 i_{0}-1}(k)-x_{2 i_{0}-2}(k)\right)=\infty$,
(c) $\lim _{k \rightarrow \infty}\left(x_{2 j_{0}}(k)-x_{2 j_{0}-1}(k)\right)=\infty$,
where for convenience we have set $x_{0}(k):=-\infty$.
Indeed, we are going to prove by induction on $N \geq 1$, that given $2 N+1$ sequences $-\infty \leq x_{0}(k)<$ $x_{1}(k)<\ldots<x_{2 N}(k) \leq \infty$, such that $\lim _{k \rightarrow \infty}\left(x_{1}(k)-x_{0}(k)\right)=\infty$, and $\lim _{k \rightarrow \infty}\left(x_{2 N}(k)-x_{2 N-1}(k)\right)=\infty$, then up to subsequence the properties (a), (b), and (c) above hold, for two fixed indices $1 \leq i_{0} \leq j_{0} \leq N$. When $N=1$, the assumption holds by taking $i_{0}=j_{0}=1$. Assume now that $N>1$, and let $l \geq 1$ be
the largest integer such that the sequence $x_{l}(k)-x_{1}(k)$ is bounded. Note that $l<2 N$. If $l$ is odd, we are done, since the sequence $x_{l+1}(k)-x_{l}(k)$ is unbounded, and thus we can extract a subsequence $\left\{n_{k}\right\}$ such that $\lim _{k \rightarrow \infty}\left(x_{l+1}\left(n_{k}\right)-x_{l}\left(n_{k}\right)\right)=\infty$. Otherwise $l=2 m$ (with $\left.1 \leq m<N\right)$, and the sequence $x_{2 m+1}(k)-x_{2 m}(k)$ is unbounded. We extract a subsequence $\left\{n_{k}\right\}$ such that $\lim _{k \rightarrow \infty}\left(x_{2 m+1}\left(n_{k}\right)-x_{2 m}\left(n_{k}\right)\right)=\infty$. Then, we apply the inductive statement with $N^{\prime}=N-m$, to the $2 N^{\prime}+1$ sequences $x_{2 m}\left(n_{k}\right)<x_{2 m+1}\left(n_{k}\right)<\ldots<x_{2 N}\left(n_{k}\right)$.

At this stage, we consider appropriate translations of the sequence $\left\{V_{k}\right\}$, by setting $\bar{V}_{k}(t)=V_{k}(t-$ $\left.x_{2 i_{0}-1}(k)\right)$. Since $\left\{\bar{V}_{k}^{\prime}\right\}$ is uniformly bounded in $L^{2}(\mathbb{R}, \mathcal{H})$, it follows that up to subsequence $\bar{V}_{k}^{\prime} \rightharpoonup V$ in $L^{2}(\mathbb{R}, \mathcal{H})$, and moreover

$$
\begin{equation*}
\int_{\mathbb{R}}\|V\|^{2} \leq \liminf _{k \rightarrow \infty} \int_{\mathbb{R}}\left\|\bar{V}_{k}^{\prime}\right\|^{2} \tag{39}
\end{equation*}
$$

On the other hand, we write $\bar{V}_{k}(t)=\bar{V}_{k}(0)+\int_{0}^{t} \bar{V}_{k}^{\prime}(s) \mathrm{d} s$, and notice that up to subsequence $\bar{V}_{k}(0) \rightharpoonup u_{0}$ in $\mathcal{H}$, since $\left\|\bar{V}_{k}(0)\right\| \leq M$ (cf. Lemma 2.1). Our claim is that $U(t):=u_{0}+\int_{0}^{t} V(s) \mathrm{d} s$ has all the desired properties. Indeed, since $\int_{0}^{t} \bar{V}_{k}^{\prime}(s) \mathrm{d} s \rightharpoonup \int_{0}^{t} V(s) \mathrm{d} s$ holds in $\mathcal{H}$ for every $t \in \mathbb{R}$, we also have $\bar{V}_{k}(t) \rightharpoonup U(t)$ for every $t \in \mathbb{R}$. In view of the weakly lower semicontinuity of $\mathcal{W}$, this implies that $\liminf _{k \rightarrow \infty} \mathcal{W}\left(\bar{V}_{k}(t)\right) \geq \mathcal{W}(U(t))$ for every $t \in \mathbb{R}$, thus by Fatou's Lemma we obtain

$$
\begin{equation*}
\int_{\mathbb{R}} \mathcal{W}(U(t)) \mathrm{d} t \leq \liminf _{k \rightarrow \infty} \int_{\mathbb{R}} \mathcal{W}\left(\bar{V}_{k}(t)\right) \mathrm{d} t \tag{40}
\end{equation*}
$$

Combining (39) with (40) it is clear that $\mathcal{J}_{\mathbb{R}}(U) \leq \liminf _{k \rightarrow \infty} \mathcal{J}_{\mathbb{R}}\left(V_{k}\right)$. To conclude it remains to show that $U \in \mathcal{A}$. In view of the above property (b) it follows that $\left\langle U(t)-e^{-}, \mathbf{n}\right\rangle \leq 3 l_{0} / 4$, for every $t \leq 0$. Similarly, in view of (a) and (c), we have $\left\langle U(t)-e^{-}, \mathbf{n}\right\rangle \geq l_{0} / 4$, for $t \geq T>0$ large enough.

Applying Lemma 2.2 to a minimizing sequence i.e. $\left\{V_{k}\right\} \subset \mathcal{A}_{b}$ such that

$$
\lim _{k \rightarrow \infty} \mathcal{J}_{\mathbb{R}}\left(V_{k}\right)=\inf _{V \in \mathcal{A}_{b}} \mathcal{J}_{\mathbb{R}}(V)
$$

we immediately obtain the existence of the minimizer $U$. To show that the minimizer $U$ satisfies the equipartition property (ii) we are going to check that

$$
\begin{equation*}
0=\int_{\mathbb{R}}\left(\frac{1}{2}\left\|U^{\prime}(t)\right\|^{2}-\mathcal{W}(U(t))\right) \phi(t) \mathrm{d} t, \forall \phi \in C_{0}^{\infty}(\mathbb{R} ; \mathbb{R}) \tag{41}
\end{equation*}
$$

Actually, since every $\phi \in C_{0}^{\infty}(\mathbb{R} ; \mathbb{R})$ is the uniform limit of step functions, we just need to prove that

$$
\begin{equation*}
\int_{a}^{b} \frac{1}{2}\left\|U^{\prime}(t)\right\|^{2}=\int_{a}^{b} \mathcal{W}(U(t)) \mathrm{d} t, \forall[a, b] \subset \mathbb{R} \tag{42}
\end{equation*}
$$

For every $\kappa>0$, let

$$
V_{\kappa}(t)= \begin{cases}U(t), & \text { for } t \leq a \\ U\left(a+\frac{t-a}{\kappa}\right), & \text { for } t \in[a, a+\kappa(b-a)] \\ U(t+(1-\kappa)(b-a)), & \text { for } t \geq a+\kappa(b-a)\end{cases}
$$

It is easy to see that $V_{\kappa} \in \mathcal{A}$ and,

$$
\begin{equation*}
\mathcal{J}_{\mathbb{R}}\left(V_{\kappa}\right)-\mathcal{J}_{\mathbb{R}}(U)=\int_{a}^{b} \frac{(1-\kappa)}{2 \kappa}\left\|U^{\prime}(t)\right\|^{2}+(\kappa-1) \int_{a}^{b} \mathcal{W}(U(t)) \mathrm{d} t \tag{43}
\end{equation*}
$$

Since $\mathcal{J}_{\mathbb{R}}\left(V_{\kappa}\right)-\mathcal{J}_{\mathbb{R}}(U) \geq 0$ by the minimality of $U$, letting $\kappa \rightarrow 1^{+}$and $\kappa \rightarrow 1^{-}$in (43), we obtain (42).
Finally we assume that $\mathcal{W} \in C^{1}(\mathcal{H} ; \mathbb{R})$. Given $\xi \in C_{0}^{\infty}(\mathcal{H} ; \mathbb{R})$, and $\lambda \in \mathbb{R}$, we compute

$$
\left.\frac{\mathrm{d}}{\mathrm{~d} \lambda}\right|_{\lambda=0} \mathcal{J}_{\mathbb{R}}(U+\lambda \xi)=\int_{\mathbb{R}}\left[\left\langle U^{\prime}(t), \xi^{\prime}(t)\right\rangle+\langle\nabla \mathcal{W}(U(t)), \xi(t)\rangle\right] \mathrm{d} t
$$

By the minimality of $U$, we have $\mathcal{J}_{\mathbb{R}}(U+\lambda \xi)-\mathcal{J}_{\mathbb{R}}(U) \geq 0$, hence

$$
\int_{\mathbb{R}}\left[\left\langle U^{\prime}(t), \xi^{\prime}(t)\right\rangle+\langle\nabla \mathcal{W}(U(t)), \xi(t)\rangle\right] \mathrm{d} t=0
$$

This implies that the derivative of $t \mapsto U^{\prime}(t)$ in $\mathcal{D}^{\prime}(\mathbb{R} ; \mathcal{H})$ is $t \mapsto \nabla \mathcal{W}(U(t))$ and that $U \in C^{2}(\mathbb{R} ; \mathcal{H})$ is a classical solution of (10).

## 3. Properties of the effective potential $\mathcal{W}$ and of the set of minimal heteroclinics $F$

We establish below some properties of the effective potential $\mathcal{W}$ defined in subsection 1.2, assuming that the function $W$ satisfies (2):
Lemma 3.1. (i) The potential $\mathcal{W}$ is sequentially weakly lower semicontinuous.
(ii) Let $\left\{u_{k}\right\} \subset \mathcal{H}$ be such that $\lim _{k \rightarrow \infty} \mathcal{W}\left(u_{k}\right)=0$. Then, there exist a sequence $\left\{x_{k}\right\} \subset \mathbb{R}$, and $e \in F$, such that (up to subsequence) the maps $\bar{u}_{k}(x):=u_{k}\left(x-x_{k}\right)$ satisfy $\lim _{k \rightarrow \infty}\left\|\bar{u}_{k}-e\right\|_{H^{1}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}=0$. As a consequence, $d_{\tilde{\mathcal{H}}}(u, F) \rightarrow 0$, as $\mathcal{W}(u) \rightarrow 0$, and for every $c_{1}>0$, there exists $c_{2}>0$ such that $d_{\mathcal{H}}(u, F) \geq c_{1}\left(\right.$ resp. $\left.d_{\tilde{\mathcal{H}}}(u, F) \geq c_{1}\right) \Rightarrow \mathcal{W}(u) \geq c_{2}$.
(iii) $\mathcal{W}$ restricted to $\tilde{\mathcal{H}}$ is a $C^{1}(\tilde{\mathcal{H}} ;[0, \infty))$ smooth function, and $D \mathcal{W}(u) h=\int_{\mathbb{R}}\left[u^{\prime} \cdot h^{\prime}+\nabla W(u) \cdot h\right], \forall u \in \tilde{\mathcal{H}}$, $\forall h \in H^{1}\left(\mathbb{R} ; \mathbb{R}^{m}\right)$.
Proof. (i) Let $\left\{u_{k}\right\} \subset \mathcal{H}$ be such that $u_{k} \rightharpoonup u$ in $\mathcal{H}$ (i.e. $u_{k}-u \rightharpoonup 0$ in $L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)$ ), and let us assume that $l=\liminf _{k \rightarrow \infty} \mathcal{W}\left(u_{k}\right)<\infty$ (since otherwise the statement is trivial). By extracting a subsequence we may assume that $\lim _{k \rightarrow \infty} \mathcal{W}\left(u_{k}\right)=l$. In view of Lemma 2.1 (applied in the finite dimensional case with $W$ instead of $\mathcal{W}$ ), the sequence $\left\{u_{k}\right\}$ is equicontinuous and uniformly bounded. Thus, the theorem of Ascoli implies that $u_{k} \rightarrow \tilde{u}$ in $C_{\text {loc }}\left(\mathbb{R} ; \mathbb{R}^{m}\right)$, as $k \rightarrow \infty$ (up to subsequence). On the other hand, since $\left\|u_{k}^{\prime}\right\|_{L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}$ is bounded, we have that $u_{k}^{\prime} \rightharpoonup v$, in $L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)$ (up to subsequence). In addition, one can easily see that $u=\tilde{u} \in H_{\mathrm{loc}}^{1}\left(\mathbb{R} ; \mathbb{R}^{m}\right)$, and $u^{\prime}=v$. Finally, by the weakly semicontinuity of the $L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)$ norm and Fatou's Lemma (cf. the end of the proof of Lemma 2.2), we deduce that $\mathcal{W}(u) \leq l$, i.e. $\mathcal{W}(u) \leq \liminf _{k \rightarrow \infty} \mathcal{W}\left(u_{k}\right)$.
(ii) We first establish that given $u \in \mathcal{H}$ such that $u^{\prime} \in L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)$, and $e \in F$, we have

$$
\begin{equation*}
\mathcal{W}(u)=\int_{\mathbb{R}}\left[\frac{1}{2}\left|u^{\prime}-e^{\prime}\right|^{2}+W(u)-W(e)-\nabla W(e) \cdot(u-e)\right] \tag{44}
\end{equation*}
$$

In view of (6), it is clear that $e^{\prime \prime}=\nabla W(e) \in L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)$, thus $e^{\prime} \in H^{1}\left(\mathbb{R} ; \mathbb{R}^{m}\right)$. As a consequence, we can see that $\int_{\mathbb{R}} e^{\prime \prime} \cdot(u-e)=-\int_{\mathbb{R}} e^{\prime} \cdot\left(u^{\prime}-e^{\prime}\right)$, and

$$
\begin{aligned}
\mathcal{W}(u) & =\int_{\mathbb{R}}\left[\frac{1}{2}\left|u^{\prime}\right|^{2}-\frac{1}{2}\left|e^{\prime}\right|^{2}+W(u)-W(e)\right] \\
& =\int_{\mathbb{R}}\left[\frac{1}{2}\left|u^{\prime}\right|^{2}-\frac{1}{2}\left|e^{\prime}\right|^{2}-e^{\prime} \cdot\left(u^{\prime}-e^{\prime}\right)+W(u)-W(e)-e^{\prime \prime} \cdot(u-e)\right]
\end{aligned}
$$

from which (44) follows.
Now, we consider a sequence $\left\{u_{k}\right\} \subset \mathcal{H}$ such that $\lim _{k \rightarrow \infty} \mathcal{W}\left(u_{k}\right)=0$. According to Lemma 2.2, there exist a sequence $\left\{x_{k}\right\} \subset \mathbb{R}$, and $e \in F$, such that (up to subsequence) the maps $\bar{u}_{k}(x):=u_{k}\left(x-x_{k}\right)$ satisfy

$$
\begin{equation*}
\lim _{k \rightarrow \infty} \bar{u}_{k}(x)=e(x), \forall x \in \mathbb{R} \tag{45}
\end{equation*}
$$

Having a closer look at the proof of Lemma 2.2, we can show that in the case of a finite dimensional space, the convergence in (45) actually holds in $C_{\text {loc }}\left(\mathbb{R} ; \mathbb{R}^{m}\right)$.

Our claim is that

$$
\begin{equation*}
\lim _{k \rightarrow \infty}\left\|\bar{u}_{k}-e\right\|_{H^{1}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}=0 \tag{46}
\end{equation*}
$$

According to hypothesis (2b) we have

$$
\begin{gather*}
W(u) \geq \frac{c}{2}\left|u-a^{ \pm}\right|^{2}, \forall u:\left|u-a^{ \pm}\right| \leq r  \tag{47a}\\
W(v)-W(u)-\nabla W(u) \cdot(v-u) \geq \frac{c}{2}|v-u|^{2}, \forall u, v:\left|u-a^{ \pm}\right| \leq r,\left|v-a^{ \pm}\right| \leq r . \tag{47~b}
\end{gather*}
$$

[^4]Let $\mu>0$ be such that

$$
\begin{equation*}
W(u) \leq \frac{\mu}{2}\left|u-a^{ \pm}\right|^{2}, \forall u \in \mathbb{R}^{m}:\left|u-a^{ \pm}\right| \leq r \tag{48}
\end{equation*}
$$

let $\epsilon \in(0, r)$, and let $\nu$ be a unit vector of $\mathbb{R}^{m}$. We notice using (48) that the map $[0,1] \ni x \mapsto z(x)=a^{ \pm}+\epsilon \nu x$, is such that $J_{[0,1]}(z) \leq \frac{\mu+1}{2} \epsilon^{2}$. As a consequence,

$$
\begin{equation*}
\inf \left\{J_{[\alpha, \beta]}(v): v \in H^{1}\left([\alpha, \beta] ; \mathbb{R}^{m}\right),\left|v(\alpha)-a^{-}\right|=\epsilon,\left|v(\beta)-a^{+}\right|=\epsilon\right\} \geq J_{\min }-(\mu+1) \epsilon^{2} \tag{49}
\end{equation*}
$$

since otherwise we can construct a map in $A$ whose action is less than $J_{\min }$. On the other hand we have

$$
\begin{equation*}
\inf \left\{J_{[\alpha, \beta]}(v): v \in H^{1}\left([\alpha, \beta] ; \mathbb{R}^{m}\right),\left|v(\alpha)-a^{ \pm}\right|=\epsilon,\left|v(\beta)-a^{ \pm}\right|=r\right\} \geq \sqrt{c}(r-\epsilon) \epsilon \tag{50}
\end{equation*}
$$

Indeed, for such a map $v$, we can check that

$$
J_{[\alpha, \beta]}(v) \geq \int_{\alpha}^{\beta} \sqrt{2 W(v)}\left|v^{\prime}\right| \geq \sqrt{c}(r-\epsilon) \epsilon
$$

Let $\epsilon_{0} \in(0, r)$ be such that $(\mu+2) \epsilon^{2}<\sqrt{c}(r-\epsilon) \epsilon, \forall \epsilon<\epsilon_{0}$. Next, for $\epsilon<\epsilon_{0}$ fixed, choose an interval $\left[\lambda^{-}, \lambda^{+}\right]$ such that $\left|e(x)-a^{-}\right| \leq \epsilon / 2, \forall x \leq \lambda^{-}$, and $\left|e(x)-a^{+}\right| \leq \epsilon / 2, \forall x \geq \lambda^{+}$. According to (45), we have for $k \geq N$ large enough:

$$
\begin{gather*}
\left|\bar{u}_{k}\left(\lambda^{ \pm}\right)-a^{ \pm}\right|<\epsilon  \tag{51a}\\
\left|\int_{\left[\lambda^{-}, \lambda^{+}\right]}\left(W\left(\bar{u}_{k}\right)-W(e)-\nabla W(e) \cdot\left(\bar{u}_{k}-e\right)\right)\right|<\epsilon^{2},  \tag{51b}\\
\left\|\bar{u}_{k}-e\right\|_{L^{2}\left(\left[\lambda^{-}, \lambda^{+}\right] ; \mathbb{R}^{m}\right)}<\epsilon  \tag{51c}\\
\mathcal{W}\left(\bar{u}_{k}\right)<\epsilon^{2} \tag{51~d}
\end{gather*}
$$

Then, combining (49) with (51d), one can see that

$$
\begin{equation*}
J_{\mathbb{R} \backslash\left[\lambda^{-}, \lambda^{+}\right]}\left(\bar{u}_{k}\right)<(\mu+2) \epsilon^{2}<\sqrt{c}(r-\epsilon) \epsilon \tag{52}
\end{equation*}
$$

Therefore, in view of (50) and (51a), it follows that $\left|\bar{u}_{k}(x)-a^{-}\right| \leq r$ (resp. $\left.\left|\bar{u}_{k}(x)-a^{+}\right| \leq r\right), \forall x \leq \lambda^{-}$(resp. $\forall x \geq \lambda^{+}$). Furthermore, as a consequence of 47b we get

$$
\begin{equation*}
\int_{\mathbb{R} \backslash\left[\lambda^{-}, \lambda^{+}\right]}\left(W\left(\bar{u}_{k}\right)-W(e)-\nabla W(e) \cdot\left(\bar{u}_{k}-e\right)\right) \geq \frac{c}{2}\left\|\bar{u}_{k}-e\right\|_{L^{2}\left(\mathbb{R} \backslash\left[\lambda^{-}, \lambda^{+}\right] ; \mathbb{R}^{m}\right)}^{2} \tag{53}
\end{equation*}
$$

To conclude, we apply formula (44) to $\bar{u}_{k}$, and combine (51d) with (51b) and (53), to obtain

$$
\begin{equation*}
\left\|\bar{u}_{k}-e\right\|_{L^{2}\left(\mathbb{R} \backslash\left[\lambda^{-}, \lambda+\right] ; \mathbb{R}^{m}\right)}<\frac{2 \epsilon}{\sqrt{c}}, \text { and }\left\|\bar{u}_{k}^{\prime}-e^{\prime}\right\|_{L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}<2 \epsilon \tag{54}
\end{equation*}
$$

Finally, in view of (51c), we have $\left\|\bar{u}_{k}-e\right\|_{L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}<\left(1+\frac{2}{\sqrt{c}}\right) \epsilon$. This establishes our claim (46), from which the statement (ii) of Lemma 3.1 is straightforward.
(iii) We recall that $\sigma:=\sup _{e \in F}\|e\|_{L^{\infty}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}<\infty$ (cf. Lemma 2.1). Given $u \in \tilde{\mathcal{H}}$, set $\kappa_{1}:=\max \left(\|u\|_{L^{\infty}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}, \sigma\right)$, and $\kappa_{2}:=\sup \left\{\left|D^{2} W(v)(\nu, \nu)\right|:|v| \leq 2 \kappa_{1},|\nu|=1\right\}$. From formula (44), it is clear that

$$
\mathcal{W}(u) \leq \frac{1}{2}\left\|u^{\prime}-e^{\prime}\right\|_{L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}^{2}+\frac{\kappa_{2}}{2}\|u-e\|_{L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}^{2}<\infty
$$

On the other hand, one can see that $\nabla W(u) \in L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)$. Furthermore, when $\|h\|_{H^{1}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}$ is small enough, such that $\|h\|_{L^{\infty}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}<\kappa_{1}$, we have

$$
\left|\mathcal{W}(u+h)-\mathcal{W}(u)-\int_{\mathbb{R}}\left[u^{\prime} \cdot h^{\prime}+\nabla W(u) \cdot h\right]\right| \leq \frac{1}{2}\left\|h^{\prime}\right\|_{L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}^{2}+\frac{\kappa_{2}}{2}\|h\|_{L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}^{2}
$$

This proves that $\mathcal{W}$ is differentiable at $u$, and $D \mathcal{W}(u) h=\int_{\mathbb{R}}\left[u^{\prime} \cdot h^{\prime}+\nabla W(u) \cdot h\right]$.
From the arguments in the proof of Lemma 3.1] we deduce some useful properties of the set $F$ (defined in subsection (1.2).

Lemma 3.2. (i) Let $\left\{e_{k}\right\} \subset F$ be bounded in $\mathcal{H}$, then there exists $e \in F$, such that up to subsequence $\lim _{k \rightarrow \infty}\left\|e_{k}-e\right\|_{H^{1}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}=0$.
(ii) There exists a constant $\gamma>0$, such that for every $e \in F$, we can find $T \in \mathbb{R}$ such that setting $e^{T}(x)=e(x-T)$, we have $\left\|e^{T}\right\|_{\tilde{\mathcal{H}}} \leq \gamma$.
(iii) For every $v \in \mathcal{H}$ (resp. $v \in \tilde{\mathcal{H}}$ ), there exists $e \in F$ such that $d_{\mathcal{H}}(v, F)=\|v-e\|_{\mathcal{H}}\left(\right.$ resp. $d_{\tilde{\mathcal{H}}}(v, F)=$ $\left.\|v-e\|_{\tilde{\mathcal{H}}}\right)$.
Proof. (i) Since $\left\{e_{k}\right\} \subset F$ is bounded in $\mathcal{H}$, we have up to subsequence $e_{k} \rightharpoonup e$ in $\mathcal{H}$, as $k \rightarrow \infty$, for some $e \in \mathcal{H}$. Proceeding as in the proof of Lemma 3.1 (i), we first obtain that (up to subsequence) $e_{k} \rightarrow e$ in $C_{\text {loc }}\left(\mathbb{R} ; \mathbb{R}^{m}\right)$, as $k \rightarrow \infty$, with $e \in F$. Next, we reproduce the arguments after (46), with $e_{k}$ instead of $\bar{u}_{k}$.
(ii) Assume by contradiction the existence of a sequence $\mathbb{N} \ni k \mapsto e_{k} \in F$, such that $\left\|e_{k}^{T}\right\|_{\tilde{\mathcal{H}}} \geq k, \forall T \in \mathbb{R}$. Then, by Lemma 3.1 (ii), there exists a sequence $\left\{x_{k}\right\} \subset \mathbb{R}$, and $e \in F$, such that (up to subsequence) the maps $e_{k}^{x_{k}}$ satisfy $\lim _{k \rightarrow \infty}\left\|e_{k}^{x_{k}}-e\right\|_{\tilde{\mathcal{H}}}=0$. Clearly, this is a contradiction.
(iii) Let $\left\{e_{k}\right\} \subset F$ be a sequence such that $\left\|v-e_{k}\right\|_{\mathcal{H}} \leq d_{\mathcal{H}}(v, F)+\frac{1}{k}, \forall k$. Then, in view of (i) we have (up to subsequence) $e_{k} \rightarrow e$ in $\mathcal{H}$, as $k \rightarrow \infty$, with $e \in F$. As a consequence $d_{\mathcal{H}}(v, F)=\|v-e\|_{\mathcal{H}}$.

In Lemma 3.3 below, we give examples of potentials for which assumption (22) holds.
Lemma 3.3. Let $W \in C^{2}\left(\mathbb{R}^{2} ; \mathbb{R}\right)$ be a potential satisfying (2). In addition we assume that

- $W\left(u_{1}, u_{2}\right)=W\left(u_{1},-u_{2}\right)$,
- $a^{ \pm}=( \pm \lambda, 0)$,
- the heteroclinic orbit $\eta$ taking its values onto the open line segment ( $a^{-}, a^{+}$) is not minimal $\square^{7}$

Then, $F$ is partitioned into two nonempty sets $F^{ \pm}$, such that $d_{\mathcal{H}}\left(F^{-}, F^{+}\right)>0$.
Proof. By symmetry, if $x \mapsto\left(e_{1}(x), e_{2}(x)\right) \in \mathbb{R}^{2}$ is a minimal heteroclinic orbit, then $x \mapsto\left(e_{1}(x),-e_{2}(x)\right)$ is also a minimal heteroclinic orbit. Since the images of two distinct minimal heteroclinic orbits do not intersect, and the heteroclinic orbit $\eta$ is not minimal, it follows that a minimal heteroclinic orbit either takes its values in the upper half-plane $\left\{u_{2}>0\right\}$ or in the lower half-plane $\left\{u_{2}<0\right\}$. We denote by $F^{ \pm}$ the corresponding subsets. If $d_{\mathcal{H}}\left(F^{-}, F^{+}\right)=0$, then there exists a sequence $e_{k}=\left(f_{k}, g_{k}\right) \subset F^{+}$such that $\lim _{k \rightarrow \infty}\left\|g_{k}\right\|_{L^{2}(\mathbb{R})}=0$. According to Lemma [2.2, there also exists a sequence $x_{k} \in \mathbb{R}$, such that $\lim _{k \rightarrow \infty} e_{k}\left(x-x_{k}\right)=(f(x), 0)=: u(x) \in A$. Furthermore, we have $J_{\mathbb{R}}(u) \leq J_{\min }$. Therefore, $u$ is a minimal heteroclinic orbit coinciding up to translations with $\eta$. This is a contradiction, since the orbit $\eta$ is not minimal.

## 4. Proof of Theorem 1.2

Existence of the minimizer $U$. To see that $\inf _{V \in \mathcal{A}} \mathcal{J}_{\mathbb{R}}(V)<\infty$, we take $\mathbf{V}_{0} \in \mathcal{A}$ as in (38), with $e^{ \pm} \in F^{ \pm}$. Since $e^{-}$and $e^{+}$satisfy the exponential estimate (6), it is clear that $\mathcal{J}_{\mathbb{R}}\left(\mathbf{V}_{0}\right)<\infty$. Next, we define the constants

- $\mathcal{W}_{1}:=\inf \left\{\mathcal{W}(v): d_{\mathcal{H}}(v, F) \in\left[d_{\min } / 8, d_{\min } / 4\right]\right\} \in(0, \infty)(c f$. Lemma 3.1 (ii) $)$,
- $M>0$ such that $\mathcal{W}(v) \leq 1 \Rightarrow\|v\|_{L^{\infty}\left(\mathbb{R} ; \mathbb{R}^{m}\right)} \leq M$ (cf. Lemma 2.1 applied to $W$ ),
- $C>0$ such that $\left|D^{2} W(v)(\nu, \nu)\right| \leq C, \forall v:|v| \leq M, \forall \nu \in \mathbb{R}^{m}:|\nu|=1$,
- $\eta \in\left(0, d_{\text {min }} / 8\right)$ such that $(1+C) \eta^{2}<\sqrt{2 \mathcal{W}_{1}}\left(d_{\text {min }} / 8\right)$,
- $\mathcal{W}_{2}:=\inf \left\{\mathcal{W}(v): d_{\mathcal{H}}(v, F) \geq \eta\right\} \in(0, \infty)(c f$. Lemma 3.1 (ii)),
- $\epsilon \in(0,1)$ such that $\epsilon<\sqrt{2 \mathcal{W}_{1}}\left(d_{\text {min }} / 8\right)-(1+C) \eta^{2}$,
and consider a minimizing sequence i.e. $\left\{V_{k}\right\} \subset \mathcal{A}$ such that $\lim _{k \rightarrow \infty} \mathcal{J}_{\mathbb{R}}\left(V_{k}\right)=\inf _{V \in \mathcal{A}} \mathcal{J}_{\mathbb{R}}(V)$. For every $k$, we set

$$
\begin{aligned}
& \lambda_{k}^{-}:=\sup S_{k}^{-}, \text {where } S_{k}^{-}:=\left\{t \in \mathbb{R}: \mathcal{W}\left(V_{k}(t)\right) \leq \epsilon, d_{\mathcal{H}}\left(V_{k}(t), F^{-}\right) \leq \eta\right\} \\
& \lambda_{k}^{+}:=\inf S_{k}^{+}, \text {where } S_{k}^{+}:=\left\{t \geq \lambda_{k}^{-}: \mathcal{W}\left(V_{k}(t)\right) \leq \epsilon, d_{\mathcal{H}}\left(V_{k}(t), F^{+}\right) \leq \eta\right\}
\end{aligned}
$$

Note that $S_{k}^{ \pm} \neq \varnothing$, since $\mathcal{J}_{\mathbb{R}}\left(V_{k}\right)<\infty$ implies that $\liminf _{|t| \rightarrow \infty} \mathcal{W}\left(V_{k}(t)\right)=0$, and also $\liminf _{|t| \rightarrow \infty} d_{\mathcal{H}}\left(V_{k}(t), F\right)=$ 0 by Lemma 3.1 (ii). Moreover, one can see that actually $\lambda_{k}^{-}=\max S_{k}^{-}$, and $\lambda_{k}^{+}=\min S_{k}^{-}$. Indeed, let $\left\{t_{j}\right\} \subset S_{k}^{-}$be a sequence such that $t_{j} \rightarrow \lambda_{k}^{-}$, as $j \rightarrow \infty$. Then, there exists a sequence $\left\{e_{j}\right\} \subset F^{-}$such that

[^5]$\left\|V_{k}\left(t_{j}\right)-e_{j}\right\|_{\mathcal{H}} \leq \eta$. In addition, in view of Lemma3.2(i), we have up to subsequence $e_{j} \rightarrow e$ in $\mathcal{H}$, as $j \rightarrow \infty$, for some $e \in F^{-}$, thus $\left\|V_{k}\left(\lambda_{k}^{-}\right)-e\right\|_{\mathcal{H}} \leq \eta$. On the other hand, from Lemma 3.1 (i) we get immediately that $\mathcal{W}\left(V_{k}\left(\lambda_{k}^{-}\right)\right) \leq \epsilon$.

By definition of $\lambda_{k}^{ \pm}$, either $\mathcal{W}\left(V_{k}(t)\right)>\epsilon$ or $d_{\mathcal{H}}\left(V_{k}(t), F\right)>\eta$ holds for $t \in\left(\lambda_{k}^{-}, \lambda_{k}^{+}\right)$. Thus, we have $\mathcal{W}\left(V_{k}(t)\right) \geq \min \left(\epsilon, \mathcal{W}_{2}\right), \forall t \in\left(\lambda_{k}^{-}, \lambda_{k}^{+}\right)$, and as a consequence of the boundedness of the sequence $k \mapsto \mathcal{J}_{\mathbb{R}}\left(V_{k}\right)$, it follows that $\Lambda:=\sup _{k}\left(\lambda_{k}^{+}-\lambda_{k}^{-}\right) \in(0, \infty)$. Our next claim is that we may assume that the minimizing sequence $\left\{V_{k}\right\}$ satisfies (cf. [7, Lemma 4.3.]):

$$
\begin{equation*}
d_{\mathcal{H}}\left(V_{k}(t), F^{-}\right) \leq d_{\min } / 4, \forall t \leq \lambda_{k}^{-}, \text {and } d_{\mathcal{H}}\left(V_{k}(t), F^{+}\right) \leq d_{\min } / 4, \forall t \geq \lambda_{k}^{+} \tag{55}
\end{equation*}
$$

Indeed, if a map $V_{k}$ is such that for instance $d_{\mathcal{H}}\left(V_{k}\left(t_{0}\right), F^{-}\right)>d_{\min } / 4$, for some $t_{0}<\lambda_{k}^{-}$, we can construct a competitor $\tilde{V}_{k} \in \mathcal{A}$, such that $\mathcal{J}_{\mathbb{R}}\left(\tilde{V}_{k}\right) \leq \mathcal{J}_{\mathbb{R}}\left(V_{k}\right)$, and (55) holds for $\tilde{V}_{k}$. To see this, let $e^{-} \in F^{-}$be such that $\left\|V_{k}\left(\lambda_{k}^{-}\right)-e^{-}\right\|_{\mathcal{H}}=d_{\mathcal{H}}\left(V_{k}\left(\lambda_{k}^{-}\right), F^{-}\right) \leq \eta$, and set

$$
\tilde{V}_{k}(t):= \begin{cases}V_{k}(t), & \text { for } t \geq \lambda_{k}^{-}  \tag{56}\\ e^{-}+\left(t-\lambda_{k}^{-}+1\right)\left(V_{k}\left(\lambda_{k}^{-}\right)-e^{-}\right), & \text {for } t \in\left[\lambda_{k}^{-}-1, \lambda_{k}^{-}\right] \\ e^{-}, & \text {for } t \leq \lambda_{k}^{-}-1\end{cases}
$$

One can see that $\int_{-\infty}^{\lambda_{k}^{-}}\left\|\tilde{V}_{k}^{\prime}\right\|_{\mathcal{H}}^{2}=\left\|V_{k}\left(\lambda_{k}^{-}\right)-e^{-}\right\|_{\mathcal{H}}^{2}$. Next, applying formula (44) to $e=e^{-}$and $u=V_{k}\left(\lambda_{k}^{-}\right)$ together with $\mathcal{W}\left(V_{k}\left(\lambda_{k}^{-}\right)\right) \leq \epsilon$, we obtain $\int_{\mathbb{R}} \frac{1}{2}\left|\left(V_{k}\left(\lambda_{k}^{-}\right)-e^{-}\right)^{\prime}\right|^{2} \leq \epsilon+\frac{C}{2}\left\|V_{k}\left(\lambda_{k}^{-}\right)-e^{-}\right\|_{\mathcal{H}}^{2}$. Finally, a second application of formula (44) to $e^{-}$and $e^{-}+s\left(V_{k}\left(\lambda_{k}^{-}\right)-e^{-}\right)$, with $s \in[0,1]$, gives $\mathcal{W}\left(\tilde{V}_{k}(t)\right) \leq \epsilon+C \| V_{k}\left(\lambda_{k}^{-}\right)-$ $e^{-} \|_{\mathcal{H}}^{2}, \forall t \in\left[\lambda_{k}^{-}-1, \lambda_{k}^{-}\right]$. Thus we have checked that $\mathcal{J}_{\left(-\infty, \lambda_{k}^{-}\right]}\left(\tilde{V}_{k}\right) \leq \epsilon+(C+1)\left\|V_{k}\left(\lambda_{k}^{-}\right)-e^{-}\right\|_{\mathcal{H}}^{2} \leq \epsilon+(C+1) \eta^{2}$. On the other hand, assuming that $d_{\mathcal{H}}\left(V_{k}\left(t_{0}\right), F^{-}\right)>d_{\min } / 4$ holds for some $t_{0}<\lambda_{k}^{-}$, we have

$$
\mathcal{J}_{\left[t_{0}, \lambda_{k}^{-}\right]}\left(V_{k}\right) \geq \int_{\left[t_{0}, \lambda_{k}^{-}\right]} \sqrt{2 \mathcal{W}\left(V_{k}\right)}\left\|V_{k}^{\prime}\right\|_{\mathcal{H}} \geq \sqrt{2 \mathcal{W}_{1}}\left(d_{\min } / 8\right)
$$

Therefore, by definition of $\epsilon$ and $\eta$ we deduce that $\mathcal{J}_{\left(-\infty, \lambda_{k}^{-}\right]}\left(\tilde{V}_{k}\right) \leq \mathcal{J}_{\left(-\infty, \lambda_{k}^{-}\right]}\left(V_{k}\right)$. This proves our claim (55).
To show the existence of the minimizer $U$, we shall consider appropriate translations of the sequence $v_{k}(t, x):=\left[V_{k}(t)\right](x)\left(\mathbb{R} \ni t \mapsto V_{k}(t) \in \mathcal{H}\right)$, with respect to the variables $x$ and $t$. Then, we shall establish the convergence of the translated maps to the minimizer $U$. Given $T \in \mathbb{R}$, and $V \in \mathcal{H}=\mathbf{e}_{0}+L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)$, we denote by $L^{T}(V)$ the map of $\mathcal{H}$ defined by $\mathbb{R} \ni x \mapsto V(x-T) \in \mathbb{R}^{m}$. It is obvious that $\mathcal{W}\left(L^{T}(V)\right)=\mathcal{W}(V)$. Similarly, if $t \mapsto V(t)$ belongs to $H_{\mathrm{loc}}^{1}(\mathbb{R} ; \mathcal{H})$, we obtain that $t \mapsto L^{T}(V(t))$ also belongs to $H_{\text {loc }}^{1}(\mathbb{R} ; \mathcal{H})$, with $\left\|\left(L^{T} V\right)^{\prime}(t)\right\|_{L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}=\left\|V^{\prime}(t)\right\|_{L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}$.

In view of Lemma 3.2 (ii), for every $k$, we can find $T_{k} \in \mathbb{R}$ and $e_{k} \in F^{-}$such that $\left\|e_{k}\right\|_{\mathcal{H}} \leq \gamma$ and $\left\|\mid L^{T_{k}} V_{k}\left(\lambda_{k}^{-}\right)-e_{k}\right\|_{\mathcal{H}} \leq \eta$. We set $\bar{V}_{k}(t):=L^{T_{k}}\left(V_{k}\left(t+\lambda_{k}^{-}\right)\right)$. Clearly, $\bar{V}_{k} \in H_{\text {loc }}^{1}(\mathbb{R} ; \mathcal{H})$ satisfies $\mathcal{J}_{\mathbb{R}}\left(\bar{V}_{k}\right)=$ $\mathcal{J}_{\mathbb{R}}\left(V_{k}\right)$, as well as

$$
\begin{equation*}
d_{\mathcal{H}}\left(\bar{V}_{k}(t), F^{-}\right) \leq d_{\min } / 4, \forall t \leq 0, \text { and } d_{\mathcal{H}}\left(\bar{V}_{k}(t), F^{+}\right) \leq d_{\min } / 4, \forall t \geq \Lambda . \tag{57}
\end{equation*}
$$

Since $\left\|\bar{V}_{k}(0)\right\|_{\mathcal{H}} \leq \eta+\gamma$ holds for every $k$, we have that (up to subsequence) $\bar{V}_{k}(0) \rightharpoonup u_{0}$ in $\mathcal{H}$, as $k \rightarrow \infty$, for some $u_{0} \in \mathcal{H}$. Next, proceeding as in the proof of Lemma 2.2 we can see that (up to subsequence) $\bar{V}_{k}^{\prime} \rightharpoonup V$ in $L^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)\right)$ as $k \rightarrow \infty$, and moreover setting $\bar{V}_{k}(t)=\bar{V}_{k}(0)+\int_{0}^{t} \bar{V}_{k}^{\prime}(s) \mathrm{d} s$, and $U(t)=u_{0}+\int_{0}^{t} V(s) \mathrm{d} s$, we have $\bar{V}_{k}(t) \rightharpoonup U(t)$ in $\mathcal{H}$, as $k \rightarrow \infty, \forall t \in \mathbb{R}$. The fact that $\mathcal{J}_{\mathbb{R}}(U) \leq \liminf _{k \rightarrow \infty} \mathcal{J}_{\mathbb{R}}\left(V_{k}\right)$ follows as in the proof of Lemma 2.2 from the sequentially weakly lower semicontinuity of $\mathcal{W}$ (cf. Lemma 3.1 (i)). To conclude that $\mathcal{J}_{\mathbb{R}}(U)=\min _{V \in \mathcal{A}} \mathcal{J}_{\mathbb{R}}(V)$, we are going to check that $U$ satisfies (57). Indeed, given $t \leq 0$, let $\left\{e_{k}\right\} \subset F^{-}$be such that $\left\|\bar{V}_{k}(t)-e_{k}\right\|_{\mathcal{H}} \leq d_{\min } / 4, \forall k$. Since $\left\{e_{k}\right\}$ is bounded in $\mathcal{H}$, we have (up to subsequence) $\lim _{k \rightarrow \infty} e_{k}=e$ in $\mathcal{H}$, for some $e \in F^{-}$(cf. Lemma3.2(i)). Thus, it is clear that $d_{\mathcal{H}}\left(U(t), F^{-}\right) \leq d_{\mathcal{H}}(U(t), e) \leq$ $\lim \inf _{k \rightarrow \infty}\left\|\bar{V}_{k}(t)-e_{k}\right\|_{\mathcal{H}} \leq d_{\min } / 4$. Similarly, $d_{\mathcal{H}}\left(U(t), F^{+}\right) \leq d_{\min } / 4$ holds for $t \geq \Lambda$.
Proof of (i), (ii), (iii) and (iv). We first establish two lemmas:
Lemma 4.1. Writing $U(t)=\mathbf{e}_{0}+H(t)$, with

$$
H \in H_{\mathrm{loc}}^{1}\left(\mathbb{R} ; L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)\right) \subset L_{\mathrm{loc}}^{2}\left(\mathbb{R} ; L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)\right)
$$

and identifying $H$ with a $L_{\text {loc }}^{2}\left(\mathbb{R}^{2} ; \mathbb{R}^{m}\right)$ function via $h(t, x):=[H(t)](x)$, we have
(i) $h \in H_{\text {loc }}^{1}\left(\mathbb{R}^{2} ; \mathbb{R}^{m}\right), h_{t} \in L^{2}\left(\mathbb{R}^{2} ; \mathbb{R}^{m}\right)$,
(ii) and $\left\|h_{x}\right\|_{L^{2}\left((\alpha, \beta) \times \mathbb{R} ; \mathbb{R}^{m}\right)}^{2} \leq C_{0}(|\beta-\alpha|)$, for a constant $C_{0}>0$ depending only on the length of the interval $(\alpha, \beta) \subset \mathbb{R}$.
Proof. We recall that given any interval $(\alpha, \beta)$, we can identify $L^{2}\left((\alpha, \beta) \times \mathbb{R} ; \mathbb{R}^{m}\right)$ with $L^{2}\left((\alpha, \beta) ; L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)\right)$ via the canonical isomorphism

$$
\begin{aligned}
L^{2}\left((\alpha, \beta) \times \mathbb{R} ; \mathbb{R}^{m}\right) & \simeq L^{2}\left((\alpha, \beta) ; L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)\right) \\
f & \simeq[(\alpha, \beta) \ni t \mapsto[F(t)]: x \mapsto f(t, x)], F(t) \in L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right) .
\end{aligned}
$$

Let $g(t, x):=\left[U^{\prime}(t)\right](x)$, with $g \in L^{2}\left(\mathbb{R}^{2} ; \mathbb{R}^{m}\right)$, and let us prove that $h_{t}=g$. Given a function $\phi \in$ $C_{0}^{\infty}\left(\mathbb{R}^{2} ; \mathbb{R}^{m}\right)$, we also view it as a map $\Phi \in C^{1}\left(\mathbb{R} ; L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)\right)$, $t \mapsto \Phi(t)$, by setting $[\Phi(t)](x):=\phi(t, x)$. Assuming that $\operatorname{supp} \Phi \subset(\alpha, \beta)$, we have

$$
\int_{\mathbb{R}^{2}}\left[h \phi_{t}+g \phi\right]=\int_{\alpha}^{\beta}\left(\left\langle H(t), \Phi_{t}(t)\right\rangle_{\mathcal{H}}+\left\langle H_{t}(t), \Phi(t)\right\rangle_{\mathcal{H}}\right) \mathrm{d} t,
$$

and clearly the second integral vanishes if $H \in C^{1}\left([\alpha, \beta] ; L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)\right)$. Since $H$ can be approximated in $H^{1}\left((\alpha, \beta) ; L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)\right)$ by $C^{1}\left([\alpha, \beta] ; L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)\right)$ maps, we deduce that $\int_{\mathbb{R}^{2}}\left[h \phi_{t}+g \phi\right]=0$, i.e. $h_{t}=g$.

On the other hand, $\int_{\mathbb{R}} \mathcal{W}(U(t)) \mathrm{d} t<\infty$ implies that for a.e. $t \in \mathbb{R}$, we have $\mathcal{W}(U(t))<\infty$, and $U(t) \in \tilde{\mathcal{H}}$. By using difference quotients, we can see that

$$
\begin{equation*}
\int_{\mathbb{R}}\left|\frac{h(t, x+\eta)-h(t, x)}{\eta}\right|^{2} \mathrm{~d} x \leq k \int_{\mathbb{R}}\left|h_{x}\right|^{2} \leq 4 k\left(\mathcal{W}(U(t))+J_{\min }\right)+2 k\left\|\mathbf{e}_{0}^{\prime}\right\|_{L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}^{2}, \tag{58}
\end{equation*}
$$

holds for a.e. $t \in \mathbb{R}$, for $\eta \in \mathbb{R} \backslash\{0\}$, and some constant $k>0$. Thus, the difference quotients $\frac{h(t, x+\eta)-h(t, x)}{\eta}$ are bounded in $L^{2}\left((\alpha, \beta) \times \mathbb{R} ; \mathbb{R}^{m}\right)$ for every interval $[\alpha, \beta] \subset \mathbb{R}$, and as a consequence $h_{x} \in L^{2}\left((\alpha, \beta) \times \mathbb{R} ; \mathbb{R}^{m}\right)$. Finally, an integration of (58) gives $\left\|h_{x}\right\|_{L^{2}\left((\alpha, \beta) \times \mathbb{R} ; \mathbb{R}^{m}\right)}^{2} \leq C_{0}(|\beta-\alpha|)$, with

$$
C_{0}=4 k \int_{\mathbb{R}} \mathcal{W}(U(t)) \mathrm{d} t+2 k|\beta-\alpha|\left(2 J_{\min }+\left\|\mathbf{e}_{0}^{\prime}\right\|_{L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}^{2}\right) .
$$

Lemma 4.2. If (24a) holds, there exists a minimizer $U$ of $\mathcal{J}_{\mathbb{R}}$ in $\mathcal{A}$ satisfying:

$$
\begin{equation*}
\|U(t)\|_{L^{\infty}\left(\mathbb{R} ; \mathbb{R}^{m}\right)} \leq \rho, \forall t \in \mathbb{R} \tag{59}
\end{equation*}
$$

Proof. Let $P: \mathbb{R}^{m} \rightarrow \mathbb{R}^{m}$ be the projection onto the closed ball $\left\{u \in \mathbb{R}^{m}:|u| \leq \rho\right\}$. Given $V \in \mathcal{H}$, it is clear that the map $P V: x \mapsto P(V(x))$ belongs to $\mathcal{H}$. In addition, given $V_{1}, V_{2} \in \mathcal{H}$, we have $\left\|P V_{1}-P V_{2}\right\|_{\mathcal{H}} \leq \| V_{1}-$ $V_{2} \|_{\mathcal{H}}$. As a consequence, the map $P U: t \mapsto P(U(t)) \in \mathcal{H}$ belongs to $H_{\text {loc }}^{1}(\mathbb{R} ; \mathcal{H})$, and $\left\|(P U)^{\prime}(t)\right\|_{L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)} \leq$ $\left\|U^{\prime}(t)\right\|_{L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}$ holds for a.e. $t \in \mathbb{R}$. On the other hand, it is clear that $\mathcal{W}((P U)(t)) \leq \mathcal{W}(U(t))$ holds for every $t \in \mathbb{R}$. To deduce that $P U$ is a minimizer of $\mathcal{J}_{\mathbb{R}}$ in $\mathcal{A}$, it remains to check that $P U$ satisfies (57). Given $t \leq 0$, let $e \in F^{-}$be such that $\|U(t)-e\|_{\mathcal{H}} \leq d_{\min } / 4$, and note that $\|e\|_{L^{\infty}\left(\mathbb{R} ; \mathbb{R}^{m}\right)} \leq \rho$, since $e$ is a minimal heteroclinic. This implies that for every $x \in \mathbb{R}$, we have $|[P U(t)](x)-e(x)| \leq|[U(t)](x)-e(x)|$. Thus, it follows that $d_{\mathcal{H}}(P U(t), e) \leq d_{\mathcal{H}}(U(t), e) \leq d_{\min } / 4$. Similarly, $d_{\mathcal{H}}\left(P U(t), F^{+}\right) \leq d_{\min } / 4$ holds for $t \geq \Lambda$.

Given a function $\phi \in C_{0}^{1}\left(\mathbb{R}^{2} ; \mathbb{R}^{m}\right)$, we also view it as a map $\Phi \in C_{0}^{1}\left(\mathbb{R} ; L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)\right), t \mapsto \Phi(t)$, by setting $[\Phi(t)](x):=\phi(t, x)$. For every $\lambda \in \mathbb{R}$, it is clear that

$$
\begin{equation*}
\mathcal{J}_{\mathbb{R}}(U) \leq \mathcal{J}_{\mathbb{R}}(U+\lambda \Phi), \tag{60}
\end{equation*}
$$

and

$$
\begin{equation*}
\left.\frac{\mathrm{d}}{\mathrm{~d} \lambda}\right|_{\lambda=0} \int_{\mathbb{R}} \frac{1}{2}\left\|U^{\prime}(t)+\lambda \Phi^{\prime}(t)\right\|_{L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}^{2} \mathrm{~d} t=\int_{\mathbb{R}}\left\langle U^{\prime}(t), \Phi^{\prime}(t)\right\rangle_{L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)} \mathrm{d} t . \tag{61}
\end{equation*}
$$

On the other hand, since $\int_{\mathbb{R}} \mathcal{W}(U(t)) \mathrm{d} t<\infty$, it follows that for a.e. $t \in \mathbb{R}$, we have $\mathcal{W}(U(t))<\infty$, and $U(t) \in \tilde{\mathcal{H}}$. Our claim is that

$$
\begin{equation*}
\left.\frac{\mathrm{d}}{\mathrm{~d} \lambda}\right|_{\lambda=0} \int_{\mathbb{R}} \mathcal{W}(U(t)+\lambda \Phi(t)) \mathrm{d} t=\int_{\mathbb{R}} \psi(t) \mathrm{d} t, \tag{62}
\end{equation*}
$$

where $\psi(t):=\int_{\mathbb{R}}\left[\frac{\mathrm{d}[U(t)]}{\mathrm{d} x} \cdot \frac{\partial \phi(t, x)}{\partial x}+\nabla W([U(t)](x)) \cdot \phi(t, x)\right] \mathrm{d} x$. We first notice that for every $\lambda \neq 0$, the functions $\psi_{\lambda}(t):=\frac{1}{\lambda}[\mathcal{W}(U(t)+\lambda \Phi(t))-\mathcal{W}(U(t))]$ are defined a.e. Moreover, we can see that $\psi_{\lambda}(t)$ is equal to

$$
\begin{equation*}
\int_{\mathbb{R}}\left[\frac{\mathrm{d}[U(t)]}{\mathrm{d} x} \cdot \frac{\partial \phi(t, x)}{\partial x}+\frac{\lambda}{2}\left|\frac{\partial \phi(t, x)}{\partial x}\right|^{2}+\nabla W\left([U(t)](x)+c_{\lambda}(t, x) \lambda \phi(t, x)\right) \cdot \phi(t, x)\right] \mathrm{d} x \tag{63}
\end{equation*}
$$

with $0 \leq c_{\lambda}(t, x) \leq 1$. As a consequence, we obtain $\lim _{\lambda \rightarrow 0} \psi_{\lambda}(t)=\psi(t)$ for a.e. $t \in \mathbb{R}$. Finally, setting $u(t, x):=[U(t)](x)$, we have $u \in H_{\mathrm{loc}}^{1}\left(\mathbb{R}^{2} ; \mathbb{R}^{m}\right) \subset L_{\mathrm{loc}}^{q}\left(\mathbb{R}^{2} ; \mathbb{R}^{m}\right), \forall q \geq 2$ (cf. Lemma 4.1), and moreover $u \in L^{\infty}\left(\mathbb{R}^{2} ; \mathbb{R}^{m}\right)$ when (24a) holds (cf. (59)). This implies that either under assumption (24b) or (24a), we can find a function $\Psi \in L^{1}(\mathbb{R})$ such that $\left|\psi_{\lambda}(t)\right| \leq \Psi(t)$ holds a.e., when $|\lambda|$ is small. Thus, we deduce (62) by dominated convergence. Now, we gather the previous results to conclude. In view of (60), (61) and (62), the minimizer $U$ satisfies the Euler-Lagrange equation

$$
\begin{equation*}
\int_{\mathbb{R}}\left(\left\langle U^{\prime}(t), \Phi^{\prime}(t)\right\rangle_{L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}+\psi(t)\right) \mathrm{d} t=0 \tag{64}
\end{equation*}
$$

which is equivalent to

$$
\begin{equation*}
\int_{\mathbb{R}^{2}}(\nabla u \cdot \nabla \phi+\nabla W(u) \cdot \phi)=0 \tag{65}
\end{equation*}
$$

By elliptic regularity (cf. respectively [16, Theorem 8.34. and Corollary 4.14.] under assumption (24a), and [16, Theorem 8.8. and Corollary 4.14.] under assumption (24b) it follows that $u$ is a classical solution of (11). When (24a) holds it is clear that $u$ is uniformly continuous on $\mathbb{R}^{2}$, since $|\nabla u|$ is bounded on $\mathbb{R}^{2}$. Similarly, when (24b) holds, Lemma 4.1 implies that $\|u\|_{H^{1}\left(D ; \mathbb{R}^{m}\right)}$ and $\|\nabla W(u)\|_{L^{2}\left(D ; \mathbb{R}^{m}\right)}$ are uniformly bounded on the discs $D$ of radius 1 included in the strip $[\alpha, \beta] \times \mathbb{R}($ with $[\alpha, \beta] \subset \mathbb{R})$. Thus, in view of [16, Theorem 8.8.], $u$ is uniformly continuous on the strip $[\alpha, \beta] \times \mathbb{R}$. To prove (25b), assume by contradiction the existence of a sequence $\left(t_{k}, x_{k}\right)$ such that $\lim _{k \rightarrow \infty} x_{k}=\infty, t_{k} \in[\alpha, \beta]$, and $\left|u\left(t_{k}, x_{k}\right)-a^{+}\right|>\epsilon>0$. As a consequence of the uniform continuity of $u$, we can construct a sequence of disjoint discs of fixed radius, centered at $\left(t_{k}, x_{k}\right)$, over which $W(u)$ is bounded uniformly away from zero. This clearly violates the finiteness of $E_{[\alpha, \beta] \times \mathbb{R}}(u)=\mathcal{J}_{[\alpha, \beta]}(U)+J_{\min }(\beta-\alpha)$. To prove (25a), assume by contradiction the existence of a sequence $t_{k}$ such that $\lim _{k \rightarrow \infty} t_{k}=\infty$, and $d_{\mathcal{H}}\left(U\left(t_{k}\right), F^{+}\right)>2 \epsilon>0$. Since $\mathbb{R} \ni t \mapsto U(t) \in \mathcal{H}$ is uniformly continuous, we can construct a sequence of disjoint intervals $\left[t_{k}-\eta, t_{k}+\eta\right]$ of fixed length over which $d_{\mathcal{H}}\left(U(t), F^{+}\right)>\epsilon>0$, and $\mathcal{W}(U(t))$ is bounded uniformly away from zero (cf. Lemma 3.1(ii)). This again violates the finiteness of $\mathcal{J}_{\mathbb{R}}(U)$. Finally, the equipartition property (iii) is established as in Theorem 1.1 and (iv) follows from (60), since $E_{[\alpha, \beta] \times \mathbb{R}}(u+\phi)=\mathcal{J}_{[\alpha, \beta]}(U+\Phi)+(\beta-\alpha) J_{\min }$, if $\operatorname{supp} \phi \subset(\alpha, \beta) \times \mathbb{R}$.

Proof of (28). The proof proceeds as in [7, Proposition 6.1.]. In view of (27), let $t_{0} \in \mathbb{R}$ and $\kappa>0$ be such that

$$
\begin{equation*}
\mathcal{W}(U(t)) \geq \kappa d_{\mathcal{H}}^{2}\left(U(t), F^{-}\right), \forall t \leq t_{0} \tag{66}
\end{equation*}
$$

For $t \leq t_{0}$ fixed, let $e^{-} \in F^{-}$be such that $d_{\mathcal{H}}\left(U(t), e^{-}\right)=d_{\mathcal{H}}\left(U(t), F^{-}\right)$, and define the map

$$
Z(s)= \begin{cases}U(t)+(t-s)\left(e^{-}-U(t)\right), & \text { for } t-1 \leq s \leq t  \tag{67}\\ e^{-}, & \text {for } s \leq t-1\end{cases}
$$

By reproducing the argument after (56) we obtain $\mathcal{J}_{[t-1, t]}(Z) \leq \mathcal{W}(U(t))+(C+1) d_{\mathcal{H}}^{2}\left(U(t), F^{-}\right)$, with $C=\sup _{|u| \leq \rho,|\nu|=1}\left|D^{2} W(u)(\nu, \nu)\right|$. Thanks to the variational characterization of $U$ and to (66), it follows that

$$
\begin{equation*}
\kappa \int_{-\infty}^{t} d_{\mathcal{H}}^{2}\left(U(s), F^{-}\right) \mathrm{d} s \leq \int_{-\infty}^{t} \mathcal{W}(U(s)) \mathrm{d} s \leq \mathcal{J}_{(-\infty, t]}(U) \leq \mathcal{J}_{[t-1, t]}(Z) \leq \mathcal{W}(U(t))+(C+1) d_{\mathcal{H}}^{2}\left(U(t), F^{-}\right) \tag{68}
\end{equation*}
$$

Setting $\theta(t):=\int_{-\infty}^{t}\left(d_{\mathcal{H}}^{2}\left(U(s), F^{-}\right)+\mathcal{W}(U(s))\right) \mathrm{d} s$, we deduce that $\theta \in W_{\mathrm{loc}}^{1,1}\left(\left(-\infty, t_{0}\right]\right)$, and $\gamma \theta \leq \theta^{\prime}$ holds a.e. on $\left(-\infty, t_{0}\right]$ for some constant $\gamma>0$. By integrating this inequality, it follows that

$$
\begin{equation*}
\theta(t) \leq \theta\left(t_{0}\right) e^{\gamma\left(t-t_{0}\right)} \tag{69}
\end{equation*}
$$

Now, we notice that by the equipartition property, we have

$$
\begin{equation*}
\int_{-\infty}^{t}\left\|U^{\prime}(s)\right\|_{L^{2}\left(\mathbb{R}: \mathbb{R}^{m}\right)}^{2} \mathrm{~d} s \leq 2 \theta\left(t_{0}\right) e^{\gamma\left(t-t_{0}\right)}, \forall t \leq t_{0} \tag{70}
\end{equation*}
$$

and for every $j \in \mathbb{N}$ :

$$
\begin{equation*}
\int_{t-j-1}^{t-j}\left\|U^{\prime}(s)\right\|_{L^{2}\left(\mathbb{R}: \mathbb{R}^{m}\right)} \mathrm{d} s \leq\left(\int_{t-j-1}^{t-j}\left\|U^{\prime}(s)\right\|_{L^{2}\left(\mathbb{R}: \mathbb{R}^{m}\right)}^{2} \mathrm{~d} s\right)^{\frac{1}{2}} \leq \sqrt{2 \theta\left(t_{0}\right)} e^{\frac{\gamma}{2}\left(t-t_{0}\right)} e^{-\frac{\gamma}{2} j} \tag{71}
\end{equation*}
$$

Therefore,

$$
\begin{equation*}
\int_{-\infty}^{t}\left\|U^{\prime}(s)\right\|_{L^{2}\left(\mathbb{R}: \mathbb{R}^{m}\right)} \mathrm{d} s \leq \frac{\sqrt{2 \theta\left(t_{0}\right)}}{1-e^{-\frac{\gamma}{2}}} e^{\frac{\gamma}{2}\left(t-t_{0}\right)}<\infty \tag{72}
\end{equation*}
$$

and $U(t) \rightarrow e^{-}$in $\mathcal{H}$, as $t \rightarrow-\infty$, for some $e^{-} \in F^{-}$. Similarly, we establish the existence of $e^{+} \in F^{+}$such that $U(t) \rightarrow e^{+}$in $\mathcal{H}$, as $t \rightarrow \infty$.

Next, we choose $\epsilon \in(0, r / 2)$ such that $(\mu+1) \epsilon^{2}<\sqrt{c}(r-2 \epsilon) \epsilon$, where $\mu$ is defined in (48). Let $L>0$ be such that $\left|e^{ \pm}(x)-a^{-}\right|<\epsilon / 4$ (resp. $\left|e^{ \pm}(x)-a^{+}\right|<\epsilon / 4$ ) holds for every $x \leq-L$ (resp. $x \geq L$ ). Our claim is that $\left|u(t, x)-a^{-}\right| \leq r$ (resp. $\left.\left|u(t, x)-a^{+}\right| \leq r\right)$ holds for $x \leq-L-1$ (resp. $x \geq L+1$ ) and $|t| \geq T$ large enough. Without loss of generality we are only going to check that $\left|u(t, x)-a^{-}\right| \leq r$ holds for $x \leq-L-1$ and $t \geq T$ large enough. Indeed, otherwise there exists a sequence $\left(t_{k}, x_{k}\right)$ such that $\lim _{k \rightarrow \infty} t_{k}=\infty, x_{k} \leq-L-1$, and $\left|u\left(t_{k}, x_{k}\right)-a^{-}\right|>r$. Up to subsequence, we have $\lim _{k \rightarrow \infty} u\left(t_{k}, x\right)=e^{+}(x)$ for a.e. $x \in \mathbb{R}$. Let $T>0$ be such that $\left|u\left(t_{k}, L_{0}\right)-a^{-}\right| \leq \epsilon / 2$ holds for some $L_{0} \in(-L-1,-L)$, when $t_{k} \geq T$. By the uniform continuity of $u$, there exists $\eta>0$ (independent of k ) such that $\left|u\left(t, x_{k}\right)-a^{-}\right| \geq r-\epsilon / 2$ and $\left|u\left(t, L_{0}\right)-a^{-}\right| \leq \epsilon$ hold for $t \in\left[t_{k}-\eta, t_{k}+\eta\right]$. In view of (49) and (50) we deduce that $\mathcal{W}(U(t)) \geq \sqrt{c}(r-2 \epsilon) \epsilon-(\mu+1) \epsilon^{2}>0$, $\forall t \in\left[t_{k}-\eta, t_{k}+\eta\right]$, with $t_{k} \geq T$. Thus we obtain $\int_{\mathbb{R}} \mathcal{W}(U(t)) \mathrm{d} t=\infty$ which is a contradiction. This establishes our claim, and now (28b) follows easily from a standard comparison argument. Moreover, using elliptic estimates we also obtain that $|\nabla u(t, x)| \leq K^{\prime} e^{-k^{\prime}|x|}$ holds for some constants $k^{\prime}, K^{\prime}>0$, and $\left|D^{2} u\right|$ is bounded on $\mathbb{R}^{2}$. As a consequence, the function $\mathbb{R} \ni t \mapsto \psi(t):=\mathcal{W}(U(t))$ is Lipschitz, since $\psi^{\prime}(t)=$ $\int_{\mathbb{R}}\left[u_{x}(t, x) \cdot u_{t x}(t, x)+\nabla W(u(t, x)) \cdot u_{t}(t, x)\right] \mathrm{d} x$ is uniformly bounded by a constant $\beta>0$. We infer that

$$
\begin{equation*}
\mathcal{W}(U(t)) \leq 2 \sqrt{\beta \theta\left(t_{0}\right)} e^{\frac{\gamma}{2}\left(t-t_{0}\right)}, \forall t \leq t_{0} \tag{73}
\end{equation*}
$$

To see this, let $t \leq t_{0}$ be fixed and let $\lambda:=\psi(t)$. For $s \in\left[t-\frac{\lambda}{2 \beta}, t\right]$, we have $\psi(s) \geq \psi(t)-\beta|s-t| \geq \frac{\lambda}{2}$. Thus, we get $\frac{\lambda^{2}}{4 \beta} \leq \int_{t-\frac{\lambda}{2 \beta}}^{t} \psi(s) \mathrm{d} s \leq \theta\left(t_{0}\right) e^{\gamma\left(t-t_{0}\right)}$, from which (73) is straightforward. Finally, (72) implies that

$$
\begin{equation*}
\left\|U(t)-e^{-}\right\|_{L^{2}\left(\mathbb{R}: \mathbb{R}^{m}\right)} \leq \frac{\sqrt{2 \theta\left(t_{0}\right)}}{1-e^{-\frac{\gamma}{2}}} e^{\frac{\gamma}{2}\left(t-t_{0}\right)}, \forall t \leq t_{0} \tag{74}
\end{equation*}
$$

while according to (44) we have

$$
\begin{equation*}
\left\|u_{x}(t, \cdot)-\left(e^{-}\right)^{\prime}\right\|_{L^{2}\left(\mathbb{R}: \mathbb{R}^{m}\right)}^{2} \leq 2 \mathcal{W}(U(t))+C\left\|U(t)-e^{-}\right\|_{L^{2}\left(\mathbb{R}: \mathbb{R}^{m}\right)}^{2} \tag{75}
\end{equation*}
$$

Gathering the previous results, we deduce that $\left\|U(t)-e^{-}\right\|_{H^{1}\left(\mathbb{R}: \mathbb{R}^{m}\right)}$ converges exponentially to 0 .

## 5. Proof of Theorem 1.3

To prove the existence of the minimizer $\tilde{U}$, just replace in the proof of Theorem1.2, $\mathcal{H}, d_{\text {min }}, \mathcal{J}$ and $\mathcal{A}$, by $\tilde{\mathcal{H}}, \tilde{d}_{\text {min }}, \tilde{\mathcal{J}}$ and $\tilde{\mathcal{A}}$. Next, given a function $\Phi \in C_{0}^{1}\left(\mathbb{R} ; H^{1}\left(\mathbb{R} ; \mathbb{R}^{m}\right)\right)$ such that $\operatorname{supp} \Phi \subset[\alpha, \beta] \subset \mathbb{R}$, it is clear that for every $\lambda \in \mathbb{R}$, we have

$$
\begin{equation*}
\tilde{\mathcal{J}}_{\mathbb{R}}(\tilde{U}) \leq \tilde{\mathcal{J}}_{\mathbb{R}}(\tilde{U}+\lambda \Phi) \tag{76}
\end{equation*}
$$

and

$$
\begin{equation*}
\left.\frac{\mathrm{d}}{\mathrm{~d} \lambda}\right|_{\lambda=0} \int_{\mathbb{R}} \frac{1}{2}\left\|\tilde{U}^{\prime}(t)+\lambda \Phi^{\prime}(t)\right\|_{H^{1}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}^{2} \mathrm{~d} t=\int_{\mathbb{R}}\left\langle\tilde{U}^{\prime}(t), \Phi^{\prime}(t)\right\rangle_{H^{1}\left(\mathbb{R} ; \mathbb{R}^{m}\right)} \mathrm{d} t \tag{77}
\end{equation*}
$$

On the other hand, proceeding as in the proof of Theorem 1.2 we obtain

$$
\begin{equation*}
\left.\frac{\mathrm{d}}{\mathrm{~d} \lambda}\right|_{\lambda=0} \int_{\mathbb{R}} \mathcal{W}(\tilde{U}(t)+\lambda \Phi(t)) \mathrm{d} t=\int_{\mathbb{R}} \psi(t) \mathrm{d} t \tag{78}
\end{equation*}
$$

with $\psi(t)=\int_{\mathbb{R}}\left[\frac{\mathrm{d}[\tilde{U}(t)]}{\mathrm{d} x} \cdot \frac{\mathrm{~d}[\Phi(t)]}{\mathrm{d} x}+\nabla W([\tilde{U}(t)](x)) \cdot[\Phi(t)](x)\right] \mathrm{d} x=D \mathcal{W}(\tilde{U}(t)) \Phi(t)$ (cf. Lemma 3.1](iii)). Indeed, in view of (631), the functions $\psi_{\lambda}(t):=\frac{1}{\lambda}[\mathcal{W}(\tilde{U}(t)+\lambda \Phi(t))-\mathcal{W}(\tilde{U}(t))]$ converge as $\lambda \rightarrow 0$ to $\psi(t)$, and are uniformly bounded when $|\lambda| \leq 1$, by the integrable function

$$
\Psi(t)=\left(\|\tilde{U}(t)\|_{\tilde{\mathcal{H}}}+\left\|\mathbf{e}_{0}^{\prime}\right\|_{L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}+\|\Phi(t)\|_{\tilde{\mathcal{H}}}\right)\|\Phi(t)\|_{\tilde{\mathcal{H}}}+\kappa_{1}\left(\|\tilde{U}(t)\|_{\tilde{\mathcal{H}}}+\|\Phi(t)\|_{\tilde{\mathcal{H}}}\right)\|\Phi(t)\|_{\tilde{\mathcal{H}}}+2 \kappa \kappa_{2} \chi_{[\alpha, \beta]}(t)
$$

where $\kappa=\sup _{t \in[\alpha, \beta]}\left(\|\tilde{U}(t)\|_{L^{\infty}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}+\|\Phi(t)\|_{L^{\infty}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}\right), \kappa_{1}=\sup _{|u| \leq \kappa,|\nu|=1}\left|D^{2} W(u)(\nu, \nu)\right|, \kappa_{2}=\sup _{|u| \leq \kappa}|\nabla W(u)|$, and $\chi$ is the characteristic function. Gathering the previous results we conclude that the minimizer $\tilde{U}$ satisfies the Euler-Lagrange equation

$$
\begin{equation*}
\int_{\mathbb{R}}\left(\left\langle\tilde{U}^{\prime}(t), \Phi^{\prime}(t)\right\rangle_{H^{1}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}+D \mathcal{W}(\tilde{U}(t)) \Phi(t)\right) \mathrm{d} t=0 \tag{79}
\end{equation*}
$$

and thus $\tilde{U} \in C^{2}(\mathbb{R} ; \tilde{\mathcal{H}})$ is a classical solution of system $\tilde{U}^{\prime \prime}=\nabla \mathcal{W}(\tilde{U})$. Next, we notice that the space $L^{2}\left((\alpha, \beta) ; H^{1}\left(\mathbb{R} ; \mathbb{R}^{m}\right)\right)$ is imbedded in $L^{2}\left((\alpha, \beta) ; L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)\right)$ which is isomorphic to $L^{2}\left((\alpha, \beta) \times \mathbb{R} ; \mathbb{R}^{m}\right)$. Similarly, the space $H^{1}\left((\alpha, \beta) ; H^{1}\left(\mathbb{R} ; \mathbb{R}^{m}\right)\right)$ is imbedded in $H^{1}\left((\alpha, \beta) ; L^{2}\left(\mathbb{R} ; \mathbb{R}^{m}\right)\right)$, thus Lemma 4.1 also applies to $\tilde{U}$. That is, setting $\tilde{u}(t, x):=[\tilde{U}(t)](x), t \mapsto \tilde{U}(t) \in \tilde{\mathcal{H}}$, we have $\tilde{u} \in H_{\mathrm{loc}}^{1}\left(\mathbb{R}^{2} ; \mathbb{R}^{m}\right), \tilde{u}_{t} \in L^{2}\left(\mathbb{R}^{2} ; \mathbb{R}^{m}\right)$, and $\tilde{u}_{x} \in L^{2}\left((\alpha, \beta) \times \mathbb{R} ; \mathbb{R}^{m}\right)$. Furthermore, we can see that $\tilde{u}_{t x} \in L^{2}\left(\mathbb{R}^{2} ; \mathbb{R}^{m}\right)$ by using difference quotients as in the proof of Lemma 4.1. In view of the previous results, (79) and (76) read respectively (32) and (35), when $\phi(t, x):=[\Phi(t)](x)$ is a $C_{0}^{2}\left(\mathbb{R}^{2} ; \mathbb{R}^{m}\right)$ function. To prove (33b), we notice that $\tilde{u}$ is uniformly continuous on the strips $[\alpha, \beta] \times \mathbb{R}$, since $[\alpha, \beta] \ni t \mapsto \tilde{U}(t) \in \tilde{\mathcal{H}}$ is Lipschitz continuous, and $|\tilde{u}(t, x)-\tilde{u}(t, y)| \leq \lambda|x-y|^{\frac{1}{2}}$ holds for $t \in[\alpha, \beta], x, y \in \mathbb{R}$, and $\lambda=\sup _{[\alpha, \beta]}\|\tilde{U}(t)\|_{\tilde{\mathcal{H}}}$. Then, we establish (33b), (33a) and the equipartition property (34) as in the proof of Theorem 1.2, Finally, when $\mathcal{W}$ satisfies the nondegeneracy condition (36), the arguments in the proof of Theorem 1.2 still apply to show (37), since we have $\sup \left\{\|e\|_{L^{\infty}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}: e \in F\right\}<\infty$ as well as $\sup _{t \in \mathbb{R}}\|\tilde{U}(t)\|_{L^{\infty}\left(\mathbb{R} ; \mathbb{R}^{m}\right)}<\infty$. On the other hand, it is clear in view of (37) that the uniform convergence in (33b) holds for $t \in \mathbb{R}$.
