# MULTIPLICITY AND STABILITY OF THE POHOZAEV OBSTRUCTION FOR HARDY-SCHRÖDINGER EQUATIONS WITH BOUNDARY SINGULARITY

Abstract. Let $\Omega$ be a smooth bounded domain in $\mathbb{R}^{n}(n \geq 3)$ such that $0 \in \partial \Omega$. We consider issues of non-existence, existence, and multiplicity of variational solutions in $H_{1,0}^{2}(\Omega)$ for the borderline Dirichlet problem,

$$
\left\{\begin{align*}
-\Delta u-\gamma \frac{u}{|x|^{2}}-h(x) u & =\frac{|u|^{2^{\star}(s)-2} u}{|x|^{s}} & & \text { in } \Omega  \tag{E}\\
u & =0 & & \text { on } \partial \Omega \backslash\{0\}
\end{align*}\right.
$$

where $0<s<2,2^{\star}(s):=\frac{2(n-s)}{n-2}, \gamma \in \mathbb{R}$ and $h \in C^{0}(\bar{\Omega})$. We use sharp blowup analysis on -possibly high energy- solutions of corresponding subcritical problems to establish, for example, that if $\gamma<\frac{n^{2}}{4}-1$ and the principal curvatures of $\partial \Omega$ at 0 are non-positive but not all of them vanishing, then Equation (E) has an infinite number of high energy (possibly sign-changing) solutions in $H_{1,0}^{2}(\Omega)$. This complements results of the first and third authors, who showed in [21] that if $\gamma \leq \frac{n^{2}}{4}-\frac{1}{4}$ and the mean curvature of $\partial \Omega$ at 0 is negative, then $(E)$ has a positive least energy solution.

On the other hand, the sharp blow-up analysis also allows us to show that if the mean curvature at 0 is nonzero and the mass, when defined, is also nonzero, then there is a surprising stability of regimes where there are no variational positive solutions under $C^{1}$-perturbations of the potential $h$. In particular, and in sharp contrast with the non-singular case (i.e., when $\gamma=s=0$ ), we prove non-existence of such solutions for $(E)$ in any dimension, whenever $\Omega$ is star-shaped and $h$ is close to 0 , which include situations not covered by the classical Pohozaev obstruction.

## 1. Introduction

This manuscript is the continuation of a long-time project initiated by the first and the third author in [19] about nonlinear critical equations involving the Hardy potential when the singularity is located on the boundary of the domain under study. Let $\Omega$ be such a smooth bounded domain in $\mathbb{R}^{n}, n \geq 3$, with $0 \in \partial \Omega$. We fix $s \in(0,2)$ and define the critical Sobolev exponent $2^{\star}(s):=\frac{2(n-s)}{n-2}$. For $\gamma \in \mathbb{R}$ and $h_{0} \in C^{1}(\bar{\Omega})$, we consider in the sequel issues of non-existence, existence, and multiplicity of variational solutions in $H_{1,0}^{2}(\Omega)$ for the borderline Dirichlet problem,

$$
\left\{\begin{align*}
-\Delta u-\gamma \frac{u}{|x|^{2}}-h_{0}(x) u & =\frac{|u|^{2^{\star}(s)-2} u}{|x|^{s}} & & \text { in } \Omega,  \tag{1}\\
u & =0 & & \text { on } \partial \Omega \backslash\{0\} .
\end{align*}\right.
$$

By solutions, we mean here functions $u \in H_{1,0}^{2}(\Omega)$, i.e., the completion of $C_{c}^{\infty}(\Omega)$ for the $L_{2}$-norm of the gradient $\|\nabla u\|_{2}$. This problem has by now a long history starting with the fact that when $\gamma=s=0$ and $h_{0}$ is a constant, it is the counterpart of the Yamabe problem [1, 26, 32] in Euclidian space, as initiated by Brezis-Nirenberg [5], with important contributions in the critical dimension $n=3$, by Druet [8], and for multiplicity results for $n \geq 7$, by Devillanova-Solimini [7], among many others.

The case dealing with least energy solutions for $s>0$ but $\gamma=0$, when the singularity 0 is on the boundary of the domain was initiated by Ghoussoub-Kang [18] and developed by Ghoussoub-Robert [19]. The case involving the Hardy potential, i.e., when $\gamma>0$, was introduced by Lin-Wadade [27] with a follow-up contribution by Ghoussoub-Robert [21]. This paper addresses remaining issues about the multiplicity of solutions, but also about obstructions to the existence of solutions and their stability under small perturbations.

The existence of solutions is related to the coercivity of the operator $-\Delta-\frac{\gamma}{|x|^{2}}-$ $h_{0}(x)$. It is clear that the operator $-\Delta-\frac{\gamma}{|x|^{2}}$ is coercive on $H_{1,0}^{2}(\Omega)$ whenever $\gamma<\gamma_{H}(\Omega)$, where $\gamma_{H}(\Omega)$ is the Hardy constant associated to the domain $\Omega$, that is

$$
\begin{equation*}
\gamma_{H}(\Omega):=\inf _{u \in H_{1,0}^{2}(\Omega) \backslash\{0\}} \frac{\int_{\Omega}|\nabla u|^{2} d x}{\int_{\Omega} \frac{u^{2}}{|x|^{2}} d x}, \tag{2}
\end{equation*}
$$

which has been extensively studied (see for example [17] and [21]). We recall that if $0 \in \Omega$, then

$$
\begin{equation*}
\gamma_{H}(\Omega)=\gamma_{H}\left(\mathbb{R}^{n}\right)=\frac{(n-2)^{2}}{4} \tag{3}
\end{equation*}
$$

When $0 \in \partial \Omega$, the situation is extremely different. For non-smooth domains modeled on cones, we refer to Egnell [13], and the more recent works of Cheikh-Ali $[23,24]$. If $\Omega$ is smooth, then, around 0 , the domain is modeled on the half-space $\mathbb{R}_{-}^{n}:=\left\{x \in \mathbb{R}^{n} ; x_{1}<0\right\}$. We then get that (see [21])

$$
\begin{equation*}
\frac{(n-2)^{2}}{4}<\gamma_{H}(\Omega) \leq \gamma_{H}\left(\mathbb{R}_{-}^{n}\right)=\frac{n^{2}}{4} \tag{4}
\end{equation*}
$$

Note that when $h_{0} \equiv 0$, (1) is the Euler-Lagrange equation for the following Hardy-Sobolev variational problem: For $\gamma<\gamma_{H}(\Omega)$ and $0 \leq s \leq 2$, there exists $\mu_{\gamma, s}(\Omega)>0$ such that

$$
\begin{equation*}
\mu_{\gamma, s}(\Omega)=\inf \left\{\frac{\int_{\Omega}|\nabla u|^{2} d x-\gamma \int_{\Omega} \frac{u^{2}}{|x|^{2}} d x}{\left(\int_{\Omega} \frac{|u|^{\star \star}(s)}{|x|^{s}} d x\right)^{\frac{2}{2 \times(s)}}} ; u \in H_{1,0}^{2}(\Omega) \backslash\{0\}\right\} \tag{5}
\end{equation*}
$$

Note that when $s=2$ and $\gamma=0$, this is the Hardy inequality mentioned above, while if $s=0$ and $\gamma=0$, it is the Sobolev inequality. If $\Omega=\mathbb{R}^{n}, s \in[0,2]$ and $\gamma \in\left(-\infty, \frac{(n-2)^{2}}{4}\right)$, (5) contains - after a suitable change of variables - the Caffarelli-Kohn-Nirenberg inequalities [6]. The latter state that there is a constant $C:=C(a, b, n)>0$ such that,

\begin{equation*}
\left(\int_{\mathbb{R}^{n}}|x|^{-b q}|u|^{q}\right)^{\frac{2}{q}} \leq C \int_{\mathbb{R}^{n}}|x|^{-2 a}|\nabla u|^{2} d x \text { for all } u \in C_{c}^{\infty}\left(\mathbb{R}^{n}\right) \tag{6}
\end{equation*}
$$

where

$$
\begin{equation*}
-\infty<a<\frac{n-2}{2}, \quad 0 \leq b-a \leq 1, \quad \text { and } \quad q=\frac{2 n}{n-2+2(b-a)} \tag{7}
\end{equation*}
$$

The first difficulty in these problems is due to the fact that $2^{\star}(s)$ is critical from the viewpoint of the Sobolev embeddings, in such a way that if $\Omega$ is bounded, then $H_{1,0}^{2}(\Omega)$ is embedded in the weighted space $L^{p}\left(\Omega,|x|^{-s}\right)$ for $1 \leq p \leq 2^{\star}(s)$, and the embedding is compact if and only if $p<2^{\star}(s)$. This lack of compactness defeats the classical minimization strategy to get extremals for (5). In fact, when $s=0$ and $\gamma=0$, this is the setting of the critical case in the classical Sobolev inequalities, which started this whole line of inquiry, due to its connection with the Yamabe problem on compact Riemannian manifolds [1], [32], [26]. Another complicating feature of the problem is that the term $\frac{u}{|x|^{2}}$ is as critical as $\frac{u^{2^{*}(s)-1}}{|x|^{s}}$ in the sense that they have the same homogeneity as the Laplacian. These difficulties are summarized by the invariance of the problem under conformal transformation. Indeed, for a function $u: \Omega \rightarrow \mathbb{R}$ and $r>0$, let

\begin{equation*}
u_{r}: x \mapsto r^{\frac{n-2}{2}} u(r \cdot x) \tag{8}
\end{equation*}
$$

and note that Equation (1) is then "essentially" invariant under the transformation $u \mapsto u_{r}$ in the sense that

$$
\left\{\begin{align*}
-\Delta u_{r}-\gamma \frac{u_{r}}{|x|^{2}}-r^{2} h_{0}(r x) u_{r} & =\frac{\left|u_{r}\right|^{2^{\star}(s)-2} u_{r}}{|x|^{s}} & & \text { in } r^{-1} \Omega  \tag{9}\\
u_{r} & =0 & & \text { on } r^{-1} \partial \Omega \backslash\{0\}
\end{align*}\right.
$$

This "invariance" is behind the lack of compactness in the embeddings associated to the variational formulation of (1), which prohibits the use of general abstract topological or variational methods. However, as one notices, the invariance is not complete, since the potential $h$ has changed, and the domain itself was transformed. As we shall see, both the geometry of the domain and -to a lesser extent- the potential $h$ break the invariance enough that one will be able to recover compactness for (1).

Another important aspect of this problem is the singularity at 0 and its location within the domain since the Hardy potential does not belong to the Kato class. Elliptic problems with singular potential arise in quantum mechanics, astrophysics, as well as in Riemannian geometry, in particular in the study of the scalar curvature problem on the standard sphere. Indeed, if the latter is equipped with its standard metric whose scalar curvature is singular at the north and south poles, then by considering its stereographic projection of $\mathbb{R}^{n}$, the problem of finding a conformal metric with prescribed scalar curvature $K(x)$ leads to finding solutions of the form $-\Delta u-\gamma \frac{u}{|x|^{2}}=K(x) u^{2^{\star}(0)-1}$ on $\mathbb{R}^{n}$. The latter is a simplified version of the nonlinear Wheeler-DeWitt equation, which appears in quantum cosmology (see $[2,3,28,34]$ and the references cited therein).

This paper deals specifically with the case where 0 belongs to the boundary of a smooth domain $\Omega$. We shall see that the boundary at 0 plays an important role, and our starting point is the existence Theorem 1 below for least energy solutions. It was first established by Ghoussoub-Robert [19] when $\gamma=0$, then by Lin-Wadade [27] when $0<\gamma<\frac{(n-2)^{2}}{4}$ under the assumption that the mean curvature at 0 is negative. The result was extended to the range $\gamma \leq \frac{n^{2}-1}{4}$ in [21], but more importantly, it was shown there that in the remaining range $\left(\frac{n^{2}-1}{4}, \frac{n^{2}}{4}\right)$, the curvature condition does not suffice anymore and a more global condition is needed: the boundary mass $m_{\gamma, h}(\Omega)$ of a domain associated to $\gamma$ and $h$, that we now recall.
1.1. The models and the definition of the mass. Letting formally $r \rightarrow 0$ in (9), we get that $u$ should behave like solutions to

\left\{\begin{align*}
-\Delta U-\gamma \frac{U}{|x|^{2}} & =\frac{|U|^{2^{\star}(s)-2} U}{|x|^{s}} & & \text { in } \mathbb{R}_{-}^{n}  \tag{10}\\
U & =0 & & \text { on } \partial \mathbb{R}_{-}^{n}
\end{align*}\right.
$$

To the best of our knowledge, no explicit positive solution of (10) is known. This was the reason why a specific blowup analysis was carried out in [19], which relied on the symmetry properties and a precise description of the asymptotic behavior of such solutions -also established in [19]. On the other hand, the asymptotic behavior of such nonlinear problems is governed by the solutions to the linear problem

$$
\left\{\begin{array}{rlc}
-\Delta U-\gamma \frac{U}{|x|^{2}} & =0 & \text { in } \mathbb{R}_{-}^{n},  \tag{11}\\
U & =0 & \text { on } \partial \mathbb{R}_{-}^{n} .
\end{array}\right.
$$

One can then easily see that a function of the form $u(x)=x_{1}|x|^{-\beta}$ is a solution to (11) if and only if $\beta \in\left\{\beta_{-}(\gamma), \beta_{+}(\gamma)\right\}$, where

$$
\begin{equation*}
\beta_{ \pm}(\gamma):=\frac{n}{2} \pm \sqrt{\frac{n^{2}}{4}-\gamma} \quad \text { for } \gamma<\frac{n^{2}}{4} \tag{12}
\end{equation*}
$$

Theorem-Definition 1 ([21]). Let $\Omega$ be a smooth bounded domain of $\mathbb{R}^{n}(n \geq 3)$ such that $0 \in \partial \Omega$. Suppose $\gamma<\frac{n^{2}}{4}$ and let $h \in C^{1}(\bar{\Omega})$ be such that the operator $-\Delta-\gamma|x|^{-2}-h$ is coercive. Assuming that

$$
\gamma>\frac{n^{2}-1}{4}
$$

then there exists $\mathcal{H} \in C^{2}(\bar{\Omega} \backslash\{0\})$ such that

$$
\left\{\begin{aligned}
-\Delta \mathcal{H}-\frac{\gamma}{|x|^{2}} \mathcal{H}+h(x) \mathcal{H} & =0 & & \text { in } \Omega \\
\mathcal{H} & >0 & & \text { in } \Omega \\
\mathcal{H} & =0 & & \text { on } \partial \Omega \backslash\{0\} .
\end{aligned}\right.
$$

Then, there exist constants $c_{1}, c_{2} \in \mathbb{R}$ with $c_{1}>0$ such that

$$
\mathcal{H}(x)=c_{1} \frac{d(x, \partial \Omega)}{|x|^{\beta_{+}(\gamma)}}+c_{2} \frac{d(x, \partial \Omega)}{|x|^{\beta_{-}(\gamma)}}+o\left(\frac{d(x, \partial \Omega)}{|x|^{\beta_{-}(\gamma)}}\right)
$$

as $x \rightarrow 0$. In the spirit of Schoen-Yau [33], we define the boundary mass as

$$
m_{\gamma, h}(\Omega):=\frac{c_{2}}{c_{1}}
$$

which is independent of the choice of $\mathcal{H}$.
The problem of existence of least energy solutions can now be summarized in the following theorem, whose proof can also be deduced from the refined blow-up techniques developed in this paper.

Theorem 1 (G.-R.[19], Lin-Wadade [27], G.-R. [21]). Let $\Omega$ be a smooth bounded domain in $\mathbb{R}^{n}(n \geq 3)$ such that the singularity 0 belongs to the boundary $\partial \Omega$. Suppose that $0<s<2$ and fix $h_{0} \in C^{1}(\bar{\Omega})$ such that $-\Delta-\gamma|x|^{-2}-h_{0}$ is coercive. Assume one of the following two conditions:

- $\gamma \leq \frac{n^{2}-1}{4}$ and the mean curvature of $\partial \Omega$ at 0 is negative.
- $\frac{n^{2}-1}{4}<\gamma<\frac{n^{2}}{4}$ and the boundary mass $m_{\gamma, h_{0}}(\Omega)$ is positive.

Then, there is a positive solution to (1) that is a minimizer for the associated variational problem,

$$
\begin{equation*}
\inf \left\{\frac{\int_{\Omega}|\nabla u|^{2} d x-\gamma \int_{\Omega} \frac{u^{2}}{|x|^{2}} d x-\int_{\Omega} h_{0}(x) u^{2} d x}{\left(\int_{\Omega} \frac{|u|^{2 \star}(s)}{|x|^{s}} d x\right)^{\frac{2}{2 \star(s)}}} ; u \in H_{1,0}^{2}(\Omega) \backslash\{0\}\right\} \tag{13}
\end{equation*}
$$

Our focus in this project, is to investigate the extent to which the above local curvature condition at 0 and the global (mass) condition on the domain are necessary for the existence of positive solutions. Most importantly, we give results pertaining to the persistence of the lack of positive solutions for (1) under $C^{1}$-perturbations of the potential $h$. We will also show that, under suitable curvature conditions, this equation has an infinite number of non-necessarily positive solutions.

Both existence and non-existence results will follow from a sharp blow-up analysis of solutions to perturbations of Equation (1). More precisely, we consider

$$
\begin{equation*}
p_{\epsilon} \in\left[0,2^{\star}(s)-2\right) \text { such that } \lim _{\epsilon \rightarrow 0} p_{\epsilon}=0 \tag{14}
\end{equation*}
$$

and a family $\left(h_{\epsilon}\right)_{\epsilon>0} \in C^{1}(\bar{\Omega})$ such that

$$
\begin{equation*}
\lim _{\epsilon \rightarrow 0} h_{\epsilon}=h_{0} \text { in } C^{1}(\bar{\Omega}) \text { and }-\Delta-\frac{\gamma}{|x|^{2}}-h_{0} \text { is coercive in } \Omega \tag{15}
\end{equation*}
$$

We then perform a blow-up analysis, as $\epsilon$ go to zero, on a sequence of functions $\left(u_{\epsilon}\right)_{\epsilon>0}$ in $H_{1,0}^{2}(\Omega)$ such that $u_{\epsilon}$ is a solution to the Dirichlet boundary value problems:

$$
\left\{\begin{align*}
-\Delta u_{\epsilon}-\gamma \frac{u_{\epsilon}}{|x|^{2}}-h_{\epsilon} u_{\epsilon} & =\frac{\left|u_{\epsilon}\right|^{2^{\star}(s)-2-p_{\epsilon}} u_{\epsilon}}{|x|^{s}} & & \text { in } \Omega \\
u_{\epsilon} & =0 & & \text { on } \partial \Omega .
\end{align*}\right.
$$

The novelty and delicacy of our analysis stem from the fact that the sequence $\left(u_{\epsilon}\right)_{\epsilon>0}$ might blow up along excited states, as opposed to a unique ground state in [19]. Moreover, the sequence $\left(u_{\epsilon}\right)_{\epsilon>0}$ is not assumed to have a fixed sign.
1.2. Non-existence: stability of the Pohozaev obstruction. Starting with issues of non-existence of solutions, we shall prove the following surprising stability of regimes where variational positive solutions do not exist.

Theorem 2. Let $\Omega$ be a smooth bounded domain in $\mathbb{R}^{n}(n \geq 3)$ such that the singularity 0 belongs to the boundary $\partial \Omega$. Assume that $0<s<2$ and $\gamma<n^{2} / 4$. Fix $h_{0} \in C^{1}(\bar{\Omega})$ such that $-\Delta-\gamma|x|^{-2}-h_{0}$ is coercive, and assume that one of the following conditions hold:

- $\gamma \leq \frac{n^{2}-1}{4}$ and the mean curvature at 0 is non-zero;
- $\gamma>\frac{n^{2}-1}{4}$ and the boundary mass $m_{\gamma, h_{0}}(\Omega)$ is non-zero.

If there is no positive variational solution to (1) with $h=h_{0}$, then for all $\Lambda>0$, there exists $\epsilon:=\epsilon\left(\Lambda, h_{0}\right)>0$ such that for any $h \in C^{1}(\bar{\Omega})$ with $\left\|h-h_{0}\right\|_{C^{1}(\Omega)}<\epsilon$, there is no positive solution to (1) such that $\|\nabla u\|_{2} \leq \Lambda$.

The above result is surprising for the following reason: Assuming $\Omega$ is starshaped with respect to 0 , then the classical Pohozaev obstruction (see Section 11) yields that (1) has no positive variational solution whenever

$$
\begin{equation*}
h_{0}(x)+\frac{1}{2}\left(\nabla h_{0}(x), x\right) \leq 0 \text { for all } x \in \Omega . \tag{16}
\end{equation*}
$$

We then get the following corollaries.
Corollary 1. Let $\Omega$ be a smooth bounded domain in $\mathbb{R}^{n}(n \geq 3)$ such that $0 \in \partial \Omega$. Assume $\Omega$ is starshaped with respect to $0,0<s<2$ and $\gamma<\gamma_{H}(\Omega)$. If $\gamma \leq \frac{n^{2}-1}{4}$, we shall also assume that the mean curvature at 0 is non-vanishing. If $h_{0}$ is a potential satisfying (16), then for all $\Lambda>0$, there exists $\epsilon\left(\Lambda, h_{0}\right)>0$ such that for all $h \in C^{1}(\bar{\Omega})$ satisfying $\left\|h-h_{0}\right\|_{C^{1}(\Omega)}<\epsilon\left(\Lambda, h_{0}\right)$, there is no positive solution to (1) such that $\|\nabla u\|_{2} \leq \Lambda$.

Corollary 2. Let $\Omega$ be a smooth bounded domain in $\mathbb{R}^{n}(n \geq 3)$, such that $0 \in \partial \Omega$. We fix $0<s<2$ and $\gamma<\gamma_{H}(\Omega)$, the Hardy constant defined in (2). Assume that
$\Omega$ is starshaped with respect to 0 .
When $\gamma \leq \frac{n^{2}-1}{4}$, we assume that the mean curvature at 0 is positive. Then for all $\Lambda>0$, there exists $\epsilon(\Lambda)>0$ such that for all $\lambda \in[0, \epsilon(\Lambda))$, there is no positive solution to

$$
\left\{\begin{array}{cl}
-\Delta u-\gamma \frac{u}{|x|^{2}}-\lambda u=\frac{u^{2^{\star}(s)-1}}{|x|^{s}} & \text { in } \Omega,  \tag{17}\\
u>0 & \text { in } \Omega \\
u=0 & \text { on } \partial \Omega \backslash\{0\}
\end{array}\right.
$$

with $\|\nabla u\|_{2} \leq \Lambda$.

It is worth comparing these results to what happens in the nonsingular case. Indeed, in contrast to the singular case, a celebrated result of Brezis-Nirenberg [5] shows that, for $\gamma=s=0$, a variational solution to (17) always exists whenever $n \geq 4$ and $0<\lambda<\lambda_{1}(\Omega)$, with the geometry of the domain playing no role whatsoever. On the other hand, Druet-Laurain [12] showed that the geometry plays a role in dimension $n=3$, still for $\gamma=s=0$, by proving that when $\Omega$ is star-shaped, then there is no solution to (17) for all small values of $\lambda>0$ (with no apriori bound on $\|\nabla u\|_{2}$ ). Another point of view is that for $n=3$, the nonexistence of solutions persists under small perturbations, but it does not for $n \geq 4$ : the Pohozaev obstruction is stable only for $n=3$ in the nonsingular case.
This is in stark contrast with the situation here, i.e. when $0 \in \partial \Omega$ and $s>0$. In this case, for both the existence and non-existence results, the geometry plays a role in all dimensions: it is either the local geometry at 0 (i.e., depending on whether the mean curvature at 0 is vanishing or not) in high dimensions, or the global geometry of the domain (i.e., depending on whether the mass is positive or the domain is star-shaped) in low dimensions. Corollaries 1 and 2 show that the Pohozaev obstruction is stable in all dimensions in the singular case.
Let us discuss some extensions related to this absence or not of low/large dimension phenomenon.

- Our stability result still holds under an additional smooth perturbation of the domain $\Omega$, as was done by Druet-Hebey-Laurain [10] when $n=3$, $\gamma=s=0$.
- In the forthcoming paper [16], we tackle the case of the interior singularity $0 \in \Omega$, where the results are much more in the spirit of Brezis-Nirenberg and Druet-Laurain concerning the dichotomy between low and high dimensions.
- On of the main features of the stability result of Druet-Laurain [12] is the absence of any apriori control on $\|\nabla u\|_{2}$. In the interor case $0 \in \Omega$, we expect to get rid also of the apriori bound in the singular case $s>0$. In the boundary case $0 \in \partial \Omega$, bypassing the apriori bound by $\Lambda$ is more delicate and will require extra care. These issues are projects in progress.

The proof of Theorem 2 (and Corollaries 1 and 2) relies on the blow-up analysis. Namely, arguing by contradiction, we assume the existence of solutions $\left(u_{\epsilon}\right)_{\epsilon}$ to (17) with $p_{\epsilon} \equiv 0$ and $\left(h_{\epsilon}\right)_{\epsilon} \rightarrow h_{0}$ in $C^{1}$ with a control on the Dirichlet energy. Due to the "invariance" under the conformal transformation (8), the $u_{\epsilon}$ 's might concentrate on some peaks at 0 . The formation of these peaks is described via blow-up analysis in Proposition 3. Then Proposition 6 applies which yields vanishing of the mean curvature or the mass, depending on the dimension, contradicting the hypothesis of Theorem 2. Concerning Corollaries 1 and 2, the hypothesis imply that the mass is negative when defined.
1.3. Multiplicity of sign-changing solutions. As to the question of multiplicity, we shall prove the following result, which uses that in the subcritical case, i.e., when $p_{\epsilon}>0$, there is an infinite number of higher energy solutions for such $\epsilon$. Again, the core of the proof is a sharp blow-up analysis of such solutions as $p_{\epsilon} \rightarrow 0$.

Theorem 3 (The general case). Let $\Omega$ be a smooth bounded domain in $\mathbb{R}^{n}, n \geq 3$, such that $0 \in \partial \Omega$ and assume that $0<s<2$. Let $h_{0} \in C^{1}(\bar{\Omega})$ and $\left(h_{\epsilon}\right)_{\epsilon>0} \in C^{1}(\bar{\Omega})$ be such that (15) holds, and let $\left(p_{\epsilon}\right)_{\epsilon>0}$ be such that (14) holds. Consider a sequence
of functions $\left(u_{\epsilon}\right)_{\epsilon>0}$ that is uniformly bounded in $H_{1,0}^{2}(\Omega)$ such that for each $\epsilon>0$, $u_{\epsilon}$ satisfies Equation $\left(E_{\epsilon}\right)$. Then,
(1) If $\gamma<\frac{n^{2}}{4}-1$ and the principal curvatures of $\partial \Omega$ at 0 are non-positive but not all of them vanish, then the sequence $\left(u_{\epsilon}\right)_{\epsilon>0}$ is pre-compact in $H_{1,0}^{2}(\Omega)$.
(2) In particular, Equation (1) has an infinite number of (possibly sign-changing) solutions in $H_{1,0}^{2}(\Omega)$.

The above result was established by Ghoussoub-Robert [20] in the case when $\gamma=0$. The main challenge here is to prove the compactness of the subcritical solutions at high energy levels, as the nonlinearities approach the critical exponent. The multiplicity result then follows from standard min-max methods. The proof relies heavily on pointwise blow-up analysis techniques in the spirit of Druet-HebeyRobert [11] and Druet [9], though our situation adds considerable difficulties to carrying out the program.
1.4. Compactness Theorems and blow-up analysis. As mentioned above, the central tool is an analysis of the formation of peaks on families $\left(u_{\epsilon}\right)_{\epsilon}$ of solutions to equations like (1) when blow-up occurs. This long analysis yields Propositions 5 and 6 that describe the blow-up rate. When blowup does not occur, there is compactness. The following theorems are immediate consequences of these propositions.

We note that the restrictions on both $\gamma$ and on the curvature at 0 are more stringent than for the existence of a ground state solution in Theorem 1. The stronger assumptions turned out to be due to the potentially sign-changing approximate solutions -actually solutions of subcritical problems- and not because they are not necessarily minimizing. Indeed, the following theorem does not assume any smallness of the energy bound as long as the approximate solutions are positive. It therefore yields another proof for Theorem 1, which does not rely on the existence of minimizing sequence below the energy level of a single bubble.

Theorem 4 (The non-changing sign case). Assume in addition to the hypothesis of Theorem 3, that the solutions $\left(u_{\epsilon}\right)_{\epsilon>0}$ satisfy for all $\epsilon>0$,

Then, the sequence $\left(u_{\epsilon}\right)_{\epsilon>0}$ is pre-compact in $H_{1,0}^{2}(\Omega)$, provided one of the following conditions is satisfied:

- $\gamma \leq \frac{n^{2}-1}{4}$ and the mean curvature of $\partial \Omega$ at 0 is negative.
- $\frac{n^{2}-1}{4}<\gamma<\frac{n^{2}}{4}$ and the boundary mass $m_{\gamma, h_{0}}(\Omega)$ is positive.

Our method also shows that if the -possibly sign-changing- sequence is weakly null, then the compactness result in Theorem 3 will still hold for $\gamma$ up to $\frac{n^{2}}{4}-\frac{1}{4}$ :

Theorem 5 (The case of a weak null limit). Assume in addition to the hypothesis of Theorem 3, that the solutions $\left(u_{\epsilon}\right)_{\epsilon>0}$ satisfy,

If $\gamma<\frac{n^{2}-1}{4}$ and the principal curvatures of $\partial \Omega$ at 0 are non-positive but not all of them vanishing, then the sequence $\left(u_{\epsilon}\right)_{\epsilon>0}$ converges strongly to 0 in $H_{1,0}^{2}(\Omega)$.
1.5. Structure of the manuscript. This paper is organized as follows. Section 2 consists in preliminary material in order to introduce the sequence of functions that will be thoroughly analyzed in Sections 3 to 8 in the case where they "blow-up". Section 9 contains the proof of the multiplicity result and Section 10 will have the applications to non-existence regimes and their stability under perturbations. We then have five relevant appendices. The first (Appendix A, Section 11) introduces the Pohozaev identity in our setting. The second (Appendix B, Section 12) contains a technical lemma on the continuity of the first eigenvalue $\lambda_{1}(\Delta+V)$ with respect to variations of the potential $V$. Appendix C (Section 13) recalls regularity results established in [21] about the regularity and behavior at 0 of solutions of equations involving the Hardy-Schrödinger operator on bounded domains having 0 on their boundary. In Appendix D (Section 14), we construct the Green functions associated to the operators $-\Delta-\frac{\gamma}{|x|^{2}}-h$ on such domains, and exhibit some of their properties needed throughout the memoir. The last Appendix E (Section 15) does the same but for the Hardy-Schrödinger operator $-\Delta-\frac{\gamma}{|x|^{2}}$ on $\mathbb{R}_{-}^{n}$.

## 2. Setting up the blow-up

Throughout this paper, $\Omega$ will always be a smooth bounded domain of $\mathbb{R}^{n}$, $n \geq 3$, such that $0 \in \partial \Omega$. We will always assume that $\gamma<\frac{n^{2}}{4}$ and $s \in(0,2)$. We set $2^{\star}(s):=\frac{2(n-s)}{n-2}$. When $\gamma<\gamma_{H}(\Omega)$, then the following Hardy-Sobolev inequality holds on $\Omega$ : there exists $C>0$ such that

For each $\epsilon>0$, we consider $p_{\epsilon} \in\left[0,2^{\star}(s)-2\right)$ such that

Let $h_{0} \in C^{1}(\bar{\Omega})$ and consider a family $\left(h_{\epsilon}\right)_{\epsilon>0} \in C^{1}(\bar{\Omega})$ such that (15) holds. Consider a sequence of functions $\left(u_{\epsilon}\right)_{\epsilon>0}$ in $H_{1,0}^{2}(\Omega)$ such that for all $\epsilon>0$ the function $u_{\epsilon}$ is a solution to the Dirichlet boundary value problem:

By the regularity result Theorem 6 in Appendix B, we have $u_{\epsilon} \in C^{2}(\bar{\Omega} \backslash\{0\})$ and there exists $K_{\epsilon} \in \mathbb{R}$ such that $\lim _{x \rightarrow 0} \frac{|x|^{\beta-(\gamma)} u_{\epsilon}(x)}{d(x, \partial \Omega)}=K_{\epsilon}$. In addition, we assume that the sequence $\left(u_{\epsilon}\right)_{\epsilon>0}$ is bounded in $H_{1,0}^{2}(\Omega)$ and we let $\Lambda>0$ be such that

From the regularity Theorem 6 we have $u_{0} \in C^{2}(\bar{\Omega} \backslash\{0\})$ and $\lim _{x \rightarrow 0} \frac{|x|^{\beta-}(\gamma)}{d(x, \partial \Omega)} u_{0}(x)$, $K_{0} \in \mathbb{R}$. It then follows that $\sup _{\Omega} \frac{|x|^{\beta_{-}(\gamma)} u_{0}(x)}{d(x, \partial \Omega)}$ and hence $\left\||x|^{\beta_{-}(\gamma)-1} u_{0}(x)\right\|_{L^{\infty}(\Omega)}$ is finite.

We fix $\tau \in \mathbb{R}$ such that

The following proposition shows that the sequence $\left(u_{\epsilon}\right)_{\epsilon}$ is pre-compact in $H_{1,0}^{2}(\Omega)$ if $\left(|x|^{\tau} u_{\epsilon}\right)_{\epsilon>0}$ is uniformly bounded in $L^{\infty}(\Omega)$.
Proposition 1. Let $\Omega$ be a smooth bounded domain of $\mathbb{R}^{n}$, $n \geq 3$, such that $0 \in \partial \Omega$ and assume that $0<s<2, \gamma<\frac{n^{2}}{4}$. We let $\left(u_{\epsilon}\right)$, $\left(h_{\epsilon}\right)$ and $\left(p_{\epsilon}\right)$ be such that $\left(E_{\epsilon}\right)$, (15) and (21) holds. Suppose that there exists $C>0$ such that $|x|^{\tau}\left|u_{\epsilon}(x)\right| \leq C$ for all $x \in \Omega$ and for all $\epsilon>0$. Then up to a subsequence, $\lim _{\epsilon \rightarrow 0} u_{\epsilon}=u_{0}$ in $H_{1,0}^{2}(\Omega)$, where $u_{0}$ is as in (23).

Proof of Proposition 1: The sequence $\left(u_{\epsilon}\right)$ is clearly uniformly bounded in $L^{\infty}\left(\Omega^{\prime}\right)$ for any $\Omega^{\prime} \subset \subset \bar{\Omega} \backslash\{0\}$. Then by standard elliptic estimates and from (23) it follows that $u_{\epsilon} \rightarrow u_{0}$ in $C_{l o c}^{2}(\bar{\Omega} \backslash\{0\})$. Now since $|x|^{\tau}\left|u_{\epsilon}(x)\right| \leq C$ for all $x \in \Omega$ and for all $\epsilon>0$, and since $\tau<\frac{n-2}{2}$, we have

$$

From $\left(E_{\epsilon}\right)$ and (23) we then obtain

And hence $\lim _{\epsilon \rightarrow 0} u_{\epsilon}=u_{0}$ in $H_{1,0}^{2}(\Omega)$. This proves Proposition 1.
From now on, we assume that

## 3. Scaling Lemmas

In this section we state and prove two scaling lemmas which we shall use many times in our analysis. We start by describing a parametrization around a point of the boundary $\partial \Omega$. Let $p \in \partial \Omega$. Then there exists $U, V$ open in $\mathbb{R}^{n}$, there exists $I \subset \mathbb{R}$ an open interval, there exists $U^{\prime} \subset \mathbb{R}^{n-1}$ an open subset, and there exist a
smooth diffeomorphism $\mathcal{T}: U \longrightarrow V$ and $\mathcal{T}_{0} \in C^{\infty}\left(U^{\prime}\right)$, such that upto a rotation of coordinates if necessary

- $\quad 0 \in U=I \times U^{\prime}$ and $p \in V$.
- $\mathcal{T}(0)=p$.
- $\mathcal{T}\left(U \cap\left\{x_{1}<0\right\}\right)=V \cap \Omega$ and $\mathcal{T}\left(U \cap\left\{x_{1}=0\right\}\right)=V \cap \partial \Omega$.
- $D_{0} \mathcal{T}=\mathbb{I}_{\mathbb{R}^{n}}$. Here $D_{x} \mathcal{T}$ denotes the differential of $\mathcal{T}$ at the point $x$ and $\mathbb{I}_{\mathbb{R}^{n}}$ is the identity map on $\mathbb{R}^{n}$.
- $\mathcal{T}_{*}(0)\left(e_{1}\right)=\nu_{p}$ where $\nu_{p}$ denotes the outer unit normal vector to $\partial \Omega$ at the point $p$.
- $\left\{\mathcal{T}_{*}(0)\left(e_{2}\right), \cdots, \mathcal{T}_{*}(0)\left(e_{n}\right)\right\}$ forms an orthonormal basis of $T_{p} \partial \Omega$.
- $\mathcal{T}\left(x_{1}, y\right)=p+\left(x_{1}+\mathcal{T}_{0}(y), y\right)$ for all $\left(x_{1}, y\right) \in I \times U^{\prime}=U$
- $\mathcal{T}_{0}(0)=0$ and $\nabla \mathcal{T}_{0}(0)=0$.

This boundary parametrization will be throughout useful during our analysis. An important remark is that

Let $\left(u_{\epsilon}\right),\left(h_{\epsilon}\right)$ and $\left(p_{\epsilon}\right)$ be such that $\left(E_{\epsilon}\right)$, (15), (21) and (22) holds. Let $\left(y_{\epsilon}\right)_{\epsilon} \in \Omega$ and let

weakly in $B_{2 \rho}(0)$ for all $\epsilon>0$. With the help of (31) and standard elliptic theory it then follows that there exists $v \in C^{1}\left(B_{2 \rho}(0)\right)$ such that

\end{equation*}
$$

and therefore $v \not \equiv 0$.
On the other hand, a change of variables and the definition of $\kappa_{\epsilon}$ yields

\int_{B_{\rho \kappa_{\epsilon}}\left(y_{\epsilon}\right)} \frac{\left|u_{\epsilon}\right|^{2^{\star}(s)-p_{\epsilon}}}{|x|^{s}} d x & =\frac{\left|u_{\epsilon}\left(y_{\epsilon}\right)\right|^{2^{\star}(s)-p_{\epsilon}} \kappa_{\epsilon}^{n}}{\left|y_{\epsilon}\right|^{s}} \int_{B_{\rho}(0)} \frac{\left.\left|v_{\epsilon}\right|\right|^{\star}(s)-p_{\epsilon}}{\left|\frac{y_{\epsilon}}{\mid y_{\epsilon}}+\frac{\kappa_{\epsilon}}{\left|y_{\epsilon}\right|} x\right|^{s}} d x \\
& =\ell_{\epsilon}^{-\left(1+\frac{2(2-s)}{2^{\star(s)-2-p_{\epsilon}}}\right)}\left(\frac{\left|y_{\epsilon}\right|}{\ell_{\epsilon}}\right)^{s\left(\frac{n-2}{2}\right)} \int_{B_{\rho}(0)} \frac{\left|v_{\epsilon}\right|^{2^{\star}(s)-p_{\epsilon}}}{\left|\frac{y_{\epsilon}}{\left|y_{\epsilon}\right|}+\frac{\kappa_{\epsilon}}{\left|y_{\epsilon}\right|^{s}} x\right|^{s}} d x \\
& \geq\left(\frac{\left|y_{\epsilon}\right|}{\ell_{\epsilon}}\right)^{s\left(\frac{n-2}{2}\right)} \int_{B_{\rho}(0)} \frac{\left|v_{\epsilon}\right|^{2^{\star}(s)-p_{\epsilon}}}{\left|\frac{y_{\epsilon}}{\left|y_{\epsilon}\right|}+\frac{\kappa_{\epsilon}}{\left|y_{\epsilon}\right|} x\right|^{s}} d x .

We
let $\Delta_{g}=\operatorname{div}_{g}(\nabla)$ the Laplace-Beltrami operator with respect to the metric $g$. As easily checked, using ( $E_{\epsilon}$ ) we get that for all $\epsilon>0$

weakly in $B_{R}(0) \cap\left\{x_{1}<0\right\}$. In this expression, $\tilde{g}_{\epsilon}=g\left(\tilde{z}_{\epsilon}+\kappa_{\epsilon} x\right)$ and $\Delta_{\tilde{g}_{\epsilon}}$ is the Laplace-Beltrami operator with respect to the metric $\tilde{g}_{\epsilon}$. With (34), (35) and (36), we get for all $\epsilon>0$

\end{array}

And $\tilde{w}$ satisfies weakly the equation

Moreover if $\tilde{w} \not \equiv 0$, then

$$

and there exists $t \in(0,1]$ such that $\lim _{\epsilon \rightarrow 0} \nu_{\epsilon}^{p_{\epsilon}}=t$, where $\mu_{\gamma, s}\left(\mathbb{R}_{-}^{n}\right)$ is as in (5).
Proof of Lemma 2: The proof proceeds in four steps.
Step 2.1: Let $\eta \in C_{c}^{\infty}\left(\mathbb{R}^{n}\right)$. One has that $\eta \tilde{w}_{\epsilon} \in H_{0,1}^{2}\left(\mathbb{R}_{-}^{n}\right)$ for $\epsilon>0$ sufficiently small. We claim that there exists $\tilde{w}_{\eta} \in H_{1,0}^{2}\left(\mathbb{R}_{-}^{n}\right)$ such that upto a subsequence

\lim _{\epsilon \rightarrow 0} \eta_{R} \tilde{w}_{\epsilon}=\tilde{w}_{R} \quad \text { in } C_{l o c}^{1}\left(B_{R / 2}(0) \backslash\{0\} \cap \overline{\mathbb{R}_{-}^{n}}\right)
$$

Letting $\epsilon \rightarrow 0$ in eqn (43) gives that $w_{R}$ satisfies weakly the equation

$$
-\Delta \tilde{w}_{R}-\frac{\gamma}{|x|^{2}} \tilde{w}_{R}=\frac{\left|\tilde{w}_{R}\right|^{2^{\star}(s)-2-p_{\epsilon}} \tilde{w}_{R}}{|x|^{s}}
$$

Again we have that $\left|\tilde{w}_{R}(x)\right| \leq C(R, \delta)$ for all $x \in \overline{B_{R / 2}(0)} \backslash \overline{B_{2 \delta}(0)}$ and then again from standard elliptic estimates it follows that $\tilde{w} \in C^{1}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\{0\}\right)$ and $\lim _{R \rightarrow+\infty} \tilde{w}_{R}=\tilde{w}$ in $C_{l o c}^{1}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\{0\}\right)$, up to a subsequence. Letting $R \rightarrow+\infty$ we obtain that $\tilde{w}$ satisfies weakly the equation

\left\{\begin{aligned}
-\Delta \tilde{w}-\frac{\gamma}{|x|^{2}} \tilde{w} & =\frac{|\tilde{w}|^{2^{\star}(s)-2} \tilde{w}}{|x|^{s}} & & \text { in } \mathbb{R}_{-}^{n} \\
\tilde{w} & =0 & & \text { on } \partial \mathbb{R}_{-}^{n} \backslash\{0\}
\end{aligned}\right.
$$

This proves our claim.
Step 2.4: Coming back to equation (41) we have for $R>0$

\int_{\mathbb{R}_{-}^{n}}\left|\nabla\left(\eta_{R} \tilde{w}_{\epsilon}\right)\right|^{2} d x & \leq C(\theta)\left(\int_{\left\{x \in \mathbb{R}_{-}^{n}: R<|x|<2 R\right\}}\left(\eta_{2 R} \tilde{w}_{\epsilon}\right)^{2^{*}} d x\right)^{\frac{n-2}{n}} \\
& +(1+\theta)\left(\frac{\nu_{\epsilon}}{\ell_{\epsilon}}\right)^{n-2} \int_{\Omega}\left|\nabla u_{\epsilon}\right|^{2} d x \tag{44}
\end{align*}
$$

Since the sequence $\left(u_{\epsilon}\right)_{\epsilon}$ is bounded in $H_{1,0}^{2}(\Omega)$, letting $\epsilon \rightarrow 0$ and then $R \rightarrow+\infty$ we obtain for some constant $C$

Now if $w \not \equiv 0$ weakly satisfies the equation

\tilde{w} & =0 & & \text { on } \partial \mathbb{R}_{-}^{n} \backslash\{0\}
\end{aligned}\right.
$$

using the definition of $\mu_{\gamma, s}\left(\mathbb{R}_{-}^{n}\right)$ it then follows that

\int_{\mathbb{R}_{-}^{n}} \frac{|w|^{2^{\star}(s)}}{|x|^{s}} \geq \mu_{\gamma, s}\left(\mathbb{R}_{-}^{n}\right)^{\frac{2^{\star}(s)}{2^{\star(s)-2}}}

Hence $\lim _{\epsilon \rightarrow 0}\left(\frac{\nu_{\epsilon}}{\ell_{\epsilon}}\right)>0$ which implies that

Since $\lim _{\epsilon \rightarrow 0} \nu_{\epsilon}=0$, therefore we have that $0<t \leq 1$. This completes the lemma.

## 4. Construction and exhaustion of the blow-up scales

In this section we prove the following proposition in the spirit of Druet-HebeyRobert [11]:

Proposition 2. Let $\Omega$ be a smooth bounded domain of $\mathbb{R}^{n}, n \geq 3$, such that $0 \in \partial \Omega$ and assume that $0<s<2, \gamma<\frac{n^{2}}{4}$. Let $\left(u_{\epsilon}\right)$, $\left(h_{\epsilon}\right)$ and $\left(p_{\epsilon}\right)$ be such that $\left(E_{\epsilon}\right)$, (15), (21) and (22) holds. Assume that blow-up occurs, that is

$$
\lim _{\epsilon \rightarrow 0}\left\||x|^{\tau} u_{\epsilon}\right\|_{L^{\infty}(\Omega)}=+\infty \quad \text { where } \quad \beta_{-}(\gamma)-1<\tau<\frac{n-2}{2}
$$

Then there exists $N \in \mathbb{N}^{\star}$ families of scales $\left(\mu_{i, \epsilon}\right)_{\epsilon>0}$ such that we have:
(A1) $\lim _{\epsilon \rightarrow 0} u_{\epsilon}=u_{0}$ in $C_{l o c}^{2}(\bar{\Omega} \backslash\{0\})$ where $u_{0}$ is as in(23).
(A2) $0<\mu_{1, \epsilon}<\ldots<\mu_{N, \epsilon}$, for all $\epsilon>0$.
(A3) $\lim _{\epsilon \rightarrow 0} \mu_{N, \epsilon}=0$ and $\lim _{\epsilon \rightarrow 0} \frac{\mu_{i+1, \epsilon}}{\mu_{i, \epsilon}}=+\infty$ for all $1 \leq i \leq N-1$.
(A4) For any $1 \leq i \leq N$ and for $\epsilon>0$ we rescale and define

where $k_{i, \epsilon}=\mu_{i, \epsilon}^{1-\frac{p_{\epsilon}}{2^{\star}(s)-2}}$. Then there exists $\tilde{u}_{i} \in H_{1,0}^{2}\left(\mathbb{R}_{-}^{n}\right) \cap C^{1}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\{0\}\right)$, $\tilde{u}_{i} \not \equiv 0$ such that $\tilde{u}_{i}$ weakly solves the equation

-\Delta \tilde{u}_{i}-\frac{\gamma}{|x|^{2}} \tilde{u}_{i} & =\frac{\left|\tilde{u}_{i}\right|^{2^{\star}(s)-2} \tilde{u}_{i}}{|x|^{s}} & & \text { in } \mathbb{R}_{-}^{n} \\
\tilde{u}_{i} & =0 & & \text { on } \partial \mathbb{R}_{-}^{n} \backslash\{0\}
\end{aligned}\right.
$$

and

$$
\begin{array}{rcr}
\tilde{u}_{i, \epsilon} \longrightarrow \tilde{u}_{i} & \text { in } C_{l o c}^{1}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\{0\}\right) & \text { as } \epsilon \rightarrow 0 \\
\tilde{u}_{i, \epsilon} & \rightharpoonup \tilde{u}_{i} & \text { weakly in } H_{1,0}^{2}\left(\mathbb{R}_{-}^{n}\right)
\end{array} \quad \text { as } \epsilon \rightarrow 0
$$

(A5) There exists $C>0$ such that

|x|^{\frac{n-2}{2}}\left|u_{\epsilon}(x)\right|^{1-\frac{p_{\epsilon}}{2 \star(s)-2}} \leq C \quad \text { for all } \epsilon>0 \text { and all } x \in \Omega
$$

(A6) $\lim _{R \rightarrow+\infty} \lim _{\epsilon \rightarrow 0} \sup _{\Omega \backslash B_{R k_{N, \epsilon}}(0)}|x|^{\frac{n-2}{2}}\left|u_{\epsilon}(x)-u_{0}(x)\right|^{1-\frac{p_{\epsilon}}{2^{\star(s)-2}}}=0$.
(A7) $\lim _{\delta \rightarrow 0} \lim _{\epsilon \rightarrow 0} \sup _{B_{\delta k_{1, \epsilon}}(0) \cap \Omega}|x|^{\frac{n-2}{2}}\left|u_{\epsilon}(x)-\mu_{1, \epsilon}^{-\frac{n-2}{2}} \tilde{u}_{1}\left(\frac{\mathcal{T}^{-1}(x)}{k_{1, \epsilon}}\right)\right|^{1-\frac{p_{\epsilon}}{2^{\star}(s)-2}}=0$.
(A8) For any $\delta>0$ and any $1 \leq i \leq N-1$, we have

\lim _{R \rightarrow+\infty} \lim _{\epsilon \rightarrow 0} \sup _{\delta k_{i+1, \epsilon} \geq|x| \geq R k_{i, \epsilon}}|x|^{\frac{n-2}{2}}\left|u_{\epsilon}(x)-\mu_{i+1, \epsilon}^{-\frac{n-2}{2}} \tilde{u}_{i+1}\left(\frac{\mathcal{T}^{-1}(x)}{k_{i+1, \epsilon}}\right)\right|^{1-\frac{p_{\epsilon}}{2^{\star}(s)-2}}=0 .
$$

(A9) For any $i \in\{1, \ldots, N\}$, there exists $t_{i} \in(0,1]$ such that $\lim _{\epsilon \rightarrow 0} \mu_{i, \epsilon}^{p_{\epsilon}}=t_{i}$.
The proof of this proposition is inspired by [11] and proceeds in five steps.
Since $s>0$, the subcriticality $2^{\star}(s)<2^{\star}(s)$ of equations $\left(E_{\epsilon}\right)$ along with (23) yields that $u_{\epsilon} \rightarrow u_{0}$ in $C_{l o c}^{2}(\bar{\Omega} \backslash\{0\})$. So the only blow-up point is the origin.
Step 4.1: The construction of the $\mu_{i, \epsilon}$ 's proceeds by induction. This step is the initiation.

By the regularity Theorem 6 and the definition of $\tau$ in (24) it follows that for any $\epsilon>0$ there exists $x_{1, \epsilon} \in \bar{\Omega} \backslash\{0\}$ such that

Since blow-up occurs, that is (26) holds and since $u_{\epsilon} \rightarrow u_{0}$ in $C_{l o c}^{2}(\bar{\Omega} \backslash\{0\})$, we have that

\lim _{\epsilon \rightarrow 0} x_{1, \epsilon}=0 \in \partial \Omega \quad \text { and } \quad \lim _{\epsilon \rightarrow 0} \mu_{1, \epsilon}=0
$$

It follows that $u_{\epsilon}$ satisfies the hypothesis (29) of Lemma 1 with $y_{\epsilon}=x_{1, \epsilon}, \nu_{\epsilon}=\mu_{1, \epsilon}$. Therefore

In fact, we claim that there exists $c_{1}>0$ such that

We argue by contradiction and we assume that $\left|x_{1, \epsilon}\right|=o\left(k_{1, \epsilon}\right)$ as $\epsilon \rightarrow 0$. Let $\tilde{x}_{1, \epsilon}:=\mathcal{T}^{-1}\left(x_{1, \epsilon}\right) \in \mathbb{R}_{-}^{n}$. Since $\left|x_{1, \epsilon}\right|=o\left(k_{1, \epsilon}\right)$ as $\epsilon \rightarrow 0$, so also $\left|\tilde{x}_{1, \epsilon}\right|=o\left(k_{1, \epsilon}\right)$ as $\epsilon \rightarrow 0$.

We define for $\epsilon>0$

Using $\left(E_{\epsilon}\right)$ we obtain that $\tilde{v}_{\epsilon}$ satisfies the equation
$-\Delta \tilde{v}_{\epsilon}-\frac{\gamma}{\left|\frac{\mathcal{T}\left(\left|\tilde{x}_{1, \epsilon}\right| x\right)}{\left|\tilde{x}_{1, \epsilon}\right|}\right|^{2}} \tilde{v}_{\epsilon}+\left|x_{1, \epsilon}\right|^{2} h_{\epsilon} \circ \mathcal{T}\left(\left|\tilde{x}_{1, \epsilon}\right| x\right) \tilde{v}_{\epsilon}=\left(\frac{\left|\tilde{x}_{1, \epsilon}\right|}{k_{1, \epsilon}}\right)^{2-s-p_{\epsilon}} \frac{\left|\tilde{v}_{\epsilon}\right|^{2^{\star}(s)-2-p_{\epsilon}} \tilde{v}_{\epsilon}}{\left|\frac{\mathcal{T}\left(\left|\tilde{x}_{1, \epsilon}\right| x\right)}{\left|\tilde{x}_{1, \epsilon}\right|}\right|^{s}}$

The definition (45) yields as $\epsilon \rightarrow 0,|x|^{\tau}\left|\tilde{v}_{\epsilon}(x)\right| \leq 2$ for all $x \in \mathbb{R}_{-}^{n}$.
Standard elliptic theory then yields the existence of $\tilde{v} \in C^{2}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\{0\}\right)$ such that $\tilde{v}_{\epsilon} \rightarrow \tilde{v}$ in $C_{l o c}^{2}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\{0\}\right)$ where

$$
\left\{\begin{array}{rlll}
-\Delta \tilde{v}-\frac{\gamma}{|x|^{2}} \tilde{v} & =0 & \text { in } \mathbb{R}_{-}^{n} \\
\tilde{v} & =0 & & \text { on } \partial \mathbb{R}_{-}^{n} \backslash\{0\}
\end{array}\right.
$$

In addition, we have that $\left|\tilde{v}_{\epsilon}\left(\left|\tilde{x}_{1, \epsilon}\right|^{-1} \tilde{x}_{1, \epsilon}\right)\right|=1$ and so $\tilde{v} \not \equiv 0$. Also since $|x|^{\tau}|\tilde{v}(x)| \leq$ 2 in $\overline{\mathbb{R}_{-}^{n}} \backslash\{0\}$, we have the bound that

$$

Therefore $x \mapsto \tilde{V}(x):=4 \frac{\left|x_{1}\right|}{|x|^{\beta}+(\gamma)}+4 \frac{\left|x_{1}\right|}{|x|^{\beta}-(\gamma)}-\tilde{v}(x)$ is a positive solution to $-\Delta \tilde{V}-$ $\frac{\gamma}{|x|^{2}} \tilde{V}=0$ in $\mathbb{R}_{-}^{n}$. Proposition 9 yields the existence of $A, B \in \mathbb{R}$ such that

But the pointwise control (48) then implies $A=B=0$ by letting $|x| \rightarrow 0$ and $\rightarrow \infty$. This contradicts $\tilde{v} \not \equiv 0$. This proves Claim (47).

We rescale and define for all $\epsilon>0$

It follows from (45) and (47) that $\tilde{u}_{1, \epsilon}$ satisfies the hypothesis (40) of Lemma 2 with $y_{\epsilon}=x_{1, \epsilon}, \nu_{\epsilon}=\mu_{1, \epsilon}$. Then using Lemma 2 we get that there exists $\tilde{u}_{1} \in$ $H_{1,0}^{2}\left(\mathbb{R}_{-}^{n}\right) \cap C^{1}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\{0\}\right)$ weakly satisfying the equation:

\tilde{u}_{1, \epsilon} \longrightarrow \tilde{u}_{1} & \text { in } C_{l o c}^{1}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\{0\}\right) & \text { as } \epsilon \rightarrow 0 \\
\tilde{u}_{1, \epsilon} \rightharpoonup \tilde{u}_{1} & \text { weakly in } H_{1,0}^{2}\left(\mathbb{R}_{-}^{n}\right) & \text { as } \epsilon \rightarrow 0
\end{array}
$$

It follows from the definition that $\left|\tilde{u}_{i_{o}, \epsilon}\left(\frac{\tilde{x}_{1, \epsilon}}{k_{1, \epsilon}}\right)\right|=1$. From (47) we therefore have that $\tilde{u}_{1} \not \equiv 0$. And hence again from Lemma 2 we get that

Moreover, there exists $t_{1} \in(0,1]$ such that $\lim _{\epsilon \rightarrow 0} \mu_{1, \epsilon}^{p_{\epsilon}}=t_{1}$. Since $\frac{|x|^{\beta-(\gamma)}}{\left|x_{1}\right|} \tilde{u}_{1} \in C^{0}\left(\mathbb{R}^{n}\right)$, we get as $\epsilon \rightarrow 0$

$$

and

\lim _{\delta \rightarrow 0} \lim _{\epsilon \rightarrow 0} \sup _{B_{\delta k_{1, \epsilon}}(0) \cap \Omega}|x|^{\frac{n-2}{2}}\left|u_{\epsilon}(x)-\mu_{1, \epsilon}^{-\frac{n-2}{2}} \tilde{u}_{1}\left(\frac{\mathcal{T}^{-1}(x)}{k_{1, \epsilon}}\right)\right|^{1-\frac{p_{\epsilon}}{2^{\star(s)-2}}}=0 .
$$

Step 4.2: We claim that there exists $C>0$ such that

|x|^{\frac{n-2}{2}}\left|u_{\epsilon}(x)\right|^{1-\frac{p_{\epsilon}}{2 \star(s)-2}} \leq C \quad \text { for all } \epsilon>0 \text { and all } x \in \Omega \tag{49}

We argue by contradiction and let $\left(y_{\epsilon}\right)_{\epsilon>0} \in \Omega$ be such that

\sup _{x \in \Omega}|x|^{\frac{n-2}{2}}\left|u_{\epsilon}(x)\right|^{1-\frac{p_{\epsilon}}{2 \star(s)-2}}=\left|y_{\epsilon}\right|^{\frac{n-2}{2}}\left|u_{\epsilon}\left(y_{\epsilon}\right)\right|^{1-\frac{p_{\epsilon}}{2^{\star(s)-2}}} \rightarrow+\infty \quad \text { as } \epsilon \rightarrow 0 \tag{50}
\end{equation*}
$$

By the regularity Theorem 6, it follows that the sequence $\left(y_{\epsilon}\right)_{\epsilon>0}$ is well-defined and moreover $\lim _{\epsilon \rightarrow 0} y_{\epsilon}=0$, since $u_{\epsilon} \rightarrow u_{0}$ in $C_{l o c}^{2}(\bar{\Omega} \backslash\{0\})$. For $\epsilon>0$ we let

\nu_{\epsilon}:=\left|u_{\epsilon}\left(y_{\epsilon}\right)\right|^{-\frac{2}{n-2}}, \ell_{\epsilon}:=\nu_{\epsilon}^{1-\frac{p_{\epsilon}}{2^{\star}(s)-2}} \text { and } \kappa_{\epsilon}:=\left|y_{\epsilon}\right|^{s / 2} \ell_{\epsilon}^{\frac{2-s}{2}}
$$

Then it follows from (50) that

\lim _{\epsilon \rightarrow 0} \nu_{\epsilon}=0, \lim _{\epsilon \rightarrow 0} \frac{\left|y_{\epsilon}\right|}{\ell_{\epsilon}}=+\infty \text { and } \lim _{\epsilon \rightarrow 0} \frac{\kappa_{\epsilon}}{\left|y_{\epsilon}\right|}=0 \tag{51}
\end{equation*}
$$

Let $R>0$ and let $x \in B_{R}(0)$ be such that $y_{\epsilon}+\kappa_{\epsilon} x \in \Omega$. It follows from the definition (50) of $y_{\epsilon}$ that for all $\epsilon>0$

$$
\left|y_{\epsilon}+\kappa_{\epsilon} x\right|^{\frac{n-2}{2}}\left|u_{\epsilon}\left(y_{\epsilon}+\kappa_{\epsilon} x\right)\right|^{1-\frac{p_{\epsilon}}{2 \star(s)-2}} \leq\left|y_{\epsilon}\right|^{\frac{n-2}{2}}\left|u_{\epsilon}\left(y_{\epsilon}\right)\right|^{1-\frac{p_{\epsilon}}{2 \star(s)-2}}
$$

and then, for all $\epsilon>0$

$$
\left(\frac{\left|u_{\epsilon}\left(y_{\epsilon}+\kappa_{\epsilon} x\right)\right|}{\left|u_{\epsilon}\left(y_{\epsilon}\right)\right|}\right)^{1-\frac{p_{\epsilon}}{2^{*}(s)-2}} \leq\left(\frac{1}{1-\frac{\kappa_{\epsilon}}{\left|y_{\epsilon}\right|} R}\right)^{\frac{n-2}{2}}
$$

for all $x \in B_{R}(0)$ such that $y_{\epsilon}+\kappa_{\epsilon} x \in \Omega$. Using (51), we get that there exists $C(R)>0$ such that the hypothesis (29) of Lemma 1 is satisfied and therefore one has $\left|y_{\epsilon}\right|=O\left(\ell_{\epsilon}\right)$ when $\epsilon \rightarrow 0$, contradiction to (51). This proves (49).

Let $\mathcal{I} \in \mathbb{N}^{\star}$. We consider the following assertions:
(B1) $0<\mu_{1, \epsilon}<\ldots<\mu_{\mathcal{I}, \epsilon}$.
(B2) $\lim _{\epsilon \rightarrow 0} \mu_{\epsilon, \mathcal{I}}=0$ and $\lim _{\epsilon \rightarrow 0} \frac{\mu_{i+1, \epsilon}}{\mu_{i, \epsilon}}=+\infty$ for all $1 \leq i \leq \mathcal{I}-1$
(B3) For all $1 \leq i \leq \mathcal{I}$, there exists $\tilde{u}_{i} \in H_{1,0}^{2}\left(\mathbb{R}_{-}^{n}\right) \cap C^{2}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\{0\}\right)$ such that $\tilde{u}_{i}$ weakly solves the equation

-\Delta \tilde{u}_{i}-\frac{\gamma}{|x|^{2}} \tilde{u}_{i} & =\frac{\left|\tilde{u}_{i}\right|^{2^{\star}(s)-2} \tilde{u}_{i}}{|x|^{s}} & & \text { in } \mathbb{R}_{-}^{n} \\
\tilde{u}_{i} & =0 & & \text { on } \partial \mathbb{R}_{-}^{n} \backslash\{0\},
\end{aligned}\right.
$$

with

$$
\int_{\mathbb{R}_{-}^{n}} \frac{\left|\tilde{u}_{i}\right|^{2^{\star}(s)}}{|x|^{s}} \geq \mu_{\gamma, s}\left(\mathbb{R}_{-}^{n}\right)^{\frac{2^{\star}(s)}{2^{\star}(s)-2}}
$$

and

$$
\begin{array}{rcc}
\tilde{u}_{i, \epsilon} \longrightarrow \tilde{u}_{i} & \text { in } C_{l o c}^{1}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\{0\}\right) & \text { as } \epsilon \rightarrow 0 \\
\tilde{u}_{i, \epsilon} \rightharpoonup \tilde{u}_{i} & \text { weakly in } H_{1,0}^{2}\left(\mathbb{R}_{-}^{n}\right) & \text { as } \epsilon \rightarrow 0,
\end{array}
$$

where for $\epsilon>0$, we have set $k_{i, \epsilon}=\mu_{i, \epsilon}^{1-\frac{p_{\epsilon}}{2^{*}(s)-2}}$ and

\tilde{u}_{i, \epsilon}(x):=\mu_{1, \epsilon}^{\frac{n-2}{2}} u_{\epsilon}\left(\mathcal{T}\left(k_{i, \epsilon} x\right)\right) \quad \text { for } x \in k_{i, \epsilon}^{-1} U \cap \overline{\mathbb{R}_{-}^{n}} \backslash\{0\}
$$

(B4) For all $1 \leq i \leq \mathcal{I}$, there exists $t_{i} \in(0,1]$ such that $\lim _{\epsilon \rightarrow 0} \mu_{i, \epsilon}^{p_{\epsilon}}=t_{i}$.
We shall then say that $\left(\mathcal{H}_{\mathcal{I}}\right)$ holds if there exists $\mathcal{I}$ sequences $\left(\mu_{i, \epsilon}\right)_{\epsilon>0}, i=1, \ldots, \mathcal{I}$ such that items (B1), (B2) (B3) and (B4) holds. Note that it follows from Step 4.1 that $\left(\mathcal{H}_{1}\right)$ holds. Next we show the following:

Step 4.3 Let $I \geq 1$. We assume that $\left(\mathcal{H}_{I}\right)$ holds. Then, either

Proof of Step 4.3: Suppose $\lim _{R \rightarrow+\infty} \lim _{\epsilon \rightarrow 0} \sup _{\Omega \backslash B_{R k_{\mathcal{I}}, \epsilon}(0)}|x|^{\frac{n-2}{2}}\left|u_{\epsilon}(x)-u_{0}(x)\right|^{1-\frac{p_{\epsilon}}{2^{\star}(s)-2}} \neq$ 0 . Then, there exists a sequence of points $\left(y_{\epsilon}\right)_{\epsilon>0} \in \Omega$ such that

Since $u_{\epsilon} \rightarrow u_{0}$ in $C_{l o c}^{2}(\bar{\Omega} \backslash\{0\})$ it follows that $\lim _{\epsilon \rightarrow 0} y_{\epsilon}=0$. Then by the regularity Theorem 6 and since $\beta_{-}(\gamma)<\frac{n-2}{2}$, we get

It follows from (49) that for all $\epsilon>0$

\left|\frac{\mathcal{T}\left(k_{I+1, \epsilon} x\right)}{k_{\mathcal{I}+1, \epsilon}}\right|^{\frac{n-2}{2}}\left|\tilde{u}_{\mathcal{I}+1, \epsilon}(x)\right|^{1-\frac{p_{\epsilon}}{2^{\star}(s)-2}} \leq C \quad \text { for } x \in k_{\mathcal{I}+1, \epsilon}^{-1} \Omega \backslash\{0\}
$$

and so hypothesis (40) of Lemma 2 is satisfied. Using Lemma 2, we then get that there exists $\tilde{u}_{\mathcal{I}+1} \in H_{1,0}^{2}\left(\mathbb{R}_{-}^{n}\right) \cap C^{1}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\{0\}\right)$ that satisfies weakly the equation:

while
$\tilde{u}_{\mathcal{I}+1, \epsilon} \rightharpoonup \tilde{u}_{\mathcal{I}+1} \quad$ weakly in $H_{1,0}^{2}\left(\mathbb{R}_{-}^{n}\right) \quad$ and $\quad \tilde{u}_{\mathcal{I}+1, \epsilon} \rightarrow \tilde{u}_{\mathcal{I}+1} \quad$ in $C_{l o c}^{1}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\{0\}\right)$, as $\epsilon \rightarrow 0$.
We denote $\tilde{y}_{\epsilon}:=\frac{\mathcal{T}^{-1}\left(y_{\epsilon}\right)}{k_{\mathcal{I}+1, \epsilon}} \in \mathbb{R}_{-}^{n}$. From (54) it follows that that $\lim _{\epsilon \rightarrow 0}\left|\tilde{y}_{\epsilon}\right|:=\left|\tilde{y}_{0}\right|>$ $a / 2 \neq 0$. Therefore

\left|\tilde{u}_{\mathcal{I}+1}\left(\tilde{y}_{0}\right)\right|=\lim _{\epsilon \rightarrow 0}\left|\tilde{u}_{\mathcal{I}+1, \epsilon}\left(\tilde{y}_{\epsilon}\right)\right|=1 .

Since $\tilde{u}_{\mathcal{I}+1} \equiv 0$ on $\partial \mathbb{R}_{-}^{n} \backslash\{0\}$ so $\tilde{y}_{\epsilon} \notin \partial \mathbb{R}_{-}^{n}$ and hence $\tilde{u}_{\mathcal{I}+1} \not \equiv 0$. Hence again from Lemma 2, we get

and there exists $t_{\mathcal{I}+1} \in(0,1]$ such that $\lim _{\epsilon \rightarrow 0} \mu_{\mathcal{I}+1, \epsilon}^{p_{\epsilon}}=t_{\mathcal{I}+1}$. Moreover, it follows from (52) and (54) that

\lim _{\epsilon \rightarrow 0} \frac{\mu_{\mathcal{I}+1, \epsilon}}{\mu_{\mathcal{I}, \epsilon}}=+\infty \text { and } \lim _{\epsilon \rightarrow 0} \mu_{\mathcal{I}+1, \epsilon}=0

Hence the families $\left(\mu_{i, \epsilon}\right)_{\epsilon>0}, 1 \leq i \leq \mathcal{I}+1$ satisfy $\mathcal{H}_{\mathcal{I}+1}$.
The next step is equivalent to step 4.3 at intermediate scales.
Step 4.4 Let $I \geq 1$. We assume that $\left(\mathcal{H}_{\mathcal{I}}\right)$ holds. Then, for any $1 \leq i \leq \mathcal{I}-1$ and for any $\delta>0$, either
$\lim _{R \rightarrow+\infty} \lim _{\epsilon \rightarrow 0} \sup _{\Omega \cap B_{\delta k_{i+1, \epsilon}}(0) \backslash \bar{B}_{R k_{i, \epsilon}(0)}}|x|^{\frac{n-2}{2}}\left|u_{\epsilon}(x)-\mu_{i+1, \epsilon}^{-\frac{n-2}{2}} \tilde{u}_{i+1}\left(\frac{\mathcal{T}^{-1}(x)}{k_{i+1, \epsilon}}\right)\right|^{1-\frac{p_{\epsilon}}{2^{\star}(s)-2}}=0$ or $\left(\mathcal{H}_{\mathcal{I}+1}\right)$ holds.
Proof of Step 4.4: We assume that there exist an $i \leq \mathcal{I}-1$ and $\delta>0$ such that

& \left|y_{\epsilon}\right|^{\frac{n-2}{2}}\left|u_{\epsilon}\left(y_{\epsilon}\right)-\mu_{i+1, \epsilon}^{-\frac{n-2}{2}} \tilde{u}_{i+1}\left(\frac{\mathcal{T}^{-1}\left(y_{\epsilon}\right)}{k_{i+1, \epsilon}}\right)\right|^{1-\frac{p_{\epsilon}}{2^{\star}(s)-2}}=a>0 \tag{56}
\end{align*}
$$

for some positive constant $a$. Note that $a<+\infty$ since

|x|^{\frac{n-2}{2}}\left|u_{\epsilon}(x)-\mu_{i+1, \epsilon}^{-\frac{n-2}{2}} \tilde{u}_{i+1}\left(\frac{\mathcal{T}^{-1}(x)}{k_{i+1, \epsilon}}\right)\right|^{1-\frac{p_{\epsilon}}{2 \star(s)-2}}
$$

is uniformly bounded for all $x \in \Omega \cap B_{\delta k_{i+1, \epsilon}}(0) \backslash \bar{B}_{R k_{i, \epsilon}}(0)$.
Let $\tilde{y}_{\epsilon}^{*} \in \mathbb{R}_{-}^{n}$ be such that $\mathcal{T}^{-1}\left(y_{\epsilon}\right)=k_{i+1, \epsilon} \tilde{y}_{\epsilon}^{*}$. It follows that $\left|\tilde{y}_{\epsilon}^{*}\right| \leq \delta$ for all $\epsilon>0$.
We rewrite (56) as

\lim _{\epsilon \rightarrow 0}\left|\tilde{y}_{\epsilon}^{*}\right|^{\frac{n-2}{2}}\left|\tilde{u}_{i+1, \epsilon}\left(\tilde{y}_{\epsilon}^{*}\right)-\tilde{u}_{i+1}\left(\tilde{y}_{\epsilon}^{*}\right)\right|^{1-\frac{p_{\epsilon}}{2^{*}(s)-2}}=a>0 .

Then from point (B3) of $\mathcal{H}_{\mathcal{I}}$ it follows that $\tilde{y}_{\epsilon}^{*} \rightarrow 0$ as $\epsilon \rightarrow 0$. Since $\frac{|x|^{\beta}-(\gamma)}{\left|x_{1}\right|} \tilde{u}_{i+1} \in$ $C^{0}\left(\mathbb{R}^{n}\right)$, we get as $\epsilon \rightarrow 0$

$$

Then (56) becomes

\lim _{\epsilon \rightarrow 0}\left|y_{\epsilon}\right|^{\frac{n-2}{2}}\left|u_{\epsilon}\left(y_{\epsilon}\right)\right|^{1-\frac{p_{\epsilon}}{2^{\star}(s)-2}}=a>0 \tag{57}
\end{equation*}
$$

In particular, $\lim _{\epsilon \rightarrow 0}\left|u_{\epsilon}\left(y_{\epsilon}\right)\right|=+\infty$. We let

\nu_{\epsilon}:=\left|u_{\epsilon}\left(y_{\epsilon}\right)\right|^{-\frac{2}{n-2}} \text { and } \ell_{\epsilon}:=\nu_{\epsilon}^{1-\frac{p_{\epsilon}}{2 \star(s)-2}} .
$$

Then we have

\lim _{\epsilon \rightarrow 0} \nu_{\epsilon}=0 \quad \text { and } \quad \lim _{\epsilon \rightarrow 0} \frac{\left|y_{\epsilon}\right|}{\ell_{\epsilon}}=a>0 \tag{58}
\end{equation*}
$$

We rescale and define

\tilde{u}_{\epsilon}(x):=\nu_{\epsilon}^{\frac{n-2}{2}} u_{\epsilon}\left(\mathcal{T}\left(\ell_{\epsilon} x\right)\right) \quad \text { for } x \in \ell_{\epsilon}^{-1} U \cap \overline{\mathbb{R}_{-}^{n}} \backslash\{0\}
$$

It follows from (49) that for all $\epsilon>0$

$$
|x|^{\frac{n-2}{2}}\left|\tilde{u}_{\epsilon}(x)\right|^{1-\frac{p_{\epsilon}}{2^{\star(s)-2}}} \leq C \quad \text { for } x \in \ell_{\epsilon}^{-1} U \cap \overline{\mathbb{R}_{-}^{n}} \backslash\{0\}
$$

so that hypothesis (40) of Lemma 2 is satisfied. We can then use it to get that there exists $\tilde{u} \in D^{1.2}\left(\mathbb{R}_{-}^{n}\right) \cap C^{1}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\{0\}\right)$ that satisfies weakly the equation:

while

\begin{array}{lcc}
\tilde{u}_{\epsilon} \rightharpoonup \tilde{u} & \text { weakly in } H_{1,0}^{2}\left(\mathbb{R}_{-}^{n}\right) & \text { as } \epsilon \rightarrow 0 \\
\tilde{u}_{\epsilon} \rightarrow \tilde{u} & \text { in } C_{l o c}^{1}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\{0\}\right) & \text { as } \epsilon \rightarrow 0
\end{array}
$$

We denote $\tilde{y}_{\epsilon}:=\frac{\mathcal{T}^{-1}\left(y_{\epsilon}\right)}{\ell_{\epsilon}} \in \mathbb{R}_{-}^{n}$. From (57) it follows that that $\lim _{\epsilon \rightarrow 0}\left|\tilde{y}_{\epsilon}\right|:=\left|\tilde{y}_{0}\right|>$ $a / 2 \neq 0$. Therefore

$$
\left|\tilde{u}\left(\tilde{y}_{0}\right)\right|=\lim _{\epsilon \rightarrow 0}\left|\tilde{u}_{\epsilon}\left(\tilde{y}_{\epsilon}\right)\right|=1 .
$$

Since $\tilde{u} \equiv 0$ on $\partial \mathbb{R}_{-}^{n} \backslash\{0\}$ so $\tilde{y}_{\epsilon} \notin \partial \mathbb{R}_{-}^{n}$ and hence $\tilde{u} \not \equiv 0$. Hence again from Lemma 2 we get

\int_{\mathbb{R}_{-}^{n}} \frac{|\tilde{u}|^{2^{\star}(s)}}{|x|^{s}} \geq \mu_{\gamma, s}\left(\mathbb{R}_{-}^{n}\right)^{\frac{2^{\star}(s)}{2^{\star}(s)-2}}
$$

and there exists $t \in(0,1]$ such that $\lim _{\epsilon \rightarrow 0} \nu_{\epsilon}^{p_{\epsilon}}=t$. Moreover, from (57), (55), and since $\lim _{\epsilon \rightarrow 0} \frac{\left|y_{\epsilon}\right|}{k_{i+1, \epsilon}}=0$, it follows that

Hence the families $\left(\mu_{1, \epsilon}\right), \ldots,\left(\mu_{i, \epsilon}\right),\left(\nu_{\epsilon}\right),\left(\mu_{i+1, \epsilon}\right), \ldots,\left(\mu_{\mathcal{I}, \epsilon}\right)$ satisfy $\left(\mathcal{H}_{\mathcal{I}+1}\right)$.

The last step tells us that the process of constructing $\left\{\mathcal{H}_{\mathcal{I}}\right\}$ stops after a finite number of steps.

Step 4.5: Let $N_{0}=\max \left\{\mathcal{I}:\left(\mathcal{H}_{\mathcal{I}}\right)\right.$ holds $\}$. Then $N_{0}<+\infty$ and the conclusion of Proposition 2 holds with $N=N_{0}$.

Proof of Step 4.5: Indeed, assume that $\left(\mathcal{H}_{\mathcal{I}}\right)$ holds. Since $\mu_{i, \epsilon}=o\left(\mu_{i+1, \epsilon}\right)$ for all $1 \leq i \leq N-1$, we get with a change of variable and the definition of $\tilde{u}_{i, \epsilon}$ that for any $R>\delta>0$

\int_{\Omega} \frac{\left|u_{\epsilon}\right|^{2^{\star}(s)-p_{\epsilon}}}{|x|^{s}} d x & \geq \sum_{i=1}^{\mathcal{I}} \int_{\mathcal{T}\left(B_{R k_{i, \epsilon}}(0) \backslash \bar{B}_{\delta k_{i, \epsilon}}(0) \cap \mathbb{R}_{-}^{n}\right)} \frac{\left|u_{\epsilon}\right|^{2^{\star}(s)-p_{\epsilon}}}{|x|^{s}} d x \\
& \geq \sum_{i=1}^{\mathcal{I}} \int_{B_{R k_{i, \epsilon}}(0) \backslash \bar{B}_{\delta k_{i, \epsilon}}(0) \cap \mathbb{R}_{-}^{n}} \frac{\left|\tilde{u}_{i, \epsilon}\right|^{\left.\right|^{\star}(s)-p_{\epsilon}}}{|x|^{s}} d v_{g_{i, \epsilon}} .
\end{aligned}
$$

Here $g_{i, \epsilon}$ is the metric such that $\left(g_{\epsilon, i}\right)_{q r}=\left(\partial_{q} \mathcal{T}\left(k_{i, \epsilon} x\right), \partial_{r} \mathcal{T}\left(k_{i, \epsilon} x\right)\right)$ for all $q, r \in$ $\{1, \ldots, n\}$. Then from (22) we have

\end{equation*}

Passing to the limit $\epsilon \rightarrow 0$ and then $\delta \rightarrow 0, R \rightarrow+\infty$ we obtain using point (B3) of $\mathcal{H}_{\mathcal{I}}$, that

To complete the proof, we let families $\left(\mu_{1, \epsilon}\right)_{\epsilon>0}, \ldots,\left(\mu_{N_{0}, \epsilon}\right)_{\epsilon>0}$ be such that $\mathcal{H}_{N_{0}}$ holds. We argue by contradiction and assume that the conclusion of Proposition 2 does not hold with $N=N_{0}$. Assertions (A1), (A2), (A3),(A4), (A5), (A7) and (A9) hold. Assume that (A6) or (A8) does not hold. It then follows from Steps 4.3, 4.4 and 4.5 that $\mathcal{H}_{N+1}$ holds. A contradiction with the choice of $N=N_{0}$. Hence the proposition is proved.

## 5. Strong pointwise estimates

The objective of this section is to obtain pointwise controls on $u_{\epsilon}$ and $\nabla u_{\epsilon}$. The core is the proof of the following proposition in the spirit of Druet-Hebey-Robert [11]:

Proposition 3. Let $\Omega$ be a smooth bounded domain of $\mathbb{R}^{n}, n \geq 3$, such that $0 \in \partial \Omega$ and assume that $0<s<2, \gamma<\frac{n^{2}}{4}$. Let $\left(u_{\epsilon}\right),\left(h_{\epsilon}\right)$ and $\left(p_{\epsilon}\right)$ be such that $\left(E_{\epsilon}\right)$, (15), (21) and (22) holds. Assume that blow-up occurs, that is

\lim _{\epsilon \rightarrow 0}\left\||x|^{\tau} u_{\epsilon}\right\|_{L^{\infty}(\Omega)}=+\infty \quad \text { where } \beta_{-}(\gamma)-1<\tau<\frac{n-2}{2}
$$

Consider $\mu_{1, \epsilon}, \ldots, \mu_{N, \epsilon}$ from Proposition 2. Then, there exists $C>0$ such that for all $\epsilon>0$

\left|u_{\epsilon}(x)\right| \leq C\left(\sum_{i=1}^{N} \frac{\mu_{i, \epsilon}^{\frac{\beta_{+}(\gamma)-\beta_{-}(\gamma)}{2}}|x|}{\mu_{i, \epsilon}^{\beta_{+}(\gamma)-\beta_{-}(\gamma)}|x|^{\beta_{-}(\gamma)}+|x|^{\beta_{+}(\gamma)}}+\frac{\left\||x|^{\beta_{-}(\gamma)-1} u_{0}\right\|_{L^{\infty}(\Omega)}}{|x|^{\beta_{-}(\gamma)}}|x|\right) \tag{60}
\end{equation*}
$$

for all $x \in \Omega$.
The proof of this estimate, inspired by the methodology of [11], proceeds in seven steps.
Step 5.1: We claim that for any $\alpha>0$ small and any $R>0$, there exists $C(\alpha, R)>$ 0 such that for all $\epsilon>0$ sufficiently small, we have for all $x \in \Omega \backslash \bar{B}_{R k_{N, \epsilon}}(0)$,

Proof of Step 5.1: We fix $\gamma^{\prime}$ such that $\gamma<\gamma^{\prime}<\frac{n^{2}}{4}$. Since the operator $-\Delta-\frac{\gamma}{|x|^{2}}-$ $h_{0}(x)$ is coercive, taking $\gamma^{\prime}$ close to $\gamma$ it follows that the operator $-\Delta-\frac{\gamma^{\prime}}{|x|^{2}}-h_{0}$ is also coercive in $\Omega$. From Theorem 7 , there exists $H \in C^{2}(\bar{\Omega} \backslash\{0\})$ such that

And we have the following bound on $H$, that there exists $C_{1}>0$ such that

\frac{1}{C_{1}} \frac{d(x, \partial \Omega)}{|x|^{\beta_{+}\left(\gamma^{\prime}\right)}} \leq H(x) \leq C_{1} \frac{d(x, \partial \Omega)}{|x|^{\beta+\left(\gamma^{\prime}\right)}} \quad \text { for all } x \in \Omega \tag{63}
\end{equation*}
$$

We let $\lambda_{1}^{\gamma^{\prime}}>0$ be the first eigenvalue of the coercive operator $-\Delta-\frac{\gamma^{\prime}}{\mid x x^{2}}-h_{0}$ on $\Omega$ and we let $\varphi \in C^{2}(\bar{\Omega} \backslash\{0\}) \cap H_{1,0}^{2}(\Omega)$ be the unique eigenfunction such that

It follows from the regularity result, Theorem 6 that there exists $C_{2}>0$ such that

\end{equation*}

We define the operator

Step 5.1.1: We claim that given any $\gamma<\gamma^{\prime}<\frac{n^{2}}{4}$ there exist $\delta_{0}>0$ and $R_{0}>0$ such that for any $0<\delta<\delta_{0}$ and $R>R_{0}$, we have for $\epsilon>0$ sufficiently small

\mathcal{L}_{\epsilon} H(x)>0 \text { and } \mathcal{L}_{\epsilon} \varphi(x)>0 & \text { for all } x \in B_{\delta}(0) \backslash \bar{B}_{R k_{N, \epsilon}}(0) \cap \Omega \\
\mathcal{L}_{\epsilon} H(x)>0 & \text { for all } x \in \Omega \backslash \bar{B}_{R k_{N, \epsilon}}(0), \text { if } u_{0} \equiv 0 \tag{67}
\end{align*}
$$

We prove the claim. As one checks for all $\epsilon>0$ and $x \in \Omega$

\frac{\mathcal{L}_{\epsilon} \varphi(x)}{\varphi(x)}=\frac{\gamma^{\prime}-\gamma}{|x|^{2}}+\left(h_{0}-h_{\epsilon}\right)-\frac{\left|u_{\epsilon}\right|^{2^{\star}(s)-2-p_{\epsilon}}}{|x|^{s}}+\lambda_{1}^{\gamma^{\prime}} .
$$

One has for $\epsilon>0$ sufficiently small $\left\|h_{0}-h_{\epsilon}\right\|_{\infty} \leq \frac{\gamma^{\prime}-\gamma}{4\left(1+\sup _{\Omega}|x|^{2}\right)}$ and we choose $0<\delta_{0}<1$ such that

This choice is possible thanks to (15) and the regularity Theorem 6 respectively. It follows from point (A6) of Proposition 2 that, there exists $R_{0}>0$ such that for any $R>R_{0}$, we have for all $\epsilon>0$ sufficiently small

With this choice of $\delta_{0}$ and $R_{0}$ we get that for any $0<\delta<\delta_{0}$ and $R>R_{0}$, we have for $\epsilon>0$ small enough

\leq & 2^{-p_{\epsilon}} \frac{\gamma^{\prime}-\gamma}{4} \leq \frac{\gamma^{\prime}-\gamma}{4}
\end{aligned}

for all $x \in B_{\delta}(0) \backslash \bar{B}_{R k_{N, \epsilon}}(0) \cap \Omega$, if $u_{0} \not \equiv 0$, and

|x|^{2-s}\left|u_{\epsilon}(x)\right|^{2^{\star}(s)-2-p_{\epsilon}} \leq \frac{\gamma^{\prime}-\gamma}{4} \quad \text { for all } x \in \Omega \backslash \bar{B}_{R k_{N, \epsilon}}(0), \text { if } u_{0} \equiv 0
$$

Hence we obtain that for $\epsilon>0$ small enough

\frac{\mathcal{L}_{\epsilon} H(x)}{H(x)} & =\frac{\gamma^{\prime}-\gamma}{|x|^{2}}+h_{0}-h_{\epsilon}-\frac{\left|u_{\epsilon}\right|^{2^{\star}(s)-2-p_{\epsilon}}}{|x|^{s}} \\
& \geq \frac{\gamma^{\prime}-\gamma}{|x|^{2}}+h_{0}-h_{\epsilon}-\frac{\gamma^{\prime}-\gamma}{4|x|^{2}} \\
& \geq \frac{\gamma^{\prime}-\gamma}{|x|^{2}}-\frac{\gamma^{\prime}-\gamma}{4|x|^{2}}-\frac{\gamma^{\prime}-\gamma}{4|x|^{2}}=\frac{\gamma^{\prime}-\gamma}{2|x|^{2}} \\
& >0 \quad \text { for all } x \in B_{\delta}(0) \backslash \bar{B}_{R k_{N, \epsilon}}(0) \cap \Omega \text { if } u_{0} \neq 0
\end{aligned}
$$

and $\frac{\mathcal{L}_{\epsilon} H(x)}{H(x)}>0 \quad$ for all $x \in \Omega \backslash \bar{B}_{R k_{N, \epsilon}}(0)$, if $u_{0} \equiv 0$.
Similarly we have

\frac{\mathcal{L}_{\epsilon} \varphi(x)}{\varphi(x)}>0 \quad \text { for all } x \in B_{\delta}(0) \backslash \bar{B}_{R k_{N, \epsilon}}(0) \cap \Omega

Step 5.1.2: It follows from point (A4) of Proposition 2 that there exists $C_{1}^{\prime}(R)>0$ such that for all $\epsilon>0$ small

\left|u_{\epsilon}(x)\right| \leq C_{1}^{\prime}(R) \frac{\mu_{N, \epsilon}^{\frac{\beta_{+}\left(\gamma^{\prime}\right)-\beta_{-}\left(\gamma^{\prime}\right)}{2}} d(x, \partial \Omega)}{|x|^{\beta_{+}\left(\gamma^{\prime}\right)}} \quad \text { for all } x \in \Omega \cap \partial B_{R k_{N, \epsilon}}(0)
$$

By estimate (63) on $H$, we then have for some constant $C_{1}(R)>0$

\left|u_{\epsilon}(x)\right| \leq C_{1}(R) \mu_{N, \epsilon}^{\frac{\beta_{+}\left(\gamma^{\prime}\right)-\beta_{-}\left(\gamma^{\prime}\right)}{2}} H(x) \quad \text { for all } x \in \Omega \cap \partial B_{R k_{N, \epsilon}}(0) \tag{69}
\end{equation*}
$$

It follows from point (A1) of Proposition 2 and the regularity Theorem 6, that there exists $C_{2}^{\prime}(\delta)>0$ such that for all $\epsilon>0$ small

\left|u_{\epsilon}(x)\right| \leq C_{2}^{\prime}(\delta)\left\||x|^{\beta_{-}(\gamma)-1} u_{0}\right\|_{L^{\infty}(\Omega)} \frac{d(x, \partial \Omega)}{|x|^{\beta_{-}\left(\gamma^{\prime}\right)}} \quad \text { for all } x \in \Omega \cap \partial B_{\delta}(0), \text { if } u_{0} \not \equiv 0 \tag{70}
\end{equation*}

And then by the estimate (65) on $\varphi$ we have for some constant $C_{2}(\delta)>0$

Then (70) and (69) imply that for all $\epsilon>0$ small

and from (67) and (73), in case $u_{0} \equiv 0$, we have for $\epsilon>0$ sufficiently small

Since $\Psi_{\epsilon}>0$ and $\mathcal{L}_{\epsilon} \Psi_{\epsilon}>0$, it follows from the comparison principle of Berestycki-Nirenberg-Varadhan [4] that the operator $\mathcal{L}_{\epsilon}$ satisfies the comparison principle on $B_{\delta}(0) \backslash \bar{B}_{R k_{N, \epsilon}}(0) \cap \Omega$. Therefore

for all $x \in B_{\delta}(0) \backslash \bar{B}_{R k_{N, \epsilon}}(0) \cap \Omega$, for $R$ large and $\delta$ small.
Then, when $u_{0} \not \equiv 0$, using the estimates (63) and (65), we have or all $\epsilon>0$ small

\left|u_{\epsilon}(x)\right| & \leq C_{1}(R) \frac{\frac{\mu_{N, \epsilon}{ }^{\frac{\beta_{+}\left(\gamma^{\prime}\right)-\beta_{-}\left(\gamma^{\prime}\right)}{2}}}{|x|^{\beta_{+}\left(\gamma^{\prime}\right)}} d(x, \partial \Omega)}{}+C_{2}(\delta)\left\||x|^{\beta_{-}(\gamma)-1} u_{0}\right\|_{L^{\infty}(\Omega)} \frac{d(x, \partial \Omega)}{|x|^{\beta_{-}\left(\gamma^{\prime}\right)}} \\
& \leq C_{1}(R) \frac{\mu_{N, \epsilon}^{\frac{\beta_{+}\left(\gamma^{\prime}\right)-\beta_{-}\left(\gamma^{\prime}\right)}{2}}|x|}{|x|^{\beta_{+}\left(\gamma^{\prime}\right)}}+C_{2}(\delta) \frac{\left\||x|^{\beta_{-}(\gamma)-1} u_{0}\right\|_{L^{\infty}(\Omega)}}{|x|^{\beta_{-}\left(\gamma^{\prime}\right)}}|x| .
\end{aligned}
$$

for all $x \in B_{\delta}(0) \backslash \bar{B}_{R k_{N, \epsilon}}(0) \cap \Omega$, for $R$ large and $\delta$ small.
Similarly if $u_{0} \equiv 0$, then all $\epsilon>0$ small and $R>0$ large

Step 5.4: Combining the previous three steps, it follows from (61), (74), (80) and Proposition 2 that for any $\alpha>0$ small, there exists $C(\alpha)>0$ such that for all $\epsilon>0$ we have for all $x \in \Omega$,

Next we improve the above estimate and show that one can take $\alpha=0$ in (84).
We let $G_{\epsilon}$ be the Green's function for the coercive operator $-\Delta-\frac{\gamma}{|x|^{2}}-h_{\epsilon}$ on $\Omega$ with Dirichlet boundary condition. Green's representation formula, the pointwise bounds on the Green's function (207) and the regularity Theorem 6, yields for any $z \in \Omega$,

- $D_{1, \epsilon}^{N}:=B_{k_{N, \epsilon}}(0) \cap \Omega, D_{2, \epsilon}^{N}:=\left\{k_{N, \epsilon}<|x|<\frac{1}{2}\left|z_{\epsilon}\right|\right\} \cap \Omega$,
- $D_{3, \epsilon}^{N}:=\left\{\frac{1}{2}\left|z_{\epsilon}\right|<|x|<2\left|z_{\epsilon}\right|\right\} \cap \Omega, D_{4, \epsilon}^{N}:=\left\{2\left|z_{\epsilon}\right|<|x|\right\} \cap \Omega$.

Note that one has $\frac{1}{2}\left|z_{\epsilon}\right|<\left|x-z_{\epsilon}\right|$ in $D_{2, \epsilon}^{N}$ and $\frac{1}{2}|x|<\left|x-z_{\epsilon}\right|$ in $D_{4, \epsilon}^{N}$.
Using point (A5) of Proposition 2 and a change of variable, we get

This completes the proof of Proposition 3.
In our next result we obtain a pointwise control on the gradient.
Proposition 4. Let $\Omega$ be a smooth bounded domain of $\mathbb{R}^{n}, n \geq 3$, such that $0 \in \partial \Omega$ and assume that $0<s<2, \gamma<\frac{n^{2}}{4}$. Let $\left(u_{\epsilon}\right),\left(h_{\epsilon}\right)$ and $\left(p_{\epsilon}\right)$ be such that $\left(E_{\epsilon}\right)$, (15), (21) and (22) holds. Assume that blow-up occurs, that is

Proof of Proposition 4: We let $G_{\epsilon}$ be the Green's function of the coercive operator $-\Delta-\frac{\gamma}{|x|^{2}}-h_{\epsilon}$ on $\Omega$ with Dirichlet boundary condition. Differentiating the Green's representation formula, and then using the pointwise bounds on the gradient Green's function (209) and the regularity result Theorem 6 yields for any $z \in \Omega$

## 6. Sharp Blow-up rates and the proof of Compactness

The proof of compactness rely on the following two key propositions.

Proposition 5. Let $\Omega$ be a smooth bounded domain of $\mathbb{R}^{n}$, $n \geq 3$, such that $0 \in \partial \Omega$ and assume that $0<s<2, \gamma<\frac{n^{2}}{4}$. Proof of Theorems 3, 5 and 4: We argue by contradiction and assume that the family is not pre-compact. Then, up to a subsequence, it blows up. We then apply Propositions 5 and 6 to get the blow-up rate (that is nonegative). However, the hypothesis of Theorems 3, 5 and 4 yield exactly negative blow-up rates. This is a contradiction, and therefore the family is pre-compact. This proves the Theorems.

We now establish Propositions 5 and 6. The proof is divided in 13 steps in Sections 7 to 8. These steps are numbered Steps P1, P2, etc.

\tilde{v}_{\epsilon}(x) & \geq \int_{\omega} r_{\epsilon}^{2 \beta_{-}(\gamma)-n}|x|^{\beta_{-}(\gamma)}\left|x-\frac{\mu_{N, \epsilon}}{r_{\epsilon}} y\right|^{-n} x_{1} y_{1} \mu_{N, \epsilon}^{\frac{n}{2}-\beta_{-}(\gamma)} \frac{\tilde{u}_{i, \epsilon}(y)^{2^{\star}(s)-1}}{|y|^{s}} d y \\
& \geq \frac{x_{1}}{|x|^{\beta_{+}(\gamma)}} \int_{\omega} \frac{\tilde{u}_{i}(y)^{2^{\star}(s)-1}}{|y|^{s}} d y
\end{aligned}
$$

for all $x \in \mathbb{R}_{-}^{n}$. Therefore, as one checks, $A \geq \int_{\omega} \frac{\tilde{u}_{i}(y)^{2^{\star}(s)-1}}{|y|^{s}} d y>0$. This ends Step P9.3.

Step P9.4: We claim that

= & \frac{A^{2}}{2} \mathcal{H}_{1}\left(v_{\beta_{+}(\gamma)}, v_{\beta_{+}(\gamma)}\right)+A B \mathcal{H}_{1}\left(v_{\beta_{+}(\gamma)}, v_{\beta_{-}(\gamma)}\right) \\
& +\frac{B^{2}}{2} \mathcal{H}_{1}\left(v_{\beta_{-}(\gamma)}, v_{\beta_{-}(\gamma)}\right)
\end{aligned}

In full generality, we compute $\mathcal{H}_{\delta}\left(v_{\alpha}, v_{\beta}\right)$ for all $\alpha, \beta \in \mathbb{R}$ and all $\delta>0$. As one checks, for any $i=1, \ldots, n$, we have that $\partial_{i} v_{\alpha}=\left(\delta_{i, 1}-\alpha \frac{x_{1} x_{i}}{|x|^{2}}\right)|x|^{-\alpha}$ for all $x \in \mathbb{R}_{-}^{n}$. Moreover, for $x \in \partial B_{\delta}(0)$, we have that $\partial_{\nu} v_{\alpha}=\frac{x^{i}}{|x|} \partial_{i} v_{\alpha}$. Consequently, straightforward computations yield

Indeed, if $\beta_{+}(\gamma)-\beta_{-}(\gamma)>1$, the claim follows from (127) and $1>\frac{\beta_{+}(\gamma)-\beta_{-}(\gamma)}{2}$. If now $\beta_{+}(\gamma)-\beta_{-}(\gamma)<1$, then (131) and the control (102) yield that

& \leq C \sum_{i=1}^{N} \mu_{i, \epsilon}^{\beta_{+}(\gamma)-\beta_{-}(\gamma)} r_{\epsilon}^{n-1-2\left(\beta_{+}(\gamma)-1\right)}+C r_{\epsilon}^{\beta_{+}(\gamma)-\beta_{-}(\gamma)+1}=o\left(\mu_{N, \epsilon}^{\frac{\beta_{+}(\gamma)-\beta_{-}(\gamma)}{2}}\right)

## 8. Proof of the sharp Blow-up rates

We now prove the sharp blow-up rates claimed in Propositions 5 and 6. We start with the case when $\beta_{+}(\gamma)-\beta_{-}(\gamma) \neq 1$. As a preliminary estimate, we claim that

& \quad \mathcal{T}\left(\partial \mathbb{R}_{-}^{n} \cap B_{r_{\epsilon}}(0) \backslash B_{k_{1, \epsilon}^{3}}(0)\right)
\end{align*}
$$

as $\epsilon \rightarrow 0$, where $\mathcal{F}_{0}$ is as in (142); and, when $u_{0} \equiv 0$, we claim that

\begin{align*}
& \frac{p_{\epsilon}}{2^{\star}(s)}\left(\frac{n-s}{2^{\star}(s)-p_{\epsilon}}\right)\left(\sum_{i=1}^{N} \frac{1}{\frac{n-2}{t_{i}^{\star(s)-2}}} \int_{\mathbb{R}_{-}^{n}} \frac{\left|\tilde{u}_{i}\right|^{2^{\star}(s)}}{|x|^{s}} d x+o(1)\right) \\
& =\int_{\text {when }} \quad(x, \nu) \frac{\left|\nabla u_{\epsilon}\right|^{2}}{2} d \sigma-\left(\mathcal{F}_{\delta_{0}}+o(1)\right) \mu_{N, \epsilon}^{\beta_{+}(\gamma)-\beta_{-}(\gamma)-\beta_{-}(\gamma) \geq 2} \\
& \quad \mathcal{T}\left(\partial \mathbb{R}_{-}^{n} \cap B_{\delta_{0}}(0) \backslash B_{k_{1, \epsilon}^{3}}(0)\right) \\
& +\underbrace{o\left(\mu_{N, \epsilon}\right)}_{\text {when } \beta_{+}(\gamma)-\beta_{-}(\gamma)<2} \tag{161}

where $\mathcal{F}_{\delta_{0}}$ is as in (150).
We prove the claim. Collecting the first estimate of Step P2, (121), (141) and (143) of the terms of the Pohozaev identity (112) gives (160). Similarly, the second estimate of Step P2, (122), (148) and (149) of the terms of the Pohozaev identity (113) gives (161).
8.1. Proof of the sharp blow-up rates when $\beta_{+}(\gamma)-\beta_{-}(\gamma) \neq 1$. We first assume $u_{\epsilon}>0$ and $\beta_{+}(\gamma)-\beta_{-}(\gamma)<1$.

Step P11. We let $\left(u_{\epsilon}\right),\left(h_{\epsilon}\right)$ and $\left(p_{\epsilon}\right)$ be such that $\left(E_{\epsilon}\right)$, (15), (21) and (22) hold. We assume that blow-up occurs. We assume that $u_{\epsilon}>0$ and $\beta_{+}(\gamma)-\beta_{-}(\gamma)<1$. Then (109) holds, that is

\end{equation*}
$$

for some $A>0$, where $m_{\gamma, h}(\Omega)$ is the boundary mass.
Proof of Step P11: It follows from Step P10 that $u_{0} \equiv 0$.
Step P11:1: We now claim that

where

M_{\delta_{0}}:= & -\int_{\mathcal{T}\left(\mathbb{R}_{-}^{n} \cap B_{\delta_{0}}(0)\right)}\left(h_{0}(x)+\frac{\left(\nabla h_{0}, x\right)}{2}\right) \bar{u}^{2} d x-\mathcal{F}_{\delta_{0}} \\
& +\int_{\mathcal{T}\left(\partial \mathbb{R}_{-}^{n} \cap B_{\delta_{0}}(0)\right)}(x, \nu) \frac{|\nabla \bar{u}|^{2}}{2} d \sigma \tag{163}
\end{align*}

and $\mathcal{F}_{\delta_{0}}$ is as in (150) and $\bar{u}$ is as in (146).
Indeed, the Pohozaev identity (112), the convergence (145), (147), (146) and $\beta_{+}(\gamma)-$ $\beta_{-}(\gamma)<1$ yield

\end{gather*}

With $u_{0} \equiv 0$ and the control (102), we get that $\left|\nabla u_{\epsilon}(x)\right| \leq C \mu_{N, \epsilon}^{\frac{\beta_{+}(\gamma)-\beta_{-}(\gamma)}{2}}|x|^{-\beta_{+}(\gamma)}$ for all $\epsilon>0$ and $x \in \Omega$. Therefore, with (145) and (146), we get that

as $\epsilon \rightarrow 0$. Plugging (143), (164) and (165) into (113), we get (163). This proves the claim and ends Step P11.1.
We fix $\delta<\delta^{\prime}$. Taking $U:=\mathcal{T}\left(\mathbb{R}_{-}^{n} \cap B_{\delta^{\prime}}(0) \backslash B_{\delta}(0)\right), K=0$ and $u=\bar{u}$ in (196), and using (146), we get that $M_{\delta}$ is independent of the choice of $\delta>0$ small enough.
Step P11.2: We claim that $\bar{u}>0$.
We prove the claim. Since $\bar{u} \geq 0$ is a solution to (146), it is enough to prove that $\bar{u} \not \equiv 0$. We argue as in the proof of Step P9. We fix $x \in \Omega$. Green's identity and $u_{\epsilon}>0$ yield

\end{aligned}

where $A_{\epsilon}:=\mathcal{T}\left(\mathbb{R}_{-}^{n} \cap B_{2 \mu_{N, \epsilon}}(0) \backslash B_{\mu_{N, \epsilon}}(0)\right), A:=\mathbb{R}_{-}^{n} \cap B_{2}(0) \backslash B_{1}(0)$. With the pointwise control (207), we get

where $u_{\epsilon, i}$ is as in Proposition 2. Letting $\epsilon \rightarrow 0$ and using the convergence (A4) of Proposition 2, we get that

It then follows from $[21,22]$ that, for $r_{0}>0$ small enough, there exists $A>0$ and $\beta \in H_{0}^{1}(\Omega)$ such that

& =\int_{\partial \mathbb{R}_{-}^{n} \cap B_{\alpha_{\epsilon}}(0) \backslash B_{\beta_{\epsilon}}(0)} \mu_{N, \epsilon} \frac{x^{i} x^{j} \partial_{i j} \mathcal{T}_{0}(0)}{|x|^{2 \beta_{+}(\gamma)}} K^{2} d x \\
& +\int_{\partial \mathbb{R}_{-}^{n} \cap B_{\alpha_{\epsilon}}(0) \backslash B_{\beta_{\epsilon}}(0)} \mu_{N, \epsilon} \frac{x^{i} x^{j} \partial_{i j} \mathcal{T}_{0}(0)}{|x|^{2 \beta_{+}(\gamma)}}\left(\frac{|x|^{2 \beta_{+}(\gamma)\left|\nabla\left(u_{\epsilon} \circ \mathcal{T}\right)\right|^{2}}}{\mu_{N, \epsilon}}-K^{2}\right) d x \\
& =\int_{\partial \mathbb{R}_{-}^{n} \cap B_{\alpha_{\epsilon}}(0) \backslash B_{\beta_{\epsilon}(0)}(0)} \mu_{N, \epsilon} \frac{x^{i} x^{j} \partial_{i j} \mathcal{T}_{0}(0)}{|x|^{2 \beta+(\gamma)}} K^{2} d x \\
& +o\left(\int_{\partial \mathbb{R}_{-}^{n} \cap B_{\alpha_{\epsilon}}(0) \backslash B_{\beta_{\epsilon}}(0)} \mu_{N, \epsilon} \frac{|x|^{2}}{|x|^{2 \beta_{+}(\gamma)}} d x\right) \tag{185}
\end{align*}
$$

Independently, with a change of variable and $2 \beta_{+}(\gamma)=n+1$, we get that

\begin{aligned}
\int_{\partial \mathbb{R}_{-}^{n} \cap B_{\alpha_{\epsilon}}(0) \backslash B_{\beta_{\epsilon}}(0)} \frac{x^{i} x^{j} \partial_{i j} \mathcal{T}_{0}(0)}{|x|^{2 \beta_{+}(\gamma)}} d x & =\partial_{i j} \mathcal{T}_{0}(0)\left(\int_{\beta_{\epsilon}}^{\alpha_{\epsilon}} \frac{d r}{r}\right)\left(\int_{\mathbb{S}^{n}-2} \sigma^{i} \sigma^{j} d \sigma\right) \\
& =\delta_{i j} \partial_{i j} \mathcal{T}_{0}(0) \frac{\omega_{n-2}}{n-1} \ln \frac{\alpha_{\epsilon}}{\beta_{\epsilon}}
\end{aligned}
$$

where $\omega_{n-2}$ is the volume of the round $(n-2)$-unit sphere. This equality, (185) and the properties (182) yield

\int_{\partial \mathbb{R}_{-}^{n} \cap B_{\alpha_{\epsilon}}(0) \backslash B_{\beta_{\epsilon}}(0)} x^{i} x^{j} \delta_{i j} \partial_{i j} \mathcal{T}_{0}(0)\left|\nabla\left(u_{\epsilon} \circ \mathcal{T}\right)\right|^{2} d x \\
=\delta_{i j} \partial_{i j} \mathcal{T}_{0}(0) \frac{K^{2} \omega_{n-2}}{n-1} \mu_{N, \epsilon} \ln \frac{1}{\mu_{N, \epsilon}}+o\left(\mu_{N, \epsilon} \ln \frac{1}{\mu_{N, \epsilon}}\right) . \tag{186}
\end{gather*}
$$

Therefore, plugging (180), (183) and (186) into (179) yields

\begin{aligned}
& \int(x, \nu) \frac{\left|\nabla u_{\epsilon}\right|^{2}}{2} d \sigma \\
& \mathcal{T}\left(\partial \mathbb{R}_{-}^{n} \cap B_{\delta_{0}}(0) \backslash B_{k_{1, \epsilon}^{3}}(0)\right) \\
& =-\frac{K^{2} \omega_{n-2} \sum_{i=2}^{n} \partial_{i i} \mathcal{T}_{0}(0)}{4(n-1)} \mu_{N, \epsilon} \ln \frac{1}{\mu_{N, \epsilon}}+o\left(\mu_{N, \epsilon} \ln \frac{1}{\mu_{N, \epsilon}}\right) \\
& =\frac{K^{2} \omega_{n-2} \sum_{i=2}^{n} I I_{0, i i}}{4(n-1)} \mu_{N, \epsilon} \ln \frac{1}{\mu_{N, \epsilon}}+o\left(\mu_{N, \epsilon} \ln \frac{1}{\mu_{N, \epsilon}}\right) \\
& =\frac{K^{2} \omega_{n-2} H(0)}{4(n-1)} \mu_{N, \epsilon} \ln \frac{1}{\mu_{N, \epsilon}}+o\left(\mu_{N, \epsilon} \ln \frac{1}{\mu_{N, \epsilon}}\right) .
\end{aligned}

Plugging this latest estimate into (178) yields (177). This ends the proof of Step P13.

## 9. Proof of multiplicity

Proof of Theorem 3: We fix $\gamma<n^{2} / 4$ and $h \in C^{1}(\bar{\Omega})$ such that $-\Delta-\gamma|x|^{-2}-h$ is coercive. For each $2<p \leq 2^{\star}(s)$, we consider the $C^{2}$-functional

on $H_{1,0}^{2}(\Omega)$, whose critical points are the weak solutions of

-\Delta u-\frac{\gamma}{|x|^{2}} u-h u & =\frac{|u|^{p-2} u}{|x|^{s}} & & \text { on } \Omega  \tag{187}\\
u & =0 & & \text { on } \partial \Omega .
\end{align*}\right.
$$

For a fixed $u \in H_{1,0}^{2}(\Omega), u \not \equiv 0$, we have that

I_{p, \gamma}(\lambda u)=\frac{\lambda^{2}}{2} \int_{\Omega}|\nabla u|^{2} d x-\frac{\gamma \lambda^{2}}{2} \int_{\Omega} \frac{|u|^{2}}{|x|^{2}} d x-\lambda^{2} \int_{\Omega} h u^{2} d x-\frac{\lambda^{p}}{p} \int_{\Omega} \frac{|u|^{p}}{|x|^{s}} d x
$$

Then, since coercivity holds, we have that that $\lim _{\lambda \rightarrow \infty} I_{p, \gamma}(\lambda u)=-\infty$, which means that for each finite dimensional subspace $E_{k} \subset E:=H_{1,0}^{2}(\Omega)$, there exists $R_{k}>0$ such that

\sup \left\{I_{p, \gamma}(u) ; u \in E_{k},\|u\|_{H_{1}^{2}}>R_{k}\right\}<0 \tag{188}
\end{equation*}
$$

when $p \rightarrow 2^{\star}(s)(s)$. Let $\left(E_{k}\right)_{k=1}^{\infty}$ be an increasing sequence of subspaces of $H_{1,0}^{2}(\Omega)$ such that $\operatorname{dim} E_{k}=k$ and $\overline{\bigcup_{k=1}^{\infty} E_{k}}=E:=H_{1,0}^{2}(\Omega)$ and define the min-max values:

Proposition 7. With the above notation and assuming $n \geq 3$, we have:
(1) For each $k \in \mathbb{N}, c_{p, k}>0$ and $\lim _{p \rightarrow 2^{\star}(s)} c_{p, k}=c_{2^{\star}(s), k}:=c_{k}$.
(2) If $2<p<2^{\star}(s)$, there exists for each $k$, functions $u_{p, k} \in H_{1,0}^{2}(\Omega)$ such that $I_{p, \gamma}^{\prime}\left(u_{p, k}\right)=0$, and $I_{p, \gamma}\left(u_{p, k}\right)=c_{p, k}$.
(3) For each $2<p<2^{\star}(s)$, we have $c_{p, k} \geq D_{n, p} k^{\frac{p+1}{p-1} \frac{2}{n}}$ where $D_{n, p}>0$ is such that $\lim _{p \rightarrow 2^{\star}(s)} D_{n, p}=0$.

\text { (4) } \lim _{k \rightarrow \infty} c_{k}=\lim _{k \rightarrow \infty} c_{2^{\star}(s), k}=+\infty \text {. }
$$

Proof: (1) Coercivity yields the existence of $a_{0}>0$ such that

\int_{\Omega}\left(|\nabla u|^{2}-\frac{\gamma}{|x|^{2}} u^{2}-h u^{2}\right) d x \geq a_{0} \int_{\Omega}|\nabla u|^{2} d x \text { for all } u \in H_{1,0}^{2}(\Omega) \tag{189}
\end{equation*}
$$

With (189), the Hardy and the Hardy-Sobolev inequality (20), there exists $C>0$ and $\alpha>0$ such that

I_{p, \gamma}(u) \geq \frac{a_{0}}{2}\|\nabla u\|_{2}^{2}-C\|\nabla u\|_{2}^{p}=\|\nabla u\|_{2}^{2}\left(\frac{a_{0}}{2}-C\|\nabla u\|_{2}^{p-2}\right) \geq \alpha>0
$$

for all $u \in H_{1,0}^{2}(\Omega)$ such that provided $\|\nabla u\|_{2}=\rho$ for some $\rho>0$ small enough. Then the sphere $S_{\rho}=\left\{u \in E ;\|u\|_{H_{1,0}^{2}(\Omega)}=\rho\right\}$ intersects every image $g\left(E_{k}\right)$ by an odd continuous function $g$. It follows that

c_{p, k} \geq \inf \left\{I_{p, \gamma}(u) ; u \in S_{\rho}\right\} \geq \alpha>0
$$

In view of (188), it follows that for each $g \in \mathbf{H}_{k}$, we have that

$$
\sup _{x \in E_{k}} I_{p_{i}, \gamma}(g(x))=\sup _{x \in D_{k}} I_{p, \gamma}(g(x))
$$

where $D_{k}$ denotes the ball in $E_{k}$ of radius $R_{k}$. Consider now a sequence $p_{i} \rightarrow 2^{\star}(s)$ and note first that for each $u \in E$, we have that $I_{p_{i}, \gamma}(u) \rightarrow I_{2^{\star}(s), \gamma}(u)$. Since $g\left(D_{k}\right)$ is compact and the family of functionals $\left(I_{p, \gamma}\right)_{p}$ is equicontinuous, it follows that $\sup _{x \in E_{k}} I_{p, \gamma}(g(x)) \rightarrow \sup _{x \in E_{k}} I_{2^{\star}(s), \gamma}(g(x))$, from which follows that $\limsup _{i \in \mathbb{N}} c_{p_{i}, k} \leq$ $\sup _{x \in E_{k}} I_{2^{\star}(s), \gamma}(g(x))$. Since this holds for any $g \in \mathbf{H}_{k}$, it follows that

\limsup _{i \in \mathbb{N}} c_{p_{i}, k} \leq c_{2^{\star}(s), k}=c_{k}
$$

On the other hand, the function $f(r)=\frac{1}{p} r^{p}-\frac{1}{2^{\star}(s)} r^{2^{\star}(s)}$ attains its maximum on $[0,+\infty)$ at $r=1$ and therefore $f(r) \leq \frac{1}{p}-\frac{1}{2^{\star}(s)}$ for all $r>0$. It follows

I_{2^{\star}(s), \gamma}(u) & =I_{p, \gamma}(u)+\int_{\Omega} \frac{1}{|x|^{s}}\left(\frac{1}{p}|u(x)|^{p}-\frac{1}{2^{\star}(s)}|u(x)|^{2^{\star}(s)}\right) d x \\
& \leq I_{p, \gamma}(u)+\int_{\Omega} \frac{1}{|x|^{s}}\left(\frac{1}{p}-\frac{1}{2^{\star}(s)}\right) d x
\end{aligned}
$$

from which follows that $c_{k} \leq \liminf _{i \in \mathbb{N}} c_{p_{i}, k}$, and claim (1) is proved.
If now $p<2^{\star}(s)$, we are in the subcritical case, that is we have compactness in the Sobolev embedding $H_{1,0}^{2}(\Omega) \rightarrow L^{p}\left(\Omega ;|x|^{-s} d x\right)$ and therefore $I_{p, \gamma}$ has the PalaisSmale condition. It is then standard to find critical points $u_{p, k}$ for $I_{p, \gamma}$ at each level $c_{p, k}$ (see for example the book [15]). Consider now the functional

I_{p, 0}(u)=\frac{1}{2} \int_{\Omega}|\nabla u|^{2} d x-\frac{1}{p} \int_{\Omega} \frac{|u|^{p}}{|x|^{s}} d x
$$

and its critical values

c_{p, k}^{0}=\inf _{g \in \mathbf{H}_{k}} \sup _{x \in E_{k}} I_{p, 0}(g(x))
$$

It has been shown in [20] that (1), (2) and (3) of Proposition 7 hold, with $c_{p, k}^{0}$ and $c_{k}^{0}$ replacing $c_{p, k}$ and $c_{k}$ respectively. In particular, $\lim _{k \rightarrow \infty} c_{k}^{0}=\lim _{k \rightarrow \infty} c_{2^{\star}(s), k}^{0}=+\infty$.

On the other hand, with the coercivity (189), we have that

I_{p, \gamma}(u) \geq a_{0}^{\frac{p}{p-2}} I_{p, 0}(v) \quad \text { for every } u \in H_{1,0}^{2}(\Omega)
$$

where $v=a_{0}^{-\frac{1}{p-2}} u$. It then follows that $\lim _{k \rightarrow \infty} c_{k}=\lim _{k \rightarrow \infty} c_{2^{\star}(s), k}=+\infty$.
To complete the proof of Theorem 3 , notice that since for each $k$, we have

\lim _{p_{i} \rightarrow 2^{\star}(s)} I_{p_{i}, \gamma}\left(u_{p_{i}, k}\right)=\lim _{p_{i} \rightarrow 2^{\star}(s)} c_{p_{i}, k}=c_{k}
$$

it follows that the sequence $\left(u_{p_{i}, k}\right)_{i}$ is uniformly bounded in $H_{1,0}^{2}(\Omega)$. Moreover, since $I_{p_{i}}^{\prime}\left(u_{p_{i}, k}\right)=0$, it follows from the compactness result that by letting $p_{i} \rightarrow 2^{\star}(s)$, we get a solution $u_{k}$ of (187) in such a way that $I_{2^{\star}(s)(s), \gamma}\left(u_{k}\right)=$ $\lim _{p \rightarrow 2^{\star}(s)} I_{p, \gamma}\left(u_{p, k}\right)=\lim _{p \rightarrow 2^{\star}(s)} c_{p, k}=c_{k}$. Since the latter sequence goes to infinity, it follows that (187) has an infinite number of critical levels.

## 10. Proof of the non-Existence Result

Proof of Theorem 2: We argue by contradiction. We fix $\gamma<\gamma_{H}(\Omega) \leq \frac{n^{2}}{4}$ and $\Lambda>0$. We assume that there is a family $\left(u_{\epsilon}\right)_{\epsilon>0} \in H_{1,0}^{2}(\Omega)$ of solutions to

$$
\left\{\begin{array}{cl}
-\Delta u_{\epsilon}-\gamma \frac{u_{\epsilon}}{\mid x x^{2}}-h_{\epsilon} u_{\epsilon}=\frac{u_{\epsilon}^{2^{\star}(s)-1}}{|x|^{s}} & \text { in } \Omega  \tag{190}\\
u_{\epsilon}>0 & \text { in } \Omega \\
u_{\epsilon}=0 & \text { on } \partial \Omega \backslash\{0\}
\end{array}\right.
$$

with $\left\|\nabla u_{\epsilon}\right\|_{2} \leq \Lambda$ and $\lim _{\epsilon \rightarrow 0} h_{\epsilon}=h_{0}$ in $C^{1}(\bar{\Omega})$.
We claim that $\left(u_{\epsilon}\right)_{\epsilon>0}$ is not pre-compact in $H_{1,0}^{2}(\Omega)$. Otherwise, up to extraction, there would be $u_{0} \in H_{1,0}^{2}(\Omega), u_{0} \geq 0$, such that $u_{\epsilon} \rightarrow u_{0}$ in $H_{1,0}^{2}(\Omega)$ as $\epsilon \rightarrow 0$. Passing to the limit in the equation, we get that $u_{0} \geq 0$ and

$$
\left\{\begin{array}{cl}
-\Delta u_{0}-\gamma \frac{u_{0}}{|x|^{2}}-h_{0} u_{0}=\frac{u_{0}^{2^{\star}(s)-1}}{|x|^{s}} & \text { in } \Omega  \tag{191}\\
u_{0} \geq 0 & \text { in } \Omega \\
u_{0}=0 & \text { on } \partial \Omega \backslash\{0\}
\end{array}\right.
$$

The coercivity of $-\Delta u_{0}-\gamma|x|^{-2}-h_{0}$ and the convergence of $\left(h_{\epsilon}\right)_{\epsilon}$ yield

$$
C\left(\int_{\Omega} \frac{u_{\epsilon}^{2^{\star}(s)}}{|x|^{s}} d x\right)^{2 / 2^{\star}(s)} \leq \int_{\Omega}\left|\nabla u_{\epsilon}\right|^{2} d x-\int_{\Omega}\left(\frac{\gamma}{|x|^{2}}+h_{\epsilon}\right) u_{\epsilon}^{2} d x \leq \int_{\Omega} \frac{u_{\epsilon}^{2^{\star}(s)}}{|x|^{s}} d x
$$

for small $\epsilon>0$, and then, since $u_{\epsilon}>0$, there exists $c_{0}>0$ such that

$$
\int_{\Omega} \frac{u_{\epsilon}^{2^{\star}(s)}}{|x|^{s}} d x \geq c_{0}
$$

for all $\epsilon>0$. Passing to the limit yields $u_{0} \not \equiv 0$. Therefore, $u_{0}>0$ is a solution to (190) with $\epsilon=0$. This is not possible simply by the hypothesis.

The family $\left(u_{\epsilon}\right)_{\epsilon}$ is not pre-compact and it therefore blows-up with bounded energy. Let $u_{0} \in H_{1,0}^{2}(\Omega)$ be its weak limit, which is necessarily a solution to (191), and hence must be the trivial solution $u_{0} \equiv 0$. Proposition 6 then yields that either

$$
\begin{equation*}
\beta_{+}(\gamma)-\beta_{-}(\gamma) \geq 1 \text { and therefore } H(0)=0 \tag{192}
\end{equation*}
$$

or

$$
\begin{equation*}
\beta_{+}(\gamma)-\beta_{-}(\gamma)<1 \text { and therefore } m_{\gamma, h_{0}}(\Omega)=0 \tag{193}
\end{equation*}
$$

It now suffices to note that when $\gamma \leq\left(n^{2}-1\right) / 4$ then $\beta_{+}(\gamma)-\beta_{-}(\gamma) \geq 1$ and the above contradicts our assumption that $H(0) \neq 0$. Similarly, if $\gamma>\left(n^{2}-1\right) / 4$, then $\beta_{+}(\gamma)-\beta_{-}(\gamma)<1$ and the above contradicts our assumption that the mass is non-zero. In either case, this means that no such a family of positive solutions $\left(u_{\epsilon}\right)_{\epsilon>0}$ exist.

Proof of Corollary 1: First note that if $h_{0}$ satisfies

$$
\begin{equation*}
h_{0}(x)+\frac{1}{2}\left(\nabla h_{0}(x), x\right) \leq 0 \text { for all } x \in \Omega \tag{194}
\end{equation*}
$$

then by differentiating for any $x \in \Omega$, the function $t \mapsto t^{2} h_{0}(t x)$ (which is well defined for $t \in[0,1]$ since $\Omega$ is starshaped), we get that $h_{0} \leq 0$. Therefore $-\Delta-$ $\gamma|x|^{-2}-h_{0}$ is coercive.
Assume now there is a positive variational solution $u_{0}$ corresponding to $h_{0}$, the Pohozaev identity (196) then gives

$$
\int_{\partial \Omega}(x, \nu) \frac{\left(\partial_{\nu} u_{0}\right)^{2}}{2} d \sigma-\int_{\Omega}\left(h_{0}+\frac{1}{2}\left(\nabla h_{0}, x\right)\right) u_{0}^{2} d x=0
$$

Hopf's strong comparison principle yields $\partial_{\nu} u_{0}<0$. Since $\Omega$ is starshaped with respect to 0 , we get that $(x, \nu) \geq 0$ on $\partial \Omega$. Therefore, with (194), we get that $(x, \nu)=0$ for all $x \in \Omega$, which is a contradiction since $\Omega$ is smooth and bounded. If now $\gamma \leq\left(n^{2}-1\right) / 4$, the result follows from Theorem 2 since we have assumed that $H(0) \neq 0$.
If $\gamma>\left(n^{2}-1\right) / 4$, we use Theorem 7.1 in Ghoussoub-Robert [21] to find $\mathcal{K} \in$ $C^{2}(\bar{\Omega} \backslash\{0\})$ and $A>0$ such that

\begin{cases}-\Delta \mathcal{K}-\frac{\gamma}{|x|^{2}} \mathcal{K}-h_{0} \mathcal{K}=0 & \text { in } \Omega \\ \mathcal{K}>0 & \text { in } \Omega \\ \mathcal{K}=0 & \text { on } \partial \Omega \backslash\{0\}\end{cases}
$$

and such that

$$
\mathcal{K}(x)=A\left(\frac{\eta(x) d(x, \partial \Omega)}{|x|^{\beta_{+}(\gamma)}}+\beta(x)\right) \text { for all } x \in \Omega
$$

where $\eta \in C_{c}^{\infty}\left(\mathbb{R}^{n}\right)$ and $\beta \in H_{1,0}^{2}(\Omega)$ are as in Step P11. We now apply the Pohozaev identity (196) to $\mathcal{K}$ on the domain $U:=\Omega \backslash \mathcal{T}\left(B_{\delta}(0)\right)$ for $\mathcal{T}$ as in (27): using that $\mathcal{K}^{2} \in L^{1}(\Omega)$ and $(\cdot, \nu)\left(\partial_{\nu} \mathcal{K}\right)^{2} \in L^{1}(\partial \Omega)$ when $\beta_{+}(\gamma)-\beta_{-}(\gamma)<1$, we get that

\int_{\partial \Omega}(x, \nu) \frac{\left(\partial_{\nu} \mathcal{K}\right)^{2}}{2} d \sigma-\int_{\Omega}\left(h_{0}+\frac{1}{2}\left(\nabla h_{0}, x\right)\right) \mathcal{K}^{2} d x=M_{\delta}
$$

where $M_{\delta}$ is defined in (163). With (166), we then get
$\int_{\partial \Omega}(x, \nu) \frac{\left(\partial_{\nu} \mathcal{K}\right)^{2}}{2} d \sigma-\int_{\Omega}\left(h_{0}+\frac{1}{2}\left(\nabla h_{0}, x\right)\right) \mathcal{K}^{2} d x=-\frac{\omega_{n-1}}{n}\left(\frac{n^{2}}{4}-\gamma\right) A^{2} \cdot m_{\gamma, h_{0}}(\Omega)$.
Since $\Omega$ is star-shaped and $h_{0}$ satisfies (194), it follows that $m_{\gamma, h_{0}}(\Omega)<0$ and Theorem 2 then applies to complete our corollary.

## 11. Appendix A: The Pohozaev identity

Proposition 8. Let $U \subset \mathbb{R}^{n}$ be a smooth bounded domain and let $u \in C^{2}(\bar{U})$ be a solution of

& =\int_{\partial U} F(x) d \sigma

i) $\lim _{k \rightarrow+\infty} V_{k}(x)=V_{\infty}(x)$ for a.e. $x \in \Omega$,
ii) There exists $C>0$ such that $\left|V_{k}(x)\right| \leq C\left|x-x_{k}\right|^{-2}$ for all $k \in \mathbb{N}$ and $x \in \Omega$.
iii) $\lim _{k \rightarrow+\infty} x_{k}=0 \in \partial \Omega$.
iv) For some $\gamma_{0}<n^{2} / 4$, there exists $\delta>0$ such that $\left|V_{k}(x)\right| \leq \gamma_{0}\left|x-x_{k}\right|^{-2}$ for all $k \in \mathbb{N}$ and $x \in B_{\delta}(0) \cap \Omega$.
$v)$ The first eigenvalue $\lambda_{1}\left(-\Delta+V_{k}\right)$ is achieved for all $k \in \mathbb{N}$.
Then,

\geq & \left(1-4 \gamma_{0} / n^{2}\right) \int_{\Omega}|\nabla \varphi|^{2} d x-4 C \delta^{-2} \int_{\Omega} \varphi^{2} d x \tag{198}

## 13. Appendix C: Regularity and the Hardy-Schrödinger operator on $\mathbb{R}_{-}^{n}$

In this section, we collect some important results from the paper [21] used in the proof of the compactness theorems. First we state the following regularity result:

Theorem 6 ([21], see also [14] ). Let $\Omega$ be a smooth bounded domain of $\mathbb{R}^{n}(n \geq 3)$ such that $0 \in \partial \Omega$. We fix $\gamma<\frac{n^{2}}{4}$ and $f: \Omega \times \mathbb{R} \rightarrow \mathbb{R}$ is a Caratheodory function such that

The following result characterizes the positive solution to the singular global equation
Proposition 9 ([21]). Let $\gamma<\frac{n^{2}}{4}$ and let $u \in C^{2}\left(\mathbb{R}^{n} \backslash\{0\}\right)$ be a nonnegative function such that

Next, we recall the existence and behaviour of the singular solution to the homogeneous equation.
Theorem 7 ([21]). Let $\Omega$ be a smooth bounded domain of $\mathbb{R}^{n}(n \geq 3)$ such that $0 \in \partial \Omega$. Fix $\gamma<\frac{n^{2}}{4}$ and $h \in C^{1}(\bar{\Omega})$ be such that the operator $\Delta-\gamma|x|^{-2}-h$ is coercive. There exists then $\mathcal{H} \in C^{2}(\bar{\Omega} \backslash\{0\})$ such that

-\Delta \mathcal{H}-\frac{\gamma}{|x|^{2}} \mathcal{H}+h(x) \mathcal{H} & =0 & & \text { in } \Omega \\

\mathcal{H} & =0 & & \text { on } \partial \Omega \backslash\{0\} .
\end{aligned}\right.

These solutions are unique up to a positive multiplicative constant, and there exists $c>0$ such that $\mathcal{H}(x) \simeq_{x \rightarrow 0} c \frac{d(x, \partial \Omega)}{|x|^{\beta}+(\gamma)}$.

We fix $\gamma<n^{2} / 4$ and $h \in C^{0, \theta}(\bar{\Omega}), \theta \in(0,1)$ such that $-\Delta-\left(\gamma|x|^{-2}+h\right)$ is coercive. We say that $G: \Omega \times \Omega \backslash\{(x, x) / x \in \Omega\}$ is a Green's function for $-\Delta-\gamma|x|^{-2}-h$ if

- For any $p \in \Omega, G_{p}:=G(p, \cdot) \in L^{1}(\Omega)$.
- For all $f \in C_{c}^{\infty}(\Omega)$ and all $p \in \Omega$, then

\varphi(p)=\int_{\Omega} G_{p}(x) f(x) d x
$$

where $\varphi \in H_{1,0}^{2}(\Omega) \cap C^{0}(\Omega)$ is the unique solution to

-\Delta \varphi-\left(\frac{\gamma}{|x|^{2}}+h(x)\right) \varphi=f \text { in } \Omega ; \varphi_{\mid \partial \Omega}=0 .
$$

This appendix is devoted to the proof of the following result.
Theorem 8. Let $\Omega$ be a smooth bounded domain of $\mathbb{R}^{n}$ such that $0 \in \partial \Omega$. We fix $\gamma<\frac{n^{2}}{4}$. We let $h \in C^{0, \theta}(\bar{\Omega})$ be such that $-\Delta-\gamma|x|^{-2}-h$ is coercive. Then there exists a unique Green's function $G$ for $-\Delta-\gamma|x|^{-2}-h$. Moreover:
I. Properties of $G$. The Green's function $G$ is such that
(a) $G_{p} \in C^{2, \theta}(\bar{\Omega} \backslash\{0, p\})$ and $G_{p}>0$ for all $p \in \Omega$.
(b) For all $p \in \Omega$ and all $\eta \in C_{c}^{\infty}\left(\mathbb{R}^{n} \backslash\{p\}\right)$, we have that $\eta G_{p} \in H_{1,0}^{2}(\Omega)$.
(c) For all $f \in L^{\frac{2 n}{n+2}}(\Omega) \cap L^{q}\left(\Omega \backslash B_{\delta}(0)\right)$, for all $\delta>0$ and some $q>n / 2$, we have for any $p \in \Omega$

\varphi(p)=\int_{\Omega} G_{p}(x) f(x) d x \tag{203}
\end{equation*}
$$

where $\varphi \in H_{1,0}^{2}(\Omega) \cap C^{0}(\Omega)$ is the unique solution to

$\left|\nabla G_{p}(x)\right| \leq c\left(\frac{\max \{|p|,|x|\}}{\min \{|p|,|x|\}}\right)^{\beta-(\gamma)}|x-p|^{1-n} \min \left\{1, \frac{d(p, \partial \Omega)}{|x-p|}\right\}$ for $x \in \Omega-\{0, p\}$.
(f) There exists $L_{\gamma, \Omega}>0$ such that for any $\left(h_{i}\right)_{i} \in C^{0, \theta}(\Omega)$ such that $\lim _{i \rightarrow+\infty} h_{i}=h$ in $C^{0, \theta}$, then for any sequences $\left(x_{i}\right)_{i},\left(y_{i}\right)_{i} \in \Omega$ such that

y_{i}=o\left(\left|x_{i}\right|\right) \text { and } x_{i}=o(1) \text { as } i \rightarrow+\infty
$$

then, as $i \rightarrow+\infty$ we have that

\end{equation*}

Notations: In order to simplify notations, we will often drop the dependence in the domain $\Omega$ and the dimension $n \geq 3$. If $F: A \times B \rightarrow \mathbb{R}$ is a function, then for any $x \in A$, we define $F_{x}: B \rightarrow \mathbb{R}$ by $F_{x}(y):=F(x, y)$ for all $y \in B$. We split the proof into several parts.

We let $\eta_{\epsilon}(x):=\tilde{\eta}\left(\epsilon^{-1}|x|\right)$ for all $x \in \mathbb{R}^{n}$ and $\epsilon>0$, where $\tilde{\eta} \in C^{\infty}(\mathbb{R})$ is nondecreasing and such that $\tilde{\eta}(t)=0$ for $t<1$ and $\tilde{\eta}(t)=1$ for $t>1$. It follows from Lemma 3 (see Appendix B) and the coercivity of $-\Delta-\left(\gamma|x|^{-2}+h\right)$ that there exists $\epsilon_{0}>0$ and $c>0$ such that such that for all $\varphi \in H_{1,0}^{2}(\Omega)$ and $\epsilon \in\left(0, \epsilon_{0}\right)$,

$$
\int_{\Omega}\left(|\nabla \varphi|^{2}-\left(\frac{\gamma \eta_{\epsilon}}{|x|^{2}}+h(x)\right) \varphi^{2}\right) d x \geq c \int_{\Omega} \varphi^{2} d x
$$

As a consequence, there exists $c>0$ such that for all $\varphi \in H_{1,0}^{2}(\Omega)$ and $\epsilon \in\left(0, \epsilon_{0}\right)$,

$$
\begin{equation*}
\int_{\Omega}\left(|\nabla \varphi|^{2}-\left(\frac{\gamma \eta_{\epsilon}}{|x|^{2}}+h(x)\right) \varphi^{2}\right) d x \geq c\|\varphi\|_{H_{1}^{2}}^{2} \tag{211}
\end{equation*}
$$

Let $G_{\epsilon}>0$ be the Green's function of $-\Delta-\left(\gamma \eta_{\epsilon}|x|^{-2}+h\right)$ on $\Omega$ with Dirichlet boundary condition. The existence follows from the coercivity and the $C^{0, \theta}$ regularity of the potential for any $\epsilon>0$ (see Robert [30]). In particular, we have that

$$
\begin{cases}-\Delta G_{\epsilon}(x, \cdot)-\left(\frac{\gamma \eta_{\epsilon}}{|\cdot|^{2}}+h\right) G_{\epsilon}(x, \cdot)=0 & \text { in } \Omega \backslash\{x\}  \tag{212}\\ G_{\epsilon}(x, \cdot)=0 & \text { on } \partial \Omega\end{cases}
$$

Step 14.1: Integral bounds for $G_{\epsilon}$. We claim that for all $\delta>0$ and $1<q<\frac{n}{n-2}$ and $\delta^{\prime} \in(0, \delta)$, there exists $C(\delta, q)>0$ and $C\left(\delta, \delta^{\prime}\right)>0$ such that

$$
\begin{equation*}
\left\|G_{\epsilon}(x, \cdot)\right\|_{L^{q}(\Omega)} \leq C(\delta, q) \text { and }\left\|G_{\epsilon}(x, \cdot)\right\|_{L^{\frac{2 n}{n-2}}\left(\Omega \backslash B_{\delta^{\prime}}(x)\right)} \leq C\left(\delta, \delta^{\prime}\right) \tag{213}
\end{equation*}
$$

for all $x \in \Omega,|x|>\delta$. We prove the claim. We fix $f \in C_{c}^{\infty}(\Omega)$ and let $\varphi_{\epsilon} \in C^{2, \theta}(\bar{\Omega})$ be the solution to the boundary value problem

$$
\left\{\begin{array}{cl}
-\Delta \varphi_{\epsilon}-\left(\frac{\gamma \eta_{\epsilon}}{|x|^{2}}+h(x)\right) \varphi_{\epsilon}=f & \text { in } \Omega  \tag{214}\\
\varphi_{\epsilon}=0 & \text { on } \partial \Omega
\end{array}\right.
$$

Multiplying the equation by $\varphi_{\epsilon}$, integrating by parts on $\Omega$, using (211) and Hölder's inequality, we get that

$$
\int_{\Omega}\left|\nabla \varphi_{\epsilon}\right|^{2} d x \leq C\|f\|_{\frac{2 n}{n+2}}\left\|\varphi_{\epsilon}\right\|_{\frac{2 n}{n-2}}
$$

where $C>0$ is independent of $\epsilon, f$ and $\varphi_{\epsilon}$. The Sobolev inequality $\|\varphi\|_{\frac{2 n}{n-2}} \leq$ $C\|\nabla \varphi\|_{2}$ for $\varphi \in H_{1,0}^{2}(\Omega)$ then yields

$$
\left\|\varphi_{\epsilon}\right\|_{\frac{2 n}{n-2}} \leq C\|f\|_{\frac{2 n}{n+2}}
$$

where $C>0$ is independent of $\epsilon, f$ and $\varphi_{\epsilon}$. Fix $p>n / 2$ and $\delta \in\left(0, \delta_{0}\right)$ and $\delta_{1}, \delta_{2}>0$ such that $\delta_{1}+\delta_{2}<\delta$, and $x \in \Omega$ such that $|x|>\delta$. It follows from standard elliptic theory that

$$
\begin{aligned}
\left|\varphi_{\epsilon}(x)\right| & \leq\left\|\varphi_{\epsilon}\right\|_{C^{0}\left(B_{\delta_{1}}(x)\right)} \\
& \leq C\left(\left\|\varphi_{\epsilon}\right\|_{L^{\frac{2 n}{n-2}}\left(B_{\delta_{1}+\delta_{2}}(x)\right)}+\|f\|_{L^{p}\left(B_{\delta_{1}+\delta_{2}}(x)\right)}\right) \\
& \leq C\left(\|f\|_{L^{\frac{2 n}{n+2}}(\Omega)}+\|f\|_{L^{p}\left(B_{\delta_{1}+\delta_{2}}(x)\right)}\right)
\end{aligned}
$$

where $C>0$ depends on $p, \delta, \delta_{1}, \delta_{2}, \gamma$ and $\|h\|_{\infty}$. Therefore, Green's representation formula yields

$$
\begin{equation*}
\left|\int_{\Omega} G_{\epsilon}(x, \cdot) f d y\right| \leq C\left(\|f\|_{L^{\frac{2 n}{n+2}(\Omega)}}+\|f\|_{L^{p}\left(B_{\delta_{1}+\delta_{2}}(x)\right)}\right) \tag{215}
\end{equation*}
$$

for all $f \in C_{c}^{\infty}(\Omega)$. It follows from (215) that

$$
\left|\int_{\Omega} G_{\epsilon}(x, \cdot) f d y\right| \leq C \cdot\|f\|_{L^{p}(\Omega)}
$$

for all $f \in C_{c}^{\infty}(\Omega)$ where $p>n / 2$. It then follows from duality arguments that for any $q \in(1, n /(n-2))$ and any $\delta>0$, there exists $C(\delta, q)>0$ such that $\left\|G_{\epsilon}(x, \cdot)\right\|_{L^{q}(\Omega)} \leq C(\delta, q)$ for all $\epsilon<\epsilon_{0}$ and $x \in \Omega \backslash B_{\delta}(0)$.
Let $\delta^{\prime} \in(0, \delta)$ and $\delta_{1}, \delta_{2}>0$ such that $\delta_{1}+\delta_{2}<\delta^{\prime}$. We get from (215) that

$$
\begin{equation*}
\left|\int_{\Omega} G_{\epsilon}(x, \cdot) f d y\right| \leq C\|f\|_{L^{\frac{2 n}{n+2}}\left(\Omega \backslash B_{\delta^{\prime}}(x)\right)} \tag{216}
\end{equation*}
$$

for all $f \in C_{c}^{\infty}\left(\Omega \backslash B_{\delta^{\prime}}(x)\right)$. Here again, a duality argument yields (213), which proves the claim in Step 14.1.
Using the same method, we can get an improvement of the control, the cost being the integrability exponent $q$. When $q \in(1, n /(n-1))$, we get that $p>n$. Then, $\left\|\varphi_{\epsilon}\right\|_{C^{1}\left(B_{\delta_{1}}(x) \cap \Omega\right)}$ is controled by the $L^{p}$ and $L^{\frac{2 n}{n+2}}$ norms. Moreover, $\left|\varphi_{\epsilon}(x)\right| \leq$ $\left\|\varphi_{\epsilon}\right\|_{C^{0}\left(B_{\delta_{1}}(x) \cap \Omega\right)} d(x, \partial \Omega)$. The argument above then yields

$$
\begin{equation*}
\left\|G_{\epsilon}(x, \cdot)\right\|_{L^{q}(\Omega)} \leq C(\delta, q) d(x, \partial \Omega) \text { for } q \in\left(1, \frac{n}{n-1}\right) \tag{217}
\end{equation*}
$$

Step 14.2: Convergence of $G_{\epsilon}$. Fix $x \in \Omega \backslash\{0\}$. For $0<\epsilon<\epsilon^{\prime}$, since $G_{\epsilon}(x, \cdot)$, $G_{\epsilon^{\prime}}(x, \cdot)$ are $C^{2}$ outside $x$, (212) yields
$-\Delta\left(G_{\epsilon}(x, \cdot)-G_{\epsilon^{\prime}}(x, \cdot)\right)-\left(\frac{\gamma \eta_{\epsilon}}{|\cdot|^{2}}+h\right)\left(G_{\epsilon}(x, \cdot)-G_{\epsilon^{\prime}}(x, \cdot)\right)=\frac{\gamma\left(\eta_{\epsilon}-\eta_{\epsilon^{\prime}}\right)}{|\cdot|^{2}} G_{\epsilon^{\prime}}(x, \cdot)$
in the strong sense. The coercivity (211) then yields $G_{\epsilon}(x, \cdot) \geq G_{\epsilon^{\prime}}(x, \cdot)$ for $0<$ $\epsilon<\epsilon^{\prime}$ if $\gamma \geq 0$, and the reverse inequality if $\gamma<0$. It then follows from the integral bound (213) and elliptic regularity that there exists $G(x, \cdot) \in C^{2, \theta}(\bar{\Omega} \backslash\{0, x\})$ such that

$$
\begin{equation*}
\lim _{\epsilon \rightarrow 0} G_{\epsilon}(x, \cdot)=G(x, \cdot) \geq 0 \text { in } C_{l o c}^{2, \theta}(\bar{\Omega}-\{0, x\}) \tag{218}
\end{equation*}
$$

In particular, $G$ is symmetric and

$$
\begin{equation*}
-\Delta G(x, \cdot)-\left(\frac{\gamma}{|\cdot|^{2}}+h\right) G(x, \cdot)=0 \text { in } \Omega \backslash\{x\} \text { and } G(x, \cdot)=0 \text { on } \partial \Omega \tag{219}
\end{equation*}
$$

Moreover, passing to the limit $\epsilon \rightarrow 0$ in (213), (217) and using elliptic regularity, we get that for all $\delta>0,1<q<\frac{n}{n-2}$ and $\delta^{\prime} \in(0, \delta)$, there exist $C(\delta, q)>0$ and $C\left(\delta, \delta^{\prime}\right)>0$ such that for all $x \in \Omega,|x|>\delta$,

$$
\begin{equation*}
\|G(x, \cdot)\|_{L^{q}(\Omega)} \leq C(\delta, q) \text { and }\|G(x, \cdot)\|_{L^{\frac{2 n}{n-2}}\left(\Omega \backslash B_{\delta^{\prime}}(x)\right)} \leq C\left(\delta, \delta^{\prime}\right) \tag{220}
\end{equation*}
$$

and

$$
\begin{equation*}
\|G(x, \cdot)\|_{L^{q}(\Omega)} \leq C(\delta, q) d(x, \partial \Omega) \text { for } q \in\left(1, \frac{n}{n-1}\right) \tag{221}
\end{equation*}
$$

In particular, for any $x \in \Omega \backslash\{0\}, G(x, \cdot) \in L^{k}(\Omega)$ for all $1<k<n /(n-2)$ and $G(x, \cdot) \in L^{2 n /(n-2)}\left(\Omega \backslash B_{\delta}(x)\right)$ for all $\delta>0$. Moreover, for any $f \in L^{\frac{2 n}{n+2}}(\Omega) \cap$ $L^{q}\left(\Omega \backslash B_{\delta}(0)\right)$ for all $\delta>0$ with $q>n / 2$, let $\varphi_{\epsilon} \in H_{1,0}^{2}(\Omega)$ be such that (214) holds. It follows from elliptic theory that $\varphi_{\epsilon} \in C^{0, \tau}(\bar{\Omega} \backslash\{0\})$ for some $\tau \in(0,1)$ and that for all $\delta_{1}>0$, there exists $C\left(\delta_{1}\right)>0$ such that $\left\|\varphi_{\epsilon}\right\|_{C^{0, \tau}\left(\bar{\Omega} \backslash B_{\delta_{1}}(0)\right)} \leq C\left(\delta_{1}\right)$. We fix $x \in \Omega \backslash\{0\}$. Passing to the limit $\epsilon \rightarrow 0$ in the Green identity $\varphi_{\epsilon}(x)=\int_{\Omega} G_{\epsilon}(x, \cdot) f d y$ yields

$$
\begin{equation*}
\varphi(x)=\int_{\Omega} G(x, \cdot) f d y \text { for all } x \in \Omega \backslash\{0\} \tag{222}
\end{equation*}
$$

where $\varphi \in H_{1,0}^{2}(\Omega) \cap C^{0}(\bar{\Omega} \backslash\{0\})$ is the only weak solution to

$$
\begin{cases}-\Delta \varphi-\left(\frac{\gamma}{|x|^{2}}+h(x)\right) \varphi=f & \text { in } \Omega \\ \varphi=0 & \text { on } \partial \Omega\end{cases}
$$

Since $G(x, \cdot) \geq 0,(219)$ and the strong comparison principle yield $G(x, \cdot)>0$. These points prove that $G$ is a Green's function for the operator and that (c) holds. We now prove point (b). We fix $\eta \in C_{c}^{\infty}\left(\mathbb{R}^{n}-\{x\}\right)$ such that $\eta(y)=1$ when $y \in B_{\delta}(0)$ for some $\delta>0$. Then $\eta G_{\epsilon}(x, \cdot) \in C^{2, \theta}(\bar{\Omega}) \cap H_{1,0}^{2}(\Omega)$. It follows from (212) and (218) that

$$
-\Delta\left(\eta G_{\epsilon}(x, \cdot)\right)-\left(\frac{\gamma \eta_{\epsilon}}{|\cdot|^{2}}+h\right)\left(\eta G_{\epsilon}(x, \cdot)\right)=\mathbf{1}_{B_{\delta}(0)^{c}} f_{\epsilon} \text { in } \Omega
$$

where $\left\|f_{\epsilon}\right\|_{C^{0}(\bar{\Omega})} \leq C$ for some $C>0$ and all $\epsilon>0$. Therefore, with the coercivity (211) and the convergence (218), we get that

$$
c\left\|\eta G_{\epsilon}(x, \cdot)\right\|_{H_{1}^{2}}^{2} \leq \int_{\Omega \backslash B_{\delta}(0)} f_{\epsilon} \eta G_{\epsilon}(x, \cdot) d y \leq C
$$

for all $\epsilon>0$. Reflexivity yields convergence of $\left(\eta G_{\epsilon}(x, \cdot)\right)$ in $H_{1,0}^{2}(\Omega) \cap L^{2}(\Omega)$ as $\epsilon \rightarrow 0$ up to extraction. The convergence in $C^{2}$ and uniqueness then yields $\eta G(x, \cdot) \in H_{1,0}^{2}(\Omega)$ and $\eta G_{\epsilon}(x, \cdot) \rightarrow \eta G(x, \cdot)$ in $H_{1,0}^{2}(\Omega)$ as $\epsilon \rightarrow 0$. The case of a general $\eta$ is a direct consequence. This proves point (b).
For the uniqueness, we suppose $G^{\prime}$ be another Green's function. We fix $x \in \Omega$ and we define $H_{x}:=G_{x}-G_{x}^{\prime}$. Then $H_{x} \in L^{1}(\Omega)$ and for any $f \in C_{c}^{\infty}(\Omega)$, we have that $\int_{\Omega} H_{x} f d y=0$. Approximating a compactly supported function by smooth fonctions with compact support, we get that this equality holds for all $f \in C_{c}^{0}(\Omega)$. Integration theory then yields $H_{x} \equiv 0$, and then $G_{x}^{\prime} \equiv G_{x}$. This proves uniqueness. This finishes the proof of (a).
This proves existence and uniqueness of the Green's function in Theorem 8(I).
14.2. Proof of the upper bound. The behavior (206) is a consequence of the classification of solutions to harmonic equations and Theorem 4.1 in GhoussoubRobert [21].
In the proof, we will often use sub- and super-solutions to the linear problem. The following existence result is contained in Proposition 4.3 of [21]:
Proposition 10. Let $\Omega$ be a smooth domain and $h \in C^{0}(\bar{\Omega})$ be a continuous fonction. We fix $\gamma<\frac{n^{2}}{4}$ and $\beta \in\left\{\beta_{-}(\gamma), \beta_{+}(\gamma)\right\}$. Then, there exist $r>0$, and $\bar{u}_{\beta}, \underline{u}_{\beta} \in C^{\infty}(\bar{\Omega} \backslash\{0\})$ such that

$$
\left\{\begin{array}{cc}
\bar{u}_{\beta}, \underline{u}_{\beta}=0 & \text { on } \partial \Omega \cap B_{r}(0)  \tag{223}\\
-\Delta \bar{u}_{\beta}-\left(\frac{\gamma}{|x|^{2}}+h\right) \bar{u}_{\beta}>0 & \text { in } \Omega \cap B_{r}(0) \\
-\Delta \underline{u}_{\beta}-\left(\frac{\gamma}{|x|^{2}}+h\right) \underline{u}_{\beta}<0 & \text { in } \Omega \cap B_{r}(0)
\end{array}\right.
$$

Moreover, for some $\tau>0$, we have that, as $x \rightarrow 0, x \in \Omega$,

$$
\begin{equation*}
\bar{u}_{\beta}(x)=\underline{u}_{\beta}(x)\left(1+O\left(|x|^{\tau}\right)\right)=\frac{d(x, \partial \Omega)}{|x|^{\beta}}\left(1+O\left(|x|^{\tau}\right)\right) . \tag{224}
\end{equation*}
$$

Step 14.3: Upper bound for $G(x, y)$ when one variable is far from 0.
Step 14.3.1: It follows from (219), elliptic theory, (221) and (220) that for any $\delta>0$, there exists $C(\delta)>0$ such that

$$
\begin{equation*}
0<G(x, y) \leq C(\delta) d(y, \partial \Omega) d(x, \partial \Omega) \text { for } x, y \in \Omega \text { s.t. }|x|,|y|>\delta,|x-y|>\delta \tag{225}
\end{equation*}
$$

Step 14.3.2: We claim that for any $\delta>0$, there exists $C(\delta)>0$ such that

$$
\begin{equation*}
|x-y|^{n-2} G(x, y) \leq C(\delta) \min \left\{1, \frac{d(x, \partial \Omega) d(y, \partial \Omega)}{|x-y|^{2}}\right\} \text { for } x, y \in \Omega \text { s.t. }|x|,|y|>\delta \tag{226}
\end{equation*}
$$

Indeed, with no loss of generality, we can assume that $\delta \in\left(0, \delta_{0}\right)$. Let $\Omega_{\delta}$ be a smooth domain of $\mathbb{R}^{n}$ be such that $\Omega \backslash B_{3 \delta / 4}(0) \subset \Omega_{\delta} \subset \Omega \backslash B_{\delta / 2}(0)$. We fix $x \in \Omega$ such that $|x|>\delta$. Let $H_{x}$ be the Green's function for $-\Delta-\left(\frac{\gamma}{|x|^{2}}+h(x)\right)$ in $\Omega_{\delta}$ with Dirichlet boundary condition. Classical estimates (see [30]) yield the existence of $C(\delta)>0$ such that

$$
|x-y|^{n-2} H_{x}(y) \leq C(\delta) \min \left\{1, \frac{d(x, \partial \Omega) d(y, \partial \Omega)}{|x-y|^{2}}\right\} \text { for all } x, y \in \Omega_{\delta}
$$

It is easy to check that

$$
\begin{cases}-\Delta\left(G_{x}-H_{x}\right)-\left(\frac{\gamma}{\cdot \cdot{ }^{2}}+h\right)\left(G_{x}-H_{x}\right)=0 & \text { weakly in } \Omega_{\delta} \\ G_{x}-H_{x}=0 & \text { on }\left(\partial \Omega_{\delta}\right) \backslash B_{3 \delta / 4}(0) \\ G_{x}-H_{x}=G_{x} & \text { on }\left(\partial \Omega_{\delta}\right) \cap B_{3 \delta / 4}(0) .\end{cases}
$$

Regularity theory then yields that $G_{x}-H_{x} \in C^{2, \theta}\left(\overline{\Omega_{\delta}}\right)$. It follows from (225) that $G_{x}(y) \leq C_{1}(\delta) d(y, \partial \Omega) d(x, \partial \Omega)$ on $\left(\partial \Omega_{\delta}\right) \cap B_{3 \delta / 4}(0)$ for $|x|>\delta$. The comparison principle then yields $G_{x}(y)-H_{x}(y) \leq C_{1}(\delta) d(y, \partial \Omega) d(x, \partial \Omega)$ for $y \in \Omega_{\delta}$ and $|x|>\delta$. The above bound for $H_{x}$ and (225) then yields (226).
Step 14.3.3: We now claim that for any $0<\delta^{\prime}<\delta$, there exists $C\left(\delta, \delta^{\prime}\right)>0$ such that

$$
\begin{equation*}
|y|^{\beta_{-}(\gamma)} G(x, y) \leq C\left(\delta, \delta^{\prime}\right) d(y, \partial \Omega) d(x, \partial \Omega) \text { for } x, y \in \Omega \text { s.t. }|x|>\delta>\delta^{\prime}>|y| \tag{227}
\end{equation*}
$$

We let $\delta_{1} \in\left(0, \delta^{\prime}\right)$ that will be fixed later. We use (225) to deduce that $G_{x}(y) \leq$ $C\left(\delta, \delta_{1}\right) d(x, \partial \Omega) d(y, \partial \Omega)$ for all $x \in \Omega \backslash B_{\delta}(0)$ and $y \in \partial B_{\delta_{1}}(0) \cap \Omega$. Since $\delta_{1}<|x|$, we have that

$$
\begin{cases}-\Delta G_{x}-\left(\frac{\gamma}{|x|^{2}}+h\right) G_{x}=0 & \text { in } \Omega \cap B_{\delta_{1}}(0) \\ 0 \leq G_{x} \leq C\left(\delta, \delta_{1}\right) d(y, \partial \Omega) d(x, \partial \Omega) & \text { on } \partial\left(\Omega \cap B_{\delta_{1}}(0)\right) \backslash\{0\}\end{cases}
$$

We choose a supersolution $\bar{u}_{\beta_{-}(\gamma)}$ as in (223) of Proposition 10. It follows from (224) and (225) that for $\delta_{1}>0$, there exists $C\left(\delta, \delta_{1}\right)>0$ such that $G_{x}(z) \leq$ $C\left(\delta, \delta_{1}\right) d(x, \partial \Omega) u_{\beta_{-}}(z)$ for all $z \in \partial\left(\Omega \cap B_{\delta_{1}}(0)\right)$. It then follows from the comparison principle that $G_{x}(y) \leq C\left(\delta, \delta_{1}\right) d(x, \partial \Omega) u_{\beta_{-}}(y)$ for all $y \in\left(\Omega \cap B_{\delta_{1}}(0)\right) \backslash\{0\}$. Combining this with (225) and (223), we obtain (227).
Note that by symmetry, we also get that for any $0<\delta^{\prime}<\delta$, there exists $C\left(\delta, \delta^{\prime}\right)>0$ such that

$$
\begin{equation*}
|x|^{\beta_{-}(\gamma)} G(x, y) \leq C\left(\delta, \delta^{\prime}\right) d(x, \partial \Omega) d(y, \partial \Omega) \text { for } x, y \in \Omega \text { s.t. }|y|>\delta>\delta^{\prime}>|x| \tag{228}
\end{equation*}
$$

## Step 14.4: Upper bound for $G(x, y)$ when both variables approach 0 .

We claim first that for all $c_{1}, c_{2}, c_{3}>0$, there exists $C\left(c_{1}, c_{2}, c_{3}\right)>0$ such that for $x, y \in \Omega$ such that $c_{1}|x|<|y|<c_{2}|x|$ and $|x-y|>c_{3}|x|$, we have

$$
\begin{equation*}
|x-y|^{n-2} G(x, y) \leq C\left(c_{1}, c_{2}, c_{3}\right) \frac{d(x, \partial \Omega) d(y, \partial \Omega)}{|x|^{2}} \tag{229}
\end{equation*}
$$

When one of the variables stays far from 0 , (229) is a consequence of (225). We now consider a chart $\mathcal{T}$ at 0 as in (27). In particular, there is $\delta_{0}>0,0 \in V \subset \mathbb{R}^{n}$ and $\mathcal{T}: B_{2 \delta_{0}}(0) \rightarrow V$ a smooth diffeomorphism such that $\mathcal{T}(0)=0$ and

\mathcal{T}\left(B_{2 \delta_{0}}(0) \cap \mathbb{R}_{-}^{n}\right)=\mathcal{T}(U) \cap \Omega \text { and } \mathcal{T}\left(B_{2 \delta_{0}}(0) \cap \partial \mathbb{R}_{-}^{n}\right)=\mathcal{T}(U) \cap \partial \Omega \tag{230}
\end{equation*}
$$

Moreover, $D_{0} \mathcal{T}=\mathbb{I}_{\mathbb{R}^{n}}$ and

$$
\begin{equation*}
|\mathcal{T}(X)|=(1+O(|X|))|X| \text { for all } X \in B_{3 \delta_{0} / 2}(0) \tag{231}
\end{equation*}
$$

We fix $X \in \mathbb{R}_{-}^{n}$ such that $0<|X|<3 \delta_{0} / 2$. We define

$$
H(z):=G_{\mathcal{T}(X)}(\mathcal{T}(|X| z)) \text { for } z \in B_{\delta_{0} /|X|}(0) \backslash\left\{0, \frac{X}{|X|}\right\}
$$

so that

-\Delta_{g_{X}} H-\left(\frac{\gamma}{\left(\frac{\mid \mathcal{T}(|X| z \mid)}{|X|}\right)^{2}}+|X|^{2} h(\mathcal{T}(|X| z))\right) H=0 \text { in } B_{\delta_{0} /|X|}(0) \backslash\left\{0, \frac{X}{|X|}\right\}
$$

where $g_{X}:=\left(\mathcal{T}^{\star} E u c l\right)_{X}$ is the pulled-back metric of the Euclidean metric Eucl via the chart $\mathcal{T}$ at the point $X$. Since $H>0$, it follows from the Harnack inequality on the boundary (see Proposition 6.3 in Ghoussoub-Robert [21]) that for all $R>0$ large enough and $r>0$ small enough, there exist $\delta_{1}>0$ and $C>0$ independent of $|X|<3 \delta_{0} / 2$ such that

which, via the chart $\mathcal{T}$, yields

\frac{G_{x}(y)}{d(y, \partial \Omega)} \leq C \frac{G_{x}\left(y^{\prime}\right)}{d\left(y^{\prime}, \partial \Omega\right)} \text { for all } y, y^{\prime} \in \Omega \cap B_{R|x| / 2}(0) \backslash\left(B_{2 r|x|}(0) \cup B_{2 r|x|}(x)\right) \tag{232}
\end{equation*}
$$

for all $x \in \Omega$ such that $|x|<\delta_{0}$. We let $W$ be a smooth domain of $\mathbb{R}^{n}$ such that for some $\lambda>0$ small enough, we have

B_{\lambda}(0) \cap \Omega \subset W \subset B_{2 \lambda}(0) \cap \Omega \text { and } B_{\lambda}(0) \cap \partial W=B_{\lambda}(0) \cap \partial \Omega \tag{233}
\end{equation*}

We choose a subsolution $\underline{u}_{\beta_{+}(\gamma)}$ as in (223) of Proposition 10. It follows from (224) and (225) that for $|x|<\delta_{2}$ small
$G_{x}(z) \geq C(R)|x|^{\beta_{+}(\gamma)}\left(\inf _{y \in \Omega \cap \partial B_{R|x|}(0)} \frac{G_{x}(y)}{d(y, \partial \Omega)}\right) \underline{u}_{\beta_{+}(\gamma)}(z)$ for all $z \in W \cap \partial B_{R|x| / 3}(0)$.
Since $-\Delta G_{x}-\left(\gamma|\cdot|^{-2}+h\right) G_{x}=0$ outside 0 , it follows from coercivity and the comparison principle that

G_{x}(z) \geq c|x|^{\beta_{+}(\gamma)}\left(\inf _{y \in \Omega \cap \partial B_{R|x|}(0)} \frac{G_{x}(y)}{d(y, \partial \Omega)}\right) \underline{u}_{\beta_{+}(\gamma)}(z) \text { for all } z \in W \backslash B_{R|x| / 3}(0)
$$

We fix $z_{0} \in W \backslash\{0\}$. Then for $\delta_{3}$ small enough, when $|x|<\delta_{3}$, it follows from (228) and the Harnack inequality (232) that there exists $C>0$ independent of $x$ such that
$G_{x}(y) \leq C|x|^{-\beta_{+}(\gamma)-\beta_{-}(\gamma)} d(x, \partial \Omega) d(y, \partial \Omega)$ for all $y \in B_{R|x|}(0) \backslash\left(B_{r|x|}(0) \cup B_{r|x|}(x)\right)$
Taking $r>0$ small enough and $R>0$ large enough, we then get (229) for $|x|<\delta_{3}$. The general case for arbitrary $x \in \Omega \backslash\{0\}$ then follows from (226). This completes the proof of (229).
Step 14.4.2: We claim that for all $c_{1}, c_{2}>0$, there exists $C\left(c_{1}, c_{2}\right)>0$ such that

for all $x, y \in \Omega$ s.t. $c_{1}|x|<|y|<c_{2}|x|$. To prove (234), we distinguish three cases: Case 1: We assume that

\end{equation*}
$$

We define

H(z):=|x|^{n-2} G_{x}(x+|x| z) \text { for } z \in B_{1 / C_{1}}(0) \backslash\{0\} .
$$

Note that this definition makes sense since for such $z, x+|x| z \in \Omega$. We then have that $H \in C^{2}\left(\overline{B_{1 /\left(2 C_{1}\right)}(0)} \backslash\{0\}\right)$ and

-\Delta H-\left(\frac{\gamma}{\left|\frac{x}{|x|}+z\right|^{2}}+|x|^{2} h(x+|x| z)\right) H=\delta_{0} \text { weakly in } B_{1 /\left(2 C_{1}\right)}(0)
$$

We now argue as in the proof of (226). From (229), we have that $|H(z)| \leq C$ for all $z \in \partial B_{1 /\left(2 C_{1}\right)}(0)$ where $C$ is independent of $x \in \Omega \backslash\{0\}$ satisfying (235). Let $\Gamma_{0}$ be the Green's function of $-\Delta-\left(\frac{\gamma}{\left|\frac{x}{|x|}+z\right|^{2}}+|x|^{2} h(x+|x| z)\right)$ at 0 on $B_{1 /\left(2 C_{1}\right)}(0)$ with Dirichlet boundary condition. Therefore, $H-\Gamma_{0} \in C^{2}\left(\overline{B_{1 /\left(2 C_{1}\right)}(0)}\right)$ and, via the comparison principle, it is bounded by its supremum on the boundary. Therefore $|z|^{n-2} H(z) \leq C$ for all $B_{1 /\left(2 C_{1}\right)}(0) \backslash\{0\}$ where $C$ is independent of $x \in \Omega \backslash\{0\}$ satisfying (235). Scaling back and using (229), we get $|x-y|^{n-2} G_{x}(y) \leq C$ for all $x, y \in \Omega \backslash\{0\}$ such that $c_{1}|x|<|y|<c_{2}|x|$ and (235) holds. This proves (234) if $d(x, \partial \Omega) d(y, \partial \Omega) \geq|x-y|^{2}$. If $d(x, \partial \Omega) d(y, \partial \Omega)<|x-y|^{2}$, we get that $d(x, \partial \Omega)<2|x-y|$, and then (235) yields $|x| \leq 2 C_{1}|x-y|$, and (234) is a consequence of (229).
This ends the proof of (234) in Case 1.
Case 2: By symmetry, (234) also holds when $|y| \leq C_{1} d(y, \partial \Omega)$.
Case 3: We assume that $d(x, \partial \Omega) \leq C_{1}^{-1}|x|$ and $d(y, \partial \Omega) \leq C_{1}^{-1}|y|$. We consider a chart at 0 , that is $\delta_{0}>0,0 \in V \subset \mathbb{R}^{n}$ and $\mathcal{T}: B_{2 \delta_{0}}(0) \rightarrow V$ a smooth diffeomorphism such that $\mathcal{T}(0)=0$ and that (230) and (231) hold. We fix $x^{\prime} \in \mathbb{R}^{n-1}$ such that $0<\left|x^{\prime}\right|<3 \delta_{0} / 2$.

We assume that $r \leq c_{0}\left|x^{\prime}\right|$. We define

H_{y}(z):=r^{n-2} G_{\mathcal{T}\left(\left(0, x^{\prime}\right)+r y\right)}\left(\mathcal{T}\left(\left(0, x^{\prime}\right)+r z\right)\right) \text { for } y, z \in B_{\delta_{0} /(2 r)}(0) \cap \mathbb{R}_{-}^{n} \backslash\{0\}
$$

We then have that $H_{y} \in C^{2}\left(\overline{B_{R_{0}}(0)} \cap \mathbb{R}_{-}^{n} \backslash\{0, y\}\right)$ and
$-\Delta_{g_{r}} H_{y}-\left(\frac{\gamma}{\left(\frac{\mid \mathcal{T}\left(\left(0, x^{\prime}\right)+r z\right)}{r}\right)^{2}}+r^{2} h\left(\mathcal{T}\left(\left(0, x^{\prime}\right)+r z\right)\right)\right) H_{y}=\delta_{y}$ weakly in $B_{R_{0}}(0) \cap \mathbb{R}_{-}^{n}$,
where $g_{r}:=\left(\mathcal{T}^{\star} \operatorname{Eucl}\right)_{\left(0, x^{\prime}\right)+r z}$ is the pulled-back metric of the Euclidean metric Eucl via the chart $\mathcal{T}$ at the point $\left(0, x^{\prime}\right)+r z$. We now argue as in the proof of (226). From (178), we have that $\left|H_{y}(z)\right| \leq C$ for all $z \in \partial B_{R_{0}}(0) \cap \mathbb{R}_{-}^{n}$ where $C$ is independent of $y \in B_{R_{0} / 2}(0)$ and $r \in\left(0, \delta_{0} / 4\right)$. Let $\Gamma_{y}$ be the Green's function of $-\Delta_{g_{r}}-\left(\frac{\gamma}{\left(\frac{\mathcal{T}\left(\left(0, x^{\prime}\right)+r z\right)}{r}\right)^{2}}+r^{2} h\left(\mathcal{T}\left(\left(0, x^{\prime}\right)+r z\right)\right)\right)$ at $y$ on $B_{c_{0} / 2}(0) \cap \mathbb{R}_{-}^{n}$ with Dirichlet boundary condition. Therefore, $H_{y}-\Gamma_{y} \in C^{2}\left(\overline{B_{c_{0} / 2}(0) \cap \mathbb{R}_{-}^{n}}\right)$ and, via the comparison principle, it is bounded by its supremum on the boundary. It follows from (178) and elliptic estimates for $\Gamma_{y}$ (see for instance [30]) that $\left|H_{y}-\Gamma_{y}\right|(z) \leq$ $C\left|y_{1}\right| \cdot\left|z_{1}\right|$ for $z \in \partial\left(B_{c_{0} / 2}(0) \cap \mathbb{R}_{-}^{n}\right)$ and $y \in B_{c_{0} / 4}(0) \cap \mathbb{R}_{-}^{n}$. Applying elliptic estimates, we then get that $\left|H_{y}-\Gamma_{y}\right|(z) \leq C\left|y_{1}\right| \cdot\left|z_{1}\right|$ for $z \in B_{c_{0} / 2}(0) \cap \mathbb{R}_{-}^{n}$ and
$y \in B_{c_{0} / 4}(0) \cap \mathbb{R}_{-}^{n}$, and since

\Gamma_{y}(z) \leq C|z-y|^{2-n} \min \left\{1, \frac{\left|y_{1}\right| \cdot\left|z_{1}\right|}{|y-z|^{2}}\right\} \text { for all } y, z \in B_{c_{0} / 2}(0) \cap \mathbb{R}_{-}^{n}
$$

(see [30]), we get that

|z-y|^{n-2} H_{y}(z) \leq C \min \left\{1, \frac{\left|y_{1}\right| \cdot\left|z_{1}\right|}{|y-z|^{2}}\right\} \text { for all } y, z \in B_{c_{0} / 2}(0) \cap \mathbb{R}_{-}^{n}
$$

where $C$ is independent of $x^{\prime} \in B_{\delta_{0} / 2}(0) \backslash\{0\}$. This yields

$$
\begin{equation*}
|r z-r y|^{n-2} G_{\mathcal{T}\left(\left(0, x^{\prime}\right)+r y\right)}\left(\mathcal{T}\left(\left(0, x^{\prime}\right)+r z\right)\right) \leq C \min \left\{1, \frac{\left|y_{1}\right| \cdot\left|z_{1}\right|}{|y-z|^{2}}\right\} \tag{236}
\end{equation*}
$$

for $\left|x^{\prime}\right|<\delta_{0} / 3, r \leq c_{0}\left|x^{\prime}\right|$ and $|y|,|z| \leq c_{0} / 4$.
We now prove (234) in the last case. We fix $x \in \Omega \backslash\{0\}$ such that $|x|<\delta_{0} / 3$.
We assume that $d(x, \partial \Omega) \leq C_{1}^{-1}|x|, d(y, \partial \Omega) \leq C_{1}^{-1}|y|$ and $|x-y| \leq \epsilon_{0}|x|$. We let $\left(x_{1}, x^{\prime}\right),\left(y_{1}, y^{\prime}\right) \in B_{\delta_{0}}(0)$ be such that $x=\mathcal{T}\left(x_{1}, x^{\prime}\right)$ and $y=\mathcal{T}\left(y_{1}, y^{\prime}\right)$. Taking the norm $\left|\left(x_{1}, x^{\prime}\right)\right|=\left|x_{1}\right|+\left|x^{\prime}\right|$, we define $r:=\max \{d(x, \partial \Omega),|x-y|\}$. Using that $|X| / 2 \leq|\mathcal{T}(X)| \leq 2|X|$ for $X \in B_{\delta_{0}}(0)$, up to taking $\epsilon_{0}>0$ small and $C_{1}, c_{0}>1$ large enough, we get that

We are now in position to conclude. Inequality (234) is a consequence of Cases 1, $2,3,(226)$ and (178). This ends the proof of (234).
Step 14.4.3: We now show that there exists $C>0$ such that

The proof goes essentially as in (227). For $|x|<\delta$ with $\delta>0$ small, we have that

$$

It follows from (178) that $G_{x}(y) \leq C|x|^{-n} d(x, \partial \Omega) d(y, \partial \Omega)$ in $\Omega \cap \partial B_{|x| / 3}(0)$. We choose a supersolution $\bar{u}_{\beta_{-}(\gamma)}$ as in (223) of Proposition 10. It follows from (224) and (178) that there exists $C>0$ such that

G_{x}(y) \leq C|x|^{-\beta_{+}(\gamma)} d(x, \partial \Omega) \bar{u}_{\beta_{-}(\gamma)}(y) \text { for all } y \in \Omega \cap \partial B_{|x| / 3}(0)
$$

The comparison principle yields that this inequality holds on $\Omega \cap B_{|x| / 3}(0)$.
Step 14.4.4: By symmetry, we conclude that there exists $C>0$ such that

\begin{equation*}
|x|^{\beta_{-}(\gamma)}|y|^{\beta_{+}(\gamma)} G(x, y) \leq C d(x, \partial \Omega) d(y, \partial \Omega) \text { for } x, y \in \Omega \text { s.t. }|x|<\frac{1}{2}|y| \tag{238}
\end{equation*}
$$

Step 14.5: Finally, it follows from (237), (238) and (234) that there exists $c>0$ such that

G(x, y) \leq c\left(\frac{\max \{|y|,|x|\}}{\min \{|y|,|x|\}}\right)^{\beta-(\gamma)}|x-y|^{2-n} \min \left\{1, \frac{d(x, \partial \Omega) d(y, \partial \Omega)}{|x-y|^{2}}\right\} \tag{239}
\end{equation*}
$$

for all $x, y \in \Omega, x \neq y$. This proves the upper bound in (207) of Theorem 8. The lower-bound and the control of the gradient will be proved in Section 14.4.
14.3. Behavior at infinitesimal scale. We prove three convergence results to get a comprehensive behavior of the Green's function. Throughout this subsection, we assume $\Omega$ is a smooth bounded domain of $\mathbb{R}^{n}$ such that $0 \in \partial \Omega$. We fix $\gamma<\frac{n^{2}}{4}$ and let $h \in C^{0, \theta}(\bar{\Omega})$ be such that $-\Delta-\gamma|x|^{-2}-h$ is coercive. We consider $G$ to be the Green's function of $-\Delta-\gamma|x|^{-2}-h$ with Dirichlet boundary condition on $\partial \Omega$.

Lemma 4. Let $\left(x_{i}\right)_{i} \in \Omega$ and $\left(r_{i}\right)_{i} \in(0,+\infty)$ be such that

$$
\lim _{i \rightarrow+\infty} r_{i}=0 \text { and } \lim _{i \rightarrow+\infty} \frac{d\left(x_{i}, \partial \Omega\right)}{r_{i}}=+\infty
$$

Then, for all $X, Y \in \mathbb{R}^{n}$ such that $X \neq Y$, we have that

$$
\lim _{i \rightarrow+\infty} r_{i}^{n-2} G\left(x_{i}+r_{i} X, x_{i}+r_{i} Y\right)=\frac{1}{(n-2) \omega_{n-1}}|X-Y|^{2-n}
$$

Moreover, the convergence holds in $C_{\text {loc }}^{2}\left(\left(\mathbb{R}^{n}\right)^{2} \backslash \operatorname{Diag}\left(\mathbb{R}^{n}\right)\right)$.
To deal with the case when the points approach the boundary, we consider a chart $\mathcal{T}$ as in (27). In particular, $D_{0} \mathcal{T}=\mathbb{I}_{\mathbb{R}^{n}}$.

Lemma 5. Let $\left(x_{i}\right)_{i} \in \partial \Omega$ and $\left(r_{i}\right)_{i} \in(0,+\infty)$ and $x_{0} \in \partial \Omega$ be such that

$$
\lim _{i \rightarrow+\infty} r_{i}=0, \quad \lim _{i \rightarrow+\infty} x_{i}=x_{0} \in \partial \Omega \text { and } \lim _{i \rightarrow+\infty} \frac{\left|x_{i}\right|}{r_{i}}=+\infty
$$

We let $\mathcal{T}$ be a chart at $x_{0}$ as in (27). We define $x_{i}^{\prime} \in \mathbb{R}^{n-1}$ such that $x_{i}=\mathcal{T}\left(0, x_{i}^{\prime}\right)$. Then, for all $X, Y \in \mathbb{R}_{-}^{n}$ such that $X \neq Y$, we have that

$$
\begin{aligned}
& \lim _{i \rightarrow+\infty} r_{i}^{n-2} G\left(\mathcal{T}\left(\left(0, x_{i}^{\prime}\right)+r_{i} X\right), \mathcal{T}\left(\left(0, x_{i}^{\prime}\right)+r_{i} Y\right)\right) \\
& =\frac{1}{(n-2) \omega_{n-1}}\left(|X-Y|^{2-n}-\left|X-Y^{*}\right|^{2-n}\right)
\end{aligned}
$$

where $\left(Y_{1}, Y^{\prime}\right)^{*}=\left(-Y_{1}, Y^{\prime}\right)$ for $\left(Y_{1}, Y^{\prime}\right) \in \mathbb{R} \times \mathbb{R}^{n-1}$. Moreover, the convergence holds in $\left.C_{l o c}^{2}\left(\left(\overline{\mathbb{R}_{-}^{n}}\right)^{2} \backslash \operatorname{Diag}\left(\overline{\mathbb{R}_{-}^{n}}\right)\right\}\right)$.

Lemma 6. Let $\left(r_{i}\right)_{i} \in(0,+\infty)$ be such that $\lim _{i \rightarrow+\infty} r_{i}=0$. We let $\mathcal{T}$ be a chart at 0 as in (27). Then, for all $X, Y \in \overline{\mathbb{R}_{-}^{n}} \backslash\{0\}$ such that $X \neq Y$, we have that

\lim _{i \rightarrow+\infty} r_{i}^{n-2} G\left(\mathcal{T}\left(r_{i} X\right), \mathcal{T}\left(r_{i} Y\right)\right)=\mathcal{G}(X, Y)
$$

where $\mathcal{G}(X, Y)=\mathcal{G}_{X}(Y)$ is the Green's function for $-\Delta-\gamma|x|^{-2}$ on $\mathbb{R}_{-}^{n}$ with Dirichlet boundary condition. Moreover, the convergence holds in $C_{l o c}^{2}\left(\left(\overline{\mathbb{R}_{-}^{n}} \backslash\{0\}\right)^{2} \backslash\right.$ $\left.\operatorname{Diag}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\{0\}\right)\right)$.

Proof of Lemma 4: We let $\left(r_{i}\right)_{i} \in(0,+\infty)$ and $\left(x_{i}\right)_{i} \in \Omega$ as in the statement of the lemma. For any $X, Y \in \mathbb{R}^{n}, X \neq Y$, we define

G_{i}(X, Y):=r_{i}^{n-2} G\left(x_{i}+r_{i} X, x_{i}+r_{i} Y\right)
$$

for all $i \in \mathbb{N}$. Since $r_{i}=o\left(d\left(x_{i}, \partial \Omega\right)\right)$ as $i \rightarrow+\infty$, for any $R>0$, there exists $i_{0} \in \mathbb{N}$ such that this definition makes sense for any $X, Y \in B_{R}(0)$. Equation (205) yields

-\Delta G_{i}(X, \cdot)-\left(\frac{\gamma}{\left|\frac{x_{i}}{r_{i}}+\cdot\right|^{2}}+r_{i}^{2} h\left(x_{i}+r_{i} \cdot\right)\right) G_{i}(X, \cdot)=0 \text { in } B_{R}(0) \backslash\{X\} \tag{240}
\end{equation*}
$$

The pointwise control (239) writes

0<G_{i}(X, Y) \leq c\left(\frac{\max \left\{\left|x_{i}+r_{i} X\right|,\left|x_{i}+r_{i} Y\right|\right\}}{\min \left\{\left|x_{i}+r_{i} X\right|,\left|x_{i}+r_{i} Y\right|\right\}}\right)^{\beta-(\gamma)}|X-Y|^{2-n} \tag{241}
\end{equation*}
$$

for all $X, Y \in B_{R}(0)$ such that $X \neq Y$. Since $0 \in \partial \Omega$, we have that $d\left(x_{i}, \partial \Omega\right) \leq\left|x_{i}\right|$, and therefore $r_{i}=o\left(\left|x_{i}\right|\right)$ as $i \rightarrow+\infty$. Equation (240) and inequality (241) yield

-\Delta G_{i}(X, \cdot)+\theta_{i}(X, \cdot) G_{i}(X, \cdot)=0 \text { in } B_{R}(0) \backslash\{X\}
$$

where $\theta_{i} \rightarrow 0$ uniformly in $C_{l o c}^{0}\left(\left(\mathbb{R}^{n}\right)^{2}\right)$ and $0<G_{i}(X, Y) \leq c|X-Y|^{2-n}$ for all $X, Y \in B_{R}(0)$ such that $X \neq Y$. It then follows from standard elliptic theory that, up to a subsequence, there exists $G_{\infty}(X, \cdot) \in C^{2}\left(\mathbb{R}^{n} \backslash\{X\}\right)$ such that $G_{i}(X, \cdot) \rightarrow$ $G_{\infty}(X, \cdot) \geq 0$ in $C_{l o c}^{2}\left(\mathbb{R}^{n} \backslash\{X\}\right)$ and
$-\Delta G_{\infty}(X, \cdot)=0$ in $\mathbb{R}^{n} \backslash\{X\}$ and $G_{\infty}(X, Y) \leq c|X-Y|^{2-n}$ for $X, Y \in \mathbb{R}^{n}, X \neq Y$.
It then follows from the classification of positive harmonic functions that there exists $\lambda>0$ such that $G_{\infty}(X, Y)=\lambda|X-Y|^{2-n}$ for all $X, Y \in \mathbb{R}^{n}, X \neq Y$.
We fix $\varphi \in C_{c}^{\infty}\left(\mathbb{R}^{n}\right)$. We define $\varphi_{i}(x):=\varphi\left(r_{i}^{-1}\left(x-x_{i}\right)\right)$ for $x \in \Omega$ (this makes sense for $i$ large enough). It follows from (204) that

\varphi_{i}\left(x_{i}+r_{i} X\right)=\int_{\Omega} G\left(x_{i}+r_{i} X, y\right)\left(-\Delta \varphi_{i}(y)-\left(\frac{\gamma}{|y|^{2}}+h(y)\right) \varphi_{i}(y)\right) d y
$$

Via a change of variable, and passing to the limit, we get that

\varphi(X)=\int_{\mathbb{R}^{n}} G_{\infty}(X, Y)(-\Delta \varphi(Y)) d y
$$

Since $G_{\infty}(X, Y)=\lambda|X-Y|^{2-n}$, we get that $\lambda=1 /\left((n-2) \omega_{n-1}\right)$. Since the limit is unique, the convergence holds without extracting a subsequence. The convergence in $C_{l o c}^{2}\left(\left(\mathbb{R}^{n}\right)^{2} \backslash \operatorname{Diag}\left(\mathbb{R}^{n}\right)\right)$ follows from the symmetry of $G$ and elliptic theory.
Proof of Lemma 5: The proof goes as in the proof of lemma 4, except that we have to take a chart due to the closeness of the boundary. We let $\left(r_{i}\right)_{i} \in(0,+\infty)$, $\left(x_{i}\right)_{i} \in \partial \Omega$ and $x_{0} \in \partial \Omega$ as in the statement of the lemma. We let $\mathcal{T}$ be a chart at $x_{0}$ as in (27) (in particular $D_{0} \mathcal{T}=\mathbb{I}_{\mathbb{R}^{n}}$ ) and we set $x_{i}^{\prime} \in \mathbb{R}^{n}$ such that $x_{i}=\mathcal{T}\left(0, x_{i}^{\prime}\right)$. In particular, $\lim _{i \rightarrow+\infty} x_{i}^{\prime}=0$. For any $X, Y \in \overline{\mathbb{R}_{-}^{n}}, X \neq Y$, we define

G_{i}(X, Y):=r_{i}^{n-2} G\left(\mathcal{T}\left(\left(0, x_{i}^{\prime}\right)+r_{i} X\right), \mathcal{T}\left(\left(0, x_{i}^{\prime}\right)+r_{i} Y\right)\right)

for all $i \in \mathbb{N}$. Here again, provided $X, Y$ remain in a given compact set, the definition of $G_{i}$ makes sense for large $i$. Equation (205) then rewrites

\end{equation*}

where

\hat{\theta}_{i}(Y):=\frac{\gamma}{\left|\frac{\mathcal{T}\left(\left(0, x_{i}^{\prime}\right)+r_{i} Y\right)}{r_{i}}\right|^{2}}+r_{i}^{2} h\left(\mathcal{T}\left(\left(0, x_{i}^{\prime}\right)+r_{i} Y\right)\right)
$$

and $g_{i}=\mathcal{T}^{\star} \operatorname{Eucl}\left(\left(0, x_{i}^{\prime}\right)+r_{i} \cdot\right)$ is the pull-back of the Euclidean metric. In particular, since $D_{0} \mathcal{T}=\mathbb{I}_{\mathbb{R}^{n}}$, we get that $g_{i} \rightarrow$ Eucl in $C_{l o c}^{2}\left(\mathbb{R}^{n}\right)$. Since $r_{i}=o\left(\left|x_{i}\right|\right)$, we get that $r_{i}=o\left(\left|x_{i}^{\prime}\right|\right)$ as $i \rightarrow+\infty$, and, using again that $D_{0} \mathcal{T}=\mathbb{I}_{\mathbb{R}^{n}}$, we get that $\hat{\theta}_{i} \rightarrow 0$ uniformly in $B_{R}(0) \cap \mathbb{R}_{-}^{n}$. The pointwise control (239) rewrite $G_{i}(X, Y) \leq$ $c|X-Y|^{2-n}$ for all $X, Y \in \mathbb{R}_{-}^{n}, X \neq Y$. With the same arguments as above, we get that for any $X \in \overline{\mathbb{R}_{-}^{n}}$, there exists $G_{\infty}(X, \cdot) \in C^{2}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\{X\}\right)$ such that

G_{\infty}(X, \cdot) \equiv 0 & \text { 伿 }\end{cases}
\end{aligned}
$$

and

\varphi(X)=\int_{\mathbb{R}_{-}^{n}} G_{\infty}(X, \cdot)(-\Delta \varphi) d Y \text { for all } \varphi \in C_{c}^{\infty}\left(\mathbb{R}_{-}^{n}\right)
$$

with $0 \leq G_{\infty}(X, Y) \leq c|X-Y|^{2-n}$ for all $X, Y \in \mathbb{R}_{-}^{n}, X \neq Y$. Define

\Gamma_{\mathbb{R}_{-}^{n}}(X, Y)=\frac{1}{(n-2) \omega_{n-1}}\left(|X-Y|^{2-n}-\left|X-Y^{*}\right|^{2-n}\right) .
$$

As one checks (see for instance [30]), $\Gamma_{\mathbb{R}_{-}^{n}}$ satisfies the same properties as $G_{\infty}$. We set $f:=G_{\infty}(X, \cdot)-\Gamma_{\mathbb{R}_{-}^{n}}(X, \cdot)$. As one checks, $f \in C^{\infty}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\{X\}\right),-\Delta f=0$ in the distribution sense in $\mathbb{R}_{-}^{n},|f| \leq C|X-\cdot|^{2-n}$ in $\mathbb{R}_{-}^{n} \backslash\{X\}$ and $f_{\partial \mathbb{R}_{-}^{n}}=0$. Hypoellipticity yields $f \in C^{\infty}\left(\overline{\mathbb{R}_{-}^{n}}\right)$. Multiplying $-\Delta f$ by $f$ and integrating by parts, we get that $f \equiv 0$, and then $G_{\infty}(X, \cdot)=\Gamma_{\mathbb{R}_{-}^{n}}(X, \cdot)$. As above, this proves the convergence without any extraction. The convergence in $C_{l o c}^{2}\left(\left(\overline{\mathbb{R}_{-}^{n}}\right)^{2} \backslash \operatorname{Diag}\left(\overline{\mathbb{R}_{-}^{n}}\right)\right)$ follows from the symmetry of $G$ and elliptic theory.
Proof of Lemma 6: Here again, the proof is similar to the two preceding proofs. We let $\left(r_{i}\right)_{i} \in(0,+\infty)$ such that $\lim _{i \rightarrow+\infty} r_{i}=0$. We let $\mathcal{T}$ be a chart at 0 as in (27) (in particular $D_{0} \mathcal{T}=\mathbb{I}_{\mathbb{R}^{n}}$ ). For any $X, Y \in \overline{\mathbb{R}_{-}^{n}} \backslash\{0\}$, we define

G_{i}(X, Y):=r_{i}^{n-2} G\left(\mathcal{T}\left(r_{i} X\right), \mathcal{T}\left(r_{i} Y\right)\right)

for all $i \in \mathbb{N}$. Equation (205) rewrites

$$

with $G_{i}(X, \cdot) \equiv 0$ on $B_{R}(0) \cap \partial \mathbb{R}_{-}^{n}$, where $g_{i}=\mathcal{T}^{\star} \operatorname{Eucl}\left(r_{i} \cdot\right)$ is the pull-back of the Euclidean metric. In particular, since $D_{0} \mathcal{T}=\mathbb{I}_{\mathbb{R}^{n}}$, we get that $g_{i} \rightarrow$ Eucl in $C_{l o c}^{2}\left(\mathbb{R}^{n}\right)$. The pointwise control (239) writes

It then follows from elliptic theory that $G_{i}(X, \cdot) \rightarrow G_{\infty}(X, \cdot)$ in $C_{l o c}^{2}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\{0, X\}\right)$. In particular, $G_{\infty}(X, \cdot)$ vanishes on $\partial \mathbb{R}_{-}^{n} \backslash\{0\}$ and

Moreover, passing to the limit in Green's representation formula, we get that

Since $G(x, \cdot)$ is locally in $H_{1,0}^{2}(\Omega)$ (see (b) in Theorem 8), we get that $\left(\eta G_{i}(X, \cdot)\right)_{i}$ is uniformly bounded in $H_{1,0}^{2}\left(\mathbb{R}_{-}^{n}\right)$ for all $\eta \in C_{c}^{\infty}\left(\mathbb{R}^{n} \backslash\{X\}\right)$. Up to another extraction, we get weak convergence in $H_{1,0}^{2}\left(\mathbb{R}_{-}^{n}\right)$, and then $\eta G_{\infty}(X, \cdot) \in H_{1,0}^{2}\left(\mathbb{R}_{-}^{n}\right)$ for all $\eta \in C_{c}^{\infty}\left(\mathbb{R}^{n} \backslash\{X\}\right)$. It then follows from Theorem 9 and (243) that $G_{\infty}(X, \cdot)=\mathcal{G}_{X}$ is the unique Green's function of $-\Delta-\gamma|x|^{-2}$ on $\mathbb{R}_{-}^{n}$ with Dirichlet boundary condition. Here again, the convergence in $C^{2}$ follows from elliptic theory.
14.4. A lower bound for the Green's function. We let $\Omega, \gamma, h$ be as in Theorem 8. We let $G$ be the Green's function for $-\Delta-\left(\gamma|x|^{-2}+h\right)$ on $\Omega$ with Dirichlet boundary condition. We let $\left(x_{i}\right),\left(y_{i}\right)_{i \in \mathbb{N}}$ be such that $x_{i}, y_{i} \in \Omega$ and $x_{i} \neq y_{i}$ for all $i \in \mathbb{N}$. We also assume that there exists $x_{\infty}, y_{\infty} \in \bar{\Omega}$ such that

\lim _{i \rightarrow+\infty} x_{i}=x_{\infty} \text { and } \lim _{i \rightarrow+\infty} y_{i}=y_{\infty}
$$

and that there exists $c_{1}, c_{2}$ such that

\lim _{i \rightarrow+\infty} \frac{G\left(x_{i}, y_{i}\right)}{H\left(x_{i}, y_{i}\right)}=c_{1} \in[0,+\infty] \text { and } \lim _{i \rightarrow+\infty} \frac{\left|\nabla G_{x_{i}}\left(y_{i}\right)\right|}{\Gamma\left(x_{i}, y_{i}\right)}=c_{2} \in[0,+\infty]
$$

where $H(x, y)$ is defined in (208) and

\Gamma(x, y):=\left(\frac{\max \{|x|,|y|\}}{\min \{|x|,|y|\}}\right)^{\beta_{-}(\gamma)}|x-y|^{1-n} \min \left\{1, \frac{d(x, \partial \Omega)}{|x-y|}\right\}

for $x, y \in \Omega, x \neq y$. Note that $c_{1}<+\infty$ by (239). We claim that

The lower bound in (207) and the upper bound in (209) both follow from (244).
This section is devoted to proving (244). We distinguish several cases:
Case 1: $x_{\infty} \neq y_{\infty}, x_{\infty}, y_{\infty} \in \Omega$. As one checks, we then have that

\lim _{i \rightarrow+\infty} G\left(x_{i}, y_{i}\right)=G\left(x_{\infty}, y_{\infty}\right)>0
$$

Therefore, we get that $c_{1} \in(0,+\infty)$. Concerning the gradient, $\lim _{i \rightarrow+\infty}\left|\nabla G_{x_{i}}\left(y_{i}\right)\right|=$ $\left|\nabla G_{x_{\infty}}\left(y_{\infty}\right)\right| \geq 0$ and this yields $c_{2}<+\infty$. This proves (244) in Case 1.
Case 2: $x_{\infty} \in \Omega$ and $y_{\infty} \in \partial \Omega \backslash\{0\}$. Since $x_{\infty}, y_{\infty}$ are distinct and far from 0 , we have that $G\left(x_{i}, y_{i}\right)=d\left(y_{i}, \partial \Omega\right)\left(-\partial_{\nu} G_{x_{\infty}}\left(y_{\infty}\right)+o(1)\right)$ as $i \rightarrow+\infty$, where $\partial_{\nu} G_{x_{\infty}}\left(y_{\infty}\right)$ is the normal derivative of $G_{x_{\infty}}>0$ at the boundary point $y_{\infty}$. Hopf's Lemma then yields $\partial_{\nu} G_{x_{\infty}}\left(y_{\infty}\right)<0$. As one checks, we have that $H\left(x_{i}, y_{i}\right)=(c+o(1)) d\left(y_{i}, \partial \Omega\right)$ as $i \rightarrow+\infty$. This then yields $0<c_{1}<+\infty$. Concerning the gradient, we get that $\lim _{i \rightarrow+\infty}\left|\nabla G_{x_{i}}\left(y_{i}\right)\right|=\left|\nabla G_{x_{\infty}}\left(y_{\infty}\right)\right| \geq 0$ and $\lim _{i \rightarrow+\infty} \Gamma\left(x_{i}, y_{i}\right) \in(0,+\infty)$, which yields $c_{2}<+\infty$. This proves (244) in Case 2.
Case 3: $x_{\infty} \in \Omega$ and $y_{\infty}=0 \in \partial \Omega$. It follows from Case 2 above that there exists $c>0$ such that $G_{x_{i}}(y) \geq c d(y, \partial \Omega)|y|^{-\beta_{-}(\gamma)}$ for all $y \in \partial\left(\Omega \cap B_{r_{0}}(0)\right)$. We take the subsolution $\underline{u}_{\beta_{-}(\gamma)}$ defined in Proposition 10. With (224), there exists $c^{\prime}>0$ such that $G_{x_{i}}(y) \geq c_{1} \underline{u}_{\beta_{-}(\gamma)}(y)$ for all $y \in \partial\left(\Omega \cap B_{r_{0}}(0)\right)$. Since $G_{x_{i}}$ is locally in $H_{1,0}^{2}$ around 0 , the comparison principle and (224) yields $G_{x_{i}}(y) \geq c " d(y, \partial \Omega)|y|^{-\beta_{-}(\gamma)}$ for all $y \in \Omega \cap B_{r_{0}}(0)$. This yields $c_{1}>0$.

We deal with the gradient. We let $\mathcal{T}$ be a chart at 0 as in (27) and we define

G_{i}(y):=r_{i}^{\beta_{-}(\gamma)-1} G_{x_{i}}\left(\mathcal{T}\left(r_{i} y\right)\right) \text { for } y \in \mathbb{R}_{-}^{n} \cap B_{2}(0)
$$

with $r_{i} \rightarrow 0$. It follows from (239) that $G_{i}(y) \leq C\left|y_{1}\right| \cdot|y|^{-\beta_{-}(\gamma)}$ for all $y \in$ $\mathbb{R}_{-}^{n} \cap B_{2}(0)$. It follows from (205) that $-\Delta_{g_{i}} G_{i}-\left(\gamma|\cdot|^{2}+o(1)\right) G_{i}=0$ in $\mathbb{R}_{-}^{n} \cap B_{2}(0)$ where $g_{i}:=\mathcal{T}^{\star} \operatorname{Eucl}\left(r_{i} \cdot\right)$ and $o(1) \rightarrow 0$ in $L_{l o c}^{\infty}\left(\mathbb{R}^{n}\right)$. Elliptic regularity then yields $\left|\nabla G_{i}(y)\right| \leq C$ for $y \in \mathbb{R}_{-}^{n} \cap B_{3 / 2}(0)$. We now let $r_{i}:=\left|\tilde{y}_{i}\right|$ where $y_{i}:=\mathcal{T}\left(\tilde{y}_{i}\right)$, so that $r_{i} \rightarrow 0$. We then have that $\left|\nabla G_{i}\left(\tilde{y}_{i} / r_{i}\right)\right| \leq C$, which rewrites $\left|\nabla G_{x_{i}}\left(y_{i}\right)\right| \leq$ $C\left|y_{i}\right|^{-\beta-(\gamma)}$. By estimating $\Gamma\left(x_{i}, y_{i}\right)$, we then get that $c_{2}<+\infty$. This proves (244) in Case 3.

Case 4: $x_{\infty} \neq y_{\infty}, x_{\infty}, y_{\infty} \in \partial \Omega \backslash\{0\}$. Since $x_{\infty}, y_{\infty}$ are distinct and far from 0 , we have that $G\left(x_{i}, y_{i}\right)=d\left(y_{i}, \partial \Omega\right) d\left(x_{i}, \partial \Omega\right)\left(\partial_{\nu_{x}} \partial_{\nu_{y}} G_{x_{\infty}}\left(y_{\infty}\right)+o(1)\right)$ as $i \rightarrow+\infty$, where $\partial_{\nu_{x}}$ is the normal derivative along the first coordinate, and $\partial_{\nu_{y}}$ is the normal derivative along the second coordinate. Since $y \mapsto G_{x}(y)$ is positive for $x, y \in \Omega$, $x \neq y$, and solves (205), Hopf's maximum principle yields $-\partial_{\nu_{y}} G\left(x, y_{\infty}\right)>0$ for $x \in \Omega$. Moreover, it follows from the symmetry of $G$ that $-\partial_{\nu_{y}} G\left(x, y_{\infty}\right)>0$ solves also (205). Another application of Hopf's principle yields $\partial_{\nu_{x}} \partial_{\nu_{y}} G_{x_{\infty}}\left(y_{\infty}\right)>0$. Estimating independently $H\left(x_{i}, y_{i}\right)$, we get that $0<c_{1}<+\infty$.
We deal with the gradient. We have that $\left|\nabla_{y} G_{x_{i}}\left(y_{i}\right)\right|=\left|\nabla_{y}\left(G_{x_{i}}-G_{\tilde{x_{i}}}\right)\left(y_{i}\right)\right|$ where $\tilde{x}_{i} \in \partial \Omega$ is the projection of $x_{i}$ on $\partial \Omega$. The $C^{2}$-control then yields $\left|\nabla_{y} G_{x_{i}}\left(y_{i}\right)\right| \leq$ $C d\left(x_{i}, \partial \Omega\right)$. Estimating independently $\Gamma\left(x_{i}, y_{i}\right)$, we get that $c_{2}<+\infty$. This proves (244) in Case 4.

Case 5: $x_{\infty} \neq y_{\infty}, x_{\infty} \in \partial \Omega \backslash\{0\}$ and $y_{\infty}=0$. It follows from Cases 2 and 4 that $G_{x_{i}}(y) \geq C d\left(x_{i}, \partial \Omega\right) d\left(y_{i}, \partial \Omega\right)$ for all $y \in \partial\left(B_{\left|x_{\infty}\right| / 2}(0) \cap \Omega\right)$. Using a subsolution as in Case 3, we get that $G_{x_{i}}(y) \geq c d\left(x_{i}, \partial \Omega\right) d(y, \partial \Omega)|y|^{-\beta_{-}(\gamma)}$ for all $y \in \partial\left(B_{\left|x_{\infty}\right| / 2}(0) \cap \Omega\right)$. This yields $0<c_{1}$.
For the gradient estimate, we choose a chart $\mathcal{T}$ around $y_{\infty}=0$ as in (27), and we let $r_{i}:=\left|\tilde{y}_{i}\right| \rightarrow 0$ where $y_{i}=\mathcal{T}\left(\tilde{y}_{i}\right)$ we define $G_{i}(y):=r_{i}^{\beta_{-}(\gamma)-1} G_{x_{i}}\left(\mathcal{T}\left(r_{i} y\right)\right) / d\left(x_{i}, \partial \Omega\right)$ for $y \in \mathbb{R}_{-}^{n} \cap B_{2}(0)$ where $r_{i} \rightarrow 0$. The pointwise control (239) and equation (205) yields the convergence of $\left(G_{i}\right)$ in $C_{l o c}^{1}\left(\overline{\mathbb{R}_{-}^{n}} \cap B_{2}(0) \backslash\{0\}\right)$ as $i \rightarrow+\infty$. The boundedness of $\left|\nabla G_{i}\right|$ yields $c_{2}<+\infty$. This proves (244) in Case 5.
Since $G$ is symmetric, it follows from Cases 1 to 5 that (244) holds when $x_{\infty} \neq y_{\infty}$.
We now deal with the case $x_{\infty}=y_{\infty}$, which rewrites $\lim _{i \rightarrow+\infty}\left|x_{i}-y_{i}\right|=0$. Via a rescaling, we are essentially back to the case $x_{\infty} \neq y_{\infty}$ via the convergence Theorems 4, 5 and 6.
Case 6: $\left|x_{i}-y_{i}\right|=o\left(d\left(x_{i}, \partial \Omega\right)\right)$ as $i \rightarrow+\infty$. We set $r_{i}:=\left|x_{i}-y_{i}\right| \rightarrow 0$ as $i \rightarrow+\infty$ and we define

G_{i}(Y):=r_{i}^{n-2} G\left(x_{i}, x_{i}+r_{i} Y\right) \text { for } Y \in \frac{\Omega-x_{i}}{r_{i}} \backslash\{0\}

It follows from Theorem 4 that $G_{i} \rightarrow c_{n}|\cdot|^{2-n}$ in $C_{l o c}^{2}\left(\mathbb{R}^{n} \backslash\{0\}\right)$ as $i \rightarrow+\infty$, with $c_{n}:=\left((n-2) \omega_{n-1}\right)^{-1}$. We define $Y_{i}:=\frac{y_{i}-x_{i}}{\left|y_{i}-x_{i}\right|}$, and we then get that $\mid y_{i}-$ $\left.x_{i}\right|^{n-2} G\left(x_{i}, y_{i}\right)=G_{i}\left(Y_{i}\right) \rightarrow c_{n}$ as $i \rightarrow+\infty$. Estimating $H\left(x_{i}, y_{i}\right)$ (and noting that $\left.d\left(x_{i}, \partial \Omega\right) \leq\left|x_{i}-0\right|=\left|x_{i}\right|\right)$, we get that $0<c_{1}<+\infty$.
The convergence of the gradient yields $\left|\nabla G_{i}\left(Y_{i}\right)\right| \leq C$ for all $i$. With the original function $G$ and points $x_{i}, y_{i}$, this yields $c_{2}<+\infty$. This proves (244) in Case 6.

Case 7: $d\left(x_{i}, \partial \Omega\right)=O\left(\left|x_{i}-y_{i}\right|\right)$ and $\left|x_{i}-y_{i}\right|=o\left(\left|x_{i}\right|\right)$ as $i \rightarrow+\infty$. Then $\lim _{i \rightarrow+\infty} x_{i}=x_{\infty} \in \partial \Omega$. We let $\mathcal{T}$ be a chart at $x_{\infty}$ as in (27), in particular $D_{0} \mathcal{T}=\mathbb{I}_{\mathbb{R}^{n}}$. We let $x_{i}=\mathcal{T}\left(x_{i, 1}, x_{i}^{\prime}\right)$ and $y_{i}=\mathcal{T}\left(y_{i, 1}, y_{i}^{\prime}\right)$ where $\left(x_{i, 1}, x_{i}^{\prime}\right),\left(y_{i, 1}, y_{i}^{\prime}\right) \in$ $(-\infty, 0) \times \mathbb{R}^{n-1}$ are going to 0 as $i \rightarrow+\infty$. In particular $d\left(x_{i}, \partial \Omega\right)=(1+o(1))\left|x_{i, 1}\right|$ and $d\left(y_{i}, \partial \Omega\right)=(1+o(1))\left|y_{i, 1}\right|$ as $i \rightarrow+\infty$. We define $r_{i}:=\left|\left(y_{i, 1}, y_{i}^{\prime}\right)-\left(x_{i, 1}, x_{i}^{\prime}\right)\right|$. In particular $r_{i}=(1+o(1))\left|x_{i}-y_{i}\right|$ as $i \rightarrow+\infty$. The hypothesis of Case 7 rewrite $x_{i, 1}=O\left(r_{i}\right)$ and $r_{i}=o\left(\left|\left(x_{i, 1}, x_{i}^{\prime}\right)\right|\right)$. Consequently, we have that $y_{i, 1}=O\left(r_{i}\right)$ and $r_{i}=o\left(\left|x_{i}^{\prime}\right|\right)$ as $i \rightarrow+\infty$. We define

G_{i}(X, Y):=r_{i}^{n-2} G\left(\mathcal{T}\left(\left(0, x_{i}^{\prime}\right)+r_{i} X\right), \mathcal{T}\left(\left(0, x_{i}^{\prime}\right)+r_{i} Y\right)\right)

for $X, Y \in \mathbb{R}_{-}^{n}$ such that $X \neq Y$. It follows from Theorem 5 that

\lim _{i \rightarrow+\infty} G_{i}(X, Y)=c_{n}\left(|X-Y|^{2-n}-\left|X-Y^{*}\right|^{2-n}\right):=\Psi(X, Y)
$$

for all $X, Y \in \overline{\mathbb{R}_{-}^{n}}, X \neq Y$, and this convergence holds in $C_{l o c}^{2}$. We define $X_{i}:=$ $\left(r_{i}^{-1} x_{i, 1}, 0\right)$ and $Y_{i}:=\left(r_{i}^{-1} y_{i, 1}, r_{i}^{-1}\left(y_{i}^{\prime}-x_{i}^{\prime}\right)\right)$ : the definition of $r_{i}$ yields $X_{i} \rightarrow X_{\infty} \in$ $\overline{\mathbb{R}_{-}^{n}}$ and $Y_{i} \rightarrow Y_{\infty} \in \overline{\mathbb{R}_{-}^{n}}$ as $i \rightarrow+\infty$. Therefore, we get that

Case 7.1: $X_{\infty, 1} \neq 0$ and $Y_{\infty, 1} \neq 0$. We then get that $\lim _{i \rightarrow+\infty}\left|x_{i}-y_{i}\right|^{n-2} G\left(x_{i}, y_{i}\right)=$ $\Psi\left(X_{\infty}, Y_{\infty}\right)>0$. Moreover, it follows from (245) that $d\left(x_{i}, \partial \Omega\right) d\left(y_{i}, \partial \Omega\right)=(c+$ $o(1))\left|x_{i}-y_{i}\right|^{2}$ as $i \rightarrow+\infty$ for some $c>0$. Since $\left|x_{i}\right|=(1+o(1))\left|y_{i}\right|$ as $i \rightarrow+\infty$ (this follows from the assumption of Case 7), we get that $\lim _{i \rightarrow+\infty}\left|x_{i}-y_{i}\right|^{n-2} H\left(x_{i}, y_{i}\right) \in$ $(0,+\infty)$. Then $0<c_{1}<+\infty$.
Case 7.2: $X_{\infty, 1} \neq 0$ and $Y_{\infty, 1}=0$. Then $Y_{i, 1} \rightarrow 0$ as $i \rightarrow+\infty$, and then, there exists $\left(\tau_{i}\right)_{i} \in(0,1)$ such that $G_{i}\left(X_{i}, Y_{i}\right)=Y_{i, 1} \partial_{Y_{1}} G_{i}\left(X_{i},\left(\tau_{i} Y_{i, 1}, Y_{i}^{\prime}\right)\right)$. Letting $i \rightarrow+\infty$ and using the convergence of $G_{i}$ in $C^{1}$, we get that

& =\frac{d\left(y_{i}, \partial \Omega\right)}{\left|x_{i}-y_{i}\right|}\left(-\partial_{Y_{1}} \Psi\left(X_{\infty}, Y_{\infty}\right)+o(1)\right)
\end{aligned}
$$

as $i \rightarrow+\infty$. As one checks, $\partial_{Y_{1}} \Psi\left(X_{\infty}, Y_{\infty}\right)<0$. Arguing as in Case 7.1, we get that $0<c_{1}<+\infty$.
Case 7.3: $X_{\infty, 1}=Y_{\infty, 1}=0$. As in Case 7.2, there exists $\left(\tau_{i}\right)_{i},\left(\sigma_{i}\right)_{i} \in(0,1)$ such that $G_{i}\left(X_{i}, Y_{i}\right)=Y_{i, 1} X_{i, 1} \partial_{Y_{1}} \partial_{X_{1}} G_{i}\left(\left(\sigma_{i} X_{i, 1}, X_{i}^{\prime}\right) X_{i},\left(\tau_{i} Y_{i, 1}, Y_{i}^{\prime}\right)\right)$. We conclude as above, noting that $\partial_{Y_{1}} \partial_{X_{1}} \Psi\left(X_{\infty}, Y_{\infty}\right)>0$. Then $0<c_{1}<+\infty$.

The gradient estimate is proved as in Cases 1 to 6 . This proves (244) in Case 7.
Case 8: $d\left(x_{i}, \partial \Omega\right)=O\left(\left|x_{i}-y_{i}\right|\right),\left|x_{i}\right|=O\left(\left|x_{i}-y_{i}\right|\right)$ and $\left|y_{i}\right|=O\left(\left|x_{i}-y_{i}\right|\right)$ as $i \rightarrow+\infty$. In particular, $x_{\infty}=y_{\infty}=0$. We take a chart at 0 as in Case 7, and we define $\left(x_{i, 1}, x_{i}^{\prime}\right),\left(y_{i, 1}, y_{i}^{\prime}\right)$ similarly. We define $r_{i}:=\left|\left(y_{i, 1}, y_{i}^{\prime}\right)-\left(x_{i, 1}, x_{i}^{\prime}\right)\right|=$ $(1+o(1))\left|x_{i}-y_{i}\right|$ as $i \rightarrow+\infty$. We define

G_{i}(X, Y):=r_{i}^{n-2} G\left(\mathcal{T}\left(r_{i} X\right), \mathcal{T}\left(r_{i} Y\right)\right)
$$

for $X, Y \in \mathbb{R}_{-}^{n}$. It follows from Theorem 6 that $G_{i} \rightarrow \mathcal{G}$ in $C_{l o c}^{2}\left(\left(\overline{\mathbb{R}_{-}^{n}} \backslash\{0\}\right)^{2} \backslash\right.$ $\operatorname{Diag}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\{0\}\right)$ ), where $\mathcal{G}$ is the Green's function for $-\Delta-\gamma|\cdot|^{-2}$ in $\mathbb{R}_{-}^{n}$. Then

\left|x_{i}-y_{i}\right|^{n-2} G\left(x_{i}, y_{i}\right)=(1+o(1)) G_{i}\left(X_{i}, Y_{i}\right)=\mathcal{G}\left(X_{\infty}, Y_{\infty}\right)+o(1)
$$

as $i \rightarrow+\infty$.
Case 8.1: We assume that $X_{\infty, 1} \neq 0$ and $Y_{\infty, 1} \neq 0$. Then we get $0<c_{1}<+\infty$ as in Case 7.1.
Case 8.2: We assume that $X_{\infty} \in \mathbb{R}_{-}^{n}$ and $Y_{\infty} \in \partial \mathbb{R}_{-}^{n} \backslash\{0\}$ or $X_{\infty}, Y_{\infty} \in \partial \mathbb{R}_{-}^{n} \backslash$ $\{0\}$. Then we argue as in Cases 7.2 and 7.3 to get $0<c_{1}<+\infty$ provided $\left\{\partial_{Y_{1}} \mathcal{G}\left(X_{\infty}, Y_{\infty}\right)<0\right.$ if $X_{\infty} \in \mathbb{R}_{-}^{n}$ and $\left.Y_{\infty} \in \partial \mathbb{R}_{-}^{n}\right\}$ and $\left\{\partial_{Y_{1}} \partial_{X_{1}} \mathcal{G}\left(X_{\infty}, Y_{\infty}\right)>\right.$ 0 if $\left.X_{\infty}, Y_{\infty} \in \partial \mathbb{R}_{-}^{n}\right\}$. So we are just left with proving these two inequalities.

We assume that $X_{\infty} \in \mathbb{R}_{-}^{n}$. It follows from Theorem 9 below that $\mathcal{G}\left(X_{\infty}, \cdot\right)>0$ is a solution to $\left(-\Delta-\gamma|\cdot|^{-2}\right) \mathcal{G}\left(X_{\infty}, \cdot\right)=0$ in $\mathbb{R}_{-}^{n}-\left\{X_{\infty}\right\}$, vanishing on $\partial \mathbb{R}_{-}^{n} \backslash\{0\}$. Hopf's maximum principle then yields $-\partial_{Y_{1}} \mathcal{G}\left(X_{\infty}, Y_{\infty}\right)>0$ for $Y_{\infty} \in \partial \mathbb{R}_{-}^{n} \backslash\{0\}$.
We fix $Y_{\infty} \in \partial \mathbb{R}_{-}^{n} \backslash\{0\}$. For $X \in \mathbb{R}_{-}^{n}$, we then define $H(X):=-\partial_{Y_{1}} \mathcal{G}\left(X, Y_{\infty}\right)>0$ by the above argument. Moreover, $\left(-\Delta-\gamma|\cdot|^{-2}\right) H=0$ in $\mathbb{R}_{-}^{n}$, vanishing on $\partial \mathbb{R}_{-}^{n} \backslash$ $\left\{0, Y_{\infty}\right\}$. Hopf's maximum principle yields $-\partial_{X_{1}} H\left(X_{\infty}\right)=\partial_{Y_{1}} \partial_{X_{1}} \mathcal{G}\left(X_{\infty}, Y_{\infty}\right)>0$ for $X_{\infty}, Y_{\infty} \in \partial \mathbb{R}_{-}^{n} \backslash\{0\}$

Case 8.3: we assume that $X_{\infty}=0$ or $Y_{\infty}=0$. Since $\left|X_{\infty}-Y_{\infty}\right|=1$, without loss of generality, we can assume that $X_{\infty} \neq 0$. It follows from Cases 8.1 and 8.2 that there exists $C>0$ such that

Arguing as in Case 3, it then follows from the comparison principle that (246) holds for $y \in B_{\left|x_{i}\right| / 2}(0) \cap \Omega$. Since $\left|y_{i}\right|=o\left(\left|x_{i}\right|\right)$, we then get that (246) holds with $y:=y_{i}$. Estimating $H\left(x_{i}, y_{i}\right)$, we then get that $0<c_{1}<+\infty$.

The gradient estimate is proved as in Cases 1 to 6 . This proves (244) in Case 8.
Since $G$ is symmetric, it follows from Cases 7 and 8 that (244) holds when $x_{\infty}=y_{\infty}$.
In conclusion, we get that (244) holds, which proves the initial claim. As noted previously, both the lower bound in (207) and the upper bound in (209) follow from these results.
We are now left with proving (210). We let $\left(\tilde{x}_{i}\right)_{i},\left(\tilde{y}_{i}\right)_{i} \in \Omega$ be such that

It follows from (251), (252) and standard elliptic theory that there exists $G \in$ $C^{2}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\{0\}\right)$ such that, up to a subsequence,

Since $\tau_{i, 1} \neq 0$ for all $i \in \mathbb{N}$, it follows form (255) that $\lambda=l$.
Therefore, in both cases, we have proved that $\lambda=l$. It follows from this uniqueness that the convergence of $G_{i}$ holds with no extraction.
We now prove (250). We let $\left(z_{i}\right)_{i} \in \mathbb{R}_{-}^{n} \backslash\{0\}$ be such that $z_{i} \rightarrow z_{\infty} \in \overline{\mathbb{R}_{-}^{n}} \backslash\{0\}$. Then $G_{i}\left(z_{i}\right) \rightarrow G\left(z_{\infty}\right)$ as $i \rightarrow+\infty$. Therefore, if $z_{\infty, 1} \neq 0$, we get that $G_{i}\left(z_{i}\right)=$ $(1+o(1)) G\left(z_{i}\right)$ as $i \rightarrow+\infty$. We now assume that $z_{\infty, 1}=0$, that is $z_{i, 1} \rightarrow 0$ as $i \rightarrow+\infty$. We use the $C^{1}$-convergence of $\left(G_{i}\right)$ and argue as in Case 2 above to get that $\lim _{i \rightarrow+\infty}\left|z_{i, 1}\right|^{-1} G_{i}\left(z_{i}\right)=-\partial_{1} G\left(z_{\infty}\right) \neq 0$. As one checks, this yields also $G_{i}\left(z_{i}\right)=(1+o(1)) G\left(z_{i}\right)$ as $i \rightarrow+\infty$. As noticed above, this proves (249) and ends Step P14.

G_{0}\left(x_{i}, y_{i}\right)=\left(L_{\gamma, \Omega}+o(1)\right) \frac{d\left(x_{i}, \partial \Omega\right)}{\left|x_{i}\right|^{\beta_{+}+(\gamma)}} \frac{d\left(y_{i}, \partial \Omega\right)}{\left|y_{i}\right|^{\beta_{-}(\gamma)}} \tag{274}
\end{equation*}
$$

as $i \rightarrow+\infty$. We fix a sequence $\left(x_{i}\right)_{i} \in \Omega$ such that $x_{i} \rightarrow 0$ and $d\left(x_{i}, \partial \Omega\right) \geq\left|x_{i}\right| / 2$ as $i \rightarrow+\infty$. In the distribution sense, we have that
$-\Delta\left(G_{h_{\varphi(i)}}\left(x_{i}, \cdot\right)-G_{0}\left(x_{i}, \cdot\right)\right)+h_{\varphi(i)}\left(G_{h_{\varphi(i)}}\left(x_{i}, \cdot\right)-G_{0}\left(x_{i}, \cdot\right)\right)=\left(0-h_{\varphi(i)}\right) G_{0}\left(x_{i}, \cdot\right)$ in $\Omega$ in the distribution sense and $G_{h_{\varphi(i)}}\left(x_{i}, \cdot\right)-G_{0}\left(x_{i}, \cdot\right)=0$ on $\partial \Omega$. It follows from (207) that for any $1<p<\frac{n}{n-2}$, we have that $\left\|G_{0}\left(x_{i}, \cdot\right)\right\|_{p} \leq C(p)$ for all $i \in \mathbb{N}$. It then follows from elliptic theory that $G_{h_{\varphi(i)}}\left(x_{i}, \cdot\right)-G_{h}\left(x_{i}, \cdot\right) \in W^{2, p}(\Omega)$ and that

$$
\left\|G_{h_{\varphi(i)}}\left(x_{i}, \cdot\right)-G_{0}\left(x_{i}, \cdot\right)\right\|_{W^{2, p}} \leq C\left\|h_{\varphi(i)}\right\|_{\infty}
$$

For $1<p<\min \{n / 2 ; n /(n-2)\}$, we define $q:=\frac{n p}{n-2 p}$. Sobolev embeddings then yield

$$
\left\|G_{h_{\varphi(i)}}\left(x_{i}, \cdot\right)-G_{0}\left(x_{i}, \cdot\right)\right\|_{L^{q}(\Omega)} \leq C\left\|h_{\varphi(i)}\right\|_{\infty}
$$

We let $\left(\epsilon_{i}\right)_{>} 0$ such that $\epsilon_{i} \rightarrow 0$ as $i \rightarrow+\infty$. We define $\alpha_{i}:=\epsilon_{i}\left|x_{i}\right|$ so that $\alpha_{i}=o\left(\left|x_{i}\right|\right)$ as $i \rightarrow+\infty$. We have that

$$
\int_{B_{\alpha_{i}}(0)}\left|G_{h_{\varphi(i)}}\left(x_{i}, y\right)-G_{0}\left(x_{i}, y\right)\right|^{q} d y \leq C\left\|h_{\varphi(i)}\right\|_{\infty}^{q}
$$

It then follows from (273), (274) and the boundedness of $\left(h_{i}\right)$ in $C^{0}$ that

$$
\int_{B_{\alpha_{i}}(0)}\left|\left(l-L_{\gamma, \Omega}+o(1)\right) \frac{d\left(x_{i}, \partial \Omega\right)}{\left|x_{i}\right|^{\beta_{+}(\gamma)}} \frac{d(y, \partial \Omega)}{|y|^{\beta_{-}(\gamma)}}\right|^{q} d y \leq C .
$$

We assume by contradiction that $l \neq L_{\gamma, \Omega}$, so that

$$
\frac{d\left(x_{i}, \partial \Omega\right)}{\left|x_{i}\right|^{\beta_{+}(\gamma)}}\left(\int_{B_{\alpha_{i}}(0)}\left|\frac{d(y, \partial \Omega)}{|y|^{\beta_{-}(\gamma)}}\right|^{q} d y\right)^{1 / q} \leq C
$$

If $n \leq q\left(1-\beta_{-}(\gamma)\right)$, then the integral is infinite. This is a contradiction. Therefore $n>q\left(1-\beta_{-}(\gamma)\right)$. Estimating the integral and using that $\left|x_{i}\right| \leq 2 d\left(x_{i}, \partial \Omega\right)$, we get that

\left|x_{i}\right|^{1-\beta_{+}(\gamma)} \alpha_{i}^{1-\beta_{-}(\gamma)+\frac{n}{q}} \leq C
$$

With $\alpha_{i}=\epsilon_{i}|x|_{i}, \beta_{-}(\gamma)+\beta_{+}(\gamma)=n$ and the definition of $q$, we get that

\left|x_{i}\right|^{-n\left(1-\frac{1}{p}\right)} \epsilon_{i}^{1-\beta_{-}(\gamma)+\frac{n}{q}} \leq C
$$

Since $\left|x_{i}\right| \rightarrow 0$, with a suitable choice of $\epsilon_{i} \rightarrow 0$, we get a contradiction.
Therefore $l=L_{\gamma, \Omega}$ that is independent of the choice of the sequence $\left(h_{i}\right)$. This proves (210) and ends the proof of Theorem 8.

## 15. Appendix E: Green's function for the Hardy-Schrödinger OPERATOR ON $\mathbb{R}_{-}^{n}$

In this section, we prove the following:
Theorem 9. Fix $\gamma<\frac{n^{2}}{4}$. For all $p \in \mathbb{R}_{-}^{n} \backslash\{0\}$, there exists $G_{p} \in L^{1}\left(\mathbb{R}_{-}^{n}\right)$ such that
(i) $\eta G_{p} \in H_{1,0}^{2}\left(\mathbb{R}_{-}^{n}\right)$ for all $\eta \in C_{c}^{\infty}\left(\mathbb{R}^{n}-\{p\}\right)$,
(ii) For all $\varphi \in C_{c}^{\infty}\left(\mathbb{R}_{-}^{n}\right)$, we have that

$$
\begin{equation*}
\varphi(p)=\int_{\mathbb{R}_{-}^{n}} G_{p}(x)\left(-\Delta \varphi-\frac{\gamma}{|x|^{2}} \varphi\right) d x \tag{275}
\end{equation*}
$$

Moreover, if $G_{p}, G_{p}^{\prime}$ satisfy (i) and (ii) and are positive, then there exists $C \in \mathbb{R}$
such that $G_{p}(x)-G_{p}^{\prime}(x)=C\left|x_{1}\right| \cdot|x|^{-\beta_{-}(\gamma)}$ for all $x \in \mathbb{R}_{-}^{n} \backslash\{0, p\}$.
In particular, there exists one and only one function $\mathcal{G}_{p}=\mathcal{G}(p, \cdot)>0$ such that (i) and (ii) hold with $G_{p}=\mathcal{G}_{p}$ and
(iii) $\mathcal{G}_{p}(x)=O\left(\frac{\left|x_{1}\right|}{|x|^{\beta}+(\gamma)}\right)$ as $|x| \rightarrow+\infty$.

We then say that $\mathcal{G}$ is the Green's function for $-\Delta-\gamma|x|^{-2}$ on $\mathbb{R}_{-}^{n}$ with Dirichlet boundary condition.
In addition, $\mathcal{G}$ satisfies the following properties:
(iv) For all $p \in \mathbb{R}^{n} \backslash\{0\}$, there exists $c_{0}(p), c_{\infty}(p)>0$ such that

$$
\begin{equation*}
\mathcal{G}_{p}(x) \sim_{x \rightarrow 0} \frac{c_{0}(p)\left|x_{1}\right|}{|x|^{\beta_{-}(\gamma)}} \text { and } \mathcal{G}_{p}(x) \sim_{x \rightarrow \infty} \frac{c_{\infty}(p)\left|x_{1}\right|}{|x|^{\beta_{+}(\gamma)}} \tag{276}
\end{equation*}
$$

and

$$
\begin{equation*}
\mathcal{G}_{p}(x) \sim_{x \rightarrow p} \frac{1}{(n-2) \omega_{n-1}|x-p|^{n-2}} \tag{277}
\end{equation*}
$$

(v) There exists $c>0$ independent of $p$ such that

$$
\begin{equation*}
c^{-1} \mathcal{H}_{p}(x) \leq \mathcal{G}_{p}(x) \leq c \mathcal{H}_{p}(x) \tag{278}
\end{equation*}
$$

where

$$
\begin{equation*}
\mathcal{H}_{p}(x):=\left(\frac{\max \{|p|,|x|\}}{\min \{|p|,|x|\}}\right)^{\beta_{-}(\gamma)}|x-p|^{2-n} \min \left\{1, \frac{\left|x_{1}\right| \cdot\left|p_{1}\right|}{|x-p|^{2}}\right\} \tag{279}
\end{equation*}
$$

Proof of Theorem 9: We shall again proceed with several steps.
Step 15.1: Construction of a positive kernel at a given point: For a fixed $p_{0} \in \mathbb{R}^{n} \backslash\{0\}$, we show that there exists $G_{p_{0}} \in C^{2}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\left\{0, p_{0}\right\}\right)$ such that

\begin{cases}-\Delta G_{p_{0}}-\frac{\gamma}{|x|^{2}} G_{p_{0}}=0 & \text { in } \mathbb{R}_{-}^{n} \backslash\left\{0, p_{0}\right\}  \tag{280}\\ G_{p_{0}}>0 & \text { with } \delta:=\left|p_{0}\right| / 4 \\ G_{p_{0}} \in L^{\frac{2 n}{n-2}}\left(B_{\delta}(0) \cap \mathbb{R}_{-}^{n}\right) & \text { with } \\ G_{p_{0}} \text { satisfies (ii) with } p=p_{0} . & \end{cases}
$$

Indeed, let $\tilde{\eta} \in C^{\infty}(\mathbb{R})$ be a nondecreasing function such that $0 \leq \tilde{\eta} \leq 1, \tilde{\eta}(t)=0$ for all $t \leq 1$ and $\tilde{\eta}(t)=1$ for all $t \geq 2$. For $\epsilon>0$, set $\eta_{\epsilon}(x):=\tilde{\eta}\left(\frac{|x|}{\epsilon}\right)$ for all $x \in \mathbb{R}^{n}$.
We let $\Omega_{1}$ be a smooth bounded domain of $\mathbb{R}^{n}$ such that $\mathbb{R}_{-}^{n} \cap B_{1}(0) \subset \Omega_{1} \subset$ $\mathbb{R}_{-}^{n} \cap B_{3}(0)$. We define $\Omega_{R}:=R \cdot \Omega_{1}$ so that $\mathbb{R}_{-}^{n} \cap B_{R}(0) \subset \Omega_{R} \subset \mathbb{R}_{-}^{n} \cap B_{3 R}(0)$. We argue as in the proof of (211) to deduce that the operator $-\Delta-\frac{\gamma \eta_{\epsilon}}{|x|^{2}}$ is coercive on $\Omega_{R}$ and that there exists $c>0$ independent of $R, \epsilon>0$ such that

$$
\int_{\Omega_{R}}\left(|\nabla \varphi|^{2}-\frac{\gamma \eta_{\epsilon}}{|x|^{2}} \varphi^{2}\right) d x \geq c \int_{\Omega_{R}}|\nabla \varphi|^{2} d x \quad \text { for all } \varphi \in C_{c}^{\infty}\left(\Omega_{R}\right)
$$

Consider $R, \epsilon>0$ such that $R>2\left|p_{0}\right|$ and $\epsilon<\frac{\left|p_{0}\right|}{6}$, and let $G_{R, \epsilon}$ be the Green's function of $-\Delta-\frac{\gamma \eta_{\epsilon}}{|x|^{2}}$ in $\Omega_{R}$ with Dirichlet boundary condition. We have that $G_{R, \epsilon}>0$ since the operator is coercive.
Fix $R_{0}>0$ and $q^{\prime} \in\left(1, \frac{n}{n-2}\right)$, then by arguing as in the proof of (213), we get that there exists $C=C\left(\gamma, p_{0}, q^{\prime}, R_{0}\right)$ such that

$$
\begin{equation*}
\left\|G_{R, \epsilon}\left(p_{0}, \cdot\right)\right\|_{L^{q^{\prime}}\left(B_{R_{0}}(0) \cap \mathbb{R}_{-}^{n}\right)} \leq C \text { for all } R>R_{0} \text { and } 0<\epsilon<\frac{\left|p_{0}\right|}{6} \tag{281}
\end{equation*}
$$

and

$$
\begin{equation*}
\left\|G_{R, \epsilon}\left(p_{0}, \cdot\right)\right\|_{L^{\frac{2 n}{n-2}}\left(B_{\delta_{0}}(0) \cap \mathbb{R}_{-}^{n}\right)} \leq C \text { for all } R>R_{0} \text { and } 0<\epsilon<\frac{\left|p_{0}\right|}{6}, \tag{282}
\end{equation*}
$$

where $\delta:=\left|p_{0}\right| / 4$. Arguing again as in Step 14.2 of the proof of Theorem 8, there exists $G_{p_{0}} \in C^{2}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\left\{0, p_{0}\right\}\right)$ such that

\begin{cases}G_{R, \epsilon}\left(p_{0}, \cdot\right) \rightarrow G_{p_{0}} \geq 0 & \text { in } C_{l o c}^{2}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\left\{0, p_{0}\right\}\right) \text { as } R \rightarrow+\infty, \epsilon \rightarrow 0  \tag{283}\\ -\Delta G_{p_{0}}-\frac{\gamma}{|x|^{2}} G_{p_{0}}=0 & \text { in } \mathbb{R}_{-}^{n} \backslash\left\{0, p_{0}\right\} \\ G_{p_{0}} \equiv 0 \text { on } \partial \mathbb{R}_{-}^{n} \backslash\{0\} & \\ G_{p_{0}} \in L^{\frac{2 n}{n-2}}\left(B_{\delta}(0) \cap \mathbb{R}_{-}^{n}\right) & \end{cases}
$$

and $\eta G_{p_{0}} \in H_{1,0}^{2}\left(\mathbb{R}_{-}^{n}\right)$ for all $\eta \in C_{c}^{\infty}\left(\mathbb{R}^{n} \backslash\left\{p_{0}\right\}\right)$. Fix $\varphi \in C_{c}^{\infty}\left(\mathbb{R}_{-}^{n}\right)$. For $R>0$ large enough, we have that $\varphi\left(p_{0}\right)=\int_{\mathbb{R}_{-}^{n}} G_{R, \epsilon}\left(p_{0}, \cdot\right)\left(-\Delta \varphi-\gamma \eta_{\epsilon}|x|^{-2} \varphi\right) d x$. The integral bounds above yield $x \mapsto G_{p_{0}}(x)|x|^{-2} \in L_{l o c}^{1}\left(\mathbb{R}_{-}^{n}\right)$. Therefore, we get

\varphi\left(p_{0}\right)=\int_{\mathbb{R}_{-}^{n}} G_{p_{0}}(x)\left(-\Delta \varphi-\frac{\gamma}{|x|^{2}} \varphi\right) d x \text { for all } \varphi \in C_{c}^{\infty}\left(\mathbb{R}_{-}^{n}\right) \tag{284}
\end{equation*}
$$

As a consequence, $G_{p_{0}}>0$.
Step 15.2: Asymptotic behavior at 0 and $p_{0}$ for solutions to (280). It follows from Theorem 6.1 in Ghoussoub-Robert [21] that either $G_{p_{0}}$ behaves like $\left|x_{1}\right| \cdot|x|^{-\beta-(\gamma)}$ or $\left|x_{1}\right| \cdot|x|^{-\beta_{+}(\gamma)}$ at 0 . Since $G_{p_{0}} \in L^{\frac{2 n}{n-2}}\left(B_{\delta}(0) \cap \mathbb{R}_{-}^{n}\right)$ for some small $\delta>0$ and $\beta_{-}(\gamma)<\frac{n}{2}<\beta_{+}(\gamma)$, we get that there exists $c_{0}>0$ such that

\lim _{x \rightarrow 0} \frac{G_{p_{0}}(x)}{\left|x_{1}\right| \cdot|x|^{-\beta-(\gamma)}}=c_{0} . \tag{285}
\end{equation*}
$$

Since $G_{p_{0}}$ is positive and smooth in a neighborhood of $p_{0}$, it follows from (284) and the classification of solutions to harmonic equations that

\begin{equation*}
G_{p_{0}}(x) \sim_{x \rightarrow p_{0}} \frac{1}{(n-2) \omega_{n-1}\left|x-p_{0}\right|^{n-2}} . \tag{286}
\end{equation*}
$$

Step 15.3: Asymptotic behavior at $\infty$ for solutions to (280): We let

$$
\tilde{G}_{p_{0}}(x):=\frac{1}{|x|^{n-2}} G_{p_{0}}\left(\frac{x}{|x|^{2}}\right) \text { for all } x \in \mathbb{R}_{-}^{n} \backslash\left\{0, \frac{p_{0}}{\left|p_{0}\right|^{2}}\right\},
$$

be the Kelvin's transform of $G$. We have that

$$
-\Delta \tilde{G}_{p_{0}}-\frac{\gamma}{|x|^{2}} \tilde{G}_{p_{0}}=0 \text { in } \mathbb{R}_{-}^{n} \backslash\left\{0, \frac{p_{0}}{\left|p_{0}\right|^{2}}\right\} ; \tilde{G} \equiv 0 \text { on } \partial \mathbb{R}_{-}^{n} \backslash\left\{p_{0}\right\} .
$$

Since $\tilde{G}_{p_{0}}>0$, it follows from Theorem 6.1 in [21] that there exists $c_{1}>0$ such that

$$
\text { either } \tilde{G}_{p_{0}}(x) \sim_{x \rightarrow 0} c_{1} \frac{\left|x_{1}\right|}{|x|^{\beta-(\gamma)}} \text { or } \tilde{G}_{p_{0}}(x) \sim_{x \rightarrow 0} c_{1} \frac{\left|x_{1}\right|}{|x|^{\beta+(\gamma)}} .
$$

Coming back to $G_{p_{0}}$, we get that

\begin{equation*}
\text { either } G_{p_{0}}(x) \sim_{|x| \rightarrow \infty} c_{1} \frac{\left|x_{1}\right|}{|x|^{\beta+(\gamma)}} \text { or } G_{p_{0}}(x) \sim_{|x| \rightarrow \infty} c_{1} \frac{\left|x_{1}\right|}{|x|^{\beta-(\gamma)}} . \tag{287}
\end{equation*}
$$

Assuming we are in the second case, for any $c \leq c_{1}$, we define

\bar{G}_{c}(x):=G_{p_{0}}(x)-c \frac{\left|x_{1}\right|}{|x|^{\beta-(\gamma)}} \text { in } \mathbb{R}_{-}^{n} \backslash\left\{0, p_{0}\right\},
$$

which satisfy $-\Delta \bar{G}_{c}-\frac{\gamma}{|x|^{2}} \bar{G}_{c}=0$ in $\mathbb{R}_{-}^{n} \backslash\left\{0, p_{0}\right\}$. It follows from (287) and (286) that for $c<c_{1}, \bar{G}_{c}>0$ around $p_{0}$ and $\infty$. Using that $\eta \bar{G}_{c} \in H_{1,0}^{2}\left(\mathbb{R}_{-}^{n}\right)$ for all $\eta \in C_{c}^{\infty}\left(\mathbb{R}^{n} \backslash\left\{p_{0}\right\}\right)$, it follows from the coercivity of $-\Delta-\gamma|x|^{-2}$ that $\bar{G}_{c}>0$ in $\mathbb{R}_{-}^{n} \backslash\left\{0, p_{0}\right\}$ for $c<c_{1}$. Letting $c \rightarrow c_{1}$ yields $\bar{G}_{c_{1}} \geq 0$, and then $\bar{G}_{c_{1}}>0$. Since $\bar{G}_{c_{1}}(x)=o\left(\left|x_{1}\right| \cdot|x|^{-\beta_{-}(\gamma)}\right)$ as $|x| \rightarrow \infty$, another Kelvin transform and Theorem 6.1 in [21] yield $\left|x_{1}\right|^{-1}|x|^{\beta_{+}(\gamma)} \bar{G}_{c_{1}}(x) \rightarrow c_{2}>0$ as $|x| \rightarrow \infty$ for some $c_{2}>0$. Then there exists $c_{3}>0$ such that

$$
\begin{equation*}
\lim _{x \rightarrow 0} \frac{\bar{G}_{c_{1}}(x)}{\left|x_{1}\right| \cdot|x|^{-\beta_{-}(\gamma)}}=c_{3}>0 \text { and } \lim _{x \rightarrow \infty} \frac{\bar{G}_{c_{1}}(x)}{\left|x_{1}\right| \cdot|x|^{-\beta_{+}(\gamma)}}=c_{2} \tag{288}
\end{equation*}
$$

Since $x \mapsto\left|x_{1}\right| \cdot|x|^{-\beta_{-}(\gamma)} \in H_{1, l o c}^{2}\left(\mathbb{R}^{n}\right)$, we get that

$$
\varphi(p)=\int_{\mathbb{R}_{-}^{n}} \bar{G}_{c_{1}}(x)\left(-\Delta \varphi-\frac{\gamma}{|x|^{2}} \varphi\right) d x \text { for all } \varphi \in C_{c}^{\infty}\left(\mathbb{R}_{-}^{n}\right)
$$

Step 15.4: Uniqueness: Let $G_{1}, G_{2}>0$ be 2 functions such that (i), (ii) hold for $p:=p_{0}$, and set $H:=G_{1}-G_{2}$. It follows from Steps 2 and 3 that there exists $c \in \mathbb{R}$ such that $H^{\prime}(x):=H(x)-c\left|x_{1}\right| \cdot|x|^{-\beta_{-}(\gamma)}$ satisfies

$$
\begin{equation*}
H^{\prime}(x)={ }_{x \rightarrow 0} O\left(\left|x_{1}\right| \cdot|x|^{-\beta-(\gamma)}\right) \text { and } H^{\prime}(x)={ }_{|x| \rightarrow \infty} O\left(\left|x_{1}\right| \cdot|x|^{-\beta_{+}(\gamma)}\right) \tag{289}
\end{equation*}
$$

We then have that $\eta H^{\prime} \in H_{1,0}^{2}\left(\mathbb{R}_{-}^{n}\right)$ for all $\eta \in C_{c}^{\infty}\left(\mathbb{R}^{n} \backslash\left\{p_{0}\right\}\right)$ and

$$
\int_{\mathbb{R}_{-}^{n}} H^{\prime}(x)\left(-\Delta \varphi-\frac{\gamma}{|x|^{2}} \varphi\right) d x=0 \quad \text { for all } \varphi \in C_{c}^{\infty}\left(\mathbb{R}_{-}^{n}\right)
$$

The ellipticity of the Laplacian then yields $H^{\prime} \in C^{\infty}\left(\overline{\mathbb{R}_{-}^{n}} \backslash\{0\}\right)$. The pointwise bounds (289) yield that $H^{\prime} \in H_{1,0}^{2}\left(\mathbb{R}_{-}^{n}\right)$. Multiplying $-\Delta H^{\prime}-\frac{\gamma}{|x|^{2}} H^{\prime}=0$ by $H^{\prime}$, integrating by parts and the coercivity yield $H^{\prime} \equiv 0$, and therefore, $\left(G_{1}-G_{2}\right)(x)=$ $c\left|x_{1}\right| \cdot|x|^{-\beta_{-}(\gamma)}$ for all $x \in \mathbb{R}_{-}^{n}$. This proves uniqueness.
Step 15.5: Existence. It follows from Steps 2 and 3 that, up to substracting a multiple of $x \mapsto\left|x_{1}\right| \cdot|x|^{-\beta_{-}(\gamma)}$, there exists a unique function $\mathcal{G}_{p_{0}}>0$ satisfying (i), (ii) and the pointwise control (iii). Moreover, (285), (286) and (288) yield (276) and (277). As a consequence, (278) holds with $p=p_{0}$.
For $p \in \mathbb{R}^{n} \backslash\{0\}$, consider $\rho_{p}: \mathbb{R}_{-}^{n} \rightarrow \mathbb{R}_{-}^{n}$ a linear isometry fixing $\mathbb{R}_{-}^{n}$ such that $\rho_{p}\left(\frac{p_{0}}{\left|p_{0}\right|}\right)=\frac{p}{|p|}$, and define

\mathcal{G}_{p}(x):=\left(\frac{\left|p_{0}\right|}{|p|}\right)^{n-2} \mathcal{G}_{p_{0}}\left(\left(\rho_{p}^{-1}\left(\frac{\left|p_{0}\right|}{|p|} x\right)\right)\right) \text { for all } x \in \mathbb{R}^{n} \backslash\{0, p\}
$$

As one checks, $\mathcal{G}_{p}>0$ satisfies (i), (ii), (iii), (276), (277) and (278).
The definition of $\mathcal{G}_{p}$ is independent of the choice of $\rho_{p}$. Indeed, for any linear isometry $\rho_{p_{0}}: \mathbb{R}_{-}^{n} \rightarrow \mathbb{R}_{-}^{n}$ fixing $p_{0}$ and $\mathbb{R}_{-}^{n}, \mathcal{G}_{p_{0}} \circ \rho_{p_{0}}^{-1}$ satisfies (i), (ii), (iii), and therefore $\mathcal{G}_{p_{0}} \circ \rho_{p_{0}}^{-1}=\mathcal{G}_{p_{0}}$. The argument goes similarly of any isometry fixing $p$.
