# Infinite families of 2-designs from a class of cyclic codes with two non-zeros

#### Abstract

Combinatorial $t$-designs have wide applications in coding theory, cryptography, communications and statistics. It is well known that the supports of all codewords with a fixed weight in a code may give a $t$-design. In this paper, we first determine the weight distribution of a class of linear codes derived from the dual of extended cyclic code with two non-zeros. We then obtain infinite families of 2-designs and explicitly compute their parameters from the supports of all the codewords with a fixed weight in the codes. By simple counting argument, we obtain exponentially many 2 -designs.


Key words: Affine-invariant code, cyclic code, exponential sum, linear code, weight distribution, 2-design

## 1 Introduction

Let $k, t$ and $v$ are positive integers with $1 \leq t \leq k \leq v$. Let $\mathcal{P}$ be a set of $v$ elements and $\mathcal{B}$ be a set of $k$-subsets of $\mathcal{P}$. If every $t$-subset of $\mathcal{P}$ is contained in exactly $\lambda$ elements of $\mathcal{B}$, then we call the pair $\mathbb{D}=(\mathcal{P}, \mathcal{B})$ a $t-(v, k, \lambda)$ design, or simply $t$-design. The elements of $\mathcal{P}$ are called points, and those of $\mathcal{B}$ are referred to as blocks. We often define the number of blocks by $b$ and a $t$-design is simple when there is no repeated blocks in $\mathcal{B}$. A $t$-design is called symmetric if $v=b$ and trivial if $k=t$ or $k=v$. Hereafter we study only simple $t$-design with $t<k<v$. We call $t$ - $(v, k, \lambda)$ design a Steiner system when $t \geq 2$ and $\lambda=1$. It is well known that a $t-(v, k, \lambda)$ design is also an $i-\left(v, k, \lambda_{i}\right)$ design for any $0 \leq i<t$, where

\lambda_{i}=\frac{\lambda\binom{v-i}{t-i}}{\binom{k-i}{t-i}} . \tag{1}

Combinatorial $t$-designs have very important applications in coding theory, cryptography, communications and statistics. There has been an interplay between codes and $t$-designs for both directions. On one hand, a linear code over any finite field can be derived from the incidence matrix of a $t$-design and much progress has been made and documented in [1, 6, 19, 20. On the other hand, linear and nonlinear codes might both hold $t$-designs. Till now, 4-designs and 5 -designs with fixed parameters were only derived from binary and ternary Golay codes. The largest $t$ for which the infinite families of $t$-designs could be obtained from linear codes is $t=3$. In 2017, Ding and Li [8] obtained infinite families of 2-designs from p-ary Hamming codes, ternary projective cyclic codes, binary codes with two zeros and their duals as well as the infinite families of 3 -designs from the extended codes of these codes and RM codes. Afterwards, infinite families of 2-designs and 3-designs were constructed from a class of binary linear codes with five weights 9]. For other constructions of $t$-designs, for example, we refer to [2, $5, ~ 17, ~ 18]$.

The rest of this paper is organized as follows. In Section 2, we introduce some notation, together with some preliminary results on affine-invariant codes and 2designs, which will be used in subsequent sections. In Section 3, we present the weight distributions of a class of linear codes derived from the dual of the extended cyclic codes with two non-zeros. By proving that the derived codes are affine-invariant, we then obtain infinite families of 2-designs and explicitly determine their parameters. The proof of the main results are given in Section 4. Section 5 concludes the paper.

## 2 Preliminaries

In this section, we present some standard notation and basic facts on affineinvariant codes and 2-designs.

### 2.1 Some notation

For convenience, we fix the following notation unless otherwise stated in this paper.

- $p$ is an odd prime and $p^{*}=(-1)^{\frac{p-1}{2}} p$.
- $m \geq 2,1 \leq l \leq m-1$ are positive integers, $q=p^{m}, n=p^{m}-1$ and $\operatorname{gcd}(m, l)=$ $d>1$.
- $\zeta_{p}=e^{2 \pi \nu / p}$ is a primitive $p$-th root of unity, where $\nu=\sqrt{-1}$.
- $\mathbb{F}_{q}$ denotes the finite field with $q$ elements and $\mathbb{F}_{q}^{*}=\mathbb{F}_{q} \backslash\{0\}$.
- $\eta$ and $\eta^{\prime}$ are the quadratic characters of $\mathbb{F}_{q}^{*}$ and $\mathbb{F}_{p}^{*}$, respectively. We extend these quadratic characters by setting $\eta(0)=0$ and $\eta^{\prime}(0)=0$.
- $\operatorname{Tr}$ denotes the trace function from $\mathbb{F}_{q}$ onto $\mathbb{F}_{p}$.


### 2.2 The classical construction of $t$-designs from affine-invariant codes

Let $p$ be an odd prime, $m, l$ be positive integers and $(m, l)=d>1$. Let $\mathbb{F}_{q}$ denote the finite field with $q=p^{m}$ elements and $\mathbb{F}_{q}^{*}=\mathbb{F}_{q} \backslash\{0\}$. An $[n, k, d]$ linear code $\mathcal{C}$ over $\mathbb{F}_{p}$ is a $k$-dimensional subspace of $\mathbb{F}_{p}^{n}$ with minimum Hamming distance $d$, and is cyclic provided that any cyclic shift of a codeword is another codeword of $\mathcal{C}$. Any cyclic code $\mathcal{C}$ can be expressed as $\mathcal{C}=\langle g(x)\rangle$, where $g(x)$ is monic and has the least degree. The polynomial $g(x)$ is called the generator polynomial and $h(x)=\left(x^{n}-1\right) / g(x)$ is referred to as the parity check polynomial of $\mathcal{C}$. If the generator polynomial $g(x)$ (resp. the parity check polynomial $h(x)$ ) can be factored into a product of $s$ irreducible polynomials over $\mathbb{F}_{q}$, then $\mathcal{C}$ is called a cyclic code with $s$ zeros (resp. s non-zeros). The code with the generator polynomial $x^{k} h\left(x^{-1}\right) / h(0)$ is called the dual of $\mathcal{C}$ and denoted by $\mathcal{C}^{\perp}$, which is an $[n, n-k]$ code. The extended code of $\mathcal{C}$ is defined by

$$
\overline{\mathcal{C}}=\left\{\left(c_{0}, c_{1}, \ldots, c_{n}\right) \in \mathbb{F}_{p}^{n+1}:\left(c_{0}, c_{1}, \ldots, c_{n-1}\right) \in \mathcal{C} \text { with } \sum_{i=0}^{n} c_{i}=0\right\}
$$

For a codeword $\mathbf{c} \in \mathcal{C}$, the support of $\mathbf{c}$ is defined by

$$
\operatorname{Suppt}(\mathbf{c})=\left\{0 \leq i \leq n-1: c_{i} \neq 0\right\} .
$$

Let $A_{i}$ be the number of codewords with Hamming weight $i$ in a code $\mathcal{C}$. The weight enumerator of $\mathcal{C}$ is defined by

$$
1+A_{1} z+A_{2} z^{2}+\ldots+A_{n} z^{n}
$$

and the sequence $\left(1, A_{1}, \ldots, A_{n}\right)$ is called the weight distribution of $\mathcal{C}$. If $\mid\{1 \leq i \leq n$ : $\left.A_{i} \neq 0\right\} \mid=w$, then we say $\mathcal{C}$ a $w$-weight code. Indexed the coordinates of a codeword in $\mathcal{C}$ by $(0,1,2, \ldots, n-1)$, then for each $i$ with $A_{i} \neq 0$, we denote $\mathcal{B}_{i}$ by the set of the supports of all codewords with weight $i$. Let $\mathcal{P}=\{0,1, \ldots, n-1\}$. The pair $\left(\mathcal{P}, \mathcal{B}_{i}\right)$ could give a $t-(n, i, \lambda)$ design for some positive $\lambda$ [8] and the parameter $\lambda$ can be determined explicitly by Eq.(11). Such codes were used to construct 2-designs and 3 -designs in [1, 19, 20 .

We conclude this section by introducing some known results on affine-invariant codes related to 2-designs.

The set of coordinate permutations that map a code $\mathcal{C}$ to itself forms a group, which is called the permutation automorphism group of $\mathcal{C}$ and denoted by $\operatorname{PAut}(\mathcal{C})$. We define the affine group $G A_{1}\left(\mathbb{F}_{q}\right)$ by the set of all permutations

$$
\sigma_{a, b}: x \mapsto a x+b
$$

of $\mathbb{F}_{q}$, where $a \in \mathbb{F}_{q}^{*}$ and $b \in \mathbb{F}_{q}$. An affine-invariant code is an extended cyclic code $\overline{\mathcal{C}}$ over $\mathbb{F}_{p}$ satisfying $G A_{1}\left(\mathbb{F}_{q}\right) \subseteq \operatorname{PAut}(\overline{\mathcal{C}})[13]$.

The $p$-adic expansion of each $s \in \mathcal{P}$ is given by

s=\sum_{i=0}^{m-1} s_{i} p^{i}, \quad 0 \leq s_{i} \leq p-1, \quad 0 \leq i \leq m-1
$$

For any $r=\sum_{i=0}^{m-1} r_{i} p^{i} \in \mathcal{P}$, we call that $r \preceq s$ if $r_{i} \leq s_{i}$ for all $0 \leq i \leq m-1$.
For any integer $0 \leq j \leq n-1$, the $p$-cyclotomic coset of $j$ modulo $n$ is defined by

$$
C_{j}=\left\{j p^{i} \quad(\bmod n): 0 \leq i \leq \ell_{j}-1\right\}
$$

where $\ell_{j}$ is the smallest positive integer such that $j \equiv j p^{\ell_{j}}(\bmod n)$. The smallest integer in $C_{j}$ is called the coset leader of $C_{j}$. Let $g(x)=\prod_{j} \prod_{i \in C_{j}}\left(x-\alpha^{i}\right)$, where $j$ runs through some coset leaders of the $p$-cyclotomic cosets $C_{j}$ modulo $n$. The union of these $p$-cyclotomic cosets $T=\bigcup_{j} C_{j}$ is referred to as the defining set of $\mathcal{C}$.

For certain applications, it is important to know whether a given extended primitive cyclic code $\overline{\mathcal{C}}$ is affine-invariant or not. The following Lemma 1 presented by Kasami et al. [15] answered the questions by examining the defining set of the code. Lemma 2 proposed by Ding [7] in 2019 point out that one can get the new affineinvariant codes from the known ones.

Lemma $\frac{1}{\overline{\mathcal{C}}}$ Let $\overline{\mathcal{C}}$ be an extended cyclic code of length $p^{m}$ over $\mathbb{F}_{p}$ with defining set $\bar{T}$. The code $\overline{\mathcal{C}}$ is affine-invariant if and only if whenever $s \in \bar{T}$ then $r \in \bar{T}$ for all $r \in \mathcal{P}$ with $r \preceq s$.

Lemma 2 The dual of an affine-invariant code $\overline{\mathcal{C}}$ over $\mathbb{F}_{p}$ of length $n+1$ is also affine-invariant.

Lemma 2 and the following Theorem 1 given by Ding in [7] are very powerful tools in constructing 2-designs from linear codes. We will employ them to present our main results in this paper.

Theorem 1 For each $i$ with $A_{i} \neq 0$ in an affine-invariant code $\overline{\mathcal{C}}$, the supports of the codewords of weight $i$ form a 2-design.

The following theorem presented by Ding in [7] reveals the relation of the codewords with the same support in a linear code $\mathcal{C}$, which will be used together with Eq.(11) to calculate the parameters of 2-designs later.

Theorem 2 Let $\mathcal{C}$ be a linear code over $\mathbb{F}_{p}$ with minimum weight $d$. Let $w$ be the largest integer with $w \leq n$ satisfying

$$
w-\left\lfloor\frac{w+p-2}{p-1}\right\rfloor<d
$$

Let $\mathbf{c}_{\mathbf{1}}$ and $\mathbf{c}_{\boldsymbol{2}}$ be two codewords of weight $i$ with $d \leq i \leq w$ and $\operatorname{Suppt}\left(\mathbf{c}_{\mathbf{1}}\right)=\operatorname{Suppt}\left(\mathbf{c}_{\mathbf{2}}\right)$. Then $\mathbf{c}_{\mathbf{1}}=a \mathbf{c}_{\mathbf{2}}$ for some $a \in \mathbb{F}_{p}^{*}$.

## 3 The weight distribution of the codes and their 2-designs

In this section, we present the main results, including the weight distribution and the underlying 2-designs. The proofs of the main results will be provided in the following section. We begin this section by the definition of the code.

Define

$$
\begin{equation*}
\overline{\mathcal{C}^{\perp}}:=\left\{\left(\operatorname{Tr}\left(a x^{p^{l}+1}+b x\right)_{x \in \mathbb{F}_{q}}+h\right): a, b \in \mathbb{F}_{q}, h \in \mathbb{F}_{p}\right\} \tag{2}
\end{equation*}
$$

where $\mathcal{C}$ is the cyclic code of length $n$ and parity check polynomial $h_{1}(x) h_{2}(x)$ where $h_{1}(x), h_{2}(x)$ are the minimal polynomials of $\alpha, \alpha^{p^{l}+1}$ over $\mathbb{F}_{p}$, respectively, and $\alpha$ is a primitive element of $\mathbb{F}_{q}$. In particular, if $l=\frac{m}{2}$ we have

$$
\overline{\mathcal{C}^{\perp}}:=\left\{\left(\operatorname{Tr}\left(a x^{x^{\frac{m}{2}}+1}+b x\right)_{x \in \mathbb{F}_{q}}+h\right): a \in \mathbb{F}_{p^{\frac{m}{2}}}, b \in \mathbb{F}_{q}, h \in \mathbb{F}_{p}\right\} .
$$

Below, we consider only the case $\operatorname{gcd}(m, l)>1$ since the case for $\operatorname{gcd}(m, l)=1$ was discussed in [10].

The following Theorems $3+5$ are the main results of this paper.
Theorem 3 Let $m \geq 2$ and $(m, l)=d>1$. The weight distribution of the code ${\overline{\mathcal{C}^{\perp}}}^{\perp}$ over $\mathbb{F}_{p}$ with length $n+1$ are given in Table $\square$ when both $m$ and $\frac{m}{d}$ are odd, in Table图 when $m$ is even and $\frac{m}{d}$ is odd, in Table 圂 when $\frac{m}{d} \geq 4$ is even and in Table 4 when $m=2 d$, respectively. And the dimension is $\operatorname{dim}\left({\overline{\mathcal{C}^{\perp}}}^{\perp}\right)=\frac{3 m}{2}+1$ when $m=2 d$ and $\operatorname{dim}\left(\overline{\mathcal{C}^{\perp}}\right)=2 m+1$ otherwise.

One can see that the code is four-weight if both $m$ and $\frac{m}{d}$ are odd or $m=2 d$ and six-weight if $m$ is even and $\frac{m}{d}$ is odd or $\frac{m}{d} \geq 4$ is even.

Theorem 4 Let $m \geq 2, l$ be positive integers with $\operatorname{gcd}(m, l)>1$. Then the supports of the codewords of weight $i$ with $A_{i} \neq 0$ in ${\overline{\mathcal{C}^{\perp}}}^{\perp}$ form a 2-design.

Theorem 5 Let $m \geq 2, l$ be integers, $\mathcal{P}=\left\{0,1, \ldots, p^{m}-1\right\}$ and $\mathcal{B}$ be the set of the supports of the codewords of $\overline{\mathcal{C}^{\perp}}$ 都 with weight $i$, where $A_{i} \neq 0$. Then $\overline{\mathcal{C}^{\perp}}$ gives $2-\left(p^{m}, i, \lambda\right)$ designs for the following pairs:
(1) if both $m$ and $m / d$ are odd,

- $(i, \lambda)=\left(p^{m}-p^{m-1},\left(p^{m}-p^{m-1}-1\right)\left(p^{m-1}+1\right)\right)$.
- $(i, \lambda)=\left(p^{m}-p^{m-1}+p^{\frac{m-1}{2}}, \frac{1}{2} p^{\frac{m-1}{2}}\left(p^{\frac{m+1}{2}}-p^{\frac{m-1}{2}}+1\right)\left(p^{m}-p^{m-1}+p^{\frac{m-1}{2}}-1\right)\right)$.
- $(i, \lambda)=\left(p^{m}-p^{m-1}-p^{\frac{m-1}{2}}, \frac{1}{2} p^{\frac{m-1}{2}}\left(p^{\frac{m+1}{2}}-p^{\frac{m-1}{2}}-1\right)\left(p^{m}-p^{m-1}-p^{\frac{m-1}{2}}-1\right)\right)$.
(2) if $m$ is even and $m / d$ is odd,
- $(i, \lambda)=\left(p^{m}-p^{m-1}, p^{m}-p^{m-1}-1\right)$.
- $(i, \lambda)=\left(p^{m-1}(p-1)+p^{\frac{m}{2}-1}, \frac{1}{2} p^{\frac{m}{2}-1}\left(p^{\frac{m}{2}+1}-p^{\frac{m}{2}}+1\right)\left(p^{m}-p^{m-1}+p^{\frac{m}{2}-1}-1\right)\right)$.
- $(i, \lambda)=\left(p^{m-1}(p-1)-p^{\frac{m}{2}-1}, \frac{1}{2} p^{\frac{m}{2}-1}\left(p^{\frac{m}{2}+1}-p^{\frac{m}{2}}-1\right)\left(p^{m}-p^{m-1}-p^{\frac{m}{2}-1}-1\right)\right)$.
- $(i, \lambda)=\left(p^{m-1}(p-1)+p^{\frac{m}{2}-1}(p-1), \frac{1}{2} p^{\frac{m}{2}-1}\left(p^{\frac{m}{2}}+1\right)\left(p^{m}-p^{m-1}+p^{\frac{m}{2}}-p^{\frac{m}{2}-1}-1\right)\right)$.
- $(i, \lambda)=\left(p^{m-1}(p-1)-p^{\frac{m}{2}-1}(p-1), \frac{1}{2} p^{\frac{m}{2}-1}\left(p^{\frac{m}{2}}-1\right)\left(p^{m}-p^{m-1}-p^{\frac{m}{2}}+p^{\frac{m}{2}-1}-1\right)\right)$.
(3) if $m / d \geq 4$ is even,
- $(i, \lambda)=\left(p^{m}-p^{m-1},\left(p^{m}-p^{m-1}-1\right)\left(p^{m-d}-p^{m-2 d}+1\right)\right)$.
- $(i, \lambda)=\left(p^{m-1}(p-1)+(-1)^{\frac{m}{2 d}} p^{\frac{m}{2}-1}, p^{\frac{m}{2}+d-1}\left(p^{\frac{m}{2}+1}-p^{\frac{m}{2}}+(-1)^{\frac{m}{2 d}}\right)\left(p^{m}-p^{m-1}+\right.\right.$ $\left.\left.(-1)^{\frac{m}{2 d}} p^{\frac{m}{2}-1}-1\right) /\left(p^{d}+1\right)\right)$.

- $(i, \lambda)=\left(p^{m-1}(p-1)-(-1)^{\frac{m}{2 d}} p^{\frac{m}{2}+d-1}, p^{\frac{m}{2}-d-1}\left(p^{\frac{m}{2}-d+1}-p^{\frac{m}{2}-d}-(-1)^{\frac{m}{2 d}}\right)\left(p^{m}-\right.\right.$ $\left.\left.p^{m-1}-(-1)^{\frac{m}{2 d}} p^{\frac{m}{2}+d-1}-1\right) /\left(p^{d}+1\right)\right)$.
(4) if $m / d=2$,
- $(i, \lambda)=\left(p^{m}-p^{m-1}, p^{m}-p^{m-1}-1\right)$.
- $(i, \lambda)=\left(p^{m}-p^{m-1}-p^{\frac{m}{2}-1}, p^{\frac{m}{2}-1}\left(p^{\frac{m}{2}+1}-p^{\frac{m}{2}}-1\right)\left(p^{m}-p^{m-1}-p^{\frac{m}{2}-1}-1\right) /\left(p^{\frac{m}{2}}+1\right)\right)$.
- $(i, \lambda)=\left(p^{m}-p^{m-1}+p^{\frac{m}{2}}-p^{\frac{m}{2}-1}, p^{\frac{m}{2}-1}\left(p^{m}-p^{m-1}+p^{\frac{m}{2}}-p^{\frac{m}{2}-1}-1\right)\right)$.

The following examples from Magma program confirm the main results in Theorems 3 and 5 .

Example 1 If $(p, l, m)=(3,2,4)$, then the code $\overline{\mathcal{C}}^{\perp}$ has parameters [81, 7, 51] and weight enumerator $1+1296 z^{51}+240 z^{54}+648 z^{60}+2 z^{81}$, It gives $2-(81, i, \lambda)$ designs with the following pairs $(i, \lambda)$ :

$$
(51,255),(54,53),(60,177)
$$

which confirmed the results in Theorems 3 and 5.
Example 2 If $(p, l, m)=(3,3,6)$, then the code $\overline{\mathcal{C}^{\perp}}$ has parameters [729, 10, 477] and weight enumerator $1+37908 z^{477}+2184 z^{486}+18954 z^{504}+2 z^{729}$, which confirmed the results in Theorem 3 .

Example 3 If $(p, l, m)=(3,2,6)$, then the code $\overline{\mathcal{C}}^{\perp}$ has parameters [729, 10, 468] and weight enumerator $1+265356 z^{468}+530712 z^{477}+2184 z^{486}+530712 z^{495}+265356 z^{504}+$ $2^{729}$, which confirmed the results in Theorem 3 .

## 4 Proofs of the main results

We begin this section by stating some notation and basic facts on exponential sums.

### 4.1 Exponential sums

An additive character of $\mathbb{F}_{q}$ is a non-zero function $\chi$ from $\mathbb{F}_{q}$ to the set of complex numbers of absolute value 1 such that $\chi(x+y)=\chi(x) \chi(y)$ for any pair $(x, y) \in \mathbb{F}_{q}^{2}$. For each $u \in \mathbb{F}_{q}$, the function

$$
\chi_{u}(v)=\zeta^{\operatorname{Tr}(u v)}, v \in \mathbb{F}_{q}
$$

denotes an additive character of $\mathbb{F}_{q} . \chi_{0}$ is the trivial additive character of $\mathbb{F}_{q}$ since $\chi_{0}(v)=1$ for all $v \in \mathbb{F}_{q}$. We call $\chi_{1}$ the canonical additive character of $\mathbb{F}_{q}$ and we have $\chi_{u}(x)=\chi_{1}(u x)$ for all $u \in \mathbb{F}_{q}$ [16].

The Gauss sum $G\left(\eta^{\prime}, \chi_{1}^{\prime}\right)$ over $\mathbb{F}_{p}$ is defined by $G\left(\eta^{\prime}, \chi_{1}^{\prime}\right)=\sum_{c \in \mathbb{F}_{p}^{*}} \eta^{\prime}(v) \chi_{1}^{\prime}(v)=$ $\sum_{v \in \mathbb{F}_{p}} \eta^{\prime}(v) \chi_{1}^{\prime}(v)$, where $\chi_{1}^{\prime}$ is the canonical additive characters of $\mathbb{F}_{p}$.

To determine the parameters of the code $\overline{\mathcal{C}^{\perp}}{ }^{\perp}$ defined in Eq.(2), we introduce the following function.

$$
\begin{equation*}
S(a, b)=\sum_{x \in \mathbb{F}_{q}} \chi\left(a x^{p^{p}+1}+b x\right), \quad a, b \in \mathbb{F}_{q}, \tag{3}
\end{equation*}
$$

if $m \neq 2 l$, and otherwise

$$
S(a, b)=\sum_{x \in \mathbb{F}_{q}} \chi\left(a x^{p^{\frac{m}{2}}+1}+b x\right), \quad a \in \mathbb{F}_{p^{\frac{m}{2}}}, b \in \mathbb{F}_{q}
$$

The following Lemmas $3+6$ are essential to determine the values of Eq. (3).

Lemma 3 [16] With the notation above, we have

$$
G\left(\eta^{\prime}, \chi_{1}^{\prime}\right)=\sqrt{(-1)}^{\left(\frac{p-1}{2}\right)^{2}} \sqrt{p}=\sqrt{p^{*}} .
$$

Lemma 4 [6] For each $y \in \mathbb{F}_{p}^{*}, \eta(y)=1$ if $m \geq 2$ is even, and $\eta(y)=\eta^{\prime}(y)$ if $m \geq 1$ is odd.

Lemma 5 [3] Let $f(x)=a^{p^{l}} x^{p^{2 l}}+a x \in \mathbb{F}_{q}[x], g c d(m, l)=d$ and $b \in \mathbb{F}_{q}$. There are three cases.
(1) If $m / d$ is odd, then $f(x)$ is a permutation polynomial over $\mathbb{F}_{q}$ and

$$
S(a, b)={\sqrt{p^{*}}}^{m} \eta(a) \chi_{1}\left(-a x_{a, b}^{p^{l}+1}\right) .
$$

(2) If $m / d$ is even and $a^{\frac{q-1}{p^{d}+1}} \neq(-1)^{\frac{m}{2 d}}$, then $f(x)$ is a permutation polynomial over $\mathbb{F}_{q}$ and

$$
S(a, b)=(-1)^{\frac{m}{2 d}} p^{m / 2} \chi_{1}\left(-a x_{a, b}^{p^{l}+1}\right) .
$$

(3) If $m / d$ is even and $a^{\frac{q-1}{p^{d+1}}}=(-1)^{\frac{m}{2 d}}$, then $f(x)$ is not a permutation polynomial over $\mathbb{F}_{q}$. We have $S(a, b)=0$ when the equation $f(x)=-b^{p^{l}}$ is unsolvable, and

$$
S(a, b)=-(-1)^{\frac{m}{2 d}} p^{m / 2+d} \chi_{1}\left(-a x_{a, b}^{p^{l}+1}\right)
$$

otherwise. Particularly,

$$
S(a, 0)= \begin{cases}{\sqrt{p^{*}}}^{m} \eta(a) & \text { if } m / d \text { is odd } \\ (-1)^{\frac{m}{d} d} p^{\frac{m}{2}} & \text { if } m / d \text { is even and } a^{\frac{q-1}{p^{d}+1}} \neq(-1)^{\frac{m}{2 d}} \\ (-1)^{\frac{m}{2 d}+1} p^{\frac{m}{2}+d} & \text { if } m / d \text { is even and } a^{\frac{q-1}{p^{d}+1}}=(-1)^{\frac{m}{2 d}}\end{cases}
$$

Notice that $x_{a, b}^{p^{l}+1}$ is a solution to the equation $f(x)=-b^{p^{l}}$. Moreover, $x_{a, b}^{p^{l}+1}$ is the unique solution when $f(x)$ is a permutation polynomial over $\mathbb{F}_{q}$.

Lemma 6 [4] For $m$ even and $g c d(m, l)=d$, the equation $a^{p^{l}} x^{p^{2 l}}+a x=0$ is solvable for $x \in \mathbb{F}_{q}^{*}$ if and only if

$$
a^{\frac{q-1}{p^{d}+1}}=(-1)^{\frac{m}{2 d}} .
$$

In such cases there are $p^{2 d}-1$ non-zero solutions.

### 4.2 Proofs of the main results

Now we are ready to give the proofs of our main results. First we present the proof of the weight distribution of $\overline{\mathcal{C}}^{\perp}$ which is given in Eq.(2).

Proof of Theorem 3, For each non-zero codeword $\mathbf{c}(a, b, h)=\left(c_{0}, \ldots, c_{n}\right)$ in $\overline{\mathcal{C}^{\perp}}{ }^{\perp}$, the Hamming weight of $\mathbf{c}(a, b, h)$ is

$$
\begin{equation*}
w_{H}(\mathbf{c}(a, b, h))=p^{m}-T(a, b, h), \tag{4}
\end{equation*}
$$

where

$$
T(a, b, h)=\left|\left\{x: \operatorname{Tr}\left(a x^{p^{l}+1}+b x\right)+h=0, x, a, b \in \mathbb{F}_{q}, h \in \mathbb{F}_{p}\right\}\right|
$$

if $l \neq \frac{m}{2}$, and otherwise

$$
T(a, b, h)=\left|\left\{x: \operatorname{Tr}\left(a x^{p^{\frac{m}{2}}+1}+b x\right)+h=0, a \in \mathbb{F}_{p^{\frac{m}{2}}}, x, b \in \mathbb{F}_{q}, h \in \mathbb{F}_{p}\right\}\right| .
$$

Then

$$
\begin{aligned}
T(a, b, h) & =\frac{1}{p} \sum_{y \in \mathbb{F}_{p}} \sum_{x \in \mathbb{F}_{q}} \zeta_{p}^{y \operatorname{Tr}\left(a x^{p^{l}+1}+b x\right)+h y} \\
& =p^{m-1}+\frac{1}{p} \sum_{y \in \mathbb{F}_{p}^{*}} \zeta_{p}^{h y} \sum_{x \in \mathbb{F}_{q}} \zeta_{p}^{y \operatorname{Tr}\left(a x^{p^{l}+1}+b x\right)} .
\end{aligned}
$$

If $a=b=h=0$, then $\mathbf{c}(a, b, h)$ is the zero codeword.
If $a=b=0, h \neq 0$, then $T(a, b, h)=p^{m-1}+p^{m-1} \sum_{y \in \mathbb{F}_{p}^{*}} \zeta_{p}^{h y}=0$.
If $a=0, b \neq 0$, then $T(a, b, h)=p^{m-1}+\frac{1}{p} \sum_{y \in \mathbb{F}_{p}^{*}} \zeta_{p}^{h y} \sum_{x \in \mathbb{F}_{q}} \zeta_{p}^{y T r(b x)}=p^{m-1}$.
If $a \neq 0$, then from the definition of $S(a, b)$, we have

$$
T(a, b, h)=p^{m-1}+\frac{1}{p} \sum_{y \in \mathbb{F}_{p}^{*}} \zeta_{p}^{h y} S(a y, b y) .
$$

According to Lemma 5, the calculation of $T(a, b, h)$ can be divide into the following cases.
(1) When both $m$ and $m / d$ are odd, by Lemma 5, we have
$T(a, b, h)= \begin{cases}p^{m-1} & \text { if } h=\operatorname{Tr}\left(a x_{a y}^{p^{l}+1}, b y,\right. \\ p^{m-1}+p^{\frac{m-1}{2}}(-1)^{\frac{(p-1)(m+1)}{4}} \eta(a) \eta^{\prime}\left(h-\operatorname{Tr}\left(a x_{a, b}^{p^{l}+1}\right)\right) & \text { if } h \neq \operatorname{Tr}\left(a x_{a y, b y}^{p+1}\right) .\end{cases}$
Moreover, we find that $T(a, b, h)=p^{m-1}$ appears $p^{m}\left(p^{m}-1\right)$ times, and both

$$
T(a, b, h)=p^{m-1}+p^{\frac{m-1}{2}} \text { and } T(a, b, h)=p^{m-1}-p^{\frac{m-1}{2}}
$$

appear

$$
\frac{p^{m}(p-1)\left(p^{m}-1\right)}{2}
$$

times, respectively, from the properties of the quadratic characters $\eta$ of $\mathbb{F}_{q}^{*}$.
(2) When $m$ is even and $m / d$ is odd, by Lemma 5, we get

$$
T(a, b, h)= \begin{cases}p^{m-1}-p^{\frac{m}{2}-1}(-1)^{\frac{(p-1) m}{4}} \eta(a) & \text { if } h \neq \operatorname{Tr}\left(a x_{a y, b y}^{p^{l}+1}\right), \\ p^{m-1}+p^{\frac{m}{2}-1}(-1)^{\frac{(p-1) m}{4}} \eta(a)(p-1) & \text { if } h=\operatorname{Tr}\left(a x_{a y, b y}^{p+1}\right) .\end{cases}
$$

More precisely, by the properties of the quadratic characters $\eta$, we have that both

$$
T(a, b, h)=p^{m-1}+p^{\frac{m}{2}-1} \text { and } T(a, b, h)=p^{m-1}-p^{\frac{m}{2}-1}
$$

appear

$$
\frac{p^{m}(p-1)\left(p^{m}-1\right)}{2}
$$

times, and both

$$
T(a, b, h)=p^{m-1}+p^{\frac{m}{2}-1}(p-1) \text { and } T(a, b, h)=p^{m-1}-p^{\frac{m}{2}-1}(p-1)
$$

appear

$$
\frac{p^{m}\left(p^{m}-1\right)}{2}
$$

times, respectively.
(3) When $m / d$ is even and $a^{\frac{q-1}{p^{d}+1}}=(-1)^{\frac{m}{2 d}}$, from Lemma 50 we get
$T(a, b, h)= \begin{cases}p^{m-1}-(-1)^{\frac{m}{2 d}} p^{\frac{m}{2}+d-1}(p-1) & \text { if } f(x)=-b^{p^{l}} \text { is solvable and } \\ & h=\operatorname{Tr}\left(a x_{a y, b y}^{p^{p}+1}\right) \\ p^{m-1}+(-1)^{\frac{m}{2 d}} p^{\frac{m}{2}+d-1} & \text { if } f(x)=-b^{p^{l}} \text { is solvable, } b \neq 0 \text { and } \\ & h \neq \operatorname{Tr}\left(a x_{a y}^{p^{p}+b y}\right) \text { or } b=0 \text { and } h \neq 0, \\ p^{m-1} & \text { if } f(x)=-b^{p^{p}} \text { is no solvable. }\end{cases}$
It follows from Lemma 6 that there are $\frac{q-1}{p^{d}+1}$ elements $a \in \mathbb{F}_{q}^{*}$ satisfying $a^{\frac{q-1}{p^{d}+1}}=(-1)^{\frac{m}{2 d}}$, and $p^{m-2 d}$ elements $b \in \mathbb{F}_{q}$ such that $f(x)=-b^{p^{l}}$ is solvable. Therefore,

$$
T(a, b, h)=p^{m-1}+(-1)^{\frac{m}{2 d}+1} p^{\frac{m}{2}+d-1}(p-1)
$$

appears $\frac{p^{m-2 d}\left(p^{m}-1\right)}{p^{d}+1}$ times,

$$
T(a, b, h)=p^{m-1}+(-1)^{\frac{m}{2 d}} p^{\frac{m}{2}+d-1}
$$

appears $\frac{p^{m-2 d}\left(p^{m}-1\right)(p-1)}{p^{d}+1}$ times, and

$$
T(a, b, h)=p^{m-1}
$$

appears $\left(p^{m}-1\right) p^{m-2 d+1}\left(p^{d}-1\right)$ times.
(4) When $m / d \geq 4$ is even and $a^{\frac{q-1}{p^{d}+1}} \neq(-1)^{\frac{m}{2 d}}$, by Lemma 5. we have

$$
T(a, b, h)= \begin{cases}p^{m-1}+(-1)^{\frac{m}{2 d}} p^{\frac{m}{2}-1}(p-1) & \text { if } h=\operatorname{Tr}\left(a x_{a y, b y}^{p^{l}+1}\right), \\ p^{m-1}-(-1)^{\frac{m}{2 d}} p^{\frac{m}{2}-1} & \text { if } h \neq \operatorname{Tr}\left(a x_{a y, b y}^{p+1}\right) .\end{cases}
$$

Particularly, there exist $p^{m}-1-\frac{p^{m}-1}{p^{d}+1}=\frac{p^{d}\left(p^{m}-1\right)}{p^{d}+1}$ elements $a \in \mathbb{F}_{q}^{*}$ such that

$$
a^{\frac{q-1}{p^{d+1}}} \neq(-1)^{\frac{m}{2 d}} .
$$

Then

$$
T(a, b, h)=p^{m-1}+(-1)^{\frac{m}{2 d}} p^{\frac{m}{2}-1}(p-1)
$$

appears $\frac{p^{m+d}\left(p^{m}-1\right)}{p^{d}+1}$ times, and

$$
T(a, b, h)=p^{m-1}-(-1)^{\frac{m}{2 d}} p^{\frac{m}{2}-1}
$$

appears $\frac{p^{m+d}(p-1)\left(p^{m}-1\right)}{p^{d}+1}$ times.
(5) When $m=2 d$, it is clear that $a^{p^{\frac{m}{2}}-1} \neq-1$ for all $a \in \mathbb{F}_{p^{*}}^{*}$, Similarly, by Lemma [5, we have

$$
\begin{aligned}
T(a, b, h) & =\left|\left\{x: \operatorname{Tr}\left(a x^{p^{\frac{m}{2}}+1}+b x\right)+h=0, a \in \mathbb{F}_{p^{\frac{m}{2}}}, x, b \in \mathbb{F}_{q}, h \in \mathbb{F}_{p}\right\}\right| \\
& = \begin{cases}p^{m-1}-p^{\frac{m}{2}-1}(p-1) & \text { if } h=\operatorname{Tr}\left(a x_{a y, b y}^{p^{l}+1}\right), \\
p^{m-1}+p^{\frac{m}{2}-1} & \text { if } h \neq \operatorname{Tr}\left(a x_{a y, b y}^{p^{p}+1}\right) .\end{cases}
\end{aligned}
$$

More precisely, we get

$$
T(a, b, h)=p^{m-1}-p^{\frac{m}{2}-1}(p-1)
$$

appears $\left(p^{\frac{m}{2}}-1\right) p^{m}$ times, and

$$
T(a, b, h)=p^{m-1}+p^{\frac{m}{2}-1}
$$

appears $\left(p^{\frac{m}{2}}-1\right)(p-1) p^{m}$ times.
From all the discussions above, we complete the proof of the theorem.
Now we prove that $\overline{\mathcal{C}^{\perp}}$ is affine invariant.
Lemma 7 The extended code $\overline{\mathcal{C}^{\perp}}$ is affine-invariant.
Proof. We will prove the conclusion with Lemma 1. The defining set $T$ of the cyclic code $\mathcal{C}^{\perp}$ is $T=C_{1} \cup C_{p^{l}+1}$. Since $0 \notin T$, the defining set $\bar{T}$ of $\overline{\mathcal{C}^{\perp}}$ is given by $\bar{T}=C_{1} \cup C_{p^{l}+1} \cup\{0\}$. Let $s \in \bar{T}$ and $r \in \mathcal{P}$. Assume that $r \preceq s$. We need to prove that $r \in \bar{T}$ by Lemma 1 .

If $r=0$, then obviously $r \in \bar{T}$. Consider now the case $r>0$. If $s \in C_{1}$, then the Hamming weight $w t(s)=1$. As $r \preceq s, w t(r)=1$. Consequently, $r \in C_{1} \subset \bar{T}$. If $s \in C_{p^{l}+1}$, then the Hamming weight $w t(s)=2$. As $r \preceq s$, either $w t(r)=1$ or $r=s$. In both cases, $r \in \bar{T}$. The desired conclusion then follows from Lemma 1 Thus we complete the proof of the lemma.

Now we are ready to prove Theorems 4 and 5 .

## Proof of Theorem 4.

By Lemmas 7 and 2, we find that ${\overline{\mathcal{C}^{\perp}}}^{\perp}$ is affine-invariant. Thus the supports of the codewords of weight $i$ with $A_{i} \neq 0$ in ${\overline{\mathcal{C}^{\perp}}}^{\perp}$ give 2-designs from Theorem 1 .

Proof of Theorem 5.
By Theorem 2, one can prove that the number of supports of all codewords with weight $i \neq 0$ in the code $\overline{\mathcal{C}^{\perp}}$ is equal to $A_{i} /(p-1)$ for each $i$, where $A_{i}$ is given in Tables 144. Then the desired conclusions follow from Theorem 4 and Eq.(1). Thus, we complete the proof.

## 5 Concluding remarks

In this paper, first we determined the weight distribution of a class of linear codes derived from the dual of extended cyclic codes with two non-zeros. Using the properties of affine-invariant codes, we then found that the code $\overline{\mathcal{C}}^{\perp}{ }^{\perp}$ holds 2-designs. By computing certain exponential sums, we explicitly determined their parameters. The total number of the 2-designs we obtained is exponential in $m$.
