# CLASSIFICATION OF SIMPLE MODULES WITH FINITE-DIMENSIONAL WEIGHT SPACES FOR THE $N=2$ RAMOND ALGEBRA

#### Abstract

In this paper, we classify all simple weight modules with finite-dimensional weight spaces over the $N=2$ Ramond algebra. Any such module $V$ is either a simple highest weight module or a simple lowest weight module, or a simple cuspidal module with $\mathrm{b}(V) \leq 2$.


## 1. Introduction

Representation theory of the Virasoro algebra has produced a vast amount of applications in physics and mathematics. It is well-known that the classification of simple weight modules with finite-dimensional weight spaces over the Virasoro algebra, conjectured by V. Kac in [14], was completed by Mathieu in [25] (see also [17, 27]). Later, simple weight modules with finitedimensional weight spaces for various extensions of the Virasoro algebra were studied (see [29] for the Weyl algebra, [21, 30] for high rank Virasoro algebras, [22] for the twisted HeisenbergVirasoro algebra, [18] for the Schrödinger-Virasoro algebra, [20] for the generalized HeisenbergVirasoro algebra, etc.). Recently, Billig and Futorny classified all simple weight modules with finite-dimensional weight spaces for the Lie algebra $W_{n}$ of vector fields on an $n$-dimensional torus (see [2]] and the references therein).

Superconformal algebras may be viewed as natural super-extensions of the Virasoro algebra and have been playing a fundamental role in string theory and conformal field theory. In [16] Kac and van de Leur gave a mathematically rigorous definition of a superconformal algebra as follows: (a) it is a $\mathbb{Z}$-graded complex Lie superalgebra, (b) it is graded simple, (c) the dimensions of its graded spaces are uniformly bounded. Furthermore, it contains the Virasoro algebra as a graded subalgebra. In [15], Kac classified all physical superconformal algebras: namely, the $N=0$ (Virasoro), $N=1$ (Neveu-Schwarz), $N=2,3$ and 4 superconformal algebras, the superalgebra $W(2)$ of all vector fields on the $N=2$ supercircle, and a new superalgebra $C K(6)$. Representation theory of superconformal algebras has been the subject of intensive study (see [10, 13, 16], etc.). It is a challenging problem to give complete classifications of simple weight modules with finitedimensional weight spaces for superconformal algebras. In [7] all simple unitary weight modules with finite-dimensional weight spaces over the $N=1$ superconformal algebra were classified, which include highest and lowest weight modules. A complete classification for the $N=1$ superconformal algebra was given by Su in [28] (also see [7, 5]). Such modules (also named graded modules here) for superconformal algebras were also studied in [24], where some cuspidal (also named uniformly bounded) modules were constructed. The problem of classifying such simple modules over superconformal algebras turns out to be more subtle.

[^0]It is well-known that the $N=2$ superconformal algebras fall into four sectors: the Ramond sector, the Neveu-Schwarz sector, the topological sector and the twisted sector. Schwimmer and Seiberg demonstrated that the Neveu-Schwarz sector and Ramond sector are isomorphic in their work [26]. Dijkgraff et al. introduced the topological sector through topological twist in [97]. Interestingly, the topological sector is isomorphic to the untwisted sectors (Neveu-Schwarz), which means there are only two distinct sectors in the $N=2$ superconformal algebras. The main purpose of the present paper is to study simple weight modules with finite-dimensional weight spaces for the Ramond sector (see [12, 26]).

Using the classification result on simple weight modules with finite-dimensional weight spaces for the twisted Heisenberg-Virasoro algebra $t$ in [22] and some facts of Grassmann algebras, we classify all simple cuspidal $\mathfrak{q}^{ \pm}$-modules. With this classification (Proposition 3.3), we can classify all simple cuspidal $\mathfrak{g}$-modules (uniformly bounded modules) to the combinations of the two pieces of simple $\mathfrak{q}^{ \pm}$-modules $U^{ \pm}$as the following diagram (see Proposition 4.1 for details).


By direct calculations we get a useful identity $G_{r_{1}}^{-} G_{r_{2}}^{-} G_{r_{3}}^{-} G_{s_{1}}^{+} G_{s_{2}}^{+} G_{s_{3}}^{+} U^{-}=0, \forall r_{i}, s_{i} \in \mathbb{Z}, i=$ $1,2,3$ for the $\mathfrak{q}^{ \pm}$-modules $U^{ \pm}$, and then obtain our main result for the $N=2$ Ramond algebra. The main theorem can be stated as follows.

Main Theorem (see Theorem 5.2) Let $V$ be a simple weight module with finite-dimensional weight spaces over the $N=2$ Ramond algebra. Then $V$ is a highest weight module, a lowest weight module, or $\mathcal{R}_{a, b, c}^{\prime}$ for some $a, b, c \in \mathbb{C}$ (up to parity-change).

This paper is arranged as follows. In Section 2, we recall some notations and collect known facts about the $N=2$ Ramond algebra. In Section 3, we classify all simple cuspidal modules for the subalgebra $\mathfrak{q}^{ \pm}$of the $N=2$ Ramond algebra. In Section 4, we classify all simple cuspidal modules of the $N=2$ Ramond algebra. In Section 5, we show that all simple non-cuspidal weight modules over the $N=2$ Ramond algebra which turns out to be highest (or lowest) weight modules, and then get the main result of this paper.

Throughout this paper, we shall use $\mathbb{C}, \mathbb{Q}, \mathbb{Z}, \mathbb{Z}^{*}, \mathbb{Z}_{+}$and $\mathbb{N}$ to denote the sets of the complex numbers, the rational numbers, the integers, the non-zero integers, the positive integers and the nonnegative integers, respectively. For convenience, all algebras (vector spaces) are based on the field $\mathbb{C}$, all elements in superalgebras and modules are homogenous unless specified. We always denote by $U(L)$ the universal enveloping algebra of a given Lie (super)algebra $L$, and denote by $L^{n} V:=\operatorname{span}_{\mathbb{C}}\left\{x_{1} x_{2} \cdots x_{n} \cdot v \mid v \in V, x_{i} \in L, i=1,2, \cdots n\right\}$ for any positive integer $n$ and $L$-module $V$. A nonzero $v \in V$ is called a trivial $L$-vector if $L v=0$.

## 2. Preliminaries

In this section, we collect the definitions about the $N=2$ Ramond algebra and some known facts for later use.

Let $L$ be a Lie superalgebra. An $L$-module is a $\mathbb{Z}_{2}$-graded vector space $V=V_{\overline{0}} \oplus V_{\overline{1}}$ together with a bilinear map, $L \times V \rightarrow V$, denoted $(x, v) \mapsto x v$ such that

x(y v)-(-1)^{|x||v|} y(x v)=[x, y] v
$$

for all $x, y \in L, v \in V$, and $L_{\sigma} V_{\tau} \subseteq V_{\sigma+\tau}$ for all $\sigma, \tau \in \mathbb{Z}_{2}$. Thus there is a parity change functor $\Pi$ on the category of $L$-modules, which interchanges the $\mathbb{Z}_{2}$-grading of a module.

The $N=2$ Ramond algebra $\mathfrak{g}$ is a Lie superalgebra over $\mathbb{C}$ with a basis $\left\{L_{m}, H_{m}, G_{m}^{ \pm}, C \mid m \in\right.$ $\mathbb{Z}\}$ and the following relations:

& {\left[L_{m}, G_{p}^{ \pm}\right]=\left(p-\frac{m}{2}\right) G_{p+m}^{ \pm},} \\
& {\left[H_{m}, G_{p}^{ \pm}\right]= \pm G_{m+p}^{ \pm},} \\
& {\left[G_{p}^{+}, G_{q}^{-}\right]=-2 L_{p+q}+(p-q) H_{p+q}+\frac{1}{3}\left(p^{2}-\frac{1}{4}\right) \delta_{p+q, 0} C,} \\

for $m, n, p, q \in \mathbb{Z}$.
The Lie superalgebra $\mathfrak{g}$ is $\mathbb{Z}$-graded by $\left(\mathfrak{g}_{i}\right)_{\overline{0}}=\operatorname{span}_{\mathbb{C}}\left\{L_{i}, H_{i}\right\}+\delta_{i, 0} \mathbb{C} C$ and $\left(\mathfrak{g}_{i}\right)_{\overline{1}}=\operatorname{span}_{\mathbb{C}}\left\{G_{i}^{+}, G_{i}^{-}\right\}$ for any $i \in \mathbb{Z}$. Now we introduce some subalgebras of $\mathfrak{g}$ as follows:

\mathrm{t}:=\mathfrak{g}_{\overline{0}}=\operatorname{span}_{\mathbb{C}}\left\{L_{n}, H_{n}, C \mid n \in \mathbb{Z}\right\} \tag{2.1}
\end{equation*}
$$

which is called the twisted Heisenberg-Virasoro algebra (see [1, 19, 22], etc.).

$$
\begin{equation*}
\mathfrak{q}^{ \pm}:=\operatorname{span}_{\mathbb{C}}\left\{L_{n}, H_{n}, G_{n}^{ \pm}, C \mid n \in \mathbb{Z}\right\}, \tag{2.2}
\end{equation*}
$$

which play a key role in our studies, and will be mainly considered in Section 3.
For any $\mathfrak{g}$-module $V$ and $\lambda \in \mathbb{C}$, set $V_{\lambda}:=\left\{v \in V \mid L_{0} v=\lambda v\right\}$, which is generally called the weight space of $V$ corresponding to the weight $\lambda$. A $\mathfrak{g}$-module $V$ is called a weight module if $V$ is the sum of all its weight spaces.

For a weight module $V=V_{\overline{0}}+V_{\overline{1}}$, we define

\begin{equation*}
\operatorname{Supp}(V):=\left\{\lambda \in \mathbb{C} \mid V_{\lambda} \neq 0\right\} . \tag{2.3}
\end{equation*}
$$

If $V$ is a simple weight $\mathfrak{g}$-module, then there exists $\lambda \in \mathbb{C}$ such that $\operatorname{Supp}(V) \subset \lambda+\mathbb{Z}$. So $V=\sum_{i \in \mathbb{Z}} V_{\lambda+i}$ is $\mathbb{Z}$-graded (sometimes simply denoted by $V=\sum_{i \in \mathbb{Z}} V_{i}$ ). A weight $\mathfrak{g}$-module $V=\sum V_{\lambda+i}$ is called quasi-finite if all $V_{\lambda+i}$ are finite-dimensional. If, in addition, there exists a positive integer $p$ such that

\begin{equation*}
\operatorname{dim}\left(V_{\lambda+i}\right)_{\tau} \leq p, \forall i \in \mathbb{Z}, \forall \tau \in \mathbb{Z}_{2} \tag{2.4}
\end{equation*}
$$

the module $V$ is called cuspidal. In this case denoted by $\mathrm{b}(V)$ the minimal $p$ in (2.4). If $\mathrm{b}(V)=1$, the cuspidal module $V$ is called a module of the intermediate series.

A $\mathfrak{g}$-module $V$ is called a highest (resp. lowest) weight module, if there exists a nonzero $v \in V_{\lambda}$ such that

1) $V$ is generated by $v$ as $\mathfrak{g}$-module with $L_{0} v=\lambda v, G_{0}^{+} v=0, H_{0} v=h^{\prime} v$ and $C v=c v$ for some $h, h^{\prime}, c \in \mathbb{C}$;
2) $\mathfrak{g}_{+} v=0$ (resp. $\mathfrak{g}_{-} v=0$ ), where $\mathfrak{g}_{+}=\sum_{i>0} \mathfrak{g}_{i}, \mathfrak{g}_{-}=\sum_{i<0} \mathfrak{g}_{i}$. Clearly highest or lowest weight modules are quasi-finite.

Similarly, we can define a weight module, a cuspidal module and a module of the intermediate series for the Virasoro algebra Vir and the twisted Heisenberg-Virasoro algebra t .

For $a, b \in \mathbb{C}$, the Vir-module of the intermediate series $\mathcal{A}_{a, b}=\sum_{i \in \mathbb{Z}} \mathbb{C} v_{i}$ was given as follows (see [17]):

L_{m} v_{i}=(a+i+b m) v_{m+i}, \forall i, m \in \mathbb{Z} \tag{2.5}
\end{equation*}
$$

It is well-known that $\mathcal{A}_{a, b} \cong \mathcal{A}_{a+1, b}$ for all $a, b \in \mathbb{C}$, then we can always suppose that $a \notin \mathbb{Z}$ or $a=0$ in $\mathcal{A}_{a, b}$. Moreover, the module $\mathcal{A}_{a, b}$ is simple if $a \notin \mathbb{Z}$ or $b \neq 0,1$. In the opposite case, $\mathcal{A}_{0,0}$ has $\mathbb{C} v_{0}$ as a submodule, and its corresponding quotient is denoted by $\mathcal{A}_{0,0}^{\prime}$. Dually, $\mathcal{A}_{0,1}$ has $\sum_{i \neq 0} \mathbb{C} v_{i}$ as a submodule, which is isomorphic to $\mathcal{A}_{0,0}^{\prime}$. For convenience, we simply write $\mathcal{A}_{a, b}^{\prime}=\mathcal{A}_{a, b}$ when $\mathcal{A}_{a, b}$ is simple.

All simple weight Vir-modules with finite-dimensional weight spaces were classified in [25].
Theorem 2.1. Let V be a simple weight Vir-module with finite-dimensional weight spaces. Then $V$ is a highest weight module, a lowest weight module, or a module of the intermediate series.

Extending this classification in a nontrivial way, Lü and Zhao in [22] classified all simple weight t -modules with finite-dimensional weight spaces.

Theorem 2.2. Let $V$ be a simple weight t -module with finite-dimensional weight spaces. Then $V$ is a highest weight module, a lowest weight module, or a module of the intermediate series $\mathcal{A}_{a, b, c}=\sum_{i \in \mathbb{Z}} \mathbb{C} v_{i}$ for some $a, b, c \in \mathbb{C}$, with

$$
\begin{equation*}
L_{m} v_{i}=(a+i+b m) v_{m+i}, \quad H_{m} v_{i}=c v_{m+i}, \quad \forall i, m \in \mathbb{Z} \tag{2.6}
\end{equation*}
$$

Moreover, the module $\mathcal{A}_{a, b, c}$ is simple if $a \notin \mathbb{Z}$ or $b \neq 0,1$ or $c \neq 0$. For convenience, we also use $\mathcal{A}_{a, b, c}^{\prime}$ to denote the nontrivial simple sub-quotient of $\mathcal{A}_{a, b, c}$.

## 3. Cuspidal modules of the subalgebras $\mathfrak{q}^{ \pm}$

In this section, we classify all simple weight $\mathfrak{q}^{ \pm}$-modules with finite-dimensional weight spaces.

Lemma 3.1. Let $V=\sum V_{i}$ be a cuspidal t -module including no any trivial t -vector. There exists $m \in \mathbb{Z}^{+}$such that for any nonzero $v \in V_{i}, i \in \mathbb{Z}^{*}$, any simple t -module $V^{\prime} \subset U(\mathrm{t}) v$ satisfies

\begin{equation*}
V^{\prime} \subset \sum_{1 \leq k \leq m} \mathrm{t}^{k} v . \tag{3.1}
\end{equation*}
$$

Proof. From representation theory of the Virasoro algebra, $\operatorname{dim} V_{j}=N$ for some positive integer $N$ holds for almost all $j \in \mathbb{Z}$ and $C$ acts on $V$ as zero (see [[17, 23]). Consider a composition series of t -submodules of $U(\mathrm{t}) v$ :

$$
\begin{equation*}
0 \subset V^{\prime}=V^{(1)} \subset V^{(2)} \subset \cdots \subset V^{(p)}=U(\mathrm{t}) v, \tag{3.2}
\end{equation*}
$$

where $V^{(1)}, \cdots, V^{(p)}$ are t-submodules of $V, 1 \leq p \leq N$, and the quotient modules $W^{(j)}=$ $V^{(j)} / V^{(j-1)}=\sum \mathbb{C} \bar{v}_{i}^{(j)}$ are isomorphic to $\mathcal{A}_{a, b_{j}, c_{j}}^{\prime}$ for some $a, b_{j}, c_{j} \in \mathbb{C}$ by Theorem 2.2.

Assume that $0 \neq v=a_{1} v_{i}^{(1)}+\cdots+a_{p} v_{i}^{(p)} \in V_{i}^{(p)}:=V_{i} \cap V^{(p)}$ for some $a_{1}, \cdots a_{p} \in \mathbb{C}$ such that $\left\{v_{i}^{(j)}+V^{(j-1)}, i \in \mathbb{Z}\right\}$ is a basis of $V^{(j)} / V^{(j-1)}$ for $j=1, \cdots, p$, where $V^{(0)}=0$. Then we have

$$
\begin{align*}
& L_{j} v \equiv a_{p}\left(a+b_{p} j+i\right) v_{i+j}^{(p)}\left(\bmod V_{i+j}^{(p-1)}\right)  \tag{3.3}\\
& H_{j} v \equiv c_{p} v_{i+j}^{(p)}\left(\bmod V_{i+j}^{(p-1)}\right) \tag{3.4}
\end{align*}
$$

for any $j \in \mathbb{Z}$.
Now we shall prove that there exists $0 \neq u \in V_{i+k}^{(p-1)}$ for some $k \in \mathbb{Z}$ such that

$$
\begin{equation*}
u \in \sum_{i=1}^{2} \mathrm{t}^{i} v \tag{3.5}
\end{equation*}
$$

case by case.
Case 0. $V^{(p)} / V^{(p-1)}$ is a trivial t-module. In this case $\mathrm{t} v \in V^{(p-1)}$. If $\mathrm{t} v=0$, then $v$ is a trivial t -vector. It gets a contradiction. So $\mathrm{t} v \neq 0$, and then (3.5) holds.
Case 1. $c_{p} \neq 0$. In this case, for any $k, k^{\prime} \in \mathbb{Z}, X, Y \in\{L, H\}$, there exists $d_{k, k^{\prime}} \in \mathbb{C}$ such that $u=X_{k^{\prime}} Y_{k-k^{\prime}} v-d_{k, k^{\prime}} H_{k} v \in V_{i+k}^{(p-1)}$ if $X_{k^{\prime}} Y_{k-k^{\prime}} v \neq 0$ by (3.3) and (3.4). If $u$ is always zero, then

$$
X_{k^{\prime}} Y_{k-k^{\prime}} v=d_{k, k^{\prime}} H_{k} v, \forall X, Y \in\{L, H\}, k, k^{\prime} \in \mathbb{Z}
$$

for some $d_{k, k^{\prime}} \in \mathbb{C}$. Then $\operatorname{span}_{\mathbb{C}}\left\{H_{k} v \mid k \in \mathbb{Z}\right\}$ becomes a t-submodule and $p=1$. So (3.5) holds.
Case 2. $c_{p}=0$. In this case, $H_{j} v \in V_{i+j}^{(p-1)}$ for any $j \in \mathbb{Z}$. So there exists $u=H_{k} v \in V_{i+k}^{(p-1)}$ such that $0 \neq u \in \operatorname{tv}$ by (3.4) if $H_{k} v \neq 0$ for some $k \in \mathbb{Z}$. In this case (3.5) also holds.

Case 3. Now we can suppose that $H_{j} v=0$ for any $j \in \mathbb{Z}$, then $U(\mathrm{t}) v=U(\operatorname{Vir}) v$.
Subcase 3.1. $L_{j} v \notin V_{i+j}^{(p-1)}, \forall j \in \mathbb{Z}$. For any $k^{\prime} \in \mathbb{Z}$, there exists $d \in \mathbb{C}$ such that $u=L_{k^{\prime}} L_{k-k^{\prime}} v-$ $d L_{k} v \in V_{i+k}^{(p-1)}$ if $L_{k^{\prime}} L_{k-k^{\prime}} v \neq 0$ by (3.3). Similarly, if the $u$ is always zero, then $\operatorname{span}_{\mathbb{C}}\left\{L_{k} v \mid k \in \mathbb{Z}\right\}$ becomes a Vir-submodule and then $p=1$. So (3.5) still holds.
Subcase 3.2. $u=L_{k} v \in V_{i+k}^{(p-1)}$ for some $k \in \mathbb{Z}$. In this case (3.5) holds if $L_{k} v \neq 0$.
Subcase 3.3. The only left case is that $L_{k_{0}} v=0$ for some $k_{0} \in \mathbb{Z}$. In this case $L_{j} v \notin V_{i+j}^{(p-1)}$ for any $j \neq k_{0}$ by (3.3). As in Subcase 3.1, for any $k \neq k_{0}, k^{\prime} \in \mathbb{Z}$, there exists $d_{k, k^{\prime}} \in \mathbb{C}$ such that $u=L_{k^{\prime}} L_{k-k^{\prime}} v-d_{k, k^{\prime}} L_{k} v \in V_{i+k}^{(p-1)}$ if $L_{k^{\prime}} L_{k-k^{\prime}} v \neq 0$.

Suppose that the above $u$ is always zero, then

$$
L_{k^{\prime}} L_{k-k^{\prime}} v=d_{k, k^{\prime}} L_{k} v
$$

for some $d_{k, k^{\prime}} \in \mathbb{C}$ if $k \neq k_{0}$. Moreover, for any $k \neq k_{0}, k \neq 0, j \neq 0,(k-2 j) L_{k} L_{k_{0}-k} v=$ $\left[L_{j}, L_{k-j}\right] L_{k_{0}-k} v=L_{j} L_{k-j} L_{k_{0}-k} v-L_{k-j} L_{j} L_{k_{0}-k} v=d_{k-j, k_{0}-k} L_{j} L_{k_{0}-j} v-d_{k-j, j} L_{k} L_{k_{0}-k} v$. So we have

$$
L_{j} L_{k_{0}-j} v=\frac{(k-2 j)+d_{k-j, j}}{d_{k-j, k_{0}-k}} L_{k} L_{k_{0}-k} v,
$$

where $d_{k-j, k_{0}-k} \neq 0$ since $L_{j} v \notin V_{i+j}^{(p-1)}$ for any $j \neq k_{0}$. In this case $\sum_{j \in \mathbb{Z}, j \neq k_{0}} \mathbb{C} L_{j} v+\mathbb{C} u_{k_{0}}$ becomes a Vir-submodule, where $u_{k_{0}}=L_{k} L_{k_{0}-k} \nu \neq 0$ for some $k \in \mathbb{Z}^{*}$. Then $p=1$.

Now (3.5) holds in all cases. If $k+i=0$, we can replace $u$ by $L_{j} u$ or $H_{j} u$ for some $j \neq 0$ and get that there exists $0 \neq u \in V_{i+k}^{(p-1)}$ for some $k \in \mathbb{Z}$ with $k+i \neq 0$ such that

$$
\begin{equation*}
u \in \sum_{i=1}^{3} \mathrm{t}^{i} v . \tag{3.6}
\end{equation*}
$$

By induction we can find $v_{j}^{(1)} \in \sum_{1 \leq k \leq 3 p} t^{k} v$ for some $j \in \mathbb{Z}$ and then

$$
\begin{equation*}
V^{\prime} \subset \sum_{1 \leq k \leq 3 p+2} \mathrm{t}^{k} v \tag{3.7}
\end{equation*}
$$

since $L_{k-j} v_{j}^{(1)}=\left(a+b_{1}(k-j)+j\right) v_{k}^{(1)}$ and $H_{k-j} v_{j}^{(1)}=c_{1} v_{k}^{(1)}$ for any $k \in \mathbb{Z}$. Set $m=3 N+2 \geq 3 p+2$, the lemma follows.

Set $\mathcal{O}_{n}:=\{0, \pm 1, \pm 2, \cdots, \pm n\}$ for $n \in \mathbb{Z}_{+}$. We denote $\mathfrak{q}:=\mathfrak{q}^{+}\left(\cong \mathfrak{q}^{-}\right), G_{j}:=G_{j}^{+}$for all $j \in \mathbb{Z}$ and $\mathfrak{q}_{\bar{i}}=\operatorname{span}_{\mathbb{C}}\left\{G_{j} \mid j \in \mathbb{Z}\right\}$.
Lemma 3.2. Let $V$ be $a \mathfrak{q}$-module. Suppose that there exist $n, m \in \mathbb{Z}_{+}$and $n>m$ such that

\end{equation*}

for all $r_{1}, r_{2}, \cdots r_{m} \in \mathcal{O}_{n}$, then (3.8) holds for all $r_{1}, r_{2}, \cdots r_{m} \in \mathbb{Z}$.
Proof. We shall use the induction on $n$ and first prove that

$$
G_{r_{1}} \cdots G_{r_{m-1}} G_{n+1} V=0
$$

for all $r_{1}, r_{2}, \cdots, r_{m-1} \in \mathcal{O}_{n}$.
By action of $L_{n+1-r_{m}}$ on (3.8) (where $r_{1}<r_{2}<\cdots<r_{m}$ ) we get

$$
\begin{equation*}
G_{r_{1}} G_{r_{2}} \cdots G_{r_{m-1}} G_{n+1} V=0 \tag{3.9}
\end{equation*}
$$

for all $-n \leq r_{1}<r_{2}<\cdots<r_{m-1} \leq n-1$. The left is to prove that

$$
G_{r_{1}} G_{r_{2}} \cdots G_{r_{m-2}} G_{n} G_{n+1} V=0
$$

for all $r_{1}, r_{2}, \cdots r_{m-2} \in \mathcal{O}_{n}$.
By actions of $L_{1}$ and $H_{1}$ on (3.9) with $r_{m-1}=n-1$, we get

$$
\begin{align*}
& \left(\left(n-\frac{3}{2}\right) G_{r_{1}} \cdots G_{r_{m-2}} G_{n} G_{n+1}+\left(n+\frac{1}{2}\right) G_{r_{1}} \cdots G_{r_{m-2}} G_{n-1} G_{n+2}\right) V=0,  \tag{3.10}\\
& \left(G_{r_{1}} \cdots G_{r_{m-2}} G_{n} G_{n+1}+G_{r_{1}} \cdots G_{r_{m-2}} G_{n-1} G_{n+2}\right) V=0 . \tag{3.11}
\end{align*}
$$

Combining with (3.10) and (3.11), we get

$$
\begin{equation*}
G_{r_{1}} \cdots G_{r_{m-2}} G_{n} G_{n+1} V=0 \tag{3.12}
\end{equation*}
$$

for all $-n \leq r_{1}<\cdots<r_{m-2} \leq n-2$.
In the same way, by the actions of $L_{1}$ and $H_{1}$ on (3.12) with $r_{m-2}=n-2$, we get

$$
\begin{equation*}
G_{r_{1}} \cdots G_{r_{m-3}} G_{n-1} G_{n} G_{n+1} V=0 \tag{3.13}
\end{equation*}
$$

for all $-n \leq r_{1}<r_{2}<\cdots<r_{m-3} \leq n-3$.
Repeating the above steps by setting $r_{m-3}=n-3, \cdots, r_{1}=n-m+1$, respectively, we can get $G_{r_{1}} G_{r_{2}} \cdots G_{r_{m-1}} G_{n+1} V=0$ for all $r_{1}, r_{2}, \cdots r_{m-1} \in \mathcal{O}_{n}$.

Similarly we can get $G_{-n-1} G_{r_{2}} G_{r_{3}} \cdots G_{r_{m}} V=0$ for all $r_{2}, r_{3}, \cdots r_{m} \in \mathcal{O}_{n}$. Then (3.8) holds for all $r_{1}, r_{2}, \cdots r_{m} \in \mathcal{O}_{n+1}$. The lemma follows by induction on $n$.

Proposition 3.3. Let $V=\sum V_{i}$ be a simple cuspidal $\mathfrak{q}$-module. Then $V$ is isomorphic to $a \mathfrak{q}$ module of the intermediate series: $V=\sum \mathbb{C} v_{i} \cong \mathcal{A}_{a, b, c}^{\prime}$ for some $a, b, c \in \mathbb{C}$ with

$$
L_{m} v_{i}=(a+i+b m) v_{m+i}, \quad H_{j} v_{i}=c v_{i+j}, \quad G_{j} V=0
$$

for all $m, i, j \in \mathbb{Z}$.
Proof. Clearly there exists some positive integer $N$ such that $\operatorname{dim} V_{i} \leq N$ holds for almost $i \in \mathbb{Z}$ and $C$ acts on $V$ as zero (see [17, [23]). Now $q_{\overline{1}}^{i} V$ is $q^{-}$submodule since $q_{\overline{1}}^{i+1} V \subset q_{\overline{1}}^{i} V$ for all $i \in \mathbb{N}$. So $\mathfrak{q}_{\overline{1}} V=V$ or $\mathfrak{q}_{\overline{1}} V=0$.

If there exists a trivial t -vector $v \in V$, then $V=U\left(\mathfrak{q}_{\overline{1}}\right) v$. Clearly $V=\mathbb{C} v+\sum_{i \geq 1} \mathfrak{q}_{\overline{1}}^{i} v$. Moreover we have $\mathfrak{q}_{\overline{1}}^{i} v=\left\{v \in V \mid H_{0} v=i v\right\}$ for any $i \in \mathbb{Z}_{+}$. It is easy to see that $\mathfrak{q}_{\overline{1}} v=0$. Otherwise $\sum_{i \geq 1} \mathfrak{q}_{\overline{1}}^{i} v$ is a proper $\mathfrak{q}$-submodule of $V$. So we can suppose that $V$ does not contain any trivial t-vectors.
Claim For any $n \in \mathbb{Z}_{+}$, there exists $0 \neq v \in V_{i}$ for some $i \in \mathbb{Z}^{*}$ such that $G_{r} v=0$ for all $r \in \mathcal{O}_{n}$.
In fact, if $G_{r} v \neq 0$ for some $r \in \mathcal{O}_{n}$, we may replace $v$ by $G_{r} v \in V_{r+i}$. So this claim holds for any $n \in \mathbb{Z}_{+}$.

Choose $n \gg N$ for the $v, n$ in the Claim. Clearly $t v \neq 0$ (otherwise $\mathbb{C} v$ is a trivial $t$-module). By Theorem 2.2, we can choose a simple t-module $V^{\prime}=\sum \mathbb{C} v_{i} \cong \mathcal{A}_{a, b, c}^{\prime} \subset U(\mathrm{t}) v$ for some $a, b, c \in \mathbb{C}$, and then $V=U\left(\mathfrak{q}_{\overline{1}}\right) V^{\prime}$. By Lemma 3.1, there exists $m \in \mathbb{Z}^{+}$with $m<n$ such that

$$
\begin{equation*}
V^{\prime} \subset \sum_{k \leq m} \mathrm{t}^{k} v . \tag{3.14}
\end{equation*}
$$

Now for all $r_{1}, r_{2}, \cdots r_{m} \in \mathcal{O}_{n}$, we have

$$
G_{r_{1}} G_{r_{2}} \cdots G_{r_{m}} V^{\prime} \subseteq \bigoplus_{j=1}^{m} x_{j} G_{r_{j}} v=0
$$

where the $x_{j}$ 's are some elements in $U(\mathfrak{q})$. It follows from $V=U\left(\mathfrak{q}_{\overline{1}}\right) V^{\prime}$ that

$$
G_{r_{1}} G_{r_{2}} \cdots G_{r_{m}} V=0, \quad \forall r_{1}, r_{2}, \cdots r_{m} \in \mathcal{O}_{n}
$$

By Lemma 3.2, we get

$$
\begin{equation*}
\mathfrak{q}_{\overline{1}}^{m} V=0 . \tag{3.15}
\end{equation*}
$$

If $\mathfrak{q}_{\overline{1}} V=V$ then $\mathfrak{q}_{\overline{1}}^{m} V=V=0$, which is a contradiction. So $\mathfrak{q}_{\overline{1}} V=0$ and the proposition follows from Theorem 2.2.

Remark 3.4. Recently, Proposition 3.3 was proved in [6] by the different methods.

## 4. Classification of simple cuspidal $\mathfrak{g}$-modules

In this section we shall classify all simple cuspidal modules for the $N=2$ Ramond algebra g.

Proposition 4.1. Let $V$ be a simple cuspidal $\mathfrak{g}$-module. Then $\mathrm{b}(V) \leq 2$.

Proof. Clearly $C$ acts on $V$ as zero.
Now the subalgebras $\mathfrak{q}^{ \pm}=\operatorname{span}_{\mathbb{C}}\left\{L_{m}, H_{m}, G_{m}^{ \pm}, C \mid m \in \mathbb{Z}\right\}$ are all isomorphic to the Lie superalgebra $\mathfrak{q}$ in Section 3. The even part $\mathfrak{g}_{\overline{0}}$ is just the twisted Heisenberg-Virasoro algebra $t$ in Section 2.2.

If there exists a trivial $\mathfrak{q}^{+}$-vector $v \in V$, then $V=U\left(\mathfrak{q}_{\overline{1}}^{-}\right) v$. Clearly $V=\mathbb{C} v+\sum_{i \geq 1}\left(\mathfrak{q}_{\overline{1}}^{-}\right)^{i} v$ since $\left(\mathfrak{q}_{\overline{1}}^{-}\right)^{i} v=\left\{v \in V \mid H_{0} v=i v\right\}$ for any $i \in \mathbb{Z}_{+}$. It is easy to see that $\mathfrak{q}_{\overline{1}}^{-} v=0$. Otherwise $\sum_{i \geq 1}\left(\mathfrak{q}_{\overline{1}}^{-}\right)^{i} v$ is a proper $\mathfrak{g}$-submodule of $V$. So we can suppose that $V$ does not contain any trivial $\mathfrak{q}^{ \pm}$-vector.

By Proposition 3.3, we can choose a simple $\mathfrak{q}^{+}$-module $U^{+}=\sum \mathbb{C} u_{i}^{+}$of $V$ such that $G_{r}^{+} U^{+}=$ 0 for all $r \in \mathbb{Z}$. In this case $V=U\left(G^{-}\right) U^{+}$, where $G^{-}=\operatorname{span}_{\mathbb{C}}\left\{G_{r}^{-} \mid r \in \mathbb{Z}\right\}$ is a subalgebra of $\mathfrak{g}$.

Now we can suppose that $G^{-} U^{+} \neq 0$ (otherwise $V$ is a trivial $\mathfrak{g}$-module). Set $\left(G^{-}\right)^{0} U^{+}=U^{+}$ and $\left(G^{-}\right)^{i+1} U^{+}=G^{-}\left(G^{-}\right)^{i} U^{+}$for all $i \geq 0$. Then we have $G^{+}\left(G^{-}\right)^{i+1} U^{+} \subset\left(G^{-}\right)^{i} U^{+}$. Moreover

$$
\begin{equation*}
V=\sum_{i \geq 0}\left(G^{-}\right)^{i} U^{+} . \tag{4.1}
\end{equation*}
$$

By Proposition 3.3 we can choose a simple $\mathfrak{q}^{-}$-module $U^{-}$of $V$ such that $U^{-}=\sum \mathbb{C} u_{j}^{-} \cong$ $\mathcal{A}_{a, b, c}^{\prime}$ with $L_{m} u_{j}^{-}=(a+b m+j) u_{m+j}^{-}, H_{m} u_{j}^{-}=c u_{m+j}^{-}$and $G_{m}^{-} u_{j}^{-}=0$ for any $m, j \in \mathbb{Z}$, for some $a, b, c \in \mathbb{C}$.

Suppose that

$$
\begin{equation*}
u_{i}^{-} \in\left(G^{-}\right)^{n} U^{+} \tag{4.2}
\end{equation*}
$$

for some $i \in \mathbb{Z}$ and $n \in \mathbb{Z}_{+}$. By the actions of suitable $L_{m}$ 's or $H_{m}$ 's on (4.2) we get $U^{-} \subset\left(G^{-}\right)^{n} U^{+}$.
In this case,

$$
\begin{equation*}
V=\sum_{i=0}^{n}\left(G^{+}\right)^{i} U^{-}=\sum_{j=0}^{n}\left(G^{-}\right)^{j} U^{+} \tag{4.3}
\end{equation*}
$$

and $\left(G^{+}\right)^{n} U^{-} \subset\left(G^{+}\right)^{n}\left(G^{-}\right)^{n} U^{+} \subset U^{+}$(see the diagram below). Moreover $\left(G^{+}\right)^{n} U^{-} \neq 0$ (in fact, if $\left(G^{+}\right)^{n} U^{-}=0$, replace $U^{+}$by $U^{-}$and repeate the above step, one has $\left(G^{-}\right)^{n} U^{+}=0$ ). By the irreducibility of $U^{+}$as t-module, we get

$$
\begin{equation*}
\left(G^{+}\right)^{n} U^{-}=U^{+} \tag{4.4}
\end{equation*}
$$

So we have the following diagram:


Moreover from the diagram we see that $\left(G^{-}\right)^{n} U^{+}=U^{-}$and $\left(G^{-}\right)^{i} U^{+}=\left(G^{+}\right)^{n-i} U^{-}$for all $0 \leq i \leq n$. In fact, from $U^{-} \subset\left(G^{-}\right)^{n} U^{+}$, we can get $\left(G^{+}\right)^{n} U^{-} \subset U^{+}$. Due to that $U^{+}$is irreducible, $U^{+}=\left(G^{-}\right)^{n} U^{-}$. So $\left(G^{-}\right)^{i} U^{+} \subset\left(G^{+}\right)^{n-i} U^{-}$by actions of suitable $G^{-}$.

Now by Lemma 4.3 below we see that $n \leq 2$ and get the proposition.
If $n=1$, then $V=U^{+}+U^{-}$and $G^{-} U^{+}=U^{-}$by (4.4).
If $n=2$, then $V=U^{+}+G^{-} U^{+}+U^{-}$and $G^{-} U^{+}=G^{+} U^{-}$by (4.4).

For convenience, set $K_{r, s}=\left[G_{r}^{+}, G_{s}^{-}\right]=-2 L_{r+s}+(r-s) H_{r+s}$, then we have the following equalities:

$$
\begin{align*}
& K_{r, s} u_{i}^{-}=(-2(a+b(r+s)+i)+(r-s) c) u_{r+s+i}^{-},  \tag{4.5}\\
& {\left[K_{r, s}, G_{t}^{+}\right]=2(r-t) G_{r+s+i}^{+} .} \tag{4.6}
\end{align*}
$$

Lemma 4.2. For any $r_{1}, r_{2}, s_{1}, s_{2} \in \mathbb{Z}$,

$$
\begin{equation*}
G_{r_{1}}^{-} G_{r_{2}}^{-} G_{s_{1}}^{+} G_{s_{2}}^{+} u_{i}^{-}=d\left(s_{2}-s_{1}\right)\left(r_{1}-r_{2}\right) u_{i+r+s+s_{1}+s_{2}}^{-}, \tag{4.7}
\end{equation*}
$$

where $d=(2 b+c)(2+c-2 b)$.
Proof. By (4.5) and (4.6) we have

& G_{r_{1}}^{-} G_{r_{2}}^{-} G_{s_{1}}^{+} G_{s_{2}}^{+} u_{i}^{-} \\
= & G_{r_{1}}^{-} K_{s_{1}, r_{2}} G_{s_{2}}^{+} u_{i}^{-}-G_{r_{1}}^{-} G_{s_{1}}^{+} G_{r_{2}}^{-} G_{s_{2}}^{+} u_{i}^{-} \\
= & G_{r_{1}}^{-} G_{s_{2}}^{+} K_{s_{1}, r_{2}}^{-} u_{i}^{-}+2\left(s_{1}-s_{2}\right) G_{r_{1}}^{-} G_{s_{2}+s_{1}+r_{2}}^{+} u_{i}^{-}-G_{r_{1}}^{-} G_{s_{1}}^{+} K_{s_{2}, r_{2}} u_{i}^{-} \\
= & K_{s_{2}, r_{1}} K_{s_{1}, r_{2}} u_{i}^{-}-K_{s_{1}, r_{1}} K_{s_{2}, r_{2}} u_{i}^{-}+2\left(s_{1}-s_{2}\right) K_{s_{1}+s_{2}+r_{2}, r_{1} u_{i}^{-}} \\
= & \left(-2\left(a+b\left(s_{1}+r_{2}\right)+i\right)+\left(s_{1}-r_{2}\right) c\right)\left(-2\left(a+b\left(s_{2}+r_{1}\right)+i+s_{1}+r_{2}\right)+\left(s_{2}-r_{1}\right) c\right) u^{-} \\
& -\left(-2\left(a+b\left(s_{2}+r_{2}\right)+i\right)+\left(s_{2}-r_{2}\right) c\right)\left(-2\left(a+b\left(s_{1}+r_{1}\right)+i+s_{2}+r_{2}\right)+\left(s_{1}-r_{1}\right) c\right) u^{-} \\
& +2\left(s_{1}-s_{2}\right)\left(-2\left(a+b\left(r_{1}+r_{2}+s_{2}+s_{2}\right)+i\right)+\left(s_{1}+s_{2}+r_{2}-r_{1}\right) c\right) u^{-} \\
= & (2+c-2 b)(2 b+c)\left(s_{2}-s_{1}\right)\left(r_{1}-r_{2}\right) u^{-},
\end{aligned}
$$

where $u^{-}=u_{i+r_{1}+r_{2}+s_{1}+s_{2}}^{-}$.
Now we shall derive a key identity.
Lemma 4.3. For any $r_{1}, r_{2}, r_{3}, s_{1}, s_{2}, s_{3} \in \mathbb{Z}$,

for any $i \in \mathbb{Z}$, where $u^{-}=u_{i+r_{1}+r_{2}+r_{3}+s_{1}+s_{2}+s_{3}}^{-}$.

Next we shall determine the precise structure of the simple cuspidal $\mathfrak{g}$-modules.
Proposition 4.4. Let $V$ be a simple cuspidal $\mathfrak{g}$-module of the intermediate series, then $V$ is isomorphic to the simple sub-quotient of $\mathcal{R}_{a, b}$ (up to parity-change) for some $a, b \in \mathbb{C}$, where $\mathcal{R}_{a, b}:=\sum \mathbb{C} v_{i}^{+}+\sum \mathbb{C} v_{i}^{-}$with

$$
\begin{align*}
L_{m} v_{i}^{+} & =(a+i+b m) v_{m+i}^{+},  \tag{4.9}\\
L_{m} v_{i}^{-} & =\left(a+i+\left(b-\frac{1}{2}\right) m\right) v_{m+i}^{-},  \tag{4.10}\\
H_{m} v_{i}^{+} & =(2-2 b) v_{m+i}^{+},  \tag{4.11}\\
H_{m} v_{i}^{-} & =(1-2 b) v_{m+i}^{-},  \tag{4.12}\\
G_{m}^{-} v_{i}^{+} & =v_{m+i}^{-},  \tag{4.13}\\
G_{m}^{+} v_{i}^{-} & =-(2 a+(4 b-2) m+2 i) v_{m+i}^{+} \tag{4.14}
\end{align*}
$$

for all $m, i \in \mathbb{Z}$.
Proof. In this case $V=U^{+}+U^{-}$and $G^{-} U^{+}=U^{-}$by Proposition 4.1, where $U^{ \pm}$are simple t -modules.

Set $U^{+}=\sum \mathbb{C} v_{i}^{+} \cong \mathcal{A}_{a, b, c}^{\prime}$ for some $a, b, c \in \mathbb{C}$. Due to that $G^{-} U^{+}=U^{-}$, we can suppose that $U^{-}=\sum \mathbb{C} v_{i}^{-} \cong \mathcal{A}_{a, b^{-}, c^{-}}^{\prime}$ for some $b^{-}, c^{-} \in \mathbb{C}$ and $G_{r}^{-} v_{i}^{+}=g(r, i) v_{r+i}^{-}$for almost all $0 \neq g(r, i) \in \mathbb{C}$. By $\left[L_{m}, G_{n}^{-}\right] v_{i}^{+}=\left(n-\frac{m}{2}\right) G_{m+n}^{-} v_{i}^{+}$and $\left[H_{m}, G_{n}^{-}\right] v_{i}^{+}=-G_{m+n}^{-} v_{i}^{+}$, we have

$$
\begin{gather*}
\left(a+b^{-} m+n+i\right) g(n, i)-(a+b m+i) g(n, m+i)=\left(n-\frac{m}{2}\right) g(m+n, i),  \tag{4.15}\\
c^{-} g(n, i)-c g(n, m+i)=-g(m+n, i), \forall m, n, i \in \mathbb{Z} . \tag{4.16}
\end{gather*}
$$

Let $m=0$ in (4.16), then we get $c^{-}=c-1$.
Case 1. $c=0$.
In fact, if $c=0$, then $c^{-}=-1$. For any $n, i \in \mathbb{Z}$, by (4.16) we get $g(n, i)=g(i)$ for some $g(i) \in$ $\mathbb{C}$. So we can suppose that $G_{n}^{+} v_{i}^{-}=h(n, i) v_{n+i}^{+}$for some $h(n, i) \in \mathbb{C}$. By $\left[H_{m}, G_{n}^{+}\right] v_{i}^{-}=G_{m+n}^{+} v_{i}^{-}$, we have $h(n, i)=h(n+i)$ for some $h(n) \in \mathbb{C}$ for any $n, i \in \mathbb{Z}$. By

$$
\left[G_{n}^{+}, G_{m}^{-}\right] v_{i}^{-}=-2 L_{m+n} v_{i}^{+}+(n-m) H_{m+n} v_{i}^{-},
$$

we get

$$
h(n+i) g(n+i)=-2\left(a+b^{-}(m+n)+i\right)-(n-m)
$$

for any $m, n, i \in \mathbb{Z}$. Then $b^{-}=\frac{1}{2}$. Similarly, by $\left[G_{n}^{+}, G_{m}^{-}\right] v_{i}^{+}=-2 L_{m+n} v_{i}^{+}+(n-m) H_{m+n} v_{i}^{+}$, we get $b=1$. Then $g(n, i)=g(0,0)$ for all $n, i \in \mathbb{Z}$ follows by (4.15).
Case 2. $c=1$.
It is similar to prove that $g(n, i)=g(0,0)$ for all $n, i \in \mathbb{Z}$ as in Case 1.
Case 3. $c \neq 0,1$.
Setting $i=0$ in (4.16) we get

$$
\begin{equation*}
g(n, m)=\frac{c-1}{c} g(n, 0)+\frac{1}{c} g(m+n, 0), \forall m, n \in \mathbb{Z} . \tag{4.17}
\end{equation*}
$$

Substituting (4.17) into (4.16) we get

$$
\begin{equation*}
g(m+n+i, 0)=g(n+i, 0)+g(n+m, 0)-g(n, 0), \forall n, m, i \in \mathbb{Z} . \tag{4.18}
\end{equation*}
$$

By (4.18) we get $g(m, 0)=g(0,0)$ and then $g(m, n)=g(0,0)$ for all $m, n \in \mathbb{Z}$ by (4.16) again.
So in all cases we have $g(m, n)=g(0,0)$ for all $m, n \in \mathbb{Z}$. Moreover, we have $b^{-}=b-\frac{1}{2}$ by (4.15). By direct calculations, we obtain

$$
\begin{aligned}
& L_{m} v_{i}^{+}=(a+i+b m) v_{m+i}^{+}, \quad L_{m} v_{i}^{-}=\left(a+i+\left(b-\frac{1}{2}\right) m\right) v_{m+i}^{-} \\
& H_{m} v_{i}^{+}=(2-2 b) v_{m+i}^{+}, \quad H_{m} v_{i}^{-}=(1-2 b) v_{m+i}^{-}, \\
& G_{m}^{-} v_{i}^{+}=v_{m+i}^{-}, \quad G_{m}^{+} v_{i}^{-}=-(2 a+(4 b-2) m+2 i) v_{m+i}^{+}
\end{aligned}
$$

for all $m, i \in \mathbb{Z}$.
Remark 4.5. $\mathcal{R}_{a, b}$ is not simple if and only if $a=0, b=1$ or $a=0, b=\frac{1}{2}$. All indecomposable modules of of the intermediate series were given in [1]].
Proposition 4.6. Let $V$ be a simple cuspidal $\mathfrak{g}$-module with $\mathrm{b}(V)=2$, then $V$ is isomorphic to $\mathcal{R}_{a, b, c}$ (up to parity-change) for some $a, b, c \in \mathbb{C}$ and $2 b \pm c \neq 2$, where $\mathcal{R}_{a, b, c}:=\left(U+U^{+-}\right) \oplus\left(U^{+}+\right.$ $U^{-}$) with

$$
\begin{align*}
& L_{m} v_{i}=(a+i+b m) v_{m+i}, \quad L_{m} v_{k}^{ \pm}=\left(a+k+\left(b-\frac{1}{2}\right) m\right) v_{m+k}^{ \pm},  \tag{4.19}\\
& H_{m} v_{i}=c v_{m+i}, \quad H_{m} v_{k}^{ \pm}=(c \pm 1) v_{m+k}^{ \pm},  \tag{4.20}\\
& G_{r}^{ \pm} v_{i}=v_{r+i}^{ \pm}, \quad G_{r}^{ \pm} v_{i}^{ \pm}=0,  \tag{4.21}\\
& L_{m} v_{i}^{+-}=(a+i+(b-1) m) v_{m+i}^{+-}+\frac{1}{2}(2 b-c-2) m^{2} v_{i+m},  \tag{4.22}\\
& H_{m} v_{i}^{+-}=c v_{m+i}^{+-}-m(2 b-c-2) v_{m+i},  \tag{4.23}\\
& G_{r}^{+} v_{k}^{-}=v_{k+r}^{+-}+(c+2-2 b) r v_{k+r},  \tag{4.24}\\
& G_{r}^{-} v_{k}^{+}=-v_{r+k}^{+-}-(2 a+2 k+(2 b+c) r) v_{k+r},  \tag{4.25}\\
& G_{r}^{-} v_{i}^{+-}=-(2 a+2 i+(2 b+c-2) r) v_{r+i}^{-},  \tag{4.26}\\
& G_{r}^{+} v_{i}^{+-}=(2 b-c-2) r v_{r+i}^{+}, \quad \forall m, r, i \in \mathbb{Z} . \tag{4.27}
\end{align*}
$$

Proof. In this case $n=2, V=U^{+}+G^{-} U^{+}+U^{-}$and $G^{-} U^{+}=G^{+} U^{-}$by Proposition 4.1.
First we can choose a simple t-module $U=\sum \mathbb{C} v_{i} \cong \mathcal{A}_{a, b, c}^{\prime}$ of $G^{-} U^{+}$for some $a, b, c \in \mathbb{C}$. Due to $U^{ \pm}=G^{ \pm} U$ are all simple t-modules, we can get $U^{ \pm}=\sum \mathbb{C} v_{i}^{ \pm} \cong \mathcal{A}_{a, b-\frac{1}{2}, c \pm 1}^{\prime}$ as in Case 1 . So we can obtain (4.19), (4.20), (4.21) and the coefficients of $v_{m+i}^{+-}$in (4.22) and (4.23).

Notice that the quotient module $G^{-} U^{+} / U=\sum \mathbb{C} \bar{v}_{i}^{+-}\left(\right.$or $\left.G^{+} U^{-} / U\right)$ is also a simple t-module, and ismorphic to $\mathcal{A}_{a, b-1, c}^{\prime}$ as in Case 1 . So we can suppose that

$$
G_{r}^{+} v_{k}^{-}=v_{r+k}^{+-}+g(r, k) v_{r+k}
$$

for some $g(r, k) \in \mathbb{C}$ and for any $r, k \in \mathbb{Z}$. Moreover, replace $v_{k}^{+-}+g(0, k) v_{k}$ by $v_{k}^{+-}$one has $G_{0}^{+} v_{k}^{-}=v_{k}^{+-}$. It is

$$
\begin{equation*}
g(0, k)=0, \quad \forall r, k \in \mathbb{Z} \tag{4.28}
\end{equation*}
$$

By the action of $G_{s}^{-}$on $G_{r}^{+} v_{i}=v_{r+i}^{+}$for any $r, s, i \in \mathbb{Z}$, we can get

$$
G_{r}^{-} v_{k}^{+}=-v_{r+k}^{+-}+h(r, k) v_{k+r}
$$

for some $h(r, k) \in \mathbb{C}$. By $\left[G_{r}^{+}, G_{r}^{-}\right] v_{k}=-2 L_{2 r} v_{k}$, one has

$$
\begin{equation*}
g(r, k)+h(r, k)=-2(a+(2 b-1) r+k), \forall r, k \in \mathbb{Z} \tag{4.29}
\end{equation*}
$$

By $\left[H_{m}, G_{r}^{-}\right] v_{k}^{+}=-G_{m+r}^{-} v_{k}^{+}$and $\left[H_{m}, G_{r}^{+}\right] v_{k}^{-}=G_{m+r}^{+} v_{k}^{-}$, one has

$$
\begin{align*}
-f_{1}(m, r+k)+c h(r, k)-(c+1) h(r, m+k) & =-h(m+r, k) .  \tag{4.30}\\
f_{1}(m, r+k)+c g(r, k)-(c-1) g(r, m+k) & =g(m+r, k) . \tag{4.31}
\end{align*}
$$

Combining with (4.29), (4.30) and (4.31) we get

$$
\begin{equation*}
g(m+r, k)-g(r, m+k)=(c+2-2 b) m \tag{4.32}
\end{equation*}
$$

Setting $r=0$ and using (4.28) and (4.29), we get

$$
\begin{equation*}
g(m, k)=(c+2-2 b) m, \quad h(m, k)=-(2 a+2 k+(2 b+c) m), \forall m, k \in \mathbb{Z} . \tag{4.33}
\end{equation*}
$$

So (4.24) and (4.25) hold. By actions of $L_{m}, H_{m}, G_{r}^{ \pm}$on (4.24), we can easily get the remaining relations in the proposition. Moreover $\mathcal{R}_{a, b, c}$ is simple if and only if $2 b \pm c \neq 2$.

Remark 4.7. If $2 b-c=2$, then $V=\operatorname{span}_{\mathbb{C}}\left\{v_{i}^{-}, v_{i}^{+-} \mid i \in \mathbb{Z}\right\}$ is a simple module of the intermediate series, which is just isomorphic to the module $\mathcal{R}_{a, b}$ listed in Case 1 (up to parity-change).

If $2 b+c=2$, then $V=\operatorname{span}_{\mathbb{C}}\left\{v_{i}^{+}, v_{i}^{+-}+2(a+i) v_{i} \mid i \in \mathbb{Z}\right\}$ is a simple module of the intermediate series, which is also isomorphic to $\mathcal{R}_{a, b}$ (up to parity-change).

If $2 b-c=2 b+c=2(b=1, c=0)$ and $a=0, \frac{1}{2}$, then $V$ is a trivial module.
For convenience, we use $\mathcal{R}_{a, b, c}^{\prime}$ to denote the simple sub-quotient of $\mathcal{R}_{a, b, c}$ in all cases (including the module $\mathcal{R}_{a, b}$ in the case of $n=1$ ). $\mathcal{R}_{a, b, c}$ (or $\mathcal{R}_{a, b, c}^{\prime}$ ) is just corresponding to the finite conformal module given in [8]

## 5. Quasi-finite modules over the $N=2$ Ramond algebra

In this section, we classify all simple weight modules with finite-dimensional weight spaces for the $N=2$ Ramond algebra.

Theorem 5.1. Let $V$ be a simple weight module with finite-dimensional weight spaces over $\mathfrak{g}$. If $V$ is not a highest and lowest module, then $V$ is cuspidal.

Proof. Suppose that $V=\sum_{k \in \mathbb{Z}} V_{k}$ is a simple quasi-finite $\mathfrak{g}$-module without highest and lowest weights. We shall prove that for any $n \in \mathbb{Z}^{*}, k \in \mathbb{Z}$,

$$
\begin{equation*}
\left.\left.L_{n}\left|V_{k} \oplus L_{n+1}\right|_{V_{k}} \oplus H_{n+2}\right|_{V_{k}} \oplus G_{n}^{+}\right|_{V_{k}} \oplus G_{n+1}^{-} \mid V_{k}: V_{k} \rightarrow V_{k+n} \oplus V_{k+n} \oplus V_{k+n+1} \tag{5.1}
\end{equation*}
$$

is injective. In particular, by taking $n=-k$, we obtain that $V$ is cuspidal.
In fact, suppose there exists some $v_{0} \in V_{k}$ such that

$$
\begin{equation*}
L_{n} v_{0}=L_{n+1} v_{0}=G_{n}^{+} v_{0}=G_{n+1}^{-} v_{0}=H_{n+2} v_{0}=0 . \tag{5.2}
\end{equation*}
$$

Without loss of generality, we can suppose $n>0$. Note that when $\ell \gg 0$, we have

$$
\ell=n_{1} n+n_{2}(n+1)
$$

for some $n_{1}, n_{2} \in \mathbb{N}$. From this and the relations in the definition of $\mathfrak{g}$, one can easily deduce that $L_{\ell}, G_{\ell}^{ \pm}, H_{\ell}$ can be generated by $L_{n}, L_{n+1}, G_{n}^{+}, G_{n+1}^{-}, H_{n+2}$. Therefore, there exists some $N_{0}>0$ such that

$$
L_{\ell} v_{0}=G_{\ell}^{ \pm} v_{0}=H_{\ell} v_{0}=0, \forall \ell \geq N_{0}
$$

This means

$$
\begin{equation*}
\mathfrak{g}_{\left[N_{0},+\infty\right)} v_{0}=0 \tag{5.3}
\end{equation*}
$$

where $\mathfrak{g}_{\left[N_{0},+\infty\right)}=\oplus_{l \geq N_{0}} \mathfrak{g}_{l}$. Clearly $V=U(\mathfrak{g}) v_{0}$ and $V_{k}=U(\mathfrak{g})_{0} v_{0}$. For any $v \in V_{k}$, there exists $u \in U(\mathrm{~g})_{0}$ such that $v=u v_{0}$. Suppose that

$$
u=\sum a_{-i_{1}, \ldots,-i_{m}, i_{m+1}, \cdots, i_{n}} X_{-i_{1}} \cdots Y_{-i_{m}} Z_{i_{m+1}} \cdots W_{i_{n}}
$$

where $X, \cdots, Y, Z \cdots, W \in\left\{L, H, G^{ \pm}\right\}, i_{1}, \cdots, i_{n}>0$. Define the negative degree

$$
n(v):=\max \left\{i_{1}+\cdots+i_{m} \mid a_{-i_{1}, \ldots, i_{m}, i_{m+1}, \cdots, i_{n}} \neq 0\right\}
$$

It is well-defined since the sum is finite. Choose a basis $\left\{v_{1}, v_{2}, \cdots, v_{d_{k}}\right\}$ of the finite-dimensional space $V_{k}$, and set $n_{k}:=\max \left\{n\left(v_{i}\right) \mid 1 \leq i \leq d_{k}\right\}$. Then we have

$$
\begin{equation*}
\mathfrak{g}_{[N,+\infty)} V_{k}=0, \text { where } N=N_{0}+n_{k} . \tag{5.4}
\end{equation*}
$$

Clearly $\mathfrak{g}_{+}$is generated by $S:=\left\{L_{1}, H_{1}, G_{1}^{+}, G_{1}^{-}\right\}$. For any $i \geq 1$, set $U_{k+1}=S V_{k}=\sum_{x \in S} x V_{k} \subset$ $V_{k+1}$. If $U_{k+1}=0$, then there exists a nonzero element $v \in V_{k}$ such that $S v=0$ and then $\mathfrak{g}_{+} v=0$. So $v$ is a highest weight vector, and $V$ is a highest weight module.

Now we can suppose that $U_{k+1} \neq 0$. For any $l \geq N$, we have $\mathfrak{g}_{l} U_{k+1}=\sum_{x \in S}\left[\mathfrak{g}_{l}, x\right] V_{k}+$ $\sum_{x \in S} x \mathfrak{g}_{l} V_{k} \subset \mathfrak{g}_{l+1} V_{k}+S \mathfrak{g}_{l} V_{k}=0$. Then we get

$$
\begin{equation*}
\mathfrak{g}_{[N,+\infty)} U_{k+1}=0 \tag{5.5}
\end{equation*}
$$

Repeating the above steps, we get $U_{k+i+1}=S U_{k+i}$ for any $i \geq 0$, and

$$
\begin{equation*}
\mathfrak{g}_{[N,+\infty)} U_{k+i}=0, \forall i \geq 0 \tag{5.6}
\end{equation*}
$$

For any $1 \leq j<N, z \in \mathfrak{g}_{N-j}$, there exists $y \in \mathfrak{g}_{N}$ such that $z=\left[y, L_{-j}\right]$. Then $z U_{k+j}=\left[y, L_{-j}\right] U_{k+j}=$ $y L_{-j} U_{k+j}-L_{-j} y U_{k+j} \subset y V_{k}-L_{-j} y U_{k+j}=0$. So

$$
\begin{equation*}
\mathfrak{g}_{[N-j,+\infty)} U_{k+j}=0, \forall 1 \leq j<N \tag{5.7}
\end{equation*}
$$

Then $\mathfrak{g}_{+} U_{k+N}=0$ for some $U_{k+N} \neq 0$.
Since the finite-dimensional subalgebra $\mathfrak{a}:=\operatorname{span}_{\mathbb{C}}\left\{L_{0}, H_{0}, C\right\}$ is commutative, there exists a common eigenvector $w$ of $\mathfrak{a}$ in $U_{k+N}$. Replace $w$ by $G_{0}^{+} w$ if $G_{0}^{+} w \neq 0, w$ becomes a highest weight vector of $\mathfrak{g}$. This contradicts the assumption of the theorem.

Combining with Theorem 5.1 and Proposition 4.1, we obtain our main result of this paper.
Theorem 5.2. Let $V$ be a simple weight g -module with finite-dimensional weight spaces. Then $V$ is a highest weight module, a lowest weight module, or $\mathcal{R}_{a, b, c}^{\prime}$ for some $a, b, c \in \mathbb{C}$ (up to paritychange).

Remark 5.3. This research was originally announced on April 2019 by arXiv:1904.08578. Recently [31] and [3] successively obtained a classification result for the Lie superalgebra $W(m, n)$ by a different method.
