Classification of integrable vector equations of geometric type

ABSTRACT. A complete classification of isotropic vector equations of the geometric type that possess higher symmetries is proposed. New examples of integrable multi-component systems of the geometric type are found.

1 Introduction

Consider evolution systems of the form

$$u_t^i = u_{xxx}^i + 3A_{jk}^i(\boldsymbol{u}) \, u_x^j \, u_{xx}^k + B_{jkl}^i(\boldsymbol{u}) \, u_x^j \, u_x^k u_x^l, \qquad i, j, k, s = 1, \dots, N,$$
(1.1)

where $\boldsymbol{u} = (u^1, \dots, u^N)$. Here and below, we assume that the summation is carried out over repeated indexes.

Integrable systems of this type are connected with various geometric and algebraic structures and are of interest by themselves. In addition, the most interesting of them play the role of infinitesimal symmetries for physically important hyperbolic systems of the form

$$u_{xy}^{i} = C_{jk}^{i}(\boldsymbol{u}) \, u_{x}^{j} u_{y}^{k}. \tag{1.2}$$

Having an efficient description of integrable systems (1.1), we can construct a class of integrable systems of the form (1.2) following the approach from the papers [1, 2].

An example of such type integrable system provides the following equation [3]

$$\mathbf{U}_{t} = \mathbf{U}_{xxx} - \frac{3}{2} \mathbf{U}_{x} \mathbf{U}^{-1} \mathbf{U}_{xx} - \frac{3}{2} \mathbf{U}_{xx} \mathbf{U}^{-1} \mathbf{U}_{x} + \frac{3}{2} \mathbf{U}_{x} \mathbf{U}^{-1} \mathbf{U}_{x} \mathbf{U}^{-1} \mathbf{U}_{x},$$

where $\mathbf{U}(x,t)$ is an $m \times m$ matrix. In this case $N = m^2$. For any m this system has infinitely many local symmetries and conservation laws.

It is convenient to rewrite (1.1) in the following way

$$u_{t}^{i} = u_{3}^{i} + 3A_{jk}^{i}(\boldsymbol{u})u_{x}^{j}u_{xx}^{k} + \left(\frac{\partial A_{jk}^{i}}{\partial u^{l}} + 2A_{ls}^{i}A_{jk}^{s} - A_{sl}^{i}A_{jk}^{s} + \beta_{jkl}^{i}\right)u_{x}^{j}u_{x}^{k}u_{x}^{l}.$$
 (1.3)

The class of systems (1.3) is invariant under the arbitrary point transformations $\boldsymbol{u} \to \boldsymbol{\Phi}(\boldsymbol{u})$. It is easy to see that under such a change of coordinates, the functions A_{jk}^i and β_{jkm}^i are transformed just as components of an affine connection Γ and of a tensor β , respectively.

Example 1. In the case N = 1 equation (1.3) has the form

$$u_t = u_{xxx} + 3A(u) u_x u_{xx} + \left(A'(u) + A(u)^2 + \beta(u)\right) u_x^3.$$

Using the symmetry approach (see [4]), one can verify that this equation possesses higher symmetries iff $\beta' = 2A\beta$. By a proper point transformation of the form $u \to \Phi(u)$ the function A can be reduced to zero (for N = 1 any affine connection is flat) and the function β becomes a constant. The equation $u_t = u_{xxx} + \text{const} u_x^3$ is known to be integrable and it is related to the mKdV equation by a potentiation.

Without loss of generality we assume that the tensor β is symmetric:

$$\beta(X, Y, Z) = \beta(Y, X, Z) = \beta(X, Z, Y)$$

for any vectors X, Y, Z. The functions β_{ikm}^i are defined by the values of $\beta(X, X, X)$.

Suppose a system of the form (1.3) has higher symmetries and/or non-degenerate conservation laws and $A_{jk}^i = A_{kj}^i$, i.e. the torsion tensor T is equal to zero. Then¹ the corresponding affine connected space is symmetric [6] which means that

$$\nabla_X \Big(R(Y, Z, V) \Big) = 0, \tag{1.4}$$

where R is the curvature tensor². Let

$$\sigma(X,Y,Z) \stackrel{def}{=} \beta(X,Y,Z) - \frac{1}{3} \Big(R(X,Y,Z) + R(Z,Y,X) \Big).$$

Then

$$\sigma(X, Y, Z) = \sigma(Z, Y, X), \tag{1.5}$$

$$\nabla_X \Big(\sigma(Y, Z, V) \Big) = 0, \tag{1.6}$$

$$R(X, Y, Z) = \sigma(X, Z, Y) - \sigma(X, Y, Z), \qquad (1.7)$$

and

$$\sigma(X, \sigma(Y, Z, V), W) - \sigma(W, V, \sigma(X, Y, Z)) + \sigma(Z, Y, \sigma(X, V, W)) - \sigma(X, V, \sigma(Z, Y, W)) = 0.$$
(1.8)

$$R_{ijk}^m = \frac{\partial}{\partial u_j} A_{ki}^m - \frac{\partial}{\partial u_k} A_{ji}^m + A_{js}^m A_{k1}^s - A_{ks}^m A_{ji}^s.$$

The identities (1.5) and (1.8) mean that at any point u the tensor $\sigma(u)$ defines a triple Jordan system [7, 8].

Conjecture 1. If a symmetric (T = 0) affine connection and a tensor σ satisfy identities (1.4) - (1.7) and (1.8) then the corresponding³ system (1.3) possesses infinitely many local symmetries and conservation laws.

Several integrable systems of the form (1.3) that correspond to symmetric connections can be found in [9] but no integrable models corresponding to the case $T \neq 0$ are known. In this paper we construct examples of integrable models (1.3) such that $T \neq 0$ and R = 0.

Our goal is to find all non-triangular integrable systems of the form (1.1), which belong to a special class of vector isotropic equations of the form

$$\boldsymbol{u}_t = \boldsymbol{u}_{xxx} + f_2 \boldsymbol{u}_{xx} + f_1 \boldsymbol{u}_x + f_0 \boldsymbol{u}, \tag{1.9}$$

where $\boldsymbol{u}(x,t)$ is an N-dimensional vector and the coefficients f_i are supposed to be functions of the following six independent scalar products:

$$(\boldsymbol{u}, \boldsymbol{u}), (\boldsymbol{u}, \boldsymbol{u}_x), (\boldsymbol{u}_x, \boldsymbol{u}_x), (\boldsymbol{u}, \boldsymbol{u}_{xx}), (\boldsymbol{u}_x, \boldsymbol{u}_{xx}), (\boldsymbol{u}_{xx}, \boldsymbol{u}_{xx}).$$
 (1.10)

Equations (1.9) are invariant with respect to the orthogonal group O_N .

It is clear that any equation (1.9) whose component form belong to the class of equations (1.1) has the following structure:

$$\boldsymbol{u}_{t} = \boldsymbol{u}_{xxx} + a_{1}u_{[0,1]} \,\boldsymbol{u}_{xx} + (a_{2}u_{[0,2]} + a_{3}u_{[1,1]} + a_{4}u_{[0,1]}^{2}) \,\boldsymbol{u}_{x} + (a_{5}u_{[1,2]} + a_{6}u_{[0,2]}u_{[0,1]} + a_{7}u_{[1,1]}u_{[0,1]} + a_{8}u_{[0,1]}^{3}) \,\boldsymbol{u},$$
(1.11)

where

$$u_{[i,j]} = (\partial_x^i \boldsymbol{u}, \, \partial_x^j \boldsymbol{u}), \qquad 0 \leqslant i \leqslant j \tag{1.12}$$

and the coefficients a_i are functions in one variable: $a_i = a_i(u_{[0,0]})$. In this case the components, the torsion and the curvature tensors for the corresponding affine connection are given by

$$A(X,Y) = \frac{1}{3} \Big(a_1(\boldsymbol{u}, X)Y + a_2(\boldsymbol{u}, Y)X + \Big(a_5(X,Y) + a_6(\boldsymbol{u}, X)(\boldsymbol{u}, Y) \Big) \boldsymbol{u} \Big),$$
$$T(X,Y) = \frac{1}{3} (a_1 - a_2) \Big((\boldsymbol{u}, X)Y - (\boldsymbol{u}, Y)X \Big)$$

and

$$R(X,Y,Z) = \frac{1}{9} \Big(q(\boldsymbol{u},X)(\boldsymbol{u},Z) + p(X,Z) \Big) Y - \frac{1}{9} \Big(q(\boldsymbol{u},X)(\boldsymbol{u},Y) + p(X,Y) \Big) Z + \frac{r}{9} \Big((\boldsymbol{u},Y)(X,Z) - (\boldsymbol{u},Z)(X,Y) \Big) \boldsymbol{u},$$

where

$$p = a_2 a_5 \boldsymbol{u}^2 - 3a_2 + 3a_5, \qquad q = a_2 a_6 \boldsymbol{u}^2 + a_2^2 + 3a_6 - 6a_2', \qquad r = a_5 a_6 \boldsymbol{u}^2 + a_5^2 - 3a_6 + 6a_5'.$$

To find all integrable equations (1.11), we use a version of the symmetry approach developed in [10] for vector equations.

In Section 2 we discuss necessary conditions [10] of the existence of higher symmetries for vector equations of the form (1.9). In Section 3 we present lists of integrable equations (1.11), formulate and prove classification statements. For some of these equations written in components of the vector \boldsymbol{u} the torsion T is not zero. To justify the real integrability of equations found in Section 3, we detect (see Section 4) auto-Bäcklund transformations for these equations. Each of them is a new integrable semi-discrete model.

2 Integrability conditions for vector equations

It was shown in [10] that if an equation of the form (1.9) has infinitely many vector higher symmetries

$$\boldsymbol{u}_{\tau} = f_n \boldsymbol{u}_n + f_{n-1} \boldsymbol{u}_{n-1} + \dots + f_0 \boldsymbol{u}, \quad \text{where} \quad \boldsymbol{u}_k = \frac{\partial^{\kappa} \boldsymbol{u}}{\partial x^k}, \quad (2.1)$$

then an infinite series of special local⁴ conservation laws exists for equation (1.9). Their densities ρ_n , n = 0, 1, ... are called **canonical**.

The first two canonical densities are given by

$$\rho_0 = -\frac{1}{3} f_2, \tag{2.2}$$

$$\rho_1 = \frac{1}{9} f_2^2 - \frac{1}{3} f_1 + \frac{1}{3} D_x f_2.$$
(2.3)

Using a technique developed in the papers [11, 12], one can obtain the following recursion formula for other canonical densities for equations of the form (1.9):

$$\rho_{n+2} = \frac{1}{3} \left[\theta_n - f_0 \,\delta_{n,0} - 2 \,f_2 \,\rho_{n+1} - f_2 \,D_x \rho_n - f_1 \,\rho_n \right] \\ - \frac{1}{3} \left[f_2 \,\sum_{s=0}^n \rho_s \,\rho_{n-s} + \sum_{0 \leqslant s+k \leqslant n} \rho_s \,\rho_k \,\rho_{n-s-k} + 3 \sum_{s=0}^{n+1} \rho_s \,\rho_{n-s+1} \right] \\ - D_x \left[\rho_{n+1} + \frac{1}{2} \sum_{s=0}^n \rho_s \,\rho_{n-s} + \frac{1}{3} D_x \rho_n \right], \qquad n \ge 0.$$

$$(2.4)$$

⁴A conservation law $D_t(\rho) = D_x(\theta)$ is called **local** if ρ and θ are functions of variables (1.12).

Here the symbol $\delta_{i,j}$ denotes the Kronecker delta and the functions θ_i are fluxes of the canonical conservation laws

$$D_t \rho_n = D_x \theta_n, \qquad n = 0, 1, 2, \dots$$
(2.5)

In this formula D_x and D_t are the total derivatives of x and t, respectively. For brevity, we call relation (2.5) ρ_n -integrability condition.

Using formulas (2.2)–(2.4), one can obtain the next density

$$\rho_2 = -\frac{1}{3}f_0 + \frac{1}{3}\theta_0 - \frac{2}{81}f_2^3 + \frac{1}{9}f_1f_2 - D_x\left(\frac{1}{9}f_2^2 + \frac{2}{9}D_xf_2 - \frac{1}{3}f_1\right)$$
(2.6)

and so on. Notice that the density ρ_n , $n \ge 2$ depends on the coefficients of (1.9) and on the fluxes $\{\theta_0, \theta_1, \dots, \theta_{n-2}\}$. These fluxes are to be calculated from the previous conditions (2.5).

To eliminate the function θ_n from (2.5) one can apply the variational derivative

$$\frac{\delta}{\delta \boldsymbol{u}} = \sum_{0 \leq i \leq j} \left[(-D_x)^i \left(\boldsymbol{u}_j \frac{\partial}{\partial u_{[i,j]}} \right) + (-D_x)^j \left(\boldsymbol{u}_i \frac{\partial}{\partial u_{[i,j]}} \right) \right].$$
(2.7)

to both sides of (2.5) and use the fact that

$$\frac{\delta(D_x g)}{\delta \boldsymbol{u}} = 0$$

for any function g (see, for example [13], chapter 4) to obtain

$$\frac{\delta}{\delta \boldsymbol{u}}(D_t \rho_n) = 0, \qquad n = 1, 2, \dots$$
(2.8)

Conditions (2.8) are most efficient for the cases n = 1, 2 since (2.2) and (2.3) do not depend on θ_i .

3 Classification of integrable equations (1.11)

We are searching for non-triangular integrable equations of the form (1.11). In this section, **integrability** means the existence of an infinite sequence of higher symmetries [13, 4] of the form (2.1).

Some equations (1.9) become triangular in the spherical coordinates, which is defined by the formulas

$$\boldsymbol{u} = R \boldsymbol{v}, \qquad |\boldsymbol{v}| = 1, \qquad \text{where} \quad R = |\boldsymbol{u}|.$$

Let

$$v_{[i,j]} = (\partial_x^i \boldsymbol{v}, \, \partial_x^j \boldsymbol{v}), \qquad i \leqslant j.$$

Since $v_{[0,0]} = 1$, we have $D_x(v_{[0,0]}) = 2v_{[0,1]} = 0$. Moreover, $D_x v_{[0,1]} = v_{[0,2]} + v_{[1,1]} = 0$, i.e. $v_{[0,2]} = -v_{[1,1]}$ and so on. It is clear that all variables $v_{[0,k]}$ can be expressed in terms of the variables $v_{[i,k]}$, $1 \le i \le k < \infty$.

We call equation (1.9) **triangular** if it can be rewritten in the spherical coordinates as

$$m{v}_t = m{v}_{xxx} + g_2 m{v}_{xx} + g_1 m{v}_x + g_0 m{v},$$

 $R_t = R_{xxx} + S(v_{[1,1]}, v_{[1,2]}, v_{[2,2]}, R, R_x, R_{xx})$

where the coefficients g_i depend on $v_{[1,1]}, v_{[1,2]}, v_{[2,2]}$ only.

3.1 Classification statements

The class of equations of the form (1.11) is invariant with respect to the point transformations of the form

$$\boldsymbol{u} = \boldsymbol{v}\,\varphi(v_{[0,0]}).\tag{3.1}$$

Under such a transformation the coefficient a_1 changes as follows:

$$\tilde{a}_1(v_{[0,0]}) = 2\,\varphi^{-1}\varphi'\big(v_{[0,0]}\,a_1\varphi^2 + 3\big) + a_1\,\varphi^2, \qquad \text{where} \quad a_1(u_{[0,0]}) = a_1\big(v_{[0,0]}\varphi^2\big).$$

It easy to see that if $a_1 = -3 u_{[0,0]}^{-1}$, then we obtain $\tilde{a}_1 = -3 v_{[0,0]}^{-1}$. For any function a_1 different from $-3 u_{[0,0]}^{-1}$ we can choose the function φ such that \tilde{a}_1 vanishes. Thus, up to the point transformations we have two non-equivalent cases:

1.
$$a_1 = 0$$
 and **2**. $a_1 = -\frac{3}{u_{[0,0]}}$

Theorem 1. Any non-triangular integrable equation of the form (1.11) with $a_1 = 0$ can be reduced to one of equations from the following List 1 by a scaling of the form $\boldsymbol{u} \to \lambda \boldsymbol{u}$.

List 1.

$$\boldsymbol{u}_{t} = \boldsymbol{u}_{xxx} + \frac{3\lambda}{z} \, \boldsymbol{u}_{x} \left(\frac{u_{[0,1]}^{2}}{z + u_{[0,0]}} - u_{[1,1]} \right) + \frac{3}{z} \, \boldsymbol{u} \, F, \qquad \text{where} \quad \lambda = 1 \quad \text{or} \quad \lambda = \frac{1}{2}, \qquad (3.2)$$

$$\boldsymbol{u}_{t} = \boldsymbol{u}_{xxx} - \frac{3}{z} \, \boldsymbol{u}_{x} \left(\frac{z u_{[0,2]}}{z + u_{[0,0]}} - \frac{u_{[0,0]} u_{[1,1]}}{z + u_{[0,0]}} + \frac{u_{[0,0]} u_{[0,1]}^{2}}{(z + u_{[0,0]})^{2}} \right) + \frac{3}{z} \, \boldsymbol{u}F, \tag{3.3}$$

$$\boldsymbol{u}_{t} = \boldsymbol{u}_{xxx} - \frac{3}{z} \, \boldsymbol{u}_{x} \left(\frac{z u_{[0,2]}}{z + u_{[0,0]}} + \frac{(z - u_{[0,0]}) u_{[1,1]}}{2 \left(z + u_{[0,0]} \right)} - \frac{(2z - u_{[0,0]}) u_{[0,1]}^{2}}{2 \left(z + u_{[0,0]} \right)^{2}} \right) + \frac{3}{z} \, \boldsymbol{u}F, \tag{3.4}$$

where

$$F = u_{[0,1]} \frac{u_{[0,2]} + u_{[1,1]}}{z + u_{[0,0]}} - u_{[1,2]} - \frac{u_{[0,1]}^3}{(z + u_{[0,0]})^2}.$$

Here $z \neq 0$ is an arbitrary parameter.

Theorem 2. Any non-triangular integrable equation of the form (1.11) with $a_1 = -\frac{3}{u_{[0,0]}}$ can be reduced to one of the equations from the following List 2 by a point transformation of the form (3.1).

List 2.

$$\boldsymbol{u}_{t} = \boldsymbol{u}_{xxx} - 3\boldsymbol{u}_{xx} \frac{u_{[0,1]}}{u_{[0,0]}} - 3\boldsymbol{u}_{x} \left(\frac{u_{[1,1]}}{u_{[0,0]}} - \frac{u_{[0,1]}^{2}}{u_{[0,0]}^{2}} \right),$$
(3.5)

$$\boldsymbol{u}_{t} = \boldsymbol{u}_{xxx} - 3\boldsymbol{u}_{xx}\frac{u_{[0,1]}}{u_{[0,0]}} - \frac{3}{2}\boldsymbol{u}_{x}\left(\frac{u_{[1,1]}}{u_{[0,0]}} - 2\frac{u_{[0,1]}^{2}}{u_{[0,0]}^{2}}\right),$$
(3.6)

$$\boldsymbol{u}_{t} = \boldsymbol{u}_{xxx} - 3\boldsymbol{u}_{xx}\frac{u_{[0,1]}}{u_{[0,0]}} - \frac{3}{2}\boldsymbol{u}_{x}\left(2\frac{u_{[0,2]}}{u_{[0,0]}} + \frac{u_{[1,1]}}{u_{[0,0]}}\right) + 3\boldsymbol{u}\left(\frac{u_{[1,2]}}{u_{[0,0]}} - \frac{u_{[0,1]}u_{[1,1]}}{u_{[0,0]}^{2}} + \frac{4}{3}\frac{u_{[0,1]}^{3}}{u_{[0,0]}^{3}}\right). \quad (3.7)$$

Remark 1. Equation (3.7) is equivalent to the equation

$$\boldsymbol{u}_{t} = \boldsymbol{u}_{xxx} - 3\boldsymbol{u}_{xx}\frac{u_{[0,1]}}{u_{[0,0]}} - \frac{3}{2}\boldsymbol{u}_{x}\left(2\frac{u_{[0,2]}}{u_{[0,0]}} + \frac{u_{[1,1]}}{u_{[0,0]}} - 4\frac{u_{[0,1]}^{2}}{u_{[0,0]}^{2}}\right) + 3\boldsymbol{u}\left(\frac{u_{[1,2]}}{u_{[0,0]}} - \frac{u_{[1,1]}u_{[0,1]}}{u_{[0,0]}^{2}}\right)$$
(3.8)

found in [5, formula (59)].

Remark 2. Using the formulas from Introduction, one can verify that for equations (3.2) and (3.7) the torsion T is equal to zero while for equations (3.3)–(3.6) we have $T \neq 0$, R = 0.

3.2 Proof of Theorem 1

The equation under consideration is the following:

$$\boldsymbol{u}_{t} = \boldsymbol{u}_{xxx} + (a_{2}u_{[0,2]} + a_{3}u_{[1,1]} + a_{4}u_{[0,1]}^{2}) \boldsymbol{u}_{x} + (a_{5}u_{[1,2]} + a_{6}u_{[0,2]}u_{[0,1]} + a_{7}u_{[1,1]}u_{[0,1]} + a_{8}u_{[0,1]}^{3}) \boldsymbol{u}.$$
(3.9)

For such equations the canonical densities (2.2), (2.3), and (2.6) are given by

$$\rho_{0} = 0, \qquad \rho_{1} = -\frac{1}{3} \left(a_{2} u_{[0,2]} + a_{3} u_{[1,1]} + a_{4} u_{[0,1]}^{2} \right),$$

$$\rho_{2} = -\frac{1}{3} \left(a_{5} u_{[1,2]} + a_{6} u_{[0,2]} u_{[0,1]} + a_{7} u_{[1,1]} u_{[0,1]} + a_{8} u_{[0,1]}^{3} \right) + \frac{1}{3} D_{x} \left(a_{2} u_{[0,2]} + a_{3} u_{[1,1]} + a_{4} u_{[0,1]}^{2} \right).$$

Consider the ρ_1 -condition. The equality (2.8) with n = 1 has the form $\sum_{i=0}^4 q_i \boldsymbol{u}_i = 0$, where

$$q_4 = 4 \ u_{[0,1]}(a'_2 - a'_3)$$

Hence, $a_3 = a_2 + c_1$, where c_1 is a constant. Eliminating a_3 , we find that q_3 vanishes, which allows us to write the coefficient q_2 as

$$q_{2} = (u_{[0,3]} + 3u_{[1,2]}) \big((a_{5}u_{[0,0]} - 3)(2a'_{2} - a_{4}) - c_{1}(a_{2} + a_{5}) \big) + u_{[0,1]} \big(u_{[0,2]}F_{1} + u_{[1,1]}F_{2} + u_{[0,1]}^{2}F_{3} \big),$$

where $F_i = F_i(u_{[0,0]})$. The functions F_i are too cumbersome to be shown explicitly here while the difference $F_1 - F_2$ is very short:

$$F_1 - F_2 = c_1(a'_5 + 2a_6 - 2a_7).$$

Thus from (2.8) with n = 1 we have obtained three simple relations

$$a_3 = a_2 + c_1, \quad (a_5 u_{[0,0]} - 3)(2 a'_2 - a_4) - c_1(a_2 + a_5) = 0, \quad c_1(a'_5 + 2 a_6 - 2 a_7) = 0.$$
 (3.10)

Consider now the ρ_2 -condition. We obtain

$$\frac{\delta}{\delta \boldsymbol{u}}(D_t \rho_2) = \sum_{i=0}^4 p_i \boldsymbol{u}_i = 0,$$

where

$$p_4 = \left(\left(u_{[0,2]} + u_{[1,1]} \right) \left(a_5' + a_6 - a_7 \right) + 2 u_{[0,1]}^2 \left(a_5'' + a_6'' - a_7' \right) \right).$$

Equating p_4 to zero, we find $a_7 = a'_5 + a_6$ and conclude that this implies $p_3 = 0$. Substituting a_7 into third of equations (3.10), we obtain that $c_1a'_5 = 0$. Equating now p_0 to zero, we find one more simple relation $a'_6 - a_8 = 0$. So the ρ_2 -condition implies

$$a_7 = a'_5 + a_6, \qquad c_1(a_6 - a_7) = 0, \qquad a'_6 - a_8 = 0.$$
 (3.11)

Several more useful relations can be derived from the ρ_4 -condition. The density ρ_4 has the following structure:

$$\rho_4 = \frac{1}{3}\theta_2 - \frac{1}{3}D_x(\theta_1) + R,$$

where R does not depend on θ_1 and θ_2 . The term with θ_1 disappears when we apply the variational derivative in the formula (2.8) with n = 4. So to use the ρ_4 -condition, we have to specify the form of the function θ_2 only.

Using (3.11), we obtain that ρ_2 is trivial: $\rho_2 = D_x(S)$, where

Therefore, $\theta_2 = D_t(S)$. Taking into account this expression for θ_2 , we find that

Using (3.10), (3.11), (3.12), we express all coefficients in (3.9) in terms of a_2, a_6, c_1, c_2 . Then the coefficient r_5 vanishes and r_4 turns into

The equation $r_4 = 0$ is then equivalent to relations

and we have proved the following:

Lemma 1. Any integrable equation (3.9) has the form

$$(3.14)$$

where $a_2 = a_2(u_{[0,0]})$ and c_i are constants.

Let us consider the following two branches

A.
$$c_1 = 0$$
 and **B**. $c_1 \neq 0$.

In Case A the ρ_5 -condition leads to $c_2 = 0$ and $a_2 = 0$ and the linear equation $u_t = u_3$ appears.

Case **B** we separate into two following subcases:

B.1.
$$a_2 = 0$$
 and **B.2.** $a_2 \neq 0$.

Consider Case **B.1.** If $c_2 = 0$, then we arrive at the equation $\boldsymbol{u}_t = \boldsymbol{u}_3 + \boldsymbol{u}_1 c_1 \boldsymbol{u}_{[1,1]}$. This equation is not integrable since the ρ_5 -condition leads to a contradiction.

If $c_2 \neq 0$, then equation (3.14) coincides with equation (3.2), where

$$c_2 = -\frac{3}{z}, \qquad c_1 = -\frac{3\lambda}{z}.$$

The ρ_5 -condition gives rise to the following equation

$$(2\lambda - 1)(\lambda - 1) = 0.$$

Consider Case **B.2.** The coefficient r_0 in the ρ_4 -condition is given by

Therefore,

$$c_1(3a'_2 - a^2_2) = 0, \qquad a_2c_1(a_2(c_2u_{[0,0]} - 3) + 3c_2) = 0$$

and we have

$$a_2 = -\frac{3\,c_2}{c_2 u_{[0,0]} - 3}.$$

Then ρ_5 -condition provides the following equation

$$(c_1 + c_2)(2 c_1 + c_2) = 0.$$

The two possibilities $c_1 = -c_2$ and $c_1 = -\frac{c_2}{2}$ correspond to equations (3.3) and (3.4), where $c_2 = -\frac{3}{z}$.

Remark 3. We have verified that all equations of List 1 satisfy the ρ_n -conditions with $n \leq 7$. It turns out that ρ_n , where n = 0, 2, 4, 6, are total *x*-derivatives. In accordance with a general statement from [10] this is an indication of the existence of infinite series of local conservation laws. The canonical conservation laws, corresponding to n = 1, 3, 5, 7, have the orders 1, 2, 3, 4, respectively. Moreover, each equation from List 1 possesses a fifth order symmetry.

3.3 Proof of Theorem 2

Consider equations of the form

The simplest canonical densities (2.2), (2.3), and (2.6) are given by

$$\rho_{0} = \frac{1}{2} D_{x}(u_{[0,0]}), \qquad \rho_{1} = \frac{u_{[0,1]}^{2}}{u_{[0,0]}^{2}} - \frac{1}{3} \left(a_{2} u_{[0,2]} + a_{3} u_{[1,1]} + a_{4} u_{[0,1]}^{2} \right) - D_{x} \left(\frac{u_{[0,1]}}{u_{[0,0]}} \right),$$

$$\rho_{2} = \frac{1}{3} D_{x} \left(\frac{u_{[0,2]}}{u_{[0,0]}} - \frac{7}{2} \frac{u_{[0,1]}^{2}}{u_{[0,0]}^{2}} - \frac{u_{[1,1]}}{2 u_{[0,0]}} + 2 D_{x} \left(\frac{u_{[0,1]}}{u_{[0,0]}} \right) + a_{2} u_{[0,2]} + a_{3} u_{[1,1]} + a_{4} u_{[0,1]}^{2} \right).$$

Using the same line of reasoning as in Section 3.2, we derive short relations from the $\rho_1 - \rho_5$ conditions. Namely, it follows from the ρ_1 -condition that

(3.22)

It follows from (3.21) that $c_1 \neq 0$ and we may reduce (3.18) and (3.19) by the factor c_1 .

Let us simplify the equation (3.15) by an appropriate point transformation of the form (3.1). It is more convenient for computations to rewrite it as

One can verify that under this transformation the coefficient a_2 transforms as

It follows from this formula that we can reduce a_2 to zero with the exception of the case $a_2(u_{[0,0]}) = -\frac{3}{u_{[0,0]}}$.

Case A: $a_2^{[0,0]} = 0$. It follows from (3.20), (3.18) and (3.19) that $a_5 = a_6 = a_7 = 0$. From (3.17) we obtain $a_4 = \frac{3}{u_{[0,0]}^2}$. Moreover, relation (3.21) leads to $(c_1+3)(2c_1+3) = 0$. Substituting $a_i, \ 2 \leq i \leq 7$ into the ρ_1 -condition, we obtain that $a'_8 = -3 a_8 u_{[0,0]}$ or $a_8 = k/u_{[0,0]}^3$. Finally, ρ_5 -condition gives rise to k = 0.

In the case $c_1 = -3$ we arrive at equation (3.5) while $c_1 = -\frac{3}{2}$ leads to equation (3.6). It follows from (3.24) that in Case A the only admissible point transformations are $\mathbf{u} \to \text{const } \mathbf{u}$ and therefore equations (3.5) and (3.6) are non-equivalent.

Case B: $a_2 = -\frac{3}{u_{[0,0]}}$. Taking into account (3.16), we find that the equation has the following form

Relations (3.17) and (3.21) can be rewritten as

$$(c_1 - 3)(2c_1 - 3) = 0,$$
 $(a_5u_{[0,0]} - 3)(a_4u_{[0,0]}^2 + c_1 - 9) = 0.$ (3.26)

For equations of the form (3.25) the ρ_1 -condition provides the following additional relations:

$$(a_4 u_{[0,0]}^2 + c_1 - 9)(a_6 u_{[0,0]}^2 - a_7 u_{[0,0]}^2 - 3) = 0, (3.27)$$

$$a'_{4} = \frac{a_{6}}{3u_{[0,0]}} \left(a_{4}u_{[0,0]}^{2} + c_{1} - 9 \right) - 2\frac{a_{4}}{u_{[0,0]}}.$$
(3.28)

Moreover it follows from the ρ_5 -condition that

$$(a_4 u_{[0,0]}^2 + c_1 - 9)(2 c_1 - 3) = 0,$$
(3.29)

$$(a_4 u_{[0,0]}^2 + c_1 - 9)(u_{[0,0]}^4 a_6^2 + 6 a_6' u_{[0,0]}^3 - 9 a_8 u_{[0,0]}^3 - 6 a_4 u_{[0,0]}^2 - 6 a_6 u_{[0,0]}^2 + 36) = 0.$$
(3.30)

Under transformations (3.23) the coefficient a_4 changes as follows:

$$\tilde{a}_4 = \frac{f'^2}{f^2} \left(a_4 f^2 + c_1 - 9 \right) + \frac{9 - c_1}{v_{[0,0]}^2}$$

The condition $\tilde{a}_4 = 0$ is a differential equation for f, which has a non-constant solution except for the case $a_4 u_{[0,0]}^2 + c_1 - 9 = 0$. So we arrive at the following two cases:

B.1.
$$a_4 = 0$$
 and **B.2.** $a_4 = \frac{9 - c_1}{u_{[0,0]}^2}$.

In the case **Case B.1.** it follows from (3.26) - (3.30) that

where $(c_1 - 3)(2c_1 - 3) = 0$. It can be verified that in the spherical coordinates equation (3.31) has the form

where $b_i(R) = a_i(u_{[0,0]}) \equiv a_i(R^2)$. So, the system (3.31) is triangular.

Remark 4. Both equations (3.32) are integrable equations on the sphere [10]. They have infinitely many conservation laws depending on the variables $v_{[i,j]}$. This is a reason why all conditions from Section 2 are satisfied for any functions $a_5 - a_8$. However, we can use the geometric integrability conditions (1.4) - (1.8) for the classification of triangular systems (3.31) (see Appendix 6). **Remark 5.** It turns out that the equations of List 1 can be simplified by the point transformation (3.23) with

(3.36)

respectively. Equations written in this form appeared in [14] (see formulas (3.12), (3.13), (3.16) and (3.17)).

4 Auto-Bäcklund transformations

An auto-Bäcklund transformation of the first order for a vector equation of the form (1.9) is defined by the formula

$$\mathbf{u}_x = h\,\boldsymbol{v}_x + f\,\boldsymbol{u} + g\,\boldsymbol{v},$$

where **u** and **v** are solutions of (1.9). The functions f, g and h are (scalar) functions of variables

$$u_{[0,0]} \stackrel{def}{=} (\boldsymbol{u}, \boldsymbol{u}), \qquad v_{[i,j]} \stackrel{def}{=} (\boldsymbol{v}_i, \boldsymbol{v}_j), \qquad w_{i,j} \stackrel{def}{=} (\boldsymbol{u}_i, \boldsymbol{v}_j), \qquad i, j \ge 0.$$

Remark 6. If the auto-Bäcklund transformation depends on an arbitrary parameter μ , one can construct exact multi-parameter solutions of equation (1.9) by applying the transformation several times to a trivial solution.

Remark 7. The existence of a vector auto-Backlund transformation with an arbitrary parameter is the most easily verifiable evidence for the integrability of a vector equation.

For equations (3.2)–(3.4) we use the canonical forms (3.34)–(3.36) since the auto-Bäcklund transformations for them look more elegant.

The auto-Bäcklund transformations for equation (3.34) with $\lambda = 1$ and with $\lambda = 1/2$ are given by the formulas

respectively. Here $p = \sqrt{u_{[0,0]} + a}$, $q = \sqrt{v_{[0,0]} + a}$ and μ is an arbitrary parameter.

The auto-Bäcklund transformations for equations (3.35) and (3.36) have the following form:

$$\boldsymbol{u}_{x} = \frac{p}{q}\boldsymbol{v}_{x} + \frac{\mu p \left(p-q\right) \left(\boldsymbol{u}-\boldsymbol{v}\right)}{a-p q + w_{[0,0]}}$$
(4.3)

and

$$\boldsymbol{u}_{x} = \frac{p}{q}\boldsymbol{v}_{x} + \frac{\mu p \left(\boldsymbol{u} - \boldsymbol{v}\right)}{\sqrt{a - p q + w_{[0,0]}}}.$$
(4.4)

The auto-Bäcklund transformations for equation (3.5), (3.6) and (3.8) have the following form:

$$\boldsymbol{u}_{x} = \frac{\sqrt{u_{[0,0]}}}{\sqrt{v_{[0,0]}}} \boldsymbol{v}_{x} + \frac{\sqrt{v_{[0,0]}} w_{[0,1]} - \sqrt{u_{[0,0]}} v_{[0,1]}}{v_{[0,0]} \sqrt{v_{[0,0]}} \sqrt{v_{[0,0]}}} \left(\boldsymbol{u} \sqrt{v_{[0,0]}} - \boldsymbol{v} \sqrt{u_{[0,0]}} \right) + \mu \sqrt{u_{[0,0]}} \sqrt{v_{[0,0]}} \boldsymbol{u}, \quad (4.5)$$
$$\boldsymbol{u}_{x} = \frac{\sqrt{u_{[0,0]}}}{\sqrt{v_{[0,0]}}} \boldsymbol{v}_{x} + \frac{\sqrt{v_{[0,0]}} w_{[0,1]} - \sqrt{u_{[0,0]}} v_{[0,1]}}{v_{[0,0]} \sqrt{v_{[0,0]}}} \left(\boldsymbol{u} \sqrt{v_{[0,0]}} - \boldsymbol{v} \sqrt{u_{[0,0]}} \right) + \mu |u_{[0,0]}|^{1/4} |v_{[0,0]}|^{1/4} \boldsymbol{u}, \quad (4.6)$$

and

$$\boldsymbol{u}_{x} = \frac{\sqrt{u_{[0,0]}}}{\sqrt{v_{[0,0]}}} \boldsymbol{v}_{x} + \mu \boldsymbol{u} \left(\sqrt{u_{[0,0]}} \sqrt{v_{[0,0]}} - w_{[0,0]}\right)^{1/2} + \mu \frac{u_{[0,0]} \boldsymbol{v} - w_{[0,0]} \boldsymbol{u}}{\left(\sqrt{u_{[0,0]}} \sqrt{v_{[0,0]}} - w_{[0,0]}\right)^{1/2}} \\ + \frac{\left(\boldsymbol{u} \sqrt{v_{[0,0]}} - \boldsymbol{v} \sqrt{u_{[0,0]}}\right) \left(\sqrt{u_{[0,0]}} v_{[0,1]} - \sqrt{v_{[0,0]}} w_{[0,1]}\right)}{v_{[0,0]} \left(\sqrt{u_{[0,0]}} \sqrt{v_{[0,0]}} - w_{[0,0]}\right)}, \quad (4.7)$$

5 Appendix. Geometric properties of equations with T = 0

The affine connections that correspond to equation (3.8) and to two equations (3.34) have zero torsion: T = 0. We verified that they satisfy the integrability conditions (1.4)-(1.8). In the appendix we present explicit formulas for these equations.

Example 2. In the equations (3.34) we have

$$A(X,Y) = -\frac{(u,X)Y + (u,Y)X}{a + u_{[0,0]}},$$

where $u_{[0,0]} = (\boldsymbol{u}, \boldsymbol{u})$. One can check that this connection is the Levi-Civita affine connection of the metric

$$g(X,Y) = \frac{(X,Y)}{a+u_{[0,0]}} - \frac{(\boldsymbol{u},X)(\boldsymbol{u},Y)}{(a+u_{[0,0]})^2}.$$

The tensors β , R and σ can be expressed in terms of g as follows:

$$\beta(X, Y, Z) = \frac{3\lambda - 1}{3} \Big(g(X, Y) Z + g(Y, Z) X + g(Z, X) Y \Big),$$
$$R(X, Y, Z) = g(X, Z) Y - g(X, Y) Z^{-5},$$

and

$$\sigma(X, Y, Z) = \lambda g(X, Y) Z + \lambda g(Z, Y) X + (\lambda - 1) g(X, Z) Y.$$
(5.1)

It can be easily verified that for any bi-linear form g formula (5.1) defines a triple Jordan system iff $\lambda = 1$ or $\lambda = \frac{1}{2}$ (cf. (3.34)). Both these triple systems are known to be simple [8].

Example 3. An elegant description [9] of all geometric objects for equation (3.8) can be done in terms of the simple triple Jordan system (cf. (5.1))

$$S(X,Y,Z) \stackrel{\text{def}}{=} (X,Y) Z + (Z,Y) X - (X,Z) Y.$$

We have

$$\begin{split} A(X,Y) &= S(X,F,Y), \quad \text{where} \quad F \stackrel{def}{=} -\frac{\boldsymbol{u}}{\boldsymbol{u}_{[0,0]}}, \\ \sigma(X,Y,Z) &= -\frac{1}{2} S(X,\,S(F,Y,F),\,Z), \\ R(X,Y,Z) &= \sigma(X,Z,Y) - \sigma(X,Y,Z), \qquad \beta(X,X,X) = \sigma(X,X,X) \end{split}$$

The tensor $\beta(X, Y, Z)$ can be obtained from $\beta(X, X, X)$ by the symmetrization.

6 Appendix. Integrable triangular systems

Since T = 0 for triangular systems of the form (3.31), we may use the integrability conditions (1.4) - (1.8) for the classification of triangular systems.

Lemma 2. Using a transformation of the form (3.23), we can reduce the coefficient a_5 in (3.31) to

• Case a: $a_5 = 0;$

⁵This formula means that we are dealing with the space of the constant curvature k = 1.

• Case b: $a_5(x) = \frac{3}{x}$.

In the **Case a** the conditions (1.4) - (1.8) are equivalent to $a_6 = a_7 = a_8 = a_9 = 0$ and we arrive at the systems

$$\boldsymbol{u}_{t} = \boldsymbol{u}_{3} - 3\boldsymbol{u}_{2}\frac{u_{[0,1]}}{u_{[0,0]}} + \boldsymbol{u}_{1}\left((9 - c_{1})\frac{u_{[0,1]}^{2}}{u_{[0,0]}^{2}} - 3\frac{u_{[0,2]}}{u_{[0,0]}} + (c_{1} - 3)\frac{u_{[1,1]}}{u_{[0,0]}}\right), \qquad c_{1} = 3, \frac{3}{2}.$$

In the **Case b** we may use transformations (3.23) to vanish a_6 . Transformations (3.23) with

$$f(x) = k_1 x^{k_2}, (6.1)$$

where k_i are arbitrary constants, preserve the normalization $a_6 = 0$. From conditions (1.4) - (1.8) it follows that

Case b₁:
$$a_7(x) = -\frac{3}{x^2}$$
 or **Case b**₂: $a_7(x) = -\frac{c_1 + 3}{x^2}$.

In the Case b_1 conditions (1.4) - (1.8) imply $c_1 = \frac{3}{2}$ and $a_8(x) = -\frac{1}{x^3}$ and we obtain the equation

$$\boldsymbol{u}_{t} = \boldsymbol{u}_{3} - 3\boldsymbol{u}_{2}\frac{u_{[0,1]}}{u_{[0,0]}} + \boldsymbol{u}_{1}\left(\frac{15}{2}\frac{u_{[0,1]}^{2}}{u_{[0,0]}^{2}} - 3\frac{u_{[0,2]}}{u_{[0,0]}} - \frac{3}{2}\frac{u_{[1,1]}}{u_{[0,0]}}\right) + \boldsymbol{u}\left(3\frac{u_{[1,2]}}{u_{[0,0]}} - 3\frac{u_{[0,1]}u_{[1,1]}}{u_{[0,0]}^{2}} - \frac{u_{[0,1]}^{3}}{u_{[0,0]}^{3}}\right).$$

This equation is invariant with respect to the group of transformations (3.23), (6.1).

In the Case b_2 we get $a_8 = \frac{k}{x^3}$, where k is a constant. By a transformation (3.23), (6.1) we can bring k to zero. As a result we obtain

$$\begin{aligned} \boldsymbol{u}_{t} &= \boldsymbol{u}_{3} - 3\boldsymbol{u}_{2}\frac{u_{[0,1]}}{u_{[0,0]}} + \boldsymbol{u}_{1}\left((9 - c_{1})\frac{u_{[0,1]}^{2}}{u_{[0,0]}^{2}} - 3\frac{u_{[0,2]}}{u_{[0,0]}} + (c_{1} - 3)\frac{u_{[1,1]}}{u_{[0,0]}}\right) + \\ & \boldsymbol{u}\left(3\frac{u_{[1,2]}}{u_{[0,0]}} - (c_{1} + 3)\frac{u_{[0,1]}u_{[1,1]}}{u_{[0,0]}^{2}}\right) \qquad c_{1} = 3, \frac{3}{2}. \end{aligned}$$

Both of these equations admit a **total** separation of variables in the spherical coordinates: the equation with $c_1 = 3$ is converted to

$$v_t = v_{xxx} + 3v_x v_{[1,1]} + 3v v_{[1,2]}, \qquad R_t = R_{xxx} - 3\frac{R_x R_{xx}}{R}$$

while the equation with $c_1 = \frac{3}{2}$ turns into

$$\boldsymbol{v}_t = \boldsymbol{v}_{xxx} + \frac{3}{2} \boldsymbol{v}_x v_{[1,1]} + 3 \boldsymbol{v} v_{[1,2]}, \qquad R_t = R_{xxx} - 3 \frac{R_x R_{xx}}{R} + \frac{3}{2} \frac{R_x^3}{R^2}.$$

In both cases the scalar equation for R is point equivalent to the integrable equation $\tilde{R}_t = \tilde{R}_{xxx} + \tilde{R}_x^3$.

The equation from Case b_1 and the equations from Case **a** admit a **partial** separation of variables in the spherical coordinates.
