# IHARA ZETA FUNCTION, COEFFICIENTS OF MACLAURIN SERIES, AND RAMANUJAN GRAPHS

Abstract. Let $X$ denote a connected ( $q+1$ )-regular undirected graph of finite order $n$. The graph $X$ is called Ramanujan whenever

$$
|\lambda| \leq 2 q^{\frac{1}{2}}
$$

for all nontrivial eigenvalues $\lambda$ of $X$. We consider the variant $\Xi(u)$ of the Ihara zeta function $Z(u)$ of $X$ defined by

$$
\Xi(u)^{-1}= \begin{cases}(1-u)(1-q u)\left(1-q^{\frac{1}{2}} u\right)^{2 n-2}\left(1-u^{2}\right)^{\frac{n(q-1)}{2}} Z(u) & \text { if } X \text { is nonbipartite } \\ \left(1-q^{2} u^{2}\right)\left(1-q^{\frac{1}{2}} u\right)^{2 n-4}\left(1-u^{2}\right)^{\frac{n(q-1)}{2}+1} Z(u) & \text { if } X \text { is bipartite. }\end{cases}
$$

The function $\Xi(u)$ satisfies the functional equation $\Xi\left(q^{-1} u^{-1}\right)=\Xi(u)$. Let $\left\{h_{k}\right\}_{k=1}^{\infty}$ denote the number sequence given by

$$
\frac{d}{d u} \ln \Xi\left(q^{-\frac{1}{2}} u\right)=\sum_{k=0}^{\infty} h_{k+1} u^{k}
$$

In this paper we establish the equivalence of the following statements: (i) $X$ is Ramanujan; (ii) $h_{k} \geq 0$ for all $k \geq 1$; (iii) $h_{k} \geq 0$ for infinitely many even $k \geq 2$. Furthermore we derive the Hasse-Weil bound for the Ramanujan graphs.

## 1. Introduction

The motivation of this paper originates from developing a graph theoretical counterpart of the following sufficient and necessary condition for the Riemann hypothesis. Recall that the Riemann zeta function $\zeta(s)$ is the analytic continuation of

$$
\sum_{n=1}^{\infty} \frac{1}{n^{s}}
$$

The negative even integers are trivial zeros of $\zeta(s)$ and the Riemann hypothesis asserts that the real part of every nontrivial zero of $\zeta(s)$ is $\frac{1}{2}$. The Riemann xi function $\xi(s)$ is a variation of $\zeta(s)$ defined by

$$
\xi(s)=\frac{1}{2} s(s-1) \pi^{-\frac{s}{2}} \Gamma\left(\frac{s}{2}\right) \zeta(s)
$$

where $\Gamma(s)$ is the Gamma function. The function $\xi(s)$ satisfies the functional equation

$$
\xi(1-s)=\xi(s) .
$$

Let $\left\{\lambda_{k}\right\}_{k=1}^{\infty}$ denote the number sequence given by

$$
\frac{d}{d z} \ln \xi\left(\frac{1}{1-z}\right)=\sum_{k=0}^{\infty} \lambda_{k+1} z^{k}
$$

Li's criterion states that the Riemann hypothesis holds if and only if $\lambda_{k} \geq 0$ for all $k \geq 1$ [4].
Let $X$ denote an undirected graph of finite order allowing loops and multiple edges. We endow two opposite orientations on all edges of $X$ called the oriented edges of $X$. Given a vertex $x$ of $X$ the valency of $x$ is the number of oriented edges with the initial vertex $x$. If the valency of $x$ is
equal to a constant $k$ for all vertices $x$ of $X$ then $X$ is said to be $k$-regular. The adjacency matrix $A$ of $X$ is a square matrix indexed by the vertices of $X$ whose $(x, y)$-entry is defined as the number of oriented edges from $x$ to $y$ for all vertices $x, y$ of $X$. Since $A$ is symmetric $A$ is diagonalizable with real eigenvalues. The eigenvalues of $A$ are also called the eigenvalues of $X$. A walk is a nonempty finite sequence of oriented edges which joins vertices. The length of a walk is the number of oriented edges in the walk. The graph $X$ is said to be connected if there exists a walk from $x$ to $y$ for any two distinct vertices $x, y$ of $X$. A cycle is meant to be a walk from a vertex to itself. If all cycles on $X$ have even length then $X$ is called bipartite. A walk is said to have backtracking if an oriented edge is immediately followed by its opposite orientation in the walk. A cycle is said to be geodesic if all shifted cycles are backtrackless. For all $k \geq 1$ let $N_{k}$ denote the number of geodesic cycles on $X$ of length $k$. The Ihara zeta function $Z(u)$ of $X$ is the analytic continuation of

$$
\begin{equation*}
\exp \left(\sum_{k=1}^{\infty} \frac{N_{k}}{k} u^{k}\right) . \tag{1}
\end{equation*}
$$

For the rest of this paper, we always assume that $X$ is a connected $(q+1)$-regular undirected graph of finite order $n$ with $q \geq 1$ and $n \geq 3$. In this case, the eigenvalues of $X$ with absolute value $q+1$ are called trivial eigenvalues and the poles of $Z(u)$ with values $\pm 1$ and $\pm q^{-1}$ are called trivial poles. The graph $X$ is said to be Ramanujan whenever

$$
|\lambda| \leq 2 q^{\frac{1}{2}}
$$

for all nontrivial eigenvalues $\lambda$ of $X$ [5]. The graph $X$ is Ramanujan if and only if all nontrivial poles of $Z(u)$ have the same absolute value $q^{-\frac{1}{2}}$, which is similar to the Riemann hypothesis by writing $u=q^{-s}[3,[8]$. We define the function $\Xi(u)$ by

$$
\Xi(u)^{-1}= \begin{cases}(1-u)(1-q u)\left(1-q^{\frac{1}{2}} u\right)^{2 n-2}\left(1-u^{2}\right)^{\frac{n(q-1)}{2}} Z(u) & \text { if } X \text { is nonbipartite },  \tag{2}\\ \left(1-q^{2} u^{2}\right)\left(1-q^{\frac{1}{2}} u\right)^{2 n-4}\left(1-u^{2}\right)^{\frac{n q-1)}{2}+1} Z(u) & \text { if } X \text { is bipartite. }\end{cases}
$$

The function $\Xi(u)$ is considered as the Ihara xi function which satisfies the functional equation

$$
\Xi\left(q^{-1} u^{-1}\right)=\Xi(u) .
$$

If we set $u=q^{-s}$, then this becomes a functional equation relating $1-s$ and $s$ similar to the Riemann xi function.

Definition 1.1. Let $\left\{h_{k}\right\}_{k=1}^{\infty}$ denote the number sequence given by

$$
\frac{d}{d u} \ln \Xi\left(q^{-\frac{1}{2}} u\right)=\sum_{k=0}^{\infty} h_{k+1} u^{k} .
$$

The main results of this paper are as follows:
Theorem 1.2. If there is a positive even integer $k$ with $h_{k} \geq 0$ then

$$
|\lambda| \leq \begin{cases}(1+\sqrt[k]{4 n-7}) q^{\frac{1}{2}} & \text { if } X \text { is nonbipartite } \\ (1+\sqrt[k]{2 n-7}) q^{\frac{1}{2}} & \text { if } X \text { is bipartite }\end{cases}
$$

for all nontrivial eigenvalues $\lambda$ of $X$.
Theorem 1.3. The following are equivalent:
(i) $X$ is Ramanujan.
(ii) $h_{k} \geq 0$ for all $k \geq 1$.
(iii) $h_{k} \geq 0$ for infinitely many even $k \geq 2$.

Theorem 1.4. (i) If $X$ is nonbipartite, then $X$ is Ramanujan if and only if

$$
\begin{aligned}
\left|N_{k}-q^{k}-1\right| \leq 2(n-1) q^{\frac{k}{2}} & \text { for all odd } k ; \\
\left|N_{k}-n(q-1)-q^{k}-1\right| \leq 2(n-1) q^{\frac{k}{2}} & \text { for all even } k .
\end{aligned}
$$

(ii) If $X$ is bipartite, then $X$ is Ramanujan if and only if

$$
\left|N_{k}-n(q-1)-2 q^{k}-2\right| \leq 2(n-2) q^{\frac{k}{2}} \quad \text { for all even } k .
$$

Theorem 1.2 is an improvement of the implication from Theorem 1.3 (iii) to Theorem $1.3(\mathrm{i})$. The equivalence of Theorem [1.3(i), (ii) is an analogue of Li's criterion. In [7, §1.3] it was shown that if $X$ is nonbipartite Ramanujan then $N_{k}=q^{k}+O\left(n q^{\frac{k}{2}}\right)$; if $X$ is bipartite Ramanujan then $N_{k}=2 q^{k}+O\left(n q^{\frac{k}{2}}\right)$ for even $k$. Theorem [1.4 strengthens the above necessary conditions for $X$ as Ramanujan. Furthermore, Theorem 1.4 is an analogue of the Hasse-Weil bound 9 .

The paper is organized as follows: In $\S 2$ we give some preliminaries on $Z(u)$ and $\Xi(u)$. In $\S 3\}$ we derive three formulae for $\left\{h_{k}\right\}_{k=1}^{\infty}$. In $\mathbb{4}$ we prove Theorems 1.2 1.4. In $\mathbb{5}$ we discuss the behavior of $\left\{h_{2 k}\right\}_{k=1}^{\infty}$ when $X$ is not Ramanujan.

## 2. The Ihara zeta and xi functions

Let $\operatorname{Spec}(X)$ denote the spectrum of $X$; that is the multiset of all eigenvalues of $X$ with geometric multiplicities. Since $X$ is a connected $(q+1)$-regular undirected graph, the value $q+1 \in \operatorname{Spec}(X)$ with multiplicity one. Ihara's theorem [2] states that $Z(u)$ is a rational function of the form

$$
\begin{equation*}
Z(u)^{-1}=\left(1-u^{2}\right)^{\frac{n(q-1)}{2}} \prod_{\lambda \in \operatorname{Spec}(X)} 1-\lambda u+q u^{2} . \tag{3}
\end{equation*}
$$

Substituting (3) into (21) yields that

$$
\Xi^{-1}(u)= \begin{cases}\frac{(1-u)(1-q u)\left(1-q^{\frac{1}{2}} u\right)^{2 n-2}}{\prod_{\lambda \in \operatorname{Spec}(X)}^{1-\lambda u+q u^{2}}} & \text { if } X \text { is nonbipartite }  \tag{4}\\ \frac{\left(1-u^{2}\right)\left(1-q^{2} u^{2}\right)\left(1-q^{\frac{1}{2}} u\right)^{2 n-4}}{\prod_{\lambda \in \operatorname{Spec}(X)} 1-\lambda u+q u^{2}} & \text { if } X \text { is bipartite. }\end{cases}
$$

Let $\operatorname{Spec}^{*}(X)$ denote the multiset of all nontrivial eigenvalues of $X$ with geometric multiplicities. Recall that $\operatorname{Spec}(X)$ is symmetric with respect to 0 when $X$ is bipartite. Hence

$$
\operatorname{Spec}^{*}(X)= \begin{cases}\operatorname{Spec}(X) \backslash\{q+1\} & \text { if } X \text { is nonbipartite },  \tag{5}\\ \operatorname{Spec}(X) \backslash\{ \pm(q+1)\} & \text { if } X \text { is bipartite. }\end{cases}
$$

Combined with (4) we obtain that

$$
\begin{equation*}
\Xi(u)=\prod_{\lambda \in \operatorname{Spec}^{*}(X)} \frac{1-\lambda u+q u^{2}}{\left(1-q^{\frac{1}{2}} u\right)^{2}} . \tag{6}
\end{equation*}
$$

Proposition 2.1. $\Xi(u)$ satisfies the functional equation $\Xi\left(q^{-1} u^{-1}\right)=\Xi(u)$.
Proof. It is routine to verify the proposition by using (6).

## 3. Formulae for $h_{k}$

Recall the sequence $\left\{h_{k}\right\}_{k=1}^{\infty}$ from Definition [1.1. In this section we give two combinatorial formulae for $\left\{h_{k}\right\}_{k=1}^{\infty}$ and a formula for $\left\{h_{k}\right\}_{k=1}^{\infty}$ in terms of the Chebyshev polynomials.

Proposition 3.1. (i) If $X$ is nonbipartite then

$$
h_{k}= \begin{cases}2(n-1)+q^{\frac{k}{2}}+q^{-\frac{k}{2}}-q^{-\frac{k}{2}} N_{k} & \text { for all odd } k, \\ 2(n-1)+q^{\frac{k}{2}}+q^{-\frac{k}{2}}-q^{-\frac{k}{2}}\left(N_{k}-n(q-1)\right) & \text { for all even } k .\end{cases}
$$

(ii) If $X$ is bipartite then

$$
h_{k}= \begin{cases}2(n-2) & \text { for all odd } k, \\ 2\left(n-2+q^{\frac{k}{2}}+q^{-\frac{k}{2}}\right)-q^{-\frac{k}{2}}\left(N_{k}-n(q-1)\right) & \text { for all even } k .\end{cases}
$$

Proof. Taking logarithm on (1) yields that

$$
\begin{equation*}
\ln Z(u)=\sum_{k=1}^{\infty} \frac{N_{k}}{k} u^{k} . \tag{7}
\end{equation*}
$$

Evaluate $h_{k}$ by using (2) and (17) directly.
Let $\left\{T_{k}(x)\right\}_{k=0}^{\infty}$ denote the polynomials defined by

$$
x T_{k}(x)=T_{k+1}(x)+T_{k-1}(x) \quad \text { for all } k \geq 1
$$

with $T_{0}(x)=2$ and $T_{1}(x)=x$ [1, $\left.\S 2.3\right]$. Note that $\frac{1}{2} T_{k}(2 x)$ is the $k$ th Chebyshev polynomial of the first kind for all $k \geq 0$ [6].
Lemma 3.2 ([1,6]). $T_{k}\left(x+x^{-1}\right)=x^{k}+x^{-k}$ for all $k \geq 0$.
Given a multiset $S$ of numbers and a constant $c$, we let $c S$ denote the multiset consisting of $c s$ for all $s \in S$.
Proposition 3.3. For all $k \geq 1$ the following equation holds:

$$
h_{k}=2\left|\operatorname{Spec}^{*}(X)\right|-\sum_{s \in q^{-1 / 2} \operatorname{Spec}^{*}(X)} T_{k}(s) .
$$

Proof. Let $S=q^{-\frac{1}{2}} \operatorname{Spec}^{*}(X)$. Applying (6) yields that

$$
\begin{aligned}
\ln \Xi\left(q^{-\frac{1}{2}} u\right) & =\sum_{s \in S} \ln \left(1-s u+u^{2}\right)-2|S| \ln (1-u) \\
& =\sum_{s \in S} \ln \left(1-s u+u^{2}\right)+2|S| \sum_{k=1}^{\infty} \frac{u^{k}}{k} .
\end{aligned}
$$

Let $s \in S$ be given. Write $s=\alpha+\alpha^{-1}$ for some nonzero complex number $\alpha$. Then

$$
\ln \left(1-s u+u^{2}\right)=\ln (1-\alpha u)+\ln \left(1-\alpha^{-1} u\right)=-\sum_{k=1}^{\infty} \frac{\alpha^{k}+\alpha^{-k}}{k} u^{k}
$$

It follows from Lemma 3.2 that $T_{k}(s)=\alpha^{k}+\alpha^{-k}$. By the above comments we have

$$
\ln \Xi\left(q^{-\frac{1}{2}} u\right)=\sum_{k=1}^{\infty} \frac{2|S|-\sum_{s \in S} T_{k}(s)}{k} u^{k} .
$$

Now the proposition follows by taking differential on both sides of the above equation.
For convenience we define $\binom{-1}{-1}=1$ and $\binom{k}{-1}=0$ for all $k \geq 0$.
Lemma 3.4 ([1,6]). $T_{k}(x)=\sum_{i=0}^{\left\lfloor\frac{k}{2}\right\rfloor}(-1)^{i}\left(\binom{k-i}{i}+\binom{k-i-1}{i-1}\right) x^{k-2 i}$ for all $k \geq 0$.
For all $k \geq 1$ let $C_{k}$ denote the number of the cycles on $X$ of length $k$ and define $C_{0}=n$.

Lemma 3.5. $\sum_{s \in q^{-1 / 2} \operatorname{Spec}(X)} T_{k}(s)=q^{-\frac{k}{2}} \sum_{i=0}^{\left\lfloor\frac{k}{2}\right\rfloor}(-q)^{i}\left(\binom{k-i}{i}+\binom{k-i-1}{i-1}\right) C_{k-2 i}$ for all $k \geq 0$.
Proof. Evaluate the left-hand side by using Lemma 3.4 along with the fact $C_{k}=\sum_{\lambda \in \operatorname{Spec}(X)} \lambda^{k}$ for all $k \geq 0$.

Combining Propositions 3.1 and 3.3 yields that

$$
N_{k}= \begin{cases}q^{\frac{k}{2}} \sum_{s \in q^{-1 / 2} \operatorname{Spec}(X)} T_{k}(s) & \text { for all odd } k,  \tag{8}\\ n(q-1)+q^{\frac{k}{2}} \sum_{s \in q^{-1 / 2} \operatorname{Spec}(X)} T_{k}(s) & \text { for all even } k\end{cases}
$$

As far as we know, the formula (8) was first given in [7] Lemma 4] and it was given a proof of [7, Lemma 4] without using (31). By Lemma 3.5 and (8) we have the following lemma:

Lemma 3.6. The following equation holds:

$$
N_{k}= \begin{cases}\sum_{i=0}^{\frac{k-1}{2}}(-q)^{i}\left(\binom{k-i}{i}+\binom{k-i-1}{i-1}\right) C_{k-2 i} & \text { for all odd } k, \\ n(q-1)+\sum_{i=0}^{\frac{k}{2}}(-q)^{i}\left(\binom{k-i}{i}+\binom{k-i-1}{i-1}\right) C_{k-2 i} & \text { for all even } k .\end{cases}
$$

Proposition 3.7. (i) If $X$ is nonbipartite then

$$
h_{k}=2(n-1)+q^{\frac{k}{2}}+q^{-\frac{k}{2}}-q^{-\frac{k}{2}} \sum_{i=0}^{\left\lfloor\frac{k}{2}\right\rfloor}(-q)^{i}\left(\binom{k-i}{i}+\binom{k-i-1}{i-1}\right) C_{k-2 i} \quad \text { for all } k \geq 1
$$

(ii) If $X$ is bipartite then

$$
h_{k}= \begin{cases}2(n-2) & \text { for all odd } k \\ 2\left(n-2+q^{\frac{k}{2}}+q^{-\frac{k}{2}}\right)-q^{-\frac{k}{2}} \sum_{i=0}^{\frac{k}{2}}(-q)^{i}\left(\binom{k-i}{i}+\binom{k-i-1}{i-1}\right) C_{k-2 i} & \text { for all even } k .\end{cases}
$$

Proof. Combine Proposition 3.1 and Lemma 3.6 ,

## 4. Proof of the main results

In this section we show Theorems 1.2 1.4.
Lemma 4.1. For all $k \geq 1$ the coefficient $h_{k} \geq 0$ if and only if

$$
\frac{1}{2\left|\operatorname{Spec}^{*}(X)\right|} \sum_{s \in q^{-1 / 2} \operatorname{Spec}^{*}(X)} T_{k}(s) \leq 1 .
$$

Proof. Immediate from Proposition 3.3.
Lemma 4.2 ([6]). $T_{k}(2 \cos \theta)=2 \cos k \theta$ for all $k \geq 0$ and all real numbers $\theta$.
Lemma 4.3. If $s$ is a real number with $|s| \leq 2$ then $\left|T_{k}(s)\right| \leq 2$ for all $k \geq 0$.
Proof. Immediate from Lemma 4.2,

Lemma 4.4. If $X$ is Ramanujan then $\left|T_{k}(s)\right| \leq 2$ for all $k \geq 0$ and all $s \in q^{-1 / 2} \operatorname{Spec}^{*}(X)$.
Proof. Since $X$ is Ramanujan if and only if $|s| \leq 2$ for all $s \in q^{-1 / 2} \operatorname{Spec}^{*}(X)$, the lemma is immediate from Lemma 4.3 ,

Lemma 4.5 ([6]). $T_{k}(x)=2\left(\frac{x}{2}\right)^{k} \sum_{i=0}^{\left\lfloor\frac{k}{2}\right\rfloor}\binom{k}{2 i}\left(1-\left(\frac{x}{2}\right)^{-2}\right)^{i}$ for all $k \geq 0$.
Lemma 4.6. If $s$ is a real number with $|s|>2$ then $T_{k}(s)>0$ for all even $k \geq 0$.
Proof. Immediate from Lemma 4.5 .
Proposition 4.7. Let $S$ denote a nonempty finite multiset consisting of real numbers. If there is a positive even integer $k$ with

$$
\begin{equation*}
\frac{1}{2|S|} \sum_{s \in S} T_{k}(s) \leq 1 \tag{9}
\end{equation*}
$$

then $|s| \leq 1+\sqrt[k]{4|S|-3}$ for all $s \in S$.
Proof. For convenience let

$$
\begin{equation*}
\varepsilon=\frac{\sqrt[k]{4|S|-3}-1}{\sqrt[k]{4|S|-3}+1} . \tag{10}
\end{equation*}
$$

Suppose on the contrary that there is a real number $t \in S$ with

$$
\begin{equation*}
|t|>1+\sqrt[k]{4|S|-3}=\frac{2}{1-\varepsilon} \tag{11}
\end{equation*}
$$

Using (11) yields that $1-\left(\frac{t}{2}\right)^{-2}>1-(1-\varepsilon)^{2}=2 \varepsilon-\varepsilon^{2}$. Since $0<\varepsilon<1$ we have $\varepsilon^{2}<2 \varepsilon-\varepsilon^{2}$. Combined with Lemma 4.5 this implies

$$
\frac{1}{2} T_{k}(t)>\left(\frac{t}{2}\right)^{k} \sum_{i=0}^{\left\lfloor\frac{k}{2}\right\rfloor}\binom{k}{2 i} \varepsilon^{2 i}=\left(\frac{t}{2}\right)^{k} \frac{(1+\varepsilon)^{k}+(1-\varepsilon)^{k}}{2}
$$

By Lemmas 4.3 and 4.6 we have $T_{k}(s) \geq-2$ for all $s \in S \backslash\{t\}$.
Combining (9) with the above comments yields that

$$
|S| \geq \frac{1}{2} \sum_{s \in S} T_{k}(s)=\frac{1}{2} T_{k}(t)+\frac{1}{2} \sum_{s \in S \backslash\{t\}} T_{k}(s)>\left(\frac{t}{2}\right)^{k} \frac{(1+\varepsilon)^{k}+(1-\varepsilon)^{k}}{2}-(|S|-1) .
$$

It leads to

$$
\begin{equation*}
\left(\frac{t}{2}\right)^{k}<\frac{4|S|-2}{(1+\varepsilon)^{k}+(1-\varepsilon)^{k}} \tag{12}
\end{equation*}
$$

Since $k$ is even the inequality (11) implies that

$$
\begin{equation*}
\left(\frac{t}{2}\right)^{k}>\frac{1}{(1-\varepsilon)^{k}} \tag{13}
\end{equation*}
$$

Combining (12) and (13) we see that

$$
\begin{equation*}
\frac{1}{(1-\varepsilon)^{k}}<\frac{4|S|-2}{(1+\varepsilon)^{k}+(1-\varepsilon)^{k}} . \tag{14}
\end{equation*}
$$

Using the setting (10) it is routine to verify that both sides of (14) are equal, a contradiction. The proposition follows.

Proof of Theorem 1.2. By Lemma 4.1, when $X$ is nonbipartite the result follows by applying Proposition 4.7 with $S$ replaced by $q^{-1 / 2} \operatorname{Spec}^{*}(X)$.

Note that the number of zeros in $\operatorname{Spec}^{*}(X)$ is even if the regular graph $X$ is bipartite. Since $k$ is even it follows from Lemma 3.2 that $T_{k}(x)$ is an even function. Combined with Lemma 4.1, when $X$ is bipartite the result follows by applying Proposition 4.7 with $S$ chosen as the multiset of all positive numbers and a half number of zeros in $q^{-1 / 2} \operatorname{Spec}^{*}(X)$.

Proof of Theorem 1.3. (i) $\Rightarrow$ (ii): Combine Lemmas 4.1 and 4.4 .
(ii) $\Rightarrow$ (iii): It is obvious.
(iii) $\Rightarrow$ (i): Immediate from Theorem 1.2,

Lemma 4.8. If $X$ is Ramanujan then

$$
h_{k} \leq \begin{cases}4(n-1) & \text { if } X \text { is nonbipartite } \\ 4(n-2) & \text { if } X \text { is bipartite }\end{cases}
$$

for all $k \geq 1$.
Proof. By Proposition 3.3 and Lemma 4.4 the coefficient $h_{k} \leq 4\left|\operatorname{Spec}^{*}(X)\right|$ for all $k \geq 1$. Hence the lemma follows by (5).

Proof of Theorem 1.4. Combine Theorem 1.3(i), (ii) and Proposition 3.1] along with Lemma 4.8, $\square$

## 5. Behavior of $h_{2 k}$

We end this paper with a remark on $\left\{h_{2 k}\right\}_{k=1}^{\infty}$ under the assumption that $X$ is not Ramanujan. Let $S$ denote the set of all nonzero complex numbers $\alpha$ with $\alpha+\alpha^{-1} \in q^{-1 / 2} \operatorname{Spec}^{*}(X)$. For those $s \in q^{-1 / 2} \operatorname{Spec}^{*}(X)$ with $|s| \leq 2$ the corresponding numbers $\alpha \in S$ have the same absolute value 1 . By the assumption that $X$ is not Ramanujan there exists an $s \in q^{-1 / 2} \operatorname{Spec}^{*}(X)$ with $|s|>2$ and the corresponding numbers $\alpha \in S$ are real and $\alpha \neq \pm 1$. Let

$$
\mu=\max _{\alpha \in S}|\alpha|>1 .
$$

Since the function $f(x)=x+x^{-1}$ is strictly increasing on $(1, \infty)$, it follows that

$$
\mu+\mu^{-1}=\max _{\alpha \in S}|\alpha|+|\alpha|^{-1}=\max _{s \in q^{-1 / 2} \operatorname{Spec}^{*}(X)}|s| .
$$

Using Lemma 3.2 yields that

$$
\lim _{k \rightarrow \infty} \frac{T_{2 k}\left(\alpha+\alpha^{-1}\right)}{\mu^{2 k}}= \begin{cases}0 & \text { if } \mu>|\alpha| \text { and } \mu>|\alpha|^{-1} \\ 1 & \text { else }\end{cases}
$$

for all $\alpha \in S$. It follows from Proposition 3.3 that $h_{2 k}$ is asymptotic to $-m \mu^{2 k}$ as $k$ approaches to $\infty$, where $m$ is the number of $s \in q^{-1 / 2} \operatorname{Spec}^{*}(X)$ with $|s|=\mu+\mu^{-1}$. Therefore the following result holds:

Theorem 5.1. If $X$ is not Ramanujan then

$$
q^{-\frac{1}{2}} \max |\lambda|=\lim _{k \rightarrow \infty} \sqrt{\frac{h_{2 k+2}}{h_{2 k}}}+\sqrt{\frac{h_{2 k}}{h_{2 k+2}}}
$$

where max is over all nontrivial eigenvalues $\lambda$ of $X$.
