# Late time approach to Hawking radiation: terms beyond leading order

#### Abstract

Black hole evaporation is studied using wave packets for the modes. These allow for approximate frequency and time resolution. The leading order late time behavior gives the well known Hawking radiation that is independent of how the black hole formed. The focus here is on the higher order terms and the rate at which they damp at late times. Some of these terms carry information about how the black hole formed. A general argument is given which shows that the damping is significantly slower (power law) than what might be expected from the stationary phase approximation (exponential). This result is verified by numerical calculations in the cases of 2D and 4D black holes that form from the collapse of a null shell.


Hawking's seminal work showed that particle production occurs when matter collapses to form a black hole and that at late times the particles are produced in a thermal spectrum (modulo the gray body factor) at a temperature that is related to the surface gravity at the event horizon of the black hole [1]. This gives rise to the well known information issue [2-5] which involves the apparent loss of information during the formation of the black hole.

Although the leading order late time thermal radiation has been thoroughly studied in many different ways, much less attention has been paid to the early time nonthermal radiation which at late enough times becomes negligible compared with the thermal radiation. In [6] a study was done on the time dependence of the particle production that occurs due to a massless minimally coupled scalar field when a spherically symmetric null shell collapses to form a black hole in both two and four spacetime dimensions. An exact correspondence [6-9] between the particle production that occurs due to the collapse of the shell and that which occurs in 2D for a mirror undergoing a particular trajectory in flat space was shown.

In this paper we study the late time behavior of the particle production process, focusing on the late time behavior of the terms that are beyond leading order. After deriving a general form for the equations that describe the particle production process, we show that a stationary phase approximation gives the late time leading order results found by Hawking with correction terms that are exponentially damped in time. We then show that the true next to leading order (and next to next to leading order, etc.) are power law damped at late times.

For simplicity, the derivation we show uses the form of the Bogolubov coefficients for a massless minimally coupled scalar field in a 2D black hole spacetime that forms from collapse in an asymptotically flat spacetime. However, the derivation can be generalized immediately and trivially to the case of 4 D spherically symmetric collapse and almost certainly to the general case of 4D collapse to form a black hole in an asymptotically flat spacetime.

We begin by noting that in the case of collapse to form a black hole one can expand the quantum field in terms of modes that correspond to the natural in vacuum state. For an asymptotically flat spacetime these are positive frequency at past null infinity, $\mathscr{I}^{-}$, and regular at the origin, $r=0$, inside the collapsing matter. (This is a necessity in 4D.) We denote these modes by $f_{\omega}^{\mathrm{in}}$. For asymptotically flat spacetimes the modes in the out vacuum state that we are concerned with are positive frequency at future null infinity, $\mathscr{I}^{+}$, and vanish on the future horizon $H^{+}$. We denote them by $f_{\omega}^{\text {out }}$. Note that they do not form a complete set. Then in the usual way we write one of these modes in terms of the complete set of in modes as follows:

The Bogolubov coefficients are $\alpha_{\omega \omega^{\prime}}=\left(f_{\omega}^{\text {out }}, f_{\omega^{\prime}}^{i n}\right), \beta_{\omega \omega^{\prime}}=-\left(f_{\omega}^{\text {out }}, f_{\omega^{\prime}}^{i n}\right)$, with

[^0]where $\Sigma$ is a Cauchy surface and $n^{a}$ is the normal to that surface. The average number of particles produced at frequency $\omega$ is,

This number is divergent if backreaction effects are not taken into account since the black hole then radiates forever.
To investigate the time-dependence of the particle production process Hawking used wave packets for the out modes,

with $n$ an integer and $j$ a nonnegative integer. Note that near future null infinity, $\mathscr{I}^{+}, f_{\omega}^{\text {out }} \sim e^{-i \omega\left(t_{s}-r_{*}\right)}$, with $r_{*}$ the usual tortoise coordinate, so the contribution to the integral is largest if $u_{s}=t_{s}-r_{*}=2 \pi n / \epsilon$. A packet with index $j$ covers the range of frequencies $j \epsilon \leq \omega \leq(j+1) \epsilon$, and one with index $n$ covers the approximate time range $(2 \pi n-\pi) / \epsilon \lesssim u_{s} \lesssim(2 \pi n+\pi) / \epsilon$.

One can also make packets out of the Bogolubov coefficients

It is useful to write the Bogolubov coefficients in the following form ${ }^{1}$

with $\kappa$ the surface gravity of the black hole and $B\left(\omega, \omega^{\prime}\right)$ a slowly varying function of $\omega^{\prime}$. Then one finds that

A stationary phase approximation can be used to determine the leading order behavior with the stationary phase point,

At late times $\omega_{s}^{\prime} \gg \kappa$ and one can expand $B\left(\omega, \omega^{\prime}\right)$ in inverse powers of $\omega^{\prime}$ such that,

Note that the factor $e^{i \delta \omega^{\prime}}$ does not affect the particle number. Using this in (7) and keeping just the first term gives Hawking's result which is independent of $n$. Including higher order terms results in contributions that are exponentially damped in $n$.

This analysis might lead one to believe that the distribution of particles approaches exponentially in time the thermal one (modulo the graybody factor) predicted by Hawking. However, it turns out that there are contributions to the triple integral that go like inverse powers of $n$ at late times. The procedure we have used to isolate these terms is given next.

First assume $2 \pi n \kappa \epsilon^{-1} \gg 1$ and then break the integral over $\omega^{\prime}$ into two parts with the first part going from $\omega^{\prime}=0$ to $\omega^{\prime}=\Lambda$ and the second part going from $\omega^{\prime}=\Lambda$ to $\omega^{\prime}=\infty$. The cutoff $\Lambda$ should be chosen so it is in the range

[^1]$(j+1) \epsilon \ll \Lambda \ll \omega_{s}^{\prime}=\kappa e^{2 \pi n \kappa \epsilon^{-1}}$. This will always work for fixed $j$ and $\epsilon$ if large enough values of $n$ are used. Then for the second term the same triple integral with $B\left(\omega, \omega^{\prime}\right) \rightarrow B_{H}(\omega)$ is subtracted off and added back on with the result

Note that $N_{j n}$ is independent of the value of $\Lambda$.
The leading and next to leading order behaviors for large values of $n$ come from $N_{3}$. To see this one can break this integral into two parts such that

Integrating (11a) over $\omega^{\prime}$ and then $\omega_{2}$, and dropping the subscript on $\omega_{1}$ gives the leading order late time behavior found by Hawking [1]

which is independent of $n$.
The next to leading order is obtained from $N_{3 b}$ by integrating the integrals over both $\omega_{1}$ and $\omega_{2}$ by parts and noting that since $j$ and $n$ are integers, $e^{i 2 \pi n(j+1)}=e^{i 2 \pi n j}=1$. With the change of variables $\kappa z=\log \left(\kappa^{-1} \omega^{\prime}\right)$, the result is

where $\kappa Z=\log \left(\kappa^{-1} \Lambda\right)$. The first two terms can be integrated exactly and the last two terms can be integrated by parts to yield

It is easy to see by integrating the integrals over $\omega_{1}$ and $\omega_{2}$ in $N_{1}$ by parts that for large enough values of $n$, $N_{1}=O\left(n^{-2}\right)$. Note that the stationary phase point (8) lies outside of the integration range for this integral.

For $N_{2}$ the stationary phase point (8) is within the integration range. Further the expansion (9) can be used throughout the integration range. Substitution into (10c) shows that to leading order the integrand goes like $\omega^{\prime-1}$. Thus the contribution to the integral from the stationary phase point is of order $e^{-2 \pi n \kappa \epsilon^{-1}}$. This is negligible compared with the contributions from the end points. To see this first make the substitution $\kappa z=\log \left(\kappa^{-1} \omega^{\prime}\right)$ with the result

Integration by parts for the remaining two integrals then shows that $N_{2}=O\left(n^{-2}\right)$.
It is important to note that some of the terms in $N_{1}$ and $N_{3}$ and all of the terms in $N_{2}$ that are of order $n^{-2}$ at large $n$ depend on the cutoff $\Lambda$. However, it is clear from (10) that the sum of these terms cannot depend on $\Lambda$.

We have checked these results for the case of particle production due to a massless minimally coupled scalar field that occurs when a black hole forms by the collapse of a null shell in 2D and 4D. In the latter case the shell is spherically symmetric. Previous studies of particle production when a null shell collapses in 4D to form a black hole were done in $[5,6,24,25]^{2}$.

In the 2 D case the Bogolubov coefficients were computed exactly in $[6,24]$ with the result

The trajectory of the null shell is $v=v_{0}$ with $v=t+r$ inside the shell, $v=t+r_{*}$ outside the shell, and $r_{*}=$ $r+2 M \log \frac{r-2 M}{2 M}$. Then $v_{H} \equiv v_{0}-\kappa^{-1}$ with $\kappa^{-1}=4 M$. In the large $\omega^{\prime}$ limit one finds to leading order that

As shown in [14] for the case of the Carlitz-Willy mirror trajectory [13], the thermal distribution can be explicitly recovered by first writing (18) in terms of $\omega_{j}=\left(j+\frac{1}{2}\right) \epsilon$, assuming $\frac{\epsilon}{\kappa} \ll 1$ while at the same time assuming that $\frac{j \epsilon}{\kappa} \gtrsim 1$ and then expanding in powers of $\frac{\epsilon}{\kappa}$. The result is

The quantities $n^{2} N_{1}, n^{2} N_{2}$, and $n N_{3 b}$ are plotted in Fig. (1). As predicted they each approach a constant value in the large $n$ limit. For $n N_{3 b}$ the constant can be obtained by multiplying (20) by $n$ and taking the limit $n \rightarrow \infty$.

In 4 D the metric inside the shell is the flat space metric

and outside the shell the metric is the Schwarzschild metric

with the surface gravity $\kappa=(4 M)^{-1}$. The time coordinate is the only one that is not continuous across the shell.
Inside the shell the usual radial null coordinates are $u=t-r$ and $v=t+r$ while outside the shell they are $u_{s}=t_{s}-r_{*}$ and $v=t_{s}+r_{*}$ with $r_{*}=r+2 M \log \left(\frac{r-2 M}{2 M}\right) \cdot v$ is continuous across the shell and on the shell $[5,24]$

The mode functions for the massless minimally coupled scalar field in the region outside of the shell and the horizon can be written in the form

In general they can be written in terms of two positive frequency mode functions $\psi_{R}^{\infty}$ and $\psi_{L}^{\infty}$ which are right and left moving respectively at infinity. Then the out modes, which are positive frequency right moving waves at future null infinity, can be written as

\psi_{\omega \ell}^{\text {out }}=\psi_{R}^{\infty}-\frac{F_{R}}{F_{L}} \psi_{L}^{\infty}, \tag{26}
\end{equation*}

with

\begin{align*}
& \psi_{R}^{\infty} \rightarrow e^{-i \omega u_{s}} \text { as } r \rightarrow \infty,  \tag{27a}\\
& \psi_{R}^{\infty} \rightarrow E_{R} e^{-i \omega u_{s}}+F_{R} e^{-i \omega v} \text { as } r \rightarrow 2 M,  \tag{27~b}\\
& \psi_{L}^{\infty} \rightarrow e^{-i \omega v} \text { as } r \rightarrow \infty,  \tag{27c}\\
& \psi_{L}^{\infty} \rightarrow E_{L} e^{-i \omega u_{s}}+F_{L} e^{-i \omega v} \text { as } r \rightarrow 2 M . \tag{27d}

The scattering coefficients $E_{R}, E_{L}, F_{R}$, and $F_{L}$ must be computed numerically. Computing the Wronskian of $\chi_{R}^{\infty}$ and $\chi_{L}^{\infty}$ in both limits results in the condition

E_{R} F_{L}-E_{L} F_{R}=1 \tag{28}

The gray body factor is given by $\Gamma=\left|E_{R}\right|^{-2}=\left|F_{L}\right|^{-2}$ [26].
The in modes are positive frequency left moving waves on past null infinity and inside the shell they have the boundary condition $\psi_{\omega \ell}^{\text {in }}=0$ at $r=0$.

The relevant Bogolubov transformation is

f_{\omega \ell m}^{\mathrm{out}}=\sum_{\ell^{\prime} m^{\prime}} \int_{0}^{\infty} d \omega^{\prime}\left[\alpha_{\omega \ell m \omega^{\prime} \ell^{\prime} m^{\prime}} f_{\omega^{\prime} \ell^{\prime} m^{\prime}}^{\mathrm{in}}+\beta_{\omega \ell m \omega^{\prime} \ell^{\prime} m^{\prime}} f_{\omega^{\prime} \ell^{\prime} m^{\prime}}^{\mathrm{in} *}\right] \tag{29}
\end{equation*}
$$

It was shown in [6] that $\alpha_{\omega \ell m \omega^{\prime} \ell^{\prime} m^{\prime}} \propto \delta_{\ell, \ell^{\prime}} \delta_{m, m^{\prime}}, \beta_{\omega \ell m \omega^{\prime} \ell^{\prime} m^{\prime}} \propto(-1)^{m} \delta_{\ell, \ell^{\prime}} \delta_{m,-m^{\prime}}$, and that

\langle i n| N_{\omega \ell m}^{\mathrm{out}}|i n\rangle=\int_{0}^{\infty} d \omega^{\prime}\left|\beta_{\omega \ell m \omega^{\prime} \ell(-m)}\right|^{2} \tag{30}

Using the Cauchy surface shown in Fig. (2) and noting that $f_{\omega \ell m}^{\text {out }}=0$ on the horizon, we find after some calculation that

$$
\begin{align*}
\beta_{\omega \omega^{\prime} \ell} & =-\frac{i}{2 \pi \sqrt{\omega \omega^{\prime}}} \frac{F_{R}}{F_{L}} e^{-i\left(\omega+\omega^{\prime}\right) v_{0}} \frac{\omega}{\left(\omega+\omega^{\prime}-i \epsilon_{1}\right)}+J  \tag{31a}\\
J & =\frac{i}{2 \pi \sqrt{\omega \omega^{\prime}}} \int_{-\infty}^{v_{H}} d u \psi_{\omega \ell}^{\mathscr{I}^{+}} \partial_{u} \psi_{\omega^{\prime} \ell}^{i n} . \tag{31~b}
\end{align*}

The leading order late time behavior comes from $J$. For $\ell=0$ on the shell trajectory

$$
\begin{equation*}
\psi_{\omega^{\prime} 0}^{\operatorname{in}}=e^{-i \omega^{\prime} v_{0}}-e^{-i \omega^{\prime} u} \tag{32}
\end{equation*}
$$

Inserting this into (31b), using $t=v_{0}-r$ on the shell and changing the integration variable from $u=t-r$ to $s=(r-2 M) / M$ one finds

$$
\begin{equation*}
J=-\frac{1}{4 \pi \kappa} \sqrt{\frac{\omega^{\prime}}{\omega}} e^{-i \omega^{\prime} v_{H}} \int_{0}^{\infty} d s e^{i \frac{\omega^{\prime} s}{2 \kappa}} \psi_{\omega 0}^{\mathrm{out}} \tag{33}
\end{equation*}
$$

An asymptotic expansion in inverse powers of $\omega^{\prime}$ can be obtained by expanding $\psi_{\omega 0}^{\text {out }}$ in a power series in $s$. This is the near horizon approximation. The leading order term can be obtained by combining Eqs. (26), (27b), (27d), and (28) with the result that

\begin{equation*}
\psi_{\omega 0}^{\text {out }} \rightarrow \frac{e^{-i \omega u_{s}}}{F_{L}}=\frac{e^{-i \omega v_{H}}}{F_{L}}\left(\frac{s}{2}\right)^{i \frac{\omega}{\kappa}}[1+O(s)] \tag{34}
\end{equation*}
$$

Substitution into (33) gives after some algebra

$$
\begin{equation*}
J=\frac{e^{-i \omega^{\prime} v_{H}}}{F_{L} \sqrt{\omega^{\prime}}}\left(\frac{\omega^{\prime}}{\kappa}\right)^{-i \frac{\omega}{\kappa}} B_{H}^{2 D}(\omega) \tag{35}
\end{equation*}
$$

Substitution into (12) gives Hawking's result.
For Eqs. (10) it is assumed that $\Lambda \gg \omega$. As a result, one can in the first approximation simply use $B\left(\omega, \omega^{\prime}\right)=$ $e^{-i v_{H} \omega^{\prime}} B_{H}(\omega)$ in $N_{2}$ with the result that to this approximation $N_{2}=0$. Then $N_{j n} \approx N_{1}+N_{3}$. Further the late time leading and next to leading order terms come from $N_{3}$ and do not depend on $\Lambda$. We have numerically computed $N_{j n}^{H}$ for the case $M=1, j=1, \epsilon=0.1$, and $v_{0}=0$. We have also numerically computed in a direct way the value of $N_{3}$ for various values on $n$ when $\Lambda=10$. In Fig 3 the quantity $n N_{3 b}$ is plotted. As predicted it approaches a constant value in the large $n$ limit. The constant can be obtained by multiplying (14) by $n$ and taking the limit $n \rightarrow \infty$.

We have shown that the contribution to the particle production from the next to leading order term goes like $n^{-1}$, with $n$ related to the time, when wave packets are used for the out modes. This was unexpected since the stationary phase approximation would seem to predict that higher order terms are exponentially damped in $n$.

Interestingly the next to leading order term is still local in some sense since it depends on the leading order contribution to the Bogolubov coefficient $\beta_{\omega \omega^{\prime}}$ in a large $\omega^{\prime}$ expansion and, as Hawking showed, this is independent of the details about how the black hole formed. However, at the next order, $n^{-2}$, and for all higher orders $n^{-a}$ for $a>2$, there are cutoff independent contributions to $N_{1}$ in (10b) which are clearly nonlocal since they depend on much smaller values of $\omega^{\prime}$ that require a full numerical computation of $\beta_{\omega \omega^{\prime}}$ over the entire trajectory of the null shell as well as the contribution to $\beta_{\omega \omega^{\prime}}$ from past null infinity. Therefore these terms carry information about how the black hole formed.

Our findings that at late times the terms beyond leading order in the Hawking effect have a powerlaw rather than an exponential decay and that the first nonlocal terms emerge at order $n^{-2}$ put the information loss issue in a new perspective since the emitted particles in the black hole evaporation process are sensitive to the details of the collapsing matter for a significantly longer period of time than would have been expected from the stationary phase approximation. Of course for a macroscopic black hole one would still expect that the approach to a thermal state would occur well before a significant amount of evaporation has occurred.
