# Random Finite Noncommutative Geometries and Topological Recursion

#### Abstract

In this paper we investigate a model for quantum gravity on finite noncommutative spaces using the theory of blobbed topological recursion. The model is based on a particular class of random finite real spectral triples $(\mathcal{A}, \mathcal{H}, D, \gamma, J)$, called random matrix geometries of type $(1,0)$, with a fixed fermion space $(\mathcal{A}, \mathcal{H}, \gamma, J)$, and a distribution of the form $e^{-\mathcal{S}(D)} \mathrm{d} D$ over the moduli space of Dirac operators. The action functional $\mathcal{S}(D)$ is considered to be a sum of terms of the form $\prod_{i=1}^{s} \operatorname{Tr}\left(D^{n_{i}}\right)$ for arbitrary $s \geqslant 1$. The Schwinger-Dyson equations satisfied by the connected correlators $W_{n}$ of the corresponding multi-trace formal 1-Hermitian matrix model are derived by a differential geometric approach. It is shown that the coefficients $W_{g, n}$ of the large $N$ expansion of $W_{n}$ 's enumerate discrete surfaces, called stuffed maps, whose building blocks are of particular topologies. The spectral curve $\left(\Sigma, \omega_{0,1}, \omega_{0,2}\right)$ of the model is investigated in detail. In particular, we derive an explicit expression for the fundamental symmetric bidifferential $\omega_{0,2}$ in terms of the formal parameters of the model.

## 1 Introduction and basics

In metric noncommutative geometry, the formalism of spectral triples [14] encodes, in the commutative case, the data of a Riemannian metric on a spin manifold in terms of the Dirac operator. More precisely, by Connes' reconstruction theorem [17] one knows that a spin Riemannian manifold can be fully constructed if we are given a commutative spectral triple satisfying some natural conditions like reality, and regularity. A simple manifestation of this fact is a distance formula [13] according to which one can recover the Riemannian metric from the interaction between the Dirac operator and the algebra of smooth functions on a spin manifold through their actions on the Hilbert space of $L^{2}$-spinors. This naturally leads to the view that spectral triples in general, without commutativity assumption, can be regarded as noncommutative spin Riemannian manifolds.

The data of a real spectral triple $(\mathcal{A}, \mathcal{H}, D, \gamma, J)$ consists of a *-algebra $\mathcal{A}$ together with a *representation $\pi: \mathcal{A} \rightarrow \mathcal{L}(\mathcal{H})$ on a Hilbert space $\mathcal{H}$, a self-adjoint Dirac operator $D$, a $\mathbb{Z} / 2$-grading $\gamma$, and an anti-linear isometry $J$ acting on $\mathcal{H}$. The above-mentioned operators should satisfy certain (anti)-commutation relations and technical functional analytic conditions (see [14], [12] and [18] for the detailed axiomatic definition of a real spectral triple).

A spectral triple $(\mathcal{A}, \mathcal{H}, D)$ is called finite if the Hilbert space $\mathcal{H}$ is finite dimensional, i.e. $\mathcal{H} \cong \mathbb{C}^{n}$. The data $(\mathcal{A}, \mathcal{H}, \gamma, J)$ corresponding to a finite real spectral triple is referred to as a fermion space. Given a fixed fermion space $(\mathcal{A}, \mathcal{H}, \gamma, J)$, the moduli space of Dirac operators of the finite real spectral triple $(\mathcal{A}, \mathcal{H}, D, \gamma, J)$ consists of all possible self-adjoint operators $D$ (up to unitary equivalence) which satisfy the axiomatic definition of a real spectral triple [24]. It is considered as the space of all possible geometries, that is Riemannian metrics, over the noncommutative space $(\mathcal{A}, \mathcal{H}, \gamma, J)$.

The theory of spectral triples has been used in constructing geometric models of matter coupled
to gravity, using an action functional, called the spectral action, which is given in terms of the spectrum of the Dirac operator (see [15], 11, [16] and [12]).

This paper is about a second application of the idea of spectral triples by creating a connection with the recently emerged theory of topological recursion [20]. Roughly speaking, if we understand quantization of gravity as a path integral over the space of metrics, it is natural to consider models of Euclidean quantum gravity over a finite noncommutative space in which one integrates over the moduli space of Dirac operators for a fixed fermion space. Given a fermion space $(\mathcal{A}, \mathcal{H}, \gamma, J)$, the distribution over the moduli space of Dirac operators is considered to be of the form

$$

e^{-\mathcal{S}(D)} \mathrm{d} D, \tag{1.1}
\end{equation*}

where the action functional $\mathcal{S}(D)$ is defined in terms of the spectrum of the Dirac operator $D$.
The investigation of the relation between models of quantum gravity on a certain class of finite noncommutative spaces and (anti)-Hermitian matrix ensembles started in the work of Barrett and Glaser ([3], cf. also [2]), although largely through numerical simulations. In this paper we consider a much larger class of models and show that an analytic approach to analyzing these models is possible, using techniques of topological recursion and blobbed topological recursion pioneered by Eynard-Orantin [20, 21, 6, 19], and Borot [4, 9].

In the following, we recall the definition of a particular type of finite real spectral triples whose Dirac operators are classified in terms of (anti)-Hermitian matrices in [2].

Consider the real Clifford algebra ${ }^{11} \mathrm{C} \ell_{p, q}$ associated to the vector space $\mathbb{R}^{n}$ and the pseudoEuclidean metric $\eta$ of signature $(p, q)$ given by

Let $\mathbb{C} \ell_{n}:=\mathrm{C} \ell_{p, q} \otimes_{\mathbb{R}} \mathbb{C}$ denote the complexification of $\mathrm{C} \ell_{p, q}$. Let $\left\{e_{i}\right\}_{i=1}^{n}$ be the standard oriented orthonormal basis, i.e. $\eta\left(e_{i}, e_{j}\right)= \pm \delta_{i j}$, for $\mathbb{R}^{n}$. The chirality operator $\Gamma$ is given by

where $s \equiv q-p(\bmod 8), 0 \leqslant s<8$. We denote by $V_{p, q}$ the unique (up to unitary equivalence) irreducible complex $\mathrm{C} \ell_{p, q}$-module, where, for $n=p+q$ odd, the chirality operator $\Gamma$ acts trivially

Consider the Hilbert space $\left(V_{p, q},\langle\cdot, \cdot\rangle\right)$. Let $C: V_{p, q} \rightarrow V_{p, q}$ be a real structure of $K O$-dimension $s \equiv q-p(\bmod 8)\left(\right.$ see, e.g., [24]) on $V_{p, q}$ such that

satisfies all the axioms of a fermion space $5^{5}$
Definition 1.1. A matrix geometry of type $(p, q)$ is a finite real spectral triple $(\mathcal{A}, \mathcal{H}, D, \gamma, J)$, where the corresponding fermion space is given by:

- $\mathcal{A}=\mathrm{M}_{N}(\mathbb{C})$
- $\mathcal{H}=V_{p, q} \otimes \mathrm{M}_{N}(\mathbb{C})$
- $\langle v \otimes A, u \otimes B\rangle=\langle v, u\rangle \operatorname{Tr}\left(A B^{*}\right), \quad v, u \in V_{p, q}, A, B \in \mathrm{M}_{N}(\mathbb{C})$
- $\pi(A)(v \otimes B)=v \otimes(A B)$
- $\gamma(v \otimes A)=(\Gamma v) \otimes A$
- $J(v \otimes A)=(C v) \otimes A^{*}$.

The Dirac operators of type $(p, q)$ matrix geometries are expressed in term of gamma matrices $\gamma^{i}$, and commutators or anti-commutators with given Hermitian matrices $H$ and anti-Hermitian matrices $L$ (see [2] and [3]).

## 2 Random matrix geometries of type ( 1,0 )

In this section we describe a model for Euclidean quantum gravity on finite noncommutative spaces corresponding to the random matrix geometries of type $(1,0)$. The Dirac operator of type $(1,0)$ matrix geometries is given by [3]:

[^2]where $\mathcal{H}_{N}$ denotes the space of $N \times N$ Hermitian matrices. The Dirac operator $D$ acts on the Hilbert space $\mathcal{H}=\mathrm{M}_{N}(\mathbb{C})$ in the following way

The moduli space of Dirac operators is isomorphic to the space of Hermitian matrices $\mathcal{H}_{N}$. A distribution of the form

is considered over $\mathcal{H}_{N}$, where

is the canonical Lebesgue measure on $\mathcal{H}_{N}$. Let us describe the action functional $\mathcal{S}(D)$. Let

Suggested by Connes' spectral action, we define the action functional $\mathcal{S}(D)$ of the model by

In the definition of the action functional, $t$ is a fixed parameter ("temperature"), the $\left(\alpha_{n}, \hat{\alpha}_{n_{I}}\right)_{n, n_{I}}$ are formal parameters, and, for each $s$, the summation over $n_{I} \in \mathbb{N}_{\uparrow}^{s}$ is a finite sum ${ }^{6}$ Let

For large $N$, the term $\mathcal{S}_{\text {stable }}(D)$ can be considered as higher order terms in $\hbar$-expansion of the action functional $\mathcal{S}(D)$.

where $I=\{1, \cdots, s\}$. By substituting (2.11) and (2.12) into (2.6), we get the expression for the action functional $\mathcal{S}(D)$ in terms of the spectrum of the Hermitian matrix $H \in \mathcal{H}_{N}$.

## 3 Topological expansion of the action functional

In the following, we rewrite the action functional $\mathcal{S}(D)$, in a succinct form, as a summation over a finite set of (properly defined) equivalence classes of surfaces.

We start by recalling the notion of a surface with polygonal boundary. A compact, connected, oriented surface $C$ is referred to have $n$ polygonal boundary components of perimeters $\left\{\ell_{i}\right\}_{i=1}^{n}, \ell_{i} \geqslant 1$, if, for each $1 \leqslant i \leqslant n$, the $i$-th connected component of $\partial C$ is equipped with a cellular decomposition into $\ell_{i} 0$-cells and $\ell_{i} 1$-cells. We refer to the 1 -cells in each connected component of $\partial C$ as the sides of that polygon. We define an equivalence relation between surfaces with polygonal boundaries in the following way:

Definition 3.1. Two compact, connected, oriented surfaces $C_{1}, C_{2}$ with polygonal boundaries are considered equivalent if there exists an orientation-preserving diffeomorphism $F: C_{1} \rightarrow C_{2}$ which restricts to a cellular homeomorphism $f: \partial C_{1} \rightarrow \partial C_{2}$ whose inverse is also a cellular map.

The set $\widehat{\mathcal{C}}$ of equivalence classes of compact, connected, oriented surfaces with polygonal boundaries is in bijective correspondence with the set

where $g$ denotes the genus of the corresponding closed surface. Inspired by [4], we refer to the combinatorial data $(g ; \vec{\ell})$, and its corresponding equivalence class $[C] \in \widehat{\mathcal{C}}$ of surfaces with polygonal
boundaries, as the elementary 2-cell of type $(g ; \vec{\ell})$.
We isolate the free part of the action functional and denote it by

where two $(s+m)$-tuples are considered equivalent if there exists a permutation $\sigma \in \mathfrak{S}_{s+m}$ which maps one to the other. Consider the set

parameters $\hat{\alpha}_{n_{I}}$ 's with integral coefficients.
Consider the following two sets of elementary 2 -cells:

with the corresponding set of equivalence classes $[C]$ of surfaces with polygonal boundaries. We assign a Boltzmann weight, equal to $\mathrm{t}_{\vec{\ell}}^{(g)}$, to each elementary 2 -cell $[C] \in \mathcal{C}$ of type $(g ; \vec{\ell})$. Note that the elementary 2 -cells in $\mathcal{C}_{\text {ustable }}$ (resp. $\mathcal{C}_{\text {stable }}$ ) are represented by surfaces whose Euler characteristic satisfies $\chi \geqslant 0$ (resp. $\chi<0$ ). For each elementary 2-cell $[C] \in \mathcal{C}$ of type $(g ; \vec{\ell})$ with Boltzmann weight $\mathrm{t}_{\vec{\ell}}^{(g)}, \vec{\ell} \in \mathbb{N}_{\uparrow}^{n}$, let

where $\beta_{0}(\partial C)$ denotes the zeroth Betti number, i.e. the number of connected components, of the boundary $\partial C$ of a surface $C$. Thus, we get:

Proposition 3.1. The action functional $\mathcal{S}(D)$ for the random matrix geometries of type $(1,0)$, given by (2.6), can be decomposed in the following form

and $\mathcal{C}$ is given by (3.12).

## 4 The corresponding 1-Hermitian matrix model

From now on, we consider the multi-trace 1-Hermitian matrix model corresponding to the random matrix geometries of type $(1,0)$ with the distribution $\mathrm{d} \rho=e^{-\mathcal{S}(D)} \mathrm{d} D$, in the sense of formal matrix integrals. In other words, we treat the term $\mathcal{S}_{\text {int }}(H)$ in (3.16) as a perturbation of $\mathcal{S}_{0}(H)$.

Consider the normalized Gaussian measure

over $\mathcal{H}_{N}$ with total mass one. Here

Denote by $\mathbf{t}$ the sequence of Boltzmann weights $\mathrm{t}_{\vec{\ell}}^{(g)}$ in $\mathcal{S}_{\text {int }}(H)$. We consider

as a formal power series in $\mathbf{t}$, i.e. an exponential generating function. The partition function $Z_{N}$ of the model is defined by

where the second integral is understood in the sense that we expand $\Phi(H)$ as a power series in $\mathbf{t}$, and interchange the integration with the summation.

The disconnected $n$-point correlators $\widehat{W}_{n}\left(x_{1}, \cdots, x_{n}\right), n \geqslant 1$, of the model are defined as the joint moments of

where $\left(x_{j} \mathbb{1}_{N}-H\right)^{-1}$ denotes the resolvent of $H \sqrt{7}$ The connected $n$-point correlators $W_{n}\left(x_{1}, \cdots, x_{n}\right)$, $n \geqslant 1$, of the model are defined as the joint cumulants of $X_{j}$ 's, i.e.

In (4.8), the sum runs over partitions of $\llbracket 1, n \rrbracket:=\{1,2,3, \cdots, n\}$, the number of subsets in a partition $K$ is denoted by $[K]$, and

### 4.1 Topological expansion of the correlators

Proposition 4.1. The connected n-point correlators $W_{n}\left(x_{1}, \cdots, x_{n}\right)$ of the random matrix geometries of type $(1,0)$ with the distribution $\mathrm{d} \rho=e^{-\mathcal{S}(D)} \mathrm{d} D$ have a large $N$ expansion ${ }^{8}$ of topological type, given by

where $W_{g, n}\left(x_{1}, \cdots, x_{n}\right)$ is defined, in the following, by 4.17).
Proof. We use the Wick's Theorem and the techniques of [10] to relate the formal matrix integrals in our model to the combinatorics of stuffed maps (4), (9]. Considering 4.6) and 4.7), the computation of $\widehat{W}_{n}\left(x_{1}, \cdots, x_{n}\right)$ leads to Gaussian integrals of the following form

To compute 4.11) using Wick's Theorem, we represent each term of the form $\operatorname{Tr}\left(H^{\ell_{j}}\right) / x_{j}^{\ell_{j}+1}$, in (4.11), by a marked face of perimeter $\ell_{j}$ with Boltzmann weight $x_{j}^{-\left(\ell_{j}+1\right)}, j=1, \cdots, n .^{9}$ Also, we represent each term of the form

[^4]in 4.11), by a surface $C_{i}$ of Euler characteristic $\chi\left(C_{i}\right)$ and Boltzmann weight $\mathrm{t}_{\overrightarrow{\ell_{i}}}^{\left(g_{i}\right)}$ representing the corresponding elementary 2 -cell $\left[C_{i}\right] \in \mathcal{C}$ of type $\left(g_{i} ; \overrightarrow{\ell_{i}}\right), i=1, \cdots,|\mathcal{C}|$. The orientation on each $C_{i}$ induces an orientation on $\partial C_{i}$.

Let $\Xi$ be the collection of all surfaces representing the terms in 4.11) in the above-mentioned way. Consider a pairing $\sigma$ on the set of sides of the connected components of the boundary of surfaces in $\Xi$. We glue the surfaces in $\Xi$ along the sides of their boundary, according to $\sigma$, such that the gluing map reverses the orientation. The resulting stuffed map $M=(S, G)$ consists of an oriented, not necessarily connected surface $S$, and a graph $G$ embedded into $S{ }^{10}$ We denote by $\tilde{S}$ the surface which one gets by deleting the marked faces from $S$.

It can be shown that each vertex (resp. edge) of $G$ contributes a weight $N$ (resp. $t / N$ ) [10]. In addition, each unmarked connected component $\mathfrak{U}$ of $S \backslash G$ contributes a weight $(N / t)^{\chi(\mathfrak{U})}$. Hence, the exponent of $N$, in the total contribution corresponding to $M=(S, G)$, equals $\chi(\tilde{S}) 1_{1}^{11}$

In addition to the pre-mentioned Boltzmann weights assigned to the 2 -cells of $M$, we assign a Boltzmann weight equal to $t$ to each vertex of $G$. The total Boltzmann weight of the isomorphism class $[M]$ of a stuffed map $M$, denoted by $\mathfrak{B w}([M])$, is defined to be the product of all Boltzmann weights assigned to the cells in $M$ divided by the order $|\operatorname{Aut}(M)|$ of the automorphism group of $M$. The contribution of the isomorphism class [ $M$ ] of a Boltzmann-weighted not necessarily connected stuffed map $M=(S, G)$ to $\widehat{W}_{n}\left(x_{1}, \cdots, x_{n}\right)$ is given by

Let $\mathbb{M}_{g, n}(\mathcal{C})$ be the set of isomorphism classes of the Boltzmann-weighted connected closed stuffed maps $M=(S, G)$ of genus $g$ with $n$ marked faces, such that the equivalence class of each unmarked connected component of $S \backslash G$ (in the sense of Definition 3.1) is in $\mathcal{C}$. Considering 4.13), and

Since, for a connected closed stuffed map $M=(S, G)$ of genus $g$ with $n$ marked faces,

Let $\mathbb{M}_{g, n ; \vec{\ell}}(\mathcal{C}), \vec{\ell}=\left(\ell_{1}, \cdots, \ell_{n}\right) \in \mathbb{N}^{n}$, be the set of isomorphism classes $[M] \in \mathbb{M}_{g, n}(\mathcal{C})$ of the stuffed maps with $n$ marked faces of perimeters $\ell_{j}, j=1, \cdots, n$. By 4.17, the generating series $Q_{g ; \vec{\ell}} \in \mathbb{Q}[\mathbf{t}][[t]]$ of the stuffed maps, corresponding to our model, of genus $g$ with $n$ polygonal boundaries of perimeters $\ell_{j}, j=1, \cdots, n$, satisfies

& =\delta_{g, 0} \delta_{n, 1} \frac{t}{x_{1}}+\sum_{\vec{\ell} \in \mathbb{N}^{n}} Q_{g ; \vec{\ell}} \prod_{j=1}^{n} x_{j}^{-\left(\ell_{j}+1\right)} . \tag{4.18}

### 4.2 Large- $N$ spectral distribution

Using (4.18), we see that the generating series $Q_{0 ; \ell}, \ell \in \mathbb{N}$, of the rooted planar stuffed maps with topology of a disk and perimeter $\ell$, is given by

where $\mathfrak{t}_{\vec{\ell}}^{(0)}$ denotes the sequence of Boltzmann weights $\mathrm{t}_{\vec{\ell}}^{(0)}, \vec{\ell} \in \mathfrak{L}_{\text {disk }} \cup \mathfrak{L}_{\text {cylinider }}$.
If the Boltzmann weights $\mathfrak{t}_{\vec{\ell}}^{(0)}$ (or, equivalently, the formal parameters $\alpha_{n}, 3 \leqslant n \leqslant d$ ) have given values, then there exists a critical temperature $t_{c}>0$ such that, for any $|t|<t_{c}$, we have $Q_{0 ; \ell}<\infty, \forall \ell \in \mathbb{N}[4]$. From now on, we restrict ourselves to the case $0<t<t_{c}$, where $t_{c}$ is specified according to each set of given values to $\alpha_{n}$ 's. Hence, we have the following one-cut Lemma [4], [5]:

Lemma 4.2. For given values to the Boltzmann weights $\mathfrak{t}_{\vec{\ell}}^{(0)}$, and $0<t<t_{c}$, the series

The limits $\lim _{\epsilon \rightarrow 0^{+}} W_{0,1}(s \pm \mathfrak{i} \epsilon), \forall s \in \Gamma^{\circ}$ exist, and the jump discontinuity

Consider the measure $\mu=\varphi(s) \mathrm{d} s$ on $\mathbb{R}$, where $\mathrm{d} s$ denotes the Lebesgue measure, and $\varphi(s)$ is given by 4.21). By the Sokhotski-Plemelj Theorem, the function $W_{0,1}(x)$ is, indeed, the Stieltjes transform $\mathscr{S}[\mu](x)$ of $\mu$, i.e.

on $\mathbb{R}$, where $\left\{\lambda_{i}\right\}_{i=1}^{N}, \lambda_{i} \in \mathbb{R}$, denotes the eigenvalues of the random Hermitian matrix $H \in \mathcal{H}_{N}$ corresponding to the random matrix geometries of type $(1,0)$ with the distribution $\mathrm{d} \rho=e^{-\mathcal{S}(D)} \mathrm{d} D \underbrace{12}$ By (4.6), we have

up to terms with exponential decay, as $N \rightarrow \infty .{ }^{13}$ We refer to the measure $\mu=\varphi(s) \mathrm{d} s$ as the large$N$ spectral distribution. In addition, from now on, we assume that the sequence of Boltzmann weights $\mathbf{t}$, and the parameter $t$, are tame, in the sense of [4, Definition 4.1. Hence, each $W_{g, n}\left(x_{1}, \cdots, x_{n}\right)$, a priori defined as the generating series of stuffed maps, upgrades to a holomorphic function on $(\mathbb{C} \backslash \Gamma)^{n}$ which has a jump discontinuity when one of $x_{i}$ 's crosses $\Gamma$.

## 5 Schwinger-Dyson equations

Our main tool for analyzing the $W_{g, n}\left(x_{1}, \cdots, x_{n}\right)$ 's is an infinite system of equations, called the Schwinger-Dyson equations (SDEs), satisfied by the $n$-point correlators of the model. In the matrix model framework, they were introduced by Migdal [25], and referred to as the loop equations. There

[^6]are several versions of SDEs for matrix models (and some other closely related models in statistical physics, e.g., the $\beta$-ensembles) in the literature (see, e.g., [19, [7). However, the root of all of them is the invariance of the integral of a top degree differential form under a 1-parameter family of orientation-preserving diffeomorphisms on a manifold.

To put the above-mentioned differential geometric fact in a precise form, consider an oriented connected Riemannian $n$-manifold $M$ with the Riemannian volume form $\omega$. Let $V$ be a smooth vector field on $M$ with a local flow $\phi_{t}: M \rightarrow M$. Consider a smooth function $\Psi: M \rightarrow \mathbb{R}$. Let $\Omega \subset M$ be a compact $n$-dimensional submanifold of $M$. Since

In (5.2), the exterior derivative, the interior product by $V$, and the divergence of $V$ are denoted by $d, \iota_{V}$, and $\operatorname{div}(V)$, respectively.

The Schwinger-Dyson equations for the multi-trace 1-Hermitian matrix models are derived in [4], using Tutte's decomposition applied to the stuffed maps. In this section, we give a proof of them based on the above-mentioned differential geometric fact ${ }^{14}$

Consider the action of the unitary group $\mathrm{U}_{N}$ on $\mathcal{H}_{N}$ by conjugation, i.e. $u \cdot H:=u H u^{-1}$ for $u \in \mathrm{U}_{N}$ and $H \in \mathcal{H}_{N}$. Since the action functional $\mathcal{S}(D): \mathcal{H}_{N} \rightarrow \mathbb{R}$ is invariant under the prementioned action of $\mathrm{U}_{N}$ on $\mathcal{H}_{N}$, we can rewrite $\mathcal{S}(D)$ as a function of the eigenvalues $\left\{\lambda_{i}\right\}_{i=1}^{N}$, $\lambda_{i} \in \mathbb{R}$, of the random Hermitian matrix $H \in \mathcal{H}_{N}$.

Let

However, we will see that they are "asymptotically" closed as $N \rightarrow \infty$, and we can solve them to find the coefficients $W_{g, n}\left(x_{1}, \cdots, x_{n}\right)$ of the large $N$ expansion of the correlators.

Before continuing, we introduce the following notations which are used in this article. Let $V \subset X$ be an open subset of a Riemann surface $X$. We denote by $\mathscr{O}, \mathscr{O}^{*}, \mathscr{M}, \Omega$, and $\mathscr{Q}$, the sheaves on $X$ defined by

- $\mathscr{O}(V)=$ holomorphic functions on $V$
- $\mathscr{O}^{*}(V)=$ multiplicative group of nonzero holomorphic functions on $V$
- $\mathscr{M}(V)=$ meromorphic functions on $V$
- $\Omega(V)=$ holomorphic 1-forms on $V$
- $\mathscr{Q}(V)=$ meromorphic 1-forms on $V$,
respectively.


## 6 Spectral curve

We start by analyzing the rank one Schwinger-Dyson equation to leading order in $N$, i.e. the Equation (5.45) for $n=1$ and $g=0$, given by

\left(W_{0,1}(x)\right)^{2}+\sum_{k=1}^{2} \oint_{C_{\Gamma}}\left[\prod_{r=1}^{k} \frac{\mathrm{~d} \xi_{r}}{2 \pi \mathrm{i}}\right] \frac{\partial_{\xi_{1}} T_{0, k}\left(\xi_{1}, \cdots, \xi_{k}\right)}{x-\xi_{1}} \prod_{r=1}^{k} W_{0,1}\left(\xi_{r}\right)=0 . \tag{6.1}
\end{equation*}
$$

Recall that

\begin{equation*}
T_{0,1}(\xi)=-2 t \mathcal{V}(\xi)=-\frac{1}{2} \xi^{2}+\sum_{\ell \in \mathfrak{L}_{\text {disk }}} \frac{\mathrm{t}_{\ell}^{(0)}}{\ell} \xi^{\ell} \tag{6.2}
\end{equation*}
$$

where $\mathcal{V}(\xi)$ is given by (2.7), and

\begin{equation*}
T_{0,2}(\xi, \eta)=\frac{1}{2} \sum_{\left(\ell_{1}, \ell_{2}\right) \in \mathfrak{R}_{\text {cyininder }}} \frac{\mathrm{t}_{\ell_{1}, \ell_{2}}^{(0)}}{\ell_{1} \ell_{2}}\left(\xi^{\ell_{1}} \eta^{\ell_{2}}+\xi^{\ell_{2}} \eta^{\ell_{1}}\right) . \tag{6.3}
\end{equation*}
$$

We fix a simply-connected open neighborhood $U \subset \mathbb{C}$ such that $\Gamma \subset U$. Consider the following integral operator, called the master operator (4),

\mathcal{O} f(\xi)=\frac{1}{2 \pi \mathrm{i}} \oint_{C_{\Gamma}} R(\xi, \eta) f(\eta) \mathrm{d} \eta, \quad \mathcal{O}: \mathscr{O}(U \backslash \Gamma) \rightarrow \mathscr{O}(U), \tag{6.4}
\end{equation*}
$$

with the kernel

R(\xi, \eta)=\partial_{\xi} T_{0,2}(\xi, \eta) \tag{6.5}
\end{equation*}
$$

We rewrite (6.1) in the following form

\left(W_{0,1}(x)\right)^{2}+\oint_{C_{\Gamma}} \frac{\mathrm{d} \xi}{2 \pi \mathrm{i}} \frac{Q(\xi)}{x-\xi} W_{0,1}(\xi)=0 \tag{6.6}
\end{equation*}

where

\begin{equation*}
Q(\xi)=\left(\partial_{\xi} T_{0,1}(\xi)\right)+\mathcal{O} W_{0,1}(\xi) \tag{6.7}
\end{equation*}
$$

Since $W_{0,1}(x) \in \mathscr{O}(\mathbb{C} \backslash \Gamma)$, using (4.21) and 4.20), we have

\oint_{C_{\Gamma}} \frac{\mathrm{d} \xi}{2 \pi \mathrm{i}} \xi^{\ell} W_{0,1}(\xi)=\mathfrak{m}_{\ell}=\oint_{\xi=\infty} \frac{\mathrm{d} \xi}{2 \pi \mathrm{i}} \xi^{\ell} W_{0,1}(\xi)=Q_{0 ; \ell} \tag{6.8}
\end{equation*}
$$

where

$$
\begin{equation*}
\mathfrak{m}_{\ell}=\int s^{\ell} \varphi(s) \mathrm{d} s, \quad \ell \geqslant 1 \tag{6.9}
\end{equation*}
$$

denotes the moments of the large- $N$ spectral distribution $\mu=\varphi(s) \mathrm{d} s$, and $Q_{0 ; \ell}$ is given by 4.19). Thus, the polynomial $Q(\xi)$ can be expressed in terms of $\mathfrak{m}_{\ell}$ 's in the following way:

Q(\xi)=-\xi & +\sum_{\ell \in \mathfrak{L}_{\text {disk }}} \mathrm{t}_{\ell}^{(0)} \xi^{\ell-1} \\
& +\frac{1}{2} \sum_{\left(\ell_{1}, \ell_{2}\right) \in \mathfrak{L}_{\text {cyliner }}} \mathrm{t}_{\ell_{1}, \ell_{2}}^{(0)}\left[\frac{\mathfrak{m}_{\ell_{2}}}{\ell_{2}} \xi^{\ell_{1}-1}+\frac{\mathfrak{m}_{\ell_{1}}}{\ell_{1}} \xi^{\ell_{2}-1}\right] . \tag{6.10}
\end{align*}
$$

Considering $W_{0,1}(\xi)=O(1 / \xi)$ as $\xi \rightarrow \infty$, we rewrite the contour integral in (6.6) as:

\oint_{C_{\Gamma}} \frac{\mathrm{d} \xi}{2 \pi \mathrm{i}} \frac{Q(\xi)}{x-\xi} W_{0,1}(\xi) & =\oint_{C_{\Gamma}} \frac{\mathrm{d} \xi}{2 \pi \mathrm{i}} \frac{Q(x)-(Q(x)-Q(\xi))}{x-\xi} W_{0,1}(\xi) \\
& =Q(x) W_{0,1}(x)-\oint_{C_{\Gamma}} \frac{\mathrm{d} \xi}{2 \pi \mathrm{i}} \Delta[Q](x, \xi) W_{0,1}(\xi), \tag{6.11}
\end{align*}
$$

where

$$
\begin{equation*}
\Delta[Q](x, \xi)=\frac{Q(x)-Q(\xi)}{x-\xi} \tag{6.12}
\end{equation*}
$$

denotes the noncommutative derivative, aka "finite difference quotient", of $Q(\xi)$. The polynomial

P(x)=-\oint_{C_{\Gamma}} \frac{\mathrm{d} \xi}{2 \pi \mathrm{i}} \Delta[Q](x, \xi) W_{0,1}(\xi) \tag{6.13}
\end{equation*}

has the following expression in terms of $\mathfrak{m}_{\ell}$ 's:

P(x)=1 & -\sum_{\ell \in \mathfrak{L}_{\text {disk }}} \mathrm{t}_{\ell}^{(0)} \sum_{n=0}^{\ell-2} \mathfrak{m}_{\ell-2-n} x^{n} \\
& -\frac{1}{2} \sum_{\left(\ell_{1}, \ell_{2}\right) \in \mathfrak{L}_{\text {cylinder }}} \mathrm{t}_{\ell_{1}, \ell_{2}}^{(0)}\left[\frac{\mathfrak{m}_{\ell_{2}}}{\ell_{2}}\left(\sum_{n=0}^{\ell_{1}-2} \mathfrak{m}_{\ell_{1}-2-n} x^{n}\right)+\frac{\mathfrak{m}_{\ell_{1}}}{\ell_{1}}\left(\sum_{n=0}^{\ell_{2}-2} \mathfrak{m}_{\ell_{2}-2-n} x^{n}\right)\right] . \tag{6.14}
\end{align*}
$$

Therefore, we have proved:
Proposition 6.1. For the random matrix geometries of type $(1,0)$ with the distribution $\mathrm{d} \rho=e^{-\mathcal{S}(D)} \mathrm{d} D$, the Stieltjes transform $W_{0,1}(x)$ of the large- $N$ spectral distribution $\mu=\varphi(s) \mathrm{d}$ s of the model satisfies the following quadratic algebraic equation

$$
\begin{equation*}
y^{2}+Q(x) y+P(x)=0 \tag{6.15}
\end{equation*}
$$

where the polynomials $Q(x)$ and $P(x)$ are given by (6.10) and (6.14), respectively. The coefficients of $Q(x)$ and $P(x)$ depend on the Boltzmann weights $\mathfrak{t}_{\vec{\ell}}^{(0)}$, and the moments $\mathfrak{m}_{\ell}$ of the large- $N$ spectral distribution $\mu$.

Let the interval $\Gamma=[\mathfrak{a}, \mathfrak{b}] \subset \mathbb{R}$, and the open neighborhood $U \subset \mathbb{C}, \Gamma \subset U$, be the same as the above-mentioned ones. We recall the Joukowski map $x: \mathbb{C} \backslash\{0\} \rightarrow \mathbb{C}$ given by

x(z)=\frac{\mathfrak{a}+\mathfrak{b}}{2}+\frac{\mathfrak{b}-\mathfrak{a}}{4}\left(z+\frac{1}{z}\right) . \tag{6.16}
\end{equation*}

Denote by $\mathbb{T}$ and $\mathbb{D}$ the unit circle and the open unit disk in $\mathbb{C}$, respectively. The preimage $x^{-1}(U \backslash \Gamma)$ of $U \backslash \Gamma$ under the Joukowski map $x$ has two connected components $V^{e} \subset \mathbb{C} \backslash \overline{\mathbb{D}}$ and $V^{i} \subset \mathbb{D}$, whose
common boundary is the unit circle $\mathbb{T}$. The exterior neighborhood $V^{e}$ is mapped to the interior neighborhood $V^{i}$ under $\iota: z \mapsto 1 / z$.


Figure 1: Illustration of the Joukowski map in the case where the boundary of $U$ is an ellipse with the foci $x=\mathfrak{a}$ and $x=\mathfrak{b}$. The open neighborhoods $U, V^{e}$, and $V^{i}$ are colored green, brown and yellow, respectively.

By Proposition 6.1 and Lemma 4.2, the function $W_{0,1}(x) \in \mathscr{O}(U \backslash \Gamma)$ can be expressed in the following way

$$
\begin{equation*}
2 W_{0,1}(x)=-Q(x)+M(x) \sqrt{(x-\mathfrak{a})(x-\mathfrak{b})}, \tag{6.17}
\end{equation*}
$$

where $M(x) \in \mathscr{O}^{*}(U)$, and $\Gamma=[\mathfrak{a}, \mathfrak{b}] \subset \mathbb{R}$ is the support of the large- $N$ spectral distribution $\mu$. Let $W_{0,1}(x(z))$ be the pullback of $W_{0,1}(x) \in \mathscr{O}(U \backslash \Gamma)$ under the biholomorphism $\left.x\right|_{V^{e}}: V^{e} \rightarrow U \backslash \Gamma$. Since

\sqrt{(x(z)-\mathfrak{a})(x(z)-\mathfrak{b})}=\frac{\mathfrak{b}-\mathfrak{a}}{4}\left(z-\frac{1}{z}\right), \tag{6.18}
\end{equation*}

considering (6.17), the function $W_{0,1}(x(z))$ has an analytic continuation, denoted by $W_{0,1}(x(z)) \in \mathscr{O}(V)$, to $V=x^{-1}(U)=V^{e} \cup V^{i} \cup \mathbb{T}$.

Consider the open neighborhood $\Upsilon=\mathbb{D} \backslash \overline{V^{i}}$ of the point $z=0$. The Riemann surface

$$
\begin{equation*}
\Sigma=\mathbb{C P}^{1} \backslash \Upsilon, \tag{6.19}
\end{equation*}
$$

which is homeomorphic to a disk, is called the spectral curve of the model. Let

$$
\begin{equation*}
x: \Sigma \rightarrow \mathbb{C P}^{1}, \quad x \in \mathscr{M}(\Sigma), \tag{6.20}
\end{equation*}
$$

be the restriction of the Joukowski map to $\Sigma$. The map $\left.x\right|_{V}: V \subset \Sigma \rightarrow U$ is a two-sheeted ramified
covering map with the ramification points

$$
\begin{equation*}
\mathfrak{R}=\{z=1, z=-1\}, \tag{6.21}
\end{equation*}
$$

and the branch points $x=\mathfrak{a}, x=\mathfrak{b}$. In addition, the spectral curve $\Sigma$ is equipped with a local biholomorphic involution

$$
\begin{align*}
\iota & : V \\
\quad & \rightarrow V  \tag{6.22}\\
& \not \mapsto 1 / z
\end{align*}
$$

which satisfies $x \circ \iota=x$.
Using the Schwinger-Dyson equations (5.45) recursively, it can be shown [19] that each $W_{g, n}\left(x, x_{I}\right)$ for fixed $\left(x_{i}\right)_{i \in I} \in \mathbb{C} \backslash \Gamma$, initially defined as a holomorphic function on $\mathbb{C} \backslash \Gamma$, has a meromorphic continuation $W_{g, n}\left(x\left(z_{1}\right), x_{I}\right) \in \mathscr{M}(\Sigma)$ to $\Sigma$. By doing the same process for the other arguments $x_{i}$, $i \in I$, of $W_{g, n}\left(x\left(z_{1}\right), x_{1}, \cdots, x_{n-1}\right)$, one gets a meromorphic function $W_{g, n}\left(x\left(z_{1}\right), \cdots, x\left(z_{n}\right)\right)$ on $\Sigma^{n}$.

Let $K_{\Sigma} \rightarrow \Sigma$ be the canonical line bundle, i.e. the holomorphic cotangent bundle, on the spectral curve $\Sigma$. Denote by $\pi_{i}: \Sigma^{n} \rightarrow \Sigma$ the projection map onto the $i$-th component. Let

$$
\begin{equation*}
K_{\Sigma}^{\boxtimes n}:=\left(\pi_{1}^{*} K_{\Sigma}\right) \otimes \cdots \otimes\left(\pi_{n}^{*} K_{\Sigma}\right) \tag{6.23}
\end{equation*}
$$

be the $n$-times external tensor product of $K_{\Sigma}$, where $\pi_{i}^{*} K_{\Sigma}$ denotes the pullback of $K_{\Sigma}$ under $\pi_{i}$. The sections of the holomorphic line bundle $K_{\Sigma}^{\boxtimes n} \rightarrow \Sigma^{n}$ are referred to as the differentials of degree $n$ over $\Sigma^{n}$. A differential of degree $n$ is called symmetric if it is invariant under the natural action of the symmetric group $\mathfrak{S}_{n}$ on the line bundle $K_{\Sigma}^{\boxtimes n} \rightarrow \Sigma^{n}$.

In the theory of (blobbed) topological recursion [20, 6, 4], one constructs meromorphic symmetric differentials

$$
\begin{align*}
\omega_{g, n}\left(z_{1}, \cdots, z_{n}\right) & =W_{g, n}\left(x\left(z_{1}\right), \cdots, x\left(z_{n}\right)\right) d x\left(z_{1}\right) d x\left(z_{2}\right) \cdots d x\left(z_{n}\right) \\
& +\delta_{g, 0} \delta_{n, 2} \hat{B}_{0}\left(z_{1}, z_{2}\right) \tag{6.24}
\end{align*}
$$

of degree $n$ from the meromorphic functions $W_{g, n}\left(x\left(z_{1}\right), \cdots, x\left(z_{n}\right)\right)$, where $d x\left(z_{i}\right)$ denotes the pullback $\pi_{i}^{*}(d x)$ of the 1-form $d x$ under $\pi_{i}: \Sigma^{n} \rightarrow \Sigma$. In (6.24), the bidifferential, i.e. differential of degree two,

$$
\begin{equation*}
\hat{B}_{0}\left(z_{1}, z_{2}\right)=\frac{d x\left(z_{1}\right) d x\left(z_{2}\right)}{\left[x\left(z_{1}\right)-x\left(z_{2}\right)\right]^{2}} \tag{6.25}
\end{equation*}
$$

is the pullback of the fundamental symmetric bidifferential of the second kind with biresidue 1 over
$\mathbb{C P}^{1} \times \mathbb{C P}^{1}{ }^{18}$ i.e.

$$
\begin{equation*}
B_{0}\left(x_{1}, x_{2}\right)=\frac{d x_{1} d x_{2}}{\left(x_{1}-x_{2}\right)^{2}} \tag{6.26}
\end{equation*}
$$

under the $\operatorname{map}(x, x): \Sigma \times \Sigma \rightarrow \mathbb{C P}^{1} \times \mathbb{C P}^{1}$. A couple $(g, n)$ is called stable if $2-2 g-n<0$, i.e. $(g, n) \neq(0,1),(0,2)$.

Before continuing, we introduce several operators in the following which are used in our investigation of the differentials $\omega_{g, n}\left(z_{1}, \cdots, z_{n}\right)$. Denote by $\mathcal{P}_{+}$and $\mathcal{P}_{-}$the orthogonal idempotents corresponding to the involution $\iota: V \rightarrow V$, given by

\mathcal{P}_{+}=\frac{1}{2}\left(\mathbb{1}+\iota^{*}\right), \quad \text { and } \quad \mathcal{P}_{-}=\frac{1}{2}\left(\mathbb{1}-\iota^{*}\right) \tag{6.27}

respectively, where $\iota^{*}$ denotes the pullback under $\iota$. Let

\begin{equation*}
\hat{\mathcal{P}}_{ \pm}=2 \mathcal{P}_{ \pm} \tag{6.28}
\end{equation*}
$$

The domain of the operators $\mathcal{P}_{ \pm}$can be $\mathscr{M}(V)$ or $\mathscr{Q}(V)$, depending on the context which they are used. For a fixed $\epsilon>0$, consider the closed counter-clockwise-oriented contour

\begin{equation*}
\gamma=\{z \in \mathbb{C}| | z \mid=1+\epsilon\} \subset V^{e} \tag{6.29}
\end{equation*}
$$

Denote by $\hat{\mathrm{F}} \subset \mathscr{Q}(V)$ the subspace of meromorphic 1-forms on $V \subset \Sigma$ which do not have poles on $\gamma$. Denote by $\Omega_{\mathrm{inv}}(V)$ (resp. $\mathscr{O}_{\mathrm{inv}}(V)$ ) the subspace of holomorphic 1-forms (resp. functions) on $V \subset \Sigma$ which are invariant under the involution $\iota^{*}$. Let $T_{0,2}(x(z), x(\zeta)), z, \zeta \in V$, be the pullback of $T_{0,2}(\xi, \eta)$ under the map $(x, x): V \times V \rightarrow U \times U$. Consider the following integral operator

$$
\begin{equation*}
\hat{\mathcal{O}} \phi(z)=\frac{1}{2 \pi \mathrm{i}} \oint_{\gamma} \hat{R}(z, \zeta) \phi(\zeta), \quad \hat{\mathcal{O}}: \hat{\mathrm{F}} \rightarrow \Omega_{\mathrm{inv}}(V) \tag{6.30}
\end{equation*}
$$

with the kernel

$$
\begin{equation*}
\hat{R}(z, \zeta)=d_{z} T_{0,2}(x(z), x(\zeta)) \in \Gamma(V \times V, \Omega \boxtimes \mathscr{O}) \tag{6.31}
\end{equation*}
$$

where $d_{z}$ denotes the exterior derivative operator acting on the first argument. The operator $\hat{\mathcal{O}}$ is

[^10]closely related to the master operator $\mathcal{O}$ in the sense that, for each fixed $z_{I} \in \Sigma^{n-1}$, we have

where $\mathcal{O} W_{g, n}(x(z), \cdot) \in \mathscr{O}_{\text {inv }}(V)$ denotes the pullback of $\mathcal{O} W_{g, n}(x, \cdot)$ under $x: V \rightarrow U$.

## 7 Fundamental bidifferential $\omega_{0,2}(z, \zeta)$

As the next step, we investigate the large- $N$ spectral covariance $W_{0,2}\left(x_{1}, x_{2}\right)$ of the model. Fix $\zeta \in \Sigma \backslash \overline{V^{i}}$. Denote by $W_{0,2}(x(z), x(\zeta)), z \in \Sigma$, the meromorphic continuation of the pullback of $W_{0,2}\left(x_{1}, x_{2}\right)$ under the biholomorphism $\left.x\right|_{V^{e}}: V^{e} \rightarrow U \backslash \Gamma$ to $\Sigma$. By definition of $W_{0,2}\left(x_{1}, x_{2}\right)$, the possible singularities of the function $W_{0,2}(x(z), x(\zeta))$ can only occur in $\mathfrak{R} \cup V^{i} \subset \Sigma$. To investigate poles of $W_{0,2}(x(z), x(\zeta))$, we consider the rank two Schwinger-Dyson equation to leading order in $N$, i.e. the Equation (5.45) for $(g, n)=(0,2)$, given by

$$
\begin{align*}
& 2 W_{0,1}\left(x_{1}\right) W_{0,2}\left(x_{1}, x_{2}\right)+\oint_{C_{\Gamma}} \frac{\mathrm{d} \xi}{2 \pi \mathrm{i}} \frac{W_{0,1}(\xi)}{\left(x_{1}-\xi\right)\left(x_{2}-\xi\right)^{2}} \\
+ & \oint_{C_{\Gamma}} \frac{\mathrm{d} \xi}{2 \pi \mathrm{i}} \frac{1}{x_{1}-\xi}\left(\left[\partial_{\xi} T_{0,1}(\xi)+\mathcal{O} W_{0,1}(\xi)\right] W_{0,2}\left(\xi, x_{2}\right)+\left[\mathcal{O} W_{0,2}\left(\xi, x_{2}\right)\right] W_{0,1}(\xi)\right) \\
= & 0 \tag{7.1}
\end{align*}
$$

for $x_{1} \in U \backslash \Gamma$, and fixed $x_{2} \in \mathbb{C} \backslash \Gamma$. We rewrite (7.1) in the following form

$$
\begin{align*}
& -\left[2 W_{0,1}\left(x_{1}\right)+\partial_{x_{1}} T_{0,1}\left(x_{1}\right)+\mathcal{O} W_{0,1}\left(x_{1}\right)\right] W_{0,2}\left(x_{1}, x_{2}\right) \\
& =\left[\mathcal{O} W_{0,2}\left(x_{1}, x_{2}\right)\right] W_{0,1}\left(x_{1}\right)+\partial_{x_{2}}\left(\frac{W_{0,1}\left(x_{1}\right)-W_{0,1}\left(x_{2}\right)}{x_{1}-x_{2}}\right)+P_{0,2}\left(x_{1}, x_{2}\right), \tag{7.2}
\end{align*}
$$

where $P_{0,2}\left(x_{1}, \cdot\right) \in \mathscr{O}(U)$. By (6.17), the function

$$
\begin{equation*}
2 W_{0,1}(x(z))+\partial_{x} T_{0,1}(x(z))+\mathcal{O} W_{0,1}(x(z)) \tag{7.3}
\end{equation*}
$$

has a simple zero at the ramification points $\mathfrak{R}$. Therefore, considering (7.2), $W_{0,2}(x(z), x(\zeta))$ has a simple pole at $\Re$.

By considering (7.2) as $x_{1} \rightarrow s \pm \mathrm{i} \epsilon, s \in \Gamma^{\circ}$, it can be shown [4] that

\lim _{\epsilon \rightarrow 0^{+}}\left[W_{0,2}\left(s+\mathrm{i} \epsilon, x_{2}\right)+W_{0,2}\left(s-\mathrm{i} \epsilon, x_{2}\right)\right]+\mathcal{O} W_{0,2}\left(s, x_{2}\right)+\frac{1}{\left(s-x_{2}\right)^{2}}=0, \quad \forall s \in \Gamma^{\circ} . \tag{7.4}
\end{equation*}
$$

Using the identity theorem for holomorphic functions, and the Riemann's removable singularities
theorem, we deduce from (7.4) that

\hat{\mathcal{P}}_{+} W_{0,2}(x(z), x(\zeta))+\mathcal{O} W_{0,2}(x(z), x(\zeta))+\frac{1}{[x(z)-x(\zeta)]^{2}}=0 \tag{7.5}
\end{equation*}
$$

for all $z \in V \subset \Sigma$. Considering (7.5), we get the following equation

$$
\begin{equation*}
\hat{\mathcal{P}}_{+} \tilde{\omega}_{0,2}(z, \zeta)+\hat{\mathcal{O}}_{\tilde{\omega}_{0,2}}(z, \zeta)+\hat{B}_{0}(z, \zeta)=0, \tag{7.6}
\end{equation*}
$$

for the bidifferential

$$
\begin{equation*}
\tilde{\omega}_{0,2}(z, \zeta)=W_{0,2}(x(z), x(\zeta)) d x(z) d x(\zeta) \tag{7.7}
\end{equation*}
$$

where $\hat{B}_{0}(z, \zeta)$ is given by (6.25).
Consider the function

$$
\begin{equation*}
F_{\zeta}(z)=W_{0,2}(x(z), x(\zeta)) x^{\prime}(z) x^{\prime}(\zeta), \tag{7.8}
\end{equation*}
$$

where $x^{\prime}(z) \equiv \partial_{z} x(z)$. We have

$$
\begin{equation*}
\tilde{\omega}_{0,2}(z, \zeta)=F_{\zeta}(z) d z d \zeta . \tag{7.9}
\end{equation*}
$$

In the remaining part of this section, we consider the following set of assumptions, and derive an explicit expression for $F_{\zeta}(z)$.

## Hypothesis 7.1.

(i) For each fixed $\zeta \in \mathbb{C} \backslash \overline{\mathbb{D}}$, the function $F_{\zeta}(z)$ has a meromorphic continuation to the whole $\mathbb{C P}^{1}$;
(ii) The support $\Gamma$ of the large- $N$ spectral distribution $\mu$ of the model is of the form $\Gamma=[-\mathfrak{b}, \mathfrak{b}] \subset \mathbb{R}\left\{{ }^{19}\right.$

To get an explicit expression for the meromorphic function $F_{\zeta}(z), z \in \mathbb{C P}^{1}$, we find the principal part of the germ of $F_{\zeta}(z)$ at its poles on $\mathbb{C P}^{1}$, and then analyze the corresponding Mittag-Leffler problem. More precisely, we consider the following long exact sequence of Čech cohomology groups

$$
\begin{equation*}
0 \rightarrow H^{0}\left(\mathbb{C P}^{1}, \mathscr{O}\right) \rightarrow H^{0}\left(\mathbb{C P}^{1}, \mathscr{M}\right) \rightarrow H^{0}\left(\mathbb{C P}^{1}, \mathscr{M} / \mathscr{O}\right) \rightarrow H^{1}\left(\mathbb{C P}^{1}, \mathscr{O}\right) \rightarrow \cdots \tag{7.10}
\end{equation*}
$$

It is well known that

$$
\begin{equation*}
H^{0}\left(\mathbb{C P}^{1}, \mathscr{O}\right)=\mathbb{C}, \quad \text { and } \quad H^{1}\left(\mathbb{C P}^{1}, \mathscr{O}\right)=0 \tag{7.11}
\end{equation*}
$$

Therefore, given a section $\tilde{f} \in H^{0}\left(\mathbb{C P}^{1}, \mathscr{M} / \mathscr{O}\right)$, there exists a meromorphic function $f \in H^{0}\left(\mathbb{C P}^{1}, \mathscr{M}\right)$, unique up to a constant, whose local singular behavior is given by $\tilde{f}$.

The meromorphic function $F_{\zeta}(z)$ does not have any poles in $\mathbb{C P}^{1} \backslash \mathbb{D}$ because the simple zeroes of $x^{\prime}(z)$ at the ramification points $\mathfrak{R}$ cancels out the simple poles of $W_{0,2}(x(z), x(\zeta))$. We use 7.6)

[^11]to analyze the possible poles of $F_{\zeta}(z)$ in $\mathbb{D}$. Rewrite the function $T_{0,2}(\xi, \eta)$, given by (6.3), in the following form
\[

$$
\begin{equation*}
T_{0,2}(\xi, \eta)=\sum_{k=1}^{d-1} \xi^{k}\left(\sum_{m=1}^{d-k} \nu_{k, m} \eta^{m}\right), \tag{7.12}
\end{equation*}
$$

\]

where each $\nu_{k, m}$ is a linear combination of the Boltzmann weights $\mathrm{t}_{\ell_{1}, \ell_{2}}^{(0)},\left(\ell_{1}, \ell_{2}\right) \in \mathfrak{L}_{\text {cylinerer }}$. We have

$$
\begin{equation*}
\hat{\mathcal{O}} \tilde{\omega}_{0,2}(z, \zeta)=\left(1-\frac{1}{z^{2}}\right) \sum_{k=1}^{d-1} b_{k}(\zeta)\left(z+\frac{1}{z}\right)^{k-1} d z d \zeta \tag{7.13}
\end{equation*}
$$

where, for each $1 \leqslant k \leqslant d-1$,

$$
\begin{equation*}
b_{k}(\zeta)=\frac{k}{2 \pi \mathrm{i}} \sum_{m=1}^{d-k} \nu_{k, m}(\mathfrak{b} / 2)^{k+m} \oint_{\gamma}\left(\tau+\frac{1}{\tau}\right)^{m} F_{\zeta}(\tau) \mathrm{d} \tau . \tag{7.14}
\end{equation*}
$$

Considering (7.6) and (7.13), we get the following equation satisfied by $F_{\zeta}(z)$ on $\mathbb{C} \backslash\{0\}$ :

$$
\begin{equation*}
F_{\zeta}(z)=\frac{1}{z^{2}} F_{\zeta}(\iota(z))-\left[\left(1-\frac{1}{z^{2}}\right) \sum_{k=1}^{d-1} b_{k}(\zeta)\left(z+\frac{1}{z}\right)^{k-1}\right]-\frac{x^{\prime}(z) x^{\prime}(\zeta)}{[x(z)-x(\zeta)]^{2}} \tag{7.15}
\end{equation*}
$$

We recall the following basic fact from the theory of projective connections on Riemann surfaces (see, e.g., [28]). Let $D \subset \mathbb{C}$ be an open neighborhood of a point $p \in \mathbb{C}$. Let $f$ be a biholomorphism on $D$. Consider the holomorphic function $E_{f}(v, w)$ on $D \times D$ given by

$$
\begin{equation*}
E_{f}(v, w)=\frac{f^{\prime}(v) f^{\prime}(w)}{[f(v)-f(w)]^{2}}, \quad v, w \in D . \tag{7.16}
\end{equation*}
$$

Let $\hat{v}=v-p$, and $\hat{w}=w-p$. By expanding $E_{f}(v, w)$ as a series in $\hat{v}$ and $\hat{w}$, one gets

$$
\begin{equation*}
\frac{f^{\prime}(v) f^{\prime}(w)}{[f(v)-f(w)]^{2}}=\frac{1}{(v-w)^{2}}+\frac{1}{6}(S f)(p)+H(\hat{v}, \hat{w}), \tag{7.17}
\end{equation*}
$$

as $\hat{v}, \hat{w} \rightarrow 0$, where

$$
\begin{equation*}
(S f)(p)=\frac{f^{\prime \prime \prime}(p)}{f^{\prime}(p)}-\frac{3}{2}\left(\frac{f^{\prime \prime}(p)}{f^{\prime}(p)}\right)^{2} \tag{7.18}
\end{equation*}
$$

is called the Schwarzian derivative of $f$, and $H(\hat{v}, \hat{w})$ is a sum of terms in $\hat{v}$ and $\hat{w}$ of strictly positive degree.

Considering (7.15), the function $F_{\zeta}(z)$ has a pole of order two at $z=\iota(\zeta)$. Using (7.17), we have

$$
\begin{equation*}
-\frac{x^{\prime}(z) x^{\prime}(\zeta)}{[x(z)-x(\zeta)]^{2}}=-\frac{x^{\prime}(\zeta)}{x^{\prime}(\iota(\zeta))} \cdot \frac{x^{\prime}(z) x^{\prime}(\iota(\zeta))}{[x(z)-x(\iota(\zeta))]^{2}}=-\frac{x^{\prime}(\zeta)}{x^{\prime}(\iota(\zeta))}\left(\frac{1}{[z-\iota(\zeta)]^{2}}+O(1)\right), \tag{7.19}
\end{equation*}
$$

as $z \rightarrow \iota(\zeta)$. Thus, the principal part of the germ of $F_{\zeta}(z)$ at $z=\iota(\zeta)$ is given by

$$
\begin{equation*}
Q_{1}(z, \zeta)=-\frac{x^{\prime}(\zeta)}{x^{\prime}(\iota(\zeta))} \cdot \frac{1}{[z-\iota(\zeta)]^{2}}=\frac{1}{(\zeta z-1)^{2}} . \tag{7.20}
\end{equation*}
$$

In addition, by 7.15), the function $F_{\zeta}(z)$ has a pole at $z=0$. Since $W_{0,2}(x(z), x(\zeta))$ has a zero of order 2 at $z=\infty$, the term $F_{\zeta}(\iota(z)) / z^{2}$, in 7.15), is regular at $z=0$. Therefore, the principal part of the germ of $F_{\zeta}(z)$ at $z=0$ is the same as the principal part of the Laurent polynomial

$$
\begin{equation*}
-\left[\left(1-\frac{1}{z^{2}}\right) \sum_{k=1}^{d-1} b_{k}(\zeta)\left(z+\frac{1}{z}\right)^{k-1}\right] \tag{7.21}
\end{equation*}
$$

and is given by

$$
\begin{equation*}
Q_{2}(z, \zeta)=-\sum_{k=1}^{d-1} \frac{b_{k}(\zeta)}{z^{k+1}} \sum_{r=0}^{\left[\frac{k-1}{2}\right]} \mathrm{c}_{k, r} z^{2 r}, \tag{7.22}
\end{equation*}
$$

where

$$
\begin{equation*}
\mathrm{c}_{k, r}=\frac{2 r-k}{k}\binom{k}{r} . \tag{7.23}
\end{equation*}
$$

By the Mittag-Leffler theorem, we have

$$
\begin{equation*}
F_{\zeta}(z)=Q_{1}(z, \zeta)+Q_{2}(z, \zeta)+c(\zeta), \quad c(\zeta) \in H^{0}\left(\mathbb{C P}^{1}, \mathscr{O}\right) . \tag{7.24}
\end{equation*}
$$

Since the function $F_{\zeta}(z)$ has a zero of order two at $z=\infty$, the constant function $c(\zeta)$ should be equal to zero. To get an explicit expression for $F_{\zeta}(z)$ in terms of $z, \zeta$, it suffices to find $b_{k}(\zeta)$ 's, as a function of $\zeta$, explicitly. Note that each $b_{k}(\zeta)$ is a linear combination of the Fourier coefficients

$$
\begin{equation*}
a_{n}(\zeta)=\frac{1}{2 \pi \mathrm{i}} \oint_{\gamma} \frac{F_{\zeta}(z)}{z^{n+1}} \mathrm{~d} z, \quad n \in \mathbb{Z} \tag{7.25}
\end{equation*}
$$

of the restriction of $F_{\zeta}(z)$ to $\gamma$. Considering the degree of the Laurent polynomial $Q_{2}(z, \zeta)$, it suffices to find only $\mathrm{x}_{i}=a_{-i-1}(\zeta), 1 \leqslant i \leqslant d-1$. For each $1 \leqslant i \leqslant d-1$, the identity

$$
\begin{equation*}
a_{-i-1}(\zeta)=\frac{1}{2 \pi \mathrm{i}} \oint_{\gamma}\left[Q_{1}(z, \zeta)+Q_{2}(z, \zeta)\right] z^{i} \mathrm{~d} z \tag{7.26}
\end{equation*}
$$

leads to a linear equation of the following form satisfied by the $\mathrm{x}_{i}$ 's:

$$
\begin{equation*}
\sum_{j=1}^{d-1} \mathrm{C}_{i j} \mathrm{x}_{j}=\frac{i}{\zeta^{i+1}} \tag{7.27}
\end{equation*}
$$

where the coefficients $\mathrm{C}_{i j}$ depend only on $\mathfrak{b}$, and $\mathrm{t}_{\ell_{1}, \ell_{2}}^{(0)},\left(\ell_{1}, \ell_{2}\right) \in \mathfrak{L}_{\text {cylinder }}$.

We assume that the given values to the Boltzmann weights $\mathfrak{t}_{\vec{\ell}}^{(0)}$ (or, equivalently, the formal parameters $\left.\alpha_{n}, 3 \leqslant n \leqslant d\right)$ of the model are such that the above-mentioned matrix $\left(\mathrm{C}_{i j}\right)$ is invertible. Hence, we get the explicit expression of

$$
\begin{equation*}
F(z, \zeta)=Q_{1}(z, \zeta)+Q_{2}(z, \zeta) \tag{7.28}
\end{equation*}
$$

in terms of $z, \zeta$, which depends on the support $\Gamma=[-\mathfrak{b}, \mathfrak{b}]$ of the large- $N$ spectral distribution $\mu$, and the Boltzmann weights $\mathrm{t}_{\ell_{1}, \ell_{2}}^{(0)},\left(\ell_{1}, \ell_{2}\right) \in \mathfrak{L}_{\text {cylinder }}$. Since the function

$$
\begin{equation*}
W_{0,2}(x(z), x(\zeta)) x^{\prime}(z) x^{\prime}(\zeta) \tag{7.29}
\end{equation*}
$$

is symmetric on its initial domain of definition $\left(\Sigma \backslash \overline{V^{i}}\right) \times\left(\Sigma \backslash \overline{V^{i}}\right)$, the function $F(z, \zeta)$, given by (7.28), gives, indeed, the presumed meromorphic continuation of 7.29 ) to $\mathbb{C P}^{1} \times \mathbb{C P}^{1}{ }^{20}$ From now on, we consider the restriction of $F(z, \zeta)$ to $\Sigma \times \Sigma$.

The bidifferential

$$
\begin{equation*}
\tilde{\omega}_{0,2}(z, \zeta)=F(z, \zeta) d z d \zeta \tag{7.30}
\end{equation*}
$$

over $\Sigma \times \Sigma$ has only a pole of order 2 at

$$
\begin{equation*}
\tilde{\Delta}=\{(p, \iota(p)) \mid p \in V \subset \Sigma\} \subset \Sigma \times \Sigma . \tag{7.31}
\end{equation*}
$$

Considering (7.20, the singular behavior of $\tilde{\omega}_{0,2}(z, \zeta)$ at $\tilde{\Delta}$ is as follows:

$$
\begin{equation*}
\tilde{\omega}_{0,2}(z, \zeta)=-\frac{x^{\prime}(\zeta)}{x^{\prime}(\iota(\zeta))}\left(\frac{1}{[z-\iota(\zeta)]^{2}}+O(1)\right) d z d \zeta, \quad \text { as } z \rightarrow \iota(\zeta) . \tag{7.32}
\end{equation*}
$$

In addition, the polar divisor of the bidifferential

$$
\begin{equation*}
\hat{B}_{0}(z, \zeta)=\frac{d x(z) d x(\zeta)}{[x(z)-x(\zeta)]^{2}} \tag{7.33}
\end{equation*}
$$

over $\Sigma \times \Sigma$ is given by $2 \Delta+2 \tilde{\Delta}$, where

$$
\begin{equation*}
\Delta=\{(p, p) \mid p \in \Sigma\} \subset \Sigma \times \Sigma \tag{7.34}
\end{equation*}
$$

denotes the diagonal divisor. The singular behavior of $\hat{B}_{0}(z, \zeta)$ at $\Delta$ and $\tilde{\Delta}$ is given by

$$
\begin{equation*}
\hat{B}_{0}(z, \zeta)=\left(\frac{1}{[z-\zeta]^{2}}+O(1)\right) d z d \zeta, \quad \text { as } z \rightarrow \zeta \tag{7.35}
\end{equation*}
$$

\begin{equation*}
\hat{B}_{0}(z, \zeta)=\frac{\iota^{*}(d \zeta)}{d \zeta}\left(\frac{1}{[z-\iota(\zeta)]^{2}}+O(1)\right) d z d \zeta, \quad \text { as } z \rightarrow \iota(\zeta) \tag{7.36}
\end{equation*}
$$

\]

respectively. Therefore, the symmetric bidifferential

$$
\begin{equation*}
\omega_{0,2}(z, \zeta)=\tilde{\omega}_{0,2}(z, \zeta)+\hat{B}_{0}(z, \zeta) \tag{7.37}
\end{equation*}
$$

has only a pole of order 2 at $\Delta$, and its singular behavior is given by

$$
\begin{equation*}
\omega_{0,2}(z, \zeta)=\left(\frac{1}{[z-\zeta]^{2}}+O(1)\right) d z d \zeta, \quad \text { as } z \rightarrow \zeta \tag{7.38}
\end{equation*}
$$

Succinctly,

$$
\begin{equation*}
\omega_{0,2}(z, \zeta) \in H^{0}\left(\Sigma^{2}, K_{\Sigma}^{\boxtimes 2}(2 \Delta)\right)^{\mathfrak{S}_{2}} \tag{7.39}
\end{equation*}
$$

and

$$
\begin{equation*}
\left.\operatorname{Bires}\right|_{\Delta} \omega_{0,2}(z, \zeta)=1 \tag{7.40}
\end{equation*}
$$

## 8 Local Cauchy kernel

Let $\tilde{V}$ be the simply-connected domain which one gets by cutting the neighborhood $V \subset \Sigma$ along a radial line $\left\{z=r e^{i \theta} \mid r \in \mathbb{R}_{+}\right.$, fixed $\left.\theta\right\}$. Fix $p_{0} \in \tilde{V}$. Considering (7.39) and (7.40), one gets a local Cauchy kernel

$$
\begin{equation*}
G(z, \zeta)=\int_{p_{0}}^{\zeta} \omega_{0,2}(z, \tau) \tag{8.1}
\end{equation*}
$$

by integrating the 1-form $\omega_{0,2}(\cdot, \tau)$ on $\tilde{V}$ [6]. We have

$$
\begin{equation*}
G(z, \zeta) \in \Gamma(\Sigma \times V, \Omega \boxtimes \mathscr{O}(\Delta)), \tag{8.2}
\end{equation*}
$$

and

$$
\begin{equation*}
G(z, \zeta)=\left(\frac{1}{z-\zeta}+O(1)\right) d z, \quad \text { as } z \rightarrow \zeta \tag{8.3}
\end{equation*}
$$

Denote by $[\phi]_{p} \in \mathscr{Q}_{p} / \Omega_{p}$ the image of the germ of a meromorphic 1-form $\phi \in \mathscr{Q}(\Sigma)$ at a point $p \in \Sigma$ under the projection map $\pi_{p}: \mathscr{Q}_{p} \rightarrow \mathscr{Q}_{p} / \Omega_{p}$. Denote the set of poles of a meromorphic 1-form $\phi \in \mathscr{Q}(\Sigma)$ by $\mathfrak{P}(\phi)$. Let $\tilde{\mathrm{F}} \subset \mathscr{Q}(V)$ be the subspace of meromorphic 1 -forms which have finitely many poles on $V \subset \Sigma$. Consider the operator $\mathcal{K}: \tilde{\mathrm{F}} \rightarrow \mathscr{Q}(\Sigma)$ given by

$$
\begin{equation*}
\mathcal{K} \phi(z)=\sum_{p \in V} \operatorname{Res}_{\zeta=p} G(z, \zeta) \phi(\zeta)=\frac{1}{2 \pi \mathrm{i}} \sum_{p \in V} \oint_{|\zeta-p|=\epsilon} G(z, \zeta) \phi(\zeta) \tag{8.4}
\end{equation*}
$$

Note that, for each $\phi \in \tilde{\mathrm{F}}$, a point $p \in V$ contributes to the summation in iff $p \in \mathfrak{P}(\phi)$. In
addition, by (8.3), we have

$$
\begin{equation*}
[\mathcal{K} \phi]_{p}=[\phi]_{p}, \quad \forall p \in \mathfrak{P}(\mathcal{K} \phi)=\mathfrak{P}(\phi) . \tag{8.5}
\end{equation*}
$$

We use the same notation $\mathcal{K}$ to denote the operator $r_{\Sigma, V} \mathcal{K}: \tilde{\mathrm{F}} \rightarrow \tilde{\mathrm{F}}$, where $r_{\Sigma, V}: \mathscr{Q}(\Sigma) \rightarrow \mathscr{Q}(V)$ is the restriction map. By 8.5), we have

$$
\begin{equation*}
(\mathbb{1}-\mathcal{K})(\tilde{\mathrm{F}}) \subset \Omega(V) . \tag{8.6}
\end{equation*}
$$

Therefore, $\mathcal{K}: \tilde{\mathrm{F}} \rightarrow \tilde{\mathrm{F}}$ is an idempotent operator, and we have the decomposition

$$
\begin{equation*}
\tilde{F}=\mathcal{K}(\tilde{F}) \oplus(\mathbb{1}-\mathcal{K})(\tilde{F}) . \tag{8.7}
\end{equation*}
$$

Consider the operator $\tilde{\mathcal{K}}: \tilde{\mathrm{F}} \rightarrow \tilde{\mathrm{F}}$ given by

$$
\begin{equation*}
\tilde{\mathcal{K}} \phi(z)=\sum_{p \in V} \operatorname{Res}_{\zeta=p} G(z, \iota(\zeta)) \phi(\zeta) . \tag{8.8}
\end{equation*}
$$

The following simple lemma will be used several times later.
Lemma 8.1. The operator $\mathcal{K}: \tilde{\mathrm{F}} \rightarrow \tilde{\mathrm{F}}$ can be decomposed as

$$
\begin{equation*}
\mathcal{K}=\frac{1}{2}(\mathcal{K}+\tilde{\mathcal{K}}) \mathcal{P}_{+}+\frac{1}{2}(\mathcal{K}-\tilde{\mathcal{K}}) \mathcal{P}_{-}, \tag{8.9}
\end{equation*}
$$

where the orthogonal idempotents $\mathcal{P}_{ \pm}: \tilde{\mathrm{F}} \rightarrow \tilde{\mathrm{F}}_{ \pm}$are given by (6.27).
Proof. We rewrite the operator $\mathcal{K}$ in the following form

$$
\begin{equation*}
\mathcal{K}=\frac{1}{2}[(\mathcal{K}+\tilde{\mathcal{K}})+(\mathcal{K}-\tilde{\mathcal{K}})]\left[\mathcal{P}_{+}+\mathcal{P}_{-}\right] . \tag{8.10}
\end{equation*}
$$

Since $\tilde{\mathcal{K}}=\mathcal{K} \iota^{*}$, we have

$$
\begin{equation*}
(\mathcal{K} \pm \tilde{\mathcal{K}}) \mathcal{P}_{\mp}=0 . \tag{8.11}
\end{equation*}
$$

In the remaining part of this section, we try to explain some elementary aspects of the blobbed topological recursion formula, which will be discussed in the next section, in a simpler setup. Consider the operator

$$
\begin{equation*}
\mathcal{T}=\hat{\mathcal{P}}_{+}+\hat{\mathcal{O}}, \quad \mathcal{T}: \hat{\mathrm{F}} \rightarrow \mathscr{Q}(V), \tag{8.12}
\end{equation*}
$$

where the operators $\hat{\mathcal{P}}_{+}$and $\hat{\mathcal{O}}$ are given by (6.28) and (6.30), respectively. Let $P \subset V$ be a fixed finite set of points in $V \subset \Sigma$ such that $P \cap \gamma=\emptyset$. Suppose we are given a set of germs $s_{i} \in \mathscr{Q}_{p_{i}} / \Omega_{p_{i}}$,
at the points $p_{i} \in P, i=1, \cdots,|P|$, and an $\iota$-invariant holomorphic 1-form $\psi \in \Omega_{\mathrm{inv}}(V)$. Denote by $\mathrm{E} \subset H^{0}\left(\Sigma, K_{\Sigma}\right)$ the subspace of holomorphic 1-forms $\tilde{\eta}$ on $\Sigma$ whose restriction to $V \subset \Sigma$ satisfies the homogeneous equation

$$
\begin{equation*}
\mathcal{T} \tilde{\eta}=0, \quad \tilde{\eta} \in \mathrm{E} . \tag{8.13}
\end{equation*}
$$

Let $\mathrm{A} \subset \mathscr{Q}(\Sigma)$ be the set of meromorphic 1-forms $\phi$ on $\Sigma$ whose restriction to $V \subset \Sigma$ satisfies the inhomogeneous equation

$$
\begin{equation*}
\mathcal{T} \phi=\psi, \quad \phi \in \mathrm{A}, \tag{8.14}

The set $\mathrm{A} \subset \mathscr{Q}(\Sigma)$ is an affine space over the vector space E . In the following, we investigate the space A.

The operator $\mathcal{K}$ maps the space A to the meromorphic 1 -form $\phi_{0} \in \mathscr{Q}(\Sigma)$, given by

Thus, the dimension of the subspace $\mathrm{E} \subset H^{0}\left(\Sigma, K_{\Sigma}\right)$ equals the dimension of the kernel of the matrix $\left(\mathrm{C}_{i j}\right)$.

Considering Proposition 8.2, Lemma 8.3 and Lemma 8.4, in general, a 1 -form $\phi \in \mathrm{A}$ can be written as

## 9 Blobbed topological recursion formula

In this section we show that all the stable coefficients $W_{g, n}\left(x_{1}, \cdots, x_{n}\right)$ of the large $N$ expansion of the correlators of our model can be computed recursively using the blobbed topological recursion formula [4]. In the following, without further explicit mention, a couple $(g, n)$ is assumed to be stable, i.e. $(g, n) \neq(0,1),(0,2)$.

Let $f(x) \in \mathscr{O}(\mathbb{C} \backslash \Gamma)$ be a holomorphic function on $\mathbb{C} \backslash \Gamma$ with a jump discontinuity on $\Gamma$. We denote by $\delta f(s)$ and $\sigma f(s)$ the functions given by

\Phi_{g, n}\left(z ; z_{I}\right) & =\frac{1}{2 \pi \mathrm{i}} \oint_{\partial \Sigma} G(z, \zeta) d_{\zeta} \mathcal{V}_{g, n}\left(\zeta ; z_{I}\right) \\
& =-\frac{1}{2 \pi \mathrm{i}} \oint_{\partial \Sigma} \omega_{0,2}(z, \zeta) \mathcal{V}_{g, n}\left(\zeta ; z_{I}\right) . \tag{9.20}
\end{align*}
$$

Note that, for each stable $(g, n)$, the right-hand side of 9.19 and 9.20 involves only $\omega_{g^{\prime}, n^{\prime}}$ with $2 g^{\prime}+n^{\prime}-2<2 g+n-2$. Therefore, we have:

Theorem 9.1. For random matrix geometries of type $(1,0)$ with the distribution $\mathrm{d} \rho=e^{-\mathcal{S}(D)} \mathrm{d} D$, all the stable $\omega_{g, n}, 2 g+n-2>0$, can be computed recursively, using the blobbed topological recursion formula given by

$$
\begin{equation*}
\omega_{g, n}\left(z, z_{I}\right)=-\frac{1}{2 \pi \mathrm{i}} \oint_{\partial \Sigma} \omega_{0,2}(z, \zeta) \mathcal{V}_{g, n}\left(\zeta ; z_{I}\right)+\sum_{p \in \mathfrak{\Re}} \operatorname{Res}_{\zeta=p} K(z, \zeta) \mathcal{E}_{g, n}\left(\zeta, \iota(\zeta) ; z_{I}\right) . \tag{9.21}
\end{equation*}
$$

The initial data for the recursion relation (9.21) is the 1-form $\omega_{0,1}(z)$ and the fundamental bidifferential $\omega_{0,2}(z, \zeta)$.

[^1]:    ${ }^{1}$ Given a quadratic form q on a vector space $V$, we follow the convention to define the Clifford algebra $\mathrm{C} \ell(V, \mathrm{q})$ associated to $V$ and q as $\mathrm{C} \ell(V, \mathrm{q}):=\mathcal{T}(V) / \mathcal{I}_{\mathrm{q}}(V)$, where $\mathcal{T}(V)=\sum_{r=0}^{\infty} V^{\otimes r}$, and $\mathcal{I}_{\mathrm{q}}(V)$ denotes the two-sided ideal generated by elements of the form $v \otimes v-\mathrm{q}(v) \mathbb{1}$ for $v \in V$.

[^2]:    ${ }^{2}$ Let $\rho: \mathrm{C}_{p, q} \rightarrow \operatorname{Hom}_{\mathbb{C}}(V, V)$ be an irreducible complex unitary representation of $\mathrm{C}_{p, q}$. It can be shown [23] that:

    - If $n=p+q$ is even, then the representation $\rho$ is unique up to unitary equivalence;
    - If $n=p+q$ is odd, then either $\rho(\Gamma)=\mathbb{1}_{V}$ or $\rho(\Gamma)=-\mathbb{1}_{V}$. Both possibilities can occur, and the corresponding representations are inequivalent.
    ${ }^{3}$ We have $V_{p, q} \cong \mathbb{C}^{k}$, where $k=2^{n / 2}$ (resp. $k=2^{(n-1) / 2}$ ) for $n$ even (resp. odd).
    ${ }^{4}$ For $i=1, \cdots, p$ (resp. $i=p+1, \cdots, n$ ) the gamma matrix $\gamma^{i}$ is Hermitian (resp. anti-Hermitian) with respect to $\langle\cdot, \cdot\rangle$.
    ${ }^{5}$ In the physics literature, the operator $C$ is called the charge conjugation operator.

[^3]:    ${ }^{6}$ The formal parameters $\left(\alpha_{n}, \hat{\alpha}_{n_{I}}\right)_{n, n_{I}}$ play the role of coupling constants in physics literature.

    ${ }^{9}$ A polygon of perimeter $\ell$ is an oriented 2-dimensional CW complex consisting of a 2 -cell, homeomorphic to a disk, whose boundary is equipped with a cellular decomposition into $\ell 0$-cells and $\ell 1$-cells. A polygon is called rooted if we distinguish one of the 0 -cells and its incident 1-cell on the boundary. We refer to a labeled rooted polygon of perimeter $\ell$ as a marked face of perimeter $\ell$.

[^5]:    ${ }^{10}$ If each connected component of $S \backslash G$ is homeomorphic to an open disk, then $M=(S, G)$ is called a map.
    ${ }^{11}$ This fact about the exponent of $N$, in the case of maps (or, equivalently, ribbon graphs), was first noticed by Gerard 't Hooft in [26] (see, e.g., 19]).

[^6]:    ${ }^{12}$ The Dirac measure at $\lambda \in \mathbb{R}$ is denoted by $\delta_{\lambda}$.
    ${ }^{13}$ The measure $\mu=\varphi(s) \mathrm{d} s$ plays the same role as what is called, in the context of convergent matrix integrals, the equilibrium measure (see, e.g., [1).

[^7]:    ${ }^{14}$ In general, there are, at least, two approaches in the literature for deriving the SDEs for matrix models: one is usually referred to as "integration by parts" or "invariance under change of variable" which is basically the abovementioned differential geometric approach; and the other one is combinatorial and based on Tutte's decomposition. The differential geometric approach has the advantage that it can be applied to a slightly more general class of models, e.g. the $\beta$-ensembles for arbitrary $\beta>0$, which do not necessarily have a combinatorial interpretation.

[^8]:    ${ }^{15}$ In addition, the term $\operatorname{Vol}\left(\mathrm{U}_{N}\right)$ is the volume of the unitary group $\mathrm{U}_{N}$ with respect to the Riemannian volume form corresponding to the induced metric on $\mathrm{U}_{N}$ from the inner product $\langle A, B\rangle=\operatorname{Tr}\left(A B^{*}\right)$ on the ambient vector space $\mathrm{M}_{N}(\mathbb{C})$.

[^9]:    ${ }^{16}$ Since we are considering the case in which $\Gamma \subset \hat{\Gamma}^{\circ}$, i.e. both edges of $\hat{\Gamma}$ are soft, the boundary term is of exponential decay as $N \rightarrow \infty$ (see [7).
    ${ }^{17}$ Strictly speaking, we should assume that $x$ and $x_{j}$ 's are not in an $\epsilon$-tubular neighborhood of $\hat{\Gamma}$, so that the function $1 /\left((x-\xi)\left(x_{j}-\xi\right)^{2}\right)$ is holomorphic on that neighborhood of $\hat{\Gamma}$.

[^10]:    ${ }^{18}$ For a Torelli marked closed Riemann surface $X$ of genus $g \geqslant 0$, the fundamental symmetric bidifferential $B(p, q)$ of the second kind with biresidue 1 over $X^{2}$ (also referred to as the Bergman kernel, in some references) is uniquely characterized by the following conditions (see, e.g., 22, 28] and 27] for details):

    - $B \in H^{0}\left(X^{2}, K_{X}^{\boxtimes 2}(2 \Delta)\right)^{\mathfrak{G}_{2}}$, and Bires $\left.\right|_{\Delta} B=1$, where $\Delta \subset X^{2}$ denotes the diagonal divisor.
    - For each $p \in X$, the 1-form $B(p, \cdot)$ has vanishing $a_{i}$-periods, where $\left\{a_{i}, b_{i}\right\}_{i=1}^{g}$ is the symplectic basis of $H_{1}(X, \mathbb{Z})$ specifying the Torelli making of $X$.

[^11]:    ${ }^{19}$ Our approach for analyzing the function $F_{\zeta}(z)$ has a straightforward extension to the general case of $\Gamma=[\mathfrak{a}, \mathfrak{b}] \subset \mathbb{R}$. However, the computational part becomes more cumbersome.

[^12]:    ${ }^{20}$ For the classical formal 1-Hermitian matrix models, in the one-cut regime, the meromorphic continuation of 7.29 to $\mathbb{C P}^{1} \times \mathbb{C P}^{1}$ is given by $Q_{1}(z, \zeta)$, and it is universal in the sense that it does not depend on the formal parameters of the model (see [19, Sec. 3.2.1).
