# On polarized scattering equations for superamplitudes of 11D supergravity and ambitwistor superstring

#### Abstract

We revisited the formalism of 11D polarized scattering equation by Geyer and Mason from the perspective of spinor frame approach and spinor moving frame formulation of the 11D ambitwistor superstring action. In particular, we rigorously obtain the equation for the spinor function on Riemann sphere from the supertwistor form of the ambitwistor superstring action, write its general solution and use it to derive the polarized scattering equation. We show that the expression used by Geyer and Mason to motivate their ansatz for the solution of polarized scattering equation can be obtained from our solution after a suitable gauge fixing. To this end we use the hidden gauge symmetries of the 11D ambitwistor superstring, including $S O(16)$, and the description of ambitwistor superstring as a dynamical system in an 11D superspace enlarged by bosonic directions parametrized by 517 tensorial central charge coordinates $Z \underline{\mu} \underline{\underline{\nu}}$ and $Z \underline{\mu} \underline{\mu} \underline{\rho} \underline{\sigma} \kappa$. We have also found the fermionic superpartner of the polarized scattering equation. This happens to be a differential equation in fermionic variables imposed on the superamplitude, rather then just a condition on the scattering data as the bosonic polarized scattering equation is. $\mathrm{D}=10$ case is also discussed stressing the similarities and differences with 11D systems. The useful formulation of 10 D ambitwistor superstring considers it as a dynamical system in superspace enlarged with 126 tensorial central charge coordinates $Z^{\mu \nu \rho \sigma \kappa}$.

## 1. Introduction

Recent years an impressive progress in calculation of scattering amplitudes of maximally super-


 in the case of 4 spacetime dimensions.

The development of this twisor-like formalism for the case of higher dimensional theories and
 the observation that 10D spinor helicity formalism of [ $[2 \overline{0}]$ can be understood as spinor moving frame approach to supersymmetric particles extended to the description of amplitudes ${ }^{1}$ allowed us to develop the spinor helicity formalism for 11D supergravity and a new constrained superfield formalism for 10D SYM and 11D supergravity amplitudes, to find the Ward identities for these amplitudes and to discuss a candidate for generalization of the BCFW recurrent relations [12 for the constrained tree superamplitudes. In $[\overline{2} \overline{2} \overline{6}]$ an alternative analytic superfield formalism for superamplitudes was proposed. It was also oriented on the use of BCFW-type recurrent relations which are still to be found in this case.

More recently an apparently different approach to 11D supergravity and 10D SYM amplitudes was proposed in [鳥烈. It is based on the so-called polarized scattering equation which can be considered as a kind of square root of the CHY scattering equations [ $3 \overline{5} \overline{5}, \underline{1}, \overline{3} \overline{6}]$ (actually present
 scattering equation for 6 D amplitudes was proposed in [4] $\overline{1} 1]$ while the 11D and 10D polarized scattering equations are among the beautiful findings of
 for the first time in [450], was discussed and especially stressed in [20

In this paper we revisit the 11D polarized scattering equation formalism of [ $[2 \overline{8}]$ and its ambitwistor superstring origin using the spinor frame approach. We show how the understanding of the spinor frame nature of the 11D spinor helicity formalism allows to clarify the origin of basic equations imposed in $[\overline{2} \overline{2} \overline{\bar{\delta}}]$ and the ambitwistor superstring derivation of these equations. We show that the correct basis for this is provided by the 11D ambitwistor superstring of [450] rather then by its modification suggested in [2 $\overline{2} \bar{d}$. In the derivation of the basic equations the solution of which provides us with the expression for the meromorphic spinor function, which

[^0]was employed to formulated the polarized scattering equation in its most suggestive form, we have used essentially the possibility to formulate the 11D ambitwistor superstring as a system in an enlarged superspace with 528 bosonic coordinates [45] as well as the $S O(16)$ gauge symmetry of the 11D ambitwistor superstring ${ }^{2}$.

In the ambitwistor superstring approach the above mentioned meromorphic spinor function on Riemann sphere, which satisfies the polarized scattering equation, appears accompanied by 16 component fermionic meromorphic function. The expression for this in terms of scattering data is supersymmetric invariant after the expression for meromorphic bosonic spinor function is taken into account and thus can be considered as a superpartner of this latter. This observation suggests the existence of a fermionic superpartner of the polarized scattering equations. We show that such a superpartner (spolarized scattering equation) does exist but is a differential equation satisfied by 11D superamplitudes rather than a condition on scattering data (as the bosonic polarized scattering equation is itself).

We also consider 10D polarized scattering equation formalism and its ambitwistor superstring origin especially stressing the stages where the differences with 11D case occur.

We begin in sec. 2 by reviewing the spinor frame description of the 11D spinor helicity formalism [2] $\left.{ }_{2}^{2} \overline{6}\right]$. In sec. 3, after reviewing the scattering equation [3] the 11D polarized scattering equation of [20
 appears as consistency condition of the constraints for the meromorphic spinor function and scattering equation for the meromorphic vector function involved in these constraints. In sec. 4 we reconsider the supersymmetry generator and supersymmetric amplitude proposed in [20 the perspective of spinor frame approach. In Sec. 5 we turn to the ambitwistor superstring origin of the polarized scattering equation. We begin there by briefly reviewing the standard Green-Schwarz/Brink-Schwarz like formulation of the ambitwistor superstring and its reformulation in term of constrained supertwistor $\left(\mu_{\underline{q}}^{\underline{\alpha}}, \lambda_{\underline{\alpha} \underline{q}}, \eta_{\underline{q}}\right)$. We show that the fact that 11D ambitwistor superstring of [45] can be formulated as a dynamical system in an enlarged superspace can be used to relax the second class constraints restricting $\mu_{\underline{q}}^{\underline{\alpha}}$. Then, applying the Lagrange multiplier method we can introduce the first class constraints generating $S O(16)$ gauge symmetry into the supertwistor form of the ambitwistor superstring action and consider the supertwistor component $\mu_{\underline{q}}^{\alpha}$ as unconstrained variable. The variation of this first order action with respect to $\mu_{\underline{q}}^{\alpha}(\sigma)$ becomes straightforward and is used to obtain the dynamical equation for highly constrained bosonic fields, the spinor functions $\lambda_{\underline{\alpha} \underline{q}}(\sigma)$. The solution of these equations provides us with the $S O(16)$ gauge covariant generalization of the meromorphic spinor functions used as an ansatz for the solution of the polarized scattering equation in [20

In sec. $\bar{\sigma}_{1}$ we find the fermionic superpartner of the polarized scattering equation which is a differential equation imposed on superamplitudes. Finally, in sec. 7 we describe briefly the $\mathrm{D}=10$ spinor helicity formalism, polarized scattering equation and ambitwistor superstring origin of this, especially stressing the points where the 10D case differs from 11D one. We conclude in Sec. 8. Some useful equations of the spinor frame formalism can be found in the Appendices.

[^1]Our notation are that of $\left[\overline{2} \overline{2}_{1}, \overline{2} \overline{2}\right]$ ] and $[\overline{2} \overline{2} \overline{6}]$, up to the use of underlined Greek symbols from the beginning/middle of the alphabet for the 11D Majorana spinors/vectors and underlined Latin symbols for the $\mathrm{SO}(9)$ vector $(\underline{I}, \underline{J}, \ldots)$ and spinor indices $(\underline{q}, \underline{p}, \ldots)$. In some places $\underline{q}, \underline{p}, \ldots$ are also considered to be $S O(16)$ vector indices, which is related to the hidden $\mathrm{SO}(16)$ symmetry of 11 D superparticle (see [502] and refs. therein).

## 2. Spinor frame approach to the 11D spinor helicity formalism

### 2.1 Scattering data in $\mathrm{D}=11$

Light-like momentum $k_{\underline{\mu} i}$ of a massless particle (consider it to be $i$-th particle of a scattering process),

and we have used the contractions of the 11D Dirac matrices with charge conjugation matrix and its inverse, $\Gamma_{\underline{\mu} \underline{\alpha} \underline{\beta}}:=\gamma_{\underline{\mu} \underline{\alpha} \underline{\gamma}} C_{\underline{\gamma} \beta}$ and $\tilde{\Gamma}_{\underline{\mu}}^{\underline{\alpha} \underline{\beta}}:=C^{\underline{\alpha}} \underline{\gamma} \gamma_{\underline{\mu} \underline{\gamma}}$, which are real, symmetric and obey

Eqs. ( $\left.\overline{2} \cdot \overline{2}, \overline{2}^{2}\right)$ also describe the essential constraints obeyed by the helicity spinors $\lambda_{\underline{\alpha} \underline{q}}$ (denoted by $\kappa_{\mathfrak{a} \alpha}$ in $[2 \overline{2} \overline{\overline{2}}]$ ) which can be solved by expressing them in terms of spinor frame variables (spinor harmonics) ${ }^{3}$

The spinor frame variables $v_{\underline{\alpha} q i}^{-}$can be considered as a kind of square root of the light-like frame vector $u_{\underline{\mu}}^{=}$in the sense that the following constraints hold

 Eqs. ( ( $\overline{2} \cdot \overline{6})$ and $(\overline{2} \cdot \overline{4})$. The possibility of using these and some other well known properties of spinorial harmonics makes the understanding of spinor frame nature of the helicity spinors very useful for the work of $\left[\overline{2} \overline{2} \overline{\bar{F}_{1}}, \overline{2} \overline{\bar{W}}_{1}^{2}, \overline{2} \overline{2}\right]$ as well as for our study in this paper.

Of course, Eq. (2.5) describes the real Majorana helicity spinors for the case of momentum with positive energy, $k_{0}>0$, in which case also $\rho_{i}^{\#}>0$ and $\sqrt{\rho_{i}^{\#}}$ is well defined. When describing the scattering processes one usually arranges to consider all the particles as, say outcoming, and assign a momentum with negative energy to incoming particles. Then, if $j$-th particle is incoming, $\rho_{j}^{\#}<0$ and one can write $\lambda_{\underline{\alpha q} j}=\sqrt{\left|\rho_{j}^{\#}\right|} v_{\underline{\alpha} \underline{q} j}^{-}$for real $\lambda_{\underline{\alpha q} j}$ and introduce the minus sign in the right hand sides of Eqs. $(\overline{2} \cdot \overline{2})$. Alternatively, one can maintain these equations and ( $\left.\overline{2} \cdot \overline{5}_{1}^{\prime}\right)$ as they are also for incoming particles with $\rho_{j}^{\#}<0$, so that $\sqrt{\rho_{j}^{\#}}=i \sqrt{\rho_{j}^{\#}}$ and $\lambda_{\underline{\alpha} \underline{j} j}$ are just imaginary. We prefer this latter way of proceeding.

The helicity spinors ( $(\overline{2}-5)$ also carry the information about polarizations of the particles, but to make it transparent we need to supply their space by an additional complex structure (see [ $[2 \overline{2} \overline{6}]$ for the discussion). This can be encoded in the complex polarization vector. Polarization 11-vector $U_{\underline{\mu} i}$ of $i$-th particle (denoted by $e_{\mu}$ in [ $\left[\underline{2} \overline{Z_{1}}\right.$ ) obeys

(for shortness, here and below we omit the index $i$ enumerated scattering particles when this cannot lead to a confusion).

Actually, $\bar{w}_{\underline{q} \underline{A}}$ are internal frame variables [ $[\overline{2} \overline{6} \overline{6}]$ or $S O(9) / S O(7) \times S O(2)$ harmonics (in the sense of [5] $\overline{5}]$, see $[\overline{2} \overline{2} \overline{6}]$ and refs therein). This is to say they are 8 complex linear combinations of columns of an $S O(9)$ valued matrix, schematically

### 2.2 Complex spinor frame variables and complex helicity spinors

[^3]However, we do not find practical to introduce also $S O(1,1)$ invariant counterparts of the complementary spinors $v_{\underline{\alpha A}}^{+}$and $\bar{v}_{\underline{\alpha}}^{+\underline{A}}$ from the spinor frame. Of course, if we wish to present e.g. Eq. $(\overline{2}-\overline{1}-\overline{9})$ literally but in terms of the helicity spinors, we obtain not so elegant $\psi_{\underline{\alpha} \underline{\beta}}=$ $4 \lambda_{(\underline{\alpha} \mid \underline{\underline{A}}} v_{\mid \underline{\beta}) \underline{A}}^{+} / \sqrt{\rho^{\#}}$. However, instead we can write the following equivalent set of relations involving $\psi_{\underline{\alpha} \underline{\beta}}$ and the constrained spinors $(\underline{2}-\overline{2})$ only:

 (or $v_{\underline{\alpha} A i}^{-}$) provide a basis for the common kernel space of $\psi_{\underline{\alpha} \underline{\beta} i}$ and $\psi_{\underline{\alpha} \underline{\beta} i}{ }^{5}$

Then the second equations in $(2,23)$ and $(2,2)$ indicate that the set of constrained spinors $\bar{\lambda} \underline{\underline{A} i}$ complete $\lambda_{\underline{\alpha} \underline{A} i}$ till the basis of the space of solutions of the massless Dirac equation, while the matrix $\tilde{\psi}^{\underline{\underline{\alpha}} \underline{\beta}}$ maps these into $\lambda_{\underline{\alpha A} i}$,

This allows us to state that $\lambda_{\underline{\alpha} i}^{A}$ provide the basis of the complementary to the space of common zero modes of $k_{\underline{\alpha} \beta i}$ and $\psi_{\underline{\alpha} \underline{\beta} i}$ in the space of the solutions of 11D massless Dirac equation.

With Eqs. $(2,181)$ we also find

 is very efficient in derivation of such type relations.

Notice that the indices of, say, $\lambda_{\underline{\alpha A} i}$ and $v_{\underline{\alpha} A i}^{-}$are transformed by the rigid $\operatorname{Spin}(1,10)$ group, common for all values of $i$, and by $\operatorname{Spin}(7)_{i} \overline{\text { transformations, specific for each of the scattered }}$ particles. The internal harmonics $\bar{w}_{\underline{q} \underline{A} i}$ are transformed by $\operatorname{Spin}(9)_{i} \otimes \operatorname{Spin}(7)_{i}$, where $\operatorname{Spin}(9)_{i}$ is also specific for $i$-th particle.

## 3. Polarized scattering equation of 11D supergravity

### 3.1 Scattering equations

 points $\sigma_{i}$ on Riemann sphere read

In this subsection we omit underlining of 11D indices to stress that the equations are valued for arbitrary $D$.

As in $[\overline{2} \overline{2} \overline{8}]$ (see also refs. therein) we can introduce the meromorphic D-vector function

Notice that, while $P_{\mu}\left(\sigma_{i}\right)$ diverges, its contraction with $k_{i}^{\mu}$ is well defined (if no one of $\sigma_{j \neq i}$ coincide with $\sigma_{i}$, as usually assumed) due to the mass-shell conditions ( $\left.\overline{2} \cdot \overline{1} \overline{1}_{1}^{2}\right)$.

One can also write the scattering equation (1) as equation on the meromorphic vector function (3)

This equation actually implies (see e.g. [2] $2 \overline{2}]$ and refs. therein) the light-likeness of the meromorphic D-vector function ( $\overline{3}=2$

for any $\sigma$. Thus we consider ( $\overline{3} \cdot 5$ ) with (3) as the third equivalent form of the scattering equation.

The constraint (3.5) can be generated from the so-called ambitwistor string action [4 $\overline{4} \overline{2}]$ and Eq. (3.2) can be obtained from the deformation of this action obtained by incorporating the contribution of the suitable vertex operators to the path integral measure. Below we will describe 11D supersymmetric generalization of the ambitwistor superstring action proposed in [45푸] (see
 action is discussed; this paper gives the arguments in favour of the original action.

### 3.2 Constrained spinor function on Riemann sphere

Eq. (3).51) suggests the existence of a meromorphic function carrying 11D spinor index which plays the role of square root of the above meromorphic vector function in the same sence as helicity spinors can be associated with square roots of the light-like momentum, ( $2 \cdot 2$

Furthermore, then it is convenient to introduce a spinor frame field $v_{\underline{\alpha q}}^{-}(\sigma)\left[{ }_{4}^{4} \bar{w}_{-}^{1}\right.$ and a (purely gauge or Stückelberg) density $\rho^{\#}(\sigma)$ and to use this to write the general solution of the constraints (3-6) in the form

which describe the essential constraints on the spinor frame functions and their relation with the meromorphic vector function,

Notice that the algebraic relations between spinor functions, spinor frame fields and the meromorphic vector function obeying ( spinors, spinor frame variables and light-like momentum of $i$-th scattered particle. This is why we use essentially the same symbols in both cases (distinguishing them by indicating explicitly the dependence on $\sigma$ in the case of functions and putting the index $i$ in the case of variables corresponding to $i$-th scattered particle).

The presence of $S O(16)$ valued matrix field $\mathcal{S}(\sigma) \in S O(16)\left(\mathcal{S S}^{T}=I\right)$ in (3) reflects the invariance of $\left(\overline{3} \cdot \bar{W}_{1}\right)$ under the $S O(16)$ gauge transformations. One might wonder why we have not introduced such a matrix in the relation (2.5) between polarization spinors corresponding to $i$-th of scattering particles and the $i$-th spinor frame. The reason is that the helicity spinors should also carry the information about particle polarizations. This is encoded in the polarization vector which is represented by complex $\mathrm{SO}(9)$ vector with vanishing square. Its relation with the complex helicity spinors described by Eq. (2,1) requires the identification of the 16 component index $q$ of the real helicity spinor as $S O(9)$ spinor index thus breaking $S O(16)$ symmetry of Eqs. (2.2) down to $S O(9)$ and prohibiting the inclusion of $S O(16)$ matrix in the common solution (2.5) of $(\overline{2} \cdot \overline{1})$ and $(2 \overline{2})$. In contrast, the spinorial functions should obey, at present stage, only the constraints $\left(\overline{3} \cdot \mathbf{b i n}_{i}\right)$ which are invariant under $S O(16)$ gauge symmetry, so that its general solution is given by (1).

The meromorphic spinor function $\lambda_{\underline{\alpha} \underline{q}}(\sigma)$ which would correspond to the vector meromorphic
 with the use of helicity spinors (or spinor frame variables) related to light-like momenta by ( 2.21 ) instead of the momenta itself. The expression of such a type was proposed in [20
the moving frame treatment of the 11D helicity spinors makes manifest that this was the gauge fixing description.

The complete gauge covariant form of such relation reads

where the function $W_{\underline{q} i} \frac{A}{i}(\sigma)$ has no poles and obeys the 'purity' conditions

This is necessary to obey the constraints ( $\overline{3} \cdot \overline{6}$ ) with meromorphic 11 -vector ( $\overline{3} \cdot 2.2)$. Indeed, taking into account $(3)$

When all $\sigma_{i}$ 's are different, the r.h.s. of this equation has first order poles at $\sigma=\sigma_{i}$ with residues $2 \lambda_{(\underline{\alpha} \mid \underline{A} i} \lambda_{\mid \underline{\beta}) i}=2 \rho_{i}^{\#} v_{(\underline{\alpha} \mid \underline{A} i}^{-} v_{\mid \underline{\beta}) i}^{\underline{A})} \equiv \rho_{i}^{\#} v_{\underline{\alpha} \underline{q} i}^{-} v^{-\bar{\beta} q i}$. In contrast, the l.h.s generically has second order poles. These vanish if we require $W_{\underline{q}} \frac{A}{i}(\sigma)$ to obey the 'purity' conditions ( 3 . 11.1 ).

Notice that the r.h.s. of Eq. (3.10) is clearly complex, as meromorphic function should be, so that our spinor functions $\lambda_{\underline{\alpha q}}(\sigma)$ are not real. Such a complexification is characteristic for the ambitwistor string and CHY scattering equation approaches, as well as e.g. for the pure spinor
 $(3 \cdot 3)$ indicates that it is complex and hance complex are its square roots in the sense of Eqs. $(\overline{3} \cdot \overline{6})$ and $\left(\overline{3}-\overline{-} \overline{8}_{1}^{\prime}\right)$. Thus also the spinor moving frame field $v_{\underline{\alpha} q i}^{-}(\sigma)$, moving frame field $u_{\underline{\mu}}^{=}(\sigma)$ and density $\rho^{\#}(\sigma)$ in $(\overline{3} \cdot \overline{7}),\left(\overline{3} \cdot \bar{B}_{1}^{\prime}\right)$ and $(\overline{3} \cdot \overline{9})$ are complexification of the functions used e.g. in $[\overline{2} \overline{2}]$ and [5] $\overline{5}$ ]. The matrix $\mathcal{S}$ in ( takes values in $S O(16, \mathbb{C})$. As far as the counting of degrees of freedom is concerned, the usual strategy in the models with complexified variables is to substitute reality by analyticity, i.e. to allow for the dependence on, say, complex $\lambda_{\underline{\alpha} \underline{q}}(\sigma)$ but not on its complex conjugate.

### 3.3 Preliminaries on $S O(16)$ gauge symmetry, its naturalness and Stückelberg realization

The appearance of the matrix functions $W_{\underline{q} i} \frac{A}{}(\sigma)$ and not just constant matrix in the r.h.s of (3.10 is necessary to make equations gauge invariant. To motivate the requirement of gauge invariance we can turn to the ambitwistor superstring origin of the spinorial function $\lambda_{\underline{\underline{q} q}}(\sigma)$ providing the square root of the meromorphic vector function ( $\left.\overline{3} \cdot \overline{2}_{2}^{2}\right)$ in the sense of $\left(\overline{3}, \overline{3}_{1}^{2}\right)$.

Even in the case if the relations of constrained spinor functions $\lambda_{\underline{\alpha} \underline{q}}(\sigma)$ with spinor frame field in ( $\overline{3} \cdot \overline{-} \overline{1})$ were not including the $S O(16)$ matrix field and were just $\lambda_{\underline{\alpha} \underline{q}}(\sigma)=\sqrt{\rho^{\#}(\sigma)} v_{\underline{\alpha} q}^{-}(\sigma)$ (the counterpart of this situation we will observe in 10D case), the r.h.s. of ( 3 . 10 ) should include the matrix field anyway. This is because the spinor frame field $v_{\underline{\alpha} \underline{q}}^{-}(\sigma)$ suitable for the description
of 11 D ambitwistor string (and tensionless superstring) is defined up to $S O(9)$ gauge symmetry transformations with $\sigma$-dependent parameters which should act also on $W_{\underline{q} i}^{\underline{A}}(\sigma)$ to leave Eq.


In $\mathrm{D}=11$ the relation of the spinor function and spinor frame functions $(\overline{3} .7)$ includes $S O(16)$ valued matrix $\mathcal{S} \in S O(16)$, so that the reference on defining gauge symmetry of the spinor moving frame field is not valid and the arguments should be different. A way which is more straightforward, although probably not so convincing by itself, consists in just stating that the matrix field $\mathcal{S}(\sigma)$ should not carry additional degrees of freedom which can be provided by imposing the requirement of $S O(16)$ gauge symmetry acting on $\lambda_{\underline{\alpha} \underline{q}}(\sigma)$ as

and leaving invariant $(\overline{3})$. see below, $S O(16)$ is also a gauge symmetry of the 11 D ambitwistor superstring action in its supertwistor form.

To leave invariant Eq. ( 3 (30), this gauge symmetry should also act on the matrix function $W_{\underline{q} i} \frac{A}{i}(\sigma)$,

 hand, as we are going to show, after imposing on $W_{\underline{q}} \frac{A}{i}(\sigma)$ some additional conditions, one can fix a gauge with respect to the $S O(16)$ gauge symmetry in which $W_{\underline{q}}{ }^{\frac{A}{i}}(\sigma)$ for a given $i$ coincides with some $W_{\underline{q} i} \frac{A}{i}$. This implies

Furthermore, in sec. and show that the stronger version of Eq. (3) which includes the same $S O(16)$ valued matrix field $\tilde{\mathcal{O}}_{i \underline{p q}}(\sigma)=\tilde{\mathcal{O}}_{\underline{p q}}(\sigma)$ for all values of $i$, holds:

This makes manifest the existence of the gauge in which the expression similar to the one proposed in [2] 2 엥 $]$ appears ${ }^{6}$.

On the other hand, (3.1 $\overline{1} \overline{6})$ implies that this $S O(16)$ is realized as a Stückelberg gauge symmetry. The reason for this will be clarified below. What happens is that, while the $S O(16)$ is a true gauge symmetry of the ambitwistor superstring action, which is originally hidden but can be made manifest in its supertwistor formulation, it is broken by the vertex operators of physical states. To preserve it in the ambitwistor superstring action deformed by a term accounting for the contribution of the vertex operator to the path integral, $S O(16)$ valued Stückelberg field, $\tilde{\mathcal{O}}_{\underline{p q}}(\sigma) \in S O(16)$ in $(\overline{3} \overline{1} \overline{1})$, must be introduced.

### 3.4 Polarized scattering equation

Now let us observe that the residues of the poles of l.h.s. and r.h.s. of Eq. (3.12) coincide if the spinor frames and polarization data associated to the scattered particles are related by the condition

Using ( $(\overline{3}-10)$ we can write this equation in a bit more compact equivalent form

This relation basically coincides with the one first introduced in scattering equation. Our study revealed the moving frame nature of both the constrained spinors and constrained spinor functions involved in it. Furthermore, the difference with [ $[\overline{2} \overline{8}]$ is that the l.h.s of our version of the polarized scattering equation includes a value of $\mathrm{a}(\mathrm{n}$ analytic) matrix function $\left(\overline{3}-\overline{1} \overline{1}_{\underline{i}}\right)$ at $\sigma=\sigma_{i}, W_{\underline{q} i}^{\underline{A}}\left(\sigma_{i}\right)=W_{\underline{p} i} \underline{A} \tilde{\mathcal{O}}_{\underline{p q}}\left(\sigma_{i}\right)$, rather than just a constant matrix $W_{\underline{q} i} \underline{\underline{A}}$. The reason for this is that in such a way we make the polarized scattering equation invariant under the $\mathrm{SO}(16)$ gauge symmetry characteristic, as we will see below, for ambitwistor superstring. Furthermore, just our $S O(16)$ covariant version of the expression for the meromorphic spinor function ( 3 3 10.10 ) can be obtained naturally from the ambitwistor superstring action deformed by an appropriate vertex operator contribution.

Eq. (3.18) also can (or rather must) be called polarized scattering equation. This is a 'polarized' counterpart of the scattering equation ( $(\overline{3}-1,1)$ while ( $\left.(\overline{3} \cdot \overline{1} 9)^{2}\right)$ is a polarized counterpart of the scattering equation in its form of Eq. ( $\left(\overline{3} \cdot \overline{3} \overline{3}^{\prime}\right)$.

Notice that while the scattering equation ( 3.1 ) is homogeneous, the polarized scattering equation $\left(\overline{3} \cdot \overline{1} \overline{9}_{1}^{\prime}\right)$ is not. As it is seen from its equivalent form ( $\left.\overline{3} \cdot \overline{2} \overline{1}\right)$, the scattering equation provides a decomposition of $i-t h$ helicity spinors $\bar{\lambda}_{\underline{\alpha} i} \underline{A}$ (or complex spinor frame variables $\bar{v}_{\underline{\alpha} \underline{i}}^{-\frac{A}{i}}$ ), which provide the basis of the complementary to the space of common zero modes of $\psi_{i}$ and $\bar{U}_{i}$ in the space of solutions of the massless Dirac equation, on the set of the variables $\lambda_{\underline{\alpha B j}}$ (or $v_{\underline{\alpha B j}}^{-}$) providing the basis of the spaces of common eigenfunctions of $\not k_{j}$ and $\psi_{j}$ with $j \neq i$.

## 4. Supersymmetry generator and supersymmetric invariant amplitudes

The supersymmetry generator can be realized as a differential operator in superspace with 11D Majorana spinor fermionic coordinate $\theta \underline{\underline{\alpha}}$ as well as in the real analytic superspace with 16 component Majorana spinor

## 5. Polarized scattering equation and spinor moving frame formulation of ambitwistor superstring in $\mathrm{D}=11$

The Green-Schwarz (or Brink-Schwarz) formulation of the ambitwistor superstring action is reached by considering the Brink - Schwarz superparticle Lagrangian, allowing in it all the fields to be dependent on two worldsheet coordinates, replacing the proper time derivatives $d / d \tau$ with holomorphic partial derivatives $\bar{\partial}$, and integrating it over the two dimensional worldsheet [ $[\overline{4} \overline{5} \bar{j}]$. This gauge is not preserved by supersymmetry transformations (50) along so that to reach the simple transformation of supertwistor $(5 \cdot 10)$ and to preserve the gauge ( 5 supplement $\left(\overline{5} \cdot 10^{2}\right)$ by the gauge transformations of the supertwistor $(\overline{5}-16 i)$.

Of course, the fields $\lambda_{\underline{\alpha} \underline{q}}(\sigma)$ are constrained by algebraic relation which follows from their expression in terms of spinor moving frame variables ( $\left.\overline{5} \cdot \overline{6}_{1}\right)$ (these are actually collected in ( $\overline{3} \cdot \overline{6}$ ), see footnote $\overline{\underline{T}} \overline{\underline{T}})$. However, the fact that $\mu \underline{\underline{q}}(\sigma)$ in the action ( $(\overline{5} \cdot \overline{1} \overline{1} \bar{i})$ can be treated as unconsrained will be very useful in our discussion below.

### 5.2 11D ambitwistor superstring and polarized scattering equation

Besides this, the vertex operator (5. 5 fermionic and spinorial bosonic functions describing the ambitwistor string, $\eta_{\underline{q}}(\sigma)$ and $\mu_{\underline{q}}^{\alpha}(\sigma)$, $\lambda_{\underline{\alpha} \underline{q}}(\sigma)$ (the latter entering $\delta\left(k_{i} \cdot P\left(\sigma_{i}\right)\right)$ where $P_{\mu}(\sigma)$ is assumed to be taken from ( $\left.\overline{\overline{3}} \cdot \overline{6}_{\underline{i}}^{\underline{i}}\right)$, and the scattering data of $i$-th particle. These latter are described by $\lambda_{\underline{\alpha} A i}$, which defines $k_{i}$ through $\left(\overline{2}-\overline{2} 1_{i}\right)$ and polarization vector through (2.2i) , fermionic $\eta_{A i}=\sqrt{\rho_{i}^{\#}} \eta_{A i}^{-}$and bosonic matrix function $W_{\underline{q} i}^{A}(\sigma)$.

Despite of the entrance of this latter into the set of scattering data, we consider it as a function of $\sigma_{i}$ to do not break explicitly the local $S O(16)$ symmetry characteristic for the ambitwistor superstring action $\left(\overline{5}^{-1} \overline{1}_{i}\right)$. On the other hand, the entrance of $W_{\underline{q} i}^{A}\left(\sigma_{i}\right)$ into the set of scattering data suggests its identification with a constant matrices $W_{q i}^{A}$ up to the universal ( $i$-independent) local $S O(16)$ transformations, as described by ( 3.16 . $)$. Furthermore, it also suggests the identification ( $\left.\overline{3} . \overline{2} \overline{2}_{i}^{\prime}\right)$ of the constant matrices $W_{q i}^{A}$ in ( $\left.3 . \overline{1} \overline{6}\right)$ with the internal frame matrix variable ( $\left.\overline{2} \cdot \overline{1} \overline{4}\right)$

This is to say, the main contribution to the path integral will come from the extrema of the action with the source terms coming from vertex operator. The essential for our purposes part of such an effective action reads

The first of two equations which we have obtained from the ambitwistor superstring action, Eq. ( $5 . \overline{3} 3)$, coincides with the $S O(16)$ covariant ansatz ( 3.10$)$ for the solution of the polarized scattering equation ( 3.19 ) which generalizes the ansatz of [20 provides the fermionic superpartner of (5.53).

Thus, interestingly enough, in the ambitwistor superstring approach the meromorphic spinor function ( 5.312 to search also for the fermionic superpartner of the polarized scattering equation. Just formally, the structure of the bosonic polarized scattering equation considered together with the knowledge on the origin of the complex fermionic variables $\eta_{A}=\eta_{q} \bar{w}_{q A}=\theta^{\alpha} \lambda_{\alpha q} \bar{w}_{q A}$ (see [ $\left[\overline{2} \overline{6}_{i}\right]$ ) suggests to propose on this rôle

Thus we have found the superpartner of the polarized scattering equation (3.18) which happens to be an equation imposed on the supergravity amplitude, Eq. (6. $\left.\mathbf{6}^{-1} \mathbf{4}^{\prime}\right)$.

## 7. Spinor helicity formalism, polarized scattering equations and ambitwistor superstring in $D=10$

In this section we will describe the spinor frame approach to 10D polarized scattering equation and its ambitwistor superstring origin. The similarity with 11D case will allow us to be brief; we will especially notice the stages where the differences between 10D and 11D cases appear.

### 7.1 Spinor frame approach to 10D spinor helicity formalism I. Real helicity spinors

Ten dimensional Lorentz harmonics $v_{\alpha \dot{q}}^{+}, v_{\alpha q}^{-}$were introduced in [ $[\overline{6} \overline{2}, \underline{6} \overline{6} \overline{3}]$ and used to construct the spinor moving frame formulation of 10D Green-Schwarz superstring in [6] approach in [ $6 \overline{5} \overline{5}]$ (see [ $[6 \overline{6} \overline{6}]$ for a nice review). They are rectangular $16 \times 8$ blocks of the $16 \times 16$ spinor frame matrix

carrying different $S O(1,1)$ weights $( \pm)$ and the indices of different (c- and s-spinor) representations of the $S O(8)$ subgroup, $\dot{q}=1, \ldots, 8$ and $q=1, \ldots, 8$. They also carry the Majorana-Weyl spinor index $\alpha=1, \ldots, 16$ of the 10D Lorentz group.

As there is no charge conjugation matrix in 10D Majorana-Weyl spinor representation, there is no Lorentz covariant manner to rise and to lower $\operatorname{Spin}(1,9)$ indices. The position of spinor index of a field carries the physical information on its chirality. In our case this fact implies that
it is impossible to construct (in a Lorentz covariant manner) the elements of the inverse of the spinor moving frame matrix

which are tantamount to $V_{(\beta)}{ }^{\gamma} V_{\gamma}^{(\alpha)}=\delta_{(\beta)}^{(\alpha)}$. The equation $V_{\alpha}^{(\beta)} V_{(\beta)}^{\gamma}:=v_{\alpha \dot{q}}^{-} v_{\dot{q}}^{+\gamma}+v_{q}^{-\alpha} v_{q}^{-\gamma}=\delta_{\alpha}^{\gamma}$ is also valid as a consequence of (

Both the spinor frame and inverse spinor frame variables (spinor harmonics) can be considered as square roots of the same vector frame variables (vector harmonics) defined as elements of the $S O(1,9)$ valued matrix

In particular both $v_{\alpha q}{ }^{-}$and $v_{\dot{q}}^{-\alpha}$ can be considered as square roots of the same light-like vector $u_{\mu}^{=}$of the associated vector frame in the sense of

Here $\sigma_{\alpha \beta}^{a}$ and $\tilde{\sigma}^{a \alpha \beta}$ are 10D generalized Pauli matrices which obey

Relations $\left(\overline{7}-\overline{7}^{-}\right)$and $\left(\overline{7}-\overline{7}^{-}\right)$also contain all the essential constraints obeyed by the spinor frame variables with negative $S O(1,1)$ weight, $v_{\alpha q}{ }^{-}$and $v_{\dot{q}}^{-\alpha}$. More details on 10D spinor frame vari-

Adapting the vector frame to the light-like momentum $k_{\mu}$ by orienting in its direction one of the light-like vectors of the frame, say $u_{\mu}^{=}$,

### 7.2 Spinor frame approach to 10D spinor helicity formalism II. Internal frame and complex helicity spinors

The state of a scattered vector particle can be characterized by the momentum and a complex polarization vector $U_{\mu i}$ which obeys

The coefficient $U_{i}^{I}$ is a complex null $S O(8)$ vector the presence of which breaks little group of the $\mathrm{D}=10$ massless particle $S O(8)$ down to tiny group $S U(4)$ (more precisely, to $S O(2) \otimes S O(6)=$ $U(1) \otimes S U(4)$; see $[2 \overline{2} \overline{0}]$ and $\left[\begin{array}{ll}{[2 \overline{7}}\end{array}\right]$ for more discussion). This null vector can be considered as a part of internal $S O(8)$ vector frame and factorized as follows

which encode more explicitly the information about polarization of massless 10D particles.
These complex spinors solve the left- and right-chiral versions of the Dirac-Weyl equation

Thus $\lambda_{\alpha A i}$ provide a basis of common zero modes of $\tilde{\not}_{i}^{\alpha \beta}$ and $\tilde{\varphi}_{i}^{\alpha \beta}$ matrices while $\bar{\lambda}_{\beta i}^{A}$ is the basis of complementary to the above space in the space of solutions of left-chiral Dirac equation. In the case of $\psi_{\alpha \beta i}$ and $\psi_{\alpha \beta i}$ matrices the same roles are played by $\bar{\lambda}_{i}^{\alpha A}$ and $\lambda_{A i}^{\alpha}$, respectively.

From ( 7010$)$ ) and $(7 \overline{1} 1$ different chirality in terms of complex helicity spinors

These indicate, in particular, that both the left chiral and right chiral complex helicity spinors are pure spinors (which are further constrained by a number of orthogonality and normalization conditions).

### 7.3 10D polarized scattering equation

The polarized scattering equations in $\mathrm{D}=10$ is also doubled. The equations imposed on left-chiral and right-chiral helicity spinors corresponding to the scattered particles read

We restrain ourselves from fixing rigidly such an identification at the present stage of the development of the formalism keeping in mind the identification ( $\overline{7} \cdot \overline{0})$ but keeping the notation of $W_{q i}^{A}$ and $W_{\dot{q} i}^{A}$ in the equations below.

Eqs. $(\overline{7} \cdot \overline{2} \overline{7})$ and $(\overline{7} \cdot \overline{2})$ are the counterparts of the 11D polarized scattering equations in the form of (3.18). To find the 10D counterpart of the polarized scattering equation in the form of Eq. (3.19) we have to introduce two sets of constrained spinorial functions, $\lambda_{\alpha q}(\sigma)$ and $\lambda_{\dot{q}}^{\alpha}(\sigma)$, which obey

where $P_{\mu}(\sigma)$ is the meromorphic 10 -vector function (3). One can check that the above constraints are satisfied if:
i) the spinor functions are meromorphic functions of the form

with $S O(8)$ valued matrices $\tilde{\mathcal{O}}_{p q}(\sigma)$ and $\tilde{\mathcal{O}}_{p q}(\sigma)$,

ii) the polarized scattering equations $(\overline{7} \cdot \overline{2} \overline{7})$ and $(\overline{7} \cdot \overline{2} \overline{8})$ hold,
iii) $W_{p i}^{A}$ and $W_{\dot{q} i}{ }^{A}$ obey $(\overline{7} \cdot \overline{2} \overline{9})$; this is automatic when $(\overline{7} \cdot \overline{3} \overline{0})$ holds.

In terms of the meromorphic functions $(7,3)$ and $(7,3 i)$ the polrized scattering equations $(17.27)$ and $(7,-8)$ can be written in the form of

Some comments are in order. First of all, $(7,29)$ and $(7,05)$ imply

Secondly, the constraints $(\overline{7} \cdot \overline{3})$ and $(7 \overline{3} \overline{2})$ can be solved by expressing the spinor fields in terms of spinor moving frame field and compensator field $\rho^{\#}(\sigma)$ by

This is the place to stress that, according to ( $\overline{7} \cdot \overline{3} \overline{3})$ and $(\overline{7} \cdot \overline{3} \overline{4}), \lambda_{\alpha q}(\sigma)$ and $\lambda_{\dot{q}}^{\alpha}(\sigma)$ are complex so that $v_{\alpha q}^{-}(\sigma), v_{\dot{q}}^{\alpha-}(\sigma)$ and $\rho^{\#}(\sigma)$ should be considered as complexifications of the spinor moving frame variables and densities used e.g. in discussion on such a complexification in 11D context.

Notice that $(\overline{3})$, the 11 D counterpart of $(\overline{0} \cdot \overline{0})$, contains an additional $S O(16)$ matrix. Absence of the counterpart of this in $(\overline{7}=\overline{4})$ is explained by the fact that, if included, this should be $S O(8)$ valued matrix and the spinor frame variables which differ by $S O(8)$ gauge transformations are considered to be identical (see [ $6 \overline{6} 2, \overline{6} \overline{6} \overline{3}]$ and $[\overline{2} \overline{2}, \overline{2} \overline{2}]$ harmonics are identified modulo $S O(9)$ gauge symmetry while ( $\overline{3} \cdot \overline{6}$ ) is invariant under a bigger $S O(16)$ group so that $S O(16)$ matrix enters naturally the general solution of $(\overline{3}, 6)$.

### 7.4 10D ambitwistor superstring and polarized scattering equation

The spinor moving frame or twistor-like formulation of the simplest $\mathcal{N}=110 \mathrm{D}$ ambitwistor superstring, suitable for the description of 10D SYM and $\mathcal{N}=1 D=10$ supergravity amplitudes, can be based on the action quite similar to its 11D counterpart (15) [4]

It is written in terms of constrained bosonic spinor functions obeying ( $\overline{7} \overline{1}$ ), 16-component fermionic spinor field $\theta^{\alpha}(\sigma)$ and arbitrary symmetric spin tensor bosonic field

 spinor moving frame nature of this twistor-like formulation of the 10D ambitwistor superstring.

Again, the properties of the spinor moving frame and spinorial functions ( $\left(\overline{7} \cdot \overline{4} 0_{1}^{\prime}\right)$, which are concenrated in $(\overline{7} 31)$ and $(\overline{7} \cdot \overline{2})$, guarantee that the arbitrary variation of $Z^{\mu_{1} \ldots \mu_{5}}(\sigma)$ live the action invariant. The gauge fixing condition for this local symmetry can be chosen to be $Z^{\mu_{1} \ldots \mu_{5}}(\sigma)=0$ so that

However, for our purposes it is more convenient to treat the 10D ambitwistor superstring as a dynamical system in the enlarged superspace $\Sigma^{(136 \mid 32)}$ with $10+126=136$ bosonic coordinates ( $X^{\mu}, Z^{\mu_{1} \ldots \mu_{5}}$ ) and 16 fermionic coordinates $\theta^{\alpha}$.

The constrained twistor form of the 10D ambitwistor superstring action and 10D generalization of the Penrose incidence relations look quite similar to their 11D counterparts $\left(\overline{5} \cdot \overline{5} \overline{5}_{1}\right)-\left(\overline{5} \cdot \overline{5}_{1}^{\prime}\right)$ :

 in 10D equation ( in 10D, this should be $S O(8)$ valued matrix and $S O(8)$ is the fundamental gauge symmetry of the 10D spinor moving frame construction.

Eqs. $(\overline{7} \cdot \overline{4} \overline{6})$ and $(\overline{7}-\overline{4} \overline{4} \overline{4})$ describe the general solution of 28 constraints

The action $(\bar{T}=\overline{-1} \overline{4})$ is invariant under the gauge symmetry

with arbitrary $\delta Z^{\nu_{1} \ldots \nu_{5}}(\sigma)$, which allows for the gauge fixing conditions reducing the general solution (7.7 $\overline{4} \overline{6})$ of the constraints to

But for our purposes it is more convenient to do not fix this gauge symmetry. Then the only constraint restricting $\mu_{q}^{\alpha}(\sigma)$ is $\left(\overline{7}-\overline{7}_{1}^{\prime}\right)$. Similarly to 11D case, we can included this in the action with the Lagrange multiplier $\overline{\mathcal{A}}^{p q}=\overline{\mathcal{A}}^{[p q]}$ playing the role of $S O(8)$ gauge field,

Supersymmetry transformations leaving invariant the actions $(7,7)$ and $(7,51)$ are

What is specific for 10D is the problem of how to obtain the corresponding equation for $\lambda_{\dot{q}}^{\alpha}(\sigma)$ which do not enter (explicitly) the ambitwistor superstring action,

Although it is intuitively clear that this should be the case due to that $\lambda_{\dot{q}}^{\alpha}(\sigma)$ and $\lambda_{\alpha q}(\sigma)$ are different forms of the square root of the meromorphic ten-vector function ( $\overline{3} \cdot 2,2)$ (in the sense of constraints $([\overline{3} \overline{3})$ and $(7, \overline{3}))$ the understanding of the spinor moving frame nature of both the spinorial functions and helicity spinors helps to provide a more explicit arguments in favour of this. To this end, besides the generic statement that $\lambda_{\dot{q}}^{\alpha}(\sigma)$ and $\lambda_{\alpha q}(\sigma)$ represent the same element of the coset space $\frac{S O(1,9)}{S O(8)}$ isomorphic to $\mathbb{S}^{8} \otimes \mathbb{R}_{+}$, one can use the fact that thier derivatives are expressed in terms of the same Cartan forms (see Appendix '". '2.') or a special parametrization of spinor frame variables found in $[\overline{2} \overline{2}]$ in which $\lambda_{\dot{q}}^{\alpha}(\sigma)$ and $\lambda_{\alpha q}(\sigma)$, as well as $P_{\mu}(\sigma)$, are expressed in terms of the same parameter functions $\mathbb{K}^{=I}(\sigma)$ and $\rho^{\#}(\sigma)$ (see Eqs. (7.42)-(7.50) in [ $\left.{ }_{2}^{2} \overline{1} \bar{\eta}_{1}\right)$. Then $(\overline{7}-54)$ and $(7,-5 \cdot \overline{5})$ provide equivalent expressions for these parameter functions.

### 7.5 10D supersymmetry generator and supersymmetric invariants

From $(\overline{7} \cdot 53)$ it is easy to restore the form of the $\mathcal{N}=1$ supersymmetry generator $Q_{\alpha}$ which obeys the superalgebra $\left\{Q_{\alpha}, Q_{\beta}\right\}=4 \lambda_{\alpha q} \lambda_{\beta q}=8 \lambda_{(\alpha \mid A} \lambda_{\mid \beta)}^{A}$. Its realization on the variables of $i$-th of scattered particles reads

The complete supersymmetry generator given by the sum of the partial generators

is nilpotent, $\left\{Q_{\alpha}, Q_{\beta}\right\}=0$, due to the momentum conservation.
The supersymmetric invariant found in [20 $[2 \overline{2}]$ is $e^{\mathbb{F}}$ with

The superamplitudes of 10D SYM are then essentially described by Eqs. (4.10) where the reduced determinant $d e t^{\prime}$ is replaced by reduced Pfafian $P f^{\prime}$ and all the variables are considered to be ten dimensional.

The generalizations of supersymmetric invariants to type II cases is straightforward [ $\overline{2} \overline{2} \bar{d}]$. As far as the derivation of the basic equation for spinorial function is concerned, the generalization of our discussion in sec. $\overline{7}=4$ is straightforward for IIB case while type IIA case seems to be problematic. The issue can be seen from the Lagrangian 1-form associated to the 10D type IIA ambitwistor superstring action,

with $X^{\alpha \beta}=\frac{1}{16} X^{\mu} \tilde{\sigma}_{\mu}^{\alpha \beta}$. It is gauge equivalent to a Lagrangian form in an enlarged superspace with $10+126$ bosonic coordinates described by an arbitrary symmetric spin-tensor $X^{\alpha \beta}=X^{\beta \alpha}$. However, supersymmetry transformations living invariant such a generalization of the Lagrangian form,

are quite asymmetric and it is not clear whether it is possible to introduce a convenient supertwistor variables providing the basis of (constrained) Darboux coordinates for this Lagrangian form. Thus it seems that in type IIA case the shortcut through the enlarged superspace does not work and to obtain equation for the bosonic spinor functions one has to deal with the action containing supertwistor variables restricted by additional constraints similar to ( 5

## 8. Conclusion and discussion

In this paper we have revisited the formalism of the 11D polarized scattering equations of [20 from the point of view of spinor frame approach different applications of which to the description
 the problem of rigorous derivation of the equations for spinorial meromorphic function $\lambda_{\underline{\alpha} \underline{q}}(\sigma)$ and its fermionic superpartner $\eta_{\underline{q}}(\sigma)$ from the (spinor moving frame formulation) of 11 D ambitwistor superstring [ $4 \overline{4} \overline{5}]$. We have shown that, to this end, the (gauge equivalent) formulation of ambitwistor superstring as dynamical system in an enlarged 11D superspace $\Sigma^{(528 \mid 32)}$ with additional tensor central charge coordinates is very useful.

The polarized scattering equation can be written in two equivalent forms: as Eq. $\left(\overline{3} \cdot \overline{1}-19_{1}\right)$ for the spinor function on the Riemann sphere, and as Eq. (3.18) imposed on the scattering data. We have found the fermionic superpartner of the polarized scattering equation (3.18). We call this spolarized scattering equation. It happens to be an equation imposed on the supergravity


We have also revised the 10D polarized scattering equation formalism and its 10D ambitwistor superstring origin with the use of spinor frame method. In this case a counterpart of hidden $S O(16)$ symmetry of the 11 D ambitwistor superstring does not appear, being replaced by $S O(8)$ symmetry characteristic for the spinor frame formalism. However, similarly to 11D case, the treatment of the ambitwistor superstring as a dynamical system in 10D superspace enlarged
by 126 directions parametrized by tensorial central charge coordinates is also useful to obtain the basic equations for the spinor functions.

An interesting direction for future study is to apply the spinor frame approach to the construction of 11D and 10D generalization of the 6D rational map and symplectic Grassmannians approach [1] was discussed in very recent [īn

The rational maps approach introduces a scattering map

Clearly $\mathcal{P}_{\underline{\mu}}(\sigma)=P_{\underline{\mu}}(\sigma) \prod_{j=1}^{n}(\sigma-$ $\left.\sigma_{j}\right)$ and the scattering equation can be also obtained from the light-likeness condition of the scattering map

Extrapolating the 6 d results of $\left[\overline{7} \overline{2}, \overline{7} \overline{7}_{2}\right.$ one might expect that in 11D spacetime this can be solved in a manner similar to ( $\left.\overline{3}^{3} . \bar{B}_{1}^{\prime}\right)$,

Of course, in distinction to 6 d and 4 d cases, the 11D equations ( parts) impose strong constraints on $\rho_{\underline{\alpha} \underline{q}}(\sigma)$ so that their consistency with ( We leave this problem for future work and conclude here by observation that, if this consistency holds, the relation between coefficients of the rational maps and the helicity spinors, encoding

The components of that supertwistor are an unconstrained 16 -component bosonic spinor $\lambda^{\alpha}$, canonically conjugate to it 16 -component bosonic spinor $w_{\alpha}$, and fermionic 10 -vector $\psi^{\mu}$. Thus, on one hand, the fermionic variables of this alternative supertwistor formulation of the ambitwistor string are RNS-like and, on the other hand, it uses essentially the representation of a light-like vector function as a bilinear of single unconstrained bosonic spinor, $P_{\mu}(\sigma)=\lambda^{\alpha}(\sigma) \sigma_{\mu \alpha \beta} \lambda^{\beta}(\sigma)$. This is valid due to the specific identity for $\mathrm{D}=10 \sigma$-matrices (having its counterparts also in $D=3,4,6$ ) and, in distinction to our spinor moving frame related constrained supertwistor approach, do not allow for a straightforward generalization to 11D case.

The above equations can be used also for the case of $D=11$ spinor frame variables (spinor harmonics) if we assume that $I, J=1, \ldots, 9, p, q=1, \ldots, 16$, identify $\dot{q}$ with $q$ and replace the $\mathrm{SO}(8)$ Klebsh-Gordan coefficients $\gamma_{p \dot{q}}^{I}$ by $16 \times 16$ nine dimensional gamma matrices $\gamma_{p q}^{I}=\gamma_{q p}^{I}$.
