# TOTAL POSITIVITY IN SPRINGER FIBRES

## 1. The totally positive part of $\mathcal{B}_{u}$

1.1. Let $G$ be a reductive connected algebraic group over $\mathbf{C}$ and let $\mathcal{B}$ be the variety of Borel subgroups of $G$. For $g \in G$ the Springer fibre at $g$ is the subvariety $\mathcal{B}_{g}=\{B \in \mathcal{B} ; g \in B\}$ of $\mathcal{B}$. The Springer fibres can be quite complicated; they play an important role in representation theory (for example in character formulas for finite reductive groups over a finite field). In this paper we assume that a pinning of $G$ is given so that the totally positive part $G_{\geq 0}$ of $G$ and the totally positive part $\mathcal{B}_{\geq 0}$ of $\mathcal{B}$ are defined (see [L94, 2.2, 8.1]). Recall that $G_{\geq 0}$ is a submonoid and a closed subset of $G$ and $\mathcal{B}_{\geq 0}$ is a closed subset of $\mathcal{B}$ on which $G_{\geq 0}$ acts. We are interested in the interaction of the theory of total positivity with that of Springer fibres. More precisely, for any $g \in G_{\geq 0}$ we consider the closed subset $\mathcal{B}_{g, \geq 0}=\mathcal{B}_{g} \cap \mathcal{B}_{\geq 0}$ of $\mathcal{B}_{g}$, which we call the totally positive part of the Springer fibre $\mathcal{B}_{g}$. Let $\mathcal{U}$ be the variety of unipotent elements of $G$ and let $\mathcal{U} \geq 0=\mathcal{U} \cap G_{\geq 0}$. Our main result is that if $g \in \mathcal{U}_{\geq 0}, \mathcal{B}_{g, \geq 0}$ has a surprisingly simple structure, much simpler than that of $\mathcal{B}_{g}$ itself (see Cor. 1.16); namely it has a canonical cell decomposition which is part of the canonical cell decomposition of $\mathcal{B}_{\geq 0}$. By a similar argument we show that an analogous result holds for the fixed point set of $g$ on a partial flag manifold intersected with the totally positive part [L98] of that partial flag manifold (see 3.9). In $\S 4$ we state a conjecture (see 4.4) on the compatibility of two ways to define a positive structure on the cells of $\mathcal{B}_{\geq 0}$ and give some of its consequences; this conjecture extends a result of [L97, §3] which concerns the open dense cell $\mathcal{B}_{>0}$ of $\mathcal{B}_{\geq 0}$ defined in [L94, 8.8]. Let $G_{>0}$ the open dense sub-semigroup of $G_{\geq 0}$ defined in [L94]. In [L94, 8.9(c)], a map $g \mapsto B_{g}$ from

[^0]$G_{>0}$ to $\mathcal{B}_{>0}$ was defined. In $\S 5$ we give a definition of this map which is simpler than that in [L94] and we define an extension of this map to a map from $G_{\geq 0}$ to the set of parabolic subgrups of $G$. As a result we obtain a new definition of $\mathcal{B}_{>0}$.

We shall always assume that $G$ is simply laced; the non-simply laced case can be reduced to the simply laced case by descent.
1.2. Recall that we have fixed a pinning of $G$. Thus we are given a maximal torus $T$ of $G$ and a pair $B^{+}, B^{-}$of opposed Borel subgroups of $G$ containing $T$ with unipotent radicals $U^{+}, U^{-}$. The pinning also includes root homomorphisms $x_{i}: \mathbf{C} \rightarrow U^{+}, y_{i}: \mathbf{C} \rightarrow U^{-}$indexed by a finite set $I$ (corresponding to simple roots). Let $N T$ be the normalizer of $T$ in $G$ and let $W$ be the Weyl group. For $i \in I$ we set $\dot{s}_{i}=y_{i}(1) x_{i}(-1) y_{i}(1) \in N T$; let $s_{i}$ be the image of $\dot{s}_{i}$ in $W$. Now $W$ is a Coxeter group with simple reflections $\left\{s_{i} ; i \in I\right\}$; let $w \mapsto|w|$ be the standard length function. Let $w_{I}$ be the unique element of maximal length of $W$. More generally, for any $H \subset I$ we denote by $w_{H}$ the longest element in the subgroup $W_{H}$ of $W$ generated by $\left\{s_{i} ; i \in H\right\}$.

Let $\leq$ be the standard partial order on $W$. For $w \in W$ let $\mathcal{I}_{w}$ be the set of sequences $\left(i_{1}, i_{2}, \ldots, i_{m}\right)$ in $I$ such that $w=s_{i_{1}} s_{i_{2}} \ldots s_{i_{m}}, m=|w|$; let $\operatorname{supp}(w)$ be the set of all $i \in I$ which appear in some (or equivalently any) $\left(i_{1}, i_{2}, \ldots, i_{m}\right) \in \mathcal{I}_{w}$. For $w \in W$ we set $\dot{w}=\dot{s}_{i_{1}} \dot{s}_{i_{2}} \ldots \dot{s}_{i_{m}} \in N T$ where $\left(i_{1}, i_{2}, \ldots, i_{m}\right) \in \mathcal{I}_{w}$; this is known to be well defined.

For $B, B^{\prime}$ in $\mathcal{B}$ there is a unique $w \in W$ denoted by $\operatorname{pos}\left(B, B^{\prime}\right)$ such that for some $g \in G$ we have $g B g^{-1}=B^{+}, g B^{\prime} g^{-1}=\dot{w} B^{+} \dot{w}^{-1}$. There is a unique isomorphism $\phi: G \xrightarrow{\sim} G$ such that $\phi\left(x_{i}(a)\right)=y_{i}(a), \phi\left(y_{i}(a)\right)=x_{i}(a)$ for all $i \in I, a \in \mathbf{C}$ and $\phi(t)=t^{-1}$ for all $t \in T$. This carries Borel subgroups to Borel subgroups hence induces an isomorphism $\phi: \mathcal{B} \rightarrow \mathcal{B}$ such that $\phi\left(B^{+}\right)=B^{-}, \phi\left(B^{-}\right)=B^{+}$. For $i \in I$ we have $\phi\left(\dot{s}_{i}\right)=x_{i}(1) y_{i}(-1) x_{i}(1)=\dot{s}_{i}^{-1}$. Hence $\phi$ induces the identity map on $W$. We show:
(a) Let $B, B^{\prime}$ in $\mathcal{B}$ be such that $\operatorname{pos}\left(B, B^{\prime}\right)=w$. Then $\operatorname{pos}\left(\phi(B), \phi\left(B^{\prime}\right)\right)=$ $w_{I} w w_{I}$.
Assume first that for some $i \in I$ we have $B=B^{+}, B^{\prime}=\dot{s}_{i} B^{+} \dot{s}_{i}^{-1}$ so that $\operatorname{pos}\left(B, B^{\prime}\right)=s_{i}$. We have

\begin{aligned}
& \operatorname{pos}\left(\phi(B), \phi\left(B^{\prime}\right)\right)=\operatorname{pos}\left(B^{-}, \dot{s}_{i}^{-1} B^{-} \dot{s}_{i}\right)=\operatorname{pos}\left(\dot{w}_{I} B^{+} \dot{w}_{I}^{-1}, \dot{s}_{i}^{-1} \dot{w}_{I} B^{+} \dot{w}_{I}^{-1} \dot{s}_{i}\right) \\
& =\operatorname{pos}\left(B^{+}, \dot{w}_{I}^{-1} \dot{s}_{i}^{-1} \dot{w}_{I} B^{+} \dot{w}_{I}^{-1} \dot{s}_{i} \dot{w}_{I}\right)=w_{I} s_{i} w_{I}
\end{aligned}
$$

It follows that (a) holds when $w=s_{i}$ for some $i \in I$. The general case can be easily reduced to this special case. This proves (a).
1.3. Let $V$ be an irreducible rational $G$-module over $\mathbf{C}$ with a given highest weight vector $\eta$. Let $\beta$ be the basis of $V$ (containing $\eta$ ) obtained by specializing at $v=1$ the canonical basis [L90] of the corresponding module over the corresponding quantized enveloping algebra. For any $B \in \mathcal{B}$ let $L_{B}$ be the unique $B$-stable line in $V$. We can assume that $V$ is such that $B \mapsto L_{B}$ is a bijection
(a) $\mathcal{B} \xrightarrow{\sim} \mathcal{X}$
onto a subset $\mathcal{X}$ of the set of lines in $V$. Let
(b) $V_{+}=\sum_{b \in \beta} \mathbf{R}_{\geq 0} b \subset V$.

If $\xi_{1} \in V_{+}, \xi_{2} \in V_{+}$then $\xi_{1}+\xi_{2} \in V_{+}$; moreover,
(c) if $\xi_{1}+\xi_{2}=0$, then $\xi_{1}=\xi_{2}=0$.
1.4. Following [KL], for any $v, w$ in $W$ we set $\mathcal{B}_{v, w}=\left\{B \in B ; \operatorname{pos}\left(B^{+}, B\right)=\right.$ $\left.w, \operatorname{pos}\left(B^{-}, B\right)=w_{I} v\right\}$. It is known that $\mathcal{B}_{v, w} \neq \emptyset$ if and only if $v \leq w$. The subvarieties $\mathcal{B}_{v, w}$ with $v \leq w$ form a partition of $\mathcal{B}$. For $v \leq w$ in $W$ we have $w w_{I} \leq v w_{I}$; moreover,
(a) $\phi$ defines an isomorphism $\mathcal{B}_{w w_{I}, v w_{I}} \xrightarrow{\sim} \mathcal{B}_{v, w}$.

We use that for $B \in \mathcal{B}$ we have:
$\operatorname{pos}\left(B^{+}, B\right)=v w_{I} \Longrightarrow \operatorname{pos}\left(B^{-}, \phi(B)\right)=w_{I} v ; \operatorname{pos}\left(B^{-}, B\right)=w_{I} w w_{I} \quad \Longrightarrow$ $\operatorname{pos}\left(B^{+}, \phi(B)\right)=w$.
1.5. As in [L94] let $G_{\geq 0}$ be the submonoid of $G$ generated by $\left\{x_{i}(a) ; i \in I, a \in\right.$ $\left.\mathbf{R}_{\geq 0}\right\}$, $\left\{y_{i}(a) ; i \in I, a \in \mathbf{R}_{\geq 0}\right\}$ and by $\chi(a)$ for various algebraic group homomorphisms $\chi: \mathbf{C}^{*} \rightarrow T$ and various $a \in \mathbf{R}_{>0}$; this is a closed subset of $G$. We have
(a) $\phi\left(G_{\geq 0}\right)=G_{\geq 0}$.

By [L94, 3.2] we have in the setup of 1.3:
(b) $G_{\geq 0} V_{+} \subset V_{+}$.

From [L94, 8.7] it follows that
(c) $\phi\left(\mathcal{B}_{\geq 0}\right)=\mathcal{B}_{\geq 0}$.

Let $\mathcal{X}_{\geq 0}$ be the set of lines in $\mathcal{X}$ which meet $V_{+}-\{0\}$. From [L94, 8.17] we have that:
(d) under the bijection $1.3(a), \mathcal{B}_{\geq 0}$ corresponds to $\mathcal{X}_{\geq 0}$.

Using (b),(d) we deduce
(e) $g \in G_{\geq 0}, B \in \mathcal{B}_{\geq 0} \Longrightarrow g B g^{-1} \in \mathcal{B}_{\geq 0}$.
(This also follows from [L94, 8.12].)
1.6. Recall that $\mathcal{U}_{\geq 0}=\mathcal{U} \cap G_{\geq 0}$ and that for $u \in \mathcal{U}_{\geq 0}$ we have $\mathcal{B}_{u, \geq 0}=\mathcal{B}_{u} \cap \mathcal{B}_{\geq 0}$. Let $V, V_{+}$be as in 1.3. For $u \in \mathcal{U}_{\geq 0}$ let $V_{+}^{u}=\left\{\xi \in V_{+} ; u \xi=\xi\right\}$. In particular $V_{+}^{x_{i}(a)}, V_{+}^{y_{i}(a)}$ are defined for $i \in I, a \in \mathbf{R}_{>0}$. We show:
(a) Let $u, u^{\prime}, u^{\prime \prime}$ in $\mathcal{U}_{\geq 0}$ be such that $u=u^{\prime} u^{\prime \prime}$. We have $V_{+}^{u}=V_{+}^{u^{\prime}} \cap V_{+}^{u^{\prime \prime}}$.

Let $\xi \in V_{+}^{u^{\prime}} \cap V_{+}^{u^{\prime \prime}}$. Then $u \xi=u^{\prime}\left(u^{\prime \prime} \xi\right)=u^{\prime} \xi=\xi$ hence $\xi \in V_{+}^{u}$. Conversely, let $\xi \in V_{+}^{u}$. By [L94, 6.2, 3.2] for any $b \in \beta$ we have $u^{\prime} b-b \in V_{+}, u^{\prime \prime} b-b \in V_{+}$. Hence for any $\xi^{\prime}, \xi^{\prime \prime}$ in $V_{+}$we have $u^{\prime} \xi^{\prime}-\xi^{\prime} \in V_{+}, u^{\prime \prime} \xi^{\prime \prime}-\xi^{\prime \prime} \in V_{+}$. Thus $u^{\prime \prime} \xi=\xi+\xi^{\prime}$ where $\xi^{\prime} \in V_{+}$so that $\xi=u \xi=u^{\prime}\left(u^{\prime \prime} \xi\right)=u^{\prime}\left(\xi+\xi^{\prime}\right)$. We have $u^{\prime} \xi=\xi+\xi_{1}^{\prime}, u^{\prime} \xi^{\prime}=\xi^{\prime}+\xi_{2}^{\prime}$ where $\xi_{1}^{\prime} \in V_{+}, \xi_{2}^{\prime} \in V_{+}$. Thus $\xi=\xi+\xi_{1}^{\prime}+\xi^{\prime}+\xi_{2}^{\prime}$ so that $\xi_{1}^{\prime}+\xi^{\prime}+\xi_{2}^{\prime}=0$; using $1.3(\mathrm{c})$ we see that $\xi_{1}^{\prime}=\xi^{\prime}=\xi_{2}^{\prime}=0$. Thus we have $u^{\prime \prime} \xi=\xi, u^{\prime} \xi=\xi$ and $\xi \in V_{+}^{u^{\prime}} \cap V_{+}^{u^{\prime \prime}}$. This proves (a).

We show:
(b) Let $i \in I, a \in \mathbf{R}_{>0}$. We have $V_{+}^{x_{i}(a)}=V_{+}^{x_{i}(1)}, V_{+}^{y_{i}(a)}=V_{+}^{y_{i}(1)}$.

Note that $x_{i}(a)=x_{i}(1)^{a}: V \rightarrow V$ and $x_{i}(1)=x_{i}(a)^{1 / a}: V \rightarrow V$. Hence we have $\xi \in V_{+}^{x_{i}(a)}$ if and only if $\xi \in V_{+}^{x_{i}(1)}$. This proves the first equality in (b). The proof of the second equality is entirely similar.

Let $u \in \mathcal{U}_{\geq 0}$. From $1.5(\mathrm{~d})$ we see that under the bijection $1.3(\mathrm{a}), \mathcal{B}_{u, \geq 0}$ corresponds to the set of lines $L$ in $\mathcal{X}_{\geq 0}$ which are $u$-stable. Since $u: V \rightarrow V$ is unipotent, for any such $L, u$ automatically acts on $L$ as identity. Thus we have:
(c) Under the bijection 1.3(a), $\mathcal{B}_{u, \geq 0}$ corresponds to the set of lines in $\mathcal{X}$ which meet $V_{+}^{u}-\{0\}$.
1.7. Following [L94, 8.15] we define a partition $\mathcal{B}_{\geq 0}=\sqcup_{(v, w) \in W \times W ; v \leq w} \mathcal{B}_{\geq 0, v, w}$ by $\mathcal{B}_{\geq 0, v, w}=\mathcal{B}_{v, w} \cap \mathcal{B}_{\geq 0}$. In [L94, 8.15] it was conjectured that for $v \leq w$,
(a) $\mathcal{B}_{\geq 0, v, w}$ is homeomorphic to $\mathbf{R}_{>0}^{|w|-|v|}$.

This conjecture was proved by Rietsch [R98], [R99] and in a more explicit form by Marsh and Rietsch [MR].

For $v \leq w$ let $[v, w]$ be the subset of $\mathcal{X}_{\geq 0}$ corresponding to $\mathcal{B} \geq 0, v, w$ under the bijection $\mathcal{B}_{\geq 0} \leftrightarrow \mathcal{X}_{\geq 0}$ in $1.5(\mathrm{~d})$. We have $\overline{\mathcal{X}}_{\geq 0}=\sqcup_{(v, w) \in W \times W ; v \leq w}[v, w]$.
1.8. Let $v \leq w$ in $W$ and let $\mathbf{i}=\left(i_{1}, i_{2}, \ldots, i_{m}\right) \in \mathcal{I}_{w}$. According to Marsh and Rietsch $[\mathrm{MR}]$, there is a unique sequence $t_{1}, t_{2}, \ldots, t_{m}$ with $t_{k} \in\left\{s_{i_{k}}, 1\right\}$ for $k \in[1, m], t_{1} t_{2} \ldots t_{m}=v$ and such that $t_{1} \leq t_{1} t_{2} \leq \cdots \leq t_{1} t_{2} \ldots t_{m}$ and $t_{1} \leq t_{1} s_{i_{2}}, t_{1} t_{2} \leq t_{1} t_{2} s_{i_{3}}, \ldots, t_{1} t_{2} \ldots t_{m-1} \leq t_{1} t_{2} \ldots t_{m-1} s_{i_{m}}$. Following [MR] we define a subset $\mathcal{Y}_{v, w, \mathbf{i}}$ of $G$ to be the set of products $g_{1} g_{2} \ldots g_{m}$ in $G$ where $g_{k}=\dot{s}_{i_{k}}$ if $t_{k}=s_{i_{k}}$ and $g_{k}=y_{i_{k}}\left(a_{k}\right)$ with $a_{k} \in \mathbf{R}_{>0}$ if $t_{k}=1$; according to [MR], the map $\mathcal{Y}_{v, w, \mathbf{i}} \rightarrow \mathcal{B}, g \mapsto g B^{+} g^{-1}$ is a homeomorphism
(a) $\mathcal{Y}_{v, w, \mathbf{i}} \xrightarrow{\sim} \mathcal{B}_{\geq 0, v, w}$.

Moreover we have a homeomorphism
(b) $\mathcal{Y}_{v, w, \mathbf{i}} \xrightarrow{\sim} \mathbf{R}_{>0}^{|w|-|v|}$
(to $g_{1} g_{2} \ldots g_{m}$ we associate the sequence consisting of the $a_{k}$ with $k$ such that $t_{k}=1$.) In particular, the factors $g_{1}, g_{2}, \ldots, g_{m}$ are uniquely determined by their product $g_{1} g_{2} \ldots g_{m}$. The composition of the inverse of (b) with (a) is a homeomorphism
(c) $\tau_{\mathbf{i}}: \mathbf{R}_{>0}^{|w|-|v|} \xrightarrow{\sim} \mathcal{B}_{\geq 0, v, w}$.
1.9. We preserve the setup of 1.8. Assume that $s_{i_{1}} w \leq w$. We show:
(a) We have $t_{1}=1$ if and only if $v \leq s_{i_{1}} w$.

If $t_{1}=1$ then from $v=t_{1} \ldots t_{m}$ we deduce $v=t_{2} t_{3} \ldots t_{m}$; thus $v$ is equal to a product of a subsequence of $s_{i_{2}}, s_{i_{3}}, \ldots, s_{i_{m}}$ so that $v \leq s_{i_{1}} w$. Conversely, if $v \leq s_{i_{1}} w$ then by the results in 1.8 applied to $v, s_{i_{1}} w$ instead of $v, w$, we can find a sequence $t_{2}^{\prime}, \ldots, t_{m}^{\prime}$ with $t_{k}^{\prime} \in\left\{s_{i_{k}}, 1\right\}$ for $k \in[2, m], t_{2}^{\prime} \ldots t_{m}^{\prime}=v$ and such that $t_{2}^{\prime} \leq t_{2}^{\prime} t_{3}^{\prime} \leq \cdots \leq t_{2}^{\prime} \ldots t_{m}^{\prime}$ and $t_{2}^{\prime} \leq t_{2}^{\prime} s_{i_{3}}, \ldots, t_{2}^{\prime} \ldots t_{m-1}^{\prime} \leq t_{2}^{\prime} \ldots t_{m-1}^{\prime} s_{i_{m}}$. Taking $t_{1}^{\prime}=1$ we have $t_{1}^{\prime} t_{2}^{\prime} \ldots t_{m}^{\prime}=v, t_{1}^{\prime} \leq t_{1}^{\prime} t_{2}^{\prime} \leq \cdots \leq t_{1}^{\prime} t_{2}^{\prime} \ldots t_{m}^{\prime}$ and $t_{1}^{\prime} \leq$ $t_{1}^{\prime} s_{i_{2}}, t_{1}^{\prime} t_{2}^{\prime} \leq t_{1}^{\prime} t_{2}^{\prime} s_{i_{3}}, \ldots, t_{1}^{\prime} t_{2}^{\prime} \ldots t_{m-1}^{\prime} \leq t_{1}^{\prime} t_{2}^{\prime} \ldots t_{m-1}^{\prime} s_{i_{m}}$. By uniqueness we have $\left(t_{1}^{\prime}, t_{2}^{\prime}, \ldots, t_{m}^{\prime}\right)=\left(t_{1}, t_{2}, \ldots, t_{m}\right)$. Thus $t_{1}=1$ and (a) is proved.
1.10. For any $h \in G$ let $[h]: \mathcal{B} \rightarrow \mathcal{B}$ be the map $B \mapsto h B h^{-1}$.

Let $i \in I, a \in \mathbf{R}_{>0}$ and let $v, w$ in $W$ be such that $v \leq w$. We show:
(a) If $v \leq s_{i} w \leq w$, then $\left[y_{i}(a)\right]: \mathcal{B} \rightarrow \mathcal{B}$ restricts to a map $\mathcal{B}_{\geq 0, v, w} \rightarrow \mathcal{B}_{\geq 0, v, w}$ which is fixed point free.
(b) If $s_{i} w \leq w, v \not \leq s_{i} w$, then $\left[y_{i}(a)\right]: \mathcal{B} \rightarrow \mathcal{B}$ restricts to the identity map $\mathcal{B}_{\geq 0, v, w} \rightarrow \mathcal{B}_{\geq 0, v, w}$.
(c) If $w \leq s_{i} w$ then $\left[y_{i}(a)\right]: \mathcal{B} \rightarrow \mathcal{B}$ restricts to a map $\mathcal{B}_{\geq 0, v, w} \rightarrow \mathcal{B}_{\geq 0, v, s_{i} w}$. Assume first that $s_{i} w \leq w$. We can find $\mathbf{i}=\left(i_{1}, i_{2}, \ldots, i_{m}\right) \in \mathcal{I}_{w}$ such that $i_{1}=i$. We use the notation of 1.8 relative to $v, w, \mathbf{i}$.

In case (a) we have $t_{1}=1$, see $1.9(\mathrm{a})$. In this case, left multiplication by $y_{i}(a)$ restricts to a map $\mathcal{Y}_{v, w, \mathbf{i}} \rightarrow \mathcal{Y}_{v, w, \mathbf{i}}$ given by $g_{1} g_{2} \ldots g_{m} \mapsto g_{1}^{\prime} g_{2}^{\prime} \ldots g_{m}^{\prime}$ where $g_{1}=y_{1}\left(a_{1}\right), g_{1}^{\prime}=y_{1}\left(a_{1}+a\right), g_{k}^{\prime}=g_{k}$ for $k>1$. To prove (a), it remains to use that $a_{1} \mapsto a_{1}+a$ from $\mathbf{R}_{>0}$ to $\mathbf{R}_{>0}$ is fixed point free.

In case (b) we have $t_{1}=s_{i}$, see 1.9(a). In this case, for $g_{1} g_{2} \ldots g_{m} \in \mathcal{Y}_{v, w, \mathbf{i}}$ we have $g_{1}=\dot{s}_{i}$ and for some $b \in B^{+}$we have $y_{i}(a) g_{1} g_{2} \ldots g_{m}=y_{i}(a) \dot{s}_{i} g_{2} \ldots g_{m}=$ $\dot{s}_{i} x_{i}(-a) g_{2} \ldots g_{m}=\dot{s}_{i} g_{2} \ldots g_{m} b$ (the last equality follows by an argument in [MR, 11.9]). Hence (b) holds.

Assume that we are in case (c). Let $B \in \mathcal{B}_{\geq 0, v, w}, B^{\prime}=y_{i}(a) B y_{i}(a)^{-1}$. We have $\operatorname{pos}\left(B^{+}, B^{\prime}\right)=\operatorname{pos}\left(y_{i}(a)^{-1} B^{+} y_{i}(a), B\right)$. This equals $s_{i} w$ since

$$
\operatorname{pos}\left(y_{i}(a)^{-1} B^{+} y_{i}(a), B^{+}\right)=s_{i}, \operatorname{pos}\left(B^{+}, B\right)=w
$$

and $s_{i} w \geq w$. We have

$$
\operatorname{pos}\left(B^{-}, B^{\prime}\right)=\operatorname{pos}\left(y_{i}(a)^{-1} B^{-} y_{i}(a), B\right)=\operatorname{pos}\left(B^{-}, B\right)=v
$$

since $y_{i}(a) \in B^{-}$. Thus $B^{\prime} \in \mathcal{B}_{v, s_{i} w}$. By $1.5(\mathrm{e})$ we have $B^{\prime} \in \mathcal{B}_{\geq 0}$ hence $B^{\prime} \in$ $\mathcal{B}_{\geq 0, v, s_{i} w}$. Hence (c) holds.
1.11. Let $i \in I, a \in \mathbf{R}_{>0}$ and let $v, w$ in $W$ be such that $v \leq w$. We show:
(a) If $v \leq s_{i} v \leq w$, then $\left[x_{i}(a)\right]: \mathcal{B} \rightarrow \mathcal{B}$ restricts to a map $\mathcal{B}_{\geq 0, v, w} \rightarrow \mathcal{B}_{\geq 0, v, w}$ which is fixed point free.
(b) If $v \leq s_{i} v, s_{i} v \not \leq w$, then $\left[x_{i}(a)\right]: \mathcal{B} \rightarrow \mathcal{B}$ restricts to the identity map $\mathcal{B}_{\geq 0, v, w} \rightarrow \mathcal{B}_{\geq 0, v, w}$.
(c) If $s_{i} v \leq v$, then $\left[x_{i}(a)\right]: \mathcal{B} \rightarrow \mathcal{B}$ restricts to a map $\mathcal{B}_{\geq 0, v, w} \rightarrow \mathcal{B}_{\geq 0, s_{i} v, w}$.

We apply 1.10(a)-(c) to $w w_{I}, v w_{I}$ instead of $v, w$ (note that $w w_{I} \leq v w_{I}$ ) and we apply the automorphism $\phi$. We obtain the following statements.
(1) If $w w_{I} \leq s_{i} v w_{I} \leq v w_{I}$, then $\left[x_{i}(a)\right]: \mathcal{B} \rightarrow \mathcal{B}$ restricts to a map

$$
\phi\left(\mathcal{B}_{\geq 0, w w_{I}, v w_{I}}\right) \rightarrow \phi\left(\mathcal{B}_{\geq 0, w w_{I}, v w_{I}}\right)
$$

which is fixed point free.
(2) If $s_{i} v w_{I} \leq v w_{I}$, $w w_{I} \not \leq s_{i} v w_{I}$ then $\left[x_{i}(a)\right]: \mathcal{B} \rightarrow \mathcal{B}$ restricts to the identity $\operatorname{map} \phi\left(\mathcal{B}_{\geq 0, w w_{I}, v w_{I}}\right) \rightarrow \phi\left(\mathcal{B}_{\geq 0, w w_{I}, v w_{I}}\right)$.
(3) If $v w_{I} \leq s_{i} v w_{I}$, then $\left[x_{i}(a)\right]: \mathcal{B} \rightarrow \mathcal{B}$ restricts to a map $\phi\left(\mathcal{B}_{\geq 0, w w_{I}, v w_{I}}\right) \rightarrow$ $\phi\left(\mathcal{B}_{\geq 0, w w_{I}, s_{i} v w_{I}}\right)$.
It remains to note that
(d) $\phi\left(\mathcal{B}_{\geq 0, w w_{I}, v w_{I}}\right)=\mathcal{B}_{\geq 0, v, w}$
for any $v \leq w$ in $W$ (see $1.4(\mathrm{a})$ and $1.5(\mathrm{c})$ ).
1.12. Let $i \in I, a \in \mathbf{R}_{>0}$. From 1.10 we deduce:

$$
\begin{equation*}
\left\{B \in \mathcal{B}_{\geq 0} ; y_{i}(a) \in B\right\}=\sqcup_{(v, w) \in W \times W ; v \leq w, s_{i} w \leq w, v \nless s_{i} w} \mathcal{B}_{\geq 0, v, w} \tag{a}
\end{equation*}
$$

From 1.11 we deduce:

$$
\begin{equation*}
\left\{B \in \mathcal{B}_{\geq 0} ; x_{i}(a) \in B\right\}=\sqcup_{(v, w) \in W \times W ; v \leq w, v \leq s_{i} v, s_{i} v \nless w} \mathcal{B}_{\geq 0, v, w} . \tag{b}
\end{equation*}
$$

1.13. Let $(W \times W)_{d i s j}=\left\{\left(z, z^{\prime}\right) \in W \times W ; \operatorname{supp}(z) \cap \operatorname{supp}\left(z^{\prime}\right)=\emptyset\right\}$. For $\left(z, z^{\prime}\right) \in$ $(W \times W)_{\text {disj }}$ with $m=|z|, m^{\prime}=\left|z^{\prime}\right|$, let $\mathcal{U}_{\geq 0, z, z^{\prime}}$ be the image of the (injective) $\operatorname{map} \mathbf{R}_{>0}^{m} \times \mathbf{R}_{>0}^{m^{\prime}} \rightarrow G_{\geq 0}$ given by

$$
\begin{aligned}
& \left(\left(a_{1}, a_{2}, \ldots, a_{m}\right),\left(a_{1}^{\prime}, a_{2}^{\prime}, \ldots, a_{m^{\prime}}^{\prime}\right)\right) \\
& \mapsto y_{i_{1}}\left(a_{1}\right) y_{i_{2}}\left(a_{2}\right) \ldots y_{i_{m}}\left(a_{m}\right) x_{i_{1}^{\prime}}\left(a_{1}^{\prime}\right) x_{i_{2}^{\prime}}\left(a_{2}^{\prime}\right) \ldots x_{i_{m}^{\prime}}\left(a_{m^{\prime}}^{\prime}\right) \\
& =x_{i_{1}^{\prime}}\left(a_{1}^{\prime}\right) x_{i_{2}^{\prime}}\left(a_{2}^{\prime}\right) \ldots x_{i_{m}^{\prime}}\left(a_{m^{\prime}}^{\prime}\right) y_{i_{1}}\left(a_{1}\right) y_{i_{2}}\left(a_{2}\right) \ldots y_{i_{m}}\left(a_{m}\right)
\end{aligned}
$$

where $\mathbf{i}=\left(i_{1}, \ldots, i_{m}\right) \in \mathcal{I}_{w}, \mathbf{i}^{\prime}=\left(i_{1}^{\prime}, \ldots, i_{m^{\prime}}^{\prime}\right) \in \mathcal{I}_{w^{\prime}}$. This map is injective and its image is independent of the choice of $\mathbf{i}, \mathbf{i}^{\prime}$ (see [L94, 2.7, 2.9]). Note that $\mathcal{U}_{\geq 0, z, z^{\prime}} \subset \mathcal{U}_{\geq 0}$. More precisely, we have (see [L94, 6.6]):

\mathcal{U}_{\geq 0}=\sqcup_{\left(z, z^{\prime}\right) \in(W \times W)_{d i s j}} \mathcal{U}_{\geq 0, z, z^{\prime}}
$$

We state the following result.
Theorem 1.14. Let $\left(z, z^{\prime}\right) \in(W \times W)_{\text {disj }}$ and let $u \in \mathcal{U}_{\geq 0, z, z^{\prime}}, J=\operatorname{supp}(z)$, $J^{\prime}=\operatorname{supp}\left(z^{\prime}\right)$. We have

$$
\mathcal{B}_{u, \geq 0}=\cap_{i \in J} \mathcal{B}_{y_{i}(1), \geq 0} \cap \cap_{j \in J^{\prime}} \mathcal{B}_{x_{j}(1), \geq 0}
$$

Using 1.6(c) we see that the following statement implies the theorem.

$$
\begin{equation*}
V_{+}^{u}=\cap_{i \in J} V_{+}^{y_{i}(1)} \cap \cap_{j \in J^{\prime}} V_{+}^{x_{j}(1)} . \tag{a}
\end{equation*}
$$

Let $m, m^{\prime}, \mathbf{i}, \mathbf{i}^{\prime}$ be as in 1.13 and let $\left(\left(a_{1}, a_{2}, \ldots, a_{m}\right),\left(a_{1}^{\prime}, a_{2}^{\prime}, \ldots, a_{m^{\prime}}^{\prime}\right)\right)$ be corresponding to $u$ as in 1.13. We argue by induction on $m+m^{\prime}$. If $m+m^{\prime}=0$ the result is obvious. Assume now that $m+m^{\prime} \geq 1$. If $m \geq 1$ let $z_{1}=s_{i_{1}} z$ and let $u_{1}=y_{i_{1}}\left(a_{1}\right)^{-1} u$; we have $\left|z_{1}\right|=m-1$ and $u_{1} \in \mathcal{U}_{\geq 0, z_{1}, z^{\prime}}, u=y_{i_{1}}\left(a_{1}\right) u_{1}$. If $m^{\prime} \geq 1$ let $z_{1}^{\prime}=s_{i_{1}^{\prime}} z^{\prime}$ and let $u_{1}^{\prime}=x_{i_{1}^{\prime}}\left(a_{1}^{\prime}\right)^{-1} u$; we have $\left|z_{1}^{\prime}\right|=m^{\prime}-1$ and $u_{1}^{\prime} \in \mathcal{U}_{\geq 0, z, z_{1}^{\prime}}, u=x_{i_{1}^{\prime}}\left(a_{1}^{\prime}\right) u_{1}^{\prime}$. From 1.6(a),(b), we have $V_{+}^{u}=V_{+}^{y_{i_{1}}(1)} \cap V_{+}^{u_{1}}$ if $m \geq 1, V_{+}^{u}=V_{+}^{x_{i_{1}^{\prime}}{ }^{(1)}} \cap V_{+}^{u_{1}^{\prime}}$ if $m^{\prime} \geq 1$. Since the induction hypothesis is applicable to $V_{+}^{u_{1}}$ (if $m \geq 1$ ) and to $V_{+}^{u_{1}^{\prime}}$ (if $m^{\prime} \geq 1$ ) we see that (a) is proved. This proves the theorem.
1.15. Let $J \subset I, J^{\prime} \subset I$ be such that $J \cap J^{\prime}=\emptyset$. We define

$$
\begin{aligned}
& Z_{J, J^{\prime}}=\left\{(v, w) \in W \times W ; v \leq w ; s_{i} w \leq w, v \not \leq s_{i} w \quad \forall i \in J\right. \\
& \left.v \leq s_{j} v, s_{j} v \not \leq w \quad \forall j \in J^{\prime}\right\}
\end{aligned}
$$

Combining 1.14 with $1.12(\mathrm{a}),(\mathrm{b})$ we obtain our main result.
Corollary 1.16. Let $\left(z, z^{\prime}\right) \in(W \times W)_{\text {disj }}$ and let $u \in \mathcal{U}_{\geq 0, z, z^{\prime}}, J=\operatorname{supp}(z)$, $J^{\prime}=\operatorname{supp}\left(z^{\prime}\right)$. We have

$$
\mathcal{B}_{u, \geq 0}=\cup_{(v, w) \in Z_{J, J^{\prime}}} \mathcal{B}_{\geq 0, v, w}
$$

Thus $\mathcal{B}_{u, \geq 0}$ admits a canonical, explicit, cell decomposition in which each cell is part of the canonical cell decomposition of $\mathcal{B}_{\geq 0}$. The zero dimensional cells of $\mathcal{B}_{u, \geq 0}$ are $\mathcal{B}_{\geq 0, w, w}$ where $w \in W$ is such that the set $\left\{i \in I ; s_{i} w \leq w\right\}$ contains $J$ and is contained in $I-J^{\prime}$. (For example $w_{J}$ is such a $w$ since $J \subset I-J^{\prime}$.) In particular, $Z_{J, J^{\prime}} \neq \emptyset$, so that $\mathcal{B}_{u, \geq 0} \neq \emptyset$. (This also follows from [L94, 8.11].)
1.17. In [L94, 2.11], $G_{\geq 0}$ is partitioned into pieces indexed by $W \times W$; by results in [L94] each piece is a cell. In [L19] the set of pieces of $G_{\geq 0}$ is interpreted as a monoid $G(\{1\})$, the value of $G$ at the semifield $\{1\}$ with 1 element, so that pieces appear precisely as the fibres of a natural surjective map $G_{\geq 0} \rightarrow G(\{1\})=W \times W$ compatible with the monoid structures (the monoid structure on $W \times W$ thus obtained is not the usual group structure). In particular, the product of two pieces of $G_{\geq 0}$ is contained in a single piece of $G_{\geq 0}$. Similarly, we can view the set of cells $\mathcal{B}_{\geq 0, v, w}$ of $\mathcal{B}_{\geq 0}$ (see 1.7) as $\mathcal{B}(\{1\})$ or the value of $\mathcal{B}$ at the semifield $\{1\}$. From 1.10 and 1.11 we see that in the action of $G_{\geq 0}$ on $\mathcal{B}_{\geq 0}$, the result of applying a piece of $G_{\geq 0}$ to a cell of $\mathcal{B}_{\geq 0}$ is contained in a single cell of $\mathcal{B}_{\geq 0}$. It follows that the action of $G_{\geq 0}$ on $\mathcal{B}_{\geq 0}$ induces an action of $G(\{1\})=W \times W$ on $\mathcal{B}(\{1\})$. We can identify $\mathcal{B}(\{1\})$ with $\{(v, w) \in W \times W ; v \leq w\}$. Then the action of $W \times W$ becomes:

$$
\left(s_{i}, 1\right):(v, w) \mapsto\left(v, s_{i} * w\right),\left(1, s_{i}\right):(v, w) \mapsto\left(s_{i} \circ v, w\right)
$$

where for $i \in I, v \in W, w \in W$ we define

$$
\begin{aligned}
& s_{i} * w=w \text { if } s_{i} w \leq w, s_{i} * w=s_{i} w \text { if } w \leq s_{i} w, \\
& s_{i} \circ v=v \text { if } v \leq s_{i} v, s_{i} \circ v=s_{i} v \text { if } s_{i} v \leq v .
\end{aligned}
$$

Now let $u \in \mathcal{U}_{\geq 0}$ and let $z, z^{\prime}, J, J^{\prime}$ be associated to $u$ as in 1.16. Let $\mathcal{B}_{u}(\{1\})$ be the set of cells of $\mathcal{B}_{u, \geq 0}$ described in 1.16 ; this set is in bijection with $Z_{J, J^{\prime}}$ (see 1.16) and can be viewed as a subset of $\mathcal{B}(\{1\})$. Let $\mathfrak{Z}_{u}(\{1\})$ be the set of all $\left(w, w^{\prime}\right) \in W \times W=G(\{1\})$ such that in the $W \times W$-action on $\mathcal{B}(\{1\})$ (as above), we have $\left(w, w^{\prime}\right) \mathcal{B}_{u}(\{1\}) \subset \mathcal{B}_{u}(\{1\})$. Clearly, $\mathcal{Z}_{u}(\{1\})$ is a submonoid of $W \times W=G(\{1\})$.

Let $\mathfrak{Z}(u)$ be the inverse image of $\mathfrak{Z}(u)(\{1\})$ under the canonical monoid homomorphism $G_{\geq 0} \rightarrow G(\{1\})$ (as above). Note that $\mathfrak{Z}(u)$ is a submonoid of $G_{\geq 0}$ which is related to the centralizer of $u$ in $G$ (although it is not in general contained in it). Clearly the $G_{\geq 0}$-action of $\mathcal{B}_{\geq 0}$ restricts to a $\mathfrak{Z}(u)$-action on $\mathcal{B}_{u, \geq 0}$.
1.18. Let $\tilde{\mathcal{B}}=\{(u, B) \in \mathcal{U} \times \mathcal{B} ; u \in B\}$. Let $\tilde{\mathcal{B}}_{\geq 0}=\left\{(u, B) \in \mathcal{U}_{\geq 0} \times \mathcal{B}_{\geq 0} ; u \in B\right\}$. From 1.16 we can deduce that $\tilde{\mathcal{B}}_{\geq 0}$ is the disjoint union of the sets

$$
\begin{equation*}
\tilde{\mathcal{B}}_{\geq 0, z, z^{\prime}, v, w}=\mathcal{U}_{\geq 0, z, z^{\prime}} \times \mathcal{B}_{\geq 0, v, w} \tag{a}
\end{equation*}
$$

where $\left(z, z^{\prime}\right)$ runs through $(W \times W)_{d i s j}$ and $(v, w)$ runs through $Z_{J, J^{\prime}}$ where $J=$ $\operatorname{supp}(z), J^{\prime}=\operatorname{supp}\left(z^{\prime}\right)$. The subset (a) is a cell of dimension $|z|+\left|z^{\prime}\right|+|w|-|v|$. Note that the first projection $\tilde{\mathcal{B}}_{\geq 0} \rightarrow \mathcal{U}_{\geq 0}$ is a trivial fibration over each $\mathcal{U}_{\geq 0, z, z^{\prime}}$. Let $\tilde{\mathcal{B}}(\{1\})$ be the indexing set for the set of cells of $\tilde{\mathcal{B}}_{\geq 0}$. This is the set of all $\left(z, z^{\prime}, v, w\right) \in W^{4}$ such that $J=\operatorname{supp}(z), J^{\prime}=\operatorname{supp}\left(z^{\prime}\right)$ are disjoint and $(v, w) \in$ $Z_{J, J^{\prime}}$.
1.19. Let $B \in \mathcal{B}_{\geq 0}$ and let $\underline{B}=B \cap \mathcal{U}_{\geq 0}$. This is a closed subset of $B$ closed under multiplication. (If $u \in \underline{B}, u^{\prime} \in \underline{B}$ then $u, u^{\prime}$ are contained in the unipotent radical of $B$ hence $u u^{\prime}$ is also contained in that unipotent radical, so that $u u^{\prime}$ is unipotent. Since $u \in G_{\geq 0}, u^{\prime} \in G_{\geq 0}$ we have also $u u^{\prime} \in G_{\geq 0}$. Thus $u u^{\prime} \in \underline{B}$.) We have $B \in \mathcal{B}_{\geq 0, v, w}$ for well defined $v \leq w$ in $W$. We set

$$
\begin{aligned}
& \Xi_{v, w}=\left\{\left(z, z^{\prime}\right) \in(W \times W)_{d i s j} ; s_{i} w \leq w, v \not \leq s_{i} w \quad \forall i \in \operatorname{supp}(z) ;\right. \\
& \left.v \leq s_{j} v, s_{j} v \not \leq w \quad \forall j \in \operatorname{supp}\left(z^{\prime}\right)\right\}
\end{aligned}
$$

We show:

$$
\begin{equation*}
\underline{B}=\sqcup_{\left(z, z^{\prime}\right) \in \Xi_{v, w}} \mathcal{U}_{\geq 0, z, z^{\prime}} . \tag{a}
\end{equation*}
$$

Let $E$ be the right hand side of (a). Let $u \in \underline{B}$. Let $\left(z, z^{\prime}\right) \in(W \times W)_{\text {disj }}$ be such that $u \in \mathcal{U}_{\geq 0, z, z^{\prime}}$. Let $J=\operatorname{supp}(z), J^{\prime}=\operatorname{supp}\left(z^{\prime}\right)$. We have $B \in \mathcal{B}_{u, \geq 0}$ hence by 1.16 we have $(v, w) \in Z_{J, J^{\prime}}$ hence $\left(z, z^{\prime}\right) \in \Xi_{v, w}$ Thus, $u \in E$. We see that $\underline{B} \subset E$. Conversely, assume that $u \in E$. We can find $\left(z, z^{\prime}\right) \in \Xi_{v, w}$ such that $u \in \mathcal{U}_{\geq 0, z, z^{\prime}}$. Let $J=\operatorname{supp}(z), J^{\prime}=\operatorname{supp}\left(z^{\prime}\right)$. We have $(v, w) \in Z_{J, J^{\prime}}$. Since $B \in \mathcal{B}_{\geq 0, v, w}$ from 1.16 we see that $B \in \mathcal{B}_{u, \geq 0}$ so that $u \in B$ and $u \in \underline{B}$. We see that $E \subset \underline{B}$. This proves (a).

Let $H=\left\{i \in I ; s_{i} w \leq w, v \not \leq s_{i} w\right\}, H^{\prime}=\left\{j \in I ; v \leq s_{j} v, s_{j} v \not \leq w\right\}$.
If $i \in H$ then $v \leq w, s_{i} w \leq w$ and this is known to imply $s_{i} v \leq w$. Thus $i \in H \Longrightarrow i \notin H^{\prime}$ so that
(b) $H \cap H^{\prime}=\emptyset$.

We have $\Xi_{v, w}=\left\{\left(z, z^{\prime}\right) \in(W \times W)_{d i s j} ; \operatorname{supp}(z) \subset H, \operatorname{supp}\left(z^{\prime}\right) \subset H^{\prime}\right\}$. Using (b) we see that
(c) $\Xi_{v, w}=\left\{\left(z, z^{\prime}\right) \in W \times W ; \operatorname{supp}(z) \subset H, \operatorname{supp}\left(z^{\prime}\right) \subset H^{\prime}\right\}$.

Hence (a) becomes:

$$
\begin{equation*}
\underline{B}=\sqcup_{\left(z, z^{\prime}\right) \in W \times W ; \operatorname{supp}(z) \subset H, \operatorname{supp}\left(z^{\prime}\right) \subset H^{\prime}} \mathcal{U}_{\geq 0, z, z^{\prime}} . \tag{d}
\end{equation*}
$$

From (d) we see that $\underline{B}$ has a canonical cell decomposition with cells indexed by (c). One of these cells is $\mathcal{U} \geq 0, w_{H}, w_{H^{\prime}}$ (of dimension $\left|w_{H}\right|+\left|w_{H^{\prime}}\right|$ ); all other cells
have dimension strictly less than $\left|w_{H}\right|+\left|w_{H^{\prime}}\right|$ and are contained in the closure of $\mathcal{U}_{\geq 0, w_{H}, w_{H^{\prime}}}$. We see that
(e) $\underline{B}$ is connected of dimension $\left|w_{H}\right|+\left|w_{H^{\prime}}\right|$.

If $(v, w)=\left(1, w_{I}\right)$ then $H=H^{\prime}=\emptyset$ and from (d) we see that $\underline{B}=\mathcal{U}_{\geq 0,1,1}=\{1\}$. Recall that $\mathcal{B}_{\geq 0,1, w_{I}}=\mathcal{B}_{>0}$. We see that:
(f) If $u \in \mathcal{U}_{\geq 0}$ and $B \in \mathcal{B}_{u}$ satisfies $B \in \mathcal{B}_{>0}$ then $u=1$.

It is likely that, more generally, for any $B \in \mathcal{B}_{>0}, B \cap G_{\geq 0}$ consists of semisimple elements.
1.20. Let $g \in G_{\geq 0}$ and let $[g]: \mathcal{B} \rightarrow \mathcal{B}$ be as in 1.10. Let $\mathcal{B}_{g, \geq 0}$ be as in 1.1. If $v \leq w$ in $W$ then, by 1.17 , there are three possibilities:
(i) $[g] \mathcal{B}_{\geq 0, v, w}=\mathcal{B}_{\geq 0, v^{\prime}, w^{\prime}}$ where $v^{\prime} \leq w^{\prime},\left(v^{\prime}, w^{\prime}\right) \neq(v, w)$;
(ii) $[g] \mathcal{B}_{\geq 0, v, w}=\mathcal{B}_{\geq 0, v, w}$ and $B \mapsto[g] B, \mathcal{B}_{\geq 0, v, w} \rightarrow \mathcal{B}_{\geq 0, v, w}$ has empty fixed point set;
(iii) $[g] \mathcal{B}_{\geq 0, v, w}=\mathcal{B}_{\geq 0, v, w}$ and $B \mapsto[g] B, \mathcal{B}_{\geq 0, v, w} \rightarrow \mathcal{B}_{\geq 0, v, w}$ has non-empty fixed point set (denoted by $\mathcal{B}_{g, \geq 0, v, w}$ ).
It follows that $\mathcal{B}_{g, \geq 0}=\sqcup_{v, w} \mathcal{B}_{g, \geq 0, v, w}$ where $v, w$ is as in (iii). We conjecture that if $v, w$ is as in (iii), then $\mathcal{B}_{g, \geq 0, v, w}$ is a cell. (When $g$ is unipotent this holds by 1.16.)

## 2. Examples

2.1. Assume that $G=S L_{n+1}(\mathbf{C})$ and $I=\{1,2, \ldots, n\}$ with $n \geq 2$ and with $s_{1} s_{2}, s_{2} s_{3}, \ldots, s_{n-1} s_{n}$ of order 3. Let $J=\{1,2, \ldots, n-1\}$. Let - be the unit element of $W$. We have $\left(w_{J},-\right) \in(W \times W)_{d i s j}$ and $Z_{J, \emptyset}$ consists of

Thus if $u \in \mathcal{U}_{\geq 0, w_{J},-}$ then $\mathcal{B}_{u, \geq 0}$ is a union of $n+1$ cells of dimension 0 and $n$ cells of dimension 1.

We have also $\left(w_{J}, s_{n}\right) \in(W \times W)_{d i s j}$ and $Z_{J,\{n\}}$ consists of the pairs in (a) other than the last two. Thus, if $u \in \mathcal{U}_{\geq 0, z, s_{n}}$ then $\mathcal{B}_{u, \geq 0}$ is a union of $n$ cells of dimension 0 and $n-1$ cells of dimension 1 .

Assume now that $n=3$. We have $\left(s_{1} s_{3},-\right) \in(W \times W)_{\text {disj }}$. Let $J=\{1,3\}$. Then $Z_{J, \emptyset}$ consists of

(We write $i_{1} i_{2} \ldots$ instead of $s_{i_{1}} s_{i_{2}} \ldots$ ) Thus, if $u \in \mathcal{U}_{\geq 0, s_{1} s_{3},-}$ then $\mathcal{B}_{u, \geq 0}$ is a union of 6 cells of dimension 0,6 cells of dimension 1 and one cell of dimension 2 .

We have also $\left(s_{1} s_{3}, s_{2}\right) \in(W \times W)_{d i s j}$ and $Z_{J,\{2\}}$ consists of the pairs in (b) other than the last two. Thus, if $u \in \mathcal{U}_{\geq 0, s_{1} s_{3}, s_{2}}$ then $\mathcal{B}_{u, \geq 0}$ is a union of 5 cells of dimension 0,5 cells of dimension 1 and one cell of dimension 2 .

In these examples $\mathcal{B}_{u, \geq 0}$ is contractible; but in the last two examples, $\mathcal{B}_{u, \geq 0}$ is not of pure dimension, unlike $\mathcal{B}_{u}$.

(We write $i_{1} i_{2} \ldots$ instead of $s_{i_{1}} s_{i_{2}} \ldots$.) Thus if $u \in \mathcal{U}_{\geq 0, s_{1},-}$ then $\mathcal{B}_{u, \geq 0}$ is a union of cells of dimension $\leq 3$, two of which have dimension 3 .

In each of the examples above, for any cell $\mathcal{B}_{\geq 0, v, w}$ of maximal dimension of $\mathcal{B}_{u, \geq 0}$, we have $w=v w_{H}$ where $H \subset I$ is such that $u$ is conjugate in $G$ to a regular unipotent element in the subgroup of $G$ generated by $\left\{y_{i}(a), x_{i}(a) ; i \in I-H, a \in\right.$ $\mathbf{C}\}$ and by $T$. This is likely to be a general phenomenon.

For such $u$ one can show that $\left|w_{H}\right| \leq \operatorname{dim} \mathcal{B}_{u}$ (complex dimension); this is compatible with $\left|w_{H}\right|=\operatorname{dim} \mathcal{B}_{u, \geq 0}$ (real dimension).
2.2. In this subsection we assume that $G, I$ are as in 2.1 and $n=2$. In this case we can take $V$ in 1.3 to be the adjoint representation of $G$. The canonical basis $\beta$ of $V$ can be denoted by $X_{-12}, X_{-1}, X_{-2}, t_{1}, t_{2}, X_{1}, X_{2}, X_{12}$ and the action of $x_{i}(a), y_{i}(a), i \in I, a \in \mathbf{C}$ is as follows:

2.4. We return to the general case. Now $2.3(\mathrm{a}),(\mathrm{b}),(\mathrm{c})$ make sense in the general case (in (b),(c) we replace 121 by $w_{I}$ and - by the unit element of $W$ ); we expect that these statements hold in the general case. In particular $\beta_{z}^{-} \subset \beta$ and $\beta_{z}^{+} \subset \beta$ are defined for $z \in W$.

Let $\eta^{-}$be the unique vector in $\beta$ such that the stabilizer of $\mathbf{C} \eta^{-}$in $G$ is $B^{-}$. We can regard $V$ naturally as a module over the universal enveloping algebra of the Lie algebra of $G$ hence as a module over the universal enveloping algebra $\mathfrak{U}^{+}$ of the Lie algebra of $U^{+}$and as a module over the universal enveloping algebra $\mathfrak{U}^{-}$ of the Lie algebra of $U^{-}$. Now $\mathfrak{U}^{+}$(resp. $\mathfrak{U}^{-}$) has a canonical basis $\tilde{\beta}^{+}$(resp. $\tilde{\beta}^{-}$), see [L90]) and the map $c^{+}: \tilde{b} \mapsto \tilde{b} \eta^{-}$(resp. $c^{-}: \tilde{b} \mapsto \tilde{b} \eta$ ) from $\tilde{\beta}^{+}$(resp. $\tilde{\beta}^{-}$) to $V$ has image $\beta \cup\{0\}$. From [L19, 10.2] we have a partition $\tilde{\beta}^{+}=\sqcup_{w \in W} \tilde{\beta}_{w}^{+}$; similarly we have a partition $\tilde{\beta}^{-}=\sqcup_{w \in W} \tilde{\beta}_{w}^{-}$. We expect that for $z \in W, \beta_{z}^{-}$is equal to $c^{-}\left(\tilde{\beta}_{z}^{-}\right)$with 0 removed and that $\beta_{z}^{+}$is equal to $c^{+}\left(\tilde{\beta}_{z w_{I}}^{+}\right)$with 0 removed.

## 3. Partial flag manifolds

3.1. We fix $H \subset I$. Let $W^{H}$ be the set of all $w \in W$ such that $w$ has minimal length in $w W_{H}$. Let $P_{H}$ be the subgroup of $G$ generated by $\left\{x_{i}(a) ; i \in I, a \in \mathbf{C}\right\}$, $\left\{y_{i}(a) ; i \in H, a \in \mathbf{C}\right\}$ and by $T$ (a parabolic subgroup containing $B^{+}$). Let $\mathcal{P}_{H}$ be the variety whose points are the subgroups of $G$ conjugate to $P_{H}$. (We have $P_{\emptyset}=B^{+}, \mathcal{P}_{\emptyset}=\mathcal{B}$.) Define $\pi_{H}: \mathcal{B} \rightarrow \mathcal{P}_{H}$ by $B \mapsto P$ where $P \in \mathcal{P}_{H}$ contains $B$. As observed in [L98] to any $P \in \mathcal{P}_{H}$ we can attach two Borel subgroups $B^{\prime}, B^{\prime \prime}$ of $P$ such that $\operatorname{pos}\left(B^{+}, B^{\prime}\right)=b \in W^{H}, \operatorname{pos}\left(B^{-}, B^{\prime \prime}\right)=a^{\prime} \in W^{H} ;$ moreover $B^{\prime}, B^{\prime \prime}$ (hence $a^{\prime}, b$ ) are uniquely determined by $P$. Let $c=\operatorname{pos}\left(B^{\prime}, B^{\prime \prime}\right) \in W_{H}$ and let $a=w_{I} a^{\prime}$. We have $a \leq b c$ (since $B^{\prime \prime} \in \mathcal{B}_{a, b c}$ ) and $a c^{-1} \leq b$ (since $\left.B^{\prime} \in \mathcal{B}_{a c^{-1}, b}\right)$. Conversely, if
(a) $(a, b, c) \in\left(w_{I} W^{H}\right) \times W^{H} \times W_{H}$ satisfy $a \leq b c$ or equivalently $a c^{-1} \leq b$,
then the set of all $P \in \mathcal{P}_{H}$ which give rise as above to $a, b, c$ is non-empty; we denote this set by $\mathcal{P}_{H, a, b, c}$. The subsets $\mathcal{P}_{H, a, b, c}$ form a partition of $\mathcal{P}_{H}$ indexed by the set $\mathcal{P}_{H}(\{1\})$ of triples $(a, b, c)$ as in (a).

Following [L98] we set $\mathcal{P}_{H, \geq 0}=\pi_{H}\left(\mathcal{B}_{\geq 0}\right), \mathcal{P}_{H,>0}=\pi_{H}\left(\mathcal{B}_{>0}\right)$. For $(a, b, c) \in$ $\mathcal{P}_{H}(\{1\})$ we set

This implies (by $1.7(\mathrm{a})$ ) that $\mathcal{P}_{H, \geq 0, a, b, c}$ is a cell for any $(a, b, c) \in \mathcal{P}_{H}(\{1\})$, so that the various $\mathcal{P}_{H, \geq 0, a, b, c}$ form a cell decomposition of $\mathcal{P}_{H, \geq 0}$; this justifies the notation $\mathcal{P}_{H}(\{1\})$.

From 1.5(d) we deduce:
(d) $g \in G_{\geq 0}, P \in \mathcal{P}_{H, \geq 0} \Longrightarrow g P g^{-1} \in \mathcal{P}_{H, \geq 0}$.

Let $\mathcal{P}=\sqcup_{H \subset I} \mathcal{P}_{H}, \mathcal{P}_{\geq 0}=\sqcup_{H \subset I} \mathcal{P}_{H, \geq 0}, \mathcal{P}_{>0}=\sqcup_{H \subset I} \mathcal{P}_{H,>0}$.
3.2. Let $H$ be as in 3.1. Let $V_{H}$ be an irreducible rational $G$-module over $\mathbf{C}$ such that $\{g \in G ; g \mathcal{L}=\mathcal{L}\}=P_{H}$ for some (necessarily unique) line $\mathcal{L}$ in $V$; let $\eta \in \mathcal{L}-\{0\}$. Let $\beta$ be the basis of $V_{H}$ (containing $\eta$ ) obtained by specializing at $v=1$ the canonical basis [L90] of the corresponding module over the corresponding quantized enveloping algebra. Let $\mathcal{X}_{H}$ be the $G$-orbit of $\mathcal{L}$ in the set of lines in $V_{H}$. We have a bijection
(a) $\mathcal{P}_{H} \xrightarrow{\sim} \mathcal{X}_{H}$
given by $P \mapsto L_{P}$ where $L_{P}$ is the unique $P$-stable line in $V_{H}$. Let
(b) $V_{H+}=\sum_{b \in \beta} \mathbf{R}_{\geq 0} b \subset V_{H}$.

From [L98] we see that $V_{H}$ above can be chosen so that:
(c) under the bijection (a), $\mathcal{P}_{H, \geq 0}$ corresponds to the set of lines in $\mathcal{X}_{H}$ which meet $V_{H+}-\{0\}$.
In the sequel we assume that $V_{H}$ has been chosen so that (c) holds.
3.3. For $u \in \mathcal{U}_{\geq 0}$ let $\mathcal{P}_{H, u, \geq 0}=\left\{P \in \mathcal{P}_{H, \geq 0} ; u \in P\right\}, V_{H+}^{u}=\left\{\xi \in V_{H+} ; u \xi=\xi\right\}$. The proof of (a),(b),(c) below is identical to that of 1.6(a),(b),(c).
(a) Let $u, u^{\prime}, u^{\prime \prime}$ in $\mathcal{U}_{\geq 0}$ be such that $u=u^{\prime} u^{\prime \prime}$. We have $V_{H+}^{u}=V_{H+}^{u^{\prime}} \cap V_{H+}^{u^{\prime \prime}}$.
(b) Let $i \in I, a \in \mathbf{R}_{>0}$. We have $V_{H+}^{x_{i}(a)}=V_{H+}^{x_{i}(1)}, V_{H+}^{y_{i}(a)}=V_{H+}^{y_{i}(1)}$.
(c) Under the bijection 3.2(c), $\mathcal{P}_{H, u, \geq 0}$ corresponds to the set of lines in $\mathcal{X}_{H}$ which meet $V_{H+}^{u}-\{0\}$.
3.4. For any $h \in G$ let $[h]_{H}: \mathcal{P}_{H} \rightarrow \mathcal{P}_{H}$ be the map $P \mapsto h P h^{-1}$.

Let $i \in I, a \in \mathbf{R}_{>0}$. Let $(r, t) \in \mathcal{Z}$. Now (a),(b),(c) below follow immediately from 1.10(a), (b), (c) using 3.1(b).
(a) If $r \leq s_{i} t \leq t$, then $\left[y_{i}(a)\right]_{H}: \mathcal{P}_{H} \rightarrow \mathcal{P}_{H}$ restricts to a map ${ }_{r, t} \mathcal{P}_{H, \geq 0} \rightarrow$ ${ }_{r, t} \mathcal{P}_{H, \geq 0}$ which is fixed point free.
(b) If $s_{i} t \leq t, r \not \leq s_{i} t$, then $\left[y_{i}(a)\right]_{H}: \mathcal{P}_{H} \rightarrow \mathcal{P}_{H}$ restricts to the identity map ${ }_{r, t} \mathcal{P}_{H, \geq 0} \rightarrow{ }_{r, t} \mathcal{P}_{H, \geq 0}$.
(c) Ift $\leq s_{i}$ t then $\left[y_{i}(a)\right]_{H}: \mathcal{P}_{H} \rightarrow \mathcal{P}_{H}$ restricts to a map ${ }_{r, t} \mathcal{P}_{H, \geq 0} \rightarrow_{r, s_{i} t} \mathcal{P}_{H, \geq 0}$; note that $\left(r, s_{i} t\right) \in \mathcal{Z}$.
3.5. Let $i \in I, a \in \mathbf{R}_{>0}$. Let $\left(r^{\prime}, t^{\prime}\right) \in \mathcal{Z}^{\prime}$. Now (a),(b),(c) below follow immediately from $1.11(\mathrm{a}),(\mathrm{b}),(\mathrm{c})$ using 3.1(c).
(a) If $r^{\prime} \leq s_{i} r^{\prime} \leq t^{\prime}$, then $\left[x_{i}(a)\right]_{H}: \mathcal{P}_{H} \rightarrow \mathcal{P}_{H}$ restricts to a map ${ }^{r^{\prime}, t^{\prime}} \mathcal{P}_{H, \geq 0} \rightarrow$ $r^{\prime}, t^{\prime} \mathcal{P}_{H, \geq 0}$ which is fixed point free.
(b) If $r^{\prime} \leq s_{i} r^{\prime}$, $s_{i} r^{\prime} \not \leq t^{\prime}$, then $\left[x_{i}(a)\right]_{H}: \mathcal{P}_{H} \rightarrow \mathcal{P}_{H}$ restricts to the identity $\operatorname{map}_{r^{\prime}, t^{\prime}} \mathcal{P}_{H, \geq 0} \rightarrow_{r^{\prime}, t^{\prime}} \mathcal{P}_{H, \geq 0}$.
(c) If $s_{i} r^{\prime} \leq r^{\prime}$ then $\left[x_{i}(a)\right]_{H}: \mathcal{P}_{H} \rightarrow \mathcal{P}_{H}$ restricts to a map ${ }^{r^{\prime}, t^{\prime}} \mathcal{P}_{H, \geq 0} \rightarrow$ $s_{i} r^{\prime}, t^{\prime} \mathcal{P}_{H, \geq 0}$; note that $\left(s_{i} r^{\prime}, t^{\prime}\right) \in \mathcal{Z}^{\prime}$.
3.6. Let $i \in I, a \in \mathbf{R}_{>0}$. From 3.4 we deduce:

\left\{P \in \mathcal{P}_{H, \geq 0} ; y_{i}(a) \in P\right\}=\sqcup_{(r, t) \in \mathcal{Z} ; s_{i} t \leq t, r \not s_{i} t}\left(r, t \mathcal{P}_{H, \geq 0}\right) . \tag{a}
\end{equation*}
$$

From 3.5 we deduce:

$$
\begin{equation*}
\left\{P \in \mathcal{P}_{H, \geq 0} ; x_{i}(a) \in P\right\}=\sqcup_{\left(r^{\prime}, t^{\prime}\right) \in \mathcal{Z}^{\prime} ; r^{\prime} \leq s_{i} r^{\prime}, s_{i} r^{\prime} \nless t}{ }^{r^{\prime}, t^{\prime}} \mathcal{P}_{H, \geq 0} \tag{b}
\end{equation*}
$$

The proof of the following result is entirely similar to that of 1.14, using $3.3(\mathrm{a}),(\mathrm{b})$ instead of $1.6(\mathrm{a}),(\mathrm{b})$.
Theorem 3.7. Let $\left(z, z^{\prime}\right) \in(W \times W)_{\text {disj }}$ and let $u \in \mathcal{U}_{\geq 0, z, z^{\prime}}, J=\operatorname{supp}(z)$, $J^{\prime}=\operatorname{supp}\left(z^{\prime}\right)$. We have

$$
\mathcal{P}_{H, u, \geq 0}=\cap_{i \in J} \mathcal{P}_{H, y_{i}(1), \geq 0} \cap \cap_{j \in J^{\prime}} \mathcal{P}_{H, x_{j}(1), \geq 0}
$$

3.8. Let $J \subset I, J^{\prime} \subset I$ be such that $J \cap J^{\prime}=\emptyset$. We set

$$
\begin{aligned}
& Z_{H ; J, J^{\prime}}=\left\{\left((r, t),\left(r^{\prime}, t^{\prime}\right)\right) \in \mathcal{Z} \times \mathcal{Z}^{\prime} ;\right. \\
& \left.\left(r^{\prime}, t^{\prime}\right)=\alpha^{\prime} \alpha^{-1}(r, t), s_{i} t \leq t, r \not \pm s_{i} t \quad \forall i \in J ; r^{\prime} \leq s_{j} r^{\prime}, s_{j} r^{\prime} \not \pm t^{\prime} \quad \forall j \in J^{\prime}\right\} .
\end{aligned}
$$

Combining 3.7 with $3.6(\mathrm{a}),(\mathrm{b})$ we obtain the following result.
Corollary 3.9. Let $\left(z, z^{\prime}\right) \in(W \times W)_{\text {disj }}$ and let $u \in \mathcal{U}_{\geq 0, z, z^{\prime}}, J=\operatorname{supp}(z)$, $J^{\prime}=\operatorname{supp}\left(z^{\prime}\right)$. We have

$$
\mathcal{P}_{H, u, \geq 0}=\cup_{\left((r, t),\left(r^{\prime}, t^{\prime}\right)\right) \in Z_{H ; J, J^{\prime}}}\left(r, t \mathcal{P}_{H, \geq 0}\right)
$$

Thus $\mathcal{P}_{H, u, \geq 0}$ admits a canonical, explicit, cell decomposition in which each cell is part of the canonical cell decomposition of $\mathcal{P}_{H, \geq 0}$. The zero dimensional cells of $\mathcal{P}_{H, u, \geq 0}$ are indexed by

$$
\left\{\left((r, r),\left(r^{\prime}, r^{\prime}\right)\right) ; r^{\prime} \in W^{H}, r=r^{\prime} w_{H}, s_{i} r \leq r \quad \forall i \in J, r^{\prime} \leq s_{j} r^{\prime} \quad \forall j \in J^{\prime}\right\}
$$

The last set contains for example $\left((r, r),\left(r^{\prime}, r^{\prime}\right)\right)$ where

$$
r^{\prime}=w_{J} w_{J \cap H}, r=w_{J} w_{J \cap H} w_{H} .
$$

3.10. From 3.4 and 3.5 we see that in the action of $G_{\geq 0}$ on $\mathcal{P}_{H, \geq 0}$, the result of applying a piece of $G_{\geq 0}$ to a cell of $\mathcal{P}_{H, \geq 0}$ is contained in a single cell of $\mathcal{P}_{H, \geq 0}$. It follows that the action of $G_{\geq 0}$ on $\mathcal{P}_{H, \geq 0}$ induces an action of $G(\{1\})=W \times W$ on $\mathcal{P}_{H}(\{1\})$. We can identify $\mathcal{P}_{H}(\{1\})$ with

$$
\left\{\left((r, t),\left(r^{\prime}, t^{\prime}\right)\right) \in \mathcal{Z} \times \mathcal{Z}^{\prime} ;\left(r^{\prime}, t^{\prime}\right)=\alpha^{\prime} \alpha^{-1}(r, t)\right\}
$$

Then the action of $W \times W$ becomes:

$$
\begin{gathered}
\left(s_{i}, 1\right):\left((r, t),\left(r^{\prime}, t^{\prime}\right)\right) \mapsto\left(\left(r, s_{i} * t\right), \alpha^{\prime} \alpha^{-1}\left(r, s_{i} * t\right)\right) \\
\left(1, s_{i}\right):\left((r, t),\left(r^{\prime}, t^{\prime}\right)\right) \mapsto\left(\alpha \alpha^{\prime-1}\left(s_{i} \circ r^{\prime}, t^{\prime}\right),\left(s_{i} \circ r^{\prime}, t^{\prime}\right)\right),
\end{gathered}
$$

(notation of 1.17).
3.11. Let $P \in \mathcal{P}_{H, \geq 0}$ and let $\underline{P}=P \cap \mathcal{U}_{\geq 0}$. This is a closed subset of $P$. We have $P \in{ }_{r, t} \mathcal{P}_{H, \geq 0}=r^{\prime}, t^{\prime} \mathcal{P}_{H, \geq 0}$ for a well defined $\left((r, t),\left(r^{\prime}, t^{\prime}\right)\right) \in \mathcal{Z} \times \mathcal{Z}^{\prime}$ such that $\left(r^{\prime}, t^{\prime}\right)=\alpha^{\prime} \alpha^{-1}(r, t)$. We set

$$
\begin{aligned}
& \Xi_{H,(r, t),\left(r^{\prime}, t^{\prime}\right)}=\left\{\left(z, z^{\prime}\right) \in(W \times W)_{d i s j} ; s_{i} t \leq t, r \not \leq s_{i} t \quad \forall i \in \operatorname{supp}(z) ;\right. \\
& \left.r^{\prime} \leq s_{j} r^{\prime}, s_{j} r^{\prime} \not \leq t^{\prime} \quad \forall j \in \operatorname{supp}\left(z^{\prime}\right)\right\}
\end{aligned}
$$

We show:

$$
\begin{equation*}
\underline{P}=\sqcup_{\left(z, z^{\prime}\right) \in \Xi_{H,(r, t),\left(r^{\prime}, t^{\prime}\right)}} \mathcal{U}_{\geq 0, z, z^{\prime}} \tag{a}
\end{equation*}
$$

Let $E$ be the right hand side of (a). Let $u \in \underline{P}$. Let $\left(z, z^{\prime}\right) \in(W \times W)_{d i s j}$ be such that $u \in \mathcal{U}_{\geq 0, z, z^{\prime}}$. Let $J=\operatorname{supp}(z), J^{\prime}=\operatorname{supp}\left(z^{\prime}\right)$. We have $P \in \mathcal{P}_{H, u, \geq 0}$ hence by 3.9 we have $\left((r, t),\left(r^{\prime}, t^{\prime}\right)\right) \in Z_{H ; J, J^{\prime}}$ hence $\left(z, z^{\prime}\right) \in \Xi_{H,(r, t),\left(r^{\prime}, t^{\prime}\right)}$. Thus, $u \in E$. We see that $\underline{P} \subset E$. Conversely, assume that $u \in E$. We can find $\left(z, z^{\prime}\right) \in \Xi_{H,(r, t),\left(r^{\prime}, t^{\prime}\right)}$ such that $u \in \mathcal{U}_{\geq 0, z, z^{\prime}}$. Let $J=\operatorname{supp}(z), J^{\prime}=\operatorname{supp}\left(z^{\prime}\right)$. We have $\left((r, t),\left(r^{\prime}, t^{\prime}\right)\right) \in Z_{H ; J, J^{\prime}}$. Since $P \in{ }_{r, t} \mathcal{P}_{H, \geq 0}$, from 3.9 we see that $P \in \mathcal{P}_{H, u, \geq 0}$ so that $u \in P$ and $u \in \underline{P}$. We see that $E \subset \underline{P}$. This proves (a).

From (a) we see that $\underline{P}$ has a canonical cell decomposition with cells indexed by $\Xi_{H,(r, t),\left(r^{\prime}, t^{\prime}\right)}$.

## 4. A conjecture and its consequences

4.1. An $\mathbf{R}_{>0}$-positive structure on a set $\mathfrak{X}$ is a finite collection $f_{e}: \mathbf{R}_{>0}^{m} \xrightarrow{\sim} \mathfrak{X}$ of bijections $(e \in E)$ with $m \geq 0$ fixed, such that for any $e, e^{\prime}$ in $E, f_{e}^{-1} f_{e^{\prime}}: \mathbf{R}_{\geq 0}^{m} \rightarrow$ $\mathbf{R}_{>0}^{m}$ is admissible in the sense of [L19, 1.2]. If $\left(\mathfrak{X} ; f_{e}: \mathbf{R}_{>0}^{m} \rightarrow \mathfrak{X}, e \in E\right),\left(\tilde{\mathfrak{X}} ; \tilde{f}_{\tilde{e}}\right.$ : $\left.\mathbf{R}_{>0}^{\tilde{m}} \rightarrow \tilde{\mathfrak{X}}, \tilde{e} \in \tilde{E}\right)$ are two sets with $\mathbf{R}_{>0}$-positive structure, a map $\xi: \mathfrak{X} \rightarrow \tilde{\mathfrak{X}}$ is said to be a morphism if for some (or equivalently any) $e \in E, \tilde{e} \in \tilde{E}$, the map $\tilde{f}_{\tilde{e}}^{-1} \xi f_{e}: \mathbf{R}_{>0}^{m} \rightarrow \mathbf{R}_{>0}^{\tilde{m}_{m}}$ is admissible in the sense of [L19, 1.2]. We say that $\xi$ is an isomorphism if it is a bijective morphism and $\xi^{-1}$ is a morphism.

If $\mathfrak{X}, \mathfrak{X}^{\prime}$ have positive $\mathbf{R}_{>0}$-structures, then $\mathfrak{X} \times \mathfrak{X}^{\prime}$ has a natural $\mathbf{R}_{>0}$-positive structure.
4.2. Let $T_{>0}=T \cap G_{\geq 0}$. For any basis $\chi_{*}=\left(\chi_{1}, \chi_{2}, \ldots, \chi_{n}\right)$ of $\operatorname{Hom}\left(\mathbf{C}^{*}, T\right)$ we have a bijection $\mathbf{R}_{>0}^{n} \xrightarrow{\sim} T_{>0}$ given by $\left(a_{1}, \ldots, a_{n}\right) \mapsto \chi_{1}\left(a_{1}\right) \ldots \chi_{n}\left(a_{n}\right)$. These bijections (for various $\chi_{*}$ ) define an $\mathbf{R}_{>0}$-positive structure on $T_{>0}$.

Let $v \leq w$ in $W$. From [R08] we see that the bijections $\tau_{\mathbf{i}}: \mathbf{R}_{>0}^{|w|-|v|} \xrightarrow{\sim} \mathcal{B}_{\geq 0, v, w}$ (see 1.8(c)) with $\mathbf{i} \in \mathcal{I}_{w}$ form an $\mathbf{R}_{>0}$-positive structure on $\mathcal{B}_{\geq 0, v, w}$.

From 1.10 we see that for $i \in I$,
(a) the map $\mathbf{R}_{>0} \times \mathcal{B}_{\geq 0, v, w} \rightarrow \mathcal{B}_{\geq 0, v, s_{i} * w}$ given by $(a, B) \mapsto y_{i}(a) B y_{i}(a)^{-1}$ is a well defined morphism of sets with $\mathbf{R}_{>0}$-positive structure.

From the definitions, for any $\chi \in \operatorname{Hom}\left(\mathbf{C}^{*}, T\right)$,
(b) the map $\mathbf{R}_{>0} \times \mathcal{B}_{\geq 0, v, w} \rightarrow \mathcal{B}_{\geq 0, v, w}$ given by $(a, B) \mapsto \chi(a) B \chi(a)^{-1}$ is a well defined morphism of sets with $\mathbf{R}_{>0}$-positive structure.
4.3. Replacing in $4.2 v, w$ by $w_{I} w, w_{I} v$, we deduce that the bijections

$$
\tau_{\mathbf{i}^{\prime}}: \mathbf{R}_{>0}^{|w|-|v|}=\mathbf{R}_{>0}^{\left|w_{I} v\right|-\left|w_{I} w\right|} \xrightarrow{\sim} \mathcal{B}_{\geq 0, w_{I} w, w_{I} v}
$$

with $\mathbf{i}^{\prime} \in \mathcal{I}_{w_{I} v}$ form an $\mathbf{R}_{>0}$-positive structure on $\mathcal{B}_{\geq 0, w_{I} w, w_{I} v}$ and that for $i \in I$, the map

$$
\mathbf{R}_{>0} \times \mathcal{B}_{\geq 0, w_{I} w, w_{I} v} \rightarrow \mathcal{B}_{\geq 0, w_{I} w, s_{i} *\left(w_{I} v\right)}
$$

given by $(a, B) \mapsto y_{i}(a) B y_{i}(a)^{-1}$ is a well defined morphism of sets with $\mathbf{R}_{>0^{-}}$ positive structure. We state:

Conjecture 4.4. The bijection $\mathcal{B}_{\geq 0, w w_{I}, v w_{I}} \xrightarrow{\sim} \mathcal{B}_{\geq 0, v, w}$ defined by $\phi$ (see 1.11(d)) is an isomorphism of $\mathbf{R}_{>0}$-positive structures.

When $v=1, w=w_{I}$ this can be deduced from [L97, §3].
In the remainder of this section we assume that this conjecture holds.
4.5. Let $v, w$ be as in 4.2. Using 4.4 we can reformulate the last statement in 4.3 as follows. For $i \in I$,
(a) the map $\mathbf{R}_{>0} \times \mathcal{B}_{\geq 0, v, w} \rightarrow \mathcal{B}_{\geq 0, s_{i} \circ v, w}$ given by $(a, B) \mapsto x_{i}(a) B x_{i}(a)^{-1}$ is a well defined morphism of sets with $\mathbf{R}_{>0}$-positive structure.
4.6. We consider a sequence of admissible maps (see [L19, 1.2]):

$$
\begin{aligned}
& \Phi_{1}: \mathbf{R}_{>0} \times \mathbf{R}_{>0}^{n_{0}} \rightarrow \mathbf{R}_{>0}^{n_{1}}, \Phi_{2}: \mathbf{R}_{>0} \times \mathbf{R}_{>0}^{n_{1}} \rightarrow \mathbf{R}_{>0}^{n_{2}} \\
& \ldots, \Phi_{\sigma}: \mathbf{R}_{>0} \times \mathbf{R}_{>0}^{n_{\sigma-1}} \rightarrow \mathbf{R}_{>0}^{n_{\sigma}}
\end{aligned}
$$

where $n_{0}, n_{1}, \ldots, n_{\sigma}$ are in $\mathbf{N}$. We define $\Phi: \mathbf{R}_{>0}^{\sigma} \times \mathbf{R}_{>0}^{n_{0}} \rightarrow \mathbf{R}_{>0}^{n_{\sigma}}$ by

$$
\left.\Phi\left(\left(a_{1}, a_{2}, \ldots, a_{\sigma}\right), b\right)=\ldots \Phi_{3}\left(a_{3}, \Phi_{2}\left(a_{2}, \Phi_{1}\left(a_{1}, b\right)\right)\right) \ldots\right)
$$

where $b \in \mathbf{R}_{>0}^{n_{0}}$. Clearly, $\Phi$ is admissible.
4.7. Consider the inverse image $G_{r,-s}$ of $(r, s) \in W \times W$ under the map $G_{\geq 0} \rightarrow$ $W \times W$ in 1.17. Now $G_{r,-s}$ has a natural $\mathbf{R}_{>0}$-positive structure (see [L19]). Let $\left(i_{1}, i_{2}, \ldots, i_{m}\right) \in \mathcal{I}_{r},\left(j_{1}, j_{2}, \ldots, j_{l}\right) \in \mathcal{I}_{s}$. Let $v \leq w$ be elements of $W$. Define $v^{\prime} \leq w^{\prime}$ by $\left.\left.v^{\prime}=s_{i_{1}} \circ\left(\ldots s_{i_{m-1}} \circ\left(s_{i_{m}} \circ v\right)\right) \ldots\right), w^{\prime}=s_{j_{1}} *\left(\ldots s_{j_{l-1}} *\left(s_{j_{l}} \circ w\right)\right) \ldots\right)$ (notation of 1.17). The $G_{\geq 0}$-action on $\mathcal{B}_{\geq 0}$ restricts to a map $G_{r,-s} \times \mathcal{B}_{\geq 0, v, w} \rightarrow$ $\mathcal{B}_{\geq 0, v^{\prime}, w^{\prime}}$.
(a) This is a morphism of sets with $\mathbf{R}_{>0}$-positive structure.

Indeed, our map can be identified with a $\Phi$ in 4.6 where each of $\Phi_{1}, \ldots, \Phi_{\sigma}$ is a map as in $4.2(\mathrm{a}),(\mathrm{b})$ or $4.5(\mathrm{a})$ hence is admissible.
4.8. We now fix a semifield $K$. Let $\left(\mathfrak{X} ; f_{e}: \mathbf{R}_{>0}^{m} \rightarrow \mathfrak{X}, e \in E\right)$ be a set with an $\mathbf{R}_{>0}$-positive structure. For any $e, e^{\prime}$ in $E$ the admissible bijection $f_{e}^{-1} f_{e^{\prime}}: \mathbf{R}_{>0}^{m} \xrightarrow{\sim}$ $\mathbf{R}_{>0}^{m}$ induces a bijection $\underline{f}_{e, e^{\prime}}: K^{m} \xrightarrow{\sim} K^{m}$. (This is obtained by replacing the indeterminates which appear in the formula for $f_{e}^{-1} f_{e^{\prime}}$ by elements of $K$ instead of elements of $\mathbf{R}_{>0}$.) There is a well defined set $\mathfrak{X}(K)$ with bijections $\underline{f}_{e}: K^{m} \xrightarrow{\sim}$ $\mathfrak{X}(K)$ such that $\underline{f}_{e, e^{\prime}}=\underline{f}_{e}^{-1} \underline{f}_{e^{\prime}}$ for any $e, e^{\prime}$ in $E$. If $\xi: \mathfrak{X} \rightarrow \mathfrak{X}^{\prime}$ is a morphism of sets with $\mathbf{R}_{>0}$-positive structure then $\xi$ induces a map of sets $\xi(K): \mathfrak{X}(K) \rightarrow \mathfrak{X}^{\prime}(K)$.
4.9. In the setup of 4.7 , the sets $G_{r,-s}(K), \mathcal{B}_{\geq 0, v, w}(K), \mathcal{B}_{\geq 0, v^{\prime}, w^{\prime}}(K)$ are defined as in 4.8 and by $4.8(\mathrm{a})$, the map $G_{r,-s} \times \mathcal{B}_{\geq 0, v, w} \rightarrow \mathcal{B}_{\geq 0, v^{\prime}, w^{\prime}}$ induces a map
(a) $G_{r,-s}(K) \times \mathcal{B}_{\geq 0, v, w}(K) \rightarrow \mathcal{B}_{\geq 0, v^{\prime}, w^{\prime}}(K)$.

We set $G(K)=\sqcup_{(r, s) \in W \times W} G_{r,-s}(\bar{K}), \mathcal{B}(K)=\sqcup_{(v, w) \in W \times W ; v \leq w} \mathcal{B}_{\geq 0, v, w}(K)$. The maps (a) define a map $G(K) \times \mathcal{B}(K) \rightarrow \mathcal{B}(K)$. This is an action of $G(K)$ (with the monoid structure induced from that of $G_{\geq 0}$ ) on the set $\mathcal{B}(K)$.
4.10. Let $H \subset I$. For any $(a, b, c) \in \mathcal{P}_{H}(\{1\})$, the cell $\mathcal{P}_{H, \geq 0, a, b, c}$ in $\mathcal{P}_{H, \geq 0}$ has a $\mathbf{R}_{>0}$-positive structure via a bijection as in 3.1(a) or as in 3.1(b) (these two bijections define the same $\mathbf{R}_{>0}$-positive structure, as we see easily from the definitions). Thus the set $\mathcal{P}_{H, \geq 0, a, b, c}(K)$ is defined. We set

$$
\mathcal{P}_{H}(K)=\sqcup_{(a, b, c) \in \mathcal{P}_{H}(\{1\})} \mathcal{P}_{H, \geq 0, a, b, c}(K)
$$

An argument similar to that in 4.9 shows that the $G_{\geq 0}-$ action on $\mathcal{P}_{H, \geq 0}$ (see 3.1(d)) induces an action of the monoid $G(K)$ on $\mathcal{P}_{H}(K)$.
4.11. Let $u \in \mathcal{U}_{\geq 0}$. Let $z, z^{\prime}, J, J^{\prime}$ be as in 1.16 . We set

$$
\begin{aligned}
\mathcal{B}_{u}(K) & =\cup_{(v, w) \in Z_{J, J^{\prime}}} \mathcal{B}_{\geq 0, v, w}(K), \\
\mathfrak{Z}(u)(K) & =\cup_{(r, s) \in \mathcal{Z}_{u}(\{1\})} G_{r,-s}(K) .
\end{aligned}
$$

(notation of $1.15,1.17$ ). Then the action of $G(K)$ on $\mathcal{B}(K)$ restricts to an action of $\mathfrak{Z}(u)(K)$ (with the monoid structure induced from that of $G(K)$ ) on the set $\mathcal{B}_{u}(K)$.

## 5. The map $g \mapsto P_{g}$ FROM $G_{\geq 0}$ TO $\mathcal{P}_{\geq 0}$

5.1. In this section we give a new, simpler, definition of the map $g \mapsto B_{g}$ from $G_{>0}$ to $\mathcal{B}_{>0}$ in [L94, 8.9(c)] and we extend it to a map $g \mapsto P_{g}$ from $G_{\geq 0}$ to $\mathcal{P}_{\geq 0}$.
5.2. For a closed subgroup $G^{\prime}$ of $G$ we denote by $\mathfrak{L} G^{\prime}$ the Lie algebra of $G^{\prime}$. Let $\mathfrak{g}=$ $\mathfrak{L} G$. Let $g \in G_{\geq 0}$. We associate to $g$ a parabolic subgroup $P=P_{g}$ of $G$ containing $g$ as follows. By [L19, 9.1(a)], we have $\mathfrak{g}=\oplus_{a \in \mathbf{R}_{>0}} \mathfrak{g}_{a}$ where $\mathfrak{g}_{a}$ is the generalized $a$-eigenspace of $\operatorname{Ad}(g): \mathfrak{g} \rightarrow \mathfrak{g}$. It follows that we have $\mathfrak{g}=\mathfrak{g}_{<1} \oplus \mathfrak{g}_{1} \oplus \mathfrak{g}_{>1}$ where $\mathfrak{g}_{<1}=\oplus_{a: 0<a<1} \mathfrak{g}_{a}, \mathfrak{g}_{>1}=\oplus_{a: a>1} \mathfrak{g}_{a}$ and $\mathfrak{g}_{\leq 1}=\mathfrak{g}_{<1} \oplus \mathfrak{g}_{1}, \mathfrak{g}_{\geq 1}=\mathfrak{g}_{1} \oplus \mathfrak{g}_{>1}$ are opposed parabolic subalgebras of $\mathfrak{g}$ with common Levi subalgebra $\mathfrak{g}_{1}$. Let $P=P_{g}$ be the parabolic subgroup of $G$ with $\mathfrak{L} P=\mathfrak{g}_{\geq 1}$. Let $L=L_{g}$ be the Levi subgroup of $P$ with $\mathfrak{L} L=\mathfrak{g}_{1}$. Note that $L$ is the centralizer in $G$ of the semisimple part $g_{s}$ of $g$. In particular we have $g \in L$; more precisely, $g$ is a central element of $L$ times a unipotent element of $L$. For example, if $g \in G_{\geq 0}$ is unipotent then $P_{g}=G$.
5.3. We now assume that $g \in G_{>0}$. We show:
(a) $B_{g}=P_{g}$.

Let $U_{>0}^{+} \subset U^{+}, U_{>0}^{-} \subset U^{-}$be as in [L94, 2.12]. Let $T_{>0} \subset T$ be as in 4.7. By [L94, 8.10] we can find $u \in U_{>0}^{+}, u^{\prime} \in U_{>0}^{-}, t \in T_{>0}$ such that $g=u^{\prime} t u u^{\prime-1}$ and all eigenvalues of $\operatorname{Ad}(t)$ on $\mathfrak{L} U^{+}$are $>1$. Then all eigenvalues of $\operatorname{Ad}(t)$ on $\mathfrak{L} B^{+}$ are $\geq 1$. Now $t u$ is $U^{+}$-conjugate to $t$ hence all eigenvalues of $\operatorname{Ad}(t u)$ on $\mathfrak{L} B^{+}$ are $\geq 1$. It follows that all eigenvalues of $\operatorname{Ad}(g)$ on $\mathfrak{L}\left(u^{\prime} B^{+} u^{\prime-1}\right)$ are $\geq 1$, so that $\mathfrak{L}\left(u^{\prime} B^{+} u^{\prime-1}\right) \subset \mathfrak{L} P_{g}$. Since $t$ (and $t u$ ) is regular semisimple, $L_{g}$ is a maximal torus of $G$ so that $P_{g} \in \mathcal{B}$; this implies that $\mathfrak{L}\left(u^{\prime} B^{+} u^{\prime-1}\right)=\mathfrak{L} P_{g}$. From the definition of $\mathcal{B}_{>0}$ we have $u^{\prime} B^{+} u^{\prime-1} \in=\mathcal{B}_{>0}$. Since $g \in u^{\prime} B^{+} u^{\prime-1}$, we have $u^{\prime} B^{+} u^{\prime-1}=B_{g}$. This proves (a).
5.4. Let $g \in G_{\geq 0}$. We show:
(a) $P_{g} \in \mathcal{P}_{\geq 0}$.

By $[\mathrm{L} 94,4.4]$ we can find a sequence $g_{1}, g_{2}, g_{3}, \ldots$ in $G_{>0}$ such that $g=\lim _{n \rightarrow \infty} g_{n}$ in $G$. Since $\mathcal{B}$ is compact, some subsequence of the sequence of Borel subgroups $P_{g_{n}}$ converges in $\mathcal{B}$ to a Borel subgroup $B \in \mathcal{B}$. We can assume that $\lim _{n \rightarrow \infty} P_{g_{n}}=B$ in $\mathcal{B}$. Since $P_{g_{n}} \in \mathcal{B}_{>0} \subset \mathcal{B}_{\geq 0}$ and $\mathcal{B}_{\geq 0}$ is closed in $\mathcal{B}$, we have $B \in \mathcal{B}_{\geq 0}$. Let $\mathfrak{p}_{n}=\mathfrak{L} P_{g_{n}}, n=1,2, \ldots, \mathfrak{p}=\mathfrak{L} P_{g}$, and let $\mathfrak{b}=\mathfrak{L} B$. We show:
(b) $\mathfrak{b} \subset \mathfrak{p}$.

We have $\lim _{n \rightarrow \infty} \mathfrak{p}_{n}=\mathfrak{b}$ in the Grassmannian of $\operatorname{dim} \mathfrak{b}$-dimensional subspaces of $\mathfrak{g}$. Since $\mathfrak{p}_{n}$ is stable under $\operatorname{Ad}\left(g_{n}\right)$ for $n=1,2, \ldots$, we see that $\mathfrak{b}$ is stable under $\operatorname{Ad}(g)$. Moreover since all eigenvalues of $\operatorname{Ad}\left(g_{n}\right): \mathfrak{p}_{n} \rightarrow \mathfrak{p}_{n}$ are $\geq 1$, we see that all eigenvalues of $\operatorname{Ad}(g): \mathfrak{b} \rightarrow \mathfrak{b}$ are $\geq 1$. Hence (b) holds.

From (b) we deduce that $B \subset P_{g}$. Since $B \in \mathcal{B}_{\geq 0}$ we see that $P_{g} \in \mathcal{P}_{\geq 0}$; this proves (a) and completes the verification of the statements in 5.1.
5.5. Let $B \in \mathcal{B}_{>0}$. We show:
(a) $B \cap G_{>0}$ is non-empty.

We have $B=u B^{+} u^{-1}$ for some $u \in U_{>0}^{-}$. Let $\tilde{u} \in U_{>0}^{+}$. By [L94, 7.2] we can
find $t \in T_{>0}$ such that $u \tilde{u} t u^{-1} \in G_{>0}$. We have $u \tilde{u} t u^{-1} \in u B^{+} u^{-1}=B$. Thus $u \tilde{u} t u^{-1} \in B \cap G_{>0}$ and (a) follows.

We conjecture that $B \cap G_{>0}$ is homeomorphic to $\mathbf{R}_{>0}^{\operatorname{dim} B}$. Consider for example the case where $G=S L_{2}(\mathbf{C})$. In this case there is a unique $z \in \mathbf{R}_{>0}$ such that $B$ equals $\left\{\left(\begin{array}{cc}a & b \\ c & d\end{array}\right) ; a, b, c, d\right.$ in $\left.\mathbf{C}, a d=b c+1, c+d z=z(a+b z)\right\}$. Then $B \cap G_{>0}$ can be identified with the set $\left\{(a, b, c, d) \in \mathbf{R}_{>0}^{4} ; a d=b c+1, c+d z=z(a+b z)\right\}$ or (via the sustitution $d=(b c+1) / a)$, with the set $X_{z}=\left\{(a, b, c) \in \mathbf{R}_{>0}^{3} ; c+z \frac{b c+1}{a}=\right.$ $z(a+b z)\}=\left\{(a, b, c) \in \mathbf{R}_{>0}^{3} ;(a z-c)(b z+a)=z\right\}$. Setting $\epsilon=a-c z^{-1}$ we can identify $X_{z}$ with $X_{z}^{\prime}=\left\{(b, c, \epsilon) \in \mathbf{R}_{>0}^{3} ; \epsilon^{2}+\epsilon\left(b z+c z^{-1}\right)-1=0\right\}$. The map $X_{z}^{\prime} \rightarrow \mathbf{R}_{>0}^{2},(b, c, \epsilon) \mapsto(b, c)$ is a homeomorphism: for any $(b, c) \in \mathbf{R}_{>0}^{2}$ there is a unique $\epsilon \in \mathbf{R}_{>0}$ such that $\epsilon^{2}+\epsilon\left(b z+c z^{-1}\right)-1=0$. This proves the conjecture in our case.

### 5.6. We show:

(a) If $g \in G_{>0}$ then $P_{g} \in \mathcal{B}$; the image of the map $g \mapsto P_{g}$ from $G_{>0}$ to $\mathcal{B}$ is exactly $\mathcal{B}_{>0}$.
The fact that $P_{g} \in \mathcal{B}_{>0}$ for $g \in G_{>0}$ follows from 5.3(a). Let $B \in \mathcal{B}_{>0}$. Let $g \in B \cap G_{>0}$ (see 5.5(a)). From [L94, 8.9(a)] we see that $B=B_{g}$ hence by $5.3(\mathrm{a})$ we have $B=P_{g}$. This proves (a).

Now (a) provides a new definition of $\mathcal{B}_{>0}$; it is the image of the map $g \mapsto P_{g}$ from $G_{>0}$ to $\mathcal{B}$.

Let $G_{r e g}$ be the set of regular elements in $G$ and let $G_{r e g, \geq 0}=G_{r e g} \cap G_{\geq 0}$. We conjecture that the map $g \mapsto P_{g}$ from $G_{\geq 0}$ to $\mathcal{P}_{\geq 0}$ is surjective and that, moreover, its restriction $G_{\text {reg }, \geq 0} \rightarrow \mathcal{P}_{\geq 0}$ is surjective.
