# A RIGHT INVERSE OF DIFFERENTIAL OPERATOR $\Delta + a$ IN WEIGHTED HILBERT SPACE $L^2(\mathbb{R}^n, e^{-|x|^2})$

ABSTRACT. In this note, we prove the existence of weak solutions of a Poisson type equation in the weighted Hilbert space  $L^2(\mathbb{R}^n, e^{-|x|^2})$ .

### 1. INTRODUCTION

In this note, we study the right inverse of differential operator  $\Delta + a$  in a Hilbert space by proving the following result on the existence of (global) weak solutions of a Poisson type equation in the weighted Hilbert space  $L^2(\mathbb{R}^n, e^{-|x|^2})$ , where a is a real constant throughout.

**Theorem 1.1.** For each  $f \in L^2(\mathbb{R}^n, e^{-|x|^2})$ , there exists a weak solution  $u \in L^2(\mathbb{R}^n, e^{-|x|^2})$  solving the equation

$$\Delta u + au = f$$

in  $\mathbb{R}^n$  with the norm estimate

$$\int_{\mathbb{R}^n} u^2 e^{-|x|^2} dx \le \frac{1}{8n} \int_{\mathbb{R}^n} f^2 e^{-|x|^2} dx.$$

The novelty of Theorem 1.1 is that the differential operator  $\Delta + a$  has a bounded right inverse

$$Q: L^2(\mathbb{R}^n, e^{-|x|^2}) \longrightarrow L^2(\mathbb{R}^n, e^{-|x|^2}),$$
$$(\Delta + a)Q = I$$

with the norm estimate  $||Q|| \leq \frac{1}{\sqrt{8n}}$ . In particular, the Laplace operator  $\Delta$  has a bounded right inverse  $Q_0 : L^2(\mathbb{R}^n, e^{-|x|^2}) \longrightarrow L^2(\mathbb{R}^n, e^{-|x|^2})$ , which, to the best of our knowledge, appears to be new.

As a simple consequence of Theorem 1.1, we can obtain the following result on the existence of global weak solutions of a Poisson type equation for square integrable functions. This result seems to be classical and well-known, but we could not find an exact reference. At least it is well-known [1] that when f is compact supported in  $\mathbb{R}^n$ , then a solution of  $-\Delta u = f$  is  $\Phi * f$ , where  $\Phi$  is the fundamental solution of Laplace's equation.

**Theorem 1.2.** For each  $f \in L^2(\mathbb{R}^n)$  or  $f \in L^{\infty}(\mathbb{R}^n)$ , there exists a weak solution  $u \in L^2_{loc}(\mathbb{R}^n)$  solving the equation

$$\Delta u + au = f.$$

In particular, the Poisson equation  $\Delta u = f$  has a weak solution  $u \in L^2_{loc}(\mathbb{R}^n)$  for  $f \in L^2(\mathbb{R}^n)$ or  $f \in L^{\infty}(\mathbb{R}^n)$ .

The proof of Theorem 1.2 follows from the observation that  $L^2(\mathbb{R}^n) \subset L^2(\mathbb{R}^n, e^{-|x|^2})$ ,  $L^{\infty}(\mathbb{R}^n) \subset L^2(\mathbb{R}^n, e^{-|x|^2})$  and  $L^2(\mathbb{R}^n, e^{-|x|^2}) \subset L^2_{loc}(\mathbb{R}^n)$ .

The method employed in this note was motivated from the Hörmander  $L^2$  method [2] for Cauchy-Riemann equations from several complex variables.

### 2. Several Lemmas

Here, we consider weighted Hilbert space

$$L^{2}(\mathbb{R}^{n}, e^{-\varphi}) = \{ f \mid f \in L^{2}_{loc}(\mathbb{R}^{n}); \int_{\mathbb{R}^{n}} f^{2} e^{-\varphi} dx < +\infty \},$$

where  $\varphi$  is a nonnegative function on  $\mathbb{R}^n$ . We denote the weighted inner product for  $f, g \in L^2(\mathbb{R}^n, e^{-\varphi})$  by  $\langle f, g \rangle_{\varphi} = \int_{\mathbb{R}^n} fg e^{-\varphi} dx$  and the weighted norm of  $f \in L^2(\mathbb{R}^n, e^{-\varphi})$  by  $||f||_{\varphi} = \sqrt{\langle f, f \rangle_{\varphi}}$ . Let k be a positive integer,  $C^k(\mathbb{R}^n)$  denote the set of all k-times continuously differentiable real-valued functions on  $\mathbb{R}^n$ , and  $C_0^{\infty}(\mathbb{R}^n)$  denote the set of all smooth functions  $\phi : \mathbb{R}^n \to \mathbb{R}$  with compact support. Let  $\Delta = \sum_{j=1}^n \frac{\partial^2}{\partial x_j^2}$  be the Laplace operator on  $\mathbb{R}^n$ . For  $u, f \in L^2_{loc}(\mathbb{R}^n)$ , we say that f is the Laplace of u in the weak sense, written  $\Delta u = f$ , provided  $\int_{\mathbb{R}^n} u \Delta \phi dx = \int_{\mathbb{R}^n} f \phi dx$  for all test functions  $\phi \in C_0^{\infty}(\mathbb{R}^n)$ .

Let  $\varphi \in C^2(\mathbb{R}^n)$ . For  $\forall \phi \in C_0^{\infty}(\mathbb{R}^n)$ , we first define the following formal adjoint of  $\Delta$  with respect to the weighted inner product in  $L^2(\mathbb{R}^n, e^{-\varphi})$ . Let  $u \in L^2_{loc}(\mathbb{R}^n)$ . We calculate as follows.

$$\begin{split} \langle \phi, \Delta u \rangle_{\varphi} &= \int_{\mathbb{R}^n} \phi \Delta u e^{-\varphi} dx \\ &= \int_{\mathbb{R}^n} u \Delta \left( \phi e^{-\varphi} \right) dx \\ &= \int_{\mathbb{R}^n} e^{\varphi} u \Delta \left( \phi e^{-\varphi} \right) e^{-\varphi} dx \\ &= \langle e^{\varphi} \Delta \left( \phi e^{-\varphi} \right), u \rangle_{\varphi} \\ &=: \langle \Delta_{\varphi}^* \phi, u \rangle_{\varphi} \,, \end{split}$$

where  $\Delta_{\varphi}^* \phi = e^{\varphi} \Delta (\phi e^{-\varphi})$  is the formal adjoint of  $\Delta$  with domain in  $C_0^{\infty}(\mathbb{R}^n)$ . Let  $(\Delta + a)_{\varphi}^*$  be the formal adjoint of  $\Delta + a$  with domain in  $C_0^{\infty}(\mathbb{R}^n)$ . Note that  $I_{\varphi}^* = I$ , where I is the identity operator. Then  $(\Delta + a)_{\varphi}^* = \Delta_{\varphi}^* + a$ .

Let  $\nabla$  be the gradient operator on  $\mathbb{R}^n$ . Now we give several key lemmas based on functional analysis.

**Lemma 2.1.** Let  $\varphi \in C^2(\mathbb{R}^n)$ . For each  $f \in L^2(\mathbb{R}^n, e^{-\varphi})$ , there exists a global weak solution  $u \in L^2(\mathbb{R}^n, e^{-\varphi})$  solving the equation

$$\Delta u + au = f$$

in  $\mathbb{R}^n$  with the norm estimate

$$\|u\|_{\varphi}^2 \le c$$

if and only if

$$|\langle f, \phi \rangle_{\varphi}|^2 \le c \left\| (\Delta + a)^*_{\varphi} \phi \right\|_{\varphi}^2, \quad \forall \phi \in C_0^{\infty}(\mathbb{R}^n),$$

where c is a constant.

Proof. Let  $\Delta + a = H$ . Then  $(\Delta + a)^*_{\varphi} = H^*_{\varphi}$ . (Necessity) For  $\forall \phi \in C_0^{\infty}(\mathbb{R}^n)$ , from the definition of  $H^*_{\varphi}$  and Cauchy-Schwarz inequality, we have

$$\left|\langle f,\phi\rangle_{\varphi}\right|^{2} = \left|\langle Hu,\phi\rangle_{\varphi}\right|^{2} = \left|\langle u,H_{\varphi}^{*}\phi\rangle_{\varphi}\right|^{2} \le \left\|u\right\|_{\varphi}^{2} \left\|H_{\varphi}^{*}\phi\right\|_{\varphi}^{2} \le c\left\|H_{\varphi}^{*}\phi\right\|_{\varphi}^{2} = c\left\|(\Delta+a)_{\varphi}^{*}\phi\right\|_{\varphi}^{2}.$$

(Sufficiency) Consider the subspace

$$E = \left\{ H^*_{\varphi} \phi \mid \phi \in C^{\infty}_0(\mathbb{R}^n) \right\} \subset L^2(\mathbb{R}^n, e^{-\varphi}).$$

Define a linear functional  $L_f: E \to \mathbb{R}$  by

$$L_f\left(H_{\varphi}^*\phi\right) = \langle f, \phi \rangle_{\varphi} = \int_{\mathbb{R}^n} f \phi e^{-\varphi} dx.$$

Since

$$\left|L_f\left(H_{\varphi}^*\phi\right)\right| = \left|\langle f, \phi \rangle_{\varphi}\right| \le \sqrt{c} \left\|H_{\varphi}^*\phi\right\|_{\varphi},$$

then  $L_f$  is a bounded functional on E. Let  $\overline{E}$  be the closure of E with respect to the norm  $\|\cdot\|_{\varphi}$  of  $L^2(\mathbb{R}^n, e^{-\varphi})$ . Note that  $\overline{E}$  is a Hilbert subspace of  $L^2(\mathbb{R}^n, e^{-\varphi})$ . So by Hahn-Banach's extension theorem,  $L_f$  can be extended to a linear functional  $\widetilde{L}_f$  on  $\overline{E}$  such that

$$\left|\widetilde{L}_{f}(g)\right| \leq \sqrt{c} \left\|g\right\|_{\varphi}, \quad \forall g \in \overline{E}.$$
 (1)

Using the Riesz representation theorem for  $\widetilde{L}_f$ , there exists a unique  $u_0 \in \overline{E}$  such that

$$\widetilde{L}_f(g) = \langle u_0, g \rangle_{\varphi}, \quad \forall g \in \overline{E}.$$
 (2)

Now we prove  $\Delta u_0 + au_0 = f$ . For  $\forall \phi \in C_0^{\infty}(\mathbb{R}^n)$ , apply  $g = H_{\varphi}^* \phi$  in (2). Then

$$\widetilde{L}_f\left(H_{\varphi}^*\phi\right) = \left\langle u_0, H_{\varphi}^*\phi\right\rangle_{\varphi} = \left\langle Hu_0, \phi\right\rangle_{\varphi}.$$

Note that

$$\widetilde{L}_f\left(H^*_{\varphi}\phi\right) = L_f\left(H^*_{\varphi}\phi\right) = \langle f, \phi \rangle_{\varphi}.$$

Therefore,

$$\langle Hu_0, \phi \rangle_{\varphi} = \langle f, \phi \rangle_{\varphi}, \quad \forall \phi \in C_0^{\infty}(\mathbb{R}^n),$$

i.e.,

$$\int_{\mathbb{R}^n} H u_0 \phi e^{-\varphi} dx = \int_{\mathbb{R}^n} f \phi e^{-\varphi} dx, \quad \forall \phi \in C_0^\infty(\mathbb{R}^n),$$

i.e.,

$$\int_{\mathbb{R}^n} (Hu_0 - f)\phi e^{-\varphi} dx = 0, \quad \forall \phi \in C_0^\infty(\mathbb{R}^n).$$

Thus,  $Hu_0 = f$ , i.e.,  $\Delta u_0 + au_0 = f$ .

Next we give a bound for the norm of  $u_0$ . Let  $g = u_0$  in(1) and (2). Then we have

$$||u_0||_{\varphi}^2 = |\langle u_0, u_0 \rangle_{\varphi}| = \left| \widetilde{L}_f(u_0) \right| \le \sqrt{c} ||u_0||_{\varphi}.$$

Therefore,  $||u_0||_{\varphi}^2 \leq c$ .

Note that  $u_0 \in \overline{E}$  and  $\overline{E} \subset L^2(\mathbb{R}^n, e^{-\varphi})$ . Then  $u_0 \in L^2(\mathbb{R}^n, e^{-\varphi})$ . Let  $u = u_0$ . So there exists  $u \in L^2(\mathbb{R}^n, e^{-\varphi})$  such that  $\Delta u + au = f$  with  $||u||_{\varphi}^2 \leq c$ . The proof is complete.  $\Box$ 

Lemma 2.2. Let  $\varphi \in C^4(\mathbb{R}^n)$ . Then

$$\left\| \left(\Delta + a\right)_{\varphi}^{*} \phi \right\|_{\varphi}^{2} = \left\| \left(\Delta + a\right) \phi \right\|_{\varphi}^{2} + \left\langle \phi, \Delta \left(\Delta_{\varphi}^{*} \phi\right) - \Delta_{\varphi}^{*} \left(\Delta \phi\right) \right\rangle_{\varphi}, \quad \forall \phi \in C_{0}^{\infty}(\mathbb{R}^{n})$$

*Proof.* Let  $\Delta + a = H$ . Then  $(\Delta + a)^*_{\varphi} = H^*_{\varphi}$ . For  $\forall \phi \in C^{\infty}_0(\mathbb{R}^n)$ , we have

$$\begin{split} \left\| H_{\varphi}^{*}\phi \right\|_{\varphi}^{2} &= \left\langle H_{\varphi}^{*}\phi, H_{\varphi}^{*}\phi \right\rangle_{\varphi} \\ &= \left\langle \phi, HH_{\varphi}^{*}\phi \right\rangle_{\varphi} \\ &= \left\langle \phi, H_{\varphi}^{*}H\phi \right\rangle_{\varphi} + \left\langle \phi, HH_{\varphi}^{*}\phi - H_{\varphi}^{*}H\phi \right\rangle_{\varphi} \\ &= \left\langle H\phi, H\phi \right\rangle_{\varphi} + \left\langle \phi, HH_{\varphi}^{*}\phi - H_{\varphi}^{*}H\phi \right\rangle_{\varphi} \\ &= \left\| H\phi \right\|_{\varphi}^{2} + \left\langle \phi, HH_{\varphi}^{*}\phi - H_{\varphi}^{*}H\phi \right\rangle_{\varphi} \end{split}$$
(3)

Note that

$$\begin{split} HH_{\varphi}^{*}\phi &= (\Delta + a) \left(\Delta + a\right)_{\varphi}^{*}\phi \\ &= (\Delta + a) \left(\Delta_{\varphi}^{*}\phi + a\phi\right) \\ &= \Delta \left(\Delta_{\varphi}^{*}\phi\right) + a\Delta\phi + a\Delta_{\varphi}^{*}\phi + a^{2}\phi \end{split}$$

and

$$\begin{aligned} H^*_{\varphi}H\phi &= (\Delta + a)^*_{\varphi} \left(\Delta + a\right)\phi \\ &= \left(\Delta^*_{\varphi} + a\right) \left(\Delta\phi + a\phi\right) \\ &= \Delta^*_{\varphi} \left(\Delta\phi\right) + a\Delta^*_{\varphi}\phi + a\Delta\phi + a^2\phi. \end{aligned}$$

Then

$$HH^*_{\varphi}\phi - H^*_{\varphi}H\phi = \Delta\left(\Delta^*_{\varphi}\phi\right) - \Delta^*_{\varphi}\left(\Delta\phi\right). \tag{4}$$

So by (3) and (4), we have

$$\left\|H_{\varphi}^{*}\phi\right\|_{\varphi}^{2} = \left\|H\phi\right\|_{\varphi}^{2} + \left\langle\phi,\Delta\left(\Delta_{\varphi}^{*}\phi\right) - \Delta_{\varphi}^{*}\left(\Delta\phi\right)\right\rangle_{\varphi}.$$

This lemma is proved.

**Lemma 2.3.** Let  $\varphi = |x|^2$ . Then for  $\forall \phi \in C_0^{\infty}(\mathbb{R}^n)$ ,

$$\left\langle \phi, \Delta \left( \Delta_{\varphi}^{*} \phi \right) - \Delta_{\varphi}^{*} \left( \Delta \phi \right) \right\rangle_{\varphi} = 8n \|\phi\|_{\varphi}^{2} + 8 \|\nabla \phi\|_{\varphi}^{2}.$$

*Proof.* For  $\forall \phi \in C_0^{\infty}(\mathbb{R}^n)$ , by the definition of  $\Delta_{\varphi}^*$  and the following formula

$$\Delta(\alpha\beta) = \beta\Delta\alpha + \alpha\Delta\beta + 2\nabla\alpha \cdot \nabla\beta, \quad \forall \alpha, \beta \in C^2(\mathbb{R}^n),$$

we have

$$\Delta^*_{\varphi}\phi = e^{\varphi}\Delta\left(\phi e^{-\varphi}\right) = \Delta\phi + \phi|\nabla\varphi|^2 - \phi\Delta\varphi - 2\nabla\phi\cdot\nabla\varphi.$$
(5)

From (5) we have

$$\begin{split} \Delta \left( \Delta_{\varphi}^{*} \phi \right) &= \Delta^{2} \phi + \Delta (\phi | \nabla \varphi |^{2}) - \Delta (\phi \Delta \varphi) - 2\Delta (\nabla \phi \cdot \nabla \varphi) \\ &= \Delta^{2} \phi + \Delta \phi | \nabla \varphi |^{2} + \phi \Delta (|\nabla \varphi |^{2}) + 2\nabla \phi \cdot \nabla (|\nabla \varphi |^{2}) \\ &- \Delta \phi \Delta \varphi - \phi \Delta^{2} \varphi - 2\nabla \phi \cdot \nabla (\Delta \varphi) - 2\Delta (\nabla \phi \cdot \nabla \varphi) \end{split}$$

and

$$\Delta_{\varphi}^{*}(\Delta\phi) = \Delta^{2}\phi + \Delta\phi |\nabla\varphi|^{2} - \Delta\phi\Delta\varphi - 2\nabla(\Delta\phi) \cdot \nabla\varphi.$$

Then

$$\Delta \left( \Delta_{\varphi}^{*} \phi \right) - \Delta_{\varphi}^{*} \left( \Delta \phi \right) = \phi \Delta (|\nabla \varphi|^{2}) + 2\nabla \phi \cdot \nabla (|\nabla \varphi|^{2}) - \phi \Delta^{2} \varphi - 2\nabla \phi \cdot \nabla (\Delta \varphi) - 2\Delta (\nabla \phi \cdot \nabla \varphi) + 2\nabla (\Delta \phi) \cdot \nabla \varphi.$$
(6)

Let  $\varphi = |x|^2$ . We have  $\nabla \varphi = 2x$ ,  $\Delta \varphi = 2n$ ,  $|\nabla \varphi|^2 = 4|x|^2$ ,  $\nabla(|\nabla \varphi|^2) = 8x$ ,  $\Delta(|\nabla \varphi|^2) = 8n$ . Then by (6) and the following formula

$$\Delta(\nabla\phi\cdot x) = \nabla(\Delta\phi)\cdot x + 2\Delta\phi, \quad \forall\phi\in C_0^\infty(\mathbb{R}^n),$$

we get

$$\Delta \left( \Delta_{\varphi}^{*} \phi \right) - \Delta_{\varphi}^{*} \left( \Delta \phi \right) = 8n\phi + 16(\nabla \phi \cdot x) - 8\Delta \phi.$$

Consequently,

$$\begin{split} \left\langle \phi, \Delta \left( \Delta_{\varphi}^{*} \phi \right) - \Delta_{\varphi}^{*} \left( \Delta \phi \right) \right\rangle_{\varphi} &= \left\langle \phi, 8n\phi + 16(\nabla \phi \cdot x) - 8\Delta \phi \right\rangle_{\varphi} \\ &= 8n \|\phi\|_{\varphi}^{2} + 8 \left\langle \phi, 2(\nabla \phi \cdot x) - \Delta \phi \right\rangle_{\varphi}. \end{split}$$

Note, as the key step of the proof, that

$$\begin{split} \langle \phi, 2(\nabla \phi \cdot x) - \Delta \phi \rangle_{\varphi} &= \int_{\mathbb{R}^n} \phi (2(\nabla \phi \cdot x) - \Delta \phi) e^{-\varphi} dx \\ &= \int_{\mathbb{R}^n} \phi \sum_{j=1}^n \left( 2x_j \frac{\partial \phi}{\partial x_j} - \frac{\partial^2 \phi}{\partial x_j \partial x_j} \right) e^{-|x|^2} dx \\ &= -\int_{\mathbb{R}^n} \phi \sum_{j=1}^n \frac{\partial}{\partial x_j} \left( \frac{\partial \phi}{\partial x_j} e^{-|x|^2} \right) dx \\ &= -\sum_{j=1}^n \int_{\mathbb{R}^n} \phi \frac{\partial}{\partial x_j} \left( \frac{\partial \phi}{\partial x_j} e^{-|x|^2} \right) dx \\ &= \sum_{j=1}^n \int_{\mathbb{R}^n} \frac{\partial \phi}{\partial x_j} \left( \frac{\partial \phi}{\partial x_j} e^{-|x|^2} \right) dx \\ &= \sum_{j=1}^n \int_{\mathbb{R}^n} \left( \frac{\partial \phi}{\partial x_j} \right)^2 e^{-|x|^2} dx \\ &= \int_{\mathbb{R}^n} |\nabla \phi|^2 e^{-|x|^2} dx \\ &= \|\nabla \phi\|_{\varphi}^2. \end{split}$$

Then

$$\left\langle \phi, \Delta \left( \Delta_{\varphi}^{*} \phi \right) - \Delta_{\varphi}^{*} \left( \Delta \phi \right) \right\rangle_{\varphi} = 8n \|\phi\|_{\varphi}^{2} + 8 \|\nabla \phi\|_{\varphi}^{2}.$$

The lemma is proved.

# 3. Proof of theorems

The proof of Theorems 1.1.

*Proof.* Let  $\varphi = |x|^2$ . By Lemma 2.2 and Lemma 2.3, we have for  $\forall \phi \in C_0^{\infty}(\mathbb{R}^n)$ ,

$$\left\| \left(\Delta + a\right)_{\varphi}^{*} \phi \right\|_{\varphi}^{2} = \left\| \left(\Delta + a\right) \phi \right\|_{\varphi}^{2} + \left\langle \phi, \Delta \left(\Delta_{\varphi}^{*} \phi\right) - \Delta_{\varphi}^{*} \left(\Delta \phi\right) \right\rangle_{\varphi}$$
$$\geq \left\langle \phi, \Delta \left(\Delta_{\varphi}^{*} \phi\right) - \Delta_{\varphi}^{*} \left(\Delta \phi\right) \right\rangle_{\varphi}$$
$$\geq 8n \|\phi\|_{\varphi}^{2}. \tag{7}$$

By Cauchy-Schwarz inequality and (7), we have for  $\forall \phi \in C_0^{\infty}(\mathbb{R}^n)$ ,

$$\begin{split} |\langle f, \phi \rangle_{\varphi}|^{2} &\leq \|f\|_{\varphi}^{2} \|\phi\|_{\varphi}^{2} \\ &= \left(\frac{1}{8n} \|f\|_{\varphi}^{2}\right) \left(8n \|\phi\|_{\varphi}^{2}\right) \\ &\leq \left(\frac{1}{8n} \|f\|_{\varphi}^{2}\right) \left\| (\Delta + a)_{\varphi}^{*} \phi \right\|_{\varphi}^{2}. \end{split}$$

Let  $c = \frac{1}{8n} \|f\|_{\varphi}^2$ . Then

$$|\langle f, \phi \rangle_{\varphi}|^2 \le c \left\| (\Delta + a)_{\varphi}^* \phi \right\|_{\varphi}^2, \quad \forall \phi \in C_0^{\infty}(\mathbb{R}^n).$$

By Lemma 2.1, there exists a global weak solution  $u \in L^2(\mathbb{R}^n, e^{-\varphi})$  solving the equation

$$\Delta u + au = f$$

in  $\mathbb{R}^n$  with the norm estimate

$$\|u\|_{\varphi}^2 \le c,$$

i.e.,

$$\Delta u + au = f \quad with \quad \int_{\mathbb{R}^n} u^2 e^{-|x|^2} dx \le \frac{1}{8n} \int_{\mathbb{R}^n} f^2 e^{-|x|^2} dx.$$

The proof is complete.

**Theorem 3.1.** There exists a bounded operator  $Q: L^2(\mathbb{R}^n, e^{-|x|^2}) \to L^2(\mathbb{R}^n, e^{-|x|^2})$  such that

$$(\Delta + a) Q = I \quad with \quad \|Q\| \le \frac{1}{\sqrt{8n}},$$

where ||Q|| is the norm of Q in  $L^2(\mathbb{R}^n, e^{-|x|^2})$ .

*Proof.* Let  $\varphi = |x|^2$ . For each  $f \in L^2(\mathbb{R}^n, e^{-\varphi})$ , from Theorem 1.1, there exists  $u \in L^2(\mathbb{R}^n, e^{-\varphi})$  such that

$$(\Delta + a) u = f \quad with \quad \|u\|_{\varphi} \le \frac{1}{\sqrt{8n}} \|f\|_{\varphi}.$$

Denote this u by Q(f). Then Q(f) satisfies

$$(\Delta + a) Q(f) = f \quad with \quad \|Q(f)\|_{\varphi} \le \frac{1}{\sqrt{8n}} \|f\|_{\varphi}$$

Note that f is arbitrary in  $L^2(\mathbb{R}^n, e^{-\varphi})$ . So  $Q: L^2(\mathbb{R}^n, e^{-\varphi}) \to L^2(\mathbb{R}^n, e^{-\varphi})$  is a bounded operator such that

$$(\Delta + a) Q = I \quad with \quad ||Q|| \le \frac{1}{\sqrt{8n}}.$$

The proof is complete.

### 4. Further remarks

**Remark 1.** Given  $\lambda > 0$  and  $x_0 \in \mathbb{R}^n$ , for the weight  $\varphi = \lambda |x - x_0|^2$ , we obtain the following corollary from Theorem 1.1.

**Corollary 4.1.** For each  $f \in L^2(\mathbb{R}^n, e^{-\lambda|x-x_0|^2})$ , there exists a weak solution  $u \in L^2(\mathbb{R}^n, e^{-\lambda|x-x_0|^2})$  solving the equation

$$\Delta u + au = f$$

with the norm estimate

$$\int_{\mathbb{R}^n} u^2 e^{-\lambda |x-x_0|^2} dx \le \frac{1}{8n\lambda^2} \int_{\mathbb{R}^n} f^2 e^{-\lambda |x-x_0|^2} dx.$$

*Proof.* From  $f \in L^2(\mathbb{R}^n, e^{-\lambda |x-x_0|^2})$ , we have

$$\int_{\mathbb{R}^n} f^2(x) e^{-\lambda |x-x_0|^2} dx < +\infty.$$
(8)

Let  $x = \frac{y}{\sqrt{\lambda}} + x_0$  and  $g(y) = f(x) = f\left(\frac{y}{\sqrt{\lambda}} + x_0\right)$ . Then by (8), we have  $\frac{1}{\left(\sqrt{\lambda}\right)^n} \int_{\mathbb{R}^n} g^2(y) e^{-|y|^2} dy < +\infty,$ 

which implies that  $g \in L^2(\mathbb{R}^n, e^{-|y|^2})$ . For g, applying Theorem 1.1 with a replaced by  $\frac{a}{\lambda}$ , there exists a weak solution  $v \in L^2(\mathbb{R}^n, e^{-|y|^2})$  solving the equation

$$\Delta v(y) + \frac{a}{\lambda}v(y) = g(y) \tag{9}$$

in  $\mathbb{R}^n$  with the norm estimate

$$\int_{\mathbb{R}^n} v^2(y) e^{-|y|^2} dy \le \frac{1}{8n} \int_{\mathbb{R}^n} g^2(y) e^{-|y|^2} dy.$$
(10)

Note that  $y = \sqrt{\lambda}(x - x_0)$  and g(y) = f(x). Let  $u(x) = \frac{1}{\lambda}v(y) = \frac{1}{\lambda}v\left(\sqrt{\lambda}(x - x_0)\right)$ . Then (9) and (10) can be rewritten by

$$\Delta u(x) + au(x) = f(x) \tag{11}$$

$$\int_{\mathbb{R}^n} u^2(x) e^{-\lambda |x-x_0|^2} dx \le \frac{1}{8n\lambda^2} \int_{\mathbb{R}^n} f^2(x) e^{-\lambda |x-x_0|^2} dx.$$
 (12)

(12) implies that  $u \in L^2(\mathbb{R}^n, e^{-\lambda |x-x_0|^2})$ . Then by (11) and (12), the proof is complete.  $\Box$ 

**Remark 2.** From Corollary 4.1, we can obtain the following corollary, which shows that for any choice of a, the differential operator  $\Delta + a$  has a bounded right inverse in  $L^2(U)$ , provided U is a bounded open set. This result should be well-known, and we could not locate a reference (for a very close related result, see Theorem 6 in page 324 in [1]). **Corollary 4.2.** Let  $U \subset \mathbb{R}^n$  be any bounded open set. For each  $f \in L^2(U)$ , there exists a weak solution  $u \in L^2(U)$  solving the equation

$$\Delta u + au = f$$

with the norm estimate  $||u||_{L^2(U)} \leq c||f||_{L^2(U)}$ , where the constant c depends only on the diameter of U.

*Proof.* Let  $x_0 \in U$ . For given  $f \in L^2(U)$ , extending f to zero on  $\mathbb{R}^n \setminus U$ , we have

$$\tilde{f} = \begin{cases} f, & x \in U\\ 0, & x \in \mathbb{R}^n \setminus U. \end{cases}$$

Then  $\tilde{f} \in L^2(\mathbb{R}^n) \subset L^2(\mathbb{R}^n, e^{-|x-x_0|^2})$ . From Corollary 4.1, there exists  $\tilde{u} \in L^2(\mathbb{R}^n, e^{-|x-x_0|^2})$  such that

$$\Delta \tilde{u} + a\tilde{u} = \tilde{f} \quad with \quad \int_{\mathbb{R}^n} \tilde{u}^2 e^{-|x-x_0|^2} dx \le \frac{1}{8n} \int_{\mathbb{R}^n} \tilde{f}^2 e^{-|x-x_0|^2} dx.$$

Then

$$\int_{\mathbb{R}^n} \tilde{u}^2 e^{-|x-x_0|^2} dx \le \frac{1}{8n} \int_{\mathbb{R}^n} \tilde{f}^2 dx = \frac{1}{8n} \int_U f^2 dx$$

Note that

$$\int_{\mathbb{R}^n} \tilde{u}^2 e^{-|x-x_0|^2} dx \ge \int_U \tilde{u}^2 e^{-|x-x_0|^2} dx \ge \int_U \tilde{u}^2 e^{-|U|^2} dx = e^{-|U|^2} \int_U \tilde{u}^2 dx,$$

where |U| is the diameter of U. Therefore,

$$e^{-|U|^2} \int_U \tilde{u}^2 dx \le \frac{1}{8n} \int_U f^2 dx, \quad i.e., \quad \int_U \tilde{u}^2 dx \le \frac{e^{|U|^2}}{8n} \int_U f^2 dx.$$

Restricting  $\tilde{u}$  on U to get u, then

$$\Delta u + au = f \quad with \quad \int_U u^2 dx \le \frac{e^{|U|^2}}{8n} \int_U f^2 dx.$$

Note that  $u \in L^2(U)$  and let  $c = \sqrt{\frac{e^{|U|^2}}{8n}}$ . Then the proof is complete.

**Remark 3.** When  $f \in L^2(\mathbb{R}^n)$ , the solutions of  $\Delta u = f$  are not necessary in  $L^2(\mathbb{R}^n)$ . For example: n = 1,

$$f(x) = \begin{cases} \frac{1}{x}, & x \ge 1, \\ x, & 0 < x < 1, \\ 0, & x \le 0, \end{cases}$$
$$u(x) = \int_0^x (x-t)f(t)dt + c_1x + c_2 = -\frac{x}{2} + xlnx + \frac{2}{3} + c_1x + c_2, \quad x \ge 1, \end{cases}$$

where  $c_1$  and  $c_2$  are arbitrary real constants. It is easy to see  $u \notin L^2(\mathbb{R})$ .
