# A $p$-DG DEFORMED WEBSTER ALGEBRA OF TYPE $A_{1}$

#### Abstract

We define a $p$-DG structure on a deformation of Webster algebra of type $A_{1}$ and its splitter bimodules.


## 1. Introduction

Since Khovanov categorified the Jones polynomial Kho00, a categorification of the quantum link invariant of type $A$ has been constructed in several constructions. More precisely, our motivation is to construct a link homology which is an invariant of the link and whose graded Euler characteristic is the quantum link invariants. In the case of the categorification for type $A$, we have a construction of matrix factorizations KR08, Wu14, Yon11, a geometric construction CK08, a Lie theoretic construction Sus07, MS09, a diagrammatic construction Web17] and a Howe duality construction CKL10, CK18, MY19.

We are also interested in a categorification of the quantum invariant for three-dimensional manifolds. Defining the quantum link invariant we need quantum group for the generic parameter $q$. When we construct quantum invariants for three dimensional manifold, the parameter of quantum group should be a root of unity $\zeta$. One direction to construct the categorification of the WRT three manifold invariants is that, first, we categorify the quantum groups at a root of unity and, then, we extend categorical Howe duality into the categorification of quantum group of root of unity.

Khovanov proposed the categorification of a root of unity. He introduced hopfological algebra theory which is theory of Hopf algebra with homological algebra. See Kho16, Qi14 in detail. The key observation to categorify a root of unity is that the ring $\mathbb{Z}\left[\zeta_{p}\right]$, where $\zeta_{p}$ is the $p$-cyclotomic integer, is categorified by the homotopy category of $p$-complexes $\mathbb{k}[\partial] /\left(\partial^{p}\right)$-gmod over a field of characteristic $p>0$ :

K_{0}\left(\mathbb{k}[\partial] /\left(\partial^{p}\right)-\text { gmod }\right) \cong \mathbb{Z}\left[\zeta_{p}\right] .
$$

In order to apply the categorification of the ring $\mathbb{Z}\left[\zeta_{p}\right]$ to a categorification of WRT invariants, we need algebra objects in the monoidal category $\mathbb{k}[\partial] /\left(\partial^{p}\right)$-gmod which induce a braiding functor. Such objects naturally arise from $p$-differential graded algebras ( $p-D G$ algebras).

To solve the open problem of categorification of WRT invariants, we have some progress results about $p$-DG structure KQ15, KQS17, QS16, EQ16a, EQ16b, QS18, EQ16c. For instance, we have the $p$-DG structure on the symmetric polynomial ring, cyclotomic nilHecke algebra $\mathrm{NH}_{\mathrm{n}}^{\mathrm{l}}$ (a categorification of an irreducible representation of small quantum group for $s l_{2}$ ), quiver Schur algebra $S_{n}^{l}$ (a categorification of the tensor product $V_{1}^{\otimes \ell}$, where $V_{1}$ is the Weyl module of small quantum group $s l_{2}$ ), Webster algebras.

In this short note, we briefly recall $p$-DG algebras, $p$-DG modules Qi14, some progress result, the deformed Webster algebras of type $A_{1}$ KLSY18, and then we define a $p$-DG structure on the deformed Webster algebra.

## 2. $p$-DG algebras and $p$-DG modules

Let $\mathbb{k}$ be a field of characteristic $p>0$. We recall $p$-DG algebras and $p$-DG modules defined in KQ15 and give some $p$-DG algebras introduced in KQS17, KQ15, EQ16b, QS18.

## 2.1. $p$-DG algebras and $p$-DG modules.

Definition 2.1. A $\mathbb{Z}$-graded algebra $A$ is said to be a $p$ - DG algebra if there is a $p$-derivation $\partial_{A}: A \rightarrow A$ with degree 2, which is $p$-nilpotent and satisfies the Leibniz rule:

\partial_{A}^{p}=0, \quad \partial_{A}(a b)=\partial_{A}(a) b+a \partial_{A}(b)
$$

for any $a, b \in A$.
We will write $\left(A, \partial_{A}\right)$ for the $p$-DG algebra.
By the Leibniz rule and the characteristic of the field $p$, we have the following lemma.
Lemma 2.2. We have

$$
\partial_{A}^{p}(a b)=\partial_{A}^{p}(a) b+a \partial_{A}^{p}(b)
$$

When the $p$-DG algebra is generated by the elements of the set $\left\{a_{i} \mid i \in I\right\}$, to check $\partial_{A}^{p}=0$, it is enough to show $\partial_{A}^{p}\left(a_{i}\right)=0$ for all $i \in I$ by this lemma.

Definition 2.3. Let $\left(A, \partial_{A}\right)$ and $\left(B, \partial_{B}\right)$ be $p$-DG algebras. A $\mathbb{Z}$-graded $A$-module $M$ is said to be a left $p$-DG module if there is a degree 2 endomorphism $\partial_{M}$ satisfying

\partial_{M}^{p}(m)=0, \quad \partial_{M}(a m)=\partial_{A}(a) m+a \partial_{M}(m)
$$

for any elements $a \in A$ and $m \in M$.
Similarly, a $\mathbb{Z}$-graded $A$-module $M$ is said to be a right $p$-DG module if there is a degree 2 endomorphism $\partial_{M}$ satisfying

$$
\partial_{M}^{p}(m)=0, \quad \partial_{M}(m a)=m \partial_{A}(a)+\partial_{M}(m) a
$$

for any elements $a \in A$ and $m \in M$.
A $\mathbb{Z}$-graded $(A, B)$-bimodule $M$ is said to be a $p$-DG bimodule if $M$ is a left $p$-DG $A$-module and a right $p$-DG $B$-module.

We will write $\left(M, \partial_{M}\right)$ for the $p$-DG modules.
2.2. $p$-DG structure on the polynomial ring. We recall $p$-DG structure on the graded polynomial ring EQ16a.

The graded polynomial ring $R=\mathbb{k}\left[t_{1}, \ldots, t_{n}\right]$, where $\operatorname{deg} t_{i}=2$, is a $p$-DG algebra with a $p$-derivation

satisfying the Leibniz rule. By the Leibniz rule, we have $\partial_{R}\left(t_{i}^{k}\right)=k t_{i}^{k+1}$, and thus we have $\partial_{R}^{p}\left(t_{i}\right)=$ $p!t_{i}^{p+1}=0$. Hence, we have the following statement by Lemma 2.2.

Proposition 2.4. The polynomial ring with the p-derivation $\left(R, \partial_{R}\right)$ is a $p-D G$ algebra.
The invariant ring $R^{\mathfrak{S}_{n}}$ is generated by the elementary symmetric functions

We set the generating function

G:=\sum_{i=0}^{n} E_{i} s^{i}=\prod_{i=1}^{n}\left(1+t_{i} s\right)
$$

where $E_{0}=1$. We have

where $E_{n+1}=0$.
Therefore, the $p$-derivation $\partial_{R}$ acts on the elementary symmetric functions $E_{i}$ as

\partial_{R}\left(E_{i}\right)=E_{1} E_{i}-(i+1) E_{i+1} \text { for } 1 \leq i \leq n-1, \quad \partial_{R}\left(E_{n}\right)=E_{1} E_{n} .
$$

Using Lemma 2.2 we have

$$
\partial_{R}^{p}(G)=\sum_{i=0}^{n} \partial_{R}^{p}\left(E_{i}\right) s^{i}=\partial_{R}^{p}\left(\prod_{i=1}^{n}\left(1+t_{i} s\right)\right)=0
$$

since we have $\partial_{R}^{p}\left(1+t_{i} s\right)=\partial_{R}^{p}\left(t_{i}\right) s=0$. Hence, we have the following statement.
Proposition 2.5. The invariant ring with the $p$-derivation $\left(R^{\mathcal{G}_{n}}, \partial_{R}\right)$ is a $p$-DG algebra.
Proving existence of $p$-DG structure on the deformed Webster algebra in Section 4 we show $\partial_{R}^{p}\left(E_{i}\right)=$ 0 in detail.

By Leibniz rule, we have
$\partial_{R}^{p}(G)=\sum_{\substack{\underline{p}=\left(p_{1}, p_{2}, \ldots, p_{n}\right) \in \mathbb{Z}_{\geq 0}^{n} \\ p_{1}+p_{2}+\cdots+p_{n}=p}}\binom{p}{\underline{p}}\left(\prod_{i=1}^{n} \partial_{R}^{p_{i}}\left(1+t_{i} s\right)\right)=\sum_{\substack{\underline{p}=\left(p_{1}, p_{2}, \ldots, p_{n}\right) \in \mathbb{Z}_{\geq 0}^{n} \\ p_{1}+p_{2}+\cdots+p_{n}=p}}\binom{p}{\underline{p}}\left(\prod_{i=1}^{n}\left(\partial_{R}^{p_{i}}(1)+p_{i}!t_{i}^{p_{i}+1} s\right)\right)$,
where

Since the characteristic of $\mathbb{k}$ is $p$ we have

$$
\binom{p}{\underline{p}} p_{i}!=\binom{p}{p_{i}}\binom{p-p_{i}}{\underline{p}(i)} p_{i}!=p\binom{p-1}{p_{i}-1}\binom{p-p_{i}}{\underline{p}(i)}\left(p_{i}-1\right)!=0,

where $\underline{p}(i)=\left(p_{1}, \ldots, p_{i-1}, p_{i+1}, \ldots, p_{n}\right) \in \mathbb{Z}_{\geq 0}^{n-1}$. Therefore, each term in $\partial_{R}^{p}(G)$ is divisible by $p$. That is, each term in $\partial_{R}^{p}\left(E_{i}\right)$ is divisible by $p$. Hence, we have $\partial_{R}^{p}\left(E_{i}\right)=0$.
2.3. The $p$-DG nilHecke algebra. We recall the nilHecke algebra and its diagrammatic description Lau08.

The nilHecke algebra $\mathrm{NH}_{n}$ is the unital algebra generated by $x_{i}(i=1, \ldots, n)$ and $\psi_{j}(j=1, \ldots, n-1)$ subject to relations

We have a graphical presentation of $\mathrm{NH}_{n}$ whose the unit $1_{\mathrm{NH}_{n}}$ is depicted as the $n$-strands, $x_{i}$ is depicted as a dot on the $i$-th strand and $\psi_{i}$ is the crossing of the $i$-th and $(i+1)$-st strands:

Multiplication in $\mathrm{NH}_{n}$ is represented by vertical concatenation of diagrams. The product $x y$ is represented as follows:


The defining relations are represented by the following diagrammatic equalities.


We denote the element $x_{i}^{a}$ by a dot with a label $a$ on the $i$-th strand.

We recall a $p$-DG structure on the nilHecke algebra KQS17.
The nilHecke algebra $\mathrm{NH}_{n}$ is a $p$-DG algebra with a $p$-derivation for the generators

By the Leibniz rule, we have

By Lemma [2.2, the differential $\partial_{\mathrm{NH}}$ is $p$-nilpotent. Moreover, the differential $\partial_{\mathrm{NH}}$ preserves the nilHecke relations (this proof is left for the reader). Hence, we have the following statement.

Proposition 2.6. The nilHecke algebra with the p-derivation $\left(\mathrm{NH}_{n}, \partial_{\mathrm{NH}}\right)$ is a $p$ - $D G$ algebra.
2.4. The $p$-DG Webster algebra of type $A_{1}$. Webster defined algebras which categorify tensor products of representations of quantum groups Web17. Here we recall Webster algebra of type $A_{1}$ and $p$-DG structure of the Webster algebra KQS17.

Let $m \geq 0$ be an integer. For a sequence of non-negative integers $\mathbf{s}=\left(s_{1}, \ldots, s_{m}\right)$, let $\operatorname{Seq}(\mathbf{s}, n)$ be the set of all sequences $\mathbf{i}=\left(i_{1}, \ldots, i_{m+n}\right)$ in which $n$ of the entries are $\mathfrak{b}$ and $s_{i}$ appears exactly once and in the order in which it appears in s. Denote by $\mathbf{i}_{j}$ the $j$-th entry of $\mathbf{i}$ and denote by $I_{\mathbf{s}}$ the set $\left\{s_{i} \mid 1 \leq i \leq m\right\}$.

Let $S_{m+n}$ be the symmetric group on $m+n$ letters generated by simple transpositions $\sigma_{1}, \ldots, \sigma_{m+n-1}$. Each transposition $\sigma_{j}$ naturally acts on a sequence $\mathbf{i}$. Note that if $\mathbf{i} \in \operatorname{Seq}(\mathbf{s}, n)$ it is not always the case that $\sigma_{j} . \mathbf{i} \in \operatorname{Seq}(\mathbf{s}, n)$.

Definition 2.7. Webster algebra $W_{n}^{\mathbf{s}}$ of type $A_{1}$ is the $\mathbb{Z}$-graded $\mathbb{k}$-algebra generated by $e(\mathbf{i})$, where $\mathbf{i} \in \operatorname{Seq}(\mathbf{s}, n), x_{j}$, where $1 \leq j \leq m+n$, and $\psi_{\ell}$, where $1 \leq \ell \leq m+n-1$, satisfying the following relations.

The degrees of the generators are

\operatorname{deg} x_{i}=2, \quad \operatorname{deg} \psi_{j} e(\mathbf{i})= \begin{cases}-2 & \text { if } \mathbf{i}_{j}=\mathfrak{b}, \mathbf{i}_{j+1}=\mathfrak{b}, \\ s & \text { if } \mathbf{i}_{j}=\mathfrak{b}, \mathbf{i}_{j+1}=s \in I_{\mathbf{s}}, \\ s & \text { if } \mathbf{i}_{j}=s \in I_{\mathbf{s}}, \mathbf{i}_{j+1}=\mathfrak{b} .\end{cases}

The generators $e(\mathbf{i})$ for $\mathbf{i} \in \operatorname{Seq}(\mathbf{s}, n)$ represent the diagram consisting entirely of vertical strands whose $j$-th strand (counting from the left for each $j$ ) is black if $\mathbf{i}_{j}$ is $\mathfrak{b}$ or thick red with $\mathbf{i}_{j}$-labeling if $\mathbf{i}_{j}$ is in $I_{\mathbf{s}}$. Dots on black strands correspond to generators $x_{j}$. A crossing of two strands corresponds to generators $\psi_{j}$.

The generators $x_{j} e(\mathbf{i})$ represents the dot on the $j$-th strand counting from the left of the $(m+n)$ strand diagram:

The generator $\psi_{j} e(\mathbf{i})$ represents the crossing diagram as follows.

Remark 2.8. Remark that a black dot on any red strand and a red-red crossing do not appear by Relation 2.6 and 2.8 .

The degrees of the generating diagrams are

In the diagrammatic description, multiplication is vertical concatenation of diagrams. The product is zero if the colors of the boundary points of one diagram do not match the colors of the boundary points of another diagram. The diagrammatic description of the Webster algebra has local relations between generators which are the nilHecke relations among black strands

and local relations among red-black strands


and the cyclotomic relation (2.17) that a diagram equals to zero if a black strand appears at the most left strand of the diagram

The $p$-derivation $\partial_{W}$ on $W_{n}^{\mathbf{s}}$ is introduced in KQ15.
The Webster algebra $W_{n}^{\mathbf{s}}$ is a $p$-DG algebra with the following $p$-derivation for generators.

By Leibniz rule, we have

\partial_{W}^{p}\left(\psi_{j} e(\mathbf{i})\right)=\prod_{a=0}^{p-1}(s+a) \psi_{j} x_{j+1}^{p} e(\mathbf{i})=0 \quad \text { if } \mathbf{i}_{j}=s \in I_{\mathbf{s}}, \mathbf{i}_{j+1}=\mathbf{b} .
$$

Therefore, the derivation $\partial_{W}$ is $p$-nilpotent for generators. Using Lemma 2.2, we have $\partial_{W}^{p}=0$ on the Webster algebra.

Moreover, we find that the derivation $\partial_{W}$ preserves the relations of the Webster algebra. Hence, we have the following statement.

Proposition 2.9. The Webster algebra of type $A_{1}$ with the $p$-derivation $\left(W_{n}^{\mathbf{s}}, \partial_{W}\right)$ is a $p-D G$ algebra.

## 3. Deformed Webster algebra $D(\mathbf{s}, n)$ and splitter bimodules

A deformation of non-cyclotomic Webster algebras of type $A_{1}$ for $\mathbf{s}=\left(1^{m}\right)$ is introduced by Khovanov and Sussan [KS18] and the deformed Webster algebra is generalized for the general sin KLSY18. In this section, we recall the deformed Webster algebras $D(\mathbf{s}, n)$, their splitter bimodules, and these diagrammatic description defined in KLSY18. In the next section, we will define a $p$-DG structure on the deformed Webster algebra of type $A_{1}$ and splitter bimodules.
3.1. Definition of $D(\mathbf{s}, n)$. Let $m \geq 0$ be an integer. For a sequence of non-negative integers $\mathbf{s}=$ $\left(s_{1}, \ldots, s_{m}\right)$, let $\operatorname{Seq}(\mathbf{s}, n)$ be the set of all sequences $\mathbf{i}=\left(i_{1}, \ldots, i_{m+n}\right)$ in which $n$ of the entries are $\mathfrak{b}$ and $s_{i}$ appears exactly once and in the order in which it appears in $\mathbf{s}$. Denote by $\mathbf{i}_{j}$ the $j$-th entry of $\mathbf{i}$ and denote by $I_{\mathrm{s}}$ the set $\left\{s_{i} \mid 1 \leq i \leq m\right\}$.

Let $S_{m+n}$ be the symmetric group on $m+n$ letters generated by simple transpositions $\sigma_{1}, \ldots, \sigma_{m+n-1}$. Each transposition $\sigma_{j}$ naturally acts on a sequence i. Note that if $\mathbf{i} \in \operatorname{Seq}(\mathbf{s}, n)$ it is not always the case that $\sigma_{j} . \mathbf{i} \in \operatorname{Seq}(\mathbf{s}, n)$.

Let $\mathbb{k}$ be a field of characteristic $p>0 . D(\mathbf{s}, n)$ is the $\mathbb{Z}$-graded $\mathbb{k}$-algebra generated by $e(\mathbf{i})$, where $\mathbf{i} \in \operatorname{Seq}(\mathbf{s}, n), x_{j}, E(d)_{j}$, where $1 \leq j \leq m+n, d \geq 1$, and $\psi_{\ell}$, where $1 \leq \ell \leq m+n-1$, satisfying the relations below. For convenience, we use the notation $E(0)_{j}=1$.

For a sequence of $m$ non-negative integers $\mathbf{s}=\left(s_{1}, s_{2}, \ldots, s_{m}\right)$, we define the sequence $\mathbf{s}^{j}$, where $j=1, \ldots, m-1$, by the sequence of $m-1$ integers obtained from $\mathbf{s}$ by replacing the pair $\left(s_{j}, s_{j+1}\right)$ with the singleton $s_{j}+s_{j+1}$ and we define the sequence $\phi_{j, a}(\mathbf{s})$, where $j=1, \ldots, m$ and $0 \leq a \leq s_{j}$, by the sequence of $m+1$ integers obtained from $\mathbf{s}$ by replacing the integer $s_{j}$ with the pair $\left(s_{j}-a, a\right)$ :

Let $\operatorname{Seq}^{j}(\mathbf{s}, n)$ be a subset of $\operatorname{Seq}(\mathbf{s}, n)$ composed of sequences $\mathbf{i}=\left(i_{1}, \ldots, i_{m+n}\right)$ in which $s_{j}$ is neighbor to $s_{j+1}$, that is there is $1 \leq k \leq m+n-1$ such that $\mathbf{i}_{k}=s_{j}$ and $\mathbf{i}_{k+1}=s_{j+1}$, and put

First note that the inclusion $\Phi_{j, s_{j+1}}$ determines the left action of $D\left(\mathbf{s}^{j}, n\right)$ on $\widehat{e_{j}} D(\mathbf{s}, n)$ and the right action on $D(\mathbf{s}, n) \widehat{e_{j}}$. 3.4. Diagrammatic description. The generators $e(\mathbf{i})$ for $\mathbf{i} \in \operatorname{Seq}(\mathbf{s}, n)$ represent the diagram consisting entirely of vertical strands whose $j$-th strand (counting from the left for each $j$ ) is black if $\mathbf{i}_{j}$ is $\mathfrak{b}$ or thick red with $\mathbf{i}_{j}$-labeling if $\mathbf{i}_{j}$ is in $I_{\mathbf{s}}$.

The generators $x_{j} e(\mathbf{i})$ and $E(d)_{j} e(\mathbf{i})$ represent the dot on the $j$-th strand counting from the left of the $(m+n)$ strand diagram:

The elements $D(\mathbf{s}, n)$ are formal $\mathbb{k}$-linear combinations of these diagrams modulo isotopy, nilHecke relations, and the following local relations. We give the algebra structure of $D(\mathbf{s}, n)$ by concatenating diagrams vertically when the colors on the endpoints of two diagrams match.

The tensor products of splitter bimodules are diagrammatically represented by concatenating trivalent diagrams with $n$ black strands.

4. A $p$-DG structure on deformed Webster algebra $D(\mathbf{s}, n)$ of type $A_{1}$
4.1. A $p$-derivation on the deformed Webster $p$-DG algebra $D(s, n)$ of type $A_{1}$. We define a derivation $\partial_{D}: D(\mathbf{s}, n) \rightarrow D(\mathbf{s}, n)$ with degree 2 by

By the Leibniz rule, we extend the $p$-DG structure to the algebra $D(\mathbf{s}, n)$.
We will show that this $p$-derivation $\partial_{D}$ preserves double and triple red, double-black relations.
Theorem 4.1. The deformed Webster algebra of type $A_{1}$ with the $p$-derivation $\left(D(\mathbf{s}, n), \partial_{D}\right)$ is a $p-D G$ algebra.
Proof. • Differential map: First, we show the derivation preserves relations of $D(\mathbf{s}, n)$. It is enough to show that the derivation preserves relations (3.19) and (3.20) of $D(\mathbf{s}, n)$ since it is easy to check that the derivation preserves other relations of $D(\mathbf{s}, n)$.

Relation (3.19): We have

= & \mathbf{i}_{j+1} x_{j}^{\mathbf{i}_{j+1}+1} e(\mathbf{i})+\sum_{d=0}^{\mathbf{i}_{j+1}-1}(-1)^{d+1} x_{j}^{\mathbf{i}_{j+1}-d}\left(\mathbf{i}_{j+1} E(d+1)_{j+1}-E(1)_{j+1} E(d)_{j+1}\right) e(\mathbf{i})  \tag{4.7}\\
& +(-1)^{\mathbf{i}_{j+1}} E(1)_{j+1} E\left(\mathbf{i}_{j+1}\right)_{j+1} e(\mathbf{i})
\end{align*}
$$

On the other hand, the derivation of the right-hand is

$$
\begin{aligned}
& \sum_{d=0}^{\mathbf{i}_{j+1}}(-1)^{d}\left(E(1)_{j+1} E(d)_{j+1}-(d+1) E(d+1)_{j+1}\right) x_{j}^{\mathbf{i}_{j+1}-d} e(\mathbf{i}) \\
& +\sum_{d=0}^{\mathbf{i}_{j+1}}(-1)^{d}\left(\mathbf{i}_{j+1}-d\right) E(d)_{j+1} x_{j}^{\mathbf{i}_{j+1}-d+1} e(\mathbf{i})
\end{aligned}
$$

We find this is equal to the element (4.7). When $\mathbf{i}_{j} \in I_{\mathrm{s}}$ and $\mathbf{i}_{j+1}=\mathfrak{b}$, the derivation preserves the relation (3.19) by a similar calculation.
Relation (3.20): We show that the derivation preserves the relation (3.20) in the case of $\mathbf{i}_{j+1} \in I_{\mathbf{s}}, \mathbf{i}_{j}=$ $\mathbf{i}_{j+2}=\mathfrak{b}$. It is easy to find the derivation preserves the relation (3.20) in other cases.

It is suffice to show that

$$
\partial_{D}\left(\psi_{1} \psi_{2} \psi_{1} e(\mathbf{b} s \mathbf{b})-\psi_{2} \psi_{1} \psi_{2} e(\mathbf{b} s \mathbf{b})\right)=\sum_{d_{1}+d_{2}+d_{3}=s-1}(-1)^{d_{3}} \partial_{D}\left(x_{1}^{d_{1}} E\left(d_{3}\right)_{2} x_{3}^{d_{2}} e(\mathbf{b} s \mathbf{b})\right)
$$

The left-hand side is

$$
\begin{aligned}
& \partial_{D}\left(\psi_{1} e(s \mathbf{b b}) \psi_{2} e(s \mathbf{b b}) \psi_{1} e(\mathbf{b} s \mathbf{b})-\psi_{2} e(\mathbf{b} b s) \psi_{1} e(\mathbf{b} b s) \psi_{2} e(\mathbf{b} s \mathbf{b})\right) \\
= & \partial_{D}\left(\psi_{1} e(s \mathbf{b b})\right) \psi_{2} e(s \mathbf{b b}) \psi_{1} e(\mathbf{b} s \mathbf{b})+\psi_{1} e(s \mathbf{b b}) \partial_{D}\left(\psi_{2} e(s \mathbf{b b})\right) \psi_{1} e(\mathbf{b} s \mathbf{b})+\psi_{1} e(s \mathbf{b b}) \psi_{2} e(s \mathbf{b}) \partial_{D}\left(\psi_{1} e(\mathbf{b} s \mathbf{b})\right) \\
= & -\partial_{D}\left(\psi_{2} e(\mathbf{b b} s)\right) \psi_{1} e(\mathbf{b b} s) \psi_{2} e(\mathbf{b} s \mathbf{b})-\psi_{2} e(\mathbf{b b} s) \partial_{D}\left(\psi_{1} e(\mathbf{b b} s)\right) \psi_{2} e(\mathbf{b} s \mathbf{b})-\psi_{2} e(\mathbf{b b} s) \psi_{1} e(\mathbf{b b} s) \partial_{D}\left(\psi_{2} e(\mathbf{b} s \mathbf{b})\right) \\
= & s x_{1} \psi_{1} \psi_{2} \psi_{1} e(\mathbf{b} s \mathbf{b})-x_{2} \psi_{1} \psi_{2} \psi_{1} e(\mathbf{b} s \mathbf{b})-\psi_{1} \psi_{2} x_{3} \psi_{1} e(\mathbf{b} s \mathbf{b})+\psi_{1} \psi_{2} \psi_{1} E(1)_{2} e(\mathbf{b} s \mathbf{b}) \\
& -E(1)_{2} \psi_{2} \psi_{1} \psi_{2} e(\mathbf{b} s \mathbf{b})+\psi_{2} x_{1} \psi_{1} \psi_{2} e(\mathbf{b} s \mathbf{b})+\psi_{2} \psi_{1} x_{2} \psi_{2} e(\mathbf{b} s \mathbf{b})-\psi_{2} \psi_{1} s \psi_{2} x_{3} e(\mathbf{b} s \mathbf{b}) .
\end{aligned}
$$

The right-hand side is

$$
= \begin{cases}\sum_{d_{1}+d_{2}+d_{3}=\mathbf{i}_{j+1}-1}(-1)^{d_{3}} x_{j}^{d_{1}} E\left(d_{3}\right)_{j+1} x_{j+2}^{d_{2}} e(\mathbf{i}) & \text { if } \mathbf{i}_{j+1}=1, \mathbf{i}_{j}=\mathbf{i}_{j+2}=\mathfrak{b} \\ 0 & \text { otherwise }\end{cases}
$$

Next, we show the derivation $\partial_{D}$ is $p$-nilpotent for generators.

- p-nilpotency: In proof of Proposition 2.5 and 2.6, we showed that the derivation $\partial_{D}$ is $p$-nilpotent for generators $x_{j}, E(d)_{j}$ and $\psi_{j} e(\mathbf{i})$ when $\mathbf{i}_{j}=\mathbf{i}_{j+1}=\mathfrak{b}$.

In the case of $\mathbf{i}_{j} \in I_{\mathbf{s}}$ and $\mathbf{i}_{j+1}=\mathfrak{b}$, we have

$$
\partial_{D}^{p}\left(\psi_{j} e(\mathbf{i})\right)=\partial_{D}^{p-1}\left(s \psi_{j} x_{j+1} e(\mathbf{i})\right)=\partial_{D}^{p-2}\left(s(s+1) \psi_{j} x_{j+1}^{2} e(\mathbf{i})\right)=\cdots=\prod_{a=0}^{p-1} a \psi_{j} x_{j+1}^{p} e(\mathbf{i})=0
$$

In the case of $\mathbf{i}_{j}=\mathfrak{b}$ and $\mathbf{i}_{j+1} \in I_{\mathbf{s}}$, we have

$$
\partial_{D}^{2}\left(\psi_{j} e(\mathbf{i})\right)=\partial_{D}\left(\psi_{j} E(1)_{j+1} e(\mathbf{i})\right)=2 \psi_{j}\left(E(1)_{j+1}^{2}-E(2)_{j+1}\right) e(\mathbf{i})=2 \psi_{j} H(2)_{j+1} e(\mathbf{i})
$$

where $H(2)_{j+1}$ is the expression of the second complete symmetric function in the elementary symmetric functions. By the induction hypothesis, we have

$$
\partial_{D}^{p}\left(\psi_{j} e(\mathbf{i})\right)=\prod_{a=1}^{p}(a+1) \psi_{j} H(p+1)_{j+1} e(\mathbf{i})=0
$$

where $H(p+1)_{j+1}$ is the expression of the $p+1$-th complete symmetric function in the elementary symmetric functions. Using Lemma 2.2, we have $\partial_{D}^{p}=0$ on the deformed Webster algebra $D(\mathbf{s}, n)$.
4.2. $p$-DG structure on splitter bimodules $\triangle^{j}(\mathbf{s})$ and $\nabla^{j}(\mathbf{s})$. We define derivations $\partial_{\triangle}: \triangle^{j}(\mathbf{s}) \rightarrow$ $\triangle^{j}(\mathbf{s})$ and $\partial_{\nabla}(\mathbf{s}): \nabla^{j}(\mathbf{s}) \rightarrow \nabla^{j}(\mathbf{s})$ by $\partial_{D} \otimes \mathrm{id}+\mathrm{id} \otimes \partial_{D}$.

By definition, these derivations have $p$-nilpotency. We show the equality

$$
\partial_{\triangle}\left(E(i)_{j} \otimes 1\right)=\partial_{\triangle}\left(1 \otimes \sum_{a+b=i} E(a)_{j} E(b)_{j+1}\right)
$$

for $1 \leq i \leq s_{j}+s_{j+1}$.
The left-hand side equals to

$$
\begin{aligned}
\left(E(1)_{j} E(i)_{j}-(i+1) E(i+1)_{j}\right) \otimes 1= & 1 \otimes\left(E(1)_{j}+E(1)_{j+1}\right) \sum_{a+b=i} E(a)_{j} E(b)_{j+1} \\
& -1 \otimes \sum_{a+b=i+1}(i+1) E(a)_{j} E(b)_{j+1}
\end{aligned}
$$

By a direct calculation, we find that the right-hand side equals to

$$
\begin{aligned}
& 1 \otimes \sum_{\substack{a+b=i \\
a \geq 1}} \partial_{D}\left(E(a)_{j}\right) E(b)_{j+1}+1 \otimes \sum_{\substack{a+b=i \\
b \geq 1}} E(a)_{j} \partial_{D}\left(E(b)_{j+1}\right) \\
= & 1 \otimes \sum_{\substack{a+b=i \\
a \geq 1}}\left(E(1)_{j} E(a)_{j}-(a+1) E(a+1)_{j}\right) E(b)_{j+1} \\
& +1 \otimes \sum_{\substack{a+b=i \\
b \geq 1}} E(a)_{j}\left(E(1)_{j+1} E(b)_{j+1}-(b+1) E(b+1)_{j+1}\right) \\
= & 1 \otimes\left(E(1)_{j}+E(1)_{j+1}\right) \sum_{a+b=i} E(a)_{j} E(b)_{j+1} \\
& -1 \otimes \sum_{a+b=i+1}(i+1) E(a)_{j} E(b)_{j+1} .
\end{aligned}
$$

By a similar way, we have the equality

$$
\partial_{\nabla}\left(1 \otimes E(i)_{j}\right)=\partial_{\nabla}\left(\sum_{a+b=i} E(a)_{j} E(b)_{j+1} \otimes 1\right)
$$

for $1 \leq i \leq s_{j}+s_{j+1}$.
Hence, we have the following statement.
Theorem 4.2. The splitter bimodules with the p-derivation $\left(\triangle^{j}(\mathbf{s}), \partial_{\triangle}\right)$ and $\left(\nabla^{j}(\mathbf{s}), \partial_{\nabla}\right)$ are $p-D G$ modules.
4.3. Relation to $p$-DG structure on Webster algebra. Let $I$ be the two sided ideal generated by $\left\{E(d)_{j}, e(\mathbf{i}) \mid 1 \leq j \leq m+n, d \geq 1, \mathbf{i}_{1}=\mathbf{b}\right\}$. The quotient algebra $D(\mathbf{s}, n) / I$ is isomorphic to the Webster algebra $W_{n}^{\mathbf{s}}$ of type $A_{1}$. Therefore, taking this quotient, the $p$-DG algebra $\left(D(\mathbf{s}, n), \partial_{D}\right)$ naturally induces a $p$-DG structure on Webster algebra $W_{n}^{\mathbf{s}}$.

Corollary 4.3. The $p-D G$ algebra $\left(D(\mathbf{s}, n) / I, \partial_{D}\right)$ is isomorphic to the $p-D G$ algebra $\left(W_{n}^{\mathbf{s}}, \partial_{W}\right)$ defined in Section 2.4.

It is easy to find that $\partial_{D}$ on $D(\mathbf{s}, n) / I$ is equivalent to $\partial_{W}$ defined in Section 2.4.
