# The Minimal Abstract Robust Subdifferential 

M.D. Voisei


#### Abstract

This paper introduces new subdifferential concepts together with their main properties and place with respect to other subdifferential notions.


## 1 The minimality of the core subdifferential

Let $(X, s)$ be a real metrizable topological vector space with topological dual space $X^{*}$ and duality product $\left\langle x, x^{*}\right\rangle:=x^{*}(x), x \in X, x^{*} \in X^{*}$. Let $d$ be a (non necessarily translationinvariant) metric on $X$ compatible with $s$, that is, $d$ generates the linear topology $s$ of $X$. Denote by $B_{d}(x ; r):=\{y \in X \mid d(x, y) \leq r\}$ the closed ball centered at $x$ with radius $r \geq 0$.

In the sequel a set-valued operator is denoted by $T: A \rightrightarrows B, T(a) \subset B, a \in A$ while $\operatorname{Graph}(T):=\{(a, b) \in A \times B \mid b \in T(a)\}$ stands for its graph.

Definition 1 The core subdifferential, ð : $\overline{\mathbb{R}}^{X} \times X \rightrightarrows X^{*}$ is denoted by $ð\left(f, x_{0}\right)=: ð f\left(x_{0}\right)$, for $f \in \overline{\mathbb{R}}^{X}:=\{g: X \rightarrow \overline{\mathbb{R}}\}, x_{0} \in X$.

By a subdifferential $\partial$ we understand any $\partial: \overline{\mathbb{R}}^{X} \times X \rightrightarrows X^{*}$.
The convergence of a sequence $\left(x_{n}\right)_{n}$ in $(X, s)$ is denoted by $x_{n} \rightarrow^{s} x$. Similar notations are made for net or sequence convergences in $X$ or $X^{*}$ endowed with various topologies.

Let $\mu^{*}$ be a linear topology on $X^{*}$ and let $\partial: \overline{\mathbb{R}}^{X} \times X \rightrightarrows X^{*}$ be a subdifferential. For $x \in X$, consider the class of functions $S_{\mu^{*}}(\partial, x) \subset \overline{\mathbb{R}}^{X}$ given by: $L \in S_{\mu^{*}}(\partial, x)$ if there exist $M$ a $\mu^{*}$-bounded subset of $X^{*}$ and $V$ a neighborhood of $x$ such that $L$ is lower semicontinuous on $V$ (1.s.c. near $x$ for short) and for every $y \in V, \lambda \geq 0, x^{*} \in X^{*}$

$$
\begin{equation*}
\partial\left(L+x^{*}+\lambda d(\cdot, y)\right)(y) \subset \partial L(y)+x^{*}+\lambda M . \tag{1}
\end{equation*}
$$

Theorem 2 Let $(X, s)$ be a metrizable topological vector space and let d be a compatible metric on $X$ such that $(X, d)$ is a complete metric space. Let $\mu^{*}$ be a linear topology on $X^{*}$ and let $\partial: \overline{\mathbb{R}}^{X} \times X \rightrightarrows X^{*}$ be a subdifferential with the property:
$[\mathbf{M}]$ For every $L: X \rightarrow \overline{\mathbb{R}}$, if $x_{0}$ is a local minimum of $L$ and $L\left(x_{0}\right) \in \mathbb{R}$ then $0 \in \partial L\left(x_{0}\right)$.
Then for every $x \in X, L \in S_{\mu^{*}}(\partial, x)$,

$$
\partial L(x) \subset s \times \mu^{*}-\limsup _{y \rightarrow x} \partial L(y) .
$$

Here $x^{*} \in s \times \mu^{*}-\lim \sup _{y \rightarrow x} \partial L(y)$ if there exists a sequence $\left\{\left(y_{n}, y_{n}^{*}\right)\right\}_{n} \subset \operatorname{Graph}(\partial L)$ such that $y_{n} \rightarrow^{s} x$ in $X$, $y_{n}^{*} \rightarrow^{\mu^{*}} x^{*}$ in $X^{*}$, as $n \rightarrow \infty$, and $\lim _{n \rightarrow \infty} L\left(y_{n}\right)=L(x)$.

Remark 3 Most of the time the subdifferential $\partial: \overline{\mathbb{R}}^{X} \times X \rightrightarrows X^{*}$ satisfies a sum rule of the form

$$
\begin{equation*}
\left.\partial\left(L+x^{*}+\lambda d(\cdot, y)\right)(y) \subset \partial L(y)+x^{*}+\lambda \partial d(\cdot, y)\right)(y), \tag{2}
\end{equation*}
$$

together with $\partial d(\cdot, y))(y)$ is $\mu^{*}$-bounded, for some linear topology $\mu^{*}$ of $X^{*}$.
For example when $(X,\|\cdot\|)$ is a normed space and $d(x, y):=\|x-y\|, x, y \in X$ then $\partial d(\cdot, y))(y)=\partial d(\cdot, 0))(0)=B_{X^{*}}(0 ; 1):=\left\{x^{*} \in X^{*} \mid\left\|x^{*}\right\| \leq 1\right\}$ is strongly bounded whenever $\partial$ coincides with the Fenchel subdifferential on the class of convex continuous functions.

Recall that for $(X,\|\cdot\|)$ a Banach space we call an abstract subdifferential or quasi presubdifferential on $\emptyset \neq \mathcal{F} \subset \overline{\mathbb{R}}^{X}$ (see [1, p. 128] or [2, p. 178]) a multifunction $\partial: \overline{\mathbb{R}}^{X} \times X \rightrightarrows X^{*}$ with the property:
[P] If $f \in \mathcal{F}, g: X \rightarrow \mathbb{R}$ is convex continuous, $x \in X$ are such that $f(x)$ is finite and $x$ is a local minimum of $f+g$ then

$$
\begin{equation*}
0 \in \limsup _{y \rightarrow x} \partial f(y)+Ә g(x) . \tag{3}
\end{equation*}
$$

Here "Ə" stands for the Fenchel (convex) subdifferential, $s$ is the strong topology of $X$, and $\limsup _{y \rightarrow x} \partial f(y)$ is the sequential $s \times w^{*}-$ limit superior defined in Theorem 2,

In a normed space $(X,\|\cdot\|)$ we use the simplified notation $B\left(x_{0} ; r\right):=\left\{x \in X \mid\left\|x-x_{0}\right\| \leq\right.$ $\delta\}, r>0$ and " $\rightarrow$ " for the strong convergences in $X$ or $X^{*}$.

Theorem 4 Let $(X,\|\cdot\|)$ be a Banach space and let $\partial: \overline{\mathbb{R}}^{X} \times X \rightrightarrows X^{*}$ be an abstract subdifferential on $\mathcal{F}$. Then for every $x \in X$ and $L \in \mathcal{F}$ that is l.s.c. near $x$,

$$
\begin{equation*}
\partial L(x) \subset \underset{y \rightarrow x}{\limsup } \partial L(y) . \tag{4}
\end{equation*}
$$

## 2 Definition, properties, and a sum rule

Theorem 5 Let $(X, s)$ be a metrizable topological vector space and let d be a compatible metric on $X$. Let $f, g: X \rightarrow \overline{\mathbb{R}}$.
(a) For every $x \in X, ~ Ə f(x) \subset \partial f(x)$. If, in addition, $f$ is convex then, for every $x \in X$, $\partial f(x)=$ Ə $f(x)$.
(b) If $x$ is a local minimum of $f$ then $0 \in \precsim f(x)$.
(c) If $\partial f(x) \neq \emptyset$ then $f$ is l.s.c. at $x$.
(d) If $g=f$ near $x$ then $\partial g(x)=\varnothing f(x)$.

If, in addition, $(X,\|\cdot\|)$ is a normed space then
(e) For every $x \in X, ð f(x)$ is closed.
(f) If $g(x)=f\left(x+x_{0}\right), x \in X$ then $\partial g(0)=\partial f\left(x_{0}\right)$.
(g) For every $x_{0}^{*} \in X^{*}, \lambda>0, \check{\partial}\left(\lambda f+x_{0}^{*}\right)\left(x_{0}\right)=\lambda ð f\left(x_{0}\right)+x_{0}^{*}$.

Remark 6 The core subdifferential can differ from the Fenchel subdifferential. Take $(X,\|\cdot\|)$ a normed space and $S:=\{x \in X \mid\|x\|=1\} \cup\{0\}$. Then $\partial \iota_{S}(x)=\{0\}$ while $\iota_{S}(x)=X^{*}$. Indeed, $x_{0}=0$ is a global minimum point of $\iota_{S}$ so $0 \in \iota^{\prime}(0)$; whence

$$
\begin{gathered}
\partial \iota_{S}(0)=\text { Ə cl co } \iota_{S}(0)=\partial \iota_{B(0 ; 1)}(0)=\{0\} ; \\
\partial \iota_{S}(0)=X^{*} \neq \varnothing \mathrm{cl} \operatorname{co} \iota_{S}(0)=\partial \iota_{B(0 ; 1)}(0)=\partial \iota_{B(0 ; 1)}(0)=\{0\} .
\end{gathered}
$$

Remark 7 Note first that

$$
\begin{equation*}
\partial(-\|\cdot\|)(0)=\emptyset . \tag{5}
\end{equation*}
$$

Relation (5) shows that a sum rule of the form

$$
ð(f+g)(x) \subset \partial f(x)+ð g(x)
$$

for every g convex continuous and $f$ Lipschitz continuous, cannot hold because it does not hold for $f=-\|\cdot\|, g=\|\cdot\|, x=0$.

Similarly, a rule of the form

$$
0 \in ð f(x)+ð g(x)
$$

whenever $x$ is a local minimum point of $f+g$, $f$ is Lipschitz continuous and $g$ convex continuous, does not hold under the same counterexample.

Proposition 8 Let $(X,\|\cdot\|)$ be a normed space and let $x_{0} \in X, g: X \rightarrow \overline{\mathbb{R}}$.
(a) If $x_{0}$ is a local maximum point of $g$ then $\partial g\left(x_{0}\right) \subset\{0\}$.
(b) If $g$ is Gateaux differentiable at $x_{0}$ then $\partial g\left(x_{0}\right) \subset\left\{\nabla g\left(x_{0}\right)\right\}$. Here $\nabla g\left(x_{0}\right)$ denotes the Gateaux derivative of $g$ at $x_{0}$.
(c) If $g$ is Fréchet differentiable at $x_{0}$ then $\partial g\left(x_{0}\right)=\left\{\nabla g\left(x_{0}\right)\right\}$. Here $\nabla g\left(x_{0}\right)$ denotes the Fréchet derivative of $g$ at $x_{0}$.
(d) If $g$ is proper convex and $\varnothing(-g)\left(x_{0}\right) \neq \emptyset$ then $g$ is Fréchet differentiable at $x_{0}$ and $ð g\left(x_{0}\right)=-ð(-g)\left(x_{0}\right)=\left\{\nabla g\left(x_{0}\right)\right\}$.

Lemma 9 Let $(X,\|\cdot\|)$ be a normed space and let $f: X \rightarrow \overline{\mathbb{R}}, g: X \rightarrow \mathbb{R} \cup\{+\infty\}$. If $x_{0} \in X$ is a local minimum point of $f+g$ and $f\left(x_{0}\right) \in \mathbb{R}$ then $\partial(-g)\left(x_{0}\right) \subset ð f\left(x_{0}\right)$.

Theorem 10 Let $(X,\|\cdot\|)$ be a normed space and let $f, g: X \rightarrow \overline{\mathbb{R}}$. If $x_{0} \in X$ is a local minimum point of $f+g$, $g$ is proper convex, and $\varnothing(-g)\left(x_{0}\right) \neq \emptyset$ then $0 \in ð f\left(x_{0}\right)+ð g\left(x_{0}\right)$.
