# The Minimal Abstract Robust Subdifferential

#### Abstract

This paper introduces new subdifferential concepts together with their main properties and place with respect to other subdifferential notions.

#### 1 The minimality of the core subdifferential

Let (X, s) be a real metrizable topological vector space with topological dual space  $X^*$  and duality product  $\langle x, x^* \rangle := x^*(x), x \in X, x^* \in X^*$ . Let d be a (non necessarily translationinvariant) metric on X compatible with s, that is, d generates the linear topology s of X. Denote by  $B_d(x; r) := \{y \in X \mid d(x, y) \leq r\}$  the closed ball centered at x with radius  $r \geq 0$ .

In the sequel a set-valued operator is denoted by  $T : A \rightrightarrows B$ ,  $T(a) \subset B$ ,  $a \in A$  while  $\operatorname{Graph}(T) := \{(a,b) \in A \times B \mid b \in T(a)\}$  stands for its graph.

**Definition 1** The core subdifferential,  $\eth : \overline{\mathbb{R}}^X \times X \rightrightarrows X^*$  is denoted by  $\eth(f, x_0) =: \eth f(x_0)$ , for  $f \in \overline{\mathbb{R}}^X := \{g : X \to \overline{\mathbb{R}}\}, x_0 \in X$ .

By a subdifferential  $\partial$  we understand any  $\partial : \overline{\mathbb{R}}^X \times X \rightrightarrows X^*$ .

The convergence of a sequence  $(x_n)_n$  in (X, s) is denoted by  $x_n \to^s x$ . Similar notations are made for net or sequence convergences in X or  $X^*$  endowed with various topologies.

Let  $\mu^*$  be a linear topology on  $X^*$  and let  $\partial : \overline{\mathbb{R}}^X \times X \rightrightarrows X^*$  be a subdifferential. For  $x \in X$ , consider the class of functions  $S_{\mu^*}(\partial, x) \subset \overline{\mathbb{R}}^X$  given by:  $L \in S_{\mu^*}(\partial, x)$  if there exist M a  $\mu^*$ -bounded subset of  $X^*$  and V a neighborhood of x such that L is lower semicontinuous on V (l.s.c. near x for short) and for every  $y \in V$ ,  $\lambda \ge 0$ ,  $x^* \in X^*$ 

$$\partial(L + x^* + \lambda d(\cdot, y))(y) \subset \partial L(y) + x^* + \lambda M.$$
(1)

**Theorem 2** Let (X, s) be a metrizable topological vector space and let d be a compatible metric on X such that (X, d) is a complete metric space. Let  $\mu^*$  be a linear topology on  $X^*$  and let  $\partial : \overline{\mathbb{R}}^X \times X \rightrightarrows X^*$  be a subdifferential with the property:

**[M]** For every  $L: X \to \overline{\mathbb{R}}$ , if  $x_0$  is a local minimum of L and  $L(x_0) \in \mathbb{R}$  then  $0 \in \partial L(x_0)$ .

Then for every  $x \in X$ ,  $L \in S_{\mu^*}(\partial, x)$ ,

$$\eth L(x) \subset s \times \mu^* - \limsup_{y \to x} \partial L(y).$$

Here  $x^* \in s \times \mu^* - \limsup_{y \to x} \partial L(y)$  if there exists a sequence  $\{(y_n, y_n^*)\}_n \subset \operatorname{Graph}(\partial L)$  such that  $y_n \to^s x$  in  $X, y_n^* \to^{\mu^*} x^*$  in  $X^*$ , as  $n \to \infty$ , and  $\lim_{n \to \infty} L(y_n) = L(x)$ .

**Remark 3** Most of the time the subdifferential  $\partial : \overline{\mathbb{R}}^X \times X \rightrightarrows X^*$  satisfies a sum rule of the form

$$\partial(L + x^* + \lambda d(\cdot, y))(y) \subset \partial L(y) + x^* + \lambda \partial d(\cdot, y))(y), \tag{2}$$

together with  $\partial d(\cdot, y))(y)$  is  $\mu^*$ -bounded, for some linear topology  $\mu^*$  of  $X^*$ .

For example when  $(X, \|\cdot\|)$  is a normed space and  $d(x, y) := \|x - y\|$ ,  $x, y \in X$  then  $\partial d(\cdot, y)(y) = \partial d(\cdot, 0)(0) = B_{X^*}(0; 1) := \{x^* \in X^* \mid \|x^*\| \le 1\}$  is strongly bounded whenever  $\partial$  coincides with the Fenchel subdifferential on the class of convex continuous functions.

Recall that for  $(X, \|\cdot\|)$  a Banach space we call an *abstract subdifferential* or *quasi presubdifferential* on  $\emptyset \neq \mathcal{F} \subset \overline{\mathbb{R}}^X$  (see [1, p. 128] or [2, p. 178]) a multifunction  $\partial : \overline{\mathbb{R}}^X \times X \rightrightarrows X^*$ with the property:

**[P]** If  $f \in \mathcal{F}$ ,  $g: X \to \mathbb{R}$  is convex continuous,  $x \in X$  are such that f(x) is finite and x is a local minimum of f + g then

$$0 \in \limsup_{y \to x} \partial f(y) + \mathfrak{S}g(x). \tag{3}$$

Here " $\mathfrak{D}$ " stands for the Fenchel (convex) subdifferential, s is the strong topology of X, and  $\limsup_{y\to x} \partial f(y)$  is the sequential  $s \times w^*$ -limit superior defined in Theorem 2.

In a normed space  $(X, \|\cdot\|)$  we use the simplified notation  $B(x_0; r) := \{x \in X \mid \|x - x_0\| \le \delta\}, r > 0$  and " $\rightarrow$ " for the strong convergences in X or  $X^*$ .

**Theorem 4** Let  $(X, \|\cdot\|)$  be a Banach space and let  $\partial : \overline{\mathbb{R}}^X \times X \Rightarrow X^*$  be an abstract subdifferential on  $\mathcal{F}$ . Then for every  $x \in X$  and  $L \in \mathcal{F}$  that is l.s.c. near x,

$$\eth L(x) \subset \limsup_{y \to x} \eth L(y).$$
(4)

### 2 Definition, properties, and a sum rule

**Theorem 5** Let (X, s) be a metrizable topological vector space and let d be a compatible metric on X. Let  $f, g: X \to \overline{\mathbb{R}}$ .

(a) For every  $x \in X$ ,  $\Im f(x) \subset \Im f(x)$ . If, in addition, f is convex then, for every  $x \in X$ ,  $\Im f(x) = \Im f(x)$ .

- (b) If x is a local minimum of f then  $0 \in \eth f(x)$ .
- (c) If  $\partial f(x) \neq \emptyset$  then f is l.s.c. at x.
- (d) If g = f near x then  $\eth g(x) = \eth f(x)$ .
- If, in addition,  $(X, \|\cdot\|)$  is a normed space then
- (e) For every  $x \in X$ ,  $\eth f(x)$  is closed.
- (f) If  $g(x) = f(x + x_0)$ ,  $x \in X$  then  $\partial g(0) = \partial f(x_0)$ .
- (g) For every  $x_0^* \in X^*$ ,  $\lambda > 0$ ,  $\eth(\lambda f + x_0^*)(x_0) = \lambda \eth f(x_0) + x_0^*$ .

**Remark 6** The core subdifferential can differ from the Fenchel subdifferential. Take  $(X, \|\cdot\|)$ a normed space and  $S := \{x \in X \mid \|x\| = 1\} \cup \{0\}$ . Then  $\mathfrak{O}\iota_S(x) = \{0\}$  while  $\mathfrak{O}\iota_S(x) = X^*$ . Indeed,  $x_0 = 0$  is a global minimum point of  $\iota_S$  so  $0 \in \mathfrak{O}\iota_S(0)$ ; whence

$$\mathfrak{d}\iota_S(0) = \mathfrak{d}\operatorname{cl}\operatorname{co}\iota_S(0) = \mathfrak{d}\iota_{B(0;1)}(0) = \{0\};$$
  
$$\mathfrak{d}\iota_S(0) = X^* \neq \mathfrak{d}\operatorname{cl}\operatorname{co}\iota_S(0) = \mathfrak{d}\iota_{B(0;1)}(0) = \mathfrak{d}\iota_{B(0;1)}(0) = \{0\}$$

Remark 7 Note first that

$$\eth(-\|\cdot\|)(0) = \emptyset. \tag{5}$$

Relation (5) shows that a sum rule of the form

$$\eth(f+g)(x) \subset \eth f(x) + \eth g(x)$$

for every g convex continuous and f Lipschitz continuous, cannot hold because it does not hold for  $f = -\|\cdot\|$ ,  $g = \|\cdot\|$ , x = 0.

Similarly, a rule of the form

$$0 \in \eth f(x) + \eth g(x)$$

whenever x is a local minimum point of f + g, f is Lipschitz continuous and g convex continuous, does not hold under the same counterexample.

**Proposition 8** Let  $(X, \|\cdot\|)$  be a normed space and let  $x_0 \in X, g: X \to \overline{\mathbb{R}}$ .

(a) If  $x_0$  is a local maximum point of g then  $\eth g(x_0) \subset \{0\}$ .

(b) If g is Gateaux differentiable at  $x_0$  then  $\eth g(x_0) \subset \{\nabla g(x_0)\}$ . Here  $\nabla g(x_0)$  denotes the Gateaux derivative of g at  $x_0$ .

(c) If g is Fréchet differentiable at  $x_0$  then  $\eth g(x_0) = \{\nabla g(x_0)\}$ . Here  $\nabla g(x_0)$  denotes the Fréchet derivative of g at  $x_0$ .

(d) If g is proper convex and  $\eth(-g)(x_0) \neq \emptyset$  then g is Fréchet differentiable at  $x_0$  and  $\eth(x_0) = -\eth(-g)(x_0) = \{\nabla g(x_0)\}.$ 

**Lemma 9** Let  $(X, \|\cdot\|)$  be a normed space and let  $f : X \to \overline{\mathbb{R}}$ ,  $g : X \to \mathbb{R} \cup \{+\infty\}$ . If  $x_0 \in X$  is a local minimum point of f + g and  $f(x_0) \in \mathbb{R}$  then  $\eth(-g)(x_0) \subset \eth f(x_0)$ .

**Theorem 10** Let  $(X, \|\cdot\|)$  be a normed space and let  $f, g : X \to \overline{\mathbb{R}}$ . If  $x_0 \in X$  is a local minimum point of f + g, g is proper convex, and  $\eth(-g)(x_0) \neq \emptyset$  then  $0 \in \eth f(x_0) + \eth g(x_0)$ .
