# The isomorphism types of parabolic subgroups in Kac-Moody groups*

#### Abstract

In this paper we discuss the isomorphism types of parabolic subgroups in Kac-Moody groups. The results have applications in the study of topology of Kac-Moody groups and their classifying spaces.

## 1 Introduction

Let $A=\left(a_{i j}\right)$ be an $n \times n$ integer matrix which satisfies
(1) $a_{i i}=2$, for $1 \leq i \leq n$;
(2) $a_{i j} \leq 0$, for $1 \leq i \neq j \leq n$; ;
(3) $a_{i j}=0$ if and only if $a_{j i}=0$,
then $A$ is called a Cartan matrix.
For a Cartan matrix $A$, let $h$ be the complex vector space with basis $\Pi^{\vee}=\left\{\alpha_{1}^{\vee}, \alpha_{2}^{\vee}, \cdots, \alpha_{n}^{\vee}\right\}$. We denote the dual basis of $\Pi^{\vee}$ in the dual vector space $h^{*}$ by $\left\{\omega_{1}, \omega_{2}, \cdots, \omega_{n}\right\}$, i.e. $\omega_{i}\left(\alpha_{j}^{\vee}\right)=\delta_{i j}$ for $1 \leq i, j \leq n$. Let $\Pi=\left\{\alpha_{1}, \cdots, \alpha_{n}\right\} \subset h^{*}$ be given by $\left\langle\alpha_{i}^{\vee}, \alpha_{j}\right\rangle=a_{i j}$ for all $i, j$, then $\alpha_{i}=\sum_{j=1}^{n} a_{j i} \omega_{j}$. When the Cartan matrix $A$ is singular, then $\left\{\alpha_{i}, 1 \leq i \leq n\right\}$ is not a basis of $h^{*} . \alpha_{i}, \alpha_{i}^{\vee}, \omega_{i}, 1 \leq i \leq n$ are called respectively the simple roots, simple coroots and fundamental dominant weights.

By the work of Kac[2] and Moody[8], it is well known that for each Cartan matrix $A$, there exists a complex Lie algebra $g(A)$ which is called Kac-Moody Lie algebra.

The Kac-Moody Lie algebra $g(A)$ is generated by $\alpha_{i}^{\vee}, e_{i}, f_{i}, 1 \leq i \leq n$ over the complex field $\mathbb{C}$, with the defining relations:
(1) $\left[\alpha_{i}^{\vee}, \alpha_{j}^{\vee}\right]=0$ for all $i, j$;

[^0](2) $\left[e_{i}, f_{j}\right]=\delta_{i j} \alpha_{i}^{\vee}$ for all $i, j$;
(3) $\left[\alpha_{i}^{\vee}, e_{j}\right]=a_{i j} e_{j},\left[\alpha_{i}^{\vee}, f_{j}\right]=-a_{i j} f_{j}$ for all $i, j$;
(4) $\operatorname{ad}\left(e_{i}\right)^{-a_{i j}+1}\left(e_{j}\right)=0$, for all $1 \leq i \neq j \leq n$;
(5) $\operatorname{ad}\left(f_{i}\right)^{-a_{i j}+1}\left(f_{j}\right)=0$, for all $1 \leq i \neq j \leq n$.

Kac and Peterson [4] 6] constructed the simply connected Kac-Moody group $G(A)$ with Lie algebra $g(A)$.

Cartan matrices and their associated Kac-Moody Lie algebras, Kac-Moody groups are divided into three types.
(1) Finite type, if $A$ is positive definite. In this case, $G(A)$ is just the simply connected complex semisimple Lie group with Cartan matrix $A$.
(2) Affine type, if $A$ is positive semi-definite and has rank $n-1$.
(3) Indefinite type otherwise.

Let $S$ be the set $\{1,2, \cdots, n\}$. For each proper subset $I \subsetneq S$, the matrix $A_{I}=\left(a_{i j}\right)_{i, j \in I}$ is also a Cartan matrix. And there is a Kac-Moody subalgebra $g\left(A_{I}\right)$ of $g(A)$ which is generated by $\alpha_{i}^{\vee}, e_{i}, f_{i}, i \in I$, and a parabolic subalgebra $g_{I}(A)$ generated by $e_{i}, i \in I$ and $\alpha_{i}^{\vee}, f_{i}, 1 \leq i \leq n$. Corresponding to $g\left(A_{I}\right)$ and $g_{I}(A)$, there is a connected subgroup $G\left(A_{I}\right)$ and a parabolic subgroup $G_{I}(A)$ in $G(A)$.

There is a canonical anti-linear involution on the Lie algebra $g(A)$ which is defined by $\sigma\left(e_{i}\right)=$ $f_{i}, \sigma\left(f_{i}\right)=e_{i}$ and $\sigma\left(\alpha_{i}^{\vee}\right)=-\alpha_{i}^{\vee}$. The fixed real subalgebra $k(A)$ is spanned by $\sqrt{-1} \alpha_{i}^{\vee}, 1 \leq i \leq$ $n ; e_{\alpha}+f_{\alpha}, \sqrt{-1}\left(e_{\alpha}-f_{\alpha}\right), \alpha \in \Delta_{+}($the positive root system of $G(A)) . \quad k(A)$ has a real Cartan subalgebra $t$ which is generated by $\sqrt{-1} \alpha_{i}^{\vee}, 1 \leq i \leq n$. And $\sigma$ induces an automorphism $w$ on $G(A)$. The unitary form $K(A)$ of $G(A)$ is defined as the fixed subgroup $G(A)^{w}$ and $k(A)$ is its Lie algebra. The unitary form of the Kac-Moody subgroup $G\left(A_{I}\right)$ is $K\left(A_{I}\right)=K(A) \cap G\left(A_{I}\right)$ with Lie algebras $k\left(A_{I}\right)=k(A) \cap g\left(A_{I}\right)$. And the unitary form of the parabolic subgroup $G_{I}(A)$ is $K_{I}(A)=K(A) \cap G_{I}(A)$ with Lie algebras $k_{I}(A)=k(A) \cap g_{I}(A)$. For $I=\emptyset, K_{\emptyset}(A)$ is the maximal torus subgroup $T$ of $K(A)$ and $t$ is its Lie algebra. The groups $K\left(A_{I}\right)$ and $K_{I}(A)$ have the same simple root system $\Pi_{I}=\left\{\alpha_{i} \mid i \in I\right\}$ and Dynkin diagram. The readers may refer to [4] [5] 6] 7] for details.

Let $t_{I}=k\left(A_{I}\right) \cap t$ be the Cartan subalgebra of $K\left(A_{I}\right)$ and $t_{I}^{\prime}$ be the central subalgebra of $k_{I}(A)$. Let $T_{I}$ and $T_{I}^{\prime}$ be the torus subgroups of $K(A)$ corresponding to $t_{I}$ and $t_{I}^{\prime}$. Since $K\left(A_{I}\right)$ commutes with $T_{I}^{\prime}$, we have a homomorphism $\pi_{I}: K\left(A_{I}\right) \times T_{I}^{\prime} \rightarrow K_{I}(A),(a, b) \mapsto a b$. And $\pi_{I}$ induces a Lie algebra homomorphism $d \pi_{I}: k\left(A_{I}\right) \times t_{I}^{\prime} \rightarrow k_{I}(A),(X, Y) \mapsto X+Y$.

Generally, $d \pi_{I}$ is neither injective nor surjective. However, we will prove that $d \pi_{I}$ is an isomorphism if and only if the Cartan matrix $A_{I}$ is non-singular. In this case $d \pi_{I}$ is surjective and the kernel of $\pi_{I}$ is a discrete subgroup $\Gamma_{I}$ in the center of $K\left(A_{I}\right) \times T_{I}^{\prime}$, thus $K_{I}(A) \cong K\left(A_{I}\right) \times T_{I}^{\prime} / \Gamma_{I}$. Then a natural problem is
Problem: For the pair $(A, I)$ with $\operatorname{det} A_{I} \neq 0$, how to determine the discrete subgroup $\Gamma_{I}$.
If det $A_{I}=0, K_{I}(A)$ can't be written as a quotient of $K\left(A_{I}\right) \times T_{I}^{\prime}$, but as a semi-direct product of $K\left(A_{I}\right)$ and $T_{S-I}$.

For Kac-Moody groups of finite type, Duan and Liu [1] determine the isomorphism types of centralizer of an element in a simply connected compact Lie group. Their results contain the computation of the isomorphism type of parabolic subgroups of Kac-Moody group of finite type. In this paper, we will generalize their methods to general cases.

The methods to determine the isomorphism type of $K_{I}(A)$ is as follows. First we observe that the kernel of $\pi_{I}$ equals to the kernel of its restricted homomorphism on maximal torus. Then by identifying the Cartan subalgebra $t_{I} \oplus t_{I}^{\prime}$ of $k\left(A_{I}\right) \times t_{I}^{\prime}$ with the Cartan subalgebra $t$ of $k_{I}(A)$, and comparing the unit lattice $L(A) \subset t_{I} \oplus t_{I}^{\prime}$ with the unit lattice $L_{I}(A) \subset t$, we determine the group $\Gamma_{I}$. We have
Theorem 1: Let $L(A)$ and $L_{I}(A)$ be the unit lattices of $T$ and $T_{I} \times T_{I}^{\prime}$ respectively. If $\operatorname{det} A \neq 0$, $\Gamma_{I}$ is isomorphic to $L(A) / L_{I}(A)$.
Theorem 2: Let $E_{I}(A)$ be the subgroup of $\mathbb{Z}^{|I|}$ generated by the row vectors $e_{1}, e_{2}, \cdots, e_{n}$ of matrix $\widetilde{A}_{I}=\left(a_{i j}\right)_{i \in S, j \in I}$ and $E\left(A_{I}\right)$ be the subgroup generated by the row vectors $e_{i_{1}}, e_{i_{2}}, \cdots, e_{i_{|I|}}$ of matrix $A_{I}=\left(a_{i j}\right)_{i, j \in I}$, then we have $\Gamma_{I} \cong E_{I}(A) / E\left(A_{I}\right)$.

The contents of this paper are as follows. In section 2 , we discuss the computation of the center of a Kac-Moody group. In section 3, we determine the group $\Gamma_{I}$.

## 2 The center of the Kac-Moody group $K(A)$

In this section we compute the center $Z(K(A))$ of the Kac-Moody group $K(A)$.
By definition

$$
Z(K(A))=\left\{a \in K(A) \mid a b a^{-1}=b, \forall b \in K(A)\right\} .
$$

By the general theory of Kac-Moody groups, the center of $K(A)$ is contained in the maximal torus subgroup $T$. Hence an element $a \in Z(K(A))$ can be written as $a=\exp (\Lambda)$ with $\Lambda \in t$. And

$$
Z(K(A))=\{a \mid A d(a) Y=Y, \forall Y \in k(A)\} .
$$

Therefore $a \in Z(K(A))$ if and only if $A d(a) e_{i}=e_{i}$ and $A d(a) f_{i}=f_{i}$ for all $i$. And we have $A d(a) e_{i}=\operatorname{Ad}(\exp (\Lambda)) e_{i}=\exp (a d(\Lambda)) e_{i}=e^{\alpha_{i}(\Lambda)} e_{i}$. Similarly $\operatorname{Ad}(a) f_{i}=e^{-\alpha_{i}(\Lambda)} f_{i}$. Hence $a \in$ $Z(K(A))$ if and only if $\alpha_{i}(\Lambda) \in 2 \pi \sqrt{-1} \mathbb{Z}$.

From now on we may omit the constant $2 \pi \sqrt{-1}$ temporarily for convenience and we can recover it at any time. An element $\Lambda=\sum_{i=1}^{n} \lambda_{i} \alpha_{i}^{\vee} \in t$ can be regarded as a row vector $\left(\lambda_{1}, \lambda_{2}, \cdots, \lambda_{n}\right)$ under the basis $\Pi^{\vee}$. Similarly the root $\alpha_{i}=\sum_{j=1}^{n} a_{j i} w_{j}$ can be regarded as a column vector $\left(a_{1 i}, a_{2 i}, \cdots, a_{n i}\right)^{T}$, which is exact the $i$-th column vector of $A$.

Definition 2.1. For a Cartan matrix $A$, we define $\mathcal{Z}(A)=\left\{\Lambda \in t \mid \alpha_{i}(\Lambda) \in \mathbb{Z}, 1 \leq i \leq n\right\}$ and $L(A)=\{\Lambda \in t \mid \exp (\Lambda)=e\} . L(A)$ is the kernel of the exponential map $\exp : t \rightarrow T$ and is called the unit lattice of $T$.

It is easy to see that $L(A) \subset \mathcal{Z}(A)$. And for the simply connected Kac-Moody group $K(A)$, $L(A)$ is spanned by $\alpha_{1}^{\vee}, \alpha_{2}^{\vee}, \cdots, \alpha_{n}^{\vee}$.

Proposition 2.1. The center of Kac-Moody group $K(A)$ is isomorphic to $\mathcal{Z}(A) / L(A)$.
Proof: We consider the surjective homomorphism $\phi: \mathcal{Z}(A) \rightarrow Z(G(A)), \Lambda \mapsto \exp (\Lambda)$. It is easy to see that the kernel of $\phi$ is $L(A)$. This proves the proposition.

The condition $\alpha_{i}(\Lambda) \in \mathbb{Z}, 1 \leq i \leq n$ is equivalent to equation $\left(\lambda_{1}, \lambda_{2}, \cdots, \lambda_{n}\right) A=\left(k_{1}, k_{2}, \cdots, k_{n}\right)$ with $k_{1}, k_{2}, \cdots, k_{n} \in \mathbb{Z}$. Let $K=\left(k_{1}, k_{2}, \cdots, k_{n}\right)$, the equation can be written as

$$
\begin{equation*}
\Lambda A=K \tag{1}
\end{equation*}
$$

If $\operatorname{det} A \neq 0$, then the solution of Equation $\square$ is $\Lambda=K A^{-1}$. It can be written as $\Lambda=\sum_{i=1}^{n} k_{i} v_{i}$ with $v_{i}$ being the $i$-th row vector of matrix $A^{-1}$. Hence $v_{i}, 1 \leq i \leq n$ generates $\mathcal{Z}(A)$. Let $\bar{v}_{i}$ be the image of $v_{i}$ under the homomorphism $\phi$, then $\bar{v}_{i}, 1 \leq i \leq n$ generates the group $Z(K(A))$.

Let $t_{\mathbb{Q}}$ be the $\mathbb{Q}$-vector space $L(A) \otimes \mathbb{Q}$. We define a linear map $R: t_{\mathbb{Q}} \rightarrow \mathbb{Q}^{n}, \Lambda \mapsto \Lambda A$. Let $e_{1}, e_{2}, \cdots, e_{n}$ be the row vectors of $A$. They span a lattice subgroup $E$ in $\mathbb{Z}^{n}$. we have

Corollary 2.1. If $\operatorname{det} A \neq 0$, then $Z(K(A)) \cong \mathbb{Z}^{n} / E$ and it is a finite group with order $|\operatorname{det} A|$.
Proof: If $\operatorname{det} A \neq 0$, then $R$ is an isomorphism. Hence $\mathcal{Z}(A) / L(A) \cong R(\mathcal{Z}(A)) / R(L(A))=$ $\mathbb{Z}^{n} / E$.

If $\operatorname{det} A=0$, Let $F$ be the intersection of $\mathbb{Z}^{n} \subset \mathbb{Q}^{n}$ with the $\mathbb{Q}$-vector space spanned by $e_{1}, e_{2}, \cdots, e_{n}$, we have

Corollary 2.2. If $\operatorname{det} A=0$, then $Z(K(A))$ is isomorphic to the product of a finite group $Z^{\prime}(K(A))$ and a torus subgroup $T^{n-k} \subset T$, where $Z^{\prime}(K(A)) \cong F / E$ and $k=\operatorname{rank}\left(A_{I}\right)$.

Proof: We have two exact sequences.

$$
0 \rightarrow \operatorname{ker} R \rightarrow \mathcal{Z}(A) \rightarrow \operatorname{im} R \cap \mathbb{Z}^{n} \rightarrow 0, \quad 0 \rightarrow \operatorname{ker} R \cap L(A) \rightarrow L(A) \rightarrow \operatorname{im} L(A) \rightarrow 0
$$

The quotient of these two sequences gives an exact sequence

$$
0 \rightarrow T^{n-k} \rightarrow Z(K(A)) \rightarrow F / E \rightarrow 0
$$

Since $T^{n-k}$ is divisible, the exact sequence is split. This proves the corollary.
Example 2.1. Let $A=\left(a_{i j}\right)_{2 \times 2}$ be a Cartan matrix of rank 2, we compute the center of $K(A)$. $\Lambda=\left(\lambda_{1}, \lambda_{2}\right) \in \mathcal{Z}(K(A))$ if and only if

$$
\left\{\begin{aligned}
2 \lambda_{1}+a_{21} \lambda_{2} & =k_{1} \\
a_{12} \lambda_{1}+2 \lambda_{2} & =k_{2}
\end{aligned}\right.
$$

If $\Delta=4-a_{12} a_{21} \neq 0$, then

$$
\left\{\begin{array}{l}
\lambda_{1}=\frac{2}{\Delta} k_{1}+\frac{-a_{21}}{\Delta} k_{2} \\
\lambda_{2}=\frac{-a_{12}}{\Delta} k_{1}+\frac{2}{\Delta} k_{2}
\end{array}\right.
$$

Hence we have $\left(\lambda_{1}, \lambda_{2}\right)=k_{1}\left(\frac{2}{\Delta}, \frac{-a_{12}}{\Delta}\right)+k_{2}\left(\frac{-a_{21}}{\Delta}, \frac{2}{\Delta}\right)$.
We set $v_{1}=\left(\frac{2}{\Delta}, \frac{-a_{12}}{\Delta}\right)$ and $v_{2}=\left(\frac{-a_{21}}{\Delta}, \frac{2}{\Delta}\right)$, then $\bar{v}_{1}$ and $\bar{v}_{2}$ are the generators of group $Z(K(A))$. Explicit computation shows

If $a_{12}$ is odd, then $\bar{v}_{1}$ is the generator of $Z(K(A))$ with order $|\Delta|$. And $Z(K(A))$ is isomorphic to $Z_{|\Delta|}$.

If $a_{21}$ is odd, then $\bar{v}_{2}$ is the generator of $Z(K(A))$ with order $|\Delta|$. And $Z(K(A))$ is isomorphic to $Z_{|\Delta|}$.

If both $a_{12}$ and $a_{21}$ are even, then $\bar{v}_{1}$ and $\bar{v}_{2}+\frac{a_{21}}{2} \bar{v}_{1}$ are the generators of $Z(K(A))$ with order $\frac{|\Delta|}{2}$ and order 2. And $Z(K(A))$ is isomorphic to $Z_{\frac{|\Delta|}{2}} \times Z_{2}$.

If $\Delta=0$, then $a_{12} a_{21}=4$ and we must have $A=\left(\begin{array}{cc}2 & -2 \\ -2 & 2\end{array}\right)$ or $\left(\begin{array}{cc}2 & -1 \\ -4 & 2\end{array}\right)$
For $A=\left(\begin{array}{cc}2 & -2 \\ -2 & 2\end{array}\right)$, $e_{1}=(2,-2), e_{2}=(-2,2)$ and $E=\mathbb{Z}(2,-2), F=\mathbb{Z}(1,-1)$, hence $Z^{\prime}(K(A))=\mathbb{Z}_{2}$.

For $A=\left(\begin{array}{cc}2 & -1 \\ -4 & 2\end{array}\right), e_{1}=(2,-1), e_{2}=(-4,2)$ and $E=\mathbb{Z}(2,-1), F=\mathbb{Z}(2,-1)$, hence $Z^{\prime}(K(A))=\{1\}$.

In both cases $k=1$.
An $n \times n$ integer matrix $A$ has a decomposition $A=P \widetilde{A} Q$, where $P, \widetilde{A}, Q$ are integer matrices with $\operatorname{det} P$, $\operatorname{det} Q \in\{1,-1\}$ and $\widetilde{A}=\operatorname{diag}\left[q_{1}, q_{2}, \cdots, q_{n}\right]$ with $q_{1}\left|q_{2}\right| \cdots \mid q_{n}$. If $\operatorname{det} A=0$ and $\operatorname{rank}(A)=k$, then $q_{k+1}=q_{k+2}=\cdots=q_{n} \underset{\sim}{=}$. If $A$ is a Cartan matrix, then Equation 1 becomes $\Lambda P \widetilde{A} Q=K$. Denoting $\Lambda P$ and $K Q^{-1}$ by $\widetilde{\Lambda}$ and $\widetilde{K}$ respectively, then we have $\widetilde{\Lambda} \widetilde{A}=\widetilde{K}$. An easy check shows that

Proposition 2.2. $Z(K(A)) \cong Z_{q_{1}} \times Z_{q_{2}} \times \cdots \times Z_{q_{k}} \times T^{n-k}$.
This provides an alternative proof for Corollary 2.2

## 3 The kernel $\Gamma_{I}$ of the homomorphism $\pi_{I}$

First we compute the center $Z_{I}(A)$ of the parabolic subgroup $K_{I}(A)$. For $I \subsetneq S$, let $\mathcal{Z}_{I}(A)=\{\Lambda \in$ $\left.t \mid \alpha_{i}(\Lambda) \in \mathbb{Z}, \forall i \in I\right\}$.

Lemma 3.1. The center $Z_{I}(A)$ of $K_{I}(A)$ is $\exp \left(\mathcal{Z}_{I}(A)\right)$.
Proof: Since $Z_{I}(A) \subset T$, an element $a \in Z_{I}(A)$ can be written as $a=\exp (\Lambda)$. A similar argument as previous section shows that $a \in Z_{I}(A)$ if and only if $\Lambda \in \mathcal{Z}_{I}(A)$. This gives a surjective homomorphism $\phi: \mathcal{Z}_{I}(A) \rightarrow Z_{I}(A), \Lambda \mapsto \exp (\Lambda)$ and proves the lemma.

Let $A$ be a Cartan matrix and $I \subsetneq S$ be a proper subset with $\operatorname{det} A_{I} \neq 0$. We have defined the group homomorphism $\pi_{I}: K\left(A_{I}\right) \times T_{I}^{\prime} \rightarrow K_{I}(A),(a, b) \mapsto a b$. It induces a Lie algebra homomorphism $d \pi_{I}: k\left(A_{I}\right) \oplus t_{I}^{\prime} \rightarrow k_{I}(A),(X, Y) \mapsto X+Y$. By checking the definition we have

Lemma 3.2. 1. The Lie algebra $t_{I}^{\prime}=\left\{\Lambda \in t \mid \alpha_{i}(\Lambda)=0, \forall i \in I\right\}$, or equivalently $\Lambda=\left(\lambda_{1}, \lambda_{2}, \cdots, \lambda_{n}\right)$ $\in t_{I}^{\prime}$ if and only if $\Lambda \widetilde{A}_{I}=0$, where $\widetilde{A}_{I}=\left(a_{i j}\right)_{i \in S, j \in I}$.
2. The kernel of $d \pi_{I}$ is $\left\{(X,-X) \mid X \in t_{I} \cap t_{I}^{\prime}\right\}$ and it is isomorphic to $t_{I} \cap t_{I}^{\prime}$.
3. The kernel of $\pi_{I}$ is $\left\{\left(a, a^{-1}\right) \mid a \in T_{I} \cap T_{I}^{\prime}\right\}$ and it is isomorphic to $T_{I} \cap T_{I}^{\prime}=K\left(A_{I}\right) \cap T_{I}^{\prime}$.

Lemma 3.3. $d \pi_{I}$ is an isomorphism if and only if $\operatorname{det} A_{I} \neq 0$

Proof: Since $k_{I}(A)$ and $k\left(A_{I}\right)$ have the same Dynkin diagram, by the previous lemma, it is sufficient to prove that $t_{I} \cap t_{I}^{\prime}=\{0\}$ and $t_{I}+t_{I}^{\prime}=t$.

We set $l=\operatorname{rank}\left(A_{I}\right), m=\operatorname{rank}\left(\widetilde{A}_{I}\right)$, then $l \leq m \leq|I|$. By 1 and 2 of Lemma 3.2, the dimensions of $t_{I}^{\prime}$ and $t_{I} \cap t_{I}^{\prime}$ are $n-m$ and $|I|-l$. Therefore
$\operatorname{dim}\left(t_{I}+t_{I}^{\prime}\right)=\operatorname{dim} t_{I}+\operatorname{dim} t_{I}^{\prime}-\operatorname{dim} t_{I} \cap t_{I}^{\prime}=|I|+n-m-(|I|-l)=n-(m-l)$.
Hence $d \pi_{I}$ is an isomorphism if and only if $|I|-l=0$ and $n-(m-l)=n$. So we have $\operatorname{rank}\left(A_{I}\right)=l=m=|I|$. This means that $\operatorname{det} A_{I} \neq 0$.

In the following we need only consider the case when $\operatorname{det} A_{I} \neq 0$.
Let $I=\left\{i_{1}, i_{2}, \cdots, i_{|I|}\right\}, i_{1}<i_{2}<\cdots<i_{|I|}$ and $J=S-I=\left\{j_{1}, j_{2}, \cdots, j_{n-|I|}\right\}, j_{1}<j_{2}<$ $\cdots<j_{n-|I|}$, then the column vectors $\alpha_{i_{1}}, \alpha_{i_{2}}, \cdots \alpha_{i_{|I|}}$ form the $n \times|I|$ matrix $\widetilde{A}_{I}$. The matrix $\widetilde{A}_{I}$ can be decomposed into two sub-matrices. The $i_{1}, i_{2}, \cdots, i_{|I|}$-th rows of $\widetilde{A}_{I}$ form the matrix $A_{I}$, and the $j_{1}, j_{2}, \cdots, j_{n-|I|}$-th rows form another matrix $\bar{A}_{I}$. By the decomposition $t=t_{I} \oplus t_{J}$, each $\Lambda \in t$ can be written as $\left(\Lambda_{1}, \Lambda_{2}\right)$ with $\Lambda_{1} \in t_{I}$ and $\Lambda_{2} \in t_{J}$. By definition if $\Lambda \in \mathcal{Z}_{I}(A)$, then $\Lambda \widetilde{A}_{I}=\left(k_{i_{1}}, k_{i_{2}}, \cdots, k_{i_{|I|}}\right), k_{i_{1}}, k_{i_{2}}, \cdots, k_{i_{|I|}} \in \mathbb{Z}$. Let $K_{I}$ be the row vector $\left(k_{i_{1}}, k_{i_{2}}, \cdots, k_{i_{|I|}}\right)$, then we can write the equation $\Lambda \widetilde{A_{I}}=K_{I}$ as

$$
\begin{equation*}
\Lambda_{1} A_{I}+\Lambda_{2} \bar{A}_{I}=K_{I} \tag{2}
\end{equation*}
$$

The vector $\Lambda$ can also be decomposed as $\Lambda=\Lambda_{1}^{I}+\Lambda_{2}^{I}$ with $\Lambda_{1}^{I} \in t_{I}$ and $\Lambda_{2}^{I} \in t_{I}^{\prime}$. The relation for the two decompositions are described in the following lemma.
Lemma 3.4. For $\Lambda=\left(\Lambda_{1}, \Lambda_{2}\right)$, Let $K_{I}=\Lambda \widetilde{A}_{I}=\Lambda_{1} A_{I}+\Lambda_{2} \bar{A}_{I}$. If $\operatorname{det} A_{I} \neq 0$, then $\Lambda_{1}^{I}=$ $\left(K_{I} A_{I}^{-1}, 0\right)$ and $\Lambda_{2}^{I}=\left(-\Lambda_{2} \bar{A}_{I} A_{I}^{-1}, \Lambda_{2}\right)$.

Proof: We need to show that $\Lambda_{1}^{I} \in t_{I}, \Lambda_{2}^{I} \in t_{I}^{\prime}$ and $\Lambda=\Lambda_{1}^{I}+\Lambda_{2}^{I} . \Lambda_{1}^{I}=\left(K_{I} A_{I}^{-1}, 0\right) \in t_{I}$ is obvious. $\Lambda_{2}^{I} \in t_{I}^{\prime}$ is given by $\Lambda_{2}^{I} \widetilde{A}_{I}=-\Lambda_{2} \bar{A}_{I} A_{I}^{-1} A_{I}+\Lambda_{2} \bar{A}_{I}=0$. By $\Lambda_{1} A_{I}+\Lambda_{2} \bar{A}_{I}=K_{I}$ we have $\Lambda_{1}+\Lambda_{2} \bar{A}_{I} A_{I}^{-1}=K_{I} A_{I}^{-1}$. Hence $\Lambda=\left(\Lambda_{1}, \Lambda_{2}\right)=\left(K_{I} A_{I}^{-1}-\Lambda_{2} \bar{A}_{I} A_{I}^{-1}, \Lambda_{2}\right)=\Lambda_{1}^{I}+\Lambda_{2}^{I}$. This proves the lemma.

We have the following commutative diagram

where $\exp _{I}=(\exp , \exp ): t_{I} \oplus t_{I}^{\prime} \rightarrow T_{I} \times T_{I}^{\prime}$. The homomorphism $\pi_{I}$ is restricted to a homomorphism $\bar{\pi}_{I}: T_{I} \times T_{I}^{\prime} \rightarrow T$ between maximal tori.

It is obvious that $\operatorname{ker} \pi_{I}=\operatorname{ker} \bar{\pi}_{I}$. The element $a=\exp _{I}(\Lambda)$ lies in $\operatorname{ker} \bar{\pi}_{I}$ if and only if $\exp (\Lambda)=e$, i.e. $\Lambda$ lies in $L(A)$.
Definition 3.1. For $I \subset S$, we define $L_{I}(A)=\left\{\Lambda=\Lambda_{1}^{I}+\Lambda_{2}^{I} \in t_{I} \times t_{I}^{\prime} \mid \exp \left(\Lambda_{1}^{I}\right)=e, \exp \left(\Lambda_{2}^{I}\right)=e\right\}$, which is called the unit lattice of $T_{I} \times T_{I}^{\prime}$.

The lattice $L_{I}(A)$ is isomorphic to the lattice $\left(L(A) \cap t_{I}\right) \oplus\left(L(A) \cap t_{I}^{\prime}\right)$. By Lemma 3.4 and the definition of $L_{I}(A)$, we have a simple but useful result

Corollary 3.1. For an element $\Lambda=\left(\lambda_{1}, \lambda_{2}, \cdots, \lambda_{n}\right) \in L(A), K_{I}=\Lambda \widetilde{A}_{I}$, then $\Lambda \in L_{I}(A)$ if and only if $K_{I} A_{I}^{-1} \in \mathbb{Z}^{|I|}$ or $\Lambda_{2} \bar{A}_{I} A_{I}^{-1} \in \mathbb{Z}^{n-|I|}$.

Now we have
Theorem 1: Let $L(A)$ and $L_{I}(A)$ be the unit lattices of $T$ and $T_{I} \times T_{I}^{\prime}$. If $\operatorname{det} A_{I} \neq 0$, then $\Gamma_{I}=\exp _{I}(L(A)) \cong L(A) / L_{I}(A)$.
Proof: Since the exponential map $\exp _{I}$ is surjective, each element $a \in \Gamma_{I}$ can be written as $a=\exp _{I}(\Lambda)$. By considering the left square of the previous commutative diagram we have $\exp (\Lambda)=$ $\bar{\pi}_{I}\left(\exp _{I}(\Lambda)\right)=\bar{\pi}_{I}(a)=\{e\}$. So $\Lambda \in L(A)$. As a result, we can define a surjective homomorphism $f: L(A) \rightarrow \Gamma_{I}, \Lambda \mapsto \exp _{I}(\Lambda)$. It is obvious that the kernel of $f$ is $L_{I}(A)$. This proves the theorem.
Theorem 2: Let $E_{I}(A)$ be the subgroup of $\mathbb{Z}^{|I|}$ generated by the row vectors $e_{1}, e_{2}, \cdots, e_{n}$ of the matrix $\widetilde{A}_{I}=\left(a_{i j}\right)_{i \in S, j \in I}$ and $E\left(A_{I}\right)$ be the subgroup generated by the row vectors $e_{i_{1}}, e_{i_{2}}, \cdots, e_{i_{|I|}}$ of the matrix $A_{I}=\left(a_{i j}\right)_{i, j \in I}$, then we have $\Gamma_{I} \cong E_{I}(A) / E\left(A_{I}\right)$.
Proof: Let $\phi: \mathbb{Z}^{n} \rightarrow \mathbb{Z}^{I I \mid}$ be the $\mathbb{Z}$-linear map given by $\Lambda \mapsto \Lambda \widetilde{A}_{I}$, then $\phi(L(A))$ is a subgroup of $\mathbb{Z}^{|I|}$ generated by $(1,0, \cdots, 0) \widetilde{A}_{I},(0,1, \cdots, 0) \widetilde{A}_{I}, \cdots,(0,0, \cdots, 1) \widetilde{A}_{I}$, which are just the $n$ vectors $e_{1}, e_{2}, \cdots, e_{n}$. For an element $\Lambda \in \mathbb{Z}^{n}$, let $K_{I}=\Lambda \widetilde{A}_{I}$. Then by Corollary 3.1, $\Lambda \in L_{I}(A)$ if and only if $K_{I} A_{I}^{-1} \in Z^{|I|}$. This shows that $K_{I}$ is in the image of map $\mathbb{Z}^{n} \rightarrow Z^{|I|}, \Lambda \mapsto \Lambda\binom{A_{I}}{O}$. So $\phi\left(L_{I}(A)\right)$ is $E_{I}(A)$.

For $\Lambda \in \operatorname{ker} \phi$, we have $\Lambda \widetilde{A}_{I}=0$, that is $\Lambda_{1} A_{I}+\Lambda_{2} \bar{A}_{I}=0$. This shows that $\left(\Lambda_{2} \bar{A}_{I} A_{I}^{-1}, 0\right)=$ $\left(-\Lambda_{1}, 0\right) \in L(A)$. Therefore $\Lambda \in L_{I}(A)$. So $\operatorname{ker} \phi \subset L_{I}(A)$. Hence we have $L(A) / L_{I}(A) \cong$ $L(A) / \operatorname{ker} \phi / L_{I}(A) / \operatorname{ker} \phi \cong E_{I}(A) / E\left(A_{I}\right)$.

Let $V$ be an $n$-dimensional real vector space with a lattice subgroup $L$. We assume $V$ has a direct sum decomposition $V=V_{1} \oplus V_{2}$, then we can define an abelian group $\Gamma\left(V, L ; V_{1}, V_{2}\right)$ which is given by $L /\left(V_{1} \cap L \oplus V_{2} \cap L\right)$. The group $\Gamma\left(V, L ; V_{1}, V_{2}\right)$ is trivial if and only if $L=V_{1} \cap L \oplus V_{2} \cap L$, i.e. the direct sum decomposition of $V$ induces a direct sum decomposition of $L$. By this definition we have $\Gamma_{I}=\Gamma\left(t, L(A), t_{I}, t_{I}^{\prime}\right)$.

Example 3.1. Let $V=\mathbb{R}^{n}$, and $L$ be a lattice generated by standard basis $e_{1}, e_{2}, \cdots, e_{n}$ of $V$. If $V_{1}$ is spanned by $e_{1}-e_{2}, e_{2}-e_{3}, \cdots, e_{n-1}-e_{n}$ and $V_{2}$ is spanned by $e_{1}+e_{2}+\cdots+e_{n}$, then $\Gamma\left(V, L, V_{1}, V_{2}\right) \cong \mathbb{Z}_{n}$. And the natural homomorphism $\pi: V_{1} /\left(L \cap V_{1}\right) \times V_{2} /\left(L \cap V_{2}\right) \rightarrow V / L$ is an $n$-fold cyclic covering.

This example corresponds to the fact that $U(n) \cong S U(n) \times S^{1} / \mathbb{Z}_{n}$.
In the following we compute $\Gamma_{I}$ for $3 \times 3$ Cartan matrix.
Example 3.2. Let $A=\left(a_{i j}\right)$ be a $3 \times 3$ Cartan matrix, we compute the isomorphism type of the parabolic subgroup $K_{I}(A)$. By the symmetry of indices $1,2,3$, we only need to compute the cases $I=\{1\}$ and $\{1,2\}$.

For $I=\{1\}$, the groups $\mathcal{Z}_{I}(A)=\left\{\Lambda=\left(\lambda_{1}, \lambda_{2}, \lambda_{3}\right) \mid a_{11} \lambda_{1}+a_{21} \lambda_{2}+a_{31} \lambda_{3}=k_{1} \in \mathbb{Z}\right\} . t_{I}$ is generated by $\alpha_{1}^{\vee}($ or $(1,0,0))$ and $t_{I}^{\prime}=\left\{\Lambda=\left(\lambda_{1}, \lambda_{2}, \lambda_{3}\right) \mid a_{11} \lambda_{1}+a_{21} \lambda_{2}+a_{31} \lambda_{3}=0\right\}$.

By Corollary 3.1 the element $\Lambda=\left(\lambda_{1}, \lambda_{2}, \lambda_{3}\right) \in L_{I}(A)$ if and only if $\lambda_{1}, \lambda_{2}, \lambda_{3} \in \mathbb{Z}$ and $a_{21} \lambda_{2}+a_{31} \lambda_{3} \in 2 \mathbb{Z}$, if and only if

$$
\begin{cases}\lambda_{1}, \lambda_{2}, \lambda_{3} \in \mathbb{Z} & \text { if both } a_{21} \text { and } a_{31} \text { are even; } \\ \lambda_{1}, \lambda_{2} \in \mathbb{Z}, \lambda_{3} \in 2 \mathbb{Z}, & \text { if } a_{21} \text { is even and } a_{31} \text { is odd; } \\ \lambda_{1}, \lambda_{3} \in \mathbb{Z}, \lambda_{2} \in 2 \mathbb{Z}, & \text { if } a_{21} \text { is odd and } a_{31} \text { is even; } \\ \lambda_{1}, \lambda_{2}, \lambda_{3} \in \mathbb{Z}, \lambda_{2}+\lambda_{3} \in 2 \mathbb{Z}, & \text { if both } a_{21} \text { and } a_{31} \text { are odd. }\end{cases}
$$

By $a_{11} \lambda_{1}+a_{21} \lambda_{2}+a_{31} \lambda_{3}=k_{1}$, we get $\lambda_{1}=\frac{k_{1}}{2}+\frac{-a_{21}}{2} \lambda_{2}+\frac{-a_{31}}{2} \lambda_{3}$.
Hence $\left(\lambda_{1}, \lambda_{2}, \lambda_{3}\right)=k_{1}\left(\frac{1}{2}, 0,0\right)+\lambda_{2}\left(-\frac{a_{21}}{2}, 1,0\right)+\lambda_{3}\left(-\frac{a_{31}}{2}, 0,1\right)=k_{1}\left(\frac{1}{2}, 0,0\right)+\left(-\frac{\lambda_{2} a_{21}+\lambda_{3} a_{31}}{2}, 1,0\right)$. This shows that $t_{I}^{\prime}$ is spanned by $\left(-\frac{a_{21}}{2}, 1,0\right)$ and $\left(-\frac{a_{31}}{2}, 0,1\right)$.

If both $a_{21}$ and $a_{31}$ are even, then $K_{I}(A)$ is isomorphic to $S U(2) \times T^{2}$. Otherwise $K_{I}(A)$ is isomorphic to $S U(2) \times T^{2} / \mathbb{Z}_{2}$.

For $I=\{1,2\},\left(\lambda_{1}, \lambda_{2}, \lambda_{3}\right) \in \mathcal{Z}_{I}(A)$ satisfies

$$
\left\{\begin{array}{l}
a_{11} \lambda_{1}+a_{21} \lambda_{2}+a_{31} \lambda_{3}=k_{1} \in \mathbb{Z} \\
a_{12} \lambda_{1}+a_{22} \lambda_{2}+a_{32} \lambda_{3}=k_{2} \in \mathbb{Z}
\end{array}\right.
$$

We set $\Delta=\left|\begin{array}{ll}a_{11} & a_{12} \\ a_{21} & a_{22}\end{array}\right| \neq 0, \Delta_{1}=\left|\begin{array}{ll}a_{11} & a_{12} \\ a_{31} & a_{32}\end{array}\right|, \Delta_{2}=\left|\begin{array}{ll}a_{21} & a_{22} \\ a_{31} & a_{32}\end{array}\right|$,then

$$
\left\{\begin{array}{l}
\lambda_{1}=\frac{a_{22}}{\Delta}\left(k_{1}-a_{31} \lambda_{3}\right)+\frac{-a_{21}}{\Delta_{1}}\left(k_{2}-a_{32} \lambda_{3}\right) \\
\lambda_{2}=\frac{-a_{12}}{\Delta}\left(k_{1}-a_{31} \lambda_{3}\right)+\frac{a_{11}}{\Delta}\left(k_{2}-a_{32} \lambda_{3}\right)
\end{array}\right.
$$

Hence we have
$\left(\lambda_{1}, \lambda_{2}, \lambda_{3}\right)$
$=k_{1}\left(\frac{a_{22}}{\Delta}, \frac{-a_{12}}{\Delta}, 0\right)+k_{2}\left(\frac{-a_{21}}{\Delta}, \frac{a_{11}}{\Delta}, 0\right)+\lambda_{3}\left(\frac{a_{22}}{\Delta}\left(-a_{31}\right)+\frac{-a_{21}}{\Delta}\left(-a_{32}\right), \frac{-a_{12}}{\Delta}\left(-a_{31}\right)+\frac{a_{11}}{\Delta}\left(-a_{32}\right), 1\right)$
$=k_{1}\left(\frac{a_{22}}{\Delta}, \frac{-a_{12}}{\Delta}, 0\right)+k_{2}\left(\frac{-a_{21}}{\Delta}, \frac{a_{11}}{\Delta}, 0\right)+\lambda_{3}\left(\frac{\Delta_{2}}{\Delta},-\frac{\Delta_{1}}{\Delta}, 1\right)$
By Corollary 3.1 the condition for $\left(\lambda_{1}, \lambda_{2}, \lambda_{3}\right) \in L_{I}(A)$ is $\lambda_{3}\left(a_{31}, a_{32}\right)\left(\begin{array}{cc}\frac{a_{22}}{\Delta} & \frac{-a_{12}}{\Delta} \\ \frac{-a_{21}}{\Delta} & \frac{a_{11}}{\Delta}\end{array}\right)=$ $\lambda_{3}\left(\frac{-\Delta_{2}}{\Delta}, \frac{\Delta_{1}}{\Delta}\right) \in \mathbb{Z}^{2}$, i.e. $\lambda_{3} \Delta_{1} \in \mathbb{Z} \Delta$ and $\lambda_{3} \Delta_{2} \in \mathbb{Z} \Delta$. Hence $\lambda_{3}$ is divided by $\frac{\Delta}{\operatorname{lcm}\left(\Delta, \Delta_{1}\right)}$ and $\frac{\Delta}{\operatorname{lcm}\left(\Delta, \Delta_{2}\right)}$. As a result

$$
\Gamma_{I} \cong Z_{\frac{\Delta c}{\operatorname{gcd}\left(l c m\left(\Delta, \Delta_{1}\right), l \operatorname{cm}\left(\Delta, \Delta_{2}\right)\right)}}
$$

Example 3.3. For the $(n+1) \times(n+1)$ affine Cartan matrix

$$
\widetilde{A}_{n}=\left(\begin{array}{cccccc}
2 & -1 & 0 & \cdots & 0 & -1 \\
-1 & 2 & -1 & \cdots & 0 & 0 \\
0 & -1 & 2 & \ddots & 0 & 0 \\
\vdots & \vdots & \ddots & \ddots & \vdots & \vdots \\
0 & 0 & 0 & \cdots & 2 & -1 \\
-1 & 0 & 0 & \cdots & -1 & 2
\end{array}\right)
$$

Let $\widetilde{S}=\{0,1,2, \cdots, n-1, n\}$. Since the Dynkin diagrams are invariant under the cyclic permutation $(012 \cdots(n-1) n)$, we can assume $0 \notin I$ and $1 \in I$ for a subset $\emptyset \neq I \subsetneq S$. Let $k$ be
the number of connected components of the Dynkin diagram of $K_{I}(A)$. Then $I=\left[i_{1}, j_{1}\right] \sqcup\left[i_{2}, j_{2}\right] \sqcup$ $\cdots \sqcup\left[i_{k}, j_{k}\right]$, where $1=i_{1} \leq j_{1}<i_{2} \leq j_{2}<\cdots<i_{k} \leq j_{k} \leq n$.
i) If $k=1$ and $|I|=n$, then $\Gamma_{I}=\{e\}$.
ii) If $k=1$ and $|I|<n$, then $\Gamma_{I}=Z_{|I|+1}$.
iii) The case ii) can be generalized to the other case for $k>1$ and we have

$$
\Gamma_{I} \cong \mathbb{Z}_{j_{1}-i_{1}+2} \times \mathbb{Z}_{j_{2}-i_{2}+2} \times \cdots \times \mathbb{Z}_{j_{k}-i_{k}+2}
$$

The following corollary is a direct result of Theorem 2.
Example 3.4. Let $A$ be a $(n+1) \times(n+1)$ Cartan matrix of affine type and $A^{\vee}$ be its transposition. For each $i \in \widetilde{S}$, the isomorphism type of the maximal parabolic subgroup $K_{\widetilde{S}-\{i\}}(A)$ is $K\left(A_{S-\{i\}}\right) \times$ $S^{1} / \mathbb{Z}_{m_{i}}$, where $m_{i}$ is the integer below the $i$-th vertex of the Dynkin diagram of $A^{\vee}$ in the table of Kac[3], page 54-55.

For $i \in \widetilde{S}$, by deleting the $i$-th column of $A$ gives the matrix $\widetilde{A}_{\widetilde{S}-\{i\}}$. Let $\alpha_{0}, \alpha_{1}, \cdots, \alpha_{n}$ be the $n+1$ columns of $A^{\vee}$, then $\sum_{j=0}^{n} m_{j} \alpha_{j}=0$. It is easy to see the $n+1$ row vectors of $A_{\widetilde{S}-\{i\}}$ are the transpositions of $\alpha_{0}, \alpha_{1}, \cdots, \alpha_{n}$ with their $i$-th components deleted. Hence we have $\sum_{j=0}^{n} m_{j} e_{j}=0$. And $m_{i} e_{i}=-\sum_{j \neq i} m_{j} e_{j}$. By Theorem 2, we obtain that $\Gamma_{i} \cong E_{I}(A) / E\left(A_{I}\right) \cong \mathbb{Z}_{m_{i}}$.

For affine Kac-Moody group of types $\widetilde{A}, \widetilde{B}, \widetilde{C}$ and $\widetilde{D}$ (non-twisted or twisted cases), we always have $\operatorname{det} A_{I} \neq 0$ for a subset $\emptyset \neq I \subsetneq S$. In these cases the third author designs an algorithm to compute explicitly the group $\Gamma_{I}$.
