# Convergence of the Frozen Gaussian Approximation for High Frequency Elastic Waves

#### Abstract

The frozen Gaussian approximation (FGA) is an effective tool for modeling high frequency wave propagation. In previous works, the convergence of the FGA has established for strict hyperbolic systems. In this work, we derive the frozen Gaussian approximation for the elastic wave equation, which can be cast as a hyperbolic system with repeated eigenvalues. In the derivation, the strong form for the evolution equation is introduced. A diabatic coupling is observed for the amplitude of the evolution equations between the SH, SV waves. Using previous results with new energy estimates we establish the convergence for the first order FGA for the elastic wave equation.


Keywords: Frozen Gaussian approximation; elastic wave equation; highfrequency wavefield; weak asymptotic analysis; wave-packet decomposition

## 1 Introduction

This paper is to analytical show that the first ordered frozen Gaussian approximation for the elastic wave equation derived and reported in [5] is indeed the same order for strict hyperbolic systems, as proven in [9] and verified numerical in $[7,2,3,5]$. The proof will use all the same machinery from [9], with a new derivation and new error estimates for the evolution equation. The theorem that will be proven is:

Main Theorem. Let $\left\{\boldsymbol{u}_{0}^{\epsilon}\right\}$ be a family of asymptotically high frequency initial conditions for displacement, let $\boldsymbol{u}:[0, T] \times \mathbb{R}^{3}$ satisfy the elastic wave equation (3.1), with $\left\|\boldsymbol{u}_{0}^{\epsilon}\right\|_{\mathrm{L}^{2}} s \in H_{0}^{1}\left(\mathbb{R}^{3 d}\right)$ and uniformly bounded, i.e. $\left\|\boldsymbol{u}_{0}^{\epsilon}\right\|_{H_{0}^{1}}<M$ and let $\boldsymbol{u}_{\mathrm{F}}$ be the FGA approximation in (4.1), with the proper assumptions

Where the norm $\|\cdot\|_{\mathrm{E}}$ is a scaled semi-norm defined in (5.1).

As a corollary to this, we will show asymptotic equivalence to the formulation of the FGA in [9].

Related works. The FGA is originally motivated by quantum chemistry and the herman-Kluk propagater $[6,11,10]$. The FGA high frequency waves has been used for forward modeling in seismic tomography for the acoustic (P-waves) [2,3] and elastic waves (P,S-waves) [5]. The FGA for the elastic wave equation has also been used train neural networks for seismic interface and pocket detection [4].

Organization of the paper. In section 2, the necessary notation is introduced with preliminaries for phase plane analysis. In section 3 the equation and it's eigenvalue decomposition is are introduced. Section 4 describes the formulation and derivation of the frozen Gaussian approximation for the elastic wave equation. Finally, in section 5 the error estimates and proofs are given.

## 2 Preliminaries

### 2.1 Notation.

We denote $\boldsymbol{x}, \boldsymbol{y} \in \mathbb{R}^{d}$ as spatial variables, $(\boldsymbol{q}, \boldsymbol{p}) \in \mathbb{R}^{2 d}$ for the position and momentum variables, respectively, in the phase space.

For $\delta>0$, define the closed set $K_{\delta} \subset \mathbb{R}^{2 d}$

For all practical purpose, this set $K_{\delta}$ is bounding the position and the magnitude for the direction of propagation of the wave packets. The upper bound conditions on $|\boldsymbol{q}|$ and $|\boldsymbol{p}|$ are quite reasonable as any computational domain will be a finite domain. Also, $\boldsymbol{p}$ bounded away from zero is reasonable as if $\boldsymbol{p}=0$ the wave packet does not propagate and the Hamiltonian system is degenerate i.e., $H=0$.

We use the notation $\mathcal{O}\left(\epsilon^{\infty}\right)$ : $A^{\epsilon}=\mathcal{O}\left(\epsilon^{\infty}\right)$ meaning for any $k \in \mathbb{N}$

Notation $C$ will be used as a general constant, that can vary from line to line. The value will not be important, but rather that it is finite. We will use subscripts to denote constant dependence, e.g. $C_{T}$, is a constant that depends on the parameter $T$. We will use the usual notation of $\mathcal{S}, C^{\infty}$ and $C_{c}^{\infty}$ for the Schwartz class, smooth and compacted supported smooth functions respectively. For generality, we will often use $\mathbb{R}^{d}$ for a $d$-dimensional Euclidean space; however, for the actually equation and computations we set $d=3$ as we deal the usual differential operators on $\mathbb{R}^{3}$.

### 2.2 Wave packet decomposition.

For $(\boldsymbol{q}, \boldsymbol{p}) \in \mathbb{R}^{2 d}$, define $\phi_{\boldsymbol{q}, \boldsymbol{p}}^{\epsilon}$ as

With inverse transform $\left(\mathcal{F}^{\epsilon}\right)^{*}$ defined on $\mathcal{S}\left(\mathbb{R}^{2 d}\right)$ given by

The following is a standard result from microlocal analysis, e.g. see [1].
Proposition 1. For the Schwartz class, the FBI transform is an isometry on $\mathbb{R}^{d}$, i.e., for any $f \in S\left(\mathbb{R}^{d}\right)$

Furthermore; $\left(\mathcal{F}^{\epsilon}\right)^{*} \mathcal{F}^{\epsilon}=\operatorname{Id}_{\mathrm{L}^{2}\left(\mathbb{R}^{d}\right)}$. Meaning the domain of $\mathcal{F}^{\epsilon}$ and $\left(\mathcal{F}^{\epsilon}\right)^{*}$ can be extended to $\mathrm{L}^{2}\left(\mathbb{R}^{d}\right)$ and $\mathrm{L}^{2}\left(\mathbb{R}^{2 d}\right)$ respectively.

Definition 1. Let $\left\{u^{\epsilon}\right\} \subset \mathrm{L}^{2}\left(\mathbb{R}^{d}\right)$ be a family of functions that is uniformly bounded. Given $\delta>0,\left\{\boldsymbol{u}^{\epsilon}\right\}$ is asymptotically high frequency with cut off $\delta$, if

Definition 2. For $M_{n} \in \mathrm{~L}^{\infty}\left(\mathbb{R}^{2 d} ; \mathbb{C}^{N \times N}\right)$ and a Schwartz function $\boldsymbol{u} \in \mathcal{S}\left(\mathbb{R}^{;} \mathbb{C}^{N}\right)$ for each $n=1, \ldots, N$ define the Fourier integral operator $\left(\mathcal{I}_{n}^{\epsilon}(t, M) \boldsymbol{u}\right)(\boldsymbol{x})$ as

Proposition 2. If $M \in \mathrm{~L}^{\infty}\left(\mathbb{R}^{2 d} ; \mathbb{C}^{N \times N}\right)$, for any $t$ and each $n=1, \ldots, N$, $\mathcal{I}_{n}^{\epsilon}(t, M)$ can be extended to a bounded linear operator on $\mathrm{L}^{2}\left(\mathbb{R}^{d} ; \mathbb{C}^{N}\right)$ with bound

This is Proposition 3.7 in [9], a more general version is also proved [11], see Theorem 2.

## 3 Elastic Wave equation

Let $\boldsymbol{u}: \mathbb{R}^{+} \times \mathbb{R}^{3} \rightarrow \mathbb{R}^{3}$ and $\rho, \lambda, \mu: \mathbb{R}^{3} \rightarrow \mathbb{R}$, denote the operator $\mathcal{L} \boldsymbol{u}=$ $(\lambda(\boldsymbol{x})+2 \mu(\boldsymbol{x})) \nabla(\nabla \cdot \boldsymbol{u})-\mu(\boldsymbol{x}) \nabla \times(\nabla \times \boldsymbol{u})$, with the differential operators taken in the spacial variables. We are interested in the Cauchy problem with high frequency initial datum;

We remark that the P -, S - wave speeds are given by;

respectively. With this formulation we must also have $\mathcal{O}\left(\epsilon \boldsymbol{u}_{1}^{\epsilon}\right)=\mathcal{O}\left(\boldsymbol{u}_{0}^{\epsilon}\right)$. Define the following quantities

The eigenvalues of $M_{x}+M_{y}+M_{z}$ are, $\pm c_{\mathrm{p}}, 0, \pm c_{\mathrm{s}}$, with $\pm c_{\mathrm{s}}$ each having a multiplicity of 2 . Once $\boldsymbol{v}$ is known, solving for $\boldsymbol{u}$ is an easy enough task so it's not included in the matrix system. We note here that, $\Theta$ represents the potential for the P -waves and $\Psi$ the potential of the S -waves.

Let $M$ denote the operator $M=M_{x} \partial_{x}+M_{y} \partial_{y}+M_{z} \partial_{z}$ and $X_{0}=X(0)$ be the
initial condition defined appropriately from the Cauchy problem in Eq. (3.1). Denoting $\boldsymbol{p}=\left(p_{1}, p_{2}, p_{3}\right)$, the eigenfunctions and left/right eigenvectors of the matrix system are as follows:

Assuming $p_{1}, p_{2}, p_{3} \neq 0$, we normalize so that $L_{m} \cdot R_{n}=\delta_{n, m}$; otherwise, adjust the eigenvectors accordingly. Equations (3.6)-(3.9) are used for the eigenvalue decomposition form of the FGA; they will not be used in the strong form for the evolution equation, we write them here for completeness.

The Hamiltonian associated with $\Theta, \Psi$

We note that the work done in [8] for the first ordered FGA is the same as the operator is diagonalizable and the eigenspaces are non degenerate. We write $X_{\mathrm{F}}$, to show first order asymptotic equivalence; see corollary 1, to our FGA using the amplitude factor derived from projections.

## 4 The FGA via projection

We begin by defining the FGA derived from its strong form of the evolution equation; define the first order FGA as:

Eq. (4.15) is linear, and thus one can derive the prefactor equations for P- and Swaves individually by assuming $\boldsymbol{A}_{\mathrm{p}} \| \boldsymbol{P}$ or $\boldsymbol{A}_{\mathrm{s}} \perp \boldsymbol{P}$, with the following Gaussian wave packet solution ansatz;

& -\left(\epsilon^{-1} \mathcal{L}_{n, 0}+\mathcal{L}_{n, 1}+\epsilon \mathcal{L}_{n, 2}\right) \mathcal{L}_{n, 0}^{-1}\left(\left(\operatorname{Id}-\Pi_{n}\right)\left(\mathcal{L}_{n, 1}\left(\mathbf{a}_{n, 0} \hat{\mathbf{N}}_{n}\right)\right)\right) \tag{5.37}
\end{align*}
$$

Direct cancellation yields

$$
\begin{align*}
& \left(\partial_{t}^{2}-\mathcal{L}\right) \tilde{\boldsymbol{u}}_{\mathrm{F}, 1}(t, \boldsymbol{x}) \\
& \quad=(2 \pi \epsilon)^{-3 / 2} \sum_{n} G_{n}^{\epsilon} \mathrm{d} \boldsymbol{y} \mathrm{~d} \boldsymbol{q} \mathrm{~d} \boldsymbol{p} \int_{\mathbb{R}^{3 d}} R_{0}(t, \boldsymbol{p}, \boldsymbol{q})+\epsilon R_{1}(t, \boldsymbol{p}, \boldsymbol{q}) \tag{5.38}
\end{align*}
$$

where

$$
\begin{align*}
& R_{0}(t, \boldsymbol{p}, \boldsymbol{q})=\mathcal{L}_{n, 1}\left(\mathbf{a}_{n, 1}\right)+\mathcal{L}_{n, 2}\left(\mathbf{a}_{n, 0}\right)-\mathcal{L}_{n, 1} \mathbf{a}_{n, 1}^{\perp}  \tag{5.39}\\
& R_{1}(t, \boldsymbol{p}, \boldsymbol{q})=\mathcal{L}_{n, 2}\left(\mathbf{a}_{n, 1}\right)-\mathcal{L}_{n, 2} \mathbf{a}_{n, 1}^{\perp} \tag{5.40}
\end{align*}
$$

Then by Propositions 2 and 8

$$
\begin{equation*}
\left\|\left(\partial_{t}^{2}-\mathcal{L}\right) \tilde{\boldsymbol{u}}_{\mathrm{F}, 1}(t, \cdot)\right\|_{\mathrm{L}^{2}} \leq C_{T, \delta}\left(\left\|R_{0}(t, \cdot)\right\|_{\mathrm{L}^{\infty}}+\epsilon\left\|R_{1}(t, \cdot)\right\|_{\mathrm{L}^{\infty}}\right) \tag{5.41}
\end{equation*}
$$

By prop. $8,7 R_{0}$ and $R_{1}$ are bounded.
Proposition 11. Let $\boldsymbol{u}$ solve the Cauchy problem (3.1). If $\boldsymbol{u}_{\mathrm{F}, 0}$ is the first order FGA approximation (4.1), then we have the following estimate with the initial conditions.

$$
\begin{equation*}
\left\|\boldsymbol{u}(0, \boldsymbol{x})-\boldsymbol{u}_{\mathrm{F}}(0, \boldsymbol{x})\right\|_{\mathrm{E}} \leq \epsilon C_{T} \tag{5.42}
\end{equation*}
$$

Proof. First computing the following;

$$
\begin{equation*}
\partial_{t} \mathbf{a}_{n}(0, \boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p})=\alpha(\boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p})\left(\frac{\partial c(\boldsymbol{q}) \cdot \boldsymbol{p}}{|\boldsymbol{p}|}-d\right) \hat{\boldsymbol{n}}_{n} \tag{5.43}
\end{equation*}
$$

For estimating $\boldsymbol{u}(0, \boldsymbol{x})-\boldsymbol{u}_{\mathrm{F}, 0}(0, \boldsymbol{x})$ in the energy norm, we can write $\partial_{t} u(0, x)=$ $u_{1}^{\epsilon}(\boldsymbol{x})$. In terms of the FIO this gives;

\begin{align*}
\int_{\mathbb{R}^{3 d}} u_{0}^{\epsilon}(\boldsymbol{y}) \frac{\mathrm{i}}{\epsilon} \Phi_{n}(0, \boldsymbol{x}, \boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p}) G_{n}^{\epsilon} & (0, \boldsymbol{x}, \boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p}) \mathrm{d} \boldsymbol{y} \mathrm{~d} \boldsymbol{q} \mathrm{~d} \boldsymbol{p} \\
& =\int_{\mathbb{R}^{3 d}} \boldsymbol{u}_{1}^{\epsilon}(\boldsymbol{y}) G_{n}^{\epsilon}(0, \boldsymbol{x}, \boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p}) \mathrm{d} \boldsymbol{y} \mathrm{~d} \boldsymbol{q} \mathrm{~d} \boldsymbol{p} \tag{5.44}
\end{align*}
$$

Then

$$
\begin{align*}
& \left|\boldsymbol{u}_{1}^{\epsilon}(0, \boldsymbol{x})-\partial_{t} \boldsymbol{u}_{\mathrm{F}, 0}(0, \boldsymbol{x})\right|=(2 \pi \epsilon)^{-d / 2} \left\lvert\, \sum_{n} \int_{\mathbb{R}^{3 d}}\left(\frac{1}{2}\left(\boldsymbol{u}_{1}^{\epsilon}(y) \cdot \hat{\boldsymbol{n}}\right) \hat{\boldsymbol{n}}\right.\right. \\
& \left.\quad-\partial_{t} \mathbf{a}_{n}(0, \boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p})-\mathbf{a}_{n} \frac{\mathrm{i}}{\epsilon} \Phi_{n}(0, \boldsymbol{x}, \boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p})\right) G_{n}^{\epsilon}(0, \boldsymbol{x}, \boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p}) \mathrm{d} \boldsymbol{y} \mathrm{~d} \boldsymbol{q} \mathrm{~d} \boldsymbol{p} \tag{5.45}
\end{align*}
$$

For one terms this is after plugging in 5.44,

$$
\begin{align*}
& \int_{\mathbb{R}^{3 d}}\left(u_{0}^{\epsilon}(\boldsymbol{y}) \frac{\mathrm{i}}{2 \epsilon} \Phi_{n}(0, \boldsymbol{x}, \boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p})-\alpha(\boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p})\left(\frac{\partial c(\boldsymbol{q}) \cdot \boldsymbol{p}}{|\boldsymbol{p}|}-d\right) \hat{\boldsymbol{n}}_{n}\right. \\
&-2^{d / 2} \alpha(\boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p}) \hat{\boldsymbol{n}}_{n}\left.\frac{\mathrm{i}}{\epsilon} \Phi_{n}(0, \boldsymbol{x}, \boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p})\right) \\
& \times G_{n}^{\epsilon}(0, \boldsymbol{x}, \boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p}) \mathrm{d} \boldsymbol{x} \mathrm{~d} \boldsymbol{y} \mathrm{~d} \boldsymbol{q} \mathrm{~d} \boldsymbol{p} \tag{5.46}
\end{align*}
$$

Plugging in $\alpha_{n}$ from (4.8) and summing over the wavefields and branches gives

$$
\begin{align*}
& \boldsymbol{u}_{1}^{\epsilon}(\boldsymbol{x})-\partial_{t} \boldsymbol{u}_{\mathrm{F}, 0}(0, \boldsymbol{x})= \\
&-\sum_{n} \int_{\mathbb{R}^{3 d}} \frac{1}{2 c_{n}|\boldsymbol{p}|^{3}}\left(\boldsymbol{u}_{0}^{\epsilon}(\boldsymbol{y}) c_{n}|\boldsymbol{p}| \pm \mathrm{i} \epsilon \boldsymbol{u}_{1}^{\epsilon}(\boldsymbol{y})\right) \cdot \hat{\boldsymbol{n}}_{n} \\
& \times\left(\frac{\partial c(\boldsymbol{q}) \cdot \boldsymbol{p}}{|\boldsymbol{p}|}-d\right) \hat{\boldsymbol{n}}_{n} G_{n}^{\epsilon}(0, \boldsymbol{x}, \boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p}) \mathrm{d} \boldsymbol{y} \mathrm{~d} \boldsymbol{q} \mathrm{~d} \boldsymbol{p} \tag{5.47}
\end{align*}
$$

By Proposition (2) we can arrive at the estimate

$$
\begin{equation*}
\left\|\boldsymbol{u}_{1}^{\epsilon}-\partial_{t} \boldsymbol{u}_{\mathrm{F}, 0}(0, \cdot)\right\|_{\mathrm{L}^{2}} \leq C_{T} \tag{5.48}
\end{equation*}
$$

For the Div term,

$$
\begin{align*}
& \nabla \cdot \boldsymbol{u}_{\mathrm{F}}(0, \boldsymbol{x}) \mathrm{d} \boldsymbol{x} \\
& \quad=(2 \pi \epsilon)^{-d / 2} \sum_{n} \int_{\mathbb{R}^{3 d}} \nabla \cdot\left(\mathbf{a}_{n}(0, \boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p}) G_{n}^{\epsilon}(0, \boldsymbol{x}, \boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p})\right) \mathrm{d} \boldsymbol{y} \mathrm{~d} \boldsymbol{q} \mathrm{~d} \boldsymbol{p} \\
& =(2 \pi \epsilon)^{-d / 2} \sum_{n} \int_{\mathbb{R}^{3 d}} \frac{\mathrm{i}}{\epsilon} \mathbf{a}_{n} \cdot\left(\boldsymbol{P}_{n}+\left(\boldsymbol{x}-\boldsymbol{Q}_{n}\right)\right) G_{n}^{\epsilon}(0, \boldsymbol{x}, \boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p}) \mathrm{d} \boldsymbol{y} \mathrm{~d} \boldsymbol{q} \mathrm{~d} \boldsymbol{p} \tag{5.49}
\end{align*}
$$

applying the operators and integration by parts gives

$$
\begin{equation*}
\int_{\mathbb{R}^{d}}\left(\frac{\mathrm{i}}{\epsilon} \mathbf{a}_{n} \cdot \boldsymbol{p}_{n}-\partial_{\boldsymbol{z}}\left(Z^{-1} \mathbf{a}\right)\right) G_{n}^{\epsilon}(0, \boldsymbol{x}, \boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p}) \boldsymbol{x} \tag{5.50}
\end{equation*}
$$

Now consider the difference, $\nabla \cdot \boldsymbol{u}_{0}^{\epsilon}-\nabla \cdot \boldsymbol{u}_{\mathrm{F}, 0}(t, \boldsymbol{x})$. Writing in terms of the FIO and writing one term

$$
\begin{align*}
\int_{\mathbb{R}^{3 d}}\left(\frac{\mathrm{i}}{\epsilon}\left(\boldsymbol{u}_{0}^{\epsilon}(\boldsymbol{y})-\mathbf{a}(0, \boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p})\right) \cdot \boldsymbol{P}_{n}+\partial_{\boldsymbol{z}}\left(Z^{-1}\left(\boldsymbol{u}_{0}^{\epsilon}(\boldsymbol{y})-\mathbf{a}(0, \boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p})\right)\right)\right) \\
\times G_{n}^{\epsilon}(0, \boldsymbol{x}, \boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p}) \mathrm{d} \boldsymbol{y} \mathrm{~d} \boldsymbol{q} \mathrm{~d} \boldsymbol{p} \tag{5.51}
\end{align*}
$$

With $\mathbf{a}(0, \boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p})=\alpha_{n}(\boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p}) \hat{\boldsymbol{n}}$ and summing over $n$ we have;

$$
\begin{align*}
& \nabla \cdot \boldsymbol{u}_{0}^{\epsilon}(\boldsymbol{x})-\nabla \cdot \boldsymbol{u}_{\mathrm{F}, 0}(0, \boldsymbol{x})= \\
& \qquad \sum_{n} \int_{\mathbb{R}^{d}} \partial_{\boldsymbol{z}}\left(Z^{-1}\left(\boldsymbol{u}_{0}^{\epsilon}(\boldsymbol{y})-\alpha_{n}(\boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p}) \hat{\boldsymbol{n}}\right) G_{n}^{\epsilon}(0, \boldsymbol{x}, \boldsymbol{y}, \boldsymbol{q}, \boldsymbol{p}) \boldsymbol{x}\right. \tag{5.52}
\end{align*}
$$

Again, by Proposition (2) we arrive at the estimate

$$
\begin{equation*}
\left\|\nabla \cdot \boldsymbol{u}_{0}^{\epsilon}-\nabla \cdot \boldsymbol{u}_{\mathrm{F}, 0}(t, \cdot) \mathrm{d} \boldsymbol{x}\right\|_{\mathrm{L}^{2}} \leq C_{T} \tag{5.53}
\end{equation*}
$$

The Curl term has a similar estimate as the Div term. These 3 estimates show the result.

Theorem 2. Let $\left\{u_{0}^{\epsilon}\right\}$ be a family of asymptotically high frequency initial conditions, and let $\boldsymbol{u}$ solve the Cauchy problem (3.1). If $\boldsymbol{u}_{\mathrm{F}, 0}$ is the first order FGA approximation (4.1), then for a given $T$ and any $t \in[0, T], \delta>0$ and sufficiently small $\epsilon$, we have

$$
\begin{equation*}
\sup _{t \in[0, T]}\left\|\boldsymbol{u}(t, \cdot)-\boldsymbol{u}_{\mathrm{F}, 0}(t, \cdot)\right\|_{\mathrm{E}} \leq \epsilon C_{T, \delta} \tag{5.54}
\end{equation*}
$$

Proof.

$$
\begin{equation*}
\left\|\boldsymbol{u}-\boldsymbol{u}_{\mathrm{F}, 0}\right\|_{\mathrm{E}} \leq+\left\|\boldsymbol{u}-\tilde{\boldsymbol{u}}_{\mathrm{F}, 1}\right\|_{\mathrm{E}}+\left\|\tilde{\boldsymbol{u}}_{\mathrm{F}, 1}-\boldsymbol{u}_{\mathrm{F}, 1}\right\|_{\mathrm{E}}+\left\|\boldsymbol{u}_{\mathrm{F}, 1}-\boldsymbol{u}_{\mathrm{F}, 0}\right\|_{\mathrm{E}} \tag{5.55}
\end{equation*}
$$

For the first term define the quantity $e=\boldsymbol{u}-\tilde{\boldsymbol{u}}_{\mathrm{F}, 1}$. By prop. 9

$$
\begin{equation*}
\|e\|_{\mathrm{E}} \leq C_{T, \delta}\left(\|e(0, \cdot)\|_{\mathrm{E}}+\epsilon \int_{0}^{t}\left\|R_{0}\right\|_{\mathrm{L}^{2}} \mathrm{~d} s\right)+\mathcal{O}\left(\epsilon^{2}\right) \tag{5.56}
\end{equation*}
$$

Prop 11 shows that $\|e(0, \cdot)\|_{\mathrm{E}} \leq \epsilon C_{T, \delta}$. Also, prop. 8 and 7 show $\left\|R_{0}\right\|_{\mathrm{L}^{2}} \leq C_{T, \delta}$. Thus the first is estimated at the correct order. For the second term, is $\mathcal{O}\left(\epsilon^{\infty}\right)$ by 6 , and the last term is estimated to the desired order by prop. 5 .

As a consequence of the energy norm, we have the following corollary;
Corollary 1. Under the same assumptions as Theorem 2, define $U_{\mathrm{F}}$ as

$$
\begin{equation*}
U_{\mathrm{F}}=\left(\partial_{t} \boldsymbol{u}_{\mathrm{F}}, \nabla \cdot \boldsymbol{u}_{\mathrm{F}}, \nabla \times \boldsymbol{u}_{\mathrm{F}}\right) \tag{5.57}
\end{equation*}
$$

Define $X_{\mathrm{F}}$ as in eq. 3.22 and let $X$ be the solution to the hyperbolic system 3.4, then we have the estimate

$$
\begin{equation*}
\sup _{t \in[0, T]}\left\|X_{\mathrm{F}, 0}(t, \cdot)-U_{\mathrm{F}, 0}(t, \cdot)\right\|_{\mathrm{L}^{2}} \leq \epsilon C_{T, \delta} \tag{5.58}
\end{equation*}
$$

Proof. Applying the triangle inequality gives the immediate result.

$$
\begin{equation*}
\left\|X_{\mathrm{F}, 0}-U_{\mathrm{F}, 0}\right\|_{\mathrm{L}^{2}} \leq\left\|X-X_{\mathrm{F}, 0}\right\|_{\mathrm{L}^{2}}+\left\|X-U_{\mathrm{F}, 0}\right\|_{\mathrm{L}^{2}} \leq \epsilon C_{T, \delta}+\left\|\boldsymbol{u}-\boldsymbol{u}_{\mathrm{F}, 0}\right\|_{\mathrm{E}} \tag{5.59}
\end{equation*}
$$

Where $\left\|X-X_{\mathrm{F}, 0}\right\|_{\mathrm{L}^{2}}$ is bounded from (3.21).
