# A note on the lower bound of representation functions

#### Abstract

For a set $A$ of nonnegative integers, let $R_{2}(A, n)$ denote the number of solutions to $n=a+a^{\prime}$ with $a, a^{\prime} \in A, a<a^{\prime}$. Let $A_{0}$ be the Thue-Morse sequence and $B_{0}=\mathbb{N} \backslash A_{0}$. Let $A \subset \mathbb{N}$ and $N$ be a positive integer such that $R_{2}(A, n)=R_{2}(\mathbb{N} \backslash A, n)$ for all $n \geq 2 N-1$. Previously, the first author proved that if $\left|A \cap A_{0}\right|=+\infty$ and $\left|A \cap B_{0}\right|=+\infty$, then $R_{2}(A, n) \geq \frac{n+3}{56 N-52}-1$ for all $n \geq 1$. In this paper, we prove that the above lower bound is nearly best possible. We also get some other results.

## 1 Introduction

Let $\mathbb{N}$ be the set of nonnegative integers. For a set $A \subseteq \mathbb{N}$, let $R_{2}(A, n)$ denote the number of solutions to $a+a^{\prime}=n$ with $a, a^{\prime} \in A, a<a^{\prime}$. In the last few decades, there are many research on

[^0]the representation function $R_{2}(A, n)$. Professor Sárközy posed the problem that whether there exist two sets $A$ and $B$ with infinite symmetric difference such that $R_{2}(A, n)=R_{2}(B, n)$ for all sufficiently large integers $n$. Let $D(0)=0$ and let $D(a)$ be the number of ones in the binary representation of $a$. Let $A_{0}$ be the set of all nonnegative integers $a$ with even $D(a)$ and let $B_{0}=\mathbb{N} \backslash A_{0}$. The sequence $A_{0}$ is called Thue-Morse sequence. In 2002, Dombi [6] proved that $R_{2}\left(A_{0}, n\right)=R_{2}\left(B_{0}, n\right)$ for all $n \geq 0$ which answered the problem. In 2004, using the generating functions, Sándor [13] proved the following precise formulation.

Theorem A ([13, Theorem 1]). Let $N$ be a positive integer. Then $R_{2}(A, n)=R_{2}(\mathbb{N} \backslash A, n)$ for all $n \geq 2 N-1$ if and only if $|A \cap[0,2 N-1]|=N$ and $2 m \in A \Leftrightarrow m \in A, 2 m+1 \in A \Leftrightarrow m \notin A$ for all $m \geq N$.

Let $R_{A, B}(n)$ be the number of solutions to $a+b=n, a \in A, b \in B$. In 2011, Chen [1] gave the lower bound of $R_{2}(A, n)$. The following theorems are proved.

Theorem B ([1, Theorem 1.4 (i)]). Let $A$ be a subset of $\mathbb{N}$ and $N$ be a positive integer such that $R_{2}(A, n)=R_{2}(\mathbb{N} \backslash A, n)$ for all $n \geq 2 N-1$. If $\left|A \cap A_{0}\right|=+\infty$ and $\left|A \cap B_{0}\right|=+\infty$, then for all $n \geq 1$, we have

$$
R_{2}(A, n) \geq \frac{n}{40 N(N+1)}-1, \quad R_{A, \mathbb{N} \backslash A}(n) \geq \frac{n}{20 N(N+1)}-1 .
$$

Theorem C $\left(\left[1\right.\right.$, Theorem 1.5]). Let $A$ be a subset of $\mathbb{N}$ and $N$ be a positive integer such that $R_{2}(A, n)=$ $R_{2}(\mathbb{N} \backslash A, n)$ for all $n \geq 2 N-1$. Then, for any function $f$ with $f(x) \rightarrow+\infty$ as $x \rightarrow+\infty$, the set of integers $n$ with

$$
R_{2}(A, n) \geq \frac{n}{16}-f(n), \quad R_{A, \mathbb{N} \backslash A}(n) \geq \frac{n}{8}-f(n)
$$

has the density one.
Recently, Jiang, Sándor and Yang [11] improved the result of Theorem C as follows.
Theorem D ([11, Corrolary 1.3]). Let $A$ be a subset of $\mathbb{N}$ and $N$ be a positive integer such that $R_{2}(A, n)=R_{2}(\mathbb{N} \backslash A, n)$ for all $n \geq 2 N-1$. Then for any $0<\theta<\frac{2 \log 2-\log 3}{42 \log 2-9 \log 3}=0.0149 \ldots$, the set of integers $n$ with

$$
R_{2}(A, n)=\frac{n}{8}+O\left(n^{1-\theta}\right)
$$

has density one.
They also posed a problem for further research.
Problem 1.1. ([11, Problem 1.5]) Let $A$ be a subset of $\mathbb{N}$ and $N$ be a positive integer such that $R_{2}(A, n)=R_{2}(\mathbb{N} \backslash A, n)$ for all $n \geq 2 N-1$. Does there exist a sequence $n_{1}, n_{2}, \ldots$ such that

$$
\lim _{k \rightarrow \infty} \frac{R_{2}\left(A, n_{k}\right)}{n_{k}} \neq \frac{1}{8} ?
$$

Afterwards, Jiang [12] improved the result of Theorem B.
Theorem $\mathrm{E}\left(\left[12\right.\right.$, Theorem 1.4]). Let $A$ be a subset of $\mathbb{N}$ and $N \geq 2$ such that $R_{2}(A, n)=R_{2}(\mathbb{N} \backslash A, n)$ for all $n \geq 2 N-1$. If $\left|A \cap A_{0}\right|=+\infty$ and $\left|A \cap B_{0}\right|=+\infty$, then for all $n \geq 1$, we have

$$
R_{2}(A, n) \geq \frac{n+3}{56 N-52}-1, \quad R_{A, \mathbb{N} \backslash A}(n) \geq \frac{n+3}{28 N-26}-1 .
$$

For more related result, see $[2,3,5,4,7,8,9,10,14,15,16]$. In this paper, we prove that the lower bound of Theorem E is nearly best possible. The following theorems are proved.

Theorem 1.2. Let $N \geq 2$. Then there exists a set $A \subseteq \mathbb{N}$ such that $R_{2}(A, n)=R_{2}(\mathbb{N} \backslash A, n)$ for all $n \geq 2 N-1,\left|A \cap A_{0}\right|=+\infty,\left|A \cap B_{0}\right|=+\infty$ and

$$
R_{2}(A, n) \leq \frac{n+1}{4 \cdot 2^{\left\lfloor\log _{2}(N-1)\right\rfloor}}
$$

for infinitely many integers $n$.
As corollaries we get the following two results
Corollary 1.3. Let $N \geq 3$. Then there exists a set $A \subseteq \mathbb{N}$ such that $R_{2}(A, n)=R_{2}(\mathbb{N} \backslash A, n)$ for all $n \geq 2 N-1,\left|A \cap A_{0}\right|=+\infty,\left|A \cap B_{0}\right|=+\infty$ and

$$
R_{2}(A, n)<\frac{n+1}{2(N-1)}
$$

for infinitely many integers $n$.
Corollary 1.4. For $k \geq 0$, let $M_{k}=2^{k}+1$. Then there exists a set $D_{k} \subseteq \mathbb{N}$ such that $R_{2}\left(D_{k}, n\right)=$ $R_{2}\left(\mathbb{N} \backslash D_{k}, n\right)$ for all $n \geq 2 M_{k}-1,\left|D_{k} \cap A_{0}\right|=+\infty,\left|D_{k} \cap B_{0}\right|=+\infty$ and

$$
R_{2}\left(D_{k}, n\right) \leq \frac{n+1}{4\left(M_{k}-1\right)}
$$

for infinitely many integers $n$.
A trivial corollary of [12] is the following result.
Corollary 1.5. Let $A$ be a subset of $\mathbb{N}$ and $N \geq 2$ such that $R_{2}(A, n)=R_{2}(\mathbb{N} \backslash A, n)$ for all $n \geq 2 N-1$. If $\left|A \cap A_{0}\right|=+\infty$ and $\left|A \cap B_{0}\right|=+\infty$, then for all $n \geq 56 N-54$, we have

$$
R_{2}(A, n) \geq 1
$$

The bound $56 N-54$ can be improved to $14(N-1)$ (see [12]).
Theorem $\mathrm{F}\left(\left[12\right.\right.$, Theorem 1.3]). Let $A$ be a subset of $\mathbb{N}$ and $N \geq 2$ such that $R_{2}(A, n)=R_{2}(\mathbb{N} \backslash A, n)$ for all $n \geq 2 N-1$. If $A \neq A_{0}, B_{0}$ then for all $n \geq 14(N-1)$, we have

$$
R_{2}(A, n) \geq 1
$$

The following statements show that the previous theorem nearly best possible.

Theorem 1.6. For nonnegative integers $k$, let $N_{k}=3 \cdot 4^{k}$. Then there exists a set $C_{k} \subseteq \mathbb{N}$ such that $R_{2}\left(C_{k}, n\right)=R_{2}\left(\mathbb{N} \backslash C_{k}, n\right)$ for all $n \geq 2 N_{k}-1,\left|C_{k} \cap A_{0}\right|=+\infty,\left|C_{k} \cap B_{0}\right|=+\infty$ and

$$
R_{2}\left(C_{k}, \frac{14}{3} N_{k}-1\right)=0
$$

Theorem 1.7. Let $N \geq 3$. Then there exists a set $A \subseteq \mathbb{N}$ such that $R_{2}(A, n)=R_{2}(\mathbb{N} \backslash A, n)$ for all $n \geq 2 N-1,\left|A \cap A_{0}\right|=+\infty,\left|A \cap B_{0}\right|=+\infty$ and

$$
R_{2}(A, 3 N-1)=0
$$

## 2 Proofs

In this section, we prove our main results. Firstly, we give a lemma which will be used in the proofs of theorems.

Lemma 2.1. ([4, Lemma 1]) Let $A$ be a subset of $\mathbb{N}$ such that $R_{2}(A, n)=R_{2}(\mathbb{N} \backslash A, n)$ for all $n \geq 2 N-1$. Let $l, k, i$ be integers with $k \geq N, l \geq 0$ and $0 \leq i \leq 2^{l}-1$. Then
(i) if $2 \mid D(i)$, then $k \in A \Leftrightarrow 2^{l} k+i \in A$;
(ii) if $2 \nmid D(i)$, then $k \in A \Leftrightarrow 2^{l} k+i \notin A$.

Now, we give the proofs of theorems.
Proof of Theorem 1.2. Let

$$
\begin{equation*}
A \cap[0,2 N-1]=\left(A_{0} \cap[2,2 N-3]\right) \cup\{2 N-2,2 N-1\} \tag{2.1}
\end{equation*}
$$

For $a \geq N$, let $2 a \in A, 2 a+1 \notin A$ if $a \in A$ and $2 a \notin A, 2 a+1 \in A$ if $a \notin A$. By Theorem A, $R_{2}(A, n)=R_{2}(\mathbb{N} \backslash A, n)$ for all $n \geq 2 N-1$. By definition of $A_{0}$, we get that $\left|\{2 N-2,2 N-1\} \cap A_{0}\right|=1$. It follows that $\left|A \cap A_{0}\right|=+\infty$ and $\left|A \cap B_{0}\right|=+\infty$. It is enough to prove that there are infinitely many integers $n$ with $R_{2}(A, n) \leq \frac{n+1}{4 \cdot 2^{\left.\log _{2}(N-1)\right]}}$.

For $N \leq k \leq 2 N-1$, let $S^{(k)}=A_{0}$ if $k \in A$ and $S^{(k)}=B_{0}$ if $k \notin A$. By Lemma 2.1, one can get easily that

$$
A=\left(A_{0} \cap[2, N-1]\right) \cup\left(\cup_{l=0}^{\infty} \cup_{k=N}^{2 N-1}\left(2^{l} k+\left[0,2^{l}-1\right] \cap S^{(k)}\right)\right) .
$$

Furthermore, by (2.1),

$$
\left(\cup_{l=0}^{\infty} \cup_{k=N}^{2 N-3}\left(2^{l} k+\left[0,2^{l}-1\right] \cap S^{(k)}\right)\right) \subseteq A_{0}
$$

and we have that, if $2 N-2 \in B_{0}$, then

$$
\begin{aligned}
& \left(\cup_{l=0}^{\infty}\left(2^{l}(2 N-2)+\left[0,2^{l}-1\right] \cap S^{(2 N-2)}\right)\right) \subseteq B_{0} \\
& \left(\cup_{l=0}^{\infty}\left(2^{l}(2 N-1)+\left[0,2^{l}-1\right] \cap S^{(2 N-1)}\right)\right) \subseteq A_{0}
\end{aligned}
$$

if $2 N-1 \in B_{0}$, then

$$
\begin{aligned}
&\left(\cup_{l=0}^{\infty}\left(2^{l}(2 N-2)+\left[0,2^{l}-1\right] \cap S^{(2 N-2)}\right)\right) \subseteq A_{0}, \\
&\left(\cup_{l=0}^{\infty}\left(2^{l}(2 N-1)+\left[0,2^{l}-1\right] \cap S^{(2 N-1)}\right)\right) \subseteq B_{0} .
\end{aligned}
$$

It is known that $R_{2}\left(A_{0}, 2^{2 m+1}-1\right)=0$ for any nonnegative integers $m$. Thus, if $2^{2 m+1}-1=a+a^{\prime}$ with $a<a^{\prime}$ and $a, a^{\prime} \in A$, then either $a \in A \backslash A_{0}$ or $a^{\prime} \in A \backslash A_{0}$. Let us suppose that $2 N-i \in B_{0}$, where $i=1$ or 2 . Then

$$
A \backslash A_{0}=\cup_{l=0}^{\infty}\left(2^{l}(2 N-i)+\left[0,2^{l}-1\right] \cap A_{0}\right) .
$$

Hence

$$
\begin{aligned}
R_{2}\left(A, 2^{2 m+1}-1\right) & \leq\left|\left(A \backslash A_{0}\right) \cap\left[0,2^{2 m+1}-1\right]\right| \\
& =\left|\left(\cup_{l=0}^{\infty}\left(2^{l}(2 N-i)+\left[0,2^{l}-1\right] \cap A_{0}\right)\right) \cap\left[0,2^{2 m+1}-1\right]\right| .
\end{aligned}
$$

If $2^{l}(2 N-2) \geq 2^{2 m+1}$ for some $l$, then for

$$
a \in\left(2^{l}(2 N-i)+\left[0,2^{l}-1\right] \cap A_{0}\right),
$$

we have $a \geq 2^{2 m+1}$. Therefore, for $m>\frac{\log _{2}(N-1)}{2}$,

$$
\begin{array}{r}
R_{2}\left(A, 2^{2 m+1}-1\right) \leq \sum_{l=0}^{\left\lceil 2 m-1-\log _{2}(N-1)\right\rceil}\left|\left[0,2^{l}-1\right] \cap A_{0}\right| \\
=1+\sum_{l=1}^{\left\lceil 2 m-1-\log _{2}(N-1)\right\rceil} 2^{l-1}=2^{\left\lceil 2 m-1-\log _{2}(N-1)\right\rceil}=\frac{2^{2 m+1}}{4 \cdot 2^{\left\lfloor\log _{2}(N-1)\right\rfloor}} .
\end{array}
$$

This completes the proof.
Proof of Theorem 1.6. Let

$$
C_{0} \cap[0,5]=\{0,3,4\}
$$

and let $2 c \in C_{0}, 2 c+1 \notin C_{0}$ if $c \in C_{0}$ and $2 c \notin C_{0}, 2 c+1 \in C_{0}$ if $c \notin C_{0}$ for $c \geq 3$. For $k \geq 1$, let

$$
C_{k}=\left(4 C_{k-1}+\{0,3\}\right) \cup\left(4\left(\mathbb{N} \backslash C_{k-1}\right)+\{1,2\}\right) .
$$

Now, we prove that $C_{k}$ is the desired set by using induction on $k$.
By Theorem A, one can verify easily that Theorem 1.6 holds for $k=0$. Suppose that it is true for $k-1(k \geq 1)$. Then

$$
\begin{gathered}
\left|C_{k-1} \cap\left[0,2 N_{k-1}-1\right]\right|=\left|\left(\mathbb{N} \backslash C_{k-1}\right) \cap\left[0,2 N_{k-1}-1\right]\right|=N_{k-1}, \\
\left|C_{k-1} \cap A_{0}\right|=+\infty, \quad\left|C_{k-1} \cap B_{0}\right|=+\infty
\end{gathered}
$$

and for $m \geq N_{k-1}$,

$$
\begin{equation*}
2 m \in C_{k-1} \Leftrightarrow m \in C_{k-1}, \quad 2 m+1 \in C_{k-1} \Leftrightarrow m \notin C_{k-1} . \tag{2.2}
\end{equation*}
$$

By the definition of $C_{k}$,

$$
\left|C_{k} \cap\left[0,2 N_{k}-1\right]\right|=2\left(\left|C_{k-1} \cap\left[0,2 N_{k-1}-1\right]\right|+\left|\left(\mathbb{N} \backslash C_{k-1}\right) \cap\left[0,2 N_{k-1}-1\right]\right|\right)=N_{k}
$$

and

$$
\left|C_{k} \cap A_{0}\right|=+\infty, \quad\left|C_{k} \cap B_{0}\right|=+\infty
$$

For $m \geq N_{k}$, by (2.2),

$$
2 m \in C_{k} \Leftrightarrow m \in C_{k}, \quad 2 m+1 \in C_{k} \Leftrightarrow m \notin C_{k} .
$$

It follows from Theorem A that $R_{2}\left(C_{k}, n\right)=R_{2}\left(\mathbb{N} \backslash C_{k}, n\right)$ for all $n \geq 2 N_{k}-1$.
Suppose that $\frac{14}{3} N_{k}-1=14 \cdot 4^{k}-1=a_{k}+a_{k}^{\prime}$ for some $a_{k}, a_{k}^{\prime} \in C_{k}, a_{k}<a_{k}^{\prime}$. Then there exist integers $a_{k-1}, a_{k-1}^{\prime} \in C_{k-1}$ such that

$$
14 \cdot 4^{k}-1=4 a_{k-1}+\left(4 a_{k-1}^{\prime}+3\right)
$$

or there exist integers $a_{k-1}, a_{k-1}^{\prime} \in \mathbb{N} \backslash C_{k-1}$ such that

$$
14 \cdot 4^{k}-1=\left(4 a_{k-1}+1\right)+\left(4 a_{k-1}^{\prime}+2\right) .
$$

Hence,

$$
\frac{14}{3} N_{k-1}-1=14 \cdot 4^{k-1}-1=a_{k-1}+a_{k-1}^{\prime}
$$

where $a_{k-1}, a_{k-1}^{\prime} \in C_{k-1}$ or $a_{k-1}, a_{k-1}^{\prime} \in \mathbb{N} \backslash C_{k-1}$. Clearly, $a_{k-1} \neq a_{k-1}^{\prime}$. Since $R_{2}\left(C_{k-1}, n\right)=$ $R_{2}\left(\mathbb{N} \backslash C_{k-1}, n\right)$ for all $n \geq 2 N_{k-1}-1$, we have $R_{2}\left(C_{k-1}, \frac{14}{3} N_{k-1}-1\right) \geq 1$, a contradiction. This completes the proof.

Proof of Theorem 1.7. For odd integers $N$, let

$$
A \cap[0,2 N-1]=\left\{1,3,5, \cdots, N-2, N, N+1, \cdots, \frac{3 N-1}{2}\right\}
$$

and let $2 a \in A, 2 a+1 \notin A$ if $a \in A$ and $2 a \notin A, 2 a+1 \in A$ if $a \notin A$ for $a \geq N$. Then $\left|A \cap A_{0}\right|=+\infty$, $\left|A \cap B_{0}\right|=+\infty$ and

$$
A \cap[2 N, 3 N-1]=\{2 N, 2 N+2,2 N+4, \cdots, 3 N-1\} .
$$

It is easy to see that $R_{2}(A, 3 N-1)=0$. By Theorem $\mathrm{A}, R_{2}(A, n)=R_{2}(\mathbb{N} \backslash A, n)$ for all $n \geq 2 N-1$.
For even integers $N$, let

$$
A \cap[0,2 N-1]=\left\{0,2,4, \cdots, N-2, N, N+1, \cdots, \frac{3 N}{2}-1\right\}
$$

and let $2 a \in A, 2 a+1 \notin A$ if $a \in A$ and $2 a \notin A, 2 a+1 \in A$ if $a \notin A$ for $a \geq N$. Similar to the above argument, we can get the same result. This completes the proof.
