SYMMETRY ACTUATED CLOSED-LOOP HAMILTONIAN SYSTEMS

ABSTRACT. This paper extends the theory of controlled Hamiltonian systems with symmetries due to [23, 9, 10, 6, 7, 11] to the case of non-abelian symmetry groups G and semi-direct product configuration spaces. The notion of symmetry actuating forces is introduced and it is shown, that Hamiltonian systems subject to such forces permit a conservation law, which arises as a controlled perturbation of the G-momentum map. Necessary and sufficient matching conditions are given to relate the closed-loop dynamics, associated to the forced Hamiltonian system, to an unforced Hamiltonian system. These matching conditions are then applied to general Lie-Poisson systems, to the example of ideal charged fluids in the presence of an external magnetic field ([20]), and to the satellite with a rotor example ([9, 10]).

Introduction

Feedback control of Hamiltonian systems with symmetries. The method of controlled Lagrangian and Hamiltonian systems has started with [23, 9] and then been further developed in [6, 7, 11, 10, 29]. Reviews are contained in [8] and [25]. In [11] it is shown, for general systems and without explicitly considering symmetries, that the methods of controlled Lagrangian and Hamiltonian systems are equivalent.

The prototypical example with regard to this method is the satellite with a rotor. In this example the satellite is modelled as a rigid body and a rotor is attached to the third principal axis. If the rotor is turned sufficiently fast, the satellite becomes stable for rotations about the middle axis. Since the middle axis is otherwise an unstable equilibrium of the rigid body, this means that the rotor control can be used to stabilize the system. What "sufficiently fast" means has been worked out by [9]. Their construction is based on the observation that the rotor control depends on the satellite body angular momentum, which leads to a feedback system, and this feedback system can be reformulated as a Hamiltonian system. Thus, the (non-linear) stability analysis of [1, 21] can be used to find a stabilizing control.

In [6, 7, 11] this approach has been systematized in the following manner, both for Lagrangian and Hamiltonian systems: The authors of loc. cit. start with a mechanical system which is assumed to be of Kaluza-Klein type on a configuration space P. That is, $\pi: P \to M$ is a (finite-dimensional) principal fiber bundle with structure group G; $(\mu_0^M, \mathbb{I}_0, \mathcal{A}_0)$ is a set of Kaluza-Klein data consisting of metric, inertia tensor and connection form, such that the metric μ_0^P on P is given by $(\mu_0^P)_{\omega}(\xi,\zeta) = (\mu_0^M)_{\pi(\omega)}(T_{\omega}\pi.\xi,T_{\omega}\pi.\zeta) + (\mathbb{I}_0)_{\omega}(\mathcal{A}_0(\omega).\xi,\mathcal{A}_0(\omega).\zeta)$; the Hamiltonian is of the form $H_0(\Pi) = \frac{1}{2}\langle \Pi, (\mu_0^P)^{-1}\Pi \rangle + V(\omega)$ where $\omega = \tau(\Pi)$ is the base point and $V: P \to \mathbb{R}$ is a G-invariant potential. Now, the Kaluza-Klein data can be perturbed to obtain a controlled set $(\mu_C^M, \mathbb{I}_C, \mathcal{A}_C)$, and thus a controlled Hamiltonian H_C (with the same potential V). In loc. cit. it is shown how, under certain conditions, the equations of motion

corresponding to H_C are equivalent to the closed-loop dynamics corresponding to H_0 subject to a feedback control force.

Further, it is shown in [6, 7, 8, 9, 10] that this force is constructed so that it acts only along the symmetry directions of G – e.g., [6, Equ. (2.6)].

In order for this construction to work, [6, 7, 8, 9, 10, 29] make two types of assumptions:

- (1) A set of matching assumptions.
- (2) The symmetry group G is abelian.

The matching assumptions ensure that the Hamiltonian equations of motion for H_C are equivalent (can be "matched") to the desired closed loop equations. The second assumption seems to be of technical nature. Further, [7] contains an Euler-Poincaré version of these results, where it is assumed that $P = M \times G$ is a direct product of Lie groups M and G.

Description of results. In this paper the matching approach is reversed: The starting point is not the perturbation of the set of Kaluza-Klein data, but the control force. Thus, given a G-invariant Hamiltonian H and a G-equivariant fiber-linear map $j: T^*P \to \mathfrak{g}^*$, we specify in Definition 1.5 the symmetry actuating force F. This force acts only along symmetry directions in the sense (Definition 1.2) that it is a vector field, which is vertical for the control connection Γ introduced in Section 1.B. In the satellite example the control connection corresponds to the satellite variables, so that work is only done in the rotor direction.

The equation of motion associated to the Hamiltonian vector field X_H and the feedback force F is

$$\dot{\Pi}_t = X_H(\Pi_t) + F(\Pi_t)$$

and in Theorem 1.6 it is shown that a controlled conservation law holds:

$$(J+j)(\Pi_t)$$

is constant in t where $J: T^*P \to \mathfrak{g}^*$ is the momentum map associated to the cotangent lifted action of G. This constant of motion provides the link to the closed-loop equations of motion by eliminating the G-dependence.

The crucial step in the construction of F is now prescription (2.35), which determines j by means of a G-equivariant fiber-linear map $\tilde{\jmath}: \operatorname{Hor}^* = J^{-1}(0) \to \mathfrak{g}^*$. This prescription is such that the force depends on the full Π -dynamics, and not only on the shape directions, which correspond through the choice of the connection Γ to positions and momenta of the dynamics in the shape space M. (However, actuation is still only on symmetry directions.) For the satellite example, this means that the force depends on the satellite and rotor variables, and not only on satellite observations. This approach is necessary in order to deal with non-abelian symmetry groups G or semi-direct products $M \otimes G$. Also, this approach is different from [6, 7, 8, 9, 10, 29] where the perturbation $(\mu_C^M, \mathbb{I}_C, \mathcal{A}_C)$ is constructed so that the corresponding force only depends on the shape directions. See also the discussion in Sections 7.A and 7.B. Thus, while starting from the force F is in principle equivalent to starting from the perturbed data $(\mu_C^M, \mathbb{I}_C, \mathcal{A}_C)$, the former has, in conjunction with Theorem 1.6, the advantage of clarifying the relation between $(\mu_C^M, \mathbb{I}_C, \mathcal{A}_C)$ and the closed-loop equations. Compare Remarks 5.3 and 5.4.

Theorem 3.1 provides a matching result, i.e. equivalence of closed-loop and Hamiltonian H_C dynamics, under very general assumptions. In particular, G is allowed to be non-abelian. This
matching theorem is necessary and sufficient, and provides explicit formulas for $(\mu_C^M, \mathbb{I}_C, \mathcal{A}_C)$.

But there is also a fourth condition (3.44), which is not explicit. In Theorem 4.1, this fourth condition is made concrete for the case of a semi-direct product $M \odot G$ and a right invariant Hamiltonian H_0 . This condition is

$$(4.75) A_0 u \diamond (1 + CA_0^*)^{-1} C \nu = 0$$

which depends on the semi-direct product structure. Here $A_0 : \mathfrak{m} \to \mathfrak{g}$ is the downstairs connection form corresponding to \mathcal{A}_0 defined (4.57), and the linear map $C : \mathfrak{m}^* \to \mathfrak{g}^*$, introduced in (4.62), determines the fiber-linear map $\tilde{\jmath} : \operatorname{Hor}^* \to \mathfrak{g}^*$. As a corollary, it follows that matching is always possible for direct product Lie groups $M \times G$.

Formulas (4.77) and (4.79) in Theorem 4.1 have also been found in [20]. But now these formulas follow from a general construction and not from an ad-hoc analysis of the closed-loop equations and the feedback force. In particular, Theorem 3.1 implies that this form of the controlled data is not only sufficient for matching, but also necessary. Moreover, the construction is now no longer constrained to the realm of Lie-Poisson equations, but can be applied to general Hamiltonian systems with symmetries. When these systems are sufficiently explicit, it may be hoped that concrete matching conditions along the lines of Theorem 4.1 can be found. See Sections 7.C (electromagnetic flow control) and 7.D (stochastic Hamiltonian systems) for possible future directions.

To illustrate these results, two examples are treated: ideal flow of charged particles subject to an external magnetic field ([20]) and the satellite with a rotor ([9]). These examples are not new, but can now be treated both within the same framework and without any ad-hoc assumptions. This is also in contrast to [20], where these examples were considered together, but yet with respect to different feedback forces and these forces were found through an ad-hoc analysis of the desired closed loop equations.

Thus this paper is an attempt to synthesize the symmetry control approach of [6], restricted to abelian G, and the results of [20], which are restricted to the Lie-Poisson case. Comparing the general matching conditions of [6] and Theorem 3.1, it should be mentioned that the conditions M2 and M3 in Theorem 2.2 of [6] are more explicit than (3.44) for the case of basepoint dependent metric μ_0^M and connection \mathcal{A}_0 . On the other hand, [6] assume G to be abelian and also that μ_C^M satisfies two additional conditions (in the paragraph below [6, Equ. (2.1)]), which are not necessary for Theorem 3.1. Equation (3.43) for the controlled connection \mathcal{A}_C corresponds to assumption M1 in [6].

While the method of controlled Lagrangian or Hamiltonian systems was developed with the aim of stabilizing a given (unstable) equilibrium, stability is not the subject of this paper and only touched upon very briefly in Section 4.D.

Further, we do not consider a second method of controlling mechanical systems, namely that of potential shaping ([5]).

Structure of the paper. Section 1 defines the notion of a symmetry actuating force, shows that the resulting systems belong to the class of closed-loop Hamiltonian systems in the sense of [11] and provides the controlled Noether Theorem 1.6.

Section 2 is mostly technical and contains many of the formulas, particularly in Propositions 2.2 and 2.3, which are subsequently used. Further, the form of the control map $j: T^*P \to \mathfrak{g}^*$ is found in (2.35). This section could be shortened by assuming (2.35) from the beginning, but the general form of the equations is used in the discussion in Section 7.A.

Section 3 contains the general matching result Theorem 3.1.

Section 4 applies Theorem 3.1 to the case of a semi-direct product $M \otimes G$ and a right-invariant Kaluza-Klein Hamiltonian H_0 . The main result in this section is Theorem 4.1. In Section 4.D there are some comments on the suitability of the constructed force F with regard to stabilizing a given (unstable) equilibrium.

Section 5 puts the satellite example in the context of Theorem 4.1.

Section 6 does the same for the charged fluid example.

Section 7 contains conclusions and possible future directions.

Section 8 is an appendix and collects formulas which are used mainly in Section 2. The global formula (8.114) for the canonical symplectic form on the cotangent bundle of a Riemannian manifold seems to be not very well known. (I could not find it in the literature.)

1. Symmetry actuation

1.A. The mechanical system. Let $\pi: P \to M$ be a finite dimensional principal bundle over M with structure group G and principal right action denoted by r.

Consider the phase space T^*P together with the cotangent lifted G-action and the canonical symplectic form $\Omega^{T^*P} = -d\theta^{T^*P}$, which is G-invariant. The standard G-equivariant momentum map is denoted by $J: T^*P \to \mathfrak{g}^*$. Let $H: T^*P \to \mathbb{R}$ be a G-invariant Hamiltonian. It follows that $dJ.X_H = 0$.

1.B. The control connection. There are two subbundles, namely the vertical Ver and dual horizontal Hor*, which are canonically associated to the principal fiber bundle $\pi: P \to M$. Explicitly, these are

$$\operatorname{Ver} = \ker T\pi \subset TP$$
 and $\operatorname{Hor}^* = \operatorname{Ann}(\operatorname{Ver}) \subset T^*P$

where the annihilator is defined as $\operatorname{Ann}(\operatorname{Ver}) = \{\Pi \in T^*P : \Pi(X) = 0 \ \forall X \in \operatorname{Ver}\}$. Let $\Gamma \in \Omega^1(P,\mathfrak{g})$ denote a connection form on $\pi : P \to M$. Define

(1.1)
$$\operatorname{Hor}_{\Gamma} = \ker \Gamma \quad \text{and} \quad \operatorname{Ver}_{\Gamma}^* = \operatorname{Ann}(\operatorname{Hor}_{\Gamma}).$$

The corresponding projections are

$$(1.2) \qquad (\mathrm{hpr}_{\Gamma}, \mathrm{vpr}_{\Gamma}) : TP \to \mathrm{Hor}_{\Gamma} \oplus \mathrm{Ver}, \quad (\mathrm{hpr}_{\Gamma}^*, \mathrm{vpr}_{\Gamma}^*) : T^*P \to \mathrm{Hor}^* \oplus \mathrm{Ver}_{\Gamma}^*,$$

and these are connection dependent isomorphisms. We refer to Γ as the control connection.

- Remark 1.1. The purpose of Γ is to single out the directions along which the control force F acts, respectively does not act. See Definition 1.2. For instance, in the satellite example, the force acts on the rotor, but not on the satellite itself. This distinction cannot be made by the mechanical connection, but necessitates another splitting of the phase space T^*P . The control connection Γ is not to be confused with the controlled connection \mathcal{A}_C introduced below.
- 1.C. **Symmetry actuation and conserved quantities.** The isomorphism (1.2) lifts to the tangent bundle

(1.3)
$$T(\operatorname{hpr}_{\Gamma}^*, \operatorname{vpr}_{\Gamma}^*) : TT^*P \to T\operatorname{Hor}^* \oplus T\operatorname{Ver}_{\Gamma}^*.$$

Let $\tau_{TT^*P}: TT^*P \to T^*P$ be the tangent projection and note that there is an isomorphism

$$(\tau_{TT^*P}, T\mathrm{vpr}_{\Gamma}^*)|\ker T\mathrm{hpr}_{\Gamma}^* : \ker T\mathrm{hpr}_{\Gamma}^* \to T^*P \times_{\mathrm{Ver}_{\Gamma}^*} T\mathrm{Ver}_{\Gamma}^*$$

of fiber bundles over T^*P . For $\Pi \in T^*P$ we will write this isomorphism simply as $T_{\Pi} \operatorname{vpr}_{\Gamma}^*$: $\ker T_{\Pi} \operatorname{hpr}_{\Gamma}^* \to T_{\operatorname{vpr}_{\Gamma}^*(\Pi)} \operatorname{Ver}_{\Gamma}^*$.

Definition 1.2 (Symmetry actuating force). We say that a vector field $F \in \mathcal{X}(T^*P)$ is a symmetry actuating force, if it satisfies the following three conditions:

- (1) It is vertical with respect to the base point projection $\tau: T^*P \to P$, that is: $T\tau F = 0$.
- (2) It does not act along Γ -horizontal directions, that is: $Thpr_{\Gamma}^* F = 0$.
- (3) It is G-invariant with respect to the cotangent lifted r-action on T^*P .

Proposition 1.3. Let Γ be a control connection.

(1) There is a one-to-one correspondence between symmetry actuating forces $F \in \mathcal{X}(T^*P)$ and G-equivariant functions $f \in \mathcal{F}_G(T^*P, \mathfrak{g}^*)$:
Given F:

$$(1.4) f = f_F := dJ.F$$

Given f:

(1.5)
$$F(\Pi) = F_f(\Pi) := \left(T_{\Pi} \operatorname{vpr}_{\Gamma}^* | \ker T_{\Pi} \operatorname{hpr}_{\Gamma}^* \right)^{-1} \left(T_{\operatorname{vpr}_{\Gamma}^*(\Pi)}(\tau, J) | \operatorname{Ver}_{\Gamma}^* \right)^{-1} \left(0_{\omega}; J(\Pi), f(\Pi) \right)$$

$$where \ \omega = \tau(\Pi) \ and \ 0_{\omega} \ is \ the \ 0\text{-section at } \omega \ in \ TP.$$

(2) Let $f \in \mathcal{F}_G(T^*P, \mathfrak{g}^*)$ and define $\mathcal{U}(\Pi) := ((\tau, J)|\operatorname{Ver}_{\Gamma}^*)^{-1}(\tau(\Pi), f(\Pi)) \in \operatorname{Ver}_{\Gamma}^*$. If $F = F_f$, then

(1.6)
$$F(\Pi) = vl^*(\Pi, \mathcal{U}(\Pi)) = \frac{\partial}{\partial t}|_0(\Pi + t\mathcal{U}(\Pi))$$

where $vl^*: T^*P \oplus T^*P \to \ker T\tau \subset TT^*P$ is the vertical lift map.

(3) Let $F \in \mathcal{X}(T^*P)$ be a symmetry actuating force and consider

(1.7)
$$\dot{\Pi}_t = X_H(\Pi_t) + F(\Pi_t).$$

Then

(1.8)
$$\frac{\partial}{\partial t}J(\Pi_t) = f(\Pi_t)$$

where f = dJ.F.

Proof. Assertion (1). Let F be G-actuating. Then $f = f_F = dJ.F \in \mathcal{F}_G(T^*P, \mathfrak{g}^*)$ because F is assumed to be G-invariant.

Since $J^{-1}(0) = \operatorname{Hor}^*$, it follows that $(\tau, J)|\operatorname{Ver}_{\Gamma}^* : \operatorname{Ver}_{\Gamma}^* \to P \times \mathfrak{g}^*$ is an isomorphism. Now, $F \in \ker T \operatorname{hpr}_{\Gamma}^* \cap \ker T \tau$ implies

$$T_{\Pi} \operatorname{vpr}_{\Gamma}^* F(\Pi) = \left(T_{\operatorname{vpr}_{\Gamma}^*\Pi}(\tau, J) | \operatorname{Ver}_{\Gamma}^* \right)^{-1} \left(0_{\omega}; J(\Pi), dJ. F(\Pi) \right)$$

where $0_{\omega} \in TP$ is the 0-section at $\omega = \tau(\Pi)$. Therefore, given $f \in \mathcal{F}_G(T^*P, \mathfrak{g}^*)$ we may define $F = F_f$ according to (1.5).

Assertion (2). Let $\Pi \in T^*P$ and $\omega = \tau(\Pi)$. Then

$$T_{\Pi} \operatorname{vpr}_{\Gamma}^{*}.F(\Pi) = \left(T(\tau, J) | \operatorname{Ver}_{\Gamma}^{*}\right)^{-1} (0_{\omega}; J(\Pi), f(\Pi))$$

$$= \frac{\partial}{\partial t} |_{0} \left((\tau, J) | \operatorname{Ver}_{\Gamma}^{*}\right)^{-1} (\omega, J(\Pi) + t f(\Pi))$$

$$= \frac{\partial}{\partial t} |_{0} \left(\left((\tau, J) | \operatorname{Ver}_{\Gamma}^{*}\right)^{-1} (\omega, J(\Pi)) + t \left((\tau, J) | \operatorname{Ver}_{\Gamma}^{*}\right)^{-1} (\omega, f(\Pi))\right)$$

$$= \operatorname{vl}^{*}(\operatorname{vpr}_{\Gamma}^{*}(\Pi), \mathcal{U}(\Pi))$$

where we use hat J is linear in the fiber. Since $\mathrm{vl}^*(\Pi,\mathcal{U}(\Pi)) \in \ker T_\Pi \mathrm{hpr}_\Gamma^*$, the claim follows. Assertion (3) follows from $dJ.X_H = 0$.

Remark 1.4. Equation (1.6) means that (1.7) is a closed-loop Hamiltonian system in the sense of [11] with control subbundle $\operatorname{Ver}_{\Gamma}^* \subset T^*P$ and control $\mathcal{U}: T^*P \to \operatorname{Ver}_{\Gamma}^*$. (See the paragraph below Definition 3.1 in loc. cit.)

Definition 1.5 (Symmetry actuated closed-loop Hamiltonian system). Let $\pi: P \to M$, G, Γ and H as above. A symmetry actuated closed-loop Hamiltonian system on T^*P is defined by the equation of motion

$$\dot{\Pi}_t = X_H(\Pi_t) + F(\Pi_t).$$

where $F = F_f$ is a symmetry actuating force determined by (1.5), and where

$$f(\Pi) = -B_{\omega}.dj.X_H(\Pi)$$

with $\omega = \pi(\Pi)$ and:

- (1) $B: P \times \mathfrak{g}^* \to \mathfrak{g}^*, \ (\omega, p) \mapsto B_{\omega}p$ is G-equivariant and B_{ω} is an isomorphism for all $\omega \in P$. That is, $\operatorname{Ad}(g)^*B_{\omega} = B_{\omega g} \circ \operatorname{Ad}(g)^*$.
- (2) j is a G-equivariant map of the form

$$j = B^{-1} \circ (\tau, \tilde{\jmath}) \circ \operatorname{hpr}_{\Gamma}^* + (B^{-1} - \operatorname{pr}_2) \circ (\tau, J) : T^*P \to \mathfrak{g}^*$$

for a fiber-wise linear and G-equivariant map $\tilde{\jmath}: \operatorname{Hor}^* \to \mathfrak{g}^*$, and where B^{-1} is the fiber-wise inverse of B. That is, $j(\Pi) = B_{\omega}^{-1}.\tilde{\jmath}(\operatorname{hpr}_{\Gamma}^*(\Pi)) + (B_{\omega}^{-1} - 1).J(\Pi)$ where $\omega = \tau(\Pi)$.

Theorem 1.6 (Conservation law). If Π_t is a solution of (1.9), then $(J+j)(\Pi_t)$ is constant in t.

Proof. Equation (1.10) and Proposition 1.3 combine to yield

$$(1.11) dJ.F = -B.dj.X_H.$$

Further,

$$\begin{aligned} dj.F(\Pi) &= d(B^{-1}).\underbrace{(\underline{T\tau.F(\Pi)},\underline{T(\tilde{\jmath}.\mathrm{hpr}_{\Gamma}^*).F(\Pi)})}_{0_{\omega}} + d(B^{-1}-1).\underbrace{(\underline{T\tau.F(\Pi)},TJ.F(\Pi))}_{0_{\omega}} + d(B^{-1}-1).dJ.F(\Pi) \end{aligned}$$

$$= (B^{-1}-1).dJ.F(\Pi) = -(B^{-1}-1)B.dj.X_H(\Pi)$$

where $0_{\omega} \in T_{\omega}P$ is the zero-section at $\omega = \tau(\Pi)$ and we use fiber-wise linearity of B. Due to $dJ.X_H = 0$, by G-invariance of H, we obtain

$$(1.12) (dJ+dj).(X_H+F) = dj.X_H - B.dj.X_H - (B^{-1}-1)B.dj.X_H = 0.$$

Remark 1.7. Equation (1.8) means that the force acts along internal symmetry directions. At the same time, the condition $Thpr_{\Gamma}^*.F = 0$ ensures that the force does not act in Hor*-directions, corresponding to the shape space M. Compare with [10, Equ. (1.10)] or [6, Equ. (2.6)].

2. The bundle picture of symmetry actuated closed-loop Hamiltonian systems

Let $\pi: P \to M$, G, Γ and j as above. Let μ_0^M be a metric on M and \mathbb{I}_0 a G-invariant locked inertia tensor on $P \times \mathfrak{g}$.

Fix a connection form $A_0 \in \Omega^1(P, \mathfrak{g})$. The horizontal, vertical and respective dual spaces associated to A_0 are denoted by

(2.13)
$$\operatorname{Hor}_{0} = \ker \mathcal{A}_{0}, \operatorname{Ver} = \ker T\pi, \operatorname{Hor}^{*} = \operatorname{Ann}(\operatorname{Ver}), \operatorname{Ver}_{0}^{*} = \operatorname{Ann}(\operatorname{Hor}_{0}),$$

where only Hor_0 and Ver_0^* depend on the choice of connection. The corresponding projections are

$$(2.14) \qquad (\mathrm{hpr}_0, \mathrm{vpr}_0) : TP \to \mathrm{Hor}_0 \oplus \mathrm{Ver}, \quad (\mathrm{hpr}_0^*, \mathrm{vpr}_0^*) : T^*P \to \mathrm{Hor}^* \oplus \mathrm{Ver}_0^*,$$

and these depend on the chosen connection \mathcal{A}_0 .

The associated Kaluza-Klein metric on P is denoted by

$$\mu_0^P = \mu^{KK}(\mu_0^M, \mathbb{I}_0, \mathcal{A}_0)$$

with associated kinetic energy Hamiltonian

$$H_0: T^*P \to \mathbb{R}, \Pi \mapsto \frac{1}{2}\langle \Pi, (\mu_0^P)^{-1}\Pi \rangle + V \circ \tau$$

where $V \circ \tau : T^*P \to \mathbb{R}$ is a G-invariant potential. The force associated to H_0 via (1.10) is called $F_0 = F_f$ and we consider, analogously to (1.9), the forced equation

Let

$$\mathcal{W} := P \times_M T^*M \oplus P \times \mathfrak{g}^*$$

and consider the (A_0, j) -dependent isomorphism

$$(2.17) \Psi_j: \mathcal{W} \to T^*P, \quad (\omega, \nu; \omega, q) \mapsto \left((\mathrm{hl}^{\mathcal{A}_0})^* \right)^{-1} (\omega, \nu) + \left((\tau, J+j) | \mathrm{Ver}_0^* \right)^{-1} (\omega, q)$$

where $\text{hl}^{\mathcal{A}_0}: P \times_M TM \to \text{Hor}$ is the \mathcal{A}_0 -horizontal lift, $\omega \in P$ and $\nu \in T^*M$ with $\pi(\omega) = \tau(\nu)$. Here, and in the following, it is assumed that j is chosen such that Ψ_j is indeed an isomorphism. For j = 0, Ψ_j coincides with the \mathcal{A}_0 -dependent isomorphism Ψ_0 defined in (8.110).

From now on we will identify $W = P \times_M T^*M \oplus P \times \mathfrak{g}^* = P \times_M T^*M \times \mathfrak{g}^*$ and write elements $W \in \mathcal{W}$ as $W = (\omega, \nu, q)$ where $\omega \in P$, $\nu \in T^*M$, $q \in \mathfrak{g}^*$ and it is understood that $\pi(\omega) = \tau(\nu)$. Correspondingly, we introduce the projection maps

$$(\operatorname{pr}_1,\operatorname{pr}_2,\operatorname{pr}_3):\mathcal{W}\to P\times T^*M\times \mathfrak{g}^*,\quad W\mapsto (\omega,\nu,q).$$

Further, we will abbreviate $(pr_1, pr_2) = pr_{1,2}$ and $(pr_1, pr_3) = pr_{1,3}$.

The isomorphism Ψ_j can be decomposed as $\Psi_0(\omega, \nu, q) = \Psi_0^{\text{hor}}(\omega, \nu) + \Psi_j^{\text{ver}}(\omega, q)$, where

with $\operatorname{Ver}_0^*(\omega) = T_\omega^* P \cap \operatorname{Ver}_0^*$ and $\operatorname{Hor}^*(\omega) = T_\omega^* P \cap \operatorname{Hor}^*$.

The isomorphism Ψ_0 induces a G-action on \mathcal{W} . This action leaves the induced symplectic form $\Psi_0^*\Omega^{T^*P}$ invariant and has a momentum map

$$J_{\mathcal{W}} := \operatorname{pr}_3 = \Psi_0^* J : (\omega, \nu, q) \mapsto q.$$

The isomorphism Ψ_j induces a G-action on \mathcal{W} . This action leaves the induced symplectic form $\Psi_i^*\Omega^{T^*P}$ invariant and has a momentum map

$$\begin{split} \Psi_{j}^{*}J &= (\Psi_{0}^{\text{hor}} \circ \text{pr}_{1,2} + \Psi_{j}^{\text{ver}} \circ \text{pr}_{1,3})^{*}J = (\Psi_{j}^{\text{ver}} \circ \text{pr}_{1,3})^{*}J \\ &= J_{\mathcal{W}} - j \circ (\tau, J + j)|_{\text{Ver}_{0}^{*}}^{-1} \circ \text{pr}_{1,3} = J_{\mathcal{W}} - (\Psi_{j}^{\text{ver}} \circ \text{pr}_{1,3})^{*}j \end{split}$$
(2.20)

Since Ψ_j is assumed to be an isomorphism, the ω -dependent map $(J \circ \Psi_j^{\text{ver}})_{\omega} : \mathfrak{g}^* \to \mathfrak{g}^*$ is an isomorphism as-well. Therefore, (2.20) implies that the same is true for $(1 - j \circ \Psi_j^{\text{ver}})_{\omega}$, for each $\omega \in P$. Further, the map $1 - j \circ \Psi_j^{\text{ver}} : P \times \mathfrak{g}^* \to \mathfrak{g}^*$ is G-equivariant.

The actions induced by Ψ_0 and Ψ_j coincide, since j is equivariant. Therefore, we will simply speak of the G-action on W. It is given by

$$(\omega, \nu, q).g = (\omega.g, \nu, \operatorname{Ad}(g)^*.q)$$

for $g \in G$.

Remark 2.1. The momentum maps $J_{\mathcal{W}}$ and Ψ_j^*J , associated respectively to $\Psi_0^*\Omega^{T^*P}$ and $\Psi_j^*\Omega^{T^*P}$, do not necessarily coincide for $j \neq 0$. However, with assumption (2.35) below it follows, that $\Psi_0 = \Psi_j$.

The infinitesimal generator associated to an element $Y \in \mathfrak{g}$ shall be denoted by $\zeta_Y^{\mathcal{W}}$ where $\zeta^{\mathcal{W}} : \mathfrak{g} \to \mathcal{X}(\mathcal{W})$ is the fundamental vector field mapping.

Consider the mapping (id, D^0): $P \times \mathfrak{g}^* \to P \times_M T^*M$, $(\omega, p) \mapsto (\omega, D^0_{\omega}.p)$, where $D^0_{\omega}: \mathfrak{g}^* \to T^*M$ is defined as

Let $\mathrm{hl}_{\mu_0^M}^*: T^*M \oplus TM \to \mathrm{Hor}(\mu_0^M) \subset TT^*M$ denote the Riemannian horizontal lift and $\mathrm{vl}^*: T^*M \oplus T^*M \to \mathrm{Ver}(\tau_{T^*M}) = \ker T\tau_{T^*M} \subset TT^*M$ the vertical lift. Then

The operators d^{hor} and L are defined below in (2.30) and (2.31).

Let $W = (\omega, \nu, p) \in \mathcal{W}$ and $X = (X_1, X_2, X_3) \in T_{\omega}P \times T_{\nu}T^*M \times \mathfrak{g}^*$ with $T\pi.X_1 = T\tau.X_2 = u$. Further, let $X_1 = \mathrm{hl}_{\omega}^{\mathcal{A}_0}(u) + \zeta_Y(\omega)$. Using (2.20),

where θ^{T^*M} is the canonical one-form on T^*M with $\Omega^{T^*M} = -d\theta^{T^*M}$. Since $\Omega^j := \Psi_j^* \Omega^{T^*P} = -d\Psi_j^* \theta^{T^*P}$, and using the Maurer-Cartan formula

This formula will be used throughout the rest of the proof without further reference.

Equation (2.20) implies that

$$Z := \left(0, \operatorname{vl}_{\nu}^*(\eta_2), 0\right) \in T_W \mathcal{W}.$$

Then, using the μ_0^M -connector $K_0^*: TT^*M \to T^*M$ together with (8.114),

$$= \langle \dot{p}_{2} - dj.T\Psi_{j}^{\text{ver}}.(0, \dot{p}_{2}), Y \rangle = \langle (1 - j\Psi_{j}^{\text{ver}})_{\omega}.\dot{p}_{2}, Y \rangle = \langle \dot{p}_{2}, (1 - j\Psi_{j}^{\text{ver}})_{\omega}^{*}.Y \rangle$$

where the penultimate equality follows because j is fiberwise linear, and we have indicated the ω -dependence. Therefore,

- \langle p - j(\Psi_{j}^{\operatorname{ver}}(\omega, p)), \operatorname{Curv}^{\mathcal{A}_{0}}(u, u_{2}) \rangle
= -\langle \eta, u_{2} \rangle - \langle dj.T\psi_{j}^{\operatorname{ver}}.(\operatorname{hl}^{\mathcal{A}_{0}}(\omega, u_{2}), 0), \tilde{\mathbb{I}}^{-1}p \rangle
- \langle (1 - j \circ \Psi_{j}^{\operatorname{ver}}(\omega)).p, \operatorname{Curv}^{\mathcal{A}_{0}}(u, u_{2}) \rangle$$

Define $L(W) \in T_x^*M$ through

$$= -dj.(X_{H_{0}} \circ \Psi_{j}) - d(j \circ \text{hpr}_{0}^{*})(F \circ \Psi_{j})$$

$$= -dj.T\Psi_{j}.X^{j} - \frac{\partial}{\partial t}|_{0}(j \circ \text{hpr}_{0}^{*})(\Psi_{j} + t\mathcal{U} \circ \Psi_{j})$$

$$= -dj.T\Psi_{j}.X^{j} - (j \circ \text{hpr}_{0}^{*} \circ J|_{\text{Ver}_{\Gamma}^{*}(\omega)}^{-1})(f \circ \Psi_{j})$$

$$= -\left(1 + j \circ \text{hpr}_{\Gamma}^{*} \circ \Psi_{0}^{\text{ver}} \circ B_{\omega}\right)dj.T\Psi_{j}.X^{j}$$

where we use again that $\operatorname{hpr}_{\Gamma}^* \circ \Psi_0^{\operatorname{ver}} = -\operatorname{hpr}_0^* \circ \operatorname{vpr}_{\Gamma}^* \circ \Psi_0^{\operatorname{ver}} = -\operatorname{hpr}_0^* \circ (J|\operatorname{Ver}_{\Gamma}^*)^{-1}$.

In order to make use of the conservation law (1.12), we define the map

It follows that

 $\Psi_j = \Psi_0 \text{ and } j \circ \Psi_0^{\text{ver}} = 0, \text{ and }$

$$(2.37) Tpr_{2}.\left(X^{jj} + F^{jj}\right) = X_{2}^{j} \circ \Phi_{j} + vl_{\nu}^{*}\left(D_{\omega}^{0}.B_{\omega}.dj.T\Psi_{0}^{hor}.(X_{1}^{j} \circ \Phi^{j}, X_{2}^{j} \circ \Phi^{j})\right).$$

Proof. Equation 2.33 is immediate from Proposition 2.2.

Equation (2.34): Equation (2.20) yields

Remark 2.4. Equation (2.36) is the reason for introducing B in Definition 1.5. Due to (2.35) B is determined by $\tilde{\jmath}: \operatorname{Hor}^* \to \mathfrak{g}^*$.

3. Matching

Let the notation be as in Section 2. Consider equation (2.15) and assume B is given by (2.35). Because of (2.36) this implies that $\Psi_i = \Psi_0$.

In the following, we are looking for a G-equivariant bundle isomorphism $\Phi: T^*P \to T^*P$, which maps (2.15) to a Hamiltonian system (at least, when restricted to the pre-image of $J^{-1}(0)$ under this isomorphism). The target Hamiltonian system should be of Kaluza-Klein form with respect to controlled data $(\mu_C^M, \mathbb{I}_C, \mathcal{A}_C)$, which are to be specified, and the unchanged potential V. Equivalently, the goal is to explicitly find a G-equivariant isomorphism Φ_C

$$(3.38) T^*P \stackrel{\Psi_0}{\longleftarrow} W \stackrel{\Phi_f}{\longleftarrow} W \stackrel{\Phi_C}{\longleftarrow} W \stackrel{\Psi_C}{\longrightarrow} T^*P$$

and a force F_C such that (3.39), (3.40) and (3.54) hold, and where Ψ_C is the connection dependent isomorphism associated to the controlled connection \mathcal{A}_C .

3.A. Matching conditions. As above, H_0 denotes the Kaluza-Klein Hamiltonian associated to $(\mu_0^M, \mathbb{I}_0, \mathcal{A}_0)$ and the potential V.

Assume H_C is a Kaluza-Klein Hamiltonian associated to $(\mu_C^M, \mathbb{I}_C, \mathcal{A}_C)$ and the potential V. Let $\Psi_C: \mathcal{W} \to T^*P$ be the isomorphism corresponding to \mathcal{A}_C . Let $\Phi_C = (\varphi_C, S)$, where $\varphi_C: P \times_M T^*M \to P \times_M T^*M$ and $S: \mathfrak{g}^* \to \mathfrak{g}^*$ are G-equivariant isomorphisms, and φ_C is fiber-preserving. Let $F_C \in \mathcal{X}(T^*P)$ with

and define $F^C := \Psi_C^* F_C$.

Theorem 3.1. Let F_0 be as in equation (2.15). The following are equivalent:

(2) The matching conditions

(3.41)
$$\mu_C^M := \varphi_C \cdot \mu_0^M : TM \to T^*M$$

(3.43)
$$\mathcal{A}_C := \mathcal{A}_0 + \mathbb{I}_0^{-1} \cdot B^{-1} \cdot \tilde{\jmath} \cdot \mu_0^P \cdot \operatorname{hpr}_0$$

$$(3.44) (X_2^C + F_2^C) \circ \Phi_C = T(\operatorname{pr}_2 \circ \varphi_C) \cdot ((X_1^j, X_2^j + F_2^j) \circ \Phi_j)$$

hold.

Proof. Using Proposition 2.3, it follows that item (1) is equivalent to $T\Phi_C(X^{jj} + F^{jj}) =$ $(T\varphi_C.(X_1^{jj},X_2^{jj}+F_2^{jj}),TS.0)=(X^C+F^C)\circ\Phi_C=(X_1^C,X_2^C+F_2^C,0)\circ\Phi_C$, which is hence equivalent to $(X_1^C, X_2^C + F_2^C) \circ \Phi_C = T\varphi_C \cdot ((X_1^j, X_2^j + F_2^j) \circ \Phi_i)$. where $(\omega, \mu, Sq) = \Phi_C(\omega, \nu, q)$ and $(\omega, \nu, p) = \Phi_j(\omega, \nu, q) = (\omega, \nu, q - j\Psi_0^{\text{hor}}(\omega, \nu))$. Equation (3.46) necessitates $(\mu_0^M)^{-1}\nu = (\mu_C^M)^{-1}\mu = ((\mu_C^M)^{-1}\varphi_C)\nu$, since the fundamental vector fields are annihilated by the projection $T\pi: TP \to TM$, whence (3.41) follows. Further, setting $\nu = 0$, equality holds in (3.46) if, and only if, (3.42) holds. Setting q = 0 and applying \mathcal{A}_C to both sides of (3.46), equality holds if, and only if, (3.43) holds.

Remark 3.2. Assume that M is parallelizable such that $TM = M \times \mathfrak{m}$ and that

Let $S: \mathfrak{g}^* \to \mathfrak{g}^*$ be an $\mathrm{Ad}(g)^*$ -equivariant isomorphism and consider

Set $\Phi_C = (\varphi_C, S)$. Let μ_C^M , \mathbb{I}_C and \mathcal{A}_C be defined by (3.41), (3.42) and (3.43). For $(\omega, \mu, \tilde{q}) = \Phi_C(\omega, \nu, q)$ and $u = (\mu_0^M)^{-1}(\nu)$, assume the matching conditions

$$\left(\operatorname{hl}_{\mu_0^M}^*\right)_{\nu}\left(u\right) + \operatorname{vl}_{\nu}^*\left\langle j.\Psi_0^{\operatorname{hor}}(\omega,\nu), i(u)\operatorname{Curv}^{\mathcal{A}_0}\right\rangle = \left(\operatorname{hl}_{\mu_C^M}^*\right)_{\mu}\left(u\right)$$

and

(3.50)
$$d^{\text{hor}}H^{j}(\omega,\nu,q-j.\Psi_{0}^{\text{hor}}(\omega,\nu)) = d^{\text{hor}}H^{C}(\omega,\mu,\tilde{q})$$

hold, where $H^C = \Psi_C^* H_C$. The corresponding force is then given by

$$(3.51) F_2^C(\omega, \mu, \tilde{q}) := \mathrm{vl}_{\mu}^* \Big(\langle \tilde{q}, i(\tilde{u}) \mathrm{Curv}^{\mathcal{A}_C} - (S^{-1})^* i(\tilde{u}) \mathrm{Curv}^{\mathcal{A}_0} \rangle \Big)$$

where $(\omega, \mu, \tilde{q}) \in \mathcal{W}$ and $\tilde{u} = (\mu_C^M)^{-1}(\mu)$ and H_C is the Kaluza-Klein Hamiltonian associated to $(\mu_C^M, \mathbb{I}_C, \mathcal{A}_C)$ and the (unchanged) potential function V. It follows that H_C , $F_C := (\Psi_C^{-1})^*(0, F_2^C, 0)$ and $\Phi := \Psi_C \circ (\varphi_C, S) \circ \Phi_j^{-1} \circ \Psi_0^{-1}$ satisfy

$$= T \left(D^{0} \circ (\operatorname{id}, B) \right). \left(0, T(j \circ \Psi_{0}^{\text{hor}}).(X_{1}^{j}, X_{2}^{j}) \right) (\omega, \nu, p)$$

$$= T \left(D^{0} \circ (\operatorname{id}, B) \right). \left(X_{1}^{j}, T(j \circ \Psi_{0}^{\text{hor}}).(X_{1}^{j}, X_{2}^{j}) \right) (\omega, \nu, p)$$

$$= T \left(D^{0} \circ (\operatorname{id}, B) \circ (\operatorname{pr}_{1}, j \circ \Psi_{0}^{\text{hor}}) \right). \left(X_{1}^{j}, X_{2}^{j} \right) (\omega, \nu, p)$$

$$= T \left(D^{0} \circ (\operatorname{pr}_{1}, \tilde{\jmath} \circ \Psi_{0}^{\text{hor}}) \right). \left(X_{1}^{j}, X_{2}^{j} \right) (\omega, \nu, p)$$

Therefore, $T\varphi_C.((X_1^j,X_2^j+F_2^j)\circ\Phi_j)=T\varphi_C.T\varphi_C^{-1}.((X_1^j,X_2^j)\circ\Phi_j)=(X_1^j,X_2^j)\circ\Phi_j$ and we obtain the conditions (3.46) (which is equivalent to (3.41), (3.42) and (3.43)) and (3.49), (3.50). If S can be chosen so that $F^C=0$, then (2.15) is equivalent to the Hamiltonian system X_{H_C} .

The condition (3.47) is rather strong and not satisfied for the case of Section 4. Nevertheless, formula (3.48) coincides with (4.73).

Remark 3.3. The expression (3.43) should be compared with Assumption M1 in [6].

Remark 3.4. The property $F_C|J^{-1}(0) = 0$ is relevant, because it means that the restriction to $J^{-1}(0)$ allows to reduce the controlled equations to a Hamiltonian system.

4. Feedback control of mechanical systems on semi-direct products

4.A. **Setup.** Assume that M and G are Lie groups and that there is a right representation $\rho: M \to \operatorname{Aut}(G)$. That is $\rho^{\psi\phi} = \rho^{\phi} \circ \rho^{\psi}$ for $\phi, \psi \in M$. Let

$$P = M(\widehat{S})G$$

denote the semi-direct product. The right multiplication in P is given by

The action by G on $M \odot G = P$ given by right multiplication (on the second factor) makes

into a (right) principal bundle. The induced representation of M on \mathfrak{g} is again denoted by $\rho: M \to \operatorname{Aut}(\mathfrak{g})$. The contragredient representation is

$$\rho_*^{\phi} = (\rho^{\phi^{-1}})^*,$$

and similarly we have $\rho^u X = \frac{\partial}{\partial t}|_0 \rho^{\exp(tu)} X$ and $\rho^u_* p = \frac{\partial}{\partial t}|_0 \rho^{\exp(tu)}_* p = -(\rho^u)^* p$.

Let μ_0^M be a right invariant metric on M. In the right trivialization this is given by an isomorphism $\mu_0^M: \mathfrak{m} \to \mathfrak{m}^*$, where \mathfrak{m} is the Lie algebra of M and \mathfrak{m}^* its dual. Let $\mathbb{I}_0: \mathfrak{g} \to \mathfrak{g}^*$ a symmetric isomorphism such that

$$(4.56) \operatorname{Ad}(g)^* \mathbb{I}_0 \operatorname{Ad}(g) = \mathbb{I}_0 = \rho_*^{\phi^{-1}} \mathbb{I}_0 \rho^{\phi}$$

for all $(\phi, g) \in P$. Let $\mathcal{A}_0 : TP \to \mathfrak{g}$ be a principal bundle connection. In the right trivialization this is given by

$$(4.57) \mathcal{A}_0: M \times G \times \mathfrak{m} \times \mathfrak{g} \to \mathfrak{g}, \quad (\phi, g, u, X) \mapsto \operatorname{Ad}(g^{-1})\rho^{\phi}(X + A_0(u))$$

where $A_0: \mathfrak{m} \to \mathfrak{g}$ is independent of (ϕ, g) . The corresponding horizontal bundle is

(4.58)
$$\operatorname{Hor}_{0} = P \times \{(u, -A_{0}(u)) : u \in \mathfrak{m}\}.$$

Let

$$\mu_0^P = \mu^{KK}(\mu_0^M, \mathbb{I}_0, \mathcal{A}_0) = \begin{pmatrix} \mu_0^M + A_0^* \mathbb{I}_0 A_0 & A_0^* \mathbb{I}_0 \\ \mathbb{I}_0 A_0 & \mathbb{I}_0 \end{pmatrix} : \mathfrak{m} \times \mathfrak{g} \to \mathfrak{m}^* \times \mathfrak{g}^*$$

be the (right invariant) Kaluza-Klein metric on P corresponding to $(\mu_0^M, \mathbb{I}_0, \mathcal{A}_0)$. This metric has the properties

$$\mu_0^P|\mathrm{Hor}_0 = \mu_0^M \circ (T\pi, T\pi), \quad \mu_0^P|\mathrm{Ver} = \mathbb{I} \circ (\mathcal{A}, \mathcal{A}), \quad \mu_0^P(\mathrm{Hor}_0, \mathrm{Ver}) = 0.$$

The Hamiltonian $H_0: P \times \mathfrak{p}^* \to \mathbb{R}$ is

$$(4.59) H_0(\omega, \Pi) = \frac{1}{2} \langle \Pi, (\mu_0^P)^{-1} \Pi \rangle.$$

The momentum map with respect to the cotangent lifted G-action on T^*P is denoted by $J: P \times \mathfrak{p}^* \to \mathfrak{g}^*$. It is given by

(4.60)
$$J(\omega, \Pi) = \operatorname{Ad}(g)^* \rho_*^{\phi}(q)$$

where $\omega = (\phi, g)$ and $\Pi = (\nu, q)$. The connection dependent isomorphism $\Psi_0 = \Psi_0^{\text{hor}} \oplus \Psi_0^{\text{ver}}$: $\mathcal{W} = P \times_M T^*M \oplus P \times \mathfrak{g}^* \to T^*P$ is, in the right trivialization, given by

$$\Psi_0^{\mathrm{hor}}: M \times G \times \mathfrak{m}^* \to P \times \mathfrak{p}^*, \quad (\phi, g, \nu) \mapsto (\phi, g, \nu, 0)$$

and

$$\Psi_0^{\text{ver}}: M \times G \times \mathfrak{g}^* \to P \times \mathfrak{p}^*, \quad (\phi, q, p) \mapsto (\phi, q, A_0^* \rho_*^{\phi^{-1}} \operatorname{Ad}(q^{-1})^* p, \rho_*^{\phi^{-1}} \operatorname{Ad}(q^{-1})^* p).$$

4.B. Control connection and symmetry actuation. The control connection Γ on the G-bundle $P \to M$ is the direct product connection given by

$$(4.61) \mathcal{A}_{\Gamma}: M \times G \times \mathfrak{m} \times \mathfrak{g} \to \mathfrak{g}, \quad (\phi, g, u, X) \mapsto \operatorname{Ad}(g^{-1})\rho^{\phi}X.$$

Thus $\operatorname{Hor}_{\Gamma} = P \times \mathfrak{m} \times \{0\}.$

Let $\tilde{\jmath}: \operatorname{Hor}^* = P \times \mathfrak{m}^* \to \mathfrak{g}^*$ be a P-equivariant and fiber-linear map. That is,

$$\tilde{\jmath}(\phi, g, \nu) = \operatorname{Ad}(g)^* \rho_*^{\phi} C \nu$$

for a linear map

$$(4.62) C: \mathfrak{m}^* \to \mathfrak{g}^*.$$

Since $hpr_{\Gamma}^* = pr_1$, definition (2.35) becomes

The map $j: P \times \mathfrak{p}^* \to \mathfrak{g}^*$ in Definition 1.5 is now

Further, the map $D^0_\omega:\mathfrak{g}^*\to\mathfrak{m}^*,$ defined in (2.21), is given by

$$D_{\omega}^{0} = \left(\operatorname{pr}_{2} \cdot (\operatorname{hl}^{\mathcal{A}_{0}}) \cdot \operatorname{hpr}_{\Gamma}^{*} \cdot \Psi_{0}^{\operatorname{ver}} \right)_{\omega} = A_{0}^{*} \rho_{*}^{\phi^{-1}} \operatorname{Ad}(g^{-1})^{*}$$

where $\omega = (\phi, g)$.

4.C. **Matching.** The strategy is to use item (2) of Theorem 3.1 to find the isomorphism $\Phi_C = (\varphi_C, S)$ and the force F_C . More precisely, $(\mu_C^M, \mathbb{I}_C, \mathcal{A}_C)$ are given by (3.41), (3.42), (3.43), and (φ_C, S) and F_2^C shall be determined from (3.44) such that (3.39) and (3.40) hold. Since the controlled system should again be right invariant, Φ_C should be P-equivariant (not only G-equivariant). It follows that $\varphi_C = (\operatorname{id}_P, \varphi_C) : P \times_M T^*M \to P \times_M T^*M = M \times G \times \mathfrak{m}^*$ for a P-independent map $\varphi_C : \mathfrak{m}^* \to \mathfrak{m}^*$ (again denoted by the same symbol).

The right-trivialization further implies that X^j of Proposition 2.2 can be expressed as $X^j = (X_1^j, X_2^j, X_3^j) \in \mathfrak{p} \times \mathfrak{m}^* \times \mathfrak{g}^*$.

Because the operator $\mu_0^M: \mathfrak{m} \to \mathfrak{m}^*$ corresponds to a right invariant metric on M, the Riemannian horizontal lift $\mathrm{hl}_{\mu_0^M}: TM \oplus TM \to TTM$ can be expressed as (e.g., [28])

$$\operatorname{hl}_{\mu_0^M} : \mathfrak{m} \times \mathfrak{m} \to \mathfrak{m}, \quad (u, w) \mapsto -\frac{1}{2} \left(\operatorname{ad}(u)^\top w + \operatorname{ad}(w)^\top u - \operatorname{ad}(w) u \right)$$

with dual

$$(4.67) \quad \mathrm{hl}_{\mu_0^M}^* : \mathfrak{m}^* \times \mathfrak{m} \to \mathfrak{m}^*, \quad (\nu, w) \mapsto -\frac{1}{2} \Big(\mathrm{ad}((\mu_0^M)^{-1} \nu)^* w + \mathrm{ad}(w)^* \nu - \mathrm{ad}(w) ((\mu_0^M)^{-1} \nu) \Big)$$

where the last equation follows since the connector (8.113) satisfies, by definition (8.112), $K^* \circ T\mu_0^M = \mu_0^M \circ K$. Hence, $u = (\mu_0^M)^{-1}\nu$ implies $(\operatorname{hl}_{\mu_0^M}^*)_{\nu}(u) = -\operatorname{ad}(u)^*\nu$.

Fix $(\omega, \nu, q) = (\phi, g, \nu, q) \in \mathcal{W}$ and let $(\omega, \nu, p) = \Phi_j(\omega, \nu, q)$. That is,

(4.68)
$$p = q - j\Psi_0^{\text{hor}}(\omega, \nu) = q - \text{Ad}(g)^* \rho_*^{\phi} (1 + CA_0^*)^{-1} C\nu.$$

Proposition 2.2 yields

$$(4.69) X_1^j(\omega, \nu, p) = \left((\mu_0^M)^{-1}\nu, -A_0 u + \mathbb{I}_0^{-1} \rho_*^{\phi^{-1}} \mathrm{Ad}(g^{-1})^* p \right) =: \left(u, Y \right) \in \mathfrak{p} = \mathfrak{m} \times \mathfrak{g}$$

and

$$(4.70) X_2^j(\omega,\nu,p) = -\operatorname{ad}(u)^*\nu - \langle \rho_*^{\phi^{-1}}\operatorname{Ad}(g^{-1})^*p, \operatorname{Curv}_e^{\mathcal{A}_0}(u) \rangle \in \mathfrak{m}^*.$$

We use the diamond notation $\langle X \diamond p, u \rangle = \langle p, \rho^u X \rangle$ and, with $\tilde{p} = \rho_*^{\phi^{-1}} \mathrm{Ad}(g^{-1})^* p$, express the curvature term as

$$\langle \tilde{p}, \operatorname{Curv}_{e}^{A_0}(u) \rangle = \operatorname{ad}(u)^* A_0^* \tilde{p} + A_0^* \operatorname{ad}(A_0 u)^* \tilde{p} - A_0 u \diamond \tilde{p} - A_0^* \rho_*^u \tilde{p}.$$

Further, again by Proposition 2.2 and equivariance of $j \circ \Psi_0^{\text{hor}}$,

$$F_2^j(\omega,\nu,p) = D_\omega^0 B_\omega d(j \circ \Psi_0^{\text{hor}})(X_1^j, X_2^j)(\omega,\nu,p)$$

$$= A_0^* (1 + CA_0^*) \Big((\operatorname{ad}(Y)^* + \rho_*^u)(1 + CA_0^*)^{-1} C \nu + (1 + CA_0^*)^{-1} C X_2^j(\omega,\nu,p) \Big)$$

$$= A_0^* C X_2^j(\omega,\nu,p) + A_0^* (1 + CA_0^*)(\operatorname{ad}(Y)^* + \rho_*^u)(1 + CA_0^*)^{-1} C \nu.$$

Notice that $\operatorname{ad}(A_0 u)^* \tilde{p} = -\operatorname{ad}(\mathbb{I}_0^{-1} \tilde{p} - A_0 u)^* \tilde{p} = -\operatorname{ad}(Y)^* \tilde{p}$. With $\tilde{q} = \rho_*^{\phi^{-1}} \operatorname{Ad}(g^{-1})^* q$, equation (4.68) may be written as $(1 + CA_0^*)^{-1} C \nu = \tilde{q} - \tilde{p}$. Therefore,

$$\begin{split} X_2^j(\omega,\nu,p) + F_2^j(\omega,\nu,p) &= X_2^j(\omega,\nu,p) + A_0^*CX_2^j(\omega,\nu,p) + (1+A_0^*C)A_0^*(\operatorname{ad}(Y)^* + \rho_*^u)(\tilde{q}-\tilde{p}) \\ &= (1+A_0^*C)\Big(-\operatorname{ad}(u)^*\nu - \operatorname{ad}(u)^*(A_0^*\tilde{p}) + A_0u \diamond \tilde{p}\Big) \\ &\quad + (1+A_0^*C)A_0^*(\operatorname{ad}(Y)^* + \rho_*^u)\tilde{q} \\ &= (1+A_0^*C)\Big(-\operatorname{ad}(u)^*((1+A_0^*C)^{-1}\nu) - \operatorname{ad}(u)^*(A_0^*\tilde{q}) \\ &\quad + A_0u \diamond \tilde{q} - A_0u \diamond (1+CA_0^*)^{-1}C\nu + A_0^*(\operatorname{ad}(Y)^* + \rho_*^u)\tilde{q}\Big) \\ &= (1+A_0^*C)\Big(-\operatorname{ad}(u)^*\mu - \langle \tilde{q}, \operatorname{Curv}_e^{A_0}(u) \rangle - A_0u \diamond (1+CA_0^*)^{-1}C\nu\Big) \\ &= (1+A_0^*C)\Big(-\operatorname{ad}(u)^*\mu - \langle S\tilde{q}, \operatorname{Curv}_e^{A_C}(u) \rangle \\ &\quad + F_2^C(\omega,\mu,S\tilde{q}) - A_0u \diamond (1+CA_0^*)^{-1}C\nu\Big) \\ &= (1+A_0^*C)\Big(X_2^C(\omega,\mu,S\tilde{q}) + F_2^C(\omega,\mu,S\tilde{q}) - A_0u \diamond (1+CA_0^*)^{-1}C\nu\Big) \end{split}$$

whence the isomorphism $\varphi_C: \mathfrak{m}^* \to \mathfrak{m}^*$ is

(4.73)
$$\mu = \varphi_C(\nu) := (1 + A_0^*C)^{-1}\nu,$$

the force is

$$(4.74) F_2^C(\omega, \mu, \tilde{q}) := \langle \tilde{q}, \operatorname{Curv}_e^{\mathcal{A}_C}(u) \rangle - \langle S^{-1}\tilde{q}, \operatorname{Curv}_e^{\mathcal{A}_0}(u) \rangle$$

and the matching condition is

$$(4.75) A_0 u \diamond (1 + CA_0^*)^{-1} C \nu \stackrel{!}{=} 0.$$

Indeed, this condition holds, if and only if

$$(4.76) (X_2^j + F_2^j) \circ \Phi_j = \varphi_C^* (X_2^C + F_2^C).$$

Moreover, the force $F_C = (\Psi_C^{-1})^*(0, F_2^C, 0)$ satisfies (3.39) and (3.40), because (4.74) vanishes for q = 0.

If $C: \mathfrak{m}^* \to \mathfrak{g}^*$ satisfies (4.75), then the controlled Hamiltonian follows from the explicit formulas (3.41), (3.42) and (3.43) with (4.73). Write the controlled connection \mathcal{A}_C as $\mathcal{A}_C(e, e, u, X) = X + A_C(u)$. Therefore:

Theorem 4.1. Let φ_C be given by (4.73), let $S: \mathfrak{g}^* \to \mathfrak{g}^*$ be a $\rho_*(M) \times \operatorname{Ad}(G)^*$ -equivariant isomorphism and let $\Phi = \Psi_C \circ (\operatorname{id}_P, \varphi_C, S) \circ \Phi_j^{-1} \circ \Psi_0^{-1}$. Let H_C be the Kaluza-Klein Hamiltonian associated to

(4.77)
$$\mu_C^M = (1 + A_0^*C)^{-1}\mu_0^M$$

(4.79)
$$A_C = A_0 + \mathbb{I}_0^{-1} C (1 + A_0^* C)^{-1} \mu_0^M.$$

Then $\Phi^*(X_{H_C}+F_C)=X_{H_0}+F_0$ holds, if and only if (4.75) is satisfied. Moreover, $F_C|J^{-1}(0)=0$. If S can be chosen such that $F_2^C=0$, then $F_C=0$.

Remark 4.2. Equations (4.77) and (4.79) have also been found in [20] by ad-hoc calculations. Now they follow from the general results in Theorem 3.1, which also shows that the form of these equations is necessary, because of the requirements on Φ and the assumption that H_C is of Kaluza-Klein form.

Remark 4.3. If the representation ρ is trivial, so that $P = M \times G$ is a direct product of Lie groups, then the condition (4.75) is empty.

4.D. **Equilibria.** Assume $\nu_e \in \mathfrak{m}^*$ is an equilibrium of the uncontrolled equation of motion in M. That is,

(4.80)
$$\operatorname{ad}((\mu_0^M)^{-1}\nu_e).\nu_e = 0$$

or, equivalently, $X_2^j(\omega, \nu_e, 0) = 0$ where X_2^j is given in (4.70). Suppose that the matching condition (4.75) holds and that S has been found such that $F_C = 0$. Equation (4.76) with $\omega = (\phi, g)$ and q = 0 implies that ν_e is also an equilibrium of

(4.81)
$$ad((\mu_C^M)^{-1}\nu_e).\nu_e = 0$$

if $(X_2^j + F_2^j)(\omega, \nu_e, -j\Psi_0^{\text{hor}}(\omega, \nu_e)) = 0$. Because of equations (4.70) and (4.72), a sufficient condition for this to hold is that

$$(4.82) C\nu_e = 0.$$

Hence, if this condition holds, one can use (non-linear) stability analysis of (4.81) for (4.80).

5. Satellite with a rotor

The feedback control of the satellite with a rotor is studied in [9, 10, 25]. A Lie-Poisson version of the present approach (focusing on on the momentum shift factor 1 - k) is given in [20]. See also Remarks 1.1 and 1.3 in loc. cit.

5.A. **Setup.** The configuration space of the satellite with a rotor attached to the third principal axis is a direct product Lie group $P = M \times G = SO(3) \times S^1$. Let $I_1 > I_2 > I_3$ be the rigid body moments of inertia and $i_1 = i_2 > i_3$ those of the rotor. We use left multiplication in the direct product group P to write the tangent bundle $TP \cong P \times \mathfrak{so}(3) \times \mathbb{R} \cong P \times \mathbb{R}^4$. We identify $\mathfrak{m} = \mathfrak{so}(3) = \mathbb{R}^3$.

Let $\lambda_j = I_j + i_j$ for j = 1, 2, 3, $\mu_0^M = \text{diag}(\lambda_1, \lambda_2, I_3)$ and $\mathbb{I}_0 = i_3$. The mechanical connection is

$$(5.83) A_0: M \times \mathbb{R}^3 \to \mathfrak{g} = \mathbb{R}, \ (\phi, \Omega) \mapsto \Omega_3.$$

The associated (local) curvature form is denoted by $\operatorname{Curv}^{A_0} = dA_0$. This is a two-form on M and is given by

$$(5.84) i(\Omega) \operatorname{Curv}^{A_0} = (\Omega_2, -\Omega_1, 0).$$

The Kaluza-Klein metric associated to $(\mu_0^M, \mathbb{I}_0, A_0)$ is

(5.85)
$$\mu_0^P = \begin{pmatrix} \lambda_1 & & & \\ & \lambda_2 & & \\ & & \lambda_3 & i_3 \\ & & i_3 & i_3 \end{pmatrix}$$

with corresponding kinetic energy Hamiltonian H_0 . The Hamiltonian system X_{H_0} is invariant under the S^1 -action on the second factor with momentum map $J: T^*P = P \times \mathbb{R}^3 \times \mathbb{R} \to \mathbb{R}$, $(\omega, \Pi, p) \mapsto p$. (It is also invariant under the left multiplication in SO(3), but this symmetry is not needed at this point.)

5.B. The control connection. The control connection Γ is

(5.86)
$$\Gamma: SO(3) \times S^1 \times \mathbb{R}^3 \times \mathbb{R} \to \mathbb{R}, \quad (\phi, g, \Omega, X) \mapsto X.$$

Thus $\operatorname{Hor}_{\Gamma} = P \times \mathbb{R}^3 \times \{0\}$. The maps j and B are defined by the formulas (4.64) and (4.63). Hence the symmetry actuating force F_0 is given by (1.10) and J+j is a conserved quantity for solutions of $X_{H_0} + F_0$.

5.C. **Matching.** Since P is now a direct product, the matching condition (4.75) is void and any linear map $\tilde{\jmath}_e = C : \mathfrak{m}^* = \mathbb{R}^3 \to \mathfrak{g}^* = \mathbb{R}$ is admissible in the sense of Theorem 4.1. We choose

(5.87)
$$C(\Pi_1, \Pi_2, \Pi_3) = -k\Pi_3$$

for a (small) parameter $k = -\gamma$.

Remark 5.1. Because of equation (4.82), it follows that the corresponding force F_0 is potentially suitable to stabilize the unstable equilibrium $\Pi_e = (0, 1, 0)$ (rotation of the satellite about the middle axis). Indeed, [10, Prop. 3.1] show that this control stabilizes Π_e for $1 > k > 1 - I_3/\lambda_2$.

Theorem 4.1 yields the controlled data

(5.88)
$$\mu_C^M = \begin{pmatrix} \lambda_1 & & \\ & \lambda_2 & \\ & & (1-k)^{-1} I_3 \end{pmatrix}$$

$$\mathbb{I}_C = f_k^{-1} \mathbb{I}_0$$

$$(5.90) A_C = f_k A_0$$

where

$$(5.91) f_k := \frac{\mathbb{I}_0 - k\lambda_3}{\mathbb{I}_0(1-k)}$$

follows from (4.79) and the choice for \mathbb{I}_C is such that F_2^C in (4.74) vanishes.

Let $H_C: T^*P \to \mathbb{R}$ be the Kaluza-Klein Hamiltonian specified by these formulas. Then we have shown that

$$\Phi^* X_{H_C} = X_{H_0} + F_0$$

where
$$\Phi = \Psi_C \circ (\mathrm{id}, \varphi_C, f_k^{-1}) \circ \Phi_i^{-1} \circ \Psi_0^{-1}$$
.

That is, the closed-loop equations associated to the conserved quantity $(J+j)(\omega, \Pi, p)$, that is due to exerting the force F_0 , are equivalent to the Hamiltonian system X_{H_C} . Explicitly, with Definition 1.5,

$$(5.93) (J+j)(\omega,\Pi,p) = (1+Chpr_{\Gamma}^*)^{-1}(C\Pi+p) = (1-k)^{-1}(-k\Pi_3+p)$$

Remark 5.2. Equation (5.91) coincides with [20, (1.27)].

Remark 5.3. The 1-k a posteriori shift that appears in [9, 10, 25] has been included in the general construction and therefore is now a part of the formula (5.93) for the conserved quantity. The shift is explicitly mentioned in the sentence below [10, Equ. (3.7)]. The above construction is also different from [20, Section 4], where another relation between A_0 and C was given. Both relations lead to the conclusion (5.92), albeit with different formulas for \mathbb{I}_C . The ad-hoc approach of [20, Section 4] corresponds to setting B = 1 in Definition 1.5. However, this means that equation (2.36) need no longer hold. Since this equation is crucial when dealing with more general group actions, such as non-abelian G or semi-direct P, we prefer definition (2.35) for B. See Section 7.A.

Remark 5.4. Remark 1.1 in [20] can now be rephrased as follows: The controlled equation of motion corresponding to the feedback law (5.93) are obtained by replacing the uncontrolled equations of motion $\dot{\nu} = \operatorname{ad}((\mu_0^M)^{-1}\nu)^*\nu - \langle p, i((\mu_0^M)^{-1}\nu)\operatorname{Curv}^{A_0}\rangle$ with $\dot{\nu} = \operatorname{ad}((\mu_C^M)^{-1}\nu)^*\nu - \langle p, i((\mu_C^M)^{-1}\nu)\operatorname{Curv}^{A_C}\rangle$, where $p_k = (J+j)(\omega, \Pi, p)$.

6. Control of ideal fluids subject to an external Yang-Mills field

This section is concerned with ideal incomressible flow of charged particles in the presence of an external Yang-Mills field $\mathcal{M} = \operatorname{Curv}^{A_0} = dA_0 + \frac{1}{2}[A_0, A_0]$. Gauge symmetry yields conservation of charge along the fluid flow. In the language of the previous sections, the symmetry actuating force is assumed to work on the charge variables, but not on the (positions or momenta of the) fluid particles. If the symmetry group K is abelian, then $\mathcal{M} = dA_0$ is a magnetic field. See [14, 16] for further background and [20] for the Lie-Poisson version of this example.

6.A. **Setup.** Let K be a finite dimensional Lie group with Lie algebra \mathfrak{k} and Q a compact domain, possibly with boundary, in \mathbb{R}^n . Consider the trivial principal bundle $S:=Q\times K\to Q$ where the principal bundle action is given by right multiplication in the group. Let $\mu_0^Q=\langle .,.\rangle$ denote the induced Euclidean metric on $Q\subset\mathbb{R}^n$ and \mathbb{I}_0 a symmetric positive definite bilinear form on \mathfrak{k} which is $\mathrm{Ad}(k)$ -invariant. We fix a connection form $A_0:TQ\to\mathfrak{k}$. The horizontal space $\mathrm{Hor}_0\subset TS=Q\times K\times\mathbb{R}^n\times\mathfrak{k}$ is thus $\mathrm{Hor}_0=\{(u,k,u_x,X):X+A_0(x)u_x=0\}$. Denote the Kaluza-Klein metric on $Q\times K$ associated to $(\mu_0^Q,\mathbb{I}_0,A_0)$ by

(6.94)
$$\mu_0^S = \mu^{KK}(\mu_0^Q, \mathbb{I}_0, A_0).$$

For $k \in K$, let $r^k : S \to S$, $(x, g) \mapsto (x, gk)$ denote the principal right action. Consider the volume preserving automorphisms

$$\operatorname{Aut}_0(S) := \{ \Phi \in \operatorname{Diff}(S) : \Phi \circ r^k = r^k \circ \Phi \ \forall k \in K \ \& \ \Phi^* \operatorname{vol}_S = \operatorname{vol}_S \}$$

which can be identified as

$$\operatorname{Aut}_0(S) = \operatorname{Diff}_0(Q) \otimes \mathcal{F}(Q, K)$$

where $\operatorname{Diff}_0(Q)$ is the set of vol_Q -preserving diffeomorphisms and $\mathcal{F}(Q, K)$ denotes functions from Q to K (of a fixed differentiability class which we do not specify). See [14]. Composition from the right gives rise to a right representation

$$\rho: \mathrm{Diff}_0(S) \to \mathrm{Aut}(\mathcal{F}(Q,K)), \quad \phi \mapsto \rho^{\phi}$$

where $\rho^{\phi}(g) = g \circ \phi$.

Consider the action by point-wise right multiplication $R^g: \mathcal{F}(Q,K) \to \mathcal{F}(Q,K)$, $h \mapsto hg$. The induced semi-direct right action on $\operatorname{Aut}_0(S)$ is again denoted by R:

(6.95)
$$R^{(\psi,g)}(\phi,h) = (\phi \cdot \psi, R^g(\rho^{\psi}(h))).$$

In particular, $\operatorname{Aut}_0(S) \to \operatorname{Aut}_0(S)/\mathcal{F}(Q,K) = \operatorname{Diff}_0(S)$ is a right principal $\mathcal{F}(Q,K)$ bundle. We also consider the right trivializations

(6.96)
$$T \operatorname{Aut}_{0}(S) \cong \operatorname{Aut}_{0}(S) \times \mathfrak{a} = \operatorname{Diff}_{0}(S) \times \mathfrak{d} \times \mathcal{F}(Q, K) \times \mathfrak{g}$$
$$T^{*} \operatorname{Aut}_{0}(S) \cong \operatorname{Aut}_{0}(S) \times \mathfrak{a}^{*} = \operatorname{Diff}_{0}(S) \times \mathfrak{d}^{*} \times \mathcal{F}(Q, K) \times \mathfrak{g}^{*}$$

using the right multiplication in $\operatorname{Aut}_0(S)$, where $\mathfrak{a} = T_e \operatorname{Aut}_0(S)$, $\mathfrak{d} = T_e \operatorname{Diff}_0(S) = \mathcal{X}_0(Q)$ are divergence free vector fields tangent to the boundary and $\mathfrak{g} = T_e \mathcal{F}(Q, K) = \mathcal{F}(Q, \mathfrak{k})$. Here, \mathfrak{a}^* , \mathfrak{d}^* and \mathfrak{g}^* denote the smooth part of the dual.

We have $\mathfrak{d}^* = \Omega^1(Q)/d\mathcal{F}(Q)$ and $\mathfrak{g}^* = \mathcal{F}(Q, \mathfrak{t}^*)$. The pairings are given by

$$\mathfrak{d}^* \times \mathfrak{d} \to \mathbb{R}, \quad ([\Pi], u) \mapsto \int_Q \langle \Pi_x, u_x \rangle \, dx$$

$$\mathfrak{g}^* \times \mathfrak{g} \to \mathbb{R}, \quad (q, X) \mapsto \int_Q \langle q_x, X_x \rangle \, dx$$

where $[\Pi]$ is the class of $\Pi \in \Omega^1(Q)$. By definition, the smooth duals are the isomorphic images of the maps

$$[\mu_0^Q]: \mathfrak{d} \to \mathfrak{d}^*, \quad u \mapsto [\mu_0^Q(u)]$$

and $\mathbb{I}_0: \mathfrak{g} \to \mathfrak{g}^*, q \mapsto \langle \mathbb{I}_0 q, \underline{\hspace{0.1cm}} \rangle$ where $[\mu_0^Q(u)]$ is the class of $\mu_0^Q(u) \in \Omega^1(Q)$ in $\Omega^1(Q)/d\mathcal{F}(Q) = \mathfrak{d}^*$ and \mathbb{I}_0 is independent of $q \in Q$. The inverse is of $[\mu_0^Q]$ is

$$[\mu_0^Q]^{-1}: [\Pi] \mapsto \mathcal{P}((\mu_0^Q)^{-1}(\Pi))$$

where Π is a representative of $[\Pi]$ and \mathcal{P} is the Helmholtz-Hodge-Leray projection. For a vector field $u \in \mathcal{X}(Q)$ the Helmholtz-Hodge-Leray projection is divergence free, tangent to the boundary, and given by $\mathcal{P}(u) = u - \nabla g$ where g is determined by $\Delta g = \operatorname{div} u$ with Neumann boundary conditions.

In this section all duals are in the smooth sence such that $[\mu_0^Q]$ and \mathbb{I}_0 are isomorphisms. Further, the dual to $A_0: \mathfrak{d} \to \mathfrak{g}$ is $[A_0^*]: \mathfrak{g}^* \to \mathfrak{d}^*, q \mapsto [A_0^*q]$, where $A_0^*: \mathfrak{k}^* \to T^*Q$ is the point-wise dual and $[A_0^*q] \in \mathfrak{g}^*$ is the class of $A_0^*q \in \Omega^1(Q)$ in $\Omega^1(Q)/d\mathcal{F}(Q)$.

The representation ρ gives rise to an infinitesimal representations $\rho^{\phi}X$ and $\rho^{u}(X) = dX.u = L_{u}X = \nabla_{u}X$ with $\phi \in \text{Diff}_{0}(S)$, $u \in \mathfrak{d}$ and $X \in \mathfrak{g}$. The corresponding coadjoint representations are given by $\rho^{\phi}(q) = (\rho^{\phi^{-1}})^{*}(q)$ and $\rho^{u}(q) = (\rho^{-u})^{*}(q)$ with $q \in \mathfrak{g}^{*}$.

We define the bracket [.,.] on \mathfrak{d} (and similarly for \mathfrak{a}) to be the negative of the usual Lie bracket: $[u,u] := -\nabla_u v + \nabla_v u$ where $\nabla_u v = \langle u, \nabla \rangle v$ and $u,v \in \mathfrak{d}$. This choice of sign is compatible with [1,2]. Further, we define the operator $\mathrm{ad}(u).v = [u,v]$. Its dual is $\mathrm{ad}(u)^*[\Pi] = [\Pi \circ \mathrm{ad}(u)]$ for $[\Pi] \in \mathfrak{d}^*$.

Remark 6.1 (From finite to infinite dimensions). The roles of the groups P, M, G of Section 4 are now played, respectively, by $\operatorname{Aut}_0(S)$, $\operatorname{Diff}_0(Q)$, $\mathcal{F}(Q,K)$. In the above sections all spaces were assumed to be finite dimensional. However, all calculations and formulas were global and carry over, in principle, to the infinite dimensional case. The only exception to this rule are the (fundamental) equations is equation (8.114), which is based on the local coordinate result [18, Prop. 2.1]. Nevertheless, the formulas of Proposition 2.2 can be used for the Lie-Poisson case in this section, since (8.114) follows directly from the explicit expression of the symplectic form on $T^*\operatorname{Aut}_0(S)$ (see, e.g., [28]). Therefore, and also because this Lie-Poisson example has already been treated in [20], where further details on the setup are given, the algebraic formulas of Theorem 4.1 will be applied without further justification.

6.B. The Hamiltonian system. Let $[\mu_0^S]: \mathfrak{a} \to \mathfrak{a}^*$ be the isomorphism associated to (6.94). Equip $T^*\mathrm{Aut}_0^*(S) = \mathrm{Aut}_0(S) \times \mathfrak{a}^* = \mathrm{Diff}_0(Q) \times \mathcal{F}(Q,K) \times \mathfrak{d}^* \times \mathfrak{g}^*$ with the canoncal symplectic form and consider the Hamiltonian

(6.97)
$$H_0: \operatorname{Aut}_0(S) \times \mathfrak{a}^* \to \mathbb{R}, \quad (\omega, \Pi) \mapsto \frac{1}{2} \langle \Pi, [\mu_0^S]^{-1} \Pi \rangle.$$

The metric $[\mu_0^S]$ is right-invariant with respect to (4.55) and of Kaluza-Klein form with respect to $([\mu_0^Q], \mathbb{I}_0, \mathcal{A}_0)$. The mechanical connection is given by

(6.98)
$$\mathcal{A}_0: \mathrm{Diff}_0(Q) \times \mathcal{F}(Q,K) \times \mathfrak{d} \times \mathfrak{g} \to \mathfrak{g}^*, \quad (\phi,g,u,X) \mapsto \mathrm{Ad}(g^{-1})\rho^{\phi}(X+A_0u).$$

This Hamiltonian is right-invariant. Hence the momentum map $J_0: T^*\mathrm{Aut}_0(S) \to \mathfrak{a}^*$ with respect to the cotangent lifted action is constant along solutions of X_{H_0} . In particular, $J := \mathrm{pr}_2 \circ J_0: T^*\mathrm{Aut}_0(S) \to \mathfrak{g}^*$ is a conserved quantity. This momentum map corresponds to the conservation of charge.

6.C. The control connection. The control connection Γ is

(6.99)
$$\Gamma: \mathrm{Diff}_0(Q) \times \mathcal{F}(Q, K) \times \mathfrak{d} \times \mathfrak{g} \to \mathfrak{g}, \quad (\phi, g, u, X) \mapsto \mathrm{Ad}(g^{-1})\rho^{\phi}X.$$

That is $\operatorname{Hor}_{\Gamma} = \operatorname{Aut}_0(S) \times \mathfrak{d} \times \{0\}$. The maps j and B are defined by the formulas (4.64) and (4.63). Hence the symmetry actuating force F_0 is given by (1.10) and J+j is a conserved quantity for solutions of $X_{H_0} + F_0$.

6.D. **Matching condition.** We apply Theorem 4.1. The matching condition (4.75) is satisfied, if

$$(6.100) (1 + CA_0^*)^{-1}C[\mu_0^Q]u = \gamma \mathbb{I}_0 A_0 u$$

for a parameter γ . This equation is equivalent to

(6.101)
$$C = \gamma \left(1 - \gamma \mathbb{I}_0 A_0 [\mu_0^Q]^{-1} [A_0^*] \right)^{-1} \mathbb{I}_0 A_0 [\mu_0^Q]^{-1}$$

where γ is assumed to be sufficiently small so that this expression exists. Due to (4.79) this implies that the controlled connection must be given by

$$(6.102) A_C = (1+\gamma)A_0.$$

Therefore, $Curv^{A_C} = (1 + \gamma)Curv^{A_0}$ and choosing (4.78) as

$$\mathbb{I}_C = (1+\gamma)^{-1} \mathbb{I}_0$$

yields a force F_C , which vanishes because of definition (4.74).

These formulas were found in [20, Section 2.G], involving an ad-hoc analysis of the force field and the corresponding closed-loop equations.

Let $H_C: T^*\mathrm{Aut}_0(S) \to \mathbb{R}$ be the Kaluza-Klein Hamiltonian specified by Theorem 4.1. That is, $[\mu_C^Q] = (1 + [A_0^*]C)^{-1}[\mu_0^Q]$ and \mathbb{I}_C , A_C are given above. Then we have shown that

$$\Phi^* X_{H_C} = X_{H_0} + F_0$$

where $\Phi = \Psi_C \circ (\mathrm{id}, \varphi_C, (1+\gamma)^{-1}) \circ \Phi_i^{-1} \circ \Psi_0^{-1}$.

That is, the closed-loop equations associated to the conserved quantity J + j, that is due to exerting the force F_0 , are Φ -related to the Hamiltonian system X_{H_C} .

7. Conclusions and future directions

7.A. Setting B=1 and non-abelian G. Instead of (2.35), one may also set B=1 in Definition 1.5. While one then loses the simplifying equation (2.36), the controlled Noether Theorem 1.6 remains valid since it is independent of the choice of B. Moreover, as mentioned in Remark 5.3, B=1 does work for the satellite example.

To see why (2.35) is preferable, consider the direct product $P = M \times G$ of Lie groups, where G is non-abelian. As in Section 4, the strategy is to look for a fiber-linear isomorphism

$$\Phi_C = (\varphi_C, S) : P \times \mathfrak{m}^* \times \mathfrak{g}^* \to P \times \mathfrak{m}^* \times \mathfrak{g}^*$$

where $\varphi_C: P \times \mathfrak{m}^* \to P \times \mathfrak{m}^*$, $(\omega, \nu) \mapsto (\omega, \varphi_C(\omega, \nu))$ is equivariant for the right action and $S: \mathfrak{g}^* \to \mathfrak{g}^*$ is $\mathrm{Ad}^*(G)$ -equivariant, such that

$$(7.105) T\varphi_C^{-1} \cdot \left((X_1^C, X_2^C + F_2^C) (\Phi_C(\omega, \nu, q)) \right) = \left(X_1^j, X_2^j + F_2^j \right) \left(\Phi_j(\omega, \nu, q) \right)$$

where $(\omega, \nu, q) = (\phi, g, \nu, q) \in \mathcal{W}$. Equivariance of φ_C implies that $\varphi_C(\omega, \nu) = \varphi_C(\nu)$ is independent of ω . Let us assume that S has been found so that $F_2^C = 0$. Hence we obtain the necessary matching condition

$$(7.106) T\varphi_C^{-1} X_2^C(\Phi_C(\omega, \nu, q)) = \left(X_2^j + F_2^j\right) \left(\Phi_j(\omega, \nu, q)\right)$$

Now, because of (8.117) and linearity of S and φ_C , the left hand side of this equation has to depend linearly on q. To evaluate this equation at $(\omega, \nu, p) = \Phi_j(\omega, \nu, q) = (\phi, g, \nu, q - j\Psi_0^{\text{hor}}(\omega, \nu))$, rewrite (2.23) as

$$X_2^j(\omega, \nu, p) = -\operatorname{ad}(u)^*\nu - L(\omega, \nu, p),$$

where L is defined in (2.31), and (2.26) as

$$F_2^j(\omega, \nu, p) = D_\omega^0 \cdot d(j \circ \Psi_j) \cdot X^j(\omega, \nu, p)$$

$$= A_0^* \Big(\operatorname{ad}(X)^* C \nu + [\operatorname{ad}(X)^*, CA_0^* (1 + CA_0^*)^{-1}]_{\operatorname{op}} \operatorname{Ad}(g^{-1})^* p + CX_2^j(\omega, \nu, p) + CA_0^* (1 + CA_0^*)^{-1} \operatorname{Ad}(g^{-1})^* X_3^j(\omega, \nu, p) \Big)$$

where $D_{\omega}^0 = A_0^* \mathrm{Ad}(g^{-1})^*$, [., .]_{op} denotes the commutator of operators and the equations

$$j\Psi_0^{\text{hor}}(\omega,\nu) = \text{Ad}(g)^*C\nu$$

and

$$j\psi_j^{\text{ver}}(\omega, p) = \text{Ad}(g)^* C A_0^* (1 + C A_0^*)^{-1} \text{Ad}(g^{-1})^* p$$

are used. Further, $u = (\mu_0^M)^{-1}\nu$ and $X = -A_0u + \operatorname{Ad}(g)\tilde{\mathbb{I}}^{-1}p = -A_0u + \mathbb{I}_0^{-1}(1 + CA_0^*)^{-1}\operatorname{Ad}(g^{-1})^*p$, because of (2.28). Now, (2.24) equates to

$$(1 + CA_0^*)^{-1} \operatorname{Ad}(g^{-1})^* X_3^j(\omega, \nu, p) = [\operatorname{ad}(X)^*, CA_0^*(1 + CA_0^*)^{-1}]_{\operatorname{op}} \operatorname{Ad}(g^{-1})^* p$$

and the first term in (2.31), which defines $L(\omega, \nu, p)$, becomes

$$\langle d(j \circ \Psi_{j}^{\text{ver}})(\operatorname{hl}_{u_{2}}^{A_{0}}(\omega), 0), \tilde{\mathbb{I}}^{-1}p \rangle$$

$$= -\langle \operatorname{ad}(A_{0}u_{2})^{*}CA_{0}^{*}(1 + CA_{0}^{*})^{-1}\operatorname{Ad}(g^{-1})^{*}p, \mathbb{I}_{0}^{-1}(1 + CA_{0}^{*})^{-1}\operatorname{Ad}(g^{-1})^{*}p \rangle$$

$$+ \langle CA_{0}^{*}(1 + CA_{0}^{*})^{-1}\operatorname{ad}(A_{0}u_{2})^{*}\operatorname{Ad}(g^{-1})^{*}p, \mathbb{I}_{0}^{-1}(1 + CA_{0}^{*})^{-1}\operatorname{Ad}(g^{-1})^{*}p \rangle$$

$$= \langle A_{0}^{*}\left(\operatorname{ad}\left(\mathbb{I}_{0}^{-1}(1 + CA_{0}^{*})^{-1}\operatorname{Ad}(g^{-1})^{*}p\right)^{*}\left(CA_{0}^{*}(1 + CA_{0}^{*})^{-1}\operatorname{Ad}(g^{-1})^{*}p\right) \right.$$

$$- \operatorname{ad}\left((CA_{0}^{*}(1 + CA_{0}^{*})^{-1})^{*}\mathbb{I}_{0}^{-1}(1 + CA_{0}^{*})^{-1}\operatorname{Ad}(g^{-1})^{*}p\right)^{*}\left(CA_{0}^{*}(1 + CA_{0}^{*})^{-1}\operatorname{Ad}(g^{-1})^{*}p\right), u_{2}\rangle$$

Therefore, collecting all the terms in the right hand side of (7.106), which are quadratic in p, and equating these to 0, yields the condition

(7.107)

$$(1 + CA_0^*)A_0^*\operatorname{ad}\left((CA_0^*(1 + CA_0^*)^{-1})^*\mathbb{I}_0^{-1}(1 + CA_0^*)^{-1}\operatorname{Ad}(g^{-1})^*p\right)^*\left(CA_0^*(1 + CA_0^*)^{-1}\operatorname{Ad}(g^{-1})^*p\right)$$

$$= A_0^*CA_0^*\operatorname{ad}\left(\mathbb{I}_0^{-1}(1 + CA_0^*)^{-1}\operatorname{Ad}(g^{-1})^*p\right)^*\left(\operatorname{Ad}(g^{-1})^*p\right).$$

In order for (7.106) to be linear in q, and therefore in p, this equality should hold, whence we obtain a new necessary (but not sufficient) matching condition. Since the $\mathrm{ad}(\cdot)^*$ -operation is in \mathfrak{g}^* , this condition is automatically satisfied when \mathfrak{g} is abelian. We have not shown that matching is impossible for non-abelian G under the assumption B=1, but with (7.107) there is (at least) one new condition on C that has to be satisfied. On the other hand, Theorem 4.1 shows that there are no conditions on $C:\mathfrak{m}^*\to\mathfrak{g}^*$ for the direct product Lie group $P=M\times G$, regardless of whether G is commutative or not.

Consistently with this conclusion and Remark 5.3, for the satellite example the symmetry group G is the abelian group S^1 .

7.B. Comparison with existing literature. The method of controlled Lagrangian and Hamiltonian systems has started with [23, 9] and then been further developed in [6, 7, 11, 10, 29]. A review of these results is contained in [8]. In [11] it is shown, for general systems and without explicitly considering symmetries, that the methods of controlled Lagrangian and Hamiltonian systems are equivalent. The matching result of [6] is more general than Theorem 4.1, since it allows the metric μ_0^M to depend on the base point. On the other hand, [6, 7, 8, 9, 10, 29] assume the symmetry group G to be abelian and, when M is a Lie group, the product $M \times G$ is assumed to be a direct product Lie group.

With regard to the existing literature, cited in the previous paragraph, the approach of the present paper differs in the following ways:

- (1) The symmetry group G is allowed to be non-abelian.
- (2) The product P may be a semi-direct product with respect to a representation $\rho: M \to \operatorname{Aut}(G)$.
- (3) The starting point for the construction is the symmetry actuating force defined in (1.10) with B given in (2.35). This force leads to a conserved quantity (Theorem 1.12), and Theorem 3.1 provides explicit formulas for the controlled data $(\mu_C^M, \mathbb{I}_C, A_C)$ together with a non-explicit matching condition (3.44) under completely general assumptions. In the case where P is a (semi-)direct product of Lie groups M and G, the matching condition can be made explicit and is given in Theorem 4.1. We emphasize that the matching condition is automatically satisfied, if the representation $\rho: M \to \operatorname{Aut}(G)$ is trivial. In contrast, the approach of [6, 7, 8, 9, 11, 10, 29] is to start from $(\mu_C^M, \mathbb{I}_C, A_C)$ and to construct the force from the controlled data. While these approaches are, in principle, equivalent, the advantage of starting directly with the force is that the corresponding control law is automatically related to the associated conserved quantity J+j. Otherwise, the control law could be related to J+j only up to a factor. While in some cases (such as the satellite example), this factor can be absorbed by multiplying the conserved momentum variable accordingly, for more general group actions (compare Section 7.A) such an absorption may not be possible. An example of this relation is given in Remarks 5.3 and 5.4.
- (4) The crucial step in the construction of the force F in (1.10) is the choice (2.35). This choice implies, that F depends on the full Π -dynamics. Let us, locally, decompose $T^*P = M \times G \times \mathfrak{m}^* \times \mathfrak{g}^*$ and correspondingly $\Pi = (\omega, g, \nu, p)$. Since F is G-invariant, we thus write, again locally, $F = F(\omega, \nu, p)$. The point is that F depends also on observations of the controlled p-variable. This is in contrast to [6, Prop. 3.1] where the Simplified Matching Assumptions, which are used in the examples, imply that the control force [6, Equ. (3.12)] is independent of the controlled symmetry (position and velocity) variables. Similarly, the control in [7] is chosen so that the force [7, Equ. (24)] is p-independent.
- (5) All of the calculations in this paper are global and can therefore be adapted to the infinite dimensional case relevant for fluid mechanics. The only exception to this rule is (8.114), which depends on the local coordinate calculation in [18, Prop. 2.1]. However,

for the infinite dimensional case, that is relevant for fluid dynamics, this equation can be shown directly. See, e.g., [28, Section 4.1].

7.C. Electromagnetic flow control. The Hamiltonian formulation of inviscid flow of charged particles in interaction with electromagnetic or, more generally, Yang-Mills fields is given in [16, 26, 15]. For the incompressible case the phase space of this system can be schematically described as

$$T^*(\operatorname{Aut}_0 \times \operatorname{Conn})$$

where Aut₀ is the volume preserving automorphism group of a principal fiber bundle and Conn is the space of connections. In contrast to Section 6 there are now two (commuting) symmetry group actions: the action by right multiplication by Aut₀ remains; additionally there is now the diagonal action due to left multiplication by the gauge group.

This example still fits the general setup of Section 3 and one may envisage a construction similar to that of Section 4 in order to transform (3.44) into an explicit matching criterion.

7.D. Closed-loop control of stochastic Hamiltonian systems. The force in the feedback control construction of (1.9) depends on the Hamiltonian itself, the momentum map $J: T^*P \to \mathfrak{g}^*$ and a G-equivariant fiber-linear map $\tilde{\jmath}: \operatorname{Hor}^* = J^{-1}(0) \to \mathfrak{g}^*$. Hence a generalization to stochastic Hamiltonian systems could be possible.

More concretely, consider a G-invariant Hamiltonian $H_0: T^*P \to \mathbb{R}$ as in Section 1. For $k = 1, \ldots, N$, let $H_k: T^*P \to \mathbb{R}$ be a collection of G-invariant Hamiltonians and W^k pair-wise independent Brownian motions. Consider the stochastic Hamiltonian system

$$\delta\Pi_t = X_{H_0}(\Pi_t) \,\delta t + \sum_{k=1}^N X_{H_k}(\Pi_t) \,\delta W_t^k$$

where δ is the Stratonovich differential. The symmetry actuating force F depends on the system variable Π and is therefore subject to the same uncertainty as the system itself. That is, with equation (1.6):

$$F(\Pi_t) = -\mathrm{vl}^* \Big(\Pi_t, \Big((\tau, J) | \mathrm{Ver}_{\Gamma}^* \Big)^{-1} (\tau(\Pi_t), B.dj.\delta \Pi_t) \Big).$$

For k = 0, ..., N, we thus define

$$\mathcal{U}_k(\Pi) = \left((\tau, J) | \operatorname{Ver}_{\Gamma}^* \right)^{-1} \left(\tau(\Pi), -B_{\omega} dj. X_{H_k}(\Pi) \right)$$

and, analogously to (1.6),

$$F(\Pi) = \operatorname{vl}^* \left(\Pi, \mathcal{U}_0(\Pi) \, \delta t + \sum_{k=1}^N \mathcal{U}_k(\Pi) \, \delta W_t^k \right) = \operatorname{vl}^* \left(\Pi, \mathcal{U}_0(\Pi) \right) \delta t + \sum_{k=1}^N \operatorname{vl}^* \left(\Pi, \mathcal{U}_k(\Pi) \right) \delta W_t^k$$

which should be viewed as a Stratonovich operator. The stochastic controlled Hamiltonian system is

(7.108)
$$\delta\Pi_t = X_{H_0}(\Pi_t) \,\delta t + \sum_{k=1}^N X_{H_i}(\Pi_t) \,\delta W_t^k + F(\Pi_t).$$

As with (1.12), it can be verified that the stochastic controlled Noether Theorem holds:

$$d(J+j).(X_{H_0}(\Pi_t) \delta t + \sum_{k=1}^{N} X_{H_i}(\Pi_t) \delta W_t^k + F(\Pi_t)) = 0,$$

whence $(J+j)(\Pi_t)$ is constant in t.

It is therefore conceivable, that the construction in the above sections would also work for stochastic Hamiltonian systems, as long as the stochastic perturbations respect the level sets of the momentum map J (which is the case if the H_k are G-invariant). One may consider perturbations in the M-variables (e.g. satellite or fluid), in the G-variables (e.g. rotor or external magnetic field), or in both.

The modern formulation of stochastic geometric mechanics has been initiated in [24] and (7.108) is to be understood in the Stratonovich formulation of loc. cit. Examples of finite dimensional stochastic Hamiltonian (and almost-Hamiltonian) systems are in [24, 17, 18, 3] and examples of stochastic Hamiltonian fluid dynamical systems can be found in [22, 12, 19, 13]. The stochastic energy-Casimir method, whose deterministic version has been successfully applied to stabilize closed-loop systems in [6, 7, 8, 9, 10, 20], has been developed by [4].

8. Appendix

Let $G \hookrightarrow P \to M$ be a right principal bundle with a connection form $\mathcal{A} \in \Omega^1(P, \mathfrak{g})$. Suppose μ^M is a Riemannian metric on M and \mathbb{I} a locked inertia tensor on \mathfrak{g} . Let $\mu^P = \mu^{KK}(\mu^M, \mathbb{I}, A)$ be the corresponding Kaluza-Klein metric on P and $H: T^*P \to \mathbb{R}$, $\Pi \mapsto \frac{1}{2}\langle \Pi, (\mu^P)^{-1}\Pi \rangle$ the kinetic energy Hamiltonian. The standard momentum map is $J: T^*P \to \mathfrak{g}^*$.

Let

(8.109)
$$\mathcal{W} := P \times_M T^*M \oplus P \times \mathfrak{g}^*$$

and we shall identify $P \times_M T^*M \oplus P \times \mathfrak{g}^* = P \times_M T^*M \times \mathfrak{g}^*$. Consider the \mathcal{A} -dependent isomorphism

(8.110)
$$\Psi: \mathcal{W} \to T^*P, \quad (\omega, \nu, q) \mapsto (hl^*)^{-1}(\omega, \nu) + (J|Ver_A^*)_{\omega}^{-1}(q)$$

where $\text{hl}^*: \text{Hor}^* \to P \times_M T^*M$ is the adjoint to the \mathcal{A} -horizontal lift, $\omega \in P$ and $\nu \in T^*M$ with $\pi(\omega) = \tau_{T^*M}(\nu)$. See [30].

Denote the canonical Liouville and symplectic forms on T^*P by θ and $\Omega = -d\theta$, respectively. Then the pulled back symplectic form $\Omega^{\mathcal{A}} := \Psi^*\Omega = -d(\Psi^*\theta)$ can be expressed as

(8.111)
$$\Omega^{\mathcal{A}} = \pi_2^* \Omega^{T^*M} - \langle dJ_{\mathcal{W}} \, \hat{\,}, \tau^* \mathcal{A} \rangle - \langle J_{\mathcal{W}}, \tau^* \text{Curv}^{\mathcal{A}} \rangle + \langle J_{\mathcal{W}}, \frac{1}{2} \tau^* [\mathcal{A}, \mathcal{A}]_{\wedge} \rangle$$

where $\pi_2: \mathcal{W} \to T^*M$, Ω^{T^*M} is the canonical symplectic form on T^*M , $\tau: \mathcal{W} \to P$ is the projection, $\operatorname{Curv}^{\mathcal{A}} = d\mathcal{A} + \frac{1}{2}[\mathcal{A}, \mathcal{A}]_{\wedge}$ is the curvature form and $J_{\mathcal{W}}: \mathcal{W} \to \mathfrak{g}^*$, $(\omega, \nu, q) \mapsto q$ is the momentum map of the induced G-action on \mathcal{W} . Further, we use the general notation $\langle A \, \hat{\,}^{}_{}_{}^{}_{$

Let $\tau_{TM}: TM \to M$ and $\tau_{T^*M}: T^*M \to M$ be the foot point projections. The corresponding vertical spaces are $\operatorname{Ver}(\tau_{TM}) = \ker T\tau_{TM} \subset TTM$ and $\operatorname{Ver}(\tau_{T^*M}) = \ker T\tau_{T^*M} \subset TT^*M$. The Riemannian metric μ^M defines a connection on $TM \to M$ and the corresponding horizontal

space will be denoted by $\operatorname{Hor}(\mu^M) \subset TTM$. This induces a connection on $T^*M \to M$ with horizontal space $\operatorname{Hor}^*(\mu^M) = T\mu^M(\operatorname{Hor}(\mu^M))$. Hence, there are splittings

(8.112)
$$TTM = \operatorname{Hor}(\mu^{M}) \oplus \operatorname{Ver}(\tau_{T^{*}M}) \text{ and } TT^{*}M = \operatorname{Hor}^{*}(\mu^{M}) \oplus \operatorname{Ver}(\tau_{T^{*}M}).$$

The vertical lift maps give rise to the isomorphisms vl : $TM \oplus TM \cong Ver(\tau_{TM})$ and vl* : $T^*M \oplus T^*M \cong Ver(\tau_{T^*M})$. This allows to define the connector maps

(8.113)
$$K := \operatorname{pr}_2 \circ \operatorname{vl}^{-1} \circ \operatorname{vpr}(\mu^M) : TTM \to TM$$
$$K^* := \operatorname{pr}_2 \circ (\operatorname{vl}^*)^{-1} \circ \operatorname{vpr}^*(\mu^M) : TT^*M \to T^*M$$

where pr₂ are the projections onto the second factor and $\text{vpr}(\mu^M)$, $\text{vpr}^*(\mu^M)$ are the projections onto $\text{Ver}(\mu^M)$, $\text{Ver}^*(\mu^M)$ respectively. See [27, Section 22.8].

Proposition 8.1. The canonical symplectic form on T^*M can be expressed as

(8.114)
$$\Omega^{T^*M} = \langle T\tau_{T^*M} \, {}^{\wedge}_{,} \, K^* \rangle.$$

This equation is the global version of the " $\Omega = \sum dq^i \wedge dp_i$ formula". I do not know of a reference (other than the related equation in [18, Prop 2.1]), thus a proof is included:

Proof. In [18, Prop. 2.1] it is shown that

$$(\mu^{M})^{*}\Omega^{T^{*}M} = \Omega^{T^{*}M} \circ \Lambda^{2}T\mu^{M} = \langle T\tau_{TM} \, \hat{\,}, \, \mu^{M} \circ K \rangle$$

whence

$$\Omega^{T^*M} = \langle T\tau_{TM} \, \hat{\,}, K \rangle \circ \Lambda^2 (T\mu^M)^{-1} = \langle T\tau_{TM} \circ (T\mu^M)^{-1} \, \hat{\,}, \mu^M \circ K \circ (T\mu^M)^{-1} \rangle$$
$$= \langle T\tau_{T^*M} \, \hat{\,}, K^* \rangle$$

where we use that $K^* = \mu^M \circ K \circ (T\mu^M)^{-1}$.

Elements $W \in \mathcal{W}$ are written as $W = (\omega, \nu, q) \in P \times T^*M \times \mathfrak{g}^*$ where it is understood that $\pi(\omega) = \tau_{T^*M}(\nu)$. The pulled back Hamiltonian is

(8.115)
$$\Psi^* H : \mathcal{W} \to \mathbb{R}, \quad (\omega, \nu, q) \mapsto \frac{1}{2} \langle \nu, (\mu^M)^{-1} \nu \rangle + \frac{1}{2} \langle q, \mathbb{I}_{\omega}^{-1} q \rangle.$$

Let $Y_2 = (\dot{\omega}_2, \dot{\nu}_2, 0) \in T_{(\omega,\nu,q)} \mathcal{W}$ such that $K^*(\dot{\nu}_2) = 0$ and $\mathcal{A}(\dot{\omega}_2) = 0$. The fibered product requirement yields additionally $T\pi(\dot{\omega}_2) = T\tau_{T^*M}(\dot{\nu}_2) = \dot{x} \in T_x M$ where $x = \pi(\omega)$. We define the horizontal derivative $d^{\text{hor}}(\Psi^*H)_{(\omega,\nu,q)} \in T_x^*M$ by

$$\langle d^{\text{hor}}(\Psi^*H)_{(\omega,\nu,q)}, \dot{x}_2 \rangle = \langle d(\Psi^*H)_{(\omega,\nu,q)}, Y_2 \rangle.$$

If $X^{\mathcal{A}} = (\Omega^{\mathcal{A}})^{-1}d(\Psi^*H)$ is the Hamiltonian vector field with components $(X_1^{\mathcal{A}}, X_2^{\mathcal{A}}, X_3^{\mathcal{A}}) = X^{\mathcal{A}}(\omega, \nu, q)$, then it follows from (8.114) that these are given by

$$(8.116) X_1^{\mathcal{A}} = \mathrm{hl}_{\omega}^{\mathcal{A}} \left((\mu^M)^{-1} \nu \right) + \zeta_{\mathbb{I}_{\omega}^{-1} q}(\omega)$$

$$(8.117) X_2^{\mathcal{A}} = (\mathrm{hl}_{\mu^M}^*)_{\nu} \Big((\mu^M)^{-1} \nu \Big) + \mathrm{vl}_{\nu}^* \Big(-d^{\mathrm{hor}}(\Psi^* H)_{(\omega,\nu,q)} - \langle q, i((\mu^M)^{-1}\nu) \mathrm{Curv}_x^{\mathcal{A}} \rangle \Big)$$

$$(8.118) X_3^{\mathcal{A}} = 0$$

where $\mathrm{hl}_{\mu^M}^*: T^*M \oplus TM \to \mathrm{Hor}^*(\mu^M) \subset TT^*M$ is the horizontal lift, that is $(\mathrm{hl}_{\mu^M}^*)_{\nu} = (T_{\nu}\tau_{T^*M}|\mathrm{Hor}^*(\mu^M))^{-1}$, and $\zeta_X \in \mathcal{P}$ is the fundamental vector field (infinitesimal generator) associated to the G-action and $X \in \mathfrak{g}$. Note that $T\pi.X_1^{\mathcal{A}} = T\tau_{T^*M}.X_2^{\mathcal{A}} = (\mu^M)^{-1}\nu$.
