# GEODESIC LINES ON NEARLY KÄHLER $\mathbb{S}^{3} \times \mathbb{S}^{3}$

#### Abstract

A Nearly Kähler manifold is an almost Hermitian manifold with the weakened Kähler condition, that is, instead of being zero, the covariant derivative of the almost complex structure is skew-symmetric. We give the explicit parametrization of geodesic lines on nearly Kähler $\mathbb{S}^{3} \times \mathbb{S}^{3}$.


## 1. Introduction

A nearly Kähler manifold is an almost Hermitian manifold $(M, g, J)$ with the property that the tensor field $\nabla J$ is skew-symmetric: $\left(\nabla_{X} J\right) Y+\left(\nabla_{Y} J\right) X=0$, for all $X, Y \in T M$, where $\nabla$ is the Levi-Civita connection of the metric $g$. The first example of such manifolds was introduced on $\mathbb{S}^{6}$ by Fukami and Ishihara in [8] and, later, these manifolds have been intensively studied by A. Gray in [9, who generalized the classical holonomy concept by introducing a classification principle for non-integrable special Riemannian geometries and studied the defining differential equations of each class. The structure theorem of Nagy [11, 12] asserts that a strict and complete nearly Kähler manifold (of arbitrary dimension) writes as a Riemannian product of homogeneous nearly Kähler spaces, twistor spaces over quaternionic Kähler manifolds and 6-dimensional nearly Kähler manifolds. Moreover, Butruille has shown in [4] that the only nearly Kähler homogeneous manifolds of dimension 6 are the compact spaces $\mathbb{S}^{6}, \mathbb{S}^{3} \times \mathbb{S}^{3}, \mathbb{C} P^{3}$ and the flag manifold $S U(3) / U(1) \times U(1)$ (where the last three are not endowed with the standard metric). Furthermore, Foscolo et Haskins found in [6] the first two complete non-homogeneous nearly Kähler structures on $\mathbb{S}^{6}$ and on $\mathbb{S}^{3} \times \mathbb{S}^{3}$. This way they addressed an important problem in the field, namely the absence of any complete non-homogeneous examples.

More recently interest in nearly Kähler manifolds increased because these manifolds are examples of geometries with torsion and therefore they have applications in mathematical physics [1]. Moreover, 6-dimensional nearly Kähler manifolds are Einstein and are related to the existence of a Killing spinor [7, which inspires their further investigation. In this paper we continue the research of the nearly Kähler manifold $\mathbb{S}^{3} \times \mathbb{S}^{3}$ (see the previous work in 3], [5], [10, for instance) by studying its geodesics. In Section 2 we recall the basic properties of the nearly Kähler $\mathbb{S}^{3} \times \mathbb{S}^{3}$ and in Section 3 our main results are stated and proved. Theorem 3.1. presents the parametrization of geodesic lines on $\mathbb{S}^{3} \times \mathbb{S}^{3}$ and Proposition 3.1. presents their features.

## 2. Preliminaries

In this section we recall the homogeneous nearly Kähler structure of $\mathbb{S}^{3} \times \mathbb{S}^{3}$. For more details we refer the reader to [2]. By the natural identification $T_{(p, q)}\left(\mathbb{S}^{3} \times \mathbb{S}^{3}\right) \cong T_{p} \mathbb{S}^{3} \oplus T_{q} \mathbb{S}^{3}$, we write a tangent vector at $(p, q)$ in $\mathbb{S}^{3} \times \mathbb{S}^{3}$ as $Z(p, q)=(U(p, q), V(p, q))$ or simply $Z=(U, V)$. Regarding the 3 -sphere in $\mathbb{R}^{4}$ as the set of all unit quaternions in $\mathbb{H}$ and using the notations $i, j, k$ to denote

[^0]the imaginary units of $\mathbb{H}$, the vector fields defined by

are mutually orthogonal with respect to the usual Euclidean product metric on $\mathbb{S}^{3} \times \mathbb{S}^{3}$. The Lie brackets are $\left[\tilde{E}_{i}, \tilde{E}_{j}\right]=-2 \varepsilon_{i j k} \tilde{E}_{k},\left[\tilde{F}_{i}, \tilde{F}_{j}\right]=-2 \varepsilon_{i j k} \tilde{F}_{k}$ and $\left[\tilde{E}_{i}, \tilde{F}_{j}\right]=0$, where

The almost complex structure $J$ on the nearly Kähler $\mathbb{S}^{3} \times \mathbb{S}^{3}$ is defined by

J(U, V)_{(p, q)}=\frac{1}{\sqrt{3}}\left(2 p q^{-1} V-U,-2 q p^{-1} U+V\right)_{(p, q)} \tag{2.2}
\end{equation*}
$$

for $(U, V) \in T_{(p, q)}\left(\mathbb{S}^{3} \times \mathbb{S}^{3}\right)$ and the Hermitian metric associated with the usual Euclidean product metric on $\mathbb{S}^{3} \times \mathbb{S}^{3}$ on $\mathbb{S}^{3} \times \mathbb{S}^{3}$ is given by

g\left(Z, Z^{\prime}\right) & =\frac{1}{2}\left(\left\langle Z, Z^{\prime}\right\rangle+\left\langle J Z, J Z^{\prime}\right\rangle\right)  \tag{2.3}\\
& =\frac{4}{3}\left(\left\langle U, U^{\prime}\right\rangle+\left\langle V, V^{\prime}\right\rangle\right)-\frac{2}{3}\left(\left\langle p^{-1} U, q^{-1} V^{\prime}\right\rangle+\left\langle p^{-1} U^{\prime}, q^{-1} V\right\rangle\right),
\end{align*}
$$

where $Z=(U, V), Z^{\prime}=\left(U^{\prime}, V^{\prime}\right)$, in the first line $\langle\cdot, \cdot\rangle$ stands for the usual Euclidean product metric on $\mathbb{S}^{3} \times \mathbb{S}^{3}$, while in the second line $\langle\cdot, \cdot\rangle$ stands for the usual Euclidean metric on $\mathbb{S}^{3}$. By definition, the almost complex structure $J$ is compatible with the metric $g$.
Using the Koszul formula (see Lemma 2.1. in [2] for more details), one finds that the Levi-Civita connection $\tilde{\nabla}$ on $\mathbb{S}^{3} \times \mathbb{S}^{3}$ with respect to the metric $g$ is given by

\tilde{\nabla}_{\tilde{F}_{i}} \tilde{E}_{j}=\frac{\varepsilon_{i j k}}{3}\left(\tilde{F}_{k}-\tilde{E}_{k}\right) & \tilde{\nabla}_{\tilde{F}_{i}} \tilde{F}_{j}=-\varepsilon_{i j k} \tilde{F}_{k} .
\end{array}
$$

Consequently, computing

\left(\tilde{\nabla}_{\tilde{E}_{i}} J\right) \tilde{E}_{j}=-\frac{2}{3 \sqrt{3}} \varepsilon_{i j k}\left(\tilde{E}_{k}+2 \tilde{F}_{k}\right), & \left(\tilde{\nabla}_{\tilde{E}_{i}} J\right) \tilde{F}_{j}=-\frac{2}{3 \sqrt{3}} \varepsilon_{i j k}\left(\tilde{E}_{k}-\tilde{F}_{k}\right),  \tag{2.4}\\
\left(\tilde{\nabla}_{\tilde{F}_{i}} J\right) \tilde{E}_{j}=-\frac{2}{3 \sqrt{3}} \varepsilon_{i j k}\left(\tilde{E}_{k}-\tilde{F}_{k}\right), & \left(\tilde{\nabla}_{\tilde{F}_{i}} J\right) \tilde{F}_{j}=-\frac{2}{3 \sqrt{3}} \varepsilon_{i j k}\left(2 \tilde{E}_{k}+\tilde{F}_{k}\right),
\end{array}

we conclude that the $(1,2)$-tensor field $G=\nabla J$ is skew-symmetric and therefore $\mathbb{S}^{3} \times \mathbb{S}^{3}$, equipped with $g$ and $J$, becomes a nearly Kähler manifold. Moreover $G$ satisfies

G(X, J Y)=-J G(X, Y), \quad g(G(X, Y), Z)+g(G(X, Z), Y)=0 \tag{2.5}
\end{equation*}

for any vector fields $X, Y, Z$ tangent to $\mathbb{S}^{3} \times \mathbb{S}^{3}$.
The almost product structure $P$ introduced in [2] is defined as

P Z=\left(p q^{-1} V, q p^{-1} U\right), \quad Z=(U, V) \in T_{(p, q)}\left(\mathbb{S}^{3} \times \mathbb{S}^{3}\right) \tag{2.6}
\end{equation*}

and it has the following properties:

& P J=-J P \quad(P \text { and } J \text { anti-commute }) \\
& g\left(P Z, P Z^{\prime}\right)=g\left(Z, Z^{\prime}\right) \quad(P \text { is compatible with } g), \\
& g\left(P Z, Z^{\prime}\right)=g\left(Z, P Z^{\prime}\right) \quad(P \text { is symmetric }) .
\end{aligned}

Moreover, the almost product structure $P$ can be expressed in terms of the usual product structure $Q Z=Q(U, V)=(-U, V)$ and vice versa:

Q Z=\frac{1}{\sqrt{3}}(2 P J Z-J Z), \quad P Z=\frac{1}{2}(Z-\sqrt{3} Q J Z)
$$

Next, we recall the relation between the Levi-Civita connections $\tilde{\nabla}$ of $g$ and $\nabla^{E}$ of the Euclidean product metric $\langle\cdot, \cdot\rangle$.

Lemma 2.1. 5 The relation between the nearly Kähler connection $\tilde{\nabla}$ and the Euclidean connection $\nabla^{E}$ is

\nabla_{X}^{E} Y=\tilde{\nabla}_{X} Y+\frac{1}{2}(J G(X, P Y)+J G(Y, P X)) \tag{2.7}
\end{equation*}
$$

We also recall here a useful formula from (5), decomposing $D_{X} Y$ along the tangent and the normal directions:

D_{X} Y=\nabla_{X}^{E} Y+\frac{1}{2}\left\langle D_{X} Y,(p, q)\right\rangle(p, q)+\frac{1}{2}\left\langle D_{X} Y,(-p, q)\right\rangle(-p, q), \tag{2.8}
\end{equation*}
$$

where $D$ is the Euclidean connection on $\mathbb{R}^{8}$ and $X, Y$ are tangent vector fields on $\mathbb{S}^{3} \times \mathbb{S}^{3}$.

## 3. Geodesic lines on $\mathbb{S}^{3} \times \mathbb{S}^{3}$

In order to study and classify certain types of submanifolds of $\mathbb{S}^{3} \times \mathbb{S}^{3}$, it is interesting and useful to know how its geodesic lines look like. Since for unitary quaternions $a, b$ and $c$, the map $f: \mathbb{S}^{3} \times \mathbb{S}^{3} \rightarrow \mathbb{S}^{3} \times \mathbb{S}^{3}$ given by $(p, q) \mapsto\left(a p c^{-1}, b q c^{-1}\right)$ preserves the usual metric $\langle\cdot, \cdot\rangle$ and the almost complex structure $J$, it is an isometry of $\left(\mathbb{S}^{3} \times \mathbb{S}^{3}, g\right)$ (cf. [5] and remark after Lemma 2.2 in [13]). Therefore, it is enough to obtain the parametrization of geodesic lines through the point $(1,1)$, as the geodesic lines through the point $(a, b)$ are given by $\tilde{\gamma}(t)=(a x(t), b y(t))$. We prove the following.

Theorem 3.1. The geodesic lines on $\mathbb{S}^{3} \times \mathbb{S}^{3}$ through the point $(1,1)$ have the following parametrization:
(1) $\gamma(t)=(\cos (a t)+\sin (a t) i, \cos (a t)-\sin (a t) i), a \in \mathbb{R} \backslash\{0\}$;
(2) $\gamma(t)=(\cos (a t)+\sin (a t) i, \cos (\widetilde{a} t)+\sin (\widetilde{a} t) i)$, where $c_{1} \in \operatorname{Im} \mathbb{H} \backslash\{0\}, d_{1} \in \mathbb{R}, a=\frac{1+d_{1}}{2}\left\|c_{1}\right\|$, $\widetilde{a}=\frac{1-d_{1}}{2}\left\|c_{1}\right\| ;$
(3)

\begin{aligned}
\gamma(t)= & \left(\left(\frac{1}{1+\varphi^{2}} \cos (A t)+\frac{\varphi^{2}}{1+\varphi^{2}} \cos (B t)\right)+\left(\frac{1}{1+\varphi^{2}} \sin (A t)+\frac{\varphi^{2}}{1+\varphi^{2}} \sin (B t)\right) i+\right. \\
& \left(\frac{\varphi}{1+\varphi^{2}} \sin (A t)-\frac{\varphi}{1+\varphi^{2}} \sin (B t)\right) j-\left(-\frac{\varphi}{1+\varphi^{2}} \cos (A t)+\frac{\varphi}{1+\varphi^{2}} \cos (B t)\right) k, \\
& \left(\frac{1}{1+\widetilde{\varphi}^{2}} \cos (\widetilde{A} t)+\frac{\widetilde{\varphi}^{2}}{1+\widetilde{\varphi}^{2}} \cos (\widetilde{B} t)\right)+\left(\frac{1}{1+\widetilde{\varphi}^{2}} \sin (\widetilde{A} t)+\frac{\widetilde{\varphi}^{2}}{1+\widetilde{\varphi}^{2}} \sin (\widetilde{B} t)\right) i+ \\
& \left.\left(\frac{\widetilde{\varphi}}{1+\widetilde{\varphi}^{2}} \sin (\widetilde{A} t)-\frac{\widetilde{\varphi}}{1+\widetilde{\varphi}^{2}} \sin (\widetilde{B} t)\right) j-\left(-\frac{\widetilde{\varphi}}{1+\widetilde{\varphi}^{2}} \cos (\widetilde{A} t)+\frac{\widetilde{\varphi}}{1+\widetilde{\varphi}^{2}} \cos (\widetilde{B} t)\right) k\right),

where $c_{1}, c_{2} \in \operatorname{Im} \mathbb{H} \backslash\{0\}, d_{1} \in \mathbb{R}, a=\frac{1+d_{1}}{2}\left\|c_{1}\right\|, b=\frac{1}{2}\left\|c_{2}\right\|, c=\frac{2}{3}\left\|c_{1}\right\|, \tilde{a}=\frac{1-d_{1}}{2}\left\|c_{1}\right\|, \tilde{b}=-\frac{1}{2}\left\|c_{2}\right\|$, $\tilde{c}=c$,

\end{array}\right) \frac{\widetilde{c}-2 \widetilde{a}+\sqrt{(\widetilde{c}-2 \widetilde{a})^{2}+\widetilde{b^{2}}}}{2 \widetilde{b}} .

Remark 1. With the substitution $\varphi=\operatorname{tg} \theta, \theta \in \mathbb{R}$, (analogously for $\widetilde{\theta}$ ) $\frac{1}{1+\varphi^{2}}=\cos ^{2} \theta, \frac{\varphi^{2}}{1+\varphi^{2}}=\sin ^{2} \theta$, $\frac{\varphi}{1+\varphi^{2}}=\sin \theta \cos \theta=\frac{1}{2} \sin 2 \theta$, the parametrization in the case (3) becomes

\quad \sin \theta \cos \theta(\sin (A t)-\sin (B t)) j-\sin \theta \cos \theta(-\cos (A t)+\cos (B t)) k \\
\left(\cos ^{2} \widetilde{\theta} \cos (\widetilde{A} t)+\sin ^{2} \widetilde{\theta} \cos (\widetilde{B} t)\right)+\left(\cos ^{2} \widetilde{\theta} \sin (\widetilde{A} t)+\sin ^{2} \widetilde{\theta} \sin (\widetilde{B} t)\right) i+ \\
\sin \tilde{\theta} \cos \widetilde{\theta}(\sin (\widetilde{A} t)-\sin (\widetilde{B} t)) j-\sin \widetilde{\theta} \cos \widetilde{\theta}(-\cos (\widetilde{A} t)+\cos (\widetilde{B} t)) k)

Proof. Our proof starts with the observation that if $\gamma(t)=(x(t), y(t))$ is a geodesic line on $\mathbb{S}^{3} \times \mathbb{S}^{3}$, then there exist functions $\alpha, \beta: \mathbb{R} \rightarrow \operatorname{Im} \mathbb{H}$ such that

\begin{equation*}
\gamma^{\prime}(t)=\left(x^{\prime}(t), y^{\prime}(t)\right)=(x(t) \alpha(t), y(t) \beta(t)) \tag{3.1}
\end{equation*}
$$

Namely, it is well-known that for $v \in T_{p} \mathbb{S}^{3}$ there exists $\tilde{v} \in \operatorname{Im} \mathbb{H}$ such that $v=p \tilde{v}$.
For more convenience, we will sometimes omit the argument $t$ for the functions $x, y, \alpha, \beta, \gamma$ and their derivatives. From (3.1) it follows

\gamma^{\prime \prime}=\left(x \alpha \cdot \alpha+x \alpha^{\prime}, y \beta \cdot \beta+y \beta^{\prime}\right) \tag{3.2}
\end{equation*}
$$

Recall that for imaginary quaternions $\alpha_{1}, \alpha_{2}$ one has $\alpha_{1} \cdot \alpha_{2}=-<\alpha_{1}, \alpha_{2}>+\alpha_{1} \times \alpha_{2}$. Thus, $\alpha \cdot \alpha=-\|\alpha\|^{2}$ and we may write

\gamma^{\prime \prime} & =\left(x\left(\alpha^{\prime}-\|\alpha\|^{2}\right), y\left(\beta^{\prime}-\|\beta\|^{2}\right)\right) \\
& =\left(x \alpha^{\prime}, y \beta^{\prime}\right)-\|\alpha\|^{2}(x, 0)-\|\beta\|^{2}(0, y)
\end{aligned}
$$

Identifying the tangent and normal parts in the previous relation, using (2.8), it follows

\nabla_{\gamma^{\prime}}^{E} \gamma^{\prime}=\left(x \alpha^{\prime}, y \beta^{\prime}\right) \tag{3.3}
\end{equation*}
$$

and Lemma 2.1 yields

$$

\nabla_{\gamma^{\prime}}^{E} \gamma^{\prime}=\tilde{\nabla}_{\gamma^{\prime}} \gamma^{\prime}+J G\left(\gamma^{\prime}, P \gamma^{\prime}\right) \tag{3.4}
\end{equation*}
$$

An easy computation establishes the additional formula which allows us to evaluate $G$ for any tangent vector fields:

G(X, Y)=\frac{2}{3 \sqrt{3}}(p(\beta \times \gamma+\alpha \times \delta+\alpha \times \gamma-2 \beta \times \delta), q(-\alpha \times \delta-\beta \times \gamma+2 \alpha \times \gamma-\beta \times \delta)) \tag{3.5}
\end{equation*}
$$

for $X=(p \alpha, q \beta), Y=(p \gamma, q \delta) \in T_{(p, q)} \mathbb{S}^{3} \times \mathbb{S}^{3}, \alpha, \beta, \gamma, \delta \in \operatorname{Im} \mathbb{H}$. As $\gamma^{\prime}=(x \alpha, y \beta), P \gamma^{\prime}=(x \beta, y \alpha)$, relation (3.5) implies $G\left(\gamma^{\prime}, P \gamma^{\prime}\right)=\frac{2}{\sqrt{3}}(x(\alpha \times \beta), y(\alpha \times \beta))$, which then gives

J G\left(\gamma^{\prime}, P \gamma^{\prime}\right)=\frac{2}{3}(x(\alpha \times \beta),-y(\alpha \times \beta)) \tag{3.6}
\end{equation*}
$$

Finally, as $\gamma$ is a geodesic, using (3.4) and (3.6), we compute

\alpha^{\prime}(t)=\frac{2}{3} \alpha(t) \times \beta(t), \quad \beta^{\prime}(t)=-\frac{2}{3} \alpha(t) \times \beta(t) \tag{3.7}
\end{equation*}
$$

From (3.7) it follows $(\alpha(t)+\beta(t))^{\prime}=0$ and therefore there exists $c_{1} \in \operatorname{Im} \mathbb{H}$ such that

\alpha(t)+\beta(t)=c_{1} \tag{3.8}
\end{equation*}
$$

Using (3.7) and (3.8) it follows

$$
\begin{equation*}
(\alpha(t)-\beta(t))^{\prime}=-\frac{2}{3} c_{1} \times(\alpha(t)-\beta(t)) \tag{3.9}
\end{equation*}
$$

If $c_{1}=0$, using (3.8) and (3.9), then $\alpha$ and $\beta$ are constants. Without loss of generality, we can assume that they are imaginary quaternions collinear with $i$ :

\alpha=-\beta=a i, \quad a \in \mathbb{R} \backslash\{0\} \tag{3.10}
\end{equation*}
$$

If $c_{1} \neq 0$, since $<\alpha(t)-\beta(t), c_{1}>=<\alpha(t)-\beta(t), \alpha(t)+\beta(t)>$ and $c_{1}$ is a constant vector, we have $<\alpha(t)-\beta(t), c_{1}>^{\prime}=<-\frac{2}{3} c_{1} \times(\alpha(t)-\beta(t)), c_{1}>=0$, namely, $<\alpha(t)-\beta(t), c_{1}>=\tilde{d}_{1} \in \mathbb{R}$. Let us denote by $\varepsilon$ the part of $\alpha-\beta$ which is orthogonal to $c_{1}$ :

\varepsilon(t)=\alpha(t)-\beta(t)-\frac{<\alpha(t)-\beta(t), c_{1}>}{\left\|c_{1}\right\|^{2}} c_{1} \tag{3.11}

and compute

\varepsilon^{\prime}(t) & =-\frac{2}{3} c_{1} \times \varepsilon(t)  \tag{3.12}\\
\varepsilon^{\prime \prime}(t) & =-\frac{4}{9}\left\|c_{1}\right\|^{2} c_{1} \varepsilon(t) \tag{3.13}
\end{align*}
$$

Solving (3.13) gives

$$
\begin{equation*}
\varepsilon(t)=\cos \left(\frac{2}{3}\left\|c_{1}\right\| t\right) c_{2}+\sin \left(\frac{2}{3}\left\|c_{1}\right\| t\right) c_{3} \tag{3.14}
\end{equation*}
$$

for $c_{2}, c_{3} \in \operatorname{Im} \mathbb{H}, c_{2}, c_{3} \perp c_{1}$. Having in mind (3.12), we conclude that

$$
\left\|c_{1}\right\| c_{2}=c_{1} \times c_{3}, \quad\left\|c_{1}\right\| c_{3}=-c_{1} \times c_{2}
$$

Therefore

$$
\begin{equation*}
c_{3}=-\frac{c_{1}}{\left\|c_{1}\right\|} \times c_{2} \tag{3.15}
\end{equation*}
$$

and, consequently, $c_{3} \perp c_{1}, c_{2}$.
For $c_{2}=0$ it follows that $c_{3}=0, \varepsilon=0, \alpha-\beta=d_{1} c_{1}\left(d_{1}=\frac{\tilde{d}_{1}}{\left\|c_{1}\right\|^{2}}\right), \alpha+\beta=c_{1}$ and therefore

$$
\alpha=\frac{1+d_{1}}{2} c_{1}, \quad \beta=\frac{1-d_{1}}{2} c_{1} .
$$

We can assume that $c_{1}$ is collinear with $i$ and get

$$
\begin{equation*}
\alpha=a i, \quad \beta=\tilde{a} i, \tag{3.16}
\end{equation*}
$$

where $a=\frac{1+d_{1}}{2}\left\|c_{1}\right\|, \tilde{a}=\frac{1-d_{1}}{2}\left\|c_{1}\right\|$.
For $c_{2} \neq 0$, the vectors $\frac{c_{1}}{\left\|c_{1}\right\|}, \frac{c_{2}}{\left\|c_{2}\right\|},-\frac{c_{3}}{\left\|c_{3}\right\|}$ form an orthonormal basis of $\operatorname{Im} \mathbb{H}$. Since it is always possible to find a unit quaternion $h \in \mathbb{S}^{3}$ such that

$$
h^{-1} \frac{c_{1}}{\left\|c_{1}\right\|} h=i, \quad h^{-1} \frac{c_{2}}{\left\|c_{2}\right\|} h=j, \quad h^{-1} \frac{c_{3}}{\left\|c_{3}\right\|} h=-k
$$

we may assume to be working with the basis $\{i, j,-k\}$. Using (3.11) and (3.14) we obtain

$$
\begin{equation*}
\alpha(t)+\beta(t)=c_{1}=\left\|c_{1}\right\| h i h^{-1} \tag{3.17}
\end{equation*}
$$

$$
\alpha(t)-\beta(t)=d_{1}\left\|c_{1}\right\| h i h^{-1}+\left\|c_{2}\right\| \cos \left(\frac{2}{3}\left\|c_{1}\right\| t\right) h j h^{-1}-\left\|c_{2}\right\| \sin \left(\frac{2}{3}\left\|c_{1}\right\| t\right) h k h^{-1}
$$

Since $\left\|c_{3}\right\|=\left\|c_{2}\right\|$ from (3.15) and $d_{1}=\frac{\tilde{d}_{1}}{\left\|c_{1}\right\|^{2}} \in \mathbb{R}$, it gives

$$
\begin{align*}
\alpha(t) & =\frac{1+d_{1}}{2}\left\|c_{1}\right\| h i h^{-1}+\frac{1}{2}\left\|c_{2}\right\| \cos \left(\frac{2}{3}\left\|c_{1}\right\| t\right) h j h^{-1} \\
& -\frac{1}{2}\left\|c_{2}\right\| \sin \left(\frac{2}{3}\left\|c_{1}\right\| t\right) h k h^{-1}  \tag{3.19}\\
\beta(t) & =\frac{1-d_{1}}{2}\left\|c_{1}\right\| h i h^{-1}-\frac{1}{2}\left\|c_{2}\right\| \cos \left(\frac{2}{3}\left\|c_{1}\right\| t\right) h j h^{-1} \\
& +\frac{1}{2}\left\|c_{2}\right\| \sin \left(\frac{2}{3}\left\|c_{1}\right\| t\right) h k h^{-1}
\end{align*}
$$

where $h \in \mathbb{S}^{3}, c_{1}, c_{2} \in \operatorname{Im} \mathbb{H} \backslash\{0\}, d_{1} \in \mathbb{R}$.

Remark 2. Notice that we had the freedom to make a rotation of the basis, in the following sense. The map $(x, y) \rightarrow\left(h x h^{-1}, h y h^{-1}\right)$ is an isometry (rotation) of $\mathbb{S}^{3} \times \mathbb{S}^{3}$ and if $(1,1) \in \gamma=(x, y)$ then also $(1,1) \in \tilde{\gamma}=(\tilde{x}, \tilde{y})=\left(h x h^{-1}, h y h^{-1}\right)$. Moreover, $\tilde{\gamma}$ stays tangent to $\mathbb{S}^{3} \times \mathbb{S}^{3}$ since, for $\alpha$, $\beta: \mathbb{R} \rightarrow \operatorname{Im} \mathbb{H}$ and using (3.1), we have

$$
\begin{align*}
\tilde{\gamma}^{\prime} & =\left(h x^{\prime} h^{-1}, h y^{\prime} h^{-1}\right)=\left(h x \alpha h^{-1}, h y \beta h^{-1}\right)  \tag{3.20}\\
& =\left(h x h^{-1} h \alpha h^{-1}, h y h^{-1} h \beta h^{-1}\right)=(\tilde{x} \tilde{\alpha}, \tilde{y} \tilde{\beta})
\end{align*}
$$

for $\tilde{\alpha}=h \alpha h^{-1}, \tilde{\beta}=h \beta h^{-1}, \tilde{\alpha}, \tilde{\beta}: \mathbb{R} \rightarrow \operatorname{Im} \mathbb{H}$. Therefore, it is enough to solve

$$
\begin{equation*}
\left(x^{\prime}(t), y^{\prime}(t)\right)=(x(t) \alpha(t), y(t) \beta(t)) \tag{3.21}
\end{equation*}
$$

for

$$
\begin{align*}
\alpha(t) & =\frac{1+d_{1}}{2}\left\|c_{1}\right\| i+\frac{1}{2}\left\|c_{2}\right\| \cos \left(\frac{2}{3}\left\|c_{1}\right\| t\right) j-\frac{1}{2}\left\|c_{2}\right\| \sin \left(\frac{2}{3}\left\|c_{1}\right\| t\right) k  \tag{3.22}\\
\beta(t) & =\frac{1-d_{1}}{2}\left\|c_{1}\right\| i-\frac{1}{2}\left\|c_{2}\right\| \cos \left(\frac{2}{3}\left\|c_{1}\right\| t\right) j+\frac{1}{2}\left\|c_{2}\right\| \sin \left(\frac{2}{3}\left\|c_{1}\right\| t\right) k
\end{align*}
$$

In all the cases considered, we have to solve the system of differential equations

$$
\begin{align*}
\alpha(t) & =a i+b \cos (c t) j-b \sin (c t) k \\
\beta(t) & =\tilde{a} i+\tilde{b} \cos (\tilde{c} t) j-\tilde{b} \sin (\tilde{c} t) k \tag{3.23}
\end{align*}
$$

which reduces to solving an equation of the form

$$
\begin{equation*}
f^{\prime}(t)=f(t)(a i+b j \cos (c t)-b k \sin (c t)) \tag{3.24}
\end{equation*}
$$

with the following constants:
(1) if $c_{1}=0$, then $\tilde{a}=-a \neq 0, b=\tilde{b}=c=\tilde{c}=0$;
(2) if $c_{1} \neq 0, c_{2}=0$, then $a=\frac{1+d_{1}}{2}\left\|c_{1}\right\|, \tilde{a}=\frac{1-d_{1}}{2}\left\|c_{1}\right\|, b=\tilde{b}=c=\tilde{c}=0$;
(3) if $c_{1} \neq 0, c_{2} \neq 0$, then $a=\frac{1+d_{1}}{2}\left\|c_{1}\right\|, b=\frac{1}{2}\left\|c_{2}\right\|, c=\frac{2}{3}\left\|c_{1}\right\|, \tilde{a}=\frac{1-d_{1}}{2}\left\|c_{1}\right\|, \tilde{b}=-\frac{1}{2}\left\|c_{2}\right\|$, $\tilde{c}=c$.
Cases (1) and (2) lead to the same differential equation of the form $f^{\prime}(t)=f(t) \cdot a i$, which has an obvious solution which satisfies $f(0)=1$ :

$$
f(t)=\cos (a t)+i \sin (a t)
$$

The geodesics in these two cases have the parametrization

$$
\gamma(t)=(\cos (a t)+\sin (a t) i, \cos (\tilde{a} t)+\sin (\tilde{a} t) i)
$$

where in case (1) we put $\tilde{a}=-a \neq 0$ (so $a+\tilde{a}=0$ ), and in case (2) $a+\tilde{a}=\left\|c_{1}\right\| \neq 0$. In the third case, we write explicitly

$$
f(t)=f_{1}(t)+i f_{2}(t)+j f_{3}(t)+k f_{4}(t)=: g_{1}(t)+j g_{2}(t)
$$

for $f_{l}$ real functions, where $l=\overline{1,4}$. Then the equation (3.24) becomes

$$
g_{1}^{\prime}+j g_{2}^{\prime}=\left(g_{1}+j g_{2}\right)\left(a i+b j e^{i c t}\right)
$$

and we get the following system of differential equations

$$
\begin{align*}
& g_{1}^{\prime}(t)=g_{1} a i-\overline{g_{2}} b e^{i c t} \\
& g_{2}^{\prime}(t)=g_{2} a i+\overline{g_{1}} b e^{i c t} \tag{3.25}
\end{align*}
$$

When we differentiate one of these equations and combine it with the other, we get the second order linear equations

$$
\begin{align*}
& g_{1}^{\prime \prime}-c i g_{1}^{\prime}+\left(a^{2}+b^{2}-a c\right) g_{1}=0 \\
& g_{2}^{\prime \prime}-c i g_{2}^{\prime}+\left(a^{2}+b^{2}-a c\right) g_{2}=0 \tag{3.26}
\end{align*}
$$

The characteristic equation is

$$
\begin{equation*}
\lambda^{2}-c i \lambda+\left(a^{2}+b^{2}-a c\right)=0 \tag{3.27}
\end{equation*}
$$

which has the solutions $\lambda_{1}=A i, \lambda_{2}=B i$, where

$$
\begin{equation*}
A=\frac{c+\sqrt{(2 a-c)^{2}+4 b^{2}}}{2}, \quad B=\frac{c-\sqrt{(2 a-c)^{2}+4 b^{2}}}{2} \tag{3.28}
\end{equation*}
$$

We then find the general solutions for (3.26) as

$$
\begin{align*}
& g_{1}(t)=\left(\mu_{1}+i \mu_{2}\right) e^{i A t}+\left(\nu_{1}+i \nu_{2}\right) e^{i B t}, \\
& g_{2}(t)=\left(\eta_{1}+i \eta_{2}\right) e^{i A t}+\left(\xi_{1}+i \xi_{2}\right) e^{i B t} \tag{3.29}
\end{align*}
$$

where $\mu_{l}, \nu_{l}, \eta_{l}, \xi_{l} \in \mathbb{R}, l=1,2$. Since $A \neq B$, the functions $\sin (A t), \cos (A t), \sin (B t), \cos (B t)$ are linearly independent. After substitution of (3.29) in (3.25) we get that the following hold

$$
\begin{aligned}
&(A-a) \mu_{1}=b \xi_{2}, \quad(B-a) \nu_{1}=b \eta_{2} \\
&(A-a) \mu_{2}=b \xi_{1}, \\
&(A-a) \eta_{1}=-b \nu_{2}, \\
&(A-a) \nu_{2}=b \eta_{1} \\
&(B-a) \xi_{1}=-b \mu_{2} \\
&=-b \nu_{1},(B-a) \xi_{2}=-b \mu_{1}
\end{aligned}
$$

Since

$$
\frac{A-a}{b}=\frac{-b}{B-a}=\frac{c-2 a+\sqrt{(c-2 a)^{2}+4 b^{2}}}{2 b}:=\varphi
$$

we get four relations among coefficients

$$
\begin{equation*}
\varphi=\frac{\xi_{2}}{\mu_{1}}=\frac{\xi_{1}}{\mu_{2}}=-\frac{\nu_{1}}{\eta_{2}}=-\frac{\nu_{2}}{\eta_{1}} \tag{3.30}
\end{equation*}
$$

Case $b=0$ leads to $c_{2}=0$, which has already been taken into consideration.
Hence, the solution for the function $f$ is

$$
\begin{align*}
f(t)= & \left(\mu_{1} \cos (A t)-\mu_{2} \sin (A t)-\varphi \eta_{2} \cos (B t)+\varphi \eta_{1} \sin (B t)\right)+  \tag{3.31}\\
& \left(\mu_{2} \cos (A t)+\mu_{1} \sin (A t)-\varphi \eta_{1} \cos (B t)-\varphi \eta_{2} \sin (B t)\right) i+ \\
& \left(\eta_{1} \cos (A t)-\eta_{2} \sin (A t)+\varphi \mu_{2} \cos (B t)-\varphi \mu_{1} \sin (B t)\right) j- \\
& \left(\eta_{2} \cos (A t)+\eta_{1} \sin (A t)+\varphi \mu_{1} \cos (B t)+\varphi \mu_{2} \sin (B t)\right) k
\end{align*}
$$

Since $f(t)$ is a curve on the sphere $\mathbb{S}^{3}$ through the point 1 , we get the following relations

$$
\mu_{2}=\eta_{1}=0, \quad \mu_{1}=\frac{1}{1+\varphi^{2}}, \quad \eta_{2}=\frac{-\varphi}{1+\varphi^{2}}
$$

Finally, the solution of the equation is

$$
\begin{gathered}
f(t)=\left(\frac{1}{1+\varphi^{2}} \cos (A t)+\frac{\varphi^{2}}{1+\varphi^{2}} \cos (B t)\right)+\left(\frac{1}{1+\varphi^{2}} \sin (A t)+\frac{\varphi^{2}}{1+\varphi^{2}} \sin (B t)\right) i+ \\
\left(\frac{\varphi}{1+\varphi^{2}} \sin (A t)-\frac{\varphi}{1+\varphi^{2}} \sin (B t)\right) j-\left(-\frac{\varphi}{1+\varphi^{2}} \cos (A t)+\frac{\varphi}{1+\varphi^{2}} \cos (B t)\right) k
\end{gathered}
$$

Let us notice that this is indeed a curve on $\mathbb{S}^{3}$ since $\mu_{1}^{2}+\mu_{2}^{2}+\eta_{1}^{2}+\eta_{2}^{2}=\frac{1}{1+\varphi^{2}}=\cos ^{2} \theta$. We get the parametrization (3.1) of the geodesics when we substitute (3.31), with the proper constants $A, B, \tilde{A}, \tilde{B}$ into $\gamma(t)=(x(t), y(t))$.

Proposition 3.1. (1) The geodesic lines on $\mathbb{S}^{3} \times \mathbb{S}^{3}$ with respect to nearly Kähler metric coincide with geodesic lines with respect to usual Euclidean product metric if and only if $c_{1}=0$ or $c_{2}=0$.
(2) - The tangent vector of the geodesic line is the eigenvector of the product structure $P$ with eigenvalue -1 if and only if $c_{1}=0$.

- The tangent vector of the geodesic line is the eigenvector of the product structure $P$ with eigenvalue 1 if and only if $c_{1} \neq 0, c_{2}=0, d_{1}=0$.
(3) The geodesic line on $\mathbb{S}^{3} \times \mathbb{S}^{3}$ is closed if and only if it has the parametrization from the case Theorem 3.1 (1), or the fractions $\frac{a}{\tilde{a}}, \frac{B}{A}$ and $\frac{\tilde{B}}{\tilde{A}}$ are rational numbers in the cases (2) and (3) of Theorem 3.1 respectively.
Proof. (1) From relation (3.3) it is evident that $\nabla_{\gamma^{\prime}}^{E} \gamma^{\prime}=0$ is equivalent to $\alpha^{\prime}=\beta^{\prime}=0$, namely $\alpha=\beta=\mathrm{const}$. We have already seen that this is true if and only if $c_{1}=0$ or $c_{2}=0$.
(2) As $\gamma^{\prime}=(x \alpha, y \beta), P \gamma^{\prime}=(x \beta, y \alpha)$, condition $P \gamma^{\prime}= \pm \gamma^{\prime}$ reduces to $\alpha= \pm \beta$ and the conclusion follows from (3.10) and (3.16).
(3) It is apparent that $\gamma(t)$ is a periodic function in the case Theorem 3.1 (1). Also, in the case Theorem 3.1 (2) both coordinate functions of $\gamma(t)$ are periodic with the same period if and only if the fraction $\frac{a}{\tilde{a}}$ is a rational number (if one of the constants $a, \tilde{a}$ is 0 , then this condition stands for the second one which is nonzero). In the case Theorem 3.1 (3) the first coordinate function of $\gamma(t)$ is periodic if and only if the functions $\sin (A t), \cos (A t)$, $\sin (B t), \cos (B t)$ are periodic with the same period, which is again true if and only if the fraction $\frac{B}{A}$ is a rational number (if one of the constants $A, B$ is 0 , then this condition stands for the second one which is nonzero). A similar conclusion is valid for the second coordinate function.

Remark 3. Using the formula (2.3) we can calculate the length of the tangent vector

$$
\left\|\gamma^{\prime}\right\|=\sqrt{g\left(\gamma^{\prime}, \gamma^{\prime}\right)}=\sqrt{\left(\frac{1}{3}+d_{1}^{2}\right)\left\|c_{1}\right\|^{2}+\left\|c_{2}\right\|^{2}}
$$

Since this is constant, it is easy to get the arclength parametrization where $\gamma^{\prime}$ is a unit length vector field along the geodesics, only with the change of parameter $s=t \sqrt{\left(\frac{1}{3}+d_{1}^{2}\right)\left\|c_{1}\right\|^{2}+\left\|c_{2}\right\|^{2}}$.
