# LEFT ORDERABLE SURGERIES OF DOUBLE TWIST KNOTS

#### Abstract

A rational number $r$ is called a left orderable slope of a knot $K \subset S^{3}$ if the 3-manifold obtained from $S^{3}$ by $r$-surgery along $K$ has left orderable fundamental group. In this paper we consider the double twist knots $C(k, l)$ in the Conway notation. For any positive integers $m$ and $n$, we show that if $K$ is a double twist knot of the form $C(2 m,-2 n), C(2 m+1,2 n)$ or $C(2 m+1,-2 n)$ then there is an explicit unbounded interval $I$ such that any rational number $r \in I$ is a left orderable slope of $K$.


## 1. Introduction

The motivation of this paper is the L-space conjecture of Boyer, Gordon and Watson [BGW] which states that an irreducible rational homology 3 -sphere is an L-space if and only if its fundamental group is not left orderable. Here a rational homology 3 -sphere $Y$ is an L-space if its Heegaard Floer homology $\widehat{\mathrm{HF}}(Y)$ has rank equal to the order of $H_{1}(Y ; \mathbb{Z})$, and a non-trivial group $G$ is left orderable if it admits a total ordering $<$ such that $g<h$ implies $f g<f h$ for all elements $f, g, h$ in $G$. A knot $K$ in $S^{3}$ is called an L-space knot if it admits a positive Dehn surgery yielding an L-space. It is known that non-torus alternating knots are not L-space knots, see OS. In view of the L-space conjecture, this would imply that any non-trivial Dehn surgery along a non-torus alternating knot produces a 3-manifold with left orderable fundamental group.

A rational number $r$ is called a left orderable slope of a knot $K \subset S^{3}$ if the 3-manifold obtained from $S^{3}$ by $r$-surgery along $K$ has left orderable fundamental group. As mentioned above, one would expect that any rational number is a left orderable slope of any non-torus alternating knot. It is known that any rational number $r \in(-4,4)$ is a left orderable slope of the figure eight knot, and any rational number $r \in[0,4]$ is a left orderable slope of the hyperbolic twist knot $5_{2}$, see [BGW] and [HTe2] respectively. Consider the double twist knot $C(k, l)$ in the Conway notation as in Figure 1, where $k, l$ denote the numbers of horizontal half-twists with sign in the boxes. Here the sign of $\backslash$ is positive in the box $k$ and is negative in the box $l$. Then the following results were shown in [ $\mathrm{HTe} 1, \mathrm{Tr}]$ by using continuous families of hyperbolic $\mathrm{SL}_{2}(\mathbb{R})$-representations of knot groups. If $m, n$ are integers $\geq 1$, any rational number $r \in(-4 n, 4 m)$ is a left orderable slope of $C(2 m, 2 n)$. If $m, n$ are integers $\geq 2$ then any rational number $r \in[0, \max \{4 m, 4 n\})$ is a left orderable slope of $C(2 m,-2 n)$ and any rational number $r \in[0,4]$ is a left orderable slope of both

[^0]$C(2 m,-2)$ and $C(2,-2 n)$. Note that $C(2,2)$ is the figure eight knot and $C(4,-2)$ is the twist knot $5_{2}$. Moreover $C(2,-2)$ is the trefoil knot, which is the $(2,3)$-torus knot.


Figure 1. The double twist knot/link $C(k, l)$ in the Conway notation.

In this paper, by using continuous families of elliptic $\mathrm{SL}_{2}(\mathbb{R})$-representations of knot groups we extend the range of left orderable slopes of $C(2 m,-2 n)$. Moreover, we also give left orderable slopes of $C(2 m+1, \pm 2 n)$.

Theorem 1. Suppose $K$ is a double twist knot of the form $C(2 m,-2 n), C(2 m+1,2 n)$ or $C(2 m+1,-2 n)$ in the Conway notation for some positive integers $m$ and $n$. Let

$$
\mathrm{LO}_{K}= \begin{cases}(-\infty, 1) & \text { if } K=C(2 m,-2 n) \\ (-\infty, 2 n-1) & \text { if } K=C(2 m+1,2 n) \\ (3-2 n, \infty) & \text { if } K=C(2 m+1,-2 n) \text { and } n \geq 2\end{cases}
$$

Then any rational number $r \in \mathrm{LO}_{K}$ is a left orderable slope of $K$.
Combining this with results in $\mathrm{HTe} 1, \mathrm{Tr}$, we conclude that if $m$ and $n$ are integers $\geq 2$ then any rational number $r \in(-\infty, \max \{4 m, 4 n\})$ is a left orderable slope of $C(2 m,-2 n)$ and any rational number $r \in(-\infty, 4]$ is a left orderable slope of both $C(2 m,-2)$ and $C(2,-2 n)$. In the subsequent paper KTT we will use continuous families of hyperbolic $\mathrm{SL}_{2}(\mathbb{R})$-representations of knot groups to extend the range of left orderable slopes of $C(2 m+1,-2 n)$. More specifically, we will show that any rational number $r \in(-4 n, 4 m)$ is a left orderable slope of $C(2 m+1,-2 n)$ detected by hyperbolic $\mathrm{SL}_{2}(\mathbb{R})$-representations of the knot group.

We remark that in the case of $C(2 m+1, \pm 2 n)$, where $m$ and $n$ are positive integers, Gao Ga independently obtains similar results. She proves a weaker result that any rational number $r \in(-\infty, 1)$ is a left orderable slope of $C(2 m+1,2 n)$ and a stronger result that any rational number $r \in(-4 n, \infty)$ is a left orderable slope of $C(2 m+1,-2 n)$.

As in BGW, HTe1, $\mathrm{HTe} 2, \mathrm{Tr}, \mathrm{CD}$ the proof of Theorem 1 is based on the existence of continuous families of elliptic $\mathrm{SL}_{2}(\mathbb{R})$-representations of the knot groups of double twist knots $C(2 m,-2 n)$ and $C(2 m+1, \pm 2 n)$ into $\mathrm{SL}_{2}(\mathbb{R})$ and the fact that $\widehat{\mathrm{SL}_{2}(\mathbb{R}) \text {, which is }}$ the universal covering group of $\mathrm{SL}_{2}(\mathbb{R})$, is a left orderable group.

This paper is organized as follows. In Section 1, we study certain real roots of the Riley polynomial of double twist knots $C(k,-2 p)$, whose zero locus describes all non-abelian representations of the knot group into $\mathrm{SL}_{2}(\mathbb{C})$. In Section 2, we prove Theorem $\mathbf{1}$.

## 2. Real roots of the Riley polynomial

For a knot $K$ in $S^{3}$, let $G(K)$ denote the knot group of $K$ which is the fundamental group of the complement of an open tubular neighborhood of $K$.

Consider the double twist knot/link $C(k, l)$ in the Conway notation as in Figure 1, where $k, l$ are integers such that $|k l| \geq 3$. Note that $C(k, l)$ is the rational knot/link corresponding to continued fraction $k+1 / l$. It is easy to see that $C(k, l)$ is the mirror image of $C(l, k)=C(-k,-l)$. Moreover, $C(k, l)$ is a knot if $k l$ is even and is a twocomponent link if $k l$ is odd. In this paper, we only consider knots and so we can assume that $k>0$ and $l=-2 p$ is even.

Note that $C(k,-2 p)$ is the mirror image of the double twist knot $J(k, 2 p)$ in HS. Then, by [HS], the knot group of $C(k,-2 p)$ has a presentation

$$
G(C(k,-2 p))=\left\langle a, b \mid a w^{p}=w^{p} b\right\rangle
$$

where $a, b$ are meridians and

$$
w= \begin{cases}\left(a b^{-1}\right)^{m}\left(a^{-1} b\right)^{m} & \text { if } k=2 m \\ \left(a b^{-1}\right)^{m} a b\left(a^{-1} b\right)^{m} & \text { if } k=2 m+1\end{cases}
$$

Moreover, the canonical longitude of $C(k,-2 p)$ corresponding to the meridian $\mu=a$ is $\lambda=\left(w^{p}\left(w^{p}\right)^{*} a^{-2 \varepsilon}\right)^{-1}$, where $\varepsilon=0$ if $k=2 m$ and $\varepsilon=2 p$ if $k=2 m+1$. Here, for a word $u$ in the letters $a, b$ we let $u^{*}$ be the word obtained by reading $v$ backwards.

Suppose $\rho: G(C(k,-2 p)) \rightarrow \mathrm{SL}_{2}(\mathbb{C})$ is a nonabelian representation. Up to conjugation, we may assume that

$$
\rho(a)=\left[\begin{array}{cc}
M & 1  \tag{2.1}\\
0 & M^{-1}
\end{array}\right] \quad \text { and } \quad \rho(b)=\left[\begin{array}{cc}
M & 0 \\
2-y & M^{-1}
\end{array}\right]
$$

where $(M, y) \in \mathbb{C}^{2}$ satisfies the matrix equation $\rho\left(a w^{p}\right)=\rho\left(w^{p} b\right)$. It is known that this matrix equation is equivalent to a single polynomial equation $R_{C(k,-2 p)}(x, y)=0$, where $x=(\operatorname{tr} \rho(a))^{2}$ and $R_{K}(x, y)$ is the Riley polynomial of $K$, see Ri]. This polynomial can be described via the Chebychev polynomials as follows.

Let $\left\{S_{j}(v)\right\}_{j \in \mathbb{Z}}$ be the Chebychev polynomials in the variable $v$ defined by $S_{0}(v)=1$, $S_{1}(v)=v$ and $S_{j}(v)=v S_{j-1}(v)-S_{j-2}(v)$ for all integers $j$. Note that $S_{j}(v)=-S_{-j-2}(v)$ and $S_{j}( \pm 2)=( \pm 1)^{j}(j+1)$. Moreover, we have $S_{j}(v)=\left(s^{j+1}-s^{-(j+1)}\right) /\left(s-s^{-1}\right)$ for $v=s+s^{-1} \neq \pm 2$. Using this identity one can prove the following.

Lemma 2.1. For any integer $j$ and any positive integer $n$ we have
(1) $S_{j}^{2}(v)-v S_{j}(v) S_{j-1}(v)+S_{j-1}^{2}(v)=1$.
(2) $S_{n}(v)-S_{n-1}(v)=\prod_{j=1}^{n}\left(v-2 \cos \frac{(2 j-1) \pi}{2 n+1}\right)$.
(3) $S_{n}(v)+S_{n-1}(v)=\prod_{j=1}^{n}\left(v-2 \cos \frac{2 j \pi}{2 n+1}\right)$.
(4) $S_{n}(v)=\prod_{j=1}^{n}\left(v-2 \cos \frac{j \pi}{n+1}\right)$.

The Riley polynomial of $C(k,-2 p)$, whose zero locus describes all non-abelian representations of the knot group of $C(k,-2 p)$ into $\mathrm{SL}_{2}(\mathbb{C})$, is

$$
R_{C(k,-2 p)}(x, y)=S_{p}(t)-z S_{p-1}(t)
$$

where

$$
t=\operatorname{tr} \rho(w)= \begin{cases}2+(y+2-x)(y-2) S_{m-1}^{2}(y) & \text { if } k=2 m \\ 2-(y+2-x)\left(S_{m}(y)-S_{m-1}(y)\right)^{2} & \text { if } k=2 m+1\end{cases}
$$

and

$$
z= \begin{cases}1+(y+2-x) S_{m-1}(y)\left(S_{m}(y)-S_{m-1}(y)\right) & \text { if } k=2 m \\ 1-(y+2-x) S_{m}(y)\left(S_{m}(y)-S_{m-1}(y)\right) & \text { if } k=2 m+1\end{cases}
$$

Moreover, for the representation $\rho: G(C(k,-2 p)) \rightarrow \mathrm{SL}_{2}(\mathbb{C})$ of the form (2.1) the image of the canonical longitude $\lambda=\left(w^{p}\left(w^{p}\right)^{*} a^{-2 \varepsilon}\right)^{-1}$ has the form $\rho(\lambda)=\left[\begin{array}{cc}L & * \\ 0 & L^{-1}\end{array}\right]$, where

$$
L=-\frac{M^{-1}\left(S_{m}(y)-S_{m-1}(y)\right)-M\left(S_{m-1}(y)-S_{m-2}(y)\right)}{M\left(S_{m}(y)-S_{m-1}(y)\right)-M^{-1}\left(S_{m-1}(y)-S_{m-2}(y)\right)} \quad \text { if } k=2 m
$$

and

$$
L=-M^{4 p} \frac{M^{-1} S_{m}(y)-M S_{m-1}(y)}{M S_{m}(y)-M^{-1} S_{m-1}(y)} \quad \text { if } k=2 m+1
$$

See e.g. [Tr, Pe].
Lemmas (2.2)-(2.4) below describe continuous families of real roots of the Riley polynomials of the double twist knots $C(2 m,-2 n), C(2 m+1,2 n)$ and $C(2 m+1,-2 n)$ respectively, where $m$ and $n$ are positive integers.

Lemma 2.2. There exists a continuous real function $y:[4-1 /(m n), 4] \rightarrow[2, \infty)$ in the variable $x$ such that

- $y(4-1 /(m n))=2$ and
- $R_{C(2 m,-2 n)}(x, y(x))=0$ for all $x \in[4-1 /(m n), 4]$.

Proof. Let $K=C(2 m,-2 n)$. We have $R_{K}(x, y)=S_{n}(t)-z S_{n-1}(t)$ where

$$
\begin{aligned}
t & =2+(y+2-x)(y-2) S_{m-1}^{2}(y) \\
z & =1+(y+2-x) S_{m-1}(y)\left(S_{m}(y)-S_{m-1}(y)\right)
\end{aligned}
$$

Consider real numbers $x \in[4-1 /(m n), 4]$ and $y \in[2, \infty)$. Since $y \geq 2 \geq x-2$, we have $t \geq 2$ and $z \geq 1$. This implies that $z S_{n-1}(t)-S_{n-2}(t) \geq S_{n-1}(t)-S_{n-2}(t)>0$, by Lemma 2.1. The equation $R_{K}(x, y)=0$ is then equivalent to

$$
\begin{equation*}
\left(S_{n}(t)-z S_{n-1}(t)\right)\left(S_{n-2}(t)-z S_{n-1}(t)\right)=0 \tag{2.2}
\end{equation*}
$$

Let $P(x, y)$ denote the left hand side of equation (2.2). By Lemma 2.1, we have $S_{n}^{2}(t)-$ $t S_{n}(t) S_{n-1}(t)+S_{n-1}^{2}(t)=1$. This can be written as $S_{n}(t) S_{n-2}(t)=S_{n-1}^{2}(t)-1$. From this and $S_{n}(t)+S_{n-2}(t)=t S_{n-1}(t)$ we get

$$
P(x, y)=\left(z^{2}-t z+1\right) S_{n-1}^{2}(t)-1
$$

By a direct calculation, using $S_{m}^{2}(y)+S_{m-1}^{2}(y)-y S_{m}(y) S_{m-1}(y)=1$, we have

$$
\begin{aligned}
& z^{2}-t z+1 \\
= & (z-1)^{2}-(t-2) z \\
= & (y+2-x)^{2} S_{m-1}^{2}(y)\left(S_{m}(y)-S_{m-1}(y)\right)^{2} \\
& -(y+2-x)(y-2) S_{m-1}^{2}(y)\left[1+(y+2-x) S_{m-1}(y)\left(S_{m}(y)-S_{m-1}(y)\right)\right] \\
= & (y+2-x) S_{m-1}^{2}(y)\left[4-x+(y+2-x)(y-2) S_{m-1}^{2}(y)\right] \\
= & (y+2-x) S_{m-1}^{2}(y)(t+2-x) .
\end{aligned}
$$

Hence $P(x, y)=(y+2-x) S_{m-1}^{2}(y)(t+2-x) S_{n-1}^{2}(t)-1$.
By Lemma2.1(4), for any positive integer $l$ the Chebychev polynomial $S_{l}(v)=\prod_{j=1}^{l}(v-$ $2 \cos \left(\frac{j \pi}{l+1}\right)$ is a strictly increasing function in $v \in[2, \infty)$. This implies that, for a fixed real number $x \in[4-1 /(m n), 4]$, the polynomials $t=2+(y+2-x)(y-2) S_{m-1}^{2}(y) \geq 2$ and $P(x, y)=(y+2-x) S_{m-1}^{2}(y)(t+2-x) S_{n-1}^{2}(t)-1$ are strictly increasing functions in $y \in[2, \infty)$. Note that $\lim _{y \rightarrow \infty} P(x, y)=\infty$ and

$$
\lim _{y \rightarrow 2^{+}} P(x, y)=P(x, 2)=(4-x)^{2} m^{2} n^{2}-1 \leq 0
$$

Hence there exists a unique real number $y(x) \in[2, \infty)$ such that $P(x, y(x))=0$. Since $P\left(4-\frac{1}{m n}, 2\right)=0$ we have $y\left(4-\frac{1}{m n}\right)=2$. Finally, by the implicit function theorem $y=y(x)$ is a continuous function in $x \in[4-1 /(m n), 4]$.
Lemma 2.3. There exists a continuous real function $x:[2, \infty) \rightarrow\left(4 \cos ^{2} \frac{(2 n-1) \pi}{4 n+2}, \infty\right)$ in the variable $y$ such that

- $x(2)<4 \cos ^{2} \frac{(2 n-2) \pi}{4 n+2}$,
- $\lim _{y \rightarrow \infty} x(y)=\infty$ and
- $R_{C(2 m+1,2 n)}(x(y), y)=0$ for all $y \in[2, \infty)$.

Proof. Let $K=C(2 m+1,2 n)$. We have $R_{K}(x, y)=S_{-n}(t)-z S_{-n-1}(t)$ where

$$
\begin{aligned}
t & =2-(y+2-x)\left(S_{m}(y)-S_{m-1}(y)\right)^{2} \\
z & =1-(y+2-x) S_{m}(y)\left(S_{m}(y)-S_{m-1}(y)\right)
\end{aligned}
$$

Note that $R_{K}(x, y)=(t-z) S_{-n-1}(t)-S_{-n-2}(t)=S_{n}(t)-(t-z) S_{n-1}(t)$.
By Lemma 2.1 we have

$$
S_{n}(t)-S_{n-1}(t)=\prod_{j=1}^{n}\left(t-2 \cos \frac{(2 j-1) \pi}{2 n+1}\right)
$$

$$
S_{n}(t)+S_{n-1}(t)=\prod_{j=1}^{n}\left(t-2 \cos \frac{2 j \pi}{2 n+1}\right)
$$

Let $t_{j}=2 \cos \frac{j \pi}{2 n+1}$ for $j=1, \cdots, 2 n$. By writing $t_{2 j-1}=e^{i \theta}+e^{-i \theta}$ where $\theta=\frac{(2 j-1) \pi}{2 n+1}$, we have

$$
\begin{aligned}
S_{n}\left(t_{2 j-1}\right) & =\frac{e^{i(n+1) \theta}-e^{-i(n+1) \theta}}{e^{i \theta}-e^{-i \theta}}=\frac{\sin \frac{(2 j-1)(n+1) \pi}{2 n+1}}{\sin \frac{(2 j-1) \pi}{2 n+1}} \\
& =\frac{\sin \left(j \pi-\frac{\pi}{2}+\frac{(2 j-1) \pi}{2(2 n+1)}\right)}{\sin \frac{(2 j-1) \pi}{2 n+1}}=(-1)^{j-1} \frac{\cos \frac{(2 j-1) \pi}{2(2 n+1)}}{\sin \frac{(2 j-1) \pi}{2 n+1}} .
\end{aligned}
$$

This implies that $(-1)^{j-1} S_{n}\left(t_{2 j-1}\right)>0$. Similarly, $(-1)^{j} S_{n}\left(t_{2 j}\right)>0$.
Fix a real number $y \geq 2$. Let $s_{j}(y)=y+2-\frac{2-t_{j}}{\left(S_{m}(y)-S_{m-1}(y)\right)^{2}}$ for $j=1, \cdots, 2 n$. We also let $s_{0}=y+2$. Since $-2<t_{2 n}<\cdots<t_{1}<2$ we have $s_{2 n}(y)<\cdots<s_{1}(y)<y+2=s_{0}(y)$. At $x=s_{2 j-1}(y)$ we have $t=t_{2 j-1}$ and so $S_{n}(t)=S_{n-1}(t)$. This implies that

$$
\begin{aligned}
R_{K}\left(s_{2 j-1}(y), y\right) & =(1-(t-z)) S_{n}\left(t_{2 j-1}\right) \\
& =-\left(y+2-s_{2 j-1}(y)\right) S_{m-1}(y)\left(S_{m}(y)-S_{m-1}(y)\right) S_{n}\left(t_{2 j-1}\right)
\end{aligned}
$$

Since $y \geq 2$, by Lemma 2.1 we have $S_{m}(y)-S_{m-1}(y) \geq S_{m}(2)-S_{m-1}(2)=1$ and $S_{m-1}(y) \geq S_{m-1}(2)=m$. Hence $(-1)^{j} R_{K}\left(s_{2 j-1}(y), y\right)>0$.

Similarly, for $1 \leq j \leq n$ we have

$$
\begin{aligned}
R_{K}\left(s_{2 j}(y), y\right) & =(1+t-z) S_{n}\left(t_{2 j}\right) \\
& =\left[2+\left(y+2-s_{2 j-1}(y)\right) S_{m-1}(y)\left(S_{m}(y)-S_{m-1}(y)\right] S_{n}\left(t_{2 j}\right)\right.
\end{aligned}
$$

which implies that $(-1)^{j} R_{K}\left(s_{2 j}(y), y\right)>0$.
For each $1 \leq j \leq n-1$, since

$$
R_{K}\left(s_{2 j+1}(y), y\right) R_{K}\left(s_{2 j}(y), y\right)<0
$$

there exists $x_{j}(y) \in\left(s_{2 j+1}(y), s_{2 j}(y)\right)$ such that $R_{K}\left(x_{j}(y), y\right)=0$. Since

$$
R_{K}\left(s_{0}(y), y\right)=R_{K}(y+2, y)=1
$$

and $R_{K}\left(s_{1}(y), y\right)<0$ there exists $x_{0}(y) \in\left(s_{1}(y), s_{0}(y)\right)$ such that $R_{K}\left(x_{0}(y), y\right)=0$.
Since $R_{K}(x, y)=z S_{n-1}(t)-S_{n-2}(t)$, we see that $R_{K}(x, y)$ is a polynomial of degree $n$ in $x$ for each fixed real number $y \geq 2$. This polyomial has exactly $n$ simple real roots $x_{0}(y), \cdots, x_{n-1}(y)$ satisfying $x_{n-1}(y)<\cdots<x_{0}(y)<y+2$, hence the implicit function theorem implies that each $x_{j}(y)$ is a continuous function in $y \geq 2$.

By letting $x(y)=x_{n-1}(y)$ for $y \geq 2$, we have $R_{K}(x(y), y)=0$. Moreover, since

$$
x(y)>s_{2 n-1}(y)=y+2-\frac{2-2 \cos \frac{(2 n-1) \pi}{2 n+1}}{\left(S_{m}(y)-S_{m-1}(y)\right)^{2}}
$$

we have $\lim _{y \rightarrow \infty} x(y)=\infty$ and $x(y)>4-\left(2-2 \cos \frac{(2 n-1) \pi}{2 n+1}\right)=4 \cos ^{2} \frac{(2 n-1) \pi}{4 n+2}$ for $y \geq 2$.

Finally, since $x(y)<s_{2 n-2}(y)$ for all $y \geq 2$ we have $x(2)<s_{2 n-2}(2)=4 \cos ^{2} \frac{(2 n-2) \pi}{4 n+2}$.
Lemma 2.4. Suppose $n \geq 2$. Then there exists a continuous real function $x:[2, \infty) \rightarrow$ $\left(4 \cos ^{2} \frac{(2 n-1) \pi}{4 n+2}, \infty\right)$ in the variable $y$ such that

- $x(2)<4 \cos ^{2} \frac{(2 n-3) \pi}{4 n+2}$,
- $\lim _{y \rightarrow \infty} x(y)=\infty$ and
- $R_{C(2 m+1,-2 n)}(x(y), y)=0$ for all $y \in[2, \infty)$.

Proof. Let $K=C(2 m+1,-2 n)$. We have $R_{K}(x, y)=S_{n}(t)-z S_{n-1}(t)$ where

$$
\begin{aligned}
t & =2-(y+2-x)\left(S_{m}(y)-S_{m-1}(y)\right)^{2} \\
z & =1-(y+2-x) S_{m}(y)\left(S_{m}(y)-S_{m-1}(y)\right)
\end{aligned}
$$

Fix a real number $y \geq 2$. Choose $t_{j}$ and $s_{j}(y)$ for $1 \leq j \leq 2 n$ as in Lemma 2.3. Since

$$
\begin{aligned}
R_{K}\left(s_{2 j-1}(y), y\right) & =(1-z) S_{n}\left(t_{2 j-1}\right) \\
& =\left(y+2-s_{2 j-1}(y)\right) S_{m}(y)\left(S_{m}(y)-S_{m-1}(y)\right) S_{n}\left(t_{2 j-1}\right)
\end{aligned}
$$

we have $(-1)^{j-1} R_{K}\left(s_{2 j-1}(y), y\right)>0$. Hence, there exists $x_{j}(y) \in\left(s_{2 j+1}(y), s_{2 j-1}(y)\right)$ such that $R_{K}\left(x_{j}(y), y\right)=0$ for each $1 \leq j \leq n-1$.

By writing $R_{K}(x, y)=(t-z) S_{n-1}(t)-S_{n-2}(t)$ and noting that

$$
t-z=1+(y+2-x)\left(S_{m}(y)-S_{m-1}(y)\right) S_{m-1}(y)
$$

we see that $R_{K}(x, y)$ is a polynomial of degree $n$ in $x$ with negative highest coefficient for each fixed real number $y \geq 2$. Since $\lim _{x \rightarrow \infty} R_{K}(x, y)=-\infty$ and $R_{K}(y+2, y)=1$, there exists $x_{0}(y) \in(y+2, \infty)$ such that $R_{K}\left(x_{0}(y), y\right)=0$. For a fixed real number $y \geq 2$, the polynomial $R_{K}(x, y)$ of degree $n$ in $x$ has exactly $n$ simple real roots $x_{0}(y), \cdots, x_{n-1}(y)$ satisfying $x_{n-1}(y)<\cdots<x_{1}(y)<y+2<x_{0}(y)$, hence the implicit function theorem implies that each $x_{j}(y)$ is a continuous function in $y \geq 2$.

By letting $x(y)=x_{n-1}(y)$ for $y \geq 2$, we have $R_{K}(x(y), y)=0$. Moreover, since

$$
x(y)>s_{2 n-1}(y)=y+2-\frac{2-2 \cos \frac{(2 n-1) \pi}{2 n+1}}{\left(S_{m}(y)-S_{m-1}(y)\right)^{2}}
$$

we have $\lim _{y \rightarrow \infty} x(y)=\infty$ and $x(y)>4-\left(2-2 \cos \frac{(2 n-1) \pi}{2 n+1}\right)=4 \cos ^{2} \frac{(2 n-1) \pi}{4 n+2}$ for $y \geq 2$.
Finally, since $x(y)<s_{2 n-3}(y)$ for all $y \geq 2$ we have $x(2)<s_{2 n-3}(2)=4 \cos ^{2} \frac{(2 n-3) \pi}{4 n+2}$.

## 3. Proof of Theorem 1

Suppose $K$ is a double twist knot of the form $C(2 m,-2 n), C(2 m+1,2 n)$ or $C(2 m+$ $1,-2 n)$ in the Conway notation for some positive integers $m$ and $n$. Let $X$ be the complement of an open tubular neighborhood of $K$ in $S^{3}$, and $X_{r}$ the 3-manifold obtained
from $S^{3}$ by $r$-surgery along $K$. Recall that

$$
\mathrm{LO}_{K}= \begin{cases}(-\infty, 1) & \text { if } K=C(2 m,-2 n) \\ (-\infty, 2 n-1) & \text { if } K=C(2 m+1,2 n) \\ (3-2 n, \infty) & \text { if } K=C(2 m+1,-2 n) \text { and } n \geq 2\end{cases}
$$

An element of $\mathrm{SL}_{2}(\mathbb{R})$ is called elliptic if its trace is a real number in $(-2,2)$. A representation $\rho: \mathbb{Z}^{2} \rightarrow \mathrm{SL}_{2}(\mathbb{R})$ is called elliptic if the image group $\rho\left(\mathbb{Z}^{2}\right)$ contains an elliptic element of $\mathrm{SL}_{2}(\mathbb{R})$. In which case, since $\mathbb{Z}^{2}$ is an abelian group every non-trivial element of $\rho\left(\mathbb{Z}^{2}\right)$ must also be elliptic.

Using Lemmas 2.2 2.4 we first prove the following.
Proposition 3.1. For each rational number $r \in \mathrm{LO}_{K} \backslash\{0\}$ there exists a representation $\rho: \pi_{1}\left(X_{r}\right) \rightarrow \mathrm{SL}_{2}(\mathbb{R})$ such that $\left.\rho\right|_{\pi_{1}(\partial X)}: \pi_{1}(\partial X) \cong \mathbb{Z}^{2} \rightarrow \mathrm{SL}_{2}(\mathbb{R})$ is an elliptic representation.

Proof. We first consider the case $K=C(2 m,-2 n)$. Let $\theta_{0}=\arccos \sqrt{1-1 /(4 m n)}$. For $\theta \in\left(0, \theta_{0}\right) \cup\left(\pi-\theta_{0}, \pi\right)$ we let $x=4 \cos ^{2} \theta$. Then $x \in(4-1 /(m n), 4)$. Consider the continuous real function

$$
y:[4-1 /(m n), 4] \rightarrow[2, \infty)
$$

in Lemma 2.2, Let $M=e^{i \theta}$. Then $x=4 \cos ^{2} \theta=\left(M+M^{-1}\right)^{2}$. Since $R_{K}(x, y(x))=0$ there exists a non-abelian representation $\rho: \pi_{1}(X) \rightarrow \mathrm{SL}_{2}(\mathbb{C})$ such that

$$
\rho(a)=\left[\begin{array}{cc}
M & 1 \\
0 & M^{-1}
\end{array}\right] \quad \text { and } \quad \rho(b)=\left[\begin{array}{cc}
M & 0 \\
2-y(x) & M^{-1}
\end{array}\right] .
$$

Note that $x$ is the square of the trace of a meridian. Moreover, the image of the canonical longitude $\lambda$ corresponding to the meridian $\mu=a$ has the form $\rho(\lambda)=\left[\begin{array}{cc}L & * \\ 0 & L^{-1}\end{array}\right]$, where

$$
L=-\frac{M^{-1} \alpha-M \beta}{M \alpha-M^{-1} \beta}
$$

and $\alpha=S_{m}(y(x))-S_{m-1}(y(x)), \beta=S_{m-1}(y(x))-S_{m-2}(y(x))$. Note that $\alpha>\beta>0$, since $y(x)>2$.

It is easy to see that $|L|=\sqrt{L \bar{L}}=1$, where $\bar{L}$ denotes the complex conjugate of $L$. Moreover, by a direct calculation, we have

$$
\begin{aligned}
\operatorname{Re}(L) & =\left(2 \alpha \beta-\left(\alpha^{2}+\beta^{2}\right) \cos 2 \theta\right) /\left|M \alpha-M^{-1} \beta\right|^{2} \\
\operatorname{Im}(L) & =\left(\alpha^{2}-\beta^{2}\right) \sin 2 \theta /\left|M \alpha-M^{-1} \beta\right|^{2}
\end{aligned}
$$

Note that $\operatorname{Im}(L)>0$ if $\theta \in\left(0, \theta_{0}\right)$ and $\operatorname{Im}(L)<0$ if $\theta \in\left(\pi-\theta_{0}, \pi\right)$. Let

$$
\varphi(\theta)= \begin{cases}\arccos \left[\left(2 \alpha \beta-\left(\alpha^{2}+\beta^{2}\right) \cos 2 \theta\right) /\left|e^{i \theta} \alpha-e^{-i \theta} \beta\right|^{2}\right] & \text { if } \theta \in\left(0, \theta_{0}\right), \\ -\arccos \left[\left(2 \alpha \beta-\left(\alpha^{2}+\beta^{2}\right) \cos 2 \theta\right) /\left|e^{i \theta} \alpha-e^{-i \theta} \beta\right|^{2}\right] & \text { if } \theta \in\left(\pi-\theta_{0}, \pi\right) .\end{cases}
$$

Then $L=e^{i \varphi(\theta)}$. Note that $\varphi(\theta) \in(0, \pi)$ if $\theta \in\left(0, \theta_{0}\right)$ and $\varphi(\theta) \in(-\pi, 0)$ if $\theta \in\left(\pi-\theta_{0}, \pi\right)$.

The function $f(\theta):=-\frac{\varphi(\theta)}{\theta}$ is a continuous function on each of the intervals $\left(0, \theta_{0}\right)$ and $\left(\pi-\theta_{0}, \pi\right)$. As $\theta \rightarrow 0^{+}$we have $M \rightarrow 1$ and $L=-\frac{M^{-1} \alpha-M \beta}{M \alpha-M^{-1} \beta} \rightarrow-1$, so $\varphi(\theta) \rightarrow \pi$. As $\theta \rightarrow \theta_{0}^{-}$we have $x \rightarrow 4-1 /(m n), y(x) \rightarrow 2$ and $\alpha, \beta \rightarrow 1$, so $L=-\frac{M^{-1} \alpha-M \beta}{M \alpha-M^{-1} \beta} \rightarrow 1$ and $\varphi(\theta) \rightarrow 0$. This implies that

$$
\lim _{\theta \rightarrow 0^{+}}-\frac{\varphi(\theta)}{\theta}=-\infty \quad \text { and } \quad \lim _{\theta \rightarrow \theta_{0}^{-}}-\frac{\varphi(\theta)}{\theta}=0
$$

Hence the image of $f(\theta)$ on the interval $\left(0, \theta_{0}\right)$ contains the interval $(-\infty, 0)$.
Similarly, since

$$
\lim _{\theta \rightarrow\left(\pi-\theta_{0}\right)^{+}}-\frac{\varphi(\theta)}{\theta}=0 \quad \text { and } \quad \lim _{\theta \rightarrow \pi^{-}}-\frac{\varphi(\theta)}{\theta}=1
$$

the image of $f(\theta)$ on the interval $\left(\pi-\theta_{0}, \pi\right)$ contains the interval $(0,1)$.
Suppose $r=\frac{p}{q}$ is a rational number such that $r \in(-\infty, 0) \cup(0,1)$. Then $r=f(\theta)=$ $-\frac{\varphi(\theta)}{\theta}$ for some $\theta \in\left(0, \theta_{0}\right) \cup\left(\pi-\theta_{0}, \pi\right)$. Since $M^{p} L^{q}=e^{i(p \theta+q \varphi(\theta))}=1$, we have $\rho\left(\mu^{p} \lambda^{q}\right)=$ $I$. This means that the non-abelian representation $\rho: \pi_{1}(X) \rightarrow \mathrm{SL}_{2}(\mathbb{C})$ extends to a representation $\rho: \pi_{1}\left(X_{r}\right) \rightarrow \mathrm{SL}_{2}(\mathbb{C})$. Finally, since $2-y(x)<0$, a result in [Kh, page 786] implies that $\rho$ can be conjugated to an $\mathrm{SL}_{2}(\mathbb{R})$-representation. Note that the restriction of this representation to the peripheral subgroup $\pi_{1}(\partial X)$ of the knot group is an elliptic representation. This completes the proof of Proposition 3.1 for $K=C(2 m,-2 n)$.

We now consider the case $K=C(2 m+1,2 n)$. Consider the continuous real function

$$
x:[2, \infty) \rightarrow\left(4 \cos ^{2} \frac{(2 n-1) \pi}{4 n+2}, \infty\right)
$$

in Lemma 2.3. Since $x(2)<4 \cos ^{2} \frac{(2 n-2) \pi}{4 n+2}$ and $\lim _{y \rightarrow \infty} x(y)=\infty$, there exists $y^{*}>2$ such that $x\left(y^{*}\right)=4$ and $4 \cos ^{2} \frac{(2 n-1) \pi}{4 n+2}<x(y)<4$ for all $y \in\left[2, y^{*}\right)$.

For each $y \in\left[2, y^{*}\right)$ we let $\theta(y)=\arccos (\sqrt{x(y)} / 2)$. Then $\theta(2)>\frac{(2 n-2) \pi}{4 n+2}$, and for $y \in\left[2, y^{*}\right)$ we have $0<\theta(y)<\frac{(2 n-1) \pi}{4 n+2}$ and $x(y)=4 \cos ^{2} \theta(y)$. Since $R_{K}(x(y), y)=0$ there exists a non-abelian representation $\rho: \pi_{1}(X) \rightarrow \mathrm{SL}_{2}(\mathbb{C})$ such that

$$
\rho(a)=\left[\begin{array}{cc}
M & 1 \\
0 & M^{-1}
\end{array}\right] \quad \text { and } \quad \rho(b)=\left[\begin{array}{cc}
M & 0 \\
2-y & M^{-1}
\end{array}\right],
$$

where $M=e^{i \theta(y)}$. Moreover, the image of the canonical longitude $\lambda$ corresponding to the meridian $\mu=a$ has the form $\rho(\lambda)=\left[\begin{array}{cc}L & * \\ 0 & L^{-1}\end{array}\right]$, where

$$
L=-M^{-4 n} \frac{M^{-1} \gamma-M \delta}{M \gamma-M^{-1} \delta}
$$

and $\gamma=S_{m}(y), \delta=S_{m-1}(y)$. Note that $\gamma>\delta>0$, since $y>2$.
As in the previous case, we write $L=e^{i \varphi(y)}$ where

$$
\varphi(y)=(2 n-2) \pi-4 n \theta(y)+\arccos \left[\left(2 \gamma \delta-\left(\gamma^{2}+\delta^{2}\right) \cos 2 \theta(y)\right) /\left|e^{i \theta(y)} \gamma-e^{-i \theta(y)} \delta\right|^{2}\right] .
$$

Since $\frac{(2 n-2) \pi}{4 n+2}<\theta(2)<\frac{(2 n-1) \pi}{4 n+2}$ we have $-\frac{2 \pi}{2 n+1}<\varphi(2)<2 \pi-\frac{3 \pi}{2 n+1}$.
As $y \rightarrow 2^{+}, \rho$ approaches a reducible representation and so $L \rightarrow 1, \varphi(y) \rightarrow \varphi(2)=k 2 \pi$ for some integer $k$. Since $-\frac{2 \pi}{2 n+1}<\varphi(2)<2 \pi-\frac{3 \pi}{2 n+1}$, we must have $\varphi(2)=0$. As $y \rightarrow\left(y^{*}\right)^{-}$, we have $x(y) \rightarrow 4, M \rightarrow 1, L=-M^{-4 n} \frac{M^{-1} \gamma-M \delta}{M \gamma-M^{-1} \delta} \rightarrow-1$ and hence $\theta(y) \rightarrow$ $0^{+}, \varphi(y) \rightarrow(2 l-1) \pi$ for some integer $l$. Since

$$
\begin{aligned}
(2 l-1) \pi= & \lim _{y \rightarrow\left(y^{*}\right)^{-}}(2 n-2) \pi-4 n \theta(y) \\
\quad & \quad \arccos \left[\left(2 \gamma \delta-\left(\gamma^{2}+\delta^{2}\right) \cos 2 \theta(y)\right) /\left|e^{i \theta(y)} \gamma-e^{-i \theta(y)} \delta\right|^{2}\right] \\
= & \lim _{y \rightarrow\left(y^{*}\right)^{-}}(2 n-2) \pi \\
\quad & \quad \arccos \left[\left(2 \gamma \delta-\left(\gamma^{2}+\delta^{2}\right) \cos 2 \theta(y)\right) /\left|e^{i \theta(y)} \gamma-e^{-i \theta(y)} \delta\right|^{2}\right]
\end{aligned}
$$

we have $(2 n-2) \pi \leq(2 l-1) \pi \leq(2 n-1) \pi$. This implies that $2 l-1=2 n-1$ and $\varphi(y) \rightarrow(2 n-1) \pi$ as $y \rightarrow\left(y^{*}\right)^{-}$. Hence the image of $g(y):=-\frac{\varphi(y)}{\theta(y)}$ on the interval $\left(2, y^{*}\right)$ contains the interval $(-\infty, 0)$.

Similarly, with $\theta_{1}(y)=\pi-\theta(y)$ we have $x(y)=4 \cos ^{2}\left(\theta_{1}(y)\right)$ and hence for each $y \in\left[2, y^{*}\right)$ there exists a non-abelian representation $\rho_{1}: \pi_{1}(X) \rightarrow \mathrm{SL}_{2}(\mathbb{C})$ such that

$$
\rho_{1}(a)=\left[\begin{array}{cc}
M & 1 \\
0 & M^{-1}
\end{array}\right] \quad \text { and } \quad \rho_{1}(b)=\left[\begin{array}{cc}
M & 0 \\
2-y & M^{-1}
\end{array}\right]
$$

where $M=e^{i \theta_{1}(y)}$. Moreover, the image of the canonical longitude $\lambda$ corresponding to the meridian $\mu=a$ has the form $\rho_{1}(\lambda)=\left[\begin{array}{cc}L & * \\ 0 & L^{-1}\end{array}\right]$, where $L=e^{i \varphi_{1}(y)}$ and

$$
\begin{aligned}
\varphi_{1}(y)= & -(2 n-2) \pi+4 n \pi-4 n \theta_{1}(y) \\
& -\arccos \left[\left(2 \gamma \delta-\left(\gamma^{2}+\delta^{2}\right) \cos 2 \theta_{1}(y)\right) /\left|e^{i \theta_{1}(y)} \gamma-e^{-i \theta_{1}(y)} \delta\right|^{2}\right] \\
= & -(2 n-2) \pi+4 n \theta(y) \\
& -\arccos \left[\left(2 \gamma \delta-\left(\gamma^{2}+\delta^{2}\right) \cos 2 \theta_{1}(y)\right) /\left|e^{i \theta_{1}(y)} \gamma-e^{-i \theta_{1}(y)} \delta\right|^{2}\right] .
\end{aligned}
$$

Since $\frac{(2 n-2) \pi}{4 n+2}<\theta(2)<\frac{(2 n-1) \pi}{4 n+2}$ we have $-2 \pi+\frac{3 \pi}{2 n+1}<\varphi_{1}(2)<\frac{2 \pi}{2 n+1}$.
As $y \rightarrow 2^{+}, \rho_{1}$ approaches a reducible representation and so $L \rightarrow 1, \varphi_{1}(y) \rightarrow 0$. As $y \rightarrow\left(y^{*}\right)^{-}$, we have $x(y) \rightarrow 4, M \rightarrow-1, L=-M^{-4 n} \frac{M^{-1} \gamma-M \delta}{M \gamma-M^{-1} \delta} \rightarrow-1$ and hence $\theta_{1}(y) \rightarrow \pi, \varphi_{1}(y) \rightarrow-(2 n-1) \pi$. This implies that the image of $g_{1}(y):=-\frac{\varphi_{1}(y)}{\theta_{1}(y)}$ on the interval $\left(2, y^{*}\right)$ contains the interval $(0,2 n-1)$.

The rest of the proof of Proposition 3.1 for $C(2 m+1,2 n)$ is similar to that for $C(2 m,-2 n)$.

Lastly, we consider the case $K=C(2 m+1,-2 n)$ and $n \geq 2$. Consider the continuous real function

$$
x:[2, \infty) \rightarrow\left(4 \cos ^{2} \frac{(2 n-1) \pi}{4 n+2}, \infty\right)
$$

in Lemma 2.4. Since $x(2)<4 \cos ^{2} \frac{(2 n-3) \pi}{4 n+2}$ and $\lim _{y \rightarrow \infty} x(y)=\infty$, there exists $y^{*}>2$ such that $x\left(y^{*}\right)=4$ and $4 \cos ^{2} \frac{(2 n-1) \pi}{4 n+2}<x(y)<4$ for all $y \in\left[2, y^{*}\right)$.

For each $y \in\left[2, y^{*}\right)$ we let $\theta(y)=\arccos (\sqrt{x(y)} / 2)$. Then $\theta(2)>\frac{(2 n-3) \pi}{4 n+2}$, and for $y \in\left[2, y^{*}\right)$ we have $0<\theta(y)<\frac{(2 n-1) \pi}{4 n+2}$ and $x(y)=4 \cos ^{2} \theta(y)$. Since $R_{K}(x(y), y)=0$ there exists a non-abelian representation $\rho: \pi_{1}(X) \rightarrow \mathrm{SL}_{2}(\mathbb{C})$ such that

$$
\rho(a)=\left[\begin{array}{cc}
M & 1 \\
0 & M^{-1}
\end{array}\right] \quad \text { and } \quad \rho(b)=\left[\begin{array}{cc}
M & 0 \\
2-y & M^{-1}
\end{array}\right],
$$

where $M=e^{i \theta(y)}$. Moreover, the image of the canonical longitude $\lambda$ corresponding to the meridian $\mu=a$ has the form $\rho(\lambda)=\left[\begin{array}{cc}L & * \\ 0 & L^{-1}\end{array}\right]$, where

$$
L=-M^{4 n} \frac{M^{-1} \gamma-M \delta}{M \gamma-M^{-1} \delta}
$$

and $\gamma=S_{m}(y), \delta=S_{m-1}(y)$. Note that $\gamma>\delta>0$, since $y>2$.
As above, we write $L=e^{i \varphi(y)}$ where

$$
\varphi(y)=-(2 n-2) \pi+4 n \theta(y)+\arccos \left[\left(2 \gamma \delta-\left(\gamma^{2}+\delta^{2}\right) \cos 2 \theta(y)\right) /\left|e^{i \theta(y)} \gamma-e^{-i \theta(y)} \delta\right|^{2}\right]
$$

Since $\frac{(2 n-3) \pi}{4 n+2}<\theta(2)<\frac{(2 n-1) \pi}{4 n+2}$ we have $-2 \pi+\frac{4 \pi}{2 n+1}<\varphi(2)<2 \pi-\frac{(2 n-1) \pi}{2 n+1}$.
As $y \rightarrow 2^{+}, \rho$ approaches a reducible representation and so $L \rightarrow 1, \varphi(y) \rightarrow \varphi(2)=k 2 \pi$ for some integer $k$. Since $-2 \pi+\frac{4 \pi}{2 n+1}<\varphi(2)<2 \pi-\frac{(2 n-1) \pi}{2 n+1}$, we must have $\varphi(2)=0$.

As $y \rightarrow\left(y^{*}\right)^{-}$, we have $x(y) \rightarrow 4, M \rightarrow 1, L=-M^{4 n} \frac{M^{-1} \gamma-M \delta}{M \gamma-M^{-1} \delta} \rightarrow-1$ and hence $\theta(y) \rightarrow 0^{+}, \varphi(y) \rightarrow(2 l-1) \pi$ for some integer $l$. Since

$$
\begin{aligned}
&(2 l-1) \pi= \lim _{y \rightarrow\left(y^{*}\right)^{-}}-(2 n-2) \pi+4 n \theta(y) \\
& \quad \quad \arccos \left[\left(2 \gamma \delta-\left(\gamma^{2}+\delta^{2}\right) \cos 2 \theta(y)\right) /\left|e^{i \theta(y)} \gamma-e^{-i \theta(y)} \delta\right|^{2}\right] \\
&= \lim _{y \rightarrow\left(y^{*}\right)^{-}}-(2 n-2) \pi \\
& \quad \quad+\arccos \left[\left(2 \gamma \delta-\left(\gamma^{2}+\delta^{2}\right) \cos 2 \theta(y)\right) /\left|e^{i \theta(y)} \gamma-e^{-i \theta(y)} \delta\right|^{2}\right]
\end{aligned}
$$

we have $-(2 n-2) \pi \leq(2 l-1) \pi \leq-(2 n-3) \pi$. This implies that $2 l-1=-(2 n-3)$ and $\varphi(y) \rightarrow-(2 n-3) \pi$ as $y \rightarrow\left(y^{*}\right)^{-}$. Hence the image of $h(y):=-\frac{\varphi(y)}{\theta(y)}$ on the interval $\left(2, y^{*}\right)$ contains the interval $(0, \infty)$.

Similarly, with $\theta_{1}(y)=\pi-\theta(y)$ we have $x(y)=4 \cos ^{2}\left(\theta_{1}(y)\right)$ and hence for each $y \in\left[2, y^{*}\right)$ there exists a non-abelian representation $\rho_{1}: \pi_{1}(X) \rightarrow \mathrm{SL}_{2}(\mathbb{C})$ such that

$$
\rho_{1}(a)=\left[\begin{array}{cc}
M & 1 \\
0 & M^{-1}
\end{array}\right] \quad \text { and } \quad \rho_{1}(b)=\left[\begin{array}{cc}
M & 0 \\
2-y & M^{-1}
\end{array}\right],
$$

where $M=e^{i \theta_{1}(y)}$. Moreover, the image of the canonical longitude $\lambda$ corresponding to the meridian $\mu=a$ has the form $\rho_{1}(\lambda)=\left[\begin{array}{cc}L & * \\ 0 & L^{-1}\end{array}\right]$, where $L=e^{i \varphi_{1}(y)}$ and

$$
\varphi_{1}(y)=(2 n-2) \pi-4 n \pi+4 n \theta_{1}(y)
$$

$$
\begin{aligned}
& -\arccos \left[\left(2 \gamma \delta-\left(\gamma^{2}+\delta^{2}\right) \cos 2 \theta_{1}(y)\right) /\left|e^{i \theta_{1}(y)} \gamma-e^{-i \theta_{1}(y)} \delta\right|^{2}\right] \\
= & (2 n-2) \pi-4 n \theta(y) \\
& -\arccos \left[\left(2 \gamma \delta-\left(\gamma^{2}+\delta^{2}\right) \cos 2 \theta_{1}(y)\right) /\left|e^{i \theta_{1}(y)} \gamma-e^{-i \theta_{1}(y)} \delta\right|^{2}\right] .
\end{aligned}
$$

Since $\frac{(2 n-3) \pi}{4 n+2}<\theta(2)<\frac{(2 n-1) \pi}{4 n+2}$ we have $-2 \pi+\frac{(2 n-1) \pi}{2 n+1}<\varphi_{1}(2)<2 \pi-\frac{4 \pi}{2 n+1}$.
As $y \rightarrow 2^{+}, \rho_{1}$ approaches a reducible representation and so $L \rightarrow 1, \varphi_{1}(y) \rightarrow \varphi_{1}(2)=0$. As $y \rightarrow\left(y^{*}\right)^{-}$, we have $x(y) \rightarrow 4, M \rightarrow-1, L=-M^{4 n} \frac{M^{-1} \gamma-M \delta}{M \gamma-M^{-1} \delta} \rightarrow-1$ and hence $\theta_{1}(y) \rightarrow \pi, \varphi_{1}(y) \rightarrow(2 n-3) \pi$. This implies that the image of $h_{1}(y):=-\frac{\varphi_{1}(y)}{\theta_{1}(y)}$ on the interval $\left(2, y^{*}\right)$ contains the interval $(-(2 n-3), 0)$.

The rest of the proof of Proposition 3.1 for $C(2 m+1,-2 n)$ is similar to that for $C(2 m,-2 n)$.

We now finish the proof of Theorem (1) Suppose $r$ is a rational number such that $r \in \mathrm{LO}_{K}$. If $r \neq 0$, by Proposition 3.1, there exists a representation $\rho: \pi_{1}\left(X_{r}\right) \rightarrow \mathrm{SL}_{2}(\mathbb{R})$ such that $\left.\rho\right|_{\pi_{1}(\partial X)}$ is an elliptic representation. This representation lifts to a representation $\tilde{\rho}: \pi_{1}\left(X_{r}\right) \rightarrow \widetilde{\mathrm{SL}_{2}(\mathbb{R})}$, where $\widetilde{\mathrm{SL}_{2}(\mathbb{R})}$ is the universal covering group of $\mathrm{SL}_{2}(\mathbb{R})$. See e.g. [CD, Sec. 3.5] and [Va, Sec. 2.2]. Note that $X_{r}$ is an irreducible 3-manifold (by [HTh]) and $\widetilde{\mathrm{SL}_{2}(\mathbb{R})}$ is a left orderable group (by [Be]). Hence, by [BRW], $\pi_{1}\left(X_{r}\right)$ is a left orderable group. Finally, 0-surgery along a knot always produces a prime manifold whose first Betti number is 1 , and by [BRW] such manifold has left orderable fundamental group.
