# HILBERT-KUNZ FUNCTION AND HILBERT-KUNZ MULTIPLICITY OF SOME IDEALS OF THE REES ALGEBRA

#### Abstract

We prove that the Hilbert-Kunz function of the ideal (I, It) of the Rees algebra $\mathcal{R}(I)$, where $I$ is an $\mathfrak{m}$-primary ideal of a 1-dimensional local ring $(R, \mathfrak{m})$, is a quasi-polynomial in $e$, for large $e$. For $s \in \mathbb{N}$, we calculate the Hilbert-Samuel function of the $R$-module $I^{[s]}$ and obtain an explicit description of the generalized Hilbert-Kunz function of the ideal $(I, I t) \mathcal{R}(I)$ when $I$ is a parameter ideal in a Cohen-Macaulay local ring of dimension $d \geq 2$, proving that the generalized Hilbert-Kunz function is a piecewise polynomial in this case.


## 1. Introduction

Let $(R, \mathfrak{m})$ be a $d$-dimensional Noetherian local ring of positive prime characteristic $p$ and let $I$ be an $\mathfrak{m}$-primary ideal. The $q^{t h}$-Frobenius power of $I$ is the ideal $I^{[q]}=\left(x^{q} \mid x \in I\right)$ where $q=p^{e}$ for $e \in \mathbb{N}$. The function $e \mapsto \ell_{R}\left(R / I^{\left[p^{e}\right]}\right)$ is called the Hilbert-Kunz function of $R$ with respect to $I$ and was first considered by E. Kunz in [11]. In [13], P. Monsky showed that this function is of the form

$$
\ell_{R}\left(R / I^{[q]}\right)=e_{\text {НК }}(I, R) q^{d}+O\left(q^{d-1}\right),
$$

where $e_{H K}(I, R)$ is a positive real number called the Hilbert-Kunz multiplicity of $R$ with respect to $I$. We write $e_{H K}(R):=e_{H K}(\mathfrak{m}, R)$ and $e_{H K}(I):=e_{H K}(I, R)$. Besides the mysterious leading coefficient, the behavior of the Hilbert-Kunz function is also unpredictable. Monsky proved that in the case of 1-dimensional rings, the Hilbert-Kunz function $\ell_{R}\left(R / I^{\left[p^{e}\right]}\right)=e_{H K}(I, R) q+\delta_{e}$, where $\delta_{e}$ is a periodic function of $e$, for large $e$. Precisely, take $R=k[[X, Y]] /\left(X^{5}-Y^{5}\right)$, where $k$ is a field of prime characteristic $p \equiv \pm 2(\bmod 5)$. Let $\mathfrak{m}$ be the maximal ideal of $R$. Monsky [13] showed that for large $e, \ell_{R}\left(R / \mathfrak{m}^{[q]}\right)=5 q+\alpha_{\mathfrak{m}}(e)$, where $\alpha_{\mathfrak{m}}(e)=-4$ when $e$ is even and $\alpha_{\mathfrak{m}}(e)=-6$ when $e$ is odd. In [9], the authors determined the Hilbert-Kunz function of the maximal ideal of the ring $R=\mathbb{Z} / p\left[\left[x_{1}, \ldots, x_{s}\right]\right] /\left(x_{1}^{d_{1}}+\cdots+x_{s}^{d_{s}}\right)$, where $d_{i}$ are positive integers, $d=\operatorname{dim} R$, and $s=d+1 \geq 3$. They proved that if $\ell_{R}\left(R / \mathfrak{m}^{[q]}\right)=e_{H K}(R) q^{d}+\delta_{e}$, then $e_{H K}(R)$ is rational and $\delta_{e}$ is an eventually periodic function of $e$ whenever $s=3$ or $p=2$. But when $s=4$ and $p=5$ with $d_{1}=\cdots=d_{s}=4$, then $\ell_{R}\left(R / \mathfrak{m}^{\left[5^{e}\right]}\right)=(168 / 61) 5^{3 e}-(107 / 61) 3^{e}$. In [2], H. Brenner proved the following result

Theorem 1.1. Let $k$ denote the algebraic closure of a finite field of characteristic $p$. Let $R$ denote a normal twodimensional standard-graded $k$-domain and let I denote a homogeneous $R_{+}$-primary ideal. Then the Hilbert-Kunz

[^0]function of I has the form $\ell_{R}\left(R / I^{[q]}\right)=e_{H K}(I, R) q^{2}+\delta_{e}$, where $e_{H K}(I, R)$ is a rational number and $\delta_{e}$ is an eventually periodic function.

There are numerous papers in which Hilbert-Kunz function and multiplicity have been calculated for specific local and graded rings. We mention a few of them. K. Pardue [15], P. Monsky [14] and R.-O. Buchweitz and Q. Chen [3] computed the Hilbert-Kunz multiplicity for cubic curves. N. Fakhruddin and V. Trivedi [6] found explicit formulas for the Hilbert-Kunz functions and Hilbert-Kunz multiplicities of certain projective embeddings of flag varieties and elliptic curves over algebraically closed fields of positive characteristics. Explicit computation of the Hilbert-Kunz function and multiplicity are also done in [17]. In [18], a family of one-dimensional reduced Cohen-Macaulay local rings are constructed which have same Hilbert-Kunz multiplicity but have infinitely many Hilbert-Kunz functions.
We recall a few definitions. Let $(R, \mathfrak{m})$ be a Noetherian local ring of dimension $d$ and $I$ be an $\mathfrak{m}$-primary ideal of $R$. The Hilbert-Samuel function $H_{I}(n)$ of $R$ with respect to $I$ is defined as $H_{I}(n)=\ell_{R}\left(R / I^{n}\right)$. It is known that $H_{I}(n)$ is a polynomial function of $n$ of degree $d$, for large $n$. In particular, there exists a polynomial $P_{I}(x) \in \mathbb{Q}[x]$ such that $H_{I}(n)=P_{I}(n)$ for all large $n$. Write

$$
P_{I}(x)=e_{0}(I)\binom{x+d-1}{d}-e_{1}(I)\binom{x+d-2}{d-1}+\cdots+(-1)^{d} e_{d}(I)
$$

where $e_{i}(I)$ for $i=0,1, \ldots, d$ are integers, called the Hilbert coefficients of $I$. The leading coefficient $e_{0}(I)$ is called the multiplicity of $I$ and $e_{1}(I)$ is called the Chern number of $I$. We write $e_{0}(I):=e_{0}(I, R)$ and $e_{0}(R):=e_{0}(\mathfrak{m}, R)$. The postulation number of $I$ is defined as

$$
n(I)=\max \left\{n \mid H_{I}(n) \neq P_{I}(n)\right\} .
$$

The notion of reduction of an ideal was introduced by D. G. Northcott and D. Rees. Let $J \subseteq I$ be ideals of $R$. If $J I^{n}=I^{n+1}$ for some $n$, then $J$ is called a reduction of $I$. The reduction number $r_{J}(I)$ of $I$ with respect to $J$ is the smallest $n$ such that $J I^{n}=I^{n+1}$. The reduction number of $I$ is defined as

$$
r(I)=\min \left\{r_{J}(I) \mid J \text { is a minimal reduction of } I\right\} .
$$

Moreover, if $R / \mathfrak{m}$ is infinite, then minimal reduction of $I$ exists.
Let $\mathcal{R}(I)=\bigoplus_{n \geq 0} I^{n} t^{n}$ denote the Rees algebra of $I$. The Hilbert-Kunz multiplicity of various blowup algebras was estimated by K. Eto and K.-i. Yoshida in their paper [5]. Put $c(d)=(d / 2)+d /(d+1)$ !. They proved the following.

Theorem 1.2. Let $(R, \mathfrak{m})$ be a Noetherian local ring of prime characteristic $p>0$ with $d=\operatorname{dim} R \geq 1$. Then for any $\mathfrak{m}$-primary ideal $I$, we have

$$
e_{H K}(\mathcal{R}(I)) \leq c(d) e_{0}(I) .
$$

Moreover, equality holds if and only if $e_{H K}(R)=e_{0}(I)$. When this is the case, $e_{H K}(R)=e_{0}(R)$ and $e_{H K}(I)=e_{0}(I)$.

In this paper, we compute the Hilbert-Kunz function and the Hilbert-Kunz multiplicity of certain ideals of the Rees algebra. We begin with the case of one-dimensional Noetherian local rings of prime characteristic, where, motivated by the result of Monsky, we prove the quasi-polynomial nature of Hilbert-Kunz function for certain classes of ideals of the Rees algebra. For rings of dimension at least 2 , we prove that the generalized Hilbert-Kunz function is a piece-wise polynomial for certain class of ideals. The paper is organized as follows. In section 2, we begin by proving the following result.

Theorem 1.3. Let $(R, \mathfrak{m})$ be a 1-dimensional Noetherian local ring with prime characteristic $p>0$. Let $I$, $J$ be $\mathfrak{m}$-primary ideals. Then $e_{H K}((J, I t) \mathcal{R}(I))=e_{0}(J)$.

Next, we prove that the Hilbert-Kunz function of the ideal $(I, I t)$ of the Rees algebra $\mathcal{R}(I)$, where $I$ is an $\mathfrak{m}$-primary ideal of a 1 -dimensional ring, is a quasi-polynomial in $e$, for large $e$. Recall that a quasipolynomial of degree $d$ is a function $f: \mathbb{Z} \rightarrow \mathbb{C}$ of the form

$$
f(n)=c_{d}(n) n^{d}+c_{d-1}(n) n^{d-1}+\cdots+c_{0}(n)
$$

where each $c_{i}(n)$ is a periodic function and $c_{d}(n)$ is not identically zero. Equivalently, $f$ is a quasipolynomial if there exists an integer $N>0$ (namely, a common period of $c_{0}, c_{1}, \ldots, c_{d}$ ) and polynomials $f_{0}, f_{1}, \ldots, f_{N-1}$ such that $f(n)=f_{i}(n)$ if $n \equiv i(\bmod N)$ (see [16]).

Theorem 1.4. Let $R$ be a 1-dimensional Noetherian local ring with prime characteristic $p>0$. Let $I$ be an $\mathfrak{m -}$ primary ideal. Let $r$ be the reduction number of $I$ and $\rho$ be the postulation number of $I$. Put $\mathcal{I}=(I, I t) \mathcal{R}(I)$. Let $q=p^{e}$, where $e \in \mathbb{N}$ is large.
(1) If $\rho+1 \leq r$, then

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}[q]}\right)=e_{0}(I) q^{2}-e_{0}(I)\binom{r}{2}+r e_{1}(I)+\sum_{n=0}^{r-1} \ell_{R}\left(\frac{R}{I^{n}}\right)+2 \sum_{n=0}^{r-1} \alpha_{I}\left(I^{n}, e\right) .
$$

(2) If $r<\rho+1$, then

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}[q]}\right)=e_{0}(I) q^{2}-e_{0}(I)\left(r(r-1)-\frac{\rho(\rho+1)}{2}\right)+(2 r-\rho-1) e_{1}(I)+\beta+2 \sum_{n=0}^{r-1} \alpha_{I}\left(I^{n}, e\right)
$$

where $\beta=\sum_{n=0}^{r-1} \ell_{R}\left(\frac{R}{I^{n}}\right)-\sum_{n=r}^{\rho} \ell_{R}\left(\frac{R}{I^{n}}\right)$ is a constant and $\alpha_{I}\left(I^{n}, e\right)=\ell_{R}\left(I^{n} / I^{[q]} I^{n}\right)-e_{0}(I) q$ is a periodic function in $e$, for large $e$. In other words, $\ell_{R}\left(\mathcal{R}(I) / \mathcal{I}^{[q]}\right)$ is a quasi-polynomial for large $e$.

In the above setup, if $I$ is a parameter ideal and $J$ is an $\mathfrak{m}$-primary ideal of a Cohen-Macaulay local ring $R$, then we prove that for large $e$,

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{(J, I t)^{[q]}}\right)=q^{2} e_{0}(J)+q \alpha_{J}(e)
$$

where $\alpha_{J}(e)=\ell_{R}\left(R / J^{[q]}\right)-e_{0}(J) q$ is a periodic function of $e$. Let $R=k[[X, Y]] /\left(X^{5}-Y^{5}\right)$, where $k$ is a field of prime characteristic $p \equiv \pm 2(\bmod 5)$ and $\mathfrak{m}$ is the maximal ideal of $R$. As a consequence of the
above results, we compute the Hilbert-Kunz function of the ideals $(\mathfrak{m}, \mathfrak{m} t) \mathcal{R}(\mathfrak{m})$ and $(\mathfrak{m}, I t) \mathcal{R}(I)$, where $I=(x)$ is a parameter ideal and $x$ is the image of $X$ in $R$.
Let $R$ be a $d$-dimensional Noetherian ring. Let $I$ be an ideal of finite co-length. Aldo Conca introduced the concept of generalized Hilbert-Kunz function in [4]. For $s \in \mathbb{N}$, let $I^{[s]}=\left(a_{1}^{s}, \ldots, a_{n}^{s}\right)$ where $\left\{a_{1}, a_{2}, \ldots, a_{n}\right\}$ is a fixed set of generators of $I$. Then the generalized Hilbert-Kunz function is defined as

$$
H K_{R, I}(s)=\ell_{R}\left(\frac{R}{I^{[s]}}\right) .
$$

The generalized Hilbert-Kunz multiplicity is defined as $\lim _{s \rightarrow \infty} H K_{R, I}(s) / s^{d}$ whenever the limit exists. If $\operatorname{char}(R)=p>0$ and $q$ is a power of $p$, then the generalized Hilbert-Kunz function (multiplicity) coincides with the Hilbert-Kunz function (multiplicity) and is independent of the choice of the generators of $I$. In section 3, we find the generalized Hilbert-Kunz function of the ideal $\mathcal{I}=(I, I t)$ in $\mathcal{R}(I)$, when $I$ is generated by a regular sequence in a $d$-dimensional Cohen-Macaulay local ring. Our approach requires knowledge of the Hilbert-Samuel function of the $R$-module $I^{[s]}$. We obtain an explicit description of the function $F(s, n)=\ell_{R}\left(I^{[s]} / I^{[s]} I^{n}\right)$ for a fixed $s \in \mathbb{N}$ and then use some properties of Stirling numbers of the first kind and Stirling numbers of the second kind to prove the following result.

Theorem 1.5. Let $R$ be a d-dimensional Cohen-Macaulay local ring and $d \geq 2$. Let I be a parameter ideal of $R$ and $\mathcal{I}=(I, I t) \mathcal{R}(I)$. Put $c(d)=(d / 2)+d /(d+1)!$. Let $s \in \mathbb{N}$.
(1) Let $s<d$. Write $d=k_{1} s+k_{2}$ where $k_{2} \in\{0,1, \ldots, s-1\}$. If $k_{2}=0$, then

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}^{[s]}}\right)=e_{0}(I)\left[\left(d-k_{1}+1\right) s^{d+1}+d\binom{s+d-1}{d+1}-\sum_{i=0}^{d-1}\left[(-1)^{i}\binom{d}{i}\binom{\left(d-i-k_{1}+1\right) s+d-1}{d+1}\right]\right] .
$$

If $k_{2} \neq 0$, then

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}^{[s]}}\right)=e_{0}(I)\left[\left(d-k_{1}\right) s^{d+1}+d\binom{s+d-1}{d+1}-\sum_{i=0}^{d-1}\left[(-1)^{i}\binom{d}{i}\binom{\left(d-i-k_{1}\right) s+d-1}{d+1}\right]\right] .
$$

(2) Let $s \geq d$. Then

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}^{[s]}}\right)=e_{0}(I)\left[\frac{d s^{d+1}}{2}-\frac{s^{d}(d-2)}{2}+d\binom{s+d-1}{d+1}\right] .
$$

In other words, for s large,

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}^{[s]}}\right)=c(d) e_{0}(I) s^{d+1}+e_{0}(I)\left(\frac{d-2}{2}\right)\left(\frac{1}{(d-1)!}-1\right) s^{d}+e_{0}(I) \frac{d(d-1)(3 d-10)}{24(d-1)!} s^{d-1}+\cdots,
$$

implying that the generalized Hilbert-Kunz multiplicity $e_{H K}((I, I t) \mathcal{R}(I))=c(d) e_{0}(I)$.
As a consequence, we obtain the following result.
Corollary 1.6. Let $(R, \mathfrak{m})$ be a $d$-dimensional regular local ring with $d \geq 2$. Then for $s \geq d$,

$$
\ell_{R}\left(\frac{\mathcal{R}(\mathfrak{m})}{(\mathfrak{m}, \mathfrak{m} t)^{[s]}}\right)=\frac{d s^{d+1}}{2}-\frac{s^{d}(d-2)}{2}+d\binom{s+d-1}{d+1} .
$$

In [1], we continue our exploration of the nature of Hilbert-Kunz function, where we give an expression of the generalized Hilbert-Kunz function of the maximal ideal of the Rees algebra of the maximal ideal of Stanley-Reisner rings. A precise formula for the Hilbert-Samuel multiplicity of ideals of the Rees algebra was computed, in terms of mixed multiplicities, in [20]. It is natural to ask if there is a parallel notion of mixed Hilbert-Kunz multiplicities and if the Hilbert-Kunz multiplicity can be expressed in terms of these numbers. This is still an open question.

## 2. The Hilbert-Kunz function in dimension 1

Let $(R, \mathfrak{m})$ be a 1-dimensional Noetherian local ring with prime characteristic $p>0$. In this section, we calculate the Hilbert-Kunz function and Hilbert-Kunz multiplicity of certain ideals of the Rees ring $\mathcal{R}(I)$, where $I$ is an $\mathfrak{m}$-primary ideal of $R$.
Let $I, J$ be $\mathfrak{m}$-primary ideals of $R$. We begin by calculating $e_{H K}((J, I t) \mathcal{R}(I))$, the Hilbert-Kunz multiplicity of the ideal $(J, I t)$ in $\mathcal{R}(I)$. Recall that if a Noetherian ring $R$ has prime characteristic $p$, then $x \in R$ is said to be in the tight closure $I^{*}$ of an ideal $I$ if there exists $c \in R^{0}:=\{a \in R \mid a \notin \mathfrak{p}$ for any minimal prime $\mathfrak{p} \subset R\}$ such that $c x^{q} \in I^{[q]}$ for all large $q=p^{e}$. In [10, Theorem 8.17(a)], M. Hochster and C. Huneke proved that if $J \subseteq I$ are $\mathfrak{m}$-primary ideals of $R$ such that $I^{*}=J^{*}$, then $e_{H K}(I)=e_{H K}(J)$.
For an ideal $I$ in a ring $R$, the integral closure of $I$, denoted by $\bar{I}$, is the ideal which consists of elements $x \in R$ such that $x$ satisfies an equation of the form $x^{n}+a_{1} x^{n-1}+\cdots+a_{n}=0$ for some $a_{i} \in I^{i}, 1 \leq i \leq n$. The following generalization of the Briançon-Skoda theorem was given by Hochster and Huneke.

Theorem 2.1 ([10, Theorem 5.4]). Let $R$ be a Noetherian ring of prime characteristic $p$ and let $I$ be an ideal of positive height generated by $n$ elements. Then for every $m \in \mathbb{N}, \overline{I^{n+m}} \subseteq\left(I^{m+1}\right)^{*}$.

It now follows that the tight closure and integral closure of principal ideals coincide.
Theorem 2.2. Let $(R, \mathfrak{m})$ be a 1-dimensional Noetherian local ring with prime characteristic $p>0$. Let $I$, $J$ be $\mathfrak{m}$-primary ideals. Then $e_{Н К}((J, I t) \mathcal{R}(I))=e_{0}(J)$.

Proof. If $R$ does not have an infinite residue field, we pass to a general extension $S=R[x]_{\mathfrak{m}[x]}$ of $R$, where $x$ is an indeterminate. Note that $S$ has an infinite residue field. Since $S / R$ is a faithfully flat extension, it follows that for all $q=p^{e}, e \in \mathbb{N}$,

$$
\ell\left(\frac{\mathcal{R}(I)}{(J, I t)^{[q]} \mathcal{R}(I)}\right)=\ell\left(\frac{\mathcal{R}(I) \otimes_{R} S}{(J, I t)^{[q]}\left(\mathcal{R}(I) \otimes_{R} S\right)}\right)=\ell\left(\frac{\mathcal{R}\left(I \otimes_{R} S\right)}{(J, I t)^{[q]} \mathcal{R}\left(I \otimes_{R} S\right)}\right) .
$$

Hence, $e_{H K}((J, I t) \mathcal{R}(I))=e_{H K}\left((J, I t) \mathcal{R}\left(I \otimes_{R} S\right)\right)$.
Therefore, we may assume that $R$ has an infinite residue field. Let $(x),(y)$ be minimal reductions of $J$ and $I$ respectively in $R$. We claim that $e_{H K}((J, I t) \mathcal{R}(I))=e_{H K}((x, y t) \mathcal{R}(I))$. Note that it is sufficient to show that $((J, I t) \mathcal{R}(I))^{*}=((x, y t) \mathcal{R}(I))^{*}$. Using generalized Briançon-Skoda theorem, it follows that
$((x) \mathcal{R}(I))^{*}=\overline{(x) \mathcal{R}(I)}$ and $((y t) \mathcal{R}(I))^{*}=\overline{(y t) \mathcal{R}(I)}$. As $(x) \mathcal{R}(I)$ and $(y t) \mathcal{R}(I)$ are reductions of $J \mathcal{R}(I)$ and $(I t) \mathcal{R}(I)$ respectively, we have

$$
((x) \mathcal{R}(I))^{*}=\overline{(x) \mathcal{R}(I)}=\overline{J \mathcal{R}(I)} \text { and }((y t) \mathcal{R}(I))^{*}=\overline{(y t) \mathcal{R}(I)}=\overline{(I t) \mathcal{R}(I)}
$$

Since $\overline{J \mathcal{R}(I)}=((x) \mathcal{R}(I))^{*} \subseteq(J \mathcal{R}(I))^{*}$, we get $((x) \mathcal{R}(I))^{*}=(J \mathcal{R}(I))^{*}$. Similarly, $((y t) \mathcal{R}(I))^{*}=((I t) \mathcal{R}(I))^{*}$. Consider

$$
((x, y t) \mathcal{R}(I))^{*}=\left(((x) \mathcal{R}(I))^{*}+((y t) \mathcal{R}(I))^{*}\right)^{*}=\left((J \mathcal{R}(I))^{*}+((I t) \mathcal{R}(I))^{*}\right)^{*}=((J, I t) \mathcal{R}(I))^{*} .
$$

This proves the claim. Therefore, $e_{H K}((J, I t) \mathcal{R}(I))=e_{H K}((x, y t) \mathcal{R}(I))$. As $x, y t$ form a system of parameters in $\mathcal{R}(I)_{(\mathfrak{m}, I t)}$, it follows that

$$
e_{\text {НК }}((J, I t) \mathcal{R}(I))=e_{\text {НК }}((x, y t) \mathcal{R}(I))=e_{0}((x, y t) \mathcal{R}(I))=e_{0}((J, I t) \mathcal{R}(I))=e_{0}(J),
$$

where the last equality follows from [20, Theorem 3.1].
Let $I$ be an m-primary ideal of $R$. We prove that $\ell_{R}\left(\mathcal{R}(I) /(I, I t)^{\left[p^{e}\right]}\right)$ is a quasi-polynomial in $e$, for large $e$.
Theorem 2.3. Let $(R, \mathfrak{m})$ be a 1-dimensional Noetherian local ring with prime characteristic $p>0$. Let $I$ be an $\mathfrak{m}$-primary ideal. Let $r$ be the reduction number of I and $\rho$ be the postulation number of $I$. Put $\mathcal{I}=(I, I t) \mathcal{R}(I)$. Let $q=p^{e}$, where $e \in \mathbb{N}$ is large.
(1) If $\rho+1 \leq r$, then

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}[q]}\right)=e_{0}(I) q^{2}-e_{0}(I)\binom{r}{2}+e_{1}(I) r+\sum_{n=0}^{r-1} \ell_{R}\left(\frac{R}{I^{n}}\right)+2 \sum_{n=0}^{r-1} \alpha_{I}\left(I^{n}, e\right) .
$$

(2) If $r<\rho+1$, then

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}[q]}\right)=e_{0}(I) q^{2}-e_{0}(I)\left(r(r-1)-\frac{\rho(\rho+1)}{2}\right)+(2 r-\rho-1) e_{1}(I)+\beta+2 \sum_{n=0}^{r-1} \alpha_{I}\left(I^{n}, e\right),
$$

where $\beta=\sum_{n=0}^{r-1} \ell_{R}\left(\frac{R}{I^{n}}\right)-\sum_{n=r}^{\rho} \ell_{R}\left(\frac{R}{I^{n}}\right)$ is a constant and $\alpha_{I}\left(I^{n}, e\right)=\ell_{R}\left(I^{n} / I^{[q]} I^{n}\right)-e_{0}(I) q$ is a periodic function in $e$, for large $e$. In other words, $\ell_{R}\left(\mathcal{R}(I) / \mathcal{I}^{[q]}\right)$ is a quasi-polynomial for large $e$.

Proof. If $R$ does not have an infinite residue field, we pass to a general extension $S=R[x]_{\mathfrak{m}[x]}$ of $R$, where $x$ is an indeterminate. Note that $S$ has an infinite residue field. Since $S / R$ is a faithfully flat extension, it follows that for all $q=p^{e}, e \in \mathbb{N}$,

$$
\ell\left(\frac{\mathcal{R}(I)}{(I, I t)^{[q]} \mathcal{R}(I)}\right)=\ell\left(\frac{\mathcal{R}(I) \otimes_{R} S}{(I, I t)^{[q]}\left(\mathcal{R}(I) \otimes_{R} S\right)}\right)=\ell\left(\frac{\mathcal{R}\left(I \otimes_{R} S\right)}{(I, I t)^{[q]} \mathcal{R}\left(I \otimes_{R} S\right)}\right)
$$

Therefore, we may assume that $R$ has an infinite residue field. Fix $q=p^{e}$ large. Observe that

$$
\mathcal{I}^{[q]}=\left(I^{[q]}, I^{[q]} t^{q}\right)=\left(\bigoplus_{n=0}^{q-1} I^{[q]} I^{n} t^{n}\right)+\left(\bigoplus_{n \geq q} I^{[q]} I^{n-q} t^{n}\right)
$$

Let $(x)$ be a minimal reduction of $I$ and let $r$ be the reduction number of $I$. Then $x^{k} I^{l}=I^{k+l}$ for all $k \geq 1$ and $l \geq r$. Write $I=x+J$, for some ideal $J \subseteq I$. Then $I^{[q]} I^{n-q}=\left(x^{q}+J^{[q]}\right) I^{n-q}=I^{n}$, for all $n \geq q+r$. Therefore,

$$
\mathcal{I}^{[q]}=\left(\bigoplus_{n=0}^{q-1} I^{[q]} I^{n} t^{n}\right)+\left(\bigoplus_{n=q}^{q+r-1} I^{[q]} I^{n-q} t^{n}\right)+\left(\bigoplus_{n \geq q+r} I^{n} t^{n}\right)
$$

and hence

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}[q]}\right)=\sum_{n=0}^{r-1} \ell_{R}\left(\frac{I^{n}}{I^{[q]} I^{n}}\right)+\sum_{n=r}^{q-1} \ell_{R}\left(\frac{I^{n}}{I^{[q]} I^{n}}\right)+\sum_{n=q}^{q+r-1} \ell_{R}\left(\frac{I^{n}}{I^{[q]} I^{n-q}}\right) .
$$

Writing $\ell_{R}\left(I^{n} / I^{[q]} I^{n}\right)=\ell_{R}\left(R / I^{[q]} I^{n}\right)-\ell_{R}\left(R / I^{n}\right)$, we get

$$
\begin{aligned}
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}[q]}\right) & =\sum_{n=0}^{r-1} \ell_{R}\left(\frac{I^{n}}{I[q] I^{n}}\right)+\sum_{n=r}^{q-1} \ell_{R}\left(\frac{R}{I[q] I^{n}}\right)+\sum_{n=q}^{q+r-1} \ell_{R}\left(\frac{R}{I[q] I^{n-q}}\right)-\sum_{n=r}^{q+r-1} \ell_{R}\left(\frac{R}{I^{n}}\right) \\
& =\sum_{n=0}^{r-1} \ell_{R}\left(\frac{I^{n}}{I[q] I^{n}}\right)+\sum_{n=r}^{q-1} \ell_{R}\left(\frac{R}{I[q] I^{n}}\right)+\sum_{n=0}^{r-1} \ell_{R}\left(\frac{R}{I[q] I^{n}}\right)-\sum_{n=r}^{q+r-1} \ell_{R}\left(\frac{R}{I^{n}}\right) \\
& =2 \sum_{n=0}^{r-1} \ell_{R}\left(\frac{I^{n}}{I^{[q]} I^{n}}\right)+\sum_{n=r}^{q-1} \ell_{R}\left(\frac{R}{I[q] I^{n}}\right)+\sum_{n=0}^{r-1} \ell_{R}\left(\frac{R}{I^{n}}\right)-\sum_{n=r}^{q+r-1} \ell_{R}\left(\frac{R}{I^{n}}\right) .
\end{aligned}
$$

For $n \geq r, I^{[q]} I^{n}=\left(x^{q}+J^{[q]}\right) I^{n}=I^{n+q}$. If the given ring is not complete, we may pass to its $\mathfrak{m}$-adic completion $\hat{R}$ and use the fact that $\hat{R}$ is a faithfully flat extension of $R$. Now use [13, Theorem 3.11], to write $\ell_{R}\left(I^{n} / I^{[q]} I^{n}\right)=e_{0}\left(I, I^{n}\right) q+\alpha_{I}\left(I^{n}, e\right)$, where $\alpha_{I}\left(I^{n}, e\right)$ is a periodic function of $e$. Using the associativity formula for $e_{0}(I)$, one may check that $e_{0}\left(I, I^{n}\right)=e_{0}(I, R)$. Thus,

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}[q]}\right)=2 \sum_{n=0}^{r-1}\left(e_{0}(I) q+\alpha_{I}\left(I^{n}, e\right)\right)+\sum_{n=r}^{q-1} \ell_{R}\left(\frac{R}{I^{n+q}}\right)+\sum_{n=0}^{r-1} \ell_{R}\left(\frac{R}{I^{n}}\right)-\sum_{n=r}^{q+r-1} \ell_{R}\left(\frac{R}{I^{n}}\right) .
$$

Since evaluation of the expression $\sum_{n=r}^{q+r-1} \ell_{R}\left(\frac{R}{I^{n}}\right)$ depends on the relation between $r$ and $\rho$, we have the following cases:
Case 1: Let $\rho+1 \leq r$. Then $\ell_{R}\left(R / I^{n}\right)=e_{0}(I) n-e_{1}(I)$, for all $n \geq r$. Hence,

$$
\begin{aligned}
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}^{[q]}}\right) & =2 r q e_{0}(I)+2 \sum_{n=0}^{r-1} \alpha_{I}\left(I^{n}, e\right)+\sum_{n=r+q}^{2 q-1}\left(e_{0}(I) n-e_{1}(I)\right)+\sum_{n=0}^{r-1} \ell_{R}\left(\frac{R}{I^{n}}\right)-\sum_{n=r}^{q+r-1}\left(e_{0}(I) n-e_{1}(I)\right) \\
& =2 r q e_{0}(I)+2 \sum_{n=0}^{r-1} \alpha_{I}\left(I^{n}, e\right)+e_{0}(I)\left[\binom{2 q}{2}-2\binom{r+q}{2}+\binom{r}{2}\right]+e_{1}(I) r+\sum_{n=0}^{r-1} \ell_{R}\left(\frac{R}{I^{n}}\right) .
\end{aligned}
$$

Here, we use the fact that for any $a, b \in \mathbb{N}, \sum_{a}^{b-1} n=\binom{b}{2}-\binom{a}{2}$. Since $2 r q+\binom{2 q}{2}-2\binom{r+q}{2}+\binom{r}{2}=$ $q^{2}-\binom{r}{2}$, we get

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}[q]}\right)=e_{0}(I) q^{2}-e_{0}(I)\binom{r}{2}+e_{1}(I) r+\sum_{n=0}^{r-1} \ell_{R}\left(\frac{R}{I^{n}}\right)+2 \sum_{n=0}^{r-1} \alpha_{I}\left(I^{n}, e\right) .
$$

Case 2: Let $r<\rho+1$. Then $\ell_{R}\left(R / I^{n}\right)=e_{0}(I) n-e_{1}(I)$, for all $n \geq \rho+1$ and $\sum_{n=r}^{\rho} \ell_{R}\left(R / I^{n}\right)$ is a constant. Hence,

$$
\begin{array}{r}
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}[q]}\right)=2 r q e_{0}(I)+2 \sum_{n=0}^{r-1} \alpha_{I}\left(I^{n}, e\right)+\sum_{n=r+q}^{2 q-1}\left(e_{0}(I) n-e_{1}(I)\right)+\sum_{n=0}^{r-1} \ell_{R}\left(\frac{R}{I^{n}}\right)-\sum_{n=r}^{\rho} \ell_{R}\left(\frac{R}{I^{n}}\right) \\
- \\
-\sum_{n=\rho+1}^{q+r-1}\left(e_{0}(I) n-e_{1}(I)\right) .
\end{array}
$$

Rearranging the terms, we get

$$
\begin{aligned}
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}[q]}\right) & =2 r q e_{0}(I)+2 \sum_{n=0}^{r-1} \alpha_{I}\left(I^{n}, e\right)+e_{0}(I)\left[\binom{2 q}{2}-2\binom{r+q}{2}+\binom{\rho+1}{2}\right]+(2 r-\rho-1) e_{1}(I)+\beta \\
& =e_{0}(I) q^{2}-e_{0}(I)\left(r(r-1)-\frac{\rho(\rho+1)}{2}\right)+(2 r-\rho-1) e_{1}(I)+\beta+2 \sum_{n=0}^{r-1} \alpha_{I}\left(I^{n}, e\right),
\end{aligned}
$$

where $\beta=\sum_{n=0}^{r-1} \ell_{R}\left(\frac{R}{I^{n}}\right)-\sum_{n=r}^{\rho} \ell_{R}\left(\frac{R}{I^{n}}\right)$ is a constant. Let $N$ be a common period of $\alpha_{I}\left(I^{n}, e\right)$, for $0 \leq n \leq$ $r-1$. Then it follows that $\ell_{R}\left(\mathcal{R}(I) / \mathcal{I}^{[q]}\right)-e_{0}(I) q^{2}$ is a periodic function of $e$. In other words, $\ell_{R}\left(\mathcal{R}(I) / \mathcal{I}^{[q]}\right)$ is a quasi-polynomial in $e$, for large $e$.

In particular, if $R$ is a 1-dimensional Cohen-Macaulay local ring we get the following result.
Corollary 2.4. Let $(R, \mathfrak{m})$ be a 1-dimensional Cohen-Macaulay local ring with prime characteristic $p>0$. Let I be an $\mathfrak{m}$-primary ideal. Let $r$ be the reduction number of I. Put $\mathcal{I}=(I, I t) \mathcal{R}(I)$. Then for $q=p^{e}$, where $e \in \mathbb{N}$ is large,

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}^{[q]}}\right)=e_{0}(I) q^{2}-e_{0}(I)\binom{r}{2}+e_{1}(I) r+\sum_{n=0}^{r-1} \ell_{R}\left(\frac{R}{I^{n}}\right)+2 \sum_{n=0}^{r-1} \alpha_{I}\left(I^{n}, e\right)
$$

where $\alpha_{I}\left(I^{n}, e\right)=\ell_{R}\left(I^{n} / I^{[q]} I^{n}\right)-e_{0}(I) q$ is a periodic function in e, for large e. In other words, $\ell_{R}\left(\mathcal{R}(I) / \mathcal{I}^{[q]}\right)$ is a quasi-polynomial for large e.

Proof. Since $R$ is Cohen-Macaulay, using [12, Theorem 2.15] it follows that the postulation number of $I$, $\rho=r-1$. Substitute the same in Theorem 2.3 to conclude.

Next, we calculate the Hilbert-Kunz function of the ideal $\mathcal{J}=(J, I t) \mathcal{R}(I)$ when $I$ is a parameter ideal and $J$ is an $\mathfrak{m}$-primary ideal of a Cohen-Macaulay ring $R$.

Theorem 2.5. Let $(R, \mathfrak{m})$ be a 1-dimensional Cohen-Macaulay local ring with prime characteristic $p>0$. Let $I=\left(\right.$ a) be a parameter ideal and $J$ be an $\mathfrak{m}$-primary ideal. Put $\mathcal{J}=(J, I t) \mathcal{R}(I)$. Then for $q=p^{e}$, where $e \in \mathbb{N}$ is large,

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{J}[q]}\right)=q^{2} e_{0}(J)+q \alpha_{J}(e)
$$

where $\alpha_{J}(e)=\ell_{R}\left(R / J^{[q]}\right)-e_{0}(J) q$ is a periodic function of $e$.
Proof. Observe that

$$
\mathcal{J}^{[q]}=\left(J^{[q]}, I^{[q]} t^{q}\right)=\left(\bigoplus_{n=0}^{q-1} J^{[q]}\left(a^{n}\right) t^{n}\right)+\left(\bigoplus_{n \geq q}\left(a^{n}\right) t^{n}\right)
$$

which implies that

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{J}[q]}\right)=\sum_{n=0}^{q-1} \ell_{R}\left(\frac{\left(a^{n}\right)}{J^{[q]}\left(a^{n}\right)}\right)=q \ell_{R}\left(\frac{R}{J^{[q]}}\right)=e_{0}(J) q^{2}+q \alpha_{J}(e) .
$$

We illustrate the above results in the following example.
Example 2.6. Let $R=k[[X, Y]] /\left(X^{5}-Y^{5}\right)$, where $k$ is a field of prime characteristic $p \equiv \pm 2(\bmod 5)$. Let $\mathfrak{m}$ be the maximal ideal of $R$. Put $q=p^{e}$ for some $e \in \mathbb{N}$. Monsky [13] showed that for large $e$, $\ell_{R}\left(R / \mathfrak{m}^{[q]}\right)=5 q+\alpha_{\mathfrak{m}}(e)$, where $\alpha_{\mathfrak{m}}(e)=-4$ when $e$ is even and $\alpha_{\mathfrak{m}}(e)=-6$ when $e$ is odd.
(1) We first calculate $\ell_{R}\left(\mathcal{R}(\mathfrak{m}) /(\mathfrak{m}, \mathfrak{m} t)^{[q]}\right)$. It is easy to check that $e_{0}(\mathfrak{m})=5$ and $e_{1}(\mathfrak{m})=10$. Let $I=(x)$, where $x$ denotes the image of $X$ in $R$. Then $I$ is a minimal reduction of $\mathfrak{m}$ and $r(\mathfrak{m})=4$. Using Corollary 2.4, it follows that

$$
\begin{equation*}
\ell_{R}\left(\frac{\mathcal{R}(\mathfrak{m})}{(\mathfrak{m}, \mathfrak{m} t)^{[q]}}\right)=5 q^{2}+10+\sum_{n=0}^{3} \ell_{R}\left(\frac{R}{\mathfrak{m}^{n}}\right)+2 \sum_{n=0}^{3} \alpha_{\mathfrak{m}}\left(\mathfrak{m}^{n}, e\right)=5 q^{2}+20+2 \sum_{n=0}^{3} \alpha_{\mathfrak{m}}\left(\mathfrak{m}^{n}, e\right) \tag{2.1}
\end{equation*}
$$

For an $R$-ideal $J$, let $\mu(J)$ denote the minimal number of generators of $J$. For $n=1,2,3$, writing

$$
\ell_{R}\left(\frac{\mathfrak{m}^{n}}{\mathfrak{m}^{[q]} \mathfrak{m}^{n}}\right)=\ell_{R}\left(\frac{\mathfrak{m}^{[q]}}{\mathfrak{m}^{[q]} \mathfrak{m}^{n}}\right)-\ell_{R}\left(\frac{R}{\mathfrak{m}^{n}}\right)+\ell_{R}\left(\frac{R}{\mathfrak{m}^{[q]}}\right)=\sum_{i=0}^{n-1} \mu\left(\mathfrak{m}^{[q]} \mathfrak{m}^{i}\right)-\ell_{R}\left(\frac{R}{\mathfrak{m}^{n}}\right)+\ell_{R}\left(\frac{R}{\mathfrak{m}^{[q]}}\right),
$$

we obtain

$$
\alpha_{\mathfrak{m}}(\mathfrak{m}, e)=\left\{\begin{array}{ll}
-3 & \text { if } e \text { is even } \\
-5 & \text { if } e \text { is odd, }
\end{array} \quad \alpha_{\mathfrak{m}}\left(\mathfrak{m}^{2}, e\right)=\left\{\begin{array}{ll}
-2 & \text { if } e \text { is even } \\
-3 & \text { if } e \text { is odd },
\end{array} \quad \alpha_{\mathfrak{m}}\left(\mathfrak{m}^{3}, e\right)=-1\right.\right.
$$

Substituting in (2.1), we get $\ell_{R}\left(\mathcal{R}(\mathfrak{m}) /(\mathfrak{m}, \mathfrak{m} t)^{[q]}\right)=5 q^{2}+\beta_{e}$, where $\beta_{e}=0$ when $e$ is even and $\beta_{e}=-10$ when $e$ is odd.
(2) We now calculate $\ell_{R}\left(\mathcal{R}(I) /(\mathfrak{m}, I t)^{[q]}\right)$. Using Theorem 2.5 , we get

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{(\mathfrak{m}, I t)^{[q]}}\right)=e_{0}(\mathfrak{m}) q^{2}+q \alpha_{\mathfrak{m}}(e)=5 q^{2}+ \begin{cases}-4 q & \text { if } e \text { is even } \\ -6 q & \text { if } e \text { is odd }\end{cases}
$$

One can also verify this using the following arguments. Observe that $\mathcal{R}(I) \simeq k[[X, Y]][Z] /\left(X^{5}-Y^{5}\right)$. In order to find $\ell\left(k[X, Y, Z] /\left(X^{5}-Y^{5}, X^{q}, Y^{q}, Z^{q}\right)\right)$, we find the Gröbner basis of the ideal $M_{q}=\left(X^{5}-\right.$ $\left.Y^{5}, X^{q}, Y^{q}, Z^{q}\right)$ in $k[X, Y, Z]$. Let ' $>$ ' be any monomial ordering on $k[X, Y, Z]$ with $X>Y>Z$. Since $q$ is large, the $S$-polynomials are:

$$
S\left(X^{5}-Y^{5}, X^{q}\right)=X^{q-5} Y^{5}, \quad S\left(X^{5}-Y^{5}, X^{q-5} Y^{5}\right)=X^{q-10} Y^{10}, \ldots
$$

Therefore, Gröbner basis of $M_{q}$ is $G=\left\{X^{5}-Y^{5}, X^{q}, Y^{q}, Z^{q}, X^{q-5 i} Y^{5 i} \mid q-5 i>0\right\}$. Observe that

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{(\mathfrak{m}, I t)^{[q]}}\right)=\ell\left(\frac{k[X, Y, Z]}{\operatorname{in}_{>}\left(M_{q}\right)}\right)=\ell\left(\frac{k[X, Y, Z]}{\left(X^{5}, Y^{q}, Z^{q}, X^{q-5 i} Y^{5 i} \mid q-5 i<5\right)}\right) .
$$

We now explore the condition $q-5 i$ such that $q-5 i<5$. Since $q$ is of the form $(5 k+2)^{e}$ or $(5 k+3)^{e}$ for some $k, e \in \mathbb{N}$, it is sufficient to find the values $(5 k+2)^{e}$ modulo 5 and $(5 k+3)^{e}$ modulo 5 . First, consider the case $(5 k+2)^{e}$ modulo 5 . Using the binomial theorem, we only need to find $2^{e}(\bmod 5)$.
If $e$ is even, then $2^{e} \equiv 1,4(\bmod 5)$. This implies that $X^{q-5 i} Y^{5 i}=X Y^{q-1}$ or $X^{q-5 i} Y^{5 i}=X^{4} Y^{q-4}$. In either of the case, we get $\ell_{R}\left(\mathcal{R}(I) /(\mathfrak{m}, I t)^{[q]}\right)=5 q^{2}-4 q$.
If $e$ is odd, then $2^{e} \equiv 2,3(\bmod 5)$. This implies that $X^{q-5 i} Y^{5 i}=X^{2} Y^{q-2}$ or $X^{q-5 i} Y^{5 i}=X^{3} Y^{q-3}$. In either of the case, $\ell_{R}\left(\mathcal{R}(I) /(\mathfrak{m}, I t)^{[q]}\right)=5 q^{2}-6 q$. We get the same conclusion in the case $(5 k+3)^{e}$ modulo 5 .

## 3. The Hilbert-Kunz function in dimension $\geq 2$.

In this section, we find the generalized Hilbert-Kunz function of the ideal $(I, I t) \mathcal{R}(I)$, where $I$ is a parameter ideal in a Cohen-Macaulay local ring. It turns out that in this case, the generalized Hilbert-Kunz function is eventually a polynomial.
Let $R$ be a Cohen-Macaulay Stanley-Reisner ring of a simplicial complex over an infinite field with prime characteristic $p>0$. Let $\mathfrak{m}$ be the maximal homogeneous ideal of $R$ and $I$ be an ideal generated by a linear system of parameters. It is proved in [7, Theorem 6.1] that $\mathfrak{m}=I^{*}$. Therefore, using [5, Corollary 4.5] we get $e_{H K}((\mathfrak{m}, \mathfrak{m} t) \mathcal{R}(\mathfrak{m}))=e_{H K}((I, I t) \mathcal{R}(I))$. Thus in order to calculate $e_{H K}(\mathcal{R}(\mathfrak{m}))$, it is sufficient to calculate $e_{H K}((I, I t) \mathcal{R}(I))$. This observation motivated us to consider the following setup.
Let $R$ be a Cohen-Macaulay local ring and $I$ be a parameter ideal. Let $G(I)=\oplus_{n \geq 0} I^{n} / I^{n+1}$ denote the associated graded ring of $I$. Fix $s \in \mathbb{N}$. For a fixed set of generators of $I$, define functions

$$
F(s, n):=H_{I}\left(I^{[s]}, n\right)=\ell_{R}\left(\frac{I^{[s]}}{I^{[s]} I^{n}}\right) \text { and } H(n):=H_{I}(R, n)=\ell_{R}\left(\frac{R}{I^{n}}\right)=e_{0}(I)\binom{n+d-1}{d}
$$

for all $n$. Note that if $R$ is 1-dimensional, then $F(s, n)=H(n)$ for all $n$.
We shall use the following result to find the reduction number of powers of an $\mathfrak{m}$-primary ideal.
Theorem 3.1 ([12, Corollary 2.21]). Let $(R, \mathfrak{m})$ be a d-dimensional Cohen-Macaulay local ring with infinite residue field and I be an $\mathfrak{m}$-primary ideal such that $\operatorname{grade}\left(G(I)_{+}\right) \geq d-1$. Then for $k \geq 1$,

$$
r\left(I^{k}\right)=\left\lfloor\frac{n(I)}{k}\right\rfloor+d
$$

Theorem 3.2. Let $R$ be a d-dimensional Cohen-Macaulay local ring and let I be a parameter ideal. Let $d \geq 2$. For a fixed $s \in \mathbb{N}$,

$$
F(s, n)= \begin{cases}d H(n) & \text { if } 1 \leq n \leq s  \tag{3.1}\\ \sum_{i=1}^{d-1}(-1)^{i+1}\binom{d}{i} H(n-(i-1) s) & \text { if } s+1 \leq n \leq(d-1) s-1, \\ H(n+s)-s^{d} e_{0}(I) & \text { if } n \geq(d-1) s .\end{cases}
$$

In particular, the function $F(s, n)$ is independent of the choice of generating set of $I$.
Proof. Case 1: Let $1 \leq n \leq s$. Let $I=\left(x_{1}, \ldots, x_{d}\right)$. Consider the following epimorphism

$$
\begin{aligned}
\left(\frac{R}{I^{n}}\right)^{\oplus d} & \stackrel{\phi}{\longrightarrow} \frac{I^{[s]}}{I^{[s]} I^{n}} \rightarrow 0 \\
\left(a_{1}+I^{n}, \ldots, a_{d}+I^{n}\right) & \mapsto\left(a_{1} x_{1}^{s}+\cdots+a_{d} x_{d}^{s}\right)+I^{[s]} I^{n} .
\end{aligned}
$$

Let $\left(a_{1}+I^{n}, \ldots, a_{d}+I^{n}\right) \in \operatorname{ker}(\phi)$. Then $a_{1} x_{1}^{s}+\cdots+a_{d} x_{d}^{s} \in I^{[s]} I^{n}$ implies that

$$
a_{1} x_{1}^{s}+\cdots+a_{d} x_{d}^{s}=b_{1} x_{1}^{s}+\cdots+b_{d} x_{d}^{s},
$$

where $b_{1}, \ldots, b_{d} \in I^{n}$. Since $x_{1}^{s}, \ldots, x_{d}^{s}$ is an $R$-regular sequence, it follows that $\left(a_{i}-b_{i}\right) \in I^{[s]} \subseteq I^{n}$ for all $i=1, \ldots, d$. Thus $a_{1}, \ldots, a_{d} \in I^{n}$. Therefore, $\operatorname{ker}(\phi)=0$ and $I^{[s]} / I^{[s]} I^{n} \simeq\left(R / I^{n}\right)^{\oplus d}$. Hence $F(s, n)=d H(n)$, for all $1 \leq n \leq s$.
Case 2: Let $s+1 \leq n \leq(d-1) s-1$. Let $x_{i}^{*}$ denote the image of $x_{i}$ in $I / I^{2}$, for all $i=1, \ldots, d$. As $G(I)$ is Cohen-Macaulay, $\left(\mathbf{x}^{*}\right)^{[s]}=\left(x_{1}^{s}\right)^{*}, \ldots,\left(x_{d}^{s}\right)^{*} \in I^{s} / I^{s+1}$ is a $G(I)$-regular sequence. Hence the following exact sequence is obtained from the Koszul complex of $G(I)$ with respect to $\left(\mathbf{x}^{*}\right)^{[s]}$.

$$
\left.0 \rightarrow G(I)(-(d-1) s) \rightarrow G(I)(-(d-2) s)^{\left({ }_{1}^{d}\right)} \rightarrow \cdots \rightarrow G(I)\right)^{\binom{d}{1}} \rightarrow G(I)(s) \rightarrow H_{0}\left(\left(\mathbf{x}^{*}\right)^{[s]} ; G(I)(s)\right) \rightarrow 0 .
$$

As we have an exact sequence of graded $G(I)$-modules, taking the $n^{\text {th }}$-graded component of each of these modules gives us the following exact sequence

$$
0 \rightarrow \frac{I^{n-(d-1) s}}{I^{n-(d-1) s+1}} \rightarrow\left(\frac{I^{n-(d-2) s}}{I^{n-(d-2) s+1}}\right)^{\binom{d}{1}} \rightarrow \cdots \rightarrow\left(\frac{I^{n}}{I^{n+1}}\right)^{\binom{d}{1}} \rightarrow \frac{I^{n+s}}{I^{n+s+1}} \rightarrow \frac{I^{n+s}}{I^{[s]} I^{n}+I^{n+s+1}} \rightarrow 0 .
$$

For $s \leq n \leq(d-1) s-1$, it follows that

$$
\ell_{R}\left(\frac{I^{n+s}}{I^{[s]} I^{n}+I^{n+s+1}}\right)=\ell_{R}\left(\frac{I^{n+s}}{I^{n+s+1}}\right)+\sum_{i=1}^{d-1}(-1)^{i}\binom{d}{i} \ell_{R}\left(\frac{I^{n-(i-1) s}}{I^{n-(i-1) s+1}}\right) .
$$

By canceling $\ell_{R}\left(R / I^{n+s}\right)$ on both the sides, we get

$$
\begin{equation*}
\ell_{R}\left(\frac{R}{I^{[s]} I^{n}+I^{n+s+1}}\right)=\ell_{R}\left(\frac{R}{I^{n+s+1}}\right)+\sum_{i=1}^{d-1}(-1)^{i}\binom{d}{i} \ell_{R}\left(\frac{I^{n-(i-1) s}}{I^{n-(i-1) s+1}}\right) . \tag{3.2}
\end{equation*}
$$

We can also write

$$
\begin{align*}
\ell_{R}\left(\frac{R}{I^{[s]} I^{n}+I^{n+s+1}}\right) & =\ell_{R}\left(\frac{R}{I^{[s]}}\right)+\ell_{R}\left(\frac{I^{[s]}}{I^{[s]} I^{n}}\right)-\ell_{R}\left(\frac{I^{[s]} I^{n}+I^{n+s+1}}{I^{[s]} I^{n}}\right) \\
& =\ell_{R}\left(\frac{R}{I^{[s]}}\right)+\ell_{R}\left(\frac{I^{[s]}}{I^{[s]} I^{n}}\right)-\ell_{R}\left(\frac{I^{n+s+1}}{I^{[s]} I^{n+1}}\right) \tag{3.3}
\end{align*}
$$

since using Valabrega-Valla criterion ([19, Corollary 2.7]),

$$
\frac{I^{[s]} I^{n}+I^{n+s+1}}{I^{[s]} I^{n}} \simeq \frac{I^{n+s+1}}{\left(I^{[s]} \cap I^{n+s}\right) \cap I^{n+s+1}} \simeq \frac{I^{n+s+1}}{I^{[s]} \cap I^{n+s+1}} \simeq \frac{I^{n+s+1}}{I^{[s]} I^{n+1}}
$$

Combining equations (3.2) and (3.3), we get

$$
\ell_{R}\left(\frac{I^{[s]}}{I^{[s]} I^{n}}\right)-\ell_{R}\left(\frac{I^{[s]}}{I^{[s]} I^{n+1}}\right)=\sum_{i=1}^{d-1}(-1)^{i}\binom{d}{i} \ell_{R}\left(\frac{I^{n-(i-1) s}}{I^{n-(i-1) s+1}}\right)
$$

and hence for all $s \leq n \leq(d-1) s-1$,

$$
F(s, n+1)-F(s, n)=\sum_{i=1}^{d-1}(-1)^{i+1}\binom{d}{i}[H(n-(i-1) s+1)-H(n-(i-1) s)] .
$$

Adding the above equality from $s$ to $t-1$, for any $t$ such that $s+1 \leq t \leq(d-1) s-1$, we get

$$
\begin{aligned}
F(s, t)-F(s, s) & =\sum_{i=1}^{d-1}(-1)^{i+1}\binom{d}{i}[H(t-(i-1) s)-H((2-i) s)] \\
& =d[H(t)-H(s)]+\sum_{i=2}^{d-1}(-1)^{i+1}\binom{d}{i} H(t-(i-1) s) .
\end{aligned}
$$

Since $F(s, s)=d H(s)$, we get the result for $F(s, n), s+1 \leq n \leq(d-1) s-1$.
Case 3: Let $n \geq s(d-1)$. We prove that $I^{[s]} I^{n}=I^{n+s}$. Let $I=\left(x_{1}, \ldots, x_{d}\right)$, then $I^{n+s}$ is generated by the monomials of the form $x_{1}^{i_{1}} \cdots x_{d}^{i_{d}}$ where $\sum i_{j}=n+s$. Since the monomial $x_{1}^{s-1} \cdots x_{d}^{s-1}$ has degree $d s-d$ and $n+s \geq d s$, it follows that $I^{n+s} \subseteq I^{[s]} I^{n} \subseteq I^{n+s}$. Thus for all $n \geq(d-1) s$,

$$
F(s, n)=\ell_{R}\left(\frac{I^{[s]}}{I^{n+s}}\right)=\ell_{R}\left(\frac{R}{I^{n+s}}\right)-\ell_{R}\left(\frac{R}{I^{[s]}}\right)=H(n+s)-s^{d} e_{0}(I) .
$$

Remarks 3.3. (1) The arguments in proof of Theorem 3.2, case 3 actually prove that $I^{[s]} I^{n}=I^{n+s}$, for all $n \geq d(s-1)-s+1$. In other words, $F(s, n)=H(n+s)-s^{d} e_{0}(I)$ for all $n \geq s(d-1)-d+1$. This proves that

$$
F(s, n)= \begin{cases}d H(n) & \text { if } 1 \leq n \leq s  \tag{3.4}\\ \sum_{i=1}^{d-1}(-1)^{i+1}\binom{d}{i} H(n-(i-1) s) & \text { if } s+1 \leq n \leq s(d-1)-d \\ H(n+s)-s^{d} e_{0}(I) & \text { if } n \geq s(d-1)-d+1\end{cases}
$$

The following claim proves that the above observation does not contradict (3.1).
Claim: For all $s(d-1)-d+1 \leq n \leq s(d-1)$,

$$
\sum_{i=1}^{d-1}(-1)^{i+1}\binom{d}{i} H(n-(i-1) s)=H(n+s)-s^{d} e_{0}(I)
$$

Write $n=s(d-1)-d+1+j$, where $j=0,1, \ldots, d-1$. Then

$$
\begin{aligned}
\sum_{i=1}^{d-1}(-1)^{i+1}\binom{d}{i} H(n-(i-1) s) & =\sum_{i=1}^{d-1}(-1)^{i+1}\binom{d}{i}\binom{s(d-1)-d+1+j-(i-1) s+d-1}{d} e_{0}(I) \\
& =\sum_{i=1}^{d-1}(-1)^{i+1}\binom{d}{i}\binom{s(d-i)+j}{d} e_{0}(I)
\end{aligned}
$$

Using change of variables, we get

$$
\begin{aligned}
\sum_{i=1}^{d-1}(-1)^{i+1}\binom{d}{i} H(n-(i-1) s) & =\sum_{i=1}^{d-1}(-1)^{d-i+1}\binom{d}{d-i}\binom{i s+j}{d} e_{0}(I) \\
& =\sum_{i=0}^{d}(-1)^{d-i+1}\binom{d}{i}\binom{i s+j}{d} e_{0}(I)+\binom{d s+j}{d} e_{0}(I)
\end{aligned}
$$

Since $H(n+s)=\binom{d s+j}{d} e_{0}(I)$, from [8, 3.150], we get

$$
\sum_{i=1}^{d-1}(-1)^{i+1}\binom{d}{i} H(n-(i-1) s)=H(n+s)-s^{d} e_{0}(I)
$$

(2) Observe that $F(s, n)$ is the Hilbert-Samuel function of the $R$-module $I^{[s]}$ with respect to $I$. Let $n(I)$ denote the postulation number of $I$ in $R$ and $P_{I}(n)$ denote the Hilbert-Samuel polynomial of $I$ in $R$. Using (3.4), it follows that $F(s, n)$ is a polynomial, given by $P_{I}(n+s)-s^{d} e_{0}(I)$, for $n>\max \{n(I)+$ $s+1,(d-1) s-d+1\}$.

We recall the definition of Stirling numbers of the first kind and Stirling numbers of the second kind.
Definition 3.4 ([16, page 26]). Let $\mathfrak{S}_{n}$ denote the set of permutations on $n$ elements. Define $c(n, k)$ to be the number of permutations $w \in \mathfrak{S}_{n}$ with exactly $k$ cycles. The number $\mathbf{s}(n, k):=(-1)^{n-k} c(n, k)$ is known as the Stirling number of the first kind. It is easy to check that
(a) $\mathbf{s}(n, n)=1, \quad$ and $\quad(b) \mathbf{s}(n, n-1)=-\binom{n}{2}$.

Using [16, 1.3.7 Proposition], it follows that

$$
\sum_{k=0}^{n} \mathbf{s}(n, k) x^{k}=n!\binom{x}{n}
$$

Definition 3.5 ([16, page 73]). The Stirling number of the second kind, denoted by $\mathbf{S}(n, k)$, is equal to the number of partitions of the set $[n]=\{1, \ldots, n\}$ into $k$ blocks.

$$
\mathbf{S}(n, k)=\frac{1}{k!} \sum_{i=0}^{k}(-1)^{k-i}\binom{k}{i} i^{n}
$$

It is easy to check that
(a) $\mathbf{S}(d+1, d)=\binom{d+1}{2}$,
(b) $\mathbf{S}(d, d)=1$,
and
(c) $\mathbf{S}(j, d)=0$, for all $j<d$.

Using Stirling numbers we prove the following combinatorial identity.
Lemma 3.6. Let $s, d \in \mathbb{N}$. Then

$$
\sum_{i=0}^{d}(-1)^{d-i}\binom{d}{i}\binom{i s}{d+1}=\frac{d s^{d}(s-1)}{2} .
$$

Proof. Using (3.5), write

$$
\binom{i s}{d+1}=\frac{1}{(d+1)!} \sum_{j=0}^{d+1} \mathbf{s}(d+1, j)(i s)^{j}
$$

Therefore,

$$
\begin{aligned}
\sum_{i=0}^{d}(-1)^{d-i}\binom{d}{i}\binom{i s}{d+1} & =\sum_{i=0}^{d}(-1)^{d-i}\binom{d}{i} \frac{1}{(d+1)!} \sum_{j=0}^{d+1} \mathbf{s}(d+1, j)(i s)^{j} \\
& =\frac{1}{(d+1)!} \sum_{j=0}^{d+1} \mathbf{s}(d+1, j) s^{j} \sum_{i=0}^{d}(-1)^{d-i}\binom{d}{i} i^{j} .
\end{aligned}
$$

Using definition and properties of Stirling numbers (see Definition 3.4 and 3.5), we get

$$
\begin{aligned}
\sum_{i=0}^{d}(-1)^{d-i}\binom{d}{i}\binom{i s}{d+1} & =\frac{d!}{(d+1)!} \sum_{j=0}^{d+1} \mathbf{s}(d+1, j) s^{j} \mathbf{S}(j, d) \\
& =\frac{1}{(d+1)}\left[\mathbf{s}(d+1, d) s^{d} \mathbf{S}(d, d)+\mathbf{s}(d+1, d+1) s^{d+1} \mathbf{S}(d+1, d)\right] \\
& =\frac{1}{(d+1)}\left[-s^{d}\binom{d+1}{2}+s^{d+1}\binom{d+1}{2}\right] \\
& =\frac{d s^{d}(s-1)}{2}
\end{aligned}
$$

Lemma 3.7. For $d \geq 2$, put $\beta_{1}=(d-2) / 2$ and $\beta_{2}=(d-1)(3 d-10) / 24$. Then for any $s \in \mathbb{N}$,

$$
\binom{s+d-1}{d+1}=\frac{s^{d+1}}{(d+1)!}+\frac{s^{d} \beta_{1}}{d!}+\frac{s^{d-1} \beta_{2}}{(d-1)!}+\cdots,
$$

Proof. Using [8, page iv] and (3.5), it follows that

$$
\begin{aligned}
\binom{s+d-1}{d+1}=(-1)^{d+1}\binom{-(s-1)}{d+1} & =\frac{(-1)^{d+1}}{(d+1)!} \sum_{k=0}^{d+1} \mathbf{s}(d+1, k)(1-s)^{k} \\
& =\frac{(-1)^{d+1}}{(d+1)!} \sum_{k=0}^{d+1} \mathbf{s}(d+1, k) \sum_{j=0}^{k}\binom{k}{j}(-1)^{j} s^{j}
\end{aligned}
$$

By index shifting, we get

$$
\begin{equation*}
\binom{s+d-1}{d+1}=\frac{(-1)^{d+1}}{(d+1)!} \sum_{j=0}^{d+1} \sum_{k=0}^{j}(-1)^{d+1-j} \mathbf{s}(d+1, d+1-k)\binom{d+1-k}{j-k} s^{d+1-j} \tag{3.6}
\end{equation*}
$$

Coefficient of $s^{d+1}$ in (3.6) is

$$
\begin{equation*}
\frac{1}{(d+1)!} \mathbf{s}(d+1, d+1)=\frac{1}{(d+1)!} \tag{3.7}
\end{equation*}
$$

Coefficient of $s^{d}$ in (3.6) is

$$
\begin{aligned}
\frac{(-1)^{d+1}}{(d+1)!}\left[(-1)^{d} \mathbf{s}(d+1, d+1)(d+1)+(-1)^{d} \mathbf{s}(d+1, d)\right] & =\frac{-1}{(d+1)!}\left[d+1-\binom{d+1}{2}\right] \\
& =\frac{d-2}{2 d!}
\end{aligned}
$$

Coefficient of $s^{d-1}$ in (3.6) is

$$
\begin{aligned}
& \frac{1}{(d+1)!}\left[\mathbf{s}(d+1, d+1)\binom{d+1}{2}+\mathbf{s}(d+1, d) d+\mathbf{s}(d+1, d-1)\right] \\
& =\frac{1}{(d+1)!}\left[\binom{d+1}{2}-d\binom{d+1}{2}+c(d+1, d-1)\right]
\end{aligned}
$$

Using [16, 1.3.6 Lemma], it is easy to check that

$$
c(d+1, d-1)=\sum_{j=2}^{d} j\binom{j}{2}=\frac{d(d+1)\left(3 d^{2}-d-2\right)}{24} .
$$

Substituting, we get the coefficient of $s^{d-1}$ is

$$
\frac{1}{(d+1)!}\left[\binom{d+1}{2}-d\binom{d+1}{2}+\frac{d(d+1)\left(3 d^{2}-d-2\right)}{24}\right]=\frac{(d-1)(3 d-10)}{24(d-1)!} .
$$

Theorem 3.8. Let $R$ be a d-dimensional Cohen-Macaulay local ring and $d \geq 2$. Let $I$ be a parameter ideal of $R$ and $\mathcal{I}=(I, I t) \mathcal{R}(I)$. Put $c(d)=(d / 2)+d /(d+1)!$. Let $s \in \mathbb{N}$.
(1) Let $s<d$. Write $d=k_{1} s+k_{2}$ where $k_{2} \in\{0,1, \ldots, s-1\}$. If $k_{2}=0$, then

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}^{[s]}}\right)=e_{0}(I)\left[\left(d-k_{1}+1\right) s^{d+1}+d\binom{s+d-1}{d+1}-\sum_{i=0}^{d-1}\left[(-1)^{i}\binom{d}{i}\binom{\left(d-i-k_{1}+1\right) s+d-1}{d+1}\right]\right] .
$$

If $k_{2} \neq 0$, then

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}^{[s]}}\right)=e_{0}(I)\left[\left(d-k_{1}\right) s^{d+1}+d\binom{s+d-1}{d+1}-\sum_{i=0}^{d-1}\left[(-1)^{i}\binom{d}{i}\binom{\left(d-i-k_{1}\right) s+d-1}{d+1}\right]\right] .
$$

(2) Let $s \geq d$. Then

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}^{[s]}}\right)=e_{0}(I)\left[\frac{d s^{d+1}}{2}-\frac{s^{d}(d-2)}{2}+d\binom{s+d-1}{d+1}\right]
$$

In other words, for s large,

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}^{[s]}}\right)=c(d) e_{0}(I) s^{d+1}+e_{0}(I)\left(\frac{d-2}{2}\right)\left(\frac{1}{(d-1)!}-1\right) s^{d}+e_{0}(I) \frac{d(d-1)(3 d-10)}{24(d-1)!} s^{d-1}+\cdots,
$$

implying that the generalized Hilbert-Kunz multiplicity $e_{H K}((I, I t) \mathcal{R}(I))=c(d) e_{0}(I)$.

Proof. Consider

$$
\mathcal{I}^{[s]}=\left(I^{[s]}, I^{[s]} t^{s}\right)=\left(\bigoplus_{n=0}^{s-1} I^{[s]} I^{n} t^{n}\right)+\left(\bigoplus_{n \geq s} I^{[s]} I^{n-s} t^{n}\right) .
$$

Since $G(I)$ is Cohen-Macaulay and the $a$-invariant $a_{d}(G(I))=-d<0$, using Theorem 3.1 it follows that $r\left(I^{s}\right)=d-1$ if $s \geq d$. Let $s<d$. Write $d=k_{1} s+k_{2}$, where $k_{2} \in\{0,1, \ldots, s-1\}$. Then using Theorem 3.1 it follows that

$$
r\left(I^{s}\right)=\left\lfloor-k_{1}-\frac{k_{2}}{s}\right\rfloor+d= \begin{cases}d-k_{1} & \text { if } k_{2}=0 \\ d-k_{1}-1 & \text { if } k_{2} \neq 0 .\end{cases}
$$

Case 1: Let $s<d$. Write $d=k_{1} s+k_{2}$, where $k_{2} \in\{0,1, \ldots, s-1\}$. Then as observed above, $r\left(I^{s}\right)=$ $d-k_{1}-j, j \in\{0,1\}$. As $I^{[s]}$ is a minimal reduction of $I^{s}$, we get, $I^{[s]} I^{\left(d-k_{1}-j\right) s}=I^{\left(d-k_{1}-j+1\right) s}$. In other words, $I^{[s]} I^{n-s}=I^{n}$, for all $n \geq\left(d-k_{1}-j+1\right) s$. Therefore,

$$
\mathcal{I}^{[s]}=\left(\bigoplus_{n=0}^{s-1} I^{[s]} I^{n} t^{n}\right)+\left(\bigoplus_{n=s}^{\left(d-k_{1}-j+1\right) s-1} I^{[s]} I^{n-s} t^{n}\right)+\left(\bigoplus_{n \geq\left(d-k_{1}-j+1\right) s} I^{n} t^{n}\right)
$$

Consider

$$
\begin{aligned}
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}^{[s]}}\right) & =\sum_{n=0}^{s-1} \ell_{R}\left(\frac{I^{n}}{I^{[s]} I^{n}}\right)+\sum_{n=s}^{\left(d-k_{1}-j+1\right) s-1} \ell_{R}\left(\frac{I^{n}}{I^{[s]} I^{n-s}}\right) \\
& =\sum_{n=0}^{s-1} \ell_{R}\left(\frac{R}{I^{[s]} I^{n}}\right)+\sum_{n=s}^{\left(d-k_{1}-j+1\right) s-1} \ell_{R}\left(\frac{R}{I^{[s]} I^{n-s}}\right)-\sum_{n=0}^{\left(d-k_{1}-j+1\right) s-1} \ell_{R}\left(\frac{R}{I^{n}}\right) .
\end{aligned}
$$

Write $\ell_{R}\left(\frac{R}{I^{[s]} I^{n}}\right)=\ell_{R}\left(\frac{R}{I^{[s]}}\right)+\ell_{R}\left(\frac{I^{[s]}}{I^{[s]} I^{n}}\right)$. Since $R$ is Cohen-Macaulay and $I$ is a parameter ideal, $\ell_{R}\left(\frac{R}{I^{n}}\right)=e_{0}(I)\binom{n+d-1}{d}$ for all $n \geq 1$, and hence

$$
\begin{aligned}
& \ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}^{[s]}}\right)=\left(d-k_{1}-j+1\right) s \cdot \ell_{R}\left(\frac{R}{I^{[s]}}\right)+ \\
& \sum_{n=0}^{s-1} \ell_{R}\left(\frac{I^{[s]}}{I^{[s]} I^{n}}\right)+ \sum_{n=s}^{\left(d-k_{1}-j+1\right) s-1} \ell_{R}\left(\frac{I^{[s]}}{I^{[s]} I^{n-s}}\right) \\
&-\sum_{n=1}^{\left(d-k_{1}-j+1\right) s-1} e_{0}(I)\binom{n+d-1}{d} \\
&=\left(d-k_{1}-j+1\right) s \cdot \ell_{R}\left(\frac{R}{I^{[s]}}\right)+2 \sum_{n=0}^{s-1} \ell_{R}\left(\frac{I^{[s]}}{I^{[s]} I^{n}}\right)+\sum_{n=s}^{\left(d-k_{1}-j\right) s-1} \ell_{R}\left(\frac{I^{[s]}}{I^{[s]} I^{n}}\right) \\
&-\sum_{n=1}^{\left(d-k_{1}-j+1\right) s-1} e_{0}(I)\binom{n+d-1}{d} .
\end{aligned}
$$

As $s<d$, we get $k_{1} \geq 1$. Thus, $d-k_{1}-j \leq d-1$. Using Theorem 3.2, we get

$$
\begin{aligned}
& \ell_{R}\left(\frac{\mathcal{R}(I)}{\left.\mathcal{I}^{[s]}\right)}\right. \\
& =\left(d-k_{1}-j+1\right) s^{d+1} e_{0}(I)+2 d e_{0}(I) \sum_{n=1}^{s-1}\binom{n+d-1}{d}+d e_{0}(I) \sum_{n=s}^{\left(d-k_{1}-j\right) s-1}\binom{n+d-1}{d} \\
& \quad+\begin{array}{c}
\left(d-k_{1}-j\right) s-1 \\
\sum_{n=s}
\end{array}\left[\sum_{i=2}^{d-1}(-1)^{i+1}\binom{d}{i} e_{0}(I)\binom{n-(i-1) s+d-1}{d}\right]-\left(\begin{array}{c}
\left(d-k_{1}-j+1\right) s-1 \\
n=1
\end{array} e_{0}(I)\binom{n+d-1}{d}\right. \\
& =\left(d-k_{1}-j+1\right) s^{d+1} e_{0}(I)+2 d e_{0}(I)\binom{s+d-1}{d+1}+d e_{0}(I)\left[\binom{\left(d-k_{1}-j\right) s+d-1}{d+1}-\binom{s+d-1}{d+1}\right] \\
& \quad-\sum_{i=2}^{d-1}\left[(-1)^{i}\binom{d}{i} e_{0}(I)\binom{\left(d-j-k_{1}-i+1\right) s+d-1}{d+1}\right]-e_{0}(I)\binom{\left(d-k_{1}-j+1\right) s+d-1}{d+1} \\
& =\left(d-k_{1}-j+1\right) s^{d+1} e_{0}(I)+d e_{0}(I)\binom{s+d-1}{d+1}-\sum_{i=0}^{d-1}\left[(-1)^{i}\binom{d}{i} e_{0}(I)\binom{\left(d-j-k_{1}-i+1\right) s+d-1}{d+1}\right] .
\end{aligned}
$$

Case 2: Let $s \geq d$. Then $r\left(I^{s}\right)=d-1$. As $I^{[s]}$ is a minimal reduction of $I^{s}$, we get, $I^{[s]} I^{(d-1) s}=I^{d s}$. In other words, $I^{[s]} I^{n-s}=I^{n}$, for all $n \geq d s$. Therefore,

$$
\mathcal{I}^{[s]}=\left(\bigoplus_{n=0}^{s-1} I^{[s]} I^{n} t^{n}\right)+\left(\bigoplus_{n=s}^{d s-1} I^{[s]} I^{n-s} t^{n}\right)+\left(\bigoplus_{n \geq d s} I^{n} t^{n}\right)
$$

Consider

$$
\begin{aligned}
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}{ }^{[s]}}\right) & =\sum_{n=0}^{s-1} \ell_{R}\left(\frac{I^{n}}{I^{[s]} I^{n}}\right)+\sum_{n=s}^{d s-1} \ell_{R}\left(\frac{I^{n}}{I^{[s]} I^{n-s}}\right) \\
& =\sum_{n=0}^{s-1} \ell_{R}\left(\frac{R}{I^{[s]} I^{n}}\right)+\sum_{n=s}^{d s-1} \ell_{R}\left(\frac{R}{I^{[s]} I^{n-s}}\right)-\sum_{n=0}^{d s-1} \ell_{R}\left(\frac{R}{I^{n}}\right) .
\end{aligned}
$$

Write $\ell_{R}\left(\frac{R}{I^{[s]} I^{n}}\right)=\ell_{R}\left(\frac{R}{I^{[s]}}\right)+\ell_{R}\left(\frac{I^{[s]}}{I^{[s]} I^{n}}\right)$. Since $\ell_{R}\left(\frac{R}{I^{n}}\right)=e_{0}(I)\binom{n+d-1}{d}$, we have

$$
\begin{aligned}
& \ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I} I^{[s]}}\right)= d s \ell_{R}\left(\frac{R}{I^{[s]}}\right)+\sum_{n=0}^{s-1} \ell_{R}\left(\frac{I^{[s]}}{I^{[s]} I^{n}}\right)+\sum_{n=s}^{d s-1} \ell_{R}\left(\frac{I^{[s]}}{I^{[s]} I^{n-s}}\right)-\sum_{n=1}^{d s-1} e_{0}(I)\binom{n+d-1}{d} \\
&= d s \ell_{R}\left(\frac{R}{I^{[s]}}\right)+2 \sum_{n=0}^{s-1} \ell_{R}\left(\frac{I^{[s]}}{I^{[s]} I^{n}}\right)+\sum_{n=s}^{(d-1) s-1} \ell_{R}\left(\frac{I^{[s]}}{I^{[s]} I^{n}}\right)-\sum_{n=1}^{d s-1} e_{0}(I)\binom{n+d-1}{d} \\
&=d s^{d+1} e_{0}(I)+2 \sum_{n=1}^{s-1} \ell_{R}\left(\frac{I^{[s]}}{I^{[s]} I^{n}}\right)+\sum_{n=s}^{(d-1) s-d} \ell_{R}\left(\frac{I^{[s]}}{I^{[s]} I^{n}}\right)+\sum_{n=(d-1) s-d+1}^{(d-1) s-1} \ell_{R}\left(\frac{I^{[s]}}{I^{[s]} I^{n}}\right) \\
&-\sum_{n=1}^{d s-1} e_{0}(I)\binom{n+d-1}{d} .
\end{aligned}
$$

From (3.4), it follows that

$$
\left.\begin{array}{rl}
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}[s]}\right) & =d s^{d+1} e_{0}(I)+2 d e_{0}(I) \sum_{n=1}^{s-1}\binom{n+d-1}{d}+d e_{0}(I) \sum_{n=s}^{(d-1) s-d}\binom{n+d-1}{d} \\
& +\sum_{n=s}^{(d-1) s-d}\left[\sum_{i=2}^{d-1}(-1)^{i+1}\binom{d}{i} e_{0}(I)\binom{n-(i-1) s+d-1}{d}\right] \\
& +\sum_{n=s(d-1)-d+1}^{(d-1) s-1}\left[\binom{n+s+d-1}{d} e_{0}(I)-s^{d} e_{0}(I)\right]-\sum_{n=1}^{d s-1} e_{0}(I)\binom{n+d-1}{d} \\
& =d s^{d+1} e_{0}(I)+2 d e_{0}(I)\binom{s+d-1}{d+1}+d e_{0}(I)\left[\binom{(d-1) s}{d+1}-\binom{s+d-1}{d+1}\right] \\
& -\sum_{i=2}^{d-1}\left[(-1)^{i}\binom{d}{i} e_{0}(I)\binom{(d-i) s}{d+1}\right]+e_{0}(I)\binom{d s+d-1}{d+1}-e_{0}(I)\binom{d s}{d+1}-s^{d}(d-1) e_{0}(I) \\
& =d s^{d+1} e_{0}(I)+d e_{0}(I)\binom{s+d-1}{d+1}-\sum_{i=0}^{d-1}\left[(-1)^{i}\binom{d}{i} e_{0}(I)\binom{(d-i) s}{d+1}\right]-s^{d}(d-1) e_{0}(I) \\
d+1
\end{array}\right) .
$$

Using Lemma 3.6, it follows that

$$
\begin{align*}
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}^{[s]}}\right) & =e_{0}(I)\left[d s^{d+1}-s^{d}(d-1)+d\binom{s+d-1}{d+1}-\frac{d s^{d}(s-1)}{2}\right] \\
& =e_{0}(I)\left[\frac{d s^{d+1}}{2}-\frac{s^{d}(d-2)}{2}+d\binom{s+d-1}{d+1}\right] . \tag{3.8}
\end{align*}
$$

This implies that the Hilbert-Kunz function is a polynomial for $s \geq d$. We now use Lemma 3.7 to find the coefficients of $s^{d+1}, s^{d}$ and $s^{d-1}$ in the expression (3.8). The coefficient of $s^{d+1}$ is

$$
e_{0}(I)\left[\frac{d}{2}+\frac{d}{(d+1)!}\right]=c(d) .
$$

Coefficient of $s^{d}$ is

$$
e_{0}(I)\left[\frac{-(d-2)}{2}+\frac{d(d-2)}{2 d!}\right]=e_{0}(I)\left(\frac{d-2}{2}\right)\left[-1+\frac{1}{(d-1)!}\right]
$$

and coefficient of $s^{d-1}$ is

$$
e_{0}(I) \frac{d(d-1)(3 d-10)}{24(d-1)!} .
$$

In [4], Conca remarked that the generalized Hilbert-Kunz function is dependent on the choice of the set of generators of the ideal. But if $R$ is a Cohen-Macaulay local ring of dimension $d \geq 2$ and $I$ is a parameter ideal, then using Theorem 3.8 it follows that the length function $\ell\left(\mathcal{R}(I) /(I, I t)^{[s]}\right)$ is independent of the choice of generators of $I$.

Corollary 3.9. Let $(R, \mathfrak{m})$ be a d-dimensional regular local ring with $d \geq 2$. Then for $s \geq d$,

$$
\ell_{R}\left(\frac{\mathcal{R}(\mathfrak{m})}{(\mathfrak{m}, \mathfrak{m} t)^{[s]}}\right)=c(d) s^{d+1}+\left(\frac{d-2}{2}\right)\left(\frac{1}{(d-1)!}-1\right) s^{d}+\frac{d(d-1)(3 d-10)}{24(d-1)!} s^{d-1}+\cdots .
$$

Proof. Use $I=\mathfrak{m}$ in Theorem 3.8.
Corollary 3.10. Let $(R, \mathfrak{m})$ be a Cohen-Macaulay local ring of dimension $d$ with positive prime characteristic $p>0$. If there exists a parameter ideal $I$ of $R$ such that $I^{*}=\mathfrak{m}$, then

$$
e_{H K}(\mathcal{R}(\mathfrak{m}))=c(d) e_{0}(\mathfrak{m})
$$

Proof. If there exists a parameter ideal $I$ of $R$ such that $I^{*}=\mathfrak{m}$, then using the same arguments as in the proof of [5, Corollary 4.5(2)], it follows that $e_{H K}((\mathfrak{m}, \mathfrak{m} t) \mathcal{R}(\mathfrak{m}))=e_{H K}((I, I t) \mathcal{R}(I))$. Therefore,

$$
e_{H K}(\mathcal{R}(\mathfrak{m}))=e_{H K}((\mathfrak{m}, \mathfrak{m} t) \mathcal{R}(\mathfrak{m}))=e_{H K}((I, I t) \mathcal{R}(I))=c(d) e_{0}(I)=c(d) e_{0}(\mathfrak{m}) .
$$

The latter equality holds as $I^{*}=\mathfrak{m}$ implies that $\bar{I}=\mathfrak{m}$.
Corollary 3.11. Let $R$ be a d-dimensional Cohen-Macaulay Stanley-Reisner ring of a simplicial complex over an infinite field with prime characteristic $p>0$. Let $\mathfrak{m}$ be a maximal homogeneous ideal of $R$. Then $e_{H K}(\mathcal{R}(\mathfrak{m}))=$ $c(d) f_{d-1}$, where $f_{d-1}$ is the number of facets in the simplicial complex.

Proof. Let $I$ be an ideal generated by a linear system of parameters. It is proved in [7, Theorem 6.1] that $\mathfrak{m}=I^{*}$. Therefore, using Corollary 3.10 it follows that $e_{H K}(\mathcal{R}(\mathfrak{m}))=c(d) e(\mathfrak{m})$. Since $e(\mathfrak{m})=f_{d-1}$, we are done.

Example 3.12. Let $k\left[\left[X_{1}, X_{2}, X_{3}\right]\right]$ be a power series ring in 3 variables over a field $k$. Let $I=\left(X_{1}^{n_{1}}, X_{2}^{n_{2}}, X_{3}^{n_{3}}\right)$, where $n_{1}, n_{2}, n_{3} \in \mathbb{N}$. Then

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{(I, I t)^{[2]}}\right)=e_{0}(I)\left[32+3-\sum_{i=0}^{2}\left[(-1)^{i}\binom{3}{i}\binom{6-2 i}{4}\right]\right]=23 e_{0}(I)=23 n_{1} n_{2} n_{3}
$$

and for $s \geq 3$,

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}^{[s]}}\right)=n_{1} n_{2} n_{3}\left[\frac{3 s^{4}}{2}-\frac{s^{3}}{2}+3\binom{s+2}{4}\right]=n_{1} n_{2} n_{3}\left[\frac{13}{8} s^{4}-\frac{1}{4} s^{3}-\frac{1}{8} s^{2}-\frac{1}{4} s\right] .
$$

In particular, for $s \geq 3$,

$$
\ell_{R}\left(\frac{\mathcal{R}(\mathfrak{m})}{(\mathfrak{m}, \mathfrak{m} t)^{[s]}}\right)=\frac{13}{8} s^{4}-\frac{1}{4} s^{3}-\frac{1}{8} s^{2}-\frac{1}{4} s .
$$

Example 3.13. Let $R=k[[X, Y, Z]] /\left(X Y-Z^{n}\right)$ for some positive integer $n \geq 2$ and let $I$ be a parameter ideal of $R$. Then for $s \geq 2$,

$$
\ell_{R}\left(\frac{\mathcal{R}(I)}{\mathcal{I}^{[s]}}\right)=e_{0}(I)\left[s^{3}+2\binom{s+1}{3}\right]=e_{0}(I)\left[\frac{4}{3} s^{3}-\frac{1}{3} s\right] .
$$
