# Existence of radial bounded solutions for some quasilinear elliptic equations in $\mathbb{R}^{N *}$

#### Abstract

We study the quasilinear equation $$
\begin{equation*} -\operatorname{div}\left(A(x, u)|\nabla u|^{p-2} \nabla u\right)+\frac{1}{p} A_{t}(x, u)|\nabla u|^{p}+|u|^{p-2} u=g(x, u) \quad \text { in } \mathbb{R}^{N} \tag{P} \end{equation*}
$$ with $N \geq 3, p>1$, where $A(x, t), A_{t}(x, t)=\frac{\partial A}{\partial t}(x, t)$ and $g(x, t)$ are Carathéodory functions on $\mathbb{R}^{N} \times \mathbb{R}$.

Suitable assumptions on $A(x, t)$ and $g(x, t)$ set off the variational structure of $(P)$ and its related functional $\mathcal{J}$ is $C^{1}$ on the Banach space $X=W^{1, p}\left(\mathbb{R}^{N}\right) \cap L^{\infty}\left(\mathbb{R}^{N}\right)$. In order to overcome the lack of compactness, we assume that the problem has radial symmetry, then we look for critical points of $\mathcal{J}$ restricted to $X_{r}$, subspace of the radial functions in $X$.

Following an approach which exploits the interaction between $\|\cdot\|_{X}$ and the norm on $W^{1, p}\left(\mathbb{R}^{N}\right)$, we prove the existence of at least one weak bounded radial solution of $(P)$ by applying a generalized version of the Ambrosetti-Rabinowitz Mountain Pass Theorem.

## 1 Introduction

In this paper we investigate the existence of weak bounded radial solutions of the quasilinear equation

$$
\begin{equation*}
-\operatorname{div}\left(A(x, u)|\nabla u|^{p-2} \nabla u\right)+\frac{1}{p} A_{t}(x, u)|\nabla u|^{p}+|u|^{p-2} u=g(x, u) \quad \text { in } \mathbb{R}^{N} \tag{1.1}
\end{equation*}
$$

[^0]with $N \geq 3, p>1$, where $A(x, t), g(x, t)$ are given real functions on $\mathbb{R}^{N} \times \mathbb{R}$ and $A_{t}(x, t)=\frac{\partial}{\partial t} A(x, t)$.
Equation (1.1), with $p=2$, is related to the research of standing waves for the "modified Schrödinger equations" and appears quite naturally in Mathematical Physics, derived as model of several physical phenomena in plasma physics, fluidmechanics, theory of Heisenberg ferromagnets and magnons, dissipative quantum mechanics and condensed matter theory (for more details, see, e.g., [22] and references therein).

In the mathematical literature, very few results are known about equation (1.1) if $A_{t}(x, t) \not \equiv 0$ since, in general, a classical variational approach fails. In fact, the "natural" functional associated to (1.1) is

$$
\mathcal{J}(u)=\frac{1}{p} \int_{\mathbb{R}^{N}} A(x, u)|\nabla u|^{p} d x+\frac{1}{p} \int_{\mathbb{R}^{N}}|u|^{p} d x-\int_{\mathbb{R}^{N}} G(x, u) d x
$$

which is not defined in $W^{1, p}\left(\mathbb{R}^{N}\right)$ for a general coefficient $A(x, t)$ in the principal part. Moreover, even if $A(x, t)$ is a smooth strictly positive bounded function, so the functional $\mathcal{J}$ is well defined in $W^{1, p}\left(\mathbb{R}^{N}\right)$, if $A_{t}(x, t) \not \equiv 0$ it is Gâteaux differentiable only along directions of $W^{1, p}\left(\mathbb{R}^{N}\right) \cap L^{\infty}\left(\mathbb{R}^{N}\right)$.

In the past, such a problem has been overcome by introducing suitable definitions of critical point for non-differentiable functionals (see, e.g., [2, 16, 18]). In particular, existence results have been obtained if equation (1.1) is given on a bounded domain with homogeneous Dirichlet boundary conditions (see, e.g., [2, 15] and also [7] and references therein), while some existence results in unbounded domain have been stated, e.g., in [3].

In the whole Euclidean space $\mathbb{R}^{N}$ other existence results have been proved by means of constrained minimization arguments (see 21, 26]) or by using a suitable change of variable (see, e.g., [17, 22]). We note that this last method works only if $A(x, t)$ has a very special form, in particular it is independent of $x$.

More recently, if $\Omega$ is a bounded subset of $\mathbb{R}^{N}$, a different approach has been developed which exploits the interaction between two different norms on $W_{0}^{1, p}(\Omega) \cap L^{\infty}(\Omega)$ (see [9, 10, 13]).

Following this way of thinking, here firstly we prove that, under some quite natural conditions, functional $\mathcal{J}$ is $C^{1}$ in the Banach space $X=W^{1, p}\left(\mathbb{R}^{N}\right) \cap L^{\infty}\left(\mathbb{R}^{N}\right)$ equipped with the intersection norm $\|\cdot\|_{X}$ (see Proposition 3.6).

Then, due to the lack of compactness of our setting, we assume that the problem has radial symmetry so we study the existence of critical points of $\mathcal{J}$ restricted to the subspace $X_{r}$ of the radial functions.

So, by using the interaction between the norm $\|\cdot\|_{X}$ and the standard one on $W^{1, p}\left(\mathbb{R}^{N}\right)$, if $G(x, t)$ has a subcritical growth, we state that $\mathcal{J}$ satisfies a weaker version of the Cerami's variant of the Palais-Smale condition in $X_{r}$ (see Definition 2.1 and Proposition 5.4). We note that, in general, $\mathcal{J}$ cannot verify the standard Palais-Smale condition, or its Cerami's variant, as PalaisSmale sequences may converge in the $W^{1, p}\left(\mathbb{R}^{N}\right)$-norm but be unbounded in $L^{\infty}\left(\mathbb{R}^{N}\right)$ (see, e.g., [12, Example 4.3]).

Since our main theorem requires a list of hypotheses, we give its complete statement in Section 4 (see Theorem 4.2), while here, in order to highlight at least a model problem and its related result, we consider the particular setting of the "modified Schrödinger equation" in $\mathbb{R}^{3}$ with $p=2$ and

$$
A(x, t)=A_{1}(x)+A_{2}(x)|t|^{2 s}, \quad g(x, t)=|t|^{\mu-2} t
$$

so that problem (1.1) reduces to

$$
\begin{equation*}
-\operatorname{div}\left(\left(A_{1}(x)+A_{2}(x)|u|^{2 s}\right) \nabla u\right)+s A_{2}(x)|u|^{2 s-2} u|\nabla u|^{2}+u=|u|^{\mu-2} u \quad \text { in } \mathbb{R}^{3} \tag{1.2}
\end{equation*}
$$

thus generalizing the particular case $A_{1}(x) \equiv A_{2}(x) \equiv 1$ and $s=1$ which many papers deal with (see, e.g., 17). Here, we state the following result.

Theorem 1.1. Let $A_{1}, A_{2} \in L^{\infty}(\Omega)$ be two radially symmetric functions such that

$$
A_{1}(x) \geq \alpha_{0}, \quad A_{2}(x) \geq 0 \quad \text { a.e. in } \mathbb{R}^{3},
$$

for a constant $\alpha_{0}>0$. If $3<2(1+s)<\mu<6$, then problem (1.2) has at least one weak bounded radial solution.

We note that the same hypotheses of Theorem [1.1] appear in [7], where it is stated the existence of a bounded positive solution of equation (1.2) in a bounded domain. However, in such a paper, by using a different approach, namely a sequence of truncated functionals, the authors are able also to study the case $0<2 s \leq 1$.

This paper is organized as follows. In Section 2 we introduce the weak Cerami-Palais-Smale condition and a generalized version of the Mountain Pass Theorem in an abstract setting. On the contrary, in Section 3 we give the first hypotheses on functions $A(x, t), g(x, t)$, and the variational formulation of our problem when no radial assumption is involved. Then, in Section 4 the main result is stated and the radial symmetric setting is pointed out. At last, in Section 5 the main theorem is proved.

## 2 Abstract tools

In this section, we denote by $\left(X,\|\cdot\|_{X}\right)$ a Banach space with dual space $\left(X^{\prime},\|\cdot\|_{X^{\prime}}\right)$, by $\left(W,\|\cdot\|_{W}\right)$ another Banach space such that $X \hookrightarrow W$ continuously, and by $J: X \rightarrow \mathbb{R}$ a given $C^{1}$ functional.

Taking $\beta \in \mathbb{R}$, we say that a sequence $\left(u_{n}\right)_{n} \subset X$ is a Cerami-Palais-Smale sequence at level $\beta$, briefly $(C P S)_{\beta}$-sequence, if

$$
\lim _{n \rightarrow+\infty} J\left(u_{n}\right)=\beta \quad \text { and } \quad \lim _{n \rightarrow+\infty}\left\|d J\left(u_{n}\right)\right\|_{X^{\prime}}\left(1+\left\|u_{n}\right\|_{X}\right)=0 .
$$

Moreover, $\beta$ is a Cerami-Palais-Smale level, briefly $(C P S)$-level, if there exists a $(C P S)_{\beta^{-}}$ sequence.

The functional $J$ satisfies the classical Cerami-Palais-Smale condition in $X$ at level $\beta$ if every $(C P S)_{\beta}$-sequence converges in $X$ up to subsequences. Anyway, thinking about the setting of our problem, in general $(C P S)_{\beta}$-sequences may also exist which are unbounded in $\|\cdot\|_{X}$ but converge with respect to $\|\cdot\|_{W}$. Then, we can weaken the classical Cerami-Palais-Smale condition in the following way.

Definition 2.1. The functional $J$ satisfies the weak Cerami-Palais-Smale condition at level $\beta$ $\left(\beta \in \mathbb{R}\right.$ ), briefly $(w C P S)_{\beta}$ condition, if for every $(C P S)_{\beta}$-sequence $\left(u_{n}\right)_{n}$, a point $u \in X$ exists such that
(i) $\lim _{n \rightarrow+\infty}\left\|u_{n}-u\right\|_{W}=0 \quad$ (up to subsequences),
(ii) $J(u)=\beta, d J(u)=0$.

If $J$ satisfies the $(w C P S)_{\beta}$ condition at each level $\beta \in I, I$ real interval, we say that $J$ satisfies the ( $w C P S$ ) condition in $I$.

Due to the convergence only in the $W$-norm, the $(w C P S)_{\beta}$ condition implies that the set of critical points of $J$ at level $\beta$ is compact with respect to $\|\cdot\|_{W}$; anyway, this weaker "compactness" assumption is enough to prove a Deformation Lemma and then some abstract critical point theorems (see [11). In particular, the following generalization of the Mountain Pass Theorem [1, Theorem 2.1] can be stated.
Theorem 2.2 (Mountain Pass Theorem). Let $J \in C^{1}(X, \mathbb{R})$ be such that $J(0)=0$ and the $(w C P S)$ condition holds in $\mathbb{R}$. Moreover, assume that two constants $r, \varrho>0$ and a point $e \in X$ exist such that

$$
\begin{gathered}
u \in X,\|u\|_{W}=r \quad \Longrightarrow \quad J(u) \geq \varrho, \\
\|e\|_{W}>r \quad \text { and } \quad J(e)<\varrho .
\end{gathered}
$$

Then, J has a Mountain Pass critical point $u^{*} \in X$ such that $J\left(u^{*}\right) \geq \varrho$.
Proof. For the proof, see [11, Theorem 1.7] as the required assumption $(w C)$, namely any $(C P S)-$ level is also a critical level, follows from the stronger $(w C P S)$ condition.

## 3 Variational setting and first properties

Here and in the following, $|\cdot|$ is the standard norm on any Euclidean space as the dimension of the considered vector is clear and no ambiguity arises. Furthermore, we denote by:

- $B_{1}(0)=\left\{x \in \mathbb{R}^{N}:|x|<1\right\}$ the open unit ball in $\mathbb{R}^{N}$;
- meas $(\Omega)$ the usual Lebesgue measure of a measurable set $\Omega$ in $\mathbb{R}^{N}$;
- $L^{l}\left(\mathbb{R}^{N}\right)$ the Lebesgue space with norm $|u|_{l}=\left(\int_{\mathbb{R}^{N}}|u|^{l} d x\right)^{1 / l}$ if $1 \leq l<+\infty$;
- $L^{\infty}\left(\mathbb{R}^{N}\right)$ the space of Lebesgue-measurable and essentially bounded functions $u: \mathbb{R}^{N} \rightarrow \mathbb{R}$ with norm

$$
|u|_{\infty}=\underset{\mathbb{R}^{N}}{\operatorname{ess} \sup }|u| ;
$$

- $W^{1, p}\left(\mathbb{R}^{N}\right)$ the classical Sobolev space with norm $\|u\|_{W}=\left(|\nabla u|_{p}^{p}+|u|_{p}^{p}\right)^{\frac{1}{p}}$ if $1 \leq p<+\infty$;
- $W_{r}^{1, p}\left(\mathbb{R}^{N}\right)=\left\{u \in W^{1, p}\left(\mathbb{R}^{N}\right): u(x)=u(|x|)\right\}$ the subspace of $W^{1, p}\left(\mathbb{R}^{N}\right)$ equipped with the same norm $\|\cdot\|_{W}$ with dual space $\left(W_{r}^{1, p}\left(\mathbb{R}^{N}\right)\right)^{\prime}$.
From the Sobolev Imbedding Theorems, for any $l \in\left[p, p^{*}\right]$ with $p^{*}=\frac{p N}{N-p}$ if $N>p$, or any $l \in\left[p,+\infty\left[\right.\right.$ if $p=N$, the Sobolev space $W^{1, p}\left(\mathbb{R}^{N}\right)$ is continuously imbedded in $L^{l}\left(\mathbb{R}^{N}\right)$, i.e., a constant $\sigma_{l}>0$ exists, such that

$$
\begin{equation*}
|u|_{l} \leq \sigma_{l}\|u\|_{W} \quad \text { for all } u \in W^{1, p}\left(\mathbb{R}^{N}\right) \tag{3.1}
\end{equation*}
$$

(see, e.g., [8, Corollaries 9.10 and 9.11]). Clearly, it is $\sigma_{p}=1$. On the other hand, if $p>N$ then $W^{1, p}\left(\mathbb{R}^{N}\right)$ is continuously imbedded in $L^{\infty}\left(\mathbb{R}^{N}\right)$ (see, e.g., [8, Theorem 9.12]).

Thus, we define

$$
\begin{equation*}
X:=W^{1, p}\left(\mathbb{R}^{N}\right) \cap L^{\infty}\left(\mathbb{R}^{N}\right), \quad\|u\|_{X}=\|u\|_{W}+|u|_{\infty} \tag{3.2}
\end{equation*}
$$

From now on, we assume $p \leq N$ as, otherwise, it is $X=W^{1, p}\left(\mathbb{R}^{N}\right)$ and the proofs can be simplified.

Lemma 3.1. For any $l \geq p$ the Banach space $X$ is continuously imbedded in $L^{l}\left(\mathbb{R}^{N}\right)$, i.e., a constant $\sigma_{l}>0$ exists such that

$$
\begin{equation*}
|u|_{l} \leq \sigma_{l}\|u\|_{X} \quad \text { for all } u \in X \tag{3.3}
\end{equation*}
$$

Proof. If $p=N$ or if $1 \leq p<N$ and $l \leq p^{*}$ inequality (3.3) follows from (3.1) and (3.2).
On the other hand, if $1 \leq p<N$ and $l>p^{*}$ then, taking any $u \in X$, again (3.2) implies

$$
\int_{\mathbb{R}^{N}}|u|^{l} d x \leq|u|_{\infty}^{l-p} \int_{\mathbb{R}^{N}}|u|^{p} d x \leq|u|_{\infty}^{l-p}\|u\|_{W}^{p} \leq\|u\|_{X}^{l}
$$

thus (3.3) holds with $\sigma_{l}=1$.
From Lemma 3.1 it follows that if $\left(u_{n}\right)_{n} \subset X, u \in X$ are such that $u_{n} \rightarrow u$ in $X$, then $u_{n} \rightarrow u$ also in $L^{l}\left(\mathbb{R}^{N}\right)$ for any $l \geq p$. This result can be weakened as follows.
Lemma 3.2. If $\left(u_{n}\right)_{n} \subset X, u \in X, M>0$ are such that

$$
\begin{gather*}
\left\|u_{n}-u\right\|_{W} \rightarrow 0 \quad \text { if } n \rightarrow+\infty  \tag{3.4}\\
\left|u_{n}\right|_{\infty} \leq M \quad \text { for all } n \in \mathbb{N} \tag{3.5}
\end{gather*}
$$

then $u_{n} \rightarrow u$ also in $L^{l}\left(\mathbb{R}^{N}\right)$ for any $l \geq p$.
Proof. Let $1 \leq p<N$ and $l>p^{*}$ (otherwise, it is a direct consequence of (3.1)). Then, from (3.1) we have that

$$
\int_{\mathbb{R}^{N}}\left|u_{n}-u\right|^{l} d x \leq\left|u_{n}-u\right|_{\infty}^{l-p} \int_{\mathbb{R}^{N}}\left|u_{n}-u\right|^{p} d x \leq\left(M+|u|_{\infty}\right)^{l-p}\left\|u_{n}-u\right\|_{W}^{p}
$$

which implies the thesis.
As useful in the following, we recall a technical lemma (see [19]).
Lemma 3.3. A constant $b_{0}>0$ exists such that for any $y, z \in \mathbb{R}^{N}, N \geq 1$, it results

$$
\begin{array}{rlrl}
\left||y|^{l-2} y-|z|^{l-2} z\right| & \leq b_{0}|y-z|(|y|+|z|)^{l-2} & & \text { if } l>2 \\
\left||y|^{l-2} y-|z|^{l-2} z\right| & \leq b_{0}|y-z|^{l-1} & \text { if } 1<l \leq 2 \tag{3.7}
\end{array}
$$

The following estimate is a direct consequence of Lemma 3.3
Lemma 3.4. If $p>1$ a constant $b_{1}=b_{1}(p)>0$ exists such that

$$
\left.\int_{\mathbb{R}^{N}}| | \nabla u\right|^{p}-|\nabla v|^{p} \mid d x \leq b_{1}\|u-v\|_{W}\left(\|u\|_{W}^{p-1}+\|v\|_{W}^{p-1}\right) \quad \text { for any } u, v \in W^{1, p}\left(\mathbb{R}^{N}\right)
$$

Proof. Taking $u, v \in W^{1, p}\left(\mathbb{R}^{N}\right)$, by using (3.6) with $y=|\nabla u(x)|, z=|\nabla v(x)|$ and $l=p+1$, we have that

$$
\left||\nabla u|^{p}-|\nabla v|^{p}\right| \leq b_{0}| | \nabla u|-|\nabla v||(|\nabla u|+|\nabla v|)^{p-1} \leq b_{0}|\nabla u-\nabla v|(|\nabla u|+|\nabla v|)^{p-1}
$$

for a.e. $x \in \mathbb{R}^{N}$. Hence, from Hölder inequality and direct computations it follows that

$$
\left.\int_{\mathbb{R}^{N}}| | \nabla u\right|^{p}-|\nabla v|^{p} \left\lvert\, d x \leq b_{0}\|u-v\|_{W}\left(2^{p-1} \int_{\mathbb{R}^{N}}\left(|\nabla u|^{p}+|\nabla v|^{p}\right) d x\right)^{\frac{p-1}{p}}\right.
$$

which implies the thesis.

From now on, let $A: \mathbb{R}^{N} \times \mathbb{R} \rightarrow \mathbb{R}$ and $g: \mathbb{R}^{N} \times \mathbb{R} \rightarrow \mathbb{R}$ be such that:
$\left(H_{0}\right) A(x, t)$ is a $C^{1}$ Carathéodory function, i.e., $A(\cdot, t): x \in \mathbb{R}^{N} \mapsto A(x, t) \in \mathbb{R}$ is measurable for all $t \in \mathbb{R}$, $A(x, \cdot): t \in \mathbb{R} \mapsto A(x, t) \in \mathbb{R}$ is $C^{1}$ for a.e. $x \in \mathbb{R}^{N} ;$
$\left(H_{1}\right) A(x, t)$ and $A_{t}(x, t)$ are essentially bounded if $t$ is bounded, i.e.,

$$
\sup _{|t| \leq r}|A(\cdot, t)| \in L^{\infty}\left(\mathbb{R}^{N}\right), \quad \sup _{|t| \leq r}\left|A_{t}(\cdot, t)\right| \in L^{\infty}\left(\mathbb{R}^{N}\right) \quad \text { for any } r>0
$$

$\left(G_{0}\right) g(x, t)$ is a Carathéodory function, i.e., $g(\cdot, t): x \in \mathbb{R}^{N} \mapsto g(x, t) \in \mathbb{R}$ is measurable for all $t \in \mathbb{R}$, $g(x, \cdot): t \in \mathbb{R} \mapsto g(x, t) \in \mathbb{R}$ is continuous for a.e. $x \in \mathbb{R}^{N} ;$
$\left(G_{1}\right) a_{1}, a_{2}>0$ and $q \geq p$ exist such that

$$
|g(x, t)| \leq a_{1}|t|^{p-1}+a_{2}|t|^{q-1} \quad \text { a.e. in } \mathbb{R}^{N}, \text { for all } t \in \mathbb{R}
$$

Remark 3.5. From $\left(G_{0}\right)-\left(G_{1}\right)$ it follows that $G(x, t)=\int_{0}^{t} g(x, s) d s$ is a well defined $C^{1}$ Carathéodory function in $\mathbb{R}^{N} \times \mathbb{R}$ and

$$
\begin{equation*}
|G(x, t)| \leq \frac{a_{1}}{p}|t|^{p}+\frac{a_{2}}{q}|t|^{q} \quad \text { a.e. in } \mathbb{R}^{N}, \text { for all } t \in \mathbb{R} \tag{3.8}
\end{equation*}
$$

We note that (3.2) and $\left(H_{1}\right)$ imply $A(\cdot, u(\cdot))|\nabla u(\cdot)|^{p} \in L^{1}\left(\mathbb{R}^{N}\right)$ for all $u \in X$. Furthermore, even if no upper bound on $q$ is actually required in $\left(G_{1}\right)$, from Lemma3.1 it is $G(\cdot, u(\cdot)) \in L^{1}\left(\mathbb{R}^{N}\right)$ for any $u \in X$, too. Hence, we can consider the functional $\mathcal{J}: X \rightarrow \mathbb{R}$ defined as

$$
\begin{equation*}
\mathcal{J}(u)=\frac{1}{p} \int_{\mathbb{R}^{N}} A(x, u)|\nabla u|^{p} d x+\frac{1}{p} \int_{\mathbb{R}^{N}}|u|^{p} d x-\int_{\mathbb{R}^{N}} G(x, u) d x, \quad u \in X \tag{3.9}
\end{equation*}
$$

Taking any $u, v \in X$, by direct computations it follows that its Gâteaux differential in $u$ along the direction $v$ is

$$
\begin{align*}
\langle d \mathcal{J}(u), v\rangle= & \int_{\mathbb{R}^{N}} A(x, u)|\nabla u|^{p-2} \nabla u \cdot \nabla v d x+\frac{1}{p} \int_{\mathbb{R}^{N}} A_{t}(x, u) v|\nabla u|^{p} d x \\
& +\int_{\mathbb{R}^{N}}|u|^{p-2} u v d x-\int_{\mathbb{R}^{N}} g(x, u) v d x . \tag{3.10}
\end{align*}
$$

Proposition 3.6. Taking $p>1$, assume that $\left(H_{0}\right)-\left(H_{1}\right),\left(G_{0}\right)-\left(G_{1}\right)$ are satisfied. If $\left(u_{n}\right)_{n} \subset X$, $u \in X, M>0$ are such that (3.4), (3.5) hold and

$$
\begin{equation*}
u_{n} \rightarrow u \quad \text { a.e. in } \mathbb{R}^{N} \quad \text { if } n \rightarrow+\infty, \tag{3.11}
\end{equation*}
$$

then

$$

Hence, $\mathcal{J}$ is a $C^{1}$ functional on $X$ with Fréchet differential defined as in (3.10).

Proof. For simplicity, we set $\mathcal{J}=\mathcal{J}_{1}+\mathcal{J}_{2}$, where

From one hand, if $p>2$ from (3.6), Hölder inequality with $l=p-1$ and $l^{\prime}=\frac{p-1}{p-2}$, (3.12) and direct computations we have that

## 4 Statement of the main result

From now on, we assume that in addition to hypotheses $\left(H_{0}\right)-\left(H_{1}\right)$ and $\left(G_{0}\right)-\left(G_{1}\right)$, functions $A(x, t)$ and $g(x, t)$ satisfy the following further conditions:
$\left(H_{2}\right)$ a constant $\alpha_{0}>0$ exists such that

$$

$\left(H_{3}\right)$ some constants $R \geq 1$ and $\alpha_{1}>0$ exist such that

p A(x, t)+A_{t}(x, t) t \geq \alpha_{1} A(x, t) \quad \text { a.e. in } \mathbb{R}^{N} \text { if }|t| \geq R
$$

$\left(H_{4}\right)$ some constants $\mu>p$ and $\alpha_{2}>0$ exist such that

(\mu-p) A(x, t)-A_{t}(x, t) t \geq \alpha_{2} A(x, t) \quad \text { a.e. in } \mathbb{R}^{N}, \text { for all } t \in \mathbb{R}

$\left(H_{5}\right) \quad A(x, t)=A(|x|, t)$ a.e. in $\mathbb{R}^{N}$, for all $t \in \mathbb{R}$;
$\left(G_{2}\right) \lim _{t \rightarrow 0} \frac{g(x, t)}{|t|^{p-1}}=0$ uniformly for a.e. $x \in \mathbb{R}^{n} ;$
$\left(G_{3}\right)$ taking $\mu$ as in $\left(H_{4}\right)$, then

$$

Remark 4.1. If we consider the special coefficient

then $\left(H_{0}\right)-\left(H_{1}\right)$ are satisfied if $p s>1$ and $A_{1}, A_{2} \in L^{\infty}\left(\mathbb{R}^{N}\right),\left(H_{2}\right)$ follows from

A_{1}(x) \geq \alpha_{0}, \quad A_{2}(x) \geq 0 \quad \text { a.e. in } \mathbb{R}^{N}

for a constant $\alpha_{0}>0,\left(H_{3}\right)$ is always true, $\left(H_{4}\right)$ holds if $\mu>p(1+s)$, while $\left(H_{5}\right)$ reduces to assume that both $A_{1}(x)$ and $A_{2}(x)$ are radially symmetric.

Now, we are able to state our main existence result.
Theorem 4.2. Assume that $A(x, t)$ and $g(x, t)$ satisfy conditions $\left(H_{0}\right)-\left(H_{5}\right),\left(G_{0}\right)-\left(G_{4}\right)$ with $1<p<q<p^{*}$. Then, problem (1.1) admits at least one weak bounded radial solution.
Remark 4.3. If $A(x, t)$ is as in (4.1) and $g(x, t)=|t|^{\mu-2} t$, since $\left(G_{0}\right)-\left(G_{4}\right)$ hold with $q=\mu>1$, in the hypotheses pointed out in Remark 4.1 we have that Theorem 4.2 applies if

We note that, if $1<p<N$, from (4.2) it has to be $N<p^{2}+p$. In particular, if $p=2$, we obtain a solution of (1.2) when $3 \leq N<6$. Thus, Theorem 4.2 reduces to Theorem 1.1 if $p=2$ and $N=3$.

In order to prove Theorem 4.2 we need some direct consequences of the previous assumptions.
Remark 4.4. In $\left(H_{3}\right)$ and $\left(H_{4}\right)$ we can always assume $\alpha_{1}<p$ and $\alpha_{2}<\mu-p$. Hence, $\alpha_{1}+\alpha_{2}<\mu$, and we have

Remark 4.5. Conditions $\left(G_{0}\right)-\left(G_{1}\right)$ and $\left(G_{3}\right)$ imply that for any $\varepsilon>0$ a function $\eta_{\varepsilon} \in L^{\infty}\left(\mathbb{R}^{N}\right)$, $\eta_{\varepsilon}(x)>0$ a.e. in $\mathbb{R}^{N}$, exists such that

and then

\end{equation*}

From Proposition 3.6 it follows that looking for weak (bounded) solutions of (1.1) is equivalent to finding critical points of the $C^{1}$ functional $\mathcal{J}$, defined as in (3.9), on the Banach space $X$ introduced in (3.2).

Unluckily, differently from the bounded case, the embeddings of $X$ in suitable Lebesgue spaces are only continuous. So, in order to overcome the lack of compactness, we can reduce to work in the space of radial functions which is a natural constraint if the problem is radially invariant (see [23]). Thus, in our setting, we consider the space

endowed with norm $\|\cdot\|_{X}$, which has dual space $\left(X_{r}^{\prime},\|\cdot\|_{X_{r}^{\prime}}\right)$.
The following results hold.
Lemma 4.7 (Radial Lemma). If $p>1$, then every radial function $u \in W_{r}^{1, p}\left(\mathbb{R}^{N}\right)$ is almost everywhere equal to a function $U(x)$, continuous for $x \neq 0$, such that

for suitable constants $C, \vartheta>0$ depending only on $N$ and $p$.

Proof. Firstly, we note that by classical results every radial function $u \in W_{r}^{1, p}\left(\mathbb{R}^{N}\right)$ can be assumed to be continuous at all points except the origin (see [8]).
Now, if $p \geq 2$ and $\vartheta=\frac{N-2}{p}$, the proof of (4.9) follows from [6, Lemma A.III] but reasoning as in [25, Lemma 3.5] (see also [14, Lemma 3.1]).
On the other hand, if $1<p<N$, we prove that (4.9) holds with $\vartheta=\frac{N-p}{p}$ following the ideas in [4, Lemma 3.1.2]. In fact, by using a density argument, it is enough to prove the inequality for any function $u \in C_{0}^{\infty}\left(\mathbb{R}^{N}\right) \cap W_{r}^{1, p}\left(\mathbb{R}^{N}\right)$. Then, $\phi \in C_{0}^{\infty}([0,+\infty[)$ exists such that $u(x)=\phi(|x|)$. If $x \neq 0$, Hölder inequality and direct computations imply that

& \leq \omega_{N-1}^{-\frac{1}{p}}\left(\omega_{N-1} \int_{0}^{+\infty}\left|\phi^{\prime}(r)\right|^{p} r^{N-1} d r\right)^{\frac{1}{p}}\left(\frac{|x|^{\frac{p-N}{p-1}}}{\frac{N-p}{p-1}}\right)^{\frac{p-1}{p}}=C \frac{|\nabla u|_{p}}{|x|^{\frac{N-p}{p}}}
\end{aligned}
$$

where $\omega_{N-1}$ is the Lebesgue measure of $\partial B_{1}(0)$ in $\mathbb{R}^{N-1}$.
Lemma 4.8. If $p>1$ then the following compact embeddings hold:

W_{r}^{1, p}\left(\mathbb{R}^{N}\right) \hookrightarrow \hookrightarrow L^{l}\left(\mathbb{R}^{N}\right) \quad \text { for any } p<l<p^{*}
$$

Proof. The proof is contained essentially in [14. Theorem 3.2], anyway, for the sake of completeness, we give here more details.
Taking $p<l<p^{*}$, let $\left(u_{n}\right)_{n}$ be a bounded sequence in $W_{r}^{1, p}\left(\mathbb{R}^{N}\right)$. By reasoning as in [6, Theorem A.I'], from (4.9) it follows that $\left|u_{n}(x)\right| \rightarrow 0$ as $|x| \rightarrow+\infty$ uniformly with respect to $n$, moreover, up to a subsequence, $\left(u_{n}\right)_{n}$ converges for a.e. $x \in \mathbb{R}^{N}$ and weakly in $W_{r}^{1, p}\left(\mathbb{R}^{N}\right)$ to a radial function u. At last, fixing $l<\tilde{l}<p^{*}$ and taking $P(\tau)=|\tau|^{l}, Q(\tau)=|\tau|^{p}+|\tau|^{\tilde{l}}$, by [6, Theorem A.I] we conclude that $u_{n} \rightarrow u$ strongly in $L^{l}\left(\mathbb{R}^{N}\right)$.

Remark 4.9. Due to the assumptions $\left(H_{5}\right)$ and $\left(G_{4}\right)$, we can reduce to look for critical points of the restriction of $\mathcal{J}$ in (3.9) to $X_{r}$, which we still denote as $\mathcal{J}$ for simplicity (see [23]).
We recall that Proposition 3.6 implies that functional $\mathcal{J}$ is $C^{1}$ on the Banach space $X_{r}$, too, if also $\left(H_{0}\right)-\left(H_{1}\right),\left(G_{0}\right)-\left(G_{1}\right)$ hold.

## 5 Proof of the main result

The goal of this section is to apply Theorem 2.2 to the functional $\mathcal{J}$ on $X_{r}$.
For simplicity, in the following proofs, when a sequence $\left(u_{n}\right)_{n}$ is involved, we use the notation $\left(\varepsilon_{n}\right)_{n}$ for any infinitesimal sequence depending only on $\left(u_{n}\right)_{n}$ while $\left(\varepsilon_{k, n}\right)_{n}$ for any infinitesimal sequence depending not only on $\left(u_{n}\right)_{n}$ but also on some fixed integer $k$. Moreover, $c_{i}$ denotes any strictly positive constant independent of $n$.

In order to prove the weak Cerami-Palais-Smale condition, we need some preliminary lemmas.
Firstly, let us point out that, while if $p>N$ the two norms $\|\cdot\|_{X}$ and $\|\cdot\|_{W}$ are equivalent, if $p \leq N$ sufficient conditions are required for the boundedness of a $W^{1, p}-$ function on bounded sets as in the following result.

Lemma 5.1. Let $\Omega$ be an open bounded domain in $\mathbb{R}^{N}$ with boundary $\partial \Omega$, consider $p$, $q$ so that $1<p \leq q<p^{*}, p \leq N$, and take $v \in W^{1, p}(\Omega)$. If $\gamma>0$ and $k_{0} \in \mathbb{N}$ exist such that

with $\Omega_{k}^{+}=\{x \in \Omega: v(x)>k\}$, then ess sup $v$ is bounded from above by a positive constant which can be chosen so that it depends only on $\operatorname{meas}(\Omega), N, p, q, \gamma, k_{0},|v|_{p^{*}}\left(|v|_{l}\right.$ for some $l>q$ if $\left.p^{*}=+\infty\right)$. Vice versa, if

$$

and inequality

holds with $\Omega_{k}^{-}=\{x \in \Omega: v(x)<-k\}$, then ess $\sup (-v)$ is bounded from above by a positive constant which can be chosen so that it depends only on meas $(\Omega), N, p, q, \gamma, k_{0},|v|_{p^{*}}\left(|v|_{l}\right.$ for some $l>q$ if $\left.p^{*}=+\infty\right)$.

Proof. The proof follows from [20, Theorem II.5.1] but reasoning as in [10, Lemma 4.5].
A consequence of Lemma 5.1] is that the weak limit in $W_{r}^{1, p}\left(\mathbb{R}^{N}\right)$ of a $(C P S)_{\beta}$-sequence has to be bounded in $\mathbb{R}^{N}$.

Proposition 5.2. Let $1<p<q<p^{*}$ and assume that $\left(H_{0}\right)-\left(H_{5}\right),\left(G_{0}\right)-\left(G_{1}\right)$, $\left(G_{3}\right)-\left(G_{4}\right)$ hold. Then, taking any $\beta \in \mathbb{R}$ and a $(C P S)_{\beta}$-sequence $\left(u_{n}\right)_{n} \subset X_{r}$, it follows that $\left(u_{n}\right)_{n}$ is bounded in $W_{r}^{1, p}\left(\mathbb{R}^{N}\right)$ and a constant $\beta_{0}>0$ exists such that

Moreover, there exists $u \in X_{r}$ such that, up to subsequences,

& u_{n} \rightarrow u \text { a.e. in } \mathbb{R}^{N} \tag{5.4}
\end{align*}
$$

if $n \rightarrow+\infty$.
Proof. Let $\beta \in \mathbb{R}$ be fixed and consider a sequence $\left(u_{n}\right)_{n} \subset X_{r}$ such that

\geq & \frac{\alpha_{2}}{p} \int_{\mathbb{R}^{N}} A\left(x, u_{n}\right)\left|\nabla u_{n}\right|^{p} d x+\frac{\mu-p}{p} \int_{\mathbb{R}^{N}}\left|u_{n}\right|^{p} d x \\
\geq & \frac{\alpha_{0} \alpha_{2}}{p} \int_{\mathbb{R}^{N}}\left|\nabla u_{n}\right|^{p} d x+\frac{\mu-p}{p} \int_{\mathbb{R}^{N}}\left|u_{n}\right|^{p} d x \\
\geq & c_{1}\left\|u_{n}\right\|_{W}^{p}
\end{aligned}
$$

with $c_{1}=\frac{1}{p} \min \left\{\alpha_{0} \alpha_{2}, \mu-p\right\}$. Hence, $\left(u_{n}\right)_{n}$ is bounded in $W_{r}^{1, p}\left(\mathbb{R}^{N}\right)$ and Lemma 4.7 implies the uniform estimate (5.1). Furthermore, $u \in W_{r}^{1, p}\left(\mathbb{R}^{N}\right)$ exists such that (5.2)-(5.4) hold, up to subsequences.
Now, we have just to prove that $u \in L^{\infty}\left(\mathbb{R}^{N}\right)$.
As $u \in W_{r}^{1, p}\left(\mathbb{R}^{N}\right)$, from Lemma 4.7 it follows that

From (5.2) it follows that $R_{k}^{+} u_{n} \rightharpoonup R_{k}^{+} u$ weakly in $W_{r}^{1, p}\left(\mathbb{R}^{N}\right)$, then, from (5.14), in $W_{0}^{1, p}\left(B_{1}(0)\right)$. As $W_{0}^{1, p}\left(B_{1}(0)\right) \hookrightarrow \hookrightarrow L^{l}\left(B_{1}(0)\right)$ for any $1 \leq l<p^{*}$, then

\left.\left|\int_{B_{k, n}^{+}} A\left(x, u_{n}\right) R_{k}^{+} u_{n}\right| \nabla u_{n}\right|^{p-2} \nabla u_{n} \cdot \nabla v d x \mid \leq \varepsilon_{k, n} \tag{5.53}
\end{equation*}
$$

Now, if we fix $k>\max \left\{|u|_{\infty}, R, \beta_{0}\right\}+1$, all the previous computations hold also for $k-1$ and then in particular, (5.45) and (5.53) become

$$
\begin{equation*}
\lim _{n \rightarrow+\infty} \int_{B_{k-1, n}}\left|\nabla u_{n}\right|^{p} d x=0 \tag{5.54}
\end{equation*}
$$

and

$$
\begin{equation*}
\left.\left|\int_{B_{k-1, n}^{+}} A\left(x, u_{n}\right) R_{k-1}^{+} u_{n}\right| \nabla u_{n}\right|^{p-2} \nabla u_{n} \cdot \nabla v d x \mid \leq \varepsilon_{k, n} \tag{5.55}
\end{equation*}
$$

Since $B_{k, n}^{+} \subset B_{k-1, n}^{+}$, then

$$
\begin{aligned}
& \int_{B_{k-1, n}^{+}} A\left(x, u_{n}\right) R_{k-1}^{+} u_{n}\left|\nabla u_{n}\right|^{p-2} \nabla u_{n} \cdot \nabla v d x=\int_{B_{k, n}^{+}} A\left(x, u_{n}\right) R_{k-1}^{+} u_{n}\left|\nabla u_{n}\right|^{p-2} \nabla u_{n} \cdot \nabla v d x \\
&+\int_{B_{k-1, n}^{+} \backslash B_{k, n}^{+}} A\left(x, u_{n}\right) R_{k-1}^{+} u_{n}\left|\nabla u_{n}\right|^{p-2} \nabla u_{n} \cdot \nabla v d x \\
&= \int_{B_{k, n}^{+}} A\left(x, u_{n}\right) R_{k}^{+} u_{n}\left|\nabla u_{n}\right|^{p-2} \nabla u_{n} \cdot \nabla v d x+\int_{B_{k, n}^{+}} A\left(x, u_{n}\right)\left|\nabla u_{n}\right|^{p-2} \nabla u_{n} \cdot \nabla v d x \\
&+\int_{B_{k-1, n}^{+} \backslash B_{k, n}^{+}} A\left(x, u_{n}\right) R_{k-1}^{+} u_{n}\left|\nabla u_{n}\right|^{p-2} \nabla u_{n} \cdot \nabla v d x
\end{aligned}
$$

where $\left(H_{1}\right)$, (5.13), the properties of $B_{k-1, n}^{+} \backslash B_{k, n}^{+}$, Hölder inequality and (5.54) imply

$$
\begin{aligned}
\left.\left|\int_{B_{k-1, n}^{+} \backslash B_{k, n}^{+}} A\left(x, u_{n}\right) R_{k-1}^{+} u_{n}\right| \nabla u_{n}\right|^{p-2} \nabla u_{n} \cdot \nabla v d x \mid & \leq c_{6} \int_{B_{k-1, n}^{+} \backslash B_{k, n}^{+}}\left|\nabla u_{n}\right|^{p-1}|\nabla v| d x \\
& \leq c_{6}\left(\int_{B_{k-1, n}^{+}}\left|\nabla u_{n}\right|^{p} d x\right)^{\frac{p-1}{p}} \rightarrow 0
\end{aligned}
$$

Thus, from (5.53) and (5.55) it follows that

$$
\left.\left|\int_{B_{k, n}^{+}} A\left(x, u_{n}\right)\right| \nabla u_{n}\right|^{p-2} \nabla u_{n} \cdot \nabla v d x \mid \leq \varepsilon_{k, n}
$$

Similar arguments apply also if we consider $B_{k, n}^{-}$and the test functions

$$
\varphi_{k, n}^{-}=v R_{k}^{-} u_{n}, \quad \varphi_{k-1, n}^{-}=v R_{k-1}^{-} u_{n}
$$

hence, we have

$$
\begin{equation*}
\left.\left|\int_{B_{k, n}} A\left(x, u_{n}\right)\right| \nabla u_{n}\right|^{p-2} \nabla u_{n} \cdot \nabla v d x \mid \leq \varepsilon_{k, n} \tag{5.56}
\end{equation*}
$$

Thus, (5.34) follows from (5.52) and (5.56) as all $\varepsilon_{k, n}$ are independent of $v$.
Step 2. We note that (5.2)-(5.4) imply that, if $n \rightarrow+\infty$,

$$
\begin{align*}
& T_{k} u_{n} \rightharpoonup u \text { weakly in } W_{r}^{1, p}\left(\mathbb{R}^{N}\right)  \tag{5.57}\\
& \left.T_{k} u_{n} \rightarrow u \text { strongly in } L^{l}\left(\mathbb{R}^{N}\right) \text { for each } l \in\right] p, p^{*}[,  \tag{5.58}\\
& T_{k} u_{n} \rightarrow u \text { a.e. in } \mathbb{R}^{N} . \tag{5.59}
\end{align*}
$$

Now, as in [2], let us consider the real map

$$
\psi: t \in \mathbb{R} \mapsto \psi(t)=t \mathrm{e}^{\eta t^{2}} \in \mathbb{R}
$$

where $\eta>\left(\frac{\beta}{2 \alpha}\right)^{2}$ will be fixed once $\alpha, \beta>0$ are chosen in a suitable way later on. By definition,

$$
\begin{equation*}
\alpha \psi^{\prime}(t)-\beta|\psi(t)|>\frac{\alpha}{2} \quad \text { for all } t \in \mathbb{R} \tag{5.60}
\end{equation*}
$$

If we define $v_{k, n}=T_{k} u_{n}-u$, from the choice of $k$ we have that $\left|v_{k, n}\right|_{\infty} \leq 2 k$ for all $n \in \mathbb{N}$, hence

$$
\begin{equation*}
\left|\psi\left(v_{k, n}\right)\right| \leq \psi(2 k), \quad 0<\psi^{\prime}\left(v_{k, n}\right) \leq \psi^{\prime}(2 k) \quad \text { a.e. in } \mathbb{R}^{N} \text { for all } n \in \mathbb{N} \tag{5.61}
\end{equation*}
$$

while from (5.59) it follows that

$$
\begin{equation*}
\psi\left(v_{k, n}\right) \rightarrow 0, \quad \psi^{\prime}\left(v_{k, n}\right) \rightarrow 1 \quad \text { a.e. in } \mathbb{R}^{N} \text { if } n \rightarrow+\infty . \tag{5.62}
\end{equation*}
$$

Moreover, we note that

$$
\left|\psi\left(v_{k, n}\right)\right| \leq\left|v_{k, n}\right| \mathrm{e}^{4 k^{2} \eta} \quad \text { a.e. in } \mathbb{R}^{N} \text { for all } n \in \mathbb{N}
$$

thus, direct computations imply that $\left(\left\|\psi\left(v_{k, n}\right)\right\|_{X}\right)_{n}$ is bounded, and so from (5.62), up to subsequences, it is

$$
\begin{equation*}
\psi\left(v_{k, n}\right) \rightharpoonup 0 \quad \text { weakly in } W_{r}^{1, p}\left(\mathbb{R}^{N}\right) \tag{5.63}
\end{equation*}
$$

while from (5.34) it follows that

$$
\left\langle d \mathcal{J}\left(T_{k} u_{n}\right), \psi\left(v_{k, n}\right)\right\rangle \rightarrow 0 \quad \text { as } n \rightarrow+\infty
$$

where

$$
\begin{aligned}
\left\langle d \mathcal{J}\left(T_{k} u_{n}\right), \psi\left(v_{k, n}\right)\right\rangle= & \int_{\mathbb{R}^{N} \backslash B_{k, n}} A\left(x, u_{n}\right) \psi^{\prime}\left(v_{k, n}\right)\left|\nabla u_{n}\right|^{p-2} \nabla u_{n} \cdot \nabla v_{k, n} d x \\
& +\frac{1}{p} \int_{\mathbb{R}^{N} \backslash B_{k, n}} A_{t}\left(x, u_{n}\right) \psi\left(v_{k, n}\right)\left|\nabla u_{n}\right|^{p} d x+\int_{\mathbb{R}^{N} \backslash B_{k, n}}\left|u_{n}\right|^{p-2} u_{n} \psi\left(v_{k, n}\right) d x \\
& +k^{p-1} \int_{B_{k, n}} \frac{u_{n}}{\left|u_{n}\right|} \psi\left(v_{k, n}\right) d x-\int_{\mathbb{R}^{N}} g\left(x, T_{k} u_{n}\right) \psi\left(v_{k, n}\right) d x
\end{aligned}
$$

From (5.48) and (5.61) we have

$$
\lim _{n \rightarrow+\infty} \int_{B_{k, n}} \frac{u_{n}}{\left|u_{n}\right|} \psi\left(v_{k, n}\right) d x=0
$$

while, from Lemma 5.3 with $w_{n}=T_{k} u_{n}$ and $v_{n}=\psi\left(v_{k, n}\right)$, it follows that

$$
\lim _{n \rightarrow+\infty} \int_{\mathbb{R}^{N}} g\left(x, T_{k} u_{n}\right) \psi\left(v_{k, n}\right) d x=0
$$

Hence, summing up, we obtain that

$$
\begin{aligned}
\varepsilon_{k, n} \geq & \int_{\mathbb{R}^{N} \backslash B_{k, n}} A\left(x, u_{n}\right) \psi^{\prime}\left(v_{k, n}\right)\left|\nabla u_{n}\right|^{p-2} \nabla u_{n} \cdot \nabla v_{k, n} d x \\
& +\frac{1}{p} \int_{\mathbb{R}^{N} \backslash B_{k, n}} A_{t}\left(x, u_{n}\right) \psi\left(v_{k, n}\right)\left|\nabla u_{n}\right|^{p} d x+\int_{\mathbb{R}^{N} \backslash B_{k, n}}\left|u_{n}\right|^{p-2} u_{n} \psi\left(v_{k, n}\right) d x .
\end{aligned}
$$

Now, we note that, since $\left|u_{n}(x)\right| \leq k$ for all $n \in \mathbb{N}$ a.e. in $\mathbb{R}^{N} \backslash B_{k, n}$, from $\left(H_{1}\right)$ and $\left(H_{2}\right)$ a constant $c_{7}>0$, which depends only on $k$, exists such that

$$
\begin{aligned}
\left.\left|\int_{\mathbb{R}^{N} \backslash B_{k, n}} A_{t}\left(x, u_{n}\right) \psi\left(v_{k, n}\right)\right| \nabla u_{n}\right|^{p} d x \mid \leq & \frac{c_{7}}{\alpha_{0}} \int_{\mathbb{R}^{N} \backslash B_{k, n}} A\left(x, u_{n}\right)\left|\psi\left(v_{k, n}\right)\right|\left|\nabla u_{n}\right|^{p} d x \\
= & \frac{c_{7}}{\alpha_{0}} \int_{\mathbb{R}^{N} \backslash B_{k, n}} A\left(x, u_{n}\right)\left|\psi\left(v_{k, n}\right)\right|\left|\nabla u_{n}\right|^{p-2} \nabla u_{n} \cdot \nabla v_{k, n} d x \\
& +\frac{c_{7}}{\alpha_{0}} \int_{\mathbb{R}^{N} \backslash B_{k, n}} A\left(x, u_{n}\right)\left|\psi\left(v_{k, n}\right)\right|\left|\nabla u_{n}\right|^{p-2} \nabla u_{n} \cdot \nabla u d x
\end{aligned}
$$

where, the boundedness of $\left(u_{n}\right)_{n}$ in $W_{r}^{1, p}\left(\mathbb{R}^{N}\right),\left(H_{1}\right)$, Hölder inequality, (5.61), (5.62) and the Lebesgue Dominated Convergence Theorem imply

$$
\begin{aligned}
0 & \leq\left.\left|\int_{\mathbb{R}^{N} \backslash B_{k, n}} A\left(x, u_{n}\right)\right| \psi\left(v_{k, n}\right)| | \nabla u_{n}\right|^{p-2} \nabla u_{n} \cdot \nabla u d x \mid \\
& \leq c_{8}\left(\int_{\mathbb{R}^{N} \backslash B_{k, n}}\left|\psi\left(v_{k, n}\right)\right|^{p}|\nabla u|^{p} d x\right)^{\frac{1}{p}}\left(\int_{\mathbb{R}^{N} \backslash B_{k, n}}\left|\nabla u_{n}\right|^{p} d x\right)^{\frac{p-1}{p}} \rightarrow 0
\end{aligned}
$$

Thus, setting

$$
h_{k, n}(x)=\psi^{\prime}\left(v_{k, n}\right)-\frac{c_{7}}{p \alpha_{0}}\left|\psi\left(v_{k, n}\right)\right|
$$

and choosing, in the definition of function $\psi$, constants $\alpha=1$ and $\beta=\frac{c_{7}}{p \alpha_{0}}$, from (5.60) it is

$$
\begin{equation*}
h_{k, n}(x)>\frac{1}{2} \quad \text { a.e. in } \mathbb{R}^{N} \tag{5.64}
\end{equation*}
$$

Moreover, we have that

$$
\begin{aligned}
\varepsilon_{k, n} \geq & \int_{\mathbb{R}^{N} \backslash B_{k, n}} h_{k, n} A\left(x, u_{n}\right)\left|\nabla u_{n}\right|^{p-2} \nabla u_{n} \cdot \nabla v_{k, n} d x+\int_{\mathbb{R}^{N} \backslash B_{k, n}}\left|u_{n}\right|^{p-2} u_{n} \psi\left(v_{k, n}\right) d x \\
= & \int_{\mathbb{R}^{N} \backslash B_{k, n}} A(x, u)|\nabla u|^{p-2} \nabla u \cdot \nabla v_{k, n} d x \\
& +\int_{\mathbb{R}^{N} \backslash B_{k, n}}\left(h_{k, n} A\left(x, u_{n}\right)-A(x, u)\right)|\nabla u|^{p-2} \nabla u \cdot \nabla v_{k, n} d x \\
& +\int_{\mathbb{R}^{N} \backslash B_{k, n}} h_{k, n} A\left(x, u_{n}\right)\left(\left|\nabla u_{n}\right|^{p-2} \nabla u_{n}-|\nabla u|^{p-2} \nabla u\right) \cdot \nabla v_{k, n} d x \\
& +\int_{\mathbb{R}^{N} \backslash B_{k, n}}\left(\left|u_{n}\right|^{p-2} u_{n}-|u|^{p-2} u\right) \psi\left(v_{k, n}\right) d x+\int_{\mathbb{R}^{N} \backslash B_{k, n}}|u|^{p-2} u \psi\left(v_{k, n}\right) d x
\end{aligned}
$$

with

$$
\lim _{n \rightarrow+\infty} \int_{\mathbb{R}^{N} \backslash B_{k, n}} A(x, u)|\nabla u|^{p-2} \nabla u \cdot \nabla v_{k, n} d x=0, \quad \lim _{n \rightarrow+\infty} \int_{\mathbb{R}^{N} \backslash B_{k, n}}|u|^{p-2} u \psi\left(v_{k, n}\right) d x=0
$$

from (5.57), respectively (5.63). On the other hand, we note that $\left(H_{0}\right)$, (5.4) and (5.62) imply that $h_{k, n} A\left(x, u_{n}\right)-A(x, u) \rightarrow 0$ a.e. in $\mathbb{R}^{N}$; hence, since $\left(\left\|v_{k, n}\right\|_{W}\right)_{n}$ is bounded, from Hölder inequality and Lebesgue Dominated Convergence Theorem it follows that

$$
\begin{aligned}
& \left.\left|\int_{\mathbb{R}^{N} \backslash B_{k, n}}\left(h_{k, n} A\left(x, u_{n}\right)-A(x, u)\right)\right| \nabla u\right|^{p-2} \nabla u \cdot \nabla v_{k, n} d x \mid \\
& \quad \leq\left(\int_{\mathbb{R}^{N} \backslash B_{k, n}}\left|h_{k, n} A\left(x, u_{n}\right)-A(x, u)\right|^{\frac{p}{p-1}}|\nabla u|^{p}\right)^{\frac{1}{p}}\left\|v_{k, n}\right\|_{W} \rightarrow 0 .
\end{aligned}
$$

Thus, summing up, for the strong convexity of the power function with exponent $p>1$, (5.64), $\left(H_{2}\right)$ and $\mathrm{e}^{\eta v_{k, n}^{2}} \geq 1$ we obtain

$$
\begin{aligned}
\varepsilon_{k, n} \geq \frac{\alpha_{0}}{2} & \int_{\mathbb{R}^{N} \backslash B_{k, n}}\left(\left|\nabla u_{n}\right|^{p-2} \nabla u_{n}-|\nabla u|^{p-2} \nabla u\right) \cdot \nabla v_{k, n} d x \\
& +\int_{\mathbb{R}^{N} \backslash B_{k, n}}\left(\left|u_{n}\right|^{p-2} u_{n}-|u|^{p-2} u\right) v_{k, n} d x \geq 0
\end{aligned}
$$

which implies

$$
\int_{\mathbb{R}^{N} \backslash B_{k, n}}\left(\left|\nabla u_{n}\right|^{p-2} \nabla u_{n}-|\nabla u|^{p-2} \nabla u\right) \cdot \nabla v_{k, n} d x+\int_{\mathbb{R}^{N} \backslash B_{k, n}}\left(\left|u_{n}\right|^{p-2} u_{n}-|u|^{p-2} u\right) v_{k, n} d x \rightarrow 0
$$

or better, from (5.57),

$$
\begin{equation*}
\lim _{n \rightarrow+\infty}\left(\int_{\mathbb{R}^{N} \backslash B_{k, n}}\left|\nabla u_{n}\right|^{p-2} \nabla u_{n} \cdot \nabla v_{k, n} d x+\int_{\mathbb{R}^{N} \backslash B_{k, n}}\left|u_{n}\right|^{p-2} u_{n} v_{k, n} d x\right)=0 \tag{5.65}
\end{equation*}
$$

Since from (5.48) we have that

$$
\lim _{n \rightarrow+\infty} \int_{B_{k, n}}\left|T_{k} u_{n}\right|^{p-2} T_{k} u_{n} \quad v_{k, n} d x=0
$$

and

$$
\int_{\mathbb{R}^{N} \backslash B_{k, n}}\left|\nabla u_{n}\right|^{p-2} \nabla u_{n} \cdot \nabla v_{k, n} d x=\int_{\mathbb{R}^{N}}\left|\nabla T_{k} u_{n}\right|^{p-2} \nabla T_{k} u_{n} \cdot \nabla v_{k, n} d x
$$

(5.65) becomes

$$
\begin{equation*}
\lim _{n \rightarrow+\infty}\left(\int_{\mathbb{R}^{N}}\left|\nabla T_{k} u_{n}\right|^{p-2} \nabla T_{k} u_{n} \cdot \nabla v_{k, n} d x+\int_{\mathbb{R}^{N}}\left|T_{k} u_{n}\right|^{p-2} T_{k} u_{n} v_{k, n} d x\right)=0 \tag{5.66}
\end{equation*}
$$

Now, we define the operator

$$
\mathcal{L}_{p}: u \in W_{r}^{1, p}\left(\mathbb{R}^{N}\right) \mapsto \mathcal{L}_{p} u \in\left(W_{r}^{1, p}\left(\mathbb{R}^{N}\right)\right)^{\prime}
$$

as

$$
\left\langle\mathcal{L}_{p} u, v\right\rangle=\int_{\mathbb{R}^{N}}|\nabla u|^{p-2} \nabla u \cdot \nabla v d x+\int_{\mathbb{R}^{N}}|u|^{p-2} u v d x, \quad v \in W_{r}^{1, p}\left(\mathbb{R}^{N}\right)
$$

Since $\left\langle\mathcal{L}_{p} u, u\right\rangle=\|u\|_{W}^{p}$ and the Hölder inequalities for integrals and sums imply that

$$
\left|\left\langle\mathcal{L}_{p} u, v\right\rangle\right| \leq\|u\|_{W}^{p-1}\|v\|_{W}
$$

from (5.57), (5.66) and [24, Proposition 1.3] it follows that (5.35) holds.
At last, since $\left\|u_{n}-u\right\|_{W} \leq\left\|T_{k} u_{n}-u\right\|_{W}+\left\|R_{k} u_{n}\right\|_{W}$, from (5.35) and (5.47) it follows that $\left\|u_{n}-u\right\|_{W} \rightarrow 0$.
Step 3. As from definition we have $\left|T_{k} u_{n}\right|_{\infty} \leq k$ for all $n \in \mathbb{N}$, the proof follows from (5.35), (5.59), Proposition 3.6 and (5.33), (5.34).

Proof of Theorem 4.2. From Remark 4.9, looking for weak bounded radial solutions of (1.1) is equivalent to finding critical points of the $C^{1}$ functional $\mathcal{J}$, defined in (3.9), restricted to the Banach space $X_{r}$ as in (4.8). Moreover, by definition, it is $\mathcal{J}(0)=0$ and Proposition 5.4 implies that $\mathcal{J}$ satisfies the weak Cerami-Palais-Smale condition in $\mathbb{R}$.
Now, from $\left(H_{2}\right)$, (4.7) with $\varepsilon=\frac{\alpha_{0}}{2}$, (3.1) and direct computations it follows that

$$
\mathcal{J}(u) \geq \frac{\alpha_{0}}{2 p}\|u\|_{W}^{p}-\frac{a_{\varepsilon}}{q} \sigma_{q}^{q}\|u\|_{W}^{q} \quad \text { for any } u \in X_{r}
$$

hence, $r, \varrho>0$ exist such that

$$
u \in X_{r},\|u\|_{W}=r \quad \Longrightarrow \quad J(u) \geq \varrho .
$$

On the other hand, fixing any $\bar{u} \in X_{r}$ such that meas $\left(C_{1}\right)>0$, with $C_{1}=\left\{x \in \mathbb{R}^{N}:|\bar{u}(x)|>1\right\}$, for any $t>1$ from (4.5), Remark 4.5 with $\varepsilon=1,\left(G_{3}\right)$ and direct computations we have

$$
\begin{aligned}
\mathcal{J}(t \bar{u}) & =\frac{t^{p}}{p} \int_{\mathbb{R}^{N}} A(x, t \bar{u})|\nabla \bar{u}|^{p} d x+\frac{t^{p}}{p} \int_{\mathbb{R}^{N}}|\bar{u}|^{p} d x-\int_{\mathbb{R}^{N}} G(x, t \bar{u}) d x \\
& \leq c_{1} t^{p}\|\bar{u}\|_{X}^{p}+c_{2} t^{\mu-\alpha_{2}}\|\bar{u}\|_{X}^{\mu-\alpha_{2}}-\int_{C_{1}} G(x, t \bar{u}) d x-\int_{\mathbb{R}^{N} \backslash C_{1}} G(x, t \bar{u}) d x \\
& \leq c_{1} t^{p}\|\bar{u}\|_{X}^{p}+c_{2} t^{\mu-\alpha_{2}}\|\bar{u}\|_{X}^{\mu-\alpha_{2}}-t^{\mu} \int_{C_{1}} \eta_{1}(x)|\bar{u}|^{\mu} d x .
\end{aligned}
$$

Then, $p<\mu$ implies that $\mathcal{J}(t \bar{u}) \rightarrow-\infty$ as $t \rightarrow+\infty$; hence, $e \in X_{r}$ exists such that $\|e\|_{W}>r$ and $\mathcal{J}(e)<\varrho$. So, the conclusion follows from Theorem 2.2.
