LOW REGULARITY A PRIORI ESTIMATES FOR THE FOURTH ORDER CUBIC NONLINEAR SCHRÖDINGER EQUATION

ABSTRACT. We consider the low regularity behavior of the fourth order cubic nonlinear Schrödinger equation (4NLS)

$$\begin{cases} i\partial_t u + \partial_x^4 u = \pm |u|^2 u, \quad (t,x) \in \mathbb{R} \times \mathbb{R} \\ u(x,0) = u_0(x) \in H^s\left(\mathbb{R}\right). \end{cases}$$

In [17], the author showed that this equation is globally well-posed in $H^s, s \ge -\frac{1}{2}$ and ill-posedness in the sense that the solution map fails to be uniformly continuous for $-\frac{15}{14} < s < -\frac{1}{2}$. Therefore, $s = -\frac{1}{2}$ is the lowest regularity that can be handled by the contraction argument. In spite of this ill-posedness result, we obtain a priori bound below s < -1/2. This a priori estimate guarantees the existence of a weak solution for -3/4 < s < -1/2. But we cannot establish full well-posedness because of the lack of energy estimate of differences of solutions. Our method is inspired by Koch-Tataru [13]. We use the U^p and V^p based spaces adapted to frequency dependent time intervals on which the nonlinear evolution can be still described by linear dynamics.

1. INTRODUCTION

In this paper, we study the Cauchy problem for the fourth order cubic nonlinear Schrödinger equation on \mathbb{R} :

(4NLS)
$$\begin{cases} i\partial_t u + \partial_x^4 u = \mu |u|^2 u, \quad (t,x) \in \mathbb{R} \times \mathbb{R} \\ u(x,0) = u_0(x) \in H^s(\mathbb{R}), \end{cases}$$

where u is a complex-valued function and $\mu = \pm 1$. This equation is called defocusing when the sign of nonlinear term is negative and focusing when the sign is positive. This equation is also known as the biharmonic NLS. The (4NLS) has been studied in the context of stability of solitons in magnetic materials. For more physical background see [9],[10].

This equation is also a Hamiltonian PDE with the following Hamiltonian:

(1.1)
$$H(u(t)) = \frac{1}{2} \int_{\mathbb{R}} |\partial_x^2 u(t)|^2 \, dx \pm \frac{1}{4} \int_{\mathbb{R}} |u(t)|^4 \, dx.$$

Moreover, the mass M(u(t)) is defined by

(1.2)
$$M(u(t)) = \int_{\mathbb{R}} |u(t)|^2 \, dx.$$

This Hamiltonian (1.1) and mass (1.2) are conserved under the (4NLS) flow.

The (4NLS) is invariant with respect to the scaling

(1.3)
$$u(t,x) \to \lambda^2 u(\lambda^4 t, \lambda x)$$

Therefore, the scale invariant homogeneous space is $\dot{H}^{-\frac{3}{2}}$. In general, we have

(1.4)
$$\|u_{0,\lambda}\|_{\dot{H}^{s}(\mathbb{R})} = \lambda^{s+\frac{3}{2}} \|u_{0}\|_{\dot{H}^{s}(\mathbb{R})}.$$

The (4NLS) is globally well-posed for initial data $u_0 \in L^2$. Therefore, it is natural to ask whether the well-posedness also holds in negative Sobolev spaces between $H^{-\frac{3}{2}}$ and L^2 .

Let us investigate the one-dimensional cubic NLS:

(NLS)
$$\begin{cases} i\partial_t u + \partial_x^2 u = \pm |u|^2 u, \quad (t,x) \in \mathbb{R} \times \mathbb{R} \\ u(x,0) = u_0(x) \in H^s(\mathbb{R}). \end{cases}$$

We look at Galilean invariance: if u is a solution of (NLS) with initial data u_0 , then

(1.5)
$$u_N(t,x) = e^{ixN} e^{-itN^2} u(t,x-2Nt)$$

is a solution to the same equation (NLS) with initial data $e^{ixN}u_0(x)$. As a consequence of the Galilean invariance, the flow map cannot be uniformly continuous in $H^s, s < 0$. The details are presented in [2],[12]. As for (4NLS), there is no Galilean symmetry and hence we can pursue the well-posedness theory in negative regularity regime s < 0.

In [17], the author showed that $s = -\frac{1}{2}$ is the sharp regularity threshold for which the well-posedness can be handled by Picard iteration argument. More precisely, for $s \ge -1/2$, the author proved that the (4NLS) is to be locally and globally well-posed in H^s and below s < -1/2, it is ill-posed in the sense that the flow map fails to be uniformly continuous in H^s .

Although the flow map is not uniformly continuous for s < -1/2, we may have well-posedness with only continuous dependence on the initial data. Therefore, our final goal is to fill the gap between $H^{-3/2}$ and $H^{-1/2}$. In fact, to prove the wellposedness, we need to show a priori H^s bounds for the solutions and also establish continuous dependence on the initial data. In this paper, we prove a priori estimates up to s > -3/4. As a corollay, we show the existence of a weak solution for any initial data $u_0 \in H^s$, s > -3/4. Our method is inspired by Koch-Tataru [13] and Christ-Colliander-Tao [1].

The main results of this paper are the following a priori estimate and the existence of weak solution.

Theorem 1.1 (A priori estimate). Let $-\frac{3}{4} < s < -\frac{1}{2}$. Then for any M > 0, there exists time T and constant C so that for initial data $u_0 \in S$ satisfying

 $\|u_0\|_{H^s} \le M,$

the unique solution $u \in C([0,T]; \mathcal{S})$ to (4NLS)(focusing or defocusing) satisfies (1.6) $\sup_{t \in [0,T]} \|u(t)\|_{H^s_x} \leq C \|u_0\|_{H^s_x}.$

Using the uniform bound (1.6) together with the uniform bound on nonlinearity

$$\|\chi_{[0,T]}u\|_{X^s} + \|\chi_{[0,T]}|u|^2 u\|_{Y^s} \lesssim \|u_0\|_{H^s},$$

 $\mathbf{2}$

which is a byproduct of our analysis in proving Theorem 1.1, one may also prove the existence of weak solution by following the similar argument as in [1]. The spaces X^s, Y^s are defined in Section 2.

Corollary 1.2 (Existence of weak solution.). Let $-\frac{3}{4} < s < -\frac{1}{2}$. For any M > 0 there exist time T and constant C so that for any initial data in H^s satisfying

$$\|u_0\|_{H^s} \le M,$$

there exists a weak solution $u \in C([0,T]; H^s) \cap X^s$ to (4NLS) which solves the equation in the sense of distributions and satisfies

$$||u||_{L^{\infty}_{t}H^{s}} + ||\chi_{[0,T]}u||_{X^{s}} + ||\chi_{[0,T]}|u|^{2}u||_{Y^{s}} \le C||u_{0}||_{H^{s}}.$$

The solution obtained by Corollary 1.2 is a weak limit of smooth solutions with smooth initial data approximating given data. We call these solutions weak solutions because we do not have any uniqueness or continuous dependence in H^s , -3/4 < s < -1/2.

Remark 1.3. We can always rescale the initial data and hence it suffices to prove the theorem in small data case $M \ll 1$.

In [17], by just taking advantage of dispersive smoothing effects (bilinear Strichartz estimates, nonresonant interactions), the author proved the local and global well-posedness for $s \ge -1/2$. The main part of the local well-posedness is to show that the following trilinear estimate

$$\|u_1\overline{u_2}u_3\|_{X^{s,b-1}} \le \|u_1\|_{X^{s,\frac{1}{2}+}} \|u_2\|_{X^{s,\frac{1}{2}+}} \|u_3\|_{X^{s,\frac{1}{2}+}}$$

holds for $s \ge -1/2$. However, in [17], the author display an example that for s < -1/2, the above trilinear estimate fails because of the strong resonant interaction of high-high to high.

To deal with these resonant interaction, in this paper we use the short time strucutre. More precisely, we use the functions spaces adapted to a short time interval depending on the dyadic size of spatial frequencies. Then these high-high high to high resonant interaction is overcomed so that we can prove the trilinear estimate below s < -1/2.

In Remark 1.4, one can see that nonlinear solution which is localized at frequency N can be still illustrated by linear dynamics up to the time scale N^{4s+2} . In fact, for $s \ge -1/2$, we already have a local well-posedness result. Therefore, in view of perturbation, nonlinear solutions behave like a linear solution over a time interval which is independent of frequency N. For $s \ge -\frac{1}{2}$, one can observe $N^{4s+2} \ge 1$ for all large $N \gg 1$. Therefore, there is an uniform time interval in N so that nonlinear solutions localized at each frequency N show linear dynamics on that time interval. But for s < -1/2, in order for a nonlinear solution to follow linear dynamics, the time scale must depend on the size of spatial frequencies. Observe that for $s < -\frac{1}{2}$, $N^{4s+2} \ll 1$ for all large $N \gg 1$. In contrast to the case $s \ge -\frac{1}{2}$, it means that different time scales are required for nonlinear solution localized at frequency N to follow linear dynamics.

We also use the U^p and V^p spaces. These spaces have been originally introduced in unpublished work of Tataru on wave maps. In Koch-Tataru [13], they also used U^p and V^p spaces adapted to time intervals depending on the size of spatial frequencies. In Section 2, we define the function spaces employed in our analysis.

We briefly review the difference between Picard iteration method and the short time structure method. In fact, the latter is less perturbative than the former. We consider the following evolution equation: $\partial_t u - Lu = \mathcal{N}(u)$, where Lu is a linear part and $\mathcal{N}(u)$ is a homogeneous nonlinearity of degree p. Then the usual Picard iteration method needs to establish the following two estimates:

> Linear: $\|u\|_{F^s} \lesssim \|u_0\|_{H^s} + \|\mathcal{N}(u)\|_{N^s},$ Nonlinear: $\|\mathcal{N}(u)\|_{N^s} \lesssim \|u\|_{F^s}^p,$

where F^s is the space to measure the solutions and N^s is the space to measure the nonlinearity. After obtaining these two estimates, we can apply the fixed point argument to obtain the local well-posedness in H^s . For the short time strucutre method, by using the gain coming from the short time scale, nonlinear estimate can be improved up to lower regularity levels compared with the previous method. However, linear estimates are worse than before. To address these expense, we need to establish the additional energy estiamtes. In summary, we must establish the following three estimates:

Linear:

$$\begin{aligned} \|u\|_{X^s} \lesssim \|u\|_{\ell^2 L^{\infty}_t H^s_x} + \|\mathcal{N}(u)\|_{Y^s}, \\ \text{Nonlinear:} & \|\mathcal{N}(u)\|_{Y^s} \lesssim \|u\|_{X^s}^p, \\ \text{Energy:} & \|u\|_{\ell^2 L^{\infty}_t H^s_x} \lesssim \|u_0\|_{H^s} + \|u\|_{X^s}^p, \end{aligned}$$

where X^s, Y^s and energy space $\ell^2 L_t^{\infty} H_x^s$ are presented in Section 2. Then by using a continuity argument combining with above three estimates, one can establish an a priori bound and hence can prove the existence of solutions by a compactness argument. In order to obtain the energy bound, we need to use a normal form technique. In applying the normal form reduction, we need to take the expense of introducing higher order multilinear terms.

Therefore, the process of obtaining a priori bound is divided into two main steps. One is to prove the following trilinear estimates (4.1): Let -3/4 < s < -1/2. Then we have

$$||u_1u_2u_3||_{Y^s} \lesssim ||u_1||_{X^s} ||u_2||_{X^s} ||u_3||_{X^s}$$

where Y^s is a function space to measure the nonlinear term in (4NLS) and X^s is a function space to measure the solutions for (4NLS). These function spaces are defined in Section 2.

In the nonlinear interactons which result in high frequency N, we can use the gain $|J| = N^{4s+2}$ occuring from the short time structure and hence, combining the dispersive smoothing effects (e.g. Strichartz estimates (3.5) and bilinear Strichartz estimates (3.14), (3.15)), we can obtain the triliner estimates for all s < -1/2. However, there is a trade-off of using the short time structure. One can expect a loss resulted from summation of short time intervals. More precisely, in the nonlinear interactions which result in low frequency N, there is a loss of derivative originated from the interval summation. In fact, in proving trilinear estimates (4.1), high-high-high to low interaction is the worst case in terms of interval summation losses. To address this side effect of short time structure, we need to use the another dispersive smoothing effects. We can observe that the high-high-high to low interaction is a nonresonant interaction. More precisely, either the output or at least one of the

inputs must have high modulation: under $\xi = \xi_1 - \xi_2 + \xi_3$, $\tau = \tau_1 - \tau_2 + \tau_3$, we have

$$\begin{aligned} &|\tau_1 - \xi_1^4| + |\tau_2 - \xi_2^4| + |\tau_3 - \xi_3^4| + |\tau - \xi^4| \\ &\gtrsim \left| (\xi - \xi_1) \left(\xi - \xi_3 \right) \left(\xi_1^2 + \xi_2^2 + \xi_3^2 + \xi^2 + 2 \left(\xi_1 + \xi_3 \right)^2 \right) \right| \\ &\gtrsim &M_1 M_3^3, \end{aligned}$$

where the size of frequencies $\{\xi, \xi_1, \xi_2, \xi_3\}$ is $\{M, M_1, M_2, M_3\}$ with $|\xi| \approx M, M \ll M_1 \lesssim M_2 \approx M_3$. Furthermore, we use the local smoothing effect. Therefore by exploiting these high modulation gain in the high-high-high to low interaction and local smoothing effect, we are able to weaken the interval summation losses and hence can prove trilinear estimate (4.1) up to $s > -\frac{3}{4}$. The details are presented in Lemma 4.2. In fact, by using only the bilinear smoothing effect (3.14), (3.15) without using the above high modulation gain and local smoothing effect, we can prove trilinear estimate (4.1) up to $s > -\frac{5}{7}$. For more details, see Remark 4.4.

In Lemma 2.5, we prove the following linear estimates: Let u be a solution of $i\partial_t u - \partial_x^4 u = f$. Then we have

(1.7)
$$\|u\|_{X^s} \lesssim \|u\|_{\ell^2 L^\infty H^s} + \|f\|_{Y^s}.$$

Therefore, we use trilinear estimate (4.1) to control the second term on the right hand side of (1.7). Therefore, the other part is to prove the following energy estimates (5.1) to control the first term on the right hand side of (1.7): Let $-\frac{3}{4} < s < -\frac{1}{2}$ and u be a solution to (4NLS). On the time interval [0, 1], we have the following energy estimates (5.1)

$$||u||_{\ell^2_N L^\infty_t H^s} \lesssim ||u_0||_{H^s} + ||u||^3_{X^s}.$$

In Section 5, energy estimate is established by using a high frequency damped multiplier. This method is a modification of the *I*-method introduced by Colliander-Keel-Staffilani-Takaoka-Tao [4], [5], [6]. In the process of obtaining energy estimates, we use the normal form technique with the function spaces relying on frequency dependent time scales. As in proving trilinear estimate (4.1), there is a loss of derivative resulted from the interval summation. To deal with this loss, we also use Lemma 4.2 again. Our method can not construct energy bound (5.1) for differences of solutions, which is the reason we cannot establish full well-posedness in H^s , -3/4 < s < -1/2. The remaining part is to just use standard bootstrapping argument with trilinear estimates (4.1) and energy estiamtes (5.1). The details are presented in Section 6.

Organization of paper. This paper is organized as follows. In Section 2, we introduce U^p and V^p spaces adapted to short time intervals. In Section 3, we collect the linear and bilinear dispersive estimates used to prove the trilinear estimate and the energy estimate. These include Strichartz estimates, bilinear Strichartz estimates, local smoothing estimates and maximal function estimates. In Section 4, the trilinear estimate is proved. To weaken the interval summation losses, we take advantage of Lemma 4.2. In Section 5, the energy estimate with a higher order correction term is established by using a variation of the I-method. Finally, in Section 6, all materials are collected to give a proof of Theorem 1.1.

Remark 1.4. We want to explain that a solution whose frequency is localized to N behaves like a linear solution during at least N^{4s+2} time scales.

Now we assume u is a solution to (4NLS), which is localized at frequency $N \gg 1$. We also suppose $u \approx e^{it\partial_x^4}u_0$ on [0,T] for small time $T \ll 1$ with $||u_0||_{H^s_x} \approx 1$. By using the Duhamel's formula, we write

$$u(t) = e^{it\partial_x^4} u_0 \pm \int_0^t e^{i(t-t')\partial_x^4} |u|^2 u(t') \, dt'.$$

In order for our solution u to follow linear dynamics on [0, T], we should have

(1.8)
$$\left\| \int_0^t e^{i(t-t')\partial_x^4} |u|^2 u(t') \, dt' \right\|_{L^\infty_t H^s_x([0,T] \times \mathbb{R})} \approx 1.$$

Therefore, we estimate above nonlinear term as

$$\begin{split} & \left\| \int_{0}^{t} e^{i(t-t')\partial_{x}^{4}} |u|^{2} u(t') \, dt' \right\|_{L_{t}^{\infty} H_{x}^{s}([0,T] \times \mathbb{R})} \\ & \lesssim N^{s} \| u \overline{u} u \|_{L_{t}^{1} L_{x}^{2}([0,T] \times \mathbb{R})} \\ & \lesssim T^{\frac{1}{2}} N^{s} \| u \|_{L_{t}^{6} L_{x}^{6}([0,T] \times \mathbb{R})}^{3} \end{split}$$

Since u follows linear dynamics on [0,T] i.e. $u \approx e^{it\partial_x^4}u_0$ on [0,T], u satisfies the Strichartz estimate (3.3):

$$\|D^{\frac{1}{3}}e^{it\partial_x^4}u_0\|_{L^6_tL^6_x(\mathbb{R}\times\mathbb{R})} \lesssim \|u_0\|_{L^2_x(\mathbb{R})}.$$

Therefore, by applying the Strichartz estimate (3.3), we have

$$\begin{aligned} \|u\|_{L_{t}^{6}L_{x}^{6}} \approx &\|e^{it\partial_{x}^{4}}u_{0}\|_{L_{t}^{6}L_{x}^{6}([0,T]\times\mathbb{R})} \\ \lesssim &N^{-\frac{1}{3}}\|u_{0}\|_{L_{x}^{2}} \\ \approx &N^{-\frac{1}{3}-s}\|u_{0}\|_{H^{s}} \\ \approx &N^{-\frac{1}{3}-s}\end{aligned}$$

To obtain (1.8), we need

$$T^{\frac{1}{2}}N^{s} \|u\|_{L^{6}_{t}L^{6}_{x}([0,T]\times\mathbb{R})}^{3} \lesssim T^{\frac{1}{2}}N^{s} \left(N^{-\frac{1}{3}-s}\right)^{3} \approx 1.$$

Therefore, we choose time scale $T \approx N^{4s+2} \ll 1$.

By observing this heuristic calculation, we will construct our function spaces to be adapted to time intervals whose length depends on the time scale $T = N^{4s+2}$.

Notation. We use $A \leq B$ if $A \leq CB$ for some C > 0. We use $A \approx B$ when $A \leq B$ and $B \leq A$. Moreover, we use $A \ll B$ if $A \leq \frac{1}{C}B$, where C is a sufficiently large constant. We also write A^{\pm} to mean $A^{\pm \epsilon}$ for any $\epsilon > 0$.

Given $p \ge 1$, we let p' be the Hölder conjugate of p such that $\frac{1}{p} + \frac{1}{p'} = 1$. We denote $L^p = L^p(\mathbb{R}^d)$ be the usual Lebesgue space. We also define the Lebesgue space $L^q(I, L^r)$ be the space of measurable functions from an interval $I \subset \mathbb{R}$ to L^r whose $L^q(I, L^r)$ norm is finite, where

$$||u||_{L^q(I,L^r)} = \left(\int_I ||u(t)||_{L^r}^q\right)^{\frac{1}{q}}.$$

We may write $L_t^q L_x^r (I \times \mathbb{R})$ instead of $L^q (I, L^r)$.

We denote the space time Fourier transform of u(t, x) by $\hat{u}(\tau, \xi)$ or $\mathcal{F}u$

$$\widehat{u}(\tau,\xi) = \mathcal{F}u(\tau,\xi) = \int e^{-it\tau - ix\xi} u(t,x) \, dt dx.$$

On the other hand, the space Fourier transform of u(t, x) is denoted by

$$\widehat{u}(t,\xi) = \mathcal{F}_x u(t,\xi) = \int e^{-ix\xi} u(t,x) \, dx.$$

The fractional differential operator is given via Fourier transform by

$$\widehat{D^{\alpha}u}(\xi) = |\xi|^{\alpha}\widehat{u}(\xi), \quad \alpha \in \mathbb{R},$$

and the biharmonic Schrödinger semigroup is defined by

(1.9)
$$e^{it\partial_x^4} = \mathcal{F}_x^{-1} e^{it|\xi|^4} \mathcal{F}_x g$$

for any tempered distribution g. Let $\varphi : \mathbb{R} \to [0,1]$ be an even, smooth cutoff function supported on [-2,2] such that $\varphi = 1$ on [-1,1]. Given a dyadic number $N \ge 1$, we set $\varphi_1(\xi) = \varphi(|\xi|)$ and

$$\varphi_N(\xi) = \varphi\left(\frac{|\xi|}{N}\right) - \varphi\left(\frac{2|\xi|}{N}\right)$$

for $N \geq 2$. Then we define the Littlewood-Paley projection operator P_N as the Fourier multiplier operator with symbol φ_N . Moreover, we define $P_{\leq N}$ and $P_{\geq N}$ by $P_{\leq N} = \sum_{1 \leq M \leq N} P_M$ and $P_{\geq N} = \sum_{M \geq N} P_M$. They commute with the derivative operator D^{α} and the semigroup $e^{it\partial_x^4}$. We also use the notation $u_N = P_N u$ if there

operator D^{α} and the semigroup $e^{i u o_x}$. We also use the notation $u_N = P_N u$ if there is no confusion.

2. Function spaces

In this section, we set up the function spaces employed in our analysis. We also go over the properties of function spaces U^p and V^p established by Koch, Tataru. These spaces have been used in developing well-posedness of dispersive equations at scaling critical regularities. The details are presented in Hadac-Herr-Koch [7], Herr-Tataru-Tzvetkov [8], Koch-Tataru [14] and Koch-Tataru-Visan [15].

We take a time interval $I = [a, b), -\infty \leq a < b \leq \infty$. Let \mathcal{Z} be the set of partitions $a = t_0 < t_1 < \cdots < t_K = b$ of I. We also consider functions taking values in $L^2 = L^2(\mathbb{R})$.

Definition 2.1. Let $1 \leq p < \infty$. For $\{t_k\}_{k=0}^K \in \mathcal{Z}$ and $\{\phi_k\}_{k=0}^{K-1} \subset L^2(\mathbb{R})$ with $\phi_0 = 0$ and $\sum_{k=0}^{K-1} \|\phi_k\|_{L^2}^p = 1$. We call the function $a: I \to L^2$ given by

$$a(t) = \sum_{k=1}^{K} \chi_{[t_{k-1}, t_k)}(t) \phi_{k-1}$$

a $U^{p}(I; L^{2})$ - atom. We define the $U^{p}(I; L^{2})$ space:

$$U^{p}(I;L^{2}) := \left\{ u = \sum_{j=1}^{\infty} \lambda_{j} a_{j} : a_{j} \text{ is } U^{p}(I;L^{2}) \text{-atom, } \lambda_{j} \in \mathbb{C} \text{ such that } \sum_{j=1}^{\infty} |\lambda_{j}| < \infty \right\}$$

with norm

$$\|u\|_{U^p(I;L^2(\mathbb{R}))} := \inf\left\{\sum_{j=1}^{\infty} |\lambda_j| : u = \sum_{j=1}^{\infty} \lambda_j a_j, \ \lambda_j \in \mathbb{C}, \ a_j \ U^p\left(I;L^2\right) - \operatorname{atom}\right\}.$$

Definition 2.2. Let $1 \le p < \infty$. We define the space $V^p(I; L^2)$ as the space of functions on I such that

$$v(a) = \lim_{t \to a} v(t)$$
 exists and $v(b) := \lim_{t \to b} v(t) = 0$,

and for such functions v(t) we define the norm

$$\|v\|_{V^{p}(I;L^{2})} = \sup_{\{t_{k}\}\in\mathcal{Z}} \left(\sum_{k} \|v(t_{k}) - v(t_{k-1})\|_{L^{2}}^{p}\right)^{\frac{1}{p}}.$$

We also use the notation $U^p = U^p(I; L^2)$ and $V^p = V^p(I; L^2)$ if there is no confusion.

Lemma 2.3 ([7],[13]). *Fix an interval* I = [a, b).

1. Let $1 \leq p < q < \infty$. Then we have continuous embeddings $U^p \hookrightarrow U^q$ and $V^p \hookrightarrow V^q$ i.e.

(2.1)
$$||u||_{U^q} \lesssim ||u||_{U^p} \text{ and } ||u||_{V^q} \lesssim ||u||_{V^p}.$$

2. If $1 \le p < \infty$ and u(b) = 0, then we have $U^p \hookrightarrow V^p$ i.e.

$$\|u\|_{V^p} \lesssim \|u\|_{U^p}.$$

3. If $1 \le p < q \le \infty, u(a) = 0$, and $u \in V^p$ is right continuous, then we have

$$\|u\|_{U^q} \lesssim \|u\|_{V^p}.$$

We define $U_S^p(I; L^2)$, $V_S^p(I; L^2)$ spaces to be the set of all functions $u: I \to L^2$ such that the following $U_S^p(I; L^2)$ -norm and $V_S^p(I; L^2)$ -norm are finite:

$$\|u\|_{U^p_S(I;L^2)} := \|S(-t)u\|_{U^p(I;L^2)} \quad \text{and} \quad \|u\|_{V^p_S(I;L^2)} := \|S(-t)u\|_{V^p(I;L^2)},$$

where $S(t) = e^{it\partial_x^4}$ denotes the linear propagator for (4NLS). Also we use the notation $U_S^p = U_S^p(I; L^2)$ and $V_S^p = V_S^p(I; L^2)$ if there is no confusion.

Remark 2.4. Observe that U_S^p is the atomic space, where atoms are piecewise solutions to the linear equation

$$u = \sum_{k} \chi_{[t_{k-1}, t_k)} e^{it\partial_x^4}(t)\phi_{k-1}, \quad \sum_{k} \|\phi_{k-1}\|_{L^2(\mathbb{R})}^p = 1.$$

We denote by DU_S^p the space of functions

$$DU_{S}^{p} = \left\{ \left(i\partial_{t} - \partial_{x}^{4} \right) u; u \in U_{S}^{p} \right\}$$

with the induced norm. Then we have the trivial bound

(2.2)
$$\|u\|_{U_S^p} \lesssim \|u_0\|_{L_x^2} + \|\left(i\partial_t - \partial_x^4\right)u\|_{DU_S^2}.$$

Moreover we have the duality relations

$$(DU_S^p)^* = V_S^{p'}, \quad 1$$

More precisely, given $\phi \in V_S^{p'}$, the mapping $f \to \int \langle f, \phi \rangle_{L^2} dt$ belongs $(DU_S^p)^*$ and this identification is a surjective isometry. In fact, the spaces DU_S^p and DV_S^p are characterized as the spaces for which the following norms are finite:

(2.3)
$$\|f\|_{DU_{S}^{p}} = \sup\left\{ \int \langle f, \phi \rangle_{L^{2}} dt : \|\phi\|_{V_{S}^{p'}} \le 1, \phi \in C_{c}^{\infty} \right\}$$

(2.4)
$$||f||_{DV_S^p} = \sup\left\{\int \langle f, \phi \rangle_{L^2} \, dt : ||\phi||_{U_S^q} \le 1, \phi \in C_c^\infty\right\}$$

More specifically, see for instance [13], [14].

There is another choice for estimating the solution to (4NLS). The Bourgain's $X^{s,b}$ spaces is defined by

$$\|u\|_{X^{s,b}}^2 = \int |\widehat{u}(\tau,\xi)|^2 \langle \xi \rangle^{2s} \langle \tau - \xi^4 \rangle^{2b} \, d\xi d\tau,$$

where $\langle \cdot \rangle = (1 + |\cdot|^2)^{\frac{1}{2}}$. The space $X^{s,b}$ turns out to be very useful in the study of low regularity theory. But for $b = \frac{1}{2}$, logarithmic divergences happen in several estimates. To deal with this issues we consider dyadic decompositions with respect to the modulation $\tau - \xi^4$. This leads to the additional homogeneous Besov type norms

$$\begin{aligned} \|u\|_{\dot{X}^{s,\frac{1}{2},1}} &= \sum_{M} \left(\int_{|\tau-\xi^{4}|\approx M} |\widehat{u}(\tau,\xi)|^{2} \xi^{2s} |\tau-\xi^{4}| \, d\xi d\tau \right)^{\frac{1}{2}} \\ \|u\|_{\dot{X}^{s,\frac{1}{2},\infty}} &= \sup_{M} \left(\int_{|\tau-\xi^{4}|\approx M} |\widehat{u}(\tau,\xi)|^{2} \xi^{2s} |\tau-\xi^{4}| \, d\xi d\tau \right)^{\frac{1}{2}}. \end{aligned}$$

These homogeneous Besov type spaces are closely related to the spaces U_S^2 and V_S^2 . Combining the embedding $V^2 \hookrightarrow \dot{B}_{2,\infty}^{\frac{1}{2}}$ with duality we have

$$\dot{X}^{0,\frac{1}{2},1} \hookrightarrow U_S^2 \hookrightarrow V_S^2 \hookrightarrow \dot{X}^{0,\frac{1}{2},\infty}.$$

In the following we use a Littlewood-Paley decomposition with respect to the modulation $\tau - \xi^4$ as well as a spatial Littlewood-Paley decomposition

$$1 = \sum_{N \ge 1} P_N, \qquad 1 = \sum_{N \ge 1} Q_N$$

Both decompositions are inhomogeneous. It is easy to see that we have the uniform boundedness properties

$$P_N: U_S^p \to U_S^p, \qquad Q_N: U_S^p \to U_S^p$$

and similarly for V_S^p . Moreover U_S^p and V_S^p spaces behave well with respect to sharp time cut off. If I is a time interval, then we have

$$\chi_I: U_S^p \to U_S^p, \qquad \chi_I: V_S^p \to V_S^p$$

with uniform bounds with respect to I.

We define an energy space with a standard energy norm

$$||u||_{\ell_N^2 L_t^\infty H_x^s}^2 := \sum_{N \ge 1} N^{2s} ||u_N||_{L_t^\infty L_x^2}^2,$$

where we sum over all dyadic numbers ≥ 1 with the obvious modification at N = 1. Note that $\|u\|_{L_t^{\infty} H_x^s} \leq \|u\|_{\ell_x^2 L_t^{\infty} H^s}$, but the converse is not true. KIHOON SEONG

To estimate the solutions to (4NLS) we define the space X^s with the norm

(2.5)
$$\|u\|_{X^s}^2 := \sum_{N \ge 1} N^{2s} \sup_{|I| = N^{4s+2}} \|\chi_I u_N\|_{U_S^2}^2$$

where we sum over all dyadic numbers ≥ 1 with the obvious modification at N = 1and the supremum is taken over all subintervals $I \subset [0, 1]$ of length N^{4s+2} .

To measure the regularity of the nonlinear term we define the space Y^s with the norm

(2.6)
$$||f||_{Y^s}^2 := \sum_{N \ge 1} N^{2s} \sup_{|I| = N^{4s+2}} ||\chi_I f_N||_{DU_S^2}^2$$

where we sum over all dyadic numbers ≥ 1 with the obvious modification at N = 1and the supremum is taken over all subintervals $I \subset [0, 1]$ of length N^{4s+2} .

Proposition 2.5. Let u be a solution to $i\partial_t u - \partial_x^4 u = f$ on I. Then we have

 $\|u\|_{X^s} \lesssim \|u\|_{\ell^2_N L^\infty_t H^s} + \|f\|_{Y^s}.$

This proposition follows from (2.2)

$$||u||_{U_S^p} \lesssim ||u_0||_{L_x^2} + ||f||_{DU_S^2}.$$

More specifically, see [3],[13]

3. Strichartz, local smoothing and bilinear Strichartz estimate

In this section, we collect the standard linear and bilinear estimates.

Lemma 3.1 ([17]). For any $\alpha \in [0,1]$, we call a pair (q,r,α) admissible exponents if $r \geq 2, q \geq \frac{8}{(1+\alpha)}$ and $\frac{4}{q} + \frac{1+\alpha}{r} = \frac{1+\alpha}{2}$. Then for any admissible exponents (q,r,α) , we have

(3.1)
$$\left\| D^{\frac{\alpha}{2}\left(1-\frac{2}{r}\right)} e^{it\partial_x^4} u_0 \right\|_{L^q_t L^r_x(\mathbb{R}\times\mathbb{R})} \lesssim_{q,r} \|u_0\|_{L^2_x(\mathbb{R})}$$

In particular, we have

(3.2)
$$\|D^{\frac{1}{2}}e^{it\partial_x^4}u_0\|_{L^4_tL^{\infty}_x(\mathbb{R}\times\mathbb{R})} \lesssim \|u_0\|_{L^2_x(\mathbb{R})},$$

(3.3)
$$\|D^{\frac{1}{3}}e^{it\partial_{x}^{*}}u_{0}\|_{L_{t}^{6}L_{x}^{6}(\mathbb{R}\times\mathbb{R})} \lesssim \|u_{0}\|_{L_{x}^{2}(\mathbb{R})},$$

(3.4) $\|e^{it\partial_x^4}u_0\|_{L^\infty_t L^2_x(\mathbb{R}\times\mathbb{R})} \lesssim \|u_0\|_{L^2_x(\mathbb{R})}.$

Corollary 3.2. Let I = [a, b) be an interval. Then for any admissible pair (q, r, α) , we have

(3.5)
$$||P_N u||_{L^q_t L^r_x(I \times \mathbb{R})} \lesssim N^{-\frac{\alpha}{2}(1-\frac{2}{r})} ||\chi_I u||_{U^q_s}.$$

Moreover, we have the dual estimate for q > 2:

(3.6)
$$\|P_N u\|_{DU_S^2(I;L^2)} \lesssim N^{-\frac{\alpha}{2}\left(1-\frac{2}{r}\right)} \|u\|_{L_t^{q'}L_x^{r'}(I\times\mathbb{R})}.$$

Proof. We may assume $I = \mathbb{R}$ since χ_I can be inserted. It is enough to consider a U_S^q -atom u:

(3.7)
$$u(t,x) = \sum_{k=1}^{K} \chi_{[t_{k-1},t_k)}(t) S(t) \phi_{k-1}(x), \ \sum_{k=1}^{K} \|\phi_{k-1}\|_{L^2_x}^q \le 1, \text{ and } \phi_0 = 0.$$

and show that

(3.8)
$$||P_N u||_{L^q_t L^r_x} \lesssim N^{-\frac{\alpha}{2}\left(1-\frac{2}{r}\right)}.$$

By using Strichartz estimates (3.1) we have

$$\begin{aligned} \|P_N u\|_{L_t^q L_x^r}^q &= \sum_{k=1}^K \|\chi_{[t_{k-1}, t_k)}(t) P_N S(t) \phi_{k-1}\|_{L_t^q L_x^r}^q \\ &\lesssim N^{-\frac{\alpha}{2} \left(1 - \frac{2}{r}\right)q} \sum_{k=1}^K \|\phi_{k-1}\|_{L_x^2}^q \\ &= N^{-\frac{\alpha}{2} \left(1 - \frac{2}{r}\right)q}. \end{aligned}$$

Now we prove dual estimate. Recall that $(DU^2(I; L^2))^* = V^2(I; L^2)$. Therefore, we have

$$\|P_{N}u\|_{DU_{S}^{2}(I;L^{2})} = \sup_{\|v\|_{V_{S}^{2}(I;L^{2})} \leq 1} \left| \int_{I} \int_{\mathbb{R}} P_{N}u\overline{v} \, dx \, dt \right|$$

$$\lesssim \sup_{\|v\|_{V_{S}^{2}(I;L^{2})} \leq 1} \|u\|_{L_{t}^{q'}L_{x}^{r'}(I\times\mathbb{R})} \|P_{N}v\|_{L_{t}^{q}L_{x}^{r}(I\times\mathbb{R})}.$$

By applying (3.5) and Lemma 2.3, we have

$$\|P_N v\|_{L^q_t L^r_x(I \times \mathbb{R})} \lesssim N^{-\frac{\alpha}{2}\left(1-\frac{2}{r}\right)} \|\chi_I v\|_{U^q_s L^2} \\ \lesssim N^{-\frac{\alpha}{2}\left(1-\frac{2}{r}\right)} \|\chi_I v\|_{V^2_s L^2}$$

which complete the proof.

Lemma 3.3 (Local smoothing, maximal function estimates [11]).

(3.9)
$$\|D^{\frac{3}{2}}e^{it\partial_x^*}u_0\|_{L^{\infty}_x L^2_t} \lesssim \|u_0\|_{L^2_x}$$

(3.10)
$$\|D^{-\frac{1}{4}}e^{it\partial_x^4}u_0\|_{L^4_xL^\infty_t} \lesssim \|u_0\|_{L^2_x}$$

Proof. In the case of local smoothing estimate, the proof is the same as Schrödinger case. In fact, it is reducible to using Plancherel theorem in L_t^2 . For the proof of the maximal function estimate, see Theorem 2.5 in [11].

Corollary 3.4. Let I = [a, b) be an interval. Then we have

(3.11)
$$\|P_N u\|_{L^{\infty}_x L^2_t(I \times \mathbb{R})} \lesssim N^{-\frac{3}{2}} \|\chi_I u\|_{U^2_S}.$$

(3.12)
$$||P_N u||_{L^4_x L^\infty_t(I \times \mathbb{R})} \lesssim N^{\frac{1}{4}} ||\chi_I u||_{U^4_x}.$$

Proof. As we proceed in the proof of Corollary 3.2, it suffices to consider U_S^2, U_S^4 atoms respectively. For more details, see Proposition 2.19 in [7].

Proposition 3.5 (Bilinear estimate). Let $A_1, A_2 \subset \mathbb{R}$ such that

$$|\xi_1^3 - \xi_2^3| = |\xi_1 - \xi_2| |\xi_1^2 + \xi_1 \xi_2 + \xi_2^2| \approx N N_{\text{max}}^2$$

for all $\xi_1 \in A_1, \xi_2 \in A_2$ and $N_{\max} = \max\{|\xi_1|, |\xi_2|\}$. We define the projection operators P_{A_j} as the Fourier multiplier operators $\widehat{P_{A_j}\psi}(\xi) = \chi_{A_j}\widehat{\psi}(\xi)$ for a function ψ . Then we have

$$(3.13) \|P_{A_1}e^{it\partial_x^4}\phi_1P_{A_2}e^{it\partial_x^4}\phi_2\|_{L^2_tL^2_x} \lesssim N^{-\frac{1}{2}}N_{\max}^{-1}\|P_{A_1}\phi_1\|_{L^2_x}\|P_{A_2}\phi_2\|_{L^2_x}$$

г		
L		

Proof. Note that by duality,

$$\begin{split} & \left\| P_{A_{1}} e^{it\partial_{x}^{4}} \phi_{1} P_{A_{2}} e^{it\partial_{x}^{4}} \phi_{2} \right\|_{L^{2}_{t,x}(\mathbb{R} \times \mathbb{R})} \\ &= \left\| \int_{\mathbb{R}} e^{it\xi_{1}^{4}} \widehat{P_{A_{1}}\phi_{1}}\left(\xi_{1}\right) e^{it(\xi-\xi_{1})^{4}} \widehat{P_{A_{2}}\phi_{2}}\left(\xi-\xi_{1}\right) d\xi_{1} \right\|_{L^{2}_{t,\xi}(\mathbb{R} \times \mathbb{R})} \\ &= \sup_{\left\|\psi\right\|_{L_{t,\xi}}^{2}=1} \left| \int_{\mathbb{R} \times \mathbb{R}} \int_{\mathbb{R}} e^{it\xi_{1}^{4}} \widehat{P_{A_{1}}\phi_{1}}\left(\xi_{1}\right) e^{it(\xi-\xi_{1})^{4}} \widehat{P_{A_{2}}\phi_{2}}\left(\xi-\xi_{1}\right) \psi\left(t,\xi\right) d\xi_{1} d\xi dt \right| \end{split}$$

Hence, it suffcies to consider the integral

$$\begin{aligned} \left| \int_{\mathbb{R}\times\mathbb{R}} \int_{\mathbb{R}} e^{it\xi_{1}^{4}} \widehat{P_{A_{1}}\phi_{1}}\left(\xi_{1}\right) e^{it(\xi-\xi_{1})^{4}} \widehat{P_{A_{2}}\phi_{2}}\left(\xi-\xi_{1}\right)\psi\left(t,\xi\right) d\xi_{1}d\xi dt \right| \\ &= \left| \int_{\mathbb{R}\times\mathbb{R}} \int_{\mathbb{R}} e^{it\xi_{1}^{4}} \widehat{P_{A_{1}}\phi_{1}}\left(\xi_{1}\right) e^{it\xi_{2}^{4}} \widehat{P_{A_{2}}\phi_{2}}\left(\xi_{2}\right)\psi\left(t,\xi_{1}+\xi_{2}\right) d\xi_{1}d\xi_{2}dt \right| \\ &= \left| \int_{\mathbb{R}} \int_{\mathbb{R}} \widehat{P_{A_{1}}\phi_{1}}\left(\xi_{1}\right) \widehat{P_{A_{2}}\phi_{2}}\left(\xi_{2}\right) \mathcal{F}_{t}\psi\left(\xi_{1}^{4}+\xi_{2}^{4},\xi_{1}+\xi_{2}\right) d\xi_{1}d\xi_{2} \right|. \end{aligned}$$

We consider the change of variable $(\xi_1, \xi_2) \rightarrow (\eta_1(\xi_1, \xi_2), \eta_2(\xi_1, \xi_2)) = (\xi_1 + \xi_2, \xi_1^4 + \xi_2^4)$ with the Jacobian $|J| = 4 |\xi_1^3 - \xi_2^3| \approx N N_{\max}^2$. Hence,

$$|J| d\xi_1 d\xi_2 = d\eta_1 d\eta_2$$
 or $d\xi_1 d\xi_2 = |J|^{-1} d\eta_1 d\eta_2$.

So, by Hölder's inequality, the Plancherel theorem and again change of variable, we have

$$\begin{split} & \left| \int_{\mathbb{R}} \widehat{\int_{\mathbb{R}} P_{A_1} \phi_1} \left(\xi_1 \right) \widehat{P_{A_2} \phi_2} \left(\xi_2 \right) \mathcal{F}_t \psi \left(\xi_1^4 + \xi_2^4, \xi_1 + \xi_2 \right) \, d\xi_1 d\xi_2 \right| \\ & \lesssim \left\| \mathcal{F}_t \psi \right\|_{L^2_{\eta_1,\eta_2}} \left| \int_{\eta_1 \in \mathbb{R}} \int_{\eta_2 \in \mathbb{R}} \left| \widehat{P_{A_1} \phi_1} \left(\eta_1, \eta_2 \right) \widehat{P_{A_2} \phi_2} \left(\eta_1, \eta_2 \right) \right|^2 \left| J \right|^{-2} \, d\eta_1 d\eta_2 \right|^{\frac{1}{2}} \\ & \lesssim N^{-\frac{1}{2}} N_{\max}^{-1} \left| \int_{\xi_1 \in \mathbb{R}} \int_{\xi_2 \in \mathbb{R}} \left| \widehat{P_{A_1} \phi_1} \left(\xi_1 \right) \widehat{P_{A_2} \phi_2} \left(\xi_2 \right) \right|^2 \, d\xi_1 d\xi_2 \right|^{\frac{1}{2}} \\ & \lesssim N^{-\frac{1}{2}} N_{\max}^{-1} \left\| P_{A_1} \phi_1 \right\|_{L^2_x(\mathbb{R})} \left\| P_{A_2} \phi_2 \right\|_{L^2_x(\mathbb{R})}. \end{split}$$

Corollary 3.6 (bilinear Strichartz estimates). Let $N_1 \ll N_2$. Then we have (3.14)

 $\|P_{N_1}u_1P_{N_2}u_2\|_{L^2_tL^2_x(I\times\mathbb{R})} \lesssim N_2^{-\frac{3}{2}} \|\chi_I P_{N_1}u_1\|_{U^2_sL^2} \|\chi_I P_{N_1}u_1\|_{U^2_sL^2},$

and

(3.15)

$$\|P_{N_1}u_1P_{N_2}u_2\|_{L^2_tL^2_x(I\times\mathbb{R})} \lesssim N_2^{-\frac{3}{2}} (\ln N_2 + 1)^2 \|\chi_I P_{N_1}u_1\|_{V^2_SL^2} \|\chi_I P_{N_1}u_1\|_{V^2_SL^2}.$$

Proof. In fact (3.14) is the result of the transference principle. For more details, see Proposition 2.19 in [7]. The proof of estimate (3.15) follows from the argument in [[7], Proposition 2.20, Corollary 2.21.]

4. TRILINEAR ESTIMATE

In this section, we prove the following trilinear estimates below s < -1/2. As we mentiond above, we use both dispersive smoothing effects (bilinear Strichartz estimates (3.14), (3.15)) and short time structure. Our method is inspired by Koch-Tataru [13].

Proposition 4.1 (Trilinear estimate). Let -3/4 < s < -1/2. Then we have

$$(4.1) \|u_1\overline{u_2}u_3\|_{Y^s} \lesssim \|u_1\|_{X^s}\|u_2\|_{X^s}\|u_3\|_{X^s}$$

Proof. We estimate the nonlinearity $|u|^2 u$ at frequency N in a N^{4s+2} time interval I. We also consider a full dyadic decomposition of each of the factors.

$$\|u_1\overline{u_2}u_3\|_{Y^s} = \left(\sum_{N\geq 1} N^{2s} \sup_{|I|=N^{4s+2}} \|\chi_I P_N(u_1\overline{u_2}u_3)\|_{DU_S^2}^2\right)^{\frac{1}{2}}$$
$$\lesssim \sum_{N\geq 1} N^s \sup_{|I|=N^{4s+2}} \|\chi_I P_N(u_1\overline{u_2}u_3)\|_{DU_S^2}$$

and

$$\|\chi_I P_N(u_1 \overline{u_2} u_3)\|_{DU_S^2} \lesssim \sum_{1 \le N_1, N_2, N_3} \|\chi_I P_N(u_{N_1} \overline{u_{N_2}} u_{N_3})\|_{DU_S^2}$$

Therefore, we need to show that for an interval $|I| = N^{4s+2}$

$$\|\chi_I P_N\left(u_{N_1} u_{N_2} u_{N_3}\right)\|_{DU_S^2} \lesssim N_1^{\alpha_1} N_2^{\alpha_2} N_3^{\alpha_3} N^{\alpha} \prod_{j=1}^3 \sup_{|I_j| = N_j^{4s+2}} \|\chi_{I_j} u_{N_j}\|_{U_S^2}$$

where $N_1^{\alpha_1} N_2^{\alpha_2} N_3^{\alpha_3} N^{\alpha}$ have summability with respect to $N_1, N_2, N_3, N \ge 1$. We denote

$$\{N, N_1, N_2, N_3\} = \{M, M_1, M_2, M_3\}, \quad M_1 \le M_2 \le M_3, N = M.$$

Note that the two largest frequencies must be comparable. Hence, we investigate the following cases of interactions:

Case 1. $M_1 \leq M_2 \leq M_3 \approx M$. Case 2. $M_1 \lesssim M \ll M_2 \approx M_3$. Case 3. $M \ll M_1 \leq M_2 \approx M_3$.

Case 1. $M_1 \leq M_2 \leq M_3 \approx M$. In this case, we observe that $|I_j| \geq |I|$ for j = 1, 2, 3. Hence there is no interval summation loss. At the case 1, there is no role of the complex conjugate. Therefore we drop the complex conjugate sign. By using the dual estimates (3.6), Strichartz estimate (3.3) and embedding $U_S^2 \hookrightarrow U_S^6$,

we have

 $\begin{aligned} \|\chi_{I}P_{M}\left(u_{M_{1}}u_{M_{2}}u_{M_{3}}\right)\|_{DU_{S}^{2}} &\lesssim \|u_{M_{1}}u_{M_{2}}u_{M_{3}}\|_{L_{t}^{1}L_{x}^{2}(I\times\mathbb{R})} \\ &\lesssim |I|^{1/2}\|u_{M_{1}}u_{M_{2}}u_{M_{3}}\|_{L_{t}^{2}L_{x}^{2}(I\times\mathbb{R})} \\ &= M^{2s+1}\|u_{M_{1}}u_{M_{2}}u_{M_{3}}\|_{L_{t}^{2}L_{x}^{2}(I\times\mathbb{R})} \\ &\lesssim M^{2s+1}\|u_{M_{1}}\|_{L_{t}^{6}L_{x}^{6}(I\times\mathbb{R})}\|u_{M_{2}}\|_{L_{t}^{6}L_{x}^{6}(I\times\mathbb{R})}\|u_{M_{3}}\|_{L_{t}^{6}L_{x}^{6}(I\times\mathbb{R})} \\ &\lesssim M^{2s+1}M_{1}^{-\frac{1}{3}}M_{2}^{-\frac{1}{3}}M_{3}^{-\frac{1}{3}}\prod_{j=1}^{3}\|\chi_{I}u_{N_{j}}\|_{U_{S}^{6}} \\ &\lesssim M^{2s+1}M_{1}^{-\frac{1}{3}}M_{2}^{-\frac{1}{3}}M_{3}^{-\frac{1}{3}}\prod_{j=1}^{3}\|\chi_{I}u_{M_{j}}\|_{U_{S}^{2}}. \end{aligned}$

By combining above calculations, we need to focus on the following summation

$$\sum_{M_{1} \leq M_{2} \leq M_{3} \approx M} M^{s} \sup_{|I|=M^{4s+2}} \|\chi_{I} P_{M} \left(u_{M_{1}} u_{M_{2}} u_{M_{3}}\right)\|_{DU_{S}^{2}}$$

$$\lesssim \sum_{M_{1} \leq M_{2} \leq M_{3} \approx M} M^{2s+1} M_{1}^{-\frac{1}{3}-s} M_{2}^{-\frac{1}{3}-s} M_{3}^{-\frac{1}{3}} \prod_{j=1}^{3} \|u_{M_{j}}\|_{X^{s}}$$

$$\lesssim \|u_{1}\|_{X^{s}} \sum_{M_{2} \leq M_{3}} M_{2}^{-2s-\frac{2}{3}} M_{3}^{2s+\frac{2}{3}} \|u_{M_{2}}\|_{X^{s}} \|u_{M_{3}}\|_{X^{s}}.$$

Therefore, by using Schur's test, we obtain the desired result. Observe that in this interaction, trilinear estimate is satisfied for all s < -1/2.

Case 2. $M_1 \leq M \ll M_2 \approx M_3$. Similarly in case 1 there is no role of complex conjugate and hence we drop the complex conjugate sign. Observe that the u_{M_2}, u_{M_3} should be estimated in norm with timescale M_3^{4s+2} . We divide I into $|I|/|J| = \left(\frac{M_3}{M}\right)^{-4s-2} \gg 1$ intervals of size $|J| = M_3^{4s+2}$. By applying the duality (2.3), we have

$$\begin{split} \int_{I} \int_{\mathbb{R}} u_{M_{1}} u_{M_{2}} u_{M_{3}} u_{M} \, dx dt \bigg| \lesssim \left(\frac{M_{3}}{M}\right)^{-4s-2} \sup_{\substack{J \subset I \\ |J| = M_{3}^{4s+2}}} \left| \int_{J} \int_{\mathbb{R}} u_{M_{1}} u_{M_{2}} u_{M_{3}} u_{M} \, dx dt \right| \\ \lesssim \left(\frac{M_{3}}{M}\right)^{-4s-2} \sup_{\substack{J \subset I \\ |J| = M_{3}^{4s+2}}} \|\chi_{J} u_{M_{1}} u_{M_{2}}\|_{L^{2}_{t}L^{2}_{x}} \|\chi_{J} u_{M} u_{M_{3}}\|_{L^{2}_{t}L^{2}_{x}} \\ \lesssim \left(\frac{M_{3}}{M}\right)^{-4s-2} M_{3}^{-3} (\log M_{3})^{2} \\ \times \sup_{\substack{J \subset I \\ |J| = M_{3}^{4s+2}}} \|\chi_{J} u_{M_{1}}\|_{U^{2}_{S}} \|\chi_{J} u_{M_{2}}\|_{U^{2}_{S}} \|\chi_{J} u_{M_{3}}\|_{V^{2}_{S}} \|\chi_{J} u_{M}\|_{V^{2}_{S}} \|\chi_{J} u_{$$

By combining above calculation, we focus on the following summation:

$$\sum_{M_1 \leq M \ll M_2 \approx M_3} M^s \sup_{|I| = M^{4s+2}} \|\chi_I P_M \left(u_{M_1} u_{M_2} u_{M_3} \right) \|_{DU_S^2}$$

$$\lesssim \sum_{M_1 \leq M \ll M_2 \approx M_3} M_3^{-6s-5+} M^{5s+2} M_1^{-s} \|u_{M_1}\|_{X^s} \|u_{M_2}\|_{X^s} \|u_{M_3}\|_{X^s}.$$

We can deal with above summation by using Schwarz inequality if $s > -\frac{5}{6}$.

Case 3. $M \ll M_1 \leq M_2 \approx M_3$. Case 3 is the worst case in terms of the short time structure because the interval summation loss is the largest. However, because case 3 is also a nonresonant interaction unlike the other two cases above, it is necessary to take advantage of nonresonant interaction to weaken this interval summation loss.

To demonstrate the case 3, we need the following lemma

Lemma 4.2. Let $-\frac{3}{4} < s < -\frac{1}{2}$ and I be a time interval with $|I| = N^{4s+2}$. Define

Here the J summation is understood to be over a partition of I into intervals J of the indicated size. Then, we have the estimates

Remark 4.4. By using only the bilinear smoothing effect without Lemma 4.2, we can prove the tirlinear estimate up to $s > -\frac{5}{7}$.

In case 3 $M \ll M_1 \leq M_2 \approx M_3$, we consider two subcase $M \ll M_1 \ll M_2 \approx M_3$ and $M \ll M_1 \approx M_2 \approx M_3$.

Subcase 3.a. $M \ll M_1 \ll M_2 \approx M_3$. By using the same method as in case 2, we need to focus on the following summation

Subcase 3.b $M \ll M_1 \approx M_2 \approx M_3$. In order for the final output to be at frequency M, the two frequency M_3 factors must be M_3 separated. We may assume that u_{M_2}, u_{M_3} are M_3 separated. Therefore we obtain

Observe that the embedding $\dot{X}^{0,\frac{1}{2},1} \hookrightarrow U_S^2$ implies the embedding $\dot{X}^{0,-\frac{1}{2},1} \hookrightarrow DU_S^2$. By using $\dot{X}^{0,-\frac{1}{2},1} \hookrightarrow DU_S^2$, dual estimates (3.6) and Lemma 4.2 we have

Proof of Lemma 4.2. Let (τ_i, ξ_i) be the frequencies for each factor and let (τ, ξ) be the resulting frequency. Then we have

The size of frequencies $\{\xi, \xi_1, \xi_2, \xi_3\}$ is $\{M, M_1, M_2, M_3\}$ with $M \ll M_1 \leq M_2 = M_3$. Here we allow for a slight abuse of notation, as the highest M_j 's need not be equal but merely comparable. Therefore, we have

Hence at least one modulation should be large. Therefore, to take advantage of this modulation gain, we consider the following cases:

Case 1. All input factors have small modulation i.e., $|\tau_1 - \xi_1^4|, |\tau_2 - \xi_2^4|, |\tau_3 - \xi_3^4| \ll M_1 M_3^3$. Therefore, output has large modulation $|\tau - \xi^4| \gtrsim M_1 M_3^3$. **Case 2.** There is at least one input which has large modulation i.e., $|\tau_1 - \xi_1^4| \gtrsim M_1 M_3^3$ or $|\tau_2 - \xi_2^4| \gtrsim M_1 M_3^3$ or $|\tau_3 - \xi_3^4| \gtrsim M_1 M_3^3$. Depending on which factor has the large modulation and on whether the conjugated factor \overline{u}_{N_2} has lower frequency M_1 or not, we divide this case into six.

Case 1. This is when the input factors have small modulation and hence the output has large modulation. Depending on whether the conjugated factor has a lower frequency or not we divide this case into three.

Subcase 1.a First, we consider the first component of f i.e., the conjugated factor \overline{u}_{N_2} has the highest frequency M_3

Since all input factors have small modulation $\ll M_1 M_3^3$, we have

Hence $f_1^{M_1,M_3}$ is localized at modulation $M_1M_3^3 \gg M^4$. For the triple product $v_{M_3}\overline{v_{M_3}}v_{M_1}$, by using the energy bound for v_{M_3} and the bilinear estimate for $v_{M_3}v_{M_1}$, we have

The summation with respect to the dyadic numbers M_1 and M_3 is handled if $s \ge -\frac{11}{14}$. As a result, we conclude

Subcase 1.b The second component of f is that the conjugated factor \overline{u}_{N_2} has lower frequency M_1

Then $f_2^{M_1,M_3}$ is localized at modulation $M_3^4 \gg M^4$.

By using Bernstein, energy bound and bilinear estimate, we have the following $L_{t,x}^2$ bound:

By considering the interval summation losses and using (4.5), we obtain

Since $f_2^{M_1,M_3}$ has modulation M_3^4 , we have

which is summable with respect to dyadic number M_1, M_3 if $s \geq -\frac{11}{14}$. After summation, we obtain

Then $f_3^{M_1,M_3}$ has modulation $M_3^4 \gg M^4$. Observe that $\xi_1 - \xi_2 + \xi_3 = \xi$ with $|\xi| = M, |\xi_i| = M_3, i = 1, 2, 3$. In order for the output to be at a low frequency M, two of the frequencies $\xi_1, -\xi_2, \xi_3$ should be M_3 separated. Therefore, we use the bilinear estimates for those two factors and the energy bound for the remaining factor to obtain

Since the two terms f_4 and f_5 are similar, we may consider the first one f_4 . By using the embedding $V_A^2 \hookrightarrow \dot{X}^{0,\frac{1}{2},\infty}$ for the first factor and the bilinear estimates for the remaining terms, we have

This summation with respect to M_1, M_3 can be dealt with $s \ge -\frac{11}{14}$. After summation with respect to M_1, M_3 , we obtain

$$f_{8} = \sum_{M \ll M_{1} \ll M_{3}} \sum_{\substack{J \subseteq I \\ |J| = M_{3}^{4s+2}}} P_{M} \left(\chi_{J} u_{M_{3}} \overline{Q_{\geq M_{3}^{4}} (\chi_{J} u_{M_{1}})} \chi_{J} u_{M_{3}} \right)$$
$$= \sum_{M \ll M_{1} \ll M_{3}} \sum_{\substack{J \subseteq I \\ |J| = M_{3}^{4s+2}}} f_{8}^{M_{1},M_{3}}.$$

In order for the resulting frequency to be localized at frequency M, the two frequency M_3 factors should be still M_3 separated. Therefore, by applying the bilinear estimate and high modulation bound, we obtain the trilinear estimate

$$\|v_{M_3}\overline{Q_{\gtrsim M_3^4}v_{M_1}}v_{M_3}\|_{L^1_{t,x}} \lesssim M_3^{-\frac{7}{2}} \|v_{M_3}\|_{U^2_S} \|v_{M_3}\|_{U^2_S} \|v_{M_1}\|_{U^2_S}.$$

Therefore, we can argue as in Subcase 2.a with better gains.

Subcase 2.e In this case, all frequencies are equal and the conjugated factor has high modulation. We consider

$$f_{9} = \sum_{M \ll M_{3}} \sum_{\substack{J \subseteq I \\ |J| = M_{3}^{4s+2}}} P_{M} \left(\chi_{J} u_{M_{3}} \overline{Q_{\gtrsim M_{3}^{4}} (\chi_{J} u_{M_{3}})} \chi_{J} u_{M_{3}} \right)$$
$$= \sum_{M \ll M_{3}} \sum_{\substack{J \subseteq I \\ |J| = M_{3}^{4s+2}}} f_{9}^{M_{3}}.$$

This is the worst case since we cannot have any frequency separation among the two unconjugated factors and hence we cannot depend on bilinear gains. Therefore, to obtain summability for M_3 , we use the local smoothing estimates. By using

the local smoothing estimates (3.11), maximal function estimates (3.12) and high modulation bound, we have

(4.13)
$$\|v_{M_3}\overline{Q_{\gtrsim M_3^4}v_{M_3}}v_{M_3}\|_{L_x^{\frac{4}{3}}L_t^1} \lesssim \|v_{M_3}\|_{L_x^{\infty}L_t^2} \|Q_{\gtrsim M_3^4}v_{M_3}\|_{L_x^2L_t^2} \|v_{M_3}\|_{L_x^4L_t^{\infty}} \\ \lesssim M_3^{-\frac{13}{4}} \|v_{M_3}\|_{U_S^2} \|v_{M_3}\|_{U_S^2} \|v_{M_3}\|_{U_S^2}.$$

Low modulation output By considering the interval summation, we obtain

$$\sum_{\substack{J \subset I \\ |J| = M_3^{4s+2}}} \|f_9^{M_3}\|_{L_x^{\frac{4}{3}}L_t^1} \lesssim \left(M^{4s+2}M_3^{-4s-2}\right) M_3^{-3s}M_3^{-\frac{13}{4}} \|u_{M_3}\|_{X^s}^3$$
$$\lesssim M^{4s+2}M_3^{-7s-\frac{21}{4}} \|u_{M_3}\|_{X^s}^3,$$

which is summable with respect to M_3 if $s \ge -\frac{3}{4}$. After summation with respect to M_3 , we obtain

$$\|Q_{\leq M^4} f_9\|_{L_x^{\frac{4}{3}} L_t^1} \lesssim \|f_9\|_{L_x^{\frac{4}{3}} L_t^1} \lesssim M^{-3s - \frac{13}{4}} \|u\|_{X^s}^3$$

To estimate $\|Q_{\geq M^4} f_9\|_{\dot{X}^{0,-\frac{1}{2},1}}$, we need to decompose $Q_{\geq M^4} f_9$ into the following intermediate modulation output and high modulation output:

$$Q_{\geq M^4} f_9 = \sum_{\substack{M_3:\\M \ll M_3}} \sum_{\substack{J \subset I\\|J| = M_3^{4s+2}}} Q_{\geq M^4} f_9^{M_3}$$

=
$$\sum_{\substack{M_3:\\M \ll M_3}} \sum_{\substack{J \subset I\\|J| = M_3^{4s+2}}} Q_{M^4 \leq \sigma \lesssim M_3^4} f_9^{M_3} + \sum_{\substack{M_3:\\M \ll M_3}} \sum_{\substack{J \subset I\\|J| = M_3^{4s+2}}} Q_{\gg M_3^4} f_9^{M_3}.$$

Intermediate modulation output By using Bernstein's inequality and (4.13), we have

$$\|Q_{\sigma}P_{M}\left(v_{M_{3}}\overline{Q_{\gtrsim M_{3}^{4}}v_{M_{3}}}v_{M_{3}}\right)\|_{L^{2}_{x}L^{2}_{t}} \lesssim \sigma^{\frac{1}{2}}M^{\frac{1}{4}}M^{-\frac{13}{4}}_{3}\|v_{M_{3}}\|_{U^{2}_{S}}\|v_{M_{3}}\|_{U^{2}_{S}}\|v_{M_{3}}\|_{U^{2}_{S}}.$$

Hence, by considering the interval summation, we obtain

$$\sum_{\substack{J \subset I \\ |J| = M_3^{4s+2}}} \|Q_{\sigma} f_9^{M_3}\|_{L^2_{t,x}} \lesssim \left(M^{4s+2} M_3^{-4s-2}\right) \sigma^{\frac{1}{2}} M^{\frac{1}{4}} M_3^{-\frac{13}{4}} M_3^{-3s} \|u_{M_3}\|_{X^s}^3$$
$$= M^{4s+\frac{9}{4}} M_3^{-7s-\frac{21}{4}} \sigma^{\frac{1}{2}} \|u_{M_3}\|_{X^s}^3,$$

or equivalently

$$\sum_{\substack{J \subset I \\ |J| = M_3^{4s+2}}} \|Q_{\sigma} f_9^{M_3}\|_{\dot{X}^{0,-\frac{1}{2},1}} \lesssim M^{4s+\frac{9}{4}} M_3^{-7s-\frac{21}{4}} \|u_{M_3}\|_{X^s}^3.$$

By summing over $M^4 \leq \sigma \leq M_3^4$, we obtain

$$\sum_{\substack{M^4 \le \sigma \lesssim M_3^4 \ |J| = M_3^{4s+2}}} \|Q_{\sigma} f_9^{M_3}\|_{\dot{X}^{0,-\frac{1}{2},1}} \lesssim M^{4s+\frac{9}{4}} M_3^{-7s-\frac{21}{4}} \ln\left(\frac{M_3}{M}\right) \|u_{M_3}\|_{X^s}^3.$$

Hence, the summation with respect to M_3 can be handled with $s > -\frac{3}{4}$. After summation with respect to M_3 , we obtain

(4.14)
$$\sum_{M \ll M_3} \sum_{\substack{J \subset I \\ |J| = M_3^{4s+2}}} \|Q_{M^4 \le \sigma \lesssim M_3^4} f_9^{M_3}\|_{\dot{X}^{0,-\frac{1}{2},1}} \lesssim M^{-3-3s} \|u\|_{X^s}^3.$$

High modulation output. In this case, we need to estimate the output localized at modulations $\sigma \gg M_3^4$. In order to obtain such an output at least one of the inputs should have modulation at least σ . We assume that the conjugated factor has modulation σ . This is the worst case since, for the remaining case, we can use the bilinear estimates. By using Bernstein's inequality, we have

$$\|Q_{\sigma}P_{M}\left(v_{M_{3}}\overline{Q_{\sigma}v_{M_{3}}}v_{M_{3}}\right)\|_{L^{2}_{t}L^{2}_{x}} \lesssim \sigma^{\frac{1}{2}}M^{\frac{1}{4}}\|v_{M_{3}}\overline{Q_{\sigma}v_{M_{3}}}v_{M_{3}}\|_{L^{\frac{4}{3}}_{x}L^{\frac{1}{4}}_{t}}$$

By applying local smoothing estimate, maximal function estimate and high modulation bound, we have

$$\begin{split} \|Q_{\sigma}P_{M}\left(v_{M_{3}}\overline{Q_{\sigma}v_{M_{3}}}v_{M_{3}}\right)\|_{L^{2}_{t}L^{2}_{x}} \lesssim & \sigma^{\frac{1}{2}}M^{\frac{1}{4}}M^{-\frac{3}{2}}_{3}M^{\frac{1}{4}}_{3}\sigma^{-\frac{1}{2}}\|v_{M_{3}}\|_{U^{2}_{S}} \\ = & M^{\frac{1}{4}}M^{-\frac{5}{4}}_{3}\|v_{M_{3}}\|^{3}_{U^{2}_{S}}. \end{split}$$

By considering the interval summation, we obtain

$$\sum_{\substack{J \subset I \\ |J| = M_3^{4s+2}}} \|Q_{\gg M_3^4} f_9^{M_3}\|_{\dot{X}^{0, -\frac{1}{2}, 1}} \lesssim \sum_{\substack{J \subset I \\ |J| = M_3^{4s+2}}} \sum_{\sigma \gtrsim M_3^4} \|Q_\sigma f_9^{M_3}\|_{\dot{X}^{0, -\frac{1}{2}, 1}}$$
$$\lesssim \left(M^{4s+2} M_3^{-4s-2}\right) M^{\frac{1}{4}} M_3^{-\frac{13}{4} - 3s} \|u_{M_3}\|_{X^{4s+2}}^3$$
$$= M^{4s+\frac{9}{4}} M_3^{-7s-\frac{21}{4}} \|u_{M_3}\|_{X^{s}}^3,$$

which is summable with respect to M_3 if $s \ge -\frac{3}{4}$. After summation with respect to M_3 , we obtain

(4.15)
$$\sum_{M \ll M_3} \sum_{\substack{J \subset I \\ |J| = M_3^{4s+2}}} \|Q_{\gg M_3^4} f_9^{M_3}\|_{\dot{X}^{0,-\frac{1}{2},1}} \lesssim M^{-3-3s} \|u\|_{X^s}^3.$$

Therefore, by combining the intermediate modulation case (4.14) and high modulation case (4.15), we have

$$\|Q_{\geq M^4} f_9\| \lesssim M^{-3-3s} \|u\|_{X^s}^3.$$

5. Conservation of the H^s energy

In this section, we want to show the conservation of the H^s energy. We are inspired by the method that is analogous to that in Colliander-Keel-Staffilani-Takaoka-Tao [6] and follow the argument in Koch-Tataru [13]. To obtain the energy estimate, we use the *I*-method with correction term.

We first define the H^s energy:

$$E_0(u) = \langle a(D)u, u \rangle.$$

For the H^s energy conservation, we want to choose the symbol $a(\xi) = (1 + \xi^2)^s$, but as in [13], we allow a slightly larger class of symbols.

Definition 5.1. Let $\epsilon > 0, s \in \mathbb{R}$. Then S_{ϵ}^{s} is the class of spherically symmetric symbols with the following properties:

(i) Slowly varying condition: For $|\xi| \approx |\xi'|$, we have

$$a\left(\xi\right) \approx a\left(\xi'\right).$$

(ii) symbol regularity,

$$\left|\partial^{\alpha}a\left(\xi\right)\right| \lesssim a\left(\xi\right)\left(1+\xi^{2}\right)^{-\frac{\alpha}{2}}.$$

(iii) decay at infinity,

$$s - \epsilon \le \frac{\log a(\xi)}{\log (1 + \xi^2)} \le s + \epsilon.$$

Here ϵ is a small parameter.

The main goal of this section is to obtain the following energy bound.

Proposition 5.2. Let $-\frac{3}{4} < s < -\frac{1}{2}$ and u be a solution to (4NLS) with

$$\|u\|_{\ell^2_N L^\infty_t H^s} \ll 1.$$

 $Then \ we \ have$

(5.1)
$$\|u\|_{\ell_N^2 L_t^\infty H^s} \lesssim \|u_0\|_{H^s} + \|u\|_{X^s}^3.$$

We define the energy functional

$$E_0(u) = \|u\|_{H^a}^2 = \langle a(D)u, u \rangle_{L^2_x}.$$

By differentiating this energy under the (4NLS) flow, we have

$$\frac{d}{dt}E_{0}(u) = 2\Re \int_{\xi_{1}-\xi_{2}+\xi_{3}-\xi_{4}=0} ia(\xi_{1})\,\widehat{u}(\xi_{1})\,\overline{\widehat{u}}(\xi_{2})\,\widehat{u}(\xi_{3})\,\overline{\widehat{u}}(\xi_{4})\,.$$

By symmetrizing above integral, we have

$$\frac{d}{dt}E_{0}\left(u\right) = \frac{1}{2}\Re\int_{\xi_{1}-\xi_{2}+\xi_{3}-\xi_{4}=0}i\left(a\left(\xi_{1}\right)-a\left(\xi_{2}\right)+a\left(\xi_{3}\right)-a\left(\xi_{4}\right)\right)\widehat{u}\left(\xi_{1}\right)\overline{\widehat{u}}\left(\xi_{2}\right)\widehat{u}\left(\xi_{3}\right)\overline{\widehat{u}}\left(\xi_{4}\right)$$

We want to cancel this term by adding the correction term $E_1(u)$, where $E_1(u)$ has the form

$$E_1(u) = \int_{\xi_1 - \xi_2 + \xi_3 - \xi_4 = 0} b_4(\xi_1, \dots, \xi_4) \,\widehat{u}(\xi_1) \,\overline{\widehat{u}}(\xi_2) \,\widehat{u}(\xi_3) \,\overline{\widehat{u}}(\xi_4) \,,$$

where the function b_4 is symmetric under the even ξ_j indices, or of the odd ξ_j indices. The b_4 will be determined later. The role of b_4 is to make a cancelation. Observe that

$$\frac{d}{dt}E_{1}\left(u\right) = \int_{\substack{\xi_{1}-\xi_{2}+\xi_{3}-\xi_{4}=0\\ +4\Re \int_{\xi_{1}-\xi_{2}+\xi_{3}-\xi_{4}=0}} ib_{4}\left(\xi_{1}, \ldots, \xi_{4}\right)\left(\xi_{1}^{4}-\xi_{2}^{4}+\xi_{3}^{4}-\xi_{4}^{4}\right)\widehat{u}\left(\xi_{1}\right)\overline{\widehat{u}}\left(\xi_{2}\right)\widehat{u}\left(\xi_{3}\right)\overline{\widehat{u}}\left(\xi_{3}\right).$$

To cancel the first integral in $\frac{d}{dt}E_1(u)$, we choose b_4 as follows:

$$b_4(\xi_1, \dots, \xi_4) = -\frac{a(\xi_1) - a(\xi_2) + a(\xi_3) - a(\xi_4)}{i(\xi_1^4 - \xi_2^4 + \xi_3^4 - \xi_4^4)}, \quad \text{on} \quad P_4 = \{\xi_1 - \xi_2 + \xi_3 - \xi_4 = 0\}.$$

In this situation, a resonant interaction does not appear. Later in Proposition 5.3, we will show that the multiplier b_4 should be fully nonresonant.

Therefore by using the above calculations, we have

(5.2)

$$\Lambda_{6}(u(t)) := \frac{d}{dt} (E_{0} + E_{1})(u) \\
= 4\Re \int_{\substack{\xi_{1} - \xi_{2} + \xi_{3} = \xi \\ \xi_{4} - \xi_{5} + \xi_{6} = \xi}} ib_{4}(\xi_{1}, \xi_{2}, \xi_{3}, \xi) \,\widehat{u}(\xi_{1}) \,\overline{\widehat{u}}(\xi_{2}) \,\widehat{u}(\xi_{3}) \,\overline{\widehat{u}}(\xi_{4}) \,\widehat{u}(\xi_{5}) \,\overline{\widehat{u}}(\xi_{6}).$$

Before we prove the energy estimate, we prove the following multiplier estimate (5.5) that shows the multiplier b_4 is fully nonresonant. In order to estimate the correction term $E_1(u)$ and the derivative of modified energy $\frac{d}{dt}(E_0 + E_1)$, we need to obtain the size of b_4 . Originally, b_4 is defined only on the diagonal $\{\xi_1 - \xi_2 + \xi_3 - \xi_4 = 0\}$. In order to separate variables, we want to extend it off diagonal in a smooth way.

Before stating the Lemma 5.3, we recall the following two mean value formulas: if $|\eta|, |\lambda| \ll |\xi|$, then

(5.3)
$$|a(\xi + \eta) - a(\xi)| \lesssim |\eta| \sup_{|\xi'| \approx |\xi|} |a'(\xi')|,$$

and

(5.4)
$$|a(\xi+\eta+\lambda)-a(\xi+\eta)-a(\xi+\lambda)+a(\xi)| \lesssim |\eta||\lambda| \sup_{|\xi'|\approx|\xi|} \left|a^{''}(\xi')\right|.$$

Proposition 5.3. Let a be a multiplier in S^s_{ϵ} . Then for each dyadic $M_1 \leq M_2 \leq M_3$ there is an extension of b_4 from the diagonal set

$$\{(\xi_1,\xi_2,\xi_3,\xi_4) \in P_4, |\xi_1| \approx M_1, |\xi_2| \approx M_2, |\xi_3|, |\xi_4| \approx M_3\}$$

to the full dyadic set

$$\{|\xi_1| \approx M_1, |\xi_2| \approx M_2, |\xi_3|, |\xi_4| \approx M_3\}$$

which satisfies the size and regularity conditions

(5.5)
$$\left| \partial_{\xi_1}^{\beta_1} \partial_{\xi_2}^{\beta_2} \partial_{\xi_3}^{\beta_3} \partial_{\xi_4}^{\beta_4} b_4 \left(\xi_1, \xi_2, \xi_3, \xi_4 \right) \right| \lesssim a \left(M_1 \right) M_2^{-1} M_3^{-3} M_1^{-\beta_1} M_2^{-\beta_2} M_3^{-\beta_3 - \beta_4}$$

The implicit constants are independent of M_1, M_2, M_3 .

The proof of Proposition 5.3 is analogous to the proof of the Proposition 5.2 in [13]. The only difference is that the stronger dispersion produces an extra smoothing effect as much as M_3^2 . For reader's convenience, we present the proof in detail.

Proof. Observe that on P_4 resonance function admits the following factorization

$$\xi_1^4 - \xi_2^4 + \xi_3^4 - \xi_4^4 = (\xi_4 - \xi_1) \left(\xi_4 - \xi_3\right) \left(\xi_1^2 + \xi_2^2 + \xi_3^2 + \xi_4^4 + 2\left(\xi_1 + \xi_3\right)^2\right)$$

along with all versions of it due to the symmetries of P_4 . For the proof, see [16]. We consider several cases:

(i) $M_1 \ll M_2 \leq M_3$. Then the extension of b_4 is defined using the formula

$$b_4\left(\xi_1,\xi_2,\xi_3,\xi_4\right) = \frac{a(\xi_1) - a(\xi_2) + a(\xi_3) - a(\xi_4)}{\left(\xi_4 - \xi_1\right)\left(\xi_1 - \xi_2\right)\left(\xi_1^2 + \xi_2^2 + \xi_3^2 + \xi_4^4 + 2\left(\xi_1 + \xi_3\right)^2\right)}$$

and its size and regularity properties are easily followed from $|\xi_4 - \xi_1| \approx M_3$ and $|\xi_1 - \xi_2| \approx M_2$.

(ii) $M_1 \approx M_2 \ll M_3$. Then the extension of b_4 is defined by

$$b_4(\xi_1,\xi_2,\xi_3,\xi_4) = \frac{a(\xi_1) - a(\xi_2)}{(\xi_1 - \xi_2)(\xi_4 - \xi_1)\left(\xi_1^2 + \xi_2^2 + \xi_3^2 + \xi_4^4 + 2(\xi_1 + \xi_3)^2\right)} - \frac{a(\xi_3) - a(\xi_4)}{(\xi_3 - \xi_4)(\xi_4 - \xi_1)\left(\xi_1^2 + \xi_2^2 + \xi_3^2 + \xi_4^4 + 2(\xi_1 + \xi_3)^2\right)}$$

Observe that $|\xi_4 - \xi_1| \approx M_3$ and the remaining quotients exhibits cancellation properties. More precisely, by using the mean value formula (5.3), we have

$$\left|\frac{a(\xi_1) - a(\xi_2)}{\xi_1 - \xi_2}\right| \lesssim \frac{a(M_1)}{M_1} \quad \text{and} \quad \left|\frac{a(\xi_3) - a(\xi_4)}{\xi_3 - \xi_4}\right| \lesssim \frac{a(M_3)}{M_3}$$

(iii) $M_1 \approx M_2 \approx M_3$. Then the extension of b_4 is defined by

$$b_4\left(\xi_1,\xi_2,\xi_3,\xi_4\right) = -\frac{a(\xi_4 - (\xi_4 - \xi_3) - (\xi_4 - \xi_1)) - a(\xi_4 - (\xi_4 - \xi_3)) - a(\xi_4 - (\xi_4 - \xi_1)) + a(\xi_4)}{\left(\xi_4 - \xi_1\right)\left(\xi_4 - \xi_3\right)\left(\xi_1^2 + \xi_2^2 + \xi_3^2 + \xi_4^4 + 2\left(\xi_1 + \xi_3\right)^2\right)}$$

In this case, the resonant interaction is the most serious. But we can also use the cancellation properties. More precisely, by using the double mean value theorem (5.4), we have

$$\left|\frac{a(\xi_4 - (\xi_4 - \xi_3) - (\xi_4 - \xi_1)) - a(\xi_4 - (\xi_4 - \xi_3)) - a(\xi_4 - (\xi_4 - \xi_1)) + a(\xi_4)}{(\xi_4 - \xi_1)(\xi_4 - \xi_3)}\right| \lesssim \frac{a(M_3)}{M_3^2}$$

The effect of E_1 to the modified energy is easily controlled by E_0 .

Proposition 5.4. Let $a \in S^s_{\epsilon}$ with $s + \epsilon < -\frac{1}{2}$. Then we have

(5.6)
$$|E_1(u)| \lesssim E_0(u)^2$$
.

Proof. We may assume the functions $\hat{u_j}$ are nonnegative. By using the Lemma 5.3, we have

$$|E_{1}(u)| = \left| \int_{P_{4}} b_{4}(\xi_{1}, \dots, \xi_{4}) \,\widehat{u}(\xi_{1}) \,\overline{\widehat{u}}(\xi_{2}) \,\widehat{u}(\xi_{3}) \,\overline{\widehat{u}}(\xi_{4}) \right| \\ \lesssim \sum_{\substack{N_{1}, N_{2}, N_{3}, N_{4} := \{N_{\min}, N_{\max}, N_{\max}, N_{\max}\}} \frac{a(N_{\min})}{N_{\max}M_{\max}^{3}} \|u_{N_{1}}u_{N_{2}}u_{N_{3}}u_{N_{4}}\|_{L_{x}^{1}}.$$

We may assume $N_1 \leq N_2 \leq N_3 \approx N_4$ by using the symmetry. Therefore, we focus on the summation:

$$\sum_{1 \le N_1 \le N_2 \le N_3 \approx N_4} \frac{a(N_1)}{N_2 N_3^3} \|u_{N_1} u_{N_2} u_{N_3} u_{N_4}\|_{L^1_x}$$

$$\lesssim \sum_{1 \le N_1 \le N_2 \le N_3 \approx N_4} \frac{a(N_1)}{N_2 N_3^3} \|u_{N_1}\|_{L^\infty_x} \|u_{N_2}\|_{L^\infty_x} \|u_{N_3}\|_{L^2_x} \|u_{N_4}\|_{L^2_x}.$$

By using Bernstein's inequality, we have

$$\sum_{\substack{1 \le N_1 \le N_2 \le N_3 \approx N_4}} \frac{a(N_1)}{N_2 N_3^3} N_1^{\frac{1}{2}} N_2^{\frac{1}{2}} \|u_{N_1}\|_{L_x^2} \|u_{N_2}\|_{L_x^2} \|u_{N_3}\|_{L_x^2} \|u_{N_4}\|_{L_x^2}$$

$$\lesssim E_0(u)^2 \sum_{\substack{1 \le N_1 \le N_2 \le N_3 \approx N_4}} \frac{a(N_1)^{\frac{1}{2}}}{N_3^3} \frac{N_1^{\frac{1}{2}} N_2^{-\frac{1}{2}}}{a(N_2)^{\frac{1}{2}} a(N_3)}.$$

The remaining summation with respect to N_1, N_2, N_3 is easily handled. In fact, it is enough to assume $s > -\frac{7}{6}$.

Proposition 5.5. Let $a \in S^s_{\epsilon}$ with $s + \epsilon < -\frac{1}{2}$ and $s > -\frac{3}{4}$. Then we have

Proof. We consider a dyadic decomposition and represent the above integral in the frequency side as a dyadic sum of terms of the form

Here φ_N is the Fourier multiplier for P_N . There are two cases to consider:

We may assume $Q_{\sigma}u_{M_2}$. This is the worst case. We bound $Q_{\sigma}u_{M_2}$ in L^2 and the other two u_{M_3}, u_{M_3} in L^{∞} . By proceeding as in Subcase 1.b, we obtain

$$|\Lambda_1| \lesssim a(M_1) M_1^{-5s-4} M_2^{-1-s} M_3^{-4s-3} \|u_{M_3}\|_{X^s} \|u_{M_3}\|_{X^s} \|u\|_{X^s}^4.$$

Hence, the summation with respect to M_1, M_2, M_3 is also handled if $s \ge -\frac{3}{4}$.

Case 2. $N \gtrsim \min \{N_4, N_5, N_6\}$. Without loss of generality we may assume

$$N_1 \le N_2 \le N_3, \qquad N_4 \le N_5 \le N_6.$$

Then we must have

$$N_4 \lesssim N \lesssim N_3$$

We denote

$$\{N, N_1, N_2, N_3\} = \{M_1, M_2, M_3, M_3\}, \quad M_1 \le M_2 \le M_3.$$

We may expand the Fourier multiplier φ_N for P_N into a Fourier integral. For a Schwartz function ρ_N , we have

(5.7)
$$\varphi_N(\xi) = \int \rho_N(y) e^{i\xi y} \, dy = \int \rho_N(y) e^{i\xi_4 y} e^{-i\xi_5 y} e^{i\xi_6 y} \, dy, \quad \xi = \xi_4 - \xi_5 + \xi_6.$$

Here we can separate the exponential into three factors since in the domain of integration we have $\xi = \xi_4 - \xi_5 + \xi_6$. The complex exponentials are bounded symbols and thus bounded on U_S^2 . Therefore it can be harmlessly absorbed into $u_{N_4}, u_{N_5}, u_{N_6}$. Moreover we have $\|\rho_N\|_{L^1} \leq 1$ uniformly in N. Plugging in the expression (5.5) and absorbing the factors originating from (5.7) into the \hat{u}_i , we are left with estimating

$$\sum_{\substack{N,N_1,N_2,N_3,N_4,N_5,N_6:\\\{N,N_1,N_2,N_3\} = \{M_1,M_2,M_3,M_3\}}} \frac{a(M_1)}{M_2M_3^3} \int_0^1 \int_{\mathbb{R}} u_{N_1} u_{N_2} u_{N_3} u_{N_4} u_{N_5} u_{N_6} \, dx \, dt$$
$$= \sum_{\substack{N,N_1,N_2,N_3,N_4,N_5,N_6:\\\{N,N_1,N_2,N_3\} = \{M_1,M_2,M_3,M_3\}}} \Lambda_2.$$

Subcase 2.a $N = M_3$. In this case we have $N_4 \leq N = M_3, N = M_3 \leq N_6$.

Subcase 2.a.i $N_6 \approx N_5 \gg M_3$. We use the bilinear estimates for the products $u_{M_3}u_{N_5}$ and $u_{N_4}u_{N_6}$ and the L^{∞} bound for u_{M_1}, u_{M_2} . Then by considering the interval summation loss N_6^{-4s-2} , we have

$$\begin{split} |\Lambda_{2}| \lesssim & \frac{a\left(M_{1}\right)}{M_{2}M_{3}^{3}} N_{6}^{-4s-2} \left(M_{1}^{-s} M_{2}^{-s} M_{3}^{-s} N_{4}^{-s} N_{6}^{-2s}\right) \left(M_{1}^{\frac{1}{2}} M_{2}^{\frac{1}{2}}\right) \left(N_{6}^{-\frac{3}{2}} N_{6}^{-\frac{3}{2}}\right) \prod_{j=1}^{3} \|u_{M_{j}}\|_{X^{s}} \|u_{N_{4}}\|_{X^{s}} \|u_{N_{6}}\|_{X^{s}}^{2s} \\ \lesssim & a\left(M_{1}\right) M_{1}^{\frac{1}{2}-s} M_{2}^{-\frac{1}{2}-s} M_{3}^{-s-3} N_{4}^{-s} N_{6}^{-6s-5} \prod_{j=1}^{3} \|u_{M_{j}}\|_{X^{s}} \|u_{N_{4}}\|_{X^{s}} \|u_{N_{6}}\|_{X^{s}}^{2s}. \end{split}$$

Hence the summation with respect to N, N_1, \ldots, N_6 is handled if $s \ge -\frac{5}{6}$.

Subcase 2.a.ii $N_5 \leq N_6 \approx M_3$ and $M_2 \ll M_3$. Then we use the bilinear estimates for $u_{M_2}u_{M_3}$ and L^{∞} bound for u_{M_1} and the L^6 Strichartz estimate for the $u_{N_4}, u_{N_5}, u_{N_6}$. By considering the interval summation loss, we have

$$\begin{split} |\Lambda_{2}| \lesssim & \frac{a \left(M_{1}\right)}{M_{2} M_{3}^{3}} M_{3}^{-4s-2} \left(M_{1}^{-s} M_{2}^{-s} M_{3}^{-s} N_{4}^{-s} N_{5}^{-s} M_{3}^{-s}\right) M_{3}^{-\frac{3}{2}} M_{1}^{\frac{1}{2}} \left(N_{4}^{-\frac{1}{3}} N_{5}^{-\frac{1}{3}} M_{3}^{-\frac{1}{3}}\right) \\ & \times \prod_{j=1}^{3} \|u_{M_{j}}\|_{X^{s}} \|u_{N_{4}}\|_{X^{s}} \|u_{N_{5}}\|_{X^{s}} \|u_{M_{3}}\|_{X^{s}} \\ \lesssim & a \left(M_{1}\right) M_{1}^{\frac{1}{2}-s} M_{2}^{-1-s} M_{3}^{-6s-\frac{41}{6}} N_{4}^{-s-\frac{1}{3}} N_{5}^{-s-\frac{1}{3}} \|u_{M_{3}}\|_{X^{s}} \|u_{M_{3}}\|_{X^{s}} \|u_{M_{3}}\|_{X^{s}} \|u_{M_{3}}\|_{X^{s}} \|u_{M_{3}}\|_{X^{s}} \|u_{M_{3}}\|_{X^{s}} \|u\|_{X^{s}}^{4}. \end{split}$$

Hence the summation with respect to N, N_1, \ldots, N_6 is handled if $s \ge -\frac{15}{16}$.

Subcase 2.a.iii $N_5 \leq N_6 \approx M_3$ and $M_2 \approx M_3$. In this case, we use the L^6 Strichartz estimate for all the factors. Then we have

$$\begin{split} |\Lambda_{2}| \lesssim & \frac{a\left(M_{1}\right)}{M_{2}M_{3}^{3}} M_{3}^{-4s-2} \left(M_{1}^{-s} M_{3}^{-2s} N_{4}^{-s} N_{5}^{-s} M_{3}^{-s}\right) \left(M_{1}^{-\frac{1}{3}} M_{3}^{-\frac{2}{3}} N_{4}^{-\frac{1}{3}} N_{5}^{-\frac{1}{3}} M_{3}^{-\frac{1}{3}}\right) \prod_{j=1}^{6} \|u_{M_{j}}\|_{X^{s}} \\ \lesssim & a\left(M_{1}\right) M_{1}^{-s-\frac{1}{3}} N_{4}^{-s-\frac{1}{3}} N_{5}^{-s-\frac{1}{3}} M_{3}^{-7s-7} \|u_{M_{3}}\|_{X^{s}} \|u_{M_{3}}\|_{X^{s}} \|u\|_{X^{s}}^{4}. \end{split}$$

Hence the summation with respect to N, N_1, \ldots, N_6 is handled if $s \ge -\frac{23}{27}$. Subcase 2.b $N = M_2 \ll M_3$. In this case we have $N_4 \lesssim N = M_2$. **Subcase 2.b.i** $N_6 \approx N_5 \gg M_3$. In this case, we use the bilinear estimates for the products $u_{M_3}u_{N_5}$ and $u_{N_4}u_{N_6}$ and the L^{∞} bound for u_{M_1}, u_{M_3} . Then we have

$$\begin{split} |\Lambda_{2}| \lesssim & \frac{a\left(M_{1}\right)}{M_{2}M_{3}^{3}} N_{6}^{-4s-2} \left(M_{1}^{-s}M_{3}^{-2s}N_{4}^{-s}N_{6}^{-2s}\right) \left(M_{1}^{\frac{1}{2}}M_{3}^{\frac{1}{2}}\right) \left(N_{6}^{-\frac{3}{2}}N_{6}^{-\frac{3}{2}}\right) \|u\|_{X^{s}}^{4} \|u_{N_{6}}\|_{X^{s}}^{2} \\ \lesssim & a\left(M_{1}\right) M_{1}^{-s+\frac{1}{2}}M_{2}^{-1}M_{3}^{-2s-\frac{5}{2}}N_{4}^{-s}N_{6}^{-6s-5} \|u\|_{X^{s}}^{4} \|u_{N_{6}}\|_{X^{s}}^{2}. \end{split}$$

Hence the summation with respect to N, N_1, \ldots, N_6 is handled if $s \ge -\frac{5}{6}$.

Subcase 2.b.ii $N_5 \leq N_6 \approx M_3$. Then we use the bilinear estimates for $u_{M_1}u_{M_3}$ and L^{∞} bound for u_{M_3} and the L^6 Strichartz estimate for the $u_{N_4}, u_{N_5}, u_{N_6}$. Then we have

$$\begin{split} |\Lambda_{2}| \lesssim & \frac{a\left(M_{1}\right)}{M_{2}M_{3}^{3}} M_{3}^{-4s-2} \left(M_{1}^{-s}M_{3}^{-2s}N_{4}^{-s}N_{5}^{-s}M_{3}^{-s}\right) M_{3}^{-\frac{3}{2}}M_{3}^{\frac{1}{2}} \left(N_{4}^{-\frac{1}{3}}N_{5}^{-\frac{1}{3}}M_{3}^{-\frac{1}{3}}\right) \|u\|_{X^{s}}^{4} \|u_{N_{6}}\|_{X}^{2} \\ \lesssim & a\left(M_{1}\right) M_{1}^{-s}M_{2}^{-1}M_{3}^{-7s-\frac{19}{3}}N_{4}^{-s-\frac{1}{3}}N_{5}^{-s-\frac{1}{3}} \|u_{M_{3}}\|_{X^{s}} \|u_{M_{3}}\|_{X^{s}} \|u\|_{X^{s}}^{4} \|u\|_{X^{s}}^{4}. \end{split}$$

Hence the summation with respect to N, N_1, \ldots, N_6 is handled if $s \ge -\frac{5}{6}$.

Subcase 2.b.iii $N_5 \leq N_6 \ll M_3$. In this case, we use the bilinear estimates for the products $u_{M_3}u_{N_5}$ and $u_{M_3}u_{N_6}$ and the L^{∞} bound for u_{M_1}, u_{N_4} . Then we have

$$\begin{split} |\Lambda_{2}| \lesssim & \frac{a\left(M_{1}\right)}{M_{2}M_{3}^{3}} M_{3}^{-4s-2} \left(M_{1}^{-s}M_{3}^{-2s}N_{4}^{-s}N_{5}^{-s}N_{6}^{-s}\right) \left(M_{1}^{\frac{1}{2}}N_{4}^{\frac{1}{2}}\right) \left(M_{3}^{-\frac{3}{2}}M_{3}^{-\frac{3}{2}}\right) \|u\|_{X^{s}}^{4} \|u_{M_{3}}\|_{X^{s}}^{2} \\ \lesssim & a\left(M_{1}\right) M_{1}^{-s+\frac{1}{2}} M_{2}^{-1} N_{4}^{-s+\frac{1}{2}} N_{5}^{-s} N_{6}^{-s} M_{3}^{-6s-8} \|u_{M_{3}}\|_{X^{s}} \|u_{M_{3}}\|_{X^{s}} \|u\|_{X^{s}}^{4} \|u\|_{X^{s}}^{4}. \end{split}$$

Hence the summation with respect to N, N_1, \ldots, N_6 is handled if $s \geq -\frac{17}{18}$.

Subcase 2.c $N = M_1 \ll M_2$. In this case we have $N_4 \leq N = M_1$.

Subcase 2.c.i $N_6 \approx N_5 \gg M_3$. We use the bilinear estimates for the products $u_{M_3}u_{N_5}$ and $u_{M_3}u_{N_6}$ and the L^{∞} bound for u_{M_2}, u_{N_4} . Then we have

$$\begin{split} |\Lambda_{2}| \lesssim & \frac{a\left(M_{1}\right)}{M_{2}M_{3}^{3}} N_{6}^{-4s-2} \left(M_{2}^{-s} M_{3}^{-2s} N_{4}^{-s} N_{6}^{-2s}\right) \left(M_{2}^{\frac{1}{2}} N_{4}^{\frac{1}{2}}\right) \left(N_{6}^{-\frac{3}{2}} N_{6}^{-\frac{3}{2}}\right) \|u\|_{X^{s}}^{4} \|u_{N_{6}}\|_{X^{s}}^{2} \\ \lesssim & a\left(M_{1}\right) M_{2}^{-\frac{1}{2}-s} N_{4}^{\frac{1}{2}-s} M_{3}^{-2s-3} N_{6}^{-6s-5} \|u\|_{X^{s}}^{4} \|u_{N_{6}}\|_{X^{s}} \|u_{N_{6}}\|_{X^{s}}. \end{split}$$

Hence the summation with respect to N, N_1, \ldots, N_6 is handled if $s \ge -\frac{5}{6}$.

Subcase 2.b.ii $N_5 \leq N_6 \approx M_3$. Then we use the bilinear estimates for $u_{N_4}u_{M_3}$ and L^{∞} bound for u_{M_2} and the L^6 Strichartz estimate for the $u_{M_3}, u_{N_5}, u_{N_6}$. Then we have

$$\begin{split} |\Lambda_{2}| \lesssim & \frac{a\left(M_{1}\right)}{M_{2}M_{3}^{3}}M_{3}^{-4s-2}\left(M_{2}^{-s}M_{3}^{-2s}N_{4}^{-s}N_{5}^{-s}M_{3}^{-s}\right)M_{3}^{-\frac{3}{2}}M_{2}^{\frac{1}{2}}\left(M_{3}^{-\frac{1}{3}}N_{5}^{-\frac{1}{3}}M_{3}^{-\frac{1}{3}}\right)\|u\|_{X^{s}}^{4}\|u_{N_{6}}\|_{X^{s}}^{2}\\ \lesssim & a\left(M_{1}\right)M_{2}^{-\frac{1}{2}-s}M_{3}^{-7s-\frac{43}{6}}N_{4}^{-s}N_{5}^{-s-\frac{1}{3}}\|u_{M_{3}}\|_{X^{s}}\|u_{M_{3}}\|_{X^{s}}\|u\|_{X^{s}}^{4}\|u\|_{X^{s}}^{4}. \end{split}$$

Hence the summation with respect to N, N_1, \ldots, N_6 is handled if $s \ge -\frac{8}{9}$.

Subcase 2.b.iii $N_5 \leq N_6 \ll M_3$. In this case, we use the bilinear estimates for the products $u_{M_3}u_{N_5}$ and $u_{M_3}u_{N_6}$ and the L^{∞} bound for u_{M_2}, u_{N_4} . Then we have

$$\begin{aligned} |\Lambda_{2}| \lesssim & \frac{a\left(M_{1}\right)}{M_{2}M_{3}^{3}} M_{3}^{-4s-2} \left(M_{2}^{-s} M_{3}^{-2s} N_{4}^{-s} N_{5}^{-s} N_{6}^{-s}\right) \left(M_{2}^{\frac{1}{2}} N_{4}^{\frac{1}{2}}\right) \left(M_{3}^{-\frac{3}{2}} M_{3}^{-\frac{3}{2}}\right) \|u\|_{X^{s}}^{4} \|u_{M_{3}}\|_{X^{s}}^{2} \\ \lesssim & a\left(M_{1}\right) M_{2}^{-s-\frac{1}{2}} N_{4}^{-s+\frac{1}{2}} N_{5}^{-s} N_{6}^{-s} M_{3}^{-6s-8} \|u_{M_{3}}\|_{X^{s}}^{2} \|u\|_{X^{s}}^{4}. \end{aligned}$$

Hence the summation with respect to N, N_1, \ldots, N_6 is handled if $s \ge -\frac{17}{18}$. \Box

To finish the proof of energy estimate, we need to choose suitable symbol $a(\xi)$ in the previous sections. As in [13], we need the following sequence:

$$\beta_N^0 = \frac{N^{2s} ||u_{0,N}||_{L^2}^2}{||u_0||_{H^s}^2}$$
$$\beta_N = \sum_M 2^{-\frac{\epsilon}{2} |\log N - \log M|} \beta_M^0$$

These β_N satisfy the following property

(i)
$$N^{2s} \|u_{0,N}\|_{L^2}^2 \lesssim \beta_N \|u_0\|_{H^s}^2$$

(ii)
$$\sum \beta_N \lesssim 1$$
,

(iii) β_N is slowly varying in the sense that

$$|\log_2 \beta_N - \log_2 \beta_M| \lesssim \frac{\epsilon}{2} |\log_2 N - \log_2 M|.$$

We want to show that

(5.8)
$$\sup_{t} N_{0}^{s} \| u_{N_{0}}(t) \|_{L^{2}} \lesssim \beta_{N_{0}}^{\frac{1}{2}} \left(\| u_{0} \|_{H^{s}} + \| u \|_{X^{s}}^{3} \right).$$

Then by using the property (ii) we can conclude Proposition 5.2

To prove (5.8) for some frequency N_0 we choose

$$a_N = N^{2s} \max\left\{1, \beta_{N_0}^{-1} 2^{-\epsilon |\log_2 N - \log_2 N_0|}\right\}$$

Correspondingly we take a function $a(\xi) \in S^s_{\epsilon}$ so that

$$a(\xi) \approx a_N, \quad |\xi| \approx N.$$

Then from the slowly varying condition, we obtain

$$\sum_{N} a_{N} \|u_{0,N}\|_{L_{x}^{2}}^{2} \lesssim \sum_{N} N^{2s} \|u_{0,N}\|_{L_{x}^{2}}^{2} + 2^{-\epsilon |\log_{2} N - \log_{2} N_{0}|} N^{2s} \beta_{N_{0}}^{-1} \|u_{0,N}\|_{L_{x}^{2}}^{2} \lesssim \|u_{0}\|_{H^{s}}^{2}.$$

From $||u||_{\ell_N^2 L_t^{\infty} H^s} \ll 1$, we have $\sup_t E_0(u(t)) \ll 1$. Recall that

$$\frac{d}{dt} \left(E_0 + E_1 \right) \left(u \right) = \Lambda_6 \left(u(t) \right).$$

From Proposition 5.4 the contribution of E_1 to the energy is controlled by E_0 . Also, we use the energy estimate in Proposition 5.5 for this choice of a. Therefore, we obtain

$$\left(\sum_{N} a(N) \|u_N(t)\|_{L^2_x}^2\right)^{\frac{1}{2}} \lesssim \|u_0\|_{H^s} + \|u\|_{X^s}^3.$$

At fixed frequency $N = N_0$, we obtain (5.8).

6. Proof of Theorem 1.1

In this section we prove our main Theorem 1.1. The remaining part is just to do standard bootstrapping argument with trilinear estimate (4.1) and energy estimate (5.1). Our method is similar to the argument in Koch-Tataru [13]. Before we prove Theorem 1.1, we collect ingredients we need:

Linear:
$$\|u\|_{X^s} \lesssim \|u\|_{\ell^2 L^{\infty}_t H^s_x} + \||u|^2 u\|_{Y^s}$$
 (2.5),
Nonlinear: $\||u|^2 u\|_{Y^s} \le \|u\|^3_{Y^s}$ (4.1).

$$||u||_{\ell^2 L^{\infty}_t H^s_x} \lesssim ||u_0||_{H^s} + ||u||_{X^s}^{5}$$
 (5.2).

As we mentioned in Remark 1.3, by rescaling the problem we consider small initial data. Let $\epsilon > 0$ be a small constant and suppose $||u_0||_{H^s(\mathbb{R})} < \epsilon$. Take a small δ so that $\epsilon \ll \delta \ll 1$. We denote by A the set

$$A = \left\{ T \in [0,1]; \|u\|_{\ell_N^2 L_t^\infty H^s([0,T] \times \mathbb{R})} \le 2\delta, \|u\|_{X^s([0,T] \times \mathbb{R})} \le 2\delta \right\}.$$

We want to show that A = [0, 1]. Clearly A is not empty and $0 \in A$. We need to prove that it is closed and open. From the definition, the norms used in A are continuous with respect to T and hence A is closed.

Let $T \in A$. By using Proposition 5.2, we have

$$\|u\|_{\ell^2_N L^\infty_t H^s([0,T]\times\mathbb{R})} \lesssim \epsilon + \delta^3,$$

and by Proposition 2.5 and 4.1, we have

$$\|u\|_{X^s([0,T]\times\mathbb{R})} \lesssim \epsilon + \delta^3$$

Hence by taking ϵ and δ sufficiently small, we conclude that

$$\|u\|_{\ell^2_N L^\infty_t H^s([0,T]\times\mathbb{R})} \le \delta, \quad \|u\|_{X^s([0,T]\times\mathbb{R})} \le \delta.$$

Since the norms are continuous with respect to T, it follows that a neighborhood of T is in A. Therefore A = [0, 1] and hence we prove Theorem 1.1.
