# On tight sets of hyperbolic quadrics

#### Abstract

We prove that the parameter $x$ of a tight set $\mathcal{T}$ of a hyperbolic quadric $\mathrm{Q}^{+}(2 n+1, q)$ of an odd rank $n+1$ satisfies $\binom{x}{2}+w(w-x) \equiv 0 \bmod q+1$, where $w$ is the number of points of $\mathcal{T}$ in any generator of $\mathrm{Q}^{+}(2 n+1, q)$. As this modular equation should have an integer solution in $w$ if such a $\mathcal{T}$ exists, this condition rules out roughly at least one half of all possible parameters $x$. It generalizes a previous result by the author and K . Metsch shown for tight sets of a hyperbolic quadric $\mathrm{Q}^{+}(5, q)$ (also known as Cameron-Liebler line classes in $\mathrm{PG}(3, q)$ ).


## 1 Introduction

Let $\operatorname{PG}(n, q)$ denote the projective space of dimension $n$ with underlying vector space $V:=\mathbb{F}_{q}^{n+1}$ over the finite field $\mathbb{F}_{q}$ with $q$ elements. For a non-degenerate quadratic (or reflexive sesquilinear) form $f$ on $V$, the classical polar space P associated with $f$ is the incidence structure formed by the totally singular (or totally isotropic, respectively) subspaces of $f$ and their incidence is defined by symmetrized containment [6]. We consider the elements of P as subspaces of $\mathrm{PG}(n, q)$, so they are projective points, lines, $\ldots$. A maximal subspace of P has dimension $r-1$, where $r$ is the Witt index of $f$, also called the rank of P , and such a subspace is called a generator.

We will consider the polar space $\mathrm{Q}^{+}(2 n+1, q)$ of rank $n+1$ defined by a hyperbolic quadric $f$, i.e., the set of projective points of $\operatorname{PG}(2 n+1, q)$ satisfying $f(\mathbf{x})=0$, where

$$
f(\mathbf{x}):=f\left(x_{0}, \ldots, x_{2 n+1}\right)=x_{0} x_{1}+\cdots+x_{2 n} x_{2 n+1}, \mathbf{x} \in V
$$

The associated bilinear form $b(\mathbf{x}, \mathbf{y}):=f(\mathbf{x}+\mathbf{y})-f(\mathbf{x})-f(\mathbf{y})$ defines the polarity $\perp$ of $\operatorname{PG}(2 n+1, q)$. Two points of the polar space are collinear if and only if $b(\mathbf{x}, \mathbf{y})=0$. For a point $P$ of the quadric, denote by $P^{\perp}$ the set of points collinear with $P$, which form the (tangent) hyperplane of $P$. Note that $P \in P^{\perp}$, and, for a point set (or a subspace) $S$, let $S^{\perp}$ denote $\cap_{P \in S} P^{\perp}$.

The notion of tight sets was introduced by Payne [22] for generalized quadrangles (which include the classical polar spaces of rank 2), and it was extended to polar spaces of higher rank by Drudge [13]. Tight sets are extremal sets of points in the following sense. It was shown [13, Theorem 8.1] that, for a set $\mathcal{T}$ of points of a finite polar space P of rank $r$ over $\mathbb{F}_{q}$, the average number $\kappa$ of points of $\mathcal{T}$ collinear to a given point of $\mathcal{T}$ is bounded above by

$$
\begin{equation*}
\kappa \leq|\mathcal{T}| \frac{q^{r-1}-1}{q^{r}-1}+q^{r-1}, \tag{1.1}
\end{equation*}
$$

[^0]and if equality attains, then $\mathcal{T}$ is said to be tight. Moreover, in this case $|\mathcal{T}|=x \frac{q^{r}-1}{q-1}$ holds for some non-negative integer $x$, which is called the parameter of the tight set $\mathcal{T}$. The complement of an $x$-tight set is a $\left(q^{r-1}+1-x\right)$-tight set, so that we may assume $x \leq \frac{q^{r-1}+1}{2}$.

The question is to determine for which parameters $x$ an $x$-tight set exists, and to classify the examples admitting a given parameter $x$. The answer fundamentally depends on the type and the rank of P , see $[2,3,12,20,21]$ for some recent results. Besides that, geometric properties and characterizations of tight sets are of interest, as they nicely interact with related structures of polar spaces such as m-ovoids. This fact can be explained from the point of view of algebraic graph theory [2], regardless of the type of a polar space.

Note that a disjoint union of $x$ generators of P , which are the only tight sets with parameter 1 [13, Theorem 9.1], is itself a tight set with parameter $x$. As for the hyperbolic polar spaces $\mathrm{Q}^{+}(2 n+1, q)$, their tight sets in the partial case $n=2$ appeared in a different context in a paper by Cameron and Liebler [5] as classes of lines in $\operatorname{PG}(3, q)$ satisfying certain geometric conditions. While their equivalence was observed by Drudge [13] via the Klein-correspondence, they have been studied for almost three decades under the name of Cameron-Liebler line classes [23].

Further, Drudge [13, Corollary 9.1] proved that, for $q \geq 4$, any $x$-tight set of $\mathrm{Q}^{+}(2 n+1, q)$ with $x \leq \sqrt{q}$ is the disjoint union of $x$ generators (hence, none such exist if $x>2$ and the rank $n+1$ is odd). This bound was improved several times $[2,11]$ and finally Beukemann and Metsch [4] proved that the same conclusion holds if $1 \leq n \leq 3$ and $x \leq q$, or if $n \geq 4, q \geq 71$ and $x \leq q-1$.

A much stronger bound is shown [19] for the hyperbolic polar space $\mathrm{Q}^{+}(5, q)$ of rank 3 : the parameter $x$ of a tight set that is not a disjoint union of generators should satisfy $x \geq c q^{4 / 3}$ with some constant $c$. Moreover, the following result was obtained in [16].

Result 1.1. Let $\mathcal{T}$ be a tight set with parameter $x$ of $\mathrm{Q}^{+}(5, q)$. Then, for every generator $G$ of $\mathrm{Q}^{+}(5, q)$, the number $w:=|G \cap \mathcal{T}|$ satisfies

$$
\begin{equation*}
\binom{x}{2}+w(w-x) \equiv 0 \quad \bmod q+1 \tag{1.2}
\end{equation*}
$$

Thus, if $\mathrm{Q}^{+}(5, q)$ has a tight set with parameter $x$, then Eq. (1.2) has a solution in $w$ from the set $\{0,1, \ldots, q\}$. It was shown in [16] that it implies a strong non-existence result for tight sets of $\mathrm{Q}^{+}(5, q)$, as, for any given $q$, it rules out roughly at least half of the possible parameters $x$ from the set $\left\{3, \ldots, \frac{q^{2}+1}{2}\right\}$.

The main result of the present paper generalizes Result 1.1 to the hyperbolic polar space $\mathrm{Q}^{+}(2 n+$ $1, q)$ of an arbitrary rank $n+1$ as follows.

Theorem 1.2. Let $\mathcal{T}$ be a tight set with parameter $x$ of $\mathrm{Q}^{+}(2 n+1, q)$. Then, for every generator $G$ of $\mathrm{Q}^{+}(2 n+1, q)$, the number $w:=|G \cap \mathcal{T}|$ satisfies

$$
\begin{equation*}
\binom{x}{2}+w(w-x) \equiv 0 \quad \bmod q+1 \tag{1.3}
\end{equation*}
$$

if $n$ is even, and

$$
\begin{equation*}
w(w-x) \equiv 0 \quad \bmod q+1 \tag{1.4}
\end{equation*}
$$

if $n$ is odd.
The argument from [16, Section 3] shows that Eq. (1.3) rules out roughly at least half of the possible parameters $x$ from the set $\left\{3, \ldots, \frac{q^{n}+1}{2}\right\}$. Unfortunately, if $n$ is odd, it seems that Eq.
(1.4) does not impose any restrictions on $x$, which is consistent with the existence of large sets of disjoint generators in $\mathrm{Q}^{+}(2 n+1, q)$ in this case.

The proof of Theorem 1.2 generalizes a technique developed in $[16,17]$. Suppose that $\mathcal{T}$ is a tight set with parameter $x$ of $\mathrm{Q}:=\mathrm{Q}^{+}(2 n+1, q)$. It follows [13, Theorem 8.1] that, for any point $P$ of Q , one has

$$
\begin{equation*}
\left|P^{\perp} \cap \mathcal{T}\right|=q^{n}|\{P\} \cap \mathcal{T}|+x \theta_{n-1} \tag{1.5}
\end{equation*}
$$

where, for an integer $k \geq-1$, we define $\theta_{k}:=\left(q^{k+1}-1\right) /(q-1)$. Observe that $\theta_{k}$ is the number of points in the $k$-dimensional projective space over $\mathbb{F}_{q}$, and $|\mathcal{T}|=x \theta_{n}$.

The following result [4, Lemma 2.1] generalizes Eq. (1.5) to the subspaces of $\operatorname{PG}(2 n+1, q)$, and it will play a crucial role in the proof.

Result 1.3. Every s-dimensional subspace $S, s \leq n$, of the ambient space $\mathrm{PG}(2 n+1, q)$ satisfies the equality

$$
\left|S^{\perp} \cap \mathcal{T}\right|=q^{n-s}|S \cap \mathcal{T}|+x \theta_{n-s-1}
$$

Drudge [13, Theorem 8.1(3)] proved a partial case of Result 1.3 when $S$ is a line not contained in Q (i.e., $S$ intersects Q in two non-collinear points). For a point $P_{0} \in \mathrm{Q} \backslash \mathcal{T}$, applying Result 1.3 in different settings, we count the number of pairs $\left(P_{1}, P_{2}\right)$ of collinear points $P_{1} \in P_{0}^{\perp} \cap \mathcal{T}$, $P_{2} \in\left(\mathrm{Q} \backslash P_{0}^{\perp}\right) \cap \mathcal{T}$ in two ways, which gives a certain equation. We then analyze this equation modulo $q+1$.

Note that via the field reduction [18] one can construct tight sets of $\mathrm{Q}^{+}(6 b-1, q)$ from a variety of those of $\mathrm{Q}^{+}\left(5, q^{b}\right)$ that have been discovered recently $[7,8,9,10,14,15]$. Thus, $\mathrm{Q}^{+}(7, q)$ and $\mathrm{Q}^{+}(9, q)$ seem to be the first unexplored cases, where we are not aware of any non-trivial tight sets.

## 2 The proof of Theorem 1.2

We first recall some well-known properties of a hyperbolic polar space [6].
Result 2.1. Let Q be a hyperbolic polar space $\mathrm{Q}^{+}(2 n+1, q)$ or rank $n+1$.
(a) For every pair $P_{1}, P_{2}$ of non-collinear points of $\mathrm{Q},\left\{P_{1}, P_{2}\right\}^{\perp}$ is a hyperbolic quadric $\mathrm{Q}^{+}(2 n-$ $1, q)$ of rank $n$.
(b) For every s-subspace $S \subset Q$, the quotient space $S^{\perp} / S$ is a hyperbolic quadric of rank $n-s$ (over the same field).
(c) The number of points of Q is $k_{n}:=\left(q^{n}+1\right) \theta_{n}$, of which $k_{2, n}:=q^{2 n}$ are not collinear to a given point.
(d) For every pair of distinct collinear points of Q , the number of points of Q that are collinear to only one of them equals $b_{n}:=q^{2 n-1}$.

Lemma 2.2. Let Q be a hyperbolic polar space $\mathrm{Q}^{+}(2 n-1, q)$ or rank $n$. For a point $P_{0}$ of Q , let $P$ and $P^{\prime}$ be two distinct points of $P_{0}^{\perp} \backslash\left\{P_{0}\right\}$, and $\ell:=\left\langle P, P^{\prime}\right\rangle$.
(a) If $\ell \subset Q$ with $P_{0} \in \ell$, then $P^{\perp} \cap P^{\perp} \subseteq P_{0}^{\perp}$.
(b) If $\ell \subset \mathrm{Q}$ with $P_{0} \notin \ell$, then $P^{\perp} \cap P^{\prime \perp}$ contains precisely $\lambda_{n}:=q^{2 n-4}$ points of $\mathrm{Q} \backslash P_{0}^{\perp}$.
(c) If $\ell \not \subset \mathrm{Q}$, then $P^{\perp} \cap P^{\prime \perp}$ contains precisely $\lambda_{n}$ points of $\mathrm{Q} \backslash P_{0}^{\perp}$.

Proof. Statement (a) is obvious. To prove (b), we observe that $\ell^{\perp} / \ell$ is a hyperbolic quadric of rank $n-2$, whose points are the planes on $\ell$, and therefore the number of points in $P^{\perp} \cap P^{\prime \perp}$ equals $\theta_{1}+k_{n-3}\left(\theta_{2}-\theta_{1}\right)$, of which $\theta_{2}$ points are contained in the plane $\left\langle P_{0}, \ell\right\rangle$ and $k_{n-4}\left(\theta_{3}-\theta_{2}\right)$ points correspond to $\left\langle P_{0}, \ell\right\rangle^{\perp} /\left\langle P_{0}, \ell\right\rangle$. Thus, the number of points in $\left(P^{\perp} \cap P^{\prime \perp}\right) \backslash P_{0}^{\perp}$ equals:

$$
\theta_{1}+k_{n-3}\left(\theta_{2}-\theta_{1}\right)-\theta_{2}-k_{n-4}\left(\theta_{3}-\theta_{2}\right)=q^{2 n-4}
$$

which shows (b). The proof of (c) is similar.
We will need the following technical lemma. For a point $P$ of a hyperbolic quadric, define $\mathrm{L}(P)$ to be the set of lines on the quadric through $P$.

Lemma 2.3. Let $Q$ be a hyperbolic quadric $Q^{+}(2 n-1, q)$ of rank $n$. Suppose that $\mu$ is an integervalued function defined on the set of points of Q such that, for a positive integer $x$, the following properties hold.
(*) For every point $P$ of Q :

$$
\sum_{P_{1} \in P^{\perp}} \mu\left(P_{1}\right)=x \theta_{n-2}+q^{n-1} \mu(P)
$$

(**) For every pair $P_{1}, P_{2}$ of non-collinear points of Q :

$$
\sum_{P^{\prime} \in\left\{P_{1}, P_{2}\right\}^{\perp}} \mu\left(P^{\prime}\right)=x \theta_{n-3}+q^{n-2}\left(\mu\left(P_{1}\right)+\mu\left(P_{2}\right)\right)
$$

Then, for an arbitrary point $P_{0}$ of Q , one has:

$$
\sum_{P \in \mathrm{Q}} \mu(P)^{2}=\mu\left(P_{0}\right)^{2}+\left(x-\mu\left(P_{0}\right)\right)^{2}+(q+1) \cdot \sum_{P_{1} \in P_{0}^{\perp} \backslash\left\{P_{0}\right\}} \mu\left(P_{1}\right)^{2}-\sum_{\ell \in \mathrm{L}\left(P_{0}\right)}\left(\sum_{P_{2} \in \ell \backslash\left\{P_{0}\right\}} \mu\left(P_{2}\right)\right)^{2}
$$

Proof. For a point $P_{0} \in \mathrm{Q}$, one can write:

$$
\begin{equation*}
\sum_{P \in Q} \mu(P)^{2}=\mu\left(P_{0}\right)^{2}+\sum_{P_{1} \in P_{0}^{\perp} \backslash\left\{P_{0}\right\}} \mu\left(P_{1}\right)^{2}+\sum_{P_{2} \in \mathbb{Q} \backslash P_{0}^{\perp}} \mu\left(P_{2}\right)^{2} \tag{2.1}
\end{equation*}
$$

For a point $P_{2} \in \mathrm{Q} \backslash P_{0}^{\perp}$, Property $(* *)$ implies that:

$$
\mu\left(P_{2}\right)=\frac{1}{q^{n-2}}\left(\sum_{P^{\prime} \in\left\{P_{0}, P_{2}\right\}^{\perp}} \mu\left(P^{\prime}\right)-q^{n-2} \mu\left(P_{0}\right)-x \theta_{n-3}\right),
$$

which allows to rewrite the last sum in Eq. (2.1) as follows:

$$
\begin{aligned}
\sum_{P_{2} \in Q \backslash P_{0}^{\perp}} \mu\left(P_{2}\right)^{2} & =\frac{1}{q^{2 n-4}} \sum_{P_{2} \in Q \backslash P_{0}^{\perp}}\left(\sum_{P^{\prime} \in\left\{P_{0}, P_{2}\right\}^{\perp}} \mu\left(P^{\prime}\right)-q^{n-2} \mu\left(P_{0}\right)-x \theta_{n-3}\right)^{2} \\
& =\frac{1}{q^{2 n-4}} \sum_{P_{2} \in Q \backslash P_{0}^{\perp}}\left(\left(\sum_{P^{\prime} \in\left\{P_{0}, P_{2}\right\}^{\perp}} \mu\left(P^{\prime}\right)\right)^{2}-2\left(\sum_{P^{\prime} \in\left\{P_{0}, P_{2}\right\}^{\perp}} \mu\left(P^{\prime}\right)\right)\left(q^{n-2} \mu\left(P_{0}\right)+x \theta_{n-3}\right)\right. \\
& \left.+\left(q^{n-2} \mu\left(P_{0}\right)+x \theta_{n-3}\right)^{2}\right) .
\end{aligned}
$$

Further, we observe that

$$
\begin{aligned}
\sum_{P_{2} \in Q \backslash P_{0}^{\perp}} \sum_{P^{\prime} \in\left\{P_{0}, P_{2}\right\}^{\perp}} \mu\left(P^{\prime}\right) & =b_{n-1} \cdot \sum_{P_{1} \in P_{0}^{\perp} \backslash\left\{P_{0}\right\}} \mu\left(P_{1}\right)[\text { holds by Result 2.1(d) }] \\
& =q^{2 n-3}\left(\left(q^{n-1}-1\right) \mu\left(P_{0}\right)+x \theta_{n-2}\right)[\text { holds by Property }(*)], \\
\text { and } \sum_{P_{2} \in Q \backslash P_{0}^{\perp}} 1 & =k_{2, n-1}[\text { holds by Result } 2.1(\mathrm{~b}),(\mathrm{c})] \\
& =q^{2 n-2} .
\end{aligned}
$$

Thus, we obtain:

$$
\begin{aligned}
\sum_{P_{2} \in Q \backslash P_{0}^{\perp}} \mu\left(P_{2}\right)^{2} & =\frac{1}{q^{2 n-4}} \sum_{P_{2} \in Q \backslash P_{0}^{\perp}}\left(\sum_{P^{\prime} \in\left\{P_{0}, P_{2}\right\}^{\perp}} \mu\left(P^{\prime}\right)\right)^{2}+q^{2}\left(q^{n-2} \mu\left(P_{0}\right)+x \theta_{n-3}\right)^{2} \\
& -2 q\left(q^{n-2} \mu\left(P_{0}\right)+x \theta_{n-3}\right)\left(\left(q^{n-1}-1\right) \mu\left(P_{0}\right)+x \theta_{n-2}\right),
\end{aligned}
$$

where we shall evaluate the first double sum by using Lemma 2.2. Indeed, for any pair $P, P^{\prime}$ of points of $P_{0}^{\perp} \backslash\left\{P_{0}\right\}$ such that $P_{0} \notin\left\langle P, P^{\prime}\right\rangle$, there are precisely $\lambda_{n}$ points $P_{2} \in \mathrm{Q} \backslash P_{0}^{\perp}$ with $P, P^{\prime} \in\left\{P_{0}, P_{2}\right\}^{\perp}$. Thus, it follows that

$$
\sum_{P_{2} \in Q \backslash P_{0}^{\perp}}\left(\sum_{P^{\prime} \in\left\{P_{0}, P_{2}\right\}^{\perp}} \mu\left(P^{\prime}\right)\right)^{2}=b_{n-1} \cdot \sum_{P_{1} \in P_{0}^{\perp} \backslash\left\{P_{0}\right\}} \mu\left(P_{1}\right)^{2}+\lambda_{n} \cdot \sum_{\ell \in \mathrm{L}\left(P_{0}\right)} \sum_{P \in \ell \backslash\left\{P_{0}\right\}} \mu(P) \sum_{P^{\prime} \in P_{0}^{\perp} \backslash \ell} \mu\left(P^{\prime}\right),
$$

where the last triple sum can be rewritten as follows:

$$
\begin{aligned}
\sum_{\ell \in \mathrm{L}\left(P_{0}\right)} \sum_{P \in \ell \backslash\left\{P_{0}\right\}} \mu(P) \sum_{P^{\prime} \in P_{0}^{\perp} \backslash \ell} \mu\left(P^{\prime}\right) & =\sum_{\ell \in \mathrm{L}\left(P_{0}\right)} \sum_{P \in \ell \backslash\left\{P_{0}\right\}} \mu(P)\left(\sum_{P^{\prime} \in P_{0}^{\perp} \backslash\left\{P_{0}\right\}} \mu\left(P^{\prime}\right)-\sum_{P^{\prime \prime} \in \ell \backslash\left\{P_{0}\right\}} \mu\left(P^{\prime \prime}\right)\right) \\
& {\left[\text { by } \sum_{\ell \in \mathrm{L}\left(P_{0}\right)} \sum_{P \in \ell \backslash\left\{P_{0}\right\}} \mu(P)=\sum_{P_{1} \in P_{0}^{\perp} \backslash\left\{P_{0}\right\}} \mu\left(P_{1}\right)\right] } \\
& =\left(\sum_{P_{1} \in P_{0}^{\perp} \backslash\left\{P_{0}\right\}} \mu\left(P_{1}\right)\right)^{2}-\sum_{\ell \in \mathrm{L}\left(P_{0}\right)}\left(\sum_{P \in \ell \backslash\left\{P_{0}\right\}} \mu(P)\right)^{2} \\
& =\left(\left(q^{n-1}-1\right) \mu\left(P_{0}\right)+x \theta_{n-2}\right)^{2}-\sum_{\ell \in \mathrm{L}\left(P_{0}\right)}\left(\sum_{P \in \ell \backslash\left\{P_{0}\right\}} \mu(P)\right)^{2} .
\end{aligned}
$$

Putting it all together and simplifying, we obtain:

$$
\begin{aligned}
\sum_{P \in \mathrm{Q}} \mu(P)^{2} & =\mu\left(P_{0}\right)^{2}+\sum_{P_{1} \in P_{0}^{\perp} \backslash\left\{P_{0}\right\}} \mu\left(P_{1}\right)^{2}+\sum_{P_{2} \in \mathrm{Q} \backslash P_{0}^{\perp}} \mu\left(P_{2}\right)^{2} \\
& =\mu\left(P_{0}\right)^{2}+(q+1) \cdot \sum_{P_{1} \in P_{0}^{\perp} \backslash\left\{P_{0}\right\}} \mu\left(P_{1}\right)^{2}-\sum_{\ell \in \mathrm{L}\left(P_{0}\right)}\left(\sum_{P \in \ell \backslash\left\{P_{0}\right\}} \mu(P)\right)^{2} \\
& +\left(\left(q^{n-1}-1\right) \mu\left(P_{0}\right)+x \theta_{n-2}\right)^{2}+q^{2}\left(q^{n-2} \mu\left(P_{0}\right)+x \theta_{n-3}\right)^{2} \\
& -2 q\left(\left(q^{n-1}-1\right) \mu\left(P_{0}\right)+x \theta_{n-2}\right)\left(q^{n-2} \mu\left(P_{0}\right)+x \theta_{n-3}\right) \\
& =\mu\left(P_{0}\right)^{2}+\left(x-\mu\left(P_{0}\right)\right)^{2}+(q+1) \sum_{P_{1} \in P_{0}^{\perp} \backslash\left\{P_{0}\right\}} \mu\left(P_{1}\right)^{2}-\sum_{l \in \mathrm{~L}\left(P_{0}\right)}\left(\sum_{P \in \ell \backslash\left\{P_{0}\right\}} \mu(P)\right)^{2},
\end{aligned}
$$

and the lemma follows.

One can see that a function $\mu$ satisfying the condition of Lemma 2.3 generalizes the notion of tight sets. The proof of the following lemma justifies this by showing that $\mu$ is a weighted tight set [1] and, moreover, given such a function $\mu$ one can construct a weighted set for hyperbolic quadrics of smaller rank.

Lemma 2.4. Let Q be a hyperbolic quadric $\mathrm{Q}^{+}(2 n-1, q)$ of rank $n$. Suppose that $\mu$ is an integervalued function defined on the set of points of Q such that, for a positive integer $x$, $\mu$ satisfies Property (*) of Lemma 2.3. Then the following holds.
(1) $\mu$ satisfies Property (**) of Lemma 2.3.
(2) For a point $P_{0} \in Q$, a function $\widetilde{\mu}$ on the points of the hyperbolic quadric $P_{0}^{\perp} / P_{0}$ defined by:

$$
\widetilde{\mu}(\ell)=\sum_{P \in \ell \backslash\left\{P_{0}\right\}} \mu(P), \quad\left(\ell \in \mathrm{L}\left(P_{0}\right)\right),
$$

satisfies Property (*) with $\widetilde{x}=(q-1) \mu\left(P_{0}\right)+x$.
Proof. First observe that by Property (*) and Result 2.1(b),(c), we have

$$
\begin{aligned}
\sum_{P \in \mathrm{Q}} \mu(P) & =\frac{1}{q^{n-1}}\left(\sum_{P \in Q} \sum_{P_{1} \in P^{\perp}} \mu\left(P_{1}\right)\right)-k_{n-1} \frac{x \theta_{n-2}}{q^{n-1}} \\
& =\frac{1+q k_{n-2}}{q^{n-1}}\left(\sum_{P \in Q} \mu(P)\right)-k_{n-1} \frac{x \theta_{n-2}}{q^{n-1}}
\end{aligned}
$$

which implies that $M:=\sum_{P \in \mathrm{Q}} \mu(P)=x \theta_{n-1}$.
(1) Recall that the collinearity graph of $Q$, in which two distinct points are adjacent whenever they are collinear, is strongly regular. Therefore its symmetric $(0,1)$-adjacency matrix is diagonalizable with three distinct eigenvalues, namely, $\sigma_{0}=q k_{n-2}$ with multiplicify one (and the all-one eigenvector), $\sigma_{1}=q^{n-1}-1$ and $\sigma_{2}=-\left(q^{n-2}+1\right)$, see [13, Lemma 8.3].

It now follows from Property $(*)$ that a vector $\mathbf{v} \in \mathbb{R}^{Q}$ defined by $\mathbf{v}(P)=\mu(P)+\frac{x \theta_{n-2}}{q^{n-1}-1-q k_{n-2}}$ is an eigenvector for $\sigma_{1}$, as it satisfies

$$
\mathbf{v}(P)=\left(q^{n-1}-1\right) \cdot \sum_{P_{1} \in P^{\perp} \backslash\{P\}} \mathbf{v}\left(P_{1}\right) \text { for any } P \in \mathbf{Q}
$$

Given two non-collinear points $P, P^{\prime}$ of Q , it follows from the proof of $[13$, Theorem $8.1(3)]$ that

$$
\mathbf{w}_{P, P^{\prime}}=\mathbf{e}_{\left\{P, P^{\prime}\right\}^{\perp}}-\frac{\theta_{n-3}}{\theta_{n-1}} \mathbf{e}_{Q}-q^{n-2}\left(\mathbf{e}_{\{P\}}+\mathbf{e}_{\left\{P^{\prime}\right\}}\right),
$$

where $\mathbf{e}_{X} \in \mathbb{R}^{\mathrm{Q}}$ denotes the characteristic vector of a point set $X$, is an eigenvector for $\sigma_{2}$.
Since the eigenspaces associated to $\sigma_{1}$ and $\sigma_{2}$ are orthogonal, it follows that $\mathbf{v}$ is perpendicular with $\mathbf{w}_{P, P^{\prime}}$. Evaluating $\left\langle\mathbf{v}, \mathbf{w}_{P, P^{\prime}}\right\rangle=0$ and simplifying, we find that Property ( $* *$ ) follows.
(2) We follow the proof of [4, Lemma 2.1]. Fix a line $\ell_{0} \in \mathrm{~L}\left(P_{0}\right)$. If we consider the subspaces $P^{\perp}$ for the $q+1$ points $P$ of $\ell_{0}$, then the points of $\ell_{0}^{\perp}$ lie in each such subspace $P^{\perp}$, whereas every
point outside $\ell_{0}^{\perp}$ lies in exactly one of these. By double counting, we find:

$$
\begin{aligned}
q\left(\sum_{P \in \ell_{0}^{\perp}} \mu(P)\right)+M & =\sum_{P_{1} \in \ell_{0}} \sum_{P_{2} \in P_{1}^{\perp}} \mu\left(P_{2}\right) \\
& =\sum_{P_{1} \in \ell_{0}}\left(q^{n-1} \mu\left(P_{1}\right)+x \theta_{n-2}\right) \\
& =q^{n-1} \widetilde{\mu}\left(\ell_{0}\right)+q^{n-1} \mu\left(P_{0}\right)+(q+1) x \theta_{n-2},
\end{aligned}
$$

where on the left-hand side we have:

$$
\sum_{P \in \ell_{0}^{\perp}} \mu(P)=\mu\left(P_{0}\right)+\widetilde{\mu}\left(\ell_{0}\right)+\sum_{\ell_{1} \in\left(L\left(P_{0}\right) \backslash\left\{\ell_{0}\right\}\right) \cap \ell_{0}^{\perp}} \widetilde{\mu}\left(\ell_{1}\right),
$$

and simplifying gives the desired property $(*)$ for $\widetilde{\mu}$.
For the rest of the proof, we assume that $\mathcal{T}$ is a tight set with parameter $x$ of a hyperbolic quadric $\mathrm{Q}=\mathrm{Q}^{+}(2 n+1, q)$ of rank $n+1$. Fix a point $P_{0} \in \mathrm{Q} \backslash \mathcal{T}$ and, for every line $\ell$ of $\mathrm{L}\left(P_{0}\right)$, put $m_{\ell}:=|\ell \cap \mathcal{T}|$.

Lemma 2.5. The following holds:

$$
\begin{equation*}
\sum_{\ell \in \mathrm{L}\left(P_{0}\right)} m_{\ell}^{2}=x\left(\theta_{n-1}-1+x\right) . \tag{2.2}
\end{equation*}
$$

Proof. We prove the result by double counting the number $E$ of pairs ( $P_{1}, P_{2}$ ) where $P_{1} \in P_{0}^{\perp} \cap \mathcal{T}$, $P_{2} \in \mathcal{T} \backslash P_{0}^{\perp}$ and $P_{1} \in P_{2}^{\perp}$.

Observe that, by Eq. (1.5), there are precisely $\left|\mathcal{T} \backslash P_{0}^{\perp}\right|=|\mathcal{T}|-\left|P_{0}^{\perp} \cap \mathcal{T}\right|=x q^{n}$ points $P_{2}$ of $\mathcal{T}$ that are not collinear to $P_{0}$. By Result 1.3 applied to a line $\left\langle P_{0}, P_{2}\right\rangle \not \subset \mathrm{Q}, P_{2} \in \mathcal{T}$, each of them is collinear to

$$
\left|\left\langle P_{0}, P_{2}\right\rangle^{\perp} \cap \mathcal{T}\right|=q^{n-1}\left|\left\langle P_{0}, P_{2}\right\rangle \cap \mathcal{T}\right|+x \theta_{n-2}=q^{n-1}+x \theta_{n-2}
$$

points $P_{1} \in P_{0}^{\perp} \cap \mathcal{T}$, as $\left\langle P_{0}, P_{2}\right\rangle \cap \mathcal{T}=\left\{P_{2}\right\}$. Thus, $E$ equals $x q^{n}\left(q^{n-1}+x \theta_{n-2}\right)$.
On the other hand, for a point $P_{1} \in P_{0}^{\perp} \cap \mathcal{T}$, the number of points $P_{2} \in \mathcal{T} \backslash P_{0}^{\perp}$ that are collinear to $P_{1}$ equals

$$
\left|\left(P_{1}^{\perp} \backslash P_{0}^{\perp}\right) \cap \mathcal{T}\right|=\left|P_{1}^{\perp} \cap \mathcal{T}\right|-\left|\left\langle P_{0}, P_{1}\right\rangle^{\perp} \cap \mathcal{T}\right|=q^{n}+q^{n-1}\left(x-m_{\ell}\right)
$$

where we apply Result 1.3 to the line $\ell:=\left\langle P_{0}, P_{1}\right\rangle$, and observe that this number does not depend on the particular choice of a point $P_{1}$ of $\ell \cap \mathcal{T}$. Therefore, $E$ equals

$$
\sum_{\ell \in \mathbf{L}\left(P_{0}\right)} m_{\ell}\left(q^{n}+q^{n-1}\left(x-m_{\ell}\right)\right),
$$

and note that by Eq. (1.5) and $P_{0} \notin \mathcal{T}$, we have:

$$
\begin{aligned}
\left|P_{0}^{\perp} \cap \mathcal{T}\right| & =\sum_{\ell \in \mathrm{L}\left(P_{0}\right)} m_{\ell} \\
& =x \theta_{n-1} .
\end{aligned}
$$

Thus, we obtain that

$$
\sum_{\ell \in\left\llcorner\left(P_{0}\right)\right.} m_{\ell}\left(q^{n}+q^{n-1}\left(x-m_{\ell}\right)\right)=x q^{n}\left(q^{n-1}+x \theta_{n-2}\right),
$$

which simplifies to

$$
\sum_{\ell \in \mathrm{L}\left(P_{0}\right)} m_{\ell}^{2}=x\left(\theta_{n-1}-1+x\right),
$$

and the lemma follows.
In the following lemma, using Lemma 2.3, we obtain another result for the left-hand side of Eq. (2.2). Let $c \in\{0,1\}$ be defined such that $n \equiv c(\bmod 2)$.

Lemma 2.6. For any generator $G$ of $Q$ on $P_{0}$ with $w:=|G \cap \mathcal{T}|$, the following equality holds:

$$
\sum_{\ell \in \mathrm{L}\left(P_{0}\right)} m_{\ell}^{2} \equiv x\left(\theta_{n-1}-c\right)+(-1)^{c} \cdot 2 w(x-w)+c x^{2} \quad \bmod 2(q+1)
$$

Proof. Recall that $P_{0}^{\perp} / P_{0}$ is a hyperbolic quadric of rank $n$, whose points are the lines of $\mathrm{L}\left(P_{0}\right)$. Let $\mu$ be a function defined on $\mathrm{L}\left(P_{0}\right)$ such that $\mu$ satisfies the condition of Lemma 2.3. By Lemma 2.3, for an arbitrary line $\ell_{0} \in \mathrm{~L}\left(P_{0}\right)$ and the set $\mathrm{P}\left(\ell_{0}\right)$ of planes of Q on the line $\ell_{0}$, we obtain that

$$
\sum_{\ell \in \mathrm{L}\left(P_{0}\right)} \mu(\ell)^{2}=\mu\left(\ell_{0}\right)^{2}+\left(x-\mu\left(\ell_{0}\right)\right)^{2}+(q+1) \sum_{\ell_{1} \in \mathrm{~L}\left(P_{0}\right) \cap\left(\ell_{0}^{\perp} \backslash\left\{\ell_{0}\right\}\right)} \mu\left(\ell_{1}\right)^{2}-\sum_{\pi \in \mathrm{P}\left(\ell_{0}\right)}\left(\sum_{\ell^{\prime} \in \mathrm{L}\left(P_{0}\right) \cap\left(\pi \backslash\left\{\ell_{0}\right\}\right)} \mu\left(\ell^{\prime}\right)\right)^{2},
$$

which is congruent modulo $2(q+1)$ to

$$
\begin{equation*}
\mu\left(\ell_{0}\right)^{2}+\left(x-\mu\left(\ell_{0}\right)\right)^{2}+(q+1)\left(\left(q^{n-1}-1\right) \mu\left(\ell_{0}\right)+x \theta_{n-2}\right)-\sum_{\pi \in \mathrm{P}\left(\ell_{0}\right)}\left(\sum_{\ell^{\prime} \in \mathrm{L}\left(P_{0}\right) \cap\left(\pi \backslash\left\{\ell_{0}\right\}\right)} \mu\left(\ell^{\prime}\right)\right)^{2}, \tag{2.3}
\end{equation*}
$$

as modulo 2 we have $m^{2} \equiv m$ for every integer $m$ and $\sum_{\ell_{1} \in \mathrm{~L}\left(P_{0}\right) \cap\left(\ell_{0}^{\perp} \backslash\left\{\ell_{0}\right\}\right)} \mu\left(\ell_{1}\right)=\left(q^{n-1}-1\right) \mu\left(\ell_{0}\right)+$ $x \theta_{n-2}$ by Property (*).

Further, consider a hyperbolic quadric $\ell_{0}^{\perp} / \ell_{0}$, which has rank $n-1$ and whose points are the planes of $\mathrm{P}\left(\ell_{0}\right)$, and, as in Lemma 2.4(2), define a function $\widetilde{\mu}$ by

$$
\widetilde{\mu}(\pi):=\sum_{\ell^{\prime} \in \mathrm{L}\left(P_{0}\right) \cap\left(\pi \backslash\left\{\ell_{0}\right\}\right)} \mu\left(\ell^{\prime}\right)
$$

on the set $\mathrm{P}\left(\ell_{0}\right)$. By Lemma 2.4, $\widetilde{\mu}$ satisfies the condition of Lemma 2.3 for the hyperbolic quadric $\ell_{0}^{\perp} / \ell_{0}$, and therefore the last double sum in Eq. (2.3) can be evaluated by induction on $n$.

We now define $\mu$ by $\mu(\ell):=m_{\ell}$ for a line $\ell \in \mathrm{L}\left(P_{0}\right)$. By Result 1.3, $\mu$ satisfies the condition of Lemma 2.3. For $n+1=3$, it follows from the proof of [16, Theorem 3.1] that

$$
\sum_{\ell \in \mathrm{L}\left(P_{0}\right)} \mu(\ell)^{2} \equiv x(q+1)+2 w(x-w) \quad \bmod 2(q+1)
$$

where $w=\sum_{\ell \in \mathrm{L}\left(P_{0}\right) \cap \pi} \mu(\ell)$, i.e., the number of points of $\mathcal{T}$ in any plane $\pi$ on $P_{0}$.

Therefore, for $n+1=4$, from Eq. (2.3) we obtain that

$$
\begin{aligned}
\sum_{\ell \in \mathrm{L}\left(P_{0}\right)} m_{\ell}^{2} & \equiv m_{\ell_{0}}^{2}+\left(x-m_{\ell_{0}}\right)^{2}+(q+1)\left(\left(q^{2}-1\right) m_{\ell_{0}}+x \theta_{1}\right)-\sum_{\pi \in \mathrm{P}\left(\ell_{0}\right)} \widetilde{\mu}(\pi)^{2} \\
& \equiv m_{\ell_{0}}^{2}+\left(x-m_{\ell_{0}}\right)^{2}+(q+1)\left(\left(q^{2}-1\right) m_{\ell_{0}}+x \theta_{1}\right)-(\widetilde{x}(q+1)+2 \widetilde{w}(\widetilde{x}-\widetilde{w})) \quad \bmod 2(q+1)
\end{aligned}
$$

where $\widetilde{w}:=\sum_{\pi \in \mathrm{P}\left(\ell_{0}\right) \cap G} \widetilde{\mu}(\pi)=\left|\left(G \backslash\left\{\ell_{0}\right\}\right) \cap \mathcal{T}\right|$ so that $w=\widetilde{w}+m_{\ell_{0}}$ for any 3-dimensional space $G$ of Q on $\ell_{0}$, and this simplifies to

$$
\sum_{\ell \in \mathrm{L}\left(P_{0}\right)} m_{\ell}^{2} \equiv x\left(q^{2}+q+x\right)-2 w(x-w) \quad \bmod 2(q+1)
$$

Arguing in the same manner for $n+1>4$ by induction, a routine (but tedious) check shows that

$$
\sum_{\ell \in \mathrm{L}\left(P_{0}\right)} m_{\ell}^{2} \equiv x\left(\theta_{n-1}-1+x\right)-2 w(x-w) \quad \bmod 2(q+1)
$$

if $n$ is odd, and

$$
\sum_{\ell \in \mathrm{L}\left(P_{0}\right)} m_{\ell}^{2} \equiv x \theta_{n-1}+2 w(x-w) \quad \bmod 2(q+1)
$$

if $n$ is even, which shows the lemma.
We are now in a position to prove our main result. By Lemmas 2.5 and 2.6, we obtain that, if $n$ is odd then

$$
\begin{aligned}
\sum_{\ell \in \mathrm{L}\left(P_{0}\right)} m_{\ell}^{2} & \equiv x\left(\theta_{n-1}-1+x\right) \\
& \equiv x\left(\theta_{n-1}-1+x\right)-2 w(x-w) \bmod 2(q+1)
\end{aligned}
$$

i.e.,

$$
w(w-x) \equiv 0 \quad \bmod (q+1)
$$

and if $n$ is even then

$$
\begin{aligned}
\sum_{\ell \in \mathrm{L}\left(P_{0}\right)} m_{\ell}^{2} & \equiv x\left(\theta_{n-1}-1+x\right) \\
& \equiv x \theta_{n-1}+2 w(x-w) \bmod 2(q+1)
\end{aligned}
$$

i.e.,

$$
\binom{x}{2}+w(w-x) \equiv 0 \quad \bmod (q+1)
$$

which completes the proof of Theorem 1.2.
