# REMARK ON THE BETTI NUMBERS FOR HAMILTONIAN CIRCLE ACTIONS

#### Abstract

In this paper, we establish a certain inequality in terms of Betti numbers of a closed Hamiltonian $S^{1}$ manifold with isolated fixed points.


## 1. Introduction

Let $(M, \omega)$ be a $2 n$-dimensional closed symplectic manifold admitting a Hamiltonian torus action with only isolated fixed points. It has been a long-standing open problem whether $M$ admits a Kähler metric or not. Historically, Delzant [De] proved that if $M$ admits a Hamiltonian $T^{n}$-action, where the fixed point set is automatically discrete, then $M$ admits a $T^{n}$-invariant Kähler metric. Restricting to an $S^{1}$-action case, several results on the existence of a Kähler metric were provided in some special cases. For instance, Karshon [Ka] proved that every closed symplectic four manifold admitting a Hamiltonian circle action admits a Kähler metric. (In fact, the $S^{1}$-action is induced from a toric action when the fixed points are isolated.) Also if $\operatorname{dim} M=6$ with $b_{2}(M)=1$, then it turned out that $M$ admits a Kähler metric, which was proved by Tolman [T1] and McDuff [McD]. Recently, the author have shown that any 6-dimensional monotone closed semifree Hamiltonian $S^{1}$-manifold admits a Kähler metric, see [Cho2, Cho3, Cho4].

As a counterpart, there were "candidates" of closed Hamiltonian $T$-manifolds (with isolated fixed points) which possibly fail to admit Kähler metrics. Tolman [T2] and Woodward [W] constructed a six-dimensional closed Hamiltonian $T^{2}$-manifold with only isolated fixed points and with no $T^{2}$-invariant Kähler metric. Surprisingly Goertsches-Kostantis-Zoller [GKZ] have recently shown that examples of Tolman and Woodward indeed admit Kähler metrics that are not $T^{2}$-invariant. Thus their result provides a positive evidence for the conjecture of the existence of Kähler metrics.

On the other hand, it seems reasonable to ask whether $(M, \omega)$ enjoys Kählerian properties, such as the hard Lefschetz property of the symplectic form $\omega$ or the unimodality of even Betti numbers. Recall that every closed Kähler manifold $(M, \omega, J)$ satisfies the hard Lefschetz property, that is,

$$
\begin{array}{rll}
{[\omega]^{n-k}: \quad H^{k}(M ; \mathbb{R})} & \rightarrow H^{2 n-k}(M ; \mathbb{R}) \\
\alpha & \mapsto \alpha \cup[\omega]^{n-k}
\end{array}
$$

is an isomorphism for every $k=0,1, \cdots, n$. This implies that

$$
[\omega]: H^{k}(M ; \mathbb{R}) \rightarrow H^{k+2}(M ; \mathbb{R})
$$

is injective for every $k$ with $0 \leq k<n$, and therefore the sequence of even (as well as odd) Betti numbers of $M$ is unimodal. In other words,

$$
b_{k} \leq b_{k+2}, \quad k=0,1, \cdots, n-1
$$

where $b_{i}$ denotes the $i$-th Betti number of $M$. In this paper we deal with the following conjecture.
Conjecture 1.1. [JHKLM] Let $(M, \omega)$ be a $2 n$-dimensional closed symplectic manifold equipped with a Hamiltonian $S^{1}$-action with only isolated fixed points. Then the sequence of even Betti numbers is unimodal, i.e.,

$$
b_{2 i} \leq b_{2 i+2} \quad \text { for every } 0 \leq i<\left\lfloor\frac{n}{2}\right\rfloor .
$$

It is worth mentioning that every odd Betti number of $M$ vanishes by Frankel's theorem which states that a moment map is a Morse function whose critical points are of even indices. (See [Aud, Theorem IV.2.3].) Therefore we only need to care about even Betti numbers of $M$.

In [CK1], the author and Kim proved Conjecture 1.1 when $\operatorname{dim} M=8$. The main goal of this article is to improve the result of [CK1] and prove the following inequality, which is automatically satisfied when Conjecture 1.1 is true.

Theorem 1.2. Let $(M, \omega)$ be a closed symplectic manifold admitting a Hamiltonian circle action with only isolated fixed points where $\operatorname{dim} M=8 n$ or $8 n+4$. Then

$$
b_{2}+\cdots+b_{2+4(n-1)} \leq b_{4}+\cdots+b_{4+4(n-1)}
$$

In particular when $\operatorname{dim} M=8$ or 12 , we have

$$
b_{2} \leq b_{4}
$$

## 2. Proof of the main theorem

The main technique for proving Theorem 1.2 is the ABBV-localization due to Atiyah-Bott and Berline-Vergne. Recall that for an $S^{1}$-manifold $M$, the equivariant cohomology is defined by $H_{S^{1}}^{*}(M):=H^{*}\left(M \times S^{1} E S^{1}\right)$ where $E S^{1}$ is a contractible space on which $S^{1}$ acts freely. Then $H_{S^{1}}^{*}(M)$ inherits an $H^{*}\left(B S^{1}\right)$-module structure induced from the projection

$$
\pi: M \times_{S^{1}} E S^{1} \rightarrow B S^{1}:=E S^{1} / S^{1}
$$

Note that $H^{*}\left(B S^{1} ; \mathbb{R}\right) \cong H^{*}\left(\mathbb{C} P^{\infty} ; \mathbb{R}\right)=\mathbb{R}[u]$. Moreover, for the inclusion map $i: M^{S^{1}} \hookrightarrow M$, we have an induced ring homomorphism

$$
i^{*}: H_{S^{1}}^{*}(M ; \mathbb{R}) \rightarrow H_{S^{1}}^{*}\left(M^{S^{1}} ; \mathbb{R}\right) \cong H^{*}\left(B S^{1} ; \mathbb{R}\right) \otimes H^{*}\left(M^{S^{1}} ; \mathbb{R}\right)
$$

When $M^{S^{1}}=\left\{p_{1}, \cdots, p_{m}\right\}$ is discrete, we may express as $H^{*}\left(B S^{1} ; \mathbb{R}\right) \otimes H^{*}\left(M^{S^{1}} ; \mathbb{R}\right) \cong \bigoplus_{i=1}^{m} H^{*}\left(B S^{1} ; \mathbb{R}\right)$ and so

$$
i^{*}(\alpha)=\left(f_{1}, \cdots, f_{m}\right), \quad f_{i} \in \mathbb{R}[u]
$$

for $\alpha \in H_{S^{1}}^{*}(M ; \mathbb{R})$. We denote by $\left.\alpha\right|_{p_{i}}:=f_{i}$ and call it the restriction of $\alpha$ to $p_{i}$. By the Kirwan's injectivity theorem [Ki], the map $i^{*}$ is injective and hence $H_{S^{1}}^{*}(M ; \mathbb{R})$ is a free $H^{*}\left(B S^{1} ; \mathbb{R}\right)$-module.

Theorem 2.1 (ABBV Localization theorem). [AB, BV] Let $M$ be a closed $S^{1}$-manifold with only isolated fixed points and $\alpha \in H_{S^{1}}^{*}(M ; \mathbb{R})$. Then we have

$$
\int_{M} \alpha=\sum_{p \in M^{S^{1}}} \frac{\left.\alpha\right|_{p}}{\left(\Pi_{i=1}^{n} w_{i}(p)\right) u^{n}}
$$

where $w_{1}(p), \cdots, w_{n}(p)$ denote the weights of the tangential $S^{1}$-representation at $p$.
To obtain Theorem 1.2, we will apply Theorem 2.1 to canonical classes which form a basis of $H_{S^{1}}^{*}(M ; \mathbb{R})$ as an $H^{*}\left(B S^{1} ; \mathbb{R}\right)$-module.

Theorem 2.2. [MT] Let $(M, \omega)$ be a $2 n$-dimensional closed Hamiltonian $S^{1}$-manifold with only isolated fixed points. For each fixed point $p \in M^{S^{1}}$ of index $2 k$, there exists a unique class $\alpha_{p} \in H_{S^{1}}^{2 k}(M ; \mathbb{Z})$ such that

- $\left.\alpha_{p}\right|_{q}=0$ for every $q(\neq p) \in M^{S^{1}}$ with either $H(q) \leq H(p)$ or $\operatorname{ind}(q) \leq 2 k$,
- $\left.\alpha_{p}\right|_{p}=\prod_{i=1}^{k} \lambda_{i} u$, where $\lambda_{1}, \cdots, \lambda_{k}$ are negative weights of the $S^{1}$-action at $p$.

Moreover, the set $\left\{\alpha_{p} \mid p \in M^{S^{1}}\right\}$ is a basis of $H_{S^{1}}^{*}(M ; \mathbb{R})$ as an $H^{*}\left(B S^{1} ; \mathbb{R}\right)$-module.
Now we are ready to prove Theorem 1.2.

Proof of Theorem 1.2. We first consider the case $\operatorname{dim} M=8 n$. Suppose that

$$
\begin{equation*}
b_{2}+\cdots+b_{2+4(n-1)}>b_{4}+\cdots+b_{4+4(n-1)} \tag{2.1}
\end{equation*}
$$

Since $H_{S^{1}}^{*}(M)$ is a free module over $H^{*}\left(B S^{1}\right)$, we have

$$
H_{S^{1}}^{4 n-2}(M) \cong u^{0} \otimes H^{4 n-2}(M) \oplus u^{1} \otimes H^{4 n-4}(M) \oplus \cdots \oplus u^{(2 n-1)} \otimes H^{0}(M)
$$

which implies that

- $\operatorname{dim}_{\mathbb{R}} H_{S^{1}}^{4 n-2}(M ; \mathbb{R}) \cong b_{0}+b_{2}+\cdots b_{4 n-2}$, and
- $\left\{\left.\alpha_{p} \cdot u^{2 n-1-\frac{1}{2} \operatorname{ind}(p)} \right\rvert\, p \in M^{S^{1}}, \operatorname{ind}(p) \leq 4 n-2\right\}$ is a basis of $H_{S^{1}}^{4 n-2}(M ; \mathbb{R})$ (as an $\mathbb{R}$-vector space) by Theorem 2.2.

Now, consider the following map

$$
\begin{aligned}
\Phi: H_{S^{1}}^{4 n-2}(M ; \mathbb{R}) & \rightarrow\left(\mathbb{R}^{b_{0}} \oplus \mathbb{R}^{b_{4}} \oplus \cdots \oplus \mathbb{R}^{b_{4(n-1)}}\right) \oplus\left(\mathbb{R}^{b_{4 n}} \oplus \cdots \oplus \mathbb{R}^{b_{8 n-4}}\right) \\
\alpha & \mapsto\left(\alpha_{0}, \cdots, \alpha_{4 n-4}, \alpha_{4 n}, \cdots, \alpha_{8 n-4}\right)
\end{aligned}
$$

with the identification

$$
\begin{equation*}
\mathbb{R}^{b_{4 i}}=\bigoplus_{\operatorname{ind}(p)=4 i} \mathbb{R} \cdot u^{2 n-1} \quad \text { and } \quad \alpha_{4 i}:=\left(\left.\alpha\right|_{p}\right)_{\operatorname{ind}(p)=4 i} \in \bigoplus_{\operatorname{ind}(p)=4 i} \mathbb{R} \cdot u^{2 n-1} \tag{2.2}
\end{equation*}
$$

for each $i=1, \cdots, n$. Since the dimension of the range of the map $\Phi$ satisfies

$$
\operatorname{dim} \operatorname{Im} \Phi \leq b_{0}+\cdots+b_{4 n-4}+\left(b_{4 n}+b_{4 n+4}+\cdots+b_{8 n-4}\right)<b_{0}+\cdots+b_{4 n-4}+\left(b_{4 n-2}+\cdots+b_{2}\right)
$$

by the Poincaré duality and our assumption (2.1), the map $\Phi$ has a non-trivial kernel. In other words, there exists an element $\alpha \in H_{S^{1}}^{4 n-2}(M ; \mathbb{R})$ such that

$$
\left.\alpha\right|_{p}=0
$$

for every fixed point $p \in M^{S^{1}}$ of index $0,4, \cdots, 8 n-4$.
Now fix a moment map $H$ for the $S^{1}$-action on $(M, \omega)$ such that $H$ attains the maximum value 0 . Denote by $p_{\max }$ the maximal fixed point and so ind $\left(p_{\max }\right)=8 n$. The equivariant extension $\left[\omega_{H}\right] \in H_{S^{1}}^{2}(M ; \mathbb{R})$ of $\omega$ with respect to the moment map $H$ satisfies

$$
\left.\left[\omega_{H}\right]\right|_{p}=-H(p) u \in \mathbb{R}[u]
$$

for every $p \in M^{S^{1}}$, see [Cho1, Proposition 2.6]. Since $H(p)<0$ for every $p \neq p_{\max }$ by the choice of $H$, we obtain

$$
\begin{equation*}
0=\int_{M} \alpha^{2} \cdot\left[\omega_{H}\right]=\sum_{p \in M^{S^{1}}} \frac{-\left.\alpha^{2}\right|_{p} \cdot H(p) u}{\left(\prod_{i=1}^{n} w_{i}(p)\right) u^{n}}=\sum_{\operatorname{ind}(p) \equiv 2(\bmod 4)} \frac{-\left.\alpha^{2}\right|_{p} \cdot H(p) u}{\left(\prod_{i=1}^{n} w_{i}(p)\right) u^{n}} \tag{2.3}
\end{equation*}
$$

by the ABBV localization theorem 2.1 and the fact $\left.\left[\omega_{H}\right]\right|_{p_{\max }}=-H\left(p_{\max }\right) u=0$. Moreover, there exists at least one fixed point $p \in M^{S^{1}}$ such that

$$
\left.\alpha\right|_{p} \neq 0 \quad \text { and } \quad \operatorname{ind}(p)<8 n
$$

because

- $\left.\alpha\right|_{p} \neq 0$ for some $p \in M^{S^{1}}$ by the Kirwan's injectivity theorem [Ki], and
- if $\left.\alpha\right|_{p}=0$ for every $p \in M^{S^{1}}$ with $p \neq p_{\max }$, then $\left.\alpha\right|_{p_{\max }} \neq 0$ and it violates the localization theorem 2.1

$$
0=\int_{M} \alpha=\frac{\left.\alpha\right|_{p_{\max }}}{\left(\prod_{i=1}^{n} w_{i}(p)\right) u^{n}} \neq 0
$$

Consequently, each summand of the rightmost equation of (2.3) has non-negative coefficient (of $\frac{1}{u}$ ) and at least one of those should be negative. Therefore it leads to a contradiction.

Now it remains to consider the case of $\operatorname{dim} M=8 n+4$. Under the same assumption (2.1), we similarly define

$$
\begin{aligned}
\Phi: H_{S^{1}}^{4 n}(M ; \mathbb{R}) & \rightarrow\left(\mathbb{R}^{b_{0}} \oplus \mathbb{R}^{b_{4}} \oplus \cdots \oplus \mathbb{R}^{b_{4 n}}\right) \oplus\left(\mathbb{R}^{b_{4 n+4}} \oplus \cdots \oplus \mathbb{R}^{b_{8 n}}\right) \\
\alpha & \mapsto\left(\alpha_{0}, \cdots, \alpha_{4 n}, \alpha_{4 n+4}, \cdots, \alpha_{8 n}\right)
\end{aligned}
$$

with the same identification as in (2.2). Note that $\operatorname{dim}_{\mathbb{R}} H_{S^{1}}^{4 n}(M ; \mathbb{R})=b_{0}+b_{2}+\cdots+b_{4 n-2}+b_{4 n}$ and

$$
\begin{aligned}
\operatorname{dim} \operatorname{Im} \Phi \leq b_{0}+\cdots+b_{4 n}+\left(b_{4 n+4}+\cdots+b_{8 n}\right) & =b_{0}+\cdots+b_{4 n}+\left(b_{4 n}+\cdots+b_{4}\right) \\
& <b_{0}+\cdots+b_{4 n}+\left(b_{4 n-2}+\cdots+b_{2}\right)=\operatorname{dim}_{\mathbb{R}} H_{S^{1}}^{4 n}(M ; \mathbb{R})
\end{aligned}
$$

by the assumption (2.1) and the Poincaré duality again. Thus $\Phi$ has a non-trivial kernel $\alpha \in H_{S^{1}}^{4 n}(M ; \mathbb{R})$. In a similar manner as the previous case, we obtain

$$
0=\int_{M} \alpha^{2} \cdot\left[\omega_{H}\right]=\sum_{\operatorname{ind}(p) \equiv 2(\bmod 4)} \frac{-\left.\alpha^{2}\right|_{p} \cdot H(p) u}{\left(\prod_{i=1}^{n+1} w_{i}(p)\right) u^{n+1}} \neq 0
$$

which leads to a contradiction. This completes the proof.
