# Critical site percolation in high dimension

#### Abstract

We use the lace expansion to prove an infra-red bound for site percolation on the hypercubic lattice in high dimension. This implies the triangle condition and allows us to derive several critical exponents that characterize mean-field behavior in high dimensions.

## 1 Introduction

### 1.1 Site percolation on the hypercubic lattice

We consider site percolation on the hypercubic lattice $\mathbb{Z}^{d}$, where sites are independently occupied with probability $p \in[0,1]$, and otherwise vacant. More formally, for $p \in[0,1]$, we consider the probability space $\left(\Omega, \mathcal{F}, \mathbb{P}_{p}\right)$, where $\Omega=\{0,1\}^{\mathbb{Z}^{d}}$, the $\sigma$-algebra $\mathcal{F}$ is generated by the cylinder sets, and $\mathbb{P}_{p}=\bigotimes_{x \in \mathbb{Z}^{d}} \operatorname{Ber}(p)$ is a product-Bernoulli measure. We call $\omega \in \Omega$ a configuration and say that a site $x \in \mathbb{Z}^{d}$ is occupied in $\omega$ if $\omega(x)=1$. If $\omega(x)=0$, we say that the site $x$ is vacant. For convenience, we identify $\omega$ with the set of occupied sites $\left\{x \in \mathbb{Z}^{d}: \omega(x)=1\right\}$.

Given a configuration $\omega$, we say that two points $x \neq y \in \mathbb{Z}^{d}$ are connected and write $x \longleftrightarrow y$ if there is an occupied path between $x$ and $y$-that is, there are points $x=v_{0}, \ldots, v_{k}=y$ in $\mathbb{Z}^{d}$ with $k \in \mathbb{N}_{0}:=\mathbb{N} \cup\{0\}$ such that $\left|v_{i}-v_{i-1}\right|=1$ (with $|y|=\sum_{i=1}^{d}\left|y_{i}\right|$ the 1-norm) for all $1 \leq i \leq k$, and $v_{i} \in \omega$ for $1 \leq i \leq k-1$ (i.e., all inner sites are occupied). Two neighbors are automatically connected (i.e., $\{x \longleftrightarrow y\}=\Omega$ for all $x, y$ with $|x-y|=1$ ). Many authors prefer a different definition of connectivity by requiring both endpoints to be occupied as well. These two notions are closely related and we explain our choice in Section 1.4 . Moreover, we adopt the convention that $\{x \longleftrightarrow x\}=\varnothing$, that is, $x$ is not connected to itself.

We define the cluster of $x$ to be $\mathscr{C}(x):=\{x\} \cup\{y \in \omega: x \longleftrightarrow y\}$. Note that apart from $x$ itself, points in $\mathscr{C}(x)$ need to be occupied. We also define the expected cluster size (or susceptibility) $\chi(p)=\mathbb{E}_{p}[|\mathscr{C}(\mathbf{0})|]$, where for a set $A \subseteq \mathbb{Z}^{d}$, we let $|A|$ denote the cardinality of $A$, and $\mathbf{0}$ the origin in $\mathbb{Z}^{d}$.

We define the two-point function $\tau_{p}: \mathbb{Z}^{d} \rightarrow[0,1]$ by

$$
\tau_{p}(x):=\mathbb{P}_{p}(\mathbf{0} \longleftrightarrow x)
$$

The percolation probability is defined as $\theta(p):=\mathbb{P}_{p}(\mathbf{0} \longleftrightarrow \infty)=\mathbb{P}_{p}(|\mathscr{C}(\mathbf{0})|=\infty)$. We note that $p \mapsto \theta(p)$ is increasing and define the critical point for $\theta$ as

$$
p_{c}=p_{c}\left(\mathbb{Z}^{d}\right)=\inf \{p>0: \theta(p)>0\} .
$$

Note that we can define a critical point $p_{c}(G)$ for any graph $G$. As we only concern ourselves with $\mathbb{Z}^{d}$, we write $p_{c}$ or $p_{c}(d)$ the refer to the critical point of $\mathbb{Z}^{d}$.

### 1.2 Main result

The triangle condition is a versatile criterion for several critical exponents to exist and to take on their mean-field value. In order to introduce this condition, we define the open triangle diagram as

$$
\triangle_{p}(x)=p^{2}\left(\tau_{p} * \tau_{p} * \tau_{p}\right)(x)
$$

and the triangle diagram as $\triangle_{p}=\sup _{x \in \mathbb{Z}^{d}} \triangle_{p}(x)$. In the above, the convolution ' $*$ ' is defined as $(f * g)(x)=\sum_{y \in \mathbb{Z}^{d}} f(y) g(x-y)$. We also set $f^{* j}=f^{*(j-1)} * f$ and $f^{* 1} \equiv f$. The triangle condition is the condition that $\triangle_{p_{c}}<\infty$. To state Theorem 1.1. we recall that the discrete Fourier transform of an absolutely summable function $f: \mathbb{Z}^{d} \rightarrow \mathbb{R}$ is defined as $\widehat{f}:(-\pi, \pi]^{d} \rightarrow \mathbb{C}$ with

$$
\widehat{f}(k)=\sum_{x \in \mathbb{Z}^{d}} \mathrm{e}^{\mathrm{i} k \cdot x} f(x)
$$

where $k \cdot x=\sum_{j=1}^{d} k_{j} x_{j}$ denotes the scalar product. Letting $D(x)=\frac{1}{2 d} \mathbb{1}_{\{|x|=1\}}$ for $x \in \mathbb{Z}^{d}$ be the step distribution of simple random walk, we can formulate our main theorem:

Theorem 1.1 (The triangle condition and the infra-red bound). There exist $d_{0} \geq 6$ and a constant $C=C\left(d_{0}\right)$ such that, for all $d>d_{0}$,

$$
\begin{equation*}
p\left|\widehat{\tau}_{p}(k)\right| \leq \frac{|\widehat{D}(k)|+C / d}{1-\widehat{D}(k)} \tag{1.1}
\end{equation*}
$$

for all $k \in(-\pi, \pi]^{d}$ uniformly in $p \in\left[0, p_{c}\right]$ (we interpret the right-hand side of (1.1) as $\infty$ for $k=0$ ). Additionally, $\triangle_{p} \leq C / d$ uniformly in $\left[0, p_{c}\right]$, and the triangle condition holds.

### 1.3 Consequences of the infra-red bound

The triangle condition is the classical criterion for mean-field behavior in percolation models. The triangle condition implies readily that $\theta\left(p_{c}\right)=0$ (since otherwise $\triangle_{p_{c}}$ could not be finite), a problem that is still open in smaller dimension (except $d=2$ ).

Moreover, the triangle condition implies that a number of critical exponents take on their mean-field values. Indeed, using results by Aizenman and Newman [1, Section 7.7], the triangle condition implies that the critical exponent $\gamma$ exists and takes its mean-field value 1 , that is

$$
\begin{equation*}
\frac{c}{p_{c}-p} \leq \chi(p) \leq \frac{C}{p_{c}-p} \tag{1.2}
\end{equation*}
$$

for $p<p_{c}$ and constants $0<c<C$. We write $\chi(p) \sim\left(p_{c}-p\right)^{-1}$ as $p \nearrow p_{c}$ for the behavior of $\chi$ as in (1.2). There are several other critical exponents that are predicted to exist. For example, $\theta(p) \sim\left(p-p_{c}\right)^{\beta}$ as $p \searrow p_{c}$, and $\mathbb{P}_{p_{c}}(|\mathscr{C}(\mathbf{0})| \geq n) \sim n^{-1 / \delta}$ as $n \rightarrow \infty$.

Barsky and Aizenman [3] show that under the triangle condition,

$$
\begin{equation*}
\delta=2 \quad \text { and } \quad \beta=1 \tag{1.3}
\end{equation*}
$$

Their results are stated for a class of percolation models including site percolation. Hence, Theorem 1.1 implies (1.3). However, "for simplicity of presentation", the presentation of the proofs is restricted to bond percolation models.

Moreover, as shown by Nguyen [2], Theorem 1.1]implies that $\Delta=2$, where $\Delta$ is the gap exponent.

### 1.4 Discussion of literature and results

Percolation theory is a fundamental part of contemporary probability theory and its foundations are generally attributed to a 1957 paper of Broadbent and Hammersley [8. Meanwhile, a number of textbooks appeared, and we refer to Grimmett 12 for a comprehensive treatment of the subject, as well as Bollobás and Riordan [6], Werner [28] and Beffara and Duminil-Copin [4] for extra emphasis on the exciting recent progress in two-dimensional percolation.

The investigation of percolation in high dimensions was started by the seminal 1990 paper of Hara and Slade [13], who applied the lace expansion to prove the triangle condition for bond percolation in high dimension. A number of modifications and extensions of the lace expansion method for bond percolation have appeared in the meantime. The expansion itself is presented in Slade's Saint Flour notes [27]. A detailed account of the full lace expansion proof for bond percolation (including convergence of the expansion and related results) is given in a recent textbook by the first author and van der Hofstad [18].

Despite the fantastic understanding of bond percolation in high dimensions, site percolation is not yet analyzed with this method, and the present paper aims to remedy this situation. Together with van der Hofstad and Last [19, we recently applied the lace expansion to the random connection model, which can be viewed as a continuum site percolation model. The aim of this paper is to give a rigorous exhibition of the lace expansion applied to one of the simplest site percolation lattice models. We have chosen to set up the proofs in a similar fashion to corresponding work for bond percolation, making it easier to oversee by readers who are familiar with that literature. Indeed, Sections 3 and 4 follow rather closely the well-established method in [7, 18, 20], which are all based on Hara and Slade's foundational work [13. Interestingly, there is a difference in the expansion itself, which has numerous repercussions in the diagrammatic bounds and also in the different form of the infrared bounds. We now explain these differences in more detail.

A key insight for the analysis of high-dimensional site percolation is the frequent occurrence of pivotal points, which are crucial for the setup of the lace expansion. Suppose two sites $x$ and $y$ are connected, then an intermediate vertex $u$ is pivotal for this connection if every occupied path from $x$ to $y$ passes through $u$. We then break up the original connection event in two parts: a connection between $x$ and $u$, and a second connection between $u$ and $y$. In high dimension, we expect the two connection events to behave rather independently, except for their joint dependence on the occupation status of $u$. This little thought demonstrates that it is highly convenient to define connectivity events as in Section 1.1 , and thus treat the occupation of the vertex $u$ independent of the two new connection events. A more conventional choice of connectivity, where two points can only be connected if they are both occupied, is obtained a posteriori via

$$
\begin{equation*}
\mathbb{P}_{p}(\{x \longleftrightarrow y\} \cap\{x, y \text { occupied }\})=p^{2} \tau_{p}(y-x), \quad x, y \in \mathbb{Z}^{d}, x \neq y \tag{1.4}
\end{equation*}
$$

Our definition of $\tau_{p}$ avoids divisions by $p$, not only in the triangle, but throughout Sections 2 and 3
Paying close attention to the right number of factors of $p$ is a guiding thread of the technical aspects of Sections 3 and 4 that sets site percolation apart from bond percolation. Like it is done in bond percolation, the diagrammatic events by which we bound the lace-expansion coefficients depend on quite a few more points than the pivotal points. In contrast, every pair of points among these that may coincide hides a case distinction, and a coincidence case leads to a new diagram, typically with a smaller number of factors of $p$ (see, e.g., (3.2)). We handle this, for example, by encoding such coincidences in $\tau_{p}^{\circ}$ and $\tau_{p}^{\bullet}$ (which are variations of $\tau_{p}$ respecting an extra factor of $p$ and/or interactions at $\mathbf{0}$ ), see Definition 3.3. In Section 4, the mismatching number of $p$ 's and $\tau_{p}$ 's in $\triangle_{p}$ needs to be resolved.

The differing diagrams in Section 3 due to coincidences already appear in the lace-expansion coefficients of small order. This manifests itself in the answer to a classical question for high-dimensional percolation; namely, to devise an expansion of the critical threshold $p_{c}(d)$ when $d \rightarrow \infty$. It is known in the physics literature that

$$
\begin{equation*}
p_{c}(d)=(2 d)^{-1}+\frac{5}{2}(2 d)^{-2}+\frac{31}{4}(2 d)^{-3}+\frac{75}{4}(2 d)^{-4}+\frac{11977}{48}(2 d)^{-5}+\frac{209183}{96}(2 d)^{-6}+\cdots . \tag{1.5}
\end{equation*}
$$

The first four terms are due to Gaunt, Ruskin and Sykes [11], the latter two were found recently by Mertens and Moore [25] by exploiting involved numerical methods.

The lace expansion devised in this paper enables us to give a rigorous proof of the first terms of 1.5 . Indeed, we use the representation obtained in this paper to show that

$$
\begin{equation*}
p_{c}(d)=(2 d)^{-1}+\frac{5}{2}(2 d)^{-2}+\frac{31}{4}(2 d)^{-3}+\mathcal{O}\left((2 d)^{-4}\right) \quad \text { as } d \rightarrow \infty \tag{1.6}
\end{equation*}
$$

This is the content of a separate paper [16]. Deriving $p_{c}$ expansions from lace expansion coefficients has been earlier achieved for bond percolation by Hara and Slade [15] and van der Hofstad and Slade [21]. Comparing (1.6) to their expansion for bond percolation confirms that already the second coefficient is different.

Proposition 4.2 proves the convergence of the lace expansion for $p<p_{c}$, yielding an identity for $\tau_{p}$ of the form

$$
\begin{equation*}
\tau_{p}(x)=C(x)+p\left(C * \tau_{p}\right)(x) \tag{1.7}
\end{equation*}
$$

where $C$ is the direct-connectedness function and $C(\cdot)=2 d D(\cdot)+\Pi_{p}(\cdot)$ (for a definition of $\Pi_{p}$, see Definition 2.8 and Proposition 4.2). In fluid-state statistical mechanics, 1.7 is known as the OrnsteinZernike equation (OZE), a classical equation that is typically associated to the total correlation function.

We can juxtapose (1.7) with the converging lace expansion for bond percolation. There, $\tau_{p}^{\text {bond }}(x)$ is the probability that $\mathbf{0}$ and $x$ are connected by a path of occupied bonds, and we have

$$
\begin{equation*}
\tau_{p}^{\text {bond }}(x)=C^{\text {bond }}(x)+2 d p\left(C^{\text {bond }} * D * \tau_{p}^{\text {bond }}\right)(x), \tag{1.8}
\end{equation*}
$$

where $C^{\text {bond }}(x)=\mathbb{1}_{\{x=0\}}+\Pi_{p}^{\text {bond }}(x)$. Thus, there is an extra convolution with $2 d D$. Only for the site percolation two-point function (as defined in this paper), the lace expansion coincides with the OZE.

We want to touch on how this relates to the infra-red bound 1.1). To this end, define the random walk Green's function as $G_{\lambda}(x)=\sum_{m \geq 0} \lambda^{m} D^{* m}(x)$ for $\lambda \in(0,1]$. Consequently,

$$
\widehat{G}_{\lambda}(k)=\frac{1}{1-\lambda \widehat{D}(k)}
$$

One of the key ideas behind the lace expansion for bond percolation is to show that the two-point function is close to $G_{\lambda}$ in an appropriate sense (this includes an appropriate parametrization of $\lambda$ ). Solving the OZE in Fourier space for $\widehat{\tau}_{p}$ already hints at the fact that in site percolation, $p \widehat{\tau}_{p}$ should be close to $\widehat{G}_{\lambda} \widehat{D}$ and $p \tau_{p}$ should be close to $D * G_{\lambda}$. As a technical remark, we note that $\widehat{G}_{\lambda}$ is uniformly lower-bounded, whereas $\widehat{G}_{\lambda} \widehat{D}$ is not, which poses some inconvenience later on.

The complete graph may be viewed as a mean-field model for percolation, in particular when we analyze clusters on high-dimensional tori, cf. [17. Interestingly, the distinction between bond and site percolation exhibits itself rather drastically on the complete graph: for bond percolation, we obtain the usual Erdős-Rényi random graph with its well-known phase transition (see, e.g., [22]), whereas for site percolation, we obtain again a complete graph with a binomial number of points.

Theorem 1.1 proves the triangle condition in dimension $d>d_{0}$ for sufficiently large $d_{0}$. It is folklore in the physics literature that $d_{0}=6$ suffices ( 6 is the "upper critical dimension") but the perturbative nature of our argument does not allow us to derive that. Instead, we only get the result for some $d_{0} \geq 6$. For bond percolation, already the original paper by Hara and Slade [13] treated a second, spread-out version of bond percolation, and they proved that for this model, $d_{0}=6$ suffices (under suitable assumption on the spread-out nature). For ordinary bond percolation, it was announced that $d_{0}=19$ suffices for the triangle condition in [14], and the number 19 circulated for many years in the community. Finally, Fitzner and van der Hofstad 10 devised involved numerical methods to rigorously verify that an adaptation of the method is applicable for $d>d_{0}=10$. It is clear that an analogous result of Theorem 1.1 would hold for "spread-out site percolation" in suitable form (see e.g. [18, Section 5.2]).

### 1.5 Outline of the paper

The paper is organized as follows. The aim of Section 2 is to establish a lace-expansion identity for $\tau_{p}$, which is formulated in Proposition 2.9. To this end, we use Section 2.1 to state some known results that we are going to make use of in Section 2 as well as in later sections. We then introduce a lot of the language and quantities needed to state Proposition 2.9 in Section 2.2 followed by the actual derivation of the identity in Section 2.3

Section 3 bounds the lace-expansion coefficients derived in Section 2.3 in terms of simpler diagrams, which are large sums over products of two-point (and related) functions. Section 4 finishes the argument via the so-called bootstrap argument. First, a bootstrap function $f$ is introduced in Section 4.1. Among other things, it measures how close $\widehat{\tau}_{p}$ is to $\widehat{G}_{\lambda}$ (in a fractional sense). Section 4.2 shows convergence of the lace expansion for fixed $p<p_{c}$. Moreover, assuming that $f$ is bounded on $\left[0, p_{c}\right.$ ), it is shown that this convergence is uniform in $p$ (see first and second part of Proposition 4.2). Lastly, Section 4.3 actually proves said boundedness of $f$.

## 2 The expansion

### 2.1 The standard tools

We require two standard tools of percolation theory, namely Russo's formula and the BK inequality, both for increasing events. Recall that $A$ is called increasing if $\omega \in A$ and $\omega \subseteq \omega^{\prime}$ implies $\omega^{\prime} \in A$. Given $\omega$ and an increasing event $A$, we introduce

$$
\operatorname{Piv}(A)=\left\{y \in \mathbb{Z}^{d}: \omega \cup\{y\} \in A,(\omega \backslash\{y\}) \notin A\right\}
$$

If $A$ is an increasing event determined by sites in $\Lambda \subset \mathbb{Z}^{d}$ with $|\Lambda|<\infty$, then Russo's formula [26], proved independently by Margulis [24], tells us that

$$
\begin{equation*}
\frac{\mathrm{d}}{\mathrm{~d} p} \mathbb{P}_{p}(A)=\mathbb{E}[|\operatorname{Piv}(A)|]=\sum_{y \in \Lambda} \mathbb{P}_{p}(y \in \operatorname{Piv}(A)) \tag{2.1}
\end{equation*}
$$

To state the BK inequality, let $\Lambda \subset \mathbb{Z}^{d}$ be finite and, given $\omega \in \Omega$, let

$$
[\omega]_{\Lambda}=\left\{\omega^{\prime} \in \Omega: \omega^{\prime}(x)=\omega(x) \text { for all } x \in \Lambda\right\}
$$

be the cylinder event of the restriction of $\omega$ to $\Lambda$. For two events $A, B$, we can define the disjoint occurrence as

$$
A \circ B=\left\{\omega: \exists K, L \subseteq \mathbb{Z}^{d}: K \cap L=\varnothing,[\omega]_{K} \subseteq A,[\omega]_{L} \subseteq B\right\}
$$

The BK inequality, proved by van den Berg and Kesten [5] for increasing events, states that, given two increasing events $A$ and $B$,

$$
\begin{equation*}
\mathbb{P}_{p}(A \circ B) \leq \mathbb{P}_{p}(A) \mathbb{P}_{p}(B) \tag{2.2}
\end{equation*}
$$

The following proposition about simple random walk will be of importance later:
Proposition 2.1 (Random walk triangle, [18], Proposition 5.5). Let $m \in \mathbb{N}_{0}, n \geq 0$ and $\lambda \in[0,1]$. Then there exists a constant $c_{2 m, n}^{(R W)}$ independent of $d$ such that, for $d>2 n$,

$$
\int_{(-\pi, \pi]^{d}} \frac{\widehat{D}(k)^{2 m}}{[1-\lambda \widehat{D}(k)]^{n}} \frac{\mathrm{~d} k}{(2 \pi)^{d}} \leq c_{2 m, n}^{(R W)} d^{-m} .
$$

In [18], $d>4 n$ is required; however, more careful analysis shows that $d>2 n$ suffices (see [7, (2.19)]). We will also need the following related result:

Proposition 2.2 (Related random walk bounds, [18, Exercise 5.4). Let $m \in\{0,1\}, \lambda \in[0,1]$, and $r, n \geq 0$ such that $d>2(n+r)$. Then, uniformly in $k \in(-\pi, \pi]^{d}$,

$$
\begin{aligned}
& \int_{(-\pi, \pi]^{d}} \widehat{D}(l)^{2 m} \widehat{G}_{\lambda}(l)^{n} \frac{1}{2}\left[\widehat{G}_{\lambda}(l+k)+\widehat{G}_{\lambda}(l-k)\right]^{r} \frac{\mathrm{~d} l}{(2 \pi)^{d}} \leq c_{2 m, n+r}^{(R W)} d^{-m} \\
& \int_{(-\pi, \pi]^{d}} \widehat{D}(l)^{2 m} \widehat{G}_{\lambda}(l)^{n-1}\left[\widehat{G}_{\lambda}(l+k) \widehat{G}_{\lambda}(l-k)\right]^{r / 2} \frac{\mathrm{~d} l}{(2 \pi)^{d}} \leq c_{2 m, n-1+r / 2}^{(R W)} d^{-m}
\end{aligned}
$$

where the constants $c_{\cdot, \text {. }}^{(R W)}$ are from Proposition 2.1.
The following differential inequality is an application of Russo's formula and the BK inequality. It applies them to events which are not determined by a finite set of sites. We refer to the literature 18 , Lemma 4.4] for arguments justifying this and for a more detailed proof. Observation 2.3 will be of use in Section 4

Observation 2.3. Let $p<p_{c}$. Then

$$
\frac{\mathrm{d}}{\mathrm{~d} p} \widehat{\tau}_{p}(0) \leq \widehat{\tau}_{p}(0)^{2}, \quad \frac{\mathrm{~d}}{\mathrm{~d} p} \chi(p) \leq \chi(p) \widehat{\tau}_{p}(0)
$$

As a proof sketch, note that

$$
\begin{aligned}
\frac{\mathrm{d}}{\mathrm{~d} p} \widehat{\tau}_{p}(0) & =\sum_{x \in \mathbb{Z}^{d}} \frac{\mathrm{~d}}{\mathrm{~d} p} \tau_{p}(x)=\sum_{x \in \mathbb{Z}^{d}} \sum_{y \in \mathbb{Z}^{d}} \mathbb{P}_{p}(y \in \operatorname{Piv}(\mathbf{0} \longleftrightarrow x)) \leq \sum_{x \in \mathbb{Z}^{d}} \sum_{y \in \mathbb{Z}^{d}} \mathbb{P}_{p}(\{\mathbf{0} \longleftrightarrow y\} \circ\{y \longleftrightarrow x\}) \\
& \leq \sum_{x \in \mathbb{Z}^{d}} \sum_{y \in \mathbb{Z}^{d}} \tau_{p}(y) \tau_{p}(x-y)=\widehat{\tau}_{p}(0)^{2}
\end{aligned}
$$

The inequality for $\chi(p)$ follows from the identity $\chi(p)=1+p \widehat{\tau}_{p}(0)$.

### 2.2 Definitions and preparatory statements

We need the following definitions:
Definition 2.4 (Elementary definitions). Let $x, u \in \mathbb{Z}^{d}$ and $A \subseteq \mathbb{Z}^{d}$.

1. We set $\omega^{x}:=\omega \cup\{x\}$ and $\omega^{u, x}:=\omega \cup\{u, x\}$.
2. We define $J(x):=\mathbb{1}_{\{|x|=1\}}=2 d D(x)$.
3. Let $\{u \longleftrightarrow x$ in $A\}$ be the event that $\{u \longleftrightarrow x\}$, and there is a path from $u$ to $x$, all of whose inner vertices are elements of $\omega \cap A$. Moreover, write $\{u \longleftrightarrow x$ off $A\}:=\left\{u \longleftrightarrow x\right.$ in $\left.\mathbb{Z}^{d} \backslash A\right\}$.
4. We define $\{u \Longleftrightarrow x\}:=\{u \longleftrightarrow x\} \circ\{u \longleftrightarrow x\}$ and say that $u$ and $x$ are doubly connected.
5. We define the modified cluster of $x$ with a designated vertex $u$ as

$$
\widetilde{\mathscr{C}}^{u}(x):=\{x\} \cup\left\{y \in \omega \backslash\{u\}: x \longleftrightarrow y \text { in } \mathbb{Z}^{d} \backslash\{u\}\right\} .
$$

6. For a set $A \subset \mathbb{Z}^{d}$, define $\langle A\rangle:=A \cup\left\{y \in \mathbb{Z}^{d}: \exists x \in A\right.$ s.t. $\left.|x-y|=1\right\}$ as the set $A$ itself plus its external boundary.

Definition 2.41 allows us to speak of events like $\left\{a \longleftrightarrow b\right.$ in $\left.\omega^{x}\right\}$ for $a, b \in \mathbb{Z}^{d}$, which is the event that $a$ is connected to $b$ in the configuration where $x$ is fixed to be occupied. We remark that $\left\{x \longleftrightarrow y\right.$ in $\left.\mathbb{Z}^{d}\right\}=$ $\{x \longleftrightarrow y\}=\{x \longleftrightarrow y$ in $\omega\}$ and that $\{u \Longleftrightarrow x\}=\Omega$ for $|u-x|=1$. Similarly, $\{u \Longleftrightarrow x\}=\varnothing$ for $u=x$. The following, more specific definitions are important for the expansion:

Definition 2.5 (Extended connection probabilities and events). Let $v, u, x \in \mathbb{Z}^{d}$ and $A \subseteq \mathbb{Z}^{d}$.

1. Define

$$
\{u \stackrel{A}{\longleftrightarrow} x\}:=\{u \longleftrightarrow x\} \cap(\{u \longleftrightarrow x \text { off }\langle A\rangle\} \cup\{x \in\langle A\rangle\}) .
$$

In words, this is the event that $u$ is connected to $x$, but either any path from $u$ to $x$ has an interior vertex in $\langle A\rangle$, or $x$ itself lies in $\langle A\rangle$.
2. Define

$$
\tau_{p}^{A}(u, x):=\mathbb{1}_{\{x \notin\langle A\rangle\}} \mathbb{P}_{p}(u \longleftrightarrow x \text { off }\langle A\rangle)
$$

3. We introduce $\operatorname{Piv}(u, x):=\operatorname{Piv}(u \longleftrightarrow x)$ as the set of pivotal points for $\{u \longleftrightarrow x\}$. That is, $v \in \operatorname{Piv}(u, x)$ if the event $\left\{u \longleftrightarrow x\right.$ in $\left.\omega^{v}\right\}$ holds but $\{u \longleftrightarrow x$ in $\omega \backslash\{v\}\}$ does not.
4. Define the events

$$
\begin{aligned}
E^{\prime}(v, u ; A) & :=\{v \stackrel{A}{\longleftrightarrow} u\} \cap\left\{\nexists u^{\prime} \in \operatorname{Piv}(v, u): v \stackrel{A}{\longleftrightarrow} u^{\prime}\right\}, \\
E(v, u, x ; A) & :=E^{\prime}(v, u ; A) \cap\{u \in \omega \cap \operatorname{Piv}(v, x)\} .
\end{aligned}
$$

First, we remark that $\left\{u \stackrel{\mathbb{Z}^{d}}{\longleftrightarrow} x\right\}=\{u \longleftrightarrow x\}$. Secondly, note that we have the relation

$$
\begin{equation*}
\tau_{p}(x-u)=\tau_{p}^{A}(u, x)+\mathbb{P}_{p}(u \stackrel{A}{\longleftrightarrow} x) . \tag{2.3}
\end{equation*}
$$

We next state a partitioning lemma (whose proof is left to the reader; see [19, Lemma 3.5]) relating the events $E$ and $E^{\prime}$ to the connection event $\{u \stackrel{A}{\longleftrightarrow} x\}$ :

Lemma 2.6 (Partitioning connection events). Let $v, x \in \mathbb{Z}^{d}$ and $A \subseteq \mathbb{Z}^{d}$. Then

$$
\{v \stackrel{A}{\longleftrightarrow} x\}=E^{\prime}(v, x ; A) \cup \bigcup_{u \in \mathbb{Z}^{d}} E(v, u, x ; A)
$$

and the appearing unions are disjoint.
The next lemma, titled the Cutting-point lemma, is at the heart of the expansion:
Lemma 2.7 (Cutting-point lemma). Let $v, u, x \in \mathbb{Z}^{d}$ and $A \subseteq \mathbb{Z}^{d}$. Then

$$
\mathbb{P}_{p}(E(v, u, x ; A))=p \mathbb{E}_{p}\left[\mathbb{1}_{E^{\prime}(v, u ; A)} \tau_{p}^{\widetilde{\mathscr{C}}^{u}}(v)(u, x)\right] .
$$

Proof. The proof is a special case of the general setting of [19. Since it is essential, we present it here. We abbreviate $\tilde{\mathscr{C}}=\widetilde{\mathscr{C}}^{u}(v)$ and observe that

$$
\begin{aligned}
\{u \in \operatorname{Piv}(v, x)\} & =\{v \longleftrightarrow u\} \cap\{u \longleftrightarrow x \text { off } \tilde{\mathscr{C}}\} \cap\{x \notin\langle\tilde{\mathscr{C}}\rangle\} \\
& =\{v \longleftrightarrow u\} \cap\{u \longleftrightarrow x \text { off }\langle\widetilde{\mathscr{C}}\rangle\} \cap\{x \notin\langle\widetilde{\mathscr{C}}\rangle\}
\end{aligned}
$$

In the above, we can replace $\widetilde{\mathscr{C}}$ by $\langle\widetilde{\mathscr{C}}\rangle$ in the middle event, as, by definition, we know that, apart from $u$, any site in $\langle\widetilde{\mathscr{C}}\rangle \backslash \widetilde{\mathscr{C}}$ must be vacant. Now, since $E^{\prime}(v, u ; A) \subseteq\{v \longleftrightarrow u\}$, we get

$$
E(v, u, x ; A)=E^{\prime}(v, u ; A) \cap\{u \longleftrightarrow x \text { off }\langle\widetilde{\mathscr{C}}\rangle\} \cap\{x \notin\langle\widetilde{\mathscr{C}}\rangle\} \cap\{u \in \omega\}
$$

Taking probabilities, conditioning on $\tilde{\mathscr{C}}$, and observing that the status of $u$ is independent of all other events, we see

$$
\mathbb{P}_{p}(E(v, u, x ; A))=p \mathbb{E}_{p}\left[\mathbb{1}_{E^{\prime}(v, u ; A)} \mathbb{1}_{\{x \notin\langle\widetilde{\mathscr{C}}\rangle\}} \mathbb{E}_{p}\left[\mathbb{1}_{\{u \longleftrightarrow x \text { off }\langle\widetilde{\mathscr{C}}\rangle\}} \mid \widetilde{\mathscr{C}}\right]\right]
$$

making use of the fact that the first two events are measurable w.r.t. $\tilde{\mathscr{C}}$. The proof is complete with the observation that under $\mathbb{E}_{p}$, almost surely,

$$
\mathbb{1}_{\{x \notin\langle\widetilde{\mathscr{C}}\rangle\}} \mathbb{E}_{p}\left[\mathbb{1}_{\{u \longleftrightarrow x \text { off }\langle\widetilde{\mathscr{C}}\rangle\}} \mid \widetilde{\mathscr{C}}\right]=\tau_{p}^{\widetilde{\mathscr{C}}}(u, x)
$$

### 2.3 Derivation of the expansion

We introduce a sequence $\left(\omega_{i}\right)_{i \in \mathbb{N}_{0}}$ of independent site percolation configurations. For an event $E$ taking place on $\omega_{i}$, we highlight this by writing $E_{i}$. We also stress the dependence of random variables on the particular configuration they depend on. For example, we write $\mathscr{C}\left(u ; \omega_{i}\right)$ to denote the cluster of $u$ in configuration $i$.

Definition 2.8 (Lace-expansion coefficients). Let $m \in \mathbb{N}, n \in \mathbb{N}_{0}$ and $x \in \mathbb{Z}^{d}$. We define

$$
\begin{aligned}
\Pi_{p}^{(0)}(x) & :=\mathbb{P}_{p}(\mathbf{0} \Longleftrightarrow x)-J(x), \\
\Pi_{p}^{(m)}(x) & :=p^{m} \sum_{u_{0}, \ldots, u_{m-1}} \mathbb{P}_{p}\left(\left\{\mathbf{0} \Longleftrightarrow u_{0}\right\}_{0} \cap \bigcap_{i=1}^{m} E^{\prime}\left(u_{i-1}, u_{i} ; \mathscr{C}_{i-1}\right)_{i}\right),
\end{aligned}
$$

where we recall that $J(x)=\mathbb{1}_{\{|x|=1\}}$ and moreover $u_{-1}=\mathbf{0}, u_{m}=x$, and $\mathscr{C}_{i}=\widetilde{\mathscr{C}}^{u_{i}}\left(u_{i-1} ; \omega_{i}\right)$. Let

$$
R_{p, n}(x):=(-p)^{n+1} \sum_{u_{0}, \ldots, u_{n}} \mathbb{P}_{p}\left(\left\{\mathbf{0} \Longleftrightarrow u_{0}\right\}_{0} \cap \bigcap_{i=1}^{n} E^{\prime}\left(u_{i-1}, u_{i} ; \mathscr{C}_{i-1}\right)_{i} \cap\left\{u_{n} \mathscr{C}_{n}\right\}_{n+1}\right)
$$

Finally, set

$$
\Pi_{p, n}(x)=\sum_{m=0}^{n}(-1)^{m} \Pi_{p}^{(m)}(x)
$$

It should be noted that the events $E^{\prime}\left(u_{i-1}, u_{i} ; \mathscr{C}_{i-1}\right)_{i}$ appearing in Definition 2.8 take place on configuration $i$ only if $\mathscr{C}_{i-1}$ is taken to be a fixed set - otherwise, they are events determined by configurations $i-1$ and $i$.

Proposition 2.9 (The lace expansion). Let $p<p_{c}, x \in \mathbb{Z}^{d}$, and $n \in \mathbb{N}_{0}$. Then

$$
\tau_{p}(x)=J(x)+\Pi_{p, n}(x)+p\left(\left(J+\Pi_{p, n}\right) * \tau_{p}\right)(x)+R_{p, n}(x)
$$

Proof. We have

$$
\tau_{p}(x)=J(x)+\Pi_{p}^{(0)}(x)+\mathbb{P}_{p}(\mathbf{0} \longleftrightarrow x, \mathbf{0} \Longleftrightarrow x)
$$

We can partition the last summand via the first pivotal point. Pointing out that $\{\mathbf{0} \Longleftrightarrow u\}=E^{\prime}\left(0, u ; \mathbb{Z}^{d}\right)$, we obtain

$$
\begin{aligned}
\mathbb{P}_{p}(\mathbf{0} \longleftrightarrow x, \mathbf{0} \Longleftrightarrow x) & =\sum_{u_{0} \in \mathbb{Z}^{d}} \mathbb{P}_{p}\left(\mathbf{0} \Longleftrightarrow u_{0}, u_{0} \in \omega, u_{0} \in \operatorname{Piv}(\mathbf{0}, x)\right)=\sum_{u_{0}} \mathbb{P}_{p}\left(E\left(\mathbf{0}, u_{0}, x ; \mathbb{Z}^{d}\right)\right) \\
& =p \sum_{u_{0}} \mathbb{E}_{p}\left[\mathbb{1}_{\left\{\mathbf{0} \Longleftrightarrow u_{0}\right\}_{0}} \cdot \tau_{p}^{\mathscr{C}_{0}}\left(u_{0}, x\right)\right]
\end{aligned}
$$

via the Cutting-point lemma 2.7. Using 2.3 for $A=\mathscr{C}_{0}$, we have

$$
\begin{equation*}
\tau_{p}(x)=J(x)+\Pi_{p}^{(0)}(x)+p \sum_{u_{0}}\left(J\left(u_{0}\right)+\Pi_{p}^{(0)}\left(u_{0}\right)\right) \tau_{p}\left(x-u_{0}\right)-p \sum_{u_{0}} \mathbb{E}_{p}\left[\mathbb{1}_{\left\{0 \Longleftrightarrow u_{0}\right\}_{0}} \cdot \mathbb{P}_{p}\left(u_{0} \stackrel{\mathscr{C}_{0}}{\longleftrightarrow} x\right)\right] \tag{2.4}
\end{equation*}
$$

This proves the expansion identity for $n=0$. Next, Lemma 2.6 and Lemma 2.7 yield

$$
\begin{aligned}
\mathbb{P}_{p}\left(u_{0} \stackrel{A}{\longleftrightarrow} x\right) & =\mathbb{P}_{p}\left(E^{\prime}\left(u_{0}, x ; A\right)\right)+\sum_{u_{1} \in \mathbb{Z}^{d}} \mathbb{P}_{p}\left(E\left(u_{0}, u_{1}, x ; A\right)\right) \\
& =\mathbb{P}_{p}\left(E^{\prime}\left(u_{0}, x ; A\right)\right)+p \sum_{u_{1} \in \mathbb{Z}^{d}} \mathbb{E}_{p}\left[\mathbb{1}_{E^{\prime}\left(u_{0}, u_{1} ; A\right)} \cdot \tau_{p}^{\widetilde{\mathscr{G}}^{u_{1}}\left(u_{0}\right)}\left(u_{1}, x\right)\right]
\end{aligned}
$$

Plugging this into (2.4), we use 2.3) for $A=\widetilde{\mathscr{C}}^{u_{1}}(u)$ to extract $\Pi_{p}^{(1)}$ and get

$$
\begin{aligned}
\tau_{p}(x)= & J(x)+\Pi_{p}^{(0)}(x)-\Pi_{p}^{(1)}(x)+p\left(\left(J+\Pi_{p}^{(0)}\right) * \tau_{p}\right)(x) \\
& +p^{2} \sum_{u_{1}} \tau_{p}\left(x-u_{1}\right) \sum_{u_{0}} \mathbb{P}_{p}\left(\left\{\mathbf{0} \Longleftrightarrow u_{0}\right\}_{0} \cap E^{\prime}\left(u_{0}, u_{1} ; \mathscr{C}_{0}\right)_{1}\right)+R_{p, 1}(x) \\
= & J(x)+\Pi_{p}^{(0)}(x)-\Pi_{p}^{(1)}(x)+p\left(\left(J+\Pi_{p}^{(0)}-\Pi_{p}^{(1)}\right) * \tau_{p}\right)(x)+R_{p, 1}(x)
\end{aligned}
$$

Note that all appearing sums are bounded by $\sum_{y} \tau_{p}(y)$. This sum is finite for $p<p_{c}$, justifying the above changes in order of summation. The expansion for general $n$ is an induction on $n$ where the step is analogous to the step $n=1$ (but heavier on notation).

## 3 Diagrammatic bounds

### 3.1 Setup, bounds for $n=0$

We use this section to state Lemma 3.1 and state bounds on $\Pi_{p}^{(0)}$, which are rather simple to prove. The more involved bounds on $\Pi_{p}^{(n)}$ for $n \geq 1$ are dealt with in Section 3.2. Note that if $f(-x)=f(x)$, then $\widehat{f}(k)=\sum_{x \in \mathbb{Z}^{d}} \cos (k \cdot x) f(x)$. We furthermore have the following tool at our disposal:
Lemma 3.1 (Split of cosines, [9], Lemma 2.13). Let $t \in \mathbb{R}$ and $t_{i} \in \mathbb{R}$ for $i=1, \ldots, n$ such that $t=\sum_{i=1}^{n} t_{i}$. Then

$$
1-\cos (t) \leq n \sum_{i=1}^{n}\left[1-\cos \left(t_{i}\right)\right]
$$

We begin by treating the coefficient for $n=0$, giving a glimpse into the nature of the bounds to follow in Sections 3.2 and 3.3. To this end, we define the two displacement quantities

$$
J_{k}(x):=[1-\cos (k \cdot x)] J(x) \quad \text { and } \quad \tau_{p, k}(x)=[1-\cos (k \cdot x)] \tau_{p}(x)
$$

Proposition 3.2 (Bounds for $n=0)$. For $k \in(-\pi, \pi]^{d}$,

$$
\begin{aligned}
\left|\widehat{\Pi}_{p}^{(0)}(k)\right| & \leq p^{2}\left(J^{* 2} * \tau_{p}^{* 2}\right)(\mathbf{0}), \\
\left|\widehat{\Pi}_{p}^{(0)}(0)-\widehat{\Pi}_{p}^{(0)}(k)\right| & \leq 2 p^{2}\left(\left(J_{k} * J * \tau_{p}^{* 2}\right)(\mathbf{0})+\left(J^{* 2} * \tau_{p, k} * \tau_{p}\right)(\mathbf{0})\right)
\end{aligned}
$$

Proof. Note that $|x| \leq 1$ implies $\Pi_{p}^{(0)}(x)=0$ by definition. For $|x| \geq 2$, we have

$$
\Pi_{p}^{(0)}(x) \leq \mathbb{E}\left[\sum_{y \neq z \in \omega} \mathbb{1}_{\{|y|=|z|=1\}} \mathbb{1}_{\{y \longleftrightarrow x\} \circ\{z \longleftrightarrow x\}}\right] \leq p^{2}\left(\sum_{y \in \mathbb{Z}^{d}} J(y) \tau_{p}(x-y)\right)^{2}=p^{2}\left(J * \tau_{p}\right)(x)^{2}
$$

Summation over $x$ gives the first bound. The last bound is obtained by applying Lemma 3.1 to the bounds derived for $\Pi_{p}^{(0)}(x)$ :

$$
\begin{aligned}
\mid \widehat{\Pi}_{p}^{(0)}(0) & -\widehat{\Pi}_{p}^{(0)}(k) \mid=\sum_{x}[1-\cos (k \cdot x)] \Pi_{p}^{(0)}(x) \\
& \leq 2 p^{2} \sum_{x}\left(J * \tau_{p}\right)(x) \sum_{y}\left([1-\cos (k \cdot y)] J(y) \tau_{p}(x-y)+J(y)[1-\cos (k \cdot(x-y))] \tau_{p}(x-y)\right) .
\end{aligned}
$$

Resolving the sums gives the claimed convolution.

### 3.2 Bounds in terms of diagrams

The main result of this section is Proposition 3.5, providing bounds on the lace-expansion coefficients in terms of so-called diagrams, which are sums over products of two-point (and related) functions. To state it, we introduce some functions related to $\tau_{p}$ as well as several "modified triangles" closely related to $\triangle_{p}$. We denote by $\delta_{x, y}=\mathbb{1}_{\{x=y\}}$ the Kronecker delta.
Definition 3.3 (Modified two-point functions). Let $x \in \mathbb{Z}^{d}$ and define

$$
\tau_{p}^{\circ}(x):=\delta_{\mathbf{0}, x}+\tau_{p}(x), \quad \tau_{p}^{\bullet}(x)=\delta_{\mathbf{0}, x}+p \tau_{p}(x), \quad \gamma_{p}(x)=\tau_{p}(x)-J(x)
$$

Definition 3.4 (Modified triangles). We let $\triangle_{p}^{\circ}(x)=p^{2}\left(\tau_{p}^{\circ} * \tau_{p} * \tau_{p}\right)(x), \triangle_{p}^{\bullet}(x)=p\left(\tau_{p}^{\bullet} * \tau_{p} * \tau_{p}\right)(x), \triangle_{p}^{\bullet}(x)=$ $p\left(\tau_{p}^{\bullet} * \tau_{p}^{\circ} * \tau_{p}\right)(x)$, and $\triangle_{p}^{\bullet \bullet}(x)=\left(\tau_{p}^{\bullet} * \tau_{p}^{\bullet} * \tau_{p}^{\circ}\right)(x)$. We also set

$$
\triangle_{p}^{\circ}=\sup _{x \in \mathbb{Z}^{d}} \triangle_{p}^{\circ}(x), \quad \triangle_{p}^{\bullet}=\sup _{\mathbf{0} \neq x \in \mathbb{Z}^{d}} \triangle_{p}^{\bullet}(x), \quad \triangle_{p}^{\bullet \circ}=\sup _{\mathbf{0} \neq x \in \mathbb{Z}^{d}} \triangle_{p}^{\bullet \circ}(x), \quad \triangle_{p}^{\bullet \bullet}=\sup _{x \in \mathbb{Z}^{d}} \triangle_{p}^{\bullet \bullet \circ}(x)
$$

and $T_{p}:=\left(1+\triangle_{p}\right) \triangle_{p}^{\bullet \circ}+\triangle_{p} \triangle_{p}^{\bullet \bullet \circ}$.
Definitions 3.3 and 3.4 allow us to properly keep track of factors of $p$, which turns out to be important throughout Section 3 .

Proposition 3.5 (Triangle bounds on the lace-expansion coefficients). For $n \geq 0$,

$$
p \sum_{x \in \mathbb{Z}^{d}} \Pi_{p}^{(n)}(x) \leq \triangle_{p}^{\bullet}(\mathbf{0})\left(T_{p}\right)^{n}
$$

The proof of Proposition 3.5 relies on two intermediate steps, successively giving bounds on $\sum \Pi_{p}^{(n)}$. These two steps are captured in Lemmas 3.7 and 3.10, respectively. We first state the former lemma.

Recall that $\Pi_{p}^{(n)}$ is defined on independent percolation configurations $\omega_{0}, \ldots, \omega_{n}$. A crucial step in proving Proposition 3.5 is to group events taking place on the percolation configuration $i$, and then to use the independence of the different configurations. To this end, note that event $E^{\prime}\left(u_{i-1}, u_{i} ; \mathscr{C}_{i-1}\right)_{i}$ takes place on configuration $i$ only if $\mathscr{C}_{i-1}$ is considered to be a fixed set. Otherwise, it is a product event made up of the connection events of configuration $i$ as well as a connection event in configuration $i-1$, preventing a direct use of the independence of the $\omega_{i}$. Resolving this issue is one of the goals of Lemma 3.7 another is to give bounds in terms of the simpler events (amenable to application of the BK inequality) introduced below in Definition 3.6


Figure 1: The $F$ events represented graphically. For lines with double arrows, we may have coincidence of the endpoints, for lines without double arrows, we do not. The area with grey tiles indicates that its three boundary points are either all distinct or collapsed into a single point. These diagrams also serve as a pictorial representation of the function $\phi_{0}, \phi, \phi_{n}$. There, lines with double arrows represent factors of $\tau_{p}^{\circ}$ and lines without double arrows represent factors of $\tau_{p}$.

Definition 3.6 (Bounding events). Let $x, y \in \mathbb{Z}^{d}$. We define

$$
\{x \longleftrightarrow y\}:=\{x \longleftrightarrow y\} \cup\{x=y\} .
$$

Let now $i \in\{1, \ldots, n\}$ and let $a, b, t, w, z, u \in \mathbb{Z}^{d}$. We define

$$
\begin{aligned}
& F_{0}(a, w, u, b)=(\{w=a,|u-a|=1\} \cap\{a(m \rightarrow b\})
\end{aligned}
$$

$$
\begin{aligned}
& F_{n}(a, t, z, x)=\{|\{t, z, x\}| \neq 2\} \cap\{a \sim t\} \\
& \circ\{t \rightarrow x\} \circ\{t \rightarrow z\} \circ\{z \times x\} \text {, } \\
& F^{(1)}(a, t, w, z, u, b)=\{|\{w, t, z, u\}|=4\} \cap(\{a \not m s t\} \circ\{t \longleftrightarrow w\} \circ\{t \longleftrightarrow z\} \\
& \circ\{w \longleftrightarrow u\} \circ\{z \longleftrightarrow u\} \circ\{w(m) b\}), \\
& F^{(2)}(a, t, w, z, u, b)=\{w \notin\{z, u\},|\{t, z, u\}| \neq 2\} \cap(\{a+w \rightarrow w \circ\{w \text { unc } b\}
\end{aligned}
$$

The coincidence requirements in $F^{(2)}$ mean that among the points $t_{i}, w_{i}, z_{i}, u_{i}$, the point $w_{i}$ may coincide only with $t_{i}$; and additionally, the triple $\left\{t_{i}, z_{i}, u_{i}\right\}$ are either all distinct, or collapsed into a single point. The above events are depicted in Figure 1 .

For intervals $[a, b]$, we use the notation $\vec{x}_{[a, b]}=\left(x_{a}, x_{a+1}, \ldots, x_{b}\right)$. This is not to be confused with the notation $\vec{v}_{i}$ from Definition 3.6. We use the notation $\left(\mathbb{Z}^{d}\right)^{(m, 1)}$ to denote the set of vectors $\left\{\vec{y}_{[1, m]} \in\right.$ $\left.\left(\mathbb{Z}^{d}\right)^{m}: y_{i} \neq y_{i+1} \forall 1 \leq i<m\right\}$.

Lemma 3.7 (Coefficient bounds in terms of $F$ events). For $n \geq 1$ and $\left(u_{0}, \ldots, u_{n-1}, x\right) \in\left(\mathbb{Z}^{d}\right)^{(n+1,1)}$,

\begin{aligned}
& \left\{\mathbf{0} \Longleftrightarrow u_{0}\right\}_{0} \cap \bigcap_{i=1}^{n} E^{\prime}\left(u_{i-1}, u_{i} ; \mathscr{C}_{i-1}\right)_{i} \\
& \subseteq \quad \bigcup_{\substack{\vec{z}_{[1, n]}: z_{i} \in \omega_{i}^{u_{i}}, w_{0} \in \omega_{0}^{0}, t_{n} \in \omega_{n}^{u_{n-1}, x}}} F_{0}\left(\mathbf{0}, w_{0}, u_{0}, z_{1}\right)_{0} \cap\left(\bigcap_{i=1}^{n-1}\left(\bigcup_{\substack{t_{i} \in \omega_{i}^{u_{i-1}}, w_{i} \in \omega_{i}}} F^{(1)}\left(\vec{v}_{i}\right)_{i} \cup \bigcup_{\substack{w_{i} \in \omega_{i}^{u_{i-1}}, t_{i} \in \omega_{i}^{u_{i}, w_{i}}}} F^{(2)}\left(\vec{v}_{i}\right)_{i}\right)\right) \\
& \cap F_{n}\left(u_{n-1}, t_{n}, z_{n}, x\right)_{n},
\end{aligned}

where $\vec{v}_{i}=\left(u_{i-1}, t_{i}, w_{i}, z_{i}, u_{i}, z_{i+1}\right)$ and $u_{n}=x$.
The proof is analogous to the one in [19, Lemma 4.12] and we do not perform it here. The second important lemma is Lemma 3.10, and its bounds are phrased in terms of the following functions:

Definition 3.8 (The $\psi$ and $\phi$ functions). Let $n \geq 1$ and $a_{1}, a_{2}, b, w, t, u, z \in \mathbb{Z}^{d}$. We define

\psi_{n}\left(a_{1}, a_{2}, t, z, x\right) & :=\mathbb{1}_{\{|\{t, z, x\}| \neq 2\}} \tau_{p}^{\circ}\left(z-a_{1}\right) \tau_{p}^{\bullet}\left(t-a_{2}\right) \tau_{p}^{\bullet}(z-t) \tau_{p}^{\bullet}(x-t) \tau_{p}^{\circ}(x-z) .
\end{aligned}

Moreover, we define

& \psi^{(1)}\left(a_{1}, a_{2}, t, w, z, u\right):=p^{3} \mathbb{1}_{\{|\{t, w, z, u\}|=4\}} \tau_{p}^{\circ}\left(z-a_{1}\right) \tau_{p}^{\bullet}\left(t-a_{2}\right) \tau_{p}(w-t) \tau_{p}(z-t) \tau_{p}(u-w) \tau_{p}(u-z), \\
& \psi^{(2)}\left(a_{1}, a_{2}, t, w, z, u\right):=\mathbb{1}_{\{w \notin\{z, u\},|\{t, z, u\}| \neq 2\}} \tau_{p}^{\circ}\left(z-a_{1}\right) \tau_{p}^{\bullet}\left(w-a_{2}\right) \tau_{p}^{\bullet}(t-w) \tau_{p}^{\bullet}(z-t) \tau_{p}^{\bullet}(u-t) \tau_{p}^{\circ}(u-z),
\end{aligned}
$$

and $\psi:=\psi^{(1)}+\psi^{(2)}$. Furthermore, for $j \in\{1,2\}$, let

\phi_{n}\left(a_{2}, t, z, x\right) & :=\mathbb{1}_{\{|\{t, z, x\}| \neq 2\}} \tau_{p}^{\bullet}\left(t-a_{2}\right) \tau_{p}^{\bullet}(z-t) \tau_{p}^{\bullet}(x-t) \tau_{p}^{\circ}(x-z), \\
\phi^{(j)}\left(a_{2}, t, w, z, u, b\right) & :=\frac{\tau_{p}^{\circ}(b-w)}{\tau_{p}^{\circ}(z)} \psi^{(j)}\left(\mathbf{0}, a_{2}, t, w, z, u\right),

and $\tilde{\phi}_{0}(b, w, u, z):=\tilde{\psi}_{0}(b, w, u) \tau_{p}^{\circ}(z-w)$ as well as $\phi:=\phi^{(1)}+\phi^{(2)}$.
We remark that $\psi_{0} \leq \tilde{\psi}_{0}$ as well as $\phi_{0} \leq \tilde{\phi}_{0}$, and we are going to use this fact later on. In the definition of $\phi^{(j)}$, the factor $\tau_{p}^{\circ}(z)$ cancels out. In that sense, $\phi^{(j)}$ is obtained from $\psi^{(j)}$ by "replacing" the factor $\tau_{p}^{\circ}\left(z-a_{1}\right)$ by the factor $\tau_{p}^{\circ}(b-w)$, and the two functions are closely related.

We first obtain a bound on $\Pi_{p}^{(n)}$ in terms of the $F$ events (this is Lemma 3.7). Bounding those with the BK inequality, we will naturally observe the $\phi$ functions (Lemma 3.10). To decompose them further, we would like to apply induction; for this purpose, the $\psi$ functions are much better-suited. By introducing both the $\phi$ and $\psi$ functions, we increase the readability throughout this section (and later ones).

Definition 3.9 (The $\Psi$ function). Let $w_{n}, u_{n} \in \mathbb{Z}^{d}$ and define

where $\vec{t}_{[1, n]}, \vec{z}_{[1, n]}, \vec{w}_{[0, n-1]} \in\left(\mathbb{Z}^{d}\right)^{n}$ and $\vec{u}_{[0, n-1]} \in\left(\mathbb{Z}^{d}\right)^{(n, 1)}$.
We remark that $\Psi^{(n)}(x, x)=0$, resulting from the fact that the $\phi$ functions in Definition 3.8 output 0 for $w=u$. We are going to make use of this later.

Lemma 3.10 (Bound in terms of $\psi$ functions). For $n \geq 0$,

Proof. Note first that according to Definition 2.8 the function $\Pi_{p}^{(n)}$ contains the event $E^{\prime}\left(u_{i-1}, u_{i} ; \mathscr{C}_{i-1}\right)$, which is itself contained in $\left\{u_{i-1} \longleftrightarrow u_{i}\right\}$. This is why we may assume that the points $u_{0}, \ldots, u_{n}$ in the definition of $\Pi_{p}^{(n)}$ satisfy $u_{i-1} \neq u_{i}$. Together with Lemma 3.7. this yields a bound on $\Pi_{p}^{(n)}$ of the form

p \Pi_{p}^{(n)}\left(u_{n}\right) \leq p^{n+1} \sum_{\vec{u}} \mathbb{P}_{p}\left(\bigcup_{w_{0}, t_{n}, \vec{z}} F_{0}\left(\mathbf{0}, w_{0}, u_{0}, z_{1}\right)_{0} \cap \bigcap_{i=1}^{n-1}\left(\bigcup_{t_{i}, w_{i}} F^{(1)}\left(\vec{v}_{i}\right)_{i} \cup \bigcup_{t_{i}, w_{i}} F^{(2)}\left(\vec{v}_{i}\right)_{i}\right)\right. \\
\left.\cap F_{n}\left(u_{n-1}, t_{n}, z_{n}, x\right)_{n}\right)
\end{gathered}
$$

$$
\begin{align*}
& \leq \sum_{\vec{t}, \vec{w}, \vec{z}, \vec{u}} p^{\left|\left\{\mathbf{0}, w_{0}\right\}\right|} \mathbb{P}_{p}\left(F_{0}\left(\mathbf{0}, w_{0}, u_{0}, z_{1}\right)\right) \\
& \quad \times \prod_{i=1}^{n-1}\left(p^{\left|\left\{u_{i-1}, t_{i}\right\}\right|+2} \mathbb{P}_{p}\left(F^{(1)}\left(\vec{v}_{i}\right)\right)+p^{\left|\left\{u_{i-1}, w_{i}\right\}\right|+\left|\left\{w_{i}, t_{i}\right\}\right|+\left|\left\{t_{i}, z_{i}, u_{i}\right\}\right|-3} \mathbb{P}_{p}\left(F^{(2)}\left(\vec{v}_{i}\right)\right)\right) \\
& \quad \times p^{\left\{\{ u _ { n - 1 } , t _ { n } \} \left|+\left|\left\{t_{n}, z_{n}, u_{n}\right\}\right|-2\right.\right.} \mathbb{P}_{p}\left(F_{n}\left(u_{n-1}, t_{n}, z_{n}, u_{n}\right)\right) \tag{3.2}
\end{align*}
$$

where we recall that $\vec{v}_{i}=\left(u_{i-1}, t_{i}, w_{i}, z_{i}, u_{i}, z_{i+1}\right)$. In the first line, $\vec{t}, \vec{w}, \vec{z}$ are occupied points as in Lemma 3.7. In both lines, $\vec{u}_{[0, n]} \in\left(\mathbb{Z}^{d}\right)^{(n+1,1)}$, and in the second line, $\vec{t}, \vec{w}, \vec{z} \in\left(\mathbb{Z}^{d}\right)^{n}$. Crucially, in the second inequality of (3.2), the factorization occurs due to the independence of the different percolation configurations. Moreover, it is crucial here that the number of factors of $p$ (appearing when we switch from a sum over points in $\omega$ to a sum over points in $\mathbb{Z}^{d}$ ) depends on the number of coinciding points.

We can now decompose the $F$ events by heavy use of the BK inequality, producing bounds in terms of the $\phi$ functions introduced in Definition 3.8. We start by bounding

\left.p^{|\{a, t\}|+2} \mathbb{P}_{p}\left(F^{(1)}(a, t, w, z, u, b)\right)+p^{|\{a, w\}|+|\{w, t\}|+|\{t, z, u\}|-3} \mathbb{P}_{p}\left(F^{(2)}(a, t, w, z, u, b)\right)\right) \leq \phi(a, t, w, z, u, b)
$$

Plugging these bounds into 3.2 , we obtain the new bound

p \Pi_{p}^{(n)}\left(u_{n}\right) \leq \sum_{(\vec{t}, \vec{z})_{[1, n]},(\vec{w}, \vec{u})_{[0, n-1]}} \phi_{0}\left(\mathbf{0}, w_{0}, u_{0}, z_{1}\right) \phi_{n}\left(u_{n-1}, t_{n}, z_{n}, x\right) \prod_{i=1}^{n-1} \phi\left(u_{i-1}, t_{i}, w_{i}, z_{i}, u_{i}, z_{i+1}\right) \tag{3.3}
\end{equation*}
$$

where $\vec{t}_{[1, n]}, \vec{w}_{[0, n-1]}, \vec{z}_{[1, n]} \in\left(\mathbb{Z}^{d}\right)^{n}$, and $\vec{u}_{[0, n]} \in\left(\mathbb{Z}^{d}\right)^{(n+1,1)}$. We rewrite the right-hand side of 3.3) by replacing the $\phi_{0}, \phi_{n}$ and $\phi$ functions by $\psi_{0}, \psi_{n}$ and $\psi$ functions. As the additional factors arising from this replacement exactly cancel out, this gives the first bound in Lemma 3.10. The observation

Proof of Proposition 3.5. We show that

which is sufficient due to 3.1 . The proof of 3.5 is by induction on $n$. For the base case, we bound

& \leq\left(\sum_{w^{\prime}, u^{\prime}} \Psi^{(n-1)}\left(w^{\prime}, u^{\prime}\right)\right)\left(\sup _{w^{\prime} \neq u^{\prime}} \sum_{z, t, w, u \neq u^{\prime}} \psi\left(w^{\prime}, u^{\prime}, t, w, z, u\right)\right) . \tag{3.6}
\end{align*}
$$

The fact that $\Psi^{(n)}(x, x)=0$ for any $n$ and $x$ allows us to assume $w^{\prime} \neq u^{\prime}$ in the supremum in the second line of 3.6. After applying the induction hypothesis, it remains to bound the second factor for $w^{\prime} \neq u^{\prime}$,

which we rewrite as $\sup _{a \neq \mathbf{0}} \sum_{t, w, z, u \neq a} \psi(\mathbf{0}, a, t, w, z, u)$ by translation invariance. As it is a sum of two terms (originating from $\psi^{(1)}$ and $\psi^{(2)}$ ), we start with the first one and obtain

& p^{3} \sum_{t, z}\left(\tau_{p}^{\bullet}(t-a) \tau_{p}(z-t) \tau_{p}^{\circ}(z)\left(\sum_{u, w} \tau_{p}(w-t) \tau_{p}(u-w) \tau_{p}(z-u)\right)\right) \\
& \quad \leq p \sum_{t, z}\left(\tau_{p}^{\bullet}(t-a) \tau_{p}(z-t) \tau_{p}^{\circ}(z)\left(\sup _{t, z} p^{2} \sum_{u, w} \tau_{p}(w-t) \tau_{p}(u-w) \tau_{p}(z-u)\right)\right) \leq \triangle_{p} \triangle_{p}^{\bullet}(a) \tag{3.7}
\end{align*}
$$

Before treating the second term, we show how to obtain the bound from 3.7 pictorially, using diagrams very similar to the ones introduced in Figure 2. In particular, factors of $\tau_{p}$ are represented by lines, factors of $\tau_{p}^{\bullet}$ and $\tau_{p}^{\circ}$ by lines with an added ' $\bullet$ ' or ' $o$ ', respectively. Points summed over are represented by squares, other points (which we mostly take the supremum over, for example point $a$ ) are represented by colored disks. Hence, we interpret the factor $\tau_{p}(z-t)$ as a line between $t$ and $z$. Since both endpoints are summed over, we display them as squares (and without labels $t$ or $z$ ). We interpret the factor $\tau_{p}^{\circ}(z)$ as a (o-decorated) line between $\mathbf{0}$ and $z$; the origin is represented by lack of decorating the incident line. Finally, we indicate the distinctness of a pair of points (in our case $\mathbf{0} \neq a$ ) by a disrupted two-headed arrow $\stackrel{1}{\dagger}$. With this notation, 3.7 becomes

The second term in $\psi$, originating from $\psi^{(2)}$, contains an indicator. Resolving it splits this term into two further terms. We first consider the term arising from $|\{t, z, u\}|=1$, which forces $w \neq t=u=z$, and the term is of the form

Turning to the term due to $|\{t, z, u\}|=3$, with a substitution of the form $y^{\prime}=y-u$ for $y \in\{t, w, z\}$ in the second line, we see that

& p^{2} \sum_{t, w, z, u} \tau_{p}^{\bullet}(w-a) \tau_{p}^{\circ}(z) \tau_{p}^{\bullet}(t-w) \tau_{p}(z-t) \tau_{p}(u-t) \tau_{p}(z-u) \\
= & p^{2} \sum_{t^{\prime}, z^{\prime}}\left(\tau_{p}\left(z^{\prime}\right) \tau_{p}\left(t^{\prime}-z^{\prime}\right) \tau_{p}\left(t^{\prime}\right)\left(\sum_{u, w^{\prime}} \tau_{p}^{\circ}\left(z^{\prime}+u\right) \tau_{p}^{\bullet}\left(a-w^{\prime}-u\right) \tau_{p}^{\bullet}(w-t)\right)\right) \\
\leq & \triangle_{p} \triangle_{p}^{\bullet \bullet} \tag{3.8}
\end{align*}
$$

This concludes the proof. However, we also want to show how to execute the bound in (3.8) using diagrams. To do so, we need to represent a substitution in pictorial form. Note that after the substitution, the sum over point $u$ is w.r.t. two factors, namely $\tau_{p}^{\circ}\left(z^{\prime}+u\right) \tau_{p}^{\bullet}\left(a-w^{\prime}-u\right)$. We interpret these two factors as a line between $-u$ and $z^{\prime}$ and a line between $-(u-a)$ and $w^{\prime}$. In this sense, the two lines do not meet in $u$, but they have endpoints that are a constant vector $a$ apart. We represent this as

The bound in (3.8) thus becomes

where we point out that we did not use $a \neq \mathbf{0}$ for the bound $\triangle_{p}^{\bullet \bullet}$, and so it was not indicated in the diagram.

The following corollary will be needed later to show that the limit $\Pi_{p, n}$ for $n \rightarrow \infty$ exists:
Corollary 3.11. For $n \geq 1$,

Proof. Note that

\Pi_{p}^{(n)}(x) \leq\left(\sup _{w \neq u} \sum_{t, z} \psi_{n}(w, u, t, z, x)\right) \sum_{w, u} \Psi^{(n-1)}(w, u) .

Since we do not sum over $x$, we bound the factors depending on $x$ by 1 , and so

implies the claim together with Proposition 3.5.

### 3.3 Displacement bounds

The aim of this section is to give bounds on $p \sum_{x}[1-\cos (k \cdot x)] \Pi_{p}^{(n)}(x)$. Such bounds are important in the analysis in Section 4. We regard $[1-\cos (k \cdot x)]$ as a "displacement factor". To state the main results, Propositions 3.13 and 3.14 , we introduce some displacement quantities:

Definition 3.12 (Diagrammatic displacement quantities). Let $x \in \mathbb{Z}^{d}$ and $k \in(-\pi, \pi]^{d}$. Define

W_{p}(x ; k) & :=p\left(\tau_{p, k} * \tau_{p}^{\circ}\right)(x), \quad W_{p}(k)=\max _{x \in \mathbb{Z}^{d}} W_{p}(x ; k), \\
H_{p}\left(b_{1}, b_{2} ; k\right) & :=p^{5} \sum_{t, w, z, u, v} \tau_{p}(z) \tau_{p}(t-u) \tau_{p}(t-z) \tau_{p, k}(u-z) \tau_{p}(t-w) \tau_{p}\left(w-b_{1}\right) \tau_{p}(v-w) \tau_{p}\left(v+b_{2}-u\right), \\
H_{p}(k) & :=\max _{b_{1} \neq \mathbf{0} \neq b_{2} \in \mathbb{Z}^{d}} H_{p}\left(b_{1}, b_{2} ; k\right) .
\end{aligned}
$$

Note that Proposition 3.2 already provides displacement bounds for $n=0$. The following two results give bounds for $n \geq 1$ :

Proposition 3.13 (Displacement bounds for $n \geq 2$ ). For $n \geq 2$ and $x \in \mathbb{Z}^{d}$,

p \sum_{x}[1-\cos (k \cdot x)] \Pi_{p}^{(n)}(x) \leq 11(n+1)\left(T_{p}\right)^{1 \vee(n-2)}\left(\triangle_{p}^{\bullet \bullet \circ}\right)^{3} W_{p}(k)\left[1+\triangle_{p}^{\circ}+T_{p}+\frac{H_{p}(k)}{W_{p}(k)}\right]
$$

Proposition 3.14 (Displacement bounds for $n=1$ ). For $x \in \mathbb{Z}^{d}$,

$$
p \sum_{x}[1-\cos (k \cdot x)] \Pi_{p}^{(1)}(x) \leq 9 W_{p}(k)\left[\triangle_{p}^{\bullet}(\mathbf{0})\left(\triangle_{p}^{\bullet \circ}+\triangle_{p}\right)+\triangle_{p}^{\circ}+\triangle_{p}\right]+p^{2}\left(J * \tau_{p, k} * \tau_{p}\right)(\mathbf{0}) .
$$

In preparation for the proofs, we define a function $\bar{\Psi}^{(n)}$, similar to $\Psi^{(n)}$, and prove an almost identical bound to the one in Proposition 3.5. Let $\bar{\Psi}^{(0)}(t, z)=\phi_{n}(\mathbf{0}, t, z, \mathbf{0}) / \tau_{p}^{\bullet}(t)$. For $i \geq 1$, define

Note that in $\phi^{(2)}$, the points $t$ and $w$ swap roles, so that in both $\phi^{(1)}$ and $\phi^{(2)}, u$ is adjacent to $t^{\prime}$ and $t$ is the point adjacent to $\mathbf{0}$; and in particular, the factor $\tau_{\dot{p}}^{\bullet}(t)$ cancels out. The following lemma, in combination with Lemma 3.10, is analogous to the bound (3.5), and so is its proof, which is omitted.

To this end, we write $x=\sum_{i=0}^{n} d_{i}$, where $d_{i}=w_{i}-u_{i-1}$ for even $i$ and $d_{i}=u_{i}-w_{i-1}$ for odd $i$ (with the convention $u_{-1}=\mathbf{0}$ and $w_{n}=u_{n}=x$ ). Over the course of this proof, we drop the subscript $i$ and are then confronted with a displacement $d=d_{i}$ (which is not to be confused with the dimension).

Using the Cosine-split lemma 3.1, we obtain

If $t, z, x$ are distinct points, then for $d=x$, the maximum in (3.11) becomes

It remains to bound the sum over $\tilde{\phi}$. We first handle the term due to $\phi^{(1)}$, and we call it $\tilde{\phi}^{(1)}$. Depending on the orientation of the diagram (i.e., the parity of $i$ ), the displacement $d=d_{i}$ is either $d=w-a=(w-t)+(t-a)$ or $d=u=(u-z)+z$. We perform the bound for $d=u$ and use the Cosine-split lemma 3.1 once, so that we now have a displacement on an actual edge. In pictorial bounds, abbreviating $\vec{v}=(\mathbf{0}, a, t, w, z, u, b+x, x ; k, u)$, this yields

## 4 Bootstrap analysis

### 4.1 Introduction of the bootstrap functions

This section brings the previous results together to prove Proposition 4.2 from which Theorem 1.1 follows with little extra effort. The remaining strategy of proof is standard and described in detail in [18. In short, it is the following: We introduce the bootstrap function $f$ in 4.1). In Section 4.2, and in particular in Proposition 4.2, we prove several bounds in terms of $f$, including bounds uniform in $p \in\left[0, p_{c}\right.$ ) under the additional assumption that $f$ is uniformly bounded.

In Section 4.3, we show that $f(0) \leq 3$ and that $f$ is continuous on $\left[0, p_{c}\right)$. Lastly, we show that on $\left[0, p_{c}\right.$ ), the bound $f \leq 4$ implies $f \leq 3$. This is called the improvement of the bounds, and it is shown by employing the implications from Section 4.2 As a consequence of this, the results from Section 4.2 indeed hold uniformly in $p \in\left[0, p_{c}\right.$ ), and we may extend them to $p_{c}$ by a limiting argument.

Let us recall the notation $\tau_{p, k}(x)=[1-\cos (k \cdot x)] \tau_{p}(x), J_{k}(x)=[1-\cos (k \cdot x)] J(x)$. We extend this to $D_{k}(x)=[1-\cos (k \cdot x)] D(x)$. We note that $\chi(p)$ was defined as $\chi(p)=\mathbb{E}[\mathscr{C}(\mathbf{0}) \mid]$ and that $\chi(p)=1+p \sum_{x \in \mathbb{Z}^{d}} \tau_{p}(x)$. We define

We define the bootstrap function $f=f_{1} \vee f_{2} \vee f_{3}$ with

\begin{equation*}
f_{1}(p)=2 d p, \quad f_{2}(p)=\sup _{k \in(-\pi, \pi]^{d}} \frac{p\left|\widehat{\tau}_{p}(k)\right|}{\widehat{G}_{\lambda_{p}}(k)}, \quad f_{3}(p)=\sup _{k, l \in(-\pi, \pi]^{d}} \frac{p\left|\widehat{\tau}_{p, k}(l)\right|}{\widehat{U}_{\lambda_{p}}(k, l)}, \tag{4.1}
\end{equation*}
$$

where $\widehat{U}_{\lambda_{p}}$ is defined as

$$
\widehat{U}_{\lambda_{p}}(k, l):=3000[1-\widehat{D}(k)]\left(\widehat{G}_{\lambda}(l-k) \widehat{G}_{\lambda}(l)+\widehat{G}_{\lambda}(l) \widehat{G}_{\lambda}(l+k)+\widehat{G}_{\lambda}(l-k) \widehat{G}_{\lambda}(l+k)\right) .
$$

We note that $\widehat{\tau}_{p, k}$ relates to $\Delta_{k} \widehat{\tau}_{p}$, the discretized second derivative of $\widehat{\tau}_{p}$, as follows:

\Delta_{k} \widehat{\tau}_{p}(l):=\widehat{\tau}_{p}(l-k)+\widehat{\tau}_{p}(l+k)-2 \widehat{\tau}_{p}(l)=-2 \widehat{\tau}_{p, k}(l) .
$$

The following result bounds the discretized second derivative of the random walk Green's function:

Lemma 4.1 (Bounds on $\Delta_{k},[27]$, Lemma 5.7). Let $a(x)=a(-x)$ for all $x \in \mathbb{Z}^{d}$, set $\widehat{A}(k)=(1-\widehat{a}(k))^{-1}$, and let $k, l \in(-\pi, \pi]^{d}$. Then

$$
\begin{aligned}
\left|\Delta_{k} \widehat{A}(l)\right| \leq(\widehat{a \mid}(0)-\widehat{|a|}(k)) \times( & {[\widehat{A}(l-k)+\widehat{A}(l+k)] \widehat{A}(l) } \\
& +8 \widehat{A}(l-k) \widehat{A}(l+k) \widehat{A}(l)[\widehat{|a|}(0)-\widehat{|a|}(l)])
\end{aligned}
$$

In particular,

$$
\left|\Delta_{k} \widehat{G}_{\lambda}(l)\right| \leq[1-\widehat{D}(k)]\left(\widehat{G}_{\lambda}(l) \widehat{G}_{\lambda}(l-k)+\widehat{G}_{\lambda}(l) \widehat{G}_{\lambda}(l+k)+8 \widehat{G}_{\lambda}(l-k) \widehat{G}_{\lambda}(l+k)\right)
$$

A natural first guess for $f_{3}$ might have been $\sup p\left|\Delta_{k} \widehat{\tau}_{p}(l)\right| /\left|\Delta_{k} \widehat{G}_{\lambda_{p}}(l)\right|$. However, $\Delta_{k} \widehat{G}_{\lambda_{p}}(l)$ may have roots, which makes this guess an inconvenient choice for $f_{3}$. In contrast, $\widehat{U}_{\lambda_{p}}(k, l)>0$ for $k \neq 0$. Hence, the bound in Lemma 4.1 supports the idea that $f_{3}$ is a reasonable definition.

### 4.2 Consequences of the diagrammatic bounds

The main result of this section, and a crucial result in this paper, is Proposition 4.2, Proposition 4.2 proves (in high dimension) the convergence of the lace expansion derived in Proposition 2.9 by giving bounds on the lace-expansion coefficients. Under the additional assumption that $f \leq 4$ on $\left[0, p_{c}\right)$, these bounds are uniform in $p \in\left[0, p_{c}\right)$.
Proposition 4.2 (Convergence of the lace expansion and Ornstein-Zernike equation).

1. Let $n \in \mathbb{N}_{0}$ and $p \in\left[0, p_{c}\right)$. Then there is $d_{0} \geq 6$ and a constant $c_{f}=c(f(p))$ (increasing in $f$ and independent of $d$ ) such that, for all $d>d_{0}$,

$$
\begin{gather*}
\sum_{x \in \mathbb{Z}^{d}} p\left|\Pi_{p, n}(x)\right| \leq c_{f} / d, \quad \sum_{x \in \mathbb{Z}^{d}}[1-\cos (k \cdot x)] p\left|\Pi_{p, n}(x)\right| \leq[1-\widehat{D}(k)] c_{f} / d,  \tag{4.2}\\
\sup _{x \in \mathbb{Z}^{d}} p \sum_{m=0}^{n}\left|\Pi_{p}^{(m)}(x)\right| \leq c_{f} \tag{4.3}
\end{gather*}
$$

and

$$
\begin{equation*}
\sum_{x \in \mathbb{Z}^{d}}\left|R_{p, n}(x)\right| \leq c_{f}\left(c_{f} / d\right)^{n} \widehat{\tau}_{p}(0) \tag{4.4}
\end{equation*}
$$

Consequently, $\Pi_{p}:=\lim _{n \rightarrow \infty} \Pi_{p, n}$ is well defined and $\tau_{p}$ satisfies the Ornstein-Zernike equation (OZE), taking the form

$$
\begin{equation*}
\tau_{p}(x)=J(x)+\Pi_{p}(x)+p\left(\left(J+\Pi_{p}\right) * \tau_{p}\right)(x) \tag{4.5}
\end{equation*}
$$

2. Let $f \leq 4$ on $\left[0, p_{c}\right)$. Then there is a constant $c$ and $d_{0} \geq 6$ such that the bounds (4.2), 4.3), 4.4) hold for all $d>d_{0}$ with $c_{f}$ replaced by $c$ for all $p \in\left[0, p_{c}\right)$. Moreover, the OZE 4.5] holds.
A standard assumption in the lace expansion literature is a bound on $f(p)$ (often $f(p) \leq 4$ as in part 2 of the proposition), and then it is shown that this implies $f(p) \leq 3$. This is part of the so-called bootstrap argument.

We first formulate part 1 of Proposition 4.2 (of which part 2 follows straightforwardly) demonstrating that the bootstrap argument is not necessary to obtain convergence of the lace expansion and thus establish the OZE for a fixed value $p<p_{c}$ provided that the dimension is large enough. However, without uniformity in $p, d_{0}$ might depend on $p$ and diverge as $p \nearrow p_{c}$. Hence, this approach alone does not allow to extend the results to $p_{c}$.

It is at this point that the bootstrap argument (and thus Section 4.3) comes into play. In Section 4.3 , we indeed prove that $f \leq 4$ and so the second part of Proposition 4.2 applies. This is instrumental in proving Theorem 1.1. We get the following corollary:
Corollary 4.3 (OZE at $\left.p_{c}\right)$. There is $d_{0}$ such that for all $d>d_{0}$, the limit $\Pi_{p_{c}}=\lim _{p} \nearrow_{p_{c}} \Pi_{p}$ exists and is given by $\Pi_{p_{c}}=\sum_{n \geq 0}(-1)^{n} \Pi_{p_{c}}^{(n)}$, where $\Pi_{p_{c}}^{(n)}$ is the extension of Definition 2.8 at $p=p_{c}$. Consequently, the bounds in Proposition 4.2 and the OZE 4.5 extend to $p_{c}$.

Proposition 4.2 follows without too much effort as a consequence of Lemmas 4.7, 4.8, 4.9, and 4.10 . Part of the lace expansion's general strategy of proof in the bootstrap analysis is to use the Inverse Fourier Theorem to write

$$
\triangle_{p}(x)=p^{2} \int_{(-\pi, \pi]^{d}} \mathrm{e}^{-\mathrm{i} k \cdot x} \widehat{\tau}_{p}(k)^{3} \frac{\mathrm{~d} k}{(2 \pi)^{d}}
$$

and then to use an assumed bound on $f_{2}$ to replace $\widehat{\tau}_{p}$ by $\widehat{G}_{\lambda_{p}}$. For site percolation, this poses a problem, since we are missing one factor of $p$. Overcoming this issue poses a novelty of Section 4 . The following two observations turn out to be helpful for this:

Observation 4.4 (Convolutions of $J$ ). Let $m \in \mathbb{N}$ and $x \in \mathbb{Z}^{d}$ with $m \geq|x|$. Then there is a constant $c=c(m, x)$ with $c \leq m!$ such that

$$
J^{* m}(x)=c \mathbb{1}_{\{m-|x| \text { is even }\}}(2 d)^{(m-|x|) / 2} .
$$

Proof. This is an elementary matter of counting the number of $m$-step walks from $\mathbf{0}$ to $x$. If $m-|x|$ is odd, then there is no way of getting from $\mathbf{0}$ to $x$ in $m$ steps.

So assume that $m-|x|$ is even. To get from $\mathbf{0}$ to $x,|x|$ steps must be chosen to reach $x$. Only taking these $|x|$ steps (in any order) would amount to a shortest 0 - $x$-path. Out of the remaining steps, half can be chosen freely (each producing a factor of $2 d$ ), and the other half must compensate them. In counting the different walks, we have to respect the at most $m$ ! unique ways of ordering the steps.

We remark that this also shows that the maximum is attained for $x=\mathbf{0}$ when $m$ is even and for $x$ being a neighbor of $\mathbf{0}$ when $m$ is odd.

Observation 4.5 (Elementary bounds on $\left.\tau_{p}^{* n}\right)$. Let $n, m \in \mathbb{N}$. Then there is $c=c(m, n)$ such that, for all $p \in[0,1]$ and $x \in \mathbb{Z}^{d}$,

$$
\tau_{p}^{* n}(x) \leq c \sum_{l=0}^{m-n} p^{l} J^{*(l+n)}(x)+c \sum_{j=1 \vee(n-m)}^{n} p^{m+j-n}\left(J^{* m} * \tau_{p}^{* j}\right)(x)
$$

where we use the convention that $\sum_{l=0}^{m-n}$ vanishes for $n>m$.
Proof. The observation heavily relies on the bound

$$
\begin{equation*}
\tau_{p}(x) \leq J(x)+\mathbb{E}\left[\sum_{y \in \omega} \mathbb{1}_{\{|y|=1, y \longleftrightarrow x\}}\right]=J(x)+p\left(J * \tau_{p}\right)(x) . \tag{4.6}
\end{equation*}
$$

Note that the left-hand side equals 0 when $x=\mathbf{0}$. We prove the statement by induction on $m-n$; for the base case, let $m \leq n$. Then we apply (4.6) to $m$ of the $n$ convoluted $\tau_{p}$ terms to obtain

$$
\begin{aligned}
\tau_{p}^{* n}(x) & \leq\left(\tau_{p}^{*(n-m)} *\left(J+p\left(J * \tau_{p}\right)\right)^{* m}\right)(x) \\
& =\sum_{l=0}^{m}\binom{m}{l} p^{l}\left(J^{* m} * \tau_{p}^{*(n-m+l)}\right)(x)=\sum_{l=n-m}^{n}\binom{m}{l+m-n} p^{l+m-n}\left(J^{* m} * \tau_{p}^{* l}\right)(x) .
\end{aligned}
$$

Let now $m-n>0$. Applying (4.6) once yields a sum of two terms, namely

$$
\begin{equation*}
\tau_{p}^{* n}(x) \leq\left(J * \tau_{p}^{*(n-1)}\right)(x)+p\left(J * \tau_{p}^{* n}\right)(x) \tag{4.7}
\end{equation*}
$$

We can apply the induction hypothesis on the second term with $\tilde{m}=m-1$ and $\tilde{n}=n$, producing terms of the sought-after form. Now, observe that application of 4.6 yields

$$
\begin{equation*}
\left(J^{* j} * \tau_{p}^{*(n-j)}\right)(x) \leq\left(J^{*(j+1)} * \tau_{p}^{*(n-j-1)}\right)(x)+p\left(J^{*(j+1)} * \tau_{p}^{*(n-j)}\right)(x) \tag{4.8}
\end{equation*}
$$

for $1 \leq j<n$. For every $j$, the second term can be bounded by the induction hypothesis for $\tilde{m}=m-j-1$ and $\tilde{n}=n-j$ (so that $\tilde{m}-\tilde{n}<m-n$ ) with suitable $c(m, n)$. Hence, we can iteratively break down 4.7); after applying 4.8) for $j=n-1$, we are left with the term $J^{* n}(x)$, finishing the proof.

We now define

$$
V_{p}^{(m, n)}(a):=\left(J^{* m} * \tau_{p}^{* n}\right)(a), \quad W_{p}^{(m, n)}(a ; k):=\left(\tau_{p, k} * V_{p}^{(m, n)}\right)(a), \quad \widetilde{W}_{p}^{(m, n)}(a ; k):=\left(J_{k} * V_{p}^{(m, n)}\right)(a)
$$

Note that $W_{p}$ from Definition 3.12 relates to the above definition via $W_{p}=p W_{p}^{(0,0)}+p W_{p}^{(0,1)}$. Moreover, $\triangle_{p}(x)=p^{2} V^{(0,3)}(x)$.

Lemma 4.6 (Bounds on $\left.V_{p}^{(m, n)}, W_{p}^{(m, n)}, \widetilde{W}_{p}^{(m, n)}\right)$. Let $p \in\left[0, p_{c}\right)$ and $m, n \in \mathbb{N}_{0}$ with $d>\frac{20}{9} n$. Then there is a constant $c_{f}=c(m, n, f(p))$ (increasing in $f$ ) such that the following hold true:

1. For $m+n \geq 2$,

$$
p^{m+n-1} V_{p}^{(m, n)}(a) \leq \begin{cases}c_{f} & \text { if } m+n=2 \text { and } a=\mathbf{0} \\ c_{f} / d & \text { else }\end{cases}
$$

2. For $m+n \geq 1$, and under the additional assumption $d>2 n+4$ for the bound on $W_{p}^{(m, n)}$,

$$
p^{m+n} \max \left\{\sup _{a \in \mathbb{Z}^{d}} \widetilde{W}_{p}^{(m, n)}(a ; k), \sup _{a \in \mathbb{Z}^{d}} W_{p}^{(m, n)}(a ; k)\right\} \leq[1-\widehat{D}(k)] \times \begin{cases}c_{f} & \text { if } m+n \leq 2, \\ c_{f} / d & \text { if } m+n \geq 3\end{cases}
$$

We apply Lemma 4.6 for $n \leq 3$, and so $d \geq 7>60 / 9$ for the dimension suffices.
Proof. Bound on $V_{p}$. We start with the case $m \geq 4$ where we can rewrite the left-hand side via Fourier transform and apply Hölder's inequality to obtain

$$
\begin{align*}
p^{m+j-1}\left(J^{* m} * \tau_{p}^{* j}\right)(a) & =p^{m+j-1} \int_{(-\pi, \pi]^{d}} \mathrm{e}^{-\mathrm{i} k \cdot a} \widehat{J}(k)^{m} \widehat{\tau}_{p}(k)^{j} \frac{\mathrm{~d} k}{(2 \pi)^{d}} \\
& \leq\left(p^{10(m-1)} \int_{(-\pi, \pi]^{d}} \widehat{J}(k)^{10 m} \frac{\mathrm{~d} k}{(2 \pi)^{d}}\right)^{1 / 10}\left(\int_{(-\pi, \pi]^{d}}\left(p\left|\widehat{\tau}_{p}(k)\right|\right)^{10 j / 9} \frac{\mathrm{~d} k}{(2 \pi)^{d}}\right)^{9 / 10} \\
& \leq\left(p^{10(m-1)} J^{* 10 m}(\mathbf{0})\right)^{1 / 10} \times f_{2}(p)^{j}\left(\int_{(-\pi, \pi]^{d}} \widehat{G}_{\lambda_{p}}(k)^{10 j / 9} \frac{\mathrm{~d} k}{(2 \pi)^{d}}\right)^{9 / 10} \tag{4.9}
\end{align*}
$$

We note that the number 10 in the exponent holds no special meaning other than that it is large enough to make the following arguments work. The first factor in (4.9) is handled by Observation 4.4 as

$$
\begin{aligned}
\left(p^{10(m-1)} J^{* 10 m}(\mathbf{0})\right)^{1 / 10} & \leq\left(c p^{10(m-1)}(2 d)^{5 m}\right)^{1 / 10} \leq\left(c(2 d p)^{10(m-1)}(2 d)^{-5 m+10}\right)^{1 / 10} \\
& \leq c f_{1}(p)^{m-1}(2 d)^{-m / 2+1} \leq c_{f} / d
\end{aligned}
$$

and $m \geq 4$. Regarding the second factor in 4.9, note that $10 j / 9 \leq 10 n / 9<d / 2$ and so Proposition 2.1 gives a uniform upper bound. We remark that the exponent 10 in 4.9 is convenient because it is even and allows us to apply Lemma 4.6 in dimension $d \geq 7$.

If $m<4$, then we first use Observation 4.5 with $\tilde{m}=4-m$ to get that $p^{m+n-1} V_{p}^{(m, n)}$ is bounded by a sum of terms of two types, which are constant multiples of

$$
\begin{equation*}
p^{l+m+n-1} J^{*(l+m+n)}(a)=p^{s-1} J^{* s}(a) \quad \text { and } \quad p^{4+j-1}\left(J^{* 4} * \tau_{p}^{* j}\right)(a), \tag{4.10}
\end{equation*}
$$

where $0 \leq l \leq 4-m-1$ (and therefore $s \geq 2$ ) and $1 \leq j \leq n$. If $s$ is odd, we can write $s=2 r+1$ for some $r \geq 1$, and Observation 4.4 gives

$$
p^{2 r} J^{*(2 r+1)}(a) \leq c p^{2 r}(2 d)^{r}=c(2 d p)^{2 r}(2 d)^{-r} \leq c\left(f_{1}(p)\right)^{2 r}(2 d)^{-r} \leq c_{f} / d .
$$

Similarly, if $s$ is even and $a \neq \mathbf{0}$ or $s \geq 4$, then $p^{s-1} J^{* s}(a) \leq c_{f} / d$. Finally, if $s=2$ and $a=\mathbf{0}$, then $p(J * J)(\mathbf{0}) \leq c_{f}$. This shows that the terms of the first type in 4.10) are of the correct order. The second type is of the form $p^{4+j-1} V_{p}^{(4, j)}(a)$ and included in the previous considerations. Together this proves the claimed bound on $V_{p}^{(m, n)}$.

Bound on $\widetilde{W}_{p}$. Let first $m+n \geq 3$. Then

$$
\begin{aligned}
p^{m+n} \widetilde{W}_{p}^{(m, n)}(a ; k) & =p^{m+n} \sum_{y \in \mathbb{Z}^{d}} J_{k}(y) V_{p}^{(m, n)}(a-y) \\
& \leq p^{m+n-1}\left(\sup _{a \in \mathbb{Z}^{d}} V_{p}^{(m, n)}(a)\right)(2 d p) \sum_{y \in \mathbb{Z}^{d}}[1-\cos (k \cdot y)] D(y) \\
& \leq c_{f} / d \times f_{1}(p)[1-\widehat{D}(k)],
\end{aligned}
$$

applying the bound on $V_{p}$.
Consider now $m+n=2$. Using first that $J \leq \tau_{p}$ and then 4.6),

$$
\begin{equation*}
p^{2} \widetilde{W}_{p}^{(m, n)}(a ; k) \leq p^{2} \widetilde{W}_{p}^{(0,2)}(a ; k) \leq p^{2} \widetilde{W}_{p}^{(2,0)}(a ; k)+p^{3} \widetilde{W}_{p}^{(2,1)}(a ; k)+p^{3} \widetilde{W}_{p}^{(1,2)}(a ; k) \tag{4.11}
\end{equation*}
$$

The second and third summand right-hand side of 4.11) can be dealt with as before, we only have to deal with the first summand. Indeed,

$$
p^{2} \widetilde{W}_{p}^{(2,0)}(a ; k)=p^{2} \sum_{y} J_{k}(y) J^{* 2}(a-y) \leq 2 d p^{2} J^{* 2}(\mathbf{0}) \sum_{y} D_{k}(y)=f_{1}(p)^{2}[1-\widehat{D}(k)],
$$

and we can choose $c_{f}=f_{1}(p)^{2}$.
Finally, for $m+n=1$, we have $p \widetilde{W}_{p}^{(m, n)}(a ; k) \leq p \widetilde{W}_{p}^{(1,0)}(a ; k)+p^{2} \widetilde{W}_{p}^{(1,1)}(a ; k)$. The second term was already bounded, the first is

$$
p\left(J_{k} * J\right)(a) \leq p \sum_{y} J_{k}(y)=f_{1}(p)[1-\widehat{D}(k)] .
$$

Bound on $W_{p}$. We note that a combination of 4.6 and the Cosine-split lemma 3.1 yields

$$
\begin{equation*}
\tau_{p, k}(x) \leq J_{k}(x)+2 p\left(J_{k} * \tau_{p}\right)(x)+2 p\left(J * \tau_{p, k}\right)(x) \tag{4.12}
\end{equation*}
$$

Applying this repeatedly, we can bound $p^{m+n} W_{p}^{(m, n)}(a ; k)$ by a sum of quantities of the form $p^{s+t} \widetilde{W}_{p}^{(s, t)}$ (where $s+t \geq 1$ ) plus $c(m, n) p^{m+n} W_{p}^{(m, n)}$, where we can now assume $m \geq 4$ w.l.o.g. The terms of the form $\widetilde{W}_{p}^{(s, t)}$ were bounded above already. Similarly to how we obtained the bound $\sqrt{4.9}$ ), we bound the last term by applying Hölder's inequality, and so

$$
\begin{align*}
p^{m+n} W_{p}^{(m, n)} & (a ; k) \leq p^{m+n} \int_{(-\pi, \pi]^{d}}|\widehat{J}(l)|^{m}\left|\widehat{\tau}_{p}(l)\right|^{n}\left|\widehat{\tau}_{p, k}(l)\right| \frac{\mathrm{d} l}{(2 \pi)^{d}} \\
& \leq\left(p^{10(m-1)} \int_{(-\pi, \pi]^{d}} \widehat{J}(l)^{10 m} \frac{\mathrm{~d} l}{(2 \pi)^{d}}\right)^{1 / 10}\left(\int_{(-\pi, \pi]^{d}}\left(p\left|\widehat{\tau}_{p}(l)\right|\right)^{10 n / 9}\left(p\left|\widehat{\tau}_{p, k}(l)\right|\right)^{10 / 9} \frac{\mathrm{~d} l}{(2 \pi)^{d}}\right)^{9 / 10} \\
\leq & c_{f} / d \times 3000 f(p)^{n+1}\left(\int _ { ( - \pi , \pi ] ^ { d } } \widehat { G } _ { \lambda _ { p } } ( l ) ^ { 1 0 n / 9 } \left[\widehat{G}_{\lambda_{p}}(l)\left(\widehat{G}_{\lambda_{p}}(l-k)+\widehat{G}_{\lambda_{p}}(l+k)\right)\right.\right. \\
& \left.\left.\quad+\widehat{G}_{\lambda_{p}}(l-k) \widehat{G}_{\lambda_{p}}(l+k)\right]^{10 / 9} \frac{\mathrm{~d} l}{(2 \pi)^{d}}\right)^{9 / 10}
\end{align*}
$$

where the last bound is due to Proposition 2.2 and the value of $c_{f}$ has changed in the last line.
The proofs of the following lemmas, bounding the quantities appearing in Section 3 are direct consequences of Lemma 4.6 .

Lemma 4.7 (Bounds on various triangles). Let $p \in\left[0, p_{c}\right)$ and $d>6$. Then there is $c_{f}=c(f(p))$ (increasing in $f$ ) such that

\max \left\{\triangle_{p}, \triangle_{p}^{\circ}, \triangle_{p}^{\bullet}, \triangle_{p}^{\bullet \circ}\right\} \leq c_{f} / d, \quad \max \left\{\triangle_{p}^{\bullet}(\mathbf{0}), \triangle_{p}^{\bullet \circ}(\mathbf{0}), \triangle_{p}^{\bullet \bullet \circ}\right\} \leq c_{f}
$$

Proof. Note that

$$
\begin{gathered}
\triangle_{p}(x)=p^{2} V_{p}^{(0,3)}(x), \quad \triangle_{p}^{\circ}(x)=p^{2} V_{p}^{(0,2)}(x)+\triangle_{p}(x), \quad \triangle_{p}^{\bullet}(x)=p V_{p}^{(0,2)}(x)+\triangle_{p}(x), \\
\triangle_{p}^{\bullet \circ}(x)=p \tau_{p}(x)+\triangle_{p}^{\bullet}(x), \quad \triangle_{p}^{\bullet \bullet 0}(x)=\delta_{\mathbf{0}, x}+\triangle_{p}^{\bullet \circ}(x) .

For the bound on $p \tau_{p} \leq p$, we use that $p \leq f_{1}(p) / d$. For all remaining quantities, we use Lemma 4.6. which is applicable since $n \leq 3$ and $\frac{20}{9} n \leq \frac{60}{9}<7 \leq d$.

Lemma 4.8 (Bound on $W_{p}$ ). Let $p \in\left[0, p_{c}\right)$ and $d>6$. Then there is a constant $c_{f}=c(f(p))$ (increasing in f) such that

by the previous Lemmas 4.6.4.8. We can thus focus on bounding

The square brackets indicate how we want to decompose the integrals. We first bound (4.16), and we start with the integral over $l_{3}$. We intend to treat the five summands constituting $\widehat{\sigma}\left(l_{3}-l_{2}\right)$ simultaneously. Indeed, note that with our bound on $f_{2}$,

& \leq c_{f}\left(p^{20\left(-1+\sum_{i=1}^{2}\left(j_{i} \vee 4 n_{i}\right)\right)} \int \widehat{J}\left(l_{2}-l_{1}\right)^{20 \sum_{i=1}^{2}\left(j_{i} \vee 4 n_{i}\right)} \frac{\mathrm{d} l_{2}}{(2 \pi)^{d}}\right)^{1 / 20} \\
& \quad \times\left(p^{20\left(j_{3} \vee 4 n_{3}\right)} \int \widehat{J}\left(l_{2}\right)^{20\left(j_{3} \vee 4 n_{3}\right)} \frac{\mathrm{d} l_{2}}{(2 \pi)^{d}}\right)^{1 / 20} \\

& \leq c_{f} \cdot p^{-1+\sum_{i=1}^{3}\left(j_{i} \vee 4 n_{i}\right)}\left(J^{* 10\left(1+\sum_{i=1}^{3} j_{i} \vee 4 n_{i}\right)}(\mathbf{0})\right)^{1 / 10} \\
& \leq c_{f}^{\prime} \cdot p^{-1+\sum_{i=1}^{3}\left(j_{i} \vee 4 n_{i}\right)}(2 d)^{\frac{1}{2}\left(1+\sum_{i=1}^{3} j_{i} \vee 4 n_{i}\right)} \leq c_{f}^{\prime \prime} .

This proves that 4.16 is bounded by $\left(c_{f} / d\right)^{1 / 2}$. Note that 4.17 ) is very similar to 4.16 , and the same bounds can be applied to get a bound of $\left(c_{f} / d\right)^{1 / 2}$. Since the other two terms in 4.15) are handled analogously, we obtain the bound $\widetilde{H}_{p}\left(b_{1}, b_{2} ; k\right) \leq[1-\widehat{D}(k)] c_{f} / d$, which is what was claimed.

Proof of Proposition 4.2. Recalling the bounds on $\left|\Pi_{p}^{(m)}(k)\right|$ obtained in Propositions 3.2 and 3.5, and the bounds on $\left|\Pi_{p}^{(m)}(k)-\Pi_{p}^{(m)}(0)\right|$ obtained in Propositions $3.2,3.14$, and 3.13 , we can combine them with the bounds just obtained in Lemmas 4.7, 4.8, 4.9, and 4.10. This gives

Summing the above terms over $m$, we recognize the geometric series in their bounds. The series converges for sufficiently large $d$. If $f \leq 4$ on $\left[0, p_{c}\right)$, we can replace $c_{f}$ by $c=c_{4}$ in the above, so that the bounds are uniform in $p \in\left[0, p_{c}\right.$ ), which means that the value of $d$ above which the series converges is independent of $p$. Hence,

The existence of the limit $\Pi_{p}$ follows by dominated convergence with the bound (4.3). Together with 4.20, this implies that the lace expansion identity in Proposition 2.9 converges as $n \rightarrow \infty$ and satisfies the OZE.

Corollary 4.3 as well as the main theorem now follow from Proposition 4.2 in conjunction with Proposition 4.12, which is proven in Section 4.3 below.

Proof of Corollary 4.3 and Theorem 1.1. Proposition 4.12 implies that indeed $f(p) \leq 3$ for all $p \in\left[0, p_{c}\right)$, and therefore, the consequences in the second part of Proposition 4.2 are valid. Lemma 4.7 together with Fatou's lemma and pointwise convergence of $\tau_{p}(x)$ to $\tau_{p_{c}}(x)$ then implies the triangle condition.

The remaining arguments are analogous to the proofs of [19, Corollary 6.1] and [19, Theorem 1.1]. The rough idea for the proof of Corollary 4.3 is to use $\theta\left(p_{c}\right)=0$ (which follows from the triangle condition) to couple the model at $p_{c}$ with the model at $p<p_{c}$, and then show that, as $p \nearrow p_{c}$, the (a.s.) finite cluster of the origin is eventually the same. For the full argument and the proof of the infra-red bound, we refer to [19].

### 4.3 Completing the bootstrap argument

It remains to prove that $f \leq 4$ on $\left[0, p_{c}\right)$ so that we can apply the second part of Proposition 4.2. This is achieved by Proposition 4.12, where three claims are made: First, $f(0) \leq 4$, secondly, $f$ is continuous in the subcritical regime, and thirdly, $f$ does not take values in $(3,4]$ on $\left[0, p_{c}\right)$. This implies the desired boundedness of $f$. The following observation will be needed to prove the third part of Proposition 4.12,

Observation 4.11. Suppose $a(x)=a(-x)$ for all $x \in \mathbb{Z}^{d}$. Then

\end{aligned}
$$

The consequence about $\widehat{D}$ now follows from $D(x) \geq 0$ for all $x$. Moreover, the statement for $\Delta_{k} p \widehat{\Pi}_{p}(l)$ follows applying the observation to $a=\Pi_{p}$ together with the bounds in 4.2).

Proposition 4.12. The following are true:

1. The function $f$ satisfies $f(0) \leq 3$.
2. The function $f$ is continuous on $\left[0, p_{c}\right)$.
3. Let $d$ be sufficiently large; then assuming $f(p) \leq 4$ implies $f(p) \leq 3$ for all $p \in\left[0, p_{c}\right)$.

Consequently, there is some $d_{0}$ such that $f(p) \leq 3$ uniformly for all $p \in\left[0, p_{c}\right)$ and $d>d_{0}$.
As a remark, in the third step of Proposition 4.12, we prove the stronger statement $f_{i}(p) \leq 1+$ const $/ d$ for $i \in\{1,2\}$. In the remainder of the paper, we prove this proposition and thereby finish the proof the main theorem. We prove each of the three assertions separately.

1. Bounds on $f(0)$. This one is straightforward. As $f_{1}(p)=2 d p$, we have $f_{1}(0)=0$.

Further, recall that $\lambda_{p}=1-1 / \chi(p)$, and so $\lambda_{0}=0$ and $\widehat{G}_{\lambda_{0}}(k)=\widehat{G}_{0}(k)=1$ for all $k \in(-\pi, \pi]^{d}$. Since both $p\left|\widehat{\tau}_{p}(k)\right|$ and $p\left|\widehat{\tau}_{p, k}(l)\right|$ equal 0 at $p=0$, recalling the definitions of $f_{2}$ and $f_{3}$ in 4.1), we conclude that $f_{2}(0)=f_{3}(0)=0$. In summary, $f(0)=0$.
2. Continuity of $f$. The continuity of $f_{1}$ is obvious. For the continuity of $f_{2}$ and $f_{3}$, we proceed as in [18], that is, we prove continuity on $\left[0, p_{c}-\varepsilon\right]$ for every $0<\varepsilon<p_{c}$. This again is done by taking derivatives and bounding them uniformly in $k$ and in $p \in\left[0, p_{c}-\varepsilon\right]$. To this end, we calculate

$$
\begin{equation*}
\frac{\mathrm{d}}{\mathrm{~d} p} \frac{\widehat{\tau}_{p}(k)}{\widehat{G}_{\lambda_{p}}(k)}=\frac{1}{\widehat{G}_{\lambda_{p}}(k)^{2}}\left[\widehat{G}_{\lambda_{p}}(k) \frac{\mathrm{d} \widehat{\tau}_{p}(k)}{\mathrm{d} p}-\left.\widehat{\tau}_{p}(k) \frac{\mathrm{d} \widehat{G}_{\lambda}(k)}{\mathrm{d} \lambda}\right|_{\lambda=\lambda_{p}} \frac{\mathrm{~d} \lambda_{p}}{\mathrm{~d} p}\right] . \tag{4.21}
\end{equation*}
$$

Since $\lambda_{p}=1-1 / \chi(p)$,

$$
\begin{equation*}
\frac{1}{2} \leq \frac{1}{1-\lambda_{p} \widehat{D}(k)}=\widehat{G}_{\lambda_{p}}(k) \leq \widehat{G}_{\lambda_{p}}(0)=\chi(p) \leq \chi\left(p_{c}-\varepsilon\right) \tag{4.22}
\end{equation*}
$$

Further, since $\widehat{\tau}_{p}(0)$ is non-decreasing,

$$
\begin{equation*}
\widehat{\tau}_{p}(k) \leq \widehat{\tau}_{p}(0) \leq \widehat{\tau}_{p_{c}-\varepsilon}(0)=\frac{\chi\left(p_{c}-\varepsilon\right)-1}{p_{c}-\varepsilon} . \tag{4.23}
\end{equation*}
$$

We use Observation 2.3 to obtain

$$
\left|\frac{\mathrm{d}}{\mathrm{~d} p} \widehat{\tau}_{p}(k)\right|=\left|\sum_{x \in \mathbb{Z}^{d}} \mathrm{e}^{\mathrm{i} k \cdot x} \frac{\mathrm{~d}}{\mathrm{~d} p} \tau_{p}(k)\right| \leq \sum_{x \in \mathbb{Z}^{d}} \frac{\mathrm{~d}}{\mathrm{~d} p} \tau_{p}(x)=\frac{\mathrm{d}}{\mathrm{~d} p} \sum_{x \in \mathbb{Z}^{d}} \tau_{p}(x) \leq \widehat{\tau}_{p}(0)^{2}
$$

and the same bound as in (4.23) applies. The interchange of sum and derivative is justified as both sums are absolutely summable. Note that $\mathrm{d} \widehat{G}_{\lambda}(k) / \mathrm{d} \lambda=\widehat{D}(k) \widehat{G}_{\lambda}(k)^{2}$, and this is bounded by $\chi\left(p_{c}-\varepsilon\right)^{2}$ for $\lambda=\lambda_{p}$ by 4.22 . Finally, by Observation 2.3 .

$$
\frac{\mathrm{d} \lambda_{p}}{\mathrm{~d} p}=\frac{\frac{\mathrm{d}}{\mathrm{~d} p} \chi(p)}{\chi(p)^{2}} \leq \widehat{\tau}_{p}(0)
$$

which is bounded by 4.23 again. In conclusion, all terms in 4.21) are bounded uniformly in $k$ and $p$, which proves the continuity of $f_{2}$. We can treat $f_{3}$ in the exact same manner, as it is composed of terms of the same type as the ones we just bounded.
3. The forbidden region $(3,4]$. Note that we assume $f(p) \leq 4$ in the following, and so the second part of Proposition 4.2 applies with $c=c_{4}$.

Improvement of $f_{1}$. Recalling the definition of $\lambda_{p} \in[0,1]$, this implies

$$
f_{1}(p)=\lambda_{p}-p \widehat{\Pi}_{p}(0) \leq 1+c_{4} / d
$$

Improvement of $f_{2}$. We introduce $a=p\left(J+\Pi_{p}\right)$, and moreover

$$
\widehat{N}(k)=\frac{\widehat{a}(k)}{1+p \widehat{\Pi}_{p}(0)}, \quad \widehat{F}(k)=\frac{1-\widehat{a}(k)}{1+p \widehat{\Pi}_{p}(0)}
$$

By adapting the analogous argument from [19, proof of Theorem 1.1], we can show that $1-\widehat{a}(k)>0$. Therefore, under the assumption that $f(p) \leq 4$, we have $p \widehat{\tau}_{p}(k)=\widehat{N}(k) / \widehat{F}(k)=\widehat{a}(k) /(1-\widehat{a}(k))$, and furthermore $\lambda_{p}=\widehat{a}(0)$. In the following lines, $M$ and $M^{\prime}$ denote constants (typically multiples of $c_{4}$ ) whose value may change from line to line. An important observation is that

$$
\frac{1}{1+p \widehat{\Pi}_{p}(0)} \leq 1+M / d, \quad|\widehat{a}(k)| \leq 1+M / d, \quad\left|p \widehat{\Pi}_{p}(k)\right| \leq M / d
$$

We are now ready to treat $f_{2}$. Since $|\widehat{N}(k)| \leq 1+M / d$ and by the triangle inequality,

$$
\begin{align*}
\left|\frac{p \widehat{\tau}_{p}(k)}{\widehat{G}_{\lambda_{p}}(k)}\right| & =\left|\widehat{N}(k)+p \widehat{\tau}_{p}(k)\left[1-\lambda_{p} \widehat{D}(k)-\widehat{F}(k)\right]\right| \\
& \leq 1+M / d+\left|p \widehat{\tau}_{p}(k)\right|\left|1-\lambda_{p} \widehat{D}(k)-\widehat{F}(k)\right| . \tag{4.24}
\end{align*}
$$

Also,

$$
\begin{align*}
\left|1-\lambda_{p} \widehat{D}(k)-\widehat{F}(k)\right| & =\left|\frac{1+p \widehat{\Pi}_{p}(0)-\left(2 d p+p \widehat{\Pi}_{p}(0)\right)\left(1+p \widehat{\Pi}_{p}(0)\right) \widehat{D}(k)-1+2 d p \widehat{D}(k)+p \widehat{\Pi}_{p}(k)}{1+p \widehat{\Pi}_{p}(0)}\right| \\
& =\left|\frac{[1-\widehat{D}(k)] p \widehat{\Pi}_{p}(0)}{1+p \widehat{\Pi}_{p}(0)}\right|+\left|\frac{\widehat{a}(0) p \widehat{\Pi}_{p}(0) \widehat{D}(k)+p \widehat{\Pi}_{p}(k)}{1+p \widehat{\Pi}_{p}(0)}\right| \tag{4.25}
\end{align*}
$$

The first term in the right-hand side of 4.25 is bounded by $[1-\widehat{D}(k)] M / d$. In the second term, recalling that $\widehat{a}(0)=\lambda_{p}$, we add and subtract $p \overparen{\Pi}_{p}(0)$ in the numerator, and so

$$
\begin{aligned}
\left|1-\lambda_{p} \widehat{D}(k)-\widehat{F}(k)\right| & \leq[1-\widehat{D}(k)] M / d+\left|\frac{\left[1-\lambda_{p} \widehat{D}(k)\right] p \widehat{\Pi}_{p}(0)+p\left(\widehat{\Pi}_{p}(k)-\widehat{\Pi}_{p}(0)\right)}{1+p \widehat{\Pi}_{p}(0)}\right| \\
& \leq[1-\widehat{D}(k)] M^{\prime} / d+\left[1-\lambda_{p} \widehat{D}(k)\right] M^{\prime} / d \leq 3\left[1-\lambda_{p} \widehat{D}(k)\right] M^{\prime} / d
\end{aligned}
$$

for some constant $M^{\prime}$. In the second to last bound, we have used that $p \widehat{\Pi}_{p}(0)-p \widehat{\Pi}_{p}(k) \leq[1-\widehat{D}(k)] M / d$. For the last, we have used that $1-\widehat{D}(k) \leq 2\left(1-\lambda_{p} \widehat{D}(k)\right)=2 \widehat{G}_{\lambda_{p}}(k)^{-1}$. Putting this back into 4.24), we obtain

$$
\left|\frac{p \widehat{\tau}_{p}(k)}{\widehat{G}_{\lambda_{p}}(k)}\right| \leq 1+M / d+3\left|p \widehat{\tau}_{p}(k) / \widehat{G}_{\lambda_{p}}(k)\right| M^{\prime} / d \leq 1+4\left(M \vee M^{\prime}\right) / d
$$

This concludes the improvement on $f_{2}$. Before dealing with $f_{3}$, we make an important observation:
Observation 4.13. Given the improved bounds on $f_{1}$ and $f_{2}$,

$$
\sup _{k \in(-\pi, \pi]^{d}}\left|\frac{1-\lambda_{p} \widehat{D}(k)}{1-\widehat{a}(k)}\right| \leq 3 .
$$

Proof. Consider first those $p$ such that $2 d p \leq 3 / 7$. Then

$$
\left|\frac{1-\lambda_{p} \widehat{D}(k)}{1-\widehat{a}(k)}\right|=\left|\frac{1-2 d p \widehat{D}(k)-p \widehat{\Pi}_{p}(0) \widehat{D}(k)}{1-2 d p \widehat{D}(k)-p \widehat{\Pi}_{p}(k)}\right| \leq \frac{\frac{10}{7}+M / d}{\frac{4}{7}+M / d} \leq\left(1+M^{\prime} / d\right) \frac{5}{2} \leq 3
$$

for $d$ sufficiently large. Next, consider those $k \in(-\pi, \pi]^{d}$ such that $|\widehat{D}(k)| \leq 7 / 8$. Then

$$
\left|\frac{1-\lambda_{p} \widehat{D}(k)}{1-\widehat{a}(k)}\right|=\left|1-\frac{p \widehat{\Pi}_{p}(0) \widehat{D}(k)-p \widehat{\Pi}_{p}(k)}{1-\widehat{a}(k)}\right| \leq 1+\frac{2 M / d}{1-(1+M / d) \frac{7}{8}-M / d} \leq 1+16 M^{\prime} / d
$$

for $d$ sufficiently large. Let now $p$ such that $2 d p>3 / 7$ and $k$ such that $|\widehat{D}(k)|>7 / 8$. We write $1-\lambda_{p} \widehat{D}(k)=\widehat{G}_{\lambda_{p}}(k)^{-1}$ and $1-\widehat{a}(k)=\widehat{\tau}_{p}(k) / \widehat{a}(k)$. Since $2 d p|\widehat{D}(k)| \geq 3 / 8$, we obtain

$$
\begin{aligned}
\left|\frac{1-\lambda_{p} \widehat{D}(k)}{1-\widehat{a}(k)}\right| & \leq \frac{8}{3}\left|\frac{\widehat{\tau}_{p}(k)}{\widehat{G}_{\lambda_{p}}(k)} \cdot \frac{2 d p \widehat{D}(k)}{\widehat{a}(k)}\right| \leq \frac{8}{3}(1+M / d)\left|1-\frac{p \widehat{\Pi}_{p}(k)}{\widehat{a}(k)}\right| \\
& \leq \frac{8}{3}(1+M / d)\left(1+\frac{M / d}{\frac{8}{3}-M / d}\right) \leq 3
\end{aligned}
$$

for $d$ sufficiently large.
$\underline{\text { Improvement of } f_{3} \text {. Elementary calculations give }}$

$$
\Delta_{k} p \widehat{\tau}_{p}(l)=\underbrace{\frac{\Delta_{k} \widehat{a}(l)}{1-\widehat{a}(l)}}_{\text {(I) }}+\sum_{\sigma \in \pm 1} \underbrace{\frac{(\widehat{a}(l+\sigma k)-\widehat{a}(l))^{2}}{(1-\widehat{a}(l))(1-\widehat{a}(l+\sigma k))}}_{\text {(II) }}+\underbrace{\widehat{a}(l) \Delta_{k}\left(\frac{1}{1-\widehat{a}(l)}\right)}_{\text {(III) }} .
$$

We bound each of the three terms (I)-(III) separately. For the first term,

$$
\begin{aligned}
|(\mathrm{I})| & =\left|\Delta_{k} \widehat{a}(l)\right| \cdot\left|\frac{1-\lambda_{p} \widehat{D}(l)}{1-\widehat{a}(l)}\right| \cdot \widehat{G}_{\lambda_{p}}(l) \leq 3 \widehat{G}_{\lambda_{p}}(l)\left|2 d p \Delta_{k} \widehat{D}(l)+\Delta_{k} p \widehat{\Pi}_{p}(l)\right| \\
& \leq(3+M / d)[1-\widehat{D}(k)] \widehat{G}_{\lambda_{p}}(l) \widehat{G}_{\lambda_{p}}(l+k)
\end{aligned}
$$

In the above, we have first used Observation 4.13, then Observation 4.11, and finally the fact that $\widehat{G}_{\lambda_{p}}(l+k) \geq 1 / 2$. Note that if we obtained similar bounds on (II) and (III), we could prove a bound of the form $\left|\Delta_{k} \widehat{\tau}_{p}(l)\right| \leq c \widehat{U}_{\lambda_{p}}(k, l)$ for the right constant $c$ and the improvement of $f_{3}$ would be complete.

To deal with (II), we need a bound on $\widehat{a}(l+\sigma k)-\widehat{a}(l)$ for $\sigma \in\{ \pm 1\}$. As in [18, (8.4.19)-(8.4.21)],

$$
\begin{aligned}
|\widehat{D}(l \pm k)-\widehat{D}(l)| & \leq \sum_{x}(|\sin (k \cdot x)| D(x)+[1-\cos (k \cdot x)] D(x))=1-\widehat{D}(k)+\sum_{x}|\sin (k \cdot x)| D(x) \\
& \leq 1-\widehat{D}(k)+\left(\sum_{x} D(x)\right)^{1 / 2}\left(\sum \sin (k \cdot x)^{2} D(x)\right)^{1 / 2} \\
& \leq 1-\widehat{D}(k)+2\left(\sum[1-\cos (k \cdot x)] D(x)\right)^{1 / 2} \\
& \leq 4[1-\widehat{D}(k)]^{1 / 2}
\end{aligned}
$$

and similarly

$$
\begin{aligned}
p\left|\widehat{\Pi}_{p}(l \pm k)-\widehat{\Pi}_{p}(l)\right| & \leq\left(p \sum_{x}\left|\Pi_{p}(x)\right|\right)^{1 / 2}\left(2 p \sum_{x}[1-\cos (k \cdot x)]\left|\Pi_{p}(x)\right|\right)^{1 / 2}+p \sum_{x}[1-\cos (k \cdot x)]\left|\Pi_{p}(x)\right| \\
& \leq M[1-\widehat{D}(k)]^{1 / 2} / d .
\end{aligned}
$$

Putting this together yields

$$
\begin{equation*}
|\widehat{a}(l \pm k)-\widehat{a}(l)| \leq 2 d p|\widehat{D}(l \pm k)-\widehat{D}(l)|+p\left|\widehat{\Pi}_{p}(l \pm k)-\widehat{\Pi}_{p}(l)\right| \leq(16+M / d)[1-\widehat{D}(k)]^{1 / 2} \tag{4.26}
\end{equation*}
$$

Combining 4.26 with Observation 4.13 yields

$$
\begin{aligned}
(\mathrm{II}) & \leq(16+M / d)^{2}[1-\widehat{D}(k)]\left|\frac{1-\lambda_{p} \widehat{D}(l)}{1-\widehat{a}(l)}\right|\left|\frac{1-\lambda_{p} \widehat{D}(l+\sigma k)}{1-\widehat{a}(l+\sigma k)}\right| \widehat{G}_{\lambda_{p}}(l) \widehat{G}_{\lambda_{p}}(l+\sigma k) \\
& \leq\left(144+M^{\prime} / d\right)[1-\widehat{D}(k)] \widehat{G}_{\lambda_{p}}(l) \widehat{G}_{\lambda_{p}}(l+\sigma k) .
\end{aligned}
$$

To bound (III), we want to use Lemma 4.1. We first provide bounds for the three types of quantities arising in the use of the lemma. First, note that $|\widehat{a}(l)| \leq 4+M / d$. Next, we observe

$$
\widehat{|a|}(0)-\widehat{|a|}(k)=\sum_{x}[1-\cos (k \cdot x)]\left|2 d p D(x)+p \Pi_{p}(x)\right| \leq(4+M / d)[1-\widehat{D}(k)] .
$$

The third ingredient we need is Observation 4.13 . which produces $|1-\widehat{a}(l)|^{-1} \leq 3 \widehat{G}_{\lambda_{p}}(l)$. Putting all this together and applying Lemma 4.1 gives

$$
\begin{aligned}
& \Delta_{k}\left(\frac{1}{1-\widehat{a}(l)}\right) \leq(4+M / d)[1-\widehat{D}(k)]\left(9\left[\widehat{G}_{\lambda_{p}}(l-k)+\widehat{G}_{\lambda_{p}}(l+k)\right] \widehat{G}_{\lambda_{p}}(l)\right. \\
&\left.+216(4+M / d) \widehat{G}_{\lambda_{p}}(l-k) \widehat{G}_{\lambda_{p}}(l+k) \widehat{G}_{\lambda_{p}}(l)[1-\widehat{D}(l)]\right) \\
&\left.\leq\left(6912+M^{\prime} / d\right)[1-\widehat{D}(k)]\left(\widehat{G}_{\lambda_{p}}(l-k)+\widehat{G}_{\lambda_{p}}(l+k)\right] \widehat{G}_{\lambda_{p}}(l)+\widehat{G}_{\lambda_{p}}(l-k) \widehat{G}_{\lambda_{p}}(l+k)\right),
\end{aligned}
$$

noting that $\widehat{G}_{\lambda_{p}}(l)[1-\widehat{D}(l)] \leq 2$. In summary, $(\mathrm{I})+(\mathrm{II})+(\mathrm{III}) \leq 3 \widehat{U}_{\lambda_{p}}(k, l)$, which finishes the improvement on $f_{3}$. This finishes the proof of Proposition 4.12, and therewith also the proof of Theorem 1.1.
