Path-Connected Components of Affine Schemes and Algebraic K-Theory

Abstract

We introduce a functor $\mathfrak{M} : \mathbf{Alg} \times \mathbf{Alg}^{\mathrm{op}} \to \operatorname{pro-Alg}$ constructed from representations of $\operatorname{Hom}_{\mathbf{Alg}}(A, B\otimes ?)$. As applications, the following items are introduced and studied: (i) Analogue of the functor π_0 for algebras and affine schemes. (ii) Cotype of Weibel's concept of strict homotopization. (iii) A homotopy invariant intrinsic singular cohomology theory for affine schemes with cup product. (iv) Some extensions of **Alg** that are enriched over idempotent semigroups. (v) Classifying homotopy pro-algebras for Cortiñas-Thom's KKgroups and Weibel's homotopy K-groups.

1 Introduction

The main objective of this note is to introduce and study a specific bifunctor

 $\mathfrak{M}:\mathbf{Alg}\times\mathbf{Alg}^{\mathrm{op}}\to\mathrm{pro}\text{-}\mathbf{Alg}$

on the category of (noncommutative and nonunital) algebras over any field \mathbb{F} . For any two algebras A and B, the pro-algebra $\mathfrak{M}_{A,B}$ is defined to be the pro-object of **Alg** representing the set-valued functor $\operatorname{Hom}_{\operatorname{Alg}}(A, B\otimes ?)$. We give an explicit construction of $\mathfrak{M}_{A,B}$ associated with each generator-set of A and each vector-space basis of B. It turns out that $\mathfrak{M}_{A,B}$ may be regarded as the algebra of polynomial functions on the noncommutative affine ind-scheme of all morphisms $A \to B$. We consider some variants of \mathfrak{M} related to unital, commutative, and reduced cases. The behavior with respect to product and coproduct, and a specific *exponential law* for the functor \mathfrak{M} are considered. It is also shown that \mathfrak{M} preserves algebraic homotopy. Using \mathfrak{M} and regarding it as a (dual) pure-algebraic version of the ordinary mapping space functor on topological spaces (see below), we introduce and study some new objects in homotopy theories of algebras and (noncommutative) affine schemes:

(i) We introduce a functor $\mathfrak{P} = \mathfrak{P}^c$ and some of its variants on Alg that send any algebra A to some specific subalgebra $\mathfrak{P}(A) \subseteq A$. The associated functor on affine schemes turns out to be an algebraic version of the usual path-connected component functor π_0 on topological spaces. Homotopy invariance, behavior with respect to direct sum and tensor product, and some other properties of \mathfrak{P} are considered. Also, it is shown that in case char(\mathbb{F}) = 0, \mathfrak{P} is isomorphic to the de Rham cohomology-group functor at degree 0 on the category of unital commutative algebras.

(ii) For any functor F on an (admissible) subcategory of **Alg** with values in an arbitrary category we define the *costrict* homotopization of F to be a homotopy invariant functor $\lceil F \rceil$, with the same domain and target as F, satisfying a cotype of the universal property of Weibel's strict homotopization [21]. It is shown that under some mild conditions on the domain and target categories, the functor $\lceil F \rceil$ exists. It turns out that $\mathfrak{P} = \lceil id \rceil$. Also, it became clear that the *space* of *path-connected components* of any affine scheme can be defined in three different fashions.

(iii) Using machinery of ordinary singular cohomology theory, with each functor F on a specific subcategory of **Alg** with values in abelian groups we associate two homotopy invariant homology theories $\overline{\mathcal{H}}_F^*, \underline{\mathcal{H}}_F^*$ for algebras. It is proved that $\overline{\mathcal{H}}_F^0 = \lceil F \rceil$ and thus the functors $\overline{\mathcal{H}}_F^n$ may be regarded as higher ordered costrict homotopizations of F. In case F = id we have $\overline{\mathcal{H}}_F^* = \underline{\mathcal{H}}_F^*$, and we may consider the cup product for the homology theory. The associated theory on affine schemes is called *intrinsic singular cohomology theory*. A de Rham Theorem at degree zero is proved for that.

(iv) We construct an extension $\overline{\mathbf{Alg}}$ (and some of its variants) of \mathbf{Alg} . The objects of $\overline{\mathbf{Alg}}$ are those of \mathbf{Alg} and the morphisms from an algebra A to an algebra B are (various classes of) pro-ideals of $\mathfrak{M}_{A,B}$. It is shown that $\overline{\mathbf{Alg}}$ is an enriched category over partially ordered idempotent semigroups, by inclusion and intersection of proideals. Also, the K-group functor K_0 can be extended to a version of $\overline{\mathbf{Alg}}$.

(v) We consider a bivariant homology theory constructed as a pure-algebraic version of Cuntz's interpretation [5] of the Kasparov bivariant K-theory of C*-algebras [15]. It is shown that for every unital algebra C the canonical group-morphism from $K_0(C)$ into the Weibel homotopy K-group $KH_0(C)$ [19] factors through $\mathfrak{QQ}(\mathbb{F}, C)$. Following a method introduced by Phillips [17] we prove the existence of *classifying* homotopy pro-algebras for \mathfrak{QQ} -groups, Cortiñas-Thom's KK-groups [4], and KH_0 groups. Thus, for instance, it is proved that there exists a pro-object \overline{KH}_0 of the homotopy category Hot(Alg) with a cocommutative cogroup structure such that

$$KH_0(B) \cong [\overline{KH}_0, B] \qquad (B \in \mathbf{Alg}).$$

In the following we explain some simple ideas from classical Topology that are behind the definitions of \mathfrak{M} and the objects introduced in (i) and (iii).


Let \mathbf{Top} denote the category of topological spaces and \mathbf{Top}_k the subcategory of compact topological manifolds. Consider the bifunctor

$\mathrm{M}:\mathbf{Top}_k^{\mathrm{op}}\times\mathbf{Top}_k\to\mathbf{Top}$


that associates with (Y, X), the space of all (continuous) mappings from Y into X, with compact-open topology. It is an elementary fact that any map $\phi : Z \times Y \to X$ defines a Z-parameterized family $\{\psi(z)\}_z$ in $M_{Y,X}$ given by

$$\psi: Z \to \mathcal{M}_{Y,X} \qquad \psi(z)(y) := \phi(z,y).$$

Identifying maps of the type ϕ with families of maps of the type ψ , we may define the space $M_{Y,X}$ as the parameter-space M of a family $u : M \times Y \to X$ satisfying the following universal property: For any family $\phi : Z \times Y \to X$ with compact parameter space Z there exists a unique map $\overline{\phi} : Z \to M$ making the following diagram commutative:



Dualizing the above categorical definition of $M_{Y,X}$, we get the definition of $\mathfrak{M}_{A,B}$: For any two algebras A and B, $\mathfrak{M}_{A,B}$ is defined to be an object of **Alg** coming with a morphism $\Upsilon_{A,B}: A \to B \otimes \mathfrak{M}_{A,B}$ and satisfying the following universal property: For any algebra C and every morphism $\phi: A \to B \otimes C$ there exists a unique morphism $\overline{\phi}: \mathfrak{M}_{A,B} \to C$ making the following diagram commutative:



It will be shown that $\mathfrak{M}_{A,B}$ exists but not always as an algebra. Indeed, as in the general case $M_{Y,X}$ is a noncompact topological space, $\mathfrak{M}_{A,B}$ in general is a pro-object of **Alg**. Using the mentioned universal property it is easily verified that the assignment $(A, B) \to \mathfrak{M}_{A,B}$ defines a bifunctor (Theorem 2.3). Also, it is easily checked that there is a canonical bijection between \mathbb{F} -points of the noncommutative affine ind-scheme $\mathcal{S}(\mathfrak{M}_{A,B})$ associated to $\mathfrak{M}_{A,B}$ (i.e. the pro-morphisms $\mathfrak{M}_{A,B} \to \mathbb{F}$) and the morphisms $A \to B$ (Corollary 2.4). Thus, $\mathcal{S}(\mathfrak{M}_{A,B})$ may be called noncommutative (or quantum) family of *all* the maps $\mathcal{S}(B) \to \mathcal{S}(A)$. For more details on the concept of quantum family see [18].

It is necessary to remark that the pro-algebras of the type $\mathfrak{M}_{A,B}$ and their properties have been known for a long time (see for instance [9]). But it seems that these objects have not been systematically studied.

Let $\pi_0 : \mathbf{Top}_k \to \mathbf{Top}_k$ denote the functor that associates with any space the set of its path-connected components endowed with quotient topology. For any $X \in \mathbf{Top}_k$ we may identify $\mathcal{C}(\pi_0 X)$, the algebra of real-valued continuous functions on $\pi_0 X$, with the subalgebra of those functions $f \in \mathcal{C}(X)$ with the property that for any continuous curve $\gamma : [0,1] \to X$, $f \circ \gamma$ is constant. Thus if $X^{[0,1]} := \mathrm{M}([0,1], X)$ denotes the path-space of X then $f \in \mathcal{C}(X)$ belongs to $\mathcal{C}(\pi_0 X)$ iff the morphism

$$\mathcal{C}(X) \to \mathcal{C}([0,1] \times X^{[0,1]}) \quad g \mapsto [(t,\gamma) \mapsto g(\gamma(t))]$$

sends f to a function of the form

$$1 \otimes \tilde{f} \in \mathcal{C}([0,1]) \otimes \mathcal{C}(X^{[0,1]}) \subseteq \mathcal{C}([0,1] \times X^{[0,1]})$$

for some $\tilde{f} \in \mathcal{C}(X^{[0,1]})$.

Using the above formalism we may define the functor π_0 on the category of affine schemes: Let A be a unital commutative algebra regarded as the algebra of polynomial functions on the affine scheme S = S(A) over \mathbb{F} . Denote by \mathfrak{M}^{cu} , Υ^{cu} the commutative unital versions of \mathfrak{M}, Υ (Theorem 2.3). We let $\mathfrak{P}(A)$ be the subalgebra of those elements $a \in A$ such that the image of a under the morphism

$$\Upsilon^{\mathrm{cu}}_{A,\mathbb{F}[x]}:A\to\mathbb{F}[x]\otimes\mathfrak{M}^{\mathrm{cu}}_{A,\mathbb{F}[x]}$$

is of the form $1 \otimes \tilde{a}$ in each component of the pro-algebra $\mathbb{F}[x] \otimes \mathfrak{M}^{\mathrm{cu}}_{A,\mathbb{F}[x]}$ (Lemma 4.2). So, we have replaced the interval [0, 1] with the affine line $\mathbb{A}^1 = \mathcal{S}(\mathbb{F}[x])$. We define

$$\pi_0 S := \mathcal{S}(\mathfrak{P}(A)).$$

A continuous version of the ordinary singular cohomology theory with values in \mathbb{R} may be simply defined as follows: Let $\{\Delta_n\}_n$ denote the standard cosimplicial space. For any space X, the action of the cofunctor M(?, X) on $\{\Delta_n\}_n$ gives rise to the simplicial space $\{M(\Delta_n, X)\}_n$ and then to the cosimplicial vector space $\{\mathcal{C}(M(\Delta_n, X))\}_n$ that *accidentally* is also a cosimplicial algebra. The cohomology groups of the Moore cochain complex associated with that cosimplicial vector space may be called continuous singular cohomology groups of X [16].

A pure-algebraic version of the above formalism may be applied to affine schemes: Let $\mathbb{F}[\Delta] := \{\mathbb{F}[\Delta_n]\}_n$ denote the standard simplicial algebra [4, 7] (see §6 for the definition). For any affine scheme $S = \mathcal{S}(A)$ the action of $\mathfrak{M}_{A,?}$ on $\mathbb{F}[\Delta]$ gives rise to the cosimplicial pro-algebra $\mathfrak{M}_{A,\mathbb{F}[\Delta]}$. The cohomology groups of the Moore complex of $\lim \mathfrak{M}_{A,\mathbb{F}[\Delta]}$ are called intrinsic singular cohomology groups of S.

In the rest of this section we fix our notations. In § 2 we construct the functor \mathfrak{M} and its variants, and consider some basic properties of \mathfrak{M} . In § 3 we review the classical notion of algebraic homotopy for pro- and ind-morphisms, and show that \mathfrak{M} is homotopy preserving. In § 4-8 we consider respectively the items (i)-(v).

Notations & Conventions

We denote by **Set**, **Ab**, **Chain**, **CChain** respectively the categories of sets, abelian groups, and chain and cochain complexes of abelian groups. Let **C** be a category. The category of simplicial (resp. cosimplicial) objects of **C** is denoted by sim-**C** (resp. cosim-**C**). The category of pro-objects (resp. ind-object) of **C** ([1, Appendix]) is denoted by pro-**C** (resp. ind-**C**). An object of pro-**C** (alternatively called a pro-object of **C**) is an indexed family $\{C_i\}_{i\in I}$ of objects of *C* over a directed set *I* together with the structural morphisms $\alpha_{ii'}: C_{i'} \to C_i$ for $i' \geq i$ which are compatible: $\alpha_{ii} = id_{C_i}$ and $\alpha_{ii''} = \alpha_{ii'}\alpha_{i'i''}$. For pro-objects $C = (I, C_i, \alpha_{ii'})$ and $D = (J, D_j, \beta_{jj'})$ of **C** it is defined that

$$\operatorname{Hom}_{\operatorname{pro-}\mathbf{C}}(C,D) := \lim_{\infty \leftarrow j} \lim_{i \to \infty} \operatorname{Hom}_{\mathbf{C}}(C_i, D_j).$$

(The structure of $\operatorname{Hom}_{\operatorname{pro-C}}(C, D)$ may be explained as follows: A represented promorphism from C to D is distinguished by a function $f: J \to I$ and a family $\{\phi_j: C_{f(j)} \to D_j\}_j$ of morphisms with the property that if $j' \geq j$ then there exists $i \geq f(j), f(j')$ such that $\phi_j \alpha_{f(j)i} = \beta_{jj'} \phi_{j'} \alpha_{f(j')i}$. Two represented pro-morphisms (f, ϕ_j) and (g, ψ_j) are equivalent if for every j there exists $i \geq f(j), g(j)$ such that $\phi_j \alpha_{f(j)i} = \psi_j \alpha_{g(j)i}$. Then, $\operatorname{Hom}_{\operatorname{pro-C}}(C, D)$ may be identified with the set of equivalence classes of represented pro-morphisms.) We always collapse pro-pro- and ind-ind-objects to pro- and ind-objects, without further comment. We use freely the canonical embeddings

$$\mathbf{C} \subset \text{pro-}\mathbf{C}$$
 and $\mathbf{C} \subset \text{ind-}\mathbf{C}$.

We also freely use the canonical extensions of any functor $\mathbf{C} \to \mathbf{D}$ to the functors

pro- $\mathbf{C} \rightarrow \text{pro-}\mathbf{D}$, ind- $\mathbf{C} \rightarrow \text{ind-}\mathbf{D}$, sim- $\mathbf{C} \rightarrow \text{sim-}\mathbf{D}$.

Inverse limit $\lim_{i \to \infty}$ (if exists) is considered as a functor from pro-**C** to **C**. Recall that a functor $F : \mathbf{C} \to \mathbf{Set}$ is said to be pro-representable if there exist a pro-object $C = \{C_i\}$ of **C** and a natural isomorphism $\Phi : \operatorname{Hom}_{\operatorname{pro-C}}(C, ?) \to F$. Note that Φ is exactly distinguished by the family $\{\phi_i \in F(C_i)\}$ where $\phi_i := \Phi(\operatorname{id}_{C_i})$. We call

 $(\{C_i\}_i, \{\phi_i\}_i)$

a pro-representation for F, and say that F is pro-represented by C.

Throughout, we work over a fixed field \mathbb{F} ; all vector spaces and algebras are understood over \mathbb{F} . **Vec** denotes category of vector spaces. The symbol \otimes without any subscript denotes $\otimes_{\mathbb{F}}$. The sub- and super-scripts nc, c, u, r, fg, fp stand for noncommutative, commutative, unital, reduced, finitely generated, finitely presented. From now on, the category of all algebras is denoted by \mathbf{A}_{nc} . The category of unital algebras and unit preserving morphisms is denoted by \mathbf{A}_{u} . The category \mathbf{A}_{*} is similarly considered for $* = c, cu, fg, fp, \ldots$ Thus, for instance, \mathbf{A}_{cufg} denotes the category of finitely generated commutative unital algebras and unit preserving morphisms. Tensor product, product, and coproduct of pro- and ind-algebras are defined componentwise. For any pro-algebra A by a point of A we mean a pro-morphism from Ainto \mathbb{F} . The set of all points and all nonzero points of A are denoted by $\operatorname{Pnt}(A)$ and $\operatorname{Pnt}_{\neq 0}(A)$. The category of affine schemes (over \mathbb{F}) as usual is defined by $\operatorname{Aff} := \mathbf{A}_{cu}^{op}$. The affine scheme associated with $A \in \mathbf{A}_{cu}$ is denoted by $\mathcal{S}(A)$. M_n denotes the algebra of $n \times n$ matrixes with entries in \mathbb{F} . We denote with the same symbol the functor $\mathbf{A}_{nc} \to \mathbf{A}_{nc}$ given by $A \mapsto M_n(A) := M_n \otimes A$.

2 The Main Definition

Let $\mathbf{B}, \mathbf{C}, \mathbf{D}$ be arbitrary categories and let $F : \mathbf{C} \times \mathbf{D} \to \mathbf{B}$ be a functor. For objects $B \in \mathbf{B}$ and $C \in \mathbf{C}$ consider the functor

$$F_{B,C} := \operatorname{Hom}_{\mathbf{B}}(B, F(C, ?)) : \mathbf{D} \to \mathbf{Set}.$$

Let D be a pro-object of **D** and $\phi: B \to F(C, D)$ be a pro-morphism.

Lemma 2.1. (D, ϕ) is a pro-representation for $F_{B,C}$ iff the following universal property holds: For every pro-object E of \mathbf{D} and every pro-morphism $\psi : B \to F(C, E)$ there exists a unique pro-morphism $\bar{\psi} : D \to E$ such that $\psi = F(\mathrm{id}_C, \bar{\psi})\phi$.

The functor F is said to be pro-**D**-representable if for every $B, C, F_{B,C}$ is prorepresentable. For D and ϕ as above, we use respectively the notations

$$\mathfrak{M}(B,C) = \mathfrak{M}_{B,C}$$
 and $\Upsilon(B,C) = \Upsilon_{B,C}$.

Let $f: B \to B'$ and $g: C' \to C$ be morphisms respectively in **B** and **C**. The universal property of $(\mathfrak{M}_{B,C}, \Upsilon_{B,C})$ shows that there is a unique pro-morphism

$$\mathfrak{M}(f,g) = \mathfrak{M}_{f,g} : \mathfrak{M}_{B,C} \to \mathfrak{M}_{B',C'}$$

satisfying the identity

$$F(g, \operatorname{id}_{\mathfrak{M}_{B',C'}})\Upsilon_{B',C'}f = F(\operatorname{id}_C, \mathfrak{M}_{f,g})\Upsilon_{B,C}$$

It is clear that $\mathfrak{M}(\mathrm{id}_B, \mathrm{id}_C) = \mathrm{id}_{\mathfrak{M}(B,C)}$. For morphisms $f': B' \to B'', g': C'' \to C'$, again universal property of the involved objects shows that

$$\mathfrak{M}(f'f, gg') = \mathfrak{M}(f', g')\mathfrak{M}(f, g).$$

Ignoring some set-theoretical difficulties about the choice of a pro-representation $(\mathfrak{M}_{B,C}, \Upsilon_{B,C})$ for $F_{B,C}$, we have the following easily checked result.

Proposition 2.2. Suppose that the functor

$$F: \mathbf{C} \times \mathbf{D} \to \mathbf{B}$$

is pro-**D**-representable. Then, \mathfrak{M} may be considered as a functor

$$\mathfrak{M}: \mathbf{B} \times \mathbf{C}^{\mathrm{op}} \to \mathrm{pro-}\mathbf{D},$$

and Υ as a natural transformation, in the obvious way. For any $C \in \mathbf{C}$, the functor

$$\mathfrak{M}(?, C)$$
 : pro-**B** \rightarrow pro-**D**

is left-adjoint to the functor

$$F(C,?)$$
: pro-**D** \rightarrow pro-**B**.

Thus, for $B \in \text{pro-B}$, $C \in \mathbb{C}$, and $D \in \text{pro-D}$, we have the following natural bijection:

 $\operatorname{Hom}_{\operatorname{pro-}\mathbf{D}}(\mathfrak{M}(B,C),D) \cong \operatorname{Hom}_{\operatorname{pro-}\mathbf{B}}(B,F(C,D))).$

For $B \in \mathbf{B}$, $C \in \text{ind-}\mathbf{C}$, and $D \in \mathbf{D}$, we have the following bijection:

 $\operatorname{Hom}_{\operatorname{pro-D}}(\mathfrak{M}(B,C),D) \cong \operatorname{Hom}_{\operatorname{ind-B}}(B,F(C,D)).$

We now turn to our main construction in the category of algebras.

Let A, B be algebras. Suppose $\theta = {\delta_a}_{a \in G}$ is a family of finite linearly independent subsets δ_a of B indexed by a set $G \subseteq A$ that generates A as an algebra. Denote by $\mathfrak{M}\theta$ the universal algebra in \mathbf{A}_{nc} generated by symbols $z_{a,v}$, where $a \in G$ and $v \in \delta_a$, subject to the condition that the assignment

$$a \mapsto \sum_{v \in \delta_a} v \otimes z_{a,v} \tag{1}$$

defines a morphism $\Upsilon \theta : A \to B \otimes \mathfrak{M} \theta$ in \mathbf{A}_{nc} . The pair $(\mathfrak{M} \theta, \Upsilon \theta)$ has the following universal property: For every $C \in \mathbf{A}_{nc}$ and any morphism $\varphi : A \to B \otimes C$ in \mathbf{A}_{nc} with the property that for every $a \in G$, $\varphi(a)$ is a linear combination of vectors in δ_a , there is a unique morphism $\overline{\varphi} : \mathfrak{M} \theta \to C$ in \mathbf{A}_{nc} such that $\varphi = (\mathrm{id}_B \otimes \overline{\varphi}) \Upsilon \theta$. We call $\overline{\varphi}$ the morphism θ -associated with φ .

Now, fix a vector basis V for the underlying vector space of B, and let $\Theta = \Theta_{G,V}$ denote the set of all families $\theta = \{\delta_a\}_{a \in G}$ as above with $\delta_a \subseteq V$. For $\theta, \theta' \in \Theta$, write $\theta \subseteq \theta'$ if $\delta_a \subseteq \delta'_a$ for every $a \in G$. Then, \subseteq makes Θ into a directed set. For $\theta \subseteq \theta'$ let $\phi_{\theta'\theta} : \mathfrak{M}\theta' \to \mathfrak{M}\theta$ denote the morphism θ' -associated with $\Upsilon\theta$. We have $\phi_{\theta\theta} = \mathrm{id}$ and if $\theta \subseteq \theta' \subseteq \theta''$ then $\phi_{\theta''\theta} = \phi_{\theta'\theta}\phi_{\theta''\theta'}$. So, the data $\{\mathfrak{M}\theta, \phi_{\theta'\theta}\}$ distinguish a pro-algebra $\mathfrak{M}^{\mathrm{nc}}_{A,B}$ indexed by Θ and the family $\{\Upsilon\theta\}$ defines a pro-morphism

$$\Upsilon_{A,B}^{\mathrm{nc}}: A \to B \otimes \mathfrak{M}_{A,B}^{\mathrm{nc}}$$

We have the following universal property. Let $C = \{C_i\}_i$ be a pro-algebra and let

$$\varphi: A \to B \otimes C \qquad \varphi = \{\varphi_i: A \to B \otimes C_i\}_i$$

denote a pro-morphism. For every *i*, there exists $\theta = \{\delta_a\}$ in Θ such that $\varphi_i(a)$ a linear combinations of vectors in δ_a . Let $\overline{\varphi_i} : \mathfrak{M}\theta \to C_i$ be the morphism θ -associated with φ_i . Then, the family $\{\overline{\varphi_i}\}_i$ defines a unique pro-morphism

$$\overline{\varphi}:\mathfrak{M}_{A,B}^{\mathrm{nc}}\to C \qquad \varphi=\{\overline{\varphi_i}\}_i$$

satisfying

$$\varphi = (\mathrm{id}_B \otimes \overline{\varphi}) \Upsilon_{A,B}^{\mathrm{nc}}.$$

We call $\overline{\varphi}$ the pro-morphism associated with φ . By Lemma 2.1, the pair

$$(\mathfrak{M}_{A,B}^{\mathrm{nc}}, \Upsilon_{A,B}^{\mathrm{nc}}) \tag{2}$$

is a pro-representation for the functor

$$\operatorname{Hom}_{\mathbf{A}_{\operatorname{nc}}}(A, B \otimes ?) : \mathbf{A}_{\operatorname{nc}} \to \mathbf{Set}.$$

Thus, tensor product of algebras as the functor

$$\otimes: \mathbf{A}_{\mathrm{nc}} imes \mathbf{A}_{\mathrm{nc}} o \mathbf{A}_{\mathrm{nc}},$$

is pro- A_{nc} -representable. Similarly, it can be shown that the functor

$$\otimes : \mathbf{A}_{\mathrm{u}} \times \mathbf{A}_{\mathrm{u}} \to \mathbf{A}_{\mathrm{u}}$$

is pro- A_u -representable. Also, for $* \in \{c, cr\}$ ($* \in \{cu, cur\}$) the functors

 $\otimes: \mathbf{A}_{nc} \times \mathbf{A}_* \to \mathbf{A}_{nc} \qquad (\otimes: \mathbf{A}_u \times \mathbf{A}_* \to \mathbf{A}_u)$

are pro- \mathbf{A}_* -representable. We denote by $(\mathfrak{M}^*_{A,B}, \Upsilon^*_{A,B})$ the pro-representations for these functors, constructed similar to the pair (2). Thus, for instance, for unital algebras $A, B, \mathfrak{M}^{\mathrm{cur}}_{A,B}$ is an object in pro- $\mathbf{A}_{\mathrm{cur}}$ given by the inverse system $\{\mathfrak{M}\theta, \phi_{\theta'\theta}\}$ indexed over Θ as above, where $\mathfrak{M}\theta$ is the universal algebra in $\mathbf{A}_{\mathrm{cur}}$ generated by symbols $z_{a,v}$ subject to the condition that the assignment (1) defines a unit-preserving morphism from A into $B \otimes \mathfrak{M}\theta$. The following is a special case of Proposition 2.2.

Theorem 2.3. For $* \in \{nc, c, cr\}$, \mathfrak{M}^* may be considered as a functor

$$\mathfrak{M}^*:\mathbf{A}_{\mathrm{nc}} imes\mathbf{A}_{\mathrm{nc}}^{\mathrm{op}} o\mathrm{pro} extsf{-}\mathbf{A}_{\mathrm{nc}}$$

and Υ^* as a natural transformation, in the obvious way. For any $B \in \mathbf{A}_{nc}$, the functor

$$\mathfrak{M}^*(?, B): \operatorname{pro-}\mathbf{A}_{\operatorname{nc}} \to \operatorname{pro-}\mathbf{A}_*$$

is left-adjoint to the functor

$$B\otimes$$
? : pro- $\mathbf{A}_* \to \text{pro-}\mathbf{A}_{\text{nc}}$

For $A \in \text{pro-}\mathbf{A}_{nc}$, $B \in \mathbf{A}_{nc}$, and $C \in \text{pro-}\mathbf{A}_{*}$, we have the natural bijection

 $\operatorname{Hom}_{\operatorname{pro-}\mathbf{A}_{*}}(\mathfrak{M}^{*}(A, B), C) \cong \operatorname{Hom}_{\operatorname{pro-}\mathbf{A}_{\operatorname{pc}}}(A, B \otimes C),$

and for $A \in \mathbf{A}_{nc}$, $B \in \text{ind-}\mathbf{A}_{nc}$, and $C \in \mathbf{A}_{*}$, the bijection

$$\operatorname{Hom}_{\operatorname{pro-}\mathbf{A}_*}(\mathfrak{M}^*(A,B),C) \cong \operatorname{Hom}_{\operatorname{ind-}\mathbf{A}_{\operatorname{pc}}}(A,B\otimes C).$$

The above statements hold also for $* \in \{u, cu, cur\}$ if \mathbf{A}_{nc} is replaced by \mathbf{A}_{u} .

Corollary 2.4. For unital algebras A, B, we have the following identification:

$$\operatorname{Hom}_{\mathbf{A}_{u}}(A,B) \cong \operatorname{Pnt}_{\neq 0}(\mathfrak{M}_{A,B}^{*}) \qquad (* \in \{u, cu, cur\})$$

The similar statement holds for nonunital case.

Proof. It follows from Theorem 2.3 by putting $C = \mathbb{F}$.

Using universality of \mathfrak{M}^* it is easily verified that

 $\mathfrak{M}^{\mathrm{c}} = (\mathfrak{M}^{\mathrm{nc}})_{\mathrm{com}}, \ \ \mathfrak{M}^{\mathrm{cu}} = (\mathfrak{M}^{\mathrm{u}})_{\mathrm{com}}, \ \ \mathfrak{M}^{\mathrm{cr}} = (\mathfrak{M}^{\mathrm{c}})_{\mathrm{red}}, \ \ \mathfrak{M}^{\mathrm{cur}} = (\mathfrak{M}^{\mathrm{cu}})_{\mathrm{red}},$

where $A \mapsto A_{\text{com}} (\mathbf{A}_{\text{nc}} \to \mathbf{A}_{\text{c}})$ and $A \mapsto A_{\text{red}} (\mathbf{A}_{\text{c}} \to \mathbf{A}_{\text{cr}})$ denote commutativization and reduction functors. We have also canonical natural transformations

$$\mathfrak{M}^{\mathrm{nc}} \to \mathfrak{M}^{\mathrm{c}} \to \mathfrak{M}^{\mathrm{cr}} \quad \text{and} \quad \mathfrak{M}^{\mathrm{u}} \to \mathfrak{M}^{\mathrm{cu}} \to \mathfrak{M}^{\mathrm{cur}}.$$
 (3)

For the relation between unital and nonunital cases we only mention the following result. Let $+ : \mathbf{A}_{nc} \to \mathbf{A}_{u}$ denote the unitization functor. It is well-known that for any algebra A and any unital algebra B, every morphism $f : A \to B$ extends uniquely to a unit-preserving morphism $A^+ \to B$. (Indeed, this fact says that + is a left-adjoint to the embedding $\mathbf{A}_{u} \to \mathbf{A}_{nc}$.) By abuse of notation, we denote this extension of f by f^+ . The same convention is applied to pro-morphisms. **Theorem 2.5.** Let $A \in \mathbf{A}_{nc}, B \in \mathbf{A}_{u}$. Then there is a canonical isomorphism

$$(\mathfrak{M}_{A,B}^{\mathrm{nc}})^+ \cong \mathfrak{M}_{A^+,B}^{\mathrm{u}}, \quad (\mathfrak{M}_{A,B}^{\mathrm{c}})^+ \cong \mathfrak{M}_{A^+,B}^{\mathrm{cu}}, \quad (\mathfrak{M}_{A,B}^{\mathrm{cr}})^+ \cong \mathfrak{M}_{A^+,B}^{\mathrm{cur}}.$$

Proof. Let $f := (\mathrm{id}_B \otimes \mathrm{e})\Upsilon_{A,B}^{\mathrm{nc}}$ where $\mathrm{e} : \mathfrak{M}_{A,B}^{\mathrm{nc}} \to \mathfrak{M}_{A,B}^{\mathrm{nc}+}$ denotes the canonical embedding. We have $f^+ : A^+ \to B \otimes \mathfrak{M}_{A,B}^{\mathrm{nc}+}$ in pro-A_u. Let $\overline{f^+} : \mathfrak{M}_{A^+,B}^{\mathrm{u}} \to \mathfrak{M}_{A,B}^{\mathrm{nc}+}$ be the pro-morphism associated with f^+ . Thus $f^+ = (\mathrm{id} \otimes \overline{f^+})\Upsilon_{A^+,B}^{\mathrm{u}}$. Let $g := \Upsilon_{A^+,B}^{\mathrm{u}}$ where e this time shows the canonical embedding $A \to A^+$. Let $\overline{g} : \mathfrak{M}_{A,B}^{\mathrm{nc}} \to \mathfrak{M}_{A^+,B}^{\mathrm{u}}$ denote the pro-morphism associated with g. Thus $g = (\mathrm{id}_B \otimes \overline{g})\Upsilon_{A,B}^{\mathrm{nc}}$. We have $\overline{g^+} : \mathfrak{M}_{A,B}^{\mathrm{nc}+} \to \mathfrak{M}_{A^+,B}^{\mathrm{u}}$. It follows from universality of $\mathfrak{M}^{\mathrm{nc}}$ and $\mathfrak{M}^{\mathrm{u}}$ that $\overline{f^+}$ and $\overline{g^+}$ are inverses of each other. The proof is complete.

From now on, when there is no confusion about $* \in \{nc, c, cr, u, cu, cur\}$, we will use the short notations \mathfrak{M}, Υ instead of $\mathfrak{M}^*, \Upsilon^*$. In the following we consider some basic properties of \mathfrak{M} .

Theorem 2.6.

- (i) $\mathfrak{M}_{A,\mathbb{F}}^{\mathrm{nc}} \cong A$ for $A \in \mathbf{A}_{\mathrm{nc}}$, and $\mathfrak{M}_{\mathbb{F},B}^{\mathrm{u}} \cong \mathbb{F}$ for $B \in \mathbf{A}_{\mathrm{u}}$.
- (ii) For any $A \in \mathbf{A}_{nc}$ there is a canonical bijection $\operatorname{Pnt}(\mathfrak{M}^{nc}_{\mathbb{F},A}) \cong \{a \in A : a^2 = a\}$. Similarly, for every n > 1 there is a canonical bijection between $\operatorname{Pnt}(\mathfrak{M}^{nc}_{\mathbb{F}^n,A})$ and the set of *n*-tuples of pairwise orthogonal idempotents of A.
- (iii) For $A \in \mathbf{A}_{\mathrm{nc}}$ and n > 1, $\mathfrak{M}_{A,\mathbb{F}^n}^{\mathrm{nc}}$ is a coproduct of n copies of A in \mathbf{A}_{nc} .
- (iv) If $A \in \mathbf{A}_{\mathrm{ncfg}}, A' \in \mathbf{A}_{\mathrm{ncfp}}, B \in \mathbf{A}_{\mathrm{nc}}$ then $\mathfrak{M}_{A,B}^{\mathrm{nc}} \in \mathrm{pro-}\mathbf{A}_{\mathrm{ncfg}}, \mathfrak{M}_{A',B}^{\mathrm{nc}} \in \mathrm{pro-}\mathbf{A}_{\mathrm{ncfp}}$.
- (v) If B is a finite-dimensional algebra then $\mathfrak{M}_{A,B}^{\mathrm{nc}} \cong \underline{\lim} \mathfrak{M}_{A,B}^{\mathrm{nc}}$ for any algebra A.

Proof. Straightforward.

Example 2.7. $\mathfrak{M}_{\mathbb{F},\mathcal{M}_n}^{\mathrm{nc}}$ is the universal algebra generated by the symbols $\{z_{ij}\}_{i,j=1}^n$ satisfying $z_{ij} = \sum_{k=1}^n z_{ik} z_{kj}$. We have $\Upsilon_{\mathbb{F},\mathcal{M}_n}^{\mathrm{nc}}(1) = \sum_{ij=1}^n e_{ij} \otimes z_{ij}$ where $\{e_{ij}\}_{i,j=1}^n$ denotes the canonical vector basis of \mathcal{M}_n .

Example 2.8. $\mathfrak{M}^{\mathrm{u}}(\mathbb{F}[x], \mathbb{F}^n)$ is isomorphic to $\mathbb{F}_{\mathrm{nc}}[x_1, \ldots, x_n]$, the algebra of polynomials in noncommutating indeterminates x_1, \ldots, x_n .

Example 2.9. Let $A \in \mathbf{A}_{\operatorname{ncfg}}, B \in \mathbf{A}_{\operatorname{nc}}$. Suppose G is a finite generator-set for A, and V is a vector basis for B. For every finite subset S of V, let $\theta_S \in \Theta_{G,V}$ denote the family $\{\delta_a\}_a$ where $\delta_a = S$ for every $a \in G$. Then $\{\theta_S\}_S$ is a cofinal subset of $\Theta_{G,V}$, and hence the pro-algebra $\mathfrak{M}_{A,B}^{\operatorname{nc}}$ is described also by the inverse system $\{\mathfrak{M}\theta_S\}_S$ of algebras. Moreover, suppose that V is countable and $V = \{v_1, v_2, \ldots\}$, and let $S_n := \{v_1, \ldots, v_n\}$. Then, $\mathfrak{M}_{A,B}$ is also described by the following *nice* inverse subsystem of $\{\mathfrak{M}\theta_S\}_S$:

$$\mathfrak{M}\theta_{S_1} \leftarrow \cdots \leftarrow \mathfrak{M}\theta_{S_n} \leftarrow \mathfrak{M}\theta_{S_{n+1}} \leftarrow \cdots$$

Here, $\mathfrak{M}\theta_{S_n}$ is generated by $\{z_{a,i} : a \in G, i = 1, \ldots, n\}$, and $\mathfrak{M}^{\mathrm{nc}}\theta_{S_{n+1}} \to \mathfrak{M}^{\mathrm{nc}}\theta_{S_n}$ is given by $z_{a,i} \mapsto z_{a,i}$ for $i = 1, \ldots, n$, and $z_{a,n+1} \mapsto 0$.

Let $C \in \mathbf{A}_{\text{cufg}}$, and let $G = \{g_1, \ldots, g_n\}$ be a finite ordered generator-set for C. Let ϕ be the morphism $\mathbb{F}[x_1, \ldots, x_n] \to C$ given by $x_i \mapsto g_i$. Denote by $\mathcal{Z}(C, G)$ the zero-locus of ker (ϕ) , i.e. the algebraic set in \mathbb{A}^n of *n*-tuples $(\lambda_1, \ldots, \lambda_n)$ under which the evaluation of every polynomial in ker (ϕ) , is zero. It is clear that the assignment

$$(\lambda_1,\ldots,\lambda_n)\mapsto [g_1\mapsto\lambda_1,\ldots,g_n\mapsto\lambda_n]$$

defines a bijection from $\mathcal{Z}(C, G)$ onto $\operatorname{Pnt}_{\neq 0}(C)$. Thus, the choice of G gives rise to the structure $\mathcal{Z}(C, G)$ of an algebraic set on $\operatorname{Pnt}_{\neq 0}(C)$. Similarly, if $C = (C_i)_i$ be in pro- $\mathbf{A}_{\operatorname{cufg}}$ then any family $G = \{G_i\}_i$ where G_i is a finite ordered generator-set for A_i , gives rise to an algebraic ind-set structure $\mathcal{Z}(C, G) := \{\mathcal{Z}(C_i, G_i)\}_i$ on the set

$$\operatorname{Pnt}_{\neq 0}(C) = \lim_{i \to \infty} \operatorname{Pnt}_{\neq 0}(C_i).$$

(We say that a set X has the structure of a ind-set $(X_i)_i$ if we have a distinguished bijection between X and $\lim_{i\to\infty} X_i$, and for every $i, X_i \to \lim_{i\to\infty} X_i$ is injective.)

Theorem 2.10. Let $A \in \mathbf{A}_{ufg}$ and let $B \in \mathbf{A}_{u}$. Every finite ordered generator-set for A and any ordered vector basis for B, give rise to a canonical algebraic ind-set structure on $\operatorname{Hom}_{\mathbf{A}_{u}}(A, B)$.

Proof. Consider the pro-algebra $\mathfrak{M}_{A,B}^{cu}$ with the model $\{\mathfrak{M}\theta_S\}_S$ described in Example 2.9. $\mathfrak{M}\theta_S$ is generated by elements $z_{a,v}$ indexed by the set $G \times S$. This set may be endowed the dictionary ordering induced by orderings on G and V. Then, the method described above gives rise to an algebraic ind-set structure on $\operatorname{Pnt}_{\neq 0}(\mathfrak{M}_{A,B}^{cu})$. Then, the desired result follows from Corollary 2.4.

For an application of the structure given by the above theorem, see [14].

Theorem 2.11. Suppose \star denotes coproduct in \mathbf{A}_{nc} . There is an isomorphism:

$$\mathfrak{M}^{\mathrm{nc}}(A, B \oplus B') \cong \mathfrak{M}^{\mathrm{nc}}(A, B) \star \mathfrak{M}^{\mathrm{nc}}(A, B') \qquad (A, B, B' \in \mathbf{A}_{\mathrm{nc}})$$

Proof. Let A be generated by G, and $V \subset B, V' \subset B'$ be vector bases. For $\theta = \{\delta_a\} \in \Theta_{G,V}$ and $\theta' = \{\delta'_a\} \in \Theta_{G,V'}$, let $\theta \cup \theta' \in \Theta_{G,V \cup V'}$ denote the family $\{\delta_a \cup \delta'_a\}$ where $V \cup V'$ is considered as a vector basis for $B \oplus B'$. It is enough to prove that

$$\mathfrak{M}(\theta \cup \theta') = \mathfrak{M}(\theta) \star \mathfrak{M}(\theta').$$

We do that by checking that $\mathfrak{M}(\theta \cup \theta')$ has the required universal property. Let $\underline{\phi}_{\theta} := (\mathbf{p} \otimes \mathrm{id}) \Upsilon(\theta \cup \theta')$ where $\mathbf{p} : B \oplus B' \to B$ is the canonical projection. Then, $\overline{\phi}_{\theta} : \mathfrak{M}\theta \to \mathfrak{M}(\theta \cup \theta')$, the morphism θ -associated with ϕ_{θ} , plays the role of coproduct structural morphism. Similarly, the structural morphism $\overline{\phi'}_{\theta'} : \mathfrak{M}\theta' \to \mathfrak{M}(\theta \cup \theta')$ is defined. Suppose that $\psi : \mathfrak{M}\theta \to C, \psi' : \mathfrak{M}\theta' \to C$ are arbitrary morphisms, and let

$$\varphi = [(\mathrm{id}_B \otimes \psi) \Upsilon \theta] \oplus [(\mathrm{id}_{B'} \otimes \psi) \Upsilon \theta'].$$

Then, $\overline{\varphi}_{\theta\cup\theta'}: \mathfrak{M}(\theta\cup\theta')\to C$, the morphism $(\theta\cup\theta')$ -associated with φ , is the unique morphism satisfying $\psi=\overline{\varphi}_{\theta\cup\theta'}\overline{\phi}_{\theta}$ and $\psi'=\overline{\varphi}_{\theta\cup\theta'}\overline{\phi'}_{\theta'}$. The proof is complete.

Theorem 2.12. (Exponential Law) There is a canonical isomorphism:

$$\mathfrak{M}^{\mathrm{nc}}(A, B \otimes B') \cong \mathfrak{M}^{\mathrm{nc}}(\mathfrak{M}^{\mathrm{nc}}(A, B), B') \qquad (A, B, B' \in \mathbf{A}_{\mathrm{nc}}).$$

Proof. Suppose $G \subseteq A$ is a generator, and $V \subset B, V' \subset B'$ are vector bases. For $S \subseteq V, S' \subseteq V'$, denote by $S \otimes S'$ the set $\{v \otimes v' : v \in S, v' \in S'\}$. For $\theta = \{\delta_a\}$ and $\theta' = \{\delta'_a\}$ respectively in $\Theta_{G,V}$ and $\Theta_{G,V'}$, let $\theta \otimes \theta' \in \Theta_{G,V \otimes V'}$ denote $\{\delta_a \otimes \delta'_a\}$. We know that $\mathfrak{M}\theta$ is generated by $G \times \theta := \{z_{a,v} : a \in G, v \in \delta_a\}$. Let $\theta'|\theta$ in $\Theta_{G \times \theta,V'}$ denote $\{\eta_{z_{a,v}}\}$ where $\eta_{z_{a,v}} := \delta'_a$. The class $\{\theta \otimes \theta'\}$ is cofinal with $\Theta_{G,V \otimes V'}$, and the class $\{\theta'|\theta\}$ is cofinal with $\Theta_{G \times \theta,V'}$. Thus, the pro-algebras $\mathfrak{M}_{A,B \otimes B'}$ and $\mathfrak{M}_{\mathfrak{M}\theta,B'}$ are described respectively by inverse systems $\{\mathfrak{M}(\theta \otimes \theta')\}$ and $\{\mathfrak{M}(\theta'|\theta)\}$. Now, the desired result follows from the canonical isomorphism of $\mathfrak{M}(\theta \otimes \theta')$ and $\mathfrak{M}(\theta'|\theta)$ which can be proved by using similar arguments as in [18, Theorem 2.10].

The proof of the following result is similar to that of [18, Theorem 2.8] and omitted.

Theorem 2.13. There exists a canonical isomorphism:

$$\mathfrak{M}^{\mathrm{cu}}(A \otimes A', B) \cong \mathfrak{M}^{\mathrm{cu}}(A, B) \otimes \mathfrak{M}^{\mathrm{cu}}(A', B) \qquad (A, A' \in \mathbf{A}_{\mathrm{u}}, B \in \mathbf{A}_{\mathrm{cu}})$$

We denote by $\mathfrak{op} : \mathbf{A}_{nc} \to \mathbf{A}_{nc}$ the functor that associates to any algebra the algebra with opposite multiplication.

Theorem 2.14. For any two algebras A, B we have the natural isomorphism

$$\mathfrak{op}(\mathfrak{M}^{\mathrm{nc}}(A,B)) \cong \mathfrak{M}^{\mathrm{nc}}(\mathfrak{op}(A),\mathfrak{op}(B)).$$

Proof. It is easily seen from the construction of $\mathfrak{M}_{A,B}^{\mathrm{nc}}$.

Proposition 2.15. For $A, B, C \in \mathbf{A}_{nc}/\mathbf{A}_{u}$ and $* \in \{nc, c, cr\}/\{u, cu, cur\}$ there is a natural pro-morphism

$$\Phi_{A,B,C}:\mathfrak{M}^*_{A,C}\to\mathfrak{M}^*_{B,C}\otimes\mathfrak{M}^*_{A,B}$$

such that

$$(\mathrm{id}_{\mathfrak{M}_{C,D}^*} \otimes \Phi_{A,B,C}) \Phi_{A,C,D} = (\Phi_{B,C,D} \otimes \mathrm{id}_{\mathfrak{M}_{A,B}^*}) \Phi_{A,B,D}$$
(4)

Proof. By universality of $\mathfrak{M}_{A,C}$, there is a unique pro-morphism $\Phi_{A,B,C}$ satisfying

$$(\mathrm{id}_C \otimes \Phi_{A,B,C})\Upsilon_{A,C} = (\Upsilon_{B,C} \otimes \mathrm{id}_{\mathfrak{M}_{A,B}})\Upsilon_{A,B}.$$

Identity (4) follows from the universality of $\mathfrak{M}_{A,D}$.

3 Classical Algebraic Homotopy

A compatible relation on a category \mathbf{C} is an equivalence relation \mathfrak{R} on the class of morphisms of \mathbf{C} such that for morphisms $f, f': C \to C'$ and $g, g': C' \to C''$ if $f\mathfrak{R}f'$ and $g\mathfrak{R}g'$ then $gf\mathfrak{R}g'f'$. Denote by $\operatorname{Hot}_{\mathfrak{R}}(\mathbf{C})$ the category whose objects are those of \mathbf{C} and whose hom-sets are

$$[C, C']_{\mathfrak{R}} = \operatorname{Hom}_{\operatorname{Hot}_{\mathfrak{R}}(\mathbf{C})}(C, C') := \operatorname{Hom}_{\mathbf{C}}(C, C')/\mathfrak{R}.$$

Let **A** be a subcategory of \mathbf{A}_{nc} . We say that **A** is admissible if **A** is closed under polynomial extensions, and if for every algebra A in **A** the canonical embedding $\mathbf{e} : A \to A[x]$ given by $a \mapsto a$, the evaluation morphisms $\mathbf{p}_0, \mathbf{p}_1 : A[x] \to A$ given respectively by $x \mapsto 0, x \mapsto 1$, and the morphism defined by $x \mapsto 1 - x$ from A[x] onto A[x], belong to **A**. It is clear that \mathbf{A}_* for $* \in \{nc, c, cr, u, cu, cur\}$ is admissible.

Let A be an admissible category of algebras. Two morphisms $f, g : A \to B$ in pro-**A** are said to be elementary homotopic, denoted $f \approx g$, if there is a morphism $H : A \to B \otimes \mathbb{F}[x] \cong B[x]$ in pro-**A**, called elementary homotopy from f to g, such that $p_0H = f$ and $p_1H = g$. Similarly, elementary homotopic morphisms in ind-**A** are defined.

Two morphisms $f, g: A \to B$ in **A** are called algebraic homotopic, denoted fhg, if there is a finite chain h_0, \ldots, h_n of morphisms in **A** such that

$$f = h_0 \approx h_1 \approx \ldots \approx h_n = g. \tag{5}$$

It is easily verified that h is a compatible relation on \mathbf{A} , and accordingly we have the homotopy category $Hot(\mathbf{A}) = Hot_h(\mathbf{A})$.

We say that two pro-morphisms $f, g : A \to B$ are strongly homotopic, denoted $f \operatorname{sh} g$, if there is a finite chain h_0, \ldots, h_n of pro-morphisms such that (5) is satisfied. It is easily verified that sh is a compatible relation on pro-**A**, and accordingly we have the homotopy category $\operatorname{Hot}_{\operatorname{sh}}(\operatorname{pro-} \mathbf{A})$. The compatible relation sh between ind-morphisms is defined similarly, and hence we have the category $\operatorname{Hot}_{\operatorname{sh}}(\operatorname{ind-} \mathbf{A})$.

We say that two pro-morphisms $f, g : A \to B$ are weakly homotopic, denoted f whg, if their images in pro-Hot(**A**) are equal. It is clear that wh is a compatible relation on pro-**A**, and accordingly we have the homotopy category Hot_{wh}(pro-**A**). The homotopy category Hot_{wh}(ind-**A**) is defined similarly.

It is clear that wh is coarser than sh. Thus we have the following two sequences of functors all induced by id in the obvious way:

$$\operatorname{pro-} \mathbf{A} \to \operatorname{Hot}_{\operatorname{sh}}(\operatorname{pro-} \mathbf{A}) \to \operatorname{Hot}_{\operatorname{wh}}(\operatorname{pro-} \mathbf{A}) \to \operatorname{pro-Hot}(\mathbf{A})$$

 $\mathrm{ind}\text{-}\mathbf{A} \to \mathrm{Hot}_{\mathrm{sh}}(\mathrm{ind}\text{-}\mathbf{A}) \to \mathrm{Hot}_{\mathrm{wh}}(\mathrm{ind}\text{-}\mathbf{A}) \to \mathrm{ind}\text{-}\mathrm{Hot}(\mathbf{A})$

In each of the above two rows the first and second functors are full and the third one is faithful. It is customary ([4, 7, 8, 9]) to denote the hom-sets of the categories pro-Hot(\mathbf{A}) and ind-Hot(\mathbf{A}) just by [?,?]. It is easily verified that if $A \in$ pro- \mathbf{A} and $B \in \mathbf{A}$ (or if $A \in \mathbf{A}$ and $B \in$ ind- \mathbf{A}) then there are natural identifications

$$[A, B]_{\rm sh} \equiv [A, B]_{\rm wh} \equiv [A, B] \tag{6}$$

Note that for pro-algebras $A = (A_i)$ and $B = (B_j)$, we have

$$[A, B] = \lim_{\infty \leftarrow j} \lim_{i \to \infty} [A_i, B_j].$$

Similarly, for ind-algebras $A = (A_i)$ and $B = (B_j)$, we have

$$[A, B] = \lim_{\infty \leftarrow i} \lim_{j \to \infty} [A_i, B_j].$$

We remark that in general for pro- or ind-algebras A, B the set [A, B] is very bigger than $[A, B]_{wh}$.

The following simple lemma shows that for morphism f, g in \mathbf{A}_* where $* \in \{c, cr, u, cu, cur\}, f$ and g are homotopic in \mathbf{A}_* iff f and g are homotopic in \mathbf{A}_{nc} .

Lemma 3.1. Let A, B be unital algebras, $f, g : A \to B$ be morphisms in \mathbf{A}_{nc} , and H be an elementary homotopy in \mathbf{A}_{nc} from f to g. If $f \in \mathbf{A}_{u}$ then $H, g \in \mathbf{A}_{u}$.

Lemma 3.2. Let $A, B \in \mathbf{A}_{nc}$ and $C \in \text{pro-}\mathbf{A}_{nc}$, and let $f, g : A \to B \otimes C$ be promorphisms. Suppose that $\overline{f}, \overline{g} : \mathfrak{M}_{A,B}^{nc} \to C$ denote the pro-morphisms associated with f, g. Then, $f \operatorname{sh} g$ iff $\overline{f} \operatorname{sh} \overline{g}$, and $f \operatorname{wh} g$ iff $\overline{f} \operatorname{wh} \overline{g}$.

Proof. If $H: A \to B \otimes C[x]$ is an elementary homotopy between f, g then the promorphism $\overline{H}: \mathfrak{M}_{A,B} \to C[x]$ associated with H is an elementary homotopy between $\overline{f}, \overline{g}$. Conversely, if $G: \mathfrak{M}_{A,B} \to C[x]$ is an elementary homotopy between $\overline{f}, \overline{g}$ then $(\mathrm{id}_B \otimes G) \Upsilon_{A,B}$ is an elementary homotopy between f, g.

Let $C = (C_i)_i$ where $C_i \in \mathbf{A}_{nc}$, and let $f = (f_i)_i$ and $g = (g_i)_i$. Suppose f whg. Then, $f_i h g_i$. It follows from the first part that $\overline{f}_i \operatorname{sh} \overline{g}_i$, and hence $\overline{f}_i \operatorname{wh} \overline{g}_i$. Thus, $\overline{f} \operatorname{wh} \overline{g}$. The converse is similar.

We have the following lemma that can be easily proved.

Lemma 3.3. The analogue of the statement of Lemma 3.2 holds for $A, C \in \mathbf{A}_{nc}$ and $B \in \text{ind-}\mathbf{A}_{nc}$.

Theorem 3.4. For $A, B \in \mathbf{A}_{nc}$ and $C \in \text{pro-}\mathbf{A}_{nc}$ $(A, C \in \mathbf{A}_{nc} \text{ and } B \in \text{ind-}\mathbf{A}_{nc})$, we have the following canonical identification:

$$[A, B \otimes C] \cong [\mathfrak{M}^{\mathrm{nc}}(A, B), C]$$

Proof. It follows from Theorem 2.3, Identities (6), and Lemmas 3.2 and 3.3.

Theorem 3.5. The functor $\mathfrak{M}^{\mathrm{nc}}$ preserves homotopy in the sense that for morphisms $f_0, f_1: A \to A'$ and $g_0, g_1: B \to B'$ in \mathbf{A}_{nc} , if $f_0 h f_1$ and $g_0 h g_1$ then $\mathfrak{M}_{f_0, g_0} \mathrm{sh} \mathfrak{M}_{f_1, g_1}$.

Proof. It follows from definitions of $\mathfrak{M}_{f_0,g_0}, \mathfrak{M}_{f_1,g_1}$ and Lemma 3.2.

Note that the above four results hold for all \mathfrak{M}^* .

A functor F from an admissible category \mathbf{A} of algebras to an arbitrary category \mathbf{C} is said to be homotopy invariant if for any two morphism $f, g \in \mathbf{A}$, fhg implies F(f) = F(g). We say that $F : \mathbf{Aff} \to \mathbf{C}$ is \mathbb{A}^1 -homotopy invariant if F as the functor $\mathbf{A}_{cu} \to \mathbf{C}^{op}$, is homotopy invariant. The following lemma is very well-known.

Lemma 3.6. For any functor $F : \mathbf{A} \to \mathbf{C}$ the following statements are equivalent.

- (i) F is homotopy invariant.
- (ii) For every algebra A in **A**, $F(e) : F(A) \to F(A[x])$ is an isomorphism in **C**.
- (iii) For every algebra A in A, $F(p_0), F(p_1) : F(A[x]) \to F(A)$ are equal.

Proof. (i)⇒(ii): We show that $F(p_0)$ is the inverse of F(e) in **C**: We have $p_0e = id_A$. Thus $F(p_0)F(e) = id_{F(A)}$. The morphism $A[x] \to A[x]([y])$ given by $p(x) \mapsto p(xy)$ is an elementary homotopy between ep_0 and $id_{A[x]}$. Thus $F(e)F(p_0) = id_{F(A[x])}$. (ii)⇒(iii): We have $p_0e = p_1e$. Thus $F(p_0)F(e) = F(p_1)F(e)$. Since F(e) is an isomorphism, we must have $F(p_0) = F(p_1)$. (iii)⇒(i) is trivial.

Recall that a differential graded commutative algebra (DGCA) is given by a pair (\bar{A}, d) where $\bar{A} = \bigoplus_{n=0}^{\infty} A^n$ is a GA with a GC multiplication (i.e. $a_i a_j = (-1)^{ij} a_j a_i$ for $a_i \in A^i, a_j \in A^j$ and where $d : \overline{A} \to \overline{A}$ is a GD (i.e. a F-linear map of degree 1 such that $d(a_i a_j) = d(a_i)a_j + (-1)^i a_i d(a_j)$ and dd = 0). It is well-known that for every $A \in \mathbf{A}_{cu}$ there exists a DGCA $\Omega(A) = \oplus \Omega^n(A)$ with $\Omega^0(A) = A$ satisfying the following universal property: For every unital DGCA (\bar{B}, δ) , any arbitrary morphism $f: A \to B^0$ in \mathbf{A}_{cu} extends uniquely to a morphism $f: \Omega(A) \to \overline{B}$ satisfying $fd = f\delta$. Indeed, $\Omega(A)$ is the exterior algebra associated to A-module $\Omega^1(A)$ and $d: A \to \Omega^1(A)$ is a derivation such that for every unital A-module M and any derivation $\delta: A \to M$ there is a unique module homomorphism $\phi: \Omega^1(A) \to M$ satisfying $\delta = \phi d$. If \mathbb{F} is real field and A is the algebra of smooth real functions on a smooth compact manifold then $\Omega(A)$ is isomorphic to de Rham complex of differential forms on the manifold [11, Proposition 8.1]. So, for any $A \in \mathbf{A}_{cu}$ and its associated affine scheme $S = \mathcal{S}(A)$ the cohomology groups of $\Omega(A)$ is denoted by $\mathcal{H}^n_{deR}(A)$ or $\mathcal{H}^n_{deR}(S)$ $(n \ge 0)$ and called de Rham cohomology groups of A or S. Note that $\mathcal{H}_{deR}(S) := \bigoplus_{n=0}^{\infty} \mathcal{H}_{deR}^n(S)$ is a unital GCA with the multiplication induced by that of $\Omega(A)$. By universality of Ω we may consider the functors

$$\mathcal{H}^0_{\mathrm{deR}}: \mathbf{Aff}^{\mathrm{op}} o \mathbf{A}_{\mathrm{cu}}, \ \ \mathcal{H}^n_{\mathrm{deR}}: \mathbf{Aff}^{\mathrm{op}} o \mathbf{Vec}, \ \ \mathcal{H}_{\mathrm{deR}}: \mathbf{Aff}^{\mathrm{op}} o \mathbf{A}_{\mathrm{u}}.$$

It is shown that these functors are \mathbb{A}^1 -homotopy invariant provided that $\operatorname{Char}(\mathbb{F}) = 0$: For $A \in \mathbf{A}_{\operatorname{cu}}$ let $\mathbf{p}_0, \mathbf{p}_1 : \Omega(A[x]) \to \Omega(A)$ denote the cochain maps induced by $\mathbf{p}_0, \mathbf{p}_1 : A[x] \to A$. By freeness of the variable x we have a A[x]-module decomposition $\Omega^n(A[x]) = \bigoplus_{i=0}^n M_i$ such that M_i is the A[x]-submodule generated by all elements $(d^i x) \omega_{n-i} \in \Omega^n(A[x])$ where $\omega_{n-i} \in \Omega^{n-i}(A)$ and where $d^i x$ denotes the (exterior) product of i copies of dx in $\Omega(A[x])$. Consider a linear map ϕ^n from $\Omega^n(A[x])$ into $\Omega^{n-1}(A)$ defined for $\alpha_i \in M_i$ by $\phi^n(\alpha_i) := 0$ if $i \neq 1$ and $\phi^n(\alpha_1) := \int_0^1 \alpha_1$. Here the formal integral is given by

$$\int_0^1 dx (x^k \omega) := \frac{1}{k+1} x^{k+1} \omega \mid_0^1 = \frac{1}{k+1} \omega \quad (\omega \in \Omega^{n-1}(A))$$

Then it can be checked that $(\phi^n)_n$ is a cochain homotopy between p_0 and p_1 , and hence $\mathcal{H}^n_{deR}(p_0) = \mathcal{H}^n_{deR}(p_1)$.

4 Homotopy Invariant Subalgebras

The main aim of this section is to consider an analogue of the functor π_0 for algebras: **Definition 4.1.** Let $A \in \mathbf{A}_{nc}/\mathbf{A}_u$. For $* \in \{nc, c, cr\}/\{u, cu, cur\}$, let

$$\mathfrak{p}_0, \mathfrak{p}_1 : A \to \varprojlim \mathfrak{M}^*_{A, \mathbb{F}[x]}$$

be given by

$$\mathfrak{p}_0 := \varprojlim \big[((x \mapsto 0) \otimes \operatorname{id}) \Upsilon^*_{A, \mathbb{F}[x]} \big] \ \text{ and } \ \mathfrak{p}_1 := \varprojlim \big[((x \mapsto 1) \otimes \operatorname{id}) \Upsilon^*_{A, \mathbb{F}[x]} \big]$$

We let the subalgebra $\mathfrak{P}^*(A) \subseteq A$ be defined by

$$\mathfrak{P}^*(A) := \{ a \in A : \mathfrak{p}_0(a) = \mathfrak{p}_1(a) \}.$$

We have the following useful lemma.

Lemma 4.2. With assumptions of Definition 4.1, suppose A is generated by G and V is a vector basis for $\mathbb{F}[x]$. For any $a \in A$ the following statements are equivalent.

- (i) For every $\theta \in \Theta_{G,V}$, there exists $\hat{a}_{\theta} \in \mathfrak{M}^* \theta$ such that $\Upsilon^* \theta(a) = 1 \otimes \hat{a}_{\theta}$.
- (ii) For every algebra $C \in \mathbf{A}_*$ and every morphism $\phi : A \to C[x]$ in $\mathbf{A}_{nc}/\mathbf{A}_{u}$, $\phi(a)$ is constant.
- (iii) For every $\theta \in \Theta_{G,V}$, $((x \mapsto 0) \otimes id) \Upsilon^* \theta(a) = ((x \mapsto 1) \otimes id) \Upsilon^* \theta(a)$.
- (iv) For every C, ϕ as in (ii), $(x \mapsto 0)\phi(a) = (x \mapsto 1)\phi(a)$.
- (v) a belongs to $\mathfrak{P}^*(A)$.

Proof. (i) \Rightarrow (ii) and (iii) \Rightarrow (iv) follow from the universal property of $\mathfrak{M}_{A,\mathbb{F}[x]}$. (i) \Rightarrow (iii) and (iv) \Rightarrow (iii) are trivial. Also, (ii) \Rightarrow (i),(iv) and (iii) \Leftrightarrow (v) are trivial. If $\phi : A \to C[x]$ is a morphism then we can also consider the morphism $A \to (C[x])[y]$ given by $b \mapsto \phi(b)(xy)$. This shows that (iv) \Rightarrow (ii) is satisfied.

It is easily verified that any morphism from A to B transforms $\mathfrak{P}^*(A)$ into $\mathfrak{P}^*(B)$. Thus we may consider the following subfunctor of $\mathrm{id}_{\mathbf{A}_{\mathrm{nc}}/\mathbf{A}_{\mathrm{n}}}$:

$$\mathfrak{P}^*: \mathbf{A}_{\mathrm{nc}}/\mathbf{A}_{\mathrm{u}}
ightarrow \mathbf{A}_{\mathrm{nc}}/\mathbf{A}_{\mathrm{u}}.$$

(We say that a functor $F : \mathbf{A}_* \to \mathbf{A}_*$ is a subfunctor of $\mathrm{id}_{\mathbf{A}_*}$ if for any $A \in \mathbf{A}_*$, F(A) is a subalgebra of A (in unital cases, F(A) is required to have the unit of A) and for any morphism $f : A \to B$, $F(f) = f|_{F(A)}$.) For any $A \in \mathbf{A}_{\mathrm{nc}}/\mathbf{A}_{\mathrm{u}}$, we have

$$\mathfrak{P}^{\mathrm{nc}}(A) \subseteq \mathfrak{P}^{\mathrm{c}}(A) \subseteq \mathfrak{P}^{\mathrm{cr}}(A), \qquad \mathfrak{P}^{\mathrm{u}}(A) \subseteq \mathfrak{P}^{\mathrm{cu}}(A) \subseteq \mathfrak{P}^{\mathrm{cur}}(A),$$

and for any unital algebra $A, \mathfrak{P}^{\mathrm{nc}}(A) \subseteq \mathfrak{P}^{\mathrm{u}}(A), \mathfrak{P}^{\mathrm{c}}(A) \subseteq \mathfrak{P}^{\mathrm{cu}}(A), \mathfrak{P}^{\mathrm{cr}}(A) \subseteq \mathfrak{P}^{\mathrm{cur}}(A).$

Theorem 4.3. $\mathfrak{P}^*: \mathbf{A}_* \to \mathbf{A}_*$ for $* \in \{nc, c, cr, u, cu, cur\}$ is homotopy invariant.

Proof. For morphisms $f, g: A \to B$ in \mathbf{A}_* suppose $H: A \to B[x]$ is an elementary homotopy in \mathbf{A}_* from f to g. For any $a \in \mathfrak{P}^*(A)$, H(a) is constant and hence $f(a) = p_0 H(a) = p_1 H(a) = g(a)$. Thus $\mathfrak{P}^*(f) = \mathfrak{P}^*(g)$. The proof is complete. \square

Theorem 4.4. For any algebra A, we have $\mathfrak{P}^{\mathrm{nc}}(A) = 0$.

Proof. The morphism $A \to \mathcal{M}_2(A)[x]$ defined by

$$a \mapsto \left(\begin{array}{cc} a & 0 \\ 0 & 0 \end{array}\right) + \left(\begin{array}{cc} 0 & a \\ 0 & 0 \end{array}\right) x$$

transforms any nonzero a to a nonconstant polynomial. The proof is complete. \Box

It follows easily from Theorems 2.5 and 4.4 that for any algebra A,

$$\mathfrak{P}^{\mathbf{u}}(A^+) = \mathbb{F}1.$$

Theorem 4.5. For any $A \in \mathbf{A}_{u}$ we have $\mathfrak{P}^{c}(A) = \mathfrak{P}^{cu}(A)$ and $\mathfrak{P}^{cr}(A) = \mathfrak{P}^{cur}(A)$.

Proof. We have $\mathfrak{P}^{c}(A) \subseteq \mathfrak{P}^{cu}(A)$. Let $a \in \mathfrak{P}^{cu}(A)$. For $C \in \mathbf{A}_{c}$ and $\phi : A \to C[x]$ it is easily verified that $\phi(1) \in C$ and $\phi(A) \subseteq \hat{C}[x]$ where $\hat{C} := \{c \in C : \phi(1)c = c\}$. Thus $\phi : A \to \hat{C}[x]$ is a unital morphism and hence $\phi(a) \in \hat{C} \subseteq C$. So $\mathfrak{P}^{cu}(A) \subseteq \mathfrak{P}^{c}(A)$. The other case is similar.

Theorem 4.6. For any algebra A we have $\mathfrak{P}^{c}(A) = p^{-1}\mathfrak{P}^{c}(A_{\text{com}})$ where $p: A \to A_{\text{com}}$ denotes the canonical projection.

Proof. It follows from Lemma 4.2(ii) and the fact that any morphism $\phi : A \to C[x]$ where C is a commutative algebra factors through p.

In general, it is not easy to determine the subalgebras $\mathfrak{P}^*(A)$. We shall consider some other homotopy invariant subfunctors of $\mathrm{id}_{\mathbf{A}_*}$ which are computable and may be applied for our proposes instead of \mathfrak{P}^* . In § 5 we will show that \mathfrak{P}^* is the largest subfunctor among all homotopy invariant subfunctors of $\mathrm{id}_{\mathbf{A}_*}$.

Lemma 4.7. Let C be an algebra and $p = \sum_{i=0}^{n} c_i x^i$ be a polynomial in C[x].

- (i) If C is commutative and if $p^k = p$ for some $k \ge 2$ with the property $\operatorname{Char}(\mathbb{F}) \nmid (k-1)$, then p is constant.
- (ii) If C is unital and has no nonzero nilpotent element and if p is a root of a nonzero polynomial with coefficients in \mathbb{F} , then p is constant.

Proof. (i) We have $c_0^k = c_0$ and $kc_0^{k-1}c_1 = c_1$. Thus $kc_0c_1 = c_0c_1$. This implies that $c_0c_1 = 0$ and therefore $c_1 = 0$. Analogously and respectively, it is proved that $c_2 = 0, \ldots, c_n = 0$. (ii) There are $\lambda_0, \ldots, \lambda_{k-1} \in \mathbb{F}$ with $k \ge 1$ such that $p^k + \lambda_{k-1}p^{k-1} + \cdots + \lambda_0 = 0$. Thus $c_n^k = 0$ and then, by the assumption, we have $c_n = 0$. The proof is complete.

Proposition 4.8. Let A be an algebra and let $a \in A$.

- (i) If $a^k = a$ for some $k \ge 2$ with $\operatorname{Char}(\mathbb{F}) \nmid (k-1)$ then $a \in \mathfrak{P}^{c}(A)$.
- (ii) If a is an idempotent then $a \in \mathfrak{P}^{c}(A)$.
- (iii) If A is unital and a is integral over \mathbb{F} then $a \in \mathfrak{P}^{cur}(A)$.

Proof. (i) and (iii) follow from Lemma 4.7 and the definition of \mathfrak{P}^{c} by the analogue of Lemma 4.2(ii). (ii) follows from (i).

For any algebra A and every $k \geq 2$ let $\mathfrak{I}_k\mathfrak{P}(A) \subseteq A$ denote the subalgebra generated by all elements a with the property $a^k = a$. Let also $\mathfrak{IP}(A) \subseteq A$ denote the subalgebra generated by all elements a such that $a^k = a$ for some $k \geq 2$. For any commutative unital algebra A let $\operatorname{Int}(A) \subseteq A$ denote integral closure of \mathbb{F} in A. It is clear that $\mathfrak{I}_k\mathfrak{P}(A) \subseteq \mathfrak{IP}(A)$ and $\mathfrak{IP}(A) \subseteq \operatorname{Int}(A)$. We have also the subfunctors

$$\mathfrak{IP}, \mathfrak{I}_k\mathfrak{P}: \mathbf{A}_{\mathrm{nc}} \to \mathbf{A}_{\mathrm{nc}} \text{ and } \mathrm{Int}: \mathbf{A}_{\mathrm{cu}} \to \mathbf{A}_{\mathrm{cu}}.$$

Theorem 4.9.

- (i) For any algebra A, if $\operatorname{Char}(\mathbb{F}) \nmid (k-1)$ then $\mathfrak{I}_k \mathfrak{P}(A) \subseteq \mathfrak{P}^{c}(A)$, and if $\operatorname{Char}(\mathbb{F}) = 0$ then $\mathfrak{IP}(A) \subseteq \mathfrak{P}^{c}(A)$.
- (ii) If A is commutative and unital then $Int(A) \subseteq \mathfrak{P}^{cur}(A) = \mathfrak{P}^{cr}(A)$.
- (iii) If $\operatorname{Char}(\mathbb{F}) \nmid (k-1)$ then $\mathfrak{I}_k \mathfrak{P} : \mathbf{A}_c \to \mathbf{A}_c$ is homotopy invariant. If $\operatorname{Char}(\mathbb{F}) = 0$ then $\mathfrak{I}\mathfrak{P} : \mathbf{A}_c \to \mathbf{A}_c$ is homotopy invariant.
- (iv) The functor Int : $\mathbf{A}_{cur} \to \mathbf{A}_{cur}$ is homotopy invariant.

Proof. (i) and (ii) follow from Proposition 4.8. Proofs of (iii) and (iv) are similar to the proof of Theorem 4.3 and follow from Lemma 4.7. \Box

It is easily verified that any subfunctor of $id_{\mathbf{A}_*}$ for $* \in \{nc, c, cr\}$ preserves arbitrary direct sums. Thus we have,

Theorem 4.10. $\mathfrak{I}_k\mathfrak{P}, \mathfrak{IP}, \mathfrak{P}^{cr}, \mathfrak{P}^c : \mathbf{A}_{nc} \to \mathbf{A}_{nc}$ preserve arbitrary direct sums.

For proof of the next lemma we shall need the following fact from elementary Linear Algebra: Let W, W' be vector spaces and $W_0 \subseteq W$ be a vector subspace. Let $x \in W' \otimes W$ be such that for every linear functional $\alpha : W \to \mathbb{F}$ with $\alpha|_{W_0} = 0$ we have $(\mathrm{id}_{W'} \otimes \alpha)(x) = 0$. Then x belongs to $W' \otimes W_0$.

Lemma 4.11. Suppose \mathbb{F} is algebraically closed. Let $A \in \mathbf{A}_{\operatorname{curfg}}$, W be a vector space, and $W_0 \subseteq W$ be a vector subspace. For any $c \in A \otimes W$ if $h \otimes \operatorname{id}_W(c) \in W_0$ for every $h \in \operatorname{Pnt}(A)$, then $c \in A \otimes W_0$.

Proof. Let $Z \subseteq \mathbb{A}^m$ be the zero-locus of a radical ideal $I \subseteq \mathbb{F}[X_m]$ with $A \cong \mathbb{F}[X_m]/I$. We know Z may be identified with $\operatorname{Pnt}_{\neq 0}(A)$ through $\zeta \mapsto (p(X_m) \mapsto p(\zeta))$, and by Hilbert's Nullstellensatz, $A \otimes W$ may be identified with vector space of all functions $f: Z \to W$ such that $f(\zeta) = \sum_i \zeta^i w_i$ for some polynomial $\sum_i w_i X_m^i$ with $w_i \in W$. So, suppose that f be such a representation for c. By assumptions we have $f(\zeta) \in W_0$ for every $\zeta \in Z$. Thus for any linear functional $\alpha : W \to \mathbb{F}$ with $\alpha|_{W_0} = 0$ we have $\operatorname{id}_A \otimes \alpha(c) = \alpha \circ f = 0$. Hence $c \in A \otimes W_0$.

We have the following corollary of Lemma 4.11.

Proposition 4.12. Suppose \mathbb{F} is algebraically closed and let $F : \mathbf{A}_{cur} \to \mathbf{A}_{cur}$ be any subfunctor of $\mathrm{id}_{\mathbf{A}_{cur}}$. Then for every $A, B \in \mathbf{A}_{curfg}$ we have $F(A \otimes B) = F(A) \otimes F(B)$.

Proof. Let $c \in F(A \otimes B) \subseteq A \otimes B$. For any $h \in Pnt(A)$, $h \otimes id_B : A \otimes B \to B$ is a morphism in \mathbf{A}_{cur} and hence $h \otimes id_B(c) \in F(B) \subseteq B$. Thus it follows from Lemma 4.11 that $c \in A \otimes F(B)$. Similarly, $c \in F(A) \otimes B$. Thus $c \in F(A) \otimes F(B)$.

Since $x \mapsto x \otimes 1_B$ and $y \mapsto 1_A \otimes y$ define two morphisms $A \to A \otimes B$ and $B \to A \otimes B$ in \mathbf{A}_{cur} , we have $a \otimes 1_B \in F(A \otimes B)$ and $1_A \otimes b \in F(A \otimes B)$ for every $a \in F(A)$ and $b \in F(B)$. Thus $F(A) \otimes F(B) \subseteq F(A \otimes B)$.

The following theorem follows directly from Proposition 4.12.

Theorem 4.13. Suppose \mathbb{F} is algebraically closed. Then the functors

$$\mathfrak{P}^{\mathrm{c}}, \mathfrak{P}^{\mathrm{cr}}, \mathfrak{IP}, \mathfrak{I}_k \mathfrak{P}, \mathrm{Int}: \mathbf{A}_{\mathrm{curfg}} \to \mathbf{A}_{\mathrm{cur}}$$

preserve tensor product.

For any affine scheme $S = \mathcal{S}(A)$ $(A \in \mathbf{A}_{cu})$ the affine scheme of path-connected components of S is defined to be the affine scheme

$$\pi_0(S) := \mathcal{S}(\mathfrak{P}^{\mathrm{cu}}(A)). \tag{7}$$

Thus π_0 may be considered as a \mathbb{A}^1 -homotopy invariant functor

$$\pi_0: \mathbf{Aff} \to \mathbf{Aff}.$$

Recall that an affine group-scheme is a group object G in Aff. Suppose that G = S(A). Then the group structure of G is induced by a Hopf algebra structure on A. In case \mathbb{F} is algebraically closed and G is an affine variety, G is called affine group-variety. Note that in this case A is a finitely generated integral domain.

Theorem 4.14. For any affine group-variety G, $\pi_0(G)$ is an affine group-scheme.

Proof. It follows from Theorem 4.13.

For a discussion on path-connected components of algebraic groups see [13, Chapter 2]. The following important theorem and its proof have been kindly offered to me by Professor Cortiñas.

Theorem 4.15. Suppose that $\operatorname{Char}(\mathbb{F}) = 0$. Then

$$\pi_0(S) = \mathcal{H}^0_{\mathrm{deR}}(S) \qquad (S \in \mathbf{Aff}).$$

Proof. Let S = S(A). Consider the universal derivation $d : A \to \Omega^1(A)$ as described in §3. We must show that $\ker(d) = \mathfrak{P}^{\mathrm{cu}}(A)$. Let \overline{A} denote the commutative unital algebra with underlying vector space $A \oplus \Omega^1(A)$ and multiplication given by $(a, \omega)(a', \omega') = (aa', a\omega' + a'\omega)$ for $a, a' \in A$ and $\omega, \omega' \in \Omega^1(A)$. Then the assignment $a \mapsto a + d(a)x$ defines a morphism from A into $\overline{A}[x]$. Thus if $a \in \mathfrak{P}^{\mathrm{cu}}(A)$ then d(a) = 0. Hence $\mathfrak{P}^{\mathrm{cu}}(A) \subseteq \ker(d)$. Suppose that $a \in \ker(d)$. Let $\phi : A \to B[x]$ be an arbitrary unit preserving morphism for a commutative unital algebra B. B[x] can be considered as a unital A-module through ϕ . Let $D : B[x] \to B[x]$ denote the ordinary derivation given by $D(\sum_{i=0}^{n} b_i x^i) = \sum_{i=1}^{n} i b_i x^{i-1}$. Then $D\phi : A \to B[x]$ is a derivation into the A-module B[x]. Thus $D\phi(a) = 0$. This means that $\phi(a)$ must be a constant polynomial and hence $a \in \mathfrak{P}^{\mathrm{cu}}(A)$. The proof is complete.

5 Costrict homotopization

Definition 5.1. Let \mathbf{A} be an admissible category of algebras and \mathbf{C} be an arbitrary category. The costrict homotopization of a functor $F : \mathbf{A} \to \mathbf{C}$ is defined to be a homotopy invariant functor $\lfloor F \rfloor : \mathbf{A} \to \mathbf{C}$ coming with a natural transformation $\alpha_F : F \to \lfloor F \rfloor$ such that the following universal property is satisfied: For any homotopy invariant functor $G : \mathbf{A} \to \mathbf{C}$ and any natural transformation $\beta : F \to G$ there is a unique natural transformation $\beta : |F| \to G$ such that $\beta = \beta \alpha_F$.

It is clear that if $\lfloor F \rfloor$ exists then it is unique up to a natural isomorphism. Also, for any homotopy invariant functor F we have |F| = F.

Note that Definition 5.1 is a simple generalization of Weibel's concept of strict homotopization ([21, 7]). It seems that this concept at the first time has been considered by Gersten [9]. **Theorem 5.2.** Suppose C has finite coequalizers. Then any functor $F : \mathbf{A} \to \mathbf{C}$ has a costrict homotopization.

Proof. For any $A \in \mathbf{A}$ let $\alpha_F(A) : F(A) \to \lfloor F \rfloor(A)$ be a coequalizer of

$$F(\mathbf{p}_0), F(\mathbf{p}_1) : F(A[x]) \to F(A)$$

in **C**. For any morphism $f : A \to B$ in **A**, the coequalizer property of $\lfloor F \rfloor(A)$ implies the existence of a unique morphism $\lfloor F \rfloor(f)$ in **C** making the diagram

$$F(A[x]) \xrightarrow{F(p_0)} F(A) \xrightarrow{\alpha_F(A)} \lfloor F \rfloor(A)$$

$$F(f[x]) \bigvee F(f) \bigvee [F \rfloor(f)]$$

$$F(B[x]) \xrightarrow{F(p_0)} F(B) \xrightarrow{\alpha_F(B)} \lfloor F \rfloor(B)$$

commutative. Thus $\lfloor F \rfloor$ may be considered as a functor. Suppose that $H : A \to B[x]$ is an elementary homotopy from f to g. We have

$$\alpha_F(B)F(f) = \alpha_F(B)(F(\mathbf{p}_0)F(H)) = (\alpha_F(B)F(\mathbf{p}_0))F(H)$$

= $(\alpha_F(B)F(\mathbf{p}_1))F(H) = \alpha_F(B)(F(\mathbf{p}_1)F(H)) = \alpha_F(B)F(g)$

Thus $\lfloor F \rfloor(f) = \lfloor F \rfloor(g)$, and therefore $\lfloor F \rfloor$ is homotopy invariant. Suppose $G : \mathbf{A} \to \mathbf{C}$ is homotopy invariant and $\beta : F \to G$ is a natural transformation. By Lemma 3.6(iii), $G(\mathbf{p}_0) = G(\mathbf{p}_1)$, and hence universality of the coequalizer $\lfloor F \rfloor(A)$ implies the existence of a morphism $\beta(A)$ making the following diagram commutative:

$$F(A[x]) \xrightarrow{F(p_0)} F(A) \xrightarrow{\alpha_F(A)} [F](A)$$

$$\beta(A[x]) \qquad \qquad \beta(A) \qquad \qquad \beta$$

It can be seen easily from the proof of Theorem 5.2 that for the identity functor $id : \mathbf{A} \to \mathbf{A}$ we have $\lfloor id \rfloor = 0$. (Indeed, it follows from the fact that for any $A \in \mathbf{A}$ and every $a, b \in A$, $p_0(a + (b - a)x) = a$ and $p_1(a + (b - a)x) = b$.) Also, for any affine scheme S = S(A) regarded as the functor

$$S = \operatorname{Hom}_{\mathbf{A}_{cu}}(A, ?) : \mathbf{A}_{cu} \to \mathbf{Set}$$
(8)

we have

$$\lfloor S \rfloor = [A, ?]. \tag{9}$$

A cotype for the concept of strict homotopization may be defined as follows.

Definition 5.3. Let **A** be an admissible category of algebras and **C** be an arbitrary category. The costrict homotopization of a functor $F : \mathbf{A} \to \mathbf{C}$ is defined to be a homotopy invariant functor $[F] : \mathbf{A} \to \mathbf{C}$ coming with a natural transformation $\alpha^F : [F] \to F$ such that the following universal property is satisfied: For any homotopy invariant functor $G : \mathbf{A} \to \mathbf{C}$ and any natural transformation $\beta : G \to F$ there is a unique natural transformation $\overline{\beta} : G \to [F]$ such that $\beta = \alpha^F \overline{\beta}$.

It is clear that if $\lceil F \rceil$ exists then it is unique up to a natural isomorphism. Also, for any homotopy invariant functor F we have $\lceil F \rceil = F$.

The following theorem is one of the main results of this note.

Theorem 5.4. Suppose **C** has finite equalizers and arbitrary inverse limits. Then any functor $F : \mathbf{A}_* \to \mathbf{C}$, where $* \in \{\text{nc}, \text{c}, \text{cr}, \text{u}, \text{cu}, \text{cur}\}$, has a costrict homotopization.

Proof. Let $\mathbf{A}, \mathfrak{M}, \Upsilon$ denote $\mathbf{A}_*, \mathfrak{M}^*, \Upsilon^*$. For any $A \in \mathbf{A}$, let $\alpha^F(A) : \lceil F \rceil(A) \to F(A)$ denote the equalizer of the morphisms

$$\hat{\mathfrak{p}}_0, \hat{\mathfrak{p}}_1 : F(A) \to \underline{\lim} F(\mathfrak{M}_{A,\mathbb{F}[x]}),$$

given (similarly to $\mathfrak{p}_0, \mathfrak{p}_1$ in Definition 4.1) by

$$\hat{\mathfrak{p}}_0 := \varprojlim F[((x \mapsto 0) \otimes \operatorname{id}) \Upsilon_{A, \mathbb{F}[x]}] \text{ and } \hat{\mathfrak{p}}_1 := \varprojlim F[((x \mapsto 1) \otimes \operatorname{id}) \Upsilon_{A, \mathbb{F}[x]}].$$

For any $f : A \to B$ in **A**, by the universal property of the equalizer $\lceil F \rceil(B)$, there is a unique morphism $\lceil F \rceil(f)$ making the following diagram commutative:

$$\begin{bmatrix} F \rceil(A) \xrightarrow{\alpha^{F}(A)} & & \\ \lceil F \rceil(f) & & \downarrow \\ \lceil F \rceil(B) \xrightarrow{\alpha^{F}(B)} & & \downarrow \\ mrac{m}{\sim} F \end{bmatrix} \begin{pmatrix} A \xrightarrow{\Upsilon_{A,\mathbb{F}[x]}} \mathbb{F}[x] \otimes \mathfrak{M}_{A,\mathbb{F}[x]} \xrightarrow{x \mapsto 0} & \mathfrak{M}_{A,\mathbb{F}[x]} \\ f & & \downarrow \\ f & & \downarrow \\ B \xrightarrow{\Upsilon_{B,\mathbb{F}[x]}} \mathbb{F}[x] \otimes \mathfrak{M}_{B,\mathbb{F}[x]} \xrightarrow{x \mapsto 0} & \mathfrak{M}_{B,\mathbb{F}[x]} \end{pmatrix}$$

Thus $\lceil F \rceil$ may be considered as a functor. Suppose that $H : A \to B[x]$ is an elementary homotopy from f to g. Let $\overline{H} : \mathfrak{M}_{A,\mathbb{F}[x]} \to B$ denote the associated pro-morphism of H. We have

$$f = \overline{H}\big((x \mapsto 0) \otimes \operatorname{id}\big)\Upsilon_{A,\mathbb{F}[x]} \quad \text{and} \quad g = \overline{H}\big((x \mapsto 1) \otimes \operatorname{id}\big)\Upsilon_{A,\mathbb{F}[x]}.$$

It follows that,

$$\begin{split} (\varprojlim F(f))\alpha^F(A) &= (\varprojlim F(\overline{H}))\hat{\mathfrak{p}}_0\alpha^F(A) \\ &= (\varprojlim F(\overline{H}))\hat{\mathfrak{p}}_1\alpha^F(A) \\ &= (\varinjlim F(g))\alpha^F(A). \end{split}$$

This implies that $\lceil F \rceil(f) = \lceil F \rceil(g)$, and hence $\lceil F \rceil$ is homotopy invariant. Suppose $G : \mathbf{A} \to \mathbf{C}$ is homotopy invariant and $\beta : G \to F$ is a natural transformation. We

have the following commutative diagram in pro-C:

$$\begin{array}{c} F(A) \xrightarrow{F(\Upsilon_{A,\mathbb{F}[x]})} F(\mathbb{F}[x] \otimes \mathfrak{M}_{A,\mathbb{F}[x]}) \xrightarrow{F(x \mapsto 0)} F(\mathfrak{M}_{A,\mathbb{F}[x]}) \\ \xrightarrow{\beta(A)} & & & & & & \\ G(A) \xrightarrow{-G(\Upsilon_{A,\mathbb{F}[x]})} G(\mathbb{F}[x] \otimes \mathfrak{M}_{A,\mathbb{F}[x]}) \xrightarrow{G(x \mapsto 0)} G(\mathfrak{M}_{A,\mathbb{F}[x]}) \end{array}$$

On the other hand, by Lemma 3.6(iii), the pro-morphisms

$$G(\mathbb{F}[x] \otimes \mathfrak{M}_{A,\mathbb{F}[x]}) \xrightarrow{G(x \mapsto 0)}_{\overline{G(x \mapsto 1)}} G(\mathfrak{M}_{A,\mathbb{F}[x]})$$

are (componentwise) equal. Hence we have

$$\hat{\mathfrak{p}}_0\beta(A) = \hat{\mathfrak{p}}_1\beta(A).$$

Now, it follows from the universal property of the equalizer $\lceil F \rceil(A)$ that there is a unique morphism $\overline{\beta}(A) : G(A) \to \lceil F \rceil(A)$ satisfying $\beta(A) = \alpha^F(A)\overline{\beta}(A)$.

The following is seen directly from Definition 4.1 and the proof of Theorem 5.4.

Theorem 5.5. The functor $\mathfrak{P}^* : \mathbf{A}_* \to \mathbf{A}_*$ is a costrict homotopization of the identity functor id : $\mathbf{A}_* \to \mathbf{A}_*$. Therefore, in a sense, \mathfrak{P}^* is the greatest homotopy invariant subfunctor of id.

More generally, the following result is also seen from the above theorem and the proof of Theorem 5.4.

Theorem 5.6. Let **C** be a category with arbitrary limits and $F : \mathbf{A}_* \to \mathbf{C}$ be a functor that preserves arbitrary limits. Then $[F] = F \circ \mathfrak{P}^*$.

As a direct corollary of the above theorem we have,

Corollary 5.7. Let *S* denote an ordinary scheme over \mathbb{F} regarded as a Zariski-sheaf $\mathbf{A}_{cu} \to \mathbf{Set}$ [6]. Then $\lceil S \rceil = S \circ \mathfrak{P}^{cu}$.

In particular in case S is an affine scheme regarded as the functor (8) we have

$$[S] = \operatorname{Hom}_{\mathbf{A}_{cu}}(A, \mathfrak{P}^{cu}(?)).$$
(10)

Thus for any affine scheme S we have defined three types $\pi_0(S), \lfloor S \rfloor, \lceil S \rceil$ of homo-topizations given by (7),(9),(10).

Remark 5.8. It is clear that the concept of (co)strict homotopization can be defined for any functor $F : \mathbf{B} \to \mathbf{C}$ where **B** is a category with a compatible relation as defined in §3, or more generally, for any category **B** with a class of weak equivalences. Also it seems that the analogues of Theorems 5.2 and 5.4 can be stated for model categories B with natural cylinder and path objects [2, §I.3 and §I.3a].

6 Intrinsic Singular Cohomology

Let $\Delta := \{\mathbf{n}\}$ denote the category of finite ordinals $\mathbf{n} := \{0 < \ldots < n\}$. The standard simplicial algebra [4, 7] $\mathbb{F}[\Delta] \in \text{sim-}\mathbf{A}_{cu}$ is given by the following assignments:

$$\mathbf{n} \mapsto \mathbb{F}[\Delta_n] := \mathbb{F}[x_0, \dots, x_n] / \langle 1 - \sum_{i=0}^n x_i \rangle, \qquad (\alpha : \mathbf{n} \to \mathbf{m}) \mapsto ([x_i] \mapsto \sum_{j \in \alpha^{-1}(i)} [x_j]).$$

For $* \in \{nc, c, cr, u, cu, cur\}$, consider the functors

$$\mathfrak{S}^* := \mathfrak{M}^*(?, \mathbb{F}[\Delta]) \quad \text{and} \quad \underbrace{\mathfrak{S}}^* := \varprojlim \mathfrak{M}^*(?, \mathbb{F}[\Delta])$$

given by:

$$\begin{split} \mathfrak{S}^* : \mathbf{A}_{\mathrm{nc}} / \mathbf{A}_{\mathrm{u}} &\to \operatorname{cosim-pro-} \mathbf{A}_* \quad A \mapsto \left(\mathbf{n} \mapsto \mathfrak{M}^* (A, \mathbb{F}[\Delta_n]) \right) \\ \underline{\mathfrak{S}}^* : \mathbf{A}_{\mathrm{nc}} / \mathbf{A}_{\mathrm{u}} \to \operatorname{cosim-} \mathbf{A}_* \quad A \mapsto \left(\mathbf{n} \mapsto \varprojlim \mathfrak{M}^* (A, \mathbb{F}[\Delta_n]) \right) \end{split}$$

Let $F : \mathbf{A}_* \to \mathbf{Ab}$ be an arbitrary functor. For any $A \in \mathbf{A}_{nc}/\mathbf{A}_u$, we have the cosimplicial abelian groups $F \mathfrak{S}^*(A)$ and $\varprojlim F \mathfrak{S}^*(A)$. Let $\mathfrak{N} : \operatorname{cosim-Ab} \to \operatorname{coChain}$ denote the normalization functor. We let (see [20, § 8.4]):

$$\mathcal{H}_{F}^{n}(A) := \mathrm{H}^{n}\mathfrak{N}F\mathfrak{S}^{*}(A) \cong \pi^{n}(F\mathfrak{S}^{*}(A), 0)$$
$$\underline{\mathcal{H}}_{F}^{n}(A) := \mathrm{H}^{n}\mathfrak{N}\underbrace{\lim}_{F}F\mathfrak{S}^{*}(A) \cong \pi^{n}(\underbrace{\lim}_{F}F\mathfrak{S}^{*}(A), 0)$$

It is clear that $\overline{\mathcal{H}}_{F}^{n}$ and $\underline{\mathcal{H}}_{F}^{n}$ may be considered as the functors

$$\overline{\mathcal{H}}_{F}^{n}, \underline{\mathcal{H}}_{F}^{n}: \mathbf{A}_{\mathrm{nc}}/\mathbf{A}_{\mathrm{u}}
ightarrow \mathbf{Ab}$$

We have a canonical natural transformation $\mathfrak{S}^* \to \mathfrak{S}^*$ induced by the inverse limits. This, in turn, induces the canonical natural transformations

$$F \underbrace{\mathfrak{S}}^* \to \varprojlim F \mathfrak{S}^*$$
 and (hence) $\overline{\mathcal{H}}_F^n \to \underline{\mathcal{H}}_F^n$.

Theorem 6.1. The functors $\overline{\mathcal{H}}_F^n$ and $\underline{\mathcal{H}}_F^n$ are homotopy invariant.

The proof is an adaptation of the usual proof of homotopy invariance of singular cohomology of topological spaces by using prism operators. See [12, Theorem 2.10].

Proof. For every $0 \le i \le n$, let $\phi_i^n : \mathbb{F}[\Delta_n] \otimes \mathbb{F}[x] \to \mathbb{F}[\Delta_{n+1}]$ be defined by $[x_j] \mapsto [x_j]$ if j < i; $[x_i] \mapsto [x_i + x_{i+1}]$; $[x_j] \mapsto [x_{j+1}]$ if j > i; and $x \mapsto [x_{i+1} + \cdots + x_{n+1}]$. For every algebra B let

$$\Gamma_n: \mathfrak{M}(B \otimes \mathbb{F}[x], \mathbb{F}[\Delta_n] \otimes \mathbb{F}[x]) \to \mathfrak{M}(B, \mathbb{F}[\Delta_n])$$

be the unique pro-morphism satisfying

$$(\mathrm{id}_{\mathbb{F}[\Delta_n]} \otimes \mathrm{flip})(\Upsilon_{B,\mathbb{F}[\Delta_n]} \otimes \mathrm{id}_{\mathbb{F}[x]}) = (\mathrm{id}_{\mathbb{F}[\Delta_n]} \otimes \mathrm{id}_{\mathbb{F}[x]} \otimes \Gamma_n)\Upsilon_{B \otimes \mathbb{F}[x],\mathbb{F}[\Delta_n] \otimes \mathbb{F}[x]}.$$

Suppose that $H: A \to B \otimes \mathbb{F}[x]$ is an elementary homotopy from f to g. Let

$$\hat{\phi}_i^n : \underline{\lim} \mathfrak{M}(A, \mathbb{F}[\Delta_{n+1}]) \to \underline{\lim} \mathfrak{M}(B, \mathbb{F}[\Delta_n])$$

be given by

$$\hat{\phi}_i^n := \varprojlim \left(\Gamma_n \mathfrak{M}(H, \mathbb{F}[\Delta_n] \otimes \mathbb{F}[x]) \mathfrak{M}(A, \phi_i^n) \right),\$$

and let the prism operator

$$P^n: F(\varprojlim \mathfrak{M}(A, \mathbb{F}[\Delta_{n+1}])) \to F(\varprojlim \mathfrak{M}(B, \mathbb{F}[\Delta_n]))$$

be given by $P^n := \sum_{i=0}^n (-1)^i F(\hat{\phi}_i^n)$. Then, it can be checked that $(P^n)_n$ is a cochain homotopy between $\mathfrak{NF} \underbrace{\mathfrak{S}}(f)$ and $\mathfrak{NF} \underbrace{\mathfrak{S}}(g)$, and hence $\overline{\mathcal{H}}_F^n(f) = \overline{\mathcal{H}}_F^n(g)$. Thus $\overline{\mathcal{H}}_F^n$ is homotopy invariant. Homotopy invariance of $\underline{\mathcal{H}}_F^n$ is obtained similarly.

Theorem 6.2. We have the following natural isomorphism of abelian groups:

$$\overline{\mathcal{H}}_F^0(A) \cong \lceil F \rceil(A) \qquad (A \in \mathbf{A}_*)$$

Proof. It follows from the proof of Theorem 5.4 and definition of $\overline{\mathcal{H}}_{F}^{0}(A)$. (Note that we are required to have $A \cong \mathfrak{M}_{A,\mathbb{F}[\Delta_{0}]}^{*}$. Thus A must be in \mathbf{A}_{*} .)

So, the restricted functors

$$\overline{\mathcal{H}}_{F}^{n}:\mathbf{A}_{*}
ightarrow\mathbf{Ab}$$

may be interpreted as a sort of *higher* costrict homotopizations of $F : \mathbf{A}_* \to \mathbf{Ab}$.

In case F is the identity functor $id: \mathbf{A}_* \to \mathbf{A}_*$, we put

$$\mathcal{H}^n_*(A) := \overline{\mathcal{H}}^n_F(A) = \underline{\mathcal{H}}^n_F(A).$$

Thus we have defined the homotopy invariant functors

$$\mathcal{H}_{\mathrm{nc}}^{n}, \mathcal{H}_{\mathrm{c}}^{n}, \mathcal{H}_{\mathrm{cr}}^{n}: \mathbf{A}_{\mathrm{nc}} \to \mathbf{Vec} \quad \mathrm{and} \quad \mathcal{H}_{\mathrm{u}}^{n}, \mathcal{H}_{\mathrm{cu}}^{n}, \mathcal{H}_{\mathrm{cur}}^{n}: \mathbf{A}_{\mathrm{u}} \to \mathbf{Vec}.$$

From (3) we have the natural transformations

$$\mathcal{H}_{\mathrm{nc}}^n \to \mathcal{H}_{\mathrm{c}}^n \to \mathcal{H}_{\mathrm{cr}}^n \quad \mathrm{and} \quad \mathcal{H}_{\mathrm{u}}^n \to \mathcal{H}_{\mathrm{cu}}^n \to \mathcal{H}_{\mathrm{cur}}^n$$

For any algebra A it can be easily checked that

$$\mathcal{H}^{0}_{\mathrm{nc}}(A) = \mathfrak{P}^{\mathrm{nc}}(A) = 0, \ \mathcal{H}^{0}_{\mathrm{c}}(A) = \mathfrak{P}^{\mathrm{c}}(A_{\mathrm{com}}), \ \mathcal{H}^{0}_{\mathrm{cr}}(A) = \mathfrak{P}^{\mathrm{cr}}((A_{\mathrm{com}})_{\mathrm{red}})$$
(11)

Analogous identities are satisfied for unital cases. By Theorem 4.5 we have

$$\mathcal{H}^{0}_{c}(A) = \mathcal{H}^{0}_{cu}(A), \quad \mathcal{H}^{0}_{cr}(A) = \mathcal{H}^{0}_{cur}(A) \quad (A \in \mathbf{A}_{u}).$$
(12)

We now define a cup product between the cocycles: Let the morphisms $\phi_{n,m}, \psi_{n,m}$ be given by

$$\phi_{n,m}: \mathbb{F}[\Delta_{n+m}] \to \mathbb{F}[\Delta_n], \quad [x_i] \mapsto [x_i] \text{ if } 0 \le i \le n \text{ and } [x_i] \mapsto 0 \text{ otherwise}$$

$$\psi_{n,m}: \mathbb{F}[\Delta_{n+m}] \to \mathbb{F}[\Delta_m], \quad [x_{n+i}] \mapsto [x_i] \text{ if } 0 \le i \le m \text{ and } [x_i] \mapsto 0 \text{ otherwise}$$

We let the cup product of the cochains

$$c_n \in \varprojlim \mathfrak{M}^*_{A, \mathbb{F}[\Delta_n]}$$
 and $c_m \in \varprojlim \mathfrak{M}^*_{A, \mathbb{F}[\Delta_m]}$

be given by

$$c_n \sim c_m := \left(\varprojlim \mathfrak{M}^*_{A,\phi_{n,m}}(c_n) \right) \left(\varprojlim \mathfrak{M}^*_{A,\psi_{n,m}}(c_m) \right) \in \varprojlim \mathfrak{M}^*_{A,\mathbb{F}[\Delta_{n+m}]}.$$

It can be checked that \smile makes the graded vector space $\bigoplus_{n=0}^{\infty} \varprojlim \mathfrak{M}^*_{A,\mathbb{F}[\Delta_n]}$ to a DGCA. Hence, \smile can be considered as a multiplication on

$$\mathcal{H}_*(A) := \bigoplus_{n=0}^{\infty} \mathcal{H}^n_*(A),$$

making it to a GCA.

For any affine scheme S = S(A) $(A \in \mathbf{A}_{cu})$ the *intrinsic singular cohomology* algebra of S is defined to be the GCA given by

$$\mathcal{H}_{\operatorname{sing}}(S) = \bigoplus_{n=0}^{\infty} \mathcal{H}_{\operatorname{sing}}^n(S) := \mathcal{H}_{\operatorname{cu}}(A).$$

Thus we have defined a \mathbb{A}^1 -homotopy invariant cohomology theory

$$\mathcal{H}_{sing}: \mathbf{Aff}^{op} \to \mathbf{A}_{u}.$$

We end this section by the following result.

Theorem 6.3. de Rham Theorem at degree zero. Suppose $\operatorname{Char}(\mathbb{F}) = 0$. For any affine scheme S the graded-algebra morphism $\mathcal{H}_{\operatorname{deR}}(S) \to \mathcal{H}_{\operatorname{sing}}(S)$ induced by the universal property of de Rham complex is an isomorphism at degree zero:

$$\mathcal{H}^0_{deR}(S) \cong \mathcal{H}^0_{sing}(S).$$

Proof. It follows from Theorem 4.15, and identities (11) and (12).

7 Generalized Morphisms Between Algebras

For any algebra A denote by $\mathfrak{I}(A)$ (resp. $\mathfrak{I}_{\ell}(A), \mathfrak{I}_{r}(A)$) the set of all ideals (resp. left, right ideals) of A. Also, let $\mathfrak{I}_{*}(A) \subseteq \mathfrak{I}(A)$ where $* \in \{\text{prpr, fcodim, prm, max}\}$ denote respectively the subset of proper, proper with finite codimension, prime, and maximal ideals of A. \mathfrak{I} may be considered as a functor $\mathbf{A}_{nc}^{op} \to \mathbf{Set}$ in the obvious way. Similarly, we have the functors $\mathfrak{I}_{\ell}, \mathfrak{I}_{r} : \mathbf{A}_{nc}^{op} \to \mathbf{Set}, \mathfrak{I}_{prpr}, \mathfrak{I}_{fcodim} : \mathbf{A}_{u}^{op} \to \mathbf{Set}$, and $\mathfrak{I}_{prm} : \mathbf{A}_{cu}^{op} \to \mathbf{Set}$, and in case \mathbb{F} is algebraically closed, the functor $\mathfrak{I}_{max} : \mathbf{A}_{cufg}^{op} \to \mathbf{Set}$. Thus by the canonical extension we have also the functors

$$\mathfrak{I},\mathfrak{I}_\ell,\mathfrak{I}_\mathrm{r}:\mathrm{pro}\text{-}\mathbf{A}^\mathrm{op}_\mathrm{nc}\to\mathrm{ind}\text{-}\mathbf{Set},\ \ \mathfrak{I}_\mathrm{prpr},\mathfrak{I}_\mathrm{fcodim}:\mathrm{pro}\text{-}\mathbf{A}^\mathrm{op}_\mathrm{u}\to\mathrm{ind}\text{-}\mathbf{Set}$$

 $\mathfrak{I}_{\mathrm{prm}}:\mathrm{pro}\text{-}\mathbf{A}_{\mathrm{cu}}^{\mathrm{op}}\rightarrow\mathrm{ind}\text{-}\mathbf{Set},\quad\mathfrak{I}_{\mathrm{max}}:\mathrm{pro}\text{-}\mathbf{A}_{\mathrm{cufg}}^{\mathrm{op}}\rightarrow\mathrm{ind}\text{-}\mathbf{Set}.$

For $A \in \text{pro-}\mathbf{A}_{nc}$ we call any member of the set $\varinjlim \mathfrak{I}(A)$ a pro-ideal of A. We need some facts and definitions: Let $A = (A_i, \phi_{i'i})$ be a pro-algebra. (i) Any pro-ideal Tof A is a class $[T_i]$ of the equivalence relation \sim on $\bigcup_i \mathfrak{I}(A_i)$ defined by

$$\left(T_i \sim T_{i'}\right) \Leftrightarrow \left(\exists i'' \ge i', i : \phi_{i''i}^{-1}(T_i) = \phi_{i''i'}^{-1}(T_{i'})\right) \text{ for } T_i \in \mathfrak{I}(A_i), T_{i'} \in \mathfrak{I}(A_{i'}).$$

(ii) For any pro-morphism f from A into an algebra B we let ker(f) denote the proideal $[\varinjlim \Im(f)](0)$ of A where 0 denotes the zero-ideal of B. (Note that the notion of zero pro-ideal is meaningless.) (iii) For pro-ideals $T = [T_i], T' = [T'_{i'}]$ of A we let the pro-ideal $T \cap T'$ be defined by $[\phi_{i''i}^{-1}(T_i) \cap \phi_{i''i'}^{-1}(T'_{i'})]$ where i'' is an arbitrary index greater than i and i'. It is easily verified that the *intersection* $T \cap T'$ is welldefined. We write $T \subseteq T'$ and say that T' includes T if there exists $i'' \geq i, i'$ such that $\phi_{i''i}^{-1}(T_i) \subseteq \phi_{i''i'}^{-1}(T'_{i'})$. It can be checked that *inclusion* is a well-defined partial ordering on pro-ideals.

In (iv)-(vii) below suppose $A = (A_i, \phi_{i'i}), B = (B_j, \psi_{j'j})$ are pro-algebras such that all structural morphisms $\phi_{i'i}, \psi_{j'j}$ are surjective: (iv) If $T_i \in \mathfrak{I}(A_i)$ and $T_{i'} \in \mathfrak{I}(A_{i'})$ represent the same pro-ideal T of A, then

$$A_i/T_i \cong A_{i''}/\phi_{i''i}^{-1}(T_i) = A_{i''}/\phi_{i''i'}^{-1}(T_{i'}) \cong A_{i'}/T_{i'}$$
 (for some $i'' \ge i, i'$).

Thus we can define the associated quotient algebra up to isomorphism by $A/T := A_i/T_i$. Note that we have a canonical quotient pro-morphism $q_T : A \to A/T$ represented by the quotient morphism $q_{T_i} : A_i \to A_i/T_i$. Also, $T = \ker(q_T)$. (v) It is clear that if for every indexes i, i' the algebras $A_i, A_{i'}$ are considered as ideals in themselves then $[A_i] = [A_{i'}]$. We denote the pro-ideal $[A_i]$ of A by A_{ideal} . (vi) For pro-ideals $T = [T_i], T' = [T'_{i'}]$ of A we let the pro-ideal T + T' be defined by $[\phi_{i''i}^{-1}(T_i) + \phi_{i''i'}^{-1}(T'_{i'})]$ where i'' is an arbitrary index with $i'' \ge i, i'$. The sum T + T' is well-defined. (vii) For pro-ideals $T = [T_i], S = [S_j]$ of A, B we associate a pro-ideal of $A \otimes B$ given by

$$T \otimes B_{\text{ideal}} + A_{\text{ideal}} \otimes S := [T_i \otimes B_j + A_i \otimes S_j]$$

It is easily checked that this is well-defined. $(T \otimes S := [T_i \otimes S_j]$ is not well-defined.) We define a category $\bar{\mathbf{A}}_{nc}$ as follows: The objects of $\bar{\mathbf{A}}_{nc}$ are those of \mathbf{A}_{nc} , and

$$\operatorname{Hom}_{\bar{\mathbf{A}}_{\operatorname{nc}}}(A,B) := \varinjlim \mathfrak{I}(\mathfrak{M}_{A,B}^{\operatorname{nc}}).$$

The composition \circ : $\operatorname{Hom}_{\bar{\mathbf{A}}_{nc}}(B,C) \times \operatorname{Hom}_{\bar{\mathbf{A}}_{nc}}(A,B) \to \operatorname{Hom}_{\bar{\mathbf{A}}_{nc}}(A,C)$ is given by

$$\varinjlim \mathfrak{I}(\mathfrak{M}_{B,C}) \times \varinjlim \mathfrak{I}(\mathfrak{M}_{A,B}) \to \varinjlim \mathfrak{I}(\mathfrak{M}_{B,C} \otimes \mathfrak{M}_{A,B}) \to \varinjlim \mathfrak{I}(\mathfrak{M}_{A,C})$$

where the first map is given by

$$(T,S) \mapsto T \otimes (\mathfrak{M}_{A,B})_{ideal} + (\mathfrak{M}_{B,C})_{ideal} \otimes S$$

and the second map is $\lim \mathfrak{I}(\Phi_{A,B,C})$. Equivalently, we may let

$$T \circ S := \ker[(\mathbf{q}_T \otimes \mathbf{q}_S) \Phi_{A,B,C}].$$

Associativity of \circ follows from (4). For any morphism $f : A \to B$ in \mathbf{A}_{nc} denote by $\overline{f} \in \operatorname{Pnt}(\mathfrak{M}_{A,B})$ the point associated with f. By Corollary 2.4 the assignment $f \mapsto \ker(\overline{f})$ defines an embedding of $\operatorname{Hom}_{\mathbf{A}_{nc}}(A, B)$ into $\operatorname{Hom}_{\overline{\mathbf{A}}_{nc}}(A, B)$. We have

$$\mathrm{id}_{\mathfrak{M}_{A,B}} = \left(\mathfrak{M}_{A,B} \xrightarrow{\Phi_{A,A,B}} \mathfrak{M}_{A,B} \otimes \mathfrak{M}_{A,A} \xrightarrow{\mathrm{id}_{\mathfrak{M}_{A,B}} \otimes \mathrm{id}_{A}} \mathfrak{M}_{A,B} \otimes \mathbb{F} \cong \mathfrak{M}_{A,B} \right)$$

where $\overline{\mathrm{id}}_A \in \mathrm{Pnt}(\mathfrak{M}_{A,A})$ denotes the pro-morphism associated to id_A . Thus for any pro-ideal T of $\mathfrak{M}_{A,B}$, $T \circ \ker(\overline{\mathrm{id}}_A) = T$, and similarly, $\ker(\overline{\mathrm{id}}_B) \circ T = T$. For morphisms $f : A \to B$ and $g : B \to C$ in \mathbf{A}_{nc} the identity $(\overline{g} \otimes \overline{f}) \Phi_{A,B,C} = \overline{gf}$ implies that $\ker(\overline{g}) \circ \ker(\overline{f}) = \ker(\overline{gf})$. Hence $\overline{\mathbf{A}}_{\mathrm{nc}}$ is a category containing \mathbf{A}_{nc} . Similarly, we define generalized categories of algebras listed below:

• For $* \in \{\ell, r\}$: $\bar{\mathbf{A}}_{nc}^* \supset \mathbf{A}_{nc}$ with

 $\operatorname{Obj}(\bar{\mathbf{A}}_{\operatorname{nc}}^*) := \operatorname{Obj}(\mathbf{A}_{\operatorname{nc}}) \text{ and } \operatorname{Hom}_{\bar{\mathbf{A}}_{\operatorname{nc}}^*}(A, B) := \underset{}{\operatorname{\lim}} \mathfrak{I}_*(\mathfrak{M}_{A,B}^{\operatorname{nc}}).$

• For $* \in \{\text{prpr}, \text{fcodim}\}: \bar{\mathbf{A}}_u^* \supset \mathbf{A}_u \text{ with }$

$$\operatorname{Obj}(\bar{\mathbf{A}}_{u}^{*}) := \operatorname{Obj}(\mathbf{A}_{u}) \text{ and } \operatorname{Hom}_{\bar{\mathbf{A}}_{u}^{*}}(A, B) := \varinjlim \mathfrak{I}_{*}(\mathfrak{M}_{A,B}^{u}).$$

• $\bar{\mathbf{A}}_{\mathrm{u}}^{\mathrm{prm}} \supset \mathbf{A}_{\mathrm{u}}$ with

$$\operatorname{Obj}(\bar{\mathbf{A}}_{u}^{\operatorname{prm}}) := \operatorname{Obj}(\mathbf{A}_{u}) \text{ and } \operatorname{Hom}_{\bar{\mathbf{A}}_{u}^{\operatorname{prm}}}(A, B) := \underset{}{\operatorname{\underline{\lim}}} \mathfrak{I}_{\operatorname{prm}}(\mathfrak{M}_{A,B}^{\operatorname{cu}}).$$

• In case \mathbb{F} is algebraically closed: $\bar{\mathbf{A}}_{ufg}^{max} \supset \mathbf{A}_{ufg}$ with

$$\operatorname{Obj}(\bar{\mathbf{A}}_{\operatorname{ufg}}^{\max}) := \operatorname{Obj}(\mathbf{A}_{\operatorname{ufg}}) \text{ and } \operatorname{Hom}_{\bar{\mathbf{A}}_{\operatorname{ufg}}^{\max}}(A, B) := \varinjlim \mathfrak{I}_{\max}(\mathfrak{M}_{A,B}^{\operatorname{cu}}).$$

In the following theorem we record some additional properties of these categories.

Theorem 7.1.

- (i) $\bar{\mathbf{A}}_{nc}^{\ell}$ and $\bar{\mathbf{A}}_{nc}^{r}$ are equivalent categories.
- (ii) $\bar{\mathbf{A}}_{u}^{prpr} \supset \bar{\mathbf{A}}_{u}^{fcodim}$. Also $\bar{\mathbf{A}}_{u}^{prpr}$ is equivalent to a subcategory of $\bar{\mathbf{A}}_{nc}$.
- (iii) $\bar{\mathbf{A}}_{u}^{\text{prm}}$ is equivalent to a subcategory of $\bar{\mathbf{A}}_{u}^{\text{prpr}}$.
- (iv) $\bar{\mathbf{A}}_{ufg}^{max}$ and \mathbf{A}_{ufg} are equivalent (\mathbb{F} is supposed to be algebraically closed).

Proof. (i) It follows from Theorem 2.14 that $\mathbf{op} : \mathbf{A}_{nc} \to \mathbf{A}_{nc}$ extends to an equivalence between $\bar{\mathbf{A}}_{nc}^{\ell}$ and $\bar{\mathbf{A}}_{nc}^{r}$. (ii) For every $A, B \in \mathbf{A}_{u}$ let $\psi_{A,B} : \mathfrak{M}_{A,B}^{nc} \to \mathfrak{M}_{A,B}^{u}$ denote the pro-morphism satisfying $\Upsilon_{A,B}^{u} = (\mathrm{id}_{B} \otimes \psi_{A,B})\Upsilon_{A,B}^{nc}$. The functor given by $A \mapsto A$ and

$$\varinjlim \mathfrak{I}(\mathfrak{M}_{A,B}^{\mathrm{u}}) \supset \varinjlim \mathfrak{I}_{\mathrm{prpr}}(\mathfrak{M}_{A,B}^{\mathrm{u}}) \xrightarrow{\lim \mathfrak{I}(\psi_{A,B})} \varinjlim \mathfrak{I}(\mathfrak{M}_{A,B}^{\mathrm{nc}})$$

embeds $\bar{\mathbf{A}}_{u}^{\text{prpr}}$ into $\bar{\mathbf{A}}_{nc}$. The proof of (iii) is similar to that of (ii). (iv) We know that $\mathbf{A}_{ufg} \subset \bar{\mathbf{A}}_{ufg}^{\max}$. Let $A, B \in \mathbf{A}_{ufg}$. By Theorem 2.6(iii), all components of $\mathfrak{M}_{A,B}^{cu}$ are in \mathbf{A}_{cufg} . Thus if T is a maximal pro-ideal of $\mathfrak{M}_{A,B}^{cu}$ then $\mathfrak{M}_{A,B}^{cu}/T \cong \mathbb{F}$ and hence the canonical quotient pro-morphism $q : \mathfrak{M}_{A,B}^{cu} \to \mathfrak{M}_{A,B}^{cu}/T$ can be considered as a member of $\operatorname{Pnt}_{\neq 0}(\mathfrak{M}_{A,B}^{cu})$. The proof is complete.

We now consider some properties of the extended categories of algebras.

Theorem 7.2. Intersection (resp. sum) and inclusion of pro-ideals induce enriched category structure on $\bar{\mathbf{A}}_{nc}$ by partially ordered idempotent semigroups.

Proof. It is clear that \cap and \subseteq make $\operatorname{Hom}_{\bar{\mathbf{A}}_{nc}}(A, B)$ into a partially ordered idempotentsemigroup. Suppose that $S = [S_i], S' = [S'_{i'}]$ are pro-ideals of $\mathfrak{M}_{A,B}$ and $T = [T_j]$ be a pro-ideal of $\mathfrak{M}_{B,C}$. Without lost of generality assume i = i'. We have

$$(\mathfrak{M}_{B,C})_{j} \otimes (S_{i} \cap S_{i}') + T_{j} \otimes (\mathfrak{M}_{A,B})_{i} = ((\mathfrak{M}_{B,C})_{j} \otimes S_{i} + T_{j} \otimes (\mathfrak{M}_{A,B})_{i}) \cap ((\mathfrak{M}_{B,C})_{j} \otimes S_{i}' + T_{j} \otimes (\mathfrak{M}_{A,B})_{i})$$

in the algebra $(\mathfrak{M}_{B,C})_j \otimes (\mathfrak{M}_{A,B})_i$. It follows that $T \circ (S \cap S') = (T \circ S) \cap (T \circ S')$. Similarly, $(T \cap T') \circ S = (T \circ S) \cap (T' \circ S)$. Thus \circ is a bihomomorphism with respect to the semigroup operation \cap . Also, it is clear that if $T \subseteq T', S \subseteq S'$ then $T \circ S \subseteq T' \circ S'$. The sum case is similar.

Theorem 7.3. Suppose that A and B are isomorphic in $\bar{\mathbf{A}}_{u}^{prpr}$. Then they are also isomorphic in \mathbf{A}_{u} .

We shall need the following elementary fact: Let $\phi : V \to W \otimes V', \psi : W \to V \otimes W'$ be morphisms in **Vec**. Suppose for some $x \in V', y \in W'$ we have that $(\psi \otimes id)\phi(v) = v \otimes y \otimes x$ and $(\phi \otimes id)\psi(w) = w \otimes x \otimes y$. Then there are isomorphisms $\hat{\phi} : V \to W$ and $\hat{\psi} : W \to V$ such that $\phi(v) = \hat{\phi}(v) \otimes x$ and $\psi(w) = \hat{\psi}(w) \otimes y$.

Proof. Let S, T be proper pro-ideals respectively in $\mathfrak{M}^{\mathrm{u}}_{A,B}, \mathfrak{M}^{\mathrm{u}}_{B,A}$ such that

$$\ker[(\mathbf{q}_T \otimes \mathbf{q}_S)\Phi_{A,B,A}] = \ker(\overline{\mathrm{id}}_A) \qquad \ker[(\mathbf{q}_S \otimes \mathbf{q}_T)\Phi_{B,A,B}] = \ker(\overline{\mathrm{id}}_B) \tag{13}$$

Let $\phi := (\mathrm{id}_B \otimes \mathrm{q}_S) \Upsilon^{\mathrm{u}}_{A,B}$ and $\psi := (\mathrm{id}_A \otimes \mathrm{q}_T) \Upsilon^{\mathrm{u}}_{B,A}$. Since $\mathfrak{M}^{\mathrm{u}}_{A,A} / \ker(\overline{\mathrm{id}}_A) \cong \mathbb{F}$, the left side of (13) implies that image of $(\mathrm{q}_T \otimes \mathrm{q}_S) \Phi_{A,B,A}$ is the subalgebra generated by $1_{\mathfrak{M}^{\mathrm{u}}_{B,A}/T} \otimes 1_{\mathfrak{M}^{\mathrm{u}}_{A,B}/S}$. Thus, it follows from the identity

$$(\psi \otimes \mathrm{id})\phi = [\mathrm{id}_A \otimes ((\mathbf{q}_T \otimes \mathbf{q}_S)\Phi_{A,B,A})]\Upsilon^{\mathrm{u}}_{A,A}$$

that $(\psi \otimes \mathrm{id})\phi(a) = a \otimes 1_{\mathfrak{M}_{B,A}^{\mathrm{u}}/T} \otimes 1_{\mathfrak{M}_{A,B}^{\mathrm{u}}/S}$. Similarly, it is shown that $(\phi \otimes \mathrm{id})\psi(b) = b \otimes 1_{\mathfrak{M}_{A,B}^{\mathrm{u}}/S} \otimes 1_{\mathfrak{M}_{B,A}^{\mathrm{u}}/T}$. Now, the desired result follows from the mentioned fact. \Box

Every morphism $f : A \to B$ in \mathbf{A}_u induces a fundamental functor \hat{f} between categories of unital left modules of A and B given by

$$\hat{f}: \operatorname{Mod}(A) \to \operatorname{Mod}(B) \qquad \hat{f}(M) := B \otimes_A M$$

where B is considered as a right A-module with module multiplication $b \cdot a := bf(a)$. The assignment $f \mapsto \hat{f}$ is simply extended to morphisms in $\bar{\mathbf{A}}_{u}^{\text{prpr}}$ as follows: Let S be a proper pro-ideal of $\mathfrak{M}_{A,B}^{u}$ and let $\phi : A \to B \otimes \mathfrak{M}_{A,B}/S$ be as in the proof of Theorem 7.3. $\hat{S}(M)$ is defined to be the B-submodule of $B \otimes \mathfrak{M}_{A,B}/S$ with the underlying vector space $\hat{\phi}(M)$. The action of \hat{S} on morphisms of Mod(A) is defined to be that of $\hat{\phi}$. **Theorem 7.4.** The K-group functor K_0 on \mathbf{A}_u extends canonically to a functor

$$K_0: \bar{\mathbf{A}}_{\mathrm{u}}^{\mathrm{fcodim}} \to \mathbf{Ab}.$$

Proof. Let S be a proper finite-codimensional pro-ideal of $\mathfrak{M}_{A,B}^{u}$. We show that S(M) is a finitely-generated projective B-module for any finitely-generated projective A-module M: Let $C = \mathfrak{M}_{A,B}^{u}/S$, $D = B \otimes C$, $N = D \otimes_{A} M$. We know that C is a finite-dimensional algebra and N as a D-module is finitely-generated and projective. Suppose that $\{c_i\}_{i=1}^k$ is a vector basis for C. If $\{x_j\}_{j=1}^\ell$ generate N as a D-module then $\{(1_B \otimes c_i)x_j\}$ generates N as a B-module. Thus N is a finitely generated B-module. We know that there exists a D-module isomorphism $\Gamma : N \oplus N' \to \bigoplus_{i=1}^n D$ for some $n \geq 1$ and some D-module N'. It is clear that Γ is also a B-module isomorphism. On the other hand, D is a free B-module with B-basis $\{1_B \otimes c_i\}$. Thus $\bigoplus_{i=1}^n D$ is also a free B-module. So, N as a B-module is projective. $K_0(S)$ is defined to be the group-morphism $K_0(A) \to K_0(B)$ induced by the assignment $M \mapsto \hat{S}(M)$ on finitely-generated projective modules.

Theorem 7.5. Products exist in $\bar{\mathbf{A}}_{u}^{\text{prm}}$ and (hence) coincide with products of \mathbf{A}_{u} .

Proof. Let B_1, B_2 be unital algebras and let p_1, p_2 denote the canonical projections from $B_1 \oplus B_2$ respectively onto B_1, B_2 . Let S_1, S_2 be morphisms in $\bar{\mathbf{A}}_{u}^{\text{prm}}$ from Arespectively to B_1, B_2 . By a result similar to Theorem 2.11 we have the canonical isomorphism $\mathfrak{M}_{A,B_1\oplus B_2}^{\text{cu}} \cong \mathfrak{M}_{A,B_1}^{\text{cu}} \otimes \mathfrak{M}_{A,B_2}^{\text{cu}}$. So, we may consider

 $I := S_1 \otimes (\mathfrak{M}^{\mathrm{cu}}_{A,B_2})_{\mathrm{ideal}} + (\mathfrak{M}^{\mathrm{cu}}_{A,B_1})_{\mathrm{ideal}} \otimes S_2$

as a pro-ideal of $\mathfrak{M}_{A,B_1\oplus B_2}^{cu}$. Then I is the only morphism in $\bar{\mathbf{A}}_{u}^{prm}$ satisfying

$$S_1 := \ker(\overline{p}_1) \circ I$$
 and $S_2 := \ker(\overline{p}_2) \circ I$

8 Classifying Algebras for Algebraic K-Groups

In this section we consider a bivariant K-theory \mathfrak{QQ} which is a pure-algebraic version of Cuntz's interpretation [5] of the Kasparov bivariant K-theory of C*-algebras [15]. Using the functor $\mathfrak{M}^{\mathrm{nc}}$ and following a method introduced by Phillips [17] we prove the existence of *classifying homotopy pro-algebras* for \mathfrak{QQ} , Cortiñas-Thom's KK-groups [4], and Weibel's homotopy K-groups [19].

In this section we denote by \mathcal{R} the matrix in $M_2(\mathbb{F}[x])$ given by

$$\mathcal{R} := \left(\begin{array}{cc} 1 - x^2 & x^3 - 2x \\ x & 1 - x^2 \end{array} \right).$$

Note that \mathcal{R} is invertible. For a story about \mathcal{R} in Algebraic Homotopy see [4, §3.4]. We begin with some well-known lemmas.

Lemma 8.1. For any $B \in \mathbf{A}_{nc}$, the morphism $M_2(B) \to M_2(B[x])$ given by $M \mapsto \mathcal{R}^{-1}M\mathcal{R}$ is an elementary homotopy between $\mathrm{id}_{M_2(B)}$ and the morphism

$$\left(\begin{array}{cc}a&b\\c&d\end{array}\right)\mapsto \left(\begin{array}{cc}d&-c\\-b&a\end{array}\right).$$

Lemma 8.2. Let $\alpha, \beta : A \to B$ be morphisms in \mathbf{A}_{nc} . Then the morphisms

$$(a \mapsto \begin{pmatrix} \alpha(a) & 0\\ 0 & \beta(a) \end{pmatrix})$$
 and $(a \mapsto \begin{pmatrix} \beta(a) & 0\\ 0 & \alpha(a) \end{pmatrix})$

from A into $M_2(B)$ are elementary homotopic.

Proof. It follows directly from Lemma 8.1.

Lemma 8.3. With the assumptions of Lemma 8.2, suppose *B* is an ideal of a unital algebra *C*, and there exists $c \in C$ such that $\beta(a) = c\alpha(a)c^{-1}$. Then the morphisms

$$(a \mapsto \begin{pmatrix} \alpha(a) & 0\\ 0 & 0 \end{pmatrix})$$
 and $(a \mapsto \begin{pmatrix} \beta(a) & 0\\ 0 & 0 \end{pmatrix})$

from A into $M_2(B)$ are homotopic.

Proof. By Lemma 8.2, we have

$$\left(a \mapsto \left(\begin{array}{cc} \alpha(a) & 0 \\ 0 & 0 \end{array} \right) \right) \approx \left(a \mapsto \left(\begin{array}{cc} 0 & 0 \\ 0 & \alpha(a) \end{array} \right) \right)$$

Hence, the morphisms

$$a \mapsto \begin{pmatrix} 1 & 0 \\ 0 & c \end{pmatrix} \begin{pmatrix} \alpha(a) & 0 \\ 0 & 0 \end{pmatrix} \begin{pmatrix} 1 & 0 \\ 0 & c^{-1} \end{pmatrix} = \begin{pmatrix} \alpha(a) & 0 \\ 0 & 0 \end{pmatrix}$$
$$a \mapsto \begin{pmatrix} 1 & 0 \\ 0 & c \end{pmatrix} \begin{pmatrix} 0 & 0 \\ 0 & \alpha(a) \end{pmatrix} \begin{pmatrix} 1 & 0 \\ 0 & c^{-1} \end{pmatrix} = \begin{pmatrix} 0 & 0 \\ 0 & \beta(a) \end{pmatrix}$$

from A into $M_2(B)$ are elementary homotopic. Now, applying Lemma 8.2 another time, we get the desired result.

Lemma 8.4. Let $\alpha_i : A \to M_{k_i}(B)$ (i = 1, ..., n) be morphisms in \mathbf{A}_{nc} . Suppose σ denotes a permutation of $\{1, ..., n\}$. Then the morphisms

$$a \mapsto \begin{pmatrix} \alpha_1(a) & 0 & \cdots & 0 & 0 \\ 0 & \alpha_2(a) & \cdots & 0 & 0 \\ \vdots & \vdots & \ddots & \vdots & \vdots \\ 0 & 0 & \cdots & \alpha_n(a) & 0 \\ 0 & 0 & \cdots & 0 & 0 \end{pmatrix}$$
$$a \mapsto \begin{pmatrix} \alpha_{\sigma(1)}(a) & 0 & \cdots & 0 & 0 \\ 0 & \alpha_{\sigma(2)}(a) & \cdots & 0 & 0 \\ \vdots & \vdots & \ddots & \vdots & \vdots \\ 0 & 0 & \cdots & \alpha_{\sigma(n)}(a) & 0 \\ 0 & 0 & \cdots & 0 & 0 \end{pmatrix}$$

from A into $M_{2k}(B)$, where $k := \sum_i k_i$, are homotopic. *Proof.* It follows directly from Lemma 8.3.

For any algebra B, let $M_{\bullet}(B)$ denote the ind-algebra indexed over \mathbb{N} with components $M_n(B)$ and structural morphisms $M_n(B) \to M_{n+1}(B)$ given by

$$M \mapsto \left(\begin{array}{cc} M & 0\\ 0 & 0 \end{array}\right). \tag{14}$$

For any m, n, consider the morphism

$$\Gamma_{m,n}: \mathcal{M}_m(B) \oplus \mathcal{M}_n(B) \to \mathcal{M}_{m+n}(B) \quad (M,N) \mapsto \begin{pmatrix} M & 0\\ 0 & N \end{pmatrix}$$
(15)

Then it follows from Lemma 8.4 that the image of the family $\{\Gamma_{m,n}\}$ in ind-Hot (\mathbf{A}_{nc}) defines an ind-morphism

$$\Gamma : \mathrm{M}_{\bullet}(B) \oplus \mathrm{M}_{\bullet}(B) \to \mathrm{M}_{\bullet}(B).$$

(Note that $\{\Gamma_{m,n}\}$ does not define a morphism in ind- \mathbf{A}_{nc} except for B = 0.) It also follows from Lemma 8.4 that $M_{\bullet}(B)$ is an abelian monoid in ind-Hot (\mathbf{A}_{nc}) with comultiplication Γ and null element given by the ind-morphism $0 \to M_{\bullet}(B)$. It is not hard to see that all the above statements hold if the algebra B is replaced by any ind-algebra. Also, we may consider M_{\bullet} as the wh preserving functor

$$M_{\bullet}$$
: ind- $A_{nc} \rightarrow$ ind- A_{nc} .

The following result is obvious.

Proposition 8.5. For $A, B \in \text{ind-}\mathbf{A}_{nc}$, the set $[A, M_{\bullet}(B)]$ has a canonical abelian monoid structure induced by Γ . Moreover, this structure is functorial in A and B.

Lemma 8.6. Suppose there exists a morphism $f : A \to A$ such that \hat{f} h0 where

$$\tilde{f}: A \to \mathcal{M}_2(A) \quad a \mapsto \begin{pmatrix} f(a) & 0 \\ 0 & a \end{pmatrix}.$$

Then the monoid $[A, M_{\bullet}(B)]$ is a group.

Proof. It is easily verified that for every ind-morphism $g : A \to M_{\bullet}(B), g \circ f$ is an inverse for g in $[A, M_{\bullet}(B)]$.

Consider the coproduct $A \star A$ in \mathbf{A}_{nc} . For any $a \in A$, let a_1, a_2 denote the two copies of a in $A \star A$. The algebra qA, originally introduced by Cuntz, is defined to be the kernel of the codiagonal morphism $A \star A \to A(a_1, a_2 \mapsto a)$ [5],[4, §4.11]. The key property of qA is that for any two morphisms $\alpha, \beta : A \to B$ if I is an ideal of B such that $\alpha(a) - \beta(a) \in I$, then the restriction to qA of the morphism $A \star A \to A$ given by $a_1 \mapsto \alpha(a)$ and $a_2 \mapsto \beta(a)$, takes its values in I, and thus may be regarded as a morphism $qA \to I$. We may consider q as a functor $q : \mathbf{A}_{nc} \to \mathbf{A}_{nc}$ in the obvious way. Then, it is easily verified that q is homotopy preserving. The proof of the next lemma is an adapted version of that of [17, Proposition 1.15].

Lemma 8.7. qA satisfies the assumption of Lemma 8.6.

Proof. Consider the morphisms $\alpha, \beta : A \to M_2(A \star A)[x]$ given by

$$\alpha: a \mapsto \begin{pmatrix} a_2 & 0 \\ 0 & a_1 \end{pmatrix} \quad \text{and} \quad \beta: a \mapsto \mathcal{R}^{-1} \begin{pmatrix} a_1 & 0 \\ 0 & a_2 \end{pmatrix} \mathcal{R}.$$

It is easily verified that $\alpha(a) - \beta(a) \in M_2(qA)[x]$, and thus we have the canonical morphism $\varphi : qA \to M_2(qA)[x]$ induced by α, β . Let $s : A \star A \to A \star A$ denote switch i.e. the morphism defined by $a_1 \mapsto a_2$ and $a_2 \mapsto a_1$. Put $f := s|_{qA}$. Then φ is an elementary homotopy from \tilde{f} to 0.

The following result is a version of [5, Proposition 1.4].

Theorem 8.8. For any two algebras A and B, the set

$$\mathfrak{QQ}(A,B) := [qA, M_{\bullet}(B)]$$

has a canonical abelian group structure. Moreover, we may consider the following homotopy invariant functor in the obvious way:

$$\mathfrak{Q}\mathfrak{Q}: \mathbf{A}_{\mathrm{nc}}^{\mathrm{op}} \times \mathbf{A}_{\mathrm{nc}} \to \mathbf{Ab}.$$

Proof. It follows from Proposition 8.5, and Lemmas 8.6 and 8.7.

For any algebra A, let the *evaluation* morphisms $ev_1, ev_2 : qA \to A$ be defined respectively by $(a_1 \mapsto a, a_2 \mapsto 0)$ and $(a_1 \mapsto 0, a_2 \mapsto a)$.

Remark 8.9. It is proved by Cuntz that for any C*-algebra A, qA and q^2A are analytically homotopic up to stabilization by M₂ [5, Theorem 1.6]. Using this result, the triple (qA, ev_1, ev_2) can be regarded as an analogue of the triple ([0, 1], 0, 1), homology theories of C*-algebras which are stable with respect to a tensor with compact operators. Unfortunately, it seems that there is no way to restate a pure-algebraic version of this result.

We let

$$\mathfrak{Q}(B) := \mathfrak{Q}\mathfrak{Q}(\mathbb{F}, B)$$

Thus we have the following homotopy invariant functor:

$$\mathfrak{Q}: \mathbf{A}_{\mathrm{nc}} \to \mathbf{Ab}.$$

Let $C \in \mathbf{A}_{u}$. Denote by $\operatorname{Idmp}_{n}(C)$ the set of idempotent matrixes in $\operatorname{M}_{n}(C)$. Then (14) makes the family $(\operatorname{Idmp}_{n}(C))_{n\geq 1}$ into an ind-set; write $\operatorname{Idmp}(C)$ for its direct limit. The group $\lim_{n\to\infty} \operatorname{GL}_{n}(C)$ acts on $\operatorname{Idmp}(C)$ by conjugation. Write $[\operatorname{Idmp}(C)]$ for the set of conjugate classes. The morphisms (15) induce an abelian monoid structure on $[\operatorname{Idmp}(C)]$. Its Grothendieck group is $K_{0}(C)$, the usual K-group of C. It is clear that any $M \in \operatorname{Idmp}_{n}(C)$ is exactly distinguished by the morphism $\alpha_{M} :$ $\mathbb{F} \to \operatorname{M}_{n}(C)$ given by $1 \mapsto M$. By Lemma 8.3, if the idempotents $M, M' \in \operatorname{Idmp}_{n}(C)$ are conjugate then $\alpha_{M}, \alpha_{M'}$, considered canonically as morphisms into $\operatorname{M}_{2n}(C)$, are homotopic. Thus the assignment $M \mapsto \alpha_{M}$ induces a natural monoid-morphism

$$[\mathrm{Idmp}(C)] \to [\mathbb{F}, \mathrm{M}_{\bullet}(C)]. \tag{16}$$

The morphism $\mathrm{ev}_1:q\mathbb{F}\to\mathbb{F}$ induces the monoid-morphism

$$[\mathbb{F}, \mathcal{M}_{\bullet}(C)] \to [q\mathbb{F}, \mathcal{M}_{\bullet}(C)] = \mathfrak{Q}(C).$$
(17)

The composition of (16) and (17) gives rise to the group-morphism

$$K_0(C) \to \mathfrak{Q}(C).$$
 (18)

We need the following Yoneda lemma.

Lemma 8.10. Let **C** be a category with finite coproducts and cofinal object. Let $C \in \text{pro-C}$, and suppose that for every $D \in \mathbf{C}$ the set $\text{Hom}_{\text{pro-C}}(C, D)$ has an abelian group structure such that these structures make $\text{Hom}_{\text{pro-C}}(C, ?)$ to a functor from **C** to **Ab**. Then *C* has a cocommutative cogroup structure in pro-**C** whose induces the group structures of $\text{Hom}_{\text{pro-C}}(C, D)$ in the obvious way.

Theorem 8.11. For any algebra A, there exists a pro-algebra $\overline{\mathfrak{QQ}}_A$ with a cocommutative cogroup structure as an object in pro-Hot (\mathbf{A}_{nc}) such that the abelian groups $[\overline{\mathfrak{QQ}}_A, B]$ and $\mathfrak{QQ}(A, B)$ are naturally isomorphic for every algebra B. In particular, there exists a pro-algebra $\overline{\mathfrak{Q}}$ with a natural abelian group-morphism

$$[\overline{\mathfrak{Q}}, B] \cong \mathfrak{Q}(B) \qquad (B \in \mathbf{A}_{\mathrm{nc}}).$$

Proof. By Theorem 3.4, for every algebra B we have

$$\mathfrak{QQ}(A,B) = [\mathsf{q}A,\mathsf{M}_{\bullet}(B)] = [\mathsf{q}A,\mathsf{M}_{\bullet}(\mathbb{F})\otimes B] \cong [\mathfrak{M}^{\mathrm{nc}}_{\mathsf{q}A,\mathsf{M}_{\bullet}(\mathbb{F})},B].$$

Thus it follows from Lemma 8.10 that $\mathfrak{M}_{qA,M_{\bullet}(\mathbb{F})}^{\mathrm{nc}}$ is the desired pro-algebra

Following Phillips [17], $\overline{\mathfrak{QQ}}_A$ may be called classifying pro-algebra. For any algebra B, we put

$$M_{\infty}(B) := \lim_{n \to \infty} M_n(B)$$
 and $\mathcal{M}_{\infty}(B) := M_{\bullet}M_{\infty}(B).$

It is clear that we have the wh-preserving functor

$$\mathcal{M}_{\infty}$$
: ind- $\mathbf{A}_{\mathrm{nc}} \rightarrow$ ind- \mathbf{A}_{nc} .

As explained in [4, §4.1], the abelian monoid structure on $\mathcal{M}_{\infty}(B)$, may be induced also by the direct sum of infinite matrixes in $\mathcal{M}_{\infty}(B)$. For any algebra B, we denote by $B[\Delta]$ the ind-algebra $B \otimes \mathbb{F}[\Delta]$. For any simplicial set $S \in \text{sim-Set}$, let

$$\mathfrak{Z}(S,B) := \operatorname{Hom}_{\operatorname{sim-Set}}(S,B[\Delta])$$

where $B[\Delta]$, by the forgetful functor sim- $\mathbf{A}_{nc} \to \text{sim-}\mathbf{Set}$, is considered as a simplicial set. Then $\mathfrak{Z}(S, B)$ can be considered as an algebra with pointwise operations. Thus we have the functor

$$\mathfrak{Z}: (\operatorname{sim-Set})^{\operatorname{op}} \times \mathbf{A}_{\operatorname{nc}} \to \mathbf{A}_{\operatorname{nc}}$$

We extend \mathfrak{Z} canonically to the functor

$$\mathfrak{Z}: (\text{pro-sim-Set})^{\mathrm{op}} \times \mathbf{A}_{\mathrm{nc}} \to \mathrm{ind-}\mathbf{A}_{\mathrm{nc}},$$

and then again to the functor

$$\mathfrak{Z}: (\text{pro-sim-Set})^{\text{op}} \times \text{ind-} \mathbf{A}_{\text{nc}} \to \text{ind-} \mathbf{A}_{\text{nc}}$$

Let $\operatorname{sd} : \operatorname{sim}\operatorname{\mathbf{Set}} \to \operatorname{sim}\operatorname{\mathbf{Set}}$ denote the simplicial subdivision functor [10, §III.4]. For any $S \in \operatorname{sim}\operatorname{\mathbf{Set}}$ let $\operatorname{sd}^{\bullet}S \in \operatorname{pro-sim}\operatorname{\mathbf{Set}}$ be given by the inverse system

 $S = \mathrm{sd}^0 S \leftarrow \mathrm{sd}^1 S \leftarrow \cdots \leftarrow \mathrm{sd}^n S \leftarrow \cdots$

where the structural morphisms are given by a natural transformation $sd \rightarrow id$ called last vertex map. Let Δ^1 denote standard 1-simplex i.e. the simplicial set given by

$$\mathbf{n} \mapsto \operatorname{Hom}_{\Delta}(\mathbf{n}, \mathbf{1}).$$

For any ind-algebra B let B^{S^1} ([4, §3.3]) denote the kernel of ind-morphism

$$\mathfrak{Z}(\mathrm{sd}^{\bullet}\Delta^1, B) \to \mathfrak{Z}(\mathrm{sd}^{\bullet}\partial\Delta^1, B)$$

induced by the canonical morphism $\partial \Delta^1 \to \Delta^1$ in sim-**Set**. So we have the functor

$$?^{\mathcal{S}^1}: \operatorname{ind} \mathbf{A}_{\operatorname{nc}} \to \operatorname{ind} \mathbf{A}_{\operatorname{nc}}$$

The *n* times iteration of this functor is denoted by $?^{S^n}$. It is not hard to see that for any two algebras *A*, *B* we have the following canonical isomorphisms of ind-algebras:

$$(A \otimes B)^{\mathcal{S}^n} \cong A^{\mathcal{S}^n} \otimes B \qquad (\mathcal{M}_{\infty}(B))^{\mathcal{S}^n} \cong \mathcal{M}_{\infty}(B^{\mathcal{S}^n})$$

(When the ground ring is not a field, the proof of these latter identities follow from the nontrivial result [4, Proposition 3.1.3].) In particular, we have

$$(B[x])^{\mathcal{S}^n} \cong B^{\mathcal{S}^n}[x],$$

and hence the functor $?^{S^n}$ is homotopy preserving. By [4, Theorem 3.3.2] the set

$$[A, B^{S^n}]$$
 $(A \in \mathbf{A}_{\mathrm{nc}}, B \in \mathrm{ind} \mathbf{A}_{\mathrm{nc}})$

has a canonical group structure, functorial in A, B, and abelian for $n \ge 2$.

By an extension [4, Definition 4.2.1] we mean a sequence

$$C \xrightarrow{g} B \xrightarrow{f} A \tag{19}$$

of ind-morphisms between ind-algebras such that $g = \ker(f)$ and $f = \operatorname{coker}(g)$. For $B \in \operatorname{ind} \operatorname{A}_{\operatorname{nc}}$ the canonical morphism $\Delta^0 \to \Delta^1$ in sim-**Set** induces an ind-morphism

$$\mathfrak{Z}(\mathrm{sd}^{\bullet}\Delta^1, B) \to \mathfrak{Z}(\mathrm{sd}^{\bullet}\Delta^0, B) \cong B.$$

Denote its kernel by $\mathcal{P}(B)$. The canonical factorization

$$\Delta^0 \to \partial \Delta^1 \to \Delta^1$$

of $\Delta^0 \to \Delta^1$ gives us the so-called loop extension [4, §4.5]:

$$B^{\mathcal{S}^1} \to \mathcal{P}(B) \to B. \tag{20}$$

For $V \in \mathbf{Vec}$ let $\mathbf{T}(V) := \bigoplus_{n=1}^{\infty} V^{\otimes^n}$ denote the tensor algebra associated to V. Then

$$\mathrm{T}:\mathrm{ind}\text{-}\mathbf{Vec}\to\mathrm{ind}\text{-}\mathbf{A}_{\mathrm{nc}}$$

is a left adjoint for the forgetful functor $\operatorname{ind} \operatorname{\mathbf{A}_{nc}} \to \operatorname{ind} \operatorname{\mathbf{Vec}}$. For any ind-algebra A let $\eta_A : \operatorname{T}(A) \to A$ denote the adjoint of id_A and put $\operatorname{J}(A) := \ker \eta_A$. Let $\iota_A : \operatorname{J}(A) \to \operatorname{T}(A)$ denote the embedding. Then we have the following extension:

$$\mathbf{J}(A) \xrightarrow{\iota_A} \mathbf{T}(A) \xrightarrow{\eta_A} A$$

It is not hard to see that J can be considered as a homotopy preserving functor

$$J: \operatorname{ind} \mathbf{A}_{\operatorname{nc}} \to \operatorname{ind} \mathbf{A}_{\operatorname{nc}}$$

Suppose the ind-morphism $h : A \to B$ in ind-Vec is a splitting for extension (19) i.e. $fh = id_A$. Let γ_h denote the adjoint of h. Then there is a unique morphism ξ_h making the following diagram commutative:

$$J(A) \xrightarrow{\iota_A} T(A) \xrightarrow{\eta_A} A$$

$$\downarrow \xi_h \qquad \qquad \downarrow \gamma_h \qquad \qquad \downarrow_{id}$$

$$C \xrightarrow{g} B \xrightarrow{f} A$$

If $h' : A \to B$ is another splitting for (19) then by [4, Proposition 4.4.1] we have $\xi_h \sim_{\rm h} \xi_{h'}$. So $\xi = \xi_h$ is just called a classifying map for (19). For more details on the constructions of $J(A), \mathcal{P}(A), A^{S^n}$ see [4] or [8].

For any two algebras A, B we let

$$kk^{(n)}(A,B) := [\mathbf{J}^n(A), (\mathcal{M}_{\infty}(B))^{\mathcal{S}^n}] = [\mathbf{J}^n(A), \mathcal{M}_{\infty}(B^{\mathcal{S}^n})].$$
(21)

It is clear that $kk^{(n)}$ may be considered as a homotopy invariant functor

$$kk^{(n)}: \mathbf{A}_{\mathrm{nc}}^{\mathrm{op}} imes \mathbf{A}_{\mathrm{nc}} o \mathbf{Ab}$$

Let $f: A \to B$ be a morphism in \mathbf{A}_{nc} . Then let $\mathbf{j}(f) \in kk^{(1)}(A, B)$ be the composit

$$J(A) \xrightarrow{J(f)} J(B) \longrightarrow J(\mathcal{M}_{\infty}(B)) \xrightarrow{\xi} \mathcal{M}_{\infty}(B^{S^1})$$

where the second arrow is induced by the canonical embedding $B \to \mathcal{M}_{\infty}(B)$ and where ξ is a classifying map for the extention induced by (20). Similarly, for any $n \geq 1$ and any homotopy class $[f] \in kk^{(n)}(A, B)$ of a ind-morphism f let

$$\Phi^n_{A,B}([f]) \in kk^{(n+1)}(A,B)$$

denote the homotopy class of the ind-morphism defined by the composit

$$\mathbf{J}^{n+1}(A) \xrightarrow{\mathbf{J}(f)} \mathbf{J}((\mathcal{M}_{\infty}(B))^{\mathcal{S}^n}) \xrightarrow{\xi} ((\mathcal{M}_{\infty}(B))^{\mathcal{S}^n})^{\mathcal{S}^1} \cong (\mathcal{M}_{\infty}(B))^{\mathcal{S}^{n+1}}.$$

Then, as it is explained in [4, §6.1], $\Phi_{A,B}^n$ is a morphism in **Ab**, and moreover, the assignment $(A, B) \mapsto \Phi_{A,B}^n$ defines a natural transformation

$$\Phi^n: kk^{(n)} \to kk^{(n+1)}.$$

Thus, we have the following direct system of abelian groups:

$$kk^{(1)}(A,B) \xrightarrow{\Phi^1_{A,B}} kk^{(2)}(A,B) \xrightarrow{\Phi^2_{A,B}} \cdots$$

The Cortiñas-Thom bivariant K-group is defined to be the abelian group

$$kk(A,B) := \lim_{n \to \infty} kk^{(n)}(A,B).$$

It is clear that kk may be considered as a homotopy invariant functor

$$kk: \mathbf{A}_{\mathrm{nc}}^{\mathrm{op}} imes \mathbf{A}_{\mathrm{nc}} o \mathbf{Ab}$$

It is proved that there is a triangulated category kk whose objects are those of \mathbf{A}_{nc} and whose morphism-sets are kk(A, B). Also, the assignment $f \mapsto \mathbf{j}(f)$ defines a functor $\mathbf{A}_{nc} \to kk$ which is universal among all excisive, homotopy invariant and \mathbf{M}_{∞} -stable homology theories on \mathbf{A}_{nc} [4, Theorem 6.6.2].

After the above long review of Cortiñas-Thom's theory, we build a comparison morphism between $\mathfrak{Q}(C)$ and $kk(\mathbb{F}, C)$: For $C \in \mathbf{A}_{nc}$, consider the composit

$$\mathfrak{Q}(C) = [q\mathbb{F}, \mathcal{M}_{\bullet}(C)] \longrightarrow [q\mathbb{F}, \mathcal{M}_{\infty}(C)] \xrightarrow{j} kk(q\mathbb{F}, \mathcal{M}_{\infty}(C)) \cong kk(q\mathbb{F}, C) \quad (22)$$

where the first arrow is induced by the canonical ind-morphism $M_{\bullet}(C) \to M_{\infty}(C)$. As it is noted in [4, §6.1] the sum operation in the *kk*-groups is the same as the operation induced by the abelian monoid M_{\bullet} in (21). Thus the composite (22) is a group-morphism. For every surjective morphism f in \mathbf{A}_{nc} it follows from [4, Corollary 6.3.4] that $\mathbf{j}(f)$ has a right inverse in kk. So, we have the following group-morphism induced by the inverse of $\mathbf{j}(ev_1 : q\mathbb{F} \to \mathbb{F})$:

$$kk(q\mathbb{F}, C) \to kk(\mathbb{F}, C)$$
 (23)

Composition of (22) and (23) is the canonically defined group-morphism

$$\mathfrak{Q}(C) \to kk(\mathbb{F}, C). \tag{24}$$

For Weibel's homotopy algebraic K-theory KH we refer the reader to the original paper [19] or [21, 3]. By [4, Theorem 8.2.1], for any algebra C, we have a natural isomorphism between abelian groups $KH_0(C)$ and $kk(\mathbb{F}, C)$. Thus, (24) gives rise to the natural group-morphism

$$\mathfrak{Q}(C) \to KH_0(C). \tag{25}$$

In case C is a unital algebra, it can be seen from the proof of [4, Theorem 8.2.1] that the canonical morphism (see $[3, \S 5]$),

$$K_0(C) \to KH_0(C)$$
 (26)

is equal to the composition of (18) and (25).

Theorem 8.12. Let C be a unital K_0 -regular algebra. Then (18) is injective and (25) is surjective.

Proof. The theorem follows from the fact that by [3, Proposition 5.2.3], (26) is an isomorphism. \Box

We need the following elementary lemma.

Lemma 8.13. Let $C = (C_i)_i$ be in pro-**C**. Suppose that for every *i*, C_i is a cocommutative cogroup object in **C** and all structural morphisms of *C* preserve the cogroup structures. Then *C* is a cocommutative cogroup in pro-**C** with comultiplication, counit, and coinverse induced by those of C_i 's in the obvious way.

Theorem 8.14. For any algebra A, there exists an object $\overline{kk}_A \in \text{pro-Hot}(\mathbf{A}_{nc})$ with a cocommutative cogroup structure such that the abelian groups $[\overline{kk}_A, B]$ and kk(A, B) are naturally isomorphic for every algebra B.

Proof. Let

$$\overline{kk}_A^{(n)} = \mathfrak{M}^{\mathrm{nc}}(\mathcal{J}^n(A), \mathcal{M}_{\infty}(\mathbb{F}^{\mathcal{S}^n})).$$

Then by Theorem 3.4 we have the natural bijection

$$kk^{(n)}(A,B) \cong [\overline{kk}^{(n)}_A,B].$$
(27)

Thus by Lemma 8.10, $\overline{kk}_A^{(n)}$ has a cocommutative cogroup structure as an object in pro-Hot(\mathbf{A}_{nc}) that makes (27) into a natural isomorphism of groups. By the Yoneda Lemma there exists a morphism

$$\alpha_n: \overline{kk}_A^{(n+1)} \to \overline{kk}_A^{(n)}$$

in pro-Hot(\mathbf{A}_{nc}) that induces the natural transformation $\Phi_{A,?}^n$. Thus, α_n preserves the cogroup structures. Now, it follows from 8.13 that the inverse system

$$(\overline{kk}_A^{(n)}, \alpha_n)_n$$

defines the desired object \overline{kk}_A .

Following Phillips [17], \overline{kk}_A may be called classifying homotopy pro-algebra. The following theorem is one of the main results of this note.

Theorem 8.15. There exists an object \overline{KH}_0 in pro-Hot(\mathbf{A}_{nc}) with a cocommutative cogroup structure such that the abelian groups $[\overline{KH}_0, B]$ and $KH_0(B)$ are naturally isomorphic for every algebra B.

Proof. It follows directly from [4, Theorem 8.2.1] and Theorem 8.14.
