# Hamiltonicity of Domination Vertex-Critical Claw-Free Graphs

#### Abstract

A graph G is said to be k- $\gamma$ -vertex critical if the domination numbers  $\gamma(G)$  of G is k and  $\gamma(G-v) < k$  for any vertex v of G. Similarly, A graph G is said to be  $k-\gamma_c$ -vertex critical if the connected domination numbers  $\gamma_c(G)$  of G is k and  $\gamma_c(G-v) < k$  for any vertex v of G. The problem of interest is to determine whether or not 2-connected k- $\gamma$ -vertex critical graphs are Hamiltonian. In this paper, for all  $k \geq 3$ , we provide a 2-connected k- $\gamma$ -vertex critical graph which is non-Hamiltonian. We prove that every 2-connected  $3-\gamma$ -vertex critical claw-free graph is Hamiltonian and the condition claw-free is necessary. For  $k-\gamma_c$ -vertex critical graphs, we present a new method to prove that every 2-connected  $3-\gamma_c$ -vertex critical claw-free graph is Hamiltonian. Moreover, for  $4 \le k \le 5$ , we prove that every 3-connected k- $\gamma_c$ -vertex critical claw-free graph is Hamiltonian. We show that the condition claw-free is necessary by giving k- $\gamma_c$ -vertex critical non-Hamiltonian graphs containing a claw as an induced subgraph for  $3 \le k \le 5$ .

## 1 Introduction

In this paper, let G denote a finite graph with vertex set V(G) and edge set E(G). For  $S \subseteq V(G)$ , G[S] denotes the subgraph of G induced by S. Throughout this paper all graphs are simple (no loops or multiple edges) and connected. The neighborhood  $N_G(x)$  of a vertex x in G is the set of vertices of G which are adjacent to x. For vertex subsets  $X, Y \subseteq V(G)$ ,  $N_Y(X)$  denotes the set of vertices  $y \in Y$  which  $yx \in E(G)$  for some  $x \in X$ . For a subgraph H of G, we use  $N_Y(H)$  instead of  $N_Y(V(H))$  and we use  $N_H(X)$  instead of  $N_{V(H)}(X)$ . If  $X = \{x\}$ , we use  $N_Y(x)$  instead of  $N_Y(\{x\})$ . A vertex v of G is an isolated vertex if  $N_G(v) = \emptyset$ . Moreover, if  $N_G(v) = \{u\}$ , then v is called an end vertex and u is called a support vertex. A tree is a connected graph having no cycle. A star  $K_{1,n}$  is a tree of order n + 1 having n end vertices. Let  $u_1u_2u_3...u_{s_1+1}, v_1v_2v_3...v_{s_2+1}$  and  $w_1w_2w_3,...w_{s_3+1}$  be three disjoint paths of length  $s_1, s_2$  and  $s_3$  respectively. A net  $N_{s_1,s_2,s_3}$  is constructed by adding edges so that the vertices in  $\{u_{s_1+1}, v_{s_2+1}, w_{s_3+1}\}$  form a cycle of length three. For a finite family  $\mathcal{G}$  of graphs, a graph G is  $\mathcal{G}$ -free if G does not contain H as an induced subgraph for any graph H in  $\mathcal{G}$ .

An independent set of G is a set of pairwise non-adjacent vertices and the independence number of G is the maximum cardinality of an independent set. Let  $\omega(G)$  be the number of components of G. For a connected graph G, a cut set S is a subset of V(G) such that  $\omega(G - S) > 1$ , moreover, if  $S = \{v\}$ , then v is called a cut vertex. The connectivity  $\kappa(G)$  of G is the minimum s for which G has a cut set of s vertices. If G has no cut set, then we define  $\kappa(G)$  to be |V(G)| - 1. A graph G is *l*-connected if  $l \leq \kappa(G)$ . A Hamiltonian cycle(path) is a cycle(path) containing every vertex of a graph. A graph G is Hamiltonian if it contains a Hamiltonian cycle.

For subsets  $D, X \subseteq V(G)$ , D dominates X if every vertex in X is either in Dor adjacent to a vertex in D. If D dominates X, then we write  $D \succ X$ , further, we write  $a \succ X$  when  $D = \{a\}$ . If X = V(G), then D is a dominating set of Gand we write  $D \succ G$  instead of  $D \succ V(G)$ . A smallest dominating set is called a  $\gamma$ -set. The domination number  $\gamma(G)$  of G is the cardinality of a  $\gamma$ -set of G. A connected dominating set of a graph G is a dominating set D of G such that G[D]is connected. If D is a connected dominating set of G, we then write  $D \succ_c G$ . The minimum cardinality of a connected dominating set of G is called the connected domination number of G and is denoted by  $\gamma_c(G)$ . A total dominating set of a graph G is a subset D of V(G) such that every vertex in G is adjacent to a vertex in D. The minimum cardinality of a total dominating set of G is called the total domination number of G and is denoted by  $\gamma_t(G)$ .

A graph G is said to be k- $\gamma$ -edge critical if  $\gamma(G) = k$  and  $\gamma(G + uv) < k$  for any pair of non adjacent vertices u, v of G. We define a k- $\gamma_c$ -edge critical graph and a k- $\gamma_t$ -edge critical similarly. A graph G is said to be k- $\gamma$ -vertex critical if  $\gamma(G) = k$  and  $\gamma(G - v) < k$  for every vertex v of G. We define a k- $\gamma_c$ -vertex critical graph similarly. Obviously, a disconnected graph does not have a connected dominating set. If a graph has connectivity one, then it is disconnected after removing a cut vertex. Thus, when we study on k- $\gamma_c$ -vertex critical graphs, we always focus on 2-connected graphs. A graph G is said to be k- $\gamma_t$ -vertex critical if  $\gamma_t(G) = k$  and  $\gamma_t(G - v) < k$  for any vertex v of G which is not a support vertex.

The classical work on the Hamiltonicity of k- $\gamma$ -edge critical graphs has been discussed since 1983 by Sumner and Blitch [16]. Then, Wojcicka [19] proved that every connected 3- $\gamma$ -edge critical graph of at least 7 vertices has a Hamiltonian path. Further, Flandrin et al. [8], Favaron et al. [7] together with Tian et al. [17] proved that all connected 3- $\gamma$ -edge critical graph with  $\delta \geq 2$  are Hamiltonian. In 1998, Sumner and Wojcicka ([10] Chapter 16) conjectured that: "For  $k \geq 4$ , all (k-1)-connected k- $\gamma$ -edge critical graphs are Hamiltonian." In 2005, Yuansheng et al. [21] disproved this conjecture by giving a 3-connected 4- $\gamma$ -edge critical non-Hamiltonian graph. However, Kaemawichanurat and Caccetta [13] proved that this conjecture is true if k = 4 and the graphs are claw-free. That is : every 3-connected 4- $\gamma$ -edge critical claw-free graph is Hamiltonian.

In the context of k- $\gamma_c$ -edge critical graphs, Kaemawichanurat et al. [15] showed that, for  $1 \leq k \leq 3$ , every 2-connected k- $\gamma_c$ -edge critical graph is Hamiltonian. They, further, gave a construction of k- $\gamma_c$ -edge critical non-Hamiltonian graphs when  $k \geq 4$ . Very recently, Kaemawichanurat and Caccetta [13] proved that every 2-connected 4- $\gamma_c$ -edge critical claw-free graph is Hamiltonian. When  $k \geq 5$ , they found 2-connected k- $\gamma_c$ -edge critical claw-free graphs which are non-Hamiltonian. For  $5 \leq k \leq 6$ , they proved that every k- $\gamma_c$ -edge critical claw-free graphs which are non-Hamiltonian. For  $5 \leq k \leq 6$ , they proved that every k- $\gamma_c$ -edge critical claw-free graph is Hamiltonian when it is 3-connected. So far, the studies on Hamiltonicities of k- $\gamma$ -vertex critical graphs or k- $\gamma_c$ -vertex critical graphs have not been done.

In this paper, we study Hamiltonicities of k- $\gamma$ -vertex critical graphs. The results are given in Section 2. We set up notation that are used of in establishing our results in the first subsection. Then, we prove that all 2-connected 3- $\gamma$ -vertex critical claw-free graphs are Hamiltonian. For  $k \geq 3$ , we provide a 2-connected k- $\gamma$ -vertex critical  $K_{1,4}$ -free graph containing a claw as an induced subgraph which is non-Hamiltonian. That is the condition claw-free is necessary to prove that 2-connected 3- $\gamma$ -vertex critical graphs are Hamiltonian. In Section 3, we present a new method to prove Hamiltonicities of 3-connected k- $\gamma_c$ -vertex critical claw-free graphs for  $3 \leq k \leq 5$ . Thus, we set up notation that are used of in establishing our results in the first subsection. We also give k- $\gamma_c$ -vertex critical non-Hamiltonian graphs containing a claw as an induced subgraph for  $3 \leq k \leq 5$ .

## 2 Hamiltonicity of k- $\gamma$ -vertex critical graphs

In this section, we prove Hamiltonicities of k- $\gamma$ -vertex critical graphs. In the first subsection, we introduce a classical method of studying Hamiltonian properties of graphs.

### 2.1 Set up and known results

Suppose G is a 2-connected non-Hamiltonian graph. Let C be a longest cycle of G. We write  $\overrightarrow{C}$  to indicate the clockwise orientation of C. Similarly, we denote the anticlockwise orientation of C by  $\overleftarrow{C}$ . In particular, for vertices u and v of C we denote the (u, v)-directed segment of  $\overrightarrow{C}(\overleftarrow{C})$  by  $u\overrightarrow{C}v$  ( $u\overleftarrow{C}v$ ). The successor (predecessor) of a vertex v of C in  $\overrightarrow{C}$  is denoted by  $v^+(v^-)$ . Furthermore, for  $i \geq 1$ ,  $v^{(i+1)+} = (v^{i+})^+$  and  $v^{(i+1)-} = (v^{i-})^-$  where  $v^{1+} = v^+$  and  $v^{1-} = v^-$ . This notation is illustrated by the following figure. Note that we always use an orientation  $\overrightarrow{C}$  when we mention about the successor and the predecessor of any vertex of C.




Figure 1 : The *i*th successor and predecessor of *v*.

Let *H* be a component of G - C and  $X = N_C(H)$ . Suppose |X| = d. We may order the vertices of the set *X* as  $x_1, x_2, ..., x_d$  according to  $\overrightarrow{C}$ . We, further, let

$$X^+ = \{x^+_1, x^+_2, ..., x^+_d\}$$
 and  $X^- = \{x^-_1, x^-_2, ..., x^-_d\}$ 

For any vertices u and v of C, if  $|u\overrightarrow{C}v| = t$ , then we can order the vertices in  $u\overrightarrow{C}v$  as  $u, u^+, u^{2+}, ..., u^{(t-1)+}$  such that  $u^{(t-1)+} = v$ . We let  $\overrightarrow{C}[u, v] = \{u, u^+, u^{2+}, ..., u^{(t-1)+}\}$ . All subscripts are taken modulo d throughout. Favaron et al. [7] provided some structural properties described in Lemmas 1 and 2. Note that, for any two vertices u, v and subgraph H of G,  $uP_Hv$  denotes a path from u to v which the internal vertices are in V(H). **Lemma 1**  $[\gamma] X^+ \cap X = \emptyset$  and  $X^- \cap X = \emptyset$ .

**Lemma 2** [7] For any two vertices  $u, v \in X^+$  (or  $u, v \in X^-$ ), then there is no  $uP_{G-C}v$  path, in particular,  $uv \notin E(G)$ .

Lemmas 3 and 5 are well known (see Brousek [4]) and proved under the condition that G is claw-free non-Hamiltonian graph.

**Lemma 3** [4] For all  $1 \le i \le d$ ,  $x_i^+ x_i^- \in E(G)$ .

**Lemma 4** [4] For  $1 \le i \ne j \le d$ ,  $\{x_i x_j^+, x_i x_j^{2+}, x_i^+ x_j^{2+}, x_i x_j^-, x_i x_j^{2-}, x_i^- x_j^{2-}\} \cap E(G) = \emptyset$ .

**Lemma 5** [4] For all  $1 \le i \le d$ ,  $|\overrightarrow{C}[x_i^+, x_{i+1}^-]| \ge 3$ .

The study k- $\gamma$ -vertex critical graphs has been started by Brigham et al. [3] and continued by Fulman et al. [9]. Moreover, Ananchuen and Plummer [1] established some observations on these graphs.

**Lemma 6** [1] For  $k \ge 2$ , let G be a k- $\gamma$ -vertex critical graph. Moreover, for a vertex v of G, we let  $D_v$  be a  $\gamma$ -set of G - v. Then

(i)  $|D_v| = k - 1$  and

(ii) every vertex in  $D_v$  is not adjacent to v.

### 2.2 Main results

In this subsection, we prove that all 3- $\gamma$ -vertex critical claw free graphs are Hamiltonian. We first give a construction of k- $\gamma$ -vertex critical graphs  $G_k$  which are non-Hamiltonian for  $k \geq 3$ . Let  $C_k = b_1 b_2 \dots b_k b_1$  be a cycle of length k. We construct the graph  $S_k$  by subdividing the edge  $b_i b_{i+1}$  with a vertex  $a_{i+1}$  for every  $1 \leq i \leq k-1$ , subdividing the edge  $b_k b_1$  with a vertex  $a_1$  and then, joining  $a_i$ to  $a_{i+1}$  for  $1 \leq i \leq k-1$  and joining  $a_k$  to  $a_1$ . Our graph  $G_k$  is constructed from  $S_k$  by subdividing the edge  $a_i a_{i+1}$  with a vertex  $c_i$  for all  $1 \leq i \leq k-1$ , subdividing the edge  $a_k a_1$  with a vertex  $c_k$  and finally, joining  $c_i$  to  $c_{i+1}$  for all  $1 \leq i \leq k-1$  and joining  $c_k$  to  $c_1$ . The following figures illustrated  $G_3$  and  $G_8$ for examples. It is worth noting that, when k = 3, the graph  $G_3$  has been found earlier by Ananchuen and Plummer [1].




Figure 2 : The graph  $G_3$ 




Figure 3 : The graph  $G_8$ 

In the following, we let

 $A_i = \{a_i, b_i, c_i\}$  for  $1 \le i \le k$ ,

 $A = \{a_1, a_2, ..., a_k\}$  and  $B = \{b_1, b_2, ..., b_k\}.$ 

The following lemma gives that  $\gamma(G_k) = k$ .

**Lemma 7** For a positive integer  $k \ge 3$ , we have that  $\gamma(G_k) = k$ .

**Proof.** Clearly,  $A \succ G_k$ . By the minimality of  $\gamma(G_k)$ , we have  $\gamma(G_k) \leq k$ .

We will show that  $\gamma(G_k) \geq k$ . Suppose that  $\gamma(G) < k$  and let D be a  $\gamma$ -set such that  $|D \cap A|$  is maximum.

If  $D \cap A = \emptyset$ , then  $B \subseteq D$  to dominate B. Thus  $\gamma(G_k) = |D| \ge |B| = k$ , a contradiction. Hence,  $D \cap A \neq \emptyset$ . Since |D| < k, it follows that  $A \not\subseteq D$ . Thus, there exists i such that  $a_{i-1} \in D$  but  $a_i \notin D$ . To dominate  $a_i$ , we have that  $\{b_{i-1}, c_{i-1}, b_i, c_i\} \cap D \neq \emptyset$ . If  $b_{i-1} \in D$ , then  $D' = (D - \{b_{i-1}\}) \cup \{a_i\} \succ G_k$  but  $|D' \cap A| > |D \cap A|$ , contradicting the maximality of  $|D \cap A|$ . Similarly, if  $c_{i-1} \in D$ , then  $D' = (D - \{c_{i-1}\}) \cup \{a_i\} \succ G_k$  but  $|D' \cap A| > |D \cap A|$ , a contradiction. Hence,  $b_i \in D$  or  $c_i \in D$ .

We first assume that  $c_i \in D$ . To dominate  $b_i$ , we have  $b_i \in D$  or  $a_{i+1} \in D$ . If  $a_{i+1} \in D$ , then  $D' = (D - \{c_i\}) \cup \{a_i\} \succ G_k$  but  $|D' \cap A| > |D \cap A|$ , a contradiction. Hence,  $b_i \in D$ . In this case,  $D' = (D - \{b_i\}) \cup \{a_i\} \succ G_k$  but  $|D' \cap A| > |D \cap A|$  which is a contradiction.

Thus, we may assume that  $c_i \notin D$ . Therefore,  $b_i \in D$ . To dominate  $c_i$ , we have  $a_{i+1} \in D$  or  $c_{i+1} \in D$ . In both cases,  $D' = (D - \{b_i\}) \cup \{a_i\} \succ G_k$  but  $|D' \cap A| > |D \cap A|$ , a contradiction.

Therefore,  $\gamma(G_k) \geq k$  implying that  $\gamma(G_k) = k$ . This completes the proof.  $\Box$ 

The next lemma shows that, for  $k \geq 3$ , the graph  $G_k$  is k- $\gamma$ -vertex critical which is non-Hamiltonian.

**Lemma 8** For  $k \geq 3$ , the graph  $G_k$  is k- $\gamma$ -vertex critical  $K_{1,4}$ -free containing  $K_{1,3}$  which is non-Hamiltonian.

**Proof.** In view of Lemma 7, we have  $\gamma(G_k) = k$ . We will establish the criticality. For  $1 \le i \le k$ , we have

$$D_{a_i} = A - \{a_i\}, D_{b_i} = (A - \{a_i, a_{i+1}\}) \cup \{c_i\} \text{ and } D_{c_i} = (A - \{a_i, a_{i+1}\}) \cup \{b_i\}$$

which the subscripts are taken modulo k. We see that  $|D_v| = k - 1$  for all  $v \in V(G_k)$ . Hence,  $G_k$  is a k- $\gamma$ -vertex critical. It is not difficult to see that  $G_k$  is a  $K_{1,4}$ -free graph containing a claw  $G_k[\{a_1, b_k, b_1, c_1\}]$  centered at  $a_1$  as an induced subgraph.

Finally, suppose that the graph  $G_k$  is Hamiltonian. We observe that the edges incident with the degree 2 vertices,  $b_1, b_2, ..., b_k$  must be in a Hamiltonian cycle. These edges induce a cycle which does not contain the vertices  $c_1, c_2, ..., c_k$ , a contradiction. Hence,  $G_k$  is non-Hamiltonian and this completes the proof.  $\Box$ 

We will show that every 3- $\gamma\text{-vertex}$  critical graph is Hamiltonian when it is claw-free.

**Theorem 1** Let G be a 2-connected  $3-\gamma$ -vertex critical claw-free graph. Then G is Hamiltonian.

**Proof.** Suppose to the contrary that G does not contain a Hamiltonian cycle. Let C be a longest cycle of G. Thus there exists a component H of G-C. We let, further, that  $X = N_C(H)$ . We may order the vertices in X as  $x_1, ..., x_d$  according to  $\vec{C}$ . Because G is 2-connected, it follows that  $|X| \ge 2$ . We note by Lemma 5 that  $|\vec{C}[x_i^+, x_{i+1}^-]| \ge 3$  for all  $1 \le i \le d$ . We need to establish the following claims.

**Claim 1 :** For a vertex  $y \in V(C)$ , we have that  $D_y \cap V(C) \neq \emptyset$ .

Let  $y \in V(C)$ . Suppose to the contrary that  $D_y \cap V(C) = \emptyset$ . To dominate H,  $D_y \cap V(H) \neq \emptyset$ . Let  $u \in D_y \cap V(H)$ . Thus,  $|D_y - \{u\}| = 1$  by Lemma 6(i). Let  $\{v\} = D_y - \{u\}$ . Lemma 1 yields that u is not adjacent to any vertex in  $X^+ \cup X^-$ . Since  $D_y \succ G - y$ , it follows that  $vx_1^+, vx_2^+ \in E(G)$  when  $y \in \{x_1^-, x_2^-\}$  or  $vx_1^-, vx_2^- \in E(G)$  otherwise. This contradicts Lemma 2. Therefore  $D_y \cap V(C) \neq \emptyset$  and thus, establishing Claim 1.

**Claim 2 :** For a vertex  $y \in V(C)$ , we have that  $|D_y \cap X| \leq 1$ .

Suppose to the contrary that  $|D_y \cap X| \ge 2$ . By Lemma  $6(i), |D_y \cap X| = 2$ . Let  $D_y = \{x_i, x_j\}$ . Without loss of generality, let  $y \notin \overrightarrow{C}[x_i, x_j]$ . Thus  $\{x_i, x_j\} \succ \overrightarrow{C}[x_i, x_j]$ . We note by Lemma 4 that  $x_i$  does not dominate  $\overrightarrow{C}[x_i, x_j^{2-}]$ . Let  $|\overrightarrow{C}[x_i, x_j^{2-}]| = t_0$ . We can order the vertices in  $\overrightarrow{C}[x_i, x_j^{2-}]$  to be  $x_i, x_i^+, \dots, x_i^{(t_0-1)+}$ where  $x_i^{(t_0-1)+} = x_j^{-2}$ . Then, we let  $r_0 = max\{r: 1 \le r < t_0 \text{ and } x_ix_i^{r+} \in E(G)\}$ . Thus  $x_jx_i^{(r_0+1)+} \in E(G)$ . We see that

$$x_i x_i^{r_0} \overleftarrow{C} x_i^+ x_i^- \overleftarrow{C} x_j^+ x_j^- \overleftarrow{C} x_i^{(r_0+1)+} x_j P_H x_i$$

is a cycle longer than C, a contradiction. Hence,  $|D_y \cap X| \leq 1$  and we establish Claim 2.

Consider  $G - x_1$ . In view of Lemma 6(i),  $|D_{x_1}| = 2$ . We distinguish two cases.

Case 1 :  $D_{x_1} \cap X = \emptyset$ .

This implies by Claim 1 that  $D_{x_1} \cap V(C) \neq \emptyset$ . To dominate  $H, D_{x_1} \cap V(H) \neq \emptyset$ . Thus,  $|D_{x_1} \cap (V(C) - X)| = 1$  and  $|D_{x_1} \cap V(H)| = 1$ . Let  $\{a\} = D_{x_1} \cap (V(C) - X)$ and  $\{b\} = D_{x_1} \cap V(H)$ . Clearly, b is not adjacent to any vertex in  $V(G) - (X \cup (V(H)))$ . Therefore,  $a \succ V(G) - (X \cup (V(H)))$ .

Consider G - a. We have by Claim 1 that  $D_a \cap V(C) \neq \emptyset$ . Since  $a \succ V(G) - (X \cup (V(H)))$ , by Lemma 6(*ii*),  $D_a \cap (V(C) - X) = \emptyset$ . Thus  $D_a \subseteq X \cup V(H)$ . If  $D_a \subseteq V(H)$ , then, by Lemma 1,  $D_a$  does not dominate  $X^+$ , a contradiction. Thus,  $D_a \cap X \neq \emptyset$ . By Claim 2,  $|D_a \cap X| = 1$ , moreover,  $|D_a \cap V(H)| = 1$ . Let  $\{x_i\} = D_a \cap X$  and  $\{h\} = D_a \cap V(H)$ . By Lemma 1, h is not adjacent to any vertex in V(C) - X. This implies that  $x_i \succ V(C) - X$ . In particular,  $x_i x_j^+ \in E(G)$  for some  $x_j \in X - \{x_i\}$ . This contradicts Lemma 4. Hence, Case 1 cannot occur.

Case 2 :  $D_{x_1} \cap X \neq \emptyset$ .

This implies by Claim 2 that  $|D_{x_1} \cap X| = 1$ . Thus  $|D_{x_1} - X| = 1$ . Let  $\{x_i\} = D_{x_1} \cap X$  and  $\{u\} = D_{x_1} - X$ . In view of Lemma 4,  $x_i$  is not adjacent to any vertex in  $W = \{x_1^+, x_1^{2+}, x_1^{-}, x_1^{2-}\}$ . Thus  $u \succ W$ . This implies by Lemma 1 that  $u \notin V(H)$ . In the following, we assume by Lemma 3 that  $x_i^+ x_i^-, x_1^+ x_1^- \in E(G)$ .

Suppose that  $u \notin V(C)$ . Let  $|\overrightarrow{C}[x_i^+, x_1^-]| = t_1$ . The vertices in  $\overrightarrow{C}[x_i^+, x_1^-]$  can be ordered as  $x_i^+, x_i^{2+}, \dots, x_i^{t_1+}$  where  $x_i^{t_1+} = x_1^-$ . Then we let  $r_1 = max\{r : 1 \le r < t_1 \text{ and } x_i x_i^{r+} \in E(G)\}$ . Therefore,  $ux_i^{(r_1+1)+}$ . Clearly,

$$x_i x_i^{r_1+} \overleftarrow{C} x_i^+ x_i^- \overleftarrow{C} x_1^+ u x_i^{(r_1+1)+} \overrightarrow{C} x_1 P_H x_i$$

is a cycle longer than C, a contradiction. Therefore,  $u \in V(C)$ . Thus either  $u \in \overrightarrow{C}[x_i^+, x_1^-]$  or  $u \in \overrightarrow{C}[x_1^+, x_i^-]$ .

Subcase 2.1 : 
$$u \in \overrightarrow{C}[x_i^+, x_1^-]$$
.

Recall that  $ux_1^+, ux_1^{2+} \in E(G)$  but  $x_ix_1^+, x_ix_1^{2+} \notin E(G)$ . Thus, Lemma 2 implies that  $u \neq x_i^+$ . Let  $|\overrightarrow{C}[x_1^+, x_i^-]| = t_2$ . We can order the vertices in  $\overrightarrow{C}[x_1^+, x_i^-]$  as  $x_1^+, x_1^{2+}, ..., x_1^{t_2+}$  where  $x_1^{t_2+} = x_i^-$ . Then we let  $r_2 = min\{r : 1 < r \le t_2$  and  $x_ix_1^{r+} \in E(G)\}$ . By Lemma 4,  $r_2 > 2$ . We then have that  $ux_1^{(r_2-1)+} \in E(G)$ 

because  $\{x_i, u\} \succ G - x_1$ . If  $u = x_1^-$ , then

$$x_i x_1^{r_2+} \overrightarrow{C} x_i^{-} x_i^{+} \overrightarrow{C} u x_1^{(r_2-1)+} \overleftarrow{C} x_1 P_H x_i$$

is a cycle longer than C, a contradiction. Hence, suppose that  $u \neq x_1^-$ . We distinguish two subcases.

### Subcase 2.1.1 : $u^+u^- \in E(G)$ .

Since  $u \succ W$ ,  $ux_1^- \in E(G)$ . Thus,

$$x_i x_1^{r_2+} \overrightarrow{C} x_i^- x_i^+ \overrightarrow{C} u^- u^+ \overrightarrow{C} x_1^- u x_1^{(r_2-1)+} \overleftarrow{C} x_1 P_H x_i$$

is cycle longer than C, a contradiction. Thus this subcase cannot occur.

Subcase 2.1.2 :  $u^+u^- \notin E(G)$ 

By claw-freeness of  $G,\, x_1^{(r_2-1)+}$  is adjacent to  $u^-$  or  $u^+.$  If  $x_1^{(r_2-1)+}u^-\in E(G),$  then

$$x_i x_1^{r_2+} \overrightarrow{C} x_i^- x_i^+ \overrightarrow{C} u^- x_1^{(r_2-1)+} \overleftarrow{C} x_1^+ u \overrightarrow{C} x_1 P_H x_i$$

is a cycle longer than C, a contradiction. Thus  $x_1^{(r_2-1)+}u^+ \in E(G)$ . We see that

$$x_i x_1^{r_2+} \overrightarrow{C} x_i^{-} x_i^{+} \overrightarrow{C} u x_1^{+} \overrightarrow{C} x_1^{(r_2-1)+} u^{+} \overrightarrow{C} x_1 P_H x_i$$

is a cycle longer than C, a contradiction. Therefore, Subcase 2.1 cannot occur.

Subcase 2.2 : 
$$u \in \overrightarrow{C}[x_1^+, x_i^-].$$

Since  $u \succ W$ , we have that  $ux_1^-, ux_1^{2-} \in E(G)$ . By Lemma 2,  $u \neq x_i^-$ . Let  $|\overrightarrow{C}[x_i^+, x_1^-]| = t_3$ . The vertices in  $\overrightarrow{C}[x_i^+, x_1^-]$  can be ordered as  $x_i^+, x_i^{2+}, ..., x_i^{t_3+}$  where  $x_i^{t_3+} = x_1^-$ . Then we let  $r_3 = max\{r: 1 \leq r < t_3 \text{ and } x_ix_i^{r+} \in E(G)\}$ . Because  $\{u, x_i\} \succ G - x_1$  and  $x_1 \notin \overrightarrow{C}[x_i^+, x_1^-]$ , it follows that  $ux_i^{(r_3+1)+}$ . If  $u = x_1^+$ , then

$$x_i x_i^{r_3+} \overleftarrow{C} x_i^+ x_i^- \overleftarrow{C} u x_i^{(r_3+1)+} \overrightarrow{C} x_1 P_H x_i$$

is a cycle longer than C, a contradiction. Thu,  $u\neq x_1^+.$  We distinguish two more subcases.

**Subcase 2.2.1 :**  $u^+u^- \in E(G)$ .

As  $u \succ W$ , we must have  $ux_1^+ \in E(G)$ . Thus,

$$x_i x_1^{r_3+} \overleftarrow{C} x_i^+ x_i^- \overleftarrow{C} u^+ u^- \overleftarrow{C} x_1^+ u x_i^{(r_3+1)+} \overrightarrow{C} x_1 P_H x_i$$

is cycle longer than C, a contradiction. Thus this subcase cannot occur.

Subcase 2.2.2 :  $u^+u^- \notin E(G)$ 

By claw-freeness of  $G,\, x_i^{(r_3+1)+}$  is adjacent to  $u^-$  or  $u^+.$  If  $x_i^{(r_3+1)+}u^-\in E(G),$  then

$$x_i x_i^{r_3+} \overleftarrow{C} x_i^+ x_i^- \overleftarrow{C} u x_1^- \overleftarrow{C} x_i^{(r_3+1)+} u^- \overleftarrow{C} x_1 P_H x_i$$

is a cycle longer than C, a contradiction. Thus  $x_i^{(r_3+1)+}u^+\in E(G).$  We see that

$$x_i x_i^{r_3+} \overleftarrow{C} x_i^+ x_i^- \overleftarrow{C} u^+ x_i^{(r_3+1)+} \overrightarrow{C} x_1^- u \overleftarrow{C} x_1 P_H x_i$$

is a cycle longer than C, a contradiction. Therefore, Subcase 2.2 cannot occur. Hence, G is Hamiltonian and this completes the proof.  $\Box$ 

In view of Lemma 8, we see that the condition claw-free in Theorem 1 is best possible.

## 3 Hamiltonicity of k- $\gamma_c$ -vertex critical graphs

In this section we present a new method (without using the classical method) to prove that every 2-connected  $3-\gamma_c$ -vertex critical claw-free graphs is Hamiltonian. Moreover, for  $4 \le k \le 5$ , we prove that every 3-connected  $k-\gamma_c$ -vertex critical claw-free graph is Hamiltonian. For  $3 \le k \le 5$ , we find some 2-connected  $k-\gamma_c$ -vertex critical non-Hamiltonian graphs containing a claw as an induced subgraph. We first give some related results that we use in the first subsection.

### 3.1 Set up and known results

In this subsection, we begin with a result of Chvátal [6] which is a property of a graph when it is Hamiltonian.

**Lemma 9** Let G be a Hamiltonian graph and  $S \subseteq V(G)$  a cut set of G. Then  $\frac{|S|}{\omega(G-S)} \geq 1$ .

In the study on Hamiltonicity of claw-free graphs, there is a technique the so called *local completion* introduced by Ryjáček [11]. The purpose of this technique is to find the closure cl(G) of a claw-free graph G. As we use only the results of this operation, we may omit the detail of finding the closure of a graph. However, it is worth noting that V(G) = V(cl(G)) and  $E(G) \subseteq E(cl(G))$ . Brousek et al. [5] used this closure operation to establish the Hamiltonian properties of  $\{K_{1,3}, N_{s_1,s_2,s_3}\}$ -free graphs. The following graphs were found in [5].

#### The Class $\mathcal{F}_1$ :




Figure 4(a) : The Class  $\mathcal{F}_1$

Let  $Q_1, ..., Q_5$  be complete graphs of order at least three. For  $1 \leq i \leq 3$ , let  $q_i, z_i$  be two different vertices of  $Q_i$ . Moreover, let  $q'_1, q'_2, q'_3$  be three different vertices of  $Q_4$  and  $z'_1, z'_2, z'_3$  be three different vertices of  $Q_5$ . A graph in this class is constructed from  $Q_1, ..., Q_5$  by identifying  $q'_i$  with  $q_i$  and  $z'_i$  with  $z_i$  for  $1 \leq i \leq 3$ . A graph in this class is illustrated by Figure 4(a). Note that, an *oval* in the figure denotes a compete graph.

#### The Class $\mathcal{F}_2$ :

Let  $c_1c_2c_3c_1$  and  $f_1f_2f_3f_1$  be two disjoint triangles. We also let  $R_1$  and  $R_2$  be two complete graphs of order at least three and  $R_3$  a complete graph of order at least two Let  $c'_i, f'_i$  be two different vertices of  $R_i$  for  $1 \le i \le 2$  and let  $c'_3, r$  be two different vertices of  $R_3$ . A graph in this class is obtained by identifying  $c'_i$ with  $c_i$  and  $f'_i$  with  $f_i$  for  $1 \le i \le 2$  and identifying  $c'_3$  with  $c_3$  and adding an edge  $rf_3$ . A graph in this class is illustrated by Figure 4(b).

#### The Class $\mathcal{F}_3$ :

Let  $y_1y_2...y_6y_1$  be a cycle of six vertices and K a complete graph of order at least three. Let w and w' be two different vertices of K. We define a graph G in the class  $\mathcal{F}_3$  by adding edges  $wy_1, wy_6, w'y_3, w'y_4$ . A graph in this class is illustrated by Figure 4(c).

Figure 4(b) : The Class  $\mathcal{F}_2$ 




Figure 4(c) : The Class  $\mathcal{F}_3$ 

Let  $P = u_1 u_2 u_3$ ,  $P' = v_1 v_2 v_3$  and  $P'' = w_1 w_2 w_3$  be three paths of length two. The graph  $P_{3,3,3}$  is constructed from P, P' and P'' by adding edges so that  $\{u_1, v_1, w_1\}$  and  $\{u_3, v_3, w_3\}$  form two complete graphs of order three. Brousek et al. [5] proved :

**Theorem 2** [5] Let G be a 2-connected  $\{K_{1,3}, N_{1,2,2}, N_{1,1,3}\}$ -free graph. Then either G is Hamiltonian, or G is isomorphic to  $P_{3,3,3}$  or  $cl(G) \in \mathcal{F}_1 \cup \mathcal{F}_2 \cup \mathcal{F}_3$ .

Xiong et al.[20] generalized Theorem 2 into 3-connected graphs by establishing the following theorem.

**Theorem 3** [20] Let G be a 3-connected  $\{K_{1,3}, N_{s_1,s_2,s_3}\}$ -free graph. If  $s_1 + s_2 + s_3 \leq 9$  and  $s_i \geq 1$ , then G is Hamiltonian.

In the context of k- $\gamma_c$ -vertex critical graphs, Ananchuen et al. [2] established a basic property of these graphs.

**Lemma 10** [2] For  $k \ge 2$ , if G is a k- $\gamma_c$ -vertex critical graph and  $v \in V(G)$ , then  $\gamma_c(G-v) = k-1$ .

They, further, established a class of  $3-\gamma_c$ -vertex critical graphs. These graphs will be shown in this paper that they are  $3-\gamma_c$ -vertex critical non-Hamiltonian graphs containing a claw as an induced subgraph. For an integer  $l \geq 6$ , let  $H_l$  be a copy of complete graph with the vertices  $v_1, v_2, ..., v_l$  and remove a Hamiltonian cycle  $v_1v_2...v_l$ . Moreover, let J be a graph of  $\frac{l(l-3)}{2} - l$  isolated vertices  $v_{i,j}$  where  $1 \leq i < j \leq l$  except the cases when j = i + 1 and j = i + 2 modulo l. The graph

 $J_l$  is constructed by  $H_l$  and J by adding edges from  $H_l$  to J except the edges  $v_i v_{i,j}$  and  $v_j v_{i,j}$ .

Recently, Kaemawichanurat and Caccetta [13] established relationship between cardinalities of independent set and connected dominating set of claw free graphs.

**Lemma 11** [13] Let G be a claw-free graph, X be a vertex subset and I be an independent set of G such that  $X \succ_c I$ . Then  $|I| \leq |X| + 1$ .




Figure 5 : A 5- $\gamma_c$ -vertex critical graph containing claw which is non-Hamiltonian.

In [12], the author found a 5- $\gamma_c$ -vertex critical graph as illustrated by Figure 5. It is not difficult to see that this graph contains a claw as an induced subgraph and is non-Hamiltonian.

Next, we will give a construction of some  $k-\gamma_t$ -vertex critical graphs from Wang and Wang [18]. These graphs will be shown in this paper that they are  $4-\gamma_c$ -vertex critical non-Hamiltonian graphs containing a claw as an induced subgraph. Let

 $U_1 = \{u_{1,1}, u_{1,2}, ..., u_{1,l}\}, U_2 = \{u_{2,1}, u_{2,2}, ..., u_{2,l}\}, U_3 = \{u_{3,1}, u_{3,2}, ..., u_{3,l}\}, U_4 = \{y_1, y_2, y_3, y_4\}.$ 

A graph G in the class  $\mathcal{T}_l$  has the vertex set  $U_1 \cup U_2 \cup U_3 \cup U_4 \cup \{u\}$  and the edge set

 $\{uu_{i,j}: i = 1, 2, 3, j = 1, 2, ..., l\} \cup \{y_1u_{1,i}: i = 1, 2, ..., l\}$ 

 $\cup \{y_2u_{2,i}: u_{2,i}, i = 1, 2, ..., l\} \cup \{y_3u_{i,j}: i = 2, 3, j = 1, 2, ..., k\}$ 

 $\cup \{y_4 u_{3,i} : i = 1, 2, ..., l\} \cup \{y_1 y_2, y_2 y_3, y_3 y_4, y_4 y_1\}$ 

 $\{u_{1,i}u_{2,j}: i \neq j \text{ and } i, j = 1, 2, ..., l\} \cup \{u_{1,i}u_{3,j}: i \neq j \text{ and } i, j = 1, 2, ..., l\}.$ 

We conclude this section with a result concerning the relationship between 4- $\gamma_c$ -vertex critical graphs and 4- $\gamma_t$ -vertex critical graphs. This result was proved by Kaemawichanurat et al. [14].

**Theorem 4** [14] Let G be a 2-connected graph. Then G is  $4-\gamma_c$ -vertex critical if and only if G is  $4-\gamma_t$ -vertex critical.

### 3.2 Main results

We are ready to prove the following theorems. For a graph G containing a vertex v, we let  $D_v^c$  be a smallest connected dominating set of G - v.

**Theorem 5** Let G be a 2-connected  $3-\gamma_c$ -vertex critical claw-free graph. Then G is Hamiltonian.

**Proof.** We first show that G is  $\{N_{1,2,2}, N_{1,1,3}\}$ -free graph. Suppose to the contrary that G contains  $N_{1,2,2}$  as an induced subgraph. Consider  $G-w_1$ . Clearly, the graph  $G-w_1$  is claw free, moreover,  $I_1 = \{w_2, v_1, v_3, u_1\}$  is an independent set of  $G-w_1$ . Thus  $|D_{w_1}^c| \succ_c I_1$ . This implies by Lemma 11 that  $|D_{w_1}^c|+1 \ge |I_1| \ge 4$ . So  $|D_{w_1}^c| \ge 3$  contradicting Lemma 10. Therefore, G is an  $N_{1,2,2}$ -free graph. Similarly, suppose to the contrary that G contains  $N_{1,1,3}$  as an induced subgraph. Consider  $G-u_1$ . Thus, the graph  $G-u_1$  is claw free and  $I_2 = \{u_2, v_1, w_1, w_3\}$  is an independent set of  $G-u_1$ . So  $|D_{u_1}^c| \succ_c I_2$ . Lemma 11 then gives that  $|D_{u_1}^c|+1 \ge |I_2| \ge 4$ . Thus  $|D_{w_1}^c| \ge 3$  contradicting Lemma 10. Therefore, G is an  $N_{1,1,3}$ -free graph.

Clearly,  $\gamma_c(P_{3,3,3}) = 5$ . Therefore, G is not  $P_{3,3,3}$ . To show that G is Hamiltonian, by using Theorem 2, it remains to show that  $cl(G) \notin \mathcal{F}_1 \cup \mathcal{F}_2 \cup \mathcal{F}_3$ . Suppose to the contrary that  $cl(G) \in \mathcal{F}_1 \cup \mathcal{F}_2 \cup \mathcal{F}_3$ . We first consider the case when  $cl(G) \in \mathcal{F}_1$ . Consider  $G - q_1$ . Thus  $|D_{q_1}^c| = 2$  by Lemma 10. To dominate  $V(Q_2) \cup V(Q_3)$ , we have  $D_{q_1}^c \subseteq V(Q_2) \cup V(Q_3)$ . So  $D_{q_1}^c$  does not dominate  $V(Q_1) - \{q_1, z_1\}$ , a contradiction. Therefore,  $cl(G) \notin \mathcal{F}_1$ . We now consider the case when  $cl(G) \in \mathcal{F}_2$ . Consider  $G - c_3$ . Similarly,  $D_{c_3}^c \subseteq V(R_1) \cup V(R_2)$ . We see that  $D_{c_3}^c$  does not dominate r. Thus  $cl(G) \notin \mathcal{F}_2$ . We finally consider the case when  $cl(G) \in \mathcal{F}_3$ . Consider G - w. Thus,  $D_w^c \subseteq \{y_1, y_2, ..., y_6\}$  to dominate  $\{y_2, y_5\}$ . We see that  $D_w^c$  does not dominate  $K - \{w, w'\}$ , a contradiction. Therefore,  $cl(G) \notin \mathcal{F}_3$ . In view of Theorem 2, G is Hamiltonian.  $\Box$ 

Recall the graph  $J_l$  which is defined by Ananchuen et al. [2] in Subsection 3.1. Observe that when  $l \ge 8$ ,  $|V(J)| > |V(H_l)|$ . Clearly,  $V(H_l)$  is a cut set of  $J_l$  such that  $J_l - V(H_l)$  has the isolated vertices of J as the |J| components. Thus  $\frac{|V(H_l)|}{\omega(J_l - V(H_l))} < 1$ . By Lemma 9,  $J_l$  is non-Hamiltonian when  $l \ge 8$ . Therefore, the condition claw-free in Theorem 5 is necessary.

**Theorem 6** For  $4 \le k \le 5$ , let G be a 3-connected k- $\gamma_c$ -vertex critical claw-free graph. Then G is Hamiltonian.

**Proof.** We will show that G is an  $N_{3,3,3}$ -free graph. Suppose to the contrary that G contains  $N_{3,3,3}$  as an induced subgraph. Consider  $G - w_2$ . Clearly, the graph  $G - w_2$  is claw-free and  $I_3 = \{w_1, w_3, u_1, u_3, v_1, v_3\}$  is an independent set. Since  $D_{w_2}^c \succ_c I_3$ , by Lemma 11,  $|D_{w_2}^c| \geq 5$ . This implies by Lemma 10 that  $k \geq 6$ , a contradiction. Hence, G is an  $N_{3,3,3}$ -free graph. In view of Theorem 3, G is Hamiltonian.  $\Box$ 

Recall the graph  $\mathcal{T}_l$  which is defined by Wang and Wang [18]. in Subsection 3.1. Theorem 4 implies that  $\mathcal{T}_l$  is also a class of  $4 \cdot \gamma_c$ -vertex critical graphs. For a graph G in this class, G contains a claw as an induced subgraph and  $U_1 \cup U_4 \cup \{u\}$  is a cut set of l+5 vertices such that  $G - (U_1 \cup U_4 \cup \{u\})$  has isolated vertices in  $U_2 \cup U_3$  as the 2l components. Thus, when  $l \geq 6$ , we have that  $\frac{|U_1 \cup U_4 \cup \{u\}|}{\omega(G - (U_1 \cup U_4 \cup \{u\}))} < 1$ . By Lemma 9, G is non-Hamiltonian. Hence, the condition claw-free in Theorem 6 is necessary.

Finally, The graph in Figure 5 is a  $5-\gamma_c$ -vertex critical non-Hamiltonian graph containing a claw. Therefore, the condition claw-free and 3-connected in Theorem 6 are necessary.
