# ON SINGULARITIES OF THREEFOLD WEIGHTED BLOWUPS 

YIFEI CHEN


#### Abstract

We answer a conjecture raised by Caucher Birkar of singularities of weighted blowups of $\mathbb{A}^{n}$ for $n \leq 3$.


## 1. Introduction

Throughout this paper, we work over the field of complex numbers $\mathbb{C}$.
The concept of complements is introduced by Shokurov when he studied log flips of threefolds ([Sh92]). The theory of complements is further developed in [Sh00],[PS01],[PS09], [Bi19]. It is related to the boundedness of varieties and singularities of linear systems. It becomes a key ingredient of Birkar's BBAB Theorem, which confirms BAB conjecture ([Bi19],[Bi16]), and the construction of moduli of stable Fano varieties ([BLX19], [X19]).

Theorem 1.1 (Theorem 1.1 [Bi19]). Let d be a natural number. Then there is a natural number $m$ depending only on $d$ such that if $X$ is any Fano variety of dimension $d$ with klt singularities, then there exists an m-complement for $K_{X}$.

There is a general setting $(\epsilon, n)$-complements for $\log$ pairs $(X, B)$. we refer to ([Bi19] 2.18) and ([HLS19]) for the definition and some related conjectures. It is conjectured the existence of such $(\epsilon, n)$-complements if $B \in \Gamma$, where $\Gamma \subseteq[0,1]$ is a DCC set. It is proved by Shokurov for the case $\epsilon=0, \operatorname{dim} X=2$ and $\Gamma$ is the standard set; by Prokhorov and Shokurov for the case $\epsilon=0$, $\operatorname{dim} X=3$ and $\Gamma$ is a hyperstandard set; by Birkar ([Bi19] Theorem 1.7, 1.8) for the case $\epsilon=0, \Gamma$ is a hyperstandard set; by Han, Liu and Shokurov ([HLS19] Teorem 1.14) for the case $\Gamma$ is a DCC set. Recently, Shokurov ([Sh19]) announces a proof of the boundedness of complements in this general case, $\epsilon=0$ and $\Gamma=[0,1]$, under some conditions. Shokurov ([Sh19]) also proves the existence of complements imply some important and well-known results, such as the ACC of $\log$ canonical thresholds, the finite generation of $\log$ canonical rings for klt pairs and the existence of flips. There are some recent progress for the theory of complements. We refer reads to [FMX19], [HLS19], [Sh19] and [Xu19] for more details.

The following conjecture due to Shokurov is one of major important open problems in birational geometry.

Conjecture 1.2 (Shokurov). Let d be a natural number, є a positive real number. Then there is a natural number $n$ depending only on $d$ and $\epsilon$ such that if
$X \rightarrow Z$ is a Fano contraction, that is $-K_{X}$ is ample $/ Z$, and $X$ is $\epsilon$-lc, then there exists an $n$-klt complement for $K_{X}$ over any point $z \in Z$.

The conjecture is known up to $\operatorname{dim} X=2$ ([Bi04]).
Birkar raises the following conjectures which are related to Conjecture 1.2.
Let $n \in \mathbb{N}_{+}$be a positive integer, $a_{1}, a_{2}, \ldots, a_{n}$ coprime positive integers such that $a_{1} \leq a_{2} \leq \cdots \leq a_{n}$. Let $X_{\mathbf{a}}$ be the weighted blow up of the affine $n$-plane $\mathbb{A}^{n}$ at the origin with the weight $\mathbf{a}=\left(a_{1}, a_{2}, \ldots, a_{n}\right)$ (see Section 2.4).

Conjecture 1.3 (Birkar). If $X_{a}$ has terminal singularities, is $a_{1}$ bounded?
One related result with the Conjecture is the divisorial contraction of terminal threefolds obtained by Kawakita.

Theorem 1.4 ([K01] Theorem 1.1). Let $Y$ be a $\mathbb{Q}$-factorial normal variety of dimension three with only terminal singularities, and let $f:(Y \supset E) \rightarrow$ $(X \ni P)$ be an algebraic germ of a divisorial contraction which contracts its exceptional divisor $E$ to a smooth point $P$. Then $f$ is a weighted blowup. More precisely, we can take local coordinates $x, y, z$ at $P$ and coprime positive integers $a$ and $b$, such that $f$ is the weighted blow-up of $X$ with its weights wt $(x, y, z)=$ $(1, a, b)$.

Very recently, Sankaran ([Sa19]) has given an affirmative answer to Conjecture 1.3 for the case $n=4$.

Compared with Conjecture 1.3, a more general conjecture of Birkar is:
Conjecture 1.5 (Birkar). For a fixed positive integer $n$ and a fixed positive real number $\epsilon \in(0,1]$, is there a positive integer $M$ depending only on $n$ and $\epsilon$, such that if $X_{\boldsymbol{a}}$ is $\epsilon$-lc, then $a_{1} \leq M$, where $\boldsymbol{a}=\left(a_{1}, a_{2}, \ldots, a_{n}\right), a_{1} \leq a_{2} \leq \cdots \leq a_{n}$ and $a_{1}, a_{2}, \ldots, a_{n}$ are coprime.

One can not expect all $a_{i}$ are bounded, see Example 2.14.
Sankaran and Santos recently claim that Conjecture 1.5 holds for $\epsilon=1$ and any $n$. That is the case of canonical singularities.

In the paper, we study Conjecture 1.5, and get the following partial cases.
Theorem 1.6 (Main Theorem). Conjecture 1.5 holds if:

1) $n=2$.
2) $n=3$.
3) $\frac{a_{j}}{a_{2}} \leq a_{1}^{\theta}$ for all $3 \leq j \leq n$, where $\theta$ is a fixed real number such that $0<\theta<\frac{1}{2 n^{2}}$.

The problem is a toric geometry problem. Conjecture 1.5 can be reduced to a geometry of number problem, which is to prove the existence of an integral point in the interior of certain convex polytope. Then we can apply Dirichlet's approximation theorem (Theorem 2.11, Theorem 2.12).

## 2. Preliminaries

2.1. Pairs and singularities. A $\log \operatorname{pair}(X, B)$ consists of a normal variety $X$ and an $\mathbb{R}$-divisor $B \geq 0$ such that $K_{X}+B$ is $\mathbb{R}$-Cartier. An extraction is a proper birational morphism of normal varieties.

If $(X, B)$ is a $\log$ pair and $\mu: \tilde{X} \rightarrow X$ is an extraction, there exists a unique divisor $\tilde{B}$ on $\tilde{X}$ such that $\mu^{*}\left(K_{X}+B\right)=K_{\tilde{X}}+\tilde{B}$ and $\tilde{B}=\mu^{-1} B$ on $\tilde{X} \backslash \operatorname{Exc}(\mu)$. The identity $\tilde{B}=\sum_{E \subset \tilde{X}}(1-a(E ; X, B)) E$ associates to each prime divisor $E$ of $\tilde{X}$ a real number $a(E ; X, B)$, called the $\log$ discrepancy of $E$ with respect to $(X, B)$. For simplicity, we write $\operatorname{mld}(E ; B)$ for $\operatorname{mld}(E ; X, B)$.
Definition 2.2 ([Sh88]) The minimal log discrepancy of a $\log$ pair $(X, B)$ at a proper Grothendieck point $\eta \in X$ is defined as

$$
\operatorname{mld}(\eta ; X, B)=\inf _{c_{X}(E)=\eta} a(E ; X, B)
$$

where the infimum is taken after all prime divisors on extractions of $X$ having $\eta$ as a center on $X$. We set by definition $\operatorname{mld}\left(\eta_{X} ; X, B\right)=0$.

The $\log$ pair $(X, B)$ has only $l c$ ( $k l t, \epsilon$-lc) singularities if $\operatorname{mld}(\eta ; B) \geq 0$ $(\operatorname{mld}(\eta ; B)>0, \operatorname{mld}(\eta ; B) \geq \epsilon)$ for every proper point $\eta \in X .(X, B)$ has only canonical (terminal) singularities if $\operatorname{mld}(\eta ; B) \geq 1(\operatorname{mld}(\eta ; B)>1)$ for every point $\eta \in X$ of codimension at least 2 .
2.3. Complements. Let $X$ be a normal variety. We say that there exists an $n$-complement ( $n$-klt complement) for $K_{X}$, if there exists a pair $(X, B)$, such that $(X, B)$ is lc (klt), and $n\left(K_{X}+B\right) \sim 0$.

Let $f: X \rightarrow Z$ be a contraction, that is, $f_{*} \mathcal{O}_{X}=\mathcal{O}_{Z}$. We say that there exists an $n$-klt complement for $K_{X}$ over a point $z \in Z$, if there exists a pair $(X, B)$, such that $(X, B)$ is klt, and $n\left(K_{X}+B\right) \sim 0 / z \in Z$.

We refer readers to [Sh00], [PS01], [PS09], [Bi04], [Bi19], [FMX19], [HLS19], [Sh19] and [Xu19] for more background and applications of complements.
2.4. Weighted blowups. To be self-contained, we quote [KSC04] 6.38 for the definition of weighted blow-ups.

Weighted blow-ups can be described in terms of charts in a manner similar to the standard blowup, but subject to a group action. Recall that if we fix one of the standard affine charts of the blowup of the origin in $\mathbb{A}^{n}$, the blowing up morphism is given there by

$$
\begin{gathered}
\pi_{i}^{\prime}: \mathbb{A}^{n} \rightarrow \mathbb{A}^{n} \\
\left(x_{1}^{\prime}, \ldots, x_{n}^{\prime}\right) \mapsto\left(x_{i}^{\prime} x_{1}^{\prime}, \ldots, x_{i}^{\prime} x_{i-1}^{\prime}, x_{i}^{\prime}, x_{i}^{\prime} x_{x+1}^{\prime}, \ldots, x_{i}^{\prime} x_{n}^{\prime}\right)
\end{gathered}
$$

In other words, $\pi_{i}^{\prime}$ is given by the formulas

$$
x_{j}=x_{j}^{\prime} x_{i}^{\prime}, \quad \text { if } \quad j \neq i \quad \text { and } \quad x_{i}=x_{i}^{\prime} .
$$

To describer the analog for weighted blow-ups, fix relatively prime positive integers $a_{1}, \ldots, a_{n}$. For each $i$ between 1 and $n$, define a morphism $p_{i}: \mathbb{A}^{n} \rightarrow \mathbb{A}^{n}$ by

$$
x_{j}=x_{j}^{\prime}\left(x_{i}^{\prime}\right)^{a_{j}} \quad \text { if } \quad j \neq i \quad \text { and } \quad x_{i}=\left(x_{i}^{\prime}\right)^{a_{i}}
$$

The map $p_{i}$ is birational if and only if $a_{i}=1$; more generally, it has degree $a_{i}$. Note that the map is well defined on the orbits of the $\mathbb{Z}_{a_{i}}$-action

$$
\left(x_{i}^{\prime}, \ldots, x_{n}^{\prime}\right) \mapsto\left(\zeta^{-a_{1}} x_{1}^{\prime}, \ldots, \zeta^{-a_{i-1}} x_{i-1}^{\prime}, \zeta x_{i}^{\prime}, \zeta^{-a_{i+1}} x_{i+1}^{\prime}, \ldots, \zeta^{-a_{n}} x_{n}^{\prime}\right)
$$

where $\mathbb{Z}_{a_{i}}$ is a cyclic group of order $a_{i}$ generated by a primitive $a_{i}$-th root of unity $\zeta$. Therefore, $p_{i}$ descends to a birational morphism $\pi_{i}$ from the quotient variety:

$$
\pi_{i}: \mathbb{A}^{n} / \mathbb{Z}_{a_{i}} \xrightarrow{\pi_{i}} \mathbb{A}^{n}
$$

These maps $\pi_{i}$ patch together to give a birational projective morphism

$$
\pi: X_{\mathbf{a}}=B_{\left(a_{1}, \ldots, a_{n}\right)} \mathbb{A}^{n} \rightarrow \mathbb{A}^{n}
$$

This is the weighted blowup of $\mathbb{A}^{n}$ with weights $\mathbf{a}=\left(a_{1}, a_{2}, \ldots, a_{n}\right)$.
2.5. Minimal log discrepancies of toric varieties. We refer the reader to [Fu93] for definitions and basic notations of toric geometry. Let $X=T_{N} e m b(\Delta)$ be a toroidal embedding, and let $\left\{B_{i}\right\}_{i=1}^{r}$ be the $T_{N}$-invariant divisors of $X$, where $N$ is the lattice, corresponding to the primitive vectors $\left\{v_{i}\right\}_{i=1}^{r}$ on the 1-dimensional faces of $\Delta$. Let $B=\sum_{i}\left(1-a_{i}\right) B_{i}$ be an invariant $\mathbb{R}$-divisor. Let $\varphi$ be the piecewise linear function such that $\varphi\left(v_{i}\right)=a_{i}$ for every $i$.

Under the above assumptions, we have the following formula for the minimal log discrepancies of $(X, B)$ at the generic points of the orbits ([Am99]):

$$
\operatorname{mld}\left(\eta_{\text {orb }(\sigma)} ; B\right)=\inf \{\varphi(v) \mid v \in \operatorname{rel} \operatorname{int}(\sigma) \cap N\}, \sigma \in \Delta
$$

Here, $\operatorname{rel} \operatorname{int}(\sigma)$ denotes the relative interior of the cone $\sigma \subseteq \mathbb{R} \sigma$, and $\operatorname{orb}(\sigma)$ is the $T_{N}$-orbit corresponding to the cone $\sigma \in \Delta$.

Theorem 2.6 ([Am99] Theorem 4.1). In the above notations, let $X=\sqcup_{\sigma \in \Delta} \operatorname{orb}(\sigma)$ be the partition of $X$ into $T_{N}$-orbits. For every cone $\sigma \in \Delta$ and every closed point $x \in \operatorname{orb}(\sigma)$, the minimal discrepancy

$$
m l d(x, B)=\operatorname{mld}\left(\eta_{\text {orb }(\sigma)} ; B\right)+\operatorname{codim}(\sigma)
$$

2.7. Weighted blowups and toric varieties. By [Fu93], it is easy to see that weighted blow-ups $X_{\mathbf{a}}$ is a toric variety, where $\mathbf{a}=\left(a_{1}, \ldots, a_{n}\right)$. The fan $\Delta$ of $X_{\mathbf{a}}$ is a subdivision of the first quadrant. Precisely, the ray through $\left(a_{1}, a_{2}, \ldots, a_{n}\right)$ subdivides the first quadrant into $n$ cones of dimension $n$, and the fan $\Delta$ is the collection of these $n$ cones of dimension $n$.

Example 2.8 The fan of $X_{(a, b)}$


Example 2.9 The fan of $X_{(a, b, c)}$

2.10. Dirichlet's approximation theorem. Dirichlet's Theorem is a fundamental result in Diophantine approxiation.

Theorem 2.11. For any real number $\alpha$ and any positive integer $Z$, there exist integers $p$ and $q$ such that $1 \leq q \leq Z$ and

$$
|q \alpha-p|<\frac{1}{Z}
$$

The simultaneous version of the Dirichlet's approximation theorem is:
Theorem 2.12 (Dirichlet's approximation theorem). Given real numbers $\alpha_{1}, \ldots, \alpha_{d}$ and a positive integer $Z$, then there are integers $p_{1}, \ldots, p_{d}, q \in \mathbb{Z}, 1 \leq q \leq Z$ such that

$$
\left|\alpha_{i}-\frac{p_{i}}{q}\right| \leq \frac{1}{q Z^{\frac{1}{d}}} .
$$

### 2.13. Examples.

Example $2.14\left(X_{\mathbf{n}}, 0\right), \mathbf{n}=(1, n)$, are 1-lc for any positive integer $n$.


Indeed, let $\sigma_{1}$ be the cone generated by $e_{2}=(0,1)$ and $v=(1, n)$. Then $\sigma_{1}$ is a smooth cone. So $\operatorname{mld}(x ; 0)=2$, where $x$ is the toric invariant point corresponding to $\sigma_{1}$.

Let $\sigma_{2}$ be the cone generated by $e_{1}=(1,0)$ and $v$. The cone $\sigma_{2}$ is not smooth, but it has canonical singularities. We have $\operatorname{mld}(y ; 0)=1$, where $y$ is the toric invariant point corresponding to $\sigma_{2}$. Indeed, the linear function $\varphi$ such that $\varphi\left(e_{1}\right)=\varphi(v)=1$ takes minimal values on the lattice points $w_{i}=(1, i), 1 \leq i \leq$ $n-1$ in int $\sigma_{2}$ and $\varphi\left(w_{i}\right)=1$.

For any codimension 1 point $\eta, \operatorname{mld}(\eta ; 0)=1$.
Therefore, $X_{\mathbf{n}}$ are 1-lc for any positive integer $n$.
We can similar show the following example.
Example $2.15 X_{\mathbf{c}}$ is 1-lc, where $\mathbf{c}=\left(1, c_{2}, \ldots, c_{n}\right)$ for any $1 \leq c_{2} \leq \cdots \leq c_{n}$ and $\operatorname{gcd}\left(c_{2}, \ldots, c_{n}\right)=1$.

## 3. Reduction to a geometry of number problem

Lemma 3.1. Fix a positive integer $n$ and a positive real number $\epsilon \in(0,1]$. Let $C_{n}^{\epsilon}$ be the convex polytope with vertices

$$
\left\{\boldsymbol{0}, \epsilon \boldsymbol{e}_{1}, \epsilon \boldsymbol{e}_{2}, \ldots, \epsilon \boldsymbol{e}_{n}, \epsilon \boldsymbol{a}\right\}
$$

where $\left\{\boldsymbol{e}_{i}\right\}_{i=1}^{n}$ is the standard basis of $\mathbb{R}^{n}, \boldsymbol{a}=\left(a_{1}, \ldots, a_{n}\right) \in \mathbb{R}^{n}$, and $0 \leq a_{1} \leq$ $a_{2} \leq \cdots \leq a_{n}$.

Then Conjecture 1.5 holds, if there exists an integer $M$ depending only on $n$ and $\epsilon$, such that there exists an integral point in the interior of $C_{n}^{\epsilon}$ once $a_{1} \geq M$.

Example 3.2 The graphs of $C_{2}^{\epsilon}$ and $C_{3}^{\epsilon}$ are as follows


Proof of Lemma 3.1. Suppose there exists such an integer $M$ only depending on $n$ and $\epsilon$, that once $a_{1} \geq M$ then there would exist an integral point $\mathbf{w}$ in the interior of $C_{n}^{\epsilon}$. By assumption, $\operatorname{gcd}\left(a_{1}, \ldots, a_{n}\right)=1$, then the integral point $\mathbf{w}$ lies in the interior of a unique cone generated by a and $n-1$ vectors of $\left\{\mathbf{e}_{1}, \ldots, \mathbf{e}_{n}\right\}$. Without loss of generality, we can suppose that $\mathbf{w} \in \operatorname{rel}$ int $\tau$, where $\tau$ is the cone generated by $\left\{\mathbf{a}, \mathbf{e}_{1}, \ldots, \mathbf{e}_{n-1}\right\}$. Moreover, since $\mathbf{w}$ is in the interior of $\tau \cap C_{n}^{\epsilon}$, we have

$$
\mathbf{w}=\sum_{i=1}^{n-1} \lambda_{i} \cdot \epsilon \mathbf{e}_{i}+\lambda_{0} \cdot \epsilon \mathbf{a},
$$

where $0 \leq \lambda_{i} \leq 1$ for $i=0, \ldots, n-1$ and $0<\sum_{i=0}^{n-1} \lambda_{i}<1$.
View $X_{\mathbf{a}}$ as the log pair $\left(X_{\mathbf{a}}, 0\right)$. Let $\varphi$ be the piecewise linear function with $\varphi\left(\mathbf{e}_{i}\right)=1$ for $i=1, \ldots, n-1$ and $\varphi(\mathbf{a})=1$. Therefore,

$$
\varphi(\mathbf{w})=\sum_{i=1}^{n-1} \epsilon \lambda_{i} \varphi\left(\mathbf{e}_{i}\right)+\epsilon \lambda_{0} \varphi(\mathbf{a})=\epsilon \sum_{i=0}^{n-1} \lambda_{i}<\epsilon
$$

Apply the formula of minimal $\log$ discrepancies of toric varieties in Section 2.5 , we get

$$
\operatorname{mld}\left(\eta_{\operatorname{orb}(\tau)}\right)=\inf \{\varphi(\mathbf{v}) \mid \mathbf{v} \in \operatorname{rel} \operatorname{int}(\tau) \cap N\} \leq \varphi(\mathbf{w})<\epsilon
$$

Hence $X_{\mathbf{a}}$ is not $\epsilon$-lc, if $a_{1} \geq M$.

## 4. Proof of Main Theorem for $n=2$

As we discussed in Lemma 3.1, to prove Main Theorem for $n=2$, it suffices to prove Lemma 3.1 for $n=2$. We shall see that $M$ can be taken $\left\lfloor\left(\frac{2}{\epsilon}+1\right)^{2}\right\rfloor+1$, where $\rfloor$ is the round down function.

Proof of Lemma 3.1 for $n=2$. Let

$$
L_{1}: y-\epsilon=\frac{b-1}{a} x
$$

be the line passing through the points $(0, \epsilon)$ and $(\epsilon a, \epsilon b)$,

$$
L_{2}: y=\frac{b}{a-1}(x-\epsilon)
$$

the line passing through the points $(\epsilon, 0)$ and $(\epsilon a, \epsilon b)$. Let $\alpha=\frac{b}{a}$, and $Z=\lfloor\sqrt{a}\rfloor$. Then $\alpha \geq 1$ by assumption that $a \leq b$. Apply Dirichlet approximation Theorem 2.11, there exist integers $p$ and $q$ such that $1 \leq q \leq Z$ and $\left|\alpha-\frac{p}{q}\right|<\frac{1}{q Z}$.

Let

$$
L: y=\frac{p}{q} x
$$

be a line, and the point $\left(x_{0}, y_{0}\right)$ be the intersection point of $L$ and $L_{1}$ or $L_{2}$. The idea is to show that if $a$ is large enough, then the $x_{0}>q$. So there exists at least one integral point on the line $L$, and thus an integral point in the interior of $C_{2}^{\epsilon}$.

1) Case 1. $\frac{p}{q} \leq \frac{b}{a}$. In the case, $L$ intersects with $L_{2}$.


Notice that $\frac{p}{q}>\frac{b}{a}-\frac{1}{q Z}$ and $q Z \leq Z^{2} \leq a$. So

$$
\frac{b}{a-1}>\frac{b}{a} \geq \frac{p}{q}>\frac{b}{a}-\frac{1}{q Z}>0
$$

In the case,

$$
\begin{aligned}
x_{0} & =\frac{\epsilon \frac{b}{a-1}}{\frac{b}{a-1}-\frac{p}{q}}>\frac{\epsilon \frac{b}{a-1}}{\frac{b}{a-1}-\left(\frac{b}{a}-\frac{1}{q Z}\right)} \\
& =\frac{\epsilon}{1-\frac{a-1}{b} \cdot \frac{b}{a}+\frac{a-1}{b} \cdot \frac{1}{q Z}}=\frac{\epsilon}{\frac{1}{a}+\frac{a-1}{b} \frac{1}{q Z}} \\
& >\frac{\epsilon}{\frac{1}{a}+\frac{1}{q Z}} \geq q \frac{Z \epsilon}{2}
\end{aligned}
$$

The last inequality follows from $q Z \leq Z^{2} \leq a$.
Let $M=\left\lfloor\left(\frac{2}{\epsilon}+1\right)^{2}\right\rfloor+1$. If $a>M$, then $\sqrt{a}>\frac{2}{\epsilon}+1$ and thus

$$
x_{0}>q \frac{Z \epsilon}{2}=q \frac{\lfloor\sqrt{a}\rfloor \epsilon}{2}>q
$$

Hence there exists at least a lattice point in the interior of $C_{2}^{\epsilon}$.
2) Case 2. $\frac{p}{q}>\frac{b}{a}$. In the case, $L$ intersects with $L_{1}$.


Notice that $\frac{p}{q}<\frac{b}{a}+\frac{1}{q Z}$ and $q Z \leq Z^{2} \leq a$.

In the case,

$$
x_{0}=\frac{\epsilon}{\frac{p}{q}-\frac{b-1}{a}}>\frac{\epsilon}{\frac{b}{a}+\frac{1}{q Z}-\frac{b-1}{a}}=\frac{\epsilon}{\frac{1}{a}+\frac{1}{q Z}} \geq q \frac{Z \epsilon}{2}
$$

If $a>M=\left\lfloor\left(\frac{2}{\epsilon}+1\right)^{2}\right\rfloor+1$, then $\sqrt{a}>\frac{2}{\epsilon}+1$ and thus

$$
x_{0}>q \frac{Z \epsilon}{2}=q \frac{\lfloor\sqrt{a}\rfloor \epsilon}{2}>q
$$

Hence there exists at least a lattice point in the interior of $C_{2}^{\epsilon}$.

## 5. Proof of Main Theorem 3)

In the section, we consider general case of $n$.
Let $\Pi_{i}, 1 \leq i \leq n$, be the hyperplane passing through the set of vectors $\left\{\epsilon \mathbf{e}_{1}, \epsilon \mathbf{e}_{2}, \ldots, \epsilon \mathbf{e}_{n}, \epsilon \mathbf{a}\right\} \backslash\left\{\epsilon \mathbf{e}_{i}\right\}$. Then the equation for $\Pi_{i}$ is:

$$
\frac{\sum_{1 \leq j \neq i \leq n} a_{j}-1}{a_{i}} x_{i}=\sum_{1 \leq j \neq i \leq n} x_{j}-\epsilon
$$

Apply Dirichlet Approximation, Theorem 2.12, to the given real numbers $\frac{a_{2}}{a_{1}}, \ldots, \frac{a_{n}}{a_{1}}$ and the natural number $Z=\left\lfloor a_{1}^{\frac{1}{n}}\right\rfloor$, then there are integers $p_{2}, \ldots, p_{n}$ and $1 \leq p_{1} \leq Z$, such that

$$
\left|\frac{a_{i}}{a_{1}}-\frac{p_{i}}{p_{1}}\right| \leq \frac{1}{p_{1} Z^{\frac{1}{n-1}}}, \quad \text { for } \quad 2 \leq i \leq n
$$

and $p_{1} Z^{\frac{1}{n-1}} \leq Z^{\frac{n}{n-1}} \leq a_{1}^{\frac{1}{n-1}} \leq a_{1}$.
Let $L$ be the line defined by

$$
\left\{\begin{array}{c}
x_{2}=\frac{p_{2}}{p_{1}} x_{1} \\
\vdots \\
x_{n}=\frac{p_{n}}{p_{1}} x_{1}
\end{array}\right.
$$

Let $\lambda_{1}=0, \lambda_{i}=\frac{p_{j}}{p_{1}}-\frac{a_{j}}{a_{1}}, j=2, \ldots, n$. By Dirichlet Approximation, $\left|\lambda_{j}\right|<$ $\frac{1}{p_{1} Z^{\frac{1}{n-1}}}$.

Rewrite the equations of $\Pi_{i}$, we get

$$
\sum_{j \neq i}\left(x_{j}-\frac{a_{j}}{a_{i}} x_{i}\right)+\frac{x_{i}}{a_{i}}=\sum_{j \neq i}\left(x_{j}-\frac{a_{j}}{a_{1}} x_{1}-\frac{a_{j}}{a_{i}}\left(x_{i}-\frac{a_{i}}{a_{1}} x_{1}\right)\right)+\frac{x_{i}}{a_{i}}=\epsilon .
$$

The line $L$ intersects the hyperplane $\Pi_{i}$ for some $i$. Let $\left(x_{1}^{0}, x_{2}^{0}, \ldots, x_{n}^{0}\right)$ be the intersection point. Plug the equation of $L$ into the equation of $\Pi_{i}$, we get

$$
\sum_{j \neq i}\left(\left(\frac{p_{j}}{p_{1}}-\frac{a_{j}}{a_{1}}\right) x_{1}-\frac{a_{j}}{a_{i}}\left(\frac{p_{i}}{p_{1}}-\frac{a_{i}}{a_{1}}\right) x_{1}\right)+\frac{p_{i}}{p_{1}} \frac{x_{1}}{a_{i}}=\epsilon .
$$

Let

$$
A_{i}=\sum_{j \neq i}\left(\lambda_{j}-\frac{a_{j}}{a_{i}} \lambda_{i}\right)+\frac{1}{a_{i}}\left(\frac{a_{i}}{a_{1}}+\lambda_{i}\right)=\sum_{j \neq i}\left(\lambda_{j}-\frac{a_{j}}{a_{i}} \lambda_{i}\right)+\frac{1}{a_{1}}+\frac{\lambda_{i}}{a_{i}} .
$$

Then $x_{1}^{0}=\frac{\epsilon}{A_{i}}$.
The goal is to show there exists an integer $M$ depending on $n$ and $\epsilon$, such that if $a_{1}>M$, then $x_{1}^{0}>p_{1}$. Therefore, there exists at least one integral point in the interior of the convex body $C_{n}^{\epsilon}$.
Proposition 5.1 (=Main Theorem 3)). Suppose $\frac{a_{j}}{a_{2}} \leq a_{1}^{\theta}$ for all $3 \leq j \leq n$, where $\theta$ is a real number such that $0<\theta<\frac{1}{2 n^{2}}$. Then Conjecture 1.5 holds.
Proof. Since $a_{2} \leq a_{3} \leq \cdots \leq a_{n}$, we get $\frac{a_{j}}{a_{i}} \leq a_{1}^{\theta}$ for $i \neq 1$.
If $i=1$, then

$$
A_{1}=\sum_{j \neq 1} \lambda_{j}+\frac{1}{a_{1}}<\frac{n-1}{p_{1} Z^{\frac{1}{n-1}}}+\frac{1}{a_{1}} \leq \frac{n}{p_{1} Z^{\frac{1}{n-1}}}
$$

since $p_{1} Z^{\frac{1}{n-1}}<a_{1}$.
If $i \neq 1$, then
$0<A_{i}=\sum_{j \neq i}\left(\lambda_{j}-\frac{a_{j}}{a_{i}} \lambda_{i}\right)+\frac{1}{a_{1}}+\frac{\lambda_{i}}{a_{i}} \leq \frac{n-1}{p_{1} Z^{\frac{1}{n-1}}}+(n-1) a_{1}^{\theta} \frac{1}{p_{1} Z^{\frac{1}{n-1}}}+\frac{1}{a_{1}}+\frac{1}{a_{1}} \frac{1}{p_{1} Z^{\frac{1}{n-1}}}$
since $\lambda_{j}<\frac{1}{p_{1} Z^{\frac{1}{n-1}}}$ for all $j, \frac{a_{j}}{a_{i}} \leq a_{1}^{\theta}$ and $a_{i} \geq a_{1}$ for all $i \neq 1$,
Since $a_{1} \geq 1$ and $p_{1} Z^{\frac{1}{n-1}} \leq a_{1}$, we have

$$
\begin{gathered}
\frac{n-1}{p_{1} Z^{\frac{1}{n-1}}} \leq(n-1) a_{1}^{\theta} \frac{1}{p_{1} Z^{\frac{1}{n-1}}} \\
\frac{1}{a_{1}} \leq a_{1}^{\theta} \frac{1}{p_{1} Z^{\frac{1}{n-1}}} \\
\frac{1}{a_{1} p_{1} Z^{\frac{1}{n-1}}} \leq a_{1}^{\theta} \frac{1}{p_{1} Z^{\frac{1}{n-1}}}
\end{gathered}
$$

Therefore, $A_{i} \leq 2 n a_{1}^{\theta} \frac{1}{p_{1} Z^{\frac{1}{n-1}}}$ for all $i$.
So

$$
\frac{x_{1}^{0}}{p_{1}}=\frac{\epsilon}{p_{1} A_{i}} \geq \frac{\epsilon Z^{\frac{1}{n-1}}}{2 n a_{1}^{\theta}}>\frac{\epsilon\left(a_{1}^{\frac{1}{n}}-1\right)^{\frac{1}{n-1}}}{2 n a_{1}^{\theta}}>\frac{\epsilon}{4 n} a_{1}^{\frac{1}{n(n-1)}-\theta}
$$

As $a_{1}$ is sufficiently large, $\left(a_{1}^{\frac{1}{n}}-1\right)^{\frac{1}{n-1}}>\frac{1}{2} a_{1}^{\frac{1}{n(n-1)}}$. Since $\theta<\frac{1}{2 n^{2}}, \frac{1}{n(n-1)}-\theta>0$. Therefore, as $a_{1}$ sufficiently large, $\frac{x_{1}^{0}}{p_{1}}$ turns to infinity.

## 6. Proof of Main Theorem for $n=3$

By Proposition 5.1, to prove Main Theorem for $n=3$, we only need to prove for the case $\frac{a_{3}}{a_{2}}>a_{1}^{\theta}$. In the case, visually the height of $C_{3}^{\epsilon}$, which is $a_{3}$, grows much faster than $a_{2}$. Then we reduce the case to the 2 -dim case. Precisely, projecting $C_{3}^{\epsilon}$ onto the $x_{1} x_{2}$-plane. By induction, there exists at least one lattice point $(q, p)$ in the projection as $a_{1}$ is sufficiently large. Then show that the interval of $C_{3}^{\epsilon}$ and the height line $L^{\prime}: x_{1}=q, x_{2}=p$ is greater than 1 as $a_{1}$ is sufficiently large. Hence there is a lattice point inside the convex body $C_{3}^{\epsilon}$ as $a_{1}$ is sufficiently large.


Proof. Project $C_{3}^{\epsilon}$ onto the $x_{1} x_{2}$-plane. The convex set is as same as in 2 dimensional case. By Dirichlet approximation, let $M_{2}=\left\lfloor\sqrt{a_{1}}\right\rfloor$, then there exist integers $p$ and $q$ such that

$$
\left|\frac{a_{2}}{a_{1}}-\frac{p}{q}\right|<\frac{1}{q M_{2}},
$$

and $1 \leq q \leq M_{2}$. So $q M_{2}<a_{1}$.
For $\bar{a}_{1}$ sufficiently large, the lattice point $(q, p)$ is in the projection. Let the line $L^{\prime}: x_{1}=q, x_{2}=p$. Then $L^{\prime}$ intersects

$$
\Pi_{3}: \frac{a_{1}+a_{2}-1}{a_{3}} x_{3}=x_{1}+x_{2}-\epsilon
$$

and $L^{\prime}$ will intersect one of

$$
\Pi_{1}: \frac{a_{2}+a_{3}-1}{a_{1}} x_{1}=x_{2}+x_{3}-\epsilon
$$

or

$$
\Pi_{2}: \frac{a_{1}+a_{3}-1}{a_{2}} x_{2}=x_{1}+x_{3}-\epsilon
$$

The goal is to show the interval $\left|L_{23}^{\prime}\right|$ of $L^{\prime}$ between $\Pi_{2}$ and $\Pi_{3}$, or the interval $\left|L_{13}^{\prime}\right|$ of $L^{\prime}$ between $\Pi_{1}$ and $\Pi_{3}$ has length greater than 1 as $a_{1}$ is sufficiently large. Then there exists at least one lattice point inside $C_{3}^{\epsilon}$.

A direct computation shows that

$$
\left|L_{13}^{\prime}\right|=\frac{a_{2}+a_{3}-1}{a_{1}} q-p+\epsilon-\frac{p+q-\epsilon}{a_{1}+a_{2}-1} a_{3}=\left(\frac{a_{2}-1}{a_{1}} q-p+\epsilon\right)+\left(\frac{q}{a_{1}}-\frac{p+q-\epsilon}{a_{1}+a_{2}-1}\right) a_{3}
$$

Let $\lambda_{2}=-\frac{a_{2}}{a_{1}}+\frac{p}{q}$. Then $\left|\lambda_{2}\right|<\frac{1}{q M_{2}}$ and $q M_{2}<a_{1}$ by Dirichlet approximation. So

$$
\left|L_{13}^{\prime}\right|=-\frac{q}{a_{1}}-q \lambda_{2}+\epsilon+\left(\epsilon-\frac{q}{a_{1}}-\lambda_{2} q\right) \frac{a_{3}}{a_{1}+a_{2}-1} \geq-\frac{1}{M_{2}}-\frac{1}{M_{2}}+\epsilon+\left(\epsilon-\frac{1}{M_{2}}-\frac{1}{M_{2}}\right) \frac{a_{3}}{2 a_{2}}
$$

Since $\frac{a_{3}}{a_{2}} \geq a_{1}^{\theta}$ by assumption, we get

$$
\left|L_{13}^{\prime}\right| \geq\left(\epsilon-\frac{2}{M_{2}}\right)+\left(\epsilon-\frac{2}{M_{2}}\right) \frac{a_{1}^{\theta}}{2}
$$

As $a_{1}$ turns to infinity, $\left|L_{13}^{\prime}\right|$ will turn to infinity.
Similarly, a direct computation shows that
$\left|L_{23}^{\prime}\right|=\frac{a_{1}+a_{3}-1}{a_{2}} p-q+\epsilon-\frac{p+q-\epsilon}{a_{1}+a_{2}-1} a_{3}=\left(\frac{a_{1}-1}{a_{2}} p-q+\epsilon\right)+\left(\frac{p}{a_{2}}-\frac{p+q-\epsilon}{a_{1}+a_{2}-1}\right) a_{3}$

Let $\lambda_{2}=-\frac{a_{2}}{a_{1}}+\frac{p}{q}$. Then $\left|\lambda_{2}\right|<\frac{1}{q M_{2}}$ and $q M_{2}<a_{1}$ by Dirichlet approximation. So

$$
\left|L_{23}^{\prime}\right|=-\frac{q}{a_{1}}+\frac{a_{1}-1}{a_{2}} q \lambda_{2}+\epsilon+\left(\epsilon-\frac{p}{a_{2}}+\frac{a_{1}}{a_{2}} q \lambda_{2}\right) \frac{a_{3}}{a_{1}+a_{2}-1}
$$

Since $\lambda_{2}=\frac{p}{q}-\frac{a_{2}}{a_{1}} \leq \frac{1}{q M_{2}}$, we get $\frac{p}{a_{2}} \leq \frac{q}{a_{1}}+\frac{1}{a_{2} M_{2}}$.
Hence
$\left|L_{23}^{\prime}\right| \geq\left(-\frac{1}{M_{2}}-\frac{1}{M_{2}}+\epsilon\right)+\left(\epsilon-\frac{q}{a_{1}}-\frac{1}{a_{2} M_{2}}-\frac{1}{M_{2}}\right) \frac{a_{3}}{2 a_{2}} \geq\left(\epsilon-\frac{2}{M_{2}}\right)+\left(\epsilon-\frac{2}{M_{2}}-\frac{1}{a_{2} M_{2}}\right) \frac{a_{1}^{\theta}}{2}$
As $a_{1}$ turns to infinity, $\left|L_{23}^{\prime}\right|$ turns to infinity.
