# Classification of conformal minimal immersions from $S^{2}$ to $G(2, N ; \mathbb{C})$ with parallel second fundamental form

#### Abstract

In this paper, we determine all conformal minimal immersions of 2-spheres in complex Grassmann manifold $G(2, N ; \mathbb{C})$ with parallel second fundamental form. Keywords and Phrases. ## 1. Introduction

The geometry of an $m$-dimensional smooth submanifold in an $n$-dimensional Riemann space is determined by two symmetric fundamental tensor fields (equivalently, quadratic differential forms): the first fundamental form, that is, the metric tensor, and the second fundamental form, the latter with values in normal vector bundle of the submanifold. It is well known that the first one is parallel by definition, but the second one does not need to be parallel. Therefore an interesting class of submanifolds with parallel second fundamental tensor field can be singed out, and its classification is an enduring and important topic.

It is a long history of studying minimal submanifolds with parallel second fundamental form in various Riemannian spaces. The first result on parallel submanifolds was given by V.F. Kagan [18] in 1948 who showed that the class of parallel surfaces in 3-dimensional Euclidean space consists of open parts of planes, round spheres and circular cylinders $S^{1} \times \mathbb{R}^{1}$. Since then, there have emerged many works on parallel submanifolds in not only Euclidean space, but also various Riemannian spaces (see [10, 11, 19, 22] and the references therein). In an elegant paper [20], H. Nakagawa and R. Takagi studied some properties about Kähler imbeddings of compact Hermitian symmetric spaces in complex projective space $\mathbb{C} P^{n}$ and gave a classification of Kähler submanifolds in $\mathbb{C} P^{n}$ with parallel second fundamental form. In 1984 A. Ros [21] decided all compact Einstein Kähler submanifolds in $\mathbb{C} P^{n}$ with parallel second fundamental form. Generally, studying classifications of conformal minimal two-spheres immersed in various Riemannian symmetric spaces with parallel second fundamental form is very difficult. Recently, we discussed the geometry of conformal minimal immersions from $S^{2}$ to the hyperquadric $Q_{n}$ and gave a complete classification theorem of them under the assumption that they have parallel second fundamental form (cf. [16]). L. He and the first author also classified all conformal minimal two-spheres immersed in the quaternionic projective space $H P^{n}$ with parallel second fundamental form (cf. [13]).

[^0]Let $G(2, N ; \mathbb{C})$ be the complex Grassmann manifold consisting of all complex 2-dimensional subspaces in the complex vector space $\mathbb{C}^{N}$. Regarding $\mathbb{C} P^{N-2}, Q_{N-2}$ and $H P^{n}(N=$ $2 n+2$ ) are maximal totally geodesic submanifolds in $G(2, N ; \mathbb{C})$, it was natural to try to extend these results described above to study the rigidity of harmonic maps from $S^{2}$ to $G(2, N ; \mathbb{C})$. Let $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ be a linearly full conformal minimal immersion with Gauss curvature $K$ and second fundamental form $B$. Suppose $B$ is parallel, in this paper, we firstly investigate geometry of $\phi$ by the theory of harmonic maps and generalize our characterization of the harmonic sequence generated by $\phi$. Then we mainly study the rigidity of $\phi$ and give its classification according to the following four cases:
(I) $\phi$ is a holomorphic curve in $G(2, N ; \mathbb{C})$;
(II) rank $\partial^{\prime} \phi=\operatorname{rank} \partial^{\prime \prime} \underline{\phi}=1$;
(III) rank $\partial^{\prime \prime} \phi=2$ and rank $\partial^{\prime} \phi=1$;
(IV) rank $\partial^{\prime} \underline{\phi}=\operatorname{rank} \partial^{\prime \prime} \underline{\phi}=2$.

Our classification theorems of $\phi$ for cases (I)-(IV) are as follows respectively:
Theorem 1.1. Let $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ be a linearly full holomorphic curve, and let $K$ and $B$ be its Gauss curvature and second fundamental form respectively. If $B$ is parallel, then $\phi$ belongs to one of the following minimal immersions.
(1) up to $U(3)$ equivalence, $\phi$ is $\underline{V}_{0}^{(2)} \oplus \underline{V}_{1}^{(2)}: S^{2} \rightarrow G(2,3 ; \mathbb{C})$ with $K=2$ and $\|B\|^{2}=4$;
(2) up to $U(3)$ equivalence, $\phi$ is $\underline{V}_{0}^{(1)} \oplus \underline{c}_{0}: S^{2} \rightarrow G(2,3 ; \mathbb{C})$ with $K=4$ and $\|B\|^{2}=0$, where $c_{0}=(0,0,1)^{T}$;
(3) up to $U(4)$ equivalence, $\phi$ is $\underline{V}_{0}^{(2)} \oplus \underline{c}_{0}: S^{2} \rightarrow G(2,4 ; \mathbb{C})$ with $K=2$ and $\|B\|^{2}=4$, where $c_{0}=(0,0,0,1)^{T}$;
(4) up to $U(4)$ equivalence, $\phi$ is $\widehat{\widehat{V}}_{0}^{(1)} \oplus \underline{V}_{0}^{(1)}: S^{2} \rightarrow G(2,4 ; \mathbb{C})$ with $K=2$ and $\|B\|^{2}=0$;
(5) up to $U(6)$ equivalence, $\phi$ is $\widehat{\widehat{V}}_{0}^{(2)} \oplus \underline{V}_{0}^{(2)}: S^{2} \rightarrow G(2,6 ; \mathbb{C})$ with $K=1$ and $\|B\|^{2}=2$.

Theorem 1.2. Let $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ be a linearly full conformal minimal immersion with rank $\partial^{\prime} \phi=$ rank $\partial^{\prime \prime} \phi=1$, and let $K$ and $B$ be its Gauss curvature and second fundamental form respectively. If $B$ is parallel, then $\phi$ belongs to one of the following minimal immersions.
(1) up to $U(4)$ equivalence, $\phi$ is $\underline{V}_{1}^{(3)} \oplus \underline{V}_{2}^{(3)}: S^{2} \rightarrow G(2,4 ; \mathbb{C})$ with $K=\frac{2}{3}$ and $\|B\|^{2}=\frac{8}{3}$;
(2) up to $U(3)$ equivalence, $\phi$ is $\underline{V}_{0}^{(2)} \oplus \underline{V}_{2}^{(2)}: S^{2} \rightarrow G(2,3 ; \mathbb{C})$ with $K=1$ and $\|B\|^{2}=0$;
(3) up to $U(4)$ equivalence, $\phi$ is $\widehat{\widehat{V}}_{0}^{(1)} \oplus \underline{V}_{1}^{(1)}: S^{2} \rightarrow G(2,4 ; \mathbb{C})$ with $K=2$ and $\|B\|^{2}=0$;
(4) up to $U(4)$ equivalence, $\phi$ is $\underline{V}_{0}^{(3)} \oplus \underline{V}_{3}^{(3)}: S^{2} \rightarrow G(2,4 ; \mathbb{C})$ with $K=\frac{2}{3}$ and $\|B\|^{2}=\frac{8}{3}$;
(5) up to $U(6)$ equivalence, $\phi$ is $\widehat{\widehat{V}}_{0}^{(2)} \oplus \underline{V}_{2}^{(2)}: S^{2} \rightarrow G(2,6 ; \mathbb{C})$ with $K=1$ and $\|B\|^{2}=2$;
(6) up to $U(4)$ equivalence, $\phi$ is $\underline{V}_{1}^{(2)} \oplus \underline{c}_{0}: S^{2} \rightarrow G(2,4 ; \mathbb{C})$ with $K=1$ and $\|B\|^{2}=0$, where $c_{0}=(0,0,0,1)^{T}$;
(7) up to $U(6)$ equivalence, $\phi$ is $\underline{V}_{2}^{(4)} \oplus \underline{c}_{0}: S^{2} \rightarrow G(2,6 ; \mathbb{C})$ with $K=\frac{1}{3}$ and $\|B\|^{2}=\frac{4}{3}$, where $c_{0}=(0,0,0,0,0,1)^{T}$.

Theorem 1.3. Let $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ be a linearly full conformal minimal immersion with rank $\partial^{\prime} \underline{\phi}=1$ and rank $\partial^{\prime \prime} \underline{\phi}=2$, let $K$ and $B$ be its Gauss curvature and second fundamental form respectively. If $B$ is parallel, then $\phi$ belongs to one of the following minimal immersions.
(1) up to $U(4)$ equivalence, $\phi$ is $\underline{V}_{1}^{(3)} \oplus \underline{V}_{3}^{(3)}: S^{2} \rightarrow G(2,4 ; \mathbb{C})$ with $K=\frac{2}{5}$ and $\|B\|^{2}=0$;
(2) up to $U(5)$ equivalence, $\phi$ is $\widehat{V}_{1}^{(1)} \oplus \underline{V}_{1}^{(2)}: S^{2} \rightarrow G(2,5 ; \mathbb{C})$ with $K=\frac{4}{5}$ and $\|B\|^{2}=0$;
(3) up to $U(6)$ equivalence, $\phi$ is $\underline{V}_{3}^{(4)} \oplus \underline{\alpha}: S^{2} \rightarrow G(2,6 ; \mathbb{C})$ with $K=\frac{2}{5},\|B\|^{2}=\frac{4}{5}$, where $\alpha=\left(V_{2}^{(4)^{T}}, \sqrt{48} e^{\sqrt{-1} \theta}\right)^{T}$ for some constant $\theta$.
Theorem 1.4. Let $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ be a $\partial^{\prime}$-irreducible and $\partial^{\prime \prime}$-irreducible linearly full conformal minimal immersion, and let $K$ and $B$ be its Gauss curvature and second fundamental form respectively. If $B$ is parallel, then $\phi$ belongs to one of the following minimal immersions.
(1) up to $U(5)$ equivalence, $\phi$ is $\underline{V}_{1}^{(4)} \oplus \underline{V}_{3}^{(4)}: S^{2} \rightarrow G(2,5 ; \mathbb{C})$ with $K=\frac{1}{5}$ and $\|B\|^{2}=0$;
(2) up to $U(6)$ equivalence, $\phi$ is $\widehat{\widehat{V}}_{1}^{(2)} \oplus \underline{V}_{1}^{(2)}: S^{2} \rightarrow G(2,6 ; \mathbb{C})$ with $K=\frac{1}{2}$ and $\|B\|^{2}=0$;
(3) up to $U(10)$ equivalence, $\phi$ is $\widehat{\widehat{V}}_{2}^{(4)} \oplus \underline{V}_{2}^{(4)}: S^{2} \rightarrow G(2,10 ; \mathbb{C})$ with $K=\frac{1}{6}$ and $\|B\|^{2}=\frac{2}{3}$.

In these four theorems, $\underline{V}_{i}^{(n)}$ denotes the linearly full Veronese surface in $\mathbb{C} P^{n}$, its standard expression is given in Section 2 below. If $n \leq N-2$, for one thing, we add zeros to the end of $V_{i}^{(n)}$ such that it belongs to $\mathbb{C}^{N}$, in the absence of confusion, we also denote it by $V_{i}^{(n)}$; for another, we denote it as $\widehat{V}_{i}^{(n)}$ by adding zeros to the front of $V_{i}^{(n)}$ such that it belongs to $\mathbb{C}^{N}$ also.

Theorems 1.1-1.4 give the classification of all linearly full conformal minimal immersions from $S^{2}$ to $G(2, N ; \mathbb{C})$ with parallel second fundamental form, no two of the above eighteen cases are congruent, i.e. there is no isometry of $G(2, N ; \mathbb{C})$ such that it transforms one case into another. Furthermore, the Gauss curvatures that occur in Theorems 1.1-1.4 obey Delisle, Hussin and Zakrzewski's conjecture [6, 7].

## 2. Preliminaries

Let $M, d s_{M}^{2}$ be a simply connected domain in the unit sphere $S^{2}$ with conformal metric $d s_{M}^{2}=d z d \bar{z}$, and $(z, \bar{z})$ be a complex coordinate on $M$. Denote

A_{z}=\frac{1}{2} s^{-1} \partial s, \quad A_{\bar{z}}=\frac{1}{2} s^{-1} \bar{\partial} s
$$

where $s$ is a smooth map from $M$ to the unitary group $U(N), \partial=\frac{\partial}{\partial z}, \bar{\partial}=\frac{\partial}{\partial \bar{z}}$. Then $s$ is a harmonic map if and only if it satisfies the following equation (cf. [23]):

Suppose that $s: S^{2} \rightarrow U(N)$ is an isometric immersion, then $s$ is conformal and minimal if it is harmonic. Let $\omega$ be the Maurer-Cartan form on $U(N)$, and let $d s_{U(N)}^{2}=\frac{1}{8} \operatorname{tr} \omega \omega^{*}$ be the metric on $U(N)$. Then the metric induced by $s$ on $S^{2}$ is locally given by

d s^{2}=-\operatorname{tr} A_{z} A_{\bar{z}} d z d \bar{z}
$$

We consider the complex Grassmann manifold $G(2, N ; \mathbb{C})$ as the set of Hermitian orthogonal projections from $\mathbb{C}^{N}$ onto a 2-dimensional subspace in $\mathbb{C}^{N}$. Then map $\phi: M \rightarrow$ $G(2, N ; \mathbb{C})$ is a Hermitian orthogonal projection onto a 2-dimensional subbundle $\phi$ of the trivial bundle $\underline{\mathbb{C}}^{N}=M \times \mathbb{C}^{N}$ given by setting the fibre $\underline{\phi}_{x}=\phi(x)$ for all $x \in \bar{M} . \underline{\phi}$ is called (a) harmonic ((sub-) bundle) whenever $\phi$ is a harmonic map. Here $s=\phi-\phi^{\perp}$ is a map from $S^{2}$ into $U(N)$. It is well known that $\phi$ is harmonic if and only if $s$ is harmonic. $\phi$ is a holomorphic (resp. anti-holomorphic) curve in $G(2, N ; \mathbb{C})$ if and only if $\phi^{\perp} \bar{\partial} \phi=0$ (resp. $\phi^{\perp} \partial \phi=0$ ).

For a conformal minimal immersion $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$, two harmonic sequences are derived as follows (cf. [24]):

& \underline{\phi}=\underline{\phi}_{0} \xrightarrow{\partial^{\prime}} \underline{\phi}_{1} \xrightarrow{\partial^{\prime}} \cdots \xrightarrow{\partial^{\prime}} \underline{\phi}_{i} \xrightarrow{\partial^{\prime}} \cdots \xrightarrow{\partial^{\prime}} 0,  \tag{2.2}\\
& \underline{\phi}=\underline{\phi}_{0} \xrightarrow{\partial^{\prime \prime}} \underline{\phi}_{-1} \xrightarrow{\partial^{\prime \prime}} \cdots \xrightarrow{\partial^{\prime \prime}} \underline{\phi}_{-i} \xrightarrow{\partial^{\prime \prime}} \cdots \xrightarrow{\partial^{\prime \prime}} 0, \tag{2.3}
\end{align*}
$$

where $\underline{\phi}_{i}=\partial^{\prime} \underline{\phi}_{i-1}$ and $\underline{\phi}_{-i}=\partial^{\prime \prime} \underline{\phi}_{-i+1}$ are Hermitian orthogonal projections from $S^{2} \times \mathbb{C}^{N}$ onto $\underline{I m}\left(\phi_{i-1}^{\perp} \partial \phi_{i-1}\right)$ and $\underline{\operatorname{Im}}\left(\phi_{-i+1}^{\perp} \bar{\partial} \phi_{-i+1}\right)$ respectively, $i=1,2, \ldots$.

Now recall $([3], \S 3 \mathrm{~A})$ that a harmonic map $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ in (2.2)(resp. (2.3)) is said to be $\partial^{\prime}$-irreducible (resp. $\partial^{\prime \prime}$-irreducible) if rank $\underline{\phi}_{1}=\operatorname{rank} \underline{\phi}$ (resp. rank $\underline{\phi}_{-1}=\operatorname{rank}$ $\phi)$ and $\partial^{\prime}$-reducible (resp. $\partial^{\prime \prime}$-reducible) otherwise.

For an arbitrary harmonic map $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$, we know that several consecutive harmonic maps in (2.2) are not mutually orthogonal generally. So it is meaningful to define the isotropy order (cf. [3]) of $\phi$ to be the greatest integer $r$ such that $\phi \perp \phi_{i}$ for $1 \leq i \leq r$.

As in [8] call a harmonic map $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ (strongly) isotropic if $\phi$ has isotropy order $\geq r$ for all $r$. In this case we just set $r=\infty$.

Definition 2.1. Let $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ be a map. $\phi$ is linearly full if $\phi$ can not be contained in any proper trivial subbundle $S^{2} \times \mathbb{C}^{n}$ of $S^{2} \times \mathbb{C}^{N}(n<N)$.

In this paper, we always assume that $\phi$ is linearly full.
Suppose that $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ is a linearly full harmonic map and it belongs to the following harmonic sequence:

\underline{\phi}_{0} \xrightarrow{\partial^{\prime}} \cdots \xrightarrow{\partial^{\prime}} \underline{\phi}=\underline{\phi}_{i} \xrightarrow{\partial^{\prime}} \underline{\phi}_{i+1} \xrightarrow{\partial^{\prime}} \cdots \xrightarrow{\partial^{\prime}} \underline{\phi}_{i_{0}} \xrightarrow{\partial^{\prime}} 0 \tag{2.4}
\end{equation*}

for some $i=0, \ldots, i_{0}$. We choose local orthonormal frames $e_{1}^{(i)}, e_{2}^{(i)}, \ldots, e_{k_{i}}^{(i)}$ such that they locally span subbundle $\underline{\phi}_{i}$ of $S^{2} \times \mathbb{C}^{N}$, where $k_{i}=\operatorname{rank} \underline{\phi}_{i}$.

Let $W_{i}=\left(e_{1}^{(i)}, e_{2}^{(i)}, \ldots, e_{k_{i}}^{(i)}\right)$ be an $\left(N \times k_{i}\right)$-matrix. Then we have

\phi_{i}=W_{i} W_{i}^{*}, \quad W_{i}^{*} W_{i}=I_{k_{i} \times k_{i}}, \quad W_{i-1}^{*} W_{i}=0, \quad W_{i+1}^{*} W_{i}=0
$$

By these equations, a straightforward computation shows that

where $\Omega_{i}$ is a $\left(k_{i+1} \times k_{i}\right)$-matrix, $\Psi_{i}$ is a $\left(k_{i} \times k_{i}\right)$-matrix for $i=0,1,2, \ldots, i_{0}$, and $\Omega_{i_{0}}=0$. It is very evident that integrability conditions for (2.5) are

For a conformal immersion $\phi: M \rightarrow G(2, N ; \mathbb{C})$, we define its Kähler angle to be the function $\theta: M \rightarrow[0, \pi]$ given in terms of a complex coordinate $z$ on $M$ by (cf. [2, 4])

\tan \frac{\theta(p)}{2}=\frac{|d \phi(\partial / \partial \bar{z})|}{|d \phi(\partial / \partial z)|}, \quad p \in M
$$

It is clear that $\theta$ is globally defined and is smooth at $p$ unless $\theta(p)=0$ or $\pi$. $\phi$ is holomorphic (resp. anti-holomorphic) if and only if $\theta(p)=0$ (resp. $\theta(p)=\pi$ ) for all $p \in M$, while $\phi$ is totally real if and only if $\theta(p)=\frac{\pi}{2}$ for all $p \in M$.

Let $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ be a conformal minimal immersion with the harmonic sequence (2.4), put $L_{i}=\operatorname{tr}\left(\Omega_{i} \Omega_{i}^{*}\right)$, then, in terms of a local complex coordinate $z$, its Kähler angle $\theta_{i}$ satisfies

The metric induced by $\phi$ is given in the form

d s_{i}^{2}=\left(L_{i-1}+L_{i}\right) d z d \bar{z} \triangleq \lambda^{2} d z d \bar{z} \tag{2.6}
\end{equation*}

Let $K$ and $B$ be the Gauss curvature and second fundamental form of $\phi$ respectively, then we have

K=-\frac{2}{L_{i-1}+L_{i}} \partial \bar{\partial} \log \left(L_{i-1}+L_{i}\right)  \tag{2.7}\\
\|B\|^{2}=4 \operatorname{tr} P P^{*}
\end{array}\right.

where $P=\partial\left(\frac{A_{z}}{\lambda^{2}}\right)$ with $A_{z}=(2 \phi-I) \partial \phi, I$ is the identity matrix (cf. [14, 15]).
In the following, we review the rigidity theorem of conformal minimal immersions with constant curvature from $S^{2}$ to $\mathbb{C} P^{N}$.

Let $\psi: S^{2} \rightarrow \mathbb{C} P^{N}$ be a linearly full conformal minimal immersion, a harmonic sequence is derived as follows

0 \xrightarrow{\partial^{\prime}} \underline{\psi}_{0} \xrightarrow{\partial^{\prime}} \cdots \xrightarrow{\partial^{\prime}} \underline{\psi}=\underline{\psi}_{i} \xrightarrow{\partial^{\prime}} \cdots \xrightarrow{\partial^{\prime}} \underline{\psi}_{N} \xrightarrow{\partial^{\prime}} 0 \tag{2.8}
\end{equation*}

for some $i=0,1, \ldots, N$.
We define a sequence $f_{0}, \ldots, f_{N}$ be local sections of $\underline{\psi}_{0}, \ldots, \underline{\psi}_{N}$ inductively such that $f_{0}$ is a nowhere zero local section of $\underline{\psi}_{0}$ (without loss of generality, assume that $\bar{\partial} f_{0} \equiv 0$ ) and $f_{i+1}=\psi_{i}^{\perp}\left(\partial f_{i}\right)$ for $i=0, \ldots, N-1$. Then we have some formulae as follows (cf. [2]):

& \partial \bar{\partial} \log \left|f_{i}\right|^{2}=l_{i}-l_{i-1}, i=0, \ldots, N  \tag{2.11}\\
& \partial \bar{\partial} \log l_{i}=l_{i+1}-2 l_{i}+l_{i-1}, i=0, \ldots, N-1 \tag{2.12}
\end{align*}
$$

where $l_{i}=\frac{\left|f_{i+1}\right|^{2}}{\left|f_{i}\right|^{2}}$ for $i=0, \ldots, N-1$, and $l_{-1}=l_{N}=0$.
Next, we state the definition of degree of a smooth map $\psi$ from a compact Riemann surface $M$ into $G(k, N ; \mathbb{C})$ as follows.

Definition 2.2 ([3]). The degree of $\psi$, denoted by $\operatorname{deg} \psi$ is the degree of the induced map $\psi^{*}: H^{2}(G(k, N ; \mathbb{C}), Z) \cong Z \rightarrow H^{2}(M, Z) \cong Z$ on second cohomology.

In (2.8), let $F_{i}=f_{0} \wedge f_{1} \wedge \cdots \wedge f_{i}$ be a local lift of the $i$-th osculating curve, where $i=0, \cdots, N$. We write $F_{i}=f(\underset{\tilde{F}}{z}) \tilde{F}_{i}$, where $f(z)$ is the greatest common divisor of the $\binom{N+1}{i+1}$ components of $F_{i}$. Then $\tilde{F}_{i}$ is a nowhere zero holomorphic curve, and the degree
$\delta_{i}^{(N)}$ of $F_{i}$ is given by $\delta_{i}^{(N)}=1 /(2 \pi \sqrt{-1}) \int_{S^{2}} \partial \bar{\partial} \log \left|F_{i}\right|^{2} d \bar{z} \wedge d z$, which is equal to the degree of the polynomial function $\tilde{F}_{i}$. Then we have

Especially, for harmonic sequence (2.8). Let $r\left(\partial^{\prime}\right)=$ sum of the indices of the singularities of $\partial^{\prime}$, which is called the ramification index of $\partial^{\prime}$ by Bolton et al (cf. [2]). Note that if $r\left(\partial^{\prime}\right)=0$ in (2.8) for all $\partial^{\prime}$, the harmonic sequence is defined totally unramified in [2]. If (2.8) is a totally unramified harmonic sequence, then (see [2])

Consider the Veronese sequence

For each $i=0, \ldots, N, \underline{V}_{i}^{(N)}: S^{2} \rightarrow \mathbb{C} P^{N}$ is given by $V_{i}^{(N)}=\left(v_{i, 0}, \ldots, v_{i, N}\right)^{T}$, where, for $z \in S^{2}$ and $j=0, \ldots, N$,

v_{i, j}(z)=\frac{i!}{(1+z \bar{z})^{i}} \sqrt{\binom{N}{j}} z^{j-i} \sum_{k}(-1)^{k}\binom{j}{i-k}\binom{N-j}{k}(z \bar{z})^{k} .
$$

Each map $\underline{V}_{i}^{(N)}$ satisfies

\left|V_{i}^{(N)}\right|^{2}=\frac{N!i!}{(N-i)!}(1+z \bar{z})^{N-2 i}, \tag{2.14}
\end{equation*}
$$

it has induced metric $d s_{i}^{2}=\frac{N+2 i(N-i)}{(1+z \bar{z})^{2}} d z d \bar{z}$, and the corresponding constant curvature $K_{i}$ is given by $K_{i}=\frac{4}{N+2 i(N-i)}$.

By Calabi's rigidity theorem, Bolton et al proved the following rigidity result (cf. [2]).
Lemma 2.3 ([2]). Let $\psi: S^{2} \rightarrow \mathbb{C} P^{N}$ be a linearly full conformal minimal immersion of constant curvature. Then, up to a holomorphic isometry of $\mathbb{C} P^{N}$, the harmonic sequence determined by $\psi$ is the Veronese sequence.

## 3. Holomorphic curves with parallel second fundamental form

We recall that an immersion of $S^{2}$ in $G(2, N ; \mathbb{C})$ is conformal and minimal if and only if it is harmonic. Thus, we shall consider harmonic maps from $S^{2}$ to $G(2, N ; \mathbb{C})$ with parallel second fundamental form to give the proof of Theorems 1.1-1.4 in Section 1.

Let $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ be a harmonic map with Gauss curvature $K$ and second fundamental form $B$. Suppose that $B$ is parallel, it is known that such 2 -spheres in $G(2, N ; \mathbb{C})$ have constant curvature (cf. [15], Theorem 4.5). To give a complete classification, in this paper we analyze $\phi$ by the following six cases:
(I) $\phi$ is a holomorphic curve in $G(2, N ; \mathbb{C})$;
(II) rank $\partial^{\prime} \phi=\operatorname{rank} \partial^{\prime \prime} \phi=1$;
(III) rank $\partial^{\top} \phi=1$ and rank $\partial^{\prime \prime} \phi=2$;
(IV) rank $\partial^{\prime} \underline{\phi}=\operatorname{rank} \partial^{\prime \prime} \underline{\phi}=2$;
(V) $\phi$ is an anti-holomorphic curve in $G(2, N ; \mathbb{C})$;
(VI) rank $\partial^{\prime} \underline{\phi}=2$ and rank $\partial^{\prime \prime} \underline{\phi}=1$.

For cases (V) and (VI), since the conjugations of corresponding $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ belong to cases (I) and (III) respectively, we only consider the classification of $\phi$ in cases (I)-(IV) here.

In this section we first discuss the case that $\phi$ is holomorphic, then a harmonic sequence is derived by $\phi$ via the $\partial^{\prime}$-transform

To characterize $\phi$, we need the following two Lemmas about parallel minimal immersions of 2 -spheres in $G(k, N ; \mathbb{C})$ as follows:

Lemma 3.1. ([15]) Let $\phi: S^{2} \rightarrow G(k, N ; \mathbb{C})$ be a conformal minimal immersion with Gauss curvature $K$ and second fundamental form $B$. Suppose that $B$ is parallel, then the following equations

\lambda^{2}\left(2 K+\|B\|^{2}\right) A_{\bar{z}}+4\left[A_{\bar{z}},\left[A_{z}, A_{\bar{z}}\right]\right]=0  \tag{3.1}\\
\lambda^{2}\left(\frac{\|B\|^{2}}{4}-K\right) P+\left[\left[A_{\bar{z}}, A_{z}\right], P\right]=0
\end{array}\right.
$$

hold.
Lemma 3.2. ([15]) Let $\phi: S^{2} \rightarrow G(k, N ; \mathbb{C})$ be a conformal minimal immersion with Gauss curvature $K$ and second fundamental form $B$. Then $B$ is parallel if and only if the equation

\frac{\lambda^{2}}{16}\|B\|^{2}\left(8 K+\|B\|^{2}\right)-2 \operatorname{tr}\left[A_{z}, P\right]\left[A_{\bar{z}}, P^{*}\right]+5 \operatorname{tr}\left[A_{z}, A_{\bar{z}}\right]\left[P, P^{*}\right]=0 \tag{3.2}
\end{equation*}
$$

holds.
In the following we shall analyze $\phi$ by $\operatorname{rank} \underline{\phi}_{1}=1$ and $\operatorname{rank} \underline{\phi}_{1}=2$ respectively.
3.1. $\partial^{\prime}$-reducible holomorphic curves with parallel second fundamental form. Here we suppose that $\phi$ is a holomorphic curve from $S^{2}$ to $G(2, N ; \mathbb{C})$ with parallel second fundamental form and rank $\partial^{\prime} \phi=1$. To characterize these holomorphic curves, firstly by denoting $\partial^{(-1)} g=\partial^{\prime \prime} g, \partial^{(-i-1)} g=\partial^{\prime \prime}\left(\partial^{(-i)} g\right)$, we state one of Burstall and Wood' results as follows:

Lemma 3.3 ([3]). Let $\underline{\phi}: S^{2} \rightarrow G(2, N ; \mathbb{C})$ be harmonic with $\partial^{\prime} \underline{\phi}$ of rank one and $A_{\phi}^{\prime \prime}\left(\underline{\operatorname{ker}} A_{\phi}^{\prime} \perp\right)=0$. Then either (i) there is an anti-holomorphic map $g: S^{2} \rightarrow \mathbb{C} P^{N-1}$ and $\underline{\phi}=\partial^{(-i)} \underline{g} \oplus \partial^{(-i-1)} \underline{g}$ for some integer $i \geq 0$, (it can be shown that $\phi$ is a Frenet pair); or (ii) there are maps $g, h: S^{2} \rightarrow \mathbb{C} P^{N-1}$ anti-holomorphic and holomorphic respectively such that $\partial^{\prime} \underline{h} \perp \underline{g}$ and $\underline{\phi}=\underline{g} \oplus \underline{h}$, i.e. $\underline{\phi}$ is a mixed pair.
$A_{\phi}^{\prime}$ and $A_{\phi}^{\prime \prime}$ shown in Lemma 3.3 are vector bundle morphisms from $\underline{\phi}$ to $\underline{\phi}^{\perp}$, they are defined by $A_{\phi}^{\prime}(v)=\pi_{\phi^{\perp}}(\partial v)$ and $A_{\phi}^{\prime \prime}(v)=\pi_{\phi^{\perp}}(\bar{\partial} v)$ respectively for some $v \in \mathbb{C}^{\infty}(\underline{\phi})$ (cf. [3]). Here clearly we have $A_{\phi}^{\prime \prime}\left(\underline{\operatorname{ker}} A_{\phi}^{\prime} \perp\right)=0$ from the assumption that $\phi$ is holomorphic. With the help of Lemma 3.3, we now consider two cases: (1) $\phi$ is a Frenet pair, and (2) $\phi$ is a mixed pair.

Firstly we consider the case that $\phi$ is a Frenet pair. In this case

it belongs to the harmonic sequence as follows

\end{equation*}

where

0 \xrightarrow{\partial^{\prime}} \underline{f}_{0} \xrightarrow{\partial^{\prime}} \underline{f}_{1} \xrightarrow{\partial^{\prime}} \cdots \xrightarrow{\partial^{\prime}} \underline{f}_{n} \xrightarrow{\partial^{\prime}} 0 \tag{3.4}
\end{equation*}
$$

is a linearly full harmonic sequence in $\mathbb{C} P^{n}$ with $N=n+1$. By making use of $\phi=$ $\frac{f_{0} f_{0}^{*}}{\left|f_{0}\right|^{2}}+\frac{f_{1} f_{1}^{*}}{\left|f_{1}\right|^{2}}$, we get

\partial \phi=\frac{f_{2} f_{1}^{*}}{\left|f_{1}\right|^{2}}, \quad \bar{\partial} \phi=\frac{f_{1} f_{2}^{*}}{\left|f_{1}\right|^{2}}, \quad \lambda^{2}=\frac{\left|f_{2}\right|^{2}}{\left|f_{1}\right|^{2}}, \quad A_{z}=-\frac{f_{2} f_{1}^{*}}{\left|f_{1}\right|^{2}}, \quad A_{\bar{z}}=\frac{f_{1} f_{2}^{*}}{\left|f_{1}\right|^{2}}  \tag{3.5}\\
{\left[A_{z}, A_{\bar{z}}\right]=\frac{\left|f_{2}\right|^{2}}{\left|f_{1}\right|^{4}} f_{1} f_{1}^{*}-\frac{1}{\left|f_{1}\right|^{2}} f_{2} f_{2}^{*}, \quad\left[A_{\bar{z}},\left[A_{z}, A_{\bar{z}}\right]\right]=-\frac{2\left|f_{2}\right|^{2}}{\left|f_{1}\right|^{4}} f_{1} f_{2}^{*} .}
\end{gather*}
$$

Then it follows from $P=\partial\left(\frac{A_{z}}{\lambda^{2}}\right)$ that

\left[\left[A_{\bar{z}}, A_{z}\right], P\right]=\frac{1}{\left|f_{0}\right|^{2}} f_{2} f_{0}^{*}-\frac{1}{\left|f_{1}\right|^{2}} f_{3} f_{1}^{*} . \tag{3.7}
\end{equation*}

For convenience, we denote

M_{1}=-\frac{\lambda^{2}\left(2 K+\|B\|^{2}\right)}{4}, \quad M_{2}=\lambda^{2}\left(K-\frac{\|B\|^{2}}{4}\right) . \tag{3.8}
\end{equation*}

From the two equations of (3.1) we get

which verifies that

Since the second fundamental form of the map $\phi$ is paralle, its Gauss curvature is a constant (cf. [15], Theorem 4.5). Hence by ([12], Lemma 4.1) we know that $\underline{f}_{0}: S^{2} \rightarrow$ $\mathbb{C} P^{2}$ is of constant curvature, then harmonic sequences (3.3) and (3.4) are both totally unramified. From (2.13) we get

\delta_{0}^{(n)}=n, \delta_{1}^{(n)}=2(n-1), \delta_{2}^{(n)}=3(n-2) .
$$

By substituting the metric of $\phi$ shown in (3.5) into (2.7), we have

2=K=-\frac{2}{\lambda^{2}} \partial \bar{\partial} \log \lambda^{2}=-\frac{2}{l_{1}} \partial \bar{\partial} \log l_{1}=4-2 \frac{l_{0}+l_{2}}{l_{1}}=4-2 \frac{\delta_{0}^{(n)}+\delta_{2}^{(n)}}{\delta_{1}^{(n)}},
$$

then

n=2 .
$$

Using the rigidity theorem of Bolton et al ([2]), up to a holomorphic isometry of $\mathbb{C} P^{2}$, $\underline{f}_{0}$ is a Veronese surface. We can choose a complex coordinate $z$ on $\mathbb{C}=S^{2} \backslash\{p t\}$ so that $f_{0}=U V_{0}^{(2)}$, where $U \in U(3)$ and $V_{0}^{(2)}$ has the standard expression given in Section 2. By Lemma 3.2 , it can easily be checked that, for any $U \in U(3)$,

\underline{\phi}=\underline{U V_{0}^{(2)}} \oplus \underline{U V_{1}^{(2)}}: S^{2} \rightarrow G(2,3 ; \mathbb{C}) \tag{3.9}
\end{equation*}

is of parallel second fundamental form because it satisfies (3.2).
Next, we consider the case that $\phi$ is a mixed pair. In this case

\underline{\phi}=\underline{f}_{0} \oplus \underline{c}_{0}: S^{2} \rightarrow G(2, N ; \mathbb{C})
$$

where $\underline{c}_{0}$ is the line bundle spanned by constant vector $(0,0, \ldots, 0,1)^{T}$ in $\mathbb{C}^{N}, \phi$ belongs to the harmonic sequence as follows

0 \xrightarrow{\partial^{\prime}} \underline{\phi}=\underline{f}_{0} \oplus \underline{c}_{0} \xrightarrow{\partial^{\prime}} \underline{f}_{1} \xrightarrow{\partial^{\prime}} \cdots \xrightarrow{\partial^{\prime}} \underline{f}_{n} \xrightarrow{\partial^{\prime}} 0, N=n+2 .
$$

By making use of $\phi=\frac{f_{0} f_{0}^{*}}{\left|f_{0}\right|^{2}}+\frac{c_{0} c_{0}^{*}}{\left|c_{0}\right|^{2}}$ and a similar calculation as the first case above, it is very evident that

Thus $\underline{f}_{0}: S^{2} \rightarrow \mathbb{C} P^{n}, n=N-2$ is also of constant curvature, and there exists some $U \in U(n+1)$ s.t. $f_{0}=U V_{0}^{(n)}$. To determine $\phi$, we shall divide our discussion into two cases, according as $n=1$, or $n \geq 2$.

If $n=1$. Under this supposition, it can be checked that for any $U \in U(3)$,

is a totally geodesic map from $S^{2}$ to $G(2,3 ; \mathbb{C})$ with constant curvature $K=4$ by direct computation (adding zero to the end of $V_{0}^{(1)}$ such that it belongs to $\mathbb{C}^{3}$, in the absence of confusion, we also denote it by $\left.V_{0}^{(1)}\right)$.

If $n \geq 2$. Direct computations show that

A_{\bar{z}}=\frac{f_{0} f_{1}^{*}}{\left|f_{0}\right|^{2}},\left[A_{\bar{z}},\left[A_{z}, A_{\bar{z}}\right]\right]=-\frac{2\left|f_{1}\right|^{2}}{\left|f_{0}\right|^{4}} f_{0} f_{1}^{*}, P=-\frac{f_{2} f_{0}^{*}}{\left|f_{1}\right|^{2}},\left[\left[A_{\bar{z}}, A_{z}\right], P\right]=-\frac{f_{2} f_{0}^{*}}{\left|f_{0}\right|^{2}} . \tag{3.12}
\end{equation*}
$$

Then using relations $\left[A_{\bar{z}},\left[A_{z}, A_{\bar{z}}\right]\right]=M_{1} A_{\bar{z}}$ and $\left[\left[A_{\bar{z}}, A_{z}\right], P\right]=M_{2} P$, we find easily

This together with $\delta_{0}^{(n)}=n, \delta_{1}^{(n)}=2(n-1)$ implies

From Lemma 2.2, up to a holomorphic isometry of $\mathbb{C} P^{2}, \underline{f}_{0}, \underline{f}_{1}, \underline{f}_{2}: S^{2} \rightarrow \mathbb{C} P^{2}$ are Veronese surfaces. Then by Lemma 3.2, it can easily be checked that, for any $U \in U(4)$

\underline{\phi}=\underline{U V}_{0}^{(2)} \oplus \underline{c}_{0}: S^{2} \rightarrow G(2,4 ; \mathbb{C}) \tag{3.15}
\end{equation*}
$$

is of parallel second fundamental form with constant curvature $K=2$ (adding zero to the end of $V_{0}^{(2)}$ such that it belongs to $\left.\mathbb{C}^{4}\right)$.

Summing up, we get the following property

Proposition 3.4. Let $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ be a linearly full holomorphic curve with parallel second fundamental form. Suppose rank $\partial^{\prime} \underline{\phi}=1$, then $\phi$ is congruent to cases (1) (2) or (3) in Theorem 1.1.
3.2. $\partial^{\prime}$-irreducible holomorphic curves with parallel second fundamental form. Let $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ be a linearly full conformal minimal immersion with Gauss curvature $K$ and second fundamental form $B$. Suppose that $B$ is parallel and $\phi$ is holomorphic with $\partial^{\prime}$-irreducible, then a harmonic sequence derived by $\phi$ via the $\partial^{\prime}$-transform is as follows

0 \xrightarrow{\partial^{\prime}} \underline{\phi} \xrightarrow{\partial^{\prime}} \underline{\phi}_{1} \xrightarrow{\partial^{\prime}} \cdots \xrightarrow{\partial^{\prime}} 0 \tag{3.16}
\end{equation*}
$$

with rank $\underline{\phi}_{1}=2$.
Since $\phi$ is holomorphic, it is possible to obtain its local section $f_{0}$ such that $\underline{f}_{0}$ is a holomorphic subbundle of $\phi$. Without loss of generality, we assume that $\bar{\partial} f_{0}=0$. Therefore $\underline{f}_{0}$ is a linearly full harmonic map from $S^{2}$ to $\mathbb{C} P^{n}$ for some $n<N$ and belongs to the following harmonic sequence

0 \xrightarrow{\partial^{\prime}} \underline{f}_{0} \xrightarrow{\partial^{\prime}} \underline{f}_{1} \xrightarrow{\partial^{\prime}} \cdots \xrightarrow{\partial^{\prime}} \underline{f}_{n} \xrightarrow{\partial^{\prime}} 0 .

From the fact rank $\phi=2$, we immediately see that there exists another local section $\alpha$ of $\underline{\phi}$ such that $\underline{\phi}=\underline{\alpha} \oplus \underline{f}_{0}$. Set

$$

By Theorem 2.4 of [3] and (3.16), we have a new harmonic map

\underline{\alpha} \oplus \underline{\beta}: S^{2} \rightarrow G(2, N ; \mathbb{C})
$$

which belongs to the following harmonic sequence:

0 \stackrel{\partial^{\prime \prime}}{\leftarrow} \underline{f}_{0} \stackrel{\partial^{\prime \prime}}{\leftarrow} \underline{\alpha} \oplus \underline{\beta} \xrightarrow{\partial^{\prime}} \cdots \xrightarrow{\partial^{\prime}} 0
$$

From it we arrive at the following equations

Proposition 3.5. Let $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ be a linearly full $\partial^{\prime}$-irreducible holomorphic curve with parallel second fundamental form, then $\phi$ is congruent to cases (4) or (5) in Theorem 1.1.

Proof. In our prove, by observing equations (3.20) and (3.21), we discuss the rigidity of $\phi$ by cases $M_{2}=\frac{\left|\alpha_{1}\right|^{2}}{|\alpha|^{2}}$ and $M_{2} \neq \frac{\left|\alpha_{1}\right|^{2}}{|\alpha|^{2}}$ respectively.

Firstly we discuss the case $M_{2}=\frac{\left|\alpha_{1}\right|^{2}}{|\alpha|^{2}}$. In this case we immediately have

In the absence of confusion, let $V_{0}^{(2)}=\left(1, \sqrt{2} z, z^{2}, 0,0,0\right)^{T}$ and $\widehat{V}_{0}^{(2)}=$ ( $\left.0,0,0,1, \sqrt{2} z, z^{2}\right)^{T}$ (we shall use such notions repeated below), in summary, up to an isometry of $G(2, N ; \mathbb{C}), \phi$ can be expressed as

Then substituting (3.22)-(3.24) into (3.19), we get $P=0$, i.e. $\phi: S^{2} \rightarrow G(2,4 ; \mathbb{C})$ is totally geodesic with constant curvature $K=2$ from (3.18), the harmonic sequence given in (3.16) becomes

Propositions 3.4 and 3.5 give a classification of all linearly full holomorphic maps from $S^{2}$ to $G(2, N ; \mathbb{C})$ with parallel second fundamental form, from them we get Theorem 1.1 in Section 1.

## 4. Minimal two-Spheres with parallel second fundamental form and rank $\partial^{\prime} \underline{\phi}=$ RANK $\partial^{\prime \prime} \underline{\phi}=1$

Accordingly, in this section, we consider conformal minimal immersions $\phi: S^{2} \rightarrow$ $G(2, N ; \mathbb{C})$ under the assumption that $\nabla B=0$ and rank $\partial^{\prime} \underline{\phi}=\operatorname{rank} \partial^{\prime \prime} \underline{\phi}=1$. To characterize $\phi$, we first prove the following property:
Proposition 4.1. Let $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ be a linearly full conformal minimal immersion with the second fundamental form $B$. Suppose that $B$ is parallel and rank $\partial^{\prime} \underline{\phi}=$ rank $\partial^{\prime \prime} \phi=1$, then $\phi$ belongs to one of the following cases.
(i) $\phi$ is a Frenet pair, i.e. $\underline{\phi}=\underline{f}_{i-1} \oplus \underline{f}_{i}$, where $\underline{f}_{i}: S^{2} \rightarrow \mathbb{C} P^{n}$ is harmonic and $N=n+1$;
(ii) $\phi$ is a mixed pair, i.e. $\underline{\phi}=\underline{f}_{0} \oplus \underline{g}_{m}$, where $\underline{f}_{0}: S^{2} \rightarrow \mathbb{C} P^{n}$ is holomorphic and $\underline{g}_{m}: S^{2} \rightarrow \mathbb{C} P^{m}$ is anti-holomorphic;
(iii) $\underline{\phi}=\underline{f}_{i} \oplus \underline{c}_{0}$, where $c_{0}=(0,0, \ldots, 0,1)^{T}$ in $\mathbb{C}^{N}, \underline{f}_{i}: S^{2} \rightarrow \mathbb{C} P^{n}$ is harmonic and $N=\bar{n}+2$.

Proof. The harmonic sequence derived by $\phi$ via the $\partial^{\prime}$ and $\partial^{\prime \prime}$-transforms is as follows:

Since $\phi$ is harmonic and $\operatorname{rank} \partial^{\prime} \phi=\operatorname{rank} \partial^{\prime \prime} \phi=1$, it is possible to choose local sections $f_{i+1}, g_{j-1}$ of $\underline{\phi}_{1}$ and $\underline{\phi}_{-1}$ respectively such that $\underline{\phi}_{1}=\underline{f}_{i+1}, \underline{\phi}_{-1}=\underline{g}_{j-1}$, here $\underline{f}_{i+1}: S^{2} \rightarrow$ $\mathbb{C} P^{n}$ and $\underline{g}_{j-1}: S^{2} \rightarrow \mathbb{C} P^{m}$ are both harmonic. Such (4.1) can be rewritten as

From it we have $\left\langle\rho, f_{k}\right\rangle=0, k=0,1, \ldots, n, N=n+2$. Therefore $\rho$ is a constant section in $\mathbb{C}^{N}$ and $\phi$ belongs to case (iii).

If $\underline{g}_{j} \neq \underline{f}_{i}$. In this case we claim $\left\langle f_{i}, g_{j}\right\rangle=0$, i.e. $A_{\phi}^{\prime \prime}\left(\underline{\operatorname{ker}} A_{\phi}^{\prime}+\right)=0$ and then, $\phi$ belongs to cases (i) or (ii) by Lemma 3.3. For this purpose we put $\alpha=g_{j}-\frac{\left\langle g_{j}, f_{i}\right\rangle}{\left|f_{i}\right|^{2}} f_{i}$, then from
(4.2) and expression $\phi=\frac{\alpha \alpha^{*}}{|\alpha|^{2}}+\frac{f_{i} f_{i}^{*}}{\left|f_{i}\right|^{2}}$, direct computations show that

From Proposition 4.1, to finish the complete classification of $\phi$ in (4.2) with parallel second fundamental form, we distinguish three cases respectively: $\phi$ is a Frenet pair; $\phi$ is a mixed pair; whereas $\underline{\phi}=\underline{f}_{i} \oplus \underline{c}_{0}$.

Lemma 4.2. Let $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ be a linearly full Frenet pair with parallel second fundamental form and rank $\partial^{\prime} \underline{\phi}=\operatorname{rank} \partial^{\prime \prime} \phi=1$, then up to $U(4)$ equivalence, $\phi$ belongs to case (1) in Theorem 1.2.

Proof. Let us first assume that $\underline{\phi}=\underline{f}_{i-1} \oplus \underline{f}_{i}: S^{2} \rightarrow G(2, N ; \mathbb{C})$, where $\underline{f}_{i}: S^{2} \rightarrow \mathbb{C} P^{n}$ is harmonic with $N=n+1$ and $\phi$ belongs to the following harmonic sequence

$i \geq 2, n \geq i+1$. On the one hand, by making use of $\phi=\frac{f_{i-1} f_{i-1}^{*}}{\left|f_{i-1}\right|^{2}}+\frac{f_{i} f_{i}^{*}}{\left|f_{i}\right|^{2}}$ and $\left[A_{\bar{z}},\left[A_{z}, A_{\bar{z}}\right]\right]=$ $M_{1} A_{\bar{z}}$ we have

which further implies $l_{i}=l_{i-2}$ and thus $\delta_{i}^{(n)}=\delta_{i-2}^{(n)}$. Since the second fundamental form of $\phi$ is parallel, its Gauss curvature is a constant. By a similar reasoning as the one when $\phi$ is a Frenet pair in subsection 3.1, the harmonic sequence (4.3) is totally unramified, which gives $\delta_{i}^{(n)}=(i+1)(n-i), \delta_{i-2}^{(n)}=(i-1)(n-i+2)$. So we get

Then $\left[\left[A_{\bar{z}}, A_{z}\right], P\right] f_{i-1}=M_{2} P f_{i-1}$ is equivalent to

By relation in (4.4) and (4.7) we find that $\underline{f}_{2}: S^{2} \rightarrow \mathbb{C} P^{3}$ is of constant curvature, using the rigidity theorem of Bolton et al ([2]), up to a holomorphic isometry of $\mathbb{C} P^{3}, \underline{f}_{2}$ is a Veronese surface. We can choose a complex coordinate $z$ on $\mathbb{C}=S^{2} \backslash\{p t\}$ so that $f_{2}=U V_{2}^{(3)}$, where $U \in U(4)$ and $V_{2}^{(3)}$ has the standard expression given in Section 2.

Finally, in proving Lemma 4.2, it is easy to check that, for any $U \in U(4)$,

is of parallel second fundamental form with $K=\frac{2}{3}$ and $\|B\|^{2}=\frac{8}{3}$, this the proof of our lemma is complete.

Lemma 4.2 proves the case that $\phi$ is a Frenet pair, more interesting is naturally the case that $\phi$ is a mixed pair, which we are going to suppose from now on. Without loss of generality, we express it by

Basing on the formula $\phi=\frac{g_{m} g_{m}^{*}}{\left|g_{m}\right|^{2}}+\frac{f_{0} f_{0}^{*}}{\left|f_{0}\right|^{2}}$ we have

{\left[A_{\bar{z}},\left[A_{z}, A_{\bar{z}}\right]\right]=-\frac{2\left|f_{1}\right|^{2}}{\left|f_{0}\right|^{4}} f_{0} f_{1}^{*}-\frac{2\left|g_{m}\right|^{2}}{\left|g_{m-1}\right|^{4}} g_{m-1} g_{m}^{*}+\frac{\left|g_{m}\right|^{2}\left\langle g_{m-1}, f_{1}\right\rangle}{\left|f_{0}\right|^{2}\left|g_{m-1}\right|^{4}} f_{0} g_{m-1}^{*}+\frac{\left\langle g_{m-1}, f_{1}\right\rangle}{\left|f_{0}\right|^{2}\left|g_{m-1}\right|^{2}} f_{1} g_{m}^{*} .}
\end{gathered}

Then analyzing $\left[A_{\bar{z}},\left[A_{z}, A_{\bar{z}}\right]\right]=M_{1} A_{\bar{z}}$ we find

Lemma 4.3. Let $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ be a linearly full mixed pair with parallel second fundamental form and rank $\partial^{\prime} \underline{\phi}=$ rank $\partial^{\prime \prime} \underline{\phi}=1$, then $\phi$ is congruent to cases (2) (3) (4) or (5) in Theorem 1.2.

Proof. From (4.8), to finish the classification of $\phi$, we distinguish two cases: $\underline{f}_{1}=\underline{g}_{m-1}$, whereas $\underline{f}_{1} \neq \underline{g}_{m-1}$.
(a) $\underline{f}_{1}=\underline{g}_{m-1}$. In this case we have

where $\underline{f}_{0}, \underline{g}_{m}: S^{2} \rightarrow \mathbb{C} P^{2}$ are both harmonic maps with constant curvature. Therefore, by Lemma 2.2, there exists some $U \in U(3)$ s.t. $f_{0}=U V_{0}^{(2)}$, and the expression for $\phi$ becomes

For any $U \in U(3)$, it can be easily calculated that such $\underline{\phi}=\underline{f}_{0} \oplus \underline{f}_{2}$ is totally geodesic with constant curvature $K=1$, and it is congruent to the case (2) in Theorem 1.2.
(b) $\underline{f}_{1} \neq \underline{g}_{m-1}$. In this case, it follows from relations shown in (4.8) that

and $\underline{f}_{0}, \underline{g}_{m}: S^{2} \rightarrow \mathbb{C} P^{n}$ are both harmonic maps with constant curvature. Thus, by Lemma 2.2, they are both Veronese surfaces in $\mathbb{C} P^{n}$, up to a $U(n+1)$-motion.

If $m=n=1$. Here by a direct computation we immediately have $P=0$ and $\underline{\phi}=\underline{f}_{0} \oplus \underline{g}_{1}$ : $S^{2} \rightarrow G(2,4 ; \mathbb{C})$ is totally geodesic with constant curvature $K=2$ under the assumption that $\left\{\underline{g}_{0}, \underline{g}_{1}\right\}$ and $\left\{\underline{f}_{0}, \underline{f}_{1}\right\}$ are mutually orthogonal in $\mathbb{C} P^{1}$ with constant curvature. Adding zeros to $V_{0}^{(1)}$ and $V_{1}^{(1)}$ respectively, let $\widehat{V}_{0}^{(1)}=(0,0,1, z)^{T}$ and $V_{1}^{(1)}=\frac{1}{1+z \bar{z}}(-\bar{z}, 1,0,0)^{T}$, then, up to an isometry of $G(2,4 ; \mathbb{C})$, there exists some $U \in U(4)$ s.t.

2\left[\left[A_{\bar{z}}, A_{z}\right], P\right]=\frac{1}{\left|g_{m-2}\right|^{2}} g_{m} g_{m-2}^{*}+\frac{\left|g_{m}\right|^{2}\left\langle f_{2}, g_{m-1}\right\rangle}{\left|f_{1}\right|^{2}\left|g_{m-1}\right|^{4}} g_{m-1} f_{0}^{*}-\frac{\left|g_{m-1}\right|^{2}\left\langle f_{1}, g_{m-2}\right\rangle}{\left|f_{0}\right|^{2}\left|g_{m-2}\right|^{2}\left|g_{m}\right|^{2}} g_{m} f_{1}^{*}-\frac{1}{\left|f_{0}\right|^{2}} f_{2} f_{0}^{*}
\end{gathered}
$$

Then $\left[\left[A_{\bar{z}}, A_{z}\right], P\right]=M_{2} P$ holds if and only if the following equations

If $\underline{g}_{m-1}=\underline{f}_{2}$. In this case $\underline{g}_{m}=\underline{f}_{3}, m=n=3$ and $\underline{f}_{0}: S^{2} \rightarrow \mathbb{C} P^{3}$ is of constant curvature. Then, by Lemma 2.2, there exists some $U \in U(4)$ s.t. $f_{0}=U V_{0}^{(3)}$ and

With a simple test we know that such $\phi$ is of parallel second fundamental form with $K=\frac{2}{3}$ and $\|B\|^{2}=\frac{8}{3}$, and it is congruent to the case (4) in Theorem 1.2.

If $\underline{g}_{m-1} \neq \underline{f}_{2}$. In this case we have

is of parallel second fundamental form. Then let $\widehat{V}_{0}^{(2)}=\left(0,0,0,1, \sqrt{2} z, z^{2}\right)^{T}$ and $V_{2}^{(2)}=\frac{2}{(1+z \bar{z})^{2}}\left(\bar{z}^{2},-\sqrt{2} \bar{z}, 1,0,0,0\right)^{T}$, there exists some $U \in U(6)$ s.t.

which is congruent to the case (5) in Theorem 1.2. Summing up, we get the conclusion.
Lemma 4.3 gives a complete classification of $\phi$ with parallel second fundamental form and $\operatorname{rank} \partial^{\prime} \underline{\phi}=\operatorname{rank} \partial^{\prime \prime} \underline{\phi}=1$ when it is a mixed pair. Finally we need to consider the case that $\underline{\phi}=\underline{f}_{i} \oplus \underline{c}_{0}: S^{2} \rightarrow G(2, N ; \mathbb{C})$, which is a linearly full harmonic map with $\nabla B=0,1 \leq i \leq N-3$ and $c_{0}=(0, \ldots, 0,1)^{T} \in \mathbb{C}^{N}$, then we find the following harmonic sequence:

$i \geq 1, n \geq i+1, N=n+2$. At first we use $\phi=\frac{c_{0} c_{0}^{*}}{\left|c_{0}\right|^{2}}+\frac{f_{i} f_{i}^{*}}{\left|f_{i}\right|^{2}}$ to compute

This implies further that $\underline{f}_{i}: S^{2} \rightarrow \mathbb{C} P^{n}$ is of constant curvature, using the rigidity theorem of Bolton et al ([2]), up to a holomorphic isometry of $\mathbb{C} P^{n}$, there exists some $U \in U(n+1)$ s.t. $f_{i}=U V_{i}^{(n)}$.

Lemma 4.4. Let $\underline{\phi}=\underline{f}_{i} \oplus \underline{c}_{0}: S^{2} \rightarrow G(2, N ; \mathbb{C})$ be a linearly full conformal minimal immersion with parallel second fundamental form and $1 \leq i \leq N-3$, then $\phi$ is congruent to cases (6) or (7) in Theorem 1.2.

Proof. By using relation $\left[A_{\bar{z}},\left[A_{z}, A_{\bar{z}}\right]\right]=M_{1} A_{\bar{z}}$ we get $-M_{1}=\frac{\left|f_{i+1}\right|^{2}}{\left|f_{i}\right|^{2}}=\frac{\left|f_{i}\right|^{2}}{\left|f_{i-1}\right|^{2}}$, which establishes $l_{i-1}=l_{i}, \delta_{i-1}^{(n)}=\delta_{i}^{(n)}$ and therefore

2 i=n, \quad K+\frac{\|B\|^{2}}{2}=1 \tag{4.11}
\end{equation*}
$$

If $i=1$. Then we have $n=2$ and

for some $U \in U(4)$ (adding zero to the end of $V_{1}^{(2)}$ s.t. it belongs to $\mathbb{C}^{4}$ ). With a simple test we know that such $\phi$ is totally geodesic with $K=1$, and it is congruent to the case (6) in Theorem 1.2.

If $i \geq 2$. Here we obtain

$$

which implies

K=\frac{1}{3}, \quad\|B\|^{2}=\frac{4}{3}, \quad i=2 \tag{4.12}
\end{equation*}

from $\left[\left[A_{\bar{z}}, A_{z}\right], P\right]=M_{2} P$ and (4.11). With a simple test we know, for any $U \in U(6)$,

Summing Lemmas 4.2-4.4, we get Theorem 1.2 in Section 1.

## 5. Minimal two-spheres with parallel second fundamental form and rank $\partial^{\prime} \underline{\phi}=1$, RANK $\partial^{\prime \prime} \underline{\phi}=2$

In this section we analyze conformal minimal immersions $\phi$ from $S^{2}$ to $G(2, N ; \mathbb{C})$ with parallel second fundamental form, $\operatorname{rank} \partial^{\prime} \underline{\phi}=1$ and $\operatorname{rank} \partial^{\prime \prime} \underline{\phi}=2$. From $\phi$, a harmonic sequence is derived as follows:

\end{equation*}

Since $\underline{\phi}_{1}$ is of rank one and it is harmonic, we can write $\underline{\phi}_{1}=\underline{f}_{i+1}$, where $f_{i+1}$ is a local section of $\underline{\phi}_{1}$ and it belongs to the following harmonic sequence in $\mathbb{C} P^{n}$

From (5.1), since $f_{i}$ is a local section of $\underline{\phi}$ and rank $\underline{\phi}=2$, there exists another local section $\alpha$ of $\underline{\phi}$ such that $\underline{\phi}=\underline{\alpha} \oplus \underline{f}_{i}$. To characterize $\phi$ and give its classification, at first we state one of Burstall and Wood' results ([3]) as follows:

Let $\underline{\phi}: S^{2} \rightarrow G(2, N ; \mathbb{C})$ be a harmonic map with $\partial^{\prime} \underline{\phi}$ of rank one and $A_{\phi}^{\prime \prime}\left(\underline{\operatorname{ker}} A_{\phi}^{\prime}\right) \neq 0$. Lemma 5.2. Let $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ be a linearly full conformal minimal immersion in (5.1) with $\nabla B=0$ and $\underline{\alpha}_{-1}=\underline{f}_{i+1}$, then up to $U(4)$ equivalence, $\phi$ belongs to case (1) in Theorem 1.3.

Lemma 5.3. Let $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ be a linearly full conformal minimal immersion in (5.1) with $\nabla B=0$ and $\underline{\alpha}_{-1} \neq \underline{f}_{i+1}, \underline{\beta}=\underline{f}_{i-1}$, then up to an isometry of $G(2, N ; \mathbb{C}), \phi$ belongs to case (2) in Theorem 1.3.

Proof. $\underline{\beta}=\underline{f}_{i-1}$ preserves the following relation

$$
\frac{\left\langle\beta, f_{i-1}\right\rangle\left\langle f_{i-1}, \beta\right\rangle\left|f_{i}\right|^{2}}{\left|f_{i-1}\right|^{4}|\beta|^{2}}=\frac{\left|f_{i}\right|^{2}}{\left|f_{i-1}\right|^{2}}, \quad\left\langle f_{i+2}, \beta\right\rangle=0
$$

This together with (5.16) show us $l_{i-1}=l_{i}, \quad \delta_{i-1}^{(n)}=\delta_{i}^{(n)}$. So we get

In the following we discuss $\phi$ in cases $n \geq i+2, M_{2}=0 ; n \geq i+2, M_{2} \neq 0$ and $n=i+1$ respectively.

At first, if $n \geq i+2, M_{2}=0$. By comparing $K=\frac{\|B\|^{2}}{4}$ and (5.18)

In substituting the metric of $\phi$ shown in (5.17) into the equation $K=\frac{4}{15}$, we have

$$

which implies

With a little change of notation, equations (5.10)-(5.13) can be rewritten in the form

& \partial \lambda_{3}+\lambda_{3} \frac{\left\langle\partial f_{i}, f_{i}\right\rangle}{\left|f_{i}\right|^{2}}+\lambda_{3} \frac{\langle\beta, \bar{\partial} \beta\rangle}{|\beta|^{2}}=0  \tag{5.22}\\
& \quad\left\langle\alpha_{-1}, f_{i+2}\right\rangle=0,\left\langle\beta, f_{i+2}\right\rangle=0,\left\langle\bar{\partial} \beta, \alpha_{-1}\right\rangle=0, \bar{\partial} \alpha_{-1}=\frac{\left\langle\bar{\partial} \alpha_{-1}, \alpha_{-1}\right\rangle}{\left|\alpha_{-1}\right|^{2}} \alpha_{-1} .
\end{align*}
$$

Then expression of $P$ becomes

by substituting (5.21) (5.22) into (5.9). Clearly, straightforward calculations give the square of the length of the second fundamental form

\|B\|^{2}=4 \operatorname{tr} P P^{*}=4\left[\left|\lambda_{1}\right|^{2}\left|f_{2}\right|^{2}\left|f_{4}\right|^{2}+\left|\lambda_{3}\right|^{2} \frac{\left\langle f_{0}, \bar{\partial} \beta\right\rangle\left\langle\bar{\partial} \beta, f_{0}\right\rangle\left|f_{2}\right|^{2}}{\left|f_{0}\right|^{2}}\right]=\frac{64}{75}
$$

which contradicts the fact that $\|B\|^{2}=\frac{16}{15}$.
Next, if $n \geq i+2, M_{2} \neq 0$. We shall prove that this assumption is also not true. For this purpose, by using of the first relation in (5.16) we get

\left\langle f_{i+2}, \alpha\right\rangle=\left\langle\partial f_{i+1}, \alpha\right\rangle=-\left\langle f_{i+1}, \bar{\partial} \alpha\right\rangle=-\left\langle f_{i+1}, \alpha_{-1}\right\rangle=0

This together with $\left\langle f_{i+2}, \beta\right\rangle=0$ and $a=1$ reduce (5.13) to $M_{2} f_{i+2}=-\frac{\left\langle f_{i+2}, \alpha-1\right\rangle}{|\alpha|^{2}} \alpha_{-1}$, it further implies that

by (5.17) (5.18) and (5.23). Observe the induced metric and Gauss curvature of $\phi$, similarly we verify $i=3, \quad n=6$ and

Applying Lemma 3.2, with a straightforward calculation we know that, for any $U \in U(7)$,

does not have parallel second fundamental form.
At last, if $n=i+1$. This relation together with (5.20) implies $i=1, \quad n=2$. From (2.7) and (5.17), the Gauss curvature is

\|B\|^{2}=0, \quad M_{2}=\frac{2\left|f_{i+1}\right|^{2}}{\left|f_{i}\right|^{2}}
$$

Substituting it into (5.10), we get

Then by using (2.1), the subbundle $\underline{\alpha}$ is harmonic in $\mathbb{C} P^{1}$ since $\underline{\phi}=\underline{\alpha} \oplus \underline{f}_{i}$ is harmonic and $\underline{\beta}=\underline{f}_{i-1}$. Hence there exists local sections $g_{0}, g_{1}$ such that

where $g_{0}$ is holomorphic (without loss of generality, we assume $\bar{\partial} g_{0}=0$ ) and $\left\{\underline{g}_{0}, \underline{g}_{1}\right\}$ and $\left\{\underline{f}_{0}, \underline{f}_{1}, \underline{f}_{2}\right\}$ are mutually orthogonal harmonic sequences in $\mathbb{C} P^{1}$ and $\mathbb{C} P^{2}$ respectively with constant curvature. Adding zeros to $V_{1}^{(1)}$ and $V_{1}^{(2)}$ respectively, let $\widehat{V}_{1}^{(1)}=$ $\frac{1}{1+z \bar{z}}(0,0,0,-\bar{z}, 1)^{T}$ and $V_{1}^{(2)}=\frac{1}{1+z \bar{z}}(-2 \bar{z}, \sqrt{2}(1-z \bar{z}), 2 z, 0,0)^{T}$, then, up to an isometry of $G(2,5 ; \mathbb{C})$, there exists some $U \in U(5)$,

\underline{\phi}=\underline{U \widehat{V}_{1}^{(1)}} \oplus \underline{U V}_{1}^{(2)}: S^{2} \rightarrow G(2,5 ; \mathbb{C})
$$

By an immediately computation, such $\phi$ is totally geodesic with $K=\frac{4}{5}$, it belongs to case (2) in Theorem 1.3. Thus we get the conclusion.

In the following we discuss the case $\underline{\beta} \neq \underline{f}_{i-1}$. Since $f_{i-1}$ is a local section of $\underline{\alpha} \oplus \underline{\beta}$, $\underline{\beta} \neq \underline{f}_{i-1}$ means $\left\langle f_{i-1}, \alpha\right\rangle \neq 0$. From (5.19) we have $M_{2}=\frac{\left|f_{i+1}\right|^{2}}{2\left|f_{i}\right|^{2}}$. Then there holds $K-\frac{\|B\|^{2}}{4}=\frac{1}{5}$. By combining it with (5.18) we conclude

K=\frac{2}{5}, \quad\|B\|^{2}=\frac{4}{5}
$$

Now by using of $M_{2}=\frac{\left|f_{i+1}\right|^{2}}{2\left|f_{i}\right|^{2}}$ and the first three relations in (5.16), (5.11) can be reduced to

f_{i+2}=-\frac{\left\langle f_{i+2}, \alpha_{-1}\right\rangle}{|\alpha|^{2}} \alpha_{-1}-2 \frac{\left\langle f_{i+2}, \beta\right\rangle}{|\beta|^{2}} \beta

This together with the first relation in (5.4) show $f_{i+2}=0$, i.e., $n=i+1$. Moreover, it follows from $K=\frac{2}{5}$ that

Then from (5.10)-(5.13) we find $\bar{\partial} \beta=\frac{\left\langle\bar{\partial} \beta, \alpha_{-1}\right\rangle}{\left|\alpha_{-1}\right|^{2}} \alpha_{-1}+\frac{\langle\bar{\partial} \beta, \beta\rangle}{|\beta|^{2}} \beta$, and relations (5.18) and (5.19) also hold here. In order to give a complete classification of such $\phi$, we need the following important equation

\left\langle\beta, f_{1}\right\rangle=0
$$

which is obtained by substituting the expression of $\lambda_{3}$ into (5.22), and using (5.17). Finally, we end our classification for such harmonic maps by the following lemma.

Lemma 5.4. Let $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ be a linearly full conformal minimal immersion in (5.1) with $\nabla B=0$ and $\underline{\alpha}_{-1} \neq \underline{f}_{i+1}, \underline{\beta} \neq \underline{f}_{i-1}$, then up to an isometry of $G(2, N ; \mathbb{C}), \phi$ belongs to case (3) in Theorem 1.3.

Proof. By previous analysis, $\phi^{(1)}$ gives rise to the following harmonic sequence

\begin{equation*}
0 \stackrel{\partial^{\prime \prime}}{\leftrightarrows} \cdots{\stackrel{\partial}{ }{ }^{\prime \prime}}_{\leftarrow}^{\underline{\alpha}}-1{\stackrel{\partial}{ }{ }^{\prime \prime}}_{\leftarrow}^{\phi^{(1)}}=\underline{\alpha} \oplus \underline{\beta} \xrightarrow{\partial^{\prime}} \underline{f}_{3} \xrightarrow{\partial^{\prime}} \underline{f}_{4} \xrightarrow{\partial^{\prime}} 0 . \tag{5.24}
\end{equation*}
$$

At first we claim

$$
\begin{equation*}
A_{\phi^{(1)}}^{\prime \prime}\left(\underline{\operatorname{ker}} A_{\phi^{(1)}}^{\prime}\right) \neq 0 \tag{5.25}
\end{equation*}
$$

Otherwise if $A_{\phi^{(1)}}^{\prime \prime}\left(\underline{\operatorname{ker}} A_{\phi^{(1)}}^{\prime}\right)=0$, then according to Lemma 3.3 we conclude $\phi^{(1)}$ is a Frenet pair and $\underline{\phi}^{(1)}=\underline{f}_{1} \oplus \underline{f}_{2}$. Hence we have $\underline{\beta}=\underline{f}_{2}$ by means of the equation $\left\langle\beta, f_{1}\right\rangle=0$, which contradicts the fact $\underline{\beta} \neq \underline{f}_{i-1}$. Thus $(5.25)$ holds.

In view of properties of harmonic sequence (5.24) we notice that, $\underline{f}_{2}$ is a subbundle with rank one of $\underline{\phi}^{(1)}$, let

\underline{\gamma}=\underline{f}_{2}^{\perp} \cap \underline{\phi}^{(1)},
$$

then $\underline{\phi}^{(1)}$ can be rewritten as $\underline{\phi}^{(1)}=\underline{\gamma} \oplus \underline{f}_{2}: S^{2} \rightarrow G(2, N ; \mathbb{C})$. Here $\underline{\gamma}$ is an antiholomorphic subbundle of $\underline{\phi}^{(1)}$, it satisfies $A_{\phi^{(1)}}^{\prime}(\gamma)=0$ and $A_{\phi^{(1)}}^{\prime \prime}\left(f_{2}\right) \neq 0$, i.e. $\underline{\gamma}=$ $\underline{\operatorname{ker}} A_{\phi^{(1)}}^{\prime}, A_{\phi^{(1)}}^{\prime \prime}\left(\underline{\operatorname{ker}} A_{\phi^{(1)}}^{\prime}\right) \neq 0$. Then Lemma 5.1 shows that, the backward replacement of $\underline{f}_{2}$ produces a new harmonic map

it derives a harmonic sequence as follows:

0 \stackrel{\partial^{\prime \prime}}{\leftarrow} \cdots \stackrel{\partial^{\prime \prime}}{\leftarrow} \underline{\alpha}_{-2} \stackrel{\partial^{\prime \prime}}{\longleftrightarrow} \underline{\phi}^{(2)}=\underline{\alpha}_{-1} \oplus \underline{\gamma} \xrightarrow{\partial^{\prime}} \underline{f}_{2} \xrightarrow{\partial^{\prime}} \underline{f}_{3} \xrightarrow{\partial^{\prime}} \underline{f}_{4} \xrightarrow{\partial^{\prime}} 0,
$$

where $\alpha_{-2}=\bar{\partial} \alpha_{-1}-\frac{\left\langle\bar{\partial} \alpha_{-1}, \alpha_{-1}\right\rangle}{\left|\alpha_{-1}\right|^{2}} \alpha_{-1}$.
By a similar discussion we also claim

A_{\phi^{(2)}}^{\prime \prime}\left(\underline{\operatorname{ker}} A_{\phi^{(2)}}^{\prime \perp}\right) \neq 0
$$

Otherwise if $A_{\phi^{(2)}}^{\prime \prime}\left(\underline{\operatorname{ker}} A_{\phi^{(2)}}^{\prime}\right)=0$, then $\phi^{(2)}$ is a Frenet pair from Lemma 3.3, and $\underline{\phi}^{(2)}=$ $\underline{f}_{0} \oplus \underline{f}_{1}$. Since $\underline{\alpha}_{-1} \neq \underline{f}_{1}$, it is possible for us to put

\alpha_{-1}=f_{0}+x_{1} f_{1}, \gamma=-\bar{x}_{1}\left|f_{1}\right|^{2} f_{0}+\left|f_{0}\right|^{2} f_{1}, \beta=f_{2}+x_{2} \gamma
$$

where $x_{1}$ and $x_{2}$ are smooth functions on $S^{2}$ expect some isolated points. So it verifies $x_{2}=0$ from the relation $\left\langle\beta, f_{1}\right\rangle=0$, i.e. $\underline{\beta}=\underline{f}_{2}$, which is a contradiction. Thus $A_{\phi^{(2)}}^{\prime \prime}\left(\underline{\operatorname{ker}} A_{\phi^{(2)}}^{\prime}\right) \neq 0$ holds.

Reusing the above methods, $\underline{f}_{1}$ is a subbundle with rank one of $\underline{\phi}^{(2)}$, let $\underline{\gamma}^{1}=\underline{f}_{1}^{\perp} \cap \underline{\phi}^{(2)}$, then $\underline{\phi}^{(2)}$ can be rewritten as $\underline{\phi}^{\overline{(2)}}=\underline{\gamma}^{1} \oplus \underline{f}_{1}$. The backward replacement of $\underline{f}_{1}$ produces a new harmonic map

\underline{\phi}^{(3)}=\underline{\alpha}_{-2} \oplus \underline{\gamma}^{1}: S^{2} \rightarrow G(2, N ; \mathbb{C})
$$

it belongs to the following harmonic sequence:

\begin{equation*}
0 \stackrel{\partial^{\prime \prime}}{\longleftarrow} \cdots \stackrel{\partial^{\prime \prime}}{\leftarrow} \underline{\phi}^{(3)}=\underline{\alpha}_{-2} \oplus \underline{\gamma}^{1} \xrightarrow{\partial^{\prime}} \underline{f}_{1} \xrightarrow{\partial^{\prime}} \underline{f}_{2} \xrightarrow{\partial^{\prime}} \underline{f}_{3} \xrightarrow{\partial^{\prime}} \underline{f}_{4} \xrightarrow{\partial^{\prime}} 0 . \tag{5.26}
\end{equation*}
$$

In harmonic sequence (5.26) we notice that $\underline{f}_{0}$ is a subbundle with rank one of $\underline{\phi}^{(3)}$, it satisfies $A_{\phi^{(3)}}^{\prime \prime} \mid f_{0}=0$, i.e.

A_{\phi^{(3)}}^{\prime \prime}\left(\underline{\operatorname{ker}} A_{\phi^{(3)}}^{\prime}\right)=0
$$

hence $\phi^{(3)}$ is a mixed pair. Suppose therefore that $\underline{\phi}^{(3)}=\underline{g}_{m} \oplus \underline{f}_{0}, \underline{g}_{m}$ and $\underline{f}_{0}$ are antiholomorphic and holomorphic curves in $\mathbb{C} P^{m}$ and $\overline{\mathbb{C}} P^{n}$ respectively such that $\underline{h}_{1} \perp \underline{g}_{m}$. Then it is reasonable to put

\gamma^{1}=g_{m}+x_{3} f_{0}, \alpha_{-2}=-\bar{x}_{3}\left|f_{0}\right|^{2} g_{m}+\left|g_{m}\right|^{2} f_{0}, \gamma=\gamma^{1}+x_{4} f_{1}
$$

where $x_{3}$ and $x_{4}$ are smooth functions on $S^{2}$ expect some isolated points. We thus derive $x_{4}=0$ from the fact $\left\langle\beta, f_{1}\right\rangle=0$, which gives $\gamma=\gamma^{1}, \underline{\alpha}_{-1}=\underline{f}_{1}, \underline{\alpha}_{-2}=\underline{f}_{0}$, it further implies

\underline{\phi}^{(3)}=\underline{c}_{0} \oplus \underline{f}_{0}, \quad \underline{\phi}^{(1)}=\underline{c}_{0} \oplus \underline{f}_{2}, \quad \underline{\phi}=\underline{f}_{3} \oplus \underline{\alpha},
$$

where $c_{0}=(0, \ldots, 0,1)^{T}$.
Next set

$$
\begin{equation*}
\alpha=f_{2}+x_{5} c_{0}, \quad \beta=-\bar{x}_{5} f_{2}+\left|f_{2}\right|^{2} c_{0} \tag{5.27}
\end{equation*}
$$

where $x_{5}$ is a smooth functions on $S^{2}$ expect some isolated points, then using (5.27) we arrive at

\partial x_{5}=0, \quad \bar{\partial} x_{5}=0, \quad\left|x_{5}\right|^{2}=2\left|f_{2}\right|^{2}=48, \quad\langle\partial \alpha, \alpha\rangle=0, \quad\langle\bar{\partial} \alpha, \alpha\rangle=0
$$

according to
$\alpha_{-1}=\bar{\partial} \alpha-\frac{\langle\bar{\partial} \alpha, \alpha\rangle}{|\alpha|^{2}} \alpha, \alpha_{1}=\partial \alpha-\frac{\langle\partial \alpha, \alpha\rangle}{|\alpha|^{2}} \alpha=\frac{\left\langle\alpha, f_{2}\right\rangle}{\left|f_{2}\right|^{2}} f_{3}, \frac{\left|\alpha_{-1}\right|^{2}}{|\alpha|^{2}}=\frac{\left|f_{4}\right|^{2}}{2\left|f_{3}\right|^{2}},\left|f_{2}\right|^{2}=\left|V_{2}^{(4)}\right|^{2}=24$
respectively, the last equation follows from (2.14).
This together with (3.2) implies finally that such $\underline{\phi}=\underline{f}_{3} \oplus \underline{\alpha}$ is of second fundamental form, it belongs to case (3) in Theorem 1.3, which completes the proof.

Summing Lemmas 5.2-5.4, we obtain Theorem 1.3 in Section 1.
6. $\partial^{\prime}$-IRREDUCIBLE AND $\partial^{\prime \prime}$-IRREDUCIBLE MINIMAL TWO-SPHERES WITH PARALLEL SECOND FUNDAMENTAL FORM

Let $\phi$ be a conformal minimal immersion from $S^{2}$ to $G(2, N ; \mathbb{C})$ with rank $\partial^{\prime} \underline{\phi}=$ rank $\partial^{\prime \prime} \underline{\phi}=2$. Suppose $\phi$ is of parallel second fundamental form, in this section we analyze $\phi$ by $r=1$ and $r \geq 2$ respectively, where $r$ is the isotropy order of $\phi$.
(a) $r=1$. Here we consider harmonic map $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ of finite isotropy order $r=1$ under the supposition rank $\partial^{\prime} \underline{\phi}=\operatorname{rank} \partial^{\prime \prime} \underline{\phi}=2$, then $\phi$ belongs to the following harmonic sequence

$$
\begin{equation*}
0 \stackrel{\partial^{\prime \prime}}{\longleftrightarrow} \cdots \stackrel{\partial^{\prime \prime}}{\leftarrow} \underline{\phi}_{-1} \stackrel{\partial^{\prime \prime}}{\longleftrightarrow} \underline{\phi} \xrightarrow{\partial^{\prime}} \underline{\phi}_{1} \xrightarrow{\partial^{\prime}} \cdots \stackrel{\partial^{\prime}}{\longrightarrow} 0 . \tag{6.1}
\end{equation*}
$$

Since $r=1$, it is easy to see that there exists a local unitary frame $e_{0}, e_{1}, e_{2}, e_{3}, e_{4}$ of $S^{2} \times \mathbb{C}^{N}$ such that $\left\{e_{0}, e_{1}\right\},\left\{e_{0}, e_{2}\right\},\left\{e_{3}, e_{4}\right\}$ locally span subbundles $\underline{\phi}_{1}, \underline{\phi}_{-1}, \underline{\phi}$ of $S^{2} \times \mathbb{C}^{N}$ respectively, and

\underline{\phi}_{-1} \cap \underline{\phi}_{1}=\underline{e}_{0}, A_{\phi}^{\prime}\left(\underline{e}_{3}\right)=\underline{e}_{0}
$$

Let $W_{-1}=\left(e_{0}, e_{2}\right), W_{0}=\left(e_{3}, e_{4}\right), W_{1}=\left(e_{0}, e_{1}\right)$, then

$$
W_{1}^{*} W_{-1}=\left(\begin{array}{cc}
1 & 0  \tag{6.2}\\
0 & 0
\end{array}\right)
$$

Observing the fact $\phi=W_{0} W_{0}^{*}$, then by using (2.5), it is not difficult to get the following equations:

{\left[A_{\bar{z}},\left[A_{z}, A_{\bar{z}}\right]\right]=\begin{array}{l}
-2 W_{-1} \Omega_{-1}^{*} \Omega_{-1} \Omega_{-1}^{*} W_{0}^{*}-2 W_{0} \Omega_{0}^{*} \Omega_{0} \Omega_{0}^{*} W_{1}^{*}+W_{-1} \Omega_{-1}^{*} \Omega_{0}^{*} \Omega_{0} W_{0}^{*} \\
+W_{0} \Omega_{0}^{*} W_{1}^{*} W_{-1} \Omega_{-1}^{*} \Omega_{-1} W_{-1}^{*}+W_{1} \Omega_{0} \Omega_{0}^{*} W_{1}^{*} W_{-1} \Omega_{-1}^{*} W_{0}^{*} \\
+W_{0} \Omega_{-1} \Omega_{-1}^{*} \Omega_{0}^{*} W_{1}^{*}
\end{array} .}
\end{gathered}
$$

Hence we immediately get

$$
\begin{align*}
& M_{1} \Omega_{-1}^{*}=-2 \Omega_{-1}^{*} \Omega_{-1} \Omega_{-1}^{*}+\Omega_{-1}^{*} \Omega_{0}^{*} \Omega_{0}+W_{-1}^{*} W_{1} \Omega_{0} \Omega_{0}^{*} W_{1}^{*} W_{-1} \Omega_{-1}^{*}  \tag{6.3}\\
& M_{1} \Omega_{0}^{*}=-2 \Omega_{0}^{*} \Omega_{0} \Omega_{0}^{*}+\Omega_{-1} \Omega_{-1}^{*} \Omega_{0}^{*}+\Omega_{0}^{*} W_{1}^{*} W_{-1} \Omega_{-1}^{*} \Omega_{-1} W_{-1}^{*} W_{1} \tag{6.4}
\end{align*}
$$

from the fact $\left[A_{\bar{z}},\left[A_{z}, A_{\bar{z}}\right]\right]=M_{1} A_{\bar{z}}$. For convenience, using relation $A_{\phi}^{\prime}\left(\underline{e}_{3}\right)=\underline{e}_{0}$, it is possible for us to put

$$
\Omega_{-1}=\left(\begin{array}{cc}
x & y  \tag{6.5}\\
z & w
\end{array}\right), \quad \Omega_{0}=\left(\begin{array}{cc}
\lambda & \nu \\
0 & \mu
\end{array}\right)
$$

which are both $(2 \times 2)$-matrices of rank two. By comparing every elements of matrix $\Omega_{0}$, condition (6.4) is equivalent to the equations

$$
\left\{\begin{array}{l}
M_{1} \bar{\lambda}=\bar{\lambda}\left(-2|\lambda|^{2}-2|\nu|^{2}+2|x|^{2}+|y|^{2}+|z|^{2}\right)+\bar{\nu}(x \bar{z}+y \bar{w})  \tag{6.6}\\
0=\bar{\mu}(x \bar{z}+y \bar{w}-2 \bar{\lambda} \nu), \\
M_{1} \bar{\mu}=\bar{\mu}\left(-2|\nu|^{2}-2|\mu|^{2}+|z|^{2}+|w|^{2}\right) \\
M_{1} \bar{\nu}=\bar{\nu}\left(-2|\lambda|^{2}-2|\mu|^{2}-2|\nu|^{2}+|x|^{2}+2|z|^{2}+|w|^{2}\right)+\bar{\lambda}(\bar{x} z+\bar{y} w)
\end{array}\right.
$$

by (6.2) and (6.5). From above equations in (6.6) we claim

$$
\begin{equation*}
\nu=0 \tag{6.7}
\end{equation*}
$$

Otherwise by using $\lambda \neq 0, \mu \neq 0$ and $\nu \neq 0$ we derive

x \bar{z}+y \bar{w}=2 \bar{\lambda} \nu  \tag{6.8}\\
M_{1}=-2|\mu|^{2}-2|\nu|^{2}+|z|^{2}+|w|^{2} \\
M_{1}=-2|\mu|^{2}-2|\nu|^{2}+|x|^{2}+2|z|^{2}+|w|^{2}
\end{array}\right.
$$

then $x=0, z=0$ can be obtained by comparing the second and the third equations of (6.8), which contradicts our supposition rank $\Omega_{-1}=2$ and then verifies (6.7). So we have the following conclusions

M_{1}=-2|\lambda|^{2}+2|x|^{2}+|y|^{2}+|z|^{2}  \tag{6.9}\\
M_{1}=-2|\mu|^{2}+|z|^{2}+|w|^{2} \\
x \bar{z}+y \bar{w}=0
\end{array}\right.
$$

hold.
Next we consider (6.3) by induction. Applying (6.2) and (6.5), condition (6.3) holds if and only if the following equations

$$
\begin{align*}
& \left(M_{1}+2|x|^{2}+2|y|^{2}-2|\lambda|^{2}\right) \bar{x}=0,  \tag{6.10}\\
& \left(M_{1}+2|x|^{2}+2|y|^{2}-|\lambda|^{2}\right) \bar{y}=0,  \tag{6.11}\\
& \left(M_{1}+2|z|^{2}+2|w|^{2}-|\lambda|^{2}-|\mu|^{2}\right) \bar{z}=0,  \tag{6.12}\\
& \left(M_{1}+2|z|^{2}+2|w|^{2}-|\mu|^{2}\right) \bar{w}=0 \tag{6.13}
\end{align*}
$$

hold, which implies $x=0$ or $y=0$ by observing (6.10) and (6.11).
Here we claim

$$
\begin{equation*}
x=0 . \tag{6.14}
\end{equation*}
$$

In order to achieve our objective, we first discuss the case $x \neq 0$. In view of (6.10)-(6.13) we get $y=z=0$ and $w \neq 0$. (6.10) becomes $M_{1}=2|\lambda|^{2}-2|x|^{2}$, comparing it with the first equation of (6.9), $M_{1}=0$, which is impossible. At present, we have made (6.14) true, then it can be clearly seen that (6.3) becomes

$$
\left\{\begin{array}{l}
w=0  \tag{6.15}\\
M_{1}=|\lambda|^{2}-2|y|^{2} \\
M_{1}=|\lambda|^{2}+|\mu|^{2}-2|z|^{2}
\end{array}\right.
$$

Furthermore by (6.9) and (6.15), we get $|y|^{2}=|\mu|^{2}=-2 M_{1}, \quad|z|^{2}=|\lambda|^{2}=-3 M_{1}$, which implies

$$
L_{-1}=L_{0}=-5 M_{1}
$$

by using $L_{-1}=\operatorname{tr}\left(\Omega_{-1} \Omega_{-1}^{*}\right)$ and $L_{0}=\operatorname{tr}\left(\Omega_{0} \Omega_{0}^{*}\right)$. It shows that $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ is totally real with $\nabla B=0$ and $r=1$. Then from [1] and Theorem 1.1 of [16],

$$
\underline{\phi}=\underline{U V}_{1}^{(4)} \oplus \underline{U V}_{3}^{(4)}: S^{2} \rightarrow G(2,5 ; \mathbb{C})
$$

for some $U \in U(5)$ satisfies $\overline{U V}_{0}^{(4)}=\underline{U V_{4}^{(4)}}$, which is totally geodesic with $K=\frac{1}{5}$, and it is congruent to the case (1) in Theorem 1.4.
(b) $r \geq 2$. In this part we consider $\partial^{\prime}$-irreducible and $\partial^{\prime \prime}$-irreducible harmonic map $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ of isotropy order $r \geq 2$ (including the strongly isotropic case), here $\phi$
also derives the harmonic sequence given in (6.1). Since $r \geq 2, \phi_{-1}, \phi$ and $\phi_{1}$ are mutually orthogonal and $W_{1}^{*} W_{-1}=0$. Similar calculations give

$$
\begin{aligned}
{\left[A_{\bar{z}},\left[A_{z}, A_{\bar{z}}\right]\right]=} & -2 W_{-1} \Omega_{-1}^{*} \Omega_{-1} \Omega_{-1}^{*} W_{0}^{*}-2 W_{0} \Omega_{0}^{*} \Omega_{0} \Omega_{0}^{*} W_{1}^{*} \\
& +W_{-1} \Omega_{-1}^{*} \Omega_{0}^{*} \Omega_{0} W_{0}^{*}+W_{0} \Omega_{-1} \Omega_{-1}^{*} \Omega_{0}^{*} W_{1}^{*}
\end{aligned}
$$

At this time, under the assumption that $\phi$ is of parallel second fundamental form, it following from $\left[A_{\bar{z}},\left[A_{z}, A_{\bar{z}}\right]\right]=M_{1} A_{\bar{z}}$ that

$$
\left\{\begin{array}{l}
M_{1} I=-2 \Omega_{-1} \Omega_{-1}^{*}+\Omega_{0}^{*} \Omega_{0} \\
M_{1} I=-2 \Omega_{0}^{*} \Omega_{0}+\Omega_{-1} \Omega_{-1}^{*}
\end{array}\right.
$$

where $I$ is a $(2 \times 2)$-identity matrix, which implies $L_{-1}=L_{0}=-2 M_{1}$. It concludes that $\phi: S^{2} \rightarrow G(2, N ; \mathbb{C})$ is totally real with parallel second fundamental form and isotropy order $r \geq 2$. Then from [1, 13] and [16], $\phi$ belongs to the following two cases:
 some $U \in U(6)$;
(2) $\underline{\phi}=\overline{U V}_{2}^{(4)} \oplus \underline{U V}_{2}^{(4)}: S^{2} \rightarrow G(2,10 ; \mathbb{C})$ or $\underline{\phi}=\underline{\mathbf{J} U V}_{2}^{(4)} \oplus \underline{U V}_{2}^{(4)}: S^{2} \rightarrow G(2,10 ; \mathbb{C})$ for some $U \in U(10)$.

In the absence of confusion, adding zeros to $V_{1}^{(2)}$, let $\widehat{V}_{1}^{(2)}=\frac{1}{1+z \bar{z}}(0,0,0,-2 \bar{z}, \sqrt{2}(1-$ $z \bar{z}), 2 z)^{T}$ and $V_{1}^{(2)}=\frac{1}{1+z \bar{z}}(-2 \bar{z}, \sqrt{2}(1-z \bar{z}), 2 z, 0,0,0)^{T}$, in summary, for some $U \in U(6)$, $\phi$ shown in (1) can be expressed as

$$
\underline{\phi}=\underline{U}_{1}^{(2)} \oplus \underline{U V}_{1}^{(2)}: S^{2} \rightarrow G(2,6 ; \mathbb{C})
$$

which is totally geodesic with $K=\frac{1}{2}$ by a series of calculations. It is congruent to the case (2) in Theorem 1.4.

Similarly, let
$\widehat{V}_{2}^{(4)}=\frac{2}{(1+z \bar{z})^{2}}\left(0,0,0,0,0,6 \bar{z}^{2}, 6 \bar{z}(z \bar{z}-1), \sqrt{6}\left(1-4 z \bar{z}+(z \bar{z})^{2}\right), 6 z(1-z \bar{z}), 6 z^{2}\right)^{T}$,
$V_{2}^{(4)}=\frac{2}{(1+z \bar{z})^{2}}\left(6 \bar{z}^{2}, 6 \bar{z}(z \bar{z}-1), \sqrt{6}\left(1-4 z \bar{z}+(z \bar{z})^{2}\right), 6 z(1-z \bar{z}), 6 z^{2}, 0,0,0,0,0\right)^{T}$, in summary, for some $U \in U(10), \phi$ in (2) can be expressed as

$$
\underline{\phi}=\underline{U}_{\hat{V}}^{2}(4) \oplus \underline{U V}_{2}^{(4)}: S^{2} \rightarrow G(2,10 ; \mathbb{C})
$$

which is of parallel second fundamental form with $K=\frac{1}{6}$ and $\|B\|^{2}=\frac{2}{3}$, and it is congruent to the case (3) in Theorem 1.4.

Summing up, we get Theorem 1.4 in Section 1.
Theorems 1.1-1.4 in Section 1 determine all conformal minimal immersions of parallel second fundamental form from $S^{2}$ to $G(2, N ; \mathbb{C})$. It is easy to check that no two of these eighteen cases are congruent, i.e., we can not transform any one into another by left multiplication by $\mathrm{U}(\mathrm{N})$.

Up to an isometry of $G(2, N ; \mathbb{C})$, Theorems 1.1-1.4 show that all linearly full conformal minimal immersions of parallel second fundamental form from $S^{2}$ to $G(2, N ; \mathbb{C})$ are presented by Veronese surfaces in $\mathbb{C} P^{n}$ for some $n<N$. It is easy to check that these eighteen minimal immersions are all homogeneous. Of course they contain those given by ([13], Theorem 1.1 and [16], Theorem 1.1), even more than those (cf. cases (1)(2) and (3) shown in Theorem 1.1 etc.).
