# THE PICARD GROUPS OF INCLUSIONS OF $C^{*}$-ALGEBRAS INDUCED BY EQUIVALENCE BIMODULES

#### Abstract

Let $A$ and $B$ be $\sigma$-unital $C^{*}$-algebras and $X$ and $Y$ an $A-A$ equivalence bimodule and a $B-B$-equivalence bimodule, respectively. Also, let $A \rtimes_{X} \mathbf{Z}$ and $B \rtimes_{Y} \mathbf{Z}$ be the crossed products of $A$ and $B$ by $X$ and $Y$, respectively. Furthermore, let $A \subset A \rtimes_{X} \mathbf{Z}$ and $B \subset B \rtimes_{Y} \mathbf{Z}$ be the inclusions of $C^{*}$-algebras induced by $X$ and $Y$, respectively. We suppose that $A^{\prime} \cap M\left(A \rtimes_{X} \mathbf{Z}\right)=\mathbf{C} 1$. In this paper we shall show that the inclusions $A \subset A \rtimes_{X} \mathbf{Z}$ and $B \subset B \rtimes_{Y} \mathbf{Z}$ are strongly Morita equivalent if and only if there is an $A-B$-equivalence bimodule $M$ such that $Y \cong \widetilde{M} \otimes_{A} X \otimes_{A} M_{\tilde{Y}}$ or $\widetilde{Y} \cong \widetilde{M} \otimes_{A} X \otimes_{A} M$ as $B-B$-equivalence bimodules, where $\widetilde{M}$ and $\widetilde{Y}$ are the dual $B-A$-equivalence bimodule and the dual $B-B$-equivalence bimodule of $M$ and $Y$, respectively. Applying this result, we shall compute the Picard group of the inclusion $A \subset A \rtimes_{X} \mathbf{Z}$ under the assumption that $A^{\prime} \cap M\left(A \rtimes_{X} \mathbf{Z}\right)=\mathbf{C} 1$.


## 1. Introduction

In the previous paper [11], we discussed strong Morita equivalence for unital inclusions of unital $C^{*}$-algebras induced by involutive equivalence bimodules. That is, let $A$ and $B$ be unital $C^{*}$-algebras and $X$ and $Y$ an involutive $A-A$-equivalence bimodule and an involutive $B-B$-equivalence bimodule, respectively. Let $C_{X}$ and $C_{Y}$ be unital $C^{*}$-algebras induced by $X$ and $Y$ and $A \subset C_{X}$ and $B \subset C_{Y}$ the unital inclusions of unital $C^{*}$-algebras. We suppose that $A^{\prime} \cap C_{X}=\mathbf{C} 1$. In the paper [11], we showed that $A \subset C_{X}$ and $B \subset C_{Y}$ are strongly Morita equivalent if and only if there is an $A-B$-equivalence bimodule $M$ such that $Y \cong \widetilde{M} \otimes_{A} X \otimes_{A} M$ as $B-B$-equivalence bimodules. In the present paper, we shall show the same result as above in the case of inclusions of $C^{*}$-algebras induced by $\sigma$-unital $C^{*}$-algebra equivalence bimodules.

Let $A$ and $B$ be $\sigma$-unital $C^{*}$-algebras and $X$ and $Y$ an $A-A$-equivalence bimodule and a $B-B$-equivalence bimodule, respectively. Let $A \rtimes_{X} \mathbf{Z}$ and $B \rtimes_{Y} \mathbf{Z}$ be the crossed products of $A$ and $B$ by $X$ and $Y$, respectively, which are defined in Abadie, Eilers and Exel [1]. Then we have inclusions of $C^{*}$-algebras $A \subset A \rtimes_{X} \mathbf{Z}$ and $B \subset B \rtimes_{Y} \mathbf{Z}$. We note that $\overline{A\left(A \rtimes_{X} \mathbf{Z}\right)}=A \rtimes_{X} \mathbf{Z}$ and $\overline{B\left(B \rtimes_{Y} \mathbf{Z}\right)}=B \rtimes_{Y} \mathbf{Z}$. We suppose that $A^{\prime} \cap M\left(A \rtimes_{X} \mathbf{Z}\right)=\mathbf{C} 1$. We shall show that $A \subset A \rtimes_{X} \mathbf{Z}$ and $B \subset B \rtimes_{Y} \mathbf{Z}$ are strongly Morita equivalent if and only if there is an $A-B$ equivalence bimodule $M$ such that $Y \cong \widetilde{M} \otimes_{A} X \otimes_{A} M$ or $\widetilde{Y} \cong \widetilde{M} \otimes_{A} X \otimes_{A} M$ as $B-B$-equivalence bimodules, where $\widetilde{M}$ and $\widetilde{Y}$ are the dual $B-A$-equivalence bimodule and the dual $B-B$-equivalence bimodule of $M$ and $Y$, respectively. Applying the above result, we shall compute the Picard group of the inclusion of $C^{*}$-algebras $A \subset A \rtimes_{X} \mathbf{Z}$ under the assumption that $A^{\prime} \cap M\left(A \rtimes_{X} \mathbf{Z}\right)=\mathbf{C} 1$.

## 2. Preliminaries

Let $\mathbf{K}$ be the $C^{*}$-algebra of all compact operators on a countably infinite dimensional Hilbert space and $\left\{e_{i j}\right\}_{i, j \in \mathbf{N}}$ its system of matrix units.

For each $C^{*}$-algebra $A$, we denote by $M(A)$ the multiplier $C^{*}$-algebra of $A$. Let $\pi$ be an isomorphism of $A$ onto a $C^{*}$-algebra $B$. Then there is the unique strictly continuous isomorphism of $M(A)$ onto $M(B)$ extending $\pi$ by Jensen and Thomsen [7] Corollary 1.1 .15$]$. We denote it by $\underline{\pi}$.

Let $A$ and $B$ be $C^{*}$-algebras and $X$ an $A-B$-bimodule. We denote its left $A$-action and right $B$-action on $X$ by $a \cdot x$ and $x \cdot b$ for any $a \in A, b \in B, x \in X$, respectively. We denote by $\tilde{X}$ the dual $B-A$-bimodule of $X$ and we denote by $\widetilde{x}$ the element in $\widetilde{X}$ induced by $x \in X$. Let $A \subset C$ and $B \subset D$ be inclusions of $C^{*}$-algebras.

Definition 2.1. We say that $A \subset C$ and $B \subset D$ are isomorphic as inclusions of $C^{*}$ algebras if there is an isomorphism $\pi$ of $C$ onto $D$ such that $\left.\pi\right|_{A}$ is an isomorphism of $A$ onto $B$.

Also, we give the following definition:
Definition 2.2. Let $\alpha$ nad $\beta$ be actions of a discrete group $G$ on $A$ and $B$, respectively. We say that $\alpha$ and $\beta$ are strongly Morita equivalent with respect to ( $X, \lambda$ ) if there are an $A-B$-equivalence bimodule $X$ and a linear automorphism $\lambda$ of $X$ satisfying the following:
(1) $\alpha_{t}\left({ }_{A}\langle x, y\rangle\right)={ }_{A}\left\langle\lambda_{t}(x), \lambda_{t}(y)\right\rangle$,
(2) $\beta_{t}\left(\langle x, y\rangle_{B}\right)=\left\langle\lambda_{t}(x), \lambda_{t}(y)\right\rangle_{B}$
for any $x, y \in X, t \in G$.
Then we have the following:

$$
\lambda_{t}(a \cdot x)=\alpha_{t}(a) \cdot \lambda_{t}(x), \quad \lambda_{t}(x \cdot b)=\lambda_{t}(x) \cdot \beta_{t}(b)
$$

for any $a \in A, b \in B, x \in X$ and $t \in G$.
Let $A$ and $B$ be $C^{*}$-algebras and $\pi$ an isomorphism of $B$ onto $A$. We construct an $A-B$-equivalence bimodule $X_{\pi}$ as follows: Let $X_{\pi}=A$ as $\mathbf{C}$-vector spaces. For any $a \in A, b \in B, x, y \in X_{\pi}$,

\begin{aligned}
& a \cdot x=a x, \quad x \cdot b=x \pi(b) \\
& { }_{A}\langle x, y\rangle=x y^{*}, \quad\langle x, y\rangle_{B}=\pi^{-1}\left(x^{*} y\right) .
\end{aligned}
$$

By easy computations, we can see that $X_{\pi}$ is an $A-B$-equivalence bimodule. We call $X_{\pi}$ an $A-B$-equivalence bimodule induced by $\pi$. Let $\alpha$ be an automorphism of $A$. Then in the same way as above, we construct $X_{\alpha}$, as $A-B$-equivalence bimodule. Let $u_{\alpha}$ be a unitary element in $M\left(A \rtimes_{\alpha} \mathbf{Z}\right)$ implementing $\alpha$. Hence $\alpha=\operatorname{Ad}\left(u_{\alpha}\right)$. We regard $A u_{\alpha}$ as an $A-A$-equivalence bimodule as follows:

\begin{aligned}
& a \cdot x u_{\alpha}=a x u_{\alpha}, \quad x u_{\alpha} \cdot a=x \alpha(a), \\
& { }_{A}\left\langle x u_{\alpha}, y u_{\alpha}\right\rangle, \quad\left\langle x u_{\alpha}, y u_{\alpha}\right\rangle_{A}=\alpha^{-1}\left(x^{*} y\right)
\end{aligned}
$$

for any $a, x, y \in A$.
Lemma 2.1. With the above notation, $X_{\alpha} \cong A u_{\alpha}$ as $A-A$-equivalence bimodules.
Proof. This is immediate by easy computations.
Let $A$ be a $C^{*}$-algebra and $X$ an $A-A$-equivalence bimodule. Let $A \rtimes_{X} \mathbf{Z}$ be the crossed product of $A$ by $X$ defined in [1]. We regard the $C^{*}$-algebra $\mathbf{K}$ as the trivial $\mathbf{K}-\mathbf{K}$-equivalence bimodule. Then we obtain an $A \otimes \mathbf{K}-A \otimes \mathbf{K}$-equivalence bimodule $X \otimes \mathbf{K}$ and we can also consider the the crossed product

$$
(A \otimes \mathbf{K}) \rtimes_{2} \otimes_{\mathbf{K}} \mathbf{Z}
$$

of $A \otimes \mathbf{K}$ by $X \otimes \mathbf{K}$. Hence we have the following inclusions of $C^{*}$-algebras:

$$
A \subset A \rtimes_{X} \mathbf{Z}, \quad A \otimes \mathbf{K} \subset(A \otimes \mathbf{K}) \rtimes_{X \otimes \mathbf{K}} \mathbf{Z}
$$

Since there is an isomorphism $\pi$ of $(A \otimes \mathbf{K}) \rtimes_{X \otimes \mathbf{K}} \mathbf{Z}$ onto $\left(A \rtimes_{X} \mathbf{Z}\right) \otimes \mathbf{K}$ such that $\left.\pi\right|_{A \rtimes \mathbf{K}}=$ id on $A \otimes \mathbf{K}$, we identify $A \otimes \mathbf{K} \subset(A \otimes \mathbf{K}) \rtimes_{X \otimes \mathbf{K}} \mathbf{Z}$ with $A \otimes \mathbf{K} \subset$ $\left(A \rtimes_{X} \mathbf{Z}\right) \otimes \mathbf{K}$. Thus $A \subset A \rtimes_{X} \mathbf{Z}$ and $A \otimes \mathbf{K} \subset(A \otimes \mathbf{K}) \rtimes_{X \otimes \mathbf{K}} \mathbf{Z}$ are strongly Morita equivalent. Let $H_{A}$ be the $A \otimes \mathbf{K}-A$-equivalence bimodule defined as follows: Let $H_{A}=(A \otimes \mathbf{K})\left(1_{M(A)} \otimes e_{11}\right)$ as $\mathbf{C}$-vector spaces. For any $a \in A, k \in \mathbf{K}$, $x, y \in A \otimes \mathbf{K}$,

$$
\begin{aligned}
& (a \otimes k) \cdot x\left(1 \otimes e_{11}\right)=(a \otimes k) x\left(1 \otimes e_{11}\right), \\
& x\left(1 \otimes e_{11}\right) \cdot a=x\left(a \otimes e_{11}\right) \\
& A \otimes \mathbf{K}\left\langle x\left(1 \otimes e_{11}\right), y\left(1 \otimes e_{11}\right)\right\rangle=x\left(1 \otimes e_{11}\right) y^{*} \\
& \left\langle x\left(1 \otimes e_{11}\right), y\left(1 \otimes e_{11}\right)\right\rangle_{A}=\left(1 \otimes e_{11}\right) x^{*} y\left(1 \otimes e_{11}\right),
\end{aligned}
$$

where we identify $A$ with $A \otimes e_{11}$. Let $B$ be a $C^{*}$-algebra. Let $H_{B}$ be as above.
Lemma 2.2. With the above notation, let $M$ be an $A-B$ - equivalence bimodule. Then

$$
\left(1 \otimes e_{11}\right) \cdot(M \otimes \mathbf{K}) \cdot\left(1 \otimes e_{11}\right) \cong M
$$

as $A-B$-equivalence bimodules.
Proof. Since the linear span of the set

$$
\left\{x \otimes e_{i j} \mid x \in M, i, j \in \mathbf{N}\right\}
$$

is dense in $M \otimes \mathbf{K},\left(1 \otimes e_{11}\right) \cdot(M \otimes \mathbf{K}) \cdot\left(1 \otimes e_{11}\right) \cong M \otimes e_{11}$ as $A-B$-equivalence bimodules. Hence

$$
\left(1 \otimes e_{11}\right) \cdot(M \otimes \mathbf{K}) \cdot\left(1 \otimes e_{11}\right) \cong M
$$

as $A-B$-equivalence bimodules.
Lemma 2.3. With the above notation, let $M$ be an $A-B$-equivalence bimodule. Then

$$
\widetilde{H_{A}} \otimes_{A \otimes \mathbf{K}}(M \otimes \mathbf{K}) \otimes_{B \otimes \mathbf{K}} H_{B} \cong M
$$

as $A-B$-equivalence bimodules.
Proof. Let $\pi$ be the map from $\widetilde{H_{A}} \otimes_{A \otimes \mathbf{K}}(M \otimes \mathbf{K}) \otimes_{B \otimes \mathbf{K}} H_{B}$ to $\left(1 \otimes e_{11}\right) \cdot(M \otimes$ $\mathbf{K}) \cdot\left(1 \otimes e_{11}\right)$ defined by

$$
\pi\left(\left[a\left(1 \otimes e_{11}\right)\right] \otimes x \otimes b\left(1 \otimes e_{11}\right)\right)=\left(1 \otimes e_{11}\right) \cdot\left(a^{*} \cdot x \cdot b\right) \cdot\left(1 \otimes e_{11}\right)
$$

for any $a \in A \otimes \mathbf{K}, b \in B \otimes \mathbf{K}, x \in M \otimes \mathbf{K}$. Then by easy computations, $\pi$ is an $A-B$-equivalence bimodule isomorphism of $\widetilde{H_{A}} \otimes_{A \otimes \mathbf{K}}(M \otimes \mathbf{K}) \otimes_{B \otimes \mathbf{K}} H_{B}$ onto $\left(1 \otimes e_{11}\right) \cdot(M \otimes \mathbf{K}) \cdot\left(1 \otimes e_{11}\right)$. Thus by Lemma 2.2

$$
\widetilde{H_{A}} \otimes_{A \otimes \mathbf{K}}(M \otimes \mathbf{K}) \otimes_{B \otimes \mathbf{K}} H_{B} \cong M
$$

as $A-B$-equivalence bimodules.
We prepare the following lemma which is applied in the next section.
Lemma 2.4. Let $A$ and $B$ be $C^{*}$ algebras and $X$ and $Y$ an $A-A$-equivalence bimodule and $B-B$-equivalence bimodule, respectively. Let $A \subset A \rtimes_{X} \mathbf{Z}$ and $B \subset B \rtimes_{Y} \mathbf{Z}$ be inclusions of $C^{*}$ algebras induced by $X$ and $Y$, respectively. We suppose that there is an $A-B$-equivalence bimodule $M$ such that $Y \cong \widetilde{M} \otimes_{A} X \otimes_{A}$ $M$ or $\widetilde{Y} \cong \widetilde{M} \otimes_{A} X \otimes_{A} M$ as $B-B$-equivalence bimodules. Then there is an $A \rtimes_{X} \mathbf{Z}-B \rtimes_{Y} \mathbf{Z}$-equivalence bimodule $N$ satisfying the following:
(1) $M$ is included in $N$ as a closed subspace,
(2) $A \subset A \rtimes_{X} \mathbf{Z}$ and $B \subset B \rtimes_{Y} \mathbf{Z}$ are strongly Morita equivalent with respect to $N$ and its closed subspace $M$.

Proof. Modifying the proof of [1, Theorem 4.2], we prove this lemma. We suppose that $Y \cong \widetilde{M} \otimes_{A} X \otimes_{A} M$ as $B-B$-equivalence bimodules. Let $L_{M}$ be the linking $C^{*}$-algebra for $M$ defined by

$$
L_{M}=\left[\begin{array}{cc}
A & M \\
\widetilde{M} & B
\end{array}\right]
$$

Also, let $W$ be the $L_{M}-L_{M^{-}}$equivalence bimodule defined in the proof of [1, Theorem 4.2], which is defined by

$$
W=\left[\begin{array}{cc}
X & X \otimes_{A} M \\
Y \otimes_{B} \widetilde{M} & Y
\end{array}\right]
$$

Let $L_{M} \rtimes_{W} \mathbf{Z}$ be the crossed product of $L_{M}$ by $W$ and let

$$
p=\left[\begin{array}{cc}
1_{M(A)} & 0 \\
0 & 0
\end{array}\right], \quad q=\left[\begin{array}{cc}
0 & 0 \\
0 & 1_{M(B)}
\end{array}\right]
$$

Furthermore, let $N=p\left(L_{M} \rtimes_{W} \mathbf{Z}\right) q$. Then since $M=p L_{M} q, M$ is a closed subspace of $N$. Hence by the proof of [1, Theorem 4.2], $A \subset A \rtimes_{X} \mathbf{Z}$ and $B \subset B \rtimes_{Y} \mathbf{Z}$ are strongly Morita equivalent with respect $N$ and its closed subspace $M$.

Next, we suppose that $\widetilde{Y} \cong \widetilde{M} \otimes_{A} X \otimes_{A} M$. Let

$$
W_{0}=\left[\begin{array}{cc}
X & X \otimes_{A} M \\
\widetilde{Y} \otimes_{B} \widetilde{M} & \widetilde{Y}
\end{array}\right]
$$

Then $W_{0}$ is an $L_{M}-L_{M}$-equivalence bimodule. Let $N_{0}=p\left(L_{M} \rtimes_{W_{0}} \mathbf{Z}\right) q$. By the above discussions, $A \subset A \rtimes_{X} \mathbf{Z}$ and $B \subset B \rtimes_{\tilde{Y}} \mathbf{Z}$ are strongly Morita equivalent with respect to $N_{o}$ and its closed subspace $M$. On the other hand, there is an isomorphism $\pi$ of $B \rtimes_{Y} \mathbf{Z}$ onto $B \rtimes_{\tilde{Y}} \mathbf{Z}$ such that $\left.\pi\right|_{B}=\mathrm{id}$ on $B$. Let $X_{\pi}$ be the $B \rtimes_{\tilde{Y}} \mathbf{Z}-B \rtimes_{Y} \mathbf{Z}$-equivalence bimodule induced by $\pi$. Then $B$ is a closed subspace of $X_{\pi}$ and we regard $B$ as the trivial $B-B$-equivalence bimodule since $\left.\pi\right|_{B}=\mathrm{id}$ on $B$. Thus $A \subset A \rtimes_{X} \mathbf{Z}$ and $B \subset B \rtimes_{Y} \mathbf{Z}$ are strongly Morita equivalent with respect to $N_{0} \otimes_{B \rtimes_{\tilde{Y}} \mathbf{Z}} X_{\pi}$ and its closed subspace $M \otimes_{B} B(\cong M)$. Therefore, we obtain the conclusion.

Lemma 2.5. With the above notation, we suppose that $A$ is a $\sigma$-unital $C^{*}$-algebra. Then there is an automorphism $\alpha$ of $A \otimes \mathbf{K}$ such that $A \otimes \mathbf{K} \subset(A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}$ is isomorphic to $A \otimes \mathbf{K} \subset(A \otimes \mathbf{K}) \rtimes_{X \otimes \mathbf{K}} \mathbf{Z}$ as inclusions of $C^{*}$-algebras.
Proof. Since $A$ is $\sigma$-unital, by Brown, Green and Rieffel [3, Corollary 3.5], there is an automorphism $\alpha$ of $A \otimes \mathbf{K}$ such that $X \otimes \mathbf{K} \cong X_{\alpha}$ as $A \otimes \mathbf{K}-A \otimes \mathbf{K}$ equivalence bimodules, where $X_{\alpha}$ is the $A \otimes \mathbf{K}-A \otimes \mathbf{K}$-equivalence bimodule induced by $\alpha$. Let $u_{\alpha}$ be a unitary element in $M\left((A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}\right)$ implementing $\alpha$. We regard $(A \otimes \mathbf{K}) u_{\alpha}$ as an $A \otimes \mathbf{K}-A \otimes \mathbf{K}$-equivalence bimodule as above. Then by Lemma 2.1, $X_{\alpha} \cong(A \otimes \mathbf{K}) u_{\alpha}$ as $A \otimes \mathbf{K}-A \otimes \mathbf{K}$-equivalence bimodules. Let $(A \otimes \mathbf{K}) \rtimes_{(A \otimes \mathbf{K}) u_{\alpha}} \mathbf{Z}$ be the crossed product of $A \otimes \mathbf{K}$ by $(A \otimes \mathbf{K}) u_{\alpha}$. Then by the definition of the crossed product of a $C^{*}$-algebra by an equivalence bimodule, we can see that

$$
(A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z} \cong(A \otimes \mathbf{K}) \rtimes_{(A \otimes \mathbf{K}) u_{\alpha}} \mathbf{Z}
$$

as $C^{*}$-algebras. Since $X_{\alpha} \cong X \otimes \mathbf{K}$ as $A \otimes \mathbf{K}-A \otimes \mathbf{K}$ - equivalence bimodules, we obtain that

$$
(A \otimes \mathbf{K}) \rtimes_{(A \otimes \mathbf{K}) u_{\alpha}} \mathbf{Z} \cong(A \otimes \mathbf{K}) \rtimes_{X_{\alpha}} \mathbf{Z} \cong(A \otimes \mathbf{K}) \rtimes_{X \otimes \mathbf{K}} \mathbf{Z}
$$

as $C^{*}$-algebras. Since the above isomorphisms leave any element in $A \otimes \mathbf{K}$ invariant, we can see that $A \otimes \mathbf{K} \subset(A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}$ is isomorphic to $A \otimes \mathbf{K} \subset(A \otimes \mathbf{K}) \rtimes_{X \otimes \mathbf{K}} \mathbf{Z}$ as inclusions of $C^{*}$-algebras.

## 3. Strong Morita equivalence

Let $A$ and $B$ be $\sigma$-unital $C^{*}$-algebras and $X$ and $Y$ an $A-A$-equivalence bimodule and a $B-B$-equivalence bimodule, respectively. Let $A \subset A \rtimes_{X} \mathbf{Z}$ and $B \subset B \rtimes_{Y} \mathbf{Z}$ be the inclusions of $C^{*}$-algebras induced by $X$ and $Y$, respectively. We suppose that $A \subset A \rtimes_{X} \mathbf{Z}$ and $B \subset B \rtimes_{Y} \mathbf{Z}$ are strongly Morita equivalent with respect to an $A \rtimes_{X} \mathbf{Z}-B \rtimes_{Y} \mathbf{Z}$-equivalence bimodule $N$ and its closed subspace $M$. We suppose that $A^{\prime} \cap M\left(A \rtimes_{X} \mathbf{Z}\right)=\mathbf{C} 1$. Then since the inclusion $A \otimes \mathbf{K} \subset(A \otimes \mathbf{K}) \rtimes_{X \otimes \mathbf{K}} \mathbf{Z}$ is isomorphic to the inclusion $A \otimes \mathbf{K} \subset\left(A \rtimes_{X} \mathbf{Z}\right) \otimes \mathbf{K}$ as inclusions of $C^{*}$-algebras, by [12, Lemma 3.1],

$$
(A \otimes \mathbf{K})^{\prime} \cap\left((A \otimes \mathbf{K}) \rtimes_{X \otimes \mathbf{K}} \mathbf{Z}\right)=\mathbf{C} 1
$$

Also, by the above assumptions, the inclusion $A \otimes \mathbf{K} \subset(A \otimes \mathbf{K}) \rtimes_{X \otimes \mathbf{K}} \mathbf{Z}$ is strongly Morita equivalent to the inclusion $B \otimes \mathbf{K} \subset(B \otimes \mathbf{K}) \rtimes_{Y \otimes \mathbf{K}} \mathbf{Z}$ with respect to the $(A \otimes \mathbf{K}) \rtimes_{X \otimes \mathbf{K}} \mathbf{Z}-(B \otimes \mathbf{K}) \rtimes_{Y \otimes \mathbf{K}} \mathbf{Z}$-equivalence bimodule $N \otimes \mathbf{K}$ and its closed subspace $M \otimes \mathbf{K}$. By Lemma 2.5, there are an automorphism $\alpha$ of $A \otimes \mathbf{K}$ and an automorphism $\beta$ of $B \otimes \mathbf{K}$ such that $A \otimes \mathbf{K} \subset(A \otimes \mathbf{K}) \rtimes_{X \otimes \mathbf{K}} \mathbf{Z}$ and $B \otimes \mathbf{K} \subset(B \otimes \mathbf{K}) \rtimes_{Y \otimes \mathbf{K}} \mathbf{Z}$ are isomorphic to $A \otimes \mathbf{K} \subset(A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}$ and $B \otimes \mathbf{K} \subset$ $(B \otimes \mathbf{K}) \rtimes_{\beta} \mathbf{Z}$ as inclusions of $C^{*}$-algebras, respectively. Hence we can assume that $A \otimes \mathbf{K} \subset(A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}$ and $B \otimes \mathbf{K} \subset(B \otimes \mathbf{K}) \rtimes_{\beta} \mathbf{Z}$ are strongly Morita equivalent with respect to an $(A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}-(B \otimes \mathbf{K}) \rtimes_{\beta} \mathbf{Z}$-equivalence bimodule $N \otimes \mathbf{K}$ and its closed subspace $M \otimes \mathbf{K}$. Since $A$ and $B$ are $\sigma$-unital, in the same way as in the proof of [10, Proposition 3.5] or [3, Proposition 3.1], there is an isomorphism $\theta$ of $(B \otimes \mathbf{K}) \rtimes_{\beta} \mathbf{Z}$ onto $(A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}$ satisfying the following:
(1) $\left.\theta\right|_{B \otimes \mathbf{K}}$ is an isomorphism of $B \otimes \mathbf{K}$ onto $A \otimes \mathbf{K}$,
(2) There is an $(A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}-(B \otimes \mathbf{K}) \rtimes_{\beta} \mathbf{Z}$ - equivalence bimodule isomorphism $\Phi$ of $N \otimes \mathbf{K}$ onto $Y_{\theta}$ such that $\left.\Phi\right|_{M \otimes \mathbf{K}}$ is an $A \otimes \mathbf{K}-B \otimes \mathbf{K}$-equivalence bimodule isomorphism of $M \otimes \mathbf{K}$ onto $X_{\theta}$, where $Y_{\theta}$ is the $(A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}-(B \otimes \mathbf{K}) \rtimes_{\beta} \mathbf{Z}$ equivalence bimodule induced by $\theta$ and $X_{\theta}$ is the $A \otimes \mathbf{K}-B \otimes \mathbf{K}$-equivalence bimodule induced by $\left.\theta\right|_{B \otimes \mathbf{K}}$.

Let

$$
\gamma=\left.\left.\theta\right|_{B \otimes \mathbf{K}} \circ \beta \circ \theta\right|_{B \otimes \mathbf{K}} ^{-1}
$$

and let $\lambda$ be the linear automorphism of $X_{\theta}$ defined by $\lambda(x)=\gamma(x)$ for any $x \in$ $X_{\theta}(=A \otimes \mathbf{K})$.
Lemma 3.1. With the above notation, $\gamma$ and $\beta$ are strongly Morita equivalent with respect to $\left(X_{\theta}, \lambda\right)$.
Proof. For any $x, y \in X_{\theta}$,

$$
\begin{aligned}
& A \otimes \mathbf{K}\langle\lambda(x), \lambda(y)\rangle=\gamma\left(x y^{*}\right)=\gamma(A \otimes \mathbf{K}\langle x, y\rangle) \\
& \langle\lambda(x), \lambda(y)\rangle_{B \otimes \mathbf{K}}=\left.\theta\right|_{B \otimes \mathbf{K}} ^{-1}\left(\gamma\left(x^{*} y\right)\right)=\beta\left(\left.\theta\right|_{B \otimes \mathbf{K}} ^{-1}\left(x^{*} y\right)\right)=\beta\left(\langle x y\rangle_{B \otimes \mathbf{K}}\right)
\end{aligned}
$$

Hence $\gamma$ and $\beta$ are strongly Morita equivalent with respect to $\left(X_{\theta}, \lambda\right)$.
By the proof of [12, Theorem 5.5], there is an automorphism $\phi$ of $\mathbf{Z}$ satisfying that $\gamma^{\phi}$ and $\alpha$ are exterior equivalent, that is, there is a unitary element $z \in M(A \otimes \mathbf{K})$ such that

$$
\gamma^{\phi}=\operatorname{Ad}(z) \circ \alpha, \quad \underline{\alpha}(z)=z
$$

where $\gamma^{\phi}$ is the automorphism of $A \otimes \mathbf{K}$ induced by $\gamma$ and $\phi$, that is, $\gamma^{\phi}$ is defined by $\gamma^{\phi}=\gamma^{\phi(1)}$. We note that $\gamma^{\phi}=\gamma$ or $\gamma^{\phi}=\gamma^{-1}$. We regard $A \otimes \mathbf{K}$ as the trivial $A \otimes \mathbf{K}-A \otimes \mathbf{K}$-equivalence bimdule. Let $\mu$ be the linear automorphism of $A \otimes \mathbf{K}$ defined by

$$
\mu(x)=\alpha(x) z^{*}
$$

for any $x \in A \otimes \mathbf{K}$.

Lemma 3.2. With the aboe notation, $\alpha$ and $\gamma^{\phi}$ are strongly Morita equivalent with respect to $(A \otimes \mathbf{K}, \mu)$.
Proof. For any $x, y \in A \otimes \mathbf{K}$,

$$
\begin{aligned}
& A \otimes \mathbf{K}\langle\mu(x), \mu(y)\rangle=A \otimes \mathbf{K}\left\langle\alpha(x) z^{*}, \alpha(y) z^{*}\right\rangle=\alpha\left(x y^{*}\right)=\alpha(A \otimes \mathbf{K}\langle x, y\rangle), \\
& \langle\mu(x), \mu(y)\rangle_{A \otimes \mathbf{K}}=z \alpha\left(x^{*} y\right) z^{*}=\gamma^{\phi}\left(x^{*} y\right)=\gamma^{\phi}\left(\langle x, y\rangle_{A \otimes \mathbf{K}}\right)
\end{aligned}
$$

Therefore, we obtain the conclusion.
Let $\nu$ be the linear automorphism of $X_{\theta}$ defined by

$$
\nu(x)=\gamma^{\phi}\left(z^{*} x\right)
$$

for any $x \in X_{\theta}(=A \otimes \mathbf{K})$.
Lemma 3.3. With the above notation, $\alpha$ and $\beta^{\phi}$ are strongly Morita equivalent with respect to $\left(X_{\theta}, \nu\right)$, where $\beta^{\phi}$ is the automorphism of $B \otimes \mathbf{K}$ induced by $\beta$ and $\phi$.

Proof. For any $x, y \in X_{\theta}$,

$$
\begin{aligned}
A \otimes \mathbf{K}\langle\nu(x), \nu(y)\rangle & =A \otimes \mathbf{K}\left\langle\gamma^{\phi}\left(z^{*} x\right), \gamma^{\phi}\left(z^{*} y\right)\right\rangle=\gamma^{\phi}\left(z^{*} x y^{*} z\right)=z \alpha\left(z^{*} x y^{*} z\right) z^{*} \\
& =\alpha\left(x y^{*}\right)=\alpha(A \otimes \mathbf{K}\langle x, y\rangle), \\
\langle\nu(x), \nu(y)\rangle_{B \otimes \mathbf{K}} & =\left\langle\gamma^{\phi}\left(z^{*} x\right), \gamma^{\phi}\left(z^{*} y\right)\right\rangle_{B \otimes \mathbf{K}}=\left.\theta\right|_{B \otimes \mathbf{K}} ^{-1}\left(\gamma^{\phi}\left(x^{*} y\right)\right)=\beta^{\phi}\left(\left.\theta\right|_{B \otimes \mathbf{K}} ^{-1}\left(x^{*} y\right)\right) \\
& =\beta^{\phi}\left(\langle x, y\rangle_{B \otimes \mathbf{K}}\right) .
\end{aligned}
$$

Therefore, we obtain the conclusion.
Since $\beta^{\phi}=\beta$ or $\beta^{\phi}=\beta^{-1}$, by Lemma 3.3, $\alpha$ is strongly Morita equivalent to $\beta$ or $\beta^{-1}$.
(I) We suppose that $\alpha$ is strongly Morita equivalent to $\beta$. Then by Lemma 3.3, there is the linear automorphism $\nu$ of $X_{\theta}$ satisfying the following:
(1) $\nu(a \cdot x)=\alpha(a) \cdot \nu(x)$,
(2) $\nu(x \cdot b)=\nu(x) \cdot \beta(b)$,
(3) $A \otimes \mathbf{K}\langle\nu(x), \nu(y)\rangle=\alpha\left({ }_{A \otimes \mathbf{K}}\langle x, y\rangle\right)$,
(4) $\langle\nu(x), \nu(y)\rangle_{B \otimes \mathbf{K}}=\beta\left(\langle x, y\rangle_{B \otimes \mathbf{K}}\right)$,
for any $a \in A \otimes \mathbf{K}, b \in B \otimes \mathbf{K}, x, y \in X_{\theta}$.
Lemma 3.4. With the above notation and assumptions, let $X_{\alpha}$ and $X_{\beta}$ be the $A \otimes \mathbf{K}-A \otimes \mathbf{K}$-equivalence bimodule and the $B \otimes \mathbf{K}-B \otimes \mathbf{K}$-equivalence bimodule induced by $\alpha$ and $\beta$, respectively. Then

$$
X_{\beta} \cong \widetilde{X_{\theta}} \otimes_{A \otimes \mathbf{K}} X_{\alpha} \otimes_{A \otimes \mathbf{K}} X_{\theta}
$$

as $B \otimes \mathbf{K}-B \otimes \mathbf{K}$-equivalence bimodules.
Proof. Let $\Psi$ be the map from $\widetilde{X_{\theta}} \otimes_{A \otimes \mathbf{K}} X_{\alpha} \otimes_{A \otimes \mathbf{K}} X_{\theta}$ to $X_{\beta}$ defined by

$$
\Psi(\widetilde{x} \otimes a \otimes y)=\langle x, a \cdot \nu(y)\rangle_{B \otimes \mathbf{K}}
$$

for any $x, y \in X_{\theta}, a \in X_{\alpha}$. Then for any $x, x_{1}, y, y_{1} \in X_{\theta}, a, a_{1} \in X_{\alpha}$,

$$
\begin{aligned}
B \otimes \mathbf{K}\left\langle\widetilde{x} \otimes a \otimes y, \widetilde{x_{1}} \otimes a_{1} \otimes y_{1}\right\rangle & ={ }_{B \otimes \mathbf{K}}\left\langle\widetilde{x} \cdot{ }_{A \otimes \mathbf{K}}\left\langle a \otimes y, a_{1} \otimes y_{1}\right\rangle, \widetilde{x_{1}}\right\rangle \\
& =\left\langle_{A \otimes \mathbf{K}}\left\langle a_{1} \otimes y_{1}, a \otimes y\right\rangle \cdot x, x_{1}\right\rangle_{B \otimes \mathbf{K}} \\
& =\left\langle_{A \otimes \mathbf{K}}\left\langle a_{1} \cdot{ }_{A \otimes \mathbf{K}}\left\langle y_{1}, y\right\rangle, a\right\rangle \cdot x, x_{1}\right\rangle_{B \otimes \mathbf{K}} \\
& =\left\langle_{A \otimes \mathbf{K}}\left\langle a_{1} \alpha\left(A \otimes \mathbf{K}\left\langle y_{1}, y\right\rangle\right), a\right\rangle \cdot x, x_{1}\right\rangle_{B \otimes \mathbf{K}} \\
& =\left\langle a_{1} \alpha\left(A \otimes \mathbf{K}\left\langle y_{1}, y\right\rangle\right) a^{*} \cdot x, x_{1}\right\rangle_{B \otimes \mathbf{K}} .
\end{aligned}
$$

On the other hand,

$$
\begin{aligned}
B \otimes \mathbf{K}\left\langle\Psi(\widetilde{x} \otimes a \otimes y), \Psi\left(\widetilde{x_{1}} \otimes a_{1} \otimes y_{1}\right)\right\rangle & =B \otimes \mathbf{K}\left\langle\langle x, a \cdot \nu(y)\rangle_{B \otimes \mathbf{K}},\left\langle x_{1}, a_{1} \cdot \nu\left(y_{1}\right)\right\rangle_{B \otimes \mathbf{K}}\right\rangle \\
& =\langle x, a \cdot \nu(y)\rangle_{B \otimes \mathbf{K}}\left\langle a_{1} \cdot \nu\left(y_{1}\right), x_{1}\right\rangle_{B \otimes \mathbf{K}} \\
& =\left\langle x, a \cdot \nu(y) \cdot\left\langle a_{1} \cdot \nu\left(y_{1}\right), x_{1}\right\rangle_{B \otimes \mathbf{K}}\right\rangle_{B \otimes \mathbf{K}} \\
& =\left\langle x, A \otimes \mathbf{K}\left\langle a \cdot \nu(y), a_{1} \cdot \nu\left(y_{1}\right)\right\rangle \cdot x_{1}\right\rangle_{B \otimes \mathbf{K}} \\
& =\left\langle x, a_{A \otimes \mathbf{K}}\left\langle\nu(y), \nu\left(y_{1}\right)\right\rangle a_{1}^{*} \cdot x_{1}\right\rangle_{B \otimes \mathbf{K}} \\
& =\left\langle a_{1} A \otimes \mathbf{K}\left\langle\nu\left(y_{1}\right), \nu(y)\right\rangle a^{*} \cdot x, x_{1}\right\rangle_{B \otimes \mathbf{K}} \\
& =\left\langle a_{1} \alpha\left(A \otimes \mathbf{K}\left\langle y_{1}, y\right\rangle\right) a^{*} \cdot x, x_{1}\right\rangle_{B \otimes \mathbf{K}} .
\end{aligned}
$$

Hence the map $\Psi$ preserves the left $B \otimes \mathbf{K}$-valued inner products. Also,

$$
\begin{aligned}
\left\langle\widetilde{x} \otimes a \otimes y, \widetilde{x_{1}} \otimes a_{1} \otimes y_{1}\right\rangle_{B \otimes \mathbf{K}} & =\left\langle y,\left\langle\widetilde{x} \otimes a, \widetilde{x_{1}} \otimes a_{1}\right\rangle_{A \otimes \mathbf{K}} \cdot y_{1}\right\rangle_{B \otimes \mathbf{K}} \\
& =\left\langle y\left\langle a, A \otimes \mathbf{K}\left\langle x, x_{1}\right\rangle \cdot a_{1}\right\rangle_{A \otimes \mathbf{K}} \cdot y_{1}\right\rangle_{B \otimes \mathbf{K}} \\
& =\left\langle y\left\langle a, A \otimes \mathbf{K}\left\langle x, x_{1}\right\rangle a_{1}\right\rangle_{A \otimes \mathbf{K}} \cdot y_{1}\right\rangle_{B \otimes \mathbf{K}} \\
& =\left\langle y, \alpha^{-1}\left(a^{*}{ }_{A \otimes \mathbf{K}}\left\langle x, x_{1}\right\rangle a_{1}\right) \cdot y_{1}\right\rangle_{B \otimes \mathbf{K}} .
\end{aligned}
$$

On the other hand,

$$
\begin{aligned}
\left\langle\Psi(\widetilde{x} \otimes a \otimes y), \Psi\left(\widetilde{x_{1}} \otimes a_{1} \otimes y_{1}\right)\right\rangle_{B \otimes \mathbf{K}} & =\left\langle\langle x, a \cdot \nu(y)\rangle_{B \otimes \mathbf{K}},\left\langle x_{1}, a_{1} \cdot \nu\left(y_{1}\right)\right\rangle_{B \otimes \mathbf{K}}\right\rangle_{B \otimes \mathbf{K}} \\
& =\beta^{-1}\left(\langle a \cdot \nu(y), x\rangle_{B \otimes \mathbf{K}}\left\langle x_{1}, a_{1} \cdot \nu\left(y_{1}\right)\right\rangle_{B \otimes \mathbf{K}}\right) \\
& =\beta^{-1}\left(\left\langle a \cdot \nu(y), x \cdot\left\langle x_{1}, a_{1} \cdot \nu\left(y_{1}\right)\right\rangle_{B \otimes \mathbf{K}}\right\rangle_{B \otimes \mathbf{K}}\right) \\
& =\beta^{-1}\left(\left\langle a \cdot \nu(y), A \otimes \mathbf{K}\left\langle x, x_{1}\right\rangle a_{1} \cdot \nu\left(y_{1}\right)\right\rangle_{B \otimes \mathbf{K}}\right) \\
& =\beta^{-1}\left(\left\langle\nu(y), a^{*}{ }_{A \otimes \mathbf{K}}\left\langle x, x_{1}\right\rangle a_{1} \cdot \nu\left(y_{1}\right)\right\rangle_{B \otimes \mathbf{K}}\right) \\
& =\left\langle y, \alpha^{-1}\left(a^{*}{ }_{A \otimes \mathbf{K}}\left\langle x,, x_{1}\right\rangle a_{1}\right) \cdot y_{1}\right\rangle_{B \otimes \mathbf{K}} .
\end{aligned}
$$

Hence the map $\Psi$ preserves the right $B \otimes \mathbf{K}$-valued inner products. Therefore, we obtain the conclusion.
(II) We suppose that $\alpha$ is strongly Morita equivalent to $\beta^{-1}$. Then by Lemma 3.4

X_{\beta^{-1}} \cong \widetilde{X_{\theta}} \otimes_{A \otimes \mathbf{K}} X_{\alpha} \otimes_{A \otimes \mathbf{K}} X_{\theta}
$$

as $B \otimes \mathbf{K}-B \otimes \mathbf{K}$-equivalence bimodules. Thus we obtain the following:
Lemma 3.5. With the above notation and assumptions,

$$
\widetilde{X_{\beta}} \cong X_{\beta^{-1}} \cong \widetilde{X_{\theta}} \otimes_{A \otimes \mathbf{K}} X_{\alpha} \otimes_{A \otimes \mathbf{K}} X_{\theta}
$$

as $B \otimes \mathbf{K}-B \otimes \mathbf{K}$-equivalence bimodules.
We recall that there is an $(A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}-(B \otimes \mathbf{K}) \rtimes_{\beta} \mathbf{Z}$ - equivalence bimodule isomorphism $\Phi$ of $N \otimes \mathbf{K}$ onto $Y_{\theta}$ such that $\left.\Phi\right|_{M \otimes \mathbf{K}}$ is an $A \otimes \mathbf{K}-B \otimes \mathbf{K}$-equivalence bimodule isomorphism of $M \otimes \mathbf{K}$ onto $X_{\theta}$. We identify $M \otimes \mathbf{K}$ with $X_{\theta}$ by $\left.\Phi\right|_{M \otimes \mathbf{K}}$. Then

X_{\beta} \cong(\widetilde{M \otimes \mathbf{K}}) \otimes_{A \otimes \mathbf{K}} X_{\alpha} \otimes_{A \otimes \mathbf{K}}(M \otimes \mathbf{K})
$$

or

$$
\widetilde{X_{\beta}} \cong(\widetilde{M \otimes \mathbf{K}}) \otimes_{A \otimes \mathbf{K}} X_{\alpha} \otimes_{A \otimes \mathbf{K}}(M \otimes \mathbf{K})
$$

as $B \otimes \mathbf{K}-B \otimes \mathbf{K}$-equivalence bimodules. Also, we recall that $X_{\alpha} \cong X \otimes \mathbf{K}$ as $A \otimes \mathbf{K}-A \otimes \mathbf{K}$-equivalence bimodules and that $X_{\beta} \cong Y \otimes \mathbf{K}$ as $B \otimes \mathbf{K}-B \otimes \mathbf{K}$ equivalence bimodules. Thus

$$
Y \otimes \mathbf{K} \cong(\widetilde{M \otimes \mathbf{K}}) \otimes_{A \otimes \mathbf{K}}(X \otimes \mathbf{K}) \otimes_{A \otimes \mathbf{K}}(M \otimes \mathbf{K})
$$

or

$$
\widetilde{Y \otimes \mathbf{K}} \cong(\widetilde{M \otimes \mathbf{K}}) \otimes_{A \otimes \mathbf{K}}(X \otimes \mathbf{K}) \otimes_{A \otimes \mathbf{K}}(M \otimes \mathbf{K})
$$

as $B \otimes \mathbf{K}-B \otimes \mathbf{K}$-equivalence bimodules. Furthermore, by Lemma 2.3

$$
X \otimes \mathbf{K} \cong H_{A} \otimes_{A} X \otimes_{A} \widetilde{H_{A}}
$$

as $A \otimes \mathbf{K}-A \otimes \mathbf{K}$-equivalence bimodues and

$$
Y \otimes \mathbf{K} \cong H_{B} \otimes_{B} Y \otimes_{B} \widetilde{H_{B}}
$$

as $B \otimes \mathbf{K}-B \otimes \mathbf{K}$-equivalence bimodues. Thus

$$
Y \cong \widetilde{H_{B}} \otimes_{B \otimes \mathbf{K}}(\widetilde{M \otimes \mathbf{K}}) \otimes_{A \otimes \mathbf{K}} H_{A} \otimes_{A} X \otimes_{A} \widetilde{H_{A}} \otimes_{A \otimes \mathbf{K}}(M \otimes \mathbf{K}) \otimes_{B \otimes \mathbf{K}} H_{B}
$$

or

$$
\widetilde{Y} \cong \widetilde{H_{B}} \otimes_{B \otimes \mathbf{K}}(\widetilde{M \otimes \mathbf{K}}) \otimes_{A \otimes \mathbf{K}} H_{A} \otimes_{A} X \otimes_{A} \widetilde{H_{A}} \otimes_{A \otimes \mathbf{K}}(M \otimes \mathbf{K}) \otimes_{B \otimes \mathbf{K}} H_{B}
$$

as $B \otimes \mathbf{K}-B \otimes \mathbf{K}$-equivalence bimodues. Also, by Lemma 2.3,

$$
\widetilde{H_{A}} \otimes_{A \otimes \mathbf{K}}(M \otimes \mathbf{K}) \otimes_{B \otimes \mathbf{K}} H_{B} \cong M
$$

$A-B$-equivalence bimodules. Hence

$$
Y \cong \widetilde{M} \otimes_{A} X \otimes_{A} M \quad \text { or } \quad \widetilde{Y} \cong \widetilde{M} \otimes_{A} X \otimes_{A} M
$$

as $B-B$-equivalence bimodules. Therefore, we obtain the following:
Theorem 3.6. Let $A$ and $B$ be $\sigma$-unital $C^{*}$-algebras and $X$ and $Y$ an $A-A$ equivalence bimodule and a $B-B$-equivalence bimodule, respectively. Let $A \subset$ $A \rtimes_{X} \mathbf{Z}$ and $B \subset B \rtimes_{Y} \mathbf{Z}$ be the inclusions of $C^{*}$-algebras induced by $X$ and $Y$, respectively. We suppose that $A^{\prime} \cap M\left(A \rtimes_{X} \mathbf{Z}\right) \cong \mathbf{C} 1$. Then the following conditions are equivalent:
(1) $A \subset A \rtimes_{X} \mathbf{Z}$ and $B \subset B \rtimes_{Y} \mathbf{Z}$ are strongly Morita equivalent with respect to an $A \rtimes_{X} \mathbf{Z}-B \rtimes_{Y} \mathbf{Z}$-equivalence bimodule $N$ and its closed subspace $M$,
(2) $Y \cong \widetilde{M} \otimes_{A} X \otimes_{A} M$ or $\widetilde{Y} \cong \widetilde{M} \otimes_{A} X \otimes_{A} M$ as $B-B$-equivalence bimodules.

Proof. (1) $\Rightarrow(2)$ : This is immediate by the above discussions. (2) $\Rightarrow(1)$ : This is immediate by Lemma 2.4 ,

## 4. The Picard groups

Let $A$ be a unital $C^{*}$-algebra and $X$ an $A-A$-equivalence bimodule. Let $A \subset$ $A \rtimes_{X} \mathbf{Z}$ be the inclusion of unital $C^{*}$-algebra induced by $X$. We suppose that $A^{\prime} \cap\left(A \rtimes_{X} \mathbf{Z}\right)=\mathbf{C} 1$. In this section, we shall compute $\operatorname{Pic}\left(A, A \rtimes_{X} \mathbf{Z}\right)$, the Picard group of the inclusion $A \subset A \rtimes_{X} \mathbf{Z}$ (See [10]).

Let $G$ be the subgroup of $\operatorname{Pic}(A)$ defined by

$$
\begin{aligned}
& G=\left\{[M] \in \operatorname{Pic}(A) \mid X \cong \widetilde{M} \otimes_{A} X \otimes_{A} M \text { or } \widetilde{X} \cong \widetilde{M} \otimes_{A} X \otimes_{A} M\right. \\
&\text { as } A-A \text {-equivalence bimodules }\}
\end{aligned}
$$

Let $f_{A}$ be the homomorphism of $\operatorname{Pic}\left(A, A \rtimes_{X} \mathbf{Z}\right)$ to $\operatorname{Pic}(A)$ defined by

$$
f_{A}([M, N])=[M]
$$

for any $[M, N] \in \operatorname{Pic}\left(A, A \rtimes_{X} \mathbf{Z}\right)$. First, we show $\operatorname{Im} f_{A}=G$, where $\operatorname{Im} f_{A}$ is the image of $f_{A}$.
Lemma 4.1. With the above notation, $\operatorname{Im} f_{A}=G$.
Proof. Let $[M, N] \in \operatorname{Pic}\left(A, A \rtimes_{X} \mathbf{Z}\right)$. Then by the definition of $\operatorname{Pic}\left(A, A \rtimes_{X} \mathbf{Z}\right)$, the inclusion $A \subset A \rtimes_{X} \mathbf{Z}$ is strongly Morita equivalent to itself with respect to an $A \rtimes_{X} \mathbf{Z}-A \rtimes_{X} \mathbf{Z}$-equivalence bmodule $N$ and its closed subspace $M$. Hence by Theorem 3.6, $X \cong \widetilde{M} \otimes_{A} X \otimes_{A} M$ or $\widetilde{X} \cong \widetilde{M} \otimes_{A} X \otimes_{A} M$ as $A-A$-equivalence bimodules. Thus $\operatorname{Im} f_{A} \subset G$. Next, let $[M] \in G$. Then by Lemma 2.4, there is an $A \rtimes_{X} \mathbf{Z}-A \rtimes_{X} \mathbf{Z}$-equivalence bimodule $N$ satisfying following:
(1) $M$ is included in $N$ as a closed subspace,
(2) $[M, N] \in \operatorname{Pic}\left(A, A \rtimes_{X} \mathbf{Z}\right)$.

Hence $G \subset \operatorname{Im} f_{A}$. Therefore, we obtain the conclusion.
Next, we compute $\operatorname{Ker} f_{A}$, the kernel of $f_{A}$. Let $\operatorname{Aut}\left(A, A \rtimes_{X} \mathbf{Z}\right)$ be the group of all automorphisms $\alpha$ of $A \rtimes_{X} \mathbf{Z}$ such that $\left.\alpha\right|_{A}$ is an automorphism of $A$. Let $\operatorname{Aut}_{0}\left(A, A \rtimes_{X} \mathbf{Z}\right)$ be the group of all automorphisms $\alpha$ of $A \rtimes_{X} \mathbf{Z}$ such that $\left.\alpha\right|_{A}=\mathrm{id}$ on $A$. It is clear that $\operatorname{Aut}_{0}\left(A, A \rtimes_{X} \mathbf{Z}\right)$ is a normal subgroup of $\operatorname{Aut}\left(A, A \rtimes_{X} \mathbf{Z}\right)$. Let $\pi$ be the homomorphism of $\operatorname{Aut}\left(A, A \rtimes_{X} \mathbf{Z}\right)$ to $\operatorname{Pic}\left(A, A \rtimes_{X} \mathbf{Z}\right)$ defined by

$$
\pi(\alpha)=\left[M_{\alpha}, N_{\alpha}\right]
$$

for any $\alpha \in \operatorname{Aut}\left(A, A \rtimes_{X} \mathbf{Z}\right)$, where $\left[M_{\alpha}, N_{\alpha}\right]$ is an element in $\operatorname{Pic}\left(A, A \rtimes_{X} \mathbf{Z}\right)$ induced by $\alpha$ (See [10, Section 3]).

Lemma 4.2. With the above notation,

$$
\operatorname{Ker} f_{A}=\left\{\left[A, N_{\beta}\right] \in \operatorname{Pic}\left(A, A \rtimes_{X} \mathbf{Z}\right) \mid \beta \in \operatorname{Aut}_{0}\left(A, A \rtimes_{X} \mathbf{Z}\right)\right\} .
$$

Proof. Let $[M, N] \in \operatorname{Ker} f_{A}$. Then $[M]=[A]$ in $\operatorname{Pic}(A)$ and by [10, Lemma 7.5], there is a $\beta \in \operatorname{Aut}_{0}\left(A, A \rtimes_{X} \mathbf{Z}\right)$ such that

$$
[M, N]=\left[A, N_{\beta}\right]
$$

in $\operatorname{Pic}\left(A, A \rtimes_{X} \mathbf{Z}\right)$, where $N_{\beta}$ is the $A \rtimes_{X} \mathbf{Z}-A \rtimes_{X} \mathbf{Z}$-equivalence bimodule induced by $\beta$. Therefore, we obtain the conclusion.

Let $\operatorname{Int}\left(A, A \rtimes_{X} \mathbf{Z}\right)$ be the group of all $\operatorname{Ad}(u)$ such that $u$ is a unitary element in $A$. By [10, Lemma 3.4],

$$
\operatorname{Ker} \pi \cap \operatorname{Aut}_{0}\left(A, A \rtimes_{X} \mathbf{Z}\right)=\operatorname{Int}\left(A, A \rtimes_{X} \mathbf{Z}\right) \cap \operatorname{Aut}_{0}\left(A, A \rtimes_{X} \mathbf{Z}\right)
$$

Hence

$$
\begin{aligned}
& \operatorname{Ker} \pi \cap \operatorname{Aut}_{0}\left(A, A \rtimes_{X} \mathbf{Z}\right) \\
& =\left\{\operatorname{Ad}(u) \in \operatorname{Aut}_{0}\left(A, A \rtimes_{X} \mathbf{Z}\right) \mid u \text { is a unitary element in } A\right\} \\
& =\left\{\operatorname{Ad}(u) \in \operatorname{Aut}_{0}\left(A, A \rtimes_{X} \mathbf{Z}\right) \mid u \text { is a unitary element in } A^{\prime} \cap A\right\} .
\end{aligned}
$$

Since $A^{\prime} \cap\left(A \rtimes_{X} \mathbf{Z}\right)=\mathbf{C} 1, A^{\prime} \cap A=\mathbf{C} 1$. Thus

$$
\operatorname{Ker} \pi \cap \operatorname{Aut}_{0}\left(A, A \rtimes_{X} \mathbf{Z}\right)=\{1\} .
$$

It follows that we can obtain the following lemma:
Lemma 4.3. With the above notation, $\operatorname{Ker} f_{A} \cong \operatorname{Aut}_{0}\left(A, A \rtimes_{X} \mathbf{Z}\right)$.
Proof. Since $\operatorname{Ker} \pi \cap \operatorname{Aut}_{0}\left(A, A \rtimes_{X} \mathbf{Z}\right)=\{1\}$, by Lemma 4.2

$$
\begin{aligned}
\operatorname{Ker} f_{A} & =\pi\left(\operatorname{Aut}_{0}\left(A, A \rtimes_{X} \mathbf{Z}\right)\right) \cong \operatorname{Aut}_{0}\left(A, A \rtimes_{X} \mathbf{Z}\right) /\left(\operatorname{Ker} \pi \cap \operatorname{Aut}_{0}\left(A, A \rtimes_{X} \mathbf{Z}\right)\right) \\
& =\operatorname{Aut}_{0}\left(A, A \rtimes_{X} \mathbf{Z}\right) .
\end{aligned}
$$

Therefore, we obtain the conclusion.
We recall that the inclusions of $C^{*}$-algebras $A \otimes \mathbf{K} \subset\left(A \rtimes_{X} \mathbf{Z}\right) \otimes \mathbf{K}$ and $A \otimes \mathbf{K} \subset$ $(A \otimes \mathbf{K}) \rtimes_{X \otimes \mathbf{K}} \mathbf{Z}$ are isomorphic as inclusions of $C^{*}$-algebras. Also, there is an automorphism $\alpha$ of $A \otimes \mathbf{K}$ such that $A \otimes \mathbf{K} \subset(A \otimes \mathbf{K}) \rtimes_{X \otimes \mathbf{K}} \mathbf{Z}$ and $A \otimes \mathbf{K} \subset$ $(A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}$ are isomorphic as inclusions of $C^{*}$-algebras.

Lemma 4.4. With the above notation, $\alpha$ is free, that is, for any $n \in \mathbf{Z} \backslash\{0\}$, $\alpha^{n}$ satisfies the following: If $x \in M(A \otimes \mathbf{K})$ satisfies that $x a=\alpha^{n}(a) x$ for any $a \in A \otimes \mathbf{K}$, then $x=0$.

Proof. Since $A^{\prime} \cap\left(A \rtimes_{X} \mathbf{Z}\right)=\mathbf{C 1}$, by [12, Lemma 3.1] $(A \otimes \mathbf{K})^{\prime} \cap M\left(\left(A \rtimes_{X} \mathbf{Z}\right) \otimes \mathbf{K}\right)=$ $\mathbf{C} 1$. Hence since $A \otimes \mathbf{K} \subset\left(A \rtimes_{X} \mathbf{Z}\right) \otimes \mathbf{K}$ is isomorphic to $A \otimes \mathbf{K} \subset(A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}$ as inclusions of $C^{*}$-algebras,

$$
(A \otimes \mathbf{K})^{\prime} \cap M\left((A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}\right)=\mathbf{C} 1
$$

Thus by [12, Corollary 4.2], $\alpha$ is free.
For any $n \in \mathbf{Z}$, let $\delta_{n}$ be the function on $\mathbf{Z}$ defined by

$$
\delta_{n}(m)=\left\{\begin{array}{ll}
1 & m=n \\
0 & m \neq n
\end{array} .\right.
$$

We regard $\delta_{n}$ as an element in $M\left((A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}\right)$. Let $E^{M(A \otimes \mathbf{K})}$ be the faithful conditional expectation from $M(A \otimes \mathbf{K}) \rtimes_{\underline{\alpha}} \mathbf{Z}$ onto $M(A \otimes \mathbf{K})$ defined in Bédos and Conti [2, Section 3]. Let $E^{A \otimes \mathbf{K}}=\left.E^{\bar{M}(A \otimes \mathbf{K})}\right|_{(A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}}$. Let $\left\{u_{i}\right\}_{i \in I}$ be an approximate unit of $A \otimes \mathbf{K}$. We fix the approximate unit $\left\{u_{i}\right\}_{i \in I}$ of $A \otimes \mathbf{K}$. For any $x \in M\left((A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}\right)$, we define the Fourier coefficient of $x$ at $n \in \mathbf{Z}$ and the Fourier series of $x$ as in [12, Section 2]. We show that $\operatorname{Aut}_{0}\left(A \otimes \mathbf{K},(A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}\right) \cong \mathbf{T}$.

Let $\beta \in \operatorname{Aut}_{0}\left(A \otimes \mathbf{K},(A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}\right)$. For any $a \in A \otimes \mathbf{K}$,

$$
\underline{\beta}\left(\delta_{1}\right) a \underline{\beta}\left(\delta_{1}^{*}\right)=\beta\left(\delta_{1} a \delta_{1}^{*}\right)=\beta(\alpha(a))=\alpha(a) .
$$

Hence $\underline{\beta}\left(\delta_{1}\right) a=\alpha(a) \underline{\beta}\left(\delta_{1}\right)$ for any $a \in A \otimes \mathbf{K}$.
Lemma 4.5. Let $\sum_{n \in \mathbf{Z}} a_{n} \delta_{1}^{n}=\sum_{n \in \mathbf{Z}} a_{n} \delta_{n}$ be the Fourier series of $\underline{\beta}\left(\delta_{1}\right)$, where $a_{n} \in M(A \otimes \mathbf{K})$ for any $n \in \mathbf{Z}$. Then for any $n \in \mathbf{Z}, a \in A \otimes \mathbf{K}$,

$$
a_{n} \alpha^{n-1}(a)=a a_{n}
$$

Proof. For any $a \in A \otimes \mathbf{K}, \underline{\beta}\left(\delta_{1}\right) a=\alpha(a) \underline{\beta}\left(\delta_{1}\right)$. Hence the Fourier series of $\underline{\beta}\left(\delta_{1}\right) a$ is:

$$
\sum_{n \in \mathbf{Z}} a_{n} \alpha^{n}(a) \delta_{1}^{n}
$$

Also, the Fourier series of $\alpha(a) \underline{\beta}\left(\delta_{1}\right)$ is:

$$
\sum_{n \in \mathbf{Z}} \alpha(a) a_{n} \delta_{1}^{n}
$$

Thus $a_{n} \alpha^{n}(a)=\alpha(a) a_{n}$ for any $a \in A \otimes \mathbf{K}, n \in \mathbf{Z}$. Therefore, we obtain the conclusion.

Lemma 4.6. With the above notation,

$$
\operatorname{Aut}_{0}\left(A \otimes \mathbf{K},(A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}\right) \cong \mathbf{T}
$$

Proof. Let $\beta \in \operatorname{Aut}_{0}\left(A \otimes \mathbf{K},(A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}\right)$ and let $\sum_{n \in \mathbf{Z}} a_{n} \delta_{1}^{n}$ be the Fourier series of $\underline{\beta}\left(\delta_{1}\right)$. Then by Lemma 4.5, $a_{n} \alpha^{n-1}(a)=a a_{n}$ for any $a \in A \otimes \mathbf{K}, n \in \mathbf{Z}$. Since $\alpha$ is free by Lemma 4.4 $a_{n}=0$ for any $n \in \mathbf{Z} \backslash\{1\}$. Thus $\underline{\beta}\left(\delta_{1}\right)=a_{1} \delta_{1}$. Since $\underline{\beta}\left(\delta_{1}\right) a \underline{\beta}\left(\delta_{1}^{*}\right)=\alpha(a)$ for any $a \in A \otimes \mathbf{K}$,

$$
a_{1} \delta_{1} a \delta_{1}^{*} a_{1}^{*}=\alpha(a)
$$

Since $\delta_{1} a \delta_{1}^{*}=\alpha(a)$,

$$
a_{1} \alpha(a) a_{1}^{*}=\alpha(a)
$$

for any $a \in A \otimes \mathbf{K}$. Since $\delta_{1}$ and $\underline{\beta}\left(\delta_{1}\right)$ are unitary elements in $M\left((A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}\right)$, $a_{1}$ is a unitary element in $M(A \otimes \overline{\mathbf{K}})$. Thus

$$
a_{1} \alpha(a)=\alpha(a) a_{1}
$$

for any $a \in A \otimes \mathbf{K}$. Since $(A \otimes \mathbf{K})^{\prime} \cap M(A \otimes \mathbf{K})=\mathbf{C} 1, a_{1} \in \mathbf{C} 1$. Since $a_{1}$ is a unitary element in $M(A \otimes \mathbf{K})$, there is the unique element $c_{\beta} \in \mathbf{T}$, such that $a_{1}=c_{\beta} 1$. Let $\epsilon$ be the map from $\operatorname{Aut}_{0}\left(A \otimes \mathbf{K},(A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}\right)$ onto $\mathbf{T}$ defined
by $\epsilon(\beta)=c_{\beta}$. By routine computations, we can see that $\epsilon$ is an isomorphism of $\operatorname{Aut}_{0}\left(A \otimes \mathbf{K},(A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}\right)$ onto $\mathbf{T}$.

Lemma 4.7. With the above notation,

$$
\operatorname{Aut}_{0}\left(A, A \rtimes_{X} \mathbf{Z}\right) \cong \operatorname{Aut}_{0}\left(A \otimes \mathbf{K},(A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}\right)
$$

Proof. Since $A \otimes \mathbf{K} \subset(A \otimes \mathbf{K}) \rtimes_{\alpha} \mathbf{Z}$ and $A \otimes \mathbf{K} \subset\left(A \rtimes_{X} \mathbf{Z}\right) \otimes \mathbf{K}$ are isomorphic as inclusions of $C^{*}$-algebras, it suffices to show that

$$
\operatorname{Aut}_{0}\left(A, A \rtimes_{X} \mathbf{Z}\right) \cong \operatorname{Aut}_{0}\left(A \otimes \mathbf{K},\left(A \rtimes_{X} \mathbf{Z}\right) \otimes \mathbf{K}\right)
$$

Let $\kappa$ be the homomorphism of $\operatorname{Aut}_{0}\left(A, A \rtimes_{X} \mathbf{Z}\right)$ to $\operatorname{Aut}_{0}\left(A \otimes \mathbf{K},\left(A \rtimes_{X} \mathbf{Z}\right) \otimes \mathbf{K}\right)$ defined by

$$
\kappa(\beta)=\beta \otimes \operatorname{id}_{\mathbf{K}}
$$

for any $\beta \in \operatorname{Aut}_{0}\left(A, A \rtimes_{X} \mathbf{Z}\right)$. Then it is clear that $\kappa$ is a monomorphism of $\operatorname{Aut}_{0}\left(A, A \rtimes_{X} \mathbf{Z}\right)$ to $\operatorname{Aut}_{0}\left(A \otimes \mathbf{K},\left(A \rtimes_{X} \mathbf{Z}\right) \otimes \mathbf{K}\right)$. We show that $\kappa$ is surjective. Let $\gamma \in \operatorname{Aut}_{0}\left(A \otimes \mathbf{K},\left(A \rtimes_{X} \mathbf{Z}\right) \otimes \mathbf{K}\right)$. Then

$$
\gamma\left(a \otimes e_{i j}\right)=a \otimes e_{i j}
$$

for any $a \in A, i, j \in \mathbf{N}$. Thus

$$
\gamma\left(x \otimes e_{11}\right)=\left(1 \otimes e_{11}\right) \gamma\left(x \otimes e_{11}\right)\left(1 \otimes e_{11}\right)
$$

for any $x \in A \rtimes_{X} \mathbf{Z}$. Hence there is an automorphism $\alpha$ of $A \rtimes_{X} \mathbf{Z}$ such that

$$
\gamma\left(x \otimes e_{11}\right)=\alpha(x) \otimes e_{11}
$$

for any $x \in A \rtimes_{X} \mathbf{Z}$. For any $i, j \in \mathbf{N}, x \in A \rtimes_{X} \mathbf{Z}$,

$$
\begin{aligned}
\gamma\left(x \otimes e_{i j}\right) & =\gamma\left(\left(1 \otimes e_{11}\right)\left(x \otimes e_{11}\right)\left(1 \otimes e_{1 j}\right)\right)=\left(1 \otimes e_{i 1}\right)\left(\alpha(x) \otimes e_{11}\right)\left(1 \otimes e_{1 j}\right) \\
& =\alpha(x) \otimes e_{i j} .
\end{aligned}
$$

Especially, if $a \in A, \alpha(a) \otimes e_{i j}=\gamma\left(a \otimes e_{i j}\right)=a \otimes e_{i j}$ for any $i, j \in \mathbf{N}$. Thus $\alpha(a)=a$ for any $a \in A$. Therefore, $\gamma=\alpha \otimes \operatorname{id}_{\mathbf{K}}$ and $\alpha \in \operatorname{Aut}_{0}\left(A, A \rtimes_{X} \mathbf{K}\right)$. Hence we can see that $\kappa$ is surjective.

Lemma 4.8. With the above notation, $\operatorname{Ker} f_{A} \cong \mathbf{T}$.
Proof. This is immediate by Lemmas 4.3, 4.6 and 4.7
By Lemmas 4.1 and 4.8, we have the following exact sequence:

$$
1 \longrightarrow \mathbf{T} \longrightarrow \operatorname{Pic}\left(A, A \rtimes_{X} \mathbf{Z}\right) \longrightarrow G \longrightarrow 1
$$

where

$$
\begin{aligned}
& G=\left\{[M] \in \operatorname{Pic}(A) \mid X \cong \widetilde{M} \otimes_{A} X \otimes_{A} M \text { or } \widetilde{X} \cong \widetilde{M} \otimes_{A} X \otimes_{A} M\right. \\
&\text { as } A-A \text {-equivalence bimodules }\}
\end{aligned}
$$

Let $g$ be the map from $G$ to $\operatorname{Pic}\left(A, A \rtimes_{X} \mathbf{Z}\right)$ defined by

$$
g([M])=[M, N]
$$

where $N$ is the $A \rtimes_{X} \mathbf{Z}-A \rtimes_{X} \mathbf{Z}$-equivalence bimodule defined in the proof of Lemma 2.4 Then $g$ is a homomorphism of $G$ to $\operatorname{Pic}\left(A, A \rtimes_{X} \mathbf{Z}\right)$ such that

$$
f_{A} \circ g=\mathrm{id}
$$

on $G$. Thus we obtain the following:
Theorem 4.9. Let $A$ be a unital $C^{*}$-algebra and $X$ an $A-A$-equivalence bimodule. Let $A \subset A \rtimes_{X} \mathbf{Z}$ be the unital inclusion of unital $C^{*}$-algebras induced by $X$. We suppose that $A^{\prime} \cap\left(A \rtimes_{X} \mathbf{Z}\right)=\mathbf{C} 1$. Then $\operatorname{Pic}\left(A, A \rtimes_{X} \mathbf{Z}\right)$ is a semi-direct product of $G$ by $\mathbf{T}$.
